# RICCI FLOW OF $W^{2,2}$-METRICS IN FOUR DIMENSIONS 

TOBIAS LAMM AND MILES SIMON


#### Abstract

In this paper we construct solutions to Ricci DeTurck flow in four dimensions on closed manifolds which are instantaneously smooth but whose initial values $g$ are (possibly) non-smooth Riemannian metrics whose components in smooth coordinates belong to $W^{2,2}$ and satisfy $\frac{1}{a} h \leq g \leq a h$ for some $1<a<\infty$ and some smooth Riemannian metric $h$ on $M$. A Ricci flow related solution is constructed whose initial value is isometric in a weak sense to the initial value of the Ricci DeTurck solution. Results for a related non-compact setting are also presented. Various $L^{p}$ estimates for Ricci flow, which we require for some of the main results, are also derived. As an application we present a possible definition of scalar curvature $\geq k$ for $W^{2,2}$ metrics $g$ on closed four manifolds which are bounded in the $L^{\infty}$ sense by $\frac{1}{a} h \leq g \leq a h$ for some $1<a<\infty$ and some smooth Riemannian metric $h$ on $M$.

## 1. Introduction

In this paper we construct solutions to Ricci flow and Ricci DeTurck flow which are instantaneously smooth but whose initial values are (possibly) non-smooth Riemannian metrics whose components, in smooth coordinates, belong to certain Sobolev spaces.

For a given smooth Riemannian manifold $(M, h)$, and an interval $I \subseteq \mathbb{R}$, a smooth family $g(t)_{t \in I}$ of Riemannian metrics on $M$ is a solution to Ricci DeTurck $h$ Flow if

[^0]in the smooth sense on $M \times I$, where here, and in the rest of the paper, ${ }^{h} \nabla$ refers to the covariant derivative with respect to $h$. A smooth family $\ell(t)_{t \in I}$ of Riemannian metrics on $M$ is a solution to Ricci flow if

in the smooth sense on $M \times I$. The Ricci flow was first introduced and studied by R. Hamilton in [14]. Shortly after that, the Ricci DeTurck flow was introduced and studied by D. DeTurck in [10]. Ricci DeTurck flow and Ricci flow in the smooth setting are closely related : given a Ricci DeTurck flow $g(t)_{t \in I}$ on a compact manifold and an $S \in I$ there is a smooth family of diffeomorphisms $\Phi(t): M \rightarrow M, t \in I$ with $\Phi(S)=I d$ such that $\ell(t)=(\Phi(t))^{*} g(t)$ is a smooth solution to Ricci flow. The diffeomorphisms $\Phi(t)$ solve the following ordinary differential equation:

where $V^{\alpha}(y, t):=-g^{\beta \gamma}\left({ }^{g} \Gamma_{\beta \gamma}^{\alpha}-{ }^{h} \Gamma_{\beta \gamma}^{\alpha}\right)(y, t)$
There are a number of papers on solutions to Ricci DeTurck flow and Ricci flow starting from non-smooth Riemannian metric/distance spaces which immediately become smooth : Given a non-smooth starting space $\left(M, g_{0}\right)$ or $\left(M, d_{0}\right)$, it is possible in some settings, to find smooth solutions $g(t)_{t \in(0, T)}$ to (1.1), respectively $\ell(t)_{t \in(0, T)}$ to (1.2) defined for some $T>0$, where the initial values are achieved in some weak sense. Here is a nonexhaustive list of papers, where examples of this type are constructed : $[30,15,17,20,31$, $33,27,8,3,16,23,36,35]$. The initial non-smooth data considered in these papers has certain structure, which when assumed in the smooth setting, leads to a priori estimates for solutions, which are then used to construct solutions in the class being considered. In some papers this initial structure comes from geometric conditions, in others from regularity conditions on the initial function space of the metric components in smooth coordinates. In the second instance, this is usually in the setting, that one has some $C^{0}$ control of the metric. That is, the metric is close in the $L^{\infty}$ sense to the standard euclidean metric in smooth coordinates: $(1-\varepsilon) \delta \leq g(0) \leq(1+\varepsilon) \delta$ for a sufficiently small $\varepsilon$. In the current paper, the structure of the initial metric $g(0)$ comes from the assumption, in the four dimensional compact setting, that the components in coordinates are in $W^{2,2}$, and uniformly bounded from above and below : $\frac{1}{c} \delta \leq g(0) \leq c \delta$ for some constant $c$. Closeness of the metric to $\delta$ is not assumed. With this initial structure, we show that a solution to Ricci DeTurck flow exists. In the non-compact setting, we further require a uniform local smallness bound on the $W^{2,2}$ norm and a global uniform bound from above and below in the $L^{\infty}$ sense, both with respect to a geometrically controlled background metric. We also investigate the question of how the initial values are achieved, in the metric and distance sense, as time goes back to zero. See Theorem 2.2 in the next section for details.

Using this solution to Ricci DeTurck flow, we show without much trouble, that there is a Ricci flow related solution. The Ricci flow solution is related to the Ricci DeTurck solution through a smooth family of isometries $(\Phi(t))_{t \in(0, T)}$ defined for a positive time interval, and having the property that $\Phi(S)=I d$ for some $S>0$. The convergence as time goes back to zero in the distance and metric sense is investigated for this Ricci Flow solution. We require some new estimates on convergence in the $L^{p}$ sense for solutions to Ricci flow, in order to show that there is indeed a limiting weak Riemannian metric, as time approaches to zero. We also show that the initial metric value of the Ricci flow that is achieved is isometric, in a weak sense, to the initial value $g(0)$ of the Ricci DeTurck flow solution. See Theorem 2.3 in the next section for details.

Section 12 contains an application of the results obtained in the sections preceeding it. We present a possible definition of 'the scalar curvature of $g$ is bounded from below by
$k \in \mathbb{R}^{\prime}$ for a metric $g \in W^{2,2} \cap L^{\infty}$ with $\frac{1}{a} h \leq g \leq a h$ for some $1<a<\infty$ and some smooth Riemannian metric $h$ on a closed manifold $M$.

We conclude this introduction by noting, that there are metrics $g_{0} \in W^{2, \frac{n}{2}}(M) \cap L^{\infty}(M)$ on compact $n$-dimensional manifolds, which satisfy $\frac{1}{a} h \leq g_{0} \leq a h$ for some $0<a<\infty$ and some smooth fixed Riemannian metric $h$ on $M$, but are not continuous. In particular, $g_{0} \in W^{2,2}(M) \cap L^{\infty}(M)$ and $\frac{1}{a} h \leq g_{0} \leq a h$ but $g_{0}$ is not continuous when $n=4$. In the example we present below, there is a point $p \in M$, such that the values $\frac{1}{a} h$ and $a h$ are achieved by $g_{0}$ infinitely often for every neighbourhood of $p$.

Let $(M, h)$ be a smooth compact $n$ - dimensional manifold, $U \subseteq M$ open, and $\varphi: U \rightarrow$ $\varphi(U)=\mathbb{B}_{1}(0)$ be coordinates and $\tilde{h}:=\varphi_{*} h$, the push forward of $h$ with $\varphi$ to $\mathbb{B}_{1}(0)$. For $\varepsilon, r>0, c \in \mathbb{R}$, let $f=f_{\varepsilon, r, c}: \mathbb{B}_{1}(0) \rightarrow \mathbb{R}$ be the $W^{2, \frac{n}{2}}\left(\mathbb{B}_{1}(0)\right)$ function defined by $f(x)=r\left(\frac{1}{\varepsilon}\left(1+\varepsilon+\sin \left(c+\log \left(\log \left(\frac{2}{|x|}\right)\right)\right)\right)\right)$ for $x \neq 0$ and $f(0)=0$. Then $f$ is bounded from above and from below by $f(\cdot) \in\left[r, r\left(\frac{2+\varepsilon}{\varepsilon}\right)\right]$ and the values $r$ and $r\left(\frac{2+\varepsilon}{\varepsilon}\right)$ are both achieved infinitely many times on any neighbourhood of $0 \in \mathbb{B}_{1}(0)$, and consequently we see that $f$ is also not continuous. Now we set $\tilde{g}(x)=(1-\eta(x)) \tilde{h}(x)+\eta(x) \hat{g}(x)$ where $\eta$ is a smooth cut-off function $\eta \in[0,1]$ with support in $\mathbb{B}_{\frac{1}{2}}(0)$, where $\hat{g}_{i j}(x)=f_{\varepsilon_{i}, r_{i}, c_{i}}(x) \delta_{i j}$, where $\varepsilon_{i}, r_{i}, c_{i} \in \mathbb{R}, i, j \in\{1, \ldots n\}, \varepsilon_{i}, r_{i}>0$. Then the metric $g$ defined by $g=\varphi^{*}(\tilde{g})$ on $U$, and $g=h$ on $M \backslash U$ is a metric on $M$ with $g \in W^{2, \frac{n}{2}}(M) \cap L^{\infty}(M), \frac{1}{a} h \leq g \leq a h$ for some $1<a<\infty$, and $g$ is not continuous.

## 2. Main Results

The assumptions we make on the smooth background metric are as follows
(2.1) $(M, h)$ is a smooth, connected, complete manifold without boundary such that

Such manifolds always satisfy a local uniform Sobolev inequality: there exist constants $0<r_{0}(n, h), C_{S}(n)<\infty$ such that $\left(\int_{M} f^{\frac{2 n}{n-2}} d h\right)^{\frac{n-2}{2}} \leq\left.\left. C_{S}(n) \int_{M}\right|^{h} \nabla f\right|^{2} d h$ and $\left(\int_{M} f^{n} d h\right)^{\frac{1}{2}} \leq\left.\left. C_{S}(n) \int_{M}\right|^{h} \nabla f\right|^{\frac{n}{2}} d h$ for all smooth $f$ whose support is contained in a ball of radius $r_{0}(n, h)>0$. For the readers convenience, we have included a proof in the Appendix B : See Lemma B. 1 and Remark B.2.

Ultimately we would like to construct solutions to (1.1) on four manifolds starting with initial data $g_{0}$ which are uniformly bounded from above and below by a multiple of $h$, $g_{0}$ is locally in $W^{2,2}$, and for which the homogeneous $W^{2,2}$ energy of $g_{0}$ is uniformly bounded, $E\left(g_{0}\right):=\int_{M}\left(\left.\left.\right|^{h} \nabla g_{0}\right|^{2}+\left.\left.\right|^{h} \nabla^{2} g_{0}\right|^{2}\right) d h<\infty$. That is, we assume that there exists an $a>0$ such that

In this setting we show, the following
Theorem 2.1. Let $1<a<\infty$ and $\left(M^{4}, h\right)$ be a four dimensional smooth Riemannian manifold satisfying (2.1), and $g_{0}$ be $a W^{2,2} \cap L^{\infty}$ Riemannian metric, not necessarily smooth, which satisfies
(a)

Then for any $0<\varepsilon<1$ there exist constants $0<T=T\left(g_{0}, h, a, \varepsilon\right), r=r\left(g_{0}, h, a, \varepsilon\right), c_{j}=$ $c_{j}(h, a, \varepsilon)<\infty$ for all $j \in \mathbb{N}_{0}$ and a smooth solution $(g(t))_{t \in(0, T]}$ to (1.1), where $g(t)$ satisfies
( $\mathrm{a}_{t}$ )

and for all $2 \geq R>1$ there exists a $V(a, R)>0$ such that

for all $x_{0} \in M$, for all $t \leq T$. Furthermore, there exists $\varepsilon_{0}=\varepsilon_{0}\left(g_{0}, h, a\right)$ such that if $\varepsilon \leq \varepsilon_{0}$ then the solution is unique in the class of solutions which satisfy $\left(\mathrm{a}_{t}\right),\left(\mathrm{b}_{t}(r)\right)$, $\left(\mathrm{c}_{t}\right),\left(\mathrm{d}_{t}\right)$ for the $r=r\left(g_{0}, h, a, \varepsilon\right)>0$ defined above.

Proof. See Theorem 6.5 of Section 6 : The proof is given there.

Assume (2.1) and (2.2) and that $M$ is four dimensional. Then for any $1>\varepsilon>0$, we can find an $r>0$ such that

see Theorem B. 3 in Appendix B for a proof. After scaling $h$ and $g_{0}$ once, and still calling the resulting metrics $g_{0}$ and $h$, we may assume
(2.4) ( $M, h$ ) is a smooth, connected, complete manifold without boundary such that

for a small positive constant $\delta_{0}(a)$ of our choice, in place of the assumptions (2.1), and the scale invariant condition $\frac{1}{a} h \leq g_{0} \leq a h$ and $\sup _{x \in M} \int_{B_{1}(x)}\left(\left.\left.\right|^{h} \nabla g_{0}\right|^{4}+\left.\left.\right|^{h} \nabla^{2} g_{0}\right|^{2}\right) d h<\frac{\varepsilon}{2}$, is
still correct, and hence, using Hölder's ineqaulity, we have

Note further, if we assume (2.1), then (2.3) is a stronger assumption than (2.2): (2.1) and $(2.2) \Longrightarrow$ : for any $\varepsilon>0$ there exists an $r>0$ such that (2.3) holds, but for any given $\varepsilon>0$ there are $g_{0}$ and $h$ and $r>0$ for which (2.1) and (2.3) hold, but $E\left(g_{0}\right):=\infty$.

The main estimates required for the construction of solutions to (1.1) in the $W^{2,2}$ setting in this paper are proved in this setting, that is under the assumptions (2.5) (with $c(n) \sqrt{\varepsilon}$ replaced by $\varepsilon$ ) and (2.4), and we also prove an existence result in this setting:

Theorem 2.2. For any $1<a<\infty$ there exists a constant $\varepsilon_{1}=\varepsilon_{1}(a)>0$ with the following properties. Let $\left(M^{4}, h\right)$ be a smooth four dimensional Riemannian manifold which satisfies (2.4). Let $g_{0}$ be a $W_{\text {loc }}^{2,2} \cap L^{\infty}$ Riemannian metric, not necessarily smooth, which satisfies

where $\varepsilon \leq \varepsilon_{1}$. Then there exists a constant $T=T(a, \varepsilon)>0$ and a smooth solution $(g(t))_{t \in(0, T]}$ to (1.1) such that

for all $x \in M, t \in[0, T]$, where $c_{j}(h, \varepsilon, a) \rightarrow 0$ as $\varepsilon \rightarrow 0$, and

The solution is unique in the class of solutions which satisfy $\left(\mathrm{a}_{t}\right),\left(\mathrm{b}_{t}\right),\left(\mathrm{c}_{t}\right)$, and $\left(d_{t}\right)$. The solution also satisfies the local estimates

and for all $1<R \leq 2$ there exists a $V(a, R)>0$

for all $x_{0} \in M, 2 \geq R>1$ for all $t \leq T$.

Proof. The Theorem follows from Theorem 6.3 and Remark 6.4 of Section 6.

With a solution of this type at hand, we can without much trouble now construct a solution to Ricci flow $(\ell(t))_{t \in(0, T)}=\left((\Phi(t))^{*} g(t)\right)_{t \in(0, T)}$ with $\ell(S)=g(S)$ and $\Phi(S)=I d$ for any given fixed $S>0$. After some work it becomes clear, that the Ricci Flow solution has initial starting data corresponding in some weak isometric sense to the starting data $g_{0}$ of the Ricci DeTurck flow solution. More specifically, we show for all $p \in[1, \infty)$, that there is a weak limit $\ell_{0}:=\lim _{t \searrow 0} \ell(t)$ in the $L_{l o c}^{p}$ sense and that $\ell_{0}$ is isometric to $g_{0}$ with the help of a $W^{1, p}$ isometry, and that there is a uniform limit $d_{0}:=\lim _{t \searrow 0} d_{t}$ for $d_{t}:=d(g(t))$, where $d_{0}$ can be explicitly calculated from the starting data $g_{0}$. These facts, and more details, are contained in the following theorem.

Theorem 2.3. Let $1<a<\infty, M=M^{4}$ be a four dimensional manifold, and $g_{0}$ and $h$ satisfy the assumptions (2.4), (a) and (b), with $\varepsilon \leq \varepsilon_{1}$ where $\varepsilon_{1}=\varepsilon_{1}(a)>0$ is the constant coming from Theorem 2.2, and let
$(M, g(t))_{t \in(0, T]}$ be the smooth solution to (1.1) constructed in Theorem 2.2. Then
(i) there exists a constant $c(a)$ and a smooth solution $\Phi: M \times(0, T] \rightarrow M$ to (1.3) with $\Phi(T / 2)=I d$ such that $\Phi(t):=\Phi(\cdot, t): M \rightarrow M$ is a diffeomorphism and $d_{h}(\Phi(t)(x), \Phi(s)(x)) \leq c(a) \sqrt{|t-s|}$ for all $x \in M$. The metrics $\ell(t):=$ $(\Phi(t))^{*} g(t), t \in(0, T]$ solve the Ricci flow equation. Furthermore there are well defined limit maps $\Phi(0): M \rightarrow M, \Phi(0):=\lim _{t \searrow 0} \Phi(t)$, and $W(0): M \rightarrow M$, $W(0):=\lim _{t \searrow 0} W(t)$, where $W(t)$ is the inverse of $\Phi(t)$ and these limits are obtained uniformly on compact subsets, and $\Phi(0), W(0)$ are homeomorphisms inverse to one another.
(ii) For the Ricci flow solution $\ell(t)$ from (i), there is a value $\ell_{0}(\cdot)=\lim _{t \searrow 0} \ell(\cdot, t)$ well defined up to a set of measure zero, where the limit exists in the $L_{\text {loc }}^{p}$ sense, for any $p \in[1, \infty)$, such that, $\ell_{0}$ is positive definite, and in $W_{l o c}^{1,2}$ and for any $x_{0} \in M$ and $0<s<t \leq T$ we have
$\int_{B_{1}\left(x_{0}\right)}\left|\ell(s)-\ell_{0}\right|_{\ell(t)}^{p} d \ell(t) \leq c\left(g_{0}, h, p, x_{0}\right) s$
$\int_{B_{1}\left(x_{0}\right)}\left|(\ell(0))^{-1}-(\ell(s))^{-1}\right|_{\ell(t)}^{p} d \ell(t) \leq c\left(g_{0}, h, p, x_{0}\right)|s|^{\frac{1}{4}}$
$\int_{\left.B_{1}\left(x_{0}\right)\right)}\left|\nabla \ell_{0}\right|_{\ell(t)}^{2} d \ell(t) \leq c\left(g_{0}, h, p, x_{0}\right) t^{\sigma}$
$\int_{B_{1}\left(x_{0}\right)}|\operatorname{Rm}(\ell)|^{2}(x, t) d \ell(x, t)+\int_{0}^{t} \int_{B_{\ell(s)}\left(x_{0}, 1\right)}|\nabla \operatorname{Rm}(\ell)|^{2}(x, s) d \ell(x, s) d s \leq c\left(g_{0}, h, p, x_{0}\right)$
$\sup _{B_{1}\left(x_{0}\right)}\left|\nabla^{j} \operatorname{Rc}(\ell(t))\right|^{2} t^{j+2} \rightarrow 0$ as $t \searrow 0$ for all $j \in \mathbb{N}_{0}$
for a universal constant $\sigma>0$, where $\nabla$ refers to the gradient with respect to $\ell(t), c\left(g_{0}, h, p, x_{0}\right)$ is a constant depending on $g_{0}, h, p, x_{0}$ but not on $t$ or $s$.
(iii) The limit maps $\Phi(0): M \rightarrow M, \Phi(0):=\lim _{t \searrow 0} \Phi(t)$, and $W(0): M \rightarrow M$, $W(0):=\lim _{t \searrow 0} W(t)$, from (i) are also obtained in the $W_{\text {loc }}^{1, p}$ sense for $p \in[1, \infty)$. Furthermore, for any smooth coordinates $\varphi: U \rightarrow \mathbb{R}^{n}$, and $\psi: V \rightarrow \mathbb{R}^{n}$ with $W(0)(V) \subset \subset U$, the functions $\left(\ell_{0}\right)_{i j} \circ W(0): V \rightarrow \mathbb{R}$ are in $L_{\text {loc }}^{p}$ for all $p \in[1, \infty)$ and $\left(g_{0}\right)_{\alpha \beta}: V \rightarrow \mathbb{R}$ and $\left(\ell_{0}\right)_{i j}: U \rightarrow \mathbb{R}$ are related by the identity

$$
\left(g_{0}\right)_{\alpha \beta}=D_{\alpha}(W(0))^{i} D_{\beta}(W(0))^{j}\left(\left(\ell_{0}\right)_{i j} \circ W(0)\right)
$$

which holds almost everywhere. In particular: $\ell_{0}$ is isometric to $g_{0}$ almost everywhere through the map $W(0)$ which is in $W_{l o c}^{1, p}$, for all $p \in[1, \infty)$.
(iv) We define $d_{t}(x, y)=d(g(t))(x, y)$ and $\tilde{d}_{t}(p, q)=d(\ell(t))(p, q)$, for all $x, y, p, q \in$ $M, t \in(0, T)$. There are well defined limit metrics $d_{0}, \tilde{d}_{0}: M \times M \rightarrow \mathbb{R}_{0}^{+}$, $d_{0}(x, y)=\lim _{t \searrow 0} d_{t}(x, y)$, and $\tilde{d}_{0}:=M \times M \rightarrow \mathbb{R}_{0}^{+}, \tilde{d}_{0}(p, q)=\lim _{t \searrow 0} \tilde{d}_{t}(p, q)$, and they satisfy $\tilde{d}_{0}(x, y)=d_{0}(\Phi(0)(x), \Phi(0)(y))$. That is, $\left(M, \tilde{d}_{0}\right)$ and $\left(M, d_{0}\right)$ are isometric to one another through the map $\Phi(0)$.

The metric $d_{0}$ satisfies $d_{0}(x, y):=\liminf _{\varepsilon \searrow 0} \inf _{\gamma \in C_{\varepsilon, x, y}} L_{g_{0}}(\gamma)$, where $C_{\varepsilon, x, y}$ is the space of $\varepsilon$-approximative Lebesgue curves between $x$ and $y$ with respect to $g_{0}$ : This space is defined/examined in Definition 8.2.

Proof. See Theorem 8.3 of Section 8: The proof is given there.
Remark 2.4. An attempt to construct a Ricci flow solution $\ell(t)$ with $\Phi(0)=I d$ and $\ell(0)=\Phi(0)^{*} g(0)=g(0)$, using similar methods to those we use to construct the Ricci flow solution in Theorem 2.3, could lead to a non-smooth Ricci flow solution, which does not immediately become smooth (we say the solution is in a non-smooth gauge), as we now explain. The solutions $g(t)$ constructed in Theorem 2.1 are limits of solutions $g_{i}(t)$ with initial data $g_{i}(0)$ where $g_{i}(0) \rightarrow g(0)$ in $W_{l o c}^{2,2}$. For $M=\mathbb{T}^{4}$, the four dimensional Torus, whose circles have radius 10 , with $h$ the standard flat metric on $\mathbb{T}^{4}$, let $g_{i}(0)=\varphi(i)^{*} h$, where $\varphi(i): \mathbb{T}^{4} \rightarrow \mathbb{T}^{4}$ are diffeomorphisms, equal to the identity outside a ball $\mathbb{B}_{1}(0)$ of radius one (which we identify with the standard euclidean ball of radius one), and $\left.\varphi(i)\right|_{\mathbb{B}_{1}(0)}: \mathbb{B}_{1}(0) \rightarrow \varphi(i)\left(\mathbb{B}_{1}(0)\right)=\mathbb{B}_{1}(0)$ are uniformly Bi-Lipschitz diffeomorphsims, $\frac{1}{B}|x-y| \leq|\varphi(i)(x)-\varphi(i)(y)| \leq B|x-y|$ for all $x, y \in \mathbb{B}_{1}(0)$, with $\varphi_{i}(0) \rightarrow \psi$ as $i \rightarrow \infty$ in the $W^{3,2}$ sense. Assume that $\psi$ is not smooth. For example we can take $\varphi(i)(x)=x\left(1+\eta \sigma f_{i}(x)\right)$ with $f_{i}(x):=\left(2+\sin \left(\log \left(\log \left(\frac{2}{\sqrt{|x|^{2}+\frac{1}{i}}}\right)\right)\right), \sigma\right.$ a small positive constant, and $\eta$ a smooth cut-off function with $\eta=1$ on $\mathbb{B}_{1 / 2}(0), \eta=0$ on $\left(\mathbb{B}_{3 / 4}(0)\right)^{c}$. Notice that the $\varphi(i)$ are uniformly Bi-Lipschitz, as we now explain. Assume that $|x| \leq|y|$. Then

$$
\begin{aligned}
& |\varphi(i)(x)-\varphi(i)(y)|=\left|(x-y)+x \eta \sigma f_{i}(x)-y \eta \sigma f_{i}(y)\right| \\
& =\left|(x-y)+x \sigma\left(\eta(x) f_{i}(x)-\eta(y) f_{i}(y)\right)+(x-y) \eta \sigma f_{i}(y)\right| \\
& \geq \frac{9}{10}|x-y|-2 \sigma|x||\eta(x)-\eta(y)|-2 \sigma|x-y|-\sigma|x|\left|f_{i}(x)-f_{i}(y)\right| \\
& \geq \frac{9}{10}|x-y|-2 \sigma|x|\left|D_{v} \eta(c)\right||x-y|-2 \sigma|x-y|-\sigma|x|\left|D_{v} f_{i}(b)\right||x-y| \\
& \geq \frac{1}{2}|x-y|-\sigma|x|\left|D_{v} f_{i}(b)\right||x-y|
\end{aligned}
$$

where $b$ and $c$ are points in the line between $x$ and $y$ and $v$ is a length one vector pointing in the direction of the line between $x$ and $y$. A calculation shows us that

$$
\begin{aligned}
\left|D_{v} f_{i}(b)\right| & =|\cos (\ldots)| \left\lvert\, \frac{1}{\left\lvert\, \log \left(\frac{1}{\sqrt{|b|^{2}+\frac{1}{i}}}\right)\right.} 2 \frac{\langle b, v\rangle \mid}{\left(|b|^{2}+\frac{1}{i}\right)}\right. \\
& \leq|\cos (\ldots)| \frac{1}{|b|}
\end{aligned}
$$

which, combined with the fact that $|x| \leq|b|$, gives us $\sigma|x|\left|D_{v} f_{i}(b) \| x-y\right| \leq \sigma|x-y|$, and hence $|\varphi(i)(x)-\varphi(i)(y)| \geq \frac{1}{4}|x-y|$. A similar calculation shows us that $\mid \varphi(i)(x)-$ $\varphi(i)(y)|\leq 4| x-y \mid$. The definition of the $\varphi(i)^{\prime} s$ guarantees that
$\varphi(i): \mathbb{B}_{1}(0) \rightarrow \mathbb{R}^{n}$ are smooth Bi-Lipshitz diffeomomorphisms whose image lies in $B_{1}(0)$. Furhtermore $\varphi(i)(t x)$ is a continuous line, for $t$ bewteen 0 and 1 lying on the standard line $t x$ between 0 and $x$. Hence, $\{\varphi(i)(t x) \mid t \in[0,1]\}=\{t x \mid t \in[0,1]\}$. This shows that $\varphi(i): \mathbb{B}_{1}(0) \rightarrow \mathbb{B}_{1}(0)$ is also onto.

Then $\varphi(i) \rightarrow \psi$ in the $W^{3,2}$ sense, with $\psi(x)=x(1+\eta \sigma f(x)), f(x):=\left(2+\sin \left(\log \left(\log \left(\frac{2}{|x|}\right)\right)\right)\right)$ for $x \neq 0 f(0):=0, g_{i}(0) \rightarrow g(0)$ in the $W^{2,2}$ sense, but $g(0)$ is not smooth, and there exists an $1<a=a(B, K)<\infty$ such that $\frac{1}{a} h \leq g_{i}(0) \leq a h$. Hence, Theorem 2.1 is applicable and a limit solution $g(t)_{t \in(0, T)}=\lim _{i \rightarrow \infty} g_{i}(t)_{t \in(0, T)}$ exists with $g(t) \rightarrow g(0)$ in the $W^{2,2}$ sense as $t \searrow 0$. However, the Ricci-Flow of $\ell_{i}(0)=g_{i}(0)$ is $\ell_{i}(t)=\ell_{i}(0)$, as the metric $g_{i}(0)$ is flat. Hence $\ell_{i} \rightarrow \ell$ in the $W^{2,2}$ sense where $\ell(t)=\ell(0)=g(0)$ for all
$t \in(0, T)$ : By construction $g(0)$ is non-smooth. We avoid these non-smooth Gauges by choosing $\Phi(S)=I d$ for some $S>0$ in Theorem 2.3.

In order to prove the relationships of Theorem 2.3, in particular the existence of the limit $\ell_{0}$, we require some new estimates which hold for solutions to Ricci flow of the type constructed here, and for a more general class. The theorems, lemmata that we use to prove these estimates are contained in Section 7.

The existence of the weak metric $\ell_{0}$ is achieved with the following theorem
Theorem 2.5. For all $p \in[2, \infty)$ and $n \in \mathbb{N}$ there exists an $\alpha_{0}(n, p)>0$ such that the following holds. Let $\Omega$ be a smooth $n$-dimensional manifold and $\left(\Omega^{n}, \ell(t)\right)_{t \in(0, T]}$ be a smooth solution to Ricci flow satisfying

$$
\begin{aligned}
& \int_{\Omega}|\operatorname{Rc}(\ell(t))| d \ell(t) \leq \varepsilon \\
& |\operatorname{Rc}(\ell(t))| \leq \frac{\varepsilon}{t} \text { on } \Omega
\end{aligned}
$$

for all $t \in(0, T]$, where $\varepsilon \leq \alpha_{0}$. Then there exists a unique, positive definite, symmetric two tensor $\ell_{0} \in L^{p}$ such that $\ell(s) \rightarrow \ell_{0}$ in $L^{p}(\Omega)$ as $s \searrow 0$ where $\ell_{0}$, and $\ell^{-1}(s) \rightarrow\left(\ell_{0}\right)^{-1}$ in $L^{p}(\Omega)$ as $s \searrow 0$.

Proof. See Theorem 7.1 of Section 7: The proof is given there.

The proof of the existence of a homeomorphism $\Phi(0)$ at time zero in Theorem 2.3 can also be applied with no change, to the setting of a Ricci DeTurck flow coming out of a $C^{0}$ metric on an $n$-dimensional Riemannian manifold, respectively for the Ricci flow related solution. This fact is stated in the following theorem.

Theorem 2.6. For any $n \in \mathbb{N}$ there exists an $\delta_{0}(n)>0$ such that the following holds. Let $\left(M^{n}, h\right)$ be a smooth $n$-dimensional manifold satisfying the assumptions (2.4), where now $\delta_{0}=\delta_{0}(n)$ is a small constant of our choice, and assume $g_{0}$ is a $C^{0}$ metric satisfying $\left(1-\delta_{0}(n)\right) h \leq g_{0} \leq\left(1+\delta_{0}(n)\right) h$. Let $(M, g(t))_{t \in(0, T)}$ be the solution to $(1.1)$, where $g(t) \rightarrow$ $g_{0}$ as $t \searrow 0$ in the $C_{\mathrm{loc}}^{0}$ sense, constructed in [30] or [17], and let $\Phi: M \times(0, T) \rightarrow M$ be the solution to (1.3), with $\Phi(\cdot, T / 2)=I d(\cdot)$. Then there exists a homeomorphism $\Phi(0): M \rightarrow$ $M$ such that $\Phi(t) \rightarrow \Phi(0)$ locally uniformly, and $d(g(t)) \rightarrow d(g(0))=: d_{0}$ locally uniformly and $d(\ell(t)) \rightarrow \tilde{d}_{0}$ locally uniformly as $t \searrow 0$, where $\tilde{d}_{0}(\tilde{x}, \tilde{y})=d_{0}(\Phi(0)(\tilde{x}), \Phi(0)(\tilde{y}))$ for all $\tilde{x}, \tilde{y} \in M$.

Proof. The solutions constructed in [30] respectively [17] satisfy $\left|{ }^{h} \nabla g\right|_{h}^{2}(t)+\left|{ }^{h} \nabla^{2} g\right|_{h}(t) \leq$ $\frac{c\left(\delta_{0}, n\right)}{t}$ where $c\left(\delta_{0}, n\right) \rightarrow 0$ as $\delta_{0} \rightarrow 0$. These facts are required in the proof of (i) of Theorem 8.3. We may now copy and paste the proof of (i) of Theorem 8.3 given in Section 8 to here and in doing so we obtain the existence of a homeomorphism $\Phi(0)$ which is obtained locally uniformly as the limit, in the $C^{0}$ norm, of $\Phi(t)$ with $t \rightarrow 0$.
Also, the solutions constructed in [30] respectively [17] satisfy $g(t) \rightarrow g(0)$ locally uniformly in the $C^{0}$ norm as $t \rightarrow 0$ and hence $d(g(t)) \rightarrow d(g(0))$ locally uniformly, and consequently, $d(\ell(t))=(\Phi(t))^{*}(d(g(t))) \rightarrow \tilde{d}_{0}=(\Phi(0))^{*}\left(d_{0}\right)$ locally uniformly.

In Section 12 we prove the following Theorem, Theorem 2.8, which is an application of the above results. Compare the paper [4] : There, sequences of smooth Riemannian metrics with scalar curvature bounded from below which approach a $C^{0}$ metric with respect to the $C^{0}$ norm are considered. We consider $W^{2,2}$ metrics which have scalar curvature bounded from below in the following weak sense:

Definition 2.7. Let $M$ be a four dimensional smooth closed manifold and $g$ be a $W^{2,2}$ Riemannian metric (positive definite everywhere) and let $k \in \mathbb{R}$. Locally the scalar curvature may be written

$$
\begin{aligned}
\mathrm{R}(g) \quad= & g^{j k}\left(\partial_{i} \Gamma(g)_{j k}^{i}-\partial_{j} \Gamma(g)_{i k}^{i}\right. \\
& \left.+\Gamma(g)_{i p}^{i} \Gamma(g)_{j k}^{p}-\Gamma(g)_{j p}^{i} \Gamma(g)_{i k}^{p}\right)
\end{aligned}
$$

where $\Gamma(g)_{i j}^{m}=\frac{1}{2} g^{m k}\left(\partial_{i} g_{j k}+\partial_{j} g_{i k}-\partial_{k} g_{i j}\right)$, and hence $\mathrm{R}(g)$ is well defined in the $L^{2}$ sense for a $W^{2,2}$ Riemannian metric. Let $k \in \mathbb{R}$. We say the scalar curvature $\mathrm{R}(g)$ is weakly bounded from below by $k, \mathrm{R}(g) \geq k$, if this is true almost everywhere, for all local smooth coordinates.

Theorem 2.8. Let $(M, h)$ be four dimensional closed and satisfy (2.4). Assume that $\left(M, g_{0}\right)$ is a $W^{2,2}$ metric such that $\frac{1}{a} h \leq g_{0} \leq a h$ for some $\infty>a>1$ and $\mathrm{R}\left(g_{0}\right) \geq k$ in the weak sense of definition (2.7). Then the solution $g(t)_{t \in(0, T)}$ to Ricci DeTurck flow respectively $\ell(t)_{t \in(0, T)}$ to Ricci Flow constructed in Theorem 8.3, with initial value $g(0)=g_{0}$, has $\mathrm{R}(g(t)) \geq k$ and $\mathrm{R}(\ell(t)) \geq k$ for all $t \in(0, T)$.

Proof. See Theorem 12.2 : The proof is given there.
Remark 2.9. From this theorem we see that for a metric $g_{0} \in L^{\infty} \cap W^{2,2}\left(M^{4}\right)$ with $\frac{1}{a} h \leq g_{0} \leq a h$ for some positive constant $a>0: g_{0}$ has scalar curvature $\geq k$ in the weak sense of Definition $2.7 \Longleftrightarrow$ there exists a sequence of smooth Riemannian metrics $g_{i, 0}$ with $\frac{1}{b} h \leq g_{i, 0} \leq b h$ for some $1<b<\infty$ and $\mathrm{R}\left(g_{i, 0}\right) \geq k$ and $g_{i, 0} \rightarrow g_{0} \in W^{2,2}\left(M^{4}\right)$ as $i \rightarrow \infty \Longleftrightarrow$ the Ricci DeTurck flow of $g_{0}$ constructed in Theorem 2.1 has $\mathrm{R}(g(t)) \geq k$ for all $t \in(0, T)$.

## 3. Outline of the paper

The paper contains twelve sections and four appendices, A,B,C and D. Section one is an introduction and Section two contains statements of the main results, and this section gives an outline of the paper. In Section 4 we prove a priori $C^{1}$ and $L^{\infty}$ estimates for smooth solutions to the Ricci DeTurck flow. The $L^{\infty}$ estimates we are concerned with in this paper take the form $\frac{1}{b} h \leq g \leq b h$ for some constant $1<b<\infty$, for the fixed background metric $h$ which is used to define the Ricci DeTurck flow in (1.1). In particular we show in Theorem 4.2, that smooth compact solutions which a priori have small local $W^{2,2}$ energy along the flow and satisfy an initial $L^{\infty}$ estimate must also satisfy $L^{\infty}$ and $C^{1}$ estimates along the flow. In the non-compact setting, we require further that the smooth solution satisfies a regularity condition in order to obtain the same result : see Theorem 4.2. In Section 5 we prove various local estimates for integral quantities, assuming our solution satisfies an $L^{\infty}$ bound and has small local $W^{2,2}$ energy: See Theorem 5.1. This also leads to estimates on the convergence as time goes back to zero of the solution, as explained in, for example, Theorem 5.8 and Corollary 5.7. Section 6 uses the a priori estimates of the previous sections with well known existence theory for parabolic equations to show that solutions in the classes considered in those sections exist, even when the initial data is non-smooth. That is, solutions to Ricci DeTurck flow exist, if the initial metric is locally in $W^{2,2}$ and has small local initial energy and satisfies an $L^{\infty}$ bound with respect to $h$. The solutions obtained continue to have small local energy and satisfy an $L^{\infty}$ bound. In Section 7 estimates are proved for solutions to Ricci flow in a setting which includes the class of Ricci flows we construct using the Ricci DeTurck flow of Section 6. In particular, it is shown in the setting of Section 7, that a weak initial value of the Ricci flow exists.

In Section 8 a Ricci flow is constructed from the Ricci DeTurck flow of of Section 6 and in Theorem 8.3, the relationship between the two solutions is investigated. In particular, relations between the distance and the weak Riemannian metrics at time zero, as well as the convergence properties as time goes to zero are stated. Further necessary Lemmata,

Theorems, etc., that we require to prove this theorem are contained in Sections 7, 9 and 10.

Section 9 is concerned with convergence properties of Riemannian metrics in certain Sobolev spaces, and Section 10 is concerned with a definition of distance/respectively convergence properties of distances for Riemannian metrics defined in certain Sobolev spaces. Theorem 11.2 in Section 11 proves uniqueness of the Ricci DeTurck solutions in a class which includes the class of solutions that are constructed in this paper.

In Section 12 we present an application for $W^{2,2} \cap L^{\infty}$ metrics with scalar curvature bounded from below in the weak sense.

Appendix $\mathrm{A}, \mathrm{B}, \mathrm{C}, \mathrm{D}$ are technical appendices containing certain estimates, statements, the calculation/verification of which, are not included in the other sections of the paper, in order to facilitate reading.

Appendix A contains a short time existence result for Ricci DeTurck flow, using the method of W.-X. Shi. In Appendix B we state and prove some facts about Sobolev inequalities and norms thereof adapted to the setting of the paper. Appendix C contains estimates for ordinary differential equations which are required at many points in the paper.

Appendix D contains statements which compare pointwise norms and $L^{p}$ norms of different Riemannian metrics. The estimates contained in the statements are also used at many points of the paper.

## 4. $L^{\infty}$ - and $C^{1}$-estimates of the Ricci DeTurck flow

In this section we derive an a priori $L^{\infty}$ time independent bound on the evolving metric $g$, and show that the gradient thereof is bounded by $\frac{1}{\sqrt{t}}$ under the a priori assumptions that: we have an $L^{\infty}$ bound $\frac{1}{a} h \leq g_{0} \leq a h$ at time zero, the $W^{2,2}$ norm of the solution restricted to balls of radius one are small, and the time interval being considered has small length, where here the notion of small depends on $n$ and $a$.

As a first Lemma, we show that if we already have a $L^{\infty}$ and a time dependent gradient bound, then all other derivatives may be estimated.

Lemma 4.1. Let $(M, h)$ be $n$ dimensional and satisfy (2.4) and $g(\cdot, t)_{t \in[0, T)}, T \leq 1$ be a smooth family of metrics which solves (1.1) and satisfies the a priori bounds

Let $N_{2} \in \mathbb{N}$ be large (to be determined in the proof) and assume that (4.2) doesn't hold. That is, for $N:=N_{2}$, there exists a $0<t_{0}<T$ and an $x_{0} \in M$ such that $\left|{ }^{h} \nabla^{2} g\right|^{2}\left(x_{0}, t_{0}\right)>\frac{N}{t_{0}^{2}}$. Define $\tilde{g}(x, t):=c g\left(x, \frac{t}{c}\right)$ and $\tilde{h}(y)=c h(y)$ for a $c>0$ to be
chosen. Then $\tilde{g}(t)$ solves the $\tilde{h}$-flow for $t \in[0, T c)$ and we have the scaling relations

This implies $\left|{ }^{\tilde{h}} \nabla \tilde{g}\right|^{2}(t) \leq \frac{b}{t} \leq \frac{b}{\sqrt{\frac{N}{V}}-10} \leq \varepsilon$ for $t \in$ $\left(-10+\sqrt{\frac{N}{V}}, \sqrt{\frac{N}{V}}\right]$ for any $\varepsilon>0$ as long as $N=N(b, V, n, \varepsilon)$ is chosen large enough. In that which follows we use once again $g$ to denote the solution $\tilde{g}$ and $h$ to denote $\tilde{h}$. That is, we have a smooth solution $g(t)_{t \in\left[0, \sqrt{\left.\frac{N}{V}\right]}\right.}$ of the Ricci DeTurck flow with

for a ( 0 m ) tensor $T$. We have $|P(h)|^{2}(x, t) \leq c(a, m, n)$ since without loss of generality, the norm of the curvature of $h$ (after scaling ) and all its derivatives up to order $m$ are bounded by a constant (see (2.4)). In particular, for $m=1$ we obtain

Here $c(n, a)$ denotes a constant which may change from line to line but only depends on $n$ and $a$. Combinations of constants involving $b, a, n$ multiplied by $\varepsilon$ shall sometimes be written as $\varepsilon$. In what follows, we restrict ourselves to the region $t \in\left(-10+\sqrt{\frac{N}{V}}, \sqrt{\frac{N}{V}}\right]$.

Using $\left.\sup _{x \in M}\right|^{h} \nabla g \mid(x, t) \leq \varepsilon \leq 1$ for all $t \in\left(-10+\sqrt{\frac{N}{V}}, \sqrt{\frac{N}{V}}\right]$ and $\frac{1}{a} h \leq g \leq a h$ we get

& \left.\leq-\left.\left.\frac{2}{a}\right|^{h} \nabla^{3} g\right|^{2}+\left.c(n, a)\right|^{h} \nabla^{2} g \right\rvert\,\left(\left|{ }^{h} \nabla^{3} g\right|\left(\left.\right|^{h} \nabla g \mid+c(n, a)\right)+\left|{ }^{h} \nabla^{2} g\right|\left(\left.\right|^{h} \nabla^{2} g\left|+\left|{ }^{h} \nabla g\right|^{2}+\left|{ }^{h} \nabla g\right|+c(n, a)\right)\right.\right.  \tag{4.5}\\

where we have used Young's inequality a number of times. Combining these two evolution inequalities, we see that $f=\left(\left.\left.\right|^{h} \nabla g\right|^{2}+1\right)\left(\left.\left.\right|^{h} \nabla^{2} g\right|^{2}\right)$ satisfies

Now using once again that $\left.\sup _{x \in M}\right|^{h} \nabla g \mid(x, t) \leq \varepsilon$, which is true by assumption, we see that

Standard techniques (cut off function and a Bernstein type argument: see [29] or [30]) now show that $f \leq c_{1}(n, a)$ at $t=\sqrt{\frac{N}{V}}$ which implies that $\left|\left.\right|^{h} \nabla^{2} g\right|^{2} \leq c_{1}(n, a)$ at $t=\sqrt{\frac{N}{V}}$ and this contradicts the estimate $\left|{ }^{h} \nabla^{2} g\right|^{2}\left(x_{0}, \sqrt{\frac{N}{V}}\right) \geq V$ if $V=\max \left(100 c_{1}(n, a), r(h, m)\right)$, where $r(h, m)$ is chosen large so that the curvature of $h$ and all of its covariant derivatives up to order $m=2$ are bounded by one after scaling (which was used in the proof).

For the readers convenience, we explain the Bernstein type argument in more detail. By translating in time, we may assume that the time $\sqrt{\frac{N}{V}}$ corresponds to time 10 and the time $\sqrt{\frac{N}{V}}-10$ corresponds to time zero. We multiply $f$ by a cut off function $\eta$ in space
(with support in a Ball $B_{1}\left(y_{0}\right)$ ball around any point $y_{0}$ ) and such that $\frac{\left.h^{h} \nabla \eta\right|^{2}}{\eta} \leq C$. Next we consider a point $\left(x_{0}, t_{0}\right) \in B_{1}(0) \times[0,10]$ where $t \eta f$ achieves its positive maximum (assuming $f$ is not identically zero). The point $x_{0}$ must be in the interior of $B_{1}(0)$, since the support of $\eta$ is contained in $\left.B_{1}(0)\right)$, and $t_{0}$ must be larger than zero, since $t \eta f=0$ for $t=0$, and hence, by calculating at $\left(x_{0}, t_{0}\right)$, we obtain

where we used that ${ }^{h} \nabla_{i}(t f \eta)\left(x_{0}, t_{0}\right)=0$ and Young's inequality. Multipying by $t \eta$, we see that $\frac{1}{4 a}(\eta t f)^{2}\left(x_{0}, t_{0}\right)-c(n, a)(t \eta) f\left(x_{0}, t_{0}\right) \leq c(n, a)$ and hence $f\left(x_{0}, t_{0}\right) \eta\left(x_{0}, t_{0}\right) t_{0} \leq$ $\hat{c}(n, a) \eta\left(x_{0}, t_{0}\right) t_{0}$ which implies $f\left(x_{0}, t_{0}\right) \leq c(n, a)$.

Next we assume by induction that for $i \geq 2$

for all $t \in\left(-10+\sqrt[i+1]{\frac{N}{V}}, \sqrt[i+1]{\frac{N}{V}}\right]$ : The first estimates $\left|{ }^{h} \nabla g\right|^{2}(\cdot, t)+\left.\left.\right|^{h} \nabla^{2} g\right|^{2}(\cdot, t) \leq c / t$ simplify the calculation for general $i \geq 2$ (See (4.3)). Calculating as before we thus obtain for $f:=\left|{ }^{h} \nabla^{i+1} g\right|^{2}\left(1+\left|{ }^{h} \nabla^{i} g\right|^{2}\right)$ that

Now we show that if we have $L^{\infty}$ control on our initial metric and the $L^{2}$ norm of the gradient and the second gradient of $g$ remain locally, uniformly small, then we have an estimate on the $L^{\infty}$ norm of the evolving metric (and its inverse) and a time dependent gradient estimate.

Theorem 4.2. For every $1 \leq a \in \mathbb{R} n \in \mathbb{N}$ there exist (small) $\varepsilon_{0}(a, n), S_{1}(a, n)>0$ such that the following holds. Let $g_{0}$ be smooth and satisfy

where $(M, h)$ is an $n$-dimensional manifold satisfying (2.4), and assume that we have a smooth solution $g$ to (1.1) on $[0, T]$ which satisfies

Remark 4.3. The functions $\varphi(x, t):=g^{i j}(x, t) h_{i j}(x)$ and $F(x, t):=g_{i j}(x, t) h^{i j}(x)$ are both well defined smooth functions. The assumption that

We will use this result in the proof of Theorem 6.1 and in that situation this condition is satisfied.

Proof. We may replace the condition (4.7), by the scale invariant condition

\int_{B_{1}(x)}\left(\left.\left.\right|^{h} \nabla g\right|^{n}+\left.\left.\right|^{h} \nabla^{2} g\right|^{\frac{n}{2}}\right) d h \leq \varepsilon_{0} \tag{4.11}
\end{equation*}
$$

for all $x \in M$ for all $t \in[0, T]$ in view of (v) in Lemma B. 1 of Appendix B, after replacing $c(n) \varepsilon_{0}$ by $\varepsilon_{0}$. Let $\delta=\delta(n, a)=\frac{1}{(a n)^{100}} \ll 1$ (we are assuming $n \geq 2$ ). Let
$S_{1}=\sup \left\{s \in[0, T] \left\lvert\, \frac{1}{20 n a} h \leq g(t) \leq 20 n a h\right.\right.$ and $\left.\left.\sup _{x \in M}\right|^{h} \nabla g\right|^{2}(x, t) \leq \frac{\delta}{t}$ hold on $\left.[0, s]\right\}$.
We have $S_{1}>0$ due to the inequality (4.10) and the fact that $g$ satisfies (1.1). Next we want to show that $S_{1}$ can be bounded from below by a constant depending only on $n$ and $a$.

For this we argue by contradiction and we assume that $S_{1}$ is extremely small, so that if we rescale the background metric $h$ by $1 / S_{1}$, then the resulting Riemannian manifold is as close to the standard euclidean space $\mathbb{R}^{n}$ on balls as large as we like in the $C^{k}$ norm ( $k \in \mathbb{N}$ chosen as we please) in geodesic coordinates, due to the conditions on $h$, as we explained at the beginning of the paper.

Let us now scale $g$ and $h$ via $\tilde{g}(x, t)=c g\left(x, \frac{t}{c}\right), \tilde{h}=c h$ with $c=1 / S_{1} \gg 1$. We denote $\tilde{g}$ and $\tilde{h}$ once again by $g$ resp. $h$. We have for the rescaled solution that $1=S_{1}=\sup \{s \in$ $[0, T) \mid(4.8)$ and (4.9) hold on $[0, s]\}$ and (4.11) still holds, and hence, (4.7) holds, in view
of Hölder's inequality, after replacing $c(n) \varepsilon_{0}$ by $\varepsilon_{0}$. Due to the definition of $S_{1}(=1)$, the smoothness of all metrics and (4.10) we see that,

(a) $g\left(x_{0}, 1\right)(v, v)<\frac{1}{10 n a} h\left(x_{0}\right)(v, v)=\frac{1}{10 n a}$ for some $h$ length one vector $v$, or
(b) $g\left(x_{0}, 1\right)(v, v)>10 n a h(v, v)=10 n a$
for some $h$ length one vector $v$, or
(c) $\left|{ }^{h} \nabla g\right|^{2}\left(x_{0}, 1\right)>\frac{\delta}{2}$,
otherwise, using the the smoothness of $g$ and (4.10), we get a contradiction to the definition of $S_{1}=1$.

We rule out the case (c) first. We argue by contradiction and by the smoothness Lemma 4.1, we know that $\left|{ }^{h} \nabla g\right|^{2}(\cdot, 1) \geq \frac{\delta}{4}$ on a ball of radius $R(n, a, \delta)=R(n, a)>0$ around $x_{0}$, and hence

which leads to a contradiction if $\varepsilon_{0}=\varepsilon_{0}(n, a)$ is chosen small enough. Note that here we used that the manifold is very close to the euclidean space. This contradiction shows that (c) doesn't occur.

Now we rule out (a) and (b). Note that in our case

& \frac{\partial}{\partial t} \int_{B_{1}(x)} F d h \leq c(n, a) \int_{B_{1}(x)}\left(\left.\left.\right|^{h} \nabla g\right|^{2}+\left.\right|^{h} \nabla^{2} g|+|\operatorname{Rm}(h)|) d h \leq C_{S}(n) c(n, a)\left(\varepsilon_{0}\right)^{\frac{2}{n}}\right.
\end{aligned}
$$

and thus

& \leq(3 / 2) \omega_{n} n r a+c(n, a)\left(\varepsilon_{0}\right)^{\frac{2}{n}} \\
& \leq 2 \omega_{n} n a \\
\left(\int_{B_{1}\left(x_{0}\right)} F(x, 1) d h(x)\right) & \leq \int_{B_{1}\left(x_{0}\right)} F_{0} d h+c(n, a)\left(\varepsilon_{0}\right)^{\frac{2}{n}} \\
& \leq(3 / 2) \omega_{n} n a+c(n, a)\left(\varepsilon_{0}\right)^{\frac{2}{n}} \leq 2 \omega_{n} n a
\end{aligned}

if $\varepsilon_{0}(n, a)$ is sufficiently small. Here we used the initial conditions (4.12) and (4.13) freely, and the Hölder and Sobiolev inequalities to obtain $\int_{B_{1}(x)}\left(\left.\left.\right|^{h} \nabla g\right|^{2}+\left|{ }^{h} \nabla^{2} g\right| d h \leq\right.$ $C_{S}(n) c(n, a)\left(\varepsilon_{0}\right)^{\frac{2}{n}}$. In particular, there must be a point $y_{0}$ in $B_{1}\left(x_{0}\right)$ with $\varphi\left(y_{0}, 1\right) \leq 4 n a$ and a point $y_{1}$ in $B_{1}\left(x_{0}\right)$ with $F\left(y_{1}, 1\right) \leq 4 n a$. First we consider $\varphi$. At $y_{0}$ we choose a basis so that $h_{i j}\left(y_{0}\right)=\delta_{i j}$ and $g_{i j}\left(y_{0}, 1\right)=\lambda_{i} \delta_{i j}$ is diagonal. Then we see that $\varphi\left(y_{0}, 1\right) \leq 4 n a$ implies that $\lambda_{i} \geq \frac{1}{4 n a}$ for each $i \in 1, \ldots, n$ and hence $g\left(y_{0}, 1\right) \geq \frac{1}{4 n a} h\left(y_{0}\right)$. Using the
fact that $\left|{ }^{h} \nabla g\right| \leq \delta$ and that $(M, h)$ is very close to the standard $\mathbb{R}^{n}$, in particular $\left|\Gamma(h)_{j k}^{i}(x)\right| \leq \eta_{0}$ in geodesic coordinates on a ball of radius 10 centred at $x_{0}$ where $\eta_{0}$ as small as we like, we get $\left|\partial_{i} g_{k l}\right| \leq \delta+\sigma\left(\eta_{0}, a, n\right)$ with $\sigma\left(\eta_{0}, a, n\right) \rightarrow 0$ as $\eta_{0} \rightarrow 0$ and hence, without loss of generality, $\sigma\left(\eta_{0}, a, n\right) \leq \delta$, that is $\left|\partial_{i} g_{k l}\right| \leq 2 \delta=\frac{2}{(a n)^{100}}$ on $B_{1}\left(x_{0}\right)$ in geodesic coordinates (for $h$ ). This combined with $g\left(y_{0}, 1\right) \geq \frac{1}{4 n a} h\left(y_{0}\right)$, and the fact that $\left(1-\eta_{0}\right) \delta_{i j} \leq h_{i j} \leq\left(1+\eta_{0}\right) \delta_{i j}\left(\eta_{0}\right.$ as small as we like $)$ leads to $g_{i j}(y, 1) \geq\left(\frac{1}{4 n a}-\frac{4}{(a n)^{100}}\right) h_{i j}(y) \geq \frac{1}{8 n a} h_{i j}(y)$ for all $y \in B_{1}\left(x_{0}\right)$ which contradicts the fact that $g\left(x_{0}, 1\right)(v, v)<\frac{1}{10 n a} h\left(x_{0}\right)(v, v)=\frac{1}{10 n a}$. Hence (a) doesn't occur. The argument to show that (b) doesn't occur is essentially the same.

## 5. Preservation of smallness of the $W^{2,2}$ Energy and $W^{2,2}$ continuity of $g$ IN TIME

In this section we consider smooth four dimensional solutions to the Ricci DeTurck flow which satisfy $\frac{1}{a} h \leq g(t) \leq a h$ for some uniform constant $a$ and our fixed background metric $h$, and whose initial $W^{2,2}$-energy is locally small. Under these assumptions, we prove an estimate on the growth of the local $W^{2,2}$-energy, which shows that this smallness is preserved under the flow, if the time interval being considered is small enough. We see, in Theorem 5.6 and Theorem 5.8, that these estimates also imply estimates on the modulus of continuity of the local $L^{2}$ and $W^{2,2}$-energy of a solution, respectively limits of smooth solutions to (1.1).

Theorem 5.1. Let $(M, h)$ be four dimensional and satisfy (2.4). For all $0<a \in \mathbb{R}$, there exists a $\delta=\delta(a)>0$ such that for any smooth solution $g \in C^{\infty}(M \times[0, T))$ of the Ricci-DeTurck flow with

& \frac{1}{a} h(\cdot) \leq g(\cdot, t) \leq a h(\cdot)
\end{aligned}
$$

for all $t \in[0, T)$, the following holds : For every $\frac{1}{2} \leq R_{0}<R_{1} \leq 2$ there exists an $V\left(R_{0}, R_{1}, a\right)>0$ such that

\end{aligned}

for any $x_{0} \in M$, for all $t \in[0, T)$.
Remark 5.2. The condition $\sup _{x \in M} \int_{B_{1}(x)}\left(\left.\left.\right|^{h} \nabla g(\cdot, t)\right|^{2}+\left.\left.\right|^{h} \nabla^{2} g(\cdot, t)\right|^{2}\right) d h \leq \delta$ means we restrict to the class of solutions which stay locally small in $W^{2,2}$. Later we will see that this is not a restriction for the solutions that we construct, starting with initial data which is locally sufficiently small in $W^{2,2}$, as they do indeed satisfy this condition.

Remark 5.3. The constant $V\left(R_{0}, R_{1}, a\right) \rightarrow \infty$ for $R_{0} \nearrow R_{1}$.
Corollary 5.4. Let $(M, h)$ be four dimensional and satisfy (2.4). For all $0<b \in \mathbb{R}$, there exists a $\delta=\delta(b)>0$ and universal constant $c_{0}>0$ such that the following holds. For every $\varepsilon>0$ there exists an $S_{2}=S_{2}(b, \varepsilon)>0$ such that if $g \in C^{\infty}(M \times[0, T))$ is a smooth solution to the Ricci-DeTurck flow with initial data $g_{0}$ which satisfies

for all $t \in[0, T)$, and for some $x_{0} \in M$ we have

for all $t \in\left[0, S_{2}\right) \cap[0, T)$.

Proof of Corollary 5.4. Theorem 5.1 implies

& \leq \varepsilon+V(1,2, b) t \\
& \leq \frac{3}{2} \varepsilon
\end{aligned}

for $t \leq \frac{\varepsilon}{2 V(1,2, b)}=: S_{2}$
Before proving Theorem 5.1 we need a version of the Gagliardo-Nirenberg inequality.
Lemma 5.5. Let $(M, h)$ be four dimensional and satisfy (2.4), $\frac{1}{2} \leq R_{0}<R_{1} \leq 2$ and $g$ be a smooth metric on $M$ satisfying $\frac{1}{a} g \leq h \leq a g, x \in M$ and $\eta \in C_{c}^{\infty}\left(B_{R_{1}}\left(x_{0}\right)\right)$ be a standard cut-off function which is equal to 1 on $B_{R_{0}}(x)$ and equal to zero outside of $B_{\frac{R_{1}+R_{0}}{2}}\left(x_{0}\right)$ : We choose $\eta$ so that $\sqrt{\eta} \in C^{\infty}\left(B_{R_{1}}(x)\right)$ with $\left.\right|^{h} \nabla \eta \mid \leq c\left(R_{1}, R_{0}\right)$ for some constant $c\left(R_{1}, R_{0}\right)$. Then there exists a $C=C\left(a, R_{0}, R_{1}\right)$ and a $B=B(a)$ such that

Proof of Lemma 5.5. In the following $C$ refers to a constant which depends on $a, R_{0}, R_{1}$ and $B$ refers to a constant which only depends on $a$. Both constants may vary from line to line, but continue to be denoted by $C$ respectively $B$. Using Hölder's inequality and the Sobolev inequality applied to the function $f=\left.\eta^{2}\right|^{h} \nabla^{2} g \mid$, we obtain

which is the first estimate. For the second estimate we integrate by parts with respect one of the covariant derivatives ${ }^{h} \nabla$ and use Hölder's inequality, to get

\end{aligned}

Using (5.1) to estimate the first term of the right hand side of this inequality, and the Sobolev inequality, applied to the function $\left.\sqrt{\eta}\right|^{h} \nabla g \mid$ to estimate the second term, we conclude

\leq & B\left(\left.\left.\int_{B_{R_{1}(x)}}\right|^{h} \nabla^{2} g\right|^{2} d h\right)^{\frac{1}{2}}\left(\int_{B_{R_{1}(x)}}\left(\left.\left.\eta^{4}\right|^{h} \nabla^{3} g\right|^{2}+\left.\left.C\right|^{h} \nabla^{2} g\right|^{2}\right) d h\right) \\
& +C\left(\int_{B_{R_{1}}(x)}\left|{ }^{h} \nabla g\right|^{2} d h\right)^{\frac{1}{2}}\left(\int_{B_{R_{1}}(x)}\left(\left.\left.\right|^{h} \nabla^{2} g\right|^{2}+\left.\left.\right|^{h} \nabla g\right|^{2}\right) d h\right),

as required. Note, with loss of generality $\left|{ }^{h} \nabla \sqrt{\eta}\right| \leq C_{1}(n=4)$ : if not replace $\eta$ by $\eta^{2}$.

In the following proof, $C$ will once again be a constant which may change from line to line and depends on $a, R_{0}, R_{1}$, and $B$ denotes a constant which can change from line to line but only depends on $a$.

& \quad \leq\left.\left.\frac{1}{2 a}\right|^{h} \nabla^{2} g\right|^{2}+B\left(\left.\left.\right|^{h} \nabla g\right|^{4}+1\right) \tag{5.2}

for $\eta$ a standard cut-off function as in Lemma 5.5. Multiplying the above differential inequality (5.2) with $\eta^{4}$, integrating and using the inequality (5.3), we get

where we used the Sobolev inequality, applied to the function $f=\left.\sqrt{\eta}\right|^{h} \nabla g \mid$, and $\left.\left.\right|^{h} \nabla \sqrt{\eta}\right|^{2}=$ $\frac{\left.\left.\right|^{h} \nabla \eta\right|^{2}}{4 \eta} \leq C$ in the last step. Absorbing the first term on the right hand side into the left hand side and integrating from 0 to $S$ we conclude

The previous Lemma showed us that solutions which are smooth on $M \times[0, T]$ and whose $W^{1,2}$ energy is bounded on balls of radius one by $\delta$, and which are uniformly (independent of time) equivalent to $h, \frac{1}{a} h \leq g(t) \leq a h$, converge strongly in the $L^{2}$ norm back to $g_{0}$ as time goes to zero, and the rate of convergence depends only on $a, n$ and $\delta$. If we only assume that the solution is smooth on $M \times(0, T)$, then the previous Lemma shows us that the solution is Cauchy in the $L^{2}\left(B_{1}(x)\right)$ norm in time, and hence there exists a well defined $L_{l o c}^{2}$ limit, $g_{0}$ at time $t=0$ on $M$. In the four dimensional setting, the assumption that the solution is bounded in $W^{2,2}\left(B_{1}(x)\right)$ for all $x \in M$ means that there must be a sequence of times $t_{i}$, such that $g\left(t_{i}\right)$ converge weakly in $H:=W^{2,2}\left(B_{1}(x)\right)$ back to $g_{0} \in H$ (the details are given in the proof of Theorem 5.8.). The estimates of Lemma 5.5, show us that in fact the convergence is also strong in $W_{l o c}^{2,2}$, if the solution is a limit of smooth solutions, whose initial data converge locally strongly in $W^{2,2}$, as is explained in the following theorem. Note that this is precisely the situation which we study in the next section.

Theorem 5.8. For all $0<a \in \mathbb{R}$ there exists $\delta=\delta(a)$ so that the following holds. Let $(M, h)$ be four dimensional and satisfy (2.4) and $(M, g(t), p)_{t \in(0, T]}$ be the smooth limit, on compact subsets of $M \times(0, T]$, of $\left.\left(M, g(i)(t), p_{i}\right)\right|_{t \in(0, T]}$ as $i \rightarrow \infty$ of a sequence of smooth solutions $g(i)$ to (1.1) defined on $M \times[0, T]$ which satisfy

Then, $g(t) \rightarrow g_{0}$ as $t \searrow 0$ locally strongly in the $W^{2,2}$ norm, that is

& \int_{B_{R_{0}}\left(x_{0}\right)}\left(\left.\left.\right|^{h} \nabla g(\cdot, t)\right|^{2}+\left.\left.\right|^{h} \nabla^{2} g(\cdot, t)\right|^{2}+|g(t)|^{2}\right) d h \\
& \leq \int_{B_{R_{1}}\left(x_{0}\right)}\left(\left|{ }^{h} \nabla g_{0}\right|^{2}+\left.\left.\right|^{h} \nabla^{2} g_{0}\right|^{2}+\left|g_{0}\right|^{2}\right) d h+V\left(R_{0}, R_{1}, a\right) t \tag{5.7}
\end{align*}
$$

for any $x_{0} \in M$, for all $t \in(0, T)$, that is

$$
\begin{equation*}
\|g(t)\|_{W^{2,2}\left(B_{R_{0}}\left(x_{0}\right)\right)}^{2} \leq\left\|g_{0}\right\|_{W^{2,2}\left(B_{R_{1}}\left(x_{0}\right)\right)}^{2}+V\left(R_{0}, R_{1}, a\right) t \tag{5.8}
\end{equation*}
$$

for any $x_{0} \in M$, for all $t \in(0, T)$, where $\|T\|_{W^{2,2}\left(B_{R_{0}}\left(x_{0}\right)\right)}^{2}:=\int_{B_{R_{0}}\left(x_{0}\right)}\left(|T|_{h}^{2}+\left.\left.\right|^{h} \nabla T\right|^{2}+\right.$ $\left.\left.\left.\right|^{h} \nabla^{2} T\right|^{2}\right) d h$ for any zero-two tensor defined on $B_{R_{0}}\left(x_{0}\right)$ whose components are in $W^{2,2}$. Furthermore, we have $\int_{B_{1}\left(x_{0}\right)}\left|g(t)-g_{0}\right|^{2} d h \rightarrow 0$ for $t \searrow 0$ in view of Corollary 5.7, and the fact that $g(i)(0) \rightarrow g_{0}$ as $i \rightarrow \infty$ in the $W_{l o c}^{2,2}$ norm.

Fixing $x_{0} \in M$, and $R_{0}:=1$ we define the Hilbert space $H:=W^{2,2}\left(B_{1}\left(x_{0}\right)\right)$ to be the space of zero-two tensors whose components are in $W^{2,2}\left(B_{1}\left(x_{0}\right)\right)$ and whose scalar product is defined by $(T, S)_{H}:=\int_{B_{1}\left(x_{0}\right)}(T, S)_{h}+\left({ }^{h} \nabla T,{ }^{h} \nabla S\right)_{h}+\left({ }^{h} \nabla^{2} T,{ }^{h} \nabla^{2} S\right)_{h} d h$. Using this notation, we may write (5.7) as

(g(t), g(t))_{H} \leq\left\|g_{0}\right\|_{W^{2,2}\left(B_{R_{1}}\left(x_{0}\right)\right)}^{2}+V\left(R_{0}, R_{1}, a\right) t \tag{5.9}
\end{equation*}
$$

for all $t \in(0, T)$, for any $2>R_{1}>R_{0}=1$. We are going to show that every sequence $\left(g\left(t_{i}\right)\right)_{i \in \mathbb{N}}$ with $t_{i} \searrow 0$ contains a strongly converging subsequence with limit $g_{0}$ in $H$. This then clearly implies that $g(s) \rightarrow g_{0}$ in $H$ as $s \searrow 0$ since otherwise we can find a sequence $t_{i} \rightarrow 0$, and a $\delta>0$ s.t. $\left\|g\left(t_{i}\right)-g_{0}\right\|_{H}>\delta$, and hence no subsequence of $g\left(t_{i}\right)$ will converge to $g_{0}$ in $H$, which would be a contradiction.

Now to the details. For any sequence of times $0<t_{i} \rightarrow 0$ as $i \rightarrow \infty$, there exists a subsequence, $g\left(t_{i_{j}}\right)=$ : $g_{i_{j}}$ of $g\left(t_{i}\right)$ such that $g_{i_{j}} \rightharpoonup z$ as $j \rightarrow \infty$ for some $z \in H$, in view of the definition of a Hilbert space and weak convergence.

But $g_{i_{j}}$ must then converge strongly to $z$ in $L^{2}\left(B_{1}\left(x_{0}\right)\right)$ and hence $z=g_{0}$. Setting $r_{j}:=t_{i_{j}}$ this means we have $g\left(r_{j}\right) \rightarrow g_{0}$ strongly in $L^{2}\left(B_{1}\left(x_{0}\right)\right)$ and $g\left(r_{j}\right) \rightharpoonup g_{0}$ weakly in $H$. It remains to show that $g\left(r_{j}\right) \rightarrow g_{0}$ strongly in $H=W^{2,2}\left(B_{1}\left(x_{0}\right)\right)$ for all $x_{0} \in M$.

Assume that this is not true for some $x_{0} \in M$. Then we can find a subsequence $s_{k}:=r_{i_{k}}$, $k \in \mathbb{N}$ of $\left(r_{k}\right)_{k \in \mathbb{N}}$ and a $\delta>0$ such that $\left\|g\left(s_{k}\right)-g_{0}\right\|_{H}^{2} \geq \delta>0$ for all $k \in \mathbb{N}$. But then

\delta \quad & \leq\left(g\left(s_{k}\right)-g_{0}, g\left(s_{k}\right)-g_{0}\right)_{H} \\
& =\left(g\left(s_{k}\right), g\left(s_{k}\right)\right)_{H}+\left(g_{0}, g_{0}\right)_{H}-2\left(g\left(s_{k}\right), g_{0}\right)_{H} \\
& =\left\|g\left(s_{k}\right)\right\|_{H}^{2}+\left\|g_{0}\right\|_{H}^{2}-2\left(g\left(s_{k}\right), g_{0}\right)_{H}
\end{aligned}
$$

for all $k \in \mathbb{N}$, and hence, using (5.9),

$$
\begin{equation*}
\delta \quad \leq\left\|g_{0}\right\|_{W^{2,2}\left(B_{R_{1}}\left(x_{0}\right)\right)}^{2}+\left\|g_{0}\right\|_{H}^{2}-2\left(g\left(s_{k}\right), g_{0}\right)_{H}+V\left(1, R_{1}, a\right) s_{k} \tag{5.10}
\end{equation*}
$$

Since $g_{0}$ in $W^{2,2}\left(B_{2}\left(x_{0}\right)\right)$ (here we use the covering argument from Lemma B.1), there must exist a $1<R_{1}<2$ such that

$$

and hence we obtain

$$

for this choice of $R_{1}$ independent of $k \in \mathbb{N}$. Letting $k \rightarrow \infty$, we obtain a contradiction, since $2\left\|g_{0}\right\|_{H}^{2}-2\left(g\left(s_{k}\right), g_{0}\right)_{H} \rightarrow 0$ as $k \rightarrow \infty$.

## 6. Existence and Regularity

In this section we prove the main results for the Ricci DeTurck flow of data which is initially $W^{2,2}$.

Theorem 6.1. Let $1<a<\infty$ and ( $M, h$ ) be four dimensional and satisfy (2.4). Then there exists a constant $\varepsilon_{1}=\varepsilon_{1}(a)>0$ with the following properties. Assume $g_{0}$ is a smooth Riemannian metric on $M$ which is uniformly bounded in $W_{\mathrm{loc}}^{2,2} \cap L^{\infty}$ in the following sense:

& \int_{B_{2}(x)}\left(\left.\left.\right|^{h} \nabla g_{0}\right|^{2}+\left.\left.\right|^{h} \nabla^{2} g_{0}\right|^{2}\right) d h \leq \varepsilon \quad \text { for all } \quad x \in M \tag{b}
\end{align*}
$$

where $\varepsilon \leq \varepsilon_{1}(a)$, and $g_{0}$ satisfies

$$
\left.\sup _{M}| |^{h} \nabla^{i} g_{0}\right|^{2}<\infty
$$

for all $i \in N$. Then there exists constants $T=T(a, \varepsilon)>0$ and $c_{j}=c_{j}(a, h)>0$, and $a$ smooth solution $(g(t))_{t \in[0, T]}$ to (1.1) with $g(\cdot, 0)=g_{0}(\cdot)$ such that
$\left(\mathrm{a}_{t}\right) \quad \frac{1}{400 a} h \leq g(t) \leq 400 a h$
$\left(\mathrm{b}_{t}\right) \quad \int_{B_{1}(x)}\left(\left.\left.\right|^{h} \nabla g(\cdot, t)\right|^{2}+\left.\left.\right|^{h} \nabla^{2} g(\cdot, t)\right|^{2}\right) d h<2 \varepsilon \quad$ for all $x \in M, t \in[0, T]$
$\left(\mathrm{c}_{t}\right) \quad\left|{ }^{h} \nabla^{j} g(\cdot, t)\right|^{2} \leq \frac{c_{j}(a, h)}{t^{j}}$
and

$$
\left.\left.\sup _{M}\right|^{h} \nabla^{j} g(t)\right|^{2}<\infty
$$

for all $j \in N$ for all $t \in[0, T]$.

Proof. Using the existence theory for Parabolic equations, for example the method of Shi, Theorem [29] Section 3 and 4 (which in turn uses Theorem 7.1, Section VII of [19] ) we see that we have a solution to (1.1) for a short time $[0, V]$ for some $V>0$ and $\left.\left.\sup _{M \times[0, V]}\right|^{h} \nabla^{j} g\right|^{2}<\infty$ for all $j \in \mathbb{N}$ : See Theorem A.1. We assume, without loss of generality, that $\varepsilon_{1}(a) \leq \frac{\varepsilon_{0}}{4}=\frac{\varepsilon_{0}(a, 4)}{4}$, where $\varepsilon_{0}$ is the constant from Theorem 4.2. Let $\hat{S}:=\sup \left\{t \in[0, V] \mid\left(\mathrm{b}_{t}\right)\right.$ holds for $\left.t \leq \hat{S}\right\}: \hat{S}>0$ due to smoothness (and boundedness of covariant derivatives of $g$ ). We have $\left|{ }^{h} \nabla g(\cdot, t)\right| \leq \frac{1}{t}$ and $\frac{1}{80 a} h \leq g(t) \leq 80 a h$, for $t \leq \min \left(\hat{S}, S_{1}(4, a)\right)$, in view of Theorem 4.2, where $S_{1}(4, a)$ is the constant from that theorem. Hence, for such $t \leq \min \left(S_{1}(4, a), \hat{S}\right)$, we have $\left|{ }^{h} \nabla^{i} g(\cdot, t)\right|^{2} \leq \frac{N_{i}(80 a, 1,4, h)}{t^{i}}$ in view of Lemma 4.1. Also, using Corollary 5.4 with $b=80 a$, we can improve the estimate $\left(\mathrm{b}_{t}\right)$ to $\int_{B_{1}(x)}\left(\left.\left.\right|^{h} \nabla g\right|^{2}+\left|{ }^{h} \nabla g\right|^{2}\right) d h \leq \frac{3}{2} \varepsilon<2 \varepsilon$, for $t \leq \min \left(S_{1}(4, a), \hat{S}, S_{2}(b=80 a, \varepsilon)\right)$, where $S_{2}(b, \varepsilon)>0$ is the constant from that Corollary, since $2 \varepsilon \leq 2 \varepsilon_{1}(a)<\varepsilon_{0}$ and
without loss of generality, $\varepsilon_{0} \leq \delta=\delta(80 a)$, where $\delta$ is the constant appearing in that corollary. Hence $\hat{S} \geq \min \left(S_{1}(4, a), V, S_{2}(b=80 a, \varepsilon)\right)$, and $\left(\mathrm{a}_{t}\right),\left(\mathrm{b}_{t}\right)$ and ( $\mathrm{c}_{t}$ ) hold for $t \leq \min \left(S_{1}(4, a), V, S_{2}(b=80 a, \varepsilon)\right)$, with $c_{1}=2, c_{i}=N_{i}(80 a, 1,4, h)$ for all $i \in \mathbb{N}, i \geq 2$. Applying Theorem A. 1 and repeating this argument as often as necessary, we may extend this solution to a smooth solution $g(t)_{t \in[0, T]}$ satisfying $\left(\mathrm{a}_{t}\right),\left(\mathrm{b}_{t}\right)$ and $\left(\mathrm{c}_{t}\right)$ for $t \leq T:=$ $\min \left(S_{1}(4, a), S_{2}(b=80 a, \varepsilon)\right)$. The estimates $\left.\left.\sup _{M \times[0, V]}\right|^{h} \nabla^{j} g\right|^{2}<\infty$ for all $j \in \mathbb{N}$ and $\left(\mathrm{c}_{t}\right)$ guarantee that $\left.\left.\sup _{M \times[0, T]}\right|^{h} \nabla^{j} g\right|^{2}<\infty$ for all $j \in \mathbb{N}$.

Remark 6.2. In the proof of Theorem 6.1 we obtained $\int_{B_{1}(x)}\left(\left|{ }^{h} \nabla g(\cdot, t)\right|^{2}+\left.\left.\right|^{h} \nabla^{2} g(\cdot, t)\right|^{2}\right) d h<$ $\frac{3}{2} \varepsilon \quad$ for all $x \in M, t \in[0, T]$, and $\frac{1}{80 a} h g(t) \leq 80 a h$ for $t \in[0, T]:$ we will use these facts in the proof of the next theorem.

Theorem 6.3. Let $(M, h)$ be four dimensional and satisfy (2.4) and $\infty>a>1$. Assume $g_{0}$ is a $W_{\mathrm{loc}}^{2,2} \cap L^{\infty}$ Riemannian metric, not necessarily smooth, which satisfies (a) and (b), where $\varepsilon \leq \frac{\varepsilon_{1}(2 a)}{2}$ and $\varepsilon_{1}$ is the constant from Theorem 6.1.

Then there exists a constant $S=S(a, \varepsilon)>0$ and a smooth solution $(g(t))_{t \in(0, S]}$ to (1.1), where $g(t)$ satisfies $\left(\mathrm{a}_{t}\right),\left(\mathrm{b}_{t}\right)$ and $\left(\mathrm{c}_{t}\right)$ for all $x \in M$, for all $t \in(0, S]$, and

$$
\begin{equation*}
\int_{B_{1}(x)}\left(\left|g_{0}-g(t)\right|^{2}+\left.\left.\right|^{h} \nabla\left(g_{0}-g(t)\right)\right|^{2}+\left.\left.\right|^{h} \nabla^{2}\left(g_{0}-g(t)\right)\right|^{2}\right) d h \rightarrow 0 \tag{t}
\end{equation*}
$$

as $t \searrow 0$ for all $x \in M$. The solution is unique in the class of solutions satisfying $\left(\mathrm{a}_{t}\right),\left(\mathrm{b}_{t}\right),\left(\mathrm{c}_{t}\right)$ and $\left(\mathrm{d}_{t}\right)$. The solution also satisfies the local estimates

$$
\begin{align*}
& \sup _{x \in B_{1}\left(x_{0}\right)}\left|{ }^{h} \nabla^{j} g(\cdot, t)\right|^{2} t^{j} \rightarrow 0 \text { for } t \rightarrow 0  \tag{t}\\
& \int_{B_{1}\left(x_{0}\right)}\left(\left.\left.\right|^{h} \nabla g(\cdot, t)\right|^{2}+\left|{ }^{h} \nabla^{2} g(\cdot, t)\right|^{2}\right) d h \\
& \leq \int_{B_{R}\left(x_{0}\right)}\left(\left|{ }^{h} \nabla g_{0}(\cdot)\right|^{2}+\left|{ }^{h} \nabla^{2} g_{0}(\cdot)\right|^{2}\right) d h+V(a, R) t
\end{align*}
$$

for all $x_{0} \in M, 2>R>1$ for all $t \leq T$, for some constant $0<V(a, R)<\infty$.

Proof. Let $R>0$ be given, and $\eta: M \rightarrow[0,1] \subseteq \mathbb{R}$ be a smooth cut-off function as in (iv) of Lemma B.1: $\eta=1$ on $B_{R}\left(x_{0}\right), \eta=0$ on $M \backslash\left(B_{C R}\left(x_{0}\right)\right),\left.\right|^{h} \nabla^{2} \eta\left|+\left.\right|^{h} \nabla \eta\right|^{2} / \eta \leq \frac{C}{R^{2}}$ on $M$ (here $n=4$ ), $\left|{ }^{h} \nabla^{i} \eta\right|^{2} \leq c_{i}(h)$ for all $i \in \mathbb{N}$. We mollify the metric $g_{0}$ everywhere locally, to obtain a metric $\hat{g}_{0, R}$, which is smooth, and then define $g_{0, R}(\cdot):=\eta(\cdot) \hat{g}_{0, R}(\cdot)+(1-\eta(\cdot)) h(\cdot)$. We choose the mollification fine enough to guarantee that $g_{0, R}(\cdot) \rightarrow g_{0}$ in $W^{2,2}\left(B_{r}(0)\right)$ for all $r>0$ fixed as $R \rightarrow \infty$ and so that (a), and (b) still hold for $g_{0, R}$ up to a factor $\frac{10}{9}$, for all $R>0$ sufficiently large. That is we have

$$
\begin{align*}
& \frac{9}{10 a} h \leq g_{0, R} \leq \frac{10}{9} a h  \tag{a}\\
& \int_{B_{2}(x)}\left(\left.\left.\right|^{h} \nabla g_{0, R}\right|^{2}+\left.\left.\right|^{h} \nabla^{2} g_{0, R}\right|^{2}\right) d h \leq \frac{10}{9} \varepsilon \quad \text { for all } \quad x \in M \tag{b}
\end{align*}
$$

Furthermore $g_{0, R}=h$ outside of $B_{C R}\left(x_{0}\right)$ and so $\left.\left.\sup _{M}\right|^{h} \nabla^{j} g_{0, R}\right|^{2}<\infty$ for all $j \in \mathbb{N}$.
Theorem 6.1, with $a$ replaced by $\frac{10}{9} a$ and $\varepsilon$ by $\frac{10}{9}$, and Remark 6.2, guarantee the existence of a solution $\left(g_{R}(t)\right)_{t \in[0, T]}$ with $T=T(a, \varepsilon)>0$ to (1.1) satisfying $\left(\mathrm{a}_{t}\right),\left(\mathrm{b}_{t}\right)$ and $\left(\mathrm{c}_{t}\right)$ for all $x \in M$, for all $t \in[0, T]$, with $g_{R}(0)=g_{0, R}$ : Note that the constants $c_{j}\left(\frac{10}{9} a, h\right)$ of $\left(c_{t}\right)$ do not depend on $R$. Hence there exists a limit solution $\left(M, g(t)_{t \in(0, T]}\right.$ (in the $C_{l o c}^{\infty}$ sense on $M \times(0, T)$ ), by taking the sequence of radii $R(i)=i \rightarrow \infty$, which satisfies $\left(\mathrm{a}_{t}\right),\left(\mathrm{b}_{t}\right)$ and $\left(\mathrm{c}_{t}\right)$ for all $x \in M$, for all $t \in(0, T]$. Theorem 5.1 applied to each
$g_{R(i)}$ implies $\left(\mathrm{f}_{t}\right)$, and Theorem 5.8 implies $\left(\mathrm{d}_{t}\right)$, for the limit solution $g(t)_{t \in(0, T]}$. Note without loss of generality, that $\varepsilon_{1}(2 a)$ from Theorem 6.1 is less than $\frac{\delta(400 a)}{c(a, n)}$, where $\delta$ is the constant from Theorem 5.1, and $c(a, n)$ is a large constant of our choice. Hence, without loss of generality, the scale invariant condition

$$

\left(\int_{B_{1}(x)}\left|{ }^{h} \nabla g(\cdot, t)\right|^{4} d h\right)^{\frac{1}{2}}+\left.\left.\int_{B_{1}(x)}\right|^{h} \nabla^{2} g(\cdot, t)\right|^{2} d h \leq \frac{\delta(400 a)}{c(a, n)} \tag{6.1}
\end{equation*}
$$

holds for all $x \in M$, for all $t \in(0, T]$, in view of (v) from Lemma B.1. For any $x \in M$ we claim that

$$
\sup _{B_{1}(x)}\left(\left.\left.t\right|^{h} \nabla g(\cdot, t)\right|^{2}\right) \rightarrow 0 \text { as } t \searrow 0
$$

Assume that this is not the case for some $x \in M$. Then we obtain a sequence of points $y_{j} \in B_{1}(x) \subseteq M$ and $0<t_{j} \rightarrow 0$ for $j \in \mathbb{N}, j \rightarrow \infty$ and an $r>0$ such that $\left.\left.t_{j}\right|^{h} \nabla g\left(y_{j}, t_{j}\right)\right|^{2} \geq r>0$. Taking a subsequence we see $y_{j} \rightarrow y \in M$ and hence $\int_{B_{2 \sqrt{t_{j}}}\left(y_{j}\right)}\left(\left|{ }^{h} \nabla g_{0}\right|^{4}+\left.\left.\right|^{h} \nabla^{2} g_{0}\right|^{2}\right) d h \rightarrow 0$ as $j \rightarrow \infty$. Scale the solution to time 1: that is we define $g_{j}(\cdot, \tilde{t})=\frac{1}{t_{j}} g\left(\cdot, t_{j} \tilde{t}\right), h_{j}(\cdot)=\frac{1}{t_{j}} h(\cdot)$ and $g_{j, 0}=\frac{1}{t_{j}} g_{0}$. Now we have $\left|\left.\right|^{h_{j}} \nabla g_{j}\left(y_{j}, 1\right)\right|^{2} \geq$ $r>0$ and $\int_{B_{2}\left(y_{j}\right)}\left(\left.\left.\right|^{h} \nabla g_{j, 0}\right|^{4}+\left|{ }^{h} \nabla^{2} g_{j, 0}\right|^{2}\right) d h \rightarrow 0$ as $j \rightarrow \infty$, and $\frac{1}{400 a} h_{j}(\cdot) \leq g_{j}(\cdot, t) \leq$ $400 a h_{j}(\cdot)$ for all $t$ where the solution is defined. Theorem 5.1, and the fact that (6.1) also holds for the scaled solutions, now implies that $\left.\left.\int_{B_{1}\left(y_{j}\right)}\right|^{h_{j}} \nabla g_{j}(\cdot, 1)\right|^{2}+\left.\left.\right|^{h_{j}} \nabla^{2} g_{j}(\cdot, 1)\right|^{2} d h_{j} \rightarrow 0$ as $j \rightarrow \infty$, and $\frac{1}{400 a} h_{j}(\cdot) \leq g_{j}(\cdot, t) \leq$ $400 a h_{j}(\cdot)$ for all $t$ where the solution is defined. But these estimates combined with $\left(\mathrm{c}_{t}\right)$ then imply that $\left.\left.\right|^{h_{j}} \nabla^{k} g_{j}\left(y_{j}, 1\right)\right|^{2} \rightarrow 0$ for all $k \in \mathbb{N}$ as $j \rightarrow \infty$, which is a contradiction : To see this, one can write all quantities in geodesic coordinates with respect to the metric $h_{j}$ centred at $y_{j}$. The estimate $\sup _{B_{1}(x)}\left(\left.\left.t^{j}\right|^{h} \nabla^{j} g(\cdot, t)\right|^{2}\right) \rightarrow 0$ as $t \searrow 0$ for the other $j \in \mathbb{N}$ follow from an almost identical argument. That is $\left(\mathrm{e}_{t}\right)$ also holds. The uniqueness of the solution in the class of solutions satisfying $\left(\mathrm{a}_{t}\right),\left(\mathrm{b}_{t}\right),\left(\mathrm{c}_{t}\right)$ and $\left(\mathrm{d}_{t}\right)$ follows immediately from Theorem 11.2.

Remark 6.4. In fact the constants $c_{j}(h, a)$ in $\left(c_{t}\right)$ of Theorem 6.3 can be replaced by $c_{j}(h, a, \varepsilon)$ where $c_{j}(h, a, \varepsilon) \rightarrow 0$ as $\varepsilon \rightarrow 0:$

Assume $g_{i}(t)_{t \in\left(0, T\left(\frac{1}{i}, a\right)\right]}$ are solutions obtained in Theorem 6.3 with $\varepsilon$ in $\left(\mathrm{b}_{t}\right)$ given by $\varepsilon=\frac{1}{i}$ and assume $\left|{ }^{h} \nabla g_{i}\left(x_{i}, t_{i}\right)\right|^{2} \geq \frac{\alpha}{t_{i}}>0$ for a $t_{i} \in\left(0, T\left(\frac{1}{i}, a\right)\right]$ for some $\alpha>0$. From Theorem B. 1 (v), we have $\left.\left.\int_{B_{1}(x)}\right|^{h} \nabla g_{i}(\cdot, t)\right|^{4}+\left.\left.\right|^{h} \nabla g_{i}^{2}(\cdot, t)\right|^{2} \leq 2 \frac{1}{i}$ for all $t \in\left(0, T\left(\frac{1}{i}, a\right)\right]$. Scaling the solutions by $\hat{g}_{i}(t):=\frac{1}{t_{i}} g_{i}\left(t t_{i}\right)$, we obtain smooth solution defined on $(0,1]$ which satisfying $\left.\left.\right|^{h_{i}} \nabla^{j} \hat{g}_{i}(\cdot, 1)\right|^{2} \leq c_{j}$ for all $j \in \mathbb{N}$ in view of $\left(c_{t}\right)$, and $\left.\left.\right|^{h_{i}} \nabla \hat{g}_{i}\left(x_{i}, 1\right)\right|^{2} \geq \alpha$ and $\int_{B_{1}(x)}\left(\left.\left.\right|^{h_{i}} \nabla \hat{g}_{i}(\cdot, 1)\right|^{4}+\left.\left.\right|^{h_{i}} \nabla \hat{g}_{i}^{2}(\cdot, 1)\right|^{2}\right) d_{h_{i}}(x) \leq 2 \frac{1}{i}$ for all $x \in M$, where we denote the scaled metric $\frac{1}{t_{i}} h$ by $h_{i}$. But this means $\left|\left.\right|^{h_{i}} \nabla^{j} \hat{g}_{i}(\cdot, 1)\right|^{2} \rightarrow 0$ for all $j \in \mathbb{N}$ as $i \rightarrow 0$, as can be seen by writing all quantities in geodesic coordinates with respect to $h_{i}$ at $x_{i}$. This contradicts $\left|{ }^{h_{i}} \nabla \hat{g}_{i}\left(x_{i}, 1\right)\right|^{2} \geq \alpha>0$ for all $i \in \mathbb{N}$. Hence $c_{1}(a, h)=c_{1}(h, a, \varepsilon) \rightarrow 0$ as $\varepsilon \rightarrow 0$. An almost identical argument shows that $c_{j}(h, a)$ in $\left(c_{t}\right)$ of Theorem 6.3 can be replaced by $c_{j}(h, a, \varepsilon)$ where $c_{j}(h, a, \varepsilon) \rightarrow 0$ as $\varepsilon \rightarrow 0$.

In the case that the energy is bounded uniformly, then a scaling argument leads to the setting of the previous theorem, and hence we may find a solution to the equation (1.1) for a short time, which satisfies the conclusions of the previous theorems, for any $\varepsilon>0$, if we shorten the length of the time interval.
Theorem 6.5. Let $(M, h)$ be four dimensional and satisfy (2.1), and $1<a<\infty$, and $g_{0}$ be a $W^{2,2} \cap L^{\infty}$ Riemannian metric, not necessarily smooth, which satisfies (a) and

$$
\begin{equation*}
\int_{M}\left(\left.\left.\right|^{h} \nabla g_{0}\right|^{2}+\left|{ }^{h} \nabla^{2} g_{0}\right|^{2}\right) d h<\infty . \tag{6.2}
\end{equation*}
$$

Then for any $\varepsilon>0$ there exists a constant $T=T\left(g_{0}, a, \varepsilon\right)>0, a C=C\left(g_{0}, a, \varepsilon\right)$ and a smooth solution $(g(t))_{t \in(0, T]}$ to (1.1), such that after scaling the solution and the background metric $h$ once, $\left(\mathrm{a}_{t}\right),\left(\mathrm{b}_{t}\right),\left(\mathrm{c}_{t}\right),\left(\mathrm{d}_{t}\right)$, $\left(\mathrm{e}_{t}\right)$ and $\left(\mathrm{f}_{t}\right)$ hold, and $(g(t))_{t \in(0, T]}$ is the unique solution in the class of solutions satisfying the conditions $\left(\mathrm{a}_{t}\right),\left(\mathrm{b}_{t}\right),\left(\mathrm{c}_{t}\right),\left(\mathrm{d}_{t}\right)$. The constants $c_{j}(h, a)$ in $\left(c_{t}\right)$ can be replaced by $c_{j}(h, a, \varepsilon)$ where $c_{j}(h, a, \varepsilon) \rightarrow 0$ as $\varepsilon \rightarrow 0$
Remark 6.6. In this setting, we cannot expect

$$
\begin{equation*}
\int_{M}\left(\left|{ }^{h} \nabla g(t)\right|^{2}+\left.\left.\right|^{h} \nabla^{2} g(t)\right|^{2}\right) d h<\infty \tag{6.3}
\end{equation*}
$$

for any $t>0$ as the example, Example 6.7, below shows.

Proof. As explained in the introduction : By scaling the initial data $g_{0}$ and the background metric $h$ once, we can guarantee that the new initial data and background metric, which we also call $g_{0}$ and $h$, satisfy (a) and (b), where $\varepsilon \leq \frac{\varepsilon_{1}(2 a)}{2}$ and $\varepsilon_{1}$ is the constant from Theorem 6.1, and that $h$ satisfies (2.4). Using Theorem 6.3, we obtain a solution $g(t), t>0 t \in[0, T]$ which satisfies $\left(\mathrm{a}_{t}\right),\left(\mathrm{b}_{t}\right),\left(\mathrm{c}_{t}\right),\left(\mathrm{d}_{t}\right),\left(\mathrm{e}_{t}\right)$ and $\left(\mathrm{f}_{t}\right)$. The uniqueness of the solution in the class of solutions satisfying $\left(\mathrm{a}_{t}\right),\left(\mathrm{b}_{t}\right),\left(\mathrm{c}_{t}\right)$ and $\left(\mathrm{d}_{t}\right)$ follows immediately from Theorem 11.2. The fact that the $c_{j}(h, a)$ in $\left(c_{t}\right)$ can be replaced by $c_{j}(h, a, \varepsilon)$ where $c_{j}(h, a, \varepsilon) \rightarrow 0$ as $\varepsilon \rightarrow 0$ follows from Remark 6.4.

Example 6.7. Let $n=2$ and $g_{0}$ be a smooth metric on
$C_{1}(0):=\left\{\left(x_{1}, x_{2}\right) \in \mathbb{R}^{2} \mid \max \left(\left|x_{1}\right|,\left|x_{2}\right|\right)<1\right\}$ such that $(1-\varepsilon) \delta \leq g_{0} \leq(1+\varepsilon) \delta$, $0<\varepsilon \ll 1$ and $g_{0}=\delta$ on $C_{1}(0) \backslash C_{\frac{1}{2}}(0)$, and so that the curvature of $g_{0}$ is a constant $\sigma_{1}>0$ on $C_{\sigma_{2}}(0)$, for two small constants $\sigma_{1}, \sigma_{2}>0$, where $\delta$ is the standard metric on $\mathbb{R}^{2}$. We extend this metric to all of $\mathbb{R}^{2}$ through symmetry, $g_{0}(x)=g_{0}(x+p)$ for all $p \in \mathbb{Z}^{2}=\left\{\left(z_{1}, z_{2}\right) \mid z_{1}, z_{2} \in \mathbb{Z}\right\}$, and in doing so obtain a smooth Riemannian metric $g_{0}$ on $\mathbb{R}^{2}$ satisfying $(1-\varepsilon) \delta \leq g_{0} \leq(1+\varepsilon) \delta$, with $\psi_{p}^{*} g_{0}=g_{0}$ for any $p \in \mathbb{Z}^{2}$, where $\psi_{p}(x)=x+p$. Let $T_{i}^{2}$ refers to the standard 2-torus whose circles have radius $i \in \mathbb{N}$. $T_{i}^{2}:=\mathbb{R}^{2} / \Gamma(i)$, where $\Gamma(i):=\left\{T_{y}: \mathbb{R}^{2} \rightarrow \mathbb{R}^{2} \mid y \in \mathbb{Z}^{2}\right.$, where $T_{y}(x)=x+i y$, for all $\left.x \in \mathbb{R}^{2}\right\}$. That is $T_{i}^{2}=\left\{[x] \mid x \in \mathbb{R}^{2}\right\}$ where $[x]=[z]$ if and only if $T(x)=z$ for some $T \in \Gamma(i)$. We give $T_{i}^{2}$ the unique metric $g_{0}(i)$ such that $\pi^{*}\left(g_{0}(i)\right)=g_{0}$ where $\pi: \mathbb{R}^{2} \rightarrow T_{i}^{2}$ is the standard projection, $\pi(x)=[x]$.

From the work of Shi, [29], there exists a unique smooth solution $\left(T_{i}^{2}, g(i)(t)\right)_{t \in[0, T]}$ to (1.1) with $h=g_{0}(i), g(i)(0)=g_{0}(i),\left.\left.\sup _{t \in[0, T]}\right|^{h} \nabla^{j} g(i)(t)\right|^{2}<c_{j}\left(g_{0}\right)$ for all $j \in \mathbb{N}$, and all $t \in[0, T]$ and $(1-2 \varepsilon) g_{0}(i) \leq g(i)(t) \leq(1+2 \varepsilon) g_{0}(i)$ for all $t \in[0, T]$. Defining $\varphi_{p}: T_{i}^{2} \rightarrow T_{i}^{2}$ by $\varphi_{p}([x])=[p+x]$, where $p \in \mathbb{Z}^{2}$, we see that $\varphi_{p}^{*}\left(g_{0}(i)\right)=g_{0}(i)$ by construction, and hence it is an isometry with respect to $g_{0}(i)$. Setting $\tilde{g}(i)(t):=\left(\varphi_{p}\right)^{*}(g(i)(t))$, we see that it is also a solution to (1.1), with $\tilde{g}(i)(0)=g_{0}(i)$ and $h=g_{0}(i)$. Uniqueness of such solutions, which can be seen by applying the maximum principle to the function $f(\cdot, t):=\left|g_{1}(\cdot, t)-g_{2}(\cdot, t)\right|^{2}$, shows us that $\left(\varphi_{p}\right)^{*} g(i)(t)=g(i)(t)$ for all $t \in[0, T]$.

Taking a subsequence and then a limit $i \rightarrow \infty$, we obtain a solution $g(t)$ to (1.1) with $g(0)=g_{0},\left.\left.\sup _{t \in[0, T]}\right|^{h} \nabla^{j} g(t)\right|^{2}<c_{j}\left(g_{0}\right)<\infty$ for all $j \in \mathbb{N}$, and all $t \in[0, T]$, and such that $\left(\psi_{p}\right)^{*} g(t)=g(t), \psi_{p}^{*} h=h$ where $\psi_{p}(x)=x+p$ and $p \in \mathbb{Z}^{2}$. Furthermore $\left.\right|^{h} \nabla^{j} g_{0} \mid=0$ for all $j \in \mathbb{N}$, since $g_{0}=h$.

Using a Taylor expansion in time for $g(t)$, and the fact that $g(t)$ is a smooth solution to (1.1) with $g(0)=h$, we see that $g(x, t)=h(x)+\frac{\partial}{\partial t} g(x, 0) \cdot t+\left(\frac{\partial}{\partial t} \frac{\partial}{\partial t}\right) g(x, s) \cdot t^{2}$ for some $s \in(0, t)$. Notice that $\frac{\partial}{\partial t} g(x, 0)=0$ for $x \in C_{\frac{4}{5}}(0) \backslash C_{\frac{3}{4}}(0)$ because there, $g(x, 0)=h(x)=\delta$ and $\delta$ has zero curvature. Hence $g(x, t)-\delta^{4}=O\left(t^{2}\right)$ for small $t$ for $x \in C_{\frac{4}{5}}(0) \backslash C_{\frac{3}{4}}(0)$ and $g_{i i}(y, t)-h_{i i}(y)=-2 \sigma_{i i} t+O\left(t^{2}\right)$ for $y=0$, for where $\sigma_{i i}=c(n) \sigma_{1}>0$. If ${ }^{h} \nabla g(t)=0$ holds for all $t \in[0, P)$ then, for all $t \in(0, P)$ with $P>0$ small enough, we would have $g(t)=h$ on $C_{\frac{4}{5}}(0) \backslash C_{\frac{3}{4}}(0)$ and $g(y, t)-h(y) \neq$ 0 at $y=0$. But taking any two vectors $v, w$ at a point $p$ in $C_{\frac{4}{5}}(0) \backslash C_{\frac{3}{4}}(0)$ we have
$g(p, t)(v, w)=h(p)(v, w)$. Parallel transporting the vectors along a geodesic (with respect to $h$ ) from $p$ to 0 , we would have $\frac{\partial}{\partial r} g(\gamma(r), t)(v(r), w(r))=0=\frac{\partial}{\partial r} h(\gamma(r))(v(r), w(r))$ and hence $g(0, t)(v(r), w(r))=h(0)(v(r), w(r))$. Since the vectors were arbitrary, we see $g(0, t)=h(0)$ for all $t \in[0, P):$ a contradiction. By smoothness of the solution, there exists an $s_{t}>0$ such that $\int_{C_{1}(0)}\left(\left|{ }^{h} \nabla g(t)\right|^{2}+\left|{ }^{h} \nabla^{2} g(t)\right|^{2}\right) d h \geq s_{t}>0$ for some $t>0$. Using the isometry $\psi_{p}$, we see that this means $\int_{C_{1}(p)}\left(\left.\left.\right|^{h} \nabla g(t)\right|^{2}+\left.\left.\right|^{h} \nabla^{2} g(t)\right|^{2}\right) d h \geq s_{t}>0$, for all $p \in \mathbb{Z}^{2}$, hence $\int_{M}\left(\left.\left.\right|^{h} \nabla g(t)\right|^{2}+\left.\left.\right|^{h} \nabla^{2} g(t)\right|^{2}\right) d h=\infty$ for this $t$. To obtain an example in $\mathbb{R}^{n}$ with $n \in \mathbb{N}, n>2$ we simply take $\hat{g}_{0}=\hat{h}=g_{0} \oplus \delta_{\mathbb{R}^{k}}$ on $\mathbb{R}^{k+2}=\mathbb{R}^{n}$ where $\delta_{\mathbb{R}^{k}}$ is the standard metric on $\mathbb{R}^{k}$.

## 7. Ricci flow estimates

The results of the previous sections are in the setting of the Ricci DeTurck flow. As mentioned at the beginning of the paper, in certain settings, for example the closed smooth setting, there is a Ricci flow related solution, which can be written as $\ell(t):=$ $\left(\varphi_{t}\right)^{*} g(t)$ where $\varphi_{t}: M \rightarrow M, t \in[0, T]$, or possibly only $t \in(0, T]$, is a smooth family of diffeomorphisms, and $g(t)_{t \in[0, T)}$ is a solution to Ricci DeTurck flow. We say in this case, that the Ricci flow solution $\ell(t)$ comes from the Ricci DeTurck solution $g(t)$, and we call $\ell(t)$ a Ricci Flow related solution to $g(t)$. In the next section we construct and analyse the behaviour of solutions $\ell(t)$ coming from a Ricci DeTurck solution $g(t)$ constructed in the previous sections. In order to do this, we require various estimates for solutions to local Ricci flows. The statements and proofs thereof are contained in this section. The results of this section are written in a local setting assuming various geometric bounds, which we know will hold if the local Ricci flow solution comes from a Ricci DeTurck flow solution constructed in the previous sections of this paper. However, it is not necessary to assume that the local Ricci flow solutions we consider are constructed in this manner.

Theorem 7.1. For all $p \in[2, \infty)$ there exists a $\alpha_{0}=\alpha_{0}(p, n)>0$ such that the following holds. Let $\Omega$ be a smooth n-dimensional manifold and $\left(\Omega^{n}, \ell(t)\right)_{t \in(0, T]}$ be a smooth solution to Ricci flow satisfying

$$
\begin{align*}
& \int_{\Omega}|\operatorname{Rc}(\ell(t))| d \ell(t) \leq \varepsilon  \tag{7.1}\\
& |\operatorname{Rc}(\ell(t))| \leq \frac{\varepsilon}{t} \quad \text { on } \Omega
\end{align*}
$$

for all $t \in(0, T]$, where $\varepsilon \leq \alpha_{0}$. Then there exist $\delta(n, p, \varepsilon), c(n, p)>0$, with the property that $\delta(n, p, \varepsilon) \rightarrow 0$ as $\varepsilon \rightarrow 0$, such that

$$
\begin{align*}
& \int_{\Omega}|\ell(t)-\ell(s)|_{\ell(t)}^{p} d \ell(t) \leq \delta(n, p, \varepsilon)|t-s|  \tag{7.2}\\
& \int_{\Omega}\left|(\ell(t))^{-1}-(\ell(s))^{-1}\right|_{\ell(t)}^{p} d \ell(t) \leq \delta(n, p, \varepsilon)|t-s| \tag{7.3}
\end{align*}
$$

for all $t, s \in(0, T]$ with $s<t$. Furthermore,

$$
\begin{align*}
& \int_{\Omega}|\ell(s)|_{\ell(t)}^{p} d \ell(t) \leq c(n, p)(\operatorname{Vol}(\Omega, \ell(t))+|t-s|)  \tag{7.4}\\
& \int_{\Omega}\left|\ell^{-1}(s)\right|_{\ell(t)}^{p} d \ell(t) \leq c(n, p)(\operatorname{Vol}(\Omega, \ell(t))+|t-s|)  \tag{7.5}\\
& \int_{\Omega}|\ell(r)-\ell(s)|_{\ell(t)}^{p} d \ell(t) \leq c(n, p)(\operatorname{Vol}(\Omega, \ell(t))+t)^{\frac{3}{4}}|r-s|^{\frac{1}{4}}  \tag{7.6}\\
& \int_{\Omega}\left|(\ell(r))^{-1}-(\ell(s))^{-1}\right|_{\ell(t)}^{p} d \ell(t) \leq c(n, p)(\operatorname{Vol}(\Omega, \ell(t))+t)^{\frac{3}{4}}|r-s|^{\frac{1}{4}} \tag{7.7}
\end{align*}
$$

for all $r, s, t \in(0, T]$ with $r, s<t$.
Remark 7.2. This Theorem is true for any smooth Ricci flow satisfying (7.1): Completeness, compactness, volume bounds, Sobolev inequalities, are not assumed.

Proof. We write $v:=\ell(s)$, and $\ell$ for $\ell(t)$, for $t \in(s, T]$, and $\operatorname{Rc}$ for $\operatorname{Rc}(\ell(t))$ and we calculate for

\begin{aligned}
& h(t):=\int_{\Omega}|\ell(t)-\ell(s)|_{\ell(t)}^{p} d \ell(t) \\
& \frac{\partial}{\partial t} h(t)= \frac{\partial}{\partial t} \int_{\Omega}|\ell(t)-v|_{\ell(t)}^{p} d \ell(t) \\
&= \frac{\partial}{\partial t} \int_{\Omega}\left(\ell^{i k} \ell^{j m}\left(\ell_{i j}-v_{i j}\right)\left(\ell_{k m}-v_{k m}\right)\right)^{\frac{p}{2}} d \ell \\
&= \int_{\Omega}-R(\ell)|\ell-v|_{\ell}^{p}+\frac{p}{2}|\ell-v|_{\ell}^{p-2}\left(2 \ell^{i s} \ell^{k z} \operatorname{Rc}(\ell)_{s z} \ell^{j m}\left(\ell_{i j}-v_{i j}\right)\left(\ell_{k m}-v_{k m}\right)\right. \\
& \quad+2 \ell^{i k} \ell^{j s} \ell^{m z} \operatorname{Rc}(\ell)_{s z}\left(\ell_{i j}-v_{i j}\right)\left(\ell_{k m}-v_{k m}\right) \\
& \quad-2 \ell^{i k} \ell^{j m} \operatorname{Rc}(\ell)_{i j}\left(\ell_{k m}-v_{k m}\right)-2 \ell^{i k} \ell^{j m}\left(\left(\ell_{i j}-v_{i j}\right) \operatorname{Rc}_{k m}(\ell)\right) \\
& \leq c(n) p \int_{\Omega}\left(\left.|\operatorname{Rc}|_{\ell}\right|_{\ell}-\left.v\right|_{\ell} ^{p}+|\operatorname{Rc}|_{\ell}|\ell-v|_{\ell}^{p-1}\right) d \ell \\
& \leq \frac{c(n) p \varepsilon}{t} h(t)+c(n) p \int_{\Omega}|\operatorname{Rc}|_{\ell}^{\frac{1}{p}}\left(|\operatorname{Rc}|_{\ell}^{\frac{p-1}{p}}|\ell-v|_{\ell}^{p-1}\right) d \ell \\
& \leq \frac{c(n) p \varepsilon}{t} h(t)+c(n) p \int_{\Omega}\left(|\operatorname{Rc}|_{\ell}+|\operatorname{Rc}|_{\ell}|\ell-v|_{\ell}^{p}\right) d \ell \\
& \leq \frac{c(n) p \varepsilon}{t} h(t)+c(n) p \varepsilon
\end{aligned}
$$

for some $c(n) \geq 1$ depending only on $n$. Hence the function $f(t)=h(s+t)$ also satisfies

$$
\begin{align*}
\frac{\partial}{\partial t} f(t) & \leq \frac{\beta_{0}}{s+t} f(t)+\beta_{0} \\
& \leq \frac{\beta_{0}}{t} f(t)+\beta_{0} \tag{7.8}
\end{align*}
$$

for all $t \in(0, T-s]$, where $\beta_{0}:=c(n) p \varepsilon$. The assumptions on $\varepsilon$ guarantee that $\beta_{0}=$ $c(n) p \varepsilon \leq \frac{1}{2}$, and hence, using the ODE Lemma C.2, we see that $f(t) \leq 2 \beta_{0} t$ for all $t \in(0, T-s]$. In particular, we obtain $h(t)=f(t-s) \leq 2 \beta_{0}(t-s)=c(n) p \varepsilon(t-s)$ for all $t \in(s, T]$, that is (7.2) holds.

The estimate (7.3) is proved in an alomost identical way. We calculate for $y(t):=$ $\int_{\Omega}\left|\left(\ell^{-1}-v^{-1}\right)\right|_{\ell(t)}^{p} d \ell(t)$,

\begin{aligned}
\frac{\partial}{\partial t} y(t)= & \frac{\partial}{\partial t} \int_{\Omega}\left|\ell^{-1}-v^{-1}\right|_{\ell}^{p} d \ell \\
= & \int_{\Omega}-R(\ell)\left|\ell^{-1}-v^{-1}\right|_{\ell}^{p}+\frac{p}{2}\left|\ell^{-1}-v^{-1}\right|_{\ell}^{p-2}\left(-2 \operatorname{Rc}(\ell)_{i k} \ell_{j m}\left(\ell^{i j}-v^{i j}\right)\left(\ell^{k m}-v^{k m}\right)\right. \\
& \quad-2 \ell_{i k} \operatorname{Rc}(\ell)_{j m}\left(\ell^{i j}-v^{i j}\right)\left(\ell^{k m}-v^{k m}\right) \\
& \quad+2 \ell_{i k} \ell_{j m} \ell^{i p} \ell^{j q} \operatorname{Rc}(\ell)_{p q}\left(\ell^{k m}-v^{k m}\right) \\
& \left.\quad+2 \ell_{i k} \ell_{j m}\left(\ell^{i j}-v^{i j}\right) \operatorname{Rc}(\ell)_{p q} \ell^{k p} \ell^{m q}\right) d \ell \\
\leq & c(n) p\left(\int_{\Omega}|\operatorname{Rc}(\ell)|_{\ell}\left|\ell^{-1}-v^{-1}\right|_{\ell}^{p}+|\operatorname{Rc}(\ell)| \ell\left|\ell^{-1}-v^{-1}\right|_{\ell}^{p-1} d \ell\right) \\
\leq & \frac{c(n) p \alpha_{0}}{t} \int_{\Omega}\left|\ell^{-1}-v^{-1}\right|_{\ell}^{p} d \ell+c(n) p \int_{\Omega}|\operatorname{Rc}(\ell)|_{\ell}\left|\ell^{-1}-v^{-1}\right|_{\ell}^{p-1} d \ell \\
\leq & \frac{2 c(n) p \alpha_{0}}{t} \ell(t)+c(n) p \alpha_{0} \\

The inequality (7.3) now follows as before from Lemma C.2. The inequalities (7.4), (7.5), (7.6) and (7.7) follow from the Hölder and triangle inequalities, as we now show. First

The previous Theorems shows that for $p \in[2, \infty)$ and $n \in \mathbb{N}$, a solution $(\Omega, \ell(t))_{t \in(0, T]}$ which satisfies the conditions of the Lemma, that is $\int_{\Omega}|\operatorname{Rc}(\ell(t))| d \ell(t) \leq \varepsilon$ and $|\operatorname{Rc}(\ell(t))| \leq$ $\frac{\varepsilon}{t}$ on $\Omega$ for all $t \in(0, T]$, where $\varepsilon \leq \alpha_{0}=\alpha_{0}(n, p)$, must have a uniquely well defined starting value $\ell_{0} \in L^{p}(\Omega)$ which is a symmetric two tensor, whose inverse exists almost everywhere:

Corollary 7.3. For all $p \in[2, \infty)$ and $n \in \mathbb{N}$ there exists an $\alpha_{0}(n, p)>0$ such that the following holds. Let $\Omega$ be a smooth $n$-dimensional manifold and $\left(\Omega^{n}, \ell(t)\right)_{t \in(0, T]}$ be a smooth solution to Ricci flow satisfying

Proof. From (7.6) and (7.7) we see that $\ell(s)_{s \in(0, T]}$ and $\ell^{-1}(s)_{s \in(0, T]}$ are Cauchy w.r.t to $s$ in $L^{2 p}(\Omega, \ell(t))$ for fixed $t>0$, if $\varepsilon \leq \alpha_{0}(2 p, n)$ is chosen small enough, where $\ell_{0}$ is as in the statement of Theorem 7.1, so there exists $\ell_{0}, r_{0} \in L^{2 p}(\Omega, \ell(t))$ such that $\ell(s) \rightarrow \ell_{0}$ and $\ell^{-1}(s) \rightarrow r_{0}$ as $s \searrow 0$ in the $L^{2 p}$ norm. Furthermore $\delta_{j}^{i}=\ell^{i k}(s) \ell_{j k}(s)$ and so we have, for $\|\cdot\|_{L^{q}}=\|\cdot\|_{L^{q}(\Omega, \ell(t))}$ for some fixed $t>0$,

as $s \searrow 0$ in view of (7.4), (7.5), (7.6) and (7.7). Hence $r_{0}=\left(\ell_{0}\right)^{-1}$ almost everywhere. At points $x$ in the set of measure zero, where $\ell(0)(x)$ is degenerate, we replace $\ell(0)(x)$ by $\ell(t)(x)$ for a fixed $t>0$. The convergence result still holds, but now $\ell(0)$ is positive definite everywhere.

Theorem 7.4. For any $A>0$ there exist $\alpha_{1}, \beta, S>0$ such that the following holds. Let $\left(M^{4}, \ell(t)\right)_{t \in(0, T]}$ be a smooth four dimensional solution to Ricci flow, with $B_{\ell(t)}\left(x_{0}, 10\right) \Subset$ $M T \leq 1$, satisfying a uniform Sobolev inequality for all $t \in(0, T]$ :

Proof. We first prove that the space time integral of $|\nabla \mathrm{Rc}|^{2}$ can be locally, uniformly bounded in the setting we are considering. This estimate shall in turn be used to prove the $L^{2}$ gradient estimate (7.14). In the following $c$ refers to a universal constant independent of the solution. Let $\eta: M \rightarrow \mathbb{R}^{+}$be a Perelman cutoff-function, with $\eta(\cdot, t)=e^{-t}$ on $B_{\ell(t)}\left(x_{0}, 1\right)$ and $\eta(\cdot, t)=0$ on $M-B_{\ell(t)}\left(x_{0}, \frac{5}{4}\right), \frac{\partial}{\partial t} \eta \leq \Delta_{\ell(t)} \eta,|\nabla \eta|^{2} \leq c \eta$ with (see [32]
section 7 for details of the construction). Then, using the Sobolev inequality, Hölder's inequality, and the fact that $\int_{B_{\ell(t)}\left(x_{0}, 2\right)} \eta^{2}(t)|\mathrm{Rm}|^{2}(t) d \ell(t) \leq \alpha_{1}$, we see that

This is similar to the $L^{p}$ estimate obtained for $\ell(t)$ in (7.1), but uses the space-time $L^{2}$ bound on the gradient of the Ricci curvature (7.15) that we just derived, instead of the bound on the Riemannian curvature. In the following $|\cdot|$ refers to $|\cdot|_{\ell(t)}$, and Rc to $\operatorname{Rc}(\ell(t))$. Defining $\Omega:=B_{\ell\left(t_{0}\right)}\left(x_{0}, \frac{1}{2}\right)$, we see that $\Omega \subseteq B_{\ell(r)}\left(x_{0}, 1\right)$ for all $r \in\left(0, t_{0}\right)$ if $t_{0} \leq 1$ in view of Corollary 3.3 of [32] and the fact that the condition (7.13) holds. Differentiating the function $f(t):=\int_{\Omega}|\nabla(\ell(t)-\ell(s))|_{\ell(t)}^{2} d \ell(t)$, for $s<t \leq t_{0}$, and
using Young's, we get

& \leq c t^{\alpha_{2}}\left(\alpha_{2}^{-1} \int_{s}^{s+t} \int_{B_{\ell(r)}\left(x_{0}, 1\right)}|\nabla \operatorname{Rc}(\ell(r))|^{2} d \ell(r) d r+1\right) \\
& \leq c t^{\alpha_{2}}
\end{aligned}
$$

for $t \in(0, S-s)$ in view of Lemma C.1, and the fact that the inequality (7.15) hold. That is $f(t) \leq c(t-s)^{\alpha_{2}}$ for $t \in(s, S)$. By choosing $\beta=\frac{\alpha_{2}}{2}$, we obtain $f(t)=\int_{\Omega} \mid \nabla(\ell(t)-$ $\ell(s))\left.\right|_{\ell(t)} ^{2} d \ell(t) \leq(t-s)^{\beta}$ for $t \in(s, S)$ as required.

## 8. The Ricci flow related solution

In the sections before Section 7, we constructed a solution $g(t)_{t \in(0, T]}$ to the Ricci-DeTurck flow coming out of $W^{2,2}$ initial data $g_{0}$ on a four dimensional manifold, and we proved estimates for such solutions. In this section we construct a Ricci flow related solution $\ell(t)_{t \in(0, T]}$ coming from the Ricci DeTurck flow solution constructed in the sections preceding Section 7. We show in the setting we are considering, that the Ricci flow related solution $\ell(t)$ converges back to some starting value $\ell_{0}$ locally in the $W^{1,2}$ norm, as $t \rightarrow 0$. We shall see that the tensor $\ell_{0}$ is non-negative definite, up to a set of measure zero. Note that since, $g_{0}$ and $\ell_{0}$ are only defined up to a measure zero, we can arbitrarily change distance induced by $g_{0}$ respectively by $\ell_{0}$ by changing $g_{0}$ respectively $\ell_{0}$ on a set of measure zero, if we try and use the usual definition of distance with respect to a Riemannian metric, as the following example shows.
Example 8.1. Let $g, h$ be smooth Riemannian metrics on $M=\mathbb{B}_{1}(0) \subseteq \mathbb{R}^{n}, r>0$ small so that $B_{h}(0, r) \Subset \mathbb{B}_{1}(0)$ and $x \neq y, x, y \in B_{h}(0, r / 4)$ and let $\gamma:[0,1] \rightarrow \mathbb{B}_{1}(0)$ be a smooth length minimising geodesic with respect to $h$ from $x$ to $y$. We define a new metric $\tilde{g}$, which is the same as $g$ except on the line $\gamma$. On $\gamma$ we define $\tilde{g}(\gamma(s))=b^{2} h(\gamma(s))$ for all $s \in[0,1]$, for some $b \in \mathbb{R}, b>0 . \tilde{g}$ is still a well defined Riemannian metric, with $\frac{1}{N} \delta \leq \tilde{g} \leq N \delta$ for some $N>0, N \in \mathbb{R}$, in view of the smoothness of $g$ and the definition of $\tilde{g}$. This ensures then that $\tilde{g}_{i j}$ is a Borel-measurable function, since $g_{i j}$ is smooth and $g=\tilde{g}$ almost everywhere. Using the fact that $\frac{1}{N} \delta \leq \tilde{g} \leq N \delta$ for some $N>0$, we see then that $\tilde{g}$ is in $L^{p}$ for any $p \in(0, \infty]$. We also have, for any piecewise smooth $\sigma:[0,1] \rightarrow \mathbb{B}_{1}(0)$ with $\sigma(0) \neq \sigma(1)$ that $\tilde{g}_{i j} \circ \sigma: I \rightarrow \mathbb{R}$ is Borel measurable, since both $\tilde{g}_{i j}$ and $\sigma$ are, and $\frac{1}{N^{2}} \delta_{i j} \leq \tilde{g}_{i j} \circ \sigma \leq N^{2} \delta_{i j}$, since this is true for $\tilde{g}_{i j}$. This means $\ell:[0,1] \rightarrow \mathbb{R}, \ell(s):=\sqrt{\tilde{g}_{i j}(\sigma(s)) \partial_{s} \sigma^{i}(s) \partial_{s} \sigma^{j}(s)}$ is a well defined $L^{1}$ function and $L_{\tilde{g}}(\sigma):=\int_{0}^{1} \sqrt{\tilde{g}_{i j}(\sigma(s)) \partial_{s} \sigma^{i}(s) \partial_{s} \sigma^{j}(s)} d s$ satisfies $0<\frac{1}{N} L_{\delta}(\sigma) \leq L_{\tilde{g}}(\sigma)<N L_{\delta}(\sigma)<\infty$ for all such $\sigma$. If we define $d(\tilde{g})(p, q):=\inf _{\sigma \in B_{p, q}} L_{\tilde{g}}(\sigma)$ for all $p, q \in M$ where $B_{p, q}$ refers to the space of continuous, piecewise smooth curves between $p$ and $q$ in $M=\mathbb{B}_{1}(0)$, then we see that $\left(\mathbb{B}_{1}(0), d(\tilde{g})\right)$ is a well defined metric space, that is $d(\tilde{g})$ is symmetric, satisfies the triangle inequality, and $d(\tilde{g})(p, q) \geq 0$ for all $p, q \in M$ with equality if and only if $p=q$. Furthermore $d(\tilde{g})(x, y) \leq L_{\tilde{g}}(\gamma)(x, y)=L_{b h}(x, y)=b d(h)(x, y)<d(g)(x, y)$ if $b>0$ is chosen small enough, and hence $d(\tilde{g})(x, y)<d(g)(x, y)$ if $b>0$ is chosen small enough.

That is, if we use the usual definition for distance with respect to a Riemannian metric, distance can change if we change the Riemannian metric on a set of measure zero.

In particular, this example shows that we cannot be sure that $\left.d(g(t))(x, y) \rightarrow d\left(g_{0}\right)(x, y)\right)$ everywhere, as $t \searrow 0$, in the case that we have a family of smooth metrics $g(t)$ which convergences in the $L^{1}$ sense (or another weak sense) to a $g_{0} \in L^{1}$, if we define $d\left(g_{0}\right)$ in the usual way, $d\left(g_{0}\right)(x, y)=\inf _{\sigma \in B_{x, y}} L_{g_{0}}(\gamma)$, where $B_{x, y}$ is the set of smooth curves going from $x$ to $y$ : if $g_{0}$ is bounded from above and below by a smooth metric, we can change $g_{0}$ on a smooth curve between two given points $x$ and $y$ (as in the example above), so that $d(g(t))(x, y)$ doesn't converge to $d\left(g_{0}\right)(x, y)$, but we still have $g(t) \rightarrow g_{0}$ in $L^{1}$ as $t \searrow 0$.

Nevertheless, we will see for solutions $g(t)$ to the Ricci DeTurck flow constructed in the previous sections, that $d(g(t))(x, y)$ does converge to some metric $d_{0}(x, y)$ as $t \searrow 0$, where $d_{0}$ is defined in a similar fashion to the usual definition of $d\left(g_{0}\right)$, but it is necessary to restrict further the class of admissible curves $B_{x, y}$ between $x$ and $y$ to the class $C_{\varepsilon, x, y}$ of so called $\varepsilon$-approximative Lebesgue curves between $x$ and $y$, and then to take a limit inferior as $\varepsilon \rightarrow 0$ of the lengths.

Definition 8.2. i) For $p \in[1, \infty)$ we say $g$ is an $L^{p}$ metric, if the following holds. $g$ is a Riemannian metric, that is $g(x): T_{x} M \times T_{x} M \rightarrow \mathbb{R}$ is defined, symmetric, positivedefinite, for all $x \in M$ and locally, writing $\tilde{g}_{i j}(\tilde{x}):=g(x)\left(\frac{\partial}{\partial_{i}}(x), \frac{\partial}{\partial_{j}}(x)\right)$ for any smooth
coordinates $\varphi: U \rightarrow \varphi(U)=\tilde{U} \subseteq \mathbb{R}^{n}, \tilde{g}_{v v}: \tilde{U} \rightarrow \mathbb{R}$ is in $L^{p}(\tilde{U})$ for all $v \in \mathbb{R}^{n}$, where $v$ is any fixed length one (w.r.t to $\delta$ ) vector in $\mathbb{R}^{n}$, and $\tilde{g}_{v v}(x):=\tilde{g}_{i j}(x) v^{i} v^{j}$.
ii) For $x, y \in M$ we define the set $C_{\varepsilon, x, y}(g)$ of $\varepsilon$-approximative Lebesgue curves with respect to $g$ from $x$ to $y$ in $M$ to be the set of paths $\gamma:[a, b] \rightarrow M$ which can be written as the union of finitely many so called parameterised Lebesgue lines $\gamma_{i}:\left[a_{i-1}, a_{i}\right] \rightarrow M$, $i \in\{1, \ldots, N\}, a_{0}=a, a_{N}=b, \gamma=\gamma_{1} \cup \gamma_{2} \cup \gamma_{3} \cup \ldots \cup \gamma_{N}$, that is $\gamma(s):=\gamma_{i}(s)$ if $s \in\left[a_{i-1}, a_{i}\right]$, and

and a parameterised Lebesgue line is defined as follows: A parameterised Lebesgue line for an $L^{1}$ metric $g$ on $M$, is a smooth curve $\ell:[b, c] \rightarrow M$ with $|b-c| \leq \frac{1}{4}$, such that there exist smooth coordinates $\varphi: \Omega \rightarrow \varphi(\Omega)=\mathbb{B}_{1}(0)$ for some $p \in M$, such that $\ell([b, c]) \subseteq \Omega$ and the curve $\sigma:=\varphi \circ \ell:[b, c] \rightarrow \mathbb{B}_{1}(0)$ in these coordinates is a line in the direction $e_{1}$, with speed one, $\sigma(s)=-\frac{(b+c)}{2} e_{1}+s e_{1}, \sigma(b)=-k, \sigma(c)=k$, where $k=\frac{(c-b)}{2}$ and for $f(s):=\sqrt{\tilde{g}_{11}(\sigma(s))}$, we have $f \in L^{1}([b, c])$ and $\int_{b}^{c} f(s) d s=\lim _{\alpha \rightarrow 0} \frac{\int_{T_{\alpha}(\sigma)} \sqrt{\tilde{g}_{11}(x)} d x}{\omega_{n-1} \alpha^{n-1}}$, where here $T_{\alpha}(\sigma)$ refers to an $\alpha$ tubular neighbourhood of $\sigma$ with respect to $\delta, T_{\alpha}(\sigma)=$ $\left\{s e_{1}+\alpha v| | v \mid=1,\left\langle v, e_{1}\right\rangle=0, s \in\left(-\frac{(c-b)}{2}, \frac{(c-b)}{2}\right)\right\}$. Note that if $g$ is smooth then $\int_{b}^{c} f(s) d s=\lim _{\alpha \rightarrow 0} \frac{\int_{T_{\alpha}(\sigma)} \sqrt{\tilde{g}_{11}(x)} d x}{\omega_{n-1} \alpha^{n-1}}$ always holds. Also, an $\varepsilon$-approximative Lebesgue curve $\gamma$ is the union of finitely smooth curves, but may itself be discontinuous, and hence non-smooth.

In the setting that a Riemannian metric is $L^{\infty}$ (or weaker) there are various notions of distance and convergence of distance which may be defined, and there are many papers in this area investigating the properties thereof, their relation to one another and to the underlying measures. For one overview, as well as independet results/proofs thereof, we refer to the paper [5]. Further notions and convergence results may be found in the papers [2],[11], [1], [6], [18], [22], as well as the papers cited in these papers. Earlier works can be found in [7]. In our setting it is sufficient to define distance by considering the class of $\varepsilon$-approximative Lebesgue curves instead of the class of piecewise smooth curves or continuous curves, and then to take the $\lim \inf$ as $\varepsilon \rightarrow 0$ of the lengths: see (iv) of (8.3) below.

Theorem 8.3. Let $(M, h)$ be a smooth four dimensional Riemannian manifold satisfying (2.4) $1<a<\infty$ and $g_{0}$ satsify the assumptions of Theorem 6.3, and let $(M, g(t))_{t \in(0, T]}$, $T \leq 1$ be the smooth solution to (1.1) appearing in the conclusions of Theorem 6.3. Then
(i) there exists a constant $c(a)$ and a smooth solution $\Phi: M \times(0, T] \rightarrow M$ to (1.3) with $\Phi(T / 2)=I d$ such that $\Phi(t):=\Phi(\cdot, t): M \rightarrow M$ is a diffeomorphism and $d_{h}(\Phi(t)(x), \Phi(s)(x)) \leq c(a, n) \sqrt{|t-s|}$ for all $x \in M$. The metrics $\ell(t):=$ $(\Phi(t))^{*} g(t), t \in(0, T]$ solve the Ricci flow equation. Furthermore there are well defined limit maps $\Phi(0): M \rightarrow M, \Phi(0):=\lim _{t \searrow 0} \Phi(t)$, and $W(0): M \rightarrow M$, $W(0):=\lim _{t \searrow 0} W(t)$, where $W(t)$ is the inverse of $\Phi(t)$ and these limits are obtained uniformly on compact subsets, and $\Phi(0), W(0)$ are homeomorphisms inverse to another.
(ii) For the Ricci flow solution $\ell(t)$ from (i), there is a value $\ell_{0}(\cdot)=\lim _{t} \searrow_{0} \ell(\cdot, t)$ well defined up to a set of measure zero, where the limit exists in the $L^{p}$ sense, for any $p \in[1, \infty)$, such that, $\ell_{0}$ is positive definite, and in $W_{\text {loc }}^{1,2}$ and for any $y_{0} \in M$ and $0<s<t$ we have

where $\sigma>0$ is a universal constant, $c\left(g_{0}, h, p, y_{0}\right)$ is a constant depending on $g_{0}, h, p, y_{0}$ but not on $t$, and $\nabla$ refers to the gradient with respect to $\ell(t)$.
(iii) The limit maps $\Phi(0): M \rightarrow M, \Phi(0):=\lim _{t \searrow 0} \Phi(t)$, and $W(0): M \rightarrow M$, $W(0):=\lim _{t \searrow 0} W(t)$, from (i) are also obtained in the $W_{l o c}^{1, p}$ sense for $p \in[1, \infty)$. Furthermore, for any smooth coordinates $\varphi: U \rightarrow \mathbb{R}^{n}$, and $\psi: V \rightarrow \mathbb{R}^{n}$ and open sets $\tilde{U} \subset \subset U$ and $\tilde{V} \subset \subset V$ with $W(s)(\tilde{V}) \subset \subset U$ and $\Phi(s)(\tilde{U}) \subset \subset V$ for all $s \in[0, \hat{T}]$, for some $0<\hat{T}<T$ the functions $\left(\ell_{0}\right)_{i j} \circ W(0): \tilde{V} \rightarrow \mathbb{R}$ are in $L_{l o c}^{p}$ for all $p \in[1, \infty)$ and $\left(g_{0}\right)_{\alpha \beta}: \tilde{V} \rightarrow \mathbb{R}$ and $\left(\ell_{0}\right)_{i j}: W(0)(\tilde{V}) \rightarrow \mathbb{R}$ are related by the identity

on $\tilde{V}$. In particular: $\ell_{0}$ is isometric to $g_{0}$ almost everywhere through the map $W(0)$ which is in $W_{l o c}^{1, p}$, for all $p \in[1, \infty)$.
(iv) We define $d_{\tilde{t}}=d(g(t))$ and $\tilde{d}_{t}=d(\ell(t))=\Phi(t)^{*} d_{t}$. There are well defined limit metrics $d_{0}, \tilde{d}_{0}: M \times M \rightarrow \mathbb{R}_{0}^{+}, d_{0}(x, y)=\lim _{t \searrow 0} d_{t}(x, y)$, and $\tilde{d}_{0}:=M \times M \rightarrow$ $\mathbb{R}_{0}^{+}, \tilde{d}_{0}(p, q)=\lim _{t \searrow 0} \tilde{d}_{t}(p, q)$, and they satisfy $\tilde{d}_{0}(x, y)=d_{0}(\Phi(0)(x), \Phi(0)(y))$. That is, $\left(M, \tilde{d}_{0}\right)$ and $\left(M, d_{0}\right)$ are isometric to one another through the map $\Phi(0)$. The metric $d_{0}$ satisfies $d_{0}(x, y):=\liminf _{\varepsilon \searrow 0} \inf _{\gamma \in C_{\varepsilon, x, y}} L_{g_{0}}(\gamma)$, where $C_{\varepsilon, x, y}$ is the space of Lebesgue curves between $x$ and $y$ with respect to $g_{0}$.

Proof. (i):
For $r \in(0, T)$ we define $\psi_{r}: M \times(0, T] \rightarrow M$ to be the solution to

The Fundamental Theorem of Time Dependent Flows (see [21], Thm. 9.4.8) tells us that the $\psi_{r}(\cdot, s): M \rightarrow M$ are smooth diffeomorphisms for all $r, s \in(0, T]$ and that $\psi_{t_{1}}\left(\psi_{t_{0}}\left(p, t_{1}\right), s\right)=\psi_{t_{0}}(p, s)$ for all $t_{0}, t_{1}, s \in(0, T]$ and in particular that $\psi_{t_{1}}\left(\psi_{t_{0}}\left(\cdot, t_{1}\right), t_{0}\right)=$ $\operatorname{Id}(\cdot)$ for all $t_{0}, t_{1} \in(0, T]$. We shall use these facts freely in the following. The maps $\Phi(s), W(s): M \rightarrow M$ are defined by $\Phi(s)(x):=\psi_{T / 2}(x, s)$, and $W(s)(x):=\psi_{s}(x, T / 2)$ for $s \in(0, T]$ and $\Phi, W: M \times(0, T] \rightarrow M$ are defined by $\Phi(x, s)=\Phi(s)(x)$, and $W(x, s)=W(s)(x)$ for $s \in(0, T]$. From the fact that $\psi_{t_{1}}\left(\psi_{t_{0}}\left(\cdot, t_{1}\right), t_{0}\right)=I d(\cdot)$, we have $W(s) \circ \Phi(s)(\cdot)=\psi_{s}(\Phi(s)(\cdot), T / 2)=\psi_{s}\left(\psi_{T / 2}(\cdot, s), T / 2\right)=I d(\cdot)$ for all $s \in(0, T]$. Defining

for $s \in(0, T]$ we obtain a smooth solution to Ricci flow with $\ell(T / 2)=g(T / 2)$.
We define $\Phi(0)$ by $\Phi(0)(x):=\lim _{s_{i} \searrow 0} \Phi\left(s_{i}\right)(x)=\lim _{s_{i} \searrow 0} \psi_{T / 2}\left(x, s_{i}\right)$ and $W(0): M \rightarrow$ $M$ by $W(0)(x):=\lim _{t_{i} \searrow 0} W\left(t_{i}\right)(x)=\lim _{t_{i} \searrow 0} \psi_{t_{i}}(x, T / 2)$ : In the following we show that these limits exist, and are independent of the sequences $t_{i} \searrow 0$ and $s_{i} \searrow 0$ chosen. We have $\left|\frac{\partial}{\partial t} \psi_{T / 2}(x, t)\right|_{h}=\left|V\left(\psi_{T / 2}(x, t), t\right)\right|_{h} \leq \frac{\varepsilon}{\sqrt{t}}$, due to the fact that $\left|{ }^{h} \nabla g\right|^{2} \leq \frac{\varepsilon}{t}$.
Hence $d_{h}(\Phi(s)(x), \Phi(t)(x))=d_{h}\left(\psi_{T / 2}(x, s), \psi_{T / 2}(x, t)\right) \leq 2 \varepsilon|\sqrt{t}-\sqrt{s}| \leq 2 \varepsilon \sqrt{|t-s|}$ for all $t, s \in(0, T]$ which shows that $\Phi(0): M \rightarrow M$ is obtained uniformly and is well defined: $d_{h}\left(\Phi(0)(x), \psi_{T / 2}(x, t)\right)=d_{h}(\Phi(0)(x), \Phi(t)(x)) \leq c \sqrt{t}$ for all $x \in M$.

We now turn to the construction and properties of $W$. We can estimate $d_{h}\left(\psi_{t_{i}}(x, s), x\right) \leq$ $\varepsilon \sqrt{s}$ for all $s \in\left(t_{i}, T / 2\right]$, for all $x \in M$ in view of the fact that $\left|\frac{\partial}{\partial s}\left(\psi_{t_{i}}(x, s)\right)\right|_{h} \leq \frac{\varepsilon}{\sqrt{s}}$. In particular writing everything w.r.t to fixed coordinates, $\varphi$ where $\frac{99}{100} \delta \leq h \leq \frac{101}{100} \delta$ and $|D h|^{2}+\left|D^{2} h\right|^{2} \leq \varepsilon$, on a large ball of radius 1000 and centre point $x$, we have $\psi_{t_{i}}(x, s), \psi_{t_{j}}(x, s)$ stays in this ball : We write $x, h, \ldots$ for $\varphi(x), \varphi_{*}(h), \ldots$
For $s \geq s_{0}:=\max \left(t_{j}, t_{i}\right)$

& \leq c(a) \sup _{y \in \mathbb{B}_{1000}(x)}\left(\left|{ }^{h} \nabla^{2} g\right|+\left.\left.\right|^{h} \nabla g\right|^{2}+\varepsilon\right)\left|\psi_{t_{i}}(x, s)-\psi_{t_{j}}(x, s)\right|^{2} \\
& \leq \frac{\varepsilon}{s}\left|\psi_{t_{i}}(x, s)-\psi_{t_{j}}(x, s)\right|^{2}
\end{aligned}

where $m$ is some value lying on the line between $\psi_{t_{i}}(x, s)$ and $\psi_{t_{j}}(x, s)$ in the euclidean ball $\mathbb{B}_{1000}(x)$. Here we used $\left|{ }^{h} \nabla g^{j}\right|^{2} t^{j} \leq \varepsilon$ when $t$ is sufficiently small. Hence, writing $f(s):=\left|\psi_{t_{i}}(x, s)-\psi_{t_{j}}(x, s)\right|^{2}$ we have $\frac{\partial}{\partial s} f(s) \leq \frac{\varepsilon}{s} f(s)$ for $s \geq \max \left(t_{i}, t_{j}\right)=s_{0}$, which implies $\frac{\partial}{\partial s}\left(s^{-\varepsilon} f(s)\right) \leq 0$, and hence $f(s) \leq s^{\varepsilon}\left(\left(s_{0}\right)^{-\varepsilon} f\left(s_{0}\right)\right)$ for all $s \in\left[s_{0}=\right.$ $\left.\max \left(t_{i}, t_{j}\right), T / 2\right]$. This shows, $\left(\psi_{t_{i}}(x, s)\right)_{i \in \mathbb{N}}$ with $t_{i} \searrow 0$ is Cauchy and hence $\lim _{t_{i} \searrow 0} \psi_{t_{i}}(x, s)$ exists for all $s \in(0, T]$, and in particular, $W(0)(x):=\lim _{t \searrow 0} \psi_{t}(x, T / 2)=\lim _{t \searrow 0} W(t)(x)$ is well defined, and achieved uniformly,

The construction of our solution, see Theorem 6.1, Theorem 6.3 and the Tensor Sobolev inequality, Theorem B. 1 (v) guarantee, that, without loss of generality, $\int_{B_{2}(x)}\left(\left|{ }^{h} \nabla g(t)\right|^{4}+\left|{ }^{h} \nabla^{2} g(t)\right|^{2}\right) d h \leq \delta^{4}(a)$ for all $x \in M$ and $\delta(a)$ is the constant from Corollary 5.4. We also have, without loss of generality,

By choosing $R_{1}=R_{1}\left(y_{0}, g_{0}\right)>0$ small enough, we can guarantee that $\int_{B_{R_{1}\left(x_{0}\right)}}\left(\left.\left.\right|^{h} \nabla g_{0}\right|^{4}+\right.$ $\left.\left|{ }^{h} \nabla^{2} g_{0}\right|^{2}\right) d h \leq \frac{\varepsilon}{2}$ for all $x_{0}$ in the compact set $\overline{B_{100}\left(y_{0}\right)}$ in view of Lemma B.3. By scaling once, we have for all such $x_{0}$ that $\int_{B_{8}\left(x_{0}\right)}\left(\left|{ }^{h} \nabla g_{0}\right|^{2}+\left|{ }^{h} \nabla^{2} g_{0}\right|^{2}\right) d h \leq \frac{\varepsilon}{2}$, and $\int_{B_{20}(x)}\left(\left.\left.\right|^{h} \nabla g(t)\right|^{4}+\left|{ }^{h} \nabla^{2} g(t)\right|^{2}\right) d h \leq \delta^{4}(a)$ for all $x \in M$ and all $x_{0}$ in $\overline{B_{100}\left(y_{0}\right)}$ which implies $\int_{B_{20}(x)}\left(\left|{ }^{h} \nabla g(t)\right|^{2}+\left.\left.\right|^{h} \nabla^{2} g(t)\right|^{2}\right) d h \leq \delta(a)$ for all $x \in M$, in view of Hölder's inequality and the fact that $\delta(a)$ is without loss of generality less than $\operatorname{Vol}_{h}\left(B_{20}(x)\right)$ for all $x \in M$. These estimates change at most by a factor when we scale the solution back to the original solution, the constant depending on the scaling factor, $h$ and $x_{0}, g_{0}$ and $p$. These scaled estimates are (ii) for the given $p$. As $p \in[0, \infty)$ was arbitrary, (ii) holds.

\sum_{i=1}^{N-1} L_{\hat{g}_{0}}\left(v_{i}\right) \leq(1+\varepsilon) d_{\hat{g}(1)}(x, \gamma(N-1)) \leq(1+\varepsilon) d_{\hat{g}(1)}(x, y)
$$

as $\gamma$ was a length minimising, with respect to $\hat{g}(1)$, geodesic between $x$ and $y$. Scaling back the solution we had at the beginning of this proof of this claim, (8.8), that is defining $g(s)=\operatorname{tg}\left(s \frac{1}{t}\right)$, for the $t$ we chose there, we see at time $t$ that

in view of the choice of $t \leq \varepsilon^{4}$. That is $v=\cup_{i=1}^{N-1} v_{i}$ is an $R c(a) \varepsilon$-approximative Lebesgue curve and $L_{g_{0}}(v) \leq(1+\varepsilon) d_{t}(x, y)$. Hence $\inf _{\gamma \in C_{R c(a) \varepsilon, x, y}} L_{g_{0}}(\gamma) \leq(1+\varepsilon) d_{t}(x, y)$ for all $t \leq T\left(\varepsilon, a, g_{0}, x, y, R, h\right)$, and this shows $d_{0}(x, y)=\liminf _{\varepsilon \rightarrow 0} \inf _{\gamma \in C_{\varepsilon, x, y}} L_{g_{0}}(\gamma) \leq$ $\lim \inf _{t \rightarrow 0} d_{t}(x, y)$ for all $x, y \in M$.

Now we show that
$d_{0}(x, y):=\liminf _{\varepsilon \rightarrow 0} \inf _{\gamma \in C_{\varepsilon, x, y}} L_{g_{0}}(\gamma) \geq \lim \sup _{t \searrow 0} d_{t}(x, y)$ for all $x, y \in M$.
From the definition of $C_{\varepsilon, x, y}, \gamma \in C_{\varepsilon, x, y}$, may be written as $\gamma=\cup_{i=1}^{N} \gamma_{i}$ where each $\gamma_{i}:\left[a_{i}, b_{i}\right] \rightarrow M$ is a parametrised Lebesgue line. Let $\sigma:\left[c_{i}, d_{i}\right] \rightarrow \mathbb{B}_{2}(x)$ be one of the segments $\gamma_{i}$ written in smooth coordinates, so that $\sigma(t)=t e_{1}$. Since the coordinates are smooth, and $\frac{1}{400 a} h \leq g(t) \leq 400 a h$, we see that there exists a constant $C$ depending possibly on the coordinates and $a$, such that $\frac{1}{C} \delta \leq h \leq C \delta$ and $\frac{1}{C} \delta \leq g(t) \leq C \delta$ in these coordinates.

Using Corollary 5.7 and $|\operatorname{Rm}(h)| \leq \sigma \leq 1$, we see that we have

with respect to these coordinates for all $t \leq 1$ for some constant $c=c(C)$.
Using Lemma 10.1, we see that : For all $\varepsilon>0$ there exists a $t_{0}>0$ such that

That is $\left.L_{g_{0}}\left(\gamma_{i}\right) \geq(1-\varepsilon) d(g(t))\left(\gamma_{i}\left(a_{i}\right), \gamma_{i}\left(b_{i}\right)\right)\right)$.
Hence, estimating on each Lebesgue line $\gamma_{i}$ in this way, we see (setting $\gamma_{N+1}\left(a_{N+1}\right):=y$ that, there exists a $s_{0}$ such that

& \geq \sum_{i=1}^{N}(1-\varepsilon) d_{t}\left(\gamma_{i}\left(a_{i}\right), \gamma_{i+1}\left(a_{i+1}\right)\right)-c \sum_{i=1}^{N} d_{h}\left(\gamma_{i}\left(b_{i}\right), \gamma_{i+1}\left(a_{i+1}\right)\right) \\
& \geq(1-\varepsilon) d_{t}\left(\gamma_{1}\left(a_{1}\right), \gamma_{N+1}\left(a_{N+1}\right)=y\right)-c \varepsilon \\
& \geq(1-\varepsilon) d_{t}(x, y)-2 c \varepsilon
\end{aligned}
$$

for $t \in\left(0, s_{0}\right)$. That is, for fixed $x, y \in M$ we have $d_{0}(x, y) \geq \lim \sup _{t \searrow 0} d_{t}(x, y)$, in view of the definition of $d_{0}$ and the fact that $\varepsilon>0$ was arbitrarily chosen in the argument above. Combining the lower and upper bound proved for $d_{0}(x, y)$, we have

The property $\tilde{d}_{0}=\lim _{t \searrow 0} \tilde{d}_{t}$ now follows easily from the definitions and the fact that $\Phi(t)$ converges uniformly to $\Phi(0)$ as $t \searrow 0$ :

& \leq(\geq) d_{t}(\Phi(t)(x), \Phi(t)(y))+(-) c(n, a) d_{h}(\Phi(t)(x), \Phi(0)(x)) \\
& +(-) c(n, a) d_{h}(\Phi(t)(y), \Phi(0)(y))+\varepsilon(x, y, t) \\
& =\quad \tilde{d}_{t}(x, y)+(-) \quad c(n, a) d_{h}(\Phi(t)(x), \Phi(0)(x)) \\
& +(-) c(n, a) d_{h}(\Phi(t)(y), \Phi(0)(y))+\varepsilon(x, y, t)
\end{aligned}

where $\varepsilon(x, y, t) \rightarrow 0$ for $t \searrow 0$. d.h. $\tilde{d}_{t}(x, y) \rightarrow \tilde{d}_{0}(x, y)$ for $t \searrow 0$.

## 9. Metric convergence in Sobolev spaces

Theorem 9.1. Let $(M, h)$ be a four dimensional Riemannian manifold satisfying (2.4). We assume that there are continuous maps $W(0), \Phi(0): M \rightarrow M$ inverse to one another such that for all compact sets $K \subseteq M, \sup _{x \in K} d_{h}(\Phi(r)(x), \Phi(0)(x)) \rightarrow 0$ as $r \rightarrow 0$, $\sup _{y \in K} d_{h}(W(r)(y), W(0)(y)) \rightarrow 0$ as $r \rightarrow 0$, where $\Phi, W: M \times(0, T) \rightarrow M$, are smooth maps such that $W(s): M \rightarrow M, \Phi(s)$ are smooth diffeomorphisms inverse to one another, for all $s \in(0, T)$. Let $\ell(s)_{s \in(0, T)}, g(s)_{s \in(0, T)}$ be smooth families of Riemannian metrics isometric to one another through the smooth maps $\Phi(s)$ and $W(s): \ell(s)=\Phi(s)^{*}(g(s))$, $g(s)=W(s)^{*} \ell(s)$. Assume that we have chosen smooth coordinates $\varphi: U \rightarrow \mathbb{R}^{n}$, and $\psi$ : $V \rightarrow \mathbb{R}^{n}$ and open sets $\tilde{U} \subset \subset U$ and $\tilde{V} \subset \subset V$ with $W(s)(\tilde{V}) \subset \subset U$ and $\Phi(s)(\tilde{U}) \subset \subset V$ for all $s \in[0, S], W(s)(V) \subset \subset U$ for all $s \in[0, S]$ for some $0<S<T$. That is, in these coordinates we have

g_{\alpha \beta}(s)(y)=D_{\alpha} W^{i}(s)(y) D_{\beta} W^{j}(s)(y) \ell_{i j}(W(s)(y), s)

for $x \in \tilde{U}, y \in \tilde{V}$. Assume further, that there exist Riemannian metrics $\ell(0)$ and $g(0)$ whose inverse exists almost everywhere, so that $g(0), \ell(0), g^{-1}(0), \ell^{-1}(0) \in L_{\text {loc }}^{p}$ for all $p \in[1, \infty)$ such that
(i) $\ell(s) \rightarrow \ell(0), \ell^{-1}(s) \rightarrow \ell^{-1}(0), g(s) \rightarrow g(0), g^{-1}(s) \rightarrow g^{-1}(0)$ as $s \rightarrow 0$ locally in $L^{p}$ for all $p \in[1, \infty)$,
(ii) For any compact set $K \subseteq M$, for all $s \in(0, T), p \in[1, \infty)$, there exists a constant $c(K, h, p)$ such that $\|\ell(s)\|_{W^{1,2}(K)}+\|g(s)\|_{W^{1,4}(K)} \leq c(K, h, p)$,
(iii) There is a constant $a \geq 1$ such that $\frac{1}{a} h \leq g(s) \leq a h$ for all $s \in(0, T)$.

Then: $D \Phi(s)$ is bounded in $L^{p}(\tilde{U})$ and $D W(s)$ is bounded in $L^{p}(\tilde{V})$ uniformly independent of $s \in(0, T)$. Furthermore, $\Phi(s) \rightarrow \Phi(0)$ and $W(s) \rightarrow W(0)$ locally in $W^{1, p}$ for any $p \in[1, \infty), \ell(0) \circ W(0)$ is in $L_{\text {loc }}^{p}$ for all $p \in[1, \infty)$, and $\ell(0)$ and $g_{0}$ are isometric to one another through the map $W(0)$, which is in $W_{\text {loc }}^{1, p}$, for all $p \in[1, \infty)$ :

on $\tilde{V}$ in the $L^{p}$ sense for all $p \in[1, \infty)$.

Proof. We consider in the following only $s \in(0, S)$. The first identity of (9.1) implies:

where $\underset{\tilde{U}}{ }(p, \ldots)$ is a constant depending on $p, \tilde{U}, a, \ell, h$. Constants which only depend on $p, \tilde{U}, \tilde{V}, \varphi, \psi, \Phi, W, a, \ell, h, g \ell^{-1} h^{-1}, g^{-1}$ and importantly don't depend on $s$ shall be denoted by $c(p, \ldots)$, although the value may differ from line to line. In view of the uniform convergence of $\Phi(s)$ and $W(s)$ we may assume, by choosing geodesic coordinates with respect to $h$ around $m$ and $\Phi(0)(m)$ without loss of generality, that $\tilde{U}=B_{r}(m)=: B$ and $\tilde{V}=B_{v}(\Phi(0)(m))=: \hat{B}$ so that $\frac{1}{2} \delta_{\alpha \beta} \leq h_{\alpha \beta} \leq 2 \delta_{\alpha \beta}$ on $\tilde{V}$ and $\frac{1}{2} \delta_{i j} \leq h_{i j} \leq 2 \delta_{i j}$ on $\tilde{U}$, and $\tilde{B}=B_{\tilde{r}}(m) \subseteq W(s)(\hat{B}) \subseteq B=B_{r}(m)$ for $s$ sufficiently small. With respect to these coordinates we have

for sufficiently small $s>0$, where $c(p(\varepsilon), \ldots)$ is independent of $s$, and $2>\varepsilon>0$ is arbitrary, since $D g$ is bounded in $L^{4}$ due to the assumptions, and $D W(s)$ is bounded uniformly in every $L^{p}$ for every fixed $p$., and we used $\left(\int_{W(s)(\hat{B})}|D \Phi(s)|^{r(4-\varepsilon)}(x) d x\right)^{\frac{1}{r}} \leq$ $c(p, \varepsilon, \ldots)$. Hence for any sequence $t_{i}>0$ with $t_{i} \rightarrow 0$ as $i \rightarrow \infty$, we can find a subsequence $s_{i}$ with $s_{i} \searrow 0$ such that $\left(g_{s_{i}}\right)_{\alpha \beta} \circ \Phi\left(s_{i}\right)$ converges strongly in $L^{p}$ to some $Z_{\alpha \beta}$ on $\tilde{B}$ for all $p$ as $s_{i}$ goes to zero, in view of the Sobolev-Embedding theorems (see for example Theorem 7.26 in [13]). $Z$ satisfies $\frac{1}{C(a)} \delta_{\alpha \beta} \leq Z_{\alpha \beta} \leq C(a) \delta_{\alpha \beta}$ on $\tilde{B}$ since
$\frac{1}{2} \delta_{\alpha \beta} \leq h_{\alpha \beta}(\cdot) \leq 2 \delta_{\alpha \beta}$ on $\varphi(s)(\tilde{B}) \subseteq \tilde{V}$ and $\frac{1}{a} h \leq g(s) \leq a h$.
For a sequence $0<s_{i} \searrow 0$, we write $g(i)=g\left(s_{i}\right)$ and $\Phi(i)=\Phi\left(s_{i}\right)$ and $\ell(i):=\ell\left(s_{i}\right)$.

& \leq c(p, \ldots) \int_{\tilde{B}}|D \Phi(i)-D \Phi(j)|_{h, Z}^{p}(x) d x \\
& \leq c(p, \ldots) \int_{\tilde{B}}\left(1+\left|\ell_{0}\right|_{h}^{2}\right)^{p / 2}(x)|D \Phi(i)-D \Phi(j)|_{\ell_{0}, Z}^{p}(x) d x \\
& \leq c(p, \ldots)\left(\int_{\tilde{B}}\left(1+\left|\ell_{0}\right|_{h}^{2}\right)^{p}(x) d x\right)^{\frac{1}{2}}\left(\int_{\tilde{B}}|D \Phi(i)-D \Phi(j)|_{\ell_{0}, Z}^{2 p}(x) d x\right)^{\frac{1}{2}} \\
& =c(p, \ldots)\left(\int_{\tilde{B}}(\operatorname{err}(i, j))^{2 p}(x) d x\right)^{\frac{1}{2}}
\end{aligned}
$$

where $\int_{\tilde{B}}|\operatorname{err}(i, j)|^{2 p} \rightarrow 0$ as $i, j \rightarrow \infty$. That is $\left.D \Phi(i)\right|_{\tilde{B}}$ is Cauchy in $L^{p}(\tilde{B})$. Since $\Phi(i) \rightarrow$ $\Phi(0)$ in locally, uniformly, and hence locally in $L^{p}$ for any $p<\infty$, we see $\Phi(i) \rightarrow \Phi(0)$ in $W^{1, p}(\tilde{B})$ as $i \rightarrow \infty$. In fact $\Phi(s) \rightarrow \Phi(0)$ in $W^{1, p}(\tilde{B})$ as $s \searrow 0$. If this were not the case, then we could find a sequence of times $t_{i} \rightarrow 0$ such that $\left|\Phi\left(t_{i}\right)-\Phi(0)\right|_{W^{1, p}(\tilde{B})} \geq \sigma>0$. Repeating the above argument, we see that a subsequence $\Phi\left(s_{i}\right)$ of $\Phi\left(t_{i}\right)$ converges to $\Phi(0)$ in $W^{1, p}(\tilde{B})$, which contradicts $\left|\Phi\left(t_{i}\right)-\Phi(0)\right|_{W^{1, p}(\tilde{B})} \geq \sigma>0$.

We now show that a subsequence of $\ell_{t_{i}} \circ W\left(t_{i}\right)$ converges in $L^{p}$ locally for any sequence $t_{i} \searrow 0$. For $0<4 \delta<3$ we have (where here the norm, $|\cdot|$ refers to the euclidean norm)

& \leq \int_{\hat{B}}|D \ell|^{1+2 \delta} \circ W(s) d y+\int_{\hat{B}}|D W(s)|^{v} d y \\
& {\left[\text { with } v=\frac{1}{1-(1 / q)}, q=\frac{1+2 \delta}{1+\delta}\right] } \\
& \leq \int_{\hat{B}}|D \ell|^{1+2 \delta} \circ W(s) d y+c(v(\delta), \ldots) \\
& =\int_{\hat{B}}\left(|D \ell|^{1+2 \delta} \circ W(s)\right)\|D \Phi(s) \circ W(s)\|\|D W(s)\| d y+c(v(\delta), \ldots) \\
& =\int_{W(s)(\hat{B})}|D \ell|^{1+2 \delta} d x\|D \Phi(s)\|+c(v(\delta), \ldots) \\
& \leq \int_{W(s)(\hat{B})}|D \ell|^{1+4 \delta} d x+\int_{W(s)(\hat{B})}\|D \Phi(s)\|^{\hat{p}} d x+c(v(\delta), \ldots) \\
& {\left[\text { with } \hat{p}=\frac{1}{1-(1 / \hat{q})}, \hat{q}=\frac{1+4 \delta}{1+2 \delta}\right] } \\
& \leq c(v(\delta), \ldots)
\end{aligned}
$$

where $c(v(\delta), \ldots)$ is independent of $s$. Hence a subsequence $\left(s_{i}\right)_{i \in \mathbb{N}}$ of $\left(t_{i}\right)_{i \in \mathbb{N}}$ satisfies $\ell_{j k}\left(s_{i}\right) \circ W\left(s_{i}\right) \rightarrow R_{j k}$ in $L^{\alpha(\delta)}(\hat{B})$ for some $R \in L^{\alpha}(\hat{B})$ from the Sobolev embedding Theorems (see for example Theorem 7.26 in [13]). In particular $\ell_{j k}\left(s_{i}\right) \circ W\left(s_{i}\right) \rightarrow R_{j k}$ almost everywhere on $\hat{B}$. On the other hand, the transformation formula for smooth diffeomorphisms shows us that

\int_{\hat{B}}\left|\ell_{s} \circ W(s)\right|^{p} d y & =\int_{\hat{B}}\left|\ell_{s} \circ W(s)\right|^{p}\|D \Phi(s)\| \circ W(s)\|D W(s)\| d y \\
& =\int_{W(s)(\hat{B})}\left|\ell_{s}\right|^{p}\|D \Phi(s)\| d x \\
& \leq c(p, \ldots)
\end{aligned}
$$

in view of Hölder's Theorem, since $\ell_{s}$ and $D \Phi(s)$ are uniformly bounded in $L^{p}(B)$ for all $p \in[1, \infty)$. This shows us that $\ell\left(s_{i}\right) \circ W\left(s_{i}\right) \rightarrow R$ in $L^{p}(\hat{B})$ for all $p \in[1, \infty)$ and that $R \in L^{p}(\hat{B})$. Similarly $\ell\left(s_{i}\right)^{-1} \circ W\left(s_{i}\right) \rightarrow R^{-1}$ with $R^{-1}$ in $L^{p}$ for all $p \in[1, \infty)$ after taking a subsequence : $\left|D\left(\ell^{i j}(s) \circ W(s)\right)\right|^{1+\delta}=\left|\ell^{i k}(s) \ell^{j l}(s) D \ell_{k l}(s) \circ W(s)\right|^{1+\delta}$ and hence
a subsequence of $\ell^{i j}\left(s_{k}\right) \circ W\left(s_{k}\right)$ converges in $L^{\alpha(\delta)}$ to some $H^{i j}$ in $L^{\alpha(\delta)}$, and we also have

\begin{aligned}
\int_{\hat{B}}\left|\ell_{s}^{-1} \circ W(s)\right|^{p} d y & =\int_{\hat{B}}\left|\ell_{s}^{-1} \circ W(s)\right|^{p}\|D \Phi(s)\| \circ W(s)\|D W(s)\| d y \\
& =\int_{W(s)(\hat{B})}\left|\ell_{s}^{-1}\right|^{p}\|D \Phi(s)\| d x \\
& \leq c(p, \ldots)
\end{aligned}
$$

and so, $\ell^{i j}\left(s_{k_{r}}\right) \circ W\left(s_{k_{r}}\right) \rightarrow H^{i j}$ in $L^{p}(\hat{B})$ for all $p \in[1, \infty)$, where $\left(s_{k_{r}}\right)_{r \in \mathbb{N}}$ is a subsequence of $\left(s_{k}\right)_{k \in \mathbb{N}}$. We also have $\delta_{m}^{j}=\ell^{j k}\left(s_{i_{r}}\right) \circ W\left(s_{i_{r}}\right) \ell_{k m}\left(s_{i_{r}}\right) \circ W\left(s_{i_{r}}\right) \rightarrow H^{j k} R_{k m}$ in $L^{p}(\hat{B})$ and hence almost everywhere, and hence $H$ is the inverse of $R$ almost everywhere, and after changing the function $H$ on a set of measure zero, $H$ is the inverse of $R$ everywhere.

Using (9.1) we see

and writing $W(k):=W\left(s_{i_{k}}\right), g(k):=g\left(s_{i_{k}}\right), \ldots$, we have

0 & =g(k)^{\beta \alpha}(y) D_{\alpha} W^{i}(k)(y) D_{\beta} W^{j}(k)(y) \ell(k)_{i j}(W(k)(y)) \\
& -g(l)^{\beta \alpha}(y) D_{\alpha} W^{i}(l)(y) D_{\beta} W^{j}(l)(y) \ell(l)_{i j}(W(l)(y)) \\
= & g(0)^{\beta \alpha}(y)\left(D_{\alpha} W^{i}(k)(y) D_{\beta} W^{j}(k)(y)-D_{\alpha} W^{i}(l)(y) D_{\beta} W^{j}(l)(y)\right) R_{i j}(y) \\
& +\operatorname{err}(k, l)(y) \\
= & |D W(k)-D W(l)|_{g(0), R}^{2}+\operatorname{err}(k, l),
\end{aligned}
$$

where $\operatorname{err}(k, l) \rightarrow 0$ in $L^{p}(\hat{B})$ for all $p \in[1, \infty)$. Hence, using (D.1) of Theorem D. 1 we have

\begin{aligned}
& \int_{\hat{B}}|D W(k)-D W(l)|_{\delta, \delta}^{2 p} d y \\
& \leq c(p, \ldots) \int_{\hat{B}}|D W(k)-D W(l)|_{g(0), h}^{2 p} d y \\
& \leq c(p, \ldots) \int_{\hat{B}}\left(|D W(k)-D W(l)|_{g(0), R}^{2 p}\right)\left(1+|h|_{R}^{2 p}\right) d y \\
& \leq c(p, \ldots)\left(\int_{\hat{B}}|D W(k)-D W(l)|_{g(0), R}^{4 p} d y\right)^{\frac{1}{2}} \\
& =c(p, \ldots)\left(\int_{\hat{B}}|\operatorname{err}(k, l)|^{4 p} d y\right)^{\frac{1}{2}}
\end{aligned}
$$

and hence $W(k)$ is Cauchy in $W^{1, p}(\hat{B})$ and hence converges. Here we used that $\int_{\hat{B}}|h|_{R}^{4 p} d y$ is bounded which follows from the fact that $R^{-1}=H \in L^{q}$ for all $q \in[1, \infty)$. Using a similar argument to the one we used for $\Phi$, we see that $W(s) \rightarrow W(0)$ in $W^{1, p}(\hat{B})$ as $s \searrow 0$, ie. that the convergence $W\left(t_{i}\right) \rightarrow W(0)$ in $W^{1, p}(\hat{B})$ holds for all sequences $0<t_{i} \rightarrow 0$.

We saw that $\ell(s) \circ W(s)$ converges in $L^{p}(\hat{B})$ for all $p \in[1, \infty)$ as $s \searrow 0$. We would like to further show that the limit function is $\ell(0) \circ W(0)$.

Using the change of variable formula for smooth diffeomorphisms, we see for the same coordinates from above, for any $B_{r}\left(y_{0}\right) \subset \subset \hat{B}$ and any cut off smooth non-negative function $\eta$ with support in $B_{r-2 \varepsilon}\left(y_{0}\right)$ that

\int_{B_{r}\left(y_{0}\right)} \ell_{s} \circ W(s) \cdot \eta d y & =\int_{B_{r-2 \varepsilon}\left(y_{0}\right)} \ell_{s} \circ W(s) \cdot \eta \circ \Phi(s) \circ W(s) \cdot\|D \Phi(s)\| \circ W(s)\|D W(s)\| d y \\
& =\int_{W(s)\left(B_{r-2 \varepsilon}\left(y_{0}\right)\right)} \ell_{s} \cdot \eta \circ \Phi(s) \cdot\|D \Phi(s)\| d x \\
& =\int_{W(\delta)\left(B_{r-\varepsilon / 4}\left(y_{0}\right)\right)} \ell_{0} \cdot \eta \circ \Phi(0) \cdot\|D \Phi(0)\| d x+\operatorname{err}(s)
\end{aligned}
$$

for any $\delta \leq s$, where $\operatorname{err}(s) \rightarrow 0$ in $L_{l o c}^{p}$ as $s \searrow 0$ since $D \Phi(s) \rightarrow D \Phi(0)$ in $L_{l o c}^{p}$ and $\Phi(s) \rightarrow \Phi(0)$ uniformly as $s \searrow 0$ and $\ell_{s} \rightarrow \ell_{0}$ in $L_{l o c}^{p}$ as $s \searrow 0$, and $\eta \circ \Phi(s)$ has compact support in $W(s)\left(B_{r-2 \varepsilon}\left(y_{0}\right)\right) \subseteq W(\delta)\left(B_{r-\varepsilon / 4}\left(y_{0}\right)\right)$ for $s, \delta$ sufficiently small. $\Phi(0), W(0)$ are homeomorphisms which are continuous representatives of $W_{l o c}^{1, p}$ functions with $p>n$ and so they both satisfy the Lusin $N$-Property (see Corollary B , [25]) and hence the change of area formula is valid for $\Phi(0)$ and $W(0)$ (see Proposition 1.1 of [24]) :

& =\int_{\Phi(0)\left(W(\delta)\left(B_{r-\varepsilon / 4}\left(y_{0}\right)\right)\right.} \ell_{0} \circ W(0) \cdot \eta d y+\operatorname{err}(s) \\
& \rightarrow \int_{B_{r}} \ell_{0} \circ W(0) \cdot \eta d y
\end{aligned}
$$

as $s \searrow 0$. As this is true for any continuous $\eta$ and ball $B_{r}\left(y_{0}\right)$ of this type, we see that $\ell(s) \circ W(s) \rightarrow R=\ell_{0} \circ W(0)$ almost everywhere and in $L_{l o c}^{p}$, since $\ell(s) \circ W(s)$ converges in $L_{l o c}^{p}$ for $s \searrow 0$, for all $p \in[1, \infty): \int \eta \ell(s) \circ W(s) d y \rightarrow \int \eta R d y=\int \eta \ell(0) \circ W(0) d y$, and hence $\int \eta(R-\ell(0) \circ W(0)) d y=0$ for all non-negative cut off functions of this type, and hence, using the Fundamental lemma of the calculus of variations, we have, $R-\ell(0) \circ W(0)=0$ in $L^{1}(\hat{B})$ and hence $R=\ell(0) \circ W(0)$ almost everywhere in $B_{r}\left(y_{0}\right)$. Returning to the last identity in (9.1), we see that $g(0)_{\alpha \beta}=D_{\alpha} W^{i}(0) D_{\beta} W^{j}(0) \ell_{i j}(0) \circ W(0)$ almost everywhere and in the $L^{p}$ sense. An almost identical argument shows that $g_{\alpha \beta}(s) \circ \Phi(s)$ converges to $g_{\alpha \beta}(0) \circ \Phi(0)$ in $L^{p}$, as we now explain. Let $C=W(0)\left(B_{r}\left(y_{0}\right)\right)$ and $\eta$ a cut off function with compact support in $W(0)\left(B_{r-4 \varepsilon}\left(y_{0}\right)\right)$. Then $\eta=0$ outside of $W(s)\left(B_{r-2 \varepsilon}\left(y_{0}\right)\right)$ and $W(0)\left(B_{r-4 \varepsilon}\left(y_{0}\right)\right) \subseteq W(s)\left(B_{r-2 \varepsilon}\left(y_{0}\right)\right)$ for sufficiently small $s>0$. Hence

\begin{aligned}
\int_{C} g(s) \circ \Phi(s) \eta d x & =\int_{W(0)\left(B_{r-4 \varepsilon}\left(y_{0}\right)\right)} g(s) \circ \Phi(s) \eta d x \\
& =\int_{W(s)\left(B_{r-2 \varepsilon}\left(y_{0}\right)\right)} g(s) \circ \Phi(s) \eta d x \\
& =\int_{W(s)\left(B_{r-2 \varepsilon}\left(y_{0}\right)\right)} g(s) \circ \Phi(s) \cdot \eta \circ W(s) \circ \Phi(s) \cdot\|D W(s)\| \circ \Phi(s)\|D \Phi(s)\| d x \\
& =\int_{B_{r-2 \varepsilon}\left(y_{0}\right)} g(s) \cdot \eta \circ W(s) \cdot\|D W(s)\| d y \\
& =\int_{B_{r-2 \varepsilon}\left(y_{0}\right)} g(0) \cdot \eta \circ W(0) \cdot\|D W(0)\| d y+\operatorname{err}(s) \\
& =\int_{W(0)\left(B_{r-2 \varepsilon}\left(y_{0}\right)\right)} g(0) \circ \Phi(0) \cdot \eta d x+\operatorname{err}(s) \\
& \rightarrow \int_{C} g(0) \circ \Phi(0) \eta d x
\end{aligned}
$$

as $s \searrow 0$ where we have once again used that the change of variables formula is valid for $\Phi(0)$ and $W(0)$. Hence, since $g(s) \circ \Phi(s) \rightarrow Z$ in $L_{l o c}^{p}$ we have $g(s) \circ \Phi(s) \rightarrow Z=g(0) \circ \Phi(0)$ in $L^{p}(C)$ as $s \searrow 0$ for all $p \in[1, \infty)$, in view of the Fundamental lemma of the calculus of variations. Hence $g(s) \circ \Phi(s) \rightarrow g(0) \circ \Phi(0)$ in $L_{l o c}^{p}$ as $s \searrow 0$, for all $p \in[1, \infty)$. Returning to the first identity in (9.1), we see that this implies

\ell_{i j}(0)(x)=D_{i} \Phi^{\alpha}(0)(x) D_{j} \Phi^{\beta}(0)(x) g_{\alpha \beta}(0)(\Phi(0)(x))
$$

almost everywhere and in the $L^{p}$ sense.

## 10. Distance convergence in Sobolev spaces

Lemma 10.1. In the following $\mathbb{B}_{r}^{k}(0)$ is a $k$-dimensional ball of radius $r>0$ in $\mathbb{R}^{k}$ and middlepoint 0. Let $c>1$ and $g: \mathbb{B}_{2}^{n}(0) \times[0,1] \rightarrow \mathbb{R}^{n \times n}$ be a family of non-negative
two-tensors, such that

\int_{\mathbb{B}_{2}^{n}(0)}|g(t)(z)-g(0)(z)|_{\delta}^{2} d z & \leq c t  \tag{10.1}\\
\frac{1}{c} \delta \leq g(t) & \leq c \delta \tag{10.2}

$$

for all $t \in[0,1)$, where $g(t)$ are smooth for all $t>0$ and $g(0)$ is in $L^{2}$.
Let $\sigma:[-1,1] \rightarrow \mathbb{B}_{2}^{n}(0), \sigma(s)=s e_{1}$ be a Lebesgue line with respect to $g(0)$, that is the function $\sqrt{g(0)_{11}(\cdot, \cdot)}:[-1,1] \times \mathbb{B}_{1}^{n-1}(0) \subseteq \mathbb{B}_{2}^{n}(0) \rightarrow \mathbb{R}_{0}^{+}$is measurable, $\sqrt{g(0)_{11}(s, 0)}$ : $\mathbb{B}_{1}^{n-1}(0) \rightarrow \mathbb{R}_{0}^{+}$is measurable, $\sqrt{g(0)_{11}(s, \cdot)}: \mathbb{B}_{1}^{n-1}(0) \rightarrow \mathbb{R}_{0}^{+}$is measurable for almost all $s \in[-1,1], \sqrt{g(0)_{11}(\cdot, x)}:[-1,1] \rightarrow \mathbb{R}_{0}^{+}$is measurable for almost all $x \in \mathbb{B}_{1}^{n-1}(0)$ and

$$
\begin{aligned}
\int_{-1}^{1} \sqrt{g(0)_{11}(s, 0)} d s & =\lim _{\alpha \rightarrow 0} \frac{1}{\omega_{n-1} \alpha^{n-1}} \int_{-1}^{1} \int_{\mathbb{B}_{\alpha}^{n-1}(0)} \sqrt{g(0)_{11}(s, x)} d x d s \\
& =\lim _{\alpha \rightarrow 0} \frac{1}{\omega_{n-1} \alpha^{n-1}} \int_{T_{\alpha}(\sigma)} \sqrt{g(0)_{11}(z)} d z
\end{aligned}
$$

where $d x$ is $n-1$ dimensional Lebesgue measure, and $d z$ is $n$ dimensional Lebesgue measure, $T_{\alpha}(\sigma):=\left\{\sigma(s)+\beta(0, v)\left|s \in[-1,1], v \in \mathbb{R}^{n-1},|v|=1, \beta \in \mathbb{R},|\beta| \leq \alpha\right\}\right.$ is an $\alpha$ tubular neighbourhood of $\sigma, \omega_{n-1} \alpha^{n-1}$ is the (Lebesgue) $n-1$ dimensional volume of $T_{\alpha}(\sigma(s)):=\left\{\sigma(s)+\beta(0, v)\left|v \in \mathbb{R}^{n-1},|v|=1, \beta \in \mathbb{R},|\beta| \leq \alpha\right\}\right.$. Then: For all $\varepsilon>0$ there exists a $t_{0}>0$ such that

&= \frac{\int_{y \in T_{\alpha}(\sigma)}\left(\sqrt{g(0)_{11}(y)}-\sqrt{g(t)_{11}(y)}\right)+\sqrt{g(t)_{11}(y)} d y}{\operatorname{Vol}\left(\mathbb{B}_{\alpha}^{n-1}(0)\right)}-R(\alpha) \\
& \geq \frac{\int_{y \in T_{\alpha}(\sigma)}-\left|\sqrt{g(0)_{11}(y)}-\sqrt{g(t)_{11}(y)}\right| \sqrt{g(t)_{11}(y)} d y}{\operatorname{Vol}\left(\mathbb{B}_{\alpha}^{n-1}(0)\right)}-R(\alpha) \\
& {\left[\text { using }|\sqrt{a}-\sqrt{b}| \leq \sqrt{|a-b|} \text { for } a, b \in \mathbb{R}^{+}\right] } \\
& \geq \frac{\int_{y \in T_{\alpha}(\sigma)}-\sqrt{\left|g(0)_{11}(y)-g(t)_{11}(y)\right|}+\sqrt{g(t)_{11}(y)} d y}{\operatorname{Vol}\left(\mathbb{B}_{\alpha}^{n-1}(0)\right)}-R(\alpha) \\
& \geq-\frac{\left(\int_{y \in T_{\alpha}(\sigma)}\left|g(0)_{11}(y)-g(t)_{11}(y)\right|^{2} d y\right)^{\frac{1}{4}}}{\operatorname{Vol}\left(\mathbb{B}_{\alpha}^{n-1}(0)\right)}\left(2 \operatorname{Vol}\left(\mathbb{B}_{\alpha}^{n-1}(0)\right)\right)^{\frac{3}{4}}  \tag{10.4}\\
&+\frac{\int_{y \in T_{\alpha}(\sigma)} \sqrt{g(t)_{11}(y)} d y}{\operatorname{Vol}\left(\mathbb{B}_{\alpha}^{n-1}(0)\right)}-R(\alpha) \\
& \geq \frac{-2 c t^{\frac{1}{4}}\left(\operatorname{Vol}\left(\mathbb{B}_{\alpha}^{n-1}(0)\right)\right)^{\frac{3}{4}}}{\operatorname{Vol}\left(\mathbb{B}_{\alpha}^{n-1}(0)\right)}+\frac{\int_{x \in \mathbb{B}_{\alpha}^{n-1}(0)} \int_{-1}^{1} \sqrt{g(t)_{11}(s, x)} d s d x}{\operatorname{Vol}\left(\mathbb{B}_{\alpha}^{n-1}(0)\right)}-R(\alpha) \\
& \geq \frac{-c t^{\frac{1}{4}}}{\left(\operatorname{Vol}\left(\mathbb{B}_{\alpha}^{n-1}(0)\right)\right)^{\frac{1}{4}}}+\frac{\int_{x \in \mathbb{B}_{\alpha}^{n-1}(0)} L_{g(t)}\left(\sigma_{x}\right) d x}{\operatorname{Vol}\left(\mathbb{B}_{\alpha}^{n-1}(0)\right)}-R(\alpha) \\
& \geq \frac{-c t^{\frac{1}{4}}}{\left(\operatorname{Vol}\left(\mathbb{B}_{\alpha}^{n-1}(0)\right)\right)^{\frac{1}{4}}}+\inf _{x \in \mathbb{B}_{\alpha}^{n-1}(0)} L_{g(t)\left(\sigma_{x}\right)-R(\alpha)} \\
& \geq \frac{-c t^{\frac{1}{4}}}{\left(\operatorname{Vol}\left(\mathbb{B}_{\alpha}^{n-1}(0)\right)\right)^{\frac{1}{4}}}+\inf \left\{d_{t}((-1, x),(1, x)) \mid x \in \overline{\mathbb{B}_{\alpha}^{n-1}(0)}\right\}-R(\alpha), \tag{10.5}

where $R(\alpha)$ is independent of $t$ and $R(\alpha) \rightarrow 0$ as $\alpha \searrow 0$, and $\sigma_{x}:[-a, a] \rightarrow \mathbb{R}^{n}$ is $\sigma_{x}(s)=(s, x)$. Now using the equivalence of $g(t)$ to $\delta$ with the constant $c$ we see that

\end{aligned}

independently of $t$, and hence choosing $t=\alpha^{200 n}$ and $\alpha=\alpha(\varepsilon)$ small enough, we see that

Lemma 10.2. For all $\varepsilon>0$ there exists a $\alpha>0$ such that if $g$ is an $L^{2}$ metric on $\mathbb{B}_{1}(0) \subseteq$ $\mathbb{R}^{n}$, the standard ball of radius one and middlepoint 0 in $\mathbb{R}^{n}$, with $\int_{\mathbb{B}_{1}(0)}|g-\delta|^{2} \leq \alpha$, then there exits an $x \in \mathbb{B}_{\varepsilon}^{n-1}(0)$ such that $\sqrt{g_{11}}(\cdot, x):\left[-\frac{1}{2}, \frac{1}{2}\right] \rightarrow \mathbb{R}^{n}$ is measurable, $\sigma:\left[-\frac{1}{2}, \frac{1}{2}\right] \rightarrow \mathbb{R}^{n}, \sigma(t)=x+e_{1} t$, is a Lebesgue line between $\left(-\frac{1}{2}, x\right)$ and $\left(\frac{1}{2}, x\right)$ and

Proof. Fubini's Theorem tells us that the function $f: \mathbb{B}_{\frac{1}{4}}^{n-1}(0) \rightarrow \mathbb{R}_{0}^{+}, f(x):=\int_{-\frac{1}{2}}^{\frac{1}{2}} \sqrt{g_{11}(s, x)} d s$ is well defined for almost all $x \in \mathbb{B}_{\frac{1}{4}}^{n-1}(0)$ and defines an $L^{1}$ function, also denoted by $f$, and the function $\hat{f}:[-1,1] \rightarrow \mathbb{R}_{0}^{+} \hat{f}(s):=\int_{\mathbb{B}_{\frac{1}{4}}^{n-1}(0)} \sqrt{g_{11}(s, x)} d x$ is well defined for almost all $s \in\left[-\frac{1}{2}, \frac{1}{2}\right]$ and defines an $L^{1}$ function, and $\int_{\mathbb{B}_{\frac{1}{4}}^{n-1}(0)} f(x) d x=$ $\int_{-\frac{1}{2}}^{\frac{1}{2}} \int_{\mathbb{B}_{\frac{1}{4}}^{n-1}(0)} \sqrt{g_{11}(s, x)} d x d s=\int_{\mathbb{B}_{\frac{1}{4}}^{n-1}(0)} \int_{-\frac{1}{2}}^{\frac{1}{2}} \sqrt{g_{11}(s, x)} d s d x=\int_{\mathbb{B}_{\frac{1}{4}}^{n-1}(0) \times\left[-\frac{1}{2}, \frac{1}{2}\right]} \sqrt{g_{11}(z)} d z$. This also implies that almost every $x \in \mathbb{B}_{\frac{1}{4}}^{n-1}(0)$ is a Lebesgue point of $f$, that is

That is, almost every curve $v_{x}:\left[-\frac{1}{2}, \frac{1}{2}\right] \rightarrow \mathbb{B}_{1}(0), v_{x}(s):=(s, x)$ for $x \in \mathbb{B}_{\frac{1}{4}}^{n-1}(0)$ is a parametrised Lebesgue line.

We wish to estimate the measure $m$ of the set $Z \subseteq \mathbb{B}_{\frac{1}{4}}^{n-1}(0)$ of $x \in \mathbb{B}_{\frac{1}{4}}^{n-1}(0)$ such that $\int_{-\frac{1}{2}}^{\frac{1}{2}} \sqrt{g_{11}(s, x)} d s$ is well defined and for which $\int_{-\frac{1}{2}}^{\frac{1}{2}} \sqrt{g_{11}(s, x)} d s \geq 1+\hat{\alpha}$ where $\hat{\alpha}:=(\alpha)^{\frac{1}{8}}$ $(\rightarrow 0$ as $\alpha \rightarrow 0)$. We will see that $m \leq a(n) \alpha^{\frac{1}{8}}$. Using $|\sqrt{a}-\sqrt{b}| \leq \sqrt{|a-b|}$ for $a, b \in \mathbb{R}^{+}$, we see that

& \geq \int_{\mathbb{B}_{\frac{1}{4}}^{n-1}(0)} \int_{-\frac{1}{2}}^{\frac{1}{2}}\left|\sqrt{g_{11}(s, x)}-1\right|^{4} d s d x \\
& \geq \frac{\left(\int_{\mathbb{B}_{\frac{1}{4}}^{n-1}(0)} \int_{-\frac{1}{2}}^{\frac{1}{2}}\left|\sqrt{g_{11}(s, x)}-1\right| d s d x\right)^{4}}{\left(\operatorname{Vol}_{\left.\left(\mathbb{B}_{\frac{1}{4}}^{n-1}(0) \times\left[-\frac{1}{2}, \frac{1}{2}\right]\right)\right)^{3}}\right.} \\
& =\frac{1}{c(n)}\left(\int_{\mathbb{B}_{\frac{1}{4}}^{n-1}(0)} \int_{-\frac{1}{2}}^{\frac{1}{2}}\left|\sqrt{g_{11}(s, x)}-1\right| d s d x\right)^{4} \\
& \geq \frac{1}{c(n)}\left(\int_{\mathbb{B}_{\frac{1}{4}}^{n-1}(0)}\left|\int_{-\frac{1}{2}}^{\frac{1}{2}}\left(\sqrt{g_{11}(s, x)}-1\right) d s\right| d x\right)^{4} \\
& \geq \frac{1}{c(n)}\left(\int_{Z}\left|\int_{-\frac{1}{2}}^{\frac{1}{2}}\left(\sqrt{g_{11}(s, x)}-1\right) d s\right| d x\right)^{4} \\
& =\frac{1}{c(n)}\left(\int_{Z}\left|\int_{-\frac{1}{2}}^{\frac{1}{2}} \sqrt{g_{11}(s, x)} d s-1\right| d x\right)^{4} \\
& =\frac{1}{c(n)}\left(\int_{Z} \int_{-\frac{1}{2}}^{\frac{1}{2}} \sqrt{g_{11}(s, x)} d s-1 d x\right)^{4} \\
& \geq \frac{1}{c(n)}\left(\int_{Z} \hat{\alpha} d x\right)^{4} \\
& \geq \frac{1}{c(n)} m^{4}(\hat{\alpha})^{4}

which implies $m^{4} \leq \frac{c(n) \alpha}{\hat{\alpha}^{4}}=c(n) \alpha^{\frac{1}{2}}$, that is, $m=\mathcal{L}^{n-1}(Z) \leq(c(n))^{\frac{1}{4}} \alpha^{\frac{1}{8}} \leq \alpha^{\frac{1}{20}}$ for $\alpha \leq$ $\frac{1}{(c(n))^{4}}$. For $\varepsilon>0$ given, we now choose $\alpha=\varepsilon^{100 n}$, so that $m \leq \varepsilon^{5 n}$. But then $\mathcal{L}^{n-1}\left(Z^{c} \cap\right.$ $\left.\mathbb{B}_{\varepsilon}^{n-1}(0)\right)>0$ : Otherwise, $\mathcal{L}^{n-1}\left(Z^{c} \cap \mathbb{B}_{\varepsilon}^{n-1}(0)\right)=0$ that is $\mathcal{L}^{n-1}\left(Z \cap \mathbb{B}_{\varepsilon}^{n-1}(0)\right)=\omega_{n-1} \varepsilon^{n}$ and as a consequence $\varepsilon^{5 n} \geq m=\mathcal{L}^{n-1}(Z) \geq \mathcal{L}^{n-1}\left(Z \cap \mathbb{B}_{\varepsilon}^{n-1}(0)\right)=\omega_{n-1} \varepsilon^{n}$ which is a contradiction.

Using this, with the fact that for almost every $x \in \mathbb{B}_{\varepsilon}^{n-1}(0)$ the curve $v_{x}:\left[-\frac{1}{2}, \frac{1}{2}\right] \rightarrow \mathbb{B}_{1}(0)$ $v_{x}(s):=(s, x)$ is a parametrised Lebesgue line, we see that it is possible to choose an $x \in \mathbb{B}_{\varepsilon}^{n-1}(0)$ such that $\int_{-\frac{1}{2}}^{\frac{1}{2}} \sqrt{g(0)_{11}(s, x)} d s \leq 1+\hat{\alpha}=1+\varepsilon^{\frac{100 n}{8}} \leq 1+\varepsilon$ and so that $v_{x}$ is a parametrised Lebesgue line, as claimed.

## 11. Uniqueness

Lemma 11.1 ( $L^{2}$-Lemma). (cf. Lemma 6.1 in proof of [9]). Let $M$ be $n$-dimensional and $g_{1}, g_{2}$ be two smooth solutions on $M \times[0, T]$ to the h-Ricci-DeTurck flow, and let $\ell:=g_{1}-g_{2}, \tilde{\ell}^{a b}:=\frac{1}{2}\left(g_{1}^{a b}+g_{2}^{a b}\right)$ and $\hat{\ell}^{a b}:=\frac{1}{2}\left(g_{1}^{a b}-g_{2}^{a b}\right)$. Then the quantity $|\ell|_{h}^{2}$ satisfies the evolution equation:

& +\ell * g_{2}^{-1} * g_{2}^{-1} *^{h} \nabla \ell *^{h} \nabla g_{1}+\ell * g_{2}^{-1} * g_{2}^{-1} *^{h} \nabla g_{2} *^{h} \nabla \ell \\

where $T * S$ refers to contractions of the tensors $T$ and $S$ involving $h^{-1}$ and $|Z|_{g, h}^{2}=$ $g^{i j} h^{k s} h^{v r} Z_{i k v} Z_{j s r}$ for a zero-three tensor $Z$.

Proof. The formula was proved in [9] for the case that $h=\delta$ is the standard metric on a euclidean ball $B_{1}(0)$, and hence the curvature $\operatorname{Rm}(h)=0$. We carry out a similar argument to the one given there, explaining why the term arising from the curvature $R m(h)$ in the evolution equation of $|\ell|^{2}$ in this setting can be written as $\ell * \hat{\ell} * g_{1} *$ $\operatorname{Rm}(h)+\ell * \ell *\left(g_{2}\right)^{-1} * R m(h)$.

The formula now follows from this equality, combined with the facts that $\frac{\partial}{\partial t}|\ell|_{h}^{2}=$ $2\left(\ell, \frac{\partial}{\partial t} \ell\right)_{h}$ and $2\left(\ell, \tilde{\ell}^{a b}{ }^{h} \nabla_{a}^{h} \nabla_{b} \ell\right)_{h}=\tilde{\ell}^{a b}{ }^{h} \nabla_{a}{ }^{h} \nabla_{b}|\ell|_{h}^{2}-\left.\left.2\right|^{h} \nabla \ell\right|_{\tilde{\ell}, h} ^{2}$.

Using the previous evolution equation for the difference between two solutions of the $h$-Ricci-DeTurck flow we are now able to show that the solution constructed in Theorem 6.1 is unique among all solutions satisfying $\left(a_{t}\right),\left(b_{t}\right)$ and $\left(c_{t}\right)$ with $\varepsilon$ sufficiently small. The proof below slightly resembles the argument used by Struwe to prove a uniqeuness result for the harmonic map flow in two dimensions, see the argument given in the proof of uniqueness in the proof of Theorem 6.6, Chapter III in [34].

Theorem 11.2. Let $M$ be four dimensional and $g(t), 0 \leq t \leq S$, be a solution of the $h$-Ricci-DeTurck flow with initial condition $g_{0} \in W_{l o c}^{2,2} \cap W_{l o c}^{1, \infty}$ satisfying (a) and (b). Assume additionally that $g(t)$ satisfies the estimates $\left(\mathrm{a}_{t}\right),\left(\mathrm{b}_{t}\right)\left(\mathrm{c}_{t}\right)$ and $\left(\mathrm{d}_{t}\right)$ from Theorem 6.3 for all $0 \leq t \leq S$. Then there exists a time $T_{\max }=T_{\max }(n, a) \in(0, S)$ so that the solution is unique for all $0 \leq t \leq T_{\max }$.

Proof. We let $g_{1}, g_{2}$ be two solutions and as above we let $l=g_{1}-g_{2}$. Next we multiply (11.1) with $\eta^{4}$, where $\eta$ is a cut-off function which is equal to one on $B_{\frac{1}{2}}(x)$ and zero outside of $B_{\frac{3}{4}}(x)$, and integrating by parts, with respect to ${ }^{h} \nabla$, and using Youngs and Hölder inequality, we obtain the estimate

where the term $\left.\left.2 \int_{M} \eta^{4}\right|^{h} \nabla l\right|_{\tilde{\ell}, h} ^{2}$ is the second term, up to a change of sign, appearing on the right hand side of equation (11.1). Using the Sobolev embedding Theorem, see Theorem B.1, and the assumption $\left(b_{t}\right)$ it follows that

& +C \sqrt{\varepsilon} \int_{B_{1}(x)}\left(\left.\left.\right|^{h} \nabla l\right|^{2}+|l|^{2}\right)+C \int_{M} \eta^{4}\left(|l|^{2}+|\hat{l}|^{2}\right) . \tag{11.4}
\end{align*}
$$

We will estimate the first two terms appearing on the right hand side of (11.4). In preparation thereof, we first note that from $\left(b_{t}\right)$ we also have

\left(\int_{M} \eta^{4}\left(\left.\left.\right|^{h} \nabla l\right|^{4}+\left.\left.\right|^{h} \nabla \tilde{l}\right|^{4}\right)\right)^{\frac{1}{2}} \leq C \varepsilon

The first term $\int_{M} \eta^{4}\left(\left.\left.\eta|l|\right|^{h} \nabla \tilde{l}\right|^{h} \nabla l \mid\right)$ on the right hand side of (11.4) we estimate as follows,

& \leq\left.\left.\frac{1}{4} \int_{M} \eta^{4}\right|^{h} \nabla l\right|_{\tilde{\ell}, h} ^{2}+C\left(\int_{M} \eta^{4}|l|^{4}\right)^{\frac{1}{2}}\left(\left.\left.\int_{M} \eta^{4}\right|^{h} \nabla \tilde{l}\right|^{4}\right)^{\frac{1}{2}} \\
& \leq\left.\left.\frac{1}{4} \int_{M} \eta^{4}\right|^{h} \nabla l\right|_{\tilde{\ell}, h} ^{2}+C\left(\left.\left.\int_{B_{1}(x)}\right|^{h} \nabla l\right|^{2}+|l|^{2}\right) C \epsilon
\end{align*}
$$

The second term $\left.\left.\int_{M}\right|^{h} \nabla \eta\left|\eta^{3}\right| \tilde{l}| | l| |^{h} \nabla l \mid\right)$ of (11.4) is estimated as follows

& \leq C\left(\int_{M} \eta^{4}\left(|\tilde{l}|^{4}+|l|^{4}\right)\right)^{\frac{1}{2}}\left(\left.\left.\int_{M} \eta^{4}\right|^{h} \nabla l\right|^{4}\right)^{\frac{1}{4}} \\
& \leq C\left(\int_{B_{1}(x)}|l|^{2}+\left.\left.\right|^{h} \nabla l\right|^{2}\right)(\varepsilon)^{\frac{1}{4}}
\end{align*}
$$

Using (11.5) and (11.6), we can estimate the left hand side of (11.4) by

\partial_{t} \int_{M} \eta^{4}|l|^{2}+\left.\left.\int_{M} \eta^{4}\right|^{h} \nabla l\right|_{\tilde{\ell}, h} ^{2} \leq \quad C\left(\int_{M}|l|^{2}+\left|{ }^{h} \nabla l\right|^{2}\right)(\varepsilon)^{\frac{1}{4}}+C \int_{M} \eta^{4}|l|^{2} \tag{11.7}
\end{equation*}
$$

and hence

$$
\partial_{t} \int_{M} \eta^{4}|l|^{2}+\left.\left.\frac{1}{c a} \int_{M} \eta^{4}\right|^{h} \nabla l\right|^{2} \leq C \int_{B_{1}(x)}|l|^{2}+\left.C \sqrt{\varepsilon} \int_{B_{1}(x)}| |^{h} \nabla l\right|^{2}
$$

After integrating in time we obtain for every $x \in M$
$\int_{B_{\frac{1}{2}}(x)}|l|^{2}(t)+\left.\frac{1}{c a} \int_{0}^{t} \int_{B_{\frac{1}{2}}(x)}| |^{h} \nabla l\right|^{2} d s \leq C \int_{0}^{t} \int_{B_{1}(x)}|l|^{2}(s) d s+\left.\left.C(\varepsilon)^{\frac{1}{4}} \int_{0}^{t} \int_{B_{1}(x)}\right|^{h} \nabla l\right|^{2} d s$.
Next we let $1>\sigma>0$ be arbitrary and we conclude from Corollary 5.7 that

$$

for every $0 \leq t \leq C \sigma$ where $C$ is a constant only depending on $n$ and $a$. In the following we let $T_{\text {max }}$ be the smallest time so that

$$

For any $x \in M$ we can cover the ball $B_{1}(x)$ by finitely many balls $B_{\frac{1}{2}}\left(x_{i}\right), 1 \leq i \leq N=$ $N(h)$ (see Appendix B). We conclude from (11.8) that for $t \leq T_{\max }$

& \leq C N t \sigma+\left.\left.C N \varepsilon^{\frac{1}{4}} \sup _{i} \int_{0}^{t} \int_{B_{1}\left(x_{i}\right)}\right|^{h} \nabla l\right|^{2}
\end{aligned}
$$

and hence

$$
\begin{aligned}
& \sup _{x \in M}\left(\int_{B_{1}(x)}|l|^{2}(t)+\left.\frac{1}{c a} \int_{0}^{t} \int_{B_{1}(x)}| |^{h} \nabla l\right|^{2}\right) \\
& \leq C N t \sigma+C N \varepsilon^{\frac{1}{4}} \sup _{x \in M} \int_{0}^{t} \int_{B_{1}(x)}\left|{ }^{h} \nabla l\right|^{2} \\
& \leq C N t \sigma+\frac{1}{2} \sup _{x \in M}\left(\int_{B_{1}(x)}|l|^{2}(t)+\frac{1}{c a} \int_{0}^{t} \int_{B_{1}(x)}\left|{ }^{h} \nabla l\right|^{2}\right)
\end{aligned}
$$

if $\varepsilon>0$ is sufficiently small. Hence

\sup _{x \in M}\left(\int_{B_{1}(x)}|l|^{2}(t)+\left.\left.\frac{1}{c a} \int_{0}^{t} \int_{B_{1}(x)}\right|^{h} \nabla l\right|^{2}\right) \leq 2 C N t \sigma \leq \frac{\sigma}{2}
$$

for all $0 \leq t \leq \frac{1}{4 C N}$ which implies that $T_{\max } \geq \frac{1}{4 C N}$ and since $\sigma>0$ was arbitrary this finishes the proof of the theorem.

## 12. An application

Here we present an application for $W^{2,2} \cap L^{\infty}$ metrics on four dimensional manifolds in the setting that scalar curvature is weakly bounded from below. For the case that the metric is $C^{0}$ we refer to the paper of [4] for related results.

Definition 12.1. Let $M$ be a four dimensional smooth closed manifold and $g$ be a $W^{2,2} \cap L^{\infty}$ be Riemannian metric (positive definite everywhere), such that $g, g^{-1} \in L^{\infty}$ and let $k \in \mathbb{R}$. Locally the scalar curvature may be written

\begin{aligned}
\mathrm{R}(g) \quad= & g^{j k}\left(\partial_{i} \Gamma(g)_{j k}^{i}-\partial_{j} \Gamma_{i k}^{i}\right. \\
& \left.+\Gamma_{i p}^{i} \Gamma_{j k}^{p}-\Gamma_{j p}^{i} \Gamma_{i k}^{p}\right)
\end{aligned}
$$

where $\Gamma(g)_{i j}^{m}=\frac{1}{2} g^{m k}\left(\partial_{i} g_{j k}+\partial_{j} g_{i k}-\partial_{k} g_{i j}\right)$, and hence $\mathrm{R}(g)$ is well defined in the $L^{2}$ sense for a $W^{2,2}$ Riemannian metric. Let $k \in \mathbb{R}$. We say the scalar curvature $\mathrm{R}(g)$ is
weakly bounded from below by $k, \mathrm{R}(g) \geq k$, if this is true almost everywhere, for all local smooth coordinates.

Theorem 12.2. Let $(M, h)$ be four dimensional closed and satisfy (2.4). Assume that $\left(M, g_{0}\right)$ is a $W^{2,2}$ metric such that $\frac{1}{a} h \leq g_{0} \leq a h$ for some $\infty>a>1$ and $\mathrm{R}\left(g_{0}\right) \geq k$ in the weak sense of Definition 12.1. Then the solution $g(t)_{t \in(0, T)}$ to Ricci DeTurck flow respectively $\ell(t)_{t \in(0, T)}$ to Ricci Flow constructed in Theorem 8.3, with initial value $g(0)=g_{0}$, has $\mathrm{R}(g(t)) \geq k$ and $\mathrm{R}(\ell(t)) \geq k$ for all $t \in(0, T)$.

Proof. The solution $g(t)$ to Ricci DeTurck flow constructed in the main theorem is smooth for all $t>0$ and satisfies $g(t) \rightarrow g_{0}$ in the $W^{2,2}$ sense and $\frac{1}{400 a} h \leq g(t) \leq 400 a h$ for all $t \in(0, T)$. Hence $\mathrm{R}(g(t)) \rightarrow \mathrm{R}\left(g_{0}\right)$ as $t \searrow 0$ in the $L_{l o c}^{2}$ sense, and in the pointwise sense almost everywhere, where $\mathrm{R}\left(g_{0}\right)$ is the $L^{2}$ quantity defined above ( convergence of a sequence of functions in the $L_{l o c}^{2}$ sense to an $L_{l o c}^{2}$ function implies convergence of the sequence almost everywhere ). This means $(\mathrm{R}(g(t))+k)_{-} \rightarrow 0$ in the $L^{2}$ sense as $t \searrow 0$, and hence $\varphi(t):=\int_{M}(\mathrm{R}(g(t))+k)_{-}^{2} d g(t)=\int_{M}(\mathrm{R}(\ell(t))+k)_{-}^{2} d \ell(t) \rightarrow 0$ as $t \searrow 0$.

The Integrand $V(t):=(\mathrm{R}(\ell(t))+k)_{-}^{2}$ is differentiable in space and time for all $t>0$ and this yields that $\varphi$ is differentiable in time for all $t>0$. The derivative of $V$ is zero for all $(x, t) \in M \times(0, T)$ with $\mathrm{R}(\ell)(x, t)+k \geq 0$.

By Sard's theorem (see Section 2 of [26]), we know, for almost all $k$, that the sets $\{x \in M \mid \mathrm{R}(x, g(t))+k<0\}$ have smooth boundary for almost every $t>0$ : Sard applied once to R yields that $W_{k}:=\{(x, t) \in M \times(0, T) \mid \mathrm{R}(x, t)=-k\}$ is smooth for almost all $k \in \mathbb{R}$ and then Sard applied to $\Psi_{k}: W_{k} \rightarrow \mathbb{R}, \Psi_{k}(x, t)=t$ (for such $k$ ) yields that $\{x \in M \mid \mathrm{R}(x, t)=-k\}$ is smooth for almost all $t \in(0, T)$. Let $Z \subseteq \mathbb{R}$ denote the set of such $k \in \mathbb{R}$. For such $k \in Z$ we define $U_{k}(t):=\{x \in M \mid \mathrm{R}(x, g(t))+k<0\}$ if $t \in(0, T)$ is a time such that $\{x \in M \mid \mathrm{R}(x, g(t))+k<0\}$ has smooth boundary, and we define $U_{k}(t):=\emptyset$ for all other $t \in(0, T)$. Using the Fundamental Theorem of Calculus for $0<t_{1}<t_{2}$ we compute

& =e^{-k t_{2}} \varphi\left(t_{2}\right)-e^{-k t_{1}} \varphi\left(t_{1}\right) \\
& =\int_{t_{1}}^{t_{2}} \frac{d}{d \tau} \int_{M} e^{-k \tau} V(\tau) d \ell(\tau) d \tau \\
& =\int_{t_{1}}^{t_{2}} e^{-k \tau} \int_{M}\left(\frac{d}{d \tau} V(\tau)-\mathrm{R}(\tau) V(\tau)-k V(\tau)\right) d \ell(\tau) d \tau \\
& =\int_{t_{1}}^{t_{2}} \int_{U_{k}(\tau)} e^{-k \tau}\left(2 \frac{\partial}{\partial \tau}(-\mathrm{R}(\tau)-k)(-\mathrm{R}(\tau)-k)-(\mathrm{R}(\tau)+k)^{2} \mathrm{R}(\tau)\right) d \ell(\tau) d \tau \\
& -\int_{t_{1}}^{t_{2}} \int_{U_{k}(\tau)} k e^{-k \tau} V(\tau) d \ell(\tau) d \tau \\
& =\int_{t_{1}}^{t_{2}} \int_{U_{k}(\tau)} e^{-k \tau}\left(2 \Delta_{\ell(\tau)}(\mathrm{R}(\tau)+k)\right)(\mathrm{R}(\tau)+k)+4(\mathrm{R}(\tau)+k)|\operatorname{Rc}(\tau)|^{2} \\
& -\int_{t_{1}}^{t_{2}} \int_{U_{k}} e^{-k \tau}(\mathrm{R}(\tau)+k)^{3} d \ell(\tau) d \tau
\end{aligned}
$$

$$
\begin{aligned}
&+k \int_{t_{1}}^{t_{2}} \int_{U_{k}(\tau)} e^{-k \tau}(\mathrm{R}(\tau)+k)^{2}-k \int_{t_{1}}^{t_{2}} \int_{U_{k}(\tau)} e^{-k \tau} V(\tau) d \ell(\tau) d \tau \\
& \leq \int_{t_{1}}^{t_{2}} \int_{U_{k}(\tau)} e^{-k \tau}\left(2 \Delta_{\ell(\tau)}(\mathrm{R}(\tau)+k)\right)(\mathrm{R}(\tau)+k)-\int_{t_{1}}^{t_{2}} \int_{U_{k}(\tau)} e^{-k \tau}(\mathrm{R}(\tau)+k)^{3} d \ell(\tau) d \tau \\
& {\left[\text { since }(\mathrm{R}(\tau)+k)(\tau)<0 \text { on } U_{k}(\tau) \text { and } V=(\mathrm{R}(\tau)+k)^{2}\right] } \\
&= \int_{t_{1}}^{t_{2}} e^{-k \tau} \int_{U_{k}(\tau)}-2 \mid \nabla\left(\left.\mathrm{R}(\ell(\tau)+k)\right|^{2} d \ell(\tau) d \tau\right. \\
&+\int_{t_{1}}^{t_{2}} e^{-k \tau} \int_{\partial U_{k}(\tau)}(\mathrm{R}(\tau)+k) \ell(\tau)(\nu(\ell(\tau)), \nabla(\mathrm{R}(\tau)+k)) d \sigma(\tau) d \tau \\
&+ \int_{t_{1}}^{t_{2}} \int_{U_{k}(\tau)} e^{-k \tau}\left(\left|(\mathrm{R}(\tau)+k)_{-}\right|^{3} d \ell(\tau) d \tau\right. \\
&= \int_{t_{1}}^{t_{2}} \int_{U_{k}(\tau)}-2 e^{-k \tau}\left|\nabla(\mathrm{R}(\tau)+k)_{-}\right|^{2} d \ell(\tau) d \tau \\
&+\left.\left.\int_{t_{1}}^{t_{2}} \int_{U_{k}(\tau)} e^{-k \tau}(\mid(\mathrm{R}(\tau))+k)_{-}\right|^{3}\right) d \ell(\tau) d \tau \\
&= \int_{t_{1}}^{t_{2}}-2 e^{-k \tau} \int_{M}\left|\nabla(\mathrm{R}(\tau)+k)_{-}\right|^{2} d \ell(\tau) d \tau \\
&+ \int_{t_{1}}^{t_{2}} e^{-k \tau} \int_{M}|(\mathrm{R}(\tau)+k)-|^{3} \\
& \leq-A(M, h) \int_{t_{1}}^{t_{2}} e^{-k \tau}\left(\int_{M}\left|(\mathrm{R}(\tau)+k)_{-}\right|^{4} d \ell(\tau)\right)^{\frac{1}{2}} d \tau \\
&\left.+\int_{t_{1}}^{t_{2}} e^{-k \tau}\left(\int_{M}\left|(\mathrm{R}(\tau)+k)_{-}\right|^{4} d \ell(\tau)\right)^{\frac{1}{2}}\left(\int_{M}\left|(\mathrm{R}(\tau)+k)_{-}\right|^{2} d \ell(\tau)\right)^{\frac{1}{2}}\right) d \tau \\
&\left.\leq\left.\int_{t_{1}}^{t_{2}} e^{-k \tau}(-A(M)+A(M) / 2)\left(\int_{M} \mid(\mathrm{R}(\tau))+k\right)_{-}\right|^{4} d \ell(\tau)\right)^{\frac{1}{2}} d \tau \\
& {\left[\text { for sufficiently } \operatorname{small} t_{2}\right] } \\
& \leq 0
\end{aligned}
$$

where we have used the Sobolev inequality and $A(M)$ is the Sobolev constant, and we used that $\int_{M}\left|(\mathrm{R}(\tau)+k)_{-}\right|^{2} d \ell(\tau) \leq A(M) / 2$ for $\tau \leq t_{2}$ and $t_{2}$ sufficiently small, since $\int_{M}\left|(\mathrm{R}(t)+k)_{-}\right|^{2} d \ell(t) \rightarrow 0=\int_{M}\left|(\mathrm{R}(t)+k)_{-}\right|^{2} d g(t) \rightarrow 0$ as $t \searrow 0$. Hence, since $\psi(0)=0$, $\psi(t)=0$ for all $t \in[0, T)$. That is $\mathrm{R}(\ell(t)) \geq k$ for all $t \in(0, T)$ in the smooth sense. $\mathrm{R}(g(t)) \geq k$ for all $t \in(0, T)$ follows from the fact that $(M, \ell(t))$ and $(M, g(t))$ are isometric to one another. For general $k \in \mathbb{R}$ we can take a sequence $\left(k_{i}\right)_{i \in \mathbb{N}}$ with $k_{i} \rightarrow k$ and $k_{i} \in Z$.

Remark 12.3. From this theorem we see that for a metric $g_{0} \in L^{\infty} \cap W^{2,2}\left(M^{4}\right)$ with $\frac{1}{a} h \leq g_{0} \leq a h$ for some positive constant $a>0: g_{0}$ has scalar curvature $\geq k$ in the weak sense of Definition $12.1 \Longleftrightarrow$ there exists a sequence of smooth Riemannian metrics $g_{i, 0}$ with $\frac{1}{b} h \leq g_{i, 0} \leq b h$ for some $1<b<\infty$ and $\mathrm{R}\left(g_{i, 0}\right) \geq k$ and $g_{i, 0} \rightarrow g_{0} \in W^{2,2}\left(M^{4}\right)$ $\Longleftrightarrow$ the Ricci DeTurck flow of $g_{0}$ constructed in Theorem 6.5 has $\mathrm{R}(g(t)) \geq k$ for all $t \in(0, T)$. In particular, we do not need to change the constant form $k$ to $k-\frac{1}{i}$ after the first implication $\Longrightarrow$.

## Appendix A. Short time existence of Smooth bounded data

We present here a standard existence result for Ricci-DeTurck flows with smooth bounded initial data, based on the method of Shi [29].

Theorem A.1. Let $(M, h)$ be $n$-dimensional and satisfy (2.4). We assume there are constants $1<a<\infty$ and $0<c_{j}<\infty$ for all $j \in \mathbb{N}$, and $g_{0}$ is a smooth metric on $M$ satisfying

& \frac{1}{a} h \leq g_{0} \leq a h \\
& \left.\sup _{M}^{h}\right|^{h} \nabla^{j} g_{0} \mid \leq c_{j}<\infty
\end{aligned}
$$

Then there exists a smooth solution $(M, g(t))_{t \in[0, \hat{T}]}$ to (1.1) for some $\hat{T}>0$, and constants $b_{j}\left(g_{0}, h, S\right)<\infty$ for all $S \leq \hat{T}$ such that $\left.\sup _{M}\right|^{h} \nabla^{j} g(\cdot, t) \mid \leq b_{j}\left(g_{0}, h, S\right)<\infty$ for all $t \in[0, S]$.

Proof. We will construct a short time solution to, (1.1), that is

&\left.-2^{h} \nabla_{j} g_{p a}{ }^{h} \nabla_{b} g_{i q}-2^{h} \nabla_{i} g_{p a}{ }^{h} \nabla_{b} g_{j q}\right), \\
&.1) \tag{A.1}
\end{align*}
$$

with $g(0)=g_{0}$. The method is essentially the one given in [29], with some minor modifications.

We choose radii $R(i) \rightarrow \infty$ such that $B_{i}=B_{R(i)}(p)$ have smooth boundary, and $M=$ $\cup_{i=1}^{\infty} B_{i}$. For fixed $R=R(i) \geq 1$ we modify $g_{0}$ to $g_{0, R}=\eta g_{0}+(1-\eta) h$ where $\eta$ is a smooth cut off function with $\eta=0$ outside of $B_{R / 2}(p)$ and $\eta=1$ on $B_{R / 4}(p),\left|{ }^{h} \nabla^{k} \eta\right|^{2} \leq c(k, h)$ (see (iv) of Theorem B. 1 for the existence of $\eta$ ). We still have

for some constants $0<\hat{c}_{j}\left(c_{1}, \ldots, c_{j}, h, n, a\right)<\infty$ which don't depend on $R$. Equation (A.1) is strictly parabolic and $h$ and $g_{0, R}$ are smooth and so we obtain a smooth solution $g_{R}(t)_{t \in[0, T)}$ to the Dirichlet problem associated to (A.1) with $g_{R}(0)=g_{0, R}$ and $\left.g_{R}(t)\right|_{\partial B_{R}(p)}=\left.\left(g_{0, R}\right)\right|_{\partial B_{R}(p)}=\left.h\right|_{\partial B_{R}(p)}$ for a $T=T\left(B_{R}, g_{0, R}, h\right)>0$ using the methods of [29] Section 3 and 4 (which in turn uses Theorem 7.1, Section VII of [19] ). Using the argument of Lemma 3.1 of [29] we see, as long as a smooth solution exists and $\left|g_{R}(t)-g_{0, R}\right|_{h}^{2} \leq \varepsilon\left(g_{0}, a, h\right)$, then

Hence, we may extend the solution smoothly to time $\hat{T}:=\frac{\varepsilon\left(g_{0}, h\right)}{c\left(c_{2}, a, n\right)} \leq$ 1. As long as $\left|g_{R}(t)-g_{0, R}\right|_{h}^{2} \leq \varepsilon\left(g_{0}, a, h\right)$, we also have, using the arguments of Lemma 4.1 and 4.2 in [29] and the fact that $\sup _{M}\left|{ }^{h} \nabla^{j} g_{0, R}\right| \leq \hat{c}_{j}<\infty$ for constants $\hat{c}_{j}$ which do not depend on $R$, interior estimates:

Building the limit of the solutions $g_{R(i)}$ as $i \rightarrow \infty$, after taking a subsequence if necessary, we obtain a smooth solution $g(t)_{t \in[0, \hat{T}]}$ to (A.1) with $g(0)=g_{0}$, in view of the Theorem of Arzelà-Ascoli and the fact that $R(i) \rightarrow \infty$ as $i \rightarrow \infty$, satisfying $\left.\left.\sup _{M \times[0, S]}\right|^{h} \nabla^{m} g\right|^{2} \leq b_{m}$ for all $S \leq \hat{T}$ as required.

then, scaled versions of the statements (i)-(v) hold, as we now explain. If we scale $h$ by a large constant $c(h)$, we obtain a new metric which satisfies B.1, and hence (i)-(v) hold
for this new metric. Scaling back, we obtained scaled versions of the statements (i)-(v). For example, part one of (i) would be replaced by: there exists an $r_{0}>0$ such that

We can always find local geodesic coordinates for any $p_{0} \in M$ on the ball $B_{50}\left(p_{0}\right)$ such that in these coordinates $\frac{99}{100} \delta \leq h \leq \frac{101}{100} \delta$ if $\delta_{0}(n)$ is sufficiently small. This implies that the first two statements hold in these coordinates, and hence on the manifold. The third statement is proved as follows. First we construct a maximal set of disjoint balls $\left(B_{\frac{1}{2}}\left(x_{i}\right)\right)_{i=1}^{\infty}$ for $M$, maximal in the sense that any ball $B_{\frac{1}{2}}(p)$ for an arbitrary $p \in M$ must intersect one of these balls. This construction is carried out as follows: first choose disjoint balls $B_{\frac{1}{2}}\left(x_{1}\right), \ldots, B_{\frac{1}{2}}\left(x_{n(R)}\right)$ with centres in $B_{R}\left(p_{0}\right)$, such that any newly chosen ball $B_{\frac{1}{2}}(y)$ with $y \in B_{R}\left(p_{0}\right)$ intersects one of the balls $B_{\frac{1}{2}}\left(x_{1}\right), \ldots, B_{\frac{1}{2}}\left(x_{n(R)}\right)$. In the next step, choose balls $B_{\frac{1}{2}}\left(x_{n(R)}\right), \ldots, B_{\frac{1}{2}}\left(x_{n(2 R)}\right)$, with centres in $B_{2 R}\left(p_{0}\right)$ such that the collection $B_{\frac{1}{2}}\left(x_{1}\right), \ldots, B_{\frac{1}{2}}\left(x_{n(2 R)}\right)$, is disjoint, and any newly chosen ball $B_{\frac{1}{2}}(y)$ with $y \in B_{2 R}\left(p_{0}\right)$ intersects one of the balls $B_{\frac{1}{2}}\left(x_{1}\right), \ldots, B_{\frac{1}{2}}\left(x_{n(2 R)}\right)$. Continuing in this way, we obtain a collection of disjoint balls $\left(B_{\frac{1}{2}}^{2}\left(x_{i}\right)\right)_{i=1}^{\infty}$ which are maximal.

This then implies that $\left(B_{1}\left(x_{i}\right)\right)_{i=1}^{\infty}$ covers $M$ : if $y \in M$ satisfies $y \notin \cup_{i=1}^{\infty} B_{1}\left(x_{i}\right)$, then $B_{\frac{1}{2}}(y) \cap B_{\frac{1}{2}}\left(x_{i}\right)=\emptyset$ for all $i \in \mathbb{N}$, which contradicts the maximality, and hence $y \in$ $\cup_{i=1}^{\infty} B_{1}\left(x_{i}\right)$. In geodesic coordinates $\varphi: B_{50}\left(x_{i}\right) \rightarrow \mathbb{B}_{50}(0)$, there can be at most $c_{1}(n)$ euclidean balls $\mathbb{B}_{\frac{1}{4}}\left(\tilde{x}_{k(j)}\right)_{j=1}^{c_{1}(n)}, \varphi\left(x_{k(j)}\right)=\tilde{x}_{k(j)}$, which are disjoint, and contained in $\mathbb{B}_{40}(0)$. Hence there are at most $c_{1}(n)$ points, $\left(x_{k(j)}\right)_{j=1}^{c_{1}(n)}$, which are contained in $B_{30}\left(x_{i}\right)$, and this implies (iii).
Statement (iv) is proved with the help of an exhaustion function. For $R>1$ given, let $\eta(x):=\tilde{\eta}\left(\frac{f(x)}{R}\right)$, for a smooth cut off function $\tilde{\eta}: \mathbb{R} \rightarrow[0,1] \subseteq \mathbb{R}$ with $\tilde{\eta}(x)=1$ for $|x| \leq 1$ and $\tilde{\eta}(x)=0$ for $|x| \geq 2$, where $f: M \rightarrow \mathbb{R}^{+}$is a smooth so called exhaustion function, satisfying $\frac{1}{C(n)} d\left(x, x_{0}\right) \leq f(x) \leq \frac{1}{2}\left(d\left(x, x_{0}\right)+1\right),\left|{ }^{h} \nabla f\right| \leq C(n),\left|{ }^{h} \nabla^{2} f\right| \leq C(n)$, the existence of which is, for example, guaranteed by Theorem 3.6 of Shi, [28]. By slightly modifying $f$ on geodesic balls of radius 1 we can also achieve $\left|{ }^{h} \nabla^{k} f\right| \leq C(k, h)$.

Similarly $\left.\left.\right|^{h} \nabla^{k} \eta\right|^{2} \leq c(k, h)$. This finishes (iv).

We now prove (v). In the case that $\int_{M}\left(\left.\left.\right|^{h} \nabla g_{0}\right|^{n}+\left|{ }^{h} \nabla^{2} g_{0}\right|^{\frac{n}{2}}\right)<\infty$, choose $R>0$ so that $\int_{\left(B_{R / 10}\left(x_{0}\right)\right)^{c}}\left(\left.\left.\right|^{h} \nabla g_{0}\right|^{n}+\left.\left.\right|^{h} \nabla^{2} g_{0}\right|^{\frac{n}{2}}\right)<$ $\frac{\varepsilon}{2}$. This implies $\int_{B_{\sigma}(x)}\left(\left.\left.\right|^{h} \nabla g_{0}\right|^{n}+\left.\left.\right|^{h} \nabla^{2} g_{0}\right|^{\frac{n}{2}}\right)<\frac{\varepsilon}{2}$ for all $x \in\left(B_{R / 2}\left(x_{0}\right)\right)^{c}$ for any $0<\sigma<1$. Repeating the argument above, we find a $\sigma>0$ such that $\int_{B_{\sigma}(x)}\left(\left.\left.\right|^{h} \nabla g_{0}\right|^{n}+\left.\left.\right|^{h} \nabla^{2} g_{0}\right|^{\frac{n}{2}}\right)<\frac{\varepsilon}{2}$ for all $x \in\left(B_{R}\left(x_{0}\right)\right)$. Hence, $\int_{B_{\sigma}(x)}\left(\left.\left.\right|^{h} \nabla g_{0}\right|^{n}+\left|{ }^{h} \nabla^{2} g_{0}\right|^{\frac{n}{2}}\right)<\frac{\varepsilon}{2}$ for all $x \in M$, as required.

## Appendix C. Estimates for ordinary differential equations

Lemma C.1. Let $\varepsilon<1$ and $f:[0, T] \rightarrow \mathbb{R}_{0}^{+}, Z:(0,1] \rightarrow \mathbb{R}_{0}^{+}$be smooth, and satisfy

& \leq-\varepsilon t^{-1-\varepsilon} f(t)+t^{-\varepsilon} \frac{\varepsilon}{t} f(t)+t^{-\varepsilon} Z(t) \\
& \leq t^{-\varepsilon} Z(t) \tag{C.1}
\end{align*}

Using that $f$ is smooth and hence $f(t) \leq C t$ for small $t>0$ and some constant $C$, we see $F(t) \leq C t^{-\varepsilon+1} \rightarrow 0$ as $t \searrow 0$. Integrating (C.1) from $t_{0}>0$ to $t$, we see $F(t) \leq F\left(t_{0}\right)+\int_{t_{0}}^{t} \frac{Z(s)}{s^{\varepsilon}} d s \rightarrow \lim _{t_{0} \rightarrow 0} \int_{t_{0}}^{t} \frac{Z(s)}{s^{\varepsilon}} d s$, as $t_{0} \searrow 0$ and hence, from the definition of $F(t)$,

and so $t^{\varepsilon} \lim _{t_{0} \rightarrow 0} \int_{t_{0}}^{t} \frac{Z(s)}{s^{\varepsilon}} d s=t^{\varepsilon} \lim _{t_{0} \rightarrow 0} \int_{t_{0}}^{t} \frac{c}{s^{\varepsilon}} d s=\frac{c}{1-\varepsilon} t$

## Appendix D. Metric norm comparisons

We compare the norms of tensor with respect to different metrics.
Theorem D.1. Let $\ell=\left(\ell_{i j}\right)_{i, j \in\{1, \ldots n\}}, g=\left(g_{i j}\right)_{i, j \in\{1, \ldots n\}}, h=\left(h_{\alpha \beta}\right)_{\alpha, \beta \in\{1, \ldots n\}},\left(u_{\alpha \beta}\right)_{\alpha, \beta \in\{1, \ldots n\}}$ be positive definite symmetric matrices and $(\ell)^{-1}=\left(\ell^{i j}\right)_{i, j \in\{1, \ldots n\}},(g)^{-1}=\left(g^{i j}\right)_{i, j \in\{1, \ldots n\}},(h)^{-1}=$ $\left(h^{\alpha \beta}\right)_{\alpha, \beta \in\{1, \ldots n\}},\left(u^{-1}\right)=\left(u^{\alpha \beta}\right)_{\alpha, \beta \in\{1, \ldots, n\}}$ the inverses thereof. Let $S=\left(S_{\alpha}^{i}\right)_{i, \alpha \in\{1, \ldots n\}}, T=$ $\left(T_{i j}\right)_{i, j \in\{1, \ldots n\}}, N=\left(N^{i j}\right)_{i, j \in\{1, \ldots n\}}$ be matrices in $\mathbb{R}^{n \times n}$.

Then the following estimates hold for any $\varepsilon>0$ :

Proof. We regard $g, \ell$ as positive definite symmetric linear maps from $V \otimes V$ to $\mathbb{R}$ where $V=\mathbb{R}^{n}$ and $h, u$ as positive definite symmetric linear maps from $Y \otimes Y$ to $\mathbb{R}$ for another copy of $Y:=\mathbb{R}^{n} . \quad g, \ell: V \otimes V \rightarrow \mathbb{R}, h, u: Y \otimes Y \rightarrow \mathbb{R}, g\left(v^{i} e_{i}, v^{j} e_{j}\right)=$ $v^{i} v^{j} g_{i j}, \ell\left(w^{i} e_{i}, w^{j} e_{j}\right)=w^{i} w^{j} g_{i j}, h\left(z^{\alpha} e_{\alpha}, z^{\beta} e_{\beta}\right)=z^{\alpha} z^{\beta} h_{\alpha \beta}, u\left(z^{\alpha} e_{\alpha}, z^{\beta} e_{\beta}\right)=z^{\alpha} z^{\beta} u_{\alpha \beta}$, and we regard $S, T$, and $N$ as linear map $S: Y^{*} \times V \rightarrow \mathbb{R}, T: V \times V \rightarrow \mathbb{R}, N: V^{*} \times V^{*} \rightarrow$ $\mathbb{R}, S\left(w_{\alpha} e^{\alpha}, v^{i} e_{i}\right)=S_{i}^{\alpha} w_{\alpha} v^{i}$. From the theory of tensors, $|S|_{h, \ell}^{2},|S|_{u, \ell}^{2},\left|\ell^{-1}\right|_{g}^{2},|T|_{g}^{2}, \frac{\operatorname{det}(g)}{\operatorname{det}(\ell)}$, $\mid N]\left.\right|_{\ell} ^{2},|g|_{\ell}^{2}$ etc. are all quantities which are independent of coordinates: if $\left(\tilde{e}_{i}\right)_{i \in\{1, \ldots n\}}$, $\left(\hat{e}_{\alpha}\right)_{\alpha \in\{1, \ldots n\}}$ are bases, and $\tilde{\ell}_{i j}=\ell\left(\tilde{e}_{i}, \tilde{e}_{j}\right), \tilde{g}_{i j}=g\left(\tilde{e}_{i}, \tilde{e}_{j}\right), \hat{h}_{\alpha \beta}=h\left(\hat{e}_{\alpha}, \hat{e}_{\beta}\right), \hat{u}_{\alpha \beta}=$ $u\left(\hat{e}_{\alpha}, \hat{e}_{\beta}\right)$ with inverses given by $\tilde{\ell}^{i j}, \tilde{g}^{i j}, \hat{h}^{\alpha \beta}, \hat{u}^{\alpha \beta}$ then the quantities defined above as $|S|_{\ell, h}^{2},|S|_{u, \ell}^{2},|T|_{g}^{2}, \frac{\operatorname{det}(g)}{\operatorname{det}(\ell)},\left|\ell^{-1}\right|_{g}^{2}$ calculated using $\tilde{g}_{i j}, \tilde{g}^{i j}, \hat{h}_{\alpha \beta}, \hat{u}_{\alpha \beta}, \hat{h}^{\alpha \beta}, \hat{u}^{\alpha \beta} \tilde{\ell}_{i j}, \tilde{\ell}^{i j}, \tilde{T}_{i j}, \tilde{\hat{S}}_{\alpha}^{i}$
in place of $g_{i j}, g^{i j}, h_{\alpha \beta}, h^{\alpha \beta}, \ell_{i j}, \ell^{i j}, T_{i j}, S_{\alpha}^{i}$ then the result is the same : see for example [14].

We can always choose a basis for $Y$ such that $\hat{h}_{\alpha \beta}=\delta_{\alpha \beta}, \hat{u}_{\alpha \beta}=r_{\alpha} \delta_{\alpha \beta}$ and a basis for $V$ such that $\tilde{g}_{i j}=\lambda_{i} \delta_{i j}, \tilde{\ell}_{i j}=\sigma_{i} \delta_{i j}$. That is without loss of generality, we have $h_{\alpha \beta}=\delta_{\alpha \beta}, u_{\alpha \beta}=r_{\alpha} \delta_{\alpha \beta}$ and $g_{i j}=\lambda_{i} \delta_{i j}, \ell_{i j}=\sigma_{i} \delta_{i j}$.
