# Every complete atomic Boolean algebra is the ideal lattice of a cBCK-algebra

#### Abstract

Given a complete atomic Boolean algebra, we show there is a commutative BCK-algebra whose ideal lattice is that Boolean algebra. This result is shown to exist within a larger framework involving BCK-algebras of functions, whose ideals and prime ideals are analyzed by way of a specific Galois connection. As a corollary of the main theorem, we show that every discrete topological space is the prime spectrum of a cBCK-algebra.

## 1. Introduction

The class of BCK-algebras was introduced in 1966 by Imai and Iséki [7] as the algebraic semantics for a non-classical logic having only implication. While this class of algebras is not a variety [19], many subclasses are; for example, the subclass of commutative BCKalgebras forms a variety.

As with any algebra of logic, the ideal theory plays an important role in their study. The ideals of a commutative BCK-algebra correspond to its congruence relations: for a commutative BCK-algebra $\mathbf{A}$, there is a lattice isomorphism $\operatorname{Con}(\mathbf{A}) \cong \operatorname{Id}(\mathbf{A})$, where $\operatorname{Con}(\mathbf{A})$ is the lattice of congruences on $\mathbf{A}$ and $\operatorname{Id}(\mathbf{A})$ is the lattice of ideals of A 21. Because of this, all results regarding ideals of commutative BCK-algebras could equivalently be stated about congruences; we will use the language of ideals.

For any BCK-algebra $\mathbf{A}$, commutative or not, the lattice $\operatorname{Id}(\mathbf{A})$ is distributive [13]. In [4], the author proved that each of the following five types of distributive lattice is the ideal lattice of a commutative BCK-algebra:
(1) any finite chain,
(2) any countably infinite chain isomorphic to $\mathbb{Z}_{\leq 0} \cup\{-\infty\}$,
(3) any finite subdirectly irreducible distributive $p$-algebra,
(4) any finite Boolean algebra,
(5) any distributive lattice $\mathbf{D}$ whose poset of meet-irreducibles is poset-isomorphic to the order dual $T^{\partial}$ of some finite rooted tree $T$.

Additionally, any finite product of lattices where each factor lies in one of the above classes is the ideal lattice of a commutative BCK-algebra. For example, every divisor lattice is the ideal lattice of a commutative BCK-algebra since it is a finite product of finite chains. We note also that $\operatorname{Id}(\mathbf{A})$ is Boolean for any finite cBCKalgebra $\mathbf{A}[14$.

Here we extend (4) above by showing that every complete atomic Boolean algebra is the ideal lattice of a commutative BCK-algebra. We present two proofs of this fact. The first proof is presented in Section 2\% it is straightforward but perhaps ad hoc, so we situate this result within a broader context in Section 3. We define an infinite family of algebras we believe to be of interest in its own right, and which contains the algebra used in the first proof. Some time is spent analyzing the ideals of these algebras, and from this analysis a second proof of the main theorem is derived. In the final section, we present an application of the main theorem: any discrete topological space is the spectrum of a commutative BCK-algebra.

Definition 1.1. A commutative BCK-algebra (cBCK-algebra) is an algebra $\mathbf{A}=\langle A ; \cdot, 0\rangle$ of type $(2,0)$ such that
(BCK1) $(x \cdot y) \cdot z=(x \cdot z) \cdot y$
(BCK2) $x \cdot(x \cdot y)=y \cdot(y \cdot x)$
(BCK3) $x \cdot x=0$
(BCK4) $x \cdot 0=x$
for all $x, y, z \in A$.
On any cBCK-algebra A we define a partial order by: $x \leq y$ if and only if $x \cdot y=0$. It can be shown that $0 \cdot x=0$ for all $x \in A$, so 0 is the smallest element of $\mathbf{A}$ with respect to $\leq$. The term operation $x \wedge y:=y \cdot(y \cdot x)$ is the greatest lower bound of $x$ and $y$, and $\mathbf{A}$ is a semilattice with respect to $\wedge$. In particular, from (BCK2) we have
$x \wedge y=y \wedge x$, and these algebras are called commutative for this reason. We also have $x \cdot y \leq x$ with equality if and only if $x \wedge y=0$.

For proofs of these, as well as other elementary properties of cBCK-algebras, we point the reader to [8-10 14] 17,18|21. All cBCKalgebras are assumed to be non-trivial.

Definition 1.2. An ideal of a BCK-algebra $\mathbf{A}$ is a subset $I \subseteq A$ such that
(1) $0 \in I$
(2) $x \cdot y \in I$ and $y \in I$ implies $x \in I$.

From this we see that ideals are non-empty downsets. BCKideals need not be semilattice-ideals: for example, $\mathbf{A}$ itself always satisfies the above definition, but need not be directed upward. More generally, when the underlying poset of $\mathbf{A}$ is a lattice, every BCKideal is a lattice-ideal, but the converse is not true: consider the threeelement chain $\mathbf{3}=\{0<1<2\}$ with operation $x \cdot y=\max \{x-y, 0\}$. Then $I=\{0,1\}$ is a lattice-ideal since it is a downset and closed under join, but it is not a BCK-ideal since $2 \cdot 1=1 \in I$ but $2 \notin I$.

Denote the set of ideals of $\mathbf{A}$ by $\operatorname{Id}(\mathbf{A})$. This set is a complete lattice with respect to $\cap$, and is known to be distributive [13]. As mentioned earlier, there is a lattice-isomorphism $\operatorname{Id}(\mathbf{A}) \cong \operatorname{Con}(\mathbf{A})$, where $\operatorname{Con}(\mathbf{A})$ is the lattice of congruence relations on $\mathbf{A}$; see 1 ] or [21] for a proof. Of course $\{0\}$ and $\mathbf{A}$ are always ideals, and we will say $\mathbf{A}$ is simple if these are the only ideals.

For $S \subseteq A$, the smallest ideal of $\mathbf{A}$ containing $S$ is the ideal generated by $S$, which we denote by $(S]$. The join operation in $\operatorname{Id}(\mathbf{A})$ is given by $I \vee J=(I \cup J]$.

If $S=\{a\}$, we will write (a] rather than (\{a\}]. In [8], Iséki and Tanaka showed that $x \in(S]$ if and only if there exist $s_{1}, \ldots, s_{n} \in S$ such that

$$
\begin{equation*}
\left(\cdots\left(\left(x \cdot s_{1}\right) \cdot s_{2}\right) \cdots \cdot s_{n-1}\right) \cdot s_{n}=0 . \tag{*}
\end{equation*}
$$

This characterization is true in any BCK-algebra, commutative or not.

For $n \in \mathbb{N}_{0}$, define the notation $x \cdot y^{n}$ recurvisely as

$$
\begin{aligned}
& x \cdot y^{0}=x \\
& x \cdot y^{n}=\left(x \cdot y^{n-1}\right) \cdot y
\end{aligned}
$$

This gives a decreasing sequence

$$
x \cdot y^{0} \geq x \cdot y^{1} \geq x \cdot y^{2} \geq \cdots \geq x \cdot y^{n} \geq \cdots
$$

With this notation, we can describe principal ideals by

$$
\begin{equation*}
(a]=\left\{x \in \mathbf{A} \mid x \cdot a^{n}=0 \text { for some } n \in \mathbb{N}\right\} . \tag{**}
\end{equation*}
$$

If the underlying poset of a cBCK-algebra is totally ordered, we will call it a cBCK-chain. The following statement appears as a proposition in (15]:

A cBCK-chain $\mathbf{A}$ is simple if and only if, for any $x, y \in \mathbf{A}$ with $y \neq 0$, there exists $n \in \mathbb{N}$ such that $x \cdot y^{n}=0$
but it is stated without proof. The present author gave a proof in (4), but that proof does not appear to use the fact that $\mathbf{A}$ is commutative or a chain. We provide the proof here:

Proposition 1.3. A BCK-algebra $\mathbf{A}$ is simple if and only if, for any $x, y \in \mathbf{A}$ with $y \neq 0$, there is a natural number $n$ such that $x \cdot y^{n}=0$.

Proof. Assume first that $\mathbf{A}$ is simple, and take $x, y \in \mathbf{A}$ with $y \neq 0$. Consider the ideal $(y]$. By simplicity we must have $(y]=\mathbf{A}$ since $y \neq 0$. But this means $x \in(y]$, in which case ( ${ }^{* *)}$ indicates there exists $n \in \mathbb{N}$ such that $x \cdot y^{n}=0$.

On the other hand, assume for any pair $x, y \in \mathbf{A}$ with $y \neq 0$ that there exists $n \in \mathbb{N}$ such that $x \cdot y^{n}=0$. Let $I$ be a non-zero ideal of $\mathbf{A}$. Take $z \in \mathbf{A}$ and $y \neq 0$ in $I$. By hypothesis there is some $k \in \mathbb{N}$ such that $z \cdot y^{k}=0 \in I$. Since $y \in I$, we apply the ideal property inductively to obtain $z \in I$. Hence, $I=\mathbf{A}$, which implies A is simple.

For example, the set of non-negative reals $\mathbb{R}^{+}$is a simple cBCKchain under the operation $x \cdot y=\max \{x-y, 0\}$. More generally, the positive cone of any Archimedean group can be viewed as a cBCK-algebra, and with this structure it is a simple cBCK-chain. The algebra $\mathbb{R}^{+}$has many important subalgebras - the unit interval $[0,1]$, the finite chains $\mathbf{n}=\{0<1<\cdots<n\}$, the natural numbers $\mathbb{N}_{0}$ - all of which are simple. For readers familiar with the language of universal algebra: the variety of cBCK-algebras is generated by the finite chains. That is, $\mathrm{cBCK}=\operatorname{HSP}(\mathbf{2}, \mathbf{3}, \ldots)$. However, not all BCK-chains are simple; see Example 4.5 below.

On the other hand, there are many simple BCK-algebras that are not chains. For example, the algebra $\mathbf{Y}$ defined by Table 1 is simple, but not a chain. Figure 1 shows the Hasse diagram.

## 2. The Main Theorem

Theorem 2.1. Every complete atomic Boolean algebra is the ideal lattice of a commutative BCK-algebra.

Proof. Let $\mathbf{C}$ be a complete atomic Boolean algebra. Then $\mathbf{C}$ is isomorphic to $\mathcal{P}(X)$, the power set of $X$, for some set $X$. With respect to set difference, $\mathcal{P}(X)$ is a cBCK-algebra with $\varnothing$ as the zero element. Put $\mathbf{A}=\mathcal{P}_{\text {fin }}(X)$, the set of finite subsets of $X$, and note that $\mathbf{A}$ is a subalgebra of $\mathcal{P}(X)$.

The underlying poset of $\mathbf{A}$ is a lattice, so each BCK-ideal of $\mathbf{A}$ is a lattice-ideal. In this case, every lattice-ideal is also a BCK-ideal; to see this, let $I$ be a lattice-ideal of $\mathbf{A}$. Certainly $\varnothing \in I$. Now suppose $B \backslash C \in I$ and $C \in I$ for some $B, C \in \mathbf{A}$. Since $I$ is a lattice-ideal, we have $(B \backslash C) \cup C=B \in I$, which tells us $I$ is a BCK-ideal. So BCK-ideals and lattice-ideals coincide in $\mathbf{A}$. We use this fact in the remainder of the proof.

Define a map $\varphi: \mathcal{P}(X) \rightarrow \operatorname{Id}(\mathbf{A})$ by

$$
\varphi(S)=I_{S}:=(\{s\} \mid s \in S] .
$$

That is, $\varphi(S)$ is the ideal of $\mathbf{A}$ generated by the singleton subsets of $S$. We claim this is an isomorphism of Boolean algebras.

First we show $\varphi$ is surjective. Take $I \in \operatorname{Id}(\mathbf{A})$. Putting $S=$ $\bigcup_{B \in I} B$, we have $I=I_{S}$; this follows since every element $B \in I$ is a finite union of elements of $S$.

Suppose $S \neq T$ for subsets $S, T \subseteq X$. Without loss of generality, there is some $s \in S$ with $s \notin T$. Then $\{s\} \in I_{S}$ but $\{s\} \notin I_{T}$, so $I_{S} \neq I_{T}$. So $\varphi$ is injective and thus bijective.

Next we show $\varphi$ is a lattice homomorphism. Take $S, T \subseteq X$. Any element $B \in I_{S \cap T}$ is a finite union of elements from $S \cap T$, but this implies $B \in I_{S}$ and $B \in I_{T}$, so $B \in I_{S} \cap I_{T}$ giving $I_{S \cap T} \subseteq I_{S} \cap I_{T}$. The reverse inclusion is analogous, so $I_{S \cap T}=I_{S} \cap I_{T}$ and $\varphi$ preserves meets.

Take $B \in I_{S \cup T}$. Then we can write $B$ as a finite union of elements of $S \cup T$, which can be rearranged to get $B=C \cup D$ where $C$ is a finite subset of $S$ and $D$ is a finite subset of $T$. This implies
$B \in I_{S} \vee I_{T}$, so $I_{S \cup T} \subseteq I_{S} \vee I_{T}$. The reverse inclusion is analogous, so $I_{S \cup T}=I_{S} \vee I_{T}$. Thus, $\varphi$ preserves joins.

Given $I_{S}$, observe that

$$
I_{S} \cap I_{S^{c}}=I_{S \cap S^{c}}=I_{\varnothing}=\{\varnothing\}
$$

and

$$
I_{S} \vee I_{S^{c}}=I_{S \cup S^{c}}=I_{X}=\mathbf{A}
$$

meaning that $I_{S^{c}}$ is the complement of $I_{S}$ in $\operatorname{Id}(\mathbf{A})$. So $\varphi$ preserves complements, meaning $\varphi$ is an isomorphism of Boolean algebras, as claimed.

Finally, the theorem follows since we have $\mathbf{C} \cong \mathcal{P}(X) \cong \operatorname{Id}(\mathbf{A})$.

## 3. BCK-algebras of functions

In this section we show how the above theorem is a special case of a more general result. Let $X$ be any set and $\mathbf{A}$ a cBCK-algebra. Put

$$
\mathcal{F}(X, \mathbf{A})=\{f: X \rightarrow \mathbf{A}\}
$$

the set of all functions from $X$ to $\mathbf{A}$. When $X$ and $\mathbf{A}$ are understood, we will write $\mathcal{F}$ instead of $\mathcal{F}(X, \mathbf{A})$. The set $\mathcal{F}$ becomes a cBCKalgebra with pointwise operation $(f \cdot g)(x)=f(x) \cdot \mathbf{A} g(x)$, where the zero element is the zero function $\mathbf{0}$. This algebra is a generalization of Example 1 from [9, and a version also appears as Example 7 of the author's PhD thesis [3]. We will use $\leq$ to denote the order on both $\mathcal{F}$ and $\mathbf{A}$, and it will always be clear from context. We note that the semilattice operation $\wedge$ on $\mathcal{F}$ is also given pointwise; that is, $(f \wedge g)(x)=f(x) \wedge_{\mathbf{A}} g(x)$.

For $f \in \mathcal{F}$, define the support of $f$ to be

$$
\operatorname{supp}(f)=\{x \in X \mid f(x) \neq 0\}=\{x \in X \mid f(x)>0\}
$$

We say that $f$ has finite support if the support of $f$ is a finite set. Let $\mathcal{F S}(X, \mathbf{A})$ be the set of functions $f: X \rightarrow \mathbf{A}$ with finite support; when $X$ and $\mathbf{A}$ are understood we will write $\mathcal{F S}$.

Lemma 3.1. $\mathcal{F S}$ is an ideal of $\mathcal{F}$, and hence a subalgebra of $\mathcal{F}$.
Proof. Clearly $\mathbf{0} \in \mathcal{F}$. Now suppose $f \notin \mathcal{F S}$ and $g \in \mathcal{F S}$. Given $x \in \operatorname{supp}(f) \backslash \operatorname{supp}(g)$, we have

$$
(f \cdot g)(x)=f(x) \cdot \mathbf{A} g(x)=f(x) \cdot \mathbf{A} 0=f(x)>0
$$

which implies that $\operatorname{supp}(f \cdot g)$ is infinite. Thus, $f \cdot g \notin \mathcal{F S}$, and we have that $\mathcal{F S}$ is an ideal of $\mathcal{F}$.

Ideals are always subalgebras, so the result follows.

Consider the relation $R \subseteq \mathcal{F} \times X$ defined by

$$
R=\{(f, x) \in \mathcal{F} \times X \mid f(x)=0\} .
$$

This relation induces a Galois connection:

- for $\mathcal{G} \subseteq \mathcal{F}$, put

$$
\begin{aligned}
P(\mathcal{G}) & =\{x \in X \mid g(x)=0 \text { for all } g \in \mathcal{G}\} \\
& =\bigcap_{g \in \mathcal{G}}(X \backslash \operatorname{supp}(g))
\end{aligned}
$$

- for $S \subseteq X$, put

$$
\begin{aligned}
V(S) & =\{f \in \mathcal{F} \mid f(s)=0 \text { for all } s \in S\} \\
& =\{f \in \mathcal{F} \mid S=X \backslash \operatorname{supp}(f)\} .
\end{aligned}
$$

For a singleton $\{x\} \subseteq X$, we will write $V(x)$ for $V(\{x\})$. We note this is an antitone Galois connection: if $S \subseteq T \subseteq X$, then certainly $V(T) \subseteq V(S)$ since any function vanishing on $T$ must also vanish on $S$. Similarly, $P(-)$ is order-reversing.

Lemma 3.2. The set $V(S)$ is an ideal of $\mathcal{F}$ for any $S \subseteq X$.
Proof. That $\mathbf{0} \in V(S)$ is clear. Suppose $f \cdot g \in V(S)$ and $g \in V(S)$. If we had $f(s)>0$ for some $s \in S$, then $(f \cdot g)(s)>0$ since $g(s)=0$, but this contradicts the fact that $f \cdot g \in V(S)$. So we must have $f(s)=0$ for all $s \in S$, and thus $f \in V(S)$. Hence, $V(S)$ is an ideal of $\mathcal{F}$.

Lemma 3.3. The map $V: \mathcal{P}(X) \rightarrow \operatorname{Id}(\mathcal{F})$ is injective.
Proof. Let $S, T \subseteq X$ with $S \neq T$. Without loss of generality, there is some $s \in S \backslash T$. Pick some non-zero $a \in \mathbf{A}$, and define $f: X \rightarrow \mathbf{A}$ by $f(x)=0$ for all $x \in X \backslash\{s\}$ and $f(s)=a$. Then $f \in V(Z)$ but $f \notin V(Y)$, and hence $V(Y) \neq V(Z)$.

However, $V$ need not be surjective. For example, consider

$$
\mathcal{F}(\mathbb{N}, \mathbf{2})=\mathbf{2}^{\mathbb{N}} \cong \mathcal{P}(\mathbb{N})
$$

Notice that $\mathcal{F S}(\mathbb{N}, \mathbf{2}) \cong \mathcal{P}_{\text {fin }}(\mathbb{N})$ contains the characteristic function $\chi_{\{n\}}$ for each $n \in \mathbb{N}$, and so $\mathcal{F} \mathcal{S} \neq V(S)$ for any $S \subseteq \mathbb{N}$.

On the other hand, if $X$ is a finite set, say $|X|=n$, then $\mathcal{F}(X, \mathbf{A})=\mathcal{F S}(X, \mathbf{A}) \cong \mathbf{A}^{n}$, and it is known that every ideal of $\mathbf{A}^{n}$ is a product of ideals of $\mathbf{A}$ (see Lemma 2.1.1 of [3]). Thus, if $\mathbf{A}$ is simple, then every ideal $I$ of $\mathbf{A}^{n}$ is of the form $I=\prod_{i=1}^{n} E_{i}$ where each factor $E_{i}$ is either $\{0\}$ or $\mathbf{A}$, meaning every ideal of $\mathcal{F}(X, \mathbf{A})=\mathcal{F} \mathcal{S}(X, \mathbf{A})$ is of the form $V(S)$ for some $S \subseteq X$. And in fact, we observe that $I=V P(I)$ for any ideal $I$ of $\mathcal{F}$. That is, ideals are the closed sets
of the Galois connection $(V, P)$ in this case. This can be extended to infinite $X$, provided we restrict to the subalgebra $\mathcal{F S}(X, \mathbf{A})$.

Theorem 3.4. Let $X$ be any set and $\mathbf{A}$ a simple cBCK-algebra. A subset $I \subseteq \mathcal{F S}(X, \mathbf{A})$ is an ideal if and only if $I=V P(I)$. In particular, every ideal of $\mathcal{F S}$ has the form $V(S)$ for some $S \subseteq X$.

Proof. First, note that the proof of Lemma 3.2 is also true for $\mathcal{F} \mathcal{S}$. Thus, if $I=V P(I)$, we see that $I$ is an ideal.

On the other hand, suppose $I$ is an ideal of $\mathcal{F S}$. Since $V$ and $P$ are a Galois connection, we have $I \subseteq V P(I)$. For the other inclusion, take $f \in V P(I)$ with $f \neq \mathbf{0}$. We know that $\operatorname{supp}(f)$ is finite, so enumerate the elements $\operatorname{supp}(f)=\left\{x_{1}, x_{2}, \ldots, x_{k}\right\}$. For each $x_{i} \in$ $\operatorname{supp}(f)$, the fact that $f\left(x_{i}\right) \neq 0$ tells us $x_{i} \notin P V P(I)=P(I)$. Hence, for each $i=1, \ldots, k$, there is an element $g_{i} \in I$ such that $g_{i}\left(x_{i}\right) \neq 0$.

Since A is a simple, Proposition 1.3 tells us that for each $i$ there is $n_{i} \in \mathbb{N}$ such that

$$
\left(f \cdot g_{i}^{n_{i}}\right)\left(x_{i}\right)=f\left(x_{i}\right) \cdot \mathbf{A}\left(g_{i}\left(x_{i}\right)\right)^{n_{i}}=0
$$

Define $h:=\left(\cdots\left(\left(f \cdot g_{1}^{n_{1}}\right) \cdot g_{2}^{n_{2}}\right) \cdots \cdot g_{k-1}^{n_{k-1}}\right) \cdot g_{k}^{n_{k}}$. We claim that $h=\mathbf{0}$.

First, it may the be case that $g_{i}\left(x_{j}\right) \neq 0$ for $i \neq j$. By (BCK1) the order in which the $g_{i}$ 's are applied does not matter, so we have

$$
\left(\left(f \cdot g_{i}^{n_{i}}\right) \cdot g_{j}^{n_{j}}\right)\left(x_{j}\right)=\left(\left(f \cdot g_{j}^{n_{j}}\right) \cdot g_{i}^{n_{i}}\right)\left(x_{j}\right) \leq\left(f \cdot g_{j}^{n_{j}}\right)\left(x_{j}\right)=0,
$$

which implies that $h\left(x_{j}\right)=0$ for all $x_{j} \in \operatorname{supp}(f)$.
Next, for any $z \in X \backslash \operatorname{supp}(f)$ we have $f(z)=0$ which implies $h(z)=0$; so $h$ vanishes on $X \backslash \operatorname{supp}(f)$ as well.

Taking these observations together, we have

$$
h=\left(\cdots\left(\left(f \cdot g_{1}^{n_{1}}\right) \cdot g_{2}^{n_{2}}\right) \cdots \cdot g_{k-1}^{n_{k-1}}\right) \cdot g_{k}^{n_{k}}=\mathbf{0} \in I .
$$

Since each $g_{i} \in I$, we inductively apply the ideal property to see $f \in I$. Thus, $V P(I) \subseteq I$ and we have $I=V P(I)$ as claimed.

And as the following corollary shows, we can only characterize ideals in this way when $\mathbf{A}$ is simple:

Corollary 3.5. The ideals of $\mathcal{F S}(X, \mathbf{A})$ coincide with closed sets of the Galois connection $(V, P)$ if and only if $\mathbf{A}$ is simple.

Proof. If A is simple, we apply Theorem 3.4
We prove the converse by contrapositive. Suppose $\mathbf{A}$ is not simple. Let $J$ be a non-zero proper ideal of $\mathbf{A}$ and consider

$$
I=\{f \in \mathcal{F S} \mid f(x) \in J \text { for all } x \in X\}
$$

We first show that $I$ is an ideal of $\mathcal{F S}$.
Clearly $\mathbf{0} \in I$, so suppose $f \cdot g \in I$ and $g \in I$. Take $x \in X$. Then $(f \cdot g)(x)=f(x) \cdot \mathbf{A} g(x) \in J$ and $g(x) \in J$. Since $J$ is an ideal of $\mathbf{A}$ this implies that $f(x) \in J$, and since $x$ was arbitrary we have $f \in I$. So $I \leq \mathcal{F} \mathcal{S}$.

Now fix $y \in J$ with $y \neq 0$. For each $x \in X$, define the function $f_{x}$ by $f_{x}(z)=\left\{\begin{array}{ll}y & \text { if } z=x \\ 0 & \text { otherwise }\end{array}\right\}$. Clearly $f_{x} \in I$ for all $x \in X$, and so $P(I)=\varnothing$. Hence $I \subsetneq V P(I)=\mathcal{F} \mathcal{S}$. So $I$ is not a closed set.

Example 3.6. As a small example of this, consider the algebra $\mathbf{V}$ defined by Table 2 This algebra has two non-zero proper ideals,

$J=\{0,1\}$ and $K=\{0,2\}$, which means that

$$
I=J \times \mathbf{V}=\{(0,0),(0,1),(0,2),(1,0),(1,1),(1,2)\}
$$

is an ideal of $\mathbf{V}^{2} \cong \mathcal{F S}(\{1,2\}, \mathbf{V})$. Concretely we see that $P(I)=\varnothing$ and $I \subsetneq \mathbf{V}^{2}=V P(I)$.

The above corollary also implies the following:
Corollary 3.7. The map $V: \mathcal{P}(X) \rightarrow \operatorname{Id}(\mathcal{F S})$ is bijective if and only if $\mathbf{A}$ is simple.

Proof. This follows from Lemma 3.3 and Corollary 3.5.
Lemma 3.8. For any $c B C K$-algebra $\mathbf{A}$, the map $V$ is a lattice antihomomorphism. That is, for $Y, Z \subseteq X$ we have

$$
\begin{aligned}
& V(Y) \cap V(Z)=V(Y \cup Z) \text { and } \\
& V(Y) \vee V(Z)=V(Y \cap Z)
\end{aligned}
$$

Proof. We begin with the first equality. Since $Y, Z \subseteq Y \cup Z$ we have $V(Y \cup Z) \subseteq V(Y), V(Z)$ since $V$ is order-reversing, and hence $V(Y \cup Z) \subseteq V(Y) \cap V(Z)$. For the other inclusion, simply note that any function vanishing on both $Y$ and $Z$ necessarily vanishes on $Y \cup Z$.

For the second equality, begin by noting that $Y \cap Z \subseteq Y, Z$, and so $V(Y), V(Z) \subseteq V(Y \cap Z)$. This implies $V(Y) \vee V(Z) \subseteq$ $V(Y \cap Z)$. For the opposite inclusion, take $f \in V(Y \cap Z)$ and let $\operatorname{supp}(f)=\left\{x_{1}, x_{2}, \ldots, x_{k}\right\} \subseteq Y^{c} \cup Z^{c}$. Set $a_{i}:=f\left(x_{i}\right)$ for each $i$, and define $g_{i}: X \rightarrow \mathbf{A}$ by $g_{i}\left(x_{i}\right)=a_{i}$ and 0 otherwise. Observe that $\left\{g_{1}, g_{2}, \ldots, g_{k}\right\} \subseteq V(Y) \cup V(Z)$. Then

$$
\left(\cdots\left(\left(f \cdot g_{1}\right) \cdot g_{2}\right) \cdots \cdot g_{k-1}\right) \cdot g_{k}=\mathbf{0}
$$

and since each $g_{i} \in V(Y) \cup V(Z)$ we have $f \in(V(Y) \cup V(Z)]=$ $V(Y) \vee V(Z)$ by (困). Thus, $V(Y \cap Z) \subseteq V(Y) \vee V(Z)$ and the equality follows.

Theorem 3.9. The map $V: \mathcal{P}(X) \rightarrow \operatorname{Id}(\mathcal{F S})$ is an (anti-)isomorphism of Boolean algebras if and only if $\mathbf{A}$ is simple.

Proof. Assume A is simple. We know $\operatorname{Id}(\mathcal{F} \mathcal{S})$ is a bounded distributive lattice (whether $\mathbf{A}$ is simple or not). Let $I$ be an ideal of $\mathcal{F S}$. Since A is simple, Theorem 3.4 gives us $I=V(S)$ for some $S \subseteq X$. Then the complement of $I$ in $\operatorname{Id}(\mathcal{F S})$ is the obvious natural candidate $V\left(S^{c}\right)$, which follows from Lemma 3.8

$$
\begin{aligned}
& V(S) \cap V\left(S^{c}\right)=V\left(S \cup S^{c}\right)=V(X)=\{0\} \\
& V(S) \vee V\left(S^{c}\right)=V\left(S \cap S^{c}\right)=V(\varnothing)=\mathcal{F S} .
\end{aligned}
$$

Thus, $\operatorname{Id}(\mathcal{F S})$ is a Boolean algebra.
By Lemma 3.7, since $\mathbf{A}$ is simple we know that $V$ is bijective, and the preceding paragraph shows that $V$ sends complements in $\mathcal{P}(X)$ to complements in $\operatorname{Id}(\mathcal{F S})$. Lemma 3.8 shows that $V$ sends meets to joins and vice versa. So $V$ is an Boolean anti-isomorphism, but Boolean algebras are self-dual. Hence, $\operatorname{Id}(\mathcal{F} \mathcal{S}) \cong \mathcal{P}(X)$.

Conversely, if $\mathbf{A}$ is not simple then $V$ is not a surjective and hence not an isomorphism.

This now gives us another proof of Theorem 2.1] letting $\mathbf{C}$ be a complete atomic Boolean algebra, we have $\mathbf{C} \cong \mathcal{P}(X)$ for some set $X$. The cBCK-algebra $\mathbf{2}$ is simple and so $\operatorname{Id}(\mathcal{F S}(X, \mathbf{2})) \cong \mathcal{P}(X)$, which gives the result.

This is, of course, the same proof in a different disguise, but we now see that every $\mathbf{C}$ occurs as the ideal lattice of infinitely many non-isomorphic cBCK-algebras. Further, from Lemma 3.3 and Lemma [3.8, we see that the Boolean algebra $\mathcal{P}(X)$ is embedded in the lattice $\operatorname{Id}(\mathcal{F}(X, \mathbf{A}))$. We believe these algebras $\mathcal{F}(X, \mathbf{A})$ - and their ideal lattices - to be an interesting topic for future study.

## 4. A small application

In the final section, we present a small application of this theorem by showing that any discrete topological space is the prime spectrum of a cBCK-algebra. We first remind the reader of some definitions.

Definition 4.1. Let $\mathbf{L}$ be a meet-semilattice. An element $m \in \mathbf{L}$ is meet-irreducible if $x \wedge y=m$ implies either $x=m$ or $y=m$.

Definition 4.2. A proper ideal $J$ of a cBCK-algebra is prime if $x \wedge y \in$ $J$ implies $x \in J$ or $y \in J$.

Proposition 4.3. Let A be simple. An ideal $J$ of $\mathcal{F S}(X, \mathbf{A})$ is prime if and only if $J=V(x)$ for some $x \in X$.

Proof. We first show any ideal of the form $V(x)$ is prime. Suppose $f \wedge g \in V(x)$. Then $(f \wedge g)(x)=f(x) \wedge_{\mathbf{A}} g(x)=0$. Since $\mathbf{A}$ is simple, the element 0 is meet-irreducible (see Corollary 5.3 of [14]), so either $f(x)=0$ or $g(x)=0$. Thus, either $f \in V(x)$ or $g \in V(x)$, and we see $V(x)$ is a prime ideal.

Conversely, suppose $J$ is a prime ideal. Since $J$ is an ideal, we know from Theorem [3.4 that $J=V(S)$ for some subset $S \subseteq X$. If $S=\varnothing$ then $V(S)=\mathcal{F S}$, a contradiction since prime ideals are proper. If $|S| \geq 2$, take $x, y \in S$ with $x \neq y$. Let $f, g \in \mathcal{F S}$ be such that $f(x) \neq 0$ but $f(s)=0$ for all $s \in S \backslash\{x\}$, while $g(y) \neq 0$ but $g(s)=0$ for all $s \in S \backslash\{y\}$. Then $(f \wedge g)(s)=0$ for all $s \in S$, so $f \wedge g \in V(S)$. Yet $f, g \notin V(S)$, meaning $J=V(S)$ is not prime, a contradiction. Hence, we must have $|S|=1$, meaning $J$ is of the form $V(x)$ for some $x \in X$.

Remark 4.4. We note that in Corollary 5.3 of [14], used in the above proof, $\mathbf{A}$ is only assumed to be subdirectly irreducible, which is enough to guarantee that 0 is meet-irreducible. And we see in the proof above that if 0 is meet-irreducible, ideals of the form $V(x)$ are prime.

On the other hand, if 0 is not meet-irreducible, then ideals of the form $V(x)$ may not be prime. Consider again the algebra $\mathbf{V}^{2}$ from Example 3.6. The ideal $V(1)=\{0\} \times \mathbf{V}$ is not prime since $(1,0) \wedge(2,0)=(0,0) \in V(1)$, but $(1,0) \notin V(1)$ and $(2,0) \notin V(1)$.

However, 0 being meet-irreducible is not sufficient to have every prime ideal be of the form $V(x)$. We give an example:

Example 4.5. Let $\overline{\mathbb{N}}_{0}$ denote the order dual of $\mathbb{N}_{0}$, and let $\mathbf{D}=$ $\mathbb{N}_{0} \oplus \overline{\mathbb{N}}_{0}$, where $\oplus$ denotes ordinal sum. As a poset, $\mathbf{D}$ is a chain

$$
0<1<2<3<\cdots<\overline{3}<\overline{2}<\overline{1}<\overline{0}
$$

This becomes a cBCK-algebra compatible with < if we define the operation as follows: for $a, b \in \mathbb{N}_{0}$,

$$
\begin{aligned}
a \cdot b & =\max \{a-b, 0\} \\
\bar{a} \cdot \bar{b} & =\max \{b-a, 0\} \\
a \cdot \bar{b} & =0 \\
\bar{a} \cdot b & =\overline{a+b}
\end{aligned}
$$

This example seems to have first appeared in [16, appeared again shortly after in 20, and was then generalized more recently in [3]. In any case, the algebra $\mathbf{D}$ is subdirectly irreducible with ideal lattice $\operatorname{Id}(\mathbf{D})=\left\{\{0\}<\mathbb{N}_{0}<\mathbf{D}\right\}$ isomorphic to the three-element chain 3. Then the algebra $\mathcal{F}(\{1,2\}, \mathbf{D}) \cong \mathbf{D}^{2}$ has ideal lattice isomorphic to $3^{2}$. Pałasinski proved in [12] that prime ideals are precisely the meet-irreducible elements of the ideal lattice; the ideal $I:=\mathbb{N}_{0} \times \mathbf{D}$ is meet-irreducible in $\operatorname{Id}\left(\mathbf{D}^{2}\right)$, and thus a prime ideal, yet $I \neq V(1)$ and $I \neq V(2)$.

Let $\mathrm{X}(\mathbf{A})$ denote the set of prime ideals of $\mathbf{A}$. For $S \subseteq \mathbf{A}$, define

$$
\sigma(S)=\{P \in \mathrm{X}(\mathbf{A}) \mid S \nsubseteq P\}
$$

The collection $\mathcal{T}(\mathbf{A})=\{\sigma(I) \mid I \in \operatorname{Id}(\mathbf{A})\}$ is a topology on $\mathrm{X}(\mathbf{A})$. There are several proofs of this in the literature, but we point the reader to the paper [2], in which it is also shown that $\mathcal{T}(\mathbf{A}) \cong \operatorname{Id}(\mathbf{A})$ as lattices.

Definition 4.6. The space $(\mathrm{X}(\mathbf{A}), \mathcal{T}(\mathbf{A}))$ is the (prime) spectrum of A.

Given a topological space $Y$, let $\mathcal{T}_{Y}$ denote the lattice of open subsets. We say $Y$ is a spectral space if it is homeomorphic to the prime spectrum of a commutative ring. Hochster 5] proved that a space $Y$ is a spectral space if and only if $Y$ is compact, sober, and the compact open subsets form a basis that is a sublattice of $\mathcal{T}_{Y}$. A generalized spectral space is a space satisfying the latter two of these conditions. Thus, a generalized spectral space which is compact is simply a spectral space.

Meng and Jun [11] proved that the spectrum of a bounded cBCK-algebra is a spectral space. The present author showed in 4 that the spectrum of any cBCK-algebra is a locally compact generalized spectral space, with compactness if and only if the algebra is finitely generated as an ideal.

In general, given a generalized spectral space $Y$, it is difficult to say whether or not that space is the spectrum of a cBCK-algebra.

But it is known that $Y \simeq \mathrm{X}(\mathbf{A})$ for some cBCK-algebra $\mathbf{A}$ if and only if there is a lattice isomorphism $\mathcal{T}_{Y} \cong \operatorname{Id}(\mathbf{A})$; see [4] for a proof.

Proposition 4.7. Let $Y$ be a discrete topological space. Then $Y$ is the spectrum of a cBCK-algebra.

Proof. Since $Y$ is a discrete space, the lattice of open subsets is $\mathcal{P}(Y)$. By Theorem 3.9 we have $\mathcal{T}_{Y} \cong \mathcal{P}(Y) \cong \operatorname{Id}(\mathcal{F S}(Y, \mathbf{A}))$ for any simple cBCK-algebra $\mathbf{A}$, and hence $Y \simeq \mathrm{X}(\mathcal{F} \mathcal{S}(Y, \mathbf{A}))$ for any simple cBCKalgebra $\mathbf{A}$ by the preceding paragraph.
