# Some nonexistence results for space-time fractional Schrödinger equations without gauge invariance

#### Abstract

In this paper, we consider the Cauchy problem in $\mathbb{R}^{N}, N \geq 1$, for semi-linear Schrödinger equations with space-time fractional derivatives. We discuss the nonexistence of global $L^{1}$ or $L^{2}$ weak solutions in the subcritical and critical cases under some conditions on the initial data and the nonlinear term. Furthermore, the nonexistence of local $L^{1}$ or $L^{2}$ weak solutions in the supercritical case are studied.

## 1 Introduction

In this paper, we consider the problem

$$
\begin{cases}i^{\alpha c} D_{0 \mid t}^{\alpha} u-(-\Delta)^{\beta / 2} u=\lambda|u|^{p}, & (t, x) \in(0, T) \times \mathbb{R}^{N}  \tag{1}\\ u(x, 0)=\varepsilon u_{0}(x), & x \in \mathbb{R}^{N},\end{cases}
$$

where $u$ is a complex-valued unknown function of $(t, x), 0<\alpha<1,0<\beta<2, N \geq 1, p>1, T>0, \varepsilon>0$, $\lambda \in \mathbb{C} \backslash\{0\}$, and $i^{\alpha}$ is the principal part of $i^{\alpha}$, i.e.

$$
i^{\alpha}=\cos \left(\frac{\alpha \pi}{2}\right)+i \cos \left(\frac{\alpha \pi}{2}\right)
$$

${ }^{c} D_{0 \mid t}^{\alpha}$ is the Caputo fractional derivative and $(-\Delta)^{\beta / 2}: L^{2}\left(\mathbb{R}^{N}\right) \rightarrow L^{2}\left(\mathbb{R}^{N}\right)$ is the fractional Laplacian which can be defined by a pointwise representation as given in Definition 6 below.

Different fractional generalizations of the Schrödinger equation appeared in the literature: The classical Schrödinger equations with nongauge power nonlinearity, i.e. (1) with $\alpha=1$ and $\beta=2$, has been studied by Ikeda and Wakasugi [8] and Ikeda and Inui [9, 10, the spatial fractional Schrödinger equation involving fractional order space derivatives, i.e. (11) with $\alpha=1$ and $\beta \in(0,2)$, has been investigated in [4, 5, 14, 15, 16, the fractional temporal Schrödinger equation involving a fractional time derivative, i.e. $\alpha \in(0,1)$ and $\beta=2$, has been studied in [25, 19, 20], the semirelativistic Schrödinger equation with nongauge invariant power nonlinearity, i.e. (1) with $\alpha=1$ and $\beta=1 / 2$, got interest by Fujiwara [6], Inui [11], Fujiwara and Ozawa [7], and the spatio-temporal fractional Schrödinger equation with both time and space fractional derivatives attracted the attention of [2, 22].

[^0]The expected critical exponent can be determined by the following scaling argument: If $u(x, t)$ is a solution of (11) with initial data $u_{0}$, then

$$
v(t, x)=\gamma^{\frac{\beta}{p-1}} u\left(\gamma^{\beta / \alpha} t, \gamma x\right)
$$

for all $\gamma>0$, is also a solution of (1) with initial data $v_{0}(x)=v(0, x)=\gamma^{\frac{\beta}{p-1}} u_{0}(\gamma x)$, for all $x \in \mathbb{R}^{N}$. We choose $p=p_{s}$ such that we get an invariant $H^{s}$-norm of the initial data:

\left\|v_{0}\right\|_{H^{s}}=\gamma^{\frac{\beta}{p-1}-\frac{N-2 s}{2}}\left\|u_{0}\right\|_{H^{s}}=\left\|u_{0}\right\|_{H^{s}}
$$

this happens if and only if

$$
p=p_{s}=1+\frac{2 \beta}{N-2 s} .
$$

Therefore, the case $p=p_{s}$ is called $H^{s}$-critical case; the case $p<p_{s}$ (resp. $p>p_{s}$ ) is called $H^{s}$-subcritical case (resp. $H^{s}$-supercritical case). On the other hand, the Fujita critical exponent for the corresponding heat equation with fractional Laplacian is

p_{F}=1+\frac{\beta}{N}
$$

Our main goal is to study the nonexistence of $L^{1}$ or $L^{2}$ global weak solutions under the condition $p \leq p_{s}$ or $p \leq p_{F}$ as well as the nonexistence of $L^{1}$ or $L^{2}$ local weak solutions under the condition that $p>p_{s}$ or $p>p_{F}$ (see e.g. [10]), using the test function method (see e.g. [24]) or a fractional differential equation approach (i.e. construct a fractional differential equation for a new function and using comparison principle). The local existence for (1) is expected in the $H^{s}$-subcritical case, but this is not our case. We refer the reader to [8, Appendix] by using the Strichartz estimates recently studied by Lee [17].
Let

X_{T}=\left\{\varphi \in C\left([0, \infty), H^{\beta}\left(\mathbb{R}^{N}\right)\right) \cap C^{1}\left([0, \infty), L^{2}\left(\mathbb{R}^{N}\right)\right), \text { such that } \operatorname{supp} \varphi \subset Q_{T}, \varphi \text { is } \mathbb{R} \text {-valued }\right\}
$$

and

$$
Y_{T}=\left\{\varphi \in C\left([0, \infty), H^{\beta}\left(\mathbb{R}^{N}\right)\right) \cap C^{1}\left([0, \infty), L^{\infty}\left(\mathbb{R}^{N}\right)\right), \text { such that } \operatorname{supp} \varphi \subset Q_{T}, \varphi \text { is } \mathbb{R} \text {-valued }\right\}
$$

where $Q_{T}:=[0, T] \times \mathbb{R}^{N}$ and the fractional Sobolev space $H^{\beta}\left(\mathbb{R}^{N}\right)$ is defined by

H^{\beta}\left(\mathbb{R}^{N}\right)=\left\{u \in L^{2}\left(\mathbb{R}^{N}\right) ;(-\Delta)^{\beta / 2} u \in L^{2}\left(\mathbb{R}^{N}\right)\right\}
$$

Definition $1\left(L^{2}\right.$-weak solution). Let $u_{0} \in L^{2}\left(\mathbb{R}^{N}\right)$ and $T>0$. We say that $u$ is an $L^{2}$-weak solution of (11) if

u \in L^{1}\left((0, T), L^{2}\left(\mathbb{R}^{N}\right)\right) \cap L^{p}\left((0, T), L^{2 p}\left(\mathbb{R}^{N}\right)\right)
$$

and

$$
\begin{align*}
& \lambda \int_{Q_{T}}|u|^{p} \varphi(t, x) d t d x+\varepsilon i^{\alpha} \int_{Q_{T}} u_{0}(x)^{c} D_{t \mid T}^{\alpha} \varphi(t, x) d t d x \\
& =i^{\alpha} \int_{Q_{T}} u^{c} D_{t \mid T}^{\alpha} \varphi d t d x-\int_{Q_{T}} u(-\Delta)^{\beta / 2} \varphi(t, x) d t d x \tag{2}
\end{align*}

holds for all $\varphi \in X_{T}$. We denote the lifespan for the $L^{2}$-weak solution by

$$
T_{w}(\varepsilon):=\sup \left\{T \in(0, \infty] ; \text { there exists a unique } L^{2} \text {-weak solution } u \text { to (1) }\right\} .
$$

Moreover, if $T>0$ can be arbitrary chosen, i.e. $T_{w}(\varepsilon)=\infty$, then $u$ is called a global $L^{2}$-weak solution of (1).

Definition $2\left(L^{1}\right.$-weak solution). Let $u_{0} \in L^{1}\left(\mathbb{R}^{N}\right)$ and $T>0$. We say that $u$ is an $L^{1}$-weak solution of (1) if $u,|u|^{p} \in L^{1}\left((0, T), L^{1}\left(\mathbb{R}^{N}\right)\right)$ and

$$
\begin{align*}
& \lambda \int_{Q_{T}}|u|^{p} \varphi(t, x) d t d x+\varepsilon i^{\alpha} \int_{Q_{T}} u_{0}(x)^{c} D_{t \mid T}^{\alpha} \varphi(t, x) d t d x \\
& =i^{\alpha} \int_{Q_{T}} u^{c} D_{t \mid T}^{\alpha} \varphi d t d x-\int_{Q_{T}} u(-\Delta)^{\beta / 2} \varphi(t, x) d t d x \tag{3}
\end{align*}
$$

holds for all $\varphi \in Y_{T}$. We denote the lifespan for the $L^{1}$-weak solution by

$$
\bar{T}_{w}(\varepsilon):=\sup \left\{T \in(0, \infty] ; \text { there exists a unique } L^{1} \text {-weak solution } u \text { to (11) }\right\}
$$

Moreover, if $T>0$ can be arbitrary chosen, i.e. $\bar{T}_{w}(\varepsilon)=\infty$, then $u$ is called a global $L^{1}$-weak solution to (1).

## 2 Preliminaries

Definition 3 (Absolutely continuous functions). [21, Chapter 1]
A function $g:[a, b] \rightarrow \mathbb{R}$ with $a, b \in \mathbb{R}$, is absolutely continuous if and only if there exists a Lebesgue summable function $\psi \in L^{1}(a, b)$ such that

g(t)=g(a)+\int_{a}^{t} \psi(s) d s, \quad \text { for all } t \in[a, b]
$$

The space of these functions is denoted by $A C[a, b]$.
Definition 4 (Riemann-Liouville fractional integrals). [21, Chapter 1]
Let $g \in L^{1}(0, T)$ with $T>0$. The Riemann-Liouville left- and right-sided fractional integrals of order $\sigma \in(0,1)$ are, respectively, defined by

I_{0 \mid t}^{\sigma} g(t):=\frac{1}{\Gamma(\sigma)} \int_{0}^{t}(t-s)^{-(1-\sigma)} g(s) d s, \quad t>0
$$

and

$$
I_{t \mid T}^{\sigma} g(t):=\frac{1}{\Gamma(\sigma)} \int_{t}^{T}(s-t)^{-(1-\sigma)} g(s) d s, \quad t<T
$$

where $\Gamma$ is the Euler gamma function.
Definition 5 (Caputo fractional derivatives). [21, Chapter 1]
Let $f \in A C[0, T]$ with $T>0$. The Caputo left- and right-sided fractional derivatives of order $\delta \in(0,1)$ exists almost everywhere on $[0, T]$ and defined, respectively, by

{ }^{c} D_{0 \mid t}^{\delta} f(t):=\frac{d}{d t} I_{0 \mid t}^{1-\delta}[f(t)-f(0)]=I_{0 \mid t}^{1-\delta}\left[f^{\prime}(t)\right], \quad t>0
$$

and

{ }^{c} D_{t \mid T}^{\delta} f(t):=-\frac{d}{d t} I_{t \mid T}^{1-\delta}[f(t)-f(T)]=-I_{t \mid T}^{1-\delta}\left[f^{\prime}(t)\right], \quad t<T
$$

Lemma 1. [12, Lemma 2.22, p. 96$]$
Let $0<\delta<1$ and $T>0$. If $f \in A C[0, T]$ or $f \in C^{1}[0, T]$, then

$$
\begin{equation*}
I_{0 \mid t}^{\delta}{ }^{c} D_{0 \mid t}^{\delta} f(t)=f(t)-f(0) \tag{4}
\end{equation*}
$$

Given $T>0$, let us define the function $w:[0, T] \rightarrow \mathbb{R}$ by the following formula:

\begin{equation*}
w(t)=(1-t / T)^{\eta} \quad \text { for all } 0 \leq t \leq T \tag{5}
\end{equation*}
$$

where $\eta \gg 1$. Later on, we need the following properties concerning the function $w$.
Lemma 2. [12, Property 2.16, p.95]
Let $T>0, \eta>\alpha-1$, and $0<\alpha<1$. For all $t \in[0, T]$, we have

{ }^{c} D_{t \mid T}^{\alpha} w(t)=\frac{\Gamma(\eta+1)}{\Gamma(\eta+1-\alpha)} T^{-\alpha}(1-t / T)^{\eta-\alpha} \tag{6}
\end{equation*}
$$

Lemma 3. Let $T>0,0<\alpha<1, \eta>\alpha p /(p-1)-1$, and $p>1$. Then, we have

\left.\left.\int_{0}^{T}(w(t))^{-\frac{1}{p-1}}\right|^{c} D_{t \mid T}^{\alpha} w(t)\right|^{\frac{p}{p-1}} d t=C_{1} T^{1-\alpha \frac{p}{p-1}} \tag{7}
\end{equation*}
$$

and

$$
\begin{equation*}
\int_{0}^{T}{ }^{c} D_{t \mid T}^{\alpha} w(t) d t=C_{2} T^{1-\alpha} \tag{8}
\end{equation*}
$$

where

$$
C_{1}=\frac{1}{\eta+1-\alpha \frac{p}{p-1}}\left[\frac{\Gamma(\eta+1)}{\Gamma(\eta+1-\alpha)}\right]^{\frac{p}{p-1}}, \quad \text { and } \quad C_{2}=\frac{\Gamma(\eta+1)}{\Gamma(\eta+2-\alpha)}
$$

Proof. Let we start by proving (7). Using Lemma 2, we have

$$
\begin{aligned}
\left.\left.\int_{0}^{T}(w(t))^{-\frac{1}{p-1}}\right|^{c} D_{t \mid T}^{\alpha} w(t)\right|^{\frac{p}{p-1}} d t & =\left[\frac{\Gamma(\eta+1)}{\Gamma(\eta+1-\alpha)}\right]^{\frac{p}{p-1}} T^{-\alpha \frac{p}{p-1}} \int_{0}^{T}(w(t))^{-\frac{1}{p-1}}(w(t))^{\frac{p(\eta-\alpha)}{(p-1) \eta}} d t \\
& =\left[\frac{\Gamma(\eta+1)}{\Gamma(\eta+1-\alpha)}\right]^{\frac{p}{p-1}} T^{-\alpha \frac{p}{p-1}} \int_{0}^{T}(1-t / T)^{\eta-\alpha \frac{p}{p-1}} d t \\
& =\left[\frac{\Gamma(\eta+1)}{\Gamma(\eta+1-\alpha)}\right]^{\frac{p}{p-1}} T^{1-\alpha \frac{p}{p-1}} \int_{0}^{1}(1-s)^{\eta-\alpha \frac{p}{p-1}} d s \\
& =C_{1} T^{1-\alpha \frac{p}{p-1}} .
\end{aligned}
$$

Similarly, we get (8).
Lemma 4. Let $T>0,0<\alpha<1, p>1, A, B \geq 0$, and $v \in C^{1}([0, T), \mathbb{R})$ satisfying the following fractional differential inequality

$$
\begin{equation*}
{ }^{c} D_{0 \mid t}^{\alpha} v(t) \geq B\left[|v(t)|^{p}-A\right], \quad t \in[0, T) \tag{9}
\end{equation*}
$$

subject to $v(0)>A^{\frac{1}{p}}$. Then $v(t) \geq A^{\frac{1}{p}}$ for all $t \in[0, T)$.
Proof. Fixing $T_{1} \in(0, T)$, we show that $v(t) \geq A^{\frac{1}{p}}$ for any $t \in\left(0, T_{1}\right]$. Then, since $T_{1}$ is arbitrary, the claim follows. Let us start by defining $T^{*}=\inf \left\{t>0 ; v(t) \geq A^{\frac{1}{p}}\right\}$. Since $v$ is continuous and $v(0)>A^{\frac{1}{p}}$, we have $T^{*}>0$. We claim $T^{*}=T_{1}$. Otherwise, we have $v(t)>A^{\frac{1}{p}}$ for all $t \in\left(0, T^{*}\right)$ such that $v\left(T^{*}\right)=A^{\frac{1}{p}}$; this implies, in particular, that

F(t, v(t)):=B\left[|v(t)|^{p}-A\right] \geq 0, \quad \text { for all } t \in\left[0, T^{*}\right] \tag{10}
\end{equation*}
$$

On the other hand, since the right hand side of (9) is continuous on $\left[0, T_{1}\right]$ and $v \in C^{1}\left(\left[0, T_{1}\right]\right)$, applying the Riemann-Liouville fractional integral $I_{0 \mid T^{*}}^{\alpha}$ to (9) on $\left[0, T_{1}\right]$ and using (4), we get

$$
A^{\frac{1}{p}}=v\left(T^{*}\right)=v(0)+\frac{1}{\Gamma(\alpha)} \int_{0}^{T^{*}}\left(T^{*}-s\right)^{-(1-\alpha)} F(s, v(s)) d s \geq v(0)>A^{\frac{1}{p}}
$$

where we have used (10) ; contradiction. This completes the proof.

Using [18, Proposition 4.6] and applying the same argument as in the proof of Lemma 4] one can define the function $g \in C\left(\left[0, T_{b}\right), \mathbb{R}^{+}\right)$which is the unique solution of

g(0)>0,
\end{array}\right.
$$

where $T_{b}$ is the maximal time of existence.
Proposition 1 (Fractional differential inequalities).
Let $T_{b}>0$ be the blow-time of the solution of (11), and let $T>T_{b}, 0<\alpha<1, p>1, B>0$, and $f \in C^{1}([0, T), \mathbb{R})$ be a nonnegative solution of the following fractional differential inequality

\left\{\begin{array}{l}
{ }^{c} D_{0 \mid t}^{\alpha} f(t) \geq B f^{p}(t), \quad t \in[0, T),  \tag{12}\\
f(0)>0
\end{array}\right.
$$

Then $f$ blows up at $T_{b}$, i.e. $\lim _{t \rightarrow T_{b}^{-}} f(t)=+\infty$. Moreover, the following upper and lower bound of $T_{b}$ are also given

$$
\begin{equation*}
T_{L} \leq T_{b} \leq T_{U} \tag{13}
\end{equation*}
$$

where

$$
T_{U}:=\left(\frac{\Gamma(1+\alpha)}{B(f(0))^{p-1} H(p, \alpha)}\right)^{1 / \alpha} \quad \text { and } \quad T_{L}:=\left(\frac{\Gamma(1+\alpha)}{B(f(0))^{p-1} G(p)}\right)^{1 / \alpha}
$$

with

$$
\begin{equation*}
G(p)=\min \left(2^{p}, \frac{p^{p}}{(p-1)^{p-1}}\right), \quad H(p, \alpha)=\max \left(p-1,2^{-\frac{p \alpha}{p-1}}\right) \tag{14}
\end{equation*}
$$

Proof. Applying [3, Theorem 5.1], we conclude that the solution $g$ of (11) is an increasing function and

$$
\lim _{t \rightarrow T_{b}^{-}} g(t)=+\infty
$$

On the other hand, by taking $g(0)=f(0)$, applying [18, Theorem 4.10] and using (11), (12), we conclude that

$$
f(t) \geq g(t) \geq 0
$$

this implies that

$$
\lim _{t \rightarrow T_{b}^{-}} f(t)=+\infty
$$

Moreover, using [3, Theorem 5.2], we get (13)
Definition 6. [13, 23] Let $s \in(0,1)$ and $X$ be a suitable set of functions defined on $\mathbb{R}^{N}$. The fractional Laplacian $(-\Delta)^{s}$ in $\mathbb{R}^{N}$ is a non-local operator defined as the following singular integral

$$
(-\Delta)^{s}: v \in X \mapsto(-\Delta)^{s} v(x):=C_{N, s} \text { p.v. } \int_{\mathbb{R}^{N}} \frac{v(x)-v(y)}{|x-y|^{N+2 s}} d y
$$

as long as the right-hand side exists, and p.v. stands for Cauchy's principal value, $C_{N, s}:=\frac{4^{s} \Gamma\left(\frac{N}{2}+s\right)}{\pi^{\frac{N}{2}} \Gamma(-s)}$ is a normalization constant and $\Gamma$ denotes the Gamma function.

Lemma 5. [1, Lemma 2.3] Let $\langle x\rangle:=\left(1+|x|^{2}\right)^{1 / 2}$ for all $x \in \mathbb{R}^{N}$. Let $s \in(0,1)$ and $\phi: \mathbb{R}^{N} \rightarrow \mathbb{R}$ be a function defined by $\phi(x)=\langle x\rangle^{-q}$, where $n<q \leq N+2 s$. Then, $\phi \in H^{2 s}\left(\mathbb{R}^{N}\right)$ and the following estimate holds:

\begin{equation*}
\left|(-\Delta)^{s} \phi(x)\right| \leq C_{N, q} \phi(x), \quad \text { for all } x \in \mathbb{R}^{N}, \quad C_{N, q}=C(s, N, q)>0 \tag{15}
\end{equation*}
$$

Lemma 6. [1, Lemma 2.4] Let $s \in(0,1)$, and let Let $\psi$ be a smooth function satisfying $\partial_{x}^{2} \psi \in L^{\infty}\left(\mathbb{R}^{N}\right)$. For any $R>0$, let $\psi_{R}$ be a function defined by

$$
\psi_{R}(x):=\psi(x / R) \quad \text { for all } x \in \mathbb{R}^{N} .
$$

Then, $(-\Delta)^{s} \psi_{R}$ satisfies the following scaling properties:

$$
(-\Delta)^{s} \psi_{R}(x)=R^{-2 s}\left((-\Delta)^{s} \psi\right)(x / R), \quad \text { for all } x \in \mathbb{R}^{N}
$$

Lemma 7. Let $s \in(0,1), R>0$ and $p>1$. Then, the following estimate holds

$$
\int_{\mathbb{R}^{N}}\left(\phi_{R}(x)\right)^{-\frac{1}{p-1}}\left|(-\Delta)^{s} \phi_{R}(x)\right|^{\frac{p}{p-1}} d x \leq C_{3} R^{-\frac{2 s p}{p-1}+N}
$$

where $C_{3}=\left(C_{N, q}\right)^{p /(p-1)} A_{0}>0, A_{0}$ is defined below, $\phi_{R}(x):=\phi(x / R)$, and $\phi$ is given in Lemma 5.
Proof. If $0<s<1$, then using the change of variable $\tilde{x}=x / R$ and Lemma 6 we have $(-\Delta)^{s} \phi_{R}(x)=$ $R^{-2 s}(-\Delta)^{s} \phi(\tilde{x})$. Therefore, by Lemma 5 we conclude that

\int_{\mathbb{R}^{N}}\left(\phi_{R}(x)\right)^{-\frac{1}{p-1}}\left|(-\Delta)^{s} \phi_{R}(x)\right|^{\frac{p}{p-1}} d x \leq\left(C_{N, q}\right)^{\frac{p}{p-1}} R^{-\frac{2 s p}{p-1}+N} \int_{\mathbb{R}^{N}} \phi(\tilde{x}) d \tilde{x}=\left(C_{N, q}\right)^{\frac{p}{p-1}} A_{0} R^{-\frac{2 s p}{p-1}+N}
$$

where

$$
A_{0}=\int_{\mathbb{R}^{N}} \phi(x) d x>0
$$

## 3 Theorem 1. Non-existence of global $L^{1}$-weak solution in the case $p \leq p_{F}$

To state our first result, we set

$$
\lambda=\lambda_{1}+i \lambda_{2}, \quad u_{0}=g+i h
$$

where $\lambda_{i} \in \mathbb{R}(i=0,1)$ and $g$ and $h$ are real-valued functions; the real and imaginary parts of $i^{\alpha} u_{0}$ can be written, respectively, as

$$
G_{1}(x)=\cos \left(\frac{\alpha \pi}{2}\right) g(x)-\sin \left(\frac{\alpha \pi}{2}\right) h(x), \quad \text { and } \quad G_{2}(x)=\cos \left(\frac{\alpha \pi}{2}\right) h(x)+\sin \left(\frac{\alpha \pi}{2}\right) g(x)
$$

Theorem 1 (Non-existence of global $L^{1}$-weak solution in the case $p \leq p_{F}$ ).
Let $0<\alpha<1,0<\beta<2, N \geq 1, \varepsilon=1$.

1. If $1<p<1+\frac{\beta}{N}=p_{F}$, and $u_{0} \in L^{1}\left(\mathbb{R}^{N}\right)$ satisfies

$$
\begin{equation*}

\end{equation*}

then problem (1) admits no global $L^{1}$-weak solution.
2. If $p=p_{F}$, and $u_{0} \in L^{2}\left(\mathbb{R}^{N}\right)$ satisfies

\left|\lambda_{1}\right|^{\frac{2-p}{p-1}} \lambda_{1} \int_{\mathbb{R}^{N}} G_{1}(x) d x>C_{0} A_{0} \quad \text { or } \quad\left|\lambda_{1}\right|^{\frac{2-p}{p-1}} \lambda_{2} \int_{\mathbb{R}^{N}} G_{2}(x) d x>C_{0} A_{0}
$$

where $A_{0}=\int_{\mathbb{R}^{N}}\langle x\rangle^{-N-\beta} d x$, and $C_{0}$ is defined in (25) below, then problem (1) admits no global $L^{1}$-weak solution.

Proof. We argue by contradiction. Suppose that $u$ is a global weak solution to (1), then

for all $T>0$ and all $\varphi \in Y_{T}$. In order to get a non-negativity in the left hand side of (17), we consider four cases:
Case I: If $\lambda_{1}>0$, then $\int_{\mathbb{R}^{N}} G_{1} d x>0$, therefore by taking the real part (Re) of the both sides of (17), we get:

\end{aligned}

Case II: If $\lambda_{1}<0$, then $\int_{\mathbb{R}^{N}} G_{1} d x<0$ therefore by taking (-Re) of the both sides of (17) we get:

& =-\int_{Q_{T}} \operatorname{Re}\left(i^{\alpha} u\right)^{c} D_{t \mid T}^{\alpha} \varphi d t d x+\int_{Q_{T}} \operatorname{Re}(u)(-\Delta)^{\beta / 2} \varphi(t, x) d t d x
\end{aligned}
$$

Case III: If $\lambda_{2}>0$, then $\int_{\mathbb{R}^{N}} G_{2} d x>0$, therefore by taking the imaginary part (Im) of the both sides of (17), we get:

& =\int_{Q_{T}} \operatorname{Im}\left(i^{\alpha} u\right)^{c} D_{t \mid T}^{\alpha} \varphi d t d x-\int_{Q_{T}} \operatorname{Im}(u)(-\Delta)^{\beta / 2} \varphi(t, x) d t d x
\end{aligned}
$$

Case IV: If $\lambda_{2}<0$, then $\int_{\mathbb{R}^{N}} G_{2} d x<0$, therefore by taking (-Im) of the both sides of (17), we get:

Then we only consider the Case I, since the other cases can be treated in the same way, by assuming $\lambda_{1}>0$, $u_{0} \in L^{1}\left(\mathbb{R}^{N}\right)$ and

& \leq\left. 2 \int_{Q_{T}}|u|\right|^{c} D_{t \mid T}^{\alpha} \varphi(t, x)\left|d t d x+\int_{Q_{T}}\right| u| |(-\Delta)^{\beta / 2} \varphi(t, x) \mid d t d x \tag{19}
\end{align*}
$$

all $\varphi \in Y_{T}$. Using the $\varepsilon$-Young inequality

\end{equation*}

& \leq \varepsilon \int_{Q_{T}}|u|^{p} \varphi(t, x) d t d x+C_{4} \int_{Q_{T}} \varphi^{-\frac{1}{p-1}}\left|{ }^{c} D_{t \mid T}^{\alpha} \varphi(t, x)\right|^{\frac{p}{p-1}} d t d x \tag{21}
\end{align*}
$$

where

C_{4}=2^{\frac{p}{p-1}} C_{\varepsilon}=\frac{2^{\frac{p}{p-1}}(p-1)(p \varepsilon)^{-\frac{1}{p-1}}}{p}

Combining (21)-(22) with (19), we obtain

& \leq C_{4} \int_{Q_{T}} \varphi^{-\frac{1}{p-1}}\left|{ }^{c} D_{t \mid T}^{\alpha} \varphi(t, x)\right|^{\frac{p}{p-1}} d t d x+C_{5} \int_{Q_{T}} \varphi^{-\frac{1}{p-1}}\left|(-\Delta)^{\beta / 2} \varphi(t, x)\right|^{\frac{p}{p-1}} d t d x
\end{aligned}
$$

which implies, by taking $\varepsilon \leq \lambda_{1} / 2$, that

& \leq C_{4} \int_{Q_{T}} \varphi^{-\frac{1}{p-1}}\left|{ }^{c} D_{t \mid T}^{\alpha} \varphi(t, x)\right|^{\frac{p}{p-1}} d t d x+C_{5} \int_{Q_{T}} \varphi^{-\frac{1}{p-1}}\left|(-\Delta)^{\beta / 2} \varphi(t, x)\right|^{\frac{p}{p-1}} d t d x \tag{23}
\end{align*}
$$

all $\varphi \in X_{T}$. At this stage, we take the test function

\varphi(t, x):=\phi_{R}(x) w(t)
$$

with $\phi_{R}(x):=\phi(x / R), R>0$, where $\phi(x)$ and $w(t)$ are defined in Section 2 with $s=\beta / 2$ and $q=N+\beta$. Therefore, from (23) we obtain

& \leq\left.\left. C_{4} \int_{\mathbb{R}^{N}} \phi_{R}(x) d x \int_{0}^{T}(w(t))^{-\frac{1}{p-1}}\right|^{c} D_{t \mid T}^{\alpha} w(t)\right|^{\frac{p}{p-1}} d t \\
& \quad+C_{5} \int_{0}^{T} w(t) d t \int_{\mathbb{R}^{N}}\left(\phi_{R}(x)\right)^{-\frac{1}{p-1}}\left|(-\Delta)^{\beta / 2} \phi_{R}(x)\right|^{\frac{p}{p-1}} d x .
\end{aligned}
$$

As

$$
\int_{\mathbb{R}^{N}} \phi_{R}(x) d x=\int_{\mathbb{R}^{N}} \phi(\tilde{x}) R^{N} d \tilde{x}=A_{0} R^{N}, \quad \text { and } \quad \int_{0}^{T} w(t) d t=\frac{T}{\eta+1},
$$

so, using Lemma 3 and Lemma 7 with $s=\beta / 2$ and $\eta>\alpha p /(p-1)-1$, we obtain

If $p<1+\frac{\beta}{N}$, then $\frac{N}{\beta}-\frac{1}{p-1}<0$. As $G_{1} \in L^{1}\left(\mathbb{R}^{N}\right)$, letting $T \rightarrow \infty$ and using the dominated convergence theorem we derive

If $p=1+\frac{\beta}{N}$, using again the same argument, we arrive at

Remark 1. We note that the regularity of $u_{0}$ is not so important in Theorem 1, in fact, we can replace $u_{0} \in L^{1}\left(\mathbb{R}^{N}\right)$ by $u_{0} \in L^{2}\left(\mathbb{R}^{N}\right)$ and we get a nonexistence of global $L^{2}$-weak solution. In this case, to ensure the existence of the conditions on $G_{1}$ and $G_{2}$, we need also to assume that $G_{1}$ or $G_{2}$ are in $L^{1}\left(\mathbb{R}^{N}\right)$.

## 4 Theorem 2. Non-existence of global $L^{2}$-weak solution in $L^{2}$-subcritical case for small data

Theorem 2 (Non-existence for global $L^{2}$-weak solution in $L^{2}$-subcritical case and for small data). Let $0<\alpha<1,0<\beta<2, N \geq 1, \varepsilon>0$. Let $u_{0} \in H^{s}\left(\mathbb{R}^{N}\right)$, $s \geq 0$, and $u$ be an $L^{2}$-weak solution on $\left[0, T_{w}(\varepsilon)\right)$. We assume that $1<p<1+2 \beta / N$ and $u_{0}$ satisfies

$$
\lambda_{1} G_{1}(x) \quad \text { or } \quad \lambda_{2} G_{2}(x) \geq \begin{cases}|x|^{-k}, & \text { if }|x|>1  \tag{26}\\ 0, & \text { if }|x| \leq 1\end{cases}
$$

where $N / 2<k<\frac{\beta}{p-1}$. Then, $u$ is not global, i.e. $T_{w}(\varepsilon)<\infty$. More precisely, there exists a constant $\varepsilon_{0}>0$ such that

T_{w}(\varepsilon) \leq \begin{cases}B_{0} \varepsilon^{-\frac{1}{\alpha \kappa_{0}}}, & \text { if } \varepsilon \in\left(0, \varepsilon_{0}\right)  \tag{27}\\ 1, & \text { if } \varepsilon \in\left[\varepsilon_{0}, \infty\right)\end{cases}
$$

where $\kappa_{0}=\frac{1}{p-1}-\frac{k}{\beta}>0$ and

$$
B_{0}=\left(C_{0}(k+\beta) \omega_{N}^{-1} 2^{\frac{N+\beta}{2}} A_{0} \lambda_{1}^{\frac{p-2}{p-1}}\right)^{\frac{1}{\alpha \kappa_{0}}}
$$

with $\omega_{N}$ stands for the $(N-1)$-dimensional surface measure of the unit sphere.
Proof. Repeating the same calculations as in the proof of Theorem 1 by taking here $\varepsilon \neq 1$, and assuming only

\lambda_{1}>0 \quad \text { and } \quad G_{1}(x) \geq \begin{cases}\lambda_{1}^{-1}|x|^{-k}, & \text { if }|x|>1 \\ 0, & \text { if }|x| \leq 1\end{cases}
$$

(the other cases can be treated similarly). From (24), we obtain

\varepsilon \int_{\mathbb{R}^{N}} G_{1}(x) \phi\left(x / T^{\alpha / \beta}\right) d x \leq C_{0} A_{0} \lambda_{1}^{-\frac{1}{p-1}} T^{\alpha\left[\frac{N}{\beta}+1-\frac{p}{p-1}\right]}, \quad \text { for all } 0<T<T_{w}(\varepsilon) \tag{28}
\end{equation*}
$$

On the other hand,

$$
\begin{aligned}
\varepsilon \int_{\mathbb{R}^{N}} G_{1}(x) \phi\left(x / T^{\alpha / \beta}\right) d x & =\varepsilon T^{\frac{\alpha N}{\beta}} \int_{\mathbb{R}^{N}} G_{1}\left(y T^{\alpha / \beta}\right) \phi(y) d y \\
& \geq \lambda_{1}^{-1} \varepsilon T^{\frac{\alpha(N-k)}{\beta}} \int_{|y|>T^{-\frac{\alpha N}{\beta}}}|y|^{-k} \phi(y) d y \\
& =\lambda_{1}^{-1} \varepsilon T^{\frac{\alpha(N-k)}{\beta}} K(T)
\end{aligned}
$$

where

$$
K(T):=\int_{|y|>T^{-\frac{\alpha N}{\beta}}}|y|^{-k} \phi(y) d y
$$

Therefore, from (28), we arrive at

\end{equation*}
$$

It remains to estimate from below the last inequality.
First, let $\varepsilon_{0}=B_{0}^{\alpha k_{0}}$, then

for all $\varepsilon \geq \varepsilon_{0}$. Indeed, suppose on the contrary that there exists $\varepsilon \geq \varepsilon_{0}$ such that $T_{w}(\varepsilon)>1$. Applying (29) with $\tau \in\left(1, T_{w}(\varepsilon)\right)$, we obtain

Using the fact that

we have

\frac{\omega_{N}}{(k+\beta) 2^{\frac{N+\beta}{2}}}=2^{-\frac{N+\beta}{2}} \int_{|y|>1}|y|^{-k-N-\beta} d y \leq K(1) \leq \int_{|y|>1}|y|^{-k-N-\beta} d y=\frac{\omega_{N}}{(k+\beta)}
$$

Whereupon,

K(\tau) \geq K(1) \geq \frac{\omega_{N}}{(k+\beta) 2^{\frac{N+\beta}{2}}}, \quad \text { for all } 1<\tau<T_{w}(\varepsilon) \tag{31}
\end{equation*}

Combining (30) and (31), we obtain

\varepsilon \leq(k+\beta) \omega_{N}^{-1} 2^{\frac{N+\beta}{2}} C_{0} A_{0} \lambda_{1}^{\frac{p-2}{p-1}} \tau^{\alpha\left[\frac{k}{\beta}-\frac{1}{p-1}\right]}
$$

i.e.

Letting $\tau \rightarrow T_{w}(\varepsilon)$, we get

$$

contradiction. Therefore, $T_{w}(\varepsilon) \leq 1$, for all $\varepsilon \geq \varepsilon_{0}$.
On the other hand, suppose $\varepsilon<\varepsilon_{0}$. If $T_{w}(\varepsilon) \leq 1$, it follows that

T_{w}(\varepsilon) \leq 1=B_{0} \varepsilon_{0}^{-\frac{1}{\alpha \kappa_{0}}} \leq B_{0} \varepsilon^{-\frac{1}{\alpha \kappa_{0}}} .
$$

Hence, it is sufficient to consider $T_{w}(\varepsilon)>1$. By the above argument, we get again

This completes the proof.

Remark 2. We note that the condition $k>\frac{N}{2}$ in Theorem 2 is necessary to ensure the existence of at least an $H^{s}$-function $u_{0}$ satisfying (32), for all $s \geq 0$.

## 5 Theorem 3. Non-existence of global $L^{2}$-weak solution for large data

Theorem 3 (Non-existence of global $L^{2}$-weak solution for $p>1$ and large data).
Let $0<\alpha<1,0<\beta<2, N \geq 1, \varepsilon>0$, and $p>1$. Let $u_{0} \in H^{s}\left(\mathbb{R}^{N}\right), s \geq 0$, and $u$ be an $L^{2}$-weak solution on $\left[0, T_{w}(\varepsilon)\right)$. We assume that $u_{0}$ satisfies

$$
\lambda_{1} G_{1}(x) \quad \text { or } \quad \lambda_{2} G_{2}(x) \geq \begin{cases}|x|^{-k}, & \text { if }|x| \leq 1  \tag{32}\\ 0, & \text { if }|x|>1\end{cases}
$$

where $k<\min \left\{\frac{N}{2}-s, \frac{\beta}{p-1}\right\}$. Then, there exists a constant $\varepsilon_{1}>0$ such that for any $\varepsilon>\varepsilon_{1}$, u is not global, i.e. $T_{w}(\varepsilon)<\infty$. More precisely,

$$
T_{w}(\varepsilon) \leq \bar{C} \varepsilon^{-\frac{1}{\alpha \kappa_{0}}}
$$

for all $\varepsilon>\varepsilon_{1}$, where $\kappa_{0}=\frac{1}{p-1}-\frac{k}{\beta}>0$ and

$$
\bar{C}=\left(C_{0}(N-k) \omega_{N}^{-1} 2^{\frac{N+\beta}{2}} A_{0} \lambda_{1}^{\frac{p-2}{p-1}}\right)^{\frac{1}{\alpha \kappa_{0}}}
$$

Proof. Repeating the same calculations as in the proof of Theorem by taking here $\varepsilon \neq 1$, and considering only the case

$$
\lambda_{1}>0 \quad \text { and } \quad G_{1}(x) \geq \begin{cases}\lambda_{1}^{-1}|x|^{-k}, & \text { if }|x| \leq 1 \\ 0, & \text { if }|x|>1\end{cases}
$$

as the other cases can be treated similarly. From (24), we obtain

\begin{equation*}
\varepsilon \int_{\mathbb{R}^{N}} G_{1}(x) \phi\left(x / T^{\alpha / \beta}\right) d x \leq C_{0} A_{0} \lambda_{1}^{-\frac{1}{p-1}} T^{\alpha\left[\frac{N}{\beta}+1-\frac{p}{p-1}\right]}, \quad \text { for all } 0<T<T_{w}(\varepsilon) \tag{33}
\end{equation*}
$$

On the other hand,

$$
\begin{aligned}
\varepsilon \int_{\mathbb{R}^{N}} G_{1}(x) \phi\left(x / T^{\alpha / \beta}\right) d x & =\varepsilon T^{\frac{\alpha N}{\beta}} \int_{\mathbb{R}^{N}} G_{1}\left(y T^{\alpha / \beta}\right) \phi(y) d y \\
& \geq \lambda_{1}^{-1} \varepsilon T^{\frac{\alpha(N-k)}{\beta}} \int_{|y| \leq T^{-\frac{\alpha N}{\beta}}}|y|^{-k} \phi(y) d y \\
& =\lambda_{1}^{-1} \varepsilon T^{\frac{\alpha(N-k)}{\beta}} L(T)
\end{aligned}
$$

where

$$
L(T):=\int_{|y| \leq T^{-\frac{\alpha N}{\beta}}}|y|^{-k} \phi(y) d y
$$

Therefore, from (33), we arrive at

$$

\varepsilon L(T) \leq C_{0} A_{0} \lambda_{1}^{\frac{p-2}{p-1}} T^{\alpha\left[\frac{k}{\beta}-\frac{1}{p-1}\right]}, \quad \text { for all } 0<T<T_{w}(\varepsilon) \tag{34}
\end{equation*}
$$

It remains to estimate from below the last inequality.
We claim that there exists a constant $\varepsilon_{1}>0$ such that for any $\varepsilon>\varepsilon_{1}$,

T_{w}(\varepsilon) \leq 1 \tag{35}
\end{equation*}
$$

Indeed, suppose on the contrary that for all $\varepsilon_{1}>0$, there exists $\varepsilon>\varepsilon_{1}$ such that $T_{w}(\varepsilon)>1$. Applying (34) with $T=1$, we have

Using the fact that $k<N$, and

$$

it is easy to check that

\frac{\omega_{N}}{(N-k) 2^{\frac{N+\beta}{2}}} \leq L(1) \leq \frac{\omega_{N}}{(N-k)} \tag{37}
\end{equation*}
$$

Combining (36) and (37), we obtain

\varepsilon \leq(N-k) \omega_{N}^{-1} 2^{\frac{N+\beta}{2}} C_{0} A_{0} \lambda_{1}^{\frac{p-2}{p-1}}=: \varepsilon_{1}
$$

contradiction. Thus the claim is proved.
Therefore, for all $T<T_{w}(\varepsilon) \leq 1$, we have

which implies, using again (34),

$$

i.e.

T \leq \bar{C} \varepsilon^{-\frac{1}{\alpha \kappa_{0}}}, \quad \text { for all } 0<T<T_{w}(\varepsilon)
$$

Since $T$ is arbitrary in $\left(0, T_{w}(\varepsilon)\right)$, the proof is completed by letting $T \rightarrow T_{w}(\varepsilon)$.

Remark 3. In Theorem 3, it is sufficient to just consider the case $p \leq 1+2 \beta /(N-2 s)$, because the other case $p>1+2 \beta /(N-2 s)$ is proved below in Section 6. (non local implies non global existence), and in this case we take $k<\frac{N}{2}-s\left(\leq \frac{\beta}{p-1}\right)$.
Remark 4. We note that the condition $k<\frac{N}{2}-s$ in Theorem 3 is necessary to ensure the existence of at least an $H^{s}$-function $u_{0}$ satisfying (32).

## 6 Theorem 4. Nonexistence of local $L^{2}$-weak solution in $H^{s}$-supercritical case

Theorem 4 (Non-existence of local $L^{2}$-weak solution in $H^{s}$-supercritical case).
Let $0<\alpha<1,0<\beta<2, N \geq 1, \varepsilon>0$, and $p>1+2 \beta /(N-2 s)$. Assume $u_{0} \in H^{s}\left(\mathbb{R}^{N}\right), 0 \leq s<N / 2$, such that $u_{0}$ satisfies (32) with $\beta /(p-1)<k<N / 2-s$. Then there is no local $L^{2}$-weak solution of (11).

Proof. Suppose that there exists an $L^{2}$-weak solution $u$ on $[0, T)$ for some $0<T<T_{w}(\varepsilon)$. Repeating the same proof of Theorem 3, we have

$$
\varepsilon L(\tau) \leq C_{0} A_{0} \lambda_{1}^{\frac{p-2}{p-1}} \tau^{\alpha\left[\frac{k}{\beta}-\frac{1}{p-1}\right]}, \quad \text { for all } 0<\tau<T
$$

For all $\tau<1$, we have

$$
L(\tau) \geq \int_{|y| \leq 1}|y|^{-k} \phi(y) d y=L(1) \geq \frac{\omega_{N}}{(N-k) 2^{\frac{N+\beta}{2}}}
$$

whereupon

$$
\varepsilon \frac{\omega_{N}}{(N-k) 2^{\frac{N+\beta}{2}}} \leq C_{0} A_{0} \lambda_{1}^{\frac{p-2}{p-1}} \tau^{\alpha\left[\frac{k}{\beta}-\frac{1}{p-1}\right]}, \quad \text { for all } 0<\tau<\min \{1, T\}
$$

i.e.

$$
\varepsilon \leq(N-k) \omega_{N}^{-1} 2^{\frac{N+\beta}{2}} C_{0} A_{0} \lambda_{1}^{\frac{p-2}{p-1}} \tau^{\alpha\left[\frac{k}{\beta}-\frac{1}{p-1}\right]}, \quad \text { for all } 0<\tau<\min \{1, T\}
$$

As $\beta /(p-1)<k$, we have $k / \beta-1 /(p-1)>0$. Therefore, taking $\tau \rightarrow 0^{+}$, we obtain $\varepsilon=0$; contradiction. This completes the proof.

## 7 Theorem 5. Nonexistence of local $L^{1}$-weak solution in the case $p>p_{F}$

Theorem 5 (Non-existence of local $L^{1}$-weak solution in the supercritical case).
Let $0<\alpha<1,0<\beta<2, N \geq 1, \varepsilon>0$, and $p>1+\beta / N=p_{F}$. Assume $u_{0} \in L^{1}\left(\mathbb{R}^{N}\right)$ and satisfying (32) with $\beta /(p-1)<k<N$. Then there is no local $L^{1}$-weak solution of (1).

Proof. Suppose that there exists an $L^{1}$-weak solution $u$ on $[0, T)$ for some $0<T<\bar{T}_{w}(\varepsilon)$. Applying the proof of Theorem4, step by step. The only difference is the condition $k<N$ instead of $k<N / 2-s$, which is required to ensure that there exists an $L^{1}$-function $u_{0}$ satisfying (32).

## 8 Theorem 6. Nonexistence of global $L^{2}$-weak solution: New approach

Theorem 6 (Nonexistence for global $L^{2}$-weak solution: New approach).
Let $0<\alpha<1,0<\beta<2, N \geq 1, p>1, T>0$, and

$$
X(T)=C\left([0, T), L^{2}\left(\mathbb{R}^{N}\right)\right) \cap C^{1}\left([0, T), H^{-\frac{\beta}{2}}\left(\mathbb{R}^{N}\right)\right) \cap L^{\infty}\left((0, T), L^{p}\left(\mathbb{R}^{N}\right)\right)
$$

Assume $u_{0} \in L^{2}\left(\mathbb{R}^{N}\right)$ and satisfies

$$
\begin{equation*}
M_{R}(0)>C_{N, p, \beta, \gamma} R^{N-\frac{\beta}{p-1}} \tag{38}
\end{equation*}
$$

for some $R>0$ and $\gamma \in \mathbb{C}$ satisfying $\operatorname{Re}(\gamma \lambda)>0$, where

$$
M_{R}(0)=\operatorname{Re}\left(i^{\alpha} \gamma \int_{\mathbb{R}^{N}} u(0, x) \phi_{R}(x) d x\right)
$$

with $\phi_{R}(x):=\phi(x / R), R>0,(\phi(x)$ is defined in Section 圆 with $q=N+\beta)$, and

$$
C_{N, p, \beta, \lambda, \gamma}^{p}=2 C_{1 / 2}(\operatorname{Re}(\gamma \lambda))^{-\frac{p}{p-1}}|\gamma|^{\frac{p^{2}}{p-1}} A_{0}^{p}\left(C_{N, N+\beta}\right)^{\frac{p}{p-1}}
$$

Then there is no distributional solution $u \in X(T)$, with $T>T_{b}$, for (1), where (see (13))

$$
\begin{equation*}
T_{b} \sim\left(\frac{R^{N(p-1)} \Gamma(1+\alpha)}{D_{N, p, \beta, \lambda, \gamma}\left[M_{R}(0)-C_{N, p, \beta, \gamma} R^{N-\frac{\beta}{p-1}}\right]^{p-1}}\right)^{1 / \alpha} \tag{39}
\end{equation*}
$$

and

$$
D_{N, p, \beta, \lambda, \gamma}=2^{-1} \operatorname{Re}(\gamma \lambda)|\gamma|^{-p} A_{0}^{-(p-1)}
$$

Proof. Suppose, on the contrary, that there exists a distributional solution $u \in X(T)$ with $T>T_{b}$. Let

By Lemmas 5and 6. we have

& =\operatorname{Re}(\gamma \lambda) \int_{\mathbb{R}^{N}}|u(t, x)|^{p} \phi_{R}(x) d x+R^{-\beta} \operatorname{Re}\left(\gamma \int_{\mathbb{R}^{N}} u(t, x)\left((-\Delta)^{\beta / 2} \phi\right)(x / R) d x\right) \\
& \geq \operatorname{Re}(\gamma \lambda) \int_{\mathbb{R}^{N}}|u(t, x)|^{p} \phi(x / R) d x-C_{N, N+\beta} R^{-\beta}|\gamma| \int_{\mathbb{R}^{N}}|u(t, x)| \phi(x / R) d x \tag{40}
\end{align*}
$$

In order to get a differential inequality, we start by estimating the second term in the right hand side of
(40). Using $1 / 2$-Young's inequality (20), we obtain

& =\int_{\mathbb{R}^{N}}|u(t, x)|[\operatorname{Re}(\gamma \lambda) \phi(x / R)]^{1 / p} C_{N, N+\beta} R^{-\beta}|\gamma|[\operatorname{Re}(\gamma \lambda)]^{-1 / p}[\phi(x / R)]^{(p-1) / p} d x \\
& \leq \frac{1}{2} \operatorname{Re}(\gamma \lambda) \int_{\mathbb{R}^{N}}|u(t, x)|^{p} \phi(x / R) d x \\
& \quad+C_{1 / 2}|\gamma|^{\frac{p}{p-1}}\left(C_{N, N+\beta}\right)^{\frac{p}{p-1}} R^{-\frac{\beta p}{p-1}}(\operatorname{Re}(\gamma \lambda))^{-\frac{1}{p-1}} \int_{\mathbb{R}^{N}} \phi(x / R) d x \\
& =\frac{1}{2} \operatorname{Re}(\gamma \lambda) \int_{\mathbb{R}^{N}}|u(t, x)|^{p} \phi(x / R) d x \\
& \quad+C_{1 / 2} A_{0}|\gamma|^{\frac{p}{p-1}}(\operatorname{Re}(\gamma \lambda))^{-\frac{1}{p-1}}\left(C_{N, N+\beta}\right)^{\frac{p}{p-1}} R^{N-\frac{\beta p}{p-1}}, \tag{41}
\end{align*}
$$

where

C_{1 / 2}=(p-1) p^{-\frac{p}{p-1}} 2^{\frac{1}{p-1}} \quad \text { and } \quad A_{0}=\int_{\mathbb{R}^{N}} \phi(\tilde{x}) d \tilde{x}

On the other hand, by estimating the first term in the right hand side of (40) by using Hölder's inequality, we get

& =|\gamma| \int_{\mathbb{R}^{N}}|u(t, x)|(\phi(x / R))^{\frac{1}{p}}(\phi(x / R))^{\frac{p-1}{p}} d x \\
& \leq|\gamma|\left(\int_{\mathbb{R}^{N}}|u(t, x)|^{p} \phi(x / R) d x\right)^{\frac{1}{p}}\left(\int_{\mathbb{R}^{N}} \phi(x / R) d x\right)^{\frac{p-1}{p}} \\
& =|\gamma| A_{0}^{\frac{p-1}{p}} R^{\frac{N(p-1)}{p}}\left(\int_{\mathbb{R}^{N}}|u(t, x)|^{p} \phi(x / R) d x\right)^{\frac{1}{p}},
\end{aligned}
$$

i.e.

\begin{equation*}
\int_{\mathbb{R}^{N}}|u(t, x)|^{p} \phi(x / R) d x \geq|\gamma|^{-p} A_{0}^{-(p-1)} R^{-N(p-1)}\left|M_{R}(t)\right|^{p} \tag{42}
\end{equation*}
$$

Inserting (41)-(42) into (40), we conclude that

{ }^{c} D_{t \mid T}^{\alpha} M_{R}(t) \geq & 2^{-1} \operatorname{Re}(\gamma \lambda) \int_{\mathbb{R}^{N}}|u(t, x)|^{p} \phi(x / R) d x \\
& -C_{1 / 2} A_{0}|\gamma|^{\frac{p}{p-1}}(\operatorname{Re}(\gamma \lambda))^{-\frac{1}{p-1}}\left(C_{N, N+\beta}\right)^{\frac{p}{p-1}} R^{N-\frac{\beta p}{p-1}} \\
\geq & 2^{-1} \operatorname{Re}(\gamma \lambda)|\gamma|^{-p} A_{0}^{-(p-1)} R^{-N(p-1)}\left|M_{R}(t)\right|^{p} \\
& -C_{1 / 2} A_{0}|\gamma|^{\frac{p}{p-1}}(\operatorname{Re}(\gamma \lambda))^{-\frac{1}{p-1}}\left(C_{N, N+\beta}\right)^{\frac{p}{p-1}} R^{N-\frac{\beta p}{p-1}} \\
= & 2^{-1} \operatorname{Re}(\gamma \lambda)|\gamma|^{-p} A_{0}^{-(p-1)} R^{-N(p-1)}\left[\left|M_{R}(t)\right|^{p}-C_{N, p, \beta, \lambda, \gamma}^{p} R^{p\left(N-\frac{\beta}{p-1}\right)}\right]
\end{aligned}
$$

i.e.

$$
\begin{equation*}
{ }^{c} D_{t \mid T}^{\alpha} M_{R}(t) \geq D_{N, p, \beta, \lambda, \gamma} R^{-N(p-1)}\left[\left|M_{R}(t)\right|^{p}-C_{N, p, \beta, \gamma}^{p} R^{p\left(N-\frac{\beta}{p-1}\right)}\right] \tag{43}
\end{equation*}
$$

Applying Lemma 4 and using (38), we conclude that

M_{R}(t) \geq C_{N, p, \beta, \gamma} R^{N-\frac{\beta}{p-1}}>0, \quad \text { for all } t \in[0, T) \tag{44}
\end{equation*}
$$

which implies, by using (43) and the following elementary inequality

Apply Proposition 1 and the fact that ${ }^{c} D_{t \mid T}^{\alpha} C=0$, for any constant $C>0$, we infer that

$$

Since

we get a contradiction, and this completes the proof.
Remark 5. Note that, from (14), we have $H(p, \alpha)=\max \left(p-1,2^{-\frac{p \alpha}{p-1}}\right) \geq p-1$; this implies that $T_{b}$ can be chosen as

which is the same blow-up time as in the ordinary differential equation when $\alpha=1$.
Corollary 1 (Theorem 1: New approach).
Let $0<\alpha<1,0<\beta<2, N \geq 1, \gamma \in \mathbb{C}, \varepsilon=1, p>1$. Assume that $p<1+\beta / N$, and $u_{0} \in L^{1}\left(\mathbb{R}^{N}\right) \cap L^{2}\left(\mathbb{R}^{N}\right)$ satisfies

$$
\begin{equation*}
\operatorname{Re}(\gamma \lambda)>0 \quad \text { and } \quad \operatorname{Re}\left(i^{\alpha} \gamma \int_{\mathbb{R}^{N}} u_{0}(x) d x\right)>0 \tag{46}
\end{equation*}
$$

Then there is no distributional solution $u \in X(T)$ to (11) for sufficiently large $T>0$.
Proof. By (46), using the dominated convergence theorem, we conclude that

Therefore, there exists $R_{0}>0$ such that condition (38) is satisfied. Using Theorem6 the proof is completed.

Remark 6. Note that, by taking $\gamma= \pm 1, \pm i$ in Corollary 1, condition (46) implies (16), which means that (46) is more general that (16). Therefore, in the subcritical case, Theorem 1 can be seen as a particular case of Corollary 1, but with different regularity.
Corollary 2 (Theorem 2 : New approach).
Let $0<\alpha<1,0<\beta<2, N \geq 1, \varepsilon>0, \gamma \in \mathbb{C}$, and $p>1$. Assume that $p<1+2 \beta / N$, and $u_{0} \in H^{s}\left(\mathbb{R}^{N}\right)$, $s \geq 0$, satisfies

\operatorname{Re}(\gamma \lambda)>0 \quad \text { and } \quad \operatorname{Re}\left(i^{\alpha} \gamma u_{0}(x)\right) \geq \begin{cases}|x|^{-k}, & \text { if }|x|>1  \tag{47}\\ 0, & \text { if }|x| \leq 1\end{cases}
$$

where $N / 2<k<\frac{\beta}{p-1}$. Then, there exists a constant $\varepsilon_{2}>0$ such that for all $\varepsilon \in\left(0, \varepsilon_{2}\right]$, there is no distributional solution $u \in X(T)$ to (1) for sufficiently large $T>T_{b}$ with $T_{b}$ defined in (39). Moreover $T_{b}$ can be estimated as follows

for all $\varepsilon \in\left(0, \varepsilon_{2}\right]$, where $\kappa_{1}=\frac{1}{p-1}-\frac{\min (N, k)}{\beta}>0$,

B_{1}=(p-1)^{-1 / \alpha} D_{N, p, \beta, \lambda, \gamma}^{-1 / \alpha} \Gamma(1+\alpha)^{1 / \alpha} 2^{\frac{1}{\alpha \kappa_{1}}}\left(C_{N, p, \beta, \gamma}\right)^{\frac{\min (N, k)(p-1)}{\alpha \beta \kappa_{1}}} I_{1}^{-\frac{1}{\alpha \kappa_{1}}},
$$

and

$$
I_{1}:= \begin{cases}2^{-N-\beta-1} \omega_{N}(N-k)^{-1} R^{N-k}, & \text { if } k<N \\ 2^{-N-\beta} \omega_{N} \int_{1}^{2} r^{N-1-k} d r, & \text { if } k \geq N\end{cases}
$$

Proof. In order to apply Theorem 6, we need to estimate $M_{R}(0)$ from below, for some $R>0$. Let

\varepsilon_{2}= \begin{cases}I_{1}^{-1} C_{N, p, \beta, \gamma} 2^{1-\frac{\beta \kappa_{1}}{N-k}}, & \text { if } k<N \\ I_{1}^{-1} C_{N, p, \beta, \gamma} 2^{1-\beta \kappa_{1}}, & \text { if } k \geq N\end{cases}
$$

Let $\varepsilon \in\left(0, \varepsilon_{2}\right]$. We choose $R=R(\varepsilon)$ such that

\begin{cases}R \geq 2^{1 /(N-k)}, & \text { if } k<N  \tag{49}\\ R \geq 2, & \text { if } k \geq N\end{cases}

Then, as $R^{N-k}-1 \geq R^{N-k} / 2$, when $k<N$, using (47), we have

& \geq \varepsilon 2^{-N-\beta} \int_{1 \leq|x| \leq R}|x|^{-k} d x \\
& =\varepsilon 2^{-N-\beta} \omega_{N} \int_{1}^{R} r^{N-1-k} d r \\
& \geq \varepsilon 2^{-N-\beta} \omega_{N} \begin{cases}(N-k)^{-1}\left(R^{N-k}-1\right), \quad \text { if } k<N \\
& \geq \varepsilon I_{1} R^{(N-k)_{+}}, \\
\int_{1}^{N-1-k} d r, & \text { if } k \geq N\end{cases}
\end{array}
$$

with $(N-k)_{+}=\max (N-k, 0)$. Therefore

M_{R}(0)-C_{N, p, \beta, \gamma} R^{N-\frac{\beta}{p-1}} \geq R^{(N-k)_{+}}\left(\varepsilon I_{1}-C_{N, p, \beta, \gamma} R^{-\beta \kappa_{1}}\right)=R^{(N-k)_{+}}\left(\frac{\varepsilon I_{1}}{2}\right)>0 \tag{50}
\end{equation*}
$$

where $R$ is chosen to ensure the last equality, namely

$$
\begin{equation*}
R=\left(\frac{2 C_{N, p, \beta, \gamma}}{\varepsilon I_{1}}\right)^{\frac{1}{\beta \kappa_{1}}} \tag{51}
\end{equation*}
$$

It is clear, by our choice of $\varepsilon_{2}$, that condition (49) is satisfied. Applying Theorem 6, we conclude that there is no solution $u \in X(T)$ to (11) for all $T>T_{b}$. Moreover, from (13),(39) and the fact that $H(p, \alpha) \geq p-1$, we obtain

$$
T_{b} \leq T_{U} \leq(p-1)^{-1 / \alpha}\left(\frac{R^{N(p-1)} \Gamma(1+\alpha)}{D_{N, p, \beta, \lambda, \gamma}\left[M_{R}(0)-C_{N, p, \beta, \gamma} R^{N-\frac{\beta}{p-1}}\right]^{p-1}}\right)^{1 / \alpha}
$$

Then, using (50) and (51), we conclude that

$$
T_{b} \leq B_{1} \varepsilon^{-\frac{1}{\alpha \kappa_{1}}}
$$

This complete the proof.
Remark 7. Note that, $\kappa_{1}>\kappa_{0}$, this means that (27) is better than (48). Moreover, by taking $\gamma= \pm 1, \pm i$ in Corollary [2, condition (47) implies (26), which means that (47) is more general that (26). Therefore, Theorem $\mathbf{Q}^{2}$ can be seen as a particular case of Corollary $\mathbf{2}_{2}$, but with different regularity.
Corollary 3 (Theorem 3: New approach).
Let $0<\alpha<1,0<\beta<2, N \geq 1, \varepsilon>0, \gamma \in \mathbb{C}$, and $p>1$. Assume that $u_{0} \in H^{s}\left(\mathbb{R}^{N}\right)$, $s \geq 0$, satisfies

$$
\operatorname{Re}(\gamma \lambda)>0 \quad \text { and } \quad \operatorname{Re}\left(i^{\alpha} \gamma u_{0}(x)\right) \geq \begin{cases}|x|^{-k}, & \text { if }|x| \leq 1  \tag{52}\\ 0, & \text { if }|x|>1\end{cases}
$$

where $k<\min \left\{\frac{N}{2}-s, \frac{\beta}{p-1}\right\}$. Then, there exists a constant $\varepsilon_{3}>0$ such that for any $\varepsilon \geq \varepsilon_{3}$, there is no distributional solution $u \in X(T)$ to (1) for sufficiently large $T>T_{b}$ with $T_{b}$ is defined in (39). Moreover $T_{b}$ can be estimated as follows

$$
\begin{equation*}
T_{b} \leq B_{2} \varepsilon^{-\frac{1}{\alpha \kappa_{0}}} \tag{53}
\end{equation*}
$$

for all $\varepsilon \geq \varepsilon_{3}$, where $\kappa_{0}=\frac{1}{p-1}-\frac{k}{\beta}>0$,

$$
B_{2}=(p-1)^{-1 / \alpha} D_{N, p, \beta, \lambda, \gamma}^{-1 / \alpha} \Gamma(1+\alpha)^{1 / \alpha} 2^{\frac{1}{\alpha \kappa_{0}}}\left(C_{N, p, \beta, \gamma}\right)^{\frac{k(p-1)}{\alpha \beta \kappa_{0}}} I_{2}^{-\frac{1}{\alpha \kappa_{2}}},
$$

and

$$
I_{2}:=2^{-N-\beta} \omega_{N}(N-k)^{-1}
$$

Proof. In order to apply Theorem 6, we need to estimate $M_{R}(0)$ from below, for some $R>0$. Let

$$
\varepsilon_{3}=2 I_{2}^{-1} C_{N, p, \beta, \gamma}
$$

Let $\varepsilon \geq \varepsilon_{3}$. We choose $R=R(\varepsilon) \leq 1$. Then, using (52), we have

$$
\begin{aligned}
M_{R}(0) & \geq \varepsilon \operatorname{Re}\left(\gamma i^{\alpha} \int_{\mathbb{R}^{N}} u_{0}(x) \phi(x / R) d x\right) \\
& \geq \varepsilon \int_{|x| \leq 1}|x|^{-k} \phi(x / R) d x \\
& \geq \varepsilon \int_{|x| \leq R}|x|^{-k} \phi(x / R) d x \\
& \geq \varepsilon 2^{-N-\beta} \int_{|x| \leq R}|x|^{-k} d x \\
& =\varepsilon 2^{-N-\beta} \omega_{N} \int_{0}^{R} r^{N-1-k} d r \\
& =\varepsilon 2^{-N-\beta} \omega_{N}(N-k)^{-1} R^{N-k} \\
& =\varepsilon I_{2} R^{N-k} .
\end{aligned}
$$

Therefore

$$
\begin{equation*}
M_{R}(0)-C_{N, p, \beta, \gamma} R^{N-\frac{\beta}{p-1}} \geq R^{N-k}\left(\varepsilon I_{2}-C_{N, p, \beta, \gamma} R^{-\beta \kappa_{0}}\right)=R^{N-k}\left(\frac{\varepsilon I_{2}}{2}\right)>0 \tag{54}
\end{equation*}
$$

where

$$
\begin{equation*}
R=\left(\frac{2 C_{N, p, \beta, \gamma}}{\varepsilon I_{2}}\right)^{\frac{1}{\beta \kappa_{0}}} \tag{55}
\end{equation*}
$$

It is clear, by our choice of $\varepsilon_{3}$, that $R \leq 1$. Applying Theorem 6, we conclude that there is no solution $u \in X(T)$ of (11) for all $T>T_{b}$. Moreover, from (13), (39) and $H(p, \alpha) \geq p-1$, we obtain

$$
T_{b} \leq T_{U} \leq(p-1)^{-1 / \alpha}\left(\frac{R^{N(p-1)} \Gamma(1+\alpha)}{D_{N, p, \beta, \lambda, \gamma}\left[M_{R}(0)-C_{N, p, \beta, \gamma} R^{N-\frac{\beta}{p-1}}\right]^{p-1}}\right)^{1 / \alpha}
$$

Then, using (54) and (55), we conclude that

$$
T_{b} \leq B_{2} \varepsilon^{-\frac{1}{\alpha \kappa_{0}}}
$$

This complete the proof.
Remark 8. Note that, by taking $\gamma= \pm 1, \pm i$ in Corollary 3, condition (52) implies (32), which means that (52) is more general that (32). Therefore, Theorem 3 can be seen as a particular case of Corollary 3, but with different regularity.
