# EXPONENTIAL DECAY OF RANDOM CORRELATIONS FOR RANDOM ANOSOV SYSTEMS MIXING ON FIBERS

#### Abstract

In this paper, we study the statistical property of Anosov systems on surface driven by an external force. By utilizing the Birkhoff cone method, we show that if the systems on surface satisfying the Anosov and topological mixing on fibers property, then the quenched random correlation for Hölder observables with respect to the unique random SRB measures decays exponentially.

## 1. Introduction

In this paper, we investigate the decay rate of quenched random correlation for Anosov system on surface driven by an external force with respect to the random SRB measure. Let $M$ be a surface, by which we mean a connected closed smooth 2-dimensional Riemannian manifold. Let $\theta: \Omega \rightarrow \Omega$ be a homeomorphism on a compact metric space $\left(\Omega, d_{\Omega}\right)$, which will describe the external force. A dynamical system driven by $(\Omega, \theta)$ is a mapping

$$
F: \mathbb{Z} \times \Omega \times M \rightarrow M,(n, \omega, x) \mapsto F(n, \omega, x)
$$

satisfying for each $n \in \mathbb{Z},(\omega, x) \mapsto F(n, \omega, x)$ is continuous and the mappings $F(n, \omega):=F(n, \omega, \cdot)$ : $M \rightarrow M$ form a cocycle over $\theta$, i.e.,

$$
\begin{aligned}
F(0, \omega) & =i d_{M} \text { for all } \omega \in \Omega, \\
F(n+m, \omega) & =F\left(n, \theta^{m} \omega\right) \circ F(m, \omega) \text { for all } n, m \in \mathbb{Z}, \omega \in \Omega .
\end{aligned}
$$

When $(\Omega, \mathcal{B}(\Omega))$ is equipped with a $\theta$-invariant probability measure $\mathbb{P}, F$ is a continuous random dynamical system (abbr. RDS) [4]. We denote $f_{\omega}$ by the time-one map $F(1, \omega)$ of the RDS, and assume $f_{\omega}$ to be a diffeomorphism for all $\omega \in \Omega$. Putting $f_{\omega}$ and $\theta$ together forms a skew product transformation $\phi: M \times \Omega \rightarrow M \times \Omega$ by $\phi(x, \omega)=\left(f_{\omega}(x), \theta \omega\right)$. The skew product system $\phi$ is called Anosov on fibers if for every $(x, \omega) \in M \times \Omega$, there is a splitting of the tangent bundle of $M$ at $x$

$$
T_{x} M=E^{s}(x, \omega) \oplus E^{u}(x, \omega)
$$

which depends continuously on $(x, \omega) \in M \times \Omega$ with $\operatorname{dim} E^{s}(x, \omega)=\operatorname{dim} E^{u}(x, \omega)=1$, and the splitting is invariant in the sense that

$$
D_{x} f_{\omega} E^{u}(x, \omega)=E^{u}\left(f_{\omega}(x), \theta \omega\right), \quad D_{x} f_{\omega} E^{s}(x, \omega)=E^{s}\left(f_{\omega}(x), \theta \omega\right),
$$

and

$$
\begin{cases}\left|D_{x} f_{\omega} \xi\right| \geq e^{\lambda_{0}}|\xi|, & \forall \xi \in E^{u}(x, \omega), \\ \left|D_{x} f_{\omega} \eta\right| \leq e^{-\lambda_{0}}|\eta|, & \forall \eta \in E^{s}(x, \omega),\end{cases}
$$

where $\lambda_{0}>0$ is a constant. We assume that $\phi$ is topological mixing on fibers, that is, for any nonempty open sets $U, V \subset M$, there exists $N>0$ such that for any $n \geq N$ and $\omega \in \Omega, \phi^{n}(U \times$ $\{\omega\}) \cap\left(V \times\left\{\theta^{n} \omega\right\}\right) \neq \emptyset$.

A random probability measure $\omega \mapsto \mu_{\omega}$ on $M$ is a measurable map $\mu: \Omega \rightarrow \operatorname{Pr}(M)$, where $\operatorname{Pr}(M)$ is the space of Borel probability measures on $M$ equipped with the Borel $\sigma$-algebra generated by the weak ${ }^{*}$ topology. A random probability measure $\omega \mapsto \mu_{\omega}$ is said to be $\phi$-invariant if $\left(f_{\omega}\right)_{*} \mu_{\omega}=\mu_{\theta \omega}$ for $\mathbb{P}$-a.s. $\omega \in \Omega$. Given a pair of regular observables $\varphi$ and $\psi$ on $M$, we say the (quenched) past random correlation function of $\varphi$ and $\psi$ with respect to the system $\phi$ and an invariant random probability measure $\left(\mu_{\omega}\right)_{\omega \in \Omega}$ decays exponentially if

$$
\left|\int_{M} \psi\left(F\left(n, \theta^{-n} \omega, x\right)\right) \varphi(x) d \mu_{\theta^{-n} \omega}-\int_{M} \psi(x) d \mu_{\omega} \int_{M} \varphi(x) d \mu_{\theta^{-n} \omega}\right| \rightarrow 0
$$

exponentially as $n \rightarrow \infty$. We say that the (quenched) future random correlation function of $\varphi$ and $\psi$ decays exponentially if

$$
\left|\int_{M} \psi(F(n, \omega, x)) \varphi(x) d \mu_{\omega}-\int_{M} \psi(x) d \mu_{\theta^{n} \omega} \int_{M} \varphi(x) d \mu_{\omega}\right| \rightarrow 0
$$

exponentially as $n \rightarrow \infty$. If $\phi$ is Anosov and topological mixing on fibers, then $\phi$ is a random topological transitive hyperbolic systems [22], so there exists a unique random SRB measure and the unique random SRB measure is given by $\mu_{\omega}:=\lim _{n \rightarrow \infty}\left(f_{\theta^{-n_{\omega}}}^{n}\right)_{*} m$, where $m$ is the normalized Riemannian volume measure [20]. In this paper, we prove that such system $\phi$ and the unique
random SRB measure have exponential decay of both past and future random correlations for Hölder observables $\psi$ and $\varphi$. We emphasis that our result holds for all $\omega \in \Omega$, while most result of decay of quenched random correlation only holds for $\mathbb{P}$-a.s. $\omega \in \Omega$.

Recently, Anosov on fibers systems with the topological mixing on fibers property have been studied in [22] from the topological complexity perspective, in which the authors proved dynamical complexity such as the density of random periodic points, strong random horseshoe, the density of measure equi-distributed on a random periodic orbit, and a simplified random Livšic theorem. Examples such as fiber Anosov maps on 2-dimension torus driven by irrational rotation on the torus and random composition of $2 \times 2$ area-preserving positive matrices are under consideration. Moreover, the Anosov on fibers systems contain a class of partially hyperbolic systems. In fact, let $\Omega$ be a compact differentiable manifold, and let $\theta: \Omega \rightarrow \Omega$ be a diffeomorphism such that the expansion of $D \theta$ is weaker than $e^{\lambda_{0}}$ and contraction of $D \theta$ is weaker than $e^{-\lambda_{0}}$. Furthermore, we assume $f_{\omega}(x)$ and $f_{\omega}^{-1}(x)$ are $C^{1}$ in $\omega$. Then the system $\phi$ is a partially hyperbolic system, and the dimension of central direction coincides with $\operatorname{dim} \Omega$ (see Proposition A. 1 in Appendix).

For deterministic dynamical systems, there are a large number of results considering the exponential decay of correlations, for instance [ $2,9,12-14,18,19,26,30,32,35,40,42,43]$. For RDS, the exponential decay of (quenched) random correlations was obtained for random Lasota-Yorke maps on intervals [10], for random perturbations of expanding maps [8], for i.i.d unimodal maps [7] and for a class of non-uniformly expanding random dynamical systems [38]. In [25], the topological onesided random shift of finite type with the fiber Gibbs measure was proved to have certain nonuniform $\omega$-wise decay of correlations, and similar results held for random expanding in average transformations. Note that the system in this paper belongs to random hyperbolic system and it is randomly conjugated to a two-sided random shift [20]. Recently, the authors in [1] obtain the exponential decay of quenched future random correlations for random perturbation of topological mixing uniformly hyperbolic system and a family of equivariant physical measure. We note that our results are independent, since our main example can not be obtained by perturbation, and it is unknown whether the family of equivariant physical measure coincides the random SRB measure. Other decay rates of random correlations such as stretched exponential and polynomial decay were also considered for certain random dynamical systems $[1,5,27,36]$.

In this paper, we prove the exponential decay of (quenched) random correlations for Anosov and topological mixing on fibers system by directly studying the fiber transfer operator $L_{\omega}$, which is defined by

$$
\begin{equation*}
L_{\omega} \varphi: M \rightarrow \mathbb{R},\left(L_{\omega} \varphi\right)(x):=\frac{\varphi\left(\left(f_{\omega}\right)^{-1} x\right)}{\left|\operatorname{det} D_{\left(f_{\omega}\right)^{-1}(x)} f_{\omega}\right|} \tag{1.1}
\end{equation*}
$$

for any measurable observables $\varphi: M \rightarrow \mathbb{R}$. We construct a Birkhoff cone on each fiber and introduce the projective metric on each fiber Birkhoff cone. The construction of the Birkhoff cone on each fiber is inspired by the construction in [30] and [39]. The most technical analysis in this paper lies in estimating the diameter of the image of $L_{\omega}^{N}=L_{\theta^{N-1} \omega} \circ \cdots \circ L_{\omega}$ on fiber Birkhoff cone, where $N$ comes from the mixing on fibers property. We prove that the image of $L_{\omega}^{N}$ acting on the $\omega$-fiber Birkhoff cone has finite diameter with respect to the projective metric on $\theta^{N} \omega$-fiber Birkhoff cone. Moreover, this diameter is uniformly finite for all $\omega \in \Omega$. As a consequence of Birkhoff's inequality, $L_{\omega}^{N}$ is a contraction and the contraction rate is independent of $\omega \in \Omega$. The contraction implies weak*limit of $\left(L_{\theta^{-n} \omega}^{n} 1\right) d m$ exists and it gives the unique random SRB measure, where $m$ is the normalized Riemannian volume measure. The exponential decay of random correlations can be obtained from the contraction and the usual techniques in deterministic systems.

The Birkhoff cone approach has been used extensively to study the transfer operator and exponential decay of correlations. Liverani in [30] used it to prove the exponential decay of correlations for smooth uniformly hyperbolic area-preserving cases. Later, it was generalized to general Axiom A attractors in [6,39], and some partially hyperbolic systems [3,11]. For RDS, the Birkhoff cone approach was used in [8] and [38] for exponential decay of (quenched) random correlations.

This paper is organized as follows. In Section 2, we state the settings and formulate the main result. In Section 3, we introduce several preliminary lemmas and propositions to pave the way for the proof of the main result. Section 4 addresses the proof of the main result based on the Birkhoff cone. We recall the definitions of convex cone, projective metric and Birkhoff's inequality in the Appendix.

## 2. Setting and Main Result

In this section, we begin with the setting of Anosov and mixing on fibers systems. After introducing several necessary notations, we formulate the main result.
2.1. Anosov and mixing on fibers systems. Let $M$ be a connected closed smooth Riemannian manifold with $\operatorname{dim} M=2$, and $d_{M}$ be the induced Riemannian metric on $M,\left(\Omega, d_{\Omega}\right)$ be a compact metric space, and $\theta: \Omega \rightarrow \Omega$ be a homeomorphism. Let $\mathbb{P}$ be an ergodic Borel probability measure on $\Omega$. $M \times \Omega$ is a compact metric space with distance $d\left(\left(x_{1}, \omega_{1}\right),\left(x_{2}, \omega_{2}\right)\right)=d_{M}\left(x_{1}, x_{2}\right)+d_{\Omega}\left(\omega_{1}, \omega_{2}\right)$ for any $x_{1}, x_{2} \in M$ and $\omega_{1}, \omega_{2} \in \Omega$. Let $\operatorname{Diff}^{2}(M)$ be the space of $C^{2}$ diffeomorphisms on $M$ with $C^{2}$-topology (see, e.g., [21]), and $f: \Omega \rightarrow \operatorname{Diff}^{2}(M)$ be a continuous map. The skew product $\phi: M \times \Omega \rightarrow M \times \Omega$ induced by $f$ and $\theta$ is defined by:

$$
\phi(x, \omega)=(f(\omega) x, \theta \omega)=\left(f_{\omega} x, \theta \omega\right), \forall \omega \in \Omega, x \in M .
$$

where we rewrite $f(\omega)$ as $f_{\omega}$. Then inductively:

$$
\phi^{n}(x, \omega)=\left(f_{\omega}^{n} x, \theta^{n} \omega\right):= \begin{cases}\left(f_{\theta^{n-1} \omega} \circ \cdots \circ f_{\omega} x, \theta^{n} \omega\right), & \text { if } n>0  \tag{2.1}\\ (x, \omega), & \text { if } n=0 \\ \left(\left(f_{\theta^{n} \omega}\right)^{-1} \circ \cdots \circ\left(f_{\theta^{-1} \omega}\right)^{-1} x, \theta^{n} \omega\right), & \text { if } n<0\end{cases}
$$

The system $\phi$ is called Anosov on fibers if the following is true: for every $(x, \omega) \in M \times \Omega$, there is a splitting of the tangent bundle of $M$ at $x$

$$
T_{x} M=E^{s}(x, \omega) \oplus E^{u}(x, \omega)
$$

which depends continuously on $(x, \omega) \in M \times \Omega$ with $\operatorname{dim} E^{s}(x, \omega)=\operatorname{dim} E^{u}(x, \omega)=1$ and satisfies that

$$
D_{x} f_{\omega} E^{u}(x, \omega)=E^{u}\left(f_{\omega}(x), \theta \omega\right), \quad D_{x} f_{\omega} E^{s}(x, \omega)=E^{s}\left(f_{\omega}(x), \theta \omega\right)
$$

and

$$
\begin{cases}\left|D_{x} f_{\omega} \xi\right| \geq e^{\lambda_{0}}|\xi|, & \forall \xi \in E^{u}(x, \omega) \\ \left|D_{x} f_{\omega} \eta\right| \leq e^{-\lambda_{0}}|\eta|, & \forall \eta \in E^{s}(x, \omega),\end{cases}
$$

where $\lambda_{0}>0$ is a constant. We say that $\phi: M \times \Omega \rightarrow M \times \Omega$ is topological mixing on fibers if for any nonempty open sets $U, V \subset M$, there exists $N>0$ such that for any $n \geq N$ and $\omega \in \Omega$

$$
\phi^{n}(U \times\{\omega\}) \cap V \times\left\{\theta^{n} \omega\right\} \neq \emptyset .
$$

Examples of Anosov and topological mixing on fibers systems are given in Appendix A.1.
2.2. Random probability measures. The following notations are borrowed from [15]. Denote $\operatorname{Pr}(M)$ to be the space of probability measures on $(M, \mathcal{B}(M))$ equipped with weak ${ }^{*}$ topology.

A map $\mu: \mathcal{B}(M) \times \Omega \rightarrow[0,1]$ by $(B, \omega) \mapsto \mu_{\omega}(B)$ is said to be a random probability measure on $M$ if it satisfies: for every $B \in \mathcal{B}(M), \omega \mapsto \mu_{\omega}(B)$ is measurable; and for $\mathbb{P}$-almost every $\omega \in \Omega$, $B \rightarrow \mu_{\omega}(B)$ is a Borel probability measure. By Remark 3.2 in [15], the second condition can be relaxed to: for every $D$ from a $\cap$-stable family $\mathfrak{F}$ of Borel sets of $M$ which generates $\mathcal{B}(M)$ (i.e. $\sigma(\mathfrak{F})=\mathcal{B}(M)), \omega \mapsto \mu_{\omega}(D)$ is measurable. A typical example of $\mathfrak{F}$ is the family of all closed sets in $M$. We denote a random probability measure by $\omega \mapsto \mu_{\omega}$ or $\left(\mu_{\omega}\right)_{\omega \in \Omega}$.

A random probability measure $\omega \mapsto \mu_{\omega}$ is said to be $\phi$-invariant if $\left(f_{\omega}\right)_{*} \mu_{\omega}=\mu_{\theta \omega}$ for $\mathbb{P}$-a.s. $\omega \in \Omega$.
2.3. Main result. Let $C^{0}(M)$ be the collection of all continuous functions $\varphi: M \rightarrow \mathbb{R}$. For $\alpha \in(0,1)$, and $\varphi \in C^{0}(M)$, denote

$$
\|\varphi\|_{C^{0}(M)}:=\sup _{x \in M}|\varphi(x)| \text { and }|\varphi|_{\alpha}:=\sup _{x, y \in M, x \neq y} \frac{|\varphi(x)-\varphi(y)|}{d(x, y)^{\alpha}} .
$$

We denote $C^{0, \alpha}(M):=\left\{\varphi \in C^{0}(M):|\varphi|_{\alpha}<\infty\right\}$ to be the space of $\alpha$-Hölder continuous functions on $M$. For $\varphi \in C^{0, \alpha}(M)$, we let

$$
\|\varphi\|_{C^{0, \alpha}(M)}:=\|\varphi\|_{C^{0}(M)}+|\varphi|_{\alpha} .
$$

Theorem 1. Assume that $\phi$ satisfies Anosov on fibers and topological mixing on fibers. Then
(1) there exists an invariant random probability measure $\omega \mapsto \mu_{\omega}$ given by $\mu_{\omega}=\lim _{n \rightarrow \infty}\left(f_{\theta^{-n} \omega}^{n}\right)_{*} m$ for all $\omega \in \Omega$, where $m$ is the normalized Riemannian volume measure,
(2) there exists a constant $\nu_{0}$ that only depends on the system $\phi$ such that, for Hölder exponents $\kappa, \nu \in(0,1)$ with

$$
0<\kappa+\nu<\nu_{0}
$$

and $\psi \in C^{0, \kappa}(M), \varphi \in C^{0, \nu}(M)$, the (quenched) past and future random correlation between $\varphi$ and $\psi$ exponential decay with respect to the random probability measure $\left(\mu_{\omega}\right)_{\omega \in \Omega}$ defined in (1), i.e. for any $n \in \mathbb{N}, \omega \in \Omega$,

$$
\begin{aligned}
& \left|\int_{M} \psi\left(f_{\theta^{-n} \omega}^{n} x\right) \varphi(x) d \mu_{\theta^{-n} \omega}-\int_{M} \psi(x) d \mu_{\omega} \int_{M} \varphi(x) d \mu_{\theta^{-n} \omega}\right| \leq K\|\psi\|_{C^{0, \kappa}(M)} \cdot\|\varphi\|_{C^{0, \nu}(M)} \cdot \Lambda^{n} ; \\
& \left|\int_{M} \psi\left(f_{\omega}^{n} x\right) \varphi(x) d \mu_{\omega}-\int_{M} \psi(x) d \mu_{\theta^{n} \omega} \int_{M} \varphi(x) d \mu_{\omega}\right| \leq K\|\psi\|_{C^{0, \kappa}(M)} \cdot\|\varphi\|_{C^{0, \nu}(M)} \cdot \Lambda^{n}
\end{aligned}
$$

where constants $K>1$ and $\Lambda \in(0,1)$ only depend on $\kappa, \nu$ and system $\phi$.
We note that topological mixing on fibers property implies random topological transitivity by [22, Lemma A.1]. Then according to [20, Theorem 4.3], the measure $\mu_{\omega}$ we constructed above is the unique random SRB measure (we state this lemma and this theorem in the Appendix).

## 3. Preliminary Lemmas and Propositions

In this section, we introduce several technical lemmas and propositions that will be used in the proof of the main result. Lemmas in Subsections 3.1 and 3.2 can be viewed as the combination of Lusin's theorem and corresponding results in general RDS [29] by noticing that our system $f_{\omega}$, $E^{s}(x, \omega)$ and $E^{u}(x, \omega)$ are continuous depending on $\omega$. We state and prove two distortion lemmas in

Subsection 3.3. We formulate and prove the absolute continuity and Hölder continuity of the stable and unstable foliations on each fiber in Subsection 3.4 and 3.5 respectively. We discuss properties of holonomy maps between local stable leaves in Subsection 3.6. In Subsection 3.7, we prove a version of Fubini's theorem on any rectangle on each fiber.
3.1. Hölder continuity of stable and unstable subbundle on each fiber. In this subsection, we will formulate the Hölder continuity of $E^{s}(x, \omega)$ and $E^{u}(x, \omega)$ on $x \in M$ for any $\omega \in \Omega$, which is borrowed from [29].

For nontrivial closed subspaces $A, B$ in a Hilbert space $H$ with given inner product and induced norm $|\cdot|$, define the aperture between $A$ and $B$ by

$$
\Gamma(A, B):=\max \left\{\sup _{v \in A,|v|=1} \inf _{w \in B}|v-w|, \sup _{w \in B,|w|=1} \inf _{v \in A}|v-w|\right\} .
$$

Then $\Gamma(A, B) \in[0,1]$. One also has $\Gamma(A, B)=\left\|P_{A}-P_{B}\right\|$, where $P_{A}$ and $P_{B}$ are the orthogonal projections on $A$ and $B$ respectively (see more details in [23, Chap. Four sec. 2]).

By the compactness of $M$, there exists a $\rho_{0}>0$ such that for any $x, y \in M$ with $d(x, y)<\rho_{0}$, there exists a unique geodesic connecting $x$ and $y$. For any $x, y \in M$, if $d(x, y)<\rho_{0}$, then there exists an isometry from $T_{x} M$ to $T_{y} M$ given by the parallel transport on the unique geodesic connecting $x$ and $y$, named $P(x, y)$. Then for any $x, y \in M, E(x) \subset T_{x} M, E(y) \subset T_{y} M$ subspaces, we can define

$$
d(E(x), E(y)):= \begin{cases}\Gamma_{x}(E(x), P(y, x) E(y)), & \text { if } d(x, y)<\rho_{0}  \tag{3.1}\\ 1, & \text { otherwise }\end{cases}
$$

where $\Gamma_{x}$ is the aperture between subspaces in $T_{x} M$ defined by the given Riemannian metric. The following lemma is an adapted version of Theorem 4.1 in [29] by noticing that $f_{\omega} \in \operatorname{Diff}^{2}(M)$ is continuously depending on $\omega \in \Omega$.

Lemma 3.1. There are constants $C_{1}>0$ and $\nu_{1} \in(0,1)$ such that for each $\omega \in \Omega, E^{s}(x, \omega)$ and $E^{u}(x, \omega)$ are $\left(C_{1}, \nu_{1}\right)$-Hölder continuous on $x$, i.e.,

$$
\begin{equation*}
d\left(E^{\tau}(x, \omega), E^{\tau}(y, \omega)\right) \leq C_{1} d(x, y)^{\nu_{1}}, \quad \tau=s, u . \tag{3.2}
\end{equation*}
$$

3.2. Stable and unstable invariant manifolds. We define the local stable and unstable manifolds as the following:

$$
\begin{aligned}
W_{\epsilon}^{s}(x, \omega) & =\left\{y \in M \mid d\left(\phi^{n}(y, \omega), \phi^{n}(x, \omega)\right) \leq \epsilon \text { for all } n \geq 0\right\}, \\
W_{\epsilon}^{u}(x, \omega) & =\left\{y \in M \mid d\left(\phi^{n}(y, \omega), \phi^{n}(x, \omega)\right) \leq \epsilon \text { for all } n \leq 0\right\} .
\end{aligned}
$$

The following lemma can be found in [22, Lemma 3.1], and it is a special version of [20, Theorem 3.1].

For $\tau=s, u$, denote $P\left(E^{\tau}(x, \omega)\right)$ to be the projection from $T_{x} M$ to $E^{\tau}(x, \omega)$ with respect to the splitting $T_{x} M=E^{s}(x, \omega) \oplus E^{u}(x, \omega)$. Since $E^{s}(x, \omega), E^{u}(x, \omega)$ are uniformly continuous on $x$ and $\omega$, there exists a number $\mathcal{P}>1$ such that

\sup \left\{\left\|P\left(E^{s}(x, \omega)\right)\right\|,\left\|P\left(E^{u}(x, \omega)\right)\right\|:(x, \omega) \in M \times \Omega\right\}<\mathcal{P} . \tag{3.3}
\end{equation*}
$$

Lemma 3.2 (Stable and unstable invariant manifolds). For any $\lambda \in\left(0, \lambda_{0}\right)$, there exists $\epsilon_{0}>0$ such that for any $\epsilon \in\left(0, \epsilon_{0}\right]$, the followings hold:
(1) $W_{\epsilon}^{\tau}(x, \omega)$ are $C^{2}$ embedded discs for all $(x, \omega) \in M \times \Omega$ with $T_{x} W^{\tau}(x, \omega)=E^{\tau}(x, \omega)$ for $\tau=u, s$. Moreover, there exist a constant $L>1$ and $C^{2}$ maps

$$
h_{(x, \omega)}^{u}: E^{u}(x, \omega)(\mathcal{P} \epsilon) \rightarrow E^{s}(x, \omega), h_{(x, \omega)}^{s}: E^{s}(x, \omega)(\mathcal{P} \epsilon) \rightarrow E^{u}(x, \omega)
$$

such that $W_{\epsilon}^{\tau}(x, \omega) \subset \operatorname{Exp}_{x}\left(\operatorname{graph}\left(h_{(x, \omega)}^{\tau}\right)\right)$ and $\left\|D h_{(x, \omega)}^{\tau}\right\|<\frac{1}{3}, \operatorname{Lip}\left(D h_{(x, \omega)}^{\tau}\right)<L$ for $\tau=$ $u, s$, where $E^{\tau}(x, \omega)(\mathcal{P} \epsilon)$ is the $\mathcal{P} \epsilon$-ball of $E^{\tau}(x, \omega)$ centered at origin for $\tau=u, s$.
(2) $d_{M}\left(f_{\omega}^{n} x, f_{\omega}^{n} y\right) \leq e^{-n \lambda} d_{M}(x, y)$ for $y \in W_{\epsilon}^{s}(x, \omega)$ and $n \geq 0$, and $d_{M}\left(f_{\omega}^{-n} x, f_{\omega}^{-n} y\right) \leq e^{-n \lambda} d_{M}(x, y)$ for $y \in W_{\epsilon}^{u}(x, \omega)$ and $n \geq 0$.
(3) $W_{\epsilon}^{s}(x, \omega), W_{\epsilon}^{u}(x, \omega)$ vary continuously on $(x, \omega)$ in $C^{1}$ topology.

The following lemma is about the local product structure on each fiber.
Lemma 3.3. [22, Lemma 3.2] For any $\epsilon \in\left(0, \epsilon_{0}\right)$, there is a $\delta \in(0, \epsilon)$ such that for any $x, y \in M$ with $d_{M}(x, y)<\delta, W_{\epsilon}^{s}(x, \omega) \cap W_{\epsilon}^{u}(y, \omega)$ consists of a single point, which is denoted by $[x, y]_{\omega}$. Furthermore

$$
[\cdot, \cdot]:\left\{(x, y, \omega) \in M \times M \times \Omega \mid d_{M}(x, y)<\delta\right\} \rightarrow M
$$

is continuous.
3.3. Two distortion lemmas. In this subsection, we state two distortion lemmas. The following Lemma is clear, and it is used for proving the absolutely continuity of stable and unstable foliations on each fiber.

Lemma 3.4. For any $x, y \in M, E(x, \omega) \in T_{x} M, E(y, \omega) \in T_{y} M$ with $\operatorname{dim} E(x, \omega)=E(y, \omega)$, we have

$$
\begin{align*}
\left\|\operatorname{det}\left(\left.D_{x} f_{\omega}\right|_{E(x, \omega)}\right)|-| \operatorname{det}\left(\left.D_{y} f_{\omega}\right|_{E(y, \omega)}\right)\right\| & \leq C_{2} d(x, y)+C_{2} d(E(x, \omega), E(y, \omega)),  \tag{3.4}\\
\left\|\operatorname{det}\left(\left.D_{x} f_{\omega}^{-1}\right|_{E(x, \omega)}\right)|-| \operatorname{det}\left(\left.D_{y} f_{\omega}^{-1}\right|_{E(y, \omega)}\right)\right\| & \leq C_{2} d(x, y)+C_{2} d(E(x, \omega), E(y, \omega)), \tag{3.5}
\end{align*}
$$

where $C_{2}>0$ is a constant depending on $\sup _{\omega \in \Omega}\left\|f_{\omega}\right\|_{C^{2}}$ and $\sup _{\omega \in \Omega}\left\|f_{\omega}^{-1}\right\|_{C^{2}}$.
Lemma 3.5 is used for the construction of the fiber convex cone of observables in Section 4, and its proof is parallel to the deterministic case, see [28, Lemma 3.2].
Lemma 3.5. $J^{s}(x, \omega)=\left|\operatorname{det}\left(\left.D_{x} f_{\omega}\right|_{E^{s}(x, \omega)}\right)\right|$ has a uniform Lipschitz variation on the local stable manifolds, i.e., there is a constant $K_{1}>0$ independent of $\omega$ such that for any $z \in M$, and $x, y \in$ $W_{\epsilon}^{s}(z, \omega)$,

$$
\left|J^{s}(x, \omega)-J^{s}(y, \omega)\right| \leq K_{1} d(x, y)
$$

and

$$
\left|\log J^{s}(x, \omega)-\log J^{s}(y, \omega)\right| \leq K_{1} d(x, y)
$$

Proof of Lemma 3.5. Since $M \times \Omega$ is a compact space and $f: \Omega \rightarrow \operatorname{Diff}^{2}(M)$ is continuous, $\left|D_{x} f_{\omega}\right|$ and $\left|D_{x}^{2} f_{\omega}\right|$ are uniformly bounded. Let $K \geq 1$ be a constant such that

$$
\max \left\{\sup _{(x, \omega) \in M \times \Omega}\left\|D_{x} f_{\omega}\right\|, \sup _{(x, \omega) \in M \times \Omega}\left\|D_{x}^{2} f_{\omega}\right\|, \operatorname{Lip}^{2} h_{(x, \omega)}^{s}\right\} \leq K
$$

Notice that if $y, z \in W_{\epsilon}^{s}(x, \omega)$, and $d(y, z)<\frac{\epsilon}{2 \mathcal{P} K^{2}}$, then

\left\|P\left(E^{s}(x, \omega)\right)\left(\operatorname{Exp}_{x}^{-1}(z)-\operatorname{Exp}_{x}^{-1}(y)\right)\right\| \leq \mathcal{P} d(y, z)<\frac{\epsilon}{2 K^{2}}
$$

$$
\left\|P\left(E^{s}\left(f_{\omega} y, \theta \omega\right)\right)\left(\operatorname{Exp}_{f_{\omega}(x)}^{-1}\left(f_{\omega}(z)\right)-\operatorname{Exp}_{f_{\omega}(x)}^{-1}\left(f_{\omega}(y)\right)\right)\right\| \leq \mathcal{P} K d(y, z) \leq \frac{\epsilon}{2 K}
$$

Therefore, $z \in W_{\epsilon}^{s}(y, \omega)$ and $f_{\omega}(z) \in W_{\epsilon}^{s}\left(f_{\omega}(y), \theta \omega\right)$. So it is sufficient to prove that there exists a constant $K_{1}>0$ independent of $x$ and $\omega$ such that for any $y \in W_{\frac{\sigma^{\prime}}{2 \mathcal{P} K^{2}}}^{s}(x, \omega)$,

\left|J^{s}(x, \omega)-J^{s}(y, \omega)\right| \leq K_{1} d(x, y) \tag{3.6}
\end{equation*}
$$

With the help of the normal coordinate chart, and notice that $d(x, y)<\epsilon<\rho_{0}$ and $d\left(f_{\omega} x, f_{\omega} y\right) \leq$ $\epsilon<\rho_{0}$, we may pretend that $x, y$ together with $W_{\frac{\epsilon}{2 \mathcal{P} K}}^{s}(x, \omega)$ lie in a same Euclidean space, and $f_{\omega} x$, $f_{\omega} y$ together with $W_{\epsilon}^{s}\left(f_{\omega} x, \theta \omega\right)$ lie in a same Euclidean space. By the invariant stable manifolds theorem, there exists $\xi_{y} \in E^{s}(x, \omega)\left(\frac{\epsilon}{2 K^{2}}\right)$ and $\xi_{f_{\omega}(y)} \in E^{u}\left(f_{\omega}(x), \theta \omega\right)(\epsilon)$ such that

$$
\begin{align*}
y & =x+\xi_{y}+h_{(x, \omega)}^{s}\left(\xi_{y}\right)  \tag{3.7}\\
f_{\omega}(y) & =f_{\omega}(x)+\xi_{f_{\omega}(y)}+h_{\left(f_{\omega}(x), \theta \omega\right)}^{s}\left(\xi_{f_{\omega}(y)}\right) \tag{3.8}
\end{align*}
$$

and $E^{s}(y, \omega)=\operatorname{graph}\left(\left(D h_{(x, \omega)}^{s}\right) \xi_{y}\right), E^{s}\left(f_{\omega}(y), \theta \omega\right)=\operatorname{graph}\left(\left(D h_{\left(f_{\omega}(x), \theta \omega\right)}^{s}\right) \xi_{f_{\omega}(y)}\right)$. From (3.7) and (3.8), we have

d(x, y)=\|x-y\|=\left\|\xi_{y}+h_{(x, \omega)}^{s}\left(\xi_{y}\right)\right\| \geq\left\|\xi_{y}\right\|-\frac{1}{3}\left\|\xi_{y}\right\|=\frac{2}{3}\left\|\xi_{y}\right\| \tag{3.9}
\end{equation*}
$$

and

$$
\left(1-\frac{1}{3}\right)\left\|\xi_{f_{\omega}(y)}\right\| \leq\left\|\xi_{f_{\omega}(y)}+h_{\left(f_{\omega}(x), \theta \omega\right)}^{s}\left(\xi_{f_{\omega}(y)}\right)\right\|=\left\|f_{\omega}(y)-f_{\omega}(x)\right\| \leq K\|y-x\| \leq K\left(1+\frac{1}{3}\right)\left\|\xi_{y}\right\|
$$

so $\left\|\xi_{f_{\omega}(y)}\right\| \leq 2 K\left\|\xi_{y}\right\|$.
Now, we define the following linear maps $L_{(x, \omega)}, L_{(y, \omega)}: E^{s}(x, \omega) \rightarrow E^{s}\left(f_{\omega}(x), \theta \omega\right)$ by

\begin{aligned}
L_{(x, \omega)} & =\left.D_{x} f_{\omega}\right|_{E^{s}(x, \omega)} \\
L_{(y, \omega)} & =\left.P\left(E^{s}\left(f_{\omega} x, \theta \omega\right)\right) D_{y} f_{\omega}\right|_{E^{s}(y, \omega)}\left(I+\left(D h_{(x, \omega)}^{s}\right)_{\xi_{y}}\right)
\end{aligned}
$$

We have $\left\|L_{(x, \omega)}\right\|,\left\|L_{(y, \omega)}\right\| \leq \frac{4}{3} \mathcal{P} K$. Hence, we have

$$
\begin{aligned}
& \quad \sup _{v \in E^{s}(x, \omega),\|v\|=1}\left\|P\left(E^{s}\left(f_{\omega} x, \theta \omega\right)\right) D_{x} f_{\omega} v-P\left(E^{s}\left(f_{\omega} x, \theta \omega\right)\right) D_{y} f_{\omega}\left(I+\left(D h_{(x, \omega)}^{s}\right) \xi_{y}\right) v\right\| \\
& \leq \mathcal{P}\left(\left\|D_{x} f_{\omega}-D_{y} f_{\omega}\right\|+\left\|D_{y} f_{\omega}\left(D h_{(x, \omega)}^{s}\right) \xi_{y}\right\|\right) \\
& \leq \mathcal{P} K\|y-x\|+\mathcal{P} K^{2}\left\|\xi_{y}\right\| \\
& =\mathcal{P} K d(x, y)+\mathcal{P} K^{2}\left\|\xi_{y}\right\| \\
& \stackrel{(3.9)}{\leq}\left(\mathcal{P} K+\frac{3}{2} \mathcal{P} K^{2}\right) d(x, y) .
\end{aligned}
$$

So $\left\|L_{(x, \omega)}-L_{(y, \omega)}\right\| \leq C\left(\mathcal{P} K+\frac{3}{2} \mathcal{P} K^{2}\right) d(x, y)$, where the constant $C$ only depends on the normal coordinate chart. Then by properties of the determinant, we have that

\left|\operatorname{det}\left(L_{(x, \omega)}\right)-\operatorname{det}\left(L_{(y, \omega)}\right)\right| \leq R_{1} d(x, y) \tag{3.10}
\end{equation*}
$$

where $R_{1}$ is a polynomial of $K, \mathcal{P}$ and $\operatorname{dim} E^{s}(x, \omega)$.
Notice that for $\xi_{y} \in E^{s}(x, \omega)\left(\frac{\epsilon}{2 K^{2}}\right)$

$$
\begin{aligned}
& \left\|\left.P\left(E^{s}\left(f_{\omega}(x), \theta \omega\right)\right)\right|_{E^{s}\left(f_{\omega}(y), \theta \omega\right)}-I\right\| \leq \frac{\left\|\left(D h_{\left(f_{\omega}(x), \theta \omega\right)}^{s}\right) \xi_{f_{\omega}(y)}\right\|}{1-\left\|\left(D h_{\left(f_{\omega}(x), \theta \omega\right)}^{s}\right) \xi_{f_{\omega}(y)}\right\|} \\
\leq & \frac{K\left\|\xi_{f_{\omega}(y)}\right\|}{1-K\left\|\xi_{f_{\omega}(y)}\right\|} \leq \frac{2 K^{2}\left\|\xi_{y}\right\|}{1-2 K^{2}\left\|\xi_{y}\right\|} \leq \frac{2 K^{2}\left\|\xi_{y}\right\|}{1-2 K^{2} \frac{\epsilon}{2 K^{2}}}
\end{aligned}
$$

$$
\leq 4 K^{2}\left\|\xi_{y}\right\| \leq 6 K^{2} d(x, y)
$$

So we have

$$
\begin{equation*}
\left|\operatorname{det}\left(\left.P\left(E^{s}\left(f_{\omega}(x), \theta \omega\right)\right)\right|_{E^{s}\left(f_{\omega}(y), \theta \omega\right)}\right)-1\right| \leq R_{2} d(x, y) \tag{3.11}
\end{equation*}
$$

where $R_{2}$ is a polynomial of $K$ and $\operatorname{dim} E^{s}(x, \omega)$. Also

$$
\left\|I+\left(D h_{(x, \omega)}^{s}\right) \xi_{y}-I\right\| \leq K\left\|\xi_{y}\right\| \leq \frac{3}{2} K d(x, y)
$$

implies that there exists a constant $R_{3}$ such that

$$
\begin{equation*}
\left|\operatorname{det}\left(I+\left(D h_{(x, \omega)}^{s}\right) \xi_{y}\right)-1\right| \leq R_{3} d(x, y) \tag{3.12}
\end{equation*}
$$

Combining (3.10), (3.11), and (3.12), we have

\left|J^{s}(x, \omega)-J^{s}(y, \omega)\right| \leq K_{0} d(x, y)
$$

where $K_{0}$ only depends on $K, \mathcal{P}$ and $\operatorname{dim} E^{s}$. Notice that $\inf _{(x, \omega) \in M \times \Omega}\left|J^{s}(x, \omega)\right|>0$, as a consequence, there exists a $K_{1}>K_{0}$ such that

$$
\left|\log J^{s}(x, \omega)-\log J^{s}(y, \omega)\right| \leq K_{1} d(x, y)
$$

The proof of Lemma 3.5 is complete.
3.4. Absolute continuity of the stable and unstable foliations on each fiber. The absolute continuity of $\left\{W_{\epsilon}^{\tau}(x, \omega)\right\}$ for fixed $\omega$ and $\tau=s, u$ was stated in [29] for general random dynamical systems without proof. In this subsection, we give a proof in our settings. Besides, we give a specific formula for the Jacobian of holonomy maps.

For any $\omega \in \Omega$, a smooth submanifold $U(\omega) \subset M$ is said to be transverse to the local stable manifolds if for any $x \in U(\omega), T_{x} U(\omega) \oplus E^{s}(x, \omega)=T_{x} M$. The transversal angel can be measured by the following quantity. For subspaces $A, B \subset \mathbb{R}^{N}$ with a given norm $\|\cdot\|$, set

$$
\begin{equation*}
\Theta(A, B)=\min \left\{\min _{v \in A,\|v\|=1 ; w \in B}\|v-w\| ; \min _{w \in B,\|w\|=1 ; v \in A}\|v-w\|\right\} \tag{3.13}
\end{equation*}
$$

For $\theta \in(0,1]$, we say that a subspace $A \subset \mathbb{R}^{N}$ is $\theta$-transverse to a subspace $B \subset \mathbb{R}^{N}$ if $\Theta(A, B) \geq \theta$. Given smooth submanifolds $U(\omega)$ and $V(\omega)$ transversal to the local stable manifolds, we say that $\psi_{\omega}: U(\omega) \rightarrow V(\omega)$ is a fiber holonomy map induced by the local stable manifolds if $\psi_{\omega}$ is injective and continuous, and

$$
\psi_{\omega}(x) \in W_{\epsilon}^{s}(x, \omega) \cap V(\omega) \text { for every } x \in U(\omega)
$$

We say that $\left\{W_{\epsilon}^{s}(x, \omega)\right\}$ is absolutely continuous on each fiber if every fiber holonomy map $\psi_{\omega}$ induced by the local stable manifolds is absolutely continuous with respect to $m_{U(\omega)}$ and $m_{V(\omega)}$, where $m_{V(\omega)}$ and $m_{U(\omega)}$ are the intrinsic Riemannian volume measure on manifolds $V(\omega)$ and $U(\omega)$ respectively. The absolute continuity of $\left\{W_{\epsilon}^{u}(x, \omega)\right\}$ can be defined similarly. Our proof of absolute continuity follows the idea given in [41, Theorem 6.2.6].

Proposition 3.1. Suppose $\phi$ is $C^{2}$ Anosov on fibers, then $\left\{W_{\epsilon}^{s}(x, \omega)\right\}$ and $\left\{W_{\epsilon}^{u}(x, \omega)\right\}$ are absolutely continuous on each fiber respectively.

Proof of Proposition 3.1. We only prove that $\left\{W_{\epsilon}^{s}(x, \omega)\right\}$ is absolutely continuous on each fiber since the case for $\left\{W_{\epsilon}^{u}(x, \omega)\right\}$ is similar. For any $\omega \in \Omega$ fixed, let $\psi_{\omega}: U(\omega) \rightarrow V(\omega)$ be the fiber holonomy map between two smooth pre-compact submanifolds that are transverse to the local stable
manifolds. By the regularity of Riemannian volume measure, to prove the absolute continuity of $\psi_{\omega}$, it is sufficient to prove that there exists a number $C(\omega)>0$ such that

$$
\begin{equation*}
m_{V(\omega)}\left(\psi_{\omega}(A)\right) \leq C(\omega) m_{U(\omega)}(A) \text { for any compact subset } A \subset U(\omega) . \tag{3.14}
\end{equation*}
$$

Before starting the proof, we need some preparations.
Lemma 3.6. There exists $C_{3}, C_{4}(\omega) \in(0,1)$ such that for any $n \in \mathbb{N}$, one has
(1) for any $(x, \omega) \in M \times \Omega, v \in\left(E^{s}(x, \omega)\right)^{\perp}$,

$$
\begin{equation*}
\left\|D_{x} f_{\omega}^{n} v\right\| \geq C_{3} e^{\lambda n}\|v\| ; \tag{3.15}
\end{equation*}
$$

(2) for any $x \in U(\omega), v \in T_{x} U(\omega)$ and $y \in V(\omega), \beta \in T_{y} V(\omega)$,

$$
\begin{equation*}
\left\|D_{x} f_{\omega}^{n} v\right\| \geq C_{4}(\omega) e^{\lambda n}\|v\| \text {, and }\left\|D_{y} f_{\omega}^{n} \beta\right\| \geq C_{4}(\omega) e^{\lambda n}\|\beta\| ; \tag{3.16}
\end{equation*}
$$

Proof of Lemma 3.6. First, we prove (1). We pick $N_{0} \in \mathbb{N}$ such that for any $n \geq N_{0}$,

$$
e^{\lambda n}-e^{-\lambda n} \mathcal{P} \geq \frac{1}{2} e^{\lambda n},
$$

where $\mathcal{P}$ is the constant in (3.3). Now for any $(x, \omega) \in M \times \Omega, v \in\left(E^{s}(x, \omega)\right)^{\perp}$, then $v$ has decomposition $v=v_{1}+v_{2}$ for $v_{1} \in E^{u}(x, \omega)$ and $v_{2} \in E^{s}(x, \omega)$. Note that

$$
\langle v, v\rangle=\left\langle v, v_{1}+v_{2}\right\rangle=\left\langle v, v_{1}\right\rangle \leq\|v\| \cdot\left\|v_{1}\right\|,
$$

which implies $\left\|v_{1}\right\| \geq\|v\|$. If $0 \leq n<N_{0}$, we have

$$
\left\|D_{x} f_{\omega}^{n} v\right\| \geq\left(\inf _{(x, \omega) \in M \times \Omega} m\left(D_{x} f_{\omega}\right)\right)^{N_{0}}\|v\| \geq \frac{\left(\inf _{(x, \omega) \in M \times \Omega} m\left(D_{x} f_{\omega}\right)\right)^{N_{0}}}{e^{\lambda N_{0}}} e^{\lambda n}\|v\|,
$$

where $m\left(D_{x} f_{\omega}\right)=\left\|\left(D_{x} f_{\omega}\right)^{-1}\right\|^{-1}<1$ denotes the co-norm of $D_{x} f_{\omega}$. If $n \geq N_{0}$, then

$$
\begin{aligned}
\left\|D_{x} f_{\omega}^{n} v\right\| & \geq\left\|D_{x} f_{\omega}^{n} v_{1}\right\|-\left\|D_{x} f_{\omega}^{n} v_{2}\right\| \geq e^{\lambda n}\left\|v_{1}\right\|-e^{-\lambda n}\left\|v_{2}\right\| \\
& \geq e^{\lambda n}\|v\|-e^{-\lambda n} \mathcal{P}\|v\| \geq \frac{1}{2} e^{\lambda n}\|v\| .
\end{aligned}
$$

These two cases imply that (3.15) holds for

C_{3}:=\min \left\{\frac{1}{2}, \frac{\left(\inf _{(x, \omega) \in M \times \Omega} m\left(D_{x} f_{\omega}\right)\right)^{N_{0}}}{e^{\lambda N_{0}}}\right\} .

Second, we prove (2). We only prove the first inequality of (3.16), as the second one is similar. Note that $U(\omega)$ and $V(\omega)$ are transverse to the local stable manifolds and pre-compact, the following quantity is positive

\gamma_{1}(\omega):=\min \left\{\inf \left\{\Theta\left(T_{x} U(\omega), E^{s}(x, \omega)\right) \mid x \in U(\omega)\right\}, \inf \left\{\Theta\left(T_{y} V(\omega), E^{s}(y, \omega)\right) \mid y \in V(\omega)\right\}\right\} \tag{3.17}
\end{equation*}
$$

Now for any $x \in U(\omega)$ and any $v \in T_{x} U(\omega)$, then $v=v_{1}+v_{2}$ for $v_{1} \in\left(E^{s}(x, \omega)\right)^{\perp}$ and $v_{2} \in E^{s}(x, \omega)$. Then one has

$$
\begin{equation*}

Recall that $\bar{\psi}_{\theta^{n} \omega}: f_{\omega}^{n} U(\omega) \rightarrow f_{\omega}^{n} V(\omega)$ is the holonomy map induced by the local stable manifolds. Notice that $\psi_{\omega}=f_{\theta^{n} \omega}^{-n} \circ \bar{\psi}_{\theta^{n} \omega} \circ f_{\omega}^{n}$, so for $m_{U(\omega) \text {-a.s. } x \in U(\omega), ~}^{x}$,

\operatorname{Jac}\left(\psi_{\omega}\right)(x)=H_{\omega}^{n}\left(x, \psi_{\omega}(x), T_{x} U(\omega), T_{\psi_{\omega}(x)} V(\omega)\right) \cdot \operatorname{Jac}\left(\bar{\psi}_{\theta^{n} \omega}\right)\left(f_{\omega}^{n}(x)\right) \tag{3.49}
\end{equation*}
$$

To derive the formula of $\operatorname{Jac}\left(\psi_{\omega}\right)(x)$, we need the following lemma, whose condition is stronger than ones in [31, Theorem 3.3].

Lemma 3.11. Let $N$ and $P$ be manifolds with $m_{P}(P)<\infty$ and $m_{N}(\partial N)=0$, and $\left(\phi_{n}\right)_{n \geq 0}$, $\phi_{n}: N \rightarrow P$, be a sequence of absolutely continuous maps with $\operatorname{Jacobian} \operatorname{Jac}\left(\phi_{n}\right)$. If $\phi_{n}$ converges uniformly to an absolutely continuous and injective map $\phi: N \rightarrow P$ and $J a c\left(\phi_{n}\right)$ (by changing its value on zero measure set) converges uniformly to an integrable function $J: N \rightarrow \mathbb{R}$, then $J a c(\phi)=J$.

Next, we will define a sequence of absolutely continuous maps $\pi_{\theta^{n} \omega}: f_{\omega}^{n} U(\omega) \rightarrow f_{\omega}^{n} V(\omega)$ such that the sequence of mapping

\psi_{n, \omega}=\left(\left.f_{\theta^{n} \omega}^{-n}\right|_{f_{\omega}^{n} V(\omega)}\right) \circ \pi_{\theta^{n} \omega} \circ\left(\left.f_{\omega}^{n}\right|_{U(\omega)}\right): U(\omega) \rightarrow V(\omega) \tag{3.50}
\end{equation*}
$$

converges to $\psi_{\omega}$ uniformly, and a version of $\operatorname{Jac}\left(\psi_{n, \omega}\right)$ converges uniformly to an integrable function. Here, a version of $\operatorname{Jac}\left(\psi_{n, \omega}\right)$ is defined by changing the value of it on a zero $m_{U(\omega)}$-measure set.

For $\delta>0$ sufficiently small, we cover $f_{\omega}^{n} U(\omega)$ for any $n \in \mathbb{N}$ by balls $\left\{B_{f_{\omega}^{n} U(\omega)}\left(f_{\omega}^{n}(x), \delta\right)\right\}_{x \in U(\omega)}$. Since $U(\omega)$ is pre-compact, there exists a finite cover $\left\{B_{f_{\omega}^{n} U(\omega)}\left(f_{\omega}^{n}\left(x_{i}\right), \delta\right)\right\}_{i=1}^{k\left(\theta^{n} \omega\right)}$. This open cover produces a natural finite Borel partition of $f_{\omega}^{n} U(\omega)$, named $\left\{P_{i}\left(\theta^{n} \omega\right)\right\}_{i=1}^{k\left(\theta^{n} \omega\right)}$, in the following way:

P_{1}\left(\theta^{n} \omega\right):=\left(f_{\omega}^{n} U(\omega)\right) \cap B_{f_{\omega}^{n} U(\omega)}\left(f_{\omega}^{n}\left(x_{i}\right), \delta\right),

and

P_{i}\left(\theta^{n} \omega\right):=\left(f_{\omega}^{n} U(\omega)\right) \cap B_{f_{\omega}^{n} U(\omega)}\left(f_{\omega}^{n}\left(x_{i}\right), \delta\right) \backslash\left(\cup_{j=1}^{i-1} B_{f_{\omega}^{n} U(\omega)}\left(f_{\omega}^{n}\left(x_{j}\right), \delta\right)\right)
$$

for $i=2, \ldots, k\left(\theta^{n} \omega\right)$. Without loss of generality, we assume $P_{i}\left(\theta^{n} \omega\right) \neq \emptyset$ for all $i$. This Borel partition satisfies that

$$
\begin{equation*}
P_{i}\left(\theta^{n} \omega\right) \subset B_{f_{\omega}^{n} U(\omega)}\left(f_{\omega}^{n}\left(x_{i}\right), \delta\right), \text { and } m_{f_{\omega}^{n} U(\omega)}\left(\cup_{i} \partial P_{i}\left(\theta^{n} \omega\right)\right)=0 . \tag{3.51}
\end{equation*}
$$

Denote $\Psi_{n}^{1, i}$ (resp. $\left.\Psi_{n}^{2, i}\right): E^{u}\left(f_{\omega}^{n}\left(x_{i}\right), \theta^{n} \omega\right)(\mathcal{P} \delta) \rightarrow E^{s}\left(f_{\omega}^{n}\left(x_{i}\right), \theta^{n} \omega\right)$ to be the $C^{2}$ mapping such that $\exp _{x_{i}}\left(\operatorname{graph}\left(\Psi_{n}^{1, i}\right)\right)$ represents the component of $f_{\omega}^{n} U(\omega)$ (resp. $\left.f_{\omega}^{n} V(\omega)\right)$ passing through $f_{\omega}^{n}\left(x_{i}\right)$ (resp. $\left.f_{\omega}^{n}\left(\psi_{\omega}\left(x_{i}\right)\right)\right)$. We define $\tilde{\pi}_{\theta^{n} \omega}$ restricted on $\exp _{x_{i}}^{-1}\left(P_{i}\left(\theta^{n} \omega\right)\right)$ by

$$
\tilde{\pi}_{\theta^{n} \omega}\left(e, \Psi_{n}^{1, i}(e)\right)=\left(e, \Psi_{n}^{2, i}(e)\right) \text { for any }\left(e, \Psi_{n}^{1, i}(e)\right) \in \exp _{x_{i}}^{-1}\left(P_{i}\left(\theta^{n} \omega\right)\right)
$$

i.e. the holonomy map induced by the flat foliation $\left\{e+E^{s}\left(f_{\omega}^{n}\left(x_{i}\right), \theta^{n} \omega\right): e \in E^{u}\left(f_{\omega}^{n}\left(x_{i}\right), \theta^{n} \omega\right)(\mathcal{P} \delta)\right\}$. Then let

$$
\pi_{\theta^{n} \omega}(y)=\exp _{x_{i}} \circ \tilde{\pi}_{\theta^{n} \omega} \circ \exp _{x_{i}}^{-1}(y), \text { for } y \in P_{i}\left(\theta^{n} \omega\right)
$$

This mapping $\pi_{\theta^{n} \omega}$ is naturally absolutely continuous since it is absolutely continuous on each set in the partition. Moreover, $\pi_{\theta^{n} \omega}$ is $C^{2}$ for $x \in \operatorname{interior}\left(P_{i}\left(\theta^{n} \omega\right)\right)$ for all $i$. Let $\psi_{n, \omega}$ be defined as (3.50) by using this $\pi_{\theta^{n} \omega}$.

Note that $f_{\omega}^{n} U(\omega)$ is $C^{1}$-close to $f_{\omega}^{n} V(\omega)$ as $n \rightarrow \infty$. By the local stable manifolds theorem, for any $\epsilon>0$, there exists $N_{\epsilon}(\omega)$ such that

$$
d_{f_{\omega}^{n} V(\omega)}\left(\bar{\psi}_{\theta^{n} \omega}(x), \pi_{\theta^{n} \omega}(x)\right)<\epsilon \text { for } x \in f_{\omega}^{n} U(\omega)
$$

where $\bar{\psi}_{\theta^{n} \omega}=f_{\omega}^{n} \circ \psi_{\omega} \circ f_{\theta^{n} \omega}^{-n}$. Therefore, for any $x \in U(\omega), n \geq N_{\epsilon}(\omega)$, we have

d_{V(\omega)}\left(\psi_{\omega}(x), \psi_{n, \omega}(x)\right)=d_{V(\omega)}\left(f_{\theta^{n} \omega}^{-n} \circ \bar{\psi}_{\theta^{n} \omega}\left(f_{\omega}^{n}(x)\right), f_{\theta^{n} \omega}^{-n} \circ \circ \pi_{\theta^{n} \omega}\left(f_{\omega}^{n}(x)\right)\right) \stackrel{(3.16)}{\leq} C_{4}(\omega)^{-1} e^{-\lambda n} \epsilon,
$$

which goes to 0 uniformly for all $x \in U(\omega)$ as $n \rightarrow \infty$.
It is left to show that there exists a version of $\operatorname{Jac}\left(\psi_{n, \omega}\right)(x)$ converges uniformly for $x \in U(\omega)$. By (3.50), for $m_{U(\omega)}$-a.s. $x \in U(\omega)$, we have

Note that (3.51) implies that $m_{U(\omega)}\left(f_{\theta^{n} \omega}^{-n}\left(\cup_{i} \partial P_{i}\left(\theta^{n} \omega\right)\right)\right)=0$. For $x \in f_{\theta^{n} \omega}^{-n}\left(\cup_{i} \partial P_{i}\left(\theta^{n} \omega\right)\right)$, we set $\operatorname{Jac}\left(\pi_{\theta^{n} \omega}\right)\left(f_{\omega}^{n}(x)\right)=1$. For $x \in U(\omega)$ such that $f_{\omega}^{n}(x) \in \operatorname{interior}\left(P_{i}\right)\left(\theta^{n} \omega\right), \pi_{\theta^{n} \omega}$ is $C^{2}$ on $f_{\omega}^{n} x$. By the definition of $\tilde{\pi}_{\theta^{n} \omega}$, we have

$$
\operatorname{Jac}\left(\tilde{\pi}_{\theta^{n}}\right)\left(\exp _{x_{i}}^{-1}\left(f_{\omega}^{n}(x)\right)\right)=\frac{\operatorname{Jac}\left(\tilde{\Psi}_{n}^{2, i}\right)(e)}{\operatorname{Jac}\left(\tilde{\Psi}_{n}^{1, i}\right)(e)} \text { for } e=\left(\tilde{\Psi}_{n}^{1, i}\right)^{-1}\left(\exp _{x_{i}}^{-1}\left(f_{\omega}^{n}(x)\right)\right)
$$

where $\tilde{\Psi}_{n}^{\tau, i}(e)=\left(e, \Psi_{n}^{\tau, i}(e)\right)$ for $\tau=1,2$. According to the proof of (3.34), for any $\eta>0$, there exists $N_{\eta}(\omega) \in \mathbb{N}$ such that for any $n>N_{\eta}(\omega)$, one has

\operatorname{Jac}\left(\tilde{\pi}_{\theta^{n}}\right)\left(f_{\omega}^{n}(x)\right)=\frac{\operatorname{Jac}\left(\tilde{\Psi}_{n}^{2, i}\right)(e)}{\operatorname{Jac}\left(\tilde{\Psi}_{n}^{1, i}\right)(e)} \in\left(e^{-C^{*} \eta}, e^{C^{*} \eta}\right)
$$

for some constant $C^{*}$. Moreover, we have

$$
\frac{\left|\operatorname{det} D_{\tilde{\pi}_{\theta^{n}}\left(\exp _{x_{i}}^{-1}\left(f_{\omega}^{n}(x)\right)\right)} \exp _{x_{i}}\right|}{\left|\operatorname{det} D_{\exp _{x_{i}}^{-1}\left(f_{\omega}^{n}(x)\right)} \exp _{x_{i}}\right|} \rightarrow 1 \text { uniformly, as } n \rightarrow \infty
$$

since $d\left(f_{\omega}^{n}(x), \pi_{\theta^{n} \omega}\left(f_{\omega}^{n}(x)\right)\right) \rightarrow 0$ uniformly. Therefore, there exists a version of $\operatorname{Jac}\left(\pi_{\theta^{n}}\right)\left(f_{\omega}^{n}(x)\right)$ converges to 1 uniformly as $n \rightarrow \infty$.

Finally, we show that

$$
\begin{equation*}
\frac{H_{\omega}^{n}\left(x, \psi_{n, \omega}(x), T_{x} U(\omega), T_{\psi_{n, \omega}(x)} V(\omega)\right)}{H_{\omega}^{n}\left(x, \psi_{\omega}(x), T_{x} U(\omega), T_{\psi_{\omega}(x)} V(\omega)\right)}=\frac{\left|\operatorname{det} D_{\psi_{\omega}(x)} f_{\omega}^{n}\right| T_{\psi_{\omega}(x)} V(\omega) \mid}{\left|\operatorname{det} D_{\psi_{n, \omega}(x)} f_{\omega}^{n}\right| T_{\psi_{n, \omega}(x)} V(\omega) \mid} \rightarrow 1 \tag{3.52}
\end{equation*}
$$

uniformly as $n \rightarrow \infty$. For any $\epsilon>0$, we pick $N_{1}(\omega) \in \mathbb{N}$ such that for any $n \geq N$,

$$
\sum_{n \geq N_{1}(\omega)} C_{12}(\omega) e^{-\lambda n} \leq \epsilon,
$$

where $C_{12}(\omega)$ is defined in (3.48). Then we pick $\eta>0$ sufficiently small such that if $y, z \in U(\omega)$ satisfying $\sup _{0 \leq i \leq N_{1}(\omega)-1} d\left(f_{\omega}^{i}(y), f_{\omega}^{i}(z)\right)<\eta$,

$$
\frac{\left|\operatorname{det} D_{y} f_{\omega}^{N_{1}(\omega)}\right| T_{y} V(\omega) \mid}{\left|\operatorname{det} D_{z} f_{\omega}^{N_{1}(\omega)}\right| T_{z} V(\omega) \mid} \in\left(e^{-\epsilon}, e^{\epsilon}\right),
$$

and moreover,

$$
C_{12}(\omega) \sum_{i=0}^{\infty} e^{-\lambda i \nu_{1}} \eta \leq \epsilon .
$$

By the constriction of $\psi_{n, \omega}$, we pick $N_{2}(\omega)>N_{1}(\omega)$ such that for any $n \geq \mathbb{N}_{2}(\omega)$,

$$
\sup _{0 \leq i \leq n-1} d\left(f_{\omega}^{i}\left(\psi_{\omega}(x)\right), f_{\omega}^{i}\left(\psi_{n, \omega}(x)\right)\right)<\eta
$$

Now, according to the proof of (3.44), for any $n \geq N_{2}(\omega)$, we arrive

$$
\begin{aligned}
& \left.\frac{\left|\operatorname{det} D_{\psi_{\omega}(x)} f_{\omega}^{n}\right| T_{\psi_{\omega}(x)} V(\omega) \mid}{}\left|\operatorname{det} D_{\psi_{n, \omega}(x)} f_{\omega}^{n}\right| T_{\psi_{n, \omega}(x)} V(\omega) \right\rvert\, \\
= & \frac{\left|\operatorname{det} D_{\psi_{\omega}(x)} f_{\omega}^{N_{1}(\omega)}\right|_{T_{\psi_{\omega}(x)} V(\omega)} \mid}{\left|\operatorname{det} D_{\psi_{n, \omega}(x)} f_{\omega}^{N_{1}(\omega)}\right|_{T_{\psi_{n, \omega}(x)} V(\omega)} \mid} \cdot \frac{\left|\operatorname{det} D_{f_{\omega}^{N_{1}(\omega)}\left(\psi_{\omega}(x)\right)} f_{\theta^{N_{1}(\omega)} \omega}^{n-N_{1}(\omega)}\right|_{D_{\psi_{\omega}(x)} f_{\omega}^{N_{1}(\omega)} T_{\psi_{\omega}(x)} V(\omega)} \mid}{\left|\operatorname{det} D_{f_{\omega}^{N_{1}(\omega)}\left(\psi_{n, \omega}(x)\right)} f_{\theta^{N_{1}(\omega)} \omega}^{n-N_{1}(\omega)}\right|_{D_{\psi_{n, \omega}(x)} f_{\theta^{N_{1}(\omega)}{ }_{\omega}}^{n-N_{1}(\omega)} T_{x} V(\omega)} \mid} \in\left(e^{-3 \epsilon}, e^{3 \epsilon}\right) .
\end{aligned}

So (3.52) holds. Therefore, by Lemma 3.11 and changing value on zero $m_{U(\omega)}$-measure set, we have

The proof of Proposition 3.1 is complete.
3.5. Hölder continuity of the stable and unstable foliations on each fiber. In this subsection, we prove the Hölder continuity of the holonomy map between two local stable leaves (or unstable leaves). This result is known in deterministic hyperbolic systems (see, e.g., [34]), but we didn't find any reference to this result in RDS. We supply a proof in our settings, and the proof follows the idea given in Page 762 in [24]. Roughly speaking, the idea is that the action of the graph transform preserves a Hölder condition.
Proposition 3.2. Suppose $\phi$ is $C^{2}$ Anosov on fibers, let $\varrho \in(0,1)$ satisfy

$$

where

$$
\begin{aligned}
& t_{(p, \omega)}:=\inf \left\{\frac{d\left(f_{\omega} p, f_{\omega} q\right)}{d(p, q)}: q \in M, d(p, q)<\epsilon_{0}\right\}>0 \\
& s_{(p, \omega)}:=\inf \left\{\frac{d\left(f_{\omega}^{-1}(p), f_{\omega}^{-1}(q)\right)}{d(p, q)}: q \in M, d(p, q)<\epsilon_{0}\right\}>0
\end{aligned}
$$

and $\epsilon_{0}$ is the size of local stable and unstable manifolds. Then there exists a constant $\delta_{0}>0$ and $H=H\left(\delta_{0}, \varrho\right)$ such that for any $(q, \omega) \in M \times \Omega$,

& \sup \left\{\frac{\sup _{x \in E^{u}(p, \omega)\left(\delta_{0}\right)}\left\|h_{(p, \omega)}^{s}(x)-\tilde{h}_{(q, \omega)}^{s}(x)\right\|}{d(p, q)^{\varrho}}: q \in M, d(p, q)<\delta_{0}\right\} \leq H<\infty, \tag{3.55}
\end{align*}
$$

where $h_{(p, \omega)}^{u}, \tilde{h}_{(q, \omega)}^{u}: E^{u}(p, \omega)\left(\delta_{0}\right) \rightarrow E^{s}(p, \omega)$ and $\operatorname{Exp} p_{p}\left(\operatorname{graph}\left(h_{(p, \omega)}^{u}\right)\right)$, $\operatorname{Exp}_{p}\left(\operatorname{graph}\left(\tilde{h}_{(q, \omega)}^{u}\right)\right)$ represent the local unstable manifolds passing through p, q respectively, $h_{(p, \omega)}^{s}, \tilde{h}_{(q, \omega)}^{s}: E^{s}(p, \omega)\left(\delta_{0}\right) \rightarrow$ $E^{u}(p, \omega)$ and $\operatorname{Exp}_{p}\left(\operatorname{graph}\left(h_{(p, \omega)}^{s}\right)\right), \operatorname{Exp}_{p}\left(\operatorname{graph}\left(\tilde{h}_{(q, \omega)}^{s}\right)\right)$ represent the local stable manifolds passing through $p, q$ respectively. Furthermore, the local product structure is Hölder continuous, i.e., there exists a constant $H^{\prime}=H^{\prime}\left(\delta_{0}, \varrho\right)$ such that for any $(x, \omega) \in M \times \Omega, y \in W_{\delta_{0}}^{s}(x, \omega)$, any $z \in M$ such that $W_{\epsilon}^{s}(z, \omega) \cap W_{\epsilon}^{u}(x, \omega) \neq \emptyset, W_{\epsilon}^{s}(z, \omega) \cap W_{\epsilon}^{u}(y, \omega) \neq \emptyset$, we have

d\left(W_{\epsilon}^{s}(z, \omega) \cap W_{\epsilon}^{u}(x, \omega), W_{\epsilon}^{s}(z, \omega) \cap W_{\epsilon}^{u}(y, \omega)\right) \leq H^{\prime} d(x, y)^{\varrho} ;
$$

for any $(x, \omega) \in M \times \Omega, y \in W_{\delta_{0}}^{u}(x, \omega)$, any $z \in M$ such that $W_{\epsilon}^{u}(z, \omega) \cap W_{\epsilon}^{s}(x, \omega) \neq \emptyset$, $W_{\epsilon}^{u}(z, \omega) \cap$ $W_{\epsilon}^{s}(y, \omega) \neq \emptyset$, we have

d\left(W_{\epsilon}^{u}(z, \omega) \cap W_{\epsilon}^{s}(x, \omega), W_{\epsilon}^{u}(z, \omega) \cap W_{\epsilon}^{s}(y, \omega)\right) \leq H^{\prime} d(x, y)^{\varrho} .

Proof. We first prove (3.54). Recall that for each point $p \in M$, there exist a neighborhood $N_{p} \subset M$ and constant $\epsilon$ such that the exponential map $\operatorname{Exp}_{p}: B_{\epsilon}(0) \subset T p M \rightarrow M$ is a $C^{\infty}$-diffeomorphism and $N_{p} \subset \operatorname{Exp}_{p}\left(B_{\epsilon}(0)\right)$. Now for all $p \in M$ and $\omega \in \Omega$, consider any continuous function $g_{(p, \omega)}$ : $E^{u}(p, \omega)(\epsilon) \rightarrow E^{s}(p, \omega)$ with $g_{(p, \omega)}(0)=0$, where $E^{u}(p, \omega)(\epsilon)$ is the $\epsilon$-disk in $E^{u}(p, \omega)$ centered at the origin. Define the special norm by

G_{(p, \omega)}:=\left\{g_{(p, \omega)} \in G_{(p, \omega)}^{*}: \operatorname{Lip}\left(g_{(p, \omega)}\right) \leq \frac{e^{-2 \lambda}+1}{2}\right\} . \tag{3.56}

Sublemma 3.1. $G_{(p, \omega)}^{*}$ equipped with $\|\cdot\|_{*}$ is a Banach space and $G_{(p, \omega)}$ is a closed subset.

The above sublemma is a corollary of [37, Lemma III.3]. $\left\{G_{(p, \omega)}\right\}_{(p, \omega) \in M \times \Omega}$ gives a bundle $G$ on $M \times \Omega$ with fiber $G_{(p, \omega)}$ on $(p, \omega) \in M \times \Omega$.

Now we define $f_{(p, \omega)}: T_{p} M(\epsilon) \rightarrow T_{f_{\omega} p} M$ by the local representation of $f_{\omega}$ with respect to exponential maps $\operatorname{Exp}_{p}$ and $E_{x p}^{f_{\omega} p}$, i.e.,

$$
f_{(p, \omega)}(v)=\operatorname{Exp}_{f_{\omega} p}^{-1} \circ f_{\omega} \circ \operatorname{Exp}_{p}(v), \forall v \in T_{p} M(\epsilon) .
$$

For any $(p, \omega) \in M \times \Omega$, we define a bundle map $\phi_{(p, \omega)}^{*}$ on $G_{(p, \omega)}$ satisfying for any $g_{(p, \omega)} \in G_{(p, \omega)}$,

$$
\operatorname{graph}\left(\phi_{(p, \omega)}^{*} g_{(p, \omega)}\right)=f_{(p, \omega)}\left(\operatorname{graph}\left(g_{(p, \omega)}\right)\right) \cap\left(E^{u}\left(f_{\omega} p, \theta \omega\right)(\epsilon) \oplus E^{s}\left(f_{\omega} p, \theta \omega\right)\right) .
$$

Note that the definition of $G_{(p, \omega)}$ is relying on $\epsilon$. The next sublemma says that there exists $\epsilon>0$ such that $\phi_{(p, \omega)}^{*} \operatorname{maps} G_{(p, \omega)}$ into $G_{\left(f_{\omega} p, \theta \omega\right)}$ and this map is a contraction.

Sublemma 3.2. There exists a $\epsilon_{0}>0$ such that for any $\epsilon \in\left(0, \epsilon_{0}\right),(p, \omega) \in M \times \Omega$, one has $\phi_{(p, \omega)}^{*} g_{(p, \omega)} \in G_{\left(f_{\omega} p, \theta \omega\right)}$, and it is a fiber contraction, i.e., for any $g_{(p, \omega)}, g_{(p, \omega)}^{\prime} \in G_{(p, \omega)}$, we have

$$
\left\|\phi_{(p, \omega)}^{*} g_{(p, \omega)}-\phi_{(p, \omega)}^{*} g_{(p, \omega)}^{\prime}\right\|_{*} \leq \frac{e^{-2 \lambda_{0}}+1}{2}\left\|g_{(p, \omega)}-g_{(p, \omega)}^{\prime}\right\|_{*},
$$

Proof of Sublemma 3.2. Fix any $\epsilon^{\prime}>0$ such that

\frac{e^{-\lambda_{0}}+2 \mathcal{P} \epsilon^{\prime}}{e^{\lambda_{0}}-2 \mathcal{P} \epsilon^{\prime}} \leq \frac{e^{-2 \lambda_{0}}+1}{2} \tag{3.57}
\end{equation*}
$$

By compactness of $\Omega$ and $M$ and the continuity of $f_{\omega}$ on $\omega$, for the above $\epsilon^{\prime}$, we can pick a $\epsilon_{0}>0$ sufficiently small such that for any $\epsilon<\epsilon_{0}$,

\operatorname{Lip}\left(\left.\left(f_{(p, \omega)}-D_{p} f_{\omega}\right)\right|_{\left.T_{p} M_{(\epsilon)}\right)}\right)<\epsilon^{\prime}
$$

Pick any $g \in G_{(p, \omega)}$, let $f_{(p, \omega)}(x, g(x))$ have decomposition

$$
f_{(p, \omega)}(x, g(x))=\left(f_{(p, \omega), 1}(x, g(x)), f_{(p, \omega), 2}(x, g(x))\right)
$$

with respect to $T_{f_{\omega} p} M=E^{u}\left(f_{\omega} p, \theta \omega\right) \oplus E^{s}\left(f_{\omega} p, \theta \omega\right)$, and we denote $h_{(p, \omega)}:=f_{(p, \omega), 1} \circ(i d, g)$ : $E^{u}(p, \omega)(\epsilon) \rightarrow E^{u}\left(f_{\omega} p, \theta \omega\right)$. Note that

$$
\begin{aligned}
f_{(p, \omega), 1}(x, g(x)) & =P\left(E^{u}\left(f_{\omega} p, \theta \omega\right)\right) \circ f_{(p, \omega)} \circ(i d, g)(x), \\
\left.D_{p} f_{\omega}\right|_{E^{u}(p, \omega)}(x) & =P\left(E^{u}\left(f_{\omega} p, \theta \omega\right)\right) \circ D_{p} f_{\omega} \circ(i d, g)(x),
\end{aligned}
$$

where $P\left(E^{u}\left(f_{\omega} p, \theta \omega\right)\right): T_{f_{\omega} p} M \rightarrow E^{u}\left(f_{\omega} p, \theta \omega\right)$ is the projection with respect to the above decomposition. Then we have

$$
\begin{align*}
& \operatorname{Lip}\left(f_{(p, \omega), 1} \circ(i d, g)-\left.D_{p} f_{\omega}\right|_{E^{u}(p, \omega)(\epsilon)}\right) \\
\leq & \mathcal{P} \cdot \operatorname{Lip}\left(\left.\left(f_{(p, \omega)}-D_{p} f_{\omega}\right)\right|_{T_{p} M(\epsilon)}\right) \cdot \operatorname{Lip}(i d, g) \\
< & \mathcal{P} \epsilon^{\prime} \tag{3.58}
\end{align*}
$$

where $\mathcal{P}$ is the constant in (3.3). By the Lipschitz Inverse function theorem (see, e.g, [37, Theorem I.2]), $h_{(p, \omega)}$ is a homeomorphism to its image and moreover,

$$
\begin{align*}
& \operatorname{Lip}\left(h_{(p, \omega)}^{-1}\right) \leq \frac{1}{\left\|\left.D_{p} f_{\omega}\right|_{E^{u}(p, \omega)} ^{-1}\right\|^{-1}-\operatorname{Lip}\left(f_{(p, \omega), 1} \circ(i d, g)-\left.D_{p} f_{\omega}\right|_{E^{u}(p, \omega)(\epsilon)}\right)} \\
& \quad \stackrel{(3.58)}{<} \frac{1}{m\left(\left.D_{p} f_{\omega}\right|_{E^{u}(p, \omega)}\right)-\mathcal{P} \epsilon^{\prime}}, \tag{3.59}
\end{align*}
$$

where $m\left(\left.D_{p} f_{\omega}\right|_{E^{u}(p, \omega)}\right)=\left\|\left.D_{p} f_{\omega}\right|_{E^{u}(p, \omega)} ^{-1}\right\|^{-1}$ denotes the co-norm. Then for any $g \in G_{(p, \omega)}$, we have

\left(\phi_{(p, \omega)}^{*} g\right)(y)=f_{(p, \omega), 2}\left(h_{(p, \omega)}^{-1}(y), g\left(h_{(p, \omega)}^{-1}(y)\right)\right) \text { for } y \in E^{u}\left(f_{\omega} p, \theta \omega\right)(\epsilon) . \tag{3.60}
\end{equation*}
$$

Note that for $x \in E^{u}(p, \omega)(\epsilon)$,

$$
\begin{aligned}
f_{(p, \omega), 2}(x, g(x)) & =P\left(E^{s}\left(f_{\omega} p, \theta \omega\right)\right) \circ f_{(p, \omega)} \circ(i d, g)(x), \\
\left.D_{p} f_{\omega}\right|_{E^{s}(p, \omega)}(g(x)) & =P\left(E^{s}\left(f_{\omega} p, \theta \omega\right)\right) \circ D_{p} f_{\omega} \circ(i d, g)(x),
\end{aligned}
$$

then we have

$$
\begin{align*}
\operatorname{Lip}\left(f_{(p, \omega), 2} \circ(i d, g)\right) & \leq \operatorname{Lip}\left(f_{(p, \omega), 2} \circ(i d, g)-\left.D_{p} f_{\omega}\right|_{E^{s}(p, \omega)} \circ g\right)+\operatorname{Lip}\left(\left.D_{p} f_{\omega}\right|_{E^{s}(p, \omega)} \circ g\right) \\
& \leq\left\|P\left(E^{s}\left(f_{\omega} p, \theta \omega\right)\right)\right\| \cdot \operatorname{Lip}\left(f_{(p, \omega)}-D_{p} f_{\omega}\right) \cdot \operatorname{Lip}((i d, g))+\left\|\left.D_{p} f_{\omega}\right|_{E^{s}(p, \omega)}\right\| \\
& <\mathcal{P} \epsilon^{\prime}+\left\|\left.D_{p} f_{\omega}\right|_{E^{s}(p, \omega)}\right\| . \tag{3.61}
\end{align*}
$$

Combining (3.59), (3.60) and (3.61),

$$
\begin{aligned}
\operatorname{Lip}\left(\phi_{(p, \omega)}^{*} g\right) & \leq \operatorname{Lip}\left(f_{(p, \omega), 2} \circ(i d, g)\right) \cdot \operatorname{Lip}\left(h_{(p, \omega)}^{-1}\right) \leq \frac{\left\|\left.D_{p} f_{\omega}\right|_{E^{s}(p, \omega)}\right\|+\mathcal{P} \epsilon^{\prime}}{m\left(\left.D_{p} f_{\omega}\right|_{E^{u}(p, \omega)}\right)-\mathcal{P} \epsilon^{\prime}} \\
& \leq \frac{e^{-\lambda_{0}}+\mathcal{P} \epsilon^{\prime}}{e^{\lambda_{0}}-\mathcal{P} \epsilon^{\prime}} \stackrel{(3.57)}{<} \frac{e^{-2 \lambda_{0}}+1}{2} .
\end{aligned}
$$

Obviously that $\left(\phi_{(p, \omega)}^{*} g\right)(0)=0$, so we have shown that $\phi_{(p, \omega)}^{*} \operatorname{maps} G_{(p, \omega)}$ to $G_{\left(f_{\omega} p, \theta \omega\right)}$.
Next, we show that $\phi_{(p, \omega)}^{*}$ is fiber-contraction. We note that

$$
\frac{\left\|\left.D_{p} f_{\omega}\right|_{E^{s}(p, \omega)}\right\|+2 \mathcal{P} \epsilon^{\prime}}{m\left(\left.D_{p} f_{\omega}\right|_{E^{u}(p, \omega)}\right)-2 \mathcal{P} \epsilon^{\prime}} \leq \frac{e^{-\lambda_{0}}+2 \mathcal{P} \epsilon^{\prime}}{e^{\lambda_{0}}-2 \mathcal{P} \epsilon^{\prime}} \stackrel{(3.57)}{\leq} \frac{e^{-2 \lambda_{0}}+1}{2} .
$$

Therefore, it is sufficient to show that for any $g, g^{\prime} \in G_{(p, \omega)}$, for all $x \in E^{u}(p, \omega)(\epsilon)$, (3.62)

$$
\frac{\left\|\left(\phi_{(p, \omega)}^{*} g\right)\left(f_{(p, \omega), 1}(x, g(x))\right)-\left(\phi_{(p, \omega)}^{*} g^{\prime}\right)\left(f_{(p, \omega), 1}(x, g(x))\right)\right\|}{\left\|f_{(p, \omega), 1}(x, g(x))\right\|} \leq \frac{\left\|\left.D_{p} f_{\omega}\right|_{E^{s}(p, \omega)}\right\|+2 \mathcal{P} \epsilon^{\prime}}{m\left(\left.D_{p} f_{\omega}\right|_{E^{u}(p, \omega)}\right)-2 \mathcal{P} \epsilon^{\prime}} \cdot\left\|g-g^{\prime}\right\|_{*},
$$

since $h_{(p, \omega)}=f_{(p, \omega), 1} \circ(i d, g)$ is a homeomorphism.
Notice that

$$
\begin{align*}
& \left\|f_{(p, \omega), 2}(x, g(x))-f_{(p, \omega), 2}\left(x, g^{\prime}(x)\right)\right\| \\
\leq & \left\|\left(f_{(p, \omega), 2}-P\left(E^{s}\left(f_{\omega} p, \theta \omega\right)\right) D_{p} f_{\omega}\right)(x, g(x))-\left(f_{(p, \omega), 2}-P\left(E^{s}\left(f_{\omega} p, \theta \omega\right)\right) D_{p} f_{\omega}\right)\left(x, g^{\prime}(x)\right)\right\| \\
\quad & +\left\|P\left(E^{s}\left(f_{\omega} p, \theta \omega\right)\right) D_{p} f_{\omega}\left(x, g^{\prime}(x)\right)-P\left(E^{s}\left(f_{\omega} p, \theta \omega\right)\right) D_{p} f_{\omega}(x, g(x))\right\| \\
\leq & \left\{\operatorname{Lip}\left(f_{(p, \omega), 2}-P\left(E^{s}\left(f_{\omega} p, \theta \omega\right)\right) D_{p} f_{\omega}\right)+\left\|\left.D_{p} f_{\omega}\right|_{E^{s}(p, \omega)}\right\|\right\} \cdot\left\|g(x)-g^{\prime}(x)\right\| \\
= & \left\{\operatorname{Lip}\left(P\left(E^{s}\left(f_{\omega} p, \theta \omega\right)\right) f_{(p, \omega)}-P\left(E^{s}\left(f_{\omega} p, \theta \omega\right)\right) D_{p} f_{\omega}\right)+\left\|\left.D_{p} f_{\omega}\right|_{E^{s}(p, \omega)}\right\|\right\} \cdot\left\|g(x)-g^{\prime}(x)\right\| \\
< & \left(\mathcal{P} \epsilon^{\prime}+\left\|\left.D_{p} f_{\omega}\right|_{E^{s}(p, \omega)}\right\|\right)\left\|g(x)-g^{\prime}(x)\right\|, \tag{3.63}
\end{align*}
$$

and

$$
\begin{align*}
&\left\|f_{(p, \omega), 1}(x, g(x))-f_{(p, \omega), 1}\left(x, g^{\prime}(x)\right)\right\| \\
& \leq\left\|\left(f_{(p, \omega), 1}-P\left(E^{u}\left(f_{\omega} p, \theta \omega\right)\right) D_{p} f_{\omega}\right)(x, g(x))-\left(f_{(p, \omega), 1}-P\left(E^{u}\left(f_{\omega} p, \theta \omega\right)\right) D_{p} f_{\omega}\right)\left(x, g^{\prime}(x)\right)\right\| \\
& \quad \quad+\left\|P\left(E^{u}\left(f_{\omega} p, \theta \omega\right) D_{p} f_{\omega}\right)(x, g(x))-P\left(E^{u}\left(f_{\omega} p, \theta \omega\right) D_{p} f_{\omega}\right)\left(x, g^{\prime}(x)\right)\right\| \\
& \leq \operatorname{Lip}\left(f_{(p, \omega), 1}-P\left(E^{u}\left(f_{\omega} p, \theta \omega\right)\right) D_{p} f_{\omega}\right)\left\|g(x)-g^{\prime}(x)\right\| \\
&= \operatorname{Lip}\left(P\left(E^{u}\left(f_{\omega} p, \theta \omega\right)\right) f_{(p, \omega)}-P\left(E^{u}\left(f_{\omega} p, \theta \omega\right)\right) D_{p} f_{\omega}\right)\left\|g(x)-g^{\prime}(x)\right\| \\
&< \mathcal{P} \epsilon^{\prime}\left\|g(x)-g^{\prime}(x)\right\| . \tag{3.64}
\end{align*}
$$

Then (3.64) and (3.63) imply that

\begin{align*}
&\left\|\left(\phi_{(p, \omega)}^{*} g\right)\left(f_{(p, \omega), 1}(x, g(x))\right)-\left(\phi_{(p, \omega)}^{*} g^{\prime}\right)\left(f_{(p, \omega), 1}(x, g(x))\right)\right\|  \tag{3.65}\\
&=\left\|f_{(p, \omega), 2}(x, g(x))-\left(\phi_{(p, \omega)}^{*} g^{\prime}\right)\left(f_{(p, \omega), 1}(x, g(x))\right)\right\| \\
& \leq\left\|f_{(p, \omega), 2}(x, g(x))-f_{(p, \omega), 2}\left(x, g^{\prime}(x)\right)\right\|+\left\|f_{(p, \omega), 2}\left(x, g^{\prime}(x)\right)-\left(\phi_{(p, \omega)}^{*} g^{\prime}\right)\left(f_{(p, \omega), 1}(x, g(x))\right)\right\| \\
& \stackrel{(3.63)}{\leq}\left(\mathcal{P} \epsilon^{\prime}+\left\|\left.D_{p} f_{\omega}\right|_{E^{s}(p, \omega)}\right\|\right)\left\|g(x)-g^{\prime}(x)\right\| \\
& \quad+\left\|\left(\phi_{(p, \omega)}^{*} g^{\prime}\right)\left(f_{(p, \omega), 1}\left(x, g^{\prime}(x)\right)\right)-\left(\phi_{(p, \omega)}^{*} g^{\prime}\right)\left(f_{(p, \omega), 1}(x, g(x))\right)\right\| \\
& \leq\left(\mathcal{P} \epsilon^{\prime}+\left\|\left.D_{p} f_{\omega}\right|_{E^{s}(p, \omega)}\right\|\right)\left\|g(x)-g^{\prime}(x)\right\|+\operatorname{Lip}\left(\phi_{(p, \omega)}^{*} g^{\prime}\right)\left\|f_{(p, \omega), 1}(x, g(x))-f_{(p, \omega), 1}\left(x, g^{\prime}(x)\right)\right\|
\end{align*}
$$

$$
\begin{equation*}
\stackrel{(3.64)}{<}\left(2 \mathcal{P} \epsilon^{\prime}+\left\|\left.D_{p} f_{\omega}\right|_{E^{s}(p, \omega)}\right\|\right)\left\|g(x)-g^{\prime}(x)\right\| \tag{3.66}
\end{equation*}
$$

On the other hand,

$$
\begin{align*}
\left\|f_{(p, \omega), 1}(x, g(x))\right\| & =\left\|\left(f_{(p, \omega), 1}-P\left(E^{u}\left(f_{\omega} p, \theta \omega\right)\right) D_{p} f_{\omega}\right)(x, g(x))+P\left(E^{u}\left(f_{\omega} p, \theta \omega\right)\right) D_{p} f_{\omega}(x, g(x))\right\| \\
& \stackrel{(3.58)}{\geq} m\left(\left.D_{p} f_{\omega}\right|_{E^{u}(p, \omega)}\right)\|x\|-\mathcal{P} \epsilon^{\prime}\|(x, g(x))\| \\
& \geq\left(m\left(\left.D_{p} f_{\omega}\right|_{E^{u}(p, \omega)}\right)-2 \mathcal{P} \epsilon^{\prime}\right)\|x\|,
\end{align*}
$$

where we use $\|g(x)\|=\|g(x)-g(0)\| \leq\|x\|$ in the last step. Now (3.62) follows by (3.66), (3.67) and (3.57).

By Sublemma 3.2, $\phi^{*}: G \rightarrow G$ defined by

\left\{\left(p, \omega, g_{(p, \omega)}\right):(p, \omega) \in M \times \Omega, g_{(p, \omega)} \in G_{(p, \omega)}\right\} \mapsto\left\{\left(f_{\omega}(p), \theta \omega, \phi_{(p, \omega)}^{*} g_{(p, \omega)}\right):(p, \omega) \in M \times \Omega\right\}
$$

is a fiber contraction. Then there exists a unique section $g^{*}: M \times \Omega \rightarrow G$ which is invariant under $\phi^{*}$ in the sense that for all $(p, \omega) \in M \times \Omega$,

g_{\left(f_{\omega}(p), \theta \omega\right)}^{*}=\phi_{(p, \omega)}^{*} g_{(p, \omega)}^{*} .
$$

In fact, we can consider the space $\Sigma$ of all sections $g: M \times \Omega \rightarrow G$. Note that

\sup _{(p, \omega) \in M \times \Omega}\left\{\left\|g_{(p, \omega)}-g_{(p, \omega)}^{\prime}\right\|_{*}: g_{(p, \omega)}, g_{(p, \omega)}^{\prime} \in G_{(p, \omega)}\right\} \stackrel{(3.56)}{\leq} e^{-2 \lambda}+1<\infty .
$$

Therefore, $\tilde{d}\left(g, g^{\prime}\right)=\sup \left\{\left\|g_{(p, \omega)}-g_{(p, \omega)}^{\prime}\right\|_{*}: \quad(p, \omega) \in M \times \Omega\right\}$ for any $g, g^{\prime} \in \Sigma$ gives a metric on $\Sigma$. Moreover, $\Sigma$ is complete since $G_{(p, \omega)}$ is closed. By sublemma 3.2, the action of $\phi^{*}$ on $\Sigma$ is clearly a contraction mapping. The unique fixed point of $\phi^{*}$ is the unique invariant section. By virtue of contraction mapping theorem, one also can obtain the unique invariant section $g^{*}$ by iterating any section $g \in G$, i.e.,

$$
\begin{equation*}
g_{(p, \omega)}^{*}=\lim _{n \rightarrow \infty}\left(\left(\phi^{*}\right)^{n} g\right)_{(p, \omega)}=\lim _{n \rightarrow \infty} \phi_{\left(f_{\omega}^{-1} p, \theta^{-1} \omega\right)}^{*} \cdots \phi_{\left(f_{\omega}^{-n} p, \theta^{-n} \omega\right)}^{*} g_{\left(f_{\omega}^{-n} p, \theta^{-n} \omega\right)}, \tag{3.68}
\end{equation*}
$$

for any $(p, \omega) \in M \times \Omega$.
By the stable and unstable manifolds theorem, we know that the local unstable manifold passing through $p$ on the fiber $M \times\{\omega\}$ is exactly $\operatorname{Exp}_{p}\left(\operatorname{graph}\left(g_{(p, \omega)}^{*}\right)\right)$. Next, we will show that the bundle map $\phi^{*}$ preserves a local Hölder property for an appropriate Hölder exponent.

Since $E^{u}(x, \omega)$ and $E^{s}(x, \omega)$ are uniformly continuous depending on $(x, \omega) \in M \times \Omega$, with the help of local coordinate charts, we may pick a sufficiently small $\delta_{0} \in\left(0, \frac{\epsilon}{2 \mathcal{P}}\right)$ such that whenever $d(p, q)<\delta_{0}$, for any $\omega \in \Omega, g_{(q, \omega)}: E^{u}(q, \omega)(\epsilon) \rightarrow E^{s}(q, \omega)$ with $\operatorname{Lip}\left(g_{(q, \omega)}\right)<\frac{e^{-2 \lambda_{0}+1}}{2}$ can be viewed as a Lipschitz mapping from $E^{u}(p, \omega)\left(\delta_{0}\right)$ to $E^{s}(p, \omega)$ with Lipschtiz constant less than 1 with respect to the coordinate $E^{u}(p, \omega) \oplus E^{s}(p, \omega)$. We use notation $\left(g_{(q, \omega)}\right)^{(p, \omega)}$ to represent $g_{(q, \omega)}$ in the coordinate $E^{u}(p, \omega) \oplus E^{s}(p, \omega)$.

From now on, we fix this $\delta_{0}$. We pick $N>0$ depending on $\delta_{0}$ such that

$$
\begin{equation*}
e^{-N \lambda}<\frac{\delta_{0}}{2 \sup _{(x, \omega) \in M \times \Omega}\left\|D_{x} f_{\omega}^{-1}\right\|} \tag{3.69}
\end{equation*}
$$

For any constant $K>0$ and $\varrho \in(0,1)$, we define

$$
G\left(\delta_{0}, \varrho, e^{-N \lambda}, K\right):=\left\{g \in G: \sup _{x \in E^{u}(p, \omega)\left(\delta_{0}\right)}\left\|g_{(p, \omega)}(x)-\left(g_{(q, \omega)}\right)^{(p, \omega)}(x)\right\| \leq K d(p, q)^{\varrho},\right.
$$

$$
\text { whenever } \left.e^{-N \lambda}<d(p, q)<\delta_{0}\right\} \text {. }
$$

Sublemma 3.3. There exists a constant $C=C\left(\delta_{0}\right)$ such that $G \subset G\left(\delta_{0}, \varrho, e^{-N \lambda}, C\left(\delta_{0}\right) e^{N \lambda \varrho}\right)$.
Proof of Sublemma 3.3. Notice that both the Lipschitz constants of $g_{(p, \omega)}$ and $\left(g_{(q, \omega)}\right)^{(p, \omega)}$ are less than 1 , and $d(p, q)<\delta_{0}$, hence there exists a constant $C=C\left(\delta_{0}\right)>0$ such that

\sup _{x \in E^{u}(p, \omega)\left(\delta_{0}\right)}\left\|g_{(p, \omega)}(x)-\left(g_{(q, \omega)}\right)^{(p, \omega)}(x)\right\| \leq C .

Notice that $d(p, q)>e^{-N \lambda}$, so we have

For any $g_{(q, \omega)} \in G_{(q, \omega)}$, the proof of Sublemma 3.2 implies that $\phi_{(q, \omega)}^{*} g_{(q, \omega)} \in G_{\left(f_{\omega} q, \theta \omega\right)}$ and $\operatorname{Lip}\left(\phi_{(q, \omega)}^{*} g_{(q, \omega)}\right) \leq \frac{e^{-2 \lambda}+1}{2}$. If $d\left(f_{\omega} p, f_{\omega} q\right)<\delta_{0}$, then $\left.\operatorname{Lip}\left(\left(\phi_{(q, \omega)}^{*} g_{(q, \omega)}\right)\right)^{\left(f_{\omega} p, \theta \omega\right)}\right)<1$ by the choice of $\delta_{0}$.

Sublemma 3.4. Let $g \in G$, if $d(p, q)<\delta_{0}, d\left(f_{\omega} p, f_{\omega} q\right)<\delta_{0}$, and $\sup _{x \in E^{u}(p, \omega)\left(\delta_{0}\right)} \| g_{(p, \omega)}(x)-$ $\left(g_{(q, \omega)}\right)^{(p, \omega)}(x) \| \leq K d(p, q)^{\varrho}$ for some constant $K$, then

provided $\varrho \in(0,1)$ satisfying

\sup _{(p, \omega) \in M \times \Omega}\left\|\left.D_{p} f_{\omega}\right|_{E^{s}(p, \omega)}\right\| t_{(p, \omega)}^{-\varrho}<1, \tag{3.71}

t_{(p, \omega)}:=\inf \left\{\frac{d\left(f_{\omega} p, f_{\omega} q\right)}{d(p, q)}: q \in M, d(p, q)<\epsilon\right\}>0 \tag{3.72}

Proof of Sublemma 3.4. We use the same notations as in the proof of Sublemma 3.2. By (3.71), we can pick a constant $\epsilon^{\prime}>0$ sufficiently small satisfying both (3.57) and

&=\left\|f_{(p, \omega), 2}\left(x, g_{(p, \omega)}(x)\right)-\left(\phi_{(q, \omega)}^{*} g_{(q, \omega))}\right) f_{\omega}^{\left(f_{\omega} p, \theta \omega\right)}\left(f_{(p, \omega), 1}\left(x, g_{(p, \omega)}(x)\right)\right)\right\| \\
& \leq\left\|f_{(p, \omega), 2}\left(x, g_{(p, \omega)}(x)\right)-f_{(p, \omega), 2}\left(x,\left(g_{(q, \omega)}\right)^{(p, \omega)}(x)\right)\right\| \\
&\left.\quad+\|\left(\phi_{(q, \omega)}^{*} g_{(q, \omega)}\right)\right)^{\left(f_{\omega} p, \theta \omega\right)}\left(f_{(p, \omega), 1}\left(x,\left(g_{(q, \omega)}\right)^{(p, \omega)}(x)\right)\right)-\left(\phi_{(q, \omega)}^{*} g_{(q, \omega)}\right)^{\left(f_{\omega} p, \theta \omega\right)}\left(f_{(p, \omega), 1}\left(x, g_{(p, \omega)}(x)\right)\right) \| \\
& \stackrel{(3.63)}{\leq}\left(\mathcal{P} \epsilon^{\prime}+\left\|\left.D_{p} f_{\omega}\right|_{E^{s}(p, \omega)}\right\|\right)\left\|g_{(p, \omega)}(x)-\left(g_{(q, \omega)}\right)^{(p, \omega)}(x)\right\|
\end{aligned}
$$

$$
\begin{aligned}
& \left.\quad+\operatorname{Lip}\left(\phi_{(q, \omega)}^{*} g_{(q, \omega)}\right)^{\left(f_{\omega} p, \theta \omega\right)}\right) \| f_{(p, \omega), 1}\left(x,\left(g_{\left.(q, \omega))^{(p, \omega)}(x)\right)-f_{(p, \omega), 1}\left(x, g_{(p, \omega)}(x)\right) \|} \stackrel{(3.64)}{\leq}\left(2 \mathcal{P} \epsilon^{\prime}+\left\|\left.D_{p} f_{\omega}\right|_{E^{s}(p, \omega)}\right\|\right) \sup _{x \in E^{u}(p, \omega)\left(\delta_{0}\right)}\left\|g_{(p, \omega)}(x)-\left(g_{(q, \omega)}\right)^{(p, \omega)}(x)\right\|\right.\right. \\
& \leq\left(2 \mathcal{P} \epsilon^{\prime}+\left\|\left.D_{p} f_{\omega}\right|_{E^{s}(p, \omega)}\right\|\right) K d(p, q)^{\varrho} \\
& \leq\left(2 \mathcal{P} \epsilon^{\prime}+\left\|\left.D_{p} f_{\omega}\right|_{E^{s}(p, \omega)}\right\|\right) K t_{(p, \omega)}^{-\varrho} d\left(f_{\omega} p, f_{\omega} q\right)^{\varrho} \\
& \stackrel{(3.73)}{\leq} K d\left(f_{\omega} p, f_{\omega} q\right)^{\varrho},
\end{aligned}
$$

where we note that in inequality (3.63) and (3.64), $g^{\prime}$ can be replaced by $\left(g_{(q, \omega)}\right)^{(p, \omega)}$. Notice that $h_{(p, \omega)}=f_{(p, \omega), 1} \circ\left(i d, g_{(p, \omega)}\right)$ is a homeomorphism, hence we get (3.70).

where $\left(\phi^{*}\right)^{n}$ is the $n$-th iteration of $\phi^{*}$.
Sublemma 3.5. $\left\{(s, t) \in M \times M \mid t \notin W_{\delta_{0}}^{u}(s, \omega), d(s, t)<\delta_{0}\right\} \subset \cup_{n=0}^{\infty} S_{n}(\omega)$.
Proof of Sublemma 3.5. Now for any $(s, t) \in\left\{(s, t) \in M \times M \mid t \notin W_{\delta_{0}}^{u}(s, \omega), d(s, t)<\delta_{0}\right\}$. If $d(s, t)>e^{-N \lambda}$, then $(s, t) \in R_{0}(\omega)$. If $d(s, t) \leq e^{-N \lambda}$, We note that $t \in W_{\delta_{0}}^{s}\left([t, s]_{\omega}, \omega\right)$, where $[t, s]_{\omega}=W_{l o c}^{s}(t, \omega) \cap W_{l o c}^{u}(s, \omega)$. Then

d\left(f_{\omega}^{-n}(s), f_{\omega}^{-n}(t)\right) \geq d\left(f_{\omega}^{-n}\left([t, s]_{\omega}\right), f_{\omega}^{-n}(t)\right)-d\left(f_{\omega}^{-n}\left([t, s]_{\omega}\right), f_{\omega}^{-n}(s)\right),
$$

when tends to $\infty$ as $n \rightarrow \infty$. By (3.69), there exists a time $l \in \mathbb{N}$ such that $d\left(f_{\omega}^{-l} s, f_{\omega}^{-l} t\right) \in\left(e^{-N \lambda}, \delta_{0}\right)$ and $d\left(f_{\omega}^{-i} s, f_{\omega}^{-i} t\right) \leq e^{-N \lambda}<\delta_{0}$ for $i \in\{0,1, \ldots, l-1\}$. So $(s, t) \in R_{l}(\omega)$. In both cases, $(s, t) \in$ $\cup_{n=0}^{\infty} S_{n}(\omega)$. This finishes the proof of Sublemma 3.5.

Hence the fix point obtained by (3.68) has the property that for any $p, q \in M, d(p, q)<\delta_{0}$ and $q \notin W_{\delta_{0}}^{u}(p, \omega)$,

and we note that (3.74) is automatically true if $q \in W_{\delta_{0}}^{u}(p, \omega)$. Hence (3.54) holds. A similar proof can be applied to the stable manifold by reversing time.

Now let $y_{0}, y_{1} \in \operatorname{graph}\left(\left.g_{(p, \omega)}^{*}\right|_{E^{u}(p, \omega)\left(\delta_{0}\right)}\right)$, let $q \in M$ and $d(p, q)<\delta_{0}$. Let

w_{0}:=\operatorname{Exp}_{p}^{-1}\left(W_{l o c}^{s}\left(\operatorname{Exp}_{p}\left(y_{0}\right), \omega\right)\right) \cap \operatorname{graph}\left(\left(g_{(q, \omega)}^{*}\right)^{(p, \omega)}\right),
$$

and

w_{1}:=\operatorname{Exp}_{p}^{-1}\left(W_{l o c}^{s}\left(\operatorname{Exp}_{p}\left(y_{1}\right), \omega\right)\right) \cap \operatorname{graph}\left(\left(g_{(q, \omega)}^{*}\right)^{(p, \omega)}\right) .
$$

Sublemma 3.6. When $\delta_{0}$ sufficiently small, there exists a constant $\hat{C}$ such that

since $\left\|D_{0}\left(g_{p, \omega}^{*}\right)^{(p, \omega)}\right\|=0$ and $C^{1}$ continuity of local unstable manifolds as in (3) of Lemma 3.2. By the similar reason, the local stable manifold $\operatorname{Exp}_{p}^{-1}\left(W_{\delta_{0}}^{s}(\operatorname{Exp}(y), \omega)\right)$ for any $y \in \operatorname{graph}\left(\left.g_{(p, \omega)}^{*}\right|_{E^{u}(p, \omega)\left(\delta_{0}\right)}\right)$, as a graph of $C^{2}$ function from $E^{s}(p, \omega)$ to $E^{u}(p, \omega)$, has coslope $\leq L^{\prime}$, provided $\delta_{0}>0$ sufficiently small.

Now for $y_{0}, z_{0}$ and $w_{0}$ defined as above, then $w_{0}$ lies in an area constrained by the following two cones:

i.e., the fiber holonomy map between local stable manifolds is uniformly $\varrho$-Hölder continuous at a small scale. A similar result holds for fiber holonomy map between local unstable manifolds. Let $H^{\prime}=\hat{C}^{1+\varrho} H\left(\delta_{0}, \varrho\right)$, then the proof of Proposition 3.2 is complete.
3.6. Properties of the holonomy map between a pair of local stable leaves. In this subsection, the properties of the Holonomy maps are further discussed.

For each $\omega \in \Omega, \tilde{\gamma}(\omega)$ and $\gamma(\omega)$ is said to be a pair of nearby local stable leaves if $\tilde{\gamma}(\omega)$ and $\gamma(\omega)$ are local stable manifolds and the fiber holonomy map $\psi_{\omega}: \tilde{\gamma}(\omega) \rightarrow \gamma(\omega)$ by $\psi_{\omega}(x)=W_{\epsilon}^{u}(x, \omega) \cap \gamma(\omega)$ for $x \in \tilde{\gamma}(\omega)$ is a homeomorphism. From the proof of Proposition 3.1, we know that $\psi_{\omega}$ is absolutely continuous and we have

$$
\begin{equation*}
\operatorname{Jac}\left(\psi_{\omega}\right)(x)=\lim _{n \rightarrow \infty} \frac{\left|\operatorname{det}\left(\left.D_{x} f_{\omega}^{-n}\right|_{E^{s}(x, \omega)}\right)\right|}{\left|\operatorname{det}\left(\left.D_{\psi_{\omega}(x)} f_{\omega}^{-n}\right|_{E^{s}\left(\psi_{\omega}(x), \omega\right)}\right)\right|}, \tag{3.76}
\end{equation*}
$$

where $\operatorname{Jac}\left(\psi_{\omega}\right)$ denotes the Jacobian of $\psi_{\omega}$, and $f_{\omega}^{-n}$ is defined in (2.1). The time in (3.76) goes backward since the holonomy map in this section is induced by unstable manifolds, while in the proof of Proposition 3.1, the holonomy map is induced by local stable manifolds.

In the following, we restrict the size of local stable and unstable manifolds $W_{\epsilon}^{s}(x, \omega), W_{\epsilon}^{u}(x, \omega)$ satisfying $\epsilon \leq \min \left\{\epsilon_{0}, \delta_{0}\right\}$ to guarantee the Hölder continuity of the stable and unstable foliations, where $\delta_{0}$ is the constant in Proposition 3.2.

Lemma 3.12. There exist constants $a_{0}^{\prime}>0$ and $\nu_{0} \in(0,1)$ only depending on system $\phi$ such that for any $\psi_{\omega}: \tilde{\gamma}(\omega) \rightarrow \gamma(\omega)$ fiber holonomy map of a pair of nearby random local stable leaves, the followings hold:
(1) $\psi_{\omega}$ and $\log \operatorname{Jac}\left(\psi_{\omega}\right)$ are $\left(a_{0}^{\prime}, \nu_{0}\right)$-Hölder continuous;
(2) $\left|\log \operatorname{Jac}\left(\psi_{\omega}\right)(y)\right| \leq a_{0}^{\prime} d\left(y, \psi_{\omega}(y)\right)^{\nu_{0}}$ for every $y \in \tilde{\gamma}(\omega)$;
(3) $d\left(f_{\omega}^{-1} x, f_{\omega}^{-1} \psi_{\omega}(x)\right) \leq e^{-\lambda} d\left(x, \psi_{\omega}(x)\right)$.

Proof of Lemma 3.12. In Proposition 3.2, we have proved that $\psi_{\omega}$ is $\left(H^{\prime}, \varrho\right)$-Hölder continuous for all $\omega \in \Omega$. To prove the other statements, we need the following fact: there exists a constant $C_{13}>0$ such that for any $n \geq 0, x \in \tilde{\gamma}(\omega)$,

\frac{\left|\operatorname{det}\left(\left.D_{f_{\omega}^{-n} x} f_{\theta^{-n} \omega}^{-1}\right|_{E^{s}\left(f_{\omega}^{-n} x, \theta^{-n} \omega\right)}\right)\right|}{\left|\operatorname{det}\left(\left.D_{f_{\omega}^{-n} \psi_{\omega}(x)} f_{\theta^{-n} \omega}^{-1}\right|_{E^{s}\left(f_{\omega}^{-n} \psi_{\omega}(x), \theta^{-n} \omega\right)}\right)\right|} \leq 1+C_{13} e^{-\lambda n \nu_{1}} d\left(x, \psi_{\omega}(x)\right)^{\nu_{1}} . \tag{3.77}
\end{equation*}
$$

In fact, this is a consequence of (3.42) and the following inequality

& \left.\quad \mid \operatorname{det}\left(\left.D_{f_{\omega}^{-n} x} f_{\theta^{-n} \omega}^{-1}\right|_{E^{s}\left(f_{\omega}^{-n} x, \theta^{-n} \omega\right)}\right)-\operatorname{det}\left(\left.D_{f_{\omega}^{-n}} \psi_{\omega}(x) f_{\theta^{-n} \omega}^{-1}\right|_{E^{s}\left(f_{\omega}^{-n}\right.} \psi_{\omega}(x), \theta^{-n} \omega\right)\right) \mid \\
& \leq C_{2}\left[d\left(f_{\omega}^{-n} x, f_{\omega}^{-n} \psi_{\omega}(x)\right)+d\left(E^{s}\left(f_{\omega}^{-n} x, \theta^{-n} \omega\right), E^{s}\left(f_{\omega}^{-n} \psi_{\omega}(x), \theta^{-n} \omega\right)\right)\right] \\
& \stackrel{(3.2)}{\leq} C_{2} e^{-\lambda n} d\left(x, \psi_{\omega}(x)\right)+C_{2} C_{1} e^{-\lambda n \nu_{1}} d\left(x, \psi_{\omega}(x)\right)^{\nu_{1}} \\
& \leq\left(C_{2}+C_{2} C_{1}\right) e^{-\lambda n \nu_{1}} d\left(x, \psi_{\omega}(x)\right)^{\nu_{1}} .
\end{aligned}
$$

We first prove statement (2). As a consequence of (3.76) and (3.77), we have

& \leq \sum_{j=0}^{\infty} C_{13} e^{-\lambda j \nu_{1}} d\left(x, \psi_{\omega}(x)\right)^{\nu_{1}} \text { for any } x \in \tilde{\gamma}(\omega) .
\end{align*}
$$

Symmetrically, we have

\frac{1}{\operatorname{Jac}\left(\psi_{\omega}\right)(x)}=\operatorname{Jac}\left(\psi_{\omega}^{-1}\right)\left(\psi_{\omega}(x)\right) \leq \sum_{j=0}^{\infty} C_{13} e^{-\lambda j \nu_{1}} d\left(x, \psi_{\omega}(x)\right)^{\nu_{1}} \text { for any } x \in \tilde{\gamma}(\omega) .
$$

Therefore,

Next, we prove the Hölder continuity of $\log \operatorname{Jac}\left(\psi_{\omega}\right)$. Pick any $x, y \in \tilde{\gamma}(\omega)$, we consider two cases: (case 1) $d\left(x, \psi_{\omega}(x)\right) \leq d(x, y)$ and (case 2) $d\left(x, \psi_{\omega}(x)\right)>d(x, y)$.

In (case 1), applying Proposition 3.2, we have

Then property (1) and (2) are proved.

Property (3) follows the definition of holonomy map and contraction on local unstable manifolds when reverse time. The proof of Lemma 3.12 is complete.
3.7. Measure disintegration on rectangles. We call $R(\omega) \subset M$ a rectangle if it is foliated by local stable manifolds and it has the local product structure. By the lemma 3.12, for any rectangle $R(\omega)$ in small scale, the holonomy map between stable manifolds (resp. unstable manifolds) lying in $R(\omega)$ is absolutely continuous. As a consequence of this absolute continuity and Fubini's theorem, in [29, Chapter III section 6], the authors proved that on each local stable leaves, the disintegration of the Riemannian volume measure is equivalent to the inherited Riemannian measure. In here, we explore the corresponding Radon-Nikodym derivative of these two measures. The proof of this statement is parallel to the treatment of [33, Theorem 7.8].

Proposition 3.3. There exist constant $a_{0}^{\prime \prime}$ only depending on the system such that for each $\omega \in \Omega$ and any rectangle $R(\omega)=\left[W_{\epsilon}^{u}\left(x_{0}, \omega\right), W_{\epsilon}^{s}\left(x_{0}, \omega\right)\right]$, there exists a measurable function $H(\omega): R(\omega) \rightarrow \mathbb{R}^{+}$ such that for any bounded measurable function $\psi: M \rightarrow \mathbb{R}$, there is a disintegration

where $\gamma(\omega)$ denote the stable foliations in $R(\omega)$, and $\tilde{m}_{R(\omega)}$ is the quotient measure induced by Riemannian volume measure in the space of local stable leaves in $R(\omega)$. Moreover, for any local
stable leaves $\gamma(\omega) \subset R(\omega)$, one has

Moreover, $R(\omega) \subset E^{u}\left(x_{0}, \omega\right)(r) \oplus E^{u}\left(x_{0}, \omega\right)^{\perp}(r)$ for some $r>0$, where $E^{u}\left(x_{0}, \omega\right)(r)$ and $E^{u}\left(x_{0}, \omega\right)^{\perp}(r)$ are $r$-disks. We consider the following partition of $E^{u}\left(x_{0}, \omega\right)(r) \oplus E^{u}\left(x_{0}, \omega\right)^{\perp}(r)$

Denote $\xi=\psi_{\omega ; 0, \eta}^{s}\left(\xi^{\prime}\right)$ for $\xi^{\prime} \in D_{\omega}(0)$, then we have

By changing of coordinate $\eta^{\prime}=h_{\left(x_{0}, \omega\right)}^{s}(\eta)$ for $\eta \in E^{u}\left(x_{0}, \omega\right)^{\perp}(r)$, we have

Denote $\psi_{\omega ; \xi^{\prime}, 0}^{u}: W_{r}^{s}\left(\xi^{\prime}, \omega\right) \rightarrow W_{r}^{s}\left(x_{0}, \omega\right)$ to be the holonomy map induced by the local unstable manifolds, where $W_{r}^{s}\left(\xi^{\prime}, \omega\right)$ is the local stable manifold passing through $\xi^{\prime} \in E^{u}\left(x_{0}, \omega\right)$. By change of coordinate $\zeta=\left(\psi_{\omega ; \xi^{\prime} ; 0}^{u}\right)^{-1}\left(\eta^{\prime}\right)$ for $\eta^{\prime} \in W_{r}^{s}\left(x_{0}, \omega\right)$, we have

$$
m(A)=\int_{D_{\omega}(0)} \int_{W_{r}^{s}(\xi, \omega)} 1_{A}(\xi, \eta) \cdot \operatorname{Jac}\left(\psi_{\omega ; 0, \eta}^{s}\right)\left(\xi^{\prime}\right) \cdot \frac{\operatorname{Jac}\left(\psi_{\omega ; \xi^{\prime}, 0}^{u}\right)(\zeta)}{\operatorname{Jac}\left(h_{\left(x_{0}, \omega\right)}^{s}\right)(\eta)} d m_{W_{r}^{s}\left(\xi^{\prime}, \omega\right)}(\zeta) d m_{D_{\omega}(0)}\left(\xi^{\prime}\right),
$$

which implies that in (3.85),

- the space of local stable leaves is identified with $D_{\omega}(0)$ and $\tilde{m}_{R(\omega)}=m_{D(\omega)(0)}$.
- $H(\omega)(\zeta)=\operatorname{Jac}\left(\psi_{\omega ; 0, \eta}^{s}\right)\left(\xi^{\prime}\right) \cdot \frac{\operatorname{Jac}\left(\psi_{\omega ; \xi^{\prime}, 0}^{u}\right)(\zeta)}{\operatorname{Jac}\left(h_{\left(x_{0}, \omega\right)}^{s}\right)(\eta)}$ for $\zeta \in W_{r}^{s}\left(\xi^{\prime}, \omega\right)$, where $\eta=\left(h_{\left(x_{0}, \omega\right)}^{s}\right)^{-1}\left(\psi_{\omega ; \xi^{\prime}, 0}^{u}(\zeta)\right)$;

Next, let us verify the Hölder continuity of $\log H(\omega)$ on each local stable manifold $W_{r}^{s}\left(\xi^{\prime}, \omega\right)$. Pick any $\zeta_{1}, \zeta_{2} \in W_{r}^{s}\left(\xi^{\prime}, \omega\right)$ and corresponding $\eta_{1}=\left(h_{\left(x_{0}, \omega\right)}^{s}\right)^{-1}\left(\psi_{\omega ; \xi^{\prime}, 0}^{u}\left(\zeta_{1}\right)\right), \eta_{2}=\left(h_{\left(x_{0}, \omega\right)}^{s}\right)^{-1}\left(\psi_{\omega ; \xi^{\prime}, 0}^{u}\left(\zeta_{2}\right)\right)$. By (3.53), we have

\operatorname{Jac}\left(\psi_{\omega ; 0, \eta}^{s}\right)\left(\xi^{\prime}\right)=\lim _{n \rightarrow \infty} \frac{\left|\operatorname{det} D_{\xi^{\prime}} f_{\omega}^{n}\right| E^{u}\left(x_{0}, \omega\right) \mid}{\left|\operatorname{det} D_{\psi_{\omega ; 0, \eta}^{s}\left(\xi^{\prime}\right)} f_{\omega}^{n}\right|_{E^{u}\left(x_{0}, \omega\right)} \mid}
$$

We notice that $\zeta_{1}=\psi_{\omega ; 0, \eta_{1}}^{s}\left(\xi^{\prime}\right)$ and $\zeta_{2}=\psi_{\omega ; 0, \eta_{2}}^{s}\left(\xi^{\prime}\right)$. Therefore,

$$
\begin{aligned}
\frac{\operatorname{Jac}\left(\psi_{\omega ; 0, \eta_{1}}^{s}\right)\left(\xi^{\prime}\right)}{\operatorname{Jac}\left(\psi_{\omega ; 0, \eta_{2}}^{s}\right)\left(\xi^{\prime}\right)} & \left.=\left.\lim _{n \rightarrow \infty} \frac{\mid \operatorname{det} D_{\psi_{\omega}^{s} ; 0, \eta_{2}}\left(\xi^{\prime}\right)}{} f_{\omega}^{n}\right|_{E^{u}\left(x_{0}, \omega\right)} \right\rvert\, \\
& \leq \prod_{i=0}^{\infty}\left(1+C_{10} C_{2} d\left(f_{\omega}^{i}\left(\zeta_{1}\right), f_{\omega}^{i}\left(\zeta_{2}\right)\right)\right) \\
& \leq \lim _{\omega \rightarrow 0, \eta_{1}}\left(\xi^{\prime}\right) f_{\omega}^{n}\left|E^{u}\left(x_{0}, \omega\right)\right|
\end{aligned} \frac{\left|\operatorname{det} D_{\zeta_{2}} f_{\omega}^{n}\right| E^{u}\left(x_{0}, \omega\right) \mid}{\left|\operatorname{det} D_{\zeta_{1}} f_{\omega}^{n}\right| E^{u}\left(x_{0}, \omega\right) \mid}
$$

where $C_{2}$ and $C_{10}$ comes from Lemma 3.4 and (3.42). Hence, we have

$$
\begin{equation*}
\left|\log \operatorname{Jac}\left(\psi_{\omega ; 0, \eta_{1}}^{s}\right)\left(\xi^{\prime}\right)-\log \operatorname{Jac}\left(\psi_{\omega ; 0, \eta_{2}}^{s}\right)\left(\xi^{\prime}\right)\right| \leq \frac{C_{10} C_{2}}{1-e^{-\lambda}} d\left(\zeta_{1}, \zeta_{2}\right) . \tag{3.86}
\end{equation*}
$$

Note that $\psi_{\omega ; \xi^{\prime}, 0}^{u}: W_{r}^{s}\left(\xi^{\prime}, \omega\right) \rightarrow W_{r}^{s}\left(x_{0}, \omega\right)$ is the holonomy map between local stable manifolds. By Lemma 3.12, we have

\left|\log \operatorname{Jac}\left(\psi_{\omega ; \xi^{\prime}, 0}^{u}\right)\left(\zeta_{1}\right)-\log \operatorname{Jac}\left(\psi_{\omega ; \xi^{\prime}, 0}^{u}\right)\left(\zeta_{2}\right)\right| \leq a_{0}^{\prime} d\left(\zeta_{1}, \zeta_{2}\right)^{\nu_{0}} . \tag{3.87}
\end{equation*}
$$

By Lemma 3.2, there exists a constant $C_{s}>0$ such that

$$
\begin{align*}
& \left|\log \operatorname{Jac}\left(h_{\left(x_{0}, \omega\right)}^{s}\right)\left(\eta_{1}\right)-\log \operatorname{Jac}\left(h_{\left(x_{0}, \omega\right)}^{s}\right)\left(\eta_{2}\right)\right|  \tag{3.88}\\
\leq & C_{s}\left\|\eta_{1}-\eta_{2}\right\| \leq C_{s} d\left(\psi_{\omega ; \xi^{\prime}, 0}^{u}\left(\zeta_{1}\right), \psi_{\omega ; \xi^{\prime}, 0}^{u}\left(\zeta_{2}\right)\right) \leq C_{s} a_{0}^{\prime} d\left(\zeta_{1}, \zeta_{2}\right)^{\nu_{0}} .
\end{align*}
$$

Inequalities (3.86), (3.87) and (3.88) imply that

$$
\left|\log H(\omega)\left(\zeta_{1}\right)-\log H(\omega)\left(\zeta_{2}\right)\right| \leq \max \left\{\frac{C_{10} C_{2}}{1-e^{-\lambda}}, a_{0}^{\prime}, C_{s} a_{0}^{\prime}\right\} d\left(\zeta_{1}, \zeta_{2}\right)^{\nu_{0}}:=a_{0}^{\prime \prime} d\left(\zeta_{1}, \zeta_{2}\right)^{\nu_{0}}
$$

The proof of Proposition 3.3 is complete.

## 4. Proof of Main Result

In this section, we prove Theorem 1. The proof is based on the study of the fiber transfer operator $L_{\omega}$, which is defined by

$$
\begin{equation*}
L_{\omega} \varphi: M \rightarrow \mathbb{R},\left(L_{\omega} \varphi\right)(x):=\frac{\varphi\left(\left(f_{\omega}\right)^{-1} x\right)}{\left|\operatorname{det} D_{\left(f_{\omega}\right)^{-1}(x)} f_{\omega}\right|} \tag{4.1}
\end{equation*}
$$

for any bounded and measurable observable $\varphi: M \rightarrow \mathbb{R}$. We denote

$$
L_{\omega}^{n}:=L_{\theta^{n-1} \omega} \circ \cdots \circ L_{\theta \omega} \circ L_{\omega} \text { for any } \omega \in \Omega \text { and } n \in \mathbb{N} .
$$

We first construct the suitable convex cone of observables $C_{\omega}$ on each fiber in Subsection 4.1. Then in Subsection 4.2, we prove that the transfer operator $L_{\omega}$ maps $C_{\omega}$ into $C_{\theta \omega}$. Moreover, $L_{\omega}^{N} C_{\omega}$ has finite diameter with respect to the projective metric on the cone $C_{\theta^{N} \omega}$, and this diameter is independent of $\omega$, where $N$ comes from the topological mixing on fibers property. Birkhoff's inequality implies the contraction of $L_{\omega}^{N}: C_{\omega} \rightarrow C_{\theta^{N} \omega}$ for all $\omega \in \Omega$. In Subsection 4.3, we explore the relationship between the unique random SRB measure and the operator $L_{\theta^{-n} \omega}^{n}$. We show the exponential decay of past and future correlations in Subsection 4.4 and Subsection 4.5 respectively by using the contraction of $L_{\theta^{-n} \omega}^{n}$ and $L_{\omega}^{n}$ for $n \geq N$.

Before starting the proof, we recall some constants that will be needed later on. Let $K_{1}$ be the constant in Lemma 3.5 such that for any $\omega \in \Omega, z \in M$,

|\log | \operatorname{det}\left(\left.D_{x} f_{\omega}\right|_{E^{s}(x, \omega)}\right)|-\log | \operatorname{det}\left(\left.D_{y} f_{\omega}\right|_{E^{s}(y, \omega)}\right)\left|\mid \leq K_{1} d(x, y) \text { for any } x, y \in W_{\epsilon}^{s}(z, \omega) .\right. \tag{4.2}
\end{equation*}
$$

By the compactness of $\Omega$ and $M$ and the continuity of $f_{\omega} \in \operatorname{Diff}^{2}(M)$ on $\omega$, there exists a constant $K_{2}>0$ such that for any $x, y \in M$,

$$
\begin{equation*}
|\log | \operatorname{det} D_{x} f_{\omega}|-\log | \operatorname{det} D_{y} f_{\omega}| | \leq K_{2} d(x, y) \tag{4.3}
\end{equation*}
$$

Let $a_{0}:=\max \left\{a_{0}^{\prime}, a_{0}^{\prime \prime}\right\}$, then Lemma 3.12 and Proposition 3.3 hold for constants $\left(a_{0}, \nu_{0}\right)$. This $\nu_{0}$ is the desired $\nu_{0}$ in the statement of Theorem 1. Now Let's pick any $\kappa, \nu \in(0,1)$ satisfying $0<\kappa+\nu<\nu_{0}$ as in the statement of Theorem 1, and pick $\kappa_{1} \in(0,1)$ an auxiliary constant closing to 1 such that

0<\kappa+\nu<\kappa_{1} \nu_{0} . \tag{4.4}
\end{equation*}
$$

Now we are going to prove Theorem 1 for fixed $\kappa, \nu$.
4.1. Construction of Birkhoff cone. In this subsection, we will first construct convex cones of density functions on each local stable leaf. With the help of these convex cones of density functions on each local stable leaf, we can define our desired convex cone of observables on each fiber. Our construction of convex cone of obervables is inspired by [30] and [39]. The definitions of the convex cone in a topological vector space, projective metric on the convex cone, and Birkhoff's inequality are recalled in the Appendix A.4, which also can be found in $[11,30,39]$.

Denote $m^{s}$ to be the inherited Riemannian volume measure on local stable manifolds. Then by the continuity of local stable manifolds, there exists a constant $A(\epsilon)>0$ such that $A(\epsilon) \leq m^{s}\left(W_{\epsilon}^{s}(x, \omega)\right)$ for any $(x, \omega) \in M \times \Omega$. In the following, for any $\omega \in \Omega$, we say that the local stable leaf $\gamma(\omega) \subset M$ having size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$ if $\gamma(\omega)$ is connected, and $m^{s}(\gamma(\omega)) \in\left(\frac{A(\epsilon)}{4 J^{2}}, A(\epsilon)\right)$, where the notation $\gamma(\omega)$ indicates that this local stable leaf is located on the fiber $M \times\{\omega\}$. Since $\gamma(\omega)$ is a connected curve, this means that the length of local stable manifold has length bounded from below and above. Applying the continuity of local stable manifolds again, there exists $\epsilon^{*}>0$ such that for any $\gamma(\omega)$ of size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, there exists $(x, \omega) \in M \times \Omega$ satisfying

$$
\begin{equation*}
W_{\epsilon^{*}}^{s}(x, \omega) \subset \gamma(\omega) \tag{4.5}
\end{equation*}
$$

For some constant $a>0$, and a local stable leaf $\gamma(\omega)$ having size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, we define $D(a, \kappa, \gamma(\omega))$ to be the collection of all bounded and measurable function $\rho(\cdot, \omega): \gamma(\omega) \rightarrow \mathbb{R}$ satisfying the following conditions:
(D1) $\rho(x, \omega)>0$ for $x \in \gamma(\omega)$;
(D2) for any $x, y \in \gamma(\omega),|\log \rho(x, \omega)-\log \rho(y, \omega)| \leq a d(x, y)^{\kappa}$.
We note that condition (D2) implies that any $\rho(\cdot, \omega) \in D(a, \kappa, \gamma(\omega))$ is continuous on $\gamma(\omega)$. In the left of this paper, we use the notation $\rho(\omega)$ to represent $\rho(\cdot, \omega) \in D(a, \kappa, \gamma(\omega))$ for convenience.

Lemma 4.1. $D(a, \kappa, \gamma(\omega))$ is a convex cone (see Definition A. 4 in the Appendix).

Proof of Lemma 4.1. For any $\rho(\omega) \in D(a, \kappa, \gamma(\omega))$ and $t \in \mathbb{R}^{+}$, then $t \rho(x, \omega)>0$ for $x \in \gamma(\omega)$ and

$$
|\log t \rho(x, \omega)-\log t \rho(y, \omega)|=|\log \rho(x, \omega)-\log \rho(y, \omega)| \leq a d(x, y)^{\kappa}
$$

Hence $t \rho(\omega) \in D(a, \kappa, \gamma(\omega))$.

For any $\rho_{i}(\omega) \in D(a, \kappa, \gamma(\omega))$ and $t_{i} \in \mathbb{R}^{+}$for $i=1,2$, it is clear that $t_{1} \rho_{1}(x, \omega)+t_{2} \rho_{2}(x, \omega)>0$ for $x \in \gamma(\omega)$. By (D2), we have

$$
e^{-a d(x, y)^{\kappa}} \leq \frac{\rho_{i}(x, \omega)}{\rho_{i}(y, \omega)} \leq e^{a d(x, y)^{\kappa}} \text { for } x, y \in \gamma(\omega) \text { and } i=1,2 .
$$

As a consequence, we have

$$
e^{-a d(x, y)^{\kappa}} \leq \frac{t_{1} \rho_{1}(x, \omega)+t_{2} \rho_{2}(x, \omega)}{t_{1} \rho_{1}(y, \omega)+t_{2} \rho_{2}(y, \omega)} \leq e^{a d(x, y)^{\kappa}} \text { for } x, y \in \gamma(\omega),
$$

which is equivalent to

$$
\left|\log \left(t_{1} \rho_{1}(x, \omega)+t_{2} \rho_{2}(x, \omega)\right)-\log \left(t_{1} \rho_{1}(y, \omega)+t_{2} \rho_{2}(y, \omega)\right)\right| \leq a d(x, y)^{\kappa} .
$$

Hence $t_{1} \rho_{1}(\omega)+t_{2} \rho_{2}(\omega) \in D(a, \kappa, \gamma(\omega))$.
To check the last condition for convex cone, we pick any $\rho(\omega) \in \overline{D(a, \kappa, \gamma(\omega))} \cap-\overline{D(a, \kappa, \gamma(\omega))}$. Here the closure means the "integral closure" in a weaker sense, not the closure in the topological vector space, see Def A.4. Then there exists $\rho_{i}(\omega) \in D(a, \kappa, \gamma(\omega))$ and $t_{n}^{i} \downarrow 0$ for $i=1,2$ such that $\rho(\omega)+t_{n}^{1} \rho_{1}(\omega) \in D(a, \kappa, \gamma(\omega))$ and $-\rho(\omega)+t_{n}^{2} \rho_{2}(\omega) \in D(a, \kappa, \gamma(\omega))$. By (D1), for any $x \in \gamma(\omega)$, we have $\rho(x, \omega)+t_{n}^{1} \rho_{1}(x, \omega)>0$ and $-\rho(x, \omega)+t_{n}^{2} \rho_{2}(x, \omega)>0$. Letting $n \rightarrow \infty$, we arrive $\rho(x, \omega) \geq 0$ and $\rho(x, \omega) \leq 0$. Therefore, one must have $\rho(\omega) \equiv 0$. By definition, $D(a, \kappa, \gamma(\omega))$ is a convex cone.

Next, we will introduce the projective metric $d_{\gamma(\omega)}^{a, \kappa}$ on $D(a, \kappa, \gamma(\omega))$ according to Def. A.5. For any $\rho_{1}(\omega), \rho_{2}(\omega) \in D(a, \kappa, \gamma(\omega))$, we define

$$
\begin{aligned}
& \alpha_{\gamma(\omega)}^{a, \kappa}\left(\rho_{1}(\omega), \rho_{2}(\omega)\right):=\sup \left\{t>0: \rho_{2}(\omega)-t \rho_{1}(\omega) \in D(a, \kappa, \gamma(\omega))\right\} \\
& \beta_{\gamma(\omega)}^{a, \kappa}\left(\rho_{1}(\omega), \rho_{2}(\omega)\right)=\inf \left\{s>0: \operatorname{s\rho } \rho_{1}(\omega)-\rho_{2}(\omega) \in D(a, \kappa, \gamma(\omega))\right\},
\end{aligned}
$$

with the convention that $\sup \emptyset=0$ and $\inf \emptyset=+\infty$. Now let us compute these two quantities. For any $t>0$ such that $\rho_{2}(\omega)-t \rho_{1}(\omega) \in D(a, \kappa, \gamma(\omega))$, then by (D1), one must have

$$
\rho_{2}(x, \omega)-t \rho_{1}(x, \omega)>0 \text { for all } x \in \gamma(\omega),
$$

which is equivalent to $t<\frac{\rho_{2}(x, \omega)}{\rho_{1}(x, \omega)}$ for all $x \in \gamma(\omega)$; and by (D2) one also must have

$$
e^{-a d(x, y)^{\kappa}} \leq \frac{\rho_{2}(x, \omega)-t \rho_{1}(x, \omega)}{\rho_{2}(y, \omega)-t \rho_{1}(y, \omega)} \leq e^{a d(x, y)^{\kappa}} \text { for all } x, y \in \gamma(\omega),
$$

which is equivalent to

$$
t \leq \inf _{x, y \in \gamma(\omega), x \neq y}\left\{\frac{\exp \left(a d(x, y)^{\kappa}\right) \rho_{2}(x, \omega)-\rho_{2}(y, \omega)}{\exp \left(a d(x, y)^{\kappa}\right) \rho_{1}(x, \omega)-\rho_{1}(y, \omega)}, \frac{\exp \left(a d(x, y)^{\kappa}\right) \rho_{2}(y, \omega)-\rho_{2}(x, \omega)}{\exp \left(a d(x, y)^{\kappa}\right) \rho_{1}(y, \omega)-\rho_{1}(x, \omega)}\right\} .
$$

Therefore, we have

$$
t \leq \inf \left\{\frac{\rho_{2}(x, \omega)}{\rho_{1}(x, \omega)}, \frac{\exp \left(a d(x, y)^{\kappa}\right) \rho_{2}(x, \omega)-\rho_{2}(y, \omega)}{\exp \left(a d(x, y)^{\kappa}\right) \rho_{1}(x, \omega)-\rho_{1}(y, \omega)}: x, y \in \gamma(\omega), x \neq y\right\}
$$

The case that $\left\{t>0: \rho_{2}(\omega)-t \rho_{1}(\omega) \in D(a, \kappa, \gamma(\omega))\right\}=\emptyset$ is equivalent to the right term of the above is equal to 0 , and so $\alpha_{\gamma(\omega)}^{a, \kappa}\left(\rho_{1}(\omega), \rho_{2}(\omega)\right)=\sup \emptyset=0$. Hence, we obtain

$$
\begin{equation*}
\alpha_{\gamma(\omega)}^{a, \kappa}\left(\rho_{1}(\omega), \rho_{2}(\omega)\right)=\inf \left\{\frac{\rho_{2}(x, \omega)}{\rho_{1}(x, \omega)}, \frac{\exp \left(a d(x, y)^{\kappa}\right) \rho_{2}(x, \omega)-\rho_{2}(y, \omega)}{\exp \left(a d(x, y)^{\kappa}\right) \rho_{1}(x, \omega)-\rho_{1}(y, \omega)}: x, y \in \gamma(\omega), x \neq y\right\}, \tag{4.6}
\end{equation*}
$$

Similarly, we can obtain

$$
\begin{equation*}
\beta_{\gamma(\omega)}^{a, \kappa}\left(\rho_{1}(\omega), \rho_{2}(\omega)\right)=\sup \left\{\frac{\rho_{2}(x, \omega)}{\rho_{1}(x, \omega)}, \frac{\exp \left(a d(x, y)^{\kappa}\right) \rho_{2}(x, \omega)-\rho_{2}(y, \omega)}{\exp \left(a d(x, y)^{\kappa}\right) \rho_{1}(x, \omega)-\rho_{1}(y, \omega)}: x, y \in \gamma(\omega), x \neq y\right\} \tag{4.7}
\end{equation*}
$$

Now define

$$
\begin{equation*}
d_{\gamma(\omega)}^{a, \kappa}\left(\rho_{1}(\omega), \rho_{2}(\omega)\right)=\log \frac{\beta_{\gamma}^{a, \kappa}(\omega)}{\alpha_{\gamma(\omega)}^{a, \kappa}\left(\rho_{1}(\omega), \rho_{2}(\omega)\right)}, \tag{4.8}
\end{equation*}
$$

with the convention that $d_{\gamma(\omega)}^{a, \kappa}\left(\rho_{1}(\omega), \rho_{2}(\omega)\right)=\infty$ if $\alpha_{\gamma(\omega)}^{a, \kappa}\left(\rho_{1}(\omega), \rho_{2}(\omega)\right)=0$ or $\beta_{\gamma(\omega)}^{a, \kappa}\left(\rho_{1}(\omega), \rho_{2}(\omega)\right)=$ $\infty$. By the property of projective metric (see Proposition A.2), the followings hold:
(P1) $d_{\gamma(\omega)}^{a, \kappa}\left(\rho_{1}(\omega), \rho_{2}(\omega)\right)=d_{\gamma(\omega)}^{a, \kappa}\left(\rho_{2}(\omega), \rho_{1}(\omega)\right)$;
(P2) $d_{\gamma(\omega)}^{a, \kappa}\left(\rho_{1}(\omega), \rho_{2}(\omega)\right) \leq d_{\gamma(\omega)}^{a, \kappa}\left(\rho_{1}(\omega), \rho_{3}(\omega)\right)+d_{\gamma(\omega)}^{a, \kappa}\left(\rho_{3}(\omega), \rho_{2}(\omega)\right)$;
(P3) $d_{\gamma(\omega)}^{a, \kappa}\left(\rho_{1}(\omega), \rho_{2}(\omega)\right)=0$ if and only if there exists a constant $t \in \mathbb{R}^{+}$such that $\rho_{1}(\omega)=t \rho_{2}(\omega)$.
Note that (P2) and (P3) implies that

$$
\begin{equation*}
d_{\gamma(\omega)}^{a, \kappa}\left(\rho_{1}(\omega), \rho_{2}(\omega)\right)=d_{\gamma(\omega)}^{a, \kappa}\left(t_{1} \rho_{1}(\omega), t_{2} \rho_{2}(\omega)\right) \text { for any } t_{1}, t_{2} \in \mathbb{R}^{+} . \tag{4.9}
\end{equation*}
$$

It is also convenient to introduce the following convex cone. Denote $D_{+}(\gamma(\omega))$ by the collection of all bounded and measurable functions $\zeta(\omega): \gamma(\omega) \rightarrow \mathbb{R}$ such that $\zeta(x, \omega)>0$ for $x \in \gamma(\omega)$. It is clear that $D_{+}(\gamma(\omega))$ is a convex cone. For any $\zeta_{1}(\omega), \zeta_{2}(\omega) \in D_{+}(\gamma(\omega))$, we define

It is clear that $D(a, \kappa, \gamma(\omega)) \subset D_{+}(\gamma(\omega))$, and $d_{+, \gamma(\omega)}\left(\rho_{1}(\omega), \rho_{2}(\omega)\right) \leq d_{\gamma(\omega)}^{a, \kappa}\left(\rho_{1}(\omega), \rho_{2}(\omega)\right)$ for any $\rho_{1}(\omega), \rho_{2}(\omega) \in D(a, \kappa, \gamma(\omega))$.

By using density functions on $\gamma(\omega)$, we can define the corresponding density function on the pullback of $\gamma(\omega)$. For any $\omega \in \Omega$, and a local stable leaf $\gamma(\omega)$ having size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, since the local stable manifold is a curve, we can divide $f_{\omega}^{-1} \gamma(\omega)$ into connected local stable manifolds with size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, named $\gamma_{i}\left(\theta^{-1} \omega\right)$ for $i$ belonging to a finite index set such that $\gamma_{i}\left(\theta^{-1} \omega\right) \cap \gamma_{j}\left(\theta^{-1} \omega\right)=\partial \gamma_{i}\left(\theta^{-1} \omega\right) \cap \partial \gamma_{j}\left(\theta^{-1} \omega\right)$ for $i \neq j$. By using any continuous density functions $\rho(\omega)$ on $\gamma(\omega)$, we define the corresponding density function $\rho_{i}\left(\theta^{-1} \omega\right)$ on $\gamma_{i}\left(\theta^{-1} \omega\right)$ by

By using density function on $\gamma(\omega)$, we also can define the corresponding density function on the holonomy image of $\gamma(\omega)$. Given pair of local stable leaves $\gamma(\omega)$ and $\tilde{\gamma}(\omega)$, with the help of holonomy $\operatorname{map} \psi_{\omega}^{u}: \tilde{\gamma}(\omega) \rightarrow \gamma(\omega)$ induced by the local unstable manifolds, for every continuous density function $\rho(\omega)$ on $\gamma(\omega)$, we associate the density $\tilde{\rho}(\omega)$ on $\tilde{\gamma}(\omega)$ by

(3) if $\rho(\omega) \in D\left(\frac{a}{2}, \kappa_{1} \nu_{0}, \gamma(\omega)\right)$, then $\rho_{i}\left(\theta^{-1} \omega\right) \in D\left(e^{-\lambda_{1}} \frac{a}{2}, \kappa_{1} \nu_{0}, \gamma_{i}\left(\theta^{-1} \omega\right)\right) \subset D\left(\frac{a}{2}, \kappa_{1} \nu_{0}, \gamma_{i}\left(\theta^{-1} \omega\right)\right)$;
(4) if $\rho(\omega) \in D(a, \kappa, \gamma(\omega))$, then $\rho_{i}\left(\theta^{-1} \omega\right) \in D\left(e^{-\lambda_{1}} a, \kappa, \gamma_{i}\left(\theta^{-1} \omega\right)\right) \subset D\left(a, \kappa, \gamma_{i}\left(\theta^{-1} \omega\right)\right)$;
furthermore,

proof of lemma 4.2. We first prove (1). Let $\rho(\omega) \in D\left(a_{1}, \kappa, \gamma(\omega)\right)$. d_{\gamma_{i}\left(\theta^{-1} \omega\right)}^{a, \kappa}\left(\zeta_{1}\left(\theta^{-1} \omega\right), \zeta_{2}\left(\theta^{-1} \omega\right)\right) \leq d_{+, \gamma_{i}\left(\theta^{-1} \omega\right)}\left(\zeta_{1}\left(\theta^{-1} \omega\right), \zeta_{2}\left(\theta^{-1} \omega\right)\right)+\log \left(\tau_{2} / \tau_{1}\right) \tag{4.26}
\end{equation*}
$$

Next, we estimate $d_{+, \gamma_{i}(\omega)}\left(\zeta_{1}\left(\theta^{-1} \omega\right), \zeta_{2}\left(\theta^{-1} \omega\right)\right)$ for $\zeta_{1}\left(\theta^{-1} \omega\right), \zeta_{2}\left(\theta^{-1} \omega\right) \in D\left(e^{-\lambda_{1}} a, \alpha, \gamma_{i}\left(\theta^{-1} \omega\right)\right)$. By the third property of projective metric (P3) and normalizing $\zeta_{1}\left(\theta^{-1} \omega\right), \zeta_{2}\left(\theta^{-1} \omega\right)$, we can assume that

$$
\int_{\gamma_{i}\left(\theta^{-1} \omega\right)} \zeta_{1}\left(x, \theta^{-1} \omega\right) d m_{\gamma_{i}\left(\theta^{-1} \omega\right)}(x)=\int_{\gamma_{i}\left(\theta^{-1} \omega\right)} \zeta_{2}\left(x, \theta^{-1} \omega\right) d m_{\gamma_{i}\left(\theta^{-1} \omega\right)}(x)=1,
$$

without changing $d_{+, \gamma_{i}(\omega)}\left(\zeta_{1}\left(\theta^{-1} \omega\right), \zeta_{2}\left(\theta^{-1} \omega\right)\right)$. Therefore, there exists points $y_{1}, y_{2} \in \gamma_{i}\left(\theta^{-1} \omega\right)$ such that $\zeta_{1}\left(y_{1}, \theta^{-1} \omega\right)=1$ and $\zeta_{2}\left(y_{2}, \theta^{-1} \omega\right)=1$ by continuity. Then (D2) of $D\left(e^{-\lambda_{1}} a, \kappa, \gamma_{i}\left(\theta^{-1} \omega\right)\right)$ implies for all $x \in \gamma_{i}\left(\theta^{-1} \omega\right)$

$$
\frac{\zeta_{2}\left(x, \theta^{-1} \omega\right)}{\zeta_{1}\left(x, \theta^{-1} \omega\right)}=\frac{\zeta_{2}\left(x, \theta^{-1} \omega\right) / \zeta_{1}\left(y_{1}, \theta^{-1} \omega\right)}{\zeta_{1}\left(x, \theta^{-1} \omega\right) / \zeta_{2}\left(y_{2}, \theta^{-1} \omega\right)} \geq \frac{\exp \left(-e^{-\lambda_{1}} a\left(\operatorname{diam} \gamma_{i}\left(\theta^{-1} \omega\right)\right)^{\kappa}\right)}{\exp \left(e^{-\lambda_{1}} a\left(\operatorname{diam} \gamma_{i}\left(\theta^{-1} \omega\right)\right)^{\kappa}\right)} \geq e^{-2 a}
$$

where diam means the diameter. It follows that $\alpha_{+, \gamma_{i}\left(\theta^{-1} \omega\right)}\left(\zeta_{1}\left(\theta^{-1} \omega\right), \zeta_{2}\left(\theta^{-1} \omega\right)\right) \geq e^{-2 a}$. Similarly, $\beta_{+, \gamma_{i}\left(\theta^{-1} \omega\right)}\left(\zeta_{1}\left(\theta^{-1} \omega\right), \zeta_{2}\left(\theta^{-1} \omega\right)\right) \leq e^{2 a}$. Therefore, $d_{+, \gamma_{i}\left(\theta^{-1} \omega\right)}\left(\zeta_{1}\left(\theta^{-1} \omega\right), \zeta_{2}\left(\theta^{-1} \omega\right)\right) \leq 4 a$. So we have

$$
\begin{align*}
d_{\gamma_{i}\left(\theta^{-1} \omega\right)}^{a, \kappa}\left(\zeta_{1}\left(\theta^{-1} \omega\right), \zeta_{2}\left(\theta^{-1} \omega\right)\right) & \stackrel{(4.26)}{\leq} d_{+, \gamma_{i}\left(\theta^{-1} \omega\right)}\left(\zeta_{1}\left(\theta^{-1} \omega\right), \zeta_{2}\left(\theta^{-1} \omega\right)\right)+\log \left(\tau_{2} / \tau_{1}\right) \\
& \leq 4 a+\log \left(\tau_{2} / \tau_{1}\right) \tag{4.27}
\end{align*}
$$

Since $\zeta_{1}\left(\theta^{-1} \omega\right), \zeta_{2}\left(\theta^{-1} \omega\right) \in D\left(e^{-\lambda_{1}} a, \kappa, \gamma_{i}\left(\theta^{-1} \omega\right)\right)$ are arbitrary chosen, $R_{i}\left(\theta^{-1} \omega\right) \leq 4 a+\log \left(\tau_{2} / \tau_{1}\right)$. By (4.25), let $\Lambda_{1}=1-e^{-\left(4 a+\log \left(\tau_{2} / \tau_{1}\right)\right)}$. The proof of (5) is complete.

Finally, let's prove (4.23). Let $\rho(\omega) \in D\left(a_{1}, \kappa_{1}, \gamma(\omega)\right)$ be arbitrarily chosen, and $\tilde{\rho}(\omega)$ on $\tilde{\gamma}(\omega)$ be defined by (4.17). It is clear that $\tilde{\rho}(x, \omega)>0$. Moreover, for any $x, y \in \tilde{\gamma}(\omega)$, we have

$$
\begin{aligned}
&|\log \tilde{\rho}(x, \omega)-\log \tilde{\rho}(y, \omega)| \\
& \leq\left|\log \rho\left(\psi_{\omega}(x), \omega\right)-\log \rho\left(\psi_{\omega}(y), \omega\right)\right|+\left|\log \operatorname{Jac}\left(\psi_{\omega}\right)(x)-\log \operatorname{Jac}\left(\psi_{\omega}\right)(y)\right| \\
& \leq a_{1} d\left(\psi_{\omega}(x), \psi_{\omega}(y)\right)^{\kappa_{1}}+a_{0} d(x, y)^{\nu_{0}} \\
& \leq a_{1} a_{0}^{\kappa_{1}} d(x, y)^{\kappa_{1} \nu_{0}}+a_{0} d(x, y)^{\nu_{0}} \\
& \leq\left(a_{1} a_{0}^{\kappa_{1}}+a_{0}\right) d(x, y)^{\kappa_{1} \nu_{0}} \\
& \stackrel{(4.21)}{\leq} \frac{a}{2} d(x, y)^{\kappa_{1} \nu_{0}} .
\end{aligned}
$$

So $\tilde{\rho}(\omega) \in D\left(a / 2, \kappa_{1} \nu_{0}, \tilde{\gamma}(\omega)\right)$. The proof of Lemma 4.2 is complete.
Remark 4.1. We can apply the proof of statement (1) inductively to show the following conclusion. For any local stable leaf $\gamma(\omega)$ having size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, any $\rho(\omega) \in D\left(a_{1}, \kappa, \gamma(\omega)\right)$, and any local stable leaf $\gamma^{*}\left(\theta^{-n} \omega\right) \subset f_{\omega}^{-n} \gamma(\omega)$, we can define $\rho^{*}\left(\theta^{-n} \omega\right)$ on $\gamma^{*}\left(\theta^{-n} \omega\right)$ by

$$
\rho^{*}\left(x, \theta^{-n} \omega\right)=\frac{\left|\operatorname{det} D_{x} f_{\theta^{-n} \omega}^{n}\right| E^{s}\left(x, \theta^{-n} \omega\right) \mid}{\left|\operatorname{det} D_{x} f_{\theta^{-n} \omega}^{n}\right|} \rho\left(f_{\theta^{-n} \omega}^{n} x, \omega\right) \text { for } x \in \gamma^{*}\left(\theta^{-n} \omega\right) .
$$

Then $\rho^{*}\left(\theta^{-n} \omega\right) \in D\left(e^{-\lambda_{1}} a_{1}, \kappa, \gamma^{*}\left(\theta^{-n} \omega\right)\right)$.

From now on, we fix parameters $a_{1}$ and $a$ in (4.20) and (4.21), and $\lambda_{1}, \Lambda_{1}$ in Lemma 4.2. Now, we use convex cones $D\left(a_{1}, \kappa_{1}, \gamma(\omega)\right), D\left(\frac{a}{2}, \kappa, \gamma(\omega)\right)$ and $D(a, \kappa, \gamma(\omega))$ to construct the convex cone of observables on the fiber $\{\omega\}$. Let $b>1$ and $c>0$ be parameters to be determined later. Recall that $\nu$ is the constant picked at the beginning of Sec. 4. For any $\omega \in \Omega$, we define $C_{\omega}(b, c, \nu)$ to be the collection of all bounded measurable functions $\varphi: M \rightarrow \mathbb{R}$ satisfying:
(C1) $\int_{\gamma(\omega)} \varphi(x) \rho(x, \omega) d m_{\gamma(\omega)}(x)>0$ for every local stable submanifold $\gamma(\omega) \subset M$ size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, and every $\rho(\omega) \in D(a / 2, \kappa, \gamma(\omega))$ satisfying $\int_{\gamma(\omega)} \rho(x, \omega) d m_{\gamma(\omega)}(x)=1$;
(C2) $\left|\log \int_{\gamma(\omega)} \varphi(x) \rho(x, \omega) d m_{\gamma(\omega)}(x)-\log \int_{\gamma(\omega)} \varphi(x) \varsigma(x, \omega) d m_{\gamma(\omega)}(x)\right| \leq b \cdot d_{\gamma(\omega)}^{a, \kappa}(\rho(\omega), \varsigma(\omega))$ for every local stable submanifold $\gamma(\omega) \subset M$ having size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, any $\rho(\omega), \varsigma(\omega) \in$ $D(a / 2, \kappa, \gamma(\omega)) \subset D(a, \kappa, \gamma(\omega))$ satisfying $\int_{\gamma(\omega)} \rho(x, \omega) d m_{\gamma(\omega)}(x)=\int_{\gamma(\omega)} \varsigma(x, \omega) d m_{\gamma(\omega)}(x)=$ 1.
(C3)
$\left|\log \int_{\gamma(\omega)} \varphi(x) \rho(x, \omega) d m_{\gamma(\omega)}(x)-\log \int_{\tilde{\gamma}(\omega)} \varphi(x) \tilde{\rho}(x, \omega) d m_{\tilde{\gamma}(\omega)}(x)\right| \leq c d_{u}(\gamma(\omega), \tilde{\gamma}(\omega))^{\nu}$ for every pair of local stable leaves $\gamma(\omega), \tilde{\gamma}(\omega) \subset M$ having size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, any $\rho(\omega) \in$ $D\left(a_{1}, \kappa_{1}, \gamma(\omega)\right)$ and $\tilde{\rho}(\omega)$ corresponding to $\rho(\omega)$ defined as (4.17).
Remark 4.2. Parameters $a, a_{1}, \kappa_{1}, b$ and $c$ are constructed to prove the contraction of the transfer operator on the convex cone of observables. We just need to guarantee that all auxiliary parameters only depend on $\kappa$ and $\nu$.
Remark 4.3. Note that (C2) is automatically fulfilled if $\varphi$ is nonnegative. In fact, notice that

$$
\int_{\gamma(\omega)} \rho(x, \omega) d m_{\gamma(\omega)}(x)=\int_{\gamma(\omega)} \varsigma(x, \omega) d m_{\gamma(\omega)}(x)=1
$$

then we have

$$
\inf _{y \in \gamma(\omega)}\left\{\frac{\rho(y, \omega)}{\varsigma(y, \omega)}\right\} \leq 1
$$

otherwise $\int_{\gamma(\omega)} \rho(\omega) d m_{\gamma(\omega)}>\int_{\gamma(\omega)} \varsigma(\omega) d m_{\gamma(\omega)}$, a contradiction. So we have

$$
\begin{align*}
\frac{\rho(x, \omega)}{\varsigma(x, \omega)} & \leq \sup _{x \in \gamma(\omega)}\left\{\frac{\rho(x, \omega)}{\varsigma(x, \omega)}\right\} / \inf _{y \in \gamma(\omega)}\left\{\frac{\rho(y, \omega)}{\varsigma(y, \omega)}\right\}=\exp \left(d_{+, \gamma(\omega)}(\rho(\omega), \varsigma(\omega))\right) \\
& \leq \exp \left(d_{\gamma(\omega)}^{a, \kappa}(\rho(\omega), \varsigma(\omega))\right), \tag{4.28}
\end{align*}
$$

where $d_{+, \gamma(\omega)}$ is the projective metric on $D_{+}(\gamma(\omega))$ defined as (4.12). Switch $\rho$ and $\varsigma$, we get $\frac{\varsigma(x, \omega)}{\rho(x, \omega)} \leq$ $\exp \left(d_{\gamma(\omega)}^{a, \kappa}(\rho(\omega), \varsigma(\omega))\right)$. Therefore, we have

$$
e^{-d_{\gamma(\omega)}^{a, \kappa}(\rho(\omega), \varsigma(\omega))} \leq \frac{\int_{\gamma(\omega)} \varphi(x) \rho(x, \omega) d m_{\gamma(\omega)}(x)}{\int_{\gamma(\omega)} \varphi(x) \varsigma(x, \omega) d m_{\gamma(\omega)}(x)} \leq e^{e_{\gamma(\omega)}^{a, \kappa}(\rho(\omega), \varsigma(\omega))}
$$

$(C 2)$ is a consequence of the above inequality as long as $b>1$.
Besides, it is clear that positive constant functions belong to $C_{\omega}(b, c, \nu)$ for all $\omega \in \Omega$.
Lemma 4.3. For each $\omega \in \Omega, C_{\omega}(b, c, \nu)$ is a convex cone (see Def. A. 4 in the Appendix).

Proof of Lemma 4.3. For any $\varphi \in C_{\omega}(b, c, \nu)$, and $t>0$, it is clear that $t \varphi \in C_{\omega}(b, c, \nu)$.
Now, we prove the convexity, i.e., $\varphi_{1}, \varphi_{2} \in C_{\omega}(b, c, \nu)$ and $t_{1}, t_{2}>0$, we are going to prove $t_{1} \varphi+t_{2} \varphi_{2} \in C_{\omega}(b, c, \nu)$. (C1) is clearly fulfilled. For every local stable submanifold $\gamma(\omega) \subset M$ having size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, any $\rho(\omega), \varsigma(\omega) \in D(a / 2, \kappa, \gamma(\omega)) \subset D(a, \kappa, \gamma(\omega))$ satisfying $\int_{\gamma(\omega)} \rho(x, \omega) d m_{\gamma(\omega)}(x)=\int_{\gamma(\omega)} \varsigma(x, \omega) d m_{\gamma(\omega)}(x)=1$, by (C2), we have

$$
e^{-b d_{\gamma(\omega)}^{a, \kappa}(\rho(\omega), \varsigma(\omega))} \leq \frac{\int_{\gamma(\omega)} \varphi_{i}(x) \rho(x, \omega) d m_{\gamma(\omega)}(x)}{\int_{\gamma(\omega)} \varphi_{i}(x) \varsigma(x, \omega) d m_{\gamma(\omega)}(x)} \leq e^{b d_{\gamma(\omega)}^{a, \kappa}(\rho(\omega), \varsigma(\omega))}
$$

The above implies that

$$
e^{-b d_{\gamma(\omega)}^{a, \kappa}(\rho(\omega), \varsigma(\omega))} \leq \frac{\int_{\gamma(\omega)}\left(t_{1} \varphi_{1}(x)+t_{2} \varphi_{2}(x)\right) \rho(x, \omega) d m_{\gamma(\omega)}}{\int_{\gamma(\omega)}\left(t_{1} \varphi_{1}(x)+t_{2} \varphi_{2}(x)\right) \varsigma(x, \omega) d m_{\gamma(\omega)}} \leq e^{b d_{\gamma(\omega)}(\rho(\omega), \varsigma(\omega))}
$$

So (C2) is verified. Similarly, (C3) can also be verified. Therefore, $t_{1} \varphi+t_{2} \varphi_{2} \in C_{\omega}(b, c, \nu)$.
Now, we prove that $-\overline{C_{\omega}(b, c, \nu)} \cap \overline{C_{\omega}(b, c, v)}=\{0\}$. Here, the closure means the "integral closure" in a weaker sense, see Def. A.4. Suppose $\varphi \in-\overline{C_{\omega}(b, c, \nu)} \cap \overline{C_{\omega}(b, c, v)}$, then there exists $\varphi_{1}, \varphi_{2} \in$ $C_{\omega}(b, c, \nu)$ and $t_{n}^{1}, t_{n}^{2} \downarrow 0$ such that $\varphi+t_{n}^{1} \varphi_{1} \in C_{\omega}(b, c, \nu)$ and $-\varphi+t_{n}^{2} \varphi_{2} \in C_{\omega}(b, c, \nu)$ for each $n \in \mathbb{N}$. Hence, for any local stable leaf $\gamma(\omega)$ having size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, and $\rho(\omega) \in D(a / 2, \kappa, \gamma(\omega))$, we have

$$
\begin{aligned}
& \int_{\gamma(\omega)}\left(\varphi+t_{n}^{1} \varphi_{1}\right)(x) \rho(x, \omega) d m_{\gamma(\omega)}>0 \\
& \int_{\gamma(\omega)}\left(-\varphi+t_{n}^{2} \varphi_{2}\right)(x) \rho(x, \omega) d m_{\gamma(\omega)}>0
\end{aligned}
$$

Letting $n \rightarrow \infty$, by bounded convergence theorem, one must have

$$
\begin{equation*}
\int_{\gamma(\omega)} \varphi(x) \rho(x, \omega) d m_{\gamma(\omega)}(x)=0 \tag{4.29}
\end{equation*}
$$

Now pick $g \in C^{0, \kappa}(M)$ any $\kappa$-Hölder continuous function. Let

$$
|g|_{\kappa}:=\sup _{x \neq y \in M} \frac{|g(x)-g(y)|}{d(x, y)^{\kappa}}, g^{+}:=\frac{1}{2}(|g|+g), g^{-}:=\frac{1}{2}(|g|-g),
$$

and $B=\frac{2\left(|g|_{\kappa}+1\right)}{a}$. Then it is clear that

$$
\log \left(g^{+}+B\right), \text { and } \log \left(g^{-}+B\right)
$$

are ( $a / 2, \kappa$ )-Hölder continuous, i.e.,

$$
\left|\log \left(g^{ \pm}(x)+B\right)-\log \left(g^{ \pm}(y)+B\right)\right| \leq \frac{a}{2} d(x, y)^{\kappa}, \quad \forall x, y \in M
$$

Then $\left.\left(g^{+}(\cdot)+B\right)\right|_{\gamma(\omega)},\left.\left(g^{-}(\cdot)+B\right)\right|_{\gamma(\omega)}$ are in $D(a / 2, \kappa, \gamma(\omega))$ by checking the definition. By (4.29) and the linearity of integration, we have

$$
\int_{\gamma(\omega)} \varphi(x) g(x) d m_{\gamma(\omega)}(x)=0 .
$$

We can pick $g \in C^{0, \kappa}(M) L^{1}$-approximating $\varphi$ since $\varphi$ is bounded and measurable, hence we have $\int_{\gamma(\omega)} \varphi^{2}(x) d m_{\gamma(\omega)}(x)=0$. So $\varphi(x)=0$ for $x \in \gamma(\omega)$. Since $\gamma(\omega) \subset M$ is an arbitrary local stable leaf, $\varphi \equiv 0$. The proof of Lemma 4.3 is complete.

Now $C_{\omega}(b, c, \nu)$ is a convex cone, so we can define the projective metric on $C_{\omega}(b, c, \nu)$. For any $\varphi_{1}, \varphi_{2} \in C_{\omega}(b, c, \nu)$, define

$$
\begin{aligned}
\alpha_{\omega}\left(\varphi_{1}, \varphi_{2}\right) & :=\sup \left\{t>0: \varphi_{2}-t \varphi_{1} \in C_{\omega}(b, c, \nu)\right\}, \\
\beta_{\omega}\left(\varphi_{1}, \varphi_{2}\right) & :=\inf \left\{s>0: s \varphi_{1}-\varphi_{2} \in C_{\omega}(b, c, \nu)\right\},
\end{aligned}
$$

with the convention that $\sup \emptyset=0$ and $\inf \emptyset=+\infty$, and let

$$
d_{\omega}\left(\varphi_{1}, \varphi_{2}\right):=\log \frac{\beta_{\omega}\left(\varphi_{1}, \varphi_{2}\right)}{\alpha_{\omega}\left(\varphi_{1}, \varphi_{2}\right)},
$$

with the convention that $d_{\omega}\left(\varphi_{1}, \varphi_{2}\right)=\infty$ if $\alpha_{\omega}\left(\varphi_{1}, \varphi_{2}\right)=0$ or $\beta_{\omega}\left(\varphi_{1}, \varphi_{2}\right)=\infty$.
Lemma 4.4. For any $\varphi_{1}, \varphi_{2} \in C_{\omega}(b, c, \nu)$,

$$
\begin{align*}
\alpha_{\omega}\left(\varphi_{1}, \varphi_{2}\right) & =\inf \left\{\frac{\int_{\gamma(\omega)} \varphi_{2} \rho^{\prime}(\omega) d m_{\gamma(\omega)}}{\int_{\gamma(\omega)} \varphi_{1} \rho^{\prime}(\omega) d m_{\gamma(\omega)}}, \frac{\int_{\gamma(\omega)} \varphi_{2} \rho^{\prime}(\omega) d m_{\gamma(\omega)}}{\int_{\gamma(\omega)} \varphi_{1} \rho^{\prime}(\omega) d m_{\gamma(\omega)}} \xi_{\omega}\left(\rho^{\prime}, \rho^{\prime \prime}, \varphi_{1}, \varphi_{2}\right)\right.  \tag{4.30}\\
& \left.\frac{\int_{\gamma(\omega)} \varphi_{2} \rho(\omega) d m_{\gamma(\omega)}}{\int_{\gamma(\omega)} \varphi_{1} \rho(\omega) d m_{\gamma(\omega)}} \eta_{\omega}\left(\rho, \tilde{\rho}, \varphi_{1}, \varphi_{2}\right), \frac{\int_{\tilde{\gamma}(\omega)} \varphi_{2} \tilde{\rho}(\omega) d m_{\tilde{\gamma}(\omega)}}{\int_{\tilde{\gamma}(\omega)} \varphi_{1} \tilde{\rho}(\omega) d m_{\tilde{\gamma}(\omega)}} \eta_{\omega}\left(\tilde{\rho}, \rho, \varphi_{1}, \varphi_{2}\right)\right\},
\end{align*}
$$

and

$$
\begin{align*}
\beta_{\omega}\left(\varphi_{1}, \varphi_{2}\right) & =\sup \left\{\frac{\int_{\gamma(\omega)} \varphi_{2} \rho^{\prime}(\omega) d m_{\gamma(\omega)}}{\int_{\gamma(\omega)} \varphi_{1} \rho^{\prime}(\omega) d m_{\gamma(\omega)}}, \frac{\int_{\gamma(\omega)} \varphi_{2} \rho^{\prime}(\omega) d m_{\gamma(\omega)}}{\int_{\gamma(\omega)} \varphi_{1} \rho^{\prime}(\omega) d m_{\gamma(\omega)}} \xi_{\omega}\left(\rho^{\prime}, \rho^{\prime \prime}, \varphi_{1}, \varphi_{2}\right)\right.  \tag{4.31}\\

Proof of Lemma 4.4. We only compute $\alpha_{\omega}$, as the case for $\beta_{\omega}$ is similar. For any $t>0$ such that $\varphi_{2}-t \varphi_{1} \in C_{\omega}(b, c, \nu)$, then $\varphi_{2}-t \varphi_{1}$ must satisfy (C1), (C2) and (C3).

First, for every local stable submanifold $\gamma(\omega) \subset M$ having size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, and every $\rho(\omega) \in D(a / 2, \kappa, \gamma(\omega))$ satisfying $\int_{\gamma(\omega)} \rho(x, \omega) d m_{\gamma(\omega)}(x)=1$, one must have $\int_{\gamma(\omega)}\left(\varphi_{2}-t \varphi_{1}\right) \rho(\omega) d m_{\gamma(\omega)}>$ 0 , which implies

4.2. Contraction of the fiber transfer operator. In this subsection, we will prove that the fiber transfer operator $L_{\omega}$ maps $C_{\omega}(b, c, \nu)$ into $C_{\theta \omega}(b, c, \nu)$ for all $\omega \in \Omega$. Moreover, the diameter of $L_{\omega}^{N} C_{\omega}(b, c, \nu)$ with respect to the projective metric on $C_{\theta^{N} \omega}(b, c, \nu)$ is finite, and this diameter is independent of $\omega \in \Omega$, where the number $N$ comes from the topological mixing on fibers property and will be constructed in (4.54) and (4.55). Birkhoff's inequality (Proposition A. 3 in the Appendix) implies the contraction of the fiber transfer operator $L_{\omega}^{N}: C_{\omega}(b, c, \nu) \rightarrow C_{\theta^{N} \omega}(b, c, \nu)$.

Lemma 4.5. Recall that $\Lambda_{1} \in(0,1)$ is given in Lemma 4.2. Let $\lambda_{2} \in\left(\max \left\{\Lambda_{1}, e^{-\lambda \nu}\right\}, 1\right)$ be any number, for any $b>b_{0}\left(\lambda_{2}, \Lambda_{1}\right)=\frac{1}{\lambda_{2}-\Lambda_{1}}$, there exists $c_{0}=c_{0}(b, \nu)$ such that for any $c>c_{0}$ and for all $\omega \in \Omega$, we have $L_{\theta^{-1} \omega}\left(C_{\theta^{-1} \omega}(b, c, \nu)\right) \subset C_{\omega}\left(\lambda_{2} b, \lambda_{2} c, \nu\right) \subset C_{\omega}(b, c, \nu)$. Recall that the fiber transfer operator $L_{\theta^{-1} \omega}$ is defined by

Proof of Lemma 4.5. Pick any $\omega \in \Omega$ and any $\varphi \in C_{\theta^{-1} \omega}(b, c, \nu)$. It is clear that $L_{\theta^{-1} \omega} \varphi: M \rightarrow \mathbb{R}$ is bounded and measurable.

Let us first verify condition (C1) for $L_{\theta^{-1} \omega} \varphi$. Pick $\gamma(\omega)$ any local stable leaf having size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, and any $\rho(\omega) \in D(a / 2, \kappa, \gamma(\omega))$ satisfying $\int_{\gamma(\omega)} \rho(x, \omega) d m_{\gamma(\omega)}=1$. Since $\left(f_{\theta^{-1} \omega}\right)^{-1} \gamma(\omega)$ is a curve, we can divide $\left(f_{\theta^{-1} \omega}\right)^{-1} \gamma(\omega)$ into connected local stable submanifolds of size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, named $\gamma_{i}\left(\theta^{-1} \omega\right)$ for $i$ belonging to a finite index set such that $\gamma_{i}\left(\theta^{-1} \omega\right) \cap \gamma_{j}\left(\theta^{-1} \omega\right)=\partial \gamma_{i}\left(\theta^{-1} \omega\right) \cap \partial \gamma_{j}\left(\theta^{-1} \omega\right)$ for $i \neq j$. Let $\rho_{i}\left(\theta^{-1} \omega\right)$ be defined as (4.15) on $\gamma_{i}\left(\theta^{-1} \omega\right)$. By Lemma 4.2,

where the last inequality holds since $\varphi \in C_{\theta^{-1} \omega}(b, c, \nu)$ and using condition ( $\mathbf{C 1}$ ) for $\varphi$.
Secondly, let us verify condition (C2) for $L_{\theta^{-1} \omega} \varphi$. For any $\rho(\omega), \zeta(\omega) \in D(a / 2, \kappa, \gamma(\omega))$ such that

\int_{\gamma(\omega)}\left(L_{\theta^{-1} \omega} \varphi\right)(y) \rho(y, \omega) d m_{\gamma(\omega)}(y) \leq \exp \left(b \lambda_{2} d_{\gamma(\omega)}^{a, \kappa}(\rho(\omega), \zeta(\omega))\right) \int_{\gamma(\omega)}\left(L_{\theta^{-1} \omega} \varphi\right)(y) \zeta(y, \omega) d m_{\gamma(\omega)}(y)
$$

The above two estimates imply that

Next, let us verify condition (C3) for $L_{\theta^{-1} \omega} \varphi$. Given any pair of local stable leaves $\gamma(\omega)$ and $\tilde{\gamma}(\omega)$. We first divide $\left(f_{\theta^{-1} \omega}\right)^{-1} \gamma(\omega)$ into connected local stable manifolds of size between $\frac{A(\epsilon)}{4 J}$ and $\frac{A(\epsilon)}{2 J}$, named $\gamma_{i}\left(\theta^{-1} \omega\right)$, such that $\gamma(\omega)=\cup f_{\theta^{-1} \omega} \gamma_{i}\left(\theta^{-1} \omega\right)$. Let $\tilde{\gamma}_{i}\left(\theta^{-1} \omega\right)$ be the holonomy image of $\gamma_{i}\left(\theta^{-1} \omega\right)$ inside of $\left(f_{\theta^{-1} \omega}\right)^{-1} \tilde{\gamma}(\omega)$. Naturally, we have $\tilde{\gamma}(\omega)=\cup f_{\theta^{-1} \omega} \tilde{\gamma}_{i}\left(\theta^{-1} \omega\right)$. Note that the Jacobian
of holonomy map between local stable manifolds is bounded above by $J$ and bounded below by $J^{-1}$. Therefore, $\tilde{\gamma}_{i}\left(\theta^{-1} \omega\right)$ have size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$. For any $\rho(\omega) \in D\left(a_{1}, \kappa_{1}, \gamma(\omega)\right)$, let $\tilde{\rho}(\omega)$ be defined as (4.17), and we already see that $\tilde{\rho}(\omega) \in D\left(\frac{a}{2}, \kappa_{1} \nu_{0}, \tilde{\gamma}(\omega)\right) \subset D(a, \kappa, \tilde{\gamma}(\omega))$. Let

\end{aligned}

By Lemma 4.2, $\rho_{i}\left(\theta^{-1} \omega\right) \in D\left(e^{-\lambda_{1}} a_{1}, \kappa_{1}, \gamma_{i}\left(\theta^{-1} \omega\right)\right) \subset D\left(a_{1}, \kappa_{1}, \gamma_{i}\left(\theta^{-1} \omega\right)\right)$. Let $\psi_{\theta^{-1} \omega}^{i}$ be the holonomy map between $\tilde{\gamma}_{i}\left(\theta^{-1} \omega\right)$ and $\gamma_{i}\left(\theta^{-1} \omega\right)$, and define

Note that $(\tilde{\rho})_{i}\left(\theta^{-1} \omega\right)$ and $\tilde{\rho}_{i}\left(\theta^{-1} \omega\right)$ are different, and we keep in mind that $(\tilde{\rho})_{i}\left(\theta^{-1} \omega\right)$ is obtained by first applying the action of holonomy map then applying the action of pull back to $\rho(\omega)$, while $\tilde{\rho}_{i}\left(\theta^{-1} \omega\right)$ is obtained by reversing the order of these two actions. Since $\varphi \in C_{\theta^{-1} \omega}(b, c, \nu)$ and $\rho_{i}\left(\theta^{-1} \omega\right) \in$ $D\left(a_{1}, \kappa_{1}, \gamma_{i}\left(\theta^{-1} \omega\right)\right)$, by (C3), we conclude for each $i$,

\leq & \left(c \cdot e^{-\lambda \nu}+K_{0}\right) d_{u}(\gamma(\omega), \tilde{\gamma}(\omega))^{\nu} \\
\leq & \lambda_{2} c d_{u}(\gamma(\omega), \tilde{\gamma}(\omega))^{\nu},

provided $\lambda_{2} \in\left(e^{-\lambda \nu}, 1\right)$, and $c \geq \frac{K_{0}(a, b)}{\lambda_{2}-\exp (-\lambda \nu)}:=c_{0}$. The proof of Lemma 4.5 is complete.
Proof of Sublemma 4.1. Applying Lemma 4.2 and (4.23) to $\rho(\omega) \in D\left(a_{1}, \kappa_{1}, \gamma(\omega)\right)$, we see that $(\tilde{\rho})_{i}\left(\theta^{-1} \omega\right), \tilde{\rho}_{i}\left(\theta^{-1} \omega\right)$ both belong to $D\left(a / 2, \kappa_{1} \nu_{0}, \tilde{\gamma}_{i}\left(\theta^{-1} \omega\right)\right) \subset D\left(a / 2, \kappa, \tilde{\gamma}_{i}\left(\theta^{-1} \omega\right)\right)$. We fix $i$ and prove Sublemma 4.1. Without ambiguity, we denote $\rho^{\prime}\left(\theta^{-1} \omega\right):=(\tilde{\rho})_{i}\left(\theta^{-1} \omega\right)$ and $\rho^{\prime \prime}\left(\theta^{-1} \omega\right):=\tilde{\rho}_{i}\left(\theta^{-1} \omega\right)$ for short.

We normalize the random density $\rho^{\prime}\left(\theta^{-1} \omega\right)$ and $\rho^{\prime \prime}\left(\theta^{-1} \omega\right)$ by letting

\hat{\tau}_{2}\left(\theta^{-1} \omega\right)=\sup _{x \neq y \in \tilde{\gamma}_{i}\left(\theta^{-1} \omega\right)}\left\{1, \frac{\exp \left(a d(x, y)^{\kappa}\right)-\rho^{\prime \prime}\left(y, \theta^{-1} \omega\right) / \rho^{\prime \prime}\left(x, \theta^{-1} \omega\right)}{\exp \left(a d(x, y)^{\kappa}\right)-\rho^{\prime}\left(y, \theta^{-1} \omega\right) / \rho^{\prime}\left(x, \theta^{-1} \omega\right)}\right\} .

So we need to estimate $\log \left(\hat{\tau}_{2}\left(\theta^{-1} \omega\right) / \hat{\tau}_{1}\left(\theta^{-1} \omega\right)\right)$. Denote

& \leq K_{5} d_{u}(\gamma(\omega), \tilde{\gamma}(\omega))^{\nu}, \tag{4.52}

Likewise, $\eta_{\omega}\left(\rho, \tilde{\rho}, \varphi_{1}, \varphi_{2}\right), \eta_{\omega}\left(\tilde{\rho}, \rho, \varphi_{1}, \varphi_{2}\right) \in\left[\tau_{3}, \tau_{4}\right]$ for any $\rho(\omega) \in D\left(a_{1}, \kappa_{1}, \gamma(\omega)\right)$ and corresponding $\tilde{\rho}(\omega) \in D(a / 2, \kappa, \tilde{\gamma}(\omega))$, where $\eta_{\omega}\left(\rho, \tilde{\rho}, \varphi_{1}, \varphi_{2}\right)$ and $\eta_{\omega}\left(\tilde{\rho}, \rho, \varphi_{1}, \varphi_{2}\right)$ are defined in (4.33) and (4.34) respectively.

Let $C_{+, \omega}$ be the collection of all bounded measurable functions $\varphi: M \rightarrow \mathbb{R}$ only satisfying condition (C1), i.e., $\int_{\gamma(\omega)} \varphi(x) \rho(x, \omega) d m_{\gamma(\omega)}(x)>0$ for every local stable submanifold $\gamma(\omega) \subset M$ having size
between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, and every $\rho(\omega) \in D(a / 2, \kappa, \gamma(\omega))$ satisfying $\int_{\gamma(\omega)} \rho(x, \omega) d m_{\gamma(\omega)}(x)=1$. Next, we introduce the projective metric on $C_{+, \omega}$. For $\varphi_{1}, \varphi_{2} \in C_{+, \omega}$, we define

for $\varphi \in L_{\theta^{-N} N_{\omega}}^{N} C_{\theta^{-N_{\omega}}}(b, c, \nu)$ and any $\rho^{\prime}(\omega) \in D\left(a / 2, \kappa, \gamma^{\prime}(\omega)\right)$, $\rho^{\prime \prime}(\omega) \in D\left(a / 2, \kappa, \gamma^{\prime \prime}(\omega)\right)$ with $\int_{\gamma^{\prime \prime}(\omega)} \rho^{\prime \prime}(\omega) d m_{\gamma^{\prime \prime}(\omega)}=\int_{\gamma^{\prime}(\omega)} \rho^{\prime}(\omega) d m_{\gamma^{\prime}(\omega)}=1$. For $\varphi \in L_{\theta^{-N_{\omega}}}^{N} C_{\theta^{-N} \omega}(b, c, \nu)$, let

\bar{k}_{1}(\omega)=\left(\int_{\gamma^{\prime}(\omega)} \varphi(x) d m_{\gamma^{\prime}(\omega)}(x)\right)^{-1}, \bar{k}_{2}(\omega)=\left(\int_{\gamma^{\prime \prime}(\omega)} \varphi(x) d m_{\gamma^{\prime \prime}(\omega)}(x)\right)^{-1} \tag{4.63}
\end{equation*}
$$

and we define

$$
\begin{aligned}
& k_{1}(x, \omega):=\bar{k}_{1}(\omega) / \int_{\gamma^{\prime}(\omega)} \bar{k}_{1}(\omega) d m_{\gamma^{\prime}(\omega)} \text { for } x \in \gamma^{\prime}(\omega) \\
& k_{2}(x, \omega):=\bar{k}_{2}(\omega) / \int_{\gamma^{\prime \prime}(\omega)} \bar{k}_{2}(\omega) d m_{\gamma^{\prime \prime}(\omega)} \text { for } x \in \gamma^{\prime \prime}(\omega)
\end{aligned}
$$

By construction, the constant function $k_{1}(\omega) \in D\left(a / 2, \kappa, \gamma^{\prime}(\omega)\right)$ and $k_{2}(\omega) \in D\left(a / 2, \kappa, \gamma^{\prime \prime}(\omega)\right)$ and $\int_{\gamma^{\prime}(\omega)} k_{1}(x, \omega) d m_{\gamma^{\prime}(\omega)}=1$ and $\int_{\gamma^{\prime \prime}(\omega)} k_{2}(x, \omega) d m_{\gamma^{\prime \prime}(\omega)}=1$. Now by (C2),

& \frac{\int_{\gamma^{\prime \prime}(\omega)} \varphi(x) \rho \prime \prime(x, \omega) d m_{\gamma^{\prime \prime}(\omega)}(x)}{\int_{\gamma^{\prime}(\omega)} \varphi(x) \rho^{\prime}(x, \omega) d m_{\gamma^{\prime}(\omega)}(x)} \\
= & \frac{\int_{\gamma^{\prime \prime}(\omega)} \varphi(x) \rho \rho \prime \prime(x, \omega) d m_{\gamma^{\prime \prime}(\omega)}(x)}{\int_{\gamma^{\prime \prime}(\omega)} \varphi(x) k_{2}(x, \omega) d m_{\gamma^{\prime \prime}(\omega)}(x)} \cdot \frac{\int_{\gamma^{\prime}(\omega)} \varphi(x) k_{1}(x, \omega) d m_{\gamma^{\prime}(\omega)}(x)}{\int_{\gamma^{\prime}(\omega)} \varphi(x) \rho^{\prime}(x, \omega) d m_{\gamma^{\prime}(\omega)}(x)} \cdot \frac{\int_{\gamma^{\prime}(\omega)} \bar{k}_{1}(\omega) d m_{\gamma^{\prime}(\omega)}}{\int_{\gamma^{\prime \prime}(\omega)} \bar{k}_{2}(\omega) d m_{\gamma^{\prime \prime}(\omega)}} \\
\leq & e^{\lambda_{2} b d_{\gamma^{\prime \prime}(\omega)}^{a, \kappa}\left(\rho^{\prime \prime}(\cdot, \omega), k_{2}(\cdot, \omega)\right)} \cdot e^{\lambda_{2} b d_{\gamma^{\prime}(\omega)}^{a, \kappa}\left(\rho^{\prime}(\cdot, \omega), k_{1}(\cdot, \omega)\right)} \cdot \frac{\int_{\gamma^{\prime}(\omega)} \bar{k}_{1}(\omega) d m_{\gamma^{\prime}(\omega)}}{\int_{\gamma^{\prime \prime}(\omega)} \bar{k}_{2}(\omega) d m_{\gamma^{\prime \prime}(\omega)}} . \tag{4.64}
\end{align*}
$$

Sublemma 4.2. There exists a constant $D_{1}=D_{1}(a, b, c, N)<\infty$ such that

\frac{\int_{\gamma^{\prime}(\omega)} \bar{k}_{1}(\omega) d m_{\gamma^{\prime}(\omega)}}{\int_{\gamma^{\prime \prime}(\omega)} \bar{k}_{2}(\omega) d m_{\gamma^{\prime \prime}(\omega)}} \leq D_{1} \tag{4.65}
\end{equation*}
$$

We postpone the proof of Sublemma 4.2 and finish the proof of Lemma 4.6. Now we let $\tau_{5}=$ $\sup \left\{\frac{z-z^{-1 / 2}}{z-z^{1 / 2}}: z>1\right\} \in(1, \infty)$ and $\tau_{6}=\inf \left\{\frac{z-z^{1 / 2}}{z-z^{-1 / 2}}: z>1\right\} \in(0,1)$. Similar to (4.27), the diameter of $D(a / 2, \kappa, \gamma(\omega))$ with respect to the projective metric on $D(a, \kappa, \gamma(\omega))$ is bounded by $4 a+\log \tau_{5} / \tau_{6}$. Therefore,

d_{\gamma^{\prime \prime}(\omega)}^{a, \kappa}\left(\rho^{\prime \prime}(\omega), \bar{k}_{2}(\omega)\right) \leq 4 a+\log \tau_{5} / \tau_{6}, \text { and } d_{\gamma^{\prime}(\omega)}^{a, \kappa}\left(\rho^{\prime}(\omega), \bar{k}_{1}(\omega)\right) \leq 4 a+\log \tau_{5} / \tau_{6}
$$

Hence

\frac{\int_{\gamma^{\prime \prime}(\omega)} \varphi(x) \rho^{\prime \prime}(x, \omega) d m_{\gamma^{\prime \prime}(\omega)}(x)}{\int_{\gamma^{\prime}(\omega)} \varphi(x) \rho^{\prime}(x, \omega) d m_{\gamma^{\prime}(\omega)}(x)} \stackrel{(4.64)}{\leq} e^{2 \lambda_{2} b\left(4 a+\log \tau_{5} / \tau_{6}\right)} D_{1}
$$

As a consequence, we have

d_{+, \omega}\left(\varphi_{1}, \varphi_{2}\right) \stackrel{(4.61)}{\leq} \log \left(e^{4 \lambda_{2} b\left(4 a+\log \tau_{5} / \tau_{6}\right)} D_{1}^{2}\right)
$$

and $d_{\omega}\left(\varphi_{1}, \varphi_{2}\right) \stackrel{(4.60)}{\leq} \log \left(e^{4 \lambda_{2} b\left(4 a+\log \tau_{5} / \tau_{6}\right)} D_{1}^{2}\right)+\log \tau_{4} / \tau_{3}:=D_{2}$, which finishes the proof of Lemma 4.6 .

Proof of Sublemma 4.2. For any $\omega \in \Omega$ and $\psi \in C_{\omega}(b, c, \nu)$, we define

where the supremum and infimum runs over all local stable leaf $\gamma(\omega) \subset M$ having size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, and any $\rho(\omega) \in D\left(a_{1}, \kappa, \gamma(\omega)\right)$.

By noticing that constant function 1 belongs to $D\left(a_{1}, \kappa, \gamma(\omega)\right)$, we have

$$

and here $\bar{k}_{1}(\omega)$ and $\bar{k}_{2}(\omega)$ was defined in (4.63) by using $\varphi \in L_{\theta^{-N_{\omega}}}^{N} C_{\theta^{-N} \omega}(b, c, \nu) \subset C_{\omega}(b, c, \nu)$. Therefore, Lemma 4.2 is proved if there exists $D_{1}=D_{1}(a, b, c, N)>0$ independent of $\omega \in \Omega$ such that

We need some preliminary inequalities before we start the proof of (4.66). By the continuity of $f_{\omega}$ in $\omega$, there exists a constant $K_{6}>0$ such that

We recall that for $\varphi \in C_{\theta^{-n} \omega}(b, c, \nu)$,

\left(K_{6}\right)^{-n} \leq \inf _{x \in M}\left|\left(L_{\theta^{-n} \omega}^{n} \mathbf{1}\right)(x)\right| \leq \sup _{x \in M}\left|\left(L_{\theta^{-n} \omega}^{n} \mathbf{1}\right)(x)\right| \leq\left(K_{6}\right)^{n} \text { for any } \omega \in \Omega, n \in \mathbb{N} \tag{4.68}
\end{equation*}
$$

For any $n \geq 1$ and $\gamma(\omega) \subset M$ local stable leaf having size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, we divide $f_{\omega}^{-n} \gamma(\omega)$ into finite pieces of connected local stable leaves having size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, named $\gamma_{i}\left(\theta^{-n} \omega\right)$ for $i$ belonging to a finite index set such that $\gamma_{i}\left(\theta^{-n} \omega\right) \cap \gamma_{j}\left(\theta^{-n} \omega\right)=\partial \gamma_{i}\left(\theta^{-n} \omega\right) \cap \partial \gamma_{j}\left(\theta^{-n} \omega\right)$ for $i \neq j$. For any $\rho(\omega) \in D\left(a_{1}, \kappa, \gamma(\omega)\right)$, we define

\rho_{i}\left(x, \theta^{-n} \omega\right)=\frac{\left|\operatorname{det} D_{x} f_{\theta^{-n} \omega}^{n}\right| E^{s}\left(x, \theta^{-n} \omega\right) \mid}{\left|\operatorname{det} D_{x} f_{\theta^{-n} \omega}^{n}\right|} \rho\left(f_{\theta^{-n} \omega}^{n} x, \omega\right) \text { for } x \in \gamma_{i}\left(\theta^{-n} \omega\right)
$$

By Remark 4.1, we have $\rho_{i}\left(\theta^{-n} \omega\right) \in D\left(a_{1}, \kappa, \gamma_{i}\left(\theta^{-n} \omega\right)\right)$. Likewise (4.16), we have

\int_{\gamma(\omega)}\left(L_{\theta^{-n} \omega}^{n} \varphi\right)(x) \rho(x, \omega) d m_{\gamma(\omega)}(x)=\sum_{i} \int_{\gamma_{i}\left(\theta^{-n} \omega\right)} \varphi(x) \rho_{i}\left(x, \theta^{-n} \omega\right) d m_{\gamma_{i}\left(\theta^{-n} \omega\right)}(x)
$$

Now we have

$$
\begin{aligned}
& \frac{\int_{\gamma(\omega)}\left(L_{\theta^{-n} \omega}^{n} \varphi\right)(x) \rho(x, \omega) d m_{\gamma(\omega)}(x)}{\int_{\gamma(\omega)} \rho(x, \omega) d m_{\gamma(\omega)}(x)}=\frac{\sum_{i} \int_{\gamma_{i}\left(\theta^{-n} \omega\right)} \varphi(x) \rho_{i}\left(x, \theta^{-n} \omega\right) d m_{\gamma_{i}\left(\theta^{-n} \omega\right)}(x)}{\int_{\gamma(\omega)} \rho(x, \omega) d m_{\gamma(\omega)}(x)} \\
\leq & \frac{\sum_{i} \int_{\gamma_{i}\left(\theta^{-n} \omega\right)} \rho_{i}\left(x, \theta^{-n} \omega\right) d m_{\gamma_{i}\left(\theta^{-n} \omega\right)}(x) \cdot\|\varphi\|_{\theta^{-n} \omega,+}}{\int_{\gamma(\omega)} \rho(x, \omega) d m_{\gamma(\omega)}(x)} \\
= & \frac{\int_{\gamma(\omega)}\left(L_{\theta^{-n} \omega}^{n} \mathbf{1}\right)(x) \rho(x, \omega) d m_{\gamma(\omega)}(x)}{\int_{\gamma(\omega)} \rho(x, \omega) d m_{\gamma(\omega)}(x)} \cdot\|\varphi\|_{\theta^{-n} \omega,+} \\
& \leq\left(K_{6}\right)^{n} \cdot\|\varphi\|_{\theta^{-n} \omega,+},
\end{aligned}
$$

where the last inequality holds since $\rho(x, \omega)>0$ for all $x \in \gamma(\omega)$ by (D1). Since $\gamma(\omega)$ and $\rho(\omega) \in$ $D\left(a_{1}, \kappa, \gamma(\omega)\right)$ are arbitrary, we get

Next, there exists a constant $D_{3}>0$ such that for any $\omega \in \Omega$, any $\gamma(\omega) \subset M$ local stable leaf having size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon), \rho_{1}(\omega), \rho_{2}(\omega) \in D(a / 2, \kappa, \gamma(\omega))$, any $\varphi \in C_{\omega}(b, c, \nu)$, one has

\sup _{z \in \gamma(\omega)} \frac{\rho_{2}(z, \omega) \int_{\gamma(\omega)} \varphi(x) \rho_{1}(x, \omega) d m_{\gamma(\omega)}(x)}{\rho_{1}(z, \omega) \int_{\gamma(\omega)} \varphi(x) \rho_{2}(x, \omega) d m_{\gamma(\omega)}(x)} \leq D_{3}<\infty \tag{4.70}
\end{equation*}
$$

In fact, for any $z \in \gamma(\omega)$, then by condition (C2) and the fact that the diameter of $D(a / 2, \kappa, \gamma(\omega))$ in $D(a, \kappa, \gamma(\omega))$ with respect to the projective metric $d_{\gamma(\omega)}^{a, \kappa}$ is bounded by $4 a+\log \left(\tau_{5} / \tau_{6}\right)$, we have

\begin{aligned}
& \frac{\rho_{2}(z, \omega)}{\rho_{1}(z, \omega)} \cdot \frac{\int_{\gamma(\omega)} \varphi(x) \rho_{1}(x, \omega) d m_{\gamma(\omega)}(x) / \int_{\gamma(\omega)} \rho_{1}(\omega) d m_{\gamma(\omega)}}{\int_{\gamma(\omega)} \varphi(x) \rho_{2}(x, \omega) d m_{\gamma(\omega)}(x) / \int_{\gamma(\omega)} \rho_{2}(\omega) d m_{\gamma(\omega)}} \cdot \frac{\int_{\gamma(\omega)} \rho_{1}(\omega) d m_{\gamma(\omega)}}{\int_{\gamma(\omega)} \rho_{2}(\omega) d m_{\gamma(\omega)}} \\
\leq & \frac{\rho_{2}(z, \omega)}{\int_{\gamma(\omega)} \rho_{2}(x, \omega) d m_{\gamma(\omega)}(x)} \cdot e^{b d_{\gamma(\omega)}^{a, \kappa}\left(\rho_{1}(\omega), \rho_{2}(\omega)\right)} \cdot \frac{\int_{\gamma(\omega)} \rho_{1}(x, \omega) d m_{\gamma(\omega)}(x)}{\rho_{1}(z, \omega)} \\
\leq & \frac{\rho_{2}(z, \omega)}{\int_{\gamma(\omega)} \rho_{2}(x, \omega) d m_{\gamma(\omega)}(x)} \cdot e^{\left(4 a+\log \tau_{5} / \tau_{6}\right) b} \cdot \frac{\int_{\gamma(\omega)} \rho_{1}(x, \omega) d m_{\gamma(\omega)}(x)}{\rho_{1}(z, \omega)} \\
\leq & e^{a / 2(\operatorname{diam}(\gamma(\omega)))^{\kappa}} \cdot e^{a / 2(\operatorname{diam}(\gamma(\omega)))^{\kappa}} \cdot e^{\left(4 a+\log \tau_{5} / \tau_{6}\right) b} \\
= & e^{a+b\left(4 a+\log \tau_{5} / \tau_{6}\right)}:=D_{3} .
\end{aligned}
$$

Now we are in the position to prove (4.66). Recall that $N \in \mathbb{N}$ satisfying (4.54) and (4.55). For any $\omega \in \Omega$ and $\varphi \in C_{\theta-N_{\omega}}(b, c, \nu)$, we choose $\gamma_{*}\left(\theta^{-N} \omega\right)$ a local stable leaf having size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, and $\rho_{*}\left(\theta^{-N} \omega\right) \in D\left(a_{1}, \kappa, \gamma_{*}\left(\theta^{-N} \omega\right)\right)$ such that

\frac{\int_{\gamma_{*}\left(\theta^{-N} \omega\right)} \varphi(x) \rho_{*}\left(x, \theta^{-N} \omega\right) d m_{\gamma_{*}\left(\theta^{-N} \omega\right)}}{\int_{\gamma_{*}\left(\theta^{-N} \omega\right)} \rho_{*}\left(x, \theta^{-N} \omega\right) d m_{\gamma_{*}\left(\theta^{-N} \omega\right)}} \geq \frac{1}{2}\|\varphi\|_{\theta^{-N} \omega,+} .
$$

We pick $x_{*}\left(\theta^{-N} \omega\right) \in \gamma_{*}\left(\theta^{-N} \omega\right)$ such that

$$
W_{\epsilon^{*}}^{s}\left(x_{*}\left(\theta^{-N} \omega\right), \theta^{-N} \omega\right) \subset \gamma_{*}\left(\theta^{-N} \omega\right) \subset W_{\epsilon}^{s}\left(x_{*}\left(\theta^{-N} \omega\right), \theta^{-N} \omega\right) .
$$

To avoid the size of the holonomy image of $\gamma_{*}\left(\theta^{-N} \omega\right)$ being too large, we break $\gamma_{*}\left(\theta^{-N} \omega\right)$ into pieces of size between $\frac{A(\epsilon)}{4 J}$ and $\frac{A(\epsilon)}{J}$. The number of pieces is at most $\frac{A(\epsilon)}{A(\epsilon) / J}+1=J+1$. We can pick one of pieces, named $\gamma_{*}^{1}\left(\theta^{-N} \omega\right)$, such that

\frac{\int_{\gamma_{*}^{1}\left(\theta^{-N} \omega\right)} \varphi(x) \rho_{*}\left(x, \theta^{-N} \omega\right) d m_{\gamma_{*}\left(\theta^{-N} \omega\right)}}{\int_{\gamma_{*}\left(\theta^{-N} \omega\right)} \rho_{*}\left(x, \theta^{-N} \omega\right) d m_{\gamma_{*}\left(\theta^{-N} \omega\right)}} \geq \frac{1}{2(J+1)}\|\varphi\|_{\theta^{-N} \omega,+\cdot} . \tag{4.71}
\end{equation*}

Pick any $\gamma(\omega) \subset M$ local stable leaf having size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, and $x(\omega) \in \gamma(\omega)$ such that

Recall that $\left\{B_{\delta / 4}\left(x_{i}\right)\right\}_{i=1}^{l}$ is a cover of $M$. Then there exists $i, j \in\{1, \ldots, l\}$ such that $x_{*}\left(\theta^{-N} \omega\right) \in$ $B_{\delta / 4}\left(x_{i}\right)$ and $x(\omega) \in B_{\delta / 4}\left(x_{j}\right)$. Then by the choice of $N, \phi^{N}\left(B_{\delta / 4}\left(x_{i}\right) \times\left\{\theta^{-N} \omega\right\}\right) \cap\left(B_{\delta / 4}\left(x_{j}\right) \times\{\omega\}\right) \neq$ $\emptyset$. Pick $y(\omega) \in f_{\theta^{-N} \omega}^{N} B_{\delta / 4}\left(x_{i}\right) \cap B_{\delta / 4}\left(x_{j}\right)$, then

$$
d(y(\omega), x(\omega)) \leq d\left(y(\omega), x_{j}\right)+d\left(x_{j}, x(\omega)\right) \leq \delta / 4+\delta / 4<\delta .
$$

Then

$$
y_{1}(\omega):=W_{\epsilon^{*} / 8}^{u}(y(\omega), \omega) \cap W_{\epsilon^{*} / 8}^{s}(x(\omega), \omega) \subset W_{\epsilon^{*} / 8}^{u}(y(\omega), \omega) \cap \gamma(\omega)
$$

exists. Note that by (4.55), we have

d\left(f_{\omega}^{-N} y(\omega), f_{\omega}^{-N} y_{1}(\omega)\right) \leq e^{-\lambda N} \cdot \frac{\epsilon^{*}}{8} \leq \delta / 4 .
$$

So

& \leq \delta / 4+\delta / 4+\delta / 4<\delta .

As a consequence,

Note that $f_{\omega}^{-N} y_{1}(\omega) \in f_{\omega}^{-N} \gamma(\omega)$, and $e^{\lambda N} \epsilon^{*} / 8 \stackrel{(4.55)}{\geq} 3 \epsilon$, therefore, $W_{3 \epsilon}^{s}\left(f_{\omega}^{-N} y_{1}(\omega), \theta^{-N} \omega\right) \subset f_{\omega}^{-N} \gamma(\omega)$. Moreover, (4.72) implies that $\gamma_{*}(\omega)$ is sufficient close to $W_{3 \epsilon}^{s}\left(f_{\omega}^{-N} y_{1}(\omega), \theta^{-N} \omega\right) \subset f_{\omega}^{-N} \gamma(\omega)$. As a consequence, $f_{\omega}^{-N} \gamma(\omega)$ contains a holonomy image of $\gamma_{*}^{1}\left(\theta^{-N} \omega\right)$, named $\gamma_{1}\left(\theta^{-N} \omega\right)$. Since the size of $\gamma_{*}^{1}\left(\theta^{-N} \omega\right)$ is between $\frac{A(\epsilon)}{4 J}$ and $\frac{A(\epsilon)}{J}$, by holonomy, the size of $\gamma_{1}\left(\theta^{-N} \omega\right)$ is between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$.

Now for any $\rho(\omega) \in D\left(a_{1}, \kappa, \gamma(\omega)\right)$, define

Let $\tilde{\rho}_{1}\left(\theta^{-N} \omega\right)$ be the density function on $\gamma_{*}^{1}\left(\theta^{-N} \omega\right)$ defined as (4.17) corresponding to $\rho_{1}\left(\theta^{-N} \omega\right)$, and therefore $\tilde{\rho}_{1}\left(\theta^{-N} \omega\right) \in$ $D\left(a / 2, \kappa, \gamma_{*}^{1}\left(\theta^{-N} \omega\right)\right)$ by Lemma 4.2. where $d_{\omega}$ and $d_{\theta^{n} \omega}$ are projective metric on $C_{\omega}(b, c, \nu)$ and $C_{\theta^{n} \omega}(b, c, \nu)$ respectively.

Now we have a linear operator $L_{\theta^{-N_{\omega}}}^{N}$ maps cone $C_{\theta^{-N} \omega}(b, c, \nu)$ into cone $C_{\omega}(b, c, \nu)$ with finite diameter of $L_{\theta^{-N \omega}}^{N}\left(C_{\theta^{-N}}(b, c, \nu)\right)$ in $C_{\omega}(b, c, \nu)$, then we apply Birkhoff's inequality (Proposition A.3) to obtain that for all $\omega \in \Omega$,

&=\left(1-e^{-D_{2}}\right)^{\left[\frac{n-N}{N}\right]} d_{\theta^{-n+N+r} \omega}\left(L_{\theta^{-n+r} \omega}^{N} L_{\theta^{-n} \omega}^{r} \varphi_{\theta^{-n} \omega}^{1}, L_{\theta^{-n+r} \omega}^{N} L_{\theta^{-n} \omega}^{r} \varphi_{\theta^{-n} \omega}^{2}\right) \\

4.3. Construction of the random SRB measure. In this subsection, we will prove that the sequence $\left(f_{\theta^{-n} \omega}^{n}\right)_{*} m$ converges with respect to the weak* topology on $\operatorname{Pr}(M)$ by using the contraction of $L_{\theta-n_{\omega}}^{n}$ when $n \geq N$. Moreover, we will prove that the random probability measure $\mu_{\omega}$ defined by the weak ${ }^{*}$ limit of $\left(f_{\theta^{-n} \omega}^{n}\right)_{*} m$ is $\phi$-invariant.

Before we introduce the next lemma, we need some preparations. For any $\omega \in \Omega$, since the local stable leaves form a partition in a neighborhood of a point on each $M$, we can cover $M$ on the fiber $\{\omega\}$ by finite rectangles, i.e., $\mathcal{R}(\omega)=\left\{R_{1}(\omega), \ldots, R_{i}(\omega), \ldots, R_{k(\omega)}(\omega)\right\}, k(\omega)<\infty$, satisfying
(A) each $R_{i}(\omega)$ is a proper rectangle, i.e., it is the closure of its interior;
(B) interior $\left(R_{i}(\omega)\right) \cap$ interior $\left(R_{j}(\omega)\right)=\emptyset$ if $i \neq j$;
(C) each $R_{i}(\omega)$ is foliated by local stable leaves having size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$.

The conditions (A) and (B) of this cover is much weaker than the conditions of random Markov partition constructed in [20, Sec. 3]. We can obtain (C) by cutting and pasting some sets of the random Markov partition if necessary.

By Proposition 3.3, for any $i \in\{1, \ldots, k(\omega)\}$, there exists a function $H_{i}(\omega): R_{i}(\omega) \rightarrow \mathbb{R}^{+}$with $\log H_{i}(\omega)\left(a_{0}, \nu_{0}\right)$-Hölder continuous on each local stable leaf and for all bounded measurable functions $\psi: M \rightarrow \mathbb{R}$, we have disintegration

where $\gamma^{i}(\omega)$ denotes the stable leaves in $R_{i}(\omega)$ and $\tilde{m}_{R_{i}(\omega)}$ is the quotient measure induced by Riemannian volume measure in the space of local stable leaves in $R_{i}(\omega)$.

Lemma 4.8. For any $\omega \in \Omega$, given any positive function sequence $\left\{\varphi_{n}\right\}_{n \in \mathbb{N}} \subset C_{\omega}(b, c, \nu)$ satisfying

Proof. In the case that $\psi: M \rightarrow \mathbb{R}$ is a constant function, $\left\{\int_{M} \varphi_{n}(x) \psi(x) d m(x)\right\}_{n \in \mathbb{N}}$ is a constant sequence, therefore Cauchy. In the following, we only need to consider the case that $\psi$ is nonconstant continuous function.

First, we consider any positive nonconstant continuous function $\psi: M \rightarrow \mathbb{R}$, satisfying

$$
|\log \psi|_{\kappa}=\sup _{x, y \in M, x \neq y} \frac{|\log \psi(x)-\log \psi(y)|}{d(x, y)^{\kappa}}<\frac{a}{4} .
$$

Let $R_{i}(\omega)$ and $H_{i}(\omega)$ be defined as above for $i \in\{1, \ldots, k(\omega)\}$. Note that $\left.\psi(\cdot) H_{i}(\omega)(\cdot)\right|_{\gamma^{i}(\omega)}$ is strictly positive on any local stable leaf $\gamma^{i}(\omega) \subset R_{i}(\omega)$. Moreover, $\log \left(\psi(\cdot) H_{i}(\omega)(\cdot)\right)$ is $(a / 2, \kappa)$-Hölder continuous on $\gamma^{i}(\omega)$ since both $\log \psi$ and $\log H_{i}(\omega)$ are $(a / 2, \kappa)$-Hölder continuous on $\gamma^{i}(\omega)$. Hence $\left.\left(\psi \cdot H_{i}(\omega)\right)\right|_{\gamma^{i}(\omega)} \in D\left(\frac{a}{2}, \kappa, \gamma^{i}(\omega)\right)$. Therefore, by the representation of $\beta_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right)$ and $\alpha_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right)$ as in (4.59) and (4.58), for all $i \in\{1, \ldots, k(\omega)\}$, any local stable leaf $\gamma^{i}(\omega) \subset R_{i}(\omega)$ and $k, l \in \mathbb{N}$, we have

\begin{align*}
& \frac{\left.\int_{\gamma^{i}(\omega)} \varphi_{k}(x) \psi(x) H_{i}(\omega)(x)\right|_{\gamma^{i}(\omega)} d m_{\gamma^{i}(\omega)}(x)}{\left.\int_{\gamma^{i}(\omega)} \varphi_{l}(x) \psi(x) H_{i}(\omega)(x)\right|_{\gamma^{i}(\omega)} d m_{\gamma^{i}(\omega)}(x)} \\
&= \frac{\left.\int_{\gamma^{i}(\omega)} \varphi_{k}(x) \psi(x) H_{i}(\omega)(x)\right|_{\gamma^{i}(\omega)} d m_{\gamma^{i}(\omega)}(x) /\left.\int_{\gamma^{i}(\omega)} \psi(x) H_{i}(\omega)(x)\right|_{\gamma^{i}(\omega)} d m_{\gamma^{i}(\omega)}(x)}{\left.\int_{\gamma^{i}(\omega)} \varphi_{l}(x) \psi(x) H_{i}(\omega)(x)\right|_{\gamma^{i}(\omega)} d m_{\gamma^{i}(\omega)}(x) /\left.\int_{\gamma^{i}(\omega)} \psi(x) H_{i}(\omega)(x)\right|_{\gamma^{i}(\omega)} d m_{\gamma^{i}(\omega)}(x)}  \tag{4.79}\\
& \in \in\left[\alpha_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right), \beta_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right)\right] .
\end{align*}
$$

By the assumption that $\int_{M} \varphi_{k}(x) d m(x)=\int_{M} \varphi_{l}(x) d m(x)=1$ and (4.77), there exists a $\hat{i}$ and a local stable leaf $\gamma^{\hat{i}}(\omega) \subset R_{\hat{i}}(\omega)$ such that

$$
\begin{equation*}
\left.\int_{\gamma^{\hat{i}}(\omega)} \varphi_{k}(x) H_{\hat{i}}(\omega)(x)\right|_{\gamma^{\hat{i}}(\omega)} d m_{\gamma^{i}(\omega)}(x) \leq\left.\int_{\gamma^{\hat{i}}(\omega)} \varphi_{l}(x) H_{\hat{i}}(\omega)(x)\right|_{\gamma^{\hat{i}}(\omega)} d m_{\gamma^{i}(\omega)}(x) . \tag{4.80}
\end{equation*}
$$

Otherwise,

$$
\begin{aligned}
\int_{M} \varphi_{k} d m & =\left.\sum_{i=1}^{k(\omega)} \iint_{\gamma^{i}(\omega)} \varphi_{k}(x) H_{i}(\omega)(x)\right|_{\gamma^{i}(\omega)} d m_{\gamma^{i}(\omega)}(x) d \tilde{m}_{R_{i}(\omega)} \\
& >\left.\sum_{i=1}^{k(\omega)} \iint_{\gamma^{i}(\omega)} \varphi_{l}(x) H_{i}(\omega)(x)\right|_{\gamma^{i}(\omega)} d m_{\gamma^{i}(\omega)}(x) d \tilde{m}_{R_{i}(\omega)}=\int_{M} \varphi_{l} d m
\end{aligned}
$$

a contradiction. Now for any $i$ and local stable leaf $\gamma^{i}(\omega) \subset R_{i}(\omega)$, we have

$$
\begin{align*}
& \quad \frac{\left.\int_{\gamma^{i}(\omega)} \varphi_{k}(x) \psi(x) H_{i}(\omega)(x)\right|_{\gamma^{i}(\omega)} d m_{\gamma^{i}(\omega)}(x)}{\left.\int_{\gamma^{i}(\omega)} \varphi_{l}(x) \psi(x) H_{i}(\omega)(x)\right|_{\gamma^{i}(\omega)} d m_{\gamma^{i}(\omega)}(x)} \\
& \stackrel{(4.79)}{\leq} \beta_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right)=\frac{\beta_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right)}{\alpha_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right)} \cdot \alpha_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right) \\
& \stackrel{(4.79)}{\leq} \frac{\beta_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right)}{\alpha_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right)} \cdot \frac{\left.\int_{\gamma^{i}(\omega)} \varphi_{k}(x) H_{\hat{i}}(\omega)(x)\right|_{\hat{i}^{\hat{i}}}(\omega)}{\left.\int_{\gamma^{i}(\omega)} \varphi_{l}(x) H_{\hat{i}}(\omega)(x)\right|_{\gamma^{i} i}(\omega)} d m_{\gamma^{i}(\omega)}(x)  \tag{4.81}\\
& (4.80) \\
& \leq \frac{\beta_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right)}{\alpha_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right)} \cdot 1 \\
& =\exp \left(d_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right)\right), \text { for all } k, l \geq 1 .
\end{align*}
$$

By assumption, $d_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right) \rightarrow 0$ exponentially as $n, m \rightarrow \infty$. Now pick $N^{\prime}>0$ such that for any $k, l>N^{\prime}, d_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right)<\frac{1}{2}$, then we have

= & \left|\int_{M} \varphi_{l}(x) \psi(x) d m(x)\right| \cdot\left|\frac{\int_{M} \varphi_{k}(x) \psi(x) d m(x)}{\int_{M} \varphi_{l}(x) \psi(x) d m(x)}-1\right| \\
\leq & \sup _{x \in M}|\psi(x)| \cdot\left|\frac{\sum_{i=1}^{k(\omega)} \int_{R_{i}(\omega)} \varphi_{k}(x) \psi(x) d m(x)}{\sum_{i=1}^{k(\omega)} \int_{R_{i}(\omega)} \varphi_{l}(x) \psi(x) d m(x)}-1\right|  \tag{4.82}\\
= & \|\psi\|_{C^{0}(M)} \cdot\left|\frac{\left.\sum_{i=1}^{k(\omega)} \iint_{\gamma^{i}(\omega)} \varphi_{k}(x) \psi(x) H_{i}(\omega)(x)\right|_{\gamma^{i}(\omega)} d m_{\gamma^{i}(\omega)}(x) d \tilde{m}_{R_{i}(\omega)}}{\left.\sum_{i=1}^{k(\omega)} \iint_{\gamma^{i}(\omega)} \varphi_{l}(x) \psi(x) H_{i}(\omega)(x)\right|_{\gamma^{i}(\omega)} d m_{\gamma^{i}(\omega)}(x) d \tilde{m}_{R_{i}(\omega)}}-1\right| \\
& \stackrel{(4.81)}{\leq}\|\psi\|_{C^{0}(M)} \cdot\left(e^{d_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right)}-1\right) \\
\leq & 2\|\psi\|_{C^{0}(M)} \cdot d_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right),
\end{align*}
$$

where in the first $\leq$ we use the positivity of $\varphi_{l}$ and $\int \varphi_{l} d m=1$. Hence $\left\{\int_{M} \varphi_{n}(x) \psi(x) d m(x)\right\}_{n \in \mathbb{N}}$ is a Cauchy sequence in this case.

Secondly, for any nonconstant function $\psi \in C^{0, \kappa}(M)$, let

B=\frac{5|\psi|_{\kappa}}{a}>0,
$$

where $|\psi|_{\kappa}:=\sup _{x, y \in M, x \neq y} \frac{|\psi(x)-\psi(y)|}{d(x, y)^{\kappa}}$. We define

\psi_{B}^{+}:=\frac{1}{2}(|\psi|+\psi)+B, \psi_{B}^{-}:=\frac{1}{2}(|\psi|-\psi)+B .
$$

Then for any $x, y \in M$, we have

\left|\psi_{B}^{ \pm}(x)-\psi_{B}^{ \pm}(y)\right| \leq|\psi|_{\kappa} d(x, y)^{\kappa},
$$

and therefore, we obtain

$$
\left|\frac{\psi_{B}^{ \pm}(x)}{\psi_{B}^{ \pm}(y)}-1\right| \leq \frac{a}{5} d(x, y)^{\kappa} .
$$

Switch $x$ and $y$ to get

$$
\begin{equation*}
\left|\log \psi_{B}^{ \pm}\right|_{\kappa}=\sup _{x, y \in M, x \neq y} \frac{\left|\log \psi_{B}^{ \pm}(x)-\log \psi_{B}^{ \pm}(y)\right|}{d(x, y)^{\kappa}}<\frac{a}{4} . \tag{4.83}
\end{equation*}
$$

Then we apply (4.82) and the linearity of integration, for any $k, l>N^{\prime}$, one has

$$
\begin{aligned}
& \left|\int_{M} \varphi_{k}(x) \psi(x) d m(x)-\int_{M} \varphi_{l}(x) \psi(x) d m(x)\right| \\
\leq & \left|\int_{M} \varphi_{k}(x) \psi_{B}^{+}(x) d m(x)-\int_{M} \varphi_{l}(x) \psi_{B}^{+}(x) d m(x)\right|+\left|\int_{M} \varphi_{k}(x) \psi_{B}^{-}(x) d m(x)-\int_{M} \varphi_{l}(x) \psi_{B}^{-}(x) d m(x)\right| \\
\leq & 2\left(\left\|\psi_{B}^{+}\right\|_{C^{0}(M)}+\left\|\psi_{B}^{-}\right\|_{C^{0}(M)}\right) d_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right) \\
\leq & \left(4\|\psi\|_{C^{0}(M)}+\frac{20}{a}|\psi|_{\kappa}\right) d_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right) \\
\leq & \max \left\{4, \frac{20}{a}\right\}\|\psi\|_{C^{0, \kappa}(M)} \cdot d_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right) .
\end{aligned}
$$

Finally, for any nonconstant continuous function $\psi: M \rightarrow \mathbb{R}$, for any $\epsilon>0$, we can pick a nonconstant function $\tilde{\psi} \in C^{0, \kappa}(M)$ such that

$$
\sup _{x \in M}|\psi(x)-\tilde{\psi}(x)|<\epsilon / 4
$$

Now, pick $N^{\prime \prime}>N^{\prime}>0$ depending on $\tilde{\psi}$ and $\epsilon$ such that for all $k, l \geq N^{\prime \prime}$

\max \left\{4, \frac{20}{a}\right\} \cdot\|\tilde{\psi}\|_{C^{0, \kappa}(M)} \cdot d_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right)<\epsilon / 2
$$

Then for any $k, l \geq N^{\prime \prime}$, one has

$$
\begin{aligned}
&\left|\int_{M} \varphi_{k}(x) \psi(x) d m(x)-\int_{M} \varphi_{l}(x) \psi(x) d m(x)\right| \\
& \leq\left|\int_{M} \varphi_{k}(x) \tilde{\psi}(x) d m(x)-\int_{M} \varphi_{l}(x) \tilde{\psi}(x) d m(x)\right|+\int_{M} \varphi_{k}|\psi-\tilde{\psi}| d m+\int_{M} \varphi_{l}|\psi-\tilde{\psi}| d m \\
& \stackrel{(4.78)}{\leq} \max \left\{4, \frac{20}{a}\right\} \cdot\|\tilde{\psi}\|_{C^{0, \kappa}(M)} \cdot d_{+, \omega}\left(\varphi_{k}, \varphi_{l}\right)+\epsilon / 4+\epsilon / 4 \\
& \leq \epsilon
\end{aligned}
$$

where we note that $\varphi_{k}$ and $\varphi_{l}$ are positive functions. Hence, for any continuous function $\psi: M \rightarrow \mathbb{R}$, the sequence $\left\{\int_{M} \varphi_{n}(x) \psi(x) d m(x)\right\}_{n \in \mathbb{N}}$ is a Cauchy sequence. The proof of Lemma 4.8 is complete.

For any measurable function $\varphi: M \rightarrow \mathbb{R}$, we define the fiber Koopman operator

\begin{equation*}
U_{\omega} \varphi: M \rightarrow \mathbb{R},\left(U_{\omega} \varphi\right)(x):=\varphi\left(f_{\theta^{-1} \omega} x\right) . \tag{4.84}
\end{equation*}
$$

We denote

$$
U_{\omega}^{n}:=U_{\theta^{-(n-1)} \omega} \circ \cdots \circ U_{\theta^{-1} \omega} \circ U_{\omega} \text { for all } n \in \mathbb{N} \text { and } \omega \in \Omega
$$

For any $\omega \in \Omega$ and any bounded measurable functions $\varphi_{1}, \varphi_{2}$, by changing variable, we have

\begin{aligned}
\int_{M}\left(L_{\theta^{-1} \omega} \varphi_{1}\right)(y) \varphi_{2}(y) d m(y) & \left.=\int_{M} \frac{\varphi_{1}\left(\left(f_{\theta^{-1} \omega}\right)^{-1} y\right)}{\left.\mid \operatorname{det} D_{\left(f_{\theta-1}\right.}\right)^{-1}(y)} f_{\theta^{-1} \omega} \right\rvert\,
\end{aligned} \varphi_{2}(y) d m(y) \quad \begin{aligned}
& \int_{M} \frac{\varphi_{1}(x)}{\left|\operatorname{det} D_{x} f_{\theta^{-1} \omega}\right|} \varphi_{2}\left(f_{\theta^{-1} \omega} x\right)\left|\operatorname{det} D_{x} f_{\theta^{-1} \omega}\right| d m(x)
\end{aligned}
$$

$$
\begin{equation*}
=\int_{M} \varphi_{1}(x)\left(U_{\omega} \varphi_{2}\right)(x) d m(x) \tag{4.85}
\end{equation*}
$$

Let $\mathbf{1}$ be the constant function $\mathbf{1}(x) \equiv 1$, then $\mathbf{1} \in C_{\omega}(b, c, \nu)$ for all $\omega \in \Omega$ by the Remark 4.3. Now consider $\varphi_{n}=L_{\theta^{-n} \omega}^{n} \mathbf{1}$ for $n \geq N$ and notice that for all $\omega \in \Omega$,

\int_{M}\left(L_{\theta^{-n} \omega}^{n} \mathbf{1}\right)(x) d m(x)=\int_{M} \mathbf{1}(x)\left(U_{\omega}^{n} 1\right)(x) d m(x)=\int_{M} \mathbf{1} d m(x)=1 .
$$

Moreover, by (4.74), we have

d_{+, \omega}\left(L_{\theta^{-n} \omega}^{n} \mathbf{1}, L_{\theta^{-(n+k) \omega}}^{n+k} \mathbf{1}\right) \leq d\left(L_{\theta^{-n_{\omega}}}^{n} \mathbf{1}, L_{\theta^{-n} \omega}^{n}\left(L_{\theta^{-(n+k) \omega}}^{k} \mathbf{1}\right)\right) \leq \Lambda^{n} \cdot D_{4} \text { for } n \geq N . \tag{4.86}
\end{equation*}
$$

Hence the positive functions sequence $\left\{\varphi_{n}=L_{\theta^{-n} \omega}^{n} \mathbf{1}\right\}_{n \in \mathbb{N}} \subset C_{\omega}(b, c, \nu)$ satisfies conditions of Lemma 4.8. So for any $g \in C^{0}(M),\left\{\int_{M}\left(L_{\theta^{-n} \omega}^{n} \mathbf{1}\right)(x) g(x) d m\right\}_{n \in \mathbb{N}}$ is a Cauchy sequence. Now define $\mathcal{F}_{\omega}$ : $C^{0}(M) \rightarrow \mathbb{R}$ by $\mathcal{F}_{\omega}(g)=\lim _{n \rightarrow \infty} \int_{M}\left(L_{\theta^{-n} \omega}^{n} \mathbf{1}\right)(x) g(x) d m(x)$. It is clear that $\mathcal{F}_{\omega}$ is a positive linear functional on $C^{0}(M)$. By the Riesz representation theorem, there exists a regular Borel measure $\mu_{\omega}$ such that

$$
\begin{equation*}
\int_{M} g(x) d \mu_{\omega}(x)=\lim _{n \rightarrow \infty} \int_{M}\left(L_{\theta^{-n} \omega}^{n} \mathbf{1}\right)(x) g(x) d m(x) . \tag{4.87}
\end{equation*}
$$

Moreover, $\mu_{\omega}$ is a probability measure since $\mu_{\omega}(M)=\lim _{n \rightarrow \infty} \int_{M}\left(L_{\theta^{-n} \omega}^{n} \mathbf{1}\right)(x) d m(x)=1$.
Note that for each $g \in C^{0}(M), \omega \mapsto \int_{M} g(x) d \mu_{\omega}(x)$ is measurable because of the measurability of $\omega \mapsto \int_{M}\left(L_{\theta^{-n} \omega}^{n} \mathbf{1}\right)(x) g(x) d m(x)$. For any closed set $B \subset M$, let $g_{k}(x):=1-\min \{k d(x, B), 1\}$ for $k \in \mathbb{N}$ where $d(x, B):=\inf \{d(x, y): y \in B\}$, then $g_{k}(x) \in C^{0}(M)$ and $g_{k}(x) \searrow 1_{B}(x)$. Then by Monotone convergence theorem, we have

$$
\mu_{\omega}(B)=\lim _{k \rightarrow \infty} \int_{M} g_{k}(x) d \mu_{\omega}(x)=\lim _{k \rightarrow \infty} \lim _{n \rightarrow \infty} \int_{M}\left(L_{\theta^{-n} \omega}^{n} \mathbf{1}\right)(x, \omega) g_{k}(x) d m(x)
$$

Hence $\omega \mapsto \mu_{\omega}(B)$ is measurable for any closed set $B \subset M$. By the definition in Section 2.2, $\omega \mapsto \mu_{\omega}$ defines a random probability measure.

Now for any continuous $g: M \rightarrow \mathbb{R}$,

$$
\begin{aligned}
\int_{M} g\left(f_{\omega} x\right) d \mu_{\omega} & =\lim _{n \rightarrow \infty} \int_{M}\left(L_{\theta^{-n} \omega}^{n} \mathbf{1}\right)(x) g\left(f_{\omega} x\right) d m(x) \stackrel{(4.85)}{=} \lim _{n \rightarrow \infty} \int_{M} g\left(f_{\omega} f_{\theta^{-n} \omega}^{n} x\right) d m(x) \\
& =\lim _{n \rightarrow \infty} \int_{M} g\left(f_{\theta^{-(n+1)} \theta \omega}^{n+1} x\right) d m(x)=\lim _{n \rightarrow \infty} \int_{M}\left(L_{\theta^{-(n+1)} \theta \omega}^{n+1} \mathbf{1}\right)(x) g(x) d m(x) \\
& =\int_{M} g(x) d \mu_{\theta \omega} .
\end{aligned}
$$

Thus, the random probability measure $\mu_{\omega}$ is $\phi$-invariant, i.e.,

\left(f_{\omega}\right)_{*} \mu_{\omega}=\mu_{\theta \omega} \text { for all } \omega \in \Omega \tag{4.88}
\end{equation*}
$$

Notice that for any $g \in C^{0}(M)$, we have

\int_{M} g(x) d \mu_{\omega}(x) & =\lim _{n \rightarrow \infty} \int_{M}\left(L_{\theta^{-n} \omega}^{n} \mathbf{1}\right)(x) g(x) d m(x) \stackrel{(4.85)}{=} \lim _{n \rightarrow \infty} \int_{M} U_{\omega}^{n} g d m \\
& =\lim _{n \rightarrow \infty} \int_{M} g\left(f_{\theta^{-n} \omega}^{n} x\right) d m(x)=\lim _{n \rightarrow \infty} \int_{M} g(y) d\left(f_{\theta^{-n} \omega}^{n}\right)_{*} m(y) .
\end{aligned}
$$

So $\mu_{\omega}$ is actually the weak ${ }^{*}-$ limit of $\left(f_{\theta^{-n} \omega}^{n}\right)_{*} m$.

Remark 4.4. For each $\omega \in \Omega, k \in \mathbb{N}$ and any positive function $\varphi_{\theta^{-k} \omega} \in C_{\theta^{-k} \omega}(b, c, \nu)$ such that $\int_{M} \varphi_{\theta^{-k} \omega}(x) d m=1$, then we must have

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \int_{M}\left(L_{\theta^{-n} \omega}^{n} \varphi_{\theta^{-n} \omega}\right)(x) g(x) d m(x)=\int_{M} g(x) d \mu_{\omega}(x), \forall g \in C^{0}(M) . \tag{4.89}
\end{equation*}
$$

In fact, we define the sequence $\hat{\varphi}_{n} \in C_{\omega}(b, c, \nu)$ by $\hat{\varphi}_{2 k}=L_{\theta^{-k} \omega}^{k} 1, \hat{\varphi}_{2 k+1}=L_{\theta^{-k} \omega}^{k} \varphi_{\theta^{-k} \omega}$ for all $k \geq N$. By noticing

$$
d_{+, \omega}\left(\hat{\varphi}_{2 k}, \hat{\varphi}_{2 k+1}\right) \leq d_{\omega}\left(L_{\theta^{-k} \omega}^{k} 1, L_{\theta^{-k} \omega}^{k} \varphi_{\theta^{-k} \omega}\right) \stackrel{(4.74)}{\leq} \Lambda^{k} D_{4}
$$

and by (4.85),

\int_{M}\left(L_{\theta^{-k} \omega}^{k} \varphi_{\theta^{-k} \omega}\right)(x) d m(x)=\int_{M} \varphi_{\theta^{-k} \omega}(x)\left(U_{\omega}^{k} \mathbf{1}\right)(x) d m(x)=\int_{M} \varphi_{\theta^{-k} \omega}(x) d m(x)=1
$$

So $\left\{\hat{\varphi}_{n}\right\}_{n \in \mathbb{N}} \subset C_{\omega}(b, c, \nu)$ satisfying the condition of Lemma 4.8. Thus, the sequence $\left\{\int_{M} \hat{\varphi}_{n}(x) g(x) d m(x)\right\}$ is a Cauchy sequence for all $g \in C^{0}(M)$. As a consequence, we have

$$

4.4. Proof of the exponential decay of the (quenched) past random correlations. In this subsection, we prove the exponential decay of the past random correlations.
Lemma 4.9. Let $\psi: M \rightarrow \mathbb{R}^{+}$be a positive function such that $\log \psi$ is $\left(\frac{a}{4}, \kappa\right)$-Hölder continuous. Then there exists a constant $K\left(D_{4}\right)>0$ depending on $D_{4}$ such that for any $\omega \in \Omega$, positive function $\varphi_{\theta^{-k} \omega} \in C_{\theta^{-k} \omega}(b, c, \nu)$ for $k \in \mathbb{N}$, and $n \geq N$, the following holds:

\end{align*}

Recall that $D_{4}$ comes from Lemma 4.7, and $N$ is constructed satisfying (4.54) and (4.55).
Proof. First, we consider that positive function $\varphi_{\theta^{-k} \omega} \in C_{\theta^{-k} \omega}(b, c, \nu)$ satisfying $\int_{M} \varphi_{\theta^{-k} \omega}(x) d m(x)=$ 1 for all $k \in \mathbb{N}$. So

& =\|\psi\|_{C^{0}(M)}\left(e^{d_{+, \omega}\left(L_{\theta-n_{\omega}}^{n} \varphi_{\theta-n_{\omega}}, L_{\theta-n_{\omega}}^{n} L_{\theta-(n+k)_{\omega}}^{k} \varphi_{\theta^{-(n+k)}}\right)}-1\right) \\
& \leq\|\psi\|_{C^{0}(M)}\left(e^{d_{\omega}\left(L_{\theta-n}^{n} \varphi_{\omega} \varphi_{\theta}-n_{\omega}, L_{\theta^{-n}}^{n} L_{\theta^{-(n+k)}}^{k} \varphi_{\theta^{-(n+k)}}\right)}-1\right) \\
& \stackrel{(4.74)}{\leq} \\
& \stackrel{\leq}{\leq}\|\psi\|_{C^{0}(M)}\left(e^{D_{4} \Lambda^{n}}-1\right) \\
& \leq K\left(D_{4}\right)\|\psi\|_{C^{0}(M)} \Lambda^{n}
\end{aligned}
$$

for some constant $K\left(D_{4}\right)$. Letting $k \rightarrow \infty$ in the above, by Remark 4.4, we have

\left|\int_{M} \psi(x)\left(L_{\theta^{-n} \omega}^{n} \varphi_{\theta^{-n} \omega}\right)(x) d m(x)-\int_{M} \psi(x) d \mu_{\omega}(x)\right| \leq K\left(D_{4}\right) \cdot\|\psi\|_{C^{0}(M)} \Lambda^{n} . \tag{4.91}

Now for any positive function $\varphi_{\theta^{-n} \omega} \in C_{\theta^{-n} \omega}(b, c, \nu)$, let $\tilde{\varphi}_{\theta^{-n} \omega}(x):=\varphi_{\theta^{-n} \omega}(x) / \int_{M} \varphi_{\theta^{-n} \omega}(x) d m(x)$. We replace $\varphi_{\theta^{-n} \omega}$ by $\tilde{\varphi}_{\theta^{-n} \omega}$ in (4.92). Then (4.90) is proved.

We still need the following lemma. Recall the constant $K_{2}$ in (4.3), and $C_{2}+C_{2} C_{1}$ in (4.40).
Lemma 4.10. Pick the number $c$ in the definition of $C_{\omega}(b, c, \nu)$ sufficiently large satisfying not only $c>c_{0}(b, \nu)$ in Lemma 4.5, but also

then $\varphi \cdot\left(L_{\theta^{-l} \omega}^{l} \mathbf{1}\right) \in C_{\omega}(b, c, \nu)$ for every $l \geq 1$ and all $\omega \in \Omega$.
Proof. We prove this lemma for each fixed $\omega \in \Omega$ and $l \geq 1$. First, $\varphi \cdot\left(L_{\theta^{-l} \omega}^{l} \mathbf{1}\right)$ is obviously bounded and measurable function.

Let us verify (C1). For every local stable manifold $\gamma(\omega)$ having size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$, and any $\rho(\omega) \in D(a / 2, \kappa, \gamma(\omega))$ with $\int_{\gamma(\omega)} \rho(x, \omega) d m_{\gamma(\omega)}(x)=1$, we have

By Remark 4.3, $\varphi \cdot L_{\theta^{-l} \omega}^{l} \mathbf{1}$ fulfills (C2) since $\varphi \cdot L_{\theta^{-l} \omega}^{l} \mathbf{1}$ is nonnegative. So it is left to verify (C3).
Let $\gamma(\omega), \tilde{\gamma}(\omega)$ be any pair of local stable manifolds. Pick any $\rho(\omega) \in D\left(a_{1}, \kappa_{1}, \gamma(\omega)\right)$, and let $\tilde{\rho}(\omega) \in$ $D(a / 2, \kappa, \tilde{\gamma}(\omega))$ be defined as (4.17) corresponding to $\rho(\omega)$. We divide $f_{\omega}^{-l} \gamma(\omega)$ into connected local stable manifolds of size between $\frac{A(\epsilon)}{4 J}$ and $\frac{A(\epsilon)}{2 J}$, named $\gamma_{i}\left(\theta^{-l} \omega\right)$, such that $\gamma(\omega)=\cup f_{\theta^{-l} \omega}^{l} \gamma_{i}\left(\theta^{-l} \omega\right)$. Let $\tilde{\gamma}_{i}\left(\theta^{-l} \omega\right)$ be the holonomy image of $\gamma_{i}\left(\theta^{-l} \omega\right)$ inside of $f_{\omega}^{-l} \tilde{\gamma}(\omega)$. Naturally, we have $\tilde{\gamma}(\omega)=$ $\cup f_{\theta^{-1} \omega} \tilde{\gamma}_{i}\left(\theta^{-1} \omega\right)$. Note that the Jacobian of holonomy map between local stable manifolds is bounded above by $J$ and bounded below by $J^{-1}$. Therefore, $\tilde{\gamma}_{i}\left(\theta^{-l} \omega\right)$ have size between $\frac{A(\epsilon)}{4 J^{2}}$ and $A(\epsilon)$. Denote
$\psi_{\omega}: \tilde{\gamma}(\omega) \rightarrow \gamma(\omega)$ to be the holonomy map between $\tilde{\gamma}(\omega)$ and $\gamma(\omega)$, and $\psi_{\theta^{-l} \omega}^{i}: \tilde{\gamma}_{i}\left(\theta^{-l} \omega\right) \rightarrow \gamma_{i}\left(\theta^{-l} \omega\right)$ the holonomy map induced by the local unstable manifolds. By using the definition of $L_{\omega}$ and changing of variables, we have

= & \sum_{i} \int_{\tilde{\gamma}_{i}\left(\theta^{-l} \omega\right)} \frac{\left|\operatorname{det} D_{\psi_{\theta^{-l}}^{i}(x)} f_{\theta^{-l} \omega}^{l}\right|_{E^{s}}\left(\psi_{\theta^{l}-l_{\omega}}^{i}(x), \theta^{-l} \omega\right) \mid}{\left|\operatorname{det} D_{\psi_{\theta^{-l}}^{i}(x)} f_{\theta^{-l} \omega}^{l}\right|} \cdot \rho\left(f_{\theta^{-l} \omega}^{l} \psi_{\theta^{-l} \omega}^{i}(x), \omega\right) \cdot \varphi\left(f_{\theta^{-l} \omega}^{l} \psi_{\theta^{-l} \omega}^{i}(x)\right) \\
& \quad \cdot \operatorname{Jac}\left(\psi_{\theta^{-l} \omega}^{i}\right)(x) d m_{\tilde{\gamma}_{i}\left(\theta^{-l} \omega\right)}(x) .
\end{aligned}
$$

On the other hand, we have

& \int_{\tilde{\gamma}(\omega)}\left(L_{\theta^{-l} \omega}^{l} \mathbf{1}\right)(x) \varphi(x) \tilde{\rho}(x, \omega) d m_{\tilde{\gamma}(\omega)}(x) \\
= & \sum_{i} \int_{\tilde{\gamma}_{i}\left(\theta^{-l} \omega\right)} \frac{\left|\operatorname{det} D_{x} f_{\theta^{-l} \omega}^{l}\right| E^{s}\left(x, \theta^{-l} \omega\right) \mid}{\left|\operatorname{det} D_{x} f_{\theta^{-l} \omega}^{l}\right|} \tilde{\rho}\left(f_{\theta^{-l} \omega^{l}}^{l} x, \omega\right) \varphi\left(f_{\theta^{-l} \omega}^{l} x\right) d m_{\tilde{\gamma}_{i}\left(\theta^{-l} \omega\right)}(x) \\
= & \sum_{i} \int_{\tilde{\gamma}_{i}\left(\theta^{-l} \omega\right)} \frac{\left|\operatorname{det} D_{x} f_{\theta^{-l} \omega}^{l}\right|_{E^{s}\left(x, \theta^{-l} \omega\right)}}{\left|\operatorname{det} D_{x} f_{\theta^{-l} \omega}^{l}\right|} \rho\left(\psi_{\omega}\left(f_{\theta^{-l} \omega}^{l} x\right), \omega\right) \cdot \operatorname{Jac}\left(\psi_{\omega}\right)\left(f_{\theta^{-l} \omega}^{l} x\right) \cdot \varphi\left(f_{\theta^{-l} \omega}^{l} x\right) d m_{\tilde{\gamma}_{i}\left(\theta^{-l} \omega\right)}(x) .

& \leq a_{0} d_{u}(\gamma(\omega), \tilde{\gamma}(\omega))^{\nu_{0}}+a_{0} d_{u}\left(\gamma_{i}\left(\theta^{-l} \omega\right), \tilde{\gamma}_{i}\left(\theta^{-l} \omega\right)\right)^{\nu_{0}} \\
& \leq a_{0} d_{u}(\gamma(\omega), \tilde{\gamma}(\omega))^{\nu_{0}}+a_{0} e^{-\lambda l \nu_{0}} d_{u}(\gamma(\omega), \tilde{\gamma}(\omega))^{\nu_{0}} \\
& <2 a_{0} d_{u}(\gamma(\omega), \tilde{\gamma}(\omega))^{\nu_{0}} . \tag{4.97}

& \leq K_{2} e^{-l \lambda} d_{u}(\gamma(\omega), \tilde{\gamma}(\omega))+K_{2} e^{-(l-1) \lambda} d_{u}(\gamma(\omega), \tilde{\gamma}(\omega))+\cdots+K_{2} e^{-\lambda} d_{u}(\gamma(\omega), \tilde{\gamma}(\omega))
\end{aligned}
$$

$$
\begin{equation*}
\leq \frac{K_{2}}{1-e^{-\lambda}} \cdot d_{u}(\gamma(\omega), \tilde{\gamma}(\omega)) . \tag{4.98}
\end{equation*}
$$

By applying (4.40), for $x \in \tilde{\gamma}_{i}\left(\theta^{-l} \omega\right)$,

& \left.|\log | \operatorname{det} D_{\psi_{\theta}^{i} l_{\omega}(x)} f_{\theta^{-l} \omega}^{l}\right|_{E^{s}\left(\psi_{\theta-l_{\omega}}^{i}(x), \theta^{-l} \omega\right)}|-\log | \operatorname{det} D_{x} f_{\theta^{-l} \omega}^{l}\left|E^{s}\left(x, \theta^{-l} \omega\right)\right| \\
\leq & \left(C_{2}+C_{2} C_{1}\right)\left[d\left(\psi_{\theta^{-l} \omega}^{i}(x), x\right)^{\nu_{0}}+\cdots+d\left(f_{\theta^{-l} \omega}^{l-1} \psi_{\theta^{-l} \omega}^{i}(x), f_{\theta^{-l} \omega}^{l-1} x\right)^{\nu_{0}}\right] \\
\leq & \frac{C_{2}+C_{2} C_{1}}{1-e^{-\lambda \nu_{0}}} d_{u}(\gamma(\omega), \tilde{\gamma}(\omega))^{\nu_{0}} . \tag{4.99}
\end{align*}
$$

Combining (4.95), (4.96), (4.97), (4.98) and (4.99), we conclude

& \leq \max \left\{c_{1}, 2 a_{0}, \frac{K_{2}}{1-e^{-\lambda}}, \frac{C_{2}+C_{2} C_{1}}{1-e^{-\lambda \nu_{0}}}\right\} d_{u}(\gamma(\omega), \tilde{\gamma}(\omega))^{\nu} \\
& \stackrel{(4.93)(4.94)}{\leq} c d_{u}(\gamma(\omega), \tilde{\gamma}(\omega))^{\nu} .
\end{aligned}

& \left|\int_{M} \psi\left(f_{\theta^{-n} \omega}^{n} x\right) \varphi(x) d \mu_{\theta^{-n} \omega}(x)-\int_{M} \psi(x) d \mu_{\omega}(x) \int_{M} \varphi(x) d \mu_{\theta^{-n} \omega}(x)\right| \\
\leq & K\left(D_{4}\right)\|\psi\|_{C^{0}(M)} \int_{M} \varphi d \mu_{\theta^{-n} \omega} \cdot \Lambda^{n} \\
\leq & K\left(D_{4}\right)\|\psi\|_{C^{0}(M)} \cdot\|\varphi\|_{C^{0}(M)} \cdot \Lambda^{n} . \tag{4.101}
\end{align*}
$$

Finally, given any $\psi \in C^{0, \kappa}(M)$ and $\varphi \in C^{0, \nu}(M)$. If $\psi$ or $\varphi$ is a constant function, then by (4.88),

$$
\left|\int_{M} \psi\left(f_{\theta^{-n} \omega}^{n} x\right) \varphi(x) d \mu_{\theta^{-n} \omega}(x)-\int_{M} \psi(x) d \mu_{\omega}(x) \int_{M} \varphi(x) d \mu_{\theta^{-n} \omega}(x)\right|=0 .
$$

Therefore, to prove the exponential decay of past random correlations, it is sufficient to consider the case that both $\psi \in C^{0, \kappa}(M)$ and $\varphi \in C^{0, \nu}(M)$ are nonconstant functions. Let

B_{\psi}=\frac{5|\psi|_{\kappa}}{a}>0, B_{\varphi}=\frac{2|\varphi|_{\nu}}{c_{1}}>0
$$

and define

$$
\begin{aligned}
\psi_{B_{\psi}}^{+} & =\frac{1}{2}(|\psi|+\psi)+B_{\psi}, \psi_{B_{\psi}}^{-}=\frac{1}{2}(|\psi|-\psi)+B_{\psi} \\
\varphi_{B_{\varphi}}^{+} & =\frac{1}{2}(|\varphi|+\varphi)+B_{\varphi}, \varphi_{B_{\varphi}}^{-}=\frac{1}{2}(|\varphi|-\varphi)+B_{\varphi}
\end{aligned}
$$

Similar as (4.83), we can show that $\log \psi_{B_{\psi}}^{ \pm}$are $(a / 4, \kappa)-$ Hölder continuous, and $\log \varphi_{B_{\varphi}}^{ \pm}$are $\left(c_{1}, \nu\right)$ Hölder continuous. By (4.101) and the linearity of integration, we conclude for all $\omega \in \Omega$ and $n \geq N$,

$$
\begin{aligned}
& \left|\int_{M} \psi\left(f_{\theta^{-n} \omega}^{n} x\right) \varphi(x) d \mu_{\theta^{-n} \omega}(x)-\int_{M} \psi(x) d \mu_{\omega}(x) \int_{M} \varphi(x) d \mu_{\theta^{-n} \omega}(x)\right| \\
= & \mid \int_{M}\left(\psi_{B_{\psi}}^{+}-\psi_{B_{\psi}}^{-}\right)\left(f_{\theta^{-n} \omega}^{n} x\right)\left(\varphi_{B_{\varphi}}^{+}-\varphi_{B_{\varphi}}^{-}\right)(x) d \mu_{\theta^{-n} \omega}(x) \\
& \quad-\int_{M}\left(\psi_{B_{\psi}}^{+}-\psi_{B_{\psi}}^{-}\right)(x) d \mu_{\omega}(x) \int_{M}\left(\varphi_{B_{\varphi}}^{+}-\varphi_{B_{\varphi}}^{-}\right)(x) d \mu_{\theta^{-n} \omega}(x) \mid \\
\leq & 4 K\left(D_{4}\right) \cdot \max \left\{1, \frac{5}{a}\right\} \cdot \max \left\{1, \frac{2}{c_{1}}\right\} \cdot\|\psi\|_{C^{0, \kappa}(M)} \cdot\|\varphi\|_{C^{0, \nu}(M)} \cdot \Lambda^{n} .
\end{aligned}
$$

Note that the above is true for all $n \geq N$. Next, for $n \in\{0, \ldots, N-1\}$, we have

$$
\begin{aligned}
& \left|\int_{M} \psi\left(f_{\theta^{-n} \omega}^{n} x\right) \varphi(x) d \mu_{\theta^{-n} \omega}(x)-\int_{M} \psi(x) d \mu_{\omega}(x) \int_{M} \varphi(x) d \mu_{\theta^{-n} \omega}(x)\right| \\
\leq & 2\|\psi\|_{C^{0}(M)}\|\varphi\|_{C^{0}} \leq \frac{2}{\Lambda^{N}}\|\psi\|_{C^{0}(M)}\|\varphi\|_{C^{0}(M)} \Lambda^{n} .
\end{aligned}
$$

Therefore, we let

$$
\begin{equation*}
K:=\max \left\{4 K\left(D_{4}\right) \cdot \max \left\{1, \frac{5}{a}\right\} \cdot \max \left\{1, \frac{2}{c_{1}}\right\}, 2 \Lambda^{-N}\right\} \tag{4.102}
\end{equation*}
$$

then
$\left|\int_{M} \psi\left(f_{\theta^{-n} \omega}^{n} x\right) \varphi(x) d \mu_{\theta^{-n} \omega}(x)-\int_{M} \psi(x) d \mu_{\omega}(x) \int_{M} \varphi(x) d \mu_{\theta^{-n} \omega}(x)\right| \leq K\|\psi\|_{C^{0, \kappa}(M)} \cdot\|\varphi\|_{C^{0, \nu}(M)} \cdot \Lambda^{n}$.
for all $n \geq 0$. This finishes the proof for the past random correlations.
4.5. Proof of the exponential decay of the (quenched) future random correlation. In this subsection, we prove the exponential decay of the future random correlations.

Lemma 4.11. Let $\psi: M \rightarrow \mathbb{R}^{+}$be any positive continuous function satisfying that $\log \psi$ is $\left(\frac{a}{4}, \kappa\right)-$ Hölder continuous. Then for each $\omega \in \Omega$, positive function $\varphi_{\omega} \in C_{\omega}(b, c, \nu)$, for any $n \geq N$, the following holds:

\left|\int_{M} \psi\left(f_{\omega}^{n} x\right) \varphi_{\omega}(x) d m-\int_{M} \psi(x) d \mu_{\theta^{n} \omega} \int_{M} \varphi_{\omega}(x) d m\right| \leq K\left(D_{4}\right) \cdot\|\psi\|_{C^{0}(M)} \int_{M} \varphi_{\omega}(x) d m \cdot \Lambda^{n} \tag{4.103}
\end{equation*}
$$

Recall that $K\left(D_{4}\right)$ is defined in Lemma 4.9.
Proof. We first prove the case that positive function $\varphi_{\omega} \in C_{\omega}(b, c, \nu)$ satisfies $\int_{M} \varphi_{\omega}(x) d m(x)=1$. Note that by Lemma 4.5, for any $n \geq N, k \geq 0, L_{\omega}^{n} \varphi_{\omega}, L_{\theta^{-k} \omega}^{n+k} 1 \in C_{\theta^{n} \omega}(b, c, \nu)$ are positive functions. Similar proof as (4.82) can be applied on the fiber $\left\{\theta^{n} \omega\right\}$ to show that for $n \geq N$,

\left|\int_{M} \psi(x)\left(L_{\omega}^{n} \varphi_{\omega}\right)(x) d m(x)-\int_{M} \psi(x)\left(L_{\theta^{-k} \omega}^{n+k} \mathbf{1}\right)(x) d m(x)\right|
$$

$$
\begin{aligned}
& \leq\|\psi\|_{C^{0}(M)}\left(e^{d_{+, \theta n}\left(L_{\omega}^{n} \varphi_{\omega}, L_{\theta}^{n-k_{\omega}}\right.} \mathbf{n}-1\right) \\
& \leq\|\psi\|_{C^{0}(M)}\left(e^{d_{+, \theta^{n} \omega}\left(L_{\omega}^{n} \varphi_{\omega}, L_{\omega}^{n} L_{\theta-k_{\omega}}^{k} 1\right)}-1\right) \\
& { }^{(4.75)}\|\psi\|_{C^{0}(M)}\left(e^{D_{4} \Lambda^{n}}-1\right) \\
& \leq K\left(D_{4}\right) \cdot\|\psi\|_{C^{0}(M)} \Lambda^{n} .
\end{aligned}
$$

Notice that $L_{\theta^{-k} \omega}^{n+k} \mathbf{1}=L_{\theta^{-k} \theta^{n} \omega}^{k} L_{\theta^{-k} \omega}^{n} \mathbf{1}$, and $L_{\theta^{-k} \omega}^{n} \mathbf{1} \in C_{\theta^{n-k} \omega}(b, c, \nu)=C_{\theta^{-k} \theta^{n} \omega}(b, c, \nu)$. Moreover, $\int_{M} L_{\theta^{-k} \omega}^{n} \mathbf{1} d m=1$ for all $k \in \mathbb{N}$. By Remark 4.4, we have

$$
\lim _{k \rightarrow \infty} \int_{M} \psi(x)\left(L_{\theta^{-k} \omega}^{n+k} \mathbf{1}\right)(x) d m(x)=\lim _{k \rightarrow \infty} \int_{M} \psi \cdot L_{\theta^{-k} \theta^{n} \omega}^{k}\left(L_{\theta^{-k} \omega}^{n} \mathbf{1}\right) d m=\int_{M} \psi(x) d \mu_{\theta^{n} \omega}(x) .
$$

Therefore, let $k \rightarrow \infty$ in (4.104), then for $n \geq N$,

$$
\begin{equation*}
\left|\int_{M} \psi(x)\left(L_{\omega}^{n} \varphi_{\omega}\right)(x) d m(x)-\int_{M} \psi(x) d \mu_{\theta^{n} \omega}(x)\right| \leq K\left(D_{4}\right) \cdot\|\psi\|_{C^{0}(M)} \Lambda^{n} . \tag{4.105}
\end{equation*}
$$

Note that by (4.85), we have

$$
\int_{M} \psi(x)\left(L_{\omega}^{n} \varphi_{\omega}\right)(x) d m(x)=\int_{M} \psi\left(f_{\omega}^{n} x\right) \varphi_{\omega}(x) d m(x) .
$$

Hence (4.105) becomes that for any $n \geq N$,

\begin{equation*}
\left|\int_{M} \psi\left(f_{\omega}^{n} x\right) \varphi_{\omega}(x) d m(x)-\int_{M} \psi(x) d \mu_{\theta^{n} \omega}(x)\right| \leq K\left(D_{4}\right) \cdot\|\psi\|_{C^{0}(M)} \Lambda^{n} . \tag{4.106}
\end{equation*}
$$

Now for any positive function $\varphi_{\omega} \in C_{\omega}(b, c, \nu)$, let $\tilde{\varphi}_{\omega}(x):=\varphi_{\omega}(x) / \int_{M} \varphi_{\omega} d m$. Then (4.103) can be proved by replacing $\varphi_{\omega}$ by $\tilde{\varphi}_{\omega}$ in (4.106).

Now assume the function $\psi: M \rightarrow \mathbb{R}$ such that $\psi>0$, and $\log \psi$ is $(a / 4, \kappa)$-Hölder continuous. Let $\varphi: M \rightarrow \mathbb{R}^{+}$with $\log \varphi$ is $\left(c_{1}, \nu\right)$-Hölder continuous. Then by the Lemma 4.10, we have

\varphi \cdot L_{\theta^{-l} \omega}^{l} \mathbf{1} \in C_{\omega}(b, c, \nu) \text { for all } l \in \mathbb{N} \text { all } \omega \in \Omega .
$$

Now, we apply Lemma 4.11 to obtain that for all $\omega \in \Omega, n \geq N$,

\begin{aligned}
& \left|\int_{M} \psi\left(f_{\omega}^{n} x\right)\left(\varphi \cdot L_{\theta^{-l} \omega}^{l} \mathbf{1}\right)(x) d m(x)-\int_{M} \psi(x) d \mu_{\theta^{n} \omega}(x) \int_{M}\left(\varphi \cdot L_{\theta^{-l} \omega}^{l} \mathbf{1}\right)(x) d m(x)\right| \\
\leq & K\left(D_{4}\right)\|\psi\|_{C^{0}(M)} \int_{M} \varphi \cdot\left(L_{\theta^{-l} \omega}^{l} \mathbf{1}\right) d m \cdot \Lambda^{n}, \text { for all } l \in \mathbb{N} .
\end{aligned}
$$

Let $l \rightarrow \infty$, by (4.87), for all $\omega \in \Omega, n \geq N$,

$$
\begin{align*}
& \left|\int_{M} \psi\left(f_{\omega}^{n} x\right) \varphi(x) d \mu_{\omega}(x)-\int_{M} \psi(x) d \mu_{\theta^{n} \omega}(x) \int_{M} \varphi(x) d \mu_{\omega}(x)\right|  \tag{4.107}\\
\leq & K\left(D_{4}\right)\|\psi\|_{C^{0}(M)} \int_{M} \varphi d \mu_{\omega} \cdot \Lambda^{n} \leq K\left(D_{4}\right)\|\psi\|_{C^{0}(M)} \cdot\|\varphi\|_{C^{0}(M)} \cdot \Lambda^{n} .
\end{align*}
$$

Finally, given $\psi \in C^{0, \kappa}(M)$ and $\varphi \in C^{0, \nu}(M)$. If $\psi$ or $\varphi$ is a constant function, then by (4.88),

$$
\left|\int_{M} \psi\left(f_{\omega}^{n} x\right) \varphi(x) d \mu_{\omega}(x)-\int_{M} \psi(x) d \mu_{\theta^{n} \omega}(x) \int_{M} \varphi(x) d \mu_{\omega}(x)\right|=0 .
$$

Therefore, to prove the exponential decay of past random correlations, it is sufficient to consider the case that both $\psi \in C^{0, \kappa}(M)$ and $\varphi \in C^{0, \nu}(M)$ are nonconstant functions. let

$$
B_{\psi}=\frac{5|\psi|_{\kappa}}{a}>0, B_{\varphi}=\frac{2|\varphi|_{\nu}}{c_{1}}>0
$$

and define

$$
\begin{aligned}
\psi_{B_{\psi}}^{+} & =\frac{1}{2}(|\psi|+\psi)+B_{\psi}, \psi_{B_{\psi}}^{-}=\frac{1}{2}(|\psi|-\psi)+B_{\psi}, \\
\varphi_{B_{\varphi}}^{+} & =\frac{1}{2}(|\varphi|+\varphi)+B_{\varphi}, \varphi_{B_{\varphi}}^{-}=\frac{1}{2}(|\varphi|-\varphi)+B_{\varphi} .
\end{aligned}
$$

As before, $\log \psi_{B_{\psi}}^{ \pm}$are $(a / 4, \kappa)$-Hölder continuous, and $\log \varphi_{B_{\varphi}}^{ \pm}$are $\left(c_{1}, \nu\right)$ Hölder continuous. By (4.107) and the linearity of integration, we conclude for $n \geq N$,

$$
\begin{aligned}
& \left|\int_{M} \psi\left(f_{\omega}^{n} x\right) \varphi(x) d \mu_{\omega}(x)-\int_{M} \psi(x) d \mu_{\theta^{n} \omega}(x) \int_{M} \varphi(x) d \mu_{\omega}(x)\right| \\
\leq & 4 K\left(D_{4}\right) \cdot \max \left\{1, \frac{5}{a}\right\} \cdot \max \left\{1, \frac{2}{c_{1}}\right\} \cdot\|\psi\|_{C^{0, \kappa}(M)} \cdot\|\varphi\|_{C^{0, \nu}(M)} \cdot \Lambda^{n} .
\end{aligned}
$$

Recall that $K$ is defined in (4.102), then we arrive

$$
\left|\int_{M} \psi\left(f_{\omega}^{n} x\right) \varphi(x) d \mu_{\omega}(x)-\int_{M} \psi(x) d \mu_{\theta^{n} \omega}(x) \int_{M} \varphi(x) d \mu_{\omega}(x)\right| \leq K \cdot\|\psi\|_{C^{0, \kappa}(M)} \cdot\|\varphi\|_{C^{0, \nu}(M)} \cdot \Lambda^{n},
$$

for all $n \geq 0$. This finishes the proof for the future random correlations.

## Appendix A.

A.1. Examples of Anosov and mixing on Fibers System. Theorem 8.1 in [22] showed that the random dynamical systems satisfying the following conditions are topological mixing on fibers:
(A1) $(\Omega, \theta)$ is a minimal irrational rotation on the compact torus;
(A2) $\phi$ is Anosov on fibers;
(A3) $\phi$ is topological transitive on $M \times \Omega$.
Remark A.1. This class of systems can't be topological mixing. In fact, it is well-known that a factor of a topological mixing system is also topological mixing. Notice that the irrational rotation is not topological mixing, hence $\phi$ can't be topological mixing.

A typical example satisfying (A1)-(A3) is given by following. Fiber Anosov maps on 2-d tori: Let $\theta$ be a homeomorphism on a compact metric space $\Omega$ and let $A=\left(\begin{array}{ll}2 & 1 \\ 1 & 1\end{array}\right)$. Define $\phi: \mathbb{T}^{2} \times \Omega \rightarrow \mathbb{T}^{2} \times \Omega$ by

$$
\phi\left(\binom{x}{y}, \omega\right)=\left(A\binom{x}{y}+h(\omega), \theta \omega\right)=\left(\left(\begin{array}{ll}
2 & 1 \\
1 & 1
\end{array}\right)\binom{x}{y}+\binom{h_{1}(\omega)}{h_{2}(\omega)}, \theta \omega\right)
$$

where $h$ is a continuous map from $\Omega$ to $\mathbb{T}^{2}$.
Theorem 8.2 in [22] showed that the systems satisfying the following conditions are also mixing on fibers:
(B1) $(\Omega, \theta)$ is a homeomorphism on a compact metric space;
(B2) $\phi$ is Anosov on fibers;
(B3) There exists an $f_{\omega}$-invariant Borel probability measure $\nu$ with full support (i.e. $\operatorname{supp} \nu=M$ ).
A typical example satisfying (B1)-(B3) is given by following. Random composition of $2 \times 2$ areapreserving positive matrices: let

$$
\left\{B_{i}=\left(\begin{array}{ll}
a_{i} & b_{i} \\
c_{i} & d_{i}
\end{array}\right)\right\}_{1 \leq i \leq p}
$$

be $2 \times 2$ matrices with $a_{i}, b_{i}, c_{i}, d_{i} \in \mathbb{Z}^{+}$, and $\left|a_{i} d_{i}-c_{i} b_{i}\right|=1$ for any $i \in\{1, \ldots, p\}$. Let $\Omega=\mathcal{S}_{p}:=$ $\{1, \ldots, p\}^{\mathbb{Z}}$ with the left shift operator $\theta$ be the symbolic dynamical system with $p$ symbols. For any $\omega=\left(\ldots, \omega_{-1}, \omega_{0}, \omega_{1}, \ldots\right) \in \Omega$, we define $g(\omega)=B_{\omega_{0}}$. Then the skew product $\tilde{\phi}: \Omega \times \mathbb{T}^{2} \rightarrow \Omega \times \mathbb{T}^{2}$ defined by

$$
\tilde{\phi}(x, \omega)=(g(\omega) x, \theta \omega)
$$

is an Anosov on fibers system with continuous co-invariant splitting $\mathbb{R}^{2}=E_{\omega}^{u} \oplus E_{\omega}^{s}$ for $\omega \in \mathcal{S}_{p}$, on which

$$
\begin{aligned}
& \left\|D g_{\omega} v\right\| \geq \kappa\|v\| \text { for } v \in E_{\omega}^{u} ; \\
& \left\|D g_{\omega} \eta\right\| \leq \kappa^{-1}\|\eta\| \text { for } \eta \in E_{\omega}^{s}
\end{aligned}
$$

for $\kappa:=\min _{1 \leq i \leq p} \min \left\{\sqrt{a_{i}^{2}+c_{i}^{2}}, \sqrt{b_{i}^{2}+d_{i}^{2}}\right\} \geq \sqrt{2}$ by Proposition 8.2 in [22].
A.2. Random SRB measure for Anosov and Mixing on Fibers Systems. Let $F: \mathbb{Z} \times \Omega \times$ $M \rightarrow M$ be a continuous random dynamical system over an invertible ergodic metric dynamical systems $(\Omega, \mathcal{B}, P, \theta)$.

Definition A.1. A map $K: \Omega \rightarrow 2^{M}$ is called a closed random set if $K(\omega)$ is closed for any $\omega \in \Omega$; and $\omega \mapsto d(x, K(\omega))$ is measurable for each fixed $x \in M . U: \Omega \rightarrow 2^{M}$ is called an open random set if $U^{c}$ is a random closed set.

Definition A.2. $F$ is called random topological transitive if for any given open random sets $U$ and $V$ with $U(\omega), V(\omega) \neq \emptyset$ for all $\omega \in \Omega$, there exists a random variable $n$ taking values in $\mathbb{Z}$ such that the intersection $F\left(n(\omega), \theta^{-n(\omega)}\right) U\left(\theta^{-n(\omega)} \omega\right) \cap V(\omega) \neq \emptyset \mathbb{P}$-a.s..

The following Lemma is the Lemma A. 1 in [22].
Lemma A.1. If $F$ is topological mixing on fibers, then $F$ is random topological transitive.

The following theorem is Theorem 4.3 in [20], which is the main result of the SRB measure for random hyperbolic systems.

Theorem 2. Let $F$ be a $C^{1+\alpha}$ RDS with a random topological transitive hyperbolic attractor $\Lambda \subset$ $M \times \Omega$. Then there exists a unique $F$-invariant measure (SRB-measure) $\nu$ supported by $\Lambda$ and characterized by each of the following:
(i) $h_{\nu}(F)=\int \sum \lambda_{i}^{+} d \nu$, where $\lambda_{i}$ are the Lyapunov exponents corresponding to $\nu$;
(ii) $\mathbb{P}$-a.s. the conditional measure of $\nu_{\omega}$ on the unstable manifolds are absolutely continuous with respect to the Riemannian volume on these submanifolds;
(iii) $h_{\nu}(F)+\int f d \nu=\sup \left\{h_{\mu}(F)+\int f d \mu: F-\right.$ invariant $\left.\mu\right\}$ and the later is the topological pressure $\pi_{F}(f)$ of $f$ which satisfies $\pi_{F}(f)=0$;
(iv) $\nu=\psi \tilde{\mu}$, where $\psi$ is the conjugation between $F$ on $\Lambda$ and two-sided shift $\sigma$ on $\Sigma_{A}$, and $\tilde{\mu}$ is the equilibrium state for the $\sigma$ and function $f \circ \psi$. The measure $\tilde{\mu}$ can be obtained as a natural extension of the probability measure $\mu$ which is invariant with respect to the one-sided shift on $\Sigma_{A}^{+}$and such that $L_{\eta}^{*} \mu_{\theta \omega}=\mu_{\omega} \mathbb{P}$-a.s. where $\eta-f \circ \psi=h-h \circ(\theta \times \sigma)$ for some random Hölder continuous function $h$;
(v) $\nu$ can be obtained as a weak* limit $\nu_{\omega}=\lim _{n \rightarrow} F\left(n, \theta^{-n} \omega\right) m_{\theta^{-n} \omega} \mathbb{P}$-a.s. for any measure $m_{\omega}$ absolutely continuous with respect to the Riemannian volume such that suppm${ }_{\omega} \subset U(\omega)$.
A.3. Anosov on Fibers System and Partially Hyperbolic systems. In this section, we show that Anosov on fibers system contains a class of partially hyperbolic systems.
Definition A.3. $(M, f)$ is called partially hyperbolic in the narrow sense if the tangent bundle admits a splitting into three continuous vector subbundles $T_{x} M=E^{1}(x) \oplus E^{2}(x) \oplus E^{3}(x)$ which satisfy
(1) dominated splitting, i.e., $D_{x} f\left(E^{i}(x)\right)=E^{i}(f(x))$ for $i=1,2,3$, and there exists a constant $c>0$ and $\lambda \in(0,1)$ such that $\left\|\left.D f^{n}\right|_{E^{i}(x)}\right\| \leq c \lambda^{n}\left\|\left.D f^{n}\right|_{E^{i+1}(x)}\right\|$ for $i=1,2$,
(2) $E^{1}(x)$ is uniformly contracted and $E^{3}(x)$ is uniformly expanded under the action of $D_{x} f$.

We denote the dominated splitting by $T_{x} M=E^{1}(x) \oplus_{<} E^{2}(x) \oplus_{<} E^{3}(x)$.
Let $\Omega$ be a compact smooth manifold, and let $\theta: \Omega \rightarrow \Omega$ be a diffeomorphism. Denote $f(x, \omega):=$ $f_{\omega}(x)$ and $\phi^{-1}(x, \omega)=\left(f_{\omega}^{-1}(x), \theta^{-1} \omega\right)$.
Proposition A.1. Assume
(a) $\phi: M \times \Omega \rightarrow M \times \Omega$ is Anosov on fibers,
(b) $f(x, \omega)$ and $f_{\omega}^{-1}(x)$ are $C^{1}$ in $\omega$,
(c) The diffeomorphism $\theta$ satisfying:

$$
\begin{aligned}
\sup _{(x, \omega) \in M \times \Omega}\left\|\left.D_{x} f_{\omega}\right|_{E^{s}(x, \omega)}\right\|< & \inf _{\omega \in \Omega}\left\|D_{\omega} \theta^{-1}\right\|^{-1}:=m_{1} \\
& \leq \sup _{\omega \in \Omega}\left\|D_{\omega} \theta\right\|:=m_{2}<\inf _{(x, \omega) \in M \times \Omega}\left\|\left.D_{x}\left(f_{\theta^{-1} \omega}\right)^{-1}\right|_{E^{u}(x, \omega)}\right\|^{-1}
\end{aligned}
$$

Then $\phi$ is partially hyperbolic in the narrow sense.

Proof. We first show the existence of a dominated splitting. Note that $T_{(x, \omega)} M \times \Omega=T_{x} M \times T_{\omega} \Omega$ already has a splitting $E^{u}(x, \omega) \times\{0\} \oplus E^{s}(x, \omega) \times\{0\} \oplus\{0\} \times T_{\omega} \Omega$, but this splitting may not be invariant. For any $v \in T_{x} M \times T_{\omega} \Omega$, then $v=v_{1}+v_{2}+v_{3}$ according to the above splitting. Notice that $\left\|D \phi(x, \omega) v_{3}\right\|$ only depends on $\left\|D_{\omega} f(x, \omega)\right\|$ and $\left\|D_{\omega} \theta\right\|$. $\left\|D \phi^{-1}(x, \omega) v_{3}\right\|$ only depends on $\left\|D_{\omega}\left(f_{\theta^{-1} \omega}\right)^{-1}(x)\right\|$ and $\left\|D_{\omega} \theta^{-1}\right\|$, then by the compactness of $M$ and $\Omega$, there exists a number $K$ such that

$$
\left\|D \phi(x, \omega) v_{3}\right\| \leq K\left\|v_{3}\right\|,\left\|D \phi^{-1}(x, \omega) v_{3}\right\| \leq K\left\|v_{3}\right\|
$$

We let $P\left(E^{u}(x, \omega) \times\{0\}\right)$ denote the projection map from $T_{x} M \times T_{\omega} \Omega$ to $E^{u}(x, \omega) \times\{0\}$ with respect to the splitting $E^{u}(x, \omega) \times\{0\} \oplus E^{s}(x, \omega) \times\{0\} \oplus\{0\} \times T_{\omega} \Omega . P\left(E^{s}(x, \omega) \times\{0\}\right)$ and $P\left(\{0\} \times T_{\omega} \Omega\right)$ are similar notations. Since $E^{s}(x, \omega)$ and $E^{u}(x, \omega)$ are uniformly continuous on $x$ and $\omega$, there exists a number $\mathcal{P}>1$ such that

$$
\sup \left\{\left\|P\left(E^{s}(x, \omega) \times\{0\}\right)\right\|,\left\|P\left(E^{u}(x, \omega) \times\{0\}\right)\right\|:(x, \omega) \in M \times \Omega\right\}<\mathcal{P}
$$

Now consider the cone

$$
C(x, \omega):=\left\{v \in T_{x} M \times T_{\omega} \Omega \mid\left\|v_{2}\right\|+b\left\|v_{3}\right\| \leq\left\|v_{1}\right\|\right\}
$$

where $b$ is a number such that

$$
\begin{equation*}
b>\frac{2 \mathcal{P} K}{e^{\lambda_{0}}-m_{2}} . \tag{A.1}
\end{equation*}
$$

Denote

$$
c_{0}=\max \left\{\frac{2 \mathcal{P} K+b m_{2}}{e^{\lambda_{0}} b}, e^{-2 \lambda_{0}}\right\} \in(0,1) .
$$

For any $v \in C(x, \omega)$, we have

$$
\begin{aligned}
D \phi(x, \omega) v= & D \phi(x, \omega) v_{1}+D \phi(x, \omega) v_{2}+D \phi(x, \omega) v_{3} \\
= & D \phi(x, \omega) v_{1}+P\left(E^{u}(\phi(x, \omega)) \times\{0\}\right) D \phi(x, \omega) v_{3} \\
& \quad+D \phi(x, \omega) v_{2}+P\left(E^{s}(\phi(x, \omega)) \times\{0\}\right) D \phi(x, \omega) v_{3} \\
& \quad+P\left(\{0\} \times T_{\theta \omega} \Omega\right) D \phi(x, \omega) v_{3} \\
= & (D \phi(x, \omega) v)_{1}+(D \phi(x, \omega) v)_{2}+(D \phi(x, \omega) v)_{3} .
\end{aligned}
$$

Then

$$
\begin{aligned}
\left\|(D \phi(x, \omega) v)_{2}\right\|+b\left\|(D \phi(x, \omega) v)_{3}\right\| & \leq e^{-\lambda_{0}}\left\|v_{2}\right\|+\mathcal{P} K\left\|v_{3}\right\|+b \cdot m_{2}\left\|v_{3}\right\| \\
& =e^{-\lambda_{0}}\left\|v_{2}\right\|+\left(\mathcal{P} K+b m_{2}\right)\left\|v_{3}\right\| \\
& =e^{-\lambda_{0}}\left\|v_{2}\right\|+\left(2 \mathcal{P} K+b m_{2}\right)\left\|v_{3}\right\|-\mathcal{P} K\left\|v_{3}\right\| \\
& \leq e^{\lambda_{0}}\left(e^{-2 \lambda_{0}}\left\|v_{2}\right\|+e^{-\lambda_{0}}\left(2 \mathcal{P} K+b m_{2}\right)\left\|v_{3}\right\|\right)-c_{0} \mathcal{P} K\left\|v_{3}\right\| \\
& \stackrel{(\text { A.1. }}{ }<^{\lambda_{0}} e^{\lambda_{0}}\left(c_{0}\left\|v_{2}\right\|+c_{0} b\left\|v_{3}\right\|\right)-c_{0} \mathcal{P} K\left\|v_{3}\right\| \\
& \leq c_{0} e^{\lambda_{0}}\left\|v_{1}\right\|-c_{0} \mathcal{P} K\left\|v_{3}\right\| \\
& \leq c_{0}\left\|(D \phi(x, \omega) v)_{1}\right\| .
\end{aligned}
$$

Hence $D \phi(x, \omega) C(x, \omega) \subset \operatorname{int} C(\phi(x, \omega))$. By the cone-field criteria (see Theorem 2.6 in [16]), $T_{x} M \times$ $T_{\omega} \Omega$ has a dominated splitting $S_{1}(x, \omega) \oplus_{<} S_{2}(x, \omega)$ with $\operatorname{dim}\left(S_{2}(x, \omega)\right)=\operatorname{dim}\left(E^{u}(x, \omega) \times\{0\}\right)$. Notice that $E^{u}(x, \omega) \times\{0\}$ lies in $C(x, \omega)$ and it is invariant under $D \phi(x, \omega)$, so $S_{2}(x, \omega)=E^{u}(x, \omega) \times\{0\}$.

On the other hand, consider another cone

$$
\mathcal{C}(x, \omega)=\left\{v \in T_{x} M \times T_{\omega} \Omega:\left\|v_{1}\right\|+d\left\|v_{3}\right\| \leq\left\|v_{2}\right\|\right\}
$$

where

$$
\begin{equation*}
d>\frac{2 \mathcal{P} K}{e^{\lambda_{0}}-m_{1}^{-1}} . \tag{A.2}
\end{equation*}
$$

Denote

$$
c_{1}=\max \left\{\frac{2 \mathcal{P} K+m_{1}^{-1} d}{d e^{\lambda_{0}}}, e^{-2 \lambda_{0}}\right\} \in(0,1) .
$$

For any $v \in \mathcal{C}(x, \omega)$, we have

$$
\begin{aligned}
D \phi^{-1}(x, \omega) v= & D \phi^{-1}(x, \omega) v_{1}+D \phi^{-1}(x, \omega) v_{2}+D \phi^{-1}(x, \omega) v_{3} \\
= & D \phi^{-1}(x, \omega) v_{1}+P\left(E^{u}\left(\phi^{-1}(x, \omega)\right) \times\{0\}\right) D \phi^{-1}(x, \omega) v_{3} \\
& \quad+D \phi^{-1}(x, \omega) v_{2}+P\left(E^{s}\left(\phi^{-1}(x, \omega)\right) \times\{0\}\right) D \phi^{-1}(x, \omega) v_{3} \\
& \quad+P\left(\{0\} \times T_{\omega} \Omega\right) D \phi^{-1}(x, \omega) v_{3} \\
& \quad\left(D \phi^{-1}(x, \omega) v\right)_{1}+\left(D \phi^{-1}(x, \omega) v\right)_{2}+\left(D \phi^{-1}(x, \omega) v\right)_{3} .
\end{aligned}
$$

EXPONENTIAL DECAY OF RANDOM CORRELATIONS
Then

$$
\begin{aligned}
\left\|\left(D \phi^{-1}(x, \omega) v\right)_{1}\right\|+d\left\|\left(D \phi^{-1}(x, \omega) v\right)_{3}\right\| & \leq e^{-\lambda_{0}}\left\|v_{1}\right\|+\mathcal{P} K\left\|v_{3}\right\|+d \cdot m_{1}^{-1}\left\|v_{3}\right\| \\
& \leq e^{-\lambda_{0}}\left\|v_{1}\right\|+\left(2 \mathcal{P} K+d m_{1}^{-1}\right)\left\|v_{3}\right\|-c_{1} \mathcal{P} K\left\|v_{3}\right\| \\
& \leq e^{\lambda_{0}}\left(e^{-2 \lambda_{0}}\left\|v_{1}\right\|+e^{-\lambda_{0}}\left(2 \mathcal{P} K+d m_{1}^{-1}\right)\left\|v_{3}\right\|\right)-c_{1} \mathcal{P} K\left\|v_{3}\right\| \\
& \stackrel{\text { (A.2) }}{\lambda_{0}}\left(c_{1}\left\|v_{1}\right\|+c_{1} d\left\|v_{3}\right\|\right)-c_{1} \mathcal{P} K\left\|v_{3}\right\| \\
& \leq c_{1} e^{\lambda_{0}}\left\|v_{2}\right\|-c_{1} \mathcal{P} K\left\|v_{3}\right\| \\
& \leq c_{1}\left\|\left(D \phi^{-1}(x, \omega) v\right)_{2}\right\|
\end{aligned}
$$

Hence $D \phi^{-1}(x, \omega) \mathcal{C}(x, \omega) \subset \operatorname{int}\left(\mathcal{C}\left(\phi^{-1}(x, \omega)\right)\right)$. By the cone-field criteria, $T_{x} M \times T_{\omega} \Omega$ has a dominated splitting $H_{1}(x, \omega) \oplus<H_{2}(x, \omega)$ with $\operatorname{dim} H_{1}(x, \omega)=\operatorname{dim}\left(E^{s}(x, \omega) \times\{0\}\right)$. Notice that $E^{s}(x, \omega) \times\{0\}$ lies in cone $\mathcal{C}(x, \omega)$ and it is invariant under $D \phi(x, \omega)$, so $H_{1}(x, \omega)=E^{s}(x, \omega) \times\{0\}$.

Now $T_{x} M \times T_{\omega} \Omega$ has two dominated splittings: $S_{1}(x, \omega) \oplus<\left(E^{u}(x, \omega) \times\{0\}\right)$ and $\left(E^{s}(x, \omega) \times\right.$ $\{0\}) \oplus<H_{2}(x, \omega)$. Then, by uniqueness of the dominated splitting (Proposition 2.2 in [16]), we have

$$
T_{x} M \times T_{\omega} \Omega=\left(E^{s}(x, \omega) \times\{0\}\right) \oplus<\left(S_{1}(x, \omega) \cap H_{2}(x, \omega)\right) \oplus<\left(E^{u}(x, \omega) \times\{0\}\right)
$$

Besides, we already know that $E^{s}(x, \omega) \times\{0\}$ is uniformly contracted under $D \phi(x, \omega)$ and $E^{u}(x, \omega) \times$ $\{0\}$ is uniformly expanded under $D \phi(x, \omega)$. Hence $\phi$ is partially hyperbolic in the narrow sense.
A.4. Convex Cone, Projective Metric and Birkhoff's Inequality. In this section, we introduce the notion of projective metric associated to a convex cone in a topological vector space. The following knowledge is borrowed from [39, Section 2.1], and also can be found in [30].

Definition A.4. Let $E$ be a topological vector space. A subset $C \subset E$ is said to be a convex cone if
(1) $t v \in C$ for $v \in C$ and $t \in \mathbb{R}^{+}$;
(2) for any $t_{1}, t_{2} \in \mathbb{R}^{+}, v_{1}, v_{2} \in C$, then $t_{1} v_{1}+t_{2} v_{2} \in C$;
(3) $\bar{C} \cap-\bar{C}=\{0\}$, where $\bar{C}$ is the "integral closure" in a weaker sense, and it is defined by: $w \in \bar{C}$ if and only if there are $v \in C$ and $t_{n} \searrow 0$ such that $w+t_{n} v \in C$ for all $n \geq 1$.

Definition A.5. For a convex cone $C \subset E$, given any $v_{1}, v_{2} \in C$, we define

$$
\begin{aligned}
\alpha\left(v_{1}, v_{2}\right) & :=\sup \left\{t>0: v_{2}-t v_{1} \in C\right\} \\
\beta\left(v_{1}, v_{2}\right) & :=\inf \left\{s>0: s v_{1}-v_{2} \in C\right\}
\end{aligned}
$$

with the convention that $\sup \emptyset=0$ and $\inf \emptyset=+\infty$. The projective metric between $v_{1}, v_{2} \in C$ is defined by

$$
d_{C}\left(v_{1}, v_{2}\right)=\log \frac{\beta\left(v_{1}, v_{2}\right)}{\alpha\left(v_{1}, v_{2}\right)}
$$

with the convention that $d_{C}\left(v_{1}, v_{2}\right)=\infty$ if $\alpha\left(v_{1}, v_{2}\right)=0$ or $\beta\left(v_{1}, v_{2}\right)=\infty$.
Proposition A.2. $d_{C}$ is a metric in the projective quotient of $C$, i.e.,
(1) $d_{C}\left(v_{1}, v_{2}\right) \geq 0$ for all $v_{1}, v_{2} \in C$ (guaranteed by (3) in Definition A.4);
(2) $d_{C}\left(v_{1}, v_{2}\right)=d_{C}\left(v_{2}, v_{1}\right)$ for all $v_{1}, v_{2} \in C$;
(3) $d_{C}\left(v_{1}, v_{3}\right) \leq d_{C}\left(v_{1}, v_{2}\right)+d_{C}\left(v_{2}, v_{3}\right)$ for all $v_{1}, v_{2}, v_{3} \in C$;
(4) $d_{C}\left(v_{1}, v_{2}\right)=0$ if and only if there exists $t \in \mathbb{R}^{+}$such that $v_{1}=t v_{2}$.

Proposition A. 3 (Birkhoff's inequality). Let $E_{1}, E_{2}$ be two topological vector spaces, and $C_{i} \subset E_{i}$, for $i=1,2$ be convex cones. Let $L: E_{1} \rightarrow E_{2}$ be a linear operator and assume that $L\left(C_{1}\right) \subset C_{2}$. Let $D=\sup \left\{d_{C_{2}}\left(L\left(v_{1}\right), L\left(v_{2}\right)\right): v_{1}, v_{2} \in C_{1}\right\}$. If $D<\infty$, then

$$
d_{C_{2}}\left(L\left(v_{1}\right), L\left(v_{2}\right)\right) \leq\left(1-e^{-D}\right) d_{C_{1}}\left(v_{1}, v_{2}\right) \text { for all } v_{1}, v_{2} \in C_{1} .
$$
