# SOME APPROXIMATE SOLUTIONS TO THE SPREAD OF INFLUENZA A VIRUS INFECTION

#### Abstract

We study differential equations describing the spread of influenza A virus infection based on a mathematical model. We look for surface trajectories of the dynamical system in hand and their asymptotic behaviour.


## 1. Introduction

We consider the system of differential equations

where $i=2, \ldots, n_{E}$ and $j=2, \ldots, n_{I}$. We replace the value $\partial_{x x} V(x, t)$ in the model BQRY20 by the constant $a$, so in this paper we deal with only the case of constant $\partial_{x x} V(x, t)$. The constants $D_{P C F}$ and $v_{a}$ correspond to the diffusion rate and to the upward transport in the periciliary fluid. In the equations $c$ denotes the viral clearance rate, $p$ denotes the virion producing rate and $T$ denotes the fraction of uninfected target cells. We denote by $n_{I}$ and $n_{E}$ the numbers of age classes of infectious and eclipse phases, see BQRY20.

In the present paper, in the case of a system of equations with $n_{E}=0$, we propose a heuristic which shows that around $T(x, t)=\frac{c}{\tau_{I} p \beta}$ the system changes its behaviour. We obtain that if $\tau_{I} p \beta T>c$, then the trajectories tend to have asymptotic behaviour while for $\tau_{I} p \beta T<c$ they do not. Denote by $c_{E}$ and $c_{I}$ the values $\frac{n_{E}}{\tau_{E}}$ and $\frac{n_{I}}{\tau_{I}}$.

To solve the equations, we are looking for the smooth functions

are some given smooth functions.
If the linear maps

have rank two, then their graphs form a 2 -distribution in $\mathbb{R}^{n_{E}+n_{I}+3}$ and we are looking for integral surfaces (graphs of the solutions $S$ ) of this distribution.

## 2. Preliminaries

Let us partition the space $\mathbb{R}^{n_{E}+n_{I}+3}$ according to different values of the first $T$ coordinate into hyperplanes. Then for each $T \in \mathbb{R}$ consider the map

defined by the multiplication with this coefficient matrix $A \in \mathbb{R}^{\left(n_{E}+n_{I}+2\right) \times\left(n_{E}+n_{I}+2\right)}$. Then the second column in $\mathbb{R}^{\left(n_{E}+n_{I}+3\right)}$ of the coefficient matrix of the linear map

by the first coordinate $-\beta T V$.
For example, the first column of the matrix of the map $\Phi_{T, E_{1}, \ldots, E_{n_{E}}, I_{1}, \ldots, I_{n_{I}}, V, W}$ can be chosen to be

where $r_{i}>0$ are constants and $r_{n_{E}+n_{I}+2}=1$.
These two column vectors define two vector fields in $\mathbb{R}^{\left(n_{E}+n_{I}+3\right)}$. If these are linearly independent, then we have a 2 -distribution and if this distribution is involutive, then there are integral surfaces for it. These surfaces are the trajectories of the differential equation.

Lemma 2.1. We have

## 3. Results

Recall that $c$ denotes the viral clearance rate, $p$ denotes the virion producing rate and $T$ denotes the fraction of uninfected target cells. We denote by $n_{I}$ and $n_{E}$ the numbers of age classes of infectious and eclipse phases and we have $c_{I}=n_{I} / \tau_{I}$ and $c_{E}=n_{E} / \tau_{E}$. We want to determine the eigenvalues of the matrix $A$.
3.1. The case of $n_{E}=0$. If we suppose that $n_{E}=0$, then by Corollary [2.2 we have

Since $F(0)=-\beta T p c_{I}^{n_{I}}$, we have $F\left(\lambda_{2}\right)<0$ so it also has at most one singular point between $\lambda_{a}$ and $\lambda_{b}$. We have that

If $n_{I} \geq 3$ is odd, then $\lambda=-c_{I}$ is just an inflection point and then we have the analogous result about the roots but in every case there is another root $\lambda_{2}<-c_{I}$ as well. 3.1.2. The case of $\left(-c-\sqrt{c^{2}+4 \beta T p}\right) / 2<-c_{I}<\left(-c+\sqrt{c^{2}+4 \beta T p}\right) / 2$. In the case of

So $\operatorname{det}(A-\lambda I)$ has the roots $\lambda_{0}=0$ and $\lambda_{1}>0$ if $c c_{I}<\beta T p n_{I}, \lambda_{0}=0$ if $c c_{I}=\beta T p n_{I}$ and $\lambda_{0}=0$ and some $\lambda_{1}<0$ if $c c_{I}>\beta T p n_{I}$ and at most two other negative roots in each cases. If $n_{I} \geq 3$ is odd, then similarly to the case of $2 \mid n_{I}$ we have $\lambda_{0}=0$ and a positive or negative root depending on the same conditions and one other negative root.

This motivates the following definition.
Definition 3.1. If $c>\tau_{I} p \beta T$, then the system (1.1) is definite. If $c<\tau_{I} p \beta T$, then the system is indefinite.

If the system that we have studied is definite or indefinite, then 0 is an eigenvalue with multiplicity one. So we obtain the following.

Proposition 3.2. Let $n_{E}=0$. If the system (1.1) is definite, then all the non-zero eigenvalues of the matrix of $\varphi$ is negative. If the system is indefinite, then there is one positive eigenvalue and all the other non-zero eigenvalues are negative. In both cases 0 is an eigenvalue.
Proof. The statement follows from the previous arguments.

Table 1. The signs of the possible different eigenvalues of $A$ in the case of $2 \mid n_{I}$. The "-" signs in the brackets are optional and represent negative numbers which are smaller than $-c_{I}$. The other "-" signs represent negative numbers which are bigger than $-c_{I}$.

Table 2. The signs of the possible different eigenvalues of $A$ in the case of odd $n_{I}$. The " - " signs in the first and second rows represent negative numbers which are smaller than $-c_{I}$ and in the third row the " - " signs represent a negative number which is smaller than $-c_{I}$ and a negative number which is bigger than $-c_{I}$.

Proposition 3.3. The algebraic multiplicity of all the real eigenvalues is one, except possibly for the negative eigenvalues in the brackets in the case of $2 \mid n_{I}$ and for the eigenvalue 0 in the case of $c=\beta T p \tau_{I}$.

Proof. The statement follows from the previous arguments.
Proposition 3.4. The geometric multiplicity of every real eigenvalue is one.
Proof. We have to solve the equation

$$
(A-\lambda I) x=0
$$

which is just

$$
\begin{gathered}
\left(-c_{I}-\lambda\right) I_{1}+\beta T V=0, \\
c_{I} I_{1}+\left(-c_{I}-\lambda\right) I_{2}=0, \\
\cdots \\
c_{I} I_{n_{I}-1}+\left(-c_{I}-\lambda\right) I_{n_{I}}=0, \\
p \sum_{i=1}^{n_{I}} I_{i}+(-c-\lambda) V+v_{a} W=0, \\
-\lambda W=0 .
\end{gathered}
$$

This implies $W=0$ and since substituting the first $n_{I}$ equations into

$$
p \sum_{i=1}^{n_{I}} I_{i}+(-c-\lambda) V=0
$$

results $\operatorname{det}(A-\lambda I)=0$, which can be seen after a short computation, the solution of $(A-\lambda I) x=0$ is

$$
W=0, \quad V \in \mathbb{R}, \quad I_{k}=\frac{c_{I}^{k-1}}{\left(c_{I}+\lambda\right)^{k}} \beta T V,
$$

which means that the geometric multiplicity is equal to 1 for $\lambda \neq 0$. If $\lambda=0$, then the solution is

$$
V \in \mathbb{R}, \quad I_{1}=\beta T V / c_{I}, \quad I_{k}=I_{k-1}, \quad p \sum_{i=1}^{n_{I}} I_{i}-c V+v_{a} W=0
$$

so the geometric multiplicity is equal to 1 .
Corollary 3.5. The eigenvectors for $\lambda \neq 0$ are

$$
\left[\frac{1}{c_{I}+\lambda} \beta T V, \frac{c_{I}}{\left(c_{I}+\lambda\right)^{2}} \beta T V, \ldots, \frac{c_{I}^{n_{I}-1}}{\left(c_{I}+\lambda\right)^{n_{I}}} \beta T V, V, 0\right],
$$

where $V \in \mathbb{R}$ and for $\lambda=0$ they are

$$
\left[\frac{1}{c_{I}} \beta T V, \frac{1}{c_{I}} \beta T V, \ldots, \frac{1}{c_{I}} \beta T V, V, \frac{\beta T p \tau_{I}-c}{-v} V\right],
$$

where $V \in \mathbb{R}$.
In the following, suppose that $n_{E}=0$. According to the previous arguments by parametrizing everything by $T$ let us write and denote the space $\mathbb{R}^{n_{I}+3}$ as

$$
\mathbb{R} \oplus \mathbb{R}^{n_{I}+2}=\mathbb{V} \oplus \mathbb{V}_{T}^{-} \oplus \mathbb{V}_{T}^{+} \oplus \mathbb{V}_{T}^{0}
$$

where the first $\mathbb{V}$ summand stands for the variable $T$, the summand $\mathbb{V}_{T}^{-}$is the eigenspace for the negative eigenvalues, the summand $\mathbb{V}_{T}^{+}$is the eigenspace for the positive eigenvalues and the last $\mathbb{V}_{T}^{0}$ summand stands for the eigenvalue 0 . Then we get the vector field

$$
\Phi_{T, I_{1}, \ldots, I_{n_{I}}, V, W} \in \mathbb{R}^{n_{I}+3}
$$

by computing at first the vector field

$$
\varphi\left(I_{1}, \ldots, I_{n_{I}}, V, W\right) \in \mathbb{V}_{T}^{-} \oplus \mathbb{V}_{T}^{+} \oplus \mathbb{V}_{T}^{0}
$$

and then by taking the vector field

$$
\varphi\left(I_{1}, \ldots, I_{n_{I}}, V, W\right)+\left(0, \ldots, 0, D_{P C F} a, 0\right)+(0, \ldots, 0, \psi)
$$

This last addition modifies $\varphi\left(I_{1}, \ldots, I_{n_{I}}, V, W\right)$ only in its last two coordinates in $\mathbb{R}^{n_{I}+2}$. After this we add $-\beta T V$ in the first coordinate $\mathbb{R}$ in $\mathbb{R} \oplus \mathbb{R}^{n_{I}+2}$.

The map $\varphi$ has negative eigenvalues in the direction $\mathbb{V}_{T}^{-}$, an eigenvalue 0 in the direction of $\mathbb{V}_{T}^{0}$ and a positive eigenvalue in the direction of $\mathbb{V}_{T}^{+}$depending on whether the state of the system is definite or indefinite (the presence of the positive eigenvalue changes at $\left.T=\frac{c}{\tau_{I} p \beta}\right)$. The last coordinate of the vector field $\varphi\left(I_{1}, \ldots, I_{n_{I}}, V, W\right)$ is equal to 0 . By omitting $\mathbb{V}_{T}^{0}$ it is easy to sketch this vector field depending on the value of $T$, see Figure 1 .


Figure 1. The sketch of the vector fields for $T<\frac{c}{\tau_{I} p \beta}, T=\frac{c}{\tau_{I} p \beta}$ and $T>\frac{c}{\tau_{I} p \beta}$, respectively, from the left to the right hand side. The subspace $\mathbb{V}_{T}^{0^{\prime}}$ is a component of $\mathbb{V}_{T}^{0}$.

When we add $\left(0, \ldots, 0, D_{P C F} a, 0\right)$, all the vector fields are modified by the constant $D_{P C F} a$ in one coordinate direction. Then in the space $\mathbb{V}^{n_{I}} \oplus \mathbb{V}^{2}=\mathbb{R}^{n_{I}+2}$ we add $(0, \ldots, 0, \psi)$ to the previously constructed vector field. If the value of $|\psi|=\left|\partial_{x t} V(x, t)\right|$ is small, then adding it does not modify the picture too much.
