# REGULARITY OF QUASI-LINEAR EQUATIONS WITH HÖRMANDER VECTOR FIELDS OF STEP TWO

#### Abstract

If the smooth vector fields $X_{1}, \ldots, X_{m}$ and their commutators span the tangent space at every point in $\Omega \subseteq \mathbb{R}^{N}$ for any fixed $m \leq N$, then we establish the full interior regularity theory of quasi-linear equations $\sum_{i=1}^{m} X_{i}^{*} A_{i}\left(X_{1} u, \ldots, X_{m} u\right)=0$ with $p$-Laplacian type growth condition. In other words, we show that a weak solution of the equation is locally $C^{1, \alpha}$.

## 1. Introduction

The development of partial differential equations arising from families of noncommuting vector fields has been conspicuous since the fundamental work of Hörmander [29]. Such equations, nowadays referred to as sub-elliptic equations, are not elliptic in general. Nevertheless, they have a remarkable structural similarity with elliptic equations. This has been evident in the theory that sub-elliptic linear equations entail, where the given non-commuting vector fields $X_{1}, \ldots, X_{m}$ on a domain $\Omega \subseteq \mathbb{R}^{N}$ satisfy the, so-called, Hörmander's rank condition

\begin{equation*}
\operatorname{dim}\left(\operatorname{Lie}\left(X_{1}, \ldots, X_{m}\right)\right)=N \tag{1.1}
\end{equation*}
$$

at every point in $\Omega$. It was first used in [29] to show that the linear operator $\mathcal{L} u=\sum_{i=1}^{m} X_{i}^{*} X_{i} u$, called sub-elliptic Laplacian or sub-Laplacian, is hypoelliptic. Later, it was found that it also satisfies estimates of the form

$$
\|u\|_{\mathcal{S}^{k+2, p}} \leq c(N, p)\left(\|\mathcal{L} u\|_{\mathcal{S}^{k, p}}+\|u\|_{\mathcal{S}^{k, p}}\right)
$$

where $\mathcal{S}^{k, p}$ are Sobolev spaces defined by the vector fields (see Section 2 for details), which clearly shows the resemblance to the corresponding elliptic estimates. This has been unveiled at increasing levels of generality by Folland-Stein [21], Folland [20] and Rothschild-Stein [43]. Their methods also reflect the importance of the special case when the vector fields are left-invariant with respect to a Nilpotent Lie group. The Hörmander's condition (1.1) endows a stratification on the Lie algebra of such groups and they are called Carnot Groups (see [1]). Later, it has been shown by Nagel-Stein-Wainger [41] (see also Sánchez-Calle [44]) that in the general case,

[^0]the Carnot-Carathèodory metric is equivalent to the natural metrics intrinsic to the given vector fields, that are generalizations of the homogeneous metrics of Carnot groups.

These subsequently lead to the development of an extensive literature and nowadays, the theory of linear sub-elliptic equations is largely established. It naturally leads to the inquiry for a regularity theory of quasi-linear equations in the sub-elliptic setting, similar to that of quasi-linear elliptic equations. This area has remained relatively open over the years and the present paper is aimed towards this pursuit.

Let $\Omega \subset \mathbb{R}^{N}$ be an open, simply connected bounded domain and $X_{1}, \ldots, X_{m}$ be smooth vector fields with $m \leq N$ such that they, along with their commutators, span the tangent space at every point in $\Omega$. This is a special case of (1.1), referred to as the "step two hypothesis" by Nagel-Stein [40], where commutators up to second-order are considered in place of the full Lie algebra generated by the vector fields (see (2.1)). We consider the equation

\operatorname{div}_{H}(A(\mathfrak{X} u))=\sum_{i=1}^{m} X_{i}^{*} A_{i}(\mathfrak{X} u)=0 \quad \text { in } \Omega \tag{1.2}
\end{equation*}
$$

where $\mathfrak{X} u=\left(X_{1} u, \ldots, X_{m} u\right)$ is the sub-elliptic gradient, $X_{i}^{*}$ is the formal adjoint of $X_{i}$ and $A: \mathbb{R}^{m} \rightarrow \mathbb{R}^{m}$ is a given $C^{1}$-function that satisfies the following structure condition,

\left(\delta+|z|^{2}\right)^{\frac{p-2}{2}}|\xi|^{2} \leq\langle D A(z) \xi, \xi\rangle \leq L\left(\delta+|z|^{2}\right)^{\frac{p-2}{2}}|\xi|^{2} \\
|A(z)| \leq L|z|\left(\delta+|z|^{2}\right)^{\frac{p-2}{2}} \tag{1.3}
\end{gather*}
$$

for every $z, \xi \in \mathbb{R}^{m}$, with $1<p<\infty, L \geq 1$ and $\delta \geq 0$. The equation (1.2) with (1.3) is modelled on the degenerated sub-elliptic equation

$$
\begin{equation*}
\operatorname{div}_{H}\left(\left(\delta+|\mathfrak{X} u|^{2}\right)^{\frac{p-2}{2}} \mathfrak{X} u\right)=0 \tag{1.4}
\end{equation*}
$$

which, for $\delta=0$, is called the sub-elliptic $p$-Laplacian equation $\operatorname{div}_{H}\left(|\mathfrak{X} u|^{p-2} \mathfrak{X} u\right)=0$.
In the Euclidean setting, it is known that weak solutions of the classical $p$-Laplacian equation $\operatorname{div}\left(|\nabla u|^{p-2} \nabla u\right)=0$ are locally $C^{1, \alpha}$, as shown independently by DiBenedetto [10], Lewis [32] and Tolksdorf [45] using techniques descending from the seminal work of De Giorgi [9]. Hence, for the sub-elliptic case, $C^{1, \alpha}$-regularity of weak solutions with respect to the metrics introduced in [41] is likewise expected. The sub-elliptic Poincaré inequality was first proved by Jerison [30] which leads to the Sobolev embedding theorem which has been later shown in different levels of generality by Garofalo-Nhieu [24], Franchi-Lu-Wheeden [23], Hajlasz-Koskela [28], etc. However, obtaining higher regularity of the gradient $\mathfrak{X u} u$ using the classical techniques is quite difficult even in the case of step two, due to the non-commutativity of the vector fields. For previous results and similar theories in this direction, we refer to $[2,6,7,19,13,14,35,34,12,36,42,4]$ and references therein. Recently, the problem has been resolved for the case of the Heisenberg Group (see [47, 39]), which is the most trivial example of a step two Carnot group where the vector space of commutators is one dimensional. The case of non-Nilpotent groups like $\mathbb{S U}(3)$ and compact semi-simple Lie groups has been considered in [16]. In this paper, we prove the $C^{1, \alpha}$-regularity for the most general step two case.

First, we show that the sub-elliptic gradient is locally bounded as our first main result.
Theorem 1.1. If $u \in \mathcal{S}^{1, p}(\Omega)$ is a weak solution of equation (1.2) equipped with the structure condition (1.3) for any $1<p<\infty$ and $\delta \geq 0$, then $\mathfrak{X} u \in L_{\text {loc }}^{\infty}\left(\Omega, \mathbb{R}^{m}\right)$. Moreover, for any $x_{0} \in \Omega$ and metric ball $B_{r}=B_{r}\left(x_{0}\right) \subset \Omega$, we have

$$
\begin{equation*}
\sup _{B_{\sigma r}}|\mathfrak{X} u| \leq \frac{c}{(1-\sigma)^{Q / p}}\left(f_{B_{r}}\left(\delta+|\mathfrak{X} u|^{2}\right)^{\frac{p}{2}} d x\right)^{\frac{1}{p}} \tag{1.5}
\end{equation*}
$$

for any $0<\sigma<1$, where $c=c(N, p, L)>0$ and $Q=Q\left(x_{0}\right)=\liminf _{s \rightarrow 0^{+}} \frac{\log \left(\left|B_{s}\left(x_{0}\right)\right|\right)}{\log (s)}$.

The following Corollary is an easy consequence of Theorem 1.1.
Corollary 1.2. If $u \in \mathcal{S}^{1, p}(\Omega)$ is a weak solution of equation (1.2) equipped with the structure condition (1.3) for any $1<p<\infty$ and $\delta \geq 0$, then $u \in C_{\mathrm{loc}}^{0,1}(\Omega)$. Moreover, for any metric ball $B_{r} \subset \Omega$, we have

$$
\begin{equation*}
|u(x)-u(y)| \leq c\left(f_{B_{r}}\left(\delta+|\mathfrak{X} u|^{2}\right)^{\frac{p}{2}} d x\right)^{\frac{1}{p}} d_{c}(x, y) \tag{1.6}
\end{equation*}
$$

for any $x, y \in B_{r}$, where $c=c(N, p, L)>0$ and $d_{c}$ is the Carnot-Carathèodory metric.
Second, we show that the sub-elliptic gradient is locally Hölder continuous with respect to the Carnot-Carathèodory metric. The following theorem is the second main result of this paper.

Theorem 1.3. If $u \in \mathcal{S}^{1, p}(\Omega)$ is a weak solution of equation (1.2) equipped with the structure condition (1.3) for any $1<p<\infty$ and $\delta \geq 0$, then there exists a positive $\alpha=\alpha(N, p, L) \leq 1$ such that $\mathfrak{X} u \in C_{\mathrm{loc}}^{0, \alpha}\left(\Omega, \mathbb{R}^{m}\right)$. Moreover, for any concentric metric balls $B_{r} \subset B_{r_{0}} \subset \Omega$, we have

$$
\begin{equation*}
\max _{1 \leq i \leq m} \operatorname{osc}_{B_{r}} X_{i} u \leq c\left(\frac{r}{r_{0}}\right)^{\alpha}\left(f_{B_{r_{0}}}\left(\delta+|\mathfrak{X} u|^{2}\right)^{\frac{p}{2}} d x\right)^{\frac{1}{p}} \tag{1.7}
\end{equation*}
$$

for any $0<r<r_{0}$, where $c=c(N, p, L)>0$ is a constant.
The following Corollary is an easy consequence of Theorem 1.3 and Schauder estimates [46].
Corollary 1.4. If $u \in \mathcal{S}^{1, p}(\Omega)$ is a weak solution of equation (1.2) equipped with the structure condition (1.3) for any $1<p<\infty$ and $\delta>0$, moreover if $A$ is smooth, then $u \in C^{\infty}(\Omega)$.

The significance of this paper lies mainly in the fact that it shows the left invariance of the vector fields with respect to a Lie group is superfluous for the purpose of regularity. As reflected by the results in this paper, all necessary techniques and estimates are independent of any Lie group structure on $\mathbb{R}^{N}$. Therefore, the commutation relations between the vector fields are quite arbitrary within the restriction of the step two hypothesis. This is much more general than that for the case of the Heisenberg Group or any other Carnot groups of step two.

In order to get the full regularity, the general structure of the vector fields makes it necessary to obtain Caccioppoli type estimates of every possible type by testing the equations satisfied by $X_{i} u$ and $\left[X_{i}, X_{j}\right] u$ for all $i, j$ with every combination of the vector fields and their commutators. The interplay between the estimates leading to the proofs of the theorems is similar to the earlier works. The guiding principle remains that the behavior of homogeneous sub-elliptic equations (1.2) is similar to that of inhomogeneous elliptic equations with an integrable right-hand side (this role is played by the extra terms containing the commutators for the sub-elliptic case). Hence, the high integrability of the commutators (Corollary 3.9 and similar others) allows the use of De Giorgi type techniques. The double truncation $v=\min \left(\mu(r) / 8, \max \left(\mu(r) / 4-X_{l} u, 0\right)\right)$ with $\mu(r)=\max _{1 \leq i \leq m} \sup _{B_{r}}\left|X_{i} u\right|$, has been used within the estimates particularly to deal with the singular case $1<p<2$, similarly as in [39]. This argument originates in the earlier works [45, 33], etc. The Riemannian approximation is used for the local Lipschitz continuity.

The paper is organized as follows. All necessary notations and preliminaries are provided in Section 2 and the apriori Caccioppoli type estimates are proved in Section 3. Then, the proof of Theorem 1.1 is provided in Section 4. In Section 5, further requisite estimates are obtained that lead to the proof of Theorem 1.3 in the end.

Finally, we remark that the present regularity results seem to be the best possible ones within the framework of the existing techniques and methods. The estimates of this paper use properties that are specific to step two in subtle ways which, apparently do not have any immediate generalization for higher-order commutators. We believe the regularity theory involving vector fields satisfying the general Hörmander's condition (1.1) would require new fundamental ideas.

## 2. Notations and Preliminaries

In this section, we develop relevant notations and provide basic properties and previously known results that shall be used throughout this paper.

Here onwards we assume the set of smooth vector fields $\left\{X_{1}, \ldots, X_{m}\right\}$ defined on $\Omega \subseteq \mathbb{R}^{N}$ for some integer $m \leq N$, satisfy the step two hypothesis of Nagel-Stein [40]; precisely,
(2.1) $X_{1}, \ldots, X_{m}$ and $\left[X_{j}, X_{k}\right] \forall j, k \in\{1 \ldots, m\} \quad$ span the tangent space at each $x_{0} \in \Omega$.

The nontrivial case occurs if $m<N$ because the case of equality is identical to the familiar Euclidean setting. We choose an enumeration of the commutators as $\left\{T_{1}, \ldots, T_{n}\right\}$ such that $\left\{X_{1}, \ldots, X_{m}, T_{1}, \ldots, T_{n}\right\}$ span the whole tangent space, for some integer $0<n \leq m(m-1) / 2$.

For a function $u: \Omega \rightarrow \mathbb{R}$, let us denote the gradients as

$$
\mathfrak{X} u=\left(X_{1} u, \ldots, X_{m} u\right) \quad \text { and } \quad T u=\left(T_{1} u, \ldots, T_{n} u\right) .
$$

The Hessian is denoted as $\mathfrak{X X} u=\left(X_{j} X_{i} u\right)_{i, j}$, similarly $\mathfrak{X} T u=\left(X_{j} T_{k} u\right)_{k, j}$ and $T \mathfrak{X} u=\left(T_{k} X_{j} u\right)_{j, k}$ which are respectively $m \times n$ and $n \times m$ matrices. The commutator matrices are denoted as $[\mathfrak{X}, \mathfrak{X}] u=\left(\left[X_{j}, X_{i}\right] u\right)_{i, j}$ and similarly $[\mathfrak{X}, T]$ and $[T, \mathfrak{X}]$. The sub-elliptic divergence is defined as

$$
\operatorname{div}_{H}(F)=\sum_{j=1}^{m} X_{j}^{*} f_{j}, \quad \forall F=\left(f_{1}, \ldots, f_{m}\right)
$$

The Euclidean vector fields on $\mathbb{R}^{m}$ are denoted as $D_{i}$ and $D=\left(D_{1}, \ldots, D_{m}\right)$ is the Euclidean gradient; sometimes $D_{i}$ is also denoted as $\partial_{x_{i}}$ or something analogous in terms of coordinates.

We note that the step two hypothesis (2.1) implies

$$
\begin{equation*}
\left[X_{i}, X_{j}\right]=\sum_{k=1}^{n} \alpha_{i, j}^{(k)} T_{k}+\sum_{l=1}^{m} \beta_{i, j}^{(l)} X_{l} \quad \text { and } \quad\left[X_{i}, T_{j}\right]=\sum_{l=1}^{m} \gamma_{i, j}^{(l)} X_{l}+\sum_{k=1}^{n} \delta_{i, j}^{(k)} T_{k}, \tag{2.2}
\end{equation*}
$$

and with appropriate choice of scaling in the norm of vector fields, we can assume without loss of generality that

$$
\begin{equation*}
\max _{i, j} \sum_{k, l}\left(\left\|\alpha_{i, j}^{(k)}\right\|_{L^{\infty}}+\left\|\beta_{i, j}^{(l)}\right\|_{L^{\infty}}+\left\|\gamma_{i, j}^{(l)}\right\|_{L^{\infty}}+\left\|\delta_{i, j}^{(k)}\right\|_{L^{\infty}}\right) \leq c(N), \quad \text { for some } \quad c(N)>0, \tag{2.3}
\end{equation*}
$$

and from smoothness, we can also conclude boundedness $\left\|\mathfrak{X} \alpha_{i, j}^{(k)}\right\|_{L^{\infty}}+\left\|T \alpha_{i, j}^{(k)}\right\|_{L^{\infty}} \leq c(N)$ and similar bounds for the others. Therefore, some basic inequalities are in order. Using (2.2) twice successively along with (2.3) and the bounds, we have the following inequalities:
(i) $\quad\left|\left[X_{i}, T_{k}\right] X_{j} u\right| \leq c(|\mathfrak{X X} u|+|T \mathfrak{X} u|) \leq c(|\mathfrak{X} \mathfrak{X} u|+|\mathfrak{X} T u|+|\mathfrak{X} u|+|T u|)$;
(ii) $\quad\left|\left[\left[X_{i}, X_{l}\right], X_{j}\right] u\right| \leq c(|[T, \mathfrak{X}] u|+|[\mathfrak{X}, \mathfrak{X}] u|+|\mathfrak{X} u|+|T u|) \leq c(|\mathfrak{X} u|+|T u|)$,
for every $i, j, l \in\{1, \ldots, m\}$ and $k \in\{1, \ldots, n\}$, where $c=c(N)>0$ is a constant. Furthermore, we have the inequality

$$
\begin{equation*}
|T u| \leq c|\mathfrak{X X} u|, \tag{2.6}
\end{equation*}
$$

for some constant $c=c(N)>0$, since $T_{k}=\left[X_{l}, X_{j}\right]$ for some $l, j \in\{1, \ldots, m\}$.
2.1. Sub-elliptic metrics. Let us recall the Carnot-Carathéodory metric (CC-metric) which is defined in terms of the length $\ell(\gamma)$ of curves $\gamma:[0,1] \rightarrow \Omega$, as

\begin{equation*}
d_{c}(x, y)=\inf \{\ell(\gamma): \gamma \in \Gamma(x, y)\}, \tag{2.7}
\end{equation*}
$$

where the class $\Gamma$ of absolutely continuous curves is given by

$$
\Gamma(x, y)=\left\{\gamma \in A C([0,1] ; \Omega): \gamma(0)=x, \gamma(1)=y, \gamma^{\prime}(t) \in \operatorname{span}\left\{\left.X_{1}\right|_{\gamma(t)}, \ldots,\left.X_{m}\right|_{\gamma(t)}\right\}\right\} .
$$

Chow's connectivity theorem (see [8]) gurantees $\Gamma(x, y) \neq \emptyset$ so that $d_{c}$ is finite for any $x, y \in \mathbb{R}^{N}$. However, to determine the volume of the metric balls, another metric is required that is intrinsic
to the vector fields, as shown in [41]. Let $\left\{Y_{1}, \ldots, Y_{m+n}\right\}=\left\{X_{1}, \ldots, X_{m}, T_{1}, \ldots, T_{n}\right\}$. We observe that we can associate an integer, called formal degree $d_{j}=\operatorname{deg}\left(Y_{j}\right) \in\{1,2\}$; indeed, we define that $\operatorname{deg}\left(Y_{j}\right)=1$ if $Y_{j} \in \operatorname{span}\left\{X_{1}, \ldots, X_{m}\right\}$ and $\operatorname{deg}\left(Y_{j}\right)=2$ otherwise. Then, it is not difficult to see that (2.2) and (2.1) respectively imply:
(a) For every $j, k$ we have $\left[Y_{j}, Y_{k}\right] \in \operatorname{span}\left\{Y_{l}: d_{l} \leq d_{j}+d_{k}\right\}$;
(b) $Y_{1}, \ldots, Y_{m+n}$ span the whole tangent space.

Then, we can define following metric as in Nagel-Stein-Wainger [41]. For any $r>0$, let $\Gamma(r)$ be the class of absolutely continuous curves $\gamma:[0,1] \rightarrow \Omega$ satisfying the differential equation

$$
\gamma^{\prime}(t)=\sum_{j} a_{j}(t) Y_{j}(\gamma(t)) \quad \text { with } \quad\left|a_{j}(t)\right|<r^{d_{j}}
$$

then the metric is defined as

$$
\begin{equation*}
\rho(x, y)=\inf \{r>0: \exists \gamma \in \Gamma(r), \gamma(0)=x, \gamma(1)=y\} . \tag{2.8}
\end{equation*}
$$

Proposition 1.1 in [41], imply that within compact subsets of $\Omega$, we have

$$
\begin{equation*}
c_{1}|x-y| \leq \rho(x, y) \leq c_{2}|x-y|^{1 / 2} \quad \forall x, y \in \Omega \subseteq \mathbb{R}^{N} \tag{2.9}
\end{equation*}
$$

for some positive constants $c_{1}, c_{2}$. Let us denote the metric balls $B_{r}(x)=\left\{y \in \mathbb{R}^{N}: \rho(x, y)<r\right\}$ and it has been shown in [41] that they follow all standard properties. In general $m+n \geq N$ and it is possible to choose a local basis $Y_{i_{1}}, \ldots, Y_{i_{N}}$ for the tangent space. For every such $I=\left(i_{1}, \ldots, i_{N}\right)$, letting $d(I)=d_{i_{1}}+\ldots+d_{i_{N}}$ and

$$
\Lambda(x, r)=\sum_{I}\left|\lambda_{I}(x)\right| r^{d(I)}
$$

where $\lambda_{I}(x)=\operatorname{det}\left(a_{j, k}(x)\right)$ whenever $Y_{i_{j}}=\sum_{k} a_{j, k} \partial_{x_{k}}$, one can estimate the volume of the balls. Thus, $\Lambda \neq 0$ whenever $Y_{i_{1}}, \ldots, Y_{i_{N}}$ is a basis for the tangent space. Let $|E|$ be the Lebesgue measure of $E$ for any $E \subset \mathbb{R}^{N}$. Then, from Theorem 1 in [41], there exists $c_{2}>c_{1}>0$ such that we have

$$
c_{1} \Lambda(x, r) \leq\left|B_{r}(x)\right| \leq c_{2} \Lambda(x, r)
$$

in compact subsets of $\Omega$. Therefore, let us denote

$$
\begin{equation*}
Q(x)=\liminf _{r \rightarrow 0^{+}} \frac{\log \left(\left|B_{r}(x)\right|\right)}{\log (r)} \tag{2.10}
\end{equation*}
$$

so that we have $c_{1}^{\prime} r^{Q} \leq\left|B_{r}(x)\right| \leq c_{2}^{\prime} r^{Q}$ in compact subsets of $\Omega$ for some $c_{2}^{\prime}>c_{1}^{\prime}>0$ and $Q=Q(x)$. Since, $\Lambda$ is a polynomial in $r$ of fixed degree, hence $Q$ is lower semi-continuous. It is a deep result of Nagel-Stein-Wainger [41, Theorem 4], that the metric $\rho$ is equivalent to the CC-metric $d_{c}$. Henceforth, in the rest of the paper, we shall denote CC-metric balls by $B_{r}$ without loss of generality and $Q$ as the local dimension.

Remark 2.1 (Step 2 Carnot Groups). For a special case, when the vector fields are left invariant with respect to a Nilpotent Lie Group on $\mathbb{R}^{N}$ along with the hypothesis (2.1), then it is called a Carnot Group of step 2. In that case, if $X_{1}, \ldots, X_{m}$ are linearly independent, then we have $m+n=N$, the metric $\rho$ is equivalent to the metric induced by the homogeneous norm of the group, and $Q=m+2 n$. Also, the commutation relations are more special than (2.2), we have $\left[X_{i}, T_{k}\right]=0$ and $\left[X_{i}, X_{j}\right]=\sum_{k=1}^{n} \alpha_{i, j}^{(k)} T_{k}$ where $\alpha_{i, j}^{(k)}$,s are precisely prescribed by the composition law of the group. Furthermore, if it is a free group then we have $n=m(m-1) / 2$.

The Hölder classes $C^{k, \alpha}$ (also denoted as $\Gamma^{k, \alpha}$ ) has been introduced by Folland and Stein, see [20, 22]. The functions in these classes are Hölder continuous with respect to the CC-metric.

Definition 2.2 (Folland-Stein classes). Given an open set $\Omega \subset \mathbb{R}^{N}$, a function $u: \Omega \rightarrow \mathbb{R}$ and $0<\alpha \leq 1$, we say $u \in C^{0, \alpha}(\Omega)$ if there exists a constant $M>0$, such that

$$
|u(x)-u(y)| \leq M d_{c}(x, y)^{\alpha}, \quad \forall x, y \in \Omega
$$

It is a Banach space with the norm $\|u\|_{C^{0, \alpha}(\Omega)}=\|u\|_{L^{\infty}(\Omega)}+[u]_{C^{0, \alpha}(\Omega)}$, where the Hölder seminorm is defined as

[u]_{C^{0, \alpha}(\Omega)}=\sup _{\substack{x, y \in \Omega \\ x \neq y}} \frac{|u(x)-u(y)|}{d_{c}(x, y)^{\alpha}} \tag{2.11}

For any $k \in \mathbb{N}$, the spaces $C^{k, \alpha}(\Omega)$ are defined inductively as follows: we say that $u \in C^{k, \alpha}(\Omega)$ if $X_{i} u \in C^{k-1, \alpha}(\Omega)$ for every $i \in\{1, \ldots, m\}$.
Definition 2.3 (Sub-elliptic Sobolev spaces). Given an open set $\Omega \subset \mathbb{R}^{N}$, a function $u: \Omega \rightarrow \mathbb{R}$ and $1 \leq p<\infty$, the sub-elliptic Sobolev spaces are defined as

\mathcal{S}^{1, p}(\Omega)=\left\{u \in L^{p}(\Omega): X_{j} u \in L^{p}(\Omega), \forall j \in\{1, \ldots, m\}\right\}
$$

which is a Banach space with the norm $\|u\|_{\mathcal{S}^{1, p}(\Omega)}=\|u\|_{L^{p}(\Omega)}+\|\mathfrak{X} u\|_{L^{p}\left(\Omega, \mathbb{R}^{m}\right)}$. The subspaces $\mathcal{S}_{\text {loc }}^{1, p}(\Omega)$ and $\mathcal{S}_{0}^{1, p}(\Omega)$ are defined as usual. Moreoever, for any $k \in \mathbb{N}$, the space $\mathcal{S}^{k, p}(\Omega)$ is also defined by standard extension.

For any metric ball $B_{r}=B_{r}\left(x_{0}\right)$, the following Poincaré inequality for $u \in \mathcal{S}^{1, p}\left(B_{r}\right)$

holds, see [30, 28]. This leads to the following Sobolev inequality,

for all $v \in \mathcal{S}_{0}^{1, q}\left(B_{r}\right)$ and $1<q<Q$ with $Q=Q\left(x_{0}\right)$.
2.2. Sub-elliptic equations. If $u: \Omega \rightarrow \mathbb{R}$ is a weak solution of (1.2), then for every test function $\phi \in C_{0}^{\infty}(\Omega)$, we have

Furthermore, for all non-negative $\phi \in C_{0}^{\infty}(\Omega)$, if the integral above is positive (resp. negative) then $u$ is called a weak supersolution (resp. subsolution) of the equation (1.2).

It is easy to see that (1.3) implies the following ellipticity condition

for all $z, w \in \mathbb{R}^{m}$, where $c(p)>0$ and $L^{\prime}=L^{\prime}(p, L)>0$.
The inequalities (2.15) and (2.16) can be used to prove the existence of a weak solution of equation (1.2), by standard variational methods. In fact, given any $u_{0} \in \mathcal{S}^{1, p}(\Omega)$, there exists a unique weak solution $u \in \mathcal{S}^{1, p}(\Omega)$ of the following Dirichlet problem

\operatorname{div}_{H}(A(\mathfrak{X} u))=0 \text { in } \Omega  \tag{2.17}\\
u-u_{0} \in \mathcal{S}_{0}^{1, p}(\Omega)
\end{array}\right.
$$

The uniqueness follows from the comparison principle, i.e. if $u$ and $v$ respectively are weak super and subsolution of the equation (1.2) and $u \geq v$ on $\partial \Omega$ in the trace sense, then we have $u \geq v$ a.e. in $\Omega$. This can be shown easily by appropriate test fuctions on the equation (2.17).

Remark 2.4 (Divergence-free vector fields). Given a vector field $X$, its formal adjoint with respect to the Euclidean volume form (Lebesgue measure) is defined as $X^{*}$, so that for any $v \in C_{0}^{\infty}(\Omega)$, we have

$$
\begin{equation*}
\int_{\Omega} v X^{*} u d x=\int_{\Omega} u X v d x \tag{2.18}
\end{equation*}
$$

where $X^{*} u=-X u-\operatorname{div}(X) u$. For simplicity, we assume that the given vector fields $X_{1}, \ldots, X_{m}$ are divergence-free, i.e. $\operatorname{div}\left(X_{i}\right)=0$. Hence, we have that $T_{1}, \ldots, T_{n}$ are also divergence-free, from the formula $\operatorname{div}\left(\left[X_{i}, X_{j}\right]\right)=X_{i}\left(\operatorname{div}\left(X_{j}\right)\right)-X_{j}\left(\operatorname{div}\left(X_{i}\right)\right)$. The general case is a perturbation by a lower order term and can be obtained with minor modification. Moreover, in particular, if the $X_{i}$ 's are left-invariant with respect to a Lie group then they are always divergence-free with respect to the Haar measure of the group which is the Lebesgue measure up to multiples. In more general cases if the vector fields are defined on a manifold and the adjoint defined with respect to a volume form, then with appropriate geometric conditions (e.g. metrics with certain curvature conditions or manifolds with Killing forms, contact forms, etc.) divergence-free frames can exist and it is possible to write the equation (1.2) with respect to such frames having structure conditions similar to (1.3). We refer to [4] for details.

Henceforth, we assume $X_{1}, \ldots, X_{m}$ are divergence-free, so that $X_{i}^{*}=-X_{i}$ and $T_{k}^{*}=-T_{k}$.
Remark 2.5 (The case of $\delta=0$ ). If apriori estimates are available for the case of $\delta>0$ and if the constants are independent of $\delta$, then the case $\delta=0$ follows as well by a standard regularization technique. A brief outline is as follows.

Let $A$ satisfy the structure condition (1.3) for the case $\delta=0$, i.e. for all $z, \xi \in \mathbb{R}^{m}$,

There are many ways to define a regularization. In particular, for any $0<\delta<1$, one can define

A_{\delta}(z)=\left(1-\eta_{\delta}(|z|)\right) A(z)+\eta_{\delta}(|z|)\left(\delta+|z|^{2}\right)^{\frac{p-2}{2}} z \tag{2.20}
\end{equation*}

where $\eta_{\delta} \in C^{0,1}([0, \infty))$ can be chosen (see [38]) such that $A_{\delta} \rightarrow A$ uniformly on compact subsets of $\mathbb{R}^{m}$ as $\delta \rightarrow 0^{+}$and the structure condition

\begin{gather*}
\frac{1}{L^{\prime}}\left(\delta+|z|^{2}\right)^{\frac{p-2}{2}}|\xi|^{2} \leq\left\langle D A_{\delta}(z) \xi, \xi\right\rangle \leq L^{\prime}\left(\delta+|z|^{2}\right)^{\frac{p-2}{2}}|\xi|^{2} ;  \tag{2.21}\\
\left|A_{\delta}(z)\right| \leq L^{\prime}|z|\left(\delta+|z|^{2}\right)^{\frac{p-2}{2}},
\end{gather*}
$$

holds for some $L^{\prime}=L^{\prime}(p, L)>1$. Given a weak solution $u \in \mathcal{S}^{1, p}(\Omega)$ of (1.2), we consider $u_{\delta}$ as the weak solution of the following regularized equation

\left\{\begin{array}{l}
\operatorname{div}_{H}\left(A_{\delta}\left(\mathfrak{X} u_{\delta}\right)\right)=0 \text { in } \Omega^{\prime} ;  \tag{2.22}\\
u_{\delta}-u \in \mathcal{S}_{0}^{1, p}\left(\Omega^{\prime}\right),
\end{array}\right.
$$

for any $\Omega^{\prime} \subset \subset \Omega$. Now, for the case of $\delta>0$ whenever we obtain uniform estimates for $\mathfrak{X} u_{\delta}$ (with constants independent of $\delta$ ), taking limit $\delta \rightarrow 0^{+}$, one can show that (1.5) and (1.7) also hold for the case of $\delta=0$.

Therefore, we shall assume $\delta>0$ without loss of generality, hereafter.

## 3. Apriori Estimates

In this section, we consider the equation

where $A: \mathbb{R}^{m} \rightarrow \mathbb{R}^{m}$ is a given $C^{1}$-function that satisfies the structure condition

\mathrm{F}(|z|)|\xi|^{2} \leq\langle D A(z) \xi, \xi\rangle \leq L \mathrm{~F}(|z|)|\xi|^{2} ;  \tag{3.2}\\
|A(z)| \leq L|z| \mathrm{F}(|z|),
\end{gather*}
$$

for every $z, \xi \in \mathbb{R}^{m}$, given $\mathrm{F}:[0, \infty) \rightarrow[0, \infty)$ and $L>1$. We assume F to be continuous in $(0, \infty)$ and there exists $\delta_{0}>0$ such that $\mathrm{F}(t) \geq \delta_{0}$ for all $t>0$.

Here onwards, we denote $u \in \mathcal{S}_{\text {loc }}^{1,2}(\Omega)$ as a weak solution of the equation (3.1). Furthermore, in this section we assume apriori that

$$
\begin{equation*}
\mathfrak{X} u \in \mathcal{S}_{\mathrm{loc}}^{1,2}\left(\Omega, \mathbb{R}^{m}\right), \quad T u \in \mathcal{S}_{\mathrm{loc}}^{1,2}\left(\Omega, \mathbb{R}^{n}\right) \cap L_{\mathrm{loc}}^{\infty}\left(\Omega, \mathbb{R}^{n}\right) . \tag{3.3}
\end{equation*}
$$

Thus, (3.3) implies $Y X_{j} u,\left[X_{i}, Y\right] u \in L_{\text {loc }}^{2}(\Omega)$ for any $i, j$, where $Y=X_{j}$ or $Y=T_{k}$. We only require the regularity (3.3) for the apriori estimates and the assumption shall be removed later by an approximation argument.
Lemma 3.1. Let $Y=X_{j}$ or $Y=T_{k}$. For every $\varphi \in C_{0}^{\infty}(\Omega)$, we have

& =-\sum_{i=1}^{m} \int_{\Omega} Y\left(A_{i}(\mathfrak{X} u)\right) X_{i} \varphi d x+\sum_{i=1}^{m} \int_{\Omega} A_{i}(\mathfrak{X} u)\left[X_{i}, Y\right] \varphi d x .
\end{align*}
$$

The proof is finished by using chain rule $Y\left(A_{i}(\mathfrak{X} u)\right)=\sum_{j=1}^{m} D_{j} A_{i}(\mathfrak{X} u) Y X_{j} u$ on (3.5).
Using $Y X_{j}=X_{j} Y-\left[X_{j}, Y\right]$ on (3.4), we have the following variant;

& +\sum_{i=1}^{m} \int_{\Omega} A_{i}(\mathfrak{X} u)\left[X_{i}, Y\right] \varphi d x
\end{align*}

for every $\varphi \in C_{0}^{\infty}(\Omega)$. Thus for $Y=X_{l}$, we have

\sum_{i, j} \int_{\Omega} D_{j} A_{i}(\mathfrak{X} u) X_{j} X_{l} u X_{i} \varphi d x= & \sum_{i, j} \int_{\Omega} D_{j} A_{i}(\mathfrak{X} u)\left[X_{j}, X_{l}\right] u X_{i} \varphi d x  \tag{3.7}\\
& +\sum_{i} \int_{\Omega} A_{i}(\mathfrak{X} u)\left[X_{i}, X_{l}\right] \varphi d x
\end{align*}
$$

and for $Y=T_{k}$, using integral by parts on the last term, we have

\begin{align*}
\sum_{i, j} \int_{\Omega} D_{j} A_{i}(\mathfrak{X} u) X_{j} T_{k} u X_{i} \varphi d x= & \sum_{i, j} \int_{\Omega} D_{j} A_{i}(\mathfrak{X} u)\left[X_{j}, T_{k}\right] u X_{i} \varphi d x \\
& -\sum_{i, j} \int_{\Omega} \varphi D_{j} A_{i}(\mathfrak{X} u)\left[X_{i}, T_{k}\right] X_{j} u d x . \tag{3.8}
\end{align*}
$$

3.1. Caccioppoli type inequalities. Here we provide Caccioppoli type estimates satisfied by the derivatives of a weak solution $u$ of equation (3.1).

Lemma 3.2. For any $\beta \geq 0$ and $\eta \in C_{0}^{\infty}(\Omega)$, there exists $c=c(N, L)>0$ such that

\int_{\Omega} \eta^{2} \mathrm{~F}(|\mathfrak{X} u|)|T u|^{\beta}|\mathfrak{X} T u|^{2} d x \leq & \frac{c}{\tau}(\beta+1)^{2} \int_{\Omega}\left(\eta^{2}+|\mathfrak{X} \eta|^{2}\right) \mathrm{F}(|\mathfrak{X} u|)|T u|^{\beta}\left(|\mathfrak{X} u|^{2}+|T u|^{2}\right) d x  \tag{3.9}\\
& +\tau \int_{\Omega} \eta^{2} \mathrm{~F}(|\mathfrak{X} u|)|T u|^{\beta}|\mathfrak{X X} u|^{2} d x
\end{align*}
$$

for any arbitrary $0<\tau<1$.
Proof. In (3.8), we choose $\varphi=\varphi_{k}=\eta^{2}|T u|^{\beta} T_{k} u$ on (3.8) and sum over $k \in\{1, \ldots, n\}$, to obtain the following,

& =-2 \sum_{i, j, k} \int_{\Omega} \eta|T u|^{\beta} T_{k} u D_{j} A_{i}(\mathfrak{X} u) X_{j} T_{k} u X_{i} \eta d x  \tag{3.10}\\
& \quad+\sum_{i, j, k} \int_{\Omega} D_{j} A_{i}(\mathfrak{X} u)\left[X_{j}, T_{k}\right] u X_{i} \varphi_{k} d x \\
& \quad+\sum_{i, j, k} \int_{\Omega} \varphi_{k} D_{j} A_{i}(\mathfrak{X} u)\left[X_{i}, T_{k}\right] X_{j} u d x \\
& = \\
& \quad R_{1}+R_{2}+R_{3} .
\end{align*}
$$

Then, we use the structure condition (3.2) to estimate both sides of (3.10). The left hand side of the above is estimated as

& \geq \int_{\Omega} \eta^{2} \mathrm{~F}(|\mathfrak{X} u|)|T u|^{\beta}|\mathfrak{X} T u|^{2} d x \tag{3.11}

We estimate the right hand side of (3.10), one by one.
Using (3.2) and Young's inequality, we have

Notice that

& +2 \sum_{i, j, k} \int_{\Omega} \eta D_{j} A_{i}(\mathfrak{X} u)\left[X_{j}, T_{k}\right] u|T u|^{\beta} T_{k} u X_{i} \eta d x=R_{2,1}+R_{2,2} . \tag{3.13}
\end{align*}

Using (3.2) and (2.2) followed by Young's inequality, we have

\leq & \varepsilon \int_{\Omega} \eta^{2} \mathrm{~F}(|\mathfrak{X u} u|)|T u|^{\beta}|\mathfrak{X T u}|^{2} d x  \tag{3.14}\\
& +\frac{c}{\varepsilon}(\beta+1)^{2} \int_{\Omega} \eta^{2} \mathrm{~F}(|\mathfrak{X} u|)|T u|^{\beta}\left(|\mathfrak{X} u|^{2}+|T u|^{2}\right) d x
\end{align*}
$$

Similarly, we have

\left|R_{2,2}\right| \leq c \int_{\Omega}|\eta| F(|\mathfrak{X} u|)|T u|^{\beta+1}(|\mathfrak{X} u|+|T u|)|\mathfrak{X} \eta| d x \tag{3.15}
\end{equation*}

which is clearly majorised by the right hand side of (3.9) from Young's inequality.
Then, $R_{3}$ is estimated using (3.2),(2.4) and Young's inequality on each term as

\leq & \varepsilon \int_{\Omega} \eta^{2} \mathrm{~F}(|\mathfrak{X} u|)|T u|^{\beta}|\mathfrak{X} T u|^{2} d x+c\left(\frac{1}{\varepsilon}+\frac{1}{\tau}\right) \int_{\Omega} \eta^{2} \mathrm{~F}(|\mathfrak{X} u|)|T u|^{\beta}\left(|\mathfrak{X} u|^{2}+|T u|^{2}\right) d x  \tag{3.16}\\
& \quad+\tau \int_{\Omega} \eta^{2} \mathrm{~F}(|\mathfrak{X} u|)|T u|^{\beta}|\mathfrak{X} \mathfrak{X} u|^{2} d x
\end{align*}
$$

for any $0<\tau<1$. Combining (3.12),(3.14),(3.15),(3.16) with $\varepsilon=1 / 6$, it is easy to obtain (3.9) and the proof is finished.

Remark 3.3. For the special case when $X_{1}, \ldots, X_{m}$ are left invariant with respect to a step 2 Carnot Group, we have $\left[X_{i}, T_{k}\right]=0$ and hence, it corresponds to the case of $\tau=0$ in (3.9), i.e.

Nevertheless, it does not make any difference in the subsequent results.
The following is the Caccioppoli type estimate of the vector fields.
Lemma 3.4. For any $\beta \geq 0$ and $\eta \in C_{0}^{\infty}(\Omega)$, there exists $c=c(N, L)>0$ such that

\int_{\Omega} \eta^{2} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\beta}|\mathfrak{X} \mathfrak{X} u|^{2} d x \leq & c \int_{\Omega}\left(|\mathfrak{X} \eta|^{2}+|\eta T \eta|\right) \mathrm{F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\beta+2} d x  \tag{3.17}\\
& +c(\beta+1)^{4} \int_{\Omega} \eta^{2} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\beta}\left(|\mathfrak{X} u|^{2}+|T u|^{2}\right) d x .
\end{align*}
$$

Proof. Let $\varphi_{l}=\eta^{2}|\mathfrak{X} u|^{\beta} X_{l} u$ with $\eta \in C_{0}^{\infty}(\Omega)$ and $\beta \geq 0$. Notice that

\leq & \frac{\varepsilon}{(\beta+1)^{2} K_{\eta}} \int_{\Omega} \eta^{\beta+4} \mathrm{~F}(|\mathfrak{X} u|)|T u|^{\beta}|\mathfrak{X} T u|^{2} d x  \tag{3.37}\\
& +\frac{c}{\varepsilon} \beta^{2}(\beta+1)^{2} K_{\eta} \int_{\Omega} \eta^{\beta} \mathrm{F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{2}|T u|^{\beta-2}|\mathfrak{X} u|^{2} d x .
\end{align*}
$$

Then, using (3.34) to estimate the first term similarly as before, it is easy to see that $I_{1,1,2}$ also satisfies the estimate of the claim (3.33).

For $I_{1,2}$, we similarly use (3.2), $\left|\left[X_{i}, X_{l}\right] u\right| \leq 2|\mathfrak{X} \mathfrak{X} u|$ and Young's inequality to obtain

& \leq c \varepsilon \int_{\Omega} \eta^{\beta+2} \mathrm{~F}(|\mathfrak{X} u|)|T u|^{\beta}|\mathfrak{X} \mathfrak{X} u|^{2} d x+\frac{c}{\varepsilon}(\beta+1)^{2} \int_{\Omega} \eta^{\beta}|\mathfrak{X} \eta|^{2} \mathrm{~F}(|\mathfrak{X} u|)|T u|^{\beta}|\mathfrak{X} u|^{2} d x .
\end{align*}
$$

Combining (3.36),(3.37) and (3.38), we conclude that the claim (3.33) holds for $I_{1}$.
Similarly, we estimate $I_{2}$ by structure condition (3.2) and Young's inequality to get

which is estimated exactly as $I_{1,1,2}$ and thus the claim (3.33) holds for $I_{2}$.
For $I_{3}$, we have by structure condition (3.2), that

\left|I_{3}\right| \leq c(\beta+1) \int_{\Omega} \eta^{\beta+1}|\mathfrak{X} \eta| \mathrm{F}(|\mathfrak{X} u|)|\mathfrak{X} u||T u|^{\beta}|\mathfrak{X} \mathfrak{X} u| d x
$$

which is estimated exactly as $I_{1,2}$ and thus the claim (3.33) holds for $I_{3}$ as well.

Finally, we note that

\begin{aligned}
I_{4}= & -\sum_{i, j, l} \int_{\Omega} \eta^{\beta+2}|T u|^{\beta} X_{l} u D_{j} A_{i}(\mathfrak{X} u) X_{j}\left[X_{i}, X_{l}\right] u d x \\
& +\sum_{i, j, l} \int_{\Omega} \eta^{\beta+2}|T u|^{\beta} X_{l} u D_{j} A_{i}(\mathfrak{X} u)\left[\left[X_{i}, X_{l}\right], X_{j}\right] u d x \\
= & I_{4,1}+I_{4,2}
\end{aligned}
$$

From (2.2) and (3.2), we find that

\left|I_{4,1}\right| \leq c \int_{\Omega} \eta^{\beta+2} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u||T u|^{\beta}|\mathfrak{X} T u| d x+c \int_{\Omega} \eta^{\beta+2} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u||T u|^{\beta}|\mathfrak{X X} u| d x \tag{3.39}
\end{equation*}
$$

which is estimated exactly as $I_{1,1,1}$. For $I_{4,2}$, we use (3.2) followed by (2.5) and (2.6) used successively to obtain

the first term of the above is estimated from (2.6) and the second term is exactly equal to the second term of (3.39). Thus, from (3.39) and (3.40) we conclude that the claim (3.33) holds for $I_{4}$ and the proof is finished.

Remark 3.6. It is not difficult to see that from the above proof, the case $\beta=0$ leads to

since all the terms containing $\beta|T u|^{\beta-1}$ in the proof vanish in the first steps of the estimates.
The following corollary is proved by using (2.6) and Hölder's inequality on Lemma 3.5.

Proof. The right hand side of (3.29) is estimated by Hölder's inequality as

\end{align*}

Then, using Young's inequality on (3.43) and combining with (3.29), the proof is finished.
Now, we can remove the error term in (3.17) and obtain the following apriori estimate. This shall be used to prove local Lipschitz regularity of weak solutions.

It is clear that we need to estimate only the last term of the right hand side of (3.45). We estimate it by Hölder's inequality and Young's inequality as

& \leq c(\beta+1)^{4}\left(\int_{\Omega} \eta^{\beta+2} \mathrm{~F}(|\mathfrak{X} u|)|T u|^{\beta+2} d x\right)^{\frac{2}{\beta+2}}\left(\int_{\operatorname{supp}(\eta)} \mathrm{F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\beta+2} d x\right)^{\frac{\beta}{\beta+2}}  \tag{3.46}\\
& \leq c h^{\frac{\beta+2}{2}} \int_{\Omega} \eta^{\beta+2} \mathrm{~F}(|\mathfrak{X} u|)|T u|^{\beta+2} d x+\frac{c}{h^{\frac{\beta+2}{\beta}}}(\beta+1)^{\frac{4(\beta+2)}{\beta}} \int_{\operatorname{supp}(\eta)} \mathrm{F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\beta+2} d x
\end{align*}
$$

for some $h>0$ to be chosen later. The first term of the right hand side of (3.46) is estimated using (2.6) and Corrollary 3.7 as

& \leq(c h)^{\frac{\beta+2}{2}}(\beta+1)^{2 \beta} K_{\eta}^{\beta / 2} \int_{\Omega} \eta^{2} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\beta}|\mathfrak{X X} u|^{2} d x
\end{align*}

Now, for a large enough $c=c(N, L)>0$ and small enough $\varepsilon>0$, we take

Then, it is not difficult to observe that (3.49) used in (3.46) followed by (3.46) used in (3.45) with the choice of $h$ in (3.48) for a small enough $\varepsilon=\varepsilon(N, L)>0$, leads to

The following corollaries would be essential for proving the $C^{1, \alpha}$-regularity of weak solutions.

Proof. Recalling the variant (3.34) of (3.9) of Lemma 3.2, we have

$\int_{\Omega} \eta^{\beta+2} \mathrm{~F}(|\mathfrak{X} u|)|T u|^{\beta}|\mathfrak{X} u|^{2} d x \leq\left(\int_{\Omega} \eta^{\beta+2} \mathrm{~F}(|\mathfrak{X} u|)|T u|^{\beta+2} d x\right)^{\frac{\beta}{\beta+2}}\left(\int_{\Omega} \eta^{\beta+2} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\beta+2} d x\right)^{\frac{2}{\beta+2}}$ and it is further estimated from (3.50). Combining all the estimates, the proof is finished.

Finally, we need the following Corrollary, which also relies on (3.42), (3.44) and (3.50).

&+\sum_{i, j, k} \int_{\Omega} D_{j} A_{i}(\mathfrak{X} u)\left[X_{j}, T_{k}\right] u X_{i} \varphi_{k} d x \\
&+\sum_{i, j, k} \int_{\Omega} \varphi_{k} D_{j} A_{i}(\mathfrak{X} u)\left[X_{i}, T_{k}\right] X_{j} u d x \\
&= L_{1}+L_{2}+L_{3}+L_{4} .
\end{align*}
$$

From the structure condition (3.2),

\text { LHS of }(3.53) & \geq \int_{\Omega} \eta^{\beta+4} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\beta}|\mathfrak{X} T u|^{2} d x+\beta \int_{\Omega} \eta^{\beta+4} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\beta}|\mathfrak{X}(|T u|)|^{2} d x  \tag{3.54}\\
& \geq \int_{\Omega} \eta^{\beta+4} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\beta}|\mathfrak{X} T u|^{2} d x .
\end{align*}

We estimate the right hand side of (3.53), one by one. We claim that for $i \in\{1,2,3,4\}$,

\end{equation*}

which, with a small enough $\varepsilon=\varepsilon(N, L)>0$, is enough to conclude the proof.

where the last term in the right hand side of (3.57) is estimated by Hölder's inequality as

& \quad \leq\left(\int_{\Omega} \eta^{2} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\beta}|\mathfrak{X X} u|^{2} d x\right)^{\frac{\beta-2}{\beta}}\left(\int_{\Omega} \eta^{\beta+2} \mathrm{~F}(|\mathfrak{X} u|)|T u|^{\beta}|\mathfrak{X X} u|^{2} d x\right)^{\frac{2}{\beta}} .
\end{aligned}

and the claim (3.55) follows from (3.42) and (3.44).

& -\beta \sum_{i, j, k} \int_{\Omega} \eta^{\beta+4}|\mathfrak{X} u|^{\beta-1} T_{k} u D_{j} A_{i}(\mathfrak{X} u)\left[X_{j}, T_{k}\right] u X_{i}(|\mathfrak{X} u|) d x
\end{align*}

\left|L_{3}\right| \leq & c \int_{\Omega} \eta^{\beta+4} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\beta}(|\mathfrak{X} u|+|T u|)|\mathfrak{X} T u| d x \\
& +c(\beta+1) \int_{\Omega}|\eta|^{\beta+3} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\beta}|T u|(|\mathfrak{X} u|+|T u|)|\mathfrak{X} \eta| d x \\
& +c \beta \int_{\Omega} \eta^{\beta+4} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\beta-1}|T u|(|\mathfrak{X} u|+|T u|)|\mathfrak{X} \mathfrak{X} u| d x
\end{aligned}
$$

and then, by Young's inequality on all the above terms, we have

$$
\begin{align*}
\left|L_{3}\right| & \leq \varepsilon \int_{\Omega} \eta^{\beta+4} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\beta}|\mathfrak{X} T u|^{2} d x \\
& +\frac{c}{\varepsilon}(\beta+1)^{2} \int_{\Omega} \eta^{\beta+2}\left(\eta^{2}+|\mathfrak{X} \eta|^{2}\right) \mathrm{F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\beta}\left(|\mathfrak{X} u|^{2}+|T u|^{2}\right) d x  \tag{3.59}\\
& +c \beta^{2} \int_{\Omega} \eta^{\beta+4} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\beta-2}|T u|^{2}|\mathfrak{X X} u|^{2} d x
\end{align*}
$$

which is estimated similarly as $L_{1}$ and $L_{2}$ in (3.56) and (3.57) above.
Finally, we note that

$$
L_{4}=\sum_{i, j, k} \int_{\Omega} \eta^{\beta+4}|\mathfrak{X} u|^{\beta} T_{k} u D_{j} A_{i}(\mathfrak{X} u)\left[X_{i}, T_{k}\right] X_{j} u d x
$$

which, by (3.2) and (2.4), leads to

\begin{equation*}
\left|L_{4}\right| \leq c \int_{\Omega} \eta^{\beta+4} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\beta}|T u|(|\mathfrak{X X} u|+|\mathfrak{X} T u|+|\mathfrak{X} u|+|T u|) d x \tag{3.60}
\end{equation*}
$$

which is a linear combination of the right hand sides of the estimates $L_{1}, L_{2}$ and $L_{3}$ of the above, and hence is estimated accordingly. Thus (3.55) holds for all $L_{i}$ 's and the proof is finished.

Remark 3.12. Similarly as in the case of (3.41), it is not hard to see that from the above proof, the case $\beta=0$ leads to

\end{equation*}

with $K_{\eta}=\|\eta\|_{L^{\infty}}^{2}+\|\mathfrak{X} \eta\|_{L^{\infty}}^{2}+\|\eta T \eta\|_{L^{\infty}}$, since all the terms containing $\beta|\mathfrak{X} u|^{\beta-1}$ vanish.

## 4. Local Lipschitz Continuity

In this section, we shall prove Theorem 1.1 using the Caccioppoli type estimate (3.44) obtained in Section 3 and an approximation argument. We shall fix $x_{0} \in \Omega$ and denote all CC-balls as $B_{r}=B_{r}\left(x_{0}\right)$ with dimension $Q=Q\left(x_{0}\right)$. Notice that whenever $\delta>0$, the function

satisfies all conditions in the begining of Section 3 for any $1<p<\infty$ and (3.2) is identical to the structure condition (1.3). The substitution (4.1) on the estimate (3.44) followed by the use of Sobolev inequality and Moser's iteration, gives us the estimate of Theorem 1.1 subject to the apriori assumption (3.3). The proof is standard, we provide a brief outline below.
Theorem 4.1. If $u \in \mathcal{S}_{\text {loc }}^{1,2}(\Omega)$ is a weak solution of equation (1.2) and (3.3) holds, then

\sup _{B_{\sigma r}}|\mathfrak{X} u| \leq \frac{c}{(1-\sigma)^{Q / p}}\left(f_{B_{r}}\left(\delta+|\mathfrak{X} u|^{2}\right)^{\frac{p}{2}} d x\right)^{\frac{1}{p}} \tag{4.2}
\end{equation*}
$$

holds for any $0<\sigma<1$, where $1<p<\infty, \delta>0$ and $c=c(N, p, L)>0$.
Proof. We rewrite the Caccioppoli type estimate (3.44) with the substitution (4.1) to have

\int_{\Omega} \eta^{2}\left(\delta+|\mathfrak{X} u|^{2}\right)^{\frac{p-2}{2}}|\mathfrak{X} u|^{\beta}|\mathfrak{X X} u|^{2} d x \leq c(\beta+1)^{12} K_{\eta} \int_{\operatorname{supp}(\eta)}\left(\delta+|\mathfrak{X} u|^{2}\right)^{\frac{p-2}{2}}|\mathfrak{X} u|^{\beta+2} d x \tag{4.3}
\end{equation*}
$$

for any $\beta \geq 2$, where $K_{\eta}=\|\eta\|_{L^{\infty}}^{2}+\|\mathfrak{X} \eta\|_{L^{\infty}}^{2}+\|\eta T \eta\|_{L^{\infty}}$. Letting $w=\left(\delta+|\mathfrak{X} u|^{2}\right)^{p / 2}$ and using a standard choice of test function $\eta \in C_{0}^{\infty}\left(B_{r}\right)$ such that $0 \leq \eta \leq 1$ and $\eta \equiv 1$ in $B_{r^{\prime}}$ for $0<r^{\prime}<r$, $|\mathfrak{X} \eta| \leq 4 /\left(r-r^{\prime}\right)$ and $|\mathfrak{X X} \eta| \leq 16 N /\left(r-r^{\prime}\right)^{2},(4.3)$ implies

\int_{B_{r^{\prime}}} w^{\gamma}|\mathfrak{X} w|^{2} d x \leq \frac{c(\gamma+1)^{12}}{\left(r-r^{\prime}\right)^{2}} \int_{B_{r}} w^{\gamma+2} d x \tag{4.4}
\end{equation*}
$$

for large enough $\gamma$. Using Sobolev's inequality (2.13) for $q=2$ on (4.4), we get that

\left(\int_{B_{r^{\prime}}} w^{(\gamma+2) \kappa} d x\right)^{\frac{1}{\kappa}} \leq \frac{c(\gamma+1)^{14}}{\left(r-r^{\prime}\right)^{2}} \int_{B_{r}} w^{\gamma+2} d x

where $\kappa=Q /(Q-2)$. Standard Moser's iteration is carried out by taking an appropriate sequence $\gamma_{i}$ and $r_{i}=\sigma r+(1-\sigma) r / 2^{i}$ on the above, then the standard interpolation argument [11, p. 299-300] leads to (4.2) and thereby completes the proof.
4.1. Riemannian Approximation. The sub-Riemannian metric generated by the vector fields $\left\{X_{1}, \ldots, X_{m}\right\}$ are approximated in the Gromov-Hausdorff sense via Riemannian approximation generated by $\left\{X_{1}^{\varepsilon}, \ldots, X_{m+n}^{\varepsilon}\right\}$, which is a relabelling of $\left\{X_{1}, \ldots, X_{m}, \varepsilon T_{1}, \ldots, \varepsilon T_{n}\right\}$, as $\varepsilon \rightarrow 0^{+}$ and generates the norm $|\cdot|_{\varepsilon}$ on $\mathbb{R}^{m+n}$. The second order vector fields remain $\left\{T_{1}^{\varepsilon}, \ldots, T_{n}^{\varepsilon}\right\}=$ $\left\{T_{1}, \ldots, T_{n}\right\}$. In other words, the approximate vector fields in consideration are

$$
\begin{equation*}
\left\{X_{1}^{\varepsilon}, \ldots, X_{m+n}^{\varepsilon}, T_{1}^{\varepsilon}, \ldots, T_{n}^{\varepsilon}\right\}=\left\{X_{1}, \ldots, X_{m}, \varepsilon T_{1}, \ldots, \varepsilon T_{n}, T_{1}, \ldots, T_{n}\right\} \tag{4.5}
\end{equation*}
$$

which is exactly the step 2 case of the approximations provided in $[5,3]$. The idea is to be able to carry out everything above with $X_{j}^{\varepsilon}$ and $T_{k}^{\varepsilon}$ in place of $X_{j}$ and $T_{k}$. The reason for the relabelling (4.5) is that the equation with respect to $X_{j}^{\varepsilon}$ 's become automatically elliptic since $\left\{X_{1}, \ldots, X_{m}, T_{1}, \ldots, T_{n}\right\}$ spans the tangent space and hence, we can assume as much apriori regularity as needed. Then the conclusion shall follow with the limit $\varepsilon \rightarrow 0^{+}$provided that all constants do not blow up. We briefly illustrate in the following that this indeed is the case when the set up of the begining of Section 2 is re-written in terms of the approximation (4.5).

We denote the approximation gradients as

\mathfrak{X}^{\varepsilon} u=\left(X_{1}^{\varepsilon} u, \ldots, X_{m+n}^{\varepsilon} u\right)=\left(X_{1} u, \ldots, X_{m} u, \varepsilon T_{1} u, \ldots, \varepsilon T_{n} u\right), \quad \text { and } \quad T^{\varepsilon} u=T u
$$

and $\operatorname{div}_{H}^{\varepsilon}$ is similarly defined. Hence, $\mathfrak{X}^{\varepsilon} u \rightarrow(\mathfrak{X} u, 0)$ and $\left|\mathfrak{X}^{\varepsilon} u\right|_{\varepsilon}^{2}=|\mathfrak{X} u|^{2}+\varepsilon^{2}|T u|^{2} \rightarrow|\mathfrak{X} u|^{2}$ as $\varepsilon \rightarrow 0^{+}$. Given $A: \mathbb{R}^{m} \rightarrow \mathbb{R}^{m}$ that satisfies (1.3), one can define $A_{\varepsilon}: \mathbb{R}^{m+n} \rightarrow \mathbb{R}^{m+n}$ as

A_{\varepsilon}(\bar{z})=\left(1-\eta_{\varepsilon}\left(|\bar{z}|_{\varepsilon}\right)\right) \tilde{A}(\bar{z})+\eta_{\varepsilon}\left(|\bar{z}|_{\varepsilon}\right)\left(\delta+|\bar{z}|_{\varepsilon}^{2}\right)^{\frac{p-2}{2}} \bar{z} \tag{4.6}
\end{equation*}
$$

similarly as (2.20) for any $0<\varepsilon<1$, where $\tilde{A}(\bar{z})=(A(z), 0)$ for any $\bar{z}=\left(z, z^{\prime}\right) \in \mathbb{R}^{m+n}$ and $\eta_{\varepsilon} \in C^{0,1}([0, \infty))$ can be chosen (see $\left.[38]\right)$ such that $A_{\varepsilon} \rightarrow A$ uniformly on compact subsets as $\varepsilon \rightarrow 0^{+}$and the structure condition

$$
\begin{gather*}
\frac{1}{L^{\prime}}\left(\delta+|\bar{z}|_{\varepsilon}^{2}\right)^{\frac{p-2}{2}}|\xi|^{2} \leq\left\langle D A_{\varepsilon}(\bar{z}) \xi, \xi\right\rangle \leq L^{\prime}\left(\delta+|\bar{z}|_{\varepsilon}^{2}\right)^{\frac{p-2}{2}}|\xi|^{2}  \tag{4.7}\\
\left|A_{\varepsilon}(\bar{z})\right| \leq L^{\prime}|\bar{z}|_{\varepsilon}\left(\delta+|\bar{z}|_{\varepsilon}^{2}\right)^{\frac{p-2}{2}}
\end{gather*}
$$

holds for any $\bar{z}, \xi \in \mathbb{R}^{m+n}$, for some $L^{\prime}=L^{\prime}(p, L)>1$. Since (4.7) ensures that the equation $\operatorname{div}_{H}^{\varepsilon}\left(A_{\varepsilon}\left(\mathfrak{X}^{\varepsilon} u\right)\right)=0$ is uniformly elliptic on $\Omega$, hence it has all necessary regularities including (3.3). As an example we see that

\operatorname{div}_{H}^{\varepsilon}\left(\left(\delta+\left|\mathfrak{X}^{\varepsilon} u\right|_{\varepsilon}^{2}\right)^{\frac{p-2}{2}} \mathfrak{X}^{\varepsilon} u\right)=0 \quad \text { in } \Omega \tag{4.8}
\end{equation*}
$$

is a natural regularization of the sub-elliptic $p$-Laplacian (1.4).
From the step 2 hypothesis (2.1), note that $\left\{X_{1}, \ldots, X_{m}, T_{1}, \ldots, T_{n}\right\}$ spans the tangent space automatically implies $\left\{X_{1}, \ldots, X_{m},(1+\varepsilon) T_{1}, \ldots,(1+\varepsilon) T_{n}\right\}$ spans the tangent space for any $0 \leq \varepsilon \leq 1$ and therefore, any vector field can be written as linear combinations of $\left\{X_{1}^{\varepsilon}, \ldots, X_{m}^{\varepsilon}, T_{1}^{\varepsilon}, \ldots, T_{n}^{\varepsilon}\right\}$ with bounded coefficients; in particular the commutators $\left[X_{i}^{\varepsilon}, X_{j}^{\varepsilon}\right]$ and $\left[X_{i}^{\varepsilon}, T_{j}^{\varepsilon}\right]$ satisfy commutation relations similar to (2.2) with uniformly bounded coefficients as in (2.3) independent of $\varepsilon$. Hence, all constants in the following inequalities are independent of $\varepsilon$ as well. But establishing sub-elliptic metrics similarly as in Section 2 is non-trivial. Indeed, we have to similarly define

$$
\left\{Y_{1}^{\varepsilon}, \ldots, Y_{m+2 n}^{\varepsilon}\right\}=\left\{X_{1}^{\varepsilon}, \ldots, X_{m+n}^{\varepsilon}, T_{1}^{\varepsilon}, \ldots, T_{n}^{\varepsilon}\right\}
$$

and define an approximate degree $d_{j}^{\varepsilon}=\operatorname{deg}^{\varepsilon}\left(Y_{j}^{\varepsilon}\right) \in\{1,2\}$ so that $\operatorname{deg}^{\varepsilon}\left(X_{j}^{\varepsilon}\right)=1$ and $\operatorname{deg}^{\varepsilon}\left(T_{j}^{\varepsilon}\right)=2$ (as $\varepsilon \rightarrow 0^{+}$it is easy to see that $\operatorname{deg}^{\varepsilon} \rightarrow$ deg with deg as defined earlier in Section 2). As before, $Y_{1}^{\varepsilon}, \ldots, Y_{m+2 n}^{\varepsilon}$ span the whole tangent space and $\left[Y_{j}^{\varepsilon}, Y_{k}^{\varepsilon}\right] \in \operatorname{span}\left\{Y_{l}^{\varepsilon}: d_{l}^{\varepsilon} \leq d_{j}^{\varepsilon}+d_{k}^{\varepsilon}\right\}$ and we are in the set up of Nagel-Stein-Wainger [41]. However, when we have

$$
\left[Y_{j}^{\varepsilon}, Y_{k}^{\varepsilon}\right]=\sum_{d_{l}^{\varepsilon} \leq d_{j}^{\varepsilon}+d_{k}^{\varepsilon}} c_{j, k}^{l}(\varepsilon) Y_{l}^{\varepsilon}
$$

the coefficients $c_{j, k}^{l}(\varepsilon)$ will be unbounded as $\varepsilon \rightarrow 0^{+}$. In principle this could be a problem as the doubling constant for the metric balls in [41] depends on these coefficients. In other words, letting $d^{\varepsilon}(I)$ defined with respect to $d_{j}^{\varepsilon}$ 's and $\Lambda^{\varepsilon}(x, r)=\sum_{I}\left|\lambda_{I}^{\varepsilon}(x)\right| r^{d^{\varepsilon}(I)}$ where $\lambda_{I}^{\varepsilon}(x)=\operatorname{det}\left(a_{j, k}^{\varepsilon}(x)\right)$ whenever $Y_{i_{j}}^{\varepsilon}=\sum_{k} a_{j, k}^{\varepsilon} \partial_{x_{k}}$ as earlier, there exists $c_{2}(\varepsilon)>c_{1}(\varepsilon)>0$ such that we have

$$
c_{1}(\varepsilon) \Lambda^{\varepsilon}(x, r) \leq\left|B_{r}^{\varepsilon}(x)\right| \leq c_{2}(\varepsilon) \Lambda^{\varepsilon}(x, r)
$$

due to [41], where $B_{r}^{\varepsilon} \subset \Omega$ are the metric balls defined similarly as in Section 2. Nevertheless, it has been shown by Capogna-Citti-Rea [5, Proposition 4.4] (see also [3]) that there exists $0<\bar{\varepsilon}<1$ such that for every $0<\varepsilon<\bar{\varepsilon}$, the constants $c_{1}(\varepsilon)$ and $c_{2}(\varepsilon)$ may be chosen to be independent of $\varepsilon$ in compact subsets of $\Omega$. The argument involves a very delicate use of exponentiation of sub-families of the vector fields depending on $\varepsilon<r$ or $r<\varepsilon<\bar{\varepsilon}$.

Combining all the above statements, we can conclude that the approximate vector fields (4.5) has all the required properties to carry out the estimates of Section 3 for the equation $\operatorname{div}_{H}^{\varepsilon}\left(A_{\varepsilon}\left(\mathfrak{X}^{\varepsilon} u\right)\right)=0$ and the constants are independent of $\varepsilon$. The constants of Poincaré and Sobolev inequalities are also stable under $\varepsilon \rightarrow 0$, we refer to [3]. Hence, we conclude from Theorem 4.1 that

\sup _{B_{\sigma r}^{\varepsilon}}\left|\mathfrak{X}^{\varepsilon} u\right|_{\varepsilon} \leq \frac{c(N, p, L)}{(1-\sigma)^{Q / p}}\left(f_{B_{r}^{\varepsilon}}\left(\delta+\left|\mathfrak{X}^{\varepsilon} u\right|_{\varepsilon}^{2}\right)^{\frac{p}{2}} d x\right)^{\frac{1}{p}} \tag{4.9}
\end{equation*}
$$

holds for any $0<\sigma<1$. It is known that $B_{r}^{\varepsilon} \rightarrow B_{r}$ in terms of Hausdorff distance as $\varepsilon \rightarrow 0^{+}$, where $B_{r} \subseteq \Omega$ is the concentric CC-ball (see [25]). This shall be used in the following.
4.2. Proof of Theorem 1.1. We are ready to prove Theorem 1.1 by a standard approximation argument and similar as in the Euclidean setting, that incorporates the approximation in order to remove the apriori regularity (3.3).
Proof of Theorem 1.1. Let $B_{r}=B_{r}\left(x_{0}\right) \subset \Omega$ be fixed and $B_{r}^{\varepsilon}$ be a sequence of metric balls with limit $B_{r}$ as the Hausdorfff distance limit. We shall denote similarly also for concentric balls of smaller radii. Given $u \in \mathcal{S}^{1, p}(\Omega)$ as a weak solution of (1.2), there exists a smooth approximation $\phi_{k} \in C^{\infty}\left(B_{r}\right)$ such that $\phi_{k} \rightarrow u$ in $\mathcal{S}^{1, p}\left(B_{r}\right)$ as $k \rightarrow \infty$. Now, let $u_{k}^{\varepsilon}$ be the weak solution of the following Dirichlet problem,

\begin{cases}\operatorname{div}_{H}^{\varepsilon}\left(A_{\varepsilon}\left(\mathfrak{X}^{\varepsilon} u_{k}^{\varepsilon}\right)\right)=0 & \text { in } B_{\theta r}^{\varepsilon}  \tag{4.10}\\ u_{k}^{\varepsilon}-\phi_{k} \in \mathcal{S}_{0}^{1, p}\left(B_{\theta r}^{\varepsilon}\right)\end{cases}
$$

for some $\theta=\theta(N)<1$. The choice of test function $u_{k}^{\varepsilon}-\phi_{k}$ on (4.10), yields

\int_{B_{\theta r}^{\varepsilon}}\left\langle A_{\varepsilon}\left(\mathfrak{X}^{\varepsilon} u_{k}^{\varepsilon}\right), \mathfrak{X}^{\varepsilon} u_{k}^{\varepsilon}\right\rangle d x=\int_{B_{\theta r}^{\varepsilon}}\left\langle A_{\varepsilon}\left(\mathfrak{X}^{\varepsilon} u_{k}^{\varepsilon}\right), \mathfrak{X}^{\varepsilon} \phi_{k}\right\rangle d x \tag{4.11}
\end{equation*}
$$

In this case, we have an ellipticity condition similar to (2.15), which together with the structure condition (4.7) leads to

\begin{align*}
\int_{B_{\theta r}^{\varepsilon}}\left(\delta+\left|\mathfrak{X}^{\varepsilon} u_{k}^{\varepsilon}\right|_{\varepsilon}^{2}\right)^{\frac{p}{2}} d x & \leq c \int_{B_{\theta r}^{\varepsilon}}\left(\delta+\left|\mathfrak{X}^{\varepsilon} \phi_{k}\right|_{\varepsilon}^{2}\right)^{\frac{p}{2}} d x \leq c \int_{B_{\theta r}}\left(\delta+\left|\mathfrak{X} \phi_{k}\right|^{2}\right)^{\frac{p}{2}} d x+o(\varepsilon) \\
& \leq c \int_{B_{\theta r}}\left(\delta+|\mathfrak{X} u|^{2}\right)^{\frac{p}{2}} d x+o(\varepsilon)+o(1 / k) \tag{4.12}
\end{align*}
$$

for $c=c(N, p, L)>0$ and $o(\varepsilon), o(1 / k) \rightarrow 0$ as $\varepsilon \rightarrow 0^{+}$and $k \rightarrow \infty$. Now, from (4.9), we have

\sup _{B_{\sigma \theta r}^{\varepsilon}}\left|\mathfrak{X}^{\varepsilon} u_{k}^{\varepsilon}\right|_{\varepsilon} \leq \frac{c}{(1-\sigma)^{Q / p}}\left(f_{B_{\theta r}^{\varepsilon}}\left(\delta+\left|\mathfrak{X}^{\varepsilon} u_{k}^{\varepsilon}\right|_{\varepsilon}^{2}\right)^{\frac{p}{2}} d x\right)^{\frac{1}{p}} \tag{4.13}
\end{equation*}
$$

for some $c=c(N, p, L)>0, \sigma \in(0,1)$. Then a standard argument follows, since (4.12) ensures that there exists $u^{\prime} \in \mathcal{S}^{1, p}\left(B_{\theta r}\right)$ such that up to a subsequence $u_{k}^{\varepsilon} \rightharpoonup u^{\prime}$. As $u_{k}^{\varepsilon}-\phi_{k} \in \mathcal{S}_{0}^{1, p}\left(B_{\theta r}^{\varepsilon}\right)$,
hence we have $u^{\prime}-u \in \mathcal{S}_{0}^{1, p}\left(B_{\theta r}\right)$. We have a monotonicity inequality similar to (2.16), using that one can show that $u^{\prime}$ is a weak solution of (1.2). From uniqueness, $u^{\prime}=u$. Taking $\varepsilon \rightarrow 0^{+}$ and $k \rightarrow \infty$ along the convergent subsequence in (4.13) and (4.12), we conclude

\sup _{B_{\sigma \theta r}}|\mathfrak{X} u| \leq \frac{c}{(1-\sigma)^{Q / p}}\left(f_{B_{r}}\left(\delta+|\mathfrak{X} u|^{2}\right)^{\frac{p}{2}} d x\right)^{\frac{1}{p}}
$$

for some $c=c(N, p, L)>0$ and (1.5) follows from the above by a simple covering argument. This, together with Remark 2.5, concludes the proof.

## 5. The local $C^{1, \alpha}$ Regularity

Throughout this section, we denote $u \in \mathcal{S}^{1, p}(\Omega)$ as a weak solution of equation (1.2) satisfying the structure condition (1.3) with $\delta>0$. Equipped with Theorem 1.1, we have $\mathfrak{X} u \in L_{\text {loc }}^{\infty}\left(\Omega, \mathbb{R}^{m}\right)$, which together with $\delta>0$, implies that

|A(\mathfrak{X} u)| \leq \nu|\mathfrak{X} u| \tag{5.1}
\end{gather*}
$$

holds locally in $\Omega$, for some $\nu=\nu\left(N, p, L,\|\mathfrak{X} u\|_{L^{\infty}}, \delta\right)>0$. The equation $\operatorname{div}_{H}(A(\mathfrak{X} u))=0$ with condition (5.1), has been considered by Domokos-Manfredi [15] (and previously by Capogna [2] for the case of the vector fields $X_{1}, \ldots, X_{m}$ being left invariant with respect to the Heisenberg Group). From [15, Theorem 5.2], we have that

\mathfrak{X} u \in \mathcal{S}_{\mathrm{loc}}^{1,2}\left(\Omega, \mathbb{R}^{m}\right) \cap C_{\mathrm{loc}}^{0, \alpha}\left(\Omega, \mathbb{R}^{m}\right), \quad T u \in \mathcal{S}_{\mathrm{loc}}^{1,2}\left(\Omega, \mathbb{R}^{n}\right) \cap C_{\mathrm{loc}}^{0, \alpha}\left(\Omega, \mathbb{R}^{n}\right) \tag{5.2}
\end{equation*}
$$

which is, in fact, stronger than (3.3). Also, we resume the notation (4.1), i.e. $\mathrm{F}(t)=\left(\delta+t^{2}\right)^{\frac{p-2}{2}}$ throughout this section and therefore all lemmas and apriori estimates of Section 3 are also valid in the settings of this section. The local boundedness of $\mathfrak{X} u$ allows us to define

\mu_{i}(r)=\sup _{B_{r}}\left|X_{i} u\right|, \quad \mu(r)=\max _{1 \leq i \leq m} \mu_{i}(r) \tag{5.3}
\end{equation*}
$$

for any ball $B_{r} \subset \Omega$ and $i \in\{1, \ldots, m\}$.
Note that the function $h(t)=\left(\delta+t^{2}\right)^{\frac{p-2}{2}} t^{q}=\mathrm{F}(t) t^{q}$ is non-decreasing on $[0, \infty)$ whenever $q \geq 0$ and $p+q-2 \geq 0$ and hence, we have the inequality

\mathrm{F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{q}=\left(\delta+|\mathfrak{X} u|^{2}\right)^{\frac{p-2}{2}}|\mathfrak{X} u|^{q} \leq c(m, p, q)\left(\delta+\mu(r)^{2}\right)^{\frac{p-2}{2}} \mu(r)^{q} \quad \text { in } B_{r} \tag{5.4}
\end{equation*}
$$

where $c(m, p, q)=m^{(q+p-2) / 2}$ if $p \geq 2$ and $c(m, p, q)=m^{q / 2}$ if $1<p<2$. Inequalities of the type (5.4) shall be used multiple times in the local estimates.

Similarly as [39], we fix any $l \in\{1, \ldots, m\}$ and consider the following double truncation

In the setting of Euclidean spaces, similar truncations have been used previously in [45, 33], etc. The main property of $v$ that is used in the integral estimates is the fact that it avoids any possible singularities within the set

as easily seen from the following inequality

which shall be used several times throughout this section. Furthermore, note that

-\mathfrak{X} X_{l} u & \text { a.e. in } E ;  \tag{5.8}\\
0 & \text { a.e. in } \Omega \backslash E,
\end{array} \quad \text { and } \quad T v= \begin{cases}-T X_{l} u & \text { a.e. in } E \\
0 & \text { a.e. in } \Omega \backslash E,\end{cases}\right.
$$

which shall be exploited in the following integral estimates. The technique of involving the truncation in the Caccioppoli type estimates is useful particularly for the singular case $1<p<2$, whereas the required estimates can be obtained in easier ways for the case $p \geq 2$.

Finally, we remark that properties similar to the above also holds corresponding to

\end{equation*}

and all following estimates invovling $v$ shall also hold for $v^{\prime}$. Henceforth, we shall only be using the truncation $v$ without loss of generality.
5.1. Caccioppoli type inequalities with truncation. We prove certain integral estimates of the gradient by testing (3.4) with the truncation $v$ being incorporated in the test function. Due to (5.7), these will eventually lead to an estimate similar to that of a uniformly elliptic equation without the singular weight.

The following lemma is a truncated analogue of Lemma 3.4. The proof follows along the direction of [39, Lemma 3.1] but it is lengthier due to the commutation relations (2.2).
Lemma 5.1. For any $\beta, \kappa \geq 0$ and all non-negative $\eta \in C_{0}^{\infty}(\Omega)$, we have that

&+c(\beta+1)^{2}(\kappa+1)^{2} \int_{\Omega} \eta^{\beta+2} v^{\beta} \mathrm{F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\kappa+2}|\mathfrak{X} v|^{2} d x  \tag{5.10}\\
&+c(\kappa+1)^{4} \int_{\Omega} \eta^{\beta+2} v^{\beta+2} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\kappa}\left(|T u|^{2}+|\mathfrak{X} u|^{2}\right) d x
\end{align*}
$$

where $v$ is as in (5.5) and $c=c(N, p, L)>0$.
Proof. For any $k \in\{1, \ldots, m\}$, we take $Y=X_{k}$ in (3.6) to have

& +\sum_{i} \int_{\Omega} A_{i}(\mathfrak{X} u)\left[X_{i}, X_{k}\right] \varphi d x
\end{align*}

and then, we choose $\varphi=\eta^{\beta+2} v^{\beta+2}|\mathfrak{X} u|^{\kappa} X_{k} u$ with a non-negative test function $\eta \in C_{0}^{\infty}(\Omega)$ and $\beta, \kappa \geq 0$ on (5.11) to obtain

= & -(\beta+2) \int_{\Omega} \sum_{i, j} \eta^{\beta+1} v^{\beta+2}|\mathfrak{X} u|^{\kappa} X_{k} u D_{j} A_{i}(\mathfrak{X} u) X_{j} X_{k} u X_{i} \eta d x \\
& -(\beta+2) \int_{\Omega} \sum_{i, j} \eta^{\beta+2} v^{\beta+1}|\mathfrak{X} u|^{\kappa} X_{k} u D_{j} A_{i}(\mathfrak{X} u) X_{j} X_{k} u X_{i} v d x  \tag{5.12}\\
& +\sum_{i, j} \int_{\Omega} D_{j} A_{i}(\mathfrak{X} u)\left[X_{j}, X_{k}\right] u X_{i}\left(\eta^{\beta+2} v^{\beta+2}|\mathfrak{X} u|^{\kappa} X_{k} u\right) d x \\
& -\sum_{i} \int_{\Omega}\left[X_{i}, X_{k}\right]\left(A_{i}(\mathfrak{X} u)\right) \eta^{\beta+2} v^{\beta+2}|\mathfrak{X} u|^{\kappa} X_{k} u d x \\
= & I_{1}^{k}+I_{2}^{k}+I_{3}^{k}+I_{4}^{k},
\end{align*}
$$

where integral by parts is applied to the last item in (5.11). Then, by taking summation over $k \in\{1, \ldots, m\}$, we end up with

where $I_{j}^{k}$ 's are the respective terms of the right hand side of (5.12).
In the following, we estimate both sides of (5.13). For the left hand of (5.13), first note that $X_{i}\left(|\mathfrak{X} u|^{\kappa} X_{k} u\right)=|\mathfrak{X} u|^{\kappa} X_{i} X_{k} u+X_{i}\left(|\mathfrak{X} u|^{\kappa}\right) X_{k} u$, hence by the structure condition (1.3), we have

To estimate the right hand side of (5.13), we shall show that $I_{j}^{k}$ satisfies

& +\frac{c}{\varepsilon}(\beta+1)^{2} \int_{\Omega} \eta^{\beta}\left(|\mathfrak{X} \eta|^{2}+\eta|\mathcal{T} \eta|\right) v^{\beta+2} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\kappa+2} d x \\
& +\frac{c}{\varepsilon}(\beta+1)^{2}(\kappa+1)^{2} \int_{\Omega} \eta^{\beta+2} v^{\beta} \mathrm{F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\kappa+2}|\mathfrak{X} v|^{2} d x  \tag{5.15}\\
& +\frac{c}{\varepsilon}(\kappa+1)^{4} \int_{\Omega} \eta^{\beta+2} v^{\beta+2} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\kappa}\left(|T u|^{2}+|\mathfrak{X} u|^{2}\right) d x
\end{align*}
$$

for each $k \in\{1, \ldots, m\}$ and each $j=1,2,3,4$, where $c=c(N, p, L)>0$ and $0<\varepsilon<1$ is small enough. Then (5.10) follows from the above estimates (5.14) and (5.15) for both sides of (5.13). Thus the proof of the lemma is finished, modulo the proof of (5.15). In the rest, we prove (5.15) in the order of $j=1,2,3,4$.

First, for $j=1$, by the structure condition (1.3) and Young's inequality that

& +\frac{c}{\varepsilon}(\beta+1)^{2} \int_{\Omega} \eta^{\beta}|\mathfrak{X} \eta|^{2} v^{\beta+2} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\kappa+2} d x .
\end{align*}

Thus (5.15) holds for $I_{1}^{k}$.
Second, when $j=2$, by the structure condition (1.3) and Young's inequality,

\leq & c \varepsilon \int_{\Omega} \eta^{\beta+2} v^{\beta+2} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\kappa}|\mathfrak{X} \mathfrak{X} u|^{2} d x  \tag{5.17}\\
& +\frac{c}{\varepsilon}(\beta+1)^{2} \int_{\Omega} \eta^{\beta+2} v^{\beta} \mathrm{F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\kappa+2}|\mathfrak{X} v|^{2} d x,
\end{align*}
$$

which proves (5.15) for $I_{2}^{k}$.

Third, when $j=3$, we note that

\end{aligned}

Thus by the structure condition (1.3) and (2.2), we have

& +c(\beta+1) \int_{\Omega} \eta^{\beta+1}|\mathfrak{X} \eta| v^{\beta+2} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\kappa+1}(|T u|+|\mathfrak{X} u|) d x \\
& +c(\beta+1) \int_{\Omega} \eta^{\beta+2} v^{\beta+1} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\kappa+1}|\mathfrak{X} v|(|T u|+|\mathfrak{X} u|) d x
\end{aligned}
$$

from which, by Young's inequality on each term, we get

& +c(\beta+1)^{2} \int_{\Omega} \eta^{\beta}|\mathfrak{X} \eta|^{2} v^{\beta+2} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\kappa+2} d x  \tag{5.18}\\
& +c(\beta+1)^{2} \int_{\Omega} \eta^{\beta+2} v^{\beta} \mathrm{F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\kappa+2}|\mathfrak{X} v|^{2} d x .

This proves (5.15) for $I_{3}^{k}$.
Finally, we are left with the case $j=4$ and the estimate is more involved. Recalling our choice of test function $\varphi=\eta^{\beta+2} v^{\beta+2}|\mathfrak{X} u|^{\kappa} X_{k} u$, we note that

& =\sum_{i} \int_{\Omega}\left(X_{k}\left(A_{i}(\mathfrak{X} u)\right) X_{i} \varphi-X_{i}\left(A_{i}(\mathfrak{X} u)\right) X_{k} \varphi\right) d x
\end{align*}
$$

where integration by parts is used to get the last term of the above. Let us denote

where we denote the first and the second integral in the right hand side of the above by $R^{k}$ and $P^{k}$, respectively. We shall estimate both of them one by one. First, by the structure condition
(1.3), the definition of $w$ as in (5.20), and Young's inequality, we have

& +\frac{c}{\varepsilon}(\beta+1)^{2} \int_{\Omega} \eta^{\beta+2} v^{\beta} \mathrm{F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\kappa+2}|\mathfrak{X} v|^{2} d x .
\end{align*}

To estimate $P^{k}$, we use integration by parts again to get

= & P_{1}^{k}+P_{2}^{k}
\end{align*}

For $P_{1}^{k}$, we have by the structure condition (1.3) that

& +c(\beta+1)^{2} \int_{\Omega} \eta^{\beta+1} v^{\beta+1} \mathrm{~F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\kappa+2}|\mathfrak{X} v||\mathfrak{X} \eta| d x
\end{aligned}
$$

from which it follows by Young's inequality that

& +\frac{c}{\varepsilon}(\beta+1)^{2}(\kappa+1)^{2} \int_{\Omega} \eta^{\beta+2} v^{\beta} \mathrm{F}(|\mathfrak{X} u|)|\mathfrak{X} u|^{\kappa+2}|\mathfrak{X} v|^{2} d x  \tag{5.24}\\

Remark 5.3. For the special case when $X_{1}, \ldots, X_{m}$ are left invariant with respect to a step 2 Carnot Group, since we have $\left[X_{i}, T_{k}\right]=0$, hence it corresponds to the case of $c_{0}=0$ for (5.31). However, it does not make any difference because of the following corollary.

5.2. The main Lemma. We are ready to prove the main lemma for the proof of the $C^{1, \alpha}$ regularity. This is a Caccioppoli type estimate of the truncation that is devoid of the weight $\mathrm{F}(|\mathfrak{X} u|)=\left(\delta+|\mathfrak{X} u|^{2}\right)^{\frac{p-2}{2}}$ which is similar to estimates for equations with uniform ellipticity.

Towards this, we fix $B_{r} \subset \Omega$ and use a standard test function $\eta \in C_{0}^{\infty}\left(B_{r}\right)$ that satisfies

The following is the main lemma of this section, which has been proved previously in [39] for the special case when $X_{1}, \ldots, X_{m}$ are left invariant with respect to the Heisenberg Group. In the Euclidean case, similar estimates have been proved earlier, see [45, 33], etc.

Recall that $v=\min \left(\mu(r) / 8, \max \left(\mu(r) / 4-X_{l} u, 0\right)\right)$ as in (5.5), for some fixed $l \in\{1, \ldots, m\}$. For this $l$, we test (3.7) with the function $\varphi=\eta^{\beta+4} v^{\beta+3}$ for $\beta \geq 0$ and $\eta \in C_{0}^{\infty}\left(B_{r}\right)$ as given, which is allowed since it follows from (5.2) and (5.8) that $\mathfrak{X} v \in L_{\mathrm{loc}}^{2}\left(\Omega ; \mathbb{R}^{m}\right)$ and $T v \in L_{\mathrm{loc}}^{2}\left(\Omega ; \mathbb{R}^{n}\right)$. & \times\left(\int_{\Omega} \eta^{q} \mathrm{~F}(|\mathfrak{X} u|)\left(|T u|^{q}+|\mathfrak{X} u|^{q}\right) d x\right)^{\frac{1}{q}}
\end{align*}

where $q=2 \gamma /(\gamma-1)$. The fact that the first two integrals are on $E$ is crucial as (5.7) can be exploited to carry out the following estimates,

Note that $M, \bar{M}$ and $M_{0}$ are the same terms as defined in the proof of Lemma 5.2, with $\tau=2-\gamma$ when $1<\gamma<3 / 2$. Then, $M$ is estimated by Lemma 5.2 and Corollary 5.4, $M^{\prime}+\bar{M}+M_{0}$ is estimated by Hölder's inequality exactly as in (5.56) in the proof of Corollary 5.4 (to estimate the term corresponding to $M^{\prime}$, Lemma 5.1 and (3.44) are further used) and hence, we have

The following corollary follows from Lemma 5.5 by using Sobolev's inequality (2.13) on (5.58) and carrying out Moser's iteration. We refer to [39, Corollary 3.5] for the proof. In the Euclidean setting, similar statements have been proved earlier in [10, 45], etc.

5.3. De Giorgi's method. It is evident that, equipped with Lemma 5.5 and Corollary 5.6, the problem is reduced to the case for that of a uniformly elliptic equation where the Hölder continuity of the gradient has been shown in the fundamental work of De Giorgi [9]. The techniques have been adopted for degenerated equations for the Euclidean case in [31, 18, 10, 45], etc. and for the case of the Heisenberg Group in [36, 47, 39], etc.

To this end, some notations are in order. For any $B_{\rho_{0}} \subset \mathbb{R}^{N}$, the De Giorgi's class $D G^{+}\left(B_{\rho_{0}}\right)$ consists of functions $w \in \mathcal{S}^{1,2}\left(B_{\rho_{0}}\right) \cap L^{\infty}\left(B_{\rho_{0}}\right)$, which satisfy the inequality

for some $\gamma, \chi, \epsilon>0$, where $A_{k, \rho}^{+}(w)=\left\{x \in B_{\rho}:(w-k)^{+}=\max (w-k, 0)>0\right\}$ for any arbitrary $k \in \mathbb{R}$, the balls $B_{\rho^{\prime}}, B_{\rho}$ and $B_{\rho_{0}}$ are concentric with $0<\rho^{\prime}<\rho \leq \rho_{0}$. Also, $A_{k, \rho}^{-}(w)$ and the class $D G^{-}\left(B_{\rho_{0}}\right)$ are similarly defined and $D G\left(B_{\rho_{0}}\right)=D G^{+}\left(B_{\rho_{0}}\right) \cap D G^{-}\left(B_{\rho_{0}}\right)$. All properties of classical De Giorgi class functions, also hold for these classes.

In order to establish integral inequality of the type (5.82) for the gradient, we require the following lemma. The proof is similar to Lemma 4.1 of [39] but more involved.

The estimate of integrand with the terms $|\mathfrak{X} u|^{2}+|T u|^{2}$ of the above is same as (5.89). However, estimating the first two terms of the above integrand is more delicate; the use of $(3.41),(3.61)$ or any other estimate of Section 3 right away would not be appropriate because the support $A_{k, r}^{+}$ would be lost that way, thereby producing terms larger than the required right hand side.

To circumvent this, we require the following variants of the Caccioppoli type estimates that is similar to $[47,39]$. For any $\kappa \geq 0$, we test (3.8) with $\varphi_{k}=\eta^{2}\left|\left(X_{l} u-k\right)^{+}\right|^{2}|T u|^{\kappa} T_{k} u$. Then, taking summation over $k \in\{1, \ldots, n\}$, we obtain

Remark 5.8. Some observations on Lemma 5.7 are in order:
(1) We can obtain a similar inequality, corresponding to that of Lemma 5.7 with $\left(X_{l} u-k\right)^{+}$ replaced by $\left(X_{l} u-k\right)^{-}$and $A_{k, r}^{+}\left(X_{l} u\right)$ replaced by $A_{k, r}^{-}\left(X_{l} u\right)$.
(2) It can be observed from the proof that Lemma 5.7 holds without the condition (5.83), for the case of $p \geq 2$ and for this range, it is possible to prove the $C^{1, \alpha}$ regularity directly following the direction of the classical result of DiBenedetto [10], without using anything related to the truncation from the previous subsections. However, for the full range $1<p<\infty$, the application of Lemma 5.7 shall be made in the following whenever Corollary 5.6 ensures the condition (5.83).

Le us fix $B_{r_{0}} \subset \Omega$. For any $0<r<r_{0}$, similarly as (5.3), let us denote

This implies that $X_{i} u$ belongs to the De Giorgi class $D G^{+}\left(B_{2 r}\right)$ for each $i \in\{1, \ldots, m\}$ and hence, it satisfies an oscillation lemma, see [9, 31, 27], etc. from which, as in [39], it is not hard to obtain (5.105).

for all $k \geq \mu(8 r) / 4$. Thus, we can apply Lemma 5.7 with $q=2 Q$ to conclude that

$$
\begin{align*}
\int_{B_{r^{\prime \prime}}}\left|\mathfrak{X}\left(X_{i} u-k\right)^{+}\right|^{2} d x \leq & \frac{c}{\left(r^{\prime}-r^{\prime \prime}\right)^{2}} \int_{B_{r^{\prime}}}\left|\left(X_{i} u-k\right)^{+}\right|^{2} d x  \tag{5.112}\\
& +c K \mathrm{~F}(\mu(8 r))^{-1}\left|A_{k, r^{\prime}}^{+}\left(X_{i} u\right)\right|^{1-\frac{1}{Q}}
\end{align*}
$$

where $K=r_{0}^{-2}\left|B_{r_{0}}\right|^{1 / Q} \mu\left(r_{0}\right)^{2} \mathrm{~F}\left(\mu\left(r_{0}\right)\right)$, whenever $k \geq k_{0}=\mu(8 r) / 4$ and $0<r^{\prime \prime}<r^{\prime} \leq 8 r$. Then, we have standard estimates for the supremum and infimum of $X_{i} u$, see $[27,31]$, etc. such that for some $s_{1}=s_{1}(n, p, L)>0$ he following holds,

\begin{equation*}
\sup _{B_{2 r}} X_{i} u \leq \sup _{B_{8 r}} X_{i} u-2^{-s_{1}}\left(\sup _{B_{8 r}} X_{i} u-\mu(8 r) / 4\right)+c K^{\frac{1}{2}} \mathrm{~F}(\mu(8 r))^{-1 / 2} r^{\frac{1}{2}} \tag{5.113}
\end{equation*}
$$

and from the second part of Case 2 and Remark 5.8, we similarly have

$$
\begin{equation*}
\inf _{B_{2 r}} X_{i} u \geq \inf _{B_{8 r}} X_{i} u+2^{-s_{1}}\left(-\inf _{B_{8 r}} X_{i} u-\mu(8 r) / 4\right)-c K^{\frac{1}{2}} \mathrm{~F}(\mu(8 r))^{-1 / 2} r^{\frac{1}{2}} \tag{5.114}
\end{equation*}
$$

Combining (5.113) and (5.114) as in [39], one can also get (5.105) and the proof is finished.
From (5.105) of Lemma 5.9, it is easy to prove Theorem 1.3 for $\delta>0$ by a standard iteration argument which is classical. We refer to [27, 31, 26], etc. for details. Since all the constants in the above estimates are independent of $\delta$, hence from the arguments of Remark 2.5, we can obtain (1.7) also for $\delta=0$. Thus, the proof of Theorem 1.3 is complete.
5.4. Concluding Remarks. Here are some further remarks about the method and techniques used above throughout the paper and some discussion on further generalizations.
(1) All the apriori estimates for the equation (3.1) in Section 3, rely only on the structure conditions (3.2) and are independent of the " $p$ " of the $p$-Laplacian. The other arguments in the later sections can also be appropriately generalized for the regularity theory of more general classes of equations; e.g. the equation $\operatorname{div}_{H}(f(|\mathfrak{X} u|) \mathfrak{X} u)=0$ with $f$ as any doubling differentiable function on $(0, \infty)$ so that $t \mapsto t f(t)$ is monotonic, admits weak solutions in sub-elliptic Orlicz-Sobolev spaces (defined similarly as Definition (2.3)) which can be similarly shown to be locally $C^{1, \alpha}$ whenever $1+|\mathfrak{X} u| f^{\prime}(|\mathfrak{X} u|) / f(|\mathfrak{X} u|)$ is positive and finite. We refer to $[38,37]$ for the case of the Heisenberg group.
(2) In the special case when the vector fields are left invariant with respect to a Carnot group of step 2 (in particular, the Heisenberg group as in [47, 39]), the commutation relations are more special than (2.2) as mentioned earlier in Remark 2.1, up to the choice of exponential coordinates. This is why, in that case the estimates are simpler and some of the items in the integral estimates gets suppressed, see Remark 5.3. But, unlike the previous case for the Heisenberg group by Mukherjee-Zhong [39], here the lengths of the main crucial lemmas like Lemma 5.2 and Lemma 5.7 are drastically extended and Corollary 3.11, Corollary 5.4, etc. have to be added. Also, in [47], the approximation has been accomplished by a Hilbert-Haar theory for the case of the Heisenberg group, which depends on the group law and hence does not have an easy analogue for the case of general Hörmander vector fields (some deeper theorems and newer adaptations are needed for it). Therefore, in this paper, we have used the Riemannian approximation which is more natural and easier to use.
(3) The generalization of the above techniques from step 2 to any higher step does not seem to be immediately available. The inequalities (2.4) and (2.5) in their present form, do not lead to anything useful for the case of step 3 or any higher step. The higher order commutators have more intricate strucures. For instance, letting $X_{1}^{(s)}, \ldots, X_{k}^{(s)}$ as vector fields corresponding to $s$-th order commutators, the nature of the intermediate integral estimates for $\mathfrak{X}^{(s)} u$ is unclear. In case of a Carnot group of step $r$, i.e. $1 \leq s \leq r$, notice that $\left|\mathfrak{X X} \mathfrak{X}^{(s)} u\right| \neq\left|\mathfrak{X}^{(s)} \mathfrak{X} u\right|$ except for the cases of $s=r\left(\right.$ as $X_{i} X_{j}^{(r)}=\bar{X}_{j}^{(r)} X_{i}$ for the last step of the Lie algebra) and $s=1$ (from the definition of the norm even though $\left.X_{i} X_{j} \neq X_{j} X_{i}\right)$. This feature leads to serious difficulties in the integral estimates for the intermediary steps that do not occur in a set up where these two are the only possible
alternatives, i.e. the step 2 case with $s=1,2$. Similar features typical to vector fields of step 2 Carnot groups are also imbibed in more general step 2 vector fields. Lastly, we refer to [17] for some results on certain special cases of vector fields in higher steps.
