# THE STIEFEL-WHITNEY CLASSES OF MOMENT-ANGLE MANIFOLDS ARE TRIVIAL

#### Abstract

We prove that the Stiefel-Whitney classes of a moment-angle manifold, not necessarily smooth, are trivial. We also consider Stiefel-Whitney classes of the partial quotient of a moment-angle manifold.


## 1. Introduction

Davis and Januszkiewicz [6] introduced a space which is now called a moment-angle complex as a topological generalization of the homogeneous coordinate for a toric variety associated to a simplicial fan [5]. We recall its definition. Let $K$ be a simplicial complex with vertex set $\{1,2, \ldots, m\}$. The moment-angle complex for $K$ is defined by

$$
\begin{equation*}
Z_{K}=\bigcup_{\sigma \in K} Z_{\sigma} \tag{1.1}
\end{equation*}
$$

where $Z_{\sigma}=X_{1} \times \cdots \times X_{m}$ such that $X_{i}=D^{2}$ for $i \in \sigma$ and $X_{i}=S^{1}$ for $i \notin \sigma$. Note that the definition of $Z_{K}$ in the above form is due to Buchstaber and Panov [2]. The momentangle complex $Z_{K}$ has been a central object of study in toric topology. In particular, when $Z_{K}$ is a topological manifold, not necessarily smooth, it has been studied in many contexts $[1,4,9,11,12,16,18]$. Some conditions on $K$ which guarantee that $Z_{K}$ is a topological manifold are known. Buchstaber and Panov [2] proved that $Z_{K}$ is a topological manifold whenever $K$ is a simplicial sphere, and later, Cai [3] generalized this result to a generalized homology sphere which is a homology manifold having the same homology as a sphere.
Suppose that $Z_{K}$ is a topological manifold. By definition, a torus $T^{m}=\left(S^{1}\right)^{m}$ acts naturally on $Z_{K}$, which restricts to a free action of the diagonal subgroup $S^{1} \cong \Delta \subset T^{m}$. Then $Z_{K}$ is the boundary of a topological manifold $Z_{K} \times_{\Delta} D^{2}$. So if $Z_{K}$ is smooth, then it is nullcobordant, or equivalently, all of its Stiefel-Whitney numbers are trivial. Hence it is natural to ask whether or not the Stiefel-Whitney classes of $Z_{K}$ themselves are trivial whenever $Z_{K}$ is a smooth manifold.

[^0]On the other hand, for a connected topological manifold $M$, not necessarily smooth, the Wu classes $\nu_{i} \in H^{i}(M ; \mathbb{Z} / 2)$ can be defined, so that the $i$-the Stiefel-Whitney class of $M$ can be defined by

$$
w_{i}(M)=\sum_{j=0}^{i} \mathrm{Sq}^{j} \nu_{i-j}
$$

too. Then the Stiefel-Whitney classes of any moment-angle manifold, not necessarily smooth, can be defined. So we can generalize the above question as:

Question 1.1. Are the Stiefel-Whitney classes of a moment-angle manifold, not necessarily smooth, trivial?

The aim of this paper is to answer the above question.
Theorem 1.2. The Stiefel-Whitney classes of every moment-angle manifold, not necessarily smooth, are trivial.

To prove Theorem 1.2, we will construct in Section 2 equivariant Stiefel-Whitney classes for a topological manifold, not necessarily smooth. We will see in Section 3 that Theorem 1.2 can be extended to a real moment-angle manifold, and in Section 4, we will also consider the triviality of the Stiefel-Whitney numbers of the quotient manifold $Z_{K} / T$, where $T$ is a subtorus of $T^{m}$ acting freely on $Z_{K}$.

## 2. Equivariant Stiefel-Whitney class

This section recalls the definition of the Stiefel-Whitney classes of a topological manifold due to Fadell [7], and generalizes them to an equivariant context. Throughout this section, let $M$ denote an $R$-oriented connected $n$-dimensional topological manifold, where $R$ is a commutative ring.
Let $\mathcal{T}$ be a subspace of the space of paths in $M$ consisting of constant paths and paths $\ell:[0,1] \rightarrow M$ such that $\ell(t)=\ell(0)$ implies $t=0$. Let $\mathcal{T}_{0}$ be the subspace of $\mathcal{T}$ consisting of non-constant paths. Then as in [7, Proposition 3.8], the evaluation map

$$
p: \mathcal{T} \rightarrow M, \quad \ell \mapsto \ell(0)
$$

yields a locally trivial fibration pair

$$
\left(\mathcal{T}, \mathcal{T}_{0}\right) \rightarrow M
$$

with fiber homotopy equivalent to $\left(\mathbb{R}^{n}, \mathbb{R}^{n}-0\right)$. This is called the tangent fiber space. As in [7, Proposition 3.12], this fibration pair is equivalent to the fibration pair

$$
\begin{equation*}
(M, M-x) \rightarrow(M \times M, M \times M-\Delta) \rightarrow M \tag{2.1}
\end{equation*}
$$

induced from the first projection $M \times M \rightarrow M$, where $\Delta \subset M \times M$ is the diagonal set. Since (2.1) is essentially the micro tangent bundle of $M$ in the sense of Milnor, the tangent fiber space is essentially equivalent to the micro tangent bundle of $M$.
Clearly, $H^{n}\left(p^{-1}(U) ; R\right)$ for open sets $U$ of $M$ define a sheaf on $M$, implying we can define an orientation of $M$ over $R$ in the obvious way. So if $M$ is simply-connected or $R=\mathbb{Z} / 2, M$ is orientable over $R$.
We have the following Thom isomorphism [7, Theorem 5.2].
Theorem 2.1. If $M$ is orientable over $R$ in the sense above, there is a cohomology class $\Phi \in H^{n}\left(\mathcal{T}, \mathcal{T}_{0} ; R\right)$ such that the map

$$
\phi: H^{*}(M ; R) \rightarrow H^{*+n}\left(\mathcal{T}, \mathcal{T}_{0} ; R\right), \quad x \mapsto p^{*}(x) \smile \Phi
$$

is an isomorphism.
The cohomology class $\Phi$ is called the Thom class of $M$. Note that the Thom class $\Phi$ is unique for $R=\mathbb{Z} / 2$. Now we are ready to define the Stiefel-Whitney classes of $M$.

Definition 2.2. Let $R=\mathbb{Z} / 2$. The $i$-th Stiefel-Whitney class of $M$ is defined by

$$
w_{i}(M)=\phi^{-1}\left(\mathrm{Sq}^{i} \phi(1)\right)
$$

If $M$ is smooth, then by [7, Proposition 3.17], the tangent fiber space $\left(\mathcal{T}, \mathcal{T}_{0}\right) \rightarrow M$ is equivalent to the tangent bundle pair $(T M, T M-M) \rightarrow M$. So the above definition of the Stiefel-Whitney classes is consistent with the usual smooth case. Moreover, consistency with the definition using the Wu classes is also proved in [7, Theorem 6.17].
We generalize the above definition of the Stiefel-Whitney classes to an equivariant context. So we let a topological group $G$ act on $M$ from the right. Note that $G$ acts on the space of paths $M^{I}$ by

$$
(\ell \cdot g)(t)=\ell(t) \cdot g
$$

for $\ell \in M^{I}$ and $g \in G$. Clearly, this action restricts to $\mathcal{T}$ and $\mathcal{T}_{0}$ such that the map $p: \mathcal{T} \rightarrow M$ is $G$-equivariant. For the rest of this section, we will make the following assumption.

Assumption 2.3. The cohomology local coefficient systems over $R$ of fibrations

$$
\begin{align*}
& M \xrightarrow{j} M \times_{G} E G \rightarrow B G  \tag{2.2}\\
& \left(\mathcal{T}, \mathcal{T}_{0}\right) \xrightarrow{j}\left(\mathcal{T}, \mathcal{T}_{0}\right) \times_{G} E G \rightarrow B G \tag{2.3}
\end{align*}
$$

are trivial.

We prove the existence of the equivariant Thom class of $M$. For a $G$-space $X$, let $j: X \rightarrow$ $X \times{ }_{G} E G$ denote the natural inclusion. For a pair of $G$-spaces $(X, A)$, let $H_{G}^{*}(X, A ; R)$ denote its equivariant cohomology, that is,

$$
H_{G}^{*}(X, A ; R)=H^{*}\left((X, A) \times_{G} E G ; R\right)
$$

Proposition 2.4. There is a unique cohomology class $\Phi_{G} \in H_{G}^{n}\left(\mathcal{T}, \mathcal{T}_{0} ; R\right)$ such that

$$
j^{*}\left(\Phi_{G}\right)=\Phi .
$$

Proof. Let $E_{r}$ denote the Serre spectral sequence for a fibration (2.3). By Assumption 2.3, there is an isomorphism

$$
E_{2}^{p, q} \cong H^{p}\left(B G ; H^{q}\left(\mathcal{T}, \mathcal{T}_{0} ; R\right)\right)
$$

Then by Theorem 2.1, $E_{2}^{p, q}=0$ for $q<n$, so $\bigoplus_{p+q=n} E_{2}^{p, q}=E_{2}^{0, n}$ and $E_{\infty}^{0, n}=E_{2}^{0, n} \cong$ $H^{n}\left(\mathcal{T}, \mathcal{T}_{0} ; R\right)$. Thus we obtain that the map $j^{*}: H_{G}^{n}\left(\mathcal{T}, \mathcal{T}_{0} ; R\right) \rightarrow H^{n}\left(\mathcal{T}, \mathcal{T}_{0} ; R\right)$ is an isomorphism. In particular, we get a unique cohomology class $\Phi_{G} \in H_{G}^{n}\left(\mathcal{T}, \mathcal{T}_{0} ; R\right)$ satisfying $j^{*}\left(\Phi_{G}\right)=\Phi$, completing the proof.

We call the cohomology class $\Phi_{G}$ the equivariant Thom class of $M$. Now we prove the equivariant Thom isomorphism. As mentioned above, the map $p: \mathcal{T} \rightarrow M$ is $G$-equivariant, and so it induces a map $p_{G}: \mathcal{T} \times{ }_{G} E G \rightarrow M \times_{G} E G$.

Theorem 2.5. The map

$$
\phi_{G}: H_{G}^{*}(M ; R) \rightarrow H_{G}^{*+n}\left(\mathcal{T}, \mathcal{T}_{0} ; R\right), \quad x \mapsto p_{G}^{*}(x) \smile \Phi_{G}
$$

is an isomorphism.
Proof. Let $B^{k}$ denote the $k$-skeleton of $B G$. Let $M^{k}$ and $\left(\mathcal{T}^{k}, \mathcal{T}_{0}^{k}\right)$ denote the pullbacks of $M \times_{G} E G \rightarrow B G$ and $\left(\mathcal{T}, \mathcal{T}_{0}\right) \times{ }_{G} E G \rightarrow B G$ over $B_{k}$. Let $\Psi$ be a cocycle representing $\Phi_{G}$, and let $\Psi_{k}=\left.\Psi\right|_{\left(\mathcal{T}^{k}, \mathfrak{T}_{0}^{k}\right)}$. We define a map

$$
\phi_{k}: C_{G}^{*}\left(M^{k} ; R\right) \rightarrow C_{G}^{*+n}\left(\mathcal{T}^{k}, \mathcal{T}_{0}^{k} ; R\right), \quad x \mapsto p_{G}^{*}(x) \smile \Psi_{k}
$$

of cochain complexes. By definition, there is a commutative diagram


Let $E_{r}$ and $\widehat{E}_{r}$ denote the Serre spectral sequences for the fibrations $M \times{ }_{G} E G \rightarrow B G$ and $\left(\mathcal{T}, \mathcal{T}_{0}\right) \times_{G} E G \rightarrow B G$, respectively. Then the map

$$
\bar{\phi}_{G}: C_{G}^{*}(M ; R) \rightarrow C_{G}^{*}\left(\mathcal{T}, \mathcal{T}_{0} ; R\right), \quad x \mapsto p_{G}^{*}(x) \smile \Psi
$$

induces a map of spectral sequences $f_{r}: E_{r}^{p, q} \rightarrow \widehat{E}_{r}^{p, q+n}$ (with degree shift).

On the other hand, by assumption, there are isomorphisms

$$
E_{2}^{p, q} \cong H^{p}\left(B G ; H^{q}(M ; R)\right) \quad \text { and } \quad \widehat{E}_{2}^{p, q} \cong H^{p}\left(B G ; H^{q}\left(\mathcal{T}, \mathcal{T}_{0} ; R\right)\right)
$$

By the construction of these isomorphisms, the map $f_{2}: E_{2}^{p, q} \rightarrow \widehat{E}_{2}^{p, q+n}$ is identified with the map

$$
H^{p}\left(B G ; H^{q}(M ; R)\right) \rightarrow H^{p}\left(B G ; H^{q+n}\left(\mathcal{T}, \mathcal{T}_{0} ; R\right)\right)
$$

induced from $\phi: H^{q}(M ; R) \rightarrow H^{q+n}\left(\mathcal{T}, \mathcal{T}_{0} ; R\right)$. Then by Theorem 2.1, the map $f_{\infty}: E_{\infty} \rightarrow$ $\widehat{E}_{\infty}$ is an isomorphism, implying the map $\phi_{G}: H_{G}^{*}(M ; R) \rightarrow H_{G}^{*+n}\left(\mathcal{T}, \mathcal{T}_{0} ; R\right)$ is an isomorphism too. Thus the proof is finished.

We are ready to define the equivariant Stiefel-Whitney classes of $M$.
Definition 2.6. Let $R=\mathbb{Z} / 2$. The $i$-th equivariant Stiefel-Whitney class of $M$ is defined by

$$
w_{i}^{G}(M)=\phi_{G}^{-1}\left(\mathrm{Sq}^{i} \phi_{G}(1)\right)
$$

We will use the following property.
Proposition 2.7. $j^{*}\left(w_{i}^{G}(M)\right)=w_{i}(M)$.
Proof. There is a commutative diagram


Indeed, for each $x \in H_{G}^{*}(M ; R)$, we have

$$
j^{*}\left(\phi_{G}(x)\right)=j^{*}\left(p_{G}^{*}(x) \smile \Phi_{G}\right)=j^{*}\left(p_{G}^{*}(x)\right) \smile j^{*}\left(\Phi_{G}\right)=p\left(j^{*}(x)\right) \smile \Phi=\phi\left(j^{*}(x)\right) .
$$

Then we get

$$
\begin{aligned}
j^{*}\left(w_{i}^{G}(M)\right) & =j^{*}\left(\phi_{G}^{-1}\left(\operatorname{Sq}^{i} \phi_{G}(1)\right)\right)=\phi^{-1}\left(j^{*}\left(\operatorname{Sq}^{i} \phi_{G}(1)\right)\right)=\phi^{-1}\left(\operatorname{Sq}^{i} j^{*}\left(\phi_{G}(1)\right)\right) \\
& =\phi^{-1}\left(\operatorname{Sq}^{i} \phi\left(j^{*}(1)\right)\right)=\phi^{-1}\left(\operatorname{Sq}^{i} \phi(1)\right)=w_{i}(M) .
\end{aligned}
$$

Thus the proof is done.

## 3. Proof of Theorem 1.2 and its extension

This section proves Theorem 1.2 and its extension to a real moment-angle manifold. Let $K$ be a simplicial complex with $m$ vertices, and let $T^{m}=\left(S^{1}\right)^{m}$. Then $T^{m}$ acts naturally on $Z_{K}$. Suppose that $Z_{K}$ is a topological manifold. Then $Z_{K}$ is connected. Since $B T^{m}$ is simply-connected, the moment-angle manifold $Z_{K}$ with an action of $T^{m}$ satisfies Assumption 2.3. Then in particular, the equivariant Stiefel-Whitney classes $w_{i}^{T^{m}}\left(Z_{K}\right)$ can be defined.

Now we are ready to prove Theorem 1.2. Let $D J_{K}$ denote the Borel construction $Z_{K} \times{ }_{T^{m}}$ $E T^{m}$.

Proof of Theorem 1.2. Consider a fibration $Z_{K} \xrightarrow{j} D J_{K} \rightarrow B T^{m}$. As in [6, Theorem 4.8], the map $D J_{K} \rightarrow B T^{m}$ is surjective in cohomology, so by the standard spectral sequence argument, we can see that the map $j: Z_{K} \rightarrow D J_{K}$ is trivial in cohomology. Thus the proof is complete by Proposition 2.7.

We extend Theorem 1.2 to a real moment-angle manifold. Let $K$ be a simplicial complex with vertex set $\{1,2, \ldots, m\}$. The real momend-angle complex for $K$ is defined by

$$
\mathbb{R} Z_{K}=\bigcup_{\sigma \in K} \mathbb{R} Z_{\sigma}
$$

where $\mathbb{R} Z_{\sigma}=X_{1} \times \cdots \times X_{m}$ such that $X_{i}=D^{1}$ for $i \in \sigma$ and $X_{i}=S^{0}$ for $i \notin \sigma$. As well as a moment-angle manifold, we call $\mathbb{R} Z_{K}$ a real moment-angle manifold if it is a topological manifold. Cai [3, Theorem 2.3] proved that $\mathbb{R} Z_{K}$ is a topological manifold whenever $K$ is a simplicial sphere. Note that there is a natural action of a 2 -torus $(\mathbb{Z} / 2)^{m}$ on $\mathbb{R} Z_{K}$.

Lemma 3.1. The following group actions are trivial in mod 2 cohomology:
(1) the $(\mathbb{Z} / 2)^{m}$-action on $\mathbb{R} Z_{K}$;
(2) the $(\mathbb{Z} / 2)^{m}$-action on $\left(\mathcal{T}, \mathcal{T}_{0}\right)$ over $\mathbb{R} Z_{K}$ whenever $\mathbb{R} Z_{K}$ is a topological manifold.

Proof. (1) By [3, Proposition 3.3], we can see that any mod 2 homology class of $\mathbb{R} Z_{K}$ admits a representative which is fixed by the action of $(\mathbb{Z} / 2)^{m}$. So the action of $(\mathbb{Z} / 2)^{m}$ on $\mathbb{R} Z_{K}$ is trivial in mod 2 homology, so it is trivial in mod 2 cohomology too.
(2) By Theorem 2.1, $H^{n}\left(\mathcal{T}, \mathcal{T}_{0} ; \mathbb{Z} / 2\right) \cong \mathbb{Z} / 2$. Then the action of $(\mathbb{Z} / 2)^{m}$ on $H^{n}\left(\mathcal{T}, \mathcal{T}_{0} ; \mathbb{Z} / 2\right)$ is trivial, so in particular, the Thom class $\Phi$ is fixed by the action of $(\mathbb{Z} / 2)^{m}$. By Theorem 2.1, each element of $H^{*}\left(\mathcal{T}, \mathcal{T}_{0} ; \mathbb{Z} / 2\right)$ is of the form $p^{*}(x) \smile \Phi$ for some $x \in H^{*}\left(\mathbb{R} Z_{K} ; \mathbb{Z} / 2\right)$. Then since $p:\left(\mathcal{T}, \mathcal{T}_{0}\right) \rightarrow \mathbb{R} Z_{K}$ is $(\mathbb{Z} / 2)^{m}$-equivariant and the action of $(\mathbb{Z} / 2)^{m}$ on $\mathbb{R} Z_{K}$ is trivial in $\bmod 2$ cohomology, for any $g \in(\mathbb{Z} / 2)^{m}$, we have

$$
\left(p^{*}(x) \smile \Phi\right) \cdot g=\left(p^{*}(x) \cdot g\right) \smile(\Phi \cdot g)=p^{*}(x \cdot g) \smile \Phi=p^{*}(x) \smile \Phi
$$

Thus the action of $(\mathbb{Z} / 2)^{m}$ on $\left(\mathcal{T}, \mathcal{T}_{0}\right)$ is trivial in mod 2 cohomology, completing the proof.
By Lemma 3.1, the action of $(\mathbb{Z} / 2)^{m}$ on $\mathbb{R} Z_{K}$ satisfies Assumption 2.3 whenever $\mathbb{R} Z_{K}$ is a topological manifold. Then we can define its equivariant Stiefel-Whitney classes. Now we are ready to prove an extension of Theorem 1.2 to a real-moment-angle manifold.

Theorem 3.2. The Stiefel-Whitney classes of a real moment-angle manifold, not necessarily smooth, are trivial.

Proof. By [6, Theorem 4.8], the map $\mathbb{R} Z_{K} \times_{(\mathbb{Z} / 2)^{m}} E(\mathbb{Z} / 2)^{m} \rightarrow B(\mathbb{Z} / 2)^{m}$ is surjective in mod 2 cohomology, so the map $\mathbb{R} Z_{K} \rightarrow \mathbb{R} Z_{K} \times_{(\mathbb{Z} / 2)^{m}} E(\mathbb{Z} / 2)^{m}$ is trivial in mod 2 cohomology as in the proof of Theorem 1.2. Thus the proof is complete by Proposition 2.7.

## 4. Quotient manifold

There are important manifolds given by the quotient of a moment-angle manifold $Z_{K}$ by a free action of a subtorus $T \subset T^{m}$, where $m$ is the number of vertices of a simplicial complex $K$. A typical example is a quasitoric manifold [2], and there are other classes of such manifolds $[2,8,15]$. Recall that our starting point of study is the fact that every moment-angle manifold $Z_{K}$ is null-cobordant. So it is natural to ask whether or not the quotient manifold $Z_{K} / T$ is null-cobordant. This section gives an answer to this question by sorting with the dimension of $T$.

Throughout this section, let $K$ be a simplicial complex of dimension $n-1$ having the vertex set $\{1,2, \ldots, m\}$, and let $T$ be a subtorus of $T^{m}$ acting freely on $Z_{K}$. If $K$ has no simplex, we set $n=0$. Clearly, we must have $\operatorname{dim} T \leq m-n$. First, we examine the case $\operatorname{dim} T=m-n$, which includes quasitoric manifolds.

Example 4.1. Consider the case that $K$ is the boundary of an $n$-simplex, where $m=n+1$ in this case. The complex projective space $\mathbb{C} P^{n}$ is the quotient of $Z_{K}$ by a free action of a subtorus $T$ of $T^{n}$ with $\operatorname{dim} T=1$. By [17, Theorem 1.1], $\mathbb{C} P^{n}$ is null-cobordant if only if $n$ is odd. Then $\mathbb{C} P^{n}$ is not always null-cobordant. It is well known that the total Stiefel-Whitney class of $\mathbb{C} P^{n}$ is given by

$$
(1+u)^{n+1}
$$

where $u$ is a generator of $H^{2}\left(\mathbb{C} P^{n} ; \mathbb{Z} / 2\right) \cong \mathbb{Z} / 2$. So the Stiefel-Whitney classes of $\mathbb{C} P^{n}$ are trivial if and only if $n=2^{k}-1$ for some $k$. Then the Stiefel-Whitney classes of $\mathbb{C} P^{n}$ are not trivial, even if it is null-cobordant.

Thus for $\operatorname{dim} T=m-n, Z_{K} / T$ being null-cobordant and the triviality of its Stiefel-Whitney classes depend on each $Z_{K} / T$. Next, we consider the case $\operatorname{dim} T<m-n$ and prove:

Theorem 4.2. If $\operatorname{dim} T<m-n$ and $Z_{K} / T$ is a topological manifold, then all Stiefel-Whitney numbers of $Z_{K} / T$ vanish.

The following corollary is immediate from Theorem 4.2.
Corollary 4.3. If $\operatorname{dim} T<m-n$ and $Z_{K} / T$ is a smooth manifold, then $Z_{K} / T$ is nullcobordant.

If $T$ is not maximal among subtori of $T^{m}$ acting freely on a moment-angle manifold $Z_{K}$, then $S^{1}$ acts freely on the quotient manifold $Z_{K} / T$. So as well as $Z_{K}$, we can see that $Z_{K} / T$ is
null-cobordant. Then Corollary 4.3 makes sense only when $T$ is a maximal subtorus of $T^{m}$ acting freely on $Z_{K}$. We will give below such an example.
We will take three steps to prove Theorem 4.2. The first step is to extend the free action of $T$ on $Z_{K}$ to an almost free action of $(m-n)$-dimensional subtorus of $T^{m}$ containing $T$. Recall that a simplicial complex $K$ is said to be pure if all of its maximal simplices have the same dimension.

Lemma 4.4. If $Z_{K} / T$ is a topological manifold, then $K$ is pure.
Proof. By [14, Theorem 1.7.19], there is a principal fiber bundle $T \rightarrow Z_{K} \rightarrow Z_{K} / T$. So if $Z_{K} / T$ is a topological manifold, then $Z_{K}$ is a topological manifold too. Let $\sigma$ be a maximal simplex of $K$, and let $U_{i}=\operatorname{Int}\left(D^{2}\right)$ for $i \in \sigma$ and $U_{i}=S^{1}-\left\{x_{0}\right\}$ for $i \notin \sigma$, where $x_{0} \in S^{1}$. Then $U_{1} \times \cdots \times U_{m}$ is an open set of $Z_{K}$, which is homeomorphic with $\mathbb{R}^{m+|\sigma|}$. Thus if $Z_{K}$ is a topological manifold, then $K$ must be pure, completing the proof.

We introduce a rational characteristic matrix of $K$. An integer matrix $\left(\lambda_{1}, \ldots, \lambda_{m}\right)$ for $\lambda_{1}, \ldots, \lambda_{m} \in \mathbb{Z}^{n}$ is called a rational characteristic matrix of $K$ if the column vectors $\lambda_{i_{1}}, \ldots, \lambda_{i_{k}}$ are linearly independent over $\mathbb{Q}$ for each simplex $\left\{i_{1}, \ldots, i_{k}\right\} \in K$. For an $n \times m$ matrix $A=\left(a_{1}, \ldots, a_{m}\right)$ and a subset $\sigma=\left\{i_{1}<\cdots<i_{k}\right\} \subset\{1, \ldots, m\}$, let

$$
A(\sigma)=\left(a_{i_{1}}, \ldots, a_{i_{k}}\right)
$$

Lemma 4.5. Suppose that $K$ is pure and integer vectors $\lambda_{1}, \ldots, \lambda_{n}, \theta_{1}, \ldots, \theta_{m-n} \in \mathbb{Z}^{m}$ satisfy the following conditions:
(1) $\lambda_{1}, \ldots, \lambda_{n}, \theta_{1}, \ldots, \theta_{m-n}$ are linearly independent over $\mathbb{Q}$;
(2) $\lambda_{i}$ and $\theta_{j}$ are orthogonal for each $i=1, \ldots, n$ and $j=1, \ldots, m-n$.

Then $\Lambda={ }^{t}\left(\lambda_{1}, \ldots, \lambda_{n}\right)$ is a rational characteristic matrix of $K$ if and only if $\operatorname{det} \Theta(\bar{\sigma}) \neq 0$ for each maximal simplex $\sigma \in K$, where $\Theta={ }^{t}\left(\theta_{1}, \ldots, \theta_{m-n}\right)$ and $\bar{\sigma}$ denotes the complement of $\sigma$ in $\{1, \ldots, m\}$.

Proof. Since $K$ is pure, $\Lambda$ is a rational characteristic matrix of $K$ if and only if $\operatorname{det} \Lambda(\sigma) \neq 0$ for each maximal simplex $\sigma \in K$. Now we suppose that $\operatorname{det} \Lambda(\sigma) \neq 0$ and $\operatorname{det} \Theta(\bar{\sigma})=0$. We may assume $\sigma=\{1, \ldots, n\}$. Let

$$
\lambda_{i}=\binom{\lambda_{i}(1)}{\lambda_{i}(2)} \quad \text { and } \quad \theta_{j}=\binom{\theta_{j}(1)}{\theta_{j}(2)}
$$

for $\lambda_{i}(1), \theta_{j}(1) \in \mathbb{Z}^{n}$ and $\lambda_{i}(2), \theta_{j}(2) \in \mathbb{Z}^{m-n}$. Then

$$
\Lambda(\sigma)=\left(\lambda_{1}(1), \ldots, \lambda_{n}(1)\right) \quad \text { and } \quad \Theta(\bar{\sigma})=\left(\theta_{1}(2), \ldots, \theta_{m-n}(2)\right)
$$

So since $\operatorname{det} \Theta(\bar{\sigma})=0$, vectors $\theta_{1}(2), \ldots, \theta_{m-n}(2)$ are linearly dependent over $\mathbb{Q}$, and so there are $c_{1}, \ldots, c_{m-n} \in \mathbb{Q}$ such that $c_{1} \theta_{1}(2)+\cdots+c_{m-n} \theta_{m-n}(2)=0$ and $\left(c_{1}, \ldots, c_{m-n}\right) \neq 0$. Let $x=c_{1} \theta_{1}(1)+\cdots+c_{m-n} \theta_{m-n}(1)$. Then by the first condition, we have $x \neq 0$. Since
$\operatorname{det} \Lambda(\sigma) \neq 0, \lambda_{1}(1), \ldots, \lambda_{n}(1)$ are linearly independent over $\mathbb{Q}$, so there are $d_{1}, \ldots, d_{n} \in \mathbb{Q}$ such that $x=d_{1} \lambda_{1}(1)+\cdots+d_{n} \lambda_{n}(1)$. Let $y=d_{1} \lambda_{1}(2)+\cdots+d_{n} \lambda_{n}(2)$. Then we get

$$
d_{1} \lambda_{1}+\cdots+d_{n} \lambda_{n}=\binom{x}{y} \quad \text { and } \quad c_{1} \theta_{1}+\cdots+c_{m-n} \theta_{m-n}=\binom{x}{0} .
$$

Since $x \neq 0$, these two vectors are not orthogonal, which contradicts to the second condition, and thus it cannot occur that $\operatorname{det} \Lambda(\sigma) \neq 0$ and $\operatorname{det} \Theta(\bar{\sigma})=0$ simultaneously. Quite similarly, we can show that it cannot occur that $\operatorname{det} \Lambda(\sigma)=0$ and $\operatorname{det} \Theta(\bar{\sigma}) \neq 0$ simultaneously too. Thus the proof is complete.

Every $n \times m$ integer matrix $\Lambda$ defines a homomorphism $T^{m} \rightarrow T^{n}$, and we denote the identity component of its kernel by $T(\Lambda)$. Then $T(\Lambda)$ is an $(m-n)$-dimensional torus.

Lemma 4.6. If $K$ is pure, then there is a rational characteristic matrix $\Lambda$ of $K$ such that $T \subset T(\Lambda)$.

Proof. Let $\Lambda_{1}$ be a $k \times m$ integer matrix whose row vectors generate $T$, where $k=\operatorname{dim} T$. By Lemma 4.5, it is sufficient to find an $(m-n-k) \times m$ matrix $\Lambda_{2}$ with entries in $\mathbb{Q}$ such that

$$
\operatorname{det}\binom{\Lambda_{1}}{\Lambda_{2}}(\bar{\sigma}) \neq 0
$$

for each maximal simplex $\sigma \in K$. For a maximal simplex $\sigma \in K$, let $U(\sigma)$ be the subspace of $M(m-n-k, m ; \mathbb{Q})$, the space of $(m-n-k) \times m$ rational matrices, consisting of matrices $\Lambda_{2}$ satisfying the above condition. Then $U(\sigma)$ is non-empty and Zariski open. Thus the intersection of $U(\sigma)$ for all maximal simplices $\sigma \in K$ is non-empty, completing the proof.

Let $S(\Lambda)=T^{m} / T(\Lambda)$, so that $S(\Lambda)$ acts on $Z_{K} / T(\Lambda)$. The second step is to compute the $S(\Lambda)$-equivariant rational cohomology of $Z_{K} / T(\Lambda)$.

Lemma 4.7. Let $G$ be a topological group acting on a space $X$. If the restriction of the $G$-action to a normal subgroup $H$ is free, then the natural map

$$
X \times_{G} E G \rightarrow(X / H) \times_{G / H} E(G / H)
$$

is a weak homotopy equivalence.
Proof. There is a commutative diagram

in which each row is a homotopy fibration. Let $F$ be the homotopy fiber of the right vertical map. Then by taking the homotopy fibers of all vertical maps, we get a homotopy fibration
$H \rightarrow H \rightarrow F$, where the first map is the identity map. Thus $F$ is weakly contractible, completing the proof.

Lemma 4.8. Let $\Lambda$ be a rational characteristic matrix of $K$ as in Lemma 4.6. Then the natural map

$$
H_{S(\Lambda)}^{*}\left(Z_{K} / T(\Lambda) ; \mathbb{Q}\right) \rightarrow H_{T^{m}}^{*}\left(Z_{K} ; \mathbb{Q}\right)
$$

is an isomorphism.
Proof. First, we prove that the map $Z_{\sigma} \times_{T^{m}} E T^{m} \rightarrow\left(Z_{\sigma} / T(\Lambda)\right) \times_{S(\Lambda)} E S(\Lambda)$ is an isomorphism in rational cohomology, where $Z_{\sigma}$ is as in (1.1). Let $X=X_{1} \times \cdots \times X_{m}$ such that $X_{i}=0$ for $i \in \sigma$ and $X_{i}=S^{1}$ for $i \notin \sigma$, where we regard $S^{1}$ is the unit sphere in $\mathbb{C}$. Then $X$ is a $T^{m}$-equivariant deformation retract of $Z_{\sigma}$, so that there is a commutative diagram


Hence we aim to prove that the top map is an isomorphism in rational cohomology. Since $\Lambda$ is a rational characteristic matrix of $K, T(\Lambda)$ acts uniformly on $X$ such that the isotropy subgroup $G$ is finite. Then $T(\Lambda) / G$ acts freely on $X$, and so by Lemma 4.7, the natural map

$$
X \times_{T^{m} / G} E\left(T^{m} / G\right) \rightarrow(X / T(\Lambda)) \times_{S(\Lambda)} E S(\Lambda)
$$

is a weak homotopy equivalence. On the other hand, the homotopy fiber of the map $X \times_{T^{m}}$ $E T^{m} \rightarrow X \times_{T^{m} / G} E\left(T^{m} / G\right)$ is homotopy equivalent to $B G$ which is rationally contractible. Then we obtain that the map $Z_{\sigma} \times_{T^{m}} E T^{m} \rightarrow\left(Z_{\sigma} / T(\Lambda)\right) \times_{S(\Lambda)} E S(\Lambda)$ is an isomorphism in rational cohomology.
Next, we induct on the number of simplices of $K$, fixing $\Lambda$, where $K$ may have ghost vertices. If $K$ has no simplex and consists only of ghost vertices, then $Z_{K}=T^{m}$, and so by Lemma 4.7, the statement holds. Let $\tau<\sigma$ be simplices of $K$. Since $\left(Z_{\sigma}, Z_{\tau}\right)$ is a $T^{m_{-}}$ equivariant NDR pair, $\left(Z_{\sigma} \times_{T^{m}} E T^{m}, Z_{\tau} \times_{T^{m}} E T^{m}\right)$ is an NDR pair. Quite similarly, we see that $\left(\left(Z_{\sigma} / T(\Lambda)\right) \times_{S(\Lambda)} E S(\Lambda),\left(Z_{\tau} / T(\Lambda)\right) \times_{S(\Lambda)} E S(\Lambda)\right)$ is an NDR pair too. Then for each maximal simplex $\sigma$ of $K$, we can apply the Mayer-Vietotris sequene to get a commutative diagram

with exact rows, where $L=K-\sigma$, we consider ghost vertices for $Z_{\sigma}$ and $Z_{\partial \sigma}$, and we omit the coefficient $\mathbb{Q}$. Thus by the five lemma, the induction proceeds, and the proof is complete.

The final step is to prove the vanishing in the equivariant cohomology.
Lemma 4.9. Let $U$ be any subtorus of $T^{m}$. Then for $*>m+n-\operatorname{dim} U$,

$$
H^{*}\left(Z_{K} / U ; \mathbb{Q}\right)=0
$$

Proof. We prove the lemma by induction on the number of simplices of $K$, where $K$ may have ghost vertices. First, if $K$ has no simplex, then $n=0$ and $Z_{K} / U=\left(S^{1}\right)^{m} / U$ is homeomorphic with $T^{m-\operatorname{dim} U}$, so the statement holds. Next, suppose that $K$ has a simplex, and let $\sigma \in K$ be a maximal simplex. Let $L=K \backslash\{\sigma\}$. Consider the long exact sequence

$$
\cdots \rightarrow H^{*}\left(Z_{K} / U, Z_{L} / U ; \mathbb{Q}\right) \rightarrow H^{*}\left(Z_{K} / U ; \mathbb{Q}\right) \rightarrow H^{*}\left(Z_{L} / U ; \mathbb{Q}\right) \rightarrow \cdots
$$

By the induction hypothesis, $H^{*}\left(Z_{L} / U ; \mathbb{Q}\right)=0$ for $*>m+n-\operatorname{dim} U$. Then we aim to show that $H^{*}\left(Z_{K} / U, Z_{L} / U ; \mathbb{Q}\right)=0$ for $*>m+n-\operatorname{dim} U$. Since $\left(Z_{K}, Z_{L}\right)$ is a $T^{m}$-equivariant NDR pair, $\left(Z_{K} / U, Z_{L} / U\right)$ is an NDR pair. Then, by the excision property, there is an isomorphism

$$
H^{*}\left(Z_{K} / U, Z_{L} / U ; \mathbb{Q}\right) \cong H^{*}\left(Z_{\sigma} / U, Z_{\partial \sigma} / U ; \mathbb{Q}\right)
$$

where $Z_{\sigma}$ is as in (1.1). Then we show $H^{*}\left(Z_{\sigma} / U, Z_{\partial \sigma} / U ; \mathbb{Q}\right)=0$ for $*>m+n-\operatorname{dim} U$.
Let $X$ be as in the proof of Lemma 4.8. Then $Z_{\sigma} / U \simeq X / U$. Since $T^{m}$ acts on $X \cong\left(S^{1}\right)^{m-|\sigma|}$ through the projection $\rho: T^{m} \rightarrow T_{\sigma}$, where $T_{\sigma}=\left\{\left(z_{1}, \ldots, z_{m}\right) \in T^{m} \mid z_{i}=1\right.$ for $\left.i \notin \sigma\right\}$. Then there is a homeomorphism

$$
X /\left.U \cong \operatorname{Coker} \rho\right|_{U}
$$

Since Ker $\left.\rho\right|_{U} \subseteq \operatorname{Ker} \rho$, we have $\left.\operatorname{dim} \operatorname{Ker} \rho\right|_{U} \leq \operatorname{dim} \operatorname{Ker} \rho=|\sigma|$, implying $\operatorname{dim} \rho(U) \geq \operatorname{dim} U-$ $|\sigma|$. Thus we see that $X / U$ is homeomorphic with a torus of dimension $\leq(m-|\sigma|)-(\operatorname{dim} U-$ $|\sigma|)=m-\operatorname{dim} U$. In particular, we see that $H^{*}\left(Z_{\sigma} / U ; \mathbb{Q}\right)=0$ for $*>m-\operatorname{dim} U$. Now we consider the exact sequence

$$
\cdots \rightarrow H^{*}\left(Z_{\sigma} / U, Z_{\partial \sigma} / U ; \mathbb{Q}\right) \rightarrow H^{*}\left(Z_{\sigma} / U ; \mathbb{Q}\right) \rightarrow H^{*}\left(Z_{\partial \sigma} / U ; \mathbb{Q}\right) \rightarrow \cdots
$$

By the induction hypothesis, $H^{*}\left(Z_{\partial \sigma} / U ; \mathbb{Q}\right)=0$ for $*>m+n-1-\operatorname{dim} U$. Thus we obtain $H^{*}\left(Z_{\sigma} / U, Z_{\partial \sigma} / U ; \mathbb{Q}\right)=0$ for $*>m+n-\operatorname{dim} U$, completing the proof.

Let $d=m+n-\operatorname{dim} T$ and $S=T^{m} / T$. Then $S$ acts on $Z_{K} / T$.
Proposition 4.10. If $\operatorname{dim} T<m-n$ and $Z_{K}$ is a topological manifold, then the natural map

$$
H_{S}^{d}\left(Z_{K} / T\right) \rightarrow H^{d}\left(Z_{K} / T\right)
$$

is trivial.

Proof. There is a commutative diagram


By Lemmas 4.7 and 4.8, the left vertical map is an isomorphism. By Lemma 4.9, we also have $H^{d}\left(Z_{K} / T(\Lambda) ; \mathbb{Q}\right)=0$. Thus we obtain that the bottom map is trivial, completing the proof.

Now we are ready to prove Theorem 4.2.
Proof of Theorem 4.2. By assumption, $Z_{K} / T$ is a smooth manifold, so that we need to show all of its Stiefel numbers vanish. Let $j: Z_{K} / T \rightarrow E S \times_{S}\left(Z_{K} / T\right)$ denote the inclusion. By Proposition 2.7, $j^{*}\left(w_{i}^{S}\left(Z_{K} / T\right)\right)=w_{i}\left(Z_{K} / T\right)$. Then by Proposition 4.10,

$$
w_{i_{1}}\left(Z_{K} / T\right) \cdots w_{i_{k}}\left(Z_{K} / T\right)=j^{*}\left(w_{i_{1}}^{S}\left(Z_{K} / T\right) \cdots w_{i_{k}}^{S}\left(Z_{K} / T\right)\right)=0
$$

for $i_{1}+\cdots+i_{k}=d$, completing the proof.
As mentioned above, Corollary 4.3 makes sense only when $T$ is a maximal subtorus of $T^{m}$ acting freely on $Z_{K}$. We give an example of such a maximal subtorus $T$. For $t_{1}<\cdots<t_{m}$, let $P_{i}=\left(t_{i}, t_{i}^{2}, \ldots, t_{i}^{n}\right) \in \mathbb{R}^{n}$. Recall that the cyclic polytope $C_{n}(m)$ is defined by the convex hull of points $P_{1}, \ldots, P_{m}$ in $\mathbb{R}^{n}$. It is well known that the combinatorial type of $C_{n}(m)$ is independent from the choice of $t_{1}<\cdots<t_{m}$. The cyclic polytope $C_{n}(m)$ is a simplicial $n$ dimensional polytope with $m$ vertices [19, Theorem 0.7], and so $Z_{\partial C_{n}(m)}$ is a smooth manifold such that the action of $T^{m}$ is smooth [2, Lemma 3.1.2]. Hence if a subtorus $T$ of $T^{m}$ acts freely on $Z_{\partial C_{n}(m)}$, then $Z_{\partial C_{n}(m)} / T$ is a smooth manifold.

Proposition 4.11. There is a 2-dimensional subtorus $T$ of $T^{9}$ which is maximal among subtori acting freely on $Z_{\partial C_{6}(9)}$.

Proof. It is shown in [10] that there is no 3 -dimensional subtorus of $T^{9}$ acting freely on $Z_{\partial C_{6}(9)}$. So we only need to give a 2-dimensional subtorus of $T^{9}$ acting freely on $Z_{\partial C_{6}(9)}$.
Let $T$ be the image of a map $T^{2} \rightarrow T^{9}$ defined by a matrix:

$$
\left(\begin{array}{lllllllll}
1 & 0 & 1 & 0 & 1 & 0 & 1 & 0 & 1  \tag{4.1}\\
0 & 1 & 0 & 1 & 0 & 1 & 0 & 1 & 1
\end{array}\right)
$$

To see that $T$ acts freely on $Z_{\partial C_{6}(9)}$, it is sufficient to show that $T$ acts freely on

$$
D(\sigma)=\left\{\left(z_{1}, \ldots, z_{9}\right) \in Z_{\partial C_{6}(9)} \mid z_{i}=0 \text { for } P_{i} \in \sigma\right\}
$$

for each facet $\sigma$ of $\partial C_{6}(9)$. Let $\left\{P_{a}, P_{b}, P_{c}\right\}=\left\{P_{1}, \ldots, P_{9}\right\}-\sigma$ for a facet $\sigma$ of $\partial C_{6}(9)$, where $a<b<c$. By Gale's evenness condition [19, Theorem 0.7], $b-a$ must be odd, so that we can
easily verify $\operatorname{det}\left(\rho_{a}, \rho_{b}\right)= \pm 1$, where $\rho_{i}$ denotes the $i$-th column of the matrix (4.1). Then if we remove column vectors corresponding to vertices of a facet $\sigma$ from the matrix (4.1), then we get a $2 \times 3$ matrix of rank 2 . This implies that $T$ acts freely on $D(\sigma)$, completing the proof.

By Proposition 4.11, we see that Corollary 4.3 is not trivial. Now we can further ask whether or not the Stiefel-Whitney classes of $Z_{K} / T$ are trivial, as well as Question 1.1. Here is the answer to this question.

Proposition 4.12. Let $T$ be the 2-dimensional subtorus of $T^{9}$ in Proposition 4.11. Then

$$
w_{2}\left(Z_{\partial C_{6}(9)} / T\right) \neq 0
$$

Proof. By definition, the 2-dimensional subtorus $T$ of $T^{9}$ is the kernel of a map $T^{9} \rightarrow T^{7}$ defined by a matrix:

$$
\left(\begin{array}{ccccccccc}
-1 & 0 & 1 & 0 & 0 & 0 & 0 & 0 & 0  \tag{4.2}\\
0 & -1 & 0 & 1 & 0 & 0 & 0 & 0 & 0 \\
-1 & 0 & 0 & 0 & 1 & 0 & 0 & 0 & 0 \\
0 & -1 & 0 & 0 & 0 & 1 & 0 & 0 & 0 \\
-1 & 0 & 0 & 0 & 0 & 0 & 1 & 0 & 0 \\
0 & -1 & 0 & 0 & 0 & 0 & 0 & 1 & 0 \\
-1 & -1 & 0 & 0 & 0 & 0 & 0 & 0 & 1
\end{array}\right)
$$

By [13, Theorem 3.7], $T^{9} \cong T \times T^{9} / T$, and therefore we can regard $E T^{9}=E T \times E\left(T^{9} / T\right)$. Thus we see the following immediately.

$$
Z_{\partial C_{6}(9)} / T \times_{T^{9} / T} E\left(T^{9} / T\right) \simeq Z_{\partial C_{6}(9)} \times_{T^{9}} E T^{9}=D J_{\partial C_{6}(9)}
$$

Then there is a homotopy commutative diagram

where all columns and rows are homotopy fibrations and the map $\lambda$ is defined by a matrix (4.2). Consider the Serre spectral sequence for the middle row homotopy fibration. Then since $Z_{\partial C_{6}(9)}$ is simply-connected [2, Corollary 3.3.4], the map $\alpha$ is an isomorphism in $H^{2}$. By the left fibration, we can also see that $Z_{\partial C_{6}(9)} / T$ is simply-connected. Then by applying the Serre exact sequence to the bottom fibration, we get

$$
H^{2}\left(Z_{\partial C_{6}(9)} / T ; \mathbb{Z}\right)=\mathbb{Z}\left\langle v_{1}, \ldots, v_{9}\right\rangle / \mathbb{Z}\left\langle\theta_{1}, \ldots, \theta_{7}\right\rangle, \quad \theta_{i}=\lambda_{i 1} v_{1}+\cdots+\lambda_{i 9} v_{9}
$$

where $\lambda_{i j}$ denotes the $(i, j)$-entry of a matrix (4.2) and $\mathbb{Z}\left\langle a_{1}, \ldots, a_{n}\right\rangle$ means a free abelian group spanned by $a_{1}, \ldots, a_{n}$. On the other hand, quite similarly to [6, Corollary 6.7], we can see that

$$
w_{2}\left(Z_{\partial C_{6}(9)} / T\right)=\left[v_{1}+\cdots+v_{9}\right] \in H^{2}\left(Z_{\partial C_{6}(9)} / T ; \mathbb{Z} / 2\right) .
$$

Thus we obtain that $H^{2}\left(Z_{\partial C_{6}(9)} / T ; \mathbb{Z} / 2\right)$ has a basis $\left[v_{1}\right],\left[v_{2}\right]$ and $w_{2}\left(Z_{\partial C_{6}(9)} / T\right)=\left[v_{1}\right]+\left[v_{2}\right]$, implying $w_{2}\left(Z_{\partial C_{6}(9)} / T\right) \neq 0$. Therefore the proof is complete.
