# Maximal Regularity for Compressible Two-Fluid System

#### Abstract

We investigate a compressible two-fluid Navier-Stokes type system with a single velocity field and algebraic closure for the pressure law. The constitutive relation involves densities of both fluids through an implicit function. We are interested in regular solutions in a $L_{p}-L_{q}$ maximal regularity setting. We show that such solutions exists locally in time and, under additional smallness assumptions on the initial data, also globally. Our proof rely on appropriate transformation of the original problem, application of Lagrangian coordinates and maximal regularity estimates for associated linear problem.


Keywords. Compressible Navier-Stokes system, two-fluid model, local and global regular solutions, maximal regularity.

## 1 Introduction

In the present paper, we analyze a bi-fluid compressible system. It arises, in particular, as a result of averaging procedure applied to liquid-gas free boundary problem (see for instance [14]). We assume a common velocity field and pressure for both fluids (the socalled algebraic pressure closure), for justification of this reduction and presentation of related models we refer to [2].
Our system of equations reads:

By $p^{+}, p^{-}$we denote the internal barotropic pressures for each fluid with the explicit forms:

where $\gamma^{ \pm}>1$ are given constants, and we assume without loss of generality that

The stress tensor obeys the Newton rheological law

[^0]where $\mathbf{D}(\mathbf{u})=\frac{1}{2}\left(\nabla \mathbf{u}+(\nabla \mathbf{u})^{T}\right)$ and $\mu$ and $\nu$ are the nonnegative viscosity coefficients.
We consider the system (1.1) on a domain $\Omega \subset \mathbb{R}^{3}$ supplied with the Dirichlet boundary condition for the velocity

and with the initial conditions

We assume that the total initial density is separated away from zero, i.e.

and that the initial data

We immediately switch to a reformulation of the system (1.1). Introducing the notation

we check that the pressure $p$ is expressed in terms of $R, Q$. For this purpose we observe that, by (1.1d) and (1.2),

Note that by (1.11) we immediately deduce that $0 \leq \alpha \leq 1$.
The system (1.1)-(1.5) can be therefore transformed to the following form

where $Z$ is related to $R$ and $Q$ through the non-explicit formula (1.10).
Note that by $(1.1 \mathrm{~d}),(1.2)$ and (1.9) the triplet $(R, Q, Z(R, Q))$ uniquely determines $\left(\varrho^{+}, \varrho^{-}, \alpha^{+}, \alpha^{-}\right)$. Therefore it is legitimate to consider the system (1.12) instead of (1.1).

### 1.1 Notation

We use standard notation $L_{p}(\Omega)$ and $W_{p}^{k}(\Omega)$ for Lebesgue and Sobolev spaces, respectively. Furthermore by $L_{p}(I ; X)$, where $I \subset \mathbb{R}_{+}$and $X$ is a Banach space, we denote a Bochner space.

Next, we recall that for $0<s<\infty$ and $m$ a smallest integer larger than $s$ we define Besov spaces as intermediate spaces

where $(\cdot, \cdot)_{s / m, p}$ is the real interpolation functor, see [1, Chapter 7]. In particular,

We shall not distinguish between notation of spaces for scalar and vector valued functions, i.e. we write $L_{q}(\Omega)$ instead of $L_{q}(\Omega)^{3}$ etc. However, we write vector valued functions in boldface.

We also introduce a brief notation for the regularity class of the solution. Namely, for a triple $(g, h, \mathbf{f})$ we define a norm

Obviously, we denote by $\mathcal{X}(T)$ a space of functions for which the norm (1.15) is finite.
Next, for $0<\varepsilon<\pi$ and $\lambda_{0}>0$ we introduce

Finally, by $E(\cdot)$ we shall denote a non-negative non-decreasing continuous function such that $E(0)=0$. We use the notation $E(T)$ in particular to denote these constants in various inequalities, which can be made arbitrarily small by taking $T$ sufficiently small.

### 1.2 Main results

The first main result of this paper gives local in time existence and uniqueness for problem (1.12):

Theorem 1.1 Assume that $\Omega$ is a uniform $C^{2}$ domain and $2<p<\infty, 3<q<$ $\infty, \frac{2}{p}+\frac{3}{q}<1$. Assume moreover that $R_{0}, Q_{0}$ satisfy (1.7) and $\mathbf{u}_{0}$ satisfies the compatibility condition

Then for any $L>0$ there exists $T>0$ such that if

then (1.12) admits a unique solution $(R, Q, \mathbf{u})$ on $(0, T)$ with the estimate

where $\|\cdot\|_{\mathcal{X}(T)}$ is defined in (1.15) and $\delta$ is a small positive constant.

Next we show global well-posedness for (1.12) assuming additionally that $\Omega$ is bounded and initial data is close to some constants:
Theorem 1.2 Assume that $\Omega$ is a bounded $C^{2}$ domain, $p, q, R_{0}, Q_{0}$ satisfy the assumptions of Theorem 1.1 and let $R_{*}, Q_{*}$ be any positive constants. Assume moreover that $\mathbf{u}_{0}$ satisfies the compatibility condition (1.18). Then there exists $\varepsilon>0$ s.t. if

then the solution to (1.12) exists globally in time and satisfies the following decay estimate:

where $\beta$ is a positive constant, $\delta$ is a small positive constant, and $\|\cdot\|_{\dot{\mathcal{X}}}$ is defined in (1.16).

### 1.3 Discussion

The existence of global weak solutions to (1.1) in a space-periodic setting was established by Bresch et al. in [3], however with additional capillarity effects. In a one dimensional case the existence of global weak solutions without capillarity was shown in [4], where, moreover, it is shown that after a finite time a vacuum is excluded and at least component corresponding to one phase becomes regular. More recently, the global finite energy weak solutions to a two-fluid Stokes system has been shown by Bresch, Mucha and Zatorska in [5]. Soon after, similar result for full two-fluid compressible Navier-Stokes equations with single velocity was proven by Novotný and Pokorný in [23], and by Jin and Novotný [15] for the so-called Baer-Nunziato type of system.

The existence of regular solutions for a simplified version of (1.1a) where influence of one of the phases in the convective term is neglected has been shown in [11]. Existence of global strong solutions in $L_{2}$ framework in the whole space in $\mathbb{R}^{3}$ under certain smallness assumptions has been shown by Evje, Wang and Wen in [8]. In the one dimensional case, more analytical and numerical results can be found in [9], [10]. Existence, uniqueness and stability of global weak solutions, still in one dimension, to system (1.1), has been shown by Li, Sun, Zatorska in [19] and some non-uniqeness results for the inviscid version of this system in multiple dimensions was shown by Li and Zatorska in [20]. Finally, let us also mention that very recently Wang, Wen and Yao proved global existence and uniqueness of solutions to the non-conservative two-fluid model with unequal velocities using the energy methods [31].

In order to prove Theorem 1.1 we show a maximal regularity estimate for associated linear problem. For this purpose we apply the theory based on the concept of $\mathcal{R}$-boundedness. The underlying result for this approach is the famous Weis' vectorvalued Fourier multiplier theorem proved in [32], which we recall in the Appendix. In brief, this result allows to deduce maximal regularity for a time-dependent problem from $\mathcal{R}$-boundedness of a family of solution operators to associated resolvent problem. In [6] this approach was applied to prove maximal regularity for the heat equation using explicit solution formula. Further development of the theory in the context of equations of fluid mechanics was mostly due to Y. Shibata and his collaborators. In [29] the authors show a maximal regularity for the Stokes problem with Neumann boundary condition. For this purpose they prove several technical results enabling to show $\mathcal{R}$ boundedness for the resolvent problem. These results have been applied and extended in [7] to treat the compressible Navier-Stokes system with Dirichlet boundary condition. The result has been extended to slip boundary conditions in [21], [22]. For further developments we can mention [27], [28] for free boundary problems, [18] for a 2-phase compressible-incompressible flow or [12] for a compressible fluid-rigid body interaction problem. In a series of papers of Piasecki, Shibata and Zatorska [24]- [26] the above described approach was applied to
treat a system describing multi-component compressible mixtures. Here we rely on the ideas we developed in these papers to treat quite complex nonlinearities resulting from Lagrangian transformation and linearization.

## 2 Lagrangian coordinates

In order to define the Lagrangian transformation we start with a following simple observation:
Lemma 2.1 Let $p$ and $q$ satisfy the assumptions of Theorem 1.1. Then
(i) if $\|f\|_{L_{p}\left(0, T ; W_{q}^{2}(\Omega)\right)} \leq M$ for some $M>0$, then

Proof. By the imbedding theorem and Hölder inequality we have

which proves the first assertion, and for the second we have

Now we can proceed with the transformation. Let $\mathbf{v}(y, t)$ be the velocity field in the Lagrange coordinates, so that the following change of variables is true:

where $\delta_{i j}$ are Kronecker's delta symbols. If $\mathbf{v}$ is the solution satifying the regularity from Theorem 1.1, then by Lemma 2.1 we can assume

$\boldsymbol{I}$ is the $3 \times 3$ identity matrix, and $\mathbf{V}^{0}(\mathbf{k})$ is the $3 \times 3$ matrix of smooth functions with respect to $\mathbf{k} \in \mathbb{R}^{3 \times 3}$ defined on $|\mathbf{k}|<\delta$ with $\mathbf{V}^{0}(0)=0$, where $\mathbf{k}$ are independent variables corresponding to $\mathbf{k}_{\mathbf{v}}$.

We have

Notice that adding (1.12a) to (1.12b) and using this equation to compute $\partial_{t}(R+Q)$ we can rewrite (1.12c) as

For consistency with notation (2.11) let us denote the initial data for the problem in Lagrangian coordinates as

In the Appendix we recall how $\mathcal{R}$-boundedness for the resolvent problem implies maximal regularity due to Weis vector-valued Fourier Multiplier Theorem. Therefore in order to prove Theorem 3.1 it is sufficient to show the following result:
Theorem 3.2 Let $1<q<\infty$ and $0<\epsilon<\pi / 2$. Assume that $\Omega$, $\mathfrak{r}_{0}, \mathfrak{q}_{0}, \omega_{1}^{0}, \omega_{2}^{0}$ satisfy the assumptions of Theorem 3.1. Then, there exist a positive constant $\lambda_{0}$ and operator families $\mathcal{A}_{1}(\lambda), \mathcal{A}_{2}(\lambda) \in \operatorname{Hol}\left(\Lambda_{\epsilon, \lambda_{0}}, \mathcal{L}\left(W_{q}^{1}(\Omega)^{2} \times L_{q}(\Omega), W_{q}^{1}(\Omega)\right)\right)$ and $\mathcal{B}(\lambda) \in$ $\operatorname{Hol}\left(\Lambda_{\epsilon, \lambda_{0}}, \mathcal{L}\left(W_{q}^{1}(\Omega)^{2} \times L_{q}(\Omega), W_{q}^{2}(\Omega)^{N}\right)\right)$, such that for any $\left(f_{1}, f_{2}, \mathbf{f}_{3}\right) \in\left(W_{q}^{1}(\Omega)\right)^{2} \times$ $L_{q}(\Omega)$ and $\lambda \in \Sigma_{\epsilon, \lambda_{0}},\left(\sigma_{\lambda}=\mathcal{A}_{1}(\lambda)\left(f_{1}, f_{2}, \mathbf{f}_{3}\right), \eta_{\lambda}=\mathcal{A}_{2}(\lambda)\left(f_{1}, f_{2}, \mathbf{f}_{3}\right), \mathbf{u}_{\lambda}=\mathcal{B}(\lambda)\left(f_{1}, f_{2}, \mathbf{f}_{3}\right)\right)$ is a unique solution of (3.11) and

\mathcal{R}_{\mathcal{L}\left(\left(W_{q}^{1}(\Omega)\right)^{2} \times L_{q}(\Omega), W_{q}^{1}(\Omega)\right)}\left(\left\{\left(\tau \partial_{\tau}\right)^{\ell} \mathcal{A}_{1}(\lambda): \lambda \in \Sigma_{\epsilon, \lambda_{0}}\right\}\right) \leq M, \\
\mathcal{R}_{\mathcal{L}\left(\left(W_{q}^{1}(\Omega)\right)^{2} \times L_{q}(\Omega), W_{q}^{1}(\Omega)\right)}\left(\left\{\left(\tau \partial_{\tau}\right)^{\ell} \mathcal{A}_{2}(\lambda): \lambda \in \Sigma_{\epsilon, \lambda_{0}}\right\}\right) \leq M, \\
\mathcal{R}_{\mathcal{L}\left(L_{q}(\Omega) \times W_{q}^{1}(\Omega), W_{q}^{2-j}(\Omega)^{N}\right)}\left(\left\{\left(\tau \partial_{\tau}\right)^{\ell}\left(\lambda^{j / 2} \mathcal{B}(\lambda)\right): \lambda \in \Sigma_{\epsilon, \lambda_{0}}\right\}\right) \leq M,

for $\ell=0,1, j=0,1,2$ and some constant $M>0$, where by Hol we denote the space of holomorphic operators.

Remark 1 We say that the operator valued function $T(\lambda)$ is holomorphic if it is differentiable in norm for all $\lambda$ in a complex domain. For more details, see [16, Chaper VII, \$1.1].

Following the idea introduced already in [7] in context of the compressible Navier-Stokes equations, in order to prove Theorem 3.2 we transform (3.11) using the fact that continuity equation becomes an algebraic equation in the resolvent problem. Computing $\eta_{\lambda}$ and $\sigma_{\lambda}$ from (3.11a)-(3.11b) we obtain

Since the RHS of (3.12) contains lower order terms, it is enough to show $\mathcal{R}$-boundedness for a problem

Proposition 3.3 Let $1<q<\infty$ and $0<\epsilon<\pi / 2$. Assume that $\Omega$ is a uniform $C^{2}$ domain in $\mathbb{R}^{N}$. Then, there exists a positive constant $\lambda_{0}$ such that there exists an operator family $\mathcal{C}(\lambda) \in \operatorname{Hol}\left(\Sigma_{\epsilon, \lambda_{0}}, \mathcal{L}\left(L_{q}(\Omega), W_{q}^{2}(\Omega)\right)\right)$ such that for any $\lambda \in \Sigma_{\epsilon, \lambda_{0}}$ and $\mathbf{f} \in L_{q}(\Omega)$, $\boldsymbol{v}=\mathcal{C}(\lambda) \mathbf{f}$ is a unique solution of (3.13), and

$\mathcal{R}$-boundedness for (3.15) can be shown following the proof Theorem 3.1 in [7]. The latter is shown for problem (3.14) in the whole space. In order to adapt it to (3.15) we can divide (3.15) by $\mathfrak{r}_{0}^{*}+\mathfrak{q}_{0}^{*}$ using the fact that this constant is strictly positive. We obtain

Therefore the only difference is that now we have $\omega^{*} \geq 0$ instead of $\gamma^{2}$. However, strict positivity of this constant neither its square structure is not necessary, nonnegativity is sufficient.

Next we consider (3.15) in a half-space supplied with the boundary condition $\left.\mathbf{v}\right|_{\partial \mathbb{R}_{+}^{n}}=$ 0 . Here we can follow the proof of Theorem 4.1 in [7] which works without modifications for $\omega^{*} \geq 0$.

The third step consists in showing $\mathcal{R}$-boundedness in a bent half-space, the necessary result is Theorem 5.1 in [7], where replacing $\lambda^{-1} \gamma^{2}>0$ with $\omega^{*} \geq 0$ is again harmless.

The final step is application of partition of unity and properties of a uniform $C^{2}$ domain. Here we have to deal with variable coefficients which is not in the scope of Theorem 2.10 in [7]. However, we can refer to a more recent result, Theorem 4.1 in [24] which gives $\mathcal{R}$-boundedness for a resolvent problem corresponding to more complicated system describing flow of a two-component mixture. It is sufficient to follow Section 6.3 of [24] with some obvious modifications. At this stage we need continuity of the coefficients $\mathfrak{r}_{0}, \mathfrak{q}_{0}, \omega_{1}^{0}, \omega_{2}^{0}$ which is assured by (3.9).

### 3.3 Preliminary estimates

We start with recalling two embedding results for Besov spaces. The first one is $[1$, Theorem 7.34 (c)]:

& \sup _{t \in(0, T)}\|f\|_{\left.W_{\infty}^{1}(\Omega)\right)} \leq C\left[\left\|f_{t}\right\|_{L_{p}\left(0, T ; L_{q}(\Omega)\right)}+\|f\|_{L_{p}\left(0, T ; W_{q}^{2}(\Omega)\right)}+\|f(0)\|_{B_{q, p}^{2-2 / p}(\Omega)}\right] \tag{3.18}
\end{align*}

where $C$ does not depend ot $T$.

& \quad \leq C\left(\left\|f-f^{0}\right\|_{L_{p}\left(0, \infty ; W_{q}^{2}(\Omega)\right)}+\left\|\partial_{t} f\right\|_{L_{p}\left(0, T ; L_{q}(\Omega)\right)}\right)
\end{aligned}
$$

& \sup _{t \in(0, T)}\|\mathbf{w}(\cdot, t)-\mathbf{w}(0)\|_{B_{q, p}^{2(1-1 / p)}(\Omega)} \leq C(M, L)  \tag{3.27}\\
& \|\mathbf{w}\|_{L_{\infty}\left(0, T ; W_{\infty}^{1}(\Omega)\right)} \leq C(M, L) \tag{3.28}
\end{align*}

where $\mathbf{k}_{\mathbf{v}}$ is defined in (2.8).

### 3.4 Estimate of the right hand side of (3.3)

Before going to the essence of this section let is observe the following fact
Lemma 3.9 Let $\mathfrak{z}=\mathfrak{z}(\mathfrak{r}, \mathfrak{q})$ be as in (2.11) and satisfy (1.10) and (1.11), then the following is true:

In the second we have $\left(1-\frac{\mathfrak{r}}{\mathfrak{z}}\right)^{-1}<2$, which by (1.10) implies $\mathfrak{z}^{\gamma}<2 \mathfrak{q}$. This completes the proof.

We are now ready to prove the following estimate for the RHS of (3.3):

## 4 Global well-posedness

### 4.1 Linearization around the constant state

In order to prove Theorem 1.2 we linearize (2.12) around the positive constants $R_{*}, Q_{*}$ to which the initial condition is assumed to be close. For convenience let us denote

Analogous result for the compressible Stokes system was proved recently in [17, Proposition 3.2], also without the zero mean assumption. The proof is based on the ideas from [24] but the system is simpler, so we recommend also this proof for more details.

Theorem (4.1) can be proved following line by line the proof of Proposition 3.2 from [17], therefore we omit the proof here.

& \left\|z_{1}(\cdot, t)-\mathfrak{r}_{*}\right\|_{W_{q}^{1}\left(\Omega_{0}\right)} \leq\left\|z_{1}(0)-\mathfrak{r}_{*}\right\|_{W_{q}^{1}\left(\Omega_{0}\right)}+\int_{0}^{t}\left\|\partial_{t} z_{1}(s, \cdot)\right\|_{W_{q}^{1}\left(\Omega_{0}\right)} \mathrm{d} t \\
& \leq \varepsilon+C\left(\int_{0}^{t} e^{-\beta s p^{\prime}} d s\right)^{1 / p^{\prime}}\left(\int_{0}^{\infty} e^{\beta s p}\left\|z_{t}\right\|_{W_{q}^{1}\left(\Omega_{0}\right)} d s\right)^{1 / p}
\end{aligned}
$$

and similarly for $z_{2}$ and $\mathfrak{q}_{*}$, which gives (4.9) and (4.10). Finally, (4.11) and (4.12) follows from Lemma 3.7.

We are now in a position to prove the following estimate for the RHS of (3.3), which will enable us to apply Theorem 4.1:
Proposition 4.3 Let $g_{1}(V), g_{2}(V), \mathbf{g}_{3}(V)$ be defined by (4.3)-(4.5). Then

$$
\begin{align*}
& \left\|e^{\beta t} g_{1}(V), e^{\beta t} g_{2}(V)\right\|_{L_{p}\left(\mathbb{R}_{+}, W_{q}^{1}(\Omega)\right)}+\left\|e^{\beta t} \mathbf{g}_{3}(V)\right\|_{L_{p}\left(\mathbb{R}_{+}, L_{q}(\Omega)\right)} \\
& \leq C\left(\left\|e^{\beta t} V\right\|_{\dot{\mathcal{X}}(+\infty)}^{2}+\varepsilon\left(\left\|e^{\beta t} V\right\|_{\dot{\mathcal{X}}(+\infty)}+1\right)\right), \tag{4.14}
\end{align*}
$$

where $\varepsilon$ is from (1.21).
Proof. By (2.19) and (4.3) we have

$$
\begin{equation*}
g_{1}(V)=-\left(\sigma+\mathfrak{r}_{*}\right) V_{i j}^{0}\left(\mathbf{k}_{\mathbf{v}}\right) \frac{\partial v_{i}}{\partial y_{j}}-\sigma \operatorname{div} \boldsymbol{v} \tag{4.15}
\end{equation*}
$$

therefore by Lemma 4.2 we immediately get

$$
\left\|e^{\beta t} g_{1}(V)\right\|_{L_{p}\left(0, T ; L_{q}(\Omega)\right)} \leq C\left\|e^{\beta t} V\right\|_{\dot{\mathcal{X}}(+\infty)}^{2}
$$

Differentiating (4.15) we obtain

$$
\begin{aligned}
\nabla g_{1}(V)= & -\nabla\left(\sigma V_{i j}^{0}\left(\mathbf{k}_{\mathbf{v}}\right) \frac{\partial v_{i}}{\partial y_{j}}-\left(\sigma+\mathfrak{r}_{*}\right)\left[\nabla_{\mathbf{k}_{\mathbf{v}}} V_{i j}^{0}\left(\mathbf{k}_{\mathbf{v}}\right) \nabla \mathbf{k}_{\mathbf{v}} \frac{\partial v_{i}}{\partial y_{j}}+V_{i j}^{0}\left(\mathbf{k}_{\mathbf{v}}\right) \frac{\partial^{2} v_{i}}{\partial y_{i} \partial y_{k}}\right]\right. \\
& -\operatorname{div} \mathbf{v} \nabla \sigma-\sigma \nabla \operatorname{div} \mathbf{v} .
\end{aligned}
$$

By Lemma 4.2 we easily obtain

$$
\left\|e^{\beta t} \nabla g_{1}(V)\right\|_{L_{p}\left(0, T ; L_{q}(\Omega)\right)} \leq C\left\|e^{\beta t} V\right\|_{\dot{\mathcal{X}}(+\infty)}^{2} .
$$

As $g_{2}$ has the same form with $\eta, \mathfrak{q}_{*}$ instead of $\sigma, \mathfrak{r}_{*}$, alltogether we get

$$
\begin{equation*}
\left\|e^{\beta t} g_{1}(V), e^{\beta t} g_{2}(V)\right\|_{L_{p}\left(\mathbb{R}_{+}, W_{q}^{1}(\Omega)\right)} \leq C\left\|e^{\beta t} V\right\|_{\dot{\mathcal{X}}(+\infty)}^{2} \tag{4.16}
\end{equation*}
$$

It remains to estimate $\mathbf{g}_{3}$. This is more involved, however we can take advantage of ideas from the proof of local well posedness, roughly speaking replacing smallness of time by smallness of initial data. Firstly, by (2.21) and Lemma 4.2 we have

$$
\begin{equation*}
\left\|e^{\beta t} \mathbf{O}_{3}\left(V+\left(0, \mathfrak{r}_{*}, \mathfrak{q}_{*}\right)\right), e^{\beta t}(\sigma+\eta) \partial_{t} \mathbf{v}\right\|_{L_{p}\left(0, T ; L_{q}(\Omega)\right)} \leq C\left\|e^{\beta t} V\right\|_{\dot{\mathcal{X}}(+\infty)}^{2} \tag{4.17}
\end{equation*}
$$

Now we have to estimate $J_{1}, J_{2}, J_{3}$. Taking into account (3.39) with $\left(\mathfrak{r}_{*}, \mathfrak{q}_{*}, \mathfrak{z}_{*}\right)$ instead of $\left(\mathfrak{r}_{0}, \mathfrak{q}_{0}, \mathfrak{z}_{0}\right)$, it is enough to find bounds on the numerators of the last three terms of (4.5). These contains many terms but of a similar structure. First representative case is

$$
\begin{aligned}
& \left\|e^{\beta t}\left(\mathfrak{r}-\mathfrak{r}_{*}\right) \nabla \eta\right\|_{L_{p}\left(\mathbb{R}_{+} ; L_{q}(\Omega)\right)} \leq C\left\|\mathfrak{r}-\mathfrak{r}_{*}\right\|_{L_{\infty}\left(\Omega \times \mathbb{R}_{+}\right)}\left\|e^{\beta t} \nabla \eta\right\|_{L_{p}\left(\mathbb{R}_{+} ; L_{q}(\Omega)\right)} \\
& \leq C\left\|e^{\beta t} V\right\|_{\dot{\mathcal{X}}(+\infty)}\left(\left\|e^{\beta t} V\right\|_{\dot{\mathcal{X}}(+\infty)}+\varepsilon\right)
\end{aligned}
$$

where we have used (4.9). The second case is when we have increment of $\mathfrak{z}$. Then we use

$$
\begin{aligned}
& \left\|\mathfrak{z}(t)-\mathfrak{z}_{*}\right\|_{L_{\infty}(\Omega)} \leq\left\|\mathfrak{z}_{0}-\mathfrak{z}_{*}\right\|_{\infty}+\left\|\mathfrak{z}-\mathfrak{z}_{0}\right\|_{L_{\infty}(\Omega)} \\
& \quad \leq\left\|\left(\mathfrak{r}_{0}-\mathfrak{r}_{*}\right) \partial_{\varrho} \mathfrak{z},\left(\mathfrak{q}_{0}-\mathfrak{q}_{*}\right) \partial_{\kappa \mathfrak{z}}\right\|_{L_{\infty}(\Omega)}+\int_{0}^{t}\left\|\partial_{t \mathfrak{z}}(s)\right\|_{W_{q}^{1}} d s \leq C\left(\varepsilon+\left\|e^{\beta t} V\right\|_{\dot{\mathcal{X}}(t)}\right)
\end{aligned}
$$

to obtain

$$
\begin{aligned}
& \left\|e^{\beta t} \mathfrak{z}^{\gamma^{+}}\left(\mathfrak{z}_{*}-\mathfrak{z}\right) \nabla \sigma\right\|_{L_{p}\left(\mathbb{R}_{+} ; L_{q}(\Omega)\right)} \leq C\left\|_{\mathfrak{z}}-\mathfrak{z}_{*}\right\|_{L_{\infty}\left(\Omega \times \mathbb{R}_{+}\right)}\left\|e^{\beta t} \nabla \sigma\right\|_{L_{p}\left(\mathbb{R}_{+} ; L_{q}(\Omega)\right)} \\
& \leq C\left(\varepsilon+\left\|e^{\beta t} V\right\|_{\dot{\mathcal{X}}(+\infty)}\right)\left\|e^{\beta t} V\right\|_{\dot{\mathcal{X}}(+\infty)}
\end{aligned}
$$

Other terms containing $\left(\mathfrak{z}_{*}-\mathfrak{z}\right)$ can be treated similarly. Terms with $\mathfrak{z}^{\beta}-\mathfrak{z}_{*}^{\beta}$ for $\beta \in\left\{\gamma^{+}, \gamma^{+}-1, \gamma-1\right\}$ can also be estimated in a similar way. Altogether we obtain

$$
\begin{equation*}
\sum_{k=1}^{3}\left\|e^{\beta t} J_{k}(\mathfrak{r}, \mathfrak{q}, \mathfrak{z})\right\|_{L_{p}\left(\mathbb{R}_{+} ; L_{q}(\Omega)\right)} \leq C\left(\varepsilon+\left\|e^{\beta t} V\right\|_{\dot{\mathcal{X}}(+\infty)}\right)\left\|e^{\beta t} V\right\|_{\dot{\mathcal{X}}(+\infty)} \tag{4.18}
\end{equation*}
$$

Putting together (4.16),(4.17) and (4.18) we obtain (4.14).

### 4.4 Proof of Theorem 1.2

We proceed in a standard way, first we show
Lemma 4.4 Assume $(\sigma, \eta, \mathbf{v})$ is solution to (3.3) with $\mathfrak{r}_{0}, \mathfrak{q}_{0}$ and $\mathbf{u}_{0}$ satisfying the assumptions of Theorem 1.2. Then

$$
\begin{equation*}
\left\|e^{\beta t}(\sigma, \eta, \mathbf{v})\right\|_{\dot{\mathcal{X}}(+\infty)} \leq E(\epsilon) \tag{4.19}
\end{equation*}
$$

Proof. Applying Theorem 4.1 and Proposition 4.3 to (3.3) we obtain

$$
\begin{equation*}
\left\|e^{\beta t}(\sigma, \eta, \mathbf{v})\right\|_{\dot{\mathcal{X}}(T)} \leq C\left(\varepsilon+\left\|e^{\beta t}(\sigma, \eta, \mathbf{v})\right\|_{\dot{\mathcal{X}}(T)}^{2}\right) \quad \forall 0<T \leq+\infty \tag{4.20}
\end{equation*}
$$

Notice that we derived this inequality for $T=\infty$, but the same arguments allow to obtain it for any $T>0$. Now consider the equation

$$
x^{2}-\frac{x}{C}+\epsilon=0
$$

with roots

$$
x_{1}(\epsilon)=\frac{1}{2 C}-\sqrt{\frac{1}{4 C^{2}}-\epsilon}, \quad x_{2}(\epsilon)=\frac{1}{2 C}+\sqrt{\frac{1}{4 C^{2}}-\epsilon} .
$$

Observe that inequality (4.20) implies either $\left\|e^{\beta t}(\sigma, \eta, \mathbf{v})\right\|_{\dot{\mathcal{X}}(T)} \leq x_{1}(\epsilon)$ or $\left\|e^{\beta t}(\sigma, \eta, \mathbf{v})\right\|_{\dot{\mathcal{X}}(T)} \geq$ $x_{2}(\epsilon)$. However,

$$
\lim _{T \rightarrow 0}\left\|e^{\beta t}(\sigma, \eta, \mathbf{v})\right\|_{\dot{\mathcal{X}}(T)}=0
$$

therefore

$$
\begin{equation*}
\left\|e^{\beta t}(\sigma, \eta, \mathbf{v})\right\|_{\dot{\mathcal{X}}(T)} \leq x_{1}(\epsilon) \tag{4.21}
\end{equation*}
$$

for small times. However, $\left\|e^{\beta t}(\sigma, \eta, \mathbf{v})\right\|_{\dot{\mathcal{X}}(T)}$ is continuous in time and therefore (4.21) holds for $0<T \leq+\infty$.

Now we can prolong the local solution for arbitrarily large times. For this purpose observe that if the initial data satisfies (1.21) then the time of existence from Theorem 1.1 satisfies $T>C(\epsilon)>0$. Therefore, for arbitrarily large $T^{*}$ we obtain a solution on $\left(0, T^{*}\right)$ in a finite number of steps. By the estimate (4.19) this solution satisfies (1.22).

## Appendix

Here we recall the definition of $\mathcal{R}$-boundedness:
Definition 1 Let $X$ and $Y$ be two Banach spaces, and $\|\cdot\|_{X}$ and $\|\cdot\|_{Y}$ their norms. $A$ family of operators $\mathcal{T} \subset \mathcal{L}(X, Y)$ is called $\mathcal{R}$-bounded on $\mathcal{L}(X, Y)$ if there exist constants $C>0$ and $p \in[1, \infty)$ such that for any $n \in \boldsymbol{n},\left\{T_{j}\right\}_{j=1}^{n} \subset \mathcal{T}$ and $\left\{f_{j}\right\}_{j=1}^{n} \subset X$, the inequality

$$
\int_{0}^{1}\left\|\sum_{j=1}^{n} r_{j}(u) T_{j} f_{j}\right\|_{Y}^{p} d u \leq C \int_{0}^{1}\left\|\sum_{j=1}^{n} r_{j}(u) f_{j}\right\|_{X}^{p} d u
$$

where $r_{j}:[0,1] \rightarrow\{-1,1\}, j \in \boldsymbol{n}$, are the Rademacher functions given by $r_{j}(t)=$ $\operatorname{sign}\left(\sin \left(2^{j} \pi t\right)\right)$. The smallest such $C$ is called $\mathcal{R}$-bound of $\mathcal{T}$ on $\mathcal{L}(X, Y)$ which is written by $\mathcal{R}_{\mathcal{L}(X, Y)} \mathcal{T}$.
Next we quote Weis' vector valued Fourier Multiplier Theorem ( [32]):
Theorem 4.5 Let $X$ and $Y$ be UMD spaces and $1<p<\infty$. Let $M \in C^{1}(\mathbb{R} \backslash$ $\{0\}, \mathcal{L}(X, Y))$. Let us define the operator $T_{M}: \mathcal{F}^{-1} \mathcal{D}(\mathbb{R}, X) \rightarrow \mathcal{S}^{\prime}(\mathbb{R}, Y)$ :

$$
\begin{equation*}
T_{M} \phi(\tau)=\mathcal{F}^{-1}[M \mathcal{F}[\phi](\tau)] \tag{4.22}
\end{equation*}
$$

Assume that
$\mathcal{R}_{\mathcal{L}(X, Y)}(\{M(\tau): \tau \in \mathbb{R} \backslash\{0\}\})=\kappa_{0}<\infty, \quad \mathcal{R}_{\mathcal{L}(X, Y)}\left(\left\{\tau M^{\prime}(\tau): \tau \in \mathbb{R} \backslash\{0\}\right\}\right)=\kappa_{1}<\infty$.
Then, the operator $T_{M}$ defined in (4.22) is extended to a bounded linear operator $L_{p}(\mathbb{R}, X) \rightarrow$ $L_{p}(\mathbb{R}, X)$ and

$$
\left\|T_{M}\right\|_{\mathcal{L}\left(L_{p}(\mathbb{R}, X), L_{p}(\mathbb{R}, Y)\right)} \leq C\left(\kappa_{0}+\kappa_{1}\right)
$$

where $C=C(p, X, Y)>0$.
Remark 2 For definitions and properties of UMD spaces we refer the reader for example to Chapter 4 in [13]. Here let us only note that $L_{p}$ spaces and $W_{p}^{k}$ spaces are UMD for $1<p<\infty$.

We recall that the Fourier transform and its inverse are defined as

$$
\begin{equation*}
\mathcal{F}[f](\tau)=\int_{\mathbb{R}} e^{-i t \tau} f(t) d t, \quad \mathcal{F}^{-1}[f](t)=\frac{1}{2 \pi} \int_{\mathbb{R}} e^{i t \tau} f(\tau) d \tau \tag{4.24}
\end{equation*}
$$

while the Laplace transform and its inverse are

$$
\begin{equation*}
\mathcal{L}[f](\lambda)=\int_{\mathbb{R}} e^{-\lambda t} f(t) d t, \quad \mathcal{L}_{\beta}^{-1}[f](t)=\frac{1}{2 \pi} \int_{\mathbb{R}} e^{\lambda t} f(\lambda) d \tau, \quad \text { where } \lambda=\beta+i \tau \tag{4.25}
\end{equation*}
$$

The following result (Theorem 2.17 in [7]) explains how to obtain $L_{p}$ - maximal regularity using Theorem 4.5 and Laplace transform:

Theorem 4.6 Let $X$ and $Y$ be UMD Banach spaces and $1<p<\infty$. Let $0<\varepsilon<\frac{\pi}{2}$ and $\beta_{1} \in \mathbb{R}$. Let $\Phi_{\lambda}$ be a $C^{1}$ function of $\tau \in \mathbb{R} \backslash\{0\}$ where $\lambda=\beta+i \tau \in \Sigma_{\varepsilon}+\beta_{1}$ with values in $\mathcal{L}(X, Y)$. Assume that

$$
\mathcal{R}_{\mathcal{L}(X, Y)}\left(\left\{\Phi_{\lambda}: \lambda \in \Sigma_{\varepsilon}+\beta_{1}\right\}\right) \leq M, \quad \mathcal{R}_{\mathcal{L}(X, Y)}\left(\left\{\tau \frac{\partial}{\partial \tau} \Phi_{\lambda}: \lambda \in \Sigma_{\varepsilon}+\beta_{1}\right\}\right) \leq M
$$

for some $M>0$. Let us define

$$
\begin{equation*}
\Psi f(t)=\mathcal{L}_{\beta}^{-1}\left[\Phi_{\lambda} \mathcal{L}[f](\lambda)\right](t) \quad \text { for } \quad f \in \mathcal{F}^{-1} \mathcal{D}(\mathbb{R}, X) \tag{4.26}
\end{equation*}
$$

where $\mathcal{L}$ and $\mathcal{L}_{\beta}^{-1}$ are the Laplace transform and its inverse defined in (4.25). Then

$$
\begin{equation*}
\left\|e^{-\beta t} \Psi f\right\|_{L_{p}(\mathbb{R}, Y)} \leq C(p, X, Y) M\left\|e^{-\beta t}\right\|_{L_{p}(\mathbb{R}, X)} \quad \forall \beta \geq \beta_{1} \tag{4.27}
\end{equation*}
$$

Proof: For $\lambda=\beta+i \tau$ we have the following relation between Laplace and Fourier transforms defined in, respectively, (4.25) and (4.24):

$$
\begin{aligned}
& \mathcal{L}[f](\lambda)=\int_{\mathbb{R}} e^{-\lambda t} f(t) d t=\mathcal{F}\left[e^{-\beta t} f\right](\tau) \\
& \mathcal{L}_{\beta}^{-1}[f](t)=\frac{1}{2 \pi} \int_{\mathbb{R}} e^{\lambda t} f(\lambda) d \tau=e^{\beta t} \mathcal{F}^{-1}[f](t)
\end{aligned}
$$

Therefore by (4.26) we have

$$
e^{-\beta t} \Psi f(t)=\mathcal{F}^{-1}\left[\Psi_{\beta+i \tau} \mathcal{F}\left[e^{-\beta t}\right](\tau)\right](t)
$$

Applying Theorem 4.5 to the above formula we conclude (4.27).
