# Local existence of strong solutions to the stochastic Navier-Stokes equations with $L^{p}$ data

#### Abstract

For the stochastic Navier-Stokes equations with a multiplicative white noise on $\mathbb{T}^{3}$, we prove that there exists a unique strong solution locally in time when the initial datum belongs to $L^{p}\left(\Omega ; L^{p}\right)$ for $p>3$.


## 1. Introduction

We consider the stochastic Navier-Stokes equation (SNSE)

\begin{align*}
& d u(t, x)=\Delta u(t, x) d t-\mathcal{P}((u(t, x) \cdot \nabla) u(t, x)) d t+\sigma(u(t, x)) d \mathbb{W}(t),  \tag{1.1}\\
& \nabla \cdot u=0  \tag{1.2}\\
& u(0, x)=u_{0}(x), \quad(t, x) \in(0, \infty) \times \mathbb{T}^{3} \tag{1.3}
\end{align*}
$$

on the 3 D torus $\mathbb{T}^{3}=[0,1]^{3}$, where we assume that the initial datum $u_{0}$ satisfies $\nabla \cdot u_{0}=0$ and $\int_{\mathbb{T}^{3}} u_{0}=0$. The variable $u$ denotes the velocity and $\mathcal{P}$ stands for the Leray projector onto the mean zero divergencefree fields. The stochastic term $\sigma(u) d \mathbb{W}(t)$ represents a possibly infinite-dimensional multiplicative white noise and is interpreted in the Itô sense. Physically, it accounts for random velocity-dependent perturbations during the flow evolution.

In this paper, we obtain a pathwise unique strong solution of (1.1)-(1.3) in $L^{p}\left(\mathbb{T}^{3}\right)$ for the full range of exponents $p>3$. This problem was previously addressed in the paper $[\mathbf{K X Z}]$, where we used the fixed point technique utilizing a multiplicative cut-off of the nonlinear term, which in turn led to the restriction $p>5$ for the initial data. In this paper, we change the approach to using a spectral Galerkin type approximation. These approximations are generally well-suited for the Hilbert space setting but are not considered well-adapted for $L^{p}$ type approximations. However, using a square cut-off in Fourier space, we show that the solutions of the approximation converge in suitable spaces to the sought-after local $L^{p}$ solution of the stochastic Navier-Stokes system for $p>3$.

When considering the approximating system and assuming an additive noise, one can write the equation as the difference of the stochastic Stokes equation and an auxiliary deterministic equation; cf. $[\mathbf{F}, \mathbf{M S}]$ for applications of this approach to additive white noise and additive Lévy noise. When
having a general multiplicative noise, we lose such an advantage. Here, we reduce the finite-dimensional approximations of (1.1) to equations with an additive noise by a fixed point argument, and then we utilize stopping times to linearize $(u \cdot \nabla) u$ to derive energy estimates. However, introducing stopping times is known for bringing the potential issue of them being degenerate, which prevents one from claiming a limit on a nontrivial time interval for the sequence of approximating solutions. We circumvent this obstacle by employing the estimates in probability subspaces that monotonically expand to the whole probability space. In each of these subspaces, the sequence of stopping times has a positive limit almost surely, and thus we can extract a pathwise limit of approximating solutions in that space. Then, we extend the result to the whole probability space by using indicator functions and showing convergence in an appropriate sense. There are also some challenges when studying SNSE in non-Hilbert trajectory spaces. First, the usual Galerkin scheme does not converge in $L^{p}$ when $p \neq 2$. In this paper, we use the rectangular partial sums instead (cf. (2.2) below) and prove their continuity in $L^{p}\left(l^{2}\right)$ by applying a vector analog of the Calderón-Zygmund theorem. Yet as a consequence, there is no available result ensuring the existence of approximating solutions for this finite scheme. Hence, we first construct approximating solutions in $H^{1}\left(\mathbb{T}^{3}\right)$. Then we derive estimates in $L^{p}\left(\mathbb{T}^{3}\right)$, where the one of the important ingredients is Lemma 3.2, which is proven in $[\mathbf{K X Z}]$ using $[\mathbf{R}]$.

A study of the SNSE dates back to the work of Bensoussan and Temam (cf. [BeT] ) in the 1970's. Early investigations were usually conducted in Hilbert settings. Existing results on this include $[\mathbf{M e S}]$, where the SNSE with additive white noise was considered in 2D domains, and a global strong solution was shown to exist, and $[\mathbf{F}]$, where the consideration was in 3D. in $[\mathbf{F S}]$, the authors proved the same results for the SNSE in 2D unbounded domains with multiplicative noise. in [GZ], the authors constructed a maximal strong solution for the equation in 3D bounded domains assuming $H^{1}$ regularity of the initial data. If the SNSE is equipped with a non-degenerate noise and sufficiently small initial data in $H^{s}$, then by [Ki], a global strong solution exists with large probability. Development of the theory naturally leads to considerations in Banach spaces. An effort in this direction includes $[\mathbf{A g V}]$, where the authors studied the equation with multiplicative noise in critical Besov spaces, and $[\mathbf{K X Z}]$, where the SNSE with $L^{p}$ initial data was considered. Under the condition that $p>5$, a unique strong solution exists globally with large probability. There are also investigations on various notions of solutions to the SNSE or to relevant equations with different types of noise; cf. $[\mathbf{B F}, \mathbf{F G}, \mathbf{M R}]$ for results on martingale solutions of the SNSE, $[\mathbf{B C F}, \mathbf{C C}, \mathbf{D Z}, \mathbf{M S}]$ for the mild formulation subject to white noise, and $[\mathbf{B T}, \mathbf{Z B L} 1, \mathbf{Z B L} 2, \mathbf{F R S}]$ for mild formulation with Lévy noise. in $[\mathbf{G V}]$, the stochastic Euler equation with linear multiplicative noise was addressed in $W^{s, p}$, and in [BR], the vorticity equation of SNSE with a convolution-type noise was considered.

The paper is organized as follows. Section 2 is an introduction to the approximating finite dimensional scheme, while it also contains preliminaries on stochastic integration. In Section 3, we state our assumptions and the main result. In Section 4, we establish the local existence and the pathwise uniqueness of strong solutions. Furthermore, we prove that

up to the maximal time of existence $\tau$.

## 2. Notation and preliminaries

2.1. Basic Notation. The Fourier coefficients of an integrable function $f$ are denoted by

\mathcal{F} f(m)=\hat{f}(m)=\int_{\mathbb{T}^{3}} f(x) e^{-2 \pi i m \cdot x} d x, \quad m \in \mathbb{Z}^{d}

where $d$ is the space dimension, while the Fourier inversion formula reads

We adopt the same notation for the Fourier transform of a distribution $f \in \mathcal{D}^{\prime}=\left(C^{\infty}\left(\mathbb{T}^{d}\right)\right)^{\prime}$. As usual, $W^{s, p}\left(\mathbb{T}^{d}\right)$, where $p>1$, denotes the class of functions $f \in \mathcal{D}^{\prime}\left(\mathbb{T}^{d}\right)$ for which $\|f\|_{s, p}=\left\|J^{s} f\right\|_{p}<\infty$, where

J^{s} f(x):=\sum_{m \in \mathbb{Z}^{d}}\left(1+4 \pi^{2}|m|^{2}\right)^{s / 2} \hat{f}(m) e^{2 \pi i m \cdot x}, \quad x \in \mathbb{T}^{d}, \quad s \in \mathbb{R}

with $\|\cdot\|_{p}$ denoting the $L^{p}$ norm. When $p=2$, we also write $H^{s}\left(\mathbb{T}^{d}\right)=W^{s, 2}\left(\mathbb{T}^{d}\right)$. The Leray projector

(\mathcal{P} u)_{j}(x)=\sum_{k=1}^{d}\left(\delta_{j k}+R_{j} R_{k}\right) u_{k}(x), \quad j=1,2, \ldots, d
$$

is defined for distributions that have mean zero over $\mathbb{T}^{d}$. Here,

R_{j}=-\frac{\partial}{\partial x_{j}}(-\Delta)^{-\frac{1}{2}}, \quad j=1,2, \ldots, d \tag{2.1}
\end{equation*}

are Riesz transforms. For convenience, we write

W_{\mathrm{sol}}^{s, p}=\left\{\mathcal{P} f: f \in W^{s, p}\right\}
$$

When constructing solutions below, we use a finite approximation scheme to (1.1). For this purpose, we introduce the rectangular partial sums

\mathcal{T}_{n} f(x)=\sum_{\left|k_{1}\right| \leq n_{1}} \cdots \sum_{\left|k_{d}\right| \leq n_{d}} \hat{f}(k) e^{2 \pi i k \cdot x}=\int_{\mathbb{T}^{d}} f(x-u) D_{n}(u) d u \tag{2.2}

for $f \in L^{1}\left(\mathbb{T}^{d}\right)$, where $n=\left(n_{1}, \ldots, n_{d}\right)$ is a multi-index and $D_{n}(u)=\sum_{\left|k_{1}\right| \leq n_{1}} \cdots \sum_{\left|k_{d}\right| \leq n_{d}} e^{2 \pi i k \cdot u}$ is the rectangular Dirichlet kernel. Denote

It was shown in $[\mathbf{G}]$ that $\mathcal{T}_{n}$ is a continuous operator on all $L^{q}\left(\mathbb{T}^{d}\right)$ spaces $(1<q<\infty)$, i.e.,

The following lemma is one of our main devices for estimating the nonlinear terms.
Lemma 2.1. For all $q \in(1, \infty)$ and all $f \in W^{1, q}\left(\mathbb{T}^{d}\right)$ with $x$-zero mean, there exists $\alpha(q) \in(0,1]$ such that

for all multiindices $n=\left(n_{1}, \ldots, n_{d}\right)$ and $m=\left(m_{1}, \cdots, m_{d}\right)$.
Proof of Lemma 2.1. Let $u \in\left(C^{\infty}\left(\mathbb{T}^{d}\right)\right)^{d}$, and denote

T^{(n, m)}=\mathcal{T}_{n m} \Delta^{-1} \operatorname{div}
$$

where $\mathcal{T}_{n m}=\mathcal{T}_{n}-\mathcal{T}_{m}$ and

$$
\Delta^{-1} \operatorname{div} u=\sum_{k=\left(k_{1}, \ldots, k_{d}\right) \neq 0}\left(\frac{-1}{4 \pi^{2}|k|^{2}} \sum_{l=1}^{d} 2 \pi i k_{l} \hat{u}_{l}(k)\right) e^{2 \pi i k \cdot x}
$$

(Below, we shall choose $u=\nabla f$.) Note that $\Delta^{-1} \operatorname{div} \nabla f=f$ since $f$ has zero mean. By the orthogonality of $\left\{e^{2 \pi i k \cdot x}\right\}$ and Parseval's identity, we have

from where

Substituting $u$ by $\nabla f$ yields

where $C_{2}$ is a constant depending only on the dimension $d$. Now, let $q \in(1,2)$ be arbitrary and choose $r=(1+q) / 2 \in(1, q)$. Then we have

where the constant $C_{r}$ depends on $r$ and thus on $q$; in the second inequality in (2.7), we used the Poincaré inequality $\|f\|_{r} \leq C_{r}\|\nabla f\|_{r}$, which holds for $r \geq 1$ and $f \in W^{1, r}$ such that $\int_{\mathbb{T}^{d}} f=0$. Using the Marcinkiewicz interpolation theorem on the inequalities (2.6) and (2.7) yields

where $\alpha \in(0,1)$ is such that $1 / q=\alpha / 2+(1-\alpha) / r$, i.e., $\alpha=(1 / r-1 / q) /(1 / r-1 / 2)$. Substituting $u=\nabla f$ in (2.8) yields (2.5) for $q \in(1,2)$. The proof for $q \in(2, \infty)$ is the same except that we take $r=2 q$.

Above and in the rest of this paper, $C$ denotes a generic positive constant, with additional dependence indicated when necessary.
2.2. Preliminaries on stochastic analysis. We denote by $\mathcal{H}$ a real separable Hilbert space with a complete orthonormal basis $\left\{\mathbf{e}_{k}\right\}_{k \geq 1}$, and by $\left(\Omega, \mathcal{F},\left(\mathcal{F}_{t}\right)_{t \geq 0}, \mathbb{P}\right)$ a complete probability space with an augmented filtration $\left(\mathcal{F}_{t}\right)_{t \geq 0}$. With $\left\{W_{k}: k \in \mathbb{N}\right\}$ a family of independent $\mathcal{F}_{t}$-adapted Brownian motions, $\mathbb{W}(t, \omega):=\sum_{k \geq 1} W_{k}(t, \omega) \mathbf{e}_{k}$ is an $\mathcal{F}_{t}$-adapted and $\mathcal{H}$-valued cylindrical Wiener process.

For a real separable Hilbert space $\mathcal{Y}$, we define $l^{2}(\mathcal{H}, \mathcal{Y})$ to be the set of Hilbert-Schmidt operators from $\mathcal{H}$ to $\mathcal{Y}$ with the norm defined by

In this paper, we either regard (1.1) as a vector-valued equation or consider it componentwise. Correspondingly, $\mathcal{Y}=\mathbb{R}$ or $\mathbb{R}^{d}$. Let $G=\left(G_{1}, \cdots, G_{d}\right)$ and $G \mathbf{e}_{k}:=\left(G_{1} \mathbf{e}_{k}, \cdots, G_{d} \mathbf{e}_{k}\right)$. Then $G \in l^{2}\left(\mathcal{H}, \mathbb{R}^{d}\right)$ if and only if $G_{i} \in l^{2}(\mathcal{H}, \mathbb{R})$ for all $i \in\{1, \cdots, d\}$. The Burkholder-Davis-Gundy (BDG) inequality

holds for $p \in[1, \infty)$ and all $G \in l^{2}(\mathcal{H}, \mathcal{Y})$ such that the right hand side above is finite. For $s \geq 0$, introduce

\mathbb{W}^{s, p}:=\left\{f: \mathbb{T}^{d} \rightarrow l^{2}(\mathcal{H}, \mathcal{Y}): f \mathbf{e}_{k} \in W^{s, p}\left(\mathbb{T}^{d}\right) \text { for each } k, \text { and } \int_{\mathbb{T}^{d}}\left\|J^{s} f\right\|_{l^{2}(\mathcal{H}, \mathcal{Y})}^{p} d x<\infty\right\}
$$

which are Banach spaces with respect to the norm

\|f\|_{\mathbb{W}^{s, p}}:=\left(\int_{\mathbb{T}^{d}}\left\|J^{s} f\right\|_{l^{2}(\mathcal{H}, \mathcal{Y})}^{p} d x\right)^{1 / p}
$$

Above, we denoted $\left(J^{s} f\right) \mathbf{e}_{k}=J^{s}\left(f \mathbf{e}_{k}\right)$. Also, $\mathbb{W}^{0, p}$ is abbreviated as $\mathbb{L}^{p}$. If $f \in \mathbb{L}^{2}$, then $\int_{0}^{t} f d \mathbb{W}_{t}$ is an $L^{2}\left(\mathbb{T}^{d}\right)$-valued Wiener process (cf. [DZ2]).

Letting $(\mathcal{P} f) \mathbf{e}_{k}=\mathcal{P}\left(f \mathbf{e}_{k}\right)$, where $\mathcal{P}$ is the Leray projector, we have $\mathcal{P} f \in \mathbb{W}^{s, p}$ if $f \in \mathbb{W}^{s, p}$. Write

Letting $\left(\mathcal{T}_{n} f\right) \mathbf{e}_{k}=\mathcal{T}_{n}\left(f \mathbf{e}_{k}\right)$, where $\mathcal{T}_{n}$ is the rectangular partial sum in (2.2), we have the vector valued analog of (2.3)-(2.4), stated next.

Lemma 2.2. For every $q \in(1, \infty)$, we have

for $f \in \mathbb{L}^{q}$ with $x$-zero mean.
Proof of Lemma 2.2. It is sufficient to prove (2.9) when $d=1$, in which case $n \in \mathbb{N}$. Consider the mapping

H \sum_{m \in \mathbb{Z}} \hat{f}(m) e^{2 \pi i m \cdot x}:=\sum_{m \geq 1} \hat{f}(m) e^{2 \pi i m \cdot x}
$$

for $l^{2}$-valued functions $f$ such that $\hat{f}(0)=0$. Using the vector valued Calderón-Zygmund theorem, we have

\|H f\|_{\mathbb{L}^{q}} \leq C_{q}\|f\|_{\mathbb{L}^{q}}
$$

where $C_{q}$ is a constant, depending on $q$. Note that the same inequality is satisfied by the operators $H_{n} \sum_{m \in \mathbb{Z}} \hat{f}(m) e^{2 \pi i m \cdot x}=\sum_{m \leq n} \hat{f}(m) e^{2 \pi i m \cdot x}$. The proof of (2.9) is then concluded by observing that $\mathcal{T}_{n} f=\left(I-H_{-(n+1)}\right) H_{n}$, for all $n \in \mathbb{N}$.

First note that $l^{2}$-valued trigonometric polynomials $\mathcal{T}$ are dense in $\mathbb{L}^{q}$. This holds since the Fejér kernel constitutes a partition of unity, implying the convergence of the $l^{2}$-valued Fourier series in the mean. Assume that $f \in \mathbb{L}^{q}$, and let $\epsilon>0$. Then there exists $P \in \mathcal{T}$ such that $\|f-P\|_{\mathbb{L}^{q}} \leq \epsilon$, whence

\left\|f-\mathcal{T}_{n} f\right\|_{\mathbb{L}^{q}} \leq\|f-P\|_{\mathbb{L}^{q}}+\left\|P-\mathcal{T}_{n} P\right\|_{\mathbb{L}^{q}}+\left\|\mathcal{T}_{n} P-\mathcal{T}_{n} f\right\|_{\mathbb{L}^{q}} \leq \epsilon+\left\|P-\mathcal{T}_{n} P\right\|_{\mathbb{L}^{q}}+C_{q} \epsilon
$$

Since, by $P \in \mathcal{T}$, the middle term vanishes for $n$ sufficiently large, and we obtain $\lim \sup _{n \rightarrow \infty} \| f-$ $\mathcal{T}_{n} f \|_{\mathbb{L}^{q}} \leq C_{q} \epsilon$. The proof of (2.10) is then concluded by sending $\epsilon \rightarrow 0$.

Lemma 2.2 confirms that $\int_{0}^{t} \mathcal{T}_{n} f d \mathbb{W}_{t}$ is an $\mathcal{T}_{n} L^{2}\left(\mathbb{T}^{d}\right)$-valued Wiener process if $f \in \mathbb{L}^{2}$.
Let $A$ be an operator, for instance a differential operator, and let $\sigma$ and $g$ be $\left(l^{2}(\mathcal{H}, \mathbb{R})\right)^{d}$-valued operators. Given a cylindrical Wiener process $\mathbb{W}$ relative to a prescribed stochastic basis $\left(\Omega, \mathcal{F},\left(\mathcal{F}_{t}\right)_{t \geq 0}, \mathbb{P}\right)$, we define the local strong solution for the $d$-dimensional stochastic evolution partial differential equation

u(t, x)=u_{0}(x)+\int_{0}^{t}(A u(r, x)+f(r, x)) d r+\int_{0}^{t}(\sigma(u(r, x))+g(r, x)) d \mathbb{W}(r) \tag{2.11}
\end{equation*}

in the following way.
Definition 2.1 (Local strong solution). A pair $(u, \tau)$ is called a local strong solution of (2.11) on $\left(\Omega, \mathcal{F},\left(\mathcal{F}_{t}\right)_{t \geq 0}, \mathbb{P}\right)$ if $\tau$ is a stopping time with $\mathbb{P}(\tau>0)=1$ and if $u \in L^{p}\left(\Omega ; C\left([0, \tau \wedge T], L^{p}\right)\right.$ is progressively measurable and it satisfies

$$
(u(t), \phi)=\left(u_{0}, \phi\right)+\int_{0}^{t}(A u(r)+f(r), \phi) d r+\int_{0}^{t}(\sigma(u(r))+g(r), \phi) d \mathbb{W}(r) \quad \mathbb{P} \text {-a.s. }
$$

for all $\phi \in C^{\infty}\left(\mathbb{T}^{d}\right)$ and all $t \in[0, \tau \wedge T]$.
If $A$ is a differential operator, we interpret $(A u(r), \phi)$ using integration by parts.

Definition 2.2 (Pathwise uniqueness). The equation (2.11) is said to have a pathwise unique strong solution if for any pair of local strong solutions $(u, \tau)$ and $(v, \eta)$ subject to $\left(\Omega, \mathcal{F},\left(\mathcal{F}_{t}\right)_{t \geq 0}, \mathbb{P}\right)$ and the same Wiener process $\mathbb{W}$, we have $\mathbb{P}(u(t)=v(t), \forall t \in[0, \tau \wedge \eta])=1$.

## 3. Assumptions and main results

In this section, we summarize the assumptions and state the main result. We assume throughout that $d=3$ and $p>3$. We point out however that the results extend easily to any space dimension $d \geq 2$ with the condition $p>d$. On the noise coefficient $\sigma$ in (1.1), we assume
(1) (sub-linear growth)

\begin{equation*}
\sum_{i=1}^{3}\left\|\sigma_{i}(u)\right\|_{\mathbb{L}^{r}} \leq C\left(\|u\|_{r}+1\right), \quad r \in\{2, p, 3 p\} \tag{3.1}
\end{equation*}

(2) (Lipschitz continuity)

$$
\begin{equation*}
\sum_{i=1}^{3}\left\|\sigma_{i}(u)-\sigma_{i}(v)\right\|_{\mathbb{L}^{r}} \leq C\|u-v\|_{r}, \quad r \in\{2, p\} \tag{3.2}
\end{equation*}
$$

(3) (preserved divergence and mean) $\sigma\left(W_{\text {sol }}^{s, p}\right) \subset \mathbb{W}_{\text {sol }}^{s, p}$, and $\int_{\mathbb{T}^{3}} \sigma(u)=0$ if $\int_{\mathbb{T}^{3}} u=0$, and
(4) (sublinearity of the gradient)

$$
\begin{equation*}
\sum_{i=1}^{3}\left\|\nabla\left(\sigma_{i}(u)\right)\right\|_{\mathbb{L}^{2}} \leq C\|u\|_{2} \tag{3.3}
\end{equation*}
$$

Under these conditions, we have the following statement.
THEOREM 3.1. (Local strong solution up to a stopping time) Let $p>3$ and $u_{0} \in L^{p}\left(\Omega ; L^{p}\left(\mathbb{T}^{3}\right)\right)$. Then there exists a pathwise unique local strong solution $(u, \tau)$ to (1.1)-(1.3) such that

$$
\mathbb{E}\left[\sup _{0 \leq s \leq \tau}\|u(s, \cdot)\|_{p}^{p}+\int_{0}^{\tau} \sum_{j} \int_{\mathbb{T}^{3}}\left|\nabla\left(\left|u_{j}(s, x)\right|^{p / 2}\right)\right|^{2} d x d s\right] \leq C \mathbb{E}\left[\left\|u_{0}\right\|_{p}^{p}+1\right]
$$

where $C>0$ is a constant depending on $p$.
For the sake of completeness, we state two auxiliary results that were proven in $[\mathbf{K X Z}]$ (cf. Theorem 4.1 and Lemma 4.4 in [ $\mathbf{K X Z}]$ ).

Lemma 3.2. Let $2<p<\infty$ and $0<T<\infty$. Suppose that $u_{0} \in L^{p}\left(\Omega, L^{p}\left(\mathbb{T}^{d}\right)\right)$, $f \in L^{p}(\Omega \times$ $\left.[0, T], W^{-1, q}\left(\mathbb{T}^{d}\right)\right)$, and $g \in L^{p}\left(\Omega \times[0, T], \mathbb{L}^{p}\left(\mathbb{T}^{d}\right)\right)$ are $\mathbb{R}^{D}$-valued with $x$-mean zero $(\omega, t)$ a.s., and

\frac{d p}{p+d-2}<q \leq p
$$

provided $d \geq 2$, or $1<q \leq p$ if $d=1$. Then there exists a unique maximal solution $u \in L^{p}\left(\Omega ; C\left([0, T], L^{p}\right)\right)$ to

$$
\begin{aligned}
d u(t, x) & =\Delta u(t, x) d t+f(t, x) d t+g(t, x) d \mathbb{W}(t), \\
u(0, x) & =u_{0}(x) \quad \text { a.s. }, \quad x \in \mathbb{T}^{d} .
\end{aligned}
$$

Moreover,

$$
\begin{align*}
& \mathbb{E}\left[\sup _{0 \leq t \leq T}\|u(t, \cdot)\|_{p}^{p}+\sum_{j=1}^{D} \int_{0}^{T} \int_{\mathbb{T}^{d}}\left|\nabla\left(\left|u_{j}(t, x)\right|^{p / 2}\right)\right|^{2} d x d t\right] \\
& \quad \leq C \mathbb{E}\left[\left\|u_{0}\right\|_{p}^{p}+\int_{0}^{T}\|f(t, \cdot)\|_{-1, q}^{p} d t+\sum_{j=1}^{D} \int_{0}^{T} \int_{\mathbb{T}^{d}}\left\|g_{j}(t, x)\right\|_{l^{2}(\mathcal{H}, \mathbb{R})}^{p} d x d t\right], \tag{3.4}
\end{align*}
$$

where $C>0$ depends on $T$ and $p$.
The following lemma is essential when passing to the limit in $\left\|\left|u^{(n)}\right|^{p / 2}\right\|_{H^{1}}$.
Lemma 3.3. Let $p \geq 2$. If

$$
\left.u_{n} \rightarrow u \text { in } L^{p}\left(\Omega ; L^{\infty}\left([0, T], L^{p}\left(\mathbb{T}^{d}\right)\right)\right)\right) \text { as } n \rightarrow \infty
$$

and

$$
\nabla\left(\left|u_{n}(\omega, t, x)\right|^{p / 2}\right) \text { are uniformly bounded in } L^{2}\left(\Omega \times[0, T], L^{2}\left(\mathbb{T}^{d}\right)\right)
$$

then

$$
\begin{equation*}
\liminf _{n \rightarrow \infty} \mathbb{E}\left[\int_{0}^{T} \int_{\mathbb{T}^{d}}\left|\nabla\left(\left|u_{n}(\omega, t, x)\right|^{p / 2}\right)\right|^{2} d x d t\right] \geq \mathbb{E}\left[\int_{0}^{T} \int_{\mathbb{T}^{d}}\left|\nabla\left(|u(\omega, t, x)|^{p / 2}\right)\right|^{2} d x d t\right] \tag{3.5}
\end{equation*}
$$

Note that in (3.4) and (3.5), $T$ can be replaced by a stopping time by using indicator functions.

## 4. Existence of a local strong solution

Let $d=3$, and fix $p>3$; in particular, we allow all constants to depend on $p$ without mention. Denote

$$
\mathcal{S}_{n} f(x)=\sum_{\left|k_{1}\right| \leq n,\left|k_{2}\right| \leq n,\left|k_{3}\right| \leq n} \hat{f}(k) e^{2 \pi i k \cdot x}, \quad f \in L^{1}\left(\mathbb{T}^{3}\right), \quad n \in \mathbb{N}
$$

i.e.,

$$
\begin{equation*}
\mathcal{S}_{n}=\mathcal{T}_{(n, n, n)} \tag{4.1}
\end{equation*}
$$

(cf. (2.2) and (4.1)). As pointed out in Section 2, $\mathcal{S}_{n}$ is a continuous linear operator in all $L^{q}$ spaces $(1<q<\infty)$. To construct a solution of (1.1)-(1.3), we consider for $n \in \mathbb{N}$ a finite dimensional approximation

$$
\begin{align*}
& d u^{(n)}=\Delta u^{(n)} d t-\mathcal{S}_{n} \mathcal{P}\left(\left(u^{(n)} \cdot \nabla\right) u^{(n)}\right) d t+\mathcal{S}_{n} \sigma\left(u^{(n)}\right) d \mathbb{W}(t),  \tag{4.2}\\
& \nabla \cdot u^{(n)}=0  \tag{4.3}\\
& u^{(n)}(0, x)=\mathcal{S}_{n} u_{0}(x), \quad x \in \mathbb{T}^{3} . \tag{4.4}
\end{align*}
$$

Note that the cancellation property of the convective term remains true in $\mathcal{S}_{n} L^{2}$; namely, for $u, v \in$ $\left(\mathcal{S}_{n} L^{2}\left(\mathbb{T}^{3}\right)\right)^{3} \subset\left(H^{1}\left(\mathbb{T}^{3}\right)\right)^{3}$ with $\nabla \cdot u=\nabla \cdot v=0$, we have

$$
\begin{array}{rl}
\int_{\mathbb{T}^{d}} u \cdot \mathcal{S}_{n} & \mathcal{P} \\
= & (v \cdot \nabla) u) d x=\int_{\mathbb{T}^{d}}\left(u_{j} \mathcal{S}_{n}\left(v_{i} \partial_{i} u_{j}\right)+u_{j} \mathcal{S}_{n} R_{j} R_{k} \partial_{i}\left(v_{i} u_{k}\right)\right) d x  \tag{4.5}\\
& \left.=u_{j} v_{i} \partial_{i} u_{j}+u_{j} R_{j} R_{k} \partial_{i}\left(v_{i} u_{k}\right)\right) d x \\
& \left(-\frac{1}{2}\left(u_{j} u_{j}\right) \partial_{i} v_{i}-\partial_{j} u_{j} R_{k} R_{i}\left(v_{i} u_{k}\right)\right) d x=0
\end{array}
$$

where $R_{i}$ are the Riesz transforms defined in (2.1); in the third inequality, we used $R_{j} \partial_{i}=\partial_{j} R_{i}$. If $\int_{\mathbb{T}^{3}} u=\int_{\mathbb{T}^{3}} v=0$, then

$$
\begin{equation*}
\left|\int_{\mathbb{T}^{d}} u \cdot \mathcal{S}_{n} \mathcal{P}((v \cdot \nabla) w) d x\right| \leq C\|u\|_{6}\|v\|_{3}\|\nabla w\|_{2} \leq C\|\nabla u\|_{2}\|v\|_{2}^{1 / 2}\|\nabla v\|_{2}^{1 / 2}\|\nabla w\|_{2} \tag{4.6}
\end{equation*}
$$

Also, note that in $\mathcal{S}_{n} L^{2}\left(\mathbb{T}^{3}\right)$ we have the norm equivalence

$$
\frac{1}{C}\|f\|_{2} \leq\|\nabla f\|_{2} \leq C_{n}\|f\|_{2}
$$

under the mean-zero condition, where the second constant depends on the dimension $n$ of the projection $\mathcal{S}_{n}$, and the first constant is universal. Hence, we conclude from (4.6) that

$$
\begin{equation*}
\left|\int_{\mathbb{T}^{d}} v \cdot \mathcal{S}_{n} \mathcal{P}((v \cdot \nabla) w) d x\right| \leq C_{n}\|u\|_{2}\|v\|_{2}\|w\|_{2} \tag{4.7}
\end{equation*}
$$

for $u, v, w \in \mathcal{S}_{n} L^{2}\left(\mathbb{T}^{3}\right)$ with vanishing means.
The next result extends Theorem 3.1 and Lemma 3.1 in $[\mathbf{F}]$ from an additive to the multiplicative noise. The statement is proven by modifying the arguments in $[\mathbf{F}]$ and $[\mathbf{K X Z}]$. For the sake of completeness and conciseness, we include a sketch of the proof.

LEmma 4.1. Let $T>0$, and suppose $u_{0} \in L^{2}\left(\Omega ; L^{2}\right)$ satisfies $\nabla \cdot u_{0}=0$ and $\int_{\mathbb{T}^{3}} u_{0}=0$. Then for all $n \in \mathbb{N}$, the initial value problem (4.2)-(4.4) has a unique strong solution $u^{(n)} \in L^{2}\left(\Omega ; C\left([0, T], L^{2}\right)\right) \cap$ $L^{2}\left(\Omega ; L^{2}\left([0, T], H^{1}\right)\right)$. Moreover,

$$
\begin{equation*}
\mathbb{E}\left[\sup _{0 \leq s \leq T}\left\|u^{(n)}(s)\right\|_{2}^{2}+\int_{0}^{T}\left\|\nabla u^{(n)}(s)\right\|_{2}^{2} d s\right] \leq C \tag{4.8}
\end{equation*}
$$

for some positive constant $C$ independent of $n$.

Proof of Lemma 4.1. We fix $n \in \mathbb{N}$ and write $\mathcal{S}$ instead of $\mathcal{S}_{n}$ for simplicity. Let $u^{(0)}$ be the unique strong solution of the standard heat equation subject to the initial data $\mathcal{S} u_{0}$. Consider the iteration

\begin{align*}
& d u^{(k)}=\Delta u^{(k)} d t-\left(\phi_{k}^{M}\right)^{2} \mathcal{S P}\left(\left(u^{(k)} \cdot \nabla\right) u^{(k)}\right) d t+\left(\phi_{k-1}^{M}\right)^{2} \mathcal{S} \sigma\left(u^{(k-1)}\right) d \mathbb{W}(t),  \tag{4.9}\\
& \nabla \cdot u^{(k)}=0,  \tag{4.10}\\
& u^{(k)}(0, x)=\mathcal{S} u_{0}(x), \quad x \in \mathbb{T}^{3}, \tag{4.11}
\end{align*}
$$

where

$$
\phi_{k}^{M}=\phi^{M}\left(\left\|u^{(k)}(t, \cdot)\right\|_{2}\right)
$$

with $\phi^{M} \in C^{\infty}(\mathbb{R}), \phi^{M}(x)=1$ if $|x| \leq M / 2,0 \leq \phi^{M}(x) \leq 1$ if $M / 2 \leq|x| \leq M$, and $\phi^{M}(x)=0$ if $|x| \geq M$. Since the noise is additive and the bilinear term is globally Lipschitz in $u^{(k)}$, due to the factor $\left(\phi_{k}^{M}\right)^{2}$, we can prove inductively as in $[\mathbf{K X Z}]$ that (4.9)-(4.11) has a pathwise unique strong solution in $L^{2}\left(\Omega ; C\left([0, T], L^{2}\right)\right)$ for all $k \in \mathbb{N}$. Furthermore, by (4.5), we conclude that

$$
\begin{equation*}
\mathbb{E}\left[\sup _{0 \leq s \leq T}\left\|u^{(k)}(s)\right\|_{2}^{2}+\sum_{j} \int_{0}^{T} \int_{\mathbb{T}^{3}}\left|\nabla u_{j}^{(k)}(s, x)\right|^{2} d x d s\right] \leq C_{T, M}\left(\mathbb{E}\left[\left\|u_{0}\right\|_{2}^{2}\right]+1\right) \tag{4.12}
\end{equation*}
$$

Denoting $v^{(k)}=u^{(k)}-u^{(k-1)}$ and applying the Itô formula to the equation for the difference, we obtain

$$
\mathbb{E}\left[\sup _{0 \leq s \leq t}\left\|v^{(k)}(s)\right\|_{2}^{2}\right] \leq C_{M} t \mathbb{E}\left[\sup _{0 \leq s \leq t}\left\|v^{(k-1)}(s)\right\|_{2}^{2}\right]
$$

where we also used (4.6)-(4.7). This implies that there exists a fixed point $u_{M}$ of (4.9)-(4.11) in $L^{2}\left(\Omega ; C\left([0, t], L^{2}\right)\right)$ for a sufficiently small $t \in(0, T]$. The square of the truncation function $\phi_{k}^{M}$ was needed for claiming that such an interval is uniform with respect to $k$ and for previously establishing the existence of $u^{(k)}$. Passing to the limit in (4.12) by using Lemma 3.3, we conclude that (4.12) holds for $u_{M}$ with $T$ being replaced by $t$. Utilizing this estimate, we can show that $u_{M}$ is a solution of the truncated finite-dimensional model

$$
\begin{align*}
& d u=\Delta u d t-\left(\phi_{u}^{M}\right)^{2} \mathcal{S P}((u \cdot \nabla) u) d t+\left(\phi_{u}^{M}\right)^{2} \mathcal{S} \sigma(u) d \mathbb{W}(t),  \tag{4.13}\\
& \nabla \cdot u=0  \tag{4.14}\\
& u(0, x)=\mathcal{S} u_{0}(x), \quad x \in \mathbb{T}^{3} . \tag{4.15}
\end{align*}
$$

The pathwise uniqueness of the solution follows from a contraction argument similarly to above. The extension of the existence and uniqueness results from a small time interval to $[0, T]$ is obtained by using the pathwise uniqueness, and (4.12) still holds.

To address the non-truncated model (4.2)-(4.4), we introduce the stopping time

\eta_{n}^{M}=\inf \left\{t>0:\left\|u^{(n)}(s)\right\|_{2} \geq \frac{M}{2}\right\}

Clearly, (4.2)-(4.4) agrees with (4.13)-(4.15) on $\left[0, \eta_{n}^{M} \wedge T\right]$ and thus we have a pathwise unique strong solution at least up to $\eta_{n}^{M} \wedge T$. Applying the Itô formula to (4.2) on [0, $\left.\eta_{n}^{M} \wedge T\right]$ and using (4.5), we obtain the energy estimate

\begin{align*}
& \mathbb{E}\left[\sup _{0 \leq s \leq \eta_{n}^{M} \wedge T}\left\|u^{(n)}(s)\right\|_{2}^{2}+\sum_{j} \int_{0}^{\eta_{n}^{M} \wedge T} \int_{\mathbb{T}^{3}}\left|\nabla u_{j}^{(n)}(s, x)\right|^{2} d x d s\right] \\
& \quad \leq C \mathbb{E}\left[\left\|u_{0}\right\|_{2}^{2}+\sum_{j} \int_{0}^{\eta_{n}^{M} \wedge T}\left\|\mathcal{S} \sigma_{j}\left(u^{(n)}\right)(s)\right\|_{\mathbb{L}^{2}} d s\right] \tag{4.16}
\end{align*}
$$

which by (3.1) and Lemma 2.2 leads to

$$
\begin{gather*}
\mathbb{E}\left[\sup _{0 \leq s \leq \eta_{n}^{M} \wedge T}\left\|u^{(n)}(s)\right\|_{2}^{2}\right] \leq C\left(\mathbb{E}\left[\left\|u_{0}\right\|_{2}^{2}+\int_{0}^{\eta_{n}^{M} \wedge T}\left(\left\|u^{(n)}(s)\right\|_{2}^{2}+1\right) d s\right]\right)  \tag{4.17}\\
\leq C_{T} \mathbb{E}\left[\left\|u_{0}\right\|_{2}^{2}+1\right]+C \int_{0}^{T} \mathbb{E}\left[\sup _{0 \leq s \leq \eta_{n}^{M} \wedge t}\left\|u^{(n)}(s)\right\|_{2}^{2}\right] d t
\end{gather*}
$$

Then Grönwall's lemma yields

$$
\mathbb{E}\left[\sup _{0 \leq s \leq T}\left\|u^{(n)}\left(s \wedge \eta_{n}^{M}\right)\right\|_{2}^{2}\right]=\mathbb{E}\left[\sup _{0 \leq s \leq \eta_{n}^{M} \wedge T}\left\|u^{(n)}(s)\right\|_{2}^{2}\right] \leq C_{T} \mathbb{E}\left[\left\|u_{0}\right\|_{2}^{2}+1\right]
$$

Note that

$$
\mathbb{E}\left[\mathbb{1}_{\eta_{n}^{M} \leq T}\left\|u^{(n)}\left(\eta_{n}^{M}\right)\right\|_{2}^{2}\right] \leq \mathbb{E}\left[\sup _{0 \leq s \leq T}\left\|u^{(n)}\left(s \wedge \eta_{n}^{M}\right)\right\|_{2}^{2}\right]
$$

Then, $\mathbb{P}\left(\eta_{n}^{M} \leq T\right) \leq C_{T} \mathbb{E}\left[\left\|u_{0}\right\|_{2}^{2}+1\right] / M^{2}$. Also, observe that $\eta_{n}^{M}$ is an increasing function of $M$ and that

$$
\mathbb{P}\left(u_{M}=u_{K}, t \in\left[0, \eta_{n}^{M}\right]\right)=1
$$

if $M<K$. Then defining $\eta^{\infty}=\lim _{M \rightarrow \infty} \eta_{n}^{M}$, we may uniquely define a process $u^{\infty}$ such that $u^{\infty}=u_{M}$ on $\left[0, \eta_{n}^{M}\right]$, and $u^{\infty}$ solves (4.2)-(4.4) on $\left[0, \eta^{\infty}\right]$. Since $\mathbb{P}\left(\eta^{\infty} \leq T\right)=\lim _{M \rightarrow \infty} \mathbb{P}\left(\eta_{n}^{M} \leq T\right)=0$ and $T$ is arbitrary, the solution is global. Note that (4.16) also implies

$$
\begin{aligned}
& \mathbb{E}\left[\sup _{0 \leq s \leq \eta_{n}^{M} \wedge T}\left\|u^{(n)}(s)\right\|_{2}^{2}+\sum_{j} \int_{0}^{\eta_{n}^{M} \wedge T} \int_{\mathbb{T}^{3}}\left|\nabla u_{j}^{(n)}(s, x)\right|^{2} d x d s\right] \\
& \quad \leq C_{T} \mathbb{E}\left[\left\|u_{0}\right\|_{2}^{2}+1\right]+C \int_{0}^{T} \mathbb{E}\left[\sup _{0 \leq s \leq \eta_{n}^{M} \wedge t}\left\|u^{(n)}(s)\right\|_{2}^{2}+\sum_{j} \int_{0}^{\eta_{n}^{M} \wedge t} \int_{\mathbb{T}^{3}}\left|\nabla u_{j}^{(n)}(s, x)\right|^{2} d x d s\right] d t .
\end{aligned}
$$

Applying Grönwall's lemma and sending $M \rightarrow \infty$ in (4.17), we obtain (4.8), concluding the proof.
We proceed by deriving an $L^{p}$ estimate of $u^{(n)}$. For every $M>0$, we introduce stopping times relative to solutions $\left\{u^{(n)}\right\}$ as

$$
\begin{equation*}
\tau_{n}^{M}=\inf \left\{t>0: \sup _{0 \leq s \leq t}\left\|u^{(n)}(s)\right\|_{p}+\left(\int_{0}^{t}\left\|u^{(n)}(s)\right\|_{3 p}^{p} d s\right)^{1 / p} \geq M\right\} \tag{4.18}
\end{equation*}
$$

Adapting the proof in $\left[\mathbf{K Z}\right.$, Lemma 3] (by contradiction and passing to the limit) and assuming $\int_{\mathbb{T}^{3}} f=0$, we obtain the Gagliardo-Nirenberg inequality on $\mathbb{T}^{3}$,

$$
\left\||f|^{p / 2}\right\|_{r} \leq C_{0}\left\||f|^{p / 2}\right\|_{2}^{1-\alpha}\left\|\nabla\left(|f|^{p / 2}\right)\right\|_{2}^{\alpha}
$$

where $\alpha=3(1 / 2-1 / r)$ and $C_{0}>0$ is independent of $f$. In particular, setting $r=6$ yields

$$
\begin{equation*}
\|f\|_{3 p}^{p} \leq C_{0}\left\|\nabla\left(|f|^{p / 2}\right)\right\|_{2}^{2} \tag{4.19}
\end{equation*}
$$

provided $f$ has $x$-mean zero. We need this inequality to prove the next lemma which asserts the boundedness of $\left\{u^{(n)}\right\}$ in $L^{p}\left(\Omega ; C\left(\left[0, S \wedge \tau_{n}^{M}\right], L^{p}\right)\right)$ for some deterministic value $S$ that is uniform with respect to $n$.

Lemma 4.2. Let $p>3$ and $K \geq 1$. Suppose that $\nabla \cdot u_{0}=0, \int_{\mathbb{T}^{3}} u_{0}=0$, and $\left\|u_{0}\right\|_{p} \leq K$ a.s. Then there exist $M>K$ and $S>0$ such that

for any fixed $K>0$ and the corresponding $M$.

The choice of $S$ depends on $M$ and the constants of embedding inequalities, but is independent of $n$.

& +\frac{p(p-1)}{2} \int_{0}^{t} \int_{\mathbb{T}^{d}}\left|u_{j}^{(n)}\right|^{p-2}\left\|\mathcal{S}_{n} \sigma_{j}\left(u^{(n)}\right)\right\|_{l^{2}}^{2} d x d r

Then there exist $M>K$, a stopping time $\tau_{M}$ with $\mathbb{P}\left(\tau_{M}>0\right)=1$, and a subsequence $\left\{u^{\left(n_{k}\right)}\right\}$ so that

for some adapted process $u \in L^{p}\left(\Omega, C\left(\left[0, \tau_{M}\right], L^{p}\right)\right) \cap L^{p}\left(\Omega, L^{p}\left(\left[0, \tau_{M}\right], L^{3 p}\right)\right)$.

Proof of Lemma 4.4. Using (4.19) and (4.21), there exists $M$ be sufficiently large relative to $K$ so that

Note that $\eta_{k} \leq \tau_{n_{k}}^{M}$ (cf. (4.18)). Then, by Chebyshev's inequality,

& \quad \leq \mathbb{P}\left(\sup _{0 \leq r \leq \eta_{k} \wedge \eta_{k+1} \wedge S}\left\|w^{\left(n_{k}, n_{k+1}\right)}(r, \omega)\right\|_{p}^{p} \geq 2^{-k p-3 p}\right) \\
& \quad+\mathbb{P}\left(\int_{0}^{\eta_{k} \wedge \eta_{k+1} \wedge S}\left\|w^{\left(n_{k}, n_{k+1}\right)}(r, \omega)\right\|_{3 p}^{p} d r \geq 2^{-k p-3 p}\right) \\
& \quad \leq 2^{k p+3 p+1} 4^{-k p}=2^{-k p+3 p+1}
\end{aligned}

Next, by the Borel-Cantelli lemma,

& \quad \quad+\left(\int_{0}^{\eta_{k}}\left\|u^{\left(n_{k}\right)}(r, \cdot)\right\|_{3 p}^{p} d r\right)^{1 / p}-\left(\int_{0}^{\eta_{k}}\left\|w^{\left(n_{k}, n_{k+1}\right)}(r, \cdot)\right\|_{3 p}^{p} d r\right)^{\frac{1}{p}} \\
& \quad \geq \frac{M}{2}+2^{-k}-2^{-k-2}>\frac{M}{2}+2^{-k-1}

which contradicts $\eta_{k}<\eta_{k+1} \wedge S$. Then, $\Omega_{N} \cap\left\{\eta_{k}<\eta_{k+1} \wedge S\right\}=\emptyset$, and $\left\{\eta_{k}(\omega) \wedge S\right\}$ is a non-increasing sequence in $\Omega_{N}$. Also note that $\Omega_{N}$ monotonically expands to the whole probability space, and then $\tau_{M}=\lim _{k \rightarrow \infty} \eta_{k} \wedge S$ is well-defined almost everywhere in $\Omega$. It remains to show that $\left\{u^{\left(n_{k}\right)}\right\}$ has an $\omega$-pointwise limit and the limit belongs to $L^{p}\left(\Omega, C\left(\left[0, \tau_{M}\right], L^{p}\right)\right) \cap$ $L^{p}\left(\Omega, L^{p}\left(\left[0, \tau_{M}\right], L^{3 p}\right)\right)$. Indeed, by (4.33) and [KXZ, Lemma 5.2],

Using (4.20), we obtain that $\left\{u^{\left(n_{k}\right)} \mathbb{1}_{\Omega_{N}}\right\}$ are uniformly bounded in $L^{p}\left(\Omega, L^{\infty}\left(\left[0, \tau_{M}\right], L^{p}\right)\right) \cap$ $L^{p}\left(\Omega, L^{p}\left(\left[0, \tau_{M}\right], L^{3 p}\right)\right)$. Thus, the same conclusion holds for $u_{N}$ and $u$, which completes the proof.

Next, we prove the pathwise uniqueness of local strong solutions.

for all $\phi \in C^{\infty}\left(\mathbb{T}^{3}\right), s \in[0, S]$, and $m \leq l$. Also, (4.33) holds on $\left[0, \zeta_{m}\right]$ for $\left\{u_{l}\right\}_{l \geq m}$. Utilizing Lemma 4.4 and the boundedness of $\left\{u^{\left(n_{k}\right)}\right\}$ in $L_{\omega}^{p} L_{t}^{\infty} L_{x}^{p}$ on $\left[0, \zeta_{m}\right]$, we may pass to the limit in (4.35) and obtain

& \quad \leq C\|\phi\|_{2} \mathbb{E}\left[\left(\int_{0}^{\zeta_{m}}\left(\int_{\mathbb{T}^{3}}\left\|\mathcal{S}_{n_{l}}\left(\sigma\left(u^{\left(n_{l}\right)}\right)-\sigma(u)\right)\right\|_{l^{2}}^{p} d x\right)^{2 / p} d r\right)^{1 / 2}\right] \\

\mathbb{E}\left[\mathbb{1}_{\Omega_{N}} \sup _{0 \leq s \leq \tau_{M}}\left\|u^{\left(n_{l}\right)}(s, \cdot)\right\|_{p}^{p}+\mathbb{1}_{\Omega_{N}} \int_{0}^{\tau_{M}} \sum_{j} \int_{\mathbb{T}^{3}}\left|\nabla\left(\left|u_{j}^{\left(n_{l}\right)}(s, x)\right|^{p / 2}\right)\right|^{2} d x d s\right] \leq C \mathbb{E}\left[\left\|u_{0}\right\|_{p}^{p}+1\right]
$$

if $N \leq l$. Then we use Lemmas 3.3 and 4.3 , send $l \rightarrow \infty$ in above inequality, and send $N \rightarrow \infty$, arriving at

$$
\begin{equation*}
\mathbb{E}\left[\sup _{0 \leq s \leq \tau_{M}}\|u(s, \cdot)\|_{p}^{p}+\int_{0}^{\tau_{M}} \sum_{j} \int_{\mathbb{T}^{3}}\left|\nabla\left(\left|u_{j}(s, x)\right|^{p / 2}\right)\right|^{2} d x d s\right] \leq C \mathbb{E}\left[\left\|u_{0}\right\|_{p}^{p}+1\right] \tag{4.39}
\end{equation*}
$$

To remove the condition $\left\|u_{0}\right\|_{p} \leq K$ a.s., we denote the local strong solution corresponding to the initial data $u_{0} \mathbb{1}_{k \leq\left\|u_{0}\right\|_{p}<k+1}$ by $\left(u_{(k)}, \tau_{k}\right)$, i.e.,

$$
\begin{align*}
& \mathbb{1}_{\left[0, \tau_{k}\right]}(s)\left(u_{(k)}(s), \phi\right)=\left(u_{0} \mathbb{1}_{k \leq\left\|u_{0}\right\|_{p}<k+1}, \phi\right)+\mathbb{1}_{\left[0, \tau_{k}\right]}(s) \int_{0}^{s}\left(u_{(k)}, \Delta \phi\right) d r+\mathbb{1}_{\left[0, \tau_{k}\right]}(s) \int_{0}^{s}\left(\sigma\left(u_{(k)}\right), \phi\right) d \mathbb{W}_{r} \\
& \quad+\sum_{j} \mathbb{1}_{\left[0, \tau_{k}\right]}(s) \int_{0}^{s}\left(\mathcal{P}\left(\left(u_{(k)}\right)_{j} u_{(k)}\right), \partial_{j} \phi\right) d r, \quad(s, \omega) \text {-a.e. } \tag{4.40}
\end{align*}
$$

for all $k \in \mathbb{N}$. Define

$$
u=\sum_{k=0}^{\infty} u_{(k)} \mathbb{1}_{k \leq\left\|u_{0}\right\|_{p}<k+1}, \quad \tau=\sum_{k=0}^{\infty} \tau_{k} \mathbb{1}_{k \leq\left\|u_{0}\right\|_{p}<k+1}
$$

Since $\mathbb{P}\left(\tau_{k}>0\right)=1$ for all $\tau_{k}$, we have

$$
\mathbb{P}(\tau>0)=\sum_{k=0}^{\infty} \mathbb{P}\left(\tau_{k}>0 \mid k \leq\left\|u_{0}\right\|_{p}<k+1\right) \mathbb{P}\left(k \leq\left\|u_{0}\right\|_{p}<k+1\right)=\sum_{k=0}^{\infty} \mathbb{P}\left(k \leq\left\|u_{0}\right\|_{p}<k+1\right)=1
$$

Next, note $\mathbb{1}_{\left[0, \tau_{k}\right]} \mathbb{1}_{k \leq\left\|u_{0}\right\|_{p}<k+1}=\mathbb{1}_{[0, \tau]} \mathbb{1}_{k \leq\left\|u_{0}\right\|_{p}<k+1}$. Also, $\sum_{k=0}^{\infty} \sigma\left(u_{(k)}\right) \mathbb{1}_{k \leq\left\|u_{0}\right\|_{p}<k+1}$ agrees with $\sigma(u)$ in $\mathbb{L}^{p}$. Multiplying both sides of (4.40) by $\mathbb{1}_{k \leq\left\|u_{0}\right\|_{p}<k+1}$ and summing over $k$, we obtain

$$
\begin{gathered}
\mathbb{1}_{[0, \tau]}(s)(u(s), \phi)=\left(u_{0}, \phi\right)+\mathbb{1}_{[0, \tau]}(s) \int_{0}^{s}(u, \Delta \phi) d r+\mathbb{1}_{[0, \tau]}(s) \int_{0}^{s}(\sigma(u), \phi) d \mathbb{W}_{r} \\
\quad+\sum_{j} \mathbb{1}_{[0, \tau]}(s) \int_{0}^{s}\left(\mathcal{P}\left(u_{j} u\right), \partial_{j} \phi\right) d r, \quad(s, \omega) \text {-a.e. }
\end{gathered}
$$

namely, $(u, \tau)$ is a local solution associated with a general initial data $u_{0} \in L^{p}\left(\Omega, L^{p}\left(\mathbb{T}^{3}\right)\right)$.

Since $u_{(k)} \in C\left(\left[0, \tau_{k}\right], L^{p}\right)$ almost surely, we have $u \in C\left([0, \tau], L^{p}\right)$ almost surely. In addition, using (4.39) and the pathwise uniqueness, we obtain

$$
\begin{aligned}
& \mathbb{E}\left[\sup _{0 \leq s \leq \tau}\|u(s, \cdot)\|_{p}^{p}+\sum_{j} \int_{0}^{\tau} \int_{\mathbb{T}^{3}}\left|\nabla\left(\left|u_{j}(s, x)\right|^{p / 2}\right)\right|^{2} d x d s\right] \\
& \quad=\lim _{k \rightarrow \infty} \mathbb{E}\left[\mathbb{1}_{0 \leq\left\|u_{0}\right\|_{p}<k+1}\left(\sup _{0 \leq s \leq \tau}\|u(s, \cdot)\|_{p}^{p}+\sum_{j} \int_{0}^{\tau} \int_{\mathbb{T}^{3}}\left|\nabla\left(\left|u_{j}(s, x)\right|^{p / 2}\right)\right|^{2} d x d s\right)\right] \\
& \quad \leq \lim _{k \rightarrow \infty} C \mathbb{E}\left[\mathbb{1}_{0 \leq\left\|u_{0}\right\|_{p}<k+1}\left\|u_{0}\right\|_{p}^{p}\right]+C \leq C \mathbb{E}\left[\left\|u_{0}\right\|_{p}^{p}\right]+C,
\end{aligned}
$$

concluding the proof.
