# Commutativity of quantization with conic reduction for torus actions on compact CR manifolds

#### Abstract

We define conic reduction $X_{\nu}^{\text {red }}$ for torus actions on the boundary $X$ of a strictly pseudo-convex domain and for a given weight $\nu$ labeling a unitary irreducible representation. There is a natural residual circle action on $X_{\nu}^{\text {red }}$. We have two natural decompositions of the corresponding Hardy spaces $H(X)$ and $H\left(X_{\nu}^{\text {red }}\right)$. The first one is given by the ladder of isotypes $H(X)_{k \nu}, k \in \mathbb{Z}$, the second one is given by the $k$-th Fourier components $H\left(X_{\nu}^{\text {red }}\right)_{k}$ induced by the residual circle action. The aim of this paper is to prove that they are isomorphic for $k$ sufficiently large. The result is given for spaces of $(0, q)$-forms with $L^{2}$-coefficient when $X$ is a CR manifold with non-degenerate Levi-curvature.

## 1 Introduction

Let $X$ be the boundary of a strictly pseudo-convex domain $D$ in $\mathbb{C}^{n+1}$. Then $\left(X, T^{1,0} X\right)$ is a contact manifold of dimension $2 n+1, n \geq 1$, where $T^{1,0} X$ is the sub-bundle of $T X \otimes \mathbb{C}$ defining the CR structure. We denote by $\omega_{0} \in \mathcal{C}^{\infty}\left(X, T^{*} X\right)$ the contact 1-form whose kernel is the horizontal bundle $H X \subset T X$, we refer to Section 2.1 for definitions. Associated with this data we can define the Hardy space $H(X)$, it is the space of boundary values of holomorphic functions in $D$ which lie in $L^{2}(X)$, the Hilbert space of square integrable functions on $X$. Suppose a contact and CR action of a $t$-dimensional torus $\mathbb{T}$

[^0]is given; we denote by $\mu: X \rightarrow \mathfrak{t}^{*}$ the associated CR moment map. Fix a weight $i \nu$ in the lattice $i \mathbb{Z}^{t} \subset \mathfrak{t}^{*}$, if $0 \in \mathfrak{t}^{*}$ does not lie in the image of the moment map the isotypes

H(X)_{k \nu}=\left\{f \in H(X):\left(e^{i \theta} \cdot f\right)(x)=e^{i k\langle\nu, \theta\rangle} f(x), \theta \in \mathbb{R}^{t}\right\}, \quad k \in \mathbb{Z},

are finite dimensional.
Suppose that the ray $i \mathbb{R}_{+} \cdot \nu \in \mathfrak{t}^{*}$ is transversal to $\mu$, then $X_{\nu}:=\mu^{-1}\left(i \mathbb{R}_{+} \cdot \nu\right)$ is a sub-manifold of $X$ of codimension $t-1$. There is a well-defined locally free action of $\mathbb{T}_{\nu}^{t-1}:=\exp _{\mathbb{T}}(i \operatorname{ker} \nu)$ on $X_{\nu}$, the resulting orbifold $X_{\nu}^{\text {red }}$ is called conic reduction of $X$ with respect to the weight $\nu$. Let $\varphi$ be an Euclidean product on $\mathfrak{t}$, we shall also use the symbol $\langle\cdot, \cdot\rangle$, and denote by $\lambda^{\varphi} \in \mathfrak{t}$ be uniquely determined by $\lambda=\varphi\left(\lambda^{\varphi}, \cdot\right)$ and $\|\lambda\|$ the corresponding norm. By abuse of notation we write $\lambda$ for $\lambda^{\varphi}$ and we identify $\mathfrak{t} \cong i \mathbb{R}^{t}$ with its dual. We set
$$
\operatorname{ker} \nu=\nu^{\perp}:=\{\lambda \in \mathfrak{t}:\langle\nu, \lambda\rangle=0\}
$$

The locus $X_{\nu}$ is $\mathbb{T}$-invariant, we will always assume that the action of $\mathbb{T}$ on $X_{\nu}$ is locally free. After replacing $\mathbb{T}$ with its quotient by a finite subgroup, we may and will assume without loss of generality that the action is generically free. In Section 2.1, we show that $X_{\nu}^{\text {red }}$ is CR manifold with positive definite Levi form of dimension $2 n-2 t+3$.

Let us define $\mathbb{T}_{\nu}^{1}:=\exp _{\mathbb{T}}(i \nu)$, if $\nu$ is coprime, we have a Lie group isomorphism

$$
\kappa_{\nu}: S^{1} \rightarrow \mathbb{T}_{\nu}^{1}, \quad e^{i \theta} \mapsto e^{i \theta \nu}
$$

between $\mathbb{T}_{\nu}^{1}:=\exp _{\mathbb{T}}(i \nu)$ and the circle $S^{1}$. Let us denote by

$$
\overline{\mathbb{T}_{\nu}^{1}}:=\mathbb{T} / \mathbb{T}_{\nu}^{t-1} \cong \mathbb{T}_{\nu}^{1} /\left(\mathbb{T}_{\nu}^{1} \cap \mathbb{T}_{\nu}^{t-1}\right)
$$

then the character $\chi_{\nu}: \mathbb{T} \rightarrow S^{1}, \chi_{\nu}\left(e^{i \theta}\right):=e^{i k\langle\nu, \theta\rangle}$, being trivial on $\mathbb{T}_{\nu}^{t-1}$, descends to a character $\chi_{\nu}^{\prime}: \overline{\mathbb{T}_{\nu}^{1}} \rightarrow S^{1}$ which is a Lie group isomorphism, see [P3, Lemma 10]. Thus, we have a locally free circle action of $\overline{\mathbb{T}_{\nu}^{1}}$ on $X_{\nu}^{\text {red }}$, which induces an action on the Hardy space $H\left(X_{\nu}^{\text {red }}\right)$. Suppose that the action of $\frac{\nu}{\mathbb{T}_{\nu}^{1}}$ on $X$ is transversal to the CR structure. We denote by $H\left(X_{\nu}^{\text {red }}\right)_{k}$ the corresponding $k$-th Fourier component and we call the action of $\overline{\mathbb{T}_{\nu}^{1}}$ on $X_{\nu}^{\text {red }}$ residual circle action. The aim of this paper is to prove that $H(X)_{k \nu}$ and $H\left(X_{\nu}^{\mathrm{red}}\right)_{k}$ are isomorphic for $k$ sufficiently large.

We prove the aforementioned result in the more general setting of CR manifolds for spaces of $(0, q)$-forms when $k$ is large, more precisely we consider $(0, q)$ forms with $L^{2}$ coefficients and the corresponding projector $S^{(q)}$ onto the kernel of the Kohn Laplacian $H^{q}(X)$. Now, we make more precise the assumptions on the CR manifold $X$ and on the group action.

Assumption 1.1. Let $\left(X, T^{1,0} X\right)$ be a compact connected orientable $C R$ manifold of dimension $2 n+1, n \geq 1$, and let $\omega$ be the associated contact 1 -form. The Levi form is non-degenerate of constant signature ( $n_{-}, n_{+}$) on $X$. That is, the Levi form has exactly $n_{-}$negative and $n_{+}$positive eigenvalues at each point of $X$, where $n_{-}+n_{+}=n$.

Concerning the group action, we always assume
Assumption 1.2. The action of $\mathbb{T}$ preserves the contact form $\omega_{0}$ and the complex structure $J$. That is, $g^{*} \omega_{0}=\omega_{0}$ on $X$ and $g_{*} J=J g_{*}$ on the horizontal bundle $H X$ for every $g \in \mathbb{T}$ where $g^{*}$ and $g_{*}$ denote the pull-back map and push-forward map of $\mathbb{T}$, respectively.

Let $X_{\nu}^{\text {red }}:=X_{\nu} / \mathbb{T}_{\nu}^{t-1}$, defined in the same way as before, more precisely we shall assume

Assumption 1.3. The moment map $\mu$ is transverse to the ray $i \mathbb{R}_{+} \cdot \nu \in \mathfrak{t}^{*}$, the action of $\mathbb{T}$ on $X_{\nu}$ is locally free and for every $x \in X_{\nu}$

$$
\operatorname{val}_{x}\left(\nu^{\perp}\right) \cap \operatorname{val}_{x}\left(\nu^{\perp}\right)^{\perp_{b}}=\{0\}
$$

where the bilinear form $b$ is defined in Section 2.1 and it is is non-degenerate on $X_{\nu}$.
By Assumptions above, we will show that $X_{\nu}^{\text {red }}$ is a CR manifold with natural CR structure induced by $T^{1,0} X$ of dimension $2 n-2(t-1)+1$. Let $L_{X_{\nu}^{\text {red }}}$ be the Levi form on $X_{\nu}^{\text {red }}$ induced naturally from the Levi form $L$ on $X$. For a given subspace $\mathfrak{s}$ of $\mathfrak{t}$, we denote $\mathfrak{s}_{X}$ the subspace of infinitesimal vector fields on $X$. Hence, on

$$
\operatorname{ker} \nu_{X} \times \operatorname{ker} \nu_{X} \subseteq T X_{\nu} \times T X_{\nu}
$$

$b$ has constant signature, suppose $b$ has $r$ negative and $t-1-r$ positive eigenvalues on $X_{\nu}$. Hence $L_{X_{\nu}^{\text {red }}}$ has $q-r$ negative and $n-t+1-q+r$ positive eigenvalues at each point of $X_{\nu}^{\text {red }}$. We refer to Section 2.1 for definitions, we have:

Theorem 1.1. Fix a maximal coprime weight $\nu \neq 0$ in the lattice inside $\mathfrak{t}^{*}$ and assume that the circle action $\overline{\mathbb{T}_{\nu}^{1}}$ is a transversal $C R$ action. Under the assumptions above, $X_{\nu}^{\text {red }}$ is a compact CR manifold with non-degenerate Levi form having $q-r$-negative eigenvalues. There is a natural isomorphism of vector spaces $\sigma_{k}: H^{q}(X)_{k \nu} \rightarrow H^{q-r}\left(X_{\nu}^{\text {red }}\right)_{k}$ for $k$ sufficiently large.

We give a proof in Section 3, which is inspired from [HH and it is a consequence of the microlocal properties of the projector $S_{k \nu}^{(q)}$ described in Section 2.2 and calculus of Fourier integral operators of complex type, see [MS].

The conic reductions defined above appear naturally in geometric quantization. In fact, given a Hamiltonian and holomorphic action with moment map $\Phi$ of a compact Lie Group $G$ on a Hodge manifold $(M, \omega)$ with quantizing circle bundle $\pi: X \rightarrow M$, one can always define an infinitesimal action of the Lie algebra $\mathfrak{g}$ on $X$. If it can be integrated to an action of the whole group $G$, then one has a representation of $G$ on $H(X)$. In [GS2] it was observed that associated to group actions one can define reductions $M_{\text {red }}^{\ominus}$ by pulling back a $G$-invariant and proper sub-manifold $\Theta$ of $\mathfrak{g}^{*}$ via the moment map $\Phi$. When $\Theta$ is chosen to be a cone through a co-adjoint orbit $C\left(\mathcal{O}_{\nu}\right)$ one has associated reduction whose Hardy space of its quantization is

$$
H\left(X_{\mathrm{red}}^{C\left(\mathcal{O}_{\nu}\right)}\right)=\bigoplus_{k \in \mathbb{Z}} H\left(X_{\mathrm{red}}^{C\left(\mathcal{O}_{\nu}\right)}\right)_{k}
$$

where $k$ labels an irreducible representation of the residual circle action described above. Now, it is natural to ask if this spaces are related with the decomposition induced by $G$ on $H(X)$. When $G=\mathbb{T}$ Theorem 1.1 states that they are isomorphic to $H_{k \nu}(X)$; the canonical decomposition of the Hardy space $H(X)$ of the quantitation by the built-in circle action does not play any role. The semi-classical parameter $k$ is the one induced by the ladder $k \nu, k=0,1,2, \ldots$, labeling unitary irreducible representations.

Further geometrical motivations for this theorem are explained in paper [P3], where it is proved that $\delta_{k}$ is an isomorphism for $k$ large enough in the setting when $X$ is the circle bundle of a polarized Hodge manifold whose Grauert tube is $D$. Thus, Theorem 1.1 generalizes the main theorem in [P3] to compact "quantizable" pseudo-Kähler manifolds. We also refer to [P1 for examples and the explicit expression of the leading term of the asymptotic expansion of $\operatorname{dim} H(X)_{k \nu}$ as $k$ goes to infinity. Along this line of research in [P2] Toeplitz operators were studied for circle action, in [G] the study of asymptotics of compositions of Toeplitz operators with quantomopomorphism is addressed for torus actions.

## 2 Preliminaries

### 2.1 Geometric setting

We recall some notations concerning CR and contact geometry. Let ( $X, T^{1,0} X$ ) be a compact, connected and orientable CR manifold of dimension $2 n+1, n \geq 1$, where $T^{1,0} X$ is a CR structure of $X$. There is a unique sub-bundle $H X$ of $T X$ such that $H X \otimes \mathbb{C}=T^{1,0} X \oplus T^{0,1} X$. Let $J: H X \rightarrow H X$ be the complex structure map given by $J(u+\bar{u})=i u-i \bar{u}$, for every $u \in T^{1,0} X$. By complex linear extension of $J$ to $T X \otimes \mathbb{C}$, the $i$-eigenspace of $J$ is $T^{1,0} X$. We shall also write $(X, H X, J)$ to denote a CR manifold.

Since $X$ is orientable, there always exists a real non-vanishing 1-form $\omega_{0} \in \mathcal{C}^{\infty}\left(X, T^{*} X\right)$ so that $\left\langle\omega_{0}(x), u\right\rangle=0$, for every $u \in H_{x} X$, for every $x \in X ; \omega_{0}$ is called contact form and it naturally defines a volume form on $X$. For each $x \in X$, we define a quadratic form on $H X$ by

$$
L_{x}(U, V)=\frac{1}{2} \mathrm{~d} \omega_{0}(J U, V), \quad \forall U, V \in H_{x} X
$$

Then, we extend $L$ to $H X \otimes \mathbb{C}$ by complex linear extension; for $U, V \in T_{x}^{1,0} X$,

$$
L_{x}(U, \bar{V})=\frac{1}{2} \mathrm{~d} \omega_{0}(J U, \bar{V})=-\frac{1}{2 i} \mathrm{~d} \omega_{0}(U, \bar{V}) .
$$

The Hermitian quadratic form $L_{x}$ on $T_{x}^{1,0} X$ is called Levi form at $x$. In the case when $X$ is the circle bundle of an Hodge manifold $(M, \omega)$, the positivity of $\omega$ implies that the number of negative eigenvalues of the Levi form is equal to $n$. The Reeb vector field $R \in \mathcal{C}^{\infty}(X, T X)$ is defined to be the non-vanishing vector field determined by

$$
\omega_{0}(R)=-1, \quad \mathrm{~d} \omega_{0}(R, \cdot) \equiv 0 \quad \text { on } T X .
$$

Fix a smooth Hermitian metric $\langle\cdot \mid \cdot\rangle$ on $\mathbb{C} T X$ so that $T^{1,0} X$ is orthogonal to $T^{0,1} X$, $\langle u \mid v\rangle$ is real if $u, v$ are real tangent vectors, $\langle R \mid R\rangle=1$ and $R$ is orthogonal to $T^{1,0} X \oplus$ $T^{0,1} X$. For $u \in \mathbb{C} T X$, we write $|u|^{2}:=\langle u \mid u\rangle$. Denote by $T^{* 1,0} X$ and $T^{* 0,1} X$ the dual bundles of $T^{1,0} X$ and $T^{0,1} X$, respectively. They can be identified with sub-bundles of the complexified cotangent bundle $\mathbb{C} T^{*} X$.

Assume that $X$ admits an action of $t$-dimensional torus $\mathbb{T}$. In this work, we assume that the $\mathbb{T}$-action preserves $\omega_{0}$ and $J$; that is, $t^{*} \omega_{0}=\omega_{0}$ on $X$ and $t_{*} J=J t_{*}$ on $H X$. Let $\mathfrak{t}$ denote the Lie algebra of $T$, we identify $\mathfrak{t}$ with its dual $\mathfrak{t}^{*}$ by means of the scalar product $\langle\cdot, \cdot\rangle$. For any $\xi \in \mathfrak{t}$, we write $\xi_{X}$ to denote the vector field on $X$ induced by $\xi$. The moment map associated to the form $\omega_{0}$ is the map $\mu: X \rightarrow \mathfrak{t}^{*}$ such that, for all $x \in X$ and $\xi \in \mathfrak{t}$, we have

$$
\begin{equation*}
\langle\mu(x), \xi\rangle=\omega_{0}\left(\xi_{X}(x)\right) \tag{1}
\end{equation*}
$$

We can also define a non-degenerate bilinear form $b$ on $H X$ such that

$$
\begin{equation*}
b(\cdot, \cdot)=\mathrm{d} \omega_{0}(\cdot, J \cdot) . \tag{2}
\end{equation*}
$$

Fix a maximal weight $\nu \neq 0$ in the lattice inside $\mathfrak{t}^{*}$. Suppose that $i \mathbb{R}_{+} \cdot \nu$ is transversal to $\mu$, so we have

$$
\begin{equation*}
\mathfrak{t}^{*}=i \mathbb{R}_{+} \cdot \nu \oplus \mathrm{d}_{p} \mu\left(T_{p} X\right) \tag{3}
\end{equation*}
$$

and $X_{\nu}$ is a sub-manifold of $X$ of codimension $2 n+2-t$. We claim that the action of $\mathbb{T}_{\nu}^{t-1}$ on $X_{\nu}$ is locally free. In fact, by the contrary suppose that there exists $\xi \in \operatorname{ker} \nu$ such that $\xi_{X}(x)=0$ on $T_{x} X_{\nu}, x \in X_{\nu}$. For each $v \in T_{x} X$, we have

$$
\left(\mathrm{d}_{x} \mu(v)\right)(\xi)=\mathrm{d}_{x} \omega_{0}\left(\xi_{X}, v\right)=0
$$

which contradicts (3).
The action of $\mathbb{T}$ restricts to an action of $\mathbb{T}^{t-1}$ whose moment map is given by

$$
\mu_{\mid \mathbb{T}^{t-1}}=p_{\nu} \circ \mu, \quad \text { where } p_{\nu}: \mathfrak{t}^{*} \rightarrow \mathfrak{t}_{\nu}^{*}
$$

is the canonical projection onto the $t$-1-dimensional subspace $\nu^{\perp}$ in $\mathfrak{t}^{*}$. The transversality condition in 1.2 implies that $0 \in \mathfrak{t}_{\nu}^{t-1}$ is a regular value for the moment $\mu_{\mid \mathbb{T}^{t-1}}$. Thus, we have

$$
X_{\nu} / \mathbb{T}_{\nu}^{t-1}=\mu_{\mid \mathbb{T}^{t-1}}^{-1}(0) / \mathbb{T}_{\nu}^{t-1}
$$

and by assumptions 1.2, 1.3 and [HH, Section 2.5] (we shall also refer to [GH2] for definitions concerning CR structures on orbifolds) we have

Lemma 2.1. The space of orbits $X_{\nu} / \mathbb{T}_{\nu}^{t-1}$ is a CR orbifold. Let us denote bu $\pi: X_{\nu} \rightarrow$ $X_{\nu}^{\text {red }}$ and $\iota: X_{\nu} \hookrightarrow X$ the natural projection and inclusion, respectively, then there is a unique induced contact form $\omega_{0}^{\mathrm{red}}$ on $X_{\nu} / \mathbb{T}_{\nu}^{t-1}$ such that

$$
\pi^{*} \omega_{0}^{\mathrm{red}}=\iota^{*} \omega_{0}
$$

In particular, set $H X_{\nu}=T X_{\nu} \cap H X$, we have

$$
H X=H X_{\nu} \oplus J i \nu_{X}^{\perp} \quad \text { and } \quad H X_{\nu}=i \nu_{X}^{\perp} \oplus \mathrm{d} \pi^{*} H X_{\nu}^{\mathrm{red}}
$$

We will also assume that $\overline{\mathbb{T}_{\nu}^{1}}$-action is transversal CR , that is, the infinitesimal vector field

$$
\left(\nu_{X} u\right)(x)=\left.\frac{\partial}{\partial t}(u(\exp (i t \nu) \circ x))\right|_{t=0}, \quad \text { for any } u \in C^{\infty}(X)
$$

preserves the CR structure $T^{1,0} X$, so that $\nu_{X}$ and $T^{1,0} X \oplus T^{0,1} X$ generate the complex tangent bundle to $X$,

$$
\mathbb{C} T_{x} X=\mathbb{C} \nu_{X}(x) \oplus \mathbb{C} T_{x}^{1,0} X \oplus \mathbb{C} T_{x}^{0,1} X \quad(x \in X)
$$

We define local coordinates that will be useful later. Recall that $X$ admits a CR and transversal $\overline{\mathbb{T}_{\nu}^{1}}$-action which is locally free on $X_{\nu}, T \in \mathcal{C}^{\infty}(X, T X)$ denotes the global real vector field given by this infinitesimal circle action. We will take $T$ to be our Reeb vector field $R$. In a similar way as in Theorem 3.6 in [HH], there exist local coordinates $v=$ $\left(v_{1}, \ldots, v_{t-1}\right)$ of $\mathbb{T}_{\nu}^{t-1}$ in a small neighborhood $V_{0}$ of the identity $e$ with $v(e)=(0, \ldots, 0)$, local coordinates $x=\left(x_{1} \ldots, x_{2 n+1}\right)$ defined in a neighborhood $U_{1} \times U_{2}$ of $p \in X_{\nu}$, where $U_{1} \subseteq \mathbb{R}^{t-1}$ (resp. $U_{2} \subseteq \mathbb{R}^{2 n+2-t}$ ) is an open set of $0 \in \mathbb{R}^{t-1}$ (resp. $0 \in \mathbb{R}^{2 n+2-t}$ ) and $p \equiv 0 \in \mathbb{R}^{2 n+1}$, and a smooth function $\gamma=\left(\gamma_{1}, \ldots, \gamma_{t-1}\right) \in \mathcal{C}^{\infty}\left(U_{2}, U_{1}\right)$ with $\gamma(0)=0$ such that

$$
\begin{aligned}
& \left(v_{1}, \ldots, v_{t-1}\right) \circ\left(\gamma\left(x_{t}, \ldots, x_{2 n+1}\right), x_{t}, \ldots, x_{2 n+1}\right) \\
& =\left(v_{1}+\gamma_{1}\left(x_{t}, \ldots, x_{2 n+1}\right), \ldots, v_{t-1}+\gamma_{d}\left(x_{t}, \ldots, x_{2 n+1}\right), x_{t}, \ldots, x_{2 n+1}\right)
\end{aligned}
$$

for each $\left(v_{1}, \ldots, v_{t-1}\right) \in V_{0}$ and $\left(x_{t}, \ldots, x_{2 n+1}\right) \in U_{2}$. Furthermore, we have

$$
\mathfrak{t}=\operatorname{span}\left\{\partial_{x_{j}}\right\}_{j=1, \ldots, t-1}, \quad \mu^{-1}\left(i \mathbb{R}_{\nu} \cdot \nu\right) \cap U=\left\{x_{2 d-t+1}=\cdots=x_{2 d}=0\right\}
$$

on $\mu^{-1}\left(i \mathbb{R}_{\nu} \cdot \nu\right) \cap U$ there exist smooth functions $a_{j}$ 's with $a_{j}(0)=0$ for every $0 \leq j \leq t-1$ and independent on $x_{1}, \ldots, x_{2(t-1)}, x_{2 n+1}$ such that

$$
J\left(\partial_{x_{j}}\right)=\partial_{x_{t-1+j}}+a_{j}(x) \partial_{x_{2 n+1}} \quad j=1, \ldots, t-1,
$$

the Levi form $L_{p}$, the Hermitian metric $\langle\cdot \mid \cdot\rangle$ and the 1 -form $\omega_{0}$ can be written

$$
L_{p}\left(Z_{j}, \bar{Z}_{k}\right)=\mu_{j} \delta_{j, k}, \quad\left\langle Z_{j} \mid \bar{Z}_{k}\right\rangle=\delta_{j, k} \quad(1 \leq j, k \leq n)
$$

and

$$
\begin{aligned}

We need to define in local coordinates we just introduced the phase function of the $\mathbb{T}_{\nu}^{t-1}$-invariant Szegő kernel $\Phi_{-}(x, y) \in \mathcal{C}^{\infty}(U \times U)$ which is independent of $\left(x_{1}, \ldots, x_{t-1}\right)$ and $\left(y_{1}, \ldots, y_{t-1}\right)$. Hence, we write $\Phi_{-}(x, y)=\Phi_{-}\left(\left(0, x^{\prime \prime}\right),\left(0, y^{\prime \prime}\right)\right):=\Phi_{-}\left(x^{\prime \prime}, y^{\prime \prime}\right)$. Moreover, there is a constant $c>0$ such that

where $z_{j}=x_{2 j-1}+i x_{2 j}, w_{j}=\underline{y_{2 j-1}}+i y_{2 j}, j=t, \ldots, n, \mu_{j}, j=1, \ldots, n, f$ is smooth and satisfies $f(0,0)=0, f(x, y)=\bar{f}(y, x)$.

We now consider $\overline{\mathbb{T}_{\nu}^{1}}$ circle action on $X$. Let $p \in \mu^{-1}\left(i \mathbb{R}_{+} \cdot \nu\right)$, there exist local coordinates $v=\left(v_{1}, \ldots, v_{t-1}\right)$ of $\mathbb{T}^{t-1}$ in a small neighborhood $V_{0}$ of $e$ with $v(e)=(0, \ldots, 0)$, local coordinates $x=\left(x_{1} \ldots, x_{2 n+1}\right)$ defined in a neighborhood $U_{1} \times U_{2}$ of $p$, where $U_{1} \subseteq \mathbb{R}^{t-1}$ (resp. $U_{t-1} \subseteq \mathbb{R}^{2 n+t}$ ) is an open set of $0 \in \mathbb{R}^{t-1}$ (resp. $0 \in \mathbb{R}^{2 n+t}$ ) and $p \equiv 0 \in \mathbb{R}^{2 n+1}$, and a smooth function $\gamma=\left(\gamma_{1}, \ldots, \gamma_{t}\right) \in \mathcal{C}^{\infty}\left(U_{2}, U_{1}\right)$ with $\gamma(0)=0$ such that $T=-\frac{\partial}{\partial x_{2 n+1}}$ and all the properties for the local coordinates defined before hold. The phase function $\Psi$ satisfies $\Psi(x, y)=-x_{2 n+1}+y_{2 n+1}+\hat{\Psi}\left(\grave{x}^{\prime \prime}, y^{\prime \prime}\right)$, where $\hat{\Psi}\left(\dot{x}^{\prime \prime}, y^{\prime \prime}\right) \in \mathcal{C}^{\infty}(U \times U)$, $\grave{x}^{\prime \prime}=\left(x_{t}, \ldots, x_{2 n}\right), \dot{y}^{\prime \prime}=\left(y_{t}, \ldots, y_{2 n}\right)$, and $\Psi$ satisfies (5) $)$

### 2.2 Hardy spaces

We denote by $L_{(0, q)}^{2}(X)$ the completion of $\Omega^{0, q}(X)$ with respect to $(\cdot \mid \cdot)$. We extend $(\cdot \mid \cdot)$ to $L_{(0, q)}^{2}(X)$ in the standard way. We extend $\bar{\partial}_{b}$ to $L_{(0, r)}^{2}(X), r=0,1, \ldots, n$, by

where $\operatorname{Dom} \bar{\partial}_{b}:=\left\{u \in L_{(0, r)}^{2}(X) ; \bar{\partial}_{b} u \in L_{(0, r+1)}^{2}(X)\right\}$ and, for any $u \in L_{(0, r)}^{2}(X), \bar{\partial}_{b} u$ is defined in the sense of distributions. We also write

to denote the Hilbert space adjoint of $\bar{\partial}_{b}$ in the $L^{2}$ space with respect to $(\cdot \mid \cdot)$. There is a well-defined orthogonal projection

with respect to the $L^{2}$ inner product $(\cdot \mid \cdot)$ and let

denote the distribution kernel of $S^{(q)}$. We will write $H^{q}(X)$ for $\operatorname{ker} \square_{b}^{q}$ and for functions we simply write $H(X)$ to mean $H^{0}(X)$. The distributional kernel $S^{(q)}(x, y)$ was studied in [Hs], before recalling an explicit description describing the oscillatory integral defining the distribution $S^{(q)}(x, y)$ we need to fix some notation. Firstly, we recall Hörmander symbol space. Let $D \subset X$ be a local coordinate patch with local coordinates $x=\left(x_{1}, \ldots, x_{2 n+1}\right)$.

Definition 2.1. For every $m \in \mathbb{R}$, we denote with

the space of all $a$ such that, for all compact $K \Subset D \times D$ and all $\alpha, \beta \in \mathbb{N}_{0}^{2 n+1}, \gamma \in \mathbb{N}_{0}$, there is a constant $C_{\alpha, \beta, \gamma}>0$ such that

For simplicity we denote with $S_{1,0}^{m}$ the spaces defined in (7); furthermore, we write

S^{-\infty}\left(D \times D \times \mathbb{R}_{+}, T^{* 0, q} X \boxtimes\left(T^{* 0, q} X\right)^{*}\right):=\bigcap_{m \in \mathbb{R}} S_{1,0}^{m}\left(D \times D \times \mathbb{R}_{+}, T^{* 0, q} X \boxtimes\left(T^{* 0, q} X\right)^{*}\right)
$$

Let $a_{j} \in S_{1,0}^{m_{j}}, j=0,1,2, \ldots$ with $m_{j} \rightarrow-\infty$, as $j \rightarrow \infty$. Then there exists $a \in S_{1,0}^{m_{0}}$ unique modulo $S^{-\infty}$, such that

for $k=0,1,2, \ldots$. If $a$ and $a_{j}$ have the properties above, we write $a \sim \sum_{j=0}^{\infty} a_{j}$ in $S_{1,0}^{m_{0}}$.
It is known that the characteristic set of $\square_{b}^{q}$ is given by

\Sigma=\Sigma^{-} \cup \Sigma^{+}, \quad \Sigma^{-}=\left\{\left(x, \lambda \omega_{0}(x)\right) \in T^{*} X ; \lambda<0\right\}

and $\Sigma^{+}$is defined similarly for $\lambda>0$. We recall the following theorem (see Hs, Theorem 1.2]).

Theorem 2.1. Since the Levi form is non-degenerate, $\square_{b}^{q}$ has $L^{2}$ closed range. Then, there exist continuous operators $S_{-}, S_{+}: L_{(0, q)}^{2}(X) \rightarrow \operatorname{Ker} \square_{b}^{q}$ such that

where $\mathrm{WF}^{\prime}\left(S_{-}\right)=\left\{(x, \xi, y, \eta) \in T^{*} X \times T^{*} X ;(x, \xi, y,-\eta) \in \mathrm{WF}\left(S_{-}\right)\right\}$, WF $\left(S_{-}\right)$is the wave front set of $S_{-}$in the sense of Hörmander.

Moreover, consider any small local coordinate patch $D \subset X$ with local coordinates $x=\left(x_{1}, \ldots, x_{2 n+1}\right)$, then $S_{-}(x, y), S_{+}(x, y)$ satisfy

$s_{+}(x, y, t)=0$ if $q \neq n_{+}$and $s_{-}^{0}(x, x) \neq 0$ for all $x \in D$. The phase functions $\varphi_{-}, \varphi_{+}$ satisfy

\varphi_{+}, \varphi_{-} \in \mathcal{C}^{\infty}(D \times D), \quad \operatorname{Im} \varphi_{\mp}(x, y) \geq 0, \varphi_{-}(x, x)=0, \quad \varphi_{-}(x, y) \neq 0 \quad \text { if } \quad x \neq y

and

Remark 2.1. Kohn Kohn proved that if $q=n_{-}=n_{+}$or $\left|n_{-} n_{+}\right|>1$ then $\square_{b}^{q}$ has $L^{2}$ closed range. For a description of the phase function in local coordinates see chapter 8 of part I in [Hs.

Now we focus on the decomposition induced by the group action on $H^{q}(X)$. Fix $t \in \mathbb{T}$ and let $t^{*}: \Lambda_{x}^{r}\left(\mathbb{C} T^{*} X\right) \rightarrow \Lambda_{t^{-1}{ }_{\circ x}}^{r}\left(\mathbb{C} T^{*} X\right)$ be the pull-back map. Since $\mathbb{T}$ preserves $J$, we have $t^{*}: T_{x}^{* 0, q} X \rightarrow T_{g^{-1}{ }^{* 0} x} X$, for all $x \in X$. Thus, for $u \in \Omega^{0, q}(X)$, we have $t^{*} u \in \Omega^{0, q}(X)$. Put

\Omega^{0, q}(X)_{k \nu}:=\left\{u \in \Omega^{0, q}(X) ;\left(e^{i \theta}\right)^{*} u=e^{i k\langle\nu, \theta\rangle} u, \quad \forall \theta \in \mathbb{R}^{r}\right\} .

Since the Hermitian metric $\langle\cdot \mid \cdot\rangle$ on $\mathbb{C} T X$ is $\mathbb{T}$-invariant, the $L^{2}$ inner product $(\cdot \mid \cdot)$ on $\Omega^{0, q}(X)$ induced by $\langle\cdot \mid \cdot\rangle$ is $\mathbb{T}$-invariant. Let $u \in L_{(0, q)}^{2}(X)$ and $t \in \mathbb{T}$, we can also define $t^{*} u$ in the standard way. We introduce the following notation

L_{(0, q)}^{2}(X)_{k \nu}:=\left\{u \in L_{(0, q)}^{2}(X) ;\left(e^{i \theta}\right)^{*} u=e^{i k\langle\nu, \theta\rangle} u, \quad \forall \theta \in \mathbb{R}^{r}\right\},
$$

and put

\left(\operatorname{Ker} \square_{b}^{q}\right)_{k \nu}:=\operatorname{Ker} \square_{b}^{q} \cap L_{(0, q)}^{2}(X)_{k \nu} .
$$

The equivariant Szegő projection is the orthogonal projection

S_{k \nu}^{(q)}: L_{(0, q)}^{2}(X) \rightarrow\left(\operatorname{Ker} \square_{b}^{q}\right)_{k \nu}
$$

with respect to $(\cdot \mid \cdot)$. Let $S_{k \nu}^{(q)}(x, y) \in \mathcal{D}^{\prime}\left(X \times X, T^{* 0, q} X \boxtimes\left(T^{* 0, q} X\right)^{*}\right)$ be the distribution kernel of $S_{k \nu}^{(q)}$. The asymptotic expansion for the distributional kernel of the projector $S_{k \nu}^{(0)}$ was studied in [P1] when $X$ is the quantizing circle bundle of a given Hodge manifold in Heisenberg local coordinates. Using similar ideas as in [HH] one can generalize the results for $(0, q)$-forms in the following theorem, we give a sketch of the proof, which is similar to the proof of [HH, Theorem 1.8], here the group $G$ in $[\mathrm{HH}]$ is $\mathbb{T}_{\nu}^{t-1}$ and the circle action in $[\mathrm{HH}]$ is given by the action of $\overline{\mathbb{T}_{\nu}^{1}}$.

Since the action is locally free we need to recall some notations from [GH1]. Since the action is locally free $\mu^{-1}(0) / \overline{\mathbb{T}_{\nu}^{1}}$ is an orbifold, let us denote with $\pi: \mu^{-1}(0) \rightarrow \mu^{-1}(0) / \overline{\mathbb{T}_{\nu}^{1}}$ the projection. Furthermore the action of $\overline{\mathbb{T}_{\nu}^{1}}$ commutes with the one of $\mathbb{T}_{\nu}^{t-1}$, then we have a smooth locally free action of $\mathbb{T}_{\nu}^{t-1}$ on $\mu^{-1}(0) / \overline{\mathbb{T}_{\nu}^{1}}$. Given $y \in X$ and $g$ in the stabilizer $\left(\mathbb{T}_{\nu}^{t-1}\right)_{\pi(y)}$, there exist $\left|\left(\overline{\mathbb{T}_{\nu}^{1}}\right)_{y}^{1}\right|$ elements $e^{i \theta_{g, j}} \in \overline{\mathbb{T}_{\nu}^{1}}\left(j=1, \ldots,\left|\left(\overline{\mathbb{T}_{\nu}^{1}}\right)_{y}^{1}\right|\right)$ such that

g \circ y=e^{-i \theta_{g, j}} \circ y
$$

Thus, all the elements $\left(e^{i \theta}, g\right) \in \overline{\mathbb{T}_{\nu}^{1}} \times \mathbb{T}_{\nu}^{t-1}=\mathbb{T}$ satisfying

are of the form $\left(e^{i \theta_{g, j}}, g\right)$ for each $g \in\left(\mathbb{T}_{\nu}^{t-1}\right)_{\pi(y)}$.
Theorem 2.2. Suppose that $\square_{b}^{q}$ has $L^{2}$ closed range. Then, there exist continuous operators $S_{k \nu}^{-}, S_{k \nu}^{+}: L_{(0, q)}^{2}(X) \rightarrow\left(\operatorname{Ker} \square_{b}^{q}\right)_{k \nu}$ such that

S_{k \nu}^{(q)}=S_{k \nu}^{-}+S_{k \nu}^{+}, \quad S_{+} \equiv 0 \quad \text { if } q \neq n_{+}
$$

Suppose for simplicity that $q \neq n_{+}$. If $q \neq n_{-}$, then $S_{k \nu}^{(q)} \equiv O\left(k^{-\infty}\right)$ on $X$.
Suppose $q=n_{-}$and let $D$ be an open set in $X$ such that the intersection $\mu^{-1}\left(i \mathbb{R}_{+}\right.$. $\nu) \cap D=\emptyset$. Then $S_{k \nu}^{(q)} \equiv O\left(k^{-\infty}\right)$ on $D$.

Let $p \in \mu^{-1}\left(i \mathbb{R}_{+} \cdot \nu\right)$ and let $U$ a local neighborhood of $p$ with local coordinates $\left(x_{1}, \ldots x_{2 n+1}\right)$. Then, if $q=n_{-}$, for every fix $y \in U$, we consider $S_{k \nu}^{(q)}(x, y)$ as a $k$ dependent smooth function in $x$, then

S_{k \nu}^{(q)}(x, y)=\sum_{h \in G_{\pi(y)}} \sum_{j=1}^{\left|S_{x}^{1}\right|} e^{i k \theta_{h, j}} e^{i k\|\nu\| \Psi(x, y)} b(x, y, k\|\nu\|)+O\left(k^{-\infty}\right) .

for every $x \in U_{y}$, where $U_{y}$ is a small open neighborhood of $y$. The phase function $\Psi(x, y)$ is defined in local coordinates in the end of Section 2.1, the symbol satisfies

b(x, y, k\|\nu\|) \in S_{\mathrm{loc}}^{n+(1-t) / 2}\left(1, U \times U, T^{*(0, q)} X \boxtimes\left(T^{*(0, q)}\right)^{*}\right)

and the leading term of $b(x, x,\|\nu\|)$ is non-zero.
Proof. Suppose $q=n_{-}$, on small local neighborhood $D$ of a point $p \in X_{\nu}$ we have

where $\theta=\left(\theta_{1}, \ldots, \theta_{t}\right)$. It is easy to prove that the oscillatory integral has a rapidly decreasing asymptotic as $k \rightarrow+\infty$ far away from a local neighborhood of those elements $\left(e^{i \theta}, g\right) \in \overline{\mathbb{T}_{\nu}^{1}} \times \mathbb{T}_{\nu}^{t-1}=\mathbb{T}$ such that

We shall consider the case of a local neighborhood of the identity in $\mathbb{T}$, we set $\theta_{t}$ the variable for circle action of $\overline{\mathbb{T}_{\nu}^{1}}$ and $\left(\theta_{1}, \ldots, \theta_{t-1}\right)$ the variables for $\mathbb{T}_{\nu}^{t-1}$. We can then use local coordinates defined in 2.1, we have

S_{\mathbb{T}^{t-1}}^{(q)}(x, y)=\frac{1}{(2 \pi)^{t-1}} \int_{-\pi}^{\pi} \cdots \int_{-\pi}^{\pi} S^{(q)}\left(x, e^{i \operatorname{diag}\left(\theta_{1}, \ldots, \theta_{r-1}\right)} \cdot y\right) \mathrm{d} \theta_{1} \ldots \mathrm{~d} \theta_{t-1}, \tag{8}
\end{equation*}
$$

and $\stackrel{\circ}{x}=\left(x_{1}, \ldots, x_{n}, 0\right)$ and $\dot{y}=\left(y_{1}, \ldots, y_{n}, 0\right)$. The action of $\mathbb{T}$ restricts to an action of $\mathbb{T}^{t-1}$ whose moment map is given by

Since we are assuming $X_{\nu} \neq \emptyset$ we have that $0 \in \mathfrak{t}_{t-1}^{*}$ does lie in the image of the moment map $\mu_{\mid \mathbb{T}^{t-1}}$. The proof follow in a similar way as in Theorem 1.8 in $[\mathrm{HH}$ where here we have the action of $G=\mathbb{T}^{t-1}$ with moment map $\mu_{\mathbb{T}^{t-1}}$ and the $k \nu$ Fourier components are the ones induced by the transversal $\overline{\mathbb{T}_{\nu}^{1}}$-action; notice that [HH, Assumption 1.7] is satisfied. We shall also refer to [GH1, Theorem 5.4] for the locally free action case.

For ease of notation we introduce a definition to say that an operator behaves microlocally as equivariant Szegő projector we just studied. For simplicity we assume $q=n_{-}$.

Definition 2.2 (Equivariant Szegő type operator). Suppose that $q=n_{-}$and consider $H: \Omega^{0, q}(X) \rightarrow \Omega^{0, q}(X)$ be a continuous operator with distribution kernel

$$
H(x, y) \in \mathcal{D}^{\prime}\left(X \times X, T^{* 0, q} X \boxtimes\left(T^{* 0, q} X\right)^{*}\right)
$$

We say that $H$ is a complex Fourier integral operator of equivariant Szegő type of order $n+(1-t) / 2 \in \mathbb{Z}$ if $H$ is smoothing away $\mu^{-1}\left(i \mathbb{R}_{+} \cdot \nu\right)$ and for given $p \in \mu^{-1}\left(i \mathbb{R}_{+} \cdot \nu\right)$ let $D$ a local neighborhood of $p$ with local coordinates $\left(x_{1}, \ldots x_{2 n+1}\right)$. Then, the distributional kernel of $H$ satisfies

$$
H_{k}(x, y)=e^{i k \Psi(x, y)} a(x, y, k)+O\left(k^{-\infty}\right) \quad \text { on } D
$$

where $a \in S_{1,0}^{n+(1-t) / 2}\left(D \times D \times \mathbb{R}_{+}, T^{* 0, q} X \boxtimes\left(T^{* 0, q} X\right)^{*}\right)$, and $\Psi$ is as in the end of Section 2.1.

For $k=0, H_{0}^{(q)}(X)$ is the space of $\mathbb{T}$-fixed vectors, by Theorem 1.5 in [HH] we have $\operatorname{dim} H_{0}^{(q)}(X)<+\infty$ since when $0 \notin \mu(X)$ the projector $S_{\mathbb{T}}^{(q)}$ is smoothing. Now, given $k_{1}, k_{2} \in \mathbb{Z}$ with $k_{1}, k_{2} \neq 0$, consider $f_{1} \in H_{k_{1} \nu}^{(q)}(X)$ and $f_{2} \in H_{k_{2} \nu}^{(q)}(X)$, we have $f_{1} \cdot f_{2} \in$ $H_{\left(k_{1}+k_{2}\right) \nu}^{(q)}(X)$; we can study $\operatorname{dim} H_{k \nu}(X)$ for $k$ large, we have

$$
\operatorname{dim} H_{k \nu}^{(q)}(X)=\int_{X} S_{k \nu}^{(q)}(x, x) \mathrm{dV}_{X}(x)
$$

These dimensions can be studied as $k \rightarrow+\infty$ by using the microlocal properties of the Szegő kernel and Stationary Phase Lemma in a similar way as in Corollary 1.3 in [P1] we have $\operatorname{dim} H_{k \nu}^{(q)}(X)=O\left(k^{d+1-t}\right)$. So, we have the following generalization of Theorem A. 3 in [GS1], where it is proved for spaces of functions $H(X)_{k \nu}$.

Lemma 2.2. If $0 \notin \mu(X)$, then $H_{k \nu}^{q}(X)$ are finite dimensional.

## 3 Proof of Theorem 1.1

In this section we shall explain how to prove asymptotic commutativity for quantization and reduction for spaces of $(0, q)$-forms. We recall that $X_{\nu}^{\text {red }}$ is a CR orbifold whose Levi form is non-degenerate, with $r$ negative eigenvalues; let us denote with $S^{(q)}$ the corresponding Szegő kernel $S_{\text {red }}^{(q)}$ for $(0, q)$-forms whose $k$-the Fourier components are the one induced by the $\overline{\mathbb{T}_{\nu}^{1}}$-action on $X_{\nu}^{\text {red }}$. We shall recall briefly its microlocal expression by [GH2, Theorem 1.2]. Now, let us denote by $e^{i \theta}$. the transversal and CR locally free $\mathbb{T}_{\nu}^{1}$-action and we take the Reeb vector field $R$ to be the vector field on $X$ induced by it. For every $\ell \in \mathbb{N}$, put

$$
X_{\ell}:=\left\{x \in X: e^{i \theta} x \neq x, \theta \in\left[0,2 \pi / \ell\left[, e^{i 2 \pi / \ell} x=x\right\} .\right.\right.
$$

Let $q=r$, fix $p \in X$ and assume that $p \in X_{\ell}$, for some $\ell \in \mathbb{N}$. Consider an open set $U \subset X, p \in U$, and an orbifold chart $\left(\widetilde{U}, G_{U}\right) \rightarrow U$, we denote by $\widetilde{x}$ the coordinates on $\widetilde{U}$. We have as $k \rightarrow+\infty$,

$$
\begin{equation*}
\Pi_{k}^{(q)}(x, y)=\sum_{g \in G_{U}} \sum_{j=0}^{\ell-1} e^{\frac{2 \pi k j}{\ell}} e^{i k \Psi\left(\widetilde{x}, e^{i \frac{2 \pi j}{\ell}} \cdot g \cdot \widetilde{y}\right)} b\left(\widetilde{x}, e^{i \frac{2 \pi j}{\ell}} \cdot g \cdot \widetilde{y}, k\right)+O\left(k^{-\infty}\right) \tag{9}
\end{equation*}
$$

where the phase function

$$
\begin{aligned}
& \Psi \in C^{\infty}(\widetilde{U} \times \widetilde{U}), \quad \Psi(\widetilde{x}, \widetilde{x})=0, \text { for all } \widetilde{x} \in \widetilde{U} \\
& \inf _{e^{i \theta} \in S^{1}}\left\{\operatorname{dist}^{2}\left(\widetilde{x}, e^{i \theta} \widetilde{y}\right)\right\} / C \leq \operatorname{Im} \Psi(\widetilde{x}, \widetilde{y}) \leq C \inf _{e^{i \theta} \in S^{1}}\left\{\operatorname{dist}^{2}\left(\widetilde{x}, e^{i \theta} \widetilde{y}\right)\right\}
\end{aligned}
$$

for each $(\widetilde{x}, \widetilde{y}) \in \widetilde{U} \times \widetilde{U}, C>1$ is a constant; and the symbol satisfies

$$
b(\widetilde{x}, \widetilde{y}, k) \sim \sum_{j=0}^{+\infty} b_{j}(\widetilde{x}, \widetilde{y}) k^{n-j} \quad \text { in } \quad S^{n}\left(1 ; \widetilde{U} \times \widetilde{U}, T^{* 0, q} X \boxtimes\left(T^{* 0, q} X\right)^{*}\right)
$$

and $b_{0}(\widetilde{x}, \widetilde{x})$ is non zero.
Let us recall briefly why we have a local chart $\left(\widetilde{U}, G_{U}\right) \rightarrow U$, for ease of notation let us put $G=\mathbb{T}_{\nu}^{t-1}$. We recall that, for every $x \in X_{\nu}$, by the slice Theorem a neighborhood of any orbit $\mathbb{T}_{\nu}^{t-1} \cdot x=x_{0}$ is equivariantly diffeomorphic to a neighborhood of the zero section of the associated principal bundle

$$
G \times_{G_{x}} N_{x},
$$

where $N_{x}$ is the normal space to $G \cdot x$ in $X_{\nu}$ and $G_{x}$ is the stabilizer of $x$ for the action of $G$, which is finite. Therefore, for some $\epsilon>0$ and for an open ball $B_{2 e}(\epsilon) \subseteq N_{x}$, one has a homeomorphism $B_{2 e}(\epsilon) / G_{x} \cong \bar{U}$ onto some neighborhood of $x_{0}$ in $X_{\nu}^{\text {red }}$.

Since $\nu_{X}^{\perp}:=\operatorname{val}\left(\nu^{\perp}\right)$ is orthogonal to

$$
H_{x} X_{\nu} \cap J_{x} H_{x} X_{\nu} \quad \text { and } \quad H_{x} X_{\nu} \cap J_{x} H_{x} X_{\nu} \subset\left(\nu_{X}^{\perp}\right)^{\perp_{b}}
$$

for every $x \in X_{\nu}$, we can find a $\mathbb{T}$-invariant orthonormal basis $\left\{Z_{1}, \ldots, Z_{n}\right\}$ of $T^{* 0,1} X$ on $X_{\nu}$ such that for each $j, k=1, \ldots n$,

$$
L_{x}\left(Z_{j}(x), \bar{Z}_{j}(x)\right)=\delta_{j k} \lambda_{j}(x)
$$

where

$$
Z_{j}(x) \in\left(\nu_{X, x}^{\perp}+i J \nu_{X, x}^{\perp}\right) \text { for each } j=1, \ldots, r-1,
$$

$$
Z_{j}(x) \in H_{x} X_{\nu} \cap J_{x}\left(H_{x} X_{\nu}\right) \text { for each } j=r, \ldots, n
$$

Let $\left\{Z_{1}^{*}, \ldots, Z_{n}^{*}\right\}$ denote the orthonormal basis of $T^{* 0,1} X$ on $X_{\nu}$, dual to $Z_{1}, \ldots, Z_{n}$. Fix $s=0,1,2, \ldots, n-r+1$. For $x \in X_{\nu}$, put

$$
B_{x}^{* 0, s} X=\left\{\sum_{r \leq j_{1}<\cdots<j_{s} \leq n} a_{j_{1}, \ldots, j_{s}} Z_{j_{1}}^{*}, \ldots, Z_{j_{s}}^{*} ; a_{j_{1}, \ldots, j_{s}} \in \mathbb{C}\right.
$$

and let $B^{* 0, s} X$ be the vector bundle of $X_{\nu}$ with fibre $B_{x}^{* 0, s}, x \in X_{\nu}$. Let $C^{\infty}\left(X_{\nu}, B^{* 0, s} X\right)^{\mathbb{T}}$ denote the set of all $\mathbb{T}$-invariant sections of $X_{\nu}$ with values in $B_{x}^{* 0, s} X$; let

$$
\iota_{\mathrm{red}}: C^{\infty}\left(X_{\nu}, B^{* 0, s} X\right)^{\mathbb{T}} \rightarrow \Omega^{0, s}\left(X_{\nu}^{\mathrm{red}}\right)
$$

be the natural identification. Before defining the map between $H^{q}(X)_{k \nu}$ and $H^{q-r}\left(X_{\nu}^{\text {red }}\right)_{k}$ we need one more piece of notation. We can assume that $\lambda_{1}<0, \cdots, \lambda_{r}<0$ and also $\lambda_{t}<0, \ldots, \lambda_{n_{-}-r+t-1}<0$. For $x \in X_{\nu}$, set

$$
\hat{\mathcal{N}}\left(x, n_{-}\right)=\left\{c Z_{t}^{*} \wedge \cdots \wedge Z_{n_{-}-r+t-1}^{*}, c \in \mathbb{C}\right\}
$$

and let $\hat{p}: \mathcal{N}\left(x, n_{-}\right) \rightarrow \hat{\mathcal{N}}\left(x, n_{-}\right)$to be

$$
\hat{p}\left(c Z_{1}^{*} \wedge \cdots \wedge Z_{r}^{*} \wedge Z_{t}^{*} \wedge \cdots \wedge Z_{n_{-}-r+t-1}^{*}\right):=c Z_{t}^{*} \wedge \cdots \wedge Z_{n_{-}-r+t-1}^{*}
$$

where $c$ is a complex number. Put $\iota_{\nu}: X_{\nu} \rightarrow X$ be the natural inclusion, let $\iota_{\nu}^{*}$ : $\Omega^{0, q}(X) \rightarrow \Omega^{0, q}\left(X_{\nu}\right)$ be the pull-back of $\iota_{\nu}$.

Let $q=n_{-}$; now, inspired by [HH], we define the map

$$
\sigma_{k \nu}: H_{k \nu}^{(q)}(X) \rightarrow H\left(X_{\nu}^{\mathrm{red}}\right)_{k}
$$

given by

$$
\begin{equation*}
\sigma_{k \nu}(u):=k^{(t-1) / 4} S_{\mathrm{red}, k}^{(q-r)} \circ \iota_{\mathrm{red}} \circ \hat{p} \circ \tau_{x, n_{-}} \circ e \circ \iota_{\nu}^{*} \circ S_{k \nu}^{(q)}(u), \tag{10}
\end{equation*}
$$

here, $e(x)$ is a $\mathbb{T}$-invariant smooth function on $X_{\nu}$ that can be found explicitly. We recall the idea of the proof which then follows from calculation of complex Fourier integral operators. Notice that operators $S_{\text {red, } k}^{(q-r)}$ and $S_{k \nu}^{(q)}$ appearing in (10) are known explicitly. Micro-locally $S_{\text {red, } k}^{(q-r)}$ is the $k$-th Fourier component of the standard Szegő kernel for the CR manifold $X_{\nu}^{\text {red }}$, on the other hand $S_{k \nu}^{(q)}$ is described in Section 2.2, In fact, $\sigma_{k \nu}$ is an isomorphism for $k$ large if we can prove that

$$
\sigma_{k \nu}: H^{q}(X)_{k \nu} \rightarrow H^{q-r}\left(X_{\nu}\right)_{k} \quad \text { and } \quad \sigma_{k \nu}^{*}: H^{q-r}\left(X_{\nu}^{\mathrm{red}}\right)_{k} \rightarrow H^{q}(X)_{k \nu}
$$

are injective for $k$ large.
The injectivity of the map $\sigma_{k \nu}$ is a consequence of the following equality of operators

$$
\sigma_{k \nu}^{*} \sigma_{k \nu} \equiv c_{0}\left(1+R_{k}\right) S_{k \nu}^{(q)}
$$

where $c_{0}$ is a positive constant and $1+R_{k}: \Omega^{0, q}(X) \rightarrow \Omega^{0, q}(X)$ is an injective integral operator of equivariant Szegő type, see Definition 2.2. The injectivity of operator $1+R_{k}$ follows by direct computations of the leading symbol of $R_{k}$ which vanishes at $\operatorname{diag}\left(X_{\nu} \times\right.$ $\left.X_{\nu}\right)$. In fact, as a consequence of this, by Lemma 6.8 in [HH] we have that $\left\|R_{k} u\right\| \leq \epsilon_{k}\|u\|$ for all $u \in \Omega^{0, q}(X)$, for all $k \in \mathbb{N}$ where $\epsilon_{k}$ is a sequence with $\lim _{k \rightarrow+\infty} \epsilon_{k}=0$; this in turn implies, if $k$ is large enough, that the map $1+R_{k}$ is injective.

Analogously, the injectivity of the map $\sigma_{k \nu}^{*}$ follows by studying $\sigma_{k \nu} \sigma_{k \nu}^{*}$. We don't repeat the proof here since it is an application of the stationary phase formula for Fourier integral operators of complex type, see [MS], and it follows in a similar way as in [HH].
