# BOUNDARY VALUE PROBLEMS FOR SEMILINEAR SCHRÖDINGER EQUATIONS WITH SINGULAR POTENTIALS AND MEASURE DATA

#### Abstract

We study boundary value problems with measure data in smooth bounded domains $\Omega$, for semilinear equations. Specifically we consider problems of the form $-L_{V} u+f(u)=\tau$ in $\Omega$ and $\operatorname{tr}_{V} u=\nu$ on $\partial \Omega$, where $L_{V}=\Delta+V, f \in C(\mathbb{R})$ is monotone increasing with $f(0)=0$ and $\operatorname{tr}_{V} u$ denotes the measure boundary trace of $u$ associated with $L_{V}$. The potential $V$ is typically a Hölder continuous function in $\Omega$ that blows up at a set $F \subset \partial \Omega$ as dist $(x, F)^{-2}$. In general the above boundary value problem may not have a solution. We are interested in questions related to the concept of 'reduced measures', introduced in [4] for $V=0$. Our results extend results of (4] and [6] and apply to a larger class of nonlinear terms $f$. In the case of signed measures, some of the present results are new even for $V=0$.

## 1. Introduction

Let $\Omega$ be a $C^{2}$ bounded domain in $\mathbb{R}^{N}, N \geq 3$, and let

$$
L_{V}:=\Delta+V
$$

where $V \in C^{\theta}(\Omega)$, for some $\theta \in(0,1]$, satisfies the following conditions:

$$
\begin{gather*}
\exists \bar{a}>0: \quad|V(x)| \leq \bar{a} \delta(x)^{-2} \quad \forall x \in \Omega  \tag{A1}\\
\delta(x):=\operatorname{dist}(x, \partial \Omega) \\
\int_{\Omega}|\nabla \phi|^{2} d x \geq \int_{\Omega} \phi^{2} V d x \quad \forall \phi \in H_{0}^{1}(\Omega) \tag{A2}
\end{gather*}
$$

These conditions imply the existence of a (minimal) Green function $G_{V}$ and of the Martin kernel $K_{V}$ for the operator $-L_{V}$. Related to this, the operator has a ground state that we denote by $\Phi_{V}$. In the present case $\Phi_{V}$ is a positive eigenfunction of $-L_{V}$ with eigenvalue $\lambda_{V}>0$.

The function $\Phi_{V}$ and the Martin kernel $K_{V}$ are normalized at a reference point $x_{0} \in \Omega$ :

\Phi_{V}\left(x_{0}\right)=1, \quad K_{V}\left(x_{0}, y\right)=1 \quad \forall y \in \partial \Omega
$$

Notation. Denote

$$
\begin{array}{ll}
\mathbb{K}_{V}[\nu](x):=\int_{\partial \Omega} K_{V}(x, y) d \nu(y) & \forall \nu \in \mathfrak{M}(\partial \Omega) \\
\mathbb{G}_{V}[\tau](x):=\int_{\Omega} G_{V}(x, y) d \tau(y) \quad \forall \tau \in \mathfrak{M}\left(\Omega ; \Phi_{V}\right)
\end{array}
$$

Here $\mathfrak{M}(\partial \Omega)$ denotes the space of finite Borel measures on $\partial \Omega$ and $\mathfrak{M}\left(\Omega ; \Phi_{V}\right)$ denotes the space of real Borel measures $\tau$ in $\Omega$ such that $\int_{\Omega} \Phi_{V} d|\tau|<\infty$. As usual $\mathfrak{M}_{+}(\partial \Omega)$ and $\mathfrak{M}_{+}\left(\Omega ; \Phi_{V}\right)$ denote the positive cones of these spaces.

A function $u \in L_{\mathrm{loc}}^{1}(\Omega)$ is $L_{V}$ harmonic (resp. subharmonic, superharmonic) in $\Omega$ if $-L_{V} u=($ resp. $\leq, \geq) 0$ in $\Omega$ in the distribution sense.

By the Martin representation theorem, for every positive $L_{V}$ harmonic function $u$ in $\Omega$ there exists $\nu \in \mathfrak{M}_{+}(\partial \Omega)$ such that $u=\mathbb{K}_{V}[\nu]$.

By the Riesz decomposition lemma, a positive $L_{V}$ superharmonic $u$ can be represented in the form $u=p+h$ where $h$ is the largest
$L_{V}$ harmonic function dominated by $u$ and $p$ is an $L_{V}$ potential, i.e. a positive $L_{V}$ superharmonic function which does not dominate any positive $L_{V}$ harmonic.

A function $u$ is an $L_{V}$ potential if and only if there exists a positive measure $\tau \in \mathfrak{M}\left(\Omega ; \Phi_{V}\right)$ such that $u=\mathbb{G}_{V}[\tau]$. If $\tau$ is a positive Radon measure then either $\mathbb{G}_{V}[\tau]$ is finite everywhere in $\Omega$ or $\mathbb{G}_{V}[\tau] \equiv \infty$. Moreover, $\mathbb{G}_{V}[\tau]<\infty$ if and only if $\tau \in \mathfrak{M}\left(\Omega ; \Phi_{V}\right)$.

For these and other basic potential theory results we refer the reader to [1]. A brief survey can be found in [15].

In this paper we study boundary value problems of the form

$$
\begin{equation*}
-L_{V} u+f(u)=\tau \quad \text { in } \Omega, \quad \operatorname{tr}_{V} u=\nu \quad \text { on } \partial \Omega \tag{1.1}
\end{equation*}
$$

always assuming that

$$
\begin{equation*}
f \in C(\mathbb{R}), \quad f \text { is non-decreasing }, \quad f(0)=0 \tag{1.2}
\end{equation*}
$$

and

$$
\nu \in \mathfrak{M}(\partial \Omega), \quad \tau \in \mathfrak{M}\left(\Omega ; \Phi_{V}\right)
$$

Finally $\operatorname{tr}_{V} u$, the $L_{V}$ boundary trace of $u$, is defined as follows.
Definition 1.1. A non-negative Borel function $u$ defined in $\Omega$ has an $L_{V}$ boundary trace $\nu \in \mathfrak{M}(\partial \Omega)$ if

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \int_{\partial D_{n}} h u d \omega_{V}^{x_{0}, D_{n}}=\int_{\partial \Omega} h d \nu \quad \forall h \in C(\bar{\Omega}) \tag{1.3}
\end{equation*}
$$

for every uniformly Lipschitz exhaustion $\left\{D_{n}\right\}$ of $\Omega$ such that $x_{0} \in D_{n}$ for all $n$. Here $x_{0}$ is the reference point previously mentioned and $\omega_{V}^{x_{0}, D_{n}}$ denotes the harmonic measure for $L_{V}$ in $D_{n}$ relative to $x_{0}$. The $L_{V}$ boundary trace of $u$ is denoted by $\operatorname{tr}_{V} u$.

A real Borel function $u$ defined in $\Omega$ has an $L_{V}$ boundary trace if

$$
\begin{equation*}
\sup _{n} \int_{\partial D_{n}}|u| d \omega_{V}^{x_{0}, D_{n}}<+\infty \tag{1.4}
\end{equation*}
$$

and (1.3) holds.
When $V=0$ this definition reduces to the classical definition of measure boundary trace. Recall that

$$
d \omega_{n}^{x_{0}}=P_{V, n}\left(x_{0}, \cdot\right) d S \quad \text { on } \partial D_{n}
$$

where $P_{V, n}$ is the Poisson kernel of $-L_{V}$ in $D_{n}$.

By [17, Lemma 2.3], if (A1), (A2) hold, the $L_{V}$ trace has the following properties:

$$
\begin{align*}
\text { (i) } & \operatorname{tr}_{V}\left(\mathbb{K}_{V}[\nu]\right)=\nu
\end{align*} \quad \forall \nu \in \mathfrak{M}(\partial \Omega), ~ 子, ~ i(i i) \quad \operatorname{tr}_{V}\left(\mathbb{G}_{V}[\tau]\right)=0 \quad \forall \tau \in \mathfrak{M}\left(\Omega ; \Phi_{V}\right) .
$$

Notation. (i) Let $(\lambda, \sigma)$ and $(\tau, \nu)$ be two couples of measures in $\mathfrak{M}\left(\Omega ; \Phi_{V}\right) \times$ $\mathfrak{M}(\partial \Omega)$. Then $(\lambda, \sigma) \prec(\tau, \nu)$ means $\lambda \leq \tau$ and $\sigma \leq \nu$.
(ii) For $\beta>0$, denote

$$
\begin{gather*}
D_{\beta}:=\{x \in \Omega: \delta(x)>\beta\}, \quad \Omega_{\beta}:=\{x \in \Omega: \delta(x)<\beta\}, \\
\Sigma_{\beta}:=\{x \in \Omega: \delta(x)=\beta\} . \tag{1.6}
\end{gather*}
$$

Since $\Omega$ is a $C^{2}$ bounded domain, there exists $\beta_{0}>0$ such that for every $x \in \Omega_{\beta_{0}}$ there is a unique point $\sigma(x) \in \partial \Omega$ such that $|x-\sigma(x)|=$ $\delta(x)$, and $x \mapsto \delta(x)$ is in $C^{2}\left(\Omega_{\beta_{0}}\right)$ while $x \mapsto \sigma(x)$ is in $C^{1}\left(\Omega_{\beta_{0}}\right)$.

In addition to (A1) and (A2), we assume that the ground state $\Phi_{V}$ satisfies the following condition:

There exist $a_{0} \geq 1$ and $\alpha, \alpha^{*}>0$ satisfying

$$
0 \leq \alpha-\alpha^{*}<\frac{1}{2}
$$

such that for every $a>a_{0}$ and every $x, z \in \Omega_{\beta_{0}}$ lying on a normal to $\partial \Omega$ :

$$
\begin{equation*}
a \delta(x) \leq \delta(z) \Longrightarrow \frac{\Phi_{V}(x)}{\Phi_{V}(z)} \leq c(a) \frac{\delta(x)^{\alpha^{*}}}{\delta(z)^{\alpha}} . \tag{C1}
\end{equation*}
$$

Conditions (A1), (A2) and (C1) are assumed, without further mention, throughout the paper.

Definition 1.2. Let $(\tau, \nu) \in \mathfrak{M}\left(\Omega ; \Phi_{V}\right) \times \mathfrak{M}(\partial \Omega)$ and $u \in L_{\text {loc }}^{1}(\Omega)$.
(i) $u$ is a solution of (1.1) if $f(u) \in L^{1}\left(\Omega ; \Phi_{V}\right)$, the equation holds in the distribution sense and $\operatorname{tr}_{V} u=\nu$.
(ii) $u$ is a subsolution of (1.1) if $f(u) \in L^{1}\left(\Omega ; \Phi_{V}\right),-L_{V} u+f(u) \leq \tau$ in the distribution sense and $\operatorname{tr}_{V} u \leq \nu$.

A supersolution is defined in the same way with the inverse inequalities.

With this definition, $u$ is a solution of (1.1) if and only if (see [17, Lemma 3.1])

$$
\begin{equation*}
u+\mathbb{G}_{V}[f(u)]=\mathbb{G}_{V}[\tau]+\mathbb{K}_{V}[\nu] \quad \text { in } \Omega . \tag{1.7}
\end{equation*}
$$

If (1.1) has a solution we say that $(\tau, \nu)$ is a good couple.

If $(0, \nu)$ (respectively $(\tau, 0)$ ) is a good couple we say that $\nu$ (respectively $\tau$ ) is a good measure.

We are interested in questions related to the notion of 'reduced measure' introduced in [4] (for $L_{V}=\Delta$ ). In general, problem (1.1) is not solvable for every couple $(\tau, \nu)$.

A great deal of research has been devoted to a precise characterization of good measures or good couples in some specific cases. Most of this research dealt with the equation $-\Delta u+f(u)=0$ in $\Omega$ and in particular with the case $f(t)=|t|^{p} \operatorname{sign} t, p>1$ (see [9, 12, 13, 24] for $1<p \leq 2$ and [14,22, 23] for every $p>1$ and the references therein). See also [2] where the problem was treated for a general class of nonlinearities $f$ that satisfy the Keller - Osserman condition.

More recently the characterization of good measures was studied with respect to the equation $-L_{V} u+f(u)=0$ in $\Omega$, mainly when $V$ is the Hardy potential and $f(t)=|t|^{p} \operatorname{sign} t$ (see, e.g. [7, 10, 18, 20]). The question was also studied in the context of fractional Schrödinger equations (see, e.g. [11]).

The idea of 'reduced measure', introduced in 4], is to provide a reduction process that converges to the 'good' part of $\tau$ and $\nu$ when (1.1) has no solution. 1

In [4], the authors study problem (1.1) for $L_{V}=\Delta$, mainly in the case where $\nu=0, \tau \in \mathfrak{M}(\Omega)$, assuming that $f$ satisfies (1.2) and vanishes on $(-\infty, 0]$. A solution is a function $u \in L^{1}(\Omega)$ such that $f(u) \in L^{1}(\Omega)$ and $u$ satisfies (1.1) in the weak sense. To determine the reduced measure the authors consider a sequence of problems

$$
\begin{equation*}
-\Delta u+f_{n}(u)=\tau \quad \text { in } \Omega, \quad u=0 \quad \text { on } \partial \Omega, \tag{1.8}
\end{equation*}
$$

where $f_{n} \in C(\mathbb{R})$ is a non-negative, nondecreasing function, $f_{n} \uparrow f$ and (1.8) has a solution for every $\tau \in \mathfrak{M}(\Omega)$. (For instance, the functions $f_{n}$ are bounded.) One of the main results states (see [4, Theorem 4.1]):

Let $u_{n}$ be the unique solution of (1.8). Then the sequence $\left\{u_{n}\right\}$ decreases and $u^{*}:=\lim u_{n}$ satisfies

$$
-\Delta u^{*}+f\left(u^{*}\right)=\tau^{*} \quad \text { in } \Omega, \quad u^{*}=0 \quad \text { on } \partial \Omega,
$$

where $\tau^{*}$ is the largest good measure dominated by $\tau$.
In [6] a similar result is established in the case $(\tau, \nu) \in \mathfrak{M}(\Omega) \times \mathfrak{M}(\partial \Omega)$ (possibly signed measures) assuming as before that $f=0$ on $(-\infty, 0]$. It is also shown that $(\tau, \nu)$ is good if and only if, both $\tau$ and $\nu$ are good measures.

[^1]When $\tau, \nu$ are signed measures and we drop the assumption ' $f=0$ on $(-\infty, 0)$ ', the situation is more complex even in the case $V=0$.

The present definition of a solution of (1.1) is necessarily different from that of weak solution used in [4], [6]. But when $V=0$ these are essentially equivalent.

In the case where $\tau$ and $\nu$ are positive our results are similar to those quoted above.

Let $u_{n}$ denote the solution of the problem,

$$
\begin{equation*}
-L_{V} u+f_{n}(u)=\tau \quad \text { in } \Omega, \quad \operatorname{tr}_{V} u=\nu \quad \text { on } \partial \Omega \tag{1.9}
\end{equation*}
$$

where $f_{n} \in C(\mathbb{R})$ is non-decreasing, bounded and $\left(f_{n}\right)_{ \pm} \uparrow f_{ \pm}$.
Theorem 1.3. Assume that $f$ satisfies (1.2) and $(\tau, \nu) \in \mathfrak{M}_{+}\left(\Omega ; \Phi_{V}\right) \times$ $\mathfrak{M}_{+}(\partial \Omega)$. For $u_{n}$ as above: $u_{n} \downarrow u^{\#}$ and

$$
\begin{equation*}
-L_{V} u^{\#}+f\left(u^{\#}\right)=\tau^{\#} \quad \text { in } \Omega, \quad \operatorname{tr}_{V} u^{\#}=\nu^{\#} \tag{1.10}
\end{equation*}
$$

where $(0,0) \prec\left(\tau^{\#}, \nu^{\#}\right) \prec(\tau, \nu)$. Moreover, $u^{\#}$ is the largest subsolution of (1.1) and $\tau^{\#}, \nu^{\#}$ are the largest good measures dominated by $\tau$ and $\nu$ respectively.

A corresponding result holds for couples of negative measures (see Remark (3.6).

In the case that $\tau, \nu$ may be signed measures we prove:
Theorem 1.4. Assume that $f$ satisfies (1.2) and $(\tau, \nu) \in \mathfrak{M}\left(\Omega ; \Phi_{V}\right) \times$ $\mathfrak{M}(\partial \Omega)$. Let $(\lambda, \sigma)$ be a couple of measures such that

$$
\begin{equation*}
-\left(\tau_{-}, \nu_{-}\right) \prec(\lambda, \sigma) \prec\left(\tau_{+}, \nu_{+}\right) \tag{1.11}
\end{equation*}
$$

and let $u_{n}$ be the solution of (1.9) with $(\tau, \nu)$ replaced by $(\lambda, \sigma)$.
Every subsequence of $\left\{u_{n}\right\}$ has a limit point with respect to a.e. convergence. If $\tilde{u}$ is such a limit point then

$$
\begin{equation*}
-L_{V} \tilde{u}+f(\tilde{u})=\tilde{\lambda} \quad \text { in } \Omega, \quad \operatorname{tr}_{V} \tilde{u}=\tilde{\sigma} \tag{1.12}
\end{equation*}
$$

and

$$
\begin{equation*}
\left(-\tau_{-},-\nu_{-}\right)^{\#} \prec(\tilde{\lambda}, \tilde{\sigma}) \prec\left(\tau_{+}, \nu_{+}\right)^{\#} . \tag{1.13}
\end{equation*}
$$

Moreover, every couple $(\lambda, \sigma)$ such that

$$
\begin{equation*}
\left(-\tau_{-},-\nu_{-}\right)^{\#} \prec(\lambda, \sigma) \prec\left(\tau_{+}, \nu_{+}\right)^{\#} \tag{1.14}
\end{equation*}
$$

is a good couple.
This naturally leads to the following question: If $(\lambda, \sigma)$ is a good couple in the interval (1.11) does it necessarily satisfy (1.14)?

As shown below, if $f$ vanishes in $(-\infty, 0]$, the answer is positive. In the general case this is an open question.

Theorem 1.5. Assume that $f$ satisfies (1.2) and that $f(t)=0$ for $t \leq 0$. Let $(\tau, \nu) \in \mathfrak{M}\left(\Omega ; \Phi_{V}\right) \times \mathfrak{M}(\partial \Omega)$. Then $(\tau, \nu)$ is a good couple if and only if

$$
\begin{equation*}
(\tau, \nu) \prec\left(\tau_{+}^{\#}, \nu_{+}^{\#}\right) \tag{1.15}
\end{equation*}
$$

where $\tau_{+}^{\#}$ and $\nu_{+}^{\#}$ are the largest good measures dominated by $\tau_{+}$and $\nu_{+}$respectively: ${ }^{2}$

Consequently, $(\tau, \nu)$ is a good couple with respect to (1.1) if and only if $\tau$ and $\nu$ separately are good measures.

This result extends [6, Theorem 6].
Our main tools include: two-sided estimates of $\mathbb{G}_{V}[\tau], \tau \in \mathfrak{M}_{+}\left(\Omega ; \Phi_{V}\right)$, and $\mathbb{K}_{V}[\nu], \nu \in \mathfrak{M}_{+}(\partial \Omega)$ [16], the inverse maximum principle [8], Kato's inequality and its extension due to [5] and a result of [4] regarding the diffuse part of reduced measures.

Here is the plan of the paper. In Section 2 we recall the estimates of [16] as well as properties of sub and supersolutions established in [17] that are frequently used in the present paper. In Section 3 we study the problem of reduced couple for (1.1) with positive measures. Theorem 1.3 is a consequence of Theorems 3.1 and 3.5. Section 4 is devoted to problem (1.1) with signed measures. Theorem 1.4 is a consequence of Theorem 4.1 and Proposition 4.2. The section is completed by the proof of Theorem 1.5.

## 2. Some results on sub and supersolutions.

In this section we gather several results from [16] and [17] that are frequently used in the sequel.

### 2.1. Estimates of $L_{V}$ harmonic functions and $L_{V}$ potentials.

The estimates stated below are derived in [16].
Theorem 2.1. ( [16, Theorem 3.1]) Assume that (A1), (A2) and (C1) hold. Then for any $\nu \in \mathfrak{M}_{+}(\partial \Omega)$,

$$
\frac{1}{C}\|\nu\|_{\mathfrak{M}(\partial \Omega)} \leq \int_{\Sigma_{\beta}} \frac{\Phi_{V}}{\delta} \mathbb{K}_{V}[\nu] d S \leq C\|\nu\|_{\mathfrak{M}(\partial \Omega)} \quad \forall \beta \in\left(0, \beta_{0}\right)
$$

where the constant $C$ depends on $\bar{a}, \Omega$ and the constants in (C1).

[^2]Next is an estimate of $L_{V}$ potentials.
Theorem 2.2. ( [16, Theorems 3.3 and 3.4])
(i) Assume (A1) and (A2) hold. Then there exists a constant $c$ depending on $\bar{a}, \Omega$ such that, for every $\tau \in \mathfrak{M}_{+}\left(\Omega ; \Phi_{V}\right)$,

$$
\frac{1}{c} \int_{\Omega} \Phi_{V} d \tau \leq \int_{\Omega} \frac{\Phi_{V}}{\delta} \mathbb{G}_{V}[\tau] d x
$$

(ii) Assume (A1), (A2) and (C1) hold. Then there exists $c^{\prime}>0$ depending on $\bar{a}, \Omega$ and the constants in (C1) such that for every $\tau \in$ $\mathfrak{M}_{+}\left(\Omega ; \Phi_{V}\right)$,

$$
\int_{\Omega} \frac{\Phi_{V}}{\delta} \mathbb{G}_{V}[\tau] d x \leq c^{\prime} \int_{\Omega} \Phi_{V} d \tau
$$

2.2. Remarks on subsolutions and supersolutions. We list some properties of subsolutions and supersolutions from [17].
Lemma 2.3. Let $w \in L_{\mathrm{loc}}^{1}(\Omega)$ be a non-negative $L_{V}$ subharmonic function. If $\operatorname{tr}_{V} w=0$ then $w \equiv 0$.

This is a consequence of [17, Corollary 2.6].
Lemma 2.4. ( $\left[17\right.$, Corollary 2.8]) Let $u \in L_{\mathrm{loc}}^{1}(\Omega)$ and suppose that $-L_{V} u=\tau \in \mathfrak{M}\left(\Omega ; \Phi_{V}\right)$. In addition assume that for some smooth exhaustion $\left\{D_{n}\right\}$ of $\Omega$,

$$
\begin{equation*}
\sup _{n} \int_{\partial D_{n}} P_{V, n}\left(x_{0}, y\right)|u(y)| d S(y)<+\infty \tag{2.1}
\end{equation*}
$$

Then $\operatorname{tr}_{V} u=: \nu$ exists and $u=\mathbb{G}_{V}[\tau]+\mathbb{K}_{V}[\nu]$ in $\Omega$.
Remark. If $\operatorname{tr}_{V} u$ exists then, by definition, (2.1) holds.
If $u \geq 0$, condition (2.1) is not needed. In this case the result (stated below) is a consequence of the Riesz decomposition lemma.
Lemma 2.5. ( $\mathbb{1 7}$, Lemma 2.11]) Let $u \in L_{\mathrm{loc}}^{1}(\Omega)$ be a positive function such that $-L_{V} u=\tau \in \mathfrak{M}\left(\Omega ; \Phi_{V}\right)$. Then $u$ has an $L_{V}$ boundary trace, say $\nu$, and $u=\mathbb{G}_{V}[\tau]+\mathbb{K}_{V}[\nu]$ in $\Omega$.

Notation. A function $u$ is $L_{V}$ perfect if $u=\mathbb{G}_{V}[\tau]+\mathbb{K}_{V}[\nu]$ for some $\tau \in \mathfrak{M}\left(\Omega ; \Phi_{V}\right)$ and $\nu \in \mathfrak{M}(\partial \Omega)$.
Lemma 2.6. ( $\sqrt[17]{ }$, Lemma 3.3]) Suppose that $u$ is an $L_{V}$ perfect function. If $\operatorname{tr}_{V} u \leq 0$ then $\operatorname{tr}_{V} u_{+}=0$.

Consider the equation

$$
\begin{equation*}
-L_{V} u+f(u)=\tau \quad \text { in } \Omega \tag{2.2}
\end{equation*}
$$

and the boundary value problem

$$
\begin{equation*}
-L_{V} u+f(u)=\tau \quad \text { in } \Omega, \quad \operatorname{tr}_{V} u=\nu \tag{2.3}
\end{equation*}
$$

where $f$ satisfies (1.2), $\tau \in \mathfrak{M}\left(\Omega ; \Phi_{V}\right)$ and $\nu \in \mathfrak{M}(\partial \Omega)$.
Definition 2.7. Let $u \in L_{\text {loc }}^{1}(\Omega)$ be a function such that $f(u) \in$ $L_{\text {loc }}^{1}(\Omega)$.

The function $u$ is a subsolution (supersolution) of (2.2) if $-L_{V} u+$ $f(u) \leq(\geq) \tau$ in $\Omega$ in the distribution sense.

The function $u$ is a subsolution (supersolution) of (2.3) if it is a subsolution (supersolution) of (2.2), $f(u) \in L^{1}\left(\Omega ; \Phi_{V}\right)$ and $u$ has an $L_{V}$ boundary trace such that $\operatorname{tr}_{V} u \leq \nu\left(\operatorname{tr}_{V} u \geq \nu\right)$.

Lemma 2.8. ( [17, Lemma 3.1]) Assume that $u \in L_{\mathrm{loc}}^{1}(\Omega)$ and $f(u) \in$ $L^{1}\left(\Omega ; \Phi_{V}\right)$.

If $u$ is a subsolution (resp. supersolution) of problem (2.3) then $u$ is $L_{V}$ perfect. More precisely, there exist measures $\lambda \in \mathfrak{M}_{+}\left(\Omega ; \Phi_{V}\right)$ and $\sigma \in \mathfrak{M}_{+}(\partial \Omega)$ such that:

$$
\begin{align*}
u & =\mathbb{G}_{V}[\tau-f(u)-\lambda]+\mathbb{K}_{V}[\nu-\sigma]  \tag{2.4}\\
(u & \left.=\mathbb{G}_{V}[\tau-f(u)+\lambda]+\mathbb{K}_{V}[\nu+\sigma]\right) .
\end{align*}
$$

Lemma 2.9. ( [17, Lemma 3.4]) (i) Let $u_{1}$ (resp. $u_{2}$ ) be a supersolution (resp. subsolution) of (2.3). Then $u_{2} \leq u_{1}$.
(ii) Problem (2.3) has at most one solution.

Lemma 2.10. ( $\left[17\right.$, Corollary 3.7]) Suppose that $u_{1}, u_{2}$ are respectively a supersolution and a subsolution of (2.2) such that $f\left(u_{i}\right) \in$ $L^{1}\left(\Omega ; \Phi_{V}\right)$. If $u_{i}$ has an $L_{V}$ boundary trace, say $\nu_{i}, i=1,2$, and $\nu_{2} \leq \nu_{1}$ then problem (2.3) has a (unique) solution for every measure $\nu$ such that $\nu_{2} \leq \nu \leq \nu_{1}$.

## 3. The reduced measures for couples of positive MEASURES.

Notation. If $f$ and $g$ are two non-negative functions on a set $X$, we say that $f$ and $g$ are similar if there exists $c>0$ such that

$$
\frac{1}{c} f(x) \leq g(x) \leq c f(x) \quad \forall x \in X
$$

This relation is denoted by $f \sim g$.
Theorem 3.1. Let $(\tau, \nu) \in \mathfrak{M}_{+}\left(\Omega ; \Phi_{V}\right) \times \mathfrak{M}_{+}(\partial \Omega)$. Let $\left\{f_{n}\right\}$ be a sequence of continuous, bounded, non-decreasing functions on $\mathbb{R}$ such that $f_{n}(0)=0$ and $\left(f_{n}\right)_{ \pm} \uparrow f_{ \pm}$.

Then the boundary value problem

$$
\begin{equation*}
-L_{V} u+f_{n}(u)=\tau \quad \text { in } \Omega, \quad \operatorname{tr}_{V} u=\nu \tag{3.1}
\end{equation*}
$$

has a unique solution $u_{n}=u_{n}(\tau, \nu)$. The sequence $\left\{u_{n}\right\}$ is a decreasing sequence of positive functions and its limit $u^{\#}=u^{\#}(\tau, \nu)$ has the following properties.
(a) $u^{\#}$ satisfies

$$
\begin{equation*}
\left\|u^{\#}\right\|_{L^{1}\left(\Omega ; \Phi_{V} / \delta\right)}+\left\|f\left(u^{\#}\right)\right\|_{L^{1}\left(\Omega ; \Phi_{V}\right)} \leq C\left(\|\nu\|_{\mathfrak{M}(\partial \Omega)}+\|\tau\|_{\mathfrak{M}\left(\Omega ; \Phi_{V}\right)}\right) \tag{3.2}
\end{equation*}
$$

and

$$
\begin{equation*}
u^{\#}+\mathbb{G}_{V}\left[f\left(u^{\#}\right)\right] \leq \mathbb{G}_{V}[\tau]+\mathbb{K}_{V}[\nu]=: \tilde{w} \quad \text { in } \Omega . \tag{3.3}
\end{equation*}
$$

(b) There exists a non-negative measure $\tau^{\#} \leq \tau$ such that

$$
\begin{equation*}
-L_{V} u^{\#}+f\left(u^{\#}\right)=\tau^{\#} \quad \text { in } \Omega \tag{3.4}
\end{equation*}
$$

(c) $u^{\#}$ has $L_{V}$ boundary trace $0 \leq \nu^{\#} \leq \nu$. Thus

$$
\begin{equation*}
u^{\#}+\mathbb{G}_{V}\left[f\left(u^{\#}\right)\right]=\mathbb{G}_{V}\left[\tau^{\#}\right]+\mathbb{K}_{V}\left[\nu^{\#}\right] \quad \text { in } \Omega . \tag{3.5}
\end{equation*}
$$

(d) $u^{\#}$ is the largest subsolution of problem

$$
\begin{equation*}
-L_{V} u+f(u)=\tau \quad \text { in } \Omega, \quad \operatorname{tr}_{V} u=\nu \tag{3.6}
\end{equation*}
$$

In particular, if (3.6) has a solution $u$ then $u^{\#}=u, \tau^{\#}=\tau$ and $\nu^{\#}=\nu$.

Proof. The function $\tilde{w}:=\mathbb{K}_{V}[\nu]+\mathbb{G}_{V}[\tau]$ is a supersolution of the equation

$$
-L_{V} u+f_{n}(u)=\tau \quad \text { in } \Omega
$$

and $\operatorname{tr}_{V} \tilde{w}=\nu$. Obviously $v \equiv 0$ is a subsolution, $v \leq \tilde{w}$ and $f_{n}(\tilde{w}) \in$ $L^{1}\left(\Omega ; \Phi_{V}\right)$.

Therefore, by Lemma [2.10, there exists a unique solution $u_{n}=$ $u_{n}(\tau, \nu)$ of the boundary value problem (3.1) satisfying $0 \leq u_{n} \leq \tilde{w}$ in $\Omega$. The solution $u_{n}$ satisfies

$$
\begin{equation*}
u_{n}+\mathbb{G}_{V}\left[f_{n}\left(u_{n}\right)\right]=\mathbb{G}_{V}[\tau]+\mathbb{K}_{V}[\nu]=\tilde{w} \quad \text { in } \Omega \tag{3.7}
\end{equation*}
$$

Put $w:=u_{n+1}-u_{n}$. Then $w$ is $L_{V}$ perfect and $\operatorname{tr}_{V} w=0$. Consequently, by Lemma 2.6, $\operatorname{tr}_{V} w_{+}=0$. Furthermore

$$
-L_{V} w+f_{n+1}\left(u_{n+1}\right)-f_{n}\left(u_{n}\right)=0 \quad \text { in } \Omega
$$

By Kato's inequality

$$
-L_{V} w_{+}+\left(f_{n+1}\left(u_{n+1}\right)-f_{n}\left(u_{n}\right)\right) \operatorname{sign}+w \leq 0 \quad \text { in } \Omega .
$$

In the set $\left\{x \in \Omega: w_{+} \geq 0\right\}$ :

$$
f_{n+1}\left(u_{n+1}\right)-f_{n}\left(u_{n}\right) \geq f_{n+1}\left(u_{n}\right)-f_{n}\left(u_{n}\right) \geq 0 .
$$

Thus $w_{+}$is $L_{V}$ subharmonic in $\Omega$. As $\operatorname{tr}_{V} w_{+}=0$, Lemma 2.3 yields $w_{+}=0$, i.e., $u_{n+1} \leq u_{n}$ in $\Omega$.
(a) Let $u^{\#}=\lim u_{n}$, then $0 \leq u^{\#} \leq \tilde{w}$ in $\Omega$. By Dini's Lemma, $f_{n}\left(u_{n}\right) \rightarrow f\left(u^{\#}\right)$ a.e. in $\Omega$. Therefore, by (3.7) and Fatou's lemma, we obtain (3.3).

By Theorems 2.1 and 2.2, we have

$$
\int_{\Omega} \frac{\Phi_{V}}{\delta} \tilde{w} d x=\int_{\Omega} \frac{\Phi_{V}}{\delta}\left(\mathbb{K}_{V}[\nu]+\mathbb{G}_{V}[\tau]\right) d x \sim\|\tau\|_{\mathfrak{M}\left(\Omega ; \Phi_{V}\right)}+\|\nu\|_{\mathfrak{M}(\partial \Omega)}
$$

and

$$
\int_{\Omega} \frac{\Phi_{V}}{\delta} \mathbb{G}_{V}\left[f_{n}\left(u_{n}\right)\right] d x \sim \int_{\Omega} f_{n}\left(u_{n}\right) \Phi_{V} d x
$$

Therefore, multiplying (3.7) by $\Phi_{V} / \delta$ and integrating over $\Omega$, we obtain the following similarity relations

$$
\begin{align*}
& \int_{\Omega} u_{n} \frac{\Phi_{V}}{\delta} d x+\int_{\Omega} f_{n}\left(u_{n}\right) \Phi_{V} d x \\
& \sim \int_{\Omega} u_{n} \frac{\Phi_{V}}{\delta} d x+\int_{\Omega} \frac{\Phi_{V}}{\delta} \mathbb{G}_{V}\left[f_{n}\left(u_{n}\right)\right] d x  \tag{3.8}\\
& =\int_{\Omega} \tilde{w} \frac{\Phi_{V}}{\delta} d x \sim\|\tau\|_{\mathfrak{M}\left(\Omega ; \Phi_{V}\right)}+\|\nu\|_{\mathfrak{M}(\partial \Omega)} .
\end{align*}
$$

Letting $n \rightarrow \infty$ and using Fatou's lemma, we obtain (3.2).
(b) Let $\zeta \in C_{c}^{\infty}(\Omega)$. Multiplying (3.7) by $-L_{V} \zeta$ and integrating over $\Omega$, we obtain

$$
-\int_{\Omega} u_{n} L_{V} \zeta d x-\int_{\Omega} \mathbb{G}_{V}\left[f_{n}\left(u_{n}\right)\right] L_{V} \zeta d x=-\int_{\Omega} \mathbb{G}_{V}[\tau] L_{V} \zeta d x
$$

We used the fact that $\mathbb{K}_{V}[\nu]$ is $L_{V}$ harmonic. Further, for every $\tau \in$ $\mathfrak{M}\left(\Omega ; \Phi_{V}\right),-L_{V} \mathbb{G}_{V}[\tau]=\tau$, i.e.,

$$
-\int_{\Omega} \mathbb{G}_{V}[\tau] L_{V} \zeta d x=\int_{\Omega} \zeta d \tau
$$

Hence

$$
-\int_{\Omega} u_{n} L_{V} \zeta d x+\int_{\Omega} f_{n}\left(u_{n}\right) \zeta d x=\int_{\Omega} \zeta d \tau
$$

Recall that $\left\{u_{n}\right\}$ converges to $u^{\#}$ and is dominated by $u_{1}$ in $L^{1}\left(\Omega ; \Phi_{V} / \delta\right)$ and $\left\{f_{n}\left(u_{n}\right)\right\}$ converges to $f\left(u^{\#}\right)$ and - by (3.8) - is bounded in $L^{1}\left(\Omega ; \Phi_{V}\right)$. Consequently, using Fatou's lemma,

$$
-C \int_{\Omega} \zeta d x \leq-\int_{\Omega} u^{\#} L_{V} \zeta d x+\int_{\Omega} f\left(u^{\#}\right) \zeta d x \leq \int_{\Omega} \zeta d \tau
$$

for every $0 \leq \zeta \in C_{c}^{\infty}(\Omega)$ where $C \geq 0$ a constant independent of $\zeta$. Thus there exists a bounded measure $\tau^{\#} \leq \tau$ such that (3.4) holds.

Now, in Lemma 3.4 below, it is shown that $\tau^{\#} \geq \tau_{d}$. This is based only on the assumptions of the present theorem, the definition of $u^{\#}$ as the limit of the decreasing sequence $\left\{u_{n}\right\}$ and what is proved above. Therefore, as $\tau \geq 0$, we conclude that $\tau^{\#} \geq 0$. This completes the proof of part (b).
(c) By (3.3), $u^{\#} \leq \tilde{w}$. Since $\operatorname{tr}_{V} \tilde{w}$ exists and $u^{\#} \geq 0$, it follows that

$$
\begin{aligned}
& \sup _{n} \int_{\partial D_{n}} P_{V, n}\left(x_{0}, y\right)\left|u^{\#}(y)\right| d S(y) \leq \\
& \sup _{n} \int_{\partial D_{n}} P_{V, n}\left(x_{0}, y\right) \tilde{w}(y) d S(y)<+\infty .
\end{aligned}
$$

By (3.4), as $f\left(u^{\#}\right) \in L^{1}\left(\Omega ; \Phi_{V}\right)$, the function $v:=u^{\#}+\mathbb{G}_{V}\left[f\left(u^{\#}\right)\right]$ satisfies $-L_{V} v=\tau$ and $v \geq 0$. Therefore, by Lemma 2.4 and (1.5), $\operatorname{tr}_{V} v=: \nu^{\#}$ exists, $\operatorname{tr}_{V} u^{\#}=\operatorname{tr}_{V} v$ and (3.5) holds. As $0 \leq u^{\#} \leq \tilde{w}$,

$$
0 \leq \nu^{\#} \leq \operatorname{tr}_{V} \tilde{w}=\nu
$$

(d) Let $w$ be a positive subsolution of (3.6). Then

$$
-L_{V} w+f_{n}(w) \leq-L_{V} w+f(w) \leq \tau \quad \text { in } \Omega, \quad \operatorname{tr}_{V} w \leq \nu
$$

On the other hand, we have

$$
-L_{V} u_{n}+f_{n}\left(u_{n}\right)=\tau \quad \text { in } \Omega, \quad \operatorname{tr}_{V} u_{n}=\nu .
$$

By Lemma 2.9, $w \leq u_{n}$ and thus $w \leq u^{\#}$. This proves (d).
Obviously, if (3.6) has a solution $u$ then it is the largest subsolution of the problem so that $u^{\#}=u$.

Definition 3.2. A measure $\tau \in \mathfrak{M}_{+}\left(\Omega ; \Phi_{V}\right)$ is a good measure with respect to $f$ if there exists a solution $u$ of equation (2.2) such that $f(u) \in L^{1}\left(\Omega ; \Phi_{V}\right)$.

A couple of measures $(\tau, \nu) \in \mathfrak{M}_{+}\left(\Omega ; \Phi_{V}\right) \times \mathfrak{M}_{+}(\partial \Omega)$ is a good couple with respect to $f$ if there exists a solution $u$ of problem (3.6).

The couple $\left(\tau^{\#}, \nu^{\#}\right)$ that satisfies (3.5) is called the reduced couple of $(\tau, \nu)$.

Remark 3.3. We note that as a consequence of Theorem 3.1 parts (b) and (c):
(i) For every $\nu \in \mathfrak{M}_{+}(\partial \Omega)$ the reduced couple of $(0, \nu)$ is $\left(0, \nu^{*}\right)$ where $\nu^{*}$ is the largest good measure dominated by $\nu$.
(ii) For every $\tau \in \mathfrak{M}_{+}\left(\Omega ; \Phi_{V}\right)$ the reduced couple of $(\tau, 0)$ is $\left(\tau^{*}, 0\right)$ where $\tau^{*}$ is the largest good measure dominated by $\tau$.

Notation. (a) Let $\tau \in \mathfrak{M}_{+}\left(\Omega ; \Phi_{V}\right)$. Denote by $\tau^{\#}(\nu)$ the measure $\tau^{\#}$ in Theorem 3.1. In particular $\tau^{\#}(0)$ is the reduced measure of problem

$$
L_{V} u+f(u)=\tau \quad \text { in } \Omega, \quad \operatorname{tr}_{V} u=0
$$

(b) Let $\lambda$ be a Borel measure in $\Omega$ such that $\lambda=\lambda_{+}-\lambda_{-}$where $\lambda_{ \pm}$ are positive Radon measures. It is well-known (see e.g. 4]) that $\lambda$ has a unique representation of the form $\lambda=\lambda_{c}+\lambda_{d}$ where $\lambda_{d}$ vanishes on sets of (Newtonian) capacity zero while $\lambda_{c}$ is concentrated on a set of zero capacity. We say that $\lambda_{d}$ is the diffuse part of $\lambda$ while $\lambda_{c}$ is the concentrated part of $\lambda$. If $\lambda=\lambda_{d}$ we say that $\lambda$ is a diffuse measure. If $\lambda=\lambda_{c}$ we say that $\lambda$ is a concentrated measure.

For the proof of the next theorem we need a version of [4, Lemma 4.1] suitable for the present problem. The proof is essentially the same as in [4], but some slight modifications are needed. For the convenience of the reader we provide the proof below.

Lemma 3.4. Let $(\tau, \nu) \in \mathfrak{M}_{+}\left(\Omega ; \Phi_{V}\right) \times \mathfrak{M}_{+}(\partial \Omega)$. Then under the assumptions and with the notation of Theorem 3.1, we have

$$
\begin{equation*}
\tau^{\#} \geq \tau_{d} \quad \text { and } \quad\left(\tau^{\#}\right)_{d}=\tau_{d} \tag{3.9}
\end{equation*}
$$

Proof. Let $u_{n}$ be the solution of (3.1). Then $u_{n} \geq 0$, the sequence $\left\{u_{n}\right\}$ is decreasing and, as in Theorem[3.1, the function $u^{\#}:=\lim u_{n}$ satisfies

$$
\begin{equation*}
-L_{V} u^{\#}+f\left(u^{\#}\right)=\tau^{\#} \quad \text { in } \Omega, \tag{3.10}
\end{equation*}
$$

where $\tau^{\#}$ is a measure such that $\tau^{\#} \leq \tau$.
Denote $T_{k}(s):=\min (k, s), s \in \mathbb{R}$. By [5] and 4, Corollary 4.9],

$$
\Delta T_{k}\left(u_{n}\right) \leq \chi_{\left[u_{n} \leq k\right]}\left(\Delta u_{n}\right)_{d}+\left(\left(\Delta u_{n}\right)_{c}\right)_{+}
$$

where $\chi_{A}$ denotes the characteristic function of $A \subset \mathbb{R}^{N}$. Since $u_{n}$ satisfies (3.1), we obtain

$$
\left(\Delta u_{n}\right)_{d}=-V u_{n}+f_{n}\left(u_{n}\right)-\tau_{d}, \quad\left(\Delta u_{n}\right)_{c}=-\tau_{c}
$$

As $\tau \geq 0$, these relations and the previous inequality yield

$$
\Delta T_{k}\left(u_{n}\right) \leq \chi_{\left[u_{n} \leq k\right]}\left(-V u_{n}+f_{n}\left(u_{n}\right)-\tau_{d}\right) \quad \text { in } \Omega
$$

and

$$
\begin{aligned}
-L_{V} T_{k}\left(u_{n}\right) & \geq-V T_{k}\left(u_{n}\right)+\chi_{\left[u_{n} \leq k\right]}\left(V u_{n}-f_{n}\left(u_{n}\right)+\tau_{d}\right) \\
& =-\chi_{\left[u_{n}>k\right]} V k-\chi_{\left[u_{n} \leq k\right]}\left(f_{n}\left(u_{n}\right)-\tau_{d}\right) .
\end{aligned}
$$

Since $\chi_{\left[u_{n} \leq k\right]} f_{n}\left(u_{n}\right) \leq f_{n}\left(T_{k}\left(u_{n}\right)\right)$, it follows that

$$
\begin{equation*}
-L_{V} T_{k}\left(u_{n}\right)+f_{n}\left(T_{k}\left(u_{n}\right)\right) \geq-\chi_{\left[u_{n}>k\right]}|V| u_{n}+\chi_{\left[u_{n} \leq k\right]} \tau_{d} \quad \text { in } \Omega . \tag{3.11}
\end{equation*}
$$

Let $\zeta \in C_{c}^{\infty}(\Omega)$ and $\zeta \geq 0$. Since $0 \leq u_{n} \leq u_{1}$, (3.11) yields

$$
\begin{aligned}
& -\int_{\Omega} T_{k}\left(u_{n}\right) L_{V} \zeta d x+\int_{\Omega} f_{n}\left(T_{k}\left(u_{n}\right)\right) \zeta d x \geq \\
& -\int_{\Omega} \chi_{\left[u_{1}>k\right]}|V| u_{1} \zeta d x+\int_{\Omega} \chi_{\left[u_{1} \leq k\right]} \zeta d \tau_{d} .
\end{aligned}
$$

By the dominated convergence theorem, letting $n \rightarrow \infty$, we obtain

$$
\begin{aligned}
& -\int_{\Omega} T_{k}\left(u^{\#}\right) L_{V} \zeta d x+\int_{\Omega} f\left(T_{k}\left(u^{\#}\right)\right) \zeta d x \geq \\
& -\int_{\Omega} \chi_{\left[u_{1}>k\right]}|V| u_{1} \zeta d x+\int_{\Omega} \chi_{\left[u_{1} \leq k\right]} \zeta d \tau_{d} .
\end{aligned}
$$

Finally, letting $k \rightarrow \infty$, we obtain

$$
-\int_{\Omega} u^{\#} L_{V} \zeta d x+\int_{\Omega} f\left(u^{\#}\right) \zeta d x \geq \int_{\Omega} \zeta d \tau_{d}
$$

In view of (3.10) this implies $\tau^{\#} \geq \tau_{d}$ and therefore $\left(\tau^{\#}\right)_{d} \geq \tau_{d}$. As $\tau^{\#} \leq \tau$ we obtain $\left(\tau^{\#}\right)_{d}=\tau_{d}$. This proves (3.9).
Theorem 3.5. Under the assumptions and with the notation of Theorem 3.1, the following statements hold.
(i) For every $\tau, \nu^{\#}=\nu^{*}$ with $\nu^{*}$ as in Remark 3.3. Thus $\nu^{\#}$ does not depend on the data $\tau$.
(ii) For every $\nu, \tau^{\#}=\tau^{*}$ with $\tau^{*}$ as in Remark 3.3. Thus $\tau^{\#}$ does not depend on the boundary data $\nu$.
(iii) Let $(0,0) \prec(\lambda, \sigma) \prec(\tau, \nu)$. Then problem

$$
-L_{V} u+f(u)=\lambda \quad \text { in } \Omega, \quad \operatorname{tr}_{V} u=\sigma
$$

has a solution if and only if $(\lambda, \sigma) \prec\left(\tau^{*}, \nu^{*}\right)$.
Proof. (i) Let $u_{n}(\tau, \nu), u^{\#}(\tau, \nu)$ and $\left(\tau^{\#}, \nu^{\#}\right)$ be as in Theorem 3.1, For simplicity, we write $u^{*}=u^{\#}(0, \nu)$ and $u^{\#}=u^{\#}(\tau, \nu)$. Since $0 \leq$ $u_{n}(0, \nu) \leq u_{n}(\tau, \nu)$, it follows that $0 \leq u^{*} \leq u^{\#}$ in $\Omega$. Therefore, using Theorem 3.1(c), we obtain

$$
\begin{equation*}
\nu^{*}=\operatorname{tr}_{V} u^{*} \leq \operatorname{tr}_{V} u^{\#}=\nu^{\#} \leq \nu \tag{3.12}
\end{equation*}
$$

Consequently $u^{*}$ is a subsolution of problem

$$
\begin{equation*}
-L_{V} u+f(u)=0 \quad \text { in } \Omega, \quad \operatorname{tr}_{V} u=\nu^{\#} \tag{3.13}
\end{equation*}
$$

Obviously $u^{\#}$ is a supersolution of (3.13). Hence, by Lemma 2.10, there exists a unique solution $\bar{v}$ of problem (3.13) and $0 \leq u^{*} \leq \bar{v} \leq u^{\#}$. By Theorem 3.1,,$u^{*}$ is the largest solution of the equation $-L_{V} u+f(u)=0$ in $\Omega$ with $L_{V}$ boundary trace $\leq \nu$. Thus $\bar{v} \leq u^{*}$ and consequently $\nu^{\#}=\operatorname{tr}_{V} \bar{v} \leq \operatorname{tr}_{V} u^{*}=\nu^{*}$. This inequality and (3.12) imply $\nu^{\#}=\nu^{*}$.
(ii) Here we denote by $R(\tau, \nu)$ the reduced couple of $(\tau, \nu)$. For given $\tau$ we denote by $\tau^{\#}(\nu)$ the first component of $R(\tau, \nu)$.

In view of Theorem 3.1(d),

$$
R\left(\tau, \nu^{\#}\right)=R(\tau, \nu), \quad \tau^{\#}(\nu)=\tau^{\#}\left(\nu^{\#}\right)
$$

Hence, as $\nu^{\#}=\nu^{*}$,

$$
\begin{equation*}
R(\tau, \nu)=R\left(\tau, \nu^{*}\right), \quad u^{\#}(\tau, \nu)=u^{\#}\left(\tau, \nu^{*}\right) . \tag{3.14}
\end{equation*}
$$

Therefore, in this part of the proof we may assume that $\nu=\nu^{*}$.
Step I. If $\nu_{1}, \nu_{2} \in \mathfrak{M}_{+}(\partial \Omega)$ and $\nu_{1} \leq \nu_{2}$ then

$$
\begin{equation*}
\tau^{\#}\left(\nu_{1}\right) \geq \tau^{\#}\left(\nu_{2}\right) \tag{3.15}
\end{equation*}
$$

Proof. The assumption implies that $\nu_{1}^{*} \leq \nu_{2}^{*}$. Therefore by (3.14), we may assume that $\nu_{1}, \nu_{2}$ are good measures with respect to (3.6).

Let $\lambda$ be a measure such that $0 \leq \lambda \leq \tau$ and suppose that there exists a solution $u_{2}$ of

-L u+f(u)=\lambda \quad \text { in } \Omega, \quad \operatorname{tr}_{V} u=\nu_{2} .
$$

Then $u_{2}$ is a supersolution of

$$
\begin{equation*}
-L u+f(u)=\lambda \quad \text { in } \Omega, \quad \operatorname{tr}_{V} u=\nu_{1} . \tag{3.16}
\end{equation*}
$$

We also know that there exists $\lambda^{\#} \leq \lambda$ such that the following problem has a solution $u_{1}$ :

$$
-L u+f(u)=\lambda^{\#} \quad \text { in } \Omega, \quad \operatorname{tr}_{V} u=\nu_{1} .
$$

The function $u_{1}$ is a subsolution of (3.16) and, by Lemma 2.9, $u_{1} \leq u_{2}$. Hence there exists a solution $\bar{v}$ of (3.16). Clearly, $\bar{v}$ is a subsolution of

$$
-L_{V} u+f(u)=\tau \quad \text { in } \Omega, \quad \operatorname{tr}_{V} u=\nu_{1}
$$

and therefore, by Theorem 3.1(d), $\lambda \leq \tau^{\#}\left(\nu_{1}\right)$. As $\lambda=\tau^{\#}\left(\nu_{2}\right)$ satisfies the conditions required above, this implies (3.15).

Step II. With $\nu^{*}$ as before we prove that

$$
\begin{equation*}
\tau^{\#}\left(\nu^{*}\right)=\tau^{\#}(0) \tag{3.17}
\end{equation*}
$$

Let $u_{0}^{\#}$ be the solution of

$$
-L_{V} u+f(u)=\tau^{\#}(0) \quad \text { in } \Omega, \quad \operatorname{tr}_{V} u=0
$$

Then $u_{0}^{\#}$ is a subsolution of (3.6). By Theorem 3.1(d) and (3.14),

$$
u_{0}^{\#} \leq u^{\#}(\tau, \nu)=u^{\#}\left(\tau, \nu^{*}\right)
$$

Let $w:=u^{\#}\left(\tau, \nu^{*}\right)-u_{0}^{\#}$ so that

$$
-L_{V} w+f\left(u^{\#}\left(\tau, \nu^{*}\right)\right)-f\left(u_{0}^{\#}\right)=\tau^{\#}\left(\nu^{*}\right)-\tau^{\#}(0) \quad \text { in } \Omega .
$$

As $w \geq 0$, by the inverse maximum principle [8],

$$
-(\Delta w)_{c}=\left(\tau^{\#}\left(\nu^{*}\right)-\tau^{\#}(0)\right)_{c} \geq 0
$$

Moreover, by Lemma 3.4,

$$
\tau^{\#}\left(\nu^{*}\right)_{d}=\tau^{\#}(0)_{d}=\tau_{d}
$$

Hence $\tau^{\#}\left(\nu^{*}\right) \geq \tau^{\#}(0)$. On the other hand, by step $\mathrm{I}, \tau^{\#}\left(\nu^{*}\right) \leq \tau^{\#}(0)$. This proves (3.17).
(iii) This is a simple consequence of statements (i) and (ii) and Theorem 3.1(d).

Remark 3.6. Given a real function $h$ on $\mathbb{R}$, denote by $\hat{h}$ the function given by

$$
\hat{h}(t):=-h(-t) \quad \forall t \in \mathbb{R}
$$

Let $f_{n}, \tau, \nu$ be as in Theorem 3.1. If $w_{n}$ is the solution of the boundary value problem

$$
-L_{V} w+\hat{f}_{n}(w)=\tau \quad \text { in } \Omega, \quad \operatorname{tr}_{V} w=\nu
$$

then $z_{n}=-w_{n}$ satisfies

$$
-L_{V} z_{n}+f_{n}\left(z_{n}\right)=-\tau \quad \text { in } \Omega, \quad \operatorname{tr}_{V} z_{n}=-\nu
$$

Since $\hat{f}_{n}$ has the same properties as $f_{n}$, the sequence $\left\{w_{n}\right\}$ has the same properties as the sequence $\left\{u_{n}\right\}$ in Theorem 3.1.

Accordingly, for $(\tau, \nu) \in \mathfrak{M}_{+}\left(\Omega ; \Phi_{V}\right) \times \mathfrak{M}_{+}(\partial \Omega)$ the reduced measures for $-\tau$ and $-\nu$ and the corresponding reduced couple are given by

$$
\begin{gather*}
(-\tau)^{\#}:=-\left(\tau_{\hat{f}}^{\#}\right), \quad(-\nu)^{\#}:=-\left(\nu_{\hat{f}}^{\#}\right) \\
(-\tau,-\nu)^{\#}:=-\left((\tau, \nu)_{\hat{f}}^{\#}\right)=\left((-\tau)^{\#},(-\nu)^{\#}\right) \tag{3.18}
\end{gather*}
$$

(The subscript $\hat{f}$ above indicates that the reduced measure or couple is defined relative to this function.)

In this case $(-\tau)^{\#}$ and $(-\nu)^{\#}$ are the smallest good measures dominating $-\tau$ and $-\nu$ respectively. The relation between the solutions corresponding to the reduced couples is given below

$$
u^{\#}(-\tau,-\nu)=-u_{\hat{f}}^{\#}(\tau, \nu) .
$$

Here again the notation $u_{\hat{f}}^{\#}$ indicates that the reduced couple and the corresponding solution is defined relative to $\hat{f}$.

In view of this remark, the results of Theorems 3.1 and 3.5, with obvious modifications, also apply to couples of negative measures.

## 4. Signed measures

Theorem 4.1. Let $\tau \in \mathfrak{M}\left(\Omega ; \Phi_{V}\right)$ and $\nu \in \mathfrak{M}(\partial \Omega)$. Let $\tau_{1}, \tau_{2} \in$ $\mathfrak{M}_{+}\left(\Omega ; \Phi_{V}\right)$ and $\nu_{1}, \nu_{2} \in \mathfrak{M}_{+}(\partial \Omega)$ be measures such that

$$
\begin{equation*}
-\tau_{1} \leq \tau \leq \tau_{2}, \quad-\nu_{1} \leq \nu \leq \nu_{2} \tag{4.1}
\end{equation*}
$$

Let $\left\{f_{n}\right\}$ be a sequence of functions as in Theorem 3.1. Then the boundary value problem (3.1) has a unique solution $u_{n}=u_{n}(\tau, \nu)$.

The following statements hold.
(a) The sequence $\left\{u_{n}\right\}$ is bounded in $W_{\mathrm{loc}}^{1, p}(\Omega)$ for every $p \in\left[1, \frac{N}{N-1}\right)$. Consequently every subsequence has a limit point in the sense of convergence in $L_{l o c}^{p}(\Omega)$ and convergence a.e. in $\Omega$.

If $\left\{u_{n_{k}}\right\}$ is a subsequence of $\left\{u_{n}\right\}$ converging to $\tilde{u}$ a.e. then:

$$
\begin{array}{ll}
\text { (i) } & u_{n_{k}} \rightarrow \tilde{u} \quad \text { in } L^{1}\left(\Omega ; \Phi_{V} / \delta\right), \\
(i i) & f_{n_{k}}\left(u_{n_{k}}\right) \rightarrow f(\tilde{u}) \quad \text { a.e. in } \Omega . \tag{4.2}
\end{array}
$$

(b) The following inequality holds

$$
\begin{equation*}
\|\tilde{u}\|_{L^{1}\left(\Omega ; \Phi_{V} / \delta\right)}+\|f(\tilde{u})\|_{L^{1}\left(\Omega ; \Phi_{V}\right)} \leq C \sum_{i=1,2}\left(\left\|\tau_{i}\right\|_{\mathfrak{M}\left(\Omega ; \Phi_{V}\right)}+\left\|\nu_{i}\right\|_{\mathfrak{M}(\partial \Omega)}\right) \tag{4.3}
\end{equation*}
$$

(c) There exist $\tilde{\tau} \in \mathfrak{M}\left(\Omega ; \Phi_{V}\right)$ and $\tilde{\nu} \in \mathfrak{M}(\partial \Omega)$ such that

$$
\begin{equation*}
\left(-\tau_{1}\right)^{\#} \leq \tilde{\tau} \leq \tau_{2}^{\#}, \quad\left(-\nu_{1}\right)^{\#} \leq \tilde{\nu} \leq \nu_{2}^{\#} \tag{4.4}
\end{equation*}
$$

and

$$
\tilde{u}+\mathbb{G}_{V}[f(\tilde{u})]=\mathbb{G}_{V}[\tilde{\tau}]+\mathbb{K}_{V}[\tilde{\nu}] \quad \text { in } \Omega
$$

Thus $\tilde{u}$ is the solution of the boundary value problem

$$
\begin{equation*}
-L_{V} \tilde{u}+f(\tilde{u})=\tilde{\tau} \quad \text { in } \Omega, \quad \operatorname{tr}_{V} \tilde{u}=\tilde{\nu} \tag{4.5}
\end{equation*}
$$

Proof. Let $v_{2, n}$ denote the solution of the boundary value problem

$$
\begin{equation*}
-L_{V} v+f_{n}(v)=\tau_{2} \quad \text { in } \Omega, \quad \operatorname{tr}_{V} v=\nu_{2} \tag{4.6}
\end{equation*}
$$

and $v_{1, n}$ denote the solution of the boundary value problem

$$
\begin{equation*}
-L_{V} v+f_{n}(v)=-\tau_{1} \quad \text { in } \Omega, \quad \operatorname{tr}_{V} v=-\nu_{1} \tag{4.7}
\end{equation*}
$$

By Theorem 3.1 and Remark 3.6. $v_{2, n}$ and $-v_{1, n}$ are positive and the following inequalities hold

$$
\begin{align*}
&\left\|v_{i, n}\right\|_{L^{1}\left(\Omega ; \Phi_{V} / \delta\right)}+\left\|f_{n}\left(v_{i, n}\right)\right\|_{L^{1}\left(\Omega ; \Phi_{V}\right)}  \tag{4.8}\\
& \leq C\left(\left\|\tau_{i}\right\|_{\mathfrak{M}\left(\Omega ; \Phi_{V}\right)}+\left\|\nu_{i}\right\|_{\mathfrak{M}(\partial \Omega)}\right), \quad i=1,2
\end{align*}
$$

Moreover,

$$
\begin{gathered}
v_{1, n} \uparrow v_{1}^{\#}(-\tau,-\nu)=: w_{1}, \quad v_{2, n} \downarrow v_{2}^{\#}(\tau, \nu)=: w_{2} \quad \text { a.e. in } \Omega, \\
f\left(v_{i}^{\#}\right) \in L^{1}\left(\Omega ; \Phi_{V}\right), \quad i=1,2,
\end{gathered}
$$

and there exist

$$
\tau_{2}^{\#},\left(-\tau_{1}\right)^{\#} \in \mathfrak{M}\left(\Omega ; \Phi_{V}\right), \quad \nu_{2}^{\#},\left(-\nu_{1}\right)^{\#} \in \mathfrak{M}(\partial \Omega)
$$

such that

$$
\begin{array}{ll}
-L_{V} w_{2}+f\left(w_{2}\right)=\tau_{2}^{\#} \quad \text { in } \Omega, &  \tag{4.9}\\
\operatorname{tr}_{V} w_{2}=\nu_{2}^{\#} \\
-L_{V} w_{1}+f\left(w_{1}\right)=\left(-\tau_{1}\right)^{\#} \quad \text { in } \Omega, & \operatorname{tr}_{V} w_{1}=\left(-\nu_{1}\right)^{\#}
\end{array}
$$

The monotone convergence of the sequences $\left\{v_{i, n}\right\}$ and (4.8) imply

$$
\begin{equation*}
v_{i, n} \rightarrow w_{i} \quad \text { in } L^{1}\left(\Omega ; \Phi_{V} / \delta\right) \tag{4.10}
\end{equation*}
$$

and, by Dini's lemma,

$$
\begin{equation*}
f_{n}\left(v_{i, n}\right) \rightarrow f\left(w_{i}\right) \quad \text { a.e. in } \Omega, \quad i=1,2 . \tag{4.11}
\end{equation*}
$$

(a) By (3.1) and (4.6), we have

$$
\begin{align*}
-L_{V}\left(u_{n}-v_{2, n}\right)+f_{n}\left(u_{n}\right)-f_{n}\left(v_{2, n}\right) & =\tau-\tau_{2} \quad \text { in } \Omega \\
\operatorname{tr}_{V}\left(u_{n}-v_{2, n}\right) & =\nu-\nu_{2} . \tag{4.12}
\end{align*}
$$

By (4.1), $\tau-\tau_{2} \leq 0$ and $\nu-\nu_{2} \leq 0$. Therefore, using Kato's inequality, we obtain $-L_{V}\left(u_{n}-v_{2, n}\right)_{+} \leq 0$ and, by Lemma 2.6, $\operatorname{tr}_{V}\left(u_{n}-v_{2, n}\right)_{+}=0$. By Lemma 2.3, $\left(u_{n}-v_{2, n}\right)_{+}=0$, which implies

u_{n} \leq v_{2, n} \quad \text { in } \Omega \tag{4.13}
\end{equation*}
$$

Similarly, by (3.1) and (4.7), we obtain

\end{equation*}

(Recall that $v_{1, n} \leq 0$.) Thus

\left|u_{n}\right| \leq \max \left\{-v_{1, n}, v_{2, n}\right\} \quad \text { in } \Omega \tag{4.15}
\end{equation*}
$$

This inequality and the monotonicity of $f_{n}$ imply that

\left|f_{n}\left(u_{n}\right)\right| \leq \max \left\{f_{n}\left(-v_{1, n}\right), f_{n}\left(v_{2, n}\right)\right\} \quad \text { in } \Omega . \tag{4.16}
\end{equation*}
$$

Inequalities (4.15), (4.16) and (4.8) together with the fact that $V$ is locally bounded in $\Omega$ imply that $\left\{\left|V u_{n}+f_{n}\left(u_{n}\right)\right|\right\}$ is bounded in $L_{\text {loc }}^{1}(D)$. Consequently $\left\{u_{n}\right\}$ is bounded in $W_{\mathrm{loc}}^{1, p}(\Omega)$ for every $p \in\left[1, \frac{N}{N-1}\right)$. Therefore $\left\{u_{n}\right\}$ is precompact in $L_{\mathrm{loc}}^{p}(\Omega)$. Hence there exists a subsequence $\left\{u_{n_{k}}\right\}$ ) that converges to a function $\tilde{u}$ in $L_{\text {loc }}^{p}(\Omega)$ and a.e. in $\Omega$.

By the generalized dominated convergence theorem, the convergence of $\left\{u_{n_{k}}\right\}$ to $\tilde{u}$ a.e. in $\Omega$, (4.15) and (4.10) imply (4.2) (i).

The assumption $f_{n}^{ \pm} \uparrow f^{ \pm}$and Dini's lemma imply (4.2) (ii).
To simplify the presentation, in the remainder of the proof we assume that $\left\{u_{n}\right\}$ is a sequence converging a.e. to $\tilde{u}$.
(b) By (4.15), (4.8) and (4.2)(i), we obtain

$$
\begin{aligned}
\|\tilde{u}\|_{L^{1}\left(\Omega ; \Phi_{V} / \delta\right)} & =\lim _{n \rightarrow \infty}\left\|u_{n}\right\|_{L^{1}\left(\Omega ; \Phi_{V} / \delta\right)} \\
& \leq C \sum_{i=1,2}\left(\left\|\tau_{i}\right\|_{\mathfrak{M}\left(\Omega ; \Phi_{V}\right)}+\left\|\nu_{i}\right\|_{\mathfrak{M}(\partial \Omega)}\right) .
\end{aligned}
$$

By Fatou's lemma, (4.16), (4.8) and (4.2) yield

$$
\begin{aligned}
\|f(\tilde{u})\|_{L^{1}\left(\Omega ; \Phi_{V}\right)} & \leq \lim _{n \rightarrow \infty}\left\|f_{n}\left(u_{n}\right)\right\|_{L^{1}\left(\Omega ; \Phi_{V}\right)} \\
& \leq \limsup _{n \rightarrow \infty}\left\|\max \left\{f_{n}\left(-v_{1, n}\right), f_{n}\left(v_{2, n}\right)\right\}\right\|_{L^{1}\left(\Omega ; \Phi_{V}\right)} \\
& \leq C \sum_{i=1,2}\left(\left\|\tau_{i}\right\|_{\mathfrak{M}\left(\Omega ; \Phi_{V}\right)}+\left\|\nu_{i}\right\|_{\mathfrak{M}(\partial \Omega)}\right) .
\end{aligned}
$$

This proves (4.3).
(c) Inequalities (4.13) and (4.14) imply $w_{1} \leq \tilde{u} \leq w_{2}$ a.e. in $\Omega$.

Let $\zeta \in C_{c}^{\infty}(\Omega)$ and $\zeta \geq 0$. By (4.12),

$$
\begin{equation*}
-\int_{\Omega}\left(v_{2, n}-u_{n}\right) L_{V} \zeta d x+\int_{\Omega}\left(f_{n}\left(v_{2, n}\right)-f_{n}\left(u_{n}\right)\right) \zeta d x=\int_{\Omega} \zeta d\left(\tau_{2}-\tau\right) \tag{4.17}
\end{equation*}
$$

By (4.13), (4.11) and Fatou's lemma,

$$
\int_{\Omega}\left(f\left(w_{2}\right)-f(\tilde{u})\right) \zeta d x \leq \liminf _{n \rightarrow \infty} \int_{\Omega}\left(f_{n}\left(v_{2, n}\right)-f_{n}\left(u_{n}\right)\right) \zeta d x
$$

Therefore, by (4.17) and (4.10),

$$
\begin{equation*}
-\int_{\Omega}\left(w_{2}-\tilde{u}\right) L_{V} \zeta d x+\int_{\Omega}\left(f\left(w_{2}\right)-f(\tilde{u})\right) \zeta d x \leq \int_{\Omega} \zeta d\left(\tau_{2}-\tau\right) \tag{4.18}
\end{equation*}
$$

By (4.17), we have

$$
\left|\int_{\Omega}\left(v_{2, n}-u_{n}\right) L_{V} \zeta d x\right| \leq \int_{\Omega}\left(f_{n}\left(v_{2, n}\right)-f_{n}\left(u_{n}\right)\right) \zeta d x+\int_{\Omega} \zeta d\left(\tau_{2}-\tau\right) .
$$

By (4.8), (4.15) and (4.16),

$$
\begin{aligned}
0 & \leq \int_{\Omega}\left(f_{n}\left(v_{2, n}\right)-f_{n}\left(u_{n}\right)\right) \zeta d x+\int_{\Omega} \zeta d\left(\tau_{2}-\tau\right) \\
& \leq c \sup \left(\zeta / \Phi_{V}\right)\left(\sum_{i=1,2}\left(\left\|\tau_{i}\right\|_{\mathfrak{M}\left(\Omega ; \Phi_{V}\right)}+\left\|\nu_{i}\right\|_{\mathfrak{M}(\partial \Omega)}+\|\tau\|_{\mathfrak{M}\left(\Omega ; \Phi_{V}\right)}\right)\right. \\
& \leq C \sup \left(\zeta / \Phi_{V}\right)
\end{aligned}
$$

Since

$$
\lim _{n \rightarrow \infty} \int_{\Omega}\left(v_{2, n}-u_{n}\right) L_{V} \zeta d x=\int_{\Omega}\left(w_{2}-\tilde{u}\right) L_{V} \zeta d x
$$

it follows that

$$
\left|\int_{\Omega}\left(w_{2}-\tilde{u}\right) L_{V} \zeta d x\right| \leq C \sup \left(\zeta / \Phi_{V}\right)
$$

Hence, by (4.18), there exists a measure $\lambda \leq \tau_{2}-\tau$ such that $\lambda \in$ $\mathfrak{M}\left(\Omega ; \Phi_{V}\right)$ and
$-\int_{\Omega}\left(w_{2}-\tilde{u}\right) L_{V} \zeta d x+\int_{\Omega}\left(f\left(w_{2}\right)-f(\tilde{u})\right) \zeta d x=\int_{\Omega} \zeta d \lambda \quad \forall \zeta \in C_{c}^{\infty}(\Omega)$ or equivalently,

$$
\begin{equation*}
-L_{V}\left(w_{2}-\tilde{u}\right)+f\left(w_{2}\right)-f(\tilde{u})=\lambda \quad \text { in } \Omega \tag{4.19}
\end{equation*}
$$

Consequently, by (4.9),

$$
\begin{equation*}
-L_{V} \tilde{u}+f(\tilde{u})=\tilde{\tau} \quad \text { in } \Omega \quad \text { where } \quad \tilde{\tau}:=\tau_{2}^{\#}-\lambda \geq \tau_{2}^{\#}-\tau_{2}+\tau \tag{4.20}
\end{equation*}
$$

Next, by (3.1) and (4.7), for $\zeta \in C_{c}^{\infty}(\Omega)$,

$$
-\int_{\Omega}\left(u_{n}-v_{1, n}\right) L_{V} \zeta d x+\int_{\Omega}\left(f_{n}\left(u_{n}\right)-f_{n}\left(v_{1, n}\right)\right) \zeta d x=\int_{\Omega} \zeta d\left(\tau_{1}+\tau\right)
$$

By the same argument as above it follows that there exists a measure $\lambda^{\prime} \leq \tau_{1}+\tau$ such that $\lambda^{\prime} \in \mathfrak{M}\left(\Omega ; \Phi_{V}\right)$ and

$$
\begin{equation*}
-L_{V}\left(\tilde{u}-w_{1}\right)+f(\tilde{u})-f\left(w_{1}\right)=\lambda^{\prime} \quad \text { in } \Omega \tag{4.21}
\end{equation*}
$$

Consequently, by (4.9),

$$
\begin{equation*}
\tilde{\tau}=\lambda^{\prime}+\left(-\tau_{1}\right)^{\#} \leq \tau_{1}+\tau+\left(-\tau_{1}\right)^{\#} \tag{4.22}
\end{equation*}
$$

Next we show that $\tilde{\tau}$ satisfies (4.4). By Lemma 3.4,

Therefore, by (4.20), $\tilde{\tau}_{d} \geq \tau_{d}$ and by (4.22), $\tilde{\tau}_{d} \leq \tau_{d}$. Thus

\tau_{d}=\tilde{\tau}_{d} \tag{4.24}
\end{equation*}
$$

By (4.19) and (4.20),

$$
-L_{V}\left(w_{2}-\tilde{u}\right)+f\left(w_{2}\right)-f(\tilde{u})=\tau_{2}^{\#}-\tilde{\tau} \quad \text { in } \Omega .
$$

Since $\tilde{u}$ and $w_{2}$ are diffuse and $f(0)=0$, it follows that

$$
\begin{equation*}
\left(-\Delta\left(w_{2}-\tilde{u}\right)\right)_{c}=\left(\tau_{2}^{\#}-\tilde{\tau}\right)_{c} \tag{4.25}
\end{equation*}
$$

As $w_{2}-\tilde{u} \geq 0$, by the inverse maximum principle [8], $\left(-\Delta\left(w_{2}-\tilde{u}\right)\right)_{c} \geq 0$. Consequently,

$$
\left(\tau_{2}^{\#}-\tilde{\tau}\right)_{c} \geq 0
$$

As $\tau \leq \tau_{2}$, (4.23), (4.24) yield,

$$
\left(\tau_{2}^{\#}\right)_{d}=\left(\tau_{2}\right)_{d} \geq \tau_{d}=\tilde{\tau}_{d}
$$

This inequality and (4.25) imply

$$
\begin{equation*}
\tilde{\tau} \leq \tau_{2}^{\#} \tag{4.26}
\end{equation*}
$$

Similarly by (4.21) and (4.22),

$$
-L_{V}\left(\tilde{u}-w_{1}\right)+f(\tilde{u})-f\left(w_{1}\right)=\tilde{\tau}-\left(-\tau_{1}\right)^{\#} \quad \text { in } \Omega .
$$

Since $\tilde{u}-w_{1} \geq 0$, another application of the inverse maximum principle yields $\left(-\Delta\left(\tilde{u}-w_{1}\right)\right)_{c} \geq 0$ and consequently

$$
\begin{equation*}
\left(\tilde{\tau}-\left(-\tau_{1}\right)^{\#}\right)_{c} \geq 0 \tag{4.27}
\end{equation*}
$$

As $-\tau_{1} \leq \tau$, (4.23), (4.24) imply

$$
\tilde{\tau}_{d}=\tau_{d} \geq\left(-\tau_{1}\right)_{d}=\left(\left(-\tau_{1}\right)^{\#}\right)_{d} .
$$

This and (4.27) yield

$$
\tilde{\tau} \geq\left(-\tau_{1}\right)^{\#} .
$$

Finally, this and (4.26) imply (4.4) with respect to $\tilde{\tau}$.
It remains to show that $\tilde{u}$ has an $L_{V}$ boundary trace and that the second inequality in (4.4) holds.

By (4.19) $-L_{V}\left(w_{2}-\tilde{u}\right)=\mu$ where $\mu \in \mathfrak{M}\left(\Omega ; \Phi_{V}\right)$. Since $w_{2}-\tilde{u} \geq 0$, by Lemma 2.5, $w_{2}-\tilde{u}$ has an $L_{V}$ boundary trace, say $\sigma$, and $w_{2}-\tilde{u}=$ $\mathbb{G}_{V}[\mu]+\mathbb{K}_{V}[\sigma]$. Obviously $\sigma \geq 0$. Therefore

$$
\operatorname{tr}_{V} \tilde{u}=\operatorname{tr}_{V} w_{2}-\sigma \leq \operatorname{tr}_{V} w_{2}=\nu_{2}^{\#}
$$

Similarly, starting with (4.21) we conclude that there exists $\sigma^{\prime} \in$ $\mathfrak{M}(\partial \Omega)$ such that $\operatorname{tr}_{V}\left(\tilde{u}-w_{1}\right)=\sigma^{\prime} \geq 0$. Therefore

$$
\operatorname{tr}_{V} \tilde{u}=\sigma^{\prime}+\operatorname{tr}_{V} w_{1} \geq \operatorname{tr}_{V} w_{1}=\left(-\nu_{1}\right)^{\#}
$$

This completes the proof.
The theorem is complemented by the following consequence of [17, Corollary 3.7] (see Lemma 2.10).

Proposition 4.2. Let $\left(\lambda_{i}, \sigma_{i}\right) \in \mathfrak{M}\left(\Omega ; \Phi_{V}\right) \times \mathfrak{M}(\partial \Omega), i=1,2$. Suppose that these are good couples with respect to (1.1) and that $\left(\lambda_{1}, \sigma_{1}\right) \prec$ $\left(\lambda_{2}, \sigma_{2}\right)$. Then, every couple $(\lambda, \sigma)$ such that

$$
\begin{equation*}
\left(\lambda_{1}, \sigma_{1}\right) \prec(\lambda, \sigma) \prec\left(\lambda_{2}, \sigma_{2}\right) \tag{4.28}
\end{equation*}
$$

is a good couple.
Proof. Let $v_{i}$ be the solution corresponding to the couple $\left(\lambda_{i}, \sigma_{i}\right), i=$ 1,2 and let $(\lambda, \sigma)$ be as in (4.28). Then $v_{2}$ is a supersolution and $v_{1}$ a subsolution of equation $-L_{V} u+f(u)=\lambda$ and $\operatorname{tr}_{V} v_{1} \leq \sigma \leq \operatorname{tr}_{V} v_{2}$. Therefore the stated result is a consequence of Lemma (2.10).

Remark. As mentioned before, Theorem 4.1 and Proposition 4.2 imply Theorem 1.4. However we emphasize that, in contrast to Theorem 4.1, in Proposition $4.2\left(\lambda_{i}, \sigma_{i}\right)$ may be couples of signed measures.

Proposition 4.3. In addition to the assumptions of Theorem 4.1, assume that $\left(\tau_{2}, \nu_{2}\right)$ and $\left(-\tau_{1},-\nu_{1}\right)$ are good couples.

Suppose that $\left(-\tau_{1},-\nu_{1}\right) \prec(\tau, \nu) \prec\left(\tau_{2}, \nu_{2}\right)$. (By the previous result, $(\tau, \nu)$ is a good couple.) Let $u$ be the solution of problem (2.3) and let $u_{n}$ denote the solution of the 'approximating' problem

$$
-L_{V} u+f_{n}(u)=\tau \quad \text { in } \Omega, \quad \operatorname{tr}_{V} u=\nu
$$

If $\Phi_{V}$ satisfies the additional condition

$$
\begin{equation*}
\int_{\Sigma_{\beta}} \Phi_{V}^{2} / \delta d S \rightarrow 0 \quad \text { as } \beta \rightarrow 0 \tag{4.29}
\end{equation*}
$$

then $u_{n} \rightarrow u$, i.e. $\tilde{u}=u$.
Proof. We use the notation in the proof of Theorem 4.1.
Let $v_{1, n}$ and $v_{2, n}$ be the solutions of (4.7) and (4.6). Then

$$
\begin{equation*}
v_{1, n} \leq u_{n} \leq v_{2, n} \quad \text { in } \Omega \tag{4.30}
\end{equation*}
$$

The sequences $\left\{v_{i, n}\right\}, i=1,2$ satisfy (4.10) and (4.11). In addition, by Proposition A. 1 (see Appendix),

$$
\begin{equation*}
f_{n}\left(v_{i, n}\right) \rightarrow f\left(w_{i}\right) \quad \text { in } \quad L^{1}\left(\Omega ; \Phi_{V}\right) \tag{4.31}
\end{equation*}
$$

By (4.30) and the monotonicity of $f_{n}$,

$$
f_{n}\left(v_{1, n}\right) \leq f_{n}\left(u_{n}\right) \leq f_{n}\left(v_{2, n}\right) \quad \text { in } \Omega
$$

Therefore, taking a subsequence for which (4.2) holds, the (generalized) dominated convergence theorem implies $f_{n}\left(u_{n}\right) \rightarrow f(\tilde{u})$ in $L^{1}\left(\Omega ; \Phi_{V}\right)$ as $n \rightarrow \infty$. Hence, by Theorem 2.2,

$$
\mathbb{G}_{V}\left[f_{n}\left(u_{n}\right)\right] \rightarrow \mathbb{G}_{V}[f(\tilde{u})] \quad \text { in } \quad L^{1}\left(\Omega ; \Phi_{V} / \delta\right) .
$$

By (4.2), $u_{n} \rightarrow \tilde{u}$ in $L^{1}\left(\Omega ; \Phi_{V} / \delta\right)$. As

$$
u_{n}+\mathbb{G}_{V}\left[f_{n}\left(u_{n}\right)\right]=\mathbb{G}_{V}[\tau]+\mathbb{K}_{V}[\nu] \quad \text { in } \Omega
$$

we conclude that

$$
\tilde{u}+\mathbb{G}_{V}[f(\tilde{u})]=\mathbb{G}_{V}[\tau]+\mathbb{K}_{V}[\nu] \quad \text { in } \Omega .
$$

Thus $\tilde{u}$ is a solution of (2.3). By uniqueness (Lemma 2.9), $\tilde{u}=u$.
Proof of Theorem 1.5. Since $f$ vanishes on $(-\infty, 0]$, if $w$ is a real function on $\Omega$ then

$$
\begin{equation*}
f(w)=f\left(w_{+}\right)+f\left(-w_{-}\right)=f\left(w_{+}\right) . \tag{4.32}
\end{equation*}
$$

Suppose that $(\tau, \nu)$ is a good couple, i.e. (3.6) has a solution $u$ such that $f(u) \in L^{1}\left(\Omega ; \Phi_{V}\right)$.

Let $u_{n}$ and $\tilde{u}$ be as in Theorem 4.1. In view of (4.32), $\left\{u_{n}\right\}$ is decreasing (by Lemma 2.9) and $\tilde{u}=\lim u_{n}$.

Let $w$ be a subsolution of (3.6) such that $f(w) \in L^{1}\left(\Omega ; \Phi_{V}\right)$. Then

$$
-L_{V} w+f_{n}(w) \leq-L_{V} w+f\left(w_{+}\right) \leq \tau \quad \text { in } \Omega, \quad \operatorname{tr}_{V} w \leq \nu
$$

As $u_{n}$ satisfies (3.1), Lemma 2.9 implies that $w \leq u_{n}$. Thus $w \leq \tilde{u}$ and, in particular,

$$
\begin{equation*}
u \leq \tilde{u} \quad \text { in } \Omega \tag{4.33}
\end{equation*}
$$

Let $v:=\tilde{u}-u$. Then $v \geq 0, \Delta v$ is a measure and therefore, by the inverse maximum principle,

$$
(-\Delta v)_{c}=(\tilde{\tau}-\tau)_{c} \geq 0
$$

As in the proof of Theorem 4.1 (see (4.24)) $\tau_{d}=\tilde{\tau}_{d}$. Therefore

$$
\tau \leq \tilde{\tau}
$$

In addition, by (4.33),

$$
\nu=\operatorname{tr}_{V} u \leq \operatorname{tr}_{V} \tilde{u}=\tilde{\nu} .
$$

Thus

$$
\begin{equation*}
(\tau, \nu) \prec(\tilde{\tau}, \tilde{\nu}) . \tag{4.34}
\end{equation*}
$$

If $\left(\tau_{1}, \nu_{1}\right):=\left(\tau_{-}, \nu_{-}\right)$and $\left(\tau_{2}, \nu_{2}\right):=\left(\tau_{+}, \nu_{+}\right)$then $\tau, \nu$ satisfy (4.1) and by Theorem 4.1(c),

$$
\begin{equation*}
(\tilde{\tau}, \tilde{\nu}) \prec\left(\tau_{+}, \nu_{+}\right)^{\#} . \tag{4.35}
\end{equation*}
$$

Hence, by (4.34), we obtain (1.15).
Conversely, assume that $(\tau, \nu)$ satisfies (1.15). Recall that every couple of negative measures is good relative to $f$. Therefore, by Proposition 4.2, the relation

$$
-\left(\tau_{-}, \nu_{-}\right) \prec(\tau, \nu) \prec\left(\tau_{+}, \nu_{+}\right)^{\#}
$$

implies that $(\tau, \nu)$ is a good couple.
The last assertion of the theorem is obvious.

## Appendix A.

We prove an auxilliary result that is used in the proof of Proposition 4.3

Proposition A.1. Assume (A1), (A21), (C1) and (4.29) hold. Suppose that $(\tau, \nu) \in \mathfrak{M}_{+}\left(\Omega ; \Phi_{V}\right) \times \mathfrak{M}_{+}(\partial \Omega)$ is a good couple of measures. Let $u$ be the corresponding solution of problem (3.6) and $u_{n}$ be the solution of (3.1). Then

$$
u_{n} \rightarrow u \quad \text { in } L^{1}\left(\Omega ; \Phi_{V} / \delta\right), \quad f_{n}\left(u_{n}\right) \rightarrow f(u) \quad \text { in } L^{1}\left(\Omega ; \Phi_{V}\right)
$$

The proof is based on the following lemma that was established in [20] for a more restricted class of potentials.

Lemma A.2. Assume (A1), (A2), (C1) and (4.29) hold. Let $\tau \in$ $\mathfrak{M}\left(\Omega ; \Phi_{V}\right)$ and let $\lambda_{V}$ be the eigenvalue of $-L_{V}$ corresponding to $\Phi_{V}$. Then

$$
\begin{equation*}
\lambda_{V} \int_{\Omega} \mathbb{G}_{V}[\tau] \Phi_{V} d x=-\int_{\Omega} \mathbb{G}_{V}[\tau] L_{V} \Phi_{V} d x=\int_{\Omega} \Phi_{V} d \tau \tag{a.1}
\end{equation*}
$$

Proof. By linearity, we may assume that $\tau \geq 0$. For $\beta>0$, put

$$
I_{\beta}(\tau):=-\lambda_{V} \int_{D_{\beta}} \mathbb{G}_{V}[\tau] \Phi_{V} d x+\int_{D_{\beta}} \Phi_{V} d \tau
$$

where $D_{\beta}=\{x \in \Omega: \delta(x)>\beta\}$. To prove (a.1) we show that

$$
\begin{equation*}
\lim _{\beta \rightarrow 0} I_{\beta}(\tau)=0 \tag{a.2}
\end{equation*}
$$

By Theorem 2.2 (ii),

$$
I_{0}(\tau) \leq C \int_{\Omega} \Phi_{V} d \tau
$$

Given $\epsilon>0$ we choose $0<\gamma$ sufficiently small so that, for $\tau_{\gamma}:=\tau \mathbf{1}_{\Omega_{\gamma}}$,

$$
\begin{equation*}
I_{0}\left(\tau_{\gamma}\right)<\epsilon \tag{a.3}
\end{equation*}
$$

Therefore it is sufficient to prove

$$
\lim _{\beta \rightarrow 0} I_{\beta}\left(\tau-\tau_{\gamma}\right)=0
$$

Thus it is sufficient to prove (a.2) when $\tau$ has compact support in $\Omega$.
Let $\beta_{\tau}=\frac{1}{2} \operatorname{dist}(\operatorname{supp} \tau, \partial \Omega)$ and let $\beta \in\left(0, \beta_{\tau}\right)$. Applying Green's theorem in $D_{\beta}$, we obtain

$$
\begin{aligned}
& \lambda_{V} \int_{D_{\beta}} \mathbb{G}_{V}[\tau] \Phi_{V} d x=-\int_{D_{\beta}} \mathbb{G}_{V}[\tau] L_{V} \Phi_{V} d x \\
& =\int_{D_{\beta}} \Phi_{V} d \tau+\int_{\Sigma_{\beta}} \frac{\partial \mathbb{G}_{V}[\tau]}{\partial \mathbf{n}} \Phi_{V} d S(x)-\int_{\Sigma_{\beta}} \frac{\partial \Phi_{V}}{\partial \mathbf{n}} \mathbb{G}_{V}[\tau] d S(x) .
\end{aligned}
$$

Thus

$$
\begin{equation*}
I(\beta)=-\int_{\Sigma_{\beta}} \frac{\partial \mathbb{G}_{V}[\tau]}{\partial \mathbf{n}} \Phi_{V} d S(x)+\int_{\Sigma_{\beta}} \frac{\partial \Phi_{V}}{\partial \mathbf{n}} \mathbb{G}_{V}[\tau] d S(x) \tag{a.4}
\end{equation*}
$$

Note that

$$
G_{V}(x, y) \sim \Phi_{V}(x) \quad \forall(x, y) \in \Omega_{\beta_{\tau}} \times \operatorname{supp} \tau
$$

Therefore

$$
\begin{equation*}
\mathbb{G}_{V}[\tau](x)=\int_{\Omega} G_{V}(x, y) d \tau(y) \sim \Phi_{V}(x), \quad \forall x \in \Sigma_{\beta} \tag{a.5}
\end{equation*}
$$

By interior elliptic estimates, for every $x \in \Sigma_{\beta}$,

$$
\left|\frac{\partial \Phi_{V}}{\partial \mathbf{n}}(x)\right| \leq C \sup _{|\xi-x|<\beta / 4} \Phi_{V}(\xi) \beta^{-1}
$$

Therefore by Harnack's inequality, we deduce

$$
\left|\frac{\partial \Phi_{V}}{\partial \mathbf{n}}(x)\right| \leq C \Phi_{V}(x) \beta^{-1} \quad \forall x \in \Sigma_{\beta} .
$$

Hence, by (a.5) and assumption (4.29),

$$
\lim _{\beta \rightarrow 0} \int_{\Sigma_{\beta}} \frac{\partial \Phi_{V}}{\partial \mathbf{n}} \mathbb{G}_{V}[\tau] d S(x)=0
$$

In $D_{\beta_{\tau}}: G_{V}[\tau]$ is $L_{V}$ harmonic and $G_{V}[\tau] \sim \Phi_{V}$. Therefore the same argument as above yields,

$$
\begin{equation*}
\lim _{\beta \rightarrow 0} \int_{\Sigma_{\beta}} \frac{\partial \mathbb{G}_{V}[\tau]}{\partial \mathbf{n}} \Phi_{V} d S(x)=0 . \tag{a.6}
\end{equation*}
$$

Combining (a.4) - (a.6), we obtain (a.2) for measures $\tau$ with compact support. In view of previous remarks, this implies (a.2) for any measure $\tau \in \mathfrak{M}\left(\Omega ; \Phi_{V}\right)$. This in turn implies (a.1).

Proof of Proposition A.1. By Theorem 3.1(d), $u=u^{\#}$. From the proof of Theorem 3.1, $u_{n} \geq 0$ satisfies (3.7), $u_{n} \downarrow u^{\#}=u$ and $f_{n}\left(u_{n}\right) \rightarrow f(u)$ a.e. in $\Omega$. By (3.7), $u_{n} \leq \mathbb{G}_{V}[\tau]+\mathbb{K}_{V}[\nu] \in L^{1}\left(\Omega ; \Phi_{V} / \delta\right)$. Therefore, by the dominated convergence theorem,

$$
u_{n} \rightarrow u \quad \text { in } L^{1}\left(\Omega ; \Phi_{V} / \delta\right) .
$$

By Lemma A. 2 with $\tau$ replaced by $f_{n}\left(u_{n}\right)$ (recall that $f_{n}$ is a bounded function) we have,

$$
\begin{equation*}
\int_{\Omega} f_{n}\left(u_{n}\right) \Phi_{V} d x=\lambda_{V} \int_{\Omega} \mathbb{G}_{V}\left[f_{n}\left(u_{n}\right)\right] \Phi_{V} d x \tag{a.7}
\end{equation*}
$$

Since $u_{n}$ is the solution of (3.1) it satisfies

$$
u_{n}+\mathbb{G}_{V}\left[f_{n}\left(u_{n}\right)\right]=\mathbb{G}_{V}[\tau]+\mathbb{K}_{V}[\nu] .
$$

Multiplying this equality by $\lambda_{V} \Phi_{V}$ and using (a.7) we obtain

$$
\begin{gathered}
\int_{\Omega} f_{n}\left(u_{n}\right) \Phi_{V} d x=\lambda_{V} \int_{\Omega} \mathbb{G}_{V}\left[f_{n}\left(u_{n}\right)\right] \Phi_{V} d x \\
=-\lambda_{V} \int_{\Omega} u_{n} \Phi_{V} d x+\lambda_{V} \int_{\Omega} \mathbb{G}_{V}[\tau] \Phi_{V} d x+\lambda_{V} \int_{\Omega} \mathbb{K}_{V}[\nu] \Phi_{V} d x .
\end{gathered}
$$

Hence,

$$
\begin{align*}
& \lim _{n \rightarrow \infty} \int_{\Omega} f_{n}\left(u_{n}\right) \Phi_{V} d x=  \tag{a.8}\\
& -\lambda_{V} \int_{\Omega} u \Phi_{V} d x+\lambda_{V} \int_{\Omega} \mathbb{G}_{V}[\tau] \Phi_{V} d x+\lambda_{V} \int_{\Omega} \mathbb{K}_{V}[\nu] \Phi_{V} d x
\end{align*}
$$

Since $u$ is the solution of (3.6), $f(u) \in L^{1}\left(\Omega ; \Phi_{V}\right)$ and $u+\mathbb{G}_{V}[f(u)]=$ $\mathbb{G}_{V}[\tau]+\mathbb{K}_{V}[\nu]$. In addition, by Lemma A.2,

$$
\int_{\Omega} f(u) \Phi_{V} d x=\lambda_{V} \int_{\Omega} \mathbb{G}_{V}[f(u)] \Phi_{V} d x
$$

Therefore, as before,

$$
\begin{align*}
& \int_{\Omega} f(u) \Phi_{V} d x \\
& =-\lambda_{V} \int_{\Omega} u \Phi_{V} d x+\lambda_{V} \int_{\Omega} \mathbb{G}_{V}[\tau] \Phi_{V} d x+\lambda_{V} \int_{\Omega} \mathbb{K}_{V}[\nu] \Phi_{V} d x \tag{a.9}
\end{align*}
$$

By (a.8) and (a.9), $\left\|f_{n}\left(u_{n}\right)\right\|_{L^{1}\left(\Omega ; \Phi_{V}\right)} \rightarrow\|f(u)\|_{L^{1}\left(\Omega ; \Phi_{V}\right)}$. As $f_{n}\left(u_{n}\right) \rightarrow$ $f(u)$ a.e. in $\Omega$, it follows that

$$
f_{n}\left(u_{n}\right) \rightarrow f(u) \quad \text { in } L^{1}\left(\Omega ; \Phi_{V}\right) .
$$

The proof is complete.
