# FLOWS ON METRIC GRAPHS WITH GENERAL BOUNDARY CONDITIONS

ABSTRACT. In this note we study the generation of  $C_0$ -semigroups by first order differential operators on  $L^p(\mathbb{R}_+, \mathbb{C}^\ell) \times L^p([0, 1], \mathbb{C}^m)$  with general boundary conditions. In many cases we are able to characterize the generation property in terms of the invertibility of a matrix associated to the boundary conditions. The abstract results are used to study well-posedness of transport equations on non-compact metric graphs.

#### 1. INTRODUCTION

This is a companion paper of [18] where we studied linear wave and diffusion equations on metric graphs subject to general boundary conditions. The aim of the present work is to apply the same approach used there to examine first order equations modeling flows on metric graphs. This leads to the abstract Cauchy problem

(1.1) 
$$\begin{cases} \dot{x}(t) = Gx(t), & t \ge 0, \\ x(0) = x_0, \end{cases}$$

for a first-order differential operator  $G: D(G) \subset X \to X$  on the Banach space

 $X = \mathcal{L}^p(\mathbb{R}_+, \mathbb{C}^\ell) \times \mathcal{L}^p([0,1], \mathbb{C}^m).$ 

Here,  $\mathbb{R}_+$  and the interval [0,1] represent the unbounded, respectively normalized bounded edges of the graph while its structure is encoded in the boundary conditions appearing in the definition of the domain D(G).

In the simplest case, all edges are bounded, hence we have  $\ell = 0$ , i.e.,  $X = L^p([0,1], \mathbb{C}^m)$  and

(1.2) 
$$G = c(\bullet) \cdot \frac{d}{ds},$$
$$D(G) = \left\{ f \in \mathbf{W}^{1,p} ([0,1], \mathbb{C}^m) : V_0 f(0) = V_1 f(1) \right\},$$

where  $c(s) = \text{diag}(\lambda_1(s), \ldots, \lambda_m(s))$  for non-vanishing, Lipschitz continuous functions  $\lambda_k(\bullet)$ ,  $k = 1, \ldots, m$ , and suitable scalar "boundary" matrices  $V_0, V_1 \in M_m(\mathbb{C})$ .

It is well known, for the details we refer to [19, Sect. II.6], that the problem (1.1) is well-posed if and only if G generates a strongly continuous semigroup on X.

Our results now give sufficient conditions, which in many important cases are also necessary, in terms of the invertibility of a linear map, for a first-order differential operator G with general boundary conditions to be a generator, hence for the well-posedness of the associated problem (1.1). For example, by Corollary 2.19 the operator G in (1.2) is a generator if and only if

(1.3) 
$$\det(V_1P_+ + V_0P_-) \neq 0,$$

where  $P_{\pm}$  denote the spectral projections associated to the positive/negative eigenvalues of  $c(\bullet)$ . In particular, condition (1.3) characterizes the well-posedness of the Cauchy problem (1.1) for G given by (1.2).

The semigroup approach to linear transport equations (or flows) on networks was initiated in [28] and further pursued by many authors, see e.g. [30, 16, 9, 31, 6, 8, 5, 7]. In all these works finite compact graphs (i.e., with finitely many edges that are all compact intervals) are considered,  $c(\cdot)$  are constant and diagonal matrices, and the boundary conditions rely on the structure of the graph, representing conservation of the mass, so-called Kirchhoff conditions. In [13, 14, 15] the same approach was applied to study flows on infinite but compact graphs. The setting has been generalized in [27, 17] to so-called difference operators, that are operators of the form (1.2) where  $c(\cdot)$  was considered to be a constant, not necessarily diagonal, selfadjoint matrix. We note that our problem can also be formulated as a first order boundary system or a so-called port-Hamiltonian system. In this framework generation results are shown in Hilbert space setting by a suitable basis transformation and then carried over to  $L^p$ -spaces, see for example [32, 24]. These methods were also applied in [23, 25] to first order equations on some classes of non-compact graphs.

In comparison to the above cited works our approach presents several novelties: it allows to

- consider operators on  $L^p(\mathbb{R}_+, \mathbb{C}^\ell) \times L^p([0,1], \mathbb{C}^m)$  with applications to *non*-compact graphs,
- treat very general (also non-diagonal) "velocity matrices"  $c(\bullet, \bullet)$ , cf. (2.1),
- treat very general (also non-local) boundary conditions, cf. (2.3),
- treat all cases of  $p \in [1, +\infty)$  simultaneously without using interpolation arguments,
- obtain necessary conditions for the generator property, hence the well-posedness, for important classes of boundary conditions.

Our reasoning is based on similarity transformations and a perturbation result for boundary perturbations of domains of generators from [1, Sect. 4.3].

This paper is organized as follows. In Section 2, after introducing our general setup in Subsection 2.1, we state and prove in Subsection 2.2 the main generation result, Theorem 2.4. In Subsection 2.3 we supplement this result in Theorem 2.12 by a necessary condition for G to be a generator. If the boundary operators defining the domain D(G) are, modulo bounded perturbations, given by point evaluations, this gives simple generation conditions which are presented in Subsection 2.4. In the compact case  $\ell = 0$  this reduces in Corollary 2.19 to a very simple necessary and sufficient determinant condition like (1.3). In Section 3 we then show how our results apply to transport processes on metric graphs. In particular, we reproduce and generalize many existing results which demonstrates the versatility of our approach. Finally, in the appendix we recall our approach to boundary perturbations from [1, 18] and present in Theorem A.6 a new necessary condition for a perturbed generator to be again a generator.

# 2. Generation of $C_0$ -Semigroups

In this section we introduce our general setup, present the generation results, give a necessary condition for generation and then give some reformulations of the boundary conditions.

2.1. The Setup. Let  $\mathbb{R}_+ := [0, +\infty)$ . Throughout this section we make the following

Assumption 2.1. Consider for some fixed  $p \ge 1$  and  $\ell, m \in \mathbb{N}_0$  satisfying  $\ell + m > 0$ 

- the space  $X^e := L^p(\mathbb{R}_+, \mathbb{C}^\ell)$  of functions on the  $\ell$  "external edges",
- the space  $X^i := L^p([0,1], \mathbb{C}^m)$  of functions on the *m* "internal edges",
- the "state space"  $X := X^e \times X^i$  of functions on all  $\ell + m$  edges,
- a "boundary space"  $\partial X \subseteq \mathbb{C}^{\ell+m}$  (which will be determined later, cf. (2.5)),
- a "boundary operator"  $\Phi = (\Phi^e, \Phi^i) \in \mathcal{L}(\mathcal{C}_0(\mathbb{R}_+, \mathbb{C}^\ell) \times \mathcal{C}([0, 1], \mathbb{C}^m), \partial X)$  (which determines the boundary conditions),

• a "velocity matrix"  $c(\bullet, \bullet) \in L^{\infty}(\mathbb{R}_+, M_{\ell}(\mathbb{C})) \times L^{\infty}([0, 1], M_m(\mathbb{C}))$  (containing the coefficients of the associated differential equation) of the form

(2.1) 
$$c(\bullet, \bullet) := \begin{pmatrix} q^{e}(\bullet) & 0 \\ 0 & q^{i}(\bullet) \end{pmatrix} \cdot \begin{pmatrix} \lambda^{e}(\bullet) & 0 \\ 0 & \lambda^{i}(\bullet) \end{pmatrix} \cdot \begin{pmatrix} q^{e}(\bullet) & 0 \\ 0 & q^{i}(\bullet) \end{pmatrix}^{-1}$$
$$=: q(\bullet, \bullet) \cdot \lambda(\bullet, \bullet) \cdot q(\bullet, \bullet)^{-1},$$

where the diagonal entries of  $\lambda(\bullet, \bullet)$  are matrix-valued functions given by

$$\lambda^{e}(r) = \operatorname{diag} \left( \lambda_{k}^{e}(r) \right)_{k=1}^{\ell} \in \mathcal{M}_{\ell}(\mathbb{R}), \quad r \in \mathbb{R}_{+}, \\ \lambda^{i}(s) = \operatorname{diag} \left( \lambda_{j}^{i}(s) \right)_{j=1}^{m} \in \mathcal{M}_{m}(\mathbb{R}), \quad s \in [0, 1]$$

and have strictly constant sign, i.e., there exists  $\varepsilon > 0$  such that

(2.2) 
$$\varepsilon \leq \lambda_k^e(0) \cdot \lambda_k^e(r) \quad \text{for all } k = 1, \dots, \ell, \ r \in \mathbb{R}_+,$$
$$\varepsilon \leq \lambda_j^i(0) \cdot \lambda_j^i(s) \quad \text{for all } j = 1, \dots, m, \ s \in [0, 1]$$

and the matrix-valued function  $q(\bullet, \bullet)$  is Lipschitz continuous and satisfies

$$q(\bullet, \bullet), q(\bullet, \bullet)^{-1} \in \mathcal{L}^{\infty}(\mathbb{R}_+, \mathcal{M}_{\ell}(\mathbb{C})) \times \mathcal{L}^{\infty}([0, 1], \mathcal{M}_m(\mathbb{C}))$$

Note that these hypotheses imply that the mapping  $\lambda(\bullet, \bullet)$  is invertible and  $\lambda(\bullet, \bullet), \lambda(\bullet, \bullet)^{-1}$  are both uniformly bounded.

Remark 2.2. We mention that in general even a smooth positive definite valued  $c(\bullet, \bullet)$  cannot be represented as in (2.1), cf. [18, Rem. 2.9.(vi)]. However, if  $c(\bullet, \bullet)$  is analytic or if c(r, s) has  $m + \ell$  distinct eigenvalues for all  $r \in \mathbb{R}_+$ ,  $s \in [0, 1]$  then it can always be written as in (2.1), see [26, Chapt. 2]. For the relevant assumptions in the Hilbert space setting we refer to [29, Lem. A.1].

In the sequel we equip all subspaces of  $\mathbb{C}^k$  with the maximum norm  $\|\cdot\|_{\infty}$ , i.e., we define

$$\|(x_1,\ldots,x_k)^{\top}\|_{\mathbb{C}^k} := \max\{|x_1|,\ldots,|x_k|\}.$$

Then, using that  $W^{1,p}(\mathbb{R}_+, \mathbb{C}^{\ell}) \subset C_0(\mathbb{R}_+, \mathbb{C}^{\ell})$  and  $W^{1,p}([0,1], \mathbb{C}^m) \subset C([0,1], \mathbb{C}^m)$  (see [11, Sect.8.2]), we define on  $X = L^p(\mathbb{R}_+, \mathbb{C}^{\ell}) \times L^p([0,1], \mathbb{C}^m)$  the operator

(2.3) 
$$G := c(\bullet, \bullet) \cdot \frac{a}{ds},$$
$$D(G) := \left\{ f \in \mathrm{W}^{1,p}(\mathbb{R}_+, \mathbb{C}^\ell) \times \mathrm{W}^{1,p}([0,1], \mathbb{C}^m) : \Phi f = 0 \right\} = \ker(\Phi).$$

Our aim is to give conditions on the boundary operator  $\Phi$  implying that G generates a  $C_0$ -semigroup on X. As we will see in our main result, Theorem 2.4, this can be achieved through the invertibility of the operator  $\mathcal{R}_{t_0}$  defined in (2.10).

In order to choose in Assumption 2.1 a reasonable boundary space  $\partial X$  note that for  $\pm \frac{d}{ds}$  to be a generator on  $L^p(\mathbb{R}_+)$  we need to impose no boundary condition in case of "+" while for the sign "-" a boundary condition in r = 0 is needed. On the other hand, for  $\pm \frac{d}{ds}$  to be a generator on  $L^p[0, 1]$  in both cases exactly one boundary condition is needed, in case of "+" in s = 1, and for the sign "-" in s = 0. Denote the (constant and diagonal) spectral projections corresponding to the positive/negative eigenvalues of  $\lambda^e(r) \in M_\ell(\mathbb{R})$  and  $\lambda^i(s) \in M_m(\mathbb{R})$ ,  $r \in \mathbb{R}_+, s \in [0, 1]$ , by

(2.4) 
$$P^e_+, P^e_- \in \mathcal{M}_\ell(\mathbb{C}), \quad P^i_+, P^i_- \in \mathcal{M}_m(\mathbb{C}),$$

respectively. Then, by the previous considerations, for  $G = c(\bullet, \bullet) \cdot \frac{d}{ds}$  in (2.3) to be a generator it is reasonable to impose rank $(P^e_{-}) + m$  boundary conditions. This motivates the choice of

(2.5) 
$$\partial X := \partial X^e \times \partial X^i := \operatorname{rg}(P^e_{-}) \times \mathbb{C}^m \subseteq \mathbb{C}^{\ell+m}$$

as boundary space.

In order to state our main result rigorously we need some more notation. For  $1 \leq k \leq \ell$  we define

(2.6) 
$$\phi_k(r) := \int_0^r \frac{ds}{|\lambda_k^e(s)|}, \ r \in \mathbb{R}_+.$$

It follows from (2.2) that all functions  $\phi_k : \mathbb{R}_+ \to \mathbb{R}_+$  are Lipschitz continuous, surjective, and strictly increasing, hence invertible with Lipschitz continuous inverses  $\phi_k^{-1} : \mathbb{R}_+ \to \mathbb{R}_+$ . Next, for  $1 \leq j \leq m$  we similarly define

(2.7) 
$$\varphi_j(s) := \int_0^s \frac{dr}{\lambda_j^i(r)}, \quad \bar{c}_j := \frac{1}{\varphi_j(1)}, \quad \bar{\varphi}_j(s) := \bar{c}_j \cdot \varphi_j(s), \ s \in [0,1].$$

Also, all functions  $\bar{\varphi}_j : [0,1] \to [0,1]$  are Lipschitz continuous, surjective, and strictly monotone, hence invertible with Lipschitz continuous inverses  $\bar{\varphi}_i^{-1} : [0,1] \to [0,1]$ . Now, we put

$$\begin{split} \phi &:= (\phi_1, \dots, \phi_\ell)^\top : \mathbb{R}_+ \to \mathbb{R}_+^\ell, \qquad \phi^{-1} := (\phi_1^{-1}, \dots, \phi_\ell^{-1})^\top : \mathbb{R}_+ \to \mathbb{R}_+^\ell, \\ \bar{\varphi} &:= (\bar{\varphi}_1, \dots, \bar{\varphi}_m)^\top : [0, 1] \to [0, 1]^m, \qquad \bar{\varphi}^{-1} := (\bar{\varphi}_1^{-1}, \dots, \bar{\varphi}_m^{-1})^\top : [0, 1] \to [0, 1]^m, \\ \bar{c} &:= (\bar{c}_1, \dots, \bar{c}_m) \in \mathbb{R}^m, \qquad |\bar{c}| := (|\bar{c}_1|, \dots, |\bar{c}_m|) \in \mathbb{R}_+^m. \end{split}$$

Finally, for functions  $h = (h_1, \ldots, h_n)^\top : I \subseteq \mathbb{R} \to \mathbb{C}^n, \ \nu = (\nu_1, \ldots, \nu_n) : I \to I^n$ , a vector  $x = (x_1, \ldots, x_n)^\top \in \mathbb{R}^n$  and scalars  $r, s \in \mathbb{R}$  we set

$$(h \circ \nu)(r) := (h_1(\nu_1(r)), \dots, h_n(\nu_n(r)))^\top, h(r+x) := (h_1(r+x_1), \dots, h_n(r+x_n))^\top, h(r+\frac{s}{x}) := (h_1(r+\frac{s}{x_1}), \dots, h_n(r+\frac{s}{x_n}))^\top$$

Using this notation we define the transformations

(2.8) 
$$J_{\phi} \in \mathcal{L}(X^{e}), \qquad J_{\phi}f^{e} := f^{e} \circ \phi \qquad \text{for } f^{e} \in X^{e}, \\ J_{\bar{\varphi}} \in \mathcal{L}(X^{i}), \qquad J_{\bar{\varphi}}f^{i} := f^{i} \circ \bar{\varphi} \qquad \text{for } f^{i} \in X^{i}.$$

Then  $J_{\phi}$  and  $J_{\bar{\varphi}}$  are invertible with inverses  $J_{\phi}^{-1} = J_{\phi^{-1}} \in \mathcal{L}(X^e)$  and  $J_{\bar{\varphi}}^{-1} = J_{\bar{\varphi}^{-1}} \in \mathcal{L}(X^i)$ . Using these facts we define for fixed  $t_0 > 0$  and  $t \in [0, t_0]$  the bounded linear operators  $Q_t \in \mathcal{L}(L^p([0, t_0], \partial X^e), X^e)$  and  $R_t, S_t \in \mathcal{L}(L^p([0, t_0], \partial X^i), X^i)$  by

(2.9) 
$$Q_t u^e := \hat{u}^e(t - \bullet), \quad R_t u^i := \hat{u}^i \left( t - \frac{\bullet}{|\overline{c}|} \right), \quad S_t u^i := \hat{u}^i \left( t - \frac{1 - \bullet}{|\overline{c}|} \right),$$

where  $\hat{u}$  denotes the extension of a function u defined on  $I \subset \mathbb{R}$  to  $\mathbb{R}$  by the value 0. In order to state the main result we need to define an operator  $\mathcal{R}_{t_0}$  as follows where

$$\Phi := (\Phi^e, \Phi^i) := (\Phi^e \cdot q^e(\bullet) \cdot J_{\phi}, \Phi^i \cdot q^i(\bullet) \cdot J_{\bar{\varphi}})$$
  
$$\in \mathcal{L}(\mathcal{C}_0(\mathbb{R}_+, \mathbb{C}^\ell) \times \mathcal{C}([0, 1], \mathbb{C}^m), \partial X).$$

**Lemma 2.3.** Let  $0 < t_0 \leq \frac{1}{\|\bar{c}\|_{\infty}}$ . Then the operator  $\Re_{t_0} : W_0^{1,p}([0,t_0],\partial X) \subset L^p([0,t_0],\partial X) \rightarrow L^p([0,t_0],\partial X)$  given by

(2.10) 
$$\begin{pmatrix} \left(\mathcal{R}_{t_0} \begin{pmatrix} u^e \\ u^i \end{pmatrix}\right)(t) := \left(\bar{\Phi}^e, \bar{\Phi}^i\right) \cdot \begin{pmatrix} Q_t & 0 \\ 0 & P^i_+ S_t - P^i_- R_t \end{pmatrix} \begin{pmatrix} u^e \\ u^i \end{pmatrix} \\ = \left(\bar{\Phi}^e \cdot Q_t u^e, \bar{\Phi}^i \left(P^i_+ \cdot S_t - P^i_- \cdot R_t\right) u^i\right)$$

for  $t \in [0, t_0]$  and  $(u^e, u^i)^\top \in W_0^{1, p}([0, t_0], \partial X^e) \times W_0^{1, p}([0, t_0], \partial X^i)$  is well-defined and has a unique bounded extension denoted again by  $\mathcal{R}_{t_0} \in \mathcal{L}(L^p([0, t_0], \partial X))$ .

*Proof.* Define  $\psi(s) := 1 - s$  for  $s \in [0, 1]$ . Then  $S_t = \psi \cdot R_t$ , hence

(2.11) 
$$P_{+}^{i} \cdot S_{t} - P_{-}^{i} \cdot R_{t} = (P_{+}^{i} \cdot \psi - P_{-}^{i}) \cdot R_{t}$$

Observe, that  $\bar{\Phi}^e \in \mathcal{L}(C_0(\mathbb{R}_+, \mathbb{C}^\ell), \partial X)$  and  $\bar{\Phi}^i(P^i_+ \cdot \psi - P^i_-) \in \mathcal{L}(C([0, 1], \mathbb{C}^m), \partial X)$  are well-defined. Hence, it suffices to show that the operator

(2.12) 
$$U_{t_0}^{\Psi} : W_0^{1,p} ([0,t_0], \mathbb{C}^k) \subset L^p ([0,t_0], \mathbb{C}^k) \to L^p ([0,t_0], \partial X), \\ (U_{t_0}^{\Psi} u)(t) := \Psi \hat{u} (t - \vartheta(\bullet)), \ t \in [0,t_0]$$

is well-defined and has a bounded extension in  $\mathcal{L}(L^p([0,t_0],\mathbb{C}^k),L^p([0,t_0],\partial X))$  where for the

- external part  $k = \ell, \Psi \in \mathcal{L}(\mathcal{C}_0(I, \mathbb{C}^k), \partial X)$  and  $\vartheta(s) := s, s \in I := \mathbb{R}_+,$
- internal part k = m,  $\Psi \in \mathcal{L}(\mathbf{C}(I, \mathbb{C}^k), \partial X)$  and  $\vartheta(s) := \frac{s}{|\overline{c}|}, s \in I := [0, 1].$

Let

(2.13) 
$$I_{t_0} := \begin{cases} [0, t_0], & \text{in the external case,} \\ [0, \|\bar{c}\|_{\infty} \cdot t_0], & \text{in the internal case.} \end{cases}$$

Then, by repeating the same arguments as in the proof of [18, Lem. 2.2], it follows that  $U_{t_0}^{\Psi}$  is indeed well-defined, bounded, and satisfies for  $u \in W_0^{1,p}([0, t_0], \mathbb{C}^k)$  the estimate

(2.14) 
$$\|U_{t_0}^{\Psi}u\|_p^p \le \left(|\eta|(I_{t_0})\right)^p \cdot \|u\|_p^p$$

Here,  $|\eta| : I \to \mathbb{R}_+$  denotes the positive Borel measure defined by the total variation of  $\eta$ and  $\eta : I \to \mathcal{L}(\mathbb{C}^k, \partial X)$  is the function of bounded variation such that  $\Psi$  is given by the Riemann–Stieltjes integral

(2.15) 
$$\Psi h = \int_{I} d\eta(s) h(s) \quad \text{for all} \quad h \in \mathbf{W}^{1,p}(I, \mathbb{C}^{k}).$$

2.2. The Main Generation Results. We are now ready to state our main result on the generation of a  $C_0$ -semigroup by operators given by (2.3).

**Theorem 2.4.** Let Assumption 2.1 be satisfied. If there exists  $t_0 > 0$  such that the operator  $\mathcal{R}_{t_0} \in \mathcal{L}(L^p([0, t_0], \partial X))$  given by (2.10) is invertible, then the operator G defined in (2.3) generates a  $C_0$ -semigroup on  $X = L^p(\mathbb{R}_+, \mathbb{C}^\ell) \times L^p([0, 1], \mathbb{C}^m)$ .

Remark 2.5. It is slightly inconvenient that  $\mathfrak{R}_{t_0}$  is defined on functions assuming values in the subspace  $\partial X = \operatorname{rg}(P^e_{-}) \times \mathbb{C}^m$  of the (simpler) space  $\mathbb{C}^{\ell} \times \mathbb{C}^m$ . However, one can easily extend  $\mathfrak{R}_{t_0}$  to an operator  $\tilde{\mathfrak{R}}_{t_0} \in \mathcal{L}(\mathrm{L}^p([0, t_0], \mathbb{C}^{\ell} \times \mathbb{C}^m))$  without changing its invertibility. In fact, if we put

$$\tilde{\mathfrak{R}}_{t_0} := \begin{pmatrix} P^e_+ \ 0\\ 0 \ 0 \end{pmatrix} + \mathfrak{R}_{t_0} \cdot \begin{pmatrix} P^e_- \ 0\\ 0 \ Id_m \end{pmatrix} \in \mathcal{L} \big( \mathrm{L}^p \big( [0, t_0], \mathbb{C}^\ell \times \mathbb{C}^m \big) \big),$$

then  $\mathcal{R}_{t_0}$  is invertible if and only if  $\tilde{\mathcal{R}}_{t_0}$  is invertible.

The proof of Theorem 2.4 is split into several steps. First, under the hypothesis  $c(\bullet, \bullet)$  to be diagonal, that is  $q(\bullet, \bullet) \equiv \text{diag}(Id, Id)$ , we normalize the operator G to obtain a simpler but similar operator  $\overline{G}$  with constant velocities. The case of general  $q(\bullet, \bullet)$  as in (2.1) then follows by similarity and bounded perturbation.

Recall that  $J_{\phi} \in \mathcal{L}(X^e)$ ,  $J_{\overline{\varphi}} \in \mathcal{L}(X^i)$  are given by (2.8). Moreover, let

(2.16) 
$$\bar{C} := \operatorname{diag}(\bar{c}_1, \dots, \bar{c}_m) \in \operatorname{M}_m(\mathbb{R})$$

where the  $\bar{c}_i$  are defined in (2.7).

**Lemma 2.6.** Let  $q(\bullet, \bullet) = \text{diag}(Id, Id)$ . Then the operator G given in (2.3) on  $X = X^e \times X^i$  is similar to  $\overline{G} : D(\overline{G}) \subset X \to X$  where

(2.17) 
$$\bar{G} := \operatorname{diag}\left(\left(P_{+}^{e} - P_{-}^{e}\right) \cdot \frac{d}{ds}, \bar{C} \cdot \frac{d}{ds}\right), \quad D(\bar{G}) := \operatorname{ker}(\bar{\Phi})$$

and  $\bar{\Phi} := (\Phi^e \cdot J_\phi, \Phi^i \cdot J_{\bar{\varphi}}) \in \mathcal{L}(\mathcal{C}_0(\mathbb{R}_+, \mathbb{C}^\ell) \times \mathcal{C}([0, 1], \mathbb{C}^m), \partial X).$ 

*Proof.* Consider the invertible transformation

 $S := \operatorname{diag}(J_{\phi}, J_{\bar{\phi}}) \in \mathcal{L}(X) \quad \text{with inverse} \quad S^{-1} := \operatorname{diag}(J_{\phi}^{-1}, J_{\bar{\phi}}^{-1}) \in \mathcal{L}(X).$ 

We claim that

$$\bar{G} = S^{-1} \cdot G \cdot S$$

Let  $\tilde{G} := S^{-1}GS$ . Then, by definition,

$$f \in D(\tilde{G}) \iff Sf \in D(G) = \ker(\Phi) \iff f \in \ker(\bar{\Phi}),$$

i.e.,  $D(\tilde{G}) = D(\bar{G})$ . Next,  $(\phi^{-1})' = |\lambda^e(\bullet)| \circ \phi^{-1}$  implies that

 $J_{\phi} \cdot (P^e_+ - P^e_-) \cdot \frac{d}{ds} \cdot J_{\phi}^{-1} = \lambda^e(\bullet) \cdot \frac{d}{ds}.$ 

Similarly, since  $(\bar{C} \cdot \bar{\varphi}^{-1})' = \lambda^i(\bullet) \circ \bar{\varphi}^{-1}$  we obtain

$$J_{\bar{\varphi}} \cdot \bar{C} \cdot \frac{d}{ds} \cdot J_{\bar{\varphi}}^{-1} = \lambda^{i}(\bullet) \cdot \frac{d}{ds}.$$

This implies that  $\tilde{G}f = \bar{G}f$  for  $f \in D(\tilde{G}) = D(\bar{G})$  which completes the proof of (2.18).  $\Box$ 

Next we consider  $\overline{G}$  as a domain perturbation of a simpler generator A. This perturbation problem is treated using a recent result stated in Theorem A.2. To this end we first prove a series of lemmas. It is convenient to consider the external and internal part separately.

External Part. We introduce on  $X^e = L^p(\mathbb{R}_+, \mathbb{C}^\ell)$  the operators

$$D_m^e := \frac{d}{ds}, \qquad D(D_m^e) := W^{1,p}(\mathbb{R}_+, \mathbb{C}^\ell), \\ D_0^e := \frac{d}{ds}, \qquad D(D_0^e) := \{f \in D(D_m^e) : f(0) = 0\}$$

and

(2.19) 
$$A_m^e := D_m^e P_+^e - D_m^e P_-^e, \qquad D(A_m^e) := D(D_m^e),$$
  
(2.20) 
$$A^e := D_m^e P_+^e - D_0^e P_-^e, \qquad D(A^e) := \left\{ f \in D(D_m^e) : P_-^e f(0) = 0 \right\}.$$

Note that  $D_m^e$  and  $-D_0^e$  generate the strongly continuous left- and right-shift semigroups  $(T_l^e(t))_{t>0}$  and  $(T_r^e(t))_{t>0}$  on  $X^e$ , respectively, given by

(2.21) 
$$(T_l^e(t)f)(\bullet) := f(\bullet + t), \qquad (T_r^e(t)f)(\bullet) := \hat{f}(\bullet - t),$$

where as usual  $\hat{f}$  denotes the extension of f to  $\mathbb{R}$  by the value zero. Then the following simple result holds.

**Lemma 2.7.** The operator  $A^e$  generates a  $C_0$ -semigroup  $(T^e(t))_{t\geq 0}$  on  $X^e$  given by

(2.22) 
$$T^{e}(t) = T^{e}_{l}(t)P^{e}_{+} + T^{e}_{r}(t)P^{e}_{-}, \quad t \ge 0$$

Now, in the context of Appendix A, we have  $A^e \subset A^e_m$  with domain  $D(A^e) = \ker(L^e)$  for

$$L^e := P^e_{-}\delta_0 : D(A^e_m) \to \partial X^e,$$

where  $\delta_0$  denotes the point evaluation in s = 0 and  $\partial X^e = \operatorname{rg}(P_-^e)$ . The next result follows easily by inspection from the definition of  $Q_t$  in (2.9).

**Lemma 2.8.** For  $t_0 > 0$  and given  $u \in W_0^{2,p}([0,t_0], \partial X^e)$  the function  $x : [0,t_0] \to X^e$ ,

 $x(t, \bullet) := Q_t u$ 

is a classical solution of the boundary control system

(BCS<sup>e</sup>) 
$$\begin{cases} \dot{x}(t) = A_m^e x(t), & 0 \le t \le t_0, \\ L^e x(t) = u(t), & 0 \le t \le t_0, \\ x(0) = 0. \end{cases}$$

Internal Part. We introduce on  $X^i = L^p([0,1], \mathbb{C}^m)$  the operators

(2.23) 
$$A_{m}^{i} := \bar{C} \cdot \frac{d}{ds}, \qquad D(A_{m}^{i}) := W^{1,p}([0,1], \mathbb{C}^{m}),$$
  
(2.24) 
$$A^{i} := \bar{C} \cdot \frac{d}{ds}, \qquad D(A^{i}) := \{f \in D(A_{m}^{i}) : f(0) = f(1)\}$$

Now the following is well-known.

**Lemma 2.9.** The operator  $A^i$  generates the rotation  $C_0$ -group  $(T^i(t))_{t \in \mathbb{R}}$  on  $X^i$  given by (2.25)  $(T^i(t)f)(\bullet) = \tilde{f}(\bullet + \bar{c} \cdot t),$ 

where  $\tilde{f}$  denotes the 1-periodic extension to  $\mathbb{R}$  of f defined on [0,1].

As before we observe that in the context of Appendix A we have  $A^i \subset A^i_m$  with domain

$$D(A^{i}) = \left\{ f \in D(A_{m}^{i}) : L^{i}f = 0 \right\} = \ker(L^{i}),$$

for

(2.26) 
$$L^{i} := \delta_{1} - \delta_{0} : D(A_{m}^{i}) \to \partial X^{i},$$

where  $\delta_s$  denotes the point evaluation in  $s \in \{0, 1\}$  and  $\partial X^i = \mathbb{C}^m$ .

**Lemma 2.10.** Let  $0 < t_0 \leq \frac{1}{\|\bar{c}\|_{\infty}}$ . Then for every given  $v \in W_0^{2,p}([0,t_0],\partial X^e)$  the function  $x: [0,t_0] \to X^i$  defined by

$$x(t, \bullet) := \left(P_+^i S_t - P_-^i R_t\right) u$$

is a classical solution of the boundary control system

(BCS<sup>*i*</sup>) 
$$\begin{cases} \dot{x}(t) = A_m^i x(t), & 0 \le t \le t_0, \\ L^i x(t) = v(t), & 0 \le t \le t_0, \\ x(0) = 0. \end{cases}$$

*Proof.* The first equation in  $(BCS^i)$  follows easily by inspection. The second equation holds since for  $v \in W_0^{1,p}([0, t_0], \mathbb{C}^m)$  we have

$$\delta_0(S_t v) = \hat{v} \left( t - \frac{1}{|\vec{c}|} \right) = 0, \qquad \delta_1(S_t v) = \hat{v}(t - 0) = v(t),$$
  
$$\delta_0(R_t v) = \hat{v}(t - 0) = v(t), \qquad \delta_1(R_t v) = \hat{v} \left( t - \frac{1}{|\vec{c}|} \right) = 0.$$

Finally, the third equation in  $(BCS^i)$  follows from the definition of  $\hat{v}$ .

We are now well-prepared for the proof of our main result.

Proof of Theorem 2.4. We first assume that  $c(\bullet, \bullet)$  is diagonal, i.e.,  $q(\bullet, \bullet) \equiv \text{diag}(Id, Id)$ . Then, by Lemma 2.6, G is similar to  $\overline{G}$ , hence it suffices to prove that  $\overline{G}$  given in (2.17) generates a  $C_0$ -semigroup on X. This will be done using the results from Appendix A.

For the operators  $A_m^e$ ,  $A^e$  and  $A_m^i$ ,  $A^i$  given by (2.19)–(2.20) and (2.23)–(2.24), respectively, we define on  $X = X^e \times X^i$  the operators

$$A_m := \operatorname{diag}(A_m^e, A_m^i), \quad D(A_m) := D(A_m^e) \times D(A_m^i),$$
$$A := \operatorname{diag}(A^e, A^i), \qquad D(A) := D(A^e) \times D(A^i).$$

Then  $\bar{G}, A \subset A_m$  with domains  $D(\bar{G}) = \ker(\bar{\Phi}) = \ker(\Phi^e J_\phi, \Phi^i J_{\bar{\varphi}})$  and  $D(A) = \ker(L)$  where

$$L := \operatorname{diag}(L^e, L^i) = \begin{pmatrix} P^e_{-}\delta_0 & 0\\ 0 & \delta_1 - \delta_0 \end{pmatrix} : D(A_m) \to \partial X = \partial X^e \times \partial X^i.$$

Moreover, by Lemma 2.7 and Lemma 2.9, A generates a  $C_0$ -semigroup  $(T(t))_{t\geq 0}$  on X given by

(2.27) 
$$T(t) = \operatorname{diag}(T^{e}(t), T^{i}(t)), \quad t \ge 0.$$

Hence, the assertion follows if we verify the assumptions (i)–(iv) in Theorem A.2 adapted to the present situation. Let  $0 < t_0 \leq \frac{1}{\|\bar{c}\|_{\infty}}$ .

(i) For  $t \in [0, t_0]$  and  $u \in W_0^{2, p}([0, t_0], \partial X^e)$  define  $\mathcal{B}_t^e u := Q_t u \in X^e$ . Similarly, for  $v \in L^p([0, t_0], \partial X^i)$  define  $\mathcal{B}_t^i v := (P_+^i S_t - P_-^i R_t) v \in X^i$  and put

$$\mathcal{B}_t := \operatorname{diag}\left(\mathcal{B}_t^e, \mathcal{B}_t^i\right) : \partial X = \partial X^e \times \partial X^i \to X = X^e \times X^i.$$

Then  $(\mathcal{B}_t)_{t\in[0,t_0]} \subset \mathcal{L}(\mathrm{L}^p([0,t_0],\partial X),X)$  is strongly continuous. Moreover, by Lemma 2.8 and Lemma 2.10,  $\mathbf{x}(t) := \mathcal{B}_t(u,v)^{\top}$  solves

(BCS) 
$$\begin{cases} \dot{x}(t) = A_m x(t), & 0 \le t \le t_0, \\ L x(t) = {u(t) \choose v(t)}, & 0 \le t \le t_0, \\ x(0) = 0, \end{cases}$$

hence the assertion follows.

(ii) Using the terminology introduced in Remark A.3, we have to show that  $\bar{\Phi} = (\bar{\Phi}^e, \bar{\Phi}^i)$  is *p*-admissible for the semigroup  $(T(t))_{t\geq 0}$  generated by *A*. By the representations of T(t) in (2.27) and  $T^e(t)$ ,  $T^i(t)$  in (2.22), (2.25), this is equivalent to the *p*-admissibility of

(1)  $\overline{\Phi}^e$  for the semigroup  $(T^e(t))_{t\geq 0}$  given in (2.22), and

(2)  $\overline{\Phi}^i$  for the group  $(T^i(t))_{t \in \mathbb{R}}$  given in (2.25).

To show (1), we first choose  $f \in D(A^e) \subset X^e = L^p(\mathbb{R}_+, \mathbb{C}^\ell)$ . Then similarly as in the proof of [18, Lem. 2.2] it follows for that

$$\begin{split} \int_{0}^{t_{0}} \left\| \bar{\Phi}^{e} \, T^{e}(t) f \right\|_{\partial X}^{p} \, dt &= \int_{0}^{t_{0}} \left\| \int_{0}^{+\infty} d\eta(s) \left( P_{+}^{e} f(s+t) + P_{-}^{e} \hat{f}(s-t) \right) \right\|_{\partial X}^{p} \, dt \\ &\leq \|\eta\|^{p-1} \cdot \int_{0}^{+\infty} \int_{0}^{t_{0}} \left\| \hat{f}(s\pm t) \right\|_{\mathbb{C}^{\ell}}^{p} \, dt \, d|\eta|(s) \\ &\leq \|\eta\|^{p} \cdot \|f\|_{p}^{p}, \end{split}$$

where  $\eta$  is given by (2.15) for  $\Psi = \overline{\Phi}^e$  and  $\widehat{f}$  denotes the extension of f to  $\mathbb{R}$  by the value zero. This proves (1). Next, we verify (2). Let  $f \in D(A^i) \subset X^i = L^p([0,1], \mathbb{C}^m)$ . Then, again as in the proof of [18, Lem. 2.2], it follows that

$$\begin{split} \int_{0}^{t_{0}} \left\| \bar{\Phi}^{i} T^{i}(t) f \right\|_{\partial X}^{p} dt &= \int_{0}^{t_{0}} \left\| \int_{0}^{1} d\eta(s) \, \tilde{f}(s + \bar{c} \cdot t) \right\|_{\partial X}^{p} dt \\ &\leq \|\eta\|^{p-1} \cdot \int_{0}^{1} \int_{0}^{t_{0}} \left\| \tilde{f}(s + \bar{c} \cdot t) \right\|_{\mathbb{C}^{m}}^{p} dt \, d|\eta|(s) \\ &\leq \|\eta\|^{p} \cdot M^{p} \cdot \int_{0}^{1} \|f(r)\|_{\mathbb{C}^{m}}^{p} dr \\ &\leq \|\eta\|^{p} \cdot M^{p} \cdot \|f\|_{p}^{p}, \end{split}$$

where  $\eta$  is given by (2.15) for  $\Psi = \overline{\Phi}^i$ ,  $M := \max\{|\varphi_1(1)|, \ldots, |\varphi_m(1)|\}$  and  $\tilde{f}$  denotes the 1-periodic extension of f to  $\mathbb{R}$ . This proves (2) and completes the proof of (ii). (iii) By part (i) we have

$$\mathcal{B}_t = \begin{pmatrix} Q_t & 0\\ 0 & P_+^i S_t - P_-^i R_t \end{pmatrix} \in \mathcal{L} \big( \mathcal{L}^p \big( [0, t_0], \partial X \big), X \big), \quad t \in [0, t_0],$$

where  $Q_t, S_t$  and  $R_t$  are defined in (2.9). This combined with Lemma 2.3 implies the assertion and also yields

(iv) This follows immediately from (2.28) and the invertibility assumption on  $\mathcal{R}_{t_0}$ .

Summing up, we conclude that for  $q(\bullet, \bullet) \equiv \text{diag}(Id, Id)$ , i.e., for  $c(\bullet, \bullet) = \text{diag}(\lambda^e(\bullet), \lambda^i(\bullet))$ , the operator G in (2.3) generates a  $C_0$ -semigroup if  $\mathcal{R}_{t_0}$  given by (2.10) (for  $q(\bullet, \bullet) \equiv \text{diag}(Id, Id)$ ) is invertible.

Now assume that  $c(\bullet, \bullet)$  is given by (2.1) for a Lipschitz continuous matrix function  $q(\bullet, \bullet)$ . Let  $\lambda(\bullet, \bullet) := \operatorname{diag}(\lambda^e(\bullet), \lambda^i(\bullet))$ . Then, via the similarity transformation induced by  $q(\bullet, \bullet)$ , we see that

$$G = q(\bullet, \bullet)\lambda(\bullet, \bullet)q(\bullet, \bullet)^{-1} \cdot \frac{d}{ds}, \quad D(G) = \ker(\Phi),$$

is similar to the operator

$$\tilde{G} := \lambda(\bullet, \bullet) \cdot \frac{d}{ds} + P, \quad D(\tilde{G}) := \ker \left( \Phi \cdot q(\bullet, \bullet) \right),$$

for

$$P := \lambda(\bullet, \bullet)q^{-1}(\bullet, \bullet)q'(\bullet, \bullet) \in \mathcal{L}(X).$$

Hence, by similarity and bounded perturbation G, is a generator if and only if  $\tilde{G}$  is. However, by what we proved previously for diagonal  $\lambda(\bullet, \bullet)$ , the matrix  $\tilde{G}$  is a generator if  $\mathcal{R}_{t_0}$  given by (2.10) is invertible. This completes the proof of Theorem 2.4.

Since an operator G generates a group if and only if  $\pm G$  both generate semigroups the above result gives also conditions for G to be a group generator. In particular, if the external part is empty, i.e., if  $X = X^i = L^p([0,1], \mathbb{C}^m)$ , the boundary space  $\partial X = \mathbb{C}^m$  for  $\pm G$  remains invariant. By applying Theorem 2.4 to the velocity matrices  $\pm c(\bullet, \bullet)$  we then obtain the operators  $\mathcal{R}_{t_0}^{i,+}, \mathcal{R}_{t_0}^{i,-} \in \mathcal{L}(L^p([0,t_0], \mathbb{C}^m))$  given by

(2.29) 
$$(\mathfrak{R}_{t_0}^{i,+}v)(t) = \bar{\Phi}^i \cdot (P^i_+ S_t - P^i_- R_t)v \\ (\mathfrak{R}_{t_0}^{i,-}v)(t) = \bar{\Phi}^i \cdot (P^i_+ R_t - P^i_- S_t)v$$

for  $t \in [0, t_0]$  and  $v \in W_0^{1, p}([0, t_0], \mathbb{C}^m)$ . Then the following holds.

**Corollary 2.11.** Let Assumption 2.1 be satisfied. If there exists  $t_0 > 0$  such that the operators  $\mathcal{R}_{t_0}^{i,+}, \mathcal{R}_{t_0}^{i,-} \in \mathcal{L}(\mathrm{L}^p([0,t_0],\mathbb{C}^m))$  given by (2.29) are both invertible, then the operator

$$G^{i} := c(\bullet) \cdot \frac{d}{ds},$$
$$D(G^{i}) := \left\{ f \in \mathbf{W}^{1,p} ([0,1], \mathbb{C}^{m}) : \Phi^{i} f = 0 \right\},$$

generates a  $C_0$ -group on  $X^i = L^p([0,1], \mathbb{C}^m)$ .

2.3. A Necessary Condition. In this subsection we will deduce a necessary condition for G defined in (2.3) to generate a  $C_0$ -semigroup on  $X = L^p(\mathbb{R}_+, \mathbb{C}^\ell) \times L^p([0, 1], \mathbb{C}^m)$ . In the next section we then apply this result to particular sets of boundary conditions and show that in many important cases the invertibility condition of the operator  $\mathcal{R}_{t_0}$  in Theorem 2.4 is also necessary for G to be a generator.

In order to do so we first note that by Lemma 2.6 and the final part of the proof of Theorem 2.4 the operator G with domain  $D(G) = \ker(\Phi)$  is, up to a bounded perturbation, similar to  $\overline{G}$ with domain  $D(\overline{G}) = \ker(\overline{\Phi})$  given by (2.17) for the boundary operator

(2.30) 
$$\bar{\Phi} := (\Phi^e, \Phi^i) \cdot q(\bullet, \bullet) \cdot \operatorname{diag}(J_{\phi}, J_{\bar{\varphi}}) \in \mathcal{L}(\mathcal{C}_0(\mathbb{R}_+, \mathbb{C}^\ell) \times \mathcal{C}([0, 1], \mathbb{C}^m), \partial X).$$

We then consider  $\overline{G}$  as a boundary perturbation of

(2.31) 
$$A := \operatorname{diag}\left(\left(P_{+}^{e} - P_{-}^{e}\right) \cdot \frac{d}{ds}, \bar{C} \cdot \frac{d}{ds}\right), \quad D(A) := \operatorname{ker}(L)$$

for the boundary operator

(2.32) 
$$L := \operatorname{diag}\left(P^{e}_{-}\delta_{0}, P^{i}_{+}\delta_{1} + P^{i}_{-}\delta_{0}\right) \in \mathcal{L}\left(\operatorname{C}_{0}\left(\mathbb{R}_{+}, \mathbb{C}^{\ell}\right) \times \operatorname{C}\left([0, 1], \mathbb{C}^{m}\right), \partial X\right)$$

Since the generator property is invariant under similarity transformations and bounded perturbations, Theorem A.6 will give the following result.

**Theorem 2.12.** Let the operators A and G be given by (2.31) and (2.3), respectively. Moreover, assume that the boundary operator  $\overline{\Phi}$  in (2.30) can be decomposed as

$$\bar{\Phi} = \Phi_0 + B + V \cdot L$$

for some  $\Phi_0 \in \mathcal{L}(\mathcal{C}_0(\mathbb{R}_+, \mathbb{C}^\ell) \times \mathcal{C}([0, 1], \mathbb{C}^m), \partial X)$ ,  $B \in \mathcal{L}(X, \partial X)$ , a non-invertible  $V \in \mathcal{L}(\partial X)$ , and L given by (2.32). If G generates a  $C_0$ -semigroups on X then

(2.33) 
$$\lim_{\lambda \to +\infty} \lambda^{\frac{1}{p}} \cdot \|\Phi_0 L_\lambda\| = +\infty$$

where  $L_{\lambda} \in \mathcal{L}(\partial X, X)$  is defined by  $L_{\lambda}x := \varepsilon_{\lambda}(\bullet, \bullet) \cdot x$  for

$$\varepsilon_{\lambda}(r,s) := \operatorname{diag}\left(e^{-\lambda r}, P^{i}_{+} \cdot e^{\lambda(s-1)\cdot \bar{C}^{-1}} + P^{i}_{-} \cdot e^{\lambda s \cdot \bar{C}^{-1}}\right), \quad r \in \mathbb{R}_{+}, \ s \in [0,1]$$

and  $\bar{C} \in M_m(\mathbb{R})$  given by (2.16).

*Proof.* First assume that B = 0. To verify the hypotheses of Theorem A.6 we note that  $A, \overline{G} \subset A_m$  for

(2.34) 
$$A_m := \operatorname{diag}\left(\left(P_+^e - P_-^e\right) \cdot \frac{d}{ds}, \bar{C} \cdot \frac{d}{ds}\right), \quad D(A_m) := \operatorname{W}^{1,p}\left(\mathbb{R}_+, \mathbb{C}^\ell\right) \times \operatorname{W}^{1,p}\left([0,1], \mathbb{C}^m\right).$$

Moreover, A generates a diagonal shift-semigroup on X, shifting to the left on the ranges of  $P^{e,i}_+$  and to the right on the ranges of  $P^{e,i}_-$ . Since  $\ker(\lambda - A_m) = \{\varepsilon_\lambda \cdot x : x \in \partial X\}$  and  $L\varepsilon_\lambda \cdot x = x$  for all  $\lambda > 0$  and  $x \in \partial X$ , it follows that  $L_\lambda = (L|_{\ker(\lambda - A_m)})^{-1}$ , i.e., it coincides indeed with the Dirichlet operator introduced in Lemma A.4.

Next, we estimate  $||L_{\lambda}x||_p^p$  for  $\lambda > 0$  and  $x = (x^e, x^i) = (x^e, (x_k^i)_1^m) \in \partial X = \operatorname{rg}(P_-^e) \times \mathbb{C}^m$ . In fact, since

$$\lim_{\lambda \to +\infty} e^{\frac{-p\lambda}{\bar{c}_k}} = 0 \text{ if } \bar{c}_k > 0 \quad \text{and} \quad \lim_{\lambda \to +\infty} e^{\frac{p\lambda}{\bar{c}_k}} = 0 \text{ if } \bar{c}_k < 0,$$

there exists  $\lambda_0 > 0$  such that for  $\bar{c}_{\min} := \min\{|\bar{c}_k| : k = 1, \dots, m\} > 0$  and  $\lambda \ge \lambda_0$  it holds

$$(2.35) \qquad \|L_{\lambda}x\|_{p}^{p} = \frac{1}{p\lambda} \cdot \left( \|x^{e}\|^{p} + \sum_{\bar{c}_{k}>0} \bar{c}_{k} \cdot \left(1 - e^{\frac{-p\lambda}{\bar{c}_{k}}}\right) \cdot |x_{k}^{i}|^{p} + \sum_{\bar{c}_{k}<0} |\bar{c}_{k}| \cdot \left(1 - e^{\frac{p\lambda}{\bar{c}_{k}}}\right) \cdot |x_{k}^{i}|^{p} \right) \\ \geq \frac{1}{p\lambda} \left( \|x^{e}\|^{p} + \bar{c}_{\min} \cdot \|x^{i}\|^{p} \right).$$

This implies that there exist M > 0 and  $\lambda_0 > 0$  such that

$$||L_{\lambda}x|| \ge M^{-1} \cdot \lambda^{-\frac{1}{p}} \cdot ||x||$$
 for all  $x \in \partial X, \ \lambda \ge \lambda_0$ .

Using this estimate we conclude that for all  $0 \neq f = L_{\lambda}Lf \in \ker(\lambda - A_m)$  we have

$$||Lf|| = ||Lf|| \cdot \frac{||f||}{||L_{\lambda}Lf||} \le ||Lf|| \cdot \frac{||f||}{M^{-1} \cdot \lambda^{-\frac{1}{p}} \cdot ||Lf||} = M \cdot \lambda^{\frac{1}{p}} \cdot ||f||,$$

i.e.,  $\|L\|_{\lambda} \leq M \cdot \lambda^{\frac{1}{p}}$ . The assertion now follows immediately from Theorem A.6. Finaly, take  $B \in \mathcal{L}(X, \partial X)$ . Since, by (2.35) there exists  $\tilde{M} > 0$  such that  $\|L_{\lambda}\| \leq \tilde{M} \cdot \lambda^{-\frac{1}{p}}$  for all  $\lambda > 0$ ,  $\lambda^{\frac{1}{p}} \cdot \|BL_{\lambda}\|$  remains bounded as  $\lambda \to +\infty$ . By replacing  $\Phi_0$  by  $\Phi_0 + B$ , by the first part of the proof this implies the assertion for arbitrary B.

At a first glance this result might seem rather artificial, however, as we will see in the next subsection, it significantly simplifies (like Theorem 2.4) in case the boundary operator  $\Phi$  is mainly given by point evaluations in  $r = 0 \in \mathbb{R}_+$  and  $s = 0, 1 \in [0, 1]$ .

Remark 2.13. In Theorem 2.12 we used in the internal part the boundary operator  $L^i = P^i_+ \delta_1 + P^i_- \delta_0$  for the unperturbed generator  $A^i = \bar{C} \cdot \frac{d}{ds}$ , cf. (2.32), which generates nilpotent left/right-shift semigroups. This choice is different from (2.26) in the proof of Theorem 2.4 which was associated to left/right-rotation groups. We note that in (2.32) one could also choose

(2.36) 
$$L = \operatorname{diag}(P^e_{-}\delta_0, \delta_1 - \delta_0).$$

By similar computations as above it follows again that  $||L||_{\lambda} \geq M^{-1} \cdot \lambda^{-\frac{1}{p}}$  for a suitable constant M > 0 while  $L_{\lambda}$  in this case is given by  $L_{\lambda}x = \varepsilon_{\lambda} \cdot x$  for

$$(2.37) \quad \varepsilon_{\lambda}(r,s) := \operatorname{diag}\left(e^{-\lambda r}, P^{i}_{+} \cdot e^{\lambda(s-1)\cdot \bar{C}^{-1}} \cdot \left(Id - e^{-\lambda \cdot \bar{C}^{-1}}\right) - P^{i}_{-} \cdot e^{\lambda s \cdot \bar{C}^{-1}} \cdot \left(Id - e^{\lambda \cdot \bar{C}^{-1}}\right)\right).$$

Summing up, Theorem 2.12 remains true if the operators L and  $L_{\lambda}$  are replaced by their counterparts defined by (2.36) and (2.37).

2.4. Reformulations of the Boundary Conditions. Next, we study the invertibility of  $\mathcal{R}_{t_0}$  appearing in Theorem 2.4. To this end we assume that as in (2.15) the boundary operators are given by

$$\Phi^{e}h = \int_{0}^{+\infty} d\eta^{e}(r) h(r) \quad \text{for all} \quad h \in \mathcal{L}^{p}(\mathbb{R}_{+}, \mathbb{C}^{\ell}),$$
  
$$\Phi^{i}h = \int_{0}^{1} d\eta^{i}(s) h(s) \quad \text{for all} \quad h \in \mathcal{L}^{p}([0, 1], \mathbb{C}^{m}),$$

for functions  $\eta^e : \mathbb{R}_+ \to \mathcal{L}(\mathbb{C}^\ell, \partial X)$  and  $\eta^i : [0, 1] \to \mathcal{L}(\mathbb{C}^m, \partial X)$  of bounded variation. Using these representations we define the operators

(2.38) 
$$V_0^e := \lim_{r \to 0^+} \eta^e(r) - \eta^e(0) = \int_{\{0\}} d\eta^e(r) = \nu^e(\{0\}) \in \mathcal{L}(\mathbb{C}^\ell, \partial X).$$

(2.39) 
$$V_0^i := \lim_{s \to 0^+} \eta^i(s) - \eta^i(0) \int_{\{0\}} d\eta^i(s) = \nu^i(\{0\}) \in \mathcal{L}(\mathbb{C}^m, \partial X),$$

(2.40) 
$$V_1^i := \eta^i(1) - \lim_{s \to 1^-} \eta^i(s) = \int_{\{1\}} d\eta^i(s) = \nu^i(\{1\}) \in \mathcal{L}(\mathbb{C}^m, \partial X),$$

where  $\nu^e$  and  $\nu^i$  denote the vector measures on  $\mathbb{R}_+$  and [0,1] associated to the functions  $\eta^e$  and  $\eta^i$ , respectively.

As we will see, the invertibility of  $\mathcal{R}_{t_0}$  can be characterized in terms of these three finite dimensional operators. Combined with Theorem 2.4 this gives a simple condition implying the generator property of the operator G in (2.3). In particular, it follows that the wellposedness of (1.1) for G as in (2.3) only depends on the boundary condition localized to the endpoints of the "edges"  $\mathbb{R}_+$  of the external part and [0,1] of the internal part. Recall that  $\partial X = \partial X^e \times \partial X^i = \operatorname{rg}(P^e_-) \times \mathbb{C}^m \subseteq \mathbb{C}^\ell \times \mathbb{C}^m$ , cf. (2.5).

**Lemma 2.14.** Let  $V_0^e, V_0^i, V_1^i$  be defined by (2.38)–(2.40) and let  $t_{\max} := \frac{1}{\|\bar{e}\|_{\infty}}$ . Then the following conditions are equivalent.

(a) The operator

$$\mathcal{R}_0 := \left( V_0^e q^e(0), V_1^i q^i(1) P_+^i - V_0^i q^i(0) P_-^i \right) \in \mathcal{L}(\partial X)$$

is invertible.

(b) There exists  $0 < t_0 \leq t_{\max}$  such that  $\mathcal{R}_{t_0} \in \mathcal{L}(L^p([0, t_0], \partial X))$  given by (2.10) is invertible.

*Proof.* Since in this proof we consider the "input-output map"  $\mathcal{R}_{t_0}$  for different boundary operators we use for  $\Psi = (\Psi^e, \Psi^i) \in \mathcal{L}(\mathcal{C}_0(\mathbb{R}_+, \mathbb{C}^\ell) \times \mathcal{C}([0, 1], \mathbb{C}^m), \partial X)$  the notations

$$\bar{\Psi} := (\bar{\Psi}^e, \bar{\Psi}^i) := (\Psi^e \cdot q^e(\bullet) \cdot J_\phi, \Psi^i \cdot q^i(\bullet) \cdot J_{\bar{\varphi}}) \in \mathcal{L}(\mathcal{C}_0(\mathbb{R}_+, \mathbb{C}^\ell) \times \mathcal{C}([0, 1], \mathbb{C}^m), \partial X)$$

and

$$\mathfrak{R}^{\Psi}_{t_0} := \left(\bar{\Psi}^e \cdot Q_t, \bar{\Psi}^i \cdot \left(P^i_+ \cdot \psi - P^i_-\right) \cdot R_t\right) \in \mathcal{L}(\mathrm{L}^p([0, t_0], \partial X)),$$

where  $\psi(s) := 1 - s$ , cf. (2.10), (2.11). Observe that then  $\mathcal{R}_{t_0}^{\Phi} = \mathcal{R}_{t_0}$ . Let

$$\Phi_0 = (\Phi_0^e, \Phi_0^i) := (V_0^e \delta_0, V_1^i \delta_1 + V_0^i \delta_0).$$

Then, a simple computation shows that  $\mathcal{R}_{t_0}^{\Phi_0} = \mathcal{R}_0$  for every  $t_0 > 0$ . Next, we show that

(2.41) 
$$\left\| \mathcal{R}_{t_0}^{\Phi - \Phi_0} \right\| \to 0 \quad \text{as } t_0 \to 0^+.$$

For this it suffices to verify that  $||U_{t_0}^{\Psi}|| \to 0$  for

(2.42) 
$$\Psi = \begin{cases} (\bar{\Phi}^e - \bar{\Phi}^e_0), & \text{in the external case,} \\ (\bar{\Phi}^i - \bar{\Phi}^i_0) \cdot (P^i_+ \cdot \psi - P^i_-), & \text{in the internal case,} \end{cases}$$

where  $U_{t_0}^{\Psi}$  is defined by (2.12). However, by (2.14) we have  $||U_{t_0}^{\Psi}|| \leq |\eta|(I_{t_0})$  for  $\eta$  as in (2.15) and  $I_{t_0}$  given by (2.13). Since by (2.38)–(2.40) in both cases, the external and the internal one,  $|\eta|(\{0\}) = 0$  we infer from  $I_{t_1} \subset I_{t_0}$  for  $0 < t_1 < t_0 \leq t_{\max}$  and

$$\bigcap_{0 < t_0 \le t_{\max}} I_{t_0} = \{0\}$$

that

$$0 = |\eta| (\{0\}) = \lim_{t_0 \to 0^+} |\eta| (I_{t_0})$$

which implies (2.41). Finally, observe that

(2.43) 
$$\mathcal{R}_{t_0}^{\Phi} = \mathcal{R}_{t_0}^{\Phi_0} + \mathcal{R}_{t_0}^{\Phi-\Phi_0} = \mathcal{R}_0 + \mathcal{R}_{t_0}^{\Phi-\Phi_0}$$

(a) $\Rightarrow$ (b). By (2.43) we have

(2.44) 
$$\mathfrak{R}^{\Phi}_{t_0} = \mathfrak{R}_0 \cdot \left( Id + \mathfrak{R}_0^{-1} \cdot \mathfrak{R}^{\Phi-\Phi_0}_{t_0} \right).$$

Since  $\|\mathcal{R}_0^{-1}\|_{\mathcal{L}(L^p([0,t_0],\partial X))}$  is independent of  $t_0 > 0$ , the representation (2.44) combined with (2.41) implies that  $\mathcal{R}_{t_0}^{\Phi}$  is invertible for  $t_0 > 0$  sufficiently small.

(b) $\Rightarrow$ (a). We first observe that by causality we have  $\mathcal{R}_{t_0}^{\Phi}|_{[0,t]} = \mathcal{R}_t^{\Phi}$  and  $(\mathcal{R}_{t_0}^{\Phi})^{-1}|_{[0,t_0]} = (\mathcal{R}_t^{\Phi})^{-1}$ for all  $t \in (0, t_0]$ . Hence,  $\mathcal{R}_t^{\Phi}$  is invertible and  $\|(\mathcal{R}_t^{\Phi})^{-1}\|_{\mathcal{L}(\mathrm{L}^p([0,t],\partial X))} \leq \|(\mathcal{R}_{t_0}^{\Phi})^{-1}\|_{\mathcal{L}(\mathrm{L}^p([0,t_0],\partial X))}$ for all  $t \in (0, t_0]$ . Combined with (2.43) (with  $t_0$  replaced by t) this implies

(2.45) 
$$\mathfrak{R}_0 = \mathfrak{R}_t^{\Phi} \cdot \left( Id - (\mathfrak{R}_t^{\Phi})^{-1} \cdot \mathfrak{R}_t^{\Phi - \Phi_0} \right).$$

Since  $\|(\mathcal{R}^{\Phi}_t)^{-1}\|_{\mathcal{L}(L^p([0,t],\partial X))}$  remains bounded for  $t \to 0^+$ , the representation (2.45) together with (2.41) (again with  $t_0$  replaced by t) implies that  $\mathcal{R}_0$  considered as an operator on  $L^p([0,t],\partial X)$  is invertible for t > 0 sufficiently small. Clearly, this implies that  $\mathcal{R}_0 \in \mathcal{L}(\partial X)$ is invertible as well.  $\Box$ 

Remark 2.15. Let  $B \in \mathcal{L}(X, \partial X)$ . Since  $\partial X$  is finite dimensional there exists  $k = (k^e, k^i) \in L^q(\mathbb{R}_+, \mathcal{L}(\mathbb{C}^l, \partial X)) \times L^q([0, 1], \mathcal{L}(\mathbb{C}^m, \partial X))$  for  $\frac{1}{p} + \frac{1}{q} = 1$  such that for  $f = (f^e, f^i) \in X$  we have

$$Bf = \int_0^\infty k^e(r) \cdot f^e(r) \, dr + \int_0^1 k^i(s) \cdot f^i(s) \, ds.$$

Hence, the matrices  $V_0^e, V_0^i, V_1^i$  defined in (2.38)–(2.40) remain invariant if we change the boundary operator  $\Phi$  into  $\Phi + B$ . By the previous lemma this implies that the invertibility of  $\mathcal{R}_{t_0}$  for sufficiently small  $t_0 > 0$  is invariant under bounded perturbations of the boundary operator  $\Phi$ .

Lemma 2.14 together with Theorem 2.4 gives the following.

**Corollary 2.16.** Let 
$$V_0^e, V_0^i, V_1^i$$
 be given by (2.38)–(2.40). If the operator  
 $\mathcal{R}_0 = \left(V_0^e q^e(0), V_1^i q^i(1) P_+^i - V_0^i q^i(0) P_-^i\right) \in \mathcal{L}(\partial X)$ 

is invertible, then the operator G defined in (2.3) generates a  $C_0$ -semigroup on the space  $X = L^p(\mathbb{R}_+, \mathbb{C}^{\ell}) \times L^p([0,1], \mathbb{C}^m).$ 

Denote by  $P_{\pm}^{c(\bullet,\bullet)}$  the spectral projections of  $c(\bullet,\bullet)$  associated to the positive/negative eigenvalues of  $c(\bullet,\bullet)$ . Then  $q(\bullet,\bullet)P_{\pm} = P_{\pm}^{c(\bullet,\bullet)}q(\bullet,\bullet)$  where the columns of  $q(\bullet,\bullet)$  contain linearly independent eigenvectors of  $c(\bullet,\bullet)$ . Combining this with Corollary 2.16 and the fact that a linear map on a finite dimensional vector space is surjective if and only if it is invertible immediately implies the following non-trivial generalization of the main result Thm. 1.5 in [24] to possibly non-local boundary conditions and non-compact metric graphs. At the same time it generalizes the main result Thm. 4.10 in [25] where only equations on semi-axis are considered.

**Corollary 2.17.** Let  $Z_{-}^{e}(0) \subseteq \mathbb{C}^{\ell}$  be the eigenspace of  $\lambda^{e}(0)$  corresponding to its negative eigenvalues. Similarly, for s = 0, 1 let  $Z_{\pm}^{i}(s) \subseteq \mathbb{C}^{m}$  denote the eigenspaces of  $\lambda^{i}(s)$  corresponding to its positive/negative eigenvalues. Finally, let  $V_{0}^{e}, V_{0}^{i}, V_{1}^{i}$  be given by (2.38)–(2.40). If

$$V_0^e Z_-^e(0) + V_1^i Z_+^i(1) + V_0^i Z_-^i(0) = \partial X$$

then G defined in (2.3) generates a C<sub>0</sub>-semigroup on  $X = L^p(\mathbb{R}_+, \mathbb{C}^\ell) \times L^p([0, 1], \mathbb{C}^m)$ .

Next, we consider the case where the boundary conditions are given via "boundary matrices". Recall that  $\partial X = \operatorname{rg}(P^e_{-}) \times \mathbb{C}^m \subseteq \mathbb{C}^{\ell+m}$  and denote by

$$q := \dim \partial X = \operatorname{rank}(P^e_{-}) + m$$

**Corollary 2.18.** Let  $V_0^e \in M_{q \times \ell}(\mathbb{C}), V_0^i, V_1^i \in M_{q \times m}(\mathbb{C})$  and  $B \in \mathcal{L}(X, \partial X)$ . Then

$$G = c(\bullet, \bullet) \cdot \frac{a}{ds},$$
  
$$D(G) = \left\{ f = {f^e \choose f^i} \in W^{1,p}(\mathbb{R}_+, \mathbb{C}^\ell) \times W^{1,p}([0,1], \mathbb{C}^m) : V_0^e f^e(0) + V_0^i f^i(0) - V_1^i f^i(1) = Bf \right\},$$

generates a  $C_0$ -semigroup on  $X = L^p(\mathbb{R}_+, \mathbb{C}^\ell) \times L^p([0,1], \mathbb{C}^m)$  if and only if the operator

(2.46) 
$$\mathcal{R}_0 := \left( V_0^e q^e(0), V_1^i q^i(1) P_+^i - V_0^i q^i(0) P_-^i \right) \in \mathcal{L}(\partial X)$$

is invertible.

*Proof.* The "if" part follows from Remark 2.15 and Corollary 2.16 by choosing  $\Phi^e := V_0^e \delta_0$  and  $\Phi^i := V_0^i \delta_0 - V_1^i \delta_1$  which implies  $\nu^e(\{0\}) = V_0^e, \nu^i(\{0\}) = V_0^i, \nu^i(\{1\}) = V_1^i$  in (2.38)–(2.40). For the "only if" part we assume that  $\mathcal{R}_0$  is not invertible and have to show that in this case G is not a generator. To this end we use Theorem 2.12 where, without loss of generality, we assume that B = 0. Observe, that as  $\mathcal{R}_0$  also

$$V := \mathcal{R}_0 \cdot \operatorname{diag}(Id_{\partial X^e}, -Id_{\partial X^i}) = \left(V_0^e q^e(0), V_0^i q^i(0) P_-^i - V_1^i q^i(1) P_+^i\right) \in \mathcal{L}(\partial X)$$

is not invertible. Next we decompose

$$\bar{\Phi} = \left( V_0^e q^e(0)\delta_0, V_0^i q^i(0)\delta_0 - V_1^i q^i(1)\delta_1 \right) = \Phi_0 + V \cdot L$$

where L is given by (2.32). Hence,

$$\Phi_0 = \bar{\Phi} - V \cdot L = \left( V_0^e q^e(0) P_+^e \delta_0, V_0^i q^i(0) P_+^i \delta_0 - V_1^i q^i(1) P_-^i \delta_1 \right).$$

This yields, independently on the generator property of G, that

$$\begin{aligned} \|\Phi_0 L_\lambda\| &= \left\| \left( 0, V_0^i q^i(0) \cdot P_+^i e^{-\lambda \bar{C}^{-1}} - V_1^i q^i(1) \cdot P_-^i e^{\lambda \bar{C}^{-1}} \right) \right\| \\ &\leq M \cdot e^{-\bar{c}_{\min} \cdot \lambda} \end{aligned}$$

for a suitable constant M > 0,  $\bar{c}_{\min} := \min\{|\bar{c}_k| : k = 1, \dots, m\} > 0$  and  $\lambda > 0$ . Thus,

$$\lim_{\lambda \to +\infty} \lambda^{\frac{1}{p}} \cdot \|\Phi_0 L_\lambda\| = 0$$

and by (2.33) in Theorem 2.12 the operator G cannot be the generator of a  $C_0$ -semigroup. This completes the proof.

In the compact case  $X = X^i = L^p([0,1], \mathbb{C}^m)$  we obtain a simple determinant condition for the (semi-)group generation.

**Corollary 2.19.** Let  $V_0, V_1 \in M_m(\mathbb{C})$  and  $B \in \mathcal{L}(L^p([0,1],\mathbb{C}^m),\mathbb{C}^m)$ . Then the operator

$$G = c(\bullet) \cdot \frac{d}{ds},$$
  
$$D(G) = \left\{ f \in \mathbf{W}^{1,p} ([0,1], \mathbb{C}^m) : V_0 f(0) - V_1 f(1) = Bf \right\},$$

generates a  $C_0$ -semigroup on  $L^p([0,1], \mathbb{C}^m)$  if and only if

$$\det(V_1q(1)P_+ - V_0q(0)P_-) \neq 0,$$

Moreover, (G, D(G)) generates a  $C_0$ -group if and only if in addition

$$\det(V_1q(1)P_- - V_0q(0)P_+) \neq 0.$$

*Remark* 2.20. Observe that in the group case one can combine the two determinant conditions to the single condition

$$\det\left(V_1q(1)P_+q(0)^\top V_0^\top + V_0q(0)P_-q(1)^\top V_1^\top\right) \neq 0.$$

Moreover, since  $q(\bullet)$  is invertible, in the case when all the velocities are of the same sign, the conditions simplify to det  $V_0 \neq 0$ , det  $V_1 \neq 0$ , and det $(V_0 V_1^{\top}) \neq 0$ , respectively.

We conclude the section with a few basic examples.

Example 2.21. Consider a simple transport operator  $G \subset \frac{d}{ds}$  on  $L^p[0, 1]$  with non-local boundary conditions that appear, for example, in the McKendrick–von Foerster equation, cf. [22]. More precisely, for  $h \in L^q[0, 1]$  where  $\frac{1}{p} + \frac{1}{q} = 1$ , we define the domain

$$D(G) := \left\{ f \in \mathbf{W}^{1,p}([0,1],\mathbb{C}) \mid f(1) = \int_0^1 h(s)f(s) \, ds \right\}.$$

In our setting this corresponds to  $\ell = 0$ , m = 1, the velocity coefficient  $c(\bullet) \equiv 1$ , the state space  $X = L^p[0,1]$ , the boundary space  $\partial X = \mathbb{C}$ , the boundary "matrices"  $V_0 = 0$ ,  $V_1 = -1$ , the projections  $P_+ = 1$ ,  $P_- = 0$  and the bounded boundary functional  $B \in X'$  given by  $Bf := \int_0^1 h(s)f(s) ds$ . By Corollary 2.19 this implies that G generates a  $C_0$ -semigroup but not a group on  $L^p[0,1]$ .

*Example 2.22.* Consider a system of transport equations on two closed unit intervals, so m = 2 and  $\ell = 0$ . More precisely, we take the operator

$$G = q(\bullet) \cdot \begin{pmatrix} \lambda_1(\bullet) & 0\\ 0 & \lambda_2(\bullet) \end{pmatrix} \cdot q(\bullet)^{-1} \cdot \frac{d}{ds}, \quad D(G) = \{ f \in W^{1,p}([0,1], \mathbb{C}^2) : V_0 f(0) = V_1 f(1) \},$$

for functions  $\lambda_1(\bullet), \lambda_2(\bullet) \in L^{\infty}([0,1], \mathbb{C})$  of constant sign (cf. (2.2)), Lipschitz continuous matrix-valued function  $q(\bullet)$  such that  $q(\bullet), q^{-1}(\bullet) \in L^{\infty}([0,1], M_2(\mathbb{C}))$ , and complex 2 × 2 matrices

(2.47) 
$$V_0 = \begin{pmatrix} a & b \\ c & d \end{pmatrix}$$
 and  $V_1 = \begin{pmatrix} \alpha & \beta \\ \gamma & \delta \end{pmatrix}$ .

Let us first examine the simplest case when  $q(\bullet) = Id$ . If  $\lambda_1(\bullet), \lambda_2(\bullet)$  are both positive (resp. negative), Corollary 2.19 yields the generation of a  $C_0$ -semigroup if and only if det  $V_1 \neq 0$ (resp. det  $V_0 \neq 0$ ) and the generation of a group if and only if both matrices are invertible. In case  $\lambda_1(\bullet) > 0 > \lambda_2(\bullet)$  (resp.  $\lambda_1(\bullet) < 0 < \lambda_2(\bullet)$ ), the generation condition for the  $C_0$ -semigroup becomes

(2.48) 
$$\det \begin{pmatrix} \alpha & -b \\ \gamma & -d \end{pmatrix} \neq 0 \quad (\text{resp. } \det \begin{pmatrix} \beta & -a \\ \delta & -c \end{pmatrix} \neq 0).$$

Moreover, if both determinants are nonzero we obtain a  $C_0$ -group.

Next, we consider general  $q(\bullet)$ . Observe, that in the case when  $\lambda_1(\bullet), \lambda_2(\bullet)$  are both of the same sign, by invertibility,  $q(\bullet)$  has no influence to the generation condition. However, if  $\lambda_1(\bullet)$  and  $\lambda_2(\bullet)$  have the opposite signs, the entries of q(0) and q(1) may significantly contribute to the invertibility of the matrices in question. To demonstrate this, take  $\lambda_1(\bullet) > 0 > \lambda_2(\bullet)$  and  $V_0 = V_1 = Id$ . For  $q(\bullet) = Id$  both conditions in (2.48) are fullfiled and yield a  $C_0$ -group. On the other hand, if we take

$$q(s) := \begin{pmatrix} 2-s & s-1\\ 1-s & s \end{pmatrix},$$

which satisfies Assumption 2.1, the matrix  $V_1q(1)P_+ - V_0q(0)P_-$  is singular.

*Example* 2.23. Consider a system of transport equations on two different intervals: the first equations takes place on  $\mathbb{R}_+$  and the second one on [0, 1]. We thus have  $\ell = 1 = m$  and

$$G = \begin{pmatrix} \lambda^e(\bullet) \cdot \frac{d}{ds} & 0\\ 0 & \lambda^i(\bullet) \cdot \frac{d}{ds} \end{pmatrix},$$
  
$$D(G) = \left\{ f = \begin{pmatrix} f^e\\ f^i \end{pmatrix} \in \mathrm{W}^{1,p}(\mathbb{R}_+, \mathbb{C}) \times \mathrm{W}^{1,p}([0,1], \mathbb{C}) : V_0^e f^e(0) + V_0^i f^i(0) = V_1^i f^i(1) \right\},$$

for some velocity functions  $\lambda^{e}(\bullet) \in L^{\infty}(\mathbb{R}_{+}, \mathbb{C}), \lambda^{i}(\bullet) \in L^{\infty}([0, 1], \mathbb{C})$  and boundary matrices  $V_{0}^{e} \in M_{q \times 1}(\mathbb{C})$  and  $V_{0}^{i}, V_{1}^{i} \in M_{q \times 1}(\mathbb{C})$ . The size of these matrices depends on the sign of  $\lambda^{e}(\bullet)$ : if  $\lambda^{e}(\bullet) > 0$  then q = 1 and all the matrices are scalars, i.e., we only have one boundary condition. In this case, Corollary 2.18 characterizes the generation of a  $C_{0}$ -semigroup through the condition  $V_{0}^{i} \neq 0$  if  $\lambda^{i}(\bullet) < 0$ , respectively  $V_{1}^{i} \neq 0$  if  $\lambda^{i}(\bullet) > 0$ . However, if  $\lambda^{e}(\bullet) < 0$ , the boundary space  $\partial X$  gets two-dimensional, that is q = 2, and the generation condition in case of  $\lambda^{i}(\bullet) > 0$  (resp.  $\lambda^{i}(\bullet) < 0$ ) becomes

$$\det \begin{pmatrix} \alpha & c \\ \beta & d \end{pmatrix} \neq 0 \quad (\text{resp. } \det \begin{pmatrix} \alpha & -a \\ \beta & -b \end{pmatrix} \neq 0),$$

where  $V_0^e = \begin{pmatrix} \alpha \\ \beta \end{pmatrix}$ ,  $V_0^i = \begin{pmatrix} a \\ b \end{pmatrix}$  and  $V_1^i = \begin{pmatrix} c \\ d \end{pmatrix}$ .

# 3. Application to Flows in Networks

In this section we use our abstract results to show the well-posedness of transport equations on networks. We will consider initial-boundary value problems as in (1.1) where the structure of the network will be encoded in the domain D(G).

Consider a finite metric graph (network) with *n* vertices  $v_1, \ldots, v_n$ , *m* internal edges  $e_1^i, \ldots, e_m^i$ , which we parametrize on the unit interval [0, 1], and  $\ell$  external edges  $e_1^e, \ldots, e_{\ell}^e$ , parametrized on the half-line  $\mathbb{R}_+$ . A graph without external edges is called *compact*. For simplicity, the graph is assumed to be connected and without vertices of degree 1.

Along the edges of this metric graph some material is transported. This flow process is described by a system of linear transport equations

(3.1) 
$$\frac{d}{dt} u_k^e(t,s) = \lambda_k^e(s) \cdot \frac{d}{ds} u_k^e(t,s), \quad t \ge 0, \quad s > 0, \qquad k = 1, \dots, \ell, \\ \frac{d}{dt} u_j^i(t,s) = \lambda_j^i(s) \cdot \frac{d}{ds} u_j^i(t,s), \quad t \ge 0, \quad s \in (0,1), \quad j = 1, \dots, m,$$

for some uniformly bounded functions  $\lambda_k^e(\bullet) \in L^{\infty}(\mathbb{R}_+, \mathbb{C}), \lambda_j^i(\bullet) \in L^{\infty}([0, 1], \mathbb{C}$ . Here,  $u_k^e$ ,  $u_j^i$  represent the flow density and  $\lambda_k^e, \lambda_j^i$  the flow velocity on the edge  $\mathbf{e}_k^e, \mathbf{e}_j^i$ , respectively. In the vertices of the graph the material gets redistributed according to some prescribed rules which translate to boundary conditions of our problem. We shall assume that these conditions respect the network structure, that is only the values at common endpoints can interfere.

While the underlying combinatorial graph is a priori not directed, the parametrization orients the edges of the corresponding metric graph. The direction of the flow on a given edge is determined by the sign of the appropriate velocity coefficient: a negative coefficient yields a flow from the endpoint 0 to the endpoint 1 on the corresponding edge and the opposite holds in the case of a positive coefficient. For a directed graph we always assume that the direction of the edges corresponds to the direction of the flow. Let us start with some simple examples.

Example 3.1. Reconsider the system presented in Example 2.22 (with  $q(\bullet) = Id$ ) and imagine now the two intervals glued together at both endpoints, forming a double edge, so m = 2and  $\ell = 0$ . Here, we have two possibilities for the flow direction, yielding either a sink or a loop, as depicted in the first two pictures of Figure 1. They are obtained by the appropriate combinations of the parametrization of the intervals and the sign of the velocity coefficients. Up to isomorphism, we may assume that  $\lambda_1(\bullet), \lambda_2(\bullet)$  are both negative, and we glue the same endpoints (0-0 and 1-1) in the first case and mixed endpoints (0-1 and 1-0) in the second case.



FIGURE 1. Compact graphs from Example 3.1. The edges are oriented according to the direction of the flow.

We now only consider boundary conditions that are reflecting the structure of the graph, that is boundary matrices  $V_0$ ,  $V_1$  from (2.47) should have non-zero entries only if the corresponding endpoints agree. Up to the simultaneous permutation of the rows, we obtain in case of the sink-graph (A) the following possibilities

$$V_0 = \begin{pmatrix} a & b \\ 0 & 0 \end{pmatrix}, \quad V_1 = \begin{pmatrix} 0 & 0 \\ \gamma & \delta \end{pmatrix} \quad \text{or} \quad V_0 = \begin{pmatrix} a & 0 \\ 0 & d \end{pmatrix}, \quad V_1 = \begin{pmatrix} 0 & 0 \\ 0 & 0 \end{pmatrix}$$

Since we assumed negative velocities, Corollary 2.19 yields no generation in the first case and the generation of a  $C_0$ -semigroup (but not a group) in the second case if and only if  $ad \neq 0$ . Note, however, that the second boundary conditions are degenerated since the second common node (at the endpoints 1) is not taken into account and are usually not considered in the study of transport processes on metric graphs.

In the case of the loop-graph (B), we have

$$V_0 = \begin{pmatrix} a & 0 \\ 0 & d \end{pmatrix}, \quad V_1 = \begin{pmatrix} 0 & \beta \\ \gamma & 0 \end{pmatrix},$$

which yields the generation of a  $C_0$ -semigroup if and only if  $ad \neq 0$  and even a  $C_0$ -group if and only if  $ad\beta\gamma \neq 0$ .

Now, let us add another edge, obtaining the so-called pumpkin graph (C). As before, we assume that  $\lambda_1(\bullet), \lambda_2(\bullet), \lambda_3(\bullet)$  are all negative, and the intervals are parametrized such that the direction of the flow is from endpoint 0 to endpoint 1. We first take the following coupling conditions for the intervals

$$u_1(0) + u_2(0) = u_3(1)$$
 and  $u_3(0) = u_1(1) + u_2(1)$ 

that incorporate the conservation of the mass in both vertices (i.e., so-called Kirchhoff-type conditions). These conditions give rise to the boundary matrices

$$V_0 = \begin{pmatrix} 1 & 1 & 0 \\ 0 & 0 & 1 \\ 0 & 0 & 0 \end{pmatrix} \quad \text{and} \quad V_1 = \begin{pmatrix} 0 & 0 & 1 \\ 1 & 1 & 0 \\ 0 & 0 & 0 \end{pmatrix}$$

which yield no generation since  $V_0$  is not invertible. This corresponds with the intuition that only 2 boundary conditions for this problem do not suffice. If instead we impose the conditions

$$u_1(0) = \alpha \cdot u_3(1), \quad u_2(0) = (1 - \alpha) \cdot u_3(1) \text{ and } u_3(0) = u_1(1) + u_2(1),$$

for some  $\alpha \in (0, 1)$ , we still have the conservation of mass in the vertices but the boundary matrices now take the form

$$V_0 = \begin{pmatrix} 1 & 0 & 0 \\ 0 & 1 & 0 \\ 0 & 0 & 1 \end{pmatrix} \quad \text{and} \quad V_1 = \begin{pmatrix} 0 & 0 & \alpha \\ 0 & 0 & 1 - \alpha \\ 1 & 1 & 0 \end{pmatrix}$$

and we obtain a well-posed problem governed by a semigroup which is not a group.

*Example* 3.2. To obtain simple examples of non-compact graphs we add to the loop-graph from Example 3.1 two edges of infinite length, parametrized as  $\mathbb{R}_+$ . For the velocities we consider 3 possibilities, each yielding a different dimension q of the respective boundary space  $\partial X$ . They are presented in Figure 2 together with the corresponding boundary matrices.

By Corollary 2.18, we obtain a  $C_0$ -semigroup in every case if and only if  $ad \neq 0$ ,  $ad\mu \neq 0$ , and  $ad\lambda\nu \neq 0$ , respectively.

3.1. Compact Graphs. Starting with [28], there is a series of articles dealing with transport processes of type (3.1) on compact graphs, cf. [30, 6, 5]. In all these works the semigroup approach is used, which is summarized in [15] and [8, Ch. 18]. Note, that in most of these papers the velocities are taken positive and the flow process is directed on the edges from the endpoint 1 to the endpoint 0. Moreover, the "boundary space"  $\partial X$  in these works relates to the vertices of the graph and equals  $\mathbb{C}^n$  while we take  $\partial X = \mathbb{C}^m$  that complies with the number of the boundary conditions needed (see the discussion preceding (2.5)).

The most natural boundary conditions in this context are *Kirchhoff conditions* expressing the conservation of mass, that is, the sum of the incoming flow in every vertex equals the sum of the outgoing flow from that vertex. These conditions are complemented by certain

transmission rules that prescribe the proportions of the mass flowing into each of the outgoing edges. As observed in [6, Thm. 2.1], one needs to restrict to the case without sinks in the graph; that is, we have to assume that from every vertex the material is flowing out on at least one edge. In this case, the boundary conditions appearing in the description of the domain of the generator can be rewritten in the form

$$(3.2) f(0) = \mathbb{B}f(1),$$

where  $\mathbb{B}$  is the so-called (weighted, transposed) *adjacency matrix of the line graph*, i.e. an  $m \times m$  matrix incorporating the structure of the graph, see [8, Prop. 18.2] for more details. By Corollary 2.19, the network transport problem (3.1) with boundary conditions of the form (3.2) is well-posed with no extra assumptions on the matrix  $\mathbb{B}$ .

Our results cover all situations where the boundary conditions can be written as in (3.2)which, apart from simple transport equation with constant coefficients like in [28, 6, 5, 8], include also non-constant coefficients cases as in [30, 4] or transport equations with scattering, see [31, 15]. Yet another example of this kind are transmission line networks with nonconservative junction conditions as studied in [12]. Since every edge has exactly one starting and one ending vertex, the local boundary conditions [12, (3.3)] can be equivalently written as (3.2) where the entries of  $\mathbb{B}$  correspond to appropriate entries of locally given scattering matrices. Again, no additional assumption on  $\mathbb{B}$  is needed in order to obtain well-posedness. In [12] only balanced graphs are considered (i.e., graphs with the same number of incoming and outgoing edges in each vertex) and invertibility of the scattering matrices is assumed, however, the focus there is not on well-posedness but on spectral properties of the generator. We point out that Theorem 2.4 and its corollaries for the compact case, i.e., Corollary 2.11 and Corollary 2.19, enable to tackle problems with much more general boundary conditions as studied in the references mentioned above. Moreover, one can apply the spectral theory developed in [3] to characterize the spectrum of the generator in terms of the graph matrix  $\mathbb{B}$ , see, e.g. Lemma A.5 and [8, Cor. 18.13].

3.2. Non-compact Graphs. To our knowledge, first-order equations on non-compact graphs have not attained much attention in the literature. In [20] the action of momentum operator  $-i\hbar \frac{d}{ds}$  on non-compact metric (or quantum) graphs has been considered in the L<sup>2</sup>-setting, the conditions yielding a self-adjoint generator were presented, and its spectral properties studied. Further, [25] is devoted to port-Hamiltonian systems corresponding to a class of hyperbolic partial differential equations of first order on the semi-axis and the main result is the characterization of the boundary conditions yielding  $C_0$ -semigroup generation. On the other hand, there has been some more work done in the case of second-order equations, see [18] and the references therein.

Let us first show how to write the boundary conditions also in the non-compact case in the form resembling (3.2). Starting with the problem on a compact graph as in Corollary 2.19 and assuming that all the velocities are negative, the generation condition becomes the invertibility of  $V_0$ . For invertible  $V_0$ , we can write the boundary conditions as

$$V_0f(0) = V_1f(1) \iff f(0) = V_0^{-1}V_1f(1),$$

hence, by taking  $\mathbb{B} := V_0^{-1}V_1$ , we obtain (3.2). We now proceed similarly in the non-compact case, with the setting as in Corollary 2.18 and taking all the internal velocities to be negative. We can write the boundary conditions in D(G) as

$$\left( V_0^e, V_0^i \right) \begin{pmatrix} f^e(0) \\ f^i(0) \end{pmatrix} = V_1^i f^i(1) \iff \begin{pmatrix} f^e(0) \\ f^i(0) \end{pmatrix} = \left( V_0^e, V_0^i \right)^+ V_1^i f^i(1)$$

where  $A^+$  denotes the Moore-Penrose pseudoinverse of matrix A. Note, that the generation condition in this case yields that the matrix  $(V_0^e, V_0^i)$  has full rank (=q) and the pseudoinverse

is the right inverse of this matrix. Taking  $\mathbb{B} := (V_0^e, V_0^i)^+ V_1^i$  we obtain the desired form of the conditions. Thus, by Corollary 2.18 we can cover a wide variety of boundary conditions.

*Example* 3.3. Take a non-compact graph with 5 finite and 4 infinite edges as depicted on Figure 3. We assume that all internal velocities  $\lambda_k^i(\bullet) < 0, k = 1, \ldots, 5$ . For the external part

we assume

$$\lambda_1^e(\bullet) = \lambda_2^e(\bullet) > 0, \quad \lambda_3^e(\bullet) = \lambda_4^e(\bullet) < 0,$$

hence  $P^i_+ = 0$ ,  $P^i_- = Id$  and rank  $P^e_- = 2$ , so q = 7. We equip the system with the following coupling conditions in the common vertices

$$\begin{aligned} u_2^i(0) &= \alpha_1 u_1^i(1), & u_1^i(0) = u_4^i(1) + u_1^e(0), \\ u_5^i(0) &= \alpha_2 u_1^i(1), & u_4^i(0) = \gamma_1 u_5^i(1) + \delta_1 u_3^i(1) + \varepsilon_1 u_2^e(0), \\ u_3^i(0) &= \beta_1 u_2^i(1), & u_3^e(0) = \gamma_2 u_5^i(1) + \delta_2 u_3^i(1) + \varepsilon_2 u_2^e(0), \\ u_4^e(0) &= \beta_2 u_2^i(1) \end{aligned}$$

for some coefficients  $\alpha_1, \alpha_2, \beta_1, \beta_2, \gamma_1, \gamma_2, \delta_1, \delta_2, \varepsilon_1, \varepsilon_2 > 0$ . The corresponding boundary matrices in this situation are

Observe that the matrix

$$\mathcal{R}_0 = \left(V_0^e, V_1^i P_+^i - V_0^i P_-^i\right) = \left(V_0^e, V_0^i\right)$$

from (2.46) is of full rank, hence we obtain the generation of a  $C_0$ -semigroup.

*Example* 3.4. The non-compact graphs considered in the literature are usually assumed to be star-shaped, that is without the compact part. Let us thus consider transport equations on a star-shaped network with a single vertex and  $\ell$  infinite edges. We assume the material is transported into the common node along  $\ell - q$  edges while it flows out of it along q edges. We orient and enumerate the edges according to the flow direction:

$$\lambda_i^e < 0, \ i = 1, \dots, q \text{ and } \lambda_j^e > 0, \ j = q + 1, \dots, \ell,$$

as depicted in Figure 4. In the common vertex we impose the boundary conditions for the

outgoing flows in the form

$$u_i^e(t,0) = \sum_{j=q+1}^{\ell} \alpha_{ij} u_j^e(t,0), \quad i = 1, \dots, q.$$

Since for any choice of the coefficients  $\alpha_{ij} \in \mathbb{R}$  we have  $\operatorname{rank}(P^e_{-}) = q = \operatorname{rank} V^e_0$ , Corollary 2.18 yields the generation of a  $C_0$ -semigroup. This result generalizes [25, Ex. 6.2].

### Appendix A. Domain Perturbation for Generators of $C_0$ -Semigroups

In this appendix we first briefly recall a perturbation result from [18, App. A] which easily follows from [1, Sect. 4.3] and is our main tool to prove Theorem 2.4. Further, in Theorem A.6 we supplement this theory with a new result which is needed to obtain the necessary condition in Theorem 2.12.

To explain the general setup we consider

- two Banach spaces X and  $\partial X$ , called "state" and "boundary" spaces, respectively;
- a closed, densely defined "maximal" operator<sup>1</sup>  $A_m : D(A_m) \subseteq X \to X;$
- the Banach space  $[D(A_m)] := (D(A_m), \|\bullet\|_{A_m})$  where  $\|f\|_{A_m} := \|f\| + \|A_m f\|$  is the graph norm;
- two "boundary" operators  $L, \Phi \in \mathcal{L}([D(A_m)], \partial X)$ .

Then, define two restrictions  $A, G \subset A_m$  by

$$D(A) := \{ f \in D(A_m) : Lf = 0 \} = \ker(L), D(G) := \{ f \in D(A_m) : \Phi f = 0 \} = \ker(\Phi).$$

Hence, one can consider G with boundary condition  $\Phi f = 0$  as a perturbation of the operator A with abstract "Dirichlet type" boundary condition Lf = 0. In order to proceed we make throughout this appendix the following

### Assumption A.1.

- (i) The operator A generates a  $C_0$ -semigroup  $(T(t))_{t>0}$  on X;
- (ii) the boundary operators  $L, \Phi: D(A_m) \to \partial X$  are surjective.

By combining [18, Cor. A.5] and [18, Lem. A.6] we obtain the following.

**Theorem A.2.** Assume that there exist  $1 \leq p < +\infty$ ,  $t_0 > 0$ ,  $M \geq 0$ , and a strongly continuous family  $(\mathcal{B}_t)_{t \in [0,t_0]} \subset \mathcal{L}(\mathrm{L}^p([0,t_0],\partial X), X)$  such that the following assertions hold.

<sup>&</sup>lt;sup>1</sup>"maximal" concerns the size of the domain, e.g., a differential operator without boundary conditions.

(i) For every  $v \in W_0^{2,p}([0,t_0],\partial X)$  the function

 $x \colon [0, t_0] \to X, \quad x(t) := \mathcal{B}_t v$ 

is a classical solution of the boundary control problem

$$\begin{cases} \dot{x}(t) = A_m x(t), & 0 \le t \le t_0, \\ L x(t) = v(t), & 0 \le t \le t_0, \\ x(0) = 0. \end{cases}$$

(ii) For all  $x \in D(A)$ ,

$$\int_0^{t_0} \left\| \Phi T(s) x \right\|_{\partial X}^p ds \le M \cdot \|x\|_X^p.$$

(iii) For all  $v \in W_0^{2,p}([0,t_0],\partial X)$ ,

$$\int_0^{t_0} \left\| \Phi \mathcal{B}_t v \right\|_{\partial X}^p dt \le M \cdot \|v\|_p^p$$

(iv)  $\Omega_{t_0}$  is invertible, where  $\Omega_{t_0} \in \mathcal{L}(L^p([0, t_0], \partial X))$  is given by

$$(\mathfrak{Q}_{t_0}v)(\bullet) = \Phi \mathfrak{B}_{\bullet}v \quad for \ all \ v \in \mathrm{W}^{2,p}_0([0,t_0],\partial X).$$

Then  $G \subset A_m$ ,  $D(G) := \ker(\Phi)$  generates a  $C_0$ -semigroup on the Banach space X.

Remark A.3. If assumption (ii) in Theorem A.2 is satisfied, then the operator  $\Phi$  is called *p*-admissible for  $(T(t))_{t\geq 0}$ .

For more details and examples regarding boundary perturbation results of the above type we refer to [1, 2, 10].

While the previous result provides a sufficient condition for  $G \subset A_m$  with domain  $D(G) = \ker \Phi$  to be the generator of a  $C_0$ -semigroup our next aim is to give a necessary one. To this end we first need the following result from in [21, Lem. 1.2].

**Lemma A.4.** For each  $\lambda \in \rho(A)$  the restricted operator  $L|_{\ker(\lambda-A_m)}$  is invertible and  $L_{\lambda} := (L|_{\ker(\lambda-A_m)})^{-1} : \partial X \to \ker(\lambda-A_m) \subseteq X$  is bounded.

Using these so-called abstract Dirichlet operators  $L_{\lambda} \in \mathcal{L}(\partial X, X)$  one can characterize the spectrum of G, cf. [3, Cor. 3.13]. Note that  $L_{\lambda} \in \mathcal{L}(\partial X, [D(A_m)])$ , hence  $\Phi L_{\lambda} : \partial X \to \partial X$  is bounded for every  $\lambda \in \rho(A)$ .

**Lemma A.5.** For every  $\lambda \in \rho(A)$  one has

$$\lambda \in \rho(G) \iff \Phi L_{\lambda} \in \mathcal{L}(\partial X) \text{ is invertible}$$

Since for  $\lambda \in \rho(A)$  the norms  $\|\cdot\|_{[D(A_m)]}$  and  $\|\cdot\|_X$  restricted to  $\operatorname{rg}(L_\lambda) = \ker(\lambda - A_m)$  are equivalent, the restriction  $L : (\ker(\lambda - A_m), \|\cdot\|_X) \to \partial X$  is bounded. Hence,

(A.1) 
$$||L||_{\lambda} := ||L||_{\mathcal{L}((\ker(\lambda - A_m), \|\cdot\|_X), \partial X)} < +\infty$$

is well-defined. Now we are well-prepared to give a necessary condition for G to be a generator on X.

**Theorem A.6.** Suppose that  $G \subset A_m$  with domain  $D(G) = \ker(\Phi)$  is a generator of a  $C_0$ semigroup where  $\Phi = \Phi_0 + V \cdot L$  for  $\Phi_0 \in \mathcal{L}([D(A_m)], \partial X)$  and a non-invertible operator  $V \in \mathcal{L}(\partial X)$ . If  $\dim(\partial X) < \infty$  then

(A.2) 
$$\lim_{\lambda \to +\infty} \|L\|_{\lambda} \cdot \|\Phi_0 L_{\lambda}\| = +\infty.$$

*Proof.* Let  $\lambda, \mu \in \rho(A) \cap \rho(G)$ . Then, by Lemma A.4, the Dirichlet operators  $L_{\lambda}, L_{\mu}$  exist and by Lemma A.5 the operator  $\Phi L_{\lambda} \in \mathcal{L}(\partial X)$  is invertible. A simple computation then shows that

$$R(\lambda, G)L_{\mu} = \frac{1}{\lambda - \mu} \left( L_{\mu} - L_{\lambda} (\Phi L_{\lambda})^{-1} \Phi L_{\mu} \right).$$

Using that  $\lambda R(\lambda, G)f \to f$  as  $\lambda \to +\infty$  for every  $f \in X$  we conclude that for all  $x \in \partial X$ 

$$\lim_{\lambda \to +\infty} L_{\lambda} (\Phi L_{\lambda})^{-1} \Phi L_{\mu} x = 0$$

Since  $\Phi L_{\mu} \in \mathcal{L}(\partial X)$  is invertible and the unit ball in  $\partial X$  is compact this implies

(A.3) 
$$\lim_{\lambda \to +\infty} \left\| L_{\lambda} (\Phi L_{\lambda})^{-1} \right\| = 0.$$

Next, using that  $LL_{\lambda} = Id_{\partial X}$  from the decomposition  $\Phi = \Phi_0 + V \cdot L$  we obtain

$$V = \Phi L_{\lambda} - \Phi_0 L_{\lambda} = \Phi L_{\lambda} \cdot \left( Id - (\Phi L_{\lambda})^{-1} \cdot \Phi_0 L_{\lambda} \right) \in \mathcal{L}(\partial X)$$

which by assumption is not invertible. Therefore,

(A.4) 
$$\|\Phi_0 L_\lambda\| \ge \|(\Phi L_\lambda)^{-1}\|^{-1}$$

Combining this with (A.1) gives

$$\begin{split} \|\Phi_0 L_\lambda\|^{-1} &\leq \left\| (\Phi L_\lambda)^{-1} \right\| \\ &= \left\| L L_\lambda (\Phi L_\lambda)^{-1} \right\|_{\mathcal{L}(X)} \\ &\leq \|L\|_\lambda \cdot \left\| L_\lambda (\Phi L_\lambda)^{-1} \right\|_{\mathcal{L}(\partial X, X)} \end{split}$$

By (A.3) we infer

$$\lim_{\lambda \to +\infty} \|L\|_{\lambda}^{-1} \cdot \|\Phi_0 L_{\lambda}\|^{-1} = 0$$

which implies (A.2).

Note that in the previous proof we didn't make use of the fact that A is a generator but only needed the existence of the Dirichlet operators  $L_{\lambda}$  for  $\lambda$  sufficiently large.
