# Semantics of Conjectures

#### Abstract

This paper aims to expand and detail the notion of formal semantics of Conjectures by applying the theoretic-model approach seen in [Hay04], [Pat14] and related works. After a short introduction to the concepts and basics of Conjectures, we will start from the notion of Simple Interpretation of RDF, applying and extending the semantic rules and conditions to fully cover the concepts and features of Conjectures.


## 1 Introduction

The semantics of RDF makes it impossible to express contradictory points of view that act on the same data.
Every approach applied in the past has not solved the main issue, that is, being able to express different statements whose truth value is not known, or even in contrast with each other, without fully asserting them, therefore making them undoubtedly true.

In this paper we introduce and examine the characteristics of conjectures, a proposed extension to RDF 1.1 that by design allows the expressions of graphs whose truth value is unknown.
The approach revolves around two main concepts:

- conjecture: a concept whose truth value is not available and its representation;
- collapse to reality: a mechanism to fully assert, when the time comes, the truth value of conjectures in their RDF-esque form.

Conjectures encapsulate plain RDF statements or other conjectures in specially marked named graphs. They can be expressed in a strong form:

or, allowing us to be able to include them in plain RDF 1.1 datasets, in a weak form, where the predicate is expressed as a conjectural predicate:

Additional statements adding information to the conjecture, but external to it, are the grounds or ground statements. One of them is the last triple in the last example.

This paper is organized as follows: in section 2 we show a number of fundamental concepts and results of the conceptual model of conjectures.
In section 3 we introduce the impact of conjectures onto the standard RDF Simple interpretation according to [Hay04].
Sections 4 through 7 describe the simple interpretation of the main concepts of Conjectures: conjectures of individual triples, collapse to reality of individual triples, conjectures and collapses of graphs, and conjectures involving blank nodes.
In section 8 we discuss the simple interpretation of the additional features of conjectures: nested conjectures, conjectural collapses, ad cascading collapses.
In section 9 we draw some conclusions about the formal model presented here.

## 2 Set-theoretical formal model

Assume the disjoint sets $\mathcal{I}$ (all IRIs), $\mathcal{B}$ (blank nodes), and $\mathcal{L}$ (literals). An RDF triple is a tuple $(s, p, o) \in \mathcal{T}=$ $(\mathcal{I} \cup \mathcal{B}) \times \mathcal{I} \times(\mathcal{I} \cup \mathcal{B} \cup \mathcal{L})$.
For every RDF predicate $p$, let $\mathcal{S}_{p} \subseteq(\mathcal{I} \cup \mathcal{B})$ be its domain and $\mathcal{O}_{p} \subseteq(\mathcal{I} \cup \mathcal{B} \cup \mathcal{L})$ its range.
We denote with
$x\{s p \circ\}$
a triple $(s, p, o)$ that is referred to in the examples by the name $x$.
Conjecturing: Conjecturing is the function conj: $\mathcal{T} \rightarrow \mathcal{T}$ such that, for every RDF triple $t_{1}=\left(s_{1}, p, o_{1}\right), \operatorname{conj}\left(t_{1}\right)=$ $\left(s, p_{s, o}, o\right)$ where:

1. Identity of subject: $s_{1}=s$.
2. Identity of object: $o_{1}=o$.
3. Disjointness: $\forall s_{j}, o_{k}$ such that $\left(s_{j}, p_{s, o}, o_{k}\right) \in \mathcal{T}$, we have that $s=s_{j}$ and $o=o_{k}$.

Conjectures, conjectural predicates, conjecturing triple: given the triple $(s, p, o) \in \mathcal{T}$, its conjecture is the triple

$$
\operatorname{conj}((s, p, o))=\left(s, p_{s, o}, o\right)
$$

Conjectural predicates (or weak predicates) of predicate $p$ are all the predicates that are members of the set $\mathcal{C o n j} j_{p}$, such that:

$$
\mathcal{C o n j}_{p}=\left\{c p \in \mathcal{I} \mid \exists s \in S_{p}, o \in O_{p}, \operatorname{conj}((s, p, o))=(s, c p, o)\right\}
$$

Theorem 1: every conjectural predicate is used in one triple only.
Proof: derives from item 3 of definition 1 (Disjointness): Given two triples $\left(s_{1}, p_{s, o}, o_{1}\right),\left(s_{2}, p_{s, o}, o_{2}\right) \in \mathcal{T}$.
For item 3 of definition 1 (Disjointness), we have that $s_{1}=s_{2}$ and $o_{1}=o_{2} . \forall(s, p, o) \in \mathcal{T}, \exists!p_{s, o}$ such that $\operatorname{conj}((s, p, o))=\left(s, p_{s, o}, o\right)$.
Corollary 1: the function conj is unique (barring predicate name changes).
Proof: derives immediately from Theorem 1.
Conjectural Form: predicate $q$ is said to be a conjectural form of $p$ if there exists a pair of subjects and objects $s, o$ such that $\operatorname{conj}((s, p, o))=(s, q, o)$.
Collapsing: Collapsing is a function collapses : $\mathcal{T} \rightarrow \mathcal{T}$ such that, for every RDF triple $t=(s, p, o)$, $\operatorname{collapses}(s, p, o)=\left(s, p_{s, o}, o\right)$ iff $\operatorname{conj}((s, p, o))=\left(s, p_{s, o}, o\right)$, and is undefined otherwise.
Collapsed predicate; collapse: let $\left(s, p_{s, o}, o\right)$ be a conjecture. The collapsed predicate of $p_{s, o}$ is the predicate $p$ such that

$$
\operatorname{collapses}(s, p, o)=\left(s, p_{s, o}, o\right)
$$

The collapse is the triple

$$
\left((s, p, o), \text { collapse },\left(s, p_{s, o}, o\right)\right)
$$

## 3 RDF Simple interpretation and Conjectures

In RDF, a simple interpretation $I$ of a vocabulary $V$ consists of:

1. A non-empty set $I R$ of resources, called the domain or universe of $I$.
2. A set $I P$, called the set of properties of $I$.
3. A mapping $I E X T$ from $I P$ into the powerset of $I R \times I R$ i.e. the set of sets of pairs $<x, y>$ with $x$ and $y$ in $I R$.
4. A mapping $I S$ from IRIs into $I R$ - in order to map resources and properties
5. A partial mapping $I L$ from literals into $I R$ - in order to map literals
$\operatorname{IEXT}(p)$ is the extension of $p$, that is the set of pairs that are the arguments for which the property $p$ is true.
According to [Pat14], a semantic extension is a set of additional semantic assumptions that gives IRIs additional meanings on the basis of other specifications or conventions. When this happens, the semantic extension must conform to the minimal truth conditions already enunciated, extending from them to accommodate the additional meanings.

Therefore, we extend the RDF Simple Interpretation adding a new set of conjectural properties, $I P C$, disjoint from the set of properties $I P$, where the conjectural predicates are created on the fly.
We add a new mapping $I E X T C$ from $I P C$ to the Cartesian product $I R \times I R . I E X T C(c p)$ identifies the pair for which the property $c p$ is true.

Because of the Disjointness property of the conjecturing function conj seen in section 1, the pair satisfying the property $c p$ will always be unique.

We need to specify an additional mapping $C O N J F O R M$ from $I P$ into $I P C$ to map the conjectural forms of the properties.
Our full simple interpretation of $I$ in RDF with Conjectures is:

1. A non-empty set $I R$ of resources, called the domain or universe of $I$.
2. A set $I P$, called the set of properties of $I$.
3. A set $I P C$, called the set of conjectural properties of $I . I P C \cap I P=\emptyset$
4. A mapping $I E X T$ from $I P$ into the powerset of $I R \times I R$ i.e. the set of sets of pairs $<x, y>$ with $x, y \in I R$
5. An injective mapping $I E X T C$ from $I P C$ into $I R \times I R$, in other words the set of pairs $<x, y>$ with $x, y \in I R$. By definition of injective mapping, if $\operatorname{IEXTC}(a)=\operatorname{IEXTC}(b)$, then $a=b$, that is, any $c p \in I P C$ uniquely applies to a specific pair $\langle x, y\rangle$.
6. A mapping CONJFORM from $I P$ into $I P C$ in order to map the conjectural forms of the properties
7. A mapping $I S$ from IRIs into $I R$ - in order to map resources, properties and conjectural properties
8. A partial mapping $I L$ from literals into $I R$ - in order to map literals
9. A conjecture might be represented as a set of individual statements composing as a whole the conjecture. This set is a conjectural graph

## 4 Conjectures

- if $E$ is a literal then $I(E)=I L(E)$
- if $E$ is an IRI then $I(E)=I S(E)$
- if $E$ is a ground triple $s p o$. then
$-I(E)=$ true if $I(p) \in I P$ and

- the pair $<I(s), I(o)>\in I E X T(I(p))$
- otherwise $I(E)=$ false.
- if $E$ is a Conjecture triple $s c p o$. then
- $I(E)=$ true if $I(c p) \in I P C$ and
- the pair $<I(s), I(o)>\in I E X T C(I(c p))$
- $I(c p) \in C O N J F O R M(I(p))$ for some $I(p) \in I P$
- otherwise $I(E)=$ false.
- if $E$ is a ground RDF graph then $I(E)=$ false if $I\left(E^{\prime}\right)=$ false for some triple $E^{\prime} \in E$, otherwise $I(E)=$ true.
- if $E$ is a ground conjectural graph then $I(E)=$ false if $I\left(E^{\prime}\right)=$ false for some triple $E^{\prime} \in E$, otherwise $I(E)=$ true .

The last clause captures the definition of conjectural graph seen before.

### 4.1 Model

Given a RDF graph $G$, we say that the interpretation $I$ is a model of the graph $G$ if all the triples of graph $G$ are satisfied, that is, if they are true according to rules of $I$. In this case, we can say that Interpretation $I$ satisfies $G$.

The notion of model is at the basis of the (simple) entailment: following standard terminology, we say that $I$ (simply) satisfies $G$ when $I(G)=$ true, that $G$ is (simply) satisfiable when a simple interpretation exists which satisfies it, otherwise (simply) unsatisfiable, and that a graph $E$ simply entails a graph $G$ when every interpretation which satisfies $E$ also satisfies $G$. If two graphs $G$ and F each entail the other then they are logically equivalent. [Pat14]
Is our interpretation $I$ a model of this conjecture graph?

- $I R=\{d V W H, h, c, c c 1, e, i a c f\}$
- $I P=\{c, i a c f\}$
- IPC $=\{c c 1\}$

The functions:

- IS(: deVereWroteHamlet) $\rightarrow d V W H$
- IS (: Hamlet $) \rightarrow h$
- IS(conj001 : creator) $\rightarrow c c 1$
- IS(: EdwardDeVere) $\rightarrow e$
- IS(conj :isAConjecturalFormOf) $\rightarrow$ iacf
- IS $(d c:$ creator $) \rightarrow c$
- $\operatorname{IEXT}(c)=\emptyset$
- IEXT(iacf) $=\{\langle c c 1, c\rangle\}$
- $\operatorname{IEXTC}(c c 1)=\{\langle h, e\rangle\}$
- $\operatorname{CONJFORM}(c)=c c 1$

IEXT(c) is the empty set. We are still dealing with a conjecture, there is no assertion regarding any "real" property (in this case $d c:$ creator) yet.

All the clauses seem to hold. We can say that simple interpretation (s-interpretation) $I$ is a model of our graph.

## 5 Collapse to reality

At a certain point, someone may want to consider our conjectures as true.
In this case we would need to specify a mechanism in order to express the statements in the conjecture in full force.
This mechanism is called "collapse to reality".
It consists of exactly two triples added to the base, where:

- in the first new triple, the "effective" property is used instead of the corresponding conjectural property.
- the first new triple is then declared to "collapse" the conjecture .

Two new triples are added, nothing gets replaced or deleted. So we can keep track of what's happening and all the relationships between the graphs.
Let's reason on an example of a collapse:

: attr 1 is collapsed by adding a triple : attr $1 C o t$ where the conjectural predicate is replaced by the corresponding "real" predicate.

The final additional triple functions as the explication of the collapse. : attr1Cot is declarad to collapse the conjecture : attr1 by means of the property "conj:collapses".

For the sake of clarity:

- the conjecture triple to be collapsed will be the "conjecture triple";
- the new triple collapsing the conjecture will be the "collapsing triple";
- the last triple will be the "collapse triple".


### 5.1 Interpretation $[I+C O L L A P S E]$

We need to extend once more our Interpretation with Conjectures $I$ by adding the Collapse to Reality rules.
We define a new mapping collapses from triples to triples that maps the relationship between the conjecture triple and its collapsing triple:
$\operatorname{collapses}(s, p, o)=(s, c p, o)$ iff $\operatorname{conj}(s, p, o)=(s, c p, o)$.
The collapse collapses the conjecture triple if, and only if, the latter is the (unique) conjecture of the collapsing triple.
We can clearly see that the "collapses triple" is just the translation into RDF of the definition of collapse we have introduced in section 1 , that is, the triple:

$$
((s, p, o), \quad \text { collapses, } \quad(s, c p, o))
$$

From a more formal point of view, given a conjectural triple $E$, we add the triple $E_{c o t}$ as a collapsing triple $\left\{\begin{array}{lll}s & p & o .\end{array}\right\}$. The semantic conditions of the collapse to reality should be the following:

- let $E$ be a conjecture triple
$\left\{\begin{array}{llll}s & c p & o & .\end{array}\right\}$
let $E_{c o t}$ be a collapsing triple
$\left\{\begin{array}{llll}s & p & o & .\end{array}\right\}$
and finally let $E_{\text {collapse }}$ be the collapse triple
$\left\{E_{\text {cot }}\right.$ collapses $\left.E\right\}$
then
- $I(E)=$ true if $I(c p) \in I P C$ and
- $I\left(E_{\text {cot }}\right)=$ true if $I(p) \in I P$ and
- CONJFORM $(I(p))=I(c p)$ and
- the pair $<I(s), I(o)>\in I E X T C(I(c p))$ and
- the pair $<I(s), I(o)>\in I E X T(I(p))$ and
$-I\left(E_{\text {collapse }}\right)=$ true if collapses $\left(I\left(E_{\text {cot }}\right)\right)=I(E)$, that is: collapses $(I(s), I(p), I(o))=$ $(I(s), I(c p), I(o))$
- otherwise $I(E)=$ false and $I\left(E_{c o t}\right)=$ false and $I\left(E_{\text {collapse }}\right)=$ false.


### 5.2 Model

Now, let's check if our Interpretation $[I+C O L L A P S E]$ can be a model of our example graph.

- $I R=\{a 1, h, c c 3, s, i a c f, c, a 1 c o t, c l\}$
- $I P=\{i a c f, c, c l\}$
- $I P C=\{c c 3\}$

The functions:

- IS $(: \operatorname{attr} 1) \rightarrow a 1$
- IS(: Hamlet) $\rightarrow h$
- IS(conj003 : creator $) \rightarrow c c 3$
- IS(: Shakespeare) $\rightarrow s$
- IS (conj : isAConjecturalFormOf) $\rightarrow i a c f$
- IS $(d c:$ creator $) \rightarrow c$
- IS (: attr $1 C o t) \rightarrow a 1 c o t$
- IS (conj : collapses $) \rightarrow c l$
- $\operatorname{IEXT}(i a c f)=\{<c c 3, c\rangle\}$
- $\operatorname{IEXT}(c)=\{<h, s>\}$
- $\operatorname{IEXT}(c l)=\{<a 1, a 1 \cot >\}$
- $\operatorname{IEXTC}(c c 3)=\{\langle h, s\rangle\}$
- CONJFORM $(c)=c c 3$

Let's check our semantic conditions for the collapse to reality:

- $c c 3 \in I P C$ ? Yes;
- $c \in I P$ ? Yes;
- CONJFORM $(c)=c c 3$ ? Yes;
- The pair $<h, s>\in I E X T C(c c 3)$ ? Yes;
- The pair $<h, s>\in \operatorname{IEXTC}(c)$ ? Yes;
- collapses $(h, c, s)=(h, c c 3, s)$ ? Yes, because CONJFORM $(c)=c c 3$, hence $\operatorname{conj}(h, c, s)=(h, c c 3, s)$

All of them seem to hold.
Hence, our interpretation $[I+C O L L A P S E]$ is a model of our graph.
As we will see in section 6.2 , the collapsing triple and the collapse triple can be safely merged into a collapse graph:

## 6 Conjectural Graphs and Collapse Graphs

### 6.1 Conjectural Graphs

A conjectural graph is a representation of a conjecture by means of a set of individual statements composing as a whole the said conjecture.

A ground Conjectural Graph is a graph with no blank nodes.
All triples inside a Conjectural Graph must be either with a conjectural predicate used exactly once, or a "conj:isAConjecturalFormOf" triple connecting a conjectural predicate to an original one.

The semantic conditions for Conjectural Graphs are:

- if $E$ is a literal then $I(E)=I L(E)$
- if $E$ is an IRI then $I(E)=I S(E)$
- if $E$ is a Conjecture triple $s c p$ o . then
- $I(E)=$ true if $I(c p) \in I P C$ and
- the pair $<I(s), I(o)>\in I E X T C(I(c p))$
- $I(c p) \in C O N J F O R M(I(p))$ for some $I(p) \in I P$ and
- $E$ must be unique in the graph
- otherwise $I(E)=$ false.
- if $E$ is a triple cpconj : isAConjecturalFormOfp then
$-I(E)=$ true if $I(c p) \in I P C$ and
- $I(p) \in I P$ and
- $I(c p) \in C O N J F O R M(I(p))$ and
- I(conj : isAConjecturalFormOf) $\in I P$
- the pair $<I(c p), I(p)>\in I E X T(I(\operatorname{conj}:$ isAConjecturalFormOf $))$
- otherwise $I(E)=$ false
- if $E$ is a ground conjectural graph then $I(E)=$ false if $I\left(E^{\prime}\right)=$ false for some triple $E^{\prime} \in E$, otherwise $I(E)=$ true .


### 6.2 Collapse Graphs

Collapse graphs are graphs that connect explicitly with a conjecture and make it possible to track which conjecture was collapsed.

They must be composed at least of:

- the "effective form" of the conjecture to be collapsed
- a "conj:collapse" triple connecting the conjecture to the collapse

The semantic conditions are:

- let $E_{c o n j}$ be a conjecture triple $s c p o$.
- let $E_{\text {collapse }}$ be a collapse graph
- if $E$ is a literal then $I(E)=I L(E)$
- if $E$ is an IRI then $I(E)=I S(E)$
- if $E$ is a triple spo. then
- $I(E)=$ true if $I(p) \in I P$ and
- the pair $<I(s), I(o)>\in \operatorname{IEXT}(I(p))$
- CONJFORM $(I(p))=I(c p)$ where $c p$ is the conjectural predicate of the conjecture to be collapsed
- otherwise $I(E)=$ false.
- if $E$ is a triple $E_{\text {collapse }}$ conj : collapses $\quad E_{\text {conj }}$ then
$-I(E)=$ true if $I($ conj : collapses $) \in I P$ and
- the pair $<I\left(E_{\text {collapse }}\right), I\left(E_{\text {conj }}\right)>\in I E X T(I($ conj : collapses $))$
- otherwise $I(E)=$ false
- if $E$ is a ground conjectural graph then $I(E)=$ false if $I\left(E^{\prime}\right)=$ false for some triple $E^{\prime} \in E$, otherwise $I(E)=$ true .


## 7 Blank Nodes

With conjectures, we would want to be able to express even more "uncertain" concepts involving unnamed entities or unspecified values.

In RDF this is done through blank nodes, which indicate the existence of an entity without using a IRI to identify any particular one.
In this section we will use a simple sentence implying the reliance on a blank node, namely "Muammar al-Qaddafi claimed that the author of Othello was someone who was an Arab" ${ }^{1}$

In this case we don't know who someone is, and we can't identify it with any IRIs.
Nevertheless, the information we are conveying with our conjecture maintains some degree of meaningfulness, and it definitely is something we could reason upon.

Sticking to our examples' style, we could say it like this: 'it is conjectured that Othello was written by somebody and this somebody was an Arab. And this claim has been attributed to Muammar al-Qaddafi".
In RDF:

It comes pretty natural to conceive the term "somebody" as a blank node.

### 7.1 Interpretation $[I+A]$

In order to deal with blank nodes, we need to add a new mapping $A$ from blank nodes into IR.
Therefore, we extend our interpretation $I$ :

- $[I+A](x)=I(x)$ for names
- $[I+A](x)=A(x)$ if x is a blank node.

We add a couple of semantic conditions to our interpretation for blank nodes, one is the "standard" one for RDF graphs, the other one is for conjectures:

- if $E$ is a RDF graph then $I(E)=$ true if $[I+A](E)=$ true for some mapping $A$ from the set of blank nodes in $E$ to $I R$, otherwise $I(E)=$ false.
- if $E$ is a conjectural graph then $I(E)=$ true if $[I+A](E)=$ true for some mapping $A$ from the set of blank nodes in $E$ to $I R$, otherwise $I(E)=$ false.


### 7.2 Model

Is our Interpretation $[I+A]$ with blank nodes a model of our example graph?
Let's reason on : ArabW roteOthello part only.
Be $A$ our blank nodes mapping into $I R:_{-}: z \rightarrow z z$.
Our interpretation $[I+A]$ will be:

- $I R=\{a w o, o, c, c c 2, i a c f, n, a, z z\}$
- IP $=\{c, i a c f, n\}$
- IPC $=\{c c 2\}$

The functions:

- IS (: ArabWroteOthello $) \rightarrow$ awo
- IS (: Othello) $\rightarrow o$
- IS (conj002 : creator $) \rightarrow c c 2$
- IS $(d c:$ creator $) \rightarrow c$
- IS (dbpedia - owl : nationality $) \rightarrow n$
- IS $(: A r a b) \rightarrow a$
- IS (conj : isAConjecturalFormOf) $\rightarrow i a c f$
- $\operatorname{IEXT}(c)=\emptyset$
- $\operatorname{IEXT}(i a c f)=\{\langle c c 2, c\rangle\}$
- CONJFORM $(c)=c c 2$
- $\operatorname{IEXT}(n)=\{<z z, a>\}$
- $\operatorname{IEXTC}(c c 2)=\{\langle o, z z\rangle\}$

Even in this case $\operatorname{IEXT}(c)$ is empty because there is no assertion regarding the property $d c$ : creator yet, so our conjecture is, well, still a conjecture.

The last two functions hold because of the mapping $A$ of our blank node.
All the clauses are true. Our interpretation $I+A$ is a model of our graph.
This approach allows us to reason with the blank nodes in what-if scenarios, where we could define the $A$ mapping from blank nodes to specific resources of our choice, therefore exploring new relationships arising between the triples.

## 8 Further applications of conjectures

### 8.1 Conjecture of a conjecture - nested conjectures

Let's imagine we want to express a conjecture on another conjecture. Of course, the process can involve as many conjectures over conjectures we want.
Such as:

They are three different conjectures, one becoming the subject of the other one:

- the first one says that Hamlet is conjectured to have been written by Edward De Vere;
- the second one says that the previous conjecture could possibly have been made by J. Thomas Looney;
- The third one says that it might be that the second conjecture could have been brought to light by the resource with URL https://bit.ly/3wSH76A.

The fourth triple says that the last conjecture has been attributed to Fabio Vitali.
Reading it (more or less) backwards: Fabio Vitali has stated that the resource at https://bit.ly/3wSH76A might have brought to light that J. Thomas Looney could have possibly said that Hamlet is conjectured to have been written by Edward De Vere.

We could imagine it as a stack, or a stair, where at level 0 we have the first conjecture, and then as we get on the higher steps, the conjectures we find are built with the conjecture at the level below as a subject (or object, or both):

Level 2: $\quad E\{3\}=\{\mathrm{E}\{2\}, \mathrm{cp} 3, \mathrm{o} 3\}$
Level 1: $\quad E\{2\}=(E\{1\}, c p 2, o 2\}$
Level 0: E\{1\}=(s1, cp1, o1)
Developing the Level 2 we see they are nested in each other: $E 3=(E 1, c p 2, o 2), c p 3, o 3)=$ (((s1, cp1,o1), cp2, o2), cp3,o3)

### 8.1.1 Interpretation $[I+N E S T E D C O N J]$

In order to delineate the rules for the conjectures of conjectures (or nested conjectures), we can reason with pairs of conjectures.

As stated before, the conjectures at levels $>0$ could be based on lower-level conjectures as their subject or object, or both.
For the sake of conciseness, we momentarily limit ourselves to reason with the case of the lower-level conjectures as their subject only.

1. if $E_{0}$ is a ground conjecture $\left(s_{0}, c p_{0}, o_{0}\right), E_{1}=\left(E_{0}, c p_{1}, o_{1}\right)$
2. if $E_{1}$ is a ground conjecture $\left(E_{0}, c p_{1}, o_{1}\right), E_{2}=\left(E 1, c p_{2}, o_{2}\right)[\ldots]$
3. if $E_{k-1}$ is a "higher level" ground conjecture $\left(E_{k-2}, c p_{k-1}, o_{k-1}\right), E_{k}=\left(E_{k-1}, c p_{k}, o_{k}\right)$
4. if $E_{k}$ is a "higher level" ground conjecture $\left(E_{k-1}, c p_{k}, o_{k}\right), E_{k+1}=\left(E_{k}, c p_{k+1}, o_{k+1}\right)$

We should have the following cases:

- base case:

$$
-E_{0}=\left(s_{0}, p_{0}, o_{0}\right)
$$

- 1st cases:
- $E_{1}=\left(E_{0}, c p_{1}, o_{1}\right)$
- $E_{1}=\left(s_{1}, c p_{1}, E_{0}\right)$
- $k^{t h}$ cases:
- $E_{k}=\left(E_{k-1)}, c p_{k}, o_{k}\right)$
- $E_{k}=\left(s_{k}, c p_{k}, E_{k-1}\right)$

Let's extend our interpretation $I$ adding new rules.
The extension will be subdivided into cases, depending on the type of conjectures to be evaluated.
We must also enforce an order on the operations: we start from the conjecture(s) at the "lowest level", that is, the one(s) not involving other conjectures, evaluate them and "climb" up the "stair".
Therefore, the extension to the interpretation $I$ will be:
Base case - for the lowest level conjecture at level 0:

- let $E_{0}$ be a conjecture triple
$\left\{\begin{array}{llll}s_{0} & c p_{0} & o_{0} & .\end{array}\right\}$ then
$-I\left(E_{0}\right)=$ true if $I\left(c p_{0}\right) \in I P C$ and
- the pair $<I\left(s_{0}\right), I\left(o_{0}\right)>\in I E X T C\left(I\left(c p_{0}\right)\right)$
- otherwise $I\left(E_{0}\right)=$ false

As we "climb" up the "stair" and get to the conjecture $E_{k}$, we can assume that the conjecture $E_{k-1}$ has already been proved by the previous steps.
$K^{t h}$ Case $\mathbf{S}$ - for conjectures at the first step and above having another conjecture as the subject:

- let $E_{k-1}$ be a conjecture triple
let $E_{k}$ be a conjecture triple
$\left\{\begin{array}{llll}E_{k-1} & c p_{k} & o_{k} & .\end{array}\right\}$
then
- $I\left(E_{k}\right)=$ true if $I\left(E_{k-1}\right)=$ true and
- $I\left(c p_{k}\right) \in I P C$ and
- the pair $<I\left(E_{k-1}\right), I\left(o_{k}\right)>\in \operatorname{IEXTC}\left(I\left(c p_{k}\right)\right)$
- otherwise $I\left(E_{k}\right)=$ false
$K^{t h}$ Case $\mathbf{O}$ - for conjectures at the first step and above having another conjecture as the object:
- let $E_{k-1}$ be a conjecture triple
let $E_{k}$ be a conjecture triple
$\left\{\begin{array}{llll}s_{k} & c p_{k} & E_{k-1} & .\end{array}\right\}$
then
- $I\left(E_{k}\right)=$ true if $I\left(E_{k-1}\right)=$ true and
$-I\left(c p_{k}\right) \in I P C$ and
- the pair $<I\left(s_{k}\right), I\left(E_{k-1}\right)>\in \operatorname{IEXTC}\left(I\left(c p_{k}\right)\right)$
- otherwise $I\left(E_{k}\right)=$ false
$K^{t h}$ Case SO - for conjectures at the first step and above having another conjecture as the subject and yet another one as the object:
- let $E_{(k-1) a}$ be a conjecture triple let $E_{(k-1) b}$ be a conjecture triple let $E_{k}$ be a conjecture triple
$\left\{E_{(k-1) a} \quad c p_{k} \quad E_{(k-1) b} \quad.\right\}$ then
$-I\left(E_{k}\right)=$ true if $I\left(E_{(k-1) a}\right)=$ true and
$-I\left(E_{(k-1) b}\right)=$ true and
- $I\left(c p_{k}\right) \in I P C$ and
- the pair $<I\left(E_{(k-1) a}\right), I\left(E_{(k-1) b}\right)>\in \operatorname{IEXTC}\left(I\left(c p_{k}\right)\right)$
- otherwise $I\left(E_{k}\right)=$ false


### 8.1.2 Model

Is our Interpretation $[I+N E S T E D C O N J]$ a model of the nested conjectures example seen before?
We define the sets:

- IR $=\{c 1, h, c c 4, e d v, i a c f, c, c 2, c w a 4, j t l, p w a, c 3, c w i b 4, h t t p, p w i b, f v\}$
- $I P=\{c, i a c f, p w a, p w i b\}$
- $I P C=\{c c 4, c w a 4, c w i b 4\}$

The functions:

- IS $(:$ conjecture 01$) \rightarrow c 1$
- IS (: Hamlet) $\rightarrow h$
- IS (conj004 : creator $) \rightarrow c c 4$
- IS(: EdwardDeVere) $\rightarrow e d v$
- IS (conj : isAConjecturalFormOf) $\rightarrow$ iacf
- IS $(d c:$ creator $) \rightarrow c$
- IS $(:$ conjecture 02$) \rightarrow c 2$
- IS (conj004 : was AttributedTo) $\rightarrow$ cwa 4
- IS(: JThomasLooney $) \rightarrow j t l$
- IS(prov: wasAttributedTo) $\rightarrow$ pwa
- IS $(:$ conjecture 03$) \rightarrow c 3$
- IS (conj004 : wasInformedBy) $\rightarrow$ cwib4

Let's check the validity of the rules of the new semantic extension.
We must start from the conjecture not depending on other conjecture, that is : conjecture 01 , and we use the Base Case:

- Is $c c 4 \in I P C$ ? Yes
- Is the pair $<h, e v>\in I E X T C(c c 4)$ Yes

The "base" conjecture seems to hold. We can say that $c 1=$ true

Now we "climb the stair" to : conjecture02. Since it is based on another conjecture (: conjecture01, already proved true) as its subject, we use " $k^{t h}$ Case $S$ "

- is $c 1=$ true? Yes
- is $c w a 4 \in I P C$ ? Yes
- is the pair $<c 1, j t l>\in I E X T C(c w a 4)$ ? Yes

Then we can say that $c 2=$ true.

Let's climb one step higher. : conjecture 03 is based on : conjecture 02 as its subject. We still use " $k^{\text {th }}$ Case S "

- is $c 2=$ true? Yes
- is cwib4 $\in I P C$ ? Yes
- is the pair $<c 2$, http $>\in I E X T C(c w i b 4)$ ? Yes
$\rightarrow c 3=$ true.
The last triple : conjecture03prov : wasAttributedTo : FabioVitali is satisfied by the rules of the simple intepretation $I$
Everything seems to hold.
We can say that our Interpretation $[I+N E S T E D C O N J]$ satisfies all the triples of the graph.


### 8.2 Conjecture of a collapse

Let us consider the following sentence:
According to Encyclopaedia Britannica (https://bit.ly/3qgakFT), Samuel Johnson attributed Hamlet to William Shakespeare, and he was right in saying so.

This sentence is more than a mere collapse: it is a conjecture by an article in Encyclopedia Britannica a) attributing to Samuel Johnson a conjecture (about the authorship of Hamlet), and b) expressing total confidence in such conjecture (i.e., collapsing it).

Its representation is:

In this case we have a conjecture of a collapse that, if collapsing, as a side effect, triggers the collapse of another conjecture, therefore asserting it in full force. Please note that, in its current and "uncollapsed" status, everything is conjectured.

We can see the familiar predicate collapses in its conjectural form, not yet in force in this case. This predicate, once met in its "effective" form, will trigger the collapse of its subject. We will see it in the next section.

### 8.3 Cascading collapses

Cascading collapses are all the collapses that take place recursively when multiple and nested conjectures of collapses collapse.
For example, what if we wanted to state that the collapse Of Attribution01 is true? We would collapse it by adding the "collapsing triple" and the "collapse triple" as per the rules of Interpretation [I + COLLAPSE] seen before in 5.1

For the sake of simplicity, we resort to the notion of collapse graph 6.2. According to that, we can safely group the added triples into the collapse graph : collapseO fcollapseOf Attribution01.
Now that our conjecture of a collapse is declared true, therefore the collapse is true and effective, we have to enforce it, collapsing : attribution01

Generalising, once a conjecture of a collapse is declared true, we must enforce a new special rule for its collapse to reality:

Whenever collapses is met in its effective form inside a collapse graph, its object, if it is a conjecture, must be collapsed.
If the object is a conjecture triple scp o, we need to add the collapsing triple and the collapse triple.
Getting back to our example, we can see that the collapse triple is already defined in its effective form, in fact we have that:

So we just need to add the collapsing triple, stating the conjecture in its full force, in the graph where the conj : collapses property is met in full force.

The result will be as follows:

A collapse graph is built for the first collapse of the conjecture of the collapse, and then, at the end, the final "effective" triple.
We need to extend the Interpretation [I + COLLAPSE] seen before in 5.1 .
After we collapse the conjecture of the collapse following the rules in [I+COLLAPSE], we will find the property collapses in its effective form inside the collapse graph.
We need to extend the notion of collapses defining it from collapse graphs to conjectural graphs: collapses $(G)=(E)$ iff $\forall(s, c p, o) \in E, \operatorname{conj}(s, p, o)=(s, c p, o)$ with $(s, p, o) \in G$.
If the object of the collapses property is a triple, which can be considered as a special case of a graph, we will add its effective form to the conjectural graph collapses is in.

If the object of collapses property is a conjectural graph, we need to add the effective forms of all its conjectures.
One important thing to be aware of is that we disregard the subject of the collapses property: the effective form of the conjecture(s) in the object(s) is added to the current collapse graph no matter their subject(s).

In the semantic conditions below we will simplify for clarity by adopting the notion of a generic graph as the theoretical subject of a collapses property. The graphs will in fact be more than one, if the subjects of the conjectures which are objects of collapses are distinct (as in the example above). Also The conjecture graphs/triples can be more than one.

The semantic conditions are:

## conjecture triple:

- let $E$ be a conjecture triple
$\left\{\begin{array}{llll}s & c p & o & .\end{array}\right\}$
let $E_{g}$ be a generic graph
let $E_{c g}$ be a collapse graph
$\left\{E_{g}\right.$ conj : collapses $E$
$\left.\begin{array}{lll}s & p & o .\end{array}\right\}$
then
- $I(E)=$ true if $I(c p) \in I P C$ and
- $I\left(E_{c g}\right)=$ true if $I(p) \in I P$ and
- CONJFORM $(I(p))=I(c p)$ and
- the pair $<I(s), I(o)>\in I E X T C(I(c p))$ and
- the pair $<I(s), I(o)>\in I E X T(I(p))$ and
- I(conj : collapses $) \in I P$ and
- the pair $<I\left(E_{g}\right), I(E>\in I E X T(I(c o n j:$ collapses $))$
- otherwise $I(E)=$ false and $I\left(E_{c g}\right)$ is false.
conjectural graph: If we are dealing with a conjectural graph as the object of conj : collapses:
- let $E$ be a conjectural graph $\left\{\begin{array}{llll}s_{0} & c p_{0} & o_{0} & .\end{array}\right.$

Let's check once again if the interpretation can be a model for our last example.
We define the sets:

- $I R=\{a 1, h, c c 5, w s, i a c f, c, c o a 1, c 5 w a t, s j, p w a t, c 5 c l, c l, p w i b, u r l, c c o a 1\}$
- IP $=\{c, i a c f, p w a t, p w i b, c l\}$
- IPC $=\{c c 5, c 5 w a t, c 5 c l\}$

The functions:

- IS $(:$ attribution 01$) \rightarrow a 1$
- IS (: Hamlet $) \rightarrow h$
- IS (conj005 : creator $) \rightarrow c c 5$
- IS $(:$ WilliamShakespeare $) \rightarrow$ ws
- IS (conj : isAConjecturalFormOf) $\rightarrow i a c f$
- IS $(d c:$ creator $) \rightarrow c$
- IS $(:$ collapseOf Attribution 01$) \rightarrow$ coa 1
- IS (conj005 : wasAttributedTo) $\rightarrow$ c5wat
- IS $(:$ SamuelJohnson $) \rightarrow$ sj
- IS (prov : wasAttributedTo) $\rightarrow$ pwat
- IS (conj005 : collapses $) \rightarrow c 5 c l$
- IS (conj : collapses) $\rightarrow c l$
- IS (prov: wasInformedBy) $\rightarrow$ pwib

Let's check now the rules. We focus the check on the cascading collapses only.
We need to proceed in steps. The first conj : collapses in our final collapse graph has : attribution01 as its object. We can consider : attribution 01 as a single triple, as it contains only one conjecture:

- is $c c 5 \in I P C$ ? Yes;
- is $c \in I P$ ? Yes;
- is $C O N J F O R M(c)=c c 5$ ? Yes;
- is the pair $<h, w s>\in I E X T C(c c 5)$ ? Yes;
- is the pair $<h, w s>\in \operatorname{IEXT}(c)$ ? Yes;
- is $c l \in I P$ ? Yes;
- the pair $<a 1$, coa1 $>\in I E X T(c l)$ ?Yes.

It seems to hold.
Let's get to the second con : collapses of our final collapse graph. It has : collapseOfAttribution 01 as its object. It is a graph. Let's apply rules for the graphs:

- c5wat, c5cl $\in I P C$ ? Yes;
- pwat, cl $\in I P$ ? Yes;
- CONJFORM $(c 5 w a t)=$ pwat $; C O N J F O R M(c 5 c l)=c l$ ? Yes;
- <a1, sj $>\in I E X T C(c 5 w a t)$ ? Yes; $<a 1$, coa1 $>\in \operatorname{IEXTC}(c 5 c l)$ ? Yes;
- <a1, sj) $>\in I E X T(p w a t)$ ? Yes; $<a 1$, coa $1>\in I E X T(c l)$ ? Yes;
- $c l \in I P$ ? Yes;
- the pair $<a 1$, coa 1$)>\in I E X T(c l)$ ? Yes

It can be easily verified that all the other triples of the example can be satisfied by the interpretation [I + COLLAPSE]. Our interpretation is a model of the graph.

## 9 Conclusions

In this paper we have attempted to build a formal representation of the semantics of the conjectures.
We have started with the formal model and extended the simple interpretation and model of RDF 1.1.
Then we have explored the key features of the conjectures and verified that they fit in the semantics, expanding it when needed.

The conjectures allow to express concepts whose truth value is unknown, without asserting it, something that is currently missing in RDF.

With this work we have demonstrated that, with a somewhat limited extension to its model, it is possibile to add this powerful feature to RDF 1.1.
