# A Sum of Squares Characterization of Perfect Graphs

#### Abstract

We present an algebraic characterization of perfect graphs, i.e., graphs for which the clique number and the chromatic number coincide for every induced subgraph. We show that a graph is perfect if and only if certain nonnegative polynomials associated with the graph are sums of squares. As a byproduct, we obtain several infinite families of nonnegative polynomials that are not sums of squares through graph-theoretic constructions. We also characterize graphs for which the associated polynomials belong to certain structured subsets of sum of squares polynomials. Finally, we reformulate some well-known results from the theory of perfect graphs as statements about sum of squares proofs of nonnegativity of certain polynomials.


Keywords: Nonnegative and sum of squares polynomials, perfect graphs, matrix copositivity, semidefinite programming, convex relaxations for the clique number.

## 1 Introduction

A graph is perfect if for any of its induced subgraphs, the chromatic number equals the cardinality of a largest clique. Perfect graphs, introduced by Berge in 1960, have elegant theoretical properties and curious connections with linear, integer, and semidefinite programming. For instance, perfect graphs appear in the study of exactness of linear programming relaxations of integer programs. As an example, for a matrix $A \in\{0,1\}^{m \times n}$, all vertices of the polytope $\left\{x \in \mathbb{R}^{n}: A x \leq 1, x \geq 0\right\}$ are integral if and only if the undominated rows of $A$ are the incidence vectors of the maximal cliques of a perfect graph [17, [19]. Moreover, several combinatorial problems that are NP-hard on general graphs can be solved efficiently on perfect graphs using semidefinite programming [37]. Examples include the maximum independent set and the minimum clique cover problems. More generally, perfect graphs have been the subject of much research in recent decades due to the fact that they are at the crossroad of several mathematical disciplines, including graph theory, information theory, combinatorial optimization, polyhedral and convex geometry, and semidefinite programming [19, 22, 31, 37, 38, 50, 36].

The second notion of interest to this paper is that of sum of squares polynomials. A polynomial is a sum of squares (sos) if it can be written as a sum of squares of some other polynomials. There has been a growing interest in sos polynomials recently due to the fact that they provide semidefinite programmingbased sufficient conditions for problems involving nonnegative polynomials. It is well known that several important problems in applied and computational mathematics can be formulated as optimization problems over the set of nonnegative polynomials. Although these problems are generally intractable to solve exactly, they can be efficiently approximated by replacing nonnegativity constraints with sum of squares requirements. By connecting ideas from real algebraic geometry and semidefinite programming, sum of squares polynomials have significantly impacted both discrete and continuous optimization over the last two decades; see, e.g., [42, 59, 8, 43, 39, 44 .

[^0]In this work, we introduce and study the notion of sos-perfectness, a notion that brings together perfect graphs and sos polynomials. For a graph $G=(V, E)$ with clique number $\omega(G)$, we define the following quartic (homogeneous) polynomial in the variables $x=\left(x_{1}, \ldots, x_{|V(G)|}\right)^{T}$ :

p_{G}(x):=-2 \omega(G) \sum_{i j \in E(G)} x_{i}^{2} x_{j}^{2}+(\omega(G)-1)\left(\sum_{i=1}^{|V(G)|} x_{i}^{2}\right)^{2} . \tag{1}
\end{equation*}

It turns out that for every graph $G$, the polynomial $p_{G}(x)$ is nonnegative by construction. We say that a graph $G$ is sos-perfect if $p_{H}(x)$ is sos for every induced subgraph $H$ of $G$. In this paper, we prove the following theorem.

Theorem 1.1. A graph is perfect if and only if it is sos-perfect.
The remainder of this paper is organized as follows. In Section 2, we recall some definitions and results related to perfect graphs and sos polynomials. In Section 3, we prove Theorem 1.1. Our proof brings together a number of interesting results in graph theory and conic optimization. In Section 4, we focus on the connection between imperfect graphs and nonnegative polynomials that are not sos. In Sections 4.1 and 4.2, we provide several infinite families of nonnegative polynomials that are not sos through various graph-theoretic constructions. In Section 4.3, by building on previous results on the probable values of certain parameters associated with Erdős-Rényi random graphs $G_{n, p}$, we show that for a fixed parameter $p$ and for large enough $n$, the polynomial $p_{G_{n, p}}(x)$ is nonnegative but not sos with high probability. In Section 4.4 we provide an explicit hyperplane that separates a given non-sos polynomial $p_{G}(x)$ from the set of sos polynomials. In Section 4.5, we show that an example of a convex nonnegative polynomial that is not sos cannot arise from our graph-theoretic constructions. (The construction of such a polynomial was an open problem until recently [66]). In Section [5, we examine certain subsets of sos polynomials which admit a linear or second-order cone representation [2], or a more restricted semidefinite representation. We study the bounds that optimization over these subsets produces on the clique number of a graph, and characterize the graphs for which these bounds are tight for all induced subgraphs. Finally, in Section 6, we reformulate a number of results from the theory of perfect graphs as statements about sum of squares proofs of nonnegativity of certain polynomials. Our hope is that our reformulations will lead to more connections between structural graph theory and real algebraic geometry, and ideally to an algebraic proof of the "strong perfect graph theorem".

## 2 Preliminaries

A (multivariate) polynomial $p(x)$ in variables $x:=\left(x_{1}, \ldots, x_{n}\right)^{T}$ is a function from $\mathbb{R}^{n}$ to $\mathbb{R}$ that is a finite linear combination of monomials:

p(x)=\sum_{\alpha} c_{\alpha} x^{\alpha}=\sum_{\alpha_{1}, \ldots, \alpha_{n}} c_{\alpha_{1}, \ldots, \alpha_{n}} x_{1}^{\alpha_{1}} \ldots x_{n}^{\alpha_{n}},
$$

where the sum is over $n$-tuples of nonnegative integers $\alpha_{i}$. The degree of a monomial $x^{\alpha}$ is equal to $\alpha_{1}+\cdots+\alpha_{n}$. The degree of a polynomial $p(x)$ is defined to be the highest degree of its monomials. A form (or a homogeneous polynomial) is a polynomial where all the monomials have the same degree.

We denote the set of real symmetric $n \times n$ matrices by $S_{n}$. A matrix $M \in S_{n}$ is positive semidefinite (psd) if $x^{T} M x \geq 0$ for all $x \in \mathbb{R}^{n}$, and nonnegative if the entries of $M$ are all nonnegative. We write $M \succeq 0$ if $M$ is psd, and $M \geq 0$ if $M$ is nonnegative. We denote the set of $n \times n$ psd (resp. nonnegative) matrices by $S_{n}^{+}$(resp. $N_{n}$ ). The trace of $M$ is denoted by $\operatorname{Tr}(M)$.

All graphs in this paper are undirected, finite, and simple (i.e., have no loops or parallel edges). Throughout the paper, $G=(V, E)$ denotes a graph with vertex set $V(G)$ and edge set $E(G)$. The
complement of a graph $G$, denoted by $\bar{G}$, is the graph with vertex set $V(G)$ and edge set consisting of all distinct pairs of vertices that are not adjacent in $G$. The matrices $A$ and $\bar{A}$ respectively denote the adjacency matrices of $G$ and $\bar{G}$. The matrices $I$ and $J$ respectively denote the identity matrix and the all-ones matrix. Observe that $A+\bar{A}+I=J$.

A graph $H$ is an induced subgraph of a graph $G$ if $V(H) \subseteq V(G)$ and any two vertices of $H$ are adjacent if and only if they are adjacent in $G$. We say that $G$ contains a graph $H$ if $G$ has an induced subgraph isomorphic to $H$, and that $G$ is $H$-free if it does not contain $H$. For an integer $k \geq 4$, a hole (of length $k$ ) is a graph isomorphic to the chordless $k$-vertex cycle $C_{k}$, and an antihole (of length $k$ ) is a graph isomorphic to $\bar{C}_{k}$. A hole (or an antihole) is odd if its length is odd.

A clique in a graph is a set of pairwise adjacent vertices, and an independent set is a set of pairwise non-adjacent vertices. The clique number of a graph $G$, denoted by $\omega(G)$, is the size of a maximum clique in $G$, and the independence number of $G$, denoted by $\alpha(G)$, is the size of a maximum independent set in $G$. The chromatic number of a graph $G$, denoted by $\chi(G)$, is the smallest number of independent sets of $G$ with union $V(G)$. Every graph $G$ clearly satisfies $\chi(G) \geq \omega(G)$. The inequality, however, may be strict. For instance, if $G$ is an odd hole, it is easy to see that $\omega(G)=2$ and $\chi(G)=3$. Similarly, if $G$ is an odd antihole of length $2 k+1$ for some $k \geq 2$, then $\omega(G)=k$ and $\chi(G)=k+1$.

### 2.1 Perfect graphs

A graph $G$ is perfect if every induced subgraph $H$ of $G$ satisfies $\chi(H)=\omega(H)$. Berge introduced perfect graphs and made two conjectures [4]. The first, proved by Lovász [48] and now known as the weak perfect graph theorem, states that a graph is perfect if and only if its complement is perfect. Berge's second conjecture characterizes minimal imperfect graphs. A graph $G$ is minimal imperfect if $G$ is not perfect but every proper induced subgraph of $G$ is perfect. Berge observed that odd holes and odd antiholes are minimal imperfect graphs, and conjectured that they are, in fact, the only minimal imperfect graphs. This conjecture, now known as the strong perfect graph theorem, was proved by Chudnovsky, Robertson, Seymour, and Thomas [18]: A graph is perfect if and only if it does not contain an odd hole or an odd antihole. Indeed, since odd holes and odd antiholes satisfy $\chi(G)=\omega(G)+1$, perfect graphs do not contain odd holes or odd antiholes. The proof of the converse direction is long and relies on structural graph theory.

The theta number of a graph $G$, introduced by Lovász [50] and denoted by $\vartheta(G)$, is given as the optimal value of the following semidefinite program:

\text { s.t. } & X_{i j}=0 \quad \text { if } i j \in E  \tag{2}\\
& \operatorname{Tr}(X)=1 \\

Grötschel, Lovász, and Schrijver [37] showed that the theta number of the complement of a graph is sandwiched between the clique number and the chromatic number of the graph, that is, for any graph $G$, we have $\omega(G) \leq \vartheta(\bar{G}) \leq \chi(G)$. Since $\vartheta(\bar{G})$ can be computed with arbitrary precision in polynomial time via the semidefinite program (2), one of the consequences of this result is that for a perfect graph $G$, the clique number of $G$ can be computed in polynomial time.

A strengthening of the theta number was introduced by McEliece et al. [52] and Schrijver [67], where an entry-wise nonnegativity constraint on the matrix $X$ is added to (2):

Schrijver [67] observed that $\vartheta^{\prime}(\bar{G})$, too, is an upper bound on $\omega(G)$, that is, for any graph $G$, we have

$$
\begin{equation*}
\omega(G) \leq \vartheta^{\prime}(\bar{G}) \leq \vartheta(\bar{G}) \leq \chi(G) \tag{4}
\end{equation*}
$$

### 2.2 Sum of squares polynomials

A polynomial $p: \mathbb{R}^{n} \rightarrow \mathbb{R}$ with real coefficients is nonnegative if $p(x) \geq 0$ for all $x \in \mathbb{R}^{n}$ and a sum of squares (sos) if there exist polynomials $q_{1}(x), \ldots, q_{m}(x)$ such that $p(x)=\sum_{i=1}^{m} q_{i}^{2}(x)$. While every sos polynomial is clearly nonnegative, Hilbert showed in 1888 that there exist nonnegative polynomials that are not sos [41]. His proof was not constructive and did not lead to an explicit example of a nonnegative polynomial that is not sos. The first examples of such polynomials were found by Motzkin [53] and Robinson [65] nearly eighty years after Hilbert's proof.

From a complexity standpoint, testing nonnegativity of polynomials of any fixed degree $2 d \geq 4$ is NP-hard [55]. By contrast, checking whether a polynomial is sos can be done by solving a semidefinite program. Indeed, a polynomial $p(x)$ in $n$ variables and of degree $2 d$ is sos if and only if there exists a psd matrix $Q$ such that $p(x)=z(x)^{T} Q z(x)$, where $z(x)$ is the vector of monomials of degree up to $d$, i.e., $z(x)=\left(1, x_{1}, \ldots, x_{n}, x_{1} x_{2}, \ldots, x_{n}^{d}\right)^{T}$ (see, e.g., [16, 58]). In fact, this statement leads to a semidefinite programming-based approach for optimizing a linear function over the intersection of the set of sos polynomials with an affine subspace. This observation has enabled wide-ranging applications, see, e.g., [39].

## 3 A Sum of Squares Characterization of Perfect Graphs

In this section, we prove Theorem 1.1 by establishing a few intermediary lemmas. We begin by stating some relevant results from prior literature.

A matrix $M \in S_{n}$ is copositive if $x^{T} M x \geq 0$ for all $x \geq 0$ (i.e., for all vectors $x$ in the nonnegative orthant). We denote the set of $n \times n$ copositive matrices by $C_{n}$. It is not difficult to observe that minimization of a quadratic function over the standard simplex $\Delta:=\left\{x \in \mathbb{R}^{n}: \sum_{i=1}^{n} x_{i}=1, x \geq 0\right\}$ is equivalent to optimization of a linear function over $C_{n}$ (see, e.g., [26, 10]):

$$
\begin{array}{rl}
\min _{x \in \Delta} x^{T} Q x=\max _{k \in \mathbb{R}} & k  \tag{5}\\
\text { s.t. } & Q-k J \in C_{n} .
\end{array}
$$

As shown by Motzkin and Straus [54], the problem on the left can be related to the clique number of a graph as follows:

$$
\begin{equation*}
\frac{1}{\omega(G)}=\min _{x \in \Delta} x^{T}(I+\bar{A}) x \tag{6}
\end{equation*}
$$

Here, $\bar{A}$ denotes the adjacency matrix of the complement graph $\bar{G}$. It follows from (5) and (6) that

$$
\begin{align*}
\omega(G)= & \min _{k \in \mathbb{R}}  \tag{7}\\
& k \\
& \text { s.t. } \\
& k(I+\bar{A})-J \in C_{n} .
\end{align*}
$$

It is easy to see that a matrix $M$ belongs to $C_{n}$ if and only if the quartic form

$$
\begin{equation*}
p_{M}(x):=\sum_{i, j=1}^{n} M_{i j} x_{i}^{2} x_{j}^{2} \tag{8}
\end{equation*}
$$

is nonnegative. Let $K_{n}$ denote the set of matrices $M \in S_{n}$ such that $p_{M}(x)$ is sos. Clearly, $K_{n} \subseteq C_{n}$. Hence, a tractable upper bound on $\omega(G)$ can be obtained by replacing $C_{n}$ in (7) with $K_{n}$. Using in part a result from [58, Section 5] (see also [13, Lemma 3.5]), De Klerk and Pasechnik [26] showed that the resulting upper bound coincides with the parameter $\vartheta^{\prime}(\bar{G})$ defined in (3):

& \text { s.t. } & k(I+\bar{A})-J \in K_{n} .
\end{array}

The following lemma sheds light on the construction of the polynomial $p_{G}(x)$ in (1), and a corollary of it will be used in the proof of Theorem 1.1. Let us consider a more general family of quartic forms by replacing the constant $\omega(G)$ in $p_{G}(x)$ with an arbitrary scalar $k \in \mathbb{R}$ :

\begin{equation*}
p_{G, k}(x):=-2 k \sum_{i j \in E(G)} x_{i}^{2} x_{j}^{2}+(k-1)\left(\sum_{i=1}^{|V(G)|} x_{i}^{2}\right)^{2} \tag{10}
\end{equation*}
$$

Lemma 3.1. For any graph $G$,
(a) the polynomial $p_{G, k}(x)$ is nonnegative if and only if $k \geq \omega(G)$.
(b) the polynomial $p_{G, k}(x)$ is sos if and only if $k \geq \vartheta^{\prime}(\bar{G})$.

Proof. Let $G=(V, E)$ be a graph with $|V(G)|=n$ and with adjacency matrix $A$. We first claim that the polynomial $p_{G, k}(x)$ is nonnegative if and only if $k(I+\bar{A})-J \in C_{n}$. Observe that since $I+\bar{A}=J-A$, we have $k(I+\bar{A})-J=-k A+(k-1) J$. Therefore,

k(I+\bar{A})-J \in C_{n} & \Longleftrightarrow \sum_{i, j=1}^{n}[-k A+(k-1) J]_{i j} x_{i}^{2} x_{j}^{2} \geq 0 \quad \forall x \in \mathbb{R}^{n} \\
& \Longleftrightarrow-k \sum_{i, j=1}^{n} A_{i j} x_{i}^{2} x_{j}^{2}+(k-1) \sum_{i, j=1}^{n} J_{i j} x_{i}^{2} x_{j}^{2} \geq 0 \quad \forall x \in \mathbb{R}^{n} \\
& \Longleftrightarrow-2 k \sum_{i j \in E(G)} x_{i}^{2} x_{j}^{2}+(k-1)\left(\sum_{i=1}^{n} x_{i}^{2}\right)^{2} \geq 0 \quad \forall x \in \mathbb{R}^{n} \\
& \Longleftrightarrow p_{G, k}(x) \geq 0 \quad \forall x \in \mathbb{R}^{n}
\end{aligned}
$$

Similarly, $k(I+\bar{A})-J \in K_{n}$ if and only if $p_{G, k}(x)$ is sos. Hence, by (7) and (9), we obtain the following formulations of $\omega(G)$ and $\vartheta^{\prime}(\bar{G})$ :

\begin{array}{rll}
\omega(G)= & \min _{k \in \mathbb{R}} & k \\
& \text { s.t. } \quad p_{G, k}(x) \text { is nonnegative, }
\end{array}
$$

$$
\begin{array}{rll}
\vartheta^{\prime}(\bar{G})= & \min _{k \in \mathbb{R}} & k \\
& \text { s.t. } & p_{G, k}(x) \text { is sos. }
\end{array}
$$

Therefore, if $p_{G, k}(x)$ is nonnegative, then $k \geq \omega(G)$. Similarly, if $p_{G, k}(x)$ is sos, then $k \geq \vartheta^{\prime}(\bar{G})$. Observe also that if $p_{G, k}(x)$ is nonnegative (resp. sos) for some $k \in \mathbb{R}$, then $p_{G, k^{\prime}}(x)$ is nonnegative (resp. sos) for every $k^{\prime} \in \mathbb{R}$ with $k^{\prime} \geq k$. This is simply because

$$
\left(k^{\prime}(I+\bar{A})-J\right)-(k(I+\bar{A})-J)=\left(k^{\prime}-k\right)(I+\bar{A})
$$

is a nonnegative matrix, thus belongs to $C_{n}$ (resp. $K_{n}$ ). It follows that $p_{G, k}(x)$ is nonnegative if and only if $k \geq \omega(G)$, and that $p_{G, k}(x)$ is sos if and only if $k \geq \vartheta^{\prime}(\bar{G})$.

Corollary 3.2. For any graph $G$,
(a) the polynomial $p_{G}(x)$ is nonnegative.
(b) the polynomial $p_{G}(x)$ is sos if and only if $\omega(G)=\vartheta^{\prime}(\bar{G})$.

Proof. Part (a) follows from Lemma 3.1(园) since $p_{G}(x)=p_{G, \omega(G)}(x)$, and part (b) follows from Lemma 3.1(b) and (4).

We refer the reader to the recent work of Laurent and Vargas [46] where the equality between $\omega(G)$ and $\vartheta^{\prime}(\bar{G})$ is studied for graphs with $\omega(G) \leq 2$ and for the complements of the so-called " $\alpha$-critical" graphs. (See also [45, 47] for a related study of a hierarchy of semidefinite programming-based inner approximations for $C_{n}$, whose first level corresponds to $K_{n}$.)
Remark 1. In the statement of Corollary 3.2(b), one cannot replace the quantity $\vartheta^{\prime}(\bar{G})$ with the theta number $\vartheta(\bar{G})$. For example, let $G$ be the graph on 64 vertices corresponding to the vectors in $\{0,1\}^{6}$, with two vertices adjacent if and only if the Hamming distance between the corresponding vectors is at least 4. We have $\omega(G)=\vartheta^{\prime}(\bar{G})=4$ and $\vartheta(\bar{G})=16 / 3$; see [67]. Therefore, $p_{G}(x)$ is sos by Corollary 3.2(b), but $\omega(G) \neq \vartheta(\bar{G})$.
Remark 2. Corollary 3.2(b) characterizes the graphs $G$ for which the polynomial $p_{G}(x)$ is sos. We note that the condition $\omega(G)=\vartheta^{\prime}(\bar{G})$ is not enough for a graph $G$ to be perfect. In fact, even the condition $\omega(G)=\chi(G)$ is not enough for $G$ to be perfect since perfectness requires this condition to hold for every induced subgraph. As an example, let $G$ be the graph with vertex set $\left\{v_{1}, v_{2}, v_{3}, v_{4}, v_{5}, h\right\}$ and edge set $\left\{v_{1} v_{2}, v_{2} v_{3}, v_{3} v_{4}, v_{4} v_{5}, v_{5} v_{1}, h v_{1}, h v_{2}\right\}$, i.e., $G$ is the graph $C_{5}$ with an additional vertex $h$ adjacent only to $v_{1}$ and $v_{2}$. Then, it is easy to verify that $\omega(G)=\chi(G)=3$. However, $G$ is not perfect as it contains the graph $C_{5}$, for which we have $2=\omega\left(C_{5}\right)<\chi\left(C_{5}\right)=3$. Observe also that this graph $G$ is an example of an imperfect graph for which $p_{G}(x)$ is sos. This observation justifies our definition of sos-perfectness which takes induced subgraphs into consideration. Indeed, if $G$ is a perfect graph, then, by definition, every induced subgraph of $G$ is perfect. However, being sos is not a "hereditary" property in the sense that it is possible for the polynomial $p_{G}(x)$ to be sos and for $G$ to have an induced subgraph $H$ with $p_{H}(x)$ not sos. The graph above with $H=C_{5}$ provides one such example.

Although the condition " $\omega(G)=\vartheta^{\prime}(\bar{G})$ " is not sufficient for a graph $G$ to be perfect, we prove next that the condition " $\omega(H)=\vartheta^{\prime}(\bar{H})$ for every induced subgraph $H$ of $G$ " is. We follow a proof technique of Lovász [51] which makes use of a binary matrix associated with the maximum cliques of a graph. Let $G$ be a graph with $n$ vertices and $m$ maximum cliques. Then, the max-clique matrix $C$ of $G$ is an $m \times n$ matrix with $C_{i j}=1$ if the $i^{t h}$ maximum clique contains the $j^{\text {th }}$ vertex, and $C_{i j}=0$ otherwise. As an example, the max-clique matrix of the graph $C_{5}$ is given in Figure $\mathbb{1}$

Lemma 3.3. If $G$ is a minimal imperfect graph, then $\omega(G)<\vartheta^{\prime}(\bar{G})$.
Proof. We follow a proof of Lovász's (see Lemma 7.9 in [51, Section 3]). Let $G=(V, E)$ be a minimal imperfect graph with $|V(G)|=n$ and with clique number $\omega$. Let $C$ be the max-clique matrix of $G$. By a result of Padberg [57] (see also [32] for a different proof), $G$ has $n$ maximum cliques, every vertex of $G$ is in exactly $\omega$ maximum cliques, and the matrix $C$ is non-singular.

Figure 1: The graph $C_{5}$ and its max-clique matrix $C$
Let $\lambda_{1}$ be the smallest eigenvalue of $C^{T} C$. Observe that the diagonal entries of $C^{T} C$ are all $\omega$. It is then not difficult to see that $\lambda_{1} \in(0, \omega)$. Indeed, since $C^{T} C$ is psd and since $\operatorname{Tr}\left(C^{T} C\right)=n \omega$, we have $\lambda_{1} \in[0, \omega]$. Also, we have $\lambda_{1} \neq 0$ since $C$ is non-singular, and $\lambda_{1} \neq \omega$ as otherwise all eigenvalues of $C^{T} C$ would equal $\omega$, in which case $C^{T} C=\omega I$. This is a contradiction since a minimal imperfect graph has at least one edge.

Now recall that

$$
\begin{align*}
\vartheta^{\prime}(\bar{G})=\max _{X \in S_{n}} & \operatorname{Tr}(J X) \\
\text { s.t. } & X_{i j}=0 \quad \text { if } \quad \text { ij } \notin E(G) \\
& \operatorname{Tr}(X)=1  \tag{11}\\
& X \succeq 0 \\
& X \geq 0 .
\end{align*}
$$

Consider the matrix $X=\frac{1}{n\left(\omega-\lambda_{1}\right)}\left(C^{T} C-\lambda_{1} I\right)$. It is straightforward to check that $X$ is a feasible solution to (11), and that

$$
\vartheta^{\prime}(\bar{G}) \geq \operatorname{Tr}(J X)=\frac{\omega^{2}-\lambda_{1}}{\omega-\lambda_{1}}>\omega
$$

Corollary 3.4. A graph $G$ is perfect if and only if $\omega(H)=\vartheta^{\prime}(\bar{H})$ for every induced subgraph $H$ of $G$.
Proof. If $G$ is perfect, then by definition, $\omega(H)=\chi(H)$ for every induced subgraph $H$ of $G$. Hence, by (4), we have $\omega(H)=\vartheta^{\prime}(\bar{H})$ for every induced subgraph $H$ of $G$. If $G$ is not perfect, then it contains a minimal imperfect graph $H_{\star}$. By Lemma 3.3, $\omega\left(H_{\star}\right)<\vartheta^{\prime}\left(\bar{H}_{\star}\right)$.

We are now ready to present the proof of Theorem 1.1, which we restate here for ease of reference.
Theorem 1.1. A graph is perfect if and only if it is sos-perfect.
Proof. By Corollary 3.4, a graph $G$ is perfect if and only if $\omega(H)=\vartheta^{\prime}(\bar{H})$ for every induced subgraph $H$ of $G$, which by Corollary 3.2 holds if and only if $p_{H}(x)$ is sos for every induced subgraph $H$ of $G$.

Remark 3. It is known that if $G$ is an odd hole or an odd antihole, then $\omega(G)<\vartheta^{\prime}(\bar{G})$ (see, e.g., Proposition 15 and Proposition 19 in [62], or see [26, 45, 46]). 1 Hence, assuming the strong perfect graph theorem, one can bypass Lemma 3.3 in the proof of Theorem 1.1. Indeed, if a graph $G$ is not perfect, then by the strong perfect graph theorem, it contains either an odd hole or an odd antihole, call it $H$. Since $\omega(H)<\vartheta^{\prime}(\bar{H})$, by Corollary 3.2(b), the polynomial $p_{H}(x)$ is not sos. Therefore, $G$ is not sos-perfect. However, we purposefully want to avoid the use of the highly-nontrivial strong perfect graph theorem in the proof of Theorem 1.1. Indeed, our hope is that Theorem 1.1 could lead to an algebraic proof of the strong perfect graph theorem in the future (see Section 6.1).

## 4 Nonnegative Polynomials That Are Not Sums of Squares

As mentioned in Section 2.2, Hilbert proved the existence of nonnegative polynomials that are not sums of squares in [41], while the first examples of such polynomials were constructed by Motzkin 53 ] and Robinson 65] many years later. Many other examples have appeared in the literature over the years; see, e.g., [64, 13, 14, 15]. Understanding the distinction between nonnegative polynomials and sos polynomials is an active area of research. In relatively low degrees and dimensions, constructing examples of nonnegative polynomials that are not sos seems to be a nontrivial task.

In Section 4.1, we provide several infinite families of nonnegative polynomials that are not sos through various families of imperfect graphs. In Section 4.2, we describe certain operations on graphs that allow us to generate more nonnegative polynomials that are not sos starting from existing ones. In Section 4.3, by appealing to the literature on random graph theory, we show that for a fixed parameter $p$ and for large enough $n$, the polynomial $p_{G_{n, p}}(x)$ associated with the Erdős-Rényi random graph $G_{n, p}$ is nonnegative but not sos with high probability. In Section 4.4, we provide an explicit hyperplane that separates a given non-sos polynomial $p_{G}(x)$ from the set of sos polynomials. Finally, in Section 4.5, we show that an example of a convex nonnegative polynomial that is not sos cannot arise from our graph-theoretic constructions. The construction of such a polynomial was an open problem until recently [66].

### 4.1 From imperfect graphs to nonnegative polynomials that are not sos

### 4.1.1 Odd holes and odd antiholes

Recall that odd holes and odd antiholes are minimal imperfect graphs, i.e., they are not perfect but their proper induced subgraphs are all perfect. Hence, by Lemma 3.3 and Corollary 3.2, for every odd hole and odd antihole $G$, the polynomial $p_{G}(x)$ is a nonnegative polynomial that is not sos. This yields an infinite family of degree- 4 polynomials that are nonnegative but not sos. As an example, consider the smallest minimal imperfect graph $C_{5}$ and the corresponding polynomial $p_{C_{5}}(x)$ :

$$
p_{C_{5}}(x)=-4\left(x_{1}^{2} x_{2}^{2}+x_{2}^{2} x_{3}^{2}+x_{3}^{2} x_{4}^{2}+x_{4}^{2} x_{5}^{2}+x_{1}^{2} x_{5}^{2}\right)+\left(x_{1}^{2}+x_{2}^{2}+x_{3}^{2}+x_{4}^{2}+x_{5}^{2}\right)^{2} .
$$

This polynomial is known as the "Horn form" in the sos community (see [64]). Similarly, the polynomials $p_{C_{7}}(x), p_{C_{9}}(x), \ldots, p_{\bar{C}_{7}}(x), p_{\bar{C}_{9}}(x), \ldots$ are all nonnegative but not sos. We recall that for $m \geq 2$, we have $\omega\left(C_{2 m+1}\right)=2$ and $\omega\left(\overline{C_{2 m+1}}\right)=m$, and therefore it is immediate to explicitly write down the polynomial $p_{G}(x)$ when $G$ is an odd hole or an odd antihole.

Odd holes are a special case of the so-called $\alpha$-critical graphs, i.e., graphs for which the removal of any edge increases the stability number. It follows from [46, Corollary 5.3.] that if $G$ is the complement of an $\alpha$-critical graph and not complete multipartite (see Section 5.1 for the definition), then $\omega(G)<\vartheta^{\prime}(\bar{G})$. Therefore, the fact that odd antiholes yield nonnegative polynomials that are not sos also follows from [46, Corollary 5.3.].

### 4.1.2 Powers of cycles and their complements

The conclusion of Lemma 3.3 holds for a more general class of graphs than minimal imperfect graphs. A graph $G$ is called partitionable (or an ( $\alpha, \omega$ )-graph) if there exist integers $\alpha \geq 2$ and $\omega \geq 2$ such that $|V(G)|=\alpha \omega+1$, and for every vertex $v$, there is a partition of $V(G) \backslash\{v\}$ into $\alpha$ many cliques of size $\omega$ and $\omega$ many independent sets of size $\alpha$. Using only elementary linear algebra, the authors in [5] show that every partitionable graph $G$ with $n$ vertices has $n$ maximum cliques, every vertex of $G$ is in exactly $\omega(G)$ maximum cliques, and the max-clique matrix $C$ of $G$ is non-singular. Notice that these were the only properties of minimal imperfect graphs that were used to prove Lemma 3.3. Hence, the same proof implies that if $G$ is a partitionable graph, then $\omega(G)<\vartheta^{\prime}(\bar{G})$. Consequently,
by Corollary 3.2, partitionable graphs provide an infinite family of polynomials that are nonnegative but not sos.

It can be shown that a minimal imperfect graph $G$ is partitionable with $\alpha=\alpha(G)$ and $\omega=\omega(G)$. There are, however, many other partitionable graphs; see, e.g., 60, 61] for Cayley partitionable graphs, and [20] for other constructions of partitionable graphs. The simplest examples are "powers" of cycles. The $k^{\text {th }}$ power of a graph $G$, denoted by $G^{k}$, is a graph with the same vertex set as $G$, and with two vertices adjacent if and only if their distanct ${ }^{2}$ in $G$ is at most $k$. For every integer $\alpha \geq 2$ and $\omega \geq 2$, the graph $C_{\alpha \omega+1}^{\omega-1}$ is a partitionable graph; see [20]. Notice that if $\omega=2$, then the graphs $C_{\alpha \omega+1}^{\omega-1}=C_{2 \alpha+1}$ are precisely odd holes, and if $\alpha=2$, then the graphs $C_{\alpha \omega+1}^{\omega-1}=C_{2 \omega+1}^{\omega-1}=\overline{C_{2 \omega+1}}$ are precisely odd antiholes. However, for $\alpha, \omega \geq 3$, we obtain several other partitionable graphs that are not odd holes or odd antiholes, such as $C_{10}^{2}, C_{13}^{2}, C_{13}^{3}, C_{16}^{2}, C_{16}^{4}, C_{17}^{3}, \ldots$. Moreover, it is clear from the definition that a graph is partitionable if and only if its complement is partitionable. Hence, for $\alpha \geq 2$ and $\omega \geq 2$, both $C_{\alpha \omega+1}^{\omega-1}$ and $\overline{C_{\alpha \omega+1}^{\omega-1}}$ provide infinite families of graphs whose associated polynomials are nonnegative but not sos. We remark that the clique number of $C_{\alpha \omega+1}^{\omega-1}$ is $\omega$ and the clique number of $\overline{C_{\alpha \omega+1}^{\omega-1}}$ is $\alpha$, and therefore it is immediate to explicitly write down the polynomial $p_{G}(x)$ when $G$ is the graph $C_{\alpha \omega+1}^{\omega-1}$ or $\overline{C_{\alpha \omega+1}^{\omega-1}}$.

### 4.1.3 Paley graphs

Paley graphs are graphs constructed from the elements of certain finite fields by connecting pairs of elements that differ by a quadratic residue. More precisely, for a prime number ${ }^{3} q$ with $q \equiv 1(\bmod 4)$, the Paley graph $P_{q}$ is the graph with vertices the elements of the finite field $F_{q}$, which can be represented by integers $0,1, \ldots, q-1$, and an edge between two vertices $x$ and $y$ if and only if $x-y=a^{2}$ for some nonzero element $a \in F_{q}$. Paley graphs have been extensively studied due to their interesting symmetry properties. In particular, Paley graphs are self-complementary and edge-transitive (see, e.g., 9 for these and other properties of Paley graphs). See Figure 2 for two examples of Paley graphs.


Figure 2: The Paley graphs on 5 and 13 vertices
Let $G$ be an edge-transitive graph and let $\lambda_{\text {max }}$ and $\lambda_{\text {min }}$ respectively denote the largest and smallest eigenvalues of its adjacency matrix. It is shown in [35, Corollary 5.3] that

$$
\vartheta^{\prime}(\bar{G})=\vartheta(\bar{G})=1-\frac{\lambda_{\max }}{\lambda_{\min }}
$$

Since the Paley graph $P_{q}$ is edge-transitive and the distinct eigenvalues of its adjacency matrix are known to be $\frac{1}{2}(q-1), \frac{1}{2}(\sqrt{q}-1)$ (see, e.g., [12, Proposition 9.1.1]), and $\frac{1}{2}(-\sqrt{q}-1)$, it follows that $\vartheta^{\prime}\left(\overline{P_{q}}\right)=\sqrt{q}$. In particular, for a prime number $q \equiv 1(\bmod 4)$, as $\sqrt{q}$ is not an integer, we have $\omega\left(P_{q}\right)<\vartheta^{\prime}\left(\overline{P_{q}}\right)$. Therefore, by Corollary 3.2, the polynomial $p_{P_{q}}(x)$ is nonnegative but not sos. Thus,

[^2]for primes $q \equiv 1(\bmod 4)$, the family of Paley graphs $P_{q}$ yields another infinite family of polynomials that are nonnegative but not sos $4^{4}$

Although the clique number of Paley graphs is in general not known, an upper bound was recently given in [40] for any prime number $q$ :

$$
\omega\left(P_{q}\right) \leq \frac{\sqrt{2 q-1}+1}{2}
$$

Note that the inequality $\frac{\sqrt{2 q-1}+1}{2}<\sqrt{q}$ holds for any integer $q>1$. Therefore, for every prime number $q \equiv 1(\bmod 4)$ and for every $k \in \mathbb{R}$ with $\left\lfloor\frac{\sqrt{2 q-1}+1}{2}\right\rfloor \leq k<\sqrt{q}$, the polynomial $p_{P_{q}, k}(x)$ as defined in (10) is nonnegative but not sos.

### 4.1.4 Mycielski graphs

For a graph $G$ with vertex set $V(G)=\left\{v_{1}, \ldots, v_{n}\right\}$, the Mycielskian of $G$, denoted by $M(G)$, is the graph obtained from $G$ by adding $n+1$ new vertices $u_{1}, \ldots, u_{n}, w$, and for $1 \leq i \leq n$, making $u_{i}$ adjacent to the neighbors of $v_{i}$ and to $w$. The sequence of graphs $M_{2}, M_{3}, M_{4}, \ldots$ obtained by starting with the one-edge graph $M_{2}$ and applying the Mycielskian operation $M_{k+1}=M\left(M_{k}\right)$ repeatedly for $k \geq 2$ is called the Mycielski graphs. It is well known that for every $k=2,3, \ldots$, we have $\omega\left(M_{k}\right)=2$ and $\chi\left(M_{k}\right)=k$ [56]. In other words, the Mycielskian operation preserves the property of having clique number equal to 2 but increases the chromatic number. The first few graphs in this sequence are the one-edge graph $M_{2}$, the 5 -vertex cycle graph $M_{3}=C_{5}$, and the Grötzsch graph $M_{4}$. See Figure 3 for the Mycielski graphs $M_{3}$ and $M_{4}$.


Figure 3: The Mycielski graphs $M_{3}$ and $M_{4}$
Since $\omega\left(M_{3}\right)<\vartheta^{\prime}\left(\overline{M_{3}}\right)$ and since $M_{k+1}$ is obtained from $M_{k}$ by adding vertices and edges without increasing the clique number, it follows from the arguments in Section 4.2.1 below that for $k \geq 3$, we have $\omega\left(M_{k}\right)<\vartheta^{\prime}\left(\overline{M_{k}}\right)$.5 Therefore, by Corollary 3.2, the polynomial $p_{M_{k}}(x)$ is nonnegative but not sos. Thus, for $k \geq 3$, the family of Mycielski graphs $M_{k}$ yields another infinite family of polynomials that are nonnegative but not sos and that can explicitly be written down (since $\omega\left(M_{k}\right)=2$ ).

### 4.2 Graph-theoretic operations that preserve the property of being not sos

### 4.2.1 Adding edges and vertices without increasing the clique number

It is easy to observe that adding edges to a graph without increasing its clique number preserves the property of being not sos. Indeed, if $H$ is the graph obtained from a graph $G$ by adding the edge $i j$

[^3]such that $\omega(H)=\omega(G)$, then from the definition in (1), we have $p_{G}(x)=p_{H}(x)+2 \omega(G) x_{i}^{2} x_{j}^{2}$. This observation also appears in [46, Lemma 4.9] (see also [45]) with a slightly different language.

The following lemma, whose proof is simple and thus omitted, also allows us to add new vertices with arbitrary adjacencies.
Lemma 4.1. Let $G$ be a graph with vertex set $V(G)=\left\{v_{1}, \ldots, v_{n}\right\}$ and let $H$ be an induced subgraph of $G$ with $V(H)=\left\{v_{1}, \ldots, v_{k}\right\}$ (i.e., the graph $H$ is obtained from $G$ by deleting the vertices $v_{k+1}, \ldots, v_{n}$ ). Then,

$$
p_{G}\left(x_{1}, \ldots, x_{k}, 0, \ldots, 0\right)=p_{H}\left(x_{1}, \ldots, x_{k}\right)
$$

if and only if $\omega(G)=\omega(H)$.
Using the "if direction" of this lemma, we can generate many more nonnegative polynomials that are not sos starting from existing ones. Let $H$ be a graph with $\omega(H)<\vartheta^{\prime}(\bar{H})$ (such as the graphs described in Section (4.1). By Corollary [3.2, the polynomial $p_{H}(x)$ is nonnegative but not sos. Let $G$ be a graph obtained from $H$ by adding new vertices with arbitrary adjacencies such that $\omega(G)=\omega(H)$. Then, the polynomial $p_{G}(x)$ is nonnegative but not sos. Indeed, since $\omega(G)=\omega(H)$, by setting the variables that correspond to vertices in $V(G) \backslash V(H)$ to zero, we obtain the polynomial $p_{H}(x)$. Hence, if $p_{G}(x)$ was sos, then $p_{H}(x)$ would be sos since it is obtained from an sos polynomial by setting some variables to zero.

As an example of this operation, let $H$ be the graph $C_{5}$ and $G$ be the graph in Figure 4 (right), which is arbitrarily constructed by adding vertices to $H$ without increasing the clique number. We have $p_{G}\left(x_{1}, \ldots, x_{5}, 0, \ldots, 0\right)=p_{H}\left(x_{1}, \ldots, x_{5}\right)$, and since $p_{H}\left(x_{1}, \ldots, x_{5}\right)$ is not sos, the polynomial $p_{G}\left(x_{1}, \ldots, x_{14}\right)$ is not sos.

Figure 4: The graph $G$ is obtained from the graph $H$ by adding new vertices with arbitrary adjacencies such that $\omega(G)=\omega(H)$, making $p_{G}$ inherit the property of being not sos from $p_{H}$

We note that for a graph $H$ for which $p_{H}(x)$ is not sos, if $G$ is obtained from $H$ by adding new vertices in a way that $\omega(G)>\omega(H)$, then $p_{G}(x)$ might become sos. See the last two sentences of Remark 2 for an example.

### 4.2.2 Graph join

The join of two graphs $G_{1}$ and $G_{2}$, with disjoint vertex sets, is the graph obtained by connecting every vertex of $G_{1}$ to all vertices of $G_{2}$. See Figure 5 for an example. It is easy to see that if $G$ is the join of $G_{1}$ and $G_{2}$, then $\omega(G)=\omega\left(G_{1}\right)+\omega\left(G_{2}\right)$. It is also true that $\vartheta^{\prime}(\bar{G})=\vartheta^{\prime}\left(\overline{G_{1}}\right)+\vartheta^{\prime}\left(\overline{G_{2}}\right)$ (see Theorem 4.1 in [11). Hence, if we start with two graphs $G_{1}$ and $G_{2}$ such that $\omega\left(G_{i}\right)<\vartheta^{\prime}\left(\bar{G}_{i}\right)$ for either $i=1$ or $i=2$, then the join $G$ of $G_{1}$ and $G_{2}$ satisfies $\omega(G)<\vartheta^{\prime}(\bar{G})$. Therefore, for every graph $G$ obtained this way, the polynomial $p_{G}(x)$ is a nonnegative polynomial that is not sos. As an example, consider the graphs $G_{1}, G_{2}$, and their join $G$, given in Figure 5. We have

$$
4=\omega\left(G_{1}\right)+\omega\left(G_{2}\right)=\omega(G)<\vartheta^{\prime}(\bar{G})=\vartheta^{\prime}\left(\overline{G_{1}}\right)+\vartheta^{\prime}\left(\overline{G_{2}}\right)=\sqrt{5}+2,
$$

and thus the polynomial $p_{G}(x)$ is nonnegative but not sos.


Figure 5: Since $p_{G_{1}}$ is not sos, the polynomial $p_{G}$ associated with the join $G$ of $G_{1}$ and $G_{2}$ is not sos

### 4.2.3 Graph strong product

The strong product of two graphs $G_{1}$ and $G_{2}$, denoted by $G_{1} \boxtimes G_{2}$, is the graph with vertex set $V\left(G_{1} \boxtimes G_{2}\right)=V\left(G_{1}\right) \times V\left(G_{2}\right)$, where two vertices $\left(a_{1}, a_{2}\right)$ and $\left(b_{1}, b_{2}\right)$ are adjacent if and only if

- $a_{1}=b_{1}$ and $a_{2} b_{2} \in E\left(G_{2}\right)$, or
- $a_{1} b_{1} \in E\left(G_{1}\right)$ and $a_{2}=b_{2}$, or
- $a_{1} b_{1} \in E\left(G_{1}\right)$ and $a_{2} b_{2} \in E\left(G_{2}\right)$.

It is not difficult to see that ${ }^{6} \omega\left(G_{1} \boxtimes G_{2}\right)=\omega\left(G_{1}\right) \omega\left(G_{2}\right)$ holds for any two graphs $G_{1}, G_{2}$ (see, e.g., Lemma 3.1 in [27]). It is also true that $\sqrt{7} \vartheta^{\prime}\left(\overline{G_{1} \boxtimes G_{2}}\right)=\vartheta^{\prime}\left(\overline{G_{1}}\right) \vartheta^{\prime}\left(\overline{G_{2}}\right)$ for any two graphs $G_{1}, G_{2}$, see, e.g., Theorem 254 in [23]. (In fact, for our purposes, the inequalities $\omega\left(G_{1} \boxtimes G_{2}\right) \leq \omega\left(G_{1}\right) \omega\left(G_{2}\right)$ and $\vartheta^{\prime}\left(\overline{G_{1} \boxtimes G_{2}}\right) \geq \vartheta^{\prime}\left(\overline{G_{1}}\right) \vartheta^{\prime}\left(\overline{G_{2}}\right)$ are enough.) Hence, if we start with two graphs $G_{1}$ and $G_{2}$ such that $\omega\left(G_{i}\right)<\vartheta^{\prime}\left(\bar{G}_{i}\right)$ for either $i=1$ or $i=2$, then

$$
\omega\left(G_{1} \boxtimes G_{2}\right)=\omega\left(G_{1}\right) \omega\left(G_{2}\right)<\vartheta^{\prime}\left(\overline{G_{1}}\right) \vartheta^{\prime}\left(\overline{G_{2}}\right)=\vartheta^{\prime}\left(\overline{G_{1} \boxtimes G_{2}}\right),
$$

and so the graph $G_{1} \boxtimes G_{2}$ satisfies $\omega\left(G_{1} \boxtimes G_{2}\right)<\vartheta^{\prime}\left(\overline{G_{1} \boxtimes G_{2}}\right)$. Therefore, for every graph $G$ obtained this way, the polynomial $p_{G}(x)$ is a nonnegative polynomial that is not sos. As an example, consider the graphs $G_{1}, G_{2}$, and their strong product $G$, given in Figure 6. We have

$$
4=\omega\left(G_{1}\right) \omega\left(G_{2}\right)=\omega(G)<\vartheta^{\prime}(\bar{G})=\vartheta^{\prime}\left(\overline{G_{1}}\right) \vartheta^{\prime}\left(\overline{G_{2}}\right)=2 \sqrt{5},
$$

and thus the polynomial $p_{G}(x)$ is nonnegative but not sos.


Figure 6: Since $p_{G_{1}}$ is not sos, the polynomial $p_{G}$ associated with the strong product $G$ of $G_{1}$ and $G_{2}$ is not sos

[^4]Remark 4. Although not explicitly mentioned, it follows from Theorem 3 of a work of Dickinson and de Zeeuw [25], which was recently brought to our attention, that for every graph $G$ with at least one edge whose complement is connected, $\alpha$-critical, and " $\alpha$-covered" (see 25 for definitions), the nonnegative polynomial $p_{G}(x)$ in (1) would not be sos. However, these three conditions are quite restrictive for our purposes. In particular, using the operations presented above, it is easy to produce many examples of graphs $G$ for which $p_{G}(x)$ is not sos and such that any one of three conditions of [25, Theorem 3] is violated.

### 4.3 Random graphs

For a positive integer $n$ and a real number $p \in(0,1)$, an Erdős-Rényi random graph $G_{n, p}$, introduced in [29], is a graph on $n$ vertices where each vertex is adjacent to each other vertex with probability $p$, independent of all other choices. In this section, we consider the polynomial $p_{G_{n, p}}(x)$ (as defined in (11)) associated with an Erdős-Rényi random graph $G_{n, p}$. For a constant $p \in(0,1)$, we would like to understand the probability that the nonnegative polynomial $p_{G_{n, p}}(x)$ is not sos as $n$ tends to infinity.
Lemma 4.2. Let $p \in(0,1)$ be fixed. Then, for every integer $n$ that satisfies $1 \leq 2 \log _{1 / p} n \leq n$, we have

$$
\operatorname{Pr}\left(\omega\left(G_{n, p}\right)<2 \log _{1 / p} n\right) \geq 1-n\left(\frac{e}{2 \log _{1 / p} n}\right)^{2 \log _{1 / p} n}
$$

Proof. Let $X_{r}$ denote the number of cliques of size $r$ in $G_{n, p}$. Note that

$$
\begin{equation*}
\operatorname{Pr}\left(\omega\left(G_{n, p}\right)<r\right)=\operatorname{Pr}\left(X_{r}=0\right)=1-\operatorname{Pr}\left(X_{r} \geq 1\right) \geq 1-\mathrm{E}\left[X_{r}\right] . \tag{12}
\end{equation*}
$$

For any $n \geq r \geq 1$, we have

$$
\mathrm{E}\left[X_{r}\right]=\binom{n}{r} p^{\binom{r}{2}} \leq\left(\frac{n e}{r}\right)^{r} p^{\frac{r(r-1)}{2}}
$$

where the inequality follows since $\binom{n}{r} \leq\left(\frac{n e}{r}\right)^{r}$. If we set $r=2 \log _{1 / p} n$, we obtain

$$
\mathrm{E}\left[X_{r}\right] \leq n\left(\frac{e}{2 \log _{1 / p} n}\right)^{2 \log _{1 / p} n}
$$

which combined with (12) proves the claim.
Lemma 4.3 ([21]). Let $p \in(0,1)$ be fixed. Then, there exist a constant $\lambda>0$ such that for large enough $n$, we have

$$
\operatorname{Pr}\left(\vartheta^{\prime}\left(\overline{G_{n, p}}\right)>\frac{1}{2(\lambda+4)} \sqrt{\frac{n p}{1-p}}\right) \geq 1-e^{-n} .
$$

The following theorem is then a direct consequence of Lemma 3.1, and the union bound applied to Lemma 4.2 and Lemma 4.3. Recall the definition of the polynomial $p_{G, k}(x)$ from (10).
Theorem 4.4. Let $p \in(0,1)$ be fixed. Then, there exist a constant $\lambda>0$ such that for large enough $n$ and for any $k$ satisfying $2 \log _{1 / p} n \leq k \leq \frac{1}{2(\lambda+4)} \sqrt{\frac{n p}{1-p}}$, we have

$$
\begin{equation*}
\operatorname{Pr}\left(p_{G_{n, p}, k}(x) \text { is nonnegative but not sos }\right) \geq 1-e^{-n}-n\left(\frac{e}{2 \log _{1 / p} n}\right)^{2 \log _{1 / p} n} . \tag{13}
\end{equation*}
$$

Notice that the range of allowed values for $k$ in Theorem4.4 gets larger as $n$ increases, and that the right hand side in (13) tends to 1 as $n$ tends to infinity. Note also that for any $n, p, k$, the probability that the (nonnegative) polynomial $p_{G_{n, p}}(x)$ is not sos is greater than or equal to the probability that the polynomial $p_{G_{n, p}, k}(x)$ is nonnegative but not sos. Therefore, for a fixed constant $p \in(0,1)$ and for large enough $n$, the polynomial $p_{G_{n, p}}(x)$ is nonnegative but not sos with high probability. In some sense, Theorem 4.4 can be considered as a discrete confirmation of a result of Blekherman [6], which implies that when the degree is even and at least four, there are "significantly more" nonnegative polynomials than sos polynomials as the number of variables tends to infinity.

### 4.3.1 Computational experiments on random graphs

For a fixed constant $p \in(0,1)$, although Theorem 4.4 might require $n$ to be large in order to obtain random graphs $G_{n, p}$ with $p_{G_{n, p}}(x)$ not sos, we observe computationally that this phenomenon occurs for relatively small values of $n$. To demonstrate this, for each value of $n$ and $p$ given in Table [1, we generate 100 random graphs on $n$ vertices and with edge probability $p$. We report a lower bound on the number of times the (nonnegative) polynomial $p_{G_{n, p}}(x)$ is not sos, which by Corollary 3.2 holds if and only if $\omega\left(G_{n, p}\right)<\vartheta^{\prime}\left(\overline{G_{n, p}}\right)$. This lower bound is obtained by counting the number of times $\vartheta^{\prime}\left(\overline{G_{n, p}}\right)$ is not an integer, which implies $\omega\left(G_{n, p}\right)<\vartheta^{\prime}\left(\overline{G_{n, p}}\right)$ as $\omega\left(G_{n, p}\right)$ is an integer. We observe that when $n \geq 150$, the (nonnegative) polynomial $p_{G_{n, p}}(x)$ is almost never sos.

Table 1: A lower bound on the number of times that 100 randomly generated graphs $G_{n, p}$ satisfy $\omega\left(G_{n, p}\right)<\vartheta^{\prime}\left(\overline{G_{n, p}}\right)$ (or equivalently make the (nonnegative) polynomial $p_{G_{n, p}}(x)$ not sos)

We remark that when the value $\vartheta^{\prime}(\bar{G})$ is not an integer, for any $k \in \mathbb{R}$ with

$$
\left\lfloor\vartheta^{\prime}(\bar{G})\right\rfloor \leq k<\vartheta^{\prime}(\bar{G}),
$$

the polynomial $p_{G, k}(x)$ is nonnegative but not sos. Thus, this method suggests a very simple and efficient way of generating random nonnegative polynomials of degree 4 that are not sos.

### 4.4 Separating hyperplanes

Let $\Sigma_{n, d}$ denote the set of sos polynomials of degree $d$ in $n$ variables. Since $\Sigma_{n, d}$ is a closed convex set, one can always show that a polynomial $p(x)$ of degree $d$ in $n$ variables does not belong to $\Sigma_{n, d}$ by presenting a hyperplane that separates $p(x)$ from $\Sigma_{n, d}$. For a graph $G$ with $p_{G}(x) \notin \Sigma_{n, 4}$, the following theorem makes this hyperplane explicit.

Theorem 4.5. Let $G=(V, E)$ be a graph on $n$ vertices with $p_{G}(x) \notin \Sigma_{n, 4}$. An optimal solution $X \in S_{n}$ to (11) provides a hyperplane that separates $p_{G}(x)$ from $\Sigma_{n, 4}$.

Proof. Let us recall the polynomial $p_{G}(x)$ :

$$
p_{G}(x)=-2 \omega(G) \sum_{i j \in E(G)} x_{i}^{2} x_{j}^{2}+(\omega(G)-1)\left(\sum_{i=1}^{n} x_{i}^{2}\right)^{2} .
$$

Notice that the polynomial $p_{G}(x)$ consists of monomials $x_{i}^{2} x_{j}^{2}$ for $i, j=1, \ldots, n$. Let $V:=V(x)$ denote the $n \times n$ symmetric matrix that consists of these monomials where $V_{i j}=x_{i}^{2} x_{j}^{2}$ for $i, j=1, \ldots, n$. Let the matrix of coefficients of $p_{G}(x)$ in the monomial ordering $V$ be denoted by $M^{p} \in S_{n}$, i.e., $p_{G}(x)=\left\langle V, M^{p}\right\rangle$, where $\langle\cdot, \cdot\rangle$ denotes the standard matrix inner product ${ }^{9}$. We claim that an optimal solution $X \in S_{n}$ to (11) satisfies $\left\langle X, M^{p}\right\rangle<0$ and $\left\langle X, M^{q}\right\rangle \geq 0$ for any sos polynomial $q(x)$ consisting of the monomials in $V$. Here, $M^{q} \in S_{n}$ denotes the coefficients of $q(x)$ listed according to the ordering in $V$. Observe that

$$
M_{i j}^{p}= \begin{cases}\omega(G)-1 & \text { if } i=j \\ -1 & \text { if } i j \in E(G) \\ \omega(G)-1 & \text { if } i j \notin E(G)\end{cases}
$$

Let $X$ be an optimal solution to (11). Then, we have

$$
X \geq 0, \quad X \succeq 0, \quad \operatorname{Tr}(X)=1, \quad X_{i j}=0 \text { for } i j \notin E(G), \quad 2 \sum_{i j \in E(G)} X_{i j}=\vartheta^{\prime}(\bar{G})-1
$$

where the last equality follows since

$$
\vartheta^{\prime}(\bar{G})=\operatorname{Tr}(J X)=\sum_{i, j=1}^{n} X_{i j}=2 \sum_{i j \in E(G)} X_{i j}+2 \sum_{i j \notin E(G)} X_{i j}+\sum_{i=1}^{n} X_{i i}=2 \sum_{i j \in E(G)} X_{i j}+1
$$

Now, observe that

$$
\left\langle X, M^{p}\right\rangle=(\omega(G)-1) \operatorname{Tr}(X)-2 \sum_{i j \in E(G)} X_{i j}=(\omega(G)-1)-\left(\vartheta^{\prime}(\bar{G})-1\right)=\omega(G)-\vartheta^{\prime}(\bar{G})
$$

Since $p_{G}(x)$ is not sos, by Corollary [3.2(b), we have $\omega(G)<\vartheta^{\prime}(\bar{G})$, and therefore $\left\langle X, M^{p}\right\rangle<0$.
Consider now an arbitrary sos polynomial $q(x)$ consisting of the monomials in $V$. By [58, Section 5] (see also [13, Lemma 3.5]), we must have $M^{q}=P+N$, where $P \succeq 0$ and $N \geq 0$. Since $X \succeq 0$ and $X \geq 0$, it follows that $\left\langle X, M^{q}\right\rangle=\langle X, P\rangle+\langle X, N\rangle \geq 0$.

### 4.5 Convexity of the polynomial $p_{G, k}(x)$

In addition to nonnegativity, convexity 10 is another fundamental property of polynomials. The study of the relationship between the set of convex and the set of sos polynomials is a subject of active research. In [7], Blekherman showed that there are convex forms 11 that are not sos, although the problem of constructing an explicit example remained open until recently. In [66], Saunderson provided the first such example. Saunderson's form is of degree 4 and has 272 variables and it is known that such an example does not exist among forms of degree 4 in less than 5 variables [28]. Given that we have shown in Sections 4.1, 4.2, 4.3 how various graphs $G$ can lead to degree- 4 nonnegative forms $p_{G}(x)$ that are not sos, it is natural to ask whether it is possible to construct convex forms that are not sos through the polynomial $p_{G}(x)$, or more generally $p_{G, k}(x)$. In this section, we show that these polynomials are unfortunately always "closer" to being sos than to being convex.

Recall the definitions of the quartic forms $p_{G}(x)$ and $p_{G, k}(x)$ from (11) and (10). It is easy to see that if $G$ is a graph with no edge, then $p_{G, k}(x)=(k-1)\left(\sum_{i=1}^{|V(G)|} x_{i}^{2}\right)^{2}$, which is convex if and only if $k \geq 1$. It turns out that this is the only case where $p_{G, k}(x)$ is convex.

[^5]Lemma 4.6. Let $G$ be a graph with at least one edge. Then, the polynomial $p_{G, k}(x)$ is not convex for any $k$.

It follows that the polynomial $p_{G, k}(x)$ is convex if and only if $G$ has no edge and $k \geq 1$ (in which case $p_{G, k}(x)$ is clearly sos). In particular, the polynomial $p_{G}(x)$ is convex if and only if $G$ has no edge (in which case $p_{G}(x)=0$ ).

Instead of proving Lemma 4.6, we prove a more general statement in Lemma 4.7. Even though the polynomial $p_{G, k}(x)$ does not directly lead to a convex form that is not sos, one might still hope to obtain such a form by considering the following family of polynomials:

$$
p_{G, k, \gamma}(x):=p_{G, k}(x)+\gamma\left(\sum_{i=1}^{|V(G)|} x_{i}^{2}\right)^{2} .
$$

Indeed, starting with a pair $(G, k)$ for which the nonnegative polynomial $p_{G, k}(x)$ is not sos, by increasing the value of the scalar $\gamma$, one might hope that the polynomial $p_{G, k, \gamma}(x)$ becomes convex before it becomes sos ${ }^{12}$ The next lemma shows that this can never happen.

Lemma 4.7. Let $G$ be a graph with at least one edge. If the polynomial $p_{G, k, \gamma}(x)$ is convex for some $k$, then $\gamma \geq 1$ (in which case the polynomial $p_{G, k, \gamma}(x)$ is sos).

Proof. Let $G=(V, E)$ be a graph with at least one edge and with vertex set $V=\{1, \ldots, n\}$. We may assume without of loss of generality that vertex 1 is adjacent to vertex 2. Let $H(x)$ denote the Hessian of the polynomial $p_{G, k, \gamma}(x)$. We have

$$
H_{1,1}(x)=12(k-1+\gamma) x_{1}^{2}+4 k \sum_{1 i \notin E} x_{i}^{2}+4(\gamma-1) \sum_{i=2}^{n} x_{i}^{2} .
$$

Observe that $H_{1,1}(0,1,0, \ldots, 0)=4(\gamma-1)$. Hence, regardless the value of $k$, the Hessian $H(x)$ cannot not globally psd when $\gamma<1$. This proves that if $p_{G, k, \gamma}(x)$ is convex, then $\gamma \geq 1$.

Observe also that $p_{G, k, 1}(x)=k \sum_{i=1}^{n} x_{i}^{4}+2 k \sum_{i j \notin E} x_{i}^{2} x_{j}^{2}$. Therefore, $p_{G, k, \gamma}(x)$ is sos for $\gamma \geq 1$.

## 5 Subsets of Sum of Squares Polynomials and Their Graph-Theoretic Interpretations

As observed in the proof of Lemma 3.1, the following formulations of $\omega(G)$ and $\vartheta^{\prime}(\bar{G})$ can be obtained through nonnegativity and sum of squares conditions on the polynomial $p_{G, k}(x)$ defined in (10):

$$
\begin{array}{rl}
\omega(G)=\min _{k \in \mathbb{R}} & k \\
\text { s.t. } & p_{G, k}(x) \text { is nonnegative }, \tag{15}
\end{array}
$$

$$
\begin{array}{rl}
\vartheta^{\prime}(\bar{G})=\min _{k \in \mathbb{R}} & k \\
\text { s.t. } & p_{G, k}(x) \text { is sos. }
\end{array}
$$

It is therefore natural to wonder the graph parameters that some subsets of sos polynomials would lead to. In this section, we consider certain subsets of sos polynomials and study the bounds that optimization over these subsets produces on the clique number of a graph. We then characterize the graphs for which these bounds are tight for all induced subgraphs.

### 5.1 Dsos and sdsos polynomials

Recall that a polynomial $p(x)$ in $n$ variables and of degree $2 d$ is sos if and only if there exists a matrix $Q \in S_{n}^{+}$such that $p(x)=z(x)^{T} Q z(x)$, where $z(x)$ is the vector of monomials of degree up to $d$ [16, 58]. In [2], the condition that the matrix $Q$ be psd is replaced with stronger conditions for the purpose of obtaining subsets of sos polynomials that one can optimize over more efficiently. Two such conditions arise from the notions of diagonally dominant and scaled diagonally dominant matrices. A matrix $A \in S_{n}$ is

- diagonally dominant (dd) if $A_{i i} \geq \sum_{j \neq i}\left|A_{i j}\right|$ for every $i=1, \ldots, n$,
- scaled diagonally dominant (sdd) if there exists a diagonal matrix $D$, with positive diagonal entries, such that $D A D$ is diagonally dominant.

We refer to the set of $n \times n$ dd (resp. sdd) matrices as $D D_{n}$ (resp. $S D D_{n}$ ). By Gershgorin's circle theorem [34], we have $D D_{n} \subseteq S D D_{n} \subseteq S_{n}^{+}$. We say that a polynomial $p(x)$ is diagonally dominant sum of squares (dsos) (resp. scaled diagonally dominant sum of squares (sdsos)) if there exists a dd (resp. sdd) matrix $Q$ such that $p(x)=z(x)^{T} Q z(x)$ It is shown in [2] that one can optimize a linear function over the set of dsos (resp. sdsos) polynomials intersected with an affine subspace using linear programming (resp. second-order cone programming). Since dsos/sdsos polynomials form more tractable subsets of sos polynomials, in view of (14) and (15), it is natural to wonder the graph parameters that they produce. For a graph $G$, let us define the following parameters:

$$
\begin{align*}
\tau(G):= & \min _{k \in \mathbb{R}}  \tag{16}\\
& k  \tag{17}\\
& \text { s.t. } \quad p_{G, k}(x) \text { is dsos, },
\end{align*}
$$

$$
\begin{aligned}
\gamma(G):= & \min _{k \in \mathbb{R}} \\
\text { s.t. } & k \\
& p_{G, k}(x) \text { is sdsos. }
\end{aligned}
$$

In this subsection, we show that for any graph $G$, we have

- $\tau(G)=\Delta(G)+1$, where $\Delta(G)$ is the maximum degree of $G$,
- $\gamma(G)=\lambda_{\max }(A)+1$, where $\lambda_{\max }(A)$ is the largest eigenvalue of the adjacency matrix $A$ of $G 14$

Since dsos polynomials form a subset of sdsos polynomials, we have $\gamma(G) \leq \tau(G)$ for any graph $G$, and therefore we obtain the well-known inequality $\lambda_{\max }(A) \leq \Delta(G)$ from spectral graph theory (see, e.g., Section 3 in [24]). Together with (14) and (15), we have

$$
\omega(G) \leq \vartheta^{\prime}(\bar{G}) \leq \lambda_{\max }(A)+1 \leq \Delta(G)+1
$$

Remark 5. Recall the formulations of $\omega(G)$ and $\vartheta^{\prime}(\bar{G})$ given in (7) and (9), respectively. As stated in Section 3, the set $C_{n}$ (resp. $K_{n}$ ) can equivalently be described as the set of matrices $M \in S_{n}$ for which the polynomial $p_{M}(x)$ given in (8) is nonnegative (resp. sos). Parrilo [58, Section 5] observed (see also [13, Lemma 3.5]) that for a matrix $M \in S_{n}$, the polynomial $p_{M}(x)$ in (8) is sos if and only if $M \in S_{n}^{+}+N_{n}$, i.e., that $K_{n}=S_{n}^{+}+N_{n}$. Following the proof of Parrilo and using [2, Theorem 3.4 and Theorem 3.6], it is not difficult to verify that the polynomial $p_{M}(x)$ is sdsos (resp. dsos) if and only if $M \in S D D_{n}+N_{n}$ (resp. $M \in D D_{n}+N_{n}$ ). Hence, $\gamma(G)$ and $\tau(G)$ can equivalently be formulated as:

$$
\begin{array}{clrl}
\tau(G)=\min _{k \in \mathbb{R}} & k & & \\
\text { s.t. } & k(I+\bar{A})-J \in D D_{n}+N_{n}, & \min _{k \in \mathbb{R}} & k \\
\text { (18) } & \text { s.t. } & k(I+\bar{A})-J \in S D D_{n}+N_{n} . \tag{19}
\end{array}
$$

[^7]Theorem 5.1. For any graph $G$, we have $\tau(G)=\Delta(G)+1$.
Proof. Let $G$ be a graph on $n$ vertices and let $\bar{A}$ denote the adjacency matrix of $\bar{G}$. Let $k \in \mathbb{R}$ be feasible to (18). Then, we have $k(I+\bar{A})-J=D+N$, where $D \in D D_{n}$ and $N \in N_{n}$. Note that the matrix $k(I+\bar{A})-J$ has entries $k-1$ or -1 . More precisely,

$$
(k(I+\bar{A})-J)_{i j}= \begin{cases}k-1 & \text { if } i=j, \\ -1 & \text { if } i j \in E(G) \\ k-1 & \text { if } i j \notin E(G) .\end{cases}
$$

Since $N$ is a nonnegative matrix, for every $i j \in E(G)$, we must have $D_{i j} \leq-1$. Then, since $D$ is a dd matrix, for every $i \in V(G)$, we must have $k-1 \geq \operatorname{deg}(i)$, where $\operatorname{deg}(i)$ denotes the degree of the vertex $i$ in $G$. Thus, for any feasible $k \in \mathbb{R}$, we have $k \geq \Delta(G)+1$, and therefore $\tau(G) \geq \Delta(G)+1$.

It remains to show that $k=\Delta(G)+1$ is feasible to (18).15 Indeed, if $k=\Delta(G)+1$, let

$$
D_{i j}=\left\{\begin{array}{ll}
\Delta(G) & \text { if } i=j, \\
-1 & \text { if } i j \in E(G), \\
0 & \text { if } i j \notin E(G),
\end{array} \quad N_{i j}= \begin{cases}0 & \text { if } i=j, \\
0 & \text { if } i j \in E(G), \\
\Delta(G) & \text { if } i j \notin E(G) .\end{cases}\right.
$$

Then, $k(I+\bar{A})-J=D+N$, where $D \in D D_{n}$ and $N \in N_{n}$.
We now move to the parameter $\gamma(G)$. Recall the following characterization of the largest eigenvalue of a symmetric $n \times n$ matrix $A$ :

$$
\begin{array}{rl}
\lambda_{\max }(A)=\min _{k \in \mathbb{R}} & k \\
\text { s.t. } & k I-A \in S_{n}^{+}
\end{array}
$$

The following lemma gives a refined characterization of the largest eigenvalue of the adjacency matrix of a graph.

Lemma 5.2. Let $G$ be a graph on $n$ vertices with adjacency matrix $A$. Then,

$$
\begin{array}{rl}
\lambda_{\max }(A)=\min _{k \in \mathbb{R}} & k \\
\text { s.t. } & k I-A \in S D D_{n} .
\end{array}
$$

Proof. Since $S D D_{n} \subseteq S_{n}^{+}$, it is enough to show that for $k=\lambda_{\max }(A)$, we have $k I-A \in S D D_{n}$. Assume first that $G$ is a connected graph. Let $v=\left(v_{1}, \ldots, v_{n}\right)^{T}$ be an eigenvector that corresponds to $\lambda_{\max }(A)$. Then, by the Perron-Frobenius ${ }^{16}$ theorem [63, 30, we have $\lambda_{\max }(A)>0$ and we may assume that $v_{i}>0$ for $i=1, \ldots, n$. Let $D=\operatorname{Diag}\left(v_{1}, \ldots, v_{n}\right)$, where $\operatorname{Diag}\left(v_{1}, \ldots, v_{n}\right)$ denotes the $n \times n$ diagonal matrix with the vector $\left(v_{1}, \ldots, v_{n}\right)^{T}$ on its diagonal. We claim that $D\left(\lambda_{\max }(A) I-A\right) D$ is dd, and thus $\lambda_{\max }(A) I-A \in S D D_{n}$. We have

$$
D\left(\lambda_{\max }(A) I-A\right) D=\lambda_{\max }(A) \cdot \operatorname{Diag}\left(v_{1}^{2}, \ldots, v_{n}^{2}\right)-\left.A\right|_{v_{i} v_{j}: i j \in E(G)},
$$

where $\left.A\right|_{v_{i} v_{j}: i j \in E(G)}$ denotes the adjacency matrix $A$ with 1 's replaced by $v_{i} v_{j}$ for $i j \in E(G)$. Hence, the matrix $D\left(\lambda_{\max }(A) I-A\right) D$ is dd if and only if

$$
\lambda_{\max }(A) \cdot v_{i}^{2} \geq \sum_{i j \in E(G)} v_{i} v_{j}
$$

[^8]for every $i=1, \ldots, n$, which holds if and only if $\lambda_{\max }(A) \cdot v_{i} \geq \sum_{i j \in E(G)} v_{j}$ for every $i=1, \ldots, n$. But since $A v=\lambda_{\max }(A) v$, we have $\lambda_{\max }(A) \cdot v_{i}=\sum_{i j \in E(G)} v_{j}$ for every $i=1, \ldots, n$. This completes the proof for the case when $G$ is a connected graph.

Next, assume that $G$ has several connected components $G_{1}, \ldots, G_{r}$, with adjacency matrices $A_{1}, \ldots, A_{r}$ and with $\left|V\left(G_{i}\right)\right|=n_{i}$ for $i=1, \ldots, r$. Then, $A$ is a block diagonal matrix with diagonal blocks $A_{1}, \ldots, A_{r}$, and

$$
\begin{array}{rlrl}
\lambda_{\max }(A)=\max _{1 \leq i \leq r} \lambda_{\max }\left(A_{i}\right)=\max _{1 \leq i \leq r} \min _{k \in \mathbb{R}} & k & =\min _{k \in \mathbb{R}} & k \\
\text { s.t. } & k I-A_{i} \in S D D_{n_{i}} & \text { s.t. } & k I-A_{i} \in S D D_{n_{i}}, i=1, \ldots, r \\
= & \min _{k \in \mathbb{R}} & k \\
& \text { s.t. } & k I-A \in S D D_{n} .
\end{array}
$$

This completes the proof.
Theorem 5.3. For any graph $G$, we have $\gamma(G)=\lambda_{\max }(A)+1$.
Proof. Let $G$ be a graph on $n$ vertices, and let $A$ and $\bar{A}$ be the adjacency matrices of $G$ and $\bar{G}$ respectively. Since $k(I+\bar{A})-J=(k-1) I-A+(k-1) \bar{A}$, by (19), we have

$$
\begin{array}{rl}
\gamma(G)=\min _{k \in \mathbb{R}} & k  \tag{20}\\
& \text { s.t. } \\
& (k-1) I-A+(k-1) \bar{A} \in S D D_{n}+N_{n} .
\end{array}
$$

By Lemma 5.2, we also have

$$
\begin{array}{rl}
\lambda_{\max }(A)+1=\min _{k \in \mathbb{R}} & k  \tag{21}\\
\text { s.t. } & (k-1) I-A \in S D D_{n}
\end{array}
$$

We claim that

$$
\begin{aligned}
& \min _{k \in \mathbb{R}} k \quad=\min _{k \in \mathbb{R}} k \\
& \text { s.t. }(k-1) I-A \in S D D_{n} \quad \text { s.t. }(k-1) I-A+(k-1) \bar{A} \in S D D_{n}+N_{n} .
\end{aligned}
$$

Since $(k-1) \bar{A} \in N_{n}$ for any $k \geq 1$, any feasible solution to (21) is also feasible to (20). Next, we show that any feasible solution to (20) is also feasible to (21). Assume for the sake of contradiction that for some $k \in \mathbb{R}$, we have $(k-1) I-A+(k-1) \bar{A} \in S D D_{n}+N_{n}$, but $(k-1) I-A \notin S D D_{n}$. Then, there exist a diagonal matrix $D$ with positive diagonal entries, a dd matrix $M$, and a nonnegative matrix $N$, such that $D((k-1) I-A) D+(k-1) D \bar{A} D=M+N$. We have

$$
(D((k-1) I-A) D+(k-1) D \bar{A} D)_{i j}= \begin{cases}(k-1) d_{i}^{2} & \text { if } i=j \\ -d_{i} d_{j} & \text { if } i j \in E(G) \\ (k-1) d_{i} d_{j} & \text { if } i j \notin E(G)\end{cases}
$$

Since $N$ is a nonnegative matrix, for every $i j \in E(G)$, we must have $M_{i j} \leq-d_{i} d_{j}$. Then, since $M$ is a dd matrix, for every $i \in V(G)$, we must have $(k-1) d_{i}^{2} \geq \sum_{i j \in E(G)} d_{i} d_{j}$. But then the matrix $D((k-1) I-A) D$ is a dd matrix since we have

$$
(D((k-1) I-A) D)_{i j}= \begin{cases}(k-1) d_{i}^{2} & \text { if } i=j, \\ -d_{i} d_{j} & \text { if } i j \in E(G) \\ 0 & \text { if } i j \notin E(G)\end{cases}
$$

Hence, $(k-1) I-A \in S D D_{n}$, a contradiction.

Next, we characterize the graphs $G$ for which $\omega(H)=\tau(H)$ or $\omega(H)=\gamma(H)$ for every induced subgraph $H$ of $G$. A path on three vertices, denoted by $P_{3}$, is a graph with vertex set $\left\{v_{1}, v_{2}, v_{3}\right\}$ and edge set $\left\{v_{1} v_{2}, v_{2} v_{3}\right\}$; see Figure 7 for the graph $P_{3}$ and its complement $\overline{P_{3}}$. It is easy to observe that a graph is $P_{3}$-free if and only if it is a disjoint union of cliques (i.e., a graph whose connected components are complete graphs). Taking the complement, it follows that a graph is $\overline{P_{3}}$-free if and only if it is complete multipartite (i.e., a graph whose vertices can be partitioned into independent sets in such a way that all edges across independent sets are present).


Figure 7: The graph $P_{3}$ (left) and its complement $\overline{P_{3}}$ (right)
Corollary 5.4. For any graph $G$, the following are equivalent:
(a) $\omega(H)=\tau(H)$ for every induced subgraph $H$ of $G$,
(b) $\omega(H)=\gamma(H)$ for every induced subgraph $H$ of $G$,
(c) $G$ is a disjoint union of cliques.

Proof. Since $\gamma(H) \leq \tau(H)$ for any graph $H$, (ㅁa) clearly implies (b). We first show that (b) implies (디). Suppose $G$ is not a disjoint union of cliques. Then, $G$ contains $P_{3}$, and we have

$$
2=\omega\left(P_{3}\right)<\gamma\left(P_{3}\right)=\lambda_{\max }\left(A_{P_{3}}\right)+1=\sqrt{2}+1,
$$

where $A_{P_{3}}$ is the adjacency matrix of $P_{3}$ and the equality $\gamma\left(P_{3}\right)=\lambda_{\max }\left(A_{P_{3}}\right)+1$ follows from Theorem 5.3. This shows that $G$ has an induced subgraph $H$ with $\omega(H) \neq \gamma(H)$.

Next, we show that ((C) implies (回). Let $G$ be a disjoint union of cliques. Clearly, $\omega(G)=\Delta(G)+1$ and by Theorem 5.1, we have $\omega(G)=\tau(G)$. Since every induced subgraph of $G$ is also a disjoint union of cliques, we have $\omega(H)=\tau(H)$ for every induced subgraph $H$ of $G$.

### 5.2 Another structured subset of sos polynomials

For a graph $G$ and for an arbitrary scalar $k \in \mathbb{R}$, let us define the following quadratic polynomial:

$$
\hat{p}_{G, k}(x):=-2 k \sum_{i j \in E(G)} x_{i} x_{j}+(k-1)\left(\sum_{i=1}^{|V(G)|} x_{i}\right)^{2} .
$$

Equivalently, the polynomial $\hat{p}_{G, k}(x)$ is obtained from $p_{G, k}(x)$ (defined in (101)) by replacing $x_{i}^{2}$ with $x_{i}$ for $i=1, \ldots, n$. We then define the following parameter:

$$
\begin{array}{rl}
\rho(G):=\min _{k \in \mathbb{R}} & k  \tag{22}\\
\text { s.t. } & \hat{p}_{G, k}(x) \text { is nonnegative. }
\end{array}
$$

Since $\hat{p}_{G, k}(x)$ is a quadratic polynomial, it is nonnegative if and only if it is sos. Thus, whenever $\hat{p}_{G, k}(x)$ is nonnegative, the polynomial $p_{G, k}\left(x_{1}, \ldots, x_{n}\right)=\hat{p}_{G, k}\left(x_{1}^{2}, \ldots, x_{n}^{2}\right)$ is sos. Hence, in view of (14) and (15), we have $\omega(G) \leq \vartheta^{\prime}(\bar{G}) \leq \rho(G)$.

Remark 6. Recall the formulations of $\omega(G)$ and $\vartheta^{\prime}(\bar{G})$ in (77) and (9), and the fact that $K_{n}=S_{n}^{+}+N_{n}$. We remark that the polynomial $\hat{p}_{G, k}(x)$ is nonnegative if and only if $k(I+\bar{A})-J \in S_{n}^{+}$. Hence, $\rho(G)$ can equivalently be formulated as:

$$
\begin{align*}
& \rho(G)=\min _{k \in \mathbb{R}} k  \tag{23}\\
& \text { s.t. } k(I+\bar{A})-J \in S_{n}^{+} .
\end{align*}
$$

One can also define an upper bound on $\omega(G)$ by replacing the set $S_{n}^{+}$in (23) with $N_{n}$. However, it is easy to observe that $k(I+\bar{A})-J \in N_{n}$ for some $k \in \mathbb{R}$ if and only if $\bar{A}=J-I$, which holds if and only if the graph $G$ has no edge.

The result of this subsection is the following theorem.
Theorem 5.5. The parameter $\rho(G)$ is finite if and only if $G$ is complete multipartite, in which case $\rho(G)=\omega(G)$.
Proof. Suppose first that $G$ is not complete multipartite. We show that the matrix $k(I+\bar{A})-J$ in (23) is not psd for any $k \in \mathbb{R}$, and thus $\rho(G)$ is not finite. Since $G$ is not complete multipartite, it contains $\overline{P_{3}}$. Consider the submatrix of $k(I+\bar{A})-J$ that corresponds to $\overline{P_{3}}$ :

$$
\left(\begin{array}{ccc}
k-1 & k-1 & -1 \\
k-1 & k-1 & k-1 \\
-1 & k-1 & k-1
\end{array}\right)
$$

Suppose this matrix is psd for some $k \in \mathbb{R}$. Then, by nonnegativity of its principal minors, we have $k-1 \geq 0,(k-1)^{2}-1 \geq 0$, and $-k^{2}(k-1) \geq 0$. The first and the third inequalities together imply that $k=1$, which contradicts the second inequality.

Conversely, suppose $G$ is complete multipartite. We show that the matrix $k(I+\bar{A})-J$ is psd for $k=\omega(G)$. Since $\omega(G) \leq \rho(G)$, this would prove that $\rho(G)=\omega(G)$. Let $k=\omega(G)$. Since $G$ is complete multipartite, $V(G)$ can be partitioned into $\omega(G)$ independent sets $V(G)=I_{1} \cup \cdots \cup I_{k}$. For $i=1, \ldots, k$, let $\left|I_{i}\right|=m_{i}$. Since

$$
(k(I+\bar{A})-J)_{i j}= \begin{cases}k-1 & \text { if } i=j, \\ -1 & \text { if } i j \in E(G), \\ k-1 & \text { if } i j \notin E(G),\end{cases}
$$

we have

$$
k(I+\bar{A})-J=\left(\begin{array}{cccc}
(k-1) J_{m_{1}} & -J_{m_{1} m_{2}} & \ldots & -J_{m_{1} m_{k}} \\
-J_{m_{2} m_{1}} & (k-1) J_{m_{2}} & \ldots & -J_{m_{2} m_{k}} \\
\vdots & \vdots & \ddots & \vdots \\
-J_{m_{k} m_{1}} & -J_{m_{k} m_{2}} & \ldots & (k-1) J_{m_{k}}
\end{array}\right)
$$

where $J_{m_{i}}$ and $J_{m_{i} m_{j}}$ respectively denote the $m_{i} \times m_{i}$ and $m_{i} \times m_{j}$ all-ones block matrices. Then, observe that the matrix $k(I+\bar{A})-J$ can be expressed as

$$
\left(\begin{array}{cccc}
L_{m_{1}} & 0 & \ldots & 0 \\
0 & L_{m_{2}} & \ldots & 0 \\
\vdots & \vdots & \ddots & \vdots \\
0 & 0 & \ldots & L_{m_{k}}
\end{array}\right)\left(\begin{array}{cccc}
(k-1) U_{m_{1}} & -U_{m_{1} m_{2}} & \ldots & -U_{m_{1} m_{k}} \\
-U_{m_{2} m_{1}} & (k-1) U_{m_{2}} & \ldots & -U_{m_{2} m_{k}} \\
\vdots & \vdots & \ddots & \vdots \\
-U_{m_{k} m_{1}} & -U_{m_{k} m_{2}} & \ldots & (k-1) U_{m_{k}}
\end{array}\right)\left(\begin{array}{cccc}
L_{m_{1}}^{T} & 0 & \ldots & 0 \\
0 & L_{m_{2}}^{T} & \ldots & 0 \\
\vdots & \vdots & \ddots & \vdots \\
0 & 0 & \ldots & L_{m_{k}}^{T}
\end{array}\right)
$$

where $L_{m_{i}}$ is an $m_{i} \times m_{i}$ matrix with 1's on its diagonal and on its first column, and 0's everywhere else; and $U_{m_{i}}$ and $U_{m_{i} m_{j}}$ are respectively the $m_{i} \times m_{i}$ and $m_{i} \times m_{j}$ matrices with 1 on the first element of the first row, and 0 's everywhere else. Since the matrix in the middle is psd 17 it follows that the matrix $k(I+\bar{A})-J$ is psd.

It follows from Theorem 5.5 that a graph $G$ is complete multipartite if and only if $\omega(G)=\rho(G)$, which holds if and only if $\omega(H)=\rho(H)$ for every induced subgraph $H$ of $G$.

## 6 Future Research Directions

Theorem 1.1 establishes a link between perfect graphs and sos polynomials. In Section 4, we exploited certain results from graph theory to systematically construct nonnegative polynomials that are not sos, a task which is of interest to the algebraic geometry and polynomial optimization communities. We hope that future research can also transfer ideas in the other direction, for example provide algebraic proofs of structural results concerning perfect graphs. In this section, we lay down this research agenda more concretely and also discuss a few other directions for future research.

### 6.1 Algebraic reformulations of structural results concerning perfect graphs

In view of Theorem [1.1, we reformulate a number of results from the theory of perfect graphs as statements about sum of squares proofs of nonnegativity of certain polynomials.
The weak perfect graph theorem [48]:
A graph is perfect if and only if its complement is perfect.
The proof of the weak perfect graph theorem was given by Lovász in 1972 and relies on the following lemma which is interesting in its own right. Recall that replicating a vertex $v$ of a graph means adding a new vertex to the graph and making it adjacent to $v$ and to all the neighbors of $v$.

## The replication lemma [48]:

If $G$ is a perfect graph and $G^{\prime}$ is obtained from $G$ by replicating a vertex of $G$, then $G^{\prime}$ is perfect.
Other proofs of the weak perfect graph theorem can be obtained by self-complementary characterizations of perfect graphs. The following is one such characterization due to Lovász.

## Lovász's characterization of perfect graphs [49]:

A graph $G$ is perfect if and only if every induced subgraph $H$ of $G$ satisfies $\alpha(H) \omega(H) \geq|V(H)|$.
Lastly, the following (self-complementary) characterization of perfect graphs was proven in [18] more than forty years after it was conjectured in [4].
The strong perfect graph theorem [18]:
A graph is perfect if and only if it does not contain an odd hole or an odd antihole.
We now invoke Theorem 1.1 to provide algebraic reformulations of the four structural results above. From (1), recall the definition of the polynomial $p_{G}(x)$ associated with a graph $G$.

## The weak perfect graph theorem (algebraic reformulation):

If for every induced subgraph $H$ of a graph $G, p_{H}(x)$ is sos, then $p_{\bar{G}}(x)$ is sos.
Remark 7. The statement "if $p_{G}(x)$ is sos, then $p_{\bar{G}}(x)$ is sos" is not true in general. To see this, let $G$ be the the graph in Figure [8. Then, by Corollary 3.2(b), the polynomial $p_{G}(x)$ is sos since $\omega(G)=\vartheta^{\prime}(\bar{G})=3$, while the polynomial $p_{\bar{G}}(x)$ is not sos since $\omega(\bar{G})=2<\sqrt{5}=\vartheta^{\prime}(G)$.


Figure 8: The graph associated with Remark 7

## The replication lemma (algebraic reformulation):

Let $G^{\prime}$ be the graph obtained from a graph $G$ by replicating a vertex of $G$. If for every induced subgraph $H$ of $G, p_{H}(x)$ is sos, then $p_{G^{\prime}}(x)$ is sos.

Remark 8. The statement "if $p_{G}(x)$ is sos, then $p_{G^{\prime}}(x)$ is sos" is not true in general. To see this, let $G$ be the graph in Figure 9 (left), and $G^{\prime}$ be the graph obtained from $G$ by replicating the vertex $v$ as shown in Figure 9 (right). One can verify that $\omega(G)=\vartheta^{\prime}(\bar{G})=3$ while $\omega\left(G^{\prime}\right)=3<3.196<\vartheta^{\prime}\left(\overline{G^{\prime}}\right)$. By Corollary 3.2(b), the polynomial $p_{G}(x)$ is sos while the polynomial $p_{G^{\prime}}(x)$ is not.


Figure 9: The graphs $G$ (left) and $G^{\prime}$ (right) associated with Remark 8
The following is a reformulation of the nontirivial direction of Lovász's characterization of perfect graphs. (The other direction is immediate since $\alpha(G) \chi(G) \geq|V(G)|$ for any graph $G$.)

## Lovász's characterization of perfect graphs (algebraic reformulation):

If every induced subgraph $H$ of a graph $G$ satisfies $\alpha(H) \omega(H) \geq|V(H)|$, then $p_{G}(x)$ is sos.
Remark 9. The statement "if $G$ satisfies $\alpha(G) \omega(G) \geq|V(G)|$, then $p_{G}(x)$ is sos" is not true in general. As an example, consider the graph $G$ obtained from $C_{5}$ by adding a vertex adjacent to every vertex of $C_{5}$. We have $\omega(G)=3, \alpha(G)=2$, and $|V(G)|=6$. However, by Corollary 3.2(b), the polynomial $p_{G}(x)$ is not sos since $\vartheta^{\prime}(\bar{G})=\sqrt{5}+1$.

The following is a reformulation of the nontrivial direction of the strong perfect graph theorem. (As mentioned in Section 2.1, the other direction is immediate.)

The strong perfect graph theorem (algebraic reformulation - polynomial version):
If a graph $G$ does not contain an odd hole or an odd antihole, then $p_{G}(x)$ is sos.
Considering (7) and (9), together with Corollary (3.2(b) and the fact that $K_{n}=S_{n}^{+}+N_{n}$, another reformulation of the strong perfect graph theorem is the following.

The strong perfect graph theorem (algebraic reformulation - matrix version):
If a graph $G$ does not contain an odd hole or an odd antihole, then $\omega(G)(I+\bar{A})-J \in S_{n}^{+}+N_{n}$.
We hope that the above algebraic reformulations lead to new (and ideally simpler) proofs of these statements, possibly using tools from convex algebraic geometry and semidefinite optimization. This would be particularly exciting in the case of the strong perfect graph theorem, whose original proof in [18] is long and highly nontrivial.

### 6.2 Other research directions

We end with a few other research directions that could be of interest.

### 6.2.1 Sos decompositions for subclasses of perfect graphs

By Theorem [1.1, for any perfect graph $G$, the polynomial $p_{G}(x)$ is sos. Can one write down an explicit sos decomposition for some subclasses of perfect graphs? For example, for a complete graph $G$ on $n$ vertices, we have the following two possible sos decompositions:

$$
p_{G}(x)=\sum_{i j \in E(G)}\left(x_{i}^{2}-x_{j}^{2}\right)^{2},
$$

$$
p_{G}(x)=\sum_{i=1}^{n-1} \frac{n}{(n-i+1)(n-i)}\left((n-i) x_{i}^{2}-x_{i+1}^{2}-x_{i+2}^{2}-\cdots-x_{n}^{2}\right)^{2} .
$$

Similarly, for a bipartite graph $G$ whose vertex set is partitioned into two (independent) sets $A=\{1,2, \ldots, p\}$ and $B=\{p+1, p+2, \ldots, n\}$, we have the following sos decomposition:

$$
p_{G}(x)=\left(\sum_{i=1}^{p} x_{i}^{2}-\sum_{i=p+1}^{n} x_{i}^{2}\right)^{2}+\sum_{i \in A, j \in B, i j \notin E(G)}\left(2 x_{i} x_{j}\right)^{2} .
$$

Can one similarly write sos decompositions for other subclasses of perfect graphs, e.g., for chordal graphs? More interestingly, does an sos decomposition of $p_{G}(x)$ contain useful information about the perfect graph $G$ ?

### 6.2.2 Algebraic imperfection ratio

It would be interesting to study the relationship between the so-called imperfection ratio of a graph (see [33] for a definition) and an algebraic notion we define below which measures how close a given graph is to being sos-perfect.

Let $p_{G}^{\min }$ and $p_{G}^{\max }$ respectively denote the minimum and the maximum value of the nonnegative quartic form $p_{G}(x)$ on the unit sphere:

$$
p_{G}^{\min }:=\min _{\|x\|^{2}=1} p_{G}(x), \quad p_{G}^{\max }:=\max _{\|x\|^{2}=1} p_{G}(x)
$$

In general, a (computationally tractable) lower bound on $p_{G}^{\min }$ can be obtained by

$$
\begin{aligned}
& p_{G}^{\mathrm{sos}}:=\max _{\gamma \in \mathbb{R}} \gamma \\
& \text { s.t. } \\
& p_{G}(x)-\gamma\|x\|^{4} \text { is sos. }
\end{aligned}
$$

One way to measure the quality of $p_{G}^{\text {sos }}$ as a lower bound on $p_{G}^{\min }$ is through the "normalized" quantity $\left(p_{G}^{\max }-p_{G}^{\mathrm{sos}}\right) /\left(p_{G}^{\max }-p_{G}^{\min }\right)$. Taking induced subgraphs into consideration, we propose the following as to measure how close a given graph is to being sos-perfect:

$$
\begin{equation*}
\operatorname{AIMP}(G):=\max _{H \subseteq G}\left\{\frac{p_{H}^{\max }-p_{H}^{\mathrm{sos}}}{p_{H}^{\max }-p_{H}^{\min }}\right\} \tag{24}
\end{equation*}
$$

Here, the maximum is taken over all induced subgraphs $H$ of $G$. The following is a simple observation, which we give without proof.

Observation 6.1. For any graph $G$, we have $p_{G}^{m i n}=0$ and $p_{G}^{m a x}=\omega(G)-1$.
Notice that since $p_{G}^{\min }=0$, we have $p_{G}^{\text {sos }} \leq 0$ for every graph $G$. By Observation 6.1, we have

$$
\operatorname{AIMP}(G)=\max _{H \subseteq G}\left\{1-\frac{p_{H}^{\mathrm{sos}}}{\omega(H)-1}\right\}
$$

From (24), it is easy to see that $\operatorname{AIMP}(H) \leq \operatorname{AIMP}(G)$ for every induced subgraph $H$ of $G$. $\operatorname{Moreover}, \operatorname{AIMP}(G) \geq 1$ for every graph $G$, and $\operatorname{AIMP}(G)=1$ if and only if $G$ is sos-perfect (i.e., perfect). (These properties of $\operatorname{AIMP}(G)$ hold also for the imperfection ratio that is proposed in [33].) Can one classify interesting families of graphs for which $\operatorname{AIMP}(G)$ is bounded above by a given constant? Is it possible to efficiently approximate the clique number or the chromatic number for these graph families, e.g., by semidefinite programming?

### 6.2.3 $d$-sos-perfect graphs

From Artin's solution [3] to Hilbert's 17th problem, we know that for every nonnegative form $p(x)$, there exists a nonzero sos form $q(x)$ such that $p(x) q(x)$ is sos. (The representation of $p(x)$ as the ratio of two sos forms algebraically certifies nonnegativity of $p(x)$.) For an even nonnegative integer $d$, let us call a graph $G d$-sos-perfect if for every induced subgraph $H$ of $G$, there exists a nonzero degree- $d$ sos form $q_{H}(x)$ with $p_{H}(x) q_{H}(x)$ sos. (Here, $p_{H}(x)$ is defined as in (11).) With this definition, 0 -sos-perfect graphs are precisely perfect graphs. What are $d$-sos-perfect graphs for $d \geq 2$ ? What is the minimum $d$ that makes odd holes or odd antiholes (or some other families of imperfect graphs) $d$-sos-perfect? Does the answer relate to the algebraic imperfection ratio of these graphs, and if so how?

Hence, more generally, circulant graphs yield an infinite family of polynomials that are nonnegative but not sos.
    ${ }^{5}$ The inequality $\omega\left(M_{k}\right)<\vartheta^{\prime}\left(\overline{M_{k}}\right)$ for $k \geq 3$ also follows from a lemma of Laurent and Vargas [46, Lemma 5.6] which states that for graphs $G$ with $\omega(G) \leq 2, \omega(G)=\vartheta(\bar{G})$ if and only if $\omega(G)=\chi(G)$.
