# Optimistic Policy Optimization is Provably Efficient in Non-stationary MDPs

#### Abstract

We study episodic reinforcement learning (RL) in non-stationary linear kernel Markov decision processes (MDPs). In this setting, both the reward function and the transition kernel are linear with respect to the given feature maps and are allowed to vary over time, as long as their respective parameter variations do not exceed certain variation budgets. We propose the periodically restarted optimistic policy optimization algorithm (PROPO), which is an optimistic policy optimization algorithm with linear function approximation. PROPO features two mechanisms: sliding-window-based policy evaluation and periodic-restart-based policy improvement, which are tailored for policy optimization in a non-stationary environment. In addition, only utilizing the technique of sliding window, we propose a value-iteration algorithm. We establish dynamic upper bounds for the proposed methods and a matching minimax lower bound which shows the (near-) optimality of the proposed methods. To our best knowledge, PROPO is the first provably efficient policy optimization algorithm that handles non-stationarity.

## 1 Introduction

Reinforcement Learning (RL) (Sutton and Barto, 2018), coupled with powerful function approximators such as deep neural network, has demonstrated great potential in solving complicated sequential decision-making tasks such as games (Silver et al., 2016, 2017; Vinyals et al., 2019) and robotic control (Kober et al., 2013; Gu et al., 2017; Akkaya et al., 2019; Andrychowicz et al., 2020). Most of these empirical successes are driven by deep policy optimization methods such as trust region policy optimization (TRPO) (Schulman et al., 2015) and proximal policy optimization (PPO) (Schulman et al., 2017), whose performance has been extensively studied recently (Agarwal et al., 2019; Liu et al., 2019; Shani et al., 2020; Mei et al., 2020; Cen et al., 2020).

While classical RL assumes that an agent interacts with a time-invariant (stationary) environment, when deploying RL to real-world applications, both the reward function and Markov transition kernel can be time-varying. For example, in autonomous driving (Sallab et al., 2017), the vehicle needs to handle varying conditions of weather and traffic. When the environment changes with time, the agent must quickly adapt its policy to maximize the expected total rewards in the new environment. Meanwhile, another example of such a non-stationary scenario is when the environment is subject to adversarial manipulations, which is the case of adversarial attacks (Pinto et al., 2017; Huang et al., 2017; Pattanaik et al., 2017). In this situation, it is desired that the RL agent is robust against the malicious adversary.

Although there is a huge body of literature on developing provably efficient RL methods, most the existing works focus on the classical stationary setting, with a few exceptions include Jaksch et al. (2010); Gajane et al. (2018); Cheung et al. (2019a, c, 2020); Mao et al. (2020); Ortner et al. (2020); Domingues et al. (2020); Zhou et al. (2020c); Touati and Vincent (2020); Wei and Luo (2021). However, these works focus on value-based methods which only output deterministic/greedy policies, and mostly focus on the tabular case where the state space is finite. It is well-known that deterministic algorithms cannot tackle the adversarial rewards even in the bandit scenario (Lattimore and Szepesvári, 2020). In contrast, the policy optimization (EXP3-type) algorithms are ready to tackle the adversarial rewards in both bandits (Lattimore and Szepesvári, 2020) and RL (Cai et al., 2019; Efroni et al., 2020). Thus, motivated by the empirical successes and theoretical advantages of policy optimization
algorithms, it is desired to answer the following problem:
How can we design a provably efficient policy optimization algorithm for non-stationary environment in the context of function approximation?

There are five intertwined challenges associated with this problem: (i) non-stationary rewards with bandit feedback or even the adversarial rewards with full-information feedback. See Remark 3.2 for the reason why we only consider the full-information feedback adversarial rewards setting. (ii) non-stationary transition kernel, (iii) exploration-exploitation tradeoff that is inherent to online RL, (iv) incorporating function approximation in the algorithm, and (v) characterizing the convergence and optimality of policy optimization. Existing works merely address a subset of these four challenges and it remains open how to tackle all of them simultaneously. See Table 1 for detailed comparisons.

More importantly, these five challenges are coupled together, which requires sophisticated algorithm design. In particular, due to challenges (i), (ii) and (iv), we need to track the nonstationary or even adversarial reward function and transition kernel by function estimation based on the feedbacks. The estimated model is also time-varying and thus the corresponding policy optimization problem (challenge (v)) has a non-stationary objective function. Moreover, to obtain sample efficiency, we need to strike a balance between exploration and exploitation in the policy update steps (challenge (iii)).

In this work, we propose a periodically restarted optimistic policy optimization algorithm (PROPO) which successfully tackle the four challenges above. Specifically, we focus on the model of episodic linear kernel MDP (Ayoub et al., 2020; Zhou et al., 2020b) where both the reward and transition functions are parameterized by linear functions. Besides, we focus on the non-stationary setting and adopt the dynamic regret as the performance metric. Moreover, PROPO performs a policy evaluation step and a policy improvement step in each iteration. To handle challenges (i)-(iii), we propose a novel optimistic policy evaluation method that incorporates the technique of sliding window to handle non-stationarity. Specifically, based on the non-stationary bandit feedbacks, we propose to estimate the timevarying model via a sliding-window-based least-squares regression problem, where we only keep a subset of recent samples in regression. Based on the model estimator, we construct an optimistic value function by implementing model-based policy evaluation and adding an exploration bonus. Then, using such an optimistic value function as the update direction,

Table 1: (I) represents previous optimistic-based value iteration algorithms (Jiang et al., 2017; Jin et al., 2019b; Wang et al., 2019b; Zanette et al., 2020; Wang et al., 2020; Ayoub et al., 2020; Zhou et al., 2020b) that successfully handles the exploration-exploitation tradeoff that is inherent to online RL and incorporate function approximation in the algorithm; (II) denotes the policy optimization algorithms (Cai et al., 2019; Efroni et al., 2020) that can additionally tackle the adversarial rewards with full information feedback; (III) are the value-based algorithms (Cheung et al., 2019a,c; Mao et al., 2020) that can handles the nonstationary environments, and (IV) are the value-based algorithms (Zhou et al., 2020c; Touati and Vincent, 2020; Wei and Luo, 2021) incorporating function approximation. (V) is the policy optimization algorithm in Fei et al. (2020) that can tackle the adversarial rewards. However, they assumes the transition kernels are static, which circumvents the fundamental difficulties in non-stationarity RL. Furthermore, they only consider the tabular case.
in the policy improvement step, we propose to obtain a new policy by solving a KullbackLeibler (KL) divergence regularized problem, which can be viewed as a mirror descent step. Moreover, as the underlying optimal policy is time-varying (challenge (v)), we additionally restart the policy periodically by setting it to uniform policy every $\tau$ episodes. The two novel mechanisms, sliding window and periodic restart, respectively enable us to track the nonstationary MDP based on bandit feedbacks and handle the time-varying policy optimization problem.

Finally, to further exhibit effect of these two mechanisms, we propose an optimism-based value iteration algorithm, dubbed as SW-LSVI-UCB, which only utilize the sliding window
and does not restart the policy as challenge (v) disappears.

### 1.1 Our Contributions

Our contribution is four-fold. First, we propose PROPO, a policy optimization algorithm designed for non-stationary linear kernel MDPs. This algorithm features two novel mechanisms, namely sliding window and periodic restart, and also incorporates linear function approximation and a bonus function to incentivize exploration. Second, we prove that PROPO achieves a dynamic regret sublinear in $d, \Delta, H, T$, and $P_{T}$. Here $d$ is the feature dimension, $\Delta$ is the total variation budget, $H$ is the episode horizon, $T$ is the total number of steps, and $P_{T}$ is the variation budget of adjacent optimal policies. Third, to separately demonstrate the effect of sliding window, we propose a value-iteration algorithm, SW-LSVI-UCB, which adopts sliding-window-based regression to handle non-stationarity. Such an algorithm is shown to achieve a similar sublinear dynamic regret. Finally, we establish a $\Omega\left(d^{5 / 6} \Delta^{1 / 3} H^{2 / 3} T^{2 / 3}\right)$ lower bound on the dynamic regret, which shows the (near-)optimality of the proposed algorithms. To our best knowledge, PROPO is the first provably efficient policy optimization algorithm under the non-stationary environment.

### 1.2 Related Work

Our work adds to the vast body of existing literature on non-stationary MDPs. A line of work studies non-stationary RL in the tabular setting. See Jaksch et al. (2010); Gajane et al. (2018); Cheung et al. (2019a,c, 2020); Fei et al. (2020); Mao et al. (2020); Ortner et al. (2020) and the references therein for details. Recently, Domingues et al. (2020) consider the non-stationary RL in continuous environments and proposes a kernel-based algorithm. More related works are Zhou et al. (2020c); Touati and Vincent (2020), which study nonstationary linear MDPs, but their setting is not directly comparable with ours since linear MDPs cannot imply linear kernel MDPs. Moreover, Zhou et al. (2020c); Touati and Vincent (2020) do not incorporate policy optimization methods, which are more difficult because we need to handle the variation of the optimal policies of adjacent episodes and value-based methods only need to handle the non-stationarity drift of reward functions and transition kernels. Fei et al. (2020) also makes an attempt to investigate policy optimization algorithm for non-stationary environments. However, this work requires full-information feedback and
only focuses on the tabular MDPs with time-varying reward functions and time-invariant transition kernels.

As a special case of MDP problems with unit horizon, bandit problems have also been the subject of intense recent interest. See Besbes et al. (2014, 2019); Russac et al. (2019); Cheung et al. (2019a); Chen et al. (2019) and the references therein for details.

Another line closely related to our work is policy optimization. As proved in Yang et al. (2019); Agarwal et al. (2019); Liu et al. (2019); Wang et al. (2019a), policy optimization enjoys computational efficiency. Recently Cai et al. (2019); Efroni et al. (2020); Agarwal et al. (2020) proposed optimistic policy optimization methods which simultaneously attain computational efficiency and sample efficiency. Our work is also related to the value-based methods, especially LSVI (Bradtke and Barto, 1996; Jiang et al., 2017; Jin et al., 2019b; Wang et al., 2019b; Zanette et al., 2020; Wang et al., 2020; Ayoub et al., 2020; Zhou et al., 2020b).

Broadly speaking, our work is also related to a line of research on adversarial MDPs (Even-Dar et al., 2009; Neu et al., 2010, 2012; Zimin and Neu, 2013; Rosenberg and Mansour, 2019; Jin et al., 2019a). But most of this work studies static regret, which is easier than the dynamic regret.

### 1.3 Notation

We denote by $\|\cdot\|_{2}$ the $\ell_{2}$-norm of a vector or the spectral norm of a matrix. Furthermore, for a positive definite matrix $A$, we denote by $\|x\|_{A}$ the matrix norm $\sqrt{x^{\top} A x}$ of a vector $x$. For any number $a$, we denote $\lceil a\rceil$ the smallest integer that is no smaller than $a$, and $\lfloor a\rfloor$ the largest integer no larger than $a$. Also, for any two numbers $a$ and $b$, let $a \vee b=\max \{a, b\}$ and $a \wedge b=\min \{a, b\}$. For some positive integer $K,[K]$ denotes the index set $\{1,2, \cdots, K\}$. When logarithmic factors are omitted, we use $\widetilde{O}$ to denote function growth.

## 2 Preliminaries

### 2.1 Non-stationary MDPs

An episodic non-stationary MDP is defined by a tuple $(\mathcal{S}, \mathcal{A}, H, P, r)$, where $\mathcal{S}$ is a state space, $\mathcal{A}$ is an action space, $H$ is the length of each episode, $P=\left\{P_{h}^{k}\right\}_{(k, h) \in[K] \times[H], r}=$
$\left\{r_{h}^{k}\right\}_{(k, h) \in[K] \times[H]}$, where $P_{h}^{k}: \mathcal{S} \times \mathcal{A} \times \mathcal{S} \rightarrow[0,1]$ is the probability transition kernel at the $h$-th step of the $k$-th episode, and $r_{h}^{k}: \mathcal{S} \times \mathcal{A} \rightarrow[0,1]$ is the reward function at the $h$-th step of the $k$-th episode. We consider an agent which iteratively interacts with a non-stationary MDP in a sequence of $K$ episodes. At the beginning of the $k$-th episode, the initial state $s_{1}^{k}$ is a fixed state $s_{1}{ }^{1}$, and the agent determines a policy $\pi^{k}=\left\{\pi_{h}^{k}\right\}_{h=1}^{H}$. Then, at each step $h \in[H]$, the agent observes the state $s_{h}^{k}$, takes an action following the policy $a_{h}^{k} \sim \pi_{h}^{k}\left(\cdot \mid s_{h}^{k}\right)$ and receives a bandit feedback $r_{h}^{k}\left(s_{h}^{k}, a_{h}^{k}\right)$ or the full-information feedback $r_{h}^{k}(\cdot, \cdot)^{2}$. Meanwhile, the MDP evolves into next state $s_{h+1}^{k} \sim P_{h}^{k}\left(\cdot \mid x_{h}^{k}, a_{h}^{k}\right)$. The $k$-th episode ends at state $s_{H+1}^{k}$, when this happens, no control action is taken and reward is equal to zero. We define the state and state-action value functions of policy $\pi=\left\{\pi_{h}\right\}_{h=1}^{H}$ recursively via the following Bellman equation:

where $\mathbb{P}_{h}^{k}$ is the operator form of the transition kernel $P_{h}^{k}(\cdot \mid \cdot, \cdot)$, which is defined as

for any function $f: \mathcal{S} \rightarrow \mathbb{R}$. Here $\langle\cdot, \cdot\rangle_{\mathcal{A}}$ denotes the inner product over $\mathcal{A}$.
In the literature of optimization and reinforcement learning, the performance of the agent is measured by its dynamic regret, which measures the difference between the agent's policy and the benchmark policy $\pi^{*}=\left\{\pi^{*, k}\right\}_{k=1}^{K}$. Specifically, the dynamic regret is defined as

where $T=H K$ is the number of steps taken by agent and $\pi^{*, k}$ is the benchmark policy of episode $k$. It is worth mentioning that when the benchmark policy is the optimal policy of each individual episode, that is, $\pi^{*, k}=\operatorname{argmax}_{\pi} V_{1}^{\pi, k}\left(s_{1}^{k}\right)$, the dynamic regret reaches the maximum, and this special case is widely considered in previous works (Cheung et al., 2020; Mao et al., 2020; Domingues et al., 2020). Throughout the paper, when $\pi^{*}$ is clear from the context, we may omit $\pi^{*}$ from $\operatorname{D-Regret}\left(T, \pi^{*}\right)$.

### 2.2 Model Assumptions

We focus on the linear setting of Markov decision process, where the reward functions and transition kernels are assumed to be linear. We formally make the following assumption.

Assumption 2.1 (Non-stationary Linear Kernel MDP). MDP $(\mathcal{S}, \mathcal{A}, H, P, r)$ is a linear kernel MDP with known feature maps $\phi: \mathcal{S} \times \mathcal{A} \rightarrow \mathbb{R}^{d}$ and $\psi: \mathcal{S} \times \mathcal{A} \times \mathcal{S} \rightarrow \mathbb{R}^{d}$, if for any $(k, h) \in[K] \times[H]$, there exist unknown vectors $\theta_{h}^{k} \in \mathbb{R}^{d}$ and $\xi_{h} \in \mathbb{R}^{d}$, such that

r_{h}^{k}(s, a)=\phi(s, a)^{\top} \theta_{h}^{k}, \quad P_{h}^{k}\left(s^{\prime} \mid s, a\right)=\psi\left(s, a, s^{\prime}\right)^{\top} \xi_{h}^{k}
$$

for any $\left(s, a, s^{\prime}\right) \in \mathcal{S} \times \mathcal{A} \times \mathcal{S}$. Without loss of generality, we assume that

\|\phi(s, a)\|_{2} \leq 1, \quad\left\|\theta_{h}^{k}\right\|_{2} \leq \sqrt{d}, \quad\left\|\xi_{h}^{k}\right\|_{2} \leq \sqrt{d}
$$

for any $(k, h) \in[K] \times[H]$. Moreover, we assume that

$$
\int_{\mathcal{S}}\left\|\psi\left(s, a, s^{\prime}\right)\right\|_{2} \mathrm{~d} s^{\prime} \leq \sqrt{d}
$$

for any $(s, a) \in \mathcal{S} \times \mathcal{A}$.

Our assumption consists of two parts. One is about reward functions, which follows the setting of linear bandits (Abbasi-Yadkori et al., 2011; Agrawal and Goyal, 2013; Besbes et al., 2014, 2015; Cheung et al., 2019a,b). The other part is about transition kernels. As shown in Cai et al. (2019); Ayoub et al. (2020); Zhou et al. (2020b), linear kernel MDPs as defined above cover several other MDPs studied in previous works, as special cases. For example, tabular MDPs with canonical basis (Cai et al., 2019; Ayoub et al., 2020; Zhou et al., 2020b), feature embedding of transition models (Yang and Wang, 2019a) and linear combination of base models (Modi et al., 2020) are special cases. However, it is worth mentioning that Jin et al. (2019b); Yang and Wang (2019b) studied another "linear MDPs", which assumes the transition kernels can be represented as $\mathbb{P}_{h}\left(s^{\prime} \mid s, a\right)=\psi^{\prime}(s, a)^{\top} \mu_{h}\left(s^{\prime}\right)$ for any $h \in[H]$ and $\left(s, a, s^{\prime}\right) \in \mathcal{S} \times \mathcal{A} \times \mathcal{S}$. Here $\psi^{\prime}(\cdot, \cdot)$ is a known feature map and $\mu(\cdot)$ is an unknown measure. It is worth noting that linear MDPs studied in our paper and linear MDPs (Jin et al., 2019b; Yang and Wang, 2019b) are two different classes of MDPs since their feature maps $\psi(\cdot, \cdot, \cdot)$ and $\psi^{\prime}(\cdot, \cdot)$ are different and neither class of MDPs includes the other.

To facilitate the following analysis, we denote by $P_{h}^{k, \pi}$ the Markov kernel of policy at the $h$-step of the $k$-th episode, that is, for $s \in \mathcal{S}, P_{h}^{k, \pi}(\cdot \mid s)=\sum_{a \in \mathcal{A}} P_{h}^{k}(\cdot \mid s, a) \cdot \pi_{h}(a \mid s)$. Also,
we define

\left\|\pi_{h}-\pi_{h}^{\prime}\right\|_{\infty, 1} & =\max _{s \in \mathcal{S}}\left\|\pi_{h}(\cdot \mid s)-\pi_{h}^{\prime}(\cdot \mid s)\right\|_{1} \\
\left\|P_{h}^{k, \pi}-P_{h}^{k, \pi^{\prime}}\right\|_{\infty, 1} & =\max _{s \in \mathcal{S}}\left\|P_{h}^{k, \pi}(\cdot \mid s)-P_{h}^{k, \pi^{\prime}}(\cdot \mid s)\right\|_{1}
\end{aligned}
$$

Next, we introduce several measures of change in MDPs. First, we denote by $P_{T}$ the total variation in the benchmark policies of adjacent episodes:

P_{T}=\sum_{k=1}^{K} \sum_{h=1}^{H}\left\|\pi_{h}^{*, k}-\pi_{h}^{*, k-1}\right\|_{\infty, 1} \tag{2.4}

where we choose $\pi_{h}^{*, 0}=\pi_{h}^{*, 1}$ for any $h \in[H]$.
Next, we assume the drifting environment (Besbes et al., 2014, 2015; Cheung et al., 2019a; Russac et al., 2019), that is, $\theta_{h}^{k}$ and $\xi_{h}^{k}$ can change over different indexes ( $k, h$ ), with the constraint that the sum of the Euclidean distances between consecutive $\theta_{h}^{k}$ and $\xi_{h}^{k}$ are bounded by variation budgets $B_{T}$ and $B_{P}$. Formally, we impose the following assumption.

Assumption 2.2. There exists some variation budget $B_{T}=\mathcal{O}\left(T^{\nu_{1}}\right)$ and $B_{P}=\mathcal{O}\left(T^{\nu_{2}}\right)$ for some $\nu_{1} \in(0,1]$ and $\nu_{2} \in(0,1)$, such that

where $H$ is the length of each episode, $K$ is the total number of episodes, and $T=H K$ is the total number of steps taken by the agent. Here $\Delta$ is the total variation budget, which quantifies the non-stationarity of a linear kernel MDP. We remark that when the reward functions are adversarially chosen, $\nu_{1}$ can be 1 .

## 3 Minimax Lower Bound

In this section, we provide the information-theoretical lower bound result. The following theorem shows a minimax lower bound of dynamic regret for any algorithm to learn nonstationary linear kernel MDPs.

Theorem 3.1 (Minimax lower bound). Fix $\Delta>0, H>0, d \geq 2$, and $T=\Omega\left(d^{5 / 2} \Delta H^{1 / 2}\right)$. Then, there exists a non-stationary linear kernel MDP with a $d$-dimensional feature map
and maximum total variation budget $\Delta$, such that,

\min _{\mathbb{A}} \max _{\pi^{*}} \operatorname{D-Regret}\left(T, \pi^{*}\right) \geq \Omega\left(d^{5 / 6} \Delta^{1 / 3} H^{2 / 3} T^{2 / 3}\right)
$$

where $\mathbb{A}$ denotes the learning algorithm which has only the access to the bandit feedback.

Proof sketch. As mentioned above, we only need to establish the lower bound of the dynamic regret when the benchmark policy is the optimal policy of each individual episode. The proof of lower bound relies on the construction of a hard-to-learn non-stationary linear kernel MDP instance. To handle the non-stationarity, we need to divide the total $T$ steps into $L$ segments, where each segment contains $T_{0}=\left\lfloor\frac{T}{L}\right\rfloor$ steps and has $K_{0}=\left\lfloor\frac{K}{L}\right\rfloor$ episodes. Within each segment, the construction of MDP is similar to the hard-to-learn instance constructed in stationary RL problems (Jaksch et al., 2010; Lattimore and Hutter, 2012; Osband and Van Roy, 2016). Then, we can derive a lower bound of $\Omega\left(d H \sqrt{T_{0}}\right)$ for the stationary RL problem. Meanwhile, the transition kernel of this hard-to-learn MDP changes abruptly between two consecutive segments, which forces the agent to learn a new stationary MDP in each segment. Finally, by optimization $L$ subject to the total budget constraint, we obtain the lower bound of $\Omega\left(d^{5 / 6} \Delta^{1 / 3} H^{2 / 3} T^{2 / 3}\right)$. See Appendix B for details.

Remark 3.2. This theorem states that the non-stationary MDP with $\Delta=\Omega(T)$ is unlearnable. Thus, when reward functions are adversarially chosen, there is no algorithm can efficient solve the underlying MDPs with only the bandit feedback. However, if we can obtain the full-information feedback, solving non-stationary MDPs with adversarial rewards is possible. In Section 4, we will show that, under the non-stationary environments, our policy optimization algorithm can tackle the adversarial rewards with full-information feedbacks.

## 4 Algorithm and Theory

### 4.1 PROPO

Now we present Periodically Restarted Optimistic Policy Optimization (PROPO) in Algorithm 1 , which includes a policy improvement step and a policy evaluation step.

Policy Improvement Step. At $k$-th episode, Model-Based OPPO updates $\pi^{k}=\left\{\pi_{h}^{k}\right\}_{h=1}^{H}$ according to $\pi^{k-1}=\left\{\pi_{h}^{k-1}\right\}_{h=1}^{H}$. Motivated by the policy improvement step in NPG (Kakade,
2002), TRPO (Schulman et al., 2015), and PPO (Schulman et al., 2017), we consider the following policy improvement step

\pi^{k}=\underset{\pi}{\operatorname{argmax}} L_{k-1}(\pi), \tag{4.1}
\end{equation*}
$$

where $L_{k-1}(\pi)$ is defined as

L_{k-1}(\pi)=\mathbb{E}_{\pi^{k-1}} & {\left[\sum_{h=1}^{H}\left\langle Q_{h}^{k-1}\left(s_{h}, \cdot\right), \pi_{h}\left(\cdot \mid s_{h}\right)-\pi_{h}^{k-1}\left(\cdot \mid s_{h}\right)\right\rangle\right] }  \tag{4.2}\\
& -\alpha^{-1} \cdot \mathbb{E}_{\pi^{k-1}}\left[\sum_{h=1}^{H} \operatorname{KL}\left(\pi_{h}\left(\cdot \mid s_{h}\right) \| \pi_{h}^{k-1}\left(\cdot \mid s_{h}\right)\right)\right]
\end{align*}
$$

where $\alpha>0$ is a stepsize and $Q_{h}^{k-1}$ which is obtained in Line 10 of Algorithm 2 is the estimator of $Q_{h}^{\pi^{k-1}, k-1}$. Here the expectation $\mathbb{E}_{\pi^{k-1}}$ is taken over the random state-action pairs $\left\{\left(s_{h}, a_{h}\right)\right\}_{h=1}^{H}$, where the initial state $s_{1}=s_{1}^{k}$, the distribution of action $a_{h}$ follows $\pi\left(\cdot \mid s_{h}\right)$, and the distribution of the next state $s_{h+1}$ follows the transition dynamics $P_{h}^{k}\left(\cdot \mid s_{h}, a_{h}\right)$. Such a policy improvement step can also be regarded as one iteration of infinite-dimensional mirror descent (Nemirovsky and Yudin, 1983; Liu et al., 2019; Wang et al., 2019a).

By the optimality condition, policy update in (4.1) admits a closed-form solution

for any $s \in \mathcal{S}$ and $(k, h) \in[K] \times[H]$.
Policy Evaluation Step. At the end of the $k$-th episode, Model-Based OPPO evaluates the policy $\pi^{k}$ based on the $(k-1)$ historical trajectories. Then, we show the details of estimating the reward functions and transition kernels, respectively.
(i) Estimating Reward. To estimate the reward functions, we use the sliding window regularized least squares estimator (SW-RLSE) (Garivier and Moulines, 2011; Cheung et al., 2019a,b), which is a key tool in estimating the unknown parameters online. At $h$-th step of $k$ th episode, we aim to estimate the unknown parameter $\theta_{h}^{k}$ based on the historical observation $\left\{\left(s_{h}^{\tau}, a_{h}^{\tau}\right), r_{h}^{\tau}\left(s_{h}^{\tau}, a_{h}^{\tau}\right)\right\}_{\tau=1}^{k-1}$. The design of SW-RLSE is based on the "forgetting principle" (Garivier and Moulines, 2011), that is, under non-stationarity, the historical observations far in the past are obsolete, and they do not contain relevant information for the evaluation of the current policy. Therefore, we could estimate $\theta_{h}^{k}$ using only $\left\{\left(s_{h}^{\tau}, a_{h}^{\tau}\right), r_{h}^{\tau}\left(s_{h}^{\tau}, a_{h}^{\tau}\right)\right\}_{\tau=1 \vee(k-w)}^{k-1}$,
the observations during the sliding window $1 \vee(k-w)$ to $k-1$,

\widehat{\theta}_{h}^{k}=\underset{\theta}{\operatorname{argmin}}\left(\sum_{\tau=1 \vee(k-w)}^{k-1}\left(r_{h}^{\tau}\left(s_{h}^{\tau}, a_{h}^{\tau}\right)-\phi\left(s_{h}^{k}, a_{h}^{k}\right)^{\top} \theta\right)^{2}+\lambda \cdot\|\theta\|_{2}^{2}\right), \tag{4.4}
\end{equation*}

where $\lambda$ is the regularization parameter and $w$ is the length of a sliding window. By solving (4.4), we obtain the estimator of $\theta_{h}^{k}$ :

(ii) Estimating Transition. Similar to the estimation of reward functions, for any $(k, h) \in$ $[K] \times[H]$, we define the sliding window empirical mean-squared Bellman error (SW-MSBE) as

where $\lambda^{\prime}$ is the regularization parameter. By solving (4.7), we obtain

The policy evaluation step is iteratively updating the estimated Q-function $Q^{k}=\left\{Q_{h}^{k}\right\}_{h=1}^{H}$
by

in the order of $h=H, H-1, \cdots, 1$. Here bonus functions $B_{h}^{k}(\cdot, \cdot): \mathcal{S} \times \mathcal{A} \rightarrow \mathbb{R}^{+}$and $\Gamma_{h}^{k}(\cdot, \cdot): \mathcal{S} \times \mathcal{A} \rightarrow \mathbb{R}^{+}$are used to quantify the uncertainty in estimating reward $r_{h}^{k}$ and quantity $\mathbb{P}_{h}^{k} V_{h+1}^{k}$ respectively, defined as

where $\beta>0$ and $\beta^{\prime}>0$ are parameters depend on $d, H$ and $K$, which are specified in Theorem 4.2.

To handle the non-stationary drift incurred by the different optimal policies in different episodes, Algorithm 1 also includes a periodic restart mechanism, which resets the policy estimates every $\tau$ episodes. We call the $\tau$ episodes between every two resets a segment. In each segment, each episode is approximately the same as the first episode, which means that we can regard it as a stationary MDP. Then we can use the method of solving the stationary MDP to analyze each segment with a small error, and finally combine each segment and choose the value of $\tau$ to get the desired result. Such a restart mechanism is widely used in RL (Auer et al., 2009; Ortner et al., 2020), bandits (Besbes et al., 2014; Zhao et al., 2020), and non-stationary optimization (Besbes et al., 2015; Jadbabaie et al., 2015).

The pseudocode of the PROPO algorithm is given in Algorithm 1.
Learning Adversarial Rewards. We remark that PROPO is an EXP3-type algorithm, and thus can naturally tackle the adversarial rewards with full information. Specifically, we only need to replace the previous policy evaluation step in (4.9) by

where $\eta_{h}^{k}, \widehat{\xi}_{h}^{k}$, and $\Gamma_{h}^{k}$ are defined in (4.6), (4.8), and (4.10), respectively. For completeness, we provide the pseudocode in Appendix A. We remark that the value-based algorithm cannot tackle the adversarial rewards with full-information feedback with such a simple modification.

### 4.2 SW-LSVI-UCB

In this subsection, we present the details of Sliding Window Least-Square Value Iteration with UCB (SW-LSVI-UCB) in Algorithm 3.

Similar to Least-Square Value Iteration with UCB (LSVI-UCB) in Jin et al. (2019b), SW-LSVI-UCB is also an optimistic modification of Least-Square Value Iteration (LSVI) (Bradtke and Barto, 1996), where the optimism is realized by Upper-Confidence Bounds (UCB). Specifically, the optimism is achieved due to the bonus functions $B_{h}^{k}$ and $\Gamma_{h}^{k}$, which quantify the uncertainty of reward functions and transition kernels, respectively. It is worth noting that in order to handle the non-stationarity, SW-LSVI-UCB also uses the sliding window method (Garivier and Moulines, 2011; Cheung et al., 2019a,b).

In detail, at $k$-th episode, SW-LSVI-UCB consists of two steps. In the first step, by solving the sliding window least-square problems (4.4) and (4.7), SW-LSVI-UCB updates the parameters $\Lambda_{h}^{k}$ in (4.5), $\widehat{\theta}_{h}^{k}$ in (4.5), $A_{h}^{k}$ in (4.8), and $\widehat{\xi}_{h}^{k}$ in (4.8), which are used to form the Q-function $Q_{h}^{k}$. In the second step, SW-LSVI-UVB obtains the greedy policy with respect to the Q-function $Q_{h}^{k}$ gained in the first step. See Algorithm 3 for more details.

### 4.3 Regret Analysis

In this subsection, we analyze the dynamic regret incurred by Algorithms 1 and 3 and compare the theoretical regret upper bounds derived for these two algorithms. To derive sharper dynamic regret bounds, we impose the following technical assumption.

Assumption 4.1. There exists an orthonormal basis $\Psi=\left(\Psi_{1}, \cdots, \Psi_{d}\right)$ such that for any $(s, a) \in \mathcal{S} \times \mathcal{A}$, there exists a vector $z \in \mathbb{R}^{d}$ satisfying that $\phi(s, a)=\Psi z$. We also assume the existence of another orthonormal basis $\Psi^{\prime}=\left(\Psi_{1}^{\prime}, \cdots, \Psi_{d}^{\prime}\right)$ such that for any $(s, a, k, h) \in$ $\mathcal{S} \times \mathcal{A} \times[K] \times[H]$ such that $\eta_{h}^{k}(s, a)=\Psi^{\prime} z^{\prime}$ for some $z^{\prime} \in \mathbb{R}^{d}$.

It is not difficult to show that this assumption holds in the tabular setting, where the state space and action space are finite. Similar assumption is also adopted by previous work in non-stationary optimization (Cheung et al., 2019a).

First, we establish an upper bound on the dynamic regret of PROPO. Recall that the dynamic regret is defined in (2.3) and $d$ is the dimension of the feature maps $\phi$ and $\psi$. Also,

Let $\tau=\Pi_{[1, K]}\left(\left\lfloor\left(\frac{T \sqrt{\log \mid \mathcal{A |}}}{H\left(P_{T}+\sqrt{d} \Delta\right)}\right)^{2 / 3}\right\rfloor\right), \alpha=\sqrt{\rho \log |\mathcal{A}| /\left(H^{2} K\right)}$ in $(4.2), w=\Theta\left(d^{1 / 3} \Delta^{-2 / 3} T^{2 / 3}\right)$ in (4.4), $\lambda=\lambda^{\prime}=1$ in (4.4) and (4.9), $\beta=\sqrt{d}$ in (4.10), and $\beta^{\prime}=C^{\prime} \sqrt{d H^{2} \cdot \log (d T / \zeta)}$ in (4.10), where $C^{\prime}>1$ is an absolute constant and $\zeta \in(0,1]$. We have

D-Regret $(T) \lesssim d^{5 / 6} \Delta^{1 / 3} H T^{2 / 3} \cdot \log (d T / \zeta)$

$$
+\left\{\begin{array}{cl}
\sqrt{H^{3} T \log |\mathcal{A}|}, & \text { if } 0 \leq P_{T}+\sqrt{d} \Delta \leq \sqrt{\frac{\log |\mathcal{A}|}{K}}, \\
\left(H^{2} T \sqrt{\log |\mathcal{A}|}\right)^{2 / 3}\left(P_{T}+\sqrt{d} \Delta\right)^{1 / 3}, & \text { if } \sqrt{\frac{\log |\mathcal{A}|}{K}} \leq P_{T}+\sqrt{d} \Delta \lesssim K \sqrt{\log |\mathcal{A}|}, \\
H^{2}\left(P_{T}+\sqrt{d} \Delta\right), & \text { if } P_{T}+\sqrt{d} \Delta \gtrsim K \sqrt{\log |\mathcal{A}|},
\end{array}\right.
$$

with probability at least $1-\zeta$.
Proof. See Section 5 for a proof sketch and Appendix E. 1 for a detailed proof.
Then we discuss the regret bound throughout three regimes of $P_{T}+\sqrt{d} \Delta$ :

- Small $P_{T}+\sqrt{d} \Delta$ : when $0 \leq P_{T}+\sqrt{d} \Delta \leq \sqrt{\frac{\log |\mathcal{A}|}{K}}$, restart period $\tau=K$, which means that we do not need to periodically restart in this case. Assuming that $\log |\mathcal{A}|=$ $\mathcal{O}\left(d^{5 / 3} \Delta^{2 / 3} H^{-1} T^{1 / 3}\right)$, Algorithm 1 attains a $\widetilde{\mathcal{O}}\left(d^{5 / 6} \Delta^{1 / 3} H T^{2 / 3}\right)$ dynamic regret. Combined with the lower bound established in Theorem 3.1, our result matches the lower bound in $d, \Delta$ and $T$ up to logarithmic factors. Hence, we can conclude that Algorithm 1 is a near-optimal algorithm;
- Moderate $P_{T}+\sqrt{d} \Delta$ : when $\sqrt{\frac{\log |\mathcal{A}|}{K}} \leq P_{T}+\sqrt{d} \Delta \lesssim K \sqrt{\log |\mathcal{A}|}$, restart period $\tau=$ $\left(\frac{T \sqrt{\log |\mathcal{A}|}}{H\left(P_{T}+\sqrt{d} \Delta\right)}\right)^{2 / 3} \in[2, K]$. Algorithm 2 incurs a $\widetilde{\mathcal{O}}\left(T^{2 / 3}\right)$ dynamic regret if $\Delta=\mathcal{O}(1)$ and $P_{T}=\mathcal{O}(1)$;
- Large $P_{T}+\sqrt{d} \Delta$ : when $P_{T}+\sqrt{d} \Delta \gtrsim K \sqrt{\log |\mathcal{A}|}$, restart period $\tau=K$. Since the model is highly non-stationary, we only obtain a linear regret in $T$.

Notably, when the reward functions' total variation budget $\Delta_{T}$ defined in Assumption 2.2 is linear in $T$, we know $\Delta \geq \Delta_{T}=\Omega(T)$, then the regret bound in Theorem 4.2 becomes vacuous. Under this scenario, if we have the access to the full-information feedback of rewards, we can obtain the following theorem.

Theorem 4.3 (Informal). For the MDPs with adversarial rewards and non-stationary transitions, if the full-information feedback of rewards is available, then the dynamic regret of PROPO is bounded by

D-Regret $(T) \lesssim d^{5 / 6} \Delta^{1 / 3} H T^{2 / 3} \cdot \log (d T / \zeta)$

$$
+\left\{\begin{array}{cl}
\sqrt{H^{3} T \log |\mathcal{A}|}, & \text { if } 0 \leq P_{T}+\sqrt{d} \Delta_{P} \leq \sqrt{\frac{\log |\mathcal{A}|}{K}}, \\
\left(H^{2} T \sqrt{\log |\mathcal{A}|}\right)^{2 / 3}\left(P_{T}+\sqrt{d} \Delta_{P}\right)^{1 / 3}, & \text { if } \sqrt{\frac{\log |\mathcal{A}|}{K}} \leq P_{T}+\sqrt{d} \Delta_{P} \lesssim K \sqrt{\log |\mathcal{A}|} \\
H^{2}\left(P_{T}+\sqrt{d} \Delta_{P}\right), & \text { if } P_{T}+\sqrt{d} \Delta_{P} \gtrsim K \sqrt{\log |\mathcal{A}|},
\end{array}\right.
$$

with probability at least $1-\zeta$.
Proof. See Appendix A for detailed description and proof.

In the following theorem, we establish the upper bound of dynamic regret incurred by SW-LSVI-UCB (Algorithm 3).

Theorem 4.4 (Upper bound for Algorithm 3). Suppose Assumption 2.1, 2.2, and 4.1 hold. Let $w=\Theta\left(d^{1 / 3} \Delta^{-2 / 3} T^{2 / 3}\right)$ in (4.4), $\lambda=\lambda^{\prime}=1$ in (4.4) and (4.9), $\beta=\sqrt{d}$ in (4.10), and $\beta^{\prime}=C^{\prime} \sqrt{d H^{2} \cdot \log (d T / \zeta)}$ in (4.10), where $C^{\prime}>1$ is an absolute constant and $\zeta \in(0,1]$. We have

$$
\text { D-Regret }(T) \lesssim d^{5 / 6} \Delta^{1 / 3} H T^{2 / 3} \cdot \log (d T / \zeta)
$$

with probability at least $1-\zeta$.
Proof. See Appendix E. 3 for a detailed proof.
Comparison. Compared with PROPO, SW-LSVI-UCB achieves a slightly better regret without the help of the periodic restart mechanism. Especially in the highly non-stationary case, that is $P_{T}+\sqrt{d} \Delta \gtrsim K \sqrt{\log |\mathcal{A}|}$, SW-LSVI-UCB achieves a $\widetilde{\mathcal{O}}\left(T^{2 / 3}\right)$ regret, where PROPO only attains a linear regret in $T$. However, PROPO achieves the same $\widetilde{\mathcal{O}}\left(T^{2 / 3}\right)$ regret as SW-LSVI-UCB when $P_{T}+\sqrt{d} \Delta \lesssim K \sqrt{\log |\mathcal{A}|}$, which suggests that PROPO is provably efficient for solving slightly or even moderately non-stationary MDPs. Meanwhile, PROPO are ready to tackle the adversarial rewards with full-information feedback.

Optimality of the Bounds. There is only a gap of $H^{1 / 3}$ between the sharper upper bound and the lower bound in Theorem 3.1. We conjecture that this gap can be bridged by using the "Bernstein" type bonus functions Azar et al. (2017); Jin et al. (2018); Zhou et al. (2020a). Since our focus is on designing a provably efficient policy optimization algorithm for non-stationary linear kernel MDPs, we do not use this technique for the clarity of our analysis.

Results without Assumption 4.1. As stated before, Assumption 4.1 is helpful to derive sharp regret bounds. Next, we show that our algorithm are also efficient even without Assumption 4.1. Detailed proofs are deferred to Appendix F.1.

Theorem 4.5 (Upper bound for Algorithm 1). Suppose Assumptions 2.1 and 2.2 hold. Let $\tau=\Pi_{[1, K]}\left(\left\lfloor\left(\frac{T \sqrt{\log |\mathcal{A}|}}{H\left(P_{T}+\sqrt{d} \Delta\right)}\right)^{2 / 3}\right\rfloor\right), \alpha=\sqrt{\rho \log |\mathcal{A}| /\left(H^{2} K\right)}$ in (4.2), $w=\Theta\left(\Delta^{-1 / 4} T^{1 / 4}\right)$ in (4.4), $\lambda=\lambda^{\prime}=1$ in (4.4) and (4.9), $\beta=\sqrt{d}$ in (4.10), and $\beta^{\prime}=C^{\prime} \sqrt{d H^{2} \cdot \log (d T / \zeta)}$ in (4.10),
where $C^{\prime}>1$ is an absolute constant and $\zeta \in(0,1]$. We have
D-Regret $(T) \lesssim d \Delta^{1 / 4} H T^{3 / 4} \cdot \log (d T / \zeta)$

$$
+\left\{\begin{array}{cl}
\sqrt{H^{3} T \log |\mathcal{A}|}, & \text { if } 0 \leq P_{T}+\sqrt{d} \Delta \leq \sqrt{\frac{\log |\mathcal{A}|}{K}}, \\
\left(H^{2} T \sqrt{\log |\mathcal{A}|}\right)^{2 / 3}\left(P_{T}+\sqrt{d} \Delta\right)^{1 / 3}, & \text { if } \sqrt{\frac{\log |\mathcal{A}|}{K} \leq P_{T}+\sqrt{d} \Delta \lesssim K \sqrt{\log |\mathcal{A}|}}, \\
H^{2}\left(P_{T}+\sqrt{d} \Delta\right), & \text { if } P_{T}+\sqrt{d} \Delta \gtrsim K \sqrt{\log |\mathcal{A}|}
\end{array}\right.
$$

with probability at least $1-\zeta$.
Theorem 4.6 (Informal). For the MDPs with adversarial rewards and non-stationary transitions, if the full-information feedback is available, then the dynamic regret of PROPO is bounded by

D-Regret $(T) \lesssim d \Delta^{1 / 4} H T^{3 / 4} \cdot \log (d T / \zeta)$

$$
+\left\{\begin{array}{cl}
\sqrt{H^{3} T \log |\mathcal{A}|}, & \text { if } 0 \leq P_{T}+\sqrt{d} \Delta_{P} \leq \sqrt{\frac{\log |\mathcal{A}|}{K}}, \\
\left(H^{2} T \sqrt{\log |\mathcal{A}|}\right)^{2 / 3}\left(P_{T}+\sqrt{d} \Delta_{P}\right)^{1 / 3}, & \text { if } \sqrt{\frac{\log |\mathcal{A}|}{K} \leq P_{T}+\sqrt{d} \Delta_{P} \lesssim K \sqrt{\log |\mathcal{A}|}}, \\
H^{2}\left(P_{T}+\sqrt{d} \Delta_{P}\right), & \text { if } P_{T}+\sqrt{d} \Delta_{P} \gtrsim K \sqrt{\log |\mathcal{A}|}
\end{array}\right.
$$

with probability at least $1-\zeta$.
Theorem 4.7 (Upper bound for Algorithm 3). Suppose Assumptions 2.1 and 2.2 hold. Let $w=\Theta\left(\Delta^{-1 / 4} T^{1 / 4}\right)$ in (4.4), $\lambda=\lambda^{\prime}=1$ in (4.4) and (4.9), $\beta=\sqrt{d}$ in (4.10), and $\beta^{\prime}=C^{\prime} \sqrt{d H^{2} \cdot \log (d T / \zeta)}$ in (4.10), where $C^{\prime}>1$ is an absolute constant and $\zeta \in(0,1]$. We have

$$
\text { D-Regret }(T) \lesssim d \Delta^{1 / 4} H T^{3 / 4} \cdot \log (d T / \zeta)
$$

with probability at least $1-\zeta$.
Notably the term $\widetilde{\mathcal{O}}\left(d \Delta^{1 / 4} H T^{3 / 4}\right)$ appears in both the results in Theorems 4.5, 4.6, and 4.7. Ignoring logarithmic factors, there is a gap $\widetilde{\mathcal{O}}\left(d^{1 / 6} \Delta^{-1 / 12} H^{1 / 3} T^{1 / 12}\right)$ between our upper bounds and the lower bound $\Omega\left(d^{5 / 6} \Delta^{1 / 3} H^{2 / 3} T^{2 / 3}\right)$ established in Theorem 3.1. We also remark that most existing work (Cheung et al., 2020; Zhao and Zhang, 2021; Zhao et al., 2020; Russac et al., 2019; Zhou et al., 2020c; Touati and Vincent, 2020) can only obtain the similar bound $\widetilde{\mathcal{O}}\left(T^{3 / 4}\right)$ without additional assumption. The only exception is Wei and Luo (2021), which establishes the $\widetilde{\mathcal{O}}\left(T^{2 / 3}\right)$ regret upper bound. However, their algorithms cannot tackle the adversarial rewards.

## 5 Proof Sketch of Theorem 4.2

In this section, we sketch the proof of Theorem 4.2.
To facilitate the following analysis, we define the model prediction error as

l_{h}^{k}=r_{h}^{k}+\mathbb{P}_{h}^{k} V_{h+1}^{k}-Q_{h}^{k} \tag{5.1}
\end{equation*}
$$

which characterizes the error using $V_{h}^{k}$ to replace $V_{h}^{\pi_{k}, k}$ in the Bellman equation (2.1).

### 5.1 Proof Sketch of Theorem 4.2

Proof Sketch of Theorem 4.2. First, we decompose the regret of Algorithm 1 into two terms

$$
\operatorname{D-Regret}(T)=\mathcal{R}_{1}+\mathcal{R}_{2},
$$

where $\mathcal{R}_{1}=\sum_{k=1}^{K} V_{1}^{\pi^{*}, k}\left(s_{1}^{k}\right)-V_{1}^{k}\left(s_{1}^{k}\right)$ and $\mathcal{R}_{2}=\sum_{k=1}^{K} V_{1}^{k}\left(s_{1}^{k}\right)-V_{1}^{\pi^{k}, k}\left(s_{1}^{k}\right)$. Then we analyze $\mathcal{R}_{1}$ and $\mathcal{R}_{2}$ respectively. By Lemma C.1, we have

$$
\begin{aligned}
\mathcal{R}_{1}= & \sum_{i=1}^{\rho} \sum_{k=(i-1) \tau+1}^{i \tau} \sum_{h=1}^{H} \mathbb{E}_{\pi^{*, k}}\left[\left\langle Q_{h}^{k}\left(s_{h}, \cdot\right), \pi_{h}^{*, k}\left(\cdot \mid s_{h}\right)-\pi_{h}^{k}\left(\cdot \mid s_{h}\right)\right\rangle\right] \\
& +\sum_{i=1}^{\rho} \sum_{k=(i-1) \tau+1}^{i \tau} \sum_{h=1}^{H} \mathbb{E}_{\pi^{*, k}}\left[l_{h}^{k}\left(s_{h}, a_{h}\right)\right] .
\end{aligned}
$$

Applying Lemma 5.2 to the first term, we obtain

$$
\begin{aligned}
& \sum_{i=1}^{\rho} \sum_{k=(i-1) \tau+1}^{i \tau} \sum_{h=1}^{H} \mathbb{E}_{\pi^{*, k}}\left[\left\langle Q_{h}^{k}\left(s_{h}, \cdot\right), \pi_{h}^{*, k}\left(\cdot \mid s_{h}\right)-\pi_{h}^{k}\left(\cdot \mid s_{h}\right)\right\rangle\right] \\
& \quad \leq \sqrt{2 H^{3} T \rho \log |\mathcal{A}|}+\tau H^{2}\left(P_{T}+\sqrt{d} \Delta\right)
\end{aligned}
$$

Meanwhile, as shown in Lemma C.1, we have

$$
\mathcal{R}_{2}=\mathcal{M}_{K, H, 2}-\sum_{i=1}^{\rho} \sum_{k=(i-1) \tau+1}^{i \tau} \sum_{h=1}^{H} l_{h}^{k}\left(s_{h}^{k}, a_{h}^{k}\right)
$$

Here $\mathcal{M}_{K, H, 2}$ is a martingale defined in Appendix C. Then by the Azuma-Hoeffding inequality, we obtain $\left|\mathcal{M}_{K, H, 2}\right| \leq \sqrt{16 H^{2} T \cdot \log (4 / \zeta)}$ with probability at least $1-\zeta / 2$. Here $\zeta \in(0,1]$ is a constant.

Now we only need to derive the bound of the quantity $\sum_{i=1}^{\rho} \sum_{k=(i-1) \tau+1}^{i \tau} \sum_{h=1}^{H}\left(\mathbb{E}_{\pi^{*, k}}\left[l_{h}^{k}\left(s_{h}, a_{h}\right)\right]-\right.$ $\left.l_{h}^{k}\left(s_{h}^{k}, a_{h}^{k}\right)\right)$. Applying the bound of $l_{h}^{k}$ in Lemma 5.3 to this quantity, it holds with probability
at least $1-\zeta / 2$ that

$$
\begin{aligned}
& \sum_{i=1}^{\rho} \quad \sum_{k=(i-1) \tau+1}^{i \tau} \sum_{h=1}^{H}\left(\left(\mathbb{E}_{\pi^{*, k}}\left[l_{h}^{k}\left(s_{h}, a_{h}\right)\right]-l_{h}^{k}\left(s_{h}^{k}, a_{h}^{k}\right)\right)\right. \\
& \quad \leq 2 \sum_{k=1}^{K} \sum_{h=1}^{H}\left(\sum_{i=1 \vee(k-w)}^{k-1}\left\|\theta_{h}^{i}-\theta_{h}^{i+1}\right\|_{2}+\sum_{i=1 \vee(k-w)}^{k-1}\left\|\xi_{h}^{i}-\xi_{h}^{i+1}\right\|_{2}+B_{h}^{k}(s, a)+\Gamma_{h}^{k}(s, a)\right) .
\end{aligned}
$$

Then we apply Lemmas G. 1 and G. 2 to bound this quantity by $2 w \Delta H \sqrt{d}+8 d T \sqrt{\log (w) / w}+$ $8 C^{\prime} d T H \cdot \sqrt{\log \left(w H^{2} d\right) / w} \cdot \log (d T / \zeta)$, where $C^{\prime}$ is a constant specified in the detailed proof.

With the help of these bounds, we derive the regret bound in Theorem 4.2.

### 5.2 Online Mirror Descent Term

In this subsection, we establish the upper bound of the online mirror descent term.
The following lemma characterizes the policy improvement step defined in (4.1), where the updated policy $\pi^{k}$ takes the closed form in (4.3).

Lemma 5.1 (One-Step Descent). For any distribution $\pi$ on $\mathcal{A}$ and $\left\{\pi^{k}\right\}_{k=1}^{K}$ obtained in Algorithm 1, it holds that

$$
\begin{aligned}
& \alpha \cdot\left\langle Q_{h}^{k}, \pi_{h}(\cdot \mid s)-\pi^{k}(\cdot \mid s)\right\rangle \\
& \quad \leq \operatorname{KL}\left(\pi_{h}(\cdot \mid s) \| \pi_{h}^{k}(\cdot \mid s)\right)-\operatorname{KL}\left(\pi_{h}(\cdot \mid s) \| \pi_{h}^{k+1}(\cdot \mid s)\right)+\alpha^{2} H^{2} / 2
\end{aligned}
$$

Proof. See Appendix D. 1 for a detailed proof.

Based on Lemma 5.1, we establish an upper bound of online mirror descent term in the following lemma.

Lemma 5.2 (Online Mirror Descent Term). For the Q-functions $\left\{Q_{h}^{k}\right\}_{(k, h) \in[K] \times[H]}$ obtained in (4.9) and the policies $\left\{\pi_{h}^{k}\right\}_{(k, h) \in[K] \times[H]}$ obtained in (4.3), we have

$$
\begin{aligned}
& \sum_{i=1}^{\rho} \sum_{k=(i-1) \tau+1}^{i \tau} \sum_{h=1}^{H} \mathbb{E}_{\pi^{*}, k}\left[\left\langle Q_{h}^{k}\left(s_{h}, \cdot\right), \pi_{h}^{*, k}\left(\cdot \mid s_{h}\right)-\pi_{h}^{k}\left(\cdot \mid s_{h}\right)\right\rangle\right] \\
& \quad \leq \sqrt{2 H^{3} T \rho \log |\mathcal{A}|}+\tau H^{2}\left(P_{T}+\sqrt{d} \Delta\right)
\end{aligned}
$$

Proof. See Appendix D. 2 for a detailed proof.

### 5.3 Model Prediction Error Term

In this subsection, we characterize the model prediction errors arising from estimating reward functions and transition kernels.

Lemma 5.3 (Upper Confidence Bound). Under Assumptions 2.1 and 4.1, it holds with probability at least $1-\zeta / 2$ that

$$
\begin{gathered}
-2 B_{h}^{k}(s, a)-2 \Gamma_{h}^{k}(s, a)-\sum_{i=1 \vee(k-w)}^{k-1}\left\|\theta_{h}^{i}-\theta_{h}^{i+1}\right\|_{2}-H \sqrt{d} \cdot \sum_{i=1 \vee(k-w)}^{k-1}\left\|\xi_{h}^{i}-\xi_{h}^{i+1}\right\|_{2} \\
\leq l_{h}^{k}(s, a) \leq \sum_{i=1 \vee(k-w)}^{k-1}\left\|\theta_{h}^{i}-\theta_{h}^{i+1}\right\|_{2}+H \sqrt{d} \cdot \sum_{i=1 \vee(k-w)}^{k-1}\left\|\xi_{h}^{i}-\xi_{h}^{i+1}\right\|_{2}
\end{gathered}
$$

for any $(k, h) \in[K] \times[H]$ and $(s, a) \in \mathcal{S} \times \mathcal{A}$, where $w$ is the length of a sliding window defined in (4.5), $B_{h}^{k}(\cdot, \cdot)$ is the bonus function of reward defined in (4.10) and $\Gamma_{h}^{k}(\cdot, \cdot)$ is the bonus function of transition kernel defined in (4.10).

Proof. See Appendix D. 3 for a detailed proof.
Since our model is non-stationary, we cannot ensure that the estimated Q-function is "optimistic in the face of uncertainty" as $l_{h}^{k} \leq 0$ like the previous work (Jin et al., 2019b; Cai et al., 2019) in the stationary case. Thanks to the sliding window method, the model prediction error here can be upper bounded by the slight changes of parameters in the sliding window. Specifically, within the sliding window, the reward functions and transition kernels can be considered unchanged, which encourages us to estimate the Q-function by regression and UCB bonus, and thus achieve the optimism like the stationary case. However, reward functions and transition kernels are actually different in the sliding window, which leads to additional errors caused by parameter changes.

By giving the bound of the model prediction error $l_{h}^{k}$ defined in (5.1), Lemma 5.3 quantifies uncertainty and thus realizes sample-efficient. In detail, uncertainty is because we can only observe finite historical data and many state-action pairs $(s, a)$ are less visited or even unseen. The model prediction error of these state-action pairs may be large. However, as is shown in Lemma 5.3, the model prediction error $l_{h}^{k}$ can be bounded by the variation of sequences $\left\{\theta_{h}^{i}\right\}_{i=1 \vee(k-w)}^{k}$ and $\left\{\xi_{h}^{i}\right\}_{i=1 \vee(k-w)}^{k}$, together with the bonus functions $B_{h}^{k}$ and $\Gamma_{h}^{k}$ defined in (4.10), which helps us to derive the bound of the regret. See Appendix E. 1 for details.

## 6 Conclusion

In this work, we have proposed a probably efficient policy optimization algorithm, dubbed as PROPO, for non-stationary linear kernel MDPs. Such an algorithm incorporates a bonus function to incentivize exploration, and more importantly, adopts sliding-window-based regression in policy evaluation and periodic restart in policy update to handle the challenge of non-stationarity. Moreover, as a byproduct, we establish an optimistic value iteration algorithm, SW-LSVI-UCB, by combining UCB and sliding-window. We prove that PROPO and SW-LSVI-UCB both achieve sample efficiency by having sublinear dynamic regret. We also establish a dynamic regret lower bound which shows that PROPO and SW-LSVI-UCB are near-optimal. To our best knowledge, we propose the first provably efficient policy optimization method that successfully handles non-stationarity.

## B Proof of Theorem 3.1



Figure 1: The hard-to-learn linear kernel MDP constructed in the proof of Theorem 3.1. Note that the probability of state $x_{0}$ to state $x_{1}$ depends on the choice of action $a$.

Proof. To handle the non-stationarity, we divide the total $T$ steps into $L$ segments, where each segment has $K_{0}=\left\lfloor\frac{K}{L}\right\rfloor$ episodes and contains $T_{0}=H K_{0}=H\left\lfloor\frac{K}{L}\right\rfloor$ steps. Now we show the construction of a hard-to-learn MDP within each segment, the construction is similar to that used in previous works (Jaksch et al., 2010; Lattimore and Hutter, 2012; Osband and Van Roy, 2016; Zhou et al., 2020b). Consider an MDP as depicted in Figure 1. The state space $\mathcal{S}$ consists of two states $x_{0}$ and $x_{1}$. The action space $\mathcal{A}$ consists of $2^{d-1}$ vectors $a \in\{-1,1\}^{d-1}$, where $d \geq 2$ is the dimension of feature map $\psi$ defined in Assumption 2.1. The reward function does not depend on actions: state $x_{0}$ always gives reward 0 , and state $x_{1}$ always gives reward 1 , that is, for any $a \in \mathcal{A}$,

r\left(x_{0}, a\right)=0, \quad r\left(x_{1}, a\right)=1 .
$$

Choosing,
$\theta=(1 / d, 1 / d, \cdots, 1 / d)^{\top} \in \mathbb{R}^{d}, \phi\left(x_{0}, a\right)=(0,0, \cdots, 0)^{\top} \in \mathbb{R}^{d}, \phi\left(x_{1}, a\right)=(1,1, \cdots, 1)^{\top} \in \mathbb{R}^{d}$, for any $a \in \mathcal{A}$, it follows that $r(s, a)=\phi(s, a)^{\top} \theta$ for any $(s, a) \in \mathcal{S} \times \mathcal{A}$, and thus this reward is indeed linear. The probability transition $P_{\xi}$ is parameterized by a $(d-1)$-dimensional vector $\xi \in \Xi=\{-\epsilon /(d-1), \epsilon /(d-1)\}^{d-1}$, which is defined as

where $\delta>0$ and $\epsilon \in[0, d-1]$ are parameters which satisfy that $2 \epsilon \leq \delta \leq 1 / 3$. This MDP is indeed a linear kernel MDP with the $d$-dimensional vector $\widetilde{\xi}=\left(\xi^{\top}, 1\right)^{\top}$. Specifically, we can
define the feature map $\psi\left(s, a, s^{\prime}\right)$ as

\psi\left(x_{1}, a, x_{0}\right)=\left(\mathbf{0}^{\top}, \delta\right)^{\top}, & \psi\left(x_{1}, a, x_{1}\right)=\left(\mathbf{0}^{\top}, 1-\delta\right)^{\top},
\end{array}
$$

and it is not difficult to verify that $P_{\xi}\left(s^{\prime} \mid s, a\right)=\psi\left(s, a, s^{\prime}\right)^{\top} \widetilde{\xi}$.
Now we are ready to establish the lower bound in Theorem 3.1. By Yao's minimax principle (Yao, 1977), it is sufficient to consider deterministic policies. Hence, we assume that the policy $\pi$ obtained by the algorithm maps from a sequence of observations to an action deterministically. To facilitate the following proof, we introduce some notations. Let $N_{0}, N_{1}, N_{0}^{a}$ and $N_{0}^{\mathcal{A}^{\prime}}$ denote the total number of visits to state $x_{0}$, the total number of visits to $x_{1}$, the total number of visits to state $x_{0}$ followed by taking action $a$, and the total number of visits to state $x_{0}$ followed by taking an action in $\mathcal{A}^{\prime} \subseteq \mathcal{A}$, respectively. Let $\mathcal{P}_{\xi}(\cdot)$ denote the distribution over $\mathcal{S}^{T_{0}}$, where $s_{1}^{k}=x_{0}, s_{h+1}^{k} \sim P_{\xi}\left(\cdot \mid s_{h}^{k}, a_{h}^{k}\right), a_{h}^{k}$ is decided by $\pi_{h}^{k}$. We use $\mathbb{E}_{\xi}$ to denote the expectation with respect to $\mathcal{P}_{\xi}$.

Now we consider a segment that consists of $K_{0}$ episodes and each episode starts from state $x_{0}$. Let $s_{h}^{k}$ denote the state in the $h$-th state of the $k$-th episode. Fix $\xi \in \Xi$. We have,

\begin{align*}
\mathbb{E}_{\xi} N_{1} & =\sum_{k=1}^{K_{0}} \sum_{h=2}^{H} \mathcal{P}_{\xi}\left(s_{h}^{k}=x_{1}\right)=\sum_{k=1}^{K_{0}} \sum_{h=2}^{H} \mathcal{P}_{\xi}\left(s_{h}^{k}=x_{1}, s_{h-1}^{k}=x_{1}\right)+\sum_{k=1}^{K_{0}} \sum_{h=2}^{H} \mathcal{P}_{\xi}\left(s_{h}^{k}=x_{1}, s_{h-1}^{k}=x_{0}\right) \\
& =\underbrace{\sum_{k=1}^{K_{0}} \sum_{h=2}^{H} \mathcal{P}_{\xi}\left(s_{h}^{k}=x_{1} \mid s_{h-1}^{k}=x_{1}\right) \mathcal{P}_{\xi}\left(s_{h-1}^{k}=x_{1}\right)}_{(\mathrm{i})}+\underbrace{\sum_{k=1}^{K_{0}} \sum_{h=2}^{H} \mathcal{P}_{\xi}\left(s_{h}^{k}=x_{1}, s_{h-1}^{k}=x_{0}\right)}_{(\mathrm{ii})} . \tag{B.1}
\end{align*}
$$

By the construction of this hard-to-learn MDP, we have $\mathcal{P}_{\xi}\left(s_{h}^{k}=x_{1} \mid s_{h-1}^{k}=x_{1}\right)=1-\delta$, which implies that

(\mathrm{i}) & =(1-\delta) \cdot \sum_{k=1}^{K_{0}} \sum_{h=2}^{H} \mathcal{P}_{\xi}\left(s_{h-1}^{k}=x_{1}\right) \\
& =(1-\delta) \cdot \mathbb{E}_{\xi} N_{1}-(1-\delta) \cdot \sum_{k=1}^{K_{0}} \mathcal{P}_{\xi}\left(s_{H}^{k}=x_{1}\right) . \tag{B.2}
\end{align*}
$$

Meanwhile, we have

$$
\text { (ii) }=\sum_{k=1}^{K_{0}} \sum_{h=2}^{H} \sum_{a} \mathcal{P}_{\xi}\left(s_{h}^{k}=x_{1} \mid s_{h-1}^{k}=x_{0}, a_{h-1}^{k}=a\right) \cdot \mathcal{P}_{\xi}\left(s_{h-1}^{k}=x_{0}, a_{h-1}^{k}=a\right)
$$

By the fact that $\mathcal{P}_{\xi}\left(s_{h}^{k}=x_{1} \mid s_{h-1}^{k}=x_{0}, a_{h-1}^{k}=a\right)=\delta+\langle a, \xi\rangle$, we further obtain

$$
\begin{align*}
(\mathrm{ii}) & =\sum_{k=1}^{K_{0}} \sum_{h=2}^{H} \sum_{a}(\delta+\langle a, \xi\rangle) \cdot \mathcal{P}_{\xi}\left(s_{h-1}^{k}=x_{0}, a_{h-1}^{k}=a\right) \\
& =\sum_{a}(\delta+\langle a, \xi\rangle) \cdot\left(\mathbb{E}_{\xi} N_{0}^{a}-\sum_{k=1}^{K_{0}} \mathcal{P}_{\xi}\left(s_{H}^{k}=x_{0}, a_{H}^{k}=a\right)\right) . \tag{B.3}
\end{align*}
$$

Plugging (B.2) and (B.3) into (B.1) and rearranging gives

$$
\begin{align*}
\mathbb{E}_{\xi} N_{1} & =\sum_{a}(1+\langle a, \xi\rangle / \delta) \cdot \mathbb{E}_{\xi} N_{0}^{a}-\underbrace{\sum_{k=1}^{K_{0}}\left(\frac{1-\delta}{\delta} \cdot \mathcal{P}_{\xi}\left(s_{H}^{k}=x_{1}\right)+\sum_{a}\left(1+\frac{\langle a, \xi\rangle}{\delta}\right) \cdot \mathcal{P}_{\xi}\left(s_{H}^{k}=x_{0}, a_{H}^{k}=a\right)\right)}_{\Phi_{\xi}} \\
& =\mathbb{E}_{\xi} N_{0}+\delta^{-1} \cdot \sum_{a}\langle a, \xi\rangle \mathbb{E}_{\xi} N_{0}^{a}-\Phi_{\xi} . \tag{B.4}
\end{align*}
$$

By (B.4) and the fact that $\langle a, \xi\rangle \leq \epsilon$, we further have

\begin{align*}
\mathbb{E}_{\xi} N_{1} & =\mathbb{E}_{\xi} N_{0}+\delta^{-1} \cdot \sum_{a}\langle a, \xi\rangle \cdot \mathbb{E}_{\xi} N_{0}^{a}-\Phi_{\xi} \\
& \geq \mathbb{E}_{\xi} N_{0}-\frac{\epsilon}{\delta} \cdot \mathbb{E}_{\xi} N_{0}-\sum_{k=1}^{K_{0}}\left(\frac{1-\delta}{\delta} \mathcal{P}_{\xi}\left(s_{H}^{k}=x_{1}\right)+\left(1+\frac{\epsilon}{\delta}\right) \cdot \mathcal{P}_{\xi}\left(s_{H}^{k}=x_{0}\right)\right) \\
& =\left(1-\frac{\epsilon}{\delta}\right) \cdot \mathbb{E}_{\xi} N_{0}-\sum_{k=1}^{K_{0}}\left(\frac{1-\delta}{\delta}+\frac{\epsilon+2 \delta-1}{\delta} \cdot \mathcal{P}_{\xi}\left(s_{H}^{k}=x_{0}\right)\right) \\
& \geq\left(1-\frac{\epsilon}{\delta}\right) \cdot \mathbb{E}_{\xi} N_{0}-\frac{1-\delta}{\delta} \cdot K_{0}, \tag{B.5}
\end{align*}
$$

where the second equality uses the fact that $\mathcal{P}_{\xi}\left(s_{H}^{k}=x_{0}\right)+\mathcal{P}_{\xi}\left(s_{H}^{k}=x_{1}\right)=1$, and the last inequality holds since $\frac{\epsilon+2 \delta-1}{\delta} \cdot \mathcal{P}_{\xi}\left(s_{H}^{k}=x_{0}\right)$ is negative. Together with $N_{0}+N_{1}=T_{0}$, (B.5) implies that

\mathbb{E}_{\xi} N_{0} \leq \frac{T_{0}+(1-\delta) / \delta \cdot K_{0}}{2-\epsilon / \delta} \leq \frac{2 T_{0}}{3}+\frac{2}{3 \delta} K_{0}

where the last inequality follows from $2 \epsilon \leq \delta$ and $\delta>0$. Meanwhile, note that $\Phi_{\xi}$ is nonnegative because $\langle a, \xi\rangle \geq-\epsilon \geq-\delta$. Combined with the fact that $N_{0}+N_{1}=T_{0}$, (B.4) and $\Phi_{\xi} \geq 0$ imply that

& \leq \frac{T_{0}}{2}+\frac{\epsilon}{2 \delta(d-1)|\Xi|} \sum_{j=1}^{d-1} \sum_{a} \sum_{\xi} \mathbb{E}_{\xi}\left(\mathbf{1}\left\{\operatorname{sgn}\left(\xi_{j}\right)=\operatorname{sgn}\left(a_{j}\right)\right\}\right) N_{0}^{a} \tag{B.7}
\end{align*}
$$

where $\mathbf{1}\{\cdot\}$ is the indicator function. Here the last inequality uses the fact that $\langle a, \xi\rangle \leq$ $\frac{\epsilon}{d-1} \sum_{j=1}^{d-1} \mathbf{1}\left\{\operatorname{sgn}\left(\xi_{j}\right)=\operatorname{sgn}\left(a_{j}\right)\right\}$ for any $a \in \mathcal{A}$ and $\xi \in \Xi$. Fix $j \in[d-1]$. We define a new vector $g(\xi)$ as

Then, for any $a \in \mathcal{A}$ and $\xi \in \Xi$, we have

& \mathbb{E}_{\xi} \mathbf{1}\left\{\operatorname{sgn}\left(\xi_{j}\right)=\operatorname{sgn}\left(a_{j}\right)\right\} N_{0}^{a}+\mathbb{E}_{g(\xi)} \mathbf{1}\left\{\operatorname{sgn}\left(g(\xi)_{j}\right)=\operatorname{sgn}\left(a_{j}\right)\right\} N_{0}^{a} \\
& \quad=\mathbb{E}_{g(\xi)} N_{0}^{a}+\mathbb{E}_{\xi} \mathbf{1}\left\{\operatorname{sgn}\left(\xi_{j}\right)=\operatorname{sgn}\left(a_{j}\right)\right\} N_{0}^{a}-\mathbb{E}_{g(\xi)} \mathbf{1}\left\{\operatorname{sgn}\left(\xi_{j}\right)=\operatorname{sgn}\left(a_{j}\right)\right\} N_{0}^{a} \tag{B.8}
\end{align*}
$$

Taking summation of (B.8) over $a$ and $\xi$, and because $g(\xi)$ is uniformly distributed over $\Xi$ when $\xi$ is uniformly distributed over $\Xi$, we have

2 \sum_{a} & \sum_{\xi} \mathbb{E}_{\xi}\left(\mathbf{1}\left\{\operatorname{sgn}\left(\xi_{j}\right)=\operatorname{sgn}\left(a_{j}\right)\right\}\right) N_{0}^{a} \\
& =\sum_{\xi} \sum_{a}\left(\mathbb{E}_{g(\xi)} N_{0}^{a}+\mathbb{E}_{\xi} \mathbf{1}\left\{\operatorname{sgn}\left(\xi_{j}\right)=\operatorname{sgn}\left(a_{j}\right)\right\} N_{0}^{a}-\mathbb{E}_{g(\xi)} \mathbf{1}\left\{\operatorname{sgn}\left(\xi_{j}\right)=\operatorname{sgn}\left(a_{j}\right)\right\} N_{0}^{a}\right) \\
& =\sum_{\xi}\left(\mathbb{E}_{g(\xi)} N_{0}+\mathbb{E}_{\xi} N_{0}^{\mathcal{A}_{j}^{\xi}}-\mathbb{E}_{g(\xi)} N_{0}^{\mathcal{A}_{j}^{\xi}}\right), \tag{B.9}
\end{align*}
$$

where $\mathcal{A}_{j}^{\xi}=\left\{a: \operatorname{sgn}\left(\xi_{j}\right)=\operatorname{sgn}\left(a_{j}\right)\right\}$. By Lemma G. 4 and the fact that $N_{0}^{\mathcal{A}_{j}^{\xi}} \leq T_{0}$, we have

\mathbb{E}_{\xi} N_{0}^{\mathcal{A}_{j}^{\xi}}-\mathbb{E}_{g(\xi)} N_{0}^{\mathcal{A}_{j}^{\xi}} \leq \frac{c T_{0}}{16} \sqrt{\operatorname{KL}\left(\mathcal{P}_{g(\xi)} \| \mathcal{P}_{\xi}\right)} \tag{B.10}
\end{equation*}
$$

where $c=8 \sqrt{\log 2}$. Moreover, by Lemma G. 5 , we have

\operatorname{KL}\left(\mathcal{P}_{\xi^{\prime}} \| \mathcal{P}_{\xi}\right) \leq \frac{16 \epsilon^{2}}{(d-1)^{2} \delta} \mathbb{E}_{\xi} N_{0} \tag{B.11}
\end{equation*}
$$

Plugging (B.8), (B.9), (B.10) and (B.11) into (B.7), we obtain

\frac{1}{|\Xi|} \sum_{\xi} \mathbb{E}_{\xi} N_{1} & \leq \frac{T_{0}}{2}+\frac{\epsilon}{4 \delta(d-1)|\Xi|} \sum_{j=1}^{d-1} \sum_{\xi}\left(\mathbb{E}_{\xi^{\prime}} N_{0}+\frac{c T_{0} \epsilon}{2 d \sqrt{\delta}} \sqrt{\mathbb{E}_{\xi} N_{0}}\right) \\
& \leq \frac{T_{0}}{2}+\frac{\epsilon}{4 \delta(d-1)|\Xi|} \sum_{j=1}^{d-1} \sum_{\xi}\left(\frac{2 T_{0}}{3}+\frac{2}{3 \delta} K_{0}+\frac{c T_{0} \epsilon}{2 d \sqrt{\delta}} \sqrt{\frac{2 T_{0}}{3}+\frac{2}{3 \delta} K_{0}}\right) \\
& =\frac{T_{0}}{2}+\frac{\epsilon T_{0}}{6 \delta}+\frac{\epsilon K_{0}}{6 \delta^{2}}+\frac{c T_{0} \epsilon^{2}}{8 d \delta \sqrt{\delta}} \sqrt{\frac{2 T_{0}}{3}+\frac{2}{3 \delta} K_{0}} . \tag{B.12}
\end{align*}
$$

Note that for a given $\xi$, whether in state $x_{0}$ or $x_{1}$, the optimal policy is to choose $a_{\xi}=$ $\left[\operatorname{sgn}\left(\xi_{i}\right)\right]_{i=1}^{d-1}$. Hence, we can calculate the stationary distribution and find that the optimal average reward is $\frac{\delta+\epsilon}{2 \delta+\epsilon}$. Recall the definition of dynamic regret in (2.3), we have

\frac{1}{|\Xi|} \sum_{\xi} \mathbb{E}_{\xi} \mathrm{D}-\operatorname{Regret}\left(T_{0}\right) & \geq \frac{\delta+\epsilon}{2 \delta+\epsilon} \cdot T_{0}-\frac{1}{|\Xi|} \sum_{\xi} \mathbb{E}_{\xi} N_{1} \\
& \geq \frac{\delta+\epsilon}{2 \delta+\epsilon} \cdot T_{0}-\frac{T_{0}}{2}-\frac{\epsilon T_{0}}{6 \delta}-\frac{\epsilon K_{0}}{6 \delta^{2}}-\frac{c T_{0} \epsilon^{2}}{8 d \delta \sqrt{\delta}} \sqrt{\frac{2 T_{0}}{3}+\frac{2}{3 \delta} K_{0}} . \tag{B.13}
\end{align*}
$$

Setting $\delta=\Theta\left(\frac{1}{H}\right)$ and $\epsilon=\Theta\left(\frac{d}{\sqrt{H T_{0}}}\right)$, we have

$$
\frac{1}{|\Xi|} \sum_{\xi} \mathbb{E}_{\xi} \operatorname{D-Regret}\left(T_{0}\right) \geq \Omega\left(d \sqrt{H T_{0}}\right)
$$

Recall that in our episodic setting, the transition kernels $\mathbb{P}_{1}, \mathbb{P}_{2}, \cdots, \mathbb{P}_{H}$ may be different. By the same argument in Jin et al. (2018) (consider $H$ distinct hard-to-learn MDPs and set $\delta=\Theta\left(\frac{1}{H}\right)$ and $\left.\epsilon=\Theta\left(\frac{d}{\sqrt{T_{0}}}\right)\right)$, we obtain a dynamic regret lower bound of $\Omega\left(d H \sqrt{T_{0}}\right)$ in the stationary linear kernel MDPs. For non-stationary linear kernel MDPs, the number of segments $L$ is under budget constraint $2 \epsilon H L / \sqrt{d} \leq \Delta$. By choosing $L=\Theta\left(d^{-1 / 3} \Delta^{2 / 3} H^{-2 / 3} T^{1 / 3}\right)$, we have

\frac{1}{|\Xi|} \sum_{\xi} \mathbb{E}_{\xi} \operatorname{D-Regret}(T) \geq \Omega(L \cdot d H \sqrt{T / L})=\Omega\left(d^{5 / 6} \Delta^{1 / 3} H^{2 / 3} T^{2 / 3}\right)
$$

which concludes the proof of Theorem 3.1.

## C Regret Decomposition

Recall the definition of model prediction error in (5.1)

\left\{\left(s_{i}^{\tau}, a_{i}^{\tau}\right)\right\}_{(\tau, i) \in[k-1] \times[H]} \cup\left\{r^{\tau}\right\}_{\tau \in[k]} \cup\left\{\left(s_{i}^{k}, a_{i}^{k}\right)\right\}_{i \in[h]} .
$$

Similarly, we define $\mathcal{F}_{k, h, 2}$ as the $\sigma$-algebra generated by

\left\{\left(s_{i}^{\tau}, a_{i}^{\tau}\right)\right\}_{(\tau, i) \in[k-1] \times[H]} \cup\left\{r^{\tau}\right\}_{\tau \in[k]} \cup\left\{\left(s_{i}^{k}, a_{i}^{k}\right)\right\}_{i \in[h]} \cup\left\{s_{h+1}^{k}\right\},
$$

where $s_{H+1}^{k}$ is a null state for any $k \in[K]$. The $\sigma$-algebra sequence $\left\{\mathcal{F}_{k, h, m}\right\}_{(k, h, m) \in[K] \times[H] \times[2]}$ is a filtration with respect to the timestep index $t(k, h, m)=(k-1) \cdot 2 H+(h-1) \cdot 2+m$. It holds that $\mathcal{F}_{k, h, m} \subseteq \mathcal{F}_{k^{\prime}, h^{\prime}, m^{\prime}}$ for any $t(k, h, m) \leq t\left(k^{\prime}, h^{\prime}, m^{\prime}\right)$.

Lemma C. 1 (Dynamic Regret Decomposition). For the policies $\left\{\pi^{k}\right\}_{k=1}^{K}$ obtained in Algorithm 1 and the optimal policies $\pi^{*, k}$ in $k$-th episode, we have the following decomposition

= & \underbrace{\sum_{i=1}^{\rho} \sum_{k=(i-1) \tau+1}^{i \tau} \sum_{h=1}^{H} \mathbb{E}_{\pi^{*, k}}\left[\left\langle Q_{h}^{k}\left(s_{h}, \cdot\right), \pi_{h}^{*, k}\left(\cdot \mid s_{h}\right)-\pi_{h}^{k}\left(\cdot \mid s_{h}\right)\right\rangle\right]}_{(\mathrm{i})}+\underbrace{\mathcal{M}_{K, H, 2}}_{(\mathrm{ii})} \\
& +\underbrace{\sum_{i=1}^{\rho} \sum_{k=(i-1) \tau+1}^{i \tau} \sum_{h=1}^{H} \mathbb{E}_{\pi^{*, k}}\left[l_{h}^{k}\left(s_{h}, a_{h}\right)\right]}_{(\mathrm{iii})}+\underbrace{\sum_{i=1}^{\rho} \sum_{k=(i-1) \tau+1}^{i \tau} \sum_{h=1}^{H}-l_{h}^{k}\left(s_{h}^{k}, a_{h}^{k}\right)}_{(\mathrm{iv})},
\end{align*}
$$

Proof. Recall the definition of dynamic regret in (2.3), we have

\end{align*}

\end{equation*}

Term (i): By Bellman equation we have

V_{h}^{\pi^{*, k}, k}(s)-V_{h}^{k}(s) & =\left\langle Q_{h}^{\pi^{k}, k}(s, \cdot), \pi_{h}^{*, k}(\cdot \mid s)\right\rangle_{\mathcal{A}}-\left\langle Q_{h}^{k}(s, \cdot), \pi_{h}^{k}(\cdot \mid s)\right\rangle_{\mathcal{A}}  \tag{C.4}\\
& =\left\langle Q_{h}^{\pi^{k}, k}(s, \cdot)-Q_{h}^{k}(s, \cdot), \pi_{h}^{*, k}(\cdot \mid s)\right\rangle_{\mathcal{A}}+\left\langle Q_{h}^{k}(s, \cdot), \pi_{h}^{*, k}(\cdot \mid s)-\pi_{h}^{k}(\cdot \mid s)\right\rangle_{\mathcal{A}}
\end{align*}
$$

for any $(s, h, k) \in \mathcal{S} \times[H] \times[K]$. Meanwhile, by the definition of the model prediction error in (5.1), we have

Combining with Bellman equation in (2.1), we further obtain

Q_{h}^{\pi^{k}, k}-Q_{h}^{k}=\mathbb{P}_{h}^{k}\left(V_{h+1}^{\pi^{k}, k}-V_{h+1}^{k}\right)+l_{h}^{k} \tag{C.5}

Plugging (C.4) into (C.5), we obtain

+\left\langle Q_{h}^{k}(s, \cdot), \pi_{h}^{*, k}(\cdot \mid s)-\pi_{h}^{k}(\cdot \mid s)\right\rangle_{\mathcal{A}} \tag{C.6}
\end{gather*}

For notational simplicity, for any $(k, h) \in[K] \times[H]$ and function $f: \mathcal{S} \times \mathcal{A} \rightarrow \mathbb{R}$. we define the operators $\mathbb{I}_{h}^{k}$ and $\mathbb{I}_{k, h}$ respectively by

& =\sum_{h=1}^{H}\left(\prod_{i=1}^{h-1} \mathbb{I}_{i}^{k} \mathbb{P}_{i}^{k}\right) \mathbb{I}_{h}^{k} l_{h}^{k}+\sum_{h=1}^{H}\left(\prod_{i=1}^{h-1} \mathbb{I}_{i}^{k} \mathbb{P}_{i}^{k}\right) \mu_{h}^{k}
\end{aligned}
$$

where the last inequality follows from $V_{H+1}^{\pi^{*}, k}=V_{H+1}^{k}=0$. By the definitions of $\mathbb{P}_{h}^{k}$ in (2.2),
$\mathbb{I}_{h}^{k}$ in (C.7), and $\mu_{h}^{k}$ in (C.8), we further obtain

\end{equation*}

Term (ii): Recall the definition of value function $V_{h}^{\pi^{k}, k}$ in (2.1), the estimated function $V_{h}^{k}$ in (4.9) and the operator $\mathbb{I}_{h}^{k}$ in (C.7), we expand the model prediction error $l_{h}^{k}$ into

& =\left(r_{h}^{k}\left(s_{h}^{k}, a_{h}^{k}\right)+\left(\mathbb{P}_{h}^{k} V_{h+1}^{k}\right)\left(s_{h}^{k}, a_{h}^{k}\right)-Q_{h}^{\pi^{k}, k}\left(s_{h}^{k}, a_{h}^{k}\right)\right)+Q_{h}^{\pi^{k}, k}\left(s_{h}^{k}, a_{h}^{k}\right)-Q_{h}^{k}\left(s_{h}^{k}, a_{h}^{k}\right) \\
& =\left(\mathbb{P}_{h}^{k}\left(V_{h+1}^{k}-V_{h+1}^{\pi^{k}, k}\right)\right)\left(s_{h}^{k}, a_{h}^{k}\right)+\left(Q_{h}^{\pi^{k}, k}-Q_{h}^{k}\right)\left(s_{h}^{k}, a_{h}^{k}\right)
\end{aligned}

& +\left(\mathbb{P}_{h}^{k}\left(V_{h+1}^{k}-V_{h+1}^{\pi^{k}, k}\right)\right)\left(s_{h}^{k}, a_{h}^{k}\right)-l_{h}^{k}\left(s_{h}^{k}, a_{h}^{k}\right) .
\end{aligned}

To facilitate our analysis, we define

D_{k, h, 2} & =\left(\mathbb{P}_{h}^{k}\left(V_{h+1}^{k}-V_{h+1}^{\pi^{k}, k}\right)\right)\left(s_{h}^{k}, a_{h}^{k}\right)-\left(V_{h+1}^{k}-V_{h+1}^{\pi^{k}, k}\right)\left(s_{h+1}^{k}\right)
\end{align*}
$$

Hence, we have

& =\sum_{h=1}^{H}\left(D_{k, h, 1}+D_{k, h, 2}\right)-\sum_{h=1}^{H} l_{h}^{k}\left(s_{h}^{k}, a_{h}^{k}\right) \tag{C.12}
\end{align*}

where the last equality uses the fact that $V_{H+1}^{k}\left(s_{H+1}^{k}\right)=V_{H+1}^{\pi^{k}, k}\left(s_{H+1}^{k}\right)=0$. By the definitions of $\mathcal{F}_{k, h, 1}$ and $\mathcal{F}_{k, h, 2}$, we have the $D_{k, h, 1} \in \mathcal{F}_{k, h, 1}$ and $D_{k, h, 2} \in \mathcal{F}_{k, h, 2}$. Hence, for any $(k, h) \in$
$[K] \times[H]$,

Notice that $\mathcal{F}_{k, 0,2}=\mathcal{F}_{k-1, H, 2}$ for any $k \geq 2$, which implies the corresponding timestep index $t(k, 0,2)=t(k-1, H, 2)=2 H(k-1)$. Meanwhile, we define $\mathcal{F}_{1,0,2}$ to be empty. Thus we can define the following martingale

where $t(k, h, m)=2(k-1) H+2(h-1)+m$ is the timestep index. This martingale is obviously adapted to the filtration $\left\{\mathcal{F}_{k, h, m}\right\}_{(k, h, m) \in[K] \times[H] \times[2]}$, and particularly we have

& =\left\langle\log \left(\pi_{h}^{k+1}(\cdot \mid s) / \pi_{h}^{k}(\cdot \mid s)\right), \pi_{h}(\cdot \mid s)-\pi_{h}^{k+1}(\cdot \mid s)\right\rangle+\operatorname{KL}\left(\pi_{h}^{k+1}(\cdot \mid s) \| \pi_{h}^{k}(\cdot \mid s)\right) \\
& =\left\langle\log z_{k}(s)+\log \left(\pi_{h}^{k+1}(\cdot \mid s) / \pi_{h}^{k}(\cdot \mid s)\right), \pi_{h}(\cdot \mid s)-\pi_{h}^{k+1}(\cdot \mid s)\right\rangle+\operatorname{KL}\left(\pi_{h}^{k+1}(\cdot \mid s) \| \pi_{h}^{k}(\cdot \mid s)\right)

& \quad \leq \operatorname{KL}\left(\pi_{h}(\cdot \mid s) \| \pi_{h}^{k}(\cdot \mid s)\right)-\operatorname{KL}\left(\pi_{h}(\cdot \mid s) \| \pi_{h}^{k+1}(\cdot \mid s)\right)+\alpha^{2} H^{2} / 2
\end{aligned}
$$

which completes the proof of Lemma 5.1.

= & \frac{1}{2} \alpha K H^{3}+\sum_{h=1}^{H} \sum_{i=1}^{\rho} \frac{1}{\alpha} . \\

& \leq \max _{a}\left|P_{j}^{k_{j}}\left(s_{j+1} \mid s_{j}, a\right)-P_{j}^{k_{j}}\left(s_{j+1} \mid s_{j}, a\right)\right| . \tag{D.41}

& \quad=\max _{\left(s_{j}, a\right) \in \mathcal{S} \times \mathcal{A}}\left\|P_{j}^{k_{j}}\left(\cdot \mid s_{j}, a\right)-P_{j}^{k^{\prime}}\left(\cdot \mid s_{j}, a\right)\right\|_{1} \\

\sum_{h=1}^{H} \sum_{k=1}^{K} H \wedge \Gamma_{h}^{k}\left(s_{h}^{k}, a_{h}^{k}\right) & \leq \beta^{\prime} \cdot \sum_{h=1}^{H} \sum_{k=1}^{K} 1 \wedge \sqrt{\eta_{h}^{k}\left(s_{h}^{k}, a_{h}^{k}\right)^{\top}\left(A_{h}^{k}\right)^{-1} \eta_{h}^{k}\left(s_{h}^{k}, a_{h}^{k}\right)} \\
& \leq \beta^{\prime} \cdot \sum_{h=1}^{H}\left(K \cdot \sum_{k=1}^{K} 1 \wedge\left\|\eta_{h}^{k}\left(s_{h}^{k}, a_{h}^{k}\right)\right\|_{\left(A_{h}^{k}\right)^{-1}}\right)^{1 / 2} \tag{E.13}
\end{align*}
$$

where the second inequality follows from Cauchy-Schwarz inequality. Note the facts that $A_{h}^{1}=\lambda^{\prime} I_{d}$ and $\left\|\eta_{h}^{k}(s, a)\right\|_{2} \leq \sqrt{d} H$ for any $(k, h) \in[K] \times[H]$ and $(s, a) \in \mathcal{S} \times \mathcal{A}$. & +\underbrace{\sum_{k=1}^{K} \sum_{h=1}^{H} \mathbb{E}_{\pi^{*, k}}\left[l_{h}^{k}\left(s_{h}, a_{h}\right)\right]}_{(\mathrm{iii})}+\underbrace{\sum_{k=1}^{K} \sum_{h=1}^{H}-l_{h}^{k}\left(s_{h}^{k}, a_{h}^{k}\right)}_{(\mathrm{iv})},
\end{align*}

Since policies $\pi_{h}^{k}$ are greedy with respect to $Q_{h}^{k}$ for any $(k, h) \in[K] \times[H]$, we have

for any $(k, h) \in[K] \times[H]$ and $(s, a) \in \mathcal{S} \times \mathcal{A}$, where $w$ is the length of a sliding window defined in (4.5), $B_{h}^{k}(\cdot, \cdot)$ is the bonus function of reward defined in (4.10) and $\Gamma_{h}^{k}(\cdot, \cdot)$ is the bonus function of transition kernel defined in (4.10).

Compared with Lemma 5.3, Lemma F. 1 shows that we can achieve optimism with slightly large bonus functions. Equipped with this lemma, we can derive slightly worse regret bounds for our algorithms.

Proof of Theorem 4.5. The proof is the same as the proof of Theorem 4.2 except that Lemma 5.3 is replaced by Lemma F.1.

Proof of Theorem A.2. The proof is the same as the proof of Theorem A. 1 except that Lemma 5.3 is replaced by Lemma F.1.

Proof of Theorem 4.7. The proof is the same as the proof of Theorem 4.4 except that Lemma 5.3 is replaced by Lemma F.1.

## F. 2 Proof of Lemma F. 1

& \leq \sum_{\tau=1 \vee(k-w)}^{k-1}\left|\phi(s, a)^{\top}\left(\Lambda_{h}^{k}\right)^{-1} \phi\left(s_{h}^{\tau}, a_{h}^{\tau}\right)\right| \cdot\left\|\phi\left(s_{h}^{\tau}, a_{h}^{\tau}\right)\right\|_{2} \cdot\left\|\theta_{h}^{\tau}-\theta_{h}^{k}\right\|_{2} \\

For any two distributions $\mathcal{P}_{1}$ and $\mathcal{P}_{2}$ over $\mathcal{S}$ and any bounded function $f: \mathcal{S}^{\top} \rightarrow[0, B]$, we have

where $\mathbb{E}_{1}$ and $\mathbb{E}_{2}$ denote expectations with respect to $\mathcal{P}_{1}$ and $\mathcal{P}_{2}$.

Lemma G.5. Suppose $\xi$ and $\xi^{\prime}$ have the same entries except for $j$-th coordinate. We also assume that $2 \epsilon \leq \delta \leq 1 / 3$, then we have
