# SCATTERING AND UNIFORM IN TIME ERROR ESTIMATES FOR SPLITTING METHOD IN NLS 

RÉMI CARLES AND CHUNMEI SU


#### Abstract

We consider the nonlinear Schrödinger equation with a defocusing nonlinearity which is mass-(super)critical and energy-subcritical. We prove uniform in time error estimates for the Lie-Trotter time splitting discretization. This uniformity in time is obtained thanks to a vectorfield which provides time decay estimates for the exact and numerical solutions. This vectorfield is classical in scattering theory, and requires several technical modifications compared to previous error estimates for splitting methods.


## 1. Introduction

We consider large time error estimates for the Lie-Trotter time splitting method associated to the defocusing nonlinear Schrödinger equation

$$
\begin{equation*}
i \partial_{t} u+\frac{1}{2} \Delta u=|u|^{2 \sigma} u, \quad(t, x) \in \mathbb{R} \times \mathbb{R}^{d}, \quad u_{\mid t=0}=\phi \tag{1.1}
\end{equation*}
$$

in space dimension $d \leqslant 5$, in the case where the nonlinearity is mass-(super)critical and energy-subcritical,

$$
\begin{equation*}
\frac{2}{d} \leqslant \sigma<\frac{2}{(d-2)_{+}} \tag{1.2}
\end{equation*}
$$

that is, $\sigma \geqslant 2 / d$ when $d \leqslant 2$, and $2 / d \leqslant \sigma<2 /(d-2)$ when $d \geqslant 3$. The restriction on the space dimension is due to the fact that we want the nonlinearity to be energy-subcritical, and to have two continuous derivatives, $\sigma>1 / 2$. Under these assumptions, the Cauchy problem (1.1) is globally well-posed in $H^{1}\left(\mathbb{R}^{d}\right)(4,11)$, and mass and energy are conserved,

& \text { Mass: } M(u(t)):=\|u(t)\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2}=M(\phi) \\
& \text { Energy: } E(u(t)):=\frac{1}{2}\|\nabla u(t)\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2}+\frac{1}{\sigma+1}\|u(t)\|_{L^{2 \sigma+2}\left(\mathbb{R}^{d}\right)}^{2 \sigma+2}=E(\phi) .
\end{aligned}
$$

Like initially in [12], denote by $\Sigma \subset H^{1}\left(\mathbb{R}^{d}\right)$ the Hilbert space, sometimes called conformal space in the context of nonlinear Schrödinger equations,

$$
\Sigma:=\left\{\phi \in H^{1}\left(\mathbb{R}^{d}\right) ; \int_{\mathbb{R}^{d}}|x|^{2}|\phi(x)|^{2} d x<\infty\right\}
$$

[^0]equipped with the norm
$$
\|\phi\|_{\Sigma}^{2}:=\|\phi\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2}+\|\nabla \phi\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2}+\|x \phi\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2} .
$$

Then the Cauchy problem (1.1) is globally well-posed in $\Sigma$ as well: if $\phi \in \Sigma$, the solution $u(t, \cdot)$ has a finite momentum in $L^{2}\left(\mathbb{R}^{d}\right)$ for all time, and the evolution of this quantity is described by the pseudo-conformal evolution law, recalled in Proposition 2.2

We now recall the definition of the Lie-Trotter time splitting for (1.1). We define $N(t) \phi$ as the solution of the flow

$$
i \partial_{t} u=|u|^{2 \sigma} u, \quad u_{\mid t=0}=\phi
$$

that is, $N(t) \phi=\phi e^{-i t|\phi|^{2 \sigma}}$. We set $S(t) \phi$ as the solution of the linear Schrödinger flow

$$
i \partial_{t} u+\frac{1}{2} \Delta u=0, \quad u_{\mid t=0}=\phi
$$

It is a Fourier multiplier, $S(t) \phi=e^{i \frac{t}{2} \Delta} \phi$, and thus $S(t)$ is unitary on $H^{s}\left(\mathbb{R}^{d}\right)$ for any $s \in \mathbb{R}$. The Lie-Trotter approximation is defined, for $\tau \in(0,1)$, as

$$
Z(n \tau) \phi=(S(\tau) N(\tau))^{n} \phi
$$

Error estimates for this time discretization were established first in 1 for globally Lipschitz nonlinearities. C. Lubich 21] proved error estimates in the case of the Strang splitting, allowing (Schrödinger-Poisson nonlinearity and) cubic nonlinearity ( $\sigma=1$ in (1.1) ), hence a nonlinearity which is not globally Lipschitz continuous.

As pointed out in [16, 17, 18, 24, $S(\cdot)$ does not satisfy discrete in time Strichartz estimates, which makes it difficult to envisage error estimates involving a rather low regularity (in space) of the initial datum $\phi$; see also [8, 23] for discussions leading to the same conclusion, that $S(\cdot)$ should be modified in order to get better convergence results. Following [16, 18] and the adaptation in [6], we consider the modified splitting operator:

\begin{equation*}
Z_{\tau}(n \tau)=\left(S_{\tau}(\tau) N(\tau)\right)^{n} \Pi_{\tau} \phi \tag{1.3}
\end{equation*}
$$

Here, $S_{\tau}(t)$ denotes the frequency localized Schrödinger flow given by

$$
S_{\tau}(t) \phi=S(t) \Pi_{\tau} \phi
$$

where

$$
\begin{equation*}
\widehat{\Pi_{\tau} \phi}(\xi)=\chi\left(\tau^{1 / 2} \xi\right) \widehat{\phi}(\xi), \quad \xi \in \mathbb{R}^{d} \tag{1.4}
\end{equation*}
$$

and $\chi \in C^{k}\left(\mathbb{R}^{d}\right)$ is a cut-off function supported in $B^{d}(0,2)$ such that $\chi \equiv 1$ on $B^{d}(0,1), k$ an integer larger than $1+d / 2$ (this condition appears in the proof of Lemma 3.3).

All the error estimates associated to splitting methods for nonlinear Schrödinger equations have been established so far for bounded time intervals $[0, T]$ (with constants growing at best exponentially in $T$ ). As far as we are aware of, the same is true regarding linear Schrödinger equations with potential. On the other hand, global in time estimates have been proven in the framework of kinetic equations [9. There, time decay estimates (associated to a scattering phenomenon) play a crucial role. In this paper, we prove an analogous result in the case of (1.1), by using techniques related to the scattering theory (in $\Sigma$ ), in order to get quantitative time decay estimates) for nonlinear Schrödinger equations. More precisely, we use
a specific vectorfield, standard in the scattering theory for (1.1), $J(t)=x+i t \nabla$, which provides more precise decay estimates in time than the mixed $L_{t}^{q} L_{x}^{r}$-norms appearing in Strichartz estimates. It is well known that $J$ does not commute with $S$, but $J(t)=S(t) x S(-t)$ (see Proposition 2.2 below). A new technical specific aspect in this paper is that we also have to deal with the absence of commutation between $J$ and the frequency cut-off $\Pi_{\tau}$.

For any interval $I \subset[0, \infty)$, we define the space $\ell^{q}\left(n \tau \in I ; L^{r}\left(\mathbb{R}^{d}\right)\right)$, or simply $\ell^{q}\left(I ; L^{r}\right)$ as consisting of functions defined on $\tau \mathbb{Z} \cap I$ with values in $L^{r}\left(\mathbb{R}^{d}\right)$, the norm of which is given by

\|u\|_{\ell q\left(I ; L^{r}\right)}=\left\{\begin{align*}
\left(\tau \sum_{n \tau \in I}\|u(n \tau)\|_{L^{r}\left(\mathbb{R}^{d}\right)}^{q}\right)^{1 / q} & \text { if } 1 \leqslant q<\infty  \tag{1.5}\\
\sup _{n \tau \in I}\|u(n \tau)\|_{L^{r}\left(\mathbb{R}^{d}\right)} & \text { if } q=\infty
\end{align*}\right.
$$

We recall the notion of admissible pairs in the context of Schrödinger equation (we shall not need endpoint Strichartz estimates, $(q, r)=\left(2, \frac{2 d}{d-2}\right)$ for $\left.d \geqslant 3\right)$.
Definition 1.1. A pair $(q, r)$ is admissible if $2 \leqslant r<\frac{2 d}{d-2}(2 \leqslant r \leqslant \infty$ if $d=1$, $2 \leqslant r<\infty$ if $d=2$ ) and

$$
\frac{2}{q}=\delta(r):=d\left(\frac{1}{2}-\frac{1}{r}\right)
$$

Remark 1.2. We note that the range for $q$ is equivalent to: $q \in(2, \infty]$ if $d \geqslant 2$, and $q \in[4, \infty]$ if $d=1$.

As it plays a central role in the analysis of (1.1), throughout this paper, and following [6, 16], we denote by $\left(q_{0}, r_{0}\right)$ the admissible pair

$$
\left(q_{0}, r_{0}\right)=\left(\frac{4 \sigma+4}{d \sigma}, 2 \sigma+2\right) .
$$

Theorem 1.3. Let $d \leqslant 5$, $\sigma$ satisfying (1.2), with in addition $\sigma \geqslant 1 / 2$ (if $d=5$ ), $\phi \in \Sigma$, and $u \in C(\mathbb{R} ; \Sigma)$ the solution to (1.1). Suppose there exists $M_{2}$ such that

$$
\begin{equation*}
\max _{A \in\{1, \nabla, J\}}\left\|A(n \tau) Z_{\tau}(n \tau)\right\|_{\ell \infty\left(\tau \mathbb{N} ; L^{2}\right)}+\left\|Z_{\tau}(n \tau)\right\|_{\ell^{q_{0}}\left(\tau \mathbb{N} ; W^{1, r_{0}}\right)} \leqslant M_{2} \tag{1.6}
\end{equation*}
$$

where $J(t)=x+i t \nabla$. Then there exists $C=C\left(d, \sigma,\|\phi\|_{\Sigma}, M_{2}\right)$ such that for all $\tau \in(0,1)$,

$$
\sup _{n \geqslant 0}\left\|Z_{\tau}(n \tau)-u(n \tau)\right\|_{L^{2}\left(\mathbb{R}^{d}\right)} \leqslant C \tau^{1 / 2}
$$

In addition, there exists $u_{+} \in \Sigma$ such that

$$
\lim _{k \rightarrow \infty} \sup _{n \geqslant k}\left\|Z_{\tau}(n \tau)-S(n \tau) u_{+}\right\|_{L^{2}\left(\mathbb{R}^{d}\right)} \leqslant C \tau^{1 / 2}
$$

Remark 1.4. We prove convergence in the $L^{2}$-topology. It is very likely that it holds also in the $H^{1}$-topology if we require in addition $\phi \in H^{2}$, in view of the second result in Theorem 2.5.

Remark 1.5. The existence of the asymptotic state $u_{+}$can be understood as follows: for sufficiently large time, nonlinear effects have become negligible, and the action of the nonlinear flow $N(\tau)$ converges (fast enough) toward the identity, so the splitting operator $Z_{\tau}$ behaves like $S_{\tau}$, which in turn is equivalent to $S$ for smooth functions.

This is the meaning of the last estimate in Theorem 1.3 which, in some sense, makes the uniform error estimate more precise.

Now demanding $\sigma>1 / 2$, and not only $\sigma \geqslant 1 / 2$ (see the proof of Proposition 6.2 for the reason why this constraint is introduced), we show that the assumptions of Theorem 1.3 are indeed satisfied by the numerical solution:

Theorem 1.6. Let $d \leqslant 5, \sigma$ satisfying (1.2), with in addition $\sigma>1 / 2$ (if $d=4$ or $5)$, and $\phi \in \Sigma$. Then, for any admissible pair $(q, r)$, there exists $C(d, \sigma, q, \phi)$ such that for all $\tau \in(0,1)$, the numerical solution $Z_{\tau}$ satisfies

$$
\max _{A \in\{\mathbf{1}, \nabla, J\}}\left\|A(n \tau) Z_{\tau}(n \tau)\right\|_{\ell_{q}\left(\tau \mathbb{N} ; L^{r}\right)} \leqslant C(d, \sigma, q, \phi) .
$$

Remark 1.7. In view of classical results on nonlinear Schrödinger equations (see e.g [4, 26]), Theorems 1.3 and 1.6 remain valid in the case of a focusing nonlinearity $\left(|u|^{2 \sigma} u\right.$ is replaced by $-|u|^{2 \sigma} u$ in (1.1)), provided that $\|\phi\|_{\Sigma}$ is sufficiently small. Without smallness assumption, finite time blow up is possible, but even global solutions need not be dispersive, since standing wave solutions of the form $u(t, x)=$ $e^{i \omega t} \phi(x)$ exist. Theorems 1.3 and 1.6 highly rely on dispersive properties of the solution to (1.1), and should not be expected to remain true in the case of standing waves. More general nonlinearities than the homogeneous one considered in (1.1) could be addressed though (typically, combined power nonlinearities), provided that suitable a priori estimates (in the spirit of the pseudoconformal conservation law recalled in Proposition (2.2) are available. This is for instance the case when the nonlinearity is the sum of two defocusing homogeneous terms, $|u|^{2 \sigma_{1}} u+|u|^{2 \sigma_{2}} u$, $\frac{2}{d} \leqslant \sigma_{j}<\frac{2}{(d-2)_{+}}$, but the situation is more involved when it is the sum of a focusing and a defocusing term, since standing waves exist (see e.g. [20]).

Remark 1.8. As recalled in Section 2, the assumptions on $\sigma$ and $\phi$ ensure that the solution $u$ to (1.1) is global, and satisfies $u \in L^{q}\left(\mathbb{R} ; L^{r}\left(\mathbb{R}^{d}\right)\right)$ for all admissible pairs. It is tempting to conjecture that Theorem 1.6 remains true under the assumptions that $u \in L^{q}\left(\mathbb{R} ; L^{r}\left(\mathbb{R}^{d}\right)\right)$ for all admissible pairs, a property that actually follows from the weaker one $u \in L^{q_{0}}\left(\mathbb{R} ; L^{r_{0}}\left(\mathbb{R}^{d}\right)\right)$, see Section 2 However, the introduction of the operator $J$ induces stronger estimates, and it is not clear at all that the proof of Theorem 1.6 can be adapted to this broader setting (typically, one could assume $\phi \in H^{1}\left(\mathbb{R}^{d}\right)$ only).

Organization of the paper. The rest of this paper is organized as follows. In Section 2 we recall some standard results related to (1.1), including global in time estimates, establish some new ones (in particular Theorem 2.5), to provide general estimates on solutions to (1.1). Section 3 is devoted to general estimates involving the numerical solution (discrete in time). The main novelties concern the introduction of the operator $J$, and the difficulties caused by its absence of commutation with the frequency cut-off $\Pi_{\tau}$. Theorem 1.3 is proved in Section 4 . In Section 5, we establish local $\Sigma$ stability results (Proposition 5.1); there, local means local in time, allowing a neighborhood to $t=\infty$. In Section 6 we prove refined estimates allowing to conclude with the proof of Theorem 1.6 in Section 7. Finally Section 8 is dedicated to a summary and a list of possible related extensions.

## General notations.

- We denote by $\mathbf{1}$ the identity operator.
- We denote by $L^{r}$ the standard space $L^{r}\left(\mathbb{R}^{d}\right)$ for $1 \leqslant r \leqslant \infty$.
- For $y \in \mathbb{R}^{n}, n \in \mathbb{N}$, the Japanese bracket is $\langle y\rangle=\left(1+|y|^{2}\right)^{1 / 2}$.
- We denote by $C$ generic constants, which may vary from line to line.
- We underline the dependence of constants as follows: $C(d, \sigma)$ or $C_{d, \sigma}$ means that $C$ does not depend on other parameters, such as $\tau$ or $\phi$.
- For $a, b \geqslant 0$, we use the notation

$$
a \lesssim b
$$

whenever there exists a constant $C$ independent of $\tau \in(0,1)$ and the time interval considered (but certainly depending on $d$ and $\sigma$ ) such that $a \leqslant C b$.

- When considered useful, we write $u^{\phi}$ to underscore that $u$ is the solution to (1.1) with initial datum $\phi$ (typically, when several such solutions are involved).


## 2. Preliminary estimates: the exact solution

2.1. Generalities. For $t_{0} \in \mathbb{R}$, Duhamel formula for the solution $u$ to (1.1) with the initial condition $u_{\mid t=t_{0}}=\phi$, reads as follows:

$$
\begin{equation*}
u(t)=S\left(t-t_{0}\right) \phi-i \int_{t_{0}}^{t} S(t-s)\left(|u|^{2 \sigma} u\right)(s) d s \tag{2.1}
\end{equation*}
$$

The standard Strichartz inequalities associated to the Schrödinger equation (see e.g. [4, 26) are summarized below. We recall that the notion of admissible pairs was introduced in Definition 1.1 .

Proposition 2.1 (Strichartz estimates). Let $d \geqslant 1$ and $S(t)=e^{i \frac{t}{2} \Delta}$.
(1) Homogeneous estimates. For any admissible pair $(q, r)$, there exists $C_{q}$ such that

$$
\|S(t) \phi\|_{L^{q}\left(\mathbb{R} ; L^{r}\right)} \leqslant C_{q}\|\phi\|_{L^{2}}, \quad \forall \phi \in L^{2}
$$

(2) Inhomogeneous estimates. Denote

$$
D(F)(t, x)=\int_{0}^{t} S(t-s) F(s, x) d s
$$

For all admissible pairs $\left(q_{1}, r_{1}\right)$ and $\left(q_{2}, r_{2}\right)$, there exists $C=C_{q_{1}, q_{2}}$ such that for all intervals $I \ni 0$,

$$
\begin{equation*}
\|D(F)\|_{L^{q_{1}}\left(I ; L^{r_{1}}\right)} \leqslant C\|F\|_{L^{q_{2}^{\prime}}\left(I ; L^{r_{2}^{\prime}}\right)}, \quad \forall F \in L^{q_{2}^{\prime}}\left(I ; L^{r_{2}^{\prime}}\right) \tag{2.2}
\end{equation*}
$$

With Strichartz and Hölder inequalities in mind, we remark that $r_{0}$ satisfies

$$
\frac{1}{r_{0}^{\prime}}=\frac{2 \sigma+1}{r_{0}}
$$

with $2 \sigma+1$ being the homogeneity of the nonlinearity in (1.1), and we introduce $\gamma$ given by

$$
\begin{equation*}
\frac{1}{q_{0}^{\prime}}=\frac{1}{q_{0}}+\frac{2 \sigma}{\gamma} \Longleftrightarrow \gamma=\frac{4 \sigma(\sigma+1)}{2-(d-2) \sigma} \tag{2.3}
\end{equation*}
$$

We see that $\gamma$ is finite since the nonlinearity is energy-subcritical. The above relations will be applied many times, as follows (according to whether continuous
or discrete time intervals are considered), recalling that $2 \sigma \geqslant 1$ :

$$
\begin{align*}
& \left\||f|^{2 \sigma-1} g h\right\|_{L^{q_{0}^{\prime}}\left(I ; L^{r_{0}^{\prime}}\right)} \leqslant\|f\|_{L^{\gamma}\left(I ; L^{r_{0}}\right)}^{2 \sigma-1}\|g\|_{L^{\gamma}\left(I ; L^{r_{0}}\right)}\|h\|_{L^{q_{0}}\left(I ; L^{r_{0}}\right)}, \quad \text { or }  \tag{2.4}\\
& \left\||f|^{2 \sigma-1} g h\right\|_{\ell^{q_{0}^{\prime}}\left(I ; L^{r_{0}^{\prime}}\right)} \leqslant\|f\|_{\ell \gamma\left(I ; L^{r_{0}}\right)}^{2 \sigma-1}\|g\|_{\ell^{\gamma}\left(I ; L^{r_{0}}\right)}\|h\|_{\ell_{0}\left(I ; L^{r_{0}}\right)} .
\end{align*}
$$

The following result was discovered in [12], and is crucial to turn the local error estimates from [16, 6] into global ones:

Proposition 2.2 (Pseudo-conformal conservation law). The operator

$$
J(t)=x+i t \nabla
$$

satisfies the following properties:

- $J(t)=S(t) x S(-t)$, and therefore $J$ commutes with the linear part of (1.1),

$$
\begin{equation*}
\left[J(t), i \partial_{t}+\frac{1}{2} \Delta\right]=0 . \tag{2.5}
\end{equation*}
$$

- It can be factorized as

$$
J(t)=i t e^{i \frac{|x|^{2}}{2 t}} \nabla\left(e^{-i \frac{|x|^{2}}{2 t}} .\right)
$$

As a consequence, J yields weighted Gagliardo-Nirenberg inequalities. For $2 \leqslant r<\frac{2 d}{(d-2)_{+}}(2 \leqslant r \leqslant \infty$ if $d=1)$, there exists $C(d, r)$ depending only on $d$ and $r$ such that

$$
\begin{equation*}
\|f\|_{L^{r}} \leqslant \frac{C(d, r)}{|t|^{\delta(r)}}\|f\|_{L^{2}}^{1-\delta(r)}\|J(t) f\|_{L^{2}}^{\delta(r)}, \quad \delta(r):=d\left(\frac{1}{2}-\frac{1}{r}\right) \tag{2.6}
\end{equation*}
$$

Also, if $F(z)=G\left(|z|^{2}\right) z$ is $C^{1}$, then $J(t)$ acts like a derivative on $F(w)$ :

$$
\begin{equation*}
J(t)(F(w))=\partial_{z} F(w) J(t) w-\partial_{\bar{z}} F(w) \overline{J(t) w} \tag{2.7}
\end{equation*}
$$

Any solution $u \in C(\mathbb{R} ; \Sigma)$ to (1.1) satisfies the pseudo-conformal conservation law:

$$
\begin{equation*}
\frac{d}{d t}\left(\frac{1}{2}\|J(t) u\|_{L^{2}}^{2}+\frac{t^{2}}{\sigma+1}\|u(t)\|_{L^{2 \sigma+2}}^{2 \sigma+2}\right)=\frac{t}{\sigma+1}(2-d \sigma)\|u(t)\|_{L^{2 \sigma+2}}^{2 \sigma+2} \tag{2.8}
\end{equation*}
$$

For some time interval $I$, we introduce the norm

$$
\begin{equation*}
\|u\|_{X(I)}=\max _{A \in\{\mathbf{1}, \nabla, J\}} \sup _{t \in I}\|A(t) u(t)\|_{L^{2}}, \tag{2.9}
\end{equation*}
$$

and the space $X(I)$ defined by the finiteness of this quantity. We emphasize that in view of the time dependence of $J, X(I)=L^{\infty}(I ; \Sigma)$ if and only if $I$ is bounded. This can be seen on the linear Schrödinger equation (linear solutions $S(t) \phi$ are dispersive): in view of (2.5), since $S(t)$ is unitary on $L^{2}$,

$$
\|J(t) S(t) \phi\|_{L^{2}}=\|x \phi\|_{L^{2}}, \quad\|\nabla S(t) \phi\|_{L^{2}}=\|\nabla \phi\|_{L^{2}} \Longrightarrow\|x S(t) \phi\|_{L^{2}} \underset{t \rightarrow \infty}{\sim} t\|\nabla \phi\|_{L^{2}}
$$

We note that if $I$ is reduced to a single element, $I=\left\{t_{0}\right\}$, then $X(I)=\Sigma$, but the norm $\|\cdot\|_{X(I)}$ involves the operator $J\left(t_{0}\right)$, so the norms $\|\cdot\|_{\Sigma}$ and $\|\cdot\|_{X(I)}$ are equivalent, but with comparing constants highly depending on $t_{0}$. We also consider the norm

$$
\begin{equation*}
\|u\|_{Y(I)}:=\max _{A \in\{\mathbf{1}, \nabla, J\}} \sup _{(q, r) \text { admissible }}\|A u\|_{L^{q}\left(I ; L^{r}\right)} \tag{2.10}
\end{equation*}
$$

and the associated space $Y(I)$. Note that $\|u\|_{X(I)} \leqslant\|u\|_{Y(I)}$.
2.2. Global solutions. At this stage, we emphasize that the assumption $\sigma \geqslant 2 / d$ implies that for $t \geqslant 0$, the right hand side in (2.8) is nonpositive. Together with the conservation of mass and energy, this entails $u \in X(\mathbb{R})$. This implies in particular $u \in L^{\gamma}\left(\mathbb{R} ; L^{r_{0}}\right)$, as

$$
\begin{equation*}
\gamma \delta\left(r_{0}\right)>1 \tag{2.11}
\end{equation*}
$$

This property is indeed classical in scattering theory for (1.1): it is equivalent to

\sigma>\frac{2-d+\sqrt{d^{2}+12 d+4}}{4 d}=: \sigma_{*},

and $\sigma_{*}<2 / d$. This parameter $\sigma_{*}$ is a standard lower bound for $\sigma$ to prove scattering theory in $\Sigma$, see e.g. 4] (see also [5, 22] for the case $\sigma=\sigma_{*}$ ). The standard Gagliardo-Nirenberg inequality (for bounded $t$ ) and (2.6) (for large $t$ ) yield

and in view of Hölder inequality in time,

where $C$ does not depend on the time interval $I$. For $A \in\{\mathbf{1}, \nabla, J\}$, Strichartz and Hölder inequalities (involving (2.4)) then yield

and splitting $\mathbb{R}$ into finitely many intervals $I_{j}$ where $\|u\|_{L^{\gamma}\left(I_{j} ; L^{r_{0}}\right)}$ is sufficiently small, we infer $u \in Y(\mathbb{R})$. We obtain the following statement (see e.g. [4, Theorem 7.4.1] or [14, Theorem B]):
Theorem 2.3. Let $\phi \in \Sigma, \frac{2}{d} \leqslant \sigma<\frac{2}{(d-2)_{+}}$. Then (1.1) has a unique solution $u \in C(\mathbb{R} ; \Sigma) \cap L_{\text {loc }}^{q_{0}}\left(\mathbb{R} ; L^{r_{0}}\right)$. It satisfies $u \in Y(\mathbb{R})$, and there exist $u_{ \pm} \in \Sigma$ such that

A priori, the asymptotic states $u_{+}$and $u_{-}$are different, even though the relation between $u_{+}$and $u_{-}$remains rather mysterious in general (see e.g. [3).

Remark 2.4. The first reason why we assume $\sigma \geqslant 2 / d$ instead of the more general hypothesis $\sigma>\sigma_{*}$ ensuring scattering in $\Sigma$ is that in view of (2.8), we have the global estimate $J u \in L^{\infty}\left(\mathbb{R} ; L^{2}\left(\mathbb{R}^{d}\right)\right)$ as soon as $\sigma \geqslant 2 / d$. On the other hand, if $\sigma_{*}<\sigma<2 / d$, (2.8) provides only a control on the growth (in $t$ ) of $t^{2}\|u(t)\|_{L^{2 \sigma+2}}^{2 \sigma+2}$ (via Gronwall lemma), hence of $\|J(t) u\|_{L^{2}}$ (using (2.8) again). The assumption $\sigma \geqslant 2 / d$ is made not only for this simplification: filling the gap $\sigma_{*}<\sigma<2 / d$ would require to modify several arguments below, see the proofs of Theorem 2.5 and Lemma 2.6

We state and prove the global in time analogue of [6, Theorem B], and establish some specific global in time integrability properties:

Theorem 2.5. Let $1 \leqslant d \leqslant 5, \frac{2}{d} \leqslant \sigma<\frac{2}{(d-2)_{+}}$, with in addition (if $d=5$ ) $\sigma \geqslant 1 / 2$.

- For any $M \geqslant 1$, there exists $C=C(M, d, \sigma)$ such that for any $t_{0} \in \mathbb{R}$, if $\phi_{1}, \phi_{2} \in \Sigma$ are initial data for $u_{1}$ and $u_{2}$, respectively, at time $t_{0}$,

and are such that $\left\|\phi_{1}\right\|_{X\left(\left\{t_{0}\right\}\right)},\left\|\phi_{2}\right\|_{X\left(\left\{t_{0}\right\}\right)} \leqslant M$, then

- If $\psi \in \Sigma \cap H^{2}$, and $u$ solves (1.1), where, for $t_{0} \in \mathbb{R}, u_{\mid t=t_{0}}=\psi$, then for all $A \in\{\mathbf{1}, \nabla, J\}$,

Proof. For the first point, we note that the conservation of the energy and the pseudoconformal conservation law (2.8) yield

We then remark that since $J(t)=S(t) x S(-t)$ (Proposition 2.2), we have $J(t)=$ $S\left(t-t_{0}\right) J\left(t_{0}\right) S\left(t_{0}-t\right)$, and Duhamel's formula becomes, for $A \in\{\mathbf{1}, \nabla, J\}$, and $j=1,2$,

\end{aligned}

When $A=\nabla$ or $J(t)$, computations are similar:

& +\left(\left\|u_{1}\right\|_{L^{\gamma}\left(I ; L^{r_{0}}\right)}^{2 \sigma}+\left\|u_{2}\right\|_{L^{\gamma}\left(I ; L^{r_{0}}\right)}^{2 \sigma}\right)\left\|A\left(u_{1}-u_{2}\right)\right\|_{L^{q_{0}}\left(I ; L^{r_{0}}\right)} \\
& +\left(\left\|u_{1}\right\|_{L^{\gamma}\left(I ; L^{r_{0}}\right)}^{2 \sigma-1}+\left\|u_{2}\right\|_{L^{\gamma}\left(I ; L^{r_{0}}\right)}^{2 \sigma-1}\right)\left\|A u_{2}\right\|_{L^{q_{0}}\left(I ; L^{r_{0}}\right)}\left\|u_{1}-u_{2}\right\|_{L^{\gamma}\left(I ; L^{r_{0}}\right)}

The last term is controlled, in view of (2.12), by

and similarly, using Strichartz estimates again, for any $t_{j} \in \mathbb{R}, I_{j}=\overline{\left[t_{j}, t_{j+1}\right)}$ $\left(t_{j}<t_{j+1} \leqslant \infty\right.$, we consider the adherence of $I_{j}$ to address a closed interval except if $\left.t_{j+1}=\infty\right)$,

where $C_{4}$ and $C_{5}$ is independent of $I_{j}$, that is,

In order to prove the second point, we do not follow the same strategy as in 4, where the $H^{2}$ regularity of $u$ is read from the equation (1.1), after it is proved that $\partial_{t} u$ is in $L^{2}$ (this strategy does not require the nonlinearity to be more than $C^{1}$, and $\sigma>0$ is allowed). Since $\sigma \geqslant 1 / 2$, we may differentiate (1.1) twice in space, instead of once in time.

We check that since $d \sigma \geqslant 2, \gamma$, defined in (2.3), is such that $\gamma \geqslant q_{0}$, as

We infer that $W^{s, \rho} \hookrightarrow L^{r_{0}}$, with $s$ defined above, which is such that $s \in[0,1[$ since $2 / d \leqslant \sigma<2 /(d-2)_{+}$. We note that for $A=J, \partial_{j}$ and $A$ do not commute (but the commutation bracket is of order zero, and is therefore harmless in the estimates). Applying $A \in\{\mathbf{1}, \nabla, J\}$ to the Duhamel's formula (2.1), then $\partial_{j}$, Strichartz estimates yield, for $t_{0} \in I$,

\lesssim & \|u\|_{L^{\gamma}\left(I ; L^{r_{0}}\right)}^{2 \sigma}\left\|\partial_{j} A u\right\|_{L^{q_{0}\left(I ; L^{r_{0}}\right)}} \\
& +\|u\|_{L^{\gamma}\left(I ; L^{r_{0}}\right)}^{2 \sigma-1}\|u\|_{L^{\gamma}\left(I ; W^{2, \rho}\right)}\|A u\|_{L^{q_{0}\left(I ; L^{r_{0}}\right)}}
\end{aligned}

If $\sigma>1 / 2$, we use the same idea as for the first point of the theorem, namely

and split $\mathbb{R}$ into finitely many intervals such that the last term in (2.13) can be absorbed by the left hand side on each of them. We conclude by (finite) induction like before. If $\sigma=1 / 2$, we use in addition the property $A u \in L^{q_{0}}\left(\mathbb{R} ; L^{r_{0}}\right.$ ) (from Theorem 2.3), and conclude similarly, by considering Strichartz estimates involving other admissible pairs, among them $(\gamma, \rho)$.
2.3. Estimating the source term. Suppose that $u$ solves (1.1), and $v$ solves

then Taylor formula shows that $w=u-v$ solves

$$

where the source term is controlled pointwise by $\left|r_{w}\right| \lesssim|u|^{4 \sigma+1}$. In terms of estimates, it is as if the power $2 \sigma$ in (1.1) had been replaced by $4 \sigma$, which may no longer correspond to an energy-subcritical nonlinearity. This difficulty is overcome thanks to the introduction of the frequency cutoff $\Pi_{\tau}$. The following lemma is a global in time version of [6, Lemma 2.8], and the proof resumes many of its ingredients:

Lemma 2.6. There exists $C$ independent of $\tau$ and the time interval I such that

We check that in view of (1.2), $r_{1} \geqslant 2$. By definition, $r_{1} \geqslant 2$ if and only if

But $d \sigma \geqslant 2$, so the above inequality is satisfied. For $d=1,2$, we do not have to check anything else. Introduce now $q_{2}$ and $r_{2}$ given by

We check that for $d \leqslant 5,1 / q_{2}>0$, and $1 / q_{2}<1 / 2$ since $\sigma \geqslant 2 / d$ : $q_{2} \in(2, \infty)$, and if $d=1, q_{2}>4$, hence, by definition of $r_{2},\left(q_{2}, r_{2}\right)$ is admissible. Sobolev embedding reads

We note that for $\frac{2}{d} \leqslant \sigma<\frac{2}{(d-2)_{+}}, s \in(0,1)$, hence (2.14) entails

\end{aligned}

and the first estimate of the lemma follows.
For the second term of left hand side of the lemma, Hölder inequality yields:

\end{aligned}
$$

In view of Lemma 3.2, again since $r_{1}<(4 \sigma+1) r_{0}^{\prime}$,

$$

Still from Lemma 3.2

$$
\left\|\Pi_{\tau}\left(|u|^{2 \sigma} u\right)\right\|_{L^{\frac{4 \sigma+1}{2 \sigma+1} q_{0}^{\prime}}\left(I ; L^{\left.\frac{4 \sigma+1}{2 \sigma+1} r_{0}^{\prime}\right)}\right.} \lesssim \tau^{\frac{d}{2}\left(\frac{2 \sigma+1}{(4 \sigma+1) r_{0}^{\prime}}-\frac{2 \sigma+1}{r_{1}}\right)}\left\||u|^{2 \sigma} u\right\|_{L^{\frac{4 \sigma+1}{2 \sigma+1} q_{0}^{\prime}\left(I ; L^{\frac{r_{1}}{2 \sigma+1}}\right)}}
$$

Therefore,

\left\|\left|\Pi_{\tau} u\right|^{2 \sigma} \Pi_{\tau}\left(|u|^{2 \sigma} u\right)\right\|_{L^{q_{0}^{\prime}}\left(I ; L^{r_{0}^{\prime}}\right)} \lesssim & \tau^{\frac{d}{2}\left(\frac{1}{r_{0}^{\prime}}-\frac{4 \sigma+1}{r_{1}}\right)}\|u\|_{L^{(4 \sigma+1) q_{0}^{\prime}\left(I ; L^{r_{1}}\right)}}^{2 \sigma} \\
& \left.\times\left\|\left.u\right|^{2 \sigma} u\right\|_{L^{\frac{4 \sigma+1}{2 \sigma+1} q_{0}^{\prime}}\left(I ; L^{\frac{r}{2}}\right.}^{2 \sigma+1}\right) \\
\lesssim & \tau^{-1 / 2}\|u\|_{L^{4 \sigma+1}}^{4 \sigma+1) q_{0}^{\prime}\left(I ; L^{r_{1}}\right)}
\end{aligned}=\tau^{-1 / 2}\|u\|_{L^{q_{2}\left(I ; L^{r_{1}}\right)}}^{4 \sigma+1},
$$

where we have used Hölder inequality for the last estimate, and we are back to the situation of the first case.

## 3. PRELIMINARY ESTIMATES: THE NUMERICAL SOLUTION

The discrete (in time) counterpart of the $L_{t}^{q} L^{r}$ norms involved in the standard Strichartz estimates is:

which is compared to the formula (2.1). We now list analogues of Proposition 2.1 in the discrete (in time) setting, a framework which is not quite as classical.

Proposition 3.1 ([16, Theorem 2.1]). Let $(q, r)$, $\left(q_{1}, r_{1}\right)$ and $\left(q_{2}, r_{2}\right)$ be any admissible pairs. Then, there exist $C_{d, q}, C_{d, q_{1}, q_{2}}>0$ such that

hold for all $\phi \in L^{2}$ and $f \in \ell^{q_{2}^{\prime}}\left(\tau \mathbb{Z} ; L^{r_{2}^{\prime}}\right)$.
The following version of Bernstein lemma is borrowed from [6]:

An important technical novelty compared both with previous studies of (1.1), and with error estimates for time discretization, is that since we consider the vectorfield $J$ in the presence of the truncated propagator $S_{\tau}$, we face a lack of commutation: $\Pi_{\tau}$ commutes with 1 and $\nabla$, but not with $J$. This lack of commutation turns out to be controlled thanks to the following lemma:

Lemma 3.3. For any $1<p<\infty$, there exists $C_{p}>0$ such that

\end{aligned}

The lemma follows from the boundedness of $\nabla \chi$ and basic Fourier multiplier theory, provided that $\nabla \chi \in C^{k}$ with $k>d / 2$ (see e.g. [25, p. 96]).

Since the operators $S_{\tau}$ and $\nabla$ commute, the following corollary is immediate in the case $A \in\{\mathbf{1}, \nabla\}$, but requires more work in the case $A=J$.

Corollary 3.4. Let $(q, r),\left(q_{1}, r_{1}\right)$ and $\left(q_{2}, r_{2}\right)$ be any admissible pairs. Then, there exist $C_{d, q}, C_{d, q_{1}, q_{2}}>0$ such that for any $t_{0} \in \tau \mathbb{Z}$ and $A \in\{\mathbf{1}, \nabla\}$,

hold for all $\phi \in \Sigma$ and $f$ such that $A f \in \ell^{q_{2}^{\prime}}\left(\tau \mathbb{Z} ; L^{r_{2}^{\prime}}\right)$. While for $A=J$, we have

& \left\|\tau J(n \tau) \sum_{k=-\infty}^{n-1} S_{\tau}((n-k) \tau) f(k \tau)\right\|_{\ell q_{1}\left(\tau \mathbb{Z} ; L^{r_{1}}\right)} \\
& \quad \leqslant C_{d, q_{1}, q_{2}}\left(\tau^{1 / 2}\|f\|_{\ell^{q_{2}^{\prime}}\left(\tau \mathbb{Z} ; L^{r^{\prime}}\right)}+\|J f\|_{\ell^{q_{2}^{\prime}}\left(\tau \mathbb{Z} ; L^{r^{\prime}}\right)}\right) . \tag{3.12}

Proof. For $A=\{\mathbf{1}, \nabla\}$, (3.9) and (3.10) follow directly from Proposition 3.1 by noticing that $A$ commutes with $S_{\tau}$. On the other hand, $J$ does not commute with $S_{\tau}$. In view of the properties of $\chi$, we have the identity

Since $J(t)=S(t) x S(-t)=S\left(t-t_{0}\right) J\left(t_{0}\right) S\left(t_{0}-t\right)$, the last term is equal to

& =S_{\tau}\left(t-t_{0}\right)\left[J\left(t_{0}\right), \Pi_{\tau / 4}\right] \phi+S_{\tau}\left(t-t_{0}\right) J\left(t_{0}\right) \phi
\end{aligned}
$$

We infer

\leqslant & \left\|S_{\tau}\left(\cdot-t_{0}\right) J\left(t_{0}\right) \phi\right\|_{\ell q}\left(\tau \mathbb{Z} ; L^{r}\right)+\left\|\left[J(\cdot), \Pi_{\tau}\right] S_{\tau / 4}\left(\cdot-t_{0}\right) \phi\right\|_{\ell^{q}\left(\tau \mathbb{Z} ; L^{r}\right)} \\
& +\left\|S_{\tau}\left(\cdot-t_{0}\right)\left[J\left(t_{0}\right), \Pi_{\tau / 4}\right] \phi\right\|_{\ell^{q}\left(\tau \mathbb{Z} ; L^{r}\right)} \\
\leqslant & C_{d, q}\left\|J\left(t_{0}\right) \phi\right\|_{L^{2}}+C \tau^{1 / 2}\left\|S_{\tau / 4}\left(\cdot-t_{0}\right) \phi\right\|_{\ell^{q}\left(\tau \mathbb{Z} ; L^{r}\right)}+C_{d, q}\left\|\left[J\left(t_{0}\right), \Pi_{\tau / 4}\right] \phi\right\|_{L^{2}} \\
\leqslant & \tilde{C}_{d, q}\left(\tau^{1 / 2}\|\phi\|_{L^{2}}+\left\|J\left(t_{0}\right) \phi\right\|_{L^{2}}\right)
\end{aligned}
$$

where we have used (3.2) and (3.8). Similarly, (3.12) can be established by applying (3.3) and (3.8).

Propositions 2.1 and 3.1 and Christ-Kiselev lemma imply this slight extension (to incorporate $J$ ) of [16, Lemma 4.5]:

Lemma 3.6. [6, Lemma 2.5] There exists $c>0$ such that

& \leqslant C_{d, q_{1}, q_{2}} \tau^{1 / 2}\|f\|_{L^{q_{2}^{\prime}}\left(\mathbb{R} ; W^{\left.1, r_{2}^{\prime}\right)}\right.}+C_{d, q_{1}, q_{2}} \tau\left\|\partial_{t} f\right\|_{L^{q_{2}^{\prime}}\left(\mathbb{R} ; L^{r_{2}^{\prime}}\right)}
\end{align*}
$$

hold for any test function $f \in \mathcal{S}\left(\mathbb{R}^{d+1}\right)$.

## 4. $L^{2}$ CONVERGENCE

Proof of Theorem 1.3. In view of Theorem 2.3 and the assumption of Theorem 1.3 we see that $u$ and $Z_{\tau}$ satisfy the following estimates

\end{array}\right)\left\|Z_{\tau}(n \tau)\right\|_{\ell^{q_{0}}\left(\tau \mathbb{N} ; W^{1, r_{0}}\right)} \leqslant M_{2} .
$$

We shall estimate $Z_{\tau}(n \tau)-\Pi_{\tau} u(n \tau)$ instead of $Z_{\tau}(n \tau)-u(n \tau)$, in view of

by (3.4). We recall that $\gamma<\infty$ is defined by (2.3). We recall that $\gamma \delta\left(r_{0}\right)>1$ (see (2.11). Therefore, in view of (1.5), (4.1) and (2.6), for any $\eta>0$, we can find a
finite number $K=K(\eta)$ of time intervals $I_{j}=\overline{\left[m_{j}, m_{j+1}\right)}$ with $m_{j} \in \mathbb{N}$ if $j \leqslant K$, $m_{K+1}=\infty$, and $\tau(\eta)>0$ such that for $1 \leqslant j \leqslant K$ and $0<\tau \leqslant \tau(\eta)$,

We consider the adherence of $I_{j}$ because unlike in the continuous case, for $j+1 \leqslant K$, the singleton $\left\{m_{j+1}\right\}$ is not of measure zero, and actually becomes important in the following discussion. On each interval $I_{j}$, the discrete Duhamel's formula (3.1) can be written as

for $0 \leqslant n<m_{j+1}-m_{j}$ ( $m_{j+1}$ may be infinite, but $m_{j}$ is always finite). By combining this with (2.1), we obtain the following decomposition:

Z_{\tau}\left(m_{j} \tau+n \tau\right)-\Pi_{\tau} u\left(m_{j} \tau+n \tau\right)=\mathcal{A}_{1}(n)+\mathcal{A}_{2}(n)+\mathcal{A}_{3}(n)+\mathcal{A}_{4}(n) \tag{4.3}
\end{equation*}
$$

where

$$
\begin{aligned}
& \mathcal{A}_{1}(n):= S_{\tau}(n \tau)\left(Z_{\tau}\left(m_{j} \tau\right)-\Pi_{\tau} u\left(m_{j} \tau\right)\right) \\
& \mathcal{A}_{2}(n):=S_{\tau}(n \tau)\left(\Pi_{\tau} u\left(m_{j} \tau\right)-u\left(m_{j} \tau\right)\right) \\
& \mathcal{A}_{3}(n):=\tau \sum_{k=0}^{n-1} S_{\tau}(n \tau-k \tau)\left(\frac{N(\tau)-1}{\tau} Z_{\tau}\left(m_{j} \tau+k \tau\right)-\frac{N(\tau)-1}{\tau} \Pi_{\tau} u\left(m_{j} \tau+k \tau\right)\right), \\
& \mathcal{A}_{4}(n):= \tau \sum_{k=0}^{n-1} S_{\tau}(n \tau-k \tau) \frac{N(\tau)-1}{\tau} \Pi_{\tau} u\left(m_{j} \tau+k \tau\right) \\
&+i \int_{0}^{n \tau} S_{\tau}(n \tau-s)\left(|u|^{2 \sigma} u\right)\left(m_{j} \tau+s\right) d s
\end{aligned}
$$

and we omit the dependence of the $\mathcal{A}_{k}$ 's upon $j$ to ease notations. The terms $\mathcal{A}_{1}$ and $\mathcal{A}_{2}$ are linear, while $\mathcal{A}_{3}$ and $\mathcal{A}_{4}$ are nonlinear. The goal is to show that in the estimates, the term $\mathcal{A}_{3}$ can be absorbed by the left hand side of (4.3), $\mathcal{A}_{2}$ and $\mathcal{A}_{4}$ are $\mathcal{O}\left(\tau^{1 / 2}\right)$, and $\mathcal{A}_{1}$ is then estimated by induction on $j$.

Let $(q, r) \in\left\{\left(q_{0}, r_{0}\right),(\infty, 2)\right\}$. The homogeneous Strichartz estimate (3.2) yields

& \leqslant C_{d, q}\left\|\Pi_{\tau} u\left(m_{j} \tau\right)-u\left(m_{j} \tau\right)\right\|_{L^{2}} \\
& \leqslant C_{d, q} \tau^{1 / 2}\left\|(-\Delta)^{1 / 2} u\left(m_{j} \tau\right)\right\|_{L^{2}} \leqslant C_{d, q} \tau^{1 / 2} M_{1}
\end{aligned}
$$

where we have used (4.1). To estimate $\mathcal{A}_{3}$, we use (3.15) to find

\left|\frac{N(\tau)-1}{\tau} Z_{\tau}-\frac{N(\tau)-1}{\tau} \Pi_{\tau} u\right| \lesssim\left(\left|Z_{\tau}\right|^{2 \sigma}+\left|\Pi_{\tau} u\right|^{2 \sigma}\right)\left|Z_{\tau}-\Pi_{\tau} u\right|

The inhomogeneous Strichartz estimate (3.3) and Hölder inequality (2.4) yield

& \lesssim\left(\left\|Z_{\tau}\right\|_{\ell^{\gamma}\left(\tau I_{j} ; L^{r_{0}}\right)}^{2 \sigma}+\left\|\Pi_{\tau} u\right\|_{\ell^{\gamma}\left(\tau I_{j} ; L^{r_{0}}\right)}^{2 \sigma}\right)\left\|Z_{\tau}-\Pi_{\tau} u\right\|_{\ell^{q_{0}}\left(\tau I_{j} ; L^{r_{0}}\right)} \\
& \leqslant \mathbf{C}_{d, \sigma, q} \eta^{2 \sigma}\left\|Z_{\tau}-\Pi_{\tau} u\right\|_{\ell q_{0}\left(\tau I_{j} ; L^{r_{0}}\right)}
\end{aligned}
$$

for some constant $\mathbf{C}_{d, \sigma, q}$, where we have used the definition of the intervals $I_{j}$ in terms of $\eta$. We now choose $\eta>0$ sufficiently small so that $\mathbf{C}_{d, \sigma, q_{0}} \eta^{2 \sigma}<1 / 2$, thus

\max _{1 \leqslant j \leqslant K}\left(\left\|\mathcal{A}_{4}\right\|_{\ell \infty\left(\tau I_{j} ; L^{2}\right)}+\left\|\mathcal{A}_{4}\right\|_{\ell_{0}^{q_{0}}\left(\tau I_{j} ; L^{r_{0}}\right)}\right) \lesssim \tau^{1 / 2} \tag{4.4}
\end{equation*}
$$

Gathering all the previous estimates, we first get, with $(q, r)=\left(q_{0}, r_{0}\right)$,

& +C \tau^{1 / 2}+\frac{1}{2}\left\|Z_{\tau}-\Pi_{\tau} u\right\|_{\ell \ell_{0}\left(\tau I_{j} ; L^{r_{0}}\right)}
\end{aligned}
$$

hence

$$
\left\|Z_{\tau}-\Pi_{\tau} u\right\|_{\ell \ell_{0}\left(\tau I_{j} ; L^{r_{0}}\right)} \leqslant 2 C\left\|Z_{\tau}\left(m_{j} \tau\right)-\Pi_{\tau} u\left(m_{j} \tau\right)\right\|_{L^{2}}+2 C \tau^{1 / 2}, \quad 1 \leqslant j \leqslant K
$$

Taking now $(q, r)=(\infty, 2)$, we obtain

& \lesssim\left\|Z_{\tau}\left(m_{j} \tau\right)-\Pi_{\tau} u\left(m_{j} \tau\right)\right\|_{L^{2}}+\tau^{1 / 2}, \quad 1 \leqslant j \leqslant K
\end{aligned}
$$

Now by construction $m_{1}=0, Z_{\tau}\left(m_{1} \tau\right)-\Pi_{\tau} u\left(m_{1} \tau\right)=0$, and for $2 \leqslant j \leqslant K$,

we have the first conclusion in Theorem 1.3. The second one is then a direct consequence of this first point and the scattering result recalled in Theorem 2.3 there exists $u_{+} \in \Sigma$ such that

Proof. As observed in the previous computations, we recall that the assumptions of Lemma 4.1 imply

& \mathcal{A}_{2}(u)(n \tau)=\int_{0}^{n \tau} S_{\tau}(n \tau-s) \mathcal{B}_{1}(u)(s) d s+i \int_{0}^{n \tau} S_{\tau}(n \tau-s)|u|^{2 \sigma} u(s) d s
\end{aligned}
$$

with

$$
\mathcal{B}_{1}(u)(s):=\frac{N(\tau)-\mathbf{1}}{\tau} \Pi_{\tau} u(s)
$$

By Lemma 3.7 we can estimate

$$

for all admissible pair $(q, r)$. Lemma 3.6 entails

\left\|\mathcal{B}_{1}(u)\right\|_{L^{q_{0}}\left(\mathbb{R}_{+} ; W^{1, r_{0}{ }^{\prime}}\right)} \lesssim\left\|\left|\Pi_{\tau} u\right|^{2 \sigma+1}\right\|_{L^{q_{0}^{\prime}}\left(\mathbb{R}_{+} ; L^{r_{0}^{\prime}}\right)}+\left\|\left|\Pi_{\tau} u\right|^{2 \sigma}\left|\nabla \Pi_{\tau} u\right|\right\|_{L^{q_{0}^{\prime}}\left(\mathbb{R}_{+} ; L^{r_{0}^{\prime}}\right)} .
$$

Using now Hölder inequality (2.4) and Lemma 3.2.

$$
\begin{aligned}
\left\|\mathcal{B}_{1}(u)\right\|_{L^{q_{0}}\left(\mathbb{R}_{+} ; W^{1, r_{0}}\right)} & \lesssim\left\|\Pi_{\tau} u\right\|_{L^{\gamma}\left(\mathbb{R}_{+} ; L^{r_{0}}\right)}^{2 \sigma}\left\|\Pi_{\tau} u\right\|_{L^{q_{0}}\left(\mathbb{R}_{+} ; W^{1, r_{0}}\right)} \\
& \lesssim\|u\|_{L^{\gamma}\left(\mathbb{R}_{+} ; L^{r_{0}}\right)}^{2 \sigma}\|u\|_{L^{q_{0}}\left(\mathbb{R}_{+} ; W^{1, r_{0}}\right)} \lesssim\|u\|_{Y\left(\mathbb{R}_{+}\right)}^{2 \sigma+1} .
\end{aligned}
$$

For the other term, Lemma 3.6 yields

\left\|\mathcal{B}_{1}(u)\right\|_{W^{1, q_{0}}\left(\mathbb{R}_{+} ; L^{r_{0}}\right)} & =\left\|\partial_{t}\left(\frac{N(\tau)-1}{\tau} \Pi_{\tau} u\right)\right\|_{L^{q_{0}^{\prime}\left(\mathbb{R}_{+} ; L^{r_{0}^{\prime}}\right)}} \\
& \lesssim\left\|\left|\Pi_{\tau} u\right|^{2 \sigma} \partial_{t} \Pi_{\tau} u\right\|_{L^{q_{0}^{\prime}}\left(\mathbb{R}_{+} ; L^{r_{0}^{\prime}}\right)} .
\end{aligned}
$$

Observing that $\partial_{t}$ and $\Pi_{\tau}$ commute, (1.1) implies

\left\|\mathcal{B}_{1}(u)\right\|_{W^{1, q_{0}^{\prime}}\left(\mathbb{R}_{+} ; L^{r_{0}}\right)} \lesssim & \left\|\left|\Pi_{\tau} u\right|^{2 \sigma} \Pi_{\tau} \Delta u\right\|_{L^{q_{0}^{\prime}}\left(\mathbb{R}_{+} ; L^{r_{0}^{\prime}}\right)} \\
& +\left\|\left|\Pi_{\tau} u\right|^{2 \sigma} \Pi_{\tau}\left(|u|^{2 \sigma} u\right)\right\|_{L^{q_{0}^{\prime}}\left(\mathbb{R}_{+} ; L^{r_{0}^{\prime}}\right)}
\end{aligned}
$$

For the first term of the right side, Hölder inequality (2.4) and Lemma 3.2 imply

\left\|\left|\Pi_{\tau} u\right|^{2 \sigma} \Pi_{\tau} \Delta u\right\|_{L^{q_{0}^{\prime}}\left(\mathbb{R}_{+} ; L^{r_{0}^{\prime}}\right)} & \lesssim\left\|\Pi_{\tau} u\right\|_{L^{\gamma}\left(\mathbb{R}_{+} ; L^{r_{0}}\right)}^{2 \sigma}\left\|\Pi_{\tau} \Delta u\right\|_{L^{q_{0}}\left(\mathbb{R}_{+} ; L^{r_{0}}\right)} \\
& \lesssim \tau^{-1 / 2}\left\|\Pi_{\tau} u\right\|_{L^{\gamma}\left(\mathbb{R}_{+} ; L^{r_{0}}\right)}^{2 \sigma}\left\|\Pi_{\tau} \nabla u\right\|_{L^{q_{0}}\left(\mathbb{R}_{+} ; L^{r_{0}}\right)} \\
& \lesssim \tau^{-1 / 2}\|u\|_{L^{\gamma}\left(\mathbb{R}_{+} ; L^{r_{0}}\right)}^{2 \sigma}\|\nabla u\|_{L^{q_{0}}\left(\mathbb{R}_{+} ; L^{r_{0}}\right)} \\
& \lesssim \tau^{-1 / 2}\|u\|_{Y\left(\mathbb{R}_{+}\right)}^{2 \sigma+1} .
\end{aligned}
$$

Lemma 2.6 provides the following control for the second term of the right side:

\left\|\mathcal{A}_{1}(u)\right\|_{\ell^{q}\left(\tau \mathbb{N} ; L^{r}\right)} \lesssim \tau^{1 / 2}\left\|\mathcal{B}_{1}(u)\right\|_{L^{q_{0}^{\prime}}\left(\mathbb{R}_{+} ; W^{1, r_{0}}\right)}+\tau\left\|\mathcal{B}_{1}(u)\right\|_{W^{1, q_{0}}\left(\mathbb{R}_{+} ; L^{r_{0}}\right)}
$$

$$
\lesssim \tau^{1 / 2}\left(\|u\|_{Y\left(\mathbb{R}_{+}\right)}^{2 \sigma+1}+\|u\|_{Y\left(\mathbb{R}_{+}\right)}^{4 \sigma+1}\right)
$$

To complete the proof, we perform another decomposition,

\mathcal{B}_{1}(u)+i|u|^{2 \sigma} u=\mathcal{B}_{2}(u)+i \mathcal{B}_{3}(u),
$$

where

\mathcal{B}_{2}(u):=\mathcal{B}_{1}(u)+i\left|\Pi_{\tau} u\right|^{2 \sigma} \Pi_{\tau} u, \quad \mathcal{B}_{3}(u):=|u|^{2 \sigma} u-\left|\Pi_{\tau} u\right|^{2 \sigma} \Pi_{\tau} u
$$

The discrete inhomogeneous Strichartz estimates (3.13) yields, for ( $q, r$ ) admissible,

\begin{aligned}
& \left\|\mathcal{A}_{2}(u)\right\|_{\ell^{q}\left(\tau \mathbb{N} ; L^{r}\right)} \\
\leqslant & \left\|\int_{0}^{n \tau} S_{\tau}(n \tau-s) \mathcal{B}_{2}(u) d s\right\|_{\ell q\left(\tau \mathbb{N} ; L^{r}\right)}+\left\|\int_{0}^{n \tau} S_{\tau}(n \tau-s) \mathcal{B}_{3}(u) d s\right\|_{\ell q\left(\tau \mathbb{N} ; L^{r}\right)} \\
\lesssim & \left\|\mathcal{B}_{2}(u)\right\|_{L^{q_{0}^{\prime}}\left(\mathbb{R}_{+} ; L^{L_{0}^{\prime}}\right)}+\left\|\mathcal{B}_{3}(u)\right\|_{L^{q_{0}^{\prime}\left(\mathbb{R}_{+} ; L^{r_{0}^{\prime}}\right)}} .
\end{aligned}
$$

Recall that $N(\tau) z=z e^{-i \tau|z|^{2 \sigma}}$, Taylor formula yields the pointwise estimate

$$

where we have used Lemma 2.6 for the last estimate.
Finally, Hölder inequality (2.4) yields

\left\|\mathcal{B}_{3}(u)\right\|_{L^{q_{0}^{\prime}}\left(\mathbb{R}_{+} ; L^{r_{0}^{\prime}}\right)} & =\left\|\left|\Pi_{\tau} u\right|^{2 \sigma} \Pi_{\tau} u-|u|^{2 \sigma} u\right\|_{L^{q_{0}^{\prime}}\left(\mathbb{R}_{+} ; L^{r_{0}^{\prime}}\right)} \\
& \lesssim\left(\left\|\Pi_{\tau} u\right\|_{L^{\gamma}\left(\mathbb{R}_{+} ; L^{r_{0}}\right)}^{2 \sigma}+\|u\|_{L^{\gamma}\left(\mathbb{R}_{+} ; L^{r_{0}}\right)}^{2 \sigma}\right)\left\|\Pi_{\tau} u-u\right\|_{L^{q_{0}}\left(\mathbb{R}_{+} ; L^{r_{0}}\right)} \\
& \lesssim \tau^{1 / 2}\|u\|_{Y\left(\mathbb{R}_{+}\right)}^{2 \sigma}\|u\|_{L^{q_{0}}\left(\mathbb{R}_{+} ; W^{1, r_{0}}\right)} \lesssim \tau^{1 / 2}\|u\|_{Y\left(\mathbb{R}_{+}\right)}^{2 \sigma+1},
\end{aligned}
$$

where we have used Lemma 3.2. Lemma 4.1 follows.

## 5. Local stability

We denote

\|v\|_{\Gamma(I)}=\|v\|_{\ell \infty\left(I ; L^{2}\right)}+\|\nabla v\|_{\ell \infty\left(I ; L^{2}\right)}+\|J v\|_{\ell \infty\left(I ; L^{2}\right)} \tag{5.1}
\end{equation*}
$$

the discrete counterpart of the norm $\|\cdot\|_{X(I)}$ defined in (2.9). Define

K_{0}:=1+\sup _{\tau \in(0,1)} \sup _{\phi \in L^{2}} \frac{\left\|S_{\tau}(\cdot) \phi\right\|_{\ell^{q_{0}}\left(\tau \mathbb{Z} ; L^{r_{0}}\right)}+\left\|S_{\tau}(\cdot) \phi\right\|_{\ell \infty}\left(\tau \mathbb{Z} ; L^{2}\right)}{\|\phi\|_{L^{2}}}
$$

which is finite in view of the discrete homogeneous Strichartz estimates (3.2).
Recall that in accordance with (1.5), we have, for $1 \leqslant q<\infty$,

Proposition 5.1 (Local $\Sigma$ stability). Let $\phi \in \Sigma$. Consider an interval I of the form $I=\overline{[a \tau, b \tau)}$, with $a, b \in \mathbb{N} \cup\{\infty\}$ such that $0 \leqslant a<b \leqslant \infty$. There exist $\tau_{0}>0$ and $K_{1}$ depending only on $d$ and $\sigma$ such that if

\end{equation*}

then

\max _{A \in\{1, \nabla, J\}} \sum_{(q, r) \in\left\{\left(q_{0}, r_{0}\right),(\infty, 2)\right\}}\left\|A Z_{\tau}\right\|_{\ell^{q}\left(I ; L^{r}\right)} \leqslant 4 K_{0}\left\|Z_{\tau}\right\|_{X(\{a \tau\})}, \quad \forall \tau \in\left(0, \tau_{0}\right) \tag{5.3}
\end{equation*}
$$

and for all $(q, r)$ admissible, there exists $K_{q}$ such that

Remark 5.2. We call the above result a local stability, since we require some smallness on

Obviously, the series is convergent, since $\gamma \delta\left(r_{0}\right)>1$, and this smallness means that either $b$ is finite and $b-a$ is sufficiently small, or $b=\infty$ and $a$ is sufficiently large, a case which corresponds to a local result near $t=\infty$ (in the spirit of the construction of wave operators in scattering theory, see e.g [4, 10]). More precisely, for finite $b$, we may use the estimate

If $\Lambda$ is an infinite set, then the conclusion of proposition follows easily, from the estimates presented below, based on Strichartz estimates.

Suppose that $\Lambda$ is a finite set, and let $N_{*}$ be the largest element of $\Lambda$. First we verify that the set $\Lambda$ is non-empty. Indeed, by the definitions of $Z_{\tau}$ and $K_{0}$, we find that, for $A \in\{\mathbf{1}, \nabla\}$,

& \leqslant\left\|S_{\tau}(\cdot) A Z_{\tau}(a \tau)\right\|_{\ell^{q_{0}}\left(\tau \mathbb{Z} ; L^{r_{0}}\right)}+\left\|S_{\tau}(\cdot) A Z_{\tau}(a \tau)\right\|_{\ell \infty}\left(\tau \mathbb{Z} ; L^{2}\right) \\
& \leqslant\left(K_{0}-1\right)\left\|A Z_{\tau}(a \tau)\right\|_{L^{2}} \leqslant\left(K_{0}-1\right)\left\|Z_{\tau}\right\|_{X(\{a \tau\})} .
\end{aligned}
$$

While for $A=J$, applying Lemma 3.3 we get

& +C \tau^{1 / 2}\left(\tau^{\frac{1}{q_{0}}}\left\|Z_{\tau}(a \tau)\right\|_{L^{r_{0}}}+\left\|Z_{\tau}(a \tau)\right\|_{L^{2}}\right) \\
\leqslant & \left\|S_{\tau}(\cdot) J(a \tau) Z_{\tau}(a \tau)\right\|_{\ell^{q_{0}}\left(\tau \mathbb{Z} ; L^{r_{0}}\right)}+\left\|S_{\tau}(\cdot) J(a \tau) Z_{\tau}(a \tau)\right\|_{\ell \infty\left(\tau \mathbb{Z} ; L^{2}\right)} \\
& +C \tau^{1 / 2}\left(K_{0}-1\right)\left\|Z_{\tau}\right\|_{X(\{a \tau\})} \\
\leqslant & \left(K_{0}-1\right)\left\|J(a \tau) Z_{\tau}(a \tau)\right\|_{L^{2}}+C \tau^{1 / 2}\left(K_{0}-1\right)\left\|Z_{\tau}\right\|_{X(\{a \tau\})}
\end{aligned}
$$

$$
\begin{aligned}
& \leqslant\left(1+C \tau^{1 / 2}\right)\left(K_{0}-1\right)\left\|Z_{\tau}\right\|_{X(\{a \tau\})} \\
& <4 K_{0}\left\|Z_{\tau}\right\|_{X(\{a \tau\})}
\end{aligned}
$$

when $\tau \leqslant \tau_{0}:=1 / 4 C^{2}$, where $C$ is the constant in Lemma 3.3. Therefore, $0 \in \Lambda$.
For $A \in\{\mathbf{1}, \nabla\}$, and $(q, r) \in\left\{\left(q_{0}, r_{0}\right),(\infty, 2)\right\}$,

& \left\|A Z_{\tau}(n \tau)\right\|_{\ell^{q}\left(a \leqslant n \leqslant a+N_{*}+1 ; L^{r}\right)} \\
\leqslant & \left\|A S_{\tau}(n \tau-a \tau) Z_{\tau}(a \tau)\right\|_{\ell^{q}\left(a \leqslant n \leqslant a+N_{*}+1 ; L^{r}\right)} \\
& +\left\|\tau A \sum_{k=a}^{n-1} S_{\tau}(n \tau-k \tau) \frac{N(\tau)-1}{\tau} Z_{\tau}(k \tau)\right\|_{\ell^{q}\left(a+1 \leqslant n \leqslant a+N_{*}+1 ; L^{r}\right)} \\
\leqslant & \left\|S_{\tau}(n \tau-a \tau) A Z_{\tau}(a \tau)\right\|_{\ell^{q}\left(a \leqslant n \leqslant a+N_{*}+1 ; L^{r}\right)} \\
& +\left\|\tau \sum_{k=a}^{n-1} S_{\tau}(n \tau-k \tau) A \frac{N(\tau)-1}{\tau} Z_{\tau}(k \tau)\right\|_{\ell^{q}\left(a+1 \leqslant n \leqslant a+N_{*}+1 ; L^{r}\right)} \\
\leqslant & \left(K_{0}-1\right)\left\|Z_{\tau}\right\|_{X(\{a \tau\})}+Q_{1}
\end{aligned}
$$

where the last term $Q_{1}$ is bounded by applying the Strichartz estimate (3.10) as follows:

\end{aligned}

To estimate the right hand side, we apply Lemma 3.6 and Hölder inequality (2.4). We omit the information $a \leqslant n \leqslant a+N_{*}$ to ease notations:

\end{aligned}
$$

where we have used (1.5), and (weighted) Gagliardo-Nirenberg inequality for the last estimate. Since $N_{*} \in \Lambda$, we infer that

We infer that there exists $K_{1}$ depending only on $d$ and $\sigma$ such that, for any $A \in$ $\{1, \nabla\}$,

& \sum_{(q, r) \in\left\{\left(q_{0}, r_{0}\right),(\infty, 2)\right\}}\left\|A Z_{\tau}\right\|_{\ell q\left(a \leqslant n \leqslant a+N_{*}+1 ; L^{r}\right)} \leqslant 2 K_{0}\left\|Z_{\tau}\right\|_{X(\{a \tau\})} \\
& \quad+K_{1}\left\|\langle n \tau\rangle^{-\delta\left(r_{0}\right)}\right\|_{\ell^{\gamma}\left(a \leqslant n \leqslant a+N_{*}\right)}^{2 \sigma}\left(4 K_{0}\left\|Z_{\tau}\right\|_{X(\{a \tau\})}\right)^{2 \sigma+1} .
\end{aligned}
$$

We conclude with the case $A=J$. We have from (3.1),

We proceed like in the proof of Corollary 3.4 $J(t)=S\left(t-t_{0}\right) J\left(t_{0}\right) S\left(t_{0}-t\right)$, hence

= & {\left[J(n \tau), \Pi_{\tau}\right] S_{\tau / 4}((n-a) \tau)+\Pi_{\tau} S((n-a) \tau) J(a \tau) \Pi_{\tau / 4} } \\
= & {\left[J(n \tau), \Pi_{\tau}\right] S_{\tau / 4}((n-a) \tau)+S_{\tau}((n-a) \tau)\left[J(a \tau), \Pi_{\tau / 4}\right] } \\
& +S_{\tau}((n-a) \tau) J(a \tau) . \tag{5.6}
\end{align*}
$$

Now, $J$ acts on gauge invariant nonlinearities like the gradient, see (2.7), and we observe that $(N(\tau)-\mathbf{1}) Z_{\tau}$ enjoys this gauge invariance. We infer from (5.6) and Lemma 3.3 that the above estimates, proven in the case $A \in\{\mathbf{1}, \nabla\}$, remains essentially the same in the case $A=J$ :

& \left.\quad+K_{1}\left\|\langle n \tau\rangle^{-\delta\left(r_{0}\right)}\right\|_{\ell^{\gamma}\left(a \leqslant n \leqslant a+N_{*}\right)}^{2 \sigma}\left(4 K_{0}\left\|Z_{\tau}\right\|_{X(\{a \tau\})}\right)^{2 \sigma+1}\right) \\
& \leqslant 3 K_{0}\left\|Z_{\tau}\right\|_{X(\{a \tau\})}+\frac{3}{2} K_{1}\left\|\langle n \tau\rangle^{-\delta\left(r_{0}\right)}\right\|_{\ell^{\gamma}\left(a \leqslant n \leqslant a+N_{*}\right)}^{2 \sigma}\left(4 K_{0}\left\|Z_{\tau}\right\|_{X(\{a \tau\})}\right)^{2 \sigma+1},
\end{aligned}
$$

when $\tau \leqslant \tau_{0}$. The maximality of $N_{*}$ implies that

i.e.,

since if the reverse inequality were true, then $N_{*}+1$ would belong to $\Lambda$. Keeping this constant $K_{1}$ in the statement of Proposition 5.1. we see that $I \varsubsetneqq\left[a \tau,\left(a+N_{*}\right) \tau\right]$, and the result follows, by using Strichartz estimates once more in order to cover all admissible pairs $(q, r)$.

## 6. More estimates

The following lemma is the large time counterpart of [6, Lemma 5.2], where we also change the numerology:
Lemma 6.1. For any time interval $I$, and $A \in\{1, \nabla, J\}$,

& +\left(\|v\|_{\ell^{\gamma}\left(I ; L^{r_{0}}\right)}^{2 \sigma-1}+\|w\|_{\ell^{\gamma}\left(I ; L^{r_{0}}\right)}^{2 \sigma-1}\right)\|v-w\|_{\ell \gamma\left(I ; L^{r_{0}}\right)}\|A w\|_{\ell^{q_{0}}\left(I ; L^{r_{0}}\right)} \\
& +\tau\|v-w\|_{\ell^{\gamma}\left(I ; L^{r_{0}}\right)}\|A w\|_{\ell^{q_{0}}\left(I ; L^{r_{0}}\right)}\left\||v|^{4 \sigma-1}+|w|^{4 \sigma-1}\right\|_{\ell^{\frac{\gamma}{2 \sigma-1}\left(I ; L^{\frac{r_{0}}{2 \sigma-1}}\right)}} .
\end{aligned}
$$

Proof. In view of Lemma 3.6. Hölder inequality yields

Next, by differentiating and rearranging, we have

= & -i \sigma\left(e^{\left.-i \tau|v|^{2 \sigma}|v|^{2 \sigma} \nabla v-e^{-i \tau|w|^{2 \sigma}}|w|^{2 \sigma} \nabla w\right)}\right. \\
& -i \sigma\left(e^{-i \tau|v|^{2 \sigma}}|v|^{2 \sigma-2} v^{2} \nabla \bar{v}-e^{-i \tau|w|^{2 \sigma}}|w|^{2 \sigma-2} w^{2} \nabla \bar{w}\right) \\
& +\left(\left(\frac{e^{-i \tau|v|^{2 \sigma}}-1}{\tau}\right)-\left(\frac{e^{-i \tau|w|^{2 \sigma}}-1}{\tau}\right)\right) \nabla w+\left(\frac{e^{-i \tau|v|^{2 \sigma}}-1}{\tau}\right)(\nabla v-\nabla w)
\end{aligned}
$$

Lemma 3.6 now yields

By inserting the terms $|w|^{2 \sigma} \nabla w e^{-i \tau|v|^{2 \sigma}}$ and $|w|^{2 \sigma-2} w^{2} \nabla \bar{w} e^{-i \tau|v|^{2 \sigma}}$ in the first and second lines of the right hand side of (6.1), respectively, we obtain, since $\sigma \geqslant 1 / 2$,

& +\left\|\left(|v|^{2 \sigma-1}+|w|^{2 \sigma-1}\right)(|v|-|w|) \nabla w\right\|_{\ell^{q_{0}^{\prime}}\left(I ; L^{r_{0}^{\prime}}\right)} \\
& +\left\||w|^{2 \sigma} \nabla w\left(e^{-i \tau|v|^{2 \sigma}}-e^{-i \tau|w|^{2 \sigma}}\right)\right\|_{\ell^{q_{0}^{\prime}}\left(I ; L^{r_{0}^{\prime}}\right)} .
\end{align*}

The first term on the right hand side is estimated by Hölder inequality (2.4),

& \quad \lesssim\left(\|v\|_{\ell \gamma\left(I ; L^{r_{0}}\right)}^{2 \sigma-1}+\|w\|_{\ell \gamma\left(I ; L^{r_{0}}\right)}^{2 \sigma-1}\right)\|v-w\|_{\ell \gamma\left(I ; L^{r_{0}}\right)}\|\nabla w\|_{\ell^{q_{0}}\left(I ; L^{r_{0}}\right)}
\end{aligned}

For the last term in (6.2), we notice the pointwise estimate, using again $\sigma \geqslant 1 / 2$,

& \quad \lesssim \tau\|v-w\|_{\ell^{\gamma}\left(I ; L^{r_{0}}\right)}\|\nabla w\|_{\ell \ell_{0}\left(I ; L^{r_{0}}\right)}\left\||v|^{4 \sigma-1}+|w|^{4 \sigma-1}\right\|_{\ell^{\frac{\gamma}{2 \sigma-1}}\left(I ; L^{\frac{r_{0}}{2 \sigma-1}}\right)} .
\end{aligned}
$$

The lemma follows from the above estimates, for $A \in\{\mathbf{1}, \nabla\}$. The case $A=J$ is similar to the case $A=\nabla$, since $J(t)=S(t) x S(-t)$ and $J$ acts on gauge invariant nonlinearities like the gradient, (2.7).

So far, we have supposed $\sigma \geqslant 1 / 2$. From the next proposition on, we need to require $\sigma>1 / 2$, as pointed out in the proof below.

Proposition 6.2. Suppose $\sigma>1 / 2$. Let $(q, r)$ be an admissible pair. Consider an interval $I$ of the form $I=\overline{[a \tau, b \tau)}$, with $a, b \in \mathbb{N} \cup\{\infty\}$ such that $0 \leqslant a<b \leqslant \infty$. There exists $K_{2}$ such that if

where $Z_{\tau}^{\phi_{j}}(n \tau)=\left(S_{\tau}(\tau) N(\tau)\right)^{n} \Pi_{\tau} \phi_{j}$.

- If $\psi \in \Sigma \cap H^{2}\left(\mathbb{R}^{d}\right)$, with $\left\|Z_{\tau}^{\psi}\right\|_{X(\{a \tau\})} \leqslant M$, then there exists a constant $C=C(d, \sigma, M, \psi)>0$ such that

- Assume $\phi \in \Sigma$ satisfies $\|\phi\|_{X(\{a \tau\})} \leqslant M / 2$. denote $u^{\phi}$ by the solution of (1.1) with the initial condition $u_{\mid t=a \tau}=\phi$, i.e., $u$ is given by (2.1) with $t_{0}=a \tau$. Similarly in the discrete version, let $Z_{\tau}^{\phi}(n \tau)(n>a)$ be given by (3.1) with $Z_{\tau}(a \tau)$ replaced by $\phi$. Then it holds that

Remark 6.3. In view of Remark 5.2 the assumption (6.3) means, typically for $M$ large, that either $I$ is finite with $|I|$ sufficiently small, say $|I|=T \approx M^{-\gamma}$, or $I=[N T, \infty)$, with

We consider the difference between the Duhamel formulas of $Z_{\tau}^{\phi_{1}}$ and $Z_{\tau}^{\phi_{2}}$ provided by (3.1). For $A \in\{\mathbf{1}, \nabla, J\}$, (3.1) together with Corollary 3.4 yields

\end{aligned}
$$

+\left\|A\left(\frac{N(\tau)-1}{\tau} Z_{\tau}^{\phi_{2}}-\frac{N(\tau)-1}{\tau} Z_{\tau}^{\phi_{1}}\right)\right\|_{\ell^{q_{0}^{\prime}\left(I ; L^{r_{0}^{\prime}}\right)}}
$$

In view of Proposition 5.1 with choosing $K_{2}>0$ small enough in (6.3), for $(q, r) \in$ $\left\{\left(q_{0}, r_{0}\right),(\infty, 2)\right\}$, we have

\lesssim & \max _{A \in\{\mathbf{1}, \nabla, J\}}\left\|A(a \tau)\left(Z_{\tau}^{\phi_{2}}(a \tau)-Z_{\tau}^{\phi_{1}}(a \tau)\right)\right\|_{L^{2}} \\

where we recall that the norm $\|\cdot\|_{\Gamma(I)}$ is defined in (5.1). In view of Bernstein inequality (3.7), for $j=1,2$,

& \lesssim \tau^{-2 / q_{0}}\left\|\langle n \tau\rangle^{-\delta\left(r_{0}\right)}\right\|_{\frac{4 \sigma-1}{4 \sigma-1}}^{\ell^{\frac{4 \sigma}{2 \sigma-1}(I)}}\left\|Z_{\tau}^{\phi_{j}}\right\|_{\Gamma(I)}^{4 \sigma-1}  \tag{6.8}\\
& \lesssim \tau^{-2 / q_{0}}\left\|\langle n \tau\rangle^{-\delta\left(r_{0}\right)}\right\|_{\ell \gamma(I)}^{4 \sigma-1} M^{4 \sigma-1}
\end{align*}

where we have used (6.7) and $\frac{4 \sigma-1}{2 \sigma-1}>1$ for the last inequality. Note that if $\sigma=1 / 2$, the Lebesgue exponent $\frac{4 \sigma-1}{2 \sigma-1} \gamma$ becomes infinite, and we can no longer invoke (3.7) like we did above. This is why we assume $\sigma>1 / 2$. In view of (2.3), we get

The inequality (6.4) then follows in the same fashion as in the proof of Proposition 5.1. up to considering a smaller constant $K_{2}$.

Proof of (6.5). Assume that $\psi \in \Sigma \cap H^{2}\left(\mathbb{R}^{d}\right)$, with $\left\|Z_{\tau}^{\psi}\right\|_{X(\{a \tau\})} \leqslant M$, and let $A \in\{\mathbf{1}, \nabla, J\}$. We estimate $Z_{\tau}^{\psi}(n \tau)-\Pi_{\tau} u^{\psi}(n \tau)$ instead of $Z_{\tau}^{\psi}(n \tau)-u^{\psi}(n \tau)$, since we have

In this decomposition, $\mathcal{G}_{1}$ must be thought of as an arbitrary small perturbation of the left hand side, and $\mathcal{G}_{2}$ must be thought of as the actual source term.

Let $(q, r)$ be an admissible pair, and $A \in\{\mathbf{1}, \nabla\}$. We estimate the terms of the above right hand side, after the action of $A$. First, discrete Strichartz estimates (3.3) and Lemma 6.1 yield

& +\left(\left\|\langle n \tau\rangle^{-\delta\left(r_{0}\right)}\right\|_{\ell^{\gamma}(I)} M\right)^{2 \sigma-1} M\left\|Z_{\tau}^{\psi}-\Pi_{\tau} u^{\psi}\right\|_{\ell^{\gamma}\left(I ; L^{r_{0}}\right)} \\

When $A=J$, we recall that in view of Corollary 3.4, we may repeat the same computations, up to an (irrelevant) extra multiplicative factor $1+C \tau^{1 / 2}$. Picking $\left\|\langle n \tau\rangle^{-\delta\left(r_{0}\right)}\right\|_{\ell \gamma(I)} M$ sufficiently small,

\max _{\substack{A \in\{1,, J\} \\(q, r) \text { admissible }}}\left\|A \mathcal{G}_{2}\right\|_{\ell^{q}\left(I ; L^{r}\right)} \leqslant C(d, \sigma, M, \psi) \tau^{1 / 2}
$$

hence (6.5) is established by similar induction applied in the proof of Lemma 4.1
Proof of (6.6). Let $\varepsilon \in(0, M / 2)$, and $\psi \in H^{2} \cap \Sigma$ such that

$$
\|\phi-\psi\|_{X(\{a \tau\})} \leqslant \varepsilon
$$

Then $\|\psi\|_{X(\{a \tau\})} \leqslant M$, so we may invoke Theorem 2.5 and (6.4) to claim that

$$
\left\|u^{\phi}-u^{\psi}\right\|_{Y(\mathbb{R})} \leqslant C\|\phi-\psi\|_{X(\{a \tau\})} \lesssim \varepsilon
$$

and, since $u^{\phi}(a \tau)=Z_{\tau}^{\phi}(a \tau)=\phi$,

$$
\max _{A \in\{\mathbf{1}, \nabla, J\}}\left\|A(n \tau)\left(Z_{\tau}^{\phi}(n \tau)-Z_{\tau}^{\psi}(n \tau)\right)\right\|_{\ell \infty\left(I ; L^{2}\right)} \leqslant C\|\phi-\psi\|_{X(\{a \tau\})} \lesssim \varepsilon
$$

On the other hand, (6.5) yields

$$
\max _{A \in\{\mathbf{1}, \nabla, J\}}\left\|A(n \tau)\left(Z_{\tau}^{\psi}(n \tau)-u^{\psi}(n \tau)\right)\right\|_{\ell \infty\left(I ; L^{2}\right)} \leqslant C(d, \sigma, M, \psi) \tau^{1 / 2}
$$

and the triangle inequality implies

$$
\max _{A \in\{\mathbf{1}, \nabla, J\}}\left\|A(n \tau)\left(Z_{\tau}^{\phi}(n \tau)-u^{\phi}(n \tau)\right)\right\|_{\ell \infty\left(I ; L^{2}\right)} \leqslant C(d, \sigma, M, \psi) \tau^{1 / 2}+C(d, \sigma, M) \varepsilon
$$

Therefore, for all $\varepsilon \in(0, M / 2)$,

$$
\limsup _{\tau \rightarrow 0} \max _{A \in\{\mathbf{1}, \nabla, J\}}\left\|A(n \tau)\left(Z_{\tau}^{\phi}(n \tau)-u^{\phi}(n \tau)\right)\right\|_{\ell_{\infty}^{\infty}\left(I ; L^{2}\right)} \leqslant C(d, \sigma, M) \varepsilon
$$

and the left hand side must then be zero.

## 7. Global $\Sigma$ stability of $Z_{\tau}$

In this section, we prove Theorem 1.6. As suggested by the statements of Propositions 5.1 and 6.2 the idea is to split $\mathbb{N}$ into finitely many intervals, like in the proof of Theorem 1.3 and apply these local results on each of them: the accumulation of errors is thus limited.

Proof of Theorem 1.6. Let $\phi \in \Sigma$ : in view of Theorem 2.3, there exists $M$ such that

$$
\sum_{A \in\{\mathbf{1}, \nabla, J\}}\left\|A u^{\phi}\right\|_{L^{\infty}\left(\mathbb{R} ; L^{2}\right)} \leqslant \frac{M}{2} .
$$

Consider $K_{2}$ provided by Proposition 6.2, see (6.3). Like in the proof of Theorem 1.3, we can find a finite number $K$ of time intervals $I_{j}=\overline{\left[m_{j} \tau, m_{j+1} \tau\right)}$ with $0=m_{1}<m_{2}<\ldots<m_{K} \in \mathbb{N}, m_{K+1}=\infty$, such that

$$
M\left\|\langle n \tau\rangle^{-\delta\left(r_{0}\right)}\right\|_{L^{\gamma}\left(I_{j}\right)} \leqslant K_{2}, \quad \mathbb{R}_{+}=\bigcup_{j=1}^{K} I_{j} .
$$

Typically, in view of Remarks 5.2 and 6.3 , this means that for $1 \leqslant j \leqslant K-1$, we may consider $\left|I_{j}\right|=T$ sufficiently small (in terms of $M$, and uniformly in $\tau$ ), while $I_{K}$ is of the form $[\alpha T, \infty)$, with $\alpha$ sufficiently large.

For each $1 \leqslant j \leqslant K$, let $\psi_{j} \in \Sigma \cap H^{2}$ such that

$$
\begin{equation*}
\left\|\psi_{j}-u^{\phi}\left(m_{j} \tau\right)\right\|_{X\left(\left\{m_{j} \tau\right\}\right)} \leqslant \frac{M}{\left(10 C_{0}\right)^{K}} \tag{7.1}
\end{equation*}
$$

with $C_{0}$ the largest constant between 1 , the constant $C$ in the first point of Theorem [2.5) and the constant $C$ in (6.4). We show by induction that for $\tau>0$ sufficiently small,

$$
\begin{equation*}
\max _{A \in\{\mathbf{1}, \nabla, J\}}\left\|A(n \tau)\left(Z_{\tau}^{\phi}(n \tau)-u^{\phi}(n \tau)\right)\right\|_{\ell \infty\left(I_{j} ; L^{2}\right)} \leqslant\left(3 C_{0}\right)^{j} \frac{M}{\left(10 C_{0}\right)^{K}}, \tag{7.2}
\end{equation*}
$$

and

$$
\begin{equation*}
\max _{A \in\{\mathbf{1}, \nabla, J\}}\left\|A(n \tau) Z_{\tau}^{\phi}(n \tau)\right\|_{\ell \infty\left(I_{j} ; L^{2}\right)} \leqslant M . \tag{7.3}
\end{equation*}
$$

Let $A \in\{\mathbf{1}, \nabla, J\}$. For $j=1$, we use triangle inequality to observe

$$
\begin{aligned}
\left\|A\left(Z_{\tau}^{\phi}(n \tau)-u^{\phi}(n \tau)\right)\right\|_{\ell \infty\left(I_{1} ; L^{2}\right)} \leqslant & \left\|A\left(Z_{\tau}^{\phi}(n \tau)-Z_{\tau}^{\psi_{1}}(n \tau)\right)\right\|_{\ell \infty\left(I_{1} ; L^{2}\right)} \\
& +\left\|A\left(Z_{\tau}^{\psi_{1}}(n \tau)-u^{\psi_{1}}(n \tau)\right)\right\|_{\ell \infty\left(I_{1} ; L^{2}\right)}
\end{aligned}
$$

$$
+\left\|A\left(u^{\psi_{1}}(n \tau)-u^{\phi}(n \tau)\right)\right\|_{\ell \infty\left(I_{1} ; L^{2}\right)}
$$

In view of (6.4), the first term in the right hand side is controlled by

$$
\left\|A\left(Z_{\tau}^{\phi}(n \tau)-Z_{\tau}^{\psi_{1}}(n \tau)\right)\right\|_{\ell \infty\left(I_{1} ; L^{2}\right)} \leqslant C_{0}\left\|\phi-\psi_{1}\right\|_{X(\{0\})} \leqslant C_{0} \frac{M}{\left(10 C_{0}\right)^{K}}
$$

where we have used (7.1). The second term is estimated in view of (6.5), by

$$
\left\|A\left(Z_{\tau}^{\psi_{1}}(n \tau)-u^{\psi_{1}}(n \tau)\right)\right\|_{\ell \infty}\left(I_{1} ; L^{2}\right) \leqslant \tau^{1 / 2} C\left(d, \sigma, M, \psi_{1}\right)
$$

For $0<\tau \leqslant \tau_{1}=\tau_{1}\left(d, \sigma, M, \psi_{1}\right)$, we infer

$$
\left\|A\left(Z_{\tau}^{\psi_{1}}(n \tau)-u^{\psi_{1}}(n \tau)\right)\right\|_{\ell \infty\left(I_{1} ; L^{2}\right)} \leqslant C_{0} \frac{M}{\left(10 C_{0}\right)^{K}}
$$

We impose a smallness constraint on each $I_{j}$, but since there are finitely many such intervals, the minimum of these $\tau_{j}$ is indeed positive. Finally, Theorem 2.5 and (7.1) yield

$$
\left\|A\left(u^{\psi_{1}}(n \tau)-u^{\phi}(n \tau)\right)\right\|_{\ell \infty\left(I_{1} ; L^{2}\right)} \leqslant C_{0}\left\|\psi_{1}-\phi\right\|_{X(\{0\})} \leqslant C_{0} \frac{M}{\left(10 C_{0}\right)^{K}}
$$

hence (7.2) for $j=1$. To prove (7.3) for $j=1$, write

$$
\begin{aligned}
\left\|A(n \tau) Z_{\tau}^{\phi}(n \tau)\right\|_{\ell\left(I_{1} ; L^{2}\right)} \leqslant & \left\|A(n \tau) u^{\phi}(n \tau)\right\|_{\ell \infty\left(I_{1} ; L^{2}\right)} \\
& +\left\|A(n \tau)\left(Z_{\tau}^{\phi}(n \tau)-u^{\phi}(n \tau)\right)\right\|_{\ell \infty\left(I_{1} ; L^{2}\right)} \\
\leqslant & \frac{M}{2}+3 C_{0} \frac{M}{\left(10 C_{0}\right)^{K}} \leqslant M
\end{aligned}
$$

Suppose now that (7.2) and (7.3) hold for some $1 \leqslant j \leqslant K-1$. We invoke the same intermediary results as in the case $j=1$ :

$$
\begin{aligned}
&\left\|A\left(Z_{\tau}^{\phi}(n \tau)-u^{\phi}(n \tau)\right)\right\|_{\ell \infty\left(I_{j+1} ; L^{2}\right)} \\
& \leqslant\left\|A\left(Z_{\tau}^{\phi}(n \tau)-Z_{\tau}^{\psi_{j+1}}\left(n \tau-m_{j+1} \tau\right)\right)\right\|_{\ell \infty\left(I_{j+1} ; L^{2}\right)} \\
& \quad+\left\|A\left(Z_{\tau}^{\psi_{j+1}}\left(n \tau-m_{j+1} \tau\right)-u^{\psi_{j+1}}\left(n \tau-m_{j+1} \tau\right)\right)\right\|_{\ell^{\infty}\left(I_{j+1} ; L^{2}\right)} \\
&+\left\|A\left(u^{\psi_{j+1}}\left(n \tau-m_{j+1} \tau\right)-u^{\phi}(n \tau)\right)\right\|_{\ell \infty\left(I_{j+1} ; L^{2}\right)} .
\end{aligned}
$$

For the first term on the right hand side, in view of (7.3) at step $j$, we have:

$$
\begin{aligned}
& \left\|A\left(Z_{\tau}^{\phi}(n \tau)-Z_{\tau}^{\psi_{j+1}}\left(n \tau-m_{j+1} \tau\right)\right)\right\|_{\ell \infty\left(I_{j+1} ; L^{2}\right)} \\
\leqslant & C_{0}\left\|Z_{\tau}^{\phi}\left(m_{j+1} \tau\right)-\psi_{j+1}\right\|_{X\left(\left\{m_{j+1} \tau\right\}\right)} \\
\leqslant & C_{0}\left\|Z_{\tau}^{\phi}\left(m_{j+1} \tau\right)-u^{\phi}\left(m_{j+1} \tau\right)\right\|_{X\left(\left\{m_{j+1} \tau\right\}\right)}+C_{0}\left\|u^{\phi}\left(m_{j+1} \tau\right)-\psi_{j+1}\right\|_{X\left(\left\{m_{j+1} \tau\right\}\right)} \\
\leqslant & C_{0} \max _{B \in\{\mathbf{1}, \nabla, J\}}\left\|B\left(Z_{\tau}^{\phi}(n \tau)-u^{\phi}(n \tau)\right)\right\|_{\ell \infty\left(I_{j} ; L^{2}\right)}+C_{0} \frac{M}{\left(10 C_{0}\right)^{K}} \\
\leqslant & C_{0} \times\left(3 C_{0}\right)^{j} \frac{M}{\left(10 C_{0}\right)^{K}}+C_{0} \frac{M}{\left(10 C_{0}\right)^{K}}
\end{aligned}
$$

where we have used (7.2) at step $j$, and (7.1). The second term is estimated in view of (6.5), by
$\left\|A\left(Z_{\tau}^{\psi_{j+1}}\left(n \tau-m_{j+1} \tau\right)-u^{\psi_{j+1}}\left(n \tau-m_{j+1} \tau\right)\right)\right\|_{\ell \infty\left(I_{j+1} ; L^{2}\right)} \leqslant \tau^{1 / 2} C\left(d, \sigma, M, \psi_{j+1}\right)$.
For $0<\tau \leqslant \tau_{j+1}=\tau_{j+1}\left(d, \sigma, M, \psi_{j+1}\right)$, we infer

$$
\left\|A\left(Z_{\tau}^{\psi_{j+1}}\left(n \tau-m_{j+1} \tau\right)-u^{\psi_{j+1}}\left(n \tau-m_{j+1} \tau\right)\right)\right\|_{\ell \infty\left(I_{j+1} ; L^{2}\right)} \leqslant C_{0} \frac{M}{\left(10 C_{0}\right)^{K}}
$$

Eventually, we assume

$$
0<\tau \leqslant \min _{1 \leqslant j \leqslant K} \tau_{j}
$$

Finally, Theorem 2.5 and (7.1) yield

$$
\begin{aligned}
\left\|A\left(u^{\psi_{j+1}}\left(n \tau-m_{j+1} \tau\right)-u^{\phi}(n \tau)\right)\right\|_{\ell \infty\left(I_{j+1} ; L^{2}\right)} & \leqslant C_{0}\left\|\psi_{j+1}-u^{\phi}\left(m_{j+1} \tau\right)\right\|_{X\left(\left\{m_{j+1} \tau\right\}\right)} \\
& \leqslant C_{0} \frac{M}{\left(10 C_{0}\right)^{K}}
\end{aligned}
$$

hence

$$
\begin{aligned}
\left\|A\left(Z_{\tau}^{\phi}(n \tau)-u^{\phi}(n \tau)\right)\right\|_{\ell \infty\left(I_{j+1} ; L^{2}\right)} & \leqslant\left(3^{j} C_{0}^{j+1}+3 C_{0}\right) \frac{M}{\left(10 C_{0}\right)^{K}} \\
& \leqslant\left(3^{j} C_{0}^{j+1}+3 C_{0}^{j+1}\right) \frac{M}{\left(10 C_{0}\right)^{K}}
\end{aligned}
$$

and (7.2) follows for $j+1$. To prove (7.3), write again

$$
\begin{aligned}
\left\|A(n \tau) Z_{\tau}^{\phi}(n \tau)\right\|_{\ell \infty\left(I_{j+1} ; L^{2}\right)} \leqslant & \left\|A(n \tau) u^{\phi}(n \tau)\right\|_{\ell \infty}\left(I_{j+1} ; L^{2}\right) \\
& +\left\|A(n \tau)\left(Z_{\tau}^{\phi}(n \tau)-u^{\phi}(n \tau)\right)\right\|_{\ell \infty\left(I_{j+1} ; L^{2}\right)} \\
\leqslant & \frac{M}{2}+\left(3 C_{0}\right)^{j+1} \frac{M}{\left(10 C_{0}\right)^{K}} \leqslant M
\end{aligned}
$$

This yields Theorem 1.6 for $(q, r)=(\infty, 2)$. The case of other admissible pairs then follows from Proposition 5.1

## 8. Conclusion and outlooks

In this paper, we have proved the first uniform in time error estimate for splitting methods in the context of nonlinear Schrödinger equations. The main tools are discrete Strichartz estimates for the frequency truncated free Schrödinger group established in [18] on the one hand, the Galilean operator $J$ and its main properties discovered in [12] on the other hand. The Galilean operator provides precious dispersive estimates, in the sense that $L^{r}$-norms in space decay with an explicit rate in time: this is more precise than belonging to some space $L_{t}^{q} L_{x}^{r}$, a property related to Strichartz estimates. We have considered Lie-Trotter splitting in time, the question of higher order methods, starting with Strang splitting, remains open.

For several technical reasons (see Remark 2.4), we have assumed $\sigma \geqslant 2 / d$. Filling the gap $\sigma_{*}<\sigma<2 / d$ does not seem straightforward, and is a fairly natural question.

It is very likely that the method presented here can be adapted in order to treat some (defocusing) Hartree-type nonlinearities, of the form

$$
\left(\frac{1}{|x|^{\gamma}} *|u|^{2}\right) u
$$

with $4 / 3<\gamma<\min (4, d)$; see [13, 15] for scattering theory in this case.
As it is the case in several physical models, such as Bose-Einstein condensation (see e.g. [19]), one may ask if our result remains true if (1.1) is replaced by

$$
i \partial_{t} u+\frac{1}{2} \Delta u=|u|^{2 \sigma} u+\frac{|x|^{2}}{2} u
$$

As the harmonic potential prevents large time dispersion (linear solutions are periodic in time), no uniform in time error estimate should be expected to the splitting
method. More generally, if the solution to the Schrödinger equation that we consider is not (sufficiently) dispersive, then our approach fails, as discussed in Remark 1.7 On the other hand, if one considers the repulsive harmonic potential,

$$
i \partial_{t} u+\frac{1}{2} \Delta u=|u|^{2 \sigma} u-\frac{|x|^{2}}{2} u
$$

which enhances the linear dispersion (algebraic decay in time becomes an exponential decay), then the scattering theory developed in [2] suggests that an analogue of Theorem 1.3 may be available.

In the case of linear Schrödinger equations with a potential,

$$
i \partial_{t} u+\frac{1}{2} \Delta u=V u
$$

if $V$ is a short-range potential in the sense that scattering theory is available (see e.g. 7 for a reference including time-dependent potentials), it seems that no uniform in time error estimate is known for splitting methods. The case of short-range potentials should be a reasonable framework to try to prove the analogue of Theorem 1.3 since solutions are asymptotically free (the action of the potential $V$ is negligible for large time), but a suitable technical approach is to be developed.

Probably the most natural and challenging question at this stage would be to adapt our result to the fully discrete case, that is, taking spatial discretization into account. The first remark is that fully discrete Strichartz estimates have been proven in [18]. The most important aspect to address is therefore the adaptation of the Galilean operator $J(t)=x+i t \nabla$. The two operators involved in the definition of $J$, the multiplication by $x$ and the gradient in space, are easily adapted to the discrete case, but the analogue of Proposition 2.2 is certainly the key step to understand, in order to treat the fully discrete case.
