# Folding transformations for $q$-Painlevé equations

#### Abstract

Folding transformation of the Painlevé equations is an algebraic (of degree greater than 1) transformation between solutions of different equations. In 2005 Tsuda, Okamoto and Sakai classified folding transformations of differential Painlevé equations. These transformations are in correspondence with automorphisms of affine Dynkin diagrams.

We give a complete classification of folding transformations of the $q$-difference Painlevé equations, these transformations are in correspondence with certain subdiagrams of the affine Dynkin diagrams (possibly with automorphism). The method is based on Sakai's approach to Painlevé equations through rational surfaces.

## 1 Introduction

The paper is devoted to the classification of folding transformations between solutions of $q$-difference Painlevé equations. We first explain the problem and illustrate it by a simple instructive example.
$q$-Painlevé equations. The $q$-difference Painlevé equations are systems of two difference equations on two functions which we denote by $F, G$. The celebrated Sakai's classification Sak01 assigns to each $q$ difference Painlevé equation two affine root systems. These systems are called the symmetry and the surface root systems, and are denoted by $\Phi_{\text {sym }}^{a}$ and $\Phi_{\text {surf }}^{a}$ respectively. The list of all pairs, together with arrows of degenerations is given in the Fig. 1 .

Here we use the notation $E_{5}^{(1)}=D_{5}^{(1)}, E_{4}^{(1)}=A_{4}^{(1)}, E_{3}^{(1)}=\left(A_{2}+A_{1}\right)^{(1)}, E_{2}^{(1)}=\left(A_{1}+A_{1}\right)^{(1)}, E_{1}^{(1)}=A_{1}^{(1)}$.
The symmetry group of a Painlevé equation is an extended affine Weyl group $W^{a e}$ of the root system $\Phi_{\text {sym }}^{a}$, translations in $W^{a e}$ generate $q$-difference dynamics. The $F, G$ are then coordinates on (some chart of) the surface $\mathcal{X}_{\vec{a}}$ called the space of initial conditions Sak01. This surface depends on set of parameters $a_{0}, \ldots, a_{r}$ which are called multiplicative root variables; here $r+1$ is the rank of $\Phi_{\text {sym }}^{a}$. The Weyl group acts on $a_{j}$ as

where $s_{0}, \ldots, s_{r}$ are simple reflections, $C$ is a Cartan matrix of $\Phi_{\text {sym }}^{a}$ and $\pi$ is an external automorphism.
Example 1.1. The dynamics of the $q$-Painlevé equation is usually denoted by an underline and an overline, $\ldots \mapsto \underline{X} \mapsto X \mapsto \bar{X} \mapsto \ldots$. The standard $q$-Painlevé equation of the symmetry/surface type $D_{5}^{(1)} / A_{3}^{(1)}$ together with symmetry type Dynkin diagram and transformation of root variables are given below

This equation is a $q$-analog of the Painlevé VI equation. Here $a_{2}$ can be considered as a time, $a_{3}$ could be replaced by $q$, while $a_{0}, a_{1}, a_{4}, a_{5}$ are the four parameters of the equation.

The symmetry group is $W_{D_{5}}^{a e}$, it is generated by the simple reflections $s_{0}, \ldots, s_{5}$ and an order 4 external automorphism $\pi$ which permutes the $s_{i}$ (arrows on above Dynkin diagram). The variables $a_{i}$ are multiplicative root variables and the action of $W_{D_{5}}^{a e}$ on them is given by 1.1). The action of this group on the coordinates $F, G$ is given by

Foldings of Painlevé equations. A folding transformation TOS05] is an algebraic map between solutions of Painlevé equations which goes through the quotient of the space of initial conditions. In other words, there is a certain $\vec{a}$, subgroup $H \in \operatorname{Aut}\left(\mathcal{X}_{\vec{a}}\right)$ and birational map between the quotient $\mathcal{X}_{\vec{a}} / H$ and space of initial conditions of another Painlevé equation $\mathcal{Y}_{\vec{a}}$. Such $H$ should then be a subgroup of $W^{a e}$ commuting with certain Painlevé dynamics, we call it folding subgroup.

Example 1.2 (Continuation of Example 1.1). Consider an element $w=s_{0} s_{1} s_{4} s_{5}$ of order 2. It acts as

It is easy to see that $w$ commutes with the $q$-Painlevé dynamics 1.2 .
If $a_{0}=a_{1}=a_{4}=a_{5}=-1$, then $w$ preserves the multiplicative root variables. Equations 1.2 become

where we used that $q=a_{2}^{2} a_{3}^{2}$ in this case. Two equations in 1.5 now look almost the same and this leads to the possibility of creating a half-step (or "extracting a root") of this dynamics. We denote this square root by dashed over-(under-) line and define it by

Then equations 1.5 can be rewritten as

Let us introduce coordinates $\mathrm{F}=F^{2}, \mathrm{G}=F G$, which are invariant under $w$ and give a map of degree 2 from $\mathcal{X}_{\vec{a}}$. Then from (1.7) we have

which is a $q$-Painlevé equation with symmetry/surface type $A_{1}^{(1)} / A_{7}^{(1)^{\prime}}$ (or parameterless $q$-Painlevé III) with $\mathrm{a}_{1}=a_{2}^{2}, \mathrm{a}_{0}=a_{3}^{2}$.

Motivation. Folding transformations lead to algebraic relations between solutions of Painlevé equations. For example, one has a relation between special solutions. The points fixed under the action of $H$ on the surface $\mathcal{X}_{\vec{a}}$ correspond to certain algebraic solutions of the Painlevé equations. On the other hand, in the quotient space $\mathcal{X}_{\vec{a}} / H$ these fixed points become singularities which, after the resolution, give exceptional divisors. Such divisors correspond to Ricatti solutions, so the folding transformation relates the equation having an algebraic solution to that having Riccati solution. This was the original observation in TOS05.

On the other hand, there was huge progress in the last 10 years in the Painlevé theory in relation to the formulas for generic solutions. Namely, it was proposed in GIL12, GIL13 that Painlevé equations can be solved in terms of certain special functions that appeared in mathematical physics. These functions themselves have two definitions: conformal blocks in 2d conformal field theory [BPZ84] and partition functions in $4 \mathrm{~d} \mathcal{N}=2$ supersymmetric gauge theory Nek03. The equivalence between these two definitions is famous AGT correspondence AGT10. Later the formulas for generic solutions were extended to the case of $q$-difference Painlevé equations for $E_{r}^{(1)}, r \leq 4$ symmetry BS17, JNS17, BGT19, MN19].

Therefore, folding transformations lead to nontrivial algebraic relations between partition functions. And the folding transformation discussed in Example 1.2 indeed has such meaning. The corresponding relation is (roughly speaking) a combination of the identity found in the conformal field theory Pog09, FLNO09, HJS10 and bilinear relations from the gauge theory [NY05a, NY05b. This was (again, roughly speaking) observed in BS19, Shc20, and our original motivation was to find more folding transformations in order to find new relations for partition functions. For the $E_{6}^{(1)}, E_{7}^{(1)}, E_{8}^{(1)}$ we do not have formulas for generic solutions, so the folding transformation gives particular family of solutions.

The classification of folding transformations is a problem also interesting in itself. From the first glance, the task seems to be wild, there are many vectors $\vec{a}$ for which the stabilizer $W_{\vec{a}}^{a e}$ is nontrivial, this stabilizer could act on the surface of initial conditions $\mathcal{X}_{\vec{a}}$. But there is a huge restriction - namely, for given $\vec{a}$ the subgroup of stabilizer $\left(W_{\vec{a}}^{a e}\right)_{\vec{a}}$ generated by reflections acts trivially on the surface $\mathcal{X}_{\vec{a}}$ (with some exceptions for small $\Phi_{\text {sym }}^{a}$, namely for the cases $\left.E_{1}^{(1)}, E_{2}^{(1)}, E_{3}^{(1)}\right)$. It was shown in TOS05], using this observation, that all folding transformations of differential Painlevé equations come from the subgroups of
external automorphisms $\widehat{\Omega} \subset W^{a e}$. More geometrically, $\widehat{\Omega}$ is a subgroup of $W^{a e}$ preserving fundamental alcove. It is well known that $\widehat{\Omega} \simeq P / Q$, where $P$ and $Q$ are weight and root lattices for the finite root system $\Phi_{\text {sym }}$.

Recall that differential Painlevé equations correspond to the additive cases in Sakai's classification [Sak01], contrary to $q$-difference equations, which correspond to the multiplicative cases. In a multiplicative case situation becomes richer, it appears that nontrivial folding transformations could come from the product of reflections from $W^{a}$, and even from the finite Weyl group $W$. This is similar to the known fact in the theory of Lie groups that the centralizer of a semisimple element of the adjoint group can be non-connected, contrary to simply connected case, or Lie algebra case (see e.g. Hum95). And the group of connected components can be identified with a subgroup of the group $\Omega$, where $\Omega$ is the subgroup of $W$ which maps fundamental alcove to a parallel one. It is easy to see that the groups $\Omega$ and $\widehat{\Omega}$ are isomorphic.

Remarkably, it appears that any folding subgroup $H$ can be embedded as

where a reducible root system $\sqcup_{j} \Phi_{j}$ corresponds to a subdiagram $I \subset \Delta^{a}$ in the affine Dynkin diagram of $\Phi^{a}$. Only special subdiagrams and special subgroups of 1.9 give (essentially different) foldings. We proceed now to the more precise statement.

Main result. It follows from formula (1.9) that any folding subgroup $H$ is solvable. So it is convenient to classify first the cyclic folding subgroups and then to construct general folding subgroups from the cyclic ones.

Clearly it is sufficient to classify folding subgroups in $H \subset W^{a e}$ up to conjugacy. Moreover, since the map from $W^{a e} \rightarrow$ Aut $\mathcal{X}_{\vec{a}}$ can have a kernel, it is sufficient to classify the images of $H$ in Aut $\mathcal{X}_{\vec{a}}$.

Theorem 1. a) There are 24 nonequivalent cyclic folding subgroups. They are given in Table 1 .
b) There are also 9 nonequivalent non-cyclic folding subgroups. They are given in Table 2 ,

Let us explain the notation used in the tables. For each folding subgroup, we draw nodes of the corresponding subset in black. We label folding transformation via types of the root system generated by simple roots corresponding to $I$. If $H$ contains (at least as a factor) an external automorphism $\pi \in \widehat{\Omega}$, we also write its action on the diagram and add $\pi \ltimes$ in the notation of the folding transformation. In particular, if the folding subgroup is a subgroup of $\widehat{\Omega}$, then we draw all vertices in white and denote the corresponding folding transformation by $\pi$.

For each folding subgroup, we draw an arrow whose source is the symmetry of the initial Painlevé equation and whose target is the Painlevé equation after the folding. We write the degree of the transformation above the arrow.

In Table 2 we also write the isomorphism class of the group $H$. Note that contrary to differential foldings, in this case the group $H$ can be non-commutative.
Example 1.3. The folding transformation used in the Example 1.2 in this notation corresponds to the subdiagram $4 A_{1} \subset D_{5}^{(1)}$. The corresponding folding subgroup is generated by $w=s_{0} s_{1} s_{4} s_{5} \in \Omega_{A_{1}}^{4}$.

Remark 1.1. The diagrams represented in Table 1 are specified by the element $\pi \in \widehat{\Omega}$ and the coloring which satisfies the following combinatorial properties. Let $I$ denote subgraph of $\Delta^{a}$ with black vertices, $\left\{\Delta_{j}\right\}$ be the set of connected components of $I$, and $n_{j}$ be a number of vertices in $\Delta_{j}$. Then:

- Each $\Delta_{j}$ is a Dynkin diagram of type $A$. Coloring is invariant with respect to $\pi$, if some $\Delta_{j}$ is $\pi$-invariant as a set, then $\pi$ acts trivially on it.
- Number of $\pi$ orbits on the set of vertices $\Delta^{a} \backslash I$ is at least 2 .
- In each $\pi$-orbit choose one component $\Delta_{j}$, called distinguished. Number the vertices of each distinguished component successively from 1 to $n_{j}$. Then there is a choice of integer numbers $m_{j}, 0<m_{j} \leq n_{j}, \quad \operatorname{gcd}\left(m_{j}, n_{j}+1\right)=1$, for each distinguished component such that, for any white vertex $c$,

where the sum runs over the set of black vertices belonging to the set of distinguished components $I_{D}$ and adjacent to $c, j(b)$ is such that $b \in \Delta_{j(b)}$, and $i_{b}$ is the number of $b$ in the component $\Delta_{j(b)}$.

In the main text we present more details about folding transformations given in tables 122 In particular, we present the corresponding subgroups $H \subset W^{a e}$, give explicit formulas for the coordinate transformation $\mathrm{F}=\mathrm{F}(F, G), \mathrm{G}=\mathrm{G}(F, G)$, and compute the automorphism group of the image.

Content of the paper. The main text of the paper consists of two parts: the first one is devoted to the algebra and combinatorics of the affine Weyl group (Secs. 2, 4) and the second one is devoted to the geometry of rational surfaces (Secs. 3. 5). In each of the two parts, we first explain the results and give some examples, and then we give some tables with the explicit data.

Section 2 is devoted to the classification. Theorem 2 reduces the problem to the subgroups of 1.9 . In Section 2.4 we obtain selection rules as in Remark 1.1, and in Section 2.5 we give the results.

In Section 2.6 we discuss the normalizer subgroup $N=N\left(H, W^{a e}\right) \subset W^{a e}$ of $H$. The group $N$ is important since it acts after the folding. In particular, it should include the Painlevé dynamics. Here we restrict ourselves to the case of cyclic $H$ and denote its generator by $w$. Roughly speaking the answer is the following. Let $Q_{\text {fold sym }}^{a}$ be the sublattice in $Q_{\text {sym }}^{a}$ invariant under $w$. Then it appears that $Q_{\text {fold sym }}^{a}$ is the lattice for the affine root system $\Phi_{\text {fold sym }}^{a}$ and the group $N$ on the image is a finite extension of the affine Weyl group $W_{\text {fold sym }}^{a}$. Details on the computation of $N$ in each case are given in Sec. 4 .

As we saw in Example 1.2, for special values of the parameters it may be possible to extract a root of the dynamics. This phenomenon is called a projective reduction of the Painlevé equation [KNT11], KN13. Projective reductions quite often appear in examples of folding transformations, we also discuss this Sec. 2.6

In the geometrical part, we find the type of a Painlevé equation after the folding ${ }^{1}$ and compute explicit formulas for the coordinates $\mathrm{F}=\mathrm{F}(F, G), \mathrm{G}=\mathrm{G}(F, G)$. To do this we have to take the quotient $\mathcal{X}_{\vec{a}} / H$, resolve its singularities, and then (probably after some blowdown) identify the result with the space $\mathcal{Y}_{\vec{a}}$ of initial conditions of the resulting Painlevé equation. This scheme is described in Sec. 3 and details for

[^1]each example are given in Sec. 5. For the convenience of the reader, note that tables with the main results are given in Sec. 3.4. In Sec. 3.3 (again, with details in Sec. 5) we compute the symmetry group from the geometry of $\mathcal{Y}_{\vec{a}}$ and observe that it is in complete agreement with the computation of $N$ mentioned above.

Finally, in Section 6 we shortly discuss two questions that are natural after completion of the classification. The first question is the continuous limit. Unfortunately, we do not have a complete answer, so we will limit ourselves to one example. The second question is a comparison of our classification with previously known examples. There are 4 folding transformations of $q$-difference equations in RGT00 (see also [RNGT09]), we found them in our classification. The fifth example appeared in [BS19].

Notation. Here we list some notation and abbreviations which we used through the main text. Of course this not the full list, but rather a list necessary to avoid confusion.

- $C_{n}$ : the cyclic group of order $n$,
- $\zeta_{n}$ : some primitive root of 1 of order $n$,
- $\mathrm{i}=\sqrt{-1}, \zeta=\zeta_{3}$,
- $s_{i_{1} \ldots i_{k}}=s_{i_{1}} \cdot \ldots \cdot s_{i_{k}}$, where $s_{i_{1}} \ldots s_{i_{k}}$ are simple reflections.
- $t_{\lambda}$ are translations in affine Weyl group, corresponding to weight $\lambda \in P$.
- $\alpha_{i_{1} \ldots i_{k}}=\alpha_{i_{1}}+\ldots+\alpha_{i_{k}}$, where $\alpha_{i_{j}}$ are simple roots.
- $\omega_{i}, \omega_{\alpha_{i}}$ : fundamental weight, corresponding to the simple root $\alpha_{i}$.
- $F, G, a_{i}, q, E_{i}$ : coordinates, root variables, imaginary root variable, exceptional divisors on the surface from which folding transformation acts.
- $\mathrm{F}, \mathrm{G}, \mathrm{a}_{i}, \mathrm{q}, \mathcal{E}_{i}$ : coordinates, root variables, imaginary root variable, exceptional divisors on the surface obtained after folding transformation.
- $E_{i_{1} \ldots i_{k}}=E_{i_{1}}+\cdots+E_{i_{k}}, H_{F G}=H_{F}+H_{G}$.

## 2 Classification of folding transformations

### 2.1 Main problems

Sakai's geometric approach. Celebrated Sakai's classification Sak01 relates $q$-Painlevé equations to the families of rational surfaces $\mathcal{X}$. These surfaces are blowups of $\mathbb{P}^{1} \times \mathbb{P}^{1}$ in 8 points (or, equivalently, $\mathbb{P}^{2}$ in 9 points). We will usually denote coordinates on $\mathbb{P}^{1} \times \mathbb{P}^{1}$ by $F$ and $G$.

Each family is parametrized by a collection of root variables $\vec{a}=\left(a_{0}, \ldots, a_{r}\right) \in \mathcal{A} \subset\left(\mathbb{C}^{*}\right)^{r+1}{ }^{2}$, which correspond to the set $\left\{\alpha_{0}, \ldots, \alpha_{r}\right\}=\Delta^{a}$ of simple roots of certain affine root system $\Phi^{a}$. The positions of 8 blowup points are given in terms of $\vec{a}$. Symmetries of the family $\mathcal{X}$ are given by affine extended Weyl group $W^{a e}$ of root system $\Phi^{a}$, thus type of this system in called symmetry typ $8^{3}$ All these $\Phi^{a}$ are of $E$-type: $\Phi^{a}=E_{r}^{(1)}, r=1 \ldots 8$, see Fig. 1 above.

Group $W^{a e}$ is a semidirect product $\Omega \ltimes W^{a}$ of affine Coxeter group $W^{a}$ and group of external automorphisms $\widehat{\Omega}$. Hence $W^{a e}$ is generated by simple reflections $s_{i}, i=0, \ldots, r$ and permutations of simple roots $\pi$. Action of $w$ on root variables is multiplicative, namely

$$
\begin{equation*}
s_{i}\left(a_{j}\right)=a_{j} a_{i}^{-C_{i j}}, s_{i} \in W^{a}, \quad \pi\left(a_{i}\right)=a_{\pi(i)}, \pi \in \widehat{\Omega}, \tag{2.1}
\end{equation*}
$$

where $C_{i j}$ is Cartan matrix of $\Phi^{a}$.
Group $W^{a e}$ acts between different members of the family $\mathcal{X}$, nontrivially acting on $\mathcal{X}_{\vec{a}}$

$$
\begin{equation*}
W^{a e} \ni w: \quad \mathcal{X}_{\vec{a}} \rightarrow \mathcal{X}_{w(\vec{a})}, \quad(F, G) \in \mathcal{X}_{\vec{a}} \mapsto(w(F), w(G)) \in \mathcal{X}_{w(\vec{a})} \tag{2.2}
\end{equation*}
$$

Explicit formulas for the action are given in Section 5. More details about Sakai's approach can be found in review KNY17, we usually follow loc. cit. in notations and conventions.

Folding: definition. We see that generally, the symmetry changes $\vec{a}$. However, under restrictions on parameters $\vec{a}$ symmetry can act as an automorphism of corresponding $\mathcal{X}_{\vec{a}}$ and such automorphism can be nontrivial. This phenomenon is what we call folding

Definition 2.1. Folding transformation of surface is an element $w \in W^{a e}$ and family $\mathcal{A}_{w} \subset \mathcal{A}$ of root variable tuples such that for any (generic) $\vec{a} \in \mathcal{A}_{w}$ we have

$$
\begin{equation*}
w(\vec{a})=(\vec{a}), \quad w((F, G)) \neq(F, G) . \tag{2.3}
\end{equation*}
$$

Folding subgroup is a subgroup $H \subset W^{a e}$ and family $\mathcal{A}_{H}$ of root variable tuples such that for any (generic) $\vec{a} \in \mathcal{A}_{H}$ we have an embedding $H \rightarrow \operatorname{Aut}\left(\mathcal{X}_{\vec{a}}\right)$.

Without loss of generality, we can take $\mathcal{A}_{w}\left(\mathcal{A}_{H}\right)$ to be an irreducible component of the invariant subset $\mathcal{A}^{w}\left(\mathcal{A}^{H}\right)$. We will see below that for given $w$ there is often only one component $\mathcal{A}_{w}$ which gives nontrivial folding transformation. If there are several such components, then they give folding transformations, equivalent under a certain symmetry. Hence we will label folding transformations by group element $w \in W^{a e}$.

Informally we can say that the folding subgroup is a subgroup in which any nontrivial element is folding transformation. Individual folding transformations correspond to the cyclic folding subgroups $H$. As already mentioned in the Introduction we concentrate first on these cyclic groups and then construct all folding subgroups from cyclic ones.

For the folding subgroup, we can take the quotient $\mathcal{X}_{\vec{a}} / H$. The normalizer subgroup $N$ of $H$ in $W^{a e}$ acts on the family $\mathcal{A}_{H}$. Therefore it is natural to ask for the birational model $Y$ of the quotient $\mathcal{X}_{\vec{a}} / H$ and map from $N$ to the corresponding affine Weyl group. If $\mathcal{X}$ corresponds to root system $\Phi^{a}$ and $\mathcal{Y}$ corresponds to root system $\Phi^{\prime a}$ we say that we get folding transformation from symmetry type $\Phi^{a}$ to symmetry type $\Phi^{\prime a}$.

The first key point in the classification of folding transformations is the following lemma and corollary.
Lemma 2.1. For $a_{i}=1$ we have $s_{i}(F, G)=(F, G)$.

[^2]Proof. One can just check the statement of the lemma case-by-case, using formulas for action of simple reflections from Section 5 or KNY17]

Remark 2.1. According to formulas from Section 5 the simple reflections $s_{0}$ for $E_{7}^{(1)} / A_{1}^{(1)}$ and $s_{1}$ for $E_{8}^{(1)} / A_{0}^{(1)}$ naively violate the statement of the lemma. However, this is not the case, because value 1 for root variables $a_{0}$ for $E_{7}^{(1)} / A_{1}^{(1)}$ and $a_{1}$ for $E_{8}^{(1)} / A_{0}^{(1)}$ is excluded from the family $\mathcal{X}$, since it leads to another geometry, see defining equations (5.11) for $E_{7}^{(1)} / A_{1}^{(1)}$ case and 5.1) for $E_{8}^{(1)} / A_{0}^{(1)}$ case.

There is also a geometric proof of the Lemma 2.1, see Section 3.1 .
Corollary 2.2. Let root $\alpha$ belong to component of $\Phi^{a}$ different from $A_{1}^{(1)}$, let $s_{\alpha}$ be the corresponding reflection. If $s_{\alpha}(\vec{a})=\vec{a}$ then $s_{\alpha}((F, G))=(F, G)$.

In other words the condition of the lemma holds if $\Phi^{a}$ is different from $E_{1}^{(1)}, E_{2}^{(1)}$ and $E_{3}^{(1)}$.
Proof of the Colorrary. Since any roots is conjugated to simple one it is sufficient to consider case $\alpha=\alpha_{i}$. It follows from the assumptions of the corollary that there exists simple root $\alpha_{j}$ such that $C_{i j}=-1$. Hence $s_{i}\left(a_{j}\right)=a_{j}$ implies $a_{i}=1$ and it remains to use Lemma 2.1.

Folding on equations. $q$-Painlevé equations correspond to translations in affine Weyl group. Recall that affine Weyl groups have a structure of semidirect product

$$
\begin{equation*}
W^{a}=Q \rtimes W, \quad W^{a e}=P \rtimes W . \tag{2.4}
\end{equation*}
$$

Here $W$ is (finite) Weyl group corresponding to (finite) root system $\Phi, Q$ is a root lattice of $\Phi$ and $P$ is a weight lattice of $\Phi$. We denote by $\bar{w} \in W$ the finite part of $w \in W^{a(e)}$. We denote fundamental weight corresponding to simple root $\alpha_{i}$ by $\omega_{i}$.

For any $\lambda \in P$ let $t_{\lambda}$ be the corresponding element of $W^{a e}$. Its action on root variables is given by $t_{\lambda} a_{i}=q^{\left(\lambda, \alpha_{i}\right)} a_{i}$. Here $q$ corresponds to imaginary root $\delta \in \Phi^{a}$, namely

$$
\begin{equation*}
\delta=\sum_{i=0}^{r} \mathfrak{m}_{i} \alpha_{i}, \quad q=\prod_{i=0}^{r} a_{i}^{\mathfrak{m}_{i}} . \tag{2.5}
\end{equation*}
$$

Coefficients $\mathfrak{m}_{i}$ of $\delta$ decomposition into sum of simple roots $\alpha_{i}$ we call marks of $\alpha_{i}$.
The action of translation $t_{\lambda}$ on coordinates $F, G$ is very nontrivial. The $q$-Painlevé equation is an equation on the section of the bundle $\mathcal{X} \rightarrow \mathcal{A}$ equivariant under the action of $t_{\lambda}$. Namely, $q$-Painlevé equations are equations of the form

$$
\begin{equation*}
t_{\lambda}(F(\vec{a}), G(\vec{a}))=\left(F\left(t_{\lambda}(\vec{a})\right), G\left(t_{\lambda}(\vec{a})\right)\right) \tag{2.6}
\end{equation*}
$$

on functions $(F(\vec{a}), G(\vec{a}))$ (which actually take values in surface $\mathcal{X}_{\vec{a}}$ ). In a sense, the Painlevé equation is defined by the family of surfaces and chosen translation $t_{\lambda}$.

Remark 2.2. There is a slight extension of this construction. Namely, for certain values of root variables $\vec{a}$, there is certain $w \in W^{a e}, w^{k} \in P$ which act as a translation by $q^{1 / k}$ for certain $k \in \mathbb{Z}_{>0}$. Such phenomenon is called projective reduction, see e.g. KNT11, KN13. Projective reductions quite often appear in the study of the folding transformations, see end of Sec. 2.6 below.

In order to have folding transformation (or folding subgroup) of $q$-difference Painlevé equation we need translation $t_{\lambda}$ which will act on the quotient $\mathcal{X}_{\vec{a}} / H$. Hence $t_{\lambda}$ belongs to the normalizer subgroup $N$. We will call folding transformation $\left(w, \mathcal{A}_{w}\right)$ true folding if there is translation in $N$ and the family $\mathcal{A}_{w}$ contains points with arbitrary $q$. Similarly we define true folding subgroup.

The true folding condition requires that family $\mathcal{A}_{w}$ (correspondingly $\mathcal{A}_{H}$ ) is at least two dimensional since one parameter is $q$, and another parameter is shifted by translation. The normalizer subgroup $N$ could contain several linear independent translations, for this case one folding transformation (or folding subgroup) gives transformation for several $q$-Painlevé equations.

Below we give a list of all up to conjugations in $W^{a e}$ possible cyclic true folding subgroups. To be more precise we classify the images of the folding subgroups in the automorphism group of $\mathcal{X}_{\vec{a}}$, this is important
since as we saw in Lemma 2.1 the map from $W^{a e}$ to automorphism group can have a kernel. Our approach is based on the combinatorics of the affine Weyl group, the only geometric input is Lemma 2.1. Then, in Section 5 we will see that all transformations from the list found by such approach give non-equivalent true folding transformations.

### 2.2 Stabilizer

Additive case. Let $\Phi$ be a finite simply laced irreducible root system, $\Delta=\left\{\alpha_{1}, \ldots, \alpha_{r}\right\}$ set of its simple roots, $W_{\Phi}$ be the corresponding Weyl group. Let $V_{\Phi}$ be a real vector space with coordinates $x_{1}, \ldots, x_{l}$ with action of group $W_{\Phi}$ by the formula $s_{i}\left(x_{j}\right)=x_{j}-C_{i j} x_{j}$. In more invariant terms $V_{\Phi}$ is a space dual to the real vector space generated by $\alpha_{1}, \ldots, \alpha_{r}$.

There is a standard action of the extended affine Weyl group $W_{\Phi}^{a e}$ on $V_{\Phi}$, namely for $\lambda \in P$ translations $t_{\lambda}$ act as $x_{i} \mapsto x_{i}+\left(\lambda, \alpha_{i}\right)$. Subgroup $W_{\Phi}^{a} \subset W_{\Phi}^{a e}$ is generated by reflections. The reflection hyperplane for $s_{0}$ is given by the equation $\sum_{i=1}^{r} \mathfrak{m}_{i} x_{i}=1$, where marks $\mathfrak{m}_{i}$ are defined by the expansion of the highest root $\theta=\sum_{i=1}^{r} \mathfrak{m}_{i} \alpha_{i}$.
Remark 2.3. In the standard convention $\alpha_{1} \ldots, \alpha_{r}$ are roots of finite root system and $\alpha_{0}=-\theta+\delta$ is additional "affine" root. Here as usual $\delta$ is an imaginary root and $\theta$ is highest root. Hence $\sum_{i=0}^{r} \mathfrak{m}_{i} \alpha_{i}=\delta$, where $\mathfrak{m}_{0}=1$ in agreement with formula (2.5).

In the paper, we follow conventions of KNY17] in the numbering of simple roots in $\Phi^{a}$. This convention in two cases disagrees with one above, namely for $E_{7}^{(1)}$ affine root is $\alpha_{7}$ and for $E_{8}^{(1)}$ affine root is $\alpha_{8}$. All statements in this section will be given in the invariant form, so this discrepancy will not lead to confusion.

The (closed) fundamental alcove Alc $\subset V_{\Phi}$ is the set bounded by the hyperplanes of simple reflections in $W^{a}$. In coordinates Alc is defined by the equations $x_{i} \geq 0,1 \leq i \leq r$ and $\sum_{i=1}^{r} \mathfrak{m}_{i} x_{i} \leq 1$. Below we will identify facets of the fundamental alcove with the set $\Delta^{a}$ of simple roots of the affine root system. The fundamental alcove is the fundamental domain for the action of $W^{a}$ on $V_{\Phi}$, see e.g. Hum90, Th. 4.8]. Let $\widehat{\Omega} \subset W^{a e}$ denotes subgroup which preserves Alc. Clearly we have decomposition $W^{a e} \simeq \widehat{\Omega} \ltimes W^{a}$. Hence $\widehat{\Omega} \simeq P / Q$. Elements of the group $\widehat{\Omega}$ permutes facets of Alc, i.e. perform permutation of the set of $\alpha_{0}, \ldots, \alpha_{r}$, this permutation is automorphism of affine Dynkin diagram.

The following lemma is standard.
Lemma 2.3. Let $\vec{x} \in \operatorname{Alc}, I \subset \Delta^{a}$ denotes the set of facets containing $\vec{x}$ and $W_{I}^{\circ}$ denotes subgroup of $W^{a}$ generated by $s_{i}, i \in I$. Then the stabilizer of $\vec{x}$ in $W^{a e}$ has the form $W_{\vec{x}}^{a e}=\widehat{\Omega}_{\vec{x}} \ltimes W_{I}^{\circ}$, where $\widehat{\Omega}_{\vec{x}}$ is stabilizer of $\vec{x}$ in $\widehat{\Omega}$.

Proof. It follows from Hum90, proof of Th. 4.8] that stabilizer of $\vec{x}$ in $W^{a}$ is $W_{I}^{\circ}$. If $\pi w(\vec{x})=\vec{x}$ for $\pi \in \widehat{\Omega}$, $w \in W^{a}$ then $w(\vec{x}) \in$ Alc hence $w(\vec{x})=\vec{x}$ (see Hum90, proof of Th. 4.8]).

We will need an analog of this statement for the reducible root system $\Phi=\sqcup_{j=1}^{l} \Phi_{j}$. Here and below in such occasions we assume roots systems $\Phi_{j}$ are irreducible, and use notations like $\Delta_{j}^{a}, W_{j}^{a e}, \mathrm{Alc}_{j}$ for the corresponding set of affine simple roots, affine Weyl group, and fundamental alcove. Let Aut ${ }_{\Phi}$ be a group of external automorphisms of $\Phi$. Any element $\sigma \in \operatorname{Aut}_{\Phi}$ acts on simple roots $\Delta_{j}$ as permutation or moves them to roots $\Delta_{j}^{\prime}$ of isomorphic component. The fundamental alcove $\mathrm{Alc}_{\Phi}$ is a product $\prod \mathrm{Alc}_{j}$, the set of facets of $\mathrm{Alc}_{\Phi}$ is a union $\sqcup \Delta_{j}^{a}$. We can extend finite and affine Weyl groups of $\Phi$ by $\mathrm{Aut}_{\Phi}$

$$
\begin{equation*}
\widetilde{W}_{\Phi}=\operatorname{Aut}_{\Phi} \ltimes \prod_{j=1}^{l} W_{j}, \quad \widetilde{W}_{\Phi}^{a e}=\operatorname{Aut}_{\Phi} \ltimes \prod_{j=1}^{l} W_{j}^{a e} . \tag{2.7}
\end{equation*}
$$

Lemma 2.4. Let $\vec{x} \in \mathrm{Alc}_{\Phi}$, and $I, W_{I}^{\circ}$ are as in Lemma 2.3. Then the stabilizer of $\vec{x}$ in $\widetilde{W}_{\Phi}^{a e}$ has the form $\widetilde{W}_{\Phi, x}^{a e}=\left(\operatorname{Aut}_{\Phi} \ltimes \prod \widehat{\Omega}_{j}\right)_{\vec{x}} \ltimes W_{I}^{\circ}$.

The proof of this lemma is the same as proof of Lemma 2.3 , with replacement of $\widehat{\Omega}$ to Aut ${ }_{\Phi} \ltimes \Pi \widehat{\Omega}_{j}$.
Let $\Omega \in W$ denotes subgroup which maps fundamental alcove Alc into parallel one. It is easy to see that any element $\pi \in \widehat{\Omega}$ has unique decomposition $\pi=t_{-\omega_{\pi}} \bar{\pi}$, where $\bar{\pi} \in \Omega$. Hence the groups $\widehat{\Omega}$ and $\Omega$ are isomorphic. For reducible system $\Phi=\sqcup_{j=1}^{l} \Phi_{j}$ we denote $\widetilde{\Omega}_{\Phi}=\operatorname{Aut}_{\Phi} \ltimes \prod \Omega_{j}$, this is subgroup of $\widetilde{W}_{\Phi}$ which maps alcove Alc into parallel one.

Corollary 2.5. Let $\Phi=\sqcup_{j=1}^{l} \Phi_{j}$ and $\vec{x} \in$ Alc, then the group $\left\{w \in \widetilde{W}_{\Phi} \mid w \vec{x}-\vec{x} \in P\right\}$ has the form $\widetilde{\Omega}_{(\vec{x})} \ltimes W_{I}^{\circ}$ where $I, W_{I}^{\circ}$ are as in Lemma 2.3 and $\widetilde{\Omega}_{(\vec{x})}$ is the subgroup of $\widetilde{\Omega}$.
Proof. The condition $w \vec{x}-\vec{x} \in P$ is equivalent to existence of $\lambda \in P$ such that $t_{\lambda} w$ belong the the stabilizer of $\vec{x}$ in $\widetilde{W}^{a e}$. Hence the statement follows from Lemma 2.4 .

The logic here is similar to Hum95, Sec. 2.10]. Note that $\widetilde{\Omega}_{(\vec{x})}$ is not stabilizer of $\vec{x}$ in $\widetilde{\Omega}$ but rather finite part of stabilizer in $\operatorname{Aut}_{\Phi} \ltimes \prod_{j=1}^{l} \widehat{\Omega}_{j}$.

Multiplicative case. Recall now that our parameters $\vec{a}=\left(a_{0}, \ldots, a_{r}\right)$ are multiplicative root variables. For any root $\alpha=\sum_{i=0}^{r} k_{i} \alpha_{i}$ we assign root variable $\prod_{i=0}^{r} a_{i}^{k_{i}}$.

Theorem 2. Let $|q| \neq 1, \vec{a} \in \mathcal{A}$. Then there exist $I \subset \Delta^{a}$ and $g \in W^{a e}$ such that for stabilizer of $\vec{a}^{\prime \prime}=g(\vec{a})$ we have

$$
\begin{equation*}
W_{\vec{a}^{\prime \prime}}^{a e}=\Omega_{[\vec{a}]} \ltimes \prod_{j=1}^{l} W_{j}^{o} \tag{2.8}
\end{equation*}
$$

Here $\Phi_{j}, j=1, \ldots, l$ are finite root systems corresponding to connected components of the subgraph whose vertex set is $I$ in the graph of affine Dynkin diagram $\Phi^{a}, W_{j}^{o}$ is group generated by reflections by roots of $\Phi_{j}$ such that corresponding multiplicative root variables equal to 1. The $\Omega_{[\vec{a}]}$ is a certain subgroup in $\widehat{\Omega}_{I} \ltimes \prod_{j=1}^{l} \Omega_{\Phi_{j}}$, where $\widehat{\Omega}_{I}$ is a subgroup of $\widehat{\Omega}$ preserving $I$.

Through the paper, we assume that $q$ is generic so the condition $|q| \neq 1$ holds. It is easy to see that if Theorem 2 holds fo generic $q$ then it holds for any $q$ which is not a root of unity.

Proof. There is a map from $\mathcal{A} \rightarrow V_{\Phi}$ given by the formula $x_{i}=\left(\operatorname{Re} \log a_{i}\right) /(\operatorname{Re} \log q), i=1, \ldots, r$. This map is equivariant with respect to the action of $W^{a e}$. Indeed, it is easy to check for reflections in $W$ and for translation in $P$.

Now fix $\vec{a} \in \mathcal{A}$, let $\vec{x} \in V_{\Phi}$ denotes its image. Due to equivariance we have inclusion of stabilizers $W_{\vec{a}}^{a e} \subset W_{\vec{x}}^{a e}$. There is $g^{\prime} \in W^{a}$ such that $\vec{x}^{\prime}=g^{\prime}(\vec{x}) \in$ Alc, let $\vec{a}^{\prime}=g^{\prime}(\vec{a})$. As in Lemma 2.3 we introduce $I$ and we have

$$
\begin{equation*}
W_{\vec{x}^{\prime}}^{a e}=\widehat{\Omega}_{\vec{x}^{\prime}} \ltimes W_{I}^{\circ}=\widehat{\Omega}_{\vec{x}^{\prime}} \ltimes \prod_{j=1}^{l} W_{\Phi_{j}} \tag{2.9}
\end{equation*}
$$

Since $I$ cannot coincide with $\Delta^{a}$ the root systems $\Phi_{j}$ are of finite type. Clearly $\widehat{\Omega}_{\vec{x}^{\prime}} \subset \widehat{\Omega}_{I}$.
It follows from definition of $I$ that $\left|a_{i}^{\prime}\right|=1 \mathrm{iff} \alpha_{i} \in I$. Denote $a_{i}^{\prime}=\exp \left(2 \pi \mathrm{i} y_{i}\right)$ for real $y_{i}$. One can consider collection $y_{i}$ as an element of $V_{\sqcup \Phi_{j}}=\oplus_{j=1}^{l} V_{\Phi_{j}}$, note that $\vec{y}$ is defined up to the integer shift $\vec{y} \mapsto \vec{y}+\lambda$ where $\lambda \in \oplus_{j=1}^{l} P_{j}$. Then there is $g^{\prime \prime} \in \prod_{j=1}^{l} W_{\Phi_{j}}$ and $\lambda \in \oplus_{j=1}^{l} Q_{j}$ such that $\vec{y}^{\prime \prime}=g^{\prime \prime}(\vec{y})+\lambda$ belongs to the product of fundamental alcoves $\prod_{j} \operatorname{Alc}_{j}$. If some $w \in W_{\vec{x}^{\prime}}^{a e}$ preserves all $a_{i}^{\prime \prime}$ for $\alpha_{i} \in I$, then $w\left(\vec{y}^{\prime \prime}\right)-\vec{y}^{\prime \prime} \in P_{\sqcup \Phi_{j}}$.

The group $\widehat{\Omega}_{\vec{x}^{\prime}}$ acts on $\sqcup \Phi_{j}$ as a subgroup of $\operatorname{Aut}_{\sqcup \Phi_{j}}$. Hence by Corollary 2.5 , the stabilizer of set of all $a_{i}^{\prime \prime}$ for $\alpha_{i} \in I$ has the form

$$
\begin{equation*}
\left(\widehat{\Omega}_{\vec{x}^{\prime}} \ltimes \prod_{j=1}^{l} \Omega_{\Phi_{j}}\right)_{\left(\vec{y}^{\prime \prime}\right)} \ltimes W^{\circ} \tag{2.10}
\end{equation*}
$$

where $W^{\circ}$ is generated by reflections through hyperplanes containing $\vec{y}^{\prime \prime}$.
Condition that hyperplane contains $\vec{y}^{\prime \prime}$ is equivalent to the condition that corresponding multiplicative root variable is equal to 1 . Hence the defined above group $W^{\circ}$ preserves the whole $\vec{a}^{\prime \prime}$. Therefore we get the formula 2.8, where $\Omega_{[\vec{a}]}$ is stabilizer of $\vec{a}^{\prime \prime}$ in $\left(\widehat{\Omega}_{\vec{x}^{\prime}} \ltimes \prod_{j=1}^{l} \Omega_{\Phi_{j}}\right)_{\left(\vec{y}^{\prime \prime}\right)}$.

Due to Lemma 2.1 subgroup $W^{\circ}$ acts trivially on $\mathcal{X}_{\vec{a}}$. Hence, the folding transformations (and folding subgroups) could come only from the group $\left.\widehat{\Omega} \ltimes \prod \Omega_{\Phi_{j}}\right|^{4}$

### 2.3 Reduction to type A

If one of the systems $\Phi_{j}$ is of $A$-type, say $A_{n}$ then the group $\Omega$ is cyclic group of order $n+1, \Omega_{A_{n}} \simeq C_{n+1}$. The generator of this cyclic group is $\bar{\pi}_{n+1}=s_{n} s_{n-1} \ldots s_{2} s_{1}$, where we used standard consecutive numbering of the simple roots.

It appears that it is sufficient to consider the case that all root systems $\Phi_{j}$ are of type $A$.
Lemma 2.6. For finite irreducible simply laced root system $\Phi$ the group $\Omega_{\Phi} \in W_{\Phi}$ can be conjugated into the subgroup of $\prod_{j=1}^{l^{\prime}} \Omega_{\Phi_{j}^{\prime}}$, where $\Phi_{j}^{\prime}$ are A-type roots systems corresponding to connected components $\Delta_{j}^{\prime}$ in Dynkin diagram $\Delta$.

Proof. We will use the following numbering of roots in root diagrams of $D_{n}, E_{6}, E_{7}$


For $\Phi=E_{8}$ the group $\Omega$ is trivial and there is nothing to prove. For $E_{6}$ and $E_{7}$ we have the formulas

& E_{7}: \Omega=\left\{e, s_{123405645342} s_{031} s_{123405645342}^{-1}\right\} \simeq C_{2} \tag{2.12}
\end{align*}
$$

For the $D$-type recall that Weyl group $W_{D_{n}}$ is isomorphic to the group of linear transformations of the vector space with basis $\epsilon_{1}, \ldots, \epsilon_{n}$ which permutes basis vectors and change signs of even number of them, simple roots are expressed in terms of such basis as $\alpha_{i}=e_{i}-e_{i+1}, i=1 \ldots n-1, \alpha_{n}=e_{n-1}+e_{n}$. Each element of $W_{D_{n}}$ can be decomposed into product of cycles $\left(i_{1}, \ldots, i_{k}\right)$, each of them is either positive or negative. Here cycle of length $k$ is said to be positive if its $k$-th power is identity and negative if its $k$-th power is minus identity. See e.g. Car72, Sec. 7] for details. Two elements $w_{1}, w_{2} \in W_{D_{n}}$ are conjugated if they have the same cyclic type (including signs) except the case of all cycles are even and positive, in this case there are two conjugacy classes, see Car72, Prop 25].

Let $n=2 k+1$. The group $\Omega_{D_{2 k+1}}$ is isomorphic to $C_{4}$ and generated by the element

\epsilon_{1} & \epsilon_{2} & \epsilon_{3} & \ldots & \epsilon_{k+1} & \ldots & \epsilon_{2 k} & \epsilon_{2 k+1}  \tag{2.13}\\
\epsilon_{2 k+1} & -\epsilon_{2 k} & -\epsilon_{2 k-1} & \ldots & -\epsilon_{k+1} & \ldots & -\epsilon_{2} & -\epsilon_{1}
\end{array}\right) .
$$

We have $w=g^{-1} w^{\prime} g$, where

\left.\begin{array}{rl}
w^{\prime} & =\left(\begin{array}{cccccccc}
\epsilon_{1} & \epsilon_{2} & \ldots & \epsilon_{2 k-3} & \epsilon_{2 k-2} & \epsilon_{2 k-1} & \epsilon_{2 k} & \epsilon_{2 k+1} \\
\epsilon_{2} & \epsilon_{1} & \ldots & \epsilon_{2 k-2} & \epsilon_{2 k-3} & -\epsilon_{2 k+1} & -\epsilon_{2 k} & \epsilon_{2 k-1}
\end{array}\right), \\
g & =\left(\begin{array}{cccccccccc}
\epsilon_{1} & \epsilon_{2} & \epsilon_{3} & \ldots & \epsilon_{k} & \epsilon_{k+1} & \epsilon_{k+2} & \ldots & \epsilon_{2 k-1} & \epsilon_{2 k} \\
\epsilon_{2 k-1} & \epsilon_{1} & \epsilon_{3} & \ldots & \epsilon_{2 k-3} & (-1)^{k} \epsilon_{2 k} & -\epsilon_{2 k-2} & \ldots & -\epsilon_{4} & -\epsilon_{2}
\end{array}-\epsilon_{2 k+1},\right. \tag{2.15}
\end{array}\right) .
$$

Note that $w^{\prime}=s_{13 \ldots 2 k-32 k} 2 k-12 k+1 \in \prod \Omega_{\Phi_{j}^{\prime}}$ for the subset $I^{\prime}=\{1,3, \ldots, 2 k-3,2 k-1,2 k, 2 k+1\}$. The corresponding root system is $(k-1) A_{1}+A_{3}$.

Let $n=2 k$. The group $\Omega_{D_{2 k}}$ is isomorphic to $C_{2} \times C_{2}$ and has three nontrivial elements $w_{1}, w_{2}^{+}, w_{2}^{-}$

\epsilon_{1} & \epsilon_{2} & \ldots & \epsilon_{2 k-1} & \epsilon_{2 k}  \tag{2.16}\\

\end{array}\right), \quad w_{2}^{ \pm}=\left(\begin{array}{ccccc}
\epsilon_{1} & \epsilon_{2} & \ldots & \epsilon_{2 k-1} & \epsilon_{2 k} \\
\pm \epsilon_{2 k} & -\epsilon_{2 k-1} & \ldots & -\epsilon_{2} & \pm \epsilon_{1}
\end{array}\right)
$$

Let us define $g, w_{1}^{\prime}, w_{2}^{\prime}$ by the formulas

\epsilon_{1} & \ldots & \epsilon_{2 k-2} & \epsilon_{2 k-1} & \epsilon_{2 k} \\
\epsilon_{1} & \ldots & \epsilon_{2 k-2} & -\epsilon_{2 k-1} & -\epsilon_{2 k}
\end{array}\right), \quad w_{2}^{\prime}=\left(\begin{array}{ccccccc}
\epsilon_{1} & \epsilon_{2} & \ldots & \epsilon_{2 k-3} & \epsilon_{2 k-2} & \epsilon_{2 k-1} & \epsilon_{2 k} \\
\epsilon_{2} & \epsilon_{1} & \ldots & \epsilon_{2 k-2} & \epsilon_{2 k-3} & \epsilon_{2 k} & \epsilon_{2 k-1}
\end{array}\right) \\
 \tag{2.18}\\
g=\left(\begin{array}{ccccccccc}
\epsilon_{1} & \epsilon_{2} & \ldots & \epsilon_{k-1} & \epsilon_{k} & \ldots & \epsilon_{2 k-2} & \epsilon_{2 k-1} & \epsilon_{2 k} \\
\epsilon_{2 k-1} & \epsilon_{2 k-3} & \ldots & \epsilon_{1} & -\epsilon_{2} & \ldots & -\epsilon_{2 k-4} & -\epsilon_{2 k-2} & (-1)^{k} \epsilon_{2 k}
\end{array}\right)
\end{array}
$$

Then we have $w_{1}=g^{-1} w_{1}^{\prime} g$, and $w_{2}^{+}=g^{-1} w_{2}^{\prime} g$ for even $k, w_{2}^{-}=g^{-1} w_{2}^{\prime} g$ for odd $k$. Note that $w_{1}^{\prime}=s_{2 k-12 k}$ and $w_{2}^{\prime}=s_{13 \ldots 2 k-1}$. So $w_{1}^{\prime}, w_{2}^{\prime} \in \prod \Omega_{\Phi_{j}^{\prime}}$ for the subset $I^{\prime}=\{1,3, \ldots, 2 k-3,2 k-1,2 k\}$, the corresponding root system is $(k+1) A_{1}$.

As was shown in previous subsection all folding subgroups come from subgroups of the groups of the form $\widehat{\Omega}_{I} \ltimes \prod_{j=1}^{l} \Omega_{\Phi_{j}}$ corresponding to certain $I \subset \Delta^{a}$. For any $\Phi_{j}$ which is of type $D_{n}, E_{6}, E_{7}$ we can pick $g_{j} \in W_{j}$ as in proof of Lemma 2.6. The following Lemma says that the choice of $g_{j}$ is actually canonical

Lemma 2.7. Let $\Phi$ be of type $D_{n}, E_{6}, E_{7}, g \in W_{\Phi}$ as in proof of Lemma 2.6. Let $\sigma \in$ Aut $_{\Phi}$. Then $\sigma g=g \sigma$.
Proof. For $\Phi=D_{n}, n>4$ the only automorphism of Dynkin is given by $\sigma=\left(\begin{array}{ccccc}\epsilon_{1} & \epsilon_{2} & \ldots & \epsilon_{n-1} & \epsilon_{n} \\ \epsilon_{1} & \epsilon_{2} & \ldots & \epsilon_{n-1} & -\epsilon_{n}\end{array}\right)$, and clearly commutes with $g$. For $E_{7}$ there is no automorphisms of $\Delta$. It remains to check cases $D_{4}$ and $E_{6}$, this is a direct computation.

Due to lemma the element $g=\prod g_{j}$ commutes with the group $\widehat{\Omega}_{I}$. Then using $g$ we conjugate the group $\widehat{\Omega}_{I} \ltimes \prod_{j=1}^{l} \Omega_{\Phi_{j}}$ to $\widehat{\Omega}_{I} \ltimes \prod_{j=1}^{l^{\prime}} \Omega_{\Phi_{j}^{\prime}}$, where subset $I^{\prime} \subset I$ such that all corresponding root systems $\Phi_{j}^{\prime}$ are of $A$ type.

Therefore all folding subgroups come from from subgroups of the groups of the form $\widehat{\Omega} \ltimes \prod_{j^{\prime}=1}^{l^{\prime}} \Omega_{\Phi_{j}^{\prime}}$ where all $\Phi_{j}^{\prime}$ are of $A$ type.

### 2.4 Selection rules

We will see that to find disctinct (true) folding transformations, it is sufficient to consider rather special subsets $I=\sqcup I_{j}$ and special elements of the group $\widehat{\Omega} \ltimes \prod \Omega_{\Phi_{j}}, \Phi_{j}=A_{n_{j}}$. More precisely, corresponding selection rules will follow from the invariant set condition. Note that such selection rules are only necessary. As we mentioned before in order to show that all folding candidates will give us foldings and these foldings are not equivalent we will use geometry in Sections 3, 5.

It is instructive to consider at first two extreme cases.
Case 1. Let $w=\pi \in \widehat{\Omega}$. In this case, we only have to check that the invariant set $\mathcal{A}_{w}$ is at least two dimensional (true folding condition). This condition means that the number of orbits of $\pi$ on the set $\Delta^{a}$ (vertices of the affine Dynkin diagram) should be at least 2. We list folding candidates satisfying this condition in Section 2.5. We list folding candidates with one orbit in Appendix A.

Case 2. Let $w \in \prod_{j=1}^{l} \Omega_{\Phi_{j}}$. Recall that any element of $\Omega_{A_{n}}$ has the form $\bar{\pi}_{n+1}^{k}, 0 \leq k \leq n$, where $\bar{\pi}_{n+1}=s_{n} s_{n-1} \ldots s_{2} s_{1}$.

Lemma 2.8. For $A_{n}$ let $\operatorname{gcd}(k, n+1)=d$ and $m=(n+1) / d-1$. Then $\bar{\pi}_{n+1}^{k}$ is conjugated to $\prod_{j=1}^{d} \bar{\pi}_{m+1}^{(j)}$, where $\bar{\pi}_{m+1}^{(j)}=s_{(j-1)(m+1)+m} \cdots \cdots s_{(j-1)(m+1)+1}$.

In other words, $\bar{\pi}_{m+1}^{(j)}$ is a standard generator of $\Omega_{A_{m}}$, where $A_{m}$ has simple roots $\alpha_{(j-1)(m+1)+i}, i=$ $1 \ldots m$. We can also say, that after removing simple roots $\alpha_{i}$ with $m+1 \mid i$, the Dynkin diagram of $A_{n}$ breaks up into $d$ subdiagrams $A_{m}$.

Proof. Under isomorphism $W\left(A_{n}\right)=S_{n+1}$ both $\bar{\pi}_{n+1}^{k}$ and $\prod_{j=1}^{d} \bar{\pi}_{m+1}^{(j)}$ are products of $d$ cycles of length $m+1$. It remains to note that conjugacy classes in $S_{n+1}$ are labeled by the cyclic types.

It follows from the lemma that it is sufficient to consider elements of the form $w=\prod_{j=1}^{l} \bar{\pi}_{n_{l}+1}^{(j)}$ for standard generators $\bar{\pi}_{n_{l}+1}^{(j)}$ of $\Phi_{j}=A_{n_{j}}$. The choice of $\bar{\pi}_{n_{l}+1}$ depends on the orientation of Dynkin diagram of $\Phi_{j}$, but up to conjugacy, we can pick any orientation.

Below we will visualize the set $I$ as a coloring of affine Dynkin diagram, namely vertices corresponding to $\alpha_{i} \in I$ we color in black and other vertices we color in white. Let us now find condition on the invariant subset $\mathcal{A}_{w}$.

For the root system $A_{n}$ we have in terms of the root variables

$$
\begin{align*}
s_{n} s_{n-1} \ldots & s_{2} s_{1}\left(a_{1}, a_{2}, a_{3}, \ldots, a_{n}\right)=s_{n} s_{n-1} \ldots s_{2}\left(a_{1}^{-1}, a_{1} a_{2}, a_{3}, \ldots, a_{n}\right) \\
& =s_{n} s_{n-1} \ldots s_{3}\left(a_{2},\left(a_{1} a_{2}\right)^{-1}, a_{1} a_{2} a_{3}, a_{4}, \ldots, a_{n}\right)=\cdots=\left(a_{2}, a_{3}, \ldots, a_{n},\left(a_{1} \ldots a_{n}\right)^{-1}\right) \tag{2.19}
\end{align*}
$$

Hence $w$-invariance condition on black vertices $b$ give

$$
\begin{equation*}
b \in \Phi_{j}: a_{b}=\exp \left(2 \pi \mathrm{i} \frac{m_{j}}{n_{j}+1}\right) \tag{2.20}
\end{equation*}
$$

for some $0 \leq m_{j} \leq n_{j}$. Moreover if $\operatorname{gcd}\left(m_{j}, n_{j}+1\right)=d>1$ then the reflections $\frac{n_{j}+1}{d} i, i=1 \ldots d-1$ act trivially and corresponding roots can be excluded from $I$. So we can assume coprimeness of $m_{j}$ and $n_{j}+1$.

Action of $w$ will multiply white vertex $c \in \Delta^{a} \backslash I$ root variable by root variables of adjacent $(\in N(c))$ and black $(\in I)$ vertices. Namely, we have

$$
\begin{equation*}
w\left(a_{c}\right)=a_{c} \prod_{b \in I \cap N(c)} \exp \left(2 \pi \mathrm{i} \frac{i_{b} m_{b}}{n_{b}+1}\right) \tag{2.21}
\end{equation*}
$$

where $n_{b}=n_{j}, m_{b}=m_{j}$ for $\Phi_{j} \ni b$ and $i_{b} \in 1 \ldots n_{b}$ is the number of vertex $b$ in $\Phi_{j}$ in the numbering used in the definition of $\bar{\pi}$. The $w$-invariance condition (on white vertices) reads that product in r.h.s. of above formula equals 1 .

We summarize discussion above as a set of selection rules on the coloring of affine Dynkin diagram:

- Each connected component of $I$ is Dynkin diagram of $A$ type: $I=\sqcup \Delta_{j}$ where $\Delta_{j}$ corresponds to root system $\Phi_{j}=A_{n_{j}}$.
- Number vertices of each $\Delta_{j}$ successively from 1 to $n_{j}$, starting from either end. Then for all $\Delta_{j}$ exist integer number $m_{j}, 0<m_{j} \leq n_{j}, \operatorname{gcd}\left(m_{j}, n_{j}+1\right)=1$, such that for any white vertex $c$

$$
\begin{equation*}
\sum_{b \in I \cap N(c)} \frac{i_{b} m_{j(b)}}{n_{j(b)}+1} \in \mathbb{Z} \tag{2.22}
\end{equation*}
$$

where the sum runs over the set of black vertices adjacent to $c, j(b)$ is number of $A$-component of $b$ i.e. $b \in \Delta_{j(b)}$, and $i_{b}$ is number of $b$ in $\Delta_{j(b)}$.

- There are at least two white vertices: $\left|\Delta^{a} \backslash I\right| \geq 2$.

The last item is necessary to have at least two dimensional $\mathcal{A}_{w}$, namely to have a true folding.
It is sufficient to classify colorings up to the action of the group $\widehat{\Omega}$ because such action corresponds to conjugation of $w$. We give a complete list of colorings that satisfy the above selection rules in Section 2.5 Additionally, in Appendix A we give complete list of colorings with $\left|\Delta^{a} \backslash I\right|=1$.

Group element will be given by $w=\prod_{j=1}^{l} \bar{\pi}^{(j)}$, where $\bar{\pi}^{(j)} \in \Omega_{j}$. The order of $w$ is least common multiple of $n_{j}+1$. The values $m_{j}$ determine connected component $\mathcal{A}_{w}$ of the invariant set $\mathcal{A}^{w}$ by 2.20 . We will see below that for given $w$ there are either one such component or several (usually two) components related by the action of normalizer $N\left(\langle w\rangle, W^{a e}\right)$. So it is sufficient to consider only one component.

Example 2.1. Let us consider case $\Phi^{a}=E_{7}^{(1)}$. In this example we consider four subsets $I \subset \Delta^{a}$, they are given in Fig. 2,

First consider $I=3 A_{1}$, it is given on the upper left diagram of Fig. 2. Here there is no choice for $m_{j}, i_{b}$ namely $m_{j}=1$ and $i_{b}=1$. Summands from 2.22 are denoted on the figure as blue fractions. For all white nodes, we compute sums 2.22 , they are written in green. All of them are integer, so the selection rule is satisfied and we have folding transformation $w=s_{0} s_{1} s_{3}$.

Consider $I=A_{1}+A_{3}$ as on upper right diagram of Fig. 2. We choose here $m_{j}=1$ for both components $A_{3}$ and again write summands near black nodes and sums near black ones. One of the sums is not an integer (it is written in red) so the selection rule fails. It is easy to see that if we set $m_{j}=3$ for $A_{3}$ component then the selection rule also fails.

Consider now $I=2 A_{3}$, the corresponding diagrams are in the bottom of Fig. 2 In the left diagram we choose $m_{j}=1$ for left $A_{3}$ and $m_{j}=3$ in right $A_{3}$ and failed. However, in the right diagram, taking both $m_{j}=1$ we succeed and obtain folding $w=s_{321} s_{765}$. The corresponding irreducible component in $\mathcal{A}_{w}$ is defined by $a_{1}=a_{2}=a_{3}=a_{5}=a_{6}=a_{7}=\mathrm{i}$. Another component could be obtained by taking both $m_{j}=3$, in this case we obtain -i on black vertices. These components are related by normalizer.


Figure 2: Example of different $E_{7}^{(1)}$ colorings

Case 3. Finally, let us consider intermediate case $w=\pi \cdot \prod_{j=1}^{l} \bar{\pi}_{n_{j}+1}^{k_{j}}$, where $\pi \neq e \in \widehat{\Omega}_{I}$. Recall the $\pi$ acts on the set of connected components of $I$, i.e. in the set of $\Delta_{j}$, as permutation.

Let $\pi$ has order $d$. Each $\Delta_{j}$ is either invariant under the action of $\pi$ or belongs to the orbit of the size $d$. Indeed, since possible values of $d$ for $\Phi=E_{n}^{(1)}$ are $2,3,4,5,6$ the only cases to exclude is $d=4$ and orbit of size 2 and $d=6$ and orbits of sizes 2 and 3 . This can possibly happen only for $\Phi^{a}=D_{5}^{(1)}, E_{3}^{(1)}$, but still does not happen.

If component $\Delta_{j}$ is invariant then $\pi$ either acts on it trivially or by $\sigma$ which reversing order. In first case we can apply Lemma 2.8 and (possibly reducing $\Delta_{j}$ ) we can assume that corresponding element of $\Omega_{\Phi_{j}}$ is $\bar{\pi}_{n_{j}+1}$. Otherwise we use
Lemma 2.9. Element $w=\sigma \bar{\pi}_{n+1}^{k} \in C_{2} \ltimes W_{A_{n}}$ can be conjugated by the elements of $W_{A_{n}}$ to $\sigma s_{(n+1) / 2}$ for odd $n$ and $k$ or to $\sigma$ otherwise.

Proof. Using relation $\bar{\pi}_{n+1} \sigma=\sigma \bar{\pi}_{n+1}^{-1}$ we can conjugate $w$ to $\sigma$ for even $k$ and to $\sigma \bar{\pi}_{n+1}$ for odd $k$. Now using $s_{n+1-i} \sigma=\sigma s_{i}$ we conjugate $\sigma \bar{\pi}_{n+1}$ to $\sigma$ or to $\sigma s_{(n+1) / 2}$ depending on parity of $n$.

Hence we can consider that $\pi$ acts trivially on any invariant component $\Delta_{j}$.
Let us pick on component $\Delta_{j}$ for each orbit of $\pi$. We call such component distinguished and denote set of such components by $D$. By $I_{D}=\sqcup_{j \in D} \Delta_{j}$ we denote the set of corresponding nodes.

Lemma 2.10. Element $w$ can be conjugated by element from $W_{\left\llcorner\Phi_{j}\right.}$ to the form

$$
\begin{equation*}
w=\pi \prod_{j \in D} \bar{\pi}_{n_{j}+1}^{(j)} \tag{2.23}
\end{equation*}
$$

Proof. It is sufficient to consider one $\pi$-orbit of length $d$. Denote corresponding components by $\Delta_{0}, \Delta_{1}, \ldots \Delta_{d-1}$, assuming that distinguished component is $\Delta_{0}$ and $\pi(i)=i+1 \bmod d$. Let factor of $w$ corresponding to this orbit be $\pi \cdot \prod_{i}\left(\bar{\pi}^{(i)}\right)^{k_{i}}$. Conjugating $w$ by the elements $\pi^{(i}$ successively for $i=d-1 \ldots 1$, we vanish all $k_{i}$ except probably $i=0$. Now for any $g \in W_{\Phi_{0}}$ we can conjugate $w$ by the product $\prod_{i=0}^{d-1} \pi^{i}(g)$, this is equivalent to conjugation of the $\Delta_{0}$ component of $w$ by $g$. Then, using Lemma [2.8, we reduce to the case $k_{0}=1$.

Let us now find the condition on the invariant subset $\mathcal{A}_{w}$. As in previous case, for the black vertices we have

$$
\begin{equation*}
b \in \Delta_{j}: a_{b}=\exp \left(2 \pi \mathrm{i} \frac{m_{j}}{n_{j}+1}\right) \tag{2.24}
\end{equation*}
$$

with $\operatorname{gcd}\left(m_{j}, n_{j}+1\right)=1$ and numbers $m_{j}$ are $\pi$ invariant $m_{j}=m_{\pi(j)}$. The white vertex root variables transform under $w$ as follows

$$
\begin{equation*}
w\left(a_{\pi(c)}\right)=a_{c} \prod_{b \in I_{D} \cap N(c)} \exp \left(2 \pi \mathrm{i} \frac{i_{b} m_{j(b)}}{n_{j(b)}+1}\right), \tag{2.25}
\end{equation*}
$$

where $i_{b}$ as before is the number of vertex $b$ in component $j(b)$. The $w$-invariance condition (on white vertices) reads that product in r.h.s. of the above formula equals 1.

We summarize the discussion above as a set of selection rules on the coloring of the affine Dynkin diagram with automorphism $\pi \neq e \in \widehat{\Omega}_{\Phi}$. As before $\left\{\Delta_{j}\right\}$ is a set of connected components of $I$, by $n_{j}$ we denote number of vertices in $\Delta_{j}$

- Coloring is invariant with respect to $\pi$.
- Each $\Delta_{j}$ is Dynkin diagram of type $A$.
- If some $\Delta_{j}$ is $\pi$-invariant as a set then $\pi$ acts trivially on it $\left(\forall b \in \Delta_{j}, \pi j=j: \pi b=b\right)$.
- In each $\pi$-orbit choose one distinguished component $\Delta_{j}$. Number vertices of each distinguished component $\Delta_{j}$ successively from 1 to $n_{j}$, starting from either end. Then there is a choice of numbers $m_{j}, 0<m_{j} \leq n_{j}, \operatorname{gcd}\left(m_{j}, n_{j}+1\right)=1$ for each distinguished component, such that for any white vertex c

$$
\begin{equation*}
\sum_{b \in I_{D} \cap N(c)} \frac{i_{b} m_{j(b)}}{n_{j(b)}+1} \in \mathbb{Z} \tag{2.26}
\end{equation*}
$$

where the sum runs over the set of black vertices from distinguished components adjacent to $c, j(b)$ is such that $b \in \Delta_{j(b)}$, and $i_{b}$ is number of $b$ in component $\Delta_{j}(b)$.

- Number of $\pi$-orbits on the set of vertices $\Delta^{a} \backslash I$ is at least 2 .

The last item is necessary to have at least two-dimensional $\mathcal{A}_{w}$, namely to have a true folding. Clearly these selection rules are generalization of selection rules in case 2. The general formula for the folding transformation is

$$
\begin{equation*}
w=\pi \prod_{j \in D} \bar{\pi}^{(j)}, \quad \pi \in \widehat{\Omega}_{\Phi}, \quad \bar{\pi}^{(j)} \in \Omega_{\Phi_{j}=A_{n_{j}}} \tag{2.27}
\end{equation*}
$$

We will list colorings that satisfy selection rules in Section 2.5 . It appears that there are only 2 true folding transformations of case 3 : one for $E_{7}^{(1)}$ and one for $D_{5}^{(1)}$. There exist more case 3 folding transformations, if we drop the true folding selection rule (take one white orbit), they are listed in Appendix A. We have the same comment about $m_{j}$ as for case 2 .

Non-cyclic groups. It remains to classify folding groups $H$ which are not cyclic. As was shown above any such $H$ is a subgroup of group of the form $\widehat{\Omega} \ltimes \prod_{j^{\prime}=1}^{l^{\prime}} \Omega_{\Phi_{j}^{\prime}}$ where all $\Phi_{j}^{\prime}$ are of $A$ type. Any nontrivial element of the $H$ should generate a cyclic folding subgroup, and such elements were classified above up to conjugation. For any such element $w$ we find list of subsets $I \in \Delta^{a}$ such that there exists element $\tilde{w} \in \widehat{\Omega} \ltimes \prod_{j^{\prime}=1}^{l^{\prime}} \Omega_{\Phi_{j}^{\prime}}$ conjugated to $w$. In order to do this we reverse simplification performed in Lemmas $2.8,2.9$ and 2.10 . Note that condition 2.20 should hold for any connected component of $I$, and we can keep the assumption $\operatorname{gcd}\left(m_{j}, n_{j}+1\right)=1$.

Then we check which of such $\tilde{w}$ can be combined into one group. The list of not cyclic folding subgroups is given in Section 2.5. Here we just consider the most nontrivial example.

Example 2.2. We have 6 folding transformations for $E_{7}^{(1)}$. For each of them we list conjugated elements in form $\widehat{\Omega} \ltimes \prod_{j^{\prime}=1}^{l^{\prime}} \Omega_{\Phi_{j}^{\prime}}$. We restrict ourselves to the case that $\left|\Delta^{a} \backslash I\right| \geq 2$, since otherwise we do not have dynamics. Similarly in the last case we assumed that number of $\pi$ orbits on $\Delta^{a} \backslash I$ is at least 2 . By $[i, i+1, \ldots, j]$ we denote connected component with nodes $i, i+1, \ldots, j$.

In the paper we name folding transformations by element of $\widehat{\Omega}$ and components of $I$, like $\pi \ltimes A_{n_{1}}+$ $\ldots+A_{n_{l}}$. In this naming we will drop $e \in \widehat{\Omega}$ and write $\times$ instead of $\ltimes$, when all components of $I$ are $\pi$-invariant.

In the next table, we present non-cyclic folding subgroups. For each group, we write formulas for its generators. In the column "Group" we also note nontrivial embeddings between different non-cyclic folding subgroups.

### 2.6 Invariant lattices and normalizers

Invariant and orthogonal lattices. For given $w \in W^{a e}$ of finite order $n$ introduce two sublattices of $Q^{a}$ :

1. Invariant sublattice $Q^{a, w}=\operatorname{Ker}_{Q^{a}}(w-1)$.
2. Orhtogonal sublattice $Q^{a, \perp w}=\operatorname{Ker}_{Q^{a}} \sum_{i=0}^{n-1} w^{i}$.

Lemma 2.11. Sublattices $Q^{a, w}, Q^{a, \perp w}$ have following properties

1. Lattices $Q^{a, w}$ and $Q^{a, \perp w}$ are orthogonal, union of their bases is a basis in $Q^{a} \otimes_{\mathbb{Z}} \mathbb{Q}$, i.e. $Q^{a, w} \oplus Q^{a, \perp w}$ is a sublattice of full rank in $Q^{a}$.
2. Invariant sublattice of $w=t_{\lambda} \bar{w} \in P \rtimes W$ depends only on finite part $\bar{w} \in W: Q^{a, w}=Q^{a, \bar{w}}$.
3. Imaginary root belongs to invariant sublattice: $\delta \in Q^{a, w}, \delta \notin Q^{a, \perp w}$.

Proof. 1. Let us consider complexification $Q^{a} \otimes_{\mathbb{Z}} \mathbb{C}=\mathbb{C}^{r+1}$. If $w$ has order $n$, eigenvalues of its natural action on this space will be $n$-th roots of unity. Note that the dimension of space of solutions of
the equation $w\left(\sum_{j} c_{j} \alpha_{j}\right)=\sum_{j} c_{j} \alpha_{j}$ is the same for the base fields $\mathbb{Q}$ and $\mathbb{C}$. Hence the eigenspace of $w$ with eigenvalue 1 is complexification $Q^{a, w} \otimes_{\mathbb{Z}} \mathbb{C}$ of $Q^{a, w}$. Similarly, looking to the equation $\left(\sum_{i=0}^{n-1} w^{i}\right) \sum_{j} c_{j} \alpha_{j}=0$ we see that span of eigenspaces with eigenvalues $\neq 1$ is a complexification $Q^{a, \perp, w} \otimes_{\mathbb{Z}} \mathbb{C}$ of $Q^{a, \perp, w}$.
2. Because $w=t_{\lambda} \bar{w}$ has finite order, then $\lambda \in \operatorname{Ker}_{P} \sum_{i=0}^{n-1} w^{i} \subset Q^{a, \perp w} \otimes_{\mathbb{Z}} \mathbb{Q}$. So $\lambda$ is orthogonal to $Q^{a, w}$, which give us the statement.
3. This follows from $W^{a e}(\delta)=\delta$.

These sublattices we will use for the calculation of the normalizer of folding transformations. Below we present some simplifications for calculation of such sublattices:

1. Due to the Lemma 2.6 finitization $\bar{w}$ of folding group elements of case 1 is conjugated to folding group element of case 2. A similar statement holds also for the case 3. Hence, their invariant sublattices $Q^{a, w}$ are related by action of group elements, which are used for above conjugation.
2. For case 2 direct calculation gives $Q^{a, \perp w}=\left\langle\left\{\alpha_{i \in I}\right\}\right\rangle$.
3. For case 1 direct calculation gives $Q^{a, \perp w}=\left\langle\left\{\alpha_{i}-\pi\left(\alpha_{i}\right)\right\}\right\rangle$
4. For case 3 direct calculation gives $Q^{a, \perp w}=\left\langle\left\{\alpha_{i}-\pi\left(\alpha_{i}\right), i \in \Delta^{a} \backslash I\right\}\right\rangle \oplus\left\langle\left\{\alpha_{i \in I}\right\}\right\rangle$.

Normalizer and components. Normalizer of the cyclic group $\langle w\rangle$ is a semidirect product of group $N_{\text {flip }}$, changing its primitive generator and centralizer $C$ :

$$
\begin{equation*}
N\left(\langle w\rangle, W^{a e}\right)=N_{f l i p} \ltimes C\left(w, W^{a e}\right), \tag{2.28}
\end{equation*}
$$

$N_{f l i p} \subset C_{2}$ for $w$ of order $2,3,4,6$ and $C_{4}$ for $w$ of order 5 . We write $\subset$, because we cannot guarantee that all elements of $N_{\text {flip }}$ are realized in $W^{a e}$. Indeed, for $w \in \widehat{\Omega}$ we cannot change primitive generator of outer automorphism group.

Normalizer acts on $A^{w}$ and it appears that centralizer preserves folding irreducible components $\mathcal{A}_{w}$ and $N_{\text {flip }}$ permutes them. Note that for true folding, if $t_{\lambda} \in N$, then it immediately belongs to centralizer $C$.

Proposition 2.1. Assume that $Q^{a, w}$ and $Q^{a, \perp w}$ are generated by root subsystems $\Phi^{a, w}, \Phi^{a, \perp w}$ of $\Phi^{a}$. Then

$$
\begin{equation*}
C\left(w, W^{a e}\right) \subset \operatorname{Aut} \ltimes\left(W_{\Phi^{a, w}}^{a} \times W_{\Phi^{a, \perp w}}\right) \tag{2.29}
\end{equation*}
$$

where Aut $\subset \operatorname{Aut}\left(\Phi^{a, w}\right) \times \operatorname{Aut}\left(\Phi^{a, \perp w}\right)$ denotes subgroup of all automorphisms of both lattices, that is realized in $W^{a e}$.

Proof. Sublattices $Q^{a, w}$ and $Q^{a, \perp w}$ are defined by $w$. Hence centralizer $C\left(w, W^{a e}\right)$ should preserve sublattices $Q^{a, w}$ and $Q^{a, \perp w}$, as well as corresponding root systems $\Phi^{a, w}$ and $\Phi^{a, \perp w}$.

Subgroup Aut of elements that can be realized in $W^{a e}$ is usually much smaller than $\operatorname{Aut}\left(\Phi^{a, w}\right) \times$ $\operatorname{Aut}\left(\Phi^{a, \perp w}\right)$.

By definition of the invariant sublattice $W_{\Phi^{a, w}}^{a}$ commutes with $w$. We can decompose Aut $=$ Aut ${ }^{\|} \ltimes$ Aut ${ }^{\perp}$, where Aut ${ }^{\|}$acts effectively on the $\Phi^{a, w}$, $\operatorname{Aut}^{\perp} \subset \operatorname{Aut}\left(\Phi^{a, \perp w}\right)$. If Aut ${ }^{\|}$commutes with $w$, then

$$
\begin{equation*}
C\left(w, W^{a e}\right)=\mathrm{Aut}^{\|} \ltimes\left(W_{\Phi^{a, w}}^{a} \times\left(\mathrm{Aut}^{\perp} \ltimes W_{\Phi^{a, \perp w}}\right)^{w}\right), \tag{2.30}
\end{equation*}
$$

where we take $w$-centralizer of last multiplier.
Remark 2.4. Sometimes in cases 1 and 3 sublattice $Q^{a, \perp w}$ is not generated by any root system. Namely, this happens for foldings $\pi \ltimes 5 A_{1} \subset E_{7}^{(1)}, \pi \subset E_{6}^{(1)}$ and $\pi \subset D_{5}^{(1)}$. But it appears that in such cases we can find $\widetilde{Q^{a, \perp w}}$ of finite index in $Q^{a, \perp w}$ which corresponds to some root system and invariant under the action of normalizer $N\left(w, W^{a e}\right)$. So the analog of the formula 2.29 holds.

Example 2.3. Let us consider folding $2 A_{3}$ for $\Phi^{a}=E_{7}^{(1)}$ (second folding from Example 2.1) given by formula $w=s_{321} s_{765}$. We have, that $\Phi^{a, \perp w}=2 A_{3}$ generated by $\alpha_{1}, \alpha_{2}, \alpha_{3}$ and $\alpha_{5}, \alpha_{6}, \alpha_{7}$. $Q^{a, w}$ obviously contain $\alpha_{0}$, so together with $\delta$ we have $\Phi^{a, w}=A_{1}^{(1)}$.

We choose generator $s_{1} s_{3} s_{5} s_{7}$ for $N_{f l i p}$, such generator permutes irreducible components $a_{1,2,3,5,6,7}=\mathrm{i}$ and $a_{1,2,3,5,6,7}=-\mathrm{i}$.

Group Aut could be obtained by direct calculations. They give, that Aut ${ }^{\perp}=C_{2}$, generated by $\pi$. Another multiplier Aut ${ }^{\|}=C_{2}$, which generator is defined up to Aut ${ }^{\perp}$, we take $\pi s \pi s^{-1}$, where $s=$ $s_{4354} s_{2132}$. Aut ${ }^{\perp}$ and Aut ${ }^{\|}$commutes. Sublattices and automorphisms are pictured on Fig. $\left.3\right|^{5}$


Figure 3: Root systems $\Phi^{a, w}, \Phi^{a, \perp w}$ and their automorphisms
We can check, that Aut ${ }^{\|}$commutes with $w$, so due to (2.30), we have

$$
\begin{equation*}
C\left(w, W_{E_{7}}^{a e}\right)=\underbrace{C_{2}}_{\pi s \pi s^{-1}} \ltimes(W^{a} \times \underbrace{C_{2}}_{\pi s_{1} s_{3} s_{5} s_{7}} \ltimes \underbrace{C_{4}^{2}}_{\Omega_{A_{3}}^{2}}) \simeq(\underbrace{C_{2}}_{\pi s_{1} s_{3} s_{5} s_{7}} \times W_{A_{1}}^{a e}) \ltimes C_{4}^{2}, \tag{2.31}
\end{equation*}
$$

where we already calculated centralizer $\left(\text { Aut }^{\perp} \ltimes W_{\Phi^{a, \perp w}}\right)^{w}$.
Remark 2.5. Situation, presented in the Proposition 2.1 occurs only for about half cases of our folding classification. In other cases one of $Q^{a, w}, Q^{a, \perp w}$ (or $Q^{a, \perp w}$ ) is generated by long root subsystem with roots of length $|\alpha|^{2}=2 k$ for integer $k>1$. In this case we usually can find elements in $W^{a e}$ which acts as reflections in this long root system. But such an element could act by automorphisms on the other, $|\alpha|^{2}=2$ lattice, so direct product in the formula 2.29 becomes semidirect.

Note that symmetry on the image of folding transformation is smaller then $C\left(w, W^{a e}\right)$, because some of the elements of the centralizer (for example $w$ itself) act trivially on the image. In Sec. 3.3 we find the symmetry group on the image in each case by similar considerations. Also we explain, how to identify elements of centralizer with symmetries, using explicit formulas for coordinates $\mathrm{F}=\mathrm{F}(F, G), \mathrm{G}=\mathrm{G}(F, G)$ found in Sec. 5. Now we only state that very often $W_{Q^{a, \perp w}}^{w}$ acts trivially on the image of the folding transformation.

Projective reduction. As was already mentioned in Remark 2.2 for special values of parameters there could exist group element $t^{1 / n} \in W^{a e}$, such that

$$
\begin{equation*}
\left(t^{1 / n}\right)^{n} \in P, \quad t^{1 / n} a_{i}=a_{i} q^{k_{i} / n}, k_{i} \in \mathbb{Z} \tag{2.32}
\end{equation*}
$$

Example 2.4. We had already example of projective reduction in the Introduction (Example 1.2). The dynamics of the $q$-Painlevé equation acts on root variables as 1.3 ), hence it is a translation $t_{\omega_{2}-\omega_{3}}$, recall that $\omega_{i} \in P$ denotes $i$-th fundamental weight. It is easy to see that

$$
\begin{equation*}
t_{\omega_{2}-\omega_{3}}=\pi^{2} s_{3453} s_{2012}=\left(\pi s_{2012}\right)^{2} \tag{2.33}
\end{equation*}
$$

[^4]Let us denote $t_{\omega_{2}-\omega_{3}}^{1 / 2} \equiv \pi s_{2012}$. This element acts as

$$
\begin{equation*}
t_{\omega_{2}-\omega_{3}}^{1 / 2}\left(a_{0}, a_{1}, a_{2}, a_{3}, a_{4}, a_{5}\right)=\left(a_{5}, a_{4}, a_{2} a_{0123}, a_{3} a_{0123}^{-1}, a_{1}, a_{0}\right) \tag{2.34}
\end{equation*}
$$

For example, if $a_{0}=a_{5}, a_{4}=a_{1}$, this become a projective reduction and $q=a_{0123}^{2}$. In the Example 1.2 we have $a_{0,1,4,5}=-1$ so the projective reduction condition is satisfied. This is dashed dashed dynamics as in 1.6, 1.7).

To obtain a projective reduction for a special value of $\vec{a}$ it is necessary, that some root of $q$ is a Laurent monomial in free root variables.

For the folding invariant subset projective reduction should act as a translation on the invariant lattice root system $\Phi^{a, w}$. This transformation could act on orthogonal lattice $Q^{a, \perp w}$ as a nontrivial element of finite order.

Example 2.5 (Continuation of the Example 2.3. For the folding transformation $2 A_{3} \subset E_{7}^{(1)}$ we have $q=a_{0}^{2} a_{4}^{4}=\left(a_{0} a_{4}^{2}\right)^{2}$, so we can expect for projective reduction as a square root of elementary translation. The elementary translation in invariant lattice is given by $\alpha_{0}=2 \omega_{0}-\omega_{4}$. In terms of symmetry lattice $\Phi^{a, w}$ this is translation by simple root, but one can expect existence of the translation by fundamental weight.

According to the formula 2.31) the elementary translation in $W_{A_{1}}^{a e}$ is $s_{0} s \pi s^{-1} \pi$, where $s=s_{4354} s_{2132}$. And we have relation

$$
\begin{equation*}
t_{\omega_{4}-2 \omega_{0}}=\left(s_{0} s \pi s^{-1} \pi\right)^{2}=\left(t_{\omega_{4}-2 \omega_{0}}^{1 / 2}\right)^{2} \tag{2.35}
\end{equation*}
$$

This square root $s_{0} s \pi s^{-1} \pi$ is not a translation since it acts on orthogonal root system $\Phi^{a, w}$ as a nontrivial automorphism of order to 2 , see Fig. 3). Hence $s_{0} s \pi s^{-1} \pi$ is projective reduction.

Remark 2.6. For any $\Phi^{a}$ and $n>1$ we can consider the following coloring. It is defined by the set $\Delta^{a} \backslash I$ of white nodes which is $\Delta^{a} \backslash I=\left\{i \in \Delta^{a} \mid \mathfrak{m}_{i} \bmod n=0\right\}$ where $\mathfrak{m}_{i}$ are marks in affine Dynkin diagram, see formula 2.5). If we set root variabes corresponding to black nodes to be root of 1 (according to the case 2 condition (2.20) then $q$ becomes the $n$ power of free root variables (possibly with some additional root of unity).

It is interesting, that if all connected components of $I$ is Dynkin diagram of $A$-type then such coloring correspond to folding transformation. Such constriction gives 7 folding transformations: $3 A_{2}, 4 A_{1}, A_{1}+$ $2 A_{3} \subset E_{8}^{(1)}, 4 A_{1}, 3 A_{2} \subset E_{7}^{(1)}, 4 A_{1} \subset E_{6}^{(1)}, 4 A_{1} \subset D_{5}^{(1)}$ (see Section 2.5. It also gives some folding transformations without dynamics (see Appendix A). Let us present the proof of this fact without case-by-case considerations.

The root marks for simply laced Dynkin diagram satisfy relation

$$
\begin{equation*}
\forall j \in \Delta^{a}: \sum_{i \in N(j)} \mathfrak{m}_{i}=2 \mathfrak{m}_{j} \tag{2.36}
\end{equation*}
$$

which follow from orthogonality of $\alpha_{j}$ and $\delta$. Therefore for any white node $c$ we have

$$
\begin{equation*}
\sum_{b \in I \cap N(c)} \frac{\mathfrak{m}_{b}}{n} \in \mathbb{Z} \tag{2.37}
\end{equation*}
$$

Let us number vertices on each connected component $\Delta_{j}$ from 1 to $n_{j}$. We also number corresponding border (white) points by 0 and $n_{j}+1$, if the there is no border (white) point, we consider corresponding mark to be equal zero. Due to relation (2.36) for each connected component $\Delta_{j}$ difference $\mathfrak{m}_{k}-\mathfrak{m}_{k-1}$ $\bmod n$ does not depend on $k$. We have

$$
\begin{equation*}
\left(\mathfrak{m}_{k}-\mathfrak{m}_{k-1}\right)\left(n_{j}+1\right)=0 \quad \bmod n, \quad\left(\mathfrak{m}_{k}-\mathfrak{m}_{k-1}\right) l \neq 0 \quad \bmod n, \quad \text { for } l \leq n_{j} . \tag{2.38}
\end{equation*}
$$

Hence there exist $0<m_{j} \leq n_{j}, \operatorname{gcd}\left(m_{j}, n_{j}+1\right)=1$ such that $\frac{m_{j}}{n_{j}+1}=\frac{\mathfrak{m}_{k}-\mathfrak{m}_{k-1}}{n} \bmod 1$. For such choice of $m_{j}$ and any vertex $k$ in $\Delta_{j}$ we have $\frac{k m_{j}}{n_{j}+1}=\frac{\mathfrak{m}_{k}}{n} \bmod 1$. Hence the selection rule 2.22) is satisfied.

## 3 Geometric realization

### 3.1 Picard lattice

In the previous section, we classified all possible folding transformations and folding subgroups. Now for each folding, we will find to which Painlevé equation it maps. We will also show that folding transformations found are nontrivial and pairwise non-conjugate. In this section, we explain the methods, illustrate them with certain examples and give the table with answers. More details are given in Section 5.

Let us fix Painlevé family $\mathcal{X}$. Recall that any surface $\mathcal{X}_{\vec{a}}$ is blowup of $\mathbb{P}^{1} \times \mathbb{P}^{1}$ in 8 points. We denote by $H_{F}, H_{G}, E_{1}, \ldots, E_{8}$ standard generators of the Picard group of $\mathcal{X}_{\vec{a}}$, here $E_{i}$ is an exceptional divisor corresponding to $i$-th blowup, $H_{F}$ and $H_{G}$ are given by equations $F=$ const and $G=$ const correspondingly, for generic constants.

Let $K$ denotes canonical divisor of $\mathcal{X}_{\vec{a}}$. The anti-canonical divisor can be represented by unique curve $D$, in case of $q$-difference equation this curve is a closed chain of $\mathbb{P}^{1}$-s, namely $(-K)=\delta_{0}+\delta_{1}+\cdots+\delta_{n}$. Each $\delta_{i}$ has self-intersection $\delta_{i}^{2}=-2$ and pairwise intersections are $\delta_{i} \cdot \delta_{j}=1$ if $|i-j|=1$ or $|i-j|=n$ and zero otherwise. Hence $\delta_{i}$ generate lattice of the type $A_{n}^{(1)}$ in the Picard group, this is so called surface lattice $\Phi_{\text {surf }}^{a}$. The orthogonal complement to the surface lattice is called symmetry lattice $\Phi_{\text {sym }}^{a}=\Phi^{a}$. The (affine extended) Weyl group of $\Phi^{a}$ is the symmetry group of the family $\mathcal{X}$ which we used in the previous section. The Sakai's families are labeled by their symmetry/surface types.

Example 3.1. Take any numbers $a_{0}, \ldots, a_{7} \in \mathbb{C}^{*}, a_{0} \neq 1$, let $\mathcal{X}_{\vec{a}}$ be a blowup of $\mathbb{P}^{1} \times \mathbb{P}^{1}$ at 8 points with coordinates as in the Fig. 4


Figure 4: Blowup scheme for $E_{7}^{(1)} / A_{1}^{(1)}$
These points belong to two curves of degree $(1,1)$ on $\mathbb{P}^{1} \times \mathbb{P}^{1}$ given by equations $F G=1$ and $F G=a_{0}$. Therefore the meromorphic form $\frac{d F \wedge d G}{(F G-1)\left(F G-a_{0}\right)}$ has no zeroes on $\mathcal{X}_{\vec{a}}$ and only poles on the preimages of these curves. Hence $(-K)$ consists of two components

$$
\begin{equation*}
\delta_{0}=H_{F G}-E_{1234}, \quad \delta_{1}=H_{F G}-E_{5678} \tag{3.1}
\end{equation*}
$$

which generate surface lattice. Its type is $A_{1}^{(1)}$. We see that if $a_{0}=1$, then $-K$ degenerate, that's why this value is removed. The symmetry lattice is generated by classes

$$
\begin{align*}
& \alpha_{0}=H_{F}-H_{G}, \alpha_{1}=E_{3}-E_{4}, \alpha_{2}=E_{2}-E_{3}, \alpha_{4}=E_{1}-E_{2}  \tag{3.2}\\
& \alpha_{5}=H_{G}-E_{15}, \alpha_{6}=E_{5}-E_{6}, \alpha_{7}=E_{6}-E_{7}, \alpha_{7}=E_{7}-E_{8} \tag{3.3}
\end{align*}
$$

The intersection pairing between these roots is (opposite to) intersection pairing in root lattice $E_{7}^{(1)}$.


Hence we get symmetry/surface type $E_{7}^{(1)} / A_{1}^{(1)}$.
Remark 3.1. Here and below in figures we draw rational curves with self-intersection $(-1)$ in red and rational curves with self-intersection ( -2 ) in blue. Generally we will distinguish curves with different self-intersections by different colors according to the Table 3

The parameters $a_{i}$ used there are multiplicative root variables. They can be defined using period map $\chi: \operatorname{Pic}\left(\mathcal{X}_{\vec{a}}\right) \rightarrow \mathbb{C}^{*}$, see Sak01, Sec. 5] ${ }^{6}$. Then $a_{i}=\chi\left(\alpha_{i}\right)$, where $\alpha_{0}, \ldots, \alpha_{r}$ are simple roots in the symmetry system $\Phi^{a}$.

Usually the classes of roots in $\Phi^{a}$ are not effective, there are no curves representing such classes. But for some special values of root variables some of these classes might become effective. Recall Sak01, Sec. 3] that a smooth rational curve with self-intersection $(-2)$ is called a nodal curve. According to this definition all components $\delta_{0}, \ldots, \delta_{n}$ of $(-K)$ are nodal curves, but we will mostly interest in nodal curves in symmetry lattice $\Phi^{a}$, the set of such curves will be denoted as $\Delta^{\text {nod }}$.

Proposition 3.1 ([Sak01, Prop. 22]). Denote by $W^{\text {nod }}$ the subgroup of $W_{\Phi^{a}}$ generated by the reflections with respect to $\alpha \in \Delta^{\text {nod }}$. Then $\chi(\alpha)=1$ if and only if $\alpha \in W^{\text {nod }} \cdot \Delta^{\text {nod }}$.

Let $\alpha \in Q^{a}$ be a root (i.e. $\alpha^{2}=-2$ ), $\chi(\alpha)$ be a corresponding root variable and $s_{\alpha}: X_{\vec{a}} \rightarrow X_{s_{\alpha}(\vec{a})}$ corresponding reflection. For generic values of parameters we have $\chi\left(s_{\alpha}(\alpha)\right)=\chi(\alpha)^{-1}$. Now assume that $\alpha$ is a nodal curve $\alpha \in \Delta^{\text {nod }}$, hence $\chi(\alpha)=1$ and assume that other root variables are generic. We have $\chi\left(s_{\alpha}(\alpha)\right)=1$, hence $s_{\alpha}(\alpha)=n \alpha$ for $n \in \mathbb{Z}$, hence $s_{\alpha}(\alpha)=\alpha$ since $(-\alpha)$ could not be effective. Moreover, for any $\beta \in Q^{a}$ we have $\beta \cdot \alpha=s_{\alpha}(\beta) \cdot \alpha$ and $\chi\left(s_{\alpha}(\beta)\right)=\chi(\beta)$, hence $s_{\alpha}(\beta)=\beta$. Since $s_{\alpha}$ acts trivially on Picard lattice it should be a trivial transformation of $\mathcal{X}_{\vec{a}}$. Clearly, the same property holds for divisors in $\alpha \in W^{\text {nod }} \cdot \Delta^{\text {nod }}$, in other words for any divisor with $\chi(\alpha)=1$ the corresponding reflection should be trivial transformation of $\mathcal{X}_{\vec{a}}$. This can be considered as a geometric proof of Lemma 2.1.

For any two nodal curves $\alpha, \beta \in \Delta_{\text {nod }}$ we have either $\alpha \cdot \beta=0$ or $\alpha \cdot \beta=1$ since otherwise $(\alpha+\beta)^{2} \geq 0$ and non proportional to $\delta$ and this is forbidden in $Q^{a}$. Therefore elements of $\Delta_{\text {nod }}$ are simple roots for some finite root system which we denote by $\Phi_{\text {nod }}$. We denote by $Q_{\text {nod }}$ the sublattice in $Q^{a}$ generated by $\Phi_{\text {nod }}$ and $\bar{Q}_{\text {nod }}=\left(Q_{\text {nod }} \otimes_{\mathbb{Z}} \mathbb{Q}\right) \cap Q^{a}$. In general the lattices $Q_{\text {nod }}$ and $\bar{Q}_{\text {nod }}$ are different, but $Q_{\text {nod }}$ is a sublattice of finite index in $\bar{Q}_{\text {nod }}$. Usually the lattice $\bar{Q}_{\text {nod }}$ is generated by some root system, we denote this root system by $\bar{\Phi}_{\text {nod }}$.

### 3.2 Quotient

Surface. Let $w \in W^{a e}$ be a true folding transformation. Recall that it means there exists $\vec{a}$ such that $w(\vec{a})=\vec{a}$, but $w$ acts on $X=\mathcal{X}_{\vec{a}}$ nontrivially and there exists translation $t_{\lambda} \in W^{a e}$ which commutes with $w$. Hence $t_{\lambda}$ acts on the quotient $Y^{\prime}=X /\langle w\rangle$, where $\langle w\rangle$ is a group generated by $w$. This action of $t_{\lambda}$ is a new Painlevé dynamics, dynamics after folding transformation. But in general $Y^{\prime}$ is not a rational surface corresponding to the Painlevé equation, one have to first resolve singularities $\widetilde{Y} \rightarrow Y^{\prime}$ and then (possibly) perform additional blowdown $\widetilde{Y} \rightarrow Y$.


Let us discuss these steps in more detail. The singularities of $Y^{\prime}$ are images of points of $p \in X$ which are stabilized by nontrivial subgroups in $\langle w\rangle$, denote generator of this subgroup by $w^{\sharp}$. The order of $w$ can be $2,3,4$ (this follows from classification performed in Section 2), then $w^{\sharp}=w$ or $w^{\sharp}=w^{2}$ if order of

[^5]$w$ is 4. There exist some coordinates in the neighborhood of $p$ such that $w^{\sharp}$ acts as $F \mapsto F \zeta_{m}, G \mapsto G \zeta_{m}^{d}$, where $\zeta_{m}$ is some primitive root of unity of order $m, m$ is the order of $w^{\sharp}$, and $0<d<m$.

The minimal resolution of such singularities can be constructed using toric geometry as in [Ful93, Sec 2.6]. After the resolution, we get an exceptional divisor which is the sequence of $\mathbb{P}^{1}$ with negative selfintersection. In the table below we give the structure of the exceptional divisor and intersection pairing on the components of the exceptional divisor. We restrict to the case $m \leq 4$ needed in the paper. We also give formulas for the coordinates in the neighborhood of the exceptional divisor. The last column stands for the contribution in self-intersection and will be explained below.

It appears that in some cases the resolution $\widetilde{Y}$ is not minimal, i.e. differs from representative of Painlevé family by additional blowup. In such case effective divisor $(-K)$ contains $(-1)$ curves. After blowdown of these curves, we get the surface $Y$ on which new Painlevé dynamics acts.

Example 3.2 (Continuation of Example 3.1). Consider folding transformation $2 A_{3} \subset E_{7}$ from the table in Section 2.5. According to this table the corresponding root variables should satisfy (for one of two irreducible components, see Remark 3.3)

a_{1}=a_{2}=a_{3}=a_{5}=a_{6}=a_{7}=\mathrm{i} \tag{3.4}
\end{equation*}
$$

The action of the $w$ is given by

w=s_{321765}: \quad F \mapsto-\mathrm{i} F, \quad G \mapsto \mathrm{i} G \tag{3.5}
\end{equation*}
$$

where we used realization of the Weyl group given in Section 5.2. The order of $w$ is 4 . There are 4 fixed points in $X$, we list them in the Table 5. The meaning of the last column will be explained later, after identification with standard geometry.

Now we proceed to geometry. It is easy to see that $w$ permutes exceptional divisors $E_{1}, E_{2}, E_{3}, E_{4}$ and also $E_{5}, E_{6}, E_{7}, E_{8}$ hence in the $Y^{\prime}$ they will go to two $(-1)$ curves.

Consider curves $F G=1, F G=a_{0}$ which are components of the $(-K)$. Curves of the form $F G=$ const form a pencil with intersection 2 between each two curves. In the image of this pencil in $\widetilde{Y}$ such intersections
become 0 , since we made resolution at points $(0, \infty)$ and $(\infty, 0)$. Hence, the images of curves $F G=$ const have self-intersection 0 , for generic const. Therefore, the images of curves $F G=1, F G=a_{0}$ have self-intersection -1 due to one additional blowup mentioned above.

It appears that images in $\widetilde{Y}$ of coordinate lines $F=0, F=\infty, G=0, G=\infty$ are also -1 divisors. This (and also previous) self-intersection could be calculated, using standard intersection theory results, which we review below, see formula (3.6).

The first two pictures in Fig. 5 represent $X$ and $\widetilde{Y}$. Here and below we draw fixed point $p \in X$ by black circles.


Figure 5: Geometry for the folding $2 A_{3} \subset E_{7}^{(1)}$
We see that anticanonical divisor on $\tilde{Y}$ consists of 4 components which are $(-4),(-1),(-4),(-1)$ curves. The map $\tilde{Y} \rightarrow Y$ is blow down of these two $(-1)$ curves. The picture for $Y$ is the third picture on Fig. 5 On the surface $Y$ the anticanonical divisor consists of two $(-2)$ curves and has zero self-intersection, this is $A_{1}$ surface type. Hence we have folding transformation from $E_{7}^{(1)} / A_{1}^{(1)} q$-Painlevé equation to itself.

Intersections and Standard geometry. We have constructed above the birational map $\psi: X \rightarrow Y$, such that $\psi(w(p))=\psi(p)$ for any $p \in X$. Now we have to identify $Y$ with $\mathcal{Y}_{\vec{a}}$ which is the member of some Painlevé family $\mathcal{Y}$.

The surface $\mathcal{Y}_{\vec{a}}$ is defined through its blowup structure, namely choice of points $p_{1}, \ldots, p_{8} \in \mathbb{P}^{1} \times \mathbb{P}^{1}$. The configuration of these points could be quite degenerate, including many infinitely near points. We follow [KNY17] in the description of blowup structure on Painlevé family and call the structure from loc. cit. a standard geometry. We recall necessary details in Section 5 .

The choice of standard geometry leads to choice of the basis $\mathcal{E}_{1}, \ldots \mathcal{E}_{8}, \mathcal{H}_{\mathrm{F}}, \mathcal{H}_{\mathrm{G}}$, here $\mathrm{F}, \mathrm{G}$ are some coordinates on $Y$, choice of them is part of the choice of standard geometry. The standard geometry is not unique. In order to have formulas for $\mathrm{F}, \mathrm{G}$ simple it is natural to have $\mathcal{E}_{1}, \ldots \mathcal{E}_{8}, \mathcal{H}_{\mathrm{F}}, \mathcal{H}_{\mathrm{G}}$ as images of some natural divisors in $X$.

Let us recall basic statements of intersection theory which we will use below. Let $\psi^{\prime}: X \rightarrow Y^{\prime}$ denotes the quotient map. This is a finite map of degree $m$, where $m$ is order of $w$. Let $C$ be a curve on $X$ and $D^{\prime}$ be a curve on $Y^{\prime}$ such that we have relation in Picard group $[C]=\left(\psi^{\prime}\right)^{*}\left(\left[D^{\prime}\right]\right) \Rightarrow \psi_{*}^{\prime}([C])=m\left[D^{\prime}\right]$. Due to push-pull formula (see e.g. EH16]) we have relation on self-intersection $\left(D^{\prime}, D^{\prime}\right)=(C, C) / m$. Note that curve $C$ should be $w$-invariant but not necessarily irreducible or reduced.

Let $\widetilde{D}$ denotes the proper transform of $D^{\prime}$ in $\widetilde{Y}$. The self-intersection of $\widetilde{D}$ differs from self-intersection $D^{\prime}$ by contribution of exceptional divisor in $\tilde{Y}$. The last contributions are local and can be computed for example using toric description of resolution of singularities in Ful93, Sec 2.6]. Here we present an answer, in order to do this we need some notations.

Let $x_{i} \in C$ be point which goes to singular point of $Y^{\prime}$. Assume first for simplicity that $x_{i}$ is $w$ invariant and action of $w$ on $C$ has order $m$. Then for certain primitive $m$-th root of unity $\zeta_{m}$ and integer $d_{i}, 0<d_{i}<m$ the $w$ acts in vicinity of the point $p$ with eigenvalue $\zeta_{m}$ in tangent to $C$ direction and $\zeta_{m}^{d_{i}}$ in normal direction. Using these notations the contribution of the point $x_{i}$ is $-d_{i} / m$.

In general $x_{i}$ could be not invariant under the action. By $w_{i}$ denote a power of $w$ which preserves $x_{i}$. As was explained above $w_{i}$ is either $w$ or $w^{2}$. Denote by $m_{i}$ the order of $w_{i}$ on $C$ in vicinity of the point $x_{i}$. The number $m_{i}$ could be smaller than the order of $w_{i}$, we denote $\operatorname{ord}\left(w_{i}\right)=m_{i} m_{i}^{\perp}$. Then for certain primitive $m_{i}$-th root of unity $\zeta_{m_{i}}$ and integer $d_{i}, 0<d_{i}<m_{i}$ the $w$ acts in vicinity of the point $x_{i}$ with eigenvalue $\zeta_{m_{i}}$ in tangent to $C$ direction and $\left(\zeta_{m_{i}}^{d_{i} / m_{i}^{\perp}}\right)$ in normal direction. Using these notations the contribution of the point $x_{i}$ is $-d_{i} / m_{i}$. Putting all this together we get the formula for self-intersection.

$$
\begin{equation*}
\widetilde{D} \cdot \widetilde{D}=\frac{1}{m} C \cdot C-\sum_{x_{i}} \frac{d_{i}}{m_{i}} \tag{3.6}
\end{equation*}
$$

We present these local contributions in the last column of Table 4.
Example 3.3 (Continuation of Examples 3.1, 3.2). Let $C$ be one of the coordinate lines $F=0$, It has self-intersection 0 and goes through two singular points, one of the is $A_{3}$ singularity and another one correponds to $(-4)$ curve. Hence the self-intersection of $\widetilde{D}$ is $(-1)$.

Let $C$ be one of the curves $F G=1$ or $F G=a_{0}$. The corresponding divisors on $X$ are $H_{F G}-E_{1234}$ and $H_{F G}-E_{5678}$, so $C$ has self-intersection (-2). It goes through two singular points, each of them is $A_{3}$ singularity. Hence the self-intersection of $\widetilde{D}$ is $(-1)$.

In Table 6 we list $w$-invariant curves which are drawn in the figure. For each curve, we specify fixed points through which it goes and the corresponding tangent direction. As we computed above the images of these curves are $(-1)$ curves, hence they are drawn red in Fig. 5 .

Now we can identify the standard geometry on $Y$. According to standard geometry components of the anticanonical divisor should be $\mathcal{H}_{\mathrm{FG}}-\mathcal{E}_{1234}$ and $\mathcal{H}_{\mathrm{FG}}-\mathcal{E}_{5678}$. We pick image of $G=0$ to be $\mathcal{E}_{4}$, image
$G=\infty$ to be $\mathcal{E}_{8}$. Other exceptional divisors are reducible, this is because of many nodal curves in the $Y$, in the Fig. 5 we add names of these curves. We also add names of the components of an anticanonical divisor on $\widetilde{Y}$. In the last columns of the Tables 5.6 we write image in terms of the standard geometry on $Y$.

Remark 3.2. In order to describe standard geometry on $Y$ we use certain simple $w$-invariant curves on $X$. The most typical example is the following. Let $C$ be a rational curve with self-intersection by $k$. Assume that $w$ acts on $C$ as $z \mapsto \zeta_{n} z$, where $z$ is some coordinate on $C$. In this case the formula (3.6) can be reproduced by the following elementary calculation.

Let us choose local coordinates $\left(z, v_{0}\right)$ near $0 \in C$ and $\left(z^{-1}, v_{\infty}\right)$ near $\infty \in C$. We can assume that $v_{\infty}=v_{0} z^{-k}$ since $C^{2}=k$. Assume now that $w$ acts on these coordinates as

w: z \mapsto \zeta_{n} z, v_{0} \mapsto \zeta_{n}^{d_{0}} v_{0}, v_{\infty} \mapsto \zeta_{n}^{-d_{\infty}} v_{\infty} \tag{3.7}
\end{equation*}

After the quotient $C$ becomes rational curve with coordinate $z^{n}$. And after the resolution local coordinates near the images of fixed points are $\left(z^{n}, v_{0} z^{-d_{0}}\right)$ and $\left(z^{-n}, v_{\infty} z^{d_{\infty}}\right)$. Since

$$

v_{\infty} z^{d_{\infty}}=v_{0} z^{-d_{0}}\left(z^{n}\right)^{-\frac{k-d_{0}-d_{\infty}}{n}} \tag{3.8}
\end{equation*}
$$

the self intersection of $\widetilde{D}$ is $\frac{k-d_{0}-d_{\infty}}{n}$. This is consistent with formula (3.6).


Let us mention another typical case. Let $C^{\sharp}$ be rational curve with self-intersection $k$ and assume that $w$ acts on $C^{\sharp}$ trivially. Then there is no singular points on $D^{\prime}$, hence $\widetilde{D}=D^{\prime}$. But $\left(\psi^{\prime}\right)^{*}\left(\left[D^{\prime}\right]\right)=n\left[C^{\sharp}\right]=[C]$. Hence $(\widetilde{D})^{2}=C^{2} / n=n k$.

Remark 3.3. One can take another irreducible component, namely instead of (3.4) we can set

\begin{equation*}
a_{1}^{\prime}=a_{2}^{\prime}=a_{3}^{\prime}=a_{5}^{\prime}=a_{6}^{\prime}=a_{7}^{\prime}=-\mathrm{i} \tag{3.9}
\end{equation*}
$$

But looking to the blowup scheme in Fig. 4 we see that surfaces $\mathcal{X}_{\vec{a}}$ and $\mathcal{X}_{\overrightarrow{a^{\prime}}}$ are naturally isomorphic if $a_{0}^{\prime}=a_{0}$ and $a_{4}^{\prime}=a_{4}$. Moreover, this isomorphism intertwines orbits of the group $\langle w\rangle$ generated by $w$. So the geometry of the quotients $\mathcal{X}_{\vec{a}} /\langle w\rangle$ and $\mathcal{X}_{\overrightarrow{a^{\prime}}} /\langle w\rangle$ coincide.

This can be stated more algebraically. Namely there is an element $n_{\text {flip }}=s_{1357}$ which belong to normalizer of $\langle w\rangle$, namely $n_{f l i p} w n_{f l i p}^{-1}=w^{3}$. The isomorphism between $\mathcal{X}_{\vec{a}}$ and $\mathcal{X}_{\overrightarrow{a^{\prime}}}$ is given by $w n_{f l i p} \in$ $W^{a e}$.

And this is always the case, if we have two different irreducible folding components in $\mathcal{A}^{w}$ then there exists element $n_{f l i p}$ in the normalizer of $H$ which permutes these components. See the last column in tables in Sec. 4. So the folding transformation does not depend on an irreducible component in $\mathcal{A}^{w}$.

Coordinates and parameters. The next goal is to write down the map $\psi: X \rightarrow Y$ in coordinates. In other words we want to write down formulas

\begin{equation*}
\mathrm{F}=\mathrm{F}(F, G), \quad \mathrm{G}=\mathrm{G}(F, G) \tag{3.10}
\end{equation*}
$$

This is necessary for the study of explicit relation between solutions of the $q$-Painlevé equations. And also this provides some double check of the geometric answer obtained above.

It is convenient to find first the formulas for the pencils of the curves $F=$ const and $G=$ const. Curves from such pencils should be $w$-invariant and from the geometry, we can compute their degrees and properties which determines the pencils. The structure of the pencil determines formulas for $F, G$ up to Möbius transformation, as automorphisms of $\mathbb{P}^{1} \times \mathbb{P}^{1}$ on the image.

We find multiplicative root variables parameters $a_{i}$ on $Y$ using formulas for coordinates $\mathrm{F}, \mathrm{G}$. They always are products of some powers of the initial multiplicative root variables $a_{i}$.

Example 3.4 (Continuation of Examples 3.1, 3.2, 3.3). Consider first pencils of curves $F=$ const and $G=$ const on $X$. We claim that

\begin{equation*}
\psi_{*}\left(H_{F}\right)=\mathcal{H}_{\mathrm{F}}+5 \mathcal{H}_{\mathrm{G}}-\mathcal{E}_{12345678}, \quad \psi_{*}\left(H_{G}\right)=\mathcal{H}_{\mathrm{F}}+\mathcal{H}_{\mathrm{G}} \tag{3.11}
\end{equation*}
$$

Indeed, it follows from the geometry (see image columns in Tables 5 , 6) that

$$
\begin{align*}
& \psi_{*}\left(H_{F}\right) \cdot \mathcal{E}_{4}=\psi_{*}\left(H_{F}\right) \cdot \mathcal{E}_{8}=1, \quad \psi_{*}\left(H_{F}\right) \cdot\left(\mathcal{H}_{\mathrm{G}}-\mathcal{E}_{1}\right)=\psi_{*}\left(H_{F}\right) \cdot\left(\mathcal{H}_{\mathrm{G}}-\mathcal{E}_{5}\right)=0  \tag{3.12}\\
& \psi_{*}\left(H_{F}\right) \cdot\left(\mathcal{E}_{1}-\mathcal{E}_{2}\right)=\psi_{*}\left(H_{F}\right) \cdot\left(\mathcal{E}_{2}-\mathcal{E}_{3}\right)=\psi_{*}\left(H_{F}\right) \cdot\left(\mathcal{E}_{3}-\mathcal{E}_{4}\right)=0  \tag{3.13}\\
& \psi_{*}\left(H_{F}\right) \cdot\left(\mathcal{E}_{5}-\mathcal{E}_{6}\right)=\psi_{*}\left(H_{F}\right) \cdot\left(\mathcal{E}_{6}-\mathcal{E}_{7}\right)=\psi_{*}\left(H_{F}\right) \cdot\left(\mathcal{E}_{7}-\mathcal{E}_{8}\right)=0  \tag{3.14}\\
& \psi_{*}\left(H_{F}\right) \cdot\left(\mathcal{H}_{\mathrm{F}}+\mathcal{H}_{\mathrm{G}}-\mathcal{E}_{1234}\right)=\psi_{*}\left(H_{F}\right) \cdot\left(\mathcal{H}_{\mathrm{F}}+\mathcal{H}_{\mathrm{G}}-\mathcal{E}_{5678}\right)=2 \tag{3.15}
\end{align*}
$$

From this intersections we get the formula (3.11) for $\psi_{*}\left(H_{F}\right)$. As a double-check note that by push-pull formula the self-intersection of $\psi_{*}^{\prime}\left(H_{F}\right)$ is zero and after blowdown of $\mathcal{E}^{a b}$ (see Fig. 5) the self-intersection of $\psi_{*}\left(H_{F}\right)$ will be 2 , this is consistent with formula (3.11).

Similarly we have

$$
\begin{align*}
& \psi_{*}\left(H_{G}\right) \cdot\left(\mathcal{H}_{\mathrm{G}}-\mathcal{E}_{1}\right)=\psi_{*}\left(H_{G}\right) \cdot\left(\mathcal{H}_{\mathrm{G}}-\mathcal{E}_{5}\right)=1, \quad \psi_{*}\left(H_{G}\right) \cdot \mathcal{E}_{4}=\psi_{*}\left(H_{G}\right) \cdot \mathcal{E}_{8}=0  \tag{3.16}\\
& \psi_{*}\left(H_{G}\right) \cdot\left(\mathcal{E}_{1}-\mathcal{E}_{2}\right)=\psi_{*}\left(H_{G}\right) \cdot\left(\mathcal{E}_{2}-\mathcal{E}_{3}\right)=\psi_{*}\left(H_{G}\right) \cdot\left(\mathcal{E}_{3}-\mathcal{E}_{4}\right)=0  \tag{3.17}\\
& \psi_{*}\left(H_{G}\right) \cdot\left(\mathcal{E}_{5}-\mathcal{E}_{6}\right)=\psi_{*}\left(H_{G}\right) \cdot\left(\mathcal{E}_{6}-\mathcal{E}_{7}\right)=\psi_{*}\left(H_{G}\right) \cdot\left(\mathcal{E}_{7}-\mathcal{E}_{8}\right)=0  \tag{3.18}\\
& \psi_{*}\left(H_{G}\right) \cdot\left(\mathcal{H}_{\mathrm{F}}+\mathcal{H}_{\mathrm{G}}-\mathcal{E}_{1234}\right)=\psi_{*}\left(H_{G}\right) \cdot\left(\mathcal{H}_{\mathrm{F}}+\mathcal{H}_{\mathrm{G}}-\mathcal{E}_{5678}\right)=2 \tag{3.19}
\end{align*}

This leads to the formula (3.11) for $\psi_{*}\left(H_{G}\right)$. As a double-check, we can compute that self-intersection of $\psi_{*}\left(H_{G}\right)$ is 2, this is consistent with formula 3.11.

Now return to the curves given by $\mathrm{F}=\mathrm{const}$ and $\mathrm{G}=\mathrm{const}$ in $X$. From the formula (3.11) we know intersections of $\psi_{*}\left(H_{F}\right), \psi_{*}\left(H_{G}\right)$ with $\mathcal{H}_{\mathrm{F}}$ and $\mathcal{H}_{\mathrm{G}}$. Using this we conclude that $\mathrm{F}=$ const should be $(1,5)$ curve and $\mathrm{G}=$ const should be $(1,1)$ curve. We claim that

$$
\begin{equation*}
\psi^{*}\left(\mathcal{H}_{\mathrm{F}}\right)=H_{F}+5 H_{G}-E_{12345678}, \quad \psi^{*}\left(\mathcal{H}_{\mathrm{G}}\right)=H_{F}+H_{G} \tag{3.20}
\end{equation*}
$$

Indeed, on the surface $Y$ curves $G=$ const intersect each component of $-K_{Y}$ in one point. Therefore curves $\mathrm{G}=\mathrm{const}$ on $X$ intersect hyperbolas $F G=1$ and $F G=a_{0}$ in two points $(0, \infty)$ and $(\infty, 0)$, hence do not contain exceptional divisors, so we get formula 3.20 for $\psi^{*}\left(\mathcal{H}_{\mathrm{G}}\right)$. Similarly, the curves $\mathrm{F}=$ const on $X$ intersect hyperbolas $F G=1$ and $F G=a_{0}$ in two points $(0, \infty)$ and $(\infty, 0)$, but since they are $(1,5)$ curves they should contain exceptional divisors. Due to $w$-invariance the only choice is given by the formula (3.20).

The formulas (3.20) can be also deduced (or checked) computing self-intersection. Namely, note that the curves $\mathrm{F}=$ const and $\mathrm{G}=$ const on $X$ goes through two singular points with $d_{i}=1$ and in the image have self-intersection 0 . Therefore on $X$ such curves have self-intersection 2 (using (3.6). This and $w$-invariance give formulas (3.20).

Now we can write formula for the pencils $F=$ const and $G=$ const. The first one consist of $(1,1)$ curves which are $w$-invariant and go through $(0, \infty)$ and $(\infty, 0)$. This determines the 1-parameter family

c_{1} F G-c_{2}=0 \tag{3.21}
\end{equation*}
$$

where $c_{1}, c_{2}$ are complex constants. The second pencil consist of $(1,5)$ curves which go through $(0, \infty)$ and $(\infty, 0)$ and intersect all exceptional divisors $E_{1}, \ldots, E_{8}$. This determines the 1-parameter family

$$
\begin{equation*}
c_{1}\left(F G-a_{0}\right)\left(G^{4}-1\right)-c_{2}(F G-1)\left(G^{4}-a_{4}^{-4}\right)=0, \tag{3.22}
\end{equation*}
$$

where $c_{1}, c_{2}$ are complex constants (recall that root variables are subject of (3.4)).
The final formulas for $F$ and $G$ are ratios of two equations from the families above. They are determined by the properties that curves $F G-1, F G-a_{0}, G=\infty$ go to $(\infty, 0),(0, \infty)$ and $(1,1)$ correspondingly. We get formulas (3.23).

It remain to find root variables on the image. Since on the image we have effective divisors $\mathcal{E}_{1}-\mathcal{E}_{2}$, $\mathcal{E}_{2}-\mathcal{E}_{3}, \mathcal{E}_{3}-\mathcal{E}_{4}$ the blowup points $p_{1}, p_{2}, p_{3}, p_{4}$ on the image are infinitely near points. Hence $\mathrm{a}_{1}=\mathrm{a}_{2}=$
$\mathrm{a}_{3}=1$. Similarly $\mathrm{a}_{5}=\mathrm{a}_{6}=\mathrm{a}_{7}=1$. Since curve $G=0$ goes to $\mathcal{E}_{8}$ we see from formulas (3.23) that $p_{8}=\left(a_{0} a_{4}^{4}, a_{0}^{-1}\right)$. Hence $\mathrm{a}_{0}=a_{4}^{4}$ and $\mathrm{a}_{4}=a_{0}$. We put these root variables in the diagram below.


$$
\begin{align*}
\mathrm{F} & =\frac{F G-a_{0}}{F G-1} \frac{G^{4}-1}{G^{4}-a_{4}^{-4}},  \tag{3.23}\\
\mathrm{G} & =\frac{F G-1}{F G-a_{0}}
\end{align*}
$$

Finally, after defining geometry on the image for all foldings transformations, we should check, that foldings with the same order and the same symmetry/surface type both in the image and in the preimage are not equivalent. Such groups of foldings appear iff their finitizations $\bar{w}$ are conjugated (see Remark 3.6). It appears that these groups have also the same nodal root subsystem $\Phi_{\text {nod }}$. But $\bar{\Phi}_{\text {nod }}$ appear to be different for them, so we take $\bar{\Phi}_{\text {nod }}$ as distinguishing invariant.

### 3.3 Nodal curves and symmetries on image

Symmetries on the image from nodal root systems. Let us define special symmetry lattice - root sublattice in root lattice $\Phi^{a}$, orthogonal to the nodal curves $\Delta_{\text {nod }}: Q^{\text {sym }}=\left(\alpha \in Q^{a} \mid\left(\alpha, \Delta_{\text {nod }}\right)=0\right)$.

Assume that $Q^{\text {sym }}$ is generated by certain (affine) root subsystem $\Phi^{\text {sym }}$. Then we can calculate symmetries of our special subfamily $Y_{\vec{a}}$ analogously to Prop. 2.1. Indeed, our special configuration is defined by $\Delta_{\text {nod }}$, so we should take only those elements from $W^{a e}$ in the image $Y$, that preserve $\Delta_{\text {nod }}$, as well as its orthogonal special symmetry lattice $\Phi^{\text {sym }}$. So we have

$$
\begin{equation*}
\operatorname{Sym}\left(Y_{\vec{a}}\right)=\mathrm{Aut} \ltimes W_{\Phi^{\mathrm{sym}}}=\left(\mathrm{Aut}^{\mathrm{sym}} \ltimes W_{\Phi^{\mathrm{sym}}}\right) \ltimes \mathrm{Aut}^{\mathrm{nod}} \tag{3.24}
\end{equation*}
$$

where Aut $=A u t^{\text {sym }} \ltimes A u t^{\text {nod }}$ for automorphism subgroups Aut ${ }^{\text {nod }} \subset \operatorname{Aut}\left(\Delta_{\text {nod }}\right)$ and Aut ${ }^{\text {sym }} \subset \operatorname{Aut}\left(\Phi^{\perp, \text { nod }}\right) \times$ Aut $\left(\Delta_{\text {nod }}\right)$, the latter acts effectively on $\Phi^{\text {sym }}$. Note that automorphisms Aut $\left(\Delta_{\text {nod }}\right)$ is only permutations. As in the algebraic case, this is subgroups, that are realized in symmetry group $W^{a e}$ of subfamily $Y_{\vec{a}}$.

Remark 3.4. There are some peculiarities about sublattice $Q^{\text {sym }}$. Namely, for $E_{3}^{(1)}$ and $E_{1}^{(1)}$ cases there sublattices could be realized only by long root system $\left.\Phi^{\perp, \text { nod }}\right|_{|\alpha|^{2}=2 n}$, where $n$ is the order of folding. Then we should find reflections by hands and they could act on $\Delta_{\text {nod }}$. Even more problems we occur for folding transformations $\pi^{3}$ and $\pi^{2}$ for $E_{3}^{(1)}$. In this case elementary long root system simple reflections cannot be realized in $W^{a e}$, that's why it is convenient to take instead of $Q^{\text {sym }}$ its sublattice with imaginary root $2 \delta$ and $3 \delta$ respectively. Cf. Remark 2.4 from the preimage side.

Remark 3.5. In the special configuration $\vec{a}$ in the image we can also have projective reduction and it could be found in the same way, as in the preimage. I.e., q should be some full power of root variables a and projective reduction should be translation in the special symmetry root subsystem $\Phi^{\text {sym }}$ and non-trivial permutation of $\Delta^{\text {nod }}$.

Example 3.5 (Continuation of Examples 3.1-3.4). On the Fig. 5 we see 6 nodal curves, which form two $A_{3}$ root systems, consisting from $\alpha_{3}=\mathcal{E}_{1}-\mathcal{E}_{2}, \alpha_{2}=\mathcal{E}_{2}-\mathcal{E}_{3}, \alpha_{1}=\mathcal{E}_{3}-\mathcal{E}_{4}$ and $\alpha_{5}=\mathcal{E}_{5}-\mathcal{E}_{6}, \alpha_{6}=\mathcal{E}_{6}-\mathcal{E}_{7}, \alpha_{7}=$ $\mathcal{E}_{7}-\mathcal{E}_{8}$. Root variables $\mathrm{a}_{0}$ and $\mathrm{a}_{4}$ are free, so, according to Prop. 3.1 there are no other irreducible nodal curves. Extended nodal root subsystem equals to the nodal root subsystem $\bar{\Phi}_{\text {nod }}=\Phi_{\text {nod }}=2 A_{3}$.

It is easy to see that $\Phi^{\text {sym }}=A_{1}^{(1)}$, generated by $\alpha_{0}$ and $\delta$. Special symmetry and nodal root subsystems as well as its automorphisms are represented by left and right pictures on Fig. 6. Calculation gives, that Aut ${ }^{\text {nod }}$, Aut ${ }^{\text {sym }}$ are commuting $C_{2}$, generated by $\pi$ and $\pi s \pi s^{-1}$ for $s=s_{4354} s_{2132}$ respectively ${ }^{7}$. So symmetry on the image will be $C_{2} \times W_{A_{1}}^{a e}$, this is written at the right side of Fig. 6.

We have $\mathrm{q}=2.5_{0}^{2} 2.5_{4}^{4}=\left(2.5_{0} 2.5_{4}^{2}\right)^{2}$ and the elementary translation in special symmetry lattice is given by $\alpha_{0}=2 \omega_{0}-\omega_{4}$ so one can expect existence of the translation by fundamental weight. We have projective reduction $t_{2 \omega_{0}-\omega_{4}}^{1 / 2}$ :

which non-trivially permute nodal curves. We see that it corresponds to the projective reduction $t_{\omega_{4}-2 \omega_{0}}^{1 / 2}$ in the preimage due to $\mathrm{a}_{0}=a_{4}^{4}, \mathrm{a}_{4}=a_{0}$ and $\mathrm{q}=q^{2}$. We will talk systematically about correspondence in the image and preimage in the coming paragraph. Such correspondence is also written on the right side of Fig. 6.

Note that configuration of root variables in the preimage and in the image are similar: $a_{1,2,3,5,6,7}=\mathrm{i}$ vs. $a_{1,2,3,5,6,7}=1$, that is why Fig. 3 and 6 coincide (cf. Remark 3.7).

Relation to centralizer in the preimage. Finally, let us connect symmetries $\operatorname{Sym}\left(Y_{\overrightarrow{\mathrm{a}}}\right)$ in the image and centralizer $C\left(w, W^{a e}\right)$ in the preimage for folding transformation $w$ of order $n$. We have map $\psi_{*}=$ $C\left(w, W^{a e}\right) \mapsto \operatorname{Sym}\left(Y_{\vec{a}}\right)$, which is not injective, because at least folding sungroup $\langle w\rangle$ becomes trivial. It appears, that in several cases it is even not surjective, see below. Connection between centralizer and symmetry in the image is done by such steps:

1. Let $\alpha \in \Phi^{\text {sym }}$ be a root. Then we have $\left|\psi_{*}^{-1}(\alpha)\right|^{2}=n|\alpha|^{2}$, due to push-pull formula. So we take in the preimage "long" root subsystem $\Phi_{\text {long }}^{a, w} \subset Q^{a, w}$ with $|\alpha|^{2}=2 n$ (or $|\alpha|^{2}=2 l n$, where $2 l$ is a length of special symmetry root subsystem in the image) instead of $\Phi^{a, w}$. Type of this long root subsystem should coincide with special symmetry root subsystem in the image. We choose simple roots of this long root subsystem in a way that root variables of $\Phi_{\text {long }}^{a, w}$ equal to the corresponding root variables of $\Phi^{\text {sym }}$ in the image 8 .
2. Then we isomorphically rewrite $C(w, W)$ in the form of 2.30, but for long $\Phi_{l o n g}^{a, w}$. A common situation is that reflections in short invariant root subsystem become outer automorphisms of long invariant root subsystem and vice versa. Groups of automorphisms Aut ${ }^{\|}$and Aut ${ }^{\text {sym }}$ also should become the same.
3. Check, what elements of $\left(\mathrm{Aut}^{\perp} \ltimes W_{\Phi^{a, \perp w}}\right)^{w}$ act non-trivially on the image (their image belongs to Aut $\left.{ }^{\text {nod }}\right)$. That could be done using explicit coordinates $(\mathrm{F}(F, G), \mathrm{G}(F, G))$.
4. If there are additional symmetries $\operatorname{Sym}\left(Y_{\overrightarrow{\mathrm{a}}}\right)$, which do not come from $C(w, W)$, then they act trivially on initial coordinates and root variables. From the point of view of coordinates, this means that formulas for $\mathrm{F}(F, G), \mathrm{G}(F, G)$ contain fractional powers of root variables (or(and) roots of unity) and such symmetries occur from their branching (or Galois group). Such symmetries belong to Aut ${ }^{\text {nod }}$, so they permute nodal curves and corresponding fixed points in the preimage.
5. Finally, we can check the correspondence $\psi_{*}$ explicitly. Namely, for $w \in$ Aut ${ }^{\|} \ltimes W_{\Phi^{a, w}}^{a}$ and $\mathbf{w}=$ $\psi_{*}(w) \in \mathrm{Aut}^{\text {sym }} \ltimes W_{\Phi \perp \text {, nod }}$ we should have

$$
\begin{equation*}
\mathrm{w}(\overrightarrow{\mathrm{a}})(\vec{a})=\overrightarrow{\mathrm{a}}(w(\vec{a})), \quad \mathrm{w}(\mathrm{~F}, \mathrm{G})(\vec{a}, F, G)=(\mathrm{F}, \mathrm{G})(w(\vec{a}), w(F), w(G)) \tag{3.26}
\end{equation*}
$$

Automorphism group Aut ${ }^{\text {sym }}$ is defined up to Aut ${ }^{\text {nod }}$, the latter formula fix this freedom. We also should relate nontrivial (Aut $\left.{ }^{\perp} \ltimes W_{\Phi^{a, \perp w}}\right)^{w}$ to the subgroup of Aut ${ }^{\text {nod }}$ in similar manner.
In fact this is non-trivial double-check both for calculation of $C(w, W)$ and $\operatorname{Sym}\left(Y_{2.5}\right)$.


Figure 7: Relation between symmetries in image and preimage

Example 3.6 (Continuation of Examples 3.1-3.5. Here we compare symmetry from Fig. 6 with centralizer 2.31:

1. We should take root subsystem in $Q^{a, w}$ with roots $|\alpha|^{2}=8$, so $Q_{\text {long }}^{a, w} \subset 2 \alpha_{0}, \delta$. To match root variables $\mathrm{a}_{0}=a_{4}^{4}$ and $\chi\left(\delta-\alpha_{0}\right)=a_{04}^{4}$ in the image, we should take simple roots $\delta-2 \alpha_{0}, \delta+2 \alpha_{0}$, see Fig. 7. Note that imaginary root become $2 \delta$ instead of $\delta$.
2. $W_{\Phi^{a, w}}^{a e} \simeq W_{\Phi_{\text {long }}^{a, w}}^{a e}, s_{0}$ becomes outer automorphism, $\pi s \pi s^{-1}$ becomes reflection.
3. $\Omega_{A_{3}}^{2}$ act trivially on the image, $\pi s_{1} s_{3} s_{5} s_{7}$ - non-trivially.
4. We have no such additional symmetries.
5. Changing root variables symmetry generators in image and preimage correspond to each other by superimposition of left and right pictures of Fig. 7:

$$
\begin{equation*}
\psi_{*}\left(\pi s \pi s^{-1}\right)=s_{0}, \quad \psi_{*}\left(s_{0}\right)=\pi s \pi s^{-1} \tag{3.27}
\end{equation*}
$$

Also we have $\psi_{*}\left(\pi s_{1} s_{3} s_{5} s_{7}\right)=\pi$.
Generator $\pi$ is folding in the image and provide further extension of folding group $C_{4}$ to $C_{2} \ltimes C_{4}=\operatorname{Dih}{ }_{4}^{(2)}$

Remark 3.6. It is remarkable, that folding transformations with conjugated finitizations $\bar{w}$ always go to the same symmetry/surface type. We spotted that from answers above case by case, however, we have no explanation of this phenomenon.

Remark 3.7. We have a lots of pairs foldings transformations $w_{1}, w_{2}$ going in "opposite direction":

Here $\mathcal{A}_{w_{1,2}}\left(\zeta_{n}\right)$ denotes irreducible component of the folding invariant subset. In particular $\mathcal{A}_{w_{1,2}}(1)$ is component on which corresponding folding acts trivially.

In particular in folding transformation in Example 3.5 is opposite to itself.

## 4 Folding transformation: lattices, normalizers and components

$4.1 \quad E_{8}^{(1)} / A_{0}^{(1)}$

For $E_{8}^{(1)}$ we have only case 2 foldings: of order 3 , of order 4 , and (conjugated to) its square of order 2. We start from folding of order 3 on which we explain our notations.

- In the second column for roots of length $|\alpha|^{2}=6$, under the decomposition of given root in terms of simple ones we write corresponding element from $W^{a e}$, which realizes reflection in such root. At the bottom of this column, we write projective reduction occurs and corresponding translation in Weyl group of $\left.\Phi^{a, w}\right|_{|\alpha|^{2}=6}$.
- In the fourth column we write two centralizers with respect to short and long (l) $\Phi^{a, w}$, write image of centralizer after folding matching elements, which go to trivial in the image. We also write the
image of projective reduction after folding. Note that the image of the centralizer is found from the coordinates, found in Section 5 .

Affine Weyl group $W\left(E_{7}^{(1)}\right)$ (and corresponding Dynkin diagram) has outer automorphism of order $2^{9}$ For $E_{7}^{(1)}$ we have 6 foldings:

- Two foldings of order 2 , of case 1 and 2 , which have common (up to conjugation) $\bar{w}$.
- Two foldings of order 4 , of case 2 and 3 , which have common (up to conjugation) $\bar{w}$.
- Folding of order 2 , of case 2 , which is (up to conjugation) square of both foldings of order 4 .
- Folding of order 3 , of case 2 .

Several new notations and peculiarities appear here in comparison with $E_{8}^{(1)}$ case.

- Here appear foldings which have conjugated finitization $\bar{w}$. This is reflected in the first column, where we wrote decomposition of $w$ into translational and finite parts and write conjugation of $\bar{w}$ explicitly. Due to Lemma 2.11 invariant lattices $Q^{a, w}$ are of the same type.
- We denote by $w_{0}\left(S_{n}\right)$ longest element of Weyl group $S_{n}$
- In the $\mathcal{A}_{w}$ arrow with "=" means, that corresponding root variables equal (we write one "=" for several arrows for simplicity)
- In case $3 A_{2}$ we have no short invariant lattice, we immediately obtain long lattice. For the next cases, one finds more such examples.
- In case $\pi \ltimes 5 A_{1}$ we have $Q^{a, \perp w}$ generated by $\alpha_{0}, \alpha_{1}, \alpha_{3}, \alpha_{5}, \alpha_{7}$ and $\alpha_{2}-\alpha_{6}$. This sublattice is not generated by any root subsystem, this is inconvenient, so instead we take its sublattice of index 2 , taking doubled generator $2\left(\alpha_{2}-\alpha_{6}\right)$. Such sublattice already have root subsystem description, we denote it $\widetilde{Q^{a, \perp w}}$.

Affine Weyl group $W\left(E_{6}^{(1)}\right)$ (and corresponding Dynkin diagram) has outer automorphism of order 3. Diagram has also outer automorphism of order 2 (vertical reflection), which is absent in $W\left(E_{6}^{(1)}\right)$.

For $E_{6}^{(1)}$ we have 3 foldings:

- Two foldings of order 3 , of case 1 and 2 , which have common (up to conjugation) $\bar{w}$.
- Folding of order 2 , of case 2 .

For folding $\pi$ we have two peculiarities:

- First, to obtain root subsystem realization, we take index 3 sublattice $\widetilde{Q^{a, \perp w}}$ of $Q^{a, \perp w}$ defined as follows. $Q^{a, \perp w}$ are defined as ( $\alpha=x_{0} \alpha_{0}+x_{1} \alpha_{1}+x_{5} \alpha_{5}+y_{2} \alpha_{2}+y_{4} \alpha_{4}+y_{6} \alpha_{6} \in Q \mid \sum x_{i}=0, \sum y_{i}=0$ ). Then $\widetilde{Q^{a, \perp w}}$ are defined as $\left(\alpha \in Q^{a, \perp w} \mid x_{1}+x_{2}-x_{4}-x_{5}=0 \bmod 3\right)$.
- After we find convenient sublattice $\widetilde{Q^{a, \perp w}}=2 A_{2}$, we discover, that its simple reflections cannot be realized inside $W^{a e}$, from $W_{A_{2}^{2}}$ we can realize only $\Omega_{A_{2}}^{2}$. This realization is written at the table.

- Three foldings of order 4 , of case 1,2 and 3 , which have common (up to conjugation) $\bar{w}$.
- Two foldings of order 2 , of case 1 , which is square of case 1 folding of order 4 , and of case 2 , which is (up to conjugation) square of both other foldings of order 4. $\bar{w}$.
- Another folding of order 2 , of case 2 .

For folding $\pi$ of order 4 we have the same problems, as for case 1 folding in $E_{6}^{(1)}$. Namely, $Q^{a, \perp w}$ is generated by $\alpha_{0}-\alpha_{4}, \alpha_{5}-\alpha_{0}, \alpha_{1}-\alpha_{5}$ and $\alpha_{2}-\alpha_{3}$. We take index 2 sublattice $\widetilde{Q^{a, \perp w}}$, doubling latter generator. Namely, if we denote by $\alpha_{1}$ and $\alpha_{2}$ simple roots for this 2 summands, then first $\alpha_{2}^{2}=-8$ and second $\left(\alpha_{1}-\alpha_{2}\right) / 2 \in Q^{a}$. Due to this reason

symmetry group is smaller, it is generated by $\pi$ and $s_{1}$, where $\pi$ acts on first summand as automotphism and on second summand as translation. See Fig. 14 . Geometrically, this is corresponds to the fact that the surface $\mathcal{X}$ for $E_{2}^{(1)} / A_{6}^{(1)}$ depends on square roots of root variables, namely on $b=\left(a_{1} / a_{2}\right)^{1 / 2}$. See section 5.6 below.

The only possibility for the folding transformation is simple reflection, say $s_{1}$ with $a_{1}=-1$. But since $s_{1}(b)=b a_{1}^{-1}$ this is not the case. Therefore we have no folding transformations in this case.

There is also $q$-Painlevé (gauge) symmetry $\sigma$ of order $2{ }^{10}$ These extensions act trivially on root variables, but nontriviallly on coordinates, see Subsection 5.7

## 6 Further questions

### 6.1 Continuous limit

It is interesting to study the continuous limits of the folding transformations obtained here. These limits should be compared with the classification of differential Painlevé equation foldings [TOS05]. This is not straightforward since there are various limits from $q$-Painlevé equations to differential Painlevé ones (especially when parameters of $q$-equations are special).

For example, let us consider folding transformation discussed in Example 1.2. This is folding from $D_{5}^{(1)} / A_{3}^{(1)}$ to $A_{1}^{(1)} / A_{7}^{(1)^{\prime}}$, which have standard degenerations to $D_{4}^{(1)} / D_{4}^{(1)}$ and $A_{0}^{(1)} / D_{8}^{(1)}$ correspondingly. Thus, naively one could expect that continuous limit corresponds to the folding between Painlevé VI and Painlevé $\operatorname{III}\left(D_{8}^{(1)}\right)$ equations. But, according to TOS05] (see Fig. 1 in loc. cit.) there is no such folding.

In the Introduction we obtained, that for the invariant set $a_{0}=a_{1}=a_{4}=a_{5}=-1$ of given folding $w=s_{0} s_{1} s_{4} s_{5}$ standard Painlevé $D_{5}^{(1)} / A_{3}^{(1)}$ dynamics could be rewritten as "half-shift" equation on single function $F(\boxed{1.7})$ :

F(q z) F\left(q^{-1} z\right)=-\frac{F(z)^{2}-z}{F(z)^{2}-1} \tag{6.1}
\end{equation*}
$$

where we denoted $z=a_{2}^{2}$. From the other hand, from Painlevé $A_{1}^{(1)} / A_{7}^{(1)^{\prime}}$ equation 1.8 , we obtain

$$
\begin{equation*}
\mathrm{F}(q z) \mathrm{F}\left(q^{-1} z\right)=\left(\frac{\mathrm{F}-z}{\mathrm{~F}-1}\right)^{2} \tag{6.2}
\end{equation*}
$$

Let us make standard limit, rescaling

$$
\begin{equation*}
z \mapsto \hbar^{4} z, \quad F \mapsto \hbar F \Rightarrow \mathrm{~F} \mapsto \hbar^{2} \mathrm{~F}, \quad \text { where } \hbar=\log q \tag{6.3}
\end{equation*}
$$

and tending $\hbar \rightarrow-0$. Namely, after such limit from 6.2 we obtain

\mathrm{F}^{\prime \prime}=\frac{\mathrm{F}^{\prime 2}}{\mathrm{~F}}-\frac{\mathrm{F}^{\prime}}{z}+\frac{2 \mathrm{~F}^{2}}{z^{2}}-\frac{2}{z} \tag{6.4}
\end{equation*}
$$

which is Painlevé $\operatorname{III}\left(D_{8}^{(1)}\right)$ equation. This limit of 6.1) will be

$$
\begin{equation*}
F^{\prime \prime}=\frac{F^{\prime 2}}{F}-\frac{F^{\prime}}{z}+\frac{F^{3}}{z^{2}}-\frac{1}{z F} \tag{6.5}
\end{equation*}
$$

Under substitution $z=t^{2} / 16, F \mapsto F / 2$ we obtain

$$
\begin{equation*}
\ddot{F}=\frac{\dot{F}^{2}}{F}-\frac{\dot{F}}{t}+\frac{F^{3}}{t^{2}}-\frac{1}{F}, \tag{6.6}
\end{equation*}
$$

which is Painlevé III $\left(D_{6}^{(1)}\right)$ equation with $\theta_{\star}=0, \theta_{*}=1 / 2$. Finally, we have that after the limit folding $w=s_{0} s_{1} s_{4} s_{5}: D_{5}^{(1)} / A_{3}^{(1)} \rightarrow A_{1}^{(1)} / A_{7}^{(1)^{\prime}}$ goes to the folding 5.2 from [TOS05] from $A_{2}^{(1)} / D_{6}^{(1)}$ to $A_{0}^{(1)} / D_{8}^{(1)}$ with $\mathrm{F}=F^{2} / 4, z=t^{2} / 16$.

### 6.2 Relation to known foldings of $q$-Painlevé equations

Few foldings of $q$-Painlevé equations were found in the paper RGT00. The constructions in loc. cit. were based on two possibilities: either right side of equation becomes perfect square or depend in some variable $x$ through its square $x^{2}$. The relation between formulas in RGT00 and classification, obtained in this paper is the following [RGT00]. Here we present the relation of these results to the classification of folding transformation, obtained in our paper:

1. Section 3.1 of loc. cit. in perfect square case corresponds to $2 A_{1}: D_{5}^{(1)} / A_{3}^{(1)} \rightarrow E_{7}^{(1)} / A_{1}^{(1)}$.
2. Section 3.1 of loc. cit. in square dependence case corresponds to $4 A_{1}: E_{7}^{(1)} / A_{1}^{(1)} \rightarrow D_{5}^{(1)} / A_{3}^{(1)}$.
3. Section 3.3 of loc. cit. in perfect square case corresponds to $A_{1}: E_{3}^{(1)} / A_{5}^{(1)} \rightarrow E_{6}^{(1)} / A_{2}^{(1)}$.
4. Section 3.3 of loc. cit. in square dependence case corresponds to $4 A_{1}: E_{6}^{(1)} / A_{2}^{(1)} \rightarrow E_{3}^{(1)} / A_{5}^{(1)}$.

Note that foldings from perfect square cases and square dependence cases form pairs of opposite foldings, see Remark 3.7.
