# Mean-field BDSDEs and associated nonlocal semi-linear backward stochastic partial differential equations *

#### Abstract

In this paper we investigate mean-field backward doubly stochastic differential equations (BDSDEs), i.e., BDSDEs whose driving coefficients also depend on the joint law of the solution process as well as the solution of an associated mean-field forward SDE. Unlike the pioneering paper on BDSDEs by Pardoux-Peng [25], we handle a driving coefficient in the backward integral of the BDSDE for which the Lipschitz assumption with respect to the law of the solution is sufficient, without assuming that this Lipschitz constant is small enough. Using the splitting method introduced in 4 for mean-field SDEs, we study the unique solutions $\left(Y^{t, \xi}, Z^{t, \xi}\right)$ and ( $Y^{t, x, P_{\xi},} Z^{t, x, P_{\xi}}$ ) of our BDSDEs. Under suitable regularity assumptions on the coefficients we investigate the first and the second order derivatives of the solution ( $Y^{t, x, P_{\xi},} Z^{t, x, P_{\xi}}$ ) with respect to $x$, the derivative $\left(\partial_{\mu} Y^{t, x, P_{\xi}}(y), \partial_{\mu} Z^{t, x, P_{\xi}}(y)\right)$ of the solution process with respect to the measure $P_{\xi}$, and the derivative of $\left(\partial_{\mu} Y^{t, x, P_{\xi}}(y), \partial_{\mu} Z^{t, x, P_{\xi}}(y)\right)$ with respect to $y$. However, as the parameters $\left(x, P_{\xi}\right)$ and $\left(x, P_{\xi}, y\right)$ run an infinite-dimensional space, unlike Pardoux and Peng, we cannot apply Kolmogorov's continuity criterion to the value function $V\left(t, x, P_{\xi}\right):=Y_{t}^{t, x, P_{\xi}}$, while in the classical case studied in [25] the value function $V(t, x)=Y_{t}^{t, x}$ can be shown to be of class $C^{1,2}\left([0, T] \times \mathbb{R}^{d}\right)$, we have for our value function $V\left(t, x, P_{\xi}\right)$ and its derivative $\partial_{\mu} V\left(t, x, P_{\xi}, y\right)$ only the $L^{2}$-differentiability with respect to $x$ and $y$, respectively. However, we have to use the (mean-field) Itô formula. To overcome this problem the characterisation of $V=\left(V\left(t, x, P_{\xi}\right)\right)$ as the unique solution of the associated mean-field backward stochastic PDE uses the $C_{b}^{1,2,2}$-functions $\Psi\left(t, x, P_{\xi}\right):=E\left[V\left(t, x, P_{\xi}\right) \cdot \eta\right]$ for suitable $\eta \in L^{\infty}(\mathcal{F} ; \mathbb{R})$. Using a similar idea, we extend the classical mean-field Itô formula to smooth functions of solutions of mean-field BDSDEs.

## 1 Introduction

Backward doubly stochastic differential equations (BDSDEs, for short) were introduced by Pardoux and Peng in their pioneering paper [25] in 1994. These equations are a generalisation of backward SDEs involving in addition to the (forward) Itô integral driven by a Brownian motion $W$ a backward one governed by an independent Brownian motion $B$. Pardoux and Peng showed namely that the BDSDE gives a (doubly) stochastic interpretation for the classical solution of the following backward stochastic partial differential equation (SPDE, for short):

where the second-order differential operator $\mathcal{L}$ is the generator of the forward diffusion SDE associated with the BDSDE.

Stimulated by this pioneering work, a great number of researchers have been attracted by this topic and studied different extensions. Without going into details, let us cite here, for instance, the works by Bally and Matoussi [1], Zhang and Zhao [28] and Matoussi, Piozin and Popier [23]. Other works on BDSDEs were motivated, e.g., by Zakai equation in filtering [21, 22], by stochastic control with partial observations or pathwise stochastic control theory [20]. For other recent developments on BDSDEs, we refer, e.g., to Buckdahn and Ma [5, 6], Han, Peng and Wu [11, but also Li and Xing [17], Li, Xing and Peng [18], Shi, Wen and Xiong [27, Shi, Gu and Liu [26], should be mentioned.

The study of mean-field stochastic differential equations (SDEs), known also as McKeanVlasov SDEs, goes back to the work by Kac [13] in 1956. Since then, stimulated by numerous applications, the theory of mean-field SDEs has been dynamically developing. In recent years, new impulses to this research were given by the course given by P.L. Lions at Collège de France [19] (We also refer to the notes by Cardaliaguet [7]), in which the author introduced the notion of differentiability with respect to (w.r.t.) the probability measure of a function defined over a space of probability laws with finite second order moment. Inspired by [19, 7, in 2017, Buckdahn, Li, Peng and Rainer [4] considered a general mean-field SDE whose coefficients depend on both the solution process and its law. They studied the properties of the solution of this SDE, and in particular, the associated non-local PDEs of mean-field type. Hao and Li [12] extended these studies to meanfield SDEs which, in addition to the driving Brownian motion, are governed by a compensated Poisson random measure. In [15], Li extended this work to general mean-field forward-backward SDEs (FBSDEs) with jumps, in which the coefficients of both the forward and also the backward SDE depend on the solution processes but also on their joint law. She showed in particular that such mean-field FBSDEs give a stochastic interpretation to nonlocal integral-partial differential equations. We emphasize that the value functions in [4, 12 and [15] are deterministic functions.

On the other hand, inspired by the seminal paper [14] by Lasry and Lions (2007), Buckdahn, Djehiche, Li and Peng [2] investigated a nonlinear mean-field BSDE. Since then, motivated by its various applications, the theory of mean-field BSDEs has been studied by numerous researchers, among them Buckdahn, Li and Peng [3], Carmona and Delarue [9], Li, Liang and Zhang [16], Chen, Xing and Zhang [10]. Li and Xing [17] extended these investigations to general mean-field BDSDEs

We emphasise that the Lipschitz constant of the coefficient $h$ can be arbitrary without necessarily being small enough. For more details we refer to Appendix A.2.

Inspired by above works, in this paper we study a general mean-field BDSDE associated with a forward diffusion SDE as well as the related backward SPDEs of mean-field type. More precisely, we consider the solutions $\left(X^{t, \xi}, X^{t, x, P_{\xi}}\right)$ of the split forward SDE (see, (3.1) and (3.2)) and those of the split $\operatorname{BDSDE}\left(Y^{t, \xi}, Z^{t, \xi}\right)$ and $\left(Y^{t, x, \xi}, Z^{t, x, \xi}\right)$ (see, (4.1) and (4.2)). Their existence is stated in Theorem A. 1 (Appendix A.2), and the fact that $\left(Y^{t, x, \xi}, Z^{t, x, \xi}\right)$ depends on $\xi$ only through its law $\left(\left(Y^{t, x, \xi}, Z^{t, x, \xi}\right)=\left(Y_{s}^{t, x, P_{\xi}}, Z_{s}^{t, x, P_{\xi}}\right)\right)$ is proven by Proposition 4.1. Besides of the study of regularity properties of the solution of the mean-field BDSDE, our main objective is the characterization of the value function $V\left(t, x, P_{\xi}\right):=Y_{t}^{t, x, P_{\xi}}$, a stochastic process adapted to the backward filtration generated by the Brownian motion $B$, as unique solution of the associated mean-field semi-linear backward stochastic PDE (SPDE) which is a new type of SPDE

where $\psi\left(s, x, P_{\xi}\right):=\left(V\left(s, x, P_{\xi}\right), \sum_{i=1}^{d} \partial_{x_{i}} V\left(s, x, P_{\xi}\right) \sigma_{i}\left(x, P_{\xi}\right)\right)$. Observed that, when the coefficients don't depend on the law, (1.3) reduces to (1.1). Following the scheme given by Pardoux and Peng in their seminal paper [25], we study the regularity of $\left(Y^{t, x, P_{\xi}}, Z^{t, x, P_{\xi}}\right)$. However, apart from the fact that Pardoux and Peng restricted to the proof of the first order derivative of $\left(Y^{t, x}, Z^{t, x}\right)$ w.r.t. $x$ and only stated the second order differentiability, to make the proofs not only for the first order derivative of $\left(Y^{t, x, P_{\xi}}, Z^{t, x, P_{\xi}}\right)$ w.r.t. $x$ and w.r.t. the measure, but we discuss also all the details of the proof for its second order derivative w.r.t. $x$ and the derivative w.r.t. $y$ of the derivative w.r.t. the measure $\left(\partial_{\mu} Y^{t, x, P_{\xi}}(y), \partial_{\mu} Z^{t, x, P_{\xi}}(y)\right)$, and this is related with different subtle technicalities. In particular, Malliavin calculus will be used to prove some crucial estimates for $Z^{t, x, P_{\xi}}$ and its derivatives (see, the Propositions 4.3, 8.1 and A.1). Another difficulty comes from the fact that the derivatives of $\left(Y^{t, x, P_{\xi}}, Z^{t, x, P_{\xi}}\right)$ w.r.t. $x$ (of first and second order) and the (first order) derivative
of $\left(\partial_{\mu} Y^{t, x, P_{\xi}}(y), \partial_{\mu} Z^{t, x, P_{\xi}}(y)\right)$ w.r.t. $y$ are $L^{2}$-derivatives, i.e., we prove the $L^{2}$-regularity of the value function $V\left(t, x, P_{\xi}\right):=Y_{t}^{t, x, P_{\xi}}$. However, we have to apply the (mean-field) Itô formula to $V\left(s, X_{s}^{t, x, P_{\xi}}, P_{X_{s}^{t, \xi}}\right)$. Pardoux and Peng concluded that their value function $V(t, x)$ is a $C^{1,2}$-function by using Kolmogorov's continuity criterion. But we cannot use it, because in our case the parameter $\left(t, x, P_{\xi}\right)$ of $V=V\left(t, x, P_{\xi}\right)$ runs an infinite-dimensional space. To overcome that we have for $V$ only $L^{2}$-regularity, we introduce the deterministic function $\Psi\left(t, x, P_{\xi}\right):=E\left[V\left(t, x, P_{\xi}\right) \cdot \eta\right]$, for suitable $\eta \in L^{\infty}(\mathcal{F} ; \mathbb{R})$, and for $\Psi$ we can show that it is a $C_{b}^{1,2,2}$-function. Applying the (mean-field) Itô formula to $\Psi\left(s, X_{s}^{t, x, P_{\xi}}, P_{X_{s}^{t, \xi}}\right)$ will be crucial for the proof that $V$ is a solution of SPDE (1.3), a classical one but with the derivatives w.r.t. $x$ and $y$ in $L^{2}$-sense. By defining a suitable space to which the solution process $V$ belongs, the same technique will allow to prove the uniqueness.

Last but not least, let us mention that we extend the classical mean-field Itô formula (see [4]) to $C_{b}^{1,2,2}$-functions $F\left(s, U_{s}, P_{Y_{s}}\right)$ applied to solutions of BDSDEs $U=\left(U_{s}\right)$ and $Y=\left(Y_{s}\right)$ (Theorem [2.1). Our Itô formula extends namely that by Pardoux-Peng [25] who studied the case $F\left(s, U_{s}\right)=\left|U_{s}\right|^{2}$. As, on the other hand, a classical SDE (with backward integral) is a special case of a BDSDE, our Itô formula can also be regarded as extension of the classical mean-field Itô SDE. The proof of Theorem 2.1 is inspired by our approach in the proof that $V$ is the unique solution of SPDE (1.3).

Our paper is organized as follows: Section 2 is on one hand devoted to preliminaries, but on the other hand we state there also our mean-field Itô formula extended to solutions of BDSDEs. While Section 3 gives a recall on mean-field SDEs, Section 4 is devoted to the investigation of the existence and the uniqueness of solutions and the corresponding estimates for our split mean-field BDSDEs. Section 5 gives a recall on the first order derivatives of the process $X^{t, x, P_{\xi}}$ with respect to $x$ and the measure $P_{\xi}$, and the corresponding estimates. In Section 6 the first order derivatives of $\left(Y^{t, x, P_{\xi}}, Z^{t, x, P_{\xi}}\right)$ w.r.t. $x$ and w.r.t. $P_{\xi}$ are investigated. Section 7 is devoted to the second order derivatives of $X^{t, x, P_{\xi}}$, and using an additional assumption on $g$ (Assumption (H8.2)), the second order derivatives of $\left(Y^{t, x, P_{\xi}}, Z^{t, x, P_{\xi}}\right)$ are discussed in Section 8. Basing on our mean-field Itô's formula, in Section 9 we prove that the value function $V\left(t, x, P_{\xi}\right)$ is the unique classical solution of the SPDE (1.3). Finally, in the Appendix we give the proof of Theorem 2.1 (Appendix A.1), we recall some basic results on mean-field BDSDEs (Appendix A.2), and we study the special case of BDSDEs with a coefficient $g$ which is affine in $z$ (Appendix A.3).

## 2 Preliminaries

Let $T>0$ be a fixed time horizon and $(\Omega, \mathcal{F}, P)$ be a complete probability space. Let $\left\{W_{t}, 0 \leq\right.$ $t \leq T\}$ and $\left\{B_{t}, 0 \leq t \leq T\right\}$ be two mutually independent standard Brownian motions defined on $(\Omega, \mathcal{F}, P)$, with values in $\mathbb{R}^{d}$ and in $\mathbb{R}^{l}$, respectively. We assume that there is a sub- $\sigma$-field $\mathcal{F}^{0} \subset \mathcal{F}$, containing all $P$-null subsets of $\mathcal{F}$, such that
(i) the Brownian motion $(B, W)$ is independent of $\mathcal{F}^{0}$;
(ii) $\mathcal{F}^{0}$ is 'rich enough', i.e., $\mathcal{P}_{2}\left(\mathbb{R}^{k}\right)=\left\{P_{\xi}, \xi \in L^{2}\left(\mathcal{F}^{0} ; \mathbb{R}^{k}\right)\right\}, k \geq 1$.

Here $P_{\xi}:=P \circ[\xi]^{-1}$ denotes the law of the random variable $\xi$ under the probability $P$.
For $0 \leq t \leq s \leq T$, we define $\mathcal{F}_{t, s}:=\mathcal{F}_{t, s}^{W} \vee \mathcal{F}_{s, T}^{B} \vee \mathcal{F}^{0}, \mathcal{F}_{s}:=\mathcal{F}_{0, s}, \mathcal{G}_{s}:=\mathcal{F}_{s}^{W} \vee \mathcal{F}^{0}$ and $\mathcal{D}_{s}:=\mathcal{F}_{s}^{W} \vee \mathcal{F}_{T}^{B} \vee \mathcal{F}^{0}$, where for any process $\left\{\eta_{t}\right\}, \mathcal{F}_{t, s}^{\eta}=\sigma\left\{\eta_{r}-\eta_{t} ; t \leq r \leq s\right\}$ augmented by the $P-$ null sets, and $\mathcal{F}_{t}^{\eta}=\mathcal{F}_{0, t}^{\eta}$. It should be noted that $\left\{\mathcal{F}_{t}, t \in[0, T]\right\}$ is neither increasing nor decreasing,
and so it does not constitute a filtration. However, $\left\{\mathcal{G}_{t}, t \in[0, T]\right\}$ as well as $\left\{\mathcal{D}_{t}, t \in[0, T]\right\}$ are filtrations. For $n \in \mathbb{N}$ and $x, y \in \mathbb{R}^{n}$, we denote the norm and inner product, respectively, by $|x|=\left(\sum_{i=1}^{n} x_{i}^{2}\right)^{\frac{1}{2}}$ and $\langle x, y\rangle=\sum_{i=1}^{n} x_{i} y_{i}$.

Let us introduce some notations and concepts, which are used frequently in what follows. Recall that $\mathcal{P}_{2}\left(\mathbb{R}^{k}\right)$ is the set of all probability measures $\mu$ on $\left(\mathbb{R}^{k}, \mathcal{B}\left(\mathbb{R}^{k}\right)\right)$ with finite second moment, i.e., $\int_{\mathbb{R}^{k}}|x|^{2} \mu(d x)<\infty$. Here $\mathcal{B}\left(\mathbb{R}^{k}\right)$ denotes the Borel $\sigma$-field over $\mathbb{R}^{k}$. $\mathcal{P}_{2}\left(\mathbb{R}^{k}\right)$ is endowed with the 2-Wasserstein metric: For $\mu, \nu \in \mathcal{P}_{2}\left(\mathbb{R}^{k}\right)$,

We will also need a weighted 2-Wasserstein metric on $\mathcal{P}_{2}\left(\mathbb{R}^{k} \times \mathbb{R}^{k \times d}\right)$ : For $\mu, \mu^{\prime} \in \mathcal{P}_{2}\left(\mathbb{R}^{k} \times \mathbb{R}^{k \times d}\right)$,

for any fixed $\gamma_{1}, \gamma_{2}>0$. It is obvious that $W_{2, \gamma_{1}, \gamma_{2}}(\cdot, \cdot)$ is not only a metric but also equivalent to $W_{2}(\cdot, \cdot)$. Indeed, $\left(\gamma_{1} \wedge \gamma_{2}\right)^{\frac{1}{2}} W_{2}\left(\mu, \mu^{\prime}\right) \leq W_{2, \gamma_{1}, \gamma_{2}}\left(\mu, \mu^{\prime}\right) \leq\left(\gamma_{1} \vee \gamma_{2}\right)^{\frac{1}{2}} W_{2}\left(\mu, \mu^{\prime}\right)$.

We shall also introduce the following spaces of stochastic processes: For $p>1, t \in[0, T]$,

- $L^{p}\left(\Omega, \mathcal{F}_{T}, P ; \mathbb{R}^{d}\right)$ is the set of $\mathcal{F}_{T}$-measurable random variables $\xi: \Omega \rightarrow \mathbb{R}^{d}$ such that $\|\xi\|_{L^{p}}:=$ $\left(E\left[|\xi|^{p}\right)^{\frac{1}{p}}<\infty\right.$.
- $\mathcal{S}_{\mathcal{F}}^{p}\left(t, T ; \mathbb{R}^{d}\right)$ is the set of $\left\{\mathcal{F}_{t, s}\right\}$-adapted measurable continuous processes $\eta: \Omega \times[t, T] \rightarrow \mathbb{R}^{d}$ with $\|\eta\| \mathcal{S}^{p}:=\left(E\left[\sup _{t \leq s \leq T}|\eta(s)|^{p}\right]\right)^{\frac{1}{p}}<\infty$.
- $\mathcal{H}_{\mathcal{F}}^{p}\left(t, T ; \mathbb{R}^{d}\right)$ is the set of $\left\{\mathcal{F}_{t, s}\right\}$-adapted measurable processes $\eta: \Omega \times[t, T] \rightarrow \mathbb{R}^{d}$ with $\|\eta\|_{\mathcal{H}^{p}}:=$ $\left(E\left[\left(\int_{t}^{T}|\eta(s)|^{2} d s\right)^{\frac{p}{2}}\right]\right)^{\frac{1}{p}}<\infty$.
- $C_{b}^{k}\left(\mathbb{R}^{p}, \mathbb{R}^{q}\right)$ is the set of functions of class $C^{k}$ from $\mathbb{R}^{p}$ into $\mathbb{R}^{q}$ whose partial derivatives of all order less than or equal to $k$ are bounded.
- $\mathcal{S}$ is the set of smooth random variables $\xi$ of the form $\xi=\varphi\left(W\left(h_{1}\right), \cdots, W\left(h_{n}\right) ; B\left(k_{1}\right), \cdots, B\left(k_{p}\right)\right)$, $n, p \geq 0$, with $\varphi \in C_{b}^{\infty}\left(\mathbb{R}^{n+p}, \mathbb{R}\right), h_{1}, \cdots, h_{n} \in L^{2}\left(0, T ; \mathbb{R}^{d}\right), k_{1}, \cdots, k_{p} \in L^{2}\left(0, T ; \mathbb{R}^{l}\right)$, $W\left(h_{i}\right):=$ $\int_{0}^{T}\left\langle h_{i}(t), d W_{t}\right\rangle, B\left(k_{j}\right):=\int_{0}^{T}\left\langle k_{j}(t), d B_{t}\right\rangle$.

Moreover, if $\xi \in S$ is of the above form, its Malliavin derivative w.r.t. $W$, denoted by $D[\cdot]:=D^{W}[\cdot]$, is given by $D_{t} \xi=\sum_{i=1}^{n} \frac{\partial \varphi}{\partial x_{i}}\left(W\left(h_{1}\right), \cdots, W\left(h_{n}\right) ; B\left(k_{1}\right), \cdots, B\left(k_{p}\right)\right) h_{i}(t), 0 \leq t \leq T$. For $\xi \in S, p>1$, we define the norm $\|\xi\|_{1, p}=\left(E\left[|\xi|^{p}+\left(\int_{0}^{T}\left|D_{t} \xi\right|^{2} d t\right)^{\frac{p}{2}}\right]\right)^{\frac{1}{p}}$. From [24] we know the operator $D$ has a closed extension to the space $\mathbb{D}^{1, p}$, the closure of $S$ with respect to the norm $\|\cdot\|_{1, p}$. Furthermore, we put $\mathbb{D}^{1, \infty}=\bigcap_{p \geq 2} \mathbb{D}^{1, p}$. Observe that if $\xi \in \mathbb{D}^{1,2}$ is $\mathcal{F}_{t}$-measurable, $D_{\theta} \xi=0$, $d \theta d P$-a.e., $\theta \in(t, T]$. We shall denote by $D_{\theta}^{i} \xi$, the $i$-th component of $D_{\theta} \xi, 1 \leq i \leq d$.

We now recall the notion of differentiability with respect to probability measure of a function defined on $\mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$. There are different definitions, we use that introduced by Lions [19], also refer to
the notes by Cardaliaguet [7]. For more details the readers also may refer to Buckdahn, Li, Peng and Rainer [4], Hao and Li [12, Li [15]. Given a function $\varphi: \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \rightarrow \mathbb{R}$, we consider the lifted function $\widetilde{\varphi}(\xi):=\varphi\left(P_{\xi}\right), \xi \in L^{2}\left(\mathcal{F} ; \mathbb{R}^{d}\right)\left(:=L^{2}\left(\Omega, \mathcal{F}, P ; \mathbb{R}^{d}\right)\right)$. If for a given $\mu_{0} \in \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$ there exists a random variable $\xi_{0} \in L^{2}\left(\mathcal{F} ; \mathbb{R}^{d}\right)$ satisfying $P_{\xi_{0}}=\mu_{0}$, such that $\widetilde{\varphi}: L^{2}\left(\mathcal{F} ; \mathbb{R}^{d}\right) \rightarrow \mathbb{R}$ is Fréchet differentiable in $\xi_{0}, \varphi$ is said to be differentiable with respect to $\mu_{0}$. This is equivalent with the existence of a continuous linear mapping $D \widetilde{\varphi}\left(\xi_{0}\right): L^{2}\left(\mathcal{F} ; \mathbb{R}^{d}\right) \rightarrow \mathbb{R}^{d}$ (i.e., $D \widetilde{\varphi}\left(\xi_{0}\right) \in L\left(L^{2}\left(\mathcal{F} ; \mathbb{R}^{d}\right), \mathbb{R}^{d}\right)$ ) such that

for $\zeta \in L^{2}\left(\mathcal{F} ; \mathbb{R}^{d}\right)$ with $|\zeta|_{L^{2}} \rightarrow 0$. Riesz's Representation Theorem allows to show that there exists a unique $\eta \in L^{2}\left(\mathcal{F} ; \mathbb{R}^{d}\right)$ such that $D \widetilde{\varphi}\left(\xi_{0}\right)(\zeta)=E[\eta \cdot \zeta], \zeta \in L^{2}\left(\mathcal{F} ; \mathbb{R}^{d}\right)$. It was shown by Lions that $\eta$ is a Borel measurable function of $\xi_{0}$, refer to Cardaliaguet [7, $\eta=\psi\left(\xi_{0}\right)$, where $\psi$ is a Borel measurable function depending on $\xi_{0}$ only through its law. Combining (2.3) and the above argument, we have

In the spirit of Lions and Cardaliaguet, the derivative of $\varphi: \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \rightarrow \mathbb{R}$ with respect to the measure $P_{\xi_{0}}$ is denoted by $\partial_{\mu} \varphi\left(P_{\xi_{0}}, y\right):=\psi(y), y \in \mathbb{R}^{d}$. Observe that $\partial_{\mu} \varphi\left(P_{\xi_{0}}, y\right)$ is only $P_{\xi_{0}}(d y)-$ a.e. uniquely determined; see also Definition 2.1 in Buckdahn, Li, Peng and Rainer 44. We also mention that an equivalent approach for the derivative was developed by Cardaliaguet, Delarue, Lasry and P.L. Lions [8], interested readers are referred to this work.

Now we introduce several spaces which will be used frequently.
Definition 2.1. (1) We say that $\varphi$ belongs to $C_{b}^{1}\left(\mathcal{P}_{2}\left(\mathbb{R}^{d}\right)\right)$, if $\varphi: \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \rightarrow \mathbb{R}$ is differentiable on $\mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$ and $\partial_{\mu} \varphi(\cdot, \cdot): \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \times \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ is bounded and Lipschitz continuous, i.e., there exists some positive constant $L$ such that
(i) $\left|\partial_{\mu} \varphi(\mu, y)\right| \leq L, \mu \in \mathcal{P}_{2}\left(\mathbb{R}^{d}\right), y \in \mathbb{R}$,
(ii) $\left|\partial_{\mu} \varphi(\mu, y)-\partial_{\mu} \varphi\left(\mu^{\prime}, y^{\prime}\right)\right| \leq L\left(W_{2}\left(\mu, \mu^{\prime}\right)+\left|y-y^{\prime}\right|\right), \mu, \mu^{\prime} \in \mathcal{P}_{2}\left(\mathbb{R}^{d}\right), y, y^{\prime} \in \mathbb{R}$.
(2) By $C_{b}^{2}\left(\mathcal{P}_{2}\left(\mathbb{R}^{d}\right)\right)$ we denote the space of all functions $\varphi \in C_{b}^{1}\left(\mathcal{P}_{2}\left(\mathbb{R}^{d}\right)\right)$ such that $\left(\partial_{\mu} \varphi\right)_{j}(\mu, \cdot)$ : $\mathbb{R}^{d} \rightarrow \mathbb{R}$ is differentiable, for every $\mu \in \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$, and the derivative $\partial_{y} \partial_{\mu} \varphi: \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \times \mathbb{R}^{d} \rightarrow \mathbb{R}^{d} \otimes \mathbb{R}^{d}$ is bounded and Lipschitz continuous.
We will use the notation $\partial_{\mu} \varphi(\mu, y):=\left(\left(\partial_{\mu} \varphi\right)_{j}(\mu, y)\right)_{1 \leq j \leq d},(\mu, y) \in \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \times \mathbb{R}^{d}$.
Definition 2.2. (1) We say that $\varphi$ belongs to $C_{b}^{0,2,2}\left([0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)\right)$, if $\varphi:[0, T] \times \mathbb{R}^{d} \times$ $\mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \rightarrow \mathbb{R}$ satisfies
(i) $\varphi(\cdot, \cdot, \mu) \in C_{b}^{0,2}\left([0, T] \times \mathbb{R}^{d}\right)$, for all $\mu \in \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$;
(ii) $\varphi(t, x, \cdot) \in C_{b}^{2}\left(\mathcal{P}_{2}\left(\mathbb{R}^{d}\right)\right)$, for all $(t, x) \in[0, T] \times \mathbb{R}^{d}$;
(iii) All derivatives of order 1 and 2 are continuous on $[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \times \mathbb{R}^{d}$, and uniformly bounded over $[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \times \mathbb{R}^{d}, \partial_{\mu} \varphi$ and $\partial_{y}\left(\partial_{\mu} \varphi\right)$ are Lipschitz continuous w.r.t. $(x, \mu, y)$, uniformly w.r.t. $t$.
(2) We say that $\varphi$ belongs to $C_{b}^{1,2,2}\left([0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)\right)$, if $\varphi:[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \rightarrow \mathbb{R}$ satisfies
(i) $\varphi(\cdot, \cdot, \mu) \in C_{b}^{1,2}\left([0, T] \times \mathbb{R}^{d}\right)$, for all $\mu \in \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$;
(ii) $\varphi(t, x, \cdot) \in C_{b}^{2}\left(\mathcal{P}_{2}\left(\mathbb{R}^{d}\right)\right)$, for all $(t, x) \in[0, T] \times \mathbb{R}^{d}$;
(iii) All derivatives of order 1 and 2 are continuous on $[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \times \mathbb{R}^{d}$, and uniformly bounded over $[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \times \mathbb{R}^{d}, \partial_{\mu} \varphi$ and $\partial_{y}\left(\partial_{\mu} \varphi\right)$ are Lipschitz continuous w.r.t. $(x, \mu, y)$,
uniformly w.r.t. $t$.
(3) We say that $\varphi$ belongs to $C_{b}^{1,2}\left([0, T] \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)\right)$, if $\varphi:[0, T] \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \rightarrow \mathbb{R}$ satisfies
(i) $\varphi(\cdot, \mu) \in C_{b}^{1}([0, T])$, for all $\mu \in \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$;
(ii) $\varphi(t, \cdot) \in C_{b}^{2}\left(\mathcal{P}_{2}\left(\mathbb{R}^{d}\right)\right)$, for all $t \in[0, T]$;
(iii) All derivatives of order 1 and 2 are continuous on $[0, T] \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \times \mathbb{R}^{d}$, and uniformly bounded over $[0, T] \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \times \mathbb{R}^{d}, \partial_{\mu} \varphi$ and $\partial_{y}\left(\partial_{\mu} \varphi\right)$ are Lipschitz continuous w.r.t. $(\mu, y)$, uniformly w.r.t. $t$.

Now we briefly review the notion of a solution of a backward doubly stochastic differential equations (BDSDEs, for short) from Pardoux and Peng [25].

Let $f:[0, T] \times \Omega \times \mathbb{R}^{k} \times \mathbb{R}^{k \times d} \rightarrow \mathbb{R}^{k}, g:[0, T] \times \Omega \times \mathbb{R}^{k} \times \mathbb{R}^{k \times d} \rightarrow \mathbb{R}^{k \times l}$ be jointly measurable and satisfy:
Assumption (H2.1) (i) $(g(t, \cdot, 0,0))_{t \in[0, T]} \in \mathcal{H}_{\mathcal{F}}^{2}\left(0, T ; \mathbb{R}^{k \times l}\right)$;
(ii) $g$ is Lipschitz in $(y, z)$, i.e., there exist constants $C>0$, and $0<\alpha<1$ such that for all $t \in[0, T], y_{1}, y_{2} \in \mathbb{R}^{k}, z_{1}, z_{2} \in \mathbb{R}^{k \times d}, P$-a.s.,

(iii) $(f(t, \cdot, 0,0))_{t \in[0, T]} \in \mathcal{H}_{\mathcal{F}}^{2}\left(0, T ; \mathbb{R}^{k}\right)$;
(iv) $f$ is Lipschitz in $(y, z)$, i.e., there exists a constant $C>0$ such that for all $t \in[0, T], y_{1}, y_{2} \in \mathbb{R}^{k}$, $z_{1}, z_{2} \in \mathbb{R}^{k \times d}, P$-a.s.,

Given $\xi \in L^{2}\left(\Omega, \mathcal{F}_{T}, P ; \mathbb{R}^{k}\right)$, Pardoux and Peng [25] studied the following BDSDE:

where $W$ and $B$ are two independent Brownian motions, the integral with respect to $B$ is the Itô backward one, denoted by $d \overleftarrow{B}$

Proposition 2.1. Under Assumption (H2.1), equation (2.5) has a unique solution $(Y, Z) \in \mathcal{S}_{\mathcal{F}}^{2}(0, T$; $\left.\mathbb{R}^{k}\right) \times \mathcal{H}_{\mathcal{F}}^{2}\left(0, T ; \mathbb{R}^{k \times d}\right)$.

For more details, please, we refer to Theorem 1.1 in Pardoux and Peng [25] or Appendix A. 2 of this paper.

Next we give a general Itô's formula which will be used later.
Theorem 2.1. (Itô's formula). Let $F \in C_{b}^{1,2,2}\left([0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)\right)$. Given $f \in \mathcal{H}_{\mathcal{F}}^{2}\left(0, T ; \mathbb{R}^{d}\right), g \in$ $\mathcal{H}_{\mathcal{F}}^{2}\left(0, T ; \mathbb{R}^{d \times l}\right), \xi \in L^{2}\left(\mathcal{F}_{T} ; \mathbb{R}^{d}\right)$, as well as $u \in \mathcal{H}_{\mathcal{F}}^{2}\left(0, T ; \mathbb{R}^{d}\right)$, $v \in \mathcal{H}_{\mathcal{F}}^{2}\left(0, T ; \mathbb{R}^{d \times l}\right)$, $\eta \in L^{2}\left(\mathcal{F}_{T} ; \mathbb{R}^{d}\right)$. We consider the solution $(Y, Z),(U, V) \in \mathcal{S}_{\mathcal{F}}^{2}\left(0, T ; \mathbb{R}^{d}\right) \times \mathcal{H}_{\mathcal{F}}^{2}\left(0, T ; \mathbb{R}^{d \times d}\right)$ of the following BDSDE, respectively:

Here $(\widehat{Y}, \widehat{Z}, \widehat{f}, \widehat{g})$ denotes an independent copy of $(Y, Z, f, g)$, defined on another probability space $(\widehat{\Omega}, \widehat{\mathcal{F}}, \widehat{P})$. The expectation $\widehat{E}[\cdot]$ on $(\widehat{\Omega}, \widehat{\mathcal{F}}, \widehat{P})$ concerns only random variables endowed with the superscript "へ". For a better readability of the manuscript, the proof of this theorem is postponed to Appendix A.1.

Remark 2.1. We note that like in [4] (there for the "classcal" mean-field Ito formula) we do not need the existence of the second order mixed derivatives $\partial_{x} \partial_{\mu} F, \partial_{\mu} \partial_{x} F, \partial_{\mu}^{2} F$ for our Itô formula. This is why they are not introduced in the definition of the space $C_{b}^{1,2,2}\left([0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)\right)$.

In particular, for dimensions $d=1, l=1$, we have the following corollary.
Corollary 2.1. Let $F \in C_{b}^{1,2,2}\left([0, T] \times \mathbb{R}^{2} \times \mathcal{P}_{2}\left(\mathbb{R}^{2}\right)\right)$. Given the solution $(Y, Z) \in \mathcal{S}_{\mathcal{F}}^{2}(0, T ; \mathbb{R}) \times$ $\mathcal{H}_{\mathcal{F}}^{2}(0, T ; \mathbb{R})$ of the $B D S D E$

Proof. Obviously, due to our assumptions, the process $((X, Y),(\sigma, Z)) \in \mathcal{S}_{\mathcal{F}}^{2}\left(0, T ; \mathbb{R}^{2}\right) \times \mathcal{H}_{\mathcal{F}}^{2}\left(0, T ; \mathbb{R}^{2}\right)$ is the unique solution of the BDSDE

Hence, Corollary 2.1 follows directly from Theorem 2.1.
Remark 2.2. We also observe that the Itô formula studied in [4] is a special case of Theorem [2.1 and Corollary 2.1.

## 3 Mean-field stochastic differential equations

In this section we consider mean-field stochastic differential equations (SDEs). From now on let be given deterministic Lipschitz functions $b: \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \rightarrow \mathbb{R}^{d}, \sigma: \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \rightarrow \mathbb{R}^{d \times d}$ satisfying Assumption (H3.1) $b$ and $\sigma$ are bounded and Lipschitz continuous on $\mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$.

We consider for the initial data $(t, x) \in[0, T] \times \mathbb{R}^{d}$ and $\xi \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right)$ the following both stochastic differential equations (SDEs):

We recall that under Assumption (H3.1) the both SDEs have a unique solution in $\mathcal{S}_{\mathcal{G}}^{2}\left(t, T ; \mathbb{R}^{d}\right)$ (see, e.g., Buckdahn, Li, Peng and Rainer (4). In particular, the solution $X^{t, \xi}$ of equation (3.1) allows to determine that of (3.2). Observe that $X^{t, x, \xi} \in \mathcal{S}_{\mathcal{G}}^{2}\left(t, T ; \mathbb{R}^{d}\right)$ is independent of $\mathcal{G}_{t}$. As SDE standard estimates show, we have for some $C \in \mathbb{R}_{+}$depending only on the Lipschitz constants of $b$ and $\sigma$,

This allows to substitute the random variable $\xi$ for $x$ in (3.2) and shows that $\left.X^{t, x, \xi}\right|_{x=\xi}$ solves the same SDE as $X^{t, \xi}$. From the uniqueness of the solution we conclude

We have to show that the solution $X^{t, x, \xi}$ does not depend on $\xi$ itself but only on its law $P_{\xi}$. For this, the following lemma is very useful; please refer to Buckdahn, Li, Peng and Rainer [4], or Proposition 3.1 in Hao and $\mathrm{Li}[12$, which is formulated for mean-field SDEs with jump.

Lemma 3.1. Suppose Assumption (H3.1) holds true. Then, for all $p \geq 2$ there exists a constant $C_{p}>0$ only depending on the Lipschitz constants of $b$ and $\sigma$, such that for all $t \in[0, T], x, \widehat{x} \in \mathbb{R}^{d}$, $\xi, \widehat{\xi} \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right)$, we have the following estimates

Remark 3.1. An immediate consequence of Lemma 3.1-(i) is that, given $(t, x) \in[0, T] \times \mathbb{R}^{d}$, the processes $X^{t, x, \xi_{1}}$ and $X^{t, x, \xi_{2}}$ are indistinguishable, whenever the laws of $\xi_{1}, \xi_{2} \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right)$ are the same. But this means that we can define

Extending the notation introduced in the preceding section for functions to random variables and processes, we shall consider the lifted process $\widetilde{X}_{s}^{t, x, \xi}:=X_{s}^{t, x, P_{\xi}}=X_{s}^{t, x, \xi}, s \in[t, T],(t, x) \in[0, T] \times \mathbb{R}^{d}$, $\xi \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right)$. However, we prefer to continue to write $X^{t, x, \xi}$ and reserve the notation $\widetilde{X}^{t, x, \xi}$ for an independent copy of $X^{t, x, P_{\xi}}$, which we will introduce later. On the other hand, note that $X_{s}^{t, x, P_{\xi}}$ is $\mathcal{F}_{s}^{W}$-measurable, $s \in[t, T],(t, x) \in[0, T] \times \mathbb{R}^{d}, \xi \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right)$.

We now recall that under natural conditions the solution of a SDE is differentiable in Malliavin's sense and that the derivative is a solution of a linear SDE.

Proposition 3.1. Let $b$ and $\sigma$ satisfy Assumption (H3.1). Moreover, we suppose the coefficients $b_{j}, \sigma_{i, j}, 1 \leq i, j \leq d$, to satisfy the following assumptions:
(i) $b_{j}(\cdot, \mu), \sigma_{i, j}(\cdot, \mu)$ belong to $C_{b}^{1}\left(\mathbb{R}^{d}\right)$, for all $\mu \in \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$;
(ii) The derivatives $\partial_{x} b_{j}, \partial_{x} \sigma_{i, j}: \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \rightarrow \mathbb{R}^{d}$ are bounded and Lipschitz continuous.

Then for all $(t, x) \in[0, T] \times \mathbb{R}^{d}, \xi \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right), s \in[t, T], X_{s}^{t, x, P_{\xi}} \in\left(\mathbb{D}^{1,2}\right)^{d}$ and a version of $\left\{D_{\theta} X_{s}^{t, x, P_{\xi}}: \theta, s \in[t, T]\right\}$ is given by:
(i) $D_{\theta} X_{s}^{t, x, P_{\xi}}=0$, if $\theta>s$;
(ii) $\left\{D_{\theta} X_{s}^{t, x, P_{\xi}}=\left(D_{\theta}^{i} X_{s}^{t, x, P_{\xi}, j}\right)_{1 \leq i, j \leq d}: s \in[\theta, T]\right\}$ is the unique solution of the linear $S D E$ : $s \in[t, T], 1 \leq i, j \leq d$,

Furthermore, for all $p \geq 2$ there exists a constant $C_{p}>0$ only depending on the Lipschitz constants of $\partial_{x} b$ and $\partial_{x} \sigma$, such that, for all $t \in[0, T], x, x^{\prime} \in \mathbb{R}^{d}, \xi, \xi^{\prime} \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right), P$-a.s.,

Proof. It is standard to prove that $X_{s}^{t, x, P_{\xi}}$ has a Malliavin derivative under our assumptions (see [24]). Moreover, from the assumptions, Lemma 3.1 and the standard estimates of classical SDEs, it can easily be verified that (3.9) holds true.

## 4 Mean-field BDSDEs

In this section we consider mean-field backward doubly stochastic differential equations (BDSDEs for short) driven by a standard (forward) stochastic integral $d W_{t}$ and a backward stochastic integral $d B_{t}$. The existence and the uniqueness of the solution for this type of BDSDEs is proved; for more details, please, we refer to Appendix A.2.

Let $f: \mathbb{R}^{d} \times \mathbb{R} \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d} \times \mathbb{R} \times \mathbb{R}^{d}\right) \rightarrow \mathbb{R}, g: \mathbb{R}^{d} \times \mathbb{R} \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d} \times \mathbb{R} \times \mathbb{R}^{d}\right) \rightarrow \mathbb{R}^{l}$, $h: \mathcal{P}_{2}\left(\mathbb{R}^{d} \times \mathbb{R} \times \mathbb{R}^{d}\right) \rightarrow \mathbb{R}^{l}$ and $\Phi: \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \rightarrow \mathbb{R}$ be deterministic and satisfy:
Assumption (H4.1) The functions $f, g, h$ and $\Phi$ are bounded and Lipschitz, i.e., there exist constants $C>0$, and $\alpha_{1}, \alpha_{2}>0$ with $0<\alpha_{1}+\alpha_{2}<1$ such that, for all $x, x^{\prime} \in \mathbb{R}^{d}, y, y^{\prime} \in \mathbb{R}$, $z, z^{\prime} \in \mathbb{R}^{d}, \mu, \mu^{\prime} \in \mathcal{P}_{2}\left(\mathbb{R}^{d+1} \times \mathbb{R}^{d}\right)$,
(i) $\left|f(x, y, z, \mu)-f\left(x^{\prime}, y^{\prime}, z^{\prime}, \mu^{\prime}\right)\right|+\left|h(\mu)-h\left(\mu^{\prime}\right)\right|+\left|\Phi(x, \mu)-\Phi\left(x^{\prime}, \mu^{\prime}\right)\right|$

$$
\leq C\left(\left|x-x^{\prime}\right|+\left|y-y^{\prime}\right|+\left|z-z^{\prime}\right|+W_{2}\left(\mu, \mu^{\prime}\right)\right),
$$

(ii) $\left|g(x, y, z, \mu)-g\left(x^{\prime}, y^{\prime}, z^{\prime}, \mu^{\prime}\right)\right|^{2} \leq C\left(\left|x-x^{\prime}\right|^{2}+\left|y-y^{\prime}\right|^{2}\right)+\alpha_{1}\left|z-z^{\prime}\right|^{2}+W_{2, C, \alpha_{2}}\left(\mu, \mu^{\prime}\right)^{2}$.

Given $x \in \mathbb{R}^{d}$ and $\xi \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right)$ we consider the following both BDSDEs:

where $\Pi_{s}^{t, \xi}:=\left(X_{s}^{t, \xi}, Y_{s}^{t, \xi}, Z_{s}^{t, \xi}\right), \Pi_{s}^{t, x, \xi}:=\left(X_{s}^{t, x, \xi}, Y_{s}^{t, x, \xi}, Z_{s}^{t, x, \xi}\right)$. Recall that the processes $X^{t, \xi}$ and $X^{t, x, \xi}$ are the solution of SDEs (3.1) and (3.2), respectively.

Under Assumption (H4.1) we know that from Theorem A. 1 in Appendix A. 2 that Eq.(4.1) has a unique solution $\left(Y^{t, \xi}, Z^{t, \xi}\right) \in \mathcal{S}_{\mathcal{F}}^{2}(t, T ; \mathbb{R}) \times \mathcal{H}_{\mathcal{F}}^{2}\left(t, T ; \mathbb{R}^{d}\right)$. On the other hand, once having the solution of (4.1), under Assumption (H4.1) BDSDE (4.2) becomes classical and possesses a unique solution $\left(Y^{t, x, \xi}, Z^{t, x, \xi}\right) \in \mathcal{S}_{\mathcal{F}}^{2}(t, T ; \mathbb{R}) \times \mathcal{H}_{\mathcal{F}}^{2}\left(t, T ; \mathbb{R}^{d}\right)$. Indeed, once we have got $\Pi_{\sim}^{t, \xi}:=$ $\left(X_{s}^{t, \xi}, Y_{s}^{t, \xi}, Z_{s}^{t, \xi}\right)$, we define $\widetilde{f}(s, y, z)=f\left(X_{s}^{t, x, \xi}, y, z, P_{\Pi_{s}^{t, \xi}}\right), \widetilde{g}(s, y, z)=g\left(X_{s}^{t, x, \xi}, y, z, P_{\Pi_{s}^{t, \xi}}\right), \widetilde{h}(s)=$
$h\left(P_{\Pi_{s}^{t, \xi}}\right), \widetilde{\xi}=\Phi\left(X_{T}^{t, x, \xi}, P_{\Pi_{T}^{t, \xi}}\right)$. Obviously, $\widetilde{f}, \widetilde{g}, \widetilde{h}$ and $\widetilde{\xi}$ satisfy all assumptions of classical BDSDEs, and hence, $\operatorname{BDSDE}$ (4.2) has a unique solution $\left(Y^{t, x, \xi}, Z^{t, x, \xi}\right) \in \mathcal{S}_{\mathcal{F}}^{2}(t, T ; \mathbb{R}) \times \mathcal{H}_{\mathcal{F}}^{2}\left(t, T ; \mathbb{R}^{d}\right)$.

From the flow property (3.5) and the uniqueness of the solution of (4.1) and (4.2) we have the following properties: For all $0 \leq t \leq s \leq T, x \in \mathbb{R}^{d}, \xi \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right)$,

Moreover, we have to show that the solution $\left(Y^{t, x, \xi}, Z^{t, x, \xi}\right)$ does not depend on $\xi$ itself but only on its law $P_{\xi}$.
Proposition 4.1. Suppose the Assumptions (H3.1) and (H4.1) hold true. Then, there is a constant $C>0$ only depending on the Lipschitz constants of $b, \sigma, f, g, h$ and $\Phi$, such that, for $t \in[0, T]$, $x, \widehat{x} \in \mathbb{R}^{d}, \xi, \widehat{\xi} \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right)$,
(i) $E\left[\sup _{s \in[t, T]}\left|Y_{s}^{t, x, \xi}\right|^{2}+\int_{t}^{T}\left|Z_{s}^{t, x, \xi}\right|^{2} d s \mid \mathcal{G}_{t}\right] \leq C ;$
(ii) $E\left[\sup _{s \in[t, T]}\left|Y_{s}^{t, x, \xi}-Y_{s}^{t, \widehat{x}, \widehat{\xi}}\right|^{2}+\int_{t}^{T}\left|Z_{s}^{t, x, \xi}-Z_{s}^{t, \widehat{x}, \widehat{\xi}}\right|^{2} d s \mid \mathcal{G}_{t}\right] \leq C_{p}\left(|x-\widehat{x}|^{2}+W_{2}\left(P_{\xi}, P_{\widehat{\xi}}\right)^{2}\right)$;
(iii) $\int_{t}^{T} W_{2}\left(P_{\Pi_{s}^{t, \xi}}, P_{\Pi_{s}^{t, \widehat{\xi}}}\right)^{2} d s \leq C W_{2}\left(P_{\xi}, P_{\widehat{\xi}}\right)^{2}$.

Proof. From Lemma A.1-(1) we get (i) directly. Now we prove (ii) and (iii).
Note that $\Pi^{t, x, \xi}$ is independent of $\mathcal{G}_{t}$ and, hence, of $\xi \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right)$. This allows to consider $\left.\Pi^{t, x, \xi}\right|_{x=\xi}$, and from the uniqueness of the solution of (4.1) and (4.2), it follows from (3.4) that $\Pi^{t, \xi}=\left.\Pi^{t, x, \xi}\right|_{x=\xi}$. Remark 4.1. As a matter of fact, in Assumption (H4.1), it is necessary to assume that the functions $f, g, h$ and $\Phi$ are Lipschitz. However, the boundedness condition can be replace by a linear growth condition. In other word, if the functions $f, g, h$ and $\Phi$ are Lipschitz and of linear growth, analogous arguments allow to show that Propositions 4.1 and 4.2 still hold true, respectively. On the other hand, notice that in fact $Y_{s}^{t, x, \xi}$ is $\mathcal{F}_{t, s}^{W} \vee \mathcal{F}_{s, T^{-}}^{B}$ measurable, $s \in[t, T]$.

Recalling that $\left(Y^{t, \xi}, Z^{t, \xi}\right)=\left.\left(Y^{t, x, \xi}, Z^{t, x, \xi}\right)\right|_{x=\xi}$ we have the following result.

Next, we recall that under natural conditions the solution of a BDSDE is differentiable w.r.t. the Brownian motion $W$ in Malliavin's sense and that the derivative is a solution of a linear BDSDE.

(ii) The derivatives $\partial_{x} \Phi: \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \rightarrow \mathbb{R}^{d},\left(\partial_{x}, \partial_{y}, \partial_{z}\right) f: \mathbb{R}^{d+1+d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d+1+d}\right) \rightarrow \mathbb{R}^{d+1+d}$, and $\left(\partial_{x}, \partial_{y}, \partial_{z}\right) g_{i}: \mathbb{R}^{d+1+d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d+1+d}\right) \rightarrow \mathbb{R}^{d+1+d}, 1 \leq i \leq l$, are bounded and Lipschitz continuous.

Therefore, combining (4.23), (4.24) and (4.25) with (ii) of Proposition 4.2, and applying Kolmogorov's continuity criterion, we get that $V\left(t, x, P_{\xi}\right)$ has a version continuous with respect to $(t, x)$.

Remark 4.3. (4.22) of Proposition 4.4 implies that for all fixed $\mu \in \mathcal{P}_{2}\left(\mathbb{R}^{d}\right), V(\cdot, \cdot, \mu)=\{V(t, x, \mu)$, $\left.(t, x) \in[0, T] \times \mathbb{R}^{d}\right\}$ admits a continuous version. As this conclusion is based on Kolmogorov's continuity criterion, and so on the finite-dimensionality of $[0, T] \times \mathbb{R}^{d}$, it cannot be extended to $(t, x, \mu) \rightarrow V(t, x, \mu)$.

## 5 First order derivatives of $X^{t, x, P_{\xi}}$

In this section we revisit the first order derivatives of $X^{t, x, P_{\xi}}$ with respect to $x$ and the measure $P_{\xi}$, studied by Buckdahn, Li, Peng and Rainer 4]. For the reader's convenience we give the main results here, for more details the reader is referred to [4], or to Hao and Li [12], where mean-field SDEs with jump are studied.
Assumption (H5.1) The couple of coefficients $(b, \sigma)$ belongs to $C_{b}^{1,1}\left(\mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) ; \mathbb{R}^{d} \times \mathbb{R}^{d \times d}\right)$, that is, the components $b_{j}, \sigma_{i, j}, 1 \leq i, j \leq d$, have the following properties:
(i) $b_{j}(x, \cdot), \sigma_{i, j}(x, \cdot)$ belong to $C_{b}^{1}\left(\mathcal{P}_{2}\left(\mathbb{R}^{d}\right)\right)$, for all $x \in \mathbb{R}^{d}$;
(ii) $b_{j}(\cdot, \mu), \sigma_{i, j}(\cdot, \mu)$ belong to $C_{b}^{1}\left(\mathbb{R}^{d}\right)$, for all $\mu \in \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$;
(iii) The derivatives $\partial_{x} b_{j}, \partial_{x} \sigma_{i, j}: \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \rightarrow \mathbb{R}^{d}$ and $\partial_{\mu} b_{j}, \partial_{\mu} \sigma_{i, j}: \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \times \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ are bounded and Lipschitz continuous.

We begin with recalling the first order derivative of $X^{t, x, P_{\xi}}$ with respect to $x$.
Theorem 5.1. Suppose Assumption (H5.1) holds true. Then the $L^{2}$-derivative of $X^{t, x, P_{\xi}}$ with respect to $x$ exists, it is denoted by $\partial_{x} X^{t, x, P_{\xi}}=\left(\partial_{x} X^{t, x, P_{\xi}, j}\right)_{1 \leq j \leq d}$, and it satisfies the following SDE: $s \in[t, T], 1 \leq i, j \leq d$,

For the proof the reader is referred to Theorem 3.1 in [4], and for the case with jumps also to Theorem 4.1 in 12 . From standard estimates for classical SDEs we have

For all $p \geq 2$, there exists a constant $C_{p}>0$ only depending on the Lipschitz constants of $\partial_{x} b$ and $\partial_{x} \sigma$, such that, for all $t \in[0, T], x, x^{\prime} \in \mathbb{R}^{d}, \xi, \xi^{\prime} \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right)$, P-a.s.,

Here $I_{d \times d}$ denotes the unit matrix in dimension d.
The following theorem shows that the unique solution $X^{t, x, \xi}$ of Eq. (3.2) interpreted as a functional of $\xi \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right)$ is Fréchet differentiable.

Theorem 5.2. Let $(b, \sigma)$ satisfy Assumption (H5.1). Then, for all $0 \leq t \leq s \leq T, x \in \mathbb{R}^{d}$, the lifted process $L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right) \ni \xi \rightarrow X_{s}^{t, x, \xi} \in L^{2}\left(\mathcal{G}_{s} ; \mathbb{R}^{d}\right)$ is Fréchet differentiable, and the Fréchet derivative is given by

(i) $E\left[\sup _{s \in[t, T]}\left(\left|U_{s}^{t, x, P_{\xi}}(y)\right|^{p}+\left|U_{s}^{t, \xi}(y)\right|^{p}\right)\right] \leq C_{p}$;
(ii) $E\left[\sup _{s \in[t, T]}\left|U_{s}^{t, x, P_{\xi}}(y)-U_{s}^{t, x^{\prime}, P_{\xi^{\prime}}}\left(y^{\prime}\right)\right|^{p}\right] \leq C_{p}\left(\left|x-x^{\prime}\right|^{p}+\left|y-y^{\prime}\right|^{p}+W_{2}\left(P_{\xi}, P_{\xi^{\prime}}\right)^{p}\right)$;

For the proof of Theorem 5.2 and Proposition 5.2 we refer the reader to Section 4 in 4], and for the case with jumps also to Section 4 in [12] (in the case of jumps we have $h$ instead of $h^{\frac{p}{2}}$ in (iii)).

Furthermore, the derivative of $X_{s}^{t, x, P_{\xi}}$ with respect to the probability measure can be defined as follows

Proposition 5.3. For all $p \geq 2$, there exists a constant $C_{p}>0$ only depending on the Lipschitz constants of $b$ and $\sigma$, such that, for all $t \in[0, T], x, x^{\prime}, y, y^{\prime} \in \mathbb{R}^{d}, \xi, \xi^{\prime} \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right)$, P-a.s.,
(i) $E\left[\sup _{s \in[t, T]}\left|\partial_{\mu} X_{s}^{t, x, P_{\xi}}(y)\right|^{p} \mid \mathcal{G}_{t}\right] \leq C_{p}$;
(ii) $E\left[\sup _{s \in[t, T]}\left|\partial_{\mu} X_{s}^{t, x, P_{\xi}}(y)-\partial_{\mu} X_{s}^{t, x^{\prime}, P_{\xi^{\prime}}}\left(y^{\prime}\right)\right|^{p} \mid \mathcal{G}_{t}\right] \leq C_{p}\left(\left|x-x^{\prime}\right|^{p}+\left|y-y^{\prime}\right|^{p}+W_{2}\left(P_{\xi}, P_{\xi^{\prime}}\right)^{p}\right)$;

## 6 First order derivatives of ( $\left.Y^{t, x, P_{\xi}}, Z^{t, x, P_{\xi}}\right)$

We recall from Proposition 4.2 that ( $Y^{t, x, P_{\xi},} Z^{t, x, P_{\xi}}$ ) depends on $\xi$ only through its law, which allows to define $\left(Y^{t, x, P_{\xi}}, Z^{t, x, P_{\xi}}\right):=\left(Y^{t, x, \xi}, Z^{t, x, \xi}\right)$. This section is devoted to the study of the first order derivatives of $\left(Y^{t, x, P_{\xi}}, Z^{t, x, P_{\xi}}\right)$ with respect to $x$ and $P_{\xi}$, respectively.

Assumption (H6.1) Let $\Phi \in C_{b}^{1,1}\left(\mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)\right), f \in C_{b}^{1,1}\left(\mathbb{R}^{d+1+d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d+1+d}\right)\right), g \in C_{b}^{1,1}\left(\mathbb{R}^{d+1+d} \times\right.$ $\left.\mathcal{P}_{2}\left(\mathbb{R}^{d+1+d}\right) ; \mathbb{R}^{l}\right)$ and $h \in C_{b}^{1}\left(\mathcal{P}_{2}\left(\mathbb{R}^{d+1+d}\right) ; \mathbb{R}^{l}\right)$. In addition we suppose Assumption (H4.1)-(ii).

Theorem 6.1. Under the Assumptions (H5.1) and (H6.1), the $L^{2}$-derivative of the solution of Eq. (4.2) with respect to $x,\left(\partial_{x} Y^{t, x, P_{\xi}}, \partial_{x} Z^{t, x, P_{\xi}}\right)$, exists and is the unique solution of the following BDSDE: $s \in[t, T], 1 \leq i \leq d$,

As the $L^{2}$-derivative of the coefficients $f\left(\Pi_{s}^{t, x, P_{\xi}}, P_{\Pi_{s}^{t, \xi}}\right)$ and $g\left(\Pi_{s}^{t, x, P_{\xi}}, P_{\Pi_{s}^{t, \xi}}\right)$ concern only $\Pi_{s}^{t, x, P_{\xi}}$ but not the law $P_{\Pi_{s}^{t, \xi}}$, the arguments of the proof are standard; the reader is referred, for instance, to [25].

From the standard estimates-Lemma A. 1 for classical BDSDEs, combined with Lemma 3.1, Proposition 4.2, Corollary 4.1 and Proposition 5.1, we have the following result (as for the estimate (ii) for $\left(\partial_{x} Y_{s}^{t, x, P_{\xi}}, \partial_{x} Z_{s}^{t, x, P_{\xi}}\right)$, the reader may also refer to the proof of Proposition 4.3).

Remark 6.1. In analogy to the proof in Proposition 4.1, it can easily be checked that under the Assumptions (H5.1) and (H6.1), there exists a constant $C>0$ only depending on the Lipschitz constants of the coefficients, such that for all $t \in[0, T], x, x^{\prime} \in \mathbb{R}^{d}, \xi, \xi^{\prime} \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right)$, P-a.s.,

So far, combining the Lemmas 6.1, 6.2 and 6.3. Theorem 6.2 has been proved. As shown in Section $5,\left(O^{t, x, P_{\xi}}, Q^{t, x, P_{\xi}}\right)$ is the derivative of $\left(Y^{t, x, P_{\xi}}, Z^{t, x, P_{\xi}}\right)$ with respect to the measure $P_{\xi}$, i.e., $\partial_{\mu} Y_{s}^{t, x, P_{\xi}}(y):=O_{s}^{t, x, P_{\xi}}(y), \partial_{\mu} Z_{s}^{t, x, P_{\xi}}(y):=Q_{s}^{t, x, P_{\xi}}(y)$. (i) $E\left[\sup _{s \in[t, T]}\left|\partial_{\mu} Y_{s}^{t, x, P_{\xi}}(y)\right|^{p}+\left(\int_{t}^{T}\left|\partial_{\mu} Z_{s}^{t, x, P_{\xi}}(y)\right|^{2} d s\right)^{\frac{p}{2}}\right] \leq C_{p}$,

## 7 Second order derivatives of $X^{t, x, P_{\xi}}$

In this section we investigate the second order derivatives of $X^{t, x, P_{\xi}}$. For this we use the following hypothesis.
Assumption (H7.1) The couple of coefficients $(b, \sigma)$ belongs to $C_{b}^{2,2}\left(\mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) ; \mathbb{R}^{d} \times \mathbb{R}^{d \times d}\right)$, that is, $(b, \sigma) \in C_{b}^{1,1}\left(\mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) ; \mathbb{R}^{d} \times \mathbb{R}^{d \times d}\right)$ [see Assumption (H5.1)] and the derivatives of the components $b_{j}, \sigma_{i, j}, 1 \leq i, j \leq d$, have the following properties:
(i) $\partial_{x_{k}} b_{i}(\cdot, \mu), \partial_{x_{k}} \sigma_{i, j}(\cdot, \mu) \in C_{b}^{1}\left(\mathbb{R}^{d}\right)$, for all $\mu \in \mathcal{P}_{2}\left(\mathbb{R}^{d}\right), 1 \leq k \leq d$;
(ii) $\partial_{\mu} b_{j}(x, \mu, \cdot), \partial_{\mu} \sigma_{i, j}(x, \mu, \cdot) \in C_{b}^{1}\left(\mathbb{R}^{d} \rightarrow \mathbb{R}^{d}\right)$, for all $x \in \mathbb{R}^{d}, \mu \in \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$;
(iii) All the derivatives of $b_{j}, \sigma_{i, j}$ up to order 2 are bounded and Lipschitz.

Theorem 7.1. Under Assumption (H7.1) the first order derivatives $x \rightarrow \partial_{x_{i}} X^{t, x, P_{\xi}}, \partial_{\mu} X^{t, x, P_{\xi}}(y) \in$ $\mathcal{S}_{\mathcal{G}}^{2}\left(t, T ; \mathbb{R}^{d}\right)$ are differentiable w.r.t. $x$ and $y$, respectively, and for

we have that, for all $p \geq 2$, there exists a constant $C_{p} \in \mathbb{R}_{+}$such that, for all $t \in[0, T], x, x^{\prime}, y, y^{\prime} \in$ $\mathbb{R}^{d}, \xi, \xi^{\prime} \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right), 1 \leq i, j \leq d$,
(i) $E\left[\sup _{s \in[t, T]}\left|M_{s, i, j}^{t, x, P_{\xi}}(y)\right|^{p}\right] \leq C_{p}$;
(ii) $E\left[\sup _{s \in[t, T]}\left|M_{s, i, j}^{t, x, P_{\xi}}(y)-M_{s, i, j}^{t, x^{\prime}, P_{\xi^{\prime}}}\left(y^{\prime}\right)\right|^{p}\right] \leq C_{p}\left(\left|x-x^{\prime}\right|^{p}+\left|y-y^{\prime}\right|^{p}+W_{2}\left(P_{\xi}, P_{\xi^{\prime}}\right)^{p}\right)$;
(iii) $E\left[\sup _{s \in[t, t+h]}\left|M_{s, i, j}^{t, x, P_{\xi}}(y)\right|^{p}\right] \leq C_{p} h^{\frac{p}{2}}, 0 \leq t \leq t+h \leq T$.

For the proof we refer to Section 5 in [4], or Proposition 5.1 in [12].
We now recall that the first order derivative $\partial_{x} X^{t, x, P_{\xi}}$ is differentiable in Malliavin's sense and that the derivative is a solution of a linear SDE.

Proposition 7.1. Let Assumption (H7.1) hold true. Then for all $(t, x) \in[0, T] \times \mathbb{R}^{d}, \xi \in$ $L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right), s \in[t, T], 1 \leq k \leq d$, the first order derivative $\partial_{x_{k}} X^{t, x, P_{\xi}} \in\left(\mathbb{D}^{1,2}\right)^{d}$ and a version of $\left\{D_{\theta}\left[\partial_{x_{k}} X_{s}^{t, x, P_{\xi}}\right]: \theta, s \in[t, T]\right\}$ is given by:
(i) $D_{\theta}\left[\partial_{x_{k}} X_{s}^{t, x, P_{\xi}}\right]=0$, if $\theta>s$;
(ii) $\left\{D_{\theta}\left[\partial_{x_{k}} X^{\left.t, x, P_{\xi}\right]}=\left(D_{\theta}^{i}\left[\partial_{x_{k}} X^{\left.t, x, P_{\xi}, j\right]}\right)_{1 \leq i, j \leq d}: s \in[\theta, T]\right\}\right.\right.$ is the unique solution of the linear $S D E$

Proof. It is standard to prove that $\partial_{x} X_{s}^{t, x, P_{\xi}}$ has a Malliavin derivative $D_{\theta}\left[\partial_{x} X_{s}^{t, x, P_{\xi}}\right]$ under our assumptions, and $D_{\theta}\left[\partial_{x} X_{s}^{t, x, P_{\xi}}\right]$ satisfies $\operatorname{SDE}(7.2)$. So we omit proving this here. Moreover, with the help of Lemma 3.1, the Propositions 3.1 and 5.1 as well as standard estimates for classical SDEs it can easily be verified that (7.3) holds true.

## 8 Second order derivatives of ( $\left.Y^{t, x, P_{\xi}}, Z^{t, x, P_{\xi}}\right)$

This section is devoted to the study of second order derivatives of $\left(Y^{t, x, P_{\xi}}, Z^{t, x, P_{\xi}}\right)$.
Assumption (H8.1) Let $\Phi \in C_{b}^{2,2}\left(\mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)\right), f \in C_{b}^{2,2}\left(\mathbb{R}^{d+1+d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d+1+d}\right)\right)$ and $h \in$ $C_{b}^{2}\left(\mathcal{P}_{2}\left(\mathbb{R}^{d+1+d}\right) ; \mathbb{R}^{l}\right)$.

First we recall that under natural conditions the first order derivative ( $\partial_{x} Y^{t, x, P_{\xi}}, \partial_{x} Z^{t, x, P_{\xi}}$ ) is differentiable w.r.t. the Brownian motion $W$ in Malliavin's sense and that the derivative is a solution of a linear BDSDE. For this we need an additional assumption on $g$.
Assumption (H8.2) The coefficient $g$ is affine in $z$ : For all $x \in \mathbb{R}^{d}, y \in \mathbb{R}, z \in \mathbb{R}^{d}, \mu \in$ $\mathcal{P}_{2}\left(\mathbb{R}^{d+1} \times \mathbb{R}^{d}\right)$,

where $g^{1} \in C_{b}^{2,2}\left(\mathbb{R}^{d+1} \times \mathcal{P}_{2}\left(\mathbb{R}^{d+1+d}\right) ; \mathbb{R}^{l}\right)$ and $g^{2} \in C_{b}^{2}\left(\mathcal{P}_{2}\left(\mathbb{R}^{d}\right) ; \mathbb{R}^{l}\right)$. In addition we suppose $\left|g^{2}\right|^{2} \leq$ $\alpha_{1}, \sum_{k=1}^{d} \sum_{i=1}^{l}\left|\left(\partial_{\mu} g_{i}^{1}\right)_{d+1+k}\right|^{2} \leq \alpha_{2}$, where constants $\alpha_{1}, \alpha_{2}>0$ with $0<\alpha_{1}+\alpha_{2}<1$.

Remark 8.1. In order to understand better why we need Assumption (H8.2), consider for $d=l=1$ and for the functions $\Phi, g \in C_{b}^{2}(\mathbb{R})$ with $\left|\partial_{z} g\right|^{2} \leq \alpha_{1}$, the BDSDE

Moreover, there is some constant $C_{p}>0$ only depending on the bounds and the Lipschitz constants of the coefficients $b, \sigma, f, g, h, \Phi$ and their first and second order derivatives, such that, for all $t \in[0, T], x, x^{\prime} \in \mathbb{R}^{d}, \xi, \xi^{\prime} \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right)$,

## 9 Related backward SPDEs of mean-field type

If we tried now to translate the approach of Pardoux and Peng [25] to our setting, in order to prove that $V$ is a classical solution of SPDE (9.1), we should show that $V(t, \cdot, \cdot) \in C_{b}^{2,2}\left(\mathbb{R}^{d} \times\right.$ $\mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$ ). However, in [25] Kolmogorov's continuity criterion played a crucial role for the proof. Here, in our mean-field context we meet the problem that $\left(t, x, P_{\xi}\right) \in[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$ runs an infinite dimensional space which excludes the application of Kolmogorov's continuity criterion. The consequence is that we have to content with the continuity and differentiability of first and second order derivatives of $V(t, \cdot, \cdot)$ in the only $L^{2}$-sense. However, we can make the following observation.

Lemma 9.1. Let $\varphi: \Omega \times \mathbb{R}^{d} \rightarrow \mathbb{R}$ be $\mathcal{F} \otimes \mathcal{B}\left(\mathbb{R}^{d}\right)$-measurable and $x \rightarrow \varphi(\cdot, x) L^{2}$-differentiable. Then, for all $\eta \in L^{\infty}(\mathcal{F} ; \mathbb{R})$, the deterministic function $\Psi(x):=E[\varphi(\cdot, x) \cdot \eta], x \in \mathbb{R}^{d}$, is differentiable w.r.t. $x$ on $\mathbb{R}^{d}$, and $\partial_{x} \Psi(x)=E\left[\partial_{x} \varphi(\cdot, x) \cdot \eta\right], x \in \mathbb{R}^{d}$, where $\partial_{x} \varphi(x)$ denotes the $L^{2}$-derivative of $\varphi(\cdot, \cdot)$ at $x$.

As the expectation $E[\cdot]: L^{2}(\mathcal{F}) \rightarrow \mathbb{R}$ is a bounded linear operator, it follows from Proposition A. 3 that $L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}\right) \ni \xi \rightarrow \widetilde{\Psi}(t, x, \xi):=\Psi\left(t, x, P_{\xi}\right)=E\left[V\left(t, x, P_{\xi}\right) \cdot \eta\right]$ is Fréchet differentiable and, for all $\zeta \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}\right)$,

We say that random field $\varphi$ belongs to $\mathfrak{C}^{0,2,2}\left(\Omega \times[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)\right)$, if $\varphi$ : $\Omega \times[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \rightarrow \mathbb{R}$ satisfies:
(i) $\varphi(t, x, \mu)$ is $\mathcal{F}_{t, T}^{B}$-measurable, $(t, x, \mu) \in[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$;
(ii) $x \rightarrow \varphi(t, x, \mu)$ is twice continuously $L^{2}$-differentiable;
(iii) $\mu \rightarrow \varphi(t, x, \mu)$ is differentiable;
(iv) $y \rightarrow \partial_{\mu} \varphi(t, x, \mu, y)$ is continuously $L^{2}$-differentiable;
(v) The first and second order derivatives are $L^{2}$-continuous on $[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right) \times \mathbb{R}^{d}$;
(vi) $\Gamma \in C_{b}^{0,2,2}\left([0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)\right)$ [see Definition [2.2), where $\Gamma(t, x, \mu):=E[\varphi(t, x, \mu) \cdot \eta]$, for all $\eta \in L^{\infty}\left(\mathcal{F}_{0, T}^{B} ; \mathbb{R}\right)$ satisfying (H9.1), and all $(t, x, \mu) \in[0, T] \times \mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$.

Now we are able to establish and to prove our main result.
Theorem 9.1. Under the Assumptions (H4.2), (H7.1), (H8.1) and (H8.2), $V \in \mathfrak{C}^{0,2,2}(\Omega \times[0, T] \times$ $\mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)$ ) is a classical solution of backward SPDE (9.1), and it is unique in $\mathfrak{C}^{0,2,2}(\Omega \times[0, T] \times$ $\left.\mathbb{R}^{d} \times \mathcal{P}_{2}\left(\mathbb{R}^{d}\right)\right)$.

Proof. For simplicity of redaction but without loss of generality, let us restrict to the dimensions $d=1, l=1$, and to the coefficients $b=0, f=0, g^{1}=0, h\left(P_{\Pi_{s}^{t, \xi}}\right)=h\left(P_{X_{s}^{t, \xi}}\right), \Phi(x, \mu)=\Phi(x)$.

We prove that $V\left(t, x, P_{\xi}\right)$ is a solution of (9.1). Let $\eta \in L^{\infty}\left(\mathcal{F}_{0, T}^{B} ; \mathbb{R}\right)$ be such that (H9.1) holds true, and $s \rightarrow \theta_{s}^{\eta}$ is continuous. It follows from the Propositions A.2, A.3 and 9.2 and the Theorems 8.1 and 8.2 that $V \in \mathfrak{C}^{0,2,2}\left(\Omega \times[0, T] \times \mathbb{R} \times \mathcal{P}_{2}(\mathbb{R})\right)$. The general case with $f$ and dimensions $d \geq 1$, $l \geq 1$ can be obtained by a straight-forward extension.
Step 1. Firstly, we consider the special case $F(s, x, \mu)=G(\mu),(s, x, \mu) \in[0, T] \times \mathbb{R} \times \mathcal{P}_{2}(\mathbb{R})$. For this we consider the solution $(Y, Z)$ of the BDSDE $Y_{t}=\xi+\int_{t}^{T} g_{s} d \overleftarrow{B_{s}}-\int_{t}^{T} Z_{s} d W_{s}, t \in[0, T]$, for $\xi \in L^{2}\left(\mathcal{F}_{T} ; \mathbb{R}\right)$ and $g \in \mathcal{H}_{\mathcal{F}}^{2}(0, T ; \mathbb{R})$, where $g$ and $\xi$ are bounded by a positive constant $C$.

for $\eta \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}\right)$, where for all $y \in \mathbb{R},\left(\partial_{\mu} Y_{r}^{t, x, P_{\xi}}(y), \partial_{\mu} Z_{r}^{t, x, P_{\xi}}(y)\right) \in \mathcal{S}_{\mathcal{F}}^{2}(t, T ; \mathbb{R}) \times \mathcal{H}_{\mathcal{F}}^{2}(t, T ; \mathbb{R})$ is the unique solution of the following BDSDE:

Furthermore, if in addition Assumption (H4.2) is satisfied, then there is a constant $C_{p}>0$ only depending on the Lipschitz constants of the coefficients, such that, for all $t \in[0, T], x, x^{\prime}, y, y^{\prime} \in \mathbb{R}$, $\xi, \xi^{\prime} \in L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}\right), P$-a.s.,
(i) $E\left[\sup _{s \in[t, T]}\left|\partial_{\mu} Y_{s}^{t, x, P_{\xi}}(y)\right|^{p}+\left(\int_{t}^{T}\left|\partial_{\mu} Z_{s}^{t, x, P_{\xi}}(y)\right|^{2} d s\right)^{\frac{p}{2}}\right] \leq C_{p}$, for all $p \in\left[2, p_{0}\right]$,

Using (A.33) and (A.37), the proof is similar to that of Theorem 6.2 and Proposition 6.2, and so we omit it here.

Remark A.3. In analogy to the proof in Proposition 4.1, it can easily be checked that under the Assumptions (H5.1) and (H10.4) but without (H4.2), there exists a constant $C>0$ only depending on the Lipschitz constants of the coefficients, such that for all $t \in[0, T], x, x^{\prime}, y, y^{\prime} \in \mathbb{R}^{d}, \xi, \xi^{\prime} \in$ $L^{2}\left(\mathcal{G}_{t} ; \mathbb{R}^{d}\right), P$-a.s.,

E\left[\sup _{s \in[t, T]}\left|\partial_{\mu} Y_{s}^{t, x, P_{\xi}}(y)\right|^{2}+\int_{t}^{T}\left|\partial_{\mu} Z_{s}^{t, x, P_{\xi}}(y)\right|^{2} d s\right] \leq C
$$
