# Spectral radius and $[a, b]$-factors in graphs *

#### Abstract

An $[a, b]$-factor of a graph $G$ is a spanning subgraph $H$ such that $a \leq$ $d_{H}(v) \leq b$ for each $v \in V(G)$. In this paper, we provide spectral conditions for the existence of an odd $[1, b]$-factor in a connected graph with minimum degree $\delta$ and the existence of an $[a, b]$-factor in a graph, respectively. Our results generalize and improve some previous results on perfect matchings of graphs. For $a=1$, we extend the result of O [30] to obtain an odd [1, b]-factor and further improve the result of Liu, Liu and Feng [27] for $a=b=1$. For $n \geq 3 a+b-1$, we confirm the conjecture of Cho, Hyun, O and Park [6]. We conclude some open problems in the end.

## 1 Introduction

The study of factors from graph eigenvalues has a rich history. In 2005, Brouwer and Haemers [3] described a regular graph to contain a perfect matching in terms of the third largest eigenvalue. Their result was improved in [8-10] and extended in [22,23] to obtain a regular factor. Very recently, O [30] provided a spectral condition to guarantee the existence of a perfect matching in a graph. One problem concerning perfect matching which has attracted considerable interest is that of determining the structure of graphs with a unique perfect matching [5,32,35]. Yang and Ye [37] characterized all bipartite graphs with a unique perfect matching whose adjacency

[^0]matrices have inverses diagonally similar to non-negative matrices, which settles an open problem of Godsil on inverses of bipartite graphs in [14]. Lovász [26] proved that a graph of order $n$ with a unique perfect matching cannot have more than $\frac{n^{2}}{4}$ edges. Based on the structural properties of graphs with a unique perfect matching, in this paper, we first determine the graph attaining the maximum spectral radius among all graphs of order $2 n$ with a unique perfect matching.

Let $G$ be a graph with adjacency matrix $A(G)$. The largest eigenvalue of $A(G)$, denoted by $\rho(G)$, is called the spectral radius of $G$. Denote by ' $\nabla{ }^{\prime}$ and ' $\cup$ ' the join and union products, respectively. Suppose that $G_{1}$ is an empty graph with vertex set $U=\left\{u_{1}, u_{2}, \ldots, u_{n}\right\}$, and $G_{2}$ is a complete graph with vertex set $W=$ $\left\{w_{1}, w_{2}, \ldots, w_{n}\right\}$. Let $G(2 n, 1)$ be the graph of order $2 n$ obtained from $G_{1} \cup G_{2}$ by letting $N_{G_{2}}\left(u_{i}\right)=\left\{w_{1}, w_{2}, \ldots, w_{i}\right\}$ for $1 \leq i \leq n$. Clearly, $G(2 n, 1)$ contains a unique perfect matching.

Theorem 1.1. If $G$ is a connected graph of order $2 n$ with a unique perfect matching, then $\rho(G) \leq \rho(G(2 n, 1))$, with equality if and only if $G \cong G(2 n, 1)$.

Another problem concerning perfect matching is extending it to a general factor. An odd [1,b]-factor of a graph $G$ is a spanning subgraph $H$ such that $d_{H}(v)$ is odd and $1 \leq d_{H}(v) \leq b$ for each $v \in V(G)$. Lu, Wu and Yang [20] gave a sufficient condition for the existence of an odd $[1, b]$-factor in a graph in terms of the third largest eigenvalue. Recently, Kim, O, Park and Ree [19] improved the spectral condition of $\mathrm{Lu}, \mathrm{Wu}$ and Yang. In this paper, we generalize their result by giving a spectral condition to guarantee the existence of an odd $[1, b]$-factor with minimum degree $\delta$. Let $T(n, b, \delta)=K_{\delta} \nabla\left(K_{n-(b+1) \delta-1} \cup(b \delta+1) K_{1}\right)$ and $F(b, \delta)=\max \{4(b+$ 1) $\left.\delta+4, b \delta^{3}+\delta\right\}$, where $b$ is a positive odd integer.

Theorem 1.2. Suppose that $G$ is a connected graph of even order $n \geq F(b, \delta)$ with minimum degree $\delta$. If $\rho(G) \geq \rho(T(n, b, \delta))$, then $G$ contains an odd $[1, b]$-factor, unless $G \cong T(n, b, \delta)$.

An $[a, b]$-factor of a graph $G$ is a spanning subgraph $H$ such that $a \leq d_{H}(v) \leq b$ for each $v \in V(G)$. In the past decades, some researchers provided various parameter conditions for a graph to have an [a,b]-factor, such as the degree condition [28], the neighborhood condition [25], the stability number [17], and the binding number [7]. In addition, the conditions for a graph to have a fractional $[a, b]$-factor (see [34] for the definition) was also investigated by several researchers [11, 18, 21]. Only very recently, Cho, Hyun, O and Park [6] posed a conjecture regarding the spectral condition for the existence of an $[a, b]$-factor as follows.

Conjecture 1.1. (See [6]) Let $a \cdot n$ be an even integer at least 2, where $n \geq a+1$. If $G$ is a graph of order $n$ with $\rho(G)>\rho\left(H_{n, a}\right)$ where $H_{n, a}=K_{a-1} \nabla\left(K_{1} \cup K_{n-a}\right)$, then $G$ contains an $[a, b]$-factor.

In this paper, we confirm Conjecture 1.1 for $n \geq 3 a+b-1$.

Theorem 1.3. Let $a \cdot n$ be an even integer, where $n \geq 3 a+b-1$ and $b \geq a \geq 1$. If $\rho(G)>\rho\left(H_{n, a}\right)$, then $G$ contains an $[a, b]$-factor.

A $[k, k]$-factor is called a $k$-factor. As a corollary of Theorem 1.3, we have the following result.

Corollary 1.1. Let $k \cdot n$ be an even integer, where $n \geq 4 k-1$. If $\rho(G)>\rho\left(H_{n, k}\right)$, then $G$ contains a $k$-factor.

## 2 Proof of Theorem 1.1

If $G$ is connected, then $A(G)$ is irreducible. By the Perron-Frobenius theorem(cf. [15, Section 8.8]), the Perron vector $x$ is a positive eigenvector of $A(G)$ respect to $\rho(G)$. For any $v \in V(G)$, let $N_{G}(v)$ and $d_{G}(v)$ be the neighborhood and degree of $v$, respectively. In this section, we give the proof of Theorem 1.1. Before proceeding, the following lemmas are needed.

Lemma 2.1. (See [24]) Let $G$ be a connected graph, and let $u, v$ be two vertices of $G$. Suppose that $v_{1}, v_{2}, \ldots, v_{s} \in N_{G}(v) \backslash N_{G}(u)$ with $s \geq 1$, and $G^{*}$ is the graph obtained from $G$ by deleting the edges $v v_{i}$ and adding the edges $u v_{i}$ for $1 \leq i \leq s$. Let $x$ be the Perron vector of $A(G)$. If $x_{u} \geq x_{v}$, then $\rho(G)<\rho\left(G^{*}\right)$.

An edge is said to be a cut edge if its removal increases the number of components of a graph.

Lemma 2.2. (See [16]) Let $G$ be a connected graph with a unique perfect matching. Then $G$ contains a cut edge uv that is an edge of the perfect matching of $G$.

Lemma 2.3. (See [2]) If $u$ and $v$ are two nonadjacent vertices of graph $G$, then $\rho(G+u v)>\rho(G)$.

For any $S \subseteq V(G)$, let $G[S]$ be the subgraph of $G$ induced by $S$. An edge of a graph is called pendant edge if exactly one of its ends has the degree 1 . We now give a short proof of Theorem 1.1.

Proof of Theorem 1.1. Suppose that $G$ is a connected graph of order $2 n$ with a unique perfect matching $M$. By Lemma 2.2 , there exists a cut edge, say $u_{0} v_{0}$, that is contained in $M$. Observe that $G-u_{0} v_{0}$ consists of two odd components. Let $x^{(0)}$ be the Perron vector of $A(G)$. Without loss of generality, we assume that $x_{u_{0}}^{(0)} \geq x_{v_{0}}^{(0)}$. Let

$$
G_{1}=G-\sum_{w \in N_{G}\left(v_{0}\right) \backslash\left\{u_{0}\right\}} v_{0} w+\sum_{w \in V(G) \backslash\left(N\left(u_{0}\right) \cup\left\{u_{0}\right\}\right)} u_{0} w .
$$

We see that $G_{1}$ also has a unique perfect matching, say $M_{1}$. By Lemmas 2.1 and 2.3, we have $\rho(G) \leq \rho\left(G_{1}\right)$, with equality if and only if $G \cong G_{1}$. Let $S_{1}=V\left(G_{1}\right)-$ $\left\{u_{0}, v_{0}\right\}$. Since $u_{0} v_{0}$ is a pendant edge of $G_{1}$ that is contained in $M_{1}$, the induced
subgraph $G_{1}\left[S_{1}\right]$ also contains a unique perfect matching, i.e., $M_{1} \backslash\left\{u_{0} v_{0}\right\}$. Again by Lemma 2.2, there exists a cut edge $u_{1} v_{1}$ in $G_{1}\left[S_{1}\right]$ that is contained in $M_{1} \backslash\left\{u_{0} v_{0}\right\}$. Let $x^{(1)}$ be the Perron vector of $A\left(G_{1}\right)$. Assume that $x_{u_{1}}^{(1)} \geq x_{v_{1}}^{(1)}$. Let

$$
G_{2}=G_{1}-\sum_{w \in N_{G_{1}\left[S_{1}\right]}\left(v_{1}\right) \backslash\left\{u_{1}\right\}} v_{1} w+\sum_{w \in S_{1} \backslash\left(N\left(u_{1}\right) \cup\left\{u_{1}\right\}\right)} u_{1} w .
$$

Clearly, $G_{2}$ also has a unique perfect matching. Again by Lemmas 2.1 and 2.3, $\rho\left(G_{1}\right) \leq \rho\left(G_{2}\right)$, where the equality holds if and only if $G_{1} \cong G_{2}$. By repeating this procedure, we can construct a sequence of graphs $G_{0}, G_{1}, G_{2}, \cdots, G_{n-1}$ :
(i) $G_{0}=G$;
(ii) for $i \in[0, n-2]$, let $S_{i}=V\left(G_{i}\right)-\left\{v_{0}, v_{1}, \ldots, v_{i-1}, u_{0}, u_{1}, \ldots, u_{i-1}\right\}$ and

$$
G_{i+1}=G_{i}-\sum_{w \in N_{G_{i}}\left[S_{i}\right]\left(v_{i}\right) \backslash\left\{u_{i}\right\}} v_{i} w+\sum_{w \in S_{i} \backslash\left(N\left(u_{i}\right) \cup\left\{u_{i}\right\}\right)} u_{i} w,
$$

where $u_{i} v_{i}$ is a cut edge of $G_{i}\left[S_{i}\right]$ that is contained in the unique perfect matching of $G_{i}\left[S_{i}\right]$ and $x_{v_{i}}^{(i)} \leq x_{u_{i}}^{(i)}$, where $x^{(i)}$ is the Perron vector of $A\left(G_{i}\right)$.

As above, we see that $G_{i}$ has a unique perfect matching for each $i$, and $\rho\left(G_{i}\right) \leq$ $\rho\left(G_{i+1}\right)$ with equality if and only if $G_{i} \cong G_{i+1}(0 \leq i \leq n-2)$. Note that $G_{n-1} \cong$ $G(2 n, 1)$. Thus we conclude that $\rho(G) \leq \rho(G(2 n, 1))$, where the equality holds if and only if $G \cong G(2 n, 1)$.

We complete the proof.

## 3 Proof of Theorem 1.2

The well-known sufficient and necessary condition for the existence of an odd $[1, b]$ factor established by Amahashi [1].

Lemma 3.1. (See [1]) Let $G$ be a graph and let b be a positive odd integer. Then $G$ contains an odd $[1, b]$-factor if and only if for every subset $S \subseteq V(G)$,

$$
o(G-S) \leq b|S|
$$

where $o(H)$ is the number of odd components in a graph $H$.
Lemma 3.2. (See [12]) Let $n=\sum_{i=1}^{t} n_{i}+s$. If $n_{1} \geq n_{2} \geq \cdots \geq n_{t} \geq p$ and $n_{1}<n-s-p(t-1)$, then

$$
\rho\left(K_{s} \nabla\left(K_{n_{1}} \cup K_{n_{2}} \cup \cdots \cup K_{n_{t}}\right)\right)<\rho\left(K_{s} \nabla\left(K_{n-s-p(t-1)} \cup(t-1) K_{p}\right)\right) .
$$

Now we shall give the proof of Theorem 1.2.

Proof of Theorem 1.2. Suppose that $G$ contains no odd $[1, b]$-factor, by Lemma 3.1, there exists some nonempty subset $S$ of $V(G)$ such that $q=o(G-S)>b|S|$. Since $n$ is even, $q$ and $b|S|$ have the same parity, we have $q \geq b|S|+2$. Let $|S|=s$ and $t=b s+2$. Then $G$ is a spanning subgraph of $G_{s}^{1}=K_{s} \nabla\left(K_{n_{1}} \cup K_{n_{2}} \cup \cdots \cup K_{n_{t}}\right)$ for some positive odd integers $n_{1} \geq n_{2} \geq \cdots \geq n_{t}$ with $\sum_{i=1}^{t} n_{i}=n-s$. Thus,

$$
\begin{equation*}
\rho(G) \leq \rho\left(G_{s}^{1}\right) \tag{1}
\end{equation*}
$$

where the equality holds if and only if $G \cong G_{s}^{1}$. Note that the graph $G_{s}^{1}$ contains no odd $[1, b]$-factor. Then we shall derive the proof into the following three cases.

Case 1. $s \geq \delta+1$.
Let $G_{s}^{2}=K_{s} \nabla\left(K_{n-s-t+1} \cup(t-1) K_{1}\right)$. Note that $s \geq \delta+1$ and $t=b s+2$. Then by Lemma 3.2, we have

$$
\begin{equation*}
\rho\left(G_{s}^{1}\right) \leq \rho\left(G_{s}^{2}\right) \tag{2}
\end{equation*}
$$

with equality if and only if $\left(n_{1}, \ldots, n_{t}\right)=(n-s-t+1,1, \ldots, 1)$. The vertex set of $G_{s}^{2}$ can be partitioned as $V\left(G_{s}^{2}\right)=V\left(K_{s}\right) \cup V\left((b s+1) K_{1}\right) \cup V\left(K_{n-(b+1) s-1}\right)$, where $V\left(K_{s}\right)=\left\{v_{1}, \ldots, v_{s}\right\}, V\left((b s+1) K_{1}\right)=\left\{u_{1}, \ldots, u_{b s+1}\right\}$ and $V\left(K_{n-(b+1) s-1}\right)=$ $\left\{w_{1}, \ldots, w_{n-(b+1) s-1}\right\}$. Let

$$
G_{s}^{\prime}=G_{s}^{2}+\sum_{i=b \delta+2}^{b s+1} \sum_{j=1}^{n-(b+1) s-1} u_{i} w_{j}+\sum_{i=b \delta+2}^{b s} \sum_{j=i+1}^{b s+1} u_{i} u_{j}-\sum_{i=\delta+1}^{s} \sum_{j=1}^{b \delta+1} v_{i} u_{j} .
$$

Clearly, $G_{s}^{\prime} \cong K_{\delta} \nabla\left(K_{n-(b+1) \delta-1} \cup(b \delta+1) K_{1}\right)$. Let $x$ be the Perron vector of $A\left(G_{s}^{2}\right)$ with respect to $\rho=\rho\left(G_{s}^{2}\right)$. By symmetry, $x$ takes the same value (say $x_{1}, x_{2}$ and $x_{3}$ ) on the vertices of $V\left(K_{s}\right), V\left((b s+1) K_{1}\right)$ and $V\left(K_{n-(b+1) s-1)}\right)$, respectively. Then, by $A\left(G_{s}^{2}\right) x=\rho x$, we have

$$
\begin{aligned}
\rho x_{2} & =s x_{1} \\
\rho x_{3} & =s x_{1}+(n-(b+1) s-2) x_{3}
\end{aligned}
$$

Note that $n \geq s+t=(b+1) s+2$. Then $x_{3} \geq x_{2}$ and

$$
\begin{equation*}
x_{2}=\frac{s x_{1}}{\rho} \tag{3}
\end{equation*}
$$

Similarly, let $y$ be the Perron vector of $A\left(G_{s}^{\prime}\right)$ corresponding to $\rho\left(G_{s}^{\prime}\right)=\rho^{\prime}$. By symmetry, $y$ takes the same values $y_{1}, y_{2}$ and $y_{3}$ on the vertices of $V\left(K_{\delta}\right), V((b \delta+$ 1) $K_{1}$ ) and $V\left(K_{n-(b+1) \delta-1}\right)$, respectively. Then, by $A\left(G_{s}^{\prime}\right) y=\rho^{\prime} y$, we obtain

$$
\begin{align*}
\rho^{\prime} y_{2} & =\delta y_{1}  \tag{4}\\
\rho^{\prime} y_{3} & =\delta y_{1}+(n-(b+1) \delta-2) y_{3} \tag{5}
\end{align*}
$$

Note that $G_{s}^{\prime}$ contains $K_{n-(b+1) \delta-1} \cup K_{\delta} \cup(b \delta+1) K_{1}$ as a proper spanning subgraph. Then $\rho^{\prime}>\rho\left(K_{n-(b+1) \delta-1} \cup K_{\delta} \cup(b \delta+1) K_{1}\right)=n-(b+1) \delta-2$. Putting (4) into (5), and considering that $\rho^{\prime}>n-(b+1) \delta-2$, we have

$$
\begin{equation*}
y_{3}=\frac{\rho^{\prime} y_{2}}{\rho^{\prime}-(n-(b+1) \delta-2)} . \tag{6}
\end{equation*}
$$

Recall that $n \geq(b+1) s+2$. Then $\delta+1 \leq s \leq(n-2) /(b+1)$. Since $G_{s}^{2}$ is not a regular graph, it follows that $\rho<n-1$. Suppose to the contrary that $\rho \geq \rho^{\prime}$. Combining this with (3) and (6) yields that

$$
\begin{aligned}
& y^{T}\left(\rho^{\prime}-\rho\right) x \\
& =y^{T}\left(A\left(G_{s}^{\prime}\right)-A\left(G_{s}^{2}\right)\right) x \\
& =\sum_{i=b \delta+2}^{b s+1} \sum_{j=1}^{n-(b+1) s-1}\left(x_{u_{i}} y_{w_{j}}+x_{w_{j}} y_{u_{i}}\right)+\sum_{i=b \delta+2}^{b s} \sum_{j=i+1}^{b s+1}\left(x_{u_{i}} y_{u_{j}}+x_{u_{j}} y_{u_{i}}\right)-\sum_{i=\delta+1}^{s} \sum_{j=1}^{b \delta+1}\left(x_{v_{i}} y_{u_{j}}+x_{u_{j}} y_{v_{i}}\right) \\
& =(s-\delta)\left[b(n-(b+1) s-1)\left(x_{2} y_{3}+x_{3} y_{3}\right)+b(b s-b \delta-1) x_{2} y_{3}-(b \delta+1)\left(x_{1} y_{2}+x_{2} y_{3}\right)\right] \\
& =(s-\delta)\left[(b(n-(b+1) \delta-s-2)-1) x_{2} y_{3}+b(n-(b+1) s-1) x_{3} y_{3}-(b \delta+1) x_{1} y_{2}\right] \\
& \geq(s-\delta)\left[b(n-(b+1) \delta-s-2) x_{2} y_{3}-(b \delta+1) x_{1} y_{2}\right]\left(\text { since } x_{3} \geq x_{2} \text { and } n \geq(b+1) s+2\right) \\
& \geq(s-\delta)\left[b\left(n-(b+1) \delta-\frac{n-2}{b+1}-2\right) x_{2} y_{3}-(b \delta+1) x_{1} y_{2}\right] \quad\left(\text { since } s \leq \frac{n-2}{b+1}\right) \\
& =(s-\delta) x_{1} y_{2}\left(\frac{b s \rho^{\prime}\left(n-(b+1) \delta-\frac{n-2}{b+1}-2\right)}{\rho\left(\rho^{\prime}-(n-(b+1) \delta-2)\right)}-(b \delta+1)\right) \\
& \geq \frac{(b \delta+1)(s-\delta) x_{1} y_{2}}{\rho\left(\rho^{\prime}-(n-(b+1) \delta-2)\right)}\left[\rho^{\prime}\left(n-(b+1) \delta-\frac{n-2}{b+1}-2\right)-\rho\left(\rho^{\prime}-(n-(b+1) \delta-2)\right)\right]
\end{aligned}
$$

(since $s \geq \delta+1$ and $b \geq 1$ )
$\geq \frac{(b \delta+1)(s-\delta) x_{1} y_{2}}{\rho\left(\rho^{\prime}-(n-(b+1) \delta-2)\right)}\left(\rho^{\prime}\left(2 n-2(b+1) \delta-\frac{n-2}{b+1}-4\right)-\rho \rho^{\prime}\right) \quad\left(\right.$ since $\left.\rho \geq \rho^{\prime}\right)$
$\geq \frac{(b \delta+1)(s-\delta) \rho^{\prime}\left(\frac{3 n}{2}-2(b+1) \delta-3-\rho\right) x_{1} y_{2}}{\rho\left(\rho^{\prime}-(n-(b+1) \delta-2)\right)} \quad($ since $b \geq 1)$
$\geq \frac{(b \delta+1)(s-\delta) \rho^{\prime}(n-1-\rho) x_{1} y_{2}}{\rho\left(\rho^{\prime}-(n-(b+1) \delta-2)\right)} \quad($ since $n \geq 4(b+1) \delta+4)$
$>0$ (since $\rho<n-1, \rho^{\prime}>n-(b+1) \delta-2$ and $\left.s \geq \delta+1\right)$.
This implies that $\rho^{\prime}>\rho$, which contradicts the assumption $\rho^{\prime} \leq \rho$. It follows that $\rho^{\prime}>\rho$. Combining this with (1) and (2), we may conclude that $\rho(G) \leq \rho\left(G_{s}^{1}\right) \leq$ $\rho\left(G_{s}^{2}\right)<\rho(T(n, b, \delta))$.

Case 2. $s<\delta$.
Let $G_{s}^{3}=K_{s} \nabla\left(K_{n-s-(\delta+1-s)(t-1)} \cup(t-1) K_{\delta+1-s}\right)$. Recall that $G$ is a spanning subgraph of $G_{s}^{1}=K_{s} \nabla\left(K_{n_{1}} \cup K_{n_{2}} \cup \cdots \cup K_{n_{t}}\right)$, where $t=b s+2, n_{1} \geq n_{2} \geq \cdots \geq n_{t}$ and $\sum_{i=1}^{t} n_{i}=n-s$. Clearly, $n_{t} \geq \delta+1-s$ because the minimum degree of $G_{s}^{1}$ is at least $\delta$. By Lemma 3.2, we have

$$
\begin{equation*}
\rho\left(G_{s}^{1}\right) \leq \rho\left(G_{s}^{3}\right), \tag{7}
\end{equation*}
$$

where the equality holds if and only if $\left(n_{1}, \ldots, n_{t}\right)=(n-s-(\delta+1-s)(t-1), \delta+$ $1-s, \ldots, \delta+1-s)$.

Assume that $\rho\left(G_{s}^{3}\right)=\rho^{*} \geq n-(\delta+1-s)(t-1)$. Let $x$ be the Perron vector of $A\left(G_{s}^{3}\right)$ corresponding to $\rho^{*}$. By symmetry, $x$ takes the same values $x_{1}, x_{2}$, and $x_{3}$ on
the vertices of $K_{n-s-(\delta+1-s)(t-1)}, K_{\delta+1-s}$ and $K_{s}$, respectively. Then, by $A\left(G_{s}^{3}\right) x=$ $\rho^{*} x$, we have

$$
\begin{align*}
\rho^{*} x_{1} & =(n-1-(\delta+1-s)(t-1)-s) x_{1}+s x_{3},  \tag{8}\\
\rho^{*} x_{2} & =(\delta-s) x_{2}+s x_{3},  \tag{9}\\
\rho^{*} x_{3} & =(n-(\delta+1-s)(t-1)-s) x_{1}+(\delta+1-s)(t-1) x_{2}+(s-1) x_{3} . \tag{10}
\end{align*}
$$

From (8) and (9), we obtain

$$
\left\{\begin{array}{l}
x_{1}=\frac{s x_{3}}{\rho^{*}-(n-1-(\delta+1-s)(t-1))+s}  \tag{11}\\
x_{2}=\frac{s x_{3}}{\rho^{*}-\delta+s}
\end{array}\right.
$$

Note that $n \geq F(b, \delta) \geq b \delta^{3}+\delta, b \geq 1$ and $\delta \geq s+1 \geq 2$. Then $\rho^{*} \geq n-(\delta+1-s)(t-$ $1)>\delta+1$. Putting (11) into (10), and considering that $\rho^{*} \geq n-(\delta+1-s)(t-1)>$ $\delta+1$, we get

$$
\begin{aligned}
& \rho^{*}+1 \\
= & s+\frac{s(n-(\delta+1-s)(t-1)-s)}{\rho^{*}-(n-1-(\delta+1-s)(t-1))+s}+\frac{s(\delta+1-s)(t-1)}{\rho^{*}-(\delta-s)} \\
< & s+\frac{s(n-(\delta+1-s)(t-1)-s)}{s+1}+\frac{s(\delta+1-s)(t-1)}{s+1} \\
= & s+\frac{s(n-s)}{s+1} \\
= & n-(\delta+1-s)(t-1)-\frac{n-s-(\delta+1-s)(t-1)(s+1)}{s+1} \\
\leq & n-(\delta+1-s)(t-1)-\frac{b \delta^{3}+\delta-s-(\delta+1-s)(t-1)(s+1)}{s+1} \quad\left(\text { since } n \geq b \delta^{3}+\delta\right) \\
< & n-(\delta+1-s)(t-1) \quad(\text { since } \quad \delta \geq s+1, b \geq 1 \text { and } s \geq 1) \\
\leq & \rho^{*}
\end{aligned}
$$

which is impossible. Thus we have

$$
\begin{align*}
\rho^{*} & <n-(\delta+1-s)(t-1) \\
& =n-b \delta-2-((s-1)(\delta-s) b+\delta-(s+1)) \quad(\text { since } \quad \delta \geq s+1, b \geq 1 \text { and } s \geq 1)  \tag{12}\\
& \leq n-b \delta-2
\end{align*}
$$

Since $T(n, b, \delta)$ contains $K_{n-b \delta-1} \cup(b \delta+1) K_{1}$ as a proper spanning subgraph, it follows that $\rho(T(n, b, \delta))>\rho\left(K_{n-b \delta-1} \cup(b \delta+1) K_{1}\right)=n-b \delta-2$. Combining this with (1), (7) and (12), we may conclude that $\rho(G) \leq \rho\left(G_{s}^{1}\right) \leq \rho\left(G_{s}^{3}\right)<\rho(T(n, b, \delta))$.

Case 3. $s=\delta$.
Note that $G_{s}^{1}$ is a spanning subgraph of $T(n, b, \delta)$. Then

$$
\rho\left(G_{s}^{1}\right) \leq \rho(T(n, b, \delta))
$$

with equality holding if and only if $G_{s}^{1} \cong T(n, b, \delta)$. Combining this with (1), we may conclude that

$$
\rho(G) \leq \rho(T(n, b, \delta))
$$

where the equality holds if and only if $G \cong T(n, b, \delta)$. This completes the proof.
From Theorem 1.2, we can get the result of Liu, Liu and Feng [27] immediately.
Corollary 3.1. (See [2'7]) Let $G$ be a connected graph of even order $n$ with minimum degree $\delta(G) \geq 2$. If $n \geq \max \left\{7+7 \delta+2 \delta^{2}, \delta^{3}+3 \delta^{2}+2 \delta\right\}$ and $\rho(G) \geq \rho(T(n, 1, \delta))$, then $G$ has a perfect matching, unless $G \cong T(n, 1, \delta)$.

## 4 Proof of Theorem 1.3

The following two structural lemmas will play an essential role in the proof of Theorem 1.3.

Lemma 4.1. (See [28]) Let $G$ be a graph of order $n$ with minimum degree $\delta(G)$ and let $a$ and $b$ be integers such that $1 \leq a<b$. Then if $\delta(G) \geq a, n \geq 2 a+b+\frac{a^{2}-a}{b}$ and

$$
\max \left\{d_{G}(u), d_{G}(w)\right\} \geq \frac{a n}{a+b},
$$

for any two nonadjacent vertices $u$ and $w$ of $G$, then $G$ contains an $[a, b]$-factor.
Lemma 4.2. (See [29]) Suppose that $k \geq 3$. Let $G$ be a connected graph of order $n \geq 4 k-3$ with minimum degree $\delta(G)$, where $k \cdot n$ is even and $\delta(G) \geq k$. If

$$
\max \left\{d_{G}(u), d_{G}(w)\right\} \geq \frac{n}{2}
$$

for any two nonadjacent vertices $u$ and $w$ of $G$, then $G$ contains a $k$-factor.
Lemma 4.3. (See [13]) Let $G$ be a connected graph of order n. If

$$
\begin{equation*}
\rho(G) \geq n-2, \tag{13}
\end{equation*}
$$

then $G$ contains a Hamiltonian path unless $G \cong H_{n, 1}$. If the inequality (13) is strict, then $G$ contains a Hamiltonian cycle unless $G \cong H_{n, 2}$.

Lemma 4.4. (See [2]) Let $M$ be a real symmetric matrix, and let $\lambda_{1}(M)$ be the largest eigenvalue of $M$. If $B_{\Pi}$ is an equitable quotient matrix of $M$, then the eigenvalues of $B_{\Pi}$ are also eigenvalues of $M$. Furthermore, if $M$ is nonnegative and irreducible, then $\lambda_{1}(M)=\lambda_{1}\left(B_{\Pi}\right)$.

Lemma 4.5. Suppose that $G$ is a connected graph of order $n$. Let $u, w$ be two nonadjacent vertices of $G$ such that $\max \left\{d_{G}(u), d_{G}(w)\right\} \leq t$, where $t \geq 1$. Then $\rho(G) \leq \rho\left(K_{t} \nabla\left(2 K_{1} \cup K_{n-t-2}\right)\right)$, with equality if and only if $G \cong K_{t} \nabla\left(2 K_{1} \cup K_{n-t-2}\right)$.

Proof. Let $x$ be the Perron vector of $A(G)$ with respect to $\rho(G)$. Assume that $V(G) \backslash\{u, w\}=\left\{v_{1}, v_{2}, \ldots, v_{n-2}\right\}$ with $x_{v_{1}} \geq x_{v_{2}} \geq \cdots \geq x_{v_{n-2}}$. Let

$$
G^{\prime}=G-\sum_{v \in N_{G}(u)} u v-\sum_{v \in N_{G}(w)} w v+\sum_{i=1}^{t}\left(u v_{i}+w v_{i}\right)
$$

Since $d_{G}(u) \leq t$ and $d_{G}(w) \leq t$, by Lemma 2.1, it follows that $\rho(G) \leq \rho\left(G^{\prime}\right)$, where equality holds if and only if $G \cong G^{\prime}$. Obviously, $G^{\prime}$ is a spanning subgraph of $K_{t} \nabla\left(2 K_{1} \cup K_{n-t-2}\right)$. Thus

$$
\rho(G) \leq \rho\left(K_{t} \nabla\left(2 K_{1} \cup K_{n-t-2}\right)\right)
$$

with equality if and only if $G \cong K_{t} \nabla\left(2 K_{1} \cup K_{n-t-2}\right)$.
Now we shall give the proof of Theorem 1.3.
Proof of Theorem 1.3. Let $G$ be a graph of order $n \geq 3 a+b-1$ with $\rho(G)>$ $\rho\left(H_{n, a}\right)$, where $a \cdot n$ is an even integer and $b \geq a \geq 1$. We first assert that $G$ is connected. If not, suppose that $G_{1}, \ldots, G_{p}(p \geq 2)$ are the components of $G$. Then $\rho(G)=\max \left\{\rho\left(G_{1}\right), \ldots, \rho\left(G_{p}\right)\right\} \leq \rho\left(K_{n-1}\right)=n-2$, which contradicts that $\rho(G)>\rho\left(H_{n, a}\right) \geq n-2$, and so we assume that $G$ is connected in the following. We next assert that $\delta(G) \geq a$. Otherwise, let $1 \leq \delta(G) \leq a-1$. Then $G$ is a spanning subgraph of $H_{n, a}$ for $a \geq 2$, and so $\rho(G) \leq \rho\left(H_{n, a}\right)$, a contradiction.

If $a=b=1$. Since $n$ is even and $\rho(G)>\rho\left(H_{n, 1}\right)$, by Lemma 4.3, it follows that $G$ contains a Hamiltonian path of even number, and so $G$ contains a 1-factor. If $a=b=$ 2 , then by using the same analysis as above, we deduce that $G$ contains a 2 -factor. Next, we assume that both $a$ and $b$ are not equal to 1 or 2 simultaneously. Suppose that $G$ contains no $[a, b]$-factor of order $n \geq 3 a+b-1$. By Lemmas 4.1 and 4.2, there exist two nonadjacent vertices $u$ and $w$ such that $\max \left\{d_{G}(u), d_{G}(w)\right\} \leq \frac{a n}{a+b}-1$. Let $t=\frac{a n}{a+b}-1$. Then $t \geq \delta(G) \geq a \geq 1$. Suppose that $G_{1} \cong K_{t} \nabla\left(2 K_{1} \cup K_{n-t-2}\right)$. By Lemma 4.5, we obtain

$$
\begin{equation*}
\rho(G) \leq \rho\left(G_{1}\right) \tag{14}
\end{equation*}
$$

The vertex set of $G_{1}$ can be partitioned as $V\left(G_{1}\right)=V\left(2 K_{1}\right) \cup V\left(K_{t}\right) \cup V\left(K_{n-t-2}\right)$, where $V\left(2 K_{1}\right)=\{u, w\}, V\left(K_{t}\right)=\left\{v_{1}, \ldots, v_{t}\right\}$ and $V\left(K_{n-t-2}\right)=\left\{v_{t+1}, \ldots, v_{n-2}\right\}$. Let $G_{1}^{\prime}=G_{1}-\left\{u v_{a}, u v_{a+1}, \ldots, u v_{t}\right\}+\left\{w v_{t+1}, w v_{t+2}, \ldots, w v_{n-2}\right\}$. Clearly, $G_{1}^{\prime} \cong H_{n, a}$. If $a=1$ and $b \geq 2$, then $G_{1}^{\prime} \cong K_{1} \cup K_{n-1}$. Note that $t=\frac{a n}{a+b}-1$. Then $n \geq 3 t+3$. Observe that $A\left(G_{1}\right)$ has the equitable quotient matrix

$$
B_{1}=\left[\begin{array}{ccc}
0 & t & 0 \\
2 & t-1 & n-t-2 \\
0 & t & n-t-3
\end{array}\right]
$$

The characteristic polynomial of $B_{1}$ is

$$
f(\lambda)=\lambda^{3}-(n-4) \lambda^{2}-(n+2 t-3) \lambda+2 t n-2 t^{2}-6 t
$$

By a simple computation, we have

$$
f(-\infty)=-\infty, \quad f(0)=2 t(n-t-3)>0, \quad f(n-3)=-2 t^{2}<0
$$

and

$$
f(n-2)=\left(n-\frac{3}{2}\right)^{2}-2 t^{2}-2 t-\frac{1}{4} \geq 7 t^{2}+7 t+2>0
$$

By Lemma 4.4, we have $\lambda_{1}\left(B_{1}\right)=\rho\left(G_{1}\right)$. Notice that $\rho\left(G_{1}^{\prime}\right)=\rho\left(K_{1} \cup K_{n-1}\right)=n-2$ and $\lambda_{1}\left(B_{1}\right)<n-2$. Then $\rho\left(G_{1}\right)<\rho\left(G_{1}^{\prime}\right)$. Combining this with (14), we obtain that $\rho(G) \leq \rho\left(G_{1}\right)<\rho\left(H_{n, 1}\right)$, a contradiction. Next, we assume that $a \geq 2$ and $b \geq 3$. Recall that $t=\frac{a n}{a+b}-1$. Then $n \geq 2 t+2$. Let $x$ be the Perron vector of $A\left(G_{1}\right)$ with respect to $\rho\left(G_{1}\right)$, and let $\rho=\rho\left(G_{1}\right)$. By symmetry, $x$ takes the same value (say $x_{1}$, $x_{2}$ and $x_{3}$ ) on the vertices of $V\left(2 K_{1}\right), V\left(K_{t}\right)$ and $V\left(K_{n-t-2}\right)$, respectively. Then, by $A\left(G_{1}\right) x=\rho x$, we have

$$
\begin{equation*}
x_{2}=\frac{(\rho-(n-t-3)) x_{3}}{t} . \tag{15}
\end{equation*}
$$

Similarly, let $y$ be the Perron vector of $A\left(G_{1}^{\prime}\right)$ corresponding to $\rho\left(G_{1}^{\prime}\right)=\rho^{\prime}$. By symmetry, $y$ takes the same values $y_{1}, y_{2}$ and $y_{3}$ on the vertices of $V\left(K_{1}\right), V\left(K_{a-1}\right)$ and $V\left(K_{n-a}\right)$, respectively. Then, by $A\left(G_{1}^{\prime}\right) y=\rho^{\prime} y$, we obtain

$$
\begin{align*}
\rho^{\prime} y_{1} & =(a-1) y_{2},  \tag{16}\\
\rho^{\prime} y_{3} & =(a-1) y_{2}+(n-a-1) y_{3} . \tag{17}
\end{align*}
$$

Since $G_{1}^{\prime}$ contains $K_{1} \cup K_{n-1}$ as a proper spanning subgraph, we have $\rho^{\prime}>n-2>$ $n-a-1$. Putting (16) into (17), and considering that $\rho^{\prime}>n-a-1$, we have

$$
\begin{equation*}
y_{3}=\frac{\rho^{\prime} y_{1}}{\rho^{\prime}-(n-a-1)} \tag{18}
\end{equation*}
$$

Obviously, neither $G_{1}$ nor $G_{1}^{\prime}$ is a regular graph. Thus $\rho<n-1$ and $\rho^{\prime}<n-1$. Combining this with (15) and (18) yields that

$$
\begin{aligned}
y^{T}\left(\rho^{\prime}-\rho\right) x & =y^{T}\left(A\left(G_{1}^{\prime}\right)-A\left(G_{1}\right)\right) x \\
& =\sum_{i=t+1}^{n-2}\left(x_{w} y_{v_{i}}+x_{v_{i}} y_{w}\right)-\sum_{i=a}^{t}\left(x_{u} y_{v_{i}}+x_{v_{i}} y_{u}\right) \\
& =(n-t-2)\left(x_{1} y_{3}+x_{3} y_{3}\right)-(t-a+1)\left(x_{1} y_{3}+x_{2} y_{1}\right) \\
& =(n-2 t+a-3) x_{1} y_{3}+(n-t-2) x_{3} y_{3}-(t-a+1) x_{2} y_{1} \\
& >(n-t-2) x_{3} y_{3}-(t-a+1) x_{2} y_{1} \quad(\text { since } n \geq 2 t+2 \text { and } a \geq 2) \\
& =x_{3} y_{1}\left(\frac{\rho^{\prime}(n-t-2)}{\rho^{\prime}-(n-a-1)}-\frac{(\rho-(n-t-3))(t-a+1)}{t}\right) \\
& >x_{3} y_{1}\left(\frac{\rho^{\prime}(n-t-2)}{a}-\frac{(t-a+1)(t+2)}{t}\right) \quad\left(\text { since } \rho<n-1 \text { and } \rho^{\prime}<n-1\right)
\end{aligned}
$$

$$
\begin{aligned}
& >x_{3} y_{1}\left(\frac{(n-2)(n-t-2)}{a}-\frac{(t-a+1)(t+2)}{t}\right) \quad\left(\text { since } \rho^{\prime}>n-2\right) \\
& \geq \frac{((n-2)(n-t-2)-(t-a+1)(t+2)) x_{3} y_{1}}{t}(\text { since } t \geq a) \\
& >0 \quad(\text { since } t \geq a \geq 2 \text { and } n \geq 2 t+2) .
\end{aligned}
$$

Therefore, we have $\rho<\rho^{\prime}$. Combining this with (14), we may conclude that $\rho(G) \leq$ $\rho\left(G_{1}\right)<\rho\left(H_{n, a}\right)$, a contradiction. Therefore, the proof is complete.

## 5 Concluding remarks

A fractional matching of a graph $G$ is a function $f$ giving each edge a number in $[0,1]$ such that $\sum_{e \in \Gamma(v)} f(e) \leq 1$ for each $v \in V(G)$, where $\Gamma(v)$ is the set of edges incident to $v$. A fractional perfect matching of a graph $G$ is a fractional matching $f$ with $\sum_{e \in E(G)} f(e)=\frac{n}{2}$. The relations between the eigenvalues and the fractional matching number of a graph were studied by several researchers [31, 33, 36].

The following fundamental lemmas provide some sufficient and necessary conditions for the existence of a $[1, b]$-factor for $b \geq 2$ and a fractional perfect matching in a graph, respectively. Let $i(H)$ be the number of isolated vertices of a graph $H$.

Lemma 5.1. (See [4]) Let $G$ be a graph and let $b \geq 2$ be a positive integer. Then $G$ contains a $[1, b]$-factor if and only if for every subset $S \subseteq V(G)$,

$$
i(G-S) \leq b|S|
$$

Lemma 5.2. (See [34]) A graph $G$ has a fractional perfect matching if and only if for every subset $S \subseteq V(G)$,

$$
i(G-S) \leq|S|
$$

By Lemmas 5.1 and 5.2 and using the same analysis as the proof of Theorem 1.2. We easily obtain the following result.

Theorem 5.1. Suppose that $G$ is a connected graph of order $n$ with minimum degree $\delta$.
(i) If $n \geq 4(b+1) \delta+4$ and $\rho(G) \geq \rho\left(K_{\delta} \nabla\left(K_{n-(b+1) \delta-1} \cup(b \delta+1) K_{1}\right)\right)$ where $b \geq 2$, then $G$ contains $a[1, b]$-factor, unless $G \cong K_{\delta} \nabla\left(K_{n-(b+1) \delta-1} \cup(b \delta+1) K_{1}\right)$.
(ii) If $n \geq 8 \delta+4$ and $\rho(G) \geq \rho\left(K_{\delta} \nabla\left(K_{n-2 \delta-1} \cup(\delta+1) K_{1}\right)\right)$, then $G$ contains $a$ fractional perfect matching, unless $G \cong K_{\delta} \nabla\left(K_{n-2 \delta-1} \cup(\delta+1) K_{1}\right)$.

Corollary 1.1 provides a spectral condition to guarantee the existence a $k$-factor in a graph. It is natural to ask the following question for $k \geq 1$.

Problem 5.1. What is the maximum spectral radius and what is the corresponding extremal graph among all graphs with a unique $k$-factor for $k \geq 1$ ?

In this paper, we give the answer to Problem 5.1 for $k=1$. However, the structure of graphs with a unique $k$-factor is more complicated for $k \geq 2$, and it seems difficult to determine the extremal graphs about the problem.

If $k \leq n$. Let $n=s k+t$ with $s \geq 1$ and $0 \leq t \leq k-1$. We give the process to construct the graph $G(2 n, k)$. First define a graph $F_{1}$ on $2(k+t)$ vertices as follows. Let $H_{1} \cong K_{t} \nabla t K_{1}$, and let $A_{11}=V\left(t K_{1}\right)$ and $A_{12}=V\left(K_{t}\right)$. Denote by $H_{2}$ the graph obtained from $k K_{1} \cup K_{k}$ by adding edges between $V\left(k K_{1}\right)$ and $V\left(K_{k}\right)$ such that $d_{H_{2}}(v)=k-t$ for $v \in V\left(k K_{1}\right)$ and $d_{H_{2}}(u)=2 k-t-1$ for $u \in V\left(K_{k}\right)$. Suppose that $A_{21}=V\left(k K_{1}\right)$ and $A_{22}=V\left(K_{k}\right)$. Let $F_{1}$ be the graph of order $2(k+t)$ obtained from $H_{1} \cup H_{2}$ by connecting all vertices of $A_{1 j}$ with $A_{2(3-j)}$ for $1 \leq j \leq 2$ and adding all edges between $A_{12}$ and $A_{22}$. The resulting graph $F_{1}$ has exactly one $k$-factor. Suppose that $U_{1}=A_{11} \cup A_{21}$ and $W_{1}=A_{12} \cup A_{22}$. Next take $s-1$ copies of $K_{k} \nabla k K_{1}$ labeled $F_{2}, \ldots, F_{s}$. For $2 \leq i \leq s$, let $U_{i}$ and $W_{i}$ be the vertices set of $V\left(k K_{1}\right)$ and $V\left(K_{k}\right)$ in each $F_{i}$, respectively. Then the graph $G(2 n, k)$ is obtained by adding edges connecting all vertices of $W_{i}$ in $F_{i}$ to all vertices in $F_{j}$ for each $i, j$ with $1 \leq i<j \leq s$. The resulting graph $G(2 n, k)$ has a unique $k$-factor. We end the paper by proposing the following problem for further research.

Problem 5.2. For $k \geq 1$. Suppose that $G$ is a graph of order $2 n$ with a unique $k$-factor.
(I) Does $\rho(G) \leq \rho\left(K_{2 n-k} \nabla H\right)$, where $H$ is a $2(k-n)$-regular graph if $k>n$ ?
(II) Does $\rho(G) \leq \rho(G(2 n, k))$, if $k \leq n$ ?
