# GENERALIZED INTEGER SPLINES ON ARBITRARY GRAPHS

#### Abstract

Generalized integer splines on a graph $G$ with integer edge weights are integer vertex labelings such that if two vertices share an edge in $G$, the vertex labels are congruent modulo the edge weight. We introduce collapsing operations that reduce any simple graph to a single vertex, carrying with it the edge weight information. This corresponds to a sequence of surjective maps between the associated spline modules, leading to an explicit construction of a $\mathbb{Z}$-module basis in terms of the edge weights.


## Introduction

Consider a graph $G$ with integer edge weights. Label the vertices so that if two vertices are joined by an edge with weight $w$, then their vertex labels are congruent modulo $w$. This leads to the following questions:

- Given arbitrary edge weights, can we always construct a vertex labeling?
- Can we find a finite set that generates all vertex labelings?

In [6], Tymozcko, et. al. introduced the study of generalized splines on a graph with edges weighted by ideals in a commutative ring $R$. Their foundational paper concludes with many open questions, primarily about the $R$-module structure of sets of splines and how much this structure is determined by properties of the ring and/or the underlying graph. A subsequent survey article [13] describes the role that generalized splines play in geometry and topology.

In this paper we set $R$ to be $\mathbb{Z}$, the ring of integers, although the results in this paper hold when $R$ is an Euclidean Ring, with minor modifications. We answer both of the above questions affirmatively, and in doing so find a complete characterization of spline modules over $\mathbb{Z}$ for arbitrary graphs.

Generalized splines are a generalization of polynomial splines, which are ubiquitous in applied math, computer graphics and approximation

theory. They are often defined to be piecewise polynomial functions on a polyhedral subdivision of $\mathbb{R}^{d}$. Alfeld and others [1] studied the question of finding dimensions and bases for vector spaces of splines of restricted polynomial degree. In [3, 5], Billera pioneered the use of algebraic techniques in the study of polynomial splines. When the polynomial degrees are unrestricted, the set of all splines on a polyhedral complex will be both a ring and an $R$-module, where $R$ is a polynomial ring in $d$ variables over a field.

The algebraic study of polynomial splines led to a representation of splines as vertex labels of the dual graph of the polyhedral complex [11, 10], where the edges are labeled with linear forms. In this new representation, a set of vertex labels is a spline if each edge label divides the difference between its two vertex labels. This representation easily extends to arbitrary rings, and in fact arises in geometry and topology.

When $R$ is a principal ideal domain, generalized spline modules are always free of rank $n$, the number of vertices of the graph. In 8], Handschy, et. al, constructed "flow-up class" bases for $n$-cycle graphs with integer edge weights. In [9] we proved that flow-up class bases exist for spline modules over arbitrary graphs with integer edge weights, and expanded the class of graphs for which a flow-up class basis could be constructed.

The main result of this paper is the construction of flow-up class bases for the spline module $S_{G}$, for any arbitrary graph $G$ with integer edge weights. To do this, we introduce two collapsing operations that transform $G$ into a graph with fewer vertices or edges. Using these operations, we can reduce any connected graph to a point. Then we show that each of these operations induces a surjective $\mathbb{Z}$-module map of the associated spline modules. The main algebraic result is that $S_{G}$ is the direct sum of the kernels of these maps. From there, all that is left to do is to construct a basis for each of the kernels, and show that their pre-images form a basis for $S_{G}$. A nice feature of this construction is that the first non-zero entry of each basis element, viewed as an $n$ tuple of $\mathbb{Z}^{n}$, can be written in terms of least common multiples and greatest common divisors of a subset of the edge weights.

## 1. Preliminaries

We begin with a formal definition of a generalized integer spline. Let $G$ be a graph with $n$ vertices, edge set $E$, and $A: E \rightarrow \mathbb{N}$ an assignment of positive integer weights to edges of $G$.

We denote the set of splines on $(G, A)$ by $S_{G}(A)$, or just $S_{G}$ when there is no ambiguity.

Definition 1.1. Let $G$ a graph with $n$ vertices. A generalized integer spline on $G$ is an $n$-tuple $\left(g_{1}, g_{2}, \ldots, g_{n}\right) \in \mathbb{Z}^{n}$ such that if vertices $v_{i}$ and $v_{j}$ are joined by $e \in E$, then $g_{i} \equiv g_{j} \bmod A(e)$. We refer to these equations as the defining equations for $S_{G}$.

Example 1.2. Let $G$ be a 3 -cycle with edge labels $a, b, c$ as in Figure1. By the definition above, $\left(g_{1}, g_{2}, g_{3}\right) \in Z^{3}$ is a spline in $S_{G}$ if the following defining equations, one for each edge, are satisfied.

\begin{aligned}
g_{1} & \equiv g_{2} \bmod a \\
g_{2} & \equiv g_{3} \bmod b \\
g_{3} & \equiv g_{1} \bmod c
\end{aligned}
$$

Notation: Let $\left(r_{1}, r_{2}, \ldots r_{m}\right)$ denote the GCD and $\left[r_{1}, r_{2}, \ldots r_{m}\right]$ denote the LCM of the set $\left\{r_{1}, r_{2}, \ldots r_{m}\right\}$.

The following lemma will be used in later sections. The proofs are straightforward, so we omit them.

Lemma 1.3. Let $a, b, m, n$ in $\mathbb{N}$.
(1) $(a,(b, c))=(a, b, c)$.
(2) $[a,[b, c]]=[a, b, c]$.
(3) $[(a, c),(b, c)]=([a, b], c)$.
(4) $x \equiv a \bmod m$ and $x \equiv a \bmod n$ if and only if $x \equiv a \bmod [m, n]$.

We will need the non-coprime version of the Chinese Remainder Theorem, which we state for convenience.

Theorem 1.4 (Non-Coprime Chinese Remainder Theorem). Let $a_{i} \in$ $\mathbb{Z}$ and $m_{i} \in \mathbb{N}$ for $i$ between 1 and $n$. The system of congruences

$$
\begin{aligned}
& x \equiv a_{1} \bmod m_{1} \\
& x \equiv a_{2} \bmod m_{2} \\
& \vdots \\
& x \equiv a_{n} \bmod m_{n}
\end{aligned}
$$

has a solution if and only if

$$
a_{i} \equiv a_{j} \bmod \left(m_{i}, m_{j}\right)
$$

for all $i, j$ with $1 \leq i, j \leq n$. If a solution exists, then it is unique modulo $\left[m_{1}, m_{2}, \ldots, m_{n}\right]$.

## 2. Collapsing Operations on $G$

In this section, we define two operations on $(G, A)$ that yield another edge-weighted graph $\left(G^{\prime}, A^{\prime}\right)$ with either fewer vertices or the same number of vertices and fewer edges. We will show that for any $(G, A)$, and vertices $v_{i}$ and $v_{j}$, there exists a sequence of operations that yield the weighted edge $\left(K_{2}, A_{*}\right)$, for some $A_{*}$ in $\mathbb{N}$. Moreover, we will show that any spline on $\left(K_{2}, A_{*}\right)$ can be extended to a spline on $(G, A)$. We can then use this collapse sequence to construct a $\mathbb{Z}$-module basis for $S_{G}$.

Definition 2.1. Let $G$ be a graph and $v$ a vertex of $G$ of degree $d$.
(1) The star of $v$, denoted $s t(v)$, is the subgraph consisting of $v$ and all edges that contain $v$.
(2) A $d$-clique is a subgraph that is a complete graph on $d$ vertices.

The first collapse operation replaces the star of $v$ with a $d$-clique, where $d$ is the degree of $v$, using the neighbors of $v$ are the vertices. All other vertices and edges in the graph remain the same, although the new graph may have multiple edges. We call this a star-clique operation, as we are deleting a vertex star, and then adding new edges to the adjacent $d$ vertices to form a $d$-clique. This generalizes the standard $\mathbf{Y}-\boldsymbol{\Delta}$ transform that takes a 3 -star to the 3 -clique $K_{3}$. We now define this process more formally.
Definition 2.2. Let $v$ be a vertex of $G$ of degree $d$, with adjacent vertices $\left\{v_{1}, \ldots, v_{d}\right\}$ and incident edge weights $\left\{a_{1}, \ldots, a_{d}\right\}$. The starclique operation transforms $(G, A)$ to $\left(G_{v}, A_{v}\right)$ as follows.

- Remove $v$ and the edges of $s t(v)$, but keep the adjacent vertices.
- Add edges between adjacent vertices to form a $d$-clique.
- Label the new edge between $v_{i}$ and $v_{j}$ with $\left(a_{i}, a_{j}\right)$.

Example 2.3. Let $v_{2}$ be a vertex of degree 1 , with adjacent vertex $v_{1}$ and incident edge $e$ with weight $a$. The star-clique operation replaces the star of $v_{2}$, an edge, with a 1 -clique, which is the single vertex $v_{1}$. We call this a leaf deletion. See Figure 2 .

Example 2.4. Let $v_{2}$ have degree 2, with adjacent vertices $v_{1}$ and $v_{3}$ and incident edges with weights $a$ and $b$. The star-clique operation replaces the star of $v_{2}$, i.e. the path $v_{1} v_{2} v_{3}$, with the edge $v_{1} v_{3}$. This is a path contraction, with edge weights $a$ and $b$ replaced by ( $a, b$ ) (see Figure (3).

Example 2.5. Let $v_{4}$ be a vertex of degree 3, with adjacent vertices $v_{1}, v_{2}$ and $v_{3}$ and incident edge weights $c, a, b$. The star-clique operation replaces the star of $v_{4}$, a " $Y$-graph," with a triangle with vertices $v_{1}, v_{2}, v_{3}$. The new edges will have weights $(a, c),(a, b),(b, c)$, as shown inn Figure (4).

The new graph $\left(G_{v}, A_{v}\right)$ has one fewer vertex, but may no longer be a simple graph if some of the $v_{i}$ 's were already be connected in $G$.

In order to turn $G_{v}$ into a simple graph, so that we can apply the star-clique operation again, we introduce a second operation, edge collapse, that collapses multiple edges between the same pair of vertices (see Figure 5).

Definition 2.6. Let $e_{1}, e_{2}, \ldots e_{r}$ be multiple edges between vertices $v$ and $w$ in $G$ with labels $\left\{a_{1}, \ldots, a_{r}\right\}$. The edge-collapes operation transforms $(G, A)$ to $\left(G^{\prime}, A^{\prime}\right)$ as follows.

- Remove $e_{1}, e_{2}, \ldots e_{r}$.
- Add a new edge $e$ between $v$ and $w$.
- Label $e$ with $\left[a_{1}, a_{2}, \ldots, a_{r}\right]$.

Example 2.7. Let $v_{1}, v_{2}$ be two vertices joined by edges of weights $a, b$. The edge-collapse operation replaces these edges with a single edge of weight $[a, b]$ (see Figure 5).

Lemma 2.8. Let $(G, A)$ be a simple, connected graph containing at least one vertex $v$. Then $\left(G_{v}, A_{v}\right)$ is also connected.

Proof. We consider two cases.

- Case 1: If $G_{v}$ is the empty graph or has only one vertex, then it is vacuously connected.
- Case 2: Assume $G_{v}$ has 2 or more vertices. Let $x$ and $y$ be distinct vertices of $G_{v}$. Hence they are vertices in $G$ since $G_{v}$ doesn't introduce new vertices. Since $G$ is connected, there is a path $P$ connecting $x$ and $y$ in $G$. There are two cases.
- First, assume $P$ does not pass through the vertex $v$. The removal of $v$ does not affect $P$, so $P$ is also a path in $G_{v}$.
- Now suppose $P$ passes through the vertex $v$. Then $P$ passes through vertices $p$ and $q$, where $p$ and $q$ are adjacent to $v$. When we form $G_{v}$, the path $p v q$ in $G$ will be replaced by a single edge $p q$. Thus, we can form a path $P_{v}$ from $x$ to $y$ in $G_{v}$ by replacing the edges $p v$ and $v q$ with the edge $p q$ in $G_{v}$.

A graph can always be collapsed to a single edge, and even further to a single vertex.

Lemma 2.9. Let $(G, A)$ be a connected edge-weighted graph, and let $v$ and $w$ be vertices of $G$.
(1) We can collapse $G$ to the graph $K_{2}$ with vertices $v$ and $w$.
(2) We can collapse $G$ to the vertex $v$.

Proof. Choose a vertex other than $v$ and $w$ and do a star-clique operation. This will reduce the number of vertices by one. Now do an edge collapse to remove multiple edges. Repeat until $v$ and $w$ are the only vertices left, and remove any multiple edges. Since the graphs at each stage are connected, by Lemma 2.8, we are left with a single edge between $v$ and $w$.

For part 2, a star-clique operation on $w$ will transform the edge $v w$ into the single vertex $v$.

## 3. The Spline Modules $S_{G}$ and $S_{G^{\prime}}$

Now that we have constructed the graph collapsing operations, we describe their effects on the spline module $S_{G}$. In order to do this, we must first fix an ordering of the vertices $v_{1}, \ldots, v_{n}$ of $G$. Next, we partition $S_{G}$ into flow-up classes $\mathcal{F}_{i}$, which are subsets of splines with the first $i$ entries equal to zero and the $i+1$ st entry non-zero. A flowup class basis will be a basis that consists of an element from each non-zero flow-up class.

Definition 3.1. For $0 \leq i<n$, the $i$ th flow-up class, denoted $\mathcal{F}_{i}$, is the set of splines of the form $F=\left(0,0, \ldots, 0, f_{i+1}, \ldots, f_{n}\right)$ where $f_{i+1}$ is non-zero. We also define $\mathcal{F}_{n}=\{\mathbf{0}\}=\mathbf{0}=(0,0, \ldots, 0)$, the zero spline.

We now define the leading term of a spline to be its first non-zero entry.

Definition 3.2. Let $F \in \mathcal{F}_{i}$ where $i \neq n$, so that $F=\left(0,0, \ldots, 0, f_{i+1}, \ldots, f_{n}\right)$ and $f_{i+1} \neq 0 . L(F)=f_{i+1}$ is the leading term of $F$.
Definition 3.3. A spline $B \in \mathcal{F}_{i}$ is a minimal element of $\mathcal{F}_{i}$ if $L(B)>0$, and for all $F \in \mathcal{F}_{k},(L(B) \leq|L(F)|$.

For example, $\mathbf{1}=(1,1, \ldots, 1)$ has leading term 1 , which is minimal in $\mathbb{N}$. Thus, $\mathbf{1}$ is a minimal element of $\mathcal{F}_{0}$.

Note: Although minimal elements of $\mathcal{F}_{i}$ have the same leading term, the other terms are not in general unique.

Our strategy for constructing a basis for $S_{G}$ is to find a minimal element from each $\mathcal{F}_{i}$, for $i<n$. The theorem below asserts that this set will alway form a basis, called a flow-up class basis.

Theorem 3.4. 9 Let $(G, A)$ be an edge labeled graph with $n$ vertices. Let $\mathcal{B}=\left\{B_{0}, B_{1}, \ldots, B_{n-1}\right\} \subset S_{G}$ where each $B_{i}$ is a minimal element of $\mathcal{F}_{i}$. Then $\mathcal{B}$ is a $\mathbb{Z}$-module basis for $S_{G}$.

We now look at the effect of collapsing operations on flow-up classes and minimal elements. We begin with an example.

Example 3.5. Let $G$ be the $Y$-graph with vertices $v_{1}, v_{2}, v_{3}, v_{4}$, and edge labels $a, b, c$, as in Figure 4. The star-clique operation on $v_{4}$ yields a 3 -cycle $G^{\prime}$ with edge labels $(a, b),(b, c)$, and $(a, c)$.

Let $\left(v_{1}, v_{2}, v_{3}, v_{4}\right) \in S_{G}$. The defining equations on $G$ are

$$
\begin{align*}
v_{4} & \equiv v_{1} \bmod c \\
v_{4} & \equiv v_{2} \bmod a  \tag{3.1}\\
v_{4} & \equiv v_{3} \bmod b
\end{align*}
$$

By the Theorem 1.4, Equation 3.1 has a solution if and only if

$$
\begin{align*}
& v_{1} \equiv v_{2} \quad \bmod (a, c) \\
& v_{2} \equiv v_{3} \bmod (a, b)  \tag{3.2}\\
& v_{3} \equiv v_{1} \bmod (b, c)
\end{align*}
$$

Note that these are in fact the defining equations of $S_{G^{\prime}}$. Thus the projection map

$$
\phi: S_{G} \rightarrow S_{G^{\prime}}
$$

defined by $\phi\left(v_{1}, v_{2}, v_{3}, v_{4}\right)=\left(v_{1}, v_{2}, v_{3}\right)$ is well defined, due to the forward direction of Theorem 1.4, and surjective by the reverse direction.

Since it's a projection map, it is also an $\mathbb{Z}$-module homomorphism. Let $K$ be the kernel of $\phi$. Then $\mathbf{g}$ is in $K=\phi^{-1}(\mathbf{0})$ if an only if $\mathbf{g}=\left(0,0,0, v_{4}\right)$ in $S_{G}$. Substituting these values into (1), we get

$$
\begin{align*}
& v_{4} \equiv 0 \bmod a \\
& v_{4} \equiv 0 \bmod b  \tag{3.3}\\
& v_{4} \equiv 0 \bmod c
\end{align*}
$$

which have as solutions $g_{4} \equiv 0 \bmod [a, b, c]$. Thus $\mathbf{g}=(0,0,0,[a, b, c])$ is a minimal element of $\mathcal{F}_{3}$ and forms a basis for $K$.

We can formalize this process for any graph.
Theorem 3.6. Let $(G, A)$ be an edge-weighted simple graph on vertices $\left\{v_{1}, \ldots, v_{n}\right\}$ and let $\left(G_{n}, A_{n}\right)$ be the result of a star-clique operation on vertex $v_{n}$. The map $\phi: S_{G} \rightarrow S_{G_{n}}$ defined by $\phi\left(g_{1}, g_{2}, \ldots, g_{n}\right)=$ $\left(g_{1}, g_{2}, \ldots, g_{n-1}\right)$ is a surjective $\mathbb{Z}$-module homomorphism with kernel $\mathcal{F}_{n-1} \cup \mathcal{F}_{n}$.

Proof. The first thing to note is that the only edges affected by a starclique operation are those incident to vertex $v$, say $v_{i_{1}}, \ldots, v_{i_{d}}$. Thus the defining equations for $S_{G}$ and $S_{G_{n}}$ only differ in that $S_{G}$ includes equations

$$
\begin{aligned}
g_{n} & \equiv g_{i_{1}} \bmod a_{i_{1}} \\
g_{n} & \equiv g_{i_{2}} \bmod a_{i_{2}} \\
& \vdots \\
g_{n} & \equiv g_{i_{d}} \bmod a_{i_{d}}
\end{aligned}
$$

whereas $S_{G_{n}}$ includes the equations

$$
g_{i_{j}} \equiv g_{i_{k}} \bmod \left(a_{i_{j}}, a_{i_{k}}\right), \text { for all } 1 \leq j \leq d
$$

By Theorem 1.4, the first set of equations implies that second, hence $\phi$ is well defined. Also by Theorem 1.4 , the second set of equations implies there exists a $g_{n}$ satisfying the first set, and since the remaining equations don't involve $g_{n}$, we have shown there exists a spline in $S_{G}$ mapping to a given spline in $S_{G_{n}}$.

Now let $K$ denote the kernel of $\phi$. Then $\mathbf{g} \in K=\phi^{-1}(\mathbf{0})$ if and only if $\mathbf{g}=\left(0, \ldots, 0, g_{n}\right)$ in $S_{G}$. If $g_{n} \neq 0$, then $\mathbf{g}$ has exactly $n$ zeroes, hence is an element of $\mathcal{F}_{n-1}$. If $g_{n}=0$, then $\mathbf{g}=\mathbf{0}$, the only element of $\mathcal{F}_{n}$.

Theorem 3.7. $\operatorname{Let}(G, A)$ be an edge weighted graph and $\left(G^{\prime}, A^{\prime}\right)$ be the result of an edge collapse operation on multiple edges $e_{1}, e_{2}, \ldots, e_{r}$. Then $S_{G^{\prime}}=S_{G}$.

Proof. Suppose that edges $e_{1}, e_{2}, \ldots, e_{r}$ each connect vertices $v$ and $w$, and have edge labels $a_{1}, a_{2}, \ldots, a_{r}$. The label for the new edge $e$ in $G^{\prime}, A^{\prime}$ is $\left[a_{1}, a_{2}, \ldots, a_{r}\right]$. Thus the only difference between the defining equations for $S_{G}$ and $S_{G^{\prime}}$ are the $r$ equations $g_{v} \equiv g_{w} \bmod a_{i}$ and the single equation $g_{v} \equiv g_{w} \bmod \left[a_{1}, a_{2}, \ldots, a_{r}\right]$ in $S_{G_{e}}$. By Lemma 1.3. these two sets of equations have the same solutions, hence $S_{G^{\prime}}=$ $S_{G}$.

In other words, collapsing multiple edges changes the graph, but not the corresponding spline module. Putting these theorems together we now state our main result of this section.

Theorem 3.8. Let $\left(G^{\prime}, A^{\prime}\right)$ be the result of a sequence of collapsing operations on an edge-weighted graph $(G, A)$ resulting in the removal of vertices $v_{r+1}, \ldots v_{n}$ and the collapsing of any multiple edges. Then the map $\phi: S_{G} \rightarrow S_{G^{\prime}}$ defined by $\phi\left(g_{1}, g_{2}, \ldots, g_{n}\right)=\left(g_{1}, g_{2}, \ldots, g_{r}\right)$ is a surjective $\mathbb{Z}$-module homomorphism with kernel $\mathcal{F}_{r} \cup \cdots \cup \mathcal{F}_{n-1} \cup \mathcal{F}_{n}$.
Proof. By Theorem 3.6, each time we do a star-clique operation, we have a surjective $\mathbb{Z}$ - module homomorphism $\phi: S_{G} \rightarrow S_{G_{v}}$, and each time we do an edge collapse, the module stays the same. Since $\phi$ is a composition of finitely many surjective $\mathbb{Z}$-module homomorphisms, it is also a surjective $\mathbb{Z}$-module homomorphism.

Let $K$ denote the kernel of $\phi$. Then $\mathbf{g} \in K=\phi^{-1}(\mathbf{0})$ if and only if $\mathbf{g}=\left(0, \ldots, 0, g_{r+1}, \ldots, g_{n}\right)$ in $S_{G}$. Since $\mathbf{g}$ has at least $r$ zeroes, it is an element of $\mathcal{F}_{i}$ for some $i \geq r$.

Corollary 3.9. Let $(G, A)$ be an edge-weighted graph on $n$ vertices and $v_{i}$ and $v_{j}$ be distinct vertices of $G$. The map $\phi: S_{G} \rightarrow S_{K_{2}}$ defined by $\phi\left(g_{1}, g_{2}, \ldots, g_{n}\right)=\left(g_{i}, g_{j}\right)$ is a surjective $\mathbb{Z}$-module homomorphism.
Proof. We start with $(G, A)$ and delete vertices one by one until there are only two vertices left. Each time we end up with multiple edges, we collapse them and replace $S_{G}$ with $S_{G_{e}}$. By Theorem 3.8 , the result now follows.

## 4. A BASIS FOR $S_{G}$

We now use the map $\phi$ to compare flow-up classes and minimal elements of $S_{G}$ and $S_{G^{\prime}}$.

Theorem 4.1. Let $\left(G^{\prime}, A^{\prime}\right)$ be the result of collapsing operations that remove vertices $v_{r+1}, \ldots, v_{n}$. Define $\phi: S_{G} \rightarrow S_{G^{\prime}}$ by $\phi\left(g_{1}, g_{2}, \ldots, g_{n}\right)=$ $\left(g_{1}, g_{2}, \ldots, g_{r}\right)$. Suppose $i<r, F \in \mathcal{F}_{i}$, and $K$ is the kernel of $\phi$. Then,
(1) $\phi(\mathcal{F})=\mathcal{F}_{i}^{\prime}$
(2) $L(F)=L(\phi(F))$.
(3) $F$ is minimal if and only if $\phi(F)$ is minimal.
(4) Let $\mathcal{B}^{\prime}$ and $\mathcal{K}$ be flow-up class bases for $S_{G^{\prime}}$ and $K$, respectively. Let $\mathcal{B}$ consist of a pre-image of each element of $\mathcal{B}^{\prime}$. Then $\mathcal{B} \cup \mathcal{K}$ is a flow-up class basis of $S_{G}$.
(5) As R-modules, $S_{G} \cong S_{G^{\prime}} \oplus K$.

Proof.
(1) If $F=\left(0, \ldots, 0, f_{i+1}, \ldots, f_{n}\right)$ has $i$ leading zeroes, then $\phi(F)=$ $\left(0, \ldots, 0, f_{i+1}, \ldots f_{r}\right)$ also has $i$ leading zeroes.
(2) $L(F)=f_{i+1}=L(\phi(F))$.
(3) If $F$ is minimal but $\phi(F)$ is not, then there is some $M^{\prime}$ in $\mathcal{F}_{i}^{\prime}$ such that $\left|L\left(M^{\prime}\right)\right|<|L(\phi F)|$. Let $M$ be in the inverse image of $M^{\prime}$. By (2), $L(M)=L\left(M^{\prime}\right)$, so $|L(M)|<|L(\phi F)|$, which contradicts the minimality of $F$. Conversely, suppose $F^{\prime}=\phi(F)$ is minimal but $F$ is not. Then there exists $M$ in $\mathcal{F}_{i}$ such that $|L(M)|<|L(F)|$. Then $L(M)=L(\phi(M))$, which implies $\mid L\left(\phi(M)\left|<\left|L\left(F^{\prime}\right)\right|\right.\right.$, contradicting the minimality of $F^{\prime}$.
(4) Since $\mathcal{B}^{\prime}$ and $\mathcal{K}$ are flow-up class bases, their leading terms are minimal in $S_{G^{\prime}}$ and $K$, respectively. Let $\mathcal{B}$ be a set of inverse images of elements of $\mathcal{B}^{\prime}$. By (3), these elements will minimal and there will be one from each flow-up class $\mathcal{F}_{0}, \ldots, \mathcal{F}_{r-1}$. To complete a basis for $S_{G}$, we need a minimal element from each remaining non-zero flow-up classes $\mathcal{F}_{r}, \ldots, \mathcal{F}_{n-1}$. By Theorem 3.8, $K=\mathcal{F}_{r} \cup \cdots \cup \mathcal{F}_{n-1} \cup \mathcal{F}_{n}$. Thus any flow-up class basis for $K$ will complete a basis of $S_{G}$, making $\mathcal{B} \cup \mathcal{K}$ a flow-up class basis for $S_{G}$.
(5) This follows from (4).

In fact, we can describe $S_{G}$ as the direct sum of rank 1 kernels of collapsing maps. First, we define a complete collapse sequence of graphs.

Definition 4.2. Let $(G, A)$ be a simple edge-weighted graph with $n$ vertices. A complete collapse sequence is a set of graphs $\left\{G_{n}, \ldots, G_{1}\right\}$, where $G=G_{n}$ and for $2 \leq i \leq n, G_{i-1}$ is result of collapsing operations that remove the vertex $v_{i}$ from $G_{i}$.

Note that each $G_{i}$ contains $i$ vertices and that $G_{1}$ is a graph consisting of the single vertex $v_{1}$.

Theorem 4.3. Let $\left\{G_{k}\right\}$ be a complete collapse sequence of $(G, A)$. Define

$$
S_{G_{n}} \xrightarrow{\phi_{n}} S_{G_{n-1}} \ldots \xrightarrow{\phi_{3}} S_{G_{2}} \xrightarrow{\phi_{2}} S_{G_{1}} \xrightarrow{\phi_{1}} 0
$$

by $\phi_{i}\left(g_{1}, g_{2}, \ldots, g_{i}\right)=\left(g_{1}, g_{2}, \ldots, g_{i-1}\right)$ for $i>1$, and $\phi_{1}\left(g_{1}\right)=0$. Let $K_{i}$ denote the kernel of $\phi_{i}$. Then
(1) $S_{G} \cong K_{1} \oplus K_{2} \oplus \cdots \oplus K_{n}$.
(2) $K_{i}$ is a rank 1 submodule of $S_{G_{i}}$.
(3) Let st $\left(v_{i}\right)$ in $G_{i}$ have edge weights $\left\{c_{1}, \ldots, c_{d}\right\}$. Then $m_{1}=(1)$ generates $K_{1}$ and and $m_{i}=\left(0,0, \ldots,\left[c_{1}, \ldots, c_{d}\right]\right)$ generates $K_{i}$, for $i>1$.
(4) For each $i<n$, let $M_{i}$ in $S_{G}$ be a pre-image of $m_{i}$ under the map $\phi_{n} \circ \phi_{n-1} \cdots \circ \phi_{i+1}$, and let $M_{n}=m_{n}$. Then $\left\{M_{1}, \ldots M_{n}\right\}$ is a flow-up class basis for $S_{G}$ where $M_{i} \in \mathcal{F}_{i-1}$.

Proof. By Theorem 4.1, for all $i>1 S_{G_{i}} \cong S_{G_{i-1}} \oplus \mathcal{K}_{i}$. When $i=n$ and $n-1$, we have $S_{G} \cong S_{G_{n-1}} \oplus \mathcal{K}_{n}$ and $S_{G_{n-1}} \cong S_{G_{n-2}} \oplus \mathcal{K}_{n-1}$. Putting these together we have

$$
S_{G}=S_{G_{n-2}} \oplus \mathcal{K}_{n} \oplus \mathcal{K}_{n-1}
$$

We can continue in this manner, down to $i=2$, to get $S_{G} \cong \mathcal{K}_{n} \oplus$ $\mathcal{K}_{n-1} \oplus \cdots \oplus \mathcal{K}_{2} \oplus S_{G_{1}}$. The last map $\phi_{1}: S_{G_{1}} \rightarrow 0$ is the zero map, so $K_{1}=S_{G_{1}}$, giving us the first result. Since $G_{1}$ has no edges, and hence no defining equations, $S_{G_{1}}=R$. Thus $K_{1}=R$, which is generated by the element (1). For $i>1$, elements of $K_{i}$ have form $\left(0,0, \ldots, 0, g_{i}\right)$. Thus $K_{i}$ is isomorphic to a non-zero submodule of $R$, hence $K_{i}$ has rank 1. Elements of $K_{i}$ correspond to vertex labels $g_{i}$ for $v_{i}$ and 0 for all other vertices, so the defining equations are $g_{i} \equiv 0 \bmod A\left(e_{j}\right)$ for each edge $e_{j}$ incident to $v_{i}$, and $0 \equiv 0 \bmod A(e)$ for all other edges. The incident edges are precisely the edges in $s t\left(v_{i}\right)$, which have weights $\left\{c_{1}, \ldots, c_{d}\right\}$. Then $\left(0,0, \ldots, 0, g_{i}\right) \in K_{i}$ if and only if $g_{i} \equiv 0 \bmod c_{j}$ for all $j$. But by Lemma 1.3 , this is equivalent to $g_{i} \equiv 0 \bmod \left[c_{1}, \ldots, c_{d}\right]$. So $m_{i}=\left(0,0, \ldots,\left[c_{1}, \ldots, c_{d}\right]\right)$ is a minimal element of $K_{i}$, which means $m_{i}$ generates $K_{i}$.

Finally, since $m_{i}$ is a minimal element of of the $i-1$ st flow-up class of $S_{G_{i}}$, any pre-image $M_{i}$ in $S_{G}$ will be a minimal element of $\mathcal{F}_{i-1}$, by Theorem 4.1. Thus the $M_{i}$ 's form a flow-up class basis of $S_{G}$.

This gives a procedure for constructing a basis $\left\{M_{1}, \ldots M_{n}\right\}$ for $S_{G}$. For $i>1, M_{i}$ has leading term $\left[c_{1}, \ldots, c_{d}\right]$ where $\left\{c_{1}, \ldots, c_{d}\right\}$ are weights of edges incident to vertex $v_{i}$ in $G_{i}$, and we can use the Chinese Remainder Theorem to explicitly construct the other terms of $M_{i}$. When

$i=1, G_{1}$ is a single vertex with no edges. Since there are no restrictions, $m_{1}=(1)$, and it's trivial to see that $M_{1}=(1, \ldots, 1)$ is always a spline in $S_{G}$.

Example 4.4. Let $G=K_{4}$ with the sequence of collapsing operations in Figures 6a through 6e.

In order to find $M_{4}$, we set $g_{1}=0, g_{2}=0, g_{3}=0$ in Figure 6a. This gives us the follow equations.

$$
\begin{aligned}
& g_{4} \equiv 0 \bmod 12 \\
& g_{4} \equiv 0 \bmod 15 \\
& g_{4} \equiv 0 \bmod 8
\end{aligned}
$$

By Theorem 4.3, the leading term $g_{4}$ will be the LCM of the edge weights incident to $v_{4}$, so $g_{4}=[12,15,8]=120$. This gives basis element $M_{4}=(0,0,0,120)$.

Next let $g_{1}=0, g_{2}=0$ in (Figure 6c). The equations are

$$
\begin{aligned}
g_{3} & \equiv 0 \bmod 20 \\
g_{3} & \equiv 0 \bmod 12
\end{aligned}
$$

which has least solution $g_{3}=[12,20]=60$. We can let $g_{4}=0$, which gives us a basis element $M_{3}=(0,0,60,0)$.

Now consider Figure 6e and let $g_{1}=0$. Then $g_{2} \equiv 0 \bmod 12$, so $g_{2}=12$ is minimal. We are guaranteed values for $g_{3}$ and $g_{4}$ by the Chinese Remainder Theorem, but in this case we easily find a basis element $M_{2}=(0,12,12,12)$.

Finally, we can always set $M_{1}=(1,1,1,1)$.
In the next section we find an alternate construction of $L\left(M_{i}\right)$, in terms of the original edge weights of $G$. This construction does not require collapsing $G$ to the graph $G_{i}$, in terms of the original edge weights of $G$.

## 5. Leading Terms of Basis Elements

Let $(G, A)$ be an edge-weighted graph and let $\left(G^{\prime}, A^{\prime}\right)$ be the result of a star-clique operation removing vertex $v$ from $G$. Let $w$ and $u$ be vertices in $G$ distinct from $v$. We introduce the following notation.

- $(p)=$ the GCD of the edge labels of a path $p$.
- $\mathcal{P}=$ the set of paths between $w$ and $u$ in $G$.
- $\mathcal{Q}=$ the set of paths between $w$ and $u$ in $G^{\prime}$.
- $[\mathcal{P}]=$ the LCM of the $(p)$ 's, where $p \in \mathcal{P}$.
- $[\mathcal{Q}]=$ the LCM of the $(q)$ 's, where $q \in \mathcal{Q}$.

Next, we show that $[\mathcal{P}]$ is invariant under the star-clique operation.
Lemma 5.1. Let $v$ be a vertex of $G$ and let $\left(G^{\prime}, A^{\prime}\right)$ be the result a star-clique operation. Let $w, u$ be vertices in $G$ distinct from $v$. Then $[\mathcal{P}]=[\mathcal{Q}]$.

Proof. We partition $\mathcal{P}$ into two sets:

- $\mathcal{P}_{+}=$paths that include $v$;
- $\mathcal{P}_{-}=$paths not including $v$.

Let $p$ be a path in $\mathcal{P}_{-}$. Since this path doesn't includes $v$, it will also be a path in $G^{\prime}$, hence $p$ is in $\mathcal{Q}$. Now let $p$ be a path in $\mathcal{P}_{+}$with edge labels $c_{1}, c_{2}, \ldots, c_{n}$. Since this $p$ includes $v$, it contains two vertices $x$ and $y$ and two edges $e$ and $f$ adjacent to $v$, with edge labels $c_{i}$ and $c_{i+1}$. Thus,

$$
(p)=\left(c_{1}, c_{2}, \ldots, c_{i}, c_{i+1}, \ldots, c_{n}\right)
$$

However, by the star-clique construction, there will be an edge in $G^{\prime}$ directly between $x$ and $y$ with edge label $\left(c_{i}, c_{i+1}\right)$. Consequently there is a path $p^{\prime}$ in $G^{\prime}$ with

$$
\left(p^{\prime}\right)=\left(c_{1}, c_{2}, \ldots,\left(c_{i}, c_{i+1}\right), \ldots, c_{n}\right)
$$

But since $(a,(b, c))=(a, b, c)$, we have $(p)=\left(p^{\prime}\right)$.
Now let $q=e_{1} \cdots e_{n}$ be a path in $\mathcal{Q}$ and

$$
(q)=\left(c_{1}, c_{2}, \ldots, c_{n}\right)
$$

If an $e_{i}$ was not an edge in $G$, then its vertices $x$ and $y$ must be adjacent to $v$ in $G$. Thus there are edges $e_{x}$ and $e_{y}$ in $G$ with weights $c_{x}$ and $c_{y}$, which means $e_{i}$ in $G^{\prime}$ has weight $c_{i}=\left(c_{x}, c_{y}\right)$. Let $q_{i}=$ $e_{1} \cdots e_{i-1} e_{x} e_{y} e_{i+1} e_{n}$, then

$$
\begin{aligned}
& \left(q_{i}\right)=\left(c_{1}, c_{2}, \ldots, c_{i-1}, c_{x}, c_{y}, c_{i+1}, \ldots, c_{n}\right) \\
& =\left(c_{1}, c_{2}, \ldots, c_{i-1},\left(c_{x}, c_{y}\right), c_{i+1}, \ldots, c_{n}\right) \\
& =\left(c_{1}, c_{2}, \ldots, c_{i-1}, c_{i}, c_{i+1}, \ldots, c_{n}\right)=(q)
\end{aligned}
$$

Since we can do this for each such edge $e_{i}$, we see that there is a path $q^{+}$in $G$ with $\left(q^{+}\right)=(q)$. Consequently, the GCDs used to compute $[\mathcal{P}]$ are identical to the GCDs used to compute $[\mathcal{Q}]$, so $[\mathcal{P}]=[\mathcal{Q}]$.

We now prove that $[\mathcal{P}]$ is invariant under edge-collapse.
Lemma 5.2. Let $\left(G^{\prime}, A^{\prime}\right)$ be the result an edge-collapse operation, and let $w, u$ be vertices of $G$. Then $[\mathcal{P}]=[\mathcal{Q}]$.

Proof. Let $d_{1}, d_{2}, \ldots, d_{r}$ with weights $c_{1} c_{2}, \ldots, c_{r}$ be the edges in $G$ that are collapsed to an edge $d$ with weight $c=\left[c_{1}, c_{2}, \ldots, c_{r}\right]$ in $G^{\prime}$.

We can partition $\mathcal{P}$ and $\mathcal{Q}$ into two sets:

- $\mathcal{P}_{1}=$ paths that include any of the $d_{i}$
- $\mathcal{P}_{2}=$ paths that include none of the $d_{i}$
- $\mathcal{Q}_{1}=$ paths that include $d$
- $\mathcal{Q}_{2}=$ paths that don't include $d$

Let $p \in \mathcal{P}_{2}$. Since $p$ does not include any $d_{i}$, all of its edges are in $G^{\prime}$, so $p \in \mathcal{Q}_{2}$. Similary, if $p \in \mathcal{Q}_{2}$ then $p \in \mathcal{P}_{2}$. Thus $\mathcal{P}_{2}=\mathcal{Q}_{2}$.

Now let $p_{1} \in \mathcal{P}_{1}$ contain edges $d_{1}$, with remaining edges $e_{1}, \ldots, e_{s}$ in both $G$ and $G^{\prime}$, and edge weights $a_{1}, \ldots, a_{s}$. Clearly, for each $1<i \leq r$ there is a path $p_{i} \in \mathcal{P}_{1}$ with edges $d_{i}, e_{1}, \ldots, e_{s}$. Thus we have

$$
\begin{aligned}
\left(p_{1}\right) & =\left(c_{i}, a_{1}, a_{2}, \ldots, a_{s}\right) \\
\left(p_{2}\right) & =\left(c_{i}, a_{1}, a_{2}, \ldots, a_{s}\right) \\
\vdots & \\
\left(p_{r}\right) & =\left(c_{i}, a_{1}, a_{2}, \ldots, a_{s}\right)
\end{aligned}
$$

These correspond directly to the path $p^{\prime}$ in $\mathcal{Q}_{1}$ with edges $d, e_{1}, \ldots, e_{s}$ and

$$
\left(p^{\prime}\right)=\left(\left[c_{1}, c_{2}, \ldots, c_{r}\right], a_{1}, a_{2}, \ldots, a_{s}\right)
$$

Similarly, any $p^{\prime} \in \mathcal{Q}_{1}$ corresponds to $p_{1}, \ldots, p_{r}$ in $\mathcal{P}_{\infty}$. Let $a=$ $\left(a_{1}, a_{2}, \ldots a_{n}\right)$. By repeated applications of Lemma 1.3, we have

$$
\begin{aligned}
{\left[\left(p_{1}\right), \ldots\left(p_{r}\right)\right] } & =\left[\left(c_{1}, a_{1}, a_{2}, \ldots a_{s}\right), \ldots,\left(c_{r}, a_{1}, a_{2}, \ldots a_{s}\right)\right] \\
& \left.\left.=\left[\left(c_{1},\left(a_{1}, a_{2}, \ldots a_{s}\right)\right), \ldots a_{s}\right)\right), \ldots,\left(c_{r},\left(a_{1}, a_{2}, \ldots a_{s}\right)\right)\right] \\
& =\left[\left(c_{1}, a\right), \ldots,\left(c_{r}, a\right)\right] \\
& =\left[\left(a,\left[c_{1}, \ldots, c_{r}\right)\right]\right. \\
& =\left(p^{\prime}\right)
\end{aligned}
$$

Let $\mathcal{Q}_{1}=\left\{x_{1}, \ldots x_{m}\right\}, \mathcal{Q}_{2}=\left\{y_{1}, \ldots, y_{k}\right\}$ and $y=\left[y_{1}, \ldots y_{k}\right]$. Then each $x_{i} \in \mathcal{Q}_{\infty}$ corresponds to $r$ different paths $x_{i j} \in \mathcal{P}_{1}$, and by above, $\operatorname{each}\left(x_{i}\right)=\left[\left(x_{i 1}\right), \ldots\left(x_{i r}\right)\right]$.

By repeated applications of Lemma 1.3 we have

$$
\begin{aligned}
{[\mathcal{Q}] } & =\left[\left(x_{1}\right), \ldots,\left(x_{m}\right),\left(y_{1}\right), \ldots,\left(y_{k}\right)\right] \\
& =\left[\left(x_{1}\right), \ldots,\left(x_{m}\right),\left[\left(y_{1}\right), \ldots,\left(y_{k}\right)\right]\right. \\
& =\left[\left(x_{1}\right), \ldots,\left(x_{m}\right), y\right] \\
& \left.=\left[\left(x_{11}\right), \ldots,\left(x_{1 r}\right)\right], \ldots,\left[\left(x_{m 1}\right), \ldots,\left(x_{m r}\right)\right], y\right] \\
& \left.=\left[\left(x_{11}\right), \ldots,\left(x_{1 r}\right)\right], \ldots,\left[\left(x_{m 1}\right), \ldots,\left(x_{m r}\right)\right],\left[\left(x_{1}\right), \ldots,\left(x_{m}\right),\left(y_{1}\right), \ldots,\left(y_{k}\right)\right]\right] \\
& =\left[\left(x_{11}\right), \ldots,\left(x_{1 r}\right), \ldots,\left(x_{m 1}\right), \ldots\left(x_{m r}\right),\left(x_{1}\right), \ldots,\left(x_{m}\right),\left(y_{1}\right), \ldots,\left(y_{k}\right)\right] \\
& =[\mathcal{P}]
\end{aligned}
$$

We have the following important corollary.

Corollary 5.3. Let $w, u$ be two vertices in both $G$ and $G^{\prime}$. The LCM of the GCD of all paths from $w$ to $u$ is invariant under collapsing operations taking $G$ to $G^{\prime}$.

Using this result, we can construct leading terms of basis elements in terms of LCMs and GCDs of the edge weights of $G$.

Theorem 5.4. Let $M_{1}, M_{2}, \ldots M_{n}$ be a flow up class basis for $S_{G}$ and let $\mathcal{P}_{i j}$ denote the set of paths from $v_{i}$ to $v_{j}$ in $S_{G}$ where $i<j$. Then $L\left(M_{1}\right)=1$, and for $i>1$, and $L\left(M_{i}\right)=\left[\left[\mathcal{P}_{i 1}\right],\left[\mathcal{P}_{i 2}\right], \ldots,\left[\mathcal{P}_{i, i-1}\right]\right]$.

Proof. $M_{1}=(1, \ldots, 1)$ is minimal in $\mathcal{F}_{0}$ since 1 is minimal in $\mathbb{N}$. We know from Theorem that $L\left(M_{i}\right)=L\left(m_{i}\right)$ where $m_{i}=\left(0,0, \ldots,\left[c_{1}, \ldots, c_{r}\right]\right)$ is a minimal element of $K_{i}$, and $c_{j}$ is the edge label of the edge between $v_{i}$ and $v_{j}$, for all $j \leq r \leq i$. (If necessary we can temporarily reorder the $v_{j}$ 's incident to $v_{i}$ so that they are vertices $v_{1}, \ldots, v_{r}$.) For each $j$, the edge $e_{j}$ with label $c_{j}$ is the only path form $v_{i}$ to $v_{j}$ in $G_{i}$. By Lemma 1.3, this means that $c_{j}=\left[\mathcal{P}_{i j}\right]$. Then $L\left(M_{i}\right)=\left[c_{1}, \ldots, c_{r}\right]=$ $\left[\left[\mathcal{P}_{i 1}\right],\left[\mathcal{P}_{i 2}\right], \ldots,\left[\mathcal{P}_{i, r}\right]\right]$. If $r=i-1$, we are done. If $r<i$, let $p$ be a path from $v_{i}$ to $v_{k}$ where $r<k \leq i$. This path necessarily passes through some $v_{j}$ for some $j \leq r$, so $d_{j}$ is one of the edges of $p$. Let $b$ be the GCD of the edge weights of the remaining edges of $p$. Then $(p)=\left(c_{j}, b\right)$. Since $(p)$ divides $c_{j}$, we have $\left[c_{j}\right]=\left[c_{j},(p)\right]$ and thus $\left[c_{1}, \ldots, c_{r}\right]=$ $\left[c_{1}, \ldots, c_{r},(p)\right]$. Since we can do this for any path from $v_{i}$ to $v_{k}$, we get that $\left[c_{1}, \ldots, c_{r}\right]=\left[c_{1}, \ldots, c_{r},\left[P_{i k}\right]\right]$ and by varying $k$ we get that $L\left(M_{i}\right)=\left[c_{1}, \ldots, c_{r},\left[\mathcal{P}_{i, r}\right], \ldots,\left[\mathcal{P}_{i, i-1}\right]\right]=\left[\left[\mathcal{P}_{i 1}\right],\left[\mathcal{P}_{i 2}\right], \ldots,\left[\mathcal{P}_{i, i-1}\right]\right]$.

We see from this proof that we don't need to check all paths from $v_{i}$ to all vertices $v_{j}$, just paths from $v_{i}$ to $v_{j}$ where all interior vertices have subscripts bigger than $i$. An easy way to identify these paths is to label all vertices $v_{1}$ to $v_{i-1}$ with 0 's, and use only paths from $v_{i}$ to the first 0 you run into.

Example 5.5. We will use Theorem 5.4 to compute the leading terms of a flow class basis for $S_{G}$, the $K_{4}$ graph of Figure 7 .
(1) First, we have $L\left(M_{1}\right)=1$.
(2) In order to find $L\left(M_{2}\right)$ we set $g_{1}=0$ as in Figure 8a. Then $L\left(M_{2}\right)$ is the LCM of the GCD of all paths from $g_{2}$ to any vertex labeled 0 . These paths are:

- $g_{2} g_{1}$, which has edge weight 6 ,
- $g_{2} g_{4} g_{1}$, which has edge weights 12,15
- $g_{2} g_{3} g_{1}$, which has edge weights 20,6
- $g_{2} g_{4} g_{3} g_{1}$, which has edge weights $15,8,6$
- $g_{3} g_{4} g_{1}$, which has edge weights $20,8,12$

Thus $L\left(M_{2}\right)=[6,(12,15),(20,6),(15,8,6),(20,8,12)]=[6,3,2,1,4]=$ 12.
(3) For $L\left(M_{3}\right)$, we set both $g_{1}, g_{2}$ equal 0 as in Figure 8b. The paths from $g_{3}$ to any vertex labeled 0 are:

- $g_{3} g_{2}$, with edge weight 20 ,
- $g_{3} g_{1}$, with edge weight 6 ,
- $g_{3} g_{4} g_{1}$, with edge weights 8,12
- $g_{3} g_{4} g_{2}$, with edge weights 8,15

Thus $L\left(M_{3}\right)=[20,6,(8,12),(8,15)]=[20,6,4,1]=60$.
(4) Finally to compute $L\left(M_{4}\right)$ we set $g_{1}, g_{2}, g_{3}$ equal to 0 , as in Figure 8r, and find the paths from $g_{4}$ to 0 :

- $g_{4} g_{1}$, with weight 12 ,
- $g_{4} g_{2}$, with weight 15 ,
- $g_{4} g_{3}$, with weight 8 ,

Then $L\left(M_{4}\right)=[12,15,8]=120$.
Thus the leading terms of $M_{1}, M_{2}, M_{3}, M_{4}$ are $1,12,60$, and 120 respectively. These agree with the leading terms found in Example 4.4, illustrating that Theorems 4.3 and 5.4 provide two different ways to contruct the same basis for $S_{G}$.
