# Ramsey numbers for complete graphs versus generalized fans

#### Abstract

For two graphs $G$ and $H$, let $r(G, H)$ and $r_{*}(G, H)$ denote the Ramsey number and star-critical Ramsey number of $G$ versus $H$, respectively. In 1996, Li and Rousseau proved that $r\left(K_{m}, F_{t, n}\right)=\operatorname{tn}(m-1)+1$ for $m \geq 3$ and sufficiently large $n$, where $F_{t, n}=K_{1}+n K_{t}$. Recently, Hao and Lin proved that $r\left(K_{3}, F_{3, n}\right)=6 n+1$ for $n \geq 3$ and $r_{*}\left(K_{3}, F_{3, n}\right)=3 n+3$ for $n \geq 4$. In this paper, we show that $r\left(K_{m}, s F_{t, n}\right)=\operatorname{tn}(m+s-2)+s$ for sufficiently large $n$ and, in particular, $r\left(K_{3}, s F_{t, n}\right)=t n(s+1)+s$ for $t \in\{3,4\}, n \geq t$ and $s \geq 1$. We also show that $r_{*}\left(K_{3}, F_{4, n}\right)=4 n+4$ for $n \geq 4$ and establish an upper bound on $r\left(F_{2, m}, F_{t, n}\right)$.


Keywords: Ramsey number; star-critical Ramsey number; complete graph; generalized fan

## 1 Introduction

For two graphs $G$ and $H$, we denote by $r(G, H)$ the Ramsey number of $G$ versus $H$, that is, the minimum integer $r$ such that any red/blue edge-coloring of $K_{r}$ contains a red $G$ or a blue $H$. By the definition, $K_{r-1}$ has a red/blue edge-coloring that contains neither a red copy of $G$ nor a blue copy of $H$. We call such a coloring a $(G, H)$-free coloring. For two vertex disjoint graphs $G_{1}$ and $G_{2}$, we denote by $G_{1}+G_{2}$ the join of $G_{1}$ and $G_{2}$, that is, the graph obtained from $G_{1}$ and $G_{2}$ by adding all edges between $V\left(G_{1}\right)$ and $V\left(G_{2}\right)$. Further, for a graph $G$ and positive integer $n$, the disjoint union of $n$ copies of $G$ is denoted by $n G$. For positive integer $n$, the fan $F_{n}$ is defined as $K_{1}+n K_{2}$. Generally, the generalized fan $F_{t, n}$ is defined by $K_{1}+n K_{t}$. It is clear that $F_{2, n}=F_{n}$.

Ramsey theory is a fascinating branch in combinatorics. Most problems in this area are far from being solved, which stem from the classic problem of determining the number $r\left(K_{n}, K_{n}\right)$. In this paper we focus on the Ramsey numbers for complete graphs versus generalized fans.

[^0]In [14], Li and Rousseau proved the following result.
Theorem 1.1. 14] For any graphs $G$ and $H$, there is a positive integer $n(G, H)$ such that for any integer $n \geq n(G, H)$,

$$
r\left(K_{2}+H, K_{1}+n G\right)=k n(\chi(H)+1)+1
$$

where $k$ is the number of the vertices in $G$ and $\chi(H)$ the chromatic number of $H$.
Conjecture 1.2. [3] For any $n \geq m \geq 3, r\left(K_{m}, F_{n}\right)=2 n(m-1)+1$.

Choosing $G=K_{2}$ and $H=K_{m-2}$ in Theorem 1.1, we see that Theorem 1.1 supports Conjecture 1.2 for any $m$ and sufficiently large $n$. In contrast to sufficiently large $n$, the conjecture is also confirmed for some small $m$ 's as follows.

Theorem 1.3. The following statement holds:
(i) $r\left(K_{3}, F_{n}\right)=4 n+1$ for any $n \geq 3$ [6, 14];
(ii) $r\left(K_{4}, F_{n}\right)=6 n+1$ for any $n \geq 4$ [3];
(iii) $r\left(K_{5}, F_{n}\right)=8 n+1$ for any $n \geq 5$ [5];
(iv) $r\left(K_{6}, F_{n}\right)=10 n+1$ for any $n \geq 6[13]$.

Let $K_{r-1} \sqcup S_{k}$ denote the graph obtained from $K_{r-1}$ by adding a new vertex $v$ and an edge joining $v$ to each of $k$ vertices of $K_{r-1}$. For $r=r(G, H)$, the star-critical Ramsey number $r_{*}(G, H)$ is defined as the minimum integer $r_{*}$ such that any red/blue edge-coloring of $K_{r-1} \sqcup S_{r_{*}}$ contains a red $G$ or a blue $H$. This parameter was first introduced by Hook and Isaak [10], which could be viewed as a refinement of the Ramsey number. For results on star-critical Ramsey numbers involving $F_{t, n}$, we refer the readers to references [7, 8, 12, 15, 16]. In [7], Hao and Lin determined the Ramsey number and the star-critical Ramsey number of $K_{3}$ versus $F_{3, n}$.

Theorem 1.4. 77] $r\left(K_{3}, F_{3, n}\right)=6 n+1$ for any integer $n \geq 3$ and $r_{*}\left(K_{3}, F_{3, n}\right)=3 n+3$ for any integer $n \geq 4$.

Recently, Hamm et al. [9] determined the Ramsey number of $s K_{m}$ versus $F_{t, n}$ for sufficiently large $n$ as follows.

Theorem 1.5. [9] Let $m, s, t, n$ be four positive integers with $m \geq 3$ and tn $\geq \max \{(m+$ $\left.1)(m+C(t, m)+t)+3, \frac{(m-1)^{2}}{m-2}((s-1)(m-1)+t)\right\}$, where $C(t, m)$ is a constant depending only on $t$ and $m$. Then $r\left(s K_{m}, F_{t, n}\right)=\operatorname{tn}(m-1)+s$.

In 1975, Burr, Erdős and Spencer [1] investigated Ramsey number for disjoint union of small graphs and showed that $r\left(n K_{3}, n K_{3}\right)=5 n$ for $n \geq 2$. Li and Rousseau [14] first studied offdiagonal Ramsey number of fans. They showed that $4 n+1 \leq r\left(F_{m}, F_{n}\right) \leq 4 n+4 m-2$ for $n \geq m \geq 1$. Later in [17], Lin and Li proved that $r\left(F_{2}, F_{n}\right)=4 n+1$ for $n \geq 2$ and improved the upper bound of Li and Rousseau to be $r\left(F_{m}, F_{n}\right) \leq 4 n+2 m$ for $n \geq m \geq 2$. Recently, Chen, Yu and Zhao [4] showed that $9 n / 2-5 \leq r\left(F_{n}, F_{n}\right) \leq 11 n / 2+6$ for any $n$. For more results on Ramsey numbers involving $F_{t, n}$, we refer the readers to references [18, 20, 21].

In this paper, we prove the following two results.

Theorem 1.6. For any integer $n \geq 4, r\left(K_{3}, F_{4, n}\right)=8 n+1$ and $r_{*}\left(K_{3}, F_{4, n}\right)=4 n+4$.
Theorem 1.7. Let $m, s, t$, $n$ be four positive integers with $n \geq m \geq 3$. Then $\operatorname{tn}(m+s-2)+s \leq$ $r\left(K_{m}, s F_{t, n}\right) \leq(t n+1)(s-1)+r\left(K_{m}, F_{t, n}\right)$.

As direct consequences of Theorem 1.4, Theorem 1.6-1.7 and Theorem 1.5, Theorem 1.7, respectively, we have the following two corollaries.

Corollary 1.8. $r\left(K_{3}, s F_{t, n}\right)=\operatorname{tn}(s+1)+s$ for any $t \in\{3,4\}, n \geq t$ and $s \geq 1$.

Corollary 1.9. Let $m, s, t$, $n$ be four positive integers with $m \geq 3$ and $t n \geq \max \{(m+$ $\left.1)(m+C(t, m)+t)+3, \frac{(m-1)^{2}}{m-2} t\right\}$, where $C(t, m)$ is a constant depending only on $t$ and $m$. Then $r\left(K_{m}, s F_{t, n}\right)=\operatorname{tn}(m+s-2)+s$.

Further, combining Theorem 1.7 with Conjecture 1.2 and Theorem 1.3, we have the following corollary.

Corollary 1.10. Let $m, s$, $t$, $n$ be four positive integers with $n \geq m \geq 3$. If $3 \leq m \leq 6$, then $r\left(K_{m}, s F_{n}\right)=2 n(s+m-2)+s$. In general, if Conjecture 1.2 is true, then $r\left(K_{m}, s F_{n}\right)=$ $2 n(s+m-2)+s$.

Finally, we prove the following result.
Theorem 1.11. Let $t$, $n, m$ be three positive integers with $t \geq 3$ and $2 m \geq \max \{(t+1)(t+$ $\left.C(t)+2)+3, \frac{(t-1)^{2}}{t-2}((n-1)(t-1)+2)\right\}$ where $C(t)$ is a constant depending only on $t$. Then $r\left(F_{m}, F_{t, n}\right) \leq \max \{m, n\}+(t-1)(2 m+n)+n+m$.

In the following section, we give a proof of Theorem 1.6 and, in the last section, we give the proofs of Theorem 1.7 and Theorem 1.11 .

## 2 Proof of Theorem 1.6

Let $G=(V, E)$ be a graph. For any subset $S \subseteq V$ or $S \subseteq E$, we use $G[S]$ to denote the subgraph of $G$ induced by $S$. A neighbour of a vertex $v$ is a vertex adjacent to $v$. The set of all neighbours of $v$ is denoted by $N_{G}(v)$ and the degree of $v$ is defined to be $d_{G}(v)=\left|N_{G}(v)\right|$. For a subset $U \subseteq V, N_{G}(v, U)$ denotes the set of all neighbors of $v$ in $U$ and $d_{G}(v, U)=\left|N_{G}(v, U)\right|$ denotes the degree of $v$ in $U$. In the definition of Ramsey number, a red/blue edge-coloring of $K_{r}$ on vertex set $V$ can be associated with graphs $(V, R)$ and $(V, B)$, where $R$ and $B$ consist of all red and blue edges, respectively. Thus they are complementary to each other. Conversely, any graph $G$ and its complement $\bar{G}$ can be associated with a red/blue edge-coloring of a complete graph on $V$ in which the edges in $G$ and $\bar{G}$ are colored in red and blue, respectively. Throughout the following, for a red/blue edge-coloring, we also use $R$ (or $B$ ) to denote the spanning subgraph induced by the red edges (or blue edges) if no confusion can occur.

The chromatic surplus $s(G)$ of a graph $G$ is the minimum size of a color class over all proper vertex-colorings of $G$ by using $\chi(G)$ colors. Burr [2] proved that, for any connected graph $H$ of order $n \geq s(G)$,

$$
\begin{equation*}
r(G, H) \geq(\chi(G)-1)(n-1)+s(G) \tag{1}
\end{equation*}
$$

A graph $H$ is called $G$-good if the equality in (1) holds.
Let $U_{1}, U_{2}, \ldots, U_{\chi(G)}$ be the color classes of vertices under a proper vertex coloring of $G$ and $\left|U_{1}\right|=s(G)$. Denote

$$
\tau(G)=\min \min _{v \in U_{1}} \min _{2 \leq i \leq \chi(G)} d_{G}\left(v, U_{i}\right),
$$

where the first minimum is taken over all proper vertex colorings of $G$ with $\chi(G)$ colors.
We begin our proof with the following four lemmas.
Lemma 2.1. [19] For $n \geq m \geq 1$ and $n \geq 2, r\left(m K_{3}, n K_{4}\right)=4 n+2 m+1$.
Lemma 2.2. [7, 8] Let $G$ be a graph with $\chi(G) \geq 2$, and $H$ a connected graph of order $n \geq s(G)$ with minimum degree $\delta(H)$. If $H$ is $G$-good, then $r_{*}(G, H) \geq(\chi(G)-2)(n-1)+\min \{n, \delta(H)+$ $\tau(G)-1\}$.

Lemma 2.3. Let $G$ be a graph whose vertex set is partitioned into three subsets $V_{1}, V_{2}$ and $V_{3}$ with $G\left[V_{1}\right]=K_{4 n-k}$ and $G\left[V_{2}\right]=K_{4 n-k}$, where $1 \leq k \leq 3$ and $n \geq 4$. If $G$ has independence number $\alpha(G)$ at most two and contains no $F_{4, n}$, then for every vertex $w \in V_{3}, w$ is adjacent to all vertices of either $V_{1}$ or $V_{2}$.

Proof. Suppose to the contrary that $w$ is not adjacent to $u$ of $V_{1}$ and $v$ of $V_{2}$ for some vertex $w$ of $V_{3}$. If $w$ has four nonadjacent vertices $u, u_{1}, u_{2}, u_{3}$ of $V_{1}$, then these four vertices must be
adjacent to $v$, otherwise $\alpha(G) \geq 3$, which is a contradiction. In this way, $G\left[V_{2} \cup\left\{u, u_{1}, u_{2}, u_{3}\right\}\right]$ contains an $F_{4, n}$ with $v$ as its center, also a contradiction. Therefore, $w$ has at most three nonadjacent vertices in $V_{1}$. That is, $w$ has at least $4 n-k-3$ neighbors in $V_{1}$. For the same reason, $w$ has at least $4 n-k-3$ neighbors in $V_{2}$. We can find $n-2$ disjoint $K_{4}$ in $N_{G}\left(w, V_{1}\right)$ and two disjoint $K_{4}$ in $N_{G}\left(w, V_{2}\right)$, which together with $w$ form an $F_{4, n}$, a contradiction.

Lemma 2.4. For any $n \geq 4, B \supseteq 2 K_{4 n}$ for any $\left(K_{3}, F_{4, n}\right)$-free coloring of $K_{8 n}$.

Proof. Consider any $\left(K_{3}, F_{4, n}\right)$-free coloring of $K_{8 n}$. By Lemma 2.1, we know that $r\left(K_{3}, n K_{4}\right)=$ $4 n+3$, which implies that $d_{B}(u) \leq 4 n+2$ or, equivalently, $d_{R}(u) \geq 4 n-3$ for any vertex $u \in V$. Since $R$ contains no red $K_{3}, N_{R}(u)$ contains a blue $K_{4 n-3}$, denoted by $G_{1}$. Choose a vertex $v$ from $V\left(G_{1}\right)$. Since $d_{R}(v) \geq 4 n-3, N_{R}(v)$ also contains a blue $K_{4 n-3}$, denoted by $G_{2}$. Therefore, we have $B \supseteq 2 K_{4 n-3}$.

Let $V_{1}=V\left(G_{1}\right), V_{2}=V\left(G_{2}\right)$ and $V_{3}=V\left(K_{8 n}\right) \backslash\left(V_{1} \cup V_{2}\right)$. We note that $V_{3}$ consists of exactly six vertices. By Lemma 2.3, we know that every vertex in $V_{3}$ is blue-adjacent (adjacent by a blue edge) to all vertices of either $G_{1}$ or $G_{2}$. If at least four vertices in $V_{3}$ are blueadjacent to all vertices of either $G_{1}$ or $G_{2}$, then either $B\left[V_{3} \cup V_{1}\right]$ or $B\left[V_{3} \cup V_{2}\right]$ contains a blue $F_{4, n}$, a contradiction. By symmetry, this means that exactly three vertices in $V_{3}$, say $x_{1}, x_{2}, x_{3}$, are blue-adjacent to all vertices in $V_{1}$ while the other three vertices, denoted by $x_{4}, x_{5}, x_{6}$, are blue-adjacent to all vertices in $V_{2}$.

If $x_{1}$ is blue-adjacent to at least four vertices in $V_{2}$, then $B$ has an $F_{4, n}$ with $x_{1}$ as its center, a contradiction. Hence, $x_{1}$ is blue-adjacent to at most three vertices in $V_{2}$. For the same reason, each of $x_{2}$ and $x_{3}$ is blue-adjacent to at most three vertices in $V_{2}$. Equivalently, each of $x_{1}, x_{2}$ and $x_{3}$ is red-adjacent to at least $4 n-6$ vertices in $V_{2}$. Therefore, each pair of $x_{1}, x_{2}$ and $x_{3}$ are red-adjacent to a common vertex in $V_{2}$ as $\left|V_{2}\right|=4 n-3$. This implies that $x_{1} x_{2}, x_{2} x_{3}$ and $x_{1} x_{3}$ are blue edges to avoid a red $K_{3}$. By symmetry, $x_{4} x_{5}, x_{5} x_{6}$ and $x_{4} x_{6}$ are also blue edges. As a result, $B\left[\left\{x_{1}, x_{2}, x_{3}\right\} \cup V_{1}\right]=K_{4 n}$ and $B\left[\left\{x_{4}, x_{5}, x_{6}\right\} \cup V_{1}\right]=K_{4 n}$, i.e., $B \supseteq 2 K_{4 n}$.

Proof of Theorem 1.6; We first prove that $r\left(K_{3}, F_{4, n}\right)=8 n+1$ for $n \geq 4$. By (1), $r\left(K_{3}, F_{4, n}\right) \geq 8 n+1$ follows immediately. We now need only to show the converse. Consider a red/blue edge-coloring of $K_{8 n+1}$. Suppose to the contrary that $K_{8 n+1}$ contains neither red $K_{3}$ nor blue $F_{4, n}$. Choose an arbitrary vertex $u \in V\left(K_{8 n+1}\right)$. Since the red neighborhood (the neighbour adjacent by red edges) $N_{R}(u)$ of $u$ induces a blue complete graph, we have $d_{R}(u) \leq 4 n$ and, hence, $d_{B}(u) \geq 4 n$. Let $K_{8 n+1}=K_{8 n}+u$. It is clear that the red/blue edge-coloring restricted on $K_{8 n}$ is also a $\left(K_{3}, F_{4, n}\right)$-free coloring. So by lemma 2.4, we have $B-u \supseteq 2 K_{4 n}$. Therefore, $K_{8 n+1}$ contains a blue $F_{4, n}$, a contradiction.

Next, we prove that $r_{*}\left(K_{3}, F_{4, n}\right)=4 n+4$. Note that $r_{*}\left(K_{3}, F_{4, n}\right) \geq 4 n+4$ follows directly from lemma 2.2. We now prove its converse.

Consider any $\left(K_{3}, F_{4, n}\right)$-free coloring for $K_{8 n}$. Lemma 2.4 implies that the blue graph $B \supseteq$ $2 K_{4 n}$. Let $V_{1}$ and $V_{2}$ be the vertex sets of the two blue $K_{4 n}$ 's, respectively. Add a new vertex $v$ and an edge joining $v$ to each of $4 n+4$ vertices in $V_{1} \cup V_{2}$. It suffices to show that, no matter how to color these $4 n+4$ edges, we can always find either a red $K_{3}$ or a blue $F_{4, n}$.

Note that for $n \geq 4$, there are at least four edges between $v$ and $V_{i}$ for each $i \in\{1,2\}$. Further, $v$ is adjacent to at least ten vertices of either $V_{1}$ or $V_{2}$, say $V_{1}$. Take $\left\{u_{1}, u_{2}, u_{3}, u_{4}\right\} \subset V_{1}$ and $\left\{v_{1}, v_{2}, v_{3}, v_{4}\right\} \subset V_{2}$. We see that $v$ is red-adjacent to some vertex of $\left\{u_{1}, u_{2}, u_{3}, u_{4}\right\}$. Otherwise, $\{v\} \cup V_{1}$ will induce a blue $F_{4, n}$. Without loss of generality, assume $v u_{4}$ is red. Similarly, assume $v v_{4}$ is red. If $v$ has at least four blue neighbors in $V_{1}$, then we get a blue $F_{4, n}$, a contradiction. So we assume that $v$ has at most three blue neighbors in $V_{1}$. For the same reason, assume that $v_{4}$ has at most three blue neighbors in $V_{1}$. In this way, $v$ and $v_{4}$ have a common red neighbor in $V_{1}$. Therefore, we get a red $K_{3}$, again a contradiction. This completes the proof.

## 3 Proof of Theorem 1.7 and Theorem 1.11

We first prove Theorem 1.7. Since the complete multipartite graph $K_{(t n+1) s-1, t n, t n, \ldots, t n} \underbrace{}_{m-2}$ does not contain $K_{m}$ and its complement $K_{(t n+1) s-1} \cup \underbrace{K_{t n} \cup K_{t n}, \ldots, K_{t n}}_{m-2}$ does not contain $s F_{t, n}$, we have $r\left(K_{m}, s F_{t, n}\right) \geq \operatorname{tn}(s+m-2)+s$.

We now prove that $r\left(K_{m}, s F_{t, n}\right) \leq(t n+1)(s-1)+r\left(K_{m}, F_{t, n}\right)$. Let $N=(t n+1)(s-$ $1)+r\left(K_{m}, F_{t, n}\right)$. For a red/blue edge-coloring of $K_{N}$, if $K_{N}$ has a red $K_{m}$, then we are done. Otherwise, we have a blue $F_{t, n}$ since $N>r\left(K_{m}, F_{t, n}\right)$. Removing the blue $F_{t, n}$ from $K_{N}$, we get a red/blue edge-coloring complete graph of order $(t n+1)(s-2)+r\left(K_{m}, F_{t, n}\right)$, which contains a blue $F_{t, n}$ if $s-2 \geq 0$. Repeating this procedure, we finally get a complete graph of order $r\left(K_{m}, F_{t, n}\right)-(t n+1)$, which is obtained from $K_{N}$ by removing $s$ blue $F_{t, n}$ 's. This means $r\left(K_{m}, s F_{t, n}\right) \leq(t n+1)(s-1)+r\left(K_{m}, F_{t, n}\right)$, which completes our proof of Theorem 1.7 .

Next, we prove Theorem 1.11. We begin with the following two lemmas.
Lemma 3.1. [11] Let $n, t$ be two positive integers with $t \geq 2$ and $G$ be a graph of order $t n$. If $\delta(G) \geq\left(1-\frac{1}{t}\right)$ tn, then $G$ has $n$ vertex-disjoint $K_{t}$ 's.

Lemma 3.2. Let $s, n, t$ be three positive integers with $t \geq 2$. Then $r\left(s K_{2}, F_{t, n}\right)=\max \{s, n\}+$ $(t-1) n+s$.

Proof. We separate the proof into two cases.
Case 1. $n \geq s$.

In this case, $\max \{s, n\}+(t-1) n+s=t n+s$. Since the graph $K_{t n, s-1}$ does not contain $s K_{2}$ and its complement $K_{t n} \cup K_{s-1}$ does not contain $F_{t, n}$, we have $r\left(s K_{2}, F_{t, n}\right) \geq t n+s$.

We now prove $r\left(s K_{2}, F_{t, n}\right) \leq t n+s$ by induction on $s$. The case $s=1$ is trivial. We assume that $s \geq 2$ and assertion holds for $s-1$, i.e., $r\left((s-1) K_{2}, F_{t, n}\right) \leq t n+s-1$. For any red/blue edge-coloring of $K_{t n+s}$, if $K_{t n+s}$ contains no blue $F_{t, n}$, then by the induction hypothesis, $K_{t n+s}$ must contain a red $(s-1) K_{2}$ as $t n+s>r\left((s-1) K_{2}, F_{t, n}\right)$. Let $M=\left\{u_{1} v_{1}, u_{2} v_{2}, \ldots, u_{s-1} v_{s-1}\right\}$ be the set of the $s-1$ red $K_{2}^{\prime}$ 's, $M^{*}=\left\{u_{1}, v_{1}, u_{2}, v_{2}, \ldots u_{s-1}, v_{s-1}\right\}$ and $W=V\left(K_{t n+s}\right) \backslash M^{*}$. Then $|W|=t n-s+2$. We see that $W$ induces a blue $K_{t n-s+2}$, since otherwise $W$ would contain a red edge, which together with $M^{*}$ form a red $s K_{2}$.

If $v_{i}$ is red-adjacent to one vertex in $W$ for some $i$, then $u_{i}$ must be blue-adjacent to all other vertices in $W$, since otherwise we would obtain two independent red edges between $\left\{u_{i}, v_{i}\right\}$ and $W$, which together with the $s-2$ red $K_{2}$ 's in $M \backslash\left\{u_{i} v_{i}\right\}$ form a red $s K_{2}$. By symmetry, this implies that, for any $i \in\{1,2, \cdots, s-1\}$, either $u_{i}$ or $v_{i}$ is blue-adjacent to all but at most one vertex in $W$. By relabeling if necessary, we may assume that each $u_{i}$ is blue-adjacent to all but at most one vertex in $W$. Let $W^{\prime}$ be the set of all red neighbours of $u_{i}$ in $W$ (maybe empty). Then $\left|W^{\prime}\right| \leq s-1$ and $\left|W \backslash W^{\prime}\right| \geq(t n-s+2)-(s-1) \geq 3$. We thus have a vertex $w \in W$ that is blue-adjacent to each $u_{i}$. Let $G_{1}=B\left[W \cup\left\{u_{1}, u_{2}, \ldots u_{s-1}\right\} \backslash\{w\}\right]$. It is easy to see that $\delta\left(G_{1}\right) \geq t n-s \geq\left(1-\frac{1}{t}\right) t n$. So by Lemma 3.1, we obtain $n$ vertex-disjoint $K_{t}$ 's in $G_{1}$. Therefore, $G_{1}+w$ contains a blue $F_{t, n}$ with $w$ as its center, a contradiction.

Case 2. $n<s$.
In this case, $\max \{s, n\}+(t-1) n+s=(t-1) n+2 s$. The desired lower bound $r\left(s K_{2}, F_{t, n}\right) \geq$ $(t-1) n+2 s$ follows from the fact that the graph $\bar{K}_{(t-1) n} \cup K_{2 s-1}$ does not contain $s K_{2}$ and its complement $K_{(t-1) n}+\bar{K}_{2 s-1}$ does not contain $F_{t, n}$.

To prove $r\left(s K_{2}, F_{t, n}\right) \leq(t-1) n+2 s$, we show by induction on $s \geq n$ that if a graph $\bar{G}$ of order $(t-1) n+2 s$ contains no $F_{t, n}$, then $G$ contains $s$ independent edges. The assertion for the case $s=n$ follows directly from Case 1 . We now assume that $s>n$. By deleting a pair of nonadjacent vertices $u$ and $v$ from $\bar{G}$, we have a subgraph $\bar{H}$ of $\bar{G}$ on $(t-1) n+2(s-1)$ vertices with $s-1 \geq n$, which does not contain $F_{t, n}$. So by the induction hypothesis, $H$ contains $(s-1) K_{2}$, which together with the edge $u v$ yields an $s K_{2}$ in $G$.

Let $N=\max \{m, n\}+(t-1)(2 m+n)+n+m$, and consider a red/blue edge-coloring of $K_{N}$. Suppose to the contrary that $R$ contains no $F_{m}$ and $B$ contains no blue $F_{t, n}$. By Lemma 3.2, we know that $d_{R}(u) \leq \max \{m, n\}+(t-1) n+m-1$ for any $u \in V\left(K_{N}\right)$ since the red neighbours of $u$ induce no $m K_{2}$. Furthermore, by Theorem 1.5, we have $d_{B}(u) \leq 2 m(t-1)+n-1$ for any $u \in V\left(K_{N}\right)$. Then $N \leq \max \{m, n\}+(t-1) n+m-1+2 m(t-1)+n-1+1<$ $\max \{m, n\}+(t-1)(2 m+n)+n+m$, a contradiction. This completes the proof of Theorem 1.11.
