# TRANSVERSAL HAMILTON CYCLE IN HYPERGRAPH SYSTEMS

#### Abstract

A $k$-graph system $\boldsymbol{H}=\left\{H_{i}\right\}_{i \in[m]}$ is a family of not necessarily distinct $k$-graphs on the same $n$-vertex set $V$ and a $k$-graph $H$ on $V$ is said to be $\boldsymbol{H}$-transversal provided that there exists an injection $\varphi: E(H) \rightarrow[m]$ such that $e \in E\left(H_{\varphi(e)}\right)$ for all $e \in E(H)$. We show that given $k \geq 3, \gamma>0$, sufficiently large $n$ and an $n$-vertex $k$-graph system $\boldsymbol{H}=\left\{H_{i}\right\}_{i \in[n]}$, if $\delta_{k-1}\left(H_{i}\right) \geq(1 / 2+\gamma) n$ for each $i \in[n]$, then there exists an $\boldsymbol{H}$-transversal tight Hamilton cycle. This extends the result of Rödl, Ruciński and Szemerédi [Combinatorica, 2008] on single $k$-graphs.


## 1. Introduction

1.1. Dirac-type problems. The study of Hamilton cycles in graphs and hypergraphs is a central area in graph theory with a rich history. A classical theorem of Dirac [22] asserts that for any $n \geq 3$, every $n$-vertex graph with minimum degree at least $n / 2$ contains a Hamilton cycle.

A $k$-uniform hypergraph ( $k$-graph, hereafter) $H=(V, E)$ consists of a vertex set $V$ and an edge set $E$ which is a family of $k$-element subsets of $V$, i.e. $E \subseteq\binom{V}{k}$. For any $S \subseteq V(H)$, the degree of $S$ in $H$, denoted by $\operatorname{deg}_{H}(S)$, is the number of edges containing $S$. For any integer $\ell \geq 0$, define the minimum $\ell$-degree $\delta_{\ell}(H)$ to be $\min \left\{\operatorname{deg}_{H}(S): S \in\binom{V(H)}{\ell}\right\}$. A tight Hamilton cycle $H=(V, E)$ is a cyclic ordering of $V$ such that every interval of $k$ consecutive vertices forms an edge. Throughout the rest of this paper, we refer to tight Hamilton cycles as Hamilton cycles.

Problems that relate the minimum degree (in general, minimum $\ell$-degree in hypergraphs) to the structure of the (hyper)graphs are often referred to as Dirac-type problems. The problem of determining the best possible minimum ( $k-1$ )-degree condition forcing Hamilton cycles in $k$-graphs, was initially researched by Katona and Kierstead [44]. They proved that every $n$-vertex $k$-graph $H$ with $\delta_{k-1}(H)>\left(1-\frac{1}{2 k}\right) n+4-k-\frac{5}{2 k}$ admits a Hamilton cycle. They also conjectured that the bound on the minimum ( $k-1$ )-degree can be reduced to roughly $n / 2$, which was confirmed asymptotically by Rödl, Ruciński and Szemerédi in [65, 66]. The same authors gave the exact version for $k=3$ in [68].

Theorem 1.1 ( $[66,68])$. Let $k \geq 3, \gamma>0$ and $H$ be an $n$-vertex $k$-graph, where $n$ is sufficiently large. If $\delta_{k-1}(H) \geq(1 / 2+\gamma) n$, then $H$ contains a Hamilton cycle. Furthermore, when $k=3$ it is enough to have $\delta_{2}(H) \geq\lfloor n / 2\rfloor$.

For more problems and results on Dirac-type problems, we refer the readers to [5, 8, 10, 11, 14, $21,25,31,37,38,39,40,45,48,49,50,51,53,55,60,63]$ and the recent surveys by Rödl and Ruciński [64], Simonovits and Szemerédi [69] and Zhao [70].
1.2. A transversal setting. A $k$-graph system $\boldsymbol{H}=\left\{H_{i}\right\}_{i \in[m]}$ is a family of not necessarily distinct $k$-graphs on the same $n$-vertex set $V$. Note that each $H_{i}$ can be seen as the collection of edges with color $i$, and in this sense $\boldsymbol{H}$ can be regarded as an edge-colored multi- $k$-graph. For convenience, we use $[i, j], i, j \in \mathbb{Z}$, to denote the set $\{i, i+1, \ldots, j\}$. The set $[1, n]$ is denoted by $[n]$ in short.

Definition 1.2. Let $m$ be an integer and $\boldsymbol{H}=\left\{H_{i}\right\}_{i \in[m]}$ be a $k$-graph system. Then a $k$-graph $H$ on $V$ is said to be $\boldsymbol{H}$-transversal provided that there exists an injection $\varphi: E(H) \rightarrow[m]$ such that $e \in E\left(H_{\varphi(e)}\right)$ for each $e \in E(H)$.

Since $\varphi$ is an injection, it follows that all edges of $H$ are from different members of $\boldsymbol{H}$. When $m=e(H), \varphi$ is a bijection and thus $H$ contains exactly one edge from each $H_{i}$.

Recently, the study of graph systems has received much attention. Aharoni [1] conjectured a transversal version of the Dirac theorem, that is, for $|V|=n \geq 3$ and $\boldsymbol{G}=\left\{G_{i}\right\}_{i \in[n]}$ on $V$, if $\delta\left(G_{i}\right) \geq n / 2$ for each $i \in[n]$, then there exists a $G$-transversal Hamilton cycle. This was verified asymptotically by Cheng, Wang and Zhao [18], and completely by Joos and Kim [43]. In [13], Bradshaw, Halasz, and Stacho strengthened the result of Joos and Kim by showing that there exist exponentially many $\boldsymbol{G}$-transversal Hamilton cycles. Similarly, the Hamiltonicity of bipartite graphs due to Moon and Moser [62] has recently been extended to the transversal setting by Bradshaw in [12]. Recently, Ferber, Han and Mao [25] gave a transversal version of the Dirac theorem in random graph systems.

Other recent results on transversal settings include works on matchings $[2,28,41,46,52,56,57$, $58,59]$, factors [3, 17, 61] and so on. We should mention that another related setting which studies rainbow subgraphs in edge-colored (hyper)graphs with restrictions, e.g. properly-colorings [7, 16, $26,29,30,32,34,35,47]$ and general $m$-bounded colorings [4, 9, 15, 19, 20, 23, 24, 36].

The main goal of this paper is to extend Theorem 1.1 to the transversal setting. For every $k \geq 3, \gamma>0$, we say that an $n$-vertex $k$-graph system $\boldsymbol{H}=\left\{H_{i}\right\}_{i \in[n]}$ is a $(k, n, \gamma)$-graph system if $\delta_{k-1}\left(H_{i}\right) \geq(1 / 2+\gamma) n$ for each $i \in[n]$.

Theorem 1.3. For every $k \geq 3, \gamma>0$ and sufficiently large $n \in \mathbb{N}$, every ( $k, n, \gamma$ )-graph system $\boldsymbol{H}=\left\{H_{i}\right\}_{i \in[n]}$ admits an $\boldsymbol{H}$-transversal Hamilton cycle.

## 2. Notation and Proof Strategy

2.1. Notation. A tight path $P=v_{1} v_{2} \cdots v_{t}$ is a $k$-graph whose vertices can be ordered in such a way that each edge consists of $k$ consecutive vertices and two consecutive edges intersect in exactly $k-1$ vertices. The length of a tight path is the number of edges in the path. We say that $P$ connects $\left(v_{1}, \ldots, v_{k-1}\right)$ and $\left(v_{t}, \ldots, v_{t-k+2}\right)$. In this paper, a $(k-1)$-element sequence of distinct vertices of $V$ will be referred as a $(k-1)$-tuple. The $(k-1)$-tuples $\left(v_{1}, \ldots, v_{k-1}\right)$ and $\left(v_{t}, \ldots, v_{t-k+2}\right)$ are called the ends of $P$. Tight paths are referred as paths for convenience.

Given a $k$-graph $H$ and a $k$-graph system $\boldsymbol{H}=\left\{H_{i}\right\}_{i \in[n]}$ on the same vertex set with $H$, we define $\left\{i: E\left(H_{i}\right) \cap E(H) \neq \emptyset\right\}$ as the color set of $H$, denoted by $C(H)$. We call $P=x_{1} \cdots x_{2 k-2}$ an $\boldsymbol{H}$-transversal path with color pattern $\left(c_{1}, \ldots, c_{k-1}\right)$ if $\left\{x_{i}, \ldots, x_{i+k-1}\right\} \in E\left(H_{c_{i}}\right)$ for $i \in[k-1]$. Let $\mathcal{P}=\left\{P_{1}, \ldots, P_{m}\right\}$ be a family of vertex-disjoint paths. If each $P_{i}, i \in[m]$, is an $\boldsymbol{H}$-transversal
path and $C\left(P_{i}\right) \cap C\left(P_{j}\right)=\emptyset$ for distinct $i, j \in[m]$, then we call this family an $\boldsymbol{H}$-transversal family of paths. Denote $\bigcup_{i \in[m]} V\left(P_{i}\right)$ by $V(\mathcal{P})$. The size of $\mathcal{P}$ is the number of paths in the family.

When we write $\alpha \ll \beta$, we mean that $\alpha, \beta$ are constants in $(0,1)$, and for every $\beta$ we have chosen, there exists $\alpha_{0}=\alpha_{0}(\beta)$ such that the subsequent arguments hold for all $\alpha \leq \alpha_{0}$. While multiple constants appear in a hierarchy, they are chosen from right to left.

Besides, we require the following concentration inequalities.
Proposition 2.1 (Corollary 2.3, [42]). Suppose that $X$ has the binomial distribution and $0<a<$ $3 / 2$. Then $\operatorname{Pr}(|X-\mathbb{E} X| \geq a \mathbb{E} X) \leq 2 e^{-a^{2} \mathbb{E} X / 3}$.

Proposition 2.2 (Corollary 2.2, [33]). Let $\binom{[N]}{r}$ be the set of $r$-subsets of $\{1, \ldots, N\}$ and let $h:\binom{[N]}{r} \rightarrow \mathbb{R}$ be given. Suppose that there exists $\alpha \geq 0$ such that

\left|h(A)-h\left(A^{\prime}\right)\right| \leq \alpha
$$

for any $A, A^{\prime} \in\binom{[N]}{r}$ with $\left|A \cap A^{\prime}\right|=r-1$. Let $C \subseteq[N]$ be a set of size $r$ chosen uniformly at random. Then

\begin{equation*}
\mathbb{E} e^{h(C)}=\exp (\mathbb{E} h(C)+a), \tag{1}
\end{equation*}
$$

where $a$ is a real constant such that $0 \leq a \leq \frac{\alpha^{2}}{8} \min \{r, N-r\}$. Furthermore, for any real $t>0$,

$$
\begin{equation*}
\operatorname{Pr}(|h(C)-\mathbb{E} h(C)| \geq t) \leq 2 \exp \left(-\frac{2 t^{2}}{\min \{r, N-r\} \alpha^{2}}\right) . \tag{2}
\end{equation*}
$$

2.2. Proof strategy. In this section we give an outline of the proof of Theorem 1.3. Our proof is under the framework of the absorption method, systematised by the work of Rödl, Ruciński and Szemerédi $[65,67]$, which reduces the problem of finding a spanning subgraph to building an absorption structure and an almost spanning structure. Tailored to our problem, the idea is to build a transversal absorbing cycle and a transversal path cover. Moreover, the transversal absorbing cycle will be able to swallow an arbitrary leftover of vertices, a leftover of colors as well as an $\boldsymbol{H}$-transversal family of paths so that we obtain a transversal Hamilton cycle. This motivates us to append the color information and the connecting technique into the transversal absorption method, which is our contribution compared with the proof of Theorem 1.1 in [66].

Lemma 2.3 (Absorbing Lemma). Given $k \geq 3, \gamma>0$, there exists $\kappa>0$ such that the following holds for sufficiently large $n \in \mathbb{N}$. Let $\boldsymbol{H}=\left\{H_{i}\right\}_{i \in[n]}$ be a $(k, n, \gamma)$-graph system on $V$. Then there exists an $\boldsymbol{H}$-transversal cycle $A$ with at most $\gamma n / 2$ vertices such that for any $\boldsymbol{H}$-transversal family of paths $\mathcal{P}$ and any vertex set $U$ in $V \backslash V(A)$ with $|\mathcal{P}|,|U| \leq \kappa n$, there exists an $\boldsymbol{H}$-transversal cycle $A^{\prime}$ with vertex set $V(A) \cup U \cup V(\mathcal{P})$ and $C(A) \subseteq C\left(A^{\prime}\right)$.

We first define two versions of absorbers as follows .
Definition 2.4. Given a $(k, n, \gamma)$-graph system $\boldsymbol{H}$, a vertex $x$ and a color $c$, we say that a path $P$ is a transversal absorber for $(x, c)$ in an n-vertex $k$-graph system if the following holds:

- $x \notin V(P)$;
- $P=x_{1} \cdots x_{2 k-2}$ is an $\boldsymbol{H}$-transversal path with color pattern $\left(c_{1}, \ldots, c_{k-1}\right)$;
- $x_{1} \cdots x_{k-1} x x_{k} \cdots x_{2 k-2}$ is an $\boldsymbol{H}$-transversal path with color pattern $\left(c, c_{1}, \ldots, c_{k-1}\right)$.

Definition 2.5. Given a ( $k, n, \gamma$ )-graph system $\boldsymbol{H}$, two disjoint $(k-1)$-tuples of vertices $\mathbf{u}=$ $\left(u_{1}, \ldots, u_{k-1}\right), \mathbf{v}=\left(v_{1}, \ldots, v_{k-1}\right)$ and a $(k-1)$-tuple $\left(o_{1}, \ldots, o_{k-1}\right)$ of colors, we say that a path $P$ is a transversal absorber for $\left(\mathbf{u}, \mathbf{v} ; o_{1}, \ldots, o_{k-1}\right)$ in an n-vertex $k$-graph system if the following holds:

- $V(P) \cap\left\{u_{1}, \ldots, u_{k-1}, v_{1}, \ldots, v_{k-1}\right\}=\emptyset ;$
- $P=x_{1} \cdots x_{2 k-2}$ is an $\boldsymbol{H}$-transversal path with color pattern $\left(c_{1}, \ldots, c_{k-1}\right)$;
- $x_{1} \cdots x_{k-1} u_{1} \cdots u_{k-1}$ and $v_{1} \cdots v_{k-1} x_{k} \cdots x_{2 k-2}$ are $\boldsymbol{H}$-transversal paths with color patterns $\left(c_{1}, \ldots, c_{k-1}\right),\left(o_{1}, \ldots, o_{k-1}\right)$ respectively.

The second task is to connect the absorbers to a path. The following lemma helps us to connect any two disjoint paths (by connecting their ends).

Lemma 2.6 (Connecting Lemma). For every $k \geq 3, \gamma>0$, there exists $c \in \mathbb{N}$ such that the following holds for sufficiently large $n \in \mathbb{N}$. Let $\boldsymbol{H}=\left\{H_{i}\right\}_{i \in[c]}$ be a $(k, n, \gamma)$-graph system and $\mathbf{u}$, $\mathbf{v}$ be two disjoint $(k-1)$-tuples of vertices. Then, there exists an $\boldsymbol{H}$-transversal path from $\mathbf{u}$ to $\mathbf{v}$ with at most $c+k-1$ vertices.

Given a $(k, n, \gamma)$-graph system $\boldsymbol{H}=\left\{H_{i}\right\}_{i \in[n]}$, we need to construct an $\boldsymbol{H}$-transversal family of paths, covering almost all vertices of $V \backslash V(A)$ and almost all colors of $[n] \backslash C(A)$. To achieve this, we use the regularity lemma for hypergraphs and a trick of Ferber and Kwan [25].

Lemma 2.7 (Path cover Lemma). For every $k \geq 3, \gamma, \delta>0$, there exists $L>0$ such that the following holds for sufficiently large $n \in \mathbb{N}$. Every $(k, n, \gamma)$-graph system $\boldsymbol{H}=\left\{H_{i}\right\}_{i \in[n]}$ on $V$ contains an $\boldsymbol{H}$-transversal family of paths $\mathcal{P}$ of size at most $L$, covering at least $(1-\delta) n$ vertices of $V$.

Proof of Theorem 1.3. For any $k \geq 3$ and $\gamma>0$, we choose $1 / n \ll 1 / L, \kappa \ll \gamma, 1 / k$, and fix $\boldsymbol{H}$ to be a $(k, n, \gamma)$-graph system on $V$.
Step 1. By Absorbing Lemma, we obtain an $\boldsymbol{H}$-transversal cycle $A$ with at most $\gamma n / 2$ vertices such that the following property holds. For any $\boldsymbol{H}$-transversal family of paths $\mathcal{P}$ and any vertex set $U$ in $V \backslash V(A)$ with $|\mathcal{P}|,|U| \leq \kappa n$, there exists an $\boldsymbol{H}$-transversal cycle $A^{\prime}$ with vertex set $V(A) \cup U \cup V(\mathcal{P})$ and $C(A) \subseteq C\left(A^{\prime}\right)$.
Step 2. Set $\boldsymbol{H}^{\prime}=\left\{H_{i}^{\prime}\right\}_{i \in C^{\prime}}$ where $C^{\prime}=[n] \backslash C(A), H_{i}^{\prime}=H_{i}[V \backslash V(A)]$ for $i \in C^{\prime}$. Let $n^{\prime}=n-|V(A)|$. Note that $\boldsymbol{H}^{\prime}$ is a $\left(k, n^{\prime}, \gamma / 2\right)$-graph system where $n^{\prime}>(1-\gamma / 2) n$. Applying Path Cover Lemma to $\boldsymbol{H}^{\prime}$ with $\delta=\kappa$, we obtain an $\boldsymbol{H}^{\prime}$-transversal family of paths $\mathcal{P}=\left\{P_{1}, \ldots, P_{p}\right\}$, where $p \leq L \leq \kappa n$, covering all but at most $\kappa n^{\prime}$ vertices of $V \backslash V(A)$. Denote the set of uncovered vertices by $T$. Thus, $|T| \leq \kappa n^{\prime} \leq \kappa n$.
Step 3. Using property in Step 1, we obtain a transversal cycle with vertex set $V(A) \cup T \cup V(\mathcal{P})$, which is actually an $\boldsymbol{H}$-transversal Hamilton cycle.

## 3. Transversal Absorption Method

Given a vertex $x \in V$ and a color $c \in[n]$, let $\mathcal{L}(x ; c)$ be the family of transversal absorbers for $(x, c)$. Similarly, given two disjoint $(k-1)$-tuples $\mathbf{u}$ and $\mathbf{v}$ of $V$ and a $(k-1)$-tuple ( $o_{1}, \ldots, o_{k-1}$ ) of $[n]$, let $\mathcal{L}\left(\mathbf{u}, \mathbf{v} ; o_{1}, \ldots, o_{k-1}\right)$ be the set of transversal absorbers for $\left(\mathbf{u}, \mathbf{v} ; o_{1}, \ldots, o_{k-1}\right)$. We need the following simple result.

Fact 3.1. Let $\boldsymbol{H}=\left\{H_{1}, \ldots, H_{n}\right\}$ be a $(k, n, \gamma)$-graph system on $V$, $S$ be $a(k-1)$-subset of $V$ and $V_{0} \subseteq V \backslash S$. For any $i \in[n]$, we have

$$
\left|N_{H_{i}}(S) \cap V_{0}\right| \geq\left|V_{0}\right|-\frac{1}{2} n+\gamma n+k-1 .
$$

In particular, for two $(k-1)$-subsets of vertices $S_{1}$ and $S_{2}$, we obtain that for any $i, j \in[n]$,

$$
\left|N_{H_{i}}\left(S_{1}\right) \cap N_{H_{j}}\left(S_{2}\right)\right| \geq 2 \gamma n+\left|S_{1} \cap S_{2}\right| .
$$

Proof. We have $\left|N_{H_{i}}(S) \cup V_{0}\right| \leq n-k+1$ and thus

$$
\left|N_{H_{i}}(S) \cap V_{0}\right| \geq\left|V_{0}\right|+\left|N_{H_{i}}(S)\right|-(n+k-1) \geq\left|V_{0}\right|-\frac{1}{2} n+\gamma n+k-1 .
$$

For the second statement, we apply the first one with $S=S_{1}$ and $V_{0}=N_{H_{i}}\left(S_{2}\right) \backslash S_{1}$ and note that $\left|V_{0}\right| \geq\left(\frac{1}{2}+\gamma\right) n-\left(k-1-\left|S_{1} \cap S_{2}\right|\right)$.

Next we show lower bounds on the number of absorbers in a $(k, n, \gamma)$-graph system.

Proposition 3.2. For any $k \geq 3, \gamma>0$, there exists $\zeta>0$ such that the following holds for all sufficiently large $n \in \mathbb{N}$. Suppose $\boldsymbol{H}=\left\{H_{1}, \ldots, H_{n}\right\}$ is a $(k, n, \gamma)$-graph system on $V$, then $|\mathcal{L}(x ; c)| \geq \zeta n^{3 k-3}$ for every vertex $x \in V$ and color $c \in[n],\left|\mathcal{L}\left(\mathbf{u}, \mathbf{v} ; o_{1}, \ldots, o_{k-1}\right)\right| \geq \zeta n^{3 k-3}$ for every two disjoint $(k-1)$-tuples $\mathbf{u}$ and $\mathbf{v}$ of $V$ and $a(k-1)$-tuple $\left(o_{1}, \ldots, o_{k-1}\right)$ of $[n]$.

Proof. Given $k, \gamma$, we choose $1 / n \ll \zeta \ll \gamma / k$. Fixing vertex $x \in V$ and color $c \in[n]$, we construct a transversal absorber $P=x_{1} \cdots x_{2 k-2}$ with color pattern $\left(c_{1}, \ldots, c_{k-1}\right)$ for $(x, c)$. We choose $\left(c_{1}, \ldots, c_{k-1}\right)$ arbitrarily, so there are $(n-1) \cdots(n-k+1) \geq 2^{1-k} n^{k-1}$ choices. Furthermore, $x_{1}, \ldots, x_{k-2}$ can be chosen arbitrarily in $(n-1) \cdots(n-k+2) \geq 2^{2-k} n^{k-2}$ ways. For $x_{k-1}$, there are at least $\left(\frac{1}{2}+\gamma\right) n$ choices such that $\left\{x_{1}, \ldots, x_{k-1}, x\right\} \in E\left(H_{c}\right)$. By Fact 3.1, there are at least $2 \gamma n+k-2$ choices for $x_{j}, j \in[k, 2 k-2]$, such that $\left\{x_{j-k+1}, \ldots, x_{j}\right\},\left\{x_{j-k+2}, \ldots, x_{j}, x\right\} \in$ $E\left(H_{c_{j-k+1}}\right)$. For $j \in[k+1,2 k-2], x_{j}$ should be different from $x_{1}, \ldots, x_{j-k}$. Thus, the number of choices for each $x_{j}$ is at least $2 \gamma n+k-2-(j-k) \geq 2 \gamma n, j \in[k, 2 k-2]$, yielding together at least $2^{1-k} n^{k-1} 2^{2-k} n^{k-2}\left(\frac{1}{2}+\gamma\right) n(2 \gamma n)^{k-1} \geq \zeta n^{3 k-3}$ transversal absorbers for $(x, c)$.

Given $\mathbf{u}=\left(u_{1}, \ldots, u_{k-1}\right), \mathbf{v}=\left(v_{1}, \ldots, v_{k-1}\right)$ and $\left(o_{1}, \ldots, o_{k-1}\right)$, we construct a transversal absorber $P=x_{1} \cdots x_{2 k-2}$ with color pattern $\left(c_{1}, \ldots, c_{k-1}\right)$ for $\left(\mathbf{u}, \mathbf{v} ; o_{1}, \ldots, o_{k-1}\right)$. There are $(n-k+1) \cdots(n-2 k+2) \geq 2^{1-k} n^{k-1}$ choices for $\left(c_{1}, \ldots, c_{k-1}\right)$. There are at least $\left(\frac{1}{2}+\gamma\right) n-(k-1) \geq$ $\gamma n$ choices for $x_{k-1}$ such that $\left\{u_{1}, \ldots, u_{k-1}, x_{k-1}\right\} \in E\left(H_{c_{k-1}}\right)$ and $x_{k-1}$ should be different from $v_{1}, \ldots, v_{k-1}$. For $x_{i}, i \in[k-2]$, there are at least $\left(\frac{1}{2}+\gamma\right) n-(2 k-3) \geq \gamma n$ choices such that $\left\{u_{k-i}, \ldots, u_{k-1}, x_{k-1}, \ldots, x_{i+1}, x_{i}\right\} \in E\left(H_{c_{i}}\right)$, and it should be different from $v_{1}, \ldots, v_{k-1}, u_{1}, \ldots$, $u_{k-1-i}$.

By Fact 3.1, there are at least $2 \gamma n$ choices for $x_{k}$ such that $\left\{x_{1}, \cdots, x_{k-1}, x_{k}\right\} \in E\left(H_{c_{1}}\right)$, $\left\{v_{1}, \cdots, v_{k-1}, x_{k}\right\} \in E\left(H_{o_{1}}\right)$ and it is different from $u_{1}, \ldots, u_{k-1}$. For $x_{i}, i \in[k+1,2 k-2]$, the number of choices is at least $2 \gamma n+k-2-(k-1+2(i-k)) \geq \gamma n$, such that $\left\{x_{i-(k-1)}, \ldots, x_{i}\right\} \in$ $E\left(H_{\left.c_{i-(k-1)}\right)}\right),\left\{v_{i-(k-1)}, \ldots, v_{k-1}, x_{k}, \ldots, x_{i}\right\} \in E\left(H_{o_{i-(k-1)}}\right)$ and it should be different from $u_{1}, \ldots$, $u_{k-1}, x_{1}, \ldots, x_{i-k}, v_{1}, \ldots, v_{i-k}$. Thus, there are at least $2^{1-k} n^{k-1}(\gamma n)^{k-1}(\gamma n)^{k-1} \geq \zeta n^{3 k-3}$ transversal absorbers for ( $\left.\mathbf{u}, \mathbf{v} ; o_{1}, \ldots, o_{k-1}\right)$.

Now we show that we can construct a family of disjoint absorbers, with all different colors.
Lemma 3.3. For any $k \geq 3$ and $\alpha, \zeta>0$, there exists $\beta>0$ such that the following holds for all sufficiently large $n \in \mathbb{N}$. Let $\boldsymbol{H}=\left\{H_{1}, \ldots, H_{n}\right\}$ be an $n$-vertex $k$-graph system on $V$. If $|\mathcal{L}(x ; c)| \geq \zeta n^{3 k-3}$ for every vertex $x \in V, c \in[n]$ and $\left|\mathcal{L}\left(\mathbf{u}, \mathbf{v} ; o_{1}, \ldots, o_{k-1}\right)\right| \geq \zeta n^{3 k-3}$ for all disjoint $(k-1)$-tuples $\mathbf{u}$ and $\mathbf{v}$ of $V$ and $(k-1)$-tuple $\left(o_{1}, \ldots, o_{k-1}\right)$ of $[n]$, then there exists an $\boldsymbol{H}$-transversal family $\mathcal{F}^{\prime}$ of paths of length $k-1$, satisfying

$$
\begin{gathered}
\left|\mathcal{F}^{\prime}\right| \leq \alpha n, \quad\left|\mathcal{F}^{\prime} \cap \mathcal{L}(x ; c)\right| \geq \beta n, \text { and } \\
\left|\mathcal{F}^{\prime} \cap \mathcal{L}\left(\mathbf{u}, \mathbf{v} ; o_{1}, \ldots, o_{k-1}\right)\right| \geq \beta n,
\end{gathered}
$$

for every vertex $x \in V, c \in[n]$, two disjoint $(k-1)$-tuples $\mathbf{u}$ and $\mathbf{v}$ of $V$ and $\left(o_{1}, \ldots, o_{k-1}\right)$ of $[n]$.
Proof. Let $1 / n \ll \beta \ll \varepsilon \ll \alpha, \zeta$. Each $\boldsymbol{H}$-transversal path $x_{1} x_{2} \cdots x_{2 k-2}$ with color pattern $\left(c_{1}, \ldots, c_{k-1}\right)$ can be viewed as a $(3 k-3)$-tuple $\left(x_{1}, x_{2}, \ldots, x_{2 k-2}, c_{1}, \ldots, c_{k-1}\right)$. Choose a family $\mathcal{F}$ of $(3 k-3)$-tuples from $\binom{V}{2 k-2} \times\binom{[n]}{k-1}$ by including each possible $(3 k-3)$-tuple independently at
random with probability

$$
p=\varepsilon \frac{(n-(2 k-2))!\cdot(n-(k-1))!}{(n-1)!\cdot n!} \geq \varepsilon n^{-(3 k-4)}
$$

Note that $|\mathcal{F}|,|\mathcal{L}(x, c) \cap \mathcal{F}|,\left|\mathcal{L}\left(\mathbf{u}, \mathbf{v} ; o_{1}, \ldots, o_{k-1}\right) \cap \mathcal{F}\right|$ are binomial random variables with

$$
\begin{gathered}
\mathbb{E}|\mathcal{F}|=p \frac{n!\cdot n!}{(n-(2 k-2))!\cdot(n-(k-1))!}=\varepsilon n \\
\mathbb{E}|\mathcal{L}(x, c) \cap \mathcal{F}|=p|\mathcal{L}(x ; c)| \geq \varepsilon \zeta n \\
\mathbb{E}\left|\mathcal{L}\left(\mathbf{u}, \mathbf{v} ; o_{1}, \ldots, o_{k-1}\right) \cap \mathcal{F}\right|=p\left|\mathcal{L}\left(\mathbf{u}, \mathbf{v} ; o_{1}, \ldots, o_{k-1}\right)\right| \geq \varepsilon \zeta n
\end{gathered}
$$

for every vertex $x \in V, c \in[n]$, two disjoint $(k-1)$-tuples $\mathbf{u}$ and $\mathbf{v}$ of $V$ and $\left(o_{1}, \ldots, o_{k-1}\right)$ of $[n]$. By Proposition 2.1, with probability $1-o(1)$, the family $\mathcal{F}$ satisfies the following properties

$$
\begin{gathered}
|\mathcal{F}| \leq 2 \mathbb{E}|\mathcal{F}|=2 \varepsilon n \leq \alpha n \\
|\mathcal{L}(x ; c) \cap \mathcal{F}| \geq 2^{-1} \mathbb{E}|\mathcal{L}(x ; c) \cap \mathcal{F}| \geq 2^{-1} \varepsilon \zeta n \\
\left|\mathcal{L}\left(\mathbf{u}, \mathbf{v} ; o_{1}, \ldots, o_{k-1}\right) \cap \mathcal{F}\right| \geq 2^{-1} \mathbb{E}\left|\mathcal{L}\left(\mathbf{u}, \mathbf{v} ; o_{1}, \ldots, o_{k-1}\right)\right| \geq 2^{-1} \varepsilon \zeta n
\end{gathered}
$$

for every vertex $x \in V, c \in[n]$, two disjoint $(k-1)$-tuples $\mathbf{u}$ and $\mathbf{v}$ of $V$ and $\left(o_{1}, \ldots, o_{k-1}\right)$ of $[n]$. We say that two $(3 k-3)$-tuples $\left(x_{1}, x_{2}, \ldots, x_{2 k-2}, c_{1}, \ldots, c_{k-1}\right)$ and $\left(y_{1}, y_{2}, \ldots, y_{2 k-2}, f_{1}, \ldots, f_{k-1}\right)$ are intersecting if $x_{i}=y_{j}$ for some $i, j \in[2 k-2]$ or $c_{m}=f_{\ell}$ for some $m, \ell \in[k-1]$. We can bound the expected number of pairs of $(3 k-3)$-tuples in $\mathcal{F}$ that are intersecting from above by

$$
\frac{n!\cdot n!}{(n-(2 k-2))!\cdot(n-(k-1))!}(3 k-3)^{2} \frac{(n-1)!\cdot n!}{(n-(2 k-2))!\cdot(n-(k-1))!} p^{2}=(3 k-3)^{2} \varepsilon^{2} n .
$$

Thus, using Markov's inequality, we derive that with probability at least $1 / 2, \mathcal{F}$ contains at most $2(3 k-3)^{2} \varepsilon^{2} n$ intersecting pairs of $(3 k-3)$-tuples. Remove one $(3 k-3)$-tuple from every intersecting pair in $\mathcal{F}$ and remove the $(3 k-3)$-tuples that can not absorb any $(x, c)$ or $\left(\mathbf{u}, \mathbf{v}, o_{1}, \ldots, o_{k-1}\right)$ where $x \in V, c \in[n], \mathbf{u}$ and $\mathbf{v}$ are $(k-1)$-tuples of $V$ and $\left(o_{1}, \ldots, o_{k-1}\right)$ is a $(k-1)$-tuple of [n]. Thus the resulting subfamily, say $\mathcal{F}^{\prime}$, consists of pairwise disjoint $(3 k-3)$-tuples, which satisfies

$$
\left|\mathcal{L}(x ; c) \cap \mathcal{F}^{\prime}\right| \geq 2^{-1} \varepsilon \zeta n-2(3 k-3)^{2} \varepsilon^{2} n \geq \beta n
$$

for any $x \in V, c \in[n]$, and a similar statement holds for $\left|\mathcal{L}\left(\mathbf{u}, \mathbf{v} ; o_{1}, \ldots, o_{k-1}\right) \cap \mathcal{F}^{\prime}\right|$ for any two disjoint $(k-1)$-tuples $\mathbf{u}$ and $\mathbf{v}$ of $V$ and a $(k-1)$-tuple $\left(o_{1}, \ldots, o_{k-1}\right)$ of $[n]$. Since each $(3 k-3)$-tuple in $\mathcal{F}^{\prime}$ induces a transversal absorber, $\mathcal{F}^{\prime}$ is an $\boldsymbol{H}$-transversal family of paths, where each path is of length $k-1$.

Now we are ready to prove Lemma 2.3, assuming Lemma 2.6 holds.

Proof of Lemma 2.3. Given $1 / n \ll \kappa \ll \beta \ll \alpha, \zeta \ll \gamma, 1 / k$, let $\boldsymbol{H}=\left\{H_{i}\right\}_{i \in[n]}$ be a $(k, n, \gamma)$ graph system on $V$. By Proposition 3.2 , we obtain $|\mathcal{L}(x ; c)| \geq \zeta n^{3 k-3}$ for every vertex $x \in V$ and $c \in[n]$, and $\left|\mathcal{L}\left(\mathbf{u}, \mathbf{v} ; o_{1}, \ldots, o_{k-1}\right)\right| \geq \zeta n^{3 k-3}$ for every two disjoint $(k-1)$-tuples $\mathbf{u}$ and $\mathbf{v}$ of $V$ and a $(k-1)$-tuple $\left(o_{1}, \ldots, o_{k-1}\right)$ of $[n]$. By Lemma 3.3, there is an $\boldsymbol{H}$-transversal family of paths $\mathcal{F}^{\prime}=\left\{P_{1}, \ldots, P_{q n}\right\}$, where $q \leq \alpha$ and $\left|V\left(P_{i}\right)\right|=2 k-2$ for $i \in[q n],\left|\mathcal{F}^{\prime} \cap \mathcal{L}(x ; c)\right| \geq \beta n$ for every
vertex $x \in V, c \in[n]$ and $\left|\mathcal{F}^{\prime} \cap \mathcal{L}\left(\mathbf{u}, \mathbf{v} ; o_{1}, \ldots, o_{k-1}\right)\right| \geq \beta n$ for every two disjoint $(k-1)$-tuples $\mathbf{u}$ and $\mathbf{v}$ of $V$ and $\left(o_{1}, \ldots, o_{k-1}\right)$ of $[n]$.

Next, we shall connect all the paths in $\mathcal{F}^{\prime}$ into an $\boldsymbol{H}$-transversal cycle. Suppose we have connected $P_{1}, \ldots, P_{j}$ into one path $P$, by using each time at most $\left\lceil 8 k \gamma^{-2}\right\rceil-(2 k-2)$ vertices from outside $V\left(\mathcal{F}^{\prime}\right)$. Let $\mathbf{e}=\left(u_{1}, \ldots, u_{k-1}\right)$ be an end of $P$ and $\mathbf{f}=\left(v_{1}, \ldots, v_{k-1}\right)$ be an end of $P_{j+1}$. Let $H_{i}^{\prime}$ be the induced subgraph of $H_{i}$ obtained by removing the vertices of $V\left(\mathcal{F}^{\prime}\right) \cup V(P)$ except $\mathbf{e}$ and $\mathbf{f}$. The number of vertices removed is at most

$$
\left|V\left(\mathcal{F}^{\prime}\right) \cup V(P)\right| \leq(2 k-2) q n+\left(\left\lceil\frac{8 k}{\gamma^{2}}\right\rceil-(2 k-2)\right)(q n-1)<\left\lceil\frac{8 k}{\gamma^{2}}\right\rceil q n<\frac{\gamma n}{2}
$$

where the last inequality holds since $\alpha \ll \gamma$ and $k \geq 3$.
We get a $\left(k, n^{\prime}, \gamma / 2\right)$-graph system $\boldsymbol{H}^{\prime}=\left\{H_{i}^{\prime}\right\}_{i \in C}$ where $C=[n] \backslash\left(C(P) \cup C\left(\mathcal{F}^{\prime}\right)\right)$ and $n^{\prime}=$ $\left|V\left(H_{i}^{\prime}\right)\right|$. Taking a $\left(\left\lceil 8 k \gamma^{-2}\right\rceil-(k-1)\right)$-subset $C^{\prime}$ of $C$, we apply Lemma 2.6 to $\left\{H_{i}^{\prime}\right\}_{i \in C^{\prime}}$ with $\mathbf{e}^{\prime}=\left(u_{k-1}, \ldots, u_{1}\right)$ and $\mathbf{f}^{\prime}=\left(v_{k-1}, \ldots, v_{1}\right)$, obtaining an $\boldsymbol{H}$-transversal path $P^{\prime}$ connecting $\mathbf{e}^{\prime}$ and $\mathbf{f}^{\prime}$ such that $\left|V\left(P^{\prime}\right)\right| \leq\left\lceil 8 k \gamma^{-2}\right\rceil$. Thus, $P \cup P^{\prime} \cup P_{j+1}$ forms an $\boldsymbol{H}$-transversal path.

After connecting all paths in $\boldsymbol{F}^{\prime}$ in a cyclic order, we obtain an $\boldsymbol{H}$-transversal $(k-1)$-cycle $A$ with at most

$$
(2 k-2) q n+\left(\left\lceil\frac{8 k}{\gamma^{2}}\right\rceil-(2 k-2)\right) q n \leq \frac{\gamma n}{2}
$$

vertices. Finally, fix any $\boldsymbol{H}$-transversal family of paths $\mathcal{P}$ and any vertex set $U$ in $V \backslash V(A)$ with $|\mathcal{P}|,|U| \leq \kappa n$. We may assume that $U \cap V(\mathcal{P})=\emptyset$ as otherwise we just replace $U$ be $U \backslash V(\mathcal{P})$. Since the paths in $\mathcal{P}$ are vertex disjoint, and $V(\mathcal{P}), U$ and $V(A)$ are pairwise disjoint, we infer that the number of colors in $\boldsymbol{H}$ not used in $\mathcal{P}$ or $A$ is at least $n-|V(A)|-(|V(\mathcal{P})|-(k-1)|\mathcal{P}|) \geq$ $n-|V(A)|-(n-|V(A)|-|U|-(k-1)|\mathcal{P}|)=|U|+(k-1)|\mathcal{P}|$. Thus, by the property of $\mathcal{F}^{\prime}$ and the fact that $\kappa \ll \beta$, there is an $\boldsymbol{H}$-transversal cycle $A^{\prime}$ with vertex set $V(A) \cup U \cup V(\mathcal{P})$ and $C(A) \subseteq C\left(A^{\prime}\right)$.

## 4. Transversal Path cover lemma

In this section, we prove our Path Cover Lemma, Lemma 2.7.
4.1. Weak Regularity Lemma for Hypergraphs. A $k$-graph $H$ is $k$-partite if there is a partition $V(H)=V_{1} \cup \cdots \cup V_{k}$ such that every edge of $H$ intersects each set $V_{i}$ in precisely one vertex for $i \in[k]$. Given a $k$-partite $k$-graph $H$ on $V_{1} \cup \cdots \cup V_{k}$ and subsets $A_{i} \subset V_{i}, i \in[k]$, we define $e_{H}\left(A_{1}, \ldots, A_{k}\right)$ to be the number of edges in $H$ with one vertex in each $A_{i}$ and the density of $H$ with respect to $\left(A_{1}, \ldots, A_{k}\right)$ as

$$
d_{H}\left(A_{1}, \ldots, A_{k}\right)=\frac{e_{H}\left(A_{1}, \ldots, A_{k}\right)}{\left|A_{1}\right| \cdots\left|A_{k}\right|} .
$$

We say that a $k$-partite $k$-graph $H$ is $\varepsilon$-regular if for all $A_{i} \subseteq V_{i}$ with $\left|A_{i}\right| \geq \varepsilon\left|V_{i}\right|, i \in[k]$, we have

$$
\left|d_{H}\left(A_{1}, \ldots, A_{k}\right)-d_{H}\left(V_{1}, \ldots, V_{k}\right)\right| \leq \varepsilon
$$

We give a straightforward generalization of the graph regularity lemma.
Lemma 4.1 (Weak regularity lemma for hypergraphs [37]). For any $k \geq 2, \varepsilon>0$ and $t_{0} \in \mathbb{N}$, there exists $T_{0} \in \mathbb{N}$ such that the following holds. For every $k$-graph $H$ on sufficiently large $n \in \mathbb{N}$
vertices, there is, for some $t \in \mathbb{N}$ with $t_{0} \leq t \leq T_{0}$, a partition $V(H)=V_{0} \cup V_{1} \cup \cdots \cup V_{t}$ such that $\left|V_{0}\right| \leq \varepsilon n,\left|V_{1}\right|=\left|V_{2}\right|=\cdots=\left|V_{t}\right|$ and for all but at most $\varepsilon t^{k}$ sets $\left\{i_{1}, \ldots, i_{k}\right\} \in\binom{[t]}{k}$, the induced $k$-partite $k$-graph $H\left[V_{i_{1}}, \ldots, V_{i_{k}}\right]$ is $\varepsilon$-regular.

The partition in Lemma 4.1 is called an $\varepsilon$-regular partition of $H$. For an $\varepsilon$-regular partition of $H$ and $d \geq 0$, we refer to the sets $V_{i}, i \in[t]$ as clusters and define the reduced hypergraph $K=K(\varepsilon, d)$ with vertex set $[t]$ and $\left\{i_{1}, \ldots, i_{k}\right\} \in\binom{[t]}{k}$ being an edge if and only if $\left(V_{i_{1}}, \ldots, V_{i_{k}}\right)$ is $\varepsilon$-regular and $d\left(V_{i_{1}}, \ldots, V_{i_{k}}\right) \geq d$.
4.2. Proof Sketch. In this subsection we provide a proof sketch of Lemma 2.7 and highlight key ideas. We need the following definition.

Definition 4.2. A hypergraph $H^{*}$ is a $(1, k)$-graph $((1, k)$-partite, in other words), if there is a partition of $V\left(H^{*}\right)=V_{1} \cup V_{2}$ such that every edge contains exactly one vertex of $V_{1}$ and $k$ vertices of $V_{2}$.

Given a partition of $V\left(H^{*}\right)=V_{1} \cup V_{2}$, a $(1, k-1)$-subset $S$ of $V\left(H^{*}\right)$ contains one vertex in $V_{1}$ and $k-1$ vertices in $V_{2}$. Let $\delta_{1, k-1}\left(H^{*}\right):=\min \left\{\operatorname{deg}_{H^{*}}(S): S\right.$ is a $(1, k-1)$-subset of $\left.V\left(H^{*}\right)\right\}$.
Step 1. Construct an auxiliary $(1, k)$-graph. Given a $(k, n, \gamma)$-graph system $\boldsymbol{H}=\left\{H_{i}\right\}_{i \in[n]}$ on $V$, we construct the auxiliary hypergraph $H^{*}$ with vertex set $V\left(H^{*}\right)=[n] \cup V$ and edge set $E\left(H^{*}\right)=\left\{\{i\} \cup e \mid e \in E\left(H_{i}\right), i \in[n]\right\}$. By the definition of $(k, n, \gamma)$-graph system, we have $\delta_{k-1}\left(H_{i}\right) \geq(1 / 2+\gamma) n$ for each $i \in[n]$. Thus, $H^{*}$ is a $(1, k)$-graph with $\delta_{1, k-1}\left(H^{*}\right) \geq(1 / 2+\gamma) n$.
Step 2. Obtain a reduced hypergraph $K$. With an initial partition $[n] \cup V$ of $V\left(H^{*}\right)$, we apply the Weak Regularity Lemma (Lemma 4.1) to $H^{*}$, and obtain a partition $V\left(H^{*}\right)=$ $V_{0}^{*} \cup I_{1} \cup \cdots \cup I_{t_{1}} \cup W_{1} \cup \cdots \cup W_{t_{2}}$ where $\left|I_{i}\right|=\left|W_{j}\right|=m$ for every $i \in\left[t_{1}\right], j \in\left[t_{2}\right],\left|V_{0}^{*}\right| \leq 2 \varepsilon n$. By moving at most $2 \varepsilon n / m$ clusters to $V_{0}^{*}$ and renaming if necessary, we obtain a partition $V\left(H^{*}\right)=$ $V_{0} \cup I_{1} \cup \cdots \cup I_{t} \cup W_{1} \cup \cdots \cup W_{t}$, where $t=\min \left\{t_{1}, t_{2}\right\},\left|V_{0}\right| \leq 4 \varepsilon n, I_{i} \subseteq[n]$ and $W_{j} \subseteq V$ for every $i, j \in[t]$. Let $K$ be the reduced hypergraph for the partition with vertex set $\mathcal{I} \cup \mathcal{W}$ where $\mathcal{I}=\left\{I_{1}, \ldots, I_{t}\right\}$ and $\mathcal{W}=\left\{W_{1}, \ldots, W_{t}\right\}$. Note that $K$ is a $(1, k)$-graph. We will prove that $K$ almost 'inherits' the ( $1, k-1$ )-degree condition of $H^{*}$ in Section 4.3.
Step 3. Obtain many matchings in $K$. We equally split $\mathcal{I}$ into $k$ parts $\mathcal{I}_{i}=\left\{I_{(i-1) t / k+1}, \ldots, I_{i t / k}\right\}$ for $i \in[k]$. For each $\mathcal{I}_{i} \cup \mathcal{W}$, we randomly partition it to balanced smaller pieces, namely, into parts of form $\mathcal{I}^{\prime} \cup \mathcal{W}^{\prime}$, where $\left|\mathcal{I}^{\prime}\right|=Q / k$ and $\left|\mathcal{W}^{\prime}\right|=Q$. Denote the family of vertex-disjoint $(1, k)-$ subgraphs of $K$ induced on all parts from the partition of $\mathcal{I}_{i} \cup \mathcal{W}$ by $\mathcal{F}_{i}, i \in[k]$. Note that the size of $\mathcal{F}_{i}$ is $t / Q$. We shall see in Section 4.4 that almost all members in $\mathcal{F}_{i}$ are 'nice' in the sense that they inherit the $(1, k-1)$-degree condition of $H^{*}$. For each such member in $\mathcal{F}_{i}, i \in[k]$, we use the following lemma, a combination of results in ([17] Theorem 1.7) and ([6] Theorem 1.2), and obtain a perfect matching. This yields for each $i \in[k]$ a large matching (in $K$ ), say $M_{i}$, by taking the union of the resulting matchings over all members in $\mathcal{F}_{i}$.

Lemma 4.3 ( $[6,17])$. For every $\gamma>0, k \in \mathbb{N}$, the following holds for all sufficiently large $n \in k \mathbb{N}$. every $(1, k)$-graph $H$ on $[n / k] \cup V$ with $\delta_{1, k-1}(H) \geq(1 / 2+\gamma) n$ admits a perfect matching, where $|V|=n$.

Step 4. Embed the paths. Now back to the original $(1, k)$-graph $H^{*}$, each matching edge in $\bigcup_{i \in[k]} M_{i}$ can be blown up and we obtain an $\boldsymbol{H}$-transversal family of paths. This is achieved in Lemma 4.6. However, note that distinct matchings $M_{i}, M_{j}$ may intersect on vertices in $\mathcal{W}$. To overcome this, we build the $\boldsymbol{H}$-transversal family of paths in $H$ piece by piece by zooming in each matching $M_{i}$ one by one.
4.3. Tools. The following proposition shows that the reduced hypergraph almost inherits the minimum degree property of the original hypergraph.

Proposition 4.4. For any $\gamma>0, k \in \mathbb{N}$, there exists $\varepsilon>0$ such that the following holds for sufficiently large $t \in \mathbb{N}$. Given a $(1, k)$-graph $H^{*}$ with $\delta_{1, k-1}\left(H^{*}\right) \geq(1 / 2+\gamma) n$ and an $\varepsilon$-regular partition $V\left(H^{*}\right)=V_{0} \cup I_{1} \cup \cdots \cup I_{t} \cup W_{1} \cup \cdots \cup W_{t}$, let $K:=K(\varepsilon, \gamma / 6)$ be the reduced hypergraph. The number of $(1, k-1)$-subsets $S$ of $V(K)$ violating $\operatorname{deg}_{K}(S) \geq(1 / 2+\gamma / 4) t$ is at most $k \sqrt{\varepsilon} t^{k}$.

Proof. Let $1 / t, \varepsilon \ll \gamma$. Note that the reduced hypergraph $K(\varepsilon, \gamma / 6)$ can be written as the intersection of two hypergraphs $D:=D(\gamma / 6)$ and $R:=R(\varepsilon)$ both defined on the vertex set $\left\{I_{1}, \ldots, I_{t}, W_{1}, \ldots, W_{t}\right\}$ where

- $D$ consists of all sets $\left\{I_{i_{0}}, W_{i_{1}}, \ldots, W_{i_{k}}\right\}$ such that $d\left(I_{i_{0}}, W_{i_{1}}, \ldots, W_{i_{k}}\right) \geq \gamma / 6$,
- $R$ consists of all sets $\left\{I_{i_{0}}, W_{i_{1}}, \ldots, W_{i_{k}}\right\}$ such that $\left(I_{i_{0}}, W_{i_{1}}, \ldots, W_{i_{k}}\right)$ is $\varepsilon$-regular.

For any $(1, k-1)$-set $S$, assuming $S=\left\{I_{1}, W_{1}, W_{2}, \ldots, W_{k-1}\right\}$, we first show that

$$
\begin{equation*}
\operatorname{deg}_{D}(S) \geq\left(\frac{1}{2}+\frac{\gamma}{2}\right) t \tag{3}
\end{equation*}
$$

Note that $n / t \geq m:=\left|W_{i}\right|=\left|I_{j}\right|$ for $i, j \in[t]$. We now consider the number $z$ of edges in $H^{*}$ which intersect each of $I_{i_{0}}, W_{i_{1}}, \ldots, W_{i_{k-1}}$ in exactly one vertex. If (3) does not hold, then from the condition on $\delta_{1, k-1}\left(H^{*}\right)$, we have

$$
\begin{equation*}
t m^{k+1}\left(\frac{1}{2}+\frac{2 \gamma}{3}\right) \leq m^{k}\left(\left(\frac{1}{2}+\gamma\right) n-(k-1) m\right) \leq z<\left(\frac{1}{2}+\frac{\gamma}{2}\right) t m^{k+1}+t \frac{\gamma}{6} m^{k+1} \tag{4}
\end{equation*}
$$

a contradiction.
Note that there are at most $\varepsilon t^{k+1}$ edges in $\bar{R}$ (the complement of $R$ ). Let $\mathcal{S}$ be the family of all (1, $k-1$ )-element subsets $S$ for which $\operatorname{deg}_{\bar{R}}(S)>\sqrt{\varepsilon} t$. We have $|\mathcal{S}| \leq k \sqrt{\varepsilon} t^{k}$. This, together with (3) and $\varepsilon \ll \gamma$, implies that all but at most $k \sqrt{\varepsilon} t^{k}(1, k-1)$-sets $S \subseteq V(K)$ satisfy $\operatorname{deg}_{K}(S) \geq$ $\operatorname{deg}_{D}(S)-\sqrt{\varepsilon} t \geq\left(\frac{1}{2}+\frac{\gamma}{4}\right) t$.
4.4. Random Partition. Ferber and Kwan [27] showed that if we randomly partition the vertex set of a $k$-graph $H$, then the subgraph of $H$ induced on almost all parts inherits the minimum degree of $H$. Here we need such a result for our ( $1, k$ )-graphs, whose proof follows almost identical as that in [27]. We include a proof for completeness.

Lemma 4.5 (Partition Lemma). Suppose that $k \geq 3, \lambda, \gamma>0$, there exist $\eta>0$ and $Q \in k \mathbb{N}$ such that the following holds for $t \in Q \mathbb{N}$. If $H^{*}$ is a $(1, k)$-graph on $\left[\frac{t}{k}\right] \cup V$ with $|V|=t$ where all but at most $\frac{\eta t}{k}\binom{t}{k-1}$ of the $(1, k-1)$-subsets of $V\left(H^{*}\right)$ have degree at least $(1 / 2+\gamma)(t-k+1)$, then there is a partition $V\left(H^{*}\right)=S_{1} \cup \cdots \cup S_{t / Q}$ such that all but at most $\lambda t / Q$ classes $S_{i}$ satisfy
$\delta_{1, k-1}\left(H^{*}\left[S_{i}\right]\right) \geq(1 / 2+\gamma / 2)(Q-k+1)$ where each $S_{i}$ consists of a $Q / k$-subset of $[t / k]$ and $a$ $Q$-subset of $V$.

Proof. Let $\eta \ll 1 / Q \ll \lambda, \gamma$. Partition $[t / k]$ into $t / Q$ sets $I_{1}, \ldots, I_{t / Q}$ randomly such that $\left|I_{i}\right|=Q / k$ for $i \in[t / Q]$. We randomly order $V$ as $v_{1}, \ldots, v_{t}$ and let $V_{i}=\left\{v_{(i-1) Q+1}, \ldots, v_{i Q}\right\}$ for $i \in[t / Q]$. Let $S_{i}=I_{i} \cup V_{i}$ for $i \in[t / Q]$. Note that each $V_{i}$ is a random subset of $V$. Let $M^{*}$ be the collection of $(1, k-1)$-subsets with degree less than $(1 / 2+\gamma)(t-k+1)$ in $H^{*}$. Then $\left|M^{*}\right| \leq \frac{\eta t}{k}\binom{t}{k-1}$. We will prove that for $i \in[t / Q]$ and every $(1, k-1)$-subset $S$ of $S_{i}$,

$$
\begin{equation*}
\operatorname{Pr}\left[\operatorname{deg}_{H^{*}\left[S_{i}\right]}(S)<\left(\frac{1}{2}+\frac{\gamma}{2}\right)(Q-k+1)\right] \leq \eta+e^{-\Omega\left(\gamma^{2} Q\right)} . \tag{5}
\end{equation*}
$$

First note that the probability of the event $S \in M^{*}$, is at most $\eta$. Now let $A_{S}$ be the event that $S$ is not in $M^{*}$. The set $V_{i} \backslash S$ is equivalent to a uniformly random set of size $Q-(k-1)$ in $V \backslash S$. Let $A$ denote the event that a vertex $v$ in $V_{i} \backslash S$ such that $S \cup\{v\} \in E\left(H^{*}\right)$. Note that

$$
\operatorname{Pr}\left[A \mid A_{S}\right] \geq \frac{\left(\frac{1}{2}+\gamma\right)(t-k+1)\binom{t-k}{Q-k}}{(Q-(k-1))\binom{t-(k-1)}{Q-(k-1)}}=\frac{1}{2}+\gamma,
$$

then we have

$$
\mathbb{E}\left[\operatorname{deg}_{H^{*}\left[S_{i}\right]}(S) \mid A_{S}\right] \geq\left(\frac{1}{2}+\gamma\right)(Q-k+1)
$$

Exchanging any element with an element outside $V_{i} \backslash S$ affects $\operatorname{deg}_{H^{*}\left[S_{i}\right]}(S)$ by at most 1 . Fixing $i$, we apply Proposition 2.2 with $S \notin M^{*}$, the probability that $S$ has degree less than $(1 / 2+\gamma / 2)(Q-k+1)$ in $H^{*}\left[S_{i}\right]$ is at most

$$
2 \exp \left(-\frac{2\left(\frac{\gamma}{2}(Q-k+1)\right)^{2}}{(Q-k+1)}\right)=e^{-\Omega\left(\gamma^{2} Q\right)}
$$

Thus, (5) is proved.
We say that $S_{i}$ is poor if some ( $1, k-1$ )-set in the induced graph $H^{*}\left[S_{i}\right]$ has degree less than $(1 / 2+\gamma / 2)(Q-k+1)$. By (5), $\operatorname{Pr}\left[S_{i}\right.$ is poor $] \leq \frac{Q}{k}\binom{Q}{k-1}\left(\eta+e^{-\Omega\left(\gamma^{2} Q\right)}\right)$ for $i \in[t / Q]$. Let $X$ be the number of poor classes in our partition, then $\mathbb{E}[X] \leq \frac{t}{k}\binom{Q}{k-1}\left(\eta+e^{-\Omega\left(\gamma^{2} Q\right)}\right)$. By Markov's inequality, we obtain

$$
\operatorname{Pr}\left[X \geq \lambda \frac{t}{Q}\right] \leq \frac{Q}{\lambda k}\binom{Q}{k-1}\left(\eta+e^{-\Omega\left(\gamma^{2} Q\right)}\right) .
$$

By the choice of $\eta \ll 1 / Q \ll \lambda, \gamma$, it follows that

$$
\frac{Q}{k}\binom{Q}{k-1}\left(\eta+e^{-\Omega\left(\gamma^{2} Q\right)}\right)<\lambda
$$

and thus $\operatorname{Pr}\left[X \geq \lambda \frac{t}{Q}\right]<1$. Therefore, there is a partition $V\left(H^{*}\right)=S_{1} \cup \cdots \cup S_{t / Q}$, where $S_{i}=I_{i} \cup V_{i}$, such that at least $(1-\lambda) t / Q$ classes of them satisfy $\delta_{1, k-1}\left(H^{*}\left[S_{i}\right]\right) \geq(1 / 2+\gamma / 2)(Q-k+1)$.
4.5. Path Embeddings. Given a $(k+1)$-partite $(k+1)$-graph $H$ on $V_{0} \cup V_{1} \cup \cdots \cup V_{k}$, we call that a ( $k-1$ )-subset $S$ of $V(H)$ is legal if $\left|S \cap V_{i}\right| \leq 1$ for $i \in[k]$ and $\left|S \cap V_{0}\right|=0$. An expanded path $P$ of length $t$ in $H$ is a $(k+1)$-graph with vertex set $\left\{c_{1}, \ldots, c_{t}\right\} \cup\left\{v_{1}, \ldots, v_{t+k-1}\right\}$ where $\left\{c_{1}, \ldots, c_{t}\right\} \subseteq V_{0}$, $\left\{v_{1}, \ldots, v_{t+k-1}\right\} \subseteq V_{1} \cup \cdots \cup V_{k}$ and edge set $\left\{e_{1}, \ldots, e_{t}\right\}$ such that $e_{i}=\left\{c_{i}, v_{i}, \ldots, v_{i+k-1}\right\}$. Note that $\left|V(P) \cap V_{j}\right|=\left\lfloor\frac{t+k-1}{k}\right\rfloor$ or $\left\lceil\frac{t+k-1}{k}\right\rceil$ for $j \in[k]$.


Figure 3. An expanded path in a 4 -partite 4 -graph (the vertices with the same color are from the same part)

Lemma 4.6. Given $c, m>0$ and $k \geq 2$, every $(k+1)$-partite $(k+1)$-graph $H$ on $V_{0} \cup V_{1} \cup \cdots \cup V_{k}$ with at most $m$ vertices in each part and with at least $\mathrm{cm}^{k+1}$ edges contains an expanded path of at least cm/k vertices.

Proof. There are at most $k \cdot m^{k-1}$ legal $(k-1)$-subsets of $V(H)$. We proceed the following process iteratively. If there is a legal $(k-1)$-subset $S$, which is contained in less than $\mathrm{cm}^{2} / k$ edges in the current hypergraph, then we delete all the edges containing $S$. The process terminates at a nonempty hypergraph $H_{0}$ since less than $k m^{k-1}\left(\mathrm{~cm}^{2} / k\right)=c m^{k+1}$ edges have been deleted in total. In $H_{0}$, every legal $(k-1)$-subset has degree either zero or at least $\mathrm{cm}^{2} / k$.

Let $P$ be a longest expanded path in $H_{0}$ with vertex set $\left\{c_{1}, \ldots, c_{t}\right\} \cup\left\{v_{1}, \ldots, v_{t+k-1}\right\}$ for some integer $t$. We have $\left|V(P) \cap V_{0}\right|=t$ and $\left|V(P) \cap V_{i}\right| \leq t$ since each edge contains exactly one vertex of $V_{i}$ for each $i \in[k]$. Consider $S_{t}=\left\{v_{t+1}, \ldots, v_{t+k-1}\right\}$, which is a legal $(k-1)$-subset of $V(H)$. Furthermore, $\operatorname{deg}_{H_{0}}\left(S_{t}\right) \geq \mathrm{cm}^{2} / k$ since $S_{t}$ has positive degree. All the edges containing $S_{t}$ must intersect $\left(V(P) \cap V_{0}\right) \cup\left(V(P) \cap V_{j}\right)$ by the maximality of $P$, where the index $j>0$ such that $S_{t} \cap V_{j}=\emptyset$. Thus, we have

$$
\begin{equation*}
\frac{c m^{2}}{k} \leq\left|V(P) \cap V_{0}\right| \cdot\left|V_{j}\right|+\left|V(P) \cap V_{j}\right| \cdot\left|V_{0}\right| \leq 2 t m \tag{6}
\end{equation*}
$$

which implies $t \geq c m /(2 k)$. Note that $|V(P)|=t+t+k-1$ and thus $|V(P)| \geq c m / k$.
The next result enables us to find a family of long vertex-disjoint expanded paths which covers almost all vertices in $V_{0}$ in an $\varepsilon$-regular $(k+1)$-partite $(k+1)$-graph.

Lemma 4.7. For any $\alpha>0, k \in \mathbb{N}$, there exists $\varepsilon>0$ such that the following holds for sufficiently large $m \in \mathbb{N}$. Suppose $H$ is an $\varepsilon$-regular $(k+1)$-partite $(k+1)$-graph with density at least $\alpha$ and $V(H)=V_{0} \cup V_{1} \cup \cdots \cup V_{k}$ where $\left|V_{0}\right|=m, m / k \leq\left|V_{i}\right| \leq m$ for $i \in[k]$. Then we obtain that $H$ contains a family $\mathcal{P}$ of vertex-disjoint expanded paths such that for each $P \in \mathcal{P},|V(P)| \geq$ $\varepsilon(\alpha-\varepsilon) m / k$ and $\sum_{P \in \mathcal{P}}\left|V(P) \cap V_{0}\right| \geq(1-2 k \varepsilon) m$.

Proof. Let $1 / m \ll \varepsilon \ll \alpha, 1 / k$. We call an expanded path $P$ good if $|V(P)| \geq \varepsilon(\alpha-\varepsilon) m / k$. Let $\mathcal{P}=\left\{P_{1}, \ldots, P_{p}\right\}$ be a largest family of good, vertex-disjoint expanded paths and $\left|V\left(P_{i}\right) \cap V_{0}\right|=t_{i}$ for $i \in[p]$. Note that $\left|V\left(P_{i}\right) \cap V_{j}\right|=\left\lfloor\frac{t_{i}+k-1}{k}\right\rfloor$ or $\left\lceil\frac{t_{i}+k-1}{k}\right\rceil$ for $i \in[p]$ and $j \in[k]$. Suppose to the contrary that $\mathcal{P}$ covers less than $(1-2 k \varepsilon) m$ vertices of $V_{0}$ and thus $\sum_{i \in[p]} t_{i}<(1-2 k \varepsilon) m$. Let $W=V(H)-\bigcup_{P \in \mathcal{P}} V(P)$ be the set of vertices uncovered by $\mathcal{P}$. Then we have $\left|W \cap V_{0}\right| \geq 2 k \varepsilon m$.

Hence, by the observation that $\left|V\left(P_{i}\right) \cap V_{j}\right| \leq\left\lceil\frac{t_{i}+k-1}{k}\right\rceil \leq \frac{t_{i}}{k}+2$ for each $i \in[p], j \in[k]$ and the fact that $p=|\mathcal{P}| \leq(k+1) m /(\varepsilon(\alpha-\varepsilon) m / k)=k(k+1)(\varepsilon(\alpha-\varepsilon))^{-1}$, we have that

$$
\left|W \cap V_{i}\right|=\left|V_{i}\right|-\left|V_{i} \cap V(\mathcal{P})\right| \geq \frac{m}{k}-\sum_{i \in[p]}\left(\frac{t_{i}}{k}+2\right) \geq \frac{m}{k}-\frac{(1-2 k \varepsilon) m}{k}-2 p \geq \varepsilon m+1 .
$$

Let $W_{i} \subseteq W \cap V_{i}, i \in\{0,1, \ldots, k\}$ be such that

$$
\left|W_{0}\right|=\left|W_{1}\right|=\cdots=\left|W_{k}\right|=\varepsilon m \geq \varepsilon\left|V_{i}\right| .
$$

Finally, let $\hat{H}$ be the subhypergraph of $H$ induced on the vertex set $W_{0} \cup W_{1} \cup \cdots \cup W_{k}$. Since $H$ is $\varepsilon$-regular, we have

$$
d_{H}\left(W_{0}, W_{1}, \ldots, W_{k}\right) \geq d_{H}\left(V_{0}, V_{1}, \ldots, V_{k}\right)-\varepsilon \geq \alpha-\varepsilon
$$

or equivalently,

$$
|E(\hat{H})| \geq(\alpha-\varepsilon)(\varepsilon m)^{k+1}
$$

and then Lemma 4.6 implies that there is an expanded path in $\hat{H}$ on at least $\varepsilon(\alpha-\varepsilon) m / k$ vertices, contrary to the maximality of $\mathcal{P}$.

### 4.6. Proof of Lemma 2.7.

Proof. We choose the following parameters

$$
1 / n \ll 1 / T_{0} \ll \varepsilon, 1 / t_{0} \ll 1 / Q \ll \lambda \ll \delta, \gamma, 1 / k .
$$

Given a $(k, n, \gamma)$-graph system $\boldsymbol{H}=\left\{H_{i}\right\}_{i \in[n]}$ on $V$, we construct a $(1, k)$-graph $H^{*}$ with vertex set $[n] \cup V$ and edge set $\left\{\{i\} \cup e: e \in E\left(H_{i}\right), i \in[n]\right\}$. With an initial partition $[n] \cup V$ of $V\left(H^{*}\right)$, we apply Lemma 4.1 to $H^{*}$, and obtain a partition $V\left(H^{*}\right)=V_{0}^{*} \cup I_{1} \cup \cdots \cup I_{t_{1}} \cup W_{1} \cup \cdots \cup W_{t_{2}}$ where $t_{0} \leq t_{1}, t_{2} \leq T_{0},\left|I_{i}\right|=\left|W_{j}\right|=m$ for $i \in\left[t_{1}\right]$ and $j \in\left[t_{2}\right],\left|V_{0}^{*}\right| \leq 2 \varepsilon n$. By moving at most $2 \varepsilon n / m$ clusters to $V_{0}^{*}$ and renaming if necessary, we obtain a partition $V\left(H^{*}\right)=V_{0} \cup I_{1} \cup \cdots \cup I_{t} \cup W_{1} \cup \cdots \cup W_{t}$, where $t=\min \left\{t_{1}, t_{2}\right\},\left|V_{0}\right| \leq 4 \varepsilon n, I_{i} \subseteq[n]$ and $W_{j} \subseteq V$ for every $i, j \in[t]$. Let $L=\left\lceil\frac{3 k T_{0}}{\varepsilon(\gamma / 6-\varepsilon)}\right\rceil$.

Let $K:=K(\varepsilon, \gamma / 6)$ be the $(1, k)$-partite reduced hypergraph on $\mathcal{I} \cup \mathcal{W}$ where $\mathcal{I}=\left\{I_{1}, \ldots, I_{t}\right\}$ and $\mathcal{W}=\left\{W_{1}, \ldots, W_{t}\right\}$. We get a family of $(1, k)$-graphs $\mathcal{F}=\left\{F_{1}, \ldots, F_{k}\right\}$ where $F_{i}=K\left[\left\{I_{(i-1) t / k+1}\right.\right.$, $\left.\left.\ldots, I_{i t / k}\right\} \cup \mathcal{W}\right]$ for $i \in[k]$.

For each $i \in[k]$, applying Proposition 4.4 and Lemma 4.5 to $F_{i}$ with $\eta=k \sqrt{\varepsilon}$, we obtain a partition $V\left(F_{i}\right)=S_{i, 1} \cup \cdots \cup S_{i, t / Q}$ such that each $S_{i, j}$ consists of $Q / k$ vertices in $\mathcal{I}$ and $Q$ vertices in $\mathcal{W}$, and all but at most $\lambda t / Q$ classes $S_{i, j}$ satisfy $\delta_{1, k-1}\left(F_{i}\left[S_{i, j}\right]\right) \geq(1 / 2+\gamma / 2)(Q-k+1)$ where $j \in[t / Q]$. We call such classes $S_{i, j}$ nice. Denote by $\mathcal{S}_{i}$ the set of indices $j$ such that $S_{i, j}$ is nice. Then $\left|\mathcal{S}_{i}\right| \geq(1-\lambda) t / Q$. Applying Lemma 4.3 to each $F_{i}\left[S_{i, \ell}\right]$ for $i \in[k], \ell \in \mathcal{S}_{i}$, we obtain a perfect matching $M_{i, \ell}$. Let $M_{i}=\bigcup_{\ell \in \mathcal{S}_{i}} M_{i, \ell}$ and $M=\bigcup_{i \in[k]} M_{i}$. Note that each $M_{i}$ is a matching in $F_{i}$. For each $W_{j} \in \mathcal{W}$, let $p_{j}$ be the number of edges in $M$ that contain $W_{j}, j \in[t]$. Then $\sum_{j \in[t]} p_{j} \geq k \cdot(1-\lambda) \frac{t}{Q} \cdot Q=(1-\lambda) k t$. Next, we proceed the following process.

## Path Embedding Process:

Given $H^{*}, \mathcal{I}=\left\{I_{1}, \ldots, I_{t}\right\}, \mathcal{W}=\left\{W_{1}, \ldots, W_{t}\right\}, M_{1}, \ldots, M_{k}$, we initialize $W_{j}^{*}:=W_{j}$ for $j \in[t]$ and $i:=1$.

Step 1. For each $e \in M_{i}$, let $H_{e}$ be the subgraph of $H^{*}$ induced on the corresponding clusters constituting the edge $e$, we denote by $I_{e}, W_{j_{1}(e)}^{*}, \ldots, W_{j_{k}(e)}^{*}$ where $I_{e} \in \mathcal{I}$.
Step 2. Applying Lemma 4.7 to each $H_{e}, e \in M_{i}$ with $\alpha=\gamma / 6$, we obtain a family $\mathcal{P}_{e}$ of vertexdisjoint expanded paths that covers all but at most $2 k \varepsilon m$ vertices in $I_{e}$ and for each $P \in \mathcal{P}_{e}$, $|V(P)| \geq \varepsilon(\gamma / 6-\varepsilon) m / k$.
Step 3. Let $\mathcal{P}_{i}=\bigcup_{j \leq i} \bigcup_{e \in M_{j}} \mathcal{P}_{e}$ and update $W_{j}^{*}$ by deleting the vertices used in $\mathcal{P}_{i}$ for $j \in[t]$.
Step 4. Update $i:=i+1$ and if $i \leq k$, go to Step 1; otherwise terminate the process.
After the process, we obtain $\mathcal{P}:=\mathcal{P}_{k}$. It follows from the definition of $p_{j}$ that the size of uncovered vertices of each $W_{j}$ is

$$
\left|W_{j}^{*}\right|=m-\sum_{W_{j} \in e, e \in M}\left|\mathcal{P}_{e} \cap W_{j}\right| \leq m-p_{j}\left\lfloor\frac{(1-2 k \varepsilon) m+k-1}{k}\right\rfloor \leq m-p_{j} \frac{(1-2 k \varepsilon) m}{k} .
$$

Recall that $\sum_{j \in[t]} p_{j} \geq(1-\lambda) k t$. We obtain that $\mathcal{P}$ covers all but

$$
\left|V_{0}\right|+\sum_{j \in[t]}\left|W_{j}^{*}\right| \leq 4 \varepsilon n+\sum_{j \in[t]}\left(m-p_{j} \frac{(1-2 k \varepsilon) m}{k}\right) \leq(4(k+1) \varepsilon+\lambda) n \leq \delta n
$$

vertices of $V$. Moreover, since $|V(P)| \geq \frac{\varepsilon\left(\frac{\gamma}{6}-\varepsilon\right)}{k}\left\lfloor\frac{n}{t}\right\rfloor$ for each path $P \in \mathcal{P}$ and $t \leq T_{0}$, we have $|\mathcal{P}|<2 n /\left(\frac{\varepsilon\left(\frac{\gamma}{6}-\varepsilon\right)}{k}\left\lfloor\frac{n}{t}\right\rfloor\right)<L$. Finally, observe that $\mathcal{P}$ gives rise to an $\boldsymbol{H}$-transversal family of paths which completes the proof.

## 5. Concluding Remarks

Inspired by a series of recent successes on transversal settings of matchings [57, 56, 58, 59] and Hamilton cycles [43], we suspect the threshold for transversal Hamilton cycle in a $k$-graph system is the same with the threshold for Hamilton cycle in a single $k$-graph.

Conjecture 5.1. Suppose $\boldsymbol{H}=\left\{H_{i}\right\}_{i \in[n]}$ is an n-vertex $k$-graph system on $V$, $n \geq k+1 \geq 4$, such that $\delta_{k-1}\left(H_{i}\right) \geq\lfloor(n-k+3) / 2\rfloor$, then there is an $\boldsymbol{H}$-transversal Hamilton cycle.

On the other hand, the problem of giving the sufficient condition for the transversal Hamilton $\ell$-cycles, $\ell \in[k-2]$, is still open.

## Appendix A. The postponed proofs

In this section, we prove Lemma 2.6. The idea of the proof is to grow tree-like structures (called cascades) from both designated ends $e_{1}$ and $e_{2}$ until they meet, forming the $\boldsymbol{H}$-transversal path as desired. Our proof follows almost identical as that in [54, 66]. Before we describe the cascades, it is convenient to introduce the following notation. For two sequences of vertices

$$
\omega_{1}=\left(v_{1}, \ldots, v_{r}, w_{1}, \ldots, w_{s}\right) \text { and } \omega_{2}=\left(w_{1}, \ldots, w_{s}, u_{1}, \ldots, u_{t}\right)
$$

where $r, t \geq 1, s \geq 0$ and all vertices are distinct, we define their concatenation as

$$
\omega_{1} \omega_{2}=\left(v_{1}, \ldots, v_{r}, w_{1}, \ldots, w_{s}, u_{1}, \ldots, u_{t}\right)
$$

This operation can be iterated. For instance, if $\omega_{1}=\left(w_{1}, \ldots, w_{k-2}\right), \omega_{2}=\left(w_{2}, \ldots, w_{k-1}\right)$ and $\omega_{3}=\left(w_{3}, \ldots, w_{k}\right)$ where all $w_{i}$ are distinct, then $\omega_{1} \omega_{2} \omega_{3}=\left(w_{1}, \ldots, w_{k}\right)$. We could write $\omega_{1} \omega_{2} w_{k}$ instead of $\omega_{1} \omega_{2} \omega_{3}$. Let $e_{0}=\left(v_{1}, \ldots, v_{k-1}\right)$ be a given $(k-1)$-tuple of vertices. We will define the transversal $e_{0}$-cascade as an auxiliary sequence of bipartite graphs $G_{j}, j=1,2, \ldots$, with bipartitions $\left(A_{j-1}, A_{j}\right)$, whose vertices are $(k-2)$-tuples of the vertices of $H$ and the edges correspond to some $(k-1)$-tuples of the vertices of $H$. Each node $f \in A_{j}$ belongs to two graphs $G_{j}$ and $G_{j+1}$. Its neighbors in $G_{j}$ belongs to $A_{j-1}$, while its neighbors in $G_{j+1}$ belongs to $A_{j+1}$. For a node $f=\left(v_{1}, \ldots, v_{k-2}\right)$ of the transversal cascade, the vertex $v_{1}$ is called the prefix, while $v_{k-2}$ is called the suffix of $f$.

We define the transversal cascade recursively as follows. Let $e_{0}=\left(v_{1}, \ldots, v_{k-1}\right), f_{0}=\left(v_{2}, \ldots, v_{k-1}\right)$ and $A_{0}=\left\{f_{0}\right\}$. For every vertex $v \notin e_{0}$, we include the node $g=\left(v_{3}, \ldots, v_{k-1}, v\right)$ in the set $A_{1}$ if and only if $v_{1} f_{0} g=e_{0} v \in H_{c_{1}}$ for $c_{1} \in[c]$. The graph $G_{1}$ is the star with center $f_{0}$ and the arms leading to all the nodes $g \in A_{1}$.

Further, let $A_{2}$ be the set of all $(k-2)$-tuples $h$ such that for some node $g \in A_{1}$ we have $f_{0} g h \in H_{c_{2}}$ where $c_{2} \neq c_{1}$ and $c_{2} \in[c]$. Note that each $h \in A_{2}$ is obtained from a node $g \in A_{1}$ by dropping the prefix of $g$ and adding a new suffix $u$, we denote such node by $g_{u}$. The graph $G_{2}$ consists of all edges $\{g, h\}$ where $g \in A_{1}, h \in A_{2}$ and $f_{0} g h \in H_{c_{2}}$, it is equal to say $G_{2}$ consists of all edges $\left\{g, g_{u}\right\}$ where $f_{0} g u \in H_{c_{2}}$.

For $j=3, \ldots, k-2$, we similarly define

$$
A_{j}=\left\{h: \exists f \in A_{j-2}, g \in A_{j-1} \text { such that }\{f, g\} \in G_{j-1}, f g h \in H_{c_{j}} \text { where } c_{j} \neq c_{\ell} \text { for } \ell \in[j-1]\right\}
$$

and $G_{j}$ as the bipartite graph with bipartition $\left(A_{j-1}, A_{j}\right)$ and the edge set
$\left\{\{g, h\}: \exists f \in A_{j-2}\right.$ such that $\{f, g\} \in G_{j-1}$ and $f g h \in H_{c_{j}}$, where $c_{j} \neq c_{\ell}$ for $\left.\ell \in[j-1]\right\}$.
In other words, $A_{j}$ and $G_{j}$ correspond to the sets of $(k-2)$-tuples and $(k-1)$-tuples of the vertices of $V$ which can be reached from $e_{0}$ in $j$ steps by an $\boldsymbol{H}$-transversal path.

First refinement. Having defined $A_{j}$ and $G_{j}$ for $j \leq k$, beginning with $j=k-1$ we change the recursive mechanism by getting rid of the nodes in $A_{j}$ with too small degree in $G_{j}$. We define auxiliary
$A_{k-1}^{\prime}=\left\{h: \exists f \in A_{k-3}, g \in A_{k-2}\right.$ such that $\{f, g\} \in G_{k-2}, f g h \in H_{c_{k-1}}$ where $c_{k-1} \neq c_{\ell}$ for $\left.\ell \in[k-2]\right\}$
and $G_{k-1}^{\prime}$ as the bipartite graph with bipartition $\left(A_{k-2}, A_{k-1}^{\prime}\right)$ and the edge set

$$
\left\{\{g, h\}: \exists f \in A_{k-3} \text { such that }\{f, g\} \in G_{k-2} \text { and } f g h \in H_{c_{k-1}} \text { where } c_{k-1} \neq c_{\ell} \text { for } \ell \in[k-2]\right\} .
$$

Then let $A_{k-1}$ be the subset of $A_{k-1}^{\prime}$ consisting of all nodes $h$ with $\operatorname{deg}_{G_{k-1}^{\prime}}(h) \geq \sqrt{n}$ and set $G_{k-1}=G_{k-1}^{\prime}\left[A_{k-2} \cup A_{k-1}\right]$.

Second refinement. For $j \geq k$, to form an edge $\{g, h\}$ of $G_{j}$ we will now require not one but many nodes $f \in A_{j-2}$ to fulfil the above definition.

Set $m=\left\lceil n^{1 / 4}\right\rceil$. Having defined $G_{j-1}$, let $A_{j}^{\prime}=\left\{h: \exists f_{1}, \ldots, f_{m} \in A_{j-2}, g \in A_{j-1}\right.$ such that for all $i \in[m],\left\{f_{i}, g\right\} \in G_{j-1}$ and $f_{i} g h \in H_{c_{j}}$ where $c_{j} \neq c_{\ell}$ for $\left.\ell \in[j-1]\right\}$ and let $G_{j}^{\prime}$ be the bipartite graph with bipartition $\left(A_{j-1}, A_{j}^{\prime}\right)$ and the edge set $\left\{\{g, h\}: \exists f_{1}, \ldots, f_{m} \in A_{j-2}\right.$ such that for all $i \in$ $[m],\left\{f_{i}, g\right\} \in G_{j-1}$ and $f_{i} g h \in H_{c_{j}}$ where $c_{j} \neq c_{\ell}$ for $\left.\ell \in[j-1]\right\}$.

Finally, let $A_{j}$ be the subset of $A_{j}^{\prime}$ consisting of all nodes $h$ with $\operatorname{deg}_{G_{j}^{\prime}}(h) \geq \sqrt{n}$ and let $G_{j}=$ $G_{j}^{\prime}\left[A_{j-1} \cup A_{j}\right]$. The sequence $\left(G_{j}\right), j=1,2, \ldots$, will be called the transversal $e_{0}$-cascade.

## A.1. Properties of the cascade.

Claim A. 1 ([66]). For every $j \geq k-1$ and every edge $\{g, h\}$ of $G_{j}$ where $g=\left(w_{1}, \ldots, w_{k-2}\right) \in$ $A_{j-1}, h=\left(w_{2}, \ldots, w_{k-1}\right) \in A_{j}$ and $(g \cup h) \cap e_{0}=\emptyset$ and for every set of vertices $W \subset V \backslash\left(g \cup h \cup e_{0}\right)$ such that $j+|W| \leq n^{1 / 4}$, there is an $\boldsymbol{H}$-transversal path $P$ of length $j$ which connects $\left(w_{k-1}, \ldots, w_{1}\right)$ with $e_{0}=\left(v_{1}, \ldots, v_{k-1}\right)$ and $V(P) \cap W=\emptyset$.

Degrees. Recall that $G_{j}^{\prime}=G_{j}$ for $j \leq k-2$. For a node $g \in A_{j}$, we set

$$
d^{+}(g)=\operatorname{deg}_{G_{j+1}^{\prime}}(g) \text { and } d^{-}(g)=\operatorname{deg}_{G_{j}}(g)
$$

for the forward and backward degree of $g$ in the cascade. Note that in the definition of $d^{+}(g)$ we consider the forward degree before some small degree vertices of $A_{j+1}^{\prime}$ are removed. The reason is that we have no control over the effects of the removal on individual forward degrees. On the other hand, for all $f \in A_{j}, \operatorname{deg}_{G_{j}}(f)=\operatorname{deg}_{G_{j}^{\prime}}(f)$, so the backward degree is unaffected unless the node is removed. It is trivial that $d^{-}(g), d^{+}(g) \leq n-k+2$. Observe that $G_{1} \cup \cdots \cup G_{k-2}$ is a tree, thus, $d^{-}(g)=1$ for all $g \in A_{j}, j=1, \ldots, k-2$. Recall that for $j \geq k-1$ the graph $G_{j}$ is obtained from $G_{j}^{\prime}$ by removing nodes $g$ with $\operatorname{deg}_{G_{j}^{\prime}}(g)<\sqrt{n}$. Hence our construction guarantees that for all $g \in A_{j}, j \geq k-1$, we have $d^{-}(g) \geq \sqrt{n}$.

For all $j \leq k-2$ and all $g \in A_{j}$,

$$
\begin{equation*}
d^{+}(g) \geq\left(\frac{1}{2}+\gamma\right) n \tag{7}
\end{equation*}
$$

since there are at least $\left(\frac{1}{2}+\gamma\right) n$ vertices $u$ such that $f g u \in H_{c_{j+1}}$ where $f$ is the neighbor of $g$ in $A_{j-1}$. Each such vertex $u$ corresponds to a neighbor $g_{u}$ of $g$ in $A_{j+1}$.

For $j \geq k$, the second refinement affects and no lower bound on $d^{+}(g)$ is obvious. However, the lower bound $d^{-}(g) \geq \sqrt{n}$ introduced by the first refinement maintains.

Growth. By inequality (7), for each $j \in[k-2]$, we have

$$
\begin{equation*}
\left|G_{j}\right|=\left|A_{j}\right| \geq\left(\frac{1}{2}+\gamma\right)^{j} n^{j}, \tag{8}
\end{equation*}
$$

$$
\begin{equation*}
\left|G_{k-1}\right| \geq\left(\frac{1}{2}+\gamma\right)^{k-1} n^{k-1} \tag{9}
\end{equation*}
$$

Call a node $f \in A_{j}$ small if $d^{-}(f)<\frac{1}{2} n$ and denote by $S_{j}$ the subset of $A_{j}$ consisting of the small nodes. Assume for simplicity that $1 / \varepsilon^{2}$ is an integer.

Claim A. 2 ([66]). There exists an index $j_{0}, k-1 \leq j_{0} \leq k-1+(k-1) / \gamma^{2}$ such that for all $j \in\left[j_{0}, j_{0}+k-2\right]$ we have $\left|S_{j}\right| \leq 2 \gamma n^{k-2}$.

Claim A. 3 ([66]). Let

$$
k \gamma^{2^{2-k}}<2^{-k}
$$

and let $j_{0}$ be as in Claim A.2. Then $\left|A_{j_{0}+k-2} \backslash S_{j_{0}+k-2}\right| \geq\left(n-k+2-\gamma^{2^{2-k}} n\right)^{k-2}$.
A.2. The completion of the proof of Lemma 2.6. Let $\gamma_{0}$ satisfy the condition in Claim A.3, i.e. $\gamma_{0}:=\gamma^{2^{2-k}}$ and $k \gamma_{0}<2^{-k}$. Given two disjoint ( $k-1$ )-tuples of vertices $e_{1}$ and $e_{2}$, we build the transversal $e_{1}$-cascade and the transversal $e_{2}$-cascade, with the sets of nodes denoted by $A_{j}$ and $B_{j}$.

Let $j_{1}=j_{0}+k-2$, where $j_{0}$ is the index guaranteed by Claim A. 2 for the transversal $e_{1}$-cascade. Then by Claim A.3, with sufficiently large $n$, using Bernoulli inequality, we have

$$
\left|A_{j_{1}} \backslash S_{j_{1}}\right| \geq\left(n-2 \gamma_{0} n\right)^{k-2}>\left(1-2 k \gamma_{0}\right) n^{k-2} .
$$

On the other hand by inequality (8) for $j=k-2$, we have $\left|B_{k-2}\right|>2^{2-k} n^{k-2}$,

$$
\left|B_{k-2} \cap\left(A_{j_{1}} \backslash S_{j_{1}}\right)\right|>\left(2^{2-k}-2 k \gamma_{0}\right) n^{k-2} \geq\left(\frac{n}{2}\right)^{k-2}
$$

Hence, there is a not small node $g=\left(u_{1}, \ldots, u_{k-2}\right) \in A_{j_{1}}$ such that $g \cap\left(e_{1} \cup e_{2}\right)=\emptyset$ and $g^{\prime}=\left(u_{k-2}, \ldots, u_{1}\right) \in B_{k-2}$.

Let $e_{2}=\left(w_{1}, \ldots, w_{k-1}\right), S=\left\{u_{1}, \ldots, u_{k-2}, w_{k-1}\right\}$ and $V_{0}$ be the set of prefixes $v$ of the neighbors $f \in A_{j_{1}-1}$ of $g$. Since $g^{\prime}=\left(u_{k-2}, \ldots, u_{1}\right) \in B_{k-2}$, we obtain that $w_{1} \cdots w_{k-1} u_{k-2} \cdots u_{1}$ is an $\boldsymbol{H}$ transversal path. By Fact 3.1, we have $\left|N_{H_{c_{j_{1}}}}(S) \cap V_{0}\right|>\gamma n$, and thus, there is at least one vertex $v_{0} \notin e_{2}$ such that $\left\{v_{0}, u_{1}, \ldots, u_{k-2}, w_{k-1}\right\} \in H_{c_{j_{1}}}$.

Let $P_{1}=e_{1} \cdots v_{0} u_{1} \cdots u_{k-2}$ be an $\boldsymbol{H}$-transversal path of length $j_{1}$ which avoids the vertices of $e_{2}$. The existence of $P_{1}$ follows from Claim A. 1 with $W=e_{2}$. The path $P$ obtained from $P_{1}$ by adding the segment $\left(w_{k-1}, \ldots, w_{1}\right)$ and the "hook-up" edge $\left\{v_{0}, u_{1}, \ldots, u_{k-2}, w_{k-1}\right\}$, is the $\boldsymbol{H}$-transversal path connecting $e_{1}$ and $e_{2}$ as desired.

By the bound on $j_{0}$ established in Claim A. 2 and since $\gamma \leq 1 / 2$,

$$
|V(P)|=j_{1}+2(k-1)=j_{0}+3 k-4 \leq \frac{k-1}{\gamma^{2}}+4 k-5 \leq \frac{2 k}{\gamma^{2}} .
$$
