# ON TWO CONGRUENCE CONJECTURES OF Z.-W. SUN INVOLVING FRANEL NUMBERS

& \text { tures of Z.-W. Sun [17): Let } p>2 \text { be a prime. If } p=x^{2}+3 y^{2} \text { with } \\
& x, y \in \mathbb{Z} \text { and } x \equiv 1(\bmod 3) \text {, then } \\
& \qquad x \equiv \frac{1}{4} \sum_{k=0}^{p-1}(3 k+4) \frac{f_{k}}{2^{k}} \equiv \frac{1}{2} \sum_{k=0}^{p-1}(3 k+2) \frac{f_{k}}{(-4)^{k}}\left(\bmod p^{2}\right), \\
& \text { and if } p \equiv 1(\bmod 3) \text {, then } \\
& \qquad \sum_{k=0}^{p-1} \frac{f_{k}}{2^{k}} \equiv \sum_{k=0}^{p-1} \frac{f_{k}}{(-4)^{k}}\left(\bmod p^{3}\right), \\
& \text { where } f_{n}=\sum_{k=0}^{n}\binom{n}{k}^{3} \text { stands for the } n \text {th Franel number. }

## 1. Introduction

In 1894, Franel [2] found that the numbers

$$
f_{n}=\sum_{k=0}^{n}\binom{n}{k}^{3} \quad(n=0,1,2, \ldots)
$$

satisfy the recurrence relation (cf. [12, A000172]):

$$
(n+1)^{2} f_{n+1}=\left(7 n^{2}+7 n+2\right) f_{n}+8 n^{2} f_{n-1} \quad(n=1,2,3, \ldots) .
$$

These numbers are now called Franel numbers. Callan [1] found a combinatorial interpretation of the Franel numbers. The Franel numbers play important roles in combinatorics and number theory. The sequence $\left(f_{n}\right)_{n \geqslant 0}$ is one of the five sporadic sequences (cf. [21, Section 4]) which are integral solutions of certain Apéry-like recurrence equations and closely related to the theory of modular forms. In 2013, Sun [17] revealed some unexpected connections between the numbers

[^0]$f_{n}$ and representations of primes $p \equiv 1(\bmod 3)$ in the form $x^{2}+3 y^{2}$ with $x, y \in \mathbb{Z}$, for example, Z.-W. Sun [17, (1.2)] showed that

and in the same paper, Sun proposed some conjectures involving Franel numbers, one of which is

Conjecture 1.1. Let $p>2$ be a prime. If $p=x^{2}+3 y^{2}$ with $x, y \in \mathbb{Z}$ and $x \equiv 1(\bmod 3)$, then

$$
x \equiv \frac{1}{4} \sum_{k=0}^{p-1}(3 k+4) \frac{f_{k}}{2^{k}} \equiv \frac{1}{2} \sum_{k=0}^{p-1}(3 k+2) \frac{f_{k}}{(-4)^{k}}\left(\bmod p^{2}\right) .
$$

For more studies on Franel numbers, we refer the readers to ([3, 4, 6, 77, 8, 15, 18 , and so on).

In this paper, our first goal is to prove the above conjecture.
Theorem 1.1. Conjecture 1.1 is true.
Z.-W. Sun 17] also gave the following conjecture which is much difficult and complex.

Conjecture 1.2. Let $p>2$ be a prime. If $p \equiv 1(\bmod 3)$, then

$$
\sum_{k=0}^{p-1} \frac{f_{k}}{2^{k}} \equiv \sum_{k=0}^{p-1} \frac{f_{k}}{(-4)^{k}}\left(\bmod p^{3}\right)
$$

Our last goal is to prove this conjecture.
Theorem 1.2. Conjecture 1.2 is true.
We are going to prove Theorem 1.1 in Section 2. Section 3 is devoted to proving Theorem 1.2, Our proofs make use of some combinatorial identities which were found by the package Sigma [11] via the software Mathematica and the $p$-adic Gamma function. The proof of Theorem 1.2 is somewhat difficult and complex because it is rather convoluted. Throughout this paper, prime $p$ always $\equiv 1(\bmod 3)$, so in the following Lemmas $p>5$ or $p>3$ or $p>2$ is the same, we mention it here first.

## 2. Proof of Theorem 1.1

For a prime $p$, let $\mathbb{Z}_{p}$ denote the ring of all $p$-adic integers and let $\mathbb{Z}_{p}^{\times}:=\left\{a \in \mathbb{Z}_{p}: a\right.$ is prime to $\left.p\right\}$. For each $\alpha \in \mathbb{Z}_{p}$, define the $p$-adic
order $\nu_{p}(\alpha):=\max \left\{n \in \mathbb{N}: p^{n} \mid \alpha\right\}$ and the $p$-adic norm $|\alpha|_{p}:=$ $p^{-\nu_{p}(\alpha)}$. Define the $p$-adic gamma function $\Gamma_{p}(\cdot)$ by

\Gamma_{p}(n)=(-1)^{n} \prod_{\substack{1 \leq k<n \\(k, p)=1}} k, \quad n=1,2,3, \ldots,
$$

and

$$
\Gamma_{p}(\alpha)=\lim _{\substack{|\alpha-n|_{p} \rightarrow 0 \\ n \in \mathbb{N}}} \Gamma_{p}(n), \quad \alpha \in \mathbb{Z}_{p}
$$

In particular, we set $\Gamma_{p}(0)=1$. Following, we need to use the most basic properties of $\Gamma_{p}$, and all of them can be found in [9, 10]. For example, we know that

\frac{\Gamma_{p}(x+1)}{\Gamma_{p}(x)}= \begin{cases}-x, & \text { if }|x|_{p}=1 \\
-1, & \text { if }|x|_{p}>1\end{cases}  \tag{2.1}\\
\Gamma_{p}(1-x) \Gamma_{p}(x)=(-1)^{a_{0}(x)} \tag{2.2}
\end{gather*}
$$

where $a_{0}(x) \in\{1,2, \ldots, p\}$ such that $x \equiv a_{0}(x)(\bmod p)$. And a property we need here is the fact that for any positive integer $n$,

z_{1} \equiv z_{2}\left(\bmod p^{n}\right) \quad \text { implies } \quad \Gamma_{p}\left(z_{1}\right) \equiv \Gamma_{p}\left(z_{2}\right)\left(\bmod p^{n}\right) \tag{2.3}
\end{equation*}
$$

Lemma 2.1. ([17, Lemma 2.2]) For any $n \in \mathbb{N}$ we have

\begin{equation*}
\sum_{k=0}^{n}\binom{n}{k}^{3} z^{k}=\sum_{k=0}^{\lfloor n / 2\rfloor}\binom{n+k}{3 k}\binom{2 k}{k}\binom{3 k}{k} z^{k}(1+z)^{n-2 k} \tag{2.4}
\end{equation*}
$$

and

$$
\begin{equation*}
f_{n}=\sum_{k=0}^{n}\binom{n+2 k}{3 k}\binom{2 k}{k}\binom{3 k}{k}(-4)^{n-k} . \tag{2.5}
\end{equation*}
$$

For $n, m \in\{1,2,3, \ldots\}$, define

$$
H_{n}^{(m)}=\sum_{1 \leq k \leq n} \frac{1}{k^{m}},
$$

these numbers with $m=1$ are often called the classic harmonic numbers.
Recall that the Bernoulli polynomials are given by

B_{n}(x)=\sum_{k=0}^{n}\binom{n}{k} B_{k} x^{n-k} \quad(n=0,1,2, \ldots)
$$

Lemma 2.2. ([13, [14]) Let $p>5$ be a prime. Then

$$
\begin{gathered}
H_{p-1}^{(2)} \equiv 0(\bmod p), \quad H_{\frac{p-1}{2}}^{(2)} \equiv 0(\bmod p), \quad H_{p-1} \equiv 0\left(\bmod p^{2}\right), \\
\frac{1}{5} H_{\left\lfloor\frac{p}{6}\right\rfloor}^{(2)} \equiv H_{\left\lfloor\frac{p}{3}\right\rfloor}^{(2)} \equiv \frac{1}{2}\left(\frac{p}{3}\right) B_{p-2}\left(\frac{1}{3}\right)(\bmod p), \\
H_{\left\lfloor\frac{p}{6}\right\rfloor} \equiv-2 q_{p}(2)-\frac{3}{2} q_{p}(3)+p q_{p}^{2}(2)+\frac{3 p}{4} q_{p}^{2}(3)-\frac{5 p}{12}\left(\frac{p}{3}\right) B_{p-2}\left(\frac{1}{3}\right)\left(\bmod p^{2}\right), \\
H_{\left\lfloor\frac{p}{3}\right\rfloor} \equiv-\frac{3}{2} q_{p}(3)+\frac{3 p}{4} q_{p}^{2}(3)-\frac{p}{6}\left(\frac{p}{3}\right) B_{p-2}\left(\frac{1}{3}\right)\left(\bmod p^{2}\right), \\
H_{\frac{p-1}{2}} \equiv-2 q_{p}(2)+p q_{p}^{2}(2)\left(\bmod p^{2}\right), H_{\left\lfloor\frac{p}{4}\right\rfloor}^{(2)} \equiv(-1)^{\frac{p-1}{2}} 4 E_{p-3}(\bmod p), \\
H_{\left\lfloor\frac{2 p}{3}\right\rfloor} \equiv-\frac{3}{2} q_{p}(3)+\frac{3 p}{4} q_{p}^{2}(3)+\frac{p}{3}\left(\frac{p}{3}\right) B_{p-2}\left(\frac{1}{3}\right)\left(\bmod p^{2}\right),
\end{gathered}
$$

where $q_{p}(a)=\left(a^{p-1}-1\right) / p$ stands for the Fermat quotient.
Lemma 2.3. Let $p>2$ be a prime and $p \equiv 1(\bmod 3)$. If $0 \leq j \leq$ $(p-1) / 2$, then we have

$$
\binom{3 j}{j}\binom{p+j}{3 j+1} \equiv \frac{p}{3 j+1}\left(1-p H_{2 j}+p H_{j}\right)\left(\bmod p^{3}\right)
$$

Proof. If $0 \leq j \leq(p-1) / 2$ and $j \neq(p-1) / 3$, then we have

$$
\begin{aligned}
\binom{3 j}{j}\binom{p+j}{3 j+1} & =\frac{(p+j) \cdots(p+1) p(p-1) \cdots(p-2 j)}{j!(2 j)!(3 j+1)} \\
& \equiv \frac{p j!\left(1+p H_{j}\right)(-1)^{2 j}(2 j)!\left(1-p H_{2 j}\right)}{j!(2 j)!(3 j+1)} \\
& \equiv \frac{p}{3 j+1}\left(1-p H_{2 j}+p H_{j}\right)\left(\bmod p^{3}\right) .
\end{aligned}
$$

If $j=(p-1) / 3$, then by Lemma 2.2, we have

$$
\begin{aligned}
& \binom{p-1}{\frac{p-1}{3}}\binom{p+\frac{p-1}{3}}{\frac{p-1}{3}} \\
\equiv & \left(1-p H_{\frac{p-1}{3}}+\frac{p^{2}}{2}\left(H_{\frac{p-1}{3}}^{2}-H_{\frac{p-1}{3}}^{(2)}\right)\right)\left(1+p H_{\frac{p-1}{3}}+\frac{p^{2}}{2}\left(H_{\frac{p-1}{3}}^{2}-H_{\frac{p-1}{3}}^{(2)}\right)\right) \\
\equiv & 1-p^{2} H_{\frac{p-1}{3}}^{(2)} \equiv 1-\frac{p^{2}}{2}\left(\frac{p}{3}\right) B_{p-2}\left(\frac{1}{3}\right)\left(\bmod p^{3}\right)
\end{aligned}
$$

and

$$
1-p H_{\frac{2 p-2}{3}}+p H_{\frac{p-1}{3}} \equiv 1-\frac{p^{2}}{2}\left(\frac{p}{3}\right) B_{p-2}\left(\frac{1}{3}\right)\left(\bmod p^{3}\right) .
$$

Now the proof of Lemma 2.3 is complete.

Proof of Theorem 1.1. With the help of (2.4), we have

$$
\begin{align*}
\sum_{k=0}^{p-1}(3 k+4) \frac{f_{k}}{2^{k}} & =\sum_{k=0}^{p-1} \frac{3 k+4}{2^{k}} \sum_{j=0}^{\lfloor k / 2\rfloor}\binom{k+j}{3 j}\binom{2 j}{j}\binom{3 j}{j} 2^{k-2 j} \\
& =\sum_{j=0}^{(p-1) / 2} \frac{\binom{2 j}{j}\binom{3 j}{j}}{4^{j}} \sum_{k=2 j}^{p-1}(3 k+4)\binom{k+j}{3 j} \tag{2.6}
\end{align*}
$$

By loading the package Sigma in the software Mathematica, we find the following identity:

$$
\sum_{k=2 j}^{n-1}(3 k+4)\binom{k+j}{3 j}=\frac{9 n j+3 n+9 j+5}{3 j+2}\binom{n+j}{3 j+1}
$$

Thus, replacing $n$ by $p$ in the above identity and then substitute it into (2.6), we have

$$
\sum_{k=0}^{p-1}(3 k+4) \frac{f_{k}}{2^{k}}=\sum_{j=0}^{(p-1) / 2} \frac{\binom{2 j}{j}\binom{3 j}{j}}{4^{j}} \frac{9 p j+3 p+9 j+5}{3 j+2}\binom{p+j}{3 j+1}
$$

Hence we immediately obtain the following result by Lemma 2.3,

$$
\begin{equation*}
\sum_{k=0}^{p-1}(3 k+4) \frac{f_{k}}{2^{k}} \equiv p \sum_{j=0}^{(p-1) / 2} \frac{\binom{2 j}{j}}{4^{j}} \frac{9 j+5}{(3 j+1)(3 j+2)}\left(\bmod p^{2}\right) . \tag{2.7}
\end{equation*}
$$

It is easy to verify that

$$
\begin{equation*}
p \sum_{j=0}^{(p-1) / 2} \frac{\binom{2 j}{j}}{4^{j}} \frac{9 j+5}{(3 j+1)(3 j+2)} \equiv S_{1}+S_{2}\left(\bmod p^{2}\right) \tag{2.8}
\end{equation*}
$$

where

$$
\begin{equation*}
S_{1}=p \sum_{j=0}^{(p-1) / 2}\binom{(p-1) / 2}{j}(-1)^{j}\left(\frac{2}{3 j+1}+\frac{1}{3 j+2}\right) \tag{2.9}
\end{equation*}
$$

and

$$
S_{2}=\frac{3 p+2}{p+1}\left(\binom{(2 p-2) / 3}{(p-1) / 3} 4^{(1-p) / 3}-\binom{(p-1) / 2}{(p-1) / 3}\right) .
$$

Applying the famous identity

$$
\begin{equation*}
\sum_{k=0}^{n}\binom{n}{k} \frac{(-1)^{k}}{k+x}=\frac{n!}{x(x+1) \cdots(x+n)} \tag{2.10}
\end{equation*}
$$

with $x=1 / 3, n=(p-1) / 2$ and $x=2 / 3, n=(p-1) / 2$, we may simplify (2.9) as

$$
S_{1}=\frac{4 p}{3 p-1} \frac{(1)_{(p-1) / 2}}{(1 / 3)_{(p-1) / 2}}+\frac{2 p}{3 p+1} \frac{(1)_{(p-1) / 2}}{(2 / 3)_{(p-1) / 2}},
$$

where $(a)_{n}=a(a+1) \cdots(a+n-1)$ is the rising factorial or the Pochhammer symbol.

In view of (2.2), we have

$$
\begin{aligned}
& \frac{4 p}{3 p-1} \frac{(1)_{\frac{p-1}{2}}}{(1 / 3)_{\frac{p-1}{2}}}=\frac{4 p}{3 p-1} \frac{\Gamma\left(\frac{p+1}{2}\right) \Gamma\left(\frac{1}{3}\right)}{\Gamma\left(\frac{1}{3}+\frac{p-1}{2}\right)}=\frac{4 p}{3 p-1} \frac{(-1)^{\frac{p+1}{2}} \Gamma_{p}\left(\frac{p+1}{2}\right) \Gamma_{p}\left(\frac{1}{3}\right)}{(-1)^{\frac{p-1}{2}} \frac{p}{3} \Gamma_{p}\left(\frac{1}{3}+\frac{p-1}{2}\right)} \\
& =\frac{12}{1-3 p} \frac{\Gamma_{p}\left(\frac{p+1}{2}\right) \Gamma_{p}\left(\frac{1}{3}\right)}{\Gamma_{p}\left(\frac{p}{2}-\frac{1}{6}\right)}=\frac{12\left(-1 \frac{p-1}{6}\right.}{1-3 p} \Gamma_{p}\left(\frac{p+1}{2}\right) \Gamma_{p}\left(\frac{1}{3}\right) \Gamma_{p}\left(\frac{7}{6}-\frac{p}{2}\right),
\end{aligned}
$$

where $\Gamma(\cdot)$ is the Gamma function. It is known that for $\alpha, s \in \mathbb{Z}_{p}$, we have

\begin{equation*}
\Gamma_{p}(\alpha+p s) \equiv \Gamma_{p}(\alpha)+p s \Gamma_{p}^{\prime}(\alpha)\left(\bmod p^{2}\right) \tag{2.11}
\end{equation*}
$$

and

$$
\begin{equation*}
\frac{\Gamma_{p}^{\prime}(\alpha)}{\Gamma_{p}(\alpha)} \equiv 1+H_{p-\langle-\alpha\rangle_{p}-1}(\bmod p) \tag{2.12}
\end{equation*}
$$

where $\Gamma_{p}^{\prime}(x)$ denotes the $p$-adic derivative of $\Gamma_{p}(x),\langle\alpha\rangle_{n}$ denotes the least non-negative residue of $\alpha$ modulo $n$, i.e., the integer lying in $\{0,1, \ldots, n-1\}$ such that $\langle\alpha\rangle_{n} \equiv \alpha(\bmod n)$.
Therefore modulo $p^{2}$, we have

\frac{4 p}{3 p-1} \frac{(1)_{\frac{p-1}{2}}}{\left(\frac{1}{3}\right)_{\frac{p-1}{2}}} \equiv \frac{12(-1)^{\frac{p-1}{6}} \Gamma_{p}\left(\frac{1}{2}\right) \Gamma_{p}\left(\frac{1}{3}\right) \Gamma_{p}\left(\frac{7}{6}\right)}{1-3 p}\left(1+\frac{p}{2}\left(H_{\frac{p-1}{2}}-H_{\frac{p-7}{6}}\right)\right) .
$$

In view of (2.1) and (2.2), we have

$$
\frac{4 p}{3 p-1} \frac{(1)_{\frac{p-1}{2}}}{\left(\frac{1}{3}\right)_{\frac{p-1}{2}}} \equiv \frac{2(1+3 p) \Gamma_{p}\left(\frac{1}{2}\right) \Gamma_{p}\left(\frac{1}{3}\right)}{\Gamma_{p}\left(\frac{5}{6}\right)}\left(1+\frac{p}{2}\left(H_{\frac{p-1}{2}}-H_{\frac{p-7}{6}}\right)\right)\left(\bmod p^{2}\right) .
$$

And then by using [20, Proposition 4.1], we have

$$
\frac{\Gamma_{p}\left(\frac{1}{2}\right) \Gamma_{p}\left(\frac{1}{3}\right)}{\Gamma_{p}\left(\frac{5}{6}\right)} \equiv \frac{\binom{(5 p-5) / 6}{(p-1) / 3}}{\left(1+\frac{p}{6}\left(5 H_{(5 p-5) / 6}-3 H_{(p-1) / 2}-2 H_{(p-1) / 3}\right)\right)}\left(\bmod p^{2}\right)
$$

Then with the help of [20, Theorem 4.12] and Lemma [2.2, we have

$$
\begin{equation*}
\frac{4 p}{3 p-1} \frac{(1)_{\frac{p-1}{2}}}{(1 / 3)_{\frac{p-1}{2}}} \equiv 4 x+3 p x q_{p}(3)-\frac{p}{x}\left(\bmod p^{2}\right) \tag{2.13}
\end{equation*}
$$

and

$$
\begin{equation*}
\frac{2 p}{3 p+1} \frac{(1)_{(p-1) / 2}}{(2 / 3)_{(p-1) / 2}} \equiv \frac{p}{x}\left(\bmod p^{2}\right) . \tag{2.14}
\end{equation*}
$$

Hence

$$
\begin{equation*}
S_{1} \equiv 4 x+3 p x q_{p}(3)\left(\bmod p^{2}\right) \tag{2.15}
\end{equation*}
$$

Lemma 2.4. Let $p>3$ be a prime. For any p-adic integer $t$, we have

$$
\begin{equation*}
\binom{\frac{p-1}{2}+p t}{\frac{p-1}{3}} \equiv\binom{\frac{p-1}{2}}{\frac{p-1}{3}}\left(1+p t\left(H_{\frac{p-1}{2}}-H_{\frac{p-1}{6}}\right)\right)\left(\bmod p^{2}\right) . \tag{2.16}
\end{equation*}
$$

Proof. Set $m=(p-1) / 2$. It is easy to check that

$$
\begin{aligned}
\binom{m+p t}{(p-1) / 3} & =\frac{(m+p t) \cdots(m+p t-(p-1) / 3+1)}{((p-1) / 3)!} \\
& \equiv \frac{m \cdots(m-(p-1) / 3+1)}{((p-1) / 3)!}\left(1+p t\left(H_{m}-H_{m-(p-1) / 3}\right)\right. \\
& =\binom{m}{(p-1) / 3}\left(1+p t\left(H_{m}-H_{m-(p-1) / 3}\right)\left(\bmod p^{2}\right)\right.
\end{aligned}
$$

So Lemma 2.4 is finished.
Now we evaluate $S_{2}$ modulo $p^{2}$. It is easy to obtain that

$$
\begin{align*}
S_{2} & \equiv 2\left(\binom{-\frac{1}{2}}{(p-1) / 3}-\binom{(p-1) / 2}{(p-1) / 3}\right) \\
& \equiv-p\binom{(p-1) / 2}{(p-1) / 3}\left(H_{(p-1) / 2}-H_{(p-1) / 6}\right) \\
& \equiv-3 p x q_{p}(3)\left(\bmod p^{2}\right) \tag{2.17}
\end{align*}
$$

with the help of Lemma [2.2, Lemma 2.4 and [20, Theorem 4.12].
Therefore, in view of (2.7), (2.8), (2.15) and (2.17), we immediately get the desired result

$$
\frac{1}{4} \sum_{k=0}^{p-1}(3 k+4) \frac{f_{k}}{2^{k}} \equiv x\left(\bmod p^{2}\right) .
$$

On the other hand, we use the equation (2.5) to obtain that

$$
\begin{aligned}
\sum_{k=0}^{p-1}(3 k+2) \frac{f_{k}}{(-4)^{k}} & =\sum_{k=0}^{p-1} \frac{3 k+2}{(-4)^{k}} \sum_{j=0}^{k}\binom{k+2 j}{3 j}\binom{2 j}{j}\binom{3 j}{j}(-4)^{k-j} \\
& =\sum_{j=0}^{p-1} \frac{\binom{2 j}{j}\binom{3 j}{j}}{(-4)^{j}} \sum_{k=j}^{p-1}(3 k+2)\binom{k+2 j}{3 j} .
\end{aligned}
$$

By using the package Sigma again, we find the following identity:

$$
\sum_{k=j}^{n-1}(3 k+2)\binom{k+2 j}{3 j}=\frac{9 n j+3 n+1}{3 j+2}\binom{n+2 j}{3 j+1} .
$$

Thus,

$$
\begin{equation*}
\sum_{k=0}^{p-1}(3 k+2) \frac{f_{k}}{(-4)^{k}}=\sum_{j=0}^{p-1} \frac{\binom{2 j}{j}\binom{3 j}{j}\binom{p+2 j}{3 j+1}}{(-4)^{j}} \frac{9 p j+3 p+1}{3 j+2} \tag{2.18}
\end{equation*}
$$

Lemma 2.5. Let $p>3$ be a prime and $p \equiv 1(\bmod 3)$. If $0 \leq j \leq$ $(p-1) / 2$ and $j \neq(p-1) / 3$, then

$$

If $(p+1) / 2 \leq j \leq p-1$, then

& =p \sum_{j=0}^{\frac{p-1}{2}}\binom{\frac{p-1}{2}}{j}(-1)^{j}\left(\frac{1}{3 j+1}-\frac{1}{3 j+2}\right)+S_{3}\left(\bmod p^{2}\right), \tag{2.19}
\end{align*}

& \equiv \frac{(-1)^{\frac{p-1}{2} \frac{p}{2}\left(\frac{p-1}{2}\right)!\left(\frac{p-7}{6}\right)!}}{\left(\frac{2 p-2}{3}\right)!}=\frac{(-1)^{\frac{p-1}{2}} 3 p}{p-1} \frac{1}{\left(\frac{2 p-2}{3}\right)} \\
& \equiv \frac{-3 p(-1)^{(p-1) / 2}}{\left(\frac{2 p-2}{2}\right.}\left(\bmod p^{2}\right) .
\end{aligned}

In view of (2.17) and [20, Theorem 4.12], we immediately obtain that

& \equiv p \sum_{j=0}^{(p-1) / 2} \frac{\binom{\frac{p-1}{2}}{j}(-1)^{j}\left(1+\frac{p}{2} H_{k}\right)}{(3 j+1)}-S_{2}\left(\bmod p^{3}\right)
\end{aligned}

H_{\frac{p-1}{2}}-\sum_{k=1}^{\frac{p-1}{2}} \frac{1}{k+r} \equiv-\sum_{k=1}^{r} \frac{1}{k(2 k-1)}(\bmod p) .
$$

And by Sigma, we have

$$
\sum_{r=1}^{n} \frac{(-1)^{r}}{r}\binom{n}{r} \sum_{k=1}^{r} \frac{1}{k(2 k-1)}=H_{n}^{(2)}-\sum_{k=1}^{n} \frac{4^{k}}{k^{2}\binom{2 k}{k}}
$$

So by Lemma 2.2, we have

$$
\sum_{k=1}^{\frac{p-1}{2}} \frac{(-1)^{k}}{k^{2}\binom{-\frac{5}{6}}{k}} \equiv \sum_{k=1}^{\frac{p-1}{6}} \frac{4^{k}}{k^{2}\binom{2 k}{k}}-\frac{5}{2}\left(\frac{p}{3}\right) B_{p-2}\left(\frac{1}{3}\right)(\bmod p)
$$

Hence

$$
\sum_{k=0}^{\frac{p-7}{6}} \frac{(-1)^{k}}{(k+1)\left(\frac{p-1}{2}\right)} \equiv \frac{(-1)^{\frac{p-1}{2}}}{x}-2-\frac{1}{2} \sum_{k=1}^{\frac{p-1}{6}} \frac{4^{k}}{k^{2}\binom{2 k}{k}}(\bmod p) .
$$

This, with (3.11) and (3.12) yields that

$$
\begin{align*}
& 2 \sum_{k=1}^{\frac{p-1}{3}} \frac{4^{k}}{(2 k-1)} \\
\equiv & -2+\frac{1}{x}+2 E_{p-3}-\frac{1}{2}(-1)^{\frac{p-1}{2}} \sum_{k=1}^{\frac{p-1}{6}} \frac{4^{k}}{k^{2}\binom{2 k}{k}}(\bmod p) . \tag{3.13}
\end{align*}
$$

By Sigma, we have

$$
\begin{equation*}
\sum_{k=1}^{n} \frac{4^{k}}{k\binom{2 k}{k}}=-2+2 \frac{4^{n}}{\binom{2 n}{n}} \tag{3.14}
\end{equation*}
$$

So by [20], we have

$$
\sum_{k=1}^{\frac{p-1}{3}} \frac{4^{k}}{k\binom{2 k}{k}} \equiv-2+\frac{2}{\left(\frac{p-1}{\frac{p-1}{3}}\right)} \equiv-2+\frac{1}{x}(\bmod p)
$$

This, with (3.9) and (3.13) yields that

$$
\sum_{k=1}^{\frac{p-1}{3}} \frac{4^{k}}{(2 k-1) k\binom{2 k}{k}} \equiv 2 E_{p-3}-\frac{1}{2}(-1)^{\frac{p-1}{2}} \sum_{k=1}^{\frac{p-1}{6}} \frac{4^{k}}{k^{2}\binom{2 k}{k}}(\bmod p)
$$

This with (3.8) yields that

$$
\begin{equation*}
\sum_{k=1}^{\frac{p-1}{2}} \frac{\left(\frac{1}{3}\right)_{k}}{k\left(\frac{1}{2}\right)_{k}} \equiv \frac{3}{2} q_{p}(3)-\frac{3 p}{4} q_{p}^{2}(3)+\frac{p}{3} \sum_{k=1}^{\frac{p-1}{6}} \frac{4^{k}}{k^{2}\binom{2 k}{k}}\left(\bmod p^{2}\right) \tag{3.15}
\end{equation*}
$$

So by (3.7), we have

$$
\sum_{k=1}^{\frac{p-1}{2}} \frac{\left(\frac{1}{3}\right)_{k}}{k(1)_{k}}-\sum_{k=1}^{\frac{p-1}{2}} \frac{\left(\frac{1}{3}\right)_{k}}{k\left(\frac{1}{2}\right)_{k}} \equiv-\frac{p}{3}\left(\sum_{k=1}^{\frac{p-1}{3}} \frac{4^{k}}{k^{2}\binom{2 k}{k}}+\sum_{k=1}^{\frac{p-1}{6}} \frac{4^{k}}{k^{2}\binom{2 k}{k}}\right)\left(\bmod p^{2}\right)
$$

Therefore, by (3.6) and (3.4), we have

$$
\begin{align*}
& 2 p^{2} \sum_{j=0}^{\frac{p-1}{2}} \frac{\binom{\frac{p-1}{2}}{j}(-1)^{j}\left(H_{2 j}-H_{j}\right)}{3 j+1} \\
& \equiv-\frac{p^{2}}{3}\binom{\frac{p-1}{2}}{\frac{p-1}{3}}\left(\sum_{k=1}^{\frac{p-1}{3}} \frac{4^{k}}{k^{2}\binom{2 k}{k}}+\sum_{k=1}^{\frac{p-1}{6}} \frac{4^{k}}{k^{2}\binom{2 k}{k}}\right)\left(\bmod p^{3}\right) \tag{3.16}
\end{align*}
$$

Now we evaluate the second sum in the right side of (3.5). It is easy to see that

$$
\begin{equation*}
\sum_{j=1}^{\frac{p-1}{2}} \frac{4^{j}}{(3 j-1) j\binom{2 j}{j}}=3 \sum_{j=1}^{\frac{p-1}{2}} \frac{4^{j}}{(3 j-1)\binom{2 j}{j}}-\sum_{j=1}^{\frac{p-1}{2}} \frac{4^{j}}{j\binom{2 j}{j}} . \tag{3.17}
\end{equation*}
$$

It is easy to see from (3.14) that

$$
\begin{equation*}
\sum_{j=1}^{\frac{p-1}{2}} \frac{4^{j}}{j\binom{2 j}{j}} \equiv-2+2(-1)^{\frac{p-1}{2}}(\bmod p) \tag{3.18}
\end{equation*}
$$

Now we consider the first sum of the right side in (3.17).

$$
\sum_{j=1}^{\frac{p-1}{2}} \frac{4^{j}}{(3 j-1)\binom{2 j}{j}}=\sum_{j=1}^{\frac{p-1}{3}} \frac{4^{j}}{(3 j-1)\binom{2 j}{j}}+\sum_{j=\frac{p+2}{3}}^{\frac{p-1}{2}} \frac{4^{j}}{(3 j-1)\binom{2 j}{j}}
$$

The following identity is very import to us:

$$
\begin{equation*}
\sum_{k=1}^{n} \frac{4^{k}}{(k+n)\binom{2 k}{k}}=-2+2 \frac{4^{n}}{\binom{2 n}{n}}-\frac{n\binom{2 n}{n}}{4^{n}} \sum_{k=1}^{n} \frac{4^{k}}{k^{2}\binom{2 k}{k}} \tag{3.19}
\end{equation*}
$$

This, with [20] yields that

$$
\begin{align*}
& 3 \sum_{j=1}^{\frac{p-1}{3}} \frac{4^{j}}{(3 j-1)\binom{2 j}{j}} \equiv \sum_{j=1}^{\frac{p-1}{3}} \frac{4^{j}}{\left(j+\frac{p-1}{3}\right)\binom{2 j}{j}} \\
& \equiv-2+\frac{2}{\binom{-1 / 2}{\frac{p-1}{3}}}+\frac{1}{3}\binom{-1 / 2}{\frac{p-1}{3}} \sum_{k=1}^{\frac{p-1}{3}} \frac{4^{k}}{k^{2}\binom{2 k}{k}} \\
& \equiv-2+\frac{1}{x}+\frac{1}{3}\binom{\frac{p-1}{2}}{\frac{p-1}{3}} \sum_{k=1}^{\frac{p-1}{3}} \frac{4^{k}}{k^{2}\binom{2 k}{k}}(\bmod p) . \tag{3.20}
\end{align*}
$$

It is easy to check that And by (3.19), we have

$$
\begin{align*}
& 3 \sum_{j=\frac{p+2}{3}}^{\frac{p-1}{2}} \frac{4^{j}}{(3 j-1)\binom{2 j}{j}} \equiv 3 \sum_{j=0}^{\frac{p-7}{6}} \frac{(-1)^{\frac{p-1}{2}-j}}{\left(3\left(\frac{p-1}{2}-j\right)-1\right)\binom{\frac{p-1}{2}}{j}} \\
& \equiv 6(-1)^{\frac{p+1}{2}} \sum_{j=0}^{\frac{p-7}{6}} \frac{4^{j}}{(6 j+5)\binom{2 j}{j}} \equiv(-1)^{\frac{p+1}{2}} \sum_{j=0}^{\frac{p-7}{6}} \frac{(-1)^{j}}{\left(j+\frac{p+5}{6}\right)\binom{\frac{p-1}{2}}{j}} \\
& \equiv \frac{6}{5}(-1)^{\frac{p+1}{2}}+(-1)^{\frac{p+1}{2}} \sum_{j=1}^{\frac{p+5}{6}} \frac{4^{j}}{\left(j+\frac{p+5}{6}\right)\binom{2 j}{j}}+\frac{3}{\binom{\frac{p-1}{2}}{\frac{p-1}{3}}}(\bmod p) . \tag{3.21}
\end{align*}
$$

By (3.19) and [20], we have

$$
\sum_{j=1}^{\frac{p+5}{6}} \frac{4^{j}}{\left(j+\frac{p+5}{6}\right)\binom{2 j}{j}} \equiv-\frac{16}{5}+\frac{5(-1)^{\frac{p-1}{6}}}{2 x}-\frac{(-1)^{\frac{p-1}{6}}}{6 x} \sum_{k=1}^{\frac{p-1}{6}} \frac{4^{k}}{k^{2}\binom{2 k}{k}}(\bmod p)
$$

This, with (3.21) yields that

$$
3 \sum_{j=\frac{p+2}{3}}^{\frac{p-1}{2}} \frac{4^{j}}{(3 j-1)\binom{2 j}{j}} \equiv 2(-1)^{\frac{p-1}{2}}-\frac{1}{x}+\frac{1}{3}\binom{\frac{p-1}{2}}{\frac{p-1}{3}} \sum_{k=1}^{\frac{p-1}{6}} \frac{4^{k}}{k^{2}\binom{2 k}{k}}(\bmod p)
$$

Combining this with (3.20), we have

$$
\begin{aligned}
& 3 \sum_{j=1}^{\frac{p-1}{2}} \frac{4^{j}}{(3 j-1)\binom{2 j}{j}} \\
& \equiv-2+2(-1)^{\frac{p-1}{2}}+\frac{1}{3}\binom{\frac{p-1}{2}}{\frac{p-1}{3}}\left(\sum_{k=1}^{\frac{p-1}{3}} \frac{4^{k}}{k^{2}\binom{2 k}{k}}+\sum_{k=1}^{\frac{p-1}{6}} \frac{4^{k}}{k^{2}\binom{2 k}{k}}\right)(\bmod p) .
\end{aligned}
$$

Thus, by (3.17) and (3.18), we have

$$
\sum_{j=1}^{\frac{p-1}{2}} \frac{4^{j}}{(3 j-1) j\binom{2 j}{j}} \equiv \frac{1}{3}\binom{\frac{p-1}{2}}{\frac{p-1}{3}}\left(\sum_{k=1}^{\frac{p-1}{3}} \frac{4^{k}}{k^{2}\binom{2 k}{k}}+\sum_{k=1}^{\frac{p-1}{6}} \frac{4^{k}}{k^{2}\binom{2 k}{k}}\right)(\bmod p)
$$

This, with (3.5) and (3.16) yields that

$$
\begin{equation*}
\sum_{k=0}^{p-1} \frac{f_{k}}{(-4)^{k}}-\sum_{k=0}^{p-1} \frac{f_{k}}{2^{k}} \equiv S_{5}\left(\bmod p^{3}\right) \tag{3.22}
\end{equation*}
$$

While

$$
\begin{aligned}
S_{5}= & \binom{-\frac{1}{2}}{\frac{p-1}{3}}\binom{p-1}{\frac{p-1}{3}}\left(\binom{p+\frac{2 p-2}{3}}{\frac{p-1}{3}}-\binom{p+\frac{p-1}{3}}{\frac{p-1}{3}}\right) \\
& +2 p\binom{\frac{p-1}{2}}{\frac{p-1}{3}}\left(H_{\frac{p-1}{3}}-H_{\frac{2 p-2}{3}}\right) .
\end{aligned}
$$

It is easy to check that

$$
\binom{p+\frac{2 p-2}{3}}{\frac{p-1}{3}} \equiv 1+p H_{\frac{2 p-2}{3}}+\frac{p^{2}}{2}\left(H_{\frac{2 p-2}{3}}^{2}-H_{\frac{2 p-2}{3}}^{(2)}\right)\left(\bmod p^{3}\right)
$$

and

$$
\binom{p+\frac{p-1}{3}}{\frac{p-1}{3}} \equiv 1+p H_{\frac{p-1}{3}}+\frac{p^{2}}{2}\left(H_{\frac{p-1}{3}}^{2}-H_{\frac{p-1}{3}}^{(2)}\right)\left(\bmod p^{3}\right) .
$$

So by Lemma 2.2 and the fact that $H_{p-1-k}^{(2)} \equiv-H_{k}^{(2)}(\bmod p)$ for each $0 \leq k \leq p-1$, we have

$$
\begin{aligned}
\binom{p+\frac{2 p-2}{3}}{\frac{p-1}{3}}-\binom{p+\frac{p-1}{3}}{\frac{p-1}{3}} & \equiv p\left(H_{\frac{2 p-2}{3}}-H_{\frac{p-1}{3}}\right)+\frac{p^{2}}{2}\left(H_{\frac{p-1}{3}}^{(2)}-H_{\frac{2 p-2}{3}}^{(2)}\right) \\
& \equiv p^{2}\left(\frac{p}{3}\right) B_{p-2}\left(\frac{1}{3}\right)\left(\bmod p^{3}\right)
\end{aligned}
$$

and

$$
2 p\left(H_{\frac{p-1}{3}}-H_{\frac{2 p-2}{3}}\right) \equiv-p^{2}\left(\frac{p}{3}\right) B_{p-2}\left(\frac{1}{3}\right)\left(\bmod p^{3}\right) .
$$

So by $\binom{-\frac{1}{2}}{\frac{p-1}{3}} \equiv\binom{\frac{p-1}{2}}{\frac{p-1}{3}}(\bmod p)$ and $\binom{p-1}{\frac{p-1}{3}} \equiv(-1)^{\frac{p-1}{3}}=1(\bmod p)$, we can immediately obtain that

$$
S_{5} \equiv 0\left(\bmod p^{3}\right)
$$

This, with (3.22) yields that

$$
\sum_{k=0}^{p-1} \frac{f_{k}}{(-4)^{k}} \equiv \sum_{k=0}^{p-1} \frac{f_{k}}{2^{k}}\left(\bmod p^{3}\right)
$$

Now the proof of Theorem 1.2 is complete.
