L²-Density of Wild Initial Data for the Hypodissipative Navier-Stokes Equations

Abstract

In this paper we deal with the Cauchy problem for the hypodissipative Navier-Stokes equations in the three-dimensional periodic setting. For all Laplacian exponents $\theta < 1/3$, we prove non-uniqueness of dissipative $L_t^2 H_x^{\theta}$ weak solutions for an L^2 -dense set of C^{θ} Hölder continuous wild initial data with $\theta < \beta < \frac{1}{3}$. This improves previous results of non-uniqueness for infinitely many wild initial data ([8, 20]) and generalizes previous results on density of wild initial data obtained for the Euler equations ([14, 13]).

Keywords: Convex integration, hypodissipative Navier-Stokes equations, wild initial data

1 Introduction

The existence of dissipative solutions for the Euler equations

$$\begin{cases} \partial_t v + \operatorname{div}(v \otimes v) + \nabla p = 0\\ \operatorname{div} v = 0 \end{cases}$$
(1.1)

with regularity lower than $C_t^0 C_x^{\frac{1}{3}}$ has been investigated deeply. After the pioneering works of Scheffer [33] (on the plane \mathbb{R}^2) and Shnirelman [34] (on the periodic torus \mathbb{T}^2), De Lellis and Székelyhidi, in [15], introduced the convex integration technique (first used by Nash in [28] and Kuiper in [26] in the context of isometric embeddings, and formalized in a more general setting by Gromov in [23]) in this setting, proving the existence of nontrivial compactly supported $L_t^{\infty} L_x^2$ weak solutions of (1.1) in \mathbb{R}^n for any *n*. The subsequent paper [16] provided a proof of the non-uniqueness of weak solutions satisfying the weak energy inequality

$$\int_{\mathbb{T}^3} |v(x,t)|^2 \mathrm{d}x \le \int_{\mathbb{T}^3} |v(x,0)|^2 \mathrm{d}x,$$
(1.2)

i.e. dissipating the total kinetic energy. We call such solutions *dissipative* or *admissible*.

Both of these papers use a Baire category argument, proving that such solutions constitute the set of continuity points of a Baire-1 map. This implies that such solutions not only exist, but are "typical" in the sense of category. These results were the first steps in the resolution of the second part of Onsager's conjecture from [29].

Onsager's Conjecture. Let (v.p) be a weak solution of (1.1) and define the total kinetic energy as

$$E(t) \coloneqq \frac{1}{2} \int_{\mathbb{T}^3} |v(x,t)|^2 \mathrm{d}x$$

If $v \in C^{\beta}$ for $\beta > \frac{1}{3}$, then the energy is a conserved quantity, i.e. $E(t) \equiv E(0)$. By contrast, for any $\beta < \frac{1}{3}$, there exist C^{β} weak solutions of (1.1) which do not conserve the energy.

The first part was proved in [10], and refined for more general spaces in [6, 22].

In [17], De Lellis and Székelyhidi introduced a more constructive approach which allowed to obtain infinitely many dissipative continuous solutions (see also [18]), and then infinitely many $C^{\frac{1}{10}-\varepsilon}$ -Hölder solutions in [19]. In [3], Isett was able to improve the Hölder exponent for the existence of non-conservative solutions to $\frac{1}{5} - \varepsilon$ and, after the introduction of Mikado flows by Daneri and Székelyhidi in [14], he completed the proof of Onsager's conjecture above in [25] by showing existence of infinitely many Hölder continuous dissipative solutions in the class $C_t^0 C_x^\beta$, for all $\beta < \frac{1}{3}$. This result was later improved to dissipative solutions in the same class in [4].

In the class of admissible solutions, weak-strong uniqueness holds, as proved in [36]: C^1 solutions are unique, and moreover, if such a solution exists, any $L_t^{\infty} L_x^2$ solution with the same initial data which is admissible coincides with the C^1 solution.

However, cleverly adapting and improving the convex integration technique of the above-mentioned papers, the existence of infinitely many initial data giving rise to admissible solutions in the class C^{β} for $\beta < 1/16}$ was proved in [12]. In [14] and [13], the following topologically stronger statement was proved: the set of C^{β} initial data giving rise to admissible solutions is dense in $L^2(\mathbb{T}^3)$. It was proved in [14] for $\beta < 1/5$, and in [13] for $\beta < 1/3$. Removing the admissibility condition (1.2) leads to non-uniqueness for any C^{∞} initial datum, as proved in [21]. For the Navier-Stokes equations

$$\begin{cases} \partial_t v + \operatorname{div}(v \otimes v) + \nabla p = \Delta v\\ \operatorname{div} v = 0 \end{cases}, \tag{1.3}$$

in [27], Leray proved the existence of global weak solutions satisfying the following energy inequality:

$$\int_{\mathbb{T}^3} |v(x,t)|^2 dx + 2 \cdot \int_0^t \int_{\mathbb{T}^3} |\nabla v(x,s)|^2 dx ds \le \int_{\mathbb{T}^3} |v(x,0)|^2 dx \qquad \text{a.e. } t > 0.$$
(1.4)

Such solutions are called *Leray solutions* or *Leray-Hopf solutions*, and we will call them *admissible solutions of* (1.3). The strategy employed in [27] can easily be adapted to prove the existence of solutions to (1.1) satisfying (1.2), which are therefore called by the same names.

Thanks to the Ladyzhenskaya-Prodi-Serrin regularity theory, weak-strong uniqueness for (1.3) holds for $L_t^r L_x^s$ solutions, where $\frac{d}{s} + \frac{2}{r} = 1$, as proved in [30] for d = 3 and in [31] for the general case. The uniqueness of non-uniqueness of solutions to (1.3) satisfying (1.4) is still a long-standing open problem.

The uniqueness of non-uniqueness of solutions to (1.3) satisfying (1.4) is still a long-standing open problem. The latest step in this regard is [1] where, introducing a body force in the equation, the authors exhibit two distinct admissible solutions on \mathbb{R}^3 .

Several non-uniqueness results have been obtained for non-admissible solutions, i.e. in the absence of the energy inequality (1.4). In [5], the authors prove the existence, for any smooth energy profile e, of $C_t^0 H_x^\beta$ solutions with kinetic energy e, i.e.

$$\int_{\mathbb{T}^3} |v(x,t)|^2 \mathrm{d}x = e(t),$$

for some parameter β . This implies non-uniqueness for the zero initial datum. Choosing a non-increasing *e*, this also implies the existence of solutions of (1.3) satisfying (1.2).

It is known that such β cannot be too large, since $\beta = 1/2$ implies weak-strong uniqueness by [11]. In arbitrary dimensions, $\beta = 1/2$ is in fact a threshold for weak-strong uniqueness. Indeed, in Terence Tao's blog post [35], the non-uniqueness of $H_t^1 H_x^s$ for any s < 1/2 has been proven to hold on \mathbb{T}^d where d = d(s) is sufficiently large. In the subsequent work [2], a "gluing" theorem is proved: given any two strong solutions $u_1, u_2 \in C_t^0 \dot{H}_x^3([0,T], \mathbb{T}^3)$, there exists a weak solution $v \in C_t^0(H_x^\beta \cap W_x^{1,1+\beta})$, with a set of singular times Σ having dimension dim $_H \Sigma \leq 1 - \beta$, which coincides with u_1 on [0, T/3] and with u_2 on [2/3T, T]. The parameter β is not quantified in [2], but the strategy therein allows it to reach at most a value slightly above 10^{-3} .

Reducing the regularity in time can lead to better spatial regularity. Indeed, in [7], the authors prove an approximation result: given a smooth divergence-free field v, we can approximate it in $L_t^p L_x^{\infty} \cap L_t^1 W_x^{1,\infty}$ with a solution of (1.3), for any p < 2. The singular set of these solutions is also of low dimension. The strategy of [7] can be extended to $L_t^p L_x^{\infty} \cap L_t^s W_x^{1,q}$, where once again p < 2, and we have that s < 2 and $q < q_{max}(s, p)$, where $q_{max}(s, p) \to 1$ if $s \to 2$ or $p \to 2$.

In this paper we are interested in studying how introducing a fractional dissipative term in (1.1) may affect the uniqueness or ill-posedness of the Cauchy problem. More specifically, we consider the hypodissipative Navier-Stokes equations

$$\begin{cases} \partial_t v + \operatorname{div}(v \otimes v) + \nabla p + (-\Delta)^{\theta} v = 0\\ \operatorname{div} v = 0 \end{cases},$$
(1.5)

with exponent $\theta < \frac{1}{3}$ and admissibility condition

$$\frac{1}{2} \int_{\mathbb{T}^3} |v(x,t)|^2 dx + \int_0^t \int_{\mathbb{T}^3} \left| (-\Delta)^{\frac{\theta}{2}} v(x,s) \right|^2 dx ds \le \frac{1}{2} \int_{\mathbb{T}^3} |v(x,0)|^2 dx.$$
(1.6)

The previously cited proof of [27] can be adapted to show existence for admissible solutions in this case as well. This result is stated in **Theorem 6.1**. In this case as well, admissible solutions are also known as Leray solutions.

In [8] and [20] it was proved that there exist infinitely many C^{β} initial data for $\theta < \beta < 1/3$ which generate infinitely many $C_t^{0}C_x^{\beta}$ solutions which, by [9], are in fact $C_{t,x}^{\beta}$. In fact, [8] produces such data for θ up to 1/2, with solutions that can only be proved to be admissible (i.e. satisfy (1.6)) for $\theta < 1/5$.

Inspired by the results in [14] and [13], which prove the L^2 -density of such initial data for the Euler equations (1.1), respectively for $\beta < 1/5$ and for $\beta < 1/3$, we investigate the existence of an L^2 -dense class of C^{β} wild initial data (namely data for which non-uniqueness holds) for admissible solutions to (1.5) in $L_t^2 H_x^{\theta}$. The strategy proposed in [14] and [13] provides a quantitative criterion for non-uniqueness based on the existence of approximate solutions called *adapted subsolutions*.

Here, we explore and extend that strategy to the hypodissipative Navier-Stokes equations. The main issue with respect to the Euler setting is to control the dissipative term in the energy. Our main results are the following.

Theorem 1.1 (C^{β} weak solutions with data close to L^2 functions and time of admissibility). Let $\theta < \beta < \frac{1}{3}$, $w \in L^2(\mathbb{T}^3)$. Then, for all $\eta > 0$, there exist a time $T = T(\eta) > 0$, an initial datum $w_{\eta} \in C^{\beta}(\mathbb{T}^3)$ such that $||w_{\eta} - w||_{L^2} < \eta$, and infinitely many weak solutions $v_{\eta} \in C^0([0,T], C^{\beta}(\mathbb{T}^3))$, with initial datum $v_{\eta}|_{t=0} = w_{\eta}$, which satisfy (1.2) on [0,T], but can be proved to satisfy (1.6) (i.e to be admissible) only on $[0,T(\eta)]$. Moreover

$$\lim_{\eta\to 0} T(\eta) = 0.$$

The fact that the admissibility condition in **Theorem 1.1** cannot be guaranteed to hold for C^{β} solutions on a fixed set of times is due to the necessity of controlling the dissipation term in the energy.

Definition 1.1 (Wild initial data). Let X be a function space. A divergence-free vector field $w \in L^2(\mathbb{T}^3)$ is a (θ, X, T) -wild initial datum for (1.5) if there exist infinitely many weak solutions $v : [0, T] \times \mathbb{T}^3 \to \mathbb{R}^3$ of (1.5) such that $v \in X$, v(x, 0) = w(x) a.e. in \mathbb{T}^3 , and the admissibility condition (1.6) holds on [0, T]. The set of such data is denoted by $W_{\theta,X,T}$. If $X = L_t^{\infty} C_x^{\beta}$, we will speak of (θ, β, T) -wild data, and of the set $W_{\theta,\beta,T}$.

As a consequence of **Theorem 1.1**, we obtain the following corollary.

Corollary 1.1 (Density of wild initial data – Hölder solutions). The set $\bigcup_T W_{\theta,\beta,T}$ is dense in the set of divergence-free L^2 vector fields, for all $\theta < \beta < \frac{1}{2}$.

Moreover, by taking a solution v_{η} as given by **Theorem 1.1**, and continuing it with a Leray solution \tilde{v}_{η} : $[T(\eta), \infty] \times \mathbb{T}^3 \to \mathbb{R}^3$ with datum $\tilde{v}_{\eta}(T(\eta)) = v_{\eta}(T(\eta))$, as provided by **Theorem 6.1**, we obtain the following.

Theorem 1.2 (Density of wild initial data – Sobolev solutions). $W_{\theta,L_t^2H_x^\theta,T}$ is dense in the sef of divergence-free L^2 vector fields, for all $\theta < \frac{1}{3}, T > 0$.

The general strategy of the paper is to define suitable relaxations of the notion of solution (the so-called "subsolutions" of Section 3), and approximating one kind of subsolution with another one which is closer to the notion of solution. This is done constructing sequences of subsolutions that converge, in an appropriate

sense, to a "stronger" subsolution. We will need two such approximations, and therefore two convex integration schemes: the first one will converge to a subsolution which is a solution at t = 0, and has the C^1 norm of the velocity blowing up at a controlled rate at t = 0. The second approximation will lead to a weak solution. The paper is organized as follows. Section 2 establishes some notations and contains a few useful preliminary results. Section 3 introduces three kinds of subsolutions, namely strict, strong, and adapted. Section 4 contains some important definitions and relations used in the following sections. Section 5 states the approximation results that lie at the heart of the proof. Section 6 deduces **Theorem 1.1** from those approximation results. Section 7 shows how one can approximate strict subsolutions with strong ones. Sections 8 and 9 contain the two substeps of each convex integration step, respectively a gluing step and a perturbation step. Sections 10 and 11 then prove the other approximation results, namely the approximation of strong subsolutions with adapted ones, and that of adapted subsolutions with weak solutions.

2 Preliminaries

Throughout the paper, we will use the following notations:

- $S^{3\times3}$ are the symmetric 3-by-3 matrices; within this set, $S^{3\times3}_+$ are the positive definite ones, $S^{3\times3}_0$ are the traceless ones, and $S^{3\times3}_{\geq 0}$ are the positive semidefinite ones.
- If $R \in S^{3 \times 3}$, we decompose it as

$$R = \frac{1}{3} \operatorname{tr} R \operatorname{Id} + \mathring{R} = \rho \operatorname{Id} + \mathring{R},$$

where $\mathring{R} \in \mathscr{S}_0^{3 \times 3}$ is the *traceless part of R*.

- For scalar functions f, we write $\nabla f \coloneqq (\partial_1 f, \partial_2 f, \partial_3 f) \eqqcolon \mathfrak{D} f$;
- However, for vector fields v, we define $\mathfrak{D}v$ so that $(\mathfrak{D}v)_{ij} = \partial_j v_i$, whereas $\nabla v = (\mathfrak{D}v)^T$; with these choices, $(v \cdot \nabla)v = \mathfrak{D}v \cdot v = v \cdot \nabla v$;
- In a similar fashion, for tensor fields *S*, $\mathfrak{D}S$ is defined by $(\mathfrak{D}S)_{ijk} = \partial_k S_{ij}$, whereas ∇S is defined by $(\nabla S)_{ijk} = \partial_i S_{jk}$;
- The Hölder norms are defined as follows

$$\begin{split} \|f\|_{0} \coloneqq \sup |f(x)|, \qquad [f]_{k} \coloneqq \max_{\substack{\beta \in \mathbb{N}^{3} \\ |\beta| = k}} \sup \left|\partial_{\beta}f\right|, \qquad [f]_{\alpha} \coloneqq \sup_{x,y} \frac{|f(x) - f(y)|}{|x - y|^{\alpha}} \\ \|f\|_{k} \coloneqq \|f\|_{0} + \sum_{i=1}^{k} [f]_{i}, \qquad \|f\|_{k+\alpha} \coloneqq \|f\|_{k} + \max_{\substack{|\beta| = k \\ \beta \in \mathbb{N}^{3}}} [\partial_{\beta}f]_{\alpha}, \end{split}$$

for $k \in \mathbb{N}$, $\alpha \in (0, 1)$.

Concerning the Hölder norms, we recall the following standard inequalities.

Lemma 2.1 (Hölder norm inequalities). For $0 \le s \le r$ and $f, g: \mathbb{T}^3 \to \mathbb{R}^d$

$$[fg]_r \le C(r)([f]_r ||g||_0 + ||f||_0 [g]_r)$$
(2.1)

$$[f]_{s} \le C(r,s) \|f\|_{0}^{1-\frac{s}{r}} [f]_{r}^{\frac{1}{s}}.$$

Moreover, for $f : \mathbb{T}^3 \to S \subseteq \mathbb{R}^d$ *and* $\Psi : S \to \mathbb{R}$ *:*

$$[\Psi \circ f]_m \le K(d,m)([\Psi]_1 \|\mathfrak{D}f\|_{m-1} + \|\nabla\Psi\|_{m-1} \|f\|_0^{m-1} \|f\|_m)$$
(2.3)

$$[\Psi \circ f]_m \le K(d,m)([\Psi]_1 \|\mathfrak{D}f\|_{m-1} + \|\nabla\Psi\|_{m-1}[f]_1^m).$$

Finally, for all $s, r \ge 0$ *:*

$$\begin{aligned} \|f * \varphi_{\ell}\|_{r+s} &\leq C(r,s)\ell^{-s} \|f\|_{r} \\ \|f - f * \varphi_{\ell}\|_{r} &\leq C(r,s)\ell^{1} \|f\|_{r+1} \\ \|f - f * \varphi_{\ell}\|_{r} &\leq C(r,s)\ell^{2} \|f\|_{r+2} \\ \|(fg) * \varphi_{\ell} - (f * \varphi_{\ell})(g * \varphi_{\ell})\|_{r} &\leq C(r,s)\ell^{2-r} \|f\|_{1} \|g\|_{1}, \end{aligned}$$

$$(2.5)$$

where φ is a standard mollification kernel, i.e. $\varphi \in C_c^{\infty}(B_1; [0, 1])$ and $\int \varphi = 1$, and $\varphi_{\ell} \coloneqq \frac{1}{\ell^3} \varphi(\frac{\cdot}{\ell})$.

For functions $f,g: \mathbb{T}^3 \times [0,T] \to \mathbb{R}^d$, we denote their time-slices by $f_t(x) \coloneqq f(x), g_t(x) \coloneqq g(x)$. The above lemma can then be applied to the time slices of time-dependent vector fields, e.g. the velocities of subsolutions, with the notation $||f(t,\cdot)||_{C^r}, [f(t,\cdot)]_{C^r}$ for the (semi)norms of the slices. By taking supremum norms in time, the above inequalities can be formulated with $C_t^0 C_x^r$ norms.

We now introduce Mikado flows, the basic building blocks of the perturbations, and the important Stationary Phase Lemma. The proofs of the following results can be found in [14].

Lemma 2.2 (Mikado flows). For any compact subset $\mathcal{N} \subset \mathcal{S}^{3\times 3}_+$ there exists a smooth vector field $W : \mathcal{N} \times \mathbb{T}^3 \to \mathbb{R}^3$ such that, for every $R \in \mathcal{N}$

$$\begin{cases} \operatorname{div}_{\xi}(W(R,\xi) \otimes W(R,\xi)) = 0\\ \operatorname{div}_{\xi}W(R,\xi) = 0 \end{cases},$$
(2.6)

and

$$\begin{cases} \int_{\mathbb{T}^3} W(R,\xi) d\xi = 0\\ \int_{\mathbb{T}^3} W(R,\xi) \otimes W(R,\xi) d\xi = R \end{cases}$$

Using Fourier series in ξ and the above integral and differential relations, we obtain that

$$W(R,\xi) = \sum_{k \in \mathbb{Z}^3 \setminus \{0\}} a_k(R) A_k e^{ik \cdot \xi}$$

$$W(R,\xi) \otimes W(R,\xi) = R + \sum_{k \in \mathbb{Z}^3 \setminus \{0\}} C_k(R) e^{ik \cdot \xi},$$

where the coefficients $a_k, C_k \in \mathbb{C}^{\infty}$, the A_k satisfy $A_k \cdot k = 0$, $|A_k| = 1$, the C_k satisfy $C_k k = 0$, and moreover

$$\sup_{R\in\mathcal{N}} \left|\mathfrak{D}_R^N a_k(R)\right| = \|a_k\|_{C^N(\mathcal{N})} \le \frac{C(\mathcal{N}, N, m)}{|k|^m}$$

$$\sup_{R\in\mathcal{H}} \left|\mathfrak{D}_R^N C_k(R)\right| = \|C_k\|_{\mathcal{C}^N(\mathcal{H})} \le \frac{C(\mathcal{H}, N, m)}{|k|^m}.$$

In Section 7, we will need the fact that, if we set

$$U(R,\xi) \coloneqq \sum_{k} a_k(R) \frac{ik \times A_k}{|k|^2} e^{ik \cdot \xi},$$
(2.12)

then we have that $\operatorname{curl}_{\xi} U = W$. Indeed

$$\begin{aligned} \operatorname{curl}_{\xi} U(R,\xi) &= \sum_{k\ell mn} \varepsilon_{\ell mn} \partial_m \left(a_k(R) \frac{ik \times A_k}{|k|^2} e^{ik \cdot \xi} \right)_n e_\ell = \sum_{k\ell mnpq} \varepsilon_{\ell mn} \varepsilon_{npq} a_k(R) ik_p(A_k)_q |k|^{-2} \cdot ik_m e^{ik \cdot \xi} e_\ell = \\ &= -\sum_{k\ell mpq} (\delta_{\ell p} \delta_{mq} - \delta_{\ell q} \delta_{mp}) a_k(R) k_p |k|^{-2} (A_k)_q k_m e^{ik \cdot \xi} e_\ell = \\ &= \sum_k a_k(R) A_k e^{ik \cdot \xi} - \sum_{kpq} a_k(R) k_p k_q |k|^{-2} (A_k)_q e^{ik \cdot \xi} e_p = \\ &= W(R,\xi) - \sum_k a_k(R) \underbrace{(k \cdot A_k)}_0 \frac{k}{|k|^2} e^{ik \cdot \xi}. \end{aligned}$$

We now introduce a certain "anti-divergence operator" which will be used to obtain the new Reynolds stress R in the various approximation results.

Definition 2.1 (Anti-divergence \mathcal{R}). Define the operator \diamond so that

$$\begin{cases} \Delta \diamond v = v - \oint_{\mathbb{T}^3} v \mathrm{d}x \\ \int_{\mathbb{T}^3} \diamond v = 0 \end{cases},$$

and then define

$$\mathscr{R}v \coloneqq \frac{1}{4}(\mathfrak{D}\mathscr{P} \diamond v + (\mathfrak{D}\mathscr{P} \diamond v)^T) + \frac{3}{4}(\mathfrak{D} \diamond v + (\mathfrak{D} \diamond v)^T) - \frac{1}{2}(\operatorname{div} \diamond v)\operatorname{Id},$$
(2.13)

 $\mathcal P$ being the Leray projection onto divergence-free fields with zero average.

This operator satisfies the following properties.

Lemma 2.3 (Divergence and \mathcal{R}). For any \mathcal{C}^{∞} vector field v, $\mathcal{R}v \in \mathcal{S}_0^{3 \times 3}$ is symmetric and trace-free, and moreover

$$\operatorname{div} \mathcal{R} v = v - \int_{\mathbb{T}^3} v \mathrm{d}x,.$$
(2.14)

Moreover, we have the following statement, which we will use numerous times throughout the paper.

Lemma 2.4 (Stationary Phase Lemma). Let $\alpha \in (0,1), N \ge 1$. Let $a \in C^{\infty}(\mathbb{T}^3), \Phi \in C^{\infty}(\mathbb{R}^3, \mathbb{R}^3)$ be smooth functions and assume

$$\frac{1}{K} \le |\mathfrak{D}\Phi| \le K \qquad on \ \mathbb{T}^3$$

and for the operator \mathcal{R} of (2.13) above we have that

$$\left\| \mathcal{R}(a(x)e^{ik\cdot\Phi}) \right\|_{\alpha} \le C(\alpha, K, N) \left(\frac{\|a\|_{0}}{|k|^{1-\alpha}} + \frac{\|a\|_{N+\alpha} + \|a\|_{0} \|\Phi\|_{N+\alpha}}{|k|^{N-\alpha}} \right).$$
(2.16)

We now recall some classical estimates regarding fractional laplacians.

Theorem 2.1 (Fractional laplacian and Hölder norms). Let $\gamma, \varepsilon > 0$ and $\beta \ge 0$ such that $2\gamma + \beta + \varepsilon \le 1$, and let $f : \mathbb{T}^3 \to \mathbb{R}^3$. If $f \in C^{0,2\gamma+\beta+\varepsilon}$, then $(-\Delta)^{\gamma} f \in C^{\beta}$, moreover there exists a constant $C = C(\varepsilon)$ such that

$$\|(-\Delta)^{\gamma}f\|_{\beta} \le C(\varepsilon)[f]_{2\gamma+\beta+\varepsilon}.$$
(2.17)

Moreover, for every $\gamma \in (0,1)$, $\varepsilon > 0$ such that $0 < \gamma + \varepsilon \le 1$, and f as above, then there exists $C = C(\varepsilon) > 0$ such that

$$\int_{\mathbb{T}^3} \left| (-\Delta)^{\frac{\gamma}{2}} f \right|^2 (x) \mathrm{d}x \le C(\varepsilon) [f]^2_{\gamma + \varepsilon} \qquad \forall f \in \mathcal{C}^{\gamma + \varepsilon} (\mathbb{T}^3).$$
(2.18)

For a proof, see [20, Theorem B.1 and Corollary B.1].

Continuing, we recall some elementary calculations for the reader's convenience. With the definitions we gave for ∇ , \mathfrak{D} , setting $D_t^{(v)} \coloneqq \partial_t + v \cdot \nabla$, we have that

$$\nabla e^{ik\cdot\Phi} = i\nabla\Phi \cdot k e^{ik\cdot\Phi} = i e^{k\cdot\Phi} k \cdot \mathfrak{D}\Phi \tag{2.19}$$

$$D_t^{(v)}(\mathfrak{D}\Phi) = \mathfrak{D}(D_t^{(v)}\Phi) - \mathfrak{D}\Phi \cdot \mathfrak{D}v.$$
(2.20)

Observing that $\mathfrak{D}\Phi\mathfrak{D}\Phi^{-1} = \mathrm{Id}$ and thus $0 = D_t^{(v)}(\mathfrak{D}\Phi\mathfrak{D}\Phi^{-1}) = D_t^{(v)}(\mathfrak{D}\Phi) \cdot \mathfrak{D}\Phi^{-1} + \mathfrak{D}\Phi \cdot D_t^{(v)}(\mathfrak{D}\Phi^{-1})$, we can see that

$$D_t^{(v)}\mathfrak{D}\Phi^{-1} = -\mathfrak{D}\Phi^{-1}D_t^{(v)}(\mathfrak{D}\Phi)\mathfrak{D}\Phi^{-1} = (\nabla\Phi^{-1}\nabla v)^T - \mathfrak{D}\Phi^{-1}\cdot\mathfrak{D}D_t^{(v)}\Phi\cdot\mathfrak{D}\Phi^{-1}.$$
(2.21)

We continue by recalling some classical estimates on the transport and transport-diffusion equations, which can be found e.g. in [4, Proposition B.1] (transport) and [20, Proposition 3.3] (transport-diffusion).

Proposition 2.1 (Estimates on the transport equation). Assume $|t - t_0| ||v||_1 \le 1$. Then, any solution f of

$$\begin{cases} (\partial_t + v \cdot \nabla)f = g\\ f(\cdot, 0) = f_0 \end{cases}$$

satisfies

$$\|f(t)\|_{0} \leq \|f_{0}\|_{0} + \int_{t_{0}}^{t} \|g(\cdot, \tau)\| ds$$
$$\|f(t)\|_{\alpha} \leq e^{\alpha} \left(\|f_{0}\|_{\alpha} + \int_{t_{0}}^{t} \|g(\cdot, s)\|_{\alpha} ds \right)$$

for all $0 \le \alpha \le 1$ and, more generally, for any $N \ge 1$ and $0 \le \alpha < 1$

$$[f(t)]_{N+\alpha} \lesssim [f_0]_{N+\alpha} + |t|[v]_{N+\alpha}[f_0]_1 + \int_{t_0}^t ([g(s)]_{N+\alpha} + (t-s)[v]_{N+\alpha}[g(s)]_1) \mathrm{d}s.$$

Define $\Phi(t, \cdot)$ to be the inverse of the flux X of v starting at time t_0 as the identity (i.e. d/dt X = v(X,t) and $X(x,t_0) = x$). Under the same assumptions as above we have that

$$\begin{aligned} \|\nabla \Phi(t) - \mathrm{Id}\|_0 \lesssim |t| [v]_1 \\ [\Phi(t)]_N \lesssim |t| [v]_N \quad \forall N \ge 2 \end{aligned}$$

Proposition 2.2 (Estimates on the transport-diffusion equation). Assume $0 \le (t - t_0)[v]_1 \le 1$. Then, any solution of

$$\begin{cases} (\partial_t + v \cdot \nabla + (-\Delta)^{\theta})u = f & \text{in } \mathbb{T}^3 \times (t_0, T) \\ u(\cdot, t_0) = u_0 & \text{in } \mathbb{T}^3 \end{cases}$$

satisfies

$$\|u(t)\|_{\alpha} \leq e^{\alpha} \left(\|u_0\|_{\alpha} + \int_{t_0}^t \|f(\cdot,s)\|_{\alpha} \mathrm{d}s \right)$$

for all $0 \le \alpha \le 1$ and, more generally, for any $N \ge 1$ and $0 \le \alpha < 1$

$$[u(t)]_{N+\alpha} \lesssim [u_0]_{N+\alpha} + (t-t_0)[v]_{N+\alpha}[u_0]_1 + \int_{t_0}^t \left([f(s)]_{N+\alpha} + (t-s)[v]_{N+\alpha}[f(s)]_1 \right) \mathrm{d}s,$$

where the implicit constants depends only on N, α .

To conclude this section, we recall classical Schauder estimates (see e.g. the book [24]), which will be used in several places in this paper.

Lemma 2.5 (Schauder estimates). For any $\alpha \in (0,1)$ and any $m \in \mathbb{N}$, there exists a constant $C(\alpha,m)$ with the following properties. If $\varphi, \psi : \mathbb{T}^3 \to \mathbb{R}$ are the unique solutions of

$$\begin{cases} \Delta \varphi = f \\ \oint \varphi = 0 \end{cases} \qquad \begin{cases} \Delta \psi = \operatorname{div} F \\ \oint \psi = 0 \end{cases},$$

then

$$\|\varphi\|_{m+2+\alpha} \leq C(m,\alpha) \|f\|_{m+\alpha} \qquad \qquad \|\psi\|_{m+1+\alpha} \leq C(m,\alpha) \|F\|_{m+\alpha}.$$

3 Approximate solutions

For the proof of **Theorem 1.1**, we begin by introducing the various notions of subsolutions needed to perform the convex integration schemes.

The first notion of subsolution is very similar to the one used in [13, 14, 17].

Definition 3.1 (Subsolutions and strict subsolutions). A subsolution is a triple $(v, p, R) : \mathbb{T}^3 \times (0, T) \rightarrow \mathbb{R}^3 \times \mathbb{R} \times S_{>0}^{3 \times 3}$ such that $v \in L^2_{loc}$, $R \in L^1_{loc}$, p is a distribution, the equations

$$\begin{cases} \partial_t v + \operatorname{div}(v \otimes v) + \nabla p + (-\Delta)^{\theta} v = -\operatorname{div} R\\ \operatorname{div} v = 0 \end{cases}$$
(3.1)

hold in the sense of distributions in $\mathbb{T}^3 \times (0,T)$, and moreover $R \ge 0$ a.e., i.e. it is positive semidefinite a.e.. If $R \in S^{3 \times 3}_+$ a.e., then the subsolution is said to be strict.

The next notion of subsolution extends the ones of [14] and [13]. As in [13], the Reynolds stress is controlled by a power of the trace. However, the exponent γ will only act on the "reduced" trace $\rho\Omega^{-1}$, where $\Omega > 0$ is a constant whose role is explained in Section 4.

Definition 3.2 (Strong subsolutions). A strong subsolution with parameters γ , $\Omega > 0$ *is a subsolution* (v, p, R) *such that in addition* tr *R is a function of t only and, if*

$$\rho(t) \coloneqq \frac{1}{3} (\operatorname{tr} R)(t) \qquad \qquad \varrho(t) \coloneqq \frac{\rho(t)}{\Omega},$$

then

$$\left| \mathring{R}(x,t) \right| \le \Omega \varrho^{1+\gamma}(t) \qquad \forall (x,t).$$
(3.2)

Remark 3.1 (On strength and parameters). In our schemes ϱ will be sufficiently small so that in particular $\varrho^{\gamma} \leq r_0$, where r_0 is the geometric constant in [14, Definition 3.2], thus leading to the conclusion that (3.2) implies that our strong subsolutions are also strong in the sense of [14], provided $\Omega = O(1)$ (specifically $\Omega \varrho^{\gamma} \leq r_0$). Note also that, if (v, p, R) is a strong subsolution for some parameters $\gamma, \Omega > 0$ with $\varrho < 1$, then it is also a strong subsolution for any $0 < \gamma' < \gamma$ with the same Ω .

The last notion of subsolution has vanishing Reynolds stress at time t = 0 and the C^1 -norms blow up at certain rates as the Reynolds stress goes to zero. Such adapted subsolutions have been introduced in [14, 13]. The blow-up rate in this paper is analogous to the one of [13]. Differently from [13], the blow-up is controlled by the "reduced" trace ρ rather than the "full" trace ρ , and the estimates include a power of Ω .

Definition 3.3 (Adapted subsolutions). Given $\gamma, \Omega > 0, 0 < \beta < \frac{1}{3}$, and ν satisfying

$$\nu > \frac{1 - 3\beta}{2\beta},\tag{3.3}$$

we call a triple (v, p, R) a C^{β} -adapted subsolution on [0, T] with parameters γ, Ω, ν if $(v, p, R) \in C^{\infty}(\mathbb{T}^3 \times (0, T]) \cap C(\mathbb{T}^3 \times [0, T])$ is a strong subsolution with parameters γ, Ω with initial datum

$$v(\cdot,0) \in C^{\beta}(\mathbb{T}^3) \quad and \quad R(\cdot,0) \equiv 0, \tag{3.4}$$

and, setting $\rho(t) \coloneqq \frac{1}{3} \operatorname{tr} R(x,t)$ and $\varrho \coloneqq \rho \Omega^{-1}$, for all t > 0 we have that $\rho(t) > 0$ and there exist $\alpha \in (0,1)$ and $C \ge 1$ such that

$$\|v\|_{1+\alpha} \le C\Omega^{\frac{1}{2}} \varrho^{-(1+\nu)} \tag{3.5}$$

$$\left|\partial_{t}\varrho\right| \le C\Omega^{\frac{1}{2}}\varrho^{-\nu}.\tag{3.6}$$

4 Strategy of the proof

The remainder of this paper closely follows the convex integration strategy adopted by [13] in the Euler setting. Section 5 states results that allow us to approximate one kind of subsolution (as defined in the previous section) with another. One of those results uses the parameters we will introduce in this section in (4.1).

Section 6 proves the main theorem starting from the results of Section 5.

Section 7 shows how to obtain a strong subsolution from a strict one. By iterating Sections 8-9, we produce sequences (v_q, p_q, R_q) of strong subsolutions which converge to a C^{β} -adapted subsolution in Section 10, and to a weak solution in Section 11.

In passing from one subsolution to another, the C^0 and C^1 norms of the various subsolutions are estimated in terms of parameters (δ_q, λ_q) , where $\delta_q^{1/2}$ is the amplitude (in space) of $w_q \coloneqq v_q - v_{q-1}$, and λ_q is the oscillation frequency (in space) of w_q . The parameters, however, are partially different from those chosen in [13] and closer to the ones used in [14]. More precisely, we define

$$\lambda_q \coloneqq 2\pi \lceil a^{b^q} \rceil \qquad \delta_q \coloneqq \Lambda \zeta_q = \delta \lambda_1^{2\beta} \lambda_q^{-2\beta} \qquad \zeta_q \coloneqq \lambda_q^{-2\beta} \qquad \Lambda \coloneqq \delta \lambda_1^{2\beta}, \tag{4.1}$$

where

- $\lceil x \rceil$ denotes the ceiling of *x*, i.e. the smallest integer $n \ge x$;
- $\beta \in (0, 1/3)$ and $b \in (1, 3/2)$ control the Hölder exponent of the scheme and are required to satisfy

$$1 < b < \frac{1-\beta}{2\beta}.\tag{4.2}$$

• $a \gg 1$ is sufficiently large to absorb various q-independent constants in the course of the proofs.

The parameter Λ , and thus the distinction between δ_q and ζ_q , were absent in [13]. They are added here to make sure $\delta_1 = \delta$, thus making (7.12) an *a*-independent estimate. Thus, in particular, we are allowed to bound Λ from below, since such a bound will be satisfied for *a* large enough, but not to bound it from above, which would cause δ to depend on *a*.

With this choice of parameters, we must require the conditions

$$\Lambda \ge 1 \tag{4.3}$$

$$\frac{1}{3} > \beta > \theta + \varepsilon', \tag{4.4}$$

for some positive ε' . Condition (4.3) merely requires *a* to be sufficiently large.

The main convex integration step will consist in stating that, for a certain universal constant M > 1, some sufficiently small $\alpha, \gamma > 0$, and a sufficiently large $a \gg 1$, if (v_q, p_q, R_q) is a strong subsolution satisfying

$$\left\|\mathring{R}_{q}\right\|_{0} \leq \Lambda \varrho_{q}^{1+\gamma} \tag{4.5}$$

$$\left\| v_q \right\|_{1+\alpha} \le M \delta_q^{\frac{1}{2}} \lambda_q^{1+\alpha} \tag{4.6}$$

$$\frac{3}{4}\delta_{q+2} \le \rho_q \le \frac{7}{2}\delta_{q+1} \tag{4.7}$$

$$\left|\partial_{t}\rho_{q}\right| \leq \rho_{q}\delta_{q}^{\frac{1}{2}}\lambda_{q} \tag{4.8}$$

$$\left\| v_q \right\|_{\theta+\varepsilon} \le M \left(1 + \sum_{i=0}^q \lambda_i^{\theta+\varepsilon-\beta} \right), \tag{4.9}$$

where $\rho_q \coloneqq \frac{1}{3} \operatorname{tr} R_q$, and $\varrho_q \coloneqq \Lambda^{-1} \rho_q$, then there exists a strong subsolution $(v_{q+1}, p_{q+1}, R_{q+1})$ satisfying the conditions (4.5)-(4.9) with *q* replaced by q + 1 as well as the following additional estimate

$$\|v_{q+1} - v_q\|_0 + \lambda_{q+1} \|v_{q+1} - v_q\|_{H^{-1}} + \lambda_{q+1}^{-1-\alpha} \|v_{q+1} - v_q\|_{1+\alpha} \le M\delta_{q+1}^{\frac{1}{2}}.$$

The proof consists of three steps:

- 1. A mollification step, moving from (v_q, p_q, R_q) to $(v_{\ell_{q,i}}, p_{\ell_{q,i}}, R_{\ell_{q,i}})$, where the mollification parameter $\ell_{q,i}$ varies on suitably chosen subintervals, as required by the different orders of the upper and lower bounds on ρ_q in (4.7);
- 2. A gluing step, which goes from $(v_{\ell_{a,i}}, p_{\ell_{a,i}}, R_{\ell_{a,i}})$ to $(\overline{v}_q, \overline{p}_q, \overline{R}_q)$;
- 3. A perturbation step going from $(\overline{v}_q, \overline{p}_q, \overline{R}_q)$ to $(v_{q+1}, p_{q+1}, R_{q+1})$.

The change in condition (4.5) with respect to [13] was made in order to prevent the new definition of δ_q from causing bounds of the form $\Lambda^A \leq 1$, with A > 0, to appear in the proofs. Condition (4.9) was added in order to control the new trace terms.

Section 8 proves the mollification and gluing steps, and Section 9 addresses the perturbation step. The gluing step was introduced in [25] to ensure \mathring{R}_q is supported in pairwise disjoint time intervals. This allows us to construct the perturbation as $w = \sum_i (w_{o,i} + w_{c,i})$, where the $w_{o,i}$ are Mikado flows with pairwise disjoint supports and supp $w_{c,i} \subseteq \text{supp } w_{o,i}$, thus preventing $w \otimes w$ from containing "mixed terms" $w_{o,i} \otimes w_{o,j}$ with $i \neq j$, which are harder to deal with.

Fixing $\alpha > 0, \gamma > 0$, we also define

$$\ell_q \coloneqq \frac{\zeta_{q+2}^{\frac{1+\gamma}{2}}}{\zeta_q^{\frac{1}{2}}\lambda_q\lambda_{q+1}^{2\alpha}} = \frac{\delta_{q+2}^{\frac{1+\gamma}{2}}\Lambda^{-\frac{\gamma}{2}}}{\delta_q^{\frac{1}{2}}\lambda_q\lambda_{q+1}^{2\alpha}}$$
(4.10)

$$\mathbf{r}_q \coloneqq \frac{\ell_q^{4\alpha}}{\delta_q^{\frac{1}{2}} \lambda_q}.\tag{4.11}$$

Remark 4.1 (Homogeneity in Λ of ℓ_q, τ_q). ℓ_q , as well as the $\ell_{q,i}$ defined in Section 8, are 0-homogeneous in Λ , whereas τ_q is 1/2-homogeneous. The last property allows us to cancel the $\Lambda^{1/2}$ factors we will see appearing in the course of the proof.

We also assume

$$\frac{\delta_{q+1}^{\frac{1}{2}}\delta_q^{\frac{1}{2}}\lambda_q}{\lambda_{q+1}^{1-15\alpha-\beta\gamma}} \le \delta_{q+2},\tag{4.12}$$

which can be achieved if *a* is sufficiently large assuming $(15\alpha + \beta\gamma)b < (b-1)(1 - \beta - 2b\beta)$. Moreover, we assume

$$\lambda_{q+1}^{-1} \le \ell_q \le \lambda_q^{-1}. \tag{4.13}$$

The right inequality in (4.13) is evident from the definition. The left inequality can be reduced to $-b < \beta b^2(1+\gamma) + \beta - 1 - 2b\alpha$, which can easily be verified for $\alpha = 0 = \gamma$, and thus also for α, γ sufficiently small. We will in fact need the following sharper bound:

$$\lambda_{q+1}^{1-\overline{N}} \le \ell_q^{\overline{N}+1},\tag{4.14}$$

which can be achieved by imposing the following condition:

$$\overline{N}[(b-1)(1-\beta(b+1)) - \gamma\beta b^2 - 2\alpha b] > 1 + b + (1+\gamma)\beta b^2 + 2\alpha b - \beta.$$
(4.15)

The above conditions can be obtained by choosing, in this order

- b,β as in (4.2), so that in particular $\beta(1+b) < 1$;
- $0 < \alpha, \gamma$ sufficiently small depending on *b*, β ;
- $\overline{N} \in \mathbb{N}$ sufficiently large depending on b, β, α, γ so as to get (4.15).

One last notational remark: $A \leq B$ (resp. $A \geq B$) will mean $A \leq C(b,\beta,\alpha,\gamma,M)B$ (resp. $A \geq C(b,\beta,\alpha,\gamma,M)B$), or $C(N,b,\beta,\alpha,\gamma,M)$ if norms depending on N are involved (e.g. $C^{N+1+\alpha}$ -norms). $A \sim B$ will mean $A \leq B$ and $A \geq B$. Note that C does not depend on $a \gg 1$.

5 Main iterative propositions

In this section, we state the main propositions which allow us to pass from one kind of subsolution to another one, which is closer to the notion of solution. Both the below statements use the parameters δ_q , λ_q , Λ defined in the previous section. The combination of these propositions leads to our main theorem, as illustrated in Section 6.

In the first proposition it is shown that a smooth strict subsolution can be approximated with an adapted subsolution.

Proposition 5.1 (From strict to adapted subsolutions). Let $(\tilde{v}, \tilde{p}, \tilde{R})$ be a smooth strict subsolution on [0, T]. Then, for any $\theta < \hat{\beta} < 1/_3$, $\nu > \frac{1-3\hat{\beta}}{2\hat{\beta}}$, and $\delta, \sigma > 0$, there exist $\gamma, \Omega > 0$ and a $C^{\hat{\beta}}$ -adapted subsolution $(\hat{v}, \hat{p}, \hat{R})$ with parameters γ, Ω, ν such that $\hat{\rho} \le \frac{5}{4}\delta$ and, for all $t \in [0, T]$

$$\int_{\mathbb{T}^3} \left(|\hat{v}|^2 + \operatorname{tr} \hat{R} \right) \mathrm{d}x = \int_{\mathbb{T}^3} \left(|\tilde{v}|^2 + \operatorname{tr} \tilde{R} \right) \mathrm{d}x$$
(5.1)

$$\|\tilde{v} - \hat{v}_{C^0} \lesssim \|1 + \delta^{\frac{1}{2}} \tag{5.2}$$

$$\left\|\tilde{v} - \hat{v}\right\|_{H^{-1}} < \sigma \tag{5.3}$$

Moreover, if we define

$$\hat{\mathcal{T}}(t) \coloneqq \int_{0}^{t} \int_{\mathbb{T}^{3}} \left(\left| (-\Delta)^{\frac{\theta}{2}} \tilde{v} \right|^{2} - \left| (-\Delta)^{\frac{\theta}{2}} \hat{v} \right|^{2} \right) \mathrm{d}x \mathrm{d}s,$$
(5.4)

we have the bound

$$\left|\partial_{t}\hat{\mathcal{T}}\right| \lesssim \sum_{q} \Lambda \lambda_{q}^{\theta+\varepsilon-\beta}.$$
(5.5)

The q = 0 term of this sum is the largest, and is $\delta \lambda_1^{2\beta} \lambda_0^{\theta+\epsilon-\beta}$, which is a-increasing. Since we can see that $a \to \infty$ for $\delta \to 0$, for any $\eta > 0$, it can only be ensured that

$$\hat{\mathcal{T}}|(t) \leq \eta$$
 $t \in [0, \hat{T}(\eta, \delta, a)],$

where $\hat{T}(\eta, \delta, a) \sim \eta \delta^{-1} \lambda_1^{-2\beta} \lambda_0^{\beta-\theta-\varepsilon} \to 0$ if $a \to \infty$ or $\eta \to 0$.

The proof will be given in Section 10.

Next, we show that adapted subsolutions can be approximated by weak solutions with the same initial data.

Proposition 5.2 (From adapted subsolutions to weak solutions). Let $\theta < \beta < \hat{\beta} < \frac{1}{3}$, $\gamma > 0$, and $\nu > 0$ with

$$\frac{1-3\hat{\beta}}{2\hat{\beta}} < \nu < \frac{1-3\beta}{2\beta}.$$
(5.6)

The following holds for all $\delta < 1$.

If $(\hat{v}, \hat{p}, \hat{R})$ is a $C^{\hat{\beta}}$ -adapted subsolution with parameters γ, Ω, ν and $\hat{\rho} \leq \frac{5}{2}\delta$, then, for all $\sigma > 0$, there exists a C^{β} weak solution v of (1.5) with initial datum

$$v(\cdot,0) = \hat{v}(\cdot,0) \tag{5.7}$$

and such that, for all $t \in [0, T]$

$$\int_{\mathbb{T}^3} |v|^2 dx = \int_{\mathbb{T}^3} \left(|\hat{v}|^2 + \operatorname{tr} \hat{R} \right) dx$$
(5.8)

$$\|\boldsymbol{v} - \hat{\boldsymbol{v}}\|_{C^0} \lesssim \delta^{\frac{1}{2}} \tag{5.9}$$

$$\|v - \hat{v}\|_{H^{-1}} < \sigma \tag{5.10}$$

Moreover, if we define

$$\mathcal{T}(t) \coloneqq \int_{0}^{t} \int_{\mathbb{T}^{3}} \left(\left| (-\Delta)^{\frac{\theta}{2}} \hat{v} \right|^{2} - \left| (-\Delta)^{\frac{\theta}{2}} v \right|^{2} \right) \mathrm{d}x \mathrm{d}s,$$
(5.11)

once again we can see that

$$|\partial_t \mathcal{T}| \lesssim \sum \Lambda \lambda_q^{\theta + \varepsilon - \beta},\tag{5.12}$$

so that, like in the previous proposition, for any $\eta > 0$, it can be ensured that

$$|\mathcal{T}(t)| \leq \eta \qquad \forall t \in [0, T(\eta, \delta, a)]$$

where $T(\eta, \delta, a) \sim \eta \delta^{-1} \lambda_1^{-2\beta} \lambda_0^{\beta-\theta-\varepsilon} \to 0$ if $\eta \to 0$ or $a \to \infty$. Finally, consider the family of strong subsolutions $(\hat{v}, \hat{p}, \hat{R} + e/3 \operatorname{Id})$, where $e : [0, T] \to \mathbb{R}$ satisfies the following conditions:

$$e(t) \le \frac{5}{2}\delta - \hat{\rho}(t) \tag{5.13}$$

$$|\partial_t e| \le \sqrt{\delta_0} \lambda_0 e. \tag{5.14}$$

$$e \ge 0. \tag{5.15}$$

This family can be used to yield infinitely many distinct weak solutions with the same initial data as (v, p).

The proof will be given in Section 11.

Proposition 5.2 allows us to prove the following wildness criterion.

Corollary 5.1 (Wildness criterion). Let $\theta < \beta < \frac{1}{3}$ and $(\hat{v}, \hat{p}, \hat{R})$ be a C^{β} -adapted subsolution such that $\rho \leq \frac{5}{2}\delta$ for some small $\delta > 0$ and $\rho^{-1}|\partial_t \rho| \leq M\delta$ for some suitably large M > 0. Assume that the following admissibility condition is satisfied for all $t \in [0, t_a]$ for some sufficiently small t_a :

$$\frac{1}{2} \int_{\mathbb{T}^3} \left(|\hat{v}|^2(x,t) + \operatorname{tr}\hat{R}(x,t) \right) \mathrm{d}x + \int_0^t \int_{\mathbb{T}^3} \left| (-\Delta)^{\frac{\theta}{2}} \hat{v} \right|^2(x,s) \mathrm{d}x \mathrm{d}s \le \frac{1}{2} \int_{\mathbb{T}^3} \left(|\hat{v}|^2(x,0) + \operatorname{tr}\hat{R}(x,0) \right) \mathrm{d}x,$$
(5.16)

with a strict inequality for at least some $t \in [0, t_a]$. Then $\hat{v}(x, 0) \in W_{\theta, \beta-\varepsilon, t_a}$ for any $\varepsilon > 0$.

The existence of infinitely many $C^{\beta-\varepsilon}$ weak solutions with $\hat{v}(x,0)$ as their initial datum is a consequence of **Proposition 5.2** above. The admissibility of those solutions follows from (5.16) as shown in the next section, where it is also seen that the strictness of (5.16) for at least some *t* is vital to the admissibility of the solutions. We shall henceforth adopt the following notational convention, already applied in the statements of the propositions:

- $(\tilde{v}, \tilde{p}, \tilde{R})$ will always denote strict subsolutions;
- In Sections 6-7, (v, p, Ř) will always denote strong subsolutions; in Sections 8-9, all subsolutions will be strong, and in Sections 10-11, the subscripts will mark strong subsolutions;
- $(\hat{v}, \hat{p}, \hat{R})$ will always denote adapted subsolutions, and $\hat{\beta}$ will be the Hölder regularity of adapted subsolutions;
- (*v*, *p*) will always denote (weak) solutions.

6 **Proof of the existence theorem**

We start by recalling the following classical result.

Theorem 6.1 (Existence of Leray solutions). For any $w \in L^2(\mathbb{T}^3)$ with div w = 0 and every $\theta \in (0,1)$ there is a weak solution $v \in L^{\infty}(\mathbb{R}^+, L^2(\mathbb{T}^3)) \cap L^2(\mathbb{R}^+, H^{\theta}(\mathbb{T}^3))$ of (1.5) such that $v(\cdot, 0) = w$ and

$$\frac{1}{2} \int_{\mathbb{T}^3} |v|^2(x,t) dx + \int_0^t \int_{\mathbb{T}^3} \left| (-\Delta)^{\frac{\theta}{2}} v \right|^2(x,s) dx ds \le \frac{1}{2} \int_{\mathbb{T}^3} |w|^2(x) dx \qquad \forall t \ge 0.$$
(6.1)

In fact, the following form of energy inequality also holds:

$$\frac{1}{2}\int_{\mathbb{T}^3} |v|^2(x,t) \mathrm{d}x + \int_s^t \int_{\mathbb{T}^3} \left| (-\Delta)^{\frac{\theta}{2}} v \right|^2(x,\tau) \mathrm{d}x \mathrm{d}\tau \le \frac{1}{2} \int_{\mathbb{T}^3} |v|^2(x,s) \mathrm{d}x \qquad a.e. \ s, \forall t > s$$

Recalling the **Definition 3.1** of subsolutions and strict subsolutions, one can prove the following existence result.

Lemma 6.1 (Existence of strict subsolutions). Let $w \in L^2(\mathbb{T}^3)$ with div w = 0. For any $\delta > 0$ there exists a smooth strict subsolution $(\tilde{v}, \tilde{p}, \tilde{R})$ defined on [0, T) such that

$$\|\tilde{v}|_{t=0} - w\|_{L^2(\mathbb{T}^3)} \le \delta,$$
 (6.2)

and for all $t \in [0,T]$

$$\frac{1}{2} \int_{\mathbb{T}^3} \left(|\tilde{v}|^2(x,t) + \operatorname{tr} \tilde{R}(x,t) \right) \mathrm{d}x + \int_0^t \int_{\mathbb{T}^3} \left| (-\Delta)^{\frac{\theta}{2}} \tilde{v} \right|^2(x,s) \mathrm{d}x \mathrm{d}s \le \frac{1}{2} \int_{\mathbb{T}^3} |w|^2(x) \mathrm{d}x + \delta.$$
(6.3)

The proof is an adaptation of the one of [32, Lemma 6.8, p. 38], and is reported in Appendix A.

The proof of the main result then follows the steps of [14, Section 4], taking care of the additional dissipation by suitably increasing the energy of the starting strict subsolution.

Proof. (Theorem 1.1)

We choose $\eta > 0, \theta < \beta < \beta', w \in L^2$ with div w = 0. Using the above result, we obtain a smooth strict subsolution $(\tilde{v}', \tilde{p}', \tilde{R}')$ on [0, T] such that (6.2)-(6.3) hold for some $\delta > 0$ which we will fix later. We now note that adding a smoothly time-dependent non-negative multiple of the identity to \tilde{R}' does not change the fact that $(\tilde{v}', \tilde{p}', \tilde{R}')$ is a smooth strict subsolution. We may thus substitute our strict subsolution with $(\tilde{v}, \tilde{p}, \tilde{R}) := (\tilde{v}', \tilde{p}', \tilde{R}' + 2(3|\mathbb{T}^3|)^{-1}e_K(t) \mathrm{Id})$, where *K* is a constant to be specified later in this proof, $0 \le e_K(t) \le (\delta/2 - Kt)^+$, and $e_K(0) = \delta/2$. Combining the choice of e_K with (6.3), we obtain the following relations for $\delta/2 - Kt > 0$:

$$\frac{1}{2} \int_{\mathbb{T}^3} \left(|\tilde{v}|^2(x,0) + \operatorname{tr} \tilde{R}(x,0) \right) \mathrm{d}x = \frac{1}{2} \int_{\mathbb{T}^3} |w|^2(x) \mathrm{d}x + \frac{3}{2} \delta$$
(6.4)

$$\frac{1}{2} \int_{\mathbb{T}^3} \left(|\tilde{v}|^2(x,t) + \operatorname{tr} \tilde{R}(x,t) \right) \mathrm{d}x + \int_0^t \int_{\mathbb{T}^3} \left| (-\Delta)^{\frac{\theta}{2}} \tilde{v} \right|^2(x,s) \mathrm{d}x \mathrm{d}s \le \frac{1}{2} \int_{\mathbb{T}^3} |w|^2(x) \mathrm{d}x + \frac{3}{2} \delta - Kt.$$
(6.5)

Indeed, passing from $(\tilde{v}', \tilde{p}', \tilde{R}')$ to $(\tilde{v}, \tilde{p}, \tilde{R})$ adds a term e_K to the left-hand side, since tr $\tilde{R} = \text{tr} \tilde{R}' + 2|\mathbb{T}^3|^{-1}e_K$. Now let \tilde{v}_0 be the initial datum of \tilde{v} , and note that

$$\int_{\mathbb{T}^3} \operatorname{tr} \tilde{R}(x,0) \mathrm{d}x = \|w\|_{L^2}^2 - \|\tilde{v}_0\|_{L^2}^2 + 3\delta \le \|w - \tilde{v}_0\|_{L^2} (\|w\|_{L^2} + \|\tilde{v}_0\|_{L^2}) + 3\delta \le \delta(2\|w\|_{L^2} + \delta) + 3\delta \le C(w)\delta.$$
(6.6)

Using **Proposition 5.1** and **Proposition 5.2**, we can produce a $C^{\hat{\beta}}$ -adapted subsolution $(\hat{v}, \hat{p}, \hat{R})$ and a C^{β} weak solution (v, p), satisfying the integral equalities (5.1) and (5.8) and the H^{-1} estimates (5.3) and (5.10), and the functions \hat{T}, T of (5.4) and (5.11). Recall that we have that

$$\int_{\mathbb{T}^3} (|\tilde{v}|^2 + \operatorname{tr} \tilde{R})(x, t) \mathrm{d}x = \int_{\mathbb{T}^3} (|\hat{v}|^2 + \operatorname{tr} \hat{R})(x, t) \mathrm{d}x = \int_{\mathbb{T}^3} |v(x, t)|^2 \mathrm{d}x, \tag{6.7}$$

and thus

$$\|v(t)\|_{2}^{2} - \|\tilde{v}(t)\|_{2}^{2} = \int \operatorname{tr} \tilde{R}(x,t) \mathrm{d}x.$$
(6.8)

Call v_0 the initial datum of v and of \hat{v} , and note that, by (5.3), (6.8) and (6.6), we have that

$$\|v_0 - \tilde{v}_0\|_2^2 = \|v_0\|_2^2 - \|\tilde{v}_0\|_2^2 - 2 \cdot \int_{\mathbb{T}^3} \tilde{v}_0 \cdot (v_0 - \tilde{v}_0) dx \le C(w) \delta + 2\sigma \|\tilde{v}_0\|_{H^1}$$

Thus, we first choose δ sufficiently small so that $C(w)\delta < \frac{\eta^2}{2}$ and obtain \tilde{v} , then we fix $\sigma < \frac{\eta^2}{4\|\tilde{v}_0\|_{H^1}}$ and obtain \hat{v} , and finally we conclude that

$$\|v_0-\tilde{v}_0\|_2^2 \leq \eta^2 \implies \|\tilde{v}_0-v_0\|_{L^2} \leq \eta.$$

As for the admissibility condition, choosing *K* so that $|\partial_t(\mathcal{T} + \hat{\mathcal{T}})| \le K - 1$, as is made possible by (5.5) and (5.12), we have that

$$\begin{aligned} \frac{1}{2} \int_{\mathbb{T}^{3}} |v(x,t)|^{2} dx + \int_{0}^{t} \int_{\mathbb{T}^{3}} \left| (-\Delta)^{\frac{\theta}{2}} v \right|^{2}(x,s) ds dx \\ \stackrel{(6.7)}{=} \frac{1}{2} \int_{\mathbb{T}^{3}} \left(|\tilde{v}(x,t)|^{2} + \operatorname{tr} \tilde{R}(x,t) \right) dx - (\hat{\mathcal{T}} + \mathcal{T})(t) + \int_{0}^{t} \int_{\mathbb{T}^{3}} \left| (-\Delta)^{\frac{\theta}{2}} \tilde{v} \right|^{2}(x,s) ds dx \\ \stackrel{(6.5)}{\leq} \int_{\mathbb{T}^{3}} \frac{1}{2} |w|^{2}(x) dx + \frac{3}{2} \delta - t \stackrel{(6.4)}{\leq} \frac{1}{2} \int_{\mathbb{T}^{3}} \left(|\tilde{v}_{0}|^{2} + \operatorname{tr} \tilde{R}(x,0) \right) dx \stackrel{(6.7)}{=} \frac{1}{2} \int_{\mathbb{T}^{3}} |v|^{2}(x,0) dx, \end{aligned}$$

where the second-last inequality is strict for all $t \neq 0$ where (6.5) is valid. This yields the energy inequality for t sufficiently small. Since we can only estimate $|\partial_t \mathcal{T} + \partial_t \hat{\mathcal{T}}|$ with a quantity which is potentially unbounded as $\delta \to 0$ (as seen in (5.5) and (5.12)), and $C(w)\delta < \frac{\eta^2}{2}$ implies $\delta \to 0$ as $\eta \to 0$, we conclude that our time $T(\eta)$ of guaranteed admissibility satisfies

$$\lim_{\eta\to 0} T(\eta) = 0.$$

So far, we have only obtained one solution for each η . Suppose that, from $(\tilde{v}, \tilde{p}, \tilde{R})$, we produced the adapted subsolution $(\hat{v}, \hat{p}, \hat{R})$, and from there the solution (v, p). As noted in **Proposition 5.2**, considering

$$(\hat{v}', \hat{p}', \hat{R}') \coloneqq \left(\hat{v}, \hat{p}, \hat{R} + \frac{e}{3} \operatorname{Id}\right)$$

with *e* satisfying a suitable set of conditions, we can obtain more weak solutions and ensure these solutions are admissible up to $T(\eta)$. The required conditions are listed below.

1. The first condition ensures $\hat{R}'(\cdot, 0) \equiv 0$:

e(0) = 0;

2. The second one ensures $tr(\hat{R}') \ge 0$:

$$e(t) \geq 0;$$

it would be enough to require $\hat{\rho}' \ge |e|$, but we exclude e < 0 for convenience (cfr. Step 3 of Section 11);

3. The third one ensures the admissibility of the new solutions:

$$\begin{split} \frac{1}{2} |\mathbb{T}^3| e(t) &\leq \frac{1}{2} \int\limits_{\mathbb{T}^3} \left(|\hat{v}(x,0)|^2 + \operatorname{tr} \hat{R}(x,0) - |\hat{v}(x,t)|^2 - \operatorname{tr} \hat{R}(x,t) \right) \mathrm{d}x \\ &- \int\limits_0^t \int\limits_{\mathbb{T}^3} \left| (-\Delta)^{\frac{\theta}{2}} \hat{v}(x,s) \right|^2 \mathrm{d}x \mathrm{d}s - \hat{\mathcal{T}} - Kt, \end{split}$$

K being the same constant used to find (v, p); since the right-hand side of the above inequality is strictly positive for all $t \neq 0$ where (v, p) is admissible, this condition is compatible with requiring that $e \ge 0$ as done above;

4. The last conditions are (5.13)-(5.15).

This completes the proof.

7 From strict to strong subsolutions

We state here an analogue of [14, Proposition 3.1].

Proposition 7.1. Let $(\tilde{v}, \tilde{p}, \tilde{R})$ be a smooth solution of (3.1), and $S \in C^{\infty}(\mathbb{T}^3 \times [0, T]; \mathcal{S}^{3 \times 3}_+)$ be a smooth positivedefinite matrix field. Fix $\overline{\alpha} \in (0, 1)$ and $\varepsilon > 0$. Then for any $\lambda > 1$ there exists a smooth solution $(\check{v}, \check{p}, \check{R})$ of (3.1) with

$$(\check{v},\check{p},\check{R}) = (\tilde{v},\tilde{p},\tilde{R}) \quad for \ t \notin \operatorname{supp} \operatorname{tr} S,$$
(7.1)

$$\int_{\mathbb{T}^3} \left(|\check{v}|^2 + \operatorname{tr}\check{R} \right)(x,t) \mathrm{d}x = \int_{\mathbb{T}^3} \left(|\tilde{v}|^2 + \operatorname{tr}\tilde{R} \right)(x,t) \mathrm{d}x \qquad \forall t \in [0,T],$$
(7.2)

and the following estimates hold

$$\|\check{v} - \tilde{v}\|_{H^{-1}} \le \frac{C}{\lambda} \tag{7.3}$$

$$\|\check{\mathbf{v}}\|_k \le C\lambda^k \qquad k = 1,2 \tag{7.4}$$

$$\left\|\tilde{R} - \check{R} - S\right\|_{N} \le \frac{C}{\lambda^{1 - 2\theta - \overline{\alpha} - N}}$$
(7.5)

Moreover, $\operatorname{tr}(\tilde{R}(x,t) - \check{R}(x,t) - S(x,t)) \Rightarrow \mu(t)$ is a function of t only and satisfies

$$\left|\mu'\right|(t) \le C\lambda^{\overline{\alpha}}.\tag{7.6}$$

The constant $C \ge 1$ above depends on (v, p, R), S and $\overline{\alpha}$, but not on λ . Finally, defining

$$\check{\mathcal{J}}(t) \coloneqq \int_{0}^{t} \int_{\mathbb{T}^{3}} \left(\left| (-\Delta)^{\frac{\theta}{2}} \check{v}(x,s) \right|^{2} - \left| (-\Delta)^{\frac{\theta}{2}} \check{v}(x,s) \right|^{2} \right) \mathrm{d}x \mathrm{d}s,$$

we have that

$$\left|\partial_t \check{\mathcal{J}}(t)\right| \le C \lambda^{2(\theta+\varepsilon)}.\tag{7.7}$$

Proof.

Define the inverse flow of \tilde{v} , $\Phi : \mathbb{T}^3 \times [0,T] \to \mathbb{T}^3$, as the solution of

$$\begin{cases} \partial_t \Phi(x,t) + (\tilde{v} \cdot \nabla) \Phi(x,t) = 0\\ \Phi(x,0) = x \qquad x \in \mathbb{T}^3 \end{cases}$$

 \diamond

and set

$$\overline{R}(x,t) = \mathfrak{D}\Phi(x,t)S(x,t)\mathfrak{D}^T\Phi(x,t).$$

Observe that \overline{R} is defined on the compact set $\mathbb{T}^3 \times [0,T]$ and, being continuous, has a compact image $\mathcal{N}_0 := \overline{R}(\mathbb{T}^3 \times [0,T]) \subset \mathcal{S}^{3 \times 3}_+$.

By Lemma 2.2 there exists a smooth vector field $W : \mathcal{N}_0 \times \mathbb{T}^3 \to \mathbb{T}^3$ satisfying the differential equations (2.6) and the integral equations (2.7). Define

$$w_o(x,t) = \mathfrak{D}\Phi^{-1}W(\overline{R},\lambda\Phi(x,t))$$
$$w_c(x,t) = \frac{1}{\lambda}\operatorname{curl}(\mathfrak{D}^T\Phi U(\overline{R},\lambda\Phi(x,t))) - w_o$$

where $U = U(R,\xi)$ is defined as in (2.12) and thus satisfies $\operatorname{curl}_{\xi} U = W$. Moreover, set

$$\check{v} \coloneqq \tilde{v} + w_o + w_c \qquad \check{p} = \tilde{p} + \overline{p} \qquad \check{R} \coloneqq \tilde{R} - S - \mathring{\mathcal{E}}^{(1)} - \mathscr{E}^{(2)},$$

where

$$\begin{split} \overline{p} &\coloneqq -\frac{1}{3} (w_c \cdot \breve{v} + w_o \cdot w_c) \\ \mathring{\mathcal{E}}^{(1)} &\coloneqq \mathcal{R}(F) + (w_c \otimes \breve{v} + w_o \otimes w_c + \overline{p} \operatorname{Id}) \\ F &\coloneqq \operatorname{div}(w_o \otimes w_o - S) + (\partial_t + \widetilde{v} \cdot \nabla) w_o \\ &+ [(w_o + w_c) \cdot \nabla] \widetilde{v} + \partial_t w_c + (-\Delta)^{\theta} (w_o + w_c) \\ \mathscr{E}^{(2)} &\coloneqq \frac{1}{3} \cdot \int_{\mathbb{T}^3} \left(|\breve{v}|^2 - |\widetilde{v}|^2 - \operatorname{tr} S \right) \mathrm{d}x \cdot \operatorname{Id}, \end{split}$$

with \mathcal{R} defined as in (2.13). By construction, the relation (7.2) holds, $\mathring{\mathcal{E}}^{(1)}$ is traceless, $\mathscr{E}^{(2)}$ is only *t*-dependent, and $(\check{v}, \check{p}, \check{R})$ solves (3.1). To verify this last claim, we can see that

$$\operatorname{div} \check{\mathcal{E}}^{(1)} = \operatorname{div}(\check{v} \otimes \check{v} - \tilde{v} \otimes \tilde{v} - S + \overline{p} \operatorname{Id}) + \partial_t (\check{v} - \tilde{v}) + (-\Delta)^{\theta} (w_o + w_c)$$
$$= \partial_t \check{v} + \operatorname{div}(\check{v} \otimes \check{v} - S + \mathring{R}) + \nabla \check{p} + (-\Delta)^{\theta} \check{v}.$$

We call $w \coloneqq w_o + w_c = \check{v} - \tilde{v}$. Recall that

$$W(R,\xi) = \sum_{k \neq 0} a_k(R) A_k e^{ik \cdot \xi}$$

 $U(R,\xi) = \sum_k a_k(R) \frac{ik \times A_k}{|k|^2} e^{ik \cdot \xi}$

which are respectively (2.8) and (2.12), with the a_k satisfying (2.10). This allows us to decompose

$$w_o = \sum_{k \neq 0} \mathfrak{D} \Phi^{-1} a_k (\mathfrak{D} \Phi S \mathfrak{D}^T \Phi) A_k e^{ik \cdot \lambda \Phi} = \sum_{k \neq 0} b_k e^{ik \cdot \lambda \Phi}$$
(7.8)

$$w_{c} = \frac{i}{\lambda} \sum_{k \neq 0} \nabla (a_{k}(\mathfrak{D} \Phi S \mathfrak{D}^{T} \Phi)) \times \frac{\mathfrak{D}^{T} \Phi(k \times A_{k})}{|k|^{2}} e^{ik \cdot \lambda \Phi} = \sum_{k \neq 0} \frac{c_{k}}{\lambda} e^{ik \cdot \lambda \Phi}.$$
(7.9)

The estimate (7.5) is deduced by combining arguments from [14] with estimates for $\mathcal{E}^{(2)}$ and $\mathcal{R}((-\Delta)^{\theta}w)$. $\mathcal{E}^{(2)}$ is estimated in a similar fashion to how we estimate $\mathring{\mathcal{E}}^{(1)}$ below. To estimate $\mathcal{R}((-\Delta)^{\theta}w)$, using the fact that $[\mathcal{R}, (-\Delta)^{\theta}] = 0$ and (2.17), we see that

$$\begin{split} \left\| \mathscr{R}((-\Delta)^{\theta} w) \right\|_{0} &\lesssim \left\| \mathscr{R} w \right\|_{2\theta + \overline{\alpha}} \lesssim \sum_{k} \left(\frac{\left\| b_{k} + \lambda^{-1} c_{k} \right\|_{0}}{|\lambda k|^{1 - \overline{\alpha} - 2\theta}} + \frac{\left\| b_{k} + \lambda^{-1} c_{k} \right\|_{N + 2\theta - \overline{\alpha}}}{|\lambda k|^{N - 2\theta - \overline{\alpha}}} \right. \\ &+ \frac{\left\| b_{k} + \lambda^{-1} c_{k} \right\|_{0} \left\| \Phi \right\|_{N + 2\theta + \overline{\alpha}}}{|\lambda k|^{N - 2\theta - \overline{\alpha}}} \right) \\ &\lesssim \lambda^{\overline{\alpha} + 2\theta - 1} \cdot \sum_{k} \left(\frac{1}{|k|^{7 - \overline{\alpha} - 2\theta}} + \frac{1 + C_{\Phi}(N, \alpha, \theta)}{\lambda^{N - 1} |k|^{N + 6 - 2\theta - \overline{\alpha}}} \right), \end{split}$$

where we used (2.10) to get the extra $|k|^{-6}$ in each term, and the boundedness of Φ to get the $C_{\Phi}(N, \alpha, \theta)$. Concerning (7.4), the smoothness of Φ , *S* combined with (2.10) gives us

$$\max\{\|c_k\|_N, \|b_k\|_N\} \lesssim |k|^{-m},\tag{7.10}$$

for all integers m > 0, where the b_k and c_k are as in the decompositions of w_o, w_c above. This easily allows us to conclude that

$$\|w\|_N \lesssim \lambda^N$$

since differentiating the exponential gives us a factor of λ for each derivative. We then note that

$$\|\check{v}\|_N \le \|\tilde{v}\|_N + \|w\|_N \lesssim 1 + \lambda^N \lesssim \lambda^N$$

where the second step used the smoothness of \tilde{v} . For N = 1, 2 the above reduces to (7.4). Estimate (7.3) is proved separately for w_c and w_o . The former is straightforward, since w_c is already of order λ^{-1} in $L^2 \hookrightarrow H^{-1}$ thanks to (7.9), and (7.3) is an H^{-1} estimate. For the latter, the main idea is to write

$$e^{i\lambda\Phi\cdot k} = \frac{\partial_j e^{i\lambda\Phi\cdot k}}{i\lambda\partial_j\Phi\cdot k},$$

and integrating by parts. One must then make sure that j = j(x) is chosen in such a way that the denominator is bounded from below. This can be done by using the fact that Φ is a diffeomorphism, which implies $|\mathfrak{D}\Phi|$ is bounded below.

To continue, we note that $\mu = \text{tr} \mathcal{E}^{(2)} = \int |\tilde{v}|^2 - |\tilde{v}|^2 - \text{tr} S dx$. \tilde{v} and tr *S* are both smooth, so they are bounded. In order to estimate $\int |\check{v}(t)|^2$, note that the following energy identity for \check{v} follows from (3.1):

$$\partial_t \frac{1}{2} |\check{v}|^2 + \operatorname{div}\left(\check{v}\left(\frac{|\check{v}|^2}{2} + \tilde{p}\right)\right) + \check{v} \cdot (-\Delta)^{\theta} \tilde{v} = -\check{v} \cdot \operatorname{div}(\mathring{\check{R}} - \mathscr{R}((-\Delta)^{\theta} w)).$$

Moreover, with the arguments used to estimate R_{11} in [14, pp. 18-20], we conclude that

$$\left\| \mathring{\mathcal{E}}^{(1)} - \mathscr{R}((-\Delta)^{\theta} w) \right\|_{0} \lesssim \lambda^{\overline{\alpha} - 1}.$$

These two bounds, by integrating in x and using (7.4), yield

$$\left|\frac{\mathrm{d}}{\mathrm{d}t}\int\frac{1}{2}|\check{v}|^{2}\mathrm{d}x\right|\lesssim\int|\check{v}|\left|(-\Delta)^{\theta}\tilde{v}\right|+|\nabla\check{v}|\left|\check{\check{R}}-\mathscr{R}((-\Delta)^{\theta}w)\right|\mathrm{d}x\leq C(1+\lambda^{\overline{\alpha}}).$$

Thus, the estimate (7.6) is proved.

The last thing left is to estimate $|\partial_t \check{\mathcal{T}}|$. Combining some simple calculations with (7.4), (2.17), (2.18), and (2.2), we obtain that

$$\begin{aligned} \left|\partial_{t}\check{\mathcal{T}}\right| &= \left|\int_{\mathbb{T}^{3}} \left|(-\Delta)^{\frac{\theta}{2}}\check{v}\right|^{2} - \left|(-\Delta)^{\frac{\theta}{2}}\check{v}\right|^{2} dx ds\right| = \left|\int_{\mathbb{T}^{3}} [2(-\Delta)^{\frac{\theta}{2}}\check{v} + (-\Delta)^{\frac{\theta}{2}}w] \cdot (-\Delta)^{\frac{\theta}{2}} w dx ds \\ &\lesssim \left|\int_{\mathbb{T}^{3}} 2(-\Delta)^{\frac{\theta}{2}}\check{v} \cdot (-\Delta)^{\frac{\theta}{2}} w dx ds\right| + [w]^{2}_{\theta+\varepsilon} ds \lesssim \underbrace{\|\check{v}\|_{\theta+\varepsilon} \|w\|_{\theta+\varepsilon}}_{=:I} + \lambda^{2(\theta+\varepsilon)}. \end{aligned}$$

The velocity \tilde{v} is bounded by smoothness, so $I \leq K(\tilde{v}, \theta, \varepsilon) \lambda^{\theta + \varepsilon}$. Since $\lambda > 1$, this yields (7.7), thus concluding the proof.

Proposition 7.1 will be applied in the situation described by the following corollary.

Corollary 7.1 (Strict to strong). Let $(\tilde{v}, \tilde{p}, \tilde{R})$ be a smooth strict subsolution on [0, T]. There exist $\tilde{\delta}, \gamma > 0$ such that the following holds.

For any $0 < \delta < \tilde{\delta}$, $\alpha, \gamma > 0$ and $0 < \varepsilon < \beta - \theta$ sufficiently small, there exists a smooth strong subsolution $(\check{v}, \check{p}, \check{R})$ with $\check{R}(x,t) = \check{\rho}(t) \operatorname{Id} + \check{R}(x,t)$, and a "dissipative trace term" as isolated in **Proposition 7.1**, i.e.

$$\check{\mathcal{T}}(t) \coloneqq \int_{0}^{t} \int_{\mathbb{T}^{3}} \left(\left| (-\Delta)^{\frac{\theta}{2}} \tilde{v}(x,s) \right|^{2} - \left| (-\Delta)^{\frac{\theta}{2}} \check{v}(x,s) \right|^{2} \right) \mathrm{d}x \mathrm{d}s$$

such that, for all $t \in [0, T]$

$$\int_{\mathbb{T}^3} \left(|\tilde{v}(x,t)|^2 + \operatorname{tr} \tilde{R}(x,t) \right) \mathrm{d}x = \int_{\mathbb{T}^3} \left(|\check{v}(x,t)|^2 + \operatorname{tr} \check{R}(x,t) \right) \mathrm{d}x$$
(7.11)

$$\frac{3}{4}\delta \le \check{\rho} \le \frac{5}{4}\delta \tag{7.12}$$

$$\left|\check{\check{R}}\right| \le \Lambda \check{\varrho}^{1+\gamma} \tag{7.13}$$

$$\|\breve{v} - \widetilde{v}\|_{H^{-1}} \le \delta\lambda_0^{-1} \tag{7.14}$$

$$\|\breve{v}\|_{1+\alpha} \le \delta_0 \lambda_0^{1+\alpha} \tag{7.15}$$

$$|\partial_t \check{\rho}(t)| \le \delta \delta_0^{\overline{2}} \lambda_0 \tag{7.16}$$

$$\left|\partial_t \check{\mathcal{J}}(t)\right| \le \Lambda^{\frac{1}{2}} \delta_0^{\frac{1}{2}} \lambda_0^{\theta+\varepsilon} \tag{7.17}$$

$$\|\check{v}\|_{\theta+\varepsilon} \le K(1+\delta_0^{\frac{1}{2}}\lambda_0^{\theta+\varepsilon}).$$
(7.18)

where the constant K depends on $(\tilde{v}, \tilde{p}, \tilde{R})$ and ε , the parameters $\delta_q, \lambda_q, \zeta_q, \Lambda$ are defined as in (4.1) with sufficiently large a, and α is the small parameter from Section 4.

The proof will proceed by first reducing all the claims in the corollary to a series of conditions on λ , and then, at the end, proving that all those conditions can be satisfied simultaneously. This is necessary because some of them are upper bounds on λ , and some are lower bounds. *Proof.*

Let

$$\tilde{\delta} \coloneqq \frac{1}{2} \inf \left\{ \tilde{R}(x,t) \xi \cdot \xi : |\xi| = 1, x \in \mathbb{T}^3, t \in [0,T] \right\}.$$

Since \tilde{R} is a smooth positive definite tensor on a compact set, $\tilde{\delta} > 0$. Then $S \coloneqq \tilde{R} - \delta$ Id is positive definite for any $\delta < \tilde{\delta}$. We may in addition assume without loss of generality that $\delta \le 1$. We apply **Proposition 7.1** with $(\tilde{v}, \tilde{p}, \tilde{R}), S$, and $\overline{\alpha} \in (0, 1), \varepsilon > 0$ to be chosen below. This yields a smooth solution $(\check{v}, \check{p}, \check{R})$ of (3.1) with properties (7.2), (7.3)-(7.5), and (7.6). We first note that (7.11) coincides with (7.2). Next, we observe that $\check{R} - \tilde{R} + S = \check{R} - \delta$ Id, so that, since $\mu(t) = tr(\check{R} - \tilde{R} + S)$ is a function of time only, the function

$$\check{\rho} = \frac{1}{3}\operatorname{tr}(\check{R} - \tilde{R} + S) + \delta \tag{7.19}$$

is independent of *x*.

Let us now prove (7.12). By the above and (7.5) for N = 0, we have that

$$|\check{\rho} - \delta| = \frac{1}{3} \left| \operatorname{tr}(\check{R} - \tilde{R} + S) \right| \le \left\| \check{R} - \tilde{R} + S \right\|_0 \le C \lambda^{2\theta + \overline{\alpha} - 1},\tag{7.20}$$

We require now the following condition on λ :

$$C\lambda^{2\theta-1+\overline{\alpha}} \le \delta_0^{\frac{1}{2}} \lambda_0^{2\theta-1+\overline{\alpha}}.$$
(7.21)

Then we notice that, for γ sufficiently small and *a* sufficiently large, we have that

$$\delta_q^{\frac{1}{2}}\lambda_q^{2\theta+\overline{\alpha}-1} \le \frac{1}{4}\delta_{q+1}\zeta_{q+1}^{\gamma}.$$
(7.22)

Indeed, rewriting the above in terms of λ_q , it reads

$$\Lambda^{\frac{1}{2}} \lambda_q^{-\beta+2\theta+\overline{\alpha}-1} \leq \Lambda \lambda_q^{-2b\beta(1+\gamma)}.$$

Since $\Lambda \ge 1$ by (4.3), this reduces to showing that

$$-\beta + 2\theta + \overline{\alpha} - 1 < -2b\beta(1+\gamma). \tag{7.23}$$

and taking *a* sufficiently large. In turn, (7.23) can be proved using that, by assumption, $\theta < \beta, 2b\beta < 1 - \beta$ (see (4.2)), and taking $\overline{\alpha}, \gamma$ sufficiently small. Thus (7.22) is proved. Now from (7.20), (7.21), and (7.22) for a = 0, it follows that

Now from (7.20), (7.21), and (7.22) for q = 0, it follows that

$$|\check{\rho} - \delta| \le \frac{1}{4} \delta_1 \zeta_1^{\gamma} = \frac{1}{4} \Lambda^{-\gamma} \delta^{1+\gamma} \le \frac{1}{4} \delta, \tag{7.24}$$

where in the last inequality we used the fact that $\delta < 1 < \Lambda$. We have thus proved (7.12).

From this estimate we can in turn deduce (7.13). Indeed, since $\check{R} = \check{R} - \check{R} + \check{S}$, by chaining the inequalities (7.5) for N = 0, (7.21), and (7.22) for q = 0, we analogously deduce that:

$$\left|\mathring{\check{R}}\right| \leq \frac{1}{4}\delta_{1}\zeta_{1}^{\gamma} = \frac{1}{4}\Lambda^{-\gamma}\delta^{1+\gamma} \leq \left(\frac{3}{4}\right)^{1+\gamma}\delta^{1+\gamma}\Lambda^{-\gamma} \leq \check{\rho}^{1+\gamma}\Lambda^{-\gamma} \leq \Lambda\check{\varrho}^{1+\gamma}.$$

The bound (7.14) follows from (7.3) together with the following condition on λ :

$$C\lambda^{-1} \le \delta\lambda_0^{-1}.\tag{7.25}$$

To obtain (7.15), we first use standard interpolation estimates together with (7.4) to obtain that

$$\|\check{\mathbf{v}}\|_{1+\alpha} \leq C_I \|\check{\mathbf{v}}\|_1^{1-\alpha} \|\check{\mathbf{v}}\|_2^{\alpha} \leq C_I C \lambda^{1+\alpha}.$$

Therefore, (7.15) reduces to the following condition on λ :

$$CC_I \lambda^{1+\alpha} \le \delta_0^{\frac{1}{2}} \lambda_0^{1+\alpha}, \tag{7.26}$$

The estimate (7.16) follows from (7.6) and (7.19), giving

$$\partial_t \check{\rho} | = \frac{1}{3} \left| \partial_t \operatorname{tr}(\check{R} - \tilde{R} + S) \right| \le \frac{C}{3} \lambda^{\overline{\alpha}}.$$

Therefore, (7.16) amounts to

$$\frac{C}{3}\lambda^{\overline{\alpha}} \le \delta\Lambda^{\frac{1}{2}}\lambda_0^{1-\beta}.$$
(7.27)

Since by (7.7) one has that $|\partial_t \check{\mathcal{T}}| \leq C \lambda^{2(\theta+\varepsilon)}$, to obtain (7.17) we require

$$C\lambda^{2(\theta+\varepsilon)} \le \Lambda^{\frac{1}{2}} \delta_0^{\frac{1}{2}} \lambda_0^{\theta+\varepsilon}.$$
(7.28)

Finally, to obtain (7.18), we note that \check{v} is smooth and thus bounded by a constant C_0 , so that, by interpolation and (7.4), we have that

$$\|\breve{v}\|_{\theta+\varepsilon} \leq C_I \|\breve{v}\|_0^{1-\theta-\varepsilon} \|\breve{v}\|_1^{\theta+\varepsilon} \leq C_I C_0^{1-\theta-\varepsilon} (C\lambda)^{\theta+\varepsilon}.$$

Therefore, we will require

$$C_I C_0^{1-\theta-\varepsilon} (C\lambda)^{\theta+\varepsilon} \le \delta_0^{\frac{1}{2}} \lambda_0^{\theta+\varepsilon}.$$
(7.29)

To conclude the proof of the corollary, we now show that, for suitable choices of δ , γ , $\overline{\alpha}$, there exists a λ satisfying conditions (7.21), (7.25), (7.26), (7.27), (7.28), and (7.29).

In particular, for fixed constants $\overline{C}, \overline{K}$ independent of the parameters $a, \delta, b, \overline{\alpha}, \beta$, the following conditions must be satisfied by λ :

(7.33)

$$\lambda \le \overline{C} \Lambda^{\frac{1}{4(\theta+\varepsilon)}} \delta_0^{\frac{1}{4(\theta+\varepsilon)}} \lambda_0^{\frac{1}{2}}$$
(7.34)

$$\lambda \le \overline{C} \delta_0^{\frac{1}{2}(\theta+\varepsilon)^{-1}} \lambda_0 \tag{7.35}$$

First we choose $\delta < 1$, and $\overline{\alpha}, \gamma$ sufficiently small, and then show that, for *a* sufficiently large there exists a λ satisfying all the above inequalities.

First of all, notice that, since $\delta_0 = \delta \lambda_0^{2\beta(b-1)} \gg 1$ if δ is fixed and *a* is sufficiently large, then (7.31) implies (7.30), and (7.32) implies (7.35) independently of the choice of $\alpha > 0$, since $\theta + \varepsilon < \beta < \frac{1}{3} < 1 + \alpha$.

Hence, we are left with showing that (7.31) is compatible with (7.32)-(7.34).

The compatibility of (7.31) and (7.32), independently of $\alpha > 0$, is straightforward, since $\delta_0 \gg 1$ when *a* is sufficiently large.

Inequality (7.33) does not contradict (7.31) provided we choose $\overline{\alpha}$ so small that $\frac{1-\beta}{\overline{\alpha}} > 1$, and then *a* sufficiently large.

The compatibility of (7.31) with (7.34) rewrites as

$$\lambda_0^{rac{1}{2}} \leq rac{\overline{C}\delta}{\overline{K}}\Lambda^{rac{1}{4(heta+arepsilon)}}\delta_0^{rac{1}{4(heta+arepsilon)}}$$

and, inserting the definitions of $\delta_0, \Lambda, \lambda_1$, as

These form a pairwise disjoint decomposition of [0, T]:

$$[0,T] = J_{\underline{n}-1} \cup I_{\underline{n}-1} \cup [J_{\underline{n}} \cup \ldots \cup J_{\overline{n}}] \cup I_{\overline{n}} \cup J_{\overline{n}+1},$$

$$(8.4)$$

and

$$t_{\underline{n}} < T_1 + \frac{5}{3}\tau_q < T_2 - \frac{5}{3}\tau_q < t_{\overline{n}}.$$
(8.5)

Moreover, if $T_1 > 0$, $\underline{n} \ge 1$, otherwise we have both that $\underline{n} = 0$ and that $J_{\underline{n}-1} \cup I_{\underline{n}-1} = \emptyset$. Given a subsolution (v_q, p_q, R_q) with $\rho_q \coloneqq \frac{1}{3} \operatorname{tr} R_q$ and $\varrho_q \coloneqq \Lambda^{-1} \rho_q$, we will define:

$$(\rho_{q,i}, \varrho_{q,i}, \ell_{q,i}) \coloneqq \left(\rho_q(t_i), \varrho_q(t_i), \frac{\varrho_{q,i}^{\frac{1+\gamma}{2}}}{\zeta_q^{\frac{1}{2}} \lambda_q^{1+\alpha} \ell_q^{-\alpha}}\right),$$
(8.6)

where α, γ are the parameters of Section 4. Using (8.11) and assuming $a \gg 1$ is sufficiently large (as in (4.13), depending on α, γ, b), we may ensure that

with some constant M > 0, where

$$\rho_q \coloneqq \frac{1}{3} \operatorname{tr} R_q \qquad \qquad \varrho_q \coloneqq \frac{\rho_q}{\Lambda}.$$

Define $\rho_{q,i}, \varrho_{q,i}, \ell_{q,i}$ *as in* (8.6).

Then, provided $a \gg 1$ is sufficiently large, there exists $(\overline{v}_q, \overline{p}_q, \overline{R}_q)$ solution of (3.1) on [0, T] such that

(8.27)

In terms of energy, we have that

$$\int_{\mathbb{T}^3} \left(\left| \overline{v}_q \right|^2(x,t) + \operatorname{tr} \overline{R}_q(x,t) \right) \mathrm{d}x = \int_{\mathbb{T}^3} \left(\left| v_q \right|^2(x,t) + \operatorname{tr} R_q(x,t) \right) \mathrm{d}x,$$
(8.28)

and the function

$$\mathcal{J}_{g} \coloneqq \iint_{\mathbb{T}^{3} 0}^{T} \left(\left| (-\Delta)^{\frac{\theta}{2}} \overline{v}_{q} \right|^{2} - \left| (-\Delta)^{\frac{\theta}{2}} v_{q} \right|^{2} \right) \mathrm{d}s \mathrm{d}x,$$
$$\left| \partial_{t} \mathcal{J}_{g} \right| \lesssim \Lambda^{\frac{1}{2}} \delta^{\frac{1}{2}}_{q+1} \lambda^{\theta + \varepsilon}_{q+1}, \tag{8.29}$$

satisfies

and therefore

 $|\mathcal{T}_g(t)| \lesssim t\Lambda \overline{\mathbf{Q}}_q^{1+\gamma} \zeta_q^{\frac{1}{2}} \ell_{q,i}^{-N} \ell_q^{-6\alpha} \leq T\Lambda \overline{\mathbf{Q}}_q^{1+\gamma} \zeta_q^{\frac{1}{2}} \ell_{q,i}^{-N} \ell_q^{-6\alpha}.$

Finally, if $2\alpha < \beta\gamma$ *, then*

The proof closely follows the gluing procedure of [13, Section 6], which in turn draws heavily from [4, Sections 3-4]. Recall that the solution is left unchanged outside $[T_1, T_2]$ and the gluing only happens in that interval. More precisely, recalling the decomposition (8.4):

• The gluing procedure is carried out in the interval

Recall also that, since the trace $\rho_q = \frac{1}{3} \operatorname{tr} R_q$ has different lower and upper bounds on $[T_1, T_2]$ (respectively of order δ_{q+2} and δ_{q+1}), mollification with different parameters $\ell_{q,i}$ depending on $\rho_q(t_i)$ on intervals of size τ_q around the points t_i is necessary.

We will also make use of the following estimates.

Lemma 8.1 (Material derivative estimates for subsolutions and potentials). Let (v, p, R), (v', p', R') be two solutions of (3.1), and let $z \coloneqq (-\Delta)^{-1} \operatorname{curl} v, z' \coloneqq (-\Delta)^{-1} \operatorname{curl} v$. Then the following estimates hold for every $N \in \mathbb{N}, \alpha \in (0, 1)$:

$$\begin{aligned} \left\| (\partial_{t} + v \cdot \nabla + (-\Delta)^{\theta})(z' - z) \right\|_{N+\alpha} &\lesssim \left\| z' - z \right\|_{N+\alpha} \|v\|_{1+\alpha} + \left\| z' - z \right\|_{\alpha} \|v\|_{N+1+\alpha} \end{aligned}$$

$$(8.32)$$

$$+ \left\| R' - R \right\|_{N+\alpha}. \tag{8.33}$$

The proof of (8.32) can be found in the proof of [20, Proposition 5.3], whereas that of (8.33) can be found within the proof of [20, Proposition 5.4]. Note that, since the proofs require the Schauder estimates of Lemma 2.5, this result does not hold for $\alpha = 0$.

Proof. (Proposition 8.1)

Step 1: Mollification

Let ϕ be a standard mollification kernel in space and define

$$\begin{aligned} \left\| \mathring{R}_{\ell_{q,i}} \right\|_{N+\alpha} &\lesssim \Lambda \varrho_q^{1+\gamma} \ell_{q,i}^{-N-\alpha} + \delta_q \lambda_q^{2+2\alpha} \ell_{q,i}^{2-N-\alpha} \\ &\lesssim \Lambda \varrho_q^{1+\gamma} \ell_{q,i}^{-N-\alpha} + \Lambda \varrho_{q,i}^{1+\gamma} \ell_{q,i}^{-N} \ell_q^{\alpha} \end{aligned} \tag{8.37}$$

$$\left| \int_{\mathbb{T}^3} \left| v_q \right|^2 - \left| v_{\ell_{q,i}} \right|^2 \mathrm{d}x \right| \lesssim \delta_q \lambda_q^{2+2\alpha} \ell_{q,i}^2 = \Lambda \varrho_{q,i}^{1+\gamma} \ell_q^{2\alpha}.$$
(8.38)

To obtain (8.38), we also use the trivial identity $\int f * \varphi_{\ell} = \int f$ for $f = |v_q|^2$.

Step 2: Gluing procedure

Let $\{I_i\}_{\underline{n} \le i \le \overline{n}}$ be the sequence of intervals corresponding to $[T_1, T_2]$ according to **Definition 8.1** above. We now fix a partition of unity on [0, T]

subordinate to the decomposition (8.4), i.e. $[0,T] = J_{\underline{n}-1} \cup I_{\underline{n}-1} \cup [J_{\underline{n}} \cup \ldots \cup J_{\overline{n}}] \cup I_{\overline{n}} \cup J_{\overline{n}+1}$. More precisely, for each $\underline{n} - 1 \le i \le \overline{n} + 1$, the function $\chi_i \ge 0$ satisfies

where (v_i, p_i) is defined as follows. For $\underline{n} \leq i \leq \overline{n}$ we define (v_i, p_i) as the solution of

and set $(v_i, p_i) = (v_q, p_q)$ for $i = \underline{n} - 1$ and $i = \overline{n} + 1$. Thus, we note first of all that div $\overline{v}_q = 0$, and moreover

Next, we define \overline{R}_q . We have that $\chi_i + \chi_{i+1} = 1$ for $t \in J_i \cup I_i \cup J_{i+1}$, and therefore

for all $\underline{n} - 1 \le i \le \overline{n}$, where we wrote $R_i = 0$ for $\underline{n} \le i \le \overline{n}$ and $R_i = R_q$ otherwise. Thus, recalling the operator \mathcal{R} from **Definition 2.1**, set

-\partial_{t}\chi_{i}\mathcal{R}(v_{i}-v_{i+1}) \\
+\chi_{i}\cdot(1-\chi_{i})(v_{i}-v_{i+1}) & t \in I_{i} \\
0 & t \in J_{i} \cup J_{i+1}
\end{cases}$$

$$\overset{\circ}{R}_{q}^{(2)} \coloneqq \sum_{i=\underline{n}-1}^{\overline{n}+1}\chi_{i}\mathring{R}_{i} = (\chi_{\underline{n}-1}+\chi_{\overline{n}+1})\mathring{R}_{q},$$
(8.41)

and

$$\overline{p}_{q}^{(2)} \coloneqq \sum_{i=\underline{n}-1}^{\overline{n}+1} \chi_{i} \cdot (1-\chi_{i}) \left(|v_{i}-v_{i+1}|^{2} - \oint_{\mathbb{T}^{3}} |v_{i}-v_{i+1}|^{2} \mathrm{d}x \right).$$
(8.42)

Finally, we define

$$\overline{R}_q = \overset{\circ}{\overline{R}}_q^{(1)} + \overset{\circ}{\overline{R}}_q^{(2)} + \overline{\rho}_q \operatorname{Id}, \qquad \overline{p}_q \coloneqq \overline{p}_q^{(1)} + \overline{p}_q^{(2)}, \qquad (8.43)$$

where

$$\overline{\rho}_q \coloneqq \rho_q + \frac{1}{3} \oint_{\mathbb{T}^3} \left(\left| v_q \right|^2 - \left| \overline{v}_q \right|^2 \right) \mathrm{d}x.$$

Define also

$$\mathcal{T}_g(t) \coloneqq \frac{1}{3} \int_{\mathbb{T}^3} \left(\left| (-\Delta)^{\frac{\theta}{2}} v_q \right|^2 - \left| (-\Delta)^{\frac{\theta}{2}} \overline{v}_q \right|^2 \right) \mathrm{d}x.$$

By construction, we have that

Step 3: Stability estimates on classical solutions

Throughout this step and the next, we will assume estimate (8.21), which will be proved in Step 5 below. This estimate will allow us to replace $\overline{\rho}_q$ with ρ_q and viceversa whenever we need to do so in our estimates, since the two are of the same order.

Let us consider for the moment $\underline{n} \le i \le \overline{n}$. We recall the classical existence result for solutions of (8.40) found in [20, Proposition 3.5], by which (v_i, p_i) in (8.39) above is defined at least on an interval of length $\sim ||v_{\ell_{q,i}}||_{1+\alpha}^{-1}$. By (8.35) and (4.11), we have that

Therefore, provided $a \gg 1$ is sufficiently large, v_i is defined on $I_{i-1} \cup J_i \cup I_i$, so that \overline{v}_q in (8.39) is well-defined. Next, we deduce from (8.15) that $|\partial_t \log \rho_q| \le \delta_q^{1/2} \lambda_q = \tau_q^{-1} \ell_q^{4\alpha}$, so that, by assuming $a \gg 1$ is sufficiently large, we may ensure that

(8.46)

Combining this with **Proposition 2.2**, working first for the case N = 0, then for N = 1, and finally for the general case, yields

The Grönwall inequality then implies that

By (8.21), this is equivalent to (8.17). The case N = 1 of (8.47) leads to

Combining the above estimate with (8.13) outside the gluing region and in $I_{\underline{n}-1} \cup I_{\overline{n}}$, and with (8.35) in $J_{\underline{n}} \cup I_{\underline{n}} \cup ... \cup I_{\overline{n}-1} \cup J_{\overline{n}}$, we deduce that (8.18) is verified. More generally, as we did above for N = 0, we deduce from (8.35) and (8.47) that

We have used the fact that $\ell_{q,i} \sim \ell_{q,i+1} \sim \ell_{q,i-1}$. The above inequality coincides with (8.24).

We also remark the following simple interpolation of the N = 0 and N = 1 cases of (8.47), which will be used in Step 5 below.

Further in the proof, we will need estimates for $||v_i - v_{i+1}||_{N+\alpha}$ and $||(\partial_t + v_{\ell_{q,i}} \cdot \nabla)(v_i - v_{i+1})||_{N+\alpha}$. Concerning the former, by applying the triangle inequality, we see that

The term *IV* is handled similarly. Since $v_{\ell_{q,i}} - v_{\ell_{q,i+1}}$ obeys the bound (8.50), using Lemma 8.1 we conclude that *II* also obeys the above bound. We now consider *III*, which can be estimated as follows:

$$III = \left\| (v_{\ell_{q,i}} - v_{\ell_{q,i+1}}) \cdot \nabla (v_{i+1} - v_{\ell_{q,i+1}}) \right\|_{N+\alpha} \lesssim \Lambda^{\frac{1}{2}} \varrho_{q,i}^{\frac{1+\gamma}{2}} \ell_{q,i}^{\alpha} \cdot \Lambda^{\frac{1}{2}} \varrho_{q,i}^{\frac{1+\gamma}{2}} \ell_{q,i}^{\alpha} \cdot \ell_{q,i}^{-N-1} = \Lambda \varrho_{q,i}^{1+\gamma} \ell_{q,i}^{2\alpha-N-1},$$

in particular satisfying the bound (8.51). We thus conclude that

$$\left\| (\partial_t + v_{\ell_{q,i}} \cdot \nabla) (v_i - v_{i+1}) \right\|_{N+\alpha} \lesssim \Lambda \varrho_{q,i}^{1+\gamma} \ell_{q,i}^{-1-N-\alpha} = \Lambda^{\frac{1}{2}} \varrho_{q,i}^{\frac{1+\gamma}{2}} \tau_q^{-1} \ell_q^{3\alpha} \lambda_q^{\alpha} \ell_{q,i}^{-N-\alpha}.$$
(8.52)

Step 4: Estimates on the new Reynolds stress

As is done in [4, Section 3.3], we define the vector potentials

$$z_i \coloneqq (-\Delta)^{-1} \operatorname{curl} v_i \qquad z_{\ell_{q,i}} \coloneqq (-\Delta)^{-1} \operatorname{curl} v_{\ell_{q,i}}, \qquad z_q \coloneqq (-\Delta)^{-1} \operatorname{curl} v_q$$

and, by a combination of **Lemma 8.1**, **Proposition 2.2**, and the Grönwall inequality similar to the one used to obtain (8.47) in Step 3 above, obtain that

$$\left\|z_{i}-z_{\ell_{q,i}}\right\|_{N+\alpha} \lesssim \Lambda \tau_{q} \varrho_{q,i}^{1+\gamma} \ell_{q,i}^{-N} \ell_{q}^{-\alpha}.$$
(8.53)

Combining this with Lemma 8.1 yields

$$\left\| (\partial_t + v_{\ell_{q,i}} \cdot \nabla + (-\Delta)^{\theta}) (z_i - z_{\ell_{q,i}}) \right\|_{N+\alpha} \lesssim \Lambda \varrho_{q,i}^{1+\gamma} \ell_{q,i}^{-N} \ell_q^{-\alpha}.$$
(8.54)

By (8.8) and the Schauder estimates of Lemma 2.5, we deduce that

$$\left\| (-\Delta)^{\theta} (z_i - z_{\ell_{q,i}}) \right\|_{N+\alpha} \lesssim \left\| z_i - z_{\ell_{q,i}} \right\|_{N+\alpha+2\theta+\varepsilon} \lesssim \left\| v_i - v_{\ell_{q,i}} \right\|_{N+\alpha-1+2\theta+\varepsilon}$$
$$\lesssim \Lambda \tau_q \varrho_{q,i}^{1+\gamma} \ell_{q,i}^{-N-2\theta-\varepsilon} \ell_q^{-\alpha} \lesssim \Lambda \varrho_{q,i}^{1+\gamma} \ell_{q,i}^{-N} \ell_q^{-\alpha}.$$
(8.55)

By the triangle inequality, (8.55), and (8.54), we thus conclude that

$$\left\| (\partial_t + v_{\ell_{q,i}} \cdot \nabla) (z_i - z_{\ell_{q,i}}) \right\|_{N+\alpha} \lesssim \Lambda \varrho_{q,i}^{1+\gamma} \ell_{q,i}^{-N} \ell_q^{-\alpha}.$$

Both (8.53) and (8.56) are valid in $I_{i-1} \cup J_i \cup I_i$ for any $\underline{n} \leq i \leq \overline{n}$.

The sequel of this proof will require estimates on $z_i - z_{i+1}$, which means we must now bound $z_{\ell_{q,i}} - z_{\ell_{q,i+1}}$. We note that $z_{\ell_{q,i}} = z_q * \varphi_{\ell_{q,i+1}} = z_q * \varphi_{\ell_{q,i+1}}$, so that, using (2.5) and Schauder estimates (Lemma 2.5), we get

The final estimate for $z_i - z_{i+1}$ is thus

$$\|z_{i} - z_{i+1}\|_{N+\alpha} \le \|z_{i} - z_{\ell_{q,i}}\|_{N+\alpha} + \|z_{\ell_{q,i}} - z_{\ell_{q,i+1}}\|_{N+\alpha} + \|z_{\ell_{q,i+1}} - z_{i+1}\|_{N+\alpha} \le \Lambda \varrho_{q,i}^{1+\gamma} \tau_{q} \ell_{q,i}^{-N} \ell_{q}^{-2\alpha} \lambda_{q}^{-\alpha}, \quad (8.58)$$

slightly coarser than (8.53) above. As for the material derivatives, we must estimate

$$\begin{aligned} \left\| (\partial_{t} + v_{\ell_{q,i}} \cdot \nabla)(z_{i} - z_{i+1}) \right\|_{N+\alpha} &\leq \left\| (\partial_{t} + v_{\ell_{q,i}} \cdot \nabla)(z_{i} - z_{\ell_{q,i}}) \right\|_{N+\alpha} \\ &+ \left\| (\partial_{t} + v_{\ell_{q,i}} \cdot \nabla)(z_{\ell_{q,i}} - z_{\ell_{q,i+1}}) \right\|_{N+\alpha} \\ &+ \left\| (v_{\ell_{q,i}} - v_{\ell_{q,i+1}}) \cdot \nabla(z_{\ell_{q,i+1}} - z_{i+1}) \right\|_{N+\alpha} \\ &+ \left\| (\partial_{t} + v_{\ell_{q,i+1}} \cdot \nabla)(z_{\ell_{q,i+1}} - z_{i+1}) \right\|_{N+\alpha} \\ &=: I + II + III + IV. \end{aligned}$$

The terms I and IV are estimated by (8.56). To estimate *II*, we apply Lemma 8.1 to $(v_{\ell_{q,i}}, p_{\ell_{q,i}}, R_{\ell_{q,i}})$ and $(v_{\ell_{q,i+1}}, p_{\ell_{q,i+1}}, R_{\ell_{q,i+1}})$ and use (8.35) and (8.57), obtaining that

$$\left\| (\partial_t + v_{\ell_{q,i}} \cdot \nabla + (-\Delta)^{\theta}) (z_{\ell_{q,i}} - z_{\ell_{q,i+1}}) \right\|_{N+\alpha} \lesssim \rho_{q,i}^{1+\gamma} \ell_{q,i}^{-N-\alpha} (\ell_{q,i}^{\alpha} \ell_q^{2\alpha} + 1).$$

We then note that, by interpolation

$$\left\| (-\Delta)^{\theta} (z_{\ell_{q,i}} - z_{\ell_{q,i+1}}) \right\|_{N+\alpha} \lesssim \Lambda \tau_q \mathbf{Q}_{q,i}^{1+\gamma} \ell_{q,i}^{-N-2\theta-\varepsilon} \ell_q^{-2\alpha} \lambda_q^{-\alpha} \lesssim \Lambda \mathbf{Q}_{q,i}^{1+\gamma} \ell_{q,i}^{-N} \ell_q^{-2\alpha} \lambda_q^{-\alpha}.$$

The above two bounds combine to yield

$$II \lesssim \Lambda \varrho_{q,i}^{1+\gamma} \ell_{q,i}^{-N} \ell_q^{-2\alpha} \lambda_q^{-\alpha}.$$
(8.59)

Coming to *III*, we estimate it by combining (8.53) with (8.50):

$$\left\| (v_{\ell_{q,i}} - v_{\ell_{q,i+1}}) \cdot \nabla(z_{i+1} - z_{\ell_{q,i+1}}) \right\|_{N+\alpha} \lesssim \Lambda^{\frac{1}{2}} \mathbf{Q}_{q,i}^{\frac{1+\gamma}{2}} \ell_{q,i}^{\alpha} \cdot \Lambda \tau_{q} \mathbf{Q}_{q,i}^{1+\gamma} \ell_{q}^{-\alpha} \cdot \ell_{q,i}^{-N-1}$$

$$\leq \Lambda \mathbf{Q}_{q,i}^{1+\gamma} \ell_{q,i}^{\alpha-N}.$$
(8.60)

Combining (8.56), (8.59), and (8.60), we thus obtain that

$$\left\| (\partial_t + v_{\ell_{q,i}} \cdot \nabla)(z_i - z_{I+1}) \right\|_{N+\alpha} \lesssim \Lambda \varrho_{q,i}^{1+\gamma} \ell_{q,i}^{-N} \ell_q^{-2\alpha} \lambda_q^{-\alpha}.$$
(8.61)

Recalling the expression for $\dot{\overline{R}}_q$ in (8.43), using (8.45), (8.58), and (8.50), we obtain, as in the proof of [4, Proposition 4.3], that

$$\begin{split} \left\| \ddot{R}_{q} \right\|_{N+\alpha} &\lesssim \tau_{q}^{-1} \| z_{i} - z_{i+1} \|_{N+\alpha} + \| v_{i} - v_{i+1} \|_{N+\alpha} \| v_{i} - v_{i+1} \|_{\alpha} \\ &\lesssim \Lambda \varrho_{q,i}^{1+\gamma} \ell_{q,i}^{-N} \ell_{q}^{-2\alpha} \lambda_{q}^{-\alpha} + \Lambda^{\frac{1}{2}} \varrho_{q,i}^{\frac{1+\gamma}{2}} \ell_{q,i}^{-N+\alpha} \cdot \Lambda^{\frac{1}{2}} \varrho_{q,i}^{\frac{1+\gamma}{2}} \ell_{q,i}^{\alpha} \\ &\lesssim \Lambda \varrho_{q,i}^{1+\gamma} \ell_{q,i}^{-N} \ell_{q}^{-\alpha} (\ell_{q}^{-\alpha} \lambda_{q}^{-\alpha} + \ell_{q,i}^{3\alpha}). \end{split}$$

This, together with (8.21), gives us (8.25). As for (8.26), we note that

$$\begin{split} \left\| (\partial_{t} + \overline{v}_{q} \cdot \nabla) \overset{\circ}{\overline{R}}_{q} \right\|_{N+\alpha} &\lesssim \tau_{q}^{-2} \| z_{i} - z_{i+1} \|_{N+\alpha} + \tau_{q}^{-1} \| (\partial_{t} + v_{\ell_{q,i}} \cdot \nabla) (z_{i} - z_{i+1}) \|_{N+\alpha} + \\ &+ \tau_{q}^{-1} \| v_{\ell_{q,i}} \|_{1+\alpha} \| z_{i} - z_{i+1} \|_{N+\alpha} + \tau_{q}^{-1} \| v_{\ell_{q,i}} \|_{N+1+\alpha} \| z_{i} - z_{i+1} \|_{\alpha} \\ &+ \tau_{q}^{-1} \| v_{i} - v_{i+1} \|_{N+\alpha} \| v_{i} - v_{i+1} \|_{\alpha} \\ &+ \| (\partial_{t} + v_{\ell_{q,i}} \cdot \nabla) (v_{i} - v_{i+1}) \|_{N+\alpha} \| v_{i} - v_{i+1} \|_{\alpha} \\ &+ \| (\partial_{t} + v_{\ell_{q,i}} \cdot \nabla) (v_{i} - v_{i+1}) \|_{\alpha} \| v_{i} - v_{i+1} \|_{N+\alpha} \\ &+ \| (v_{\ell_{q,i}} - \overline{v}_{q}) \cdot \nabla \overset{\circ}{\overline{R}}_{q} \|_{N+\alpha}. \end{split}$$

Combining the above bound on $\hat{\overline{R}}_q$ with (8.58), (8.61), (8.35), (8.50), (8.52), and the bound (8.48) applied to $v_{\ell_{q,i}} - \overline{v}_q$, we obtain that

$$\left\| \left(\partial_t + \overline{\nu}_q \cdot \nabla\right) \hat{\overline{R}}_q \right\|_{N+\alpha} \lesssim \Lambda \tau_q^{-1} \varrho_{q,i}^{1+\gamma} \ell_{q,i}^{-N} \ell_q^{-2\alpha} \lambda_q^{-\alpha}, \tag{8.62}$$

which yields (8.26) once combined with (8.21).

Step 5: $\overline{\rho}_q$, \mathcal{T}_g , and (8.30)

Next, we estimate $\overline{\rho}_q$, recalling its definition in (8.44). We wish to estimate $\overline{\rho}_q - \rho_q$. We note that

$$\left\|\overline{\rho}_{q}-\rho_{q}\right\|_{0}=\frac{1}{3}\left|\int_{\mathbb{T}^{3}}\left|\overline{v}_{q}\right|^{2}-\left|v_{q}\right|^{2}dx\right|\leq\left|\int_{\mathbb{T}^{3}}\left|\overline{v}_{q}\right|^{2}-\left|v_{\ell_{q,i}}\right|^{2}dx\right|+\left|\int_{\mathbb{T}^{3}}\left|v_{\ell_{q,i}}\right|^{2}-\left|v_{q}\right|^{2}dx\right|.$$

The second term above is already estimated by (8.38), so we proceed to estimate the first term. As in [4, Proposition 4.4], one has that

$$\begin{aligned} \left|\overline{v}_{q}\right|^{2} - \left|v_{\ell_{q,i}}\right|^{2} &= \chi_{i}(|v_{i}|^{2} - |v_{\ell_{q,i}}|^{2}) + (1 - \chi_{i})(|v_{i+1}|^{2} - |v_{\ell_{q,i+1}}|^{2}) \\ &+ (1 - \chi_{i})(|v_{\ell_{q,i+1}}|^{2} - |v_{\ell_{q,i}}|^{2}) - \chi_{i}(1 - \chi_{i})|v_{i} - v_{i+1}|^{2}. \end{aligned}$$

Therefore

$$\left| \int_{\mathbb{T}^{3}} \left| \overline{v}_{q} \right|^{2} - \left| v_{\ell_{q,i}} \right|^{2} dx \right| \leq \left| \int_{\mathbb{T}^{3}} \left| v_{i} \right|^{2} - \left| v_{\ell_{q,i}} \right|^{2} dx \right| + \left| \int_{\mathbb{T}^{3}} \left| v_{i+1} \right|^{2} - \left| v_{\ell_{q,i+1}} \right|^{2} dx \right| + \left| \int_{\mathbb{T}^{3}} \left| v_{i} - v_{i+1} \right|^{2} dx \right| + \left| \int_{\mathbb{T}^{3}} \left| v_{\ell_{q,i}} \right|^{2} - \left| v_{\ell_{q,i+1}} \right|^{2} dx \right| + \left| \int_{\mathbb{T}^{3}} \left| v_{i} - v_{i+1} \right|^{2} dx \right|.$$
(8.63)

We start by estimating the fourth term as follows by using (8.50):

$$\left| \int_{\mathbb{T}^3} |v_i - v_{i+1}|^2 \mathrm{d}x \right| \le \|v_i - v_{i+1}\|_{\alpha}^2 \lesssim \Lambda \varrho_{q,i}^{1+\gamma} \ell_q^{2\alpha}.$$
(8.64)

We then proceed to estimate the third term in (8.63) by using the triangle inequality, (8.38), and the fact $Q_{q,i} \sim Q_{q,i+1}$:

\lesssim \Lambda \varrho_{q,i}^{1+\gamma} \ell_{q}^{2\alpha}.$$
(8.65)

The first and second terms in (8.63) are estimated in similar ways, so we only estimate the former. To that end, we proceed in a way similar to [20, Proposition 5.5]. We start by using the fact that $(v_i, p_i, 0)$ and $(v_{\ell_{q,i}}, p_{\ell_{q,i}}, \mathring{R}_{\ell_{q,i}})$ are subsolutions, **Theorem 2.1**, (8.35) and (8.37), and (8.36) and (8.49), to obtain that

$$\begin{aligned} \left| \frac{\mathrm{d}}{\mathrm{d}t} \int_{\mathbb{T}^3} |v_i|^2 - |v_{\ell_{q,i}}|^2 \mathrm{d}x \right| &\leq 2 \left(\left| \int_{\mathbb{T}^3} \mathfrak{D} v_{\ell_{q,i}} : \mathring{R}_{\ell_{q,i}} \mathrm{d}x \right| + \left| \int_{\mathbb{T}^3} \left| (-\Delta)^{\frac{\theta}{2}} v_i \right|^2 - \left| (-\Delta)^{\frac{\theta}{2}} v_{\ell_{q,i}} \right|^2 \mathrm{d}x \right| \right) \\ &\lesssim \left\| v_{\ell_{q,i}} \right\|_{1+\alpha} \left\| \mathring{R}_{\ell_{q,i}} \right\|_{\alpha} + \left\| v_i + v_{\ell_{q,i}} \right\|_{\theta+\varepsilon} \left\| v_i - v_{\ell_{q,i}} \right\|_{\theta+\varepsilon} \\ &\lesssim \delta_q^{\frac{1}{2}} \lambda_q^{1+\alpha} \cdot \Lambda \varrho_{q,i}^{1+\gamma} \ell_{q,i}^{-\alpha} + \Lambda^{\frac{1}{2}} \cdot \Lambda \varrho_{q,i}^{1+\gamma} \tau_q \ell_{q,i}^{-\theta-\varepsilon-1-\alpha} \\ &= \Lambda \varrho_{q,i}^{1+\gamma} \tau_q^{-1} \ell_q^{2\alpha} (F_1 + F_2), \end{aligned}$$

where we write

$$F_{1} \coloneqq \delta_{q}^{\frac{1}{2}} \lambda_{q}^{1+\alpha} \ell_{q,i}^{-\alpha} \tau_{q} \ell_{q}^{-2\alpha}$$

$$F_{2} \coloneqq \Lambda^{\frac{1}{2}} \tau_{q}^{2} \ell_{q}^{-2\alpha} \ell_{q,i}^{-1-\theta} \ell_{q,i}^{-\varepsilon-\alpha}.$$

It is easy to see that

$$F_1 = \ell_q^{4\alpha} \lambda_q^{\alpha} \ell_{q,i}^{-\alpha} \ell_q^{-2\alpha} \lesssim 1.$$

To prove that F_2 is also bounded above by a constant, we note that

$$F_2 = f(\alpha, \varepsilon, \gamma) \frac{\Lambda^{\frac{1}{2}}}{\delta_q \lambda_q^2} \frac{(\zeta_q^{\frac{1}{2}} \lambda_q)^{1+\theta}}{\varrho_{q,i}^{\frac{1+\theta}{2}}},$$

where $f(\alpha, \varepsilon, \gamma) \sim 1$ for $\alpha, \gamma, \varepsilon \ll 1$. We then observe that (8.10), together with the fact that $\theta < \frac{1}{3}, b > 1$, implies that

We have thus proved that

$$\left| \int_{\mathbb{T}^3} \left| \overline{v}_q \right|^2 - \left| v_{\ell_{q,i}} \right|^2 \mathrm{d}x \right| \lesssim \Lambda \varrho_{q,i}^{1+\gamma} \ell_q^{2\alpha}.$$
(8.67)

Estimates (8.67) and (8.38) imply

$$\left| \int_{\mathbb{T}^3} \left| \overline{v}_q \right|^2 - \left| v_q \right|^2 \mathrm{d}x \right| \lesssim \Lambda \varrho_{q,i}^{1+\gamma} \ell_q^{2\alpha}.$$

This proves in particular that $\overline{\rho}_q \sim \rho_q$ and (8.21), as well as (8.23).

Similarly, using (3.1) for (v_q, p_q, R_q) and $(v_{\ell_{q,i}}, p_{\ell_{q,i}}, \mathring{R}_{\ell_{q,i}})$ first, and for $(\overline{v}_q, \overline{p}_q, \overline{R}_q)$ and $(v_{\ell_{q,i}}, p_{\ell_{q,i}}, R_{\ell_{q,i}})$ afterwards, we also deduce that

$$\frac{\mathrm{d}}{\mathrm{d}t} \int_{\mathbb{T}^3} \left| v_{\ell_{q,i}} \right|^2 - \left| v_q \right|^2 \mathrm{d}x \right| \lesssim \Lambda \varrho_{q,i}^{1+\gamma} \tau_q^{-1} \ell_q^{2\alpha}$$
(8.68)

$$\left| \frac{\mathrm{d}}{\mathrm{d}t} \int_{\mathbb{T}^3} \left| \overline{\nu}_q \right|^2 - \left| \nu_{\ell_{q,i}} \right|^2 \mathrm{d}x \right| \lesssim \Lambda \varrho_{q,i}^{1+\gamma} \tau_q^{-1} \ell_q^{2\alpha}.$$
(8.69)

Combining (8.68) and (8.69), we get

$$\partial_t \overline{\rho}_q - \partial_t \rho_q \Big| \lesssim \Lambda \varrho_{q,i}^{1+\gamma} \tau_q^{-1} \ell_q^{2\alpha}.$$
(8.70)

To prove (8.22) note that

$$\Lambda \mathbf{Q}_{q,i}^{1+\gamma} \mathbf{\tau}_q^{-1} \ell_q^{2\alpha} \lesssim \rho_q \delta_q^{\frac{1}{2}} \lambda_q \cdot \lambda_{q+1}^{2\alpha-2\beta\gamma} \lesssim \rho_q \delta_q^{\frac{1}{2}} \lambda_q,$$

where we used the definitions of τ_q , ζ_{q+1} , (8.11), the relations $\ell_q^{-1} \leq \lambda_{q+1}$ and $\Lambda \varrho_{q,i} = \rho_{q,i} \sim \rho_q$, and the fact that $\alpha < \alpha b < \beta \gamma$, which follows from (8.9) since b > 1. Therefore, since we showed above that $\overline{\rho}_q \sim \rho_q$, we have (8.22).

It remains to estimate $\|\mathring{R}_q\|_0$ on $[T_1, T_2]$ in order to verify (8.20) for the Reynolds stress. We already obtained (8.25) on $J_{\underline{n}} \cup \ldots \cup J_{\overline{n}}$ (recall the decomposition (8.4)). Moreover, on $J_{\underline{n}-1} \cup J_{\overline{n}+1}$ the subsolution remains unchanged, so there is nothing to prove. We are then left with the task of proving (8.20) on the cut-off regions I_{n-1} and $I_{\overline{n}}$.

To do so, we need to estimate $||v_i - v_q||_{\alpha}$ and $||z_i - z_q||_{\alpha}$. For the former, we combine estimates of $v_i - v_{\ell_{q,i}}$ and of $v_{\ell_{q,i}} - v_q$. For the latter, we only need to estimate $||z_{\ell_{q,i}} - z_q||_{\alpha}$, since we already handled $z_i - z_{\ell_{q,i}}$ above. One has that, by (2.5), Lemma 2.5 (Schauder estimates), and (8.13)

$$\left\|z_{\ell_{q,i}}-z_q\right\|_{\alpha} \lesssim \left\|z_q\right\|_{2+\alpha} \ell_{q,i}^2 \lesssim \left\|\operatorname{curl} v_q\right\|_{\alpha} \ell_{q,i}^2 \lesssim \delta_q^{\frac{1}{2}} \lambda_q^{1+\alpha} \ell_{q,i}^2 = \Lambda \tau_q \varrho_{q,i}^{1+\gamma} \ell_q^{-2\alpha} \lambda_q^{-\alpha},$$

which gives us (8.20) as desired.

We then have to verify (8.19) and (8.29). To that end, we observe that

$$\left\|\overline{v}_{q}\right\|_{\theta+\varepsilon} \leq \left\|\overline{v}_{q}-v_{q}\right\|_{\theta+\varepsilon}+\left\|v_{q}\right\|_{\theta+\varepsilon}.$$

The second term is estimated by (8.14). As for the first one, we note that

$$\left\|\overline{v}_{q}-v_{q}\right\|_{\alpha} \lesssim \Lambda^{\frac{1}{2}} \overline{\varrho}_{q}^{\frac{1+\gamma}{2}} \ell_{q}^{\alpha} \lesssim \delta_{q+1}^{\frac{1}{2}} \zeta_{q+1}^{\frac{\gamma}{2}} \ell_{q}^{\alpha} \leq \delta_{q+1}^{\frac{1}{2}} \ell_{q}^{\alpha},$$

where the first step is due to (8.48). We can thus estimate $\|\overline{v}_q - v_q\|_{\theta+\varepsilon}$ by interpolation:

$$\begin{split} \left\|\overline{v}_{q}-v_{q}\right\|_{\theta+\varepsilon} &\lesssim \left\|\overline{v}_{q}-v_{q}\right\|_{\alpha}^{1-\theta-\varepsilon} \left\|\overline{v}_{q}-v_{q}\right\|_{1+\alpha}^{\theta+\varepsilon} \lesssim (\delta_{q+1}^{\frac{1}{2}}\ell_{q}^{\alpha})^{1-\theta-\varepsilon} \cdot \left(\delta_{q}^{\frac{1}{2}}\lambda_{q}^{1+\alpha}\right)^{\theta+\varepsilon} \\ &\leq \delta_{q+1}^{\frac{1}{2}}\lambda_{q+1}^{\theta+\varepsilon} \cdot \ell_{q}^{\alpha(1-2\theta-2\varepsilon)}. \end{split}$$

Lastly

$$\left|\partial_{t}\mathcal{J}_{g}\right| = \left|\int_{\mathbb{T}^{3}} \left|(-\Delta)^{\frac{\theta}{2}}\overline{v}_{q}\right|^{2} - \left|(-\Delta)^{\frac{\theta}{2}}v_{q}\right|^{2} \mathrm{d}x\right| \lesssim \left\|\overline{v}_{q} + v_{q}\right\|_{\theta+\varepsilon} \left\|\overline{v}_{q} - v_{q}\right\|_{\theta+\varepsilon} \lesssim \Lambda^{\frac{1}{2}} \delta^{\frac{1}{2}}_{q+1} \lambda^{\theta+\varepsilon}_{q+1}$$

thus proving (8.29).

We conclude the proof by obtaining (8.30). To that end, we first note that (8.21) and (8.11) combine to give us $\overline{\varrho}_q \leq \zeta_{q+1}$. Combining this with (8.17), we conclude that

$$\left\|\overline{v}_{q}-v_{q}\right\|_{\alpha}\lesssim\delta_{q+1}^{\frac{1}{2}}\zeta_{q+1}^{\frac{\gamma}{2}}\ell_{q}^{\alpha}$$

thus reducing (8.30) to

$$\lambda_{q+1}^{-\beta\gamma}\ell_q^{(\frac{1}{2}-\frac{2}{b})\alpha} \lesssim 1$$

Since $\ell_q^{-1} \leq \lambda_{q+1}$, the above follows from

$$-\beta\gamma + \frac{2}{b}\alpha - \frac{1}{2}\alpha < 0 \iff \alpha < \frac{2b\beta\gamma}{4-b}.$$

We recall that we wish to obtain (8.30) only under the assumption $2\alpha < \beta\gamma$. This means the above relation follows from

$$\frac{2b}{4-b} > \frac{1}{2} \iff 5b > 4,$$

which in turn follows from b > 1. The proof is thus complete.

Remark 8.1 (Multi-gluing). *Proposition 8.1* can easily be extended to a pairwise disjoint union of intervals $[T_1^{(i)}, T_2^{(i)}] \subset [0,T]$ with $T_2^{(i)} - T_1^{(i)} \ge 4\tau_q$ and $T_2^{(i)} < T_1^{(i+1)}$.

9 Perturbation step

Proposition 9.1 (Main Perturbation Step). Let $b, \beta, \alpha, \gamma, (\delta_q, \lambda_q, \Lambda, \zeta_q, \ell_q, \tau_q)$ be as in Section 4 with

on $K_i := [(i-1+\frac{1}{3})\tau_q, (i+\frac{2}{3})\tau_q]$ for $\underline{n}-1 \le i \le \overline{n}+1$, where the $\ell_{q,i}$ are defined as in (8.6), and C_P is a geometric constant. Further, let $\psi : [0,T] \to [0,1]$ be a cutoff function and $S_{\psi} \in C^{\infty}(\mathbb{T}^3 \times [T_1,T_2]; S^{3\times 3})$ be a smooth matrix field with

$$S_{\psi}(x,t) = \sigma_{\psi}(t) \operatorname{Id} + \check{S}_{\psi}(x,t) = \Lambda \varsigma_{\psi}(t) \operatorname{Id} + \check{S}_{\psi}(x,t),$$

where $\mathring{S}_{\psi} = \psi^2 \mathring{S}$ is traceless, $\sigma_{\psi} = \psi^2 \sigma$, and $(\varsigma, \varsigma_{\psi}) \coloneqq \Lambda^{-1}(\sigma, \sigma_{\psi})$. Suppose ψ satisfies

$$\|v\|_{N+1+\alpha} \lesssim \delta_q^{\frac{1}{2}} \lambda_q^{1+\alpha} \ell_{q,i}^{-N} \tag{9.11}$$

$$\|v\|_{\theta+\varepsilon} \le M\left(1 + \sum_{i=0}^{q+1} \Lambda^{\frac{1}{2}} \lambda_i^{\theta+\varepsilon-\beta}\right)$$
(9.12)

Then, provided $a \gg 1$ is sufficiently large (depending on the implicit constants in (9.9), (9.10), (9.11), and (9.13)), there exist smooth $(\tilde{v}, \tilde{p}) \in C^{\infty}(\mathbb{T}^3 \times [T_1, T_2]; \mathbb{R}^3 \times \mathbb{R})$ and a smooth matrix field $\mathcal{E} \in C^{\infty}(\mathbb{T}^3 \times [T_1, T_2]; \mathcal{E}^{3 \times 3})$ with supp $\mathcal{E} \subset$ supp S such that, setting $\tilde{R}_1 \coloneqq R - S_{\Psi} - \mathcal{E}$, the triple $(\tilde{v}, \tilde{p}, \tilde{R})$ is a strong subsolution with

Moreover, we have the estimates

$$\|\tilde{v} - v\|_{H^{-1}} \le \frac{M}{2} \delta_{q+1}^{\frac{1}{2}} \ell_{q,i}^{-1} \lambda_{q+1}^{-1}$$
(9.16)

$$\|\tilde{v} - v\|_0 \le \frac{M}{2} \delta_{q+1}^{\frac{1}{2}}$$
(9.17)

$$\|\tilde{v} - v\|_{1+\alpha} \le \frac{M}{2} \delta_{q+1}^{\frac{1}{2}} \lambda_{q+1}^{1+\alpha}$$
(9.18)

$$\|\tilde{v} - v\|_{\theta + \varepsilon} \le M\delta_{q+1}^{\frac{1}{2}}\lambda_{q+1}^{\theta + \varepsilon},\tag{9.19}$$

and the error \mathcal{E} satisfies the estimates

$$\|\mathcal{E}\|_0 \le \delta_{q+2} \lambda_{q+1}^{-6\alpha} \tag{9.20}$$

$$|\partial_t \operatorname{tr} \mathcal{E}| \le \delta_{q+2} \delta_{q+1}^{\frac{1}{2}} \lambda_{q+1}^{1-6\alpha}.$$

Finally, setting

$$\begin{aligned} \mathcal{T}_p(t) &\coloneqq \frac{1}{3} \int_0^t \int_{\mathbb{T}^3} \left(\left| (-\Delta)^{\frac{\theta}{2}} \tilde{v} \right|^2 - \left| (-\Delta)^{\frac{\theta}{2}} v \right|^2 \right) \mathrm{d}x \mathrm{d}s \\ &= \frac{1}{3} \int_0^t \int_{\mathbb{T}^3} \left((-\Delta)^{\frac{\theta}{2}} (\tilde{v} + v) \cdot (-\Delta)^{\frac{\theta}{2}} (\tilde{v} - v) \right) \mathrm{d}x \mathrm{d}s, \end{aligned}$$

we have that

$$|\partial_t \mathcal{J}_p| \lesssim \Lambda \lambda_q^{\theta + \varepsilon - \beta},\tag{9.22}$$

for any $\varepsilon > 0$. Thus, \mathcal{T}_p Id satisfies (9.21) for all $t \in [0,T]$, and (9.20) only for small times.

The proof extends [13, Section 7], which is a localization of the argument carried out in [4, Section 5]. The difference between [13] and [4] is that the latter absorbs the whole R with the perturbation flow, whereas the former, as well as the proof below, aims to only absorb *S*. *Proof.*

$$\exists c_0 > 0: \quad \sum_{i} \int_{\mathbb{T}^3} \eta_i^2(x, t) dx \ge c_0 \quad \forall t \in [0, T]$$
(9.27)

$$\left\|\partial_t^N \eta_i\right\|_m \le C(N,m)\tau_q^{-N} \qquad N,m \ge 0,\tag{9.28}$$

where the c_0 in (9.27) is a geometric constant. Define

$$\sigma_i(x,t) \coloneqq \big| \mathbb{T}^3 \big| \frac{\eta_i^2(x,t)}{\sum_j \int \eta_j^2(y,t) \mathrm{d}y} \sigma_{\Psi}(t),$$

so that $\sum_i \int_{\mathbb{T}^3} \sigma_i dx = \int_{\mathbb{T}^3} \sigma_{\psi} dx$. Using the inverse flow Φ_i starting at time t_i

One can check from (9.27)-(9.28) and from (9.7) and (9.8) that

We next claim that for all (x, t)

$$\tilde{S}_i(x,t) \in B_{\frac{1}{2}}(\mathrm{Id}) \subset \mathcal{S}_+^{3 \times 3}, \tag{9.32}$$

where $B_{\frac{1}{2}}(\text{Id})$ is the ball of radius $\frac{1}{2}$ centered at the identity Id in $\mathcal{S}^{3\times 3}$. Indeed, by the classical estimates on transport equations reported in **Proposition 2.1**

$$\left\|\frac{\eta_i^2 \mathring{S}_{\Psi}}{\sigma_i}\right\|_N \lesssim \left\|\frac{\mathring{S}}{\sigma}\right\|_N \lesssim \varsigma^{\gamma} \ell_{q,i}^{-N} \ell_q^{-2\alpha} \lesssim \zeta_{q+1}^{\gamma} \lambda_{q+1}^{2\alpha} \ell_{q,i}^{-N} = \lambda_{q+1}^{2\alpha - 2\beta\gamma} \ell_{q,i}^{-N}.$$
(9.34)

Then, using the decomposition

we deduce from (9.33)-(9.34) that

Define then

$$w \coloneqq w_o + w_c$$

$$\tilde{v} \coloneqq v + w$$

$$\tilde{p} \coloneqq p - \sum_i \sigma_i$$

$$\mathcal{E}(x, t) \coloneqq \mathring{\mathcal{E}}^{(1)}(x, t) + \mathscr{E}^{(2)},$$

where

$$\mathring{\mathcal{E}}^{(1)} \coloneqq \mathscr{R}(\partial_t \widetilde{v} + \operatorname{div}(\widetilde{v} \otimes \widetilde{v}) + \nabla \widetilde{p} + (-\Delta)^{\theta} \widetilde{v} + \operatorname{div}(R - S_{\Psi})), \tag{9.37}$$

with \mathcal{R} being the anti-divergence operator defined in **Definition 2.1**, and

$$\mathcal{E}^{(2)}(t) \coloneqq \frac{\mathrm{Id}}{3} \int_{\mathbb{T}^3} \left(|\tilde{v}|^2 - |v|^2 - \mathrm{tr} S_{\Psi} \right) \mathrm{d}x.$$

Equations (9.15) and (3.1) follow by construction.

Step 3: Estimates on the perturbation

The estimates on \tilde{v} follow similarly to the ones for v_{q+1} in [4, Section 5-6]. Obtaining those requires estimates on the coefficients $b_{i,k}, c_{i,k}$, which in turn require estimates of \tilde{S}_i and estimates of $\mathfrak{D}\Phi_i$. The latter read as follows:

(9.40)

$$\|(\partial_t + v \cdot \nabla)\mathfrak{D}\Phi_i\|_N \lesssim \delta_q^{\frac{1}{2}} \lambda_q^{1+\alpha} \ell_q^{3\alpha \mathbb{1}_{N\neq 0}} \ell_{q,i}^{-N}.$$
(9.41)

To obtain these, we first observe that Φ_i is a diffeomorphism, which implies both $\mathfrak{D}\Phi_i$ and $(\mathfrak{D}\Phi_i)^{-1}$ are bounded, thus yielding the N = 0 case of (9.40). To obtain (9.39), we start by combining (9.33) with the N = 0 case of (9.40), thus obtaining that

$$\left\| (\mathfrak{D}\Phi_i)^{-1} - \mathrm{Id} \right\|_0 \leq \left\| (\mathfrak{D}\Phi_i)^{-1} \right\|_0 \|\mathrm{Id} - \mathfrak{D}\Phi_i\|_0 \lesssim \ell_q^{3\alpha}.$$

This yields (9.39) for N = 0. For $N \ge 1$, we note that

$$\|\mathfrak{D}\Phi_{i} - \mathrm{Id}\|_{N} + \|(\mathfrak{D}\Phi_{i})^{-1} - \mathrm{Id}\|_{N} \lesssim \|\mathfrak{D}\Phi_{i} - \mathrm{Id}\|_{0} + \|(\mathfrak{D}\Phi_{i})^{-1} - \mathrm{Id}\|_{0} + \|\mathfrak{D}^{2}\Phi_{i}\|_{N-1} + \|\mathfrak{D}(\mathfrak{D}\Phi_{i})^{-1}\|_{N-1}$$

The other cases of (9.39) follow by combining its N = 0 case with the $N \ge 1$ cases of (9.40). The estimates for $\|\mathfrak{D}\Phi_i\|_N$ for $N \ge 1$ follow from **Proposition 2.1**. By combining (2.20) with Lemma 2.1, we obtain that

To complete the proof of (9.40), we are left with estimating $\|(\mathfrak{D}\Phi_i)^{-1}\|_N$. We note that $\mathfrak{D}^N(\Phi_i \circ \Phi_i^{-1}) = 0$ for $N \ge 1$. We then use the Leibniz rule and the chain rule to write

$$\begin{split} \mathfrak{D}^{2}(\Phi_{i}\circ\Phi_{i}^{-1}) &= \mathfrak{D}((\mathfrak{D}\Phi_{i}\circ\Phi_{i}^{-1})\mathfrak{D}\Phi_{i}^{-1}) = (\mathfrak{D}^{2}\Phi_{i}\circ\Phi_{i}^{-1})(\mathfrak{D}\Phi_{i}^{-1})^{2} + (\mathfrak{D}\Phi_{i}\circ\Phi_{i}^{-1})\mathfrak{D}^{2}\Phi_{i}^{-1} \\ \mathfrak{D}^{3}(\Phi_{i}\circ\Phi_{i}^{-1}) &= \mathfrak{D}(\mathfrak{D}^{2}(\Phi_{i}\circ\Phi_{i}^{-1})) \\ &= (\mathfrak{D}^{3}\Phi_{i}\circ\Phi_{i}^{-1})(\mathfrak{D}\Phi_{i}^{-1})^{3} + 3(\mathfrak{D}^{2}\Phi_{i}\circ\Phi_{i}^{-1})(\mathfrak{D}\Phi_{i}^{-1})(\mathfrak{D}^{2}\Phi_{i}^{-1}) + (\mathfrak{D}\Phi_{i}\circ\Phi_{i}^{-1})\mathfrak{D}^{3}\Phi_{i}^{-1} \\ \mathfrak{D}^{4}(\Phi_{i}\circ\Phi_{i}^{-1}) &= \mathfrak{D}(\mathfrak{D}^{3}(\Phi_{i}\circ\Phi_{i}^{-1})) \\ &= (\mathfrak{D}^{4}\Phi_{i}\circ\Phi_{i}^{-1})(\mathfrak{D}\Phi_{i}^{-1})^{4} + 6(\mathfrak{D}^{3}\Phi_{i}\circ\Phi_{i}^{-1})(\mathfrak{D}\Phi_{i}^{-1})^{2}\mathfrak{D}^{2}\Phi_{i}^{-1} + 3(\mathfrak{D}^{2}\Phi_{i}\circ\Phi_{i}^{-1})(\mathfrak{D}^{2}\Phi_{i}^{-1})^{2} \\ &+ 4(\mathfrak{D}^{2}\Phi_{i}\circ\Phi_{i}^{-1})(\mathfrak{D}\Phi_{i}^{-1})(\mathfrak{D}^{3}\Phi_{i}^{-1}) + (\mathfrak{D}\Phi_{i}\circ\Phi_{i}^{-1})\mathfrak{D}^{4}\Phi_{i}^{-1}. \end{split}$$

From these, we can see that

$$\begin{split} \|\mathfrak{D}^{2}\Phi_{i}^{-1}\|_{0} &\leq \|\mathfrak{D}\Phi_{i}^{-1}\|_{0}\|\mathfrak{D}^{2}\Phi_{i}\|_{0}\|\mathfrak{D}\Phi_{i}^{-1}\|_{0}^{2} \lesssim \ell_{q}^{3\alpha}\ell_{q,i}^{-1} \\ \|\mathfrak{D}^{3}\Phi_{i}^{-1}\|_{0} &\leq \|\mathfrak{D}\Phi_{i}^{-1}\|_{0}\Big(\|\mathfrak{D}^{3}\Phi_{i}\|_{0}\|\mathfrak{D}\Phi_{i}^{-1}\|_{0}^{3} + 3\|\mathfrak{D}^{2}\Phi_{i}\|_{0}\|\mathfrak{D}\Phi_{i}^{-1}\|_{0}\|\mathfrak{D}^{2}\Phi_{i}^{-1}\|_{0}\Big) \lesssim \ell_{q}^{3\alpha}\ell_{q,i}^{-2} \\ \|\mathfrak{D}^{4}\Phi_{i}^{-1}\|_{0} &\leq \|\mathfrak{D}\Phi_{i}^{-1}\|_{0}\Big(\|\mathfrak{D}^{4}\Phi_{i}\|_{0}\|\mathfrak{D}\Phi_{i}^{-1}\|_{0}^{4} + 6\|\mathfrak{D}^{3}\Phi_{i}\|_{0}\|\mathfrak{D}\Phi_{i}^{-1}\|_{0}^{2}\|\mathfrak{D}^{2}\Phi_{i}^{-1}\|_{0} \\ &+ 3\|\mathfrak{D}^{2}\Phi_{i}\|_{0}\|\mathfrak{D}^{2}\Phi_{i}^{-1}\|_{0}^{2} + 4\|\mathfrak{D}^{2}\Phi_{i}\|_{0}\|\mathfrak{D}\Phi_{i}^{-1}\|_{0}\|\mathfrak{D}^{3}\Phi_{i}^{-1}\|_{0}\Big) \lesssim \ell_{q}^{3\alpha}\ell_{q,i}^{-3}. \end{split}$$

These two examples show us that

$$III \lesssim \rho_i^{\frac{1}{2}} |k|^{-6} \ell_{q,i}^{-1} \cdot \delta_q^{\frac{1}{2}} \lambda_q^{1+\alpha} \lesssim \delta_{q+1}^{\frac{1}{2}} \tau_q^{-1} \ell_{q,i}^{-1} |k|^{-6}.$$

We are then left with proving that II also satisfies this bound. To this end, we rewrite the commutator as

$$[v \cdot \nabla, \nabla](b_{i,k}) = \sum_{j\ell} (v_j \partial_j (\partial_\ell b_{i,k}) - \partial_\ell (v_j \partial_j b_{i,k})) e_\ell = -\sum_{j\ell} \partial_\ell v_j \partial_j b_{i,k} e_\ell = \nabla v \nabla b_{i,k}$$

It then follows from (9.40), (9.43), and (9.50) that *II* satisfies the same bound as *I* and *III*, thus proving (9.47). In turn, the estimates on \tilde{v} in (9.17)-(9.18) follow from the ones just given precisely as in [4, Corollary 5.8, pp. 23-24]. Indeed, once we note that

$$\left\|\nabla(e^{i\lambda_{q+1}k\cdot\Phi_i})\right\|_0 \le \lambda_{q+1}|k|\|\mathfrak{D}\Phi_i\|_0 \le 2\lambda_{q+1}|k|,\tag{9.58}$$

we can deduce from the estimates above that

$$\begin{split} \|w_{o,i}\|_{N} \lesssim \sum_{i,k} \left\|\mathfrak{D}\Phi_{i}^{-1}\right\|_{N} \|b_{i,k}\|_{0} \left\|e^{i\lambda_{q+1}k\cdot\Phi_{i}}\right\|_{0} + \sum_{i,k} \left\|\mathfrak{D}\Phi_{i}^{-1}\right\|_{0} \|b_{i,k}\|_{N} \left\|e^{i\lambda_{q+1}k\cdot\Phi_{i}}\right\|_{0} \\ + \sum_{i,k} \left\|\mathfrak{D}\Phi_{i}^{-1}\right\|_{0} \|b_{i,k}\|_{0} \left\|e^{i\lambda_{q+1}k\cdot\Phi_{i}}\right\|_{N} \lesssim \delta_{q+1}^{\frac{1}{2}}\lambda_{q+1}^{N}. \end{split}$$

The $w_{o,i}$ have pairwise disjoint supports, so the sum over *i* always consists of a single term, which yields that the desired estimates hold for w_o . The estimates on $c_{i,k}\lambda_{q+1}^{-1}$ are always better than those on $b_{i,k}$, meaning that any estimate that holds for w_o holds for w_c as well. Thus, (9.17) follows directly, and (9.18) and (9.19) follow by interpolation.

Coming to (9.16), the fact that w_c satisfies this bound can be easily deduced from (9.44), which tells us that $\lambda_{q+1}^{-1} \|c_{i,k}\|_0 \lesssim \delta_{q+1}^{\frac{1}{2}} |k|^{-6} \ell_{q,i}^{-1} \lambda_{q+1}^{-1}$. To estimate w_o , we use a procedure similar to the one employed in Section 7 to prove (7.3), replacing (7.10) with (9.43).

Step 4: Estimates on the new Reynolds term $\mathring{\mathcal{E}}^{(1)}$.

The aim of this section is to prove $\mathring{\mathcal{E}}^{(1)}$ satisfies (9.20), namely

Drawing from [4], we decompose $\mathring{\mathcal{E}}^{(1)}$ as

$$= \mathcal{R}\left(\partial_t w + w \cdot \nabla v + v \cdot \nabla w + \operatorname{div}(w \otimes w) - \sum_i \nabla \sigma_i + (-\Delta)^{\theta} w - \operatorname{div} S_{\Psi}\right)$$
$$= \underbrace{\mathcal{R}(w \cdot \nabla v)}_{\operatorname{Nash error} =: \mathcal{E}_N} + \underbrace{\mathcal{R}((\partial_t + v \cdot \nabla)w)}_{\operatorname{Transport error} =: \mathcal{E}_T} + \underbrace{\mathcal{R}\left[\operatorname{div}(w \otimes w - \mathring{S}_{\Psi}) - \sum_i \nabla \sigma_i\right]}_{\operatorname{Oscillation error} =: \mathcal{E}_O} + \underbrace{\mathcal{R}((-\Delta)^{\theta}w)}_{\operatorname{Dissipation error} =: \mathcal{E}_D}$$

We then note that, since the $w_{o,i}$ have disjoint supports and $w_o = \sum_i w_{o,i}$, by (9.31), we have that

$$\operatorname{div}(w \otimes w - \mathring{S}_{\psi}) - \sum_{i} \nabla \sigma_{i} = \operatorname{div}(w_{o} \otimes w_{c} + w_{c} \otimes w_{o} + w_{c} \otimes w_{c}) + \sum_{i} \left[\operatorname{div}\left(w_{o,i} \otimes w_{o,i} - \eta_{i}^{2} \mathring{S}_{\psi} - \frac{1}{3} \operatorname{tr} S_{i}\right) \right].$$
(9.59)

We now rewrite the first three terms using the definition of w, (9.59) (to rewrite \mathcal{E}_O), and the fact that $D_t e^{i\lambda_{q+1}k\cdot\Phi_i} = 0$ (to rewrite \mathcal{E}_T):

$$\begin{split} & \mathcal{E}_{N} = \sum_{i,k} \mathcal{R}((\mathfrak{D}\Phi_{i}^{-1}b_{i,k}A_{k} + \lambda_{q+1}^{-1}c_{i,k}) \cdot \nabla v e^{i\lambda_{q+1}k \cdot \Phi_{i}}) \\ & \mathcal{E}_{T} = \sum_{i,k} \mathcal{R}((D_{t}\mathfrak{D}\Phi_{i}^{-1}b_{i,k}A_{k} + \mathfrak{D}\Phi_{i}^{-1}D_{t}b_{i,k}A_{k} + \lambda_{q+1}^{-1}D_{t}c_{i,k})e^{i\lambda_{q+1}k \cdot \Phi_{i}}) \\ & \mathcal{E}_{O} = \mathcal{R}\operatorname{div}(w_{o} \otimes w_{c} + w_{c} \otimes w_{o} + w_{c} \otimes w_{c}) + \sum_{i} \mathcal{R}\operatorname{div}(w_{o,i} \otimes w_{o,i} - S_{i}) \\ & = \mathcal{R}\operatorname{div}(w_{o} \otimes w_{c} + w_{c} \otimes w_{o} + w_{c} \otimes w_{c}) + \sum_{i,k} \mathcal{R}(\operatorname{div}(\sigma_{i}\mathfrak{D}\Phi_{i}^{-1}C_{k}(\tilde{S}_{i})\mathfrak{D}^{T}\Phi_{i}^{-1})e^{i\lambda_{q+1}k \cdot \Phi_{i}}), \end{split}$$

where the C_k are as defined in Lemma 2.2. We now note that the leading order terms are

$$\begin{split} & \mathcal{E}_{N}^{(L)} \coloneqq \sum_{i,k} \mathcal{R}((\mathfrak{D}\Phi_{i}^{-1}b_{i,k}A_{k}) \cdot \nabla v e^{i\lambda_{q+1}k \cdot \Phi_{i}}) \\ & \mathcal{E}_{T}^{(L)} \coloneqq \sum_{i,k} \mathcal{R}((D_{t}\mathfrak{D}\Phi_{i}^{-1}b_{i,k} + \mathfrak{D}\Phi_{i}^{-1}D_{t}b_{i,k})A_{k}e^{i\lambda_{q+1}k \cdot \Phi_{i}}) \\ & \mathcal{E}_{O}^{(L)} \coloneqq \mathcal{R}\operatorname{div}(w_{o} \otimes w_{c} + w_{c} \otimes w_{o}) + \sum_{i,k} \mathcal{R}(\operatorname{div}(\sigma_{i}\mathfrak{D}\Phi_{i}^{-1}C_{k}(\tilde{S}_{i})\mathfrak{D}^{T}\Phi_{i}^{-1})e^{i\lambda_{q+1}k \cdot \Phi_{i}}) =: \mathcal{E}_{O}^{(L,1)} + \mathcal{E}_{O}^{(L,2)}. \end{split}$$

We start by estimating $\mathcal{E}_{O}^{(L,1)}$. Since \mathcal{R} div is Calderón-Zygmund, we have that

$$\|\mathscr{R}\operatorname{div}(w_o\otimes w_c+w_c\otimes w_o)\|_{\alpha}\lesssim \|w_o\|_{\alpha}\|w_c\|_0+\|w_o\|_0\|w_c\|_{\alpha}.$$

From (9.43), (9.40), and (9.44), we can conclude that

$$\|w_o\|_N \lesssim \rho_i^{\frac{1}{2}} \lambda_{q+1}^N \qquad \|w_c\|_N \lesssim \rho_i^{\frac{1}{2}} \lambda_{q+1}^{N-1} \ell_{q,i}^{-1}.$$

By interpolation, this lets us conclude that

$$\begin{split} \left\| \mathcal{E}_{N}^{(L)} \right\|_{\alpha} &\lesssim \sum_{i,k} \left(\frac{\left\| \mathfrak{D} \Phi_{i}^{-1} b_{i,k} \cdot \nabla v \right\|_{0}}{|k\lambda_{q+1}|^{1-\alpha}} + \frac{\left\| \mathfrak{D} \Phi_{i}^{-1} b_{i,k} \cdot \nabla v \right\|_{N+\alpha} + \left\| \mathfrak{D} \Phi_{i}^{-1} b_{i,k} \cdot \nabla v \right\|_{0} \|\Phi_{i}\|_{N+\alpha}}{|k\lambda_{q+1}|^{N-\alpha}} \right) \\ &\left\| \mathcal{E}_{T}^{(L)} \right\|_{\alpha} \lesssim \sum_{i,k} \frac{\left\| D_{t} \mathfrak{D} \Phi_{i}^{-1} b_{i,k} + \mathfrak{D} \Phi_{i}^{-1} D_{t} b_{i,k} \right\|_{0}}{|k\lambda_{q+1}|^{1-\alpha}} \\ &+ \sum_{i,k} \frac{\left\| D_{t} \mathfrak{D} \Phi_{i}^{-1} b_{i,k} + \mathfrak{D} \Phi_{i}^{-1} D_{t} b_{i,k} \right\|_{N+\alpha} + \left\| D_{t} \mathfrak{D} \Phi_{i}^{-1} b_{i,k} + \mathfrak{D} \Phi_{i}^{-1} D_{t} b_{i,k} \right\|_{0} \|\Phi_{i}\|_{N+\alpha}}{|k\lambda_{q+1}|^{N-\alpha}} \\ &\left| \mathcal{E}_{O}^{(L,2)} \right\|_{\alpha} \lesssim \sum_{i,k} \frac{\left\| \operatorname{div}(\sigma_{i} \mathfrak{D} \Phi_{i}^{-1} C_{k}(\tilde{S}_{i}) \mathfrak{D}^{T} \Phi_{i}^{-1}) \right\|_{0}}{|k\lambda_{q+1}|^{1-\alpha}} \\ &+ \sum_{i,k} \frac{\left\| \operatorname{div}(\sigma_{i} \mathfrak{D} \Phi_{i}^{-1} C_{k}(\tilde{S}_{i}) \mathfrak{D}^{T} \Phi_{i}^{-1}) \right\|_{N+\alpha} + \left\| \operatorname{div}(\sigma_{i} \mathfrak{D} \Phi_{i}^{-1} C_{k}(\tilde{S}_{i}) \mathfrak{D}^{T} \Phi_{i}^{-1}) \right\|_{0} \|\Phi_{i}\|_{N+\alpha}}{|k\lambda_{q+1}|^{N-\alpha}}. \end{split}$$

To estimate $\mathcal{E}_N^{(L)}$, we combine (9.40), (9.43), and (9.11) with a Leibniz inequality:

$$\begin{split} \sum_{i,k} \left(\frac{\left\| \mathfrak{D} \Phi_{i}^{-1} b_{i,k} \cdot \nabla v \right\|_{0}}{|k\lambda_{q+1}|^{1-\alpha}} + \frac{\left\| \mathfrak{D} \Phi_{i}^{-1} b_{i,k} \cdot \nabla v \right\|_{N+\alpha} + \left\| \mathfrak{D} \Phi_{i}^{-1} b_{i,k} \cdot \nabla v \right\|_{0} \|\Phi_{i}\|_{N+\alpha}}{|k\lambda_{q+1}|^{N-\alpha}} \right) \\ \lesssim \sum_{i,k} \frac{\left\| \mathfrak{D} \Phi_{i}^{-1} \right\|_{0} \|b_{i,k}\|_{0} \|\nabla v\|_{0}}{|k\lambda_{q+1}|^{1-\alpha}} + \sum_{i,k} \frac{\left\| \mathfrak{D} \Phi_{i}^{-1} \right\|_{0} \|b_{i,k}\|_{0} \|\nabla v\|_{0} \|\Phi_{i}\|_{N+\alpha}}{|k\lambda_{q+1}|^{N-\alpha}} + \sum_{i,k} \frac{\left\| \mathfrak{D} \Phi_{i}^{-1} \right\|_{\alpha} \|b_{i,k}\|_{\alpha} \|\nabla v\|_{N+\alpha}}{|k\lambda_{q+1}|^{N-\alpha}} \\ + \sum_{i,k} \frac{\left\| \mathfrak{D} \Phi_{i}^{-1} \right\|_{N+\alpha} \|b_{i,k}\|_{\alpha} \|\nabla v\|_{\alpha} + \left\| \mathfrak{D} \Phi_{i}^{-1} \right\|_{\alpha} \|b_{i,k}\|_{N+\alpha} \|\nabla v\|_{\alpha}}{|k\lambda_{q+1}|^{N-\alpha}} \\ \lesssim \frac{\rho_{i}^{\frac{1}{2}} \delta_{q}^{\frac{1}{2}} \lambda_{q}^{1+\alpha}}{\lambda_{q+1}^{1-\alpha}} + \frac{\ell_{q,i}^{-N-3\alpha} \rho_{i}^{\frac{1}{2}} \delta_{q}^{\frac{1}{2}} \lambda_{q}^{1+\alpha}}{\lambda_{q+1}^{N-\alpha}}. \end{split}$$

The above holds for any N. If we choose N to be the \overline{N} from Section 4, by (9.3) and (4.14), we conclude that

$$\left\| \mathscr{R}_{N}^{(L)} \right\|_{lpha} \lesssim rac{\delta_{q+1}^{rac{1}{2}} \delta_{q}^{rac{1}{2}} \lambda_{q}}{\lambda_{q+1}^{1-2lpha}}.$$

Notice how the leading order term here is the one that does not depend on N thanks to the ℓ_q in (4.14). This is also true of $\mathcal{E}_T^{(L)}$ and $\mathcal{E}_O^{(L,2)}$.

 $\mathcal{E}_{T}^{(L)}$ is estimated in a similar manner, using (9.40), (9.41), (9.43), (9.46), and (4.14).

As for $\mathcal{E}_{O}^{(L,1)}$, we first ensure that adding a derivative, whichever factor it lands on, costs at most $\ell_{q,i}^{-1}$. This ensures that the leading term is the first one, because of that gain of ℓ_q mentioned above. We then estimate the leading term.

By (9.40) and (9.43), differentiating $b_{i,k}$ or $\mathfrak{D}\Phi_i^{-1}$ costs $\ell_{q,i}^{-1}$, and by (9.30), differentiating σ_i does not cost anything, so we are left with showing that $C_k(\tilde{S}_i)$ scales like $\ell_{q,i}^{-N}$. Thanks to (2.4), (2.11), and (9.42), we have that

We then use (9.7), (9.40), and the above estimate on $C_k(\tilde{S}_i)$ to estimate the leading term:

$$\begin{split} \sum_{i,k} \frac{\left\| \operatorname{div}(\sigma_{i} \mathfrak{D} \Phi_{i}^{-1} C_{k}(\tilde{S}_{i}) \mathfrak{D}^{T} \Phi_{i}^{-1}) \right\|_{0}}{\left| k \lambda_{q+1} \right|^{1-\alpha}} \\ \lesssim \sum_{i,k} \frac{\left\| \sigma_{i} \right\|_{1} \left\| \mathfrak{D} \Phi_{i}^{-1} \right\|_{0}^{2} \left\| C_{k}(\tilde{S}_{i}) \right\|_{0} + 2 \|\sigma_{i}\|_{0} \left\| \mathfrak{D} \Phi_{i}^{-1} \right\|_{1} \left\| C_{k}(\tilde{S}_{i}) \right\|_{0} \left\| \mathfrak{D}^{T} \Phi_{i}^{-1} \right\|_{0} + \|\sigma_{i}\|_{0} \left\| \mathfrak{D} \Phi_{i}^{-1} \right\|_{0}^{2} \left\| C_{k}(\tilde{S}_{i}) \right\|_{1}}{\left| k \lambda_{q+1} \right|^{1-\alpha}} \\ \lesssim \rho_{i} \ell_{q,i}^{-1} \lambda_{q+1}^{-1}. \end{split}$$

We thus obtain that

The relation (4.12) easily yields that the above terms satisfy (9.20) for $a \gg 1$ sufficiently large, since

\frac{\rho_{i}}{\ell_{q,i}\lambda_{q+1}^{1-\alpha}} \leq \frac{\Lambda\zeta_{q+1}^{\frac{1-\gamma}{2}}\zeta_{q}^{\frac{1}{2}}\lambda_{q}^{1+\alpha}\ell_{q}^{-\alpha}}{\lambda_{q+1}^{1-\alpha}} \lesssim \frac{\delta_{q}^{\frac{1}{2}}\delta_{q+1}^{\frac{1}{2}}\lambda_{q}}{\lambda_{q+1}^{1-3\alpha-\beta\gamma}} \lesssim \delta_{q+2}\lambda_{q+1}^{-6\alpha}.$$
(9.61)

Coming to \mathcal{E}_D , which is not present in [4], we estimate it as follows:

$$\left\| \mathscr{R}((-\Delta)^{\theta} w) \right\|_{0} \lesssim \left\| \mathscr{R} w \right\|_{2\theta+\varepsilon} \lesssim \left\| \mathscr{R} w \right\|_{0}^{1-2\theta-\varepsilon} \left\| \mathscr{R} w \right\|_{1}^{2\theta+\varepsilon}.$$
(9.62)

At this point, we use Lemma 2.4 to obtain that

$$\begin{aligned} \|\mathscr{R}w_{o}\|_{0} &\lesssim \|\mathscr{R}w_{o}\|_{\alpha} \lesssim \sum_{i,k} \left(\frac{\|\mathfrak{D}\Phi_{i}^{-1}b_{i,k}\|_{0}}{|k|^{1-\alpha}} + \frac{\|\mathfrak{D}\Phi_{i}^{-1}b_{i,k}\|_{N+\alpha} + \|\mathfrak{D}\Phi_{i}^{-1}b_{i,k}\|_{0}\|\Phi_{i}\|_{N+\alpha}}{|k|^{N-\alpha}} \right) \\ &\lesssim \delta_{q+1}^{\frac{1}{2}} \cdot \sum_{k \neq 0} \left(\frac{1}{\lambda_{q+1}^{1-\alpha}|k|^{7-\alpha}} + \frac{\ell_{q}^{-N-\alpha}}{\lambda_{q+1}^{N-\alpha}|k|^{N-\alpha+7}} \right) \lesssim \frac{\delta_{q+1}^{\frac{1}{2}}}{\lambda_{q+1}^{1-\alpha}}, \end{aligned} \tag{9.63}$$

the last step being due to (4.14). We also note that

$$\left\| \mathcal{R} w_o \right\|_1 = \max_i \left\| \mathcal{R} \partial_i w_o \right\|_0.$$

Proceeding on the $\Re \partial_i w_o$ as we did on $\Re w_o$ then yields

$$\begin{aligned} \|\mathscr{R}w_{o}\|_{1} &\lesssim \max_{i} \|\mathscr{R}\partial_{t}w_{o}\|_{\alpha} \lesssim \sum_{i,k} \left(\frac{\|\mathfrak{D}\Phi_{i}^{-1}b_{i,k}\|_{1}}{|k|^{1-\alpha}} + \frac{\|\mathfrak{D}\Phi_{i}^{-1}b_{i,k}\|_{N+1+\alpha} + \|\mathfrak{D}\Phi_{i}^{-1}b_{i,k}\|_{1}\|\Phi_{i}\|_{N+\alpha}}{|k|^{N-\alpha}} \right) \\ &\lesssim \delta_{q+1}^{\frac{1}{2}}\lambda_{q+1}^{\alpha}. \end{aligned}$$
(9.64)

Such estimates analogously also hold for $\Re w_c$, and thus for $\Re w$. Thus, by (9.62)-(9.64)

(9.65)

Since $\theta < \beta$, and $2b\beta < 1 - \beta$ by (4.2), we have that $1 + \beta - 2\theta - 2b\beta > 0$. Thus, (9.65) above holds for α, ε sufficiently small.

Step 5: Estimates on the new Reynolds term $\mathcal{E}^{(2)}$ **.**

Now we turn to $\mathcal{E}^{(2)}$. Consider the decomposition

and proceed as in [4, Proposition 6.2]. In the case of the first term, we will estimate the whole tensor, and therefore the trace. For the other terms, only the trace will be handled.

Concerning the first term in (9.66), thanks to (9.31), $\sum \int \sigma_i = \int \sigma_{\psi}$, so that two cancellations occur:

$$\int w_o \otimes w_o - S_{\Psi} dx = \sum_{i,k \neq 0} \int \sigma_i \mathfrak{D} \Phi_i^{-1} C_k(\tilde{S}_i) \mathfrak{D} \Phi_i^{-T} e^{i\lambda_{q+1}k \cdot \Phi_i} dx + \int \left(\sum_i \sigma_i - \sigma_{\Psi}\right) \operatorname{Id} dx$$
$$= \sum_{i,k \neq 0} \int Z_{i,k} e^{i\lambda_{q+1}k \cdot \Phi_i} dx, \tag{9.67}$$

where we write $Z_{i,k} \coloneqq \sigma_i \mathfrak{D} \Phi_i^{-1} C_k(\tilde{S}_i) \mathfrak{D} \Phi_i^{-T}$. Using (2.15), (2.11), and (4.14), we obtain that

$$\left| \int_{\mathbb{T}^3} \sum_{i,k\neq 0} Z_{i,k} e^{i\lambda_{q+1}k \cdot \Phi_i} \right| \lesssim \sum_{i,k\neq 0} \frac{\|Z_{i,k}\|_{\overline{N}} + \|Z_{i,k}\|_0 \|\Phi_i\|_{\overline{N}}}{|\lambda_{q+1}k|^{\overline{N}}} \lesssim \sum_{k\neq 0} \frac{\delta_{q+1}\ell_q^{-\overline{N}}}{\lambda_{q+1}^{\overline{N}}} \lesssim \frac{\delta_{q+1}\ell_q}{\lambda_{q+1}}.$$
(9.68)

The second inequality above is easily justified by using (9.30), (9.39), and (9.60) to estimate $Z_{i,k}$ as follows:

$$\begin{aligned} \|Z_{i,k}\|_{N} &\lesssim \|\sigma_{i}\|_{N} \|\mathfrak{D}_{i}^{-1}\|_{0}^{2} \|C_{k}(\tilde{S}_{i})\|_{0} + 2\|\sigma_{i}\|_{0} \|\mathfrak{D}\Phi_{i}^{-1}\|_{N} \|C_{k}(\tilde{S}_{i})\| \|\mathfrak{D}\Phi_{i}^{-1}\|_{0} + \|\sigma_{i}\|_{0} \|\mathfrak{D}\Phi_{i}^{-1}\|_{0}^{2} \|C_{k}(\tilde{S}_{i})\|_{N} \\ &\lesssim |k|^{-6} \delta_{q+1} \ell_{q}^{-N}. \end{aligned}$$

To estimate the second term in (9.66), observe that

$$w \cdot v = \sum_{i,k} ((\mathfrak{D}\Phi_i)^{-1} b_{i,k} + \lambda_{q+1}^{-1} c_{i,k}) \cdot v e^{i\lambda_{q+1}k \cdot \Phi_i},$$

so that, combining Lemma 2.4, (9.43), (9.44), (9.11), (9.39), and (4.14), we obtain that

$$\left| \oint 2w \cdot v dx \right| \lesssim \sum_{i,k} \frac{\left\| \left((\mathfrak{D}\Phi_i)^{-1} b_{i,k} + \lambda_{q+1}^{-1} c_{i,k} \right) \cdot v \right\|_{\overline{N}} + \left\| \left((\mathfrak{D}\Phi_i)^{-1} b_{i,k} + \lambda_{q+1}^{-1} c_{i,k} \right) \cdot v \right\|_0 \| \mathfrak{D}\Phi_i \|_{\overline{N}}}{\lambda_{q+1}^{\overline{N}} |k|^{\overline{N}}} \\ \lesssim \delta_{q+1}^{\frac{1}{2}} \cdot \delta_q^{\frac{1}{2}} \lambda_q^{1+\alpha} \cdot \ell_q \lambda_{q+1}^{-1} \lesssim \delta_{q+1}^{\frac{1}{2}} \delta_q^{\frac{1}{2}} \lambda_q^{\alpha} \lambda_{q+1}^{-1}.$$

$$(9.69)$$

Concerning the third term in (9.66), note that the estimates on w_c are always no coarser than those for w_o , so if we estimate $\int w_o \cdot w_c$ well, the whole term is estimated well. To this end, we observe that

$$\begin{split} \left| \int w_o \cdot w_c \mathrm{d}x \right| &\leq \sum_{i} \sum_{0 \neq k \neq l} \left| \int (\mathfrak{D}\Phi_i)^{-1} b_{i,k} \lambda_{q+1}^{-1} c_{i,l-k} e^{i\lambda l \cdot \Phi} \mathrm{d}x \right| \\ &\lesssim \sum_{i} \sum_{0 \neq k \neq l \neq 0} \frac{\left\| (\mathfrak{D}\Phi_i)^{-1} b_{i,k} \lambda_{q+1}^{-1} c_{i,l-k} \right\|_{\overline{N}} + \left\| (\mathfrak{D}\Phi_i)^{-1} b_{i,k} \lambda_{q+1}^{-1} c_{i,l-k} \right\|_0 \| \mathfrak{D}\Phi_i \|_{\overline{N}}}{\lambda_{q+1}^N |l|^N} \\ &+ \sum_{i} \sum_{k \neq 0} \left| \int (\mathfrak{D}\Phi_i)^{-1} b_{i,k} \lambda_{q+1}^{-1} c_{i,-k} \mathrm{d}x \right| =: I + II, \end{split}$$

where we used Lemma 2.4 in the case $l \neq 0$, as well as the fact that the $w_{o,i}$ and $w_{c,i}$ have disjoint support so we do not have products of the form $b_{i,k}c_{j,l-k}$ for $i \neq j$. The term *I* is easily estimated as $\delta_{q+1}\ell_q^{-\overline{N}}\lambda_{q+1}^{-\overline{N}} \lesssim \delta_{q+1}\ell_q\lambda_{q+1}^{-1}$,

so that *I* satisfies the same estimate as the second term in (9.66). As for *II*, (9.43) and (9.44) easily yield $II \leq \rho_i \ell_{q,i}^{-1} \lambda_{q+1}^{-1}$. Therefore

$$\left|\int w_{o} \cdot w_{c} \mathrm{d}x\right| \lesssim \frac{\delta_{q+1}\ell_{q}}{\lambda_{q+1}} + \frac{\rho_{i}\ell_{q}^{-1}}{\lambda_{q+1}}.$$

Combining (9.66)-(9.70) with the fact that $\int |w_c|^2$ also satisfies (9.70), we arrive at

$$|\mathcal{E}|^{(2)} \lesssim \frac{\delta_{q+1}\ell_q}{\lambda_{q+1}} + \frac{\delta_{q+1}^{\frac{1}{2}}\delta_q^{\frac{1}{2}}\lambda_q^{1+\alpha}\ell_q}{\lambda_{q+1}} + \frac{\rho_i\ell_{q,i}^{-1}}{\lambda_{q+1}}.$$

By (4.12), we thus conclude that, for $a \gg 1$ sufficiently large, $\mathcal{E}^{(2)}$ satisfies (9.20). Combining with the fact (obtained in the previous step) that $\mathring{\mathcal{E}}^{(1)}$ satisfies (9.20), we thus conclude that (9.20) holds.

Step 6: Estimates on $\partial_t \operatorname{tr} \mathcal{E}$

Observe that $\mathring{\mathcal{E}}^{(1)}$ is traceless, whereas $\mathscr{E}^{(2)}$ is a function of *t* only. In order to estimate the time derivative of $\mathscr{E}^{(2)}$, observe that, since *v* is solenoidal, for every F = F(x,t)

$$\frac{\mathrm{d}}{\mathrm{d}t}\int_{\mathbb{T}^3} F = \int_{\mathbb{T}^3} D_t F$$

where $D_t = \partial_t + v \cdot \nabla$. Therefore, using again the decomposition in (9.66), we have that

$$\left| \frac{\mathrm{d}}{\mathrm{d}t} \int_{\mathbb{T}^3} |\tilde{v}|^2 - |v|^2 - \mathrm{tr} S_{\Psi} \right| \leq \left| \int_{\mathbb{T}^3} \mathrm{tr} \left[D_t \left(\sum_{i,k \neq 0} \sigma_i \mathfrak{D} \Phi_i^{-1} C_k(\tilde{S}_i) \mathfrak{D} \Phi_i^{-T} e^{i\lambda_{q+1}k \cdot \Phi_i} \right) \right] \right| + \left| \int_{\mathbb{T}^3} D_t (2w_c \cdot w_o + |w_c|^2) \right| + \left| \int_{\mathbb{T}^3} D_t (2v \cdot w) \right|.$$

$$(9.71)$$

Let us first estimate $||D_t w_o||_0$. Recall from (2.21) that $D_t(\mathfrak{D}\Phi_i)^{-1} = \mathfrak{D}v(\mathfrak{D}\Phi_i)^{-1}$, which, combined with the fact that $D_t e^{i\lambda_{q+1}k\cdot\Phi_i} = 0$, yields

$$D_t w_o = \sum_{i,k\neq 0} D_t \left(\sqrt{\sigma_i} a_k(\tilde{S}_i) \right) \mathfrak{D} \Phi_i^{-1} A_k e^{i\lambda_{q+1}k \cdot \Phi_i} + \sum_{i,k\neq 0} \sqrt{\sigma_i} a_k(\tilde{S}_i) \mathfrak{D} v \mathfrak{D} \Phi_i^{-1} A_k e^{i\lambda_{q+1}k \cdot \Phi_i} = \sum_{i,k\neq 0} \mathfrak{D} \Phi_i^{-1} D_t b_{i,k} e^{i\lambda_{q+1}k \cdot \Phi_i} + \sum_{i,k\neq 0} \mathfrak{D} v \mathfrak{D} \Phi_i^{-1} b_{i,k} e^{i\lambda_{q+1}k \cdot \Phi_i}.$$

First notice that, by using (9.11), (9.39), and (9.43), we obtain that

$$\left\|\mathfrak{D} v\mathfrak{D} \Phi_i^{-1} b_{i,k}\right\|_0 \lesssim rac{\delta_{q+1}^{\frac{1}{2}} \delta_q^{\frac{1}{2}} \lambda_q^{1+lpha}}{|k|^6}.$$

As for the coefficients $\mathfrak{D}\Phi_i^{-1}D_t b_{i,k}$, combining (9.39) and (9.46) gives

$$\left\|\mathfrak{D}\Phi_{i}^{-1}D_{t}b_{i,k}\right\|_{0} \lesssim \tau_{q}^{-1}\delta_{q+1}^{\frac{1}{2}}|k|^{-6} = rac{\delta_{q+1}^{\frac{1}{2}}\delta_{q}^{\frac{1}{2}}\lambda_{q}\ell_{q}^{-4lpha}}{|k|^{6}}.$$

Therefore

$$\|D_t w_o\|_0 \lesssim \delta_{q+1}^{\frac{1}{2}} \delta_q^{\frac{1}{2}} \lambda_q \ell_q^{-4\alpha}.$$

Observing that

$$D_t w_c = \sum_{i,k} \lambda_{q+1}^{-1} D_t c_{i,k} e^{i\lambda_{q+1}k \cdot \Phi_i}$$

which follows from $D_t e^{i\lambda_{q+1}k\cdot\Phi_i} = 0$ seen above, (9.47) implies

$$\|D_t w_c\|_0 \lesssim \delta_{q+1}^{\frac{1}{2}} \delta_q^{\frac{1}{2}} \lambda_q \ell_q^{-1-4\alpha} \lambda_{q+1}^{-1}$$

Combining with $||w_o||_0 + ||w_c||_0 \lesssim \delta_{q+1}^{\frac{1}{2}}$ and using (4.12)-(4.13), we obtain that

$$\begin{aligned} \left| \int_{\mathbb{T}^{3}} D_{t}(w_{o} \otimes w_{c} + w_{c} \otimes w_{o} + w_{c} \otimes w_{c}) \right| &\lesssim \|D_{t}w_{o}\|_{0} \|w_{c}\|_{0} + \|w_{o}\|_{0} \|D_{t}w_{c}\|_{0} + \|D_{t}w_{c}\|_{0} \|w_{c}\|_{0} \\ &\lesssim \delta_{q+1} \delta_{q}^{\frac{1}{2}} \lambda_{q} \ell_{q}^{-4\alpha} = \delta_{q+1}^{\frac{1}{2}} (\delta_{q+1}^{\frac{1}{2}} \delta_{q}^{\frac{1}{2}} \lambda_{q}) \ell_{q}^{-4\alpha} \\ &\lesssim \delta_{q+1}^{\frac{1}{2}} (\delta_{q+2} \lambda_{q+1}^{1-10} \alpha \lambda_{q+1}^{4\alpha} = \delta_{q+2} \delta_{q+1}^{\frac{1}{2}} \lambda_{q+1}^{1-6\alpha}. \end{aligned}$$

The second term of (9.71) is thus estimated. We then similarly decompose the first term in (9.71) as

$$\begin{split} D_t \left[\sum_{i,k\neq 0} \sigma_i \mathfrak{D} \Phi_i^{-1} C_k(\tilde{S}_i) \nabla \Phi_i^{-1} e^{i\lambda_{q+1}k \cdot \Phi_i} \right] &= \sum_{i,k\neq 0} D_t \sigma_i \mathfrak{D} \Phi_i^{-1} C_k(\tilde{S}_i) \nabla \Phi_i^{-1} e^{i\lambda_{q+1}k \cdot \Phi_i} \\ &+ \sum_{i,k\neq 0} \sigma_i \mathfrak{D} v \mathfrak{D} \Phi_i^{-1} C_k(\tilde{S}_i) \nabla \Phi_i^{-1} e^{i\lambda_{q+1}k \cdot \Phi_i} \\ &+ \sum_{i,k\neq 0} \sigma_i \mathfrak{D} \Phi_i^{-1} D_t [C_k(\tilde{S}_i)] \nabla \Phi_i^{-1} e^{i\lambda_{q+1}k \cdot \Phi_i} \\ &+ \sum_{i,k\neq 0} \sigma_i \mathfrak{D} \Phi_i^{-1} C_k(\tilde{S}_i) \nabla \Phi_i^{-1} \nabla v e^{i\lambda_{q+1}k \cdot \Phi_i}. \end{split}$$

In order to estimate this, we still need to estimate $D_t[C_k(\tilde{S}_i)]$ and $D_t\sigma_i$. To obtain the former, we first use (2.4):

$$\begin{aligned} \left\| D_{t}(C_{k}(\tilde{S}_{i})) \right\|_{N} &\leq \left\| (\mathfrak{D}_{2}C_{k})(\tilde{S}_{i}) \right\|_{N} \left\| D_{t}\tilde{S}_{i} \right\|_{0} + \left\| (\mathfrak{D}_{2}C_{k})(\tilde{S}_{i}) \right\|_{0} \left\| D_{t}\tilde{S}_{i} \right\|_{N} \\ &\lesssim \left(\left\| C_{k} \right\|_{N+1} \left\| \tilde{S}_{i} \right\|_{1}^{N} + \left\| C_{k} \right\|_{2} \left\| \tilde{S}_{i} \right\|_{N} \right) \left\| D_{t}\tilde{S}_{i} \right\|_{0} + \left\| C_{k} \right\|_{1} \left\| D_{t}\tilde{S}_{i} \right\|_{N} \end{aligned}$$

We then use (2.11), (9.42), and (9.45) to conclude that

$$\left\| D_t(C_k(\tilde{S}_i)) \right\|_N \lesssim |k|^{-6} \tau_q^{-1} \ell_{q,i}^{-N}.$$
 (9.72)

Coming to $D_t \sigma_i$, we claim that

$$\|D_t \sigma_i\|_N \lesssim \delta_{q+1} \tau_q^{-1} \ell_{q,i}^{-N}.$$

To obtain (9.73), we set

$$h(t) \coloneqq \sum_{j} \int \eta_{j}^{2}(x,t) dx$$
$$D_{t} \sigma_{i} = \frac{|\mathbb{T}^{3}| \psi^{2} \sigma}{h} 2\eta_{i} D_{t} \eta_{i} + |\mathbb{T}^{3}| \eta_{i}^{2} \partial_{t} \left(\frac{\psi^{2} \sigma}{h}\right) \eqqcolon I + II$$

We first estimate the term *I*. Recalling (9.28), (9.27), $\psi \leq 1$, and (9.7), we conclude that

$$\|I\|_{N} \lesssim \frac{|\mathbb{T}^{3}|\Psi^{2}\sigma}{h} (\|\eta_{i}\|_{N}\|D_{t}\eta_{i}\|_{0} + \|\eta_{i}\|_{0}\|D_{t}\eta_{i}\|_{N}) \lesssim \delta_{q+1}\tau_{q}^{-1}\ell_{q,i}^{-N}.$$

As for the second term, we already see that, since the only factor depending on *x* is η_i^2 which, by (9.28), satisfies $\|\eta_i^2\|_N \lesssim 1$ for all *N*, the estimates for *II* will only depend on *N* via an *a*-independent constant, thus making it sufficient to estimate $\partial_t(\psi^2 \sigma h^{-1})$ in C^0 . To that end, we rewrite it as

$$\partial_t \left(\frac{\psi^2 \sigma}{h} \right) = \frac{2\psi \psi' \sigma}{h} + \frac{\psi^2 \partial_t \sigma}{h} - \frac{\psi^2 \sigma h'}{h^2} =: T_1 + T_2 + T_3.$$

To estimate *T*₁, we recall (9.7), (9.6), and (9.27):

Coming to T_2 , by (9.7), (9.9), $\psi \leq 1$, and (9.27), we obtain that

$$\|T_2\|_0 \leq \frac{4C\delta_{q+1}\delta_q^{\frac{1}{2}}\lambda_q}{c_0} \lesssim \delta_{q+1}\tau_q^{-1}$$

where *C* is the implicit constant in (9.9). Finally, to estimate T_3 , we use (9.7), $\psi \le 1$, and (9.56):

$$\|T_3\|_0 \le \frac{4K\delta_{q+1}\tau_q^{-1}}{c_0^2} \lesssim \delta_{q+1}\tau_q^{-1}$$

where K is the implicit constant in (9.56). The estimate (9.73) is thus proved. By (9.73), (9.40), (9.60), (9.30), (9.11), and (9.72), we conclude that

$$\left| D_t \left[\sum_{i,k \neq 0} \sigma_i \mathfrak{D} \Phi_i^{-1} C_k(\tilde{S}_i) \nabla \Phi_i^{-1} e^{i\lambda_{q+1}k \cdot \Phi_i} \right] \right\|_0 \lesssim \delta_{q+1} \tau_q^{-1} = \delta_{q+1} \delta_q^{\frac{1}{2}} \lambda_q \ell_q^{-4\alpha} \lesssim \delta_{q+1} \delta_{q+1}^{\frac{1}{2}} \lambda_{q+1}^{1-6\alpha},$$

the last step being exactly as done above. Finally, to estimate the term involving $D_t(w \cdot v)$, we first note that

$$\int D_t(v \cdot w) = \int D_t v \cdot w + \int v \cdot D_t w = -\int (\nabla p + (-\Delta)^{\theta} v + \operatorname{div} R) \cdot w + \int v \cdot D_t w, \qquad (9.74)$$

using (3.1) in the last step. To estimate the second term of (9.74), we write

By Lemma 2.1, we obtain that

$$\begin{split} \|h_{i,k}\|_{N} &\lesssim \|v\|_{N} \bigg(\left\| D_{t} \mathfrak{D} \Phi_{i}^{-1} \right\|_{0} \|b_{i,k}\|_{0} + \left\| \mathfrak{D} \Phi_{i}^{-1} \right\|_{0} \|D_{t} b_{i,k}\|_{0} + \frac{1}{\lambda_{q+1}} \|D_{t} c_{i,k}\|_{0} \bigg) \\ &+ \|v\|_{0} \bigg(\left\| D_{t} \mathfrak{D} \Phi_{i}^{-1} \right\|_{N} \|b_{i,k}\|_{0} + \left\| D_{t} \mathfrak{D} \Phi_{i}^{-1} \right\|_{0} \|b_{i,k}\|_{N} \\ &+ \|\mathfrak{D} \Phi_{i}\|_{N} \|D_{t} b_{i,ki}\|_{0} + \left\| \mathfrak{D} \Phi_{i}^{-1} \right\|_{0} \|D_{t} b_{i,k}\|_{N} + \frac{1}{\lambda_{q+1}} \|D_{t} c_{i,k}\|_{N} \bigg). \end{split}$$

Thus, using (9.4), (9.11) (in the form $||v||_{N+\alpha} \leq \delta_q^{\frac{1}{2}} \lambda_q^{1+\alpha} \ell_{q,i}^{1-N} \leq \tau_q^{-1} \ell_q^{-N}$), (9.43)-(9.44), (9.46)-(9.47), and (9.40)-(9.41), we conclude that

$$\|h_{i,k}\|_N \lesssim \delta_{q+1}^{\frac{1}{2}} \tau_q^{-1} \ell_q^{-N} = \delta_{q+1}^{\frac{1}{2}} \delta_q^{\frac{1}{2}} \lambda_q \ell_q^{-4\alpha-N}.$$

With Lemma 2.4, the above estimate yields that $\int v \cdot D_t w$ satisfies (9.21). To deal with the first term of (9.74), we first note that, since div w = 0, $\int \nabla p \cdot w = 0$. Integrating by parts, the term $\int \text{div } R \cdot w$ can be estimated as follows:

$$\left|\int \operatorname{div} \boldsymbol{R} \cdot \boldsymbol{w} \mathrm{d}\boldsymbol{x}\right| \leq \|\boldsymbol{R}\|_1 \|\boldsymbol{w}\|_0 \lesssim \Lambda \varrho^{1+\gamma} \ell_q^{-2\alpha} \ell_{q,i}^{-1} \cdot \delta_{q+1}^{\frac{1}{2}} \lesssim \Lambda^{\frac{1}{2}} \zeta_{q+1}^{\frac{1+\gamma}{2}} \delta_q^{\frac{1}{2}} \lambda_q^{1+\alpha} \ell_q^{-3\alpha} \cdot \delta_{q+1}^{\frac{1}{2}},$$

where we used (9.2) and (9.3). To conclude that the first term in (9.74) satisfies (9.21), we would require

$$\zeta_{q+1}^{\frac{1+\gamma}{2}} \zeta_{q}^{\frac{1}{2}} \lambda_{q}^{1+\alpha} \ell_{q}^{-3\alpha} \lesssim \zeta_{q+2} \lambda_{q+1}^{1-6\alpha}.$$
(9.75)

For α, γ sufficiently small, this follows from

$$-b\beta - \beta + 1 < -2b^{2}\beta + b \iff 1 - \beta - 2b\beta < b(1 - \beta - 2b\beta) \iff 1 - \beta - 2b\beta > 0$$

which in turn follows from (4.2).

Step 7: \mathcal{T}_p and its derivative

The time derivative $\partial_t \mathcal{T}_p$ is readily estimated as

$$\begin{aligned} |\partial_t \mathcal{T}_p| &= \left| \int\limits_{\mathbb{T}^3} (-\Delta)^{\frac{\theta}{2}} (2v+w) \cdot (-\Delta)^{\frac{\theta}{2}} w \mathrm{d}x \right| \\ &\leq \left| \int\limits_{\mathbb{T}^3} 2(-\Delta)^{\frac{\theta}{2}} v \cdot (-\Delta)^{\frac{\theta}{2}} w \mathrm{d}x \right| + \int\limits_{\mathbb{T}^3} \left| (-\Delta)^{\frac{\theta}{2}} w \right|^2 \mathrm{d}x \\ &\lesssim (2\|v\|_{\theta+\varepsilon} \|w\|_0^{1-\theta-\varepsilon} \|w\|_1^{\theta+\varepsilon} + \|w\|_0^{2-2\theta-2\varepsilon} \|w\|_1^{2\theta+2\varepsilon}). \end{aligned}$$

By (9.12), we have that $||v||_{\theta+\varepsilon} \leq \Lambda^{\frac{1}{2}}$. As for *w*, we have that $||w||_N \leq \delta_{q+1}^{\frac{1}{2}} \lambda_{q+1}^N$ (cfr. Step 3 above). Thus, recalling that $\theta + \varepsilon < \beta$

$$\partial_t \mathcal{T}_p | \lesssim 2\Lambda^{\frac{1}{2}} \cdot \Lambda^{\frac{1}{2}} \lambda_{q+1}^{\theta + \varepsilon - \beta} + \Lambda \lambda_{q+1}^{2\theta + 2\varepsilon - 2\beta} \lesssim \Lambda \lambda_{q+1}^{\theta + \varepsilon - \beta}$$

Since this is exactly (9.22), the proposition is proved.

Remark 9.1 (The fractional dissipation term). Note that (9.22) is stronger than (9.21), since

$$\Lambda\lambda_{q+1}^{\theta+\varepsilon-\beta} = \Lambda^{\frac{1}{2}}\delta_{q+1}^{\frac{1}{2}}\lambda_{q+1}^{\theta+\varepsilon} \lesssim \delta_{q+1}^{\frac{1}{2}}\delta_{q+2}\lambda_{q+1}^{1-6\alpha}.$$

Indeed, this inequality follows from $\theta + \varepsilon - \beta < 1 - 6\alpha - \beta - 2b\beta$ which, for α, ε sufficiently small, follows from (4.2) and the fact $\theta < \beta$.

However, \mathcal{T}_p *is only estimated as follows:*

$$|\mathcal{T}_p(t)| \lesssim t \Lambda \lambda_{q+1}^{\theta + \varepsilon - \beta}.$$

To ensure that this satisfies (9.20) for any $q \ge 0$, we would require

$$0 < \theta + \varepsilon - \beta < -2b^2\beta - 3b\alpha \iff 3b\alpha < \beta - \theta - \varepsilon - 2b^2\beta.$$

Seen as the above right-hand side is, in general, negative, we cannot require it. Thus, in general, \mathcal{T}_p only satisfies (9.20) if the q in the statement is sufficiently large, which is why we separated \mathcal{T}_p from the other Reynolds terms. However, for $t \leq \Lambda^{-1} \lambda_{q+1}^{\beta-\epsilon-\theta}$, we can contrast the growth of $\Lambda \lambda_{q+1}^{\theta+\epsilon-\beta}$ with the smallness of the time, meaning that \mathcal{T}_p only satisfies (9.20) for a short period of time, or if q is sufficiently large.

Remark 9.2 (C^0 estimate on the Reynolds stress). *The requirement* (9.2) *is only used to obtain* (9.21), *meaning we only need it on* supp *S*, *since* $S = 0 \implies \mathcal{E} = 0$.

10 From strict to adapted subsolutions

The aim of this section is to prove **Proposition 5.1** (p. 11). The proof closely follows the arguments of [13, Section 8]. Each stage contains a localized gluing step performed using **Proposition 8.1**, and a perturbation step performed using **Proposition 9.1**.

Proof. (Proposition 5.1)

Step 1: Setting the parameters of the scheme

Let $(\tilde{v}, \tilde{p}, \tilde{R})$ be a smooth strict subsolution and let $0 < \hat{\beta} < \beta < \frac{1}{3}, \nu > 0$. Choose b > 1 according to (4.2), furthermore let $\tilde{\varepsilon} > 0$ such that:

$$b(1+\tilde{\varepsilon}) < \frac{1-\beta}{2\beta}.$$
(10.1)

Then, let $\tilde{\delta}, \tilde{\gamma} > 0$ be the constants given by **Corollary 7.1**, and choose $0 < \alpha < 1$ and $0 < \gamma < \hat{\gamma} < \tilde{\gamma}$ so that:

 \diamond

- The inequalities (4.12), (4.13) are satisfied by both the pairs (α, γ) and $(\alpha, \hat{\gamma})$;
- The other conditions in Sections 8 and 9, namely (8.9)-(8.10) and consequently (9.1), (9.65), and (9.75), are satisfied by both the pairs (α, γ) and (α, γ̂);
- Condition (4.14) can hold for both pairs (α, γ) and $(\alpha, \hat{\gamma})$; since $\hat{\gamma} > \gamma$, relation (4.15) reduces this to:

$$(b-1)(1-\beta(b+1)) - \hat{\gamma}\beta b^2 - 2\alpha b > 0; \tag{10.2}$$

• The following conditions holds:

$$\nu > \frac{1 - 3\beta + \alpha}{2\beta} \tag{10.3}$$

$$\frac{\alpha}{\beta} < b\hat{\gamma} < \frac{3\alpha}{2\beta}, \qquad \qquad 0 < b\gamma < \hat{\gamma} - \frac{\alpha}{\beta}, \qquad \qquad 3\alpha > 2b\beta\gamma. \tag{10.4}$$

Having fixed $b, \beta, \alpha, \gamma, \hat{\gamma}$, we may choose $\overline{N} \in \mathbb{N}$ so that (4.14) is also valid. For $a \gg 1$ sufficiently large (to be determined) we then define (λ_q, δ_q) as in (4.1). Thus we are in the setting of Section 4.

Step 2: From strict to strong subsolution

We apply **Corollary 7.1** to obtain from $(\tilde{v}, \tilde{p}, \tilde{R})$ a strong subsolution (v_0, p_0, R_0) with $\delta = \delta_1$ such that the properties from (7.12) to (7.16) hold. By (7.12)-(7.16), (v_0, p_0, R_0) satisfies

$$\frac{3}{4}\delta_1 \le \rho_0 \le \frac{5}{4}\delta_1 \tag{10.5}$$

$$\left\|\ddot{R}_{0}(t)\right\|_{0} \leq \Lambda \varrho_{0}^{1+\gamma} \tag{10.6}$$

$$\|v_0\|_{H^{-1}} \le \lambda_0^{-1} \tag{10.7}$$

$$|\partial_t \rho_0| \le \delta_1 \delta_0^{\frac{1}{2}} \lambda_0 . \|\nu_0\|_{1+\alpha} \le \delta_0^{\frac{1}{2}} \lambda_0^{1+\alpha}$$
(10.8)

$$|\partial_t \rho_0| \le \delta_1 \delta_0^2 \lambda_0. \tag{10.9}$$

Step 3: Inductive construction of (v_q, p_q, R_q)

Starting from (v_0, p_0, R_0) , we show how to inductively construct a sequence $\{(v_q, p_q, R_q)\}_{q \in \mathbb{N}}$ of smooth strong subsolutions with:

$$R_q(x,t) = \rho_q(t) \operatorname{Id} + \check{R}_q(x,t)$$

which satisfy the following properties:

 (a_q) For all $t \in [0,T]$

$$\int_{\mathbb{T}^3} (|v_q|^2 + \operatorname{tr} R_q) dx = \int_{\mathbb{T}^3} (|v_0|^2 + \operatorname{tr} R_0) dx;$$

 (b_q) For all $t \in [0,T]$

$$\left\|\mathring{R}_{q}(t)\right\|_{0} \leq \Lambda \varrho_{q}^{1+\gamma};$$

 (c_q) If $2^{-j}T < t \le 2^{-j+1}T$ for some $j = 1, \dots, q$, then

$$\frac{3}{8}\delta_{j+1} \le \rho_q \le 4\delta_j;$$

 (d_q) For all $t \leq 2^{-q}T$:

$$\|\mathring{R}_q(t)\|_0 \leq \Lambda \varrho_q^{1+\hat{\gamma}}, \qquad \qquad \frac{3}{4}\delta_{q+1} \leq \rho_q \leq \frac{5}{4}\delta_{q+1};$$

 (e_q) If $2^{-j}T < t \le 2^{-j+1}T$ for some j = 1, ..., q, then

$$\left\| v_q \right\|_{1+\alpha} \leq M \delta_j^{\frac{1}{2}} \lambda_j^{1+\alpha} \\ \left| \partial_t \rho_q \right| \lesssim \delta_{j+1} \delta_j^{\frac{1}{2}} \lambda_j,$$

whereas if $t \leq 2^{-q}T$

$$\left\| v_q - v_{q-1} \right\|_{H^{-1}} \le M \delta_q^{\frac{1}{2}} (\zeta_q^{\frac{1}{2}} \ell_{q-1}^{\alpha} + \ell_{q-1}^{-1} \lambda_q^{-1}) \qquad \left\| v_q - v_{q-1} \right\|_0 \le M \delta_q^{\frac{1}{2}}.$$

 $(g_q) \|v_q\|_{\theta+\varepsilon} \le M(1+\Lambda^{\frac{1}{2}}\sum_{i=0}^q \lambda_i^{\theta+\varepsilon-\beta}).$

Thanks to our choice of parameters in Step 1 above, (v_0, p_0, R_0) satisfies (10.5)-(10.9), and thus the inductive assumptions (a_0) - (g_0) (the last condition can be deduced from (7.18)).

Suppose then (v_q, p_q, R_q) is a smooth strong subsolution which satisfies (a_q) - (g_q) . The construction of $(v_{q+1}, p_{q+1}, R_{q+1})$ consists of two steps: first a localized gluing step performed using **Proposition 8.1** to get from (v_q, p_q, R_q) to a smooth strong subsolution $(\overline{v}_q, \overline{p}_q, \overline{R}_q)$, then a localized perturbation step done using **Proposition 9.1** to get $(v_{q+1}, p_{q+1}, R_{q+1})$ from $(\overline{v}_q, \overline{p}_q, \overline{R}_q)$. V

$$[T_1, T_2] = [0, 2^{-q}T].$$

Then $T_2 - T_1 \ge 4\tau_q$, if $a \gg 1$ is sufficiently large. Moreover, by (d_q) , (e_q) , and (g_q) , (v_q, p_q, R_q) fulfils the requirements of **Proposition 8.1** on $[T_1, T_2]$ with parameters $\alpha, \hat{\gamma} > 0$.

Then, by **Proposition 8.1**, we obtain a smooth strong subsolution $(\overline{v}_q, \overline{p}_q, \overline{R}_q)$ on [0, T] such that $(\overline{v}_q, \overline{p}_q, \overline{R}_q)$ is equal to (v_q, p_q, R_q) on $[2^{-q}T, T]$, and on $[0, 2^{-q}T]$ satisfies

$$\begin{aligned} \left| \overline{v}_{q} - v_{q} \right\|_{\alpha} &\lesssim \Lambda^{\frac{1}{2}} \overline{\mathbf{o}}_{q}^{\frac{1+\hat{\gamma}}{2}} \ell_{q}^{\alpha} \\ \left\| \overline{v}_{q} \right\|_{1+\alpha} &\lesssim \delta_{q}^{\frac{1}{2}} \lambda_{q}^{1+\alpha} \\ \left\| \overline{v}_{q} \right\|_{\theta+\varepsilon} &\lesssim 1 + \sum_{i=0}^{q+1} \delta_{i}^{\frac{1}{2}} \lambda_{i}^{\theta+\varepsilon} \\ \left\| \ddot{R}_{q} \right\|_{0} &\leq \Lambda \overline{\mathbf{o}}_{q}^{1+\hat{\gamma}} \ell_{q}^{-2\alpha} \\ &\frac{5}{8} \delta_{q+1} \leq \overline{\rho}_{q} \leq \frac{3}{2} \delta_{q+1} \\ \left| \partial_{t} \overline{\rho}_{q} \right| &\lesssim \delta_{q+1} \delta_{q}^{\frac{1}{2}} \lambda_{q}. \end{aligned}$$
(10.10)

Moreover, on $[0, t_{\overline{n}}]$ one has that

$$\begin{aligned} \left\| \overline{v}_{q} \right\|_{N+1+\alpha} &\lesssim \delta_{q}^{\frac{1}{2}} \lambda_{q}^{1+\alpha} \ell_{q}^{-N} \\ \left\| \mathring{R}_{q} \right\|_{N+\alpha} &\lesssim \Lambda \overline{\varrho}_{q}^{1+\hat{\gamma}} \ell_{q}^{-N-2\alpha} \\ \left| (\partial_{t} + \overline{v}_{q} \cdot \nabla) \mathring{R}_{q} \right\|_{N+\alpha} &\lesssim \Lambda \overline{\varrho}_{q}^{1+\hat{\gamma}} \ell_{q}^{-N-6\alpha} \delta_{q}^{\frac{1}{2}} \lambda_{q}. \end{aligned}$$
(10.11)

and

$$\overset{\circ}{\overline{R}}_{q} \equiv 0 \qquad t \in \bigcup_{i=0}^{\overline{n}} J_{i}.$$
(10.12)

Recalling **Definition 8.1** and (8.5) observe that

$$\left[0,\frac{3}{4}2^{-q}T\right] \subset [0,t_{\overline{n}}],\tag{10.13}$$

provided $a \gg 1$ is chosen sufficiently large (e.g. so that $\frac{5}{3}\tau_q < \frac{1}{4}2^{-q}T$). Then, choose a cut-off function $\psi_q \in C_C^{\infty}([0, \frac{3}{4}2^{-q}T]; [0, 1])$ such that

$$\Psi_q(t) = \begin{cases} 1 & t \le 2^{-(q+1)}T \\ 0 & t > \frac{3}{4}2^{-q}T \end{cases}$$
(10.14)

and such that $|\psi'_q(t)| \lesssim 2^q$. By choosing $a \gg 1$ sufficiently large, we may assume that

$$\left|\psi_{q}'(t)\right| \leq \frac{1}{2}\delta_{q}^{\frac{1}{2}}\lambda_{q} \tag{10.15}$$

for all q. Then, set

$$S_{\Psi} \coloneqq \Psi_q^2(\overline{R}_q - \delta_{q+2} \operatorname{Id}) = \Psi_q^2 S.$$

Using (10.15), (10.4), (10.10)-(10.13), and the easy observation that $\overline{\rho}_q \leq \overline{\rho}_q - \delta_{q+2}$, we see that S_{Ψ} and $(\overline{\nu}_q, \overline{p}_q, \overline{R}_q)$ satisfy the assumptions of **Proposition 9.1** on the interval $[0, t_{\overline{n}}]$ with parameters $\alpha, \hat{\gamma} > 0$. We have that

$$\sigma_{\Psi} = \Psi_q^2 (\overline{\rho}_q - \delta_{q+2}) = \Psi_q^2 \sigma_{-1}$$

Recalling **Remark 9.2**, since supp $S_{\Psi} \subseteq [t_{\underline{n}}, t_{\overline{n}}]$ where (8.25) holds, we can apply **Proposition 9.1**, thus obtaining a new subsolution $(v_{q+1}, p_{q+1}, \overline{R}_q - S_{\Psi} - \mathcal{E}_{q+1})$ with

$$\begin{split} \|v_{q+1} - \overline{v}_q\|_0 + \ell_q \lambda_{q+1} \|v_{q+1} - \overline{v}_q\|_{H^{-1}} \\ + \lambda_{q+1}^{-1-\alpha} \|v_{q+1} - \overline{v}_q\|_{1+\alpha} \\ + \lambda_{q+1}^{-\theta-\varepsilon} \|v_{q+1} - \overline{v}_q\|_{\theta+\varepsilon} \le M \delta_{q+1}^{\frac{1}{2}} \\ \int_{\mathbb{T}^3} |v_{q+1}|^2 - \operatorname{tr} S - \operatorname{tr} \mathcal{E}_{q+1} = \int_{\mathbb{T}^3} |\overline{v}_q|^2 \qquad t \in [0,T], \end{split}$$

and such that the estimates (9.20) and (9.21) hold for \mathcal{E}_{q+1} . Let

 $R_{q+1} \coloneqq \overline{R}_q - S_{\Psi} - \mathcal{E}_{q+1}.$

We claim that $(v_{q+1}, p_{q+1}, R_{q+1})$ is a smooth strong subsolution satisfying (a_{q+1}) - (g_{q+1}) . Notice that (a_{q+1}) is satisfied by construction. Since $(v_{q+1}, p_{q+1}, R_{q+1}) = (v_q, p_q, R_q)$ for $t \ge 2^{-q}T$, we may restrict t to $[0, 2^{-q}T]$ in the following, so that in particular (10.10) holds.

Let us now prove (b_{q+1}) . On the one hand

$$\begin{aligned} \left\| \mathring{R}_{q+1} \right\|_{0} &= \left\| (1 - \psi_{q}^{2}) \mathring{\overline{R}}_{q} - \mathring{\mathcal{E}}_{q+1} \right\|_{0} \\ &\leq (1 - \psi_{q}^{2}) \Lambda \overline{\varrho}_{q}^{1+\hat{\gamma}} \ell_{q}^{-2\alpha} + \delta_{q+2} \lambda_{q+1}^{-3\alpha} \mathbb{1}_{\{\psi_{q} > 0\}}, \end{aligned}$$
(10.16)

on the other hand

$$\rho_{q+1} = (1 - \psi_q^2)\Lambda \overline{\varrho}_q + \psi_q^2 \delta_{q+2} + \frac{1}{3} \operatorname{tr} \mathcal{E}_{q+1} \geq (1 - \psi_q^2)\overline{\rho}_q + \psi_q^2 \delta_{q+2} - \delta_{q+2} \lambda_{q+1}^{-3\alpha} \mathbb{1}_{\{\psi_q > 0\}}.$$
(10.17)

The proof of (b_{q+1}) thus reduces to assessing whether there exists a suitable γ such that

$$(1 - \psi_q^2)\Lambda^{-\hat{\gamma}}\overline{\rho}_q^{1+\hat{\gamma}}\ell_q^{-2\alpha} + \delta_{q+2}\lambda_{q+1}^{-3\alpha}\mathbb{1}_{\{\psi_q > 0\}} \le \Lambda^{-\gamma}[(1 - \psi_q^2)\overline{\rho}_q + \psi_q^2\delta_{q+2} - \delta_{q+2}\lambda_{q+1}^{-3\alpha}]^{1+\gamma}.$$
(10.18)

To this end set

$$\begin{split} F(s) &\coloneqq (1-s)\Lambda \overline{\varrho}_q^{1+\hat{\gamma}} \ell_q^{-2\alpha} + \delta_{q+2} \lambda_{q+1}^{-3\alpha} \\ G(s) &\coloneqq (1-s) \overline{\rho}_q + s \delta_{q+2} - \delta_{q+2} \lambda_{q+1}^{-3\alpha} \\ H(s) &\coloneqq \Lambda^{-\gamma} G^{1+\gamma}(s) - F(s), \end{split}$$

and observe that (10.18) is equivalent to $H(\psi_q^2) \ge 0$ if $\psi_q > 0$, and follows from this inequality also in case $\psi_q = 0$. In particular, (10.18) follows from:

- (i) $H(0) \ge 0$ and $H(1) \ge 0$;
- (ii) $H'(0) \le 0$ and $H'(1) \le 0$.
- (iii) $H''(s) \ge 0$.

We note next that, since $2b\beta\hat{\gamma} < 3\alpha$

$$\delta_{q+2}\lambda_{q+1}^{-3lpha}\lesssim\Lambda\overline{\varrho}_{q}^{1+\hat{\gamma}},$$

so that we have the estimates

$$F(0) \lesssim \Lambda \overline{\varrho}_q^{1+\hat{\gamma}} \ell_q^{-2lpha}, \qquad \qquad G(0) \gtrsim \overline{\rho}_q$$

It is also clear that $G(s) \leq \overline{\rho}_q$.

It is then easy to check that the requirement $H(0) \ge 0$, i.e. $F(0) \le \Lambda^{-\gamma} G^{1+\gamma}(0)$, amounts to $\Lambda \overline{\varrho}_q^{1+\hat{\gamma}} \ell_q^{-2\alpha} \le \Lambda \overline{\varrho}_q^{1+\gamma}$, i.e. $\overline{\varrho}_q^{\hat{\gamma}-\gamma} \ell_q^{-2\alpha} \le 1$. Hence, since $\ell_q^{-1} \le \lambda_{q+1}$ by (4.13) and $\overline{\varrho}_q \gtrsim \zeta_{q+1}$ by (d_{q+1}) , $H(0) \ge 0$ follows from

$$\hat{\gamma} - \frac{\alpha}{\beta} > \gamma, \tag{10.19}$$

provided $a \gg 1$ is sufficiently large to absorb geometric constants. The relation (10.19) follows from (10.4) since b > 1.

The next requirement, $H(1) \ge 0$, i.e. $\lambda_{q+1}^{-3\alpha} \le \zeta_{q+2}^{\gamma} (1 - \lambda_{q+1}^{-3\alpha})^{1+\gamma}$, requires $3\alpha > 2b\beta\gamma$ as found in (10.4), since $1 - \lambda_{q+1}^{-3\alpha} \ge \frac{1}{2}$ for *a* sufficiently large.

The following condition, $H'(0) \le 0$, can be rewritten as

$$-\Lambda \overline{\mathfrak{q}}_{q}^{1+\hat{\gamma}} \ell_{q}^{-2\alpha} \geq (1+\gamma) (\overline{\mathfrak{q}}_{q} - \zeta_{q+2} \lambda_{q+1}^{-3\alpha})^{\gamma} (\delta_{q+2} - \overline{\rho}_{q}) \Longleftrightarrow \Lambda \overline{\mathfrak{q}}_{q}^{1+\hat{\gamma}} \ell_{q}^{-2\alpha} \lesssim (\overline{\mathfrak{q}}_{q} - \zeta_{q+2} \lambda_{q+1}^{-3\alpha})^{\gamma} (\overline{\rho}_{q} - \delta_{q+2}).$$

Noting that $\overline{\rho}_q \gtrsim \delta_{q+1} \gg \delta_{q+2}$ by (d_{q+1}) , and therefore $\overline{\rho}_q - \delta_{q+2} \ge \frac{1}{2}\overline{\rho}_q$ for *a* sufficiently large, the above reduces to

$$\overline{\varrho}_{q}^{\hat{\gamma}-\gamma}\ell_{q}^{-2\alpha} \lesssim 1 \longleftrightarrow \lambda_{q+1}^{2\alpha-2\beta\hat{\gamma}+2\beta\gamma} = \zeta_{q+1}^{\hat{\gamma}-\gamma}\lambda_{q+1}^{2\alpha} \lesssim 1,$$

which follows from condition (10.19) deduced above.

We then need the condition $H'(1) \leq 0$, which can be rewritten as

$$-\Lambda \overline{\varrho}_q^{1+\hat{\gamma}} \ell_q^{-2\alpha} \ge (1+\gamma) \zeta_{q+2}^{\gamma} (1-\lambda_{q+1}^{-3\alpha})^{\gamma} (\delta_{q+2}-\overline{\rho}_q),$$

which similarly follows from (10.19).

The last condition, $H'' \ge 0$, follows from the fact that $F'' \equiv 0$ and $G'' \equiv 0$, and thus $H'' = \Lambda^{-\gamma} (1+\gamma)\gamma G^{\gamma-1} G'^2$ is positive.

Thus, our choice of $\alpha, \gamma, \hat{\gamma}$ in (10.4) guarantees that (10.18) holds, which yields (b_{q+1}) .

Consider now (c_{q+1}) , where we only need to consider the case j = q+1, i.e. the estimate on $[2^{-q-1}T, 2^{-q}T]$. Using (10.17), the fact that $\overline{\rho}_q \ge \delta_{q+2}$ for *a* large enough, and (10.10), we see that

$$\delta_{q+2}(1-\lambda_{q+1}^{-3\alpha}) \leq \rho_{q+1}(t) \leq \overline{\rho}_q(t) + \delta_{q+2}\lambda_{q+1}^{-3\alpha} \leq \frac{3}{2}\delta_{q+1} + \delta_{q+2}\lambda_{q+1}^{-3\alpha}.$$

Therefore (c_{q+1}) holds, provided $a \gg 1$ is sufficiently large.

Similarly, concerning (d_{q+1}) , observe that for $t \leq 2^{-(q+1)}T$ we have that $\psi_q(t) = 1$, so that

$$\delta_{q+2}(1-\lambda_{q+1}^{-3\alpha}) \le \rho_{q+1} \le \delta_{q+2}(1+\lambda_{q+1}^{-3\alpha}).$$

Moreover, using (10.16) and the fact that $\psi_q = 1$ for $t \leq 2^{-(q+1)}T$

$$\left\| \mathring{R}_{q+1} \right\|_0 \leq \delta_{q+2} \lambda_{q+1}^{-3\alpha} \leq \Lambda \left(\frac{3}{4} \zeta_{q+2} \right)^{1+\hat{\gamma}},$$

where we used the fact that $2b\beta\hat{\gamma} < 3\alpha$ and chose $a \gg 1$ sufficiently large. Therefore (d_{q+1}) , i.e. $\|\mathring{R}_{q+1}\|_0 \lesssim \Lambda \varrho_{q+1}^{1+\hat{\gamma}}$ and $\frac{3}{4}\delta_{q+2} \leq \rho_{q+1} \leq \frac{5}{4}\delta_{q+2}$, holds.

Concerning (e_{q+1}) , it is once more enough to restrict to $t \le 2^{-q}T$, i.e. the case j = q+1. From (10.10) and (9.18) we deduce that

$$\begin{split} \left\| v_{q+1} \right\|_{1+\alpha} &\leq \left\| v_{q+1} - \overline{v}_q \right\|_{1+\alpha} + \left\| \overline{v}_q \right\|_{1+\alpha} \\ &\leq \frac{M}{2} \delta_{q+1}^{\frac{1}{2}} \lambda_{q+1}^{1+\alpha} + C \delta_q^{\frac{1}{2}} \lambda_q^{1+\alpha} \\ &\leq M \delta_{q+1}^{\frac{1}{2}} \lambda_{q+1}^{1+\alpha}, \end{split}$$

where *C* is the implicit constant in (10.10), which can be absorbed by choosing $a \gg 1$ sufficiently large. The estimate on $|\partial_t \rho_{q+1}|$ similarly follows from the trace estimate of (10.10) and (9.21). (e_{q+1}) is thus proved. (f_{q+1}) follows from (10.10), (9.17), and (9.16).

Finally, (g_{q+1}) easily follows from (9.19) and (10.10).

Step 4: Convergence to an adapted subsolution

We have thus obtained a sequence (v_q, p_q, R_q) satisfying (a_q) - (g_q) . From (f_q) it follows that (v_q, p_q) is a Cauchy sequence in C^0 . Indeed, it is clear for $\{v_q\}$, and concerning $\{p_q\}$ we may use (3.1) to write

$$\Delta(p_{q+1} - p_q) = -\operatorname{div}\operatorname{div}(\mathring{R}_{q+1} - \mathring{R}_q + (v_{q+1} - v_q) \otimes v_q + v_{q+1} \otimes (v_{q+1} - v_q)),$$

and apply Schauder estimates (Lemma 2.5). Similarly, $\{R_q\}$ also converges in C^0 . Indeed, from the definition and using (8.20), (8.12), (9.10), (9.20), and (b_q) , we have that

$$\begin{aligned} \left\| R_{q+1} - R_q \right\|_0 &= \left\| \overline{R}_q - R_q - S_{\Psi} - \mathcal{E}_{q+1} \right\|_0 \\ &\leq \left\| \overline{R}_q \right\|_0 + \left\| R_q \right\|_0 + \left\| S_{\Psi} \right\|_0 + \left\| \mathcal{E}_{q+1} \right\|_0 \\ &\lesssim \delta_{q+1}. \end{aligned}$$

For all t > 0 there exists $q(t) \in \mathbb{N}$ such that

$$(v_q, p_q, R_q)(\cdot, t) = (v_{q(t)}, p_{q(t)}, R_{q(t)})(\cdot, t) \qquad \forall q \ge q(t),$$

thus (v_q, p_q, R_q) converges uniformly to a strong subsolution $(\hat{v}, \hat{p}, \hat{R})$ satisfying

$$\|\hat{R}\|_0 \leq \Lambda \hat{\varrho}^{1+\gamma}$$

and, using (7.11) and (a_q)

$$\int_{\mathbb{T}^3} \left(|\hat{v}|^2 + \operatorname{tr} \hat{R} \right) \mathrm{d}x = \int_{\mathbb{T}^3} \left(|\tilde{v}|^2 + \operatorname{tr} \tilde{R} \right) \mathrm{d}x \qquad \forall t \in [0, T].$$

Furthermore, using (7.14) and (f_q)

$$\begin{split} \|\hat{v} - \tilde{v}\|_{H^{-1}} &\leq \|v_0 - \tilde{v}\|_{H^{-1}} + \|v_0 - \hat{v}\|_{H^{-1}} \\ &\lesssim \delta_1 \lambda_0^{-1} + \sum_{q=0}^{\infty} \|v_{q+1} - v_q\|_{H^{-1}} \\ &\lesssim \delta^{\frac{1}{2}} \zeta_q^{\frac{\gamma}{2}} \ell_q^{\alpha}, \end{split}$$

leading to (5.3) for a sufficiently large. Using (f_q) and the fact that \tilde{v}, \check{v} are smooth and thus bounded in C^0 , (5.2) is proved similarly:

$$\begin{split} \|\hat{v} - \tilde{v}\|_{C^{0}} &\leq \|v_{0} - \tilde{v}\|_{C^{0}} + \|v_{0} - \hat{v}\|_{C^{0}} \\ &\lesssim 1 + \sum_{q=0}^{\infty} \|v_{q+1} - v_{q}\|_{0} \\ &\lesssim 1 + \delta_{1}^{\frac{1}{2}}. \end{split}$$

Concerning the initial datum, from (e_q) and (f_q) we obtain by interpolation that $\hat{v}(\cdot, 0) \in C^{\hat{\beta}}$, and from (d_q) we obtain that $\hat{R}(\cdot, 0) = 0$.

Finally, we verify conditions (3.5), and (3.6) for being a $C^{\hat{\beta}}$ -adapted subsolution. Let t > 0. Then there exists $q \in \mathbb{N}$ such that $t \in [2^{-q}T, 2^{-q+1}T]$. By (c_q) and (e_q)

$$\frac{3}{8}\delta_{q+1} \le \hat{\rho} \le 4\delta_q$$
$$\|\hat{v}\|_{1+\alpha} \le M\delta_q^{\frac{1}{2}}\lambda_q^{1+\alpha}$$

Therefore $\hat{\rho}^{-1} \ge \frac{1}{4} \delta_q^{-1}$, and hence, using (4.1) and (10.3), we deduce that

$$\|\hat{\boldsymbol{\nu}}\|_{1+\alpha} \leq \Lambda^{\frac{1}{2}} \hat{\boldsymbol{\varrho}}^{-(1+\nu)},$$

for $a \gg 1$ sufficiently large. Similarly, using (e_q) and (10.3), we deduce that

$$|\partial_t \hat{\rho}| \lesssim \delta_{q+1} \delta_q^{\frac{1}{2}} \lambda_q = \Lambda^{\frac{3}{2}} \lambda_q^{1-\beta} \lambda_{q+1}^{-2\beta} \sim \Lambda^{\frac{3}{2}} \lambda_q^{1-\beta-2b\beta} = \Lambda^{\frac{3}{2}} \zeta_q^{-\frac{1}{2\beta}(1-\beta-2b\beta)} \leq \Lambda^{\frac{3}{2}} \zeta_q^{1-\frac{1-\beta}{2\beta}} \lesssim \Lambda^{\frac{3}{2}} \hat{\varrho}^{-\nu}.$$

Finally, a word about the term

$$\hat{\mathcal{T}} \coloneqq \sum (\mathcal{T}_g^{(q)} + \mathcal{T}_d^{(q)}),$$

where $\mathcal{T}_{g}^{(q)}$ and $\mathcal{T}_{d}^{(q)}$ are the extra trace terms from the *q*th gluing and perturbation steps. We have that $|\partial_t \mathcal{T}_{g}^{(q)}| + |\partial_t \mathcal{T}_{d}^{(q)}| \leq \Lambda \lambda_q^{\theta+\varepsilon-\beta}$, thus proving (5.5). However, adding $\hat{\mathcal{T}}$ into \hat{R} could compromise the adaptedness of $(\hat{v}, \hat{p}, \hat{R})$ by rendering (3.5)-(3.6) invalid, which is why we keep it separated and deal with it in the final argument. The estimate (5.5) implies that

$$\left|\hat{\mathcal{T}}(t)\right| \lesssim \sum t \Lambda \lambda_q^{\theta + \varepsilon - \beta}.$$

To be able to make it as small as we desire, we must contrast the *a*-growth of the q = 0 and q = 1 terms of this sum. This is easily achieved by requiring $t \le \Lambda^{-1} \lambda_0^{\beta - \theta - \varepsilon - 1}$ for ι arbitrarily small. In any case, calling t_s the maximal time where $\hat{\mathcal{T}}$ can be estimated with small quantities, we have that

$$\lim_{a\to\infty}t_s=0$$

since we meed $t_s \delta_0^{1/2} \lambda_0^{\theta+\varepsilon}$ to be small.

 \diamond

11 From adapted subsolutions to solutions

The aim of this section is to prove **Proposition 5.2** (p. 11). The proof closely follows the arguments of [13, Section 9]. We now start from an adapted subsolution and, by a convex integration scheme, build a sequence of strong subsolutions which converge to a solution of the fractional Navier-Stokes equation. As in **Proposition 5.1** the convex integration scheme needs the localized gluing and perturbation arguments of **Proposition 8.1** (in the form of **Remark 8.1**) and **Proposition 9.1**. However, the choice of the cut-off functions will be, as in [14], dictated by the shape of the trace part of the Reynolds stress, and not fixed a priori as in **Proposition 5.1**. Before we start the proof, a remark needs to be made about starting the chain of **Proposition 8.1** and **Proposition 9.1** with worse estimates.

Remark 11.1 (Worse starting estimate). In Proposition 8.1, if we replace (8.12) with

$$\left\|\mathring{R}\right\|_{0} \leq \Lambda \varrho_{q}^{1+\gamma} \ell_{q}^{-\frac{2}{b}\alpha},$$

as we will need to do below, the estimates (8.37), (8.47), (8.48), (8.17), (8.18), (8.24), (8.20), (8.25), (8.23), (8.62), and (8.70) will be worsened by a factor $\ell_q^{-\frac{2}{b}\alpha}$. In fact, we can gain a factor ℓ_q^{α} in (8.20) and (8.25), and a factor $\ell_q^{\alpha}\lambda_q^{\alpha}$ in (8.23) and (8.62). To keep the inductive estimates on the velocity gap $||v_{q+1} - v_q||_0$ and $||v_{q+1} - v_q||_{H^{-1}}$, the velocity $||v_{q+1}||_0$, and the derivative of the trace $|\partial_t \rho_q|$, we will need

$$\begin{split} \Lambda^{\frac{1}{2}} \varrho_{q}^{\frac{1+\gamma}{2}} \ell_{q}^{(1-\frac{2}{b})\alpha} &\lesssim \delta_{q+1}^{\frac{1}{2}} \\ \delta_{q}^{\frac{1}{2}} \lambda_{q} \ell_{q}^{-\frac{2}{b}\alpha} &\lesssim \delta_{q+1}^{\frac{1}{2}} \lambda_{q+1} \\ \varrho_{q,i}^{\gamma} \ell_{q}^{-(2+\frac{2}{b})\alpha} &\lesssim 1, \end{split}$$

$$(11.1)$$

all of which can easily be deduced by assuming $2\alpha < \beta\gamma$ and $\alpha < \frac{2}{9}$. The former assumption also yields (8.30), which will allow us to bound the H^{-1} norm of $v_{q+1} - v_q$ sufficiently tightly. If we then start the perturbation step of **Proposition 9.1** from estimates that we can obtain from the modified output estimates mentioned above, we can get the same output estimates from **Proposition 9.1**.

Proof. (Proposition 5.2)

Step 1: Setting the parameters in the scheme

Let $(\hat{v}, \hat{p}, \hat{R})$ be a $C^{\hat{\beta}}$ -adapted subsolution on [0, T], with $\Omega = \Lambda$, satisfying the "strong" condition $|\hat{R}| \leq \Lambda \hat{\varrho}^{1+\gamma}$ for some $\gamma > 0$ and (3.5) and (3.6) for some $\alpha, \nu > 0$ as in **Definition 3.3** of adapted subsolution, with

$$\frac{1-\hat{\beta}}{2\hat{\beta}} < 1+\nu < \frac{1-\beta}{2\beta}.$$

Fix b > 0 so that

$$b^2(1+\nu) < \frac{1-\beta}{2\beta}, \qquad 2\beta(b^2-1) < 1.$$
 (11.2)

Observe that both the strongness condition (3.2) and the adaptedness conditions (3.5)-(3.6) remain valid for any $\hat{\gamma} < \gamma$ and $\alpha' \leq \alpha$ (cfr. **Remark 3.1**). Then, we may assume that $\alpha, \hat{\gamma} > 0$ are sufficiently small, so that $(\hat{\nu}, \hat{p}, \hat{R})$ satisfies (3.2) for some $\hat{\gamma} > 0$ and (3.5)-(3.6) for some $\alpha, \nu > 0$, and furthermore choose γ so that

$$2\alpha < \beta \hat{\gamma} < \beta \gamma < 3\alpha \qquad b\beta \hat{\gamma} < 3\alpha. \tag{11.3}$$

For the reasons discussed in **Remark 11.1** above, and for another technical reason we will see below, we require

$$2\alpha < \hat{\beta}\gamma < 3\alpha. \tag{11.4}$$

Finally, having fixed $b, \hat{\beta}, \beta, \alpha, \gamma, \hat{\gamma}$, we may choose $\overline{N} \in \mathbb{N}$ so that (4.14) holds. For $a \gg 1$ sufficiently large (to be determined) we then define (λ_q, δ_q) as in (4.1) (using β). Thus, we are in the setting of Section 4.

Step 2: Conditions on (v_0, p_0, R_0) and the inductive construction of (v_q, p_q, R_q)

Differently from [13, Section 9], we can take $(v_0, p_0, R_0) = (\hat{v}, \hat{p}, \hat{R})$, since we are assuming $\hat{\rho} \le \frac{5}{4}\delta_1 = \frac{5}{4}\delta$, which is *a*-independent. We do have some estimates to verify for (v_0, p_0, R_0) , namely that, wherever $\rho_0 \ge \delta_{q+2}$

$$\begin{aligned} \|v_0\|_{1+\alpha} &\leq \delta_q^{\frac{1}{2}} \lambda_q^{1+\alpha} \\ |\partial_t \rho_0| &\leq \rho_0 \delta_q^{\frac{1}{2}} \lambda_q. \end{aligned}$$
(11.5)

Indeed, where $\rho_0 \ge \delta_{q+2}$, (11.2) easily yields

$$egin{aligned} &\Lambda^{rac{1}{2}} arrho_0^{-(1+
u)} \lesssim \Lambda^{rac{1}{2}} \lambda_q^{2eta b^2(1+
u)} \leq \delta_q^{rac{1}{2}} \lambda_q \ &\Lambda^{rac{3}{2}} arrho_0^{-

provided $a \gg 1$ is sufficiently large. These two relations, combined with (3.5) and (3.6), yield (11.5). Start from (v_0, p_0, R_0) , we will inductively construct a sequence (v_q, p_q, R_q) of smooth strong subsolutions for q = 1, 2, ..., with

$$R_q(x,t) = \rho_q(t) \operatorname{Id} + \check{R}_q(x,t),$$

satisfying the following properties:

 (A_q) For all $t \in [0,T]$

(11.11)

 $(F_q) \|v_q\|_{\theta+\varepsilon} \leq M \bigg(1 + \Lambda^{\frac{1}{2}} \sum_{i=0}^q \lambda_i^{\theta+\varepsilon-\beta} \bigg).$

Thanks to our choice of parameters in Step 1 above, (v_0, p_0, R_0) satisfies (11.5), and therefore our inductive assumptions (A_0) - (F_0) . Suppose now (v_q, p_q, R_q) satisfies (A_q) - (F_q) above. Let

$$J_q \coloneqq \left\{ t \in [0,T] : \rho_q(t) > \frac{3}{2} \delta_{q+2} \right\}, \qquad K_q \coloneqq \left\{ t \in [0,T] : \rho_q(t) \ge 2\delta_{q+2} \right\}.$$

Being (relatively) open in [0,T], J_q is a disjoint, possibly countable, union of (relatively) open intervals $(T_1^{(i)}, T_2^{(i)})$. Let

$$\mathcal{G}_q \coloneqq \left\{ i : (T_1^{(i)}, T_2^{(i)}) \cap K_q \neq \varnothing \right\},\$$

Next, we apply **Proposition 8.1** (in the form of **Remark 8.1**), keeping **Remark 11.1** in mind, to (v_q, p_q, R_q) on this disjoint union of intervals $\bigcup_{g_q} J_{q,i}$. Since $\rho_q > \frac{3}{2}\delta_{q+2}$, from $(A_q) \cdot (F_q)$ and $(11.2) \cdot (11.3)$ we see that the assumptions of **Proposition 8.1** on (v_q, p_q, R_q) hold with parameter $\hat{\gamma}$. Then we obtain $(\overline{v}_q, \overline{p}_q, \overline{R}_q)$ such that, on J_q

(From (8.18))

$$\left\| \ddot{\mathbb{R}}_{q} \right\|_{0} \leq \overline{\rho}_{q}^{1+\hat{\gamma}} \ell_{q}^{-2\alpha + (1-\frac{\epsilon}{b})\alpha \mathbb{1}_{K_{q}}}$$
(From (8.20))

Such a choice is made possible by (11.12). We then want to apply **Proposition 9.1** (using **Remark 11.1** above where $\rho_q \ge 2\delta_{q+2}$) to $(\overline{\nu}_q, \overline{p}_q, \overline{R}_q)$ with

$$S_{\Psi} \coloneqq \psi_q^2 (\overline{R}_q - \delta_{q+2} \operatorname{Id}),$$

hence $\sigma_{\psi} = \psi_q^2(\overline{\rho}_q - \delta_{q+2})$. Using (11.17), (11.3), (11.2), (11.13), (11.14), (8.21)-(8.22), and $(A_q)-(F_q)$, we see that S and $(\overline{v}_q, \overline{p}_q, \overline{R}_q)$ satisfy the required assumptions on the interval $[T_1^{(i)} + 2\tau_q, T_2^{(i)} - 2\tau_q]$ with parameters $\alpha, \hat{\gamma} > 0$. In particular, (9.2) (or its worsened form discussed in **Remark 11.1**) follows from (11.13), since we only need it on supp $\psi_q \subseteq [T_i^{(1)} + 2\tau_q, T_i^{(2)} - 2\tau_q].$

Proposition 9.1 gives then a new subsolution $(v_{q+1}, p_{q+1}, \overline{R}_q - S_{\psi} - \mathcal{E}_{q+1})$ with

$$\begin{aligned} |v_{q+1} - \overline{v}_{q}||_{0} + ||v_{q+1} - \overline{v}_{q}||_{H^{-1}}\lambda_{q+1} \\ + \lambda_{q+1}^{-1-\alpha} ||v_{q+1} - \overline{v}_{q}||_{1+\alpha} \\ + \lambda_{q+1}^{-\theta-\varepsilon} ||v_{q+1} - \overline{v}_{q}||_{\theta+\varepsilon} &\leq M\delta_{q+1}^{\frac{1}{2}} \\ \int_{\mathbb{T}^{3}} |v_{q+1}|^{2} - S_{\Psi} - \mathcal{E}_{q+1} &= \int_{\mathbb{T}^{3}} |\overline{v}_{q}|^{2} \quad t \in [0,T]. \end{aligned}$$
(From (9.17) and (9.18))
(From (9.15))

and such that \mathcal{E}_{q+1} satisfies (9.20)-(9.21). Let

$$R_{q+1} \coloneqq \overline{R}_q - S_{\Psi} - \mathcal{E}_{q+1},$$

We claim that $(v_{q+1}, p_{q+1}, R_{q+1})$ is a smooth strong subsolution satisfying (A_{q+1}) - (F_{q+1}) . Notice that (A_{q+1}) is satisfied by construction. By definition of S_{ψ} , one has that

$$\rho_{q+1} = \overline{\rho}_q (1 - \psi_q^2) + \psi_q^2 \delta_{q+2} - \frac{1}{3} \operatorname{tr} \mathscr{E}_{q+1}$$
$$\mathring{R}_{q+1} = \mathring{\overline{R}}_q (1 - \psi_q^2) - \mathring{\mathscr{E}}_{q+1}.$$

For $t \in K_q$, condition (B_{q+1}) follows easily from (9.20) and the fact that $K_q \subset \{\psi_q = 1\}$. For $t \notin J_q$, we have that

$$\rho_{q+1} = \rho_q \leq rac{3}{2}\delta_{q+2} < rac{5}{2}\delta_{q+2}.$$

For $t \in J_q \setminus K_q$, we have that $\overline{\rho}_q \leq \frac{9}{8}\rho_q \leq \frac{9}{8} \cdot 2\delta_{q+2} = \frac{9}{4}\delta_{q+2}$, which means

$$\rho_{q+1} \leq \frac{9}{4} \delta_{q+2} \left(1 - \frac{4}{9} \psi_q^2 + \frac{5}{9} \lambda_{q+1}^{-6\alpha} \right) \leq \frac{5}{4} \delta_{q+2} \left(\frac{9}{5} + \lambda_1^{-6\alpha} \right),$$

and if $\lambda_1^{-6\alpha} \leq \frac{1}{5}$, which is a matter of choosing *a* large enough, we have (B_{q+1}) .

Note that, by the construction of ρ_{q+1} , we have that $J_q \subseteq K_{q+1}$, since on the whole of J_q we have that $\rho_{q+1} \sim$ $\delta_{q+2} \gg \delta_{q+3}$. This is the reason why we required $\hat{\gamma} < \gamma$ and used the larger γ outside of J_q in (C_q) : to make sure (C_{q+1}) was automatically verified outside J_q . This is in stark contrast to what happened in Section 10, where the perturbation regions $P_q \coloneqq [0, 2^{-q}T]$ satisfied the opposite inclusion $P_{q+1} \subseteq P_q$, and where we consequently required $\hat{\gamma} > \gamma$ to ensure the weaker "strong condition" (b_{q+1}) in $P_q \setminus P_{q+1}$, while the stronger (d_{q+1}) only held in P_{q+1} , where $\psi_q = 1$.

By the above paragraph, in verifying conditions (C_{q+1}) - (D_{q+1}) , it suffices to restrict to the case when $\rho_{q+1} \ge$ $2\delta_{q+3}$ and j = q+1, respectively.

The argument showing (C_{q+1}) for $t \in K_{q+1}$ is similar to the proof of (b_{q+1}) in Step 3 of **Proposition 5.1** above. On the one hand

$$\begin{split} \left\| \mathring{R}_{q+1} \right\|_{0} &= \left\| (1 - \psi_{q}^{2}) \mathring{\overline{R}}_{q} - \mathring{\mathcal{E}}_{q+1} \right\|_{0} \\ &\leq (1 - \psi_{q}^{2}) \Lambda \overline{\varrho}_{q}^{1 + \hat{\gamma}} \ell_{q}^{-2\alpha + (1 - \frac{2}{b})\alpha \mathbb{1}_{\psi_{q}=1}} + \delta_{q+2} \lambda_{q+1}^{-6\alpha}, \end{split}$$

on the other hand

$$\begin{split} \rho_{q+1} &= (1 - \psi_q^2) \Lambda \overline{\varrho}_q + \psi_q^2 \delta_{q+2} + \frac{1}{3} \operatorname{tr} \mathcal{E}_{q+1} \\ &\geq (1 - \psi_q^2) \overline{\rho}_q + \psi_q^2 \delta_{q+2} - \delta_{q+2} \lambda_{q+1}^{-6\alpha}. \end{split}$$

So where $\psi_q = 1$ we have the condition since, for *a* large enough, we can guarantee

$$\delta_{q+2}\lambda_{q+1}^{-6\alpha} \lesssim \delta_{q+2}\zeta_{q+2}^{\hat{\gamma}}(1-\lambda_{q+1}^{-6\alpha})^{1+\hat{\gamma}} \iff \lambda_{q+1}^{-6\alpha} \lesssim \zeta_{q+2}^{\hat{\gamma}}(1-\lambda_{q+1}^{-6\alpha})^{1+\hat{\gamma}}, \tag{11.18}$$

since $6\alpha > 2b\beta\hat{\gamma}$ is required in (11.3). If $\psi_q \neq 1$, however, we need

$$(1 - \psi_q^2)\Lambda^{-\hat{\gamma}}\overline{\rho}_q^{1+\hat{\gamma}}\ell_q^{-2\alpha} + \delta_{q+2}\lambda_{q+1}^{-6\alpha}\mathbb{1}_{\{\psi_q > 0\}} \le \Lambda^{-\hat{\gamma}}[(1 - \psi_q^2)\overline{\rho}_q + \psi_q^2\delta_{q+2} - \delta_{q+2}\lambda_{q+1}^{-6\alpha}]^{1+\hat{\gamma}}\ell_{q+1}^{-\frac{5}{b}\alpha}.$$
(11.19)

To this end set

$$\begin{split} F(s) &\coloneqq (1-s)\Lambda \overline{\mathbf{Q}}_q^{1+\tilde{\gamma}} \ell_q^{-2\alpha} + \delta_{q+2} \lambda_{q+1}^{-6\alpha} \\ G(s) &\coloneqq (1-s)\overline{\mathbf{p}}_q + s \delta_{q+2} - \delta_{q+2} \lambda_{q+1}^{-6\alpha} = \overline{\mathbf{p}}_q + s (\delta_{q+2} - \overline{\mathbf{p}}_q) - \delta_{q+2} \lambda_{q+1}^{-6\alpha} \\ H(s) &\coloneqq \Lambda^{-\tilde{\gamma}} G^{1+\tilde{\gamma}}(s) \ell_{q+1}^{-\frac{2}{b}\alpha} - F(s), \end{split}$$

and, just like in **Proposition 5.1**, deduce that $H(\psi_q^2) \ge 0$ by proving that:

- (i) $H(0) \ge 0$ and $H(1) \ge 0$;
- (ii) $H'(0) \ge 0$ and $H'(1) \ge 0$.
- (iii) $H''(s) \ge 0$.

To this end, we first obtain the estimates

$$\delta_{q+2}\lambda_{q+1}^{-6\alpha} \lesssim \Lambda \overline{\varrho}_q^{1+\hat{\gamma}}, \qquad F(0) \lesssim \Lambda \overline{\varrho}_q^{1+\hat{\gamma}} \ell_q^{-2\alpha}, \qquad G(0) \gtrsim \overline{\rho}_q, \qquad G(s) \le \overline{\rho}_q.$$

The first one follows from (11.18), (8.21), and the fact we are working for $t \in J_q$. The second one follows from the first one. The fourth one is obvious, since $\overline{\rho}_q \geq \frac{7}{8} \frac{3}{2} \delta_{q+2} \frac{21}{16} \delta_{q+2} > \delta_{q+2}$. For the third one, we reduce it to $\delta_{q+2}\lambda_{q+1}^{-6\alpha} \leq \overline{\rho}_q$, and then it follows from the first estimate, since $\Lambda \overline{\varrho}_q^{1+\hat{\gamma}} \leq \overline{\rho}_q$. We then prove (i)-(v) as follows.

• It is easy to check that the two parts of (i) amount to

$$\Lambda \overline{\varrho}_{q}^{1+\hat{\gamma}} \ell_{q}^{-2\alpha} \lesssim \Lambda \overline{\varrho}_{q}^{1+\hat{\gamma}} \ell_{q+1}^{-\frac{2}{b}\alpha}, \qquad \delta_{q+2} \lambda_{q+1}^{-6\alpha} \leq \Lambda^{-\hat{\gamma}} [\delta_{q+2} (1-\lambda_{q+1}^{-6\alpha})]^{1+\hat{\gamma}} \ell_{q+1}^{-\frac{2}{b}\alpha};$$

the first one follows from $\ell_q \sim \ell_{q+1}^{1/b}$; the second one follows from (11.3) and the following relations, which hold for *a* sufficiently large:

$$1-\lambda_{q+1}^{-6\alpha} \geq \frac{1}{2} \iff \lambda_{q+1}^{-6\alpha} \leq \frac{1}{2}, \qquad \qquad \lambda_{q+1}^{-6\alpha} \leq \zeta_{q+2}^{\hat{\gamma}} \ell_{q+1}^{-\frac{2}{\hat{b}}\alpha} 2^{-1-\hat{\gamma}};$$

• The requirements (ii) can be rewritten as

$$\overline{\rho}_{q}^{1+\hat{\gamma}}\ell_{q}^{-2\alpha} \geq (1+\hat{\gamma})(\overline{\rho}_{q}-\delta_{q+2})\ell_{q+1}^{-\frac{2}{b}\alpha}\max\{[\overline{\rho}_{q}-\delta_{q+2}\lambda_{q+1}^{-6\alpha}]^{\hat{\gamma}},\delta_{q+2}^{\hat{\gamma}}(1-\lambda_{q+1}^{-6\alpha})^{\hat{\gamma}}\},$$

which easily follows for sufficiently small $\hat{\gamma}$ and sufficiently large *a*, since $\ell_q^{-2\alpha} \sim \ell_{q+1}^{-\frac{2}{b}\alpha}$;

• Note that G'' = 0 because G is linear in s, and the same is true of F'', meaning that (iii) is simply

$$\begin{split} 0 &\leq \Lambda^{-\hat{\gamma}} \hat{\gamma} (1+\hat{\gamma}) G^{\hat{\gamma}-1}(s) G'^2(s) \ell_{q+1}^{-\frac{2}{b}\alpha} \\ &= \Lambda^{-\hat{\gamma}} \hat{\gamma} (1+\hat{\gamma}) [(1-s)\overline{\rho}_q + \delta_{q+2} (1-\lambda_{q+1}^{-6\alpha})]^{\hat{\gamma}-1} (\overline{\rho}_q - \delta_{q+2})^2 \ell_{q+1}^{-\frac{2}{b}\alpha}, \end{split}$$

which is obvious, since all those factors are positive.

We have thus obtained (C_{q+1}) .

The velocity estimate in (D_{q+1}) for j = q+1 follows from (9.18) and (8.24). The trace estimate in (D_{q+1}) follows from (9.21) and (8.22). Finally, (E_{q+1}) follows precisely as (f_{q+1}) in the proof of **Proposition 5.1** in Section 10 above, and (F_{q+1}) is obtained just like (g_{q+1}) . Keep in mind **Remark 11.1** above for all of these. Thus, the inductive step is proved.

Finally, the convergence of $\{v_q\}$ to a solution of the hypodissipative Navier-Stokes equations as in the statement of **Proposition 5.2** (i.e. the one we are proving) follows easily from the sequence of estimates in (A_q) - (F_q) , analogously to Step 4 of **Proposition 5.1** proved in Section 10 above.

The Navier-Stokes term \mathcal{T} will be handled in the same way as $\hat{\mathcal{T}}$ was dealt with in **Proposition 5.1**, giving us once more that the maximal time t_s of "smallness" of \mathcal{T} must satisfy

$$\lim_{a\to\infty}t_s=0.$$

Step 3: From one to infinitely many

Looking at the details of the scheme, we realize that replacing $(\hat{v}, \hat{p}, \hat{R})$ with

$$(v_0, p_0, R_0) \coloneqq (\hat{v}, \hat{p}, \hat{R} + e/3)$$

as described in the statement of **Proposition 5.2**, clearly retains condition (3.4), since the initial datum is not changed. It does not necessarily preserve conditions (3.5), and (3.6). Those, however, are only needed to obtain the conditions (D_0) . If we then show that the conditions $(A_0) - (F_0)$ (and thus also (D_0)) are maintained with such a perturbation, we need not worry about losing (3.5) and (3.6).

Conditions about the velocity are clearly preserved, and (A_0) and (E_0) are vacuous, so all we need is

$$\rho_0' \le \frac{5}{2}\delta \tag{B_0}$$

$$|\mathring{R}'_{0}||_{0} \leq \begin{cases} \Lambda \varrho_{0}^{\prime 1+\hat{\gamma}} \ell_{q}^{-\frac{\tilde{b}\alpha}{b}} & \rho_{0}' \geq 2\delta_{2} \\ \Lambda \varrho_{0}^{\prime 1+\hat{\gamma}} & \frac{3}{2}\delta_{2} \leq \rho_{0}' \leq 2\delta_{2} \\ \Lambda \varrho_{0}^{\prime 1+\gamma} & \rho_{0}' \leq \frac{3}{2}\delta_{2} \end{cases}$$
(C₀)

$$\partial_t \rho'_0 \Big| \le \rho'_0 \delta_0^{\frac{1}{2}} \lambda_0.$$
 (D₀.2, i.e. (11.10))

Concerning (B_0) , the proposition assumes $\hat{\rho} \leq \frac{5}{2}\delta$, so that the condition is preserved by requiring (5.13). Since $\hat{\rho}(0) = 0$, *e* has the possibility to vary in a neighborhood of t = 0 without becoming negative. $(D_0.3)$ boils down to the following condition on *e*:

$$\begin{cases} |\partial_t e| \le e\sqrt{\delta_0}\lambda_0 & e > 0\\ |\partial_t e| + |e|\sqrt{\delta_0}\lambda_0 \le \hat{\rho}\sqrt{\delta_0}\lambda_0 - |\partial_t \hat{\rho}| & \text{otherwise} \end{cases}$$

To keep things simple, we require (5.14) and (5.15).

Coming to (C_0) , we first assume e > 0, which immediately yields, by the properties of $(\hat{v}, \hat{p}, \hat{R})$, that

$$\left\| \mathring{R}_{0} \right\|_{0} \leq \begin{cases} \Lambda(\hat{\varrho} + \Lambda^{-1}e)^{1+\hat{\gamma}} \ell_{q}^{-\frac{2}{\rho}\alpha} & \hat{\rho} \geq 2\delta_{2} \\ \Lambda(\hat{\varrho} + \Lambda^{-1}e)^{1+\hat{\gamma}} & \frac{3}{2}\delta_{2} \leq \hat{\rho} \leq 2\delta_{2} \\ \Lambda(\hat{\varrho} + \Lambda^{-1}e)^{1+\gamma} & \hat{\rho} \leq \frac{3}{2}\delta_{2} \end{cases}$$

Our goal is to obtain that

$$\left\| \mathring{R}_0 \right\|_0 \leq \begin{cases} \Lambda(\hat{\varrho} + \Lambda^{-1}e)^{1+\hat{\gamma}} \ell_q^{-\frac{2}{b}\alpha} & \hat{\rho} + e \geq 2\delta_2 \\ \Lambda(\hat{\varrho} + \Lambda^{-1}e)^{1+\hat{\gamma}} & \frac{3}{2}\delta_2 \leq \hat{\rho} + e \leq 2\delta_2 \\ \Lambda(\hat{\varrho} + \Lambda^{-1}e)^{1+\gamma} & \hat{\rho} + e \leq \frac{3}{2}\delta_2 \end{cases}$$

• We first note that $\hat{\rho} + e \leq 3/2\delta_2 \implies \hat{\rho} \leq 3/2\delta_2$, so in this case we have the desired estimate for $\|\mathring{R}_0\|_0$;

- If $\hat{\rho} \leq {}^{3}/{}_{2}\delta_{2}$ but ${}^{3}/{}_{2}\delta_{2} \leq \hat{\rho} + e \leq 2\delta_{2}$, since $\hat{\gamma} < \gamma$ and $\|\mathring{R}_{0}\|_{0} \leq \Lambda(\hat{\varrho} + \Lambda^{-1}e)^{1+\gamma}$, we have the desired estimate;
- If $\hat{\rho} \leq \frac{3}{2}\delta_2$ but $\hat{\rho} + e \geq 2\delta_2$, the desired estimate is even looser than in the previous item;
- If ${}^{3}/{}_{2}\delta_{2} \leq \hat{\rho} \leq 2\delta_{2}$, then either $\hat{\rho} + e$ also satisfies this bound, in which case we have the desired estimate, or $\hat{\rho} + e \geq 2\delta_{2}$, in which case the desired estimate is looser;
- Finally, if $\hat{\rho} \ge 2\delta_2$, then so is $\hat{\rho} + e$, meaning again we have the desired estimate.

Thus, we need no additional conditions to obtain (C_0) . Summing up, the conditions we must impose on *e* are precisely (5.13)-(5.15). The proof is complete.

A Proof of Lemma 6.1

Proof. (Lemma 6.1)

Fix $\rho \in C_c^{\infty}(B_1(0))$ a standard mollification kernel in space, and define:

$$\rho_{\varepsilon}(x) \coloneqq \varepsilon^{-3} \rho(x \varepsilon^{-1})$$

To ensure the regularity of the initial datum, we consider the smoothed datum

$$w_0 \coloneqq w * \rho_{\eta_0}$$

where

$$\eta_{0} \coloneqq \max\left\{\eta : \|w * \rho_{\eta} - w\|_{L^{2}} \le \frac{\delta}{3} \land \int_{\mathbb{T}^{3}} [|w_{0}|^{2} - |w|^{2}](x) dx \le \frac{2}{3}\delta\right\}.$$
(A.1)

By **Theorem 6.1**, there exists a solution (\tilde{v}, \tilde{p}) with initial datum w_0 , where \tilde{p} can be recovered uniquely once we impose $\int \tilde{p} = 0$.

We now fix a standard mollification kernel in time $\chi \in C_c^{\infty}((-1,0))$ and, with ρ_{ε}, ρ as defined above, we define

$$\chi_{\varepsilon}(t) \coloneqq \varepsilon^{-1} \chi(t\varepsilon^{-1})$$

$$v(x,t) \coloneqq \int_{t}^{t+\varepsilon} (\tilde{v} * \rho_{\varepsilon})(x,s) \chi_{\varepsilon}(t-s) ds,$$

$$p(x,t) \coloneqq \int_{t}^{t+\varepsilon} (\tilde{p} * \rho_{\varepsilon})(x,s) \chi_{\varepsilon}(t-s) ds,$$

$$R(x,t) \coloneqq \overline{\tilde{v} \otimes \tilde{v}} - v \otimes v,$$

where

$$\overline{f} = \int_{t}^{t+\varepsilon} (f * \rho_{\varepsilon})(x,s) \chi_{\varepsilon}(t-s) \mathrm{d}s.$$

By construction and since (\tilde{v}, \tilde{p}) solves (1.5), (v, p, R) is a smooth solution of (3.1), i.e.

$$\begin{cases} \partial_t v + \operatorname{div}(v \otimes v) + \nabla p + (-\Delta)^{\theta} v = -\operatorname{div} R\\ \operatorname{div} v = 0 \end{cases}$$

By using Jensen's inequality on $\mathbb{T}^3 \times [t, t+\varepsilon]$ with the measure $\rho_{\varepsilon}(x-y)\chi_{\varepsilon}(t-s)dxds$, we conclude that

$$R = \overline{\tilde{v} \otimes \tilde{v}} - v \otimes v \ge 0. \tag{A.2}$$

Coming to the initial datum, we have that

$$v|_{t=0} = \int_{0}^{\bullet} ((\tilde{v} - w_0) * \rho_{\varepsilon})(x, s) \chi_{\varepsilon}(-s) \mathrm{d}s + w_0 * \rho_{\varepsilon}.$$

Taking the L^2 norm, we can easily obtain that

$$\|v\|_{t=0} - w_0\|_{L^2(\mathbb{T}^3)} \le \sup_{t \in [0,\varepsilon]} \|\tilde{v}(\cdot,t) - w_0\|_{L^2(\mathbb{T}^3)} + \|w_0 * \rho_{\varepsilon} - w_0\|_{L^2(\mathbb{T}^3)} \Longrightarrow \sup_{t \in [0,\varepsilon]} I_t + II_{\varepsilon}.$$

 II_{ε} can be made as small as we desire by choosing ε small enough. Let ε_0 be the maximal parameter such that $II_{\varepsilon} < \frac{\delta}{3}$. As for sup I_t , using $\tilde{v}_t(x) \coloneqq \tilde{v}(x,t)$, we can obtain that

$$\begin{split} I_t^2 &= \int_{\mathbb{T}^3} |\tilde{v}_t - w_0|^2 dx = \int_{\mathbb{T}^3} |\tilde{v}_t|^2 - |w_0|^2 dx - 2 \int_0^t \int_{\mathbb{T}^3} \langle \partial_t \tilde{v}, w_0 \rangle dx ds \\ &\stackrel{*}{\leq} 2 \int_0^t \int_{\mathbb{T}^3} -(\tilde{v}_s \otimes \tilde{v}_s) : \mathfrak{D} w_0 + \left\langle \tilde{v}_s, (-\Delta)^{\theta} w_0 \right\rangle dx ds \\ &\stackrel{\bullet}{\leq} 2 \sqrt{C(1 - 2\theta)} \int_0^t \|\tilde{v}_t\|_{L^2} [w_0]_1 ds + 2 \int_0^t \|\tilde{v}_t\|_{L^2}^2 \|\mathfrak{D} w_0\|_{L^\infty} ds \\ &\leq 2 t \|Dw_0\|_{L^\infty} \|w_0\|_{L^2} (\sqrt{C(1 - 2\theta)} + 2 \|w_0\|_{L^2}) \leq K(w) t \|\mathfrak{D} w_0\|_{L^\infty} \end{split}$$

In *, we used the fact that $\|\tilde{v}_t\|_{L^2}^2 \le \|w_0\|_{L^2}^2$, i.e. (6.1), as well as the fact that (\tilde{v}, \tilde{p}) is a solution of (1.5) and the fact div $w_0 = 0$. In •, we used **Theorem 2.1**, choosing $\varepsilon = 1 - 2\theta$. In the last step, we used that $\|w_0\|_{L^2} \le \|w\|_{L^2}$. This becomes arbitrarily small if we choose *t* appropriately small, and since $t \in [0, \varepsilon]$ that translates to ε small enough. Since $Dw_0 = D\rho_{\eta_0} * w = \eta_0^{-4} D\rho(\eta_0^{-1} \cdot) * w$, Hölder's inequality yields

$$\|Dw_0\|_{L^{\infty}} \leq \eta_0^{-4} \|D\rho(\eta_0^{-1}x)\|_{L^2_x(B_{\eta_0})} \|w\|_{L^2} \leq \eta_0^{-4} \eta_0^2 \|D\rho\|_{C^0} \|w\|_{L^2} = C(w) \eta_0^{-2},$$

so that, to ensure $\sup_{[0,\varepsilon]} I_t \leq \delta/2$, we choose

$$\varepsilon \leq \frac{\delta \eta_0^2}{3C(w)K(w)} \eqqcolon \tilde{\varepsilon}.$$

Choosing $\varepsilon \coloneqq \min\{\varepsilon_0, \tilde{\varepsilon}, \eta_0\}$ thus yields

$$\|\overline{v}|_{t=0} - w\|_{L^2} \le \delta \qquad \|\overline{v}|_{t=0} - w_0\|_{L^2} \le \frac{2}{3}\delta.$$

We have thus obtained (6.2). As for (6.3), we first notice that

$$\int_{\mathbb{T}^3} (\rho_{\varepsilon} * f)(x, t) \mathrm{d}x = \int_{\mathbb{T}^3} f(x, t) \mathrm{d}t, \tag{A.3}$$

for any $t \in [0,T]$ and any function f. Thus, by the definition of R, we have that

$$\int_{\mathbb{T}^3} |v|^2(x,t) + \operatorname{tr} R(x,t) \mathrm{d} x = \int_{\mathbb{T}^3} \overline{|\tilde{v}|^2}(x,t) \mathrm{d} x = \int_{\mathbb{T}^3} (\chi_{\varepsilon} * |\tilde{v}|^2)(x,t) \mathrm{d} x,$$

We have thus reduced (6.3) to the following inequality:

$$\frac{1}{2}\int_{\mathbb{T}^3} (\chi_{\varepsilon} * |\tilde{v}|^2)(x,t) + \int_0^t \int_{\mathbb{T}^3} \left| (-\Delta)^{\frac{\theta}{2}} v \right|^2 (x,s) \mathrm{d}x \mathrm{d}s \leq \int_{\mathbb{T}^3} |w|^2 (x) \mathrm{d}x + \delta.$$

Since (\tilde{v}, \tilde{p}) satisfies (6.1), we can see that

$$\begin{split} \frac{1}{2} \int_{\mathbb{T}^{3}} (\chi_{\varepsilon} * |\tilde{v}|^{2})(x,t) + \int_{0}^{t} \int_{\mathbb{T}^{3}} \left| (-\Delta)^{\frac{\theta}{2}} v \right|^{2}(x,s) dx ds &\leq \frac{1}{2} \int_{\mathbb{T}^{3}} |w|^{2} dx + \frac{1}{2} \int_{\mathbb{T}^{3}} |w_{0}|^{2} - |w|^{2} dx \\ &+ \frac{1}{2} \int_{\mathbb{T}^{3}} \left[(\chi_{\varepsilon} * |\tilde{v}|^{2}) - |\tilde{v}|^{2} \right](x,t) dx + \int_{0}^{t} \int_{\mathbb{T}^{3}} \left[\left| (-\Delta)^{\frac{\theta}{2}} v \right|^{2} - \left| (-\Delta)^{\frac{\theta}{2}} \tilde{v} \right|^{2} \right](x,s) dx ds \\ &=: \frac{1}{2} \int_{\mathbb{T}^{3}} |w|^{2} dx + I + II + III. \end{split}$$

Our desired estimate (6.3) will then follow from

$$I \le \frac{\delta}{3}$$
 $II \le \frac{\delta}{3}$ $III \le \frac{\delta}{3}$. (A.4)

The first of these relations follows from (A.1).

The second relation in (A.4) follows, for ε sufficiently small, from the fact that, since $\tilde{v} \in L_t^2 H_x^{\theta} \subseteq L_t^2 L_x^2$, $|\tilde{v}|^2 \in L_t^1 L_x^1$, so $\chi_{\varepsilon} * |\tilde{v}|^2 \to |\tilde{v}|^2$ in $L_t^1 L_x^1$ for $\varepsilon \to 0$.

Coming to the third relation, we first rewrite the integral of the first integrand:

$$\begin{split} \int_{0}^{t} \int_{\mathbb{T}^{3}} \left| (-\Delta)^{\frac{\theta}{2}} \overline{\nu} \right|^{2} (x,s) \mathrm{d}x \mathrm{d}s &= \int_{0}^{t} \int_{\mathbb{T}^{3}} \left| \int_{s}^{s+\varepsilon} \int_{\mathbb{T}^{3}} \rho_{\varepsilon} (x-y) (-\Delta)^{\frac{\theta}{2}} \widetilde{\nu} (y,\tau) \chi_{\varepsilon} (t-\tau) \mathrm{d}y \mathrm{d}\tau \right|^{2} \mathrm{d}x \mathrm{d}s \\ &\leq \int_{0}^{t} \int_{s}^{s+\varepsilon} \int_{\mathbb{T}^{3}} \left| (-\Delta)^{\frac{\theta}{2}} \widetilde{\nu} \right|^{2} (x,\tau) \chi_{\varepsilon} (t-\tau) \mathrm{d}x \mathrm{d}\tau \mathrm{d}s, \end{split}$$

where we used Jensen's inequality in the first step and (A.3) in the second one. Therefore, the remaining term is rewritten as:

$$III = \int_{0}^{t} \int_{\mathbb{T}^{3}} \left[\left(\chi_{\varepsilon} * \left| (-\Delta)^{\frac{\theta}{2}} \tilde{v} \right|^{2} \right) (x,s) - \left| (-\Delta)^{\frac{\theta}{2}} \tilde{v} \right|^{2} (x,s) \right] \mathrm{d}x \mathrm{d}s.$$

We now note that, since $\tilde{v} \in L_t^2 H_x^{\theta}$, we have that $(-\Delta)^{\frac{\theta}{2}} \tilde{v} \in L_t^2 L_x^2$, and thus $|(-\Delta)^{\frac{\theta}{2}} \tilde{v}|^2 \in L_t^1 L_x^1$. Therefore, as before, $\chi_{\varepsilon} * |(-\Delta)^{\frac{\theta}{2}} \tilde{v}|^2 - |(-\Delta)^{\frac{\theta}{2}} \tilde{v}|^2 \to 0$ in $L_t^1 L_x^1$, and the third relation of (A.4) reduces to an opportune choice of ε . Summing up, (v, p, R) is a smooth solution of (3.1), which satisfies (6.3) and (6.2), and $R \ge 0$ by (A.2). The proof of **Lemma 6.1** is thus complete.
