# The Gauge Group and Perturbation Semigroup of an Operator System

#### Abstract

The perturbation semigroup was first defined in the case of $*$-algebras by Chamseddine, Connes and van Suijlekom. In this paper, we take $\mathcal{E}$ as a concrete operator system with unit. We first give a definition of gauge group $\mathcal{G}(\mathcal{E})$ of $\mathcal{E}$, after that we give the definition of perturbation semigroup of $\mathcal{E}$, and the closed perturbation semigroup of $\mathcal{E}$ with respect to the Haagerup tensor norm. We also show that there is a continuous semigroup homomorphism from the closed perturbation semigroup to the collection of unital completely bounded Hermitian maps over $\mathcal{E}$. Finally we compute the gauge group and perturbation semigroup of the Toeplitz system as an example.

## 1 Introduction

An operator system $\mathcal{E}$ is a matrix-normed vector space equipped with a conjugate linear map $x \mapsto x^{*}$ on $\mathcal{E}$ such that $\left(x^{*}\right)^{*}=x$ for all $x \in \mathcal{E}$. Although there is not a well-defined product of elements in $\mathcal{E}$, we can embed the operator system $\mathcal{E}$ into some $C^{*}$-algebra $\mathcal{A}$, and then take the gauge group of $\mathcal{E}$ as the collection of unitary elements of $\mathcal{A}$ that keep $\mathcal{E}$ invariant under the unitary transformation, i.e.,

$$
\mathcal{G}(\mathcal{E}):=\left\{u \in \mathcal{A}: u^{*} \mathcal{E} u=\mathcal{E}\right\} .
$$

There are several different approaches to embed $\mathcal{E}$ into a $C^{*}$-algebra, for instance, we can embed $\mathcal{E}$ into the $C^{*}$-envelope $C_{\mathrm{en}}^{*}(\mathcal{E})$, the injective envelope $C_{\mathrm{in}}^{*}(\mathcal{E})$, or simply the $C^{*}$-algebra $C^{*}(\mathcal{E})$ generated by $\mathcal{E}$ when $\mathcal{E}$ is a concrete operator system. In this paper, we take $\mathcal{E}$ to be a concrete closed operator system with unit, i.e., a closed linear subspace of bounded operators on some Hilbert space $\mathcal{H}$ with $\operatorname{Id} \in \mathcal{E} \subset B(\mathcal{H})$, and we embed $\mathcal{E}$ into $C^{*}(\mathcal{E})$. In Section 2, we show that there is a group homomorphism from $\mathcal{G}(\mathcal{E})$ to the set of unital completely positive maps on $\mathcal{E}$. In Section 4.1, we show that the gauge group $\mathcal{G}\left(\operatorname{Toep}_{n}\right)$ of Toeplitz system Toep ${ }_{n}$ is independent of $n$, and

$$
\mathcal{G}\left(\operatorname{Toep}_{n}\right) \cong U(1) \times\left(U(1) \rtimes \mathbb{Z}_{2}\right)
$$

Inspired by the definition of perturbation semigroup of $*$-algebras given in [3], the perturbation semigroup of matrix algebras [10] and $C^{*}$-algebras [8], in Section 3, we give the definition of the perturbation semigroup $\operatorname{Pert}(\mathcal{E})$ of an operator system $\mathcal{E}$. More than that, since the perturbation semigroup $\operatorname{Pert}(\mathcal{E})$ is a subset of $\mathcal{A} \otimes \mathcal{A}^{\circ}$, we can take the closure of $\operatorname{Pert}(\mathcal{E})$ with respect to the Haagerup tensor norm, and we can show that there is a continuous semigroup homomorphism from this closure of $\operatorname{Pert}(\mathcal{E})$ to the collection of unital completely bounded Hermitian maps on $\mathcal{E}$.

In Section 4.2, we discuss the perturbation semigroups Pert $\left(\operatorname{Toep}_{n}\right)$ of Toeplitz system Toep ${ }_{n}$ in more detail. We show the relationship between an element $\omega \in \operatorname{Pert}\left(\operatorname{Toep}_{n}\right)$ and the corresponding $(2 n-1) \times(2 n-1)$ transformation matrix of Toeplitz system Toep $n$ under the fundamental basis $\left\{\tau_{-n+1}, \ldots, \tau_{0}, \ldots, \tau_{n-1}\right\}$ of Toep $n$.

## 2 Gauge group of an operator system

Let $\mathcal{H}$ be a separable Hilbert space, we denote by $B(\mathcal{H})$ the set of bounded operators on $\mathcal{H}, \mathcal{E} \subset$ $B(\mathcal{H})$ an operator system, ${ }^{1}$ and $C^{*}(\mathcal{E})$ the $C^{*}$-algebra generated by $\mathcal{E}$. We are mainly interested in the unital completely positive (UCP) maps over $\mathcal{E}$. According to Arveson's extension theorem $[1,11]$, if $\varphi: \mathcal{E} \rightarrow \mathcal{E}$ is a UCP map, then there is a UCP $\operatorname{map} \widetilde{\varphi}: B(\mathcal{H}) \rightarrow B(\mathcal{H})$ such that $\left.\widetilde{\varphi}\right|_{\mathcal{E}}=\varphi$. In addition, if $\widetilde{\varphi}$ is normal, ${ }^{2}$ according to Kraus [9, Theorem 3.3 or Theorem 4.1], the map $\widetilde{\varphi}$ can be written as

$$
\widetilde{\varphi}(x)=\sum_{k} V_{k}^{*} x V_{k}, \quad \forall x \in B(\mathcal{H})
$$

for some operators $\left\{V_{k}\right\}_{k \in K} \subset B(\mathcal{H})$ such that $\sum V_{k}^{*} V_{k}=\mathrm{Id}$. Hence especially when $U \in C^{*}(\mathcal{E})$ is a unitary element satisfying $U^{*} \mathcal{E} U \subset \mathcal{E}$ the corresponding map $\varphi: x \mapsto U^{*} x U$ is a UCP map over $\mathcal{E}$.

We denote by $\operatorname{UCP}(\mathcal{E})$ the collection of all the unital completely positive maps, and $\mathrm{UCP}_{\mathrm{rank}=1}(\mathcal{E})$ the collection of rank-1 unital completely positive maps, i.e.,

$$
\mathrm{UCP}_{\mathrm{rank}=1}(\mathcal{E}):=\left\{\varphi: \mathcal{E} \rightarrow \mathcal{E} \mid \varphi(\cdot)=V^{*}(\cdot) V \text { for some } V \in B(\mathcal{H}) \text { with } V^{*} V=\operatorname{Id}\right\}
$$

We realize that both $\operatorname{UCP}(\mathcal{E})$ and $\operatorname{UCP}_{\text {rank }=1}(\mathcal{E})$ are semigroups with respect to the map composition.

Definition 2.1. We define the gauge group $\mathcal{G}(\mathcal{E})$ of $\mathcal{E}$ as

$$
\mathcal{G}(\mathcal{E}):=\left\{U \in \mathcal{U}\left(C^{*}(\mathcal{E})\right) \mid U^{*} \mathcal{E} U=\mathcal{E}\right\}
$$

here $\mathcal{U}\left(C^{*}(\mathcal{E})\right)$ denotes the group of all the unitary elements in $C^{*}(\mathcal{E})$.
Remark 2.2. If $\varphi(\cdot)=V^{*}(\cdot) V \in \operatorname{UCP}_{\text {rank }=1}(\mathcal{E})$, then $V \in B(\mathcal{H})$ is an isometry. In particular, if $\mathcal{E} \subset M_{n}(\mathbb{C})$ is a finite dimensional operator system, then $V$ is a unitary matrix and $\mathrm{UCP}_{\text {rank }=1}(\mathcal{E})$ is a group.

Proposition 2.3. There is a multiplicative map $\Psi: \mathcal{G}(\mathcal{E}) \rightarrow \mathrm{UCP}_{\mathrm{rank}=1}(\mathcal{E})$ defined as

$$
\Psi: \quad U \mapsto U^{*}(\cdot) U, \quad U \in \mathcal{G}(\mathcal{E})
$$

We observe that the image of $\Psi$ forms a group and the map $\Psi: \mathcal{G}(\mathcal{E}) \rightarrow \operatorname{Image}(\Psi)$ is a surjective group homomorphism.

## 3 Perturbation semigroup of an operator system

In this section, we discuss unital completely bounded Hermitian( UCBH ) maps and the perturbation semigroup of a concrete unital operator system $\mathcal{E} \subset B(\mathcal{H})$.

[^0]Definition 3.1. We say $\Psi: \mathcal{E} \rightarrow \mathcal{E}$ is a Hermitian unital map if $\Psi\left(x^{*}\right)=\Psi(x)^{*}$ for all $x \in \mathcal{E}$ and $\Psi(\mathrm{Id})=\operatorname{Id}$ for the unital element $\operatorname{Id} \in \mathcal{E}$. We denote by $\operatorname{UCBH}(\mathcal{E})$ the collection of all unital completely bounded Hermitian maps over $\mathcal{E}$, i.e.,

$$
\operatorname{UCBH}(\mathcal{E}):=\left\{\Psi: \mathcal{E} \rightarrow \mathcal{E} \mid \Psi\left(x^{*}\right)=\Psi(x)^{*}, \Psi(\mathrm{Id})=\mathrm{Id}, \Psi \text { is completely bounded }\right\} .
$$

Inspired by the definition of perturbation semigroups introduced in [3, 8, 10], we define the perturbation semigroup $\operatorname{Pert}(\mathcal{E})$ of an operator system as follows:

Definition 3.2. Let $\mathcal{E}$ be an operator system, $C^{*}(\mathcal{E})$ be the $C^{*}$-algebra generated by $\mathcal{E}$ and $C^{*}(\mathcal{E})^{\circ}$ be the opposite algebra of $C^{*}(\mathcal{E})$. We define the perturbation semigroup $\operatorname{Pert}(\mathcal{E})$ as the collection of all the finite sums of the form $\sum a_{i} \otimes b_{i}^{\circ} \in C^{*}(\mathcal{E}) \otimes C^{*}(\mathcal{E})^{\circ}$ satisfying the following requirements:

1) $\sum a_{i} b_{i}=\mathrm{Id}$,
2) $\sum a_{i} \mathcal{E} b_{i} \subset \mathcal{E}$,
3) $\sum a_{i} \otimes b_{i}^{\circ}=\sum b_{i}^{*} \otimes a_{i}^{* \circ}$.

Remark 3.3. In the definition above, the opposite algebra $C^{*}(\mathcal{E})^{\circ}$ contains the same elements and addition operation as $C^{*}(\mathcal{E})$, while the multiplication order is reversed. And it is worth to observe that (1) and (3) inherit from the original definition of perturbation semigroup in [3], while (2) is an extra condition we need to assume in our case of operator system.

For each $\left(a, b^{\circ}\right) \in C^{*}(\mathcal{E}) \times C^{*}(\mathcal{E})^{\circ}$, let $\delta_{\left(a, b^{\circ}\right)}$ denote the completely bounded linear map on $C^{*}(\mathcal{E})$ in which $\delta_{\left(a, b^{\circ}\right)}(\xi)=a \xi b$, for all $\xi \in C^{*}(\mathcal{E})$. Let $\operatorname{CB}\left(C^{*}(\mathcal{E})\right)$ denote the set of all completed bounded maps over $C^{*}(\mathcal{E})$. The map $C^{*}(\mathcal{E}) \times C^{*}(\mathcal{E})^{\circ} \rightarrow \mathrm{CB}\left(C^{*}(\mathcal{E})\right)$ that sends each $\left(a, b^{\circ}\right) \in C^{*}(\mathcal{E}) \times C^{*}(\mathcal{E})^{\circ}$ to $\delta_{\left(a, b^{\circ}\right)} \in \operatorname{CB}\left(C^{*}(\mathcal{E})\right)$ is bilinear and therefore extends to a linear map $\Psi: C^{*}(\mathcal{E}) \otimes_{\text {alg }} C^{*}(\mathcal{E})^{\circ} \rightarrow \mathrm{CB}\left(C^{*}(\mathcal{E})\right)$.

The perturbation semigroup $\operatorname{Pert}(\mathcal{E})$ is a subset of $C^{*}(\mathcal{E}) \otimes_{\text {alg }} C^{*}(\mathcal{E})^{\circ}$, and so we define the map $\Phi: \operatorname{Pert}(\mathcal{E}) \rightarrow \mathrm{CB}\left(C^{*}(\mathcal{E})\right)$ by $\Phi=\left.\Psi\right|_{\operatorname{Pert}(\mathcal{E})}$. Proposition 3.4 below shows that $\Phi$ is a semigroup homomorphism of $\operatorname{Pert}(\mathcal{E})$ into $\operatorname{UCBH}(\mathcal{E})$.
Proposition 3.4. There is a semigroup homomorphism $\Phi$ from $\operatorname{Pert}(\mathcal{E})$ to $\operatorname{UCBH}(\mathcal{E})$ defined by
$\Phi: \operatorname{Pert}(\mathcal{E}) \rightarrow \operatorname{UCBH}(\mathcal{E})$,

$$
\omega \mapsto \sum a_{i}(\cdot) b_{i}
$$

with $\omega=\sum a_{i} \otimes b_{i}^{\circ} \in \operatorname{Pert}(\mathcal{E})$.
Proof. According to the definition of $\operatorname{Pert}(\mathcal{E})$ any element $\omega \in \operatorname{Pert}(\mathcal{E})$ can be written as $\omega=\sum a_{i} \otimes b_{i}^{\circ}=\sum b_{i}^{*} \otimes a_{i}^{* \circ}$, thus $\Phi(\omega)$ is a Hermitian map. The assumption that $\sum a_{i} b_{i}=\mathrm{Id}$ confirms $\Phi(\omega)$ is unital. Since there are only finitely many terms in the expression of the sum

$$
\Phi(\omega): \quad x \mapsto \sum a_{i} x b_{i}, \quad \forall x \in \mathcal{E},
$$

hence it is completely bounded due to [11, Chapter 8].
Finally we shall show that the map $\Phi: \operatorname{Pert}(\mathcal{E}) \rightarrow \operatorname{UCBH}(\mathcal{E})$ is a semigroup homomorphism. Let $\omega=\sum a_{i} \otimes b_{i}^{\circ}$ and $\widetilde{\omega}=\sum \widetilde{a}_{j} \otimes \widetilde{b}_{j}^{\circ}$ be two elements in $\operatorname{Pert}(\mathcal{E})$, we have that $\omega \widetilde{\omega}=\sum a_{i} \widetilde{a}_{j} \otimes$ $\left(\widetilde{b}_{j} b_{i}\right)^{\circ}$, and by Definition 3.2

$$
\Phi(\omega \widetilde{\omega})(x)=\sum a_{i} \widetilde{a}_{j} x \widetilde{b}_{j} b_{i}=\sum_{i} a_{i}\left(\sum_{j} \widetilde{a}_{j} x \widetilde{b}_{j}\right) b_{i} \quad \text { for any } \quad x \in \mathcal{E}
$$

thus $\Phi(\omega \widetilde{\omega})=\Phi(\omega) \Phi(\widetilde{\omega})$ for $\omega, \widetilde{\omega} \in \operatorname{Pert}(\mathcal{E})$.

We can move one step further by equipping the semigroup $\operatorname{Pert}(\mathcal{E})$ with the Haagerup tensor norm so that $\Phi$ can be extended to the closure of $\operatorname{Pert}(\mathcal{E})$. Recall that the Haagerup tensor norm $^{3}\|u\|_{h}$ of an element $u \in C^{*}(\mathcal{E}) \otimes C^{*}(\mathcal{E})^{\circ}$ is defined as

$$
\|u\|_{h}=\inf \left\{\left\|\sum a_{i} a_{i}^{*}\right\|^{1 / 2}\left\|\sum b_{i}^{*} b_{i}\right\|^{1 / 2}\right\}
$$

where the infimum is taken over all the expressions of $u=\sum a_{i} \otimes b_{i}^{\circ}$ for $a_{i}, b_{i} \in C^{*}(\mathcal{E})$. Here we omit the opposite algebra structure. Since $\operatorname{Pert}(\mathcal{E})$ is a subset of $C^{*}(\mathcal{E}) \otimes C^{*}(\mathcal{E})^{\circ}$, we can endow $\operatorname{Pert}(\mathcal{E})$ with the metric topology induced by the Haagerup tensor norm $\|\cdot\|_{h}$.

Definition 3.5. We define the closed perturbation semigroup $\overline{\operatorname{Pert}(\mathcal{E})}$ as the closure of $\operatorname{Pert}(\mathcal{E})$ with respect to the topology induced by Haagerup tensor norm $\|\cdot\|_{h}$.

Proposition 3.6. Let $\mathcal{E} \subset B(\mathcal{H})$ be a unital operator system, the map $\Phi: \operatorname{Pert}(\mathcal{E}) \rightarrow \operatorname{UCBH}(\mathcal{E})$ can be extended to a map

$$
\widetilde{\Phi}: \overline{\operatorname{Pert}(\mathcal{E})} \rightarrow \mathrm{UCBH}(\mathcal{E}),
$$

such that $\left.\widetilde{\Phi}\right|_{\operatorname{Pert}(\mathcal{E})}=\Phi$. Moreover, if we equip $\overline{\operatorname{Pert}(\mathcal{E})}$ and $\operatorname{UCBH}(\mathcal{E})$ with the metric topology induced by Haagerup tensor norm $\|\cdot\|_{h}$ and complete bound norm $\|\cdot\|_{c b}$ respectively, the map $\widetilde{\Phi}$ is contractive.

Proof. By Definition 3.2 $\operatorname{Pert}(\mathcal{E})$ is a subset of $C^{*}(\mathcal{E}) \otimes_{\text {alg }} C^{*}(\mathcal{E})$. Take an element $\omega=\sum a_{i}$ $\otimes b_{i}^{\circ} \in \operatorname{Pert}(\mathcal{E})$, we define a map $\widetilde{\Phi}: \operatorname{Pert}(\mathcal{E}) \rightarrow \mathrm{CB}(B(\mathcal{H}))$ as $\widetilde{\Phi}(\omega): T \mapsto \sum a_{i} T b_{i}$ for $T \in B(\mathcal{H})$. According to [12, Theorem 5.12], the map $\widetilde{\Phi}$ is completely isometric if we equip with $\omega$ the Haagerup norm and $\widetilde{\Phi}(\omega)$ the completely bounded norm. If we can take the closure $\overline{\operatorname{Pert}(\mathcal{E})}$, we get a map from $\overline{\operatorname{Pert}(\mathcal{E})}$ to $\operatorname{CB}(B(\mathcal{H}))$, which we still denote as $\widetilde{\Phi}$. By our definition of $\widetilde{\Phi}$, we observe that $\left.\widetilde{\Phi}\right|_{\text {Pert }(\mathcal{E})}=\Phi$, hence we only need to show that the image of $\widetilde{\Phi}$ is contained in $\operatorname{UCBH}(\mathcal{E})$.

Take a sequence of $\left\{\omega_{n}\right\}_{n \geq 1} \subset \operatorname{Pert}(\mathcal{E})$ that approaches to some $\omega \in \overline{\operatorname{Pert}(\mathcal{E})}$. Since

$$
\widetilde{\Phi}\left(\omega_{n}\right)(\mathrm{Id})=\Phi\left(\omega_{n}\right)(\mathrm{Id})=\mathrm{Id},
$$

we obtain that $\widetilde{\Phi}(\omega)$ is a unital map. Similarly, since for each $\omega_{n}$ the map $\Phi\left(\omega_{n}\right)$ is Hermitian, we conclude that $\widetilde{\Phi}(\omega)$ is Hermitian. Hence we only need to show that for any $x \in \mathcal{E}, \widetilde{\Phi}(\omega)(x) \in \mathcal{E}$.

In fact, for any $\epsilon>0$, there exists an $N>0$ such that when $n \geq N$ we have $\left\|\omega_{n}-\omega\right\|_{h}<\epsilon$. Besides that, according to [12, Theorem 5.12], if we regard $\widetilde{\Phi}\left(\omega_{n}\right)-\widetilde{\Phi}(\omega)$ as a map on $B(\mathcal{H})$ we can obtain that $\left\|\widetilde{\Phi}\left(\omega_{n}\right)-\widetilde{\Phi}(\omega)\right\|_{c b}=\left\|\omega_{n}-\omega\right\|_{h}$, since $\mathcal{E} \subset B(\mathcal{H})$. For the restriction of $\widetilde{\Phi}\left(\omega_{n}\right)-\widetilde{\Phi}(\omega)$ to $\mathcal{E}$ we obtain $\left\|\widetilde{\Phi}\left(\omega_{n}\right)-\widetilde{\Phi}(\omega)\right\|_{c b} \leq\left\|\omega_{m}-\omega\right\|_{h}$. Hence

$$
\left\|\widetilde{\Phi}\left(\omega_{n}\right)-\widetilde{\Phi}(\omega)\right\| \leq\left\|\widetilde{\Phi}\left(\omega_{n}\right)-\widetilde{\Phi}(\omega)\right\|_{c b} \leq\left\|\omega_{n}-\omega\right\|_{h}<\epsilon .
$$

Thus if we take an $x \in \mathcal{E}$, we have

$$
\frac{\left\|\widetilde{\Phi}\left(\omega_{n}\right)(x)-\widetilde{\Phi}(\omega)(x)\right\|}{\|x\|}<\epsilon .
$$

Therefore $\widetilde{\Phi}\left(\omega_{n}\right)(x) \rightarrow \widetilde{\Phi}(\omega)(x)$. So that by closedness of $\mathcal{E}$ we obtain that $\widetilde{\Phi}(\omega)(x) \in \mathcal{E}$.
Hence for an element $\omega \in \overline{\operatorname{Pert}(\mathcal{E})}$, we can consider $\widetilde{\Phi}(\omega)$ as either an element of $\operatorname{UCBH}(B(\mathcal{H}))$ or an element of $\operatorname{UCBH}(\mathcal{E})$. However, since $\mathcal{E} \subset B(\mathcal{H})$ is a subset, if we regard $\widetilde{\Phi}(\omega)$ as a element in $\operatorname{UCBH}(\mathcal{E})$, the completely bounded norm of $\widetilde{\Phi}(\omega)$ is less than or equal to the completely bounded norm of $\widetilde{\Phi}(\omega)$ as an element of $\operatorname{UCBH}(B(\mathcal{H}))$. Therefore the map $\widetilde{\Phi}$ is contractive.

[^1]For a general operator system $\mathcal{E}$ we can only conclude the map $\widetilde{\Phi}: \overline{\operatorname{Pert}(\mathcal{E})} \rightarrow \operatorname{UCBH}(\mathcal{E})$ is completely contractive rather than completely isometric.

Example 3.7. Let $\left\{E_{i j}\right\}, 1 \leq i, j \leq 2$ be the standard matrix units for $M_{2}(\mathbb{C})$. Define

$$
\mathrm{Toep}_{2}=\left\{\left(\begin{array}{ll}
a & b \\
c & a
\end{array}\right) \subset M_{2}(\mathbb{C})\right\} .
$$

Take $\omega_{1}, \omega_{2} \in \operatorname{Pert}\left(\right.$ Toep $\left._{2}\right)$ given as
$\omega_{1}=E_{12} \otimes E_{12}^{\circ}+E_{21} \otimes E_{21}^{\circ}+E_{11} \otimes E_{11}^{\circ}+E_{22} \otimes E_{22}^{\circ}$,
$\omega_{2}=\left(E_{12}+E_{21}\right) \otimes\left(E_{12}+E_{21}\right)^{\circ}$.
By a direct computation we obtain that $\Phi\left(\omega_{1}\right)=\Phi\left(\omega_{2}\right)$ on Toep ${ }_{2}$, both give rise to the transposition map on $\mathrm{Toep}_{2}$, and we observe that $E_{12}+E_{21}$ is a $2 \times 2$ unitary matrix, thus $\left\|\Phi\left(\omega_{2}\right)\right\|_{c b}=1$, and therefore we obtain that $\left\|\Phi\left(\omega_{1}\right)\right\|_{c b}=1$.

However, according to [11, Theorem 17.4], the Haagerup tensor norm $\left\|\omega_{1}\right\|_{h}$ is equal to the completely bounded norm of the transposition transformation over $M_{2}(\mathbb{C})$, which is equal to 2 . Therefore, $\left\|\Phi\left(\omega_{1}\right)\right\|_{c b}=1<\left\|\omega_{1}\right\|_{h}=2$.
Definition 3.8. We denote by $\operatorname{Pert}^{+}(\mathcal{E})$ the sub-semigroup of $\operatorname{Pert}(\mathcal{E})$ containing all the $\omega \in$ $\operatorname{Pert}(\mathcal{E})$ of the form $\omega=\sum a_{i} \otimes a_{i}^{* \circ}$ for some $a_{i} \in C^{*}(\mathcal{E})$, i.e.,

$$
\operatorname{Pert}^{+}(\mathcal{E}):=\left\{\omega \in \operatorname{Pert}(\mathcal{E}) \mid \omega=\sum a_{i} \otimes a_{i}^{* \circ} \text { for some } a_{i} \in C^{*}(\mathcal{E})\right\} .
$$

To simplify the notation we still denote the restriction $\left.\Phi\right|_{\text {Pert }^{+}(\mathcal{E})}$ to $\operatorname{Pert}^{+}(\mathcal{E})$ by $\Phi$.
Corollary 3.9. Let $\omega=\sum a_{i} \otimes a_{i}^{* \circ} \in \operatorname{Pert}^{+}(\mathcal{E})$. We have $\Phi(\omega) \in \operatorname{UCP}(\mathcal{E})$, namely
$\Phi: \operatorname{Pert}^{+}(\mathcal{E}) \rightarrow \operatorname{UCP}(\mathcal{E})$,

$$
\omega \mapsto \sum a_{i}(\cdot) a_{i}^{*} .
$$

Proof. By Proposition 3.4 we have that $\Phi(\omega) \in \operatorname{UCBH}(\mathcal{E})$ for $\omega \in \operatorname{Pert}^{+}(\mathcal{E})$, and $\Phi(\omega)(\cdot)=$ $\sum a_{i}(\cdot) a_{i}^{*}$, which is a completely positive map.

As in the case of $\operatorname{Pert}(\mathcal{E})$, we can take the closure of $\operatorname{Pert}^{+}(\mathcal{E})$ with respect to Haagerup tensor norm, which we denote as $\overline{\text { Pert }^{+}(\mathcal{E})}$.
Proposition 3.10. Let $\overline{\operatorname{Pert}^{+}(\mathcal{E})}$ be the closure of $\operatorname{Pert}^{+}(\mathcal{E})$ with respect to Haagerup tensor norm. We can extend the map $\Phi: \operatorname{Pert}^{+}(\mathcal{E}) \rightarrow \operatorname{UCP}(\mathcal{E})$ to a map

$$
\widetilde{\Phi}: \overline{\operatorname{Pert}^{+}(\mathcal{E})} \rightarrow \mathrm{UCP}(\mathcal{E}),
$$

such that $\left.\widetilde{\Phi}\right|_{\operatorname{Pert}^{+}(\mathcal{E})}=\Phi$. Moreover, we have $\|\omega\|_{h}=1$ and $\|\widetilde{\Phi}(\omega)\|_{c b}=1$ for every $\omega \in \overline{\operatorname{Pert}^{+}(\mathcal{E})}$.
Proof. Take an element $\omega \in \overline{\operatorname{Pert}^{+}(\mathcal{E})}$, according to Proposition 3.6, the map $\widetilde{\Phi}(\omega) \in \operatorname{UCBH}(\mathcal{E})$. we then need to show that $\widetilde{\Phi}(\omega)$ is completely positive. Indeed, if we take a sequence $\left\{\omega_{n}\right\}_{n \geq 1} \subset$ $\operatorname{Pert}^{+}(\mathcal{E})$ such that $\omega_{n} \rightarrow \omega$, then for any $\epsilon>0$, there exists an $N>0$ such that when $n \geq N$

$$
\begin{equation*}
\left\|\widetilde{\Phi}\left(\omega_{n}\right)-\widetilde{\Phi}(\omega)\right\|_{c b} \leq\left\|\omega_{n}-\omega\right\|_{h}<\epsilon \tag{3.1}
\end{equation*}
$$

Take a positive element $X_{k} \in M_{k}(\mathcal{E})$, then $\widetilde{\Phi}\left(\omega_{n}\right)\left(X_{k}\right) \in M_{k}(\mathcal{E})$ is also positive for all $n \in \mathbb{N}$. And by the inequality (3.1), we have

$$
\frac{\left\|\widetilde{\Phi}\left(\omega_{n}\right)\left(X_{k}\right)-\widetilde{\Phi}(\omega)\left(X_{k}\right)\right\|}{\left\|X_{k}\right\|}<\epsilon
$$

that is to say, $\widetilde{\Phi}(\omega)\left(X_{k}\right)$ is the limit point of the sequence of positive elements $\left\{\widetilde{\Phi}\left(\omega_{n}\right)\left(X_{k}\right)\right\}_{n \geq 1}$ in $M_{k}(\mathcal{E})$, thus $\widetilde{\Phi}(\omega)\left(X_{\underline{k}}\right) \in M_{k}(\mathcal{E})$ is positive. Since this is true for all $k \in \mathbb{N}, \widetilde{\Phi}(\omega)$ is completely positive and therefore $\widetilde{\Phi}(\omega) \in \operatorname{UCP}(\mathcal{E})$.

Finally, we only need to show that $\|\widetilde{\Phi}(\omega)\|_{c b}=\|\omega\|_{h}=1$ for each $\omega \in \overline{\operatorname{Pert}^{+}(\mathcal{E})}$. Take an element $\omega \in \overline{\operatorname{Pert}^{+}(\mathcal{E})}$. For any $\epsilon>0$, there exists an $\omega^{\prime} \in \operatorname{Pert}^{+}(\mathcal{E})$ such that

$$
\left\|\Phi\left(\omega^{\prime}\right)\right\|_{c b}-\epsilon \leq\|\widetilde{\Phi}(\omega)\|_{c b} \leq\|\omega\|_{h} \leq\left\|\omega^{\prime}\right\|_{h}+\epsilon .
$$

Since $\omega^{\prime} \in \operatorname{Pert}^{+}(\mathcal{E})$, we can write $\omega^{\prime}$ as $\omega^{\prime}=\sum_{i=1}^{k} a_{i} \otimes a_{i}^{* \circ}$ for some $a_{i} \in C^{*}(\mathcal{E})$, and according to Definition 3.2, we obtain that $\sum_{i=1}^{k} a_{i} a_{i}^{*}=\mathrm{Id}$. Thus

$$
\left\|\omega^{\prime}\right\|_{h} \leq\left\|\sum_{i=1}^{k} a_{i} a_{i}^{*}\right\|=1
$$

On the other hand, we observe the inequality

$$
\left\|\Phi\left(\omega^{\prime}\right)\right\|_{c b} \geq\left\|\Phi\left(\omega^{\prime}\right)\right\| \geq\left\|\Phi\left(\omega^{\prime}\right)(\mathrm{Id})\right\|=1
$$

Hence combine the three inequalities above together we conclude that

$$
1-\epsilon \leq\|\widetilde{\Phi}(\omega)\|_{c b} \leq\|\omega\|_{h} \leq 1+\epsilon .
$$

Since this is true for every $\epsilon>0$, we obtain that $\|\widetilde{\Phi}(\omega)\|_{c b}=\|\omega\|_{h}=1$ for all $\omega \in \overline{\operatorname{Pert}^{+}(\mathcal{E})}$.
We also observe that there is a map from the gauge group $\mathcal{G}(\mathcal{E})$ to the semigroup $\operatorname{Pert}^{+}(\mathcal{E})$, as stated in the following proposition.

Proposition 3.11. There is a multiplicative map from $\mathcal{G}(\mathcal{E})$ to $\operatorname{Pert}^{+}(\mathcal{E})$ defined by

$$
\begin{aligned}
\mathcal{G}(\mathcal{E}) & \rightarrow \operatorname{Pert}^{+}(\mathcal{E}), \\
u & \rightarrow u^{*} \otimes u^{\circ} .
\end{aligned}
$$

Remark 3.12. Although for an element $\omega \in \overline{\operatorname{Pert}^{+}(\mathcal{E})}$ we have $\|\widetilde{\Phi}(\omega)\|_{c b}=\|\omega\|_{h}=1$, the completely bounded norm $\left\|\widetilde{\Phi}\left(\omega_{1}\right)-\widetilde{\Phi}\left(\omega_{2}\right)\right\|_{c b}$ and the Haagerup norm of $\left\|\omega_{1}-\omega_{2}\right\|_{h}$ for two elements $\omega_{1}, \omega_{2} \in \overline{\operatorname{Pert}^{+}(\mathcal{E})}$ usually are not equal.

Consider the $2 \times 2$ Toeplitz system Toep 2 . Take $\omega_{1}, \omega_{2} \in$ Pert $^{+}\left(\right.$Toep $\left._{2}\right)$ as

$$
\omega_{1}=E_{11} \otimes E_{11}^{\circ}+E_{22} \otimes E_{22}^{\circ}, \quad \omega_{2}=E_{12} \otimes E_{21}^{\circ}+E_{21} \otimes E_{12}^{\circ},
$$

although $\omega_{1} \neq \omega_{2}$, we have $\Phi\left(\omega_{1}\right)=\Phi\left(\omega_{2}\right)$. Indeed,

$$
\Phi\left(\omega_{1}\right)=\Phi\left(\omega_{2}\right):\left(\begin{array}{ll}
a & b \\
c & a
\end{array}\right) \mapsto\left(\begin{array}{ll}
a & 0 \\
0 & a
\end{array}\right) .
$$

Therefore $\left\|\widetilde{\Phi}\left(\omega_{1}\right)-\widetilde{\Phi}\left(\omega_{2}\right)\right\|_{c b}$ is equal to 0 while $\left\|\omega_{1}-\omega_{2}\right\|_{h}$ is not.

## 4 Gauge group and perturbation semigroup of the Toeplitz system

The concept of truncated circle is introduced by Alain Connes and Walter D. van Suijlekom in [4]. Recall that the canonical spectral triple on the circle is in the form of

$$
\left(C^{\infty}\left(S^{1}\right), L^{2}\left(S^{1}\right), D=-\mathrm{i} \frac{\mathrm{~d}}{\mathrm{~d} t}\right)
$$

as discussed in [15, Chapter 5]. Let $\left\{e_{n}\right\}_{n \in \mathbb{Z}}$ be the set of eigenvectors of $D$, we consider a spectral truncation defined by the orthogonal projection $P_{n}$ onto $\operatorname{span}_{\mathbb{C}}\left\{e_{1}, e_{2}, \ldots, e_{n}\right\}$ for some $n>0$. The truncated circle with respect to $P_{n}$ is defined as

$$
\left(P_{n} C^{\infty}\left(S^{1}\right) P_{n}, P_{n} L^{2}\left(S^{1}\right), P_{n} D P_{n}\right)
$$

Since $P_{n}$ does not commute with the $*$-algebra $C^{\infty}\left(S^{1}\right), P_{n} C^{\infty}\left(S^{1}\right) P_{n}$ is only an operator system rather than an algebra. In fact, if $f \in C^{\infty}\left(S^{1}\right)$ is a smooth function with Fourier coefficients $\left\{a_{n}\right\}_{n \in \mathbb{Z}}$, then the truncation $P_{n} f P_{n}$ can be written as a Toeplitz matrix:

$$
P_{n} f P_{n}=\left(\begin{array}{ccccc}
a_{0} & a_{-1} & \cdots & a_{-n+2} & a_{-n+1} \\
a_{1} & a_{0} & a_{-1} & \cdots & a_{-n+2} \\
\vdots & a_{1} & a_{0} & \ddots & \vdots \\
a_{n-2} & \vdots & \ddots & \ddots & a_{-1} \\
a_{n-1} & a_{n-2} & \cdots & a_{1} & a_{0}
\end{array}\right)
$$

Hence it turns out that $P_{n} C^{\infty}\left(S^{1}\right) P_{n}$ is the Toeplitz operator system containing all the $n \times n$ Toeplitz matrices, which we denote as Toep ${ }_{n}$.

One interesting question is what are the gauge group and perturbation semigroup of the Toeplitz operator system $\mathrm{Toep}_{n}$. In this section, we will present the structure of gauge group $\mathcal{G}\left(\operatorname{Toep}_{n}\right)$ and some properties of perturbation semigroup Pert $\left(\operatorname{Toep}_{n}\right)$. Many properties of $\mathrm{Toep}_{n}$ are different from that of $M_{n}(\mathbb{C})$, in this section, we will also show that the transpose map on $\mathrm{Toep}_{n}$ is a UCP map, which is absolutely wrong in the case of $M_{n}(\mathbb{C})$. The readers can refer to [7] for more details and other interesting behaviors about Toeplitz operator system.

### 4.1 Gauge group of the Toeplitz system

As is shown in [4], the $C^{*}$-algebra generated by $\operatorname{Toep}_{n}$ is just $M_{n}(\mathbb{C})$. The main goal of this section is to figure out $\mathcal{G}\left(\operatorname{Toep}_{n}\right)$. One interesting phenomenon is that $\mathcal{G}\left(\operatorname{Toep}_{n}\right)$ is independent of $n$. Before proving that we need the following lemma.

Lemma 4.1. Let $U \in \mathcal{G}\left(\operatorname{Toep}_{n}\right)$, then $U$ is either a diagonal matrix or an anti-diagonal matrix.
Proof. We take a unitary matrix $U=\left(u_{i j}\right)_{1 \leq i, j \leq n} \in \mathcal{U}\left(M_{n}(\mathbb{C})\right)$ and a basis $\left\{\tau_{j}\right\}_{j=-n+1, \ldots, n-1}$ of the Toeplitz system Toep ${ }_{n}$ given by 1's on the $j$ 'th diagonal and 0 's elsewhere, i.e., for positive $k$ we have

$$
\tau_{k}=\sum_{i=1}^{n-k} E_{i, i+k}, \quad \tau_{-k}=\sum_{i=1}^{n-k} E_{i+k, i},
$$

here $E_{i, j}$ is the $n \times n$ unit matrix with 1 in $(i, j)$-entry and 0 's everywhere else. An element $U \in \mathcal{G}\left(\operatorname{Toep}_{n}\right)$ if and only if $U^{*} \tau_{j} U \in \operatorname{Toep}_{n}$ for all $j \in[-n+1, n-1]$. We observe first that when $k>0$ the $(j, l)$-entry of $U^{*} \tau_{k} U$ is given by

$$
\begin{equation*}
\left(U^{*} \tau_{k} U\right)_{j, l}=\sum_{i=1}^{n-k} \bar{u}_{i, j} u_{k+i, l}, \quad 1 \leq j, l \leq n, \tag{4.1}
\end{equation*}
$$

and

$$
\operatorname{Tr}\left(U^{*} \tau_{k} U\right)=\sum_{j=1}^{n} \sum_{i=1}^{n-k} \bar{u}_{i, j} u_{k+i, j} .
$$

Since $U$ is a unitary matrix, we have $\sum_{j=1}^{n} \bar{u}_{i, j} u_{k+i, j}=0$ for $k>0$ and $1 \leq i \leq n-k$. Thus we have

$$
\operatorname{Tr}\left(U^{*} \tau_{k} U\right)=\sum_{j=1}^{n} \sum_{i=1}^{n-k} \bar{u}_{i, j} u_{k+i, j}=0, \quad k>0
$$

Due to our assumption that $U^{*} \tau_{k} U \in \operatorname{Toep}_{n}$, we must have all the diagonal entries of $U^{*} \tau_{k} U$ are zeros:

$$
\begin{equation*}
\sum_{i=1}^{n-k} \bar{u}_{i, j} u_{k+i, j}=0, \quad k>0, \quad 1 \leq j \leq n . \tag{4.2}
\end{equation*}
$$

Take $k=n-1$ and $j=1$ in formula (4.2), we have that $\bar{u}_{1,1} u_{n, 1}=0$. However $\bar{u}_{1,1}$ and $u_{n, 1}$ can not be both equal to 0 , otherwise by equation (4.1), $U^{*} \tau_{n-1} U=0$. In fact, the equation (4.1) implies that $\left(U^{*} \tau_{n-1} U\right)_{j, l}=\bar{u}_{1, j} u_{n, l}$, suppose if $\bar{u}_{1,1}=u_{n, 1}=0$, then $\left(U^{*} \tau_{n-1} U\right)_{1, l}=\left(U^{*} \tau_{n-1} U\right)_{j, 1}=0$ for all $1 \leq j, l \leq n$. That is, all the entries in the first row and the first column of $U^{*} \tau_{n-1} U$ are 0 's, since we assume the matrix $U^{*} \tau_{n-1} U$ is a Toeplitz matrix, we conclude that $\left(U^{*} \tau_{n-1} U\right)=0$. This is a contradiction of the unitary of $U$.

Since $u_{1,1}$ and $u_{n, 1}$ can not both be equal to 0 , we first assume that $u_{1,1}=\alpha \neq 0$ and $u_{n, 1}=0$. If we take $k=n-2$ and $j=1$ in formula (4.2), we obtain that

$$
\begin{equation*}
\bar{u}_{1,1} u_{n-1,1}+\bar{u}_{2,1} u_{n, 1}=0 . \tag{4.3}
\end{equation*}
$$

Therefore we have $u_{n-1,1}=0$. We then take $k=n-3$ and $j=1$ in formula (4.2) again, we obtain the equation

$$
\begin{equation*}
\bar{u}_{1,1} u_{n-2,1}+\bar{u}_{2,1} u_{n-1,1}+\bar{u}_{3,1} u_{n, 1}=0, \tag{4.4}
\end{equation*}
$$

since $u_{1,1} \neq 0, u_{n, 1}=0$ and $u_{n-1,1}=0$, we obtain that $u_{n-2,1}=0$. By induction, take $j=1$ and $k=n-4, n-5, \ldots, 2,1$, we obtain that $u_{i, 1}=0$ for $1<i \leq n$, namely, all the entries in the first column of $U$ are equal to 0 except that $u_{1,1}=\alpha \neq 0$. Thus we can write $U$ in the matrix form as

$$
U=\left(\begin{array}{ccccc}
\alpha & u_{1,2} & u_{1,3} & \cdots & u_{1, n} \\
0 & u_{2,2} & u_{2,3} & \cdots & u_{2, n} \\
0 & u_{3,2} & u_{3,3} & \cdots & u_{3, n} \\
\vdots & \vdots & \vdots & \ddots & \vdots \\
0 & u_{n, 2} & u_{n, 3} & \cdots & u_{n, n}
\end{array}\right),
$$

and by a simple computation

$$
U^{*} \tau_{n-1} U=\left(\begin{array}{ccccc}
0 & \bar{\alpha} u_{n, 2} & \bar{\alpha} u_{n, 3} & \cdots & \bar{\alpha} u_{n, n}  \tag{4.5}\\
0 & \bar{u}_{1,2} u_{n, 2} & \bar{u}_{1,2} u_{n, 3} & \cdots & \bar{u}_{1,2} u_{n, n} \\
0 & \bar{u}_{1,3} u_{n, 2} & \bar{u}_{1,3} u_{n, 3} & \cdots & \bar{u}_{1,3} u_{n, n} \\
\vdots & \vdots & \vdots & \ddots & \vdots \\
0 & \bar{u}_{1, n} u_{n, 2} & \bar{u}_{1, n} u_{n, 3} & \cdots & \bar{u}_{1, n} u_{n, n}
\end{array}\right) .
$$

Now we show that $u_{1,2}=u_{1,3}=\cdots=u_{1, n}=0$. Since the matrix (4.5) is a Toeplitz matrix, the $(2,2)$-entry element in (4.5) must be equal to 0 , namely $\bar{u}_{1,2} u_{n, 2}=0$. Suppose $u_{1,2} \neq 0$, then we must have $u_{n, 2}=0$, which implies that the second column of (4.5) is 0 . It then implies that the $(2,3)$-entry element in (4.5) is equal to 0 , which implies $u_{n, 3}=0$ and thus the third column of (4.5) is 0 . By induction, we obtain that $u_{n, 1}=u_{n, 2}=u_{n, 3}=\cdots=u_{n, n-1}=u_{n, n}=0$, that is, $U^{*} \tau_{n-1} U=0$, which is impossible. Therefore we must have $u_{1,2}=0$, and we deduce that all the entries in the second row of (4.5) are 0's. Hence the only non-zero entry in (4.5) is the $(1, n)$-entry and all the rest entries are 0's. Namely,

$$
U^{*} \tau_{n-1} U=\bar{\alpha} u_{n, n} \tau_{n-1}
$$

Thus we obtain that $u_{1,2}=u_{1,3}=\cdots=u_{1, n}=0$. That is to say, the unitary matrix $U$ is of the form

$$
U=\left(\begin{array}{cc}
\alpha & 0 \\
0 & \tilde{U}
\end{array}\right), \quad|\alpha|=1, \quad \widetilde{U} \in \mathcal{U}\left(M_{n-1}(\mathbb{C})\right)
$$

Take a Toeplitz matrix $T=\left(t_{i j}\right)_{1 \leq i, j \leq n} \in \operatorname{Toep}_{n}$, we write $T$ in the block form as

$$
T=\left(\begin{array}{cc}
x & X \\
Y & \widetilde{T}
\end{array}\right), \quad \widetilde{T} \in \operatorname{Toep}_{n-1}
$$

here $x=t_{11}, X=\left(t_{12}, \ldots, t_{1 n}\right)$, and $Y=\left(t_{21}, \ldots, t_{n 1}\right)^{\mathrm{T}}$. A simple computation shows that

$$
U^{*} T U=\left(\begin{array}{cc}
x & \bar{\alpha} X \widetilde{U} \\
\alpha \widetilde{U}^{*} Y & \widetilde{U}^{*} \widetilde{T} \widetilde{U}
\end{array}\right) \in \operatorname{Toep}_{n}
$$

which implies that $\widetilde{U}^{*} \widetilde{T} \widetilde{U} \in \operatorname{Toep}_{n-1}$. Apply the same argument to $\widetilde{U} \in \operatorname{Toep}_{n-1}$, we obtain that the $(n-1) \times(n-1)$ unitary matrix $\widetilde{U}$ is of the form

$$
\widetilde{U}=\left(\begin{array}{cc}
\beta & 0 \\
0 & \widehat{U}
\end{array}\right), \quad|\beta|=1, \quad \widehat{U} \in \mathcal{U}\left(M_{n-2}(\mathbb{C})\right)
$$

apply the same argument to $\widehat{U}$ again, by induction we obtain that $U$ is a diagonal matrix when $u_{1,1} \neq 0$.

On the other hand, when $u_{1,1}=0$ and $u_{n, 1}=\alpha \neq 0$, the equation (4.3) then implies that $u_{2,1}=0$, and the equation (4.4) implies that $u_{3,1}=0$, by induction, take $k=n-4, n-5, \ldots, 2,1$ and $j=1$, we obtain that the first column of $U$ are all zeros except $u_{n, 1} \neq 0$. Namely the unitary matrix $U$ is of the form

$$
U=\left(\begin{array}{ccccc}
0 & u_{1,2} & \cdots & u_{1, n-1} & u_{1, n} \\
0 & u_{2,2} & \cdots & u_{2, n-1} & u_{2, n} \\
\vdots & \vdots & \ddots & \vdots & \vdots \\
0 & u_{n-1,2} & \cdots & u_{n-1, n-1} & u_{n-1, n} \\
\alpha & u_{n, 2} & \cdots & u_{n, n-1} & u_{n, n}
\end{array}\right)
$$

and by a direct computation we can write the matrix $U^{*} \tau_{n-1} U$ as

$$
U^{*} \tau_{n-1} U=\left(\begin{array}{ccccc}
0 & 0 & \cdots & 0 & 0 \\
\bar{u}_{1,2} \alpha & \bar{u}_{1,2} u_{n, 2} & \cdots & \bar{u}_{1,2} u_{n, n-1} & \bar{u}_{1,2} u_{n, n} \\
\vdots & \vdots & \ddots & \vdots & \vdots \\
\bar{u}_{1, n-1} \alpha & \bar{u}_{1, n-1} u_{n, 2} & \cdots & \bar{u}_{1, n-1} u_{n, n-1} & \bar{u}_{1, n-1} u_{n, n} \\
\bar{u}_{1, n} \alpha & \bar{u}_{1, n} u_{n, 2} & \cdots & \bar{u}_{1, n} u_{n, n-1} & \bar{u}_{1, n} u_{n, n}
\end{array}\right)
$$

Using a similar argument as in the case of $u_{1,1} \neq 0$ and $u_{n, 1}=0$, we can deduce that $U$ is an anti-diagonal matrix if $u_{1,1}=0$ and $u_{n, 1} \neq 0$.

The gauge group $\mathcal{G}\left(\operatorname{Toep}_{n}\right)$ has a more explicit expression as given below.
Proposition 4.2. The gauge group $\mathcal{G}\left(\operatorname{Toep}_{n}\right)$ is generated by the diagonal matrices $U_{\alpha, \beta}$ and anti-diagonal matrix $V$ of the form

$$
U_{\alpha, \beta}=\left(\begin{array}{ccccc}
\alpha & 0 & 0 & \cdots & 0  \tag{4.6}\\
0 & \beta & 0 & \cdots & 0 \\
0 & 0 & \bar{\alpha} \beta^{2} & \cdots & 0 \\
\vdots & \vdots & \vdots & \ddots & \vdots \\
0 & 0 & 0 & \cdots & \bar{\alpha}^{n-2} \beta^{n-1}
\end{array}\right), \quad V=\left(\begin{array}{ccccc}
0 & \cdots & 0 & 0 & 1 \\
0 & \cdots & 0 & 1 & 0 \\
0 & \cdots & 1 & 0 & 0 \\
\vdots & . & \vdots & \vdots & \vdots \\
1 & \cdots & 0 & 0 & 0
\end{array}\right), \quad|\alpha|=|\beta|=1 .
$$

Proof. According to Lemma 4.1, any $U \in \mathcal{G}\left(\operatorname{Toep}_{n}\right)$ is either a diagonal matrix or an antidiagonal matrix. Suppose $U$ is a diagonal matrix, then $U$ can be expressed as

$$
U=\left(\begin{array}{cccc}
\alpha_{1} & 0 & \cdots & 0 \\
0 & \alpha_{2} & \cdots & 0 \\
\vdots & \vdots & \ddots & \vdots \\
0 & 0 & \cdots & \alpha_{n}
\end{array}\right)
$$

with $\left|\alpha_{i}\right|=1$ for $i=1,2, \ldots, n$. We then obtain

$$
U^{*} \tau_{1} U=\left(\begin{array}{ccccc}
0 & \bar{\alpha}_{1} \alpha_{2} & 0 & \cdots & 0 \\
0 & 0 & \bar{\alpha}_{2} \alpha_{3} & \cdots & 0 \\
\vdots & \vdots & \ddots & \cdots & \vdots \\
0 & 0 & 0 & \cdots & \bar{\alpha}_{n-1} \alpha_{n} \\
0 & 0 & 0 & \cdots & 0
\end{array}\right),
$$

since $U^{*} \tau_{1} U \in \operatorname{Toep}_{n}$, we must have $\bar{\alpha}_{1} \alpha_{2}=\bar{\alpha}_{2} \alpha_{3}=\cdots=\bar{\alpha}_{n-1} \alpha_{n}$. If we take $\alpha_{1}=\alpha$ and $\alpha_{2}=\beta$, we must have $\alpha_{i}=\bar{\alpha}^{i-2} \beta^{i-1}$ for $3 \leq i \leq n$, hence we obtain the unitary matrix $U_{\alpha, \beta}$ as given in (4.6).

Now suppose if the unitary matrix $W$ is an anti-diagonal matrix of the form

$$
W=\left(\begin{array}{ccccc}
0 & 0 & \cdots & 0 & \alpha_{1} \\
0 & 0 & \cdots & \alpha_{2} & 0 \\
\vdots & \vdots & \ddots & \vdots & \vdots \\
0 & \alpha_{n-1} & \cdots & 0 & 0 \\
\alpha_{n} & 0 & \cdots & 0 & 0
\end{array}\right) .
$$

Using a similar argument we can show that

$$
W=\left(\begin{array}{ccccc}
0 & 0 & \cdots & 0 & \alpha \\
0 & 0 & \cdots & \beta & 0 \\
\vdots & \vdots & \ddots & \vdots & \vdots \\
0 & \bar{\alpha}^{n-3} \beta^{n-2} & \cdots & 0 & 0 \\
\bar{\alpha}^{n-2} \beta^{n-1} & 0 & \cdots & 0 & 0
\end{array}\right), \quad \alpha, \beta \in \mathbb{C} \quad \text { and } \quad|\alpha|=|\beta|=1 .
$$

We denote this matrix $W$ as $W_{\alpha, \beta}$, and take $V=W_{1,1}$. Observe that any $W_{\alpha, \beta}$ can be expressed as the product of $V$ and $U_{\alpha, \beta}$, i.e.,

$$
W_{\alpha, \beta}=V U_{\alpha, \beta}
$$

therefore the gauge group $\mathcal{G}\left(\operatorname{Toep}_{n}\right)$ is generated by $U_{\alpha, \beta}$ and $V$, with $|\alpha|=|\beta|=1$.

Moreover, if we denote by $\omega=\alpha \bar{\beta}$, let

$$
\Omega_{\omega}=\left(\begin{array}{ccccc}
1 & \bar{\omega} & \bar{\omega}^{2} & \ldots & \bar{\omega}^{n-1} \\
\omega & 1 & \bar{\omega} & \cdots & \bar{\omega}^{n-2} \\
\omega^{2} & \omega & 1 & \cdots & \bar{\omega}^{n-3} \\
\vdots & \vdots & \vdots & \ddots & \vdots \\
\omega^{n-1} & \omega^{n-2} & \omega^{n-3} & \ldots & 1
\end{array}\right)
$$

and we denote by $\Gamma: T \mapsto T^{\mathrm{T}}$ the transposition action of $T \in \operatorname{Toep}_{n}$, we obtain that

$$
\begin{align*}
& U_{\alpha, \beta}^{*} T U_{\alpha, \beta}=\Omega_{\omega} \odot T  \tag{4.7}\\
& U_{\alpha, \beta}^{*} V^{*} T V U_{\alpha, \beta}=\Omega_{\omega} \odot \Gamma(T),  \tag{4.8}\\
& V^{*} U_{\alpha, \beta}^{*} T U_{\alpha, \beta} V=\Omega_{\bar{\omega}} \odot \Gamma(T), \tag{4.9}
\end{align*}
$$

here $\Omega_{\omega} \odot T$ denotes the Schur product of $\Omega_{\omega}$ and $T$, that is, the elementwise product of $\Omega_{\omega}$ and $T$. Hence we obtain the following corollary.

Corollary 4.3. The group of $\mathrm{UCP}_{\mathrm{rank}=1}\left(\mathrm{Toep}_{n}\right)$ is isomorphic to the semidirect product of $U(1)$ and $\mathbb{Z}_{2}$, and the gauge group $\mathcal{G}\left(\operatorname{Toep}_{n}\right)$ is different from $\mathrm{UCP}_{\mathrm{rank}=1}\left(\operatorname{Toep}_{n}\right)$ by a phase factor, that is,

$$
\begin{equation*}
\mathrm{UCP}_{\text {rank }=1}\left(\operatorname{Toep}_{n}\right)=U(1) \rtimes \mathbb{Z}_{2} \tag{4.10}
\end{equation*}
$$

and

$$
\begin{equation*}
\mathcal{G}\left(\operatorname{Toep}_{n}\right)=U(1) \times\left(U(1) \rtimes \mathbb{Z}_{2}\right) . \tag{4.11}
\end{equation*}
$$

Moreover, We have the short exact sequence which is independent of $n$ :

$$
1 \longrightarrow U(1) \longrightarrow \mathcal{G}\left(\operatorname{Toep}_{n}\right) \longrightarrow \mathrm{UCP}_{\mathrm{rank}=1}\left(\operatorname{Toep}_{n}\right) \longrightarrow 1
$$

Proof. We first show that the group $\mathrm{UCP}_{\mathrm{rank}=1}\left(\mathrm{Toep}_{n}\right)$ is isomorphic to the semidirect product of $U(1)$ and $\mathbb{Z}_{2}$. In fact, according to the r.h.s.'s of equations (4.7)-(4.9), the group $\mathrm{UCP}_{\mathrm{rank}=1}\left(\mathrm{Toep}_{n}\right)$ is characterized by $\Omega_{\omega}$ and the transposition action $\Gamma$. We observe that $\Gamma \circ \Omega_{\omega} \circ \Gamma=\Omega_{\bar{\omega}}$, and if we equip the collection of matrices $\left\{\Omega_{\omega}\right\}_{\omega}$ with Schur product, it is obvious to see that $\left\{\Omega_{\omega}\right\}_{\omega}$ is isomorphic to $U(1)$, therefore we obtain the formula (4.10).

Since $\omega$ is determined by the product of $\alpha$ and $\bar{\beta}$, while the matrix $U_{\alpha, \beta}$ is determined by $\alpha$ and $\beta$, hence compared with $\mathrm{UCP}_{\mathrm{rank}=1}\left(\operatorname{Toep}_{n}\right)$, the gauge group $\mathcal{G}\left(\mathrm{Toep}_{n}\right)$ has one more $U(1)$ factor, therefore we obtain the formula (4.11).

Remark 4.4. Although the transposition map is not completely positive on $M_{n}(\mathbb{C})$, however, it is unital completely positive on the Toeplitz system $\operatorname{Toep}_{n}$ given by $V^{*}(\cdot) V$, that is to say, for a general $T \in M_{n}(\mathbb{C})$ we do not have $V^{*} T V=T^{\mathrm{T}}$, while if $T \in \mathrm{Toep}_{n}$ this equality does hold, as is also discussed in [7].

### 4.2 Perturbation semigroup of the Toeplitz system

In this section, we shall characterize the semigroups Pert $\left(\operatorname{Toep}_{n}\right)$ and $\operatorname{Pert}{ }^{+}\left(\operatorname{Toep}_{n}\right)$. We first need to recall the definition of the vectorization of a matrix as is defined in [14].

Definition $4.5([14$, Section 2$])$. Let $T \in M_{n \times m}(\mathbb{C})$, we define the vectorization $\operatorname{vec}(T)$ of $T$ as

$$
\begin{aligned}
\mathrm{vec}: M_{n \times m}(\mathbb{C}) & \rightarrow \mathbb{C}^{n m}, \\
T & \mapsto \sum_{j=1}^{m} e_{j}^{(m)} \otimes T e_{j}^{(m)},
\end{aligned}
$$

here the tensor notation is in the sense of Kronecker product, corresponding to the standard identification $\mathbb{C}^{n m} \cong \mathbb{C}^{m} \otimes \mathbb{C}^{n}$, and $e_{j}^{(m)}$ denotes the $j$-th basis element in $\mathbb{C}^{m}$, i.e., $e_{j}^{(m)}=$ $(0, \ldots, 1, \ldots, 0)^{\mathrm{T}}$ with the $j$-th entry is equal to 1 and 0 's otherwise.

For example, if $T=\left(t_{i j}\right)_{1 \leq i, j \leq 3} \in M_{3}(\mathbb{C})$, then

$$
\text { vec: }\left(\begin{array}{ccc}
t_{11} & t_{12} & t_{13} \\
t_{21} & t_{22} & t_{23} \\
t_{31} & t_{32} & t_{33}
\end{array}\right) \mapsto\left(t_{11}, t_{21}, t_{31}, t_{12}, t_{22}, t_{32}, t_{13}, t_{23}, t_{33}\right)^{\mathrm{T}}
$$

Remark 4.6. As it is shown in [14, Section 2] we have the formula

$$
\operatorname{vec}\left(A X B^{\mathrm{T}}\right)=(B \otimes A) \operatorname{vec}(X), \quad A \in M_{n \times m}(\mathbb{C}), \quad B \in M_{k \times l}(\mathbb{C}), \quad X \in M_{m \times l}(\mathbb{C})
$$

We take a matrix $\Delta \in M_{n^{2} \times(2 n-1)}(\mathbb{C})$ as

$$
\Delta=\left(\operatorname{vec}\left(\tau_{-n+1}\right), \operatorname{vec}\left(\tau_{-n+2}\right), \ldots, \operatorname{vec}\left(\tau_{0}\right), \operatorname{vec}\left(\tau_{1}\right), \operatorname{vec}\left(\tau_{2}\right), \ldots, \operatorname{vec}\left(\tau_{n-1}\right)\right)
$$

Consider the semigroup homomorphism $\Phi: \operatorname{Pert}\left(\operatorname{Toep}_{n}\right) \rightarrow \mathrm{UCBH}\left(\operatorname{Toep}_{n}\right)$ as is defined in Section 3. We denote the image of $\omega \in \operatorname{Pert}\left(\operatorname{Toep}_{n}\right)$ by $\varphi$, i.e., $\varphi=\Phi(\omega) \in \mathrm{UCBH}\left(\operatorname{Toep}_{n}\right)$. Take $\left\{\tau_{i}\right\}_{-n+1 \leq i \leq n-1}$ as the basis of $\operatorname{Toep}_{n}$, we can identify $\varphi$ with a $(2 n-1) \times(2 n-1)$ matrix $W=\left(w_{i j}\right)_{-n+1 \leq i, j \leq n-1}$ such that

$$
\begin{equation*}
\varphi\left(\tau_{j}\right)=\sum_{i=-n+1}^{n-1} w_{i j} \tau_{i} \tag{4.12}
\end{equation*}
$$

If we regard the tensor product in the definition of $\operatorname{Pert}\left(\operatorname{Toep}_{n}\right)$ as Kronecker product, we can then treat an element $\omega \in \operatorname{Pert}\left(\operatorname{Toep}_{n}\right)$ as a $n^{2} \times n^{2}$ matrix, which we still denote as $\omega$ without confusion. In the case of Toeplitz operator system Toep ${ }_{n}$, the $C^{*}$-algebra generated by $\operatorname{Toep}_{n}$ is $M_{n}(\mathbb{C})$. The opposite algebra $M_{n}(\mathbb{C})^{\circ}$ is the transposition of $M_{n}(\mathbb{C})$, and an element $a^{\circ} \in M_{n}(\mathbb{C})^{\circ}$ is just equal to $a^{T}$. The relationship between $\omega$ and $\varphi$ is described in the following proposition.

Proposition 4.7. Let $\omega \in \operatorname{Pert}\left(\operatorname{Toep}_{n}\right)$, then we have the equation

$$
\begin{equation*}
\omega \Delta=\Delta \bar{W} \tag{4.13}
\end{equation*}
$$

here $W \in M_{2 n-1}(\mathbb{C})$ is the square matrix associated with $\Phi(\omega)=\varphi \in \mathrm{UCBH}\left(\operatorname{Toep}_{n}\right)$ defined by equation (4.12), and $\bar{W}$ denotes the elementwise complex conjugation of $W$.

Proof. Let $\omega=\sum a_{k} \otimes b_{k}^{\mathrm{T}} \in \operatorname{Pert}\left(\operatorname{Toep}_{n}\right)$. We observe that for $-n+1 \leq j \leq n-1$, the $j-$ th column of $\omega \Delta$ is equal to

$$
\sum_{i} a_{i} \otimes b_{i}^{\mathrm{T}}\left(\operatorname{vec}\left(\tau_{j}\right)\right)=\operatorname{vec}\left(\sum_{i} b_{i}^{\mathrm{T}} \tau_{j} a_{i}^{\mathrm{T}}\right)=\operatorname{vec}\left(\sum_{i}\left(a_{i} \tau_{-j} b_{i}\right)^{\mathrm{T}}\right)=\operatorname{vec}\left(\varphi\left(\tau_{-j}\right)^{\mathrm{T}}\right)
$$

The equation (4.12) implies that

$$
\operatorname{vec}\left(\varphi\left(\tau_{-j}\right)^{\mathrm{T}}\right)=\sum_{i=-n+1}^{n-1} w_{i,-j} \operatorname{vec}\left(\tau_{-i}\right)=\sum_{i=-n+1}^{n-1} w_{-i,-j} \operatorname{vec}\left(\tau_{i}\right) .
$$

Since $\varphi$ is a Hermitian map, we conclude that $w_{i j}=\overline{w_{-i,-j}}$. Indeed, we observe that

$$
\varphi\left(\tau_{j}\right)=\varphi\left(\tau_{-j}\right)^{*} \Rightarrow \sum w_{i j} \tau_{i}=\sum \overline{w_{-i,-j}} \tau_{i} \Rightarrow w_{i j}=\overline{w_{-i,-j}},
$$

hence

$$
\begin{equation*}
\operatorname{vec}\left(\varphi\left(\tau_{-j}\right)^{\mathrm{T}}\right)=\sum_{i=-n+1}^{n-1} \overline{w_{i j}} \operatorname{vec}\left(\tau_{i}\right) \tag{4.14}
\end{equation*}
$$

notice that the l.h.s. of (4.14) is the $j$-th column of $\omega \Delta$, and the r.h.s. of (4.14) is the $j$-th column of $\Delta \bar{W}$ for $-n+1 \leq j \leq n-1$, therefore we obtain the equation (4.13).

Remark 4.8. To simplify the expression we count the rows and columns of the $(2 n-1) \times(2 n-1)$ matrix $W$ from $-n+1$ to $n-1$. Since $\varphi$ is a unital map, i.e., $\varphi\left(\tau_{0}\right)=\tau_{0}$, the 0 -th column of $W$ is $(0, \ldots, 0,1,0, \ldots, 0)^{\mathrm{T}}$ with 1 in the central entry and 0 's elsewhere.

Remark 4.9. It is not difficult to show that $\operatorname{rank}(\Delta)=2 n-1$ by a direct computation, hence for each $\omega \in \operatorname{Pert}\left(\operatorname{Toep}_{n}\right)$ there is a unique $(2 n-1) \times(2 n-1)$ matrix $W$ satisfying the equation (4.13). Especially, we have that $\omega \Delta=\Delta$ if and only if $\Phi(\omega)=\operatorname{Id} \in \operatorname{UCP}\left(\operatorname{Toep}_{n}\right)$.

The matrix $\omega \in M_{n^{2}}(\mathbb{C})$ is not Hermitian in general. However, in [13] it is shown that we can transform $\omega$ to become a Hermitian matrix.

Definition 4.10 ([13, Section 1]). Let $T=\left(t_{i j}\right)_{1 \leq i, j \leq n^{2}} \in M_{n^{2}}(\mathbb{C})$, we may write $T$ in the block form as $T=\left(T_{i j}\right)_{1 \leq i, j \leq n}$, where $T_{i j}=\left(t_{r s}^{i j}\right)_{1 \leq r, s \leq n} \in M_{n}(\mathbb{C})$. We define $\Gamma: M_{n^{2}}(\mathbb{C}) \rightarrow$ $M_{n}\left(M_{n}(\mathbb{C})\right)$ as follows:

$$
\Gamma(T)_{r s}^{i j}=t_{[i, j],[r, s]}, \quad i, j, r, s=1, \ldots, n,
$$

here $[i, j]=(i-1) n+j$.
That is to say, we rearrange each row in $T \in M_{n^{2}}(\mathbb{C})$ to become a new block and then reorder all blocks together. For example, for $n=2$,

$$
T=\left(\begin{array}{cccc}
t_{11} & t_{12} & t_{13} & t_{14} \\
t_{21} & t_{22} & t_{23} & t_{24} \\
t_{31} & t_{32} & t_{33} & t_{34} \\
t_{41} & t_{42} & t_{43} & t_{44}
\end{array}\right), \quad \text { and } \quad \Gamma(T)=\left(\begin{array}{cccc}
t_{11} & t_{12} & t_{21} & t_{22} \\
t_{13} & t_{14} & t_{23} & t_{24} \\
t_{31} & t_{32} & t_{41} & t_{42} \\
t_{33} & t_{34} & t_{43} & t_{44}
\end{array}\right) .
$$

Theorem $4.11\left(\left[13\right.\right.$, Theorems 1 and 2]). $\operatorname{Let} \mathcal{T}: M_{n}(\mathbb{C}) \rightarrow M_{n}(\mathbb{C})$ be a linear map, $\langle\mathcal{T}\rangle$ be the matrix representation of $\mathcal{T}$ with respect to the unit matrices $E_{i, j}$. The following are equivalent:

- $\mathcal{T}: M_{n}(\mathbb{C}) \rightarrow M_{n}(\mathbb{C})$ is completely positive (resp. Hermitian-preserving).
- There exist $A_{1}, \ldots, A_{s} \in M_{n}(\mathbb{C})$ such that $\langle\mathcal{T}\rangle=\sum_{i=1}^{s} A_{i} \otimes \bar{A}_{i}$ (resp. $\langle\mathcal{T}\rangle=\sum_{i=1}^{s} \epsilon_{i} A_{i} \otimes \bar{A}_{i}$ for $\left.\epsilon_{1}, \ldots, \epsilon_{s} \in\{ \pm 1\}\right)$.
- There exist $A_{1}, \ldots, A_{s} \in M_{n}(\mathbb{C})$ and $a s \times s$ positive semidefinite (resp. Hermitian) matrix $\left(d_{i j}\right)$ such that $\langle\mathcal{T}\rangle=\sum_{i, j=1}^{s} d_{i j} A_{i} \otimes \bar{A}_{j}$.
- $\Gamma(\langle\mathcal{T}\rangle)$ is positive semidefinite (resp. Hermitian).
- $\Gamma\left(\langle\mathcal{T}\rangle^{\mathrm{T}}\right)$ is positive semidefinite (resp. Hermitian).

In our case, we notice that if we regard $\omega$ as a matrix in $M_{n^{2}}(\mathbb{C})$, then $\omega$ plays the role of $\langle\mathcal{T}\rangle$ above. Hence we have the following result:

Theorem 4.12. If $\omega=\sum a_{i} \otimes b_{i}^{\circ} \in \operatorname{Pert}\left(\operatorname{Toep}_{n}\right)\left(\right.$ resp. Pert $\left.^{+}\left(\operatorname{Toep}_{n}\right)\right)$, then we have

- $\Gamma(\omega)$ is a Hermitian (resp. positive semidefinite) $n^{2} \times n^{2}$ matrix,
- $\varphi=\Phi(\omega)$ can be extended as a Hermitian-preserving (resp. completely positive) map from $M_{n}(\mathbb{C})$ to $M_{n}(\mathbb{C})$, where $\Phi$ is defined as $\Phi(\omega): X \mapsto \sum a_{i}(X) b_{i}$ for $X \in M_{n}(\mathbb{C})$, and hence we obtain the following two semigroup homomorphisms:

$$
\begin{aligned}
& \operatorname{Pert}\left(\operatorname{Toep}_{n}\right) \xrightarrow{\Phi} \mathrm{UCBH}\left(\operatorname{Toep}_{n}\right), \\
& \operatorname{Pert}^{+}\left(\operatorname{Toep}_{n}\right) \xrightarrow{\Phi} \mathrm{UCP}\left(\operatorname{Toep}_{n}\right) .
\end{aligned}
$$

Example 4.13. We now characterize the semigroup Pert $\left(\mathrm{Toep}_{2}\right)$ and Pert ${ }^{+}\left(\mathrm{Toep}_{2}\right)$. Since the basis of $\mathrm{Toep}_{2}$ is $\left\{\tau_{-1}, \tau_{0}, \tau_{1}\right\}$, we take

$$
\Delta=\left(\operatorname{vec}\left(\tau_{-1}\right), \operatorname{vec}\left(\tau_{0}\right), \operatorname{vec}\left(\tau_{1}\right)\right)=\left(\begin{array}{lll}
0 & 1 & 0 \\
1 & 0 & 0 \\
0 & 0 & 1 \\
0 & 1 & 0
\end{array}\right) .
$$

Let $\varphi \in \mathrm{UCBH}\left(\mathrm{Toep}_{2}\right)$, then $\varphi$ is determined by a $3 \times 3$ matrix

$$
W=\left(\begin{array}{ccc}
a & 0 & \bar{c} \\
b & 1 & \bar{b} \\
c & 0 & \bar{a}
\end{array}\right) \in M_{3}(\mathbb{C})
$$

given by equation (4.12), more explicitly,

$$
\begin{aligned}
\varphi: \text { Toep }_{2} & \rightarrow \text { Toep }_{2}, \\
\left(\begin{array}{ll}
0 & 0 \\
1 & 0
\end{array}\right) & \mapsto\left(\begin{array}{ll}
b & c \\
a & b
\end{array}\right), \\
\left(\begin{array}{ll}
1 & 0 \\
0 & 1
\end{array}\right) & \mapsto\left(\begin{array}{ll}
1 & 0 \\
0 & 1
\end{array}\right), \\
\left(\begin{array}{ll}
0 & 1 \\
0 & 0
\end{array}\right) & \mapsto\left(\begin{array}{ll}
\bar{b} & \bar{a} \\
\bar{c} & \bar{b}
\end{array}\right) .
\end{aligned}
$$

Let

$$
T=\left(\begin{array}{cccc}
0 & 1 & 0 & 0 \\
1 & 0 & 0 & 0 \\
0 & 0 & 1 & 0 \\
0 & 1 & 0 & 1
\end{array}\right), \quad I=\left(\begin{array}{ccc}
1 & 0 & 0 \\
0 & 1 & 0 \\
0 & 0 & 1 \\
0 & 0 & 0
\end{array}\right),
$$

a direct calculation shows that $\Delta=T I$. Let $\omega$ be an element in $\operatorname{Pert}\left(\operatorname{Toep}_{n}\right)$ such that $\Phi(\omega)=\varphi$, the Proposition 4.7 implies that

$$
T^{-1} \omega T I=I \bar{W}
$$

thus $T^{-1} \omega T$ can be expressed as

$$
T^{-1} \omega T=\left(\begin{array}{cccc}
\bar{a} & 0 & c & z_{1} \\
\bar{b} & 1 & b & z_{2} \\
\bar{c} & 0 & a & z_{3} \\
0 & 0 & 0 & z_{4}
\end{array}\right)
$$

for some $z_{1}, \ldots, z_{4} \in \mathbb{C}$, and therefore

$$
\omega=\left(\begin{array}{cccc}
1-z_{2} & \bar{b} & b & z_{2} \\
-z_{1} & \bar{a} & c & z_{1} \\
-z_{3} & \bar{c} & a & z_{3} \\
-z_{2}-z_{4}+1 & \bar{b} & b & z_{2}+z_{4}
\end{array}\right), \quad \Gamma(\omega)=\left(\begin{array}{cccc}
1-z_{2} & \bar{b} & -z_{1} & \bar{a} \\
b & z_{2} & c & z_{1} \\
-z_{3} & \bar{c} & -z_{2}-z_{4}+1 & \bar{b} \\
a & z_{3} & b & z_{2}+z_{4}
\end{array}\right)
$$

According to Theorem 4.12, $\Gamma(\omega)$ is a Hermitian matrix; thus we must have $z_{2}, z_{4} \in \mathbb{R}$ and $z_{3}=\overline{z_{1}}$. Hence $\omega \in \operatorname{Pert}\left(\operatorname{Toep}_{2}\right)$ if and only if $\omega$ and $\Gamma(\omega)$ are of the forms

$$
\omega=\left(\begin{array}{cccc}
1-z_{2} & \bar{b} & b & z_{2} \\
-z_{1} & \bar{a} & c & z_{1} \\
-\bar{z}_{1} & \bar{c} & a & \bar{z}_{1} \\
1-z_{2}-z_{4} & \bar{b} & b & z_{2}+z_{4}
\end{array}\right), \quad \Gamma(\omega)=\left(\begin{array}{cccc}
1-z_{2} & \bar{b} & -z_{1} & \bar{a} \\
b & z_{2} & c & z_{1} \\
-\bar{z}_{1} & \bar{c} & -z_{2}-z_{4}+1 & \bar{b} \\
a & \bar{z}_{1} & b & z_{2}+z_{4}
\end{array}\right)
$$

with $z_{2}, z_{4} \in \mathbb{R}$ and $z_{1} \in \mathbb{C}$. Moreover, if $\Gamma(\omega)$ is positive semidefinite then $\omega \in \operatorname{Pert}^{+}\left(\operatorname{Toep}_{n}\right)$.
We also obtain the positive definite matrix $\Gamma(\omega)$ :

$$
\Gamma(\omega)=\left(\begin{array}{cccc}
1-z_{2} & 0 & -z_{1} & 1 \\
0 & z_{2} & 0 & z_{1} \\
-\overline{z_{1}} & 0 & 1-z_{2}-z_{4} & 0 \\
1 & \overline{z_{1}} & 0 & z_{2}+z_{4}
\end{array}\right)
$$

In the case of Toeplitz system, since the $C^{*}$-algebra generated by $\operatorname{Toep}_{n}$ is $M_{n}(\mathbb{C})$, which is a nuclear $C^{*}$-algebra, and since the Haagerup tensor norm is a $C^{*}$-cross norm [5, Corollary 2.2], we conclude that $\|\omega\|=\|\omega\|_{h}$ for an element $\omega \in \operatorname{Pert}\left(\right.$ Toep $\left._{n}\right)$. According to Proposition 3.10, for $\omega \in \operatorname{Pert}^{+}\left(\operatorname{Toep}_{n}\right)$ we have $\|\omega\|=1$. We then obtain the following proposition.

Proposition 4.14. Let $\varphi \in \mathrm{UCBH}\left(\operatorname{Toep}_{n}\right), W \in M_{2 n-1}(\mathbb{C})$ be the corresponding matrix, and $\Delta=\left(\operatorname{vec}\left(\tau_{i}\right)\right)_{-n+1 \leq i \leq n-1} \in M_{n^{2} \times(2 n-1)}(\mathbb{C})$. A necessary condition for $\varphi \in \mathrm{UCP}\left(\operatorname{Toep}_{n}\right)$ is that $\|\Delta \bar{W}\| \leq\|\Delta\|$.

Proof. If $\varphi \in \operatorname{UCP}\left(\operatorname{Toep}_{n}\right)$, i.e., the $\operatorname{map} \operatorname{Toep}_{n} \xrightarrow{\varphi} \operatorname{Toep}_{n}$ is a UCP map, according to Arveson's extension theorem $[1,11]$, we can always extend $\varphi$ to a UCP map $\widetilde{\varphi}$ over $M_{n}(\mathbb{C})$, i.e., $M_{n}(\mathbb{C}) \xrightarrow{\widetilde{\varphi}} M_{n}(\mathbb{C})$, and since any UCP map $\widetilde{\varphi}$ over $M_{n}(\mathbb{C})$ can be expressed as $\widetilde{\varphi}(X)=$ $\sum V_{i}^{*} X V_{i}$ for finitely many $V_{i} \in M_{n}(\mathbb{C})$, we can take $\omega=\sum V_{i} \otimes V_{i}^{\circ}$ such that $\Phi(\omega)=\varphi$. By Proposition 4.7 we have the equality $\omega \Delta=\Delta \bar{W}$. Hence

$$
\|\Delta \bar{W}\|=\|\omega \Delta\| \leq\|\omega\|\|\Delta\|
$$

and since $\|\omega\|=1$, we obtain that $\|\Delta \bar{W}\| \leq\|\Delta\|$.

## A Operator systems

This appendix contains some basic definitions and results about operator systems. In our case we only consider the concrete operator systems, i.e., $\mathcal{E} \subset B(\mathcal{H})$ for some Hilbert space $\mathcal{H}$. We refer the reader $[2,6,11]$ for more details about operator systems.
Definition A.1. Let $\mathcal{H}$ be a Hilbert space, $B(\mathcal{H})$ be the set of all bounded operators on $\mathcal{H}$. A concrete operator system is a (closed) linear subspace $\mathcal{E}$ of $B(\mathcal{H})$. If $\mathcal{E}$ is closed under the involution, i.e., $x \in \mathcal{E}$ implies $x^{*} \in \mathcal{E}$, then $\mathcal{E}$ is called an operator system. In this paper, we always assume the identity element $\operatorname{Id} \in \mathcal{E} \subset B(\mathcal{H})$.

Let $\mathcal{H}^{(n)}$ be the direct sum of $n$ copies of $\mathcal{H}, M_{n}(\mathcal{E})$ be the set of all $n \times n$ matrices with entries in $\mathcal{E}$. Since we have the $C^{*}$-isomorphism $M_{n}(B(\mathcal{H})) \cong B\left(\mathcal{H}^{(n)}\right)$, thus we can identify each element $\left(x_{i j}\right) \in M_{n}(\mathcal{E})$ as an operator in $B\left(\mathcal{H}^{(n)}\right)$, and $\left(x_{i j}\right)$ inherits a norm $\|\cdot\|_{n}$ from $B\left(\mathcal{H}^{(n)}\right)$, thus $M_{n}(\mathcal{E})$ turns out to be a normed vector space.

Let $\mathcal{E} \subset B(\mathcal{H})$ for be an operator system, if there is a linear map $\varphi: \mathcal{E} \rightarrow \mathcal{E}$, then we define $\varphi_{n}: M_{n}(\mathcal{E}) \rightarrow M_{n}(\mathcal{E})$ by sending $\left(x_{i j}\right)$ to $\left(\varphi\left(x_{i j}\right)\right)$.
Definition A.2. Let $\mathcal{E}$ be an operator system, $\varphi: \mathcal{E} \rightarrow \mathcal{E}$ be a linear map, and $\varphi_{n}$ be the induced map $\varphi_{n}: M_{n}(\mathcal{E}) \rightarrow M_{n}(\mathcal{E})$.

1. The map $\varphi$ is called completely bounded if $\sup _{n>0}\left\|\varphi_{n}\right\|<\infty$, and we set

$$
\|\varphi\|_{c b}=\sup _{n>0}\left\|\varphi_{n}\right\| .
$$

2. The map $\varphi$ is called $n$-positive if $\varphi_{n}$ is positive, and $\varphi$ is called completely positive if $\varphi_{n}$ is $n$-positive for all $n>0$.
If a completely positive map $\varphi$ preserves the unit, i.e., $\varphi(\mathrm{Id})=\mathrm{Id}$, then $\varphi$ is called a UCP $\operatorname{map}(u n i t a l$ completely positive), and we denote the collection of all UCP maps over $\mathcal{E}$ by $\operatorname{UCP}(\mathcal{E})$.
Theorem A. 3 (Arveson's extension theorem). Let $\mathcal{A}$ be a $C^{*}$-algebra, $\mathcal{E}$ an operator system contained in $\mathcal{A}$, and $\varphi: \mathcal{E} \rightarrow B(\mathcal{H})$ a completely positive map. Then there exists a completely positive map, $\psi: \mathcal{A} \rightarrow B(\mathcal{H})$, extending $\varphi$.

According to Arveson's extension theorem we can always extend a map $\varphi \in \operatorname{UCP}(\mathcal{E})$ to a map $\psi \in \operatorname{UCP}(B(\mathcal{H}))$. In addition, if $\psi$ is normal, according to Kraus, we can obtain a more explicit description of $\psi$.
Definition A.4. We say a map $\psi: B(\mathcal{H}) \rightarrow B(\mathcal{H})$ is normal if $\psi$ is ultraweakly continuous. Equivalently, for any trace class operator $T \in B_{1}(\mathcal{H})$, take a sequence or more generally a net $\left\{x_{i}\right\}_{i \in I} \subset B(\mathcal{H})$ and an $x \in B(\mathcal{H})$, if $\operatorname{Tr}\left(T x_{i}\right) \rightarrow \operatorname{Tr}(T x)$ then we have $\operatorname{Tr}\left(T \psi\left(x_{i}\right)\right) \rightarrow$ $\operatorname{Tr}(T \psi(x))$.
Theorem A. 5 ([9, Theorem 3.3]). Any linear mapping $T$ of $B(\mathcal{H})$ into itself with $\|T B\| \leq\|B\|$, which is completely positive and ultraweakly continuous, is of the form

$$
T B=\sum_{k \in K} A_{k}^{*} B A_{k} \quad \text { with } \quad \sum_{k \in K} A_{k}^{*} A_{k} \leq 1
$$

Theorem A. 6 ([9, Theorem 4.1]). Any completely positive ultraweakly continuous linear mapping $T$ of a von Neumann algebra $\mathfrak{U}$ into itself with $\|T B\| \leq\|B\|$ is of the form

$$
T B=\sum_{k \in K} A_{k}^{*} B A_{k} \quad \text { with } \quad \sum_{k \in K} A_{k}^{*} A_{k} \leq 1
$$

Remark A.7. In Theorems A. 5 and A. 6 above, the sum is in the sense of ultraweakly convergence for infinite $K$.

## B Haagerup tensor product

In this appendix, we review some fundamental results about Haagerup tensor product of operator systems; we refer to $[6,11,12]$ for more details.

Let $\mathcal{H}$ be a Hilbert space, $B(\mathcal{H})$ the set of bounded operators over $\mathcal{H}$, and let $\mathcal{E}, \mathcal{F} \subset B(\mathcal{H})$ be two operator systems. We denote by $\mathcal{E} \otimes \mathcal{F}$ the space of algebraic tensor product, i.e.,

$$
\mathcal{E} \otimes \mathcal{F}=\left\{\sum_{i=1}^{k} a_{i} \otimes b_{i} \mid a_{i} \in \mathcal{E}, b_{i} \in \mathcal{F}, k \in \mathbb{N}\right\} .
$$

We define the Haagerup tensor norm $\|x\|_{h}$ of $x \in \mathcal{E} \otimes \mathcal{F}$ as

$$
\|x\|_{h}:=\inf \left\{\left\|\sum a_{i} a_{i}^{*}\right\|^{1 / 2}\left\|\sum b_{i}^{*} b_{i}\right\|^{1 / 2}\right\},
$$

here the infimum runs over all the expressions of $x=\sum a_{i} \otimes b_{i}$.
Definition B.1. We denote by $\mathcal{E} \otimes_{h} \mathcal{F}$ the completion of $\mathcal{E} \otimes \mathcal{F}$ with respect to the Haagerup tensor norm $\|\cdot\|_{h}$.

Theorem B. 2 ([11, Theorem 17.4]). Let $\mathcal{E} \subset \mathcal{E}_{1}$ and $\mathcal{F} \subset \mathcal{F}_{1}$ be operator systems. Then the inclusion of $\mathcal{E} \otimes_{h} \mathcal{F}$ into $\mathcal{E}_{1} \otimes_{h} \mathcal{F}_{1}$ is a complete isometry.

Theorem B. 3 ([12, Theorem 5.12]). Let $\mathcal{A} \subset B(\mathcal{H})$ and $\mathcal{B} \subset B(\mathcal{K})$ be $C^{*}$-algebras. We have a natural completely isometric embedding

$$
J: \mathcal{A} \otimes_{h} \mathcal{B} \rightarrow \mathrm{CB}(B(\mathcal{K}, \mathcal{H}))
$$

defined by
$J(a \otimes b): T \rightarrow a T b$,
here $\mathrm{CB}(B(\mathcal{K}, \mathcal{H}))$ denotes the collection of all the completely bounded maps over $B(\mathcal{K}, \mathcal{H})$.
According to [5] the Haagerup tensor norm is a $C^{*}$-cross norm:
Theorem B. 4 ([5, Corollary 2.2]). Suppose $A$ and $B$ are $C^{*}$-algebras. For any $a \in A, b \in B$, $\|a \otimes b\|_{h}=\|a\|\|b\|$.
