# Bosonic $\eta$-deformations of Non-integrable Backgrounds

AbSTRACT: We consider the non-integrable bosonic backgrounds $W_{2,4} \times T^{1,1}$ and $A d S_{5} \times$ $T^{1,1}$ and derive their bosonic $\eta$-deformed versions using an $r$-matrix that solves the modified Yang-Baxter equation obtaining new integrable deformed backgrounds.

## 1 Introduction

The dynamics of a field-theoretical system takes the form of differential equations so it is natural to ask under which conditions they can be completely solved. Formally, if this happens, the system is called integrable. In its Hamiltonian description integrability is ensured by showing the existence of an infinite number of conserved charges which are in involution or, equivalently, by writing its Lax connection. The required involution of these conserved charges leads to a particular form of the Poisson bracket of the Lax connection in terms of a $r$-matrix [1-3]. It turns out that this construction is particularly useful when discussing integrability in string theory which was originally applied to the $A d S_{5} \times S^{5}$ superstring treated as a sigma model on the supercoset $\frac{\mathfrak{p s u}(2,2 \mid 4)}{\mathfrak{s o}(1,4) \oplus \mathfrak{s o}(5)}[4,5]$.

Since integrability is not an ordinary property the exploration of the whole plethora of integrable models is a daunting task. As a consequence, techniques to deform integrable theories while keeping its integrability have been developed. The first evidence of integrable deformations was found for the $S U(2)$ principal chiral model [6] and was then generalized for any compact Lie group [7] being now known as Yang-Baxter (YB) sigma models. This construction, which is based on a solution of the modified classical Yang-Baxter equation (mCYBE), can be extended to symmetric coset spaces [8] and to semi-symmetric coset spaces, as is the case of superstrings in $A d S_{5} \times S^{5}$ [9, 10] leading to the so called $\eta$ deformed $A d S_{5} \times S^{5}$ background [11, 12]. Recently, this kind of deformation was applied to the sigma model on the supercoset $\frac{\mathfrak{u o s p}(2,2 \mid 6)}{\mathfrak{s o ( 1 , 3 ) \oplus \mathfrak { u } ( 3 )} \text { which partially describes superstrings in }}$ $A d S_{4} \times \mathbb{C P}^{3}[13]$. Besides that, some instances of integrable deformations of the $A d S_{5} \times S^{5}$ and $A d S_{4} \times \mathbb{C P}^{3}$ backgrounds were also given based on solutions of the classical Yang-Baxter equation (CYBE) in [14-18].

More recently it was explored the possibility of starting with non integrable backgrounds and then finding a YB deformation in such a way that the new deformed backgrounds are integrable. That would give us a powerfull tool to generate integrable models
from non-integrable ones. First results in this direction were given for the $\operatorname{AdS} S_{5} \times T^{1,1}$ [19, 20] and $W_{2,4} \times T^{1,1}$ [21] cases. In particular, it was found that $W_{2,4} \times T^{1,1}$ gave rise to a somewhat exotic background that is part of a NSNS string background containing a nonvanishing $B$-field [22,23]. More recently, $T^{1,1}$ type spaces were studied in the context of new integrable Gaudin models, which can also be used to construct the $W_{2,4}$ spaces, leading to a nonvanishing $B$-field [24]. However, integrability is lost since $W_{2,4}$ can be realized as the double Wick rotation of $T^{1,1}$ which exhibits a chaotic behaviour [25]. In this paper we will consider the $W_{2,4} \times T^{1,1}$ and $A d S_{5} \times T^{1,1}$ backgrounds in a first attempt to construct $\eta$-deformations of non integrable spaces in their bosonic sector.

The $\eta$-deformed $\sigma$-model on $\mathfrak{g}$ is given by the action [9] ${ }^{1}$

where $A=-g^{-1} d g \in \mathfrak{g}, g \in G, \gamma^{\alpha \beta}$ is the string worldsheet metric with $\operatorname{det} \gamma=1$, and $\kappa^{2}=1$. The $\mathbb{Z}_{4}$-grading of $\mathfrak{g}$ allows us to split $A$ as

The operator $d$ is defined as the following composition of projectors $P_{i}(i=1,2,3)$ on the subalgebras of $\mathfrak{g} i$

The absence of $P_{0}$ is required in order to (1.1) be $\mathfrak{g}^{(0)}$-invariant. The deformed current is

where the operator $R_{g}$ is given by

The operator $R$ is related to the $r$-matrix required for integrability so that the Yang-Baxter equation (YBE) can be written as

where $M, N \in \mathfrak{g}$. In (1.1) and (1.6) the parameter $c$ refers to either the CYBE equation or to the mCYBE. The $c=1$ case, known as the non-split case [26], has the $R$ operator [11]

[^0]This paper is organized as follows. In section 2 we review the $W_{2,4} \times T^{1,1}$ space and its coset construction as in [21]. In section 3 we reduce the theory to its bosonic degrees of freedom and apply the $\eta$-deformation discussed above to the bosonic sector of the $W_{2,4} \times T^{1,1}$ background. In section 4 and section 5 we review the coset construction and apply the $\eta$ deformation to the bosonic sector of $\operatorname{AdS} S_{5} \times T^{1,1}$. In section 6 we conclude and discuss our results.

## 2 Coset Construction of the Bosonic $W_{2,4} \times T^{1,1}$ Background

The $W_{2,4}$ space is the noncompact version of the Stiefel space $V_{2,4}$ [27]. It is defined by the coset $S O(2,2) / S O(2)$ or equivalently $(S L(2, \mathbb{R}) \times S L(2, \mathbb{R})) / S O(2)$. The $T^{1,1}$ space can be understood as the intersection of a cone and a sphere in $\mathbb{C}^{4}$ such that its topology is $S^{2} \times S^{3}$ and its metric is a $U(1)$ bundle over $S^{2} \times S^{2}$.

The isometry group of $W_{2,4} \times T^{1,1}$ is the coset [21]

W_{2,4} \times T^{1,1} \equiv \frac{S L(2, \mathbb{R})_{a} \times S L(2, \mathbb{R})_{b} \times S O(2)_{r}}{U(1)_{a} \times U(1)_{b}} \times \frac{S U(2)_{A} \times S U(2)_{B} \times U(1)_{R}}{U(1)_{A} \times U(1)_{B}} . \tag{2.1}

Due to the fact that $W_{2,4}$ is a non-symmetric coset [21] and can be realized as the double Wick rotation of the $T^{1,1}$, integrability of (2.1) can not be ensured. Besides that, since a chaotic behaviour was found in $T^{1,1}$ [25] we could also expect it in $W_{2,4}$ so that the $\sigma$ model on (2.1) would be non integrable. Notice that this coset has extra factors of $S O(2)_{r} \times U(1)_{R}$ in the numerator and two $U(1)$ 's in the denominator in order to take into account all isometries of the space [19, 20]

The Lie algebra that generates this space can then be written as

Taking a superalgebra that would include $\mathfrak{g}_{\mathrm{b}}$, its elements can be written as a supermatrix as
where the dashed lines divide the supermatrix into blocks corresponding to the subspaces $W_{2,4}$ and $T^{1,1} . Q$ and $\bar{Q}$ belong to $\mathfrak{g}_{\mathrm{f}}=\mathfrak{g}^{(1)} \oplus \mathfrak{g}^{(3)}$ and correspond to the generators of the fermionic sector which will not be considered here.

We will use the same basis as in [21] to parametrize $\mathfrak{s l}(2, \mathbb{R})^{2} \oplus \mathfrak{s o}(2)$
where $\mu=0,1,2$, while for $\mathfrak{s u}(2)^{2} \oplus \mathfrak{u}(1)$ we take
where $i=1,2,3$. Here,

where $\sigma_{i}, i=1,2,3$, are the standard Pauli matrices. The nonvanishing commutation rules are then

where $\mathbf{L}_{ \pm}^{(m)}=\mathbf{L}_{2}^{(m)} \pm \mathbf{L}_{0}^{(m)}$. Notice that these commutation relations are those of two $\mathfrak{s l}(2, \mathbb{R})$ and two $\mathfrak{s u}(2)$ for $m, n=1,2$. We also have

where $\eta_{\mu \nu}=\operatorname{diag}(-1,+1,+1)$. To parametrize (2.1) we follow [21] and define the basis

where $m=1,2$ and $a=0, \ldots, 9$, and

The four generators of $\mathfrak{u}(1)^{4}$ are

The undeformed metric of $W_{2,4} \times T^{1,1}$ can be obtained by choosing the following coset representatives for each subspace

g_{W_{2,4}} & =\exp \left(\varphi_{1} \mathbf{L}_{0}^{(1)}+\varphi_{2} \mathbf{L}_{0}^{(2)}+2 \xi \mathbf{N}\right) \exp \left(\left(y_{1}-i \pi\right) \mathbf{L}_{1}^{(1)}+y_{2} \mathbf{L}_{1}^{(2)}\right),  \tag{2.13}\\
g_{T^{1,1}} & =\exp \left(\phi_{1} \mathbf{F}_{3}^{(1)}+\phi_{2} \mathbf{F}_{3}^{(2)}+2 \psi \mathbf{M}\right) \exp \left(\left(\theta_{1}+\pi\right) \mathbf{F}_{2}^{(1)}+\theta_{2} \mathbf{F}_{2}^{(2)}\right),

which will lead us to a suitable form for the background. The Maurer-Cartan one form $A=g^{-1} d g$, where $g=g_{W_{2,4}} g_{T^{1,1}}$, allows us to get the metric from

To do that we take the projector $P_{2}$ on the coset to be

where $\mathbf{K}_{a}$ and $\mathbf{T}_{\alpha}$ were defined in (2.9) and (2.12), respectively. We then obtain the following expressions for the undeformed metric on $W_{2,4} \times T^{1,1}$
$d s_{W_{2,4}}^{2}=\frac{1}{6}\left(d y_{1}^{2}+\sinh ^{2} y_{1}^{2} d \varphi_{1}^{2}\right)+\frac{1}{6}\left(d y_{2}^{2}+\sinh ^{2} y_{2}^{2} d \varphi_{2}^{2}\right)-\frac{1}{9}\left(\cosh y_{1} d \varphi_{1}+\cosh y_{2} d \varphi_{2}+d \xi\right)^{2}$,
where $y_{1}, y_{2} \in[0, \infty), \varphi_{1}, \varphi_{2} \in[0,2 \pi)$, and $\chi \in[0,4 \pi)$, and also

d s_{T^{1,1}}^{2}=\frac{1}{6}\left(d \theta_{1}^{2}+\sin ^{2} \theta_{1} d \phi_{1}^{2}\right)+\frac{1}{6}\left(d \theta_{2}^{2}+\sin ^{2} \theta_{2} d \phi_{2}^{2}\right)+\frac{1}{9}\left(\cos \theta_{1} d \phi_{1}+\cos \theta_{2} d \phi_{2}+d \psi\right)^{2} \tag{2.17}

where $\theta_{1}, \theta_{2} \in[0, \pi], \phi_{1}, \phi_{2} \in[0,2 \pi)$ and $\psi \in[0,4 \pi)$. Notice the similarity between the subspaces. This happens because $W_{2,4}$ can be seen as a $U(1)$-fibration over the product of two Euclidean $A d S_{2}$ spaces $E A d S_{2} \times E A d S_{2}$, while $T^{1,1}$ can be understood as an $U(1)$-fiber over $S^{2} \times S^{2}$.

## 3 Bosonic $\eta$-deformed $W_{2,4} \times T^{1,1}$

By switching off the fermionic degrees of freedom the deformed action (1.1) reduces to

The action of $P_{2}$ on $A, R_{g}\left(\mathbf{K}_{m}\right)$ and $J$ are

where $\mathbf{K}_{m}$ are the generators of $\mathfrak{g}^{(2)}$ and the coefficients $j^{m}$ can be obtained from

The coefficients $C_{n}{ }^{m}$ and $\Lambda_{m}{ }^{n}$ can be written in matrix form as

Then, usign (3.1) we can read off the metric and the B-field as

Thus, in order to compute the deformed background with Lagrangian (3.1) we need first to compute the the non-zero components $\Lambda_{m}{ }^{n}$ in (3.2) and then follow the same procedure as in $[18,20]$. We find that

This allows to write the $\eta$-deformed background, where the $W_{2,4}$ deformed is

while the deformed metric of $T^{1,1}$ is

and

with $\mathcal{F}_{1}^{-1}=\mathcal{F}_{2}^{-1}=1$ when $\chi=0$. Notice that when we set $\chi=0$ the deformed metrics (3.8) and (3.9) reduce to the undeformed ones.

The deformed NSNS $B$-field is then given by

which vanishes when we set $\chi=0$.

## 4 Coset Construction of the Bosonic $A d S_{5} \times T^{1,1}$ Background

We can now consider $\operatorname{AdS} S_{5} \times T^{1,1}$ as a second example of non-integrable background [25]. It was used in [19] and recently in [20] to build Yang-Baxter deformations based on solutions of the CYBE. This background corresponds to the near horizon limit of $N D 3$-branes on the singularity of $\mathcal{M}_{1,4} \times Y_{6}$ where $\mathcal{M}_{1,4}$ is the four-dimensional Minkowski space and $Y_{6}$ a Ricci flat Calabi-Yau cone $C\left(X_{5}\right)$ with base $X_{5}$ [28]. In the limit the geometry becomes $A d S_{5} \times X_{5}$, where $X_{5}$ is a compact Sasaki-Einstein manifold which, in particular, can be taken to be $T^{1,1}$ conifold.

In this case the isometry group is the extended coset [19, 20]

which leads to the following extended coset algebra:
$\mathfrak{s o}(2,4) \oplus \mathfrak{s u}(2) \oplus \mathfrak{s u}(2) \oplus \mathfrak{u}(1)=\overbrace{(\mathfrak{s o}(1,4) \oplus \mathfrak{u}(1) \oplus \mathfrak{u}(1))}^{\mathfrak{g}^{(0)}} \oplus \overbrace{\left(\frac{\mathfrak{s o}(2,4) \oplus \mathfrak{s u}(2) \oplus \mathfrak{s u}(2) \oplus \mathfrak{u}(1)_{R}}{\mathfrak{s o}(1,4) \oplus \mathfrak{u}(1) \oplus \mathfrak{u}(1)}\right)}^{\mathfrak{g}^{(2)}=\mathfrak{g} / \mathfrak{g}^{(0)}}$.

We can consider a slightly different supermatrix structure
where the dashed lines split the algebras corresponding to the subspaces $A d S_{5}$ and $T^{1,1}$, while the solid lines split the $M_{4 \times 4}$ and $M_{5 \times 5}$ bosonic blocks.

The basis of $\mathfrak{s u}(2)^{2} \oplus \mathfrak{u}(1)$ generators which parametrize $T^{1,1}$ is the following

where $i=1,2,3$ and $F_{i}$ are given in (2.6). On the other hand, we take the basis of $\mathfrak{s o}(2,4)$ in terms of $\gamma$-matrices in a similar way as done in [20],

where $\gamma_{\mu}, \gamma_{5}, m_{\mu \nu}=1 / 4\left[\gamma_{\mu}, \gamma_{\nu}\right]$ and $m_{\mu 5}=1 / 4\left[\gamma_{\mu}, \gamma_{5}\right]$ are the fifteen $4 \times 4$ matrices for the generators of isometries of $A d S_{5}$.

To parametrize (4.1) we set the basis

where

The undeformed metric $A d S_{5}$ can be obtained by choosing the following coset representative

g_{A d S_{5}}=\exp \frac{i}{2}\left(\psi_{1} \mathbf{H}_{1}+\psi_{2} \mathbf{H}_{2}+t \mathbf{H}_{3}\right) \exp \left(-\zeta \mathbf{M}_{1,3}\right) \exp \frac{1}{2}\left(-\sinh ^{-1} \rho \boldsymbol{\Gamma}_{1}\right), \tag{4.8}
\end{equation*}
$$

while the coset representative for $g_{T^{1,1}}$ is given in (2.13). Using the projector (2.15) we obtain the following expression for the undeformed $A d S_{5}$ metric

which agrees with that in [11, 12]. Finally, the undeformed $T^{1,1}$ is written as in (2.17).

## 5 Bosonic $\eta$-deformed $\operatorname{AdS}_{5} \times T^{1,1}$

In this section we obtain the $\eta$-deformation of $A d S_{5} \times T^{1,1}$ based on the $R$ operator (1.7). As in section 3, we switch off the fermionic degrees of freedom to work only with the bosonic sector. Firstly, we need to rewrite the components of the $\boldsymbol{\Lambda}$ matrix from (3.2), which in this case takes the form

which allow us to construct the matrix $\mathbf{C}$ in (3.4).
This also allow us to write the $\eta$-deformed background with the $A d S_{5}$ deformed space being

\frac{d s_{A d S_{5}}^{2}}{\left(1+\chi^{2}\right)}=-\frac{\left(1+\rho^{2}\right) d t^{2}}{1+\chi^{2} q_{1}^{2}}+\frac{d \rho^{2}}{\left(1+\rho^{2}\right)\left(1+\chi^{2} q_{1}^{2}\right)}+\rho^{2}\left(\frac{d \zeta^{2}+\cos ^{2} \zeta d \psi_{1}^{2}}{1+\chi^{2} q_{2}^{2}}+\sin ^{2} \zeta d \psi_{2}^{2}\right), \tag{5.2}
\end{equation*}
$$

agreeing with the $\eta$-deformed $A d S_{5}$ space obtained in [11, 12]. The $\eta$-deformed $T^{1,1}$ metric is

\left.+G\left(q_{4}^{2}+q_{5}^{2}+q_{6}^{2} \mid q_{4}^{2} q_{5}^{2}\right) \sin ^{2} \theta_{1} d \phi_{1}^{2}+G\left(q_{3}^{2}+q_{5}^{2}+q_{6}^{2} \mid q_{3}^{2} q_{6}^{2}\right) \sin ^{2} \theta_{2} d \phi_{2}^{2}\right)  \tag{5.3}\\
\left.\quad+\frac{1}{9} G\left(q_{3}^{2} \mid 0\right) G\left(q_{4}^{2} \mid 0\right)\left(\cos \theta_{1} d \phi_{1}+\cos \theta_{2} d \phi_{2}+d \psi\right)^{2}\right),
\end{gather*}

where

\mathcal{F}_{3}^{-1}=G\left(q_{3}^{2}+q_{4}^{2}+q_{5}^{2}+q_{6}^{2} \mid q_{3}^{2} q_{4}^{2}+q_{3}^{2} q_{6}^{2}+q_{4}^{2} q_{5}^{2}\right) . \tag{5.4}
\end{equation*}

where we have used the definition (3.11). Notice that this latter deformation is the same as in (3.9). Both (5.2) and (5.3) reduce to the undeformed spaces when $\chi=0$.

Due to the $\eta$-deformation a $B$-field is also present in each sector

$$

\frac{B_{A d S_{5}}}{\left(1+\chi^{2}\right)}=\frac{2 i \chi q_{1}^{2}}{3\left(1+\chi^{2} q_{1}\right)} d t \wedge d \rho-\frac{2 \chi q_{2} \rho \cos \zeta}{3\left(1+\chi^{2} q_{2}^{2}\right)} d \zeta \wedge d \psi_{1}, \tag{5.5}
\end{equation*}
$$

which is proportional to the $B$-field with $A d S_{5}$ coordinates in [11, 12], and

$$
\begin{align*}
\frac{B_{T^{1,1}}}{\left(1+\chi^{2}\right)}=- & -\frac{\chi \mathcal{F}_{3}}{9}\left(\left(\sqrt{6} q_{5} G\left(q_{4}^{2} \mid 0\right) \cos \theta_{1}+3 q_{3} G\left(q_{4}^{2}+q_{6}^{2} \mid 0\right) \sin \theta_{1}\right) d \theta_{1} \wedge d \phi_{1}\right. \\
& +q_{5}\left(\sqrt{6} G\left(q_{4}^{2} \mid 0\right) \cos \theta_{2}+3 q_{4} q_{6} \chi^{2} \sin \theta_{2}\right) d \theta_{1} \wedge d \phi_{2} \\
& +q_{6}\left(\sqrt{6} G\left(q_{5}^{2} \mid 0\right) \cos \theta_{1}-3 q_{3} q_{5} \chi^{2} \sin \theta_{1}\right) d \theta_{2} \wedge d \phi_{1}  \tag{5.6}\\
+ & \left(\sqrt{6} q_{6} G\left(q_{3}^{2} \mid 0\right) \cos \theta_{2}-3 q_{4} G\left(q_{3}^{2}+q_{5}^{2} \mid 0\right) \sin \theta_{2}\right) d \theta_{2} \wedge d \phi_{2} \\
& \left.+\sqrt{6} q_{5} G\left(q_{4}^{2} \mid 0\right) d \theta_{1} \wedge d \psi+\sqrt{6} q_{6} G\left(q_{3}^{2} \mid 0\right) d \theta_{2} \wedge d \psi\right) .
\end{align*}

The $B$-field in (5.6) has the same form as the one found previously (3.13). As expected, these $B$-fields vanish for $\chi=0$.

## 6 Conclusions

In this paper we have obtained new bosonic $\eta$-deformed $W_{2,4} \times T^{1,1}$ and $\operatorname{AdS} S_{5} \times T^{1,1}$ backgrounds based on a solution of the mCYBE providing new integrable backgrounds besides the one found in [21] for $W_{2,4} \times T^{1,1}$.

Recently new integrable models on $T^{1,1}$ manifolds with non-vanishing B-fields were found [24]. It was then shown that such B-fields are the only possible ones which avoid a chaotic behaviour of $T^{1,1}$ [29]. Since $W_{2,4}$ is closely related to $T^{1,1}$ by two Wick rotations we would expect that it gives rise to a $B$-field as in [24] and it would also be very interesting to look for integrable deformations of $W_{2,4} \times T^{1,1}$ along the lines of [24]. Besides that, it would also be interesting to analyse whether our deformed $W_{2,4} \times T^{1,1}$ and $A d S_{5} \times T^{1,1}$ backgrounds present chaotic behaviour.
