# WELL-POSEDNESS OF AN INTEGRO-DIFFERENTIAL MODEL FOR ACTIVE BROWNIAN PARTICLES*

#### Abstract

We propose a general strategy for solving nonlinear integro-differential evolution problems with periodic boundary conditions, where no direct maximum/minimum principle is available. This is motivated by the study of recent macroscopic models for active Brownian particles with repulsive interactions, consisting of advection-diffusion processes in the space of particle position and orientation. We focus on one of such models, namely a semilinear parabolic equation with a nonlinear active drift term, whereby the velocity depends on the particle orientation and angle-independent overall particle density (leading to a nonlocal term by integrating out the angular variable). The main idea of the existence analysis is to exploit a-priori estimates from (approximate) entropy dissipation. The global existence and uniqueness of weak solutions is shown using a two-step Galerkin approximation with appropriate cutoff in order to obtain nonnegativity, an upper bound on the overall density and preserve a-priori estimates. Our analysis naturally includes the case of finite systems, corresponding to the case of a finite number of directions. The Duhamel principle is then used to obtain additional regularity of the solution, namely continuity in time-space. Motivated by the class of initial data relevant for the application, which includes perfectly aligned particles (same orientation), we extend the well-posedness result to very weak solutions allowing distributional initial data with low regularity.


Key words. active particles, space-periodic problems, parabolic equations, Galerkin approximation, periodic heat kernel

1. Introduction. In this paper, we present a well-posedness theory (existence, uniqueness, and regularity) for an integro-differential equation describing a system of interacting active Brownian particles. Active Brownian particles are a model system for self-propelled particles, and have wide-ranging applications such as molecular motors, bacteria, animal swarms and pedestrian flows (cf. e.g. [5, 8, 12, 13]). Denote by $\mathbf{X}_{i} \in \Omega \subset \mathbb{R}^{2}$ and $\Theta_{i} \in \mathbb{T}:=\mathbb{R} /(2 \pi \mathbb{Z})$ the position and orientation of particle number $i$, respectively. The evolution of the system with $N$ indistinguishable particles is given by the following stochastic differential equations:

where $D_{T}$ and $D_{R}$ are the translational and rotational diffusion coefficients, respectively, $\mathbf{W}_{i}$ and $W_{i}$ are $N$ independent Brownian motions in $\mathbb{R}^{2}$ and $\mathbb{R}$ respectively, $v_{0}$ is the self-propulsion speed, $\mathbf{e}(\theta)=(\cos \theta, \sin \theta)$, and $u$ is the pairwise interaction potential, assumed to be radially symmetric, purely repulsive and short-ranged $(\varepsilon \ll 1)$. In contrast to passive Brownian particles (that is $D_{R}=0$ in (1.1b)), active Brownian particles perform a biased Brownian walk in the direction given by their orientation.

Starting from (1.1) and considering the associated Fokker-Planck equation for the joint probability density in $(\Omega \times \mathbb{T})^{N}$, one can derive the BBGKY hierarchy of coupled equations for the marginal probabilities. Depending on the assumptions on the interaction $u$, one can obtain different continuum models for the one-particle marginal density [4]. One of such models is studied by Speck et al. [16], where they obtain a closed equation by assuming that the system is homogeneous and neglecting the time-dependence of the pair correlation function. Following a rescaling of time and space, leading to a rescaled velocity or Péclet number $\mathrm{Pe}=v_{0} / \sqrt{D_{R} D_{T}} \geq 0$, the resulting equation is (see [4] for details)

where $D_{e} \in(0,1]$ is an effective translational diffusion, the unknown $f=f(t, \mathbf{x}, \theta)$ is the phase space density and $\rho=\rho(t, \mathbf{x})$ is the spatial density obtained through

Both densities are scaled such that they have mass $\phi \in[0,1)$; this represents the effective occupied fraction of particles in $\Omega$. By integrating (1.2) with respect to $\theta$, we obtain the following equation for $\rho$

where $\mathbf{p}(t, \mathbf{x})$ is the polarisation, defined by $\mathbf{p}(t, \mathbf{x})=\int_{0}^{2 \pi} \mathbf{e}(\theta) f(t, \mathbf{x}, \theta) \mathrm{d} \theta$. As we shall see later on, the equation for $\rho,(1.3)$, plays an important role in the analysis of (1.2) in order to determine the sign of the nonlocality (in angle) $1-\rho$, which is the reason why usual maximum/minimum principle does not work in our case. It is also interesting to consider (1.2) in one spatial dimension, $\Omega \subset \mathbb{R}$. In this case, the set of possible orientations reduces to $\theta=0, \pi$, or right- and left-moving particles, and the rotational diffusion reduces to discrete jumps between these two orientations. The one-dimensional version of (1.2) reads

where $f_{R}$ and $f_{L}$ are the densities of right- and left-moving particles, respectively, and the space density is $\rho=f_{R}+f_{L}$. This model is derived in [4] from the onedimensional version of (1.1), and in [14] as the hydrodynamic limit of an active lattice gas. In fact, the two-dimensional model (1.2) can also be derived starting from an active lattice gas model, with a partial exclusion rule (only one particle is allowed by site, but particles can exchange sites in the diffusive step). This explains why models (1.2) and (1.4) present linear diffusion. If instead one considers a complete exclusion rule (resulting in an asymmetric simple exclusion process), nonlinearities of cross-diffusion type (involving terms $\rho \nabla f, f \nabla \rho$ ) appear in the continuum model [4].

Equation (1.4) coincides with the crowded version (with the additional $1-\rho$ term in the advection) of the Goldstein-Taylor model [11, 17], and for this reason we refer to it as the crowded Goldstein-Taylor model. We shall see that well-posedness for the above system follows directly from that of (1.2), as consequence of our strategy based on a two-step approximation.

To the best of our knowledge, most of the results in literature focus on timeperiodic evolution equations or initial-value problems with Neumann or zero-flux boundary conditions, cf. e.g. [15], while periodicity in space has not been studied in detail. Moreover, the mobility $f(1-\rho)$ in the drift term does not yield a maximum principle due to the nonlocal dependence of $\rho$ on $f$. In particular, it is not immediately clear whether one can use the theory of Ladyzhenskaya and collaborators [15], or that established by Amann [1], based on fixed point theorems. Moreover, we note that the equation does not present a usual Wasserstein gradient flow structure, even in the absence of angular diffusion, again because of the mobility $f(1-\rho)$ in the transport drift term, cf. for instance, [3]. In this regard, we also point out that this problem does not fall in the theory of generalised Wasserstein gradient flows for equations with nonlinear mobility studied for instance in $[9,7]$ and the references therein, as the mobility in (1.2) is nonlocal in addition to being, effectively, nonlinear.

For these reasons, we provide a valuable strategy to tackle space-periodic nonlinear evolution PDEs with a nonlocal in angle drift term and periodic boundary conditions by means of a double space-discretisation purely using periodicity. More precisely, in order to prove the existence and uniqueness of solutions in the sense of Definition 2.2, we first consider a Galerkin approximation with respect to the angular variable $\theta$. We emphasise that, in the sequel, we make the choice to expand in terms of the sine and cosine basis instead of the complex exponentials; this is so that all coefficients are real-valued, which is required to make sense of the positive part in the parabolic system that we study; $c f$. (3.7) in section 3. Existence of solutions to such a system is proven by means of a further Galerkin approximation in the space variable, again taking into account periodicity of the problem in the choice of the basis.

In this paper we provide the first rigorous result on a macroscopic model for Brownian active particles in phase space, thus starting with the possibly simplest model without cross-diffusion effects. However, it still carries two characteristic issues of these problems, namely the nonlinear drift and the nonlocal effects due to the overall density $\rho$. Note that here we work in the setting of a continuous angular variable, with discrete angles or directions as in the one-dimensional version of the model we directly see the relation to nonlinear parabolic systems. We stress that this strategy may be extended to the analysis of a larger class of space-periodic evolution equations, even some cross-diffusion systems, see [4]. This will indeed be the object of further investigation. Let us mention at this point the importance of the space-periodic setting also for pattern formation effects. A closed system with no-flux boundary conditions might lead to very different stationary flux behaviour and may not lead to the phase separation phenomena observed in many microscopic simulations and discussed in [4].

This article is organised as follows. In section 2 we provide the general set of assumptions and the summary of the main results. Section 3 contains the proof of existence and uniqueness of weak solutions of (1.2) and (1.4). Here we provide a detailed explanation of the strategy used, which can be potentially adapted to a larger class of space-periodic nonlinear evolution problems. More precisely, well-posedness is proven via a two-step Galerkin discretisation. This involves solving a semilinear parabolic system outside what is covered by standard parabolic theory, not due to particular complications, but rather the periodic nature of the problem. In section 4
we obtain higher regularity of solutions by applying the Duhamel principle. Section 5 is devoted to enlarging the class of initial data, among them those presenting a Dirac delta in the angular variable. This is relevant to the application of active Brownian particles, as it corresponds to all particles being originally perfectly aligned (same orientation). Finally, the appendices collect some technical results used in the paper.
2. Preliminaries and main results. In what follows, we refer to (1.2) and (1.4) as 2D and 1D problems, respectively, in reference to the dimension of the spatial domain $\Omega$. Note that, mathematically, the two-dimensional problem (1.2) lives in the three-dimensional space $\Upsilon:=\Omega \times \mathbb{T}$. We choose the spatial domain $\Omega$ to be the $d$-dimensional torus $\mathbb{T}^{d}$, where $d \in\{1,2\}$ and $\mathbb{T}=\mathbb{R} /(2 \pi \mathbb{Z})$. This imposes periodic boundary conditions as considered in $[4,16]$. The $2 \pi$-period is chosen by mathematical convenience, so that in the two-dimensional problem $\Upsilon \equiv \mathbb{T}^{3}$. In the sequel, we say that a function $f$ is $\mathbb{T}^{M}$-periodic (for $M \in\{1,2,3\}$ ) if, for all $\boldsymbol{\xi} \in \mathbb{R}^{M}$ and all $j \in\{1, \ldots, M\}$, there holds $f(\boldsymbol{\xi})=f\left(\boldsymbol{\xi}+2 \pi \mathbf{e}_{j}\right)$, where $\left\{\mathbf{e}_{j}\right\}_{j=1}^{M}$ are the standard unit vectors of $\mathbb{R}^{M}$.

Definition 2.1 (Function spaces). Let $M \in\{1,2,3\}$. We define the following Banach spaces

with $p \geq 1, m \in \mathbb{N} \cup\{0\}$ endowed with the norms $\|\cdot\|_{L^{p}\left((0,2 \pi)^{M}\right)}$ and $\|\cdot\|_{H^{m}\left((0,2 \pi)^{M}\right)}$, respectively. The topological dual of $H_{p e r}^{m}\left(\mathbb{T}^{M}\right)$ is denoted by $\left(H_{p e r}^{m}\right)^{\prime}\left(\mathbb{T}^{M}\right)$. Similarly, we define the spaces

for $k \in \mathbb{N} \cup\{0\} \cup\{\infty\}$, equipped with their respective norm $\|\cdot\|_{C^{k}\left([0,2 \pi]^{M}\right)}$.
For every $f, g: \Upsilon \rightarrow \mathbb{R}$, we use the notation $\langle\cdot, \cdot\rangle_{\Upsilon}$ to denote both the $L^{2}$ scalar product in $\Upsilon$ and duality between $\left(H^{1}\right)^{\prime}$ and $H^{1}$ as a Gelfand triple with $L^{2}$, while for any $a, b: \Omega \rightarrow \mathbb{R}$ all such pairings (in $L^{2}$ and $H^{1}$ ) are denoted by $\langle a, b\rangle_{\Omega}$. Moreover, let us specify that, by slight abuse of notation, any curve $f:[0, T] \rightarrow B$ will map $t \in[0, T] \mapsto f(t, \cdot):=f(t) \in B$, for any Banach space $B$ we consider.

Definition 2.2 (Weak solution to 2D model). Let $f_{0} \in L_{\text {per }}^{2}(\Upsilon)$ be such that

A curve $f$ is a weak solution to (1.2) if $f \in C\left([0, T] ; L_{\text {per }}^{2}(\Upsilon)\right) \cap L^{2}\left([0, T] ; H_{\text {per }}^{1}(\Upsilon)\right)$, $f^{\prime} \in L^{2}\left([0, T] ;\left(H_{\text {per }}^{1}\right)^{\prime}(\Upsilon)\right)$, and for a.e. $t \in[0, T]$ and any $\varphi \in H_{\text {per }}^{1}(\Upsilon)$, there holds

with periodic boundary conditions on $\Upsilon$, where $\rho(t, \mathbf{x})=\int_{0}^{2 \pi} f(t, \mathbf{x}, \theta) \mathrm{d} \theta$, and the initial data is achieved in the sense $f(0)=f_{0}$ in $L_{\text {per }}^{2}(\Upsilon)$.

Our first main result is the following.

Theorem 2.3 (Existence and uniqueness for the 2 D model). Let $T>0$ and $f_{0} \in$ $L_{\text {per }}^{2}(\Upsilon)$ be nonnegative and such that $\rho_{0}(\mathbf{x})=\int_{0}^{2 \pi} f_{0}(\mathbf{x}, \theta) \mathrm{d} \theta \in[0,1]$ for a.e. $\mathbf{x} \in \Omega$. Then, there exists a unique weak solution to (2.2) in the sense of Definition 2.2.

Remark 2.4. In the proof of Theorem 2.3 we prove that $f \in L^{\infty}\left([0, T] ; L_{\text {per }}^{2}(\Upsilon)\right) \cap$ $L^{2}\left([0, T] ; H_{\text {per }}^{1}(\Upsilon)\right)$. Then, $f \in C\left([0, T] ; L_{\text {per }}^{2}(\Omega)\right)$ is deduced from [18, Ch. 3 Sec. 1.4 Lem. 1.2], since $f \in L^{2}\left([0, T] ; H_{p e r}^{1}(\Upsilon)\right)$ and $f^{\prime} \in L^{2}\left([0, T] ;\left(H_{p e r}^{1}\right)^{\prime}(\Upsilon)\right)$.

An analogous theorem is obtained for the 1D model (1.4), see Theorem 3.4 in subsection 3.5. We then consider the regularity of weak solutions. More precisely, we provide the following regularity result up to the initial time.

THEOREM 2.5 (Regularity for the 2D model). Let $f_{0} \in L^{\infty}(\Upsilon)$. Then the unique weak solution of (2.2) provided by Theorem 2.3 satisfies $f \in C((0, T] \times \bar{\Upsilon})$. Furthermore, if $f_{0} \in C(\bar{\Upsilon})$, the unique weak solution to (2.2) belongs to $C([0, T] \times \bar{\Upsilon})$.

The previous statement also holds true for the 1D model (1.4), see subsection 4.1.
Finally, we extend the concept of solution in order to allow for initial data with a fixed orientation (see Definition 5.1). Note that initial data of this form are of significantly lower regularity than considered in the original Theorem 2.3; indeed, they are distributional in the angle variable, and hence $\rho_{0}$ must be defined by duality. Our existence result for initial data of this kind entails defining very weak solutions, and we refer the reader to section 5 for further details; for clarity of presentation, we do not include the definition of very weak solutions here. The main result proved therein is as follows.

Theorem 2.6 (Existence of very weak solutions for 2D model). Let $T>0, f_{0}$ be a nonnegative element of $L_{\text {per }}^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)$ and $\rho_{0}(\mathbf{x}):=\left\langle f_{0}(\mathbf{x}, \cdot), 1\right\rangle \in[0,1]$ for a.e. $\mathbf{x} \in \Omega$. Then there exists a very weak solution of (1.2) in the sense of Definition 5.1, $f \in L^{2}\left([0, T] ; H_{\text {per }}^{1}\left(\Omega ;\left(H_{\text {per }}^{1}\right)^{\prime}(0,2 \pi)\right)\right) \cap L^{\infty}\left([0, T] ; L^{2}\left(\Omega ;\left(H_{\text {per }}^{1}\right)^{\prime}(0,2 \pi)\right)\right) \cap$ $L^{2}((0, T) \times \Upsilon)$.

Note that the result of Theorem 2.6 implies an instantaneous smoothing phenomenon, since the initial data is distributional in the angle variable, while the solution $f$ belongs to $L^{2}((0, T) \times \Upsilon)$.
3. Well-posedness. In this section we consider the analysis of the 1 D and 2 D models. We tackle the 2D model first, and show in subsection 3.5 that the result for the 1 D model follows from that of the 2 D model.

A crucial ingredient for the well-posedness of (1.2) and (1.4) is that $\rho \in[0,1]$ for all times. Equation (1.3) for the density $\rho$ does not have an obvious maximum or minimum principle, since the drift term neither has a sign nor is zero. One can show that any solution to (1.3) (provided it exists) satisfies $\rho \leq 1$, starting with an initial datum $\rho_{0} \in[0,1]$. However, at this early stage of the analysis, the nonnegativity of the solution is a delicate issue. For this reason we consider a variant of (1.2), where we have $\left(1-(\rho)_{+}\right)_{+}$in the transport term. It will turn out that we are indeed solving the original equation, i.e. (1.2). This final step is shown in Step 5 of the Proof of Theorem 2.3; cf. subsection 3.3. The modified version of (1.2) we start with is

in $\Upsilon=\mathbb{T}^{3}$, where $(a)_{+}=\max \{a, 0\}$, for any $a \in \mathbb{R}$. Later we show that we recover the solution to the original equation (1.2) (see subsection 3.3). We remind the reader that
the nonlocality in the drift term means that there is no inherent maximum/minimum principle for (3.1). Our strategy for solving the equation is to construct an approximating sequence $\left(f^{n}\right)_{n \in \mathbb{N}}$ whose limit solves (3.1).
3.1. Approximated system in angle. We introduce the following Galerkin approximation in $\theta$. Given the periodic boundary conditions and the term $\mathbf{e}(\theta)$ in (3.1), it is convenient to consider the basis $\{1, \cos (k(\cdot)), \sin (k(\cdot))\}_{k \in \mathbb{N}}$ of $L_{\text {per }}^{2}([0,2 \pi))$. Since $f_{0}(\mathbf{x}, \cdot) \in L_{\text {per }}^{2}([0,2 \pi))$ for a.e. $\mathbf{x} \in \Omega$, we can write

where $a_{k}(0, \cdot), b_{k}(0, \cdot)$ are the Fourier coefficients of $f_{0}(\cdot, \theta)$. Note that the requirement $0 \leq \rho_{0}(\mathbf{x}) \leq 1$ (cf. Definition 2.2) implies that $0 \leq a_{0}(0, \mathbf{x}) \leq 1$ for a.e. $\mathbf{x} \in \Omega$.

For some fixed $n \in \mathbb{N}$, we consider the finite-dimensional space

for $l=2, \ldots, n-1$, with periodic boundary conditions on $\Omega$ and initial conditions $a_{k}^{n}(0, \mathbf{x}), b_{k}^{n}(0, \mathbf{x})$ given by the corresponding Fourier coefficients of $f_{0}$ in (3.2).

Provided that (3.7) can be solved, we obtain an explicit description of each $f^{n}$ in terms of its Galerkin coefficients $a_{k}^{n}, b_{k}^{n}$. In order to prove Theorem 2.3, we need to show the convergence (in a sense to be made precise) of the sequence $\left(f^{n}\right)_{n \in \mathbb{N}}$ towards some limit $f$, and we must show that $f$ solves (3.1) in the weak sense prescribed by Definition 2.2. As previously mentioned, we will see that we are indeed solving (1.2).
3.2. Existence of solutions to the semilinear parabolic system with spatially-periodic boundary conditions. In order to solve the semilinear parabolic system (3.7), we perform a further Galerkin approximation in space, with the aim of rewriting it as a system of ODEs. While the well-posedness for systems similar to (3.7) is considered by Ladyzhenskaya et al. [15] and Amann [2], it is not obvious how these results can be applied to space-periodic problems or to systems without a maximum principle (resp. $L^{\infty}$-bounds). This motivates our study. We define

Defining the vector of unknowns by $\Lambda^{n, m}(t)$ and its initial data by $\Lambda_{0}^{n, m}$ (which are given explicitly in Appendix A), we obtain an ODE of the following form:

Next, we show $\left\|a_{k}^{m^{\prime}}\right\|_{L^{2}\left([0, T] ;\left(H_{p e r}^{1}\right)^{\prime}(\Omega)\right)},\left\|b_{k}^{m^{\prime}}\right\|_{L^{2}\left([0, T] ;\left(H_{p e r}^{1}\right)^{\prime}(\Omega)\right)}$, for $0 \leq k \leq n$, are uniformly bounded in $m$.

Let us consider a test function $\psi \in H_{p e r}^{1}(\Omega)$ such that $\|\psi\|_{H^{1}(\Omega)} \leq 1$. Since $a_{0}^{m}$ is a weak solution to (3.7a) for $k=0$, we have for a.e. $t \in[0, T]$

Step 3 (convergence of the approximating solutions): For $0 \leq k \leq n$, the sequence $\left\{a_{k}^{m}, b_{k}^{m}\right\}_{m}$ is uniformly bounded in $m$ in $L^{\infty}\left([0, T] ; L_{p e r}^{2}(\Omega)\right) \cap L^{2}\left([0, T] ; H_{p e r}^{1}(\Omega)\right)$. The Banach-Alaoglu Theorem yields that there exist subsequences $\left\{a_{k}^{m_{l}}, b_{k}^{m_{l}}\right\}_{l}$ and curves $a_{k}, b_{k} \in L^{\infty}\left([0, T] ; L_{\text {per }}^{2}(\Omega)\right) \cap L^{2}\left([0, T] ; H_{p e r}^{1}(\Omega)\right)$, for $0 \leq k \leq n$, such that

The limits coincide since $H^{1} \subset L^{2} \equiv\left(L^{2}\right)^{\prime} \subset\left(H^{1}\right)^{\prime}$ and $\varphi \in L^{2}\left([0, T] ; L_{p e r}^{2}(\Omega)\right)$ is a common test function. Since $\left\|a_{0}^{m^{\prime}}\right\|,\left\|a_{k}^{m^{\prime}}\right\|,\left\|b_{k}^{m^{\prime}}\right\|$ are bounded independently of $m$, for $1 \leq k \leq n$, in $L^{2}\left([0, T] ;\left(H_{p e r}^{1}\right)^{\prime}(\Omega)\right)$, the Banach-Alaoglu Theorem implies

By testing against a smooth compactly supported test function defined on $(0, T)$ and using the weak convergence $a_{k}^{m_{l}} \rightharpoonup a_{k}, b_{k}^{m_{l}} \rightharpoonup b_{k}$ in $L^{2}\left([0, T] ; H_{p e r}^{1}(\Omega)\right)$, we get $g_{a_{k}}=a_{k}^{\prime}, g_{b_{k}}=b_{k}^{\prime}$. Applying the Aubin-Lions Lemma to the sequence $\left\{a_{0}^{m}\right\}_{m \in \mathbb{N}}$, due to the uniform bound of $\left\|a_{0, m}^{\prime}\right\|_{L^{2}\left([0, T] ;\left(H_{p e r}^{1}\right)^{\prime}(\Omega)\right)}$ from (3.19), $a_{0}^{m}$ strongly converges in $L^{2}\left([0, T] ; L_{p e r}^{2}(\Omega)\right)$.

The strong convergence of $a_{0}^{m},(3.20)$, and (3.21) allow us to pass to the limit in the weak form of system (3.7), thus to obtain existence of weak solutions. We stress that strong convergence for $a_{0}^{m}$ is needed in order to allow convergence through the positive part in the drift term. Indeed, the positive part function is continuous and it grows at most linearly, thus $\left(1-\left(a_{0}^{m}\right)_{+}\right)_{+} \rightarrow\left(1-\left(a_{0}\right)_{+}\right)_{+}$strongly in $L^{2}\left([0, T] ; L_{p e r}^{2}(\Omega)\right)$. As consequence of the lower semicontinuity of the norm we obtain the regularity (3.8) and the uniform estimates (3.9).
3.3. Consistency of the approximating scheme. We now proceed with the proof of Theorem 2.3. We split the proof into two parts: existence and uniqueness. The proof of existence consists of five distinct steps.

Proof of Theorem 2.3 - existence. First of all, let us remind the reader we consider the variant (3.1) of the original problem, with periodic boundary conditions on $\Upsilon$. We will see that we recover the solution to the original problem (1.2) in Step 5.

Step 1 (approximating solution): As previously outlined, for each $n \in \mathbb{N}$, we consider the approximation of (3.1) given by (3.5) where the functions $\left\{a_{k}^{n}, b_{k}^{n}\right\}_{k=0}^{n}$ are a solution the semilinear parabolic equations (3.7). Note that Theorem 3.1 provides existence for the coefficients $\left\{a_{k}^{n}, b_{k}^{n}\right\}_{k=0}^{n}$ satisfying (3.8) and (3.9). In the next step we will use that, for each $n \in \mathbb{N}$, there holds

& \left\|a_{0}^{n \prime}\right\|_{L^{2}\left([0, T] ;\left(H^{1}\right)^{\prime}(\Omega)\right)} \leq \bar{C}\left(\mathrm{Pe}, D_{e}, T, C_{0}\right) \tag{3.22c}

being $C_{0}=\sum_{k=0}^{\infty}\left(\left\|a_{k}(0, \cdot)\right\|_{L^{2}(\Omega)}^{2}+\left\|b_{k}(0, \cdot)\right\|_{L^{2}(\Omega)}^{2}\right)=\left\|f_{0}\right\|_{L^{2}(\Omega)}^{2}$ and $C$ a constant independent of $n$ (see Eqs. (3.16)-(3.17) in the proof of Theorem 3.1).

Step 2 (uniform estimates for the approximating solution): The uniform bound in $L^{\infty}\left([0, T] ; L_{p e r}^{2}(\Upsilon)\right)$ for the approximation $f^{n}$ of (3.5) follows directly from (3.22). Indeed, or any $t \in[0, T]$, there holds

Note that in the penultimate inequality we used $|\sin (k \theta)|,|\cos (k \theta)| \leq 1$ for any $k \in \mathbb{N}$, Fubini Theorem and the orthogonality conditions for the trigonometric functions. Similarly, we obtain a uniform bound for $f^{n}$ in $L^{2}\left([0, T] ; H_{p e r}^{1}(\Upsilon)\right)$. Indeed, $\int_{0}^{T}\left\|\nabla_{\xi} f^{n}(t)\right\|_{L^{2}(\Upsilon)}^{2} \mathrm{~d} t=\int_{0}^{T} \int_{\Upsilon}\left|\nabla_{\mathbf{x}} f^{n}(t, \mathbf{x}, \theta)\right|^{2} \mathrm{~d} \mathbf{x} \mathrm{~d} \theta \mathrm{~d} t+\int_{0}^{T} \int_{\Upsilon}\left|\partial_{\theta} f^{n}(t, \mathbf{x}, \theta)\right|^{2} \mathrm{~d} \mathbf{x} \mathrm{~d} \theta \mathrm{~d} t$, from which it follows that, with $\boldsymbol{\xi}=(\mathbf{x}, \theta)$,

where this final constant is independent of $n$.
Finally, we prove that $\left\|\left(f^{n}\right)^{\prime}\right\|_{L^{2}\left([0, T] ;\left(H_{p e r}^{1}\right)^{\prime}(\Upsilon)\right)}$ is uniformly bounded. This will be a crucial observation in order to pass to the limit in $n$ in the equation, by applying the Aubin-Lions Lemma. Let $\varphi \in H_{p e r}^{1}(\Upsilon)$ be a test function such that $\|\varphi\|_{H^{1}(\Upsilon)} \leq 1$. Since $f^{n}$ is a weak solution to (3.1), we obtain for a.e. $t \in[0, T]$

& +\operatorname{Pe}\left\|f^{n}(t)\right\|_{L^{2}(\Upsilon)}\|\nabla \varphi\|_{L^{2}(\Upsilon)} \\

Taking the supremum over all $\varphi \in H_{p e r}^{1}(\Upsilon)$ with $\|\varphi\|_{H^{1}(\Upsilon)} \leq 1,\left\|\partial_{t} f^{n}(t)\right\|_{\left(H_{p e r}^{1}\right)^{\prime}(\Upsilon)} \leq$ $C\left(\mathrm{Pe}, D_{e}\right)\left(\left\|f^{n}(t)\right\|_{L^{2}(\Upsilon)}+\left\|\nabla f^{n}(t)\right\|_{L^{2}(\Upsilon)}+\left\|\partial_{\theta} f^{n}(t)\right\|_{L^{2}(\Upsilon)}\right)$, whence

due to the uniform bound on $\left\|f^{n}\right\|_{L^{2}\left([0, T] ; H_{p e r}^{1}(\Upsilon)\right)}$. Therefore, we have the desired bound for $\left(f^{n}\right)^{\prime}$ in $L^{2}\left([0, T] ;\left(H_{p e r}^{1}\right)^{\prime}(\Upsilon)\right)$.

Step 3 (convergence of the approximation): Since the sequence $\left\{f^{n}\right\}_{n \in \mathbb{N}}$ of (3.5) is uniformly bounded in $L^{\infty}\left([0, T] ; L_{p e r}^{2}(\Upsilon)\right) \cap L^{2}\left([0, T] ; H_{p e r}^{1}(\Upsilon)\right)$ we infer from the

Banach-Alaoglu Theorem that there exist a subsequence $\left\{f^{n_{k}}\right\}_{k \in \mathbb{N}}$ and a curve $f \in$ $L^{\infty}\left([0, T] ; L_{\text {per }}^{2}(\Upsilon)\right) \cap L^{2}\left([0, T] ; H_{\text {per }}^{1}(\Upsilon)\right)$ such that

The limits coincide since $H^{1} \subset L^{2} \equiv\left(L^{2}\right)^{\prime} \subset\left(H^{1}\right)^{\prime}$ and any $\varphi \in L^{2}\left([0, T] ; L_{p e r}^{2}(\Upsilon)\right)$ is a common test function. The uniform boundedness of $\left\|\left(f^{n}\right)^{\prime}\right\|_{L^{2}\left([0, T] ;\left(H_{p e r}^{1}\right)^{\prime}(\Upsilon)\right)}$ and the Banach-Alaoglu Theorem also yields that

where we verify that this latter limit is indeed $f^{\prime}$ by testing against a smooth compactly supported test function defined on $(0, T)$ and using the weak convergence $f^{n_{k}} \rightharpoonup f$ in $L^{2}\left([0, T] ; H_{p e r}^{1}(\Upsilon)\right)$. Henceforth, we do not relabel further subsequences.

Additionally, the aforementioned boundedness of $\left\|\left(f^{n}\right)^{\prime}\right\|_{L^{2}\left([0, T] ;\left(H_{p e r}^{1}\right)^{\prime}(\Upsilon)\right)}$ yields, taking a further subsequence if necessary, by an application of the Aubin-Lions Lemma that $f^{n} \rightarrow f$ strongly in $L^{2}\left([0, T] ; L_{\text {per }}^{2}(\Upsilon)\right)$ as $n \rightarrow \infty$. We take a further subsequence such that, for a.e. $t \in[0, T], f^{n}(t) \rightarrow f(t)$ strongly in $L_{p e r}^{2}(\Upsilon)$ as $n \rightarrow \infty$. Moreover, by further applying the theorem of Banach-Alaoglu and the Aubin-Lions Lemma to the sequence of curves $\left\{a_{0}^{n}\right\}_{n \in \mathbb{N}}$, due to the uniform bounds from (3.22), we also know that $a_{0}^{n}$ strongly converges in $L^{2}\left([0, T] ; L_{\text {per }}^{2}(\Omega)\right)$. In other words, up to a subsequence, $\left\{\rho^{n}\right\}_{n \in \mathbb{N}}$ converges strongly in $L^{2}\left([0, T] ; L_{p e r}^{2}(\Omega)\right)$. Moreover, defining $\rho:=\int_{0}^{2 \pi} f \mathrm{~d} \theta$, where $f$ is the aforementioned strong limit in $L^{2}\left([0, T] ; L_{p e r}^{2}(\Omega)\right)$, we have, for the convergent subsequence in question,

where we applied Jensen's inequality, thus $\rho^{n} \rightarrow \rho$ strongly in $L^{2}\left([0, T] ; L_{p e r}^{2}(\Omega)\right)$.
This allows us to pass to the limit in the weak form of (3.1), thus to obtain that $f$ is a weak solution to the revised (3.1). We stress that strong convergence for $a_{0}^{n}$, i.e., $\left\{\rho^{n}\right\}_{n \in \mathbb{N}}$, is needed in order to allow convergence through the positive part in the drift term. Indeed, the positive part function is continuous and it grows at most linearly, thus $\left(1-\left(\rho^{n}\right)_{+}\right)_{+} \rightarrow\left(1-(\rho)_{+}\right)_{+}$strongly in $L^{2}\left([0, T] ; L_{p e r}^{2}(\Omega)\right)$. More precisely, for a function $\psi \in C^{1}([0, T])$ such that $\psi(0)=\psi(T)=0$, there holds (using, e.g., [10, App. E Th. 8]) $\int_{0}^{T}\left\langle\partial_{t} f^{n}(t), \varphi\right\rangle_{\Upsilon} \psi(t) \mathrm{d} t=-\int_{0}^{T}\left\langle f^{n}(t), \varphi\right\rangle_{\Upsilon} \psi^{\prime}(t) \mathrm{d} t$, and hence

Using (3.25)-(3.26), the aforementioned strong convergence $\left(1-\left(\rho^{n}\right)_{+}\right)_{+} \rightarrow\left(1-(\rho)_{+}\right)_{+}$ in $L^{2}\left(0, T ; L_{\text {per }}^{2}(\Omega)\right)$, we pass to the limit $n \rightarrow+\infty$ in the above and obtain, after another integration by parts in $t$,

Hence, since $\psi$ was arbitrary, $f \in L^{2}\left([0, T] ; H_{p e r}^{1}(\Upsilon)\right)$ with $f^{\prime} \in L^{2}\left([0, T] ;\left(H_{p e r}^{1}\right)^{\prime}(\Upsilon)\right)$ solves (3.1) weakly (i.e. duality with $H_{\text {per }}^{1}(\Upsilon)$ for a.e. $\left.t \in[0, T]\right)$.

Step 4 (initial data): Recall that $f_{0}$ has Fourier expansion (3.2) and $f^{n}(0, \cdot, \cdot) \rightarrow$ $f_{0}$ strongly in $L_{p e r}^{2}(\Upsilon)$. Moreover, by extracting a subsequence after applying the Aubin-Lions Lemma under (3.26), $f^{n}(t) \rightarrow f(t)$ strongly in $L_{p e r}^{2}(\Upsilon)$ for a.e. $t \in[0, T]$. By Remark 2.4, $f^{n}, f \in C\left([0, T] ; L_{\text {per }}^{2}(\Upsilon)\right)$. Hence, $t=0$ is a Lebesgue point, and $f^{n}(0) \rightarrow f(0)$ strongly in $L_{\text {per }}^{2}(\Upsilon)$. By uniqueness of limits, $f(0)=f_{0}$ in $L_{\text {per }}^{2}(\Upsilon)$.

Step 5 (solution to the original equation and nonnegativity): As direct consequence of the previous step, by integrating the equation (3.1) in the angle variable, we infer that $\rho(t, \mathbf{x})=\int_{0}^{2 \pi} f(\mathbf{x}, t, \theta) \mathrm{d} \theta$ is a curve belonging to $L^{\infty}\left([0, T] ; L_{p e r}^{2}(\Omega)\right) \cap$ $L^{2}\left([0, T] ; H_{p e r}^{1}(\Omega)\right)$, and is a weak solution of

Moreover, by the weak-* lower semicontinuity of the norm, $\rho^{\prime} \in L^{2}\left([0, T] ;\left(H_{p e r}^{1}\right)^{\prime}(\Omega)\right)$ as it is the weak-* limit curve of the sequence $\left\{a_{0}^{n \prime}\right\}_{n \in \mathbb{N}}$. Begin by noting that (1-$\left.(\rho)_{+}\right)_{-}=-\left(1-\rho \mathbb{1}_{\rho>0}\right) \mathbb{1}_{\rho>1}$, which implies that, in the sense of distributions, $\partial_{t}(1-$ $\left.(\rho)_{+}\right)_{-}=\partial_{t} \rho \mathbb{1}_{\rho>1}$ and $\nabla\left(1-(\rho)_{+}\right)_{-}=\nabla \rho \mathbb{1}_{\rho>1}$. Testing (3.27) with $\left(1-(\rho)_{+}\right)_{-}$,
$\frac{1}{2} \frac{d}{d t} \int_{\Omega}\left(1-(\rho)_{+}\right)_{-}^{2} \mathrm{~d} \mathbf{x}=\operatorname{Pe} \int_{\Omega} \nabla\left(1-(\rho)_{+}\right)_{-} \cdot\left(1-(\rho)_{+}\right)_{+} \mathbf{p} \mathrm{d} \mathbf{x}-D_{e} \int_{\Omega}|\nabla \rho|^{2} \mathbb{1}_{\rho>1} \mathrm{~d} \mathbf{x}$.
Observe that the first term on the right-hand side is null, since the supports of the two terms in the integrand are disjoint, while the final term is nonpositive. We thereby deduce $\frac{1}{2} \int_{\Omega}\left(1-(\rho(t))_{+}\right)_{-}^{2} \mathrm{~d} \mathbf{x} \leq 0$, since we initially have $\left(1-\rho_{0}(\mathbf{x})_{-}=0\right.$ for a.e. $x \in \Omega$. As a result, $\rho(t, \mathbf{x}) \leq 1$ for a.e. $(t, \mathbf{x}) \in(0, T) \times \Omega$, as required.

Returning to (3.1) and testing with $(f)_{-}$, we get, after integrating by parts,

$$
\begin{aligned}
\frac{1}{2} \frac{d}{d t} \int_{\Upsilon}(f)_{-}^{2} \mathrm{~d} \boldsymbol{\xi} & =\operatorname{Pe} \int_{\Upsilon} \nabla(f)_{-} \cdot(f)_{-}\left(1-(\rho)_{+}\right)_{+} \mathbf{e}(\theta) \mathrm{d} \boldsymbol{\xi}-D_{e} \int_{\Upsilon}\left|\nabla(f)_{-}\right|^{2} \mathrm{~d} \boldsymbol{\xi}-\int_{\Upsilon}\left|\partial_{\theta}(f)_{-}\right|^{2} \mathrm{~d} \boldsymbol{\xi} \\
& \leq C\left(\operatorname{Pe}, D_{e}\right) \int_{\Upsilon} \frac{1}{2}(f)_{-}^{2} \mathrm{~d} \boldsymbol{\xi}-\frac{1}{2} D_{e} \int_{\Upsilon}\left|\nabla(f)_{-}\right|^{2} \mathrm{~d} \boldsymbol{\xi}-\int_{\Upsilon}\left|\partial_{\theta}(f)_{-}\right|^{2} \mathrm{~d} \boldsymbol{\xi}
\end{aligned}
$$

where $\boldsymbol{\xi}=(\mathbf{x}, \theta)$. Dropping the two nonpositive terms, Grönwall's Lemma implies

$$
\int_{\Upsilon}(f(t, \mathbf{x}, \theta))_{-}^{2} \mathrm{~d} \boldsymbol{\xi} \leq \exp (C t) \int_{\Upsilon}\left(f_{0}(\mathbf{x}, \theta)\right)_{-}^{2} \mathrm{~d} \boldsymbol{\xi}=0 \quad \text { a.e. } t \in(0, T)
$$

since $f_{0}$ is nonnegative a.e. on $\Upsilon$. Hence, $f(t, \mathbf{x}, \theta) \geq 0$ for a.e. $(t, \mathbf{x}, \theta) \in \Upsilon \times(0, T)$ and thus the space density $\rho(t, \mathbf{x}) \in[0,1]$ for a.e. $(t, \mathbf{x}) \in \Upsilon \times(0, T)$. Hence the limiting curve $f$ is a weak solution in the sense of Definition 2.2 to the original equation (1.2). We emphasise that $f \in C\left([0, T] ; L_{p e r}^{2}(\Upsilon)\right)$ is deduced from $f \in L^{2}\left([0, T] ; H_{p e r}^{1}(\Upsilon)\right)$ and $f^{\prime} \in L^{2}\left([0, T] ;\left(H_{p e r}^{1}\right)^{\prime}(\Upsilon)\right) ; c f$. Remark 2.4.

### 3.4. Uniqueness of solutions.

Lemma 3.2. Given $f_{0} \in L_{\text {per }}^{2}(\Upsilon)$ nonnegative such that its corresponding $\rho_{0}$ satisfies $\rho_{0}(\mathbf{x})=\int_{0}^{2 \pi} f_{0}(\mathbf{x}, \theta) \mathrm{d} \theta \in[0,1]$ for a.e. $\mathbf{x} \in \Omega$, there exists at most one periodic weak solution, in the sense of Definition 2.2, of the problem (2.2).

Proof. Let us consider two weak solutions to (1.2), $f_{1}, f_{2}$, in the sense of Definition 2.2, and set $\bar{f}:=f_{1}-f_{2}$ to be their difference. We refer to $\rho_{1}, \rho_{2}$ as the corresponding space densities, and to $\bar{\rho}:=\rho_{1}-\rho_{2}$ as their difference. By means of a
direct computation, $\bar{f}$ is a weak solution to

$$
\partial_{t} \bar{f}+\operatorname{Pe} \nabla \cdot\left(\left(1-\rho_{1}\right) \bar{f} \mathbf{e}(\theta)-\bar{\rho} f_{2} \mathbf{e}(\theta)\right)=D_{e} \Delta \bar{f}+\partial_{\theta}^{2} \bar{f}
$$

and $\bar{\rho}$ solves $\partial_{t} \bar{\rho}+\operatorname{Pe} \nabla \cdot\left(\left(1-\rho_{1}\right) \overline{\mathbf{p}}-\bar{\rho} \mathbf{p}_{2}\right)=D_{e} \Delta \bar{\rho}$, where we remind the reader $\overline{\mathbf{p}}(t, \mathbf{x})=\int_{0}^{2 \pi} \bar{f}(t, \mathbf{x}, \theta) \mathrm{d} \theta$ and $\mathbf{p}_{2}(t, \mathbf{x})=\int_{0}^{2 \pi} f_{2}(t, \mathbf{x}, \theta) \mathrm{d} \theta$, for any $(t, \mathbf{x}, \theta) \in[0, T] \times \Upsilon$. Note that, by directly integrating the previous equation for $\bar{\rho}, \int_{\Omega} \bar{\rho}(\mathbf{x}) \mathrm{d} \mathbf{x}=0$, and thus $\int_{\Omega} \int_{0}^{2 \pi} \bar{f}(t, \mathbf{x}, \theta) \mathrm{d} \theta \mathrm{d} \mathbf{x}=0$. Motivated by this latter "mean-zero condition", we consider the space

$$
H_{z}^{1}(\Upsilon):=\left\{f \in H^{1}(\Upsilon): \int_{\Upsilon} f(\xi) \mathrm{d} \xi=0\right\}
$$

and its dual $\left(H_{z}^{1}\right)^{\prime}(\Upsilon)$, where subscript $z$ refers to the mean-zero property in question. Let $L:=(-\Delta)^{-1}:\left(H_{z}^{1}\right)^{\prime}(\Upsilon) \rightarrow\left(H_{z}^{1}\right)(\Upsilon)$ be the inverse of the solution operator for the Poisson equation with periodic boundary condition, that is $L g=u$, where $\int_{\Upsilon} \nabla u \cdot \nabla \varphi=\langle g, \varphi\rangle$ for all $\varphi \in H_{z}^{1}(\Upsilon)$. In the following we shall use that $L$ maps continuously $L_{z}^{2}(\Upsilon)$ into $H_{z}^{2}(\Upsilon)$. Moreover, we note the self-adjointness property

$$
\langle\varphi, L \varphi\rangle=\left\langle(-\Delta) \circ(-\Delta)^{-1} \varphi, L \varphi\right\rangle=\|\nabla L \varphi\|_{L^{2}(\Upsilon)}^{2}=\langle L \varphi, \varphi\rangle
$$

for every $\varphi \in H_{z}^{1}(\Upsilon)$, where the duality product is understood in the sense of $L^{2}(\Upsilon)$. Similarly, using the commutativity of the partial derivatives, for any $\varphi \in H_{z}^{1}(\Upsilon)$,

$$
\left\langle\partial_{\theta} \varphi, \partial_{\theta} L \varphi\right\rangle=\left\langle(-\Delta) \partial_{\theta} L \varphi, \partial_{\theta} L \varphi\right\rangle=\left\|\nabla \partial_{\theta} L \varphi\right\|_{L^{2}(\Upsilon)}^{2} .
$$

Let $\lambda>0$. For the next lines of computation, we use Definition 2.2, Young's inequality, the bound $\rho_{1} \leq 1$, and the self-adjointness property. We drop the time dependence for ease of presentation. We obtain

$$
\begin{align*}
\frac{1 \mathrm{~d}}{2 \mathrm{~d} t}\left(\|\nabla L \bar{f}\|_{L^{2}(\Upsilon)}^{2}+\lambda\|\bar{\rho}\|_{L^{2}(\Omega)}^{2}\right)= & \left\langle\partial_{t} \bar{f}, L \bar{f}\right\rangle+\lambda\left\langle\partial_{t} \bar{\rho}, \bar{\rho}\right\rangle \\
= & -D_{e}\|\bar{f}\|_{L^{2}(\Upsilon)}^{2}-\left\|\nabla \partial_{\theta} L \bar{f}\right\|_{L^{2}(\Upsilon)}^{2}-\lambda D_{e}\|\nabla \bar{\rho}\|_{L^{2}}^{2} \\
& +\operatorname{Pe}\left\langle\left(1-\rho_{1}\right) \bar{f} \mathbf{e}(\theta), \nabla L \bar{f}\right\rangle-\operatorname{Pe} \lambda\left\langle\bar{\rho} \mathbf{p}_{2}, \nabla \bar{\rho}\right\rangle \\
& +\operatorname{Pe} \lambda\left\langle\left(1-\rho_{1}\right) \overline{\mathbf{p}}, \nabla \bar{\rho}\right\rangle-\operatorname{Pe}\left\langle\bar{\rho} f_{2} \mathbf{e}(\theta), \nabla L \bar{f}\right\rangle \\
\leq & -D_{e}\left(1-\frac{1}{2 \varepsilon}-\frac{\lambda}{\sigma} \pi\right)\|\bar{f}\|_{L^{2}(\Upsilon)}^{2}  \tag{3.28}\\
& -\lambda\left(D_{e}-\frac{\operatorname{Pe}^{2} \sigma}{D_{e}}\right)\|\nabla \bar{\rho}\|_{L^{2}(\Omega)}^{2}+\frac{\lambda D_{e}}{2 \sigma}\|\bar{\rho}\|_{L^{2}(\Omega)}^{2} \\
& +\frac{\operatorname{Pe}^{2} \varepsilon}{2 D_{e}}\|\nabla L \bar{f}\|_{L^{2}(\Upsilon)}^{2}-\operatorname{Pe}\left\langle\bar{\rho} f_{2} \mathbf{e}(\theta), \nabla L \bar{f}\right\rangle
\end{align*}
$$

where we also used $\|\overline{\mathbf{p}}\|_{L^{2}(\Omega)}^{2} \leq 2 \pi\|\bar{f}\|_{L^{2}(\Upsilon)}^{2}$, and noticed that for any $(t, \mathbf{x}) \in \Omega \times[0, T]$, $\left|\mathbf{p}_{2}(t, \mathbf{x})\right| \leq \int_{0}^{2 \pi} f_{2}(t, \mathbf{x}, \theta) \mathrm{d} \theta=\rho_{2}(t, \mathbf{x}) \leq 1$, which implies $\left\|\bar{\rho} \mathbf{p}_{2}\right\|_{L^{2}(\Omega)}^{2} \leq\|\bar{\rho}\|_{L^{2}(\Omega)}^{2}$. In order to apply the Grönwall inequality and conclude the argument we must estimate the final term in (3.28). Since the operator $L$ maps continuously $L_{z}^{2}(\Upsilon)$ into $H_{z}^{2}(\Upsilon)$, we have $L \bar{f} \in H_{z}^{2}(\Upsilon)$, thus $\nabla L \bar{f} \in H_{z}^{1}(\Upsilon)$. By means of the Sobolev embedding $H^{1}(\Upsilon) \hookrightarrow L^{p_{*}}(\Upsilon)$ for $p_{*}=6$, and that $|\Upsilon|<+\infty$, we infer that $\nabla L \bar{f} \in L^{p^{\prime}}(\Upsilon)$ for any $p^{\prime} \leq p_{*}=6$, and $f_{2} \in L^{q}(\Upsilon)$ for any $q \leq p_{*}=6$. In particular, for $\frac{6}{5} \leq p \leq \frac{3}{2}$ and
$q=\frac{2 p}{2-p} \leq 6$, using the Cauchy-Young inequality to get from the second line to the third, and the Gagliardo-Nirenberg inequality to get the final line, we see that the term $\operatorname{Pe}\left|\left\langle\bar{\rho} f_{2} \mathbf{e}(\theta), \nabla L \bar{f}\right\rangle\right|$ is bounded by

$$
\begin{align*}
\operatorname{Pe}\left\|\bar{\rho} f_{2}\right\|_{L^{p}(\Upsilon)}\|\nabla L \bar{f}\|_{L^{p^{\prime}}(\Upsilon)} & \leq C\left(\mathrm{Pe},|\Upsilon|, p^{\prime}, p_{*}\right)\|\bar{f}\|_{L^{2}(\Upsilon)}\left\|\bar{\rho} f_{2}\right\|_{L^{p}(\Upsilon)} \\
& \leq \frac{\lambda D_{e}}{2}\|\bar{f}\|_{L^{2}(\Upsilon)}^{2}+\frac{\tilde{c}}{\lambda D_{e}}\left\|f_{2}\right\|_{H^{1}(\Upsilon)}^{2}\|\bar{\rho}\|_{L^{2}(\Omega)}^{2} \tag{3.29}
\end{align*}
$$

where the constants $\lambda, \tilde{c}$ depend only on $\Upsilon, p, q$ via the embeddings. Using (3.29) in (3.28), we get

$$
\begin{aligned}
\frac{1}{2} \frac{\mathrm{~d}}{\mathrm{~d} t} & \left(\|\nabla L \bar{f}\|_{L^{2}(\Upsilon)}^{2}+\lambda\|\bar{\rho}\|_{L^{2}(\Omega)}^{2}\right) \\
\leq & -D_{e}\left(1-\frac{\lambda}{2}-\frac{1}{2 \varepsilon}-\frac{\lambda}{\sigma} \pi\right)\|\bar{f}\|_{L^{2}(\Upsilon)}^{2}-\lambda\left(D_{e}-\frac{\operatorname{Pe}^{2} \sigma}{D_{e}}\right)\|\nabla \bar{\rho}\|_{L^{2}(\Omega)}^{2} \\
& +\frac{\mathrm{Pe}^{2} \varepsilon}{2 D_{e}}\|\nabla L \bar{f}\|_{L^{2}(\Upsilon)}^{2}+\frac{\lambda D_{e}}{2 \sigma}\|\bar{\rho}\|_{L^{2}(\Omega)}^{2}+\frac{\tilde{c}}{\lambda D_{e}}\left\|f_{2}\right\|_{H^{1}(\Upsilon)}^{2}\|\bar{\rho}\|_{L^{2}(\Omega)}^{2} \\
\leq & \frac{M\left(f_{2}\right)}{\lambda^{2} \sigma}\left(\|\nabla L \bar{f}\|_{L^{2}(\Upsilon)}^{2}+\lambda\|\bar{\rho}\|_{L^{2}(\Omega)}^{2}\right)
\end{aligned}
$$

where we set $\sigma=\frac{D_{e}^{2}}{\mathrm{Pe}^{2}}, \lambda=\left(1+\frac{\mathrm{Pe}^{2}}{D_{e}^{2}} \pi\right)^{-1}, \varepsilon=\frac{1}{\lambda}$, and $M\left(f_{2}\right):=\max \left\{\frac{\mathrm{Pe}^{2} \lambda \sigma}{2 D_{e}}, \frac{\lambda^{2} D_{e}}{2}+\right.$ $\left.\frac{\tilde{c} \sigma}{D_{e}}\left\|f_{2}\right\|_{H^{1}(\Upsilon)}^{2}\right\}$. Finally, since $f_{2} \in L^{2}\left([0, T] ; H_{p e r}^{1}(\Upsilon)\right)$, by means of Grönwall inequality we obtain uniqueness, as for any $t \in[0, T]$

$$
\|\nabla L \bar{f}(t)\|_{L^{2}(\Upsilon)}^{2}+\lambda\|\bar{\rho}(t)\|_{L^{2}(\Omega)}^{2} \leq \underbrace{\left(\|\nabla L \bar{f}(0)\|_{L^{2}(\Upsilon)}^{2}+\lambda\|\bar{\rho}(0)\|_{L^{2}(\Omega)}^{2}\right)}_{=0} e^{2 \int_{0}^{t} \frac{M\left(f_{2}(s)\right)}{\lambda^{2} \sigma} \mathrm{~d} s}
$$

3.5. Existence and uniqueness of solutions to the 1D Model. The analysis carried out previously for (1.2) can be applied to obtain well-posedness for the 1D model (1.4). Therefore, we will not provide proofs but only point out the main differences.

Let $f_{L}(x, t)$ and $f_{R}(x, t)$ be the densities of the left- and right-moving particles, respectively. The (rescaled) one dimensional version of (1.2) is

$$
\left\{\begin{array}{l}
\partial_{t} f_{R}+\operatorname{Pe} \partial_{x}\left(f_{R}(1-\rho)\right)=\partial_{x x} f_{R}+f_{L}-f_{R}  \tag{3.30}\\
\partial_{t} f_{L}-\operatorname{Pe} \partial_{x}\left(f_{L}(1-\rho)\right)=\partial_{x x} f_{L}+f_{R}-f_{L}
\end{array}\right.
$$

The space density and the polarisation are, respectively,

$$
\rho:=f_{R}+f_{L}, \quad p:=f_{R}-f_{L}
$$

Definition 3.3 (Weak solution to 1D model). Let $f_{R, 0}, f_{L, 0} \in L_{\text {per }}^{2}([0,2 \pi])$ be nonnegative functions such that

$$
\rho_{0}(x)=f_{R, 0}(x)+f_{L, 0}(x) \in[0,1], \quad \text { for a.e } x \in[0,2 \pi]
$$

A weak solution to system (3.30) is a pair of curves $\left(f_{R}, f_{L}\right)$ such that $f_{R}, f_{L} \in$ $L^{2}\left([0, T] ; H_{\text {per }}^{1}([0,2 \pi])\right)$ and $f_{R}^{\prime}, f_{L}^{\prime} \in L^{2}\left([0, T] ;\left(H_{p e r}^{1}\right)^{\prime}([0,2 \pi])\right)$, and for a.e. $t \in[0, T]$ and any $\varphi, \phi \in H_{p e r}^{1}([0,2 \pi])$ it holds

$$
\begin{aligned}
& \left\langle\partial_{t} f_{R}(t), \varphi\right\rangle_{\Omega}=P e\left\langle f_{R}(t)(1-\rho(t)), \partial_{x} \varphi\right\rangle_{\Omega}-\left\langle\partial_{x} f_{R}(t), \partial_{x} \varphi\right\rangle_{\Omega}+\left\langle f_{L}(t)-f_{R}(t), \varphi\right\rangle_{\Omega} \\
& \left\langle\partial_{t} f_{L}(t), \phi\right\rangle_{\Omega}=-P e\left\langle f_{L}(t)(1-\rho(t)), \partial_{x} \phi\right\rangle_{\Omega}-\left\langle\partial_{x} f_{L}(t), \partial_{x} \phi\right\rangle_{\Omega}+\left\langle f_{R}(t)-f_{L}(t), \phi\right\rangle_{\Omega}, \\
& \left(f_{R}, f_{L}\right)(x, 0)=\left(f_{R, 0}, f_{L, 0}\right)
\end{aligned}
$$

with periodic boundary conditions on $\Omega$, where $\rho(t, x)=f_{R}(t, x)+f_{L}(t, x)$, and the initial data is achieved in the sense $f_{R}(0)=f_{R, 0}$ and $f_{L}(0)=f_{L, 0}$ in $L_{p e r}^{2}([0,2 \pi])$.

Notice that adding/subracting the equations in system (3.30) yields

$$
\left\{\begin{array}{l}
\partial_{t} \rho+\operatorname{Pe} \partial_{x}(p(1-\rho))=\partial_{x x} \rho  \tag{3.31}\\
\partial_{t} p+\operatorname{Pe} \partial_{x}(\rho(1-\rho))=\partial_{x x} p-2 p
\end{array}\right.
$$

As already mentioned, existence and uniqueness of solutions to (3.30) can be proved with a strategy similar to that used for (1.2). The main difference is the absence of the angular variable, which simplifies the discretisation of the system; indeed the angular variable is already discretised, as there are only two possible directions (left and right). It therefore suffices to write a Galerkin approximation only in space, as in subsection 3.2. Moreover, the solution $\left(f_{R}, f_{L}\right)$ directly inherits the bound of the density $\rho$ (unlike in the higher dimensional case). This simplifies the uniqueness proof, since we need not employ the operator $(-\Delta)^{-1}$. The result is stated below.

ThEOREM 3.4 (Well-posedness for 1D model). Let $\left(f_{R, 0}, f_{L, 0}\right) \in\left(L_{p e r}^{2}([0,2 \pi])\right)^{2}$ be a pair of nonnegative functions such that

$$
\rho_{0}(x)=f_{R, 0}(x)+f_{L, 0}(x) \in[0,1] \quad \text { for a.e. } x \in[0,2 \pi] .
$$

For any $T>0$, there exists a unique weak solution to (3.30) in the sense of Definition 3.3. Moreover, $f_{R}(t, x), f_{L}(t, x) \in[0,1]$ for a.e. $t \in[0, T]$ and $x \in[0,2 \pi]$.

Remark 3.5. As per Remark 2.4, we deduce $f_{R}, f_{L} \in C\left([0, T] ; L_{\text {per }}^{2}([0,2 \pi])\right)$.
4. Regularity. Having established well-posedness in section 3, we turn to the issue of regularity. More precisely, we provide here the proof of Theorem 2.5, which is performed in Lemmas 4.8 and 4.9. For ease of presentation we start with the one-dimensional model.
4.1. Regularity for the 1D model. Our strategy is to apply the Duhamel principle so as to treat (3.30) as a forced one-dimensional heat equation. Inspired by [ 6 , Chapter 9$]$, we make the following definition.

Definition 4.1. Define $\Phi:(0, \infty) \times \mathbb{R} \rightarrow \mathbb{R}$ by the explicit formula

$$
\begin{equation*}
\Phi(t, x):=\frac{1}{2 \pi}+\frac{1}{\pi} \sum_{n=1}^{\infty} e^{-n^{2} t} \cos n x \quad \forall(t, x) \in(0, \infty) \times \mathbb{R} \tag{4.1}
\end{equation*}
$$

Note that the above may be rewritten in terms of the complex exponential basis as $\Phi(t, x)=\frac{1}{2 \pi}+\sum_{n \in \mathbb{Z} \backslash\{0\}} \frac{e^{-n^{2} t}}{2 \pi} e^{i n x}$ for all $(t, x) \in(0, \infty) \times \mathbb{R}$. In what follows it will be useful to rewrite $\Phi$ in terms of the Jacobi theta- 3 function (denoted by $\theta_{3}$ ), and in terms of the Jacobi theta function (denoted by $\vartheta$, also sometimes by $\vartheta_{00}$ ),

$$
\begin{equation*}
\Phi(t, x)=\frac{1}{2 \pi} \theta_{3}\left(\frac{x}{2}, e^{-t}\right)=\frac{1}{2 \pi} \vartheta\left(\frac{x}{2 \pi}, \frac{i t}{\pi}\right) \quad \forall(t, x) \in(0, \infty) \times \mathbb{R} . \tag{4.2}
\end{equation*}
$$

Lemma 4.2. The function $\Phi$ of Definition 4.1 is a smooth $2 \pi$-periodic function that satisfies $\partial_{t} \Phi-\partial_{x x} \Phi=0$ as a pointwise equality in $(0, \infty) \times \mathbb{R}$, is nonnegative in $(0, \infty) \times \mathbb{R}$, and $\|\Phi(t, \cdot)\|_{L^{1}([0,2 \pi])}=1$ for every $t \in(0, \infty)$. Additionally,

$$
\begin{equation*}
\int_{0}^{t}\|\Phi(\tau, \cdot)\|_{L^{2}([0,2 \pi])}^{2} \mathrm{~d} \tau=t+\sum_{n=1}^{\infty} \frac{1}{2 n^{2}}\left(1-e^{-2 n^{2} t}\right) \quad \forall t>0 \tag{4.3}
\end{equation*}
$$

and $\int_{0}^{t} \int_{0}^{2 \pi} \Phi(t-s, x-y)^{2} \mathrm{~d} y \mathrm{~d} s=\int_{0}^{t}\|\Phi(\tau, \cdot)\|_{L^{2}([0,2 \pi])}^{2} \mathrm{~d} \tau$ for all $(t, x) \in(0, T] \times[0,2 \pi]$. Finally, for any $2 \pi$-periodic $C^{2}$ function $\psi, \lim _{t \rightarrow 0^{+}} \int_{0}^{2 \pi} \Phi(t, x) \psi(x) \mathrm{d} x=\psi(0)$.

The proof of Lemma 4.2 is in Appendix B. We use the function $\Phi$ as a periodic heat kernel, in the sense made precise by the following result. The initial data $\psi$ is chosen in $L_{\text {loc }}^{1}(\mathbb{R})$ to justify the expansion in terms of the sine/cosine basis.

Lemma 4.3. Let $\psi \in L_{\text {per }}^{1}([0,2 \pi])$. Then, $\Psi(t, x):=\int_{0}^{2 \pi} \Phi(t, x-y) \psi(y) \mathrm{d} y$ for all $(t, x) \in(0, \infty) \times \mathbb{R}$ is a smooth $2 \pi$-periodic function defined on the full-space $(0, \infty) \times \mathbb{R}$, which solves the Cauchy problem

$$
\begin{cases}\partial_{t} \Psi-\partial_{x x} \Psi=0 & \text { in }(0, \infty) \times \mathbb{R}  \tag{4.4}\\ \left.\Psi\right|_{t=0}=\psi & \text { on } \mathbb{R}\end{cases}
$$

where the initial data is achieved in $L_{l o c}^{1}$, i.e., $\lim _{t \rightarrow 0^{+}}\|\Psi(t, \cdot)-\psi\|_{L^{1}([0,2 \pi])}=0$.
The proof of this result is in Appendix B. An alternative way of generating periodic solutions of the heat equation is to convolve the classical one-dimensional heat kernel with $2 \pi$-periodic test functions. However, when performing integration by parts in the Duhamel formula ( $c f$. (4.5) in the lemma below) the boundary terms do not vanish unless both the kernel and the "test function" are periodic. Hence, the kernel of Definition 4.1 is better suited to our analysis.

Lemma 4.4 (Regularity away from initial time). Suppose that the periodic initial data for problem (3.30) is such that $f_{R, 0}, f_{L, 0} \in L^{\infty}(\Omega)$. Then, the unique weak solutions $f_{R}$ and $f_{L}$ of (3.30) belong to $C((0, T] \times \bar{\Omega})$.

Proof. Recall from Theorem 3.4 that we have $f_{R}, f_{L}, \rho \in L^{\infty}([0, T] \times \Omega)$.
The key observation is that the equations (3.30) can be interpreted as heat equations with a source on the right-hand side. Since we already derived the fundamental solution of the periodic heat equation in Lemmas 4.2 and 4.3, and we have already shown uniqueness in the relevant space of solutions to (3.30), we are in a position to apply the Duhamel principle and obtain implicit integral relations for $f_{R}$ and $f_{L}$. In the first step of the proof, we justify that these Duhamel formulas are well-defined. In a second step, we prove the continuity of these functions away from the initial time.

Step 1 (Duhamel formula): We justify that the formula for $f_{R}$

\begin{align*}
f_{R}(t, x) & =\int_{0}^{2 \pi} \Phi(t, x-y) f_{R, 0}(y) \mathrm{d} y  \tag{4.5}\\
& -\int_{0}^{t} \int_{0}^{2 \pi} \Phi(t-s, x-y)\left(\operatorname{Pe}_{y}\left\{f_{R}(s, y)[1-\rho(s, y)]\right\}+f_{R}(s, y)-f_{L}(s, y)\right) \mathrm{d} y \mathrm{~d} s
\end{align*}
$$

is well-defined, for a.e. $(t, x) \in[0, T] \times \bar{\Omega}$. To begin with, whenever $t>0$, the function $\Phi(t, \cdot)$ is smooth and is therefore square-integrable on the compact interval $[0,2 \pi]$. This shows that the integrand in the first integral in (4.5) is integrable. Meanwhile, the
equality (4.3) shows that $\Phi \in L^{2}\left([0, T] ; L^{2}([0,2 \pi])\right)$, whence, using the boundedness of $\rho$,

$$
\begin{aligned}
& \int_{0}^{t} \int_{0}^{2 \pi} \Phi(t-s, x-y)\left|\partial_{y}\left\{f_{R}(s, y)[1-\rho(s, y)]\right\}\right| \mathrm{d} y \mathrm{~d} s \\
& \leq 2 \int_{0}^{t}\left[\int_{0}^{2 \pi} \Phi(t-s, x-y)^{2} \mathrm{~d} y\right]^{1 / 2}\left[\int_{0}^{2 \pi}\left|\partial_{y} f_{R}(s, y)\right|^{2}+f_{R}(s, y)^{2}\left|\partial_{y} \rho(s, y)\right|^{2} \mathrm{~d} y\right]^{1 / 2} \mathrm{~d} s \\
& \leq \int_{0}^{t} \int_{0}^{2 \pi} \Phi(t-s, x-y)^{2} \mathrm{~d} y \mathrm{~d} s+\left\|f_{R}\right\|_{L^{2}\left(0, T ; H^{1}(\Omega)\right)}^{2}+\int_{0}^{t} \int_{0}^{2 \pi} f_{R}(s, y)^{2}\left|\partial_{y} \rho(s, y)\right|^{2} \mathrm{~d} y \mathrm{~d} s
\end{aligned}
$$

where we have used the Young inequality. As before, we use a change of variable and the constraint $x \in[0,2 \pi]$ to bound the first term on the right-hand side of the above by $2\|\Phi\|_{L^{2}\left(0, T ; L^{2}([0,2 \pi])\right)}^{2}$. Meanwhile,

$$
\int_{0}^{t} \int_{0}^{2 \pi} f_{R}(s, y)^{2}\left|\partial_{y} \rho(s, y)\right|^{2} \mathrm{~d} y \mathrm{~d} s \leq\left\|f_{R}\right\|_{L^{\infty}((0, T) \times \Omega)}^{2}\|\rho\|_{L^{2}\left(0, T ; H^{1}(\Omega)\right)}^{2}
$$

using that $f_{R} \in L^{\infty}((0, T) \times \Omega)$ from Theorem 3.4. Similarly, using Lemma 4.2
$\int_{0}^{t} \int_{0}^{2 \pi} \Phi(t-s, x-y)\left|f_{R}(s, y)-f_{L}(s, y)\right| \mathrm{d} y \mathrm{~d} s \leq 2\|\Phi\|_{L^{2}\left(0, T ; L^{2}(\Omega)\right)}\left\|f_{R}-f_{L}\right\|_{L^{2}\left(0, T ; L^{2}(\Omega)\right)}$.
Therefore, the integrand in the second integral of (4.5) is also integrable. It is an exercise to verify that (4.5), and the equivalent formula for $f_{L}$ satisfy (3.30) and are periodic on $\Omega$. These formulas therefore coincide with the unique solutions of (3.30).

Step 2 (continuity away from initial time): $\operatorname{Fix}(t, x) \in(0, T] \times \bar{\Omega}$ and let $\left(t_{n}, x_{n}\right) \in(0, T] \times \Omega$ be converging to $(t, x)$. Using the integrability from Step 1 , the continuity of $\Phi$ for $t>0$, and the Dominated Convergence Theorem on (4.5) and the analogous formula for $f_{L}$, we directly obtain $\left|f_{R}\left(t_{n}, x_{n}\right)-f_{R}(t, x)\right| \rightarrow 0$ and $\left|f_{L}\left(t_{n}, x_{n}\right)-f_{L}(t, x)\right| \rightarrow 0$ as $n \rightarrow \infty$. It follows that $f_{R}, f_{L} \in C((0, T] \times \bar{\Omega})$. In turn, we also obtain $\rho \in C((0, T] \times \bar{\Omega})$.

Lemma 4.5. Suppose that $f_{R, 0}, f_{L, 0} \in C(\bar{\Omega})$ and are periodic. Then, the unique weak solutions $f_{R}$ and $f_{L}$ of (3.30) belong to $C([0, T] \times \bar{\Omega})$.

Proof. We only write the proof for $f_{R}$, as the proof for $f_{L}$ is identical. In view of the uniform continuity of $f_{R}$ on the compact $\bar{\Omega}$, given $\varepsilon>0$ there exists $\delta=\delta(\varepsilon)$ for which if $x, y \in[0,2 \pi]$ are such that $|x-y|<\delta$, then $\left|f_{R, 0}(x)-f_{R, 0}(y)\right|<\varepsilon / 4$. Now, given $t \in(0, \infty)$ and $x^{*} \in(0,2 \pi)$, there holds from (4.5)

$$
\begin{aligned}
\left|f_{R}(t, x)-f_{R, 0}\left(x^{*}\right)\right| \leq & \left|\int_{0}^{2 \pi} \Phi(t, x-y) f_{R, 0}(y) \mathrm{d} y-f_{R, 0}\left(x^{*}\right)\right| \\
& +\operatorname{Pe} \int_{0}^{t} \int_{0}^{2 \pi} \Phi(t-s, x-y)\left|\partial_{y}\left(f_{R}(s, y)(1-\rho(s, y))\right)\right| \mathrm{d} y \mathrm{~d} s \\
& +k \int_{0}^{t} \int_{0}^{2 \pi} \Phi(t-s, x-y)\left|f_{R}(s, y)-f_{L}(s, y)\right| \mathrm{d} y \mathrm{~d} s \\
= & I_{1}(t, x)+I_{2}(t, x)+I_{3}(t, x)
\end{aligned}
$$

where we used the nonnegativity of $\Phi$ and $\int_{0}^{2 \pi} \Phi(t, x) \mathrm{d} x=1$ for every $t>0$ from Lemma 4.2. Using Hölder's inequality, the $L^{2}$-boundedness of $\partial_{x} f_{R}, f_{R}, f_{L}$, and Lemma 4.2, we obtain $\lim _{t \rightarrow 0^{+}}\left\|I_{2}(t, \cdot)\right\|_{L^{\infty}([0,2 \pi])}=\lim _{t \rightarrow 0^{+}}\left\|I_{3}(t, \cdot)\right\|_{L^{\infty}([0,2 \pi])}=0$.

It remains to control $I_{1}$. Recall that since $f_{R, 0} \in C(\bar{\Omega})$ is periodic, there exists a sequence $\left(\psi_{m}\right)_{m \in \mathbb{N}}$ of periodic elements of $C^{2}(\bar{\Omega})$ such that $\left\|f_{R, 0}-\psi_{m}\right\|_{L^{\infty}(\bar{\Omega})} \rightarrow 0$ as $n \rightarrow \infty$. Then, since $\psi_{m} \in C^{2}(\bar{\Omega})$ for each $m \in \mathbb{N}$, we know that it has Fourier coefficients $a_{m, n}, b_{m, n}$ that decay as $n^{-2} ; c f$. (B.1)-(B.2). Then, using the convolution result for Fourier series,

$$
\begin{aligned}
\left|\psi_{m}(x)-\int_{0}^{2 \pi} \Phi(t, x-y) \psi_{m}(y) \mathrm{d} y\right| & =\frac{1}{\pi}\left|\sum_{n=1}^{\infty}\left(1-e^{-n^{2} t}\right)\left(a_{m, n} \cos n x+b_{m, n} \sin n x\right)\right| \\
& \leq C_{m} \sum_{n=1}^{\infty} \frac{1}{n^{2}}\left(1-e^{-n^{2} t}\right) \rightarrow 0 \quad \text { as } t \rightarrow 0^{+}
\end{aligned}
$$

where we applied the Dominated Convergence Theorem applied to the atomic measure in the final line. Note that

$$
\begin{aligned}
& I_{1}(t, x) \leq\left|f_{R, 0}\left(x^{*}\right)-f_{R, 0}(x)\right|+\left|f_{R, 0}(x)-\psi_{m}(x)\right| \\
& \quad+\left|\psi_{m}(x)-\int_{0}^{2 \pi} \Phi(t, x-y) \psi_{m}(y) \mathrm{d} y\right|+\left|\int_{0}^{2 \pi} \Phi(t, x-y)\left(\psi_{m}(y)-f_{R, 0}(y)\right) \mathrm{d} y\right|
\end{aligned}
$$

and elementary manipulations ( $c f$. Step 3 of Proof of Lemma 4.2) relying also on the periodicity of $\psi_{m}$ yield $\int_{0}^{2 \pi} \Phi(t, x-y) \psi_{m}(y) \mathrm{d} y=\int_{0}^{2 \pi} \Phi(t, x-y) \psi_{m}(x+y) \mathrm{d} y$. Thus, given $\varepsilon>0$, by first picking $x$ such that $\left|x-x^{*}\right|<\delta$ and then choosing $m$ sufficiently large such that $\left\|f_{R, 0}-\psi_{m}\right\|_{L^{\infty}(\bar{\Omega})}<\varepsilon / 4$, and finally taking $t$ sufficiently close to zero for this particular $m$ ( $c f$. convergence to initial data of Lemma 4.2), it follows that

$$
I_{1}(t, x)<\frac{3}{4} \varepsilon+\left\|\psi_{m}-f_{R, 0}\right\|_{L^{\infty}(\bar{\Omega})} \int_{0}^{2 \pi} \Phi(t, x-y) \mathrm{d} y<\varepsilon
$$

where we used the unit integral property of $\Phi$. Hence, $\lim _{(t, x) \rightarrow\left(0^{+}, x^{*}\right)} I_{1}(t, x)=0$, and we conclude $\lim _{(t, x) \rightarrow\left(0^{+}, x^{*}\right)}\left|f_{R, 0}\left(x^{*}\right)-f_{R}(t, x)\right|=0$, which verifies the required continuity at the initial time. The same argument shows the result for $f_{L}$.

Remark 4.6. We showed that the weak solutions of the 1 D model, which (cf. Remark 3.5) in principle only belong to $C\left([0, T] ; L_{\text {per }}^{2}([0,2 \pi])\right) \cap L^{2}\left([0, T] ; H_{p e r}^{1}([0,2 \pi])\right.$, are in fact continuous under mild assumptions on the initial data. Although the authors suspect that it is possible to show higher regularity of the solutions, the method of proof required for such a result would be rather different to the current approach. For this reason, we leave this for further investigation.
4.2. Regularity for the 2 D model. In accordance with the expression for the one-dimensional periodic kernel in terms of complex exponentials ( $c f$. subsection 4.1), we find that the periodic heat kernel in three spatial dimensions (i.e. when $\Upsilon=$ $\left.[0,2 \pi]^{3}\right)$ is given by the explicit formula

$$
\begin{equation*}
\tilde{\Phi}(t, \mathbf{x})=\frac{1}{(2 \pi)^{3}}+\sum_{\mathbf{n} \in \mathbb{Z}^{3} \backslash\{0\}} \frac{e^{-|\mathbf{n}|^{2} t}}{(2 \pi)^{3}} e^{i \mathbf{n} \cdot \mathbf{x}} \quad \forall(t, \mathbf{x}) \in(0, \infty) \times \mathbb{R}^{3} \tag{4.6}
\end{equation*}
$$

Note that the above may be rewritten in terms of the Jacobi theta-3 function as $\tilde{\Phi}(t, \mathbf{x})=(2 \pi)^{-3} \theta_{3}\left(x_{1} / 2, e^{-t}\right) \theta_{3}\left(x_{2} / 2, e^{-t}\right) \theta_{3}\left(x_{3} / 2, e^{-t}\right)$ for every $(t, \mathbf{x}) \in(0, \infty) \times \mathbb{R}^{3}$. As per the proof of Lemma 4.2, we obtain that $\tilde{\Phi}$ is nonnegative in $(0, \infty) \times \mathbb{R}^{3}$ with (4.7)

$$
\|\tilde{\Phi}(t, \cdot)\|_{L^{1}(\Upsilon)}=1 \quad \text { and } \quad \int_{0}^{t}\|\tilde{\Phi}(\tau, \cdot)\|_{L^{2}(\Upsilon)}^{2} \mathrm{~d} \tau=t+\sum_{\mathbf{n} \in \mathbb{Z}^{3}} \frac{1}{2|\mathbf{n}|^{2}}\left(1-e^{-|\mathbf{n}|^{2} t}\right) \quad \forall t>0
$$

and that $\tilde{\Phi}$ is a smooth $\Upsilon$-periodic solution of the heat equation in $(0, \infty) \times \mathbb{R}^{3}$. In turn, an identical proof to that of Lemma 4.3 yields the following result.

Lemma 4.7. Let $\psi \in L_{\text {per }}^{1}(\Upsilon)$. Then, $\tilde{\Psi}(t, \boldsymbol{\xi}):=\int_{\Upsilon} \tilde{\Phi}(t, \boldsymbol{\xi}-\mathbf{z}) \psi(\mathbf{z}) \mathrm{d} \mathbf{z}$ for all $(t, \boldsymbol{\xi}) \in(0, \infty) \times \mathbb{R}^{3}$ is a smooth $\Upsilon$-periodic function defined on the full-space $(0, \infty) \times$ $\mathbb{R}^{3}$, and solves the Cauchy problem

$$
\begin{cases}\partial_{t} \tilde{\Psi}-\Delta_{\xi} \tilde{\Psi}=0 & \text { in }(0, \infty) \times \mathbb{R}^{3},  \tag{4.8}\\ \left.\Psi\right|_{t=0}=\psi & \text { on } \mathbb{R}^{3},\end{cases}
$$

where the initial data is achieved in $L_{\text {loc }}^{1}$, i.e., $\lim _{t \rightarrow 0^{+}}\|\tilde{\Psi}(t, \cdot)-\psi\|_{L^{1}(\Upsilon)}=0$.
In turn, we have the following regularity result.
LEMMA 4.8. Suppose the initial data for problem (1.2) is such that $f_{0} \in L_{p e r}^{\infty}(\Upsilon)$. Then unique weak solution $f$ of (1.2) supplied by Theorem 2.3 belongs to $C((0, T] \times \bar{\Upsilon})$.

Proof. There are two steps to the proof: the first is to show the boundedness of $f$ (which requires building an appropriate test function); the second is to argue via a Duhamel formula ( $c f$. Proof of Lemma 4.4).

Step 1 (boundedness of $f$ ): Recall from Theorem 2.3 that the weak solution of (1.2), $f$, a priori only belongs to the space $L^{\infty}\left([0, T] ; L_{\text {per }}^{2}(\Upsilon)\right) \cap L^{2}\left([0, T] ; H_{p e r}^{1}(\Upsilon)\right)$. We show that $f \in L^{\infty}((0, T) \times \Upsilon)$.

For any $k>0$, one verifies that $(f-k)_{+} \in L^{\infty}\left([0, T] ; L_{\text {per }}^{2}(\Omega)\right) \cap L^{2}\left([0, T] ; H_{p e r}^{1}(\Upsilon)\right)$ and $\partial_{t}(f-k)_{+} \in L^{2}\left([0, T] ;\left(H_{p e r}^{1}\right)^{\prime}(\Upsilon)\right)$. Indeed, there holds $(f-k)_{+}=\mathbb{1}_{\{f>k\}}(f-k)$, from which it follows that, in the sense of distributions, $\nabla_{t, \mathbf{x}, \theta}(f-k)_{+}=\mathbb{1}_{\{f>k\}} \nabla_{t, \mathbf{x}, \theta} f$ a.e. in $(0, T) \times \Upsilon$, where $\nabla_{t, \mathbf{x}, \theta}$ is the vector of derivatives $\left(\partial_{t}, \nabla, \partial_{\theta}\right)$, and we directly deduce the boundedness of the relevant norms. Thus, $(f(t)-k)_{+}$is an admissible test function for the weak formulation of Definition 2.2. Note additionally that, by [18, Ch. 2 Lem. 1.2], there holds in the sense of distributions, for a.e. $t \in(0, T)$, $\frac{d}{d t} \frac{1}{2} \int_{\Upsilon}(f(t)-k)_{+}^{2} \mathrm{~d} \mathbf{x}=\left\langle\partial_{t} f(t),(f(t)-k)_{+}\right\rangle_{\Upsilon}$. Using $(f(t)-k)_{+}$as the test function in the weak formulation of Definition 2.2, integrating in $\mathbf{x}$, using the boundedness of $\rho$, Hölder's inequality, and the Young inequality, we get

$$
\begin{array}{r}
\frac{d}{d t}\left(\frac{1}{2}\left\|(f(t)-k)_{+}\right\|_{L^{2}(\Upsilon)}^{2}\right)+\int_{\Upsilon}\left(\frac{D_{e}}{2}\left|\nabla(f(t)-k)_{+}\right|^{2}+\left|\partial_{\theta}(f(t)-k)_{+}\right|^{2}\right) \mathrm{d} \mathbf{x} \mathrm{~d} \theta \\
\leq \frac{\mathrm{Pe}^{2}}{2 D_{e}}\left\|(f(t)-k)_{+}\right\|_{L^{2}(\Upsilon)}^{2}
\end{array}
$$

for a.e. $t \in(0, T)$. It follows from the Grönwall Lemma that there holds

$$
\frac{1}{2}\left\|(f(t)-k)_{+}\right\|_{L^{2}(\Upsilon)}^{2} \leq \frac{1}{2}\left\|\left(f_{0}-k\right)_{+}\right\|_{L^{2}(\Upsilon)}^{2} \exp \left(\frac{\mathrm{Pe}^{2}}{D_{e}} t\right) \quad \text { a.e. } t \in(0, T)
$$

By selecting $k=\left\|f_{0}\right\|_{L^{\infty}(\Upsilon)}$, the right-hand side of the above is null. It follows that $f(t) \leq\left\|f_{0}\right\|_{L^{\infty}(\Upsilon)}$ for a.e. $t \in(0, T)$, i.e., $\|f\|_{L^{\infty}((0, T) \times \Upsilon)} \leq\left\|f_{0}\right\|_{L^{\infty}(\Upsilon)}$.

Step 2 (Duhamel formula for $f$ ): Without loss of generality for this final step we only consider the case where we have normalised the (1.2) by the positive constant $D_{e}$, so that $\partial_{t}-D_{e} \Delta-\partial_{\theta}^{2}$ may be rewritten as $\partial_{t}-\Delta_{\boldsymbol{\xi}}$ with $\boldsymbol{\xi}$ the usual 3-dimensional vector.

As per the proof of Lemma 4.4, in view of the uniqueness provided by Theorem 2.3, it follows from (1.2) and the Duhamel principle that $f$ satisfies the following implicit
equation, where the kernel $\tilde{\Phi}$ was defined in (4.6) (cf. Lemma 4.7),
$f(t, \boldsymbol{\xi})=\int_{\Upsilon} \tilde{\Phi}(t, \boldsymbol{\xi}-\mathbf{z}) f_{0}(\mathbf{z}) \mathrm{d} \mathbf{z}+\operatorname{Pe} \int_{0}^{t} \int_{\Upsilon} \tilde{\Phi}(t-s, \boldsymbol{\xi}-\mathbf{z}) \nabla_{\mathbf{z}} \cdot(f(s, \mathbf{z})(1-\rho(s, \mathbf{z})) \mathbf{e}(\theta)) \mathrm{d} \mathbf{z} d s$
for a.e. $(t, \boldsymbol{\xi}) \in[0, T] \times \bar{\Upsilon}$. Note that the above is well-defined: using the boundedness of $f$ from Step 1, we proceed to show the integrability of the integrand in (4.9) as per Step 1 of the proof of Lemma 4.4. We now deduce that $f \in C((0, T] \times \bar{\Omega})$ using the continuity of $\Phi$ for $t>0$ and the Dominated Convergence Theorem, exactly as we did in Step 2 of the proof of Lemma 4.4.

Finally, by following the strategy of proof of Lemma 4.5 to the letter, we obtain the following result concerning continuity up to the initial time.

Lemma 4.9. Suppose that the periodic initial data $f_{0}$ for problem (1.2) belongs to $C(\bar{\Upsilon})$. Then, the unique weak solution $f$ of (1.2) belongs to $C([0, T] \times \bar{\Upsilon})$.

We note, as per Remark 4.6, that it is likely possible to improve Lemma 4.9. However, the method for proving such a result is different from the current approach, which uses the Duhamel principle, and so we leave this for further investigation.
5. Extension to very weak solutions for the 2D model. The assumption on the initial data in $L_{\text {per }}^{2}(\Upsilon)$ rules out initial configurations with a fixed orientation, that is, $f_{0}(x, \theta)=h^{0}(x) \delta_{\theta=\theta^{*}}$ for some $\theta^{*} \in[0,2 \pi)$ and $h^{0} \in L_{p e r}^{2}(\Omega)$, where the latter is the usual Dirac delta in the angular variable only. Since such initial data belongs to $L^{2}\left(\Omega ; H^{s}(0,2 \pi)\right)$ for $s<-1 / 2$, we turn our attention to initial data $f_{0} \in$ $L_{\text {per }}^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)$. For the convenience of the reader, we clarify that, for any normed vector space $V$,

f \in L_{p e r}^{2}(\Omega ; V) \Longleftrightarrow\left\{\begin{array}{l}
f: \mathbb{R}^{2} \rightarrow V,  \tag{5.1}\\
\int_{\Omega}\|f(\mathbf{x}, \cdot)\|_{V}^{2} \mathrm{~d} \mathbf{x}<+\infty, \text { and } \\
f(\mathbf{x}-\mathbf{w}, \cdot)=f(\mathbf{x}, \cdot) \quad \text { a.e. } \mathbf{x} \in \Omega, \quad \forall \mathbf{w} \in(2 \pi \mathbb{Z})^{2},
\end{array}\right.
$$

where the final equality on the right-hand side holds in $V$.
In view of the previous discussion, we define the following Hilbert spaces, to give meaning to a weaker formulation of the equation (cf. Definition 5.1),

$$
\begin{align*}
& X:=L^{2}\left([0, T] ; H_{p e r}^{1}(\Upsilon)\right) \cap L^{2}\left([0, T] ; L_{p e r}^{2}\left(\Omega ; H_{p e r}^{2}(0,2 \pi)\right)\right) \\
& Y:=H_{p e r}^{1}(\Upsilon) \cap L_{p e r}^{2}\left(\Omega ; H_{p e r}^{2}(0,2 \pi)\right) \tag{5.2}
\end{align*}
$$

Note that $\|u\|_{X^{\prime}}^{2}=\int_{0}^{T}\|u(t)\|_{Y^{\prime}}^{2} \mathrm{~d} t$, and $\|u(t)\|_{Y^{\prime}}=\sup _{\substack{\varphi \in C_{p e r}^{\infty}(\tilde{\Upsilon}) \\\|\varphi\|_{Y} \leq 1}}\left|\langle u(t), \varphi\rangle_{\Upsilon}\right|$.
The initial density must now be defined in duality, i.e.,

$$
\begin{equation*}
\left.\rho_{0}(\mathbf{x}):=\left\langle f_{0}(\mathbf{x}, \cdot), 1\right\rangle_{\left(H_{p e r}^{1}\right)}\right)^{\prime} \times H_{p e r}^{1} \quad \text { a.e. } x \in \Omega, \tag{5.3}
\end{equation*}
$$

where $\langle\cdot, \cdot\rangle_{\left(H_{p e r}^{1}\right)^{\prime} \times H_{p e r}^{1}}$ is the duality product on $(0,2 \pi)$. Note that for $f_{0}(\mathbf{x}, \theta)=$ $h^{0}(\mathbf{x}) \delta_{\theta=\theta^{*}}$, the initial space density is $\rho_{0}(\mathbf{x})=h^{0}(\mathbf{x})$.

We now extend the concept of solution established in Definition 2.2 to admit a larger class of functions (i.e. smaller class of test functions). With slight abuse of terminology, we name these solutions very weak solutions, even though only the regularity in the angular variable is affected.

DEFINITION 5.1. A very weak solution of Eq. (1.2) is a curve $f$ belonging to $L^{2}\left([0, T] ; H_{\text {per }}^{1}\left(\Omega ;\left(H_{\text {per }}^{1}\right)^{\prime}(0,2 \pi)\right)\right) \cap L^{\infty}\left([0, T] ; L_{\text {per }}^{2}\left(\Omega ;\left(H_{\text {per }}^{1}\right)^{\prime}(0,2 \pi)\right)\right) \cap L^{2}((0, T) \times \Upsilon)$, with $\partial_{t} f \in X^{\prime}$ such that, for every test function $\varphi \in Y$, there holds for a.e. $t \in[0, T]$

$$
\begin{align*}
& \left\langle\partial_{t} f(t), \varphi\right\rangle_{\Upsilon}=\langle P e(1-\rho(t)) f(t) \mathbf{e}(\theta), \nabla \varphi\rangle_{\Upsilon}-\left\langle D_{e} \nabla f(t), \nabla \varphi\right\rangle_{\Upsilon}+\left\langle f(t), \partial_{\theta}^{2} \varphi\right\rangle_{\Upsilon},  \tag{5.4}\\
& f(0, \mathbf{x}, \theta)=f_{0}(\mathbf{x}, \theta), \quad \text { on } \Upsilon \times\{0\},
\end{align*}
$$

with periodic boundary conditions on $\Upsilon$, where $\rho(t, \mathbf{x})=\int_{0}^{2 \pi} f(t, \mathbf{x}, \theta) \mathrm{d} \theta$, and where the initial data is achieved in the sense $f(0)=f_{0}$ in $Y^{\prime}$.

Since $Y \subset L_{\text {per }}^{2}\left(\Omega ; H_{\text {per }}^{2}(0,2 \pi)\right)$, we have the inclusions $\left.L_{\text {per }}^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)\right) \subset$ $L_{\text {per }}^{2}\left(\Omega ;\left(H_{p e r}^{2}\right)^{\prime}(0,2 \pi)\right) \subset Y^{\prime}$. It follows that $f \in L^{2}\left([0, T] ; L_{\text {per }}^{2}\left(\Omega ;\left(H_{\text {per }}^{1}\right)^{\prime}(0,2 \pi)\right)\right)$ and $\partial_{t} f \in X^{\prime}$ imply $f \in H^{1}\left([0, T] ; Y^{\prime}\right)$. Hence, by [10, Sec. 5.9.2 Th. 2], $f \in$ $C\left([0, T] ; Y^{\prime}\right)$. Therefore, $f(0) \in Y^{\prime}$ is well-defined in the previous definition.

We now give the proof of Theorem 2.6; the main theorem of this section. Since a very weak solution is an element of $L^{2}((0, T) \times \Upsilon)$, this result implies that the solutions never concentrate in angle to a Dirac mass, even when the initial data does. This illustrates an instantaneous smoothing property of the equation.

Proof of Theorem 2.6. The idea of the proof is to construct a sequence of regularised initial data that approaches $f_{0}$ in the required norm, and to show that the corresponding regularised solutions converge to a very weak solution.

Step 1 (regularised sequence of initial data and solutions): Due to Lemma C. 1 in Appendix C, there exists $\left(f_{0}^{m}\right)_{m \in \mathbb{N}}$ nonnegative elements of $C_{p e r}^{\infty}(\bar{\Upsilon})$ such that

\left\|f_{0}-f_{0}^{m}\right\|_{L^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)} \rightarrow 0 \quad \text { as } m \rightarrow \infty \tag{5.5}
\end{equation*}
$$

with $\rho_{0}^{m}(\mathbf{x}):=\int_{0}^{2 \pi} f_{0}^{m}(\mathbf{x}, \theta) \mathrm{d} \theta \in[0,1]$ for a.e. $\mathbf{x} \in \Upsilon$. Note that (5.5) of course implies that there exists a positive constant $M$ independent of $m$ such that

\sup _{m}\left\|f_{0}^{m}\right\|_{L^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)} \leq M<+\infty . \tag{5.6}
\end{equation*}
$$

Since each $f_{0}^{m}$ is an admissible initial datum for Theorem 2.3, we deduce that there exists a unique $f_{m} \in L^{\infty}\left([0, T] ; L_{p e r}^{2}(\Upsilon)\right) \cap L^{2}\left([0, T] ; H_{p e r}^{1}(\Upsilon)\right)$ with $\partial_{t} f_{m} \in$ $L^{2}\left([0, T] ;\left(H_{p e r}^{1}\right)^{\prime}(\Upsilon)\right)$ solving (1.2) in the weak sense given by by Definition 2.2. Moreover, we have the uniform bound $0 \leq \rho_{m}(t, \mathbf{x}) \leq 1$ for a.e. $(t, x) \in(0, T) \times \Omega$. Note however that we do not have a uniform estimate on $\left\|f_{m}\right\|_{L^{2}\left((0, T) ; H^{1}(\Upsilon)\right)}$ or even on $\left\|f_{m}\right\|_{L^{2}((0, T) \times \Upsilon)}$, since these latter estimates depend on $\left\|f_{0}^{m}\right\|_{L^{2}(\Upsilon)}$, which explodes in the limit as $m \rightarrow \infty$. We therefore require a different estimate on $\left(f_{m}\right)_{m \in \mathbb{N}}$.

Step 2 (an auxiliary Dirichlet problem): In contrast to the inverse Laplacian introduced in subsection 3.4, we introduce $L_{\theta}:=\left(-\partial_{\theta}^{2}\right)^{-1}:\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi) \rightarrow$ $H_{p e r}^{1}(0,2 \pi)$, which is understood to be the unique solution of the Dirichlet problem:

\left(-\partial_{\theta}^{2}\right) L_{\theta} f=f \quad \text { in }(0,2 \pi)  \tag{5.7}\\
L_{\theta} f(0)=L_{\theta} f(2 \pi)=0
\end{array}\right.

Let us note that for any function $f \in\left(H_{\text {per }}^{1}\right)^{\prime}(0,2 \pi)$, there holds

\|f\|_{\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)}=\sup _{\substack{\varphi \in H_{p e r}^{1}(0,2 \pi) \\\|\varphi\|_{H^{1}(0,2 \pi)} \leq 1}}\langle f, \varphi\rangle_{\left(H_{p e r}^{1}\right)^{\prime} \times H_{p e r}^{1}} \leq\left\|\partial_{\theta} L_{\theta} f\right\|_{L_{p e r}^{2}(0,2 \pi)}
$$

Indeed, using the property $\left(-\partial_{\theta}^{2}\right) L_{\theta} f=f$, we have, where the duality product is between $H_{p e r}^{1}$ and its dual,

$$
|\langle f, \varphi\rangle|=\left|\left\langle\left(-\partial_{\theta}^{2}\right) \circ\left(-\partial_{\theta}^{2}\right)^{-1} f, \varphi\right\rangle\right|=\left|\left\langle\partial_{\theta} L_{\theta} f, \partial_{\theta} \varphi\right\rangle_{L^{2} \times L^{2}}\right| \leq\left\|\partial_{\theta} L_{\theta} f\right\|_{L^{2}}\left\|\partial_{\theta} \varphi\right\|_{L^{2}}
$$

Note that the integration by parts in the above involve no additional boundary term due to the periodicity of $f$ and $L_{\theta} f$. By choosing the specific test function $\varphi=L_{\theta} f \in$ $H_{p e r}^{1}(0,2 \pi)$ in the previous estimate, we obtain the maximum value in the duality product defining the $\left(H_{p e r}^{1}\right)^{\prime}$ norm, hence

\begin{equation*}
\|f\|_{\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)}=\left\|\partial_{\theta} L_{\theta} f\right\|_{L^{2}(0,2 \pi)} \tag{5.8}
\end{equation*}
$$

Since $L_{\theta} f \in H_{0}^{1}(0,2 \pi)$, the Poincaré inequality in one dimension yields

\begin{equation*}
\left\|L_{\theta} f\right\|_{L^{2}(0,2 \pi)}^{2} \leq C_{P}\left\|\partial_{\theta} L_{\theta} f\right\|_{L^{2}(0,2 \pi)}^{2}=C_{P}\|f\|_{\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)}^{2} \leq C_{P}\|f\|_{L_{p e r}^{2}(0,2 \pi)}^{2} \tag{5.9}
\end{equation*}
$$

where the constant $C_{P}$ depends only on the domain $(0,2 \pi)$, and (5.8) was used to obtain the equality. In turn, given a function $f$ such that $\nabla f \in L_{p e r}^{2}(0,2 \pi) \subset$ $\left(H_{\text {per }}^{1}\right)^{\prime}(0,2 \pi)$, there holds the estimate

\left\|L_{\theta} \nabla f\right\|_{L^{2}(0,2 \pi)}^{2} \leq C_{P}\|\nabla f\|_{\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)}^{2} \leq C_{P}\|\nabla f\|_{L^{2}(0,2 \pi)}^{2} \tag{5.10}
\end{equation*}
$$

and, directly from (5.8),

$$
\begin{equation*}
\left\|\partial_{\theta} L_{\theta} \nabla f\right\|_{L^{2}(0,2 \pi)}^{2}=\|\nabla f\|_{\left(H_{p e r}\right)^{\prime}(0,2 \pi)}^{2} \leq\|\nabla f\|_{L^{2}(0,2 \pi)}^{2} \tag{5.11}
\end{equation*}
$$

Step 3 (energy estimate on first derivative independent of $m$ ): We now apply the operator $L_{\theta}$ to the sequence $\left(f_{m}\right)_{m \in \mathbb{N}}$. Note that, for a.e. $t \in(0, T)$,

$$
\left\|L_{\theta} f_{m}(t)\right\|_{H^{1}(\Upsilon)}^{2}=\left\|L_{\theta} f_{m}(t)\right\|_{L^{2}(\Upsilon)}^{2}+\left\|\nabla L_{\theta} f_{m}(t)\right\|_{L^{2}(\Upsilon)}^{2}+\left\|\partial_{\theta} L_{\theta} f_{m}(t)\right\|_{L^{2}(\Upsilon)}^{2}
$$

It then follows from (5.9) and (5.10) that

$$
\begin{aligned}
\left\|L_{\theta} f_{m}(t)\right\|_{H^{1}(\Upsilon)}^{2} \leq & \int_{\Omega}\left\|L_{\theta} f_{m}(t, \mathbf{x}, \cdot)\right\|_{L^{2}(0,2 \pi)}^{2} \mathrm{~d} \mathbf{x}+\int_{\Omega}\left\|\nabla L_{\theta} f_{m}(t, \mathbf{x}, \cdot)\right\|_{L^{2}(0,2 \pi)}^{2} \mathrm{~d} \mathbf{x} \\
& +\int_{\Omega}\left\|\partial_{\theta} L_{\theta} f_{m}(t, \mathbf{x}, \cdot)\right\|_{L^{2}(0,2 \pi)}^{2} \mathrm{~d} \mathbf{x} \\
\leq & 2 C_{P} \int_{\Omega}\left(\left\|f_{m}(t, \mathbf{x}, \cdot)\right\|_{L^{2}(0,2 \pi)}^{2}+\left\|\nabla f_{m}(t, \mathbf{x}, \cdot)\right\|_{L^{2}(0,2 \pi)}^{2}\right) \mathrm{d} \mathbf{x} .
\end{aligned}
$$

Thus, $\left\|L_{\theta} f_{m}(t)\right\|_{H^{1}(\Upsilon)}^{2} \leq 2 C_{P}\left\|f_{m}\right\|_{H^{1}(\Upsilon)}^{2}<+\infty$. Therefore, $L_{\theta} f_{m}(t)$ is an admissible test function for the weak formulation of Definition 2.2. This latter observation enables us to test the equation with $L_{\theta} f_{m}$ and to obtain an estimate independent of $m$. We get, for a.e. $(t, \mathbf{x}) \in(0, T) \times \Omega$,

\begin{aligned}
\frac{1}{2} \frac{d}{d t}\left\|f_{m}(t, \mathbf{x}, \cdot)\right\|_{\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)}^{2} & =\frac{1}{2} \frac{d}{d t}\left\|\partial_{\theta} L_{\theta} f_{m}(t, \mathbf{x}, \cdot)\right\|_{L^{2}(0,2 \pi)}^{2} \\
& =\left\langle\partial_{t} f_{m}(t, \mathbf{x}, \cdot), L_{\theta} f_{m}(t, \mathbf{x}, \cdot)\right\rangle_{\left(H^{1}\right)^{\prime} \times H^{1}}
\end{aligned}
$$

where we used that $\partial_{t} f \in L^{2}\left([0, T] ;\left(H_{p e r}^{1}\right)^{\prime}(\Upsilon)\right)$ and $L_{\theta} f_{m} \in L^{2}\left([0, T] ; H_{p e r}^{1}(\Upsilon)\right)$. Hence, by integrating the previous line with respect to the space variable and using the weak formulation, also noting that $\left\langle\nabla f_{m}, \nabla L_{\theta} f_{m}\right\rangle_{\Upsilon}=\left\|\nabla \partial_{\theta} L_{\theta} f_{m}\right\|_{L^{2}(\Upsilon)}^{2}$ and
$\left\langle\partial_{\theta} f_{m}, \partial_{\theta} L_{\theta} f_{m}\right\rangle_{\Upsilon}=\left\|f_{m}\right\|_{L^{2}(\Upsilon)}^{2}$,

$$
\begin{align*}
\frac{1}{2} \frac{d}{d t}\left\|f_{m}(t)\right\|_{L^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)}^{2}=\operatorname{Pe}\langle(1 & \left.\left.-\rho_{m}\right) f_{m} \mathbf{e}(\theta), \nabla L_{\theta} f_{m}\right\rangle \Upsilon  \tag{5.12}\\
& \quad-\left\|\nabla \partial_{\theta} L_{\theta} f_{m}\right\|_{L^{2}(\Upsilon)}^{2}-\left\|f_{m}\right\|_{L^{2}(\Upsilon)}^{2}
\end{align*}
$$

where we used the equality $\left(-\partial_{\theta}^{2}\right) L_{\theta} f_{m}=f_{m}$, integrated by parts in $\theta$ the last two duality products, and used the Dirichlet problem (5.7). Next, observe that $f_{m} \mathbf{e}(\theta)=$ $\left(-\partial_{\theta}^{2}\right) L_{\theta} f_{m} \mathbf{e}(\theta)=-\partial_{\theta}\left(\partial_{\theta} L_{\theta} f_{m} \mathbf{e}(\theta)\right)-\partial_{\theta} L_{\theta} f_{m} \mathbf{e}^{\perp}(\theta)$, where $\mathbf{e}^{\perp}(\theta)=(-\sin \theta, \cos \theta)$. Using the fact that $\rho_{m}$ is independent of the angle variable, it follows from an integration by parts that

\left\langle\left(1-\rho_{m}\right) f_{m} \mathbf{e}(\theta), \nabla L_{\theta} f_{m}\right\rangle_{\Upsilon}=\left\langle\left(1-\rho_{m}\right)\right. & \left.\partial_{\theta} L_{\theta} f_{m} \mathbf{e}(\theta), \nabla \partial_{\theta} L_{\theta} f_{m}\right\rangle_{\Upsilon} \\
& -\left\langle\left(1-\rho_{m}\right) \partial_{\theta} L_{\theta} f_{m} \mathbf{e}^{\perp}(\theta), \nabla L_{\theta} f_{m}\right\rangle_{\Upsilon}
\end{aligned}
$$

whence the Hölder inequality and the bound for $\rho_{m}$ give $\left|\left\langle\left(1-\rho_{m}\right) f_{m} \mathbf{e}(\theta), \nabla L_{\theta} f_{m}\right\rangle_{\Upsilon}\right| \leq$ $\left\|\partial_{\theta} L_{\theta} f_{m}\right\|_{L^{2}(\Upsilon)}\left\|\nabla \partial_{\theta} L_{\theta} f_{m}\right\|_{L^{2}(\Upsilon)}+\left\|\partial_{\theta} L_{\theta} f_{m}\right\|_{L^{2}(\Upsilon)}\left\|\nabla L_{\theta} f_{m}\right\|_{L^{2}(\Upsilon)}$. Thus, by applying the Poincaré inequality (5.9) to bound $\nabla L_{\theta} f_{m}$ by $\nabla \partial_{\theta} L_{\theta} f_{m}$ and Young's inequality,

\left|\left\langle\left(1-\rho_{m}\right) f_{m} \mathbf{e}(\theta), \nabla L_{\theta} f_{m}\right\rangle_{\Upsilon}\right| \leq \operatorname{Pe}\left(1+C_{P}\right)\left\|\partial_{\theta} L_{\theta} f_{m}\right\|_{L^{2}(\Upsilon)}^{2}+\frac{1}{2 \operatorname{Pe}}\left\|\partial_{\theta} \nabla L_{\theta} f_{m}\right\|_{L^{2}(\Upsilon)}^{2}
$$

Combining the above with (5.12), using (5.11) to rewrite $\left\|\nabla \partial_{\theta} L_{\theta} f_{m}\right\|_{L^{2}(\Upsilon)}^{2}$ and (5.8) to rewrite $\left\|\partial_{\theta} L_{\theta} f_{m}\right\|_{L^{2}(\Upsilon)}^{2}$, and integrating in time, we get, for a.e. $t \in(0, T)$,

$$
\begin{gathered}
\left\|f_{m}(t)\right\|_{L^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)}^{2}+\int_{0}^{t}\left\|\nabla f_{m}(\tau)\right\|_{L^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)}^{2} \mathrm{~d} \tau+2 \int_{0}^{t}\left\|f_{m}(\tau)\right\|_{L^{2}(\Upsilon)}^{2} \mathrm{~d} \tau \\
\leq\left\|f_{0}^{m}\right\|_{L^{2}\left(\Omega ;\left(H_{p e r}\right)^{\prime}(0,2 \pi)\right)}^{2}+\operatorname{Pe}^{2}\left(1+C_{P}\right) \int_{0}^{t}\left\|f_{m}(\tau)\right\|_{L^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)}^{2} \mathrm{~d} \tau
\end{gathered}
$$

Grönwall's Lemma yields $\left\|f_{m}(t)\right\|_{L^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)}^{2} \leq M^{2} \exp \left(\operatorname{Pe}^{2}\left(1+C_{P}\right) T\right)$ a.e. $t \in$ $(0, T)$, and we recall from (5.6) that the right-hand side is independent of $m$. Hence, we obtain, for some positive constant $M_{1}$ independent of $m$,

\operatorname{esssup}_{t \in[0, T]}\left\|f_{m}(t)\right\|_{L^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)}^{2} & +\int_{0}^{T}\left\|\nabla f_{m}(t)\right\|_{L^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)}^{2} \mathrm{~d} t  \tag{5.13}\\
& +\int_{0}^{T}\left\|f_{m}(t)\right\|_{L^{2}(\Upsilon)}^{2} \mathrm{~d} t \leq M_{1}
\end{align*}
$$

Thus, $\left\|f_{m}\right\|_{L^{\infty}\left([0, T] ; L^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)\right)},\left\|f_{m}\right\|_{L^{2}\left([0, T] ; H^{1}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)\right)},\left\|f_{m}\right\|_{L^{2}((0, T) \times \Upsilon)}$ are bounded independently of $m$.

Step 4 (corresponding estimate on the time derivatives): We now return to (1.2) in order to obtain a similar uniform estimate on the sequence of time derivatives $\left(\partial_{t} f_{m}\right)_{m \in \mathbb{N}}$. Fix $\varphi$ to be smooth and periodic on $\bar{\Upsilon}$. Such a function is an admissible test function for the weak formulation of the equation, and we get

\leq & \operatorname{Pe}\left\|f_{m}\right\|_{L^{2}(\Upsilon)}\|\nabla \varphi\|_{L^{2}(\Upsilon)}+\left\|f_{m}\right\|_{L^{2}(\Upsilon)}\left\|\partial_{\theta}^{2} \varphi\right\|_{L^{2}(\Upsilon)} \\
& +\left\|\nabla f_{m}\right\|_{L^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)}\|\nabla \varphi\|_{L^{2}\left(\Omega ; H^{1}(0,2 \pi)\right)} \\
\leq & \left((1+\operatorname{Pe})\left\|f_{m}(t)\right\|_{L^{2}(\Upsilon)}+\left\|\nabla f_{m}(t)\right\|_{L^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)}\right)\left(\|\varphi\|_{H^{1}(\Upsilon)}\right. \\
& \left.+\|\varphi\|_{L^{2}\left(\Omega ; H^{2}(0,2 \pi)\right)}\right)
\end{aligned}
$$

for a.e. $t \in(0, T)$. We therefore obtain, using (5.2) and (5.2), $\left\|\partial_{t} f_{m}(t)\right\|_{Y^{\prime}} \leq((1+$ $\left.\mathrm{Pe})\left\|f_{m}(t)\right\|_{L^{2}(\Upsilon)}+\left\|\nabla f_{m}(t)\right\|_{L^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)}\right)$, whence, using (5.13) to bound the right-hand side of the above, we get, with $M_{2}$ a positive constant independent of $m$,

Step 5 (estimates on $\rho$ independent of $m$ ): We infer uniform estimates on the sequence $\left(\rho_{m}\right)_{m \in \mathbb{N}}$ from those on $\left(f_{m}\right)_{m \in \mathbb{N}}$. Firstly, $\rho_{m}(t, \mathbf{x})=\int_{0}^{2 \pi} f_{m}(t, \mathbf{x}, \theta) \mathrm{d} \theta$ for a.e. $(t, \mathbf{x}) \in(0, T) \times \Omega$, from which it is easy to see, since the constant function $1 / 2 \pi$ belongs to $H_{p e r}^{1}(0,2 \pi)$ and has norm equal to 1 therein,

\left|\rho_{m}(t, \mathbf{x})\right| \leq 2 \pi \sup _{\|\varphi\|_{H_{p e r}^{1}(0,2 \pi)} \leq 1}\left|\int_{0}^{2 \pi} f_{m}(t, \mathbf{x}, \theta) \varphi(\theta) \mathrm{d} \theta\right|=2 \pi\left\|f_{m}(t, \mathbf{x}, \cdot)\right\|_{\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)} \tag{5.15}
\end{equation*}
$$

for a.e. $(t, \mathbf{x}) \in(0, T) \times \Omega$. The same estimate on the derivative yields $\left|\nabla \rho_{m}(t, \mathbf{x})\right| \leq$ $2 \pi\left\|\nabla f_{m}(t, \mathbf{x}, \cdot)\right\|_{\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)}$ a.e. in $(0, T) \times \Omega$. It follows directly from the comment under the uniform estimate (5.13) that there holds

\end{equation*}

for some $M_{3}$ independent of $m$. Finally, for the time derivatives, by returning to the weak formulation of (1.3) and arguing as we did to obtain (5.14), we obtain

whence $\left\|\partial_{t} \rho_{m}(t)\right\|_{\left(H_{p e r}^{1}\right)^{\prime}(\Omega)} \leq \operatorname{Pe}|\Omega|^{1 / 2}+\left\|\nabla \rho_{m}(t)\right\|_{L^{2}(\Omega)}$ for a.e. $t \in(0, T)$. As a result, we deduce from (5.16) the uniform estimate

for some positive constant $M_{4}$ also independent of $m$.
Step 6 (compactness and passage to the limit in $m$ ): Due to the uniform estimate $\sup _{m}\left\|f_{m}\right\|_{L^{2}((0, T) \times \Upsilon)}<+\infty$ deduced under (5.13), we have from the Banach-Alaoglu Theorem that there exists $f \in L^{2}((0, T) \times \Upsilon)$ such that

up to a subsequence, which, with slight abuse of notation, we still label as $\left(f_{m}\right)_{m \in \mathbb{N}}$. In turn, there holds $\rho_{m} \rightharpoonup \rho$ weakly in $L^{2}((0, T) \times \Omega)$, where $\rho(t, \mathbf{x})=\int_{0}^{2 \pi} f(t, \mathbf{x}, \theta) \mathrm{d} \theta$ for a.e. $(t, \mathbf{x}) \in(0, T) \times \Omega$. Meanwhile, given the estimates (5.16) and (5.17), the Aubin-Lions Lemma implies the strong convergence

The term $\left(1-\rho_{m}\right) f_{m}$ is therefore the product of a strongly converging sequence and a weakly converging sequence in $L^{2}((0, T) \times \Omega)$. We are therefore able to pass to the limit weakly in $L^{2}((0, T) \times \Omega)$ in the nonlinear drift term.

Additionally, taking further subsequences if necessary, the remaining uniform estimates from (5.13) and (5.14), as well as the Banach-Alaoglu Theorem, imply the convergences $\partial_{t} f_{m} \stackrel{*}{\rightharpoonup} \partial_{t} f$ in $X^{\prime}, \nabla f_{m} \stackrel{*}{\rightharpoonup} \nabla f$ in $L^{2}\left([0, T] ; L^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)\right)$, which proves the convergence of the relevant duality products to the limit equation.

For the last duality product, we use an integration by parts to write $\left\langle\partial_{\theta} f_{m}, \partial_{\theta} \varphi\right\rangle_{\Upsilon}=$ $-\left\langle f_{m}, \partial_{\theta}^{2} \varphi\right\rangle_{\Upsilon} \rightarrow\left\langle f, \partial_{\theta}^{2} \varphi\right\rangle_{\Upsilon}$ as $m \rightarrow \infty$, where we used the weak convergence $f_{m} \rightharpoonup f$ in $L^{2}((0, T) \times \Upsilon)$. Since the test function $\varphi$ is chosen to belong to the space $X$, we obtain the limit equation as $m \rightarrow \infty$, as required.

Step 7 (initial data): Recalling also the discussion under Definition 5.1, the estimates (5.13) and (5.14) imply that $f_{m}, f \in H^{1}\left([0, T] ; Y^{\prime}\right)$. By [10, Sec. 5.9.2 Th. 2], $f_{m}, f \in C\left([0, T] ; Y^{\prime}\right)$. Recall from (5.5) $\left\|f_{0}-f_{0}^{m}\right\|_{L^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)} \rightarrow 0$, from which $\left\|f_{0}-f_{0}^{m}\right\|_{Y^{\prime}} \rightarrow 0$; since $L^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right) \hookrightarrow Y^{\prime}$ continuously. From (5.13), $\left(f_{m}\right)_{m \in \mathbb{N}}$ is bounded in $L^{2}\left([0, T] ; L_{p e r}^{2}(\Upsilon)\right)$. Using the Rellich-Kondrachov Compactness Embedding and properties of the adjoint map, $L_{\text {per }}^{2}(\Upsilon)$ embeds compactly into $Y^{\prime}$; since $Y \hookrightarrow H_{p e r}^{1}(\Upsilon)$ continuously, and $H_{p e r}^{1}(\Upsilon)$ is compactly embedded in $L_{\text {per }}^{2}(\Upsilon)$. Meanwhile, the sequence $\left(\partial_{t} f_{m}\right)_{m \in \mathbb{N}}$ is uniformly bounded in $X^{\prime}=L^{2}\left([0, T] ; Y^{\prime}\right)$. Thus the Aubin-Lions Lemma implies $f_{m} \rightarrow f$ strongly in $X^{\prime}$, and hence, up to taking a further subsequence, $f_{m}(t) \rightarrow f(t)$ strongly in $Y^{\prime}$ a.e. $t \in[0, T]$. Uniqueness of limits in $Y^{\prime}$ at the Lebesgue point $t=0$ implies $f(0)=f_{0}$ in $Y^{\prime}$.

Appendix A. The system of ODEs for the Galerkin approximation in space. Throughout this section, $m \in \mathbb{N}$ is fixed. For $k \in\{0, \ldots, n\}$, we define

where $\left\{\alpha_{j, p, q}^{k, m}, \beta_{j, p, q}^{k, m}\right\}$ are chosen to be the solutions of a specific ODE system.
Recall that the products of sines and cosines form an orthogonal basis of $L_{\text {per }}^{2}(\Omega)$, which motivates the approximations (A.1). Our aim is to recover the coefficients $\left\{a_{k}, b_{k}\right\}_{k=0}^{n}$ as the limits as $m \rightarrow \infty$ of the coefficients defined in (A.1). To do so, we impose that $\left\{a_{k}^{n, m}, b_{k}^{n, m}\right\}$ solve (3.7) weakly (i.e. in duality with $\left.H_{p e r}^{1}(\Omega)\right)$ and with initial data $\left\{a_{k}^{n, m}(0), b_{k}^{n, m}(0)\right\}$ computed by testing $\left\{a_{k}^{0}, b_{k}^{0}\right\}$ with products of sines and cosines up to frequencies $m$ inclusive and adding these contributions, i.e.,

where $C_{1, p, q}=\int_{\Omega} \cos p x \cos q y a_{k}^{0}(\mathbf{x}) \mathrm{d} \mathbf{x}, C_{2, p, q}=\int_{\Omega} \cos p x \sin q y a_{k}^{0}(\mathbf{x}) \mathrm{d} \mathbf{x}, C_{3, p, q}=$ $\int_{\Omega} \sin p x \cos q y a_{k}^{0}(\mathbf{x}) \mathrm{d} \mathbf{x}$, and $C_{4, p, q}=\int_{\Omega} \sin p x \sin q y a_{k}^{0}(\mathbf{x}) \mathrm{dx}$ (up to multiples of $2 \pi$ ). The expression for $b_{k, m}^{0}$ is similar. By construction, $\left(a_{k, m}^{0}, b_{k, m}^{0}\right) \rightarrow\left(a_{k}^{0} b_{k}^{0}\right)$ strongly in $L^{2}(\Omega)$ as $m \rightarrow \infty$.

By substituting appropriate test functions into the aforementioned weak formulations for $a_{k}^{n, m}$ and $b_{k}^{n, m}$, we obtain a system of ODEs with $\alpha_{j, p, q}^{k, m}, \beta_{j, p, q}^{k, m}$ as the unkowns.

Testing against $\varphi=1$ in the equation for $a_{0}^{m}$ in (3.7) we find $4 \pi^{2} \frac{d \alpha_{1,0,0}^{0, m}}{d t}(t)=0$, whence $\alpha_{1,0,0}^{0, m}(t)=\alpha_{1,0,0}^{0, m}(0)$ for all $t \in[0, T]$. Moreover, testing against $\varphi=1$ in the equations for $a_{1}^{m}$ and $b_{1}^{m}$ in (3.7), we obtain $4 \pi^{2} \frac{d \alpha_{1,0,0}^{k, m}}{d t}(t)=-4 \pi^{2} k^{2} \alpha_{1,0,0}^{k, m}(t)$, $4 \pi^{2} \frac{d \beta_{1,0,0}^{k, m}}{d t}(t)=-4 \pi^{2} k^{2} \beta_{1,0,0}^{k, m}(t)$ for $k \in\{1, \ldots, n\}$. All coefficients $\left\{\alpha_{1,0,0}^{k, m}, \beta_{1,0,0}^{k, m}\right\}_{k=0}^{n}$ are therefore determined.

Then, testing the equations for $a_{k}^{n, m}, b_{k}^{n, m}$ in (3.7) with $\varphi=\cos p x$ for $p \in$ $\{1, \ldots, m\}$, we get

The ODEs for the coefficients $\left\{\alpha_{3, p, 0}^{k, m}, \beta_{3, p, 0}^{k, m}\right\}_{k=0}^{n}$ are obtained similarly by testing the equations with $\varphi=\sin p x$ for $p \in\{1, \ldots, m\}$ and have a similar structure to those for $\left\{\alpha_{1, p, 0}^{k, m}, \alpha_{1, p, 0}^{k, m}\right\}_{k=0}^{n}$. The same is true for the ODEs for the coefficients $\left\{\alpha_{1,0, q}^{k, m}, \beta_{1,0, q}^{k, m}\right\}_{k=0}^{n}$ (obtained by testing (3.7) with $\varphi=\cos q y$ for $q \in\{1, \ldots, m\}$ ) and those for the coefficients $\left\{\alpha_{2,0, q}^{k, m}, \beta_{2,0, q}^{k, m}\right\}_{k=0}^{n}$ (obtained by testing (3.7) $\varphi=\sin q y$ for $q \in\{1, \ldots, m\}$ ).

Similarly, the ODEs for the coefficients $\left\{\alpha_{1, p, q}^{k, m}, \beta_{1, p, q}^{k, m}\right\}_{k=0}^{n}$ are obtained by testing
(3.7) with $\varphi=\cos p x \cos q y$ for $p, q \in\{1, \ldots, m\}$. In detail, we obtain

& \left\langle\left(1-\left(a_{0}^{m}\right)_{+}\right)_{+}\left(a_{k-1, m}+a_{k+1, m}, b_{k+1, m}-b_{k-1, m}\right),(-p \sin p x \cos q y,-q \sin q y \cos p x)\right\rangle_{\Omega}, \\
& \frac{2 \pi^{2}}{\mathrm{Pe}} \frac{d \beta_{1, p, q}^{k, m}}{d t}(t)+\frac{2 D_{e}}{\mathrm{Pe}}\left(p^{2}+q^{2}\right) \pi^{2} \beta_{1, p, q}^{k, m}(t)+\frac{2 \pi^{2}}{\mathrm{Pe}} k^{2} \beta_{1, p, q}^{k, m}(t)= \\
& \left\langle\left(1-\left(a_{0}^{m}\right)_{+}\right)_{+}\left(b_{k-1, m}+b_{k+1, m}, a_{k-1, m}-a_{k+1, m}\right),(-p \sin p x \cos q y,-q \sin q y \cos p x)\right\rangle_{\Omega},
\end{aligned}
$$

and

\begin{aligned}
& \pi^{2} \frac{d \alpha_{1, p, q}^{n, m}}{d t}(t)+D_{e}\left(p^{2}+q^{2}\right) \pi^{2} \alpha_{1, p, q}^{n, m}(t)+\pi^{2} n^{2} \alpha_{1, p, q}^{n, m}(t)= \\
& \frac{\mathrm{Pe}}{2}\left\langle\left(1-\left(a_{0}^{m}(t)\right)_{+}\right)_{+}\left(a_{n-1, m}(t),-b_{n-1, m}(t)\right),(-p \sin p x \cos q y,-q \sin q y \cos p x)\right\rangle_{\Omega} \\
& \pi^{2} \frac{d \beta_{1, p, q}^{n, m}}{d t}(t)+D_{e}\left(p^{2}+q^{2}\right) \pi^{2} \beta_{1, p, q}^{n, m}(t)+\pi^{2} n^{2} \beta_{1, p, q}^{n, m}(t)= \\
& \frac{\mathrm{Pe}}{2}\left\langle\left(1-\left(a_{0}^{m}(t)\right)_{+}\right)_{+}\left(b_{n-1, m}(t), a_{n-1, m}(t)\right),(-p \sin p x \cos q y,-q \sin q y \cos p x)\right\rangle_{\Omega}
\end{aligned}

The ODEs for the coefficients $\left\{\alpha_{3, p, q}^{k, m}, \beta_{3, p, q}^{k, m}\right\}_{k=0}^{n}$ are obtained similarly by testing the equations with $\varphi=\sin p x \cos q y$ for $p, q \in\{1, \ldots, m\}$, and have a similar structure to those of $\left\{\alpha_{1, p, q}^{n, m}, \beta_{1, p, q}^{n, m}\right\}_{k=0}^{n}$. The same is true for the ODEs for the coefficients $\left\{\alpha_{2, p, q}^{k, m}, \beta_{2, p, q}^{k, m}\right\}_{k=0}^{n}$ (obtained by testing the equations with $\varphi=\cos p x \sin q y$ for $p, q \in$ $\{1, \ldots, m\}$ ) and those for the coefficients $\left\{\alpha_{4, p, q}^{k, m}, \beta_{4, p, q}^{k, m}\right\}_{k=0}^{n}$ (obtained by testing the equations with $\varphi=\sin p x \sin q y$ for $p, q \in\{1, \ldots, m\})$.

As was already mentioned in Step 1 of subsection 3.2, the previous system may be rewritten in the form of (3.10), i.e. $\Lambda_{m}^{\prime}(t)=F\left(t, \Lambda_{m}(t)\right)$ for $t \in[0, T]$, with initial condition $\Lambda_{m}(0)=\Lambda_{m, 0}$, where $\Lambda_{m}=\left\{\alpha_{j, p, q}^{k, m}\right\}_{k, j, p, q}$ is the tensor of coefficients, with initial value $\Lambda_{m, 0}$, and $F$ is locally Lipschitz since the function $x \mapsto x_{+}^{2}$ is locally Lipschitz. The initial data is given by the explicit formulas

4 \pi^{2} \alpha_{1,0,0}^{0, m}(0)=\int_{\Omega} a_{0, m}^{0} \mathrm{~d} x \mathrm{~d} y, \quad 4 \pi^{2} \alpha_{1,0,0}^{k, m}(0)=\int_{\Omega} a_{k, m}^{0}(x, y) \mathrm{d} x \mathrm{~d} y \tag{A.3}
\end{equation*}
$$

where we recall the expression for $a_{k, m}^{0}$ in (A.2), and, for $p, q \in\{1, \ldots, m\}$,

\alpha_{1, p, 0}^{k, m}(0)=\int_{\Omega} \frac{a_{k, m}^{0}(x, y)}{2 \pi^{2}} \cos p x \mathrm{~d} x \mathrm{~d} y, & \alpha_{3, p, 0}^{k, m}(0)=\int_{\Omega} \frac{a_{k, m}^{0}(x, y)}{2 \pi^{2}} \sin p x \mathrm{~d} x \mathrm{~d} y  \tag{A.4}\\
\alpha_{1,0, q}^{k, m}(0)=\int_{\Omega} \frac{a_{k, m}^{0}(x, y)}{2 \pi^{2}} \cos q y \mathrm{~d} x \mathrm{~d} y, & \alpha_{2,0, q}^{k, m}(0)=\int_{\Omega} \frac{a_{k, m}^{0}(x, y)}{2 \pi^{2}} \sin q y \mathrm{~d} x \mathrm{~d} y \\
\alpha_{1, p, q}^{k, m}(0)=\int_{\Omega} \frac{a_{k, m}^{0}(x, y)}{\pi^{2}} \cos p x \cos q y \mathrm{~d} x \mathrm{~d} y, & \alpha_{3, p, q}^{k, m}(0)=\int_{\Omega} \frac{a_{k, m}^{0}(x, y)}{\pi^{2}} \sin p x \cos q y \mathrm{~d} x \mathrm{~d} y, \\
\alpha_{2, p, q}^{k, m}(0)=\int_{\Omega} \frac{a_{k, m}^{0}(x, y)}{\pi^{2}} \cos p x \sin q y \mathrm{~d} x \mathrm{~d} y, & \alpha_{4, p, q}^{k, m}(0)=\int_{\Omega} \frac{a_{k, m}^{0}(x, y)}{\pi^{2}} \sin p x \sin q y \mathrm{~d} x \mathrm{~d} y,
\end{array}
$$

and the formulas for the coefficients $\left\{\beta_{i, p, q}^{k, m}\right\}_{i, p, q, k, m}$ are identical, with the exception that $b_{k, m}^{0}$ replaces $a_{k, m}^{0}$ on the right-hand sides of the previous equations. Note that the above are well-defined real numbers due to the integrability of the initial data $a_{k, m}^{0}, b_{k, m}^{0}$ which is inherited from the integrability of $f_{0} \in L_{p e r}^{2}(\Upsilon)$.

Appendix B. Properties of the periodic heat kernel. Below we provide proofs of Lemma 4.2 and Lemma 4.3, respectively.

Proof of Lemma 4.2. Step 1 (smoothness away from initial time): Begin by noting that, by a standard argument using the Weierstraß M-test, the series representation (4.1) for $\Phi$ is well-defined, and moreover can repeatedly be differentiated term-by-term for positive times. As such, $\Phi \in C^{\infty}((0, \infty) \times \mathbb{R})$, and $\partial_{t} \Phi(t, x)=$ $-\frac{1}{\pi} \sum_{n=1}^{\infty} n^{2} e^{-n^{2} t} \cos n x=\partial_{x x} \Phi(t, x)$ for all $(t, x) \in(0, \infty) \times \mathbb{R}$.

Step 2 (nonnegativity and $L^{1}$-norm): Recall (cf. [19, Section 21.3]) the infinite product representation for the Jacobi theta-3 function. For every $(t, x) \in(0, \infty) \times \mathbb{R}$,

$$
\Phi(t, x)=\frac{1}{2 \pi} \theta_{3}\left(\frac{x}{2}, e^{-t}\right)=\frac{1}{2 \pi} \prod_{n=1}^{\infty}\left(1-e^{-2 n t}\right)\left(1+2 e^{-t(2 n-1)} \cos x+e^{-t(4 n-2)}\right)
$$

By the Young inequality, $1+e^{-t(4 n-2)} \geq 2 e^{-t(2 n-1)}$, and hence every term in the above product is nonnegative. As such, $\Phi$ itself is nonnegative in $(0, \infty) \times \mathbb{R}$. Meanwhile, integrating the series term by term, we obtain $\int_{0}^{2 \pi} \Phi(t, x) \mathrm{d} x=1$ for every $t \in(0, \infty)$. It therefore follows that $\|\Phi(t, \cdot)\|_{L^{1}([0,2 \pi])}=\int_{0}^{2 \pi} \Phi(t, x) \mathrm{d} x=1$ for all $t \in(0, \infty)$. Also, the Plancherel Theorem yields $\|\Phi(t, \cdot)\|_{L^{2}([0,2 \pi])}^{2}=1+\sum_{n=1}^{\infty} e^{-2 n^{2} t}$. Integrating in time (using also $\sum n^{-2}<+\infty$ ) yields (4.3).

Step 3 (constant $L^{2}$-norm): Furthermore, given any $(t, x) \in(0, T] \times[0,2 \pi]$, successive changes of variables yield

\int_{0}^{t} \int_{0}^{2 \pi} \Phi(t-s, x-y)^{2} \mathrm{~d} y \mathrm{~d} s & =\int_{0}^{t} \int_{0}^{2 \pi} \Phi(\tau, x-y)^{2} \mathrm{~d} y \mathrm{~d} \tau \\
& =\int_{0}^{t} \int_{0}^{x} \Phi(\tau, w)^{2} \mathrm{~d} w \mathrm{~d} \tau+\int_{0}^{t} \int_{x-2 \pi}^{0} \Phi(\tau, w+2 \pi)^{2} \mathrm{~d} w \mathrm{~d} \tau \\
& =\int_{0}^{t} \int_{0}^{2 \pi} \Phi(\tau, w)^{2} \mathrm{~d} w \mathrm{~d} \tau
\end{aligned}
$$

as required, where we also used the periodicity of $\Phi$ to obtain the second equality.
Step 4 (convergence to initial data): It remains to verify the initial data. Fix any $2 \pi$-periodic $C^{2}$ function $\psi$. Then, the elementary theory of Fourier series shows that $\psi$
admits the Fourier representation $\psi(x)=\frac{1}{2 \pi} a_{0}+\frac{1}{\pi} \sum_{n=1}^{\infty} a_{n} \cos n x+\frac{1}{\pi} \sum_{n=1}^{\infty} b_{n} \sin n x$ a.e. $x \in \mathbb{R}$, where, for $n \in \mathbb{N}$,

\begin{equation*}
a_{0}=\int_{0}^{2 \pi} \psi(x) \mathrm{d} x, \quad a_{n}=\int_{0}^{2 \pi} \psi(x) \cos n x \mathrm{~d} x, \quad b_{n}=\int_{0}^{2 \pi} \psi(x) \sin n x \mathrm{~d} x \tag{B.1}
\end{equation*}
$$

Note that, due to the $C^{2}$-regularity of $\psi$ and its periodicity, two consecutive integration by parts yields $a_{n}=-\frac{1}{n^{2}} \int_{0}^{2 \pi} \psi^{\prime \prime}(x) \cos n x \mathrm{~d} x$ and $b_{n}=-\frac{1}{n^{2}} \int_{0}^{2 \pi} \psi^{\prime \prime}(x) \sin n x \mathrm{~d} x$ so that there exists a positive constant $C_{\psi}$ depending on $\psi$ alone such that

$$
\begin{equation*}
\left|a_{n}\right|+\left|b_{n}\right| \leq C_{\psi} n^{-2} \quad \forall n \in \mathbb{N} \tag{B.2}
\end{equation*}
$$

Hence, $\left|\psi(0)-\int_{0}^{2 \pi} \Phi(t, x) \psi(x) \mathrm{d} x\right|=\frac{1}{\pi}\left|\sum_{n=1}^{\infty}\left(1-e^{-n^{2} t}\right) a_{n}\right| \leq \frac{C_{\psi}}{\pi} \sum_{n=1}^{\infty} n^{-2}(1-$ $e^{-n^{2} t}$ ), and, by the Dominated Convergence Theorem applied to the atomic measure (using that $\sum n^{-2}<+\infty$ ), the right-hand side vanishes in the limit as $t \rightarrow 0^{+}$.

Proof of Lemma 4.3. Recall from Lemma 4.2 that $\Phi \in C^{\infty}((0, \infty) \times \mathbb{R})$. Since $\psi \in L^{1}([0,2 \pi])$, an application of the Dominated Convergence Theorem shows that $\Psi \in C^{\infty}((0, \infty) \times \mathbb{R})$, and that for any $m, n \in \mathbb{N} \cup\{0\}$, there holds $\partial_{t}^{(m)} \partial_{x}^{(n)} \Psi(t, x)=$ $\int_{0}^{2 \pi} \partial_{t}^{(m)} \partial_{x}^{(n)} \Phi(t, x-y) \psi(y) \mathrm{d} y$ for all $(t, x) \in(0, \infty) \times \mathbb{R}$. In turn, we directly obtain that $\partial_{t} \Psi-\partial_{x x} \Psi=0$ pointwise in $(0, \infty) \times \mathbb{R}$.

It remains to verify the initial condition. Suppose for the time being that $\psi$ is smooth enough, say $\psi \in C_{p e r}^{2}([0,2 \pi])$. From the Fourier series decomposition (B.1) for $\psi$ we compute, using the Fubini-Tonelli Theorem (or directly using the convolution result for Fourier series), the Fourier coefficients of $\Psi$ :

\tilde{a}_{0}(t)=a_{0}, \quad \tilde{a}_{n}(t)=e^{-n^{2} t} a_{n}, \quad \tilde{b}_{n}(t)=e^{-n^{2} t} b_{n} \quad \text { for } n \in \mathbb{N} \tag{B.3}
\end{equation*}
$$

Using the Plancherel Theorem for Fourier series of square integrable functions we get (up to a multiplicative constant)

$$
\begin{equation*}
\|\Psi(t, \cdot)-\psi\|_{L^{2}([0,2 \pi])}^{2}=\sum_{n=1}^{\infty}\left(1-e^{-n^{2} t}\right)^{2}\left(a_{n}^{2}+b_{n}^{2}\right) \rightarrow 0 \quad \text { as } t \rightarrow 0^{+} \tag{B.4}
\end{equation*}
$$

where we used the decay estimate (B.2) and the Dominated Convergence Theorem applied to the atomic measure.

When $\psi$ is only $L_{p e r}^{1}([0,2 \pi])$, we consider $\left\{\psi_{m}\right\}_{m \in \mathbb{N}}$ a sequence in $C_{p e r}^{2}([0,2 \pi])$ approximating $\psi$ in $L^{1}([0,2 \pi])$. Then, given any $\varepsilon>0$, there exists $N(\varepsilon) \in \mathbb{N}$ such that $\left\|\psi-\psi_{m}\right\|_{L^{1}([0,2 \pi])}<\varepsilon / 3 \forall m \geq N(\varepsilon)$. We then have

$$
\begin{aligned}
\|\Psi(t, \cdot)-\psi\|_{L^{1}([0,2 \pi])} \leq\left\|\Psi(t, \cdot)-\Psi_{m}(t, \cdot)\right\|_{L^{1}([0,2 \pi])} & +\left\|\Psi_{m}(t, \cdot)-\psi_{m}\right\|_{L^{1}([0,2 \pi])} \\
& +\left\|\psi_{m}-\psi\right\|_{L^{1}([0,2 \pi])}
\end{aligned}
$$

where $\Psi_{m}=\int_{0}^{2 \pi} \Phi(t, x-y) \psi_{m}(y) \mathrm{d} y$. Note that the second term in the previous expression vanishes in the limit as $t \rightarrow 0^{+}$by the argument in the previous paragraph. Next, using the Fubini-Tonelli Theorem to exchange the order of the integrals, $\left\|\Psi(t, \cdot)-\Psi_{m}(t, \cdot)\right\|_{L^{1}([0,2 \pi])} \leq\|\Phi(t, \cdot)\|_{L^{1}([0,2 \pi])}\left\|\psi-\psi_{m}\right\|_{L^{1}([0,2 \pi])}=\left\|\psi-\psi_{m}\right\|_{L^{1}([0,2 \pi])}$, where we used from Lemma 4.2 that $\|\Phi(t, \cdot)\|_{L^{1}([0,2 \pi])}=1$ for every $t \in(0, \infty)$. It follows that $\|\Psi(t, \cdot)-\psi\|_{L^{1}([0,2 \pi])}<2 \varepsilon / 3+\left\|\Psi_{m}-\psi_{m}\right\|_{L^{1}([0,2 \pi])}$ for all $m \geq N(\varepsilon)$. Thus, having fixed $m$ large enough, by now letting $t \rightarrow 0^{+}$and using the result from the previous paragraph, we get $\|\Psi(t, \cdot)-\psi\|_{L^{1}([0,2 \pi])}$ vanishes in the limit as $t \rightarrow 0^{+} . \square$

## Appendix C. Approximation Lemma.

Lemma C.1. Let $f \in L_{\text {per }}^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)$ be nonnegative and such that $\rho(\mathbf{x}):=$ $\langle f(\mathbf{x}, \cdot), 1\rangle_{\left(H_{\text {per }}^{1}\right)^{\prime} \times H_{p e r}^{1}} \in[0,1]$ for a.e. $\mathbf{x} \in \Omega$. There exists a sequence $\left(f_{\varepsilon}\right)_{\varepsilon>0}$ of nonnegative elements of $C_{p e r}^{\infty}(\bar{\Upsilon})$ such that

$$
\begin{equation*}
\left\|f-f_{\varepsilon}\right\|_{L_{p e r}^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)} \rightarrow 0 \quad \text { as } \varepsilon \rightarrow 0 \tag{C.1}
\end{equation*}
$$

with $\rho_{\varepsilon}(\mathbf{x})=\int_{0}^{2 \pi} f_{\varepsilon}(\mathbf{x}, \theta) \mathrm{d} \theta \in[0,1]$ for a.e. $\mathbf{x} \in \Omega$.
Proof. Step 1 (defining the approximation): Let $\beta \in C_{c}^{\infty}\left(\mathbb{R}^{2}\right)$ and $\gamma \in C_{c}^{\infty}(\mathbb{R})$ be nonnegative smooth bump functions, chosen such that $\beta$ is compactly supported inside $\Omega$ and $\gamma$ is compactly supported inside the interval $[0,2 \pi)$, and without loss of generality

$$
\begin{equation*}
\left(\int_{\Omega} \beta(\mathbf{y}) \mathrm{d} \mathbf{y}\right)\left(\int_{0}^{2 \pi} \gamma(\theta) \mathrm{d} \theta\right)=1 \tag{C.2}
\end{equation*}
$$

Moreover, we impose that $\beta$ is radially symmetric about the point $(\pi, \pi)$ and that $\gamma$ is symmetric about the point $\pi$. Consider the associated sequences $\left(\beta_{\varepsilon}\right)_{\varepsilon>0}$ and $\left(\gamma_{\varepsilon}\right)_{\varepsilon>0}$

$$
\beta_{\varepsilon}(\mathbf{x}):=\varepsilon^{-2} \beta(\mathbf{x} / \varepsilon), \quad \gamma_{\varepsilon}(\theta):=\varepsilon^{-\alpha} \gamma\left(\theta / \varepsilon^{\alpha}\right)
$$

for $\alpha>2$. These functions are smooth and nonnegative, and $\beta_{\varepsilon}$ is compactly supported in the square $\varepsilon \Omega$ while $\gamma_{\varepsilon}$ is compactly supported in $\left[0,2 \pi \varepsilon^{\alpha}\right]$. We define $\tilde{\gamma}_{\varepsilon}$ to be the $2 \pi$-periodic extension of $\gamma_{\varepsilon}$ from $\left[0,2 \pi \varepsilon^{\alpha}\right]$ to all of $\mathbb{R}$, so that $\tilde{\gamma}_{\varepsilon} \in H_{p e r}^{1}(0,2 \pi)$. Similarly, we define $\tilde{\beta}_{\varepsilon}$ to be the $\Omega$-periodic extension of $\beta_{\varepsilon}$ to all of $\mathbb{R}^{2}$.

In turn, we define the sequence of approximations $\left(f_{\varepsilon}\right)_{\varepsilon>0}$ by the explicit formula

$$
f_{\varepsilon}(\mathbf{x}, \theta):=\int_{\Omega} \tilde{\beta}_{\varepsilon}(\mathbf{x}-\mathbf{y})\left\langle f(\mathbf{y}, \cdot), \tilde{\gamma}_{\varepsilon}(\theta-\cdot)\right\rangle \mathrm{d} \mathbf{y} \quad \text { a.e. }(\mathbf{x}, \theta) \in \Upsilon
$$

where, throughout the rest of this proof, the duality product is understood to be in the angle variable only, and denotes the duality product of $H_{p e r}^{1}(0,2 \pi)$.

Observe firstly that, due to the assumption that $f$ is nonnegative, we immediately have $f_{\varepsilon}$ nonnegative a.e. in $\Upsilon$. Moreover, one may readily check (for instance by means of difference quotients) that $f_{\varepsilon}$ is smooth. Similarly, it is straightforward to verify that $f_{\varepsilon}$ is itself $\Upsilon$-periodic. Thus, $f_{\varepsilon} \in C_{p e r}^{\infty}(\bar{\Upsilon})$ for every $\varepsilon>0$.

Step 2 (boundedness the approximate density): Note that, in view of the aforementioned nonnegativity of $f_{\varepsilon}$, there holds the inequality $0 \leq \int_{0}^{2 \pi} f_{\varepsilon}(\mathbf{x}, \theta) \mathrm{d} \theta=\rho_{\varepsilon}(\mathbf{x})$. Additionally, we have $\rho_{\varepsilon}(\mathbf{x})=\int_{0}^{2 \pi}\left(\int_{\Omega} \tilde{\beta}_{\varepsilon}(\mathbf{x}-\mathbf{y})\left\langle f(\mathbf{y}, \cdot), \tilde{\gamma}_{\varepsilon}(\theta-\cdot)\right\rangle \mathrm{d} \mathbf{y}\right) \mathrm{d} \theta$, and a standard argument involving Riemann sums and the Arzelà-Ascoli Theorem (using also the Fubini-Tonelli Theorem and the Dominated Convergence Theorem) leads to being able to commute the duality bracket with the integral in the angle variable, i.e.,

\rho_{\varepsilon}(\mathbf{x})=\int_{\Omega} \tilde{\beta}_{\varepsilon}(\mathbf{x}-\mathbf{y})\left\langle f(\mathbf{y}, \cdot), \int_{0}^{2 \pi} \tilde{\gamma}_{\varepsilon}(\theta-\cdot) \mathrm{d} \theta\right\rangle \mathrm{d} \mathbf{y} \tag{C.3}
\end{equation*}
$$

Observe now that the integral inside the duality bracket is a constant. Indeed, since $\tilde{\gamma}_{\varepsilon}$ is smooth, and therefore bounded over any compact interval, the Dominated Convergence Theorem yields $\frac{d}{d s} \int_{0}^{2 \pi} \tilde{\gamma}_{\varepsilon}(\theta-s) \mathrm{d} \theta=-\int_{0}^{2 \pi} \tilde{\gamma}_{\varepsilon}^{\prime}(\theta-s) \mathrm{d} \theta=\tilde{\gamma}_{\varepsilon}(-s)-\tilde{\gamma}_{\varepsilon}(2 \pi-s)=$

0 , where the final equality follows from the periodicity of $\tilde{\gamma}_{\varepsilon}$; recall that it is the periodic extension to all of $\mathbb{R}$ of the original mollifier $\gamma_{\varepsilon}$. It follows that

\begin{equation*}
\int_{0}^{2 \pi} \tilde{\gamma}_{\varepsilon}(\theta-s) \mathrm{d} \theta=\int_{0}^{2 \pi} \tilde{\gamma}_{\varepsilon}(\theta) \mathrm{d} \theta=\int_{0}^{2 \pi} \gamma_{\varepsilon}(\theta) \mathrm{d} \theta=\int_{0}^{2 \pi} \gamma(\theta) \mathrm{d} \theta \quad \forall s \in \mathbb{R} \tag{C.4}
\end{equation*}
$$

where we recall in passing that $\gamma_{\varepsilon}$ is supported in $\left[0,2 \pi \varepsilon^{\alpha}\right]$, while $\gamma$ is supported in $[0,2 \pi]$. Hence, we get $\rho_{\varepsilon}(\mathbf{x})=\left(\int_{0}^{2 \pi} \gamma(\theta) \mathrm{d} \theta\right)\left(\int_{\Omega} \tilde{\beta}_{\varepsilon}(\mathbf{x}-\mathbf{y})\langle f(\mathbf{y}, \cdot), 1\rangle \mathrm{d} \mathbf{y}\right)$.

Also, applying the Dominated Convergence Theorem and the Fubini-Tonelli Theorem gives $\partial_{x_{1}} \int_{\Omega} \tilde{\beta}_{\varepsilon}(\mathbf{x}-\mathbf{y}) \mathrm{d} \mathbf{y}=\int_{0}^{2 \pi} \int_{0}^{2 \pi} \partial_{1} \tilde{\beta}_{\varepsilon}\left(x_{1}-y_{1}, x_{2}-y_{2}\right) \mathrm{d} y_{1} \mathrm{~d} y_{2}=-\int_{0}^{2 \pi}\left(\tilde{\beta}_{\varepsilon}\left(x_{1}-\right.\right.$ $\left.\left.2 \pi, x_{2}-y_{2}\right)-\tilde{\beta}_{\varepsilon}\left(x_{1}, x_{2}-y_{2}\right)\right) \mathrm{d} y_{2}=0$, where the final equality follows from the periodicity of $\tilde{\beta}_{\varepsilon}$; recall that this latter function is the $\Omega$-periodic extension of $\beta_{\varepsilon}$. An identical argument shows that $\partial_{x_{2}} \int_{\Omega} \tilde{\beta}_{\varepsilon}(\mathbf{x}-\mathbf{y}) \mathrm{d} \mathbf{y}=0$. Arguing as per (C.4) and making use of the symmetry property of $\beta$ about the point $(\pi, \pi)$, we deduce

$$
\begin{equation*}
\int_{\Omega} \tilde{\beta}_{\varepsilon}(\mathbf{x}-\mathbf{y}) \mathrm{d} \mathbf{y}=\int_{\Omega} \beta(\mathbf{y}) \mathrm{d} \mathbf{y} \quad \forall \mathbf{x} \in \mathbb{R}^{2} . \tag{C.5}
\end{equation*}
$$

We emphasise that the above property is not true for the function $\beta_{\varepsilon}$; one must take its periodic extension in order to obtain this translation invariance, since the integral ranges only over the square $\Omega$, and not over all of $\mathbb{R}^{2}$.

Returning to (C.3) and using that $\langle f(\mathbf{y}, \cdot), 1\rangle=\rho(\mathbf{y})$ which takes values in the interval $[0,1]$, it follows that $0 \leq \rho_{\varepsilon}(\mathbf{x}) \leq\left(\int_{0}^{2 \pi} \gamma(\theta) \mathrm{d} \theta\right)\left(\int_{\Omega} \tilde{\beta}_{\varepsilon}(\mathbf{x}-\mathbf{y}) \mathrm{d} \mathbf{y}\right)=$ $\left(\int_{0}^{2 \pi} \gamma(\theta) \mathrm{d} \theta\right)\left(\int_{\Omega} \beta(\mathbf{y}) \mathrm{d} \mathbf{y}\right)=1$, as required, where we used the nonnegativity of $\tilde{\beta}_{\varepsilon}$ in the second inequality and (C.2) to obtain the final equality.

Step 3 (convergence of approximations): We now study the convergence of the sequence $\left(f_{\varepsilon}\right)_{\varepsilon>0}$ in $L_{\text {per }}^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)$. Recall that

$$
\left\|f(\mathbf{x}, \cdot)-f_{\varepsilon}(\mathbf{x}, \cdot)\right\|_{\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)}=\sup _{\substack{\varphi \in C_{\text {Per }}^{\infty}(0,2 \pi) \\\|\varphi\|_{H^{1}(0,2 \pi)} \leq 1}}\left|\left\langle f(\mathbf{x}, \cdot)-f_{\varepsilon}(\mathbf{x}, \cdot), \varphi\right\rangle\right|
$$

for a.e. $\mathbf{x} \in \Omega$, where the duality product above is that of $\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)$. Note that, due to the regularity of $f_{\varepsilon}$, one may write explicitly
$\left\langle f(\mathbf{x}, \cdot)-f_{\varepsilon}(\mathbf{x}, \cdot), \varphi\right\rangle=\langle f(\mathbf{x}, \cdot), \varphi\rangle-\int_{0}^{2 \pi}\left(\int_{\Omega} \tilde{\beta}_{\varepsilon}(\mathbf{x}-\mathbf{y})\left\langle f(\mathbf{y}, \cdot), \tilde{\gamma}_{\varepsilon}(\theta-\cdot)\right\rangle \mathrm{d} \mathbf{y}\right) \varphi(\theta) \mathrm{d} \theta$.

Using also the Fubini-Tonelli Theorem and the Dominated Convergence Theorem, a standard argument involving Riemann sums and the Arzelà-Ascoli Theorem shows that this latter term is equal to $\int_{\Omega} \tilde{\beta}_{\varepsilon}(\mathbf{x}-\mathbf{y})\left\langle f(\mathbf{y}, \cdot), \int_{0}^{2 \pi} \tilde{\gamma}_{\varepsilon}(\theta-\cdot) \varphi(\theta) \mathrm{d} \theta\right\rangle \mathrm{d} \mathbf{y}$. Using the equalities in (C.2), (C.4), and (C.5), the first term on the right-hand side of (C.6) can be written as $\langle f(\mathbf{x}, \cdot), \varphi\rangle=\int_{\Omega} \tilde{\beta}_{\varepsilon}(\mathbf{x}-\mathbf{y})\left\langle f(\mathbf{x}, \cdot), \varphi(\cdot) \int_{0}^{2 \pi} \tilde{\gamma}_{\varepsilon}(\theta) \mathrm{d} \theta\right\rangle$ d $\mathbf{y}$ a.e. $\mathbf{x} \in \Omega$. It therefore follows from (C.6) that

$$
\begin{align*}
\left\langle f(\mathbf{x}, \cdot)-f_{\varepsilon}(\mathbf{x}, \cdot), \varphi\right\rangle & =\int_{\Omega} \tilde{\beta}_{\varepsilon}(\mathbf{x}-\mathbf{y})\left\langle f(\mathbf{x}, \cdot)-f(\mathbf{y}, \cdot), \varphi(\cdot) \int_{0}^{2 \pi} \tilde{\gamma}_{\varepsilon}(\theta) \mathrm{d} \theta\right\rangle \mathrm{d} \mathbf{y}  \tag{C.7}\\
& +\int_{\Omega} \tilde{\beta}_{\varepsilon}(\mathbf{x}-\mathbf{y})\left\langle f(\mathbf{y}, \cdot), \varphi(\cdot) \int_{0}^{2 \pi} \tilde{\gamma}_{\varepsilon}(\theta) \mathrm{d} \theta-\int_{0}^{2 \pi} \tilde{\gamma}_{\varepsilon}(\theta-\cdot) \varphi(\theta) \mathrm{d} \theta\right\rangle \mathrm{d} \mathbf{y} \\
& =: I_{\varepsilon}(\mathbf{x})+J_{\varepsilon}(\mathbf{x})
\end{align*}
$$

The term $I_{\varepsilon}$ may be rewritten as $I_{\varepsilon}(\mathbf{x})=c_{\gamma} \int_{\Omega} \tilde{\beta}_{\varepsilon}(\mathbf{x}-\mathbf{y})\langle f(\mathbf{x}, \cdot)-f(\mathbf{y}, \cdot), \varphi\rangle \mathrm{d} \mathbf{y}$, where $c_{\gamma}=\int_{0}^{2 \pi} \gamma(\theta) \mathrm{d} \theta$. Using that $\|\varphi\|_{H_{p e r}^{1}(0,2 \pi)} \leq 1$, we get

$$
\begin{equation*}
\left|I_{\varepsilon}(\mathbf{x})\right| \leq c_{\gamma} \int_{\Omega} \tilde{\beta}_{\varepsilon}(\mathbf{x}-\mathbf{y})\|f(\mathbf{x}, \cdot)-f(\mathbf{y}, \cdot)\|_{\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)} \mathrm{d} \mathbf{y} \tag{C.8}
\end{equation*}
$$

however, for the time being, we concentrate on the term $J_{\varepsilon}$. We have
(C.9)
$\left|J_{\varepsilon}(\mathbf{x})\right| \leq \int_{\Omega} \tilde{\beta}_{\varepsilon}(\mathbf{x}-\mathbf{y})\|f(\mathbf{y}, \cdot)\|_{\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)}\left\|\int_{0}^{2 \pi}\left(\tilde{\gamma}_{\varepsilon}(\theta) \varphi(\cdot)-\tilde{\gamma}_{\varepsilon}(\theta-\cdot) \varphi(\theta)\right) \mathrm{d} \theta\right\|_{H^{1}(0,2 \pi)} \mathrm{d} \mathbf{y}$,
and, in view of (C.4), we notice that, for every $s \in \mathbb{R}, \int_{0}^{2 \pi}\left(\tilde{\gamma}_{\varepsilon}(\theta) \varphi(s)-\tilde{\gamma}_{\varepsilon}(\theta-\right.$ s) $\varphi(\theta)) \mathrm{d} \theta=-\int_{-s}^{2 \pi-s} \tilde{\gamma}_{\varepsilon}(w)(\varphi(w+s)-\varphi(s)) \mathrm{d} w$. Thus, using also the Dominated Convergence Theorem to differentiate under the integral in the previous right-hand side, we get, for every $s \in \mathbb{R}, \frac{d}{d s} \int_{0}^{2 \pi}\left(\tilde{\gamma}_{\varepsilon}(\theta) \varphi(s)-\tilde{\gamma}_{\varepsilon}(\theta-s) \varphi(\theta)\right) \mathrm{d} \theta=-\int_{-s}^{2 \pi-s} \tilde{\gamma}_{\varepsilon}(w)\left(\varphi^{\prime}(w+\right.$ $\left.s)-\varphi^{\prime}(s)\right) \mathrm{d} w$, where we remark that the derivative contribution due to the integral limits vanishes due to the fact that $\tilde{\gamma}_{\varepsilon}$ and $\varphi$ are $2 \pi$-periodic. It follows that

$$
\begin{align*}
& \left\|\int_{0}^{2 \pi} \tilde{\gamma}_{\varepsilon}(\theta) \varphi(\cdot)-\tilde{\gamma}_{\varepsilon}(\theta-\cdot) \varphi(\theta) \mathrm{d} \theta\right\|_{H_{p e r}^{1}(0,2 \pi)}^{2}= \\
& \quad \int_{0}^{2 \pi}\left|\int_{-s}^{2 \pi-s} \tilde{\gamma}_{\varepsilon}(w)(\varphi(w+s)-\varphi(s)) \mathrm{d} w\right|^{2} \mathrm{~d} s  \tag{C.10}\\
& \quad+\int_{0}^{2 \pi}\left|\int_{-s}^{2 \pi-s} \tilde{\gamma}_{\varepsilon}(w)\left(\varphi^{\prime}(w+s)-\varphi^{\prime}(s)\right) \mathrm{d} w\right|^{2} \mathrm{~d} s=: K_{\varepsilon}^{1}+K_{\varepsilon}^{2}
\end{align*}
$$

Using the Fundamental Theorem of Calculus along with the fact that $\left\|\varphi^{(m)}\right\|_{L^{\infty}(\mathbb{R})}<$ $+\infty$ for any $m \in \mathbb{N} \cup\{0\}$ due to the smoothness and periodicity of $\varphi$, we get $\left|\int_{-s}^{2 \pi-s} \tilde{\gamma}_{\varepsilon}(w)(\varphi(w+s)-\varphi(s)) \mathrm{d} w\right| \leq\left\|\varphi^{\prime}\right\|_{L^{\infty}(\mathbb{R})} \int_{-s}^{2 \pi-s} \tilde{\gamma}_{\varepsilon}(w)|w| \mathrm{d} w$, and (using the change of variables $\theta=w+s$ )

$$
K_{\varepsilon}^{1} \leq\left\|\varphi^{\prime}\right\|_{L^{\infty}(\mathbb{R})}^{2} \int_{0}^{2 \pi}\left|\int_{0}^{2 \pi} \tilde{\gamma}_{\varepsilon}(\theta-s)\right| \theta-s|\mathrm{~d} \theta|^{2} \mathrm{~d} s
$$

Our strategy is to split the previous right-hand side into three regions in order to bound it. While $s$ is constrained to the interval $\left[0,2 \pi\left(1-\varepsilon^{\alpha}\right)\right]$, since $\theta \in[0,2 \pi]$, we have that $-2 \pi\left(1-\varepsilon^{\alpha}\right) \leq \theta-s \leq 2 \pi$, in which case $\tilde{\gamma}_{\varepsilon}(\theta-s)$ is nonzero only when $\theta-s \in\left[0,2 \pi \varepsilon^{\alpha}\right]$; we call this Region 1. On the other hand, when $s$ is constrained to the interval $\left[2 \pi\left(1-\varepsilon^{\alpha}\right), 2 \pi\right]$, since $\theta \in[0,2 \pi]$, we have that $-2 \pi \leq \theta-s \leq 2 \pi \varepsilon^{\alpha}$, in which case $\tilde{\gamma}_{\varepsilon}(\theta-s)$ is nonzero when $\theta-s \in\left[-2 \pi,-2 \pi\left(1-\varepsilon^{\alpha}\right)\right] \cup\left[0,2 \pi \varepsilon^{\alpha}\right]$. We therefore have two more regions; Region 2, where $s \in\left[2 \pi\left(1-\varepsilon^{\alpha}\right), 2 \pi\right]$ and $\theta-s \in\left[0,2 \pi \varepsilon^{\alpha}\right]$, and Region 3, where $s \in\left[2 \pi\left(1-\varepsilon^{\alpha}\right), 2 \pi\right]$ and $\theta-s \in\left[-2 \pi,-2 \pi\left(1-\varepsilon^{\alpha}\right)\right]$. It follows from the triangle inequality and the fact that the function $x \mapsto x^{2}$ is increasing on $[0, \infty)$ that $K_{\varepsilon}^{1}$ is bounded above by the sum of the following three terms, each corresponding
to Regions 1, 2, and 3, respectively:

$$
\begin{aligned}
& L_{\varepsilon}^{1}:=4 \pi^{2} \varepsilon^{2 \alpha}\left\|\varphi^{\prime}\right\|_{L^{\infty}(\mathbb{R})}^{2} \int_{0}^{2 \pi\left(1-\varepsilon^{\alpha}\right)}\left(\int_{0}^{2 \pi} \tilde{\gamma}_{\varepsilon}(\theta-s) \mathrm{d} \theta\right)^{2} \mathrm{~d} s \\
& L_{\varepsilon}^{2}:=4 \pi^{2} \varepsilon^{2 \alpha}\left\|\varphi^{\prime}\right\|_{L^{\infty}(\mathbb{R})}^{2} \int_{2 \pi\left(1-\varepsilon^{\alpha}\right)}^{2 \pi}\left(\int_{2 \pi\left(1-\varepsilon^{\alpha}\right)}^{2 \pi} \tilde{\gamma}_{\varepsilon}(\theta-s) \mathrm{d} \theta\right)^{2} \mathrm{~d} s \\
& L_{\varepsilon}^{3}:=\left\|\varphi^{\prime}\right\|_{L^{\infty}(\mathbb{R})}^{2} \int_{2 \pi\left(1-\varepsilon^{\alpha}\right)}^{2 \pi}\left(\int_{0}^{2 \pi \varepsilon^{\alpha}} \tilde{\gamma}_{\varepsilon}(\theta-s)(s-\theta) \mathrm{d} \theta\right)^{2} \mathrm{~d} s
\end{aligned}
$$

and it is straightforward to verify, using the nonnegativity of $\tilde{\gamma}_{\varepsilon}$ and (C.4), the estimates $\left|L_{\varepsilon}^{1}\right|+\left|L_{\varepsilon}^{2}\right| \leq C \varepsilon^{2 \alpha}$ and $\left|L_{\varepsilon}^{3}\right| \leq C \varepsilon^{\alpha}$, for some positive constant $C$ depending only on $c_{\gamma}$ and $\left\|\varphi^{\prime}\right\|_{L^{\infty}(\mathbb{R})}$. It follows that, for a possibly larger constant $C$ depending only on $c_{\gamma}$ and $\left\|\varphi^{\prime}\right\|_{L^{\infty}(\mathbb{R})}$, there holds $K_{\varepsilon}^{1} \leq C \varepsilon^{\alpha}$ and, by the same argument, the same bound holds for $K_{\varepsilon}^{2}$ (with the only change being that the constant $C$ also depends on $\left.\left\|\varphi^{\prime \prime}\right\|_{L^{\infty}(\mathbb{R})}\right)$. We therefore obtain from (C.10), for a possibly larger constant $C$ depending only on $c_{\gamma},\left\|\varphi^{\prime}\right\|_{L^{\infty}(\mathbb{R})}$, and $\left\|\varphi^{\prime \prime}\right\|_{L^{\infty}(\mathbb{R})}$, there holds

$$
\left\|\int_{0}^{2 \pi} \tilde{\gamma}_{\varepsilon}(\theta) \varphi(\cdot)-\tilde{\gamma}_{\varepsilon}(\theta-\cdot) \varphi(\theta) \mathrm{d} \theta\right\|_{H_{p e r}^{1}(0,2 \pi)} \leq C \varepsilon^{\alpha / 2}
$$

Thus, returning to the bound (C.9) on $\left|J_{\varepsilon}\right|$, taking supremum over test functions and integrating, followed by applying the Jensen inequality and using the monotonicity of the functions $x \mapsto x^{2}$ and $x \mapsto x^{1 / 2}$ on $[0, \infty)$, we get
(C.11)

$$
\left\|\sup _{\substack{\varphi \in C_{p e r}^{\infty}(0,2 \pi) \\\|\varphi\|_{H^{1}(0,2 \pi)} \leq 1}} J_{\varepsilon}\right\|_{L_{p e r}^{2}(\Omega)} \leq C_{\Omega} \varepsilon^{\alpha / 2}\left(\int_{\Omega} \int_{\Omega} \tilde{\beta}_{\varepsilon}(\mathbf{x}-\mathbf{y})^{2}\|f(\mathbf{y}, \cdot)\|_{\left(H_{p e r}\right)^{1}(0,2 \pi)}^{2} \mathrm{~d} \mathbf{y} \mathrm{~d} \mathbf{x}\right)^{1 / 2}
$$

where $C_{\Omega}$ is a positive constant depending only on $|\Omega|, c_{\gamma},\left\|\varphi^{\prime}\right\|_{L^{\infty}(\mathbb{R})}$, and $\left\|\varphi^{\prime \prime}\right\|_{L^{\infty}(\mathbb{R})}$. Using the Fubini-Tonelli Theorem to evaluate the double integral exactly, using also the same procedure as the one used for (C.5) to get $\int_{\Omega} \tilde{\beta}_{\varepsilon}(\mathbf{x}-\mathbf{y})^{2} \mathrm{~d} \mathbf{x}=\varepsilon^{-2} \int_{\Omega} \beta(\mathbf{y})^{2} \mathrm{~d} \mathbf{y}$,

$$
\begin{equation*}
\left\|\sup _{\substack{\varphi \in C_{p e r}^{\infty}(0,2 \pi) \\\|\varphi\|_{H^{1}(0,2 \pi)} \leq 1}} J_{\varepsilon}\right\|_{L_{p e r}^{2}(\Omega)} \leq C_{\Omega} \varepsilon^{\frac{\alpha}{2}-1}\|f\|_{L_{p e r}^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)} \tag{C.12}
\end{equation*}
$$

for some new positive constant $C_{\Omega}$ which again only depends on $|\Omega|, c_{\gamma},\left\|\varphi^{\prime}\right\|_{L^{\infty}(\mathbb{R})}$, and $\left\|\varphi^{\prime \prime}\right\|_{L^{\infty}(\mathbb{R})}$. Notice that, since $\alpha>2$, the above vanishes in the limit as $\varepsilon \rightarrow 0$.

Finally, we return to the term $I_{\varepsilon}$. By taking the supremum over test functions and integrating, we find that $\left\|\sup _{\varphi \in C_{p e r}^{\infty}(0,2 \pi)} I_{\mathcal{E}}\right\|_{L_{p e r}^{2}(\Omega)}$ is bounded above by

$$
\|\varphi\|_{H^{1}(0,2 \pi)} \leq 1
$$

$$
c_{\gamma}\left(\int_{\Omega}\left|\int_{\Omega} \tilde{\beta}_{\varepsilon}(\mathbf{x}-\mathbf{y})\|f(\mathbf{x}, \cdot)-f(\mathbf{y}, \cdot)\|_{\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)} \mathrm{d} \mathbf{y}\right|^{2} \mathrm{~d} \mathbf{x}\right)^{1 / 2}=: c_{\gamma} L_{\varepsilon}
$$

We rewrite the innermost integral above using the change of variables $\mathbf{y} \mapsto \mathbf{z}=$ $\mathbf{x}-\mathbf{y}$. Note that $\mathbf{z} \in[-2 \pi, 2 \pi] \times[-2 \pi, 2 \pi]$ and, moreover, $\tilde{\beta}_{\varepsilon}(\mathbf{z})$ is only nonzero when $\mathbf{z} \in \bigcup_{j=1}^{4} A_{\varepsilon}^{j}$, where $A_{\varepsilon}^{1}=[-2 \pi,-2 \pi(1-\varepsilon)] \times[0,2 \pi \varepsilon], A_{\varepsilon}^{2}=[0,2 \pi \varepsilon] \times[0,2 \pi \varepsilon]$, $A_{\varepsilon}^{3}=[-2 \pi,-2 \pi(1-\varepsilon)] \times[-2 \pi,-2 \pi(1-\varepsilon)], A_{\varepsilon}^{4}=[0,2 \pi \varepsilon] \times[-2 \pi,-2 \pi(1-\varepsilon)]$. It therefore follows that, using the triangle inequality for the norm of $L^{2}(\Omega)$ in the
variable $\mathbf{x}$, there holds the inequality

$$
L_{\varepsilon} \leq \sum_{j=1}^{4}\left(\int_{\Omega}\left|\int_{A_{\varepsilon}^{j}} \tilde{\beta}_{\varepsilon}(\mathbf{z})\|f(\mathbf{x}, \cdot)-f(\mathbf{x}-\mathbf{z}, \cdot)\|_{\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)} \mathrm{d} \mathbf{z}\right|^{2} \mathrm{~d} \mathbf{x}\right)^{1 / 2}=: \sum_{j=1}^{4} L_{\varepsilon}^{j}
$$

Using the Minkowski integral inequality for finite measure spaces, we get

$$
\begin{equation*}
L_{\varepsilon}^{j} \leq \int_{A_{\varepsilon}^{j}} \tilde{\beta}_{\varepsilon}(\mathbf{z})\left(\int_{\Omega}\|f(\mathbf{x}, \cdot)-f(\mathbf{x}-\mathbf{z}, \cdot)\|_{\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)}^{2} \mathrm{~d} \mathbf{x}\right)^{1 / 2} \mathrm{~d} \mathbf{z} \tag{C.13}
\end{equation*}
$$

We now have the following claim, the proof of which we omit as it is a standard exercise. The proof relies on observing that $\mathbf{f}(\mathbf{x})=\mathbf{f}\left(\mathbf{x}-\lim _{j \rightarrow \infty} \mathbf{z}_{j}\right)$ in $\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)$ for a.e. $\mathbf{x} \in \Omega$ and then integrating in $\mathbf{x}$. In order to pass to the limit in $j$, one needs to use the strong continuity property of the shift operator in $L_{p e r}^{2}(\Omega ; X)$, i.e., $\lim _{\mathbf{w} \rightarrow 0}\left\|\tau_{\mathbf{w}} \mathbf{f}-\mathbf{f}\right\|_{L_{\text {per }}^{2}(\Omega ; X)}=0$, where $\tau_{\mathbf{w}} \mathbf{f}=\mathbf{f}(\cdot+\mathbf{w})$. The proof of this latter result is also straightforward (relying on identifying a convenient dense subset and applying the Dominated Convergence Theorem) and so we omit it.

Claim C.2. Let $f \in L_{\text {per }}^{2}\left(\Omega ;\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)\right)$. Suppose that $\left(\mathbf{z}_{j}\right)_{j \in \mathbb{N}}$ is a sequence of points in $\mathbb{R}^{2}$ converging towards the point $(2 \pi m, 2 \pi n) \in \mathbb{R}^{2}$ for some fixed $m, n \in \mathbb{Z}$. Then, $\lim _{j \rightarrow \infty}\left(\int_{\Omega}\left\|f(\mathbf{x}, \cdot)-f\left(\mathbf{x}-\mathbf{z}_{j}, \cdot\right)\right\|_{\left(H_{p e r}^{1}\right)^{\prime}(0,2 \pi)}^{2} \mathrm{~d} \mathbf{x}\right)^{1 / 2}=0$.

By rewriting $\tilde{\beta}_{\varepsilon}(\mathbf{z})$ in each of the squares $\left\{A_{\varepsilon}^{j}\right\}_{j=1}^{4}$ in terms of the original bump function $\beta$, using the previous claim, and applying the Dominated Convergence Theorem to the right-hand side of (C.13), we get $\lim _{\varepsilon \rightarrow 0} L_{\varepsilon}^{j}=0$ for $j=1, \ldots, 4$. Hence $\left\|\sup _{\varphi \in C_{p e r}^{\infty}(0,2 \pi)} I_{\varepsilon}\right\|_{L_{\text {per }}^{2}(\Omega)} \rightarrow 0$ as $\varepsilon \rightarrow 0$. This, (C.12), and (C.7), proves (C.1).
$\|\varphi\|_{H^{1}(0,2 \pi)} \leq 1$
