# Validity of Bogoliubov's approximation for translation-invariant Bose gases

#### Abstract

We verify Bogoliubov's approximation for translation-invariant Bose gases in the mean field regime, i.e. we prove that the ground state energy $E_{N}$ is given by $E_{N}=N e_{\mathrm{H}}+\inf \sigma(\mathbb{H})+o_{N \rightarrow \infty}(1)$, where $N$ is the number of particles, $e_{\mathrm{H}}$ is the minimal Hartree energy and $\mathbb{H}$ is the Bogoliubov Hamiltonian. As an intermediate result we show the existence of approximate ground states $\Psi_{N}$, i.e. states satisfying $\left\langle H_{N}\right\rangle_{\Psi_{N}}=E_{N}+o_{N \rightarrow \infty}(1)$, exhibiting complete Bose-Einstein condensation with respect to one of the Hartree minimizers.


## 1. Introduction and Main Results

We study the Hamiltonian $H_{N}$ acting on the Hilbert space $L_{\mathrm{sym}}^{2}\left(\mathbb{R}^{N \times d}\right) \simeq \otimes_{\mathrm{s}}^{N} L^{2}\left(\mathbb{R}^{d}\right)$ of $N$ identical bosons in $\mathbb{R}^{d}$ for $d \geq 1$, given by

$$
\begin{equation*}
H_{N}:=\sum_{i=1}^{N} T_{i}+\frac{1}{N-1} \sum_{i<j} v\left(x_{i}-x_{j}\right), \tag{1.1}
\end{equation*}
$$

where $T$ is a non-negative and translation-invariant operator defined on the single particle space $L^{2}\left(\mathbb{R}^{d}\right)$ and the interaction potential $v$ is an even function. Typically we will think of $T$ as the non-relativistic energy $T=-\Delta$ or the pseudo relativistic energy $T=\sqrt{m^{2}-\Delta}-m$, and of the interaction $v$ as being attractive. The most prominent features of this model are the mean field scaling $\frac{1}{N-1}$ of the interaction energy and the invariance of $H_{N}$ under translations, which especially means that the Hamiltonian $H_{N}$ describes an unconfined system of $N$ bosons. By choosing a product state $\Psi:=u^{\otimes^{N}}$ as a test function, we obtain the trivial upper bound on the ground state energy $E_{N}:=\inf \sigma\left(H_{N}\right)$ per particle

$$
N^{-1} E_{N} \leq N^{-1}\left\langle H_{N}\right\rangle_{\Psi}=\langle T\rangle_{u}+\frac{1}{2} \iint|u(x)|^{2} v(x-y)|u(y)|^{2} \mathrm{~d} x \mathrm{~d} y=: \mathcal{E}_{\mathrm{H}}[u],
$$

where $\mathcal{E}_{\mathrm{H}}[u]$ is referred to as the Hartree energy functional. This upper bound is independent of the particle number $N$ due to the scaling by $\frac{1}{N-1}$ of the interaction. It is
known under quite general assumptions on $v$ and $T$ that the upper bound

e_{\mathrm{H}}:=\inf _{\|u\|=1} \mathcal{E}_{\mathrm{H}}[u] \tag{1.2}
\end{equation*}
$$

on the ground state energy per particle is asymptotically correct in the mean field limit $N \rightarrow \infty$, see [19]. Furthermore, the Bogoliubov approximation [3] predicts that the next order term in the approximation $E_{N} \approx N e_{\mathrm{H}}$ is of order one and given by the ground state energy of the corresponding Bogoliubov Hamiltonian $\mathbb{H}$, which is formally the second quantization of the Hessian $\left.\operatorname{Hess}\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}$ at a minimizer $u_{0}$. In the past decade, this conjecture has been proven for a variety of mean field models [8, 21, 28, 31, and also for systems with more singular interactions [6, 1, 2, 4, 4, 2, 29. However, the rigorous verification of Bogoliubov's approximation has so far been restricted to confined systems only. In the case of translation-invariant models, we face the problem that minimizers of the Hartree energy functional $\mathcal{E}_{\mathrm{H}}$ are not unique and that the Hessian Hess $\left.\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}$ at a minimizer $u_{0}$ does not exhibit a gap, i.e. we do not have an inequality of the form $\left.\operatorname{Hess}\right|_{u_{0}} \mathcal{E}_{\mathrm{H}} \geq c$ with $c>0$. Novel ideas and techniques are required in order to deal with these translation-invariance specific problems, which we will develop in the course of this paper allowing us to verify Bogoliubov's prediction $E_{N}=N e_{\mathrm{H}}+\inf \sigma(\mathbb{H})+o_{N}(1)$ for translation-invariant systems. As an intermediate step, we will construct a sequence of approximate ground states $\Psi_{N}$ satisfying complete Bose-Einstein condensation, which we believe to be of independent interest.

Note that the situation is different for time-dependent problems, where it is already well-known that fluctuations around a product state $u^{\otimes^{N}}$ evolve according to a (timedependent) Bogoliubov operator, even for translation-invariant systems [20].

Due to the translation-invariance, it is clear that $H_{N}$ has no ground state and therefore we have to restrict our attention to sequences of approximate ground states $\Psi_{N}$. We will use the convention that states $\Psi$ are normed Hilbert space elements, i.e. $\|\Psi\|=1$. In our first result we show the existence of a sequence of approximate ground states $\Psi_{N}$, with the property that $\Psi_{N}$ is close to a product state $u_{0}^{\otimes^{N}}$ where $u_{0}$ minimizes the Hartree energy $\mathcal{E}_{\mathrm{H}}$. In this context, close means that the sequence $\Psi_{N}$ satisfies complete Bose-Einstein condensation with respect to the state $u_{0}$, i.e. the corresponding one particle density matrices $\gamma_{N}^{(1)}$ satisfy $\left\langle\gamma_{N}^{(1)}\right\rangle_{u_{0}} \underset{N \rightarrow \infty}{\longrightarrow}$. In general we define the $k$ particle density matrix $\gamma_{\Psi}^{(k)}$ corresponding to a state $\Psi \in \bigotimes_{\mathrm{s}}^{N} L^{2}\left(\mathbb{R}^{d}\right)$ by the equation $\operatorname{Tr}\left[\gamma_{\Psi}^{(k)} B\right]=\langle B \otimes 1 \otimes \cdots \otimes 1\rangle_{\Psi}$ for all bounded $k$-particle operators $B$. This means in particular that we use the normalization convention $\operatorname{Tr}\left[\gamma_{N}^{(k)}\right]=1$. In order to prove complete Bose-Einstein condensation, we need certain assumptions concerning the kinetic energy operator $T$ and the Hartree theory, as well as a relative bound of the interaction potential $v$ in terms of the kinetic energy.

Assumption 1.1. The kinetic energy is given by $T:=\left(m^{2}-\Delta\right)^{s}-m^{2 s}$ with $m>0$ and $s \in(0,1]$, the interaction potential $v$ satisfies $\lim _{|x| \rightarrow \infty} v(x)=0$ and the chain of
inequalities

$$
\begin{equation*}
-\lambda T-\Lambda \leq v \leq|v| \leq \Lambda(T+1) \tag{1.3}
\end{equation*}
$$

for some $\lambda \in(0,2)$ and $\Lambda \in(0, \infty)$. Furthermore, the Hartree energy defined in Eq. (1.2) is strictly negative, i.e. $e_{\mathrm{H}}<0$, and there exists a real-valued function $u_{0} \in L^{2}\left(\mathbb{R}^{d}\right)$ that minimizes the Hartree energy, i.e. $e_{\mathrm{H}}=\mathcal{E}_{\mathrm{H}}\left[u_{0}\right]$, and satisfies $\int_{\left[x_{r} \leq t\right]}\left|u_{0}(x)\right|^{2} \mathrm{~d} x=\frac{1}{2}$ if and only if $t=0$, where $x_{r}$ is the $r$-th component of the vector $x \in \mathbb{R}^{d}$. Up to a complex phase, all other Hartree minimizers are given by translations of $u_{0}$, i.e. all minimizers are of the form $e^{i \theta} u_{0, t}$ with $\theta \in[0,2 \pi), t \in \mathbb{R}^{d}$ and $u_{0, t}(x):=u_{0}(x-t)$.

By the translation-invariance of the Hartree energy, any shift of a Hartree minimizer $u_{0}(x-t)$ is again a minimizer. Therefore, we can always choose the Hartree minimizer such that it is centered around zero, i.e. such that $\int_{\left[x_{r} \leq 0\right]}\left|u_{0}(x)\right|^{2} \mathrm{~d} x=\frac{1}{2}$ for all $r \in$ $\{1, \ldots, d\}$. In particular, in case the minimizers $u$ of $\mathcal{E}_{H}$ satisfy $u>0$, the existence of a $u_{0}$ satisfying $\int_{\left[x_{r} \leq t\right]}\left|u_{0}(x)\right|^{2} \mathrm{~d} x=\frac{1}{2}$ if and only if $t=0$ is always granted. Furthermore, most of our proofs do not depend on the concrete structure $T=\left(m^{2}-\Delta\right)^{s}-m^{2 s}$ of the kinetic energy, and it is sufficient to assume instead that the operator $T$ is of the translation-invariant form $T=t(i \nabla)$ for some $t$ with $t(p) \underset{|p| \rightarrow \infty}{\longrightarrow} \infty$ such that the Hartree approximation $\frac{1}{N} E_{N} \underset{N \rightarrow \infty}{\longrightarrow} e_{\mathrm{H}}$ as well as the IMS localization formula in Lemma 2.2 hold.

With Assumption 1.1 at hand, we obtain our first main result Theorem 1.2, which we will prove in Section 2

Theorem 1.2. Given Assumption 1.1, there exists a sequence of states $\Psi_{N} \in \otimes_{\mathrm{s}}^{N} L^{2}\left(\mathbb{R}^{d}\right)$ with $\left\langle H_{N}\right\rangle_{\Psi_{N}}=E_{N}+o_{N \rightarrow \infty}(1)$, exhibiting complete Bose-Einstein condensation with respect to the state $u_{0}$, i.e.

$$
\begin{equation*}
\left\langle\gamma_{N}^{(1)}\right\rangle_{u_{0}} \underset{N \rightarrow \infty}{\longrightarrow} 1 \tag{1.4}
\end{equation*}
$$

Since Assumption 1.1 implies the validity of the Hartree approximation in the form $\frac{1}{N} E_{N} \underset{N \rightarrow \infty}{\longrightarrow} e_{\mathrm{H}}$, see [19], it is clear that the product state $u_{0}^{\otimes^{N}}$, which trivially satisfies perfect Bose-Einstein condensation, approximates the ground state energy to leading order, i.e. $\left\langle H_{N}\right\rangle_{u_{0}^{\otimes^{N}}}=E_{N}+o_{N \rightarrow \infty}(N)$. In Theorem 1.2 we improve this result by constructing a Bose-Einstein condensate that approximates $E_{N}$ even up to terms $o_{N \rightarrow \infty}(1)$. Note, however, that Theorem 1.2 claims nothing about the rate of convergence in Eq. (1.4). One can improve this result a posteriori by using the trial states in our proof of the upper bound in Theorem 1.4, which yields for any given sequence $c_{N} \underset{N \rightarrow \infty}{\longrightarrow} \infty$ a sequence of approximate ground states $\widetilde{\Psi}_{N}$ satisfying

$$
\left|\left\langle\widetilde{\gamma}_{N}^{(1)}\right\rangle_{u_{0}}-1\right| \leq \frac{c_{N}}{N}
$$

It follows from our proof of the lower bound in Theorem 1.4 that this result is optimal in the sense that any sequence with $\left|\left\langle\widetilde{\gamma}_{N}^{(1)}\right\rangle_{u_{0}}-1\right|=O_{N \rightarrow \infty}\left(\frac{1}{N}\right)$ cannot be a sequence of approximate ground states.

Furthermore it follows from the proof of Theorem 1.2 that for any sequence $c_{N} \xrightarrow[N \rightarrow \infty]{ }$ $\infty$, there exist states $\Psi_{N}^{\prime}$ exhibiting complete Bose-Einstein condensation with $\left\langle H_{N}\right\rangle_{\Psi_{N}^{\prime}} \leq$ $E_{N}+\frac{c_{N}}{N}$. Again it is a consequence of our proof of the lower bound that this result is optimal in the sense that any sequence with $\left\langle H_{N}\right\rangle_{\Psi_{N}^{\prime}}=E_{N}+O_{N \rightarrow \infty}\left(\frac{1}{N}\right)$ does not satisfy complete Bose-Einstein condensation.

Proof strategy of Theorem [1.2. With Assumption 1.1 at hand, we can apply the results in [19] which tell us that the Hartree asymptotics $\frac{1}{N} E_{N} \underset{N \rightarrow \infty}{\longrightarrow} e_{\mathrm{H}}$ holds true and that any sequence of approximate ground states $\Psi_{N}$ has a subsequence such that the $k$-particle density matrices converge weakly to a mixture of not necessarily normed Hartree minimizers. This means that there exists a probability measure $\mu$ supported on functions $u$ with $\|u\| \leq 1$ and $\mathcal{E}_{\mathrm{H}}[u]=\inf _{\|v\|=\|u\|} \mathcal{E}_{\mathrm{H}}[v]$, such that the $k$-particle density matrix of the subsequence $\Psi_{N_{j}}$ satisfies

$$
\begin{equation*}
\operatorname{Tr}\left[\gamma_{N_{j}}^{(k)} K\right] \underset{j \rightarrow \infty}{\longrightarrow} \int \operatorname{Tr}\left[(|u\rangle\langle u|)^{\otimes^{k}} K\right] \mathrm{d} \mu(u) \tag{1.5}
\end{equation*}
$$

for any compact $k$ particle operator $K$. The proofs in [19] rely on the quantum de Finetti theorem (see also [32, 12]), which identifies states on the infinite symmetric tensor product as the convex hull of product states. In order to prove Theorem 1.2, we have to construct a sequence of approximate ground states $\Psi_{N}$ such that the corresponding measure $\mu$ in Eq. (1.5) is equal to the delta measure $\delta_{u_{0}}$. In particular this means that $\mu$ has to be supported on the set of normed elements $\|u\|=1$, or equivalently we have to make sure that mass cannot escape to infinity. For confined systems satisfying a binding inequality, it has been shown in [19] that $\mu$ is always supported on normed elements. For translation-invariant systems this is no longer the case, since one can always find $y_{N} \in \mathbb{R}^{d}$ such that $\widetilde{\Psi}_{N} \underset{N \rightarrow \infty}{ }{ }^{\circ} 0$ where

$$
\widetilde{\Psi}_{N}\left(x^{(1)}, \ldots, x^{(N)}\right):=\Psi_{N}\left(x^{(1)}-y_{N}, \ldots, x^{(N)}-y_{N}\right)
$$

for all $\left(x^{(1)}, \ldots, x^{(N)}\right) \in \mathbb{R}^{N \times d}$, and therefore the corresponding measure is supported on $\{0\}$ only. While one could circumvent this issue by factoring out the center-of-mass variable, we avoid doing this since there is no straightforward analogue of product states and Bose-Einstein condensation in the space of relative coordinates. Alternatively we overcome this problem by localizing a sequence of approximate ground states $\Psi_{N}$ only to configurations that are centered around zero. It turns out that the median of a configuration $x=\left(x^{(1)}, \ldots, x^{(N)}\right) \in \mathbb{R}^{N \times d}$, respectively a regularized version of the median, is the right statistical quantity to measure whether a configuration is centered around the origin or not. Furthermore, we will energetically rule out configurations where the mass is split up in two or multiple parts, e.g. we will rule out configurations
where $\frac{N}{2}$ particles are very far from the other $\frac{N}{2}$ particles. We conclude that the mass is concentrated at the origin and therefore it does not escape to infinity.

In order to identify the support of the measure $\mu$ in Eq. (1.5), note that all Hartree minimizers are up to a complex phase translations of the minimizer $u_{0}$, which is a function centered around zero. Consequently, up to this complex phase, $u_{0}$ is the only minimizer with the property of being centered around zero. Using the support property of $\Psi_{N}$, this already suggests that the measure $\mu$ should be supported on states of the form $\left\{e^{i \theta} u_{0}: \theta \in[0,2 \pi)\right\}$ only. Since $\left|e^{i \theta} u_{0}\right\rangle\left\langle e^{i \theta} u_{0}\right|=\left|u_{0}\right\rangle\left\langle u_{0}\right|$ defines the same density matrix for all complex phases $e^{i \theta}$, this support property of the measure $\mu$ implies the convergence of the density matrix $\gamma_{N}^{(k)}$ to a single condensate $\left(\left|u_{0}\right\rangle\left\langle u_{0}\right|\right)^{\otimes^{k}}$.

Having a sequence of approximate ground states at hand that satisfies complete BoseEinstein condensation is a crucial prerequisite in identifying the sub-leading term in the energy asymptotics $E_{N}=N e_{\mathrm{H}}+o(N)$. In the following, let $u_{0}, u_{1}, \ldots, u_{d}, u_{d+1}, \ldots$ be a real orthonormal basis of $L^{2}\left(\mathbb{R}^{d}\right)$, where $u_{0}$ is the Hartree minimizer from Assumption 1.1 and $u_{1}, \ldots, u_{d}$ a basis of the vector space spanned by the partial derivatives $\left\langle\partial_{x_{1}} u_{0}, \ldots, \partial_{x_{d}} u_{0}\right\rangle$. Since the functional $\mathcal{E}_{\mathrm{H}}$ is invariant under a phase change $u \mapsto e^{i \theta} u$, we can restrict ourself to states $u$ with $\left\langle u_{0}, u\right\rangle \geq 0$. Then, the Hessian Hess $\left.\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}$ of the Hartree energy is a real quadratic form defined on $\left\{u_{0}\right\}^{\perp} \subset L^{2}\left(\mathbb{R}^{d}\right)$, and consequently there exist coefficients $Q_{i, j}, G_{i, j} \in \mathbb{C}, i, j \in \mathbb{N}$, such that Hess $\left.\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}[z]=$ $\sum_{i, j=1}^{\infty}\left(Q_{i, j} \bar{z}_{i} z_{j}+\bar{G}_{i, j} z_{i} z_{j}+G_{i, j} \bar{z}_{i} \bar{z}_{j}\right)$, where $z_{i}$ are the coordinates of $z \in\left\{u_{0}\right\}^{\perp}$. In order to define the Bogoliubov operator $\mathbb{H}$, let $a_{i}, a_{i}^{\dagger}$ be the annihilation/creation operators corresponding to the state $u_{i} \in L^{2}\left(\mathbb{R}^{d}\right)$. Following [21] we formally define $\mathbb{H}$ as the second quantization of the Hessian $\operatorname{Hess} \mid{ }_{u_{0}} \mathcal{E}_{\mathrm{H}}$, i.e.

$$
\begin{equation*}
\mathbb{H}:=\sum_{i, j=1}^{\infty}\left(Q_{i, j} a_{i}^{\dagger} a_{j}+\bar{G}_{i, j} a_{i} a_{j}+G_{i, j} a_{i}^{\dagger} a_{j}^{\dagger}\right) . \tag{1.6}
\end{equation*}
$$

For a rigorous construction see Definition 4.3.
Note that due to the translation-invariance, the Hessian Hess $\left.\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}$ is degenerate in the directions $u_{j}$ for $j \in\{1, \ldots, d\}$, i.e. Hess $\left.\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}\left[u_{j}\right]=0$. The following Assumption makes sure that $\left.\operatorname{Hess}\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}$ is non-degenerate in all other directions.
Assumption 1.3. The partial derivatives of $u_{0}$ are in the form domain of $T$, and there exists a constant $\eta>0$ such that

$$
\begin{equation*}
\left.\operatorname{Hess}\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}[z] \geq \eta\|z\|^{2} \tag{1.7}
\end{equation*}
$$

for all $z$ of the form $z=i \sum_{j=1}^{d} s_{j} u_{j}+z_{>d}$ with $s_{j} \in \mathbb{R}$ and $z_{>d} \in\left\{u_{0}, \partial_{x_{1}} u_{0}, \ldots, \partial_{x_{d}} u_{0}\right\}^{\perp}$. Furthermore, the Hartree minimizer $u_{0}$ is an element of $H^{2}\left(\mathbb{R}^{d}\right)$.

With the Assumption 1.3 at hand, we arrive at our second main Theorem, which identifies the sub-leading term in the energy asymptotics as the ground state energy $\inf \sigma(\mathbb{H})$ of the Bogoliubov operator $\mathbb{H}$.

Theorem 1.4. Let $E_{N}$ be the ground state energy of the Hamiltonian $H_{N}$ defined in $E q$. (1.1), $e_{\mathrm{H}}$ the Hartree energy defined in Eq. (1.2) and let $\mathbb{H}$ be the Bogoliubov operator defined in Eq. (1.6). Given Assumption 1.1 and Assumption 1.3, we have

$$
\begin{equation*}
E_{N}=N e_{\mathrm{H}}+\inf \sigma(\mathbb{H})+o_{N \rightarrow \infty}(1) \tag{1.8}
\end{equation*}
$$

Examples of systems satisfying both Assumptions 1.1 and 1.3 , and hence our Theorem 1.4 applies to, are as follows.

Example (I). Let us first consider a system of $N$ non-relativistic bosons in $\mathbb{R}^{3}$ interacting with each other via a Newtonian potential

$$
H_{N}:=-\sum_{i=1}^{N} \Delta_{i}-\frac{g}{N-1} \sum_{i<j} \frac{1}{\left|x_{i}-x_{j}\right|}
$$

with $g>0$. Existence and uniqueness of the Hartree minimizer $u_{0}$, in the sense of Assumption 1.1, have been shown in [22]. Moreover, $u_{0}$ is strictly positive and smooth, hence satisfies all the other requirements of Assumptions 1.1 and 1.3 . The non-degeneracy of the Hessian follows from the results in 16 by standard arguments, see for instance [7]. Furthermore, it is clear by a scaling argument that $e_{\mathrm{H}}<0$ and that we can bound the interaction energy in terms of the kinetic energy by $\frac{1}{|x|} \leq-\epsilon \Delta+\frac{1}{4 \epsilon}$ for all $\epsilon>0$.

Example (II). As a second example let us consider a system of $N$ pseudo-relativistic bosons in $\mathbb{R}^{3}$ with positive mass $m>0$, interacting with each other via a Newtonian potential

$$
H_{N}:=\sum_{i=1}^{N}\left(\sqrt{m^{2}-\Delta_{i}}-m\right)-\frac{g}{N-1} \sum_{i<j} \frac{1}{\left|x_{i}-x_{j}\right|}
$$

where we assume that the coupling strength satisfies $g \in\left(0, g_{*}\right)$ for a suitable positive constant $g_{*}>0$. It has been shown in [24] that there exists a Hartree minimizer $u_{0}$ as long as the coupling $g$ is below a critical value, in which case the Hartree approximation $\lim _{N \rightarrow \infty} N^{-1} E_{N}=e_{\mathrm{H}}$ holds true. The chain of operator inequalities in Assumption 1.1 holds as long as the coupling is below the critical value $\frac{4}{\pi}$, see [11, 13]. By restricting the attention to possibly smaller couplings $g \in\left(0, g_{*}\right)$ it has been shown in [16, 10, that minimizers $u_{0}$ are unique in the sense of Assumption 1.1. Furthermore it follows from the results in [16, 10] that the Hessian is non-degenerate in the sense of Assumption 1.3 for couplings $g$ below a critical value. We will verify this explicitly in Appendix A using an argument similar to the one in [7] for non-relativistic systems. (The argument in [7] is based on scaling the coordinates and hence not directly applicable in the pseudorelativistic case.)

Example (III). As a third example let us consider the exactly solvable model of $N$ non-relativistic bosons on the real line $\mathbb{R}$, interacting with each other via an attractive delta potential

$$
H_{N}:=-\sum_{i=1}^{N} \partial_{i}^{2}-\frac{\lambda}{N-1} \sum_{i<j} \delta\left(x_{i}-x_{j}\right),
$$

where $\lambda>0$, see [26] for an explicit expression of the ground state energy. In this case the Hartree energy $\mathcal{E}_{\mathrm{H}}$ is given by

$$
\mathcal{E}_{\mathrm{H}}[u]=\int_{-\infty}^{\infty}\left|u^{\prime}(x)\right|^{2} \mathrm{~d} x-\frac{\lambda}{2} \int_{-\infty}^{\infty}|u(x)|^{4} \mathrm{~d} x .
$$

For $d=1$ we have $\delta \leq-\epsilon \partial^{2}+\frac{1}{4 \epsilon}$ for all $\epsilon>0$ in the sense of quadratic forms, and therefore Eq. (1.3) in Assumption 1.1 holds. By a scaling argument it is clear that $e_{\mathrm{H}}<0$ and minimizers of the Hartree energy are unique in the sense of Assumption 1.1, see [15] where the uniqueness of solutions to the corresponding Euler-Lagrange equation is verified. Furthermore the coercivity assumption in Eq. (1.7) is a consequence of the slightly different coercivity result in [34 (arguing, e.g., as in Appendix (A)).

We remark that in Examples (I) and (III), the value of the coupling constant, and hence also the factor $1 /(N-1)$ in front of the interaction term, is irrelevant, since it can be replaced by any other value by a simple scaling of the coordinates. This does not apply to Example (II), however.

Proof strategy of Theorem 1.4. We will verify the upper bound in our main result (1.8) analogously to the proof of the energy asymptotics for confined systems in [21]. The more difficult lower bound will be based on the correspondence between the Hartree energy $\mathcal{E}_{\mathrm{H}}$ and the Hamiltonian $H_{N}$. This correspondence becomes evident when we rewrite $H_{N}$ in the language of second quantization. For this purpose, let us define the rescaled creation operators $b_{j}^{\dagger}:=\frac{1}{\sqrt{N}} a_{u_{j}}^{\dagger}$, where we suppress the $N$ dependence in our notation for simplicity. Then we can write

N^{-1} H_{N}=\sum_{i, j=0}^{\infty} T_{i, j} b_{i}^{\dagger} b_{j}+\frac{N}{N-1} \frac{1}{2} \sum_{i j, k \ell} \hat{v}_{i j, k \ell} b_{i}^{\dagger} b_{j}^{\dagger} b_{k} b_{\ell}, \tag{1.9}
\end{equation*}
$$

where $T_{i, j}$ are the matrix entries of the operator $T$ with respect to the basis $\left\{u_{i}: i \in \mathbb{N}_{0}\right\}$ and $\hat{v}_{i j, k \ell}$ are the ones of the two body multiplication operator $\hat{v}=v(x-y)$ with respect to the basis $\left\{u_{i} \otimes u_{j}: i, j \in \mathbb{N}_{0}\right\}$. Up to the factor $\frac{N}{N-1}$, the Hartree energy $\mathcal{E}_{\mathrm{H}}[u]$

$$
\mathcal{E}_{\mathrm{H}}[u]=\sum_{i, j=0}^{\infty} T_{i, j} \overline{c_{i}} c_{j}+\frac{1}{2} \sum_{i j, k \ell} \hat{v}_{i j, k \ell} \overline{c_{i}} \overline{c_{j}} c_{k} c_{\ell}
$$

is represented by the same symbolic expression as in Eq. (1.9), i.e. we plug in the complex numbers $c_{i}$ instead of the operators $b_{i}$. Before investigating the next order term
in the energy asymptotics, let us discuss the next order expansion of the commutative counterpart $\mathcal{E}_{\mathrm{H}}[u]=e_{\mathrm{H}}+o\left(\left\|u-u_{0}\right\|\right)$, which is given by the Hessian of the functional $\mathcal{E}_{\mathrm{H}}$. Since the Hartree energy is defined on the infinite dimensional manifold $\left\{u \in L^{2}\left(\mathbb{R}^{d}\right)\right.$ : $\left.\|u\|=1,\left\langle u_{0}, u\right\rangle \geq 0\right\} \subset L^{2}\left(\mathbb{R}^{d}\right)$, it is convenient to introduce the embedding

$$
\iota:\left\{\begin{array}{l}
\left\{z \in\left\{u_{0}\right\}^{\perp}:\|z\| \leq 1\right\} \longrightarrow\left\{u \in L^{2}\left(\mathbb{R}^{d}\right):\|u\|=1,\left\langle u_{0}, u\right\rangle \geq 0\right\}  \tag{1.10}\\
z \mapsto \iota(z):=\sqrt{1-\|z\|^{2}} u_{0}+z .
\end{array}\right.
$$

Using the chart $\iota$, we can express the Hessian as $\operatorname{Hess}_{u_{0}} \mathcal{E}_{\mathrm{H}}=\left.D^{2}\right|_{0}\left(\mathcal{E}_{\mathrm{H}} \circ \iota\right)$ and the second order expansion at $z=0$ is given by

$$
\mathcal{E}_{\mathrm{H}}[\iota(z)]=e_{\mathrm{H}}+\operatorname{Hess}_{u_{0}} \mathcal{E}_{\mathrm{H}}[z]+o\left(\|z\|^{2}\right) .
$$

In contrast to confined systems, the Hessian for translation-invariant systems is always degenerate in the directions $u_{1}, \ldots, u_{d}$, i.e. $\left.\operatorname{Hess}\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}\left[u_{j}\right]=0$ for $j \in\{1, \ldots, d\}$. It is important to observe that the manifold of minimizers $\mathcal{M}:=\left\{z: \mathcal{E}_{\mathrm{H}}[\iota(z)]=e_{\mathrm{H}}\right\}$ is not contained in the null space of the Hessian $\left\{z:\left.\operatorname{Hess}\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}[z]=0\right\}$. Therefore, we do not have the crucial estimate $\mathcal{E}_{\mathrm{H}}[\iota(z)] \geq e_{\mathrm{H}}+(1-\epsilon) \operatorname{Hess}_{u_{0}} \mathcal{E}_{\mathrm{H}}[z], 0<\epsilon<1$, not even in an arbitrary small neighborhood of zero. In order to obtain such an inequality, we will introduce yet another transformation $F$ on the ball $\left\{z \in\left\{u_{0}\right\}^{\perp}:\|z\| \leq 1\right\}$, such that $\left.D\right|_{0} F$ is the identity and such that $F$ flattens the manifold of minimizers $\mathcal{M}$, i.e. $\mathcal{E}_{\mathrm{H}}\left[(\iota \circ F)\left(\sum_{j=1}^{d} t_{j} u_{j}\right)\right]=e_{\mathrm{H}}$ for all $t_{j} \in \mathbb{R}$. For a concrete construction of $F$ see Eq. (4.7) in Section (4) Under the assumption that the Hessian is only degenerate in the directions $u_{j}$, see Assumption [1.3, we obtain for any fixed $\epsilon>0$ and $z$ small enough the important estimate

$$
\begin{equation*}
\mathcal{E}_{\mathrm{H}}[(\iota \circ F)(z)] \geq e_{\mathrm{H}}+\left.(1-\epsilon) \operatorname{Hess}\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}[z] . \tag{1.11}
\end{equation*}
$$

Returning to the Hamiltonian $H_{N}$, we will introduce non-commutative counterparts to the embedding $\iota$ and the transformation $F$. The counterpart to $\iota$ is the excitation map $U_{N}$ introduced in [21], where it has already been used to verify the next order approximation of the ground state energy for confined systems. It is defined as

$$
\begin{equation*}
U_{N}\left(u_{0}^{\otimes^{i_{0}}} \otimes_{\mathrm{s}} u_{1}^{\otimes^{i_{1}}} \otimes_{\mathrm{s}} \cdots \otimes_{\mathrm{s}} u_{m}^{\otimes^{i_{m}}}\right):=u_{1}^{\otimes^{i_{1}}} \otimes_{\mathrm{S}} \cdots \otimes_{\mathrm{s}} u_{m}^{\otimes^{i_{m}}} \tag{1.12}
\end{equation*}
$$

for non-negative integers $i_{0}+\cdots+i_{m}=N$, mapping the $N$ particle space $\bigotimes_{\mathrm{s}}^{N} L^{2}\left(\mathbb{R}^{d}\right)$ into the truncated Fock space $\mathcal{F}_{\leq N}\left(\left\{u_{0}\right\}^{\perp}\right):=\bigoplus_{n \leq N} \bigotimes_{\mathrm{s}}^{n}\left\{u_{0}\right\}^{\perp}$ over modes orthogonal to $u_{0}$, where the symmetric tensor product $\otimes_{\mathrm{s}}$ is defined as
$\psi_{k} \otimes_{s} \psi_{\ell}\left(x^{(1)}, \ldots, x^{(k+\ell)}\right):=\frac{1}{\sqrt{\ell!k!(k+\ell)!}} \sum_{\sigma \in S_{k+\ell}} \psi_{k}\left(x^{\left(\sigma_{1}\right)}, \ldots, x^{\left(\sigma_{k}\right)}\right) \psi_{\ell}\left(x^{\left(\sigma_{k+1}\right)}, \ldots, x^{\left(\sigma_{k+\ell}\right)}\right)$
for $\psi_{k} \in \bigotimes_{\mathrm{s}}^{k} L^{2}\left(\mathbb{R}^{3}\right)$ and $\psi_{\ell} \in \bigotimes_{\mathrm{s}}^{\ell} L^{2}\left(\mathbb{R}^{3}\right)$, and $S_{n}$ is the set of permutations on $\{1, \ldots, n\}$. Regarding the transformation $F$, we construct the counterpart $\mathcal{W}_{N}$ in Definition 4.8 as a certain transformation reminiscent of the Gross transformation in [9, 30,
operating on the space $\mathcal{F}\left(\left\{u_{0}\right\}^{\perp}\right)$. Based on these correspondences and the observation that the Bogoliubov operator is the non-commutative analogue of the Hessian Hess $\left.\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}$, we obtain the following inequality analogous to Eq. (1.11)

$$
\begin{equation*}
\left(\mathcal{W}_{N} U_{N}\right) N^{-1} H_{N}\left(\mathcal{W}_{N} U_{N}\right)^{-1} \gtrsim e_{\mathrm{H}}+(1-\epsilon) N^{-1} \mathbb{H} . \tag{1.13}
\end{equation*}
$$

We write $\gtrsim$ for two reasons: There are errors of order $o\left(\frac{1}{N}\right)$ coming from the noncommutative nature of $H_{N}$; moreover Eq. (1.13) only holds for states $\Psi$ that satisfy a strengthened version of Bose-Einstein condensation of the form $U_{N} \Psi \in \mathcal{F}_{\leq M_{N}}\left(\left\{u_{0}\right\}^{\perp}\right)$ with $M_{N} \ll N$, which corresponds to the fact that Inequality (1.11) only holds for small $z$. The rigorous verification of inequality (1.13) will be the content of Sections 4 and 5 .

Our construction of $\mathcal{W}_{N}$ and the proof of Inequality (1.13) do not rely on the specific structure of $H_{N}$ or $L^{2}\left(\mathbb{R}^{d}\right)$, and they can be generalized for various mean field models with continuous symmetries. The essential assumption is that the dimension of the symmetry group agrees with the nullity of the Hessian, i.e. the Hessian is as non-degenerate as possible in the presence of a continuous symmetry, see Assumption 1.3 ,

Outline. The paper is structured as follows. In Section 2 we construct a sequence of approximate ground states satisfying complete Bose-Einstein condensation, which verifies our first main Theorem 1.2. The methods and results of Section 2 can be read independently of the rest of the paper, which is dedicated to the proof of our second main Theorem [1.4. In Section 3, we will introduce the relevant Fock spaces as well as a useful notation for second quantized operators, which we believe to be intuitive and natural for our problem. With the basic notions at hand, we will follow the strategy in [21] and reformulate our problem in a Fock space language using the excitation map $U_{N}$. In Section 4 we will discuss the energy asymptotics of $H_{N}$, starting with a precise definition of the Bogoliubov operator $\mathbb{H}$ in Subsection 4.1, the verification of the upper bound in Subsection 4.2 and the proof of the lower bound in Subsection 4.3, up to the proof of the main technical inequality Eq. (1.13). The proof of the latter is the content of Section 5

## 2. Bose-Einstein Condensation of Ground States

In this section we will prove Theorem 1.2 by constructing a sequence $\Psi_{N}$ of approximate ground states satisfying complete Bose-Einstein condensation. The concrete construction of $\Psi_{N}$ will be part of Subsection 2.1, where we introduce a suitable localization method and verify that mass does not escape to infinity. In the following Subsection 2.2, we will use this to verify complete Bose-Einstein condensation of the sequence $\Psi_{N}$.

### 2.1. Localization of the Ground State

In the following we are constructing a sequence of states $\Psi_{N}$, i.e. elements satisfying $\left\|\Psi_{N}\right\|=1$, localized only to configurations $x \in \mathbb{R}^{N \times d}$ centered at zero, such that
$\left\langle H_{N}\right\rangle_{\Psi_{N}}=E_{N}+o_{N \rightarrow \infty}(1)$. For such a sequence we will verify that mass cannot escape to infinity. As it turns out, the regularized median $M_{N}$, which we will define in the subsequent Definition [2.1, is the right statistical quantity to measure the center

x_{\text {center }}:=\left(M_{N, k}\left(x_{1}^{(1)}, \ldots, x_{1}^{(N)}\right), \ldots, M_{N, k}\left(x_{d}^{(1)}, \ldots, x_{d}^{(N)}\right)\right) \in \mathbb{R}^{d}
$$

of a configuration $x=\left(x^{(1)}, \ldots, x^{(N)}\right) \in \mathbb{R}^{N \times d}$, where $x^{(j)}=\left(x_{1}^{(j)}, \ldots, x_{d}^{(j)}\right) \in \mathbb{R}^{d}$ is the coordinate vector of the $j$-th particle.
Definition 2.1 (Localization). Given $N \in \mathbb{N}$ and $k$ such that $k+\frac{N}{2} \in \mathbb{N}$, we define the regularized median $M_{N, k}: \mathbb{R}^{N} \longrightarrow \mathbb{R}$ as the unique permutation-invariant function that is defined for all $x^{(1)} \leq \cdots \leq x^{(N)}$ as

$$
M_{N, k}\left(x^{(1)}, \ldots, x^{(N)}\right):=\frac{1}{2 k+1} \sum_{j=\frac{N}{2}-k}^{\frac{N}{2}+k} x^{(j)} .
$$

In the IMS-type estimate of the following Lemma [2.2, which has been proven in [17, Lemma 7], we will make use of the specific structure of the operator $T=\left(m^{2}-\Delta\right)^{s}-$ $m^{2 s}$. Note that this is the only place where the specific structure is relevant for us.

Lemma 2.2. Let $T=\left(m^{2}-\Delta\right)^{s}-m^{2 s}$ be as in Assumption 1.1 and let $\left\{\chi_{i}: i \in I\right\}$ be a family of $W^{1, \infty}\left(\mathbb{R}^{d}\right)$ functions with $\sum_{i} \chi_{i}^{2}=1$. With the definition $C:=m^{2(s-1)} s$ we have for all states $u \in L^{2}\left(\mathbb{R}^{d}\right)$

$$
\sum_{i \in I}\langle T\rangle_{\chi_{i} u} \leq\langle T\rangle_{u}+C\left\|\sum_{i \in I}\left|\nabla \chi_{i}\right|^{2}\right\|_{\infty} .
$$

Lemma 2.3. Let $E_{N}$ denote the ground state energy of $H_{N}$ and let $k_{N}$ be a sequence with $\sqrt{N} \ll k_{N} \ll N$ such that $k_{N}+\frac{N}{2} \in \mathbb{N}$. Then there exists a sequence of states $\Psi_{N}$ in $L_{\text {sym }}^{2}\left(\mathbb{R}^{N \times d}\right)$ with $\left\langle H_{N}\right\rangle_{\Psi_{N}}-E_{N} \underset{N \rightarrow \infty}{\longrightarrow} 0$ and a sequence $0<\alpha_{N} \ll 1$, such that

$$
\left|M_{N, k_{N}}\left(x_{r}^{(1)}, \ldots, x_{r}^{(N)}\right)\right| \leq \alpha_{N}
$$

for all $x \in \operatorname{supp}\left(\Psi_{N}\right) \subset \mathbb{R}^{N \times d}$ and $r \in\{1, \ldots, d\}$.
Proof. Let $0<\alpha_{N} \leq 1$ be a sequence with $\frac{\sqrt{N}}{k_{N}} \ll \alpha_{N} \ll 1$ and let $\nu_{\ell}: \mathbb{R} \rightarrow \mathbb{R}, \ell \in \mathbb{Z}$, be a family of $C^{\infty}$ functions with $\sum_{\ell \in \mathbb{Z}} \nu_{\ell}^{2}=1, \operatorname{supp}\left(\nu_{\ell}\right) \subset(\ell-1, \ell+1)$ and $\nu_{\ell}(x)=\nu_{0}(x-\ell)$. Then we define the family of functions $\chi \ell, r: \mathbb{R}^{N \times d} \longrightarrow \mathbb{R}$ with $\ell \in \mathbb{Z}$ and $r \in\{1, \ldots, d\}$ as

\chi_{\ell, r}(x):=\nu_{\ell}\left(\frac{1}{\alpha_{N}} M_{N, k_{N}}\left(x_{r}^{(1)}, \ldots, x_{r}^{(N)}\right)\right)
$$

and for $\ell=\left(\ell_{1}, \ldots, \ell_{d}\right) \in \mathbb{Z}^{d}$ we define $\chi_{\ell}:=\chi_{\ell_{1}, 1} \ldots \chi_{\ell_{d}, d}$. First of all $\sum_{\ell \in \mathbb{Z}^{d}} \chi_{\ell}^{2}=$ $\left(\sum_{\ell_{1} \in \mathbb{Z}} \chi_{\ell_{1}, 1}^{2}\right) \ldots\left(\sum_{\ell_{d} \in \mathbb{Z}} \chi_{\ell_{d}, d}^{2}\right)=1$. Furthermore, for any $x \in \mathbb{R}^{N \times d}$ the family of
smooth functions $\left\{\chi_{\ell}: \ell \in \mathbb{Z}^{d}\right\}$ satisfies $\#\left\{\ell \in \mathbb{Z}^{d}: \chi_{\ell}(x) \neq 0\right\}=\# \prod_{r=1}^{d}\{z \in \mathbb{Z}$ : $\left.\chi_{z, r}(x) \neq 0\right\} \leq 2^{d}$. With the definition $C_{d}:=2^{d} C$, where $C$ is the constant from Lemma 2.2, we obtain any state $\Psi \in L^{2}\left(\mathbb{R}^{N \times d}\right)$
$\sum_{j=1}^{N}\left\langle T_{j}\right\rangle_{\Psi} \geq \sum_{j=1}^{N} \sum_{\ell \in \mathbb{Z}^{d}}\left\langle T_{j}\right\rangle_{\chi_{\ell} \Psi}-C_{d} \sum_{j=1}^{N} \sup _{\ell \in \mathbb{Z}^{d}}\left\|\left|\nabla_{j} \chi_{\ell}\right|^{2}\right\|_{\infty} \geq \sum_{j=1}^{N} \sum_{\ell \in \mathbb{Z}^{d}}\left\langle T_{j}\right\rangle_{\chi_{\ell} \Psi}-N \frac{C_{d} d}{\alpha_{N}^{2} k_{N}^{2}}\left\|\nu_{0}^{\prime}\right\|_{\infty}^{2}$,
where we used the fact that $\left|\nabla_{j} \chi_{\ell}\right|^{2} \leq \sum_{r=1}^{d}\left|\partial_{j} \chi_{\ell_{r}, r}\right|^{2} \leq \sum_{r=1}^{d} \frac{1}{\alpha_{N}^{2}}\left\|\nu_{\ell_{r}}^{\prime}\right\|_{\infty}^{2}\left\|\partial_{j} M_{N, k_{N}}\right\|_{\infty}^{2}$, $\left\|\partial_{j} M_{N, k_{N}}\right\|_{\infty} \leq \frac{1}{k_{N}}$ and $\left\|\nu_{z}^{\prime}\right\|_{\infty}=\left\|\nu_{0}^{\prime}\right\|_{\infty}$ for any $z \in \mathbb{Z}$. By our choice of $\alpha_{N}$ it is clear that $\epsilon_{N}:=N \frac{C_{d} d}{\alpha_{N}^{2} k_{N}^{2}}\left\|\nu_{0}^{\prime}\right\|_{\infty}^{2} \underset{N \rightarrow \infty}{\longrightarrow} 0$. In the following let $\Phi_{N}$ be a sequence of states with $\left\langle H_{N}\right\rangle_{\Phi_{N}}-E_{N} \underset{N \rightarrow \infty}{\longrightarrow} 0$, and let us define $\rho_{N, \ell}:=\left\|\chi_{\ell} \Phi_{N}\right\|^{2}$ as well as $\Phi_{N, \ell}:=\rho_{N, \ell}^{-\frac{1}{2}} \chi_{\ell} \Phi_{N}$. Since $\Phi_{N}$ is a state, it is clear that $\sum_{\ell} \rho_{N, \ell}=1$. We have the estimate

$$
\sum_{\ell \in \mathbb{Z}^{d}} \rho_{N, \ell}\left\langle H_{N}\right\rangle_{\Phi_{N, \ell}} \leq \sum_{j=1}^{N}\left\langle T_{j}\right\rangle_{\Phi_{N}}+\epsilon_{N}+\frac{1}{N-1} \sum_{i<j}\left\langle v\left(x_{i}-x_{j}\right)\right\rangle_{\Phi_{N}}=\left\langle H_{N}\right\rangle_{\Phi_{N}}+\epsilon_{N}
$$

and therefore there exists at least one $l \in \mathbb{Z}^{d}$ such that $\left\langle H_{N}\right\rangle_{\Phi_{N, \ell}} \leq\left\langle H_{N}\right\rangle_{\Phi_{N}}+\epsilon_{N}$. We can finally define $\Psi_{N}\left(x^{(1)}, \ldots, x^{(N)}\right):=\Phi_{N, \ell}\left(x^{(1)}+\xi, \ldots, x^{(N)}+\xi\right)$ with $\xi:=\alpha_{N} \ell$. By translation-invariance of $H_{N}$, we have $\left\langle H_{N}\right\rangle_{\Psi_{N}} \leq\left\langle H_{N}\right\rangle_{\Phi_{N}}+\epsilon_{N}$ and consequently $\left\langle H_{N}\right\rangle_{\Psi_{N}}-E_{N} \underset{N \rightarrow \infty}{\longrightarrow} 0$. Furthermore, $\Psi_{N}\left(x^{(1)}, \ldots, x^{(N)}\right) \neq 0$ implies for all $r \in\{1, \ldots, d\}$

$$
\frac{1}{\alpha_{N}} M_{N, k_{N}}\left(x_{r}^{(1)}+\xi_{r}, \ldots, x_{r}^{(N)}+\xi_{r}\right)=\frac{1}{\alpha_{N}} M_{N, k_{N}}\left(x_{r}^{(1)}, \ldots, x_{r}^{(N)}\right)+\ell_{r} \in \operatorname{supp}\left(\nu_{\ell_{r}}\right),
$$

and therefore $M_{N, k_{N}}\left(x_{r}^{(1)}, \ldots, x_{r}^{(N)}\right) \in\left(-\alpha_{N}, \alpha_{N}\right)$.
Recall the inequality $-(\lambda T+\Lambda) \leq v \leq|v| \leq \Lambda(T+1)$ from Assumption 1.1. Let us denote with $\hat{v}:=v(x-y)$ the two body multiplication operator associated to the interaction potential $v$. Due to the translation-invariance of $T$, we can promote the one body operator inequality from above to the two body operator inequality

$$
-(\lambda T+\Lambda) \otimes 1_{L^{2}\left(\mathbb{R}^{d}\right)} \leq \hat{v} \leq|\hat{v}| \leq \Lambda(T+1) \otimes 1_{L^{2}\left(\mathbb{R}^{d}\right)}
$$

As an immediate consequence of this inequality we have the following Lemma.

Lemma 2.4. Given Assumption 1.1, there exist constants $c$ and $\delta>0$ such that

$$
\delta \sum_{j=1}^{N}\left(T_{j}-c\right) \leq H_{N} \leq \delta^{-1} \sum_{j=1}^{N}\left(T_{j}+c\right)
$$

as well as $\frac{1}{N-1} \sum_{i<j}\left|v\left(x_{i}-x_{j}\right)\right| \leq c\left(H_{N}+N\right)$.

Definition 2.5. Let us define $n_{N, r, L}: \mathbb{R}^{N \times d} \longrightarrow \mathbb{R}$ as the density of particles $x^{(j)} \in \mathbb{R}^{d}$ that satisfy $x_{r}^{(j)} \geq L$, i.e. for a configuration $x=\left(x^{(1)}, \ldots, x^{(N)}\right) \in \mathbb{R}^{N \times d}$ with $x^{(j)}=$ $\left(x_{1}^{(j)}, \ldots, x_{d}^{(j)}\right) \in \mathbb{R}^{d}$ we define

n_{N, r, L}(x):=\frac{1}{N} \sum_{j=1}^{N} \mathbb{1}_{[L, \infty)}\left(x_{r}^{(j)}\right)
$$

Furthermore, let $\Omega_{N, r, L, \delta}$ be the set of all $x \in \mathbb{R}^{N \times d}$ that satisfy $n_{N, r, L}(x) \geq \delta$ and $M_{N, k_{N}}\left(x_{r}^{(1)}, \ldots, x_{r}^{(N)}\right)^{\leq} \leq \xi_{0}$, where $k_{N}$ is the sequence introduced in Lemma 2.3 and $\xi_{0}$ is some fixed positive number. Let $E_{N, r, L, \delta}$ denote the ground state energy of $H_{N}$ restricted to states $\Phi$ with $\operatorname{supp}(\Phi) \subset \Omega_{N, r, L, \delta}$.

Lemma 2.6. Given Assumption 1.1, there exist for all $\delta>0$ constants $\gamma_{\delta}>0, L_{0}(\delta)$ and $N_{0}(\delta)$, such that for all $r \in\{1, \ldots, d\}, L \geq L_{0}(\delta)$ and $N \geq N_{0}(\delta)$

Proof. According to Definition 2.5, for any configuration $x=\left(x^{(1)}, \ldots, x^{(N)}\right) \in \Omega_{N, r, L, \delta}$ there are at least $\frac{N}{2}-k_{N}$ particles $x^{(j)}$ such that $x_{r}^{(j)} \leq \xi_{0}$ and at least $\delta N$ particles $x^{(k)}$ such that $x_{r}^{(k)} \geq L$. Heuristically, this means that $\frac{N}{2}$ particles do not interact with $\delta N$ particles in case $L-\xi_{0}$ is large compared to the range of the interaction $v$. Since the interaction in Eq. (1.1) scales like $\frac{1}{N}$, the absence of $\frac{N}{2} \times \delta N$ interaction pairs corresponds to an increase in energy of order $N$. In order to make this rigorous, i.e. in order to verify Eq. (2.1), we will apply the ideas of geometric localization from [18, 19 . In the first step, we decompose the energy $\left\langle H_{N}\right\rangle_{\Psi}$ of a state $\Psi$ into a term $E_{-}$covering contributions from the left side $x_{r}^{(j)} \leq \xi+R$ with $\xi>\xi_{0}$ and $\xi+R<L$, a term $E_{+}$ covering contributions from the right side $x_{r}^{(j)} \geq \xi$ and a localization error depending on the length $R$ of the overlap $[\xi, \xi+R]$ of the two regions, which can be neglected for large separations $R \gg 1$. In the second step, we will verify that the sum of the local energies $E_{-}+E_{+}$is indeed larger than the ground state energy $E_{N}$ by a contribution of order $N$, which corresponds to the observation that $E_{-}+E_{+}$does not involve any interactions between particles on the left side and particles on the right side.

In the following let us fix an $r \in\{1, \ldots, d\}$, and let $f_{-}, f_{+}: \mathbb{R} \longrightarrow[0,1]$ be smooth functions with $f_{-}^{2}+f_{+}^{2}=1, f_{-}(t)=1$ for $t \leq 0$ and $f_{+}(t)=1$ for $t \geq 1$. Then we define for $\xi \in \mathbb{R}$ and $R>0$ the functions $f_{\xi, R, \pm}: \mathbb{R}^{d} \longrightarrow[0,1]$ as $f_{\xi, R, \pm}(x):=f_{ \pm}\left(\frac{x_{r}-\xi}{R}\right)$. This family of functions clearly satisfies $f_{\xi, R,-}(x)=1$ for $x_{r} \leq \xi, f_{\xi, R,-}(x)=0$ for $x_{r} \geq \xi+R, f_{\xi, R,+}(x)=1$ for $x_{r} \geq \xi+R$ and $f_{\xi, R,+}(x)=0$ for $x_{r} \leq \xi$. Furthermore, there exists a constant $k>0$ such that $\left|\nabla f_{\xi, R, \pm}\right|^{2} \leq \frac{k}{R^{2}}$. By Lemma 2.2 we have the IMS localization formula $T \geq f_{\xi, R,-} T f_{\xi, R,-}+f_{\xi, R,+} T f_{\xi, R,+}-\frac{K}{R^{2}}, K:=2 k C$. For a state $\Psi \in \bigotimes_{\mathrm{s}}^{N} L^{2}\left(\mathbb{R}^{d}\right)$, let us denote with $\gamma^{(k)}$ its reduced density matrices and with $\rho^{(k)}$ the corresponding density functions, and let us further define the localized objects
$\gamma_{\xi, R, \pm}^{(k)}:=f_{\xi, R, \pm}^{\otimes^{k}} \gamma^{(k)} f_{\xi, R, \pm}^{\otimes^{k}}$ and the corresponding density functions $\rho_{\xi, R, \pm}^{(k)}\left(x_{1}, \ldots, x_{k}\right):=$ $\rho^{(k)}\left(x_{1}, \ldots, x_{k}\right) f_{\xi, R, \pm}\left(x_{1}\right)^{2} \ldots f_{\xi, R, \pm}\left(x_{k}\right)^{2}$. Then,

& =\operatorname{Tr}\left[\gamma^{(1)} T\right]+\frac{1}{2} \iint \rho^{(2)}(x, y)\left[f_{\xi, R,-}^{2}+f_{\xi, R,+}^{2}\right](x)\left[f_{\xi, R,-}^{2}+f_{\xi, R,+}^{2}\right](y) v(x-y) \mathrm{d} x \mathrm{~d} y \\
& \geq E_{-}+E_{+}+\iint \rho^{(2)}(x, y) f_{\xi, R,-}(x)^{2} f_{\xi, R,+}(y)^{2} v(x-y) \mathrm{d} x \mathrm{~d} y-\frac{K}{R^{2}}
\end{aligned}
$$

where we define

$$
\begin{equation*}
E_{ \pm}=\operatorname{Tr}\left[\gamma_{\xi, R, \pm}^{(1)} T\right]+\frac{1}{2} \iint \rho_{\xi, R, \pm}^{(2)}(x, y) v(x-y) \mathrm{d} x \mathrm{~d} y \tag{2.2}
\end{equation*}
$$

Note that we have $v_{R}:=\sup _{|x| \geq R}|v(x)| \underset{R \rightarrow \infty}{\longrightarrow} 0$ by Assumption 1.1, and therefore we can estimate the localization error $\left|\iint \rho^{(2)}(x, y) f_{\xi, R,-}\left(x_{r}\right)^{2} f_{\xi, R,+}\left(y_{r}\right)^{2} v(x-y)\right|$ by

where we used the fact that $x \in \operatorname{supp}\left(f_{\xi, R,-}\right), y \in \operatorname{supp}\left(f_{\xi, R,+}\right)$ and $\left|x_{r}-y_{r}\right|<R$ is only possible in case $\left|x_{r}-\xi\right|<R$. Let us now define for $n \in \mathbb{N}$ and $m \leq n$ the points $\xi_{m}:=\xi_{0}+2 R m$. Clearly, the intervals $\left[\left|x_{r}-\xi_{m}\right|<R\right]$ are disjoint and therefore Lemma 2.4 yields

Hence, there exists an $m_{*} \leq n$ such that $\iint_{\left[\left|x_{r}-\xi_{m_{*}}\right|<R\right]} \rho^{(2)}(x, y)|v(x-y)| \leq \frac{2 c}{n N}\left\langle H_{N}\right\rangle_{\Psi}+$ $\frac{2 c}{n}$. We conclude that for $n \in \mathbb{N}$, there exists a $\xi$ with $\xi_{0} \leq \xi \leq \xi_{0}+2 n R$ such that

Let us now investigate the local energy contributions $E_{ \pm}$. As a first step, we follow the framework in [19] and define the mixed $\ell$ particle states

where we used the notion $\operatorname{Tr}_{\ell+1 \rightarrow N}[$.$] for the partial trace over the indices \ell+1, \ldots, N$. These mixed states satisfy $\operatorname{Tr}\left[G_{\ell,-}\right]=\operatorname{Tr}\left[G_{N-\ell,+}\right]$ as well as $\sum_{\ell=0}^{N} \operatorname{Tr}\left[G_{\ell,-}\right]=1$. Furthermore, it was shown in [19] that we can use these mixed states to express the localized
density matrices as

where $G_{\ell, \pm}^{(k)}$ is the $k$-th reduced density matrix of $G_{\ell, \pm}$. In the following, let us assume that the state $\Psi$ satisfies $\operatorname{supp}(\Psi) \subset \Omega_{N, r, L_{0}, \delta}$ with $\delta>0$ and $L_{0}>\xi_{0}+R$, i.e. all $x \in \operatorname{supp}(\Psi)$ satisfy $M_{N, k_{N}}(x) \leq \xi_{0}$ and $n_{N, r, L_{0}}(x) \geq \delta$. The first condition $M_{N, k_{N}}(x) \leq \xi_{0}$ implies that at most $\frac{N}{2}+k_{N}$ indices $j$ satisfy $x_{r}^{(j)}>\xi_{0}$ and the second condition $n_{N, r, L_{0}}(x) \geq \delta$ is equivalent to the fact that at most $\lceil(1-\delta) N\rceil$ indices satisfy $x_{r}^{(j)}<L_{0}$. Let us denote $N_{*}(N):=\max \left(\frac{N}{2}+k_{N},\lceil(1-\delta) N\rceil\right)$. From the support properties of $f_{\xi, R, \pm}$ we obtain for all $\xi$ with $\xi_{0}<\xi<L_{0}-R$ and $x \in \operatorname{supp}(\Psi)$, that $f_{\xi, R,+}\left(x^{(1)}\right) \ldots f_{\xi, R,+}\left(x^{(\ell)}\right)=0$ for all $\ell>N_{*}(N)$ and $f_{\xi, R,-}\left(x^{(\ell+1)}\right) \ldots f_{\xi, R,-}\left(x^{(N)}\right)=0$ for all $N-\ell>N_{*}(N)$. Hence, we obtain for all $\ell$ with either $\ell>N_{*}(N)$ or $\ell<N-N_{*}(N)$, and $\xi$ with $\xi_{0}<\xi<L_{0}-R$

\begin{aligned}
& \binom{N}{\ell}^{-1} \operatorname{Tr}\left[G_{\ell,+}\right]=\operatorname{Tr}\left[f_{\xi, R,+}^{\otimes \ell} \otimes f_{\xi, R,-}^{\otimes^{N-\ell}}|\Psi\rangle\langle\Psi| f_{\xi, R,+}^{\otimes^{\ell}} \otimes f_{\xi, R,-}^{\otimes^{N-\ell}}\right] \\
& =\int_{\operatorname{supp}(\Psi)} f_{\xi, R,+}\left(x^{(1)}\right)^{2} \ldots f_{\xi, R,+}\left(x^{(\ell)}\right)^{2} f_{\xi, R,-}\left(x^{(\ell+1)}\right)^{2} \ldots f_{\xi, R,-}\left(x^{(N)}\right)^{2}|\Psi|^{2} \mathrm{~d} x=0,
\end{aligned}
$$

and since $G_{\ell,+} \geq 0$ this implies $G_{\ell,+}=0$ for all such $\ell$. Using $\operatorname{Tr}\left[G_{\ell,-}\right]=\operatorname{Tr}\left[G_{N-\ell,+}\right]$, we also obtain $G_{\ell,-}=0$ for all $\ell$ with $\ell>N_{*}(N)$, respectively $\ell<N-N_{*}(N)$.

Let us define rescaled versions $H_{\ell}^{(\lambda)}:=\sum_{j=1}^{\ell} T_{j}+\frac{1}{\ell-1} \sum_{i<j}^{\ell} \lambda v\left(x_{i}-x_{j}\right)$ of the Hamiltonian $H_{N}$ and let us denote the corresponding ground state energy by $E_{\ell}^{(\lambda)}:=\inf \sigma\left(H_{\ell}^{\lambda}\right)$. Note that there exists a $\delta$-dependent $\kappa_{\delta}<1$ and $N_{1} \in \mathbb{N}$, such that $\frac{N_{*}(N)-1}{N-1} \leq \kappa_{\delta}$ for all $N \geq N_{1}$. Applying Eq. (2.4) together with the identity $\operatorname{Tr}\left[G_{\ell, \pm}^{(1)} T\right]+\frac{l-1}{N-1} \frac{1}{2} \operatorname{Tr}\left[G_{\ell, \pm}^{(2)} \hat{v}\right]=$ $\operatorname{Tr}\left[\frac{1}{\ell} H_{\ell}^{\left(\frac{\ell-1}{N-1}\right)} G_{\ell, \pm}\right]$ yields for all $N \geq N_{1}$ and $\xi$ with $\xi_{0}<\xi<L_{0}-R$

E_{ \pm} & =\operatorname{Tr}\left[\gamma_{\xi, R, \pm}^{(1)} T\right]+\frac{1}{2} \iint \rho_{\xi, R, \pm}^{(2)}(x, y) v(x-y) \mathrm{d} x \mathrm{~d} y=\frac{1}{N} \sum_{\ell=N-N_{*}(N)}^{N_{*}(N)} \operatorname{Tr}\left[H_{\ell}^{\left(\frac{\ell-1}{N-1}\right)} G_{\ell, \pm}\right] \\
& \geq \frac{1}{N} \sum_{\ell=N-N_{*}(N)}^{N_{*}(N)} E_{\ell}^{\left(\frac{l-1}{N-1}\right)} \operatorname{Tr}\left[G_{\ell, \pm}\right] \geq \frac{1}{N} \sum_{l=N-N_{*}(N)}^{N} \kappa_{\delta} E_{\ell} \operatorname{Tr}\left[G_{\ell, \pm}\right] \\
& \geq \kappa_{\delta} \min _{\ell \geq N-N_{*}(N)}\left(\frac{1}{\ell} E_{\ell}\right) \frac{1}{N} \sum_{l=0}^{N} \ell \operatorname{Tr}\left[G_{\ell, \pm}\right],
\end{aligned}
$$

where we used $H_{k}^{\left(\lambda_{1}\right)} \geq \frac{\lambda_{1}}{\lambda_{2}} H_{k}^{\left(\lambda_{2}\right)}$ for all $\lambda_{1} \leq \lambda_{2}$ as well as the fact that $E_{\ell}=E_{\ell}^{(1)}<0$, which is a direct consequence of the assumption $e_{\mathrm{H}}<0$. Observe that

Furthermore, Assumption 1.1 enables us to apply the results in [19], which tell us that $\lim _{\ell} \frac{1}{\ell} E_{\ell}=e_{\mathrm{H}}$, and since $N-N_{*}(N) \underset{N \rightarrow \infty}{\longrightarrow} \infty$, we obtain that $\min _{\ell \geq N-N_{*}(N)} \frac{1}{\ell} E_{\ell} \underset{N \rightarrow \infty}{ } e_{\mathrm{H}}$ as well. For $R>0$ and $n \in \mathbb{N}$, let us define $L_{0}:=\xi_{0}+(2 n+1) R$. Combining Inequalities (2.3) and (2.5), we obtain

Since $\kappa_{\delta}<1$ and $e_{\mathrm{H}}<0$, we can choose $R_{\delta}$ and $n_{\delta}$ large enough, such that $\beta_{\delta}:=$ $\left(\kappa_{\delta}-1\right) e_{\mathrm{H}}-\frac{K}{R_{\delta}^{2}}-v_{R_{\delta}}-\frac{2 c}{n_{\delta}}>0$. With the choice $L_{0}(\delta):=\xi_{0}+\left(2 n_{\delta}+1\right) R_{\delta}$ we conclude

\liminf _{N \rightarrow \infty} \frac{1}{N}\left[E_{N, r, L_{0}(\delta), \delta}-E_{N}\right] & \geq \liminf _{N \rightarrow \infty} \frac{1}{N}\left(\min \left[\left(1+\frac{2 c}{n_{\delta}}\right) E_{N, r, L_{0}(\delta), \delta}, 0\right]-E_{N}\right) \\
& \geq \min \left(\beta_{\delta},-e_{\mathrm{H}}\right)>0
\end{aligned}
$$

Corollary 2.7. Let Assumption 1.1 hold and $\Psi_{N}$ be a sequence as in Lemma 2.3. Then,

Proof. In the following, let $\chi: \mathbb{R} \longrightarrow[0,1]$ be a function with $\chi(x)=0$ for $x \leq 1$ and $\chi(x)=1$ for $x \geq 2$, such that $\chi$ and $\sqrt{1-\chi^{2}}$ are $C^{\infty}$. Then we define

$g_{N, r, L, \delta}(x):=\sqrt{1-f_{N, r, L, \delta}^{2}}$ and $\alpha:=\left\|\chi^{\prime}\right\|_{\infty}^{2}\left(\left\|\chi^{\prime}\right\|_{\infty}^{2}+\left\|\sqrt{1-\chi^{2}}\right\|_{\infty}^{2}\right)$. Note that we have $\operatorname{supp}\left(f_{N, r, L, \delta} \Psi_{N}\right) \subset \Omega_{N, r, \frac{L}{2}, \delta}$. Therefore the localization formula from Lemma 2.2 and the result from Lemma 2.6 tell us that there exists a $\gamma_{\delta}>0$ such that for all $L \geq 2 L_{0}(\delta)$ and $N \geq N_{0}(\delta)$

& \geq\left(E_{N}+\gamma_{\delta} N\right)\left\|f_{N, r, L, \delta} \Psi_{N}\right\|^{2}+E_{N}\left(1-\left\|f_{N, r, L, \delta} \Psi_{N}\right\|^{2}\right)-\frac{4 C}{\delta^{2} N L^{2}} \alpha .
\end{aligned}
$$

Consequently, $0 \leq\left\|f_{N, r, L, \delta} \Psi_{N}\right\|^{2} \leq \frac{\left\langle H_{N}\right\rangle_{\Psi_{N}}-E_{N}+\frac{4 C}{\delta^{2} N L^{2}} \alpha}{\gamma_{\delta} N} \underset{N \rightarrow \infty}{\longrightarrow} 0$. Furthermore, note that $x \in \operatorname{supp}\left(g_{N, r, L, \delta}\right)$ implies $n_{N, r, L}(x) \leq \frac{1}{N} \sum_{j=1}^{N} \chi\left(\frac{2 x^{(j)}}{L}\right) \leq 2 \delta$ and therefore

### 2.2. Convergence to a Single Condensate

It was shown in [19] that under quite general assumptions, including ours, on the decay and regularity of the interaction potential $v$, there exists for any sequence of states $\Phi_{N}$ with $\left\langle H_{N}\right\rangle_{\Phi_{N}}=E_{N}+o(N)$ a probability measure $\nu$ supported on the set of (not necessarily normed) Hartree minimizers $\left\{u \in \mathcal{H}: \mathcal{E}_{\mathrm{H}}[u]=e_{\mathrm{H}}(\|u\|)\right\}$, where $e_{\mathrm{H}}(s):=$ $\inf _{\|v\|=s} \mathcal{E}_{\mathrm{H}}[v]$, such that a subsequence of the sequence $\gamma_{\Phi_{N}}^{(k)}$ converges weakly to the state $\int(|u\rangle\langle u|)^{\otimes^{k}} \mathrm{~d} \nu(u)$ for all $k \in \mathbb{N}$, i.e.

$$
\begin{equation*}
\operatorname{Tr}\left[\gamma_{\Phi_{N_{j}}}^{(k)} B\right] \underset{j \rightarrow \infty}{\longrightarrow} \int \operatorname{Tr}\left[(|u\rangle\langle u|)^{\otimes^{k}} B\right] \mathrm{d} \nu(u) \tag{2.6}
\end{equation*}
$$

for any compact $k$ particle operator $B$. In Lemma [2.8, we will lift this weak convergence to a strong one for the sequence of approximate ground states $\Psi_{N}$ constructed in Lemma 2.3, by using the fact that mass cannot escape to infinity as a consequence of Corollary 2.7. In this context, strong convergence means that Eq. (2.6) holds for all bounded $k$ particle operators $B$, and not only compact ones. In particular, $\|u\|=1$ on the support of $\nu$.

Lemma 2.8 (Strong Convergence). Let $\Psi_{N}$ be the sequence from Lemma 2.3 and let $\gamma_{N}^{(k)}$ denote the corresponding reduced density matrices. Given Assumption 1.1, there exists a probability measure $\mu$ supported on $\mathbb{R}^{d}$ and a subsequence $N_{j}$, such that for any bounded $k$ particle operator $B$

$$
\operatorname{Tr}\left[\gamma_{N_{j}}^{(k)} B\right] \underset{j \rightarrow \infty}{\longrightarrow} \int_{\mathbb{R}^{d}} \operatorname{Tr}\left[\left(\left|u_{0, t}\right\rangle\left\langle u_{0, t}\right|\right)^{\otimes^{k}} B\right] \mathrm{d} \mu(t),
$$

where $u_{0, t}$ is defined in Assumption 1.1.
Proof. As was shown in [19], any sequence of approximate ground states, such as $\Psi_{N}$, has a subsequence $N_{j}$ that converges weakly to a convex combination of product states over Hartree minimizers, i.e. there exists a probability measure $\nu$ supported on the set of Hartree minimizers $u$ with $\|u\| \leq 1$, such that Eq. (2.6) holds for any compact $k$ particle operator $B$. As the central step of this proof, we will verify that the measure $\nu$ satisfies the identity $\int\|u\|^{2} \mathrm{~d} \nu(u)=1$. By Corollary 2.7 we know that

$$
\lim _{L \rightarrow \infty} \limsup _{j \rightarrow \infty} \operatorname{Tr}\left[\gamma_{N_{j}}^{(1)} \mathbb{1}_{\left[x_{r}>L\right]}\right]=\lim _{L \rightarrow \infty} \limsup _{j \rightarrow \infty}\left\langle n_{N_{j}, r, L}\right\rangle_{\Psi_{N_{j}}}=0 .
$$

Since the reflected states $x \mapsto \Psi_{N}(-x)$ still satisfy the conditions of Corollary 2.7 we obtain $\lim _{L \rightarrow \infty} \limsup _{j \rightarrow \infty} \operatorname{Tr}\left[\gamma_{N_{j}}^{(1)} \mathbb{1}_{\left[x_{r}<-L\right]}\right]=0$ as well. Consequently,

$$
\lim _{L \rightarrow \infty} \liminf _{j \rightarrow \infty} \operatorname{Tr}\left[\gamma_{N_{j}}^{(1)} \mathbb{1}_{[-L, L]^{d}}\right]=1
$$

Since the operator $\mathbb{1}_{[-L, L]^{d}}$ is not compact, we cannot immediately apply the convergence (2.6) for $B:=\mathbb{1}_{[-L, L]^{d}}$. In order to obtain a convergence in a stronger sense, note that by Lemma [2.4 we have a uniform bound on the kinetic energy of $\gamma_{N_{j}}^{(1)}$, i.e. there exists a constant $C<\infty$, such that

$$
\operatorname{Tr}\left[(T+1)^{\frac{1}{2}} \gamma_{N_{j}}^{(1)}(T+1)^{\frac{1}{2}}\right] \leq C
$$

for all $j \in \mathbb{N}$. Since the trace class operators are the dual space of the compact operators, there exists by the Banach-Alaoglu theorem a trace class operator $\gamma$ and a subsequence, which we will still denote by $N_{j}$ for the sake of readability, such that for any compact one particle operator $K$

$$
\operatorname{Tr}\left[(T+1)^{\frac{1}{2}} \gamma_{N_{j}}^{(1)}(T+1)^{\frac{1}{2}} K\right] \underset{j \rightarrow \infty}{\longrightarrow} \operatorname{Tr}[\gamma K] .
$$

This in particular yields $\operatorname{Tr}\left[\gamma_{N_{j}}^{(1)} B\right] \underset{j \rightarrow \infty}{\longrightarrow} \operatorname{Tr}\left[(T+1)^{-\frac{1}{2}} \gamma(T+1)^{-\frac{1}{2}} B\right]$ for any compact $B$, and consequently $(T+1)^{-\frac{1}{2}} \gamma(T+1)^{-\frac{1}{2}}=\int|u\rangle\langle u| \mathrm{d} \nu(u)$ by Eq. (2.6). Since the kinetic energy is of the form $T=t(i \nabla)$ with $t(p) \underset{|p| \rightarrow \infty}{\longrightarrow} \infty$, the operator $K:=$ $(T+1)^{-\frac{1}{2}} \mathbb{1}_{[-L, L]^{d}}(T+1)^{-\frac{1}{2}}$ is compact. Collecting all the results we have obtained so far yields

$$
\begin{aligned}
1 & =\lim _{L \rightarrow \infty} \liminf _{j \rightarrow \infty} \operatorname{Tr}\left[\gamma_{N_{j}}^{(1)} \mathbb{1}_{[-L, L]^{d}}\right]=\lim _{L \rightarrow \infty} \liminf _{j \rightarrow \infty} \operatorname{Tr}\left[(T+1)^{\frac{1}{2}} \gamma_{N_{j}}^{(1)}(T+1)^{\frac{1}{2}} K\right] \\
& =\lim _{L \rightarrow \infty} \operatorname{Tr}\left[(T+1)^{-\frac{1}{2}} \gamma(T+1)^{-\frac{1}{2}} \mathbb{1}_{[-L, L]^{d}}\right]=\lim _{L \rightarrow \infty} \int \operatorname{Tr}\left[|u\rangle\langle u| \mathbb{1}_{[-L, L]^{d}}\right] \mathrm{d} \nu(u) \\
& =\int \operatorname{Tr}[|u\rangle\langle u|] \mathrm{d} \nu(u)=\int\|u\|^{2} \mathrm{~d} \nu(u) .
\end{aligned}
$$

As an immediate consequence we obtain that $\nu$ is supported on Hartree minimizers $u$ with $\|u\|=1$. By Assumption 1.1, we know that all such Hartree minimizers are given by $e^{i \theta} u_{0, t}$ with $\theta \in[0,2 \pi)$ and $t \in \mathbb{R}^{d}$. Recall that $\left|e^{i \theta} u_{0, t}\right\rangle\left\langle e^{i \theta} u_{0, t}\right|=\left|u_{0, t}\right\rangle\left\langle u_{0, t}\right|$ defines the same density matrix for all complex phases $e^{i \theta}$. Therefore, defining the measure $\mu(A):=\nu\left(\left\{u_{0, t}: t \in A, \theta \in[0,2 \pi)\right\}\right)$ yields

$$
\begin{equation*}
\operatorname{Tr}\left[\gamma_{N_{j}}^{(k)} B\right] \underset{j \rightarrow \infty}{\longrightarrow} \int_{\mathbb{R}^{d}} \operatorname{Tr}\left[\left(\left|u_{0, t}\right\rangle\left\langle u_{0, t}\right|\right)^{\otimes^{k}} B\right] \mathrm{d} \mu(t) \tag{2.7}
\end{equation*}
$$

for all compact operators $B$. Since $\lim _{j} \operatorname{Tr}\left[\gamma_{N_{j}}^{(1)}\right]=1=\int_{\mathbb{R}^{d}} \operatorname{Tr}\left[\left|u_{0, t}\right\rangle\left\langle u_{0, t}\right|\right] \mathrm{d} \mu(t)$, this convergence holds even in the strong sense, see [33], i.e. the convergence (2.6) holds for all bounded operator $B$.

Lemma 2.9. Let $\Psi_{N}$ be the sequence from Lemma 2.3. For any $\epsilon>0$ and $r \in\{1, \ldots, d\}$, consider the bounded two particle operator $B_{\epsilon, r}:=\mathbb{1}_{\left[x_{r} \leq \epsilon\right]} \mathbb{1}_{\left[y_{r} \geq-\epsilon\right]}+\mathbb{1}_{\left[y_{r} \leq \epsilon\right]} \mathbb{1}_{\left[x_{r} \geq-\epsilon\right]}$. Then

$$
\liminf _{N \rightarrow \infty} \operatorname{Tr}\left[\gamma_{N}^{(2)} B_{\epsilon, r}\right] \geq \frac{1}{2}
$$

Proof. With the help of the function $f_{N, \epsilon, r}:=\frac{2}{N(N-1)} \sum_{i \neq j} \mathbb{1}_{\left[x_{r}^{(i)} \leq \epsilon\right]} \mathbb{1}_{\left[x_{r}^{(j)} \geq-\epsilon\right]}$ we have

$$
\operatorname{Tr}\left[\gamma_{N}^{(2)} B_{\epsilon, r}\right]=\int_{\mathbb{R}^{N \times d}} f_{N, \epsilon, r}(x)\left|\Psi_{N}\right|^{2} \mathrm{~d} x
$$

Let $\alpha_{N}$ and $k_{N}$ be the sequences introduced in Lemma 2.3 and let $N$ be large enough such that $\alpha_{N}<\epsilon$. Then, $\left|M_{N, k_{N}}\left(x_{r}^{(1)}, \ldots, x_{r}^{(N)}\right)\right|<\epsilon$ for all $x \in \operatorname{supp}\left(\Psi_{N}\right)$, and therefore at least $\frac{N}{2}-k_{N}$ particles satisfy $x_{r} \leq \epsilon$ and at least $\frac{N}{2}-k_{N}$ particles satisfy $-\epsilon \leq x_{r}$. Consequently

$$
f_{N, \epsilon, r}(x) \geq \frac{2}{N(N-1)}\left(\frac{N}{2}-k_{N}\right)^{2} \underset{N \rightarrow \infty}{\longrightarrow} \frac{1}{2},
$$

and therefore $\liminf _{N \rightarrow \infty} \int_{\mathbb{R}^{N \times d}} f_{N, \epsilon, r}(x)\left|\Psi_{N}\right|^{2} \mathrm{~d} x \geq \frac{1}{2}$.
Lemma 2.10. The measure $\mu$ from Lemma 2.8 is supported on $\{0\} \subset \mathbb{R}^{d}$, i.e. $\mu=\delta_{0}$.
Proof. Let us define the density function $\rho(x):=\left|u_{0}(x)\right|^{2}$, as well as the marginal density function $\rho_{r}\left(x_{r}\right):=\int \rho(x) \mathrm{d} x_{1} \ldots \mathrm{~d} x_{r-1} \mathrm{~d} x_{r+1} \ldots \mathrm{~d} x_{d}$ and the marginal measure $\mu_{r}(A):=$ $\mu\left(\left[x_{r} \in A\right]\right)$. Note that the two particle density function corresponding to $\left(\left|u_{0, t}\right\rangle\left\langle u_{0, t}\right|\right)^{\otimes^{2}}$ is given by $\rho(x-t) \rho(y-t)$, and therefore Lemmata 2.8 and 2.2 imply

$$
\begin{aligned}
& \frac{1}{2} \leq \lim _{j} \operatorname{Tr}\left[\gamma_{N_{j}}^{(2)} B_{\epsilon, r}\right]=\int_{\mathbb{R}^{d}} \operatorname{Tr}\left[\left(\left|u_{0, t}\right\rangle\left\langle u_{0, t}\right|\right)^{\otimes^{2}} B_{\epsilon, r}\right] \mathrm{d} \mu(t) \\
& =2 \int_{\mathbb{R}}\left(\int_{-\infty}^{t_{r}+\epsilon} \rho_{r}\left(x_{r}\right) \mathrm{d} x_{r}\right)\left(\int_{t_{r}-\epsilon}^{\infty} \rho_{r}\left(x_{r}\right) \mathrm{d} x_{r}\right) \mathrm{d} \mu_{r}\left(t_{r}\right) \\
& =2 \int_{\mathbb{R}} f_{r}\left(t_{r}+\epsilon\right)\left(1-f_{r}\left(t_{r}-\epsilon\right)\right) \mathrm{d} \mu_{r}\left(t_{r}\right) \underset{\epsilon \rightarrow 0}{\longrightarrow} 2 \int_{\mathbb{R}} f_{r}\left(t_{r}\right)\left(1-f_{r}\left(t_{r}\right)\right) \mathrm{d} \mu_{r}\left(t_{r}\right)
\end{aligned}
$$

with the definition $f_{r}(s):=\int_{-\infty}^{s} \rho_{r}\left(x_{r}\right) \mathrm{d} x_{r}$, where we have used dominated convergence and continuity of $f_{r}$. Hence we obtain the inequality

$$
\int_{\mathbb{R}} f_{r}\left(t_{r}\right)\left(1-f_{r}\left(t_{r}\right)\right) \mathrm{d} \mu_{r}\left(t_{r}\right) \geq \frac{1}{4}
$$

Since the function $h(q):=q(1-q)$ is bounded by $\frac{1}{4}$ and attains its maximum only for $q=\frac{1}{2}$, we conclude $f_{r}(s)=\frac{1}{2} \mu_{r}$-almost everywhere. On the other hand, by Assumption 1.1 we know that $\int_{-\infty}^{s} \rho_{r}\left(x_{r}\right) \mathrm{d} x_{r}=\frac{1}{2}$ if and only if $s=0$ and therefore $f_{r}(s) \neq \frac{1}{2}$ for all $s \neq 0$. This together with the fact $f_{r}(s)=\frac{1}{2} \mu_{r}$-almost everywhere, implies $\mu_{r}=\delta_{0}$. Since this holds for all marginal measures $\mu_{r}$ with $r \in\{1, \ldots, d\}$, we conclude $\mu=\delta_{0}$.

By choosing the bounded one particle operator $B$ as the projection onto the state $u_{0}$, Theorem 1.2 is a direct consequence of Lemmata 2.8 and 2.10.

## 3. Fock Space Formalism

In order to prove Theorem 1.4, we will make use of the correspondence between the Hartree energy $\mathcal{E}_{\mathrm{H}}$ and the Hamiltonian $H_{N}$. For a rigorous treatment of this correspondence, we first need to formulate our problem in the language of second quantization. In the subsequent Definition 3.1 we will define the necessary formalism including the relevant Fock spaces with the corresponding creation and annihilation operators. Following [21], we will use the excitation map $U_{N}$ in order to arrive at an operator $U_{N} H_{N} U_{N}^{-1}$ that only depends on modes $a_{i}, i>0$, describing excitations, and not on the mode $a_{0}$ corresponding to the condensate $u_{0}$. The usefulness of this stems from the fact that all the modes $a_{i}, i>0$, can be thought of as being small due to Bose-Einstein condensation.

Before we start introducing the Fock space formalism, let us fix some notation. In the following we will repeatedly use the notation $A \cdot B$ for the composition of an operator $B: \mathcal{H}_{1} \longrightarrow \mathcal{H}_{2}$ with an operator $A: \mathcal{H}_{2} \longrightarrow \mathcal{H}_{3}$, especially when we want to stress that the involved operators map different Hilbert spaces. In order to have a consistent notation, we will occasionally write expectation values as operator products by identifying an element $u \in L^{2}(\mathbb{R})$ with a linear map $\mathbb{C} \longrightarrow L^{2}(\mathbb{R})$, e.g. we write $u^{\dagger} \cdot T \cdot u$ for the expectation value $\langle T\rangle_{u}$. Furthermore, recall the real orthonormal basis $u_{0}, u_{1}, \ldots, u_{d}, u_{d+1}, \ldots$ from the introduction, where $u_{0}$ is the Hartree minimizer from Assumption 1.1 and $u_{1}, \ldots, u_{d}$ form a basis of the vector space spanned by the partial derivatives $\partial_{x_{1}} u_{0}, \ldots, \partial_{x_{d}} u_{0}$. Moreover, let us define the spaces

$$
\begin{aligned}
\mathcal{H} & :=L^{2}\left(\mathbb{R}^{d}\right), \\
\mathcal{H}_{0} & :=\left\{u_{0}\right\}^{\perp} \subset \mathcal{H} .
\end{aligned}
$$

Definition 3.1. Let us denote with $a_{j}:=a_{u_{j}}$ the annihilation operator corresponding to $u_{j} \in \mathcal{H}$ and $\mathcal{N}_{\geq k}:=\sum_{j=k}^{\infty} a_{j}^{\dagger} a_{j}$. In the following, we will repeatedly use the Fock spaces $\mathcal{F}:=\mathcal{F}(\mathcal{H}), \mathcal{F}_{0}:=\mathcal{F}\left(\mathcal{H}_{0}\right)$ and $\mathcal{F}_{\leq M}:=\mathbb{1}_{[\mathcal{N} \leq M]} \mathcal{F}_{0} \subset \mathcal{F}_{0}$, where $\mathcal{N}:=\mathcal{N}_{\geq 1}$. For any $k \in \mathbb{N}_{0}$ we define the operator $a_{\geq k}: \operatorname{dom}\left(\sqrt{\mathcal{N}_{\geq k}}\right) \longrightarrow \mathcal{F} \otimes \mathcal{H}$ as

$$
a_{\geq k}:=\sum_{j=k}^{\infty} a_{j} \otimes u_{j},
$$

as well as the re-scaled operator $b_{\geq k}:=\sum_{j=k}^{\infty} b_{j} \otimes u_{j}:=\frac{1}{\sqrt{N}} a_{\geq k}$, and the re-scaled and restricted operator $\mathbb{L}:=\left.\frac{1}{N} \mathcal{N}\right|_{\mathcal{F}_{\leq N}}: \mathcal{F}_{\leq N} \longrightarrow \mathcal{F}_{\leq N}$, where we suppress the $N$ dependence of $b_{\geq k}$ and $\mathbb{L}$ in our notation. Furthermore, given two operators $X=\sum_{i=0}^{\infty} X_{i} \otimes u_{i}$ : $\operatorname{dom}(X) \longrightarrow \mathcal{F} \otimes \mathcal{H}$ and $Y=\sum_{i=0}^{\infty} Y_{i} \otimes u_{i}: \operatorname{dom}(Y) \longrightarrow \mathcal{F} \otimes \mathcal{H}$ defined on subsets $\operatorname{dom}(X), \operatorname{dom}(Y) \subset \mathcal{F}$, we define the product operator $X \otimes Y: \mathcal{D} \longrightarrow \mathcal{F} \otimes \mathcal{H} \otimes \mathcal{H}$, with
$\mathcal{D}:=\left\{\Psi \in \mathcal{F}: \sum_{i, j=0}^{\infty}\left\|X_{i} Y_{j} \Psi\right\|^{2}<\infty\right\}$, as

$$
X \underline{\otimes} Y:=X \otimes 1_{\mathcal{H}} \cdot Y=\sum_{i, j=0}^{\infty}\left(X_{i} Y_{j}\right) \otimes u_{i} \otimes u_{j}
$$

where we use the convention that tensor products are performed before operator products, i.e. $X \otimes 1_{\mathcal{H}} \cdot Y:=\left(X \otimes 1_{\mathcal{H}}\right) \cdot Y$.

Remark 3.2. Recall that $T$ is an operator acting on the one particle space $\mathcal{H}$ and $\hat{v}:=v(x-y)$ is an operator acting on the two particle space $\mathcal{H} \otimes \mathcal{H}$. Then, $1_{\mathcal{F}} \otimes T$ is an operator on $\mathcal{F} \otimes \mathcal{H}$ and $1_{\mathcal{F}} \otimes \hat{v}$ operates on $\mathcal{F} \otimes \mathcal{H} \otimes \mathcal{H}$. With this, we have a convenient way to express double and four fold sums of creation and annihilation operators

$$
\begin{gathered}
b_{\geq 0}^{\dagger} \cdot 1_{\mathcal{F}} \otimes T \cdot b_{\geq 0}=\sum_{i, j=0}^{\infty} T_{i, j} b_{i}^{\dagger} b_{j}, \\
\left(b_{\geq 0} \underline{\otimes} b_{\geq 0}\right)^{\dagger} \cdot 1_{\mathcal{F}} \otimes \hat{v} \cdot b_{\geq 0} \underline{\otimes} b_{\geq 0}=\sum_{i j, k \ell=0}^{\infty} \hat{v}_{i j, k \ell} b_{i}^{\dagger} b_{j}^{\dagger} b_{k} b_{\ell} .
\end{gathered}
$$

In order to avoid issues with operator domains, we will define products of the form $\left(b_{\geq 0} \underline{\otimes} b_{\geq 0}\right)^{\dagger} \cdot 1_{\mathcal{F}} \otimes \hat{v} \cdot b_{\geq 0} \underline{\otimes} b_{\geq 0}$ as quadratic forms, i.e. we define the quadratic form

$$
\left\langle\left(b_{\geq 0} \underline{\otimes} b_{\geq 0}\right)^{\dagger} \cdot\left(1_{\mathcal{F}} \otimes \hat{v}\right) \cdot\left(b_{\geq 0} \underline{\otimes} b_{\geq 0}\right)\right\rangle_{\Psi}:=\left\langle 1_{\mathcal{F}} \otimes \hat{v}\right\rangle_{b_{\geq 0} \underline{\otimes} b_{\geq 0} \Psi}
$$

For the sake of readability, we will suppress the tensor with the identity in our notation, i.e. we will simply write $b_{\geq 0}^{\dagger} \cdot T \cdot b_{\geq 0}$ and $\left(b_{\geq 0} \underline{\otimes} b_{\geq 0}\right)^{\dagger} \cdot \hat{v} \cdot b_{\geq 0} \underline{\otimes} b_{\geq 0}$.

In the following, we will make use of the fact that we can express the Hamiltonian in Eq. (1.1) in terms of the rescaled creation and annihilation operators as

$$
\begin{equation*}
N^{-1} H_{N}=b_{\geq 0}^{\dagger} \cdot T \cdot b_{\geq 0}+\frac{N}{2(N-1)}\left(b_{\geq 0} \underline{\otimes} b_{\geq 0}\right)^{\dagger} \cdot \hat{v} \cdot b_{\geq 0} \underline{\otimes} b_{\geq 0} \tag{3.1}
\end{equation*}
$$

Since the Hamiltonian $H_{N}$ is only defined on the subset $\otimes_{\mathrm{s}}^{N} \mathcal{H} \subset \mathcal{F}$, the equation above only holds in this subspace of fixed particle number $N$. In order to focus on excitations above the condensate, we follow the strategy in [21] and map the Hamiltonian $H_{N}$ to an operator which acts on the truncated Fock space $\mathcal{F}_{\leq N}$ of modes orthogonal to $u_{0}$ with the help of the excitation $\operatorname{map} U_{N}$. We will think of this map $U_{N}$ as the quantum counterpart to the embedding of the disc $\left\{z \in\left\{u_{0}\right\}^{\perp}:\|z\| \leq 1\right\}$ into the sphere $\{u \in \mathcal{H}:\|u\|=1\}$ via the map $\iota$ defined in Eq. (1.10). The proof of the following properties of $U_{N}$ is elementary and is left to the reader.

Lemma 3.3. Recall the definition of the operator $\mathbb{L}$ in Definition 3.1 and the excitation $\operatorname{map} U_{N}: \bigotimes_{\mathrm{s}}^{N} \mathcal{H} \longrightarrow \mathcal{F}_{\leq N}$ from Eq. (1.12)

$$
U_{N}\left(u_{0}^{\otimes^{i_{0}}} \otimes_{\mathrm{s}} u_{1}^{\otimes^{i_{1}}} \otimes_{\mathrm{s}} \cdots \otimes_{\mathrm{s}} u_{m}^{\otimes^{i_{m}}}\right):=u_{1}^{\otimes^{i_{1}}} \otimes_{\mathrm{s}} \cdots \otimes_{\mathrm{s}} u_{m}^{\otimes_{m}^{i_{m}}}
$$

for non-negative integers $i_{0}+\cdots+i_{m}=N$. Under conjugation with this unitary map $U_{N}$, we have for all $i, j \geq 1$ the following transformation laws

We can summarize the transformation laws from Lemma 3.3 as follows: In any product of the form $b_{i}^{\dagger} b_{j}$ we exchange $b_{0}$ with the operator $\sqrt{1-\mathbb{L}}$. In analogy to this, the zero component of the embedding $\iota(z)$ defined in Eq. (1.10) is given by $u_{0}^{\dagger} \cdot \iota(z)=\sqrt{1-\|z\|^{2}}$. In order to express $U_{N} H_{N} U_{N}^{-1}$, let us first compute

& =\mathfrak{R e}\left[T_{0,0}(1-\mathbb{L})+2 \sum_{i=1}^{\infty} T_{i, 0} b_{i}^{\dagger} \sqrt{1-\mathbb{L}}+\sum_{i, j=1}^{\infty} T_{i, j} b_{i}^{\dagger} b_{j}\right] \\
& =\mathfrak{R e}\left[u_{0}^{\dagger} \cdot T \cdot u_{0}(1-\mathbb{L})+2 b_{\geq 1}^{\dagger} \cdot T \cdot u_{0} \cdot \sqrt{1-\mathbb{L}}+b_{\geq 1}^{\dagger} \cdot T \cdot b_{\geq 1}\right]
\end{aligned}
$$

where the real part of an operator is defined as $\mathfrak{R e}[X]:=\frac{X+X^{\dagger}}{2}$. Similarly, we can express the transformed operator $U_{N}\left(\frac{N}{2(N-1)}\left(b_{\geq 0} \underline{\otimes} b \geq 0\right)^{\dagger} \cdot \hat{v} \cdot b_{\geq 0} \underline{\otimes} b \geq 0\right) U_{N}^{-1}$ as

& +\left(b_{\geq 1} \underline{\otimes} b_{\geq 1}\right)^{\dagger} \cdot \hat{v} \cdot u_{0} \underline{\otimes} u_{0} f_{2}(\mathbb{L})+\left(b_{\geq 1} \underline{\otimes} u_{0}\right)^{\dagger} \cdot \hat{v} \cdot b_{\geq 1} \underline{\otimes} u_{0} f_{3}(\mathbb{L}) \\
& +\left(u_{0} \underline{\otimes} b_{\geq 1}\right)^{\dagger} \cdot \hat{v} \cdot b_{\geq 1} \underline{\otimes} u_{0} f_{4}(\mathbb{L})+2\left(b_{\geq 1} \underline{\otimes} b_{\geq 1}\right)^{\dagger} \cdot \hat{v} \cdot b_{\geq 1} \underline{\otimes} u_{0} f_{5}(\mathbb{L}) \\
& \left.+\frac{1}{2}\left(b_{\geq 1} \underline{\otimes} b_{\geq 1}\right)^{\dagger} \cdot \hat{v} \cdot b_{\geq 1} \underline{\otimes} b_{\geq 1} f_{6}(\mathbb{L})\right], \tag{3.2}

with $f_{0}(x):=\frac{N}{N-1}(1-x)\left(1-x-N^{-1}\right), f_{1}(x):=\frac{N}{N-1}\left(1-x-N^{-1}\right) \sqrt{1-x}, f_{2}(x):=$ $\frac{N}{N-1} \sqrt{1-x-N^{-1}} \sqrt{1-x}, f_{3}(x):=f_{4}(x):=\frac{N}{N-1}(1-x), f_{5}(x):=\frac{N}{N-1} \sqrt{1-x}$ and $f_{6}(x):=\frac{N}{N-1}$. In order to keep the notation compact, let us name the essential building blocks involved in the expressions above.

Definition 3.4. We define $A_{0}:=u_{0}^{\dagger} \cdot T \cdot u_{0}, A_{1}:=2 b_{\geq 1}^{\dagger} \cdot T \cdot u_{0}$ and $A_{2}:=b_{\geq 1}^{\dagger} \cdot T \cdot b_{\geq 1}$, as well as $B_{0}:=\frac{1}{2}\left(u_{0} \underline{\otimes} u_{0}\right)^{\dagger} \cdot \hat{v} \cdot u_{0} \underline{\otimes} u_{0}$ and

With these building blocks at hand, we can express the transformed Hamiltonian as

In the subsequent Lemma 3.5 we will derive estimates for operator expressions of the form $B_{r} f(\mathbb{L})$. Such estimates will be useful for the identification of lower order terms in the energy asymptotics in Eq. (1.8).

Lemma 3.5. Let us denote with $\pi_{M}$ the orthogonal projection onto $\mathcal{F}_{\leq M}$. Given Assumption [1.1, there exists a constant $c$ such that for functions $f:[0,1] \longrightarrow \mathbb{R}$

where the constants $\lambda, \Lambda$ are as in Assumption 1.1.

Using the Cauchy-Schwarz inequality as in Lemma C. 1 with $Q:=1_{\mathcal{F}_{0}} \otimes \hat{v}, A:=$ $b_{\geq 1} \underline{\otimes} u_{0} \pi_{M}$ and $B:=2 u_{0} \underline{\otimes} u_{0} f(\mathbb{L}) \pi_{M}$, and defining $k:=\left(u_{0} \otimes u_{0}\right)^{\dagger} \cdot|\hat{v}| \cdot u_{0} \otimes u_{0}$, we obtain for any $s>0$

By Assumption 1.1, $|\hat{v}| \leq \Lambda 1_{\mathcal{H}} \otimes(T+1)$. Let $K:=\Lambda u_{0}^{\dagger} \cdot(T+1) \cdot u_{0}$, then

The following two Lemmata will be useful tools in the verification of the lower bound of the energy asymptotics in Theorem 4.13.

with $\tilde{\delta}:=\frac{\delta}{2}$ and $\tilde{c}:=\delta u_{0}^{\dagger} \cdot T \cdot u_{0}+\delta c$. The upper bound in Eq. (3.5) follows analogously. In order to verify the second inequality note that the map $A \mapsto \sum_{n} P_{n} A P_{n}$ is monotone and $\sum_{n} P_{n}\left(b_{\geq 1}^{\dagger} \cdot T \cdot b_{\geq 1}\right) P_{n}=b_{\geq 1}^{\dagger} \cdot T \cdot b_{\geq 1} \sum_{n} P_{n}^{2}=b_{\geq 1}^{\dagger} \cdot T \cdot b_{\geq 1}$. Hence,

In the subsequent Lemma we are going to verify that we can exchange the $N$-dependent functions $f_{i}$ in Eq. (3.3) with $N$-independent functions $\sqrt{1-x}^{\beta_{i}}$, for suitable $\beta_{i}$, without changing the operator substantially. This will be convenient in the lower bound of the energy asymptotics, since there we have to verify an operator Taylor approximation, which will be more convenient to do for the functions $\sqrt{1-x}^{\beta_{i}}$ than for the functions $f_{i}$.
Lemma 3.7. Let $\beta_{0}:=4, \beta_{1}:=3, \beta_{2}:=\beta_{3}:=\beta_{4}:=2, \beta_{5}:=1$ and $\beta_{6}:=0$, and let us define the operators $\widetilde{A}_{N}$ and $\widetilde{B}_{N}$ acting on $\mathcal{F}_{0}$ as

& \quad \leq \frac{1}{2}\left|\hat{v}_{00,00}\right| \sup _{x \leq \frac{M}{N}}\left|f_{0}(x)-(1-x)^{2}\right| \leq \frac{1}{2}\left|\hat{v}_{00,00}\right| \frac{M}{(N-1) N} .
\end{aligned}
$$

Furthermore, $f_{r}(x)=\sqrt{1-x}^{\beta_{r}}+O\left(\frac{1}{N}\right)$ and therefore we obtain with Lemma 3.5 and the choice $t=1$

## 4. Asymptotics of the Ground State Energy

We start by making the formal definition of the Bogoliubov Hamiltonian $\mathbb{H}$ in Eq. (1.6) rigorous in Subsection 4.1. In the following Subsection 4.2, we will verify the upper bound in the energy asymptotics in Eq. (1.8). We will then discuss the proof of the lower bound in Subsection 4.3, while the verification of the main technical Theorem 4.12 for the lower bound will be postponed to Section 5 .

### 4.1. Construction of the Bogoliubov Operator $\mathbb{H}$

In the following Lemma 4.1 we will identify the Hessian $\operatorname{Hess}_{u_{0}} \mathcal{E}_{\mathrm{H}}$, and give a precise definition of the Bogoliubov operator in the subsequent Definition 4.3. Furthermore, we shall see that the operator $\mathbb{H}$ is indeed semi-bounded. In the following let us denote with $\operatorname{dom}[A]:=\operatorname{dom}(\sqrt{A})$ the form domain of an operator $A \geq 0$.

Lemma 4.1. Given Assumption 1.1, the Hessian of the Hartree energy $\mathcal{E}_{\mathrm{H}}$ at the Hartree minimizer $u_{0}$ is given by

\frac{1}{2} \operatorname{Hess}_{u_{0}} \mathcal{E}_{\mathrm{H}}[z]=z^{\dagger} \cdot Q_{\mathrm{H}} \cdot z+G_{\mathrm{H}}^{\dagger} \cdot z \otimes z+(z \otimes z)^{\dagger} \cdot G_{\mathrm{H}}, \tag{4.1}
\end{equation*}
$$

where $G_{\mathrm{H}}:=\frac{1}{2} \hat{v} \cdot u_{0} \otimes u_{0} \in{\overline{\mathcal{H}_{0} \otimes_{\mathrm{s}} \mathcal{H}_{0}}{ }^{\|} \cdot \|_{*} \text { is in the closure of } \mathcal{H}_{0} \otimes_{\mathrm{s}} \mathcal{H}_{0} \text { with respect to }}^{\text {a }}$ the norm $\|G\|_{*}:=\left\|1_{\mathcal{H}} \otimes(T+1)^{-\frac{1}{2}} \cdot G\right\|$, and the operator $Q_{\mathrm{H}}$ is defined by the equation

for all $z \in \mathcal{H}_{0} \cap \operatorname{dom}[T]$, with $\mu_{\mathrm{H}}:=u_{0}^{\dagger} \cdot T \cdot u_{0}+\left(u_{0} \otimes u_{0}\right)^{\dagger} \cdot \hat{v} \cdot u_{0} \otimes u_{0}$. Furthermore, $Q_{\mathrm{H}}$ is non-negative and satisfies $\nu^{-1}\left(\left.T\right|_{\mathcal{H}_{0}}+1\right) \leq Q_{\mathrm{H}}+1 \leq \nu\left(\left.T\right|_{\mathcal{H}_{0}}+1\right)$ for some constant $\nu>0$.

Remark 4.2. By Assumption 1.1, we know that $\hat{v} \cdot u_{0} \otimes u_{0} \in{\overline{\mathcal{H}}{ }_{0} \otimes_{\mathrm{s}} \mathcal{H}_{0}}^{\|} \cdot \|_{*}$, which follows from the fact that $1_{\mathcal{H}} \otimes(T+1)^{-\frac{1}{2}} \cdot \hat{v} \cdot 1_{\mathcal{H}} \otimes(T+1)^{-\frac{1}{2}}$ is a bounded operator and that $u_{0} \in$ $\operatorname{dom}[T]$. For such elements $G \in{\overline{\mathcal{H}} 0_{0} \otimes_{\mathrm{s}} \mathcal{H}_{0}}^{\|\cdot\|_{*}}$, we have that $G_{\text {reg }}:=1_{\mathcal{H}} \otimes(T+1)^{-\frac{1}{2}} \cdot G$ is an element of $\mathcal{H}_{0} \otimes_{\mathrm{s}} \mathcal{H}_{0}$ and therefore we can define for all $z \in \operatorname{dom}[T]$

In a similar fashion, we define the operator $G^{\dagger} \cdot b_{\geq 1} \underline{\otimes} b_{\geq 1}:=G_{\text {reg }}^{\dagger} \cdot b_{\geq 1} \underline{\otimes}\left((T+1)^{\frac{1}{2}} \cdot b_{\geq 1}\right)$.
Proof of Lemma 4.1. With the help of the embedding $\iota$ defined in Eq. (1.10), we can express the Hessian as $\left.\operatorname{Hess}\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}[z]=\left.D^{2}\right|_{0}\left(\mathcal{E}_{\mathrm{H}} \circ \iota\right)(z)$, where $\left.D^{2}\right|_{z_{0}} f(z)$ denotes the second derivative of a function $f$ in the direction $z$ evaluated at $z_{0}$. An explicit computation yields Eq. (4.1). Regarding the second part of the Lemma, observe that $Q_{\mathrm{H}} \geq 0$ follows from the fact that we can always find a phase $\theta_{z}$ such that

$$
z^{\dagger} \cdot Q_{\mathrm{H}} \cdot z=\left.\frac{1}{2} \operatorname{Hess}\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}\left[e^{i \theta_{z}} z\right] \geq 0 .
$$

Furthermore, note that $|v| \leq \Lambda(T+1)$ implies $\pm\left(1_{\mathcal{H}_{0}} \otimes u_{0}\right)^{\dagger} \cdot \hat{v} \cdot 1_{\mathcal{H}_{0}} \otimes u_{0} \leq c 1_{\mathcal{H}_{0}}$ with $c:=u_{0}^{\dagger} \cdot \Lambda(T+1) \cdot u_{0}$ and

$$
\pm\left(u_{0} \otimes 1_{\mathcal{H}_{0}}\right)^{\dagger} \cdot \hat{v} \cdot 1_{\mathcal{H}_{0}} \otimes u_{0} \leq \frac{1}{2}\left(u_{0} \otimes 1_{\mathcal{H}_{0}}\right)^{\dagger} \cdot|\hat{v}| \cdot u_{0} \otimes 1_{\mathcal{H}_{0}}+\frac{1}{2}\left(1_{\mathcal{H}_{0}} \otimes u_{0}\right)^{\dagger} \cdot|\hat{v}| \cdot 1_{\mathcal{H}_{0}} \otimes u_{0} \leq c 1_{\mathcal{H}_{0}} .
$$

Hence $Q_{\mathrm{H}} \geq 0$ implies $Q_{\mathrm{H}}+1 \geq\left. T\right|_{\mathcal{H}_{0}}+1-(2 c+|\mu|+1) \geq\left. T\right|_{\mathcal{H}_{0}}+1-(1+2 c+\mu)\left(Q_{\mathrm{H}}+1\right)$, and therefore $(2+2 c+\mu)\left(Q_{\mathrm{H}}+1\right) \geq\left. T\right|_{\mathcal{H}_{0}}+1$. Furthermore $T \geq 0$ implies

$$
Q_{\mathrm{H}}+1 \leq T+2 c+|\mu| \leq(1+2 c+|\mu|)\left(\left.T\right|_{\mathcal{H}_{0}}+1\right) .
$$

Definition 4.3. Let the selfadjoint operator $Q_{\mathrm{H}}$ and $G_{\mathrm{H}} \in{\overline{\mathcal{H}_{0} \otimes_{\mathrm{S}} \mathcal{H}_{0}}{ }^{\|\cdot\|_{*}} \text { be as in Lemma }{ }^{\text {a }} \text {. }}^{\text {a }}$ 4.1. Then we define the Bogoliubov operator $\mathbb{H}$ as

$$
\begin{equation*}
\mathbb{H}:=a_{\geq 1}^{\dagger} \cdot Q_{\mathrm{H}} \cdot a_{\geq 1}+G_{\mathrm{H}}^{\dagger} \cdot a_{\geq 1} \underline{\otimes} a_{\geq 1}+\left(a_{\geq 1} \underline{\otimes} a_{\geq 1}\right)^{\dagger} \cdot G_{\mathrm{H}} . \tag{4.2}
\end{equation*}
$$

Theorem 4.4. The quadratic form on the right side of Eq. (4.2) is semi-bounded from below and closeable, and consequently defines by Friedrichs extension a selfadjoint operator $\mathbb{H}$ with $\inf \sigma(\mathbb{H})>-\infty$. Furthermore there exists a sequence of states $\Psi_{M} \in \operatorname{dom}\left[a_{\geq 1}^{\dagger} \cdot(T+1) \cdot a_{\geq 1}\right] \cap \mathcal{F}_{\leq M},\left\|\Psi_{M}\right\|=1$, such that

$$
\langle\mathbb{H}\rangle_{\Psi_{M}} \underset{M \rightarrow \infty}{\longrightarrow} \inf \sigma(\mathbb{H}) .
$$

Additionally there exists a constant $r_{*}>0$ such that for all $r<r_{*}$ the operator $\mathbb{H}-r \mathbb{A}$ satisfies $\inf \sigma(\mathbb{H}-r \mathbb{A})>-\infty$ as well, where

$$
\begin{equation*}
\mathbb{A}:=-\frac{1}{4} \sum_{j=1}^{d}\left(a_{j}-a_{j}^{\dagger}\right)^{2}+a_{>d}^{\dagger} \cdot(T+1) \cdot a_{>d} \tag{4.3}
\end{equation*}
$$

The proof of Theorem 4.4 is being carried out in Appendix B We emphasize that $\mathbb{H}$ is degenerate, in the sense that $z^{\dagger} \cdot Q_{\mathrm{H}} \cdot z+G_{\mathrm{H}}^{\dagger} \cdot z \otimes z+(z \otimes z)^{\dagger} \cdot G_{\mathrm{H}}=0$ for any $z$ in the vector space spanned by $\left\{u_{1}, \ldots, u_{d}\right\}$, and therefore we cannot directly apply the results in [27]. We also note that the semi-boundedness of Bogoliubov operators with degeneracies has been verified in [14] under the additional assumption that $Q_{\mathrm{H}}$ is bounded.

### 4.2. Upper Bound

With the essential definitions at hand, we will derive the upper bound in Theorem 4.6 using the representation of $U_{N} H_{N} U_{N}^{-1}$ derived in the previous section. We follow the strategy presented in [21], by sorting the operator $U_{N} H_{N} U_{N}^{-1}$ in terms of different powers in $b_{\geq 1}$ and identifying the zero component as the Hartree energy $N e_{\mathrm{H}}$ defined in Eq. (1.2) and the second order component as the Bogoliubov operator $\mathbb{H}$ defined in Eq. (4.2).

Lemma 4.5. Let Assumption 1.1 hold. Then there exists a constant $C$ such that

$$
\pm \pi_{M}\left(U_{N} N^{-1} H_{N} U_{N}^{-1}-e_{\mathrm{H}}-N^{-1} \mathbb{H}\right) \pi_{M} \leq C\left(\frac{M}{N}\right)^{\frac{3}{2}}\left(1+a_{\geq 1}^{\dagger} \cdot(T+1) \cdot a_{\geq 1}\right)
$$

for all $M \leq N$.
While Lemma 4.5 will be useful for proving the upper bound in Theorem 4.6, it is insufficient for proving the corresponding lower bound. This is due to the fact that Bose-Einstein condensation only provides the rough a priori information $M=o(N)$, see also the proof of Theorem 4.13,

Proof. Observe that $u_{0}$ minimizes the Hartree energy, and therefore

e_{\mathrm{H}}=\inf _{\|u\|=1} \mathcal{E}_{\mathrm{H}}[u]=u_{0}^{\dagger} \cdot T \cdot u_{0}+\frac{1}{2}\left(u_{0} \otimes u_{0}\right)^{\dagger} \cdot \hat{v} \cdot u_{0} \otimes u_{0}=A_{0}+B_{0},
$$

where $A_{i}$ and $B_{i}$ are defined in Definition [3.4. Since $\mathcal{E}_{\mathrm{H}}\left[u_{0}\right] \leq \mathcal{E}_{\mathrm{H}}[u]$ for $\|u\|=1$, we obtain by differentiation in any direction $z \perp u_{0}$

$$
0=\left.D\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}(z)=u_{0}^{\dagger} \cdot T \cdot z+z^{\dagger} \cdot T \cdot u_{0}+\left(z \otimes u_{0}\right)^{\dagger} \cdot \hat{v} \cdot u_{0} \otimes u_{0}+\left(u_{0} \otimes u_{0}\right)^{\dagger} \cdot \hat{v} \cdot z \otimes u_{0}
$$

and consequently $u_{j}^{\dagger} \cdot T \cdot u_{0}+\left(u_{j} \otimes u_{0}\right)^{\dagger} \cdot \hat{v} \cdot u_{0} \otimes u_{0}=0$ for all $j \geq 1$. Hence,

$$
A_{1}+B_{1}=2\left(b_{\geq 1}^{\dagger} \cdot T \cdot u_{0}+\left(b_{\geq 1} \underline{\otimes} u_{0}\right)^{\dagger} \cdot \hat{v} \cdot u_{0} \underline{\otimes} u_{0}\right)=0 .
$$

By Definition 4.3 and Lemma 4.1, we have

$$
N^{-1} \mathbb{H}=\mathfrak{R e}\left[A_{2}+B_{2}+B_{3}+B_{4}-\mu_{\mathrm{H}} b_{\geq 1}^{\dagger} \cdot b_{\geq 1}\right],
$$

and consequently we can write for any $M \leq N$, using Eq. (3.3),

$$
\pi_{M}\left(U_{N} N^{-1} H_{N} U_{N}^{-1}-e_{\mathrm{H}}-N^{-1} \mathbb{H}\right) \pi_{M}=\pi_{M} \mathfrak{R e}[X] \pi_{M}
$$

with

$$
X:=B_{0}\left(f_{0}(\mathbb{L})-1+2 \mathbb{L}\right)+B_{1}\left(f_{1}(\mathbb{L})-\sqrt{1-\mathbb{L}}\right)+\sum_{r=2}^{4} B_{r}\left(f_{r}(\mathbb{L})-1\right)+\sum_{r=5}^{6} B_{r} f_{r}(\mathbb{L}),
$$

where we used $A_{1} \sqrt{1-\mathbb{L}}=-B_{1} \sqrt{1-\mathbb{L}}$. In order to estimate the first contribution, note that $\left|f_{0}(x)-1+2 x\right| \leq 2 \frac{M^{2}}{(N-1) N}$ for all $0 \leq x \leq \frac{M}{N}$ and therefore

$$
\pm \pi_{M} B_{0}\left(f_{0}(\mathbb{L})-1+2 \mathbb{L}\right) \pi_{M}= \pm \frac{1}{2} \hat{v}_{00,00} \pi_{M}\left(f_{0}(\mathbb{L})-1+2 \mathbb{L}\right) \pi_{M} \leq\left|\hat{v}_{00,00}\right| \frac{M^{2}}{(N-1) N} .
$$

Recalling that $b_{\geq 1}=\frac{1}{\sqrt{N}} a_{\geq 1}$ and Lemma 3.5 yields

$$
\pm \pi_{M} B_{1}\left(f_{1}(\mathbb{L})-\sqrt{1-\mathbb{L}}\right) \pi_{M} \leq c \frac{M}{N-1} \sqrt{\frac{M}{N}} .
$$

Furthermore we obtain for $r \in\{2,3,4\}$ by Lemma 3.5 with the choice $t=\frac{1}{\sqrt{N}}$, together with the bound $\sup _{x \leq \frac{M}{N}}\left|f_{r}(x)-1\right| \leq C \frac{M}{N}$ for a constant $C>0$,

$$
\pm \pi_{M} B_{r}\left(f_{r}(\mathbb{L})-1\right) \pi_{M} \leq c C \frac{M^{\frac{3}{2}}}{N^{2}}\left(1+a_{\geq 1}^{\dagger} \cdot(T+1) \cdot a_{\geq 1}\right) .
$$

The estimates for $B_{5} f_{5}(\mathbb{L})$ and $B_{6} f_{6}(\mathbb{L})$ can be obtained analogously.
Theorem 4.6 (Upper Bound). Let $E_{N}$ be the ground state energy of $H_{N}, e_{\mathrm{H}}$ the Hartree energy defined in Eq. (1.2) and let $\mathbb{H}$ be the Bogoliubov operator defined in Eq. (4.2). Given Assumption 1.1, we have the upper bound

$$
E_{N} \leq N e_{\mathrm{H}}+\inf \sigma(\mathbb{H})+o_{N \rightarrow \infty}(1) .
$$

Proof. Let $\nu$ be the constant from Lemma 4.1, such that the inequality $Q_{\mathrm{H}}+1 \leq$ $\nu\left(\left.T\right|_{\mathcal{H}_{0}}+1\right)$ holds. For all $\epsilon>0$, we know by Theorem 4.4 that there exists a state $\Psi \in$ $\mathcal{F}_{M}$ with $M<\infty$ such that $\kappa:=\left\langle a_{\geq 1}^{\dagger} \cdot(T+1) \cdot a \geq 1\right\rangle_{\Psi}<\infty$ and $\langle\mathbb{H}\rangle_{\Psi} \leq \inf \sigma(\mathbb{H})+\epsilon$. Applying Lemma 4.5 yields the estimate

$$
\begin{aligned}
\left\langle H_{N}\right\rangle_{U_{N}^{-1} \Psi} & \leq N e_{\mathrm{H}}+\langle\mathbb{H}\rangle_{\Psi}+C M \sqrt{\frac{M}{N}}\left(1+\left\langle a_{\geq 1}^{\dagger} \cdot(T+1) \cdot a_{\geq 1}\right\rangle_{\Psi}\right) \\
& \leq N e_{\mathrm{H}}+\inf \sigma(\mathbb{H})+\epsilon+C M \sqrt{\frac{M}{N}}(1+\kappa) .
\end{aligned}
$$

### 4.3. Lower Bound

In the following, we will give the proof of the lower bound in the energy asymptotics in Eq. (1.8). First of all let us define the operators $q, p: \operatorname{dom}[\mathcal{N}] \longrightarrow \mathcal{F}_{0} \otimes \mathcal{H}_{0}$ as

$$
\begin{align*}
& q:=\sum_{j=1}^{d} q_{j} \otimes u_{j}:=\frac{1}{2} \sum_{j=1}^{d}\left(b_{j}+b_{j}^{\dagger}\right) \otimes u_{j},  \tag{4.4}\\
& p:=\sum_{j=1}^{d} p_{j} \otimes u_{j}:=\frac{1}{2 i} \sum_{j=1}^{d}\left(b_{j}-b_{j}^{\dagger}\right) \otimes u_{j}, \tag{4.5}
\end{align*}
$$

which satisfy the commutation relations $\left[p_{k}, q_{\ell}\right]=\frac{1}{2 i N} \delta_{k, \ell}$. Recall that due to the translation-invariance of $\mathcal{E}_{\mathrm{H}}$, the Hessian Hess $\left.\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}$ is degenerate on the real subspace $\left\{\sum_{j=1}^{d} t_{j} u_{j}: t_{j} \in \mathbb{R}\right\}$. Therefore the Bogoliubov operator $\mathbb{H}$, which we have defined in Eq. (4.2) as the second quantization of the Hessian Hess $\left.\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}$, is degenerate with respect to the operator $q$, i.e. it can be expressed only in terms of $p, b_{>d}$ and $b_{>d}^{\dagger}$. Due to this degeneracy, we cannot directly apply the strategy pursued in [21] where the residuum of the Bogoliubov approximation is being estimated by the Bogoliubov operator itself. The problem is that the residuum $U_{N} H_{N} U_{N}^{-1}-N e_{\mathrm{H}}-\mathbb{H}$ includes contributions depending significantly on the modes $q_{j}$, like $q_{j}^{3}$, which we cannot compare with the Bogoliubov operator $\mathbb{H}$ due to its degeneracy. Furthermore, it is insufficient to compare the residuum with the (rescaled) particle number operator $\frac{1}{N} \mathcal{N}$, which indeed dominates terms like $q_{j}^{3}$, since we only have the a priori information $\langle\mathcal{N}\rangle_{U_{N} \Psi_{N}}=o(N)$ provided by Bose-Einstein condensation. The novel idea of this Subsection and the subsequent Section 5 is to apply a further unitary transformation $\mathcal{W}_{N}$ such that the residuum $\mathcal{W}_{N} U_{N} H_{N} U_{N}^{-1} \mathcal{W}_{N}^{-1}-N e_{\mathrm{H}}-\mathbb{H}$ no longer includes this kind of contributions and consequently we can compare the residuum with the Bogoliubov operator $\mathbb{H}$. This leads to the important inequality in Eq. (1.13). As a consequence we observe that, in contrast to the particle number operator $\mathcal{N}$, the Bogoliubov operator satisfies $\langle\mathbb{H}\rangle_{U_{N} \Psi_{N}}=O(1)$, which, a posteriori, justifies estimating the residuum by the Bogoliubov operator.

Before we are going to construct a unitary map $\mathcal{W}_{N}$ satisfying Eq. (1.13), we are solving the corresponding problem on a classical level, i.e. we are going to construct a map $F$ which satisfies Eq. (1.11). We will then define $\mathcal{W}_{N}$ as the quantum counterpart to $F$.

Definition 4.7. For any $y \in \mathbb{R}^{d}$, let us recall the functions $u_{0, y}(x):=u_{0}(x-y)$ defined in Assumption 1.1 and let us define the map $\lambda: \mathbb{R}^{d} \longrightarrow \mathbb{R}^{d}$

$$
\lambda(y):=\left(u_{j}^{\dagger} \cdot u_{0, y}\right)_{j=1}^{d} \in \mathbb{R}^{d} .
$$

Note that $u_{j}$ and $u_{0, y}$ are real-valued functions, and therefore $\lambda$ is indeed $\mathbb{R}^{d}$-valued. Since $y \mapsto u_{0, y}$ is a $C^{2}\left(\mathbb{R}^{d}, \mathcal{H}\right)$ function by Assumption 1.3, $D_{y} \lambda(0)$ has full rank and $\lambda(0)=0$, there exists a local inverse $\lambda^{-1}: B_{2 \delta}(0) \longrightarrow \mathbb{R}^{d}$ for $\delta>0$ small enough, where
$B_{r}(0) \subset \mathbb{R}^{d}$ denotes the ball of radius $r$ centered around the origin. Let $0 \leq \sigma \leq 1$ be a smooth function with $\left.\sigma\right|_{B_{\delta}(0)}=1$ and $\operatorname{supp}(\sigma) \subset B_{2 \delta}(0)$. Then we define the function $f: \mathbb{R}^{d} \longrightarrow \mathcal{H}$

$$
\begin{equation*}
f(t):=\sigma(t)\left[u_{0, \lambda^{-1}(t)}-\left(u_{0}^{\dagger} \cdot u_{0, \lambda^{-1}(t)}\right) u_{0}-\sum_{j=1}^{d} t_{j} u_{j}\right]=\sum_{j=d+1}^{\infty} f_{j}(t) u_{j} \tag{4.6}
\end{equation*}
$$

with $f_{j}(t):=\sigma(t) u_{j}^{\dagger} \cdot u_{0, \lambda^{-1}(t)}$. Note that $t \mapsto f(t)$ is a $C^{2}\left(\mathbb{R}^{d}, \mathcal{H}_{0}\right)$ function, due to the regularity of $y \mapsto u_{0, y}$. Furthermore, $f(0)=0$. We can now define the map $F: \mathcal{H}_{0} \longrightarrow$ $\mathcal{H}_{0}$ for all $z=\sum_{j=1}^{d}\left(t_{j}+i s_{j}\right) u_{j}+z_{>d} \in \mathcal{H}_{0}$ with $t, s \in \mathbb{R}^{d}$ and $z_{>d} \in\left\{u_{1}, \ldots, u_{d}\right\}^{\perp}$ as

$$
\begin{equation*}
F(z):=\sum_{j=1}^{d}\left(t_{j}+i s_{j}^{\prime}\right) u_{j}+z_{>d}+f(t) \tag{4.7}
\end{equation*}
$$

where $s_{j}^{\prime}:=s_{j}-\Im \mathfrak{I m}\left[\partial_{j} f(t)^{\dagger} \cdot z_{>d}\right]$.

The essential property of $F$ is that $\iota \circ F$, where $\iota$ is the embedding defined in Eq. (1.10), maps the set $\left\{\sum_{j=1}^{d} t_{j} u_{j}:|t|<\delta\right\}$ into the set of Hartree minimizers

$$
\iota \circ F\left(\sum_{j=1}^{d} t_{j} u_{j}\right)=\iota\left(\sum_{j=1}^{d} t_{j} u_{j}+f(t)\right)=u_{0, \lambda^{-1}(t)}
$$

for all $|t|<\delta$. This also implies the central inequality Eq. (1.11), as will be demonstrated in the introduction of Section 5 ,

The arguments so far are based only on the fact that $F$ shifts the component $z_{>d}$ by an amount $f(t)$. The identity $(\iota \circ F)\left(\sum_{j=1}^{d} t_{j} u_{j}\right)=u_{0, \lambda^{-1}(t)}$ would still hold if we used $s_{j}$ instead of $s_{j}^{\prime}$ in Eq. (4.7). Nevertheless, it is natural that $F$ shifts the $s$ component as well, since this shift makes sure that $\mathrm{d} F$ preserves the symplectic form $\omega\left(z_{1}, z_{2}\right):=\mathfrak{R e}\left[z_{1}\right]^{\dagger} \cdot \mathfrak{I m}\left[z_{2}\right]-\mathfrak{I m}\left[z_{1}\right]^{\dagger} \cdot \mathfrak{R e}\left[z_{2}\right]$. Therefore it makes sense to look for a quantum counterpart $\mathcal{W}_{N}$, which we are going to define in the subsequent Definition4.8. In analogy to $F$ preserving the symplectic form $\omega$, the unitary map $\mathcal{W}_{N}$ is preserving the commutator bracket.

Definition 4.8 (Unitary Transformation $\mathcal{W}_{N}: \mathcal{F}_{0} \longrightarrow \mathcal{F}_{0}$ ). Based on the fact that the operators $q_{1}, \ldots, q_{d}$ defined in Eq. (4.4) commute, we can assign to a function $h: \mathbb{R}^{d} \longrightarrow$ $\mathcal{H}_{0}$ with components $h_{j}(t):=u_{j}^{\dagger} \cdot h(t)$ an operator $h(q): \mathcal{F}_{0} \longrightarrow \mathcal{F}_{0} \otimes \mathcal{H}_{0}$

$$
h(q):=\sum_{j=1}^{\infty} h_{j}\left(q_{1}, \ldots, q_{d}\right) \otimes u_{j}
$$

where the operators $h_{j}\left(q_{1}, \ldots, q_{d}\right)$ are well defined via functional calculus. Let $f$ be the function defined in Eq. (4.6), then we can define the unitary map $\mathcal{W}_{N}: \mathcal{F}_{0} \longrightarrow \mathcal{F}_{0}$ as

$$
\begin{equation*}
\mathcal{W}_{N}:=\exp \left[N f(q)^{\dagger} \cdot b_{>d}-N b_{>d}^{\dagger} \cdot f(q)\right]=\exp \left[N \sum_{j=d+1}^{\infty} f_{j}\left(q_{1}, \ldots, q_{d}\right)\left(b_{j}-b_{j}^{\dagger}\right)\right], \tag{4.8}
\end{equation*}
$$

where we have used that $u_{j}^{\dagger} \cdot f(t)=0$ for $j \in\{1, \ldots, d\}$. Note that $q_{1}, \ldots, q_{d}$ and $b_{>d}$ have an $N$ dependence, which we suppress in our notation. Furthermore, we define the transformed operators

$$
\begin{aligned}
p_{j}^{\prime} & :=\mathcal{W}_{N} p_{j} \mathcal{W}_{N}^{-1}, \\
p^{\prime} & :=\mathcal{W}_{N} p \mathcal{W}_{N}^{-1}=\sum_{j=1}^{d} p_{j}^{\prime} \otimes u_{j}, \\
\mathbb{L}^{\prime} & :=\mathcal{W}_{N} \mathbb{L} \mathcal{W}_{N}^{-1},
\end{aligned}
$$

where $p$ is defined in Eq. (4.5) and $\mathbb{L}$ is defined in Definition 3.1. Note that the domain of $\mathbb{L}^{\prime}$ is $\mathcal{W}_{N} \mathcal{F}_{\leq N}$, since $\mathbb{L}$ is only defined on $\mathcal{F}_{\leq N}$.

That the unitary map $\mathcal{W}_{N}$ is indeed a quantum counterpart to the classical map $F$ defined in Eq. (4.7) can be seen from the transformation laws described in the following Lemma 4.9

Lemma 4.9 (Transformation Laws). We have the following transformation laws

$$
\begin{aligned}
& \mathcal{W}_{N} b_{j} \mathcal{W}_{N}^{-1}=b_{j}+f_{j}(q) \text { for } j>d, \\
& \mathcal{W}_{N} q_{j} \mathcal{W}_{N}^{-1}=q_{j} \text { for } j \in\{1, \ldots, d\}, \\
& p_{j}^{\prime}=p_{j}-\mathfrak{I m}\left[\partial_{u_{j}} f(q)^{\dagger} \cdot b_{>d}\right] \text { for } j \in\{1, \ldots, d\},
\end{aligned}
$$

and therefore $\mathcal{W}_{N} b_{\geq 1} \mathcal{W}_{N}^{-1}=q+i p^{\prime}+b_{>d}+f(q)$.
The proof of Lemma 4.9 is elementary and is left to the reader. Before we state the main Theorems of this subsection, let us define what it means for a sequence of operators $X_{N}$ to be asymptotically small compared to another sequence $Y_{N}$, in a suitable sense that is specific to our problem.

Definition 4.10. We say that sequences of operators $X_{N}, Y_{N}$ with $Y_{N} \geq 0$ satisfy

$$
X_{N}=o_{*}\left(Y_{N}\right),
$$

in case for all $\epsilon>0$ there exists a $\delta>0$, such that $\left|\left\langle X_{N}\right\rangle_{\Psi}\right| \leq \epsilon\left\langle Y_{N}\right\rangle_{\Psi}$ for all $M, N$ with $\frac{M}{N} \leq \delta$ and all elements $\Psi \in \mathcal{W}_{N} \mathcal{F}_{\leq M}$. Furthermore, we say that sequences of operators $X_{N}, Y_{N}$ with $Y_{N} \geq 0$ satisfy

$$
X_{N}=O_{*}\left(Y_{N}\right),
$$

in case there exists a constant $C$ and $\delta_{0}>0$, such that $\left|\left\langle X_{N}\right\rangle_{\Psi}\right| \leq C\left\langle Y_{N}\right\rangle_{\Psi}$ for all $M, N$ with $\frac{M}{N} \leq \delta_{0}$ and all $\Psi \in \mathcal{W}_{N} \mathcal{F}_{\leq M}$.
Remark 4.11. Let us denote with $\pi_{M, N}:=\mathcal{W}_{N} \pi_{M} \mathcal{W}_{N}^{-1}$ the orthogonal projection onto the subspace $\mathcal{W}_{N} \mathcal{F}_{\leq M} \subset \mathcal{F}_{0}$. Then the statement $X_{N}=O_{*}\left(Y_{N}\right)$ holds true if and only if there exists a constant $C$ and $\delta_{0}>0$, such that

$$
\begin{equation*}
\pi_{M, N} \mathfrak{R e}\left[\lambda X_{N}\right] \pi_{M, N} \leq C \pi_{M, N} Y_{N} \pi_{M, N} \tag{4.9}
\end{equation*}
$$

for all $\lambda \in \mathbb{C}$ with $|\lambda|=1$ and $\frac{M}{N} \leq \delta_{0}$. Similarly, $X_{N}=o_{*}\left(Y_{N}\right)$ is equivalent to the existence of a function $\epsilon: \mathbb{R}^{+} \longrightarrow \mathbb{R}^{+}$with $\lim _{\delta \rightarrow 0} \epsilon(\delta)=0$, such that

$$
\begin{equation*}
\pi_{M, N} \mathfrak{R e}\left[\lambda X_{N}\right] \pi_{M, N} \leq \epsilon\left(\frac{M}{N}\right) \pi_{M, N} Y_{N} \pi_{M, N} \tag{4.10}
\end{equation*}
$$

for all $\lambda \in \mathbb{C}$ with $|\lambda|=1$ and $M \leq N$.

Theorem 4.12. Recall the $o_{*}(\cdot)$ notation from Definition 4.10, the Hartree energy $e_{\mathrm{H}}$ defined in Eq. (1.2) and the Bogoliubov operator $\mathbb{H}$ defined in Eq. (4.2), and let us define

$$
\begin{equation*}
\mathbb{T}_{N}:=p^{\dagger} \cdot p+b_{>d}^{\dagger} \cdot(T+1) \cdot b_{>d}+\frac{1}{N} \tag{4.11}
\end{equation*}
$$

Then, given Assumptions 1.1 and 1.3, we have

$$
\left(\mathcal{W}_{N} U_{N}\right) N^{-1} H_{N}\left(\mathcal{W}_{N} U_{N}\right)^{-1}=e_{\mathrm{H}}+N^{-1} \mathbb{H}+o_{*}\left(\mathbb{T}_{N}\right)
$$

The proof of Theorem 4.12, which in particular gives rise to a rigorous version of the key inequality Eq. (1.13), will be the content of Section [5. With Theorem 4.12 at hand we can verify the lower bound in the main Theorem 1.4.

Theorem 4.13 (Lower Bound). Let $E_{N}$ be the ground state energy of $H_{N}, e_{\mathrm{H}}$ the Hartree energy defined in Eq. (1.2) and let $\mathbb{H}$ be the Bogoliubov operator defined in Eq. (4.2). Given Assumptions 1.1 and 1.3, we have the lower bound

$$
E_{N} \geq N e_{\mathrm{H}}+\inf \sigma(\mathbb{H})+o_{N \rightarrow \infty}(1)
$$

Proof. According to Theorem 1.2, there exists a sequence of states $\Psi_{N} \in \bigotimes_{\mathrm{s}}^{N} \mathcal{H},\left\|\Psi_{N}\right\|=$ 1 , such that $\left\langle H_{N}\right\rangle_{\Psi_{N}} \leq E_{N}+\alpha_{N}$ with $\alpha_{N} \xrightarrow[N \rightarrow \infty]{\longrightarrow} 0$ and

$$
\epsilon_{N}:=\left\langle b_{\geq 1}^{\dagger} \cdot b_{\geq 1}\right\rangle_{U_{N} \Psi_{N}}=\left\langle b_{\geq 1}^{\dagger} \cdot b_{\geq 1}\right\rangle_{\Psi_{N}} \xrightarrow[N \rightarrow \infty]{\longrightarrow} 0 .
$$

Let us abbreviate $\widetilde{H}_{N}:=U_{N} H_{N} U_{N}^{-1}$ and let $\pi_{M}$ be the orthogonal projection onto the space $\mathcal{F}_{\leq M}$ as before. Furthermore, let $0 \leq f, g \leq 1$ be smooth functions with $f^{2}+g^{2}=1$, $f(x)=1$ for $x \leq \frac{1}{2}$ and $f(x)=0$ for $x \geq 1$, and let us define $f_{M}(x):=f\left(\frac{x}{M}\right)$ and
$g_{M}(x):=g\left(\frac{x}{M}\right)$. Then the generalized IMS localization formula in [23, Theorem A.1], in the form stated in [21, Proposition 6.1], tells us that

$$
\widetilde{H}_{N}=f_{M}(\mathcal{N}) \widetilde{H}_{N} f_{M}(\mathcal{N})+g_{M}(\mathcal{N}) \widetilde{H}_{N} g_{M}(\mathcal{N})-R_{M, N}
$$

with $R_{M, N} \leq \frac{R}{M^{2}} \sum_{n=0}^{\infty} P_{n}\left(\widetilde{H}_{N}-E_{N}\right) P_{n}$, where $P_{n}$ is the orthogonal projection onto $\mathcal{F}_{\leq n} \cap \mathcal{F}_{\leq n-1}^{\perp}, \mathcal{N}=\sum_{j=1}^{\infty} a_{j}^{\dagger} a_{j}$ and $R:=16\left(\left\|f^{\prime}\right\|_{\infty}^{2}+\left\|g^{\prime}\right\|_{\infty}^{2}\right)$. Let us define $M_{N}$ as the smallest integer larger than $\sqrt{\epsilon_{N}} N$ and $N^{\frac{2}{3}}$. The exponent $\frac{2}{3}$ is somewhat arbitrary and we could use any sequence $\ell_{N}$ with $N^{\frac{1}{2}} \ll \ell_{N} \ll N$ instead. Using the estimate $1-f_{M}(x)^{2} \leq \frac{2}{M} x$ yields

$$
\rho_{N}:=\left\langle 1-f_{M_{N}}(\mathcal{N})^{2}\right\rangle_{U_{N} \Psi_{N}} \leq \frac{2}{M_{N}}\langle\mathcal{N}\rangle_{U_{N} \Psi_{N}}=\frac{2 N}{M_{N}}\left\langle b_{\geq 1}^{\dagger} \cdot b_{\geq 1}\right\rangle_{U_{N} \Psi_{N}} \leq \frac{2}{\sqrt{\epsilon_{N}}} \epsilon_{N} \underset{N \rightarrow \infty}{\longrightarrow} 0
$$

Let us define $\Phi_{N}:=\left(1-\rho_{N}\right)^{-\frac{1}{2}} f_{M_{N}}(\mathcal{N}) U_{N} \Psi_{N}$. Using Lemma 3.6 and the inequality $\widetilde{H}_{N} \geq E_{N}$ yields

$$
\begin{equation*}
E_{N}+\alpha_{N} \geq\left\langle\widetilde{H}_{N}\right\rangle_{U_{N} \Psi_{N}} \geq\left(1-\rho_{N}\right)\left\langle\widetilde{H}_{N}\right\rangle_{\Phi_{N}}+\rho_{N} E_{N}-\frac{R}{M_{N}^{2}}\left\langle k \widetilde{H}_{N}+k^{2} N-E_{N}\right\rangle_{U_{N} \Psi_{N}} \tag{4.12}
\end{equation*}
$$

Since $\lim _{N} N^{-1} E_{N}=e_{\mathrm{H}}$, we obtain that $\beta_{N}:=\frac{R}{M_{N}^{2}}\left\langle k \widetilde{H}_{N}+k^{2} N-E_{N}\right\rangle_{U_{N} \Psi_{N}}$ satisfies

$$
\beta_{N} \leq \frac{R}{N^{\frac{4}{3}}}\left((k-1) E_{N}+k \alpha_{N}+k^{2} N\right) \underset{N \rightarrow \infty}{\longrightarrow} 0
$$

We can now rewrite Inequality (4.12) as

$$
E_{N} \geq\left\langle\widetilde{H}_{N}\right\rangle_{\Phi_{N}}-\frac{\alpha_{N}+\beta_{N}}{1-\rho_{N}}
$$

Let $r>0$ be as in the assumption of Theorem 4.4 and recall the definition of $\mathbb{A}$ in Eq. (4.3). Note that $N \mathbb{T}_{N}=\mathbb{A}+1$. By Theorem 4.12 and Remark 4.11, there exists a function $\epsilon$ with $\lim _{\delta \rightarrow 0} \epsilon(\delta)$, such that

\begin{aligned}
& \left\langle\widetilde{H}_{N}\right\rangle_{\Phi_{N}} \geq N e_{\mathrm{H}}+\langle\mathbb{H}\rangle_{\mathcal{W}_{N} \Phi_{N}}-\epsilon\left(\frac{M_{N}}{N}\right)\langle\mathbb{A}+1\rangle_{\mathcal{W}_{N} \Phi_{N}} \\
& \quad=N e_{\mathrm{H}}+\left(1-\frac{1}{r} \epsilon\left(\frac{M_{N}}{N}\right)\right)\langle\mathbb{H}\rangle_{\mathcal{W}_{N} \Phi_{N}}+\frac{1}{r} \epsilon\left(\frac{M_{N}}{N}\right)\langle\mathbb{H}-r \mathbb{A}\rangle_{\mathcal{W}_{N} \Phi_{N}}-\epsilon\left(\frac{M_{N}}{N}\right) \\
& \quad \geq N e_{\mathrm{H}}+\inf \sigma(\mathbb{H})+\frac{1}{r} \epsilon\left(\frac{M_{N}}{N}\right)(\inf \sigma(\mathbb{H}-r \mathbb{A})-\inf \sigma(\mathbb{H}))-\epsilon\left(\frac{M_{N}}{N}\right)
\end{aligned}
$$

for all $N$ large enough such that $1-\frac{1}{r} \epsilon\left(\frac{M_{N}}{N}\right) \geq 0$. This concludes the proof, since $\inf \sigma(\mathbb{H}-r \mathbb{A})>-\infty$ by Theorem 4.4.

## 5. Taylor Expansion of $\left(\mathcal{W}_{N} U_{N}\right) H_{N}\left(\mathcal{W}_{N} U_{N}\right)^{-1}$

This section is devoted to the verification of the main technical Theorem 4.12, which is the rigorous version of inequality Eq. (1.13). Before we explain the proof, recall the definition of $\iota$ in Eq. (1.10) and $F$ in Eq. (4.7), and let us verify the classical counterpart Eq. (1.11). For this purpose we define the functional

$$
\begin{equation*}
\mathcal{E}^{\prime}(z):=\mathcal{E}_{\mathrm{H}}[\iota(F(z))], \tag{5.1}
\end{equation*}
$$

which satisfies according to the definition of $F$ that $\mathcal{E}^{\prime}(\vec{t})=e_{\mathrm{H}}$ for all $t \in \mathbb{R}^{d}$ with $\vec{t}:=\sum_{j=1}^{d} t_{j} u_{j}$, i.e. $F$ flattens the manifold of minimizers of $\mathcal{E}_{\mathrm{H}} \circ \iota$. We will verify Eq. (1.11) by sorting the functional $\mathcal{E}^{\prime}$ in terms of powers in the variables $s$ and $z_{>d}$ for any $z=\sum_{j=1}^{d}\left(t_{j}+i s_{j}\right) u_{j}+z_{>d} \in \mathcal{H}_{0}$ with $z_{>d} \in\left\{u_{1}, \ldots, u_{d}\right\}^{\perp}$. In the following, let $\pi(z):=\sum_{j=1}^{d} i s_{j} u_{j}+z_{>d}$ be the projection onto $\mathcal{V}:=\pi\left(\mathcal{H}_{0}\right)$. We can now sort $\mathcal{E}^{\prime}(z)$ in terms of powers in $s$ and $z_{>d}$, i.e. in terms of powers in $\pi(z)$, using a Taylor approximation with expansion point $\vec{t}$

$$
\begin{align*}
\mathcal{E}^{\prime}(z) & =\mathcal{E}^{\prime}(\vec{t}+\pi(z))=\mathcal{E}^{\prime}(\vec{t})+\left.D\right|_{\vec{t}} \mathcal{E}^{\prime}(\pi(z))+\left.\frac{1}{2} D^{2}\right|_{\vec{t}} \mathcal{E}^{\prime}(\pi(z))+\{\text { HigherOrders }\} \\
& =\mathcal{E}^{\prime}(\vec{t})+\left.D\right|_{\vec{t}} \mathcal{E}^{\prime}(z)+\left.\frac{1}{2} D_{\mathcal{V}}^{2}\right|_{\vec{t}} \mathcal{E}^{\prime}(z)+\{\text { HigherOrders }\} \tag{5.2}
\end{align*}
$$

where $\left.D\right|_{z_{0}} \mathcal{E}^{\prime}(v)$ is the first derivative of $\mathcal{E}^{\prime}$ in the direction $v$ at $z_{0},\left.D^{2}\right|_{z_{0}} \mathcal{E}^{\prime}(v)$ is the second derivative in the direction $v$, and $\left.D_{\mathcal{V}}\right|_{z_{0}} \mathcal{E}^{\prime}(v):=\left.D\right|_{z_{0}} \mathcal{E}^{\prime}(\pi(v))$ and $\left.D_{\mathcal{V}}^{2}\right|_{z_{0}} \mathcal{E}^{\prime}(v):=$ $\left.D^{2}\right|_{z_{0}} \mathcal{E}^{\prime}(\pi(v))$ are the derivatives only with respect to directions in $\mathcal{V}$. Using $\mathcal{E}^{\prime}(\vec{t})=e_{\mathrm{H}}$, $\left.D_{\mathcal{V}}\right|_{\vec{t}} \mathcal{E}^{\prime}=0$ and the fact that $\left.D_{\mathcal{V}}^{2}\right|_{\vec{t}} \mathcal{E}^{\prime}(v) \geq\left.\left(1-\frac{\epsilon}{2}\right) D_{\mathcal{V}}^{2}\right|_{0} \mathcal{E}^{\prime}(v)$ for $t$ small enough by continuity, we formally arrive at Eq. (1.11), which is claimed to hold only for small $\|z\|^{2}=|t|^{2}+\|\pi(z)\|^{2}$ anyway.

By sorting the expression $\left(\mathcal{W}_{N} U_{N}\right) H_{N}\left(\mathcal{W}_{N} U_{N}\right)^{-1}$ in terms of powers in the operators $p$ and $b_{>d}$, we will verify that we end up with the same Taylor approximation we obtained by sorting $\mathcal{E}^{\prime}(z)$ in terms of powers in the variables $s$ and $z_{>d}$. More precisely, our goal is to verify that

$$
\begin{align*}
\left(\mathcal{W}_{N} U_{N}\right) N^{-1} H_{N}\left(\mathcal{W}_{N} U_{N}\right)^{-1} & =\mathcal{E}(q)+\left.D \mathcal{V}\right|_{q} \mathcal{E}\left(b_{\geq 1}\right)+\left.\frac{1}{2} D_{\mathcal{V}}^{2}\right|_{0} \mathcal{E}\left(b_{\geq 1}\right)+o_{*}\left(\mathbb{T}_{N}\right)  \tag{5.3}\\
& =e_{\mathrm{H}}+N^{-1} \mathbb{H}+o_{*}\left(\mathbb{T}_{N}\right),
\end{align*}
$$

where $\mathcal{E}: \operatorname{dom}[T] \rightarrow \mathbb{R}$ is a differentiable extension to all of $\operatorname{dom}[T]$ of the functional $\left.\mathcal{E}^{\prime}\right|_{B_{r}}$, restricted to the ball $B_{r}:=\left\{z \in \mathcal{H}_{0} \cap \operatorname{dom}[T]:\|z\|<r\right\}$ for a sufficiently small $r>0$. Note that the spectrum of the operators $q_{1}, \ldots, q_{d}$ is the whole real axis $\mathbb{R}$. In order to even define $\mathcal{E}(q)$ and $\left.D_{\mathcal{V}}\right|_{q} \mathcal{E}\left(b_{\geq 1}\right)$ with the help of functional calculus, it is therefore necessary that $\mathcal{E}$, in contrast to $\mathcal{E}^{\prime}$, is an everywhere defined and differentiable functional. For such a function $\mathcal{E}$ we can define $\mathcal{E}(q)$ via functional calculus starting from the function $t \mapsto \mathcal{E}\left(\sum_{j=1}^{d} t_{j} u_{j}\right)$ for $t \in \mathbb{R}^{d}$. The so far formal objects $\left.D_{\mathcal{V}}\right|_{q} \mathcal{E}\left(b_{\geq 1}\right)$ and
$\left.\frac{1}{2} D_{\mathcal{V}}^{2}\right|_{0} \mathcal{E}\left(b_{\geq 1}\right)$ are later defined in Definition [5.4. Note that it is a necessity to restrict $\mathcal{E}^{\prime}$ to a sufficiently small ball $B_{r}$ first, to be precise we require that $\|F(z)\| \leq 1-\delta$ for all $z \in B_{r}$ where $0<\delta<1$, since $\mathcal{E}^{\prime}$ itself does not have a differentiable extension due to the square root appearing in the definition of $\iota$, see Eq. (1.10).

In order to reduce the technical efforts of proving Eq. (5.3), we will make use of the fact that

$$
\left(\mathcal{W}_{N} U_{N}\right) N^{-1} H_{N}\left(\mathcal{W}_{N} U_{N}\right)^{-1}=\mathcal{W}_{N} \widetilde{A}_{N} \mathcal{W}_{N}^{-1}+\mathcal{W}_{N} \widetilde{B}_{N} \mathcal{W}_{N}^{-1}+o_{*}\left(\mathbb{T}_{N}\right),
$$

which, as we will see in the proof of Theorem 4.12, is a consequence of Eq. (3.8). We can then prove Eq. (5.3) separately for the operators $\mathcal{W}_{N} \widetilde{A}_{N} \mathcal{W}_{N}^{-1}$ and $\mathcal{W}_{N} \widetilde{B}_{N} \mathcal{W}_{N}^{-1}$. In fact, we are going to verify that

$$
\begin{align*}
& \mathcal{W}_{N} \widetilde{A}_{N} \mathcal{W}_{N}^{-1}=\mathcal{E}_{A}(q)+\left.D \mathcal{V}\right|_{q} \mathcal{E}_{A}\left(b_{\geq 1}\right)+\left.\frac{1}{2} D_{\mathcal{V}}^{2}\right|_{0} \mathcal{E}_{A}\left(b_{\geq 1}\right)+\frac{c}{N}+o_{*}\left(\mathbb{T}_{N}\right),  \tag{5.4}\\
& \mathcal{W}_{N} \widetilde{B}_{N} \mathcal{W}_{N}^{-1}=\mathcal{E}_{B}(q)+\left.D \mathcal{V}\right|_{q} \mathcal{E}_{B}\left(b_{\geq 1}\right)+\left.\frac{1}{2} D_{\mathcal{V}}^{2}\right|_{0} \mathcal{E}_{B}\left(b_{\geq 1}\right)-\frac{c}{N}+o_{*}\left(\mathbb{T}_{N}\right), \tag{5.5}
\end{align*}
$$

where the constant $c$ arises due to the non-commutative nature of the operators $q$ and $p$, and $\mathcal{E}_{A}$ and $\mathcal{E}_{B}$ are differentiable extensions of $\mathcal{E}_{A}^{\prime}, \mathcal{E}_{B}^{\prime}: B_{r} \longrightarrow \mathbb{C}$

$$
\begin{equation*}
\mathcal{E}_{A}^{\prime}(z):=u_{z}^{\dagger} \cdot T \cdot u_{z}, \quad \quad \mathcal{E}_{B}^{\prime}(z):=\frac{1}{2}\left(u_{z} \otimes u_{z}\right)^{\dagger} \cdot \hat{v} \cdot u_{z} \otimes u_{z}, \tag{5.6}
\end{equation*}
$$

where $u_{z}:=\iota(F(z))$. The proofs of Eqs. (5.4) and (5.5) will be carried out in Subsections 5.1 and 5.2, respectively. We have to perform a variety of operator estimates, and since $\mathcal{W}_{N} \widetilde{A}_{N} \mathcal{W}_{N}^{-1}$ and $\mathcal{W}_{N} \widetilde{B}_{N} \mathcal{W}_{N}^{-1}$ involve factors of the form $\sqrt{1-\mathbb{L}^{\prime}}$ with $\mathbb{L}^{\prime}$ defined in Definition 4.8, we need in particular to estimate the Taylor residuum corresponding to approximations of such terms. The operator estimates can be found in Appendix C, respectively Appendix $D$ for the operator square root specifically.

### 5.1. Taylor Expansion of $\mathcal{W}_{N} \widetilde{A}_{N} \mathcal{W}_{N}^{-1}$

In order to structure the analysis, we split the operator $\mathcal{W}_{N} \widetilde{A}_{N} \mathcal{W}_{N}^{-1}$ into simpler operators $H_{J}$, introduced in Definition [5.1, and we split the classical counterpart $\mathcal{E}_{A}$ defined in Eq. (5.6) into atoms $\mathcal{E}_{J}$, defined in Definition 5.2, In Lemma 5.3, we then explain how $\mathcal{W}_{N} \widetilde{A}_{N} \mathcal{W}_{N}^{-1}$ and $\mathcal{E}_{A}$ can be written in terms of $H_{J}$ and $\mathcal{E}_{J}$, respectively.

Definition 5.1. Recall the function $t \mapsto f(t)$ from Definition 4.7. For $i \in\{0, \ldots, 4\}$, we define operators $h_{i}: \operatorname{dom}[\mathcal{N}] \longrightarrow \mathcal{F}_{0} \otimes \mathcal{H}$ by $h_{0}:=1_{\mathcal{F}_{0}} \otimes u_{0}$ and

$$
\begin{array}{ll}
h_{1}:=q=\sum_{j=1}^{d} q_{j} \otimes u_{j}, & h_{3}:=i p^{\prime}=i \sum_{j=1}^{d}\left(p_{j}-\Im \mathfrak{m}\left[\partial_{j} f(q)^{\dagger} \cdot b_{>d}\right]\right) \otimes u_{j}, \\
h_{2}:=f(q), & h_{4}:=b_{>d},
\end{array}
$$

where $f(q)$ and $\partial_{j} f(q)$ are defined according to Definition 4.8. Furthermore, for a multiindex $J=(i, j)$ with $i, j \in\{0, \ldots, 4\}$ we define an operator $H_{J}$ on $\mathcal{W}_{N} \mathcal{F}_{\leq N}$ as

$$
H_{J}:=h_{i}^{\dagger} \cdot T \cdot h_{j}\left(1-\mathbb{L}^{\prime}\right)^{\frac{m_{J}}{2}}
$$

where $m_{J}$ counts how many of the indices in $J=(i, j)$ are zero.
Definition 5.2. Let us decompose an arbitrary $z \in \mathcal{H}_{0}$ as $z=\sum_{j=1}^{d}\left(t_{j}+i s_{j}\right) u_{j}+z_{>d}$, with $t, s \in \mathbb{R}^{d}$ and $z_{>d} \in\left\{u_{1}, \ldots, u_{d}\right\}^{\perp}$. For $i \in\{0, \ldots, 4\}$, we define in analogy to Definition 5.1 the functions $e_{i}: \mathcal{H}_{0} \longrightarrow \mathcal{H}$ by $e_{0}(z):=u_{0}$ and

With this at hand, we can write the transformation $F: \mathcal{H}_{0} \longrightarrow \mathcal{H}_{0}$ from Eq. (4.7) as

Furthermore, consider for $m \in\{0, \ldots, 4\}$ the functions

where $\chi$ is a smooth function with $0 \leq \chi(x) \leq 1, \operatorname{supp}(\chi) \subset[0,1)$ and $\chi(x)=1$ for $|x|<\frac{1}{2}$. Then we can define for a multi-index $J=(i, j)$ with $i, j \in\{0, \ldots, 4\}$ the function $\mathcal{E}_{J}: \mathcal{H}_{0} \cap \operatorname{dom}[T] \longrightarrow \mathbb{C}$ as

where $m_{J}$ counts how many of the two indices $i, j$ are zero.

Lemma 5.3. Let us define for all $i, j \in\{1, \ldots, 4\}$ the coefficients $\lambda_{(0,0)}:=1, \lambda_{(i, 0)}:=2$, $\lambda_{(i, j)}:=1$ and $\lambda_{(0, j)}:=0$. Then

is an extension of $\left.\mathcal{E}_{A}^{\prime}\right|_{B_{r}}$ defined in Eq. (5.6), where $B_{r}:=\left\{z \in \mathcal{H}_{0} \cap \operatorname{dom}[T]:\|z\|<r\right\}$ and $r>0$ is a constant such that $\|F(z)\|<\frac{1}{2}$ for all $z \in \mathcal{H}_{0}$ with $\|z\|<r$.

Note that the operator $\mathcal{W}_{N} \widetilde{A}_{N} \mathcal{W}_{N}^{-1}$ involves terms with $\sqrt{1-\mathbb{L}^{\prime}}$ on the right side as well as on the left side. In order to reduce the technical effort later, it will be convenient to have all of them on one side, say the right side. This can be achieved by using the real part, e.g. we can write for $j \in\{1, \ldots, 4\}$

Therefore we set all the coefficients $\lambda_{(0, j)}$ in Lemma 5.3 to zero, since the $(0, j)$-contribution is already included in the real part of the $(j, 0)$-contribution.

Proof. Eq. (5.8) follows from the transformation law $\mathcal{W}_{N} b_{\geq 1} \mathcal{W}_{N}^{-1}=h_{1}+h_{2}+h_{3}+h_{4}$, where $h_{i}$ is defined in Definition 5.1, and the definition $\mathbb{L}^{\prime}=\mathcal{W}_{N} \mathbb{L} \mathcal{W}_{N}^{-1}$. Similarly we obtain $\mathcal{E}_{A}(z)=\mathcal{E}_{A}^{\prime}(z)$ for all $z$ with $\|z\|<r$ for $r$ as above and the fact that

In order to prove the Taylor approximation in Eq. (5.4), we will verify that each of the atoms $H_{J}$ can be approximated using the quantized Taylor coefficients of $\mathcal{E}_{J}$. The quantized Taylor coefficients $\left.D_{\mathcal{V}}\right|_{q} \mathcal{E}_{J}\left(b_{\geq 1}\right)$ and $\left.D_{\mathcal{V}}^{2}\right|_{0} \mathcal{E}_{J}\left(b_{\geq 1}\right)$ are rigorously defined by the following Definition.

Let $L_{t}: \mathcal{H}_{0} \longrightarrow \mathbb{C}$ be a bounded $\mathbb{R}$-linear map for all $t \in \mathbb{R}^{d}$, and let $w(t), \widetilde{w}(t)$ be the unique elements in $\mathcal{H}_{0}$ such that $L_{t}(z)=w(t)^{\dagger} \cdot z+z^{\dagger} \cdot \widetilde{w}(t)$. Then we define

is small, where the constant $c_{J}$ are given by

c_{(3,3)} & :=\frac{1}{4} \sum_{j=1}^{d} u_{j}^{\dagger} \cdot T \cdot u_{j}=\left.\frac{1}{8} \sum_{j=1}^{d} \partial_{t_{j}}^{2}\right|_{t=0} \mathcal{E}_{(1,1)}(\vec{t}) \tag{5.12}
\end{align*}
$$

$c_{(1,3)}:=c_{(3,1)}:=-c_{(3,3)}$ and $c_{J}:=0$ for all other $J \in\{0, \ldots, 4\}^{2}$, where $\vec{t}:=\sum_{j=1}^{d} t_{j} u_{j}$. The proof will be spit into two parts. In Lemma 5.6 we derive an explicit representation of the residuum $R_{J}$ by sorting the operator $H_{J}$ in terms of powers in $p$ and $b_{>d}$, and in Theorem 5.7 we will make sure that this residuum is indeed small compared to the operator $\mathbb{T}_{N}$ defined in Eq. (4.11), which is quadratic in the operators $p$ and $b_{>d}$.

In order to illustrate the emergence of the additional constants $c_{J}$ in the residuum $R_{J}$ in Eq. (5.11), let us first investigate the following toy problem.

Example. Consider the toy Hamiltonian $H_{\text {toy }}:=b_{1}^{\dagger} b_{1}$ and the corresponding Hartree functional $\mathcal{E}_{\text {toy }}: \mathbb{C} \longrightarrow \mathbb{C}$ given by $\mathcal{E}_{\text {toy }}[z]:=|z|^{2}$. Using $b_{1}=q_{1}+i p_{1}$ and the commutation relation $\left[i p_{1}, q_{1}\right]=\frac{1}{2 N}$, we obtain

Let $D_{\mathcal{V}}$ be the derivative with respect to the imaginary part and $z=t+i s \in \mathbb{C}$, then

We then define the residuum corresponding to the operator Taylor approximation of $\left(1-\mathbb{L}^{\prime}\right)^{\frac{m}{2}}$, for different degrees of accuracy, as

& E_{m}^{2}:=\left(1-\mathbb{L}^{\prime}\right)^{\frac{m}{2}}-\eta_{m}(q)-\left.D_{\mathcal{V}}\right|_{q} \eta_{m}\left(b_{\geq 1}\right)-\left.\frac{1}{2} D_{\mathcal{V}}^{2}\right|_{0} \eta_{m}\left(b_{\geq 1}\right)-\frac{c_{m}}{N} .

Lemma 5.6. Let $J=(i, j) \in\{0, \ldots, 4\}^{2}$ be such that $\lambda_{J} \neq 0$, where $\lambda_{J}$ is defined in Lemma 5.3, and let $R_{J}$ be the residuum defined in Eq. (5.11). By distinguishing different cases with the help of the index $e_{J}:=|\{\ell \in J: \ell \in\{3,4\}\}|$ and the index $m_{J}:=$ $|\{\ell \in J: \ell=0\}|$, we can explicitly express $R_{J}$ as

- In the case $m_{J}=2$, i.e. $J=(0,0): R_{(0,0)}=\left(u_{0}^{\dagger} \cdot T \cdot u_{0}\right) E_{2}^{2}$.
- In the case $e_{J}=0$ and $m_{J}<2: R_{J}=\left(h_{i}^{\dagger} \cdot T \cdot h_{j}\right) E_{m_{J}}^{1}$.
- In the case $e_{J}=1$, there exists a constant $C$ and functions $F_{J}: \mathbb{R}^{d} \longrightarrow \mathbb{R}$ with $\left|F_{J}(t)\right| \leq C|t|$, such that

Proof. The Lemma can be verified by straightforward computations for the different individual cases. For the purpose of illustration, we will explicitly carry out the computations for the case $J=(3, j)$ with $j \in\{0,1,2\}$, i.e. we are going to verify Eq. (5.14) for this special case. Using the definition of $E_{m}^{0}$ in Definition 5.5, the observation $h_{j}=e_{j}(q)$ and the fact that $\left(i p_{\ell}^{\prime}\right)^{\dagger}=b_{\geq 1}^{\dagger} \cdot\left(u_{\ell}-\partial_{u_{\ell}} f(q)\right)-\left(u_{\ell}-\partial_{u_{\ell}} f(q)\right)^{\dagger} \cdot b_{\geq 1}$, we obtain

&=\frac{1}{2} \sum_{\ell=1}^{d} b_{\geq 1}^{\dagger} \cdot\left(u_{\ell}-\partial_{u_{\ell}} f(q)\right) u_{\ell}^{\dagger} \cdot T \cdot e_{j}(q) \eta_{m}(q)-\frac{1}{2} \sum_{\ell=1}^{d}\left(u_{\ell}-\partial_{u_{\ell}} f(q)\right)^{\dagger} \cdot b_{\geq 1} u_{\ell}^{\dagger} \cdot T \cdot e_{j}(q) \eta_{m}(q) \\
& \quad+\left(i p^{\prime}\right)^{\dagger} \cdot T \cdot e_{j}(q) E_{m}^{0} \tag{5.15}
\end{align*}
$$

where $m:=m_{J}$. Our goal is to commute $b_{\geq 1}$ in $\left(u_{\ell}-\partial_{u_{\ell}} f(q)\right)^{\dagger} \cdot b_{\geq 1} u_{\ell}^{\dagger} \cdot T \cdot e_{j}(q) \eta_{m}(q)$ to the right side, in order to obtain an expression which is of the same form as (5.10). We define the corresponding functions $w$ and $\widetilde{w}$ as

where $y: \mathbb{R}^{d} \longrightarrow \mathbb{R}$ is defined as $y(t):=-\frac{1}{4} \sum_{\ell} \partial_{\ell}\left(u_{\ell} \cdot T \cdot e_{j}(\vec{t}) \eta_{m}(\vec{t})\right)$. Furthermore

\left.D_{\mathcal{V}}\right|_{\vec{t}} \mathcal{E}_{J}(z) & =e_{3}(z)^{\dagger} \cdot T \cdot e_{j}(\vec{t}) \eta_{m}(\vec{t})=\sum_{\ell=1}^{d}\left(i \Im \mathfrak{I m}\left[\left(u_{\ell}-\partial_{t_{\ell}} f(t)\right)^{\dagger} \cdot z\right] u_{\ell}\right)^{\dagger} \cdot T \cdot e_{j}(\vec{t}) \eta_{m}(\vec{t}) \\
& =w(t)^{\dagger} \cdot z+z^{\dagger} \cdot \widetilde{w}(t)
\end{aligned}
$$

Consequently we can rewrite Eq. (5.15) as

Note that $\mathcal{E}_{J}(\vec{t})=0$ and $\left.D_{\mathcal{V}}^{2}\right|_{0} \mathcal{E}_{J}=0$. Therefore Eq. (5.14) follows from the fact that $F(t):=y(t)-c_{J}$ is Lipschitz and $F(0)=0$, which implies that there exists a constant $C$ such that $|F(t)| \leq C|t|$.

For the proof of the following Theorem, we will use various operator estimates derived in Appendices $C$ and .

Theorem 5.7. Let $J \in\{0, \ldots, 4\}^{2}$ be such that $\lambda_{J} \neq 0$ and let $R_{J}$ be the residuum defined in Eq. (5.11). Then,

with $\mathbb{T}_{N}$ defined in Eq. (4.11) and the $o_{*}(\cdot)$ notation from Definition 4.10.
Proof. Recall the definitions in Lemma 5.6 of $e_{J}:=|\{l \in J: l \in\{3,4\}\}|$, which counts how many of the indices in $J=(i, j)$ are equal to 3 or $4, m_{J}:=|\{l \in J: l=0\}|$, which counts how many of the indices are zero, and the residuum $R_{J}$ defined in Eq. (5.11). In order to prove the statement of the Theorem, we are going to verify $R_{J}=o_{*}\left(\mathbb{T}_{N}\right)$ for all $J$ with $\lambda_{J} \neq 0$.

The case $J=(0,0)$ : In this case we have the identity $R_{(0,0)}=\left(u_{0}^{\dagger} \cdot T \cdot u_{0}\right) E_{2}^{2}$, hence we have to verify $E_{2}^{2}=o_{*}\left(\mathbb{T}_{N}\right)$. In order to do this, recall the function $\eta_{2}(x)=$ $1-\|F(x)\|^{2}$ from Eq. (5.7) and let us compute using Lemma 4.9

= & \eta_{2}(q)+\left.D_{\mathcal{V}}\right|_{q} \eta_{2}\left(b_{\geq 1}\right)+\left.D_{\mathcal{V}}^{2}\right|_{0} \eta_{2}\left(b_{\geq 1}\right)+\frac{d}{4 N}-p^{\dagger} \cdot\left(p^{\prime}-p\right)-\left(p^{\prime}-p\right)^{\dagger} \cdot p^{\prime},
\end{aligned}
$$

where we used $\eta_{2}(q)=1-q^{\dagger} \cdot q-f(q)^{\dagger} \cdot f(q)$ and $p^{\dagger} \cdot p=\frac{1}{4} \sum_{j=1}^{d}\left(2 b_{j}^{\dagger} b_{j}-b_{j}^{2}-\left(b_{j}^{\dagger}\right)^{2}\right)+\frac{d}{4 N}$. Note that $\frac{c_{2}}{N}=\frac{d}{4 N}$, where $c_{2}$ is the constant from Definition 5.5. Since $p^{2} \leq \mathbb{T}_{N}$, it is clear that $p^{2}=O_{*}\left(\mathbb{T}_{N}\right)$. In Lemmata C. 6 and C.5, we will verify that $\left(p^{\prime}\right)^{2}=O_{*}\left(\mathbb{T}_{N}\right)$ and $\left(p^{\prime}-p\right)^{2}=o_{*}\left(\mathbb{T}_{N}\right)$. Therefore we obtain by the operator Cauchy-Schwarz inequality in the auxiliary Lemma C. 1 that $p^{\dagger} \cdot\left(p^{\prime}-p\right)$ as well as $\left(p^{\prime}-p\right)^{\dagger} \cdot p^{\prime}$ are of order $o_{*}\left(\mathbb{T}_{N}\right)$. We conclude $E_{2}^{2}=o_{*}\left(\mathbb{T}_{N}\right)$.

The case $e_{J}=0$, with $J \neq(0,0)$ : In this case $m_{J} \in\{0,1\}$ and the error is given by

R_{J}=h_{i}^{\dagger} \cdot T \cdot h_{j} E_{m_{J}}^{1}=e_{i}(q)^{\dagger} \cdot T \cdot e_{j}(q) E_{m_{J}}^{1} .
$$

We clearly have $E_{0}^{1}=0$. For $m_{J}=1$, let us define the function $V(t):=e_{i}(\vec{t})^{\dagger} \cdot T \cdot e_{j}(\vec{t})$, which satisfies $V(t) \leq C|t|$ for a constant $C$. In Lemma D. 2 we will then verify that $V(q) E_{1}^{1}=o_{*}\left(\mathbb{T}_{N}\right)$.

The case $e_{J}=1$ : In this case the error reads $R_{J}=\left(h_{i}^{\dagger} \cdot T \cdot h_{j}\right) E_{m_{J}}^{0}+\frac{F_{J}(q)}{N}$, where $F_{J}(t) \leq C|t|$ for some constant $C$. Using LemmaD.2 and LemmaC.4from the Appendix, we obtain that $\left(E_{1}^{0}\right)^{\dagger} E_{1}^{0}=o_{*}\left(T_{N}\right)$ and $\frac{F_{J}(q)}{N}=o_{*}\left(\frac{1}{N}\right)$. Regarding the first term, note that $E_{0}^{0}=0$. Hence, we assume w.l.o.g. $m_{J}=1$. We are done once we can verify

$$
\begin{equation*}
\left(h_{i}^{\dagger} \cdot T \cdot h_{j}\right) \cdot\left(h_{i}^{\dagger} \cdot T \cdot h_{j}\right)^{\dagger}=O_{*}\left(\mathbb{T}_{N}\right) \tag{5.16}
\end{equation*}
$$

in case one of the indices $i, j$ is in $\{3,4\}$ and the other is zero. Let us first assume $i \in\{3,4\}$. Then $h_{i}^{\dagger} \cdot T \cdot h_{j}=h_{i}^{\dagger} \cdot w$, with $w:=T \cdot u_{0} \in \mathcal{H}$, and therefore Eq. (5.16) follows from Lemma C. 6 in the case $i=3$ and from Lemma C. 5 in the case $i=4$. The proof of the case $j \in\{3,4\}$ follows analogously.

The case $e_{J}=2$ : In this case, the error is a linear combination of $\left(i p^{\prime}-i p\right)^{\dagger} \cdot T \cdot h_{j}$ and $h_{i}^{\dagger} \cdot T \cdot\left(i p^{\prime}-i p\right)$ with $h_{i}, h_{j} \in\left\{p^{\prime}, b_{>d}\right\}$. Note that $A:=\sqrt{T}\left(1_{\mathcal{H}}-\pi_{>d}\right)$ is bounded, and therefore

& \left(i p^{\prime}-i p\right)^{\dagger} \cdot T \cdot\left(i p^{\prime}-i p\right)=\left(i p^{\prime}-i p\right)^{\dagger} \cdot A^{\dagger} A \cdot\left(i p^{\prime}-i p\right) \\
& \quad \leq\|A\|^{2}\left(i p^{\prime}-i p\right)^{\dagger} \cdot\left(i p^{\prime}-i p\right)=o_{*}\left(\mathbb{T}_{N}\right)
\end{aligned}
$$

by Lemma C.5. Similarly, we have $\left(p^{\prime}\right)^{\dagger} \cdot T \cdot p^{\prime} \leq\|A\|^{2}\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}=O_{*}\left(\mathbb{T}_{N}\right)$ by Lemma C.6. Hence Lemma C. 1 tells us that $\left(i p^{\prime}-i p\right)^{\dagger} \cdot T \cdot h_{j}$ and $h_{i}^{\dagger} \cdot T \cdot\left(i p^{\prime}-i p\right)$ are of order $o_{*}\left(\mathbb{T}_{N}\right)$.

Corollary 5.8. Recall the functional $\mathcal{E}_{A}$ defined in Eq. (5.9) and let us define the constant $c:=\sum_{J \in\{0, \ldots, 4\}^{2}} \lambda_{J} c_{J}$. Then

\mathcal{W}_{N} \widetilde{A}_{N} \mathcal{W}_{N}^{-1}=\mathcal{E}_{A}(q)+\left.D_{\mathcal{V}}\right|_{q} \mathcal{E}_{A}\left(b_{\geq 1}\right)+\left.\frac{1}{2} D_{\mathcal{V}}^{2}\right|_{0} \mathcal{E}_{A}\left(b_{\geq 1}\right)+\frac{c}{N}+o_{*}\left(\mathbb{T}_{N}\right) .
$$

Proof. The statement follows from combining Lemma 5.3 and Theorem 5.7

### 5.2. Taylor Expansion of $\mathcal{W}_{N} \widetilde{B}_{N} \mathcal{W}_{N}^{-1}$

Similar to the previous subsection, we introduce atoms $H_{J}$ in Definition 5.9 as well as their classical counterparts $\mathcal{E}_{J}$ in Definition 5.10. In Lemma 5.11 we explain how $\mathcal{W}_{N} \widetilde{B}_{N} \mathcal{W}_{N}^{-1}$ and $\mathcal{E}_{B}$ can be written in terms of $H_{J}$ and $\mathcal{E}_{J}$, respectively.
Definition 5.9. Recall the definition of $h_{i}: \operatorname{dom}[\mathcal{N}] \longrightarrow \mathcal{F}_{0} \otimes \mathcal{H}$ from Definition 5.1. For a multi-index $J=(i, j, k, \ell)$ with $i, j, k, \ell \in\{0, \ldots, 4\}$, we define an operator $H_{J}$ on $\mathcal{W}_{N} \mathcal{F}_{\leq N}$ as

H_{J}:=\left(h_{i} \underline{\otimes} h_{j}\right)^{\dagger} \cdot \hat{v} \cdot h_{k} \underline{\otimes} h_{\ell}\left(1-\mathbb{L}^{\prime}\right)^{\frac{m_{J}}{2}},
$$

where $m_{J}$ counts how many of the indices $i, j, k, \ell$ are zero.

Definition 5.10. Recall the definition of $e_{i}: \mathcal{H}_{0} \longrightarrow \mathcal{H}$ and $\eta_{m}$ from Definition 5.2, For a multi-index $J=(i, j, k, \ell)$ with $i, j, k, \ell \in\{0, \ldots, 4\}$, we define $\mathcal{E}_{J}: \mathcal{H}_{0} \cap \operatorname{dom}[T] \longrightarrow \mathbb{C}$

$$
\mathcal{E}_{J}(z):=\left[e_{i}(z) \otimes e_{j}(z)\right]^{\dagger} \cdot \hat{v} \cdot e_{k}(z) \otimes e_{\ell}(z) \eta_{m_{J}}(z)
$$

where $m_{J}$ counts how many of the indices $i, j, k, \ell$ are zero and $\eta_{m}$ are the functions defined in Eq. (5.7).

Lemma 5.11. Let us define for all $i, j, k, \ell \in\{1, \ldots, 4\}$ the coefficients $\lambda_{(0,0,0,0)}:=\frac{1}{2}$, $\lambda_{(i, 0,0,0)}:=2, \lambda_{(i, j, 0,0)}:=\lambda_{(i, 0, k, 0)}:=\lambda_{(0, j, k, 0)}:=1, \lambda_{(i, j, k, 0)}:=2, \lambda_{(i, j, k, \ell)}:=\frac{1}{2}$ and all other coefficients are defined as $\lambda_{J}:=0$. Then

\mathcal{W}_{N} \widetilde{B}_{N} \mathcal{W}_{N}^{-1}=\sum_{J \in\{0, \ldots, 4\}^{4}} \lambda_{J} \mathfrak{R e}\left[H_{J}\right]
$$

Furthermore, the functional $\mathcal{E}_{B}$ defined as

$$
\begin{equation*}
\mathcal{E}_{B}(z):=\sum_{J \in\{0, \ldots, 4\}^{4}} \lambda_{J} \mathfrak{R e}\left[\mathcal{E}_{J}(z)\right] \tag{5.17}
\end{equation*}
$$

is an extension of $\left.\mathcal{E}_{B}^{\prime}\right|_{B_{r}}$ defined in Eq. (5.6), where $B_{r}:=\left\{z \in \mathcal{H}_{0} \cap \operatorname{dom}[T]:\|z\|<r\right\}$ and $r>0$ is a constant such that $\|F(z)\|<\frac{1}{2}$ for all $z \in \mathcal{H}_{0}$ with $\|z\|<r$.

The proof of Lemma 5.11 works analogously to the proof of Lemma 5.3. Following the strategy from Subsection 5.1 we are going to verify that the residuum $R_{J}$

\end{equation*}
$$

is small, where the constant $c_{J}$ are given by $c_{(0,0,0,0)}:=-\left.\frac{1}{8} \sum_{j=1}^{d} \partial_{t_{j}}^{2}\right|_{t=0} \mathcal{E}_{(0,0,0,0)}(\vec{t})$ and

$$
\begin{align*}
& c_{(3,3,0,0)}:=-\left.\frac{1}{8} \sum_{j=1}^{d} \partial_{t_{j}}^{2}\right|_{t=0} \mathcal{E}_{(1,1,0,0)}(\vec{t}), \quad c_{(3,1,0,0)}:=-c_{(3,3,0,0)}, \quad c_{(1,3,0,0)}:=c_{(3,3,0,0)}, \\
& c_{(3,0,3,0)}:=\left.\frac{1}{8} \sum_{j=1}^{d} \partial_{t_{j}}^{2}\right|_{t=0} \mathcal{E}_{(1,0,1,0)}(\vec{t}), \quad c_{(1,0,3,0)}:=-c_{(3,0,3,0)}, \quad c_{(3,0,1,0)}:=-c_{(3,0,3,0)}, \\
& c_{(0,3,3,0)}:=\left.\frac{1}{8} \sum_{j=1}^{d} \partial_{t_{j}}^{2}\right|_{t=0} \mathcal{E}_{(0,1,1,0)}(\vec{t}), \quad c_{(0,1,3,0)}:=-c_{(0,3,3,0)}, \quad c_{(0,3,1,0)}:=-c_{(0,3,3,0)}, \tag{5.19}
\end{align*}
$$

and all other constants are defined as $c_{J}:=0$. The proof will be split into two parts. In Lemma 5.12 we derive an explicit representation of the residuum $R_{J}$ by sorting the operator $H_{J}$ in terms of powers in $p$ and $b_{>d}$, and in Theorem 5.16 we will make sure that this residuum is indeed small compared to the operator $\mathbb{T}_{N}$.

Lemma 5.12. Let $J=(i, j, k, \ell) \in\{0, \ldots, 4\}^{4}$ be such that $\lambda_{J} \neq 0$, where $\lambda_{J}$ is defined in Lemma 5.11, and let $R_{J}$ be the residuum defined in Eq. (5.18). By distinguishing different cases with the help of the indices $e_{J}:=|\{\ell \in J: \ell \in\{3,4\}\}|$ and $m_{J}:=|\{\ell \in J: \ell=0\}|$, we can explicitly express $R_{J}$ as:

- In the case $m_{J}=4$, i.e. $J=(0,0,0,0): R_{J}=\left(h_{i} \underline{\otimes} h_{j}\right)^{\dagger} \cdot \hat{v} \cdot h_{k} \underline{\otimes} h_{\ell} E_{4}^{2}$.
- In the case $e_{J}=0$ and $m_{J}<4: R_{J}=\left(h_{i} \underline{\otimes} h_{j}\right)^{\dagger} \cdot \hat{v} \cdot h_{k} \underline{\otimes} h_{\ell} E_{m_{J}}^{1}$.
- In the case $e_{J}=1$, there exists a constant $C$ and functions $F_{J}: \mathbb{R}^{d} \longrightarrow \mathbb{R}$ with $\left|F_{J}(t)\right| \leq C|t|$, such that $R_{J}=\left(h_{i} \underline{\otimes} h_{j}\right)^{\dagger} \cdot \hat{v} \cdot h_{k} \underline{\otimes} h_{\ell} E_{m_{J}}^{0}+\frac{F_{J}(q)}{N}$.
- In the case $e_{J}=2$ and $m_{J}=2$ when two of the indices are 4:

R_{J}=-\left(h_{i} \underline{\otimes} h_{j}\right)^{\dagger} \cdot \hat{v} \cdot h_{k} \underline{\otimes} h_{\ell} \mathbb{L}^{\prime} .
$$

- In the case $e_{\widetilde{J}}=2$ and $m_{J}=\underset{\sim}{2}$ when one of the indices is 3 and another one is 4, let us define $\widetilde{h}_{3}:=p^{\prime}-p$ and $\widetilde{h}_{r}:=h_{r}$ for $r \in\{0,1,2,4\}$. Then,

R_{J}=-\left(h_{i} \underline{\otimes} h_{j}\right)^{\dagger} \cdot \hat{v} \cdot h_{k} \underline{\otimes} h_{\ell} \mathbb{L}^{\prime}+\left(\widetilde{h}_{i} \underline{\otimes} \widetilde{h}_{j}\right)^{\dagger} \cdot \hat{v} \cdot \widetilde{h}_{k} \underline{\otimes} \widetilde{h}_{\ell}
$$

- In the case $e_{J}=2$ and $m_{J}=2$ when two of the indices are 3, let us define the coefficients $\Lambda_{(3,3,0,0)}^{r, r^{\prime}}:=-\left(u_{r} \otimes u_{r^{\prime}}\right)^{\dagger} \cdot \hat{v} \cdot u_{0} \otimes u_{0}, \Lambda_{(3,0,3,0)}^{r, r^{\prime}}:=\left(u_{r} \otimes u_{0}\right)^{\dagger} \cdot \hat{v} \cdot u_{r^{\prime}} \otimes u_{0}$ and $\Lambda_{(0,3,3,0)}^{r, r^{\prime}}:=\left(u_{0} \otimes u_{r}\right)^{\dagger} \cdot \hat{v} \cdot u_{r^{\prime}} \otimes u_{0}$. Then,

$$
\begin{equation*}
R_{J}=-\left(h_{i} \underline{\otimes} h_{j}\right)^{\dagger} \cdot \hat{v} \cdot h_{k} \underline{\otimes} h_{\ell} \mathbb{L}^{\prime}+\sum_{r, r^{\prime}=1}^{d} \Lambda_{J}^{r, r^{\prime}}\left[\left(p_{r}^{\prime}-p_{r}\right) \cdot p_{r^{\prime}}^{\prime}+p_{r} \cdot\left(p_{r^{\prime}}^{\prime}-p_{r^{\prime}}\right)\right] \tag{5.20}
\end{equation*}
$$

- In the cases $e_{J}=2$ and $m_{J}<2$, respectively $e_{J}>2: R_{J}=H_{J}$.

Proof. Similar to the proof of Lemma 5.6, the proof of Lemma 5.12 follows from a straightforward computation for the individual cases. For the purpose of illustration, we will explicitly carry out the computations for the case $J=(3,0,3,0)$, i.e. we are going to verify Eq. (5.20). Since $\mathcal{E}_{(3,0,3,0)}(z)$ is quadratic in $\pi(z)$, we immediately obtain $\mathcal{E}_{(3,0,3,0)}(\vec{t})=0$ and $\left.D \mathcal{V}\right|_{\vec{t}} \mathcal{E}_{(3,0,3,0)}=0$. Let us define the coefficients $\lambda_{\alpha, \gamma}:=\left(u_{\alpha} \otimes u_{0}\right)^{\dagger}$. $\hat{v} \cdot u_{\gamma} \otimes u_{0}$, the operator $Q=\frac{1}{2} \sum_{\alpha, \gamma=1}^{d} \hat{v}_{\alpha 0, \gamma 0} u_{\alpha} \cdot u_{\gamma}^{\dagger}$ and $G \in \mathcal{H}_{0} \otimes \mathcal{H}_{0}$ by $G=$ $-\frac{1}{4} \sum_{\alpha, \gamma=1}^{d} \hat{v}_{\alpha 0, \gamma 0} u_{\alpha} \otimes u_{\gamma}$. Then

$$
\left.D_{\mathcal{V}}^{2}\right|_{0} \mathcal{E}_{(3,0,3,0)}(z)=z^{\dagger} \cdot Q \cdot z+G^{\dagger} \cdot z \otimes z+(z \otimes z) \cdot G
$$

and therefore $\left.D_{\mathcal{V}}^{2}\right|_{0} \mathcal{E}_{(3,0,3,0)}\left(b_{\geq 1}\right)=b_{\geq 1}^{\dagger} \cdot Q \cdot b_{\geq 1}+G^{\dagger} \cdot b_{\geq 1} \otimes b_{\geq 1}+\left(b_{\geq 1} \otimes b_{\geq 1}\right) \cdot G$. This concludes the proof of Eq. (5.20), since

\begin{aligned}
& H_{J}-\left(i p^{\prime} \underline{\otimes} u_{0}\right)^{\dagger} \cdot \hat{v} \cdot i p^{\prime} \underline{\otimes} u_{0}\left(-\mathbb{L}^{\prime}\right)-\sum_{r, r^{\prime}=1}^{d} \Lambda_{J}^{r, r^{\prime}}\left[\left(p_{r}^{\prime}-p_{r}\right) \cdot p_{r^{\prime}}^{\prime}+p_{r} \cdot\left(p_{r^{\prime}}^{\prime}-p_{r^{\prime}}\right)\right] \\
& =\left(i p \underline{\otimes} u_{0}\right)^{\dagger} \cdot \hat{v} \cdot i p \underline{\otimes} u_{0}=\sum_{\alpha, \gamma=1}^{d}\left(u_{\alpha} \otimes u_{0}\right)^{\dagger} \cdot \hat{v} \cdot u_{\gamma} \otimes u_{0} \frac{1}{2}\left(b_{\alpha}-b_{\alpha}^{\dagger}\right)^{\dagger} \cdot \frac{1}{2}\left(b_{\gamma}-b_{\gamma}^{\dagger}\right) \\
& =b_{\geq 1}^{\dagger} \cdot Q \cdot b_{\geq 1}+\left(b_{\geq 1} \underline{\otimes} b_{\geq 1}\right)^{\dagger} \cdot G+G^{\dagger} \cdot b_{\geq 1} \underline{\otimes} b_{\geq 1}+\frac{c_{(3,0,3,0)}}{N} .
\end{aligned}
$$

In the remainder of this subsection, we are going to verify that the residuum $R_{J}$ is small compared to the quadratic operator $\mathbb{T}_{N}$. Note that the error term in the last case of Lemma 5.12 is quite different from the other cases, since it simply corresponds to the whole operator $H_{J}$. This is not surprising, however, since the second order Taylor approximation of an object that is already of an higher order than two is zero, i.e. the residuum coincides with the object itself. With the help of the following three results in Lemma 5.13, Lemma 5.14 and Theorem 5.15, we will systematically verify that $H_{J}$ is small compared to the quadratic operator $\mathbb{T}_{N}$ in the cases $e_{J}=2$ and $m_{J}<2$, respectively $e_{J}>2$. Regarding all other cases, we will verify the smallness of the residuum in Theorem 5.16. In order to do this, we will repeatedly use results derived in Appendices C and D.

Lemma 5.13. For indices $i, j \in\{0, \ldots, 4\}$, we have the following estimates:

- In case one of the indices is contained in $\{3,4\}$, we have

\left(h_{i} \underline{\otimes} h_{j}\right)^{\dagger} \cdot|\hat{v}| \cdot h_{i} \underline{\otimes} h_{j}=O_{*}\left(\mathbb{T}_{N}\right) .
$$

- In case one of the indices is contained in $\{3,4\}$ and the other one is contained in $\{1, \ldots, 4\}$, we have

$$
\left(h_{i} \underline{\otimes} h_{j}\right)^{\dagger} \cdot|\hat{v}| \cdot h_{i} \underline{\otimes} h_{j}=o_{*}\left(\mathbb{T}_{N}\right) .
$$

Proof. We will repeatedly use the inequality $|v| \leq \Lambda(T+1)=: S$ from Assumption 1.1. which implies together with the translation-invariance of $T$ the inequalities $|\hat{v}| \leq S \otimes 1_{\mathcal{H}}$ and $|\hat{v}| \leq 1_{\mathcal{H}} \otimes S$.

The case $i \in\{1,2\}$ and $j \in\{3,4\}$ : Recall that $h_{k}=e_{k}(q)$ for $k \in\{0,1,2\}$ and let us define the function $\phi(t):=e_{i}(\vec{t})^{\dagger} \cdot S \cdot e_{i}(\vec{t})$. Using the inequality $|\hat{v}| \leq S \otimes 1_{\mathcal{H}}$ we obtain

$$
\left(e_{i}(q) \otimes h_{j}\right)^{\dagger} \cdot|\hat{v}| \cdot e_{i}(q) \underline{\otimes} h_{j} \leq h_{j}^{\dagger} \cdot \phi(q) \cdot h_{j} .
$$

Since $|\phi(t)| \leq C\left(|t|+|t|^{2}\right)$ for a constant $C$, we obtain $h_{3}^{\dagger} \cdot \phi(q) \cdot h_{3}=o_{*}\left(\mathbb{T}_{N}\right)$ and $h_{4}^{\dagger} \cdot \phi(q) \cdot h_{4}=o_{*}\left(\mathbb{T}_{N}\right)$ by Lemmata C.4 and C.6.

The case $i \in\{3,4\}$ and $j \in\{1,2\}$ : Making use of the commutation laws $\left[b_{\alpha}, q_{\beta}\right]=0$ and $\left[i p_{\alpha}, q_{\beta}\right]=\frac{1}{2 N} \delta_{\alpha, \beta}$, this case follows from the previous one.

The case $i=3, j=3$ : Let $\pi_{\leq d}:=\sum_{r=1}^{d} u_{r} \cdot u_{r}^{\dagger}$. Since $\left(\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}\right)^{2}=o_{*}\left(\mathbb{T}_{N}\right)$, we obtain $\left(p^{\prime} \underline{\otimes} p^{\prime}\right)^{\dagger} \cdot|\hat{v}| \cdot p^{\prime} \otimes p^{\prime} \leq\left(p^{\prime}\right)^{\dagger} \cdot\left(\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}\right) \otimes S \cdot p^{\prime} \leq\left\|\pi_{\leq d} S \pi_{\leq d}\right\|\left(\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}\right)^{2}=o_{*}\left(\mathbb{T}_{N}\right)$.

The case $i=4$ and $j \in\{3,4\}$ : Note that

$$
\begin{aligned}
&\left(b_{>d} \otimes \underline{h_{j}}\right)^{\dagger} \cdot|\hat{v}| \cdot b_{>d} \otimes h_{j} \leq 2\left(f(q) \otimes h_{j}\right)^{\dagger} \cdot|\hat{v}| \cdot f(q) \underline{\otimes} h_{j} \\
&+2\left(\left(b_{>d}+f(q)\right) \underline{\otimes} h_{j}\right)^{\dagger} \cdot|\hat{v}| \cdot\left(b_{>d}+f(q)\right) \underline{\otimes} h_{j}
\end{aligned}
$$

By the previous case $i \in\{1,2\}$ and $j \in\{3,4\}$, we know that $\left(f(q) \underline{\otimes} h_{j}\right)^{\dagger} \cdot|\hat{v}| \cdot f(q) \otimes h_{j}=$ $o_{*}\left(\mathbb{T}_{N}\right)$. For the second contribution, recall the definition of $\pi_{M, N}$ from Remark 4.11 and let $\hat{\pi}_{M, N}$ be the orthogonal projection onto the subspace $\mathcal{W}_{N} \mathcal{F}_{\leq M}^{+} \subset \mathcal{F}_{0}$, where

\begin{equation*}
\mathcal{F}_{\leq M}^{+}:=\mathbb{1}_{[0, M]}\left(\sum_{j>d}^{\infty} a_{j}^{\dagger} \cdot a_{j}\right) \tag{5.21}
\end{equation*}
$$

Since we have $b_{k} \hat{\pi}_{M, N}=\hat{\pi}_{M, N} b_{k} \hat{\pi}_{M, N}$ for $k>d$ and $\left[p_{j}^{\prime}, \hat{\pi}_{M, N}\right]=0$ by Lemma C.3, we obtain using $\pi_{M, N}=\hat{\pi}_{M, N} \pi_{M, N}$ (which follows from $\mathcal{W}_{N} \mathcal{F}_{\leq M} \subset \mathcal{W}_{N} \mathcal{F}_{\leq M}^{+}$)

& \quad \leq \pi_{M, N} h_{j}^{\dagger} \cdot\left(\hat{\pi}_{M, N}\left(b_{>d}+f(q)\right)^{\dagger} \cdot\left(b_{>d}+f(q)\right) \hat{\pi}_{M, N}\right) \otimes S \cdot h_{j} \pi_{M, N} \\
& \quad \leq \frac{M}{N} \pi_{M, N} h_{j}^{\dagger} \cdot S \cdot h_{j} \pi_{M, N} \leq C \frac{M}{N} \pi_{M, N} \mathbb{T}_{N} \pi_{M, N}

for a constant $0<C<\infty$, where we used $h_{j}^{\dagger} \cdot S \cdot h_{j}=O_{*}\left(\mathbb{T}_{N}\right)$ and and the characterization of the $O_{*}(\cdot)$ notation in Remark 4.11 for the last inequality. Using this characterization for the inequality above yields $\left(\left(b_{>d}+f(q)\right) \otimes h_{j}\right)^{\dagger} \cdot|\hat{v}| \cdot\left(b_{>d}+f(q)\right) \otimes h_{j}=o_{*}\left(\mathbb{T}_{N}\right)$.

The case $i=0$ and $j \in\{3,4\}$, respectively $i \in\{3,4\}$ and $j=0$ : Since $h_{0}=1_{\mathcal{F}_{0}} \otimes u_{0}$ commutes with $h_{3}=i p^{\prime}$ and $h_{4}=b_{>d}$, we assume w.l.o.g. $i=0$ and $j \in\{3,4\}$. With $\lambda:=u_{0}^{\dagger} \cdot S \cdot u_{0}$, we obtain

The proof of Lemma 5.14 is based on the commutation relations $\left[b_{\alpha}, b_{\beta}^{\dagger}\right]=\frac{1}{N} \delta_{\alpha, \beta}$ and $\left[p_{\alpha}, q_{\beta}\right]=\frac{1}{2 i N} \delta_{\alpha, \beta}$, and is left to the reader.

Note that the case $e_{(i, j)}=0$ is only possible for the first bullet point, and the proof of the statement follows from the case $e_{(k, \ell)}=0$, since

In any case we have to verify

We define the operator $X:=(T+1)^{\frac{1}{2}} \cdot h_{i}$ and depending on the concrete bullet point let us define $Y:=h_{j}^{\dagger} \otimes 1_{\mathcal{H}} \cdot G(q) Z$ with $Z:=1_{\mathcal{F}_{0}}, Z:=\mathbb{L}^{\prime}$ or $Z:=\sqrt{1-\mathbb{L}^{\prime}}$. In the following, we have to verify $X^{\dagger} \cdot Y=o_{*}\left(\mathbb{T}_{N}\right)$. Since $i \in\{3,4\}$, we know that $X^{\dagger} \cdot X=O_{*}\left(\mathbb{T}_{N}\right)$. and Corollary D. 4 then yields that $Z^{\dagger}\|G(q)\|^{2} Z$ and $Z^{\dagger} \frac{1}{N}\left(\sum_{r=1}^{d}\left\|\partial_{r} G(q)\right\|^{2}\right) Z$ are of order $o_{*}(1)$. Therefore, $Z^{\dagger} \frac{1}{N}\|G(q)\|^{2} Z$ and $Z^{\dagger} \frac{d}{N^{2}}\left(\sum_{r=1}^{d}\left\|\partial_{r} G(q)\right\|^{2}\right) Z$ are both of order $o_{*}\left(\mathbb{T}_{N}\right)$. The case $e_{J}=0$ and $m_{J}=1$ : In this case, $R_{J}=V(q) E_{1}^{1}$, with $V(t):=\left(e_{i}(\vec{t}) \otimes\right.$ $\left.e_{j}(\vec{t})\right)^{\dagger} \cdot \hat{v} \cdot e_{k}(\vec{t}) \otimes e_{\ell}(\vec{t})$. Since the $C^{1}$ function $V$ satisfies $F(0)=0$, we obtain

E_{2}^{1}=\left(1-\mathbb{L}^{\prime}\right)-\eta_{2}(q)-\left.D \mathcal{V}\right|_{q} \eta_{2}\left(b_{\geq 1}\right)=-\left(b_{>d}^{\dagger} \cdot b_{>d}+\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}-\frac{d}{2 N}\right) .
$$

By Lemmata C.4 and C. 6 we know that $V(q) b_{>d}^{\dagger} \cdot b_{>d}=V(q) b_{>d}^{\dagger} \cdot b_{>d}$ and $V(q)\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}$ are of order $o_{*}\left(\mathbb{T}_{N}\right)$, and consequently $V(q) E_{2}^{1}=o_{*}\left(\mathbb{T}_{N}\right)$.

The case $e_{J}=0$ and $m_{J}=3$ : In this case $R_{J}=V(q) E_{3}^{1}$, with $V(t):=\left(e_{i}(\vec{t}) \otimes\right.$ $\left.e_{j}(\vec{t})\right)^{\dagger} \cdot \hat{v} \cdot e_{k}(\vec{t}) \otimes e_{\ell}(\vec{t})$. We compute

= & \left(f(q)^{\dagger} \cdot b_{>d}+b_{>d} \cdot f(q)\right)^{2}+\left\{f(q)^{\dagger} \cdot b_{>d}+b_{>d} \cdot f(q),\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}+b_{>d}^{\dagger} \cdot b_{>d}\right\} \\
& +\left(\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}+b_{>d}^{\dagger} \cdot b_{>d}\right)^{2}+\left\{\eta_{2}(q),\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}+b_{>d}^{\dagger} \cdot b_{>d}\right\} \\
& +2 p^{\dagger} \cdot\left(p^{\prime}-p\right)+2\left(p^{\prime}-p\right)^{\dagger} \cdot p^{\prime}-\frac{d}{N} \mathbb{L}^{\prime}+\frac{d^{2}}{4 N^{2}},
\end{aligned}

with the notation $\{A, B\}:=A B+B A$. Clearly $\frac{d}{N} \mathbb{L}^{\prime}=o_{*}\left(\mathbb{T}_{N}\right)$. Consequently, $\left\{\eta_{2}(q),\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}+b_{>d}^{\dagger} \cdot b_{>d}\right\}$ and $\left\{f(q)^{\dagger} \cdot b_{>d}+b_{>d} \cdot f(q),\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}+b_{>d}^{\dagger} \cdot b_{>d}\right\}$ are of order $o_{*}\left(\mathbb{T}_{N}\right)$ as well.

The case $e_{J}=1$ : In this case, we have $R_{J}=\left(h_{i} \underline{\otimes} h_{j}\right)^{\dagger} \cdot \hat{v} \cdot h_{k} \underline{\otimes} h_{\ell} E_{m_{J}}^{0}+\frac{F_{J}(q)}{N}$. By Lemma Lemma C.4, we know that $\frac{F_{J}(q)}{N}=o_{*}\left(\mathbb{T}_{N}\right)$. Since we know that $\left(E_{m_{J}}^{0}\right)^{2}=$ $o_{*}\left(\mathbb{T}_{N}\right)$ by Corollary D.5, we are done once we can verify that $X_{J} \cdot X_{J}^{\dagger}=O_{*}\left(\mathbb{T}_{N}\right)$, where $X_{J}:=\left(h_{i} \underline{\otimes} h_{j}\right)^{\dagger} \cdot \hat{v} \cdot h_{k} \underline{\otimes} h_{\ell}$.

With $3 \in\{i, j, k, \ell\}$ : Let us first assume $j=3$, and define $w(t):=e_{i}(\vec{t})^{\dagger} \otimes 1_{\mathcal{H}} \cdot \hat{v}$. $e_{k}(\vec{t}) \otimes e_{\ell}(\vec{t})$. Clearly, $X_{J}=\left(i p^{\prime}\right)^{\dagger} \cdot w(q)$ and therefore $X_{J} X_{J}^{\dagger}=O_{*}\left(\mathbb{T}_{N}\right)$ follows from C.6. The other cases $i=3, k=3$ and $\ell=3$ follows from the commutation relation $\left[i p_{\alpha}^{\prime}, q_{\beta}\right]=\frac{1}{2 N} \delta_{\alpha, \beta}$.

With $4 \in\{i, j, k, \ell\}$ : In any case, $X_{J}$ is either equal to $w(q)^{\dagger} \cdot b_{>d}$ or $b_{>d}^{\dagger} \cdot w(q)$, where $w: \mathbb{R}^{d} \longrightarrow \mathcal{H}$ with $\|w(t)\| \leq c|t|^{j}$ and $j \geq 0$. The case $\{i, j, k, \ell\}=\{0,3,4\}$ works similarly, and is left to the reader.

The cases $e_{J}=2$ and $m_{J}<2$, respectively $e_{J}>2$ : We obtain for $m_{J}=0$ by the first bullet point of Theorem 5.15, and for $m_{J}=1$ by the third bullet point, that

\mathcal{W}_{N} \widetilde{B}_{N} \mathcal{W}_{N}^{-1}=\mathcal{E}_{B}(q)+\left.D \mathcal{V}\right|_{q} \mathcal{E}_{B}(b \geq 1)+\left.\frac{1}{2} D_{\mathcal{V}}^{2}\right|_{0} \mathcal{E}_{B}\left(b_{\geq 1}\right)+\frac{\tilde{c}}{N}+o_{*}\left(\mathbb{T}_{N}\right)
$$

Recall the definition of $c_{J}$ in Eq. (5.12) for $J \in\{0, \ldots, 4\}^{2}$, respectively Eq. (5.19) for $J \in\{0, \ldots, 4\}^{4}$. Making use of the observation that most of the $c_{J}$ are zero, we obtain

c+\tilde{c} & =\sum_{J \in\{0, \ldots, 4\}^{2}} \lambda_{J} c_{J}+\sum_{J \in\{0, \ldots, 4\}^{4}} \lambda_{J} c_{J}=\lambda_{(0,0)} c_{(0,0)}+\lambda_{(1,1)}\left[c_{(1,3)}+c_{(3,1)}+c_{(3,3)}\right] \\
& +\lambda_{(0,0,0,0)} c_{(0,0,0,0)}+\lambda_{(1,1,0,0)}\left[c_{(3,3,0,0)}+c_{(3,1,0,0)}+c_{(1,3,0,0)}\right] \\
& +\lambda_{(1,0,1,0)}\left[c_{(3,0,3,0)}+c_{(3,0,1,0)}+c_{(1,0,3,0)}\right]+\lambda_{(0,1,1,0)}\left[c_{(0,3,3,0)}+c_{(0,1,3,0)}+c_{(0,3,1,0)}\right] \\
& =-\left.\frac{1}{8} \partial_{t_{j}}^{2}\right|_{t=0} \sum_{j=1}^{d}\left(\lambda_{(0,0)} \mathcal{E}_{(0,0)}(\vec{t})+\lambda_{(1,1)} \mathcal{E}_{(1,1)}(\vec{t})+\lambda_{(0,0,0,0)} \mathcal{E}_{(0,0,0,0)}(\vec{t})\right. \\
& \left.+\lambda_{(1,1,0,0)} \mathcal{E}_{(1,1,0,0)}(\vec{t})+\lambda_{(1,0,1,0)} \mathcal{E}_{(1,0,1,0)}(\vec{t})+\lambda_{(0,1,1,0)} \mathcal{E}_{(0,1,1,0)}(\vec{t})\right) \\
& =-\left.\frac{1}{8} \sum_{j=1}^{d} \partial_{t_{j}}^{2}\right|_{t=0}\left(\mathcal{E}_{A}(\vec{t})+\mathcal{E}_{B}(\vec{t})\right)=0,
\end{aligned}
$$

where we have used in the first equality of the last line that $\left.\partial_{t_{j}}^{2}\right|_{t=0} \lambda_{J} \mathcal{E}_{J}(\vec{t})=0$ for

J \notin\{(0,0),(1,1),(1,1,0,0),(1,0,1,0),(0,1,1,0)\}
$$

and in the second equality of the last line that $\mathcal{E}_{A}(\vec{t})+\mathcal{E}_{B}(\vec{t})=\mathcal{E}^{\prime}(\vec{t})=e_{\mathrm{H}}$ for $t$ small enough, where $\mathcal{E}^{\prime}$ is defined in Eq. (5.1).

Proof of Theorem 4.12. Making use of Eq. (3.8), we obtain

\left(\mathcal{W}_{N} U_{N}\right) N^{-1} H_{N}\left(\mathcal{W}_{N} U_{N}\right)^{-1}=\mathcal{W}_{N} \widetilde{A}_{N} \mathcal{W}_{N}^{-1}+\mathcal{W}_{N} \widetilde{B}_{N} \mathcal{W}_{N}^{-1}+o_{*}\left(\mathbb{T}_{N}\right) \tag{5.22}
\end{equation*}
$$

where we have used that $\mathcal{W}_{N} b_{\geq 1}^{\dagger} \cdot T \cdot b_{\geq 1} \mathcal{W}_{N}^{-1} \leq 2\left(X_{1}+X_{2}\right)$ with

$$
\begin{aligned}
& X_{1}:=(q+f(q))^{\dagger} \cdot T \cdot(q+f(q))=o_{*}(1), \\
& X_{2}:=\left(i p^{\prime}+b_{>d}\right)^{\dagger} \cdot T \cdot\left(i p^{\prime}+b_{>d}\right)=O_{*}\left(\mathbb{T}_{N}\right),
\end{aligned}
$$

see Lemmata C. 4 and C.6. Combining Corollaries 5.8 and 5.17 yields

$$
\mathcal{W}_{N} \widetilde{A}_{N} \mathcal{W}_{N}^{-1}+\mathcal{W}_{N} \widetilde{B}_{N} \mathcal{W}_{N}^{-1}=\mathcal{E}(q)+\left.D_{\mathcal{V}}\right|_{q} \mathcal{E}\left(b_{\geq 1}\right)+\left.\frac{1}{2} D_{\mathcal{V}}^{2}\right|_{0} \mathcal{E}\left(b_{\geq 1}\right)+o_{*}\left(\mathbb{T}_{N}\right)
$$

with $\mathcal{E}:=\mathcal{E}_{A}+\mathcal{E}_{B}$. Furthermore, note that $\mathcal{E}(z)=\mathcal{E}^{\prime}(z)$ for $\|z\|<r$ where $\mathcal{E}^{\prime}$ is defined in Eq. (5.1), see Lemmata 5.3 and 5.11. Therefore, $\mathcal{E}(\vec{t})=e_{\mathrm{H}}$ and $\left.D_{\mathcal{V}}\right|_{t} \mathcal{E}=0$ for $t$ small enough. As we will show in Lemma C.2, this implies $\mathcal{E}(q)=e_{\mathrm{H}}+o_{*}\left(\mathbb{T}_{N}\right)$ and $\left.D_{\mathcal{V}}\right|_{q} \mathcal{E}\left(b_{\geq 1}\right)=o_{*}\left(\mathbb{T}_{N}\right)$. Furthermore, we have $\left.\frac{1}{2} D_{\mathcal{V}}^{2}\right|_{0} \mathcal{E}=$ Hess $\left.\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}$ and therefore

\left.\frac{1}{2} D_{\mathcal{V}}^{2}\right|_{0} \mathcal{E}\left(b_{\geq 1}\right)=N^{-1} \mathbb{H}
$$

In combination with Eq. (5.22) this concludes the proof.

## A. Coercivity of the Hessian in Example (II)

In the following we are going to verify that the Hartree energy of a system of pseudorelativistic bosons in $\mathbb{R}^{3}$ interacting via a Newtonian potential, given by

\mathcal{E}_{g}[u]:=\left\langle\sqrt{m^{2}-\Delta}-m\right\rangle_{u}-(u \otimes u)^{\dagger} \cdot \frac{g}{2|x-y|} \cdot u \otimes u
$$

satisfies the coercivity assumption in Eq. (1.7) for $g$ small enough, see Example (II) in the introduction. Note that we are using the notation introduced in Section 3. Let us denote with $u_{g, \beta}$ the unique radial minimizer of the functional $\mathcal{E}_{g}$ subject to the rescaled condition $\|u\|=1+\beta$, i.e. $u_{g, \beta}$ is radial, and satisfies $\left\|u_{g, \beta}\right\|=1+\beta$ and $\mathcal{E}_{g}\left[u_{g, \beta}\right]=\inf _{\|u\|=1+\beta} \mathcal{E}_{g}[u]$. Let us further denote the normed minimizers by $u_{g}:=u_{g, 0}$. By a scaling argument it is easy to see that $u_{g, \beta}=(1+\beta) u_{g(1+\beta)^{2}}$. For real-valued functions $f$ and $h$ in $\left\{u_{g, \beta}\right\}^{\perp}$ we can express the Hessian as $\frac{1}{2} \operatorname{Hess}_{u_{g, \beta}} \mathcal{E}_{g}[f+i h]=\left\langle L_{g, \beta}^{+}\right\rangle_{f}+\left\langle L_{g, \beta}^{-}\right\rangle_{h}$, where $L_{g, \beta}^{+}$and $L_{g, \beta}^{-}$are selfadjoint operators given by

& L_{g, \beta}^{-}:=\sqrt{m^{2}-\Delta}-m-\mu_{g, \beta}-\left(1 \otimes u_{g, \beta}\right)^{\dagger} \cdot \frac{g}{|x-y|} \cdot 1 \otimes u_{g, \beta}, \\
& L_{g, \beta}^{+}:=L_{g, \beta}^{-}-\left(1 \otimes u_{g, \beta}\right)^{\dagger} \cdot \frac{2 g}{|x-y|} \cdot u_{g, \beta} \otimes 1,
\end{aligned}
$$

with $\mu_{g, \beta}:=\left\langle\sqrt{m^{2}-\Delta}-m\right\rangle_{u_{g, \beta}}-\left(u_{g, \beta} \otimes u_{g, \beta}\right)^{\dagger} \cdot \frac{g}{|x-y|} \cdot u_{g, \beta} \otimes u_{g, \beta}$. Furthermore we denote the operators associated to the normed minimizers $u_{g}$ by $L_{g}^{ \pm}:=L_{g, 0}^{ \pm}$. Note that

$$
\left\langle L_{g}^{-}-L_{g}^{+}\right\rangle_{f}=\left(f \otimes u_{g}\right)^{\dagger} \cdot \frac{2 g}{|x-y|} \cdot u_{g} \otimes f>0
$$

for all $f \neq 0$, and consequently it is enough to verify the following Theorem A.1 in order to prove Eq. (1.7).

Theorem A.1. There exist constants $g_{0}$ and $\eta>0$ such that for all $0<g<g_{0}$ and $f \in L^{2}\left(\mathbb{R}^{d}\right)$ with $f \perp\left\{u_{g}, \partial_{x_{1}} u_{g}, \partial_{x_{2}} u_{g}, \partial_{x_{3}} u_{g}\right\}$

$$
\left\langle L_{g}^{+}\right\rangle_{f} \geq \eta\|f\|^{2}
$$

In order to prove Theorem A.1, we first need some auxiliary results regarding the minimizers $u_{g, \beta}$ subject to the rescaled condition $\left\|u_{g, \beta}\right\|=1+\beta$.
Lemma A.2. Let us define $R_{g, \beta}:=u_{g, \beta}-u_{g}$ for $\beta \in[0,1$ ) (where 1 can be replaced by any other positive number). Then there exist constants $g_{0}, C>0$ such that

L_{g}^{+} R_{g, \beta}=\delta_{g, \beta} u_{g}+\epsilon_{g, \beta},
$$

with $\left|\delta_{g, \beta}\right| \leq C \beta$ and $\left\|\epsilon_{g, \beta}\right\| \leq C\left\|R_{g, \beta}\right\|^{2}$ for $g \in\left(0, g_{0}\right)$ and $\beta \in[0,1)$.

Proof. Since the elements $u_{g, \beta}$ are minimizers of $\mathcal{E}_{g}$, they satisfy the corresponding EulerLagrange equations $L_{g, \beta}^{-} u_{g, \beta}=0$. A straightforward computation yields

0=L_{g, \beta}^{-} u_{g, \beta}-L_{g}^{-} u_{g}=L_{g}^{+} R_{g, \beta}-\delta_{g, \beta} u_{g}-\epsilon_{g, \beta}
$$

with

$$
\begin{align*}
\delta_{g, \beta}:= & \mu_{g, \beta}-\mu_{g} \\
\epsilon_{g, \beta}:= & \left(\mu_{g, \beta}-\mu_{g}\right) R_{g, \beta}+\left(1 \otimes u_{g, \beta}\right)^{\dagger} \cdot \frac{g}{|x-y|} \cdot R_{g, \beta} \otimes R_{g, \beta} \\
& +\left(1 \otimes R_{g, \beta}\right)^{\dagger} \cdot \frac{g}{|x-y|} \cdot R_{g, \beta} \otimes u_{g}+\left(1 \otimes R_{g, \beta}\right)^{\dagger} \cdot \frac{g}{|x-y|} \cdot u_{g} \otimes R_{g, \beta} . \tag{A.1}
\end{align*}
$$

Let us first investigate the contributions involving $\frac{g}{|x-y|}$. From [16, Proposition 1] it is clear that there exists a constant $C$ such that $\left\|u_{g, \beta}\right\|_{H^{1}\left(\mathbb{R}^{3}\right)} \leq C<\infty$ for all $g$ small enough and $\beta \in[0,1)$. With the notation $S:=\sqrt{1-\Delta}$ we obtain

\begin{aligned}
& \left\|\left(1 \otimes u_{g, \beta}\right)^{\dagger} \cdot \frac{g}{|x-y|} \cdot R_{g, \beta} \otimes R_{g, \beta}\right\|=\left\|\left(1 \otimes S u_{g, \beta}\right)^{\dagger} \cdot 1 \otimes S^{-1} \frac{g}{|x-y|} \cdot R_{g, \beta} \otimes R_{g, \beta}\right\| \\
& \quad \leq g\left\|S u_{g, \beta}\right\|\left\|1 \otimes S^{-1} \frac{1}{|x-y|}\right\|\left\|R_{g, \beta}\right\|^{2} \leq C g\left\|S^{-1} \frac{1}{|x|}\right\|\left\|R_{g, \beta}\right\|^{2},
\end{aligned}
$$

where $\left\|S^{-1} \frac{1}{|x|}\right\|$ is the operator norm of the bounded one-particle operator $S^{-1} \frac{1}{|x|}$. Similarly, the other contributions involving $\frac{g}{|x-y|}$ in Eq. (A.1) can be estimated by $C g\left\|S^{-1} \frac{1}{|x|}\right\|\left\|R_{g, \beta}\right\|^{2}$ as well. The uniform control of the norm $\left\|u_{g, \beta}\right\|_{H^{1}\left(\mathbb{R}^{3}\right)} \leq C<\infty$ furthermore implies $\left|\delta_{g, \beta}\right|=\left|\mu_{g, \beta}-\mu_{g}\right| \leq \tilde{C} \beta$ for some constant $\tilde{C}$. Note that $\left\|R_{g, \beta}\right\| \geq$ $\left\|u_{g, \beta}\right\|-\left\|u_{g}\right\|=\beta$, and consequently $\left\|\left(\mu_{g, \beta}-\mu_{g}\right) R_{g, \beta}\right\| \leq \tilde{C} \beta\left\|R_{g, \beta}\right\| \leq \tilde{C}\left\|R_{g, \beta}\right\|^{2}$. We conclude that

$$
\left\|\epsilon_{g, \beta}\right\| \leq\left(\tilde{C}+3 C g\left\|S^{-1} \frac{1}{|x|}\right\|\right)\left\|R_{g, \beta}\right\|^{2} .
$$

Lemma A.3. Let $R_{g, \beta}$ and $\epsilon_{g, \beta}$ be as in Lemma A.2. Then there exists a constant $g_{0}>0$ such that $\lim _{\beta \rightarrow 0} \frac{\left\|\epsilon_{q, \beta}\right\|}{\left\langle u_{g}, R_{g, \beta}\right\rangle}=0$ and $\limsup _{\beta \rightarrow 0} \frac{\left|\delta_{g, \beta}\right|}{\left\langle u_{g}, R_{g, \beta}\right\rangle} \leq C$ for a suitable constant $C>0$ and $g \in\left(0, g_{0}\right)$.

Proof. By the results in [16] we know that 0 is an isolated eigenvalue of $L_{g}^{+}$, i.e. there exists a constant $\delta>0$ such that $\sigma\left(L_{g}^{+}\right) \cap(-\delta, \delta)=\{0\}$, with corresponding eigenvectors $\partial_{x_{1}} u_{g}, \partial_{x_{2}} u_{g}, \partial_{x_{3}} u_{g}$. Since $u_{g, \beta}$ is radial, we know that $R_{g, \beta} \perp \partial_{x_{j}} u_{g}$, and therefore we obtain by Lemma A. 2

$$
\begin{equation*}
\delta\left\|R_{g, \beta}\right\| \leq\left\|L_{g}^{+} R_{g, \beta}\right\| \leq C\left(\beta+\left\|R_{g, \beta}\right\|^{2}\right) . \tag{A.2}
\end{equation*}
$$

Using [16, Proposition 1] again, it is clear that $\lim _{g \rightarrow 0, \beta \rightarrow 0}\left\|R_{g, \beta}\right\|=0$ and therefore there exists a constant $g_{0}$ such that $\left\|R_{g, \beta}\right\| \leq \frac{\delta}{2 C}$ for all $g \in\left(0, g_{0}\right)$ and $\beta$ small enough. Consequently Eq. (A.2) yields $\left\|R_{g, \beta}\right\| \leq \frac{2 \mathcal{C}}{\delta} \beta$. Using the fact that $\left\|u_{g, \beta}\right\|=1+\beta$, we further obtain

1+2 \beta \leq(1+\beta)^{2}=1+2\left\langle u_{g}, R_{g, \beta}\right\rangle+\left\|R_{g, \beta}\right\|^{2} \leq 1+2\left\langle u_{g}, R_{g, \beta}\right\rangle+\left(\frac{2 C}{\delta}\right)^{2} \beta^{2}
$$

and therefore

$$
\begin{gathered}
\frac{\left\|\epsilon_{g, \beta}\right\|}{\left\langle u_{g}, R_{g, \beta}\right\rangle} \leq \frac{C\left(\frac{2 C}{\delta}\right)^{2} \beta^{2}}{\beta-2\left(\frac{C}{\delta}\right)^{2} \beta^{2}} \underset{\beta \rightarrow 0}{\longrightarrow} 0, \\
\frac{\left|\delta_{g, \beta}\right|}{\left\langle u_{g}, R_{g, \beta}\right\rangle} \leq \frac{C \beta}{\beta-2\left(\frac{C}{\delta}\right)^{2} \beta^{2}} \underset{\beta \rightarrow 0}{\longrightarrow} C .
\end{gathered}
$$

Proof of Theorem A.1. Let $Q$ denote the projection onto the space $\left\{u_{g}\right\}^{\perp}$. Clearly there exists a $w \in L^{2}\left(\mathbb{R}^{3}\right)$ such that

$$
L_{g}^{+} f=Q L_{g}^{+} f+\langle w, f\rangle u_{g}
$$

for all $f \in L^{2}\left(\mathbb{R}^{3}\right)$. With $R_{g, \beta}, \delta_{g, \beta}$ and $\epsilon_{g, \beta}$ from Lemma A. 2 at hand, we obtain

$$
L_{g}^{+}\left(\delta_{g, \beta} f-\langle w, f\rangle R_{g, \beta}\right)=\delta_{g, \beta} Q L_{g}^{+} f-\langle w, f\rangle \epsilon_{g, \beta},
$$

and therefore $\left\|L_{g}^{+}\left(\delta_{g, \beta} f-\langle w, f\rangle R_{g, \beta}\right)\right\| \leq\left|\delta_{g, \beta}\right|\left\|Q L_{g}^{+} f\right\|+\|w\|\left\|\epsilon_{g, \beta}\right\|\|f\|$. Using again that there exists a constant $\delta>0$ such that $\sigma\left(L_{g}^{+}\right) \cap(-\delta, \delta)=\{0\}$ with corresponding eigenvectors $\partial_{x_{1}} u_{g}, \partial_{x_{2}} u_{g}, \partial_{x_{3}} u_{g}$, see [16], and that $R_{g, \beta}$ as a radial function is orthogonal to them, we obtain for all $f \in\left\{u_{g}, \partial_{x_{1}} u_{g}, \partial_{x_{2}} u_{g}, \partial_{x_{3}} u_{g}\right\}^{\perp}$

$$
\left\|L_{g}^{+}\left(\delta_{g, \beta} f-\langle w, f\rangle R_{g, \beta}\right)\right\| \geq \delta\left\|\delta_{g, \beta} f-\langle w, f\rangle R_{g, \beta}\right\| \geq \delta\left|\left\langle u_{g}, R_{g, \beta}\right\rangle\right||\langle w, f\rangle| .
$$

Combining the estimates we have so far yields

$$
|\langle w, f\rangle| \leq \frac{\left|\delta_{g, \beta}\right|}{\delta\left|\left\langle u_{g}, R_{g, \beta}\right\rangle\right|}\left\|Q L_{g}^{+} f\right\|+\frac{\|w\|\left\|\epsilon_{g, \beta}\right\|}{\delta\left|\left\langle u_{g}, R_{g, \beta}\right\rangle\right|}\|f\|=: x_{\beta}\left\|Q L_{g}^{+} f\right\|+y_{\beta}\|f\| .
$$

By Lemma A.3 we know that $\underset{\beta \rightarrow 0}{\limsup }\left|x_{\beta}\right| \leq C$ for some constant $C>0$ and $y_{\beta} \underset{\beta \rightarrow 0}{\longrightarrow} 0$. Using again that $\sigma\left(L_{g}^{+}\right) \cap(-\delta, \delta)=\{0\}$, we obtain

$$
\delta\|f\| \leq\left\|L_{g}^{+} f\right\| \leq\left\|Q L_{g}^{+} f\right\|+|\langle w, f\rangle| \leq\left(1+x_{\beta}\right)\left\|Q L_{g}^{+} f\right\|+y_{\beta}\|f\|
$$

and consequently $\left\|Q L_{g}^{+} f\right\| \geq \frac{\delta-y_{\beta}}{1+x_{\beta}}\|f\|$. This holds for all (small) $\beta$, hence $\beta \rightarrow 0$ gives $\left\|Q L_{g}^{+} f\right\| \geq \frac{\delta}{1+C}\|f\|$. Finally note that $Q L_{g}^{+} Q \geq 0$ since $\left\langle L_{g}^{+}\right\rangle_{f}=\left.\frac{1}{2} \operatorname{Hess}\right|_{u_{g}} \mathcal{E}_{g}[f] \geq 0$ for real-valued $f \perp u_{g}$, which concludes the proof.

## B. The Bogoliubov Operator

In the following we will prove Theorem4.4, i.e. we are going to verify that the Bogoliubov operator $\mathbb{H}$ constructed in Definition 4.3 is bounded from below and that its ground state energy can be approximated by $\Psi \in \bigcup_{M \in \mathbb{N}} \operatorname{dom}\left[a_{\geq 1}^{\dagger} \cdot(T+1) \cdot a_{\geq 1}\right] \cap \mathcal{F}_{\leq M}$ with $\|\Psi\|=1$. Our strategy is to decouple the degenerate modes from the non-degenerate ones and to apply the general framework for non-degenerate Bogoliubov operators in [27].
Definition B.1. Let $Q_{\mathrm{H}}=\sum_{i, j \geq 1} Q_{i, j} u_{i} \cdot u_{j}^{\dagger}$ and $G_{\mathrm{H}}=\sum_{i, j \geq 1} G_{i j} u_{i} \otimes u_{j}$ be as in Lemma 4.1, and let us denote the operator $Q_{\perp}:=\sum_{i, j>d} Q_{i, j} u_{i} \cdot u_{j}^{\dagger}$ on $\mathcal{H}_{\perp}:=$ $\left\langle u_{0}, u_{1}, \ldots, u_{d}\right\rangle^{\perp}$ as well as $G_{\perp}:=\sum_{i, j>d} G_{i j} u_{i} \otimes u_{j}$. Then we define the operator $\mathbb{H}_{\perp}$ as

\mathbb{H}_{\perp}:=a_{>d}^{\dagger} \cdot Q_{\perp} \cdot a_{>d}+2 \mathfrak{R e}\left[G_{\perp}^{\dagger} \cdot a_{>d} \underline{\otimes} a_{>d}\right] .

Lemma B.2. The operator $\mathbb{H}_{\perp}$ is semi-bounded from below, i.e. $\inf \sigma\left(\mathbb{H}_{\perp}\right)>-\infty$. Furthermore, there exists a constant $R>0$ such that

Let us define the operator $G_{\text {op }}$ on $\mathcal{H}_{\perp}$ by the condition $z^{\dagger} \cdot G_{\text {op }} \cdot z=2 G_{\perp}^{\dagger} \cdot \bar{z} \otimes z$, with $\bar{z}$ being the usual complex conjugation in $L^{2}\left(\mathbb{R}^{d}\right)$. Then, $z^{\dagger} \cdot Q_{\perp} \cdot z+2 \mathfrak{R e}\left[\bar{z}^{\dagger} \cdot G_{\text {op }} \cdot z\right]=$ Hess $\left.\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}[z] \geq \eta\|z\|^{2}$ for all $z \in \mathcal{H}_{\perp}$ with $\eta>0$ by Assumption 1.3. As pointed out in Section 2.1 in [21], this implies $Q_{\perp} \geq r>0$ as well as

$$
\left(\begin{array}{cc}
Q_{\perp} & G_{\mathrm{op}}^{\dagger} \\
G_{\mathrm{op}} & Q_{\perp}
\end{array}\right) \geq 0
$$

where we have used that $Q_{\perp}$ is a real operator. Since $Q_{\perp}>0$, this is further equivalent
 Lemma 4.1, and since $z^{\dagger} \cdot Q_{\perp}^{-\frac{1}{2}} \cdot z \leq c z^{\dagger} \cdot(T+1)^{-\frac{1}{2}} \cdot z$ for a suitable constant $c$ and $z \in \mathcal{H}_{\perp}$, which is an easy consequence of the operator inequality in Lemma 4.1 and the fact that $Q_{\perp} \geq r>0$, we obtain

\operatorname{Tr}\left[G_{\mathrm{op}} Q_{\perp}^{-1} G_{\mathrm{op}}^{\dagger}\right]=\left\|1_{\mathcal{H}_{\perp}} \otimes Q_{\perp}^{-\frac{1}{2}} \cdot G_{\perp}\right\|_{\mathcal{H} \otimes \mathcal{H}}^{2} \leq c^{2}\left\|G_{\mathrm{H}}\right\|_{*}^{2}<\infty \tag{B.2}
\end{equation*}

i.e. $G_{\text {op }} Q_{\perp}^{-\frac{1}{2}}$ is a Hilbert-Schmidt operator. By the general results in [27], this implies that $\mathbb{H}_{\perp}$ is semi-bounded as well as the existence of a constant $R>0$ such that Eq. (B.1) holds.

Lemma B.3. Let us define $P_{j}:=\frac{1}{2 i}\left(a_{j}-a_{j}^{\dagger}\right)=\sqrt{N} p_{j}$ for $j \in\{1, \ldots, d\}$, the constant $c_{0}:=\sum_{j=1}^{d} G_{j, j}$, the quadratic function $\nu(y):=-4 \sum_{j, k=1}^{d} G_{j, k} y_{j} y_{k}$ for $y \in \mathbb{R}^{d}$ and the linear $\mathcal{H}_{\perp}$ valued function

Then we can rewrite the Bogoliubov operator $\mathbb{H}$ from Definition (4.3) as

\end{equation*}

Proof. Since $\operatorname{Hess}_{u_{0}} \mathcal{E}_{\mathrm{H}}[z]=z^{\dagger} \cdot Q_{\mathrm{H}} \cdot z+2 \mathfrak{R e}\left[G_{\mathrm{H}}^{\dagger} \cdot z \otimes z\right]$ is degenerate in the directions $u_{1}, \ldots, u_{d}$, we obtain $Q_{j, k}=-2 G_{j, k}$ in case $j$ or $k$ is in $\{1, \ldots, d\}$. Writing $\mathbb{H}$ in coordinates therefore yields

\mathbb{H}= & \sum_{j, k=1}^{d} G_{j, k}\left(-2 a_{j}^{\dagger} a_{k}+a_{j} a_{k}+a_{j}^{\dagger} a_{k}^{\dagger}\right)+2 \sum_{j=1}^{d} \sum_{k>d} G_{j, k}\left(a_{j}-a_{j}^{\dagger}\right) a_{k}-2 \sum_{j=1}^{d} \sum_{k>d} G_{j, k}\left(a_{j}-a_{j}^{\dagger}\right) a_{k}^{\dagger} \\
& +\sum_{j, k>d}\left(Q_{j, k} a_{j}^{\dagger} a_{k}+G_{j, k} a_{j} a_{k}+G_{j, k} a_{j}^{\dagger} a_{k}^{\dagger}\right) \\
= & \left\{c_{0}+\nu\left(P_{1}, \ldots, P_{d}\right)\right\}+u\left(P_{1}, \ldots, P_{d}\right)^{\dagger} \cdot a_{>d}+a_{>d}^{\dagger} \cdot u\left(P_{1}, \ldots, P_{d}\right)+\mathbb{H}_{\perp},
\end{aligned}
$$

where we have used $-2 a_{j}^{\dagger} a_{k}+a_{j} a_{k}+a_{j}^{\dagger} a_{k}^{\dagger}=-4 P_{j} P_{k}+\delta_{j, k}$ in the second identity.
Remark B.4. In the subsequent LemmaB.5, we want to get rid of the term $u\left(P_{1}, \ldots, P_{d}\right)^{\dagger}$. $a_{>d}+a_{>d}^{\dagger} \cdot u\left(P_{1}, \ldots, P_{d}\right)$ in Eq. (B.3) by completing the square, i.e. by applying a shift $a_{>d} \mapsto a_{>d}+w\left(P_{1}, \ldots, P_{d}\right)$ where $w\left(y_{1}, \ldots, y_{d}\right) \in \mathcal{H}_{\perp}$ is a suitable vector. In the following we are going to construct such a $w(y)$. Let us first define the $\mathbb{R}$-linear map $L: \mathcal{H}_{\perp} \longrightarrow \mathcal{H}_{\perp}$

for all $z \in \mathcal{H}_{\perp}$. Furthermore, let us define the real inner product $\langle z, w\rangle_{\mathbb{R}}:=\mathfrak{R e}\left[z^{\dagger} \cdot w\right]$ on $\mathcal{H}_{\perp}$. Clearly, $L$ is symmetric with respect to this inner product. By Assumption 1.3 we have for all $w \in \mathcal{H}_{\perp}$

We note that $w(y) \in \operatorname{dom}\left[Q_{\perp}\right]$ due to the improved coercivity

\end{equation*}

where $\tilde{c}$ is a suitable constant, which follows from the fact that

2\left|(w \otimes w)^{\dagger} \cdot G_{\perp}\right| \leq w^{\dagger} \cdot\left(\epsilon Q_{\perp}+\epsilon^{-1} c^{2}\left\|G_{\mathrm{H}}\right\|_{*}^{2}\right) \cdot w \leq \epsilon w^{\dagger} \cdot Q_{\perp} \cdot w+\frac{c^{2}\left\|G_{\mathrm{H}}\right\|_{*}^{2}}{\epsilon \eta}\langle w, L(w)\rangle_{\mathbb{R}}

for all $\epsilon>0$, where $c$ is the constant in Eq. (B.2).

Lemma B.5. Let $w: \mathbb{R}^{d} \rightarrow \mathcal{H}_{\perp}$ be the function defined by Eq. (B.5) and let us define the unitary transformation $\mathcal{R}: \mathcal{F}_{0} \longrightarrow \mathcal{F}_{0}$

Then there exists a non-negative quadratic function $\eta: \mathbb{R}^{d} \longrightarrow \mathbb{R}$, s.t.

where $c_{0}$ and $\mathbb{H}_{\perp}$ are as in Lemma B.3 and Definition B.1.
Proof. Let us define $\eta\left(y_{1}, \ldots, y_{d}\right):=\nu\left(y_{1}, \ldots, y_{d}\right)+\left\langle w\left(y_{1}, \ldots, y_{d}\right), u\left(y_{1}, \ldots, y_{d}\right)\right\rangle_{\mathbb{R}}$. With $\eta$ and the vector valued function $w$ at hand, we can rewrite Eq. (B.3) as

& +2 \mathfrak{R e}\left[G_{\perp}^{\dagger} \cdot\left(a_{>d}-w\left(P_{1}, \ldots, P_{d}\right)\right) \underline{\otimes}\left(a_{>d}-w\left(P_{1}, \ldots, P_{d}\right)\right)\right] . \tag{B.8}
\end{align*}
$$

Eq. (B.7) follows now from the representation of $\mathbb{H}$ in Eq. (B.8) and the fact that

In order to see that $\eta$ is indeed non-negative, note that we can use $\eta$ and $w$ to complete the square in $\left.\operatorname{Hess}\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}[z]$ as well, i.e. for $z=\sum_{j=1}^{d}\left(t_{j}+i s_{j}\right) u_{j}+z_{>d}$ with $t, s \in \mathbb{R}^{d}$ and $z_{>d} \in \mathcal{H}_{\perp}$ we can write $\left.\operatorname{Hess}\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}[z]$ as

Therefore, $\left.\operatorname{Hess}\right|_{u_{0}} \mathcal{E}_{\mathrm{H}}[z] \geq 0$ for all $z$ implies $\eta(s) \geq 0$ for all $s \in \mathbb{R}^{d}$.
Proof of Theorem 4.4. Since the function $\eta$ in Lemma B. 5 is non-negative, we immediately obtain the lower bound

\end{equation*}

where $r_{*}$ is a suitable constant and $z=\sum_{j=1}^{d}\left(t_{j}+i s_{j}\right) u_{j}+z_{>d}$ with $z_{>d} \in \mathcal{H}_{\perp}$, which can be verified analogously to Eq. (B.6) in Remark B.4. With the definition $\eta_{r}:=r_{*}-r$ for $r<r_{*}$ we obtain, in analogy to Assumption 1.3 ,

for all $z$ of the form $z=i \sum_{j=1}^{d} s_{j} u_{j}+z_{>d}$ with $s_{j} \in \mathbb{R}$ and $z_{>d} \in \mathcal{H}_{\perp}$. Therefore we can repeat the proof of the lower bound for the operator $\mathbb{H}-r \mathbb{A}$, which yields

In order to verify that there exists an approximate sequence of ground states $\Psi_{M}$ with $\Psi_{M} \in \mathcal{F}_{\leq M}$ and $\Psi_{M} \in \operatorname{dom}\left[a_{\geq 1}^{\dagger} \cdot(T+1) \cdot a_{\geq 1}\right]$, it is enough to prove that such states are dense in dom $\left[a_{\geq 1}^{\dagger} \cdot(T+1) \cdot a_{\geq 1}\right]$, the domain of the quadratic form which defines the Bogoliubov operator $\mathbb{H}$ by Friedrichs extension, with respect to the norm $\|\Psi\|_{\mathbb{H}}^{2}:=$ $\langle\mathbb{H}+C\rangle_{\Psi}$ where $C>-\inf \sigma(\mathbb{H})$. The lower bound follows from Eq. (B.10), while the upper bound follows from Eq. (B.3) and Inequality (B.1). Furthermore, we have

for all $\Psi \in \mathcal{F}_{0}$, where $\|\Psi\|_{\diamond}^{2}:=\alpha_{2}\left\langle a_{\geq 1}^{\dagger} \cdot(T+1) \cdot a_{\geq 1}\right\rangle_{\Psi}+\left(\beta_{2}+C+\frac{d}{4}\right)\|\Psi\|^{2}$. Clearly, $\bigcup_{M} \mathcal{F}_{\leq M} \cap \operatorname{dom}\left[a_{\geq 1}^{\dagger} \cdot(T+1) \cdot a_{\geq 1}\right]$ is dense in the domain dom $\left[a_{\geq 1}^{\dagger} \cdot(T+1) \cdot a_{\geq 1}\right]$ with respect to the norm $\|.\|_{\odot}$ and therefore it is also dense with respect to $\|.\|_{\mathbb{H}}$.

## C. Auxiliary Lemmata

In the following section we will derive various operator estimates involving powers of the operators $p, p^{\prime}, b_{>d}$ and functions of $q$, with an emphasis on asymptotic results of the form $A_{N}=o_{*}\left(B_{N}\right)$, where the $o_{*}(\cdot)$ notation is introduced in Definition 4.10, It is a crucial observation that all of our basic variables $q_{i}, p_{j}$ and $b_{k}$ are of order $o_{*}(1)$, and therefore the product of a basic variable with an operator $A_{N}$ should be of order $o_{*}\left(A_{N}\right)$, which we will verify for specific examples $A_{N}$. Let us first discuss an important tool, which we will repeatedly use, given by the following Cauchy-Schwarz inequality for operators.

Lemma C.1. For any $\lambda \in \mathbb{C}$ with $|\lambda|=1, t>0$, linear operators $A: \mathcal{H}_{1} \longrightarrow \mathcal{H}_{2}$ and $B: \mathcal{H}_{1} \longrightarrow \mathcal{H}_{2}$, and selfadjoint operator $Q: \mathcal{H}_{2} \longrightarrow \mathcal{H}_{2}$, we have the operator inequality

\mathfrak{R e}\left[\lambda A^{\dagger} \cdot Q \cdot B\right] \leq t A^{\dagger} \cdot|Q| \cdot A+t^{-1} B^{\dagger} \cdot|Q| \cdot B \tag{C.1}

Furthermore, let $A_{N}, B_{N}$ be sequences of linear operators $\mathcal{H}_{1} \longrightarrow \mathcal{H}_{2}, Q$ a selfadjoint operator on $\mathcal{H}_{2}$ and $C_{N}: \mathcal{H}_{1} \longrightarrow \mathcal{H}_{1}$ a sequence of non-negative operators, which satisfy $A_{N}^{\dagger} \cdot|Q| \cdot A_{N}=O_{*}\left(C_{N}\right)$ and $B_{N}^{\dagger} \cdot|Q| \cdot B_{N}=o_{*}\left(C_{N}\right)$. Then,

\begin{aligned}
A_{N}^{\dagger} \cdot Q \cdot B_{N} & =o_{*}\left(C_{N}\right), \\
B_{N}^{\dagger} \cdot Q \cdot A_{N} & =o_{*}\left(C_{N}\right) .
\end{aligned}
$$

Proof. Let $Q=U|Q|$ be the polar decomposition of $Q$. Inequality (C.1) immediately follows from the inequality

0 \leq\left(\sqrt{t} A-\sqrt{\frac{1}{t}} \lambda U B\right)^{\dagger} \cdot|Q| \cdot\left(\sqrt{t} A-\sqrt{\frac{1}{t}} \lambda U B\right)

By our assumption $A_{N}^{\dagger} \cdot|Q| \cdot A_{N}=O_{*}\left(C_{N}\right)$ we know that there exist constants $c, \delta_{0}>0$, such that $\pi_{M, N} A_{N}^{\dagger} \cdot|Q| \cdot A_{N} \pi_{M, N} \leq c\left\langle C_{N}\right\rangle_{\Psi}$ for all $\frac{M}{N} \leq \delta_{0}$. Furthermore, by our assumption $B_{N}^{\dagger} \cdot|Q| \cdot B_{N}=o_{*}\left(C_{N}\right)$, there exists a function $\epsilon: \mathbb{R}^{+} \longrightarrow \mathbb{R}^{+}$with $\lim _{\delta \rightarrow 0} \epsilon(\delta)$, such that $\pi_{M, N} B_{N}^{\dagger} \cdot|Q| \cdot B_{N} \pi_{M, N} \leq \epsilon\left(\frac{M}{N}\right) C_{N}$. Applying Inequality (C.1) with $t:=\sqrt{\epsilon\left(\frac{M}{N}\right)}$ yields for all $\lambda \in \mathbb{C}$ with $|\lambda|=1$ and $\frac{M}{N} \leq \delta_{0}$

$$
\pi_{M, N} \mathfrak{R e}\left[\lambda A_{N}^{\dagger} \cdot Q \cdot B_{N}\right] \pi_{M, N} \leq \sqrt{\epsilon\left(\frac{M}{N}\right)} C_{N}
$$

Consider a function $g: \mathbb{R}^{d} \longrightarrow \mathbb{R}$. The following Lemma states that the operator $g(q)$ depends, up to an exponentially small error, only on the local data of $g$ in an arbitrary small neighborhood $[-\epsilon, \epsilon]^{d}$ of the origin, i.e. $g(q)=\widetilde{g}(q)+O_{*}\left(e^{-\delta N}\right)$ in case $\left.g\right|_{[-\epsilon, \epsilon]^{d}}=\left.\widetilde{g}\right|_{[-\epsilon, \epsilon]^{d}}$. This property plays a key role in the proof of the main technical Theorem 4.12, since the involved functions are (somewhat arbitrary) extensions of locally constructed functions with specific properties, which the extensions no longer have, see for example the definition of $f: \mathbb{R}^{d} \longrightarrow \mathcal{H}_{0}$ in Definition 4.7

Lemma C.2. Let $q_{1}, \ldots, q_{d}$ be the operators defined in Eq. (4.4) and let $g: \mathbb{R}^{d} \rightarrow \mathbb{R}$ be a function such that $\left.g\right|_{[-\epsilon, \epsilon]^{d}}=0$ for some $\epsilon>0$. Furthermore, assume that $g$ satisfies the growth condition $|g(t)| \leq C|t|^{2 j}$, with $C>0$ and $j \in \mathbb{N}$. Then

g(q)=O_{*}\left(e^{-\delta N}\right)
$$

for some $\delta>0$.
Proof. Using the elementary estimate $|t|^{2 j}=\left(\sum_{r=1}^{d} t_{r}^{2}\right)^{j} \leq d^{j} \max _{1 \leq r \leq d} t_{r}^{2 j}$ yields

In the following we want to verify that there exist constants $C, \delta>0$ and $\delta_{0}>0$ such that $\left\langle q_{r}^{2 j} \mathbb{1}_{(\epsilon, \infty)}\left(\left|q_{r}\right|\right)\right\rangle_{\Psi} \leq C e^{-\delta N}$ for all states $\Psi \in \mathcal{W}_{N} \mathcal{F}_{\leq M},\|\Psi\|=1$, with $\frac{M}{N} \leq \delta_{0}$ and $r \in\{1, \ldots, d\}$. Since $\mathcal{W}_{N} q_{r} \mathcal{W}_{N}^{-1}=q_{r}$, it is equivalent to verify this for $\Psi \in \mathcal{F}_{\leq M}$ instead. Due to the reflection symmetry $q_{r} \mapsto-q_{r}$ of $q_{r}^{2 j}$, it is furthermore enough to verify that $\left\langle\mathbb{1}_{(\epsilon, \infty)}\left(q_{r}\right) q_{r}^{2 j}\right\rangle_{\Psi} \leq C e^{-\delta N}$ for all states $\Psi \in \mathcal{F}_{\leq M}$ with $\frac{M}{N} \leq \delta_{0}$. Note that the operators
$q_{r}:=\frac{1}{\sqrt{2 N}} \frac{a_{r}+a_{r}^{\dagger}}{\sqrt{2}}$ depend on $N$. In the following we will make use of the description of the Fock space $\mathcal{F}_{\leq M}$ in terms of Hermite polynomials $h_{n}$, i.e. for $r \in\{1, \ldots, d\}$ and $\Psi \in \mathcal{F}_{\leq M}$ there exist states $\Psi_{n} \in \mathcal{F}_{\leq M-n}$ with $a_{r} \Psi_{n}=0$, such that $\Psi=\sum_{n=0}^{M} h_{n}\left(\frac{a_{r}+a_{r}^{\dagger}}{\sqrt{2}}\right) \Psi_{n}$, see for example Eq. (1.26), respectively Exercise 1(ii), in [25]. Furthermore we define the density matrix $\gamma_{r}(x, y):=\sum_{n_{1}, n_{2}=0}^{M}\left\langle\Psi_{n_{1}}, \Psi_{n_{2}}\right\rangle h_{n_{2}}(x) h_{n_{1}}(y) \frac{1}{\sqrt{\pi}} e^{-\frac{x^{2}+y^{2}}{2}}$ on $L^{2}(\mathbb{R})$. With $\gamma_{r}$ at hand we have

In order to estimate this quantity, let us define the harmonic oscillator Hamiltonian $H:=-\frac{\mathrm{d}^{2}}{\mathrm{~d} x^{2}}+x^{2}$ on $L^{2}(\mathbb{R})$. Since $\gamma_{r}$ involves only eigenfunctions $h_{n}(x) e^{-\frac{x^{2}}{2}}$ of $H$ with $n \leq M$, we have the operator inequality $\gamma_{r} \leq e^{2 M+1-H}$. Using the Mehler kernel for $e^{-\bar{H}}$ therefore yields for $c:=\frac{1}{\sqrt{2 \pi \sinh (2)}}$ and $\lambda:=\operatorname{coth}(2)-\operatorname{cosech}(2)>0$, and all $M \leq \epsilon^{2} \lambda N / 2$
$\int_{\sqrt{2 N} \epsilon}^{\infty}\left(\frac{x}{\sqrt{2 N}}\right)^{2 j} \gamma_{r}(x, x) \mathrm{d} x \leq c e^{\epsilon^{2} \lambda N+1} \int_{\sqrt{2 N} \epsilon}^{\infty}\left(\frac{x}{\sqrt{2 N}}\right)^{2 j} e^{-\lambda x^{2}} \mathrm{~d} x=O_{N \rightarrow \infty}\left(e^{-\epsilon^{2} \lambda N}\right)$.

The following Lemma is an auxiliary result, which will be useful for the verification of various asymptotic results involving the operator $b_{>d}$.

Lemma C.3. Recall the operators $\mathcal{W}_{N}, \mathbb{L}^{\prime}, p_{j}^{\prime}$ and $f(q)$ from Definition 4.8 and the definition of $\hat{\pi}_{M, N}$ above Eq. (5.21). Furthermore, we have for all $M \leq N$ the estimate

Since $\mathcal{N}_{+}$commutes with $\mathbb{L}$ and $q_{j}, p_{j}$ for $j \in\{1, \ldots, d\}$, we obtain that $\hat{\pi}_{M, N}=\mathcal{W}_{N} \mathbb{1}_{[0, M]}\left(\mathcal{N}_{+}\right) \mathcal{W}_{N}^{-1}$ commutes with $q_{j}=\mathcal{W}_{N} q_{j} \mathcal{W}_{N}^{-1}$ and $p_{j}^{\prime}=\mathcal{W}_{N} p_{j} \mathcal{W}_{N}^{-1}$. Similarly $\hat{\pi}_{M, N} \mathbb{L}^{\prime} \Psi=\mathbb{L}^{\prime} \hat{\pi}_{M, N} \Psi$ for all $\Psi \in \mathcal{W}_{N} \mathcal{F}_{\leq N}$. Making use of the fact that $b_{j}=\mathcal{W}_{N}\left(b_{j}-f_{j}(q)\right) \mathcal{W}_{N}^{-1}$ yields

& =\mathcal{W}_{N} \mathbb{1}_{[0, M]}\left(\mathcal{N}_{+}\right)\left(b_{j}-f_{j}(q)\right) \mathbb{1}_{[0, M]}\left(\mathcal{N}_{+}\right) \mathcal{W}_{N}^{-1}=\hat{\pi}_{M, N} b_{j} \hat{\pi}_{M, N}
\end{aligned}

Inequality (C.2) follows from $\left(b_{>d}+f(q)\right)^{\dagger} \cdot\left(b_{>d}+f(q)\right)=\frac{1}{N} \mathcal{W}_{N} \mathcal{N}_{+} \mathcal{W}_{N}^{-1}$ and

The proof of the main technical Theorem 4.12 consists of two steps: First one has to identify the residuum $R_{J}$, which is carried out in the Lemmata 5.6 and 5.12, and in the second step one has to derive asymptotic results for these residua $R_{J}$, which is carried out in the Theorems 5.7 and 5.16. The following three Lemmata provide asymptotic results for the types of operators most frequently encountered during our analysis of $R_{J}$.

By our assumptions we know that $\left|\tau_{r} \phi\right| \leq \epsilon_{r}$ with $\epsilon_{r} \underset{r \rightarrow 0}{\longrightarrow} 0$ and $\left(1-\tau_{r}\right) \phi$ is zero in a neighborhood of zero, hence $\left(1-\tau_{r}(q)\right) \phi(q)=O_{*}\left(e^{-\delta N}\right)$ by Lemma C.2., We conclude that $|\phi(q)| \leq \epsilon_{r}+O_{*}\left(e^{-\delta N}\right)$ for all $r>0$, and consequently $\phi(q)=o_{*}(1)$. The corresponding statement for $\Phi(q)$ follows from the fact that $\Phi(q) \leq C+\phi(q)$ with $\phi(t):=|t|^{k}$ and $\phi(q)=o_{*}(1)$.

Let us write similar to before $\phi(q) b_{>d}^{\dagger} \cdot b_{>d}=\tau_{r}(q) \phi(q) b_{>d}^{\dagger} \cdot b_{>d}+\left(1-\tau_{r}(q)\right) \phi(q) b_{>d}^{\dagger} \cdot b_{>d}$. In order to verify Eq. (C.5). First of all $\tau_{r}(q) \phi(q) b_{>d}^{\dagger} \cdot b_{>d} \leq \epsilon_{r} b_{>d}^{\dagger} \cdot b_{>d}$, where we use that $q$ commutes with $b_{>d}$. For the treatment of the second term, recall Inequality (C.3) and $\pi_{M, N}\left(1-\tau_{r}(q)\right)^{2}\left|\phi_{r}(q)\right|^{2} \pi_{M, N} \leq C^{2} e^{-2 \delta N}$ for $\frac{M}{N} \leq \delta$ with $C, \delta>0$, which follows from Lemma C. 2 . We conclude that $\pi_{M, N} \phi(q) \pi_{M, N} \leq 4 C e^{-\delta N}+\epsilon_{r} b_{>d}^{\dagger} \cdot b_{>d}$ for $\frac{M}{N} \leq \delta$, and therefore $\phi(q)=o_{*}\left(b_{>d}^{\dagger} \cdot b_{>d}+\frac{1}{N}\right)$. The corresponding statement for $\Phi(q) b_{>d}^{\dagger} \cdot b_{>d}$ follows as above.

Given $w: \mathbb{R}^{d} \longrightarrow \mathcal{H}$ with $\|w(t)\| \leq c|t|^{k}$ and $W: \mathbb{R}^{d} \longrightarrow \mathcal{H}$ with $\|W(t)\| \leq c\left(1+|t|^{k}\right)$ for some $c>0$ and $k \geq 1$, we define $X:=W(q)^{\dagger} \cdot b_{>d}$ and $Y:=$ $w(q)^{\dagger} \cdot b_{>d}$. Then, $X^{\dagger} X$ and $X X^{\dagger}$ are of order $O_{*}\left(b_{>d}^{\dagger} \cdot b_{>d}+\frac{1}{N}\right)$, and $Y^{\dagger} Y$ and $Y Y^{\dagger}$ are of order $o_{*}\left(b_{>d}^{\dagger} \cdot b_{>d}+\frac{1}{N}\right)$. Furthermore, for $\Phi: \mathbb{R}^{d} \longrightarrow \mathbb{R}$ with $|\Phi(t)| \leq c\left(1+|t|^{j}\right)$, we obtain

In case the partial derivatives $\partial_{i} \phi(t), \partial_{j} \Phi(t)$ and $\partial_{i} \partial_{j} \Phi(t)$ are bounded by $c\left(1+|t|^{j}\right)$, we also have

Furthermore, Lemma C.4 tells us that $w(q)^{\dagger} \cdot w(q)=O_{*}(1)$, and therefore $\frac{1}{N} w(q)^{\dagger} \cdot \frac{1}{N} w(q)=o_{*}\left(\mathbb{Q}_{N}\right)$. Hence, $\phi(q)\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime} \phi(q)$ is of order $o_{*}\left(\mathbb{Q}_{N}\right)$ as well. The last estimate in the Lemma can be verified analogously.

## D. Analysis of the Operator Square Root

In the following section we derive asymptotic results for operators involving the square root $\sqrt{1-\mathbb{L}^{\prime}}$, where $\mathbb{L}^{\prime}$ is defined in Definition 4.8, allowing us to prove a Taylor approximation for the operators $\left(1-\mathbb{L}^{\prime}\right)^{\frac{m}{2}}$, see Definition 5.5. The easiest case $m=2$ will be discussed in the following Lemma D.1, the case $m=1$ is the content of Lemma D. 2 and the case $m=3$ is covered by Corollary D.5.

Lemma D.1. Recall the operator $\mathbb{Q}_{N}$ from Eq. (C.6) and the function $f$ from Definition 4.7. and let us define $g(t):=\sum_{j=1}^{d} t_{j}^{2}+f(t)^{\dagger} \cdot f(t)$. Then,

$$
\begin{equation*}
\left[\mathbb{L}^{\prime}-g(q)\right]^{2}=o_{*}\left(\mathbb{Q}_{N}\right) . \tag{D.1}
\end{equation*}
$$

Proof. Using the transformation laws in Lemma 4.9 we obtain

$$
\mathbb{L}^{\prime}-g(q)=f(q)^{\dagger} \cdot b_{>d}+b_{>d}^{\dagger} \cdot f(q)+\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}+b_{>d}^{\dagger} \cdot b_{>d}-\frac{d}{2 N} .
$$

By Lemma C.5, we know that $\left[f(q)^{\dagger} \cdot b_{>d}+b_{>d}^{\dagger} \cdot f(q)\right]^{2}=o_{*}\left(\mathbb{Q}_{N}\right)$ and $\left[b_{>d}^{\dagger} \cdot b_{>d}\right]^{2}=$ $o_{*}\left(\mathbb{Q}_{N}\right)$, and by Lemma C.6 we know that $\left[\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}\right]^{2}=o_{*}\left(\mathbb{Q}_{N}\right)$.

Lemma D.2. Let Assumption 1.3 hold and recall the function $\eta_{1}$ from Eq. (5.7). Then,

$$
\begin{equation*}
\left[\sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)\right]^{2}=o_{*}\left(\mathbb{Q}_{N}\right) . \tag{D.2}
\end{equation*}
$$

Furthermore for any function $V: \mathbb{R}^{d} \longrightarrow \mathbb{R}$ with $|V(t)| \leq c\left(|t|+|t|^{k}\right)$ and bounded derivatives $\left|\partial_{t_{i}} V(t)\right|+\left|\partial_{t_{i}} \partial_{t_{j}} V(t)\right| \leq c\left(1+|t|^{k}\right)$ for some $k \geq 1$, we have

$$
\begin{equation*}
V(q)\left[\sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)-\left.D_{\mathcal{V}}\right|_{q} \eta_{1}\left(b_{\geq 1}\right)\right]=o_{*}\left(\mathbb{Q}_{N}\right) . \tag{D.3}
\end{equation*}
$$

Proof. Let us define $h(x):=\chi(x) \sqrt{1-x}$, where $\chi:[0, \infty) \longrightarrow[0,1]$ is the function from the definition of $\eta_{1}$ in Eq. (5.7), as well as the operator $Q:=q^{\dagger} \cdot q+f(q)^{\dagger} \cdot f(q)$. By the support properties of $\chi$ we have for all $\frac{M}{N}<\frac{1}{2}$ and $\Psi \in \mathcal{W}_{N} \mathcal{F}_{\leq M}$

\sqrt{1-\mathbb{L}^{\prime}} \Psi=h\left(\mathbb{L}^{\prime}\right) \Psi
$$

and therefore it is enough to verify the statements of this Lemma for $h\left(\mathbb{L}^{\prime}\right)$ instead of $\sqrt{1-\mathbb{L}^{\prime}}$. With $h$ at hand, we have $\eta_{1}(q)=h\left(\|F(q)\|^{2}\right)=h(Q)$ and

\left.D \mathcal{V}\right|_{q} \eta_{1}(v)=w(q)^{\dagger} \cdot v+v^{\dagger} \cdot w(q)
$$

with $w(t):=h^{\prime}\left(\sum_{j=1}^{d} t_{j}^{2}+f(t)^{\dagger} \cdot f(t)\right) f(t)$, for all $v \in \mathcal{H}_{0}$. Hence $w(q)=h^{\prime}(Q) f(q)$. In the following, let $\hat{h}$ be the Fourier transform of the smooth function $h$, normalized such that $h(x)=\int \hat{h}(z) e^{i z x} \mathrm{~d} z$. Then,

$$
h\left(\mathbb{L}^{\prime}\right)-h(Q)=\int \hat{h}(z)\left(e^{i z \mathbb{L}^{\prime}}-e^{i z Q}\right) \mathrm{d} z
$$

In order to investigate the integrand, we use the following integral representation

$$
\begin{aligned}
e^{i z \mathbb{L}^{\prime}}-e^{i z Q} & =i \int_{0}^{z} e^{i y \mathbb{L}^{\prime}}\left(\mathbb{L}^{\prime}-Q\right) e^{i(z-y) Q} \mathrm{~d} y \\
& =i \int_{0}^{z} e^{i y \mathbb{L}^{\prime}} e^{i(z-y) Q} \mathrm{~d} y\left(\mathbb{L}^{\prime}-Q\right)+i \int_{0}^{z} e^{i y \mathbb{L}^{\prime}}\left[\mathbb{L}^{\prime}, e^{i(z-y) Q}\right] \mathrm{d} y
\end{aligned}
$$

Let us define the operators $B_{z}:=i \int_{0}^{z} e^{i y \mathbb{L}^{\prime}} e^{i(z-y) Q} \mathrm{~d} y$ and $R_{z}:=i \int_{0}^{z} e^{i y \mathbb{L}^{\prime}}\left[\mathbb{L}^{\prime}, e^{i(z-y) Q}\right] \mathrm{d} y$. Clearly, $\left\|B_{z}\right\| \leq|z|$. Regarding $R_{z}$, note that every term in the definition of $\mathbb{L}^{\prime}$ commutes with $Q$, except $\left(p^{\prime}\right) \cdot p^{\prime}$, which satisfies the relation $\left[p_{j}^{\prime}, \phi(q)\right]=\left[p_{j}, \phi(q)\right]=\frac{1}{i 2 N}\left(\partial_{j} \phi\right)(q)$. We define the family of functions

$$
\begin{equation*}
\phi_{x}(t):=e^{i x\left(\sum_{j=1}^{d} t_{j}^{2}+f(t)^{\dagger} \cdot f(t)\right)} \tag{D.4}
\end{equation*}
$$

and compute

$$
\begin{aligned}
{\left[\mathbb{L}^{\prime}, e^{i x Q}\right] } & =\left[\left(p^{\prime}\right) \cdot p^{\prime}, \phi_{x}(q)\right]=\sum_{j=1}^{d}\left[\left(p_{j}^{\prime}\right)^{2}, \phi_{x}(q)\right] \\
& =\frac{1}{i N} \sum_{j=1}^{d} \partial_{j} \phi_{x}(q) p_{j}^{\prime}-\frac{1}{4 N^{2}} \sum_{j=1}^{d} \partial_{j}^{2} \phi_{x}(q) .
\end{aligned}
$$

We have the estimates $\left|\partial_{j} \phi_{x}(t)\right| \leq c|x||t|$ and $\left|\partial_{j}^{2} \phi_{x}(t)\right| \leq c\left(1+|x|^{2}\right)\left(1+|t|^{2}\right)$ for some $c>0$, where we use the fact that $t \mapsto f(t)$ is a $C^{2}\left(\mathbb{R}^{d}, \mathcal{H}_{0}\right)$ function, see Definition 4.7. As before, let $\pi_{M, N}$ be the orthogonal projection onto $\mathcal{W}_{N}\left(\mathcal{F}_{\leq M}\right)$. By Lemma C. 4

$$
\begin{aligned}
\left\|\partial_{j} \phi_{x}(q) \pi_{M, N}\right\| & \leq c|x|\left\||q| \pi_{M, N}\right\| \leq \tilde{c}|x| \\
\left\|\partial_{j}^{2} \phi_{x}(q) \pi_{M, N}\right\| & \leq c\left(1+|x|^{2}\right)\left\|\left(1+|q|^{2}\right) \pi_{M, N}\right\| \leq \tilde{c}\left(1+|x|^{2}\right)
\end{aligned}
$$

for some constant $\tilde{c}$ and all $x \in \mathbb{R}$ and all $M \leq N$. Note that $p_{j}^{\prime} \mathcal{W}_{N} \mathcal{F}_{\leq M} \subset \mathcal{W}_{N} \mathcal{F}_{\leq M+1}$ and $\left\|p_{j}^{\prime} \pi_{M, N}\right\| \leq \sqrt{\frac{M+1}{N}}$, and consequently we have for all $M \leq N-1$

$$
\begin{aligned}
\left\|\left[\mathbb{L}^{\prime}, e^{i x Q}\right] \pi_{M, N}\right\| & \leq \frac{2}{N} \sum_{j=1}^{d}\left\|\partial_{j} \phi_{x}(q) \pi_{M+1, N}\right\|\left\|p_{j}^{\prime} \pi_{M, N}\right\|+\frac{1}{N^{2}} \sum_{j=1}^{d}\left\|\partial_{j}^{2} \phi_{x}(q) \pi_{M, N}\right\| \\
& \leq \frac{d \tilde{c}}{N}|x|+\frac{d \tilde{c}}{4 N^{2}}\left(1+|x|^{2}\right) \leq \frac{2 d \tilde{c}}{N}\left(1+|x|^{2}\right) .
\end{aligned}
$$

Therefore, $\left\|R_{z} \pi_{M, N}\right\| \leq \frac{C}{N}\left(1+|z|^{3}\right)$ for some constant $C$.
Let us define $B:=\int \hat{h}(z) B_{z} \mathrm{~d} z$ and $R:=\int \hat{h}(z) R_{z} \mathrm{~d} z$. From our estimates on $B_{z}, R_{z}$, we deduce $\|B\| \leq \int|\hat{h}(z)||z| \mathrm{d} z:=C_{1}<\infty$ and $\left\|R \pi_{M, N}\right\| \leq \frac{C}{N} \int|\hat{h}(z)|\left(1+|z|^{3}\right) \mathrm{d} z:=$ $\frac{C_{2}}{N}<\infty$. Hence, $R^{\dagger} R=o_{*}\left(\mathbb{Q}_{N}\right)$. Since $h\left(\mathbb{L}^{\prime}\right)-h(Q)=B\left(\mathbb{L}^{\prime}-Q\right)+R$, we obtain the estimate

$$
\begin{aligned}
& {\left[h\left(\mathbb{L}^{\prime}\right)-h(Q)\right]^{2}=\left[B\left(\mathbb{L}^{\prime}-Q\right)+R\right]^{\dagger}\left[B\left(\mathbb{L}^{\prime}-Q\right)+R\right]} \\
& \quad \leq 2\left(\mathbb{L}^{\prime}-Q\right) B^{\dagger} B\left(\mathbb{L}^{\prime}-Q\right)+2 R^{\dagger} R \\
& \quad \leq 2\left(C_{1}\right)^{2}\left(\mathbb{L}^{\prime}-Q\right)^{2}+2 R^{\dagger} R=o_{*}\left(\mathbb{Q}_{N}\right),
\end{aligned}
$$

where we have used that $\left(\mathbb{L}^{\prime}-Q\right)^{2}$ is of order $o_{*}\left(\mathbb{Q}_{N}\right)$, see Lemma D.1. This proves Eq. (D.2).

In order to verify Eq. (D.3) let us compute

$$
\begin{align*}
& \sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)-\left.D\right|_{q} \eta_{1}\left(b_{\geq 1}\right)=h\left(\mathbb{L}^{\prime}\right)-h(Q)-h^{\prime}(Q)\left(b_{>d}^{\dagger} \cdot f(q)+f(q)^{\dagger} \cdot b_{>d}\right) \\
&= \int \hat{h}(z)\left[i \int_{0}^{z} e^{i y \mathbb{L}^{\prime}}\left(\mathbb{L}^{\prime}-Q\right) e^{i(z-y) Q} \mathrm{~d} y-i z e^{i z Q}\left(f(q)^{\dagger} \cdot b_{>d}+b_{>d}^{\dagger} \cdot f(q)\right)\right] \mathrm{d} z \\
&= R+\int \hat{h}(z)\left[i \int_{0}^{z} e^{i y \mathbb{L}^{\prime}} e^{i(z-y) Q} \mathrm{~d} y\left(\mathbb{L}^{\prime}-Q\right)-i z e^{i z Q}\left(f(q)^{\dagger} \cdot b_{>d}+b_{>d}^{\dagger} \cdot f(q)\right)\right] \mathrm{d} z \\
&= R+i \int \hat{h}(z) \int_{0}^{z}\left(e^{i y \mathbb{L}^{\prime}}-e^{i y Q}\right) e^{i(z-y) Q} \mathrm{~d} y \mathrm{~d} z\left(\mathbb{L}^{\prime}-Q\right)  \tag{D.5}\\
&+i \int \hat{h}(z) z e^{i z Q} \mathrm{~d} z\left(\mathbb{L}^{\prime}-Q-f(q)^{\dagger} \cdot b_{>d}-b_{>d}^{\dagger} \cdot f(q)\right) .
\end{align*}
$$

Let $V$ be a function that satisfies the assumptions of the Lemma. To complete the proof, we need to verify that $V(q)\left[h\left(\mathbb{L}^{\prime}\right)-h(Q)-h^{\prime}(Q)\left(f(q)^{\dagger} \cdot b_{>d}+b_{>d}^{\dagger} \cdot f(q)\right)\right]$ is of order $o_{*}\left(\mathbb{Q}_{N}\right)$. By Lemma C.4 we know that $|V|^{2}(q)=o_{*}(1)$ and from the previous part it is clear that $\pi_{M, N} R^{\dagger} R \pi_{M, N}=O_{*}\left(\frac{1}{N^{2}}\right)$. Hence, $V(q) R=o_{*}\left(\frac{1}{N}\right)$ and especially $V(q) R=o_{*}\left(\mathbb{Q}_{N}\right)$. Regarding the second term in Eq. (D.5), recall that $e^{i y \mathbb{L}^{\prime}}-e^{i y Q}=$
$\left(\mathbb{L}^{\prime}-Q\right) B_{-y}^{\dagger}+R_{-y}^{\dagger}$. Therefore,

$$
\begin{aligned}
& \int \hat{h}(z) i \int_{0}^{z}\left(e^{i y \mathbb{L}^{\prime}}-e^{i y Q}\right) e^{i(z-y) Q} \mathrm{~d} y \mathrm{~d} z\left(\mathbb{L}^{\prime}-Q\right) \\
& \quad=\int \hat{h}(z) i \int_{0}^{z}\left[\left(\mathbb{L}^{\prime}-Q\right) B_{-y}^{\dagger}+R_{-y}^{\dagger}\right] e^{i(z-y) Q} \mathrm{~d} y \mathrm{~d} z\left(\mathbb{L}^{\prime}-Q\right) \\
& \quad=\left[\left(\mathbb{L}^{\prime}-Q\right) \widetilde{B}^{\dagger}+\widetilde{R}^{\dagger}\right]\left(\mathbb{L}^{\prime}-Q\right),
\end{aligned}
$$

with $\widetilde{B}:=-i \int \hat{h}(z) \int_{0}^{z} e^{i(y-z) Q^{-y}} B_{-y} \mathrm{~d} y \mathrm{~d} z$ and $\widetilde{R}:=-i \int \hat{h}(z) \int_{0}^{z} e^{i(y-z) Q} R_{-y} \mathrm{~d} y \mathrm{~d} z$. In the following we want to verify that $V(q)\left[\left(\mathbb{L}^{\prime}-Q\right) \widetilde{B}^{\dagger}+\widetilde{R}^{\dagger}\right]\left(\mathbb{L}^{\prime}-Q\right)=o_{*}\left(\mathbb{Q}_{N}\right)$. Since $\left(\mathbb{L}^{\prime}-Q\right)^{2}=o_{*}\left(\mathbb{Q}_{N}\right)$ by Lemma D.1, it is enough to verify that $V(q) \widetilde{R}^{\dagger} \widetilde{R} V(q)$ and $V(q)\left(\mathbb{L}^{\prime}-Q\right) \widetilde{B}^{\dagger} \widetilde{B}\left(\mathbb{L}^{\prime}-Q\right) V(q)$ are of order $o_{*}\left(\mathbb{Q}_{N}\right)$. Recall that we have the identity $R_{y}=i \int_{0}^{y} e^{i x \mathbb{L}^{\prime}}\left[\mathbb{L}^{\prime}-Q, e^{i(y-x) Q}\right] \mathrm{d} x=i \int_{0}^{y} e^{i x \mathbb{L}^{\prime}}\left[\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}, \phi_{x}(q)\right] \mathrm{d} x$ with the function $\phi_{x}$ from Eq. (D.4). We can further express $\left[\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}, \phi_{x}(q)\right] V(q)$ as

$$
\sum_{j=1}^{d}\left(\frac{1}{i N} \partial_{j} \phi_{x}(q) V(q) p_{j}^{\prime}-\frac{1}{2 N^{2}} \partial_{j} \phi_{x}(q) \partial_{j} V(q)-\frac{1}{4 N^{2}} \partial_{j}^{2} \phi_{x}(q) V(q)\right)
$$

Similar to before, this leads to the estimate $\left\|R_{z} V(q) \pi_{M, N}\right\| \leq \frac{\widetilde{C}}{N}\left(1+|z|^{3}\right)$ for some constant $\widetilde{C}$, and consequently $\left\|\widetilde{R} V(q) \pi_{M, N}\right\| \leq \frac{\widetilde{C}_{1}}{N}$ for some constant $\widetilde{C}_{1}$. Hence we have $V(q) \widetilde{R}^{\dagger} \widetilde{R} V(q)=o_{*}\left(\mathbb{Q}_{N}\right)$. Regarding the term $V(q)\left(\mathbb{L}^{\prime}-Q\right) \widetilde{B}^{\dagger} \widetilde{B}\left(\mathbb{L}^{\prime}-Q\right) V(q)$, note that $\|\widetilde{B}\|^{2}=: \tilde{C}_{2}<\infty$. Applying the Cauchy-Schwarz yields

\begin{aligned}
& V(q)\left(\mathbb{L}^{\prime}-Q\right) \widetilde{B}^{\dagger} \widetilde{B}\left(\mathbb{L}^{\prime}-Q\right) V(q) \leq \tilde{C}_{2} V(q)\left(\mathbb{L}^{\prime}-Q\right)^{2} V(q) \\
& \leq 5 \tilde{C}_{2} V(q)\left[f(q)^{\dagger} \cdot b_{>d} b_{>d}^{\dagger} \cdot f(q)+b_{>d}^{\dagger} \cdot f(q) f(q)^{\dagger} \cdot b_{>d}+\left(\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}\right)^{2}+\left(b_{>d}^{\dagger} \cdot b_{>d}\right)^{2}+\frac{d^{2}}{N^{2}}\right] V(q) .
\end{aligned}
$$

Let us define the function $w(t):=V(t) f(t)$. By Lemma C. 5 we obtain that

$$
\begin{aligned}
& V(q) f(q)^{\dagger} \cdot b_{>d} b_{>d}^{\dagger} \cdot f(q) V(q)=w(q)^{\dagger} \cdot b_{>d} b_{>d}^{\dagger} \cdot w(q)=o_{*}\left(\mathbb{Q}_{N}\right), \\
& V(q) b_{>d}^{\dagger} \cdot f(q) f(q)^{\dagger} \cdot b_{>d} V(q)=b_{>d}^{\dagger} \cdot w(q) w(q)^{\dagger} \cdot b_{>d}=o_{*}\left(\mathbb{Q}_{N}\right),
\end{aligned}
$$

and $V(q)\left(b_{>d}^{\dagger} \cdot b_{>d}\right)^{2} V(q)=o_{*}\left(\mathbb{Q}_{N}\right)$. Furthermore, $V(q)\left[\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}\right]^{2} V(q)=o_{*}\left(\mathbb{Q}_{N}\right)$ by Lemma C.6. We conclude that $V(q)\left(\mathbb{L}^{\prime}-Q\right) \widetilde{B}^{\dagger} \widetilde{B}\left(\mathbb{L}^{\prime}-Q\right) V(q)=o_{*}\left(\mathbb{Q}_{N}\right)$.

Let us now verify that the final term $\widetilde{V}(q)\left(\mathbb{L}^{\prime}-Q-b_{>d}^{\dagger} \cdot f(q)-f(q)^{\dagger} \cdot b_{>d}\right)$ in Eq. (D.5) is of order $o_{*}\left(\mathbb{Q}_{N}\right)$, where $\widetilde{V}(t):=V(t) \int \hat{h}(z) i z e^{i z\left(\sum_{j=1}^{d} t_{j}^{2}+f(t)^{\dagger} \cdot f(t)\right)} \mathrm{d} z$. By the definition of $\mathbb{L}^{\prime}$ and $Q$, we have the identity

$$
\widetilde{V}(q)\left(\mathbb{L}^{\prime}-Q-f(q)^{\dagger} \cdot b_{>d}-b_{>d}^{\dagger} \cdot f(q)\right)=\widetilde{V}(q) b_{>d}^{\dagger} \cdot b_{>d}+\widetilde{V}(q)\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}-\frac{d}{2 N} V(q)
$$

The first term is of order $o_{*}\left(\mathbb{Q}_{N}\right)$ by Lemma C.4, the second term is by Lemma C.6 and regarding the last term we know that $\frac{d}{2 N} V(q)=o_{*}\left(\mathbb{Q}_{N}\right)$ by Lemma C.4.

Before we can verify the Taylor approximation for the operator $(1-\mathbb{L})^{\frac{3}{2}}$ in Corollary D.5. we need the following two results, which are of independent relevance for the proof of Theorem 5.16.

Lemma D.3. We have $\left(\mathbb{L}^{\prime}\right)^{2}=o_{*}(1)$, and furthermore

\begin{gather*}
\sqrt{1-\mathbb{L}^{\prime}} \mathbb{Q}_{N} \sqrt{1-\mathbb{L}^{\prime}}=O_{*}\left(\mathbb{Q}_{N}\right)  \tag{D.6}\\
\mathbb{L}^{\prime} \mathbb{Q}_{N} \mathbb{L}^{\prime}=o_{*}\left(\mathbb{Q}_{N}\right) \tag{D.7}
\end{gather*}
$$

Proof. Note that $\left\|\mathbb{L}^{\prime} \pi_{M, N}\right\|=\frac{M}{N}$ for all $M \leq N$, and therefore we immediately obtain $\left(\mathbb{L}^{\prime}\right)^{2}=o_{*}(1)$. In order to verify Equations (D.6) and (D.7), it is enough to prove that $\sqrt{1-\mathbb{L}^{\prime}}\left(\xi^{\dagger} \cdot \xi\right) \sqrt{1-\mathbb{L}^{\prime}}=O_{*}\left(\mathbb{Q}_{N}\right)$ and $\mathbb{L}^{\prime}\left(\xi^{\dagger} \cdot \xi\right) \mathbb{L}^{\prime}=o_{*}\left(\mathbb{Q}_{N}\right)$ for $\xi \in\left\{p^{\prime}, b_{>d}\right\}$.

The case $\xi=p^{\prime}$ : In order to verify $\sqrt{1-\mathbb{L}^{\prime}}\left(\xi^{\dagger} \cdot \xi\right) \sqrt{1-\mathbb{L}^{\prime}}=O_{*}\left(\mathbb{Q}_{N}\right)$, observe that we have for all $\Psi \in \mathcal{W}_{N} \mathcal{F}_{\leq N-1}$ the commutation law

$$
p_{j}^{\prime} \sqrt{1-\mathbb{L}^{\prime}} \Psi=\frac{\sqrt{1-\mathbb{L}^{\prime}-\frac{1}{N}}+\sqrt{1-\mathbb{L}^{\prime}+\frac{1}{N}}}{2} p_{j}^{\prime} \Psi+\frac{\sqrt{1-\mathbb{L}^{\prime}-\frac{1}{N}}-\sqrt{1-\mathbb{L}^{\prime}+\frac{1}{N}}}{2} q_{j} \Psi
$$

For $M \leq N-2$, let us define the operators $B_{M, N}:=\frac{\sqrt{1-\mathbb{L}^{\prime}-\frac{1}{N}}+\sqrt{1-\mathbb{L}^{\prime}+\frac{1}{N}}}{2} \pi_{M+1, N}$ and $\widetilde{B}_{M, N}:=\frac{\sqrt{1-\mathbb{L}^{\prime}-\frac{1}{N}}-\sqrt{1-\mathbb{L}^{\prime}+\frac{1}{N}}}{2} \pi_{M+1, N}$. Note that $\left\|B_{M, N}\right\| \leq 1$ and $\left\|\widetilde{B}_{M, N}\right\|^{2} \leq \frac{C}{N^{2}}$ for all $\frac{M}{N} \leq \delta_{0}$, where $C$ and $0<\delta<1$ are suitable constants. Consequently

$$
\begin{aligned}
& \pi_{M, N} \sqrt{1-\mathbb{L}^{\prime}}\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime} \sqrt{1-\mathbb{L}^{\prime}} \pi_{M, N}=\left|\left(B_{M, N} \otimes 1_{\mathcal{H}} \cdot p^{\prime}+\widetilde{B}_{M, N} \otimes 1_{\mathcal{H}} \cdot q\right) \pi_{M, N}\right|^{2} \\
& \quad \leq 2\left|B_{M, N} \otimes 1_{\mathcal{H}} \cdot p^{\prime} \pi_{M, N}\right|^{2}+2\left|\widetilde{B}_{M, N} \otimes 1_{\mathcal{H}} \cdot q \pi_{M, N}\right|^{2} \\
& \quad \leq \pi_{M, N}\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime} \pi_{M, N}+\frac{C(d+1)}{N^{2}}
\end{aligned}
$$

which concludes the proof of $\sqrt{1-\mathbb{L}^{\prime}}\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime} \sqrt{1-\mathbb{L}^{\prime}}=O_{*}\left(\mathbb{Q}_{N}\right)$. The estimate $\mathbb{L}^{\prime}\left(p^{\prime}\right)^{\dagger}$. $p^{\prime} \mathbb{L}^{\prime}=o_{*}\left(\mathbb{Q}_{N}\right)$ follows from an analogue commutation law.

The case $\xi=b_{>d}$ : In order to verify $\sqrt{1-\mathbb{L}^{\prime}} b_{>d}^{\dagger} \cdot b_{>d} \sqrt{1-\mathbb{L}^{\prime}}=O_{*}\left(\mathbb{Q}_{N}\right)$, note that $\left[\sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)\right]^{2}=o_{*}\left(\mathbb{Q}_{N}\right)$ by D.2, i.e. there exists a function $\epsilon$ with $\epsilon(\delta) \underset{\delta \rightarrow 0}{\longrightarrow} 0$ and $\pi_{M, N}\left[\sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)\right]^{2} \pi_{M, N} \leq \epsilon\left(\frac{M}{N}\right) \pi_{M, N} \mathbb{Q}_{N} \pi_{M, N}$. By Lemma C.3, we know that $\hat{\pi}_{M, N} b_{>d}^{\dagger} \cdot b_{>d} \hat{\pi}_{M, N} \leq C$ for a constant $C$. Furthermore $\left[\sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)\right] \hat{\pi}_{M, N}=$ $\hat{\pi}_{M, N}\left[\sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)\right]$. Let us define $S:=\left[\sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)\right] b_{>d}^{\dagger} \cdot b_{>d}\left[\sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)\right]$, and estimate

$$
\begin{aligned}
\pi_{M, N} S \pi_{M, N} & =\pi_{M, N}\left[\sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)\right] \hat{\pi}_{M, N} b_{>d}^{\dagger} \cdot b_{>d} \hat{\pi}_{M, N}\left[\sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)\right] \pi_{M, N} \\
& \leq 4 \pi_{M, N}\left[\sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)\right]^{2} \pi_{M, N} \leq 4 \epsilon\left(\frac{M}{N}\right) \pi_{M, N} \mathbb{Q}_{N} \pi_{M, N}
\end{aligned}
$$

Hence, $S=o_{*}\left(\mathbb{Q}_{N}\right)$ and therefore

$$
\sqrt{1-\mathbb{L}^{\prime}} b_{>d}^{\dagger} \cdot b_{>d} \sqrt{1-\mathbb{L}^{\prime}} \leq 2\left(S+\eta_{1}(q) b_{>d}^{\dagger} \cdot b_{>d} \eta_{1}(q)\right)=O_{*}\left(\mathbb{Q}_{N}\right)
$$

The proof of $\mathbb{L}^{\prime} b_{>d}^{\dagger} \cdot b_{>d} \mathbb{L}^{\prime}=o_{*}\left(\mathbb{Q}_{N}\right)$ can be carried out in a similar fashion.
Corollary D.4. Let $X_{N}$ be a sequence with $X_{N}=O_{*}\left(\mathbb{Q}_{N}\right)$ and $Y_{N}$ a sequence with $Y_{N}=o_{*}\left(\mathbb{Q}_{N}\right)$. Then,

$$
\begin{gather*}
\sqrt{1-\mathbb{L}^{\prime}} X_{N} \sqrt{1-\mathbb{L}^{\prime}}=O_{*}\left(\mathbb{Q}_{N}\right),  \tag{D.8}\\
\sqrt{1-\mathbb{L}^{\prime}} Y_{N} \sqrt{1-\mathbb{L}^{\prime}}=o_{*}\left(\mathbb{Q}_{N}\right),  \tag{D.9}\\
\mathbb{L}^{\prime} X_{N} \mathbb{L}^{\prime}=o_{*}\left(\mathbb{Q}_{N}\right) . \tag{D.10}
\end{gather*}
$$

Proof. The Corollary follows from Lemma D. 3 and the fact that $\pi_{M, N}$ commutes with $\sqrt{1-\mathbb{L}^{\prime}}$ and $\mathbb{L}^{\prime}$. For the purpose of illustration, let us verify Eq. (D.8). By the assumptions of the Corollary we know that there exist constants $C$ and $\delta>0$, such that $\pi_{M, N} X_{N} \pi_{M, N} \leq C \pi_{M, N} \mathbb{Q}_{N} \pi_{M, N}$. Consequently

$$
\begin{aligned}
\pi_{M, N} & \sqrt{1-\mathbb{L}^{\prime}} X_{N} \sqrt{1-\mathbb{L}^{\prime}} \pi_{M, N}=\sqrt{1-\mathbb{L}^{\prime}} \pi_{M, N} X_{N} \pi_{M, N} \sqrt{1-\mathbb{L}^{\prime}} \\
& \leq C \pi_{M, N} \sqrt{1-\mathbb{L}^{\prime}} \mathbb{Q}_{N} \sqrt{1-\mathbb{L}^{\prime}} \pi_{M, N}=O_{*}\left(\mathbb{Q}_{N}\right)
\end{aligned}
$$

where we have used Eq. (D.6) from Lemma D. 3 in the last equality.
Corollary D.5. Let Assumption 1.9 hold and let $\eta_{m}$ be the functions from Eq. 5.7), with $m \in\{0, \ldots, 3\}$. Then

$$
\left[\left(1-\mathbb{L}^{\prime}\right)^{\frac{m}{2}}-\eta_{m}(q)\right]^{2}=o_{*}\left(\mathbb{Q}_{N}\right)
$$

Proof. The case $m=0$ is trivial. The case $m=1$ is the content of Lemma D. 2 and the case $m=2$ follows from Lemma D.1. Let us now verify the statement in the case $m=3$. Using the fact that $\eta_{3}(t)=\eta_{2}(t) \eta_{1}(t)$, we obtain

$$
\begin{aligned}
&\left(1-\mathbb{L}^{\prime}\right) \sqrt{1-\mathbb{L}^{\prime}}-\eta_{3}(q)=\left[\left(1-\mathbb{L}^{\prime}\right)-\eta_{2}(q)\right] \sqrt{1-\mathbb{L}^{\prime}}+\eta_{2}(q)\left[\sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)\right] \\
&=-\left(f(q)^{\dagger} \cdot b_{>d}+b_{>d}^{\dagger} \cdot f(q)+\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}+b_{>d}^{\dagger} \cdot b_{>d}-\frac{d}{2 N}\right) \sqrt{1-\mathbb{L}^{\prime}} \\
&+\tau_{r}(q) \eta_{2}(q)\left[\sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)\right]+\left[1-\tau_{r}(q)\right] \eta_{2}(q)\left[\sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)\right],
\end{aligned}
$$

where $\tau: \mathbb{R}^{d} \longrightarrow \mathbb{R}$ is a function with $\left.\tau\right|_{B_{1}(0)}=0,\left.\tau\right|_{\mathbb{R}^{d} \backslash B_{2}(0)}=1$ and $0 \leq \tau \leq 1$. Since the function $\tilde{\eta}=(1-\tau) \eta_{2}$ is bounded by a constant $c$, we obtain using Lemma D. 2

$$
\left[\sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)\right] \tilde{\eta}^{2}(q)\left[\sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)\right] \leq c\left[\sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)\right]^{2}=o_{*}\left(\mathbb{Q}_{N}\right)
$$

Note that $\eta^{\prime}:=\left(\tau \eta_{2}\right)^{2}$ is zero in a neighborhood of zero. Therefore, $\eta^{\prime}(q)=O_{*}\left(e^{-\delta N}\right)$ and $\eta_{1}^{2}(q) \eta^{\prime}(q)=O_{*}\left(e^{-\delta N}\right)$ for some $\delta>0$ by Lemma C.2. By Corollary D.4, we obtain in particular that $\sqrt{1-\mathbb{L}^{\prime}} \eta^{\prime}(q) \sqrt{1-\mathbb{L}^{\prime}}=o_{*}\left(\mathbb{Q}_{N}\right)$. Hence we have the estimate

$$
\left[\sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)\right] \eta^{\prime}(q)\left[\sqrt{1-\mathbb{L}^{\prime}}-\eta_{1}(q)\right] \leq 2 \sqrt{1-\mathbb{L}^{\prime}} \eta^{\prime}(q) \sqrt{1-\mathbb{L}^{\prime}}+2 \eta_{1}^{2}(q) \eta^{\prime}(q)=o_{*}\left(\mathbb{Q}_{N}\right)
$$

By Lemma C.5, Lemma C. 6 and Corollary D.4 we know that the operators

$$
\sqrt{1-\mathbb{L}^{\prime}}\left(b_{>d}^{\dagger} \cdot f(q)+f(q)^{\dagger} \cdot b_{>d}\right)^{2} \sqrt{1-\mathbb{L}^{\prime}}
$$

$\sqrt{1-\mathbb{L}^{\prime}}\left(\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}\right)^{2} \sqrt{1-\mathbb{L}^{\prime}}$ as well as $\sqrt{1-\mathbb{L}^{\prime}}\left(b_{>d}^{\dagger} \cdot b_{>d}\right)^{2} \sqrt{1-\mathbb{L}^{\prime}}$ are of order $o_{*}\left(\mathbb{Q}_{N}\right)$ as well, and therefore

$$
\sqrt{1-\mathbb{L}^{\prime}}\left(b_{>d}^{\dagger} \cdot f(q)+f(q)^{\dagger} \cdot b_{>d}+\left(p^{\prime}\right)^{\dagger} \cdot p^{\prime}+b_{>d}^{\dagger} \cdot b_{>d}-\frac{d}{2 N}\right)^{2} \sqrt{1-\mathbb{L}^{\prime}}=o_{*}\left(\mathbb{Q}_{N}\right)
$$

We conclude that $\left(1-\mathbb{L}^{\prime}\right) \sqrt{1-\mathbb{L}^{\prime}}-\eta_{3}(q)=T_{1}+T_{2}+T_{3}$ is a sum of terms with $T_{i}^{\dagger} T_{i}=o_{*}\left(\mathbb{Q}_{N}\right)$, and therefore $\left[\left(1-\mathbb{L}^{\prime}\right) \sqrt{1-\mathbb{L}^{\prime}}-\eta_{3}(q)\right]^{2}=o_{*}\left(\mathbb{Q}_{N}\right)$.
