# THE GALERKIN ANALYSIS FOR THE RANDOM PERIODIC SOLUTION OF SEMILINEAR STOCHASTIC EVOLUTION EQUATIONS

#### Abstract

In this paper we study the numerical method for approximating the random periodic solution of semilinear stochastic evolution equations. The main challenge lies in proving a convergence over an infinite time horizon while simulating infinite-dimensional objects. We first show the existence and uniqueness of the random periodic solution to the equation as the limit of the pull-back flows of the equation, and observe that its mild form is well-defined in the intersection of a family of decreasing Hilbert spaces. Then we propose a Galerkin-type exponential integrator scheme and establish its convergence rate of the strong error to the mild solution, where the order of convergence directly depends on the space (among the family of Hilbert spaces) for the initial point to live. We finally conclude with a best order of convergence that is arbitrarily close to 0.5 .


Keywords Random periodic solution • Stochastic evolution equations • Galerkin method • Discrete exponential integrator scheme

## 1 Introduction

The random periodic solution is a new concept to characterize the presence of random periodicity in the long run of some stochastic systems. On its first appearance in [22], the authors gave the definition of the random periodic solutions of random dynamical systems and showed the existence of such periodic solutions for a $C^{1}$ perfect cocycle on a cylinder. This is followed by another seminal paper [9], where the authors not only defined the random periodic solutions for semiflows but also provided a general framework for its existence. Namely, instead of following the traditional geometric method of establishing the Poincaré mapping, a new analytical method for coupled infinite horizon forward-backward integral equations was introduced. This pioneering study boosts a series of work, including the existence of random periodic solutions to stochastic partial differential equations (SPDEs) [4], the existence of anticipating random periodic solutions [6, 7], periodic measures [8], etc.
Let us recall the definition of the random periodic solution for stochastic semi-flows given in [9]. Let $H$ be a separable Banach space. Denote by $\left(\Omega, \mathcal{F}, \mathbb{P},\left(\theta_{s}\right)_{s \in \mathbb{R}}\right)$ a metric dynamical system and $\theta_{s}: \Omega \rightarrow \Omega$ is assumed to be measurably invertible for all $s \in \mathbb{R}$. Denote $\Delta:=\left\{(t, s) \in \mathbb{R}^{2}, s \leq t\right\}$. Consider a stochastic semi-flow $u: \Delta \times \Omega \times H \rightarrow H$, which satisfies the following standard condition

u(t, r, \omega)=u(t, s, \omega) \circ u(s, r, \omega), \text { for all } r \leq s \leq t, r, s, t \in \mathbb{R}, \text { for a.e. } \omega \in \Omega \tag{1}
\end{equation*}

We do not assume the map $u(t, s, \omega): H \rightarrow H$ to be invertible for $(t, s) \in \Delta, \omega \in \Omega$.

Definition 1.1. A random periodic path of period $\tau>0$ of the semi-flow $u: \Delta \times \Omega \times H \rightarrow H$ is an $\mathcal{F}$-measurable map $y: \mathbb{R} \times \Omega \rightarrow H$ such that for a.e. $\omega \in \Omega$

u(t, s, y(s, \omega), \omega)=y(t, \omega), \forall t \geq s  \tag{2}\\
y(s+\tau, \omega)=y\left(s, \theta_{\tau} \omega\right), \forall s \in \mathbb{R} .
\end{array}\right.
$$

Note that Definition 1.1 covers both the deterministic periodic path and the random fixed point (c.f. [1]), also known as stationary point as its special cases. To see the latter one, one may assume (2) holds for any $\tau>0$, and define $\hat{y}\left(\theta_{t} \omega\right)=y\left(0, \theta_{t} \omega\right)$ for $t>0$, then one can conclude that $u(t, 0, \hat{y}(\omega), \omega)=\hat{y}\left(\theta_{t} \omega\right)$ from (2), which coincides with the definition of random fixed point (also termed as the stationary solution) given in [1]. A well-known example for stationary solution is given by $Y(\omega)=\int_{-\infty}^{0} e^{s} \mathrm{~d} W(s)$, for the one-dimensional random dynamical system $\phi(t, \omega) x=$ $x e^{-t}+\int_{0}^{t} e^{-(t-s)} \mathrm{d} W(s, \omega)$ generated from the following Ornstein-Uhlenbeck process:

d y(t)=-y(t) \mathrm{d} t+d W(t), \quad y(0)=x \in \mathbb{R}, \quad t>0 \tag{3}
\end{equation*}
$$

where $W:(t, \omega) \mapsto W(t, \omega)$ is a one-dimensional two-sided Wiener process on $(\Omega, \mathcal{F}, \mathbb{P})$, and as a convention, $\omega$ is usually hidden in the notation $W(s, \omega)$. One can verify that $\phi(t, \omega) Y(\omega)=Y\left(\theta_{t} \omega\right)$. If in addition, we add a periodic drift term to Eqn. (3) such that it reads as

d y(t)=(-y(t)+\sin (t)) \mathrm{d} t+d W(t), y(s)=x \in \mathbb{R}, \quad t>0, \tag{4}
\end{equation*}
$$

then it is not hard to see the semiflow for (4) is given by $\varphi(t, s, x, \omega):=x e^{-(t-s)}+\int_{s}^{t} e^{-(t-r)} \sin (r) \mathrm{d} r+$ $\int_{s}^{t} e^{-(t-r)} \mathrm{d} W(r)$. Now define $Y(t, \omega)=\int_{-\infty}^{t} e^{-(t-s)} \sin (s) \mathrm{d} s+\int_{-\infty}^{t} e^{-(t-s)} \mathrm{d} W(s)$. One can verify that $Y(t, \omega)=\varphi(t, s, \omega) Y(s, \omega)$ and $Y(t+2 \pi, \omega)=Y\left(t, \theta_{2 \pi} \omega\right)$. Indeed,

\begin{aligned}
Y(t+2 \pi, \omega) & =\int_{-\infty}^{t+2 \pi} e^{-(t+2 \pi-s)} \sin (s) \mathrm{d} s+\int_{-\infty}^{t+2 \pi} e^{-(t+2 \pi-s)} \mathrm{d} W(s, \omega) \\
& =\int_{-\infty}^{t} e^{-(t-\hat{s})} \sin (\hat{s}+2 \pi) \mathrm{d} \hat{s}+\int_{-\infty}^{t} e^{-(t-\hat{s})} \mathrm{d} W(\hat{s}+2 \pi, \omega) \\
& =\int_{-\infty}^{t} e^{-(t-\hat{s})} \sin (\hat{s}) \mathrm{d} \hat{s}+\int_{-\infty}^{t} e^{-(t-\hat{s})} \mathrm{d}(W(\hat{s}+2 \pi, \omega)-W(2 \pi, \omega)) \\
& =\int_{-\infty}^{t} e^{-(t-\hat{s})} \sin (\hat{s}) \mathrm{d} \hat{s}+\int_{-\infty}^{t} e^{-(t-\hat{s})} \mathrm{d} W\left(\hat{s}, \theta_{2 \pi} \omega\right)=Y\left(t, \theta_{2 \pi} \omega\right)
\end{aligned}
$$

where we use in the last two lines the measure preserving property of Wiener process stated in Assumption 1.5 Therefore $Y$ is a random periodic path for semiflow $\varphi$ generated from SDE (4).

In general, random periodic solutions cannot be solved explicitly. Even for the simple case as we showcased in Eqn. (4), one relies on numerical approaches to simulate the random periodic path $Y$. For the dissipative system generated from some SDE with a global Lipchitz condition, the convergences of a forward Euler-Maruyama method and a modified Milstein method to the random period solution have been investigated in [5]. For SDEs with a monotone drift condition, one benefits a flexible choice of stepsize from applying the implicit method instead [20]. Each of these numerical schemes admits their own random periodic solution, which approximates the random periodic solution of the targeted SDE as the stepsize decreases. The main challenge lies in proving a convergence of an infinite time horizon. In this paper, we consider approximating the random periodic trajectory of SPDEs, where, we encounter an additional obstacle of simulating infinite-dimensional objects. For this, we employ the spectral Galerkin method (c.f. [13]) for spatial dimension reduction, construct a discrete exponential integrator scheme based on the spatial discretization and conclude the existence and uniqueness of random periodic solution from the discrete scheme. To the best of our knowledge, this is the first study that works on the numerical analysis (Galerkin analysis) of random periodic solutions for SEEs. The Galerkin-type method has been intensively used to simulate solutions of parabolic SPDEs over finitetime horizon [10, 11, 12, 14, 15, 17], and it is recently applied to approximate stationary distributions for SPDEs [2]. For the error analysis of both strong and weak approximation of semilinear stochastic evolution equations (SEEs) through Galerkin approximation, we refer the reader to the monograph [16].
Let $(H,(\cdot, \cdot),\|\cdot\|)$ and $\left(U,(\cdot, \cdot)_{U},\|\cdot\|_{U}\right)$ be two separable $\mathbb{R}$-Hilbert spaces. For a given $t_{0}, T \in(-\infty, \infty)$ with $t_{0}<T$ we denote by $\left(\Omega, \mathcal{F},\left(\mathcal{F}_{t}\right)_{t \in\left[t_{0}, T\right]}, \mathbb{P}\right)$ a filtered probability space satisfying the usual conditions. By $(W(t))_{t \in\left[t_{0}, T\right]}$ we denote an $\left(\mathcal{F}_{t}\right)_{t \in\left[t_{0}, T\right]}$-Wiener process on $U$ with associated covariance operator $Q \in \mathcal{L}(U)$, which is not necessarily assumed to be of finite trace. Denote by $\mathcal{L}_{2}^{0}=\mathcal{L}_{2}^{0}(H)=\mathcal{L}_{2}\left(Q^{\frac{1}{2}}(U), H\right)$ the set of all Hilbert-Schmidt operators from $Q^{\frac{1}{2}}(U)$ to $H$.

Our goal is to study and approximate the random periodic mild solution to SEEs of the form

$$
\left\{\begin{array}{l}
\mathrm{d} X_{t}^{t_{0}}=\left[-A X_{t}^{t_{0}}+f\left(t, X_{t}^{t_{0}}\right)\right] \mathrm{d} t+g\left(t, X_{t}^{t_{0}}\right) \mathrm{d} W(t), \quad \text { for } t \in\left(t_{0}, T\right]  \tag{5}\\
X_{t_{0}}^{t_{0}}=\xi
\end{array}\right.
$$

Throughout the paper, we impose the following essential assumptions.
Assumption 1.1. The linear operator $A: \operatorname{dom}(A) \subset H \rightarrow H$ is densely defined, self-adjoint, and positive definite with compact inverse.

Assumption 1.1 implies the existence of a positive, increasing sequence $\left(\lambda_{i}\right)_{i \in \mathbb{N}} \subset \mathbb{R}$ such that $0<\lambda_{1} \leq \lambda_{2} \leq \ldots$ with $\lim _{i \rightarrow \infty} \lambda_{i}=\infty$, and of an orthonormal basis $\left(e_{i}\right)_{i \in \mathbb{N}}$ of $H$ such that $A e_{i}=\lambda_{i} e_{i}$ for every $i \in \mathbb{N}$. Indeed we have that

\operatorname{dom}(A):=\left\{x \in H: \sum_{n=1}^{\infty} \lambda_{n}^{2}\left(x, e_{n}\right)^{2}<\infty\right\}
$$

In addition, it also follows from Assumption 1.1 that $-A$ is the infinitesimal generator of an analytic semigroup $(S(t))_{t \in[0, \infty)} \subset \mathcal{L}(H)$ of contractions. More precisely, the family $(S(t))_{t \in[0, \infty)}$ enjoys the properties

S(0) & =\operatorname{Id} \in \mathcal{L}(H) \\
S(s+t) & =S(s) \circ S(t)=S(t) \circ S(s), \quad \text { for all } s, t \in[0, \infty)
\end{aligned}

and

\sup _{t \in[0, \infty)}\|S(t)\|_{\mathcal{L}(H)} \leq 1 \tag{6}
\end{equation*}
$$

Further, let us introduce fractional powers of $A$, which are used to measure the (spatial) regularity of the mild solution (99. For any $r \in[-1,1]$ we define the operator $A^{\frac{r}{2}}: \operatorname{dom}\left(A^{\frac{r}{2}}\right)=\left\{x \in H: \sum_{j=1}^{\infty} \lambda_{j}^{r}\left(x, e_{j}\right)^{2}<\infty\right\} \subset H \rightarrow H$ by

A^{\frac{r}{2}} x:=\sum_{j=1}^{\infty} \lambda_{j}^{\frac{r}{2}}\left(x, e_{j}\right) e_{j}, \quad \text { for all } x \in \operatorname{dom}\left(A^{\frac{r}{2}}\right) \tag{7}
\end{equation*}
$$

Then, by setting $\left(\dot{H}^{r},(\cdot, \cdot)_{r},\|\cdot\|_{r}\right):=\left(\operatorname{dom}\left(A^{\frac{r}{2}}\right),\left(A^{\frac{r}{2}} \cdot A^{\frac{r}{2}} \cdot\right),\left\|A^{\frac{r}{2}} \cdot\right\|\right)$, we obtain a family of separable Hilbert spaces. Clearly, for any $0 \leq r_{1}<r_{2} \leq 1$, we have that $\operatorname{dom}(A) \subset \dot{H}^{r_{2}} \subset \dot{H}^{r_{1}} \subset H$.
Assumption 1.2. The initial value $\xi: \Omega \rightarrow H$ satisfies $\xi \in L^{2}\left(\Omega, \mathcal{F}_{t_{0}}, \mathbb{P} ; H\right)$. Denote by $C_{\xi}$ a constant such that $\mathbb{E}\left[\|\xi\|^{2}\right] \leq C_{\xi}^{2}$.
Assumption 1.3. The mappings $f: \mathbb{R} \times H \rightarrow H$ and $g: \mathbb{R} \times H \rightarrow \mathcal{L}_{0}^{2}$ are continuous and periodic in time with period $\tau$. Moreover, there exist $\kappa \in(0,1 / 2], C_{f}, C_{g}, C_{f, g} \in(0, \infty)$ such that

$$
\begin{array}{ll}
\left\|f\left(t, u_{1}\right)-f\left(t, u_{2}\right)\right\| \leq C_{f}\left\|u_{1}-u_{2}\right\|, & \left\|f\left(t_{1}, u\right)-f\left(t_{2}, u\right)\right\| \leq C_{f}(1+\|u\|)\left|t_{1}-t_{2}\right|^{\kappa} \\
\left\|g\left(t, u_{1}\right)-g\left(t, u_{2}\right)\right\|_{\mathcal{L}_{0}^{2}} \leq C_{g}\left\|u_{1}-u_{2}\right\|, & \left\|g\left(t_{1}, u\right)-g\left(t_{2}, u\right)\right\|_{\mathcal{L}_{0}^{2}} \leq C_{g}(1+\|u\|)\left|t_{1}-t_{2}\right|^{\kappa}
\end{array}
$$

for all $u, u_{1}, u_{2} \in H$ and $t, t_{1}, t_{2} \in[0, \tau)$.
Remark 1. Indeed the condition on $f$ can be weakened to a local Lipschitz condition for the existence and uniqueness of the random periodic solution. However, to show the continuity of the random periodic solution or to conduct the numerical analysis, one still need Assumption 1.3 .
Remark 2. One will see that the Hölder continuity in temporal variable imposed on both diffusion and drift terms plays an important role in the numerical analysis part. To be more specific, it partly determines the order of convergence of the proposed numerical scheme.
Remark 3. Note that the assumption on $g$ excludes identity in $\mathcal{L}(H)$. One may refer to [2] for techniques handing a slight more general assumption on $g$, which allows $g$ to be constant in $\mathcal{L}(H)$.

From Assumption 1.3 we directly deduce a linear growth bound of the form

\|f(t, u)\|+\|g(t, u)\|_{\mathcal{L}_{0}^{2}} \leq L_{f, g}(1+\|u\|), \quad \text { for all } t \in \mathbb{R}, u \in H \tag{8}
\end{equation*}
$$

where $L_{f, g}:=\|f(0,0)\|+\|g(0,0)\|_{\mathcal{L}_{0}^{2}}+\left(C_{f}+C_{g}\right)\left(1+\tau^{\frac{1}{2}}\right)$.
Under these assumptions the SEE (5) admits a unique mild solution $X^{t_{0}}:\left[t_{0}, T\right] \times \Omega \rightarrow H$ such that it is uniquely determined by the variation-of-constants formula (c.f. [3])

X_{t}^{t_{0}}(\xi)=S\left(t-t_{0}\right) \xi+\int_{t_{0}}^{t} S(t-s) f\left(s, X_{s}^{t_{0}}\right) \mathrm{d} s+\int_{t_{0}}^{t} S(t-s) g\left(s, X_{s}^{t_{0}}\right) \mathrm{d} W(s) \tag{9}
\end{equation*}
$$

which holds $\mathbb{P}$-almost surely for all $t \in\left[t_{0}, T\right]$.

### 1.1 The pull-back

To ensure the existence of random periodic solution, we need some additional assumptions on the Wiener process and on $C_{f}$ and $\lambda_{1}$ :
Assumption 1.4. The constant $C_{f}$ in Assumption 1.3 and the eigenvalue $\lambda_{1}$ of $A$ satisfy $C_{f}<\lambda_{1}$.
Assumption 1.5. There exists a standard $\mathbb{P}$-preserving ergodic Wiener shift $\theta$ such that $\theta_{s}(\omega)(t)=W(t+s)-W(s)$ for $s, t \in \mathbb{R}$, ie,

$$
\mathbb{P} \circ\left(\theta_{s} W(t)\right)^{-1}=\mathbb{P} \circ(W(t+s)-W(s))^{-1}
$$

Denote by $X_{t}^{-k \tau}(\xi, \omega)$ the solution starting from time $-k \tau$. The uniform boundedness of $X_{t}^{-k \tau}(\xi, \omega)$ in the $L^{2}$ sense can be guaranteed under Assumption 1.1 to 1.4 Further, under Assumption 1.1 to Assumption 1.5 , one is able to show that when $k \rightarrow \infty$, the pull-back $X_{t}^{-k \tau}(\xi)$ has a unique limit $X_{t}^{*}$ in $L^{2}(\Omega ; H)$, moreover, $X_{t}^{*}$ is the random periodic solution of SEE (5), satisfying

$$
\begin{equation*}
X_{t}^{*}=\int_{-\infty}^{t} S(t-s) f\left(s, X_{s}^{*}\right) \mathrm{d} s+\int_{-\infty}^{t} S(t-s) g\left(s, X_{s}^{*}\right) \mathrm{d} W(s) \tag{10}
\end{equation*}
$$

Surprisingly, the mild form (10) can be shown well-defined in $L^{2}\left(\Omega ; \dot{H}^{r}\right)$ for any $r \in(0,1)$. More details about the proof can be found in Section 3. Besides, the continuity of $X_{t}^{-k \tau}(\xi, \omega)$ is characterized in Section 3 for error analysis in Section 4

### 1.2 The Galerkin approximation

Next, we formulate the assumptions and notations on the spatial discretization. To this end, define finite-dimensional subspaces $H_{n}$ of $H$ spanned by the first $n$ eigenfunctions of the basis, ie, $H_{n}:=\left\{e_{1}, \ldots, e_{n}\right\}$, and let $P_{n}: H \rightarrow H_{n}$ be the orthogonal projection. Note that $H_{n} \subset \dot{H}^{r}$ for any $r \in \mathbb{R}$. By doing this, we are able to further introduce the following notations: $A_{n}=P_{n} A \in \mathcal{L}\left(H_{n}\right), S_{n}(t)=P_{n} S(t) \in \mathcal{L}\left(H_{n}\right), f_{n}=P_{n} f: \mathbb{R} \times H_{n} \rightarrow H_{n}$ and $g_{n}=P_{n} g: \mathbb{R} \times H_{n} \rightarrow \mathcal{L}_{0}^{2}\left(H_{n}\right)$. Then the Galerkin approximation to (5) can be formulated as follows

\mathrm{d} X_{t}^{n, t_{0}}=\left[-A_{n} X_{t}^{n, t_{0}}+f_{n}\left(t, X_{t}^{n, t_{0}}\right)\right] \mathrm{d} t+g_{n}\left(t, X_{t}^{n, t_{0}}\right) \mathrm{d} W(t), \quad \text { for } t \in\left(t_{0}, T\right]  \tag{11}\\
X_{t_{0}}^{n, t_{0}}=P_{n} \xi
\end{array}\right.
$$

Applying the spectral Galerkin method results in a system of finite dimensional stochastic differential equations. Note that for $x, y \in H_{n}$, we have that $A_{n} x=A x, S_{n}(t) x=S(t) x$ and $\left(x, f_{n}(t, y)\right)=(x, f(t, y))$.
Remark 4. It is easy to see there exists an isometry between $H_{n}$ and $\mathbb{R}^{n}$. An simply calculation leads to the existence of a unique strong solution to (11). The uniform boundedness of $X_{t}^{n,-k \tau}$ as well as the existence of the random periodic solution to (11) are simple consequences of the corresponding properties of $X_{t}^{-k \tau}$.

Let us fix an equidistant partition $\mathcal{T}^{h}:=\{j h, j \in \mathbb{Z}\}$ with stepsize $h \in(0,1)$. Note that $\mathcal{T}^{h}$ stretch along the real line because we are dealing with an infinite time horizon problem. Then to simulate the solution to (11) starting at $-k \tau$, the discrete exponential integrator scheme on $\mathcal{T}^{h}$ is given by the recursion

\hat{X}_{-k \tau+(j+1) h}^{n,-k \tau}=S_{n}(h)\left(\hat{X}_{-k \tau+j h}^{n,-k \tau}+h f_{n}\left(-k \tau+j h, \hat{X}_{-k \tau+j h}^{n,-k \tau}\right)+g_{n}\left(-k \tau+j h, \hat{X}_{-k \tau+j h}^{n,-k \tau}\right) \Delta W_{-k \tau+j h}\right) \tag{12}
\end{equation*}
$$

for all $j \in \mathbb{N}$, where the initial value $\hat{X}_{-k \tau}^{n,-k \tau}=P_{n} \xi$. Moreover, if we define

$$
\bar{X}_{t}^{-k \tau}=\hat{X}_{-k \tau+j h}^{n,-k \tau} \text { and } \Lambda(t)=-k \tau+j h
$$

for $t \in[-k \tau+j h,-k \tau+(j+1) h)$, it follows that the continuous version of (12) is therefore

$$
\begin{align*}
\hat{X}_{t}^{n,-k \tau}= & S_{n}(t+k \tau) P_{n} \xi+\int_{-k \tau}^{t} S_{n}(t-\Lambda(s)) f_{n}\left(\Lambda(s), \bar{X}_{s}^{n,-k \tau}\right) \mathrm{d} s \\
& +\int_{-k \tau}^{t} S_{n}(t-\Lambda(s)) g_{n}\left(\Lambda(s), \bar{X}_{s}^{n,-k \tau}\right) \mathrm{d} W(s)  \tag{13}\\
= & S(t+k \tau) P_{n} \xi+\int_{-k \tau}^{t} S(t-\Lambda(s)) f_{n}\left(\Lambda(s), \bar{X}_{s}^{n,-k \tau}\right) \mathrm{d} s \\
& +\int_{-k \tau}^{t} S(t-\Lambda(s)) g_{n}\left(\Lambda(s), \bar{X}_{s}^{n,-k \tau}\right) \mathrm{d} W(s),
\end{align*}
$$

with differential form

$$
\begin{align*}
\mathrm{d} \hat{X}_{t}^{n,-k \tau}= & -A \hat{X}_{t}^{n,-k \tau}+S(t-\Lambda(t)) f_{n}\left(\Lambda(t), \bar{X}_{t}^{n,-k \tau}\right) \mathrm{d} t  \tag{14}\\
& +S(t-\Lambda(t)) g_{n}\left(\Lambda(t), \bar{X}_{t}^{n,-k \tau}\right) \mathrm{d} W(t)
\end{align*}
$$

In Section 4 , we show the uniform boundedness of $\hat{X}_{t}^{n,-k \tau}$ by imposing another assumptions on $f$ and $g$ :
Assumption 1.6 (Dissipative condition). It holds that

2\left(f\left(t, u_{1}\right)-f\left(t, u_{2}\right), u_{1}-u_{2}\right)+\left\|g\left(t, u_{1}\right)-g\left(t, u_{2}\right)\right\|_{\mathcal{L}_{0}^{2}}^{2} \leq-C_{f, g}\left\|u_{1}-u_{2}\right\|^{2}
$$

for all $u, u_{1}, u_{2} \in H$ and $t \in[0, \tau)$.
Assumption 1.7. $L_{f, g}<2 \lambda_{1}, \frac{C_{f}}{\lambda_{1}}+\frac{C_{g}}{\sqrt{\lambda_{1}}}<1$.
We conclude the random periodicity of the spatio-temporal discrete scheme (13) in Theorem 4.1 and determine a uniform and strong order to approximate $X^{-k \tau}(\xi)$ from (13) in Theorem 4.2 Compared to the convergence in SDE cases in [5, 20], for the SEE case it is required that the approximation trajectory starting from $L^{2}\left(\Omega ; \dot{H}^{r}\right)$ with $r \in(0,1)$ rather than an arbitrary starting point in $L^{2}(\Omega ; H)$, which guarantees the continuity of the path $X^{-k \tau}(\xi)$. An interesting observation from it is, the order of convergence directly depends on the space where the initial point lives on, ie, $L^{2}\left(\Omega ; \dot{H}^{r}\right)$. As the rate of the convergence from $X_{-}^{-k \tau}(\xi)$ to the random periodic path $X_{\text {. }}$. is dependent of the initial condition, we end up this paper with Corollary 4.1 which determines a strong but not optimal order for approximating $X_{*}^{*}$. Corollary 4.1 also implies the best order of convergence can be ever achieved is $1 / 2-\epsilon$ with arbitrarily small $\epsilon$.

## 2 Preliminaries

In this section we present a few useful mathematical tools for later use.
Proposition 2.1. Under the condition of the infinitesimal generator $-A$ in Assumption 1.1 for the semigroup $(S(t))_{t \in[0, \infty)}$, the following properties hold:

1. For any $\nu \in[0,1]$, there exists a positive constant $C_{1}(\nu)$ such that

where Id is the identity map from $H$ to $H$. In addition,

2. For any $\mu \geq 0$, there exists a positive constant $C_{2}(\mu)$ such that

\end{equation*}

3. For any $t \geq 0,\|S(t)\|_{\mathcal{L}(H)} \leq e^{-\lambda_{1} t}$. For the orthogonal projection $P_{n}$, it holds that

\left\|S(t)\left(\operatorname{Id}-P_{n}\right)\right\|_{\mathcal{L}(H)} \leq e^{-\lambda_{n+1} t}, \quad \text { for } t \geq 0 \tag{18}
\end{equation*}

Proof. The proof for the first two inequalities can be found in [19]. For the last one, note for any $x \in H$, we have the decomposition $x=\sum_{i=1}^{\infty}\left(x, e_{i}\right) e_{i}$. Clearly $S(t)\left(\operatorname{Id}-P_{n}\right)$ is a linear operator from $H$ to $H$. Then the induced norm (indeed we consider its square for convenience) for it is therefore

\left\|S(t)\left(\operatorname{Id}-P_{n}\right)\right\|_{\mathcal{L}(H)}^{2} & =\sup _{x \in H,\|x\|=1}\left\|S(t)\left(\operatorname{Id}-P_{n}\right) x\right\|^{2}=\sup _{x \in H,\|x\|=1} \sum_{i=n+1}^{\infty} e^{-2 \lambda_{i} t}\left(x, e_{i}\right)^{2} \\
& \leq e^{-2 \lambda_{n+1} t} \sup _{x \in H,\|x\|=1} \sum_{i=1}^{\infty}\left(x, e_{i}\right)^{2} \leq e^{-2 \lambda_{n+1} t}\|x\|^{2}
\end{aligned}
$$

As one of the main tools, Gamma function is presented:

\Gamma(\gamma):=\int_{0}^{\infty} x^{\gamma-1} e^{-x} \mathrm{~d} x<\infty \text { for } \gamma>0 \tag{19}
\end{equation*}

## 3 Existence and uniqueness of random periodic solution

In the following, we will show the boundedness of the solution to SEE (5) and characterize its dependence on the initial condition, both of which are crucial ingredients for the existence of random periodic solutions. The proof simply follows Lemma 3.1 and Lemma 3.2 in [20].
Lemma 3.1. For SEE (5) with the given initial condition $\xi$ and satisfying Assumption 1.1to Assumption 1.4, we have

\begin{equation*}
\sup _{k \in \mathbb{N}} \sup _{t>-k \tau} \mathbb{E}\left[\left\|X_{t}^{-k \tau}(\xi)\right\|^{2}\right]<\infty \tag{20}
\end{equation*}
$$

If, in addition, $\xi \in L^{2}\left(\Omega, \mathcal{F}_{-k \tau}, \mathbb{P} ; \dot{H}^{r}\right)$ for some $r \in(0,1)$, then the mild solution $X_{t}^{-k \tau}(\xi)$ introduced in (9) is well defined in $L^{2}\left(\Omega, \mathcal{F}_{-k \tau}, \mathbb{P} ; \dot{H}^{r}\right)$ for any $k \in \mathbb{N}$, and $t>-k \tau$.

Proof. The fist assertion follows Lemma 3.1 in [20]. It remains to justify the second assertion, by bounding each term of (9) in $L^{2}\left(\Omega, \mathcal{F}_{-k \tau}, \mathbb{P} ; \dot{H}^{r}\right)$ with some constant independent of $k$ and $t$. For the first term on the right hand side of (9), we have

To bound the second term on the right hand side of (9), we apply the linear growth of $f$ in (8), Proposition 2.1 and (20), and take $\theta=\frac{1}{2}$ as follows:

& =\mathbb{E}\left[\left\|\int_{-k \tau}^{t} A^{\frac{r}{2}} S(\theta(t-s)) S((1-\theta)(t-s)) f\left(s, X_{s}^{-k \tau}\right) \mathrm{d} s\right\|^{2}\right] \\
& \leq 2 L_{f, g}^{2}\left(1+\sup _{k \in \mathbb{N}} \sup _{s \geq-k \tau} \mathbb{E}\left[\left\|X_{s}^{-k \tau}\right\|^{2}\right]\right)\left(\int_{-k \tau}^{t}\left\|A^{\frac{r}{2}} S(\theta(t-s))\right\|_{\mathcal{L}(H)}\|S((1-\theta)(t-s))\| \mathrm{d} s\right)^{2} \\
& \leq 2 L_{f, g}^{2} C_{2}\left(\frac{r}{2}\right)^{2}\left(1+\sup _{k \in \mathbb{N}} \sup _{s \geq-k \tau} \mathbb{E}\left[\left\|X_{s}^{-k \tau}\right\|^{2}\right]\right)\left(\int_{-k \tau}^{t}(\theta(t-s))^{-\frac{r}{2}} e^{-\lambda_{1}(1-\theta)(t-s)} \mathrm{d} s\right)^{2} \\
& \leq 2 L_{f, g}^{2} C_{2}\left(\frac{r}{2}\right)^{2}\left(1+\sup _{k \in \mathbb{N}} \sup _{s \geq-k \tau} \mathbb{E}\left[\left\|X_{s}^{-k \tau}\right\|^{2}\right]\right) \lambda_{1}^{r-2} \frac{\Gamma\left(1-\frac{r}{2}\right)^{2}}{4},
\end{aligned}
$$

where we make use of the definition of Gamma function (19) and $\theta=\frac{1}{2}$ to get

\int_{-k \tau}^{t}(\theta(t-s))^{-\frac{r}{2}} e^{-\lambda_{1}(1-\theta)(t-s)} \mathrm{d} s=\int_{0}^{t+k \tau}(\theta s)^{-\frac{r}{2}} e^{-\lambda_{1}(1-\theta) s} \mathrm{~d} s \leq \lambda_{1}^{\frac{r}{2}-1} \frac{\Gamma\left(1-\frac{r}{2}\right)}{2}
$$

It remains to estimate the last term of (9). To achieve it, we shall apply the Itô isometry, the linear growth of $g$ in (8), and Proposition 2.1 together with the technique involving Gamma function above:

& \mathbb{E}\left[\left\|A^{\frac{r}{2}} \int_{-k \tau}^{t} S(t-s) g\left(s, X_{s}^{-k \tau}\right) \mathrm{d} W(s)\right\|^{2}\right] \\
& \leq 2 L_{f, g}^{2}\left(1+\sup _{k \in \mathbb{N}} \sup _{s \geq-k \tau} \mathbb{E}\left[\left\|X_{s}^{-k \tau}\right\|^{2}\right]\right) \int_{-k \tau}^{t}\left\|A^{\frac{r}{2}} S(t-s)\right\|^{2} \mathrm{~d} s \\
& \leq 2 L_{f, g}^{2}\left(1+\sup _{k \in \mathbb{N}} \sup _{s \geq-k \tau} \mathbb{E}\left[\left\|X_{s}^{-k \tau}\right\|^{2}\right]\right)\left(2 \lambda_{1}\right)^{r-1} \frac{\Gamma(1-r)}{2}
\end{aligned}
$$

Remark 5. As in [20], it suffices to show (20) through a weaker condition on $f, g$ than the linear growth (8) there exists a constant $\hat{L}_{f, g}$ such that $2(u, f(t, u))+\|g(t, u)\|_{L_{0}^{2}} \leq \hat{L}_{f, g}\left(1+\|u\|^{2}\right)$, for $t \in \mathbb{R}$ and $u \in H$.
Lemma 3.2. Assume Assumption 1.1 to Assumption 1.4. Denote by $X_{t}^{-k \tau}$ and $Y_{t}^{-k \tau}$ two solutions of SPDE (5) with different initial values $\xi$ and $\eta$. Then for every $\epsilon>0$, there exists a $t \geq-k \tau$ such that

\mathbb{E}\left[\left\|X_{\tilde{t}}^{-k \tau}-Y_{\tilde{t}}^{-k \tau}\right\|^{2}\right]<\epsilon \tag{21}
\end{equation*}

whenever $\tilde{t} \geq t$.

The existence of the semiflow $u$ for SEE (5) and its continuity with respect to the initial condition, ie, $u(t, s, \cdot, \omega)$ : $H \rightarrow H$ being continuous, can be guaranteed by [18]. With Lemma 3.1, Lemma 3.2 and Assumption [1.5, the existence and uniqueness of the random periodic solution to (5) can be shown following a similar argument in the proof of Theorem 2.4 in [5].
Theorem 3.1. Under Assumption 1.1 to 1.5 , there exists a unique random periodic solution $X^{*}(t, \cdot) \in L^{2}(\Omega ; H)$ such that the solution of (5) satisfies

\lim _{k \rightarrow \infty} \mathbb{E}\left[\left\|X_{t}^{-k \tau}(\xi)-X_{t}^{*}\right\|^{2}\right]=0 \tag{22}
\end{equation*}
$$

Moreover, it holds that the mild form of $X^{*}$ given in (10) is well defined in $L^{2}\left(\Omega ; \dot{H}^{r}\right)$ for any $r \in(0,1)$.
Proof. It remains to show the second assertion. The first conclusion of Theorem 3.1 ensures that for any $\epsilon$, there exists a $K(t) \in \mathbb{N}$ such that $\mathbb{E}\left[\left\|X_{t}^{-k \tau}(\xi)-X_{t}^{*}\right\|^{2}\right]<\epsilon$ for any $k \geq K(t)$. Then

& \qquad \limsup _{t \in[0, \pi]} \mathbb{E}\left[\left\|X_{t}^{*}\right\|^{2}\right]=\limsup _{t \in[0, \pi]} \mathbb{E}\left[\left\|X_{t}^{*}-X_{t}^{-k \tau}(\xi)+X_{t}^{-k \tau}(\xi)\right\|^{2}\right] \\
& \leq \sup _{k \in \mathbb{N}} \sup _{t \in[0, \pi]} 2 \mathbb{E}\left[\left\|X_{t}^{-k \tau}(\xi)\right\|^{2}\right]+\lim _{t} \sup _{k \geq K(t)} \lim _{k \geq} 2 \mathbb{E}\left[\left\|X_{t}^{-k \tau}(\xi)-X_{t}^{*}\right\|^{2}\right] \\
& <\sup _{k \in \mathbb{N}} \sup _{t \in[0, \pi]} 2 \mathbb{E}\left[\left\|X_{t}^{-k \tau}(\xi)\right\|^{2}\right]+2 \epsilon .
\end{aligned}
$$

Due to the random periodicity of $X^{*}$ and the measure preserving property of $\theta$, it holds that

$$
\limsup _{t \in[\pi, 2 \pi]} \mathbb{E}\left[\left\|X_{t}^{*}(\cdot)\right\|^{2}\right]=\limsup _{t \in[\pi, 2 \pi]} \mathbb{E}\left[\left\|X_{t-\pi}^{*}\left(\theta_{\pi} \cdot\right)\right\|^{2}\right]=\limsup _{t \in[\pi, 2 \pi]} \mathbb{E}\left[\left\|X_{t-\pi}^{*}(\cdot)\right\|^{2}\right]=\limsup _{t \in[0, \pi]} \mathbb{E}\left[\left\|X_{t}^{*}(\cdot)\right\|^{2}\right]
$$

Similarly $\lim \sup _{t \in[-\pi, 0]} \mathbb{E}\left[\left\|X_{t}^{*}\right\|^{2}\right]=\lim \sup _{t \in[0, \pi]} \mathbb{E}\left[\left\|X_{t}^{*}\right\|^{2}\right]$. Thus by induction, $\lim \sup _{t \in \mathbb{R}} \mathbb{E}\left[\left\|X_{t}^{*}\right\|^{2}\right]<\infty$. Then following the same approach in the proof of Lemma3.1 we can deduce that the mild form of $X_{t}^{*}$ is in $L^{2}\left(\Omega ; \dot{H}^{r}\right)$ for any $r \in(0,1)$.

The second conclusion of Theorem 3.1 claims that the $X^{*}$ lives in an intersection space of $L^{2}\left(\Omega ; \dot{H}^{r}\right)$, which is much smaller than $L^{2}(\Omega ; H)$. Note that the first conclusion of Theorem 3.1 shows the convergence is regardless of the initial condition $\xi$, that is, $X_{t}^{-k \tau}(\xi)$ will converge to the unique random periodic solution no matter where it starts from. This observation is crucial in that one may choose a starting point with preferred properties, for instance, the continuity shown in Lemma 3.3.
Lemma 3.3. Recall that for a fixed $h \in(0,1), \Lambda(t):=-k \tau+j h$ when $t \in(-k \tau+j h,-k \tau+(j+1) h]$. Consider the mild solution $X^{-k \tau}(\xi)$ of SEE (5) with given initial condition $\xi \in L^{2}\left(\Omega, \mathcal{F}_{-k \tau}, \mathbb{P} ; \dot{H}^{r}\right)$ for some $r \in(0,1)$ and satisfying Assumption 1.1 to 1.4 Then for any $\nu_{1} \in(0, r / 2]$, there exists a positive constant $C_{X}$ depending on $r$ and $\nu_{1}$ such that

$$
\sup _{k \in \mathbb{N}} \sup _{t \geq k \tau} \mathbb{E}\left[\left\|X_{t}^{-k \tau}-X_{\Lambda(t)}^{-k \tau}\right\|^{2}\right] \leq C_{X}\left(\nu_{1}, r\right) h^{2 \nu_{1}} .
$$

Proof. One can deduce the following expression from the mild form (9):

\begin{align*}
& X_{t}^{-k \tau}(\xi)-X_{\Lambda(t)}^{-k \tau}(\xi) \\
& =(S(t-\Lambda(t))-\mathrm{Id}) S(\Lambda(t)+k \tau) \xi \\
& \quad+\int_{\Lambda(t)}^{t} S(t-s) f\left(s, X_{s}^{-k \tau}\right) \mathrm{d} s+\int_{-k \tau}^{\Lambda(t)}(S(t-\Lambda(t))-\mathrm{Id}) S(\Lambda(t)-s) f\left(s, X_{s}^{-k \tau}\right) \mathrm{d} s  \tag{23}\\
& \quad+\int_{\Lambda(t)}^{t} S(t-s) g\left(s, X_{s}^{-k \tau}\right) \mathrm{d} W(s)+\int_{-k \tau}^{\Lambda(t)}(S(t-\Lambda(t))-\mathrm{Id}) S(\Lambda(t)-s) g\left(s, X_{s}^{-k \tau}\right) \mathrm{d} W(s) .
\end{align*}
$$

To get the final assertion, we estimate each term on the right hand in $\mathbb{E}\left[\|\cdot\|^{2}\right]$. For the first term, we have that

& \mathbb{E}\left[\|(S(t-\Lambda(t))-\mathrm{Id}) S(\Lambda(t)+k \tau) \xi\|^{2}\right] \\
& =\mathbb{E}\left[\left\|A^{-\nu_{1}}(S(t-\Lambda(t))-\mathrm{Id}) A^{-\left(\frac{r}{2}-\nu_{1}\right)} S(\Lambda(t)+k \tau) A^{\frac{r}{2}} \xi\right\|^{2}\right] \\
& \leq\left\|A^{-\nu_{1}}(S(t-\Lambda(t))-\mathrm{Id})\right\|_{\mathcal{L}(H)}^{2}\left\|A^{-\left(\frac{r}{2}-\nu_{1}\right)}\right\|_{\mathcal{L}(H)}^{2}\|S(\Lambda(t)+k \tau)\|_{\mathcal{L}(H)}^{2} \mathbb{E}\left[\left\|A^{\frac{r}{2}} \xi\right\|^{2}\right] \\
& \leq C_{1}\left(\nu_{1}\right) h^{2 \nu_{1}} \lambda_{1}^{-\left(r-2 \nu_{1}\right)} \mathbb{E}\left[\left\|A^{\frac{r}{2}} \xi\right\|^{2}\right]
\end{aligned}
$$

where Proposition 2.1 is applied for the last line. For the second term of (23), by making use of the linear growth condition on $f$ and Hölder's inequality, we can obtain

$$

Similarly for the fourth term of (23), through the Itô isometry we have that

\begin{aligned}
& \mathbb{E}\left[\left\|\int_{\Lambda(t)}^{t} S(t-s) g\left(s, X_{s}^{-k \tau}\right) \mathrm{d} W(s)\right\|^{2}\right] \\
& =\int_{\Lambda(t)}^{t} \mathbb{E}\left[\left\|S(t-s) g\left(s, X_{s}^{-k \tau}\right)\right\|_{\mathcal{L}_{0}^{2}}\right] \mathrm{d} s \\
& \leq 2 L_{f, g}^{2} h\left(1+\sup _{k \in \mathbb{N}} \sup _{s \geq-k \tau} \mathbb{E}\left[\left\|X_{s}^{-k \tau}\right\|^{2}\right]\right) .
\end{aligned}
$$

For the third term of (23), applying Assumption 1.1, Proposition 2.1, and defining $\theta=1 / 2$ yield the following estimate

\begin{align*}
& \mathbb{E}\left[\left\|\int_{-k \tau}^{\Lambda(t)}(S(t-\Lambda(t))-\mathrm{Id}) S(\Lambda(t)-s) f\left(s, X_{s}^{-k \tau}\right) \mathrm{d} s\right\|^{2}\right] \\
& =\mathbb{E}\left[\left\|\int_{-k \tau}^{\Lambda(t)} A^{-\nu_{1}}(S(t-\Lambda(t))-\mathrm{Id}) A^{\nu_{1}} S(\Lambda(t)-s) f\left(s, X_{s}^{-k \tau}\right) \mathrm{d} s\right\|^{2}\right] \\
& \leq C_{1}\left(\nu_{1}\right)^{2} h^{2 \nu_{1}} \int_{-k \tau}^{\Lambda(t)}\left\|A^{\nu_{1}} S(\Lambda(t)-s)\right\|_{\mathcal{L}(H)} \mathrm{d} s \int_{-k \tau}^{\Lambda(t)}\left\|A^{\nu_{1}} S(\Lambda(t)-s)\right\|_{\mathcal{L}(H)} \mathbb{E}\left[\left\|f\left(s, X_{s}^{-k \tau}\right)\right\|^{2}\right] \mathrm{d} s \\
& \leq 2 L_{f, g}^{2}\left(1+\sup _{k \in \mathbb{N}} \sup _{s \geq-k \tau} \mathbb{E}\left[\left\|X_{s}^{-k \tau}\right\|^{2}\right]\right) C_{1}\left(\nu_{1}\right)^{2} h^{2 \nu_{1}}\left(\int_{0}^{\Lambda(t)+k \tau}\left\|A^{\nu_{1}} S(\theta s) S((1-\theta) s)\right\|_{\mathcal{L}(H)} \mathrm{d} s\right)^{2}  \tag{24}\\
& \leq 2 L_{f, g}^{2}\left(1+\sup _{k \in \mathbb{N}} \sup _{s \geq-k \tau} \mathbb{E}\left[\left\|X_{s}^{-k \tau}\right\|^{2}\right]\right) C_{1}\left(\nu_{1}\right)^{2} h^{2 \nu_{1}} C_{2}\left(\nu_{1}\right)^{2}\left(\int_{0}^{\Lambda(t)+k \tau}(\theta s)^{-\nu_{1}} e^{-\lambda_{1}(1-\theta) s} \mathrm{~d} s\right)^{2} \\
& \leq 2 L_{f, g}^{2}\left(1+\sup _{k \in \mathbb{N}} \sup _{s \geq-k \tau} \mathbb{E}\left[\left\|X_{s}^{-k \tau}\right\|^{2}\right]\right) C_{1}\left(\nu_{1}\right)^{2} h^{2 \nu_{1}} C_{2}\left(\nu_{1}\right)^{2} \frac{\lambda_{1}^{2\left(\nu_{1}-1\right)} \Gamma\left(1-\nu_{1}\right)^{2}}{4},
\end{align*}
$$

where we change variable to deduce the integral in the fourth line and apply the Gamma function (19) to get the last line.

For the last term of (23), using the Itô isometry, the linear growth of $g$ in (8) and the definition of the Gamma function we have that

& \mathbb{E}\left[\left\|\int_{-k \tau}^{\Lambda(t)}(S(t-\Lambda(t))-\mathrm{Id}) S(\Lambda(t)-s) g\left(s, X_{s}^{-k \tau}\right) \mathrm{d} W(s)\right\|^{2}\right] \\

## 4 The random periodic solution of the Galerkin numerical approximation

This section is devoted to the existence and uniqueness of the random periodic solution for the Galerkin-type spatiotemporal discretization defined in (13), and its convergence to the random periodic solution of our underlying SPDE (5).

Lemma 4.1. Under Assumption 1.1 to Assumption 1.3 for the continuous version of the numerical scheme defined in (13) with stepsize $h \in(0,1)$, it holds that

\end{aligned}
$$

In total, we have that

$$
\begin{aligned}
& \sup _{k \in \mathbb{N}} \sup _{t \geq k \tau}\left(\mathbb{E}\left[\left\|X_{t}^{-k \tau}-\hat{X}_{t}^{n,-k \tau}\right\|^{2}\right]\right)^{1 / 2} \leq \sum_{i=1}^{9} \sup _{k \in \mathbb{N}} \sup _{t \geq k \tau}\left(\mathbb{E}\left[\left\|J_{i}\right\|^{2}\right]\right)^{1 / 2} \\
& \leq C\left(h^{\nu_{1}}+h^{\kappa}+\frac{1}{\sqrt{\lambda_{n}^{r}}}+\frac{1}{\lambda_{n}}+\frac{1}{\lambda_{n+1}}\right)+\left(\frac{C_{f}}{\lambda_{1}}+\frac{C_{g}}{\sqrt{\lambda_{1}}}\right) \sup _{k \in \mathbb{N} t \geq k \tau}\left(\mathbb{E}\left[\left\|X_{t}^{-k \tau}-\hat{X}_{t}^{n,-k \tau}\right\|^{2}\right]\right)^{1 / 2}
\end{aligned}
$$

Because of $\frac{C_{f}}{\lambda_{1}}+\frac{C_{g}}{\sqrt{\lambda_{1}}}<1$ from Assumption 1.7 we can conclude the final assertion.

Note in Theorem4.2 one can take $\nu_{1}=r / 2$ to achieve the fastest convergence.
Corollary 4.1. Assume Assumption 1.1 to Assumption 1.7. Let $X_{t}^{*}$ be the random periodic solution of SEE (5) and $\hat{X}_{t}^{n, *}$ be the random period solution of the Galerkin numerical approximation with the stepsize $h$ satisfying (37). Consider approximating $\hat{X}^{n, *}$ through the sequence $\left\{\hat{X}^{n,-k \tau}(\xi)\right\}_{k}$ with $\xi \in L^{2}\left(\Omega, \mathcal{F}_{-k \tau}, \mathbb{P} ; \dot{H}^{r}\right)$ for $r \in(0,1)$. Then there exists a constant $C$, which depends on $A, f, g$ and $r$, such that

$$
\begin{equation*}
\sup _{t}\left(\mathbb{E}\left[\left\|X_{t}^{*}-\hat{X}_{t}^{n, *}\right\|^{2}\right]\right)^{1 / 2} \leq C\left(h^{\frac{r}{2} \wedge \kappa}+\frac{1}{\sqrt{\lambda_{n}^{r}}}\right) \tag{42}
\end{equation*}
$$

Corollary 4.1 implies that the best order of convergence can be achieved is $1 / 2-\epsilon$ for an arbitrarily small $\epsilon>0$ if $\kappa=1 / 2$. Moreover, as the mild form of $X_{t}^{*}$ is welled defined in $\bigcap_{r \in(0,1)} L^{2}\left(\Omega ; \dot{H}^{r}\right)$ shown in Theorem 3.1] and $\dot{H}^{r_{1}} \subset \dot{H}^{r_{2}}$ for $r_{1} \geq r_{2}$, it is not surprised to observe that the order of convergence would be higher if we adopt the approximation sequence with initial condition in $L^{2}\left(\Omega ; \dot{H}^{r}\right)$ under a higher value of $r$.
