# Affine subspaces of matrices with constant rank

#### Abstract

For every $m, n \in \mathbb{N}$ and every field $K$, let $M(m \times n, K)$ be the vector space of the $(m \times n)$-matrices over $K$ and let $S(n, K)$ be the vector space of the symmetric $(n \times n)$ matrices over $K$. We say that an affine subspace $S$ of $M(m \times n, K)$ or of $S(n, K)$ has constant rank $r$ if every matrix of $S$ has rank $r$. Define $$
\begin{gathered} \mathcal{A}^{K}(m \times n ; r)=\{S \mid S \text { affine subsapce of } M(m \times n, K) \text { of constant rank } r\} \\ \mathcal{A}_{s y m}^{K}(n ; r)=\{S \mid S \text { affine subsapce of } S(n, K) \text { of constant rank } r\} \\ a^{K}(m \times n ; r)=\max \left\{\operatorname{dim} S \mid S \in \mathcal{A}^{K}(m \times n ; r)\right\} \\ a_{\text {sym }}^{K}(n ; r)=\max \left\{\operatorname{dim} S \mid S \in \mathcal{A}_{s y m}^{K}(n, r)\right\} \end{gathered}
$$


In this paper we prove the following two formulas for $r \leq m \leq n$ :

$$
\begin{aligned}
a_{s y m}^{\mathbb{R}}(n, r) & =r(n-r)+\left[\frac{r^{2}}{4}\right], \\
a^{\mathbb{R}}(m \times n, r) & =r(n-r)+\frac{r(r-1)}{2} .
\end{aligned}
$$

## 1 Introduction

For every $m, n \in \mathbb{N}$ and every field $K$, let $M(m \times n, K)$ be the vector space of the $(m \times n)$-matrices over $K$ and let $S(n, K)$ be the vector space of the symmetric $(n \times n)$ matrices over $K$.
We say that an affine subspace $S$ of $M(m \times n, K)$ or of $S(n, K)$ has constant rank $r$ if every matrix of $S$ has rank $r$ and we say that a linear subspace $S$ of $M(m \times n, K)$ or of $S(n, K)$ has constant rank $r$ if every nonzero matrix of $S$ has rank $r$.
Define

$$
\begin{aligned}
\mathcal{A}^{K}(m \times n ; r) & =\{S \mid S \text { affine subsapce of } M(m \times n, K) \text { of constant rank } r\} \\
\mathcal{A}_{s y m}^{K}(n ; r) & =\{S \mid S \text { affine subsapce of } S(n, K) \text { of constant rank } r\}
\end{aligned}
$$

\mathcal{L}^{K}(m \times n ; r)=\{S \mid S \text { linear subsapce of } M(m \times n, K) \text { of constant rank } r\}
$$

\mathcal{L}_{s y m}^{K}(n ; r)=\{S \mid S \text { linear subsapce of } S(n, K) \text { of constant rank } r\}
$$

Let

$$
\begin{aligned}
a^{K}(m \times n ; r) & =\max \left\{\operatorname{dim} S \mid S \in \mathcal{A}^{K}(m \times n ; r)\right\} \\
a_{s y m}^{K}(n ; r) & =\max \left\{\operatorname{dim} S \mid S \in \mathcal{A}_{s y m}^{K}(n ; r)\right\} \\
a_{s y m}^{\mathbb{R}}(n ; p, \nu) & =\max \left\{\operatorname{dim} S \mid S \in \mathcal{A}_{s y m}^{\mathbb{R}}(n ; p, \nu)\right\} \\
l^{K}(m \times n ; r) & =\max \left\{\operatorname{dim} S \mid S \in \mathcal{L}^{K}(m \times n ; r)\right\} \\
l_{\text {sym }}^{K}(n ; r) & =\max \left\{\operatorname{dim} S \mid S \in \mathcal{L}_{\text {sym }}^{K}(n, r)\right\} .
\end{aligned}
$$

There is a wide literature on linear subspaces of constant rank. In particular we quote the following theorems:

Theorem 1. (Westwick, [6]) For $2 \leq r \leq m \leq n$, we have:

$$
n-r+1 \leq l^{\mathbb{C}}(m \times n ; r) \leq m+n-2 r+1
$$

Theorem 2. (Ilic-Landsberg, [5]) If $r$ is even and greater than or equal to 2 , then

$$
l_{\text {sym }}^{\mathbb{C}}(n ; r)=n-r+1
$$

In case $r$ odd, the following result holds, see [5], [2], [3]:
Theorem 3. If $r$ is odd, then

$$
l_{\text {sym }}^{\mathbb{C}}(n ; r)=1
$$

We mention also that, in [1], Flanders proved that, if $r \leq m \leq n$, a linear subspace of $M(m \times n, \mathbb{C})$ such that every of its elements has rank less than or equal to $r$ has dimension less than or equal to rn .
In this paper we investigate on the maximal dimension of affine subspaces of constant rank. We prove the following theorems.

Theorem 4. Let $n, r \in \mathbb{N}$ with $r \leq n$. Then

$$
a_{s y m}^{\mathbb{R}}(n, r)=r(n-r)+\left[\frac{r^{2}}{4}\right] .
$$

Theorem 5. Let $m, n, r \in \mathbb{N}$ with $r \leq m \leq n$. Then

$$
a^{\mathbb{R}}(m \times n, r)=r n-\frac{r(r+1)}{2} .
$$

## 2 Proof of Theorems 4 and 5

Notation 6. Let $n \in \mathbb{N}-\{0\}$ and $K$ be a field. We denote the $n \times n$ identity matrix over $K$ by $I_{n}^{K}$ (or by $I_{n}$ when the field is clear from the context).
For any $A \in M(m \times n, K)$ we denote the submatrix of $A$ given by the rows $i_{1}, \ldots, i_{k}$ and the columns $j_{1}, \ldots, j_{s}$ by $A_{\left(i_{1}, \ldots, i_{k}\right)}^{\left(j_{1}, \ldots, j_{s}\right)}$.

Lemma 7. Let $m, n \in \mathbb{N}-\{0\}$. Let $T \in M(m \times n, \mathbb{R})$. Then the matrix

$$
\left(\begin{array}{cc}
I_{m} & T \\
{ }_{T} & -I_{n}
\end{array}\right)
$$

is invertible.
Proof. Observe that

$$
\left(\begin{array}{cc}
I_{m} & T \\
{ }^{t} T & -I_{n}
\end{array}\right)^{2}=\left(\begin{array}{cc}
I_{m}+T^{t} T & 0 \\
0 & I_{n}+{ }^{t} T T
\end{array}\right) .
$$

Observe also that ${ }^{t} T T$ is positive semidefinite, so its eigenvalues are nonnegative, thus $I_{n}+{ }^{t} T T$ is invertible. Analogously $I_{m}+T^{t} T$ is invertible and we can conclude.

Lemma 8. Let $n \in \mathbb{N}-\{0\}$ and let $A \in S(n, \mathbb{R})$. Then there exists $s \in \mathbb{R}$ such that $\operatorname{det}\left(I_{n}+s A\right)=0$ if and only if $A \neq 0$.

Proof. $\Rightarrow$ This implication is obvious.
$\Leftarrow$ Suppose $A \neq 0$. Then $A$ has a nonzero eigenvalue $\lambda$. Let $s=-\frac{1}{\lambda}$. Then

$$
\operatorname{det}\left(I_{n}+s A\right)=s^{n} \operatorname{det}\left(\frac{1}{s} I_{n}+A\right)=s^{n} \operatorname{det}\left(A-\lambda I_{n}\right)=0 .
$$

Lemma 9. Let $r \in \mathbb{N}-\{0\}$. Let $A \in S(r, \mathbb{R})$ be invertible and $x \in \mathbb{R}^{r}-\{0\}$. Then the matrix

$$
\left(\begin{array}{cc}
A & x \\
{ }^{t} x & 0
\end{array}\right)
$$

is invertible.
Proof. Up to elementary row operations and the same elementary column operations on the first $r$ rows and the first $r$ columns, we can suppose that $A=I_{r}$. If $\binom{x}{0}$ were linear combination of the first $r$ columns of $\left(\begin{array}{cc}I & x \\ { }^{t} x & 0\end{array}\right)$, we would have that $0=$ $x_{1}^{2}+\ldots+x_{r}^{2}$, which is absurd.

Proof of Theorem \& 4 . In order to prove that $a_{s y m}^{\mathbb{R}}(n, r) \geq r(n-r)+\left[\frac{r^{2}}{4}\right]$, consider the following subspace of $S(n, \mathbb{R})$ :

$$
S:=\left\{\left.\left(\begin{array}{cc|c}
I_{\frac{I_{r}}{2}}{ }^{t} T & { }^{t} A \\
T & -I_{\frac{r}{2}} & \\
\hline A & 0
\end{array}\right) \right\rvert\, T \in M\left(\frac{r}{2} \times \frac{r}{2}, \mathbb{R}\right), A \in M((n-r) \times r, \mathbb{R})\right\}
$$

if $r$ is even,
$S:=\left\{\left.\left(\begin{array}{cc|c}\begin{array}{cc}I_{\frac{r+1}{2}} & { }^{t} T \\ T & I^{t} A \\ T & -I_{\frac{r-1}{2}}\end{array} \\ \hline A & 0\end{array}\right) \right\rvert\, T \in M\left(\frac{r-1}{2} \times \frac{r+1}{2}, \mathbb{R}\right), A \in M((n-r) \times r, \mathbb{R})\right\}$
if $r$ is odd. The dimension of $S$ is obviously $r(n-r)+\left[\frac{r^{2}}{4}\right]$. Moreover, suppose $r$ even; observe that the signature of $\left(\begin{array}{cc}I_{\frac{r}{2}} & { }^{t} T \\ T & -I_{\frac{r}{2}}\end{array}\right)$ is $\left(\frac{r}{2}, \frac{r}{2}\right)$, in fact the positivity of a symmetric bilinear form $b$ is the maximal dimension of subspace such that $b$ restricted to such subspace is positive definite and analogously the negativity; so, by elementary row and column operations, we can change every matrix $\left(\begin{array}{cc|c}I_{\frac{r}{2}} & { }^{t} T & { }^{t} A \\ T & -I_{\frac{5}{2}} & \\ \hline A & 0\end{array}\right)$ into a matrix of the kind

$$
\left(\begin{array}{cc|c}
I_{\frac{5}{2}} & 0 & { }^{t} A^{\prime} \\
0 & -I_{\frac{5}{2}} & \\
\hline A^{\prime} & 0
\end{array}\right)
$$

for some $A^{\prime} \in M((n-r) \times r, \mathbb{R})$ and by further elementary operations we can get the matrix

$$
\left(\begin{array}{cc|c}
I_{\frac{5}{2}} & 0 & 0 \\
0 & -I_{\frac{5}{2}} & 0 \\
\hline 0 & 0
\end{array}\right),
$$

so rk $\left(\begin{array}{cc|c}I_{\frac{r}{2}} & { }^{t} T & { }^{t} A \\ T & -I_{\frac{r}{2}} & \\ \hline A & 0\end{array}\right)=r$. Analogously if $r$ is odd. Thus $S \in \mathcal{A}_{s y m}^{\mathbb{R}}(n ; r)$ and hence
$a_{s y m}^{\mathbb{R}}(n, r) \geq r(n-r)+\left[\frac{r^{2}}{4}\right]$.
Now let us prove that $a_{s y m}^{\mathbb{R}}(n, r) \leq r(n-r)+\left[\frac{r^{2}}{4}\right]$.
Let $S \in \mathcal{A}_{s y m}^{\mathbb{R}}(n ; r)$. We can suppose $S=D+V$ where $V$ is a linear subspace of $S(n, \mathbb{R})$ and $D$ is the diagonal matrix whose diagonal is $(1, \ldots, 1,-1, \ldots,-1,0, \ldots, 0)$, where 1 is repeated $p$ times for some $p$ and -1 is repeated $r-p$ times.
Let $Z$ be the vector subspace of $M(n \times n, \mathbb{R})$ generated by the matrices $E_{i, j}+E_{j, i}$ for $i, j \in\{1, \ldots, p\}$ with $i \leq j$.

Let $U$ be the vector subspace of $M(n \times n, \mathbb{R})$ generated by the matrices $E_{i, j}+E_{j, i}$ for $i, j \in\{p+1, \ldots, r\}$ with $i \leq j$.
Let $W$ be the vector subspace of $M(n \times n, \mathbb{R})$ generated by the matrices $E_{i, j}+E_{j, i}$ for $i, j \in\{r+1, \ldots, n\}$ with $i \leq j$.
We want to prove that

$$
V \cap(Z+U+W)=\{0\}
$$

Let $A \in Z, B \in U, C \in W$ such that $A+B+C \in V$.

- If $C$ were nonzero, take $s \in \mathbb{R}$ such that $\operatorname{det}\left(I_{p}+s A\right) \neq 0$ and $\operatorname{det}\left(-I_{r-p}+s B\right) \neq$ 0 ; then $D+s(A+B+C)$ would have rank greater than $r$, so $S$ would not be of constant rank $r$, which is contrary to our assumption. So $C$ must be zero.
- If at least one of $A$ and $B$ were nonzero, take $s \in \mathbb{R}$ such that

$$
\operatorname{det}\left(I_{p}+s A\right)=0
$$

or

$$
\operatorname{det}\left(-I_{r-p}+s B\right)=0
$$

(there exists by Lemma 8); then $D+s(A+B+C)$, that is $D+s(A+B)$, has rank less than $r$, so $S$ would not be of constant rank $r$, which is contrary to our assumption. So also $A$ and $B$ must be zero.

So we have proved that $V \cap(Z+U+W)=\{0\}$. Hence

$$
\operatorname{dim}(S)=\operatorname{dim}(V) \leq \operatorname{dim}(S(n, \mathbb{R}))-\operatorname{dim}(Z+U+W)=p(r-p)+r(n-r)
$$

Finally, observe that $p(r-p)$ is less than or equal to $\frac{r^{2}}{4}$ if $r$ is even and less than or equal to $\frac{r^{2}-1}{4}$ if $r$ is odd. So

$$
\operatorname{dim}(S) \leq\left[\frac{r^{2}}{4}\right]+r(n-r)
$$

Observe that in a completely analogous way we can prove the following statement:
Theorem 10. Let $p, \nu, n \in \mathbb{N}$ such that $p+\nu \leq n$; then

$$
a_{s y m}^{\mathbb{R}}(n ; p, \nu)=p \nu+(p+\nu)(n-p-\nu)
$$

Proof of Theorem 5. In order to prove that $a^{\mathbb{R}}(m \times n, r)$ is greater than or equal to $r(n-r)+\frac{r(r-1)}{2}$, i.e. greater than or equal to $r n-\frac{r(r+1)}{2}$, consider the following affine subspace of $M(m \times n, \mathbb{R})$ :

$$
S=\left\{A \in M(m \times n, \mathbb{R}) \mid A_{i, i}=1 \forall i=1, \ldots, r, A_{i, j}=0 \forall(i, j) \text { with } i>j \text { or } i>r\right\}
$$

The dimension of $S$ is clearly $r(n-r)+\frac{r(r-1)}{2}$ and $S \in \mathcal{A}^{\mathbb{R}}(m \times n ; r)$, so we get our inequality.

Now let us prove the other inequality. Let $S \in \mathcal{A}^{\mathbb{R}}(m \times n ; r)$. We can easily suppose that

$$
S=J+V
$$

where $V$ is a vector subspace of $M(m \times n, \mathbb{R})$ and $J$ is the matrix such that $J_{i, i}=1$ for $i=1, \ldots, r$ and the other entries are equal to zero.
Consider now the following subspaces of $M(m \times n, \mathbb{R})$ :

$$
\begin{gathered}
Z=\left\{A \in M(m \times n, \mathbb{R}) \mid A_{i, j}=0 \forall(i, j) \text { such that } i \neq j \text { and }(i \leq r \text { or } j \leq r)\right\} \\
T=\left\{A \in M(m \times n, \mathbb{R}) \left\lvert\, \begin{array}{l}
A_{i, j}=0 \forall(i, j) \text { such that } i=j \text { or }(i>r \text { and } j>r) \text { or } j>m ; \\
A_{i, j}=A_{j, i} \forall(i, j) \text { such that } j \leq m
\end{array}\right.\right\} .
\end{gathered}
$$

We want to prove that

$$
V \cap(Z+T)=\{0\} .
$$

Let $\zeta \in Z$ and $\tau \in T$ such that $\zeta+\tau \in V$; we want to show that $\zeta=\tau=0$.
We denote $\zeta_{(r+1, \ldots, m)}^{(r+1, \ldots, n)}$ by $\zeta^{\prime}$ and $\tau_{(r+1, \ldots, m)}^{(1, \ldots, r)}$ by $\tau^{\prime}$.
We consider four cases:
Case 1: $\tau^{\prime}=0, \zeta^{\prime}=0$.
Since $\tau+\zeta \in V$ we have that $J+s(\tau+\zeta)$ must have rank $r$ for every $s \in \mathbb{R}$; observe that $(\tau+\zeta)_{i, j}=0 \forall(i, j)$ with $i>r$ or $j>r$ (by the definition of $Z$ and $T$ and the fact that $\tau^{\prime}=0$ and $\zeta^{\prime}=0$ ) and that $(\tau+\zeta)_{(1, \ldots, r)}^{(1, \ldots, r)}$ is symmetric; hence, by Lemma $\mathbb{8}$, we can conclude that $(\tau+\zeta)_{(1, \ldots, r)}^{(1, \ldots, r)}=0$ and then that $\tau+\zeta=0$.
Case 2: $\tau^{\prime}=0, \zeta^{\prime} \neq 0$.
 $l \in\{r+1, \ldots, n\}$ such that $\zeta_{h, l} \neq 0$. Then, obviously, the matrix $(J+s(\tau+\zeta))_{(1, \ldots, r, h)}^{(1, \ldots, r)}$ is invertible, , which is impossible since $J+s(\tau+\zeta) \in S \in \mathcal{A}^{\mathbb{R}}(m \times n ; r)$.
Case 3: there exists $h \in\{r+1, \ldots, m\}$ such that $\tau^{(h)} \neq 0$ and $\zeta_{(h, h)}=0$.
Take $s \in \mathbb{R}-\{0\}$ such that $\operatorname{det}\left(I_{r}+s(\tau+\zeta)_{(1, \ldots, r)}^{(1, \ldots, r)}\right)$ is nonzero. Then, by Lemma 9 , the matrix $(J+s(\tau+\zeta))_{(1, \ldots, r, h)}^{(1, \ldots, r)}$ is invertible, which is impossible since $J+s(\tau+\zeta) \in$ $S \in \mathcal{A}^{\mathbb{R}}(m \times n ; r)$.
Case 4: there exists $h \in\{r+1, \ldots, m\}$ such that $\tau^{(h)} \neq 0$ and $\zeta_{(h, h)} \neq 0$.
For $s$ nonzero and sufficiently small, we have that $\operatorname{det}\left((J+s(\tau+\zeta))_{(1, \ldots, r, h)}^{(1, \ldots r, h)}\right)$ is nonzero (in fact $\zeta_{(1, \ldots, r, h)}^{(1, \ldots r, h)}$ is diagonal and $\zeta_{(h, h)}$ is nonzero, so $\operatorname{det}\left(\left(J+s(\tau+\zeta)_{(1, \ldots, r, h)}^{(1, \ldots r, h)}\right.\right.$ is a polynomial in $s$ with the term of degree 0 equal to 0 and the coefficient of the term of degree 1 equal to $\left.\zeta_{h, h}\right)$; but this is impossible since $J+s(\tau+\zeta) \in S \in \mathcal{A}^{\mathbb{R}}(m \times n ; r)$. Observe that the four cases we have considered are the only possible ones because when $\tau^{\prime}$ is nonzero we have one among Case 3 and Case 4 . Thus we have proved that $V \cap(Z+T)=\{0\}$. Hence we have:

$$
\begin{aligned}
\operatorname{dim}(S) & =\operatorname{dim}(V) \leq \operatorname{dim} M(m \times n, \mathbb{R})-\operatorname{dim}(Z+T)= \\
& =m n-\operatorname{dim}(Z)-\operatorname{dim}(T)=r(n-r)+\frac{r(r-1)}{2}
\end{aligned}
$$

and we can conclude.

Remark 11. Let $F\left[x_{1}, \ldots, x_{k}\right]$ denote the set of the polynomials in the indeterminates $x_{1}, \ldots, x_{k}$ with coefficients on a field $F$. A matrix over $F\left[x_{1}, \ldots, x_{k}\right]$ is said an Affine Column Indipendent matrix, or ACI-matrix, if its entries are polynomials of degree at most one and no indeterminate appears in two different columns. A completion of an ACI-matrix is an assignment of values in $F$ to the indeterminates $x_{1}, \ldots, x_{k}$. In [4] Huang and Zhan proved that all the completions of a $m \times n$ ACI-matrix over a field $F$ with $|F| \geq \max \{m, n+1\}$ have rank $r$ if and only if there exists a nonsingular constant $m \times m$ matrix $T$ and a permutation $n \times n$ matrix $Q$ such that $T A Q$ is equal to a matrix of the kind

$$
\left(\begin{array}{ccc}
B & * & * \\
0 & 0 & * \\
0 & 0 & C
\end{array}\right)
$$

for some ACI-matrices $B$ and $C$ which are square upper triangular with nonzero constant diagonal entries and whose orders sum to $r$. Observe that the affine subspace given by the matrices $\left(\begin{array}{ccc}B & * & * \\ 0 & 0 & * \\ 0 & 0 & C\end{array}\right)$ with $B$ and $C$ square upper triangular ACI-matrices with nonzero constant diagonal entries and whose orders are respectively $k$ and $r-k$ is equal to the following number:

$$
\begin{aligned}
& \frac{k(k-1)}{2}+\frac{(r-k)(r-k-1)}{2}+k(n-k)+(r-k)(m-k-r+k)= \\
& =-\frac{r^{2}}{2}-\frac{r}{2}+k(n-m)+r m
\end{aligned}
$$

which obviously attains the maximum, i.e. $r n-\frac{r^{2}+r}{2}$, when $k=r$. Let $M$ be a matrix over $F\left[x_{1}, \ldots, x_{k}\right]$ with the degree of every entry at most one. Let $\tilde{M}$ be the ACImatrix obtained from $M$ in the following way: if an indeterminate $x_{i}$ appears in more than one column, say in the columns $j_{1}, \ldots, j_{s}$, replace it with new indeterminates $x_{i}^{j_{1}}, \ldots, x_{i}^{j_{s}}$.
Observe that it is not possible to deduce Theorem 5 from this result, because if we have an affine subspace $S$ of constant rank and we consider the affine subspace $\tilde{S}$ given by the "ACImade" matrices of $S$, that is, given by the matrices $\tilde{M}$ for $M \in S$, we have that it is not true in general that $\tilde{S}$ is of constant rank as the following example shows:

$$
S=\left\{\left.\left(\begin{array}{cc}
1 & s \\
s & -1
\end{array}\right) \right\rvert\, s \in \mathbb{R}\right\} .
$$
