# Sequential Transmission Over Binary Asymmetric Channels With Feedback

#### Abstract

In this paper, we consider the problem of variablelength coding over the class of memoryless binary asymmetric channels (BACs) with noiseless feedback, including the binary symmetric channel (BSC) as a special case. In 2012, Naghshvar et al. introduced an encoding scheme, which we refer to as the small-enough-difference (SED) encoder, which asymptotically achieves both capacity and Burnashev's optimal error exponent for symmetric binary-input channels. Building on the work of Naghshvar et al., this paper extends the SED encoding scheme to the class of BACs and develops a non-asymptotic upper bound on the average blocklength that is shown to achieve both capacity and the optimal error exponent. For the specific case of the BSC, we develop an additional non-asymptotic bound using a two-phase analysis that leverages both a submartingale synthesis and a Markov chain time of first passage analysis. For the BSC with capacity $1 / 2$, both new achievability bounds exceed the achievability bound of Polyanskiy et al. for a system limited to stop-feedback codes.


Index Terms-Binary asymmetric channels, variable-length coding, Burnashev's optimal error exponent, submartingales.

## I. Introduction

FEEDBACK does not increase the capacity of memoryless channels [2], but it can significantly reduce the complexity of communication and the probability of error, provided that variable-length feedback (VLF) codes are allowed. In the context of a discrete memoryless channel (DMC) with noiseless feedback, Burnashev [3] proposed a pioneering twophase transmission scheme that obtains the exact optimal error exponent for all rates below capacity. The first phase is called the communication phase, during which the transmitter seeks to increase the receiver's posterior probability for the transmitted message. The system transitions from the communication phase to the confirmation phase when the largest posterior at the receiver exceeds a certain threshold $\zeta$. During the confirmation phase, two most distinguishable input symbols

[^0]are used: one for the message with the largest posterior, and the other for the rest of messages. The confirmation phase continues until either the transmission terminates or the system returns to the communication phase. This two-phase encoder allows Burnashev to obtain an upper bound on the average blocklength that coincides asymptotically with the converse bound, thus producing the optimal error exponent. However, Burnashev did not provide an explicit non-asymptotic bound on the average blocklength for the DMC.

For the binary symmetric channel (BSC) with noiseless feedback, Horstein [4] developed a simple, one-phase scheme that maps each message to a subinterval in $[0,1]$. The transmitter sends a 0 if the subinterval of the true message lies entirely beneath the median and a 1 if it lies entirely above the median. If the subinterval includes the median point, which will eventually happen as the subinterval of the highest posterior grows, then randomized encoding is employed. Horstein did not provide a rigorous proof to show that his scheme achieves capacity. In [5], Burnashev and Zigangirov showed that Horstein's scheme achieves the capacity of the BSC in the fixed blocklength setting. In [6], Shayevitz and Feder generalized Horstein's scheme to the concept of posterior matching, thus validating the capacityachieving property of Horstein's scheme in the variable-length setting. Since Horstein's work, several authors, e.g., [7]-[10], have constructed coding schemes for the BSC with noiseless feedback under various assumptions in order to attain capacity or Burnashev's optimal error exponent.

Error exponent analysis of variable-length coding typically focuses on asymptotically long average blocklength at a fixed rate. In contrast, Polyanskiy et al. [11] showed that in the non-asymptotic regime, variable-length coding with noiseless feedback can provide a significant advantage in achievable rate over fixed-length codes. Polyanskiy et al. considered a simple stop-feedback code that only uses feedback to inform the encoder of when to terminate of transmission. A compelling example of this advantage can be seen for the BSC with capacity $1 / 2$ and target error probability $10^{-3}$. With variablelength coding and stop feedback, the average blocklength required to achieve $90 \%$ of capacity is less than 200, compared to at least 3100 for the best fixed-blocklength code with noiseless feedback.

In the non-asymptotic regime, Naghshvar et al. asked the question of whether having two separate phases of operations and randomized encoding are necessary to achieve Burnashev's optimal error exponent. In [12], they first presented a deterministic, one-phase coding scheme that achieves the optimal error exponent for any symmetric binary-input chan-
nels (including the BSC) with full, noiseless feedback. The most appealing feature in their scheme is that at each time instant, the encoder only seeks a two-way partitioning of the message set such that the probability difference of the two subsets is "small enough" (see Sec. IV in [12]), and this is sufficient for their scheme to achieve both capacity and the optimal error exponent. Since the authors did not provide a name for their scheme, here we term their scheme as the small-enough-difference (SED) encoder ${ }^{11}$ In a subsequent work [13], Naghshvar et al. applied the extrinsic Jensen-Shannon (EJS) divergence and submartingale synthesis technique to develop a non-asymptotic upper bound on the average blocklength for the SED encoder over symmetric binary-input channels with noiseless feedback. Recently, Guo et al. [14] developed an instantaneous SED code for the symmetric binary-input channels with feedback for real-time communication.

While Naghshvar et al. obtained a non-asymptotic upper bound on average blocklength for their SED encoder, the resulting achievability bound falls beneath Polyanskiy's achievability bound for a system that only employs stopfeedback codes. In general, a system, such as the SED encoder, that employs full, noiseless, instantaneous feedback should achieve a rate much better than that of a stop-feedback code. Thus, there is an opportunity to develop tighter lower bounds on the achievable rate of the SED encoder. Furthermore, the SED encoder has not yet been extended to a general binaryinput channel with feedback, let alone a general multi-input DMC with feedback.

As a primary contribution, this paper extends Naghshvar et al.'s SED encoder to the class of binary asymmetric channels (BACs) with feedback, including the BSC as a special case, and develops non-asymptotic upper bounds on average blocklength that are close to the actual performance of SED encoders. Unlike Naghshvar et al.'s one-phase SED encoder, our SED encoder for a general BAC is a deterministic, twophase encoder that performs a two-way partitioning of the message set such that the weighted probability difference is small enough in the communication phase. In the confirmation phase, the encoder assigns the most distinguishable symbol exclusively to the most likely message. In particular, for the BSC with feedback, we develop a refined non-asymptotic upper bound on the average blocklength. Simulations demonstrate that both associated achievability bounds on rate exceed the stop-feedback achievability bound of Polyanskiy et al. for the BSC with capacity $1 / 2$, which is expected since a system with full, noiseless feedback should perform better than one that is limited to stop feedback.

In our analysis, the technique for obtaining the bound for a general BAC involves a submartingale synthesis with optimal parameters. For the specific case of the BSC, the confirmation phase can be modeled as a Markov chain with possible fallbacks to the communication phase. This facilitates a decomposition of the random process concerning the transmitted message into two components: a submartingale describing the first communication phase and a generalized Markov chain that describes the subsequent behavior (see Section V-F). decomposition allows a separate upper bound to be computed for each of the two components. The upper bound for the first component is obtained using a surrogate submartingale construction and a variant of Doob's optional stopping theorem. The upper bound for the second component is obtained using time of first-passage analysis on the generalized Markov chain. Finally, the sum of the two upper bounds yields an upper bound on the overall average blocklength that turns out to be tighter than the bound developed using purely submartingale synthesis when the crossover probability is small.

The remainder of this paper is organized as follows. In Section II, we formulate the problem of variable-length coding over a BAC with noiseless feedback and review Naghshvar et al.'s scheme for symmetric binary-input channels as well as some previous results. In Section III, we present the SED encoder for a general BAC with noiseless feedback and a non-asymptotic upper bound on the corresponding average blocklength. In the case of the BSC with feedback, Section IV presents a new upper bound for the SED encoder developed by leveraging the submartingale synthesis and time of first passage analysis on Markov chains. Section $V$ contains the proofs of the main results. In Section VI we compare our bounds with the simulated performance of the SED encoder as well as some previously known results. In Section VII we show that the proposed SED encoder achieves both capacity and the optimal error exponent of the BAC. Section VIII concludes the paper.

## II. Preliminaries

## A. Notation and Definitions

Throughout the paper, $\log (\cdot), \ln (\cdot)$ denote the base- 2 and the natural logarithms, respectively. $h(p)=-p \log (p)-(1-$ $p) \log (1-p), p \in[0,1]$, denotes the binary entropy function. Let $P_{Y}, Q_{Y}$ be two distributions over a finite alphabet $\mathcal{Y}$, the Kullback-Leibler (KL) divergence between $P_{Y}$ and $Q_{Y}$ is defined as $D\left(P_{Y} \| Q_{Y}\right) \triangleq \sum_{y \in \mathcal{Y}} P_{Y}(y) \log \frac{P_{Y}(y)}{Q_{Y}(y)}$ with the convention that $0 \log \frac{0}{a}=0$ and $b \log \frac{b}{0}=\infty$ for $a, b \in[0,1]$ with $b \neq 0$. Let $[x]^{+}=\max \{0, x\}$. We denote the collection of all subsets of $\mathcal{X}$ by $2^{\mathcal{X}}$.

## B. Problem Setup

Consider the problem of variable-length coding over a $\operatorname{BAC}\left(p_{0}, p_{1}\right)$ with noiseless feedback, as depicted in Fig. (1) The BAC consists of binary input and output alphabets, i.e., $\mathcal{X}=\mathcal{Y}=\{0,1\}$, and two crossover probabilities, $p_{0} \triangleq P_{Y \mid X}(1 \mid 0)$ and $p_{1} \triangleq P_{Y \mid X}(0 \mid 1)$. As noted in [15], it suffices to restrict our attention to the regularized case where $p_{0} \in(0,1 / 2)$ and $p_{0} \leq p_{1} \leq 1-p_{0}$, as any other case can be transformed into this case by swapping either the input
or output label. For ease of reference, we say a $\operatorname{BAC}\left(p_{0}, p_{1}\right)$ is regularized if the two crossover probabilities satisfy these conditions. If $p_{0}=p_{1}=p \in(0,1 / 2)$, we simply write $\mathrm{BSC}(p)$.

Let $C$ be the capacity of the $\operatorname{BAC}\left(p_{0}, p_{1}\right)$ and let $\left(\pi_{0}^{*}, \pi_{1}^{*}\right)$ be the corresponding capacity-achieving input distribution. The following results will be useful in our proofs.

Fact 1. Consider a $\operatorname{BAC}\left(p_{0}, p_{1}\right)$ with capacity achieving input distribution $\left(\pi_{0}^{*}, \pi_{1}^{*}\right)$. Then,

where $z=2^{\frac{h\left(p_{0}\right)-h\left(p_{1}\right)}{1-p_{0}-p_{1}}}$. Furthermore, if $p_{0} \in(0,1 / 2)$ and $p_{0} \leq p_{1} \leq 1-p_{0}$, then $0<\pi_{1}^{*} \leq \pi_{0}^{*}<1$.

The proof of Fact 1 is given in Appendix $\square$
Fact 2 (Theorem 4.5.1, [16]). Consider a DMC with capacityachieving input distribution $\left(\pi_{0}^{*}, \pi_{1}^{*}, \ldots, \pi_{|\mathcal{X}|-1}^{*}\right)$. For each $k \in\{0,1, \ldots,|\mathcal{X}|-1\}$, if $\pi_{k}^{*}>0$, then,

Let $C_{1}$ be the maximal KL divergence between two conditional output distributions, i.e.,

We also denote

Fact 3. For a regularized $B A C\left(p_{0}, p_{1}\right)$,

The proof of Fact 3 is given in Appendix $\square$
For a regularized BAC, it always holds that $0<C \leq C_{1} \leq$ $C_{2}<\infty$. Later, we will see how these quantities are used in our result.

Let $\theta$ be the transmitted message uniformly drawn from the message set $\Omega=\{1,2, \ldots, M\}$. The total transmission time (or the number of channel uses, or blocklength) $\tau$ is a random variable that is governed by a stopping rule that is a function of the observed channel outputs. Thanks to the full, noiseless feedback channel, the transmitter is also informed of the channel outputs and thus the stopping time.

The transmitter wishes to communicate $\theta$ to the receiver. To this end, it produces channel inputs $X_{t}$ for $t=1,2, \ldots, \tau$ as a function of $\theta$ and past channel outputs $Y^{t-1}=$
$\left(Y_{1}, Y_{2}, \ldots, Y_{t-1}\right)$, available to the transmitter through the noiseless feedback channel. Namely,

for some encoding function $e_{t}: \Omega \times \mathcal{Y}^{t-1} \rightarrow \mathcal{X}$.
After observing $\tau$ channel outputs $Y_{1}, Y_{2}, \ldots, Y_{\tau}$, the receiver makes a final estimate $\hat{\theta}$ of the transmitted message as a function of $Y^{\tau}$, i.e.,

for some decoding function $d: \mathcal{Y}^{\tau} \rightarrow \Omega$.
The probability of error of the transmission scheme is given by

For a fixed DMC (i.e., not necessarily restricted to BAC) and a given $\epsilon \in(0,1 / 2)$, the general goal is to find encoding and decoding rules described in (9), (10), and a stopping time $\tau$ such that $P_{e} \leq \epsilon$ and $\mathbb{E}[\tau]$ is minimized. Let $\mathbb{E}\left[\tau_{\epsilon}^{*}\right]$ be the minimum average blocklength. The achievable rate is defined as

In [3], Burnashev, for the first time, derived the reliability function $E(R)$ of variable-length coding over a fixed DMC for all rates $R<C$ :

## C. The SED Encoder of Naghshvar et al.

In [12], Naghshvar et al. introduced a novel SED encoder for symmetric binary-input channels, which we now briefly describe as follows.

Let $\rho_{i}(t) \triangleq \mathscr{P}\left\{\theta=i \mid Y^{t}\right\}, t \geq 0$, be the posterior probability of $\theta=i$ given $Y^{t}$. Since $\theta$ is uniformly distributed before transmission, $\rho_{i}(0)=1 / M$ for all $i \in \Omega$. As noted in [13], a sufficient statistic for estimating $\theta$ is the belief state vector given by

According to the Bayes' rule, upon receiving $Y_{t}=y_{t}$, each $\rho_{i}(t), i \in \Omega$, can be updated from $\boldsymbol{\rho}(t-1)$ by

Thanks to the noiseless feedback, the transmitter will be informed of $y_{t}$ at time instant $t+1$ and thus can calculate the same $\boldsymbol{\rho}(t)$ before generating $X_{t+1}$.

The SED encoder for BSC with feedback: upon obtaining $\boldsymbol{\rho}(t)$ at time $t+1$, the encoder partitions the message set $\Omega$ into two subsets $S_{0}(t)$ and $S_{1}(t)$ such that

where $\pi_{x}(t) \triangleq \sum_{i \in S_{x}(t)} \rho_{i}(t), x \in\{0,1\}$. Once $S_{0}(t)$ and $S_{1}(t)$ are obtained, $X_{t+1}=0$ if $\theta \in S_{0}(t)$ and $X_{t+1}=1$ otherwise.

In the appendix of [12], the authors demonstrated that (16) is sufficient to guarantee the achievability of both capacity and the optimal error exponent of the channel.

## D. The Decoder of Naghshvar et al.

In [12] and [13], Naghshvar et al. considered the following possibly suboptimal stopping rule and decoder:

Clearly, with the above scheme, the probability of error meets the desired constraint, i.e.,

Let

\end{equation*}

be the log-likelihood ratio of $\theta=i$ given $Y^{t}$. Equivalently, the stopping time in 17) can be written as

In this paper, we consider the same possibly suboptimal stopping rule and decoder as described in (17) and (18). Thus, the average blocklength $\mathbb{E}[\tau]$ only depends on the encoding scheme.

## E. Previous Results on Average Blocklength of VLF Codes

In [13], Naghshvar et al. used the EJS divergence and submartingale synthesis technique to obtain a non-asymptotic upper bound on the average blocklength of the VLF code generated by their SED encoder for the symmetric binaryinput channel with feedback.
Theorem 1 (Remark 7, [13|). For a given $\epsilon \in(0,1 / 2)$, the average blocklength of the VLF code generated by Naghshvar et al.'s SED encoder (16) and decoding rule 17) 18) for symmetric binary-input channels satisfies

The technique that underlies this result is a two-stage submartingale resulted from the SED encoding rule.

Lemma 1 ( [12]). Consider the SED encoder described in (16) for the $\operatorname{BSC}(p), p \in(0,1 / 2)$, with feedback. If $\theta=i \in \Omega$, then $\left\{U_{i}(t)\right\}_{t=0}^{\infty}$ forms a submartingale with respect to the filtration $\mathcal{F}_{t}=\sigma\left\{Y^{t}\right\}$ satisfying

The proof of Lemma 1 can be found in [12]. We remark that the key step that links the SED encoder to the two-stage submartingale is the introduction and analysis of extrinsic
probabilities. This relation will be fully exploited in the proof of Lemma 3 (see Section V-A. The next step is to synthesize the two-stage submartingale in Lemma 1 into a single submartingale and then apply Doob's optional stopping theorem. In [13], with a sophisticated submartingale synthesis, Naghshvar et al. obtained the following result.
Lemma 2 (Lemma 8, [13]). Assume that the sequence $\left\{\xi_{t}\right\}_{t=0}^{\infty}$ forms a submartingale with respect to a filtration $\mathcal{F}_{t}$. Furthermore, assume there exist positive constants $K_{1}, K_{2}$ and $K_{3}$ such that

Consider the stopping time $v=\min \left\{t: \xi_{t} \geq B\right\}, B>0$. Then, we have the inequality,

Observe that if $U_{i}(t)$ in Lemma 1 plays the role of $\xi_{t}$ in Lemma 2 the sequence $\left\{U_{i}(t)\right\}_{t=0}^{\infty}$ meets the conditions in Lemma 2 by setting $K_{1}=C, K_{2}=C_{1}$ and $K_{3}=C_{2}$. Thus, by setting $B=\log \frac{1-\epsilon}{\epsilon}$, the stopping rule in Lemma 2 coincides with that in 17) and we have the following corollary.
Corollary 1. For a given $\epsilon \in(0,1 / 2)$, the average blocklength of the VLF code generated by the SED encoder for $\operatorname{BSC}(p)$, $p \in(0,1 / 2)$, with feedback satisfies

\begin{equation*}
\mathbb{E}[\tau] \leq \frac{\log M}{C}+\frac{\log \frac{1-\epsilon}{\epsilon}}{C_{1}}+\frac{3 C_{2}^{2}}{C C_{1}} \tag{26}
\end{equation*}
$$

Remark 1. In [13], Naghshvar et al. proved a two-stage submartingale similar to Lemma 1 by considering the average log-likelihood ratio $\tilde{U}(t)$ of the belief state $\boldsymbol{\rho}(t)$ rather than that of the transmitted message (see Appendix II in [13]). They showed that the average drift of $U(t)$ is characterized by the EJS divergence, which can be lower bounded by $C$ or $\tilde{\rho} C_{1}$ depending on the sign of $\tilde{U}(t)$, where $\tilde{\rho} \in(0,1)$ is some constant. Combining their two-stage submartingale with Lemma 2 they obtained Theorem 1 However, a direct comparison of the third terms in (22) and 26) immediately reveals that 26 is a significantly better upper bound on average blocklength.

Next, we recall Polyanskiy's achievability result for an arbitrary DMC with feedback that utilizes a stop-feedback code.
Theorem 2 (Theorem 3, [11]). Consider a DMC with transition probability $P(y \mid x), x \in \mathcal{X}, y \in \mathcal{Y}$. Fix a scalar $\gamma>0$. Let $X^{n}$ and $\bar{X}^{n}$ be independent copies from the same process and let $Y^{n}$ be the output of the DMC when $X^{n}$ is the input. Define a sequence of information density functions

Then, for any M, there exists a VLF code satisfying

Finally, we recall Polyanskiy's converse bound for a VLF code with a non-vanishing error probability $\epsilon$.

Theorem 3 (Theorems 4 and 6, [11]). Consider a DMC with $0<C \leq C_{1}<\infty$. Then any VLF code with $M$ codewords and target error probability $\epsilon$ satisfying $0<\epsilon \leq 1-1 / M$ satisfies both

## III. Achievable Rates for BAC With Feedback

In this section, we introduce the SED encoder for a regularized $\operatorname{BAC}\left(p_{0}, p_{1}\right)$ with noiseless feedback and develop a non-asymptotic upper bound on its average blocklength. Equivalently, this yields a lower bound on the achievable rate of the regularized BAC with feedback.

For a general regularized $\operatorname{BAC}\left(p_{0}, p_{1}\right)$, Naghshvar et al.'s SED encoder no longer applies. As an extension, we propose the following deterministic, two-phase SED encoder for a regularized $\mathrm{BAC}\left(p_{0}, p_{1}\right)$ with feedback.

The SED encoder for regularized $\operatorname{BAC}\left(p_{0}, p_{1}\right)$ with feedback: upon obtaining $\boldsymbol{\rho}(t)$ at time $t+1$, let $\hat{i}=$ $\arg \max _{j \in \Omega} \rho_{j}(t)$. If $\rho_{\hat{i}}(t)<\pi_{1}^{*}$, the encoder partitions the message set $\Omega$ into two subsets $S_{0}(t)$ and $S_{1}(t)$ such that

$$
\begin{equation*}
-\min _{i \in S_{1}(t)} \rho_{i}(t) \leq \frac{\pi_{1}^{*}}{\pi_{0}^{*}} \pi_{0}(t)-\pi_{1}(t) \leq \frac{\pi_{1}^{*}}{\pi_{0}^{*}} \min _{i \in S_{0}(t)} \rho_{i}(t) \tag{36}
\end{equation*}
$$

If $\rho_{\hat{i}}(t) \geq \pi_{1}^{*}$, the encoder exclusively assigns $S_{1}(t)=\{\hat{i}\}$ and $S_{0}(t)=\Omega \backslash\{\hat{i}\}$. Once $S_{0}(t)$ and $S_{1}(t)$ are obtained, $X_{t+1}=0$ if $\theta \in S_{0}(t)$ and $X_{t+1}=1$ otherwise.

Remark 2. First, we see that in the second case where $\rho_{\hat{i}}(t) \geq$ $\pi_{1}^{*}$, the partition $S_{1}(t)=\{\hat{i}\}, S_{0}(t)=\Omega \backslash\{\hat{i}\}$ still meets 36. Second, if $p_{0}=p_{1}$, then $\pi_{0}^{*}=\pi_{1}^{*}=1 / 2$ and (36) becomes

$$

-\min _{i \in S_{1}(t)} \rho_{i}(t) \leq \pi_{0}(t)-\pi_{1}(t) \leq \min _{i \in S_{0}(t)} \rho_{i}(t) \tag{37}
\end{equation*}

Clearly, this is a relaxation of (16) if the maximum posterior probability $\rho_{\hat{i}}(t)<1 / 2$. If $\rho_{\hat{i}}(t) \geq 1 / 2$, (16) is met if and only if $S_{0}(t)=\{\hat{i}\}$ and $S_{1}(t)=\Omega \backslash\{\hat{i}\}$. In [12], Naghshvar et al. showed that this assignment will yield 23b. However,

following their analysis, one can show that $S_{1}(t)=\{\hat{i}\}$ and $S_{0}(t)=\Omega \backslash\{\hat{i}\}$ also yield 23b. Therefore, our SED encoder serves as a generalization of Naghshvar et al.'s encoder.

The motivation behind our SED encoder is that Lemma 1 now holds for the regularized BAC with feedback. For the sake of completeness, we state this result in a separate lemma.

Lemma 3. Consider the SED encoder for a regularized $B A C\left(p_{0}, p_{1}\right)$ with feedback. If $\theta=i \in \Omega$, then $\left\{U_{i}(t)\right\}_{t=0}^{\infty}$ forms a submartingale with respect to the filtration $\mathcal{F}_{t}=$ $\sigma\left\{Y^{t}\right\}$ satisfying

& \mathbb{E}\left[U_{i}(t+1) \mid \mathcal{F}_{t}, \theta=i\right] \geq U_{i}(t)+C, \quad \text { if } U_{i}(t)<0  \tag{38a}\\
& \mathbb{E}\left[U_{i}(t+1) \mid \mathcal{F}_{t}, \theta=i\right]=U_{i}(t)+C_{1}, \quad \text { if } U_{i}(t) \geq 0  \tag{38b}\\
& \quad\left|U_{i}(t+1)-U_{i}(t)\right| \leq C_{2} \tag{38c}
\end{align*}

Proof: The proof fully exploits the properties of the extrinsic probabilities. See Section V-A for more details.

Since Lemma 2 is developed from a poor choice of parameters, here we perform a submartingale synthesis with optimized parameters to obtain the best possible upper bound on $\mathbb{E}[\tau]$ for a regularized BAC with feedback.

Theorem 4. For a given $\epsilon \in(0,1 / 2)$, the average blocklength of the VLF code generated by the SED encoder for a regularized BAC $\left(p_{0}, p_{1}\right)$ with feedback satisfies

\begin{equation*}
\mathbb{E}[\tau]<\frac{\log M}{C}+\frac{\log \frac{1-\epsilon}{\epsilon}+C_{2}}{C_{1}}+C_{2}\left(\frac{1}{C}-\frac{1}{C_{1}}\right) \frac{1-\frac{\epsilon}{1-\epsilon} 2^{-C_{2}}}{1-2^{-C_{2}}} \tag{39}
\end{equation*}
$$

Proof: See Section V-B
In the following, we show that the condition required by our SED encoder is always attainable at each time $t$. This is accomplished by solving a particular minimization problem.

Theorem 5. For a regularized BAC with capacity-achieving input distribution $\left(\pi_{0}^{*}, \pi_{1}^{*}\right)$, let $\lambda \triangleq \pi_{1}^{*} / \pi_{0}^{*} \in(0,1]$. For a given belief state vector $\boldsymbol{\rho}=\left[\rho_{1}, \rho_{2}, \ldots, \rho_{M}\right]$ satisfying $\max _{i \in \Omega} \rho_{i}<\pi_{1}^{*}$, define the following objective function $f: 2^{\Omega} \rightarrow \mathbb{R}$ :

f(S) \triangleq & \lambda\left(\pi_{1}(S)-\lambda \pi_{0}(S)\right) 1_{\left\{\pi_{1}(S) \geq \lambda \pi_{0}(S)\right\}} \\
& +\left(\lambda \pi_{0}(S)-\pi_{1}(S)\right) 1_{\left\{\pi_{1}(S)<\lambda \pi_{0}(S)\right\}} \tag{40}
\end{align*}
$$

where $\pi_{0}(S) \triangleq \sum_{i \in S} \rho_{i}$ and $\pi_{1}(S) \triangleq \sum_{i \in \Omega \backslash S} \rho_{i}$. Assume $S_{0}^{*} \subseteq \Omega$ minimizes (40). Then, the partition $\left(S_{0}^{*}, \Omega \backslash S_{0}^{*}\right)$ satisfies (36).

## Proof: See Section V-C.

Theorem 5 implies that when the maximum posterior of $\boldsymbol{\rho}(t)$ does not exceed $\pi_{1}^{*}$, it is always possible to identify a two-way partition of $\Omega$ that satisfies 36. In fact, our proof already reveals such a partitioning algorithm as described in Algorithm 1. The algorithm is initialized with a partition of $\Omega$ that fails to meet 36 and then successively constructs a new partition from the previous one to reduce $f(S)$. The termination condition is exactly given by 36). Theorem 5 guarantees that the termination will always be triggered at some point.

Finally, we present a greedy two-way partitioning algorithm as described in Algorithm 2 that provably meets (36). We state this result in the following theorem.

Theorem 6. Let $\left(\pi_{0}^{*}, \pi_{1}^{*}\right)$ be the capacity-achieving input distribution for a regularized BAC. Let $\rho=\left[\rho_{1}, \rho_{2}, \ldots, \rho_{M}\right]$ be the belief state vector for Algorithm 2 satisfying $\max _{i \in \Omega} \rho_{i}<$ $\pi_{1}^{*}$. Let $\left(S_{0}, S_{1}\right)$ be the partition of $\Omega$ generated by Algorithm 2 Then, $\left(S_{0}, S_{1}\right)$ meets the SED condition in (36).

Proof: See Section V-D.
Remark 3. Both Algorithms 1 and 2 have complexity of order $O(M \log M)$, making them not suitable for practical implementation.

## IV. Achievable Rates for BSC With Feedback

In this section, we present our refined non-asymptotic upper bound on the average blocklength by adopting a SED encoder for the $\operatorname{BSC}(p)$ with feedback. Both Naghshvar et al.'s encoder and ours will yield the same result.

With the SED encoder and the $\operatorname{BSC}(p)$, we obtain a refined upper bound on the average blocklength, as stated below.

Theorem 7. Let $q \triangleq 1-p$. For a given $\epsilon \in(0,1 / 2)$, the average blocklength of the VLF code generated by the SED encoder over the $B S C(p)$ with feedback, $p \in(0,1 / 2)$, satisfies

$$
\begin{align*}
\mathbb{E}[\tau]< & \frac{\log M}{C}+\frac{\log 2 q}{q C}+\frac{\log \frac{1-\epsilon}{\epsilon}+C_{2}}{C_{1}} \\
& +2^{-C_{2}} C_{2}\left(\frac{1+\frac{\log 2 q}{q C_{2}}}{C}-\frac{1}{C_{1}}\right) \frac{1-\frac{\epsilon}{1-\epsilon} 2^{-C_{2}}}{1-2^{-C_{2}}} \tag{41}
\end{align*}
$$

This result is a consequence of two supporting lemmas. To aid our discussion, let $q=1-p$ and let us consider two stopping times for $\theta=i$ when $U_{i}(t)$ first crosses 0 and $\log \frac{1-\epsilon}{\epsilon}$, respectively,

$$
\begin{align*}
& \nu_{i} \triangleq \min \left\{t: U_{i}(t) \geq 0\right\}  \tag{42}\\
& \tau_{i} \triangleq \min \left\{t: U_{i}(t) \geq \log \frac{1-\epsilon}{\epsilon}\right\} \tag{43}
\end{align*}
$$

Clearly, $\nu_{i} \leq \tau_{i} . \nu_{i}$ and $\tau_{i}$ represent the stopping times when $\rho_{i}(t)$ first crosses $1 / 2$ and $1-\epsilon$, respectively. By Lemma 10 . both $\nu_{i}$ and $\tau_{i}$ are almost surely finite.

We are now in a position to introduce the two supporting lemmas. First, note that

$$
\begin{equation*}
\mathbb{E}[\tau]=\frac{1}{M} \sum_{i=1}^{M} \mathbb{E}[\tau \mid \theta=i] \leq \frac{1}{M} \sum_{i=1}^{M} \mathbb{E}\left[\tau_{i} \mid \theta=i\right] \tag{44}
\end{equation*}
$$

where the inequality follows since $\tau \leq \tau_{i}$ for all $i \in \Omega$. Next, for $\mathbb{E}\left[\tau_{i} \mid \theta=i\right]$, it can be rewritten as

& \mathbb{E}\left[\tau_{i} \mid \theta=i\right]=\mathbb{E}\left[\nu_{i} \mid \theta=i\right]+\mathbb{E}\left[\tau_{i}-\nu_{i} \mid \theta=i\right]  \tag{45}\\
& =\mathbb{E}\left[\nu_{i} \mid \theta=i\right]+\mathbb{E}\left[\mathbb{E}\left[\tau_{i}-\nu_{i} \mid \theta=i, U_{i}\left(\nu_{i}\right)=u\right] \mid \theta=i\right] \tag{46}
\end{align*}
$$

The intuition behind this decomposition is that $\mathbb{E}\left[\nu_{i} \mid \theta=i\right]$ corresponds to the average blocklength in the first communication phase (i.e., $U_{i}(t)$ from $\log (1 /(M-1))$ to 0 ), and $\mathbb{E}\left[\tau_{i}-\nu_{i} \mid \theta=i, U_{i}\left(\nu_{i}\right)=u\right]$ corresponds to the expected additional time spent in the confirmation phase with fallbacks to the communication phase. Here, $u$ represents the value at which $U_{i}(t)$ arrives when it crosses threshold 0 for the first time.

Our next step is to develop upper bounds on $\mathbb{E}\left[\nu_{i} \mid \theta=i\right]$ and $\mathbb{E}\left[\tau_{i}-\nu_{i} \mid \theta=i, U_{i}\left(\nu_{i}\right)=u\right]$ that are independent from $\theta=i$ and $U_{i}\left(\nu_{i}\right)=u$. Thus, summing up the two bounds will yield an upper bound on $\mathbb{E}\left[\tau_{i} \mid \theta=i\right]$, hence an upper bound on $\mathbb{E}[\tau]$ using (44). We state our results in Lemmas 4 and 5

We remark that the technique for developing an upper bound on $\mathbb{E}\left[\nu_{i} \mid \theta=i\right]$ makes use of a surrogate submartingale, thus allowing us to obtain a tighter constant term. In order to upper bound $\mathbb{E}\left[\tau_{i}-\nu_{i} \mid \theta=i, U_{i}\left(\nu_{i}\right)=u\right]$, we first observe that the behavior of $U_{i}(t)$ in the confirmation phase can be modeled
as a Markov chain with a fallback self loop on the initial state. This loop represents the probability that $U_{i}(t)$ first falls back to the communication phase and then returns to the confirmation phase. Next, we formulate the problem as solving a particular expected first-passage time on a Markov chain. The solution of this problem yields the desired upper bound. Detailed analysis can be found in the proof of each lemma.

Lemma 4. The average blocklength $\mathbb{E}\left[\nu_{i}\right]$ of a SED encoder over the $\operatorname{BSC}(p), p \in(0,1 / 2)$, with feedback satisfies

\begin{equation*}
\mathbb{E}\left[\nu_{i} \mid \theta=i\right]<\frac{\log M}{C}+\frac{\log 2 q}{q C} \tag{47}
\end{equation*}
$$

## Proof: See Section V-E

Lemma 5. Consider the SED encoder for the $\operatorname{BSC}(p), p \in$ $(0,1 / 2)$, with feedback. It holds that

& \mathbb{E}\left[\tau_{i}-\nu_{i} \mid \theta=i, U_{i}\left(\nu_{i}\right)=u\right] \\
& \leq \frac{\log \frac{1-\epsilon}{\epsilon}+C_{2}}{C_{1}}+2^{-C_{2}} C_{2}\left(\frac{1+\frac{\log 2 q}{q C_{2}}}{C}-\frac{1}{C_{1}}\right) \frac{1-\frac{\epsilon}{1-\epsilon} 2^{-C_{2}}}{1-2^{-C_{2}}} . \tag{48}
\end{align*}
$$

Proof: See Section V-F

## V. Proofs

In this section, we prove our main results.

## A. Proof of Lemma 3

Several steps in the proof of Lemma 3 are analogous to that in [12], for instance, the introduction of the extrinsic probabilities. However, the distinction is that we will fully exploit the properties of the extrinsic probabilities that motivates our SED encoder for the BAC with feedback.

Let $\theta=i \in \Omega$ be fixed. For brevity, let $x_{i}$ be the input symbol for $\theta=i$ at time $t+1$. Let $\mathcal{F}_{t}=\sigma\left(Y^{t}\right)$ denote the filtration generated by $Y^{t}$. Thus, given $\mathcal{F}_{t}$ and $\theta=i, Y_{t+1}$ is distributed according to $P\left(Y \mid X=x_{i}\right)$. Hence,

$$
\left.\begin{array}{rl}
\mathbb{E} & {\left[U_{i}(t+1)-U_{i}(t) \mid \mathcal{F}_{t}, \theta=i\right]} \\
= & \sum_{y \in \mathcal{Y}} P_{Y \mid X}\left(y \mid x_{i}\right)\left(\log \frac{\rho_{i}(t+1)}{1-\rho_{i}(t+1)}-\log \frac{\rho_{i}(t)}{1-\rho_{i}(t)}\right) \\
= & \sum_{y \in \mathcal{Y}} P_{Y \mid X}\left(y \mid x_{i}\right) \\
& \cdot\left(\log \frac{\rho_{i}(t) P_{Y \mid X}\left(y \mid x_{i}\right)}{\sum_{x \in \mathcal{X}} \pi_{x}(t) P_{Y \mid X}(y \mid x)}\right. \\
1-\frac{\rho_{i}(t) P_{Y \mid X}\left(y \mid x_{i}\right)}{\sum_{x \in \mathcal{X}} \pi_{x}(t) P_{Y \mid X}(y \mid x)}
\end{array} \log \frac{\rho_{i}(t)}{1-\rho_{i}(t)}\right), ~(4)
$$

where in (50), by letting $\bar{x}=1-x$, we introduce the extrinsic probabilities defined by

& \tilde{\pi}_{x_{i}, i}(t) \triangleq \frac{\pi_{x_{i}}(t)-\rho_{i}(t)}{1-\rho_{i}(t)}  \tag{52}\\
& \tilde{\pi}_{\bar{x}_{i}, i}(t) \triangleq \frac{\pi_{\bar{x}_{i}}(t)}{1-\rho_{i}(t)} \tag{53}
\end{align*}
$$

and in [51], $\tilde{Y}$ is the output induced by the channel $P(Y \mid X)$ for an input $\tilde{X}$ distributed according to $\left(\tilde{\pi}_{0, i}(t), \tilde{\pi}_{1, i}(t)\right)$.

Next, we prove the following key lemmas that connect our SED encoder to the two-stage submartingale in Lemma 3 .
Lemma 6. The SED encoder for the regularized $\operatorname{BAC}\left(p_{0}, p_{1}\right)$ with capacity-achieving input distribution $\left(\pi_{0}^{*}, \pi_{1}^{*}\right)$ satisfies $\tilde{\pi}_{x_{i}, i}(t) \leq \pi_{x_{i}}^{*}$, where $x_{i}$ is the input symbol for $\theta=i$ at time $t+1$.

Proof: Let $\hat{i}=\arg \max _{j \in \Omega} \rho_{j}(t)$. We distinguish two cases: $\rho_{\hat{i}}(t)<\pi_{1}^{*}$ and $\rho_{\hat{i}}(t) \geq \pi_{1}^{*}$.

When $\rho_{\hat{i}}(t)<\pi_{1}^{*}$, we further discuss two subcases: $x_{i}=0$ and $x_{i}=1$. If $x_{i}=0$, then $i \in S_{0}(t)$. Invoking the second inequality in (36), we have

& =\frac{\pi_{0}^{*}}{1-\rho_{i}(t)}\left(\frac{\pi_{1}^{*}}{\pi_{0}^{*}}\left(\pi_{0}(t)-\rho_{i}(t)\right)-\pi_{1}(t)\right) \\
& \leq \frac{\pi_{0}^{*}}{1-\rho_{i}(t)}\left(\frac{\pi_{1}^{*}}{\pi_{0}^{*}}\left(\pi_{0}(t)-\min _{j \in S_{0}(t)} \rho_{j}(t)\right)-\pi_{1}(t)\right) \\
& \leq 0 \tag{54}
\end{align*}
$$

If $x_{i}=1$, then $i \in S_{1}(t)$. In a similar fashion,

\tilde{\pi}_{1, i}(t)-\pi_{1}^{*} & =\frac{\pi_{0}^{*}}{1-\rho_{i}(t)}\left(\left(\pi_{1}(t)-\rho_{i}(t)\right)-\frac{\pi_{1}^{*}}{\pi_{0}^{*}} \pi_{0}(t)\right) \\
& \leq \frac{\pi_{0}^{*}}{1-\rho_{i}(t)}\left(\left(\pi_{1}(t)-\min _{j \in S_{1}(t)} \rho_{j}(t)\right)-\frac{\pi_{1}^{*}}{\pi_{0}^{*}} \pi_{0}(t)\right) \\
& \leq 0 \tag{55}
\end{align*}
$$

Therefore, Lemma 6 holds for $\rho_{\hat{i}}(t)<\pi_{1}^{*}$.
When $\rho_{\hat{i}}(t) \geq \pi_{1}^{*}$, by the encoding rule, $S_{1}(t)=\{\hat{i}\}$ and $S_{0}(t)=\Omega \backslash\{\hat{i}\}$. If $\hat{i}=i$, then $S_{1}(t)=\{i\}$ and $S_{0}(t)=\Omega \backslash\{i\}$. Thus, $\tilde{\pi}_{1, i}(t)=0<\pi_{1}^{*}$. If $\hat{i} \neq i$, then $i \in S_{0}(t)$. Since $\pi_{1}(t)=\rho_{\hat{i}}(t) \geq \pi_{1}^{*}$, it follows that $\pi_{0}(t) \leq \pi_{0}^{*}$. Combining with the fact that $\tilde{\pi}_{0, i}(t) \leq \pi_{0}(t)$, we conclude that $\tilde{\pi}_{0, i}(t) \leq$ $\pi_{0}^{*}$. Therefore, Lemma 6 also holds in this case.

Summarizing the above two cases, we conclude that Lemma 6 holds in general.

Next, we borrow a useful lemma on the KL divergence proved in [13].
Lemma 7 (Lemma 1, [13|). For any two distributions $P$ and $Q$ on a set $\mathcal{Y}$ and $\alpha \in[0,1], D(P \| \alpha P+(1-\alpha) Q)$ is decreasing in $\alpha$.

As an application of Lemma 7, let $P=P\left(Y \mid X=x_{i}\right)$, $Q=P\left(Y \mid X=\bar{x}_{i}\right)$ and $\alpha=\tilde{\pi}_{x_{i}, i}(t)$. 51) can be lower bounded by

where (57) follows from Lemma 6 and 58) follows from Fact 2. Therefore, with the SED encoder, it always holds that

As a result, 38a is proved.
In particular, if $U_{i}(t) \geq 0$, this is equivalent to $\rho_{i}(t) \geq 1 / 2$ and thus $i$ is the index with the maximum posterior. Using Fact 1 that $\pi_{1}^{*} \leq 1 / 2$, it follows that $\max _{j \in \Omega} \rho_{j}(t)=\rho_{i}(t) \geq \pi_{1}^{*}$. Thus, the SED encoder will exclusively assign $S_{1}(t)=\{i\}$ and $S_{0}(t)=\Omega \backslash\{i\}$, resulting in $\tilde{\pi}_{1, i}(t)=0$ and

where (60) follows from Fact 3 Therefore, (38b) is proved. We also remark that for $Y_{t+1}=y$,

Hence, $C_{1}$ can be thought of as the average drift of $U_{i}(t)$ for $U_{i}(t) \geq 0$.

To prove (38c), we note that when $Y_{t+1}=y$,

& =\left|\log \frac{P_{Y \mid X}\left(y \mid e_{t+1}\left(i, Y^{t}\right)\right)}{\sum_{j \neq i} \frac{\rho_{j}(t)}{1-\rho_{i}(t)} P_{Y \mid X}\left(y \mid e_{t+1}\left(j, Y^{t}\right)\right)}\right|  \tag{62}\\
& \leq \log \frac{\max _{x \in \mathcal{X}} P_{Y \mid X}(y \mid x)}{\min _{x \in \mathcal{X}} P_{Y \mid X}(y \mid x)} \tag{63}
\end{align*}
$$

Hence, we have

\end{equation*}

which completes the proof of 38 c .

## B. Proof of Theorem 4

The proof of Theorem 4 involves a submartingale synthesis with optimized parameters and a variant of Doob's optional stopping theorem. Throughout the proof, we fix $\theta=i \in \Omega$ to avoid writing the conditioning $\theta=i$ unless otherwise specified.

Let the sequence $\left\{U_{i}(t)\right\}_{t=0}^{\infty}$ be the two-stage submartingale defined in (38) with respect to filtration $\left\{\mathcal{F}_{t}\right\}_{t=0}^{\infty}$ as a result of the SED encoding over a regularized $\operatorname{BAC}\left(p_{0}, p_{1}\right)$. Let us consider a sequence $\{\eta(t)\}_{t=0}^{\infty}$ defined as

-A+\frac{U_{i}(t)}{C}-t, \quad \text { if } U_{i}(t)<0  \tag{65}\\

\end{array}\right.
$$

where $s>0$ and $A>0$ are two constants. For our purposes, we require that $s$ and $A$ meet the following two equations.

\end{align*}

The motivation behind these equations is to select the best parameters that make $\{\eta(t)\}_{t=0}^{\infty}$ a submartingale. This will
become clearer as our proof proceeds. Solving (66) and (67) for $s$ and $A$ yields

Lemma 8. The sequence $\{\eta(t)\}_{t=0}^{\infty}$ with parameters $s$ and $A$ satisfying (66) and (67) forms a submartingale with respect to the filtration $\left\{\mathcal{F}_{t}\right\}_{t=0}^{\infty}$.

Proof: We will show that $\mathbb{E}\left[\eta(t+1) \mid \mathcal{F}_{t}\right] \geq \eta(t)$. There are two cases.

Case $1\left(U_{i}(t)<0\right)$ : there are two subcases. If $U_{i}(t+1) \geq 0$, then from (38c), $U_{i}(t+1)<C_{2}$. Consider the function

where $s$ and $A$ satisfy equations 66) and 67). Since $f(0)=0$, $f\left(C_{2}\right)=0$ due to (66), and $f(x)$ is a concave function, it follows that $f(x)>0$ for $x \in\left(0, C_{2}\right)$. Let $U_{i}(t+1)$ play the role of $x$. Using $f\left(U_{i}(t+1)\right)>0$, we obtain

& \geq-A+\frac{U_{i}(t)+C}{C}-(t+1)  \tag{74}\\
& =\eta(t) \tag{75}
\end{align*}
$$

where (74) follows from 38a).
Case $2\left(U_{i}(t) \geq 0\right)$ : there are two subcases. If $U_{i}(t+1)<0$, using $f(x)$ defined in (70), $f\left(U_{i}(t+1)\right)<0$. Therefore,

\eta(t+1) & =-A+\frac{\overline{U_{i}(t+1)}}{C}-(t+1)  \tag{76}\\
& \geq-A e^{-s U_{i}(t+1)}+\frac{U_{i}(t+1)}{C_{1}}-(t+1) \tag{77}
\end{align*}
$$

If $U_{i}(t+1) \geq 0$, then

\eta(t+1)=-A e^{-s U_{i}(t+1)}+\frac{U_{i}(t+1)}{C_{1}}-(t+1) \tag{78}
\end{equation*}

Hence, regardless of the sign of $U_{i}(t+1)$, it holds that

\mathbb{E} & {\left[\eta(t+1) \mid \mathcal{F}_{t}\right] } \\
\geq & \mathbb{E}\left[\left.-A e^{-s U_{i}(t+1)}+\frac{U_{i}(t+1)}{C_{1}}-(t+1) \right\rvert\, \mathcal{F}_{t}\right]  \tag{79}\\
= & -A \mathbb{E}\left[e^{-s U_{i}(t+1)} \mid \mathcal{F}_{t}\right]+\frac{\mathbb{E}\left[U_{i}(t+1) \mid \mathcal{F}_{t}\right]}{C_{1}}-(t+1)  \tag{80}\\
= & -A\left(p_{1} e^{-s \log \frac{p_{1}}{1-p_{0}}}+\left(1-p_{1}\right) e^{-s \log \frac{1-p_{1}}{p_{0}}}\right) e^{-s U_{i}(t)} \\
& +\frac{U_{i}(t)}{C_{1}}-t  \tag{81}\\
= & \eta(t) \tag{82}
\end{align*}
$$

where (81) follows from (38b) and (61), and (82) follows from (67).

Summarizing the above two cases, we conclude that $\mathbb{E}[\eta(t+$ 1) $\left.\mid \mathcal{F}_{t}\right] \geq \eta(t)$.

Lemma 9. The sequence $\{\eta(t)\}_{t=0}^{\infty}$ with parameters $s$ and $A$ satisfying (66) and 67] has the property that the difference between $\eta(t+1)$ and $\eta(t)$ is absolutely bounded, i.e.,

Proof: We distinguish four cases.
Case 1: $U_{i}(t)<0$ and $U_{i}(t+1)<0$. In this case,

Case 2: $U_{i}(t)<0$ and $U_{i}(t+1) \geq 0$. In this case, $U_{i}(t+1) \leq$ $C_{2}$ by 38c , and

& \leq A\left(1-e^{-s C_{2}}\right)+\frac{C_{2}}{C}+1 \tag{85}
\end{align*}

Case 3: $U_{i}(t) \geq 0$ and $U_{i}(t+1)<0$. In this case, $U_{i}(t) \leq C_{2}$ by (38c), and

& \quad+\left|\frac{U_{i}(t+1)-U_{i}(t)}{C}+\left(\frac{1}{C}-\frac{1}{C_{1}}\right) U_{i}(t)\right|+1 \\
& \leq A\left(1-e^{-s C_{2}}\right)+\frac{C_{2}}{C}+\left(\frac{1}{C}-\frac{1}{C_{1}}\right) C_{2}+1 \tag{86}
\end{align*}
$$

Case 4: $U_{i}(t) \geq 0$ and $U_{i}(t+1) \geq 0$. In this case,

& \leq A\left|e^{-s U_{i}(t+1)}-e^{-s U_{i}(t)}\right|+\frac{\left|U_{i}(t+1)-U_{i}(t)\right|}{C_{1}}+1 \\
& \leq A\left(1-e^{-s C_{2}}\right)+\frac{C_{2}}{C_{1}}+1 \tag{87}
\end{align*}
$$

where 87) follows from the inequality $\left|e^{-s y}-e^{-s x}\right| \leq 1-$ $e^{-s|y-x|}$ for $s \geq 0, x \geq 0$ and $y \geq 0$.

Note that the upper bounds in 84, (85), 86) and 87) are no greater than $A+\frac{2 C_{2}}{C}+1$. The proof is completed.
Lemma 10. Let $\{U(t)\}_{t=0}^{\infty}$ be the submartingale in (38) with respect to filtration $\left\{\mathcal{F}_{t}\right\}_{t=0}^{\infty}$. Consider the stopping time $T \triangleq$ $\min \{t: U(t) \geq \zeta\}$, where $\zeta>0$ is some constant. Then, $\mathscr{P}\{T<\infty\}=1$. Namely, $T$ is a.s. finite.

Proof: We first recall Azuma's inequality for a general submartingale $\{\xi(t)\}_{t=0}^{\infty}$ : If $\{\xi(t)\}_{t=0}^{\infty}$ is a submartingale that satisfies $|\xi(t+1)-\xi(t)| \leq K$ for all $t \geq 0$, then for a given $\sigma>0$,

Let us consider $\xi(t) \triangleq \frac{U(t)}{C}-t$. We show that $\{\xi(t)\}_{t=0}^{\infty}$ is also a submartingale with respect to filtration $\left\{\mathcal{F}_{t}\right\}_{t=0}^{\infty}$. Specifically, if $U(t)<0$, then

& =\xi(t) \tag{91}
\end{align*}

If $U(t) \geq 0$, using the fact that $C_{1} \geq C$, we can also show that $\mathbb{E}\left[\xi(t+1) \mid \mathcal{F}_{t}\right] \geq \xi(t)$. Hence, $\{\xi(t)\}_{t=0}^{\infty}$ is a submartingale with respect to filtration $\left\{\mathcal{F}_{t}\right\}_{t=0}^{\infty}$. Furthermore, for any $t \geq 0$,

Let $K=\frac{C_{2}}{C}+1$ for shorthand notation. Thus, appealing to Azuma's inequality,

& =\mathscr{P}\{\xi(t)-\xi(0) \leq-\sigma\}  \tag{94}\\
& \leq \exp \left(\frac{-\sigma^{2}}{2 t K^{2}}\right) \tag{95}
\end{align*}
$$

Equating $\zeta=(t-\sigma) C+U(0)$ yields $\sigma=t-\frac{\zeta-U(0)}{C}, t>$ $\frac{\zeta-U(0)}{C}$. Hence,

& =0 \tag{101}
\end{align*}

Namely, $\mathscr{P}\{T<\infty\}=1$.
Finally, we follow [17] to prove a variant of Doob's optional stopping theorem which will be useful in proving the main result.

Lemma 11 (Variant of Doob's Optional Stopping Theorem). Let $\{U(t)\}_{t=0}^{\infty}$ be a submartingale with respect to filtration $\left\{\mathcal{F}_{t}\right\}_{t=0}^{\infty}$ satisfying $|U(t+1)-U(t)| \leq K$ for some positive constant $K$. Let $T=\min \{t: U(t) \geq \zeta\}, \zeta>0$ be a stopping time and assume that $T$ is a.s. finite. Then,

& \leq \lim _{t \rightarrow \infty} \mathbb{E}[U(t \wedge T)]  \tag{104}\\
& \leq \mathbb{E}\left[\lim _{t \rightarrow \infty} U(t \wedge T)\right]  \tag{105}\\
& =\mathbb{E}[U(T)]
\end{align*}
$$

In the above,

- (103) follows from applying Doob's optional stopping theorem [18] to the stopped process $\{U(t \wedge T)\}_{t=0}^{\infty}$.
- (104) follows from that $\mathbb{E}[U(t \wedge T)] \leq \mathbb{E}[U((t+1) \wedge T)]$ for submartingales. This can be seen by noting that

& \geq 0
\end{aligned}
$$

where the last step follows from submartingale property $\mathbb{E}\left[U(t+1) \mid \mathcal{F}_{t}\right] \geq U(t)$.

- (105) follows from the fact that $U(t \wedge T)$ is uniformly bounded above, the assumption that $T$ is a.s. finite, and the reverse Fatou's lemma.
This concludes the proof of Lemma 11 .
Let us consider the stopping time for each $j \in \Omega$ :

& \leq-A e^{-s\left(\log \frac{1-\epsilon}{\epsilon}+C_{2}\right)}+\frac{\log \frac{1-\epsilon}{\epsilon}+C_{2}}{C_{1}}-\mathbb{E}\left[\tau_{i} \mid \theta=i\right] \tag{108}
\end{align*}

where (108) follows since

Rewriting (108) and substituting $s$ and $A$ with (68) and 69) respectively yield

& <\frac{\log M}{C}+\frac{\log \frac{1-\epsilon}{\epsilon}+C_{2}}{C_{1}}+C_{2}\left(\frac{1}{C}-\frac{1}{C_{1}}\right) \frac{1-\frac{\epsilon}{1-\epsilon} 2^{-C_{2}}}{1-2^{-C_{2}}} \tag{111}
\end{align*}
$$

Finally,

where the last inequality follows since $\tau \leq \tau_{j}$ for all $j \in$ $\Omega$. Since the upper bound in 111 holds for any $\mathbb{E}\left[\tau_{j} \mid \theta=\right.$ $j$ ]. Substituting the bound in 112 completes the proof of Theorem 4

## C. Proof of Theorem 5

We prove Theorem 5 by contradiction. Let $S_{0}^{*} \subseteq \Omega$ be an optimal subset of $\Omega$ that minimizes $f(S)$ in 40). If the partition ( $S_{0}^{*}, \Omega \backslash S_{0}^{*}$ ) does not meet (36), one can construct another subset $S_{0}^{\prime} \subseteq \Omega$ from $S_{0}^{*}$ such that $f\left(S_{0}^{\prime}\right)<f\left(S_{0}^{*}\right)$, thus contradicting the assumption that $S_{0}^{*}$ minimizes $f(S)$.

Assume that the partition $\left(S_{0}^{*}, \Omega \backslash S_{0}^{*}\right)$ does not meet (36), there are two cases.

Case 1: the partition $\left(S_{0}^{*}, \Omega \backslash S_{0}^{*}\right)$ satisfies $\lambda \pi_{0}\left(S_{0}^{*}\right)-$ $\pi_{1}\left(S_{0}^{*}\right)<-\min _{i \in \Omega \backslash S_{0}^{*}} \rho_{i}$. Let $i^{*}=\arg \min _{i \in \Omega \backslash S_{0}^{*}} \rho_{i}$. Then,

where (114) follows since all elements in $\rho$ remain strictly positive during Bayes' update. If $\pi_{1}\left(S_{0}^{\prime}\right)<\lambda \pi_{0}\left(S_{0}^{\prime}\right)$, then

where 115 follows from the assumption that $\lambda \pi_{0}\left(S_{0}^{*}\right)-$ $\pi_{1}\left(S_{0}^{*}\right)<-\rho_{i^{*}}$ and (113). Hence, the optimality assumption of $S_{0}^{*}$ is contradicted in Case 1.

Case 2: the partition $\left(S_{0}^{*}, \Omega \backslash S_{0}^{*}\right)$ satisfies $\lambda \pi_{0}\left(S_{0}^{*}\right)-$ $\pi_{1}\left(S_{0}^{*}\right)>\lambda \min _{i \in S_{0}^{*}} \rho_{i}$. Let $i^{*}=\arg \min _{i \in S_{0}^{*}} \rho_{i}$. Then,

where 117) follows from the assumption that $\lambda \pi_{0}\left(S_{0}^{*}\right)-$ $\pi_{1}\left(S_{0}^{*}\right)>\lambda \rho_{i^{*}}$ and 116). If $\pi_{1}\left(S_{0}^{\prime}\right)<\lambda \pi_{0}\left(S_{0}^{\prime}\right)$, then

& =f\left(S_{0}^{*}\right) \tag{118}

Hence, the optimality assumption of $S_{0}^{*}$ is contradicted in Case 2.

In summary, we have shown that if the partition $\left(S_{0}^{*}, \Omega \backslash S_{0}^{*}\right)$ does not meet (36), the optimality assumption of $S_{0}^{*}$ will be contradicted. Therefore, the partition $\left(S_{0}^{*}, \Omega \backslash S_{0}^{*}\right)$ must satisfy (36). This concludes the proof of Theorem 5 .

## D. Proof of Theorem 6

Let us write $\pi_{0}^{(s)}$ and $\pi_{1}^{(s)}$ to denote the probabilities of $S_{0}^{(s)}$ and $S_{1}^{(s)}$ at iteration $s, s=1,2, \ldots, M$. We prove Theorem 6 by induction.

Base case: For $s=1, \pi_{0}^{(1)}=\rho_{j_{1}}$ and $\pi_{1}^{(1)}=0$. Clearly,

Case 1: $\pi_{1}^{(k)} \geq \lambda \pi_{0}^{(k)}$. According to Algorithm 2, $\pi_{0}^{(k+1)}=$ $\pi_{0}^{(k)}+\rho_{j_{k+1}}$ and $\pi_{1}^{(k+1)}=\pi_{1}^{(k)}$. Meanwhile, $\rho_{j_{k+1}}=$ $\min _{i \in S_{0}^{(k+1)}} \rho_{i}$ and $\min _{i \in S_{1}^{(k)}} \rho_{i}=\min _{i \in S_{1}^{(k+1)}} \rho_{i}$. Therefore,

Hence, 36 holds for $\pi_{0}^{(k+1)}$ and $\pi_{1}^{(k+1)}$ in Case 1.
Case 2: $\pi_{1}^{(k)}<\lambda \pi_{0}^{(k)}$. According to Algorithm 2, $\pi_{0}^{(k+1)}=$ $\pi_{0}^{(k)}$ and $\pi_{1}^{(k+1)}=\pi_{1}^{(k)}+\rho_{j_{k+1}}$. Meanwhile, $\rho_{j_{k+1}}=$ $\min _{i \in S_{1}^{(k+1)}} \rho_{i}$ and $\min _{i \in S_{0}^{(k)}} \rho_{i}=\min _{i \in S_{0}^{(k+1)}} \rho_{i}$. Therefore,

Hence, (36) holds for $\pi_{0}^{(k+1)}$ and $\pi_{1}^{(k+1)}$ in Case 2.
In summary, 36 holds for $\pi_{0}^{(k+1)}$ and $\pi_{1}^{(k+1)}$ at iteration $s=k+1$. Therefore, when the algorithm terminates, a twoway partition of $\Omega$ will be formed and the corresponding $\pi_{0}^{(M)}$ and $\pi_{1}^{(M)}$ will satisfy 36. This completes the proof of Theorem 6

## E. Proof of Lemma 4

The proof of Lemma 4 includes a construction of a surrogate submartingale and an application of the variant of Doob's optional stopping theorem.

Let $x_{i}$ be the input symbol for $\theta=i$ at time $t+1$ and define $\bar{x}_{i}=1-x_{i}$. Following the derivation of (50), for $Y_{t+1}=y$,

2). $\mathbb{E}\left[U_{i}^{\prime}(t) \mid \mathcal{F}_{t}\right]=U_{i}^{\prime}(t)+C$.

The motivation behind condition 1 is explained below. Let

Compared with $w_{i}(t, y)$, the only distinction lies in $w_{i}^{\prime}\left(t, x_{i}\right) \neq$ $w_{i}\left(t, x_{i}\right)$. We now show that this construction of $\left\{U_{i}^{\prime}(t)\right\}_{t=0}^{\infty}$ indeed satisfies the two conditions aforementioned. First,

& \quad+P_{Y \mid X}\left(\bar{x}_{i} \mid x_{i}\right) \log 2 P_{Y \mid X}\left(\bar{x}_{i} \mid x_{i}\right)  \tag{133}\\
& =C . \tag{134}
\end{align*}

This implies that $\left\{U_{i}^{\prime}(t)\right\}_{t=0}^{\infty}$ is a submartingale satisfying Condition 2. Specifically, $\mathbb{E}\left[U_{i}^{\prime}(t+1) \mid \mathcal{F}_{t}\right]=U_{i}^{\prime}(t)+C$.

Next, we show Condition 1 also holds for $\left\{U_{i}^{\prime}(t)\right\}_{t=0}^{\infty}$. Note that the only difference between $w_{i}(t, y)$ and $w_{i}^{\prime}(t, y)$ is when $y=x_{i}$, thus, it suffices to show $w_{i}^{\prime}\left(t, x_{i}\right) \leq w_{i}\left(t, x_{i}\right)$. Indeed,

& \geq \log 2 P_{Y \mid X}\left(x_{i} \mid x_{i}\right)+\frac{P_{Y \mid X}\left(\bar{x}_{i} \mid x_{i}\right)}{P_{Y \mid X}\left(x_{i} \mid x_{i}\right)} \log \frac{\sum_{x \in \mathcal{X}} \tilde{\pi}_{x, i}(t) P\left(\bar{x}_{i} \mid x\right)}{1 / 2}  \tag{135}\\
& =w_{i}^{\prime}\left(t, x_{i}\right) \tag{136}
\end{align*}
$$

where 135 follows from the inequality below. Let us use the shorthand notation $\pi_{x, i}=\pi_{x, i}(t), p=P_{Y \mid X}(\bar{x} \mid x)$ and $q=P_{Y \mid X}(x \mid x)$. Then,

with equality if and only if $\tilde{\pi}_{x_{i}, i}=1 / 2$. Thus, $w_{i}^{\prime}(t, y) \leq$ $w_{i}(t, y)$ for $y \in\{0,1\}$ and Condition 1 follows.

Finally, we apply Lemma 11 to the surrogate submartingale $\left\{U_{i}^{\prime}(t)\right\}_{t=0}^{\infty}$ to obtain an upper bound on $\mathbb{E}\left[\nu_{i}^{\prime}\right]$. Observe that for any $t \geq 0$ and $y^{t}$,

$$
\begin{equation*}
\left|w_{i}^{\prime}(t, y)\right| \leq\left|w_{i}(t, y)\right| \leq C_{2} \tag{140}
\end{equation*}
$$

Hence, the conditions in Lemma 11 are met.
Consider a normalized sequence $\{\eta(t)\}_{t=0}^{\infty}$ defined as

$$
\begin{equation*}
\eta(t) \triangleq \frac{U_{i}^{\prime}(t)}{C}-t \tag{141}
\end{equation*}
$$

It is straightforward to show that $\{\eta(t)\}_{t=0}^{\infty}$ is a martingale with a bounded difference $|\eta(t+1)-\eta(t)|$. Therefore, by

Lemma 11

$$
\begin{align*}
\frac{U_{i}(0)}{C} & =\eta(0) \\
& \leq \mathbb{E}\left[\eta\left(\nu_{i}^{\prime}\right)\right] \\
& =\frac{\mathbb{E}\left[U_{i}^{\prime}\left(\nu_{i}^{\prime}\right)-U_{i}^{\prime}\left(\nu_{i}^{\prime}-1\right)\right]+\mathbb{E}\left[U_{i}^{\prime}\left(\nu_{i}^{\prime}-1\right)\right]}{C}-\mathbb{E}\left[\nu_{i}^{\prime}\right] \\
& \leq \frac{w_{i}^{\prime}\left(t, x_{i}\right)+0}{C}-\mathbb{E}\left[\nu_{i}^{\prime}\right]  \tag{142}\\
& \leq \frac{(1 / q) \log 2 q}{C}-\mathbb{E}\left[\nu_{i}^{\prime}\right] \tag{143}
\end{align*}
$$

where 142 follows from the fact that $U_{i}^{\prime}(t)$ has to cross the threshold 0 from $t=\nu_{i}^{\prime}-1$ to $t=\nu_{i}^{\prime}$ and that $w_{i}^{\prime}\left(t, x_{i}\right)$ is the only positive, instantanenous step size, 143) follows from the fact that

$$
\begin{equation*}
w_{i}^{\prime}\left(t, x_{i}\right) \leq \log 2 q-\frac{p}{q} \log \frac{1 / 2}{q}=\frac{\log 2 q}{q} \tag{144}
\end{equation*}
$$

Combining (143) with the fact that $\nu_{i} \leq \nu_{i}^{\prime}$,

$$
\begin{align*}
\mathbb{E}\left[\nu_{i}\right] \leq \mathbb{E}\left[\nu_{i}^{\prime}\right] & \leq \frac{\log 2 q}{q C}-\frac{\log \frac{1 / M}{1-1 / M}}{C}  \tag{145}\\
& <\frac{\log M}{C}+\frac{\log 2 q}{q C} \tag{146}
\end{align*}
$$

This completes the proof of Lemma 4

## F. Proof of Lemma 5

The proof requires several steps. First, we show that when $U_{i}(t) \geq 0$, the behavior of $U_{i}(t)$ can be modeled as a Markov chain with a fallback self loop. This self loop represents the probability that $U_{i}(t)$ first falls back to the communication phase and eventually returns to the confirmation phase. Next, the problem of solving $\mathbb{E}\left[\tau_{i}-\nu_{i} \mid \theta=i, U_{i}\left(\nu_{i}\right)=u\right]$ can be formulated as the expected first-passage time from the initial state to the terminating state on a generalized Markov chain.

Let $q \triangleq 1-p$. For $\operatorname{BSC}(p), p \in(0,1 / 2)$, by Fact 3 , $C_{2}=$ $\log (q / p)$ and $C_{1}=(q-p) C_{2}$. In the following analysis, we fix $\theta=i \in \Omega$ unless otherwise specified.

Recall that with the SED encoding, the one-step update for $U_{i}(t)$ when $U_{i}(t) \geq 0$ is given by . In the case of $\operatorname{BSC}(p)$, we have

$$
\begin{equation*}
U_{i}(t+1)=U_{i}(t)+W \tag{147}
\end{equation*}
$$

where $W=C_{2}$ with probability $P_{Y \mid X}(1 \mid 1)=q$ and $W=$ $-C_{2}$ with probability $P_{Y \mid X}(0 \mid 1)=p$. Assume that $U_{i}\left(\nu_{i}\right)=$ $u \in\left[0, C_{2}\right)$. Clearly, the behavior of $U_{i}(t)$ is a Markov chain with initial value $u$, provided that $U_{i}(t) \geq u$ for all $t \geq \nu_{i}$.

Unfortunately, the above Markov chain is too simple to capture the reality. First, $U_{i}(t)$ can fall back to the communication phase (i.e., $U_{i}(t)<0$ ) at some $t^{\prime}>\nu_{i}$. Second, if $U_{i}(t)$ falls back and then returns to the confirmation phase, the value at which $U_{i}(t) \geq 0$ might be different from $u$.

Nevertheless, we make two important observations. First, the prior probability that $U_{i}(t)$ falls back to communication phase is $p$. Given that $U_{i}(t)$ falls back, the conditional probabiliy that $U_{i}(t)$ eventually returns to the confirmation phase is 1 (since $\tau_{i}$ is a.s. finite). Hence, the transition probability

from the initial state value $u$ at which $U_{i}(t)$ falls back to another initial state value $u^{\prime}$ at which $U_{i}(t)$ returns is $p$. Second, assume $u$ is the initial value when $U_{i}(t)$ first enters the confirmation phase. By (147), the subsequent values that $U_{i}(t)$ assumes are of the form $u+j C_{2}, j=0,1, \ldots$, provided that $U_{i}(t) \geq 0$ all the time. These observations motivate the definition of a generalized Markov chain.

Definition 1. Let $\mathcal{S}_{0}=\left[0, C_{2}\right)$ represent the set of values of $U_{i}(t)$ when transitioning from below 0 to above 0 for the first time. Let $n \triangleq\left\lceil\log \frac{1-\epsilon}{\epsilon} / C_{2}\right\rceil$. Define $\mathcal{S}_{j} \triangleq\left[j C_{2}, j C_{2}+\right.$ $\left.C_{2}\right), 1 \leq j \leq n$. The generalized Markov chain consists of a sequence of states $\mathcal{S}_{0}, \mathcal{S}_{1}, \ldots, \mathcal{S}_{n}$ satisfying

$$
\begin{aligned}
\mathscr{P}\left\{\mathcal{S}_{j+1} \mid \mathcal{S}_{j}\right\} & \triangleq P_{V \mid U}\left(u+C_{2} \mid u\right), u \in \mathcal{S}_{j}, 0 \leq j \leq n-1, \\
\mathscr{P}\left\{\mathcal{S}_{j-1} \mid \mathcal{S}_{j}\right\} & \triangleq P_{V \mid U}\left(u-C_{2} \mid u\right), u \in \mathcal{S}_{j}, 1 \leq j \leq n \\
\mathscr{P}\left\{\mathcal{S}_{0} \mid \mathcal{S}_{0}\right\} & \triangleq P\left(V \in \mathcal{S}_{0} \mid U=u\right), u \in \mathcal{S}_{0}, \\
\mathscr{P}\left\{\mathcal{S}_{n} \mid \mathcal{S}_{n}\right\} & \triangleq 1
\end{aligned}
$$

where if $u \in \mathcal{S}_{0}, P\left(V \in \mathcal{S}_{0} \mid U=u\right)=p$ and $P(V=u+$ $\left.C_{2} \mid U=u\right)=q$. If $u \in \mathcal{S}_{j}, j \geq 1, P\left(V=u+C_{2} \mid U=u\right)=q$ and $P\left(V=u+C_{2} \mid U=u\right)=p$.

The distinction between the generalized Markov chain and a regular Markov chain discussed above is that each state is an interval rather than a single value. However, as soon as $U_{i}(t) \geq$ 0 , only a single value in each set $\mathcal{S}_{j}$ remains active and is uniquely determined by the initial value in $\mathcal{S}_{0}$. Specifically, if the initial value is $u$, then the only active value in $\mathcal{S}_{j}$ is given by $u+j C_{2}, 1 \leq j \leq n$. For this reason, each state $\mathcal{S}_{j}$, albeit defined as an interval, resembles a "single value", and one can directly define transition probabilities between two consecutive states. Fig. 2 illustrates an example of the generalized Markov chain with initial value $u \in\left[0, C_{2}\right)$.

Let us consider a new stopping time

$$
\begin{equation*}
\tau_{i}^{*} \triangleq \min \left\{t:\left\lfloor\frac{U_{i}(t)}{C_{2}}\right\rfloor \geq\left\lceil\frac{\log \frac{1-\epsilon}{\epsilon}}{C_{2}}\right\rceil\right\} \tag{148}
\end{equation*}
$$

By definition, $\tau_{i}^{*}$ is independent from the initial value $U_{i}(t)-$ $\left\lfloor U_{i}(t) / C_{2}\right\rfloor C_{2}$ and is achieved whenever $U_{i}(t)$ enters $\mathcal{S}_{n}$ for the first time. Moreover,

$$
\begin{equation*}
\frac{U_{i}\left(\tau_{i}^{*}\right)}{C_{2}} \geq\left\lfloor\frac{U_{i}\left(\tau_{i}^{*}\right)}{C_{2}}\right\rfloor \geq\left\lceil\frac{\log \frac{1-\epsilon}{\epsilon}}{C_{2}}\right\rceil \geq \frac{\log \frac{1-\epsilon}{\epsilon}}{C_{2}} \tag{149}
\end{equation*}
$$

Hence, by definition of $\tau_{i}$ in 43, we obtain

$$
\begin{equation*}
\tau_{i} \leq \tau_{i}^{*} \tag{150}
\end{equation*}
$$

This implies that

$$
\begin{equation*}
\mathbb{E}\left[\tau_{i}-\nu_{i} \mid \theta=i, U_{i}\left(\nu_{i}\right)=u\right] \leq \mathbb{E}\left[\tau_{i}^{*}-\nu_{i} \mid \theta=i, U_{i}\left(\nu_{i}\right)=u\right] \tag{151}
\end{equation*}
$$

Note that $\mathbb{E}\left[\tau_{i}^{*}-\nu_{i} \mid \theta=i, U_{i}\left(\nu_{i}\right)=u\right]$ represents the expected first-passage time from initial state $u \in \mathcal{S}_{0}$ when $U_{i}(t)$ first crosses threshold 0 to state $\mathcal{S}_{n}$. In Appendix III, the time of first passage analysis reveals that

$$
\begin{align*}
& \mathbb{E}\left[\tau_{i}^{*}-\nu_{i} \mid \theta=i, U_{i}\left(\nu_{i}\right)=u\right] \\
& =\frac{n}{1-2 p}+\frac{p}{1-2 p}\left(1-\left(\frac{p}{q}\right)^{n}\right)\left(\Delta_{0}-\frac{2 q}{1-2 p}\right)  \tag{152}\\
& =\frac{n C_{2}}{C_{1}}+\frac{2^{-C_{2}}}{1-2^{-C_{2}}}\left(1-2^{-n C_{2}}\right)\left(\Delta_{0}-1-\frac{C_{2}}{C_{1}}\right), \tag{153}
\end{align*}
$$

where $\Delta_{0}$ represents the expected self loop time of $U_{i}(t)$ from $\mathcal{S}_{0}$ to $\mathcal{S}_{0}$. Assume that after fallback, $U_{i}(t)=u-C_{2}<0$. Following the proof of Lemma 4 in Section V-E we immediately obtain,

$$
\begin{align*}
\Delta_{0} & \leq 1+\frac{(1 / q) \log 2 q}{C}-\frac{u-C_{2}}{C}  \tag{154}\\
& =1+\frac{(1 / q) \log 2 q+C_{2}-u}{C}  \tag{155}\\
& \leq 1+\frac{(1 / q) \log 2 q+C_{2}}{C} \tag{156}
\end{align*}
$$

Substituting (156) into (153) yields

$$
\begin{align*}
& \mathbb{E}\left[\tau_{i}^{*}-\nu_{i} \mid \theta=i, U_{i}\left(\nu_{i}\right)=u\right] \\
& \leq \frac{n C_{2}}{C_{1}}+C_{2} 2^{-C_{2}} \frac{1-2^{-n C_{2}}}{1-2^{-C_{2}}}\left(\frac{1+\frac{\log 2 q}{q C_{2}}}{C}-\frac{1}{C_{1}}\right) . \tag{157}
\end{align*}
$$

Using $n=\left\lceil\log \frac{1-\epsilon}{\epsilon} / C_{2}\right\rceil \leq \log \frac{1-\epsilon}{\epsilon} / C_{2}+1$, we obtain the desired upper bound

$$
\begin{align*}
& \mathbb{E}\left[\tau_{i}^{*}-\nu_{i} \mid \theta=i, U_{i}\left(\nu_{i}\right)=u\right] \\
& \leq \frac{\log \frac{1-\epsilon}{\epsilon}+C_{2}}{C_{1}}+C_{2} 2^{-C_{2}} \frac{1-\frac{\epsilon}{1-\epsilon} 2^{-C_{2}}}{1-2^{-C_{2}}}\left(\frac{1+\frac{\log 2 q}{q C_{2}}}{C}-\frac{1}{C_{1}}\right) . \tag{158}
\end{align*}
$$

Invoking (151) completes the proof of Lemma 5 .

## VI. Numerical Simulation

In this section, we simulate the proposed SED encoder for a regularized $\operatorname{BAC}\left(p_{0}, p_{1}\right)$ with feedback. In the case of BSC, we will compare the empirical rate with the achievability bound given by our results and previous work. By (12), we can compute the empirical rate achieved by the SED encoder. Using the non-asymptotic upper bound on $\mathbb{E}[\tau]$, we can also obtain the associated achievability bound (i.e., lower bound) on rate.

## A. Simulation Results on BAC with Feedback

Let the target error probability $\epsilon=10^{-3}$. Consider the $\operatorname{BAC}(0.03,0.22)$ with feedback. Using Facts 1 and 3 , one can compute

$$
\begin{equation*}
C=0.5, \quad C_{1}=3.1954, \quad C_{2}=4.7 \tag{159}
\end{equation*}
$$

Fig. 3 shows the simulated rate vs. average blocklength of the SED encoder over the $\operatorname{BAC}(0.03,0.22)$ with feedback, along with the achievability bound derived from Theorem 4 Since the SED encoder has an exponential complexity in message length, we were only able to simulate the message length from $k=1$ to $k=20$ bits. We see in Fig. 3 that the actual performance of the SED encoder is much better than our achievability bound, implying that there is still room for improvement.

## B. Simulation Results on BSC with Feedback

Consider the target error probability $\epsilon=10^{-3}$ and the BSC ( 0.11 ) with feedback. Using Facts 1 and 3 ,

$$
\begin{equation*}
C=0.5, \quad C_{1}=2.3527, \quad C_{2}=3.0163 \tag{160}
\end{equation*}
$$

One can verify that this setting satisfies the technical conditions in [13]. Thus, by Theorem 1 of Naghshvar et al.,

$$
\begin{equation*}
\mathbb{E}[\tau] \leq \frac{\log M+\log \log M+3.317}{0.5}+4.6609+5341.38 \tag{161}
\end{equation*}
$$

which turns out to be a much loose bound. The corresponding achievability bound even falls out of the average blocklength region of interest, thus is omitted from the simulation plot.

Fig. 4 shows the numerical comparison of the upper and lower bounds, and the actual performance of the SED encoder for the BSC with crossover probability $p=0.11$ and $\epsilon=10^{-3}$. Due to the exponential encoding complexity, we were only able to simulate message lengths from $k=1$ to $k=20$. Despite that Corollary 1 is a better result compared to Theorem 1, the resulting achievability bound still falls beneath Polyanskiy's achievability bound on rate for a system

limited to stop feedback. In contrast, our BSC achievability bound from Theorem 4 exceeds Polyanskiy's achievability result in [11]. Indeed, this should be expected since a system that employs full, noiseless feedback should perform better than a system with stop feedback. In particular, the refined achievability bound from Theorem 7 is a further improvement compared to Theorem 4.

## VII. Implications on the Reliability Function

In this section, we show that our SED encoder for the regularized BAC with feedback attains both capacity and Burnashev's optimal error exponent.

Let $\mathfrak{c}$ be a variable-length coding scheme such that for each positive number $l$, one out of $M_{\mathfrak{c}_{l}}$ equiprobable messages is transmitted at an error probability $P_{e, \mathfrak{c}}$ and with an average blocklength $\mathbb{E}_{\mathfrak{c}_{l}}[\tau]$. We say that the scheme $\mathfrak{c}$ achieves rate $R$ if for any small numbers $\delta>0, \epsilon \in[0,1)$ and all sufficiently large $l$, the following three conditions hold:

$$
\begin{align*}
P_{e, \mathfrak{c}_{l}} & \leq \epsilon  \tag{162a}\\
M_{\mathfrak{c}_{l}} & \geq 2^{l(R-\delta)}  \tag{162b}\\
\mathbb{E}_{\mathfrak{c}_{l}}[\tau] & \leq l \tag{162c}
\end{align*}
$$

Furthermore, if the scheme $\mathfrak{c}$ satisfies 162b, 162c and a stronger condition

$$
\begin{equation*}
P_{e, \mathfrak{c}_{l}} \leq 2^{-l(E-\delta)} \tag{163}
\end{equation*}
$$

for some positive real number $E$, then we say the scheme $\mathfrak{c}$ achieves error exponent $E$ at rate $R$.

We invoke a general result from [13] to show our claim.
Lemma 12 (Lemma 4, [13]). Suppose that we have a VLF coding scheme $\mathfrak{c}$ that for each message size $M>0$ and each positive $\epsilon>0$, satisfies $P_{e, \mathfrak{c}} \leq \epsilon$ with expected stopping time

$$
\begin{equation*}
\mathbb{E}_{\mathfrak{c}}[\tau] \leq\left(\frac{\log M}{R_{\min }}+\frac{\log \frac{1}{\epsilon}}{E_{\min }}\right)(1+o(1)) \tag{164}
\end{equation*}
$$

for some positive numbers $E_{\min }$ and $R_{\min }$, where $o(1) \rightarrow 0$ as $\epsilon \rightarrow 0$ or $M \rightarrow \infty$. Then, the scheme $\mathfrak{c}$ can achieve any rate $R \in\left[0, R_{\text {min }}\right]$ with error exponent $E$, if

$$
\begin{equation*}
E \leq E_{\min }\left(1-\frac{R}{R_{\min }}\right) \tag{165}
\end{equation*}
$$

Observe that in Theorem 4 and Theorem 7, both upper bounds can be relaxed and written in the form of

$$
\begin{equation*}
\frac{\log M}{C}+\frac{\log \frac{1}{\epsilon}}{C_{1}}+\frac{K\left(C, C_{1}, C_{2}\right)}{C C_{1}} \tag{166}
\end{equation*}
$$

where $K\left(C, C_{1}, C_{2}\right)$ is a constant that only relies on $C, C_{1}, C_{2}$. Hence, for sufficiently large $M$ or sufficiently small $\epsilon$,

$$
\frac{K\left(C, C_{1}, C_{2}\right)}{C C_{1}} \leq \frac{C_{1} \log M+C \log \frac{1}{\epsilon}}{C C_{1}}=\frac{\log M}{C}+\frac{\log \frac{1}{\epsilon}}{C_{1}}
$$

implying that the non-asymptotic upper bounds in both Theorem 4 and Theorem 7 meet the condition in Lemma 12 , Therefore, the SED encoding scheme can achieve any rate $R \in[0, C]$ with error exponent

$$
\begin{equation*}
E \leq C_{1}\left(1-\frac{R}{C}\right) \tag{167}
\end{equation*}
$$

thus the claim is proved.

## VIII. Conclusion

In this paper, we proposed a generalized SED encoder for the class of binary asymmetric channels with full, noiseless feedback. For a BSC with feedback, this generalized SED encoder a relaxation of Naghshvar et al.'s SED encoder. This paper develops a non-asymptotic upper bound on the average blocklength of the VLF code associated with the generalized SED encoding rule. For the example of the BSC with capacity $1 / 2$, the corresponding lower bound on achievable rate for a system with full feedback is above Polyanskiy's achievability bound for a system limited to stop-feedback codes. In summary, the SED encoding rule is a powerful tool that helps facilitate new achievability bounds.

The theoretical development utilized the concept of extrinsic probabilities introduced by Naghshvar et al. to connect the generalized SED encoder to the corresponding non-asymptotic upper bound on average blocklength. The partial ordering $\pi_{1}^{*} \leq \pi_{0}^{*}$ for a regularized BAC implies that transmitting symbol 1 achieves the maximum relative entropy $C_{1}$. These observations facilitate the generalized SED encoder. However, it remains open as to whether these observations also hold for a general binary-input channel with feedback.

## Appendix I

## Proof of Fact 1

Let $\left(\pi_{0}, 1-\pi_{0}\right)$ be an input distribution to a $\operatorname{BAC}\left(p_{0}, p_{1}\right)$. Hence, $Y$ is also a binary random variable with

$$
\begin{equation*}
\mathscr{P}\{Y=0\}=\pi_{0}\left(1-p_{0}\right)+\left(1-\pi_{0}\right) p_{1} \tag{168}
\end{equation*}
$$

Therefore, the mutual information $I\left(\pi_{0}\right)$ between $X$ and $Y$ is given by

$$
\begin{align*}
& I\left(\pi_{0}\right) \\
& =h\left(\pi_{0}\left(1-p_{0}\right)+\left(1-\pi_{0}\right) p_{1}\right)-\pi_{0} h\left(p_{0}\right)-\left(1-\pi_{0}\right) h\left(p_{1}\right) \\
& =h\left(\pi_{0}\left(1-p_{0}-p_{1}\right)+p_{1}\right)-\pi_{0}\left(h\left(p_{0}\right)-h\left(p_{1}\right)\right)-h\left(p_{1}\right) . \tag{169}
\end{align*}
$$

Since mutual information $I\left(\pi_{0}\right)$ is strictly concave in $\pi_{0} \in$ $(0,1)$ [19], the optimal $\pi_{0}^{*}$ satisfies $I^{\prime}\left(\pi_{0}^{*}\right)=0$. The first derivative of $I\left(\pi_{0}\right)$ is given by

$$
\begin{align*}
I^{\prime}\left(\pi_{0}\right) & =\left(1-p_{0}-p_{1}\right) \log \left(\frac{1}{\pi_{0}\left(1-p_{0}-p_{1}\right)+p_{1}}-1\right) \\
& -\left(h\left(p_{0}\right)-h\left(p_{1}\right)\right) . \tag{170}
\end{align*}
$$

Clearly, $I^{\prime}\left(\pi_{0}\right)$ is a monotonically decreasing function in $\pi_{0} \in$ $(0,1)$. Let $z \triangleq 2^{\frac{h\left(p_{0}\right)-h\left(p_{1}\right)}{1-p_{0}-p_{1}}}$. By setting $I^{\prime}\left(\pi_{0}\right)=0$, we obtain $\pi_{0}^{*}$ in (2). Using (169) and the relation $\pi_{1}^{*}=1-\pi_{0}^{*}$, we obtain capacity $C$ in (1) and $\pi_{1}^{*}$ in (3).

To show that $p_{0} \in(0,1 / 2)$ and $p_{0} \leq p_{1} \leq 1-p_{0}$ imply $\pi_{0}^{*} \geq 1 / 2$, it suffices to show that

$$
\begin{equation*}
I^{\prime}\left(\frac{1}{2}\right) \geq 0 \tag{171}
\end{equation*}
$$

Note that

$$
\begin{align*}
I^{\prime}\left(\frac{1}{2}\right)= & -\left(1-p_{0}-p_{1}\right) \log \left(\frac{1}{\frac{\left(1-p_{1}\right)+p_{0}}{2}}-1\right)-h\left(p_{0}\right) \\
& +h\left(1-p_{1}\right) \tag{172}
\end{align*}
$$

Therefore, it is equivalent to show that

$$
\begin{equation*}
h\left(1-p_{1}\right) \geq h\left(p_{0}\right)+\left(1-p_{1}-p_{0}\right) \log \left(\frac{1}{\frac{\left(1-p_{1}\right)+p_{0}}{2}}-1\right) \tag{173}
\end{equation*}
$$

Let us fix $p_{0} \in(0,1 / 2)$ and define $x \triangleq 1-p_{1} \in\left[p_{0}, 1-p_{0}\right]$. Then, (173) simplifies to

$$
\begin{equation*}
h(x) \geq h\left(p_{0}\right)+\left(x-p_{0}\right) \log \left(\frac{1}{\frac{x+p_{0}}{2}}-1\right) \tag{174}
\end{equation*}
$$

In order to show (174), we introduce the following useful lemma.

Lemma 13. Let $f:(0,1) \rightarrow \mathbb{R}$ be convex in $(0,1 / 2]$ and be concave in $[1 / 2,1)$. Additionally, $f(x)=-f(1-x)$. Then, $\forall x, y \in(0,1)$ with $x+y<1$,

$$
\begin{equation*}
f(x)+f(y) \geq 2 f\left(\frac{x+y}{2}\right) \tag{175}
\end{equation*}
$$

Proof: Without loss of generality, assume that $x<y$. If $y \leq 1 / 2$, 175 directly follows from convexity of $f(x)$ in $x \in(0,1 / 2]$. Now consider $y>1 / 2$. Therefore,

$$
\begin{align*}
& f\left(\frac{x+y}{2}\right)-f(y) \\
& =f\left(\frac{y+x}{2}\right)-f(1 / 2)+f(1 / 2)-f(y) \\
& \leq f\left(\frac{1-y+x}{2}\right)-f(1-y)+f(1 / 2)-f(y)  \tag{176}\\
& =f(1 / 2)-f\left(\frac{1+y-x}{2}\right)  \tag{177}\\
& \leq f\left(1-\frac{x+y}{2}\right)-f(1-x)  \tag{178}\\
& =f(x)-f\left(\frac{x+y}{2}\right) \tag{179}
\end{align*}
$$

In the above,

- (176) follows from the convexity property that for a fixed $\delta>0$,

$$
f(x)-f(x+\delta) \leq f(y)-f(y+\delta), \text { whenever } x \geq y
$$

- 177) and 179 follow from $f(x)=-f(1-x)$,
- (178) follows from the concavity property that for a fixed $\delta>0$,

$$
f(x)-f(x+\delta) \leq f(y)-f(y+\delta), \text { whenever } x \leq y
$$

This completes the proof of Lemma 13
We are now in a position to prove (174). Let $g(x) \triangleq$ $\log (1 / x-1), x \in\left[p_{0}, 1-p_{0}\right]$. Observe that $g(x)$ meets the conditions in Lemma 13 and $h^{\prime}(x)=g(x)$. Hence, appealing to Lemma 13, we obtain

$$
\begin{align*}
h(x) & =h\left(p_{0}\right)+\int_{p_{0}}^{x} g(z) \mathrm{d} z  \tag{180}\\
& =h\left(p_{0}\right)+\int_{p_{0}}^{\frac{x+p_{0}}{2}}\left(g(z)+g\left(x+p_{0}-z\right)\right) \mathrm{d} z  \tag{181}\\
& \geq h\left(p_{0}\right)+\int_{p_{0}}^{\frac{x+p_{0}}{2}} 2 g\left(\frac{x+p_{0}}{2}\right) \mathrm{d} z  \tag{182}\\
& =h\left(p_{0}\right)+\left(x-p_{0}\right) \log \left(\frac{1}{\frac{x+p_{0}}{2}}-1\right) \tag{183}
\end{align*}
$$

This implies that 174 indeed holds. Hence, $\pi_{0}^{*} \geq 1 / 2$, concluding the proof of Fact 1

## Appendix II <br> Proof of Fact 3

For brevity, let us define two distributions

$$
\begin{align*}
& P \triangleq P(Y \mid X=0)=\left[1-p_{0}, p_{0}\right]  \tag{184}\\
& Q \triangleq P(Y \mid X=1)=\left[p_{1}, 1-p_{1}\right] \tag{185}
\end{align*}
$$

Hence, it is equivalent to show that

$$
\begin{equation*}
D(Q \| P) \geq D(P \| Q) \tag{186}
\end{equation*}
$$



Fig. 5. An equivalent Markov chain from $\mathcal{S}_{n-1}$ to $\mathcal{S}_{n}$.

Let us define the function

$$
\begin{align*}
& f\left(p_{0}, p_{1}\right) \triangleq D(Q \| P)-D(P \| Q) \\
& =\left(1-p_{0}+p_{1}\right) \log \frac{p_{1}}{1-p_{0}}+\left(1+p_{0}-p_{1}\right) \log \frac{1-p_{1}}{p_{0}} \tag{187}
\end{align*}
$$

The first and second derivatives with respect to $p_{1}$ are, respectively, given by

$$
\frac{\partial f}{\partial p_{1}}=\log \frac{p_{1}}{1-p_{0}}-\log \frac{1-p_{1}}{p_{0}}+(\log e)\left(\frac{1-p_{0}}{p_{1}}-\frac{p_{0}}{1-p_{1}}\right)
$$

$$
\begin{align*}
\frac{\partial^{2} f}{\partial p_{1}^{2}}= & \frac{-(\log e)\left(2 p_{1}-1\right)\left(p_{1}-1+p_{0}\right)}{p_{1}^{2}\left(1-p_{1}\right)^{2}}  \tag{188}\\
& \begin{cases}<0, & \text { if } p_{1} \in\left[p_{0}, 1 / 2\right) \\
\geq 0, & \text { if } p_{1} \in\left[1 / 2,1-p_{0}\right]\end{cases} \tag{189}
\end{align*}
$$

Hence, for a given $p_{0} \in(0,1 / 2), f\left(p_{0}, p_{1}\right)$ is concave in $p_{1} \in\left[p_{0}, 1 / 2\right]$ and is convex in $p_{1} \in\left[1 / 2,1-p_{0}\right]$. Next, we borrow a classical result in analysis [20].
Lemma 14. Consider a function $\phi: I \rightarrow \mathbb{R}$ defined on an interval $I \triangleq[a, b]$ with $a<b$. If the first derivative $\phi^{\prime}(x)$ is continuous on $I$ and the second derivative $\phi^{\prime \prime}(x)$ exists for every $x \in I^{o} \triangleq(a, b)$, then the following two properties hold

1) if $\phi^{\prime \prime}(x) \geq 0, x \in I^{o}$, and $\phi^{\prime}\left(x^{*}\right)=0$ for some $x^{*} \in I$, then $\phi(x) \geq \phi\left(x^{*}\right)$ for all $x \in I$.
2) If $\phi^{\prime \prime}(x) \leq 0, x \in I^{o}$, then $\phi(x) \geq \min \{\phi(a), \phi(b)\}$ for all $x \in I$.

By Lemma 14 for $p_{1} \in\left[p_{0}, 1 / 2\right]$, due to concavity,

$$
\begin{align*}
f\left(p_{0}, p_{1}\right) & \geq \min \left\{f\left(p_{0}, p_{0}\right), f\left(p_{0}, 1 / 2\right)\right\}  \tag{191}\\
& =\min \left\{0, f\left(p_{0}, 1 / 2\right)\right\} \tag{192}
\end{align*}
$$

Similarly, for $p_{1} \in\left[1 / 2,1-p_{0}\right]$, due to convexity and the fact that $\left.\frac{\partial f}{\partial p_{1}}\right|_{p_{1}=1-p_{0}}=0$,

$$
\begin{equation*}
f\left(p_{0}, p_{1}\right) \geq f\left(p_{0}, 1-p_{0}\right)=0 \tag{193}
\end{equation*}
$$

implying that $f\left(p_{0}, 1 / 2\right) \geq 0$. Combining this with 192 and (193), we conclude that $f\left(p_{0}, p_{1}\right) \geq 0$ for all $p_{1} \in\left[p_{0}, 1-p_{0}\right]$, thus establishing (186). This completes the proof of (7).

Next, we prove (8). This is equivalent to showing that $p_{1}(1-$ $\left.p_{1}\right) \geq p_{0}\left(1-p_{0}\right)$, which clearly holds when $p_{0} \leq p_{1} \leq 1-p_{0}$.

## Appendix III

Time of First Passage Analysis
In this section, we compute the expected first-passage time from $\mathcal{S}_{0}$ to $\mathcal{S}_{n}$ for the generalized Markov chain, as depicted in Fig. 2. Consider the general case where the self loop for
state $\mathcal{S}_{0}$ has weight $\Delta_{0}$ (i.e., the expected self loop time from $\mathcal{S}_{0}$ to $\mathcal{S}_{0}$ ), and all other transitions in graph has weight 1 . Let $v_{i}$ denote the expected first-passage time from $\mathcal{S}_{i}$ to $\mathcal{S}_{n}$, $0 \leq i \leq n-1$. Our goal is to compute $v_{0}$, which is equal to $\mathbb{E}\left[\tau_{i}^{*}-\nu_{i} \mid \theta=i, U_{i}\left(\nu_{i}\right)=u\right]$.

This appendix computes $v_{0}$ by first simplifying the expected first-passage time node equations into an expression involving only $v_{0}$ and $v_{n-1}$. Characterizing the entire process to the left of $\mathcal{S}_{n-1}$ as a self loop with weight $\Delta_{n-1}$ yields an explicit expression for $v_{n-1}$. This eventually produces an expression for $v_{0}$ that naturally decomposes into the expected first-passage time for a classical random walk plus a differential term.

## A. Simplifying Node Equations

Following [21, Chapter 4.5.1], the node equations for the generalized Markov chain in Fig. 2 are as follows:

$$
\begin{align*}
v_{n-1} & =1+p v_{n-2}  \tag{194a}\\
v_{n-2} & =1+p v_{n-3}+q v_{n-1},  \tag{194b}\\
v_{n-3} & =1+p v_{n-4}+q v_{n-2}  \tag{194c}\\
& \vdots \\
v_{2} & =1+p v_{1}+q v_{3}  \tag{194d}\\
v_{1} & =1+p v_{0}+q v_{2}  \tag{194e}\\
v_{0} & =q+p v_{0}+q v_{1}+p \Delta_{0} . \tag{194f}
\end{align*}
$$

Summing all equations in 194, yields

$$
\begin{equation*}
\sum_{i=0}^{n-1} v_{i}=n-1+q+\sum_{i=1}^{n-2} v_{i}+q v_{n-1}+2 p v_{0}+p \Delta_{0} \tag{195}
\end{equation*}
$$

Solving for $v_{0}$ yields

$$
\begin{equation*}
v_{0}=\frac{n}{1-2 p}+\frac{p}{1-2 p}\left(\Delta_{0}-v_{n-1}-1\right) \tag{196}
\end{equation*}
$$

Thus, what remains to determine $v_{0}$ is to determine $v_{n-1}$.

## B. Expressing $v_{n-1}$ in Terms of $\Delta_{0}$

In this subsection, we aim to express $v_{n-1}$ in terms of $\Delta_{0}$. By characterizing the entire process to the left of $\mathcal{S}_{n-1}$ as a self loop with weight $\Delta_{n-1}$ and transition probability $p$, the generalized Markov chain in Fig. 2 reduces to a two-state Markov chain as shown in Fig. 5 The node equation at $\mathcal{S}_{n-1}$ in Fig. 5 is given by

$$
\begin{equation*}
v_{n-1}=p \Delta_{n-1}+q+p v_{n-1} \tag{197}
\end{equation*}
$$

Solving for $v_{n-1}$ yields

$$
\begin{equation*}
v_{n-1}=\frac{p}{q} \Delta_{n-1}+1 \tag{198}
\end{equation*}
$$

Next, we develop an recursive equation to solve $\Delta_{n-1}$. Let $\Delta_{i}$ denote the expected self loop weight for $\mathcal{S}_{i}, 0 \leq i \leq n-1$. Fig. 6 shows the transition between $\mathcal{S}_{i-1}$ and $\mathcal{S}_{i}$ conditioned on circling over $\mathcal{S}_{i}$ once. Thus, from Fig. 6, we obtain

$$
\begin{align*}
\Delta_{i} & =1+\sum_{k=0}^{\infty} p^{k} q\left(k \Delta_{i-1}+1\right)  \tag{199}\\
& =2+\frac{p}{q} \Delta_{i-1} \tag{200}
\end{align*}
$$



Fig. 6. Recursive relation between $\Delta_{i}$ and $\Delta_{i-1}$.

Since 200 holds for an arbitrary $i, 0 \leq i \leq n-1$, applying (200) in a recursive manner yields

$$
\begin{equation*}
\Delta_{n-1}=\left(\frac{p}{q}\right)^{n-1} \Delta_{0}+\frac{2 q}{1-2 p}\left[1-\left(\frac{p}{q}\right)^{n-1}\right] \tag{201}
\end{equation*}
$$

Substituting 201) into 198, we obtain

$$
\begin{equation*}
v_{n-1}=\left(\frac{p}{q}\right)^{n} \Delta_{0}+\frac{2 p}{1-2 p}\left[1-\left(\frac{p}{q}\right)^{n-1}\right]+1 \tag{202}
\end{equation*}
$$

## C. Finding the General Expression for $v_{0}$

Substituting 202 into 196,

$$
\begin{align*}
v_{0}= & \frac{n}{1-2 p}+\frac{p}{1-2 p}\left\{\left[1-\left(\frac{p}{q}\right)^{n}\right] \Delta_{0}\right. \\
& \left.-\frac{2 p}{1-2 p}\left[1-\left(\frac{p}{q}\right)^{n-1}\right]-2\right\}  \tag{203}\\
= & \frac{n}{1-2 p}+\frac{p}{1-2 p}\left(1-\left(\frac{p}{q}\right)^{n}\right)\left(\Delta_{0}-\frac{2 q}{1-2 p}\right) \tag{204}
\end{align*}
$$

This completes the derivation of $v_{0}$.
Remark 4. For an independent and identically distributed (i.i.d.) random walk that moves forward by 1 with probability $q$ and moves backward by 1 with probability $p$, all $\Delta_{i}$ 's are identical. Using (200), we obtain

$$
\begin{equation*}
\Delta_{i}=\frac{2 q}{1-2 p}, \quad \forall i \in \mathbb{Z} \tag{205}
\end{equation*}
$$

Thus, 204 can be thought of as the expected first-passage time for an i.i.d. random walk plus a differential term that depends on the difference between the self loop weight $\Delta_{0}$ of the actual random process and the self loop weight of a standard i.i.d. random walk.
