# ORBITAL STABILITY OF TWO-COMPONENT PEAKONS

#### Abstract

We prove that the two-component peakon solutions are orbitally stable in the energy space. The system concerned here is a two-component Novikov system, which is an integrable multi-component extension of the integrable Novikov equation. We improve the method for the scalar peakons to the two-component case with genuine nonlinear interactions by establishing optimal inequalities for the conserved quantities involving the coupled structures. Moreover, we also establish the orbital stability for the train-profiles of these twocomponent peakons by using the refined analysis based on monotonicity of the local energy and an induction method.


Key words: Novikov equation, two-component Novikov system, peakons, orbital stability, conservation law, Camassa-Holm equation.

## 1. Introduction

In this paper, we are devoted to the orbital stability of the two-component peakon solutions and the corresponding configuration of train-profiles. The system we are concerned with is the following integrable two-component Novikov system 32]

Note that this system reduces to the well-studied integrable Novikov equation [28, 45]

when $v=u$.
Since the celebrated work [4] by Camassa and Holm, in which they first discovered the nonsmooth peaked soliton solutions (called peakons) to the Camassa-Holm (CH) equation, the existence of peakons and multi-peakons is one of the significant properties of the integrable CH-type equations. The basic wave profile of a peakon takes a quite compact form

where $c \in \mathbb{R}$ is the wave speed and the amplitude $a(c)$ is a function related to $c$. Remarkably, the seemingly simple form of the peakon displays the deep relationship with some important phenomena of wave propagation in shallow water waves. Indeed, due to the discussion in [12, 13, 51], the feature of the peakons that their profile (1.3) is smooth, except at the crest where it is continuous but the lateral tangents differ, is similar to that of the so-called Stokes waves of greatest height, i.e. traveling waves of largest possible amplitude which are solutions to the governing equations for irrotational water waves. There is no closed forms available for these waves, and the peakons can capture these described essential features. It is well-understood that the CH equation

and the Degasperis-Procesi (DP) equation

both arise as the appropriate asymptotic approximations of the Euler equations for the freesurface shallow water waves in the moderately nonlinear regime [15], and admit the following peakon solutions $(c>0$, and anti-peakon for $c<0)$ in the line [4, 5, 6, 19, 31, 38]

On the other hand, the peakons and the corresponding multi-peakons admit a rich mathematical structure related to the underlying integrable features. Indeed, both the CH and DP equations are integrable equations with Lax-pair formulations, and the inverse scattering approach can be used to derive explicitly these peakons (1.4) and the related multi-peakon solutions [1, 18, 39. In the past ten years, two typical CH-type integrable equations with cubic nonlinearity that support peakon dynamics attracted much attention. One is the Novikov equation (1.2), whose peakon solutions take the form of [28]

Another one is the modified Camassa-Holm $(\mathrm{mCH})$ equation 46

which has the following peakon structure [25]

u(t, x)=\varphi_{c}(x-c t)=\sqrt{\frac{3 c}{2}} e^{-|x-c t|}, \quad c>0

Although the physical background of the Novikov and mCH equations is not so clear, their peakon and multi-peakon dynamics are demonstrated to have several non-trivial properties in the framework of Lax integrability (see the discussion in [8, 27, etc).

In this paper, special concern for these peakon solutions is the issue of their stability, which lies in the fact that they are the explicit weak solutions in the sense of distribution to the corresponding equations. The peakon equations exhibit different features in contrast with the classical integrable equations such as the KdV equation, the modified KdV equation and the Schrödinger equation that admit the smooth solitions, especially in the study of qualitative properties related to stability and instability. There are huge number of papers to study the stability and instability of solitons for classical integrable systems. We don't attempt to exhaust all the literatures, one can refer to [2, 3, 7, 23, 24, 47] for stability issue and [42, 43, 48] for the issue of asymptotic stability, as well as the references therein. Note that the peakons don't admit the classical second-order derivatives and the linearized operators at peakons appear to be degenerate. So the classical methods based on the spectral analysis are not available in the case of peakons. In an intriguing paper due to Constantin and Strauss [17], they proved the orbital stability of peakons for the CH equation by discovering several precise optimal inequalities relating to the maximum value of the approximate solutions and the conserved quantity of quadratic form and higher-order conserved quantity (see also [16] for a variational argument and [30] for the periodic case). This approach in [17] was further developed by Dika and Molinet [20] to study orbital stability of the train of peakons to the CH equation. Orbital stability of peakons and the train of peakons of other CH-type integrable equations were investigated in [29, 34, 35, 36, 37, 50. More recently, the issue of instability of peakons for the CH equation and the Novikov equation are addressed in 44 and [11, respectively.

Compared with the rich results of the stability or instability properties of peakons for the CH-type integrable equations of scalar form, the corresponding work for the multicomponent peakon profiles is quite a few. It is worth noticing that multi-component CHtype integrable systems, that are verified to admit the peakon structures as the distributional
solutions, are very rare up to now. A celebrated integrable multi-component extension to the CH equation is the so-called two-component CH system [9, 14, 46]

However, system (1.5) does not admit the peaked solitons [26. The orbital stability of a kind of reduced peakon profile was studied via variational method [10. The Novikov equation (1.2) admits the following two-component integrable extension, called the Geng-Xue system [22],

which has been paid much attention recently [33, 40, 41]. Although system (1.6) supports the multi-peakon structures, they are derived in the framework of Lax-pair formulation of (1.6) (see [41]), which are not weak solutions in the sense of distribution. To the best of our knowledge, there is no work to study orbital stability of multi-component peakons for integrable multi-component CH-type equations.

Recently, another kind of two-component integrable generalization (1.1) of the Novikov equation (1.2) was introduced in [32] and we find that this system admits the two-component peakon structure, which are given by

traveling at constant speed $c=a b \neq 0$. It is demonstrated that these peakons (1.7) are indeed the weak solutions of (1.1) in the distribution form

where $P(x)=e^{-|x|} / 2$ and $*$ stands for convolution with respect to the spatial variable $x \in \mathbb{R}$. Here a question arises: are these multi-component peakons and the corresponding train-profiles for system (1.1) stable in the energy space?

System (1.1) adapts the following conserved densities

and

which will play prominent role in proving stability of peakons, while the corresponding three conserved quantities of Novikov equation (1.2) are

If we choose $u=v$, then we have $H_{0}=E_{0}[u, u], E[u]=E_{u}[u]=E_{v}[v]=H[u, v]$ and $F[u, v]=F[u]$. Due to the existence of the $H^{1}$ conservation law respectively for the $u$ and $v$-components as well as the mutual interaction conservation laws $H[u, v]$, it is expected to prove stability for the two-component Novikov system in the sense of the energy space of $H^{1} \times H^{1}$-norm. In general, a small perturbation of a solitary wave can yield another one with a different speed and phase shift. It is appropriate to define the orbit of traveling-wave
solutions $\left(\varphi_{c}, \psi_{c}\right)$ to be the set $U(\varphi, \psi)=\left\{\left(a \varphi\left(\cdot+x_{1}\right), b \psi\left(\cdot+x_{2}\right)\right), x_{1} \in \mathbb{R}, x_{2} \in \mathbb{R}\right\}$. However, if $x_{1} \neq x_{2}$, the functionals $F\left[\varphi_{c}, \psi_{c}\right]$ and $H\left[\varphi_{c}, \psi_{c}\right]$ are not conserved in the time evolution for $\left(\varphi_{c}, \psi_{c}\right)$ in this set $U(\varphi, \psi)$. Thus, we consider here a suitable orbit of the travelingwave solutions $\varphi_{c}$ and $\psi_{c}$ to be the set $U_{0}(\varphi, \psi)=\left\{\left(a \varphi\left(\cdot+x_{0}\right), b \psi\left(\cdot+x_{0}\right)\right), x_{0} \in \mathbb{R}\right\}$ and the peakon solutions of the two-component Novikov equation are called orbitally stable if a wave standing close to the peakon remains close to the orbit $U_{0}(\varphi, \psi)$ at all the later existence time.

The first main result is stated as follows. Here, we only consider the case of peakons traveling to the right, i.e. the case of $a>0, b>0$ and then $c=a b>0$ in (1.7).

Theorem 1.1. Let $\left(\varphi_{c}, \psi_{c}\right)$ be the peaked solitons in (1.7), traveling with speed $c=a b>0$. Then $\left(\varphi_{c}, \psi_{c}\right)$ are orbitally stable in the following sense. Assume that $u_{0}, v_{0} \in H^{s}(\mathbb{R})$ for some $s \geq 3$, $\left(1-\partial_{x}^{2}\right) u_{0}(x)$ and $\left(1-\partial_{x}^{2}\right) v_{0}(x)$ are nonnegative, and there is a $\delta>0$ such that

Then the corresponding solution $(u(t, x), v(t, x))$ of the Cauchy problem for the two-component Novikov system (1.1) with the initial data $u(0, x)=u_{0}(x)$ and $v(0, x)=v_{0}(x)$ satisfies

where $T>0$ is the maximal existence time, $\xi(t) \in \mathbb{R}$ is the maximum point of the function $u(t, x) v(t, x)$, the constant $A$ depends only on $a, b$ as well as the norms $\left\|u_{0}\right\|_{H^{s}(\mathbb{R})}$ and $\left\|v_{0}\right\|_{H^{s}(\mathbb{R})}$.

To prove orbital stability of the two-component peakons $\left(\varphi_{c}, \psi_{c}\right)$, some new insights are developed. We aim to obtain for each component $u$ and $v$ the dynamical estimates $|u(t, \xi(t))-a|$ and $|v(t, \xi(t))-b|$ along some trajectory $t \mapsto \xi(t)$, where $a$ and $b$ are the maximal value of the component $\varphi_{c}$ and $\psi_{c}$, respectively. Here, due to the nonlinear interaction between $u$ and $v$ involved in system (1.1), the key obstacle is how to find the suitable location of $\xi(t)$ in order to derive the precise estimates for $|u(t, \xi(t))-a|$ and $|v(t, \xi(t))-b|$ (note that in the case of scalar peakons such $\xi(t)$ is always chosen to locate at the maximal point of perturbed solution, which is no longer valid in the multi-component case considered here and $\xi(t)$ must change according to the appearance of characteristic speed of nonlinear interaction $u v$ ). Moreover, the dynamical energy identities and energy inequalities should involve the nonlinear interaction of the two components. In addition, the conservation law $F[u, v]$ is much more complicated than $F[u]$ of the Novikov equation. Therefore, the stability issue of the two-component peakon solutions is more subtle. To overcome the difficulties, two observations will be crucial. System (1.1) not only has the separated $H^{1}$ conserved quantities $\int\left(u^{2}+u_{x}^{2}\right) d x$ and $\int\left(v^{2}+v_{x}^{2}\right) d x$ with which one can derive the pointwise estimates separately for each component $u$ and $v$, but also the second-order interacting conserved quantity $H[u, v]=\int\left(u v+u_{x} v_{x}\right) d x$ with which we are motivated to find the exact location of $\xi(t)$ as the maximal point of the multiplication function $u(t, \cdot) v(t, \cdot)$ of two components. This argument is quite different from the case for the scalar CH-type equations. On the other hand, new optimal energy identities for $H[u, v]$ and $F[u, v]$ are established. The new insight is that the precise control of two components is involved in one optimal energy identity. This point is also different from the scalar case. Based on these observations together with corresponding refined analysis, we are able to prove orbital stability of the two-component peakons $\left(\varphi_{c}, \psi_{c}\right)$ on the line $\mathbb{R}$.

Remark 1.1. For the Geng-Xue system (1.6), even though the peakon solutions in the Lax-pair sense are considered, system (1.6) does not admit sufficient conserved quantities to establish the corresponding estimates for the stability.

For the issue of orbital stability of train-profiles of these two-component peakons, we have the following result.
Theorem 1.2. Let be given $N$ velocities $c_{1}, c_{2}, \cdots, c_{N}$ such that $0<a_{1}<a_{2}<\ldots<a_{N}$, $0<b_{1}<b_{2}<\ldots<b_{N}$ and $c_{i}=a_{i} b_{i}$ for any $i \in\{1, \ldots, N\}$. There exist $A>0, L_{0}>0$ and $\epsilon_{0}>0$ such that if the initial data $\left(u_{0}, v_{0}\right) \in H^{s}(\mathbb{R}) \times H^{s}(\mathbb{R})$ for some $s \geq 3$ with $\left(1-\partial_{x}^{2}\right) u_{0}(x)$ and $\left(1-\partial_{x}^{2}\right) v_{0}(x)$ being nonnegative, satisfy

for some $0<\epsilon<\epsilon_{0}$ and $z_{i}^{0}-z_{i-1}^{0} \geq L$ with $L>L_{0}$, then there exist $x_{1}(t), \ldots, x_{N}(t)$ such that the corresponding strong solution $(u(t, x), v(t, x))$ satisfies

$\forall t \in[0, T)$, where $x_{j}(t)-x_{j-1}(t)>L / 2$.
In general, two main ingredients in the proof of orbital stability for the train-proflies of peakons are involved [20, 36, 43]. One is orbital stability of the single peakons, and the another one is the property of almost monotonicity of the local energy on the right hand side of the peakons. For the two-component peakons, more difficulties come from the interaction of the two components $u(t, x)$ and $v(t, x)$. The first one is how to establish inequalities among the localized conserved quantities to verify the orbital stability of the two-component peakons separately. For the train-profiles of peakons, we need to apply $N$ inequalities to control $2 N$ estimates. The second one is to establish monotonicity result of the functionals $\mathcal{J}_{j, k}^{u, v}(t)$ since we can not identify the sign for the term $u_{x} v_{x}$ in the conserved density $H[u, v]$. To overcome the difficulties, we use the conserved densities $E_{u}[u], E_{v}[v]$, $H[u, v]$ and $F[u, v]$, and establish the delicate inequalities relating to the conserved densities and the maximal value of the two components $u(t, x)$ and $v(t, x)$. And in the case of trainprofile of two-component peakons, we apply the proof of the single peakons, the modulation theory, the accurate estimates on the conserved densities $E_{u}[u], E_{v}[v], H[u, v]$ and $F[u, v]$ and the induction method to obtain the desired result.

The remainder of the paper is organized as follows. In Section 2, we provide a brief discussion on the integrability, conservation laws, the sign invariant property of $m(t, x)$ and $n(t, x)$ of system (1.1), and local well-posedness result on Cauchy problem of system (1.1). In Section 3, we prove orbital stability of single peakons on the line. Finally in Section 4, we verify orbital stability of the train of peakons.

## 2. Preliminaries

In the present section, the issue of well-posedness is discussed. First of all, we call that functions $(u, v) \in C\left([0, T) ; H^{1}(\mathbb{R})\right) \times C\left([0, T) ; H^{1}(\mathbb{R})\right)$ is a solution of system (1.1), if $(u, v)$ is a solution of (1.8) in the sense of distributions and $E_{u}[u], E_{v}[v], H[u, v]$ and $F[u, v]$ are conserved quantities.

Consider the following Cauchy problem of system (1.1) in the whole line $\mathbb{R}$

First, similar to the results for the two-component CH system given in 21], one can establish the following local well-posedness result.

Theorem 2.1. Given $z_{0}=\left(u_{0}, v_{0}\right)^{T} \in H^{s}(\mathbb{R}) \times H^{s}(\mathbb{R})(s>3 / 2)$, there exists a maximal $T=T\left(\left\|z_{0}\right\|_{H^{s}(\mathbb{R}) \times H^{s}(\mathbb{R})}\right)>0$ and a unique strong solution $z=(u, v)^{T}$ to (2.1) such that

In addition, the solution depends continuously on the initial data, i.e. the mapping
$z_{0} \rightarrow z\left(\cdot, z_{0}\right): H^{s}(\mathbb{R}) \times H^{s}(\mathbb{R}) \rightarrow C\left([0, T) ; H^{s}(\mathbb{R}) \times H^{s}(\mathbb{R})\right) \cap C^{1}\left([0, T) ; H^{s-1}(\mathbb{R}) \times H^{s-1}(\mathbb{R})\right)$ is continuous. Furthermore, the quantities $E_{u}[u], E_{v}[v], H[u, v]$ and $F[u, v]$ are all conserved along the solution $z=(u, v)^{T}$.

Consider the flow governed by $(u v)(t, x)$

Just as the case for the Novikov equation (1.2), the following lemma can be proved.
Lemma 2.1. Assume that $\left(u_{0}, v_{0}\right) \in H^{s}(\mathbb{R}) \times H^{s}(\mathbb{R})$ with $s>3 / 2$ and $T>0$ be the maximal existence time of the corresponding strong solution $(u, v)$ to the Cauchy problem of system (2.1). Then the problem (2.2) has a unique solution $q(t, x) \in C^{1}([0, T) \times \mathbb{R})$. Furthermore, the map $q(t, \cdot)$ is an increasing diffeomorphism over $\mathbb{R}$ with

Lemma 2.2. Let $u_{0}, v_{0} \in H^{s}(\mathbb{R}), s \geq 3$. Assume that $m_{0}=u_{0}-u_{0 x x}$ and $n_{0}=v_{0}-v_{0 x x}$ are nonnegative in the line. Then for the corresponding strong solution $u, v \in C\left([0, T) ; H^{s}(\mathbb{R})\right) \cap$ $C^{1}\left([0, T) ; H^{s-1}(\mathbb{R})\right)$ of the Cauchy problem of the two-component Novikov system (2.1) with the initial data $u_{0}, v_{0}$, we have for all $t \in[0, T), m(t, x)$ and $n(t, x)$ are both nonnegative functions. In addition, $u(t, \cdot) \geq 0, v(t, \cdot) \geq 0$ and $\left|u_{x}(t, \cdot)\right| \leq u(t, \cdot),\left|v_{x}(t, \cdot),\right| \leq v(t, \cdot)$ on the line.

Proof. It follows from the Cauchy problem (2.1) of the two-component Novikov system that along the flow (2.2), $m$ and $n$ satisfy

m^{\prime}+\left(2 v u_{x}+u v_{x}\right)(t, q(t, x)) m(t, q(t, x))=0  \tag{2.4}\\
n^{\prime}+\left(2 u v_{x}+v u_{x}\right)(t, q(t, x)) n(t, q(t, x))=0
\end{array}\right.
$$

where ${ }^{\prime}$ denotes the derivative with respect to $t$ along the flow (2.2). Denote
$\gamma_{1}(t, x)=\exp \left(\int_{0}^{t}\left(2 v u_{x}+u v_{x}\right)(s, q(s, x)) d s\right), \gamma_{2}(t, x)=\exp \left(\int_{0}^{t}\left(2 u v_{x}+v u_{x}\right)(s, q(s, x)) d s\right)$.
Then they satisfy

$$
\gamma_{1}^{\prime}(t, x)=\left(2 v u_{x}+u v_{x}\right)(t, q(t, x)) \gamma_{1}, \quad \gamma_{2}^{\prime}(t, x)=\left(2 u v_{x}+v u_{x}\right)(t, q(t, x)) \gamma_{2}
$$

Let

$$
\tilde{m}(t, x)=\gamma_{1}(t, x) m(t, q(t, x)), \quad \tilde{n}(t, x)=\gamma_{2}(t, x) n(t, q(t, x)) .
$$

(2.4) become

$$
\begin{equation*}
\tilde{m}^{\prime}(t, x)=0, \quad \tilde{n}^{\prime}(t, x)=0 \tag{2.5}
\end{equation*}
$$

The equations

$$
\tilde{m}(t, x)=m_{0} \quad \text { and } \quad \tilde{n}(t, x)=n_{0}
$$

lead to

$$
\begin{aligned}
& m(t, q(t, x))=\exp \left(-\int_{0}^{t}\left(2 v u_{x}+u v_{x}\right)(s, q(s, x)) d s\right) m_{0} \\
& n(t, q(t, x))=\exp \left(-\int_{0}^{t}\left(2 u v_{x}+v u_{x}\right)(s, q(s, x)) d s\right) n_{0}
\end{aligned}
$$

Thus, for all $t \in[0, T)$, we have $m(t, \cdot) \geq 0, n(t, \cdot) \geq 0$. And then $u(t, \cdot) \geq 0, v(t, \cdot) \geq 0$.
Formally regarding $m(x)=u(x)-u_{x x}(x)$, it holds that for all $x \in \mathbb{R}$,

Then we infer that

Similarly, we find

This completes the proof of the lemma.

## 3. Stability of two-component peakons

In this section, we prove Theorem 1.1, which will be based on a series of lemmas. Note that the assumptions on the initial profile guarantee the existence of a unique positive solution for the Cauchy problem (2.1) of the two-component Novikov system. In general, for $a>0$ and $b>0$, the profile functions of peakon solutions $\varphi_{c}(x)=a e^{-|x|}$ and $\psi_{c}(x)=b e^{-|x|}$ are in $H^{1}(\mathbb{R})$, which have peaks at $x=0$, and thus

\max _{x \in \mathbb{R}} \varphi_{c}(x)=\varphi_{c}(0)=a \quad \text { and } \quad \max _{x \in \mathbb{R}} \psi_{c}(x)=\psi_{c}(0)=b
$$

A direct calculation gives

$$
E_{u}\left[\varphi_{c}(x)\right]=\left\|\varphi_{c}\right\|_{H^{1}}^{2}=2 a^{2}, \quad E_{v}\left[\psi_{c}(x)\right]=\left\|\psi_{c}\right\|_{H^{1}}^{2}=2 b^{2}
$$

and

$$
H\left[\varphi_{c}(x), \psi_{c}(x)\right]=2 a b, \quad F\left[\varphi_{c}(x), \psi_{c}(x)\right]=\frac{4}{3} a^{2} b^{2}
$$

Due to the conservation of the $H^{1}$-norm of each component $u$ and $v$, the following pointwise identities still hold for the two-component Novikov system as in the scalar CH and Novikov cases.

Lemma 3.1. For any $u, v \in H^{1}(\mathbb{R})$ and $\xi \in \mathbb{R}$, we have

& E_{u}[u]-E_{u}\left[\varphi_{c}\right]=\left\|u-\varphi_{c}(\cdot-\xi)\right\|_{H^{1}(\mathbb{R})}^{2}+4 a(u(\xi)-a),  \tag{3.1}\\
& E_{v}[v]-E_{v}\left[\psi_{c}\right]=\left\|v-\psi_{c}(\cdot-\xi)\right\|_{H^{1}(\mathbb{R})}^{2}+4 b(v(\xi)-b) .
\end{align*}
$$

In the following two lemmas, two energy identities relating some kind of critical values of $u$ and $v$ to the invariants $H[u, v]$ and $F[u, v]$ are established. Consider $0 \not \equiv u, v \in H^{s}(\mathbb{R})$, $s \geq 3$, and $u, v \geq 0$. Then $u, v \in C^{2}$ due to the Sobolev imbedding theory. Since $u$ and $v$ decay at infinity, it must have a point with global maximal value of the multiplication function $u(x) v(x)$. Thus, in the following, set for some $\xi \in \mathbb{R}$

M=\max _{x \in \mathbb{R}}\{u(x) v(x)\}=u(\xi) v(\xi) . \tag{3.2}
\end{equation*}

Lemma 3.2. Let $0 \not \equiv u, v \in H^{s}(\mathbb{R}), s \geq 3$ and $u, v \geq 0$. Define the functions $g_{1}(x)$ and $g_{2}(x)$ by

\end{equation*}
$$

Proof. To show (3.5), we evaluate the integral of $g_{1}(x) g_{2}(x)$ on $\mathbb{R}$. Thus,

& \int_{\mathbb{R}} g_{1}(x) g_{2}(x) d x \\
& =\int_{-\infty}^{\xi}\left(u(x)-u_{x}(x)\right)\left(v(x)-v_{x}(x)\right) d x+\int_{\xi}^{\infty}\left(u(x)+u_{x}(x)\right)\left(v(x)+v_{x}(x)\right) d x \\
& =\int_{-\infty}^{\xi}\left(u v-(u v)_{x}+u_{x} v_{x}\right) d x+\int_{\xi}^{\infty}\left(u v+(u v)_{x}+u_{x} v_{x}\right) d x \\
& =H[u, v]-2 M
\end{aligned}
$$

The construction of the auxiliary function $h(x)$ in the following lemma is crucial in the proof of stability of peakons, which is different from the scalar cases of CH and DP equations. This new defined function is a nontrivial refinement of the case in the Novikov equation.

Lemma 3.3. With the same assumptions and notation as in Lemma 3.2, define the function $h$ by

h(x)= \begin{cases}u v-\frac{1}{3}(u v)_{x}-\frac{1}{3} u_{x} v_{x}, & x<\xi  \tag{3.6}\\ u v+\frac{1}{3}(u v)_{x}-\frac{1}{3} u_{x} v_{x}, & x>\xi\end{cases}
$$

Then

\int_{\mathbb{R}} h(x) g_{1}(x) g_{2}(x) d x=F[u, v]-\frac{4}{3} M^{2} \tag{3.7}
\end{equation*}
$$

Proof. To show (3.7), we evaluate the integral of $h(x) g_{1}(x) g_{2}(x)$ on $\mathbb{R}$. Thus,

& =\int_{-\infty}^{\xi}\left[u v-\frac{1}{3}(u v)_{x}-\frac{1}{3} u_{x} v_{x}\right]\left[u v-(u v)_{x}+u_{x} v_{x}\right] d x \\
& \quad+\int_{\xi}^{\infty}\left[u v+\frac{1}{3}(u v)_{x}-\frac{1}{3} u_{x} v_{x}\right]\left[u v+(u v)_{x}+u_{x} v_{x}\right] d x \triangleq I+\Pi .
\end{aligned}
$$

We do computation:

$$
\begin{aligned}
I & =\int_{-\infty}^{\xi}\left[u v-\frac{1}{3}(u v)_{x}-\frac{1}{3} u_{x} v_{x}\right]\left[u v-(u v)_{x}+u_{x} v_{x}\right] d x \\
& =\int_{-\infty}^{\xi}\left(u^{2} v^{2}+\frac{1}{3} u^{2} v_{x}^{2}+\frac{1}{3} v^{2} u_{x}^{2}+\frac{4}{3} u v u_{x} v_{x}-\frac{1}{3} u_{x}^{2} v_{x}^{2}\right) d x-\frac{4}{3} \int_{-\infty}^{\xi}(u v)(u v)_{x} d x \\
& =\int_{-\infty}^{\xi}\left(u^{2} v^{2}+\frac{1}{3} u^{2} v_{x}^{2}+\frac{1}{3} v^{2} u_{x}^{2}+\frac{4}{3} u v u_{x} v_{x}-\frac{1}{3} u_{x}^{2} v_{x}^{2}\right) d x-\frac{2}{3} M^{2}
\end{aligned}
$$

Similarly,

$$
\Pi=\int_{\xi}^{\infty}\left(u^{2} v^{2}+\frac{1}{3} u^{2} v_{x}^{2}+\frac{1}{3} v^{2} u_{x}^{2}+\frac{4}{3} u v u_{x} v_{x}-\frac{1}{3} u_{x}^{2} v_{x}^{2}\right) d x-\frac{2}{3} M^{2}
$$

Combining above, we have

$$
\begin{aligned}
& \int_{\mathbb{R}} h(x) g_{1}(x) g_{2}(x) d x \\
& =\int_{-\infty}^{\infty}\left(u^{2} v^{2}+\frac{1}{3} u^{2} v_{x}^{2}+\frac{1}{3} v^{2} u_{x}^{2}+\frac{4}{3} u v u_{x} v_{x}-\frac{1}{3} u_{x}^{2} v_{x}^{2}\right) d x-\frac{4}{3} M^{2}=F[u, v]-\frac{4}{3} M^{2}
\end{aligned}
$$

With the two energy identities (3.5) and (3.7) in hand, one can derive the following delicate relation between the second order conserved quantity $H[u, v]$ and the higher-order conserved quantity $F[u, v]$ for the strong solution $(u, v)$.
Lemma 3.4. Assume that $0 \not \equiv u_{0}, v_{0} \in H^{s}, s \geq 3$ and $m_{0}=u_{0}-u_{0 x x} \geq 0, n_{0}=v_{0}-v_{0 x x} \geq$ 0 . For the corresponding strong solution $(u(t, x), v(t, x))$ with initial data $\left(u_{0}, v_{0}\right)$ in the lifespan $[0, T)$, there holds

$$
\begin{equation*}
F[u, v]-\frac{4}{3} M(t) H[u, v]+\frac{4}{3} M(t)^{2} \leq 0, \quad \forall t \in[0, T) \tag{3.8}
\end{equation*}
$$

where $M(t)=\max _{x \in R}\{u(t, x) v(t, x)\}=u(t, \xi(t)) v(t, \xi(t))$ for some trajectory $\xi(t) \in \mathbb{R}$ in $[0, T)$.

Proof. First, by the sign-invariant property, the solution $(u(t, x), v(t, x))$ satisfies $m(t, x)=$ $u(t, x)-\partial_{x}^{2} u(t, x) \geq 0$ and $n(t, x)=v(t, x)-\partial_{x}^{2} v(t, x) \geq 0$ for all $(t, x) \in[0, T) \times \mathbb{R}$. It follows that $(u(t, x), v(t, x))$ is positive solution and fulfills all the conditions assumed in Lemmas 3.2 and 3.3. Hence, we have the following energy identities of the dynamical forms in $[0, T)$

\int_{\mathbb{R}} g_{1}(t, x) g_{2}(t, x) d x=H[u, v]-2 M(t) \tag{3.9}
\end{equation*}
$$

and

\begin{equation*}
\int_{\mathbb{R}} h(t, x) g_{1}(t, x) g_{2}(t, x) d x=F[u, v]-\frac{4}{3} M(t)^{2} \tag{3.10}
\end{equation*}
$$

We now claim that for any $(t, x) \in[0, T) \times \mathbb{R}$

h(t, x)=\left\{\begin{array}{ll}
\left(u v-\frac{1}{3}(u v)_{x}-\frac{1}{3} u_{x} v_{x}\right)(t, x), & x<\xi(t), \\
\left(u v+\frac{1}{3}(u v)_{x}-\frac{1}{3} u_{x} v_{x}\right)(t, x), & x>\xi(t)
\end{array} \leq \frac{4}{3} u(t, x) v(t, x)\right.
$$

In fact, due to the definition of $h(t, x)$, it follows from the fact $u(t, x) \geq\left|u_{x}(t, x)\right|$ and $v(t, x) \geq\left|v_{x}(t, x)\right|$ that

$$
h(t, x)=\frac{4}{3} u(t, x) v(t, x)-\frac{1}{3}\left(u \pm u_{x}(t, x)\right)\left(v \pm v_{x}(t, x)\right) \leq \frac{4}{3} u(t, x) v(t, x) .
$$

Thus, the combination of the above inequalities yields

h(t, x) \leq \frac{4}{3} u(t, x) v(t, x) \leq \frac{4}{3} \max _{x \in \mathbb{R}}\{u(t, x) v(t, x)\}=\frac{4}{3} M(t), \quad \forall(t, x) \in[0, T) \times \mathbb{R}
$$

Now, using estimates $\left|u_{x}\right| \leq u$ and $\left|v_{x}\right| \leq v$ again in the expressions (3.3) and (3.4), we obtain (3.8) from (3.9) and (3.10).

In the following lemma, we study the perturbation of the conserved quantities around the profile functions $\varphi_{c}(x)$ and $\psi_{c}(x)$ of peakon solutions, under the case of time independence.

Lemma 3.5. For $u, v \in H^{s}(\mathbb{R}), s \geq 3$, if $\left\|u-\varphi_{c}\right\|_{H^{1}(\mathbb{R})}<\delta$ and $\left\|v-\psi_{c}\right\|_{H^{1}(\mathbb{R})}<\delta$ with $0<\delta<1 / 2$, then

\left|E_{u}[u]-E_{u}\left[\varphi_{c}\right]\right|<2 \sqrt{2} a \delta+\delta^{2}, \quad\left|E_{v}[v]-E_{u}\left[\psi_{c}\right]\right|<2 \sqrt{2} b \delta+\delta^{2}

and

\left|H[u, v]-H\left[\varphi_{c}, \psi_{c}\right]\right|<2 \sqrt{2}(a+b) \delta+6 \delta^{2}, \quad\left|F[u, v]-F\left[\varphi_{c}, \psi_{c}\right]\right|<C \delta+O\left(\delta^{2}\right)
$$

where $C>0$ is a constant depending on $a, b,\|u\|_{H^{s}}$ and $\|v\|_{H^{s}}$.
Proof. Let $\tilde{u}=u-\varphi_{c}$ and $\tilde{v}=v-\psi_{c}$, for convenience. Since $\|\tilde{u}\|_{H^{1}(\mathbb{R})}<\delta$ and $\|\tilde{v}\|_{H^{1}(\mathbb{R})}<\delta$, it follows that

\left|E_{u}[u]-E_{u}\left[\varphi_{c}\right]\right| & =\left|\left\|u_{0}\right\|_{H^{1}(\mathbb{R})}^{2}-\left\|\varphi_{c}\right\|_{H^{1}(\mathbb{R})}^{2}\right| \\
& =\left|\left\|u_{0}\right\|_{H^{1}(\mathbb{R})}-\left\|\varphi_{c}\right\|_{H^{1}(\mathbb{R})}\right|\left|\left\|u_{0}\right\|_{H^{1}(\mathbb{R})}+\left\|\varphi_{c}\right\|_{H^{1}(\mathbb{R})}\right| \\
& \leq\left\|\tilde{u}_{0}\right\|_{H^{1}(\mathbb{R})}\left(\left\|\tilde{u}_{0}\right\|_{H^{1}(\mathbb{R})}+2\left\|\varphi_{c}\right\|_{H^{1}(\mathbb{R})}\right) \leq 2 \sqrt{2} a \delta+\delta^{2}
\end{aligned}
$$

Similarly, we have

\left|E_{v}[v]-E_{v}\left[\psi_{c}\right]\right|<2 \sqrt{2} b \delta+\delta^{2}
$$

Next, we now estimate

\begin{aligned}
\mid H[u, v]- & H\left[\varphi_{c}, \psi_{c}\right]\left|=\left|\int_{\mathbb{R}}\left(u v+u_{x} v_{x}\right) d x-\int_{\mathbb{R}}\left(\varphi_{c} \psi_{c}+\varphi_{c}^{\prime} \psi_{c}^{\prime}\right) d x\right|\right. \\
= & \left|\int_{\mathbb{R}}(\tilde{u} \tilde{v}+u \tilde{v}+v \tilde{u}) d x+\int_{\mathbb{R}}\left[\left(u_{x}-\varphi_{c}^{\prime}\right)\left(v_{x}-\psi_{c}^{\prime}\right)+u_{x}\left(v_{x}-\psi_{c}^{\prime}\right)+v_{x}\left(u_{x}-\varphi_{c}^{\prime}\right)\right] d x\right| \\
\leq & \int_{\mathbb{R}}|\tilde{u} \tilde{v}| d x+\int_{\mathbb{R}}|\tilde{u} v| d x+\int_{\mathbb{R}}\left|\left(v-\varphi_{c}\right) u\right| d x \\
& \quad+\int_{\mathbb{R}}\left|\tilde{u}^{\prime} \tilde{v}^{\prime}\right| d x+\int_{\mathbb{R}}\left|\tilde{u}^{\prime} v_{x}\right| d x+\int_{\mathbb{R}}\left|\tilde{v}^{\prime} u_{x}\right| d x .
\end{aligned}
$$

Using the Hölder inequality
$\int_{\mathbb{R}}|\tilde{u} v| d x \leq\left(\int_{\mathbb{R}} \tilde{u}^{2} d x\right)^{\frac{1}{2}}\left(\int_{\mathbb{R}} v^{2} d x\right)^{\frac{1}{2}} \leq\|\tilde{u}\|_{H^{1}(\mathbb{R})}\left(\|\tilde{v}\|_{H^{1}(\mathbb{R})}+\left\|\varphi_{c}\right\|_{H^{1}(\mathbb{R})}\right) \leq \delta^{2}+\sqrt{2} a \delta$,
we deduce that

&\left|F[u, v]-F\left[\varphi_{c}, \psi_{c}\right]\right|= \left\lvert\, \int_{\mathbb{R}}\left(u^{2} v^{2}+\frac{1}{3} u^{2} v_{x}^{2}+\frac{1}{3} v^{2} u_{x}^{2}+\frac{4}{3} u v u_{x} v_{x}-\frac{1}{3} u_{x}^{2} v_{x}^{2}\right) d x\right. \\
& \left.\quad-\int_{\mathbb{R}}\left[\varphi_{c}^{2} \psi_{c}^{2}+\frac{1}{3} \varphi_{c}^{2}\left(\psi_{c}^{\prime}\right)^{2}+\frac{1}{3}\left(\varphi_{c}^{\prime}\right)^{2} \psi_{c}^{2}+\frac{4}{3} \varphi_{c} \psi_{c} \varphi_{c}^{\prime} \psi_{c}^{\prime}-\frac{1}{3}\left(\varphi_{c}^{\prime}\right)^{2}\left(\psi_{c}^{\prime}\right)^{2}\right] d x \right\rvert\, \\
& \leq \int_{\mathbb{R}}\left|u^{2} v^{2}-\varphi_{c}^{2} \psi_{c}^{2}\right| d x+\frac{1}{3} \int_{\mathbb{R}}\left|u^{2} v_{x}^{2}-\varphi_{c}^{2}\left(\psi_{c}^{\prime}\right)^{2}\right| d x+\frac{1}{3} \int_{\mathbb{R}}\left|v^{2} u_{x}^{2}-\left(\varphi_{c}^{\prime}\right)^{2} \psi_{c}^{2}\right| d x \\
& \quad+\frac{4}{3}\left|\int_{\mathbb{R}}\left(u v u_{x} v_{x}-\varphi_{c} \psi_{c} \varphi_{c}^{\prime} \psi_{c}^{\prime}\right) d x\right|+\frac{1}{3}\left|\int_{\mathbb{R}}\left[u_{x}^{2} v_{x}^{2}-\left(\varphi_{c}^{\prime}\right)^{2}\left(\psi_{c}^{\prime}\right)^{2}\right] d x\right| \\
& \triangleq I_{1}+\frac{1}{3} I_{2}+\frac{1}{3} I_{3}+\frac{4}{3} I_{4}+\frac{1}{3} I_{5} .
\end{aligned}

For the first term $I_{1}$, we obtain

& \leq\|v\|_{L^{\infty}}^{2}\left(\int_{\mathbb{R}} \tilde{u}^{2} d x\right)^{\frac{1}{2}}\left(\int_{\mathbb{R}}\left(u+\varphi_{c}\right)^{2} d x\right)^{\frac{1}{2}}+\left\|\varphi_{c}\right\|_{L^{\infty}}^{2}\left(\int_{\mathbb{R}} \tilde{v}^{2} d x\right)^{\frac{1}{2}}\left(\int_{\mathbb{R}}\left(v+\psi_{c}\right)^{2} d x\right)^{\frac{1}{2}} \\
& \leq\|v\|_{L^{\infty}}^{2}\|\tilde{u}\|_{H^{1}}\left(\|\tilde{u}\|_{H^{1}}+2\left\|\varphi_{c}\right\|_{H^{1}}\right)+\left\|\varphi_{c}\right\|_{L^{\infty}}^{2}\|\tilde{v}\|_{H^{1}}\left(\|\tilde{v}\|_{H^{1}}+2\left\|\psi_{c}\right\|_{H^{1}}\right) \\

## 4. Stability of train-Profiles

In this section, we are devoted to proving orbital stability of train-profiles of two-component peakons $\left(\varphi_{c}, \psi_{c}\right)$. For $\alpha>0$ and $L>0$, we define the following neighborhood of all the sums of N peakons of speed $c_{1}, \ldots, c_{N}$ with spatial shifts $x_{i}$ that satisfy $x_{i}-x_{i-1} \geq L$,

In this subsection we shall prove that the different bumps of $u$ and $v$ that are individually close to their own peakons and get away from each others as time is increasing. This is crucial in our analysis since we do not know how to manage strong interactions.

We conclude that, for $L>0$ large enough, $D_{\left(y_{1}, \ldots, y_{N}\right)} Y\left(0, \ldots, 0, R_{Z}, S_{Z}\right)=D+P$ where $D$ is an invertible diagonal matrix with $\left\|D^{-1}\right\| \leq\left(a_{1}^{2}+b_{1}^{2}\right)^{-n}$ and $\|P\| \leq O\left(e^{-L / 4}\right)$. Hence there exists $L_{0}>0$ such that for $L>L_{0}, D_{\left(y_{1}, \ldots, y_{N}\right)} Y\left(0, \ldots, 0, R_{Z}, S_{Z}\right)$ is invertible with an inverse matrix of norm smaller than $2\left(a_{1}^{2}+b_{1}^{2}\right)^{-n}$. The implicit function theorem implies that there exists $\beta_{0}>0$ and $C^{1}$ functions $y_{1}, y_{2}, \ldots, y_{N}$ from $B_{H^{1} \times H^{1}}\left(\left(R_{Z}, S_{Z}\right), \beta_{0}\right)$ to a neighborhood of $(0,0, \ldots, 0)$ which uniquely determined such that

\leq & \left(O(\sqrt{\alpha})+O\left(e^{\frac{L}{4}}\right)\right) \int_{\mathbb{R}}\left|R_{i x}\right| d x \leq O(\sqrt{\alpha})+O\left(e^{-\frac{L}{4}}\right)
\end{aligned}
$$

Similarly, we find

Thanks to the lemmas $4.1,4.2$ and 4.3 we arrive at

4.2. Monotonicity property. Thanks to the preceding proposition, for $\epsilon_{0}>0$ small enough and $L_{0}>0$ large enough, one can construct $C^{1}$ functions $\tilde{x}_{1}, \ldots, \tilde{x}_{N}$ defined on $\left[0, t_{0}\right]$ such that (4.3)-(4.7) are satisfied. In this subsection we investigate the almost monotonicity of functionals that are very close to the energy at the right of $i$ th bump, $i=1, \ldots, N-1$ of $(u, v)$. Let $\Psi$ be a $C^{\infty}$-function such that

\end{aligned}

where $\Psi_{j, K}(t, x)=\Psi_{K}\left(x-y_{j}(t)\right)$ with $y_{j}(t), j=2, \ldots, N$, defined in (4.6). Note that $\mathcal{J}_{j, K}^{u}(t)$ is close to $\|u(t)\|_{H^{1}\left(x>y_{j}(t)\right)}$ and thus measures the energy at the right of the $(j-1)$ th bump of $u, \mathcal{J}_{j, K}^{v}(t)$ is close to $\|v(t)\|_{H^{1}\left(x>y_{j}(t)\right)}$ and thus measures the energy at the right of the
( $j-1$ )th bump of $v$, and $\mathcal{J}_{j, K}^{u, v}(t)$ is close to $\left\langle u(t), v(t)>_{H^{1} \times H^{1}\left(x>y_{j}(t)\right)}\right.$ and thus measures the energy at the right of the $(j-1)$ th bump of $(u, v)$. Finally, we set

We have the following monotonicity result.
Proposition 4.2. (Exponential decay of the functionals $\mathcal{J}_{j, K}^{u}(t), \mathcal{J}_{j, K}^{v}(t)$ and $\mathcal{J}_{j, K}^{u, v}(t)$ ). Let $(u, v) \in Y\left(\left[0, T[)\right.\right.$ be a solution of two component Novikov equations satisfying (4.4) on $\left[0, t_{0}\right]$. There exist $\alpha_{0}>0$ and $L_{0}>0$ only depending on $c_{1}$ such that if $0<\alpha<\alpha_{0}$ and $L \geq L_{0}$ then for any $4 \leq K \lesssim \sqrt{L}$,

\mathcal{J}_{j, K}^{u, v}(t)-\mathcal{J}_{j, K}^{u, v}(0) \leq O\left(e^{-\frac{\sigma_{0} L}{8 K}}\right), & \forall j \in\{2, \ldots, N\}, \forall t \in\left[0, t_{0}\right] .

The proof of this Proposition relies on the following Virial type identity.

\end{aligned}

and $\frac{d}{d t} \int_{\mathbb{R}}\left(u v+u_{x} v_{x}\right) g d x$
$=\int_{\mathbb{R}} u\left[v u_{x} v_{x}+P *\left(\frac{1}{2} v_{x}^{2} u+v v_{x} u_{x}+v^{2} u\right)+P_{x} *\left(\frac{1}{2} v_{x}^{2} u_{x}\right)\right] g^{\prime} d x$ $+\int_{\mathbb{R}} v\left[P *\left(\frac{1}{2} u_{x}^{2} v+u u_{x} v_{x}+u^{2} v\right)+P_{x} *\left(\frac{1}{2} u_{x}^{2} v_{x}\right)\right] g^{\prime} d x+\int_{\mathbb{R}}\left(u v+u_{x} v_{x}\right) g^{\prime} d x$.

= & \int_{\mathbb{R}}\left[u u_{x}^{2} v+2 u P *\left(\frac{1}{2} u_{x}^{2} v+u u_{x} v_{x}+u^{2} v\right)+2 u P_{x} *\left(\frac{1}{2} u_{x}^{2} v_{x}\right)\right] g^{\prime} d x+\int_{\mathbb{R}}\left(u^{2}+u_{x}^{2}\right) g^{\prime} d x .
\end{aligned}

Similarly, we have

Using the weak form of $(u, v)$ and its first derivative, integrating by parts, we obtain

& =\int_{\mathbb{R}}\left[u v u_{x} v_{x}+u P *\left(\frac{1}{2} v_{x}^{2} u+v v_{x} u_{x}+v^{2} u\right)+u P_{x} *\left(\frac{1}{2} v_{x}^{2} u_{x}\right)\right] g^{\prime} d x \\
& \quad+\int_{\mathbb{R}}\left[v P *\left(\frac{1}{2} u_{x}^{2} v+u u_{x} v_{x}+u^{2} v\right)+v P_{x} *\left(\frac{1}{2} u_{x}^{2} v_{x}\right)\right] g^{\prime} d x+\int_{\mathbb{R}}\left(u v+u_{x} v_{x}\right) g^{\prime} d x

& +\int_{\mathbb{R}}\left[2 u P *\left(\frac{1}{2} u_{x}^{2} v+u u_{x} v_{x}+u^{2} v\right)\right] \Psi_{i, K}^{\prime} d x+\int_{\mathbb{R}}\left[2 u P_{x} *\left(\frac{1}{2} u_{x}^{2} v_{x}\right)\right] \Psi_{i, K}^{\prime} d x \\
\triangleq- & \frac{c_{1}}{2} \int_{\mathbb{R}}\left(u^{2}+u_{x}^{2}\right) \Psi_{i, K}^{\prime} d x+\widetilde{I}_{1,1}+\widetilde{I}_{1,2}+\widetilde{I}_{1,3}
\end{aligned}

We claim that for the terms $\tilde{I}_{1, i}, i=1,2,3$, it holds

Indeed, we divide $\mathbb{R}$ into two regions $D_{i}$ and $D_{i}^{c}$ with

Now, using the exponential decay of $\varphi_{c}$ and $\psi_{c}$ on $D_{i}$, it holds

& \|v\|_{L^{\infty}\left(D_{i}\right)} \leq\left\|v-\sum_{j=1}^{N} \psi\left(\cdot-\tilde{x}_{j}(t)\right)\right\|_{L^{\infty}\left(D_{i}\right)}+\sum_{j=1}^{N}\left\|\psi\left(\cdot-\tilde{x}_{j}(t)\right)\right\|_{L^{\infty}\left(D_{i}\right)} \leq O(\sqrt{\alpha})+O\left(e^{-\frac{L}{8}}\right) . \tag{4.20}

& +\left\|\Psi_{i, K}^{\prime}\right\|_{L^{\infty}\left(D_{i}^{c}\right)}\|u\|_{L^{\infty}(\mathbb{R})} \int_{\mathbb{R}}\left|u_{x}^{2} v+2 u u_{x} v_{x}+2 u^{2} v\right| d x \\
\leq & 3\|u\|_{L^{\infty}\left(D_{i}\right)}\|v\|_{L^{\infty}\left(D_{i}\right)} \int_{\mathbb{R}}\left|u_{x}^{2}+u^{2}\right| \Psi_{i, K}^{\prime} d x+\frac{C}{K}\left\|u_{0}\right\|_{H^{1}(\mathbb{R})}^{3}\left\|v_{0}\right\|_{H^{1}(\mathbb{R})} e^{-\frac{1}{K}\left(\sigma_{0} t+\frac{L}{8}\right)} \\
\leq & \frac{c_{1}}{20} \int_{\mathbb{R}}\left(u^{2}+u_{x}^{2}\right) \Psi_{i, K}^{\prime} d x+\frac{C}{K}\left\|u_{0}\right\|_{H^{1}(\mathbb{R})}^{3}\left\|v_{0}\right\|_{H^{1}(\mathbb{R})} e^{-\frac{1}{K}\left(\sigma_{0} t+\frac{L}{8}\right)}
\end{aligned}

where the Young's inequality is used, the exponential decay of $\Psi_{i, K}^{\prime}$ on $D_{i}^{c}$, 4.20) and (4.21). Let us tackle now the estimate of $\widetilde{I}_{1,3}$. On $D_{i}^{c}$ we have

\int_{D_{i}^{c}}\left[u P_{x} *\left(u_{x}^{2} v_{x}\right)\right] \Psi_{i, K}^{\prime}(t) d x \leq \frac{C}{K}\left\|u_{0}\right\|_{H^{1}(\mathbb{R})}^{3}\left\|v_{0}\right\|_{H^{1}(\mathbb{R})} e^{-\frac{1}{K}\left(\sigma_{0} t+\frac{L}{8}\right)}
$$

The estimate of $\widetilde{I}_{1,3}$ on $D_{i}$ leads to

\begin{aligned}
\int_{D_{i}}\left[u P_{x} *\left(u_{x}^{2} v_{x}\right)\right] \Psi_{i, K}^{\prime}(t) d x & \leq\|u\|_{L^{\infty}\left(D_{i}\right)}\|v\|_{L^{\infty}\left(D_{i}\right)} \int_{\mathbb{R}}\left[P * \Psi_{i, K}^{\prime}(t)\right] u_{x}^{2} d x \\
& \leq \frac{c_{1}}{20} \int_{\mathbb{R}}\left(u^{2}+u_{x}^{2}\right) \Psi_{i, K}^{\prime} d x .
\end{aligned}
$$

Therefore, for $0<\alpha<\alpha_{0}$ and $L>L_{0}>0$, with $\alpha_{0} \ll 1$ and $L_{0} \gg 1$, it holds

Integrating between 0 and $t$, we obtain

&-\dot{y}_{i} \int_{\mathbb{R}}\left(u v+u_{x} v_{x}\right) \Psi_{i, K}^{\prime} d x \\
&= \int_{\mathbb{R}}\left[u v\left(u v+u_{x} v_{x}\right)+u P *\left(v\left(u v+u_{x} v_{x}\right)\right)+v P *\left(u\left(u v+u_{x} v_{x}\right)\right)\right] \Psi_{i, K}^{\prime} d x \\
&+\int_{\mathbb{R}}\left[-\frac{1}{2} u^{2} v^{2}+v P *\left(\frac{1}{2} u_{x}^{2} v\right)+v P_{x} *\left(\frac{1}{2} u_{x}^{2} v_{x}\right)\right] \Psi_{i, K}^{\prime} d x \\
&+\int_{\mathbb{R}}\left[-\frac{1}{2} u^{2} v^{2}+u P *\left(\frac{1}{2} v_{x}^{2} u\right)+u P_{x} *\left(\frac{1}{2} v_{x}^{2} u_{x}\right)\right] \Psi_{i, K}^{\prime} d x \\
&-\dot{y}_{i} \int_{\mathbb{R}}\left(u v+u_{x} v_{x}\right) \Psi_{i, K}^{\prime} d x \\
& \triangleq \widetilde{I}_{2,1}+\widetilde{I}_{2,2}+\widetilde{I}_{2,3}-\dot{y}_{i} \int_{\mathbb{R}}\left(u v+u_{x} v_{x}\right) \Psi_{i, K}^{\prime} d x .
\end{aligned}
$$

In the same way as the proof of the first inequality, we obtain

& \leq \frac{1}{2} \int_{\mathbb{R}}\left[P_{x} *\left(\left(u v+u_{x} v_{x}\right) u_{x}\right)+P_{x} *\left(\left(u v_{x}+u_{x} v\right) u\right)\right] v \Psi_{i, K}^{\prime} d x \\
& \leq \frac{1}{2} \int_{\mathbb{R}}\left[P_{x} *\left(\left(u v+u_{x} v_{x}\right) u_{x}\right)+P *\left(\left(u v+u_{x} v_{x}\right) u\right)\right] v \Psi_{i, K}^{\prime} d x
\end{aligned}
$$

In the same way as proof the inequality of the first inequality, we find

$$

Therefore, for $0<\alpha<\alpha_{0}$ and $L>L_{0}>0$, with $\alpha_{0} \ll 1$ and $L_{0} \gg 1$, it holds

4.3. A localized and a global estimate. We define the function $\Phi_{i}=\Phi_{i}(t, x)$ by $\Phi_{1}=$ $1-\Psi_{2, K}=1-\Psi_{K}\left(\cdot-y_{2}(t)\right), \Phi_{N}=\Psi_{N, K}=\Psi_{K}\left(\cdot-y_{N}(t)\right)$ and for $i=2, \ldots, N-1$,

where $\Psi_{K}$ and the $y_{i}$ are defined in the previous section. It is easy to check that $\sum_{i=1}^{N} \Phi_{i, K} \equiv$ 1. We take $L>0$ and $L / K>0$ large enough so that $\Phi_{i}$ satisfies

\end{equation*}

We now use the following localized version of $E_{u}, E_{v}, H$ and $F$ defined for $i \in\{1, \ldots, N\}$, by

H_{i}(u, v) & =\int_{\mathbb{R}}\left(u v+u_{x} v_{x}\right) \Phi_{i} d x  \tag{4.26}\\
\text { and } F_{i}(u, v) & =\int_{\mathbb{R}}\left(u^{2} v^{2}+\frac{1}{3} u^{2} v_{x}^{2}+\frac{1}{3} v^{2} u_{x}^{2}+\frac{4}{3} u v u_{x} v_{x}-\frac{1}{3} u_{x}^{2} v_{x}^{2}\right) \Phi_{i} d x .
\end{align*}
$$

Please note that henceforth we take $K=\sqrt{L} / 8$.
The following lemma gives a localized version of (3.8). Note that the functionals $H_{i}$ and $F_{i}$ do not depend on time in the statement below since we fix $\tilde{x}_{1}<\ldots<\tilde{x}_{N}$.

Lemma 4.5. Let be given $N$ real numbers $\tilde{x}_{1}<\ldots<\tilde{x}_{N}$ with $\tilde{x}_{i}-\tilde{x}_{i-1} \geq 2 L / 3$. Define the $J_{i}$ as in (4.6) and assume that, for $i=1, \ldots, N$, there exists $x_{i} \in J_{i}$ such that $\left|x_{i}-\tilde{x}_{i}\right| \leq L / 12$ and $u\left(x_{i}\right) v\left(x_{i}\right)=\max _{x \in J_{i}} u v:=M_{i}$. Then for any $(u, v) \in H^{1}(\mathbb{R}) \times H^{1}(\mathbb{R})$, it holds

$$

Integrating by parts we compute

= & \int_{-\infty}^{x_{i}}\left(u v-\frac{1}{3}(u v)_{x}-\frac{1}{3} u_{x} v_{x}\right)\left(u v-(u v)_{x}+u_{x} v_{x}\right) \Phi_{i} d x \\
& \quad+\int_{x_{i}}^{\infty}\left(u v+\frac{1}{3}(u v)_{x}-\frac{1}{3} u_{x} v_{x}\right)\left(u v+(u v)_{x}+u_{x} v_{x}\right) \Phi_{i} d x  \tag{4.28}\\
= & \int_{-\infty}^{\infty}\left(u^{2} v^{2}+\frac{1}{3} u^{2} v_{x}^{2}+\frac{1}{3} v^{2} u_{x}^{2}+\frac{4}{3} u v u_{x} v_{x}-\frac{1}{3} u_{x}^{2} v_{x}^{2}\right) d x-\frac{4}{3} M_{i}^{2} \Phi_{i}\left(x_{i}\right) \\
& \quad+\frac{2}{3} \int_{\infty}^{x_{i}} u^{2} v^{2} \Phi_{i}^{\prime} d x-\frac{2}{3} \int_{x_{i}}^{\infty} u^{2} v^{2} \Phi_{i}^{\prime} d x .
\end{align*}
$$

Recall that we take $K=\sqrt{L} / 8$ and thus $\left|\Phi^{\prime}\right| \leq C / K=O\left(L^{-1 / 2}\right)$. Moreover, since $\left|x_{i}-\tilde{x}_{i}\right| \leq$ $L / 12$, it follows from (4.24) that $\Phi_{i}\left(x_{i}\right)=1+O\left(e^{-\sqrt{L}}\right)$ and thus

On the other hand, we firstly claim that $x_{1}$ is the maximum point of the function $u(x, t) v(x, t)$ on $\left(-\infty, y_{2}(t)+a L\right], x_{N}$ is the maximum point of the function $u(x, t) v(x, t)$ on $\left[y_{N}(t)-\right.$ $a L,+\infty)$ and $x_{i}$ is the maximum point of the function $u(x, t) v(x, t)$ on $\left[y_{i}(t)-a L, y_{i+1}(t)+\right.$ $a L]$, where $a$ is a constant chosen later and $i \in\{2, \ldots, N-1\}$.

We need to show $x_{i}$ is the maximum point of the function $u(x, t) v(x, t)$ on $\left[y_{i}(t)-\right.$ $\left.a L, y_{i}(t)\right] \cup\left[y_{i+1}(t), y_{i+1}(t)+a L\right]$, where $i \in\{2, \ldots, N-1\}$. If $x \in\left[y_{i}(t)-a L, y_{i}(t)\right] \cup$ $\left[y_{i+1}(t), y_{i+1}(t)+a L\right]$, then

u(x, t) v(x, t) \leq c_{i+1} e^{-\left(\frac{3}{8}-a\right) L}+c_{i} e^{-\frac{3}{8} L}+O(\sqrt{\alpha})+O\left(e^{-\frac{L}{4}}\right)
$$

Choosing $a$ with

c_{i+1} e^{-\left(\frac{3}{8}-a\right) L}+c_{i} e^{-\frac{3}{8} L}+O(\sqrt{\alpha})+O\left(e^{-\frac{L}{4}}\right) \leq c_{i}-O(\sqrt{\alpha})-O\left(e^{-\frac{L}{4}}\right)
$$

and using the same estimate as above, we have proved similar conclusion of $x_{1}$ and $x_{N}$.

Next, we define the intervals $\hat{J}_{1}=\left(-\infty, y_{2}(t)+a L\right], \hat{J}_{N}=\left[y_{N}(t)-a L,+\infty\right)$ and for $i=2, \ldots, N-1, \hat{J}_{i}=\left[y_{i}(t)-a L, y_{i+1}(t)+a L\right]$, where $a$ is chosen above.

$$
\begin{align*}
\int_{\mathbb{R}} h(x) g_{u}(x) g_{v}(x) \Phi_{i} d x & =\int_{\hat{J}_{i}} h(x) g_{u}(x) g_{v}(x) \Phi_{i} d x+\int_{\hat{J}_{i}^{c}} h(x) g_{u}(x) g_{v}(x) \Phi_{i} d x \\
& \leq \frac{4}{3} M_{i} \int_{\mathbb{R}} g_{u}(x) g_{v}(x) \Phi_{i} d x+\int_{\hat{J}_{i}^{c}} h(x) g_{u}(x) g_{v}(x) \Phi_{i} d x \tag{4.30}
\end{align*}
$$

where we use the fact $h(x) \leq 4 u(x) v(x) / 3 \leq 4 M_{i} / 3$ on the $\hat{J}_{i}$. One chooses $L$ large enough satisfying $a L>10 \sqrt{L}$, which leads to

Now let us state a global identity related to (3.1).
Lemma 4.6. For any $Z \in \mathbb{R}^{N}$ satisfying $\left|z_{i}-z_{i-1}\right| \geq L / 2$ and any $(u, v) \in H^{1}(\mathbb{R}) \times H^{1}(\mathbb{R})$, there holds

& E_{v}(v)-\sum_{i=1}^{N} E_{v}\left(\psi_{c_{i}}\right)=\left\|v-S_{Z}\right\|_{H^{1}}^{2}+4 \sum_{i=1}^{N} b_{i}\left(v\left(z_{i}\right)-b_{i}\right)+O\left(e^{-\frac{L}{4}}\right) .
\end{aligned}
$$

Proof. Using the relation between $\varphi$ and its derivative, integrating by parts, we get

& =E_{u}(u)+E_{u}\left(R_{Z}\right)-2 \sum_{i=1}^{N} \int_{\mathbb{R}} u \varphi_{c_{i}}\left(\cdot-z_{i}\right)+2 \sum_{i=1}^{N} \int_{z_{i}}^{\infty} u_{x} \varphi_{c_{i}}\left(\cdot-z_{i}\right)-2 \sum_{i=1}^{N} \int_{-\infty}^{z_{i}} u_{x} \varphi_{c_{i}}\left(\cdot-z_{i}\right) \\
& =E_{u}(u)+E_{u}\left(R_{Z}\right)-4 \sum_{i=1}^{N} a_{i} u\left(z_{i}\right)
\end{aligned}
$$

On the other hand, since $\left|z_{i}-z_{i-1}\right| \geq L / 2$, it is easy to check that

& \left|E_{v i}\left(v_{0}\right)-E_{v i}\left(\psi_{c_{i}}\right)\right|<O(\epsilon)+O\left(e^{-\sqrt{L}}\right)
\end{aligned}

Proof. Define the interval $\bar{J}_{i}=\left[z_{i}^{0}-L / 4, z_{i}^{0}+L / 4\right]$. Using (4.24), (4.25) and the exponential decay of $\varphi_{c_{i}}$ 's and the $\psi_{c_{i}}$ 's, we have

\leq & \left|\int_{\bar{J}_{i}} \varphi_{c_{i}} \psi_{c_{i}}+\varphi_{c_{i}}^{\prime} \psi_{c_{i}}^{\prime} d x-\int_{\bar{J}_{i}}\left(u_{0} v_{0}+u_{0 x} v_{0 x}\right) d x\right|+O\left(e^{-\sqrt{L}}\right)+O\left(e^{-\frac{L}{8}}\right) .
\end{aligned}
$$

Since $\left\|u_{0}-R_{Z}\right\|_{H^{1}}+\left\|v_{0}-S_{Z}\right\|_{H^{1}}<\epsilon$, then we obtain

$$
\begin{aligned}
& \left\|u_{0}-\varphi_{c_{i}}\right\|_{H^{1}\left(\bar{J}_{i}\right)}+\left\|v_{0}-\psi_{c_{i}}\right\|_{H^{1}\left(\bar{J}_{i}\right)} \\
& \leq \mid u_{0}-R_{Z}\left\|_{H^{1}\left(\bar{J}_{i}\right)}+\right\| v_{0}-S_{Z} \|_{H^{1}\left(\bar{J}_{i}\right)}+\sum_{i \neq j}\left(\left\|\varphi_{c_{j}}\right\|_{H^{1}\left(\bar{J}_{i}\right)}+\left\|\psi_{c_{j}}\right\|_{H^{1}\left(\bar{J}_{i}\right)}\right) \\
& \leq \mid u_{0}-R_{Z}\left\|_{H^{1}(\mathbb{R})}+\right\| v_{0}-S_{Z} \|_{H^{1}(\mathbb{R})}+O\left(e^{-\frac{L}{8}}\right)<\epsilon+O\left(e^{-\frac{L}{8}}\right)
\end{aligned}
$$

Using the same way in proving the third inequality of (3.3), we obtain

$$
\left|H_{i}\left(\varphi_{c_{i}}, \psi_{c_{i}}\right)-H_{i}\left(u_{0}, v_{0}\right)\right|<O(\epsilon)+O\left(e^{-\sqrt{L}}\right)
$$

Similarly,
$\left|E_{u i}\left(\varphi_{c_{i}}\right)-E_{u i}\left(u_{0}\right)\right|<O(\epsilon)+O\left(e^{-\sqrt{L}}\right)$ and $\left|E_{v i}\left(\psi_{c_{i}}\right)-E_{v i}\left(v_{0}\right)\right|<O(\epsilon)+O\left(e^{-\sqrt{L}}\right)$.

Lemma 4.8. Assume $u \in H^{s}, v \in H^{s}, s>3$ and $u \geq 0, v \geq 0$. Let

$$
M_{i}=u\left(x_{i}\right) v\left(x_{i}\right)=\max _{x \in J_{i}} u(x) v(x)
$$

and set $\alpha_{0}=A\left(\epsilon_{0}{ }^{1 / 4}+L_{0}^{-1 / 8}\right)$. Then we have

$$
\left|M_{i}-c_{i}\right| \leq O\left(L^{-\frac{1}{4}}\right)+O\left(\epsilon^{\frac{1}{2}}\right), \quad i=1, \ldots, N
$$

Proof. Define the second-order polynomials $\bar{P}^{i}$ and $\hat{P}^{i}$ by:

$$
\bar{P}^{i}(y)=y^{2}-H_{i}(u, v) y+\frac{3}{4} F_{i}(u, v) \text { and } \hat{P}^{i}(y)=y^{2}-H_{i}\left(u_{0}, v_{0}\right) y+\frac{3}{4} F_{i}\left(u_{0}, v_{0}\right)
$$

For the peaked solution, $H\left(\varphi_{c_{i}}, \psi_{c_{i}}\right)=2 c_{i}$ and $F\left(\varphi_{c_{i}}, \psi_{c_{i}}\right)=4 c_{i}^{2} / 3$, the above polynomial becomes

$$
\begin{equation*}
\hat{P}_{0}^{i}(y)=y^{2}-2 c_{i} y+c_{i}^{2}=\left(y-c_{i}\right)^{2} \tag{4.31}
\end{equation*}
$$

Since

$$
\begin{aligned}
\bar{P}^{i}(y)=\hat{P}_{0}^{i}(y) & +\left(H\left(\varphi_{c_{i}}, \psi_{c_{i}}\right)-H_{i}\left(u_{0}, v_{0}\right)\right) y+\left(H_{i}\left(u_{0}, v_{0}\right)-H_{i}(u, v)\right) y \\
& +\frac{3}{4}\left[\left(F_{i}\left(u_{0}, v_{0}\right)-F\left(\varphi_{c_{i}}, \psi_{c_{i}}\right)\right)+\left(F_{i}(u, v)-F_{i}\left(u_{0}, v_{0}\right)\right)\right]
\end{aligned}
$$

it follows that

$$
\begin{aligned}
& \sum_{i=1}^{N} \bar{P}^{i}\left(M_{i}\right)=\sum_{i=1}^{N} \hat{P}_{0}^{i}\left(M_{i}\right)+\sum_{i=1}^{N} M_{i}\left(H\left(\varphi_{c_{i}}, \psi_{c_{i}}\right)-H_{i}\left(u_{0}, v_{0}\right)\right) \\
& \quad+\frac{4}{3}\left(F\left(u_{0}, v_{0}\right)-\sum_{i=1}^{N} F\left(\varphi_{c_{i}}, \psi_{c_{i}}\right)\right)+\sum_{i=1}^{N} M_{i}\left(\left(H_{i}\left(u_{0}, v_{0}\right)-H_{i}(u, v)\right) \leq O\left(L^{-\frac{1}{2}}\right)\right.
\end{aligned}
$$

Using the Abel transformation of the last term and the monotonicity property and combining Lemma (4.7), we thus get

$$
\begin{aligned}
\sum_{i=1}^{N}\left(M_{i}-c_{i}\right)^{2} & \leq \sum_{i=1}^{N} M_{i}\left|H\left(\varphi_{c_{i}}, \psi_{c_{i}}\right)-H_{i}\left(u_{0}, v_{0}\right)\right|+\frac{3}{4}\left|F\left(u_{0}, v_{0}\right)-F\left(R_{Z}, S_{Z}\right)\right|+O\left(L^{-\frac{1}{2}}\right)+O(\epsilon) \\
& \leq O\left(L^{-\frac{1}{2}}\right)+O(\epsilon)
\end{aligned}
$$

which completes the proof of the lemma.
Lemma 4.9. Assume $\left|M_{i}-c_{i}\right| \leq O\left(L^{-1 / 4}\right)+O\left(\epsilon^{1 / 2}\right), \quad i=1, \ldots, N$. Then for any $i=\{1, \ldots, N\}$, we have

$$
\left|u\left(x_{i}\right)-a_{i}\right| \leq O\left(L^{-1 / 4}\right)+O\left(\epsilon^{1 / 2}\right) \quad \text { and } \quad\left|v\left(x_{i}\right)-b_{i}\right| \leq O\left(L^{-1 / 4}\right)+O\left(\epsilon^{1 / 2}\right)
$$

Note the monotonicity property that $\mathcal{J}_{j, K}^{u}(t)$ is close to $\|u(t)\|_{H^{1}\left(x>y_{j}(t)\right)}$ and thus measures the energy at the right of the $(j-1)$ th bump of $u$ and $\mathcal{J}_{j, K}^{v}(t)$ is close to $\|v(t)\|_{H^{1}\left(x>y_{j}(t)\right)}$ and thus measures the energy at the right of the $(j-1)$ th bump of $v$. We thus use the induction argument to prove this lemma.
Proof. Step 1. Define

$$
g_{u N}(x)= \begin{cases}u(x)-u_{x}(x), & x<x_{N}  \tag{4.32}\\ u(x)+u_{x}(x), & x>x_{N}\end{cases}
$$

Then we have

$$
\begin{aligned}
0 \leq \int_{\mathbb{R}} g_{u N}^{2}(x) \Phi_{N}(x) d x= & \int_{\mathbb{R}}\left(u^{2}+u_{x}^{2}\right) \Phi_{N}(x) d x-2 u^{2}\left(x_{N}\right) \Phi_{N}\left(x_{N}\right) \\
& +\int_{-\infty}^{x_{N}} u^{2} \Phi_{N}^{\prime} d x-\int_{x_{N}}^{+\infty} u^{2} \Phi_{N}^{\prime} d x
\end{aligned}
$$

Using $\left|x_{i}-\tilde{x}_{i}\right| \leq L / 12$, it follows from (4.24) that $\Phi_{i}\left(x_{i}\right)=1+O\left(e^{-\sqrt{L}}\right)$ and thus

$$
E_{u N}(u(t))-2 u^{2}\left(x_{N}\right)+O\left(L^{-\frac{1}{2}}\right) \geq 0
$$

Note that

$$
E_{u N}(u(t))=\mathcal{J}_{N, K}^{u}(t) \quad \text { and } \quad E_{u N}(u(t))-E_{u N}(u(0)) \leq O\left(e^{-\sigma_{0} \sqrt{L}}\right)
$$

We thus get

$$
u^{2}\left(x_{N}\right) \leq O\left(L^{-\frac{1}{2}}\right)+O(\epsilon)+a_{N}^{2}
$$

Similarly,

$$
v^{2}\left(x_{N}\right) \leq O\left(L^{-\frac{1}{2}}\right)+O(\epsilon)+b_{N}^{2}
$$

Combining the identity $\left|M_{N}-c_{N}\right| \leq O\left(L^{-1 / 4}\right)+O\left(\epsilon^{1 / 2}\right)$, we arrive at

$$
\left|u\left(x_{N}\right)-a_{N}\right| \leq O\left(L^{-\frac{1}{4}}\right)+O\left(\epsilon^{\frac{1}{2}}\right) \quad \text { and } \quad\left|v\left(x_{N}\right)-b_{N}\right| \leq O\left(L^{-\frac{1}{4}}\right)+O\left(\epsilon^{\frac{1}{2}}\right)
$$

Step 2. Assume for any $k \leq i<N$, we have

$$
\left|u\left(x_{i}\right)-a_{i}\right| \leq O\left(L^{-\frac{1}{4}}\right)+O\left(\epsilon^{\frac{1}{2}}\right) \quad \text { and } \quad\left|v\left(x_{i}\right)-b_{i}\right| \leq O\left(L^{-\frac{1}{4}}\right)+O\left(\epsilon^{\frac{1}{2}}\right)
$$

We need to prove

$$
\left|u\left(x_{i-1}\right)-a_{i-1}\right| \leq O\left(L^{-\frac{1}{4}}\right)+O\left(\epsilon^{\frac{1}{2}}\right) \quad \text { and } \quad\left|v\left(x_{i-1}\right)-b_{i-1}\right| \leq O\left(L^{-\frac{1}{4}}\right)+O\left(\epsilon^{\frac{1}{2}}\right)
$$

Firstly, we have

$$
\begin{aligned}
\sum_{i=k-1}^{N} u^{2}\left(x_{i}\right) \leq & \frac{1}{2} \sum_{i=k-1}^{N} E_{u i}(u(t))+O\left(L^{-\frac{1}{2}}\right) \\
\leq & \frac{1}{2}\left(\mathcal{J}_{k-1, K}^{u}(t)-\mathcal{J}_{k-1, K}^{u}(0)\right)+\frac{1}{2}\left(\mathcal{J}_{k-1, K}^{u}(0)-\sum_{i=k-1}^{N} E_{u}\left(\varphi_{c_{i}}\right)\right) \\
& +\frac{1}{2} \sum_{i=k-1}^{N} E_{u}\left(\varphi_{c_{i}}\right)+O\left(L^{-\frac{1}{2}}\right) .
\end{aligned}
$$

It follows that

$$
\sum_{i=k-1}^{N} u^{2}\left(x_{i}\right) \leq \frac{1}{2} \sum_{i=k-1}^{N} E_{u}\left(\varphi_{c_{i}}\right)+O\left(L^{-\frac{1}{2}}\right)+O(\epsilon) .
$$

Using the assumption, we find

$$
u^{2}\left(x_{k-1}\right) \leq a_{k-1}^{2}+O\left(L^{-\frac{1}{4}}\right)+O(\sqrt{\epsilon}) .
$$

Similarly

$$
v^{2}\left(x_{k-1}\right) \leq b_{k-1}^{2}+O\left(L^{-\frac{1}{4}}\right)+O(\sqrt{\epsilon}) .
$$

Those together with the identity (4.8) imply that for any $i=1, \cdots, N$

$$
\left|u\left(x_{i}\right)-a_{i}\right| \leq O\left(L^{-\frac{1}{4}}\right)+O\left(\epsilon^{\frac{1}{2}}\right) \quad \text { and } \quad\left|v\left(x_{i}\right)-b_{i}\right| \leq O\left(L^{-\frac{1}{4}}\right)+O\left(\epsilon^{\frac{1}{2}}\right) .
$$

End of the Proof of Theorem 1.2. To conclude the proof, from the (4.6), it thus suffices to prove that there exists $C>0$ which does not depend on $A$ such that

$$
\left|u\left(x_{N}\right)-a_{N}\right| \leq C\left(L^{-\frac{1}{4}}+\epsilon^{\frac{1}{2}}\right) \quad \text { and } \quad\left|v\left(x_{N}\right)-b_{N}\right| \leq C\left(L^{-\frac{1}{4}}+\epsilon^{\frac{1}{2}}\right)
$$

which has been verified by (4.9). From (4.5) and (4.7), we know that for $i=2, \ldots, N$,

$$
x_{i}-x_{i-1} \geq \frac{2}{3} L .
$$

This completes the proof of the theorem.
