# Strain Tensors and Matching Property on Surfaces with the Gauss curvature changing sign

#### Abstract

We prove the regularity of solutions to the strain tensor equation on a region $S$ with the Gauss curvature changing sign. Furthermore, we obtain the density property that smooth infinitesimal isometries are dense in the $W^{2,2}\left(S, \mathbb{R}^{3}\right)$ infinitesimal isometries. Finally, the matching property is established. Those results are important tools in obtaining recovery sequences ( $\Gamma$-lim sup inequality) for dimensionallyreduced shell theories in elasticity.

## 1 Introduction and Main Results

Let $M \subset \mathbb{R}^{3}$ be a surface with a normal $\vec{n}$ and let the middle surface of a shell be an open set $S \subset M$. Let $T^{k} S$ denote all the $k$-order tensor fields on $S$ for an integer $k \geq 0$. Let $T_{\text {sym }}^{2} S$ be all the 2-order symmetrical tensor fields on $S$. For $y \in \mathrm{~W}^{1,2}\left(S, \mathbb{R}^{3}\right)$, we decompose it into $y=W+w \vec{n}$, where $w=\langle y, \vec{n}\rangle$ and $W \in T S$. For $U \in T_{\text {sym }}^{2} S$ given, linear strain tensor of a displacement $y \in \mathrm{~W}^{1,2}\left(S, \mathbb{R}^{3}\right)$ of the middle surface $S$ takes the form

[^0]where $D$ is the connection of the induced metric in $M, 2 \operatorname{sym} D W=D W+D^{T} W$, and $\Pi$ is the second fundamental form of $M$. Equation (1.1) plays a fundamental role in the theory of thin shells, see $[4,6,5,7,13,15]$ and many others. When $U=0$, a solution $y$ to (1.1) is referred to as an infinitesimal isometry.

The type of equation (1.1) depends on the sign of the curvature on the region $S$ : It is elliptic if $S$ has positive curvature; it is parabolic if the curvature is zero but $\Pi \neq 0$ on $S$; it is hyperbolic if $S$ has negative curvature. When the curvature of the region $S$ changes its sign, problem (1.1) is of changing type.

Here we establish the regularity of solutions to (1.1) when $S$ is a region with its curvature changing sign, which will be specified below. Then it is proved that smooth infinitesimal isometries are dense in the $W^{2,2}\left(S, \mathbb{R}^{3}\right)$ infinitesimal isometries on the region $S$. Finally, the matching property is derived that smooth enough infinitesimal isometries can be matched with higher order infinitesimal isometries. Those results are important tools in obtaining recovery sequences ( $\Gamma$-lim sup inequality) for dimensionally-reduced shell theories in elasticity, when the elastic energy density scales like $h^{\beta}, \beta \in(2,4)$, that is, intermediate regime between "pure bending" $(\beta=2)$ and the von-Kármán regime $(\beta=4)$. Such results have been obtained for elliptic surfaces [7], developable surfaces [4], and hyperbolic surfaces [13, 15]. Moreover, the case of degenerated hyperbolic surfaces has been studied in [1]. A survey on this topic is presented in [5].

Mixed type equations also arise naturally in many other areas. A detailed account of the historical background and known results on mixed type equations and transonic flows is given in [8]. A detailed review on mixed type equations and Riemannian-Lorentzian metrics is presented in [11]. The most intensively studied equation of mixed type is the Tricomi equation [10].

In this paper we study the mixed type equation (1.1) which is very different from all the above cases. Equation (1.1) is equivalent to a mixed type scalar equation of the form

$\kappa \neq 0$, where $w \in \mathrm{~L}^{2}(S)$ is the unknown, $f \in \mathrm{~L}^{2}(S)$ and $F \in \mathrm{~L}^{2}(S, T S)$ are given, and $\kappa$ is the Gauss curvature. The type of (1.2) is subject to the sign of $\kappa$. When $\kappa=0$, there are two terms degenerating in (1.2): The coefficient of $\left\langle D w-F, X_{0}\right\rangle$ becomes from $+\infty$ to $-\infty$ as a point crosses a zero curvature curve from the positive curvature to the negative. The coefficient of a second derivative of $w$ along the direction of the zero principal curvature changes from positive to negative. Those situations challenge the analysis of (1.2).

We observe that problem (1.2) is equivalent to a vector field system as

where $\nabla \vec{n}: S_{x} \rightarrow S_{x}$ is the second fundamental form operator, $(V, v)$ is the unknown where $V$ is a vector field and $v$ is function, and $(F, f)$ is as in (1.2). Problem (1.3) changes type when the curvature changes sign. In order to have solutions to problem (1.1), one normally starts to solve problem (1.2) in the previous works as in [1, 4, 7, 13]. However, it makes the solvability of (1.2) extremely difficult that the coefficient of $\left\langle D w-F, X_{0}\right\rangle$ varies between $+\infty$ and $-\infty$ when the curvature changes sign. Instead of analysing (1.2), here we begin from (1.3) and then obtain solutions to (1.1). The hard task is to achieve regularity of solutions to (1.3) by some priori estimates near the zero curvature curve. Thanks to the Bochner technique and the tensor analysis, the regularity analysis has been complete in Section 3.

We state our main results as follows. Let $S \subset M$ be given by

where $\alpha:[0, a) \times[0, b] \rightarrow M$ is an imbedding map which is a family of regular curves with two parameters $t, s$ such that

where $\alpha(\cdot, s)$ is a closed curve with period $a$ for each $s \in\left[-b_{0}, b_{1}\right]$. Set

where

Curvature assumptions Let $\kappa$ be the Gaussian curvature function on $M$. We assume that $S$ satisfies the following curvature conditions:

where

\Gamma_{b_{1}}=\left\{\alpha\left(t, b_{1}\right) \mid t \in[0, a)\right\}, \quad \Gamma_{-b_{0}}=\left\{\alpha\left(t,-b_{0}\right) \mid t \in[0, a)\right\} .

Our main results are the following.
Theorem 1.1. Let $S$ be of class $\mathrm{C}^{m+5}$ for some integer $m \geq 1$. For $U \in \mathrm{~W}^{m+1,2}\left(S, T_{\mathrm{sym}}^{2} S\right)$, there exists a solution $y=W+w \vec{n} \in \mathrm{~W}^{m, 2}\left(S, \mathbb{R}^{3}\right)$ to equation (1.1) satisfying

\|W\|_{\mathrm{W}^{m+1,2}(S, T S)}^{2}+\|w\|_{\mathrm{W}^{m, 2}(S)}^{2} \leq C\|U\|_{\mathrm{W}^{m+1,2}\left(S, T_{\mathrm{sym}}^{2} S\right)^{2}}^{2}
$$

Remark 1.1. The curvature of $S$ affects the regularity of (1.1) as

\begin{cases}\|y\|_{\mathrm{W}^{m, 2}\left(S, \mathbb{R}^{3}\right)}^{2} \leq C\|U\|_{\mathrm{W}^{m, 2}\left(S, T_{\mathrm{sym}}^{2} S\right)}^{2} & \text { if } \kappa>0 \text { on } \bar{S} \\ \|y\|_{\mathrm{W}^{m, 2}\left(S, \mathbb{R}^{3}\right)}^{2} \leq C\|U\|_{\mathrm{W}^{m+1,2}\left(S, T_{\mathrm{sym}}^{2} S\right)}^{2} & \text { if } \kappa<0 \text { on } \bar{S} .\end{cases}
$$

By the imbedding theorem [3, P. 158], the following corollary is immediate.
Corollary 1.1. Let $S$ be of $S \in \mathrm{C}^{m+5}$ for some integer $m \geq 0$. Then problem (1.1) admits a solution $y=W+w \vec{n} \in \mathrm{C}_{B}^{m}\left(S, \mathbb{R}^{3}\right)$ satisfying

For $y \in \mathrm{~W}^{1,2}\left(S, \mathbb{R}^{3}\right)$, we denote the left hand side of equation (1.1) by $\operatorname{sym} \nabla y$. Let

Theorem 1.2. Let $S$ be of class $\mathrm{C}^{m+5,1}$. Then, for every $y \in \mathcal{V}\left(S, \mathbb{R}^{3}\right)$ there exists a sequence $\left\{y_{k}\right\} \subset \mathcal{V}\left(S, \mathbb{R}^{3}\right) \cap \mathrm{C}_{B}^{m}\left(S, \mathbb{R}^{3}\right)$ such that

\lim _{k \rightarrow \infty}\left\|y-y_{k}\right\|_{\mathrm{W}^{2,2}\left(S, \mathbb{R}^{3}\right)}=0

A one parameter family $\left\{y_{\varepsilon}\right\}_{\varepsilon>0} \subset \mathrm{C}_{B}^{1}\left(\bar{S}, \mathbb{R}^{3}\right)$ is said to be a (generalized) $m$ th order infinitesimal isometry if the change of metric induced by $y_{\varepsilon}$ is of order $\varepsilon^{m+1}$, that is,

where $g$ is the induced metric of $M$ from $\mathbb{R}^{3}$, see [4]. A given $m$ th order infinitesimal isometry can be modified by higher order corrections to yield an infinitesimal isometry of order $m_{1}>m$, a property to which we refer to by matching property of infinitesimal isometries, [4, 7].

Theorem 1.3. Let $S$ be of class $\mathrm{C}^{4 m, 1}$. Given $y \in \mathcal{V}\left(S, \mathbb{R}^{3}\right) \cap \mathrm{C}_{B}^{4 m-2}\left(S, \mathbb{R}^{3}\right)$, there exists a family $\left\{z_{\varepsilon}\right\}_{\varepsilon>0} \subset \mathrm{C}_{B}^{2}\left(S, \mathbb{R}^{3}\right)$, equi-bounded in $\mathrm{C}_{B}^{2}\left(S, \mathbb{R}^{3}\right)$, such that for all small $\varepsilon>0$ the family:

is a mth order infinitesimal isometry of class $\mathrm{C}_{B}^{2}\left(S, \mathbb{R}^{3}\right)$.
Application to elasticity of thin shells Let $\vec{n}$ be the normal field of surface $M$. Consider a family $\left\{S_{h}\right\}_{h>0}$ of thin shells of thickness $h$ around $S$,

where $h_{0}$ is small enough so that the projection map $\pi: S_{h} \rightarrow S, \pi(x+t \vec{n})=x$ is well defined. For a $\mathrm{W}^{1,2}$ deformation $u_{h}: S_{h} \rightarrow \mathbb{R}^{3}$, we assume that its elastic energy (scaled per unit thickness) is given by the nonlinear functional:

The stored-energy density function $W: \mathbb{R}^{3} \times \mathbb{R}^{3} \rightarrow \mathbb{R}$ is $\mathrm{C}^{2}$ in an open neighborhood of $\mathrm{SO}(3)$, and it is assumed to satisfy the conditions of normalization, frame indifference and quadratic growth: For all $F \in \mathbb{R}^{3} \times \mathbb{R}^{3}, R \in \mathrm{SO}(3)$,

W(R)=0, \quad W(R F)=W(F), \quad W(F) \geq C \operatorname{dist}^{2}(F, \mathrm{SO}(3)),

with a uniform constant $C>0$. The potential $W$ induces the quadratic forms ([2])

Let $A: S \rightarrow \mathbb{R}^{3 \times 3}$ be a matrix field. We define $A \in T^{2} S$ by

For given $V \in \mathcal{V}\left(\Omega, \mathbb{R}^{3}\right)$, there exists a unique $A \in \mathrm{~W}^{1,2}\left(S, T^{2}\right)$ such that

We shall consider a sequence $e_{h}>0$ such that:

Recall the following results.
Theorem 1.4. [6] Let $S$ be a surface embedded in $\mathbb{R}^{3}$, which is compact, connected, oriented, of class $\mathrm{C}^{1,1}$, and whose boundary $\partial S$ is the union of finitely many Lipschitz curves. Let $u_{h} \in \mathrm{~W}^{1,2}\left(S_{h}, \mathbb{R}^{3}\right)$ be a sequence of deformations whose scaled energies $E_{h}\left(u_{h}\right) / e_{h}$ are uniformly bounded. Then there exist a sequence $Q_{h} \in \mathrm{SO}(3)$ and $c_{h} \in \mathbb{R}^{3}$ such that for the normalized rescaled deformations

the following holds.
(i) $y_{h}$ converge to $\pi$ in $\mathrm{W}^{1,2}\left(S_{h_{0}}, \mathbb{R}^{3}\right)$.
(ii) The scaled average displacements

converge to some $V \in \mathcal{V}\left(S, \mathbb{R}^{3}\right)$.
(iii) $\liminf _{h \rightarrow 0} E_{h}\left(u_{h}\right) / e_{h} \geq I(V)$, where

where $A$ is given in (1.9).
The above result proves the lower bound for the $\Gamma$-convergence. With Theorems 1.2 and 1.3 a recover sequence can be constructed in the $\Gamma$-limit for thin shells as in $[4,7,13]$ such that the following theorem holds true. The details of the proof are omitted.

Theorem 1.5. Let $S \subset M$ be of class $C^{5,1}$ given in (1.4) with (1.5) - (1.8). Suppose that

Then for every $V \in \mathcal{V}\left(S, \mathbb{R}^{3}\right)$ there exists a sequence of deformations $\left\{u_{h}\right\} \subset \mathrm{W}^{1,2}\left(S, \mathbb{R}^{3}\right)$ such that ( $i$ ) and (ii) of Theorem 1.4 hold. Moreover,

where $I(V)$ is given in (1.11).

## $2 \quad L^{2}$ Solutions of the tensor equation of mixed type

Let $\nabla$ and $D$ denote the connection of $\mathbb{R}^{3}$ in the Euclidean metric and the one of $M$ in the reduced metric, respectively. We have to treat the relationship between $\nabla$ and $D$ carefully.

Let $m \geq 1$ be an integer. Let $T \in T^{m} M$ be a $m$ th order tensor field on $M$. We define a $m-1$ th order tensor field by

\mathrm{i}_{Y} T\left(Y_{1}, \cdots, Y_{m-1}\right)=T\left(Y, Y_{1}, \cdots, Y_{m-1}\right) \quad \text { for } \quad Y_{1}, \cdots, Y_{m-1} \in T M
$$

which is called an inner product of $T$ with $Y$. For any $T \in T^{2} S$ and $\alpha \in T_{x} M$,

\operatorname{tr}_{g} \mathrm{i}_{\alpha} D T
$$

is a linear functional on $T_{x} M$, where $\operatorname{tr}_{g} \mathrm{i}_{\alpha} D T$ is the trace of the 2-order tensor field $\mathrm{i}_{\alpha} D T$ in the induced metric $g$. Thus there is a vector, denoted by $\operatorname{div}_{g} T$, such that

Clearly, the above formula defines a vector field $\operatorname{div}_{g} T \in T M$.
We need a linear operator $Q$ ([13], [15]) as follows. For each point $p \in M$, the Riesz representation theorem implies that there exists an isomorphism $Q: T_{p} M \rightarrow T_{p} M$ such that

Let $e_{1}, e_{2}$ be an orthonormal basis of $T_{p} M$ with positive orientation, that is,

Then $Q$ can be expressed explicitly by

Operator $Q$ plays an important role in our analysis.
Here we sum up some formulas about operator $Q$ and their proofs have been given in [1].

Lemma 2.1. The following identities hold.

Lemma 2.2. For any $Z, X, V, W \in T M$,

## $4 \mathrm{~W}^{m, 2}$ Solutions of a coupling tensor system of mixed type

For given $(F, f) \in \mathrm{L}^{2}\left(\Omega_{-\varepsilon}, T\right)$ arbitrarily, we directly seek some appropriate conditions on the boundary data $(p, q) \in \mathrm{L}^{2}\left(\Gamma_{-\varepsilon}\right) \times \mathrm{L}^{2}\left(\Gamma_{b_{1}}\right)$ such that problem

\left.V\right|_{\Gamma_{b_{1}}} \in \mathrm{C}^{m+1}\left(\Gamma_{b_{1}}\right),\left.\quad V\right|_{\Gamma_{-\varepsilon}} \in \mathrm{W}^{1,2}\left(\Gamma_{-\varepsilon}\right) .
$$

Set

$$
p=\left.\langle V, Q X\rangle\right|_{\Gamma_{-\varepsilon}}, \quad q=\left.\langle V, \nu\rangle\right|_{\Gamma_{b_{1}}} .
$$

We decompose as the direct sum

$$
(V, v)=\left(V_{1}, v_{1}\right)+\left(V_{0}, v_{0}\right) \quad \text { in } \quad \mathrm{L}^{2}\left(\Omega_{-\varepsilon}, T\right) \times \mathrm{W}^{1,2}\left(\Omega_{-\varepsilon}\right),
$$

where $\left(V_{0}, v_{0}\right) \in \mathcal{N}_{1}$ and $\mathcal{N}_{1}$ is given by (5.43). Then

$$
\left(V_{0}, v_{0}\right) \in \mathrm{W}^{m+4,2}\left(\Omega_{-\varepsilon}, T\right) \times \mathrm{W}^{m+5,2}\left(\Omega_{-\varepsilon}\right)
$$

and $\left(V_{1}, v_{1}\right) \in \mathrm{L}^{2}\left(\Omega_{-\varepsilon}, T\right) \times \mathrm{W}^{1,2}\left(\Omega_{-\varepsilon}\right)$ solves problem (5.42). By Theorem 4.2

$$
(p, q) \perp \aleph \quad \text { in } \quad \mathrm{L}^{2}\left(\Gamma_{-\varepsilon}\right) \times \mathrm{L}^{2}\left(\Gamma_{b_{1}}\right),
$$

and

$$
\left\|\left(V_{1}, v_{1}\right)\right\|_{\mathrm{W}^{1,2}\left(\Omega_{-\varepsilon}, T\right) \times \mathrm{W}^{2,2}\left(\Omega_{-\varepsilon}\right)} \leq C\|(p, q)\|_{\mathrm{W}^{1,2}\left(\Gamma_{-\varepsilon}\right) \times \mathrm{W}^{1,2}\left(\Gamma_{b_{1}}\right)}^{2},
$$

where $\aleph$ is given in (5.41).
Next, for given $\iota>0$ arbitrarily, we take $\left(p_{\iota}, q_{\iota}\right) \in \mathrm{W}^{m+1,2}\left(\Gamma_{-\varepsilon}\right) \times \mathrm{W}^{m+1,2}\left(\Gamma_{b_{1}}\right)$ such that

$$
\left\|(p, q)-\left(p_{\iota}, q_{\iota}\right)\right\|_{\mathrm{W}^{1,2}\left(\Gamma_{-\varepsilon}\right) \times \mathrm{W}^{1,2}\left(\Gamma_{b_{1}}\right)} \leq \iota .
$$

Denote by ( $\hat{p}_{\iota}, \hat{q}_{\iota}$ ) by the orthogonal projection of $\left(p_{\iota}, q_{\iota}\right)$ from $\mathrm{L}^{2}\left(\Gamma_{-\varepsilon}\right) \times \mathrm{L}^{2}\left(\Gamma_{b_{1}}\right)$ to $\aleph^{\perp}$ in $L^{2}\left(\Gamma_{-\varepsilon}\right) \times L^{2}\left(\Gamma_{b_{1}}\right)$. Since $\operatorname{dim} \aleph<\infty$, we have

$$
\left\|(p, q)-\left(\hat{p}_{\iota}, \hat{q}_{\iota}\right)\right\|_{\mathrm{W}^{1,2}\left(\Gamma_{-\varepsilon}\right) \times \mathrm{W}^{1,2}\left(\Gamma_{b_{1}}\right)} \leq C \iota .
$$

By Theorem 4.2 problem (5.42) admits a unique solution $\left(V_{\iota}, v_{\iota}\right) \in \mathcal{N}_{1}^{\perp}$ in $\mathrm{L}^{2}\left(\Omega_{-\varepsilon}\right) \times$ $\mathrm{W}^{1,2}\left(\Omega_{-\varepsilon}\right)$, and

$$
\left\|\left(V_{\iota}, v_{\iota}\right)\right\|_{\mathrm{W}^{m+1,2}\left(\Omega_{-\varepsilon}, T\right) \times \mathrm{W}^{m+2,2}\left(\Omega_{-\varepsilon}\right)} \leq C\left\|\left(\hat{p}_{\iota}, \hat{q}_{\iota}\right)\right\|_{\mathrm{W}^{m+1,2}\left(\Gamma_{-\varepsilon}\right) \times \mathrm{W}^{m+1,2}\left(\Gamma_{b_{1}}\right)} .
$$

Thus

$$
\left(V_{\iota}, v_{\iota}\right) \in \mathrm{C}_{B}^{m-1}\left(\Omega_{-\varepsilon}\right),
$$

and

$$
\left\|\left(V_{1}, v_{1}\right)-\left(V_{\iota}, v_{\iota}\right)\right\|_{\mathrm{W}^{1,2}\left(\Gamma_{-\varepsilon}\right) \times \mathrm{W}^{1,2}\left(\Gamma_{b_{1}}\right)} \leq C \iota .
$$

Now we extend the domains of $\left(V_{1}, v_{1}\right),\left(V_{0}, v_{0}\right)$, and $\left(V_{\iota}, v_{\iota}\right)$ from $\Omega_{-\varepsilon}$ to $S$, respectively, as in the proof of Theorem 1.1, with the same notations such that

$$
\begin{gathered}
(V, v)=\left(V_{1}, v_{1}\right)+\left(V_{0}, v_{0}\right) \quad \text { in } \quad \mathrm{W}^{1,2}(S, T) \times \mathrm{W}^{2,2}(S), \\
\left(V_{\iota}, v_{\iota}\right) \in \mathrm{C}_{B}^{m-1}(S),
\end{gathered}
$$

$\left(V_{1}, v_{1}\right),\left(V_{0}, v_{0}\right)$, and $\left(V_{\iota}, v_{\iota}\right)$ satisfy problem (6.10) on the region $S$, respectively, and

$$
\left\|(V, v)-\left(V_{\iota}+V_{0}, v_{\iota}+v_{0}\right)\right\|_{\mathrm{W}^{1,2}(S, T) \times \mathrm{W}^{2,2}(S)} \leq C \iota .
$$

The proof is complete by the formula (6.5).

Proof of Theorem 1.3 As in [4] we conduct in $2 \leq i \leq m$. Let

$$
y_{\varepsilon}=\sum_{j=0}^{i-1} \varepsilon^{j} z_{j}
$$

be an $(i-1)$ th order isometry of class $\mathrm{C}_{B}^{2+4(m-i+1)}\left(S, \mathbb{R}^{3}\right)$, where $z_{0}=$ id and $z_{2}=y$ for some $i \geq 2$. Then

$$
\sum_{j=0}^{k} \nabla^{T} z_{j} \nabla z_{k-j}=0 \quad \text { for } \quad 1 \leq k \leq i-1
$$

Next, we shall find out $z_{i} \in \mathrm{C}_{B}^{2+4(m-i)}\left(S, \mathbb{R}^{3}\right)$ such that

$$
\phi_{\varepsilon}=y_{\varepsilon}+\varepsilon^{i} z_{i}
$$

is an $i$ th order isometry. By Corollary 1.1 there exists a solution $z_{i} \in \mathrm{C}_{B}^{2+4(m-i)}\left(S, \mathbb{R}^{3}\right)$ to problem

$$
\operatorname{sym} \nabla z_{i}=-\frac{1}{2} \operatorname{sym} \sum_{j=1}^{i-1} \nabla^{T} z_{j} \nabla z_{i-j}
$$

which satisfies

$$
\begin{aligned}
\left\|z_{i}\right\|_{\mathrm{C}_{B}^{2+4(m-i)}\left(S, \mathbb{R}^{3}\right)} & \leq C\left\|\sum_{j=1}^{i-1} \operatorname{sym} \nabla^{T} z_{j} \nabla z_{i-j}\right\|_{\mathrm{C}_{B}^{2+4(m-i)+3}\left(S, \mathbb{R}^{3}\right)} \\
& \leq C \sum_{j=1}^{i-1}\left\|z_{j}\right\|_{\mathrm{C}_{B}^{2+4(m-i+1)}\left(S, \mathbb{R}^{3}\right)}\left\|z_{i-j}\right\|_{\mathrm{C}_{B}^{2+4(m-i+1)}\left(S, \mathbb{R}^{3}\right)}
\end{aligned}
$$

The conduction completes.

## Appendix: A theorem of Lax-Milgram's type

The following theorem is an improved version of the Lax-Milgram theorem.
Theorem A Let $\left(\mathcal{V},\langle\cdot, \cdot\rangle_{\mathcal{V}}\right)$ be a Hilbert space. Suppose that $\mathcal{W} \subset \mathcal{V}$ is a linear subspace of $\mathcal{V}$ such that $\left(\mathcal{W},\langle\cdot, \cdot\rangle_{\mathcal{W}}\right)$ is an inner product space, which may not be complete. Let $\beta$ : $\mathcal{V} \times \mathcal{W} \rightarrow \mathbb{R}$ be a bilinear functional satisfying

$$
\begin{gather*}
|\beta(v, w)| \leq C\|v\|_{\mathcal{V}}\|w\|_{\mathcal{W}} \quad \text { for } \quad v \in \mathcal{V}, w \in \mathcal{W},  \tag{6.11}\\
\beta(w, w) \geq \sigma\|w\|_{\mathcal{V}}^{2} \quad \text { for } \quad w \in \mathcal{W} . \tag{6.12}
\end{gather*}
$$

Then there is a closed linear subspace $\mathcal{V}^{\prime} \subset \mathcal{V}$ such that for given bounded linear functional $\mathcal{F}$ on $\mathcal{V}$, there exists a unique $v \in \mathcal{V}^{\prime}$ satisfying

$$
\begin{gather*}
\mathcal{F}(w)=\beta(v, w) \quad \text { for } \quad w \in \mathcal{W}, \\
\|v\| \leq \frac{1}{\sigma}\|\mathcal{F}\|_{\mathcal{V}^{*}} \tag{6.13}
\end{gather*}
$$

Proof. For given $w \in \mathcal{W}$, from (6.11) $\beta(\cdot, w)$ is a bounded linear functional on $\mathcal{V}$. The Riesz representation theorem implies that there exists a bounded linear operator $A: \mathcal{W} \rightarrow \mathcal{V}$ such that

$$
\beta(v, w)=\langle v, A w\rangle_{\mathcal{V}} \quad \text { for } \quad v \in \mathcal{V}, w \in \mathcal{W}
$$

Then $\|A\| \leq C$. Thus

$$
\langle w, A w\rangle_{\mathcal{V}}=\beta(w, w) \geq \sigma\|w\|_{\mathcal{V}}^{2} \quad \text { for } \quad w \in \mathcal{W}
$$

which yield

$$
\begin{equation*}
\|A w\|_{\mathcal{V}} \geq \sigma\|w\|_{\mathcal{V}} \quad \text { for } \quad w \in \mathcal{W} \tag{6.14}
\end{equation*}
$$

Let $\mathcal{V}^{\prime}$ be the closure of $R(A)$ in $\mathcal{V}$. Then for given $y \in \mathcal{V}^{\prime}$ there is a sequence $\left\{w_{k}\right\}_{1}^{\infty} \subset$ $\mathcal{W}$ such that

$$
\left\|y-A w_{k}\right\|_{\mathcal{V}} \rightarrow 0 \quad \text { as } \quad k \rightarrow \infty
$$

Define

$$
\varphi(y)=\lim _{k \rightarrow \infty} \mathcal{F}\left(w_{k}\right) .
$$

By (6.14) $\varphi$ is a bounded linear functional on $\mathcal{V}^{\prime}$. By the Riesz representation theorem there exists a unique $v \in \mathcal{V}^{\prime}$ such that

$$
\varphi(y)=\langle v, y\rangle_{\mathcal{V}} \quad \text { for } \quad y \in \mathcal{V}^{\prime}
$$

In particular, letting $y=A w$ for $w \in \mathcal{W}$ yields

$$
\mathcal{F}(w)=\varphi(y)=\langle v, A w\rangle_{\mathcal{V}}=\beta(v, w) \quad \text { for } \quad w \in \mathcal{W} .
$$

Finally, (6.13) follows from (6.14).
