# NUMERICAL FLATNESS AND PRINCIPAL BUNDLES ON FUJIKI MANIFOLDS

#### Abstract

Let $M$ be a compact connected Fujiki manifold, $G$ a semisimple affine algebraic group over $\mathbb{C}$ with one simple factor and $P$ a fixed proper parabolic subgroup of $G$. For a holomorphic principal $G$-bundle $E_{G}$ over $M$, let $\mathcal{E}_{P}$ be the holomorphic principal $P$-bundle $E_{G} \longrightarrow E_{G} / P$ given by the quotient map. We prove that the following three statements are equivalent: (1) ad $\left(E_{G}\right)$ is numerically flat, (2) the holomorphic line bundle $\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}$ is nef, and (3) for every reduced irreducible compact complex analytic space $Z$ with a Kähler form $\omega$, holomorphic map $\gamma: Z \longrightarrow M$, and holomorphic reduction of structure group $E_{P} \subset \gamma^{*} E_{G}$ to $P$, the inequality degree $\left(\operatorname{ad}\left(E_{P}\right)\right) \leq 0$ holds.


## 1. Introduction

A basic theorem of Miyaoka says that a vector bundle $E$ on a smooth complex projective curve $C$ is semistable if and only if the relative anticanonical line bundle for the natural projection $\mathbb{P}(E) \longrightarrow C$ is nef [Mi]. A holomorphic vector bundle $E$ on $C$ is semistable if and only if the vector bundle $\operatorname{ad}(E) \longrightarrow C$ of trace zero endomorphisms is numerically flat. The very useful notion of numerically flat vector bundles was introduced by Demailly, Peternell and Schneider in [DPS]; we recall that a holomorphic vector bundle $V$ is numerically flat if both $V$ and $V^{*}$ are nef. Therefore, a reformulation of Miyaoka's theorem says that $\operatorname{ad}(E)$ is numerically flat if and only if the relative anticanonical line bundle on $\mathbb{P}(E)$ is nef.

For $E$ as above, fix any $1 \leq r<\operatorname{rank}(E)$. Let $\operatorname{Gr}(r, E) \longrightarrow C$ be be the Grassmann bundle that parametrizes the $r$-dimensional quotients of the fibers of $E$. Bruzzo and Hernández Ruipérez proved the following big generalization of the above theorem of Miyaoka: The relative anticanonical line bundle on $\operatorname{Gr}(r, E)$ is nef if and only if $\operatorname{ad}(E)$ is numerically flat BH$]$.

Let $X$ be a smooth complex projective variety and $E_{G}$ a holomorphic principal $G$ bundle on $X$, where $G$ is a simple affine algebraic group without center over $\mathbb{C}$. Fix a parabolic subgroup $P \subsetneq G$. In $[\mathrm{BB}]$, the following generalization of the above result of Bruzzo and Hernández Ruipérez was proved: The adjoint vector bundle $\operatorname{ad}\left(E_{G}\right)$ is numerically flat if and only if the relative anticanonical line bundle for the natural projection $E_{G} / P \longrightarrow X$ is nef.

[^0]Our aim here is to investigate the principal bundles on a compact Fujiki manifold from the above point of view. We recall that a Fujiki manifold is a compact complex manifold which is the image of a bimeromorphic surjective map from a compact Kähler manifold [Fu1], [Fu2], or equivalently, the image of a holomorphic surjective map from a compact Kähler manifold Va .

Let $G$ be a semisimple affine algebraic group, over $\mathbb{C}$, with one simple factor and $P \subsetneq G$ a fixed parabolic subgroup. Let $M$ be a compact connected Fujiki manifold and $E_{G}$ a holomorphic principal $G$-bundle on $M$. The quotient map $E_{G} \longrightarrow E_{G} / P$ defines a holomorphic principal $P$-bundle on $E_{G} / P$. The top exterior product of the adjoint bundle for this principal $P$-bundle is the relative canonical bundle for the natural projection $E_{G} / P \longrightarrow M$.

We prove the following (see Theorem 3.1 and Theorem 4.1):
Theorem 1.1. Let $E_{G}$ be a holomorphic principal $G$-bundle on a compact connected Fujiki manifold $M$. Then the following three statements are equivalent:
(1) The holomorphic vector bundle $\operatorname{ad}\left(E_{G}\right)$ is numerically flat.
(2) The relative anticanonical bundle for the natural projection $E_{G} / P \longrightarrow M$ is nef.
(3) For every quadruple of the form $\left(Z, \omega, \gamma, E_{P}\right)$, where $Z$ is a reduced irreducible compact complex analytic space equipped with a Kähler form $\omega$,

$$
\gamma: Z \longrightarrow M
$$

is a holomorphic map, and $E_{P} \subset \gamma^{*} E_{G}$ is a holomorphic reduction of structure group of the principal $G$-bundle $\gamma^{*} E_{G}$ to the subgroup $P$, the inequality

$$
\text { degree }\left(\operatorname{ad}\left(E_{P}\right)\right) \leq 0
$$

holds.
Note that the first statement of Theorem 1.1 does not involve the parabolic subgroup $P$. Therefore, Theorem 1.1 has the following corollary:

Corollary 1.2. Let $E_{G}$ be a holomorphic principal $G$-bundle on a compact connected Fujiki manifold M. If the second and third statements in Theorem 1.1 hold for one parabolic subgroup $P \subsetneq G$, then they hold for every proper parabolic subgroup of $G$.

## 2. Numerically flat bundles

Let $M$ be a compact connected complex manifold. Fix a Hermitian structure $H_{0}$ on $M$. Let $\omega_{H_{0}}$ be the corresponding positive (1,1)-form on $M$. A holomorphic line bundle $L$ on $M$ is called numerically effective (nef for short) if for every $\epsilon>0$, there is a Hermitian structure $h_{\epsilon}$ on $L$ such that

$$
\Theta_{h_{\epsilon}}(L) \geq-\epsilon \cdot \omega_{H_{0}}
$$

where $\Theta_{h_{\epsilon}}(L)$ is the curvature of the Hermitian complex connection on $L$ corresponding to $h_{\epsilon}$ [DPS, p. 299, Definition 1.2]. We note that while the definition of nefness uses $H_{0}$, the nefness of any given line bundle is actually independent of the choice of $H_{0}$.

A holomorphic vector bundle $V$ on $M$ is called nef if the tautological line bundle $\mathcal{O}_{\mathbb{P}(V)}(1)$ on $\mathbb{P}(V)$ is nef [DPS, p. 305, Definition 1.9]. A holomorphic vector bundle $V$ on $M$ is called numerically flat if both $V$ and its dual $V^{*}$ are nef [DPS, p. 311, Definition 1.17].

A compact connected complex manifold $M$ is called a Fujiki manifold if there exists a surjective bimeromorphic map

$$
f: Y \longrightarrow M
$$

where $Y$ is a compact Kähler manifold [Fu1], [Fu2]. A basic theorem of Varouchas says that $M$ is a Fujiki manifold if it is the image of a compact Kähler manifold by a surjective morphism (it need not be a bimeromorphism) [Va, p. 51, Theorem 5].

Proposition 2.1. Let $M$ be a compact connected Fujiki manifold, and let

$$
f: Y \longrightarrow M
$$

be a surjective bimeromorphic map, where $Y$ is a compact connected Kähler manifold. Then a holomorphic vector bundle $E$ on $M$ is numerically flat if and only if the pulled back vector bundle $f^{*} E$ is numerically flat.

Proof. Given any nef vector bundle $F$ on $M$, the vector bundle $f^{*} F$ is nef DPS, p. 305, Proposition 1.10]. Applying this to both $E$ and $E^{*}$ we conclude that $f^{*} E$ is numerically flat if $E$ is numerically flat.

To prove the converse, assume that $f^{*} E$ is numerically flat. A structure theorem of [DPS] says that $f^{*} E$ admits a filtration of holomorphic subbundles

$$
\begin{equation*}
0=V_{0} \subset V_{1} \subset \cdots \subset V_{\ell-1} \subset V_{\ell}=f^{*} E \tag{2.1}
\end{equation*}
$$

such that the holomorphic vector bundle $V_{i} / V_{i-1}$ admits a unitary flat connection for all $1 \leq i \leq \ell$ (see [DPS, p. 311, Theorem 1.18]). This immediately implies the following:
(1) the Chern class $c_{i}\left(f^{*} E\right) \in H^{2 i}(Y, \mathbb{R})$ vanishes for every $i \geq 1$ (see [DPS, p. 311, Corollary 1.19]), and
(2) the vector bundle $f^{*} E$ is pseudostable (see [BG, p. 23, Definition 2.1] for pseudostable bundles; set the Higgs field $\theta$ in [BG, Definition 2.1] to be the zero section).

Consequently, $f^{*} E$ admits a flat holomorphic connection $\widetilde{\nabla}$ such that
(1) the connection $\widetilde{\nabla}$ preserves the subbundle $V_{i}$ in (2.1) for every $1 \leq i \leq \ell$, and
(2) the holomorphic connection on $V_{i} / V_{i-1}$ induced by $\widetilde{\nabla}$ is unitary flat for every $1 \leq i \leq \ell$.
(See [BG, p. 20, Theorem 1.1]; set the Higgs field in [BG, Theorem 1.1] to be the zero section.)

For any $1 \leq i \leq \ell$, let $\widetilde{\nabla}^{i}$ be the connection on $V_{i}$ induced by $\widetilde{\nabla}$.

Since the map $f$ is a bimeromorphism, the induced homomorphism of fundamental groups

$$
f_{*}: \pi_{1}(Y) \longrightarrow \pi_{1}(M)
$$

is actually an isomorphism. Therefore, we conclude the following:
(1) the flat connection $\widetilde{\nabla}$ on $f^{*} E$ is the pull-back of a flat connection $\nabla$ on $E$, and
(2) the flat subbundle $\left(V_{i}, \widetilde{\nabla}^{i}\right)$ of $\left(f^{*} E, \widetilde{\nabla}\right)$ descends to a flat subbundle $\left(E_{i}, \nabla^{i}\right)$ of $(E, \nabla)$ for all $1 \leq i \leq \ell$. In other words, $\left(f^{*} E, \widetilde{\nabla}\right)$ is the pullback of the flat subbundle $\left(E_{i}, \nabla^{i}\right)$ of $(E, \nabla)$.

Furthermore, the connection on $E_{i} / E_{i-1}$ induced by $\nabla^{i}$ is unitary flat, because the connection on $V_{i} / V_{i-1}$ induced by $\widetilde{\nabla}$ is unitary flat. The vector bundle $E_{i} / E_{i-1}$ is numerically flat because it admits a unitary flat connection. Since the extension of a nef vector bundle by a nef vector bundle is again nef [DPS, p. 308, Propoisition 1.15(ii)], it follows immediately that the extension of a numerically flat vector bundle by a numerically flat vector bundle is again numerically flat. Consequently, the vector bundle $E$ is numerically flat.

The following is a consequence of the proof of Proposition 2.1.
Corollary 2.2. Let $E$ be a holomorphic vector bundle on a compact connected Fujiki manifold $M$. Then $E$ is numerically flat if and only if there is a filtration of holomorphic subbundles of $E$

$$
0=E_{0} \subset E_{1} \subset \cdots \subset E_{\ell-1} \subset E_{\ell}=E
$$

and a flat holomorphic $\nabla$ on $E$ such that
(1) $\nabla$ preserves $E_{i}$ for all $1 \leq i \leq \ell$, and
(2) the connection on $E_{i} / E_{i-1}$ induced by $\nabla$ is unitary for all $1 \leq i \leq \ell$.

Proof. If there is a filtration as above and a flat holomorphic $\nabla$ on $E$ satisfying the above two conditions, then $E_{i} / E_{i-1}$ is numerically flat for all $1 \leq i \leq \ell$. Therefore, using [DPS, p. 308, Propoisition $1.15(\mathrm{ii})]$ it is deduced that $E$ is numerically flat.

To prove the converse assume that $E$ is numerically flat. Take any surjective bimeromorphic map

$$
f: Y \longrightarrow X
$$

as in Proposition 2.1 with $Y$ Kähler. Then $f^{*} E$ is numerically flat by Proposition 2.1, As we saw in the proof of Proposition 2.1, this implies that there is a filtration as in the statement of the corollary and a flat holomorphic $\nabla$ on $E$ satisfying the two conditions in the statement of the corollary.

## 3. Principal bundles on Fujiki manifolds

Let $G$ be a connected complex semisimple affine algebraic group with one simple factor. Fix a parabolic subgroup

$$
P \subsetneq G .
$$

The Lie algebras of $G$ and $P$ will be denoted by $\mathfrak{g}$ and $\mathfrak{p}$ respectively.
As before, $M$ is a compact connected Fujiki manifold. Let $E_{G}$ be a holomorphic principal $G$-bundle on $M$. Let

$$
\begin{equation*}
\operatorname{ad}\left(E_{G}\right):=E_{G} \times{ }^{G} \mathfrak{g} \longrightarrow M \tag{3.1}
\end{equation*}
$$

be the adjoint bundle for $E_{G}$; its fibers are Lie algebras identified with $\mathfrak{g}$ uniquely up to conjugations.

$$
\text { Let } p: E_{G} \longrightarrow E_{G} / P \text { and } \quad \varphi: E_{G} / P \longrightarrow M
$$

be the natural projections. Consider the projection

$$
\varphi^{*} E_{G}:=\left(E_{G} / P\right) \times_{M} E_{G} \xrightarrow{\mathrm{Id} \times p}\left(E_{G} / P\right) \times_{M}\left(E_{G} / P\right) .
$$

Let

$$
\begin{equation*}
\mathcal{E}_{P} \subset \varphi^{*} E_{G} \tag{3.3}
\end{equation*}
$$

be the inverse image of the diagonal $E_{G} / P \subset\left(E_{G} / P\right) \times_{M}\left(E_{G} / P\right)$ under this projection. It is straight-forward to check that $\mathcal{E}_{P}$ is a holomorphic reduction of structure group of the principal $G$-bundle $\varphi^{*} E_{G}$ to the subgroup $P \subset G$.

Theorem 3.1. Let $E_{G}$ be a holomorphic principal $G$-bundle on a compact connected Fujiki manifold $M$. Then the following two statements are equivalent:
(1) The holomorphic vector bundle $\operatorname{ad}\left(E_{G}\right)$ in (3.1) is numerically flat.
(2) The holomorphic line bundle $\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*} \longrightarrow E_{G} / P$ is nef, where $\mathcal{E}_{P}$ in the holomorphic principal $P$-bundle constructed in (3.3).

Proof. First assume that $\operatorname{ad}\left(E_{G}\right)$ is numerically flat. We will show that $\Lambda^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}$ is nef. For that the following lemma will be used.

Lemma 3.2. The direct image $\varphi_{*} \bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*} \longrightarrow M$, where $\varphi$ is the projection in (3.2), is a vector bundle of positive rank. If this vector bundle $\varphi_{*} \bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}$ is nef, then $\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}$ is also nef.

Proof of Lemma 3.2. The line bundle

$$
\bigwedge^{\mathrm{top}} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*} \longrightarrow E_{G} / P
$$

is the relative anti-canonical line bundle for the projection $\varphi$. So $\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}$ is relatively ample (the anti-canonical line bundle of $G / P$ is ample). Therefore, $\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}$ is relatively very ample (an ample line bundle on $G / P$ is very ample; see $S$ n, Theorem $6.5(2)]$, [Se]). Also the higher direct images of $\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}$ vanish by the Kodaira vanishing theorem. These imply that $\varphi_{*} \bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*} \longrightarrow M$ is a holomorphic vector bundle of positive rank.

Since $\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}$ is relatively very ample, we get an embedding

$$
\eta: E_{G} / P \longrightarrow \mathbb{P}\left(\varphi_{*} \bigwedge^{\mathrm{top}} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}\right)
$$

The pulled back line bundle $\left.\eta^{*} \mathcal{O}_{\mathbb{P}\left(\varphi_{*} \Lambda^{\text {top }}\right.} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}\right)(1)$ is identified with $\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}$. Consequently, $\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}$ is nef if $\varphi_{*} \bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}$ is nef, because $\left.\mathcal{O}_{\mathbb{P}\left(\varphi_{*}\right.} \Lambda^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}\right)(1)$ is nef in that case.

Let

$$
\begin{equation*}
Z_{G} \subset G \tag{3.4}
\end{equation*}
$$

be the center of $G$. We note that the left-translation action of $G$ on $G / P$ produces an action of $G$ on $H^{0}\left(G / P, K_{G / P}^{-1}\right)$, where $K_{G / P}^{-1}$ is the anti-canonical line bundle. The action of $Z_{G}$ on $G / P$ is trivial because $Z_{G} \subset P$. Also, the action of $Z_{G}$ on $H^{0}\left(G / P, K_{G / P}^{-1}\right)$ is trivial, because the adjoint action of $Z_{G}$ is trivial. So we get an action of $G / Z_{G}$ on $H^{0}\left(G / P, K_{G / P}^{-1}\right)$.

Since $G$ is semisimple, the adjoint action of $G / Z_{G}$ on $\mathfrak{g}$ is faithful. Also, the $G / Z_{G^{-}}$ module $\mathfrak{g}$ is isomorphic to $\mathfrak{g}^{*}$ using the Killing form on $\mathfrak{g}$. Therefore, there are nonnegative integers $t_{1}, \cdots, t_{n}$ such that the $G / Z_{G}-$ module $H^{0}\left(G / P, K_{G / P}^{-1}\right)$ is a direct summand of the $G / Z_{G}$-module

$$
\bigoplus_{j=1}^{n} \mathfrak{g}^{\otimes t_{j}}
$$

(see [DM, p. 40, Proposition 3.1(a)]). This implies that the holomorphic vector bundle $\varphi_{*} \bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}$ is a direct summand of the holomorphic vector bundle

$$
\bigoplus_{j=1}^{n} \operatorname{ad}\left(E_{G}\right)^{\otimes t_{j}}
$$

Indeed, if $\bigoplus_{j=1}^{n} \mathfrak{g}^{\otimes t_{j}}=H^{0}\left(G / P, K_{G / P}^{-1}\right) \oplus A$, where $A$ is a $G / Z_{G}-$ module, then

$$
\bigoplus_{j=1}^{n} \operatorname{ad}\left(E_{G}\right)^{\otimes t_{j}}=\left(\varphi_{*} \bigwedge^{\mathrm{top}} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}\right) \oplus \widetilde{A}
$$

where $\widetilde{A} \longrightarrow M$ is the holomorphic vector bundle associated to the principal $G$-bundle $E_{G}$ for the $G$-module $A$ (any $G / Z_{G}$-module is also a $G$-module).

Since $\operatorname{ad}\left(E_{G}\right)$ is nef, the vector bundle $\operatorname{ad}\left(E_{G}\right)^{\otimes t_{j}}$ is nef [DPS, p. 307, Proposition 1.14(i)], hence $\bigoplus_{j=1}^{n} \operatorname{ad}\left(E_{G}\right)^{\otimes t_{j}}$ is nef [DPS, p. 308, Proposition 1.15(ii)], and therefore, its direct summand $\varphi_{*} \bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}$ is nef [DPS, p. 308, Proposition 1.15(i)]. Now Lemma 3.2 implies that $\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}$ is nef.

To prove the converse, assume that $\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}$ is nef. We will prove that $\operatorname{ad}\left(E_{G}\right)$ is numerically flat.

Since the holomorphic line bundle

$$
\bigwedge^{\mathrm{top}} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}=\left(\bigwedge^{\mathrm{top}} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}\right)^{\otimes 2} \otimes \bigwedge^{\mathrm{top}} \operatorname{ad}\left(\mathcal{E}_{P}\right)=\left(\bigwedge^{\mathrm{top}} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}\right)^{\otimes 2} \otimes K_{\varphi}
$$

is nef, where $K_{\varphi}$ is the relative canonical bundle for the projection $\varphi$ in (3.2), we conclude that the direct image $\varphi_{*}\left(\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}\right)^{\otimes 2}$ is a nef vector bundle [M0, p. 895, Théorème 2].

On the other hand, $\varphi_{*}\left(\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}\right)^{\otimes 2}$ coincides with the holomorphic vector bundle on $M$ associated to the principal $G$-bundle $E_{G}$ for the $G$-module $H^{0}\left(G / P,\left(K_{G / P}^{-1}\right)^{\otimes 2}\right)$. Since the group $G$ is semisimple, it does not have any nontrivial character, in particular, $\bigwedge^{\text {top }} H^{0}\left(G / P,\left(K_{G / P}^{-1}\right)^{\otimes 2}\right)$ is the trivial $G$-module. This implies that the associated holomorphic line bundle $\bigwedge^{\text {top }}\left(\varphi_{*}\left(\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}\right)^{\otimes 2}\right)$ is trivial. Since $\varphi_{*}\left(\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}\right)^{\otimes 2}$ is nef, this implies that $\varphi_{*}\left(\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}\right)^{\otimes 2}$ is numerically flat (see [DPS, p. 311, Definition 1.17]). Since the tensor product of two nef bundles is nef [DPS, p. 307, Proposition 1.14(i)], and both $\varphi_{*}\left(\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}\right)^{\otimes 2}$ and $\varphi_{*}\left(\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}\right)^{\otimes 2}$ are nef, we conclude that that the vector bundle

$$
\begin{equation*}
\operatorname{End}\left(\varphi_{*}\left(\bigwedge^{\mathrm{top}} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}\right)^{\otimes 2}\right)=\left(\varphi_{*}\left(\bigwedge^{\mathrm{top}} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}\right)^{\otimes 2}\right) \otimes\left(\varphi_{*}\left(\bigwedge^{\mathrm{top}} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}\right)^{\otimes 2}\right)^{*} \tag{3.5}
\end{equation*}
$$

is nef. As $\bigwedge^{\text {top }} \operatorname{End}\left(\varphi_{*}\left(\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}\right)^{\otimes 2}\right)$ is the trivial line bundle, it now follows that $\operatorname{End}\left(\varphi_{*}\left(\bigwedge^{\mathrm{top}} \operatorname{ad}\left(\mathcal{E}_{P}\right)^{*}\right)^{\otimes 2}\right)$ is numerically flat (see [DPS, p. 311, Definition 1.17]).

Consider the $G / Z_{G}$-module $H^{0}\left(G / P,\left(K_{G / P}^{-1}\right)^{\otimes 2}\right)$ (the center $Z_{G}$ acts trivially on it). Let

$$
\rho: G / Z_{G} \longrightarrow \mathrm{GL}\left(H^{0}\left(G / P,\left(K_{G / P}^{-1}\right)^{\otimes 2}\right)\right)
$$

be the corresponding homomorphism. We note that $G / Z_{G}$ is simple without center because $G$ has only one simple factor. Hence the above homomorphism $\rho$ is injective. Therefore, the $G$-module $\operatorname{Lie}\left(G / Z_{G}\right)=\mathfrak{g}$ is a direct summand of the $G$-module

$$
\operatorname{Lie}\left(\operatorname{GL}\left(H^{0}\left(G / P,\left(K_{G / P}^{-1}\right)^{\otimes 2}\right)\right)\right)=\operatorname{End}\left(H^{0}\left(G / P,\left(K_{G / P}^{-1}\right)^{\otimes 2}\right)\right)
$$

On the other hand, the holomorphic vector bundle on $M$ associated to the principal $G$ bundle $E_{G}$ for the $G$-module $\operatorname{End}\left(H^{0}\left(G / P,\left(K_{G / P}^{-1}\right)^{\otimes 2}\right)\right)$ coincides with the vector bundle in (3.5). Since the $G$-module $\mathfrak{g}$ is a direct summand of $\operatorname{End}\left(H^{0}\left(G / P,\left(K_{G / P}^{-1}\right)^{\otimes 2}\right)\right)$, we conclude that $\operatorname{ad}\left(E_{G}\right)$ is a direct summand of the vector bundle in (3.5). We saw that the vector bundle in (3.5) is numerically flat. So its direct summand $\operatorname{ad}\left(E_{G}\right)$ is also numerically flat [DPS, p. 308, Proposition 1.15(i)]. This completes the proof of the theorem.

## 4. Pullback to Kähler manifolds

Take $M$ and $E_{G}$ as before. Let

$$
\begin{equation*}
(Z, \omega) \tag{4.1}
\end{equation*}
$$

be a reduced irreducible compact complex analytic space $Z$ with a Kähler form $\omega$, and let

$$
\begin{equation*}
\gamma: Z \longrightarrow M \tag{4.2}
\end{equation*}
$$

be a holomorphic map. Consider the holomorphic principal $G$-bundle $\gamma^{*} E_{G}$ on $Z$. Giving a holomorphic reduction of structure group

$$
E_{P} \subset \gamma^{*} E_{G}
$$

of the principal $G$-bundle $\gamma^{*} E_{G}$ to $P \subset G$ is equivalent to giving a holomorphic section

$$
\sigma: Z \longrightarrow\left(\gamma^{*} E_{G}\right) / P=\gamma^{*}\left(E_{G} / P\right)
$$

of the natural projection $\left(\gamma^{*} E_{G}\right) / P \longrightarrow Z$. Indeed, the inverse image of $\sigma(Z) \subset$ $\left(\gamma^{*} E_{G}\right) / P$ for the quotient map $\gamma^{*} E_{G} \longrightarrow\left(\gamma^{*} E_{G}\right) / P$ is a holomorphic reduction of structure group of $\gamma^{*} E_{G}$ to $P$.

Take any holomorphic reduction of structure group $E_{P} \subset \gamma^{*} E_{G}$ of $\gamma^{*} E_{G}$ to $P$. Let

$$
\begin{equation*}
\operatorname{ad}\left(E_{P}\right):=E_{P} \times^{P} \mathfrak{p} \longrightarrow Z \tag{4.3}
\end{equation*}
$$

be the adjoint bundle of $E_{P}$; the inclusion map of $\mathfrak{p}$ in $\mathfrak{g}$ produces a map

$$
\operatorname{ad}\left(E_{P}\right) \longrightarrow \operatorname{ad}\left(\gamma^{*} E_{G}\right)=\gamma^{*} \operatorname{ad}\left(E_{G}\right),
$$

so $\operatorname{ad}\left(E_{P}\right)$ is a subbundle of $\gamma^{*} \operatorname{ad}\left(E_{G}\right)$.
For a holomorphic vector bundle $W$ on $Z$, define

$$
\operatorname{degree}(W):=\int_{Z} c_{1}(W) \wedge \omega^{d-1} \in \mathbb{R}
$$

where $d=\operatorname{dim}_{\mathbb{C}} Z$; see [K0, p. 168, (7.1)].
Theorem 4.1. Let $E_{G}$ be a holomorphic principal $G$-bundle on a compact connected Fujiki manifold $M$. Then the following two statements are equivalent:
(1) The holomorphic vector bundle $\operatorname{ad}\left(E_{G}\right)$ in (3.1) is numerically flat.
(2) For every triple $(Z, \omega, \gamma)$ as in (4.1) and (4.2), and every holomorphic reduction of structure group $E_{P} \subset \gamma^{*} E_{G}$ of $\gamma^{*} E_{G}$ to $P$, the inequality

$$
\text { degree }\left(\operatorname{ad}\left(E_{P}\right)\right) \leq 0
$$

holds, where $\operatorname{ad}\left(E_{P}\right)$ is the adjoint bundle in (4.3).
Proof. First assume that $\operatorname{ad}\left(E_{G}\right)$ is numerically flat. Take any $(Z, \omega, \gamma)$ as in (4.1) and (4.2). Since $\operatorname{ad}\left(E_{G}\right)$ is numerically flat, it follows that $\gamma^{*} \operatorname{ad}\left(E_{G}\right)=\operatorname{ad}\left(\gamma^{*} E_{G}\right)$ is also numerically flat DPS, p. 305, Proposition 1.10].

Let

$$
\begin{equation*}
\phi:\left(\gamma^{*} E_{G}\right) / P \longrightarrow Z \tag{4.4}
\end{equation*}
$$

be the natural projection. The holomorphic principal $P$-bundle

$$
\gamma^{*} E_{G} \longrightarrow\left(\gamma^{*} E_{G}\right) / P=\gamma^{*}\left(E_{G} / P\right)
$$

over $\left(\gamma^{*} E_{G}\right) / P$ will be denoted by $\mathcal{F}_{P}$; it is a holomorphic reduction of structure group of the principal $G$-bundle $\phi^{*} \gamma^{*} E_{G}$ to $P \subset G$. Since $\gamma^{*} \operatorname{ad}\left(E_{G}\right)$ is numerically flat, from Theorem 3.1 we know that the line bundle $\bigwedge^{\text {top }} \operatorname{ad}\left(\mathcal{F}_{P}\right)^{*}$ is nef.

Let $E_{P} \subset \gamma^{*} E_{G}$ be a holomorphic reduction of structure group of the principal $G$ bundle $\gamma^{*} E_{G}$ to the subgroup $P$. It corresponds to a section

$$
\beta: Z \longrightarrow\left(\gamma^{*} E_{G}\right) / P
$$

of the projection $\phi$ in (4.4); the holomorphic principal $P$-bundle $E_{P}$ is the pullback $\beta^{*} \mathcal{F}_{P}$, where $\mathcal{F}_{P}$ is the principal $P$-bundle defined above. Therefore, we have

$$
\bigwedge^{\mathrm{top}} \operatorname{ad}\left(E_{P}\right)=\beta^{*} \bigwedge^{\mathrm{top}} \operatorname{ad}\left(\mathcal{F}_{P}\right)
$$

This, and the above observation that $\Lambda^{\text {top }} \operatorname{ad}\left(\mathcal{F}_{P}\right)^{*}$ is nef, together imply that $\Lambda^{\text {top }} \operatorname{ad}\left(E_{P}\right)^{*}$ is nef. This immediately implies that

$$
\text { degree }\left(\operatorname{ad}\left(E_{P}\right)\right) \leq 0
$$

To prove that converse, assume that

$$
\operatorname{degree}\left(\operatorname{ad}\left(E_{P}\right)\right) \leq 0
$$

for every triple $(Z, \omega, \gamma)$ as in (4.1) and (4.2), and every holomorphic reduction of structure group $E_{P} \subset \gamma^{*} E_{G}$ of $\gamma^{*} E_{G}$ to $P$. We will prove that $\operatorname{ad}\left(E_{G}\right)$ is numerically flat.
Take a surjective bimeromorphic map

$$
\begin{equation*}
f: Y \longrightarrow M, \tag{4.5}
\end{equation*}
$$

where $Y$ is a compact connected Kähler manifold. From Proposition 2.1 we know that $\operatorname{ad}\left(E_{G}\right)$ is numerically flat if $f^{*} \operatorname{ad}\left(E_{G}\right)=\operatorname{ad}\left(f^{*} E_{G}\right)$ is numerically flat.

Let

$$
\begin{equation*}
\psi:\left(f^{*} E_{G}\right) / P=f^{*}\left(E_{G} / P\right) \longrightarrow Y \tag{4.6}
\end{equation*}
$$

be the natural projection. The holomorphic principal $P$-bundle

$$
\begin{equation*}
f^{*} E_{G} \longrightarrow\left(f^{*} E_{G}\right) / P=f^{*}\left(E_{G} / P\right) \tag{4.7}
\end{equation*}
$$

will be denoted by $\widetilde{\mathcal{F}}_{P}$. Note that $\widetilde{\mathcal{F}}_{P}$ is a holomorphic reduction of structure group of the principal $G$-bundle $(f \circ \psi)^{*} E_{G}=\psi^{*} f^{*} E_{G}$ to $P \subset G$. To show that $f^{*} \operatorname{ad}\left(E_{G}\right)$ is numerically flat, first note that Theorem 3.1 says that it suffices to prove that $\Lambda^{\text {top }} \operatorname{ad}\left(\widetilde{\mathcal{F}}_{P}\right)^{*}$ is nef. Now, to prove that $\Lambda^{\text {top }} \operatorname{ad}\left(\widetilde{\mathcal{F}}_{P}\right)^{*}$ is nef, we will use the following criterion of Demailly and Paun, DP, for nefness.
A holomorphic line bundle $L$ on a compact Kähler manifold $N$ is nef if and only if for every Kähler form $\omega_{N}$ on $N$, and every irreducible closed connected analytic subspace $\mathcal{S} \subset N$, the inequality

$$
\begin{equation*}
\int_{\mathcal{S}} c_{1}(L) \wedge \omega_{N}^{s-1} \geq 0 \tag{4.8}
\end{equation*}
$$

holds, where $s=\operatorname{dim}_{\mathbb{C}} \mathcal{S}$ [DP, p. 1248, Corollary 0.4].
Set

$$
(N, L)=\left(\left(f^{*} E_{G}\right) / P, \bigwedge_{\text {top }}^{\text {tod }}\left(\widetilde{\mathcal{F}}_{P}\right)^{*}\right) .
$$

Take any $\left(\omega_{N}, \mathcal{S}\right)$ as above, so

$$
\mathcal{S} \subset\left(f^{*} E_{G}\right) / P .
$$

Set $Z$ in the statement of the theorem to be $\mathcal{S}$, and set $\gamma$ in the statement of the theorem to be the composition of maps

$$
\mathcal{S} \hookrightarrow\left(f^{*} E_{G}\right) / P \xrightarrow{\psi} Y \xrightarrow{f} M,
$$

where $\psi$ and $f$ are the maps in (4.6) and (4.5) respectively. Set the reduction $E_{P} \subset \gamma^{*} E_{G}$ to be the restriction of the reduction

$$
\widetilde{\mathcal{F}}_{P} \subset(f \circ \psi)^{*} E_{G}
$$

(see (4.7)) to $\mathcal{S} \subset\left(f^{*} E_{G}\right) / P$. So we have

$$
E_{P}=\left.\left(\widetilde{\mathcal{F}}_{P}\right)\right|_{\mathcal{S}}
$$

This implies that

$$
\bigwedge^{\mathrm{top}} \operatorname{ad}\left(E_{P}\right)=\bigwedge^{\mathrm{top}} \operatorname{ad}\left(\widetilde{\mathcal{F}}_{P}\right)
$$

Therefore, the given condition that

$$
\operatorname{degree}\left(\operatorname{ad}\left(E_{P}\right)\right) \leq 0
$$

implies that the inequality in (4.8) holds. Now the above mentioned criterion of [DP] for nefness implies that $\Lambda^{\text {top }} \operatorname{ad}\left(\widetilde{\mathcal{F}}_{P}\right)^{*}$ is nef.
