# MINIMAL QUADRATIC FORMS FOR THE FUNCTION FIELD OF A CONIC IN CHARACTERISTIC 2

#### Abstract

In this note, we construct explicit examples of $F_{Q}$-minimal quadratic forms of dimension 5 and 7 , where $F_{Q}$ is the function field of a conic over a field $F$ of characteristic 2 . The construction uses the fact that any set of $n$ cyclic $p$ algebras over a field of characteristic $p$ can be described using only $n+1$ elements of the base field. It also uses a general result that provides an upper bound on the Witt index of an orthogonal sum of two regular anisotropic quadratic forms over a henselian valued field.


## 1. Introduction

Let $Q$ be a quaternion division algebra over a field $F$. Its Severi-Brauer variety is a conic, which is a codimension 1 subform of the norm form $n_{Q}$ of $Q$. We denote by $F_{Q}$ the function field of this conic. One may try to describe anisotropic quadratic forms that become either hyperbolic or isotropic over this function field $F_{Q}$. For hyperbolicity, there is a well-known answer : since $n_{Q}$ is a 2-fold Pfister form, the subform theorem [6, Cor. 23.6] asserts that an anisotropic quadratic form becomes hyperbolic over $F_{Q}$ if and only if it is a multiple of $n_{Q}$. The question is much harder for isotropy. Clearly, any quadratic form having the conic as a subform becomes isotropic over $F_{Q}$. But the converse does not hold. This was initially noticed by Wadsworth, and led to the notion of minimal form, introduced by Hoffmann: a quadratic form $\varphi$ over $F$ is called $F_{Q}$-minimal if $\varphi$ is anisotropic, $\varphi_{F_{Q}}$ is isotropic, and $\varphi$ does not contain any strict subform which becomes isotropic over $F_{Q}$. Minimal forms in characteristic different from 2 were studied in the 90 's by Hoffmann, Lewis and Van Geel, see [11, [18, [12] and 13]. In particular, they described a field and a conic for which there exist minimal forms of any odd dimension $\geq 3$, see [13, Thm. 4.6].

Large parts of this theory extend to the characteristic 2 case, as was shown by Faivre in [8. In particular, he defined an invariant, called the minimal splitting index $\bar{s}_{F_{Q}}(\varphi)$, which can be used to characterize $F_{Q}$-minimal forms. For forms of dimension 5, he gave another characterization using the Clifford algebra. Nevertheless, his thesis does not contain any explicit example of $F_{Q}$-minimal forms. In this note, we construct such examples in dimension 5 and 7 , see Proposition 4.1

[^0]and Proposition 4.6, which are the first to appear in the literature in characteristic 2.

Recall that the even Clifford algebra of a quadratic space $(V, q)$ is naturally endowed with an involution, called the canonical involution, which is of symplectic type if the base field has characteristic 2 and $V$ is odd dimensional, see [15, §8.A]. Moreover, a central simple algebra with symplectic involution $(A, \sigma)$ is called hyperbolic if $A$ contains an isotropic ideal of maximal dimension, that is a right ideal $I \subset A$ such that $\sigma(I) I=\{0\}$ and $\operatorname{dim}_{F}(I)=\frac{1}{2} \operatorname{dim}_{F}(A)$ [15, (6.8)]. Starting from an $F_{Q}$-minimal quadratic form of dimension 5 , the even Clifford algebra functor produces an example of a degree 4 algebra with symplectic involution which is non hyperbolic, becomes hyperbolic over $F_{Q}$, and does not contain any subalgebra with involution isomorphic to $\left(Q,^{-}\right)$, where ${ }^{-}$denotes the canonical involution. This was already observed in [20] in characteristic different from 2 and in [4] in characteristic 2. So our paper also provides explicit examples of such algebras with involution in characteristic 2.

It is true in general that the even Clifford algebra of a quadratic form decomposes as a tensor product of quaternion algebras with involution. Over a field of characteristic 2 , any algebra which decomposes as a tensor product of $n$ quaternion algebras may be described in a specific way, using only $n+1$ elements of the base field. This fact, which actually holds over any field of positive characteristic for tensor product of cyclic $p$ algebras, see Theorem 2.1, has been a crucial ingredient in designing our examples of minimal forms.

The base fields in those examples are iterated Laurent series field. Over such a field, any vector space endowed with a regular quadratic form admits a $v$-value function which is a norm. To prove the $F_{Q}$-minimality of the 7 -dimensional example, we use a general result of independant interest and valid in arbitrary characteristic, which provides an upper bound for the Witt index of an orthogonal sum of two regular quadratic forms over a henselian valued field, see Proposition 3.1.

The content of the paper is as follows. In Section 2, we provide a general description of any set of $n$ cyclic $p$ algebras over a field of characteristic $p$, where $p$ is an arbitrary prime number. The bound on the Witt index of an orthogonal sum of two regular quadratic forms over a henselian valued field of arbitrary characteristic is in Section 3 Finally, the examples of $F_{Q}$-minimal forms over a base field of characteristic 2 are described in Section 4.

Notations. Throughout the paper, $F$ is a field of positive characteristic $p$, except in Section 3 where the characteristic is arbitrary; in Section 4 on minimal quadratic forms, we will assume $p=2$.

For $\alpha \in F$ and $\beta \in F^{\times}$, we let $[\alpha, \beta)_{p, F}$ be the cyclic $p$-algebra generated over $F$ by two elements $i$ and $j$ subject to the relations $i^{p}-i=\alpha, j^{p}=\beta$ and $j i j^{-1}=i-1$. It follows from the definition that $\left[\alpha+x^{p}-x, \beta y^{p}\right)_{p, F} \simeq[\alpha, \beta)_{p, F}$ for all $x \in F$ and $y \in F^{\times}$. Recall that $[\alpha, \beta)_{p, F}$ is either division or isomorphic to $M_{p}(F)$. In particular, for all $\alpha \in F$ and $\beta \in F^{\times}$, we have $[\alpha, 1)_{p, F} \simeq[0, \beta)_{p, F} \simeq[\beta, \beta)_{p, F} \simeq$ $M_{p}(F)$. In the sequel, we will use the following, which is proved in [1, Lemma 2.3(a)]:

\begin{equation*}
[\alpha, \beta)_{p, F} \otimes_{F}[\gamma, \delta)_{p, F} \simeq[\alpha+\gamma, \beta)_{p, F} \otimes\left[\gamma, \beta^{-1} \delta\right)_{p, F} \tag{1}
\end{equation*}
$$

for all $\alpha, \gamma \in F$ and $\beta, \delta \in F^{\times}$.

We denote by $\Omega_{F}^{*}$ the ring of differential forms. It contains an element $d \beta$ for all $\beta \in F$, and we let $\operatorname{dlog}(\beta)=\beta^{-1} d \beta$ for all $\beta \neq 0$. The subspace spanned by $n$-fold differentials $\Omega_{F}^{n}$ admits a well-defined Artin-Schreier map $\wp: \Omega_{F}^{n} \rightarrow \Omega_{F}^{n} / d \Omega_{F}^{n-1}$ given by

$$
\alpha \operatorname{dlog}\left(\beta_{1}\right) \wedge \cdots \wedge \operatorname{dlog}\left(\beta_{n}\right) \mapsto\left(\alpha^{p}-\alpha\right) \operatorname{dlog}\left(\beta_{1}\right) \wedge \cdots \wedge \operatorname{dlog}\left(\beta_{n}\right)
$$

The cokernel of this map is the Kato-Milne cohomology group $H_{p}^{n+1}(F)$. For $n=0$ one recovers the Artin-Schreier group $H_{p}^{1}(F)=F / \wp(F)$ which describes cyclic degree $p$ extensions of $F$. For $n=1$, there is an isomorphism to the $p$-torsion of the Brauer group $H_{p}^{2}(F) \simeq{ }_{p} \operatorname{Br}(F)$ (see [10, Section 9]) given by $\alpha \operatorname{dlog}(\beta) \mapsto[\alpha, \beta)_{p, F}$, where we use the same notation for the Brauer class of the cyclic algebra $[\alpha, \beta)_{p, F}$ as for the algebra itself. So, when viewed as an element of the Brauer group, the symbol $[\alpha, \beta)_{p, F}$ is additive in $\alpha$ and multiplicative in $\beta$, that is
$\left[\alpha_{1}+\alpha_{2}, \beta\right)_{p, F}=\left[\alpha_{1}, \beta\right)_{p, F}+\left[\alpha_{2}, \beta\right)_{p, F}$, and $\left[\alpha, \beta_{1} \beta_{2}\right)_{p, F}=\left[\alpha, \beta_{1}\right)_{p, F}+\left[\alpha, \beta_{2}\right)_{p, F}$, for all $\alpha, \alpha_{1}, \alpha_{2} \in F$ and $\beta, \beta_{1}, \beta_{2} \in F^{\times}$. Using these relations, one may also check, the following identity:

$$
\begin{equation*}
[\alpha, \beta)_{p, F} \simeq\left[\left(\beta+x^{p}\right) \alpha \beta^{-1}, \beta+x^{p}\right)_{p, F} \tag{2}
\end{equation*}
$$

for all $\alpha \in F, \beta \in F^{\times}$and $x \in F$ such that $\beta+x^{p} \neq 0$. Indeed, by definition, we have $\left(\beta+x^{p}\right) \operatorname{dlog}\left(\beta+x^{p}\right)=d\left(\beta+x^{p}\right)$. It follows that $\left(\beta+x^{p}\right) \alpha \beta^{-1} \operatorname{dlog}\left(\beta+x^{p}\right)=$ $\alpha \beta^{-1} d\left(\beta+x^{p}\right)=\alpha \beta^{-1} d \beta=\alpha \operatorname{dog}(\beta)$, as required. See also [1, Lemma 2.2(d)] for a direct argument.

Recall that when $p=2$, there is an isomorphism $H_{2}^{n+1}(F)=I_{q}^{n+1} F / I_{q}^{n+2} F$ where $I_{q}(F)$ is the fundamental ideal of the Witt group of nonsingular quadratic forms over $F$, as proved by Kato in [14]. The symbol $\alpha \operatorname{dlog}\left(\beta_{1}\right) \wedge \cdots \wedge \operatorname{dlog}\left(\beta_{n}\right)$ corresponds under this isomorphism to the $n$-fold Pfister form $\left\langle\left\langle\beta_{n}, \ldots, \beta_{1}, \alpha \rrbracket\right.\right.$, which is, by definition, the tensor product of the $(n-1)$-fold bilinear Pfister form $\left\langle\left\langle\beta_{n}, \ldots, \beta_{1}\right\rangle\right\rangle$ with the rank 2 non singular quadratic form $[1, \alpha]$. If $n=2$, we get the quadratic form $\left\langle\left\langle\beta, \alpha \rrbracket=[1, \alpha] \perp \beta[1, \alpha]\right.\right.$ which is the norm form $n_{Q}$ of the quaternion algebra $Q=[\alpha, \beta)_{2, F}$.

Let $(A, \sigma)$ be a central simple algebra, endowed with a symplectic involution. A right ideal $I \subset A$ is called isotropic (with respect to the involution $\sigma$ ) if $\sigma(x) y=0$ for all $x, y \in I$. An isotropic ideal has dimension at most $\frac{1}{2} \operatorname{dim}_{F}(A)$. The involution $\sigma$ is called isotropic (respectively hyperbolic) if there exists a non trivial isotropic ideal $I \subset A$ (respectively an isotropic ideal of dimension $\frac{1}{2} \operatorname{dim}_{F}(A)$ ). Over a field of characteristic 2 , this definitions apply in particular to the Clifford algebra and the even Clifford algebra of an odd dimensional quadratic space, since its canonical involution is symplectic, see [15, 6.A, 6.B, 8.A].

## 2. On sets and tensor products of cyclic p-ALGEbRAS OVER a field of CHARACTERISTIC $p$

The main result in this section is the following :
Theorem 2.1. Let $F$ be a field of positive characteristic $p$. Any $n$ cyclic p-algebras can be written as

$$
\left[a_{0}, a_{1}\right)_{p, F},\left[a_{1}, a_{2}\right)_{p, F}, \ldots,\left[a_{n-1}, a_{n}\right)_{p, F}
$$

for some non-zero elements $a_{i} \in F^{\times}$.

The proof uses the following lemma:
Lemma 2.2. Let $A_{1}=[\alpha, \beta)_{p, F}$ and $A_{2}=[\gamma, \delta)_{p, F}$ be two cyclic division $p$ algebras. Then, there exist $a, b \in F^{\times}$such that $A_{1}=[a, b)_{p, F}$ and $A_{2}=[b, \delta)_{p, F}$.
Proof of Lemma 2.2. Let $x=\gamma-\beta$, so that $\gamma+x^{p}-x=\beta+x^{p}$ and denote by $b$ this element. Since $A_{1}$ is division, $\beta \notin F^{\times p}$, so that $b=\beta+x^{p} \neq 0$; hence, by (2), the algebra $A_{1}$ is given by

$$
A_{1}=\left[\left(\beta+x^{p}\right) \alpha \beta^{-1}, \beta+x^{p}\right)_{p, F}=[a, b)_{p, F}
$$

where $a=\left(\beta+x^{p}\right) \alpha \beta^{-1}$. Again since $A_{1}$ is division we have $a \in F^{\times}$; moreover, we have

$$
A_{2}=\left[\gamma+x^{p}-x, \delta\right)_{p, F}=[b, \delta)_{p, F}
$$

and this finishes the proof.
Proof of Theorem 2.1. We first prove the result when all algebras are division, by induction on their number $n$. It clearly holds if $n=1$. Given $n$ cyclic $p$-algebras $A_{1}, \ldots, A_{n}$, the induction hypothesis provides $a_{1}^{\prime}, a_{2}, \ldots, a_{n} \in F^{\times}$such that $A_{2}=$ $\left[a_{1}^{\prime}, a_{2}\right)_{p, F}$ and $A_{i}=\left[a_{i-1}, a_{i}\right)_{p, F}$ for $i \in \llbracket 3 ; n \rrbracket$. Lemma 2.2 applied to $A_{1}$ and $A_{2}$ now provides $a_{0}$ and $a_{1} \in F^{\times}$such that $A_{1}=\left[a_{0}, a_{1}\right)_{p, F}$ and $A_{2}=\left[a_{1}, a_{2}\right)_{p, F}$, and this concludes the proof in this case.
If the algebras are not all division, one may first write the division algebras of the considered set as $\left[a_{0}, a_{1}\right)_{p, F}, \ldots,\left[a_{k-1}, a_{k}\right)_{p, F}$. Since $\left[a_{k}, 1\right)_{p, F}=[1,1)_{p, F}=M_{p}(F)$, the result holds with $a_{i}=1$ for $i \in \llbracket k+1 ; n \rrbracket$.

As an immediate corollary, we get
Corollary 2.3. Let $A$ be a tensor product of $n$ cyclic p-algebras. There exists $a_{0}, \ldots, a_{n} \in F^{\times}$such that

$$
A=\left[a_{0}, a_{1}\right)_{p, F} \otimes\left[a_{1}, a_{2}\right)_{p, F} \otimes \cdots \otimes\left[a_{n-1}, a_{n}\right)_{p, F}
$$

Remark 2.4. Theorem 2.1 provides an easy proof of the fact that the essential dimension of decomposable algebras of degree $p^{n}$ and exponent $p$ is at most $n+1$. This follows from the essential dimension of the group $(\mathbb{Z} / p \mathbb{Z})^{n}$ over a field of characteristic $p$, which is 1 (see [17]), but the argument there is more elaborate. See [19] for a detailed discussion on the essential dimension of such algebras.
3. Witt index of an orthogonal sum of two anisotropic quadratic FORMS OVER A HENSELIAN VALUED FIELD

The main result in this section provides an upper bound for the Witt index of an orthogonal sum of two anisotropic quadratic forms over a henselian valued field, under some condition on the value function associated to one of them. We refer the reader to [22, §3.1.1] for general information on value functions and norms.

Let $F$ be a field of arbitrary characteristic, and $V$ a finite-dimensional vector space over $F$. We assume $F$ is endowed with a valuation $v: F \rightarrow \Gamma \cup\{\infty\}$, where $\Gamma$ is a totally ordered group. Replacing $\Gamma$ by its divisible hull if necessary, we may assume $\Gamma$ is divisible, and we denote the value group of $F$ by $\Gamma_{F}=v\left(F^{\times}\right) \subset \Gamma$. Recall that a $v$-value function on $V$ is a map $\alpha: V \rightarrow \Gamma \cup\{\infty\}$ such that
(1) $\alpha(x)=0$ if and only if $x=0$;
(2) $\alpha(x+y) \geq \min (\alpha(x), \alpha(y))$ for all $x, y \in V$;
(3) $\alpha(x \lambda)=\alpha(x)+v(\lambda)$ for all $x \in V$ and $\lambda \in F$.

The value set of $\alpha$, denoted by $\Gamma_{\alpha}=\{\alpha(x), x \in V, x \neq 0\} \subset \Gamma$ need not be a subgroup of $\Gamma$. Nevertheless, condition (3) above shows that $\Gamma_{\alpha}$ consists of a union of cosets of $\Gamma_{F}$, and we denote by $\left|\Gamma_{\alpha}: \Gamma_{F}\right|$ the number of cosets. The $v$-value function $\alpha$ is called a $v$-norm if $V$ admits a splitting base for $\alpha$, that is a base $\left(e_{i}\right)_{1 \leq i \leq n}$ such that for all $\lambda_{1}, \ldots, \lambda_{n} \in F$, we have

$$
\alpha\left(\sum_{i=1}^{n} e_{i} \lambda_{i}\right)=\min \left\{\alpha\left(e_{i}\right)+v\left(\lambda_{i}\right), 1 \leq i \leq n\right\}
$$

The value set $\Gamma_{\alpha}$ then consists of the cosets $\alpha\left(e_{i}\right)+\Gamma_{F}$ for $1 \leq i \leq n$. Hence, we have $\left|\Gamma_{\alpha}: \Gamma_{F}\right| \leq \operatorname{dim}_{F}(V)$, with equality if and only if these cosets are pairwise distinct.

Let us assume now that $V$ is endowed with an anisotropic quadratic form $\varphi$. As explained in [7, §4], see also [21], the function $\alpha: V \rightarrow \Gamma \cup\{\infty\}$ defined by $\alpha(x)=\frac{1}{2} v(\varphi(x))$ for all $x \in V$ is a $v$-value function on $V$. We call it the $v$-value function associated to $\varphi$. Our construction of examples of 7 -dimensional $F_{Q}$-minimal forms uses the following :
Proposition 3.1. Let $(V, \varphi)$ and $(W, \psi)$ be two anisotropic quadratic spaces over a henselian valued field $(F, v)$, such that the orthogonal sum $\varphi \perp \psi$ is regular. Denote by $\alpha$ and $\beta$ the $v$-value functions on $V$ and $W$ respectively associated to $\varphi$ and $\psi$. If $\alpha$ is a norm and $\left|\Gamma_{\alpha}: \Gamma_{F}\right|=\operatorname{dim}_{F}(V)$, then the Witt index of the orthogonal sum $\varphi \perp \psi$ satisfies

$$
i_{w}(\varphi \perp \psi) \leq\left|\left(\Gamma_{\alpha} \cap \Gamma_{\beta}\right): \Gamma_{F}\right|
$$

Remark 3.2. Since $\varphi$ and $\psi$ are anisotropic, both are regular. In characteristic not 2 , it follows their orthogonal sum also is regular, but this is not true in general in characteristic 2 . We need this additional assumption in the statement.

Proof. Let $Z$ be a maximal totally isotropic subspace of $(V \oplus W, \varphi \perp \psi)$. Since $\varphi \perp \psi$ is regular, the dimension of $Z$ is equal to the Witt index of this form, and we need to prove that $\operatorname{dim}_{F}(Z) \leq\left|\left(\Gamma_{\alpha} \cap \Gamma_{\beta}\right): \Gamma_{F}\right|$. Denote by $p_{1}$ and $p_{2}$ the projections of $V \oplus W$ on $V$ and $W$ respectively; since $Z$ is totally isotropic, for all $z \in Z$, we have

$$
\begin{equation*}
(\varphi \perp \psi)(z)=\varphi\left(p_{1}(z)\right)+\psi\left(p_{2}(z)\right)=0 \tag{3}
\end{equation*}
$$

On the other hand, $\varphi$ and $\psi$ are both anisotropic. Hence, the projection $p_{1}$ induces an isomorphism between $Z$ and $Z_{1}=p_{1}(Z) \subset V$. Similarly, $p_{2}$ induces an isomorphism between $Z$ and $Z_{2}=p_{2}(Z) \subset W$. Combining those isomorphisms and using (3), we get an isometry $f$ between the quadratic spaces $\left(Z_{1}, \varphi_{\mid Z_{1}}\right)$ and $\left(Z_{2},-\psi_{\mid Z_{2}}\right)$. By definition of the $v$-value functions $\alpha$ and $\beta$ associated to $\varphi$ and $\psi$ respectively, it follows that for all $z_{1} \in Z_{1}$ we have

$$
\alpha\left(z_{1}\right)=\frac{1}{2} v\left(\varphi\left(z_{1}\right)\right)=\frac{1}{2} v\left(-\psi\left(f\left(z_{1}\right)\right)\right)=\frac{1}{2} v\left(\psi\left(f\left(z_{1}\right)\right)\right)=\beta\left(f\left(z_{1}\right)\right) .
$$

Therefore, since $f$ is bijective, the $v$-value functions $\alpha$ and $\beta$ induce $v$-value functions on $Z_{1}$ and $Z_{2}$ with the same value group, which we denote by $\Gamma_{Z}$. It satisfies

$$
\Gamma_{Z}=\left\{\alpha\left(z_{1}\right), z_{1} \in Z_{1}, z_{1} \neq 0\right\}=\left\{\beta\left(z_{2}\right), z_{2} \in Z_{2}, z_{2} \neq 0\right\} \subset \Gamma_{\alpha} \cap \Gamma_{\beta}
$$ and it follows that

$$
\left|\Gamma_{Z}: \Gamma_{F}\right| \leq\left|\left(\Gamma_{\alpha} \cap \Gamma_{\beta}\right): \Gamma_{F}\right|
$$

By [22, Prop. 3.14], since $\alpha$ is a norm, its restriction to $Z_{1}$ also is a norm, hence in particular we have $\left|\Gamma_{Z}: \Gamma_{F}\right| \leq \operatorname{dim}_{F}\left(Z_{1}\right)$. We claim they actually are equal. Indeed, assume for the sake of contradiction that $\left|\Gamma_{Z}: \Gamma_{F}\right|<\operatorname{dim}_{F}\left(Z_{1}\right)$. Again by [22, Prop. 3.14], $Z_{1}$ admits a splitting complement $Y$, that is $V=Z_{1} \oplus Y$ and $\alpha(v)=\min \left(\alpha\left(z_{1}\right), \alpha(y)\right)$ for all $v=z_{1}+y \in V$ with $z_{1} \in Z_{1}$ and $y \in Y$. Therefore, we have $\Gamma_{\alpha}=\Gamma_{\alpha \mid Z_{1}} \cup \Gamma_{\alpha \mid Y}=\Gamma_{Z} \cup \Gamma_{\alpha \mid Y}$. Moreover, the restriction of $\alpha$ to $Y$ also is a norm, so that its value set satisfies $\left|\Gamma_{\alpha \mid Y}: \Gamma_{F}\right| \leq \operatorname{dim}_{F}(Y)$. So, we get

$$
\left|\Gamma_{\alpha}: \Gamma_{F}\right| \leq\left|\Gamma_{Z}: \Gamma_{F}\right|+\left|\Gamma_{\alpha \mid Y}: \Gamma_{F}\right|<\operatorname{dim}_{F}\left(Z_{1}\right)+\operatorname{dim}_{F}(Y)=\operatorname{dim}_{F}(V)
$$

which contradicts the assumption we made on $\alpha$ in the statement. So we have $\left|\Gamma_{Z}: \Gamma_{F}\right|=\operatorname{dim}_{F}\left(Z_{1}\right)=\operatorname{dim}_{F}(Z)$, and this concludes the proof.

## 4. Explicit examples of $F_{Q}$-minimal forms

From now on, we assume $p=2$, so that $F$ has characteristic 2 , and we use the notation $[\alpha, \beta)=[\alpha, \beta)_{2, F}$ for all $\alpha \in F$ and $\beta \in F^{\times}$. The purpose of this section is to construct explicit examples of $F_{Q}$-minimal forms of dimension 5 and 7 . In both cases, the results are proved using characterisations of $F_{Q}$-minimal forms in characteristic 2 which are due to Faivre [8, §5.2]. As explained below, the method is slightly different in dimension 5 and in dimension 7 .

We first prove the following:
Proposition 4.1. Assume $a, b, c$ are elements of $F$ such that $a \operatorname{dog}(b) \wedge \operatorname{dlog}(c)$ is a non trivial symbol in $H_{2}^{3}(F)$, and let $Q$ be the quaternion algebra $Q=[a, c)$. The quadratic form $\varphi_{1}=c[1, a+b] \perp b[1, a] \perp\langle 1\rangle$ is anisotropic, and becomes isotropic over $F_{Q}$. If in addition $[a, b) \otimes_{F}[b, c)$ is division over $F$, then $\varphi_{1}$ is $F_{Q}$-minimal.

Proof. Let $F, a, b, c$ and $\varphi_{1}$ be as in the statement. Since the quaternion algebras $[a+b, b)$ and $[a, b)$ are isomorphic, they have isometric norm form $\langle\langle b, a+b \rrbracket \simeq\langle\langle b, a \rrbracket$. It follows that

$$
\varphi_{1} \perp b c[1, a+b] \simeq c\langle\langle b, a \rrbracket \perp b[1, a] \perp\langle 1\rangle
$$

Therefore, one may easily check that $\varphi_{1}$ is isometric to a subform of $\langle\langle b, c, a \rrbracket$. This form has non trivial Arason invariant $a \operatorname{dlog}(b) \wedge \operatorname{dlog}(c)$, hence it is anisotropic and so is $\varphi_{1}$. Moreover $\left\langle\left\langle b, c, a \rrbracket=\langle\langle b\rangle\rangle \otimes n_{Q}\right.\right.$ is hyperbolic over the field $F_{Q}$, and it follows that the 5 -dimensional subform $\varphi_{1}$ is isotropic over $F_{Q}$. We now use [8, Prop 5.2.12] to check $\varphi_{1}$ is $F_{Q}$-minimal. The first condition has already been checked: $\varphi_{1}$ is a Pfister neighbour of $\left\langle\left\langle b, c, a \rrbracket=\langle\langle b\rangle\rangle \otimes n_{Q}\right.\right.$. Moreover, its Clifford algebra is Brauer equivalent to $[a+b, c) \otimes[a, b) \simeq[a+b, b c)$, and the tensor product with $Q$ is

$$
[a+b, b c) \otimes[a, c)=[a, b) \otimes[b, c)
$$

which is division as required. This finishes the proof.
To get an explicit example, it remains to exhibit a field over which the assumptions of the theorem are fulfilled. This can be done as follows :

Example 4.2. Let $F_{0}$ be a field of characteristic 2 and consider the field of iterated Laurent series $F=F_{0}\left(\left(c^{-1}\right)\right)\left(\left(b^{-1}\right)\right)\left(\left(a^{-1}\right)\right)$. By [2, Lem. 3.4], the biquaternion algebra $[a, b) \otimes[b, c)$ is division over $F$. Moreover, the symbol $a \operatorname{dlog} b \wedge \operatorname{dlog} c$ is non trivial in $H_{2}^{3}(F)$. Therefore, $\varphi_{1}$ and $Q$ defined as in Proposition4.1 provide an explicit example of an $F_{Q}$-minimal form.

Remark 4.3. (1) By contrast, in characteristic 0, there exists no 5-dimensional $F_{Q^{-}}$-minimal form over the field of iterated Laurent series $\mathbb{C}((x))((y))((z))$. Indeed, there is no biquaternion division algebra over this field, see [16, XIII, Rmk. 2.5], hence the conditions in [12, Prop. 4.1] are not satisfied.
(2) Since $b[1, b] \perp\langle 1\rangle \simeq[1, b] \perp\langle 1\rangle \simeq \mathbb{H}+\langle 1\rangle$, the form $\varphi_{1}$ is isometric to

$$
c[1, a+b] \perp b[1, a+b] \perp\langle 1\rangle \simeq c(\langle\langle b c, a+b \rrbracket \perp\langle c\rangle)
$$

In characteristic $p$, we may still consider the homogeneous degree $p$ form $\langle c\rangle \perp n_{T}$, where $n_{T}$ now stands for the norm form of $[a+b, b c)_{p, F}$. It is still true in this case that this form is anisotropic and becomes isotropic over the function field of the Severi-Brauer variety of $[a, c)_{p, F}$. This can be checked using 9, Thm. 6].

The even Clifford algebra of the quadratic form $\varphi_{1}$, endowed with its canonical involution, may be computed as in [5, Ex 2.1]. Applying [4, Prop. 3.6], we get the following :

Corollary 4.4. Over the field $F=F_{0}\left(\left(c^{-1}\right)\right)\left(\left(b^{-1}\right)\right)\left(\left(a^{-1}\right)\right)$, with $F_{0}$ of characteristic 2, the biquaternion algebra with symplectic involution

$$
(C, \gamma)=([a+b, c),-) \otimes\left([a, b),^{-}\right)
$$

satisfies the following : it is anisotropic, becomes hyperbolic over $F_{Q}$, and does not contain any $\gamma$-stable subalgebra isomorphic to $\left(Q,^{-}\right)$, where $Q=[a, c)$.

Remark 4.5. Alternately, using some explicit base change, and the characterization of orthogonal involutions on a split quaternion algebra given in [3, Lem 7.1], one may check that the even Clifford algebra of $\varphi_{1}$ is isomorphic to

$$
(C, \gamma)=\left([a+b, b c),^{-}\right) \otimes\left(M_{2}(F), \operatorname{ad}_{\langle\langle b\rangle\rangle}\right)
$$

The corollary then follows from [4, Thm 3.4].
The previous example of a 5 -dimensional quadratic form extends to dimension 7 as follows :

Proposition 4.6. Consider the quaternion algebra $Q=[a, d)$ over the field of iterated Laurent series $F=F_{0}\left(\left(d^{-1}\right)\right)\left(\left(c^{-1}\right)\right)\left(\left(b^{-1}\right)\right)\left(\left(a^{-1}\right)\right)$. The quadratic form

$$
\varphi_{2}=d[1, a+c] \perp c[1, a+b] \perp b c d[1, a] \perp\langle 1\rangle
$$

over $F$ is $F_{Q}$-minimal.
Proof. The first part of the argument follows the same line as in dimension 5. Using the following isometries

$$
d[1, a+c] \perp c d[1, a+c] \simeq d\langle\langle c, a+c \rrbracket \simeq d\langle\langle c, a \rrbracket \simeq d[1, a] \perp c d[1, a],
$$

and similarly

$$
c[1, a+b] \perp b c[1, a+b] \simeq c[1, a] \perp b c[1, a]
$$

one may check that $\varphi_{2}$ is a subform of $\langle 1, c, b c\rangle \otimes\left\langle\left\langle d, a \rrbracket=\langle 1, c, b c\rangle \otimes n_{Q}\right.\right.$, which in turn is a subform of $\langle\langle b, c\rangle\rangle \otimes n_{Q}=\langle\langle b, c, d, a \rrbracket$. Since $a \operatorname{dlog} b \wedge \operatorname{dlog} c \wedge \operatorname{dlog} d$ is a non-trivial symbol in $H_{2}^{4}(F)$, this form is anisotropic, and so is $\varphi_{2}$. Moreover, over the function field $F_{Q}$, the forms $n_{Q}$ and $\langle 1, c, b c\rangle \otimes n_{Q}$ are hyperbolic, hence $\varphi_{2}$ is isotropic.

Denote by $\chi$ the quadratic form $c d[1, a+c] \perp b c[1, a+b]$. Since $[1, a] \perp\langle 1\rangle \simeq$ $\mathbb{H} \perp\langle 1\rangle$, the computation above actually shows that $\varphi_{2} \perp \chi$ is Witt equivalent to
$\langle 1, c, b c\rangle \otimes n_{Q} \perp\langle 1\rangle$. In the language of [8, Def 5.2.3], this shows that the invariant $\bar{s}_{F_{Q}}\left(\varphi_{2}\right)$ is at most 3. In view of [8, Prop 5.2.7], to prove $\varphi_{2}$ is $F_{Q}$-minimal, it is enough to prove that $\bar{s}_{F_{Q}}\left(\varphi_{2}\right)=3$, that is, there is no 4-dimensional regular quadratic form $\chi$ over $F$ such that $\varphi_{2} \perp \chi$ is Witt equivalent to $\tau \otimes n_{Q} \perp\langle 1\rangle$ with $\tau \otimes n_{Q}$ anisotropic, and $\tau$ of dimension 1 or 2 .

Let us assume, for the sake of contradiction that such forms exist. Using again $[1, \lambda] \perp\langle 1\rangle \simeq \mathbb{H} \perp\langle 1\rangle$ for all $\lambda \in F$, we get that

$$
\tilde{\varphi}_{2} \perp \tilde{\chi} \perp\langle 1\rangle \sim \tau \otimes n_{Q} \perp\langle 1\rangle
$$

where

$$
\tilde{\varphi}_{2}=d[1, a+c] \perp c[1, a+b] \perp b c d[1, a]+[1, a+b+c]
$$

and $\tilde{\chi}$ is the Albert form $\chi \perp[1, \delta]$, where $\delta$ is the discriminant of $\chi$. By [6, Prop 13.6], it follows that

$$
\tilde{\varphi}_{2} \perp \tilde{\chi} \sim \tau \otimes n_{Q}, \text { with } \tau \text { of dimension } 1 \text { or } 2 .
$$

We may now use Clifford algebras to prove $\tau$ has dimension 1. Indeed, since both forms have trivial discriminant, by additivity of the Clifford invariant [6, Lem. 14.2], the Witt equivalence above implies that $\mathcal{C}\left(\tilde{\varphi}_{2}\right) \otimes \mathcal{C}(\tilde{\chi})$ is split if $\tau$ has dimension 2 and Brauer equivalent to $Q$ if $\tau$ has dimension 1. The Clifford algebra of $\tilde{\varphi}_{2}$ may be computed as in [5, Appendix], and we get

$$
\mathcal{C}\left(\tilde{\varphi}_{2}\right) \simeq[a+c, d) \otimes[a+b, c) \otimes[a, b c d) \simeq[a, b) \otimes[b, c) \otimes[c, d)
$$

By [2, Lem. 3.4], it is a division algebra. On the other hand, $\tilde{\chi}$ is an Albert form, so $\mathcal{C}(\tilde{\chi})$ is a biquaternion algebra. Hence the tensor product is not split, and it follows that $\tau$ has dimension 1. Moreover, the Clifford algebra of $\tilde{\chi}$ is Brauer-equivalent to $\mathcal{C}\left(\tilde{\varphi}_{2}\right) \otimes Q$ which is

$$
[a+c, d) \otimes[a+b, c) \otimes[a, b c) \sim[a+c, c d) \otimes[a+b, b c)
$$

Hence, we get $\tilde{\chi} \simeq \mu(c d[1, a+c]+b c[1, a+b]+[1, b+c])$ for some $\mu \in F^{\times}$.
To finish the proof, we use Proposition 3.1. Denote by $v$ the $\left(d^{-1}, c^{-1}, b^{-1}, a^{-1}\right)$ adic valuation of $F$. Its value group is $\Gamma_{F}=\mathbb{Z}^{4} \subset \Gamma=\mathbb{Q}^{4}$. By [22, Prop 3.8 and Ex 3.11 (ii)], every $v$-value function on a finite dimensional $F$-vector space is a norm. In particular, the $v$-value functions $\alpha$ and $\beta$ respectively associated to the quadratic forms $\tilde{\varphi}_{2}$ and $\tilde{\chi}$ are norms. Hence, the value set of $\alpha$ is the union of the cosets of values of vectors of a splitting base of $V$. Specifically, one may check that the base of $V$ corresponding to the following presentation of the quadratic form,

$$
\tilde{\varphi}_{2} \simeq d[1, a+c] \perp c[1, a+b] \perp b c d[1, a]+[1, a+b+c],
$$

is a splitting base. It follows that the value set $\Gamma_{\alpha}$ of the norm $\alpha$ consists of the cosets of the following elements of $\Gamma$ :

$$
\begin{gathered}
\left\{\alpha_{1} ; \alpha_{1}+\alpha^{\prime} ; \alpha_{2} ; \alpha_{2}+\alpha^{\prime} ; \alpha_{3} ; \alpha_{3}+\alpha^{\prime} ; \alpha_{4} ; \alpha_{4}+\alpha^{\prime}\right\} \\
\text { where } \alpha_{1}=\left(\frac{1}{2}, 0,0,0\right), \alpha_{2}=\left(0, \frac{1}{2}, 0,0\right), \alpha_{3}=\left(\frac{1}{2}, \frac{1}{2}, \frac{1}{2}, 0\right), \alpha_{4}=(0,0,0,0), \\
\text { and } \alpha^{\prime}=\left(0,0,0, \frac{1}{2}\right)
\end{gathered}
$$

Any two of those clearly give rise to distinct cosets, so that $\left|\Gamma_{\alpha}: \Gamma_{F}\right|=8$, which is the dimension of the underlying vector space. Hence the assumptions in Proposition 3.1 are satisfied and we get that the Witt index of $\tilde{\varphi}_{2} \perp \tilde{\chi}$ is at most $\left|\left(\Gamma_{\alpha} \cap \Gamma_{\beta}\right): \Gamma_{F}\right|$, where $\Gamma_{\beta}$ denotes the value set of the norm $\beta$. On the other
hand, since $\tilde{\varphi}_{2} \perp \tilde{\chi} \sim \tau \otimes n_{Q}$ with $\tau$ of dimension 1 , this orthogonal sum has Witt index 5 , so that

$$
\left|\left(\Gamma_{\alpha} \cap \Gamma_{\beta}\right): \Gamma_{F}\right| \geq 5
$$

Besides, we have

$$
\tilde{\chi} \simeq \mu(c d[1, a+c]+b c[1, a+b]+[1, b+c])
$$

Hence, the value set $\Gamma_{\beta}$ consists of the cosets of the elements

$$
\left\{\beta_{5}+\beta^{\prime \prime} ; \beta_{5}+\beta^{\prime \prime}+\alpha^{\prime} ; \beta_{6}+\beta^{\prime \prime} ; \beta_{6}+\beta^{\prime \prime}+\alpha^{\prime}, \beta^{\prime \prime}, \beta_{7}+\beta^{\prime \prime}\right\}
$$

where $\beta_{5}=\left(\frac{1}{2}, \frac{1}{2}, 0,0\right), \beta_{6}=\left(0, \frac{1}{2}, \frac{1}{2}, 0\right), \beta_{7}=\left(0,0, \frac{1}{2}, 0\right)$ and $\beta^{\prime \prime}=\frac{1}{2} v(\mu)$,
and $\alpha^{\prime}$ is as defined above.
In order to get a contradiction, we use the following :
Lemma 4.7. The element $\frac{1}{2} v(\mu)+\Gamma_{F}$ is the coset of one of the following :

$$
\left\{\alpha_{4}, \alpha_{4}+\alpha^{\prime}, \alpha_{2}, \alpha_{2}+\alpha^{\prime}\right\}
$$

It follows that $\beta^{\prime \prime}$ in the description of $\Gamma_{2}$ may only take one of those four values, and in each case, one may check that $\Gamma_{\alpha} \cap \Gamma_{\beta}$ consists of at most four distinct cosets, which contradicts the inequality above.

Hence, to complete the argument, it only remains to prove Lemma 4.7. Consider the quadratic extension $F^{\prime}=F[t] /\left(t^{2}+t+a\right)$. There is an isomorphism

$$
F^{\prime} \simeq F_{0}\left(\left(d^{-1}\right)\right)\left(\left(c^{-1}\right)\right)\left(\left(b^{-1}\right)\right)\left(\left(z^{-1}\right)\right), \text { where } z \in F^{\prime} \text { satisfies } z^{2}+z=a
$$

Over $F^{\prime}, n_{Q}$ is hyperbolic, so $\tilde{\varphi}_{2}$ and $\tilde{\chi}$ are Witt equivalent. Computing the Witt classes of both forms over this field, we get

$$
d[1, c] \perp c[1, b] \perp[1, b+c] \sim \mu(d[1, c] \perp c[1, b] \perp[1, b+c])
$$

Hence, $\mu$ is a similarity factor of the Albert form $d[1, c] \perp c[1, b] \perp[1, b+c]$ over the field $F^{\prime}$. By [15, (16.6)], it follows $\mu$ belongs to $F^{\prime \times 2} \operatorname{Nrd}_{B} B^{\times}$, where $B$ is the biquaternion algebra $([b, c) \otimes[c, d))_{F^{\prime}}$. Since $F$ is henselian, the value $v$ extends uniquely to the field $F^{\prime}$ and to the division algebra $B$, with value groups respectively denoted by $\Gamma_{F^{\prime}}$ and $\Gamma_{B}$. Moreover, we have $v_{B}(x)=\frac{1}{4} v^{\prime}\left(\operatorname{Nrd}_{B}(x)\right)$ for all $x$ in $B$. Therefore, $\frac{1}{2} v(\mu)$ belongs to $\Gamma_{F^{\prime}}+2 \Gamma_{B}$. Clearly, we have

$$
\Gamma_{F^{\prime}}=\mathbb{Z}^{3} \times \frac{1}{2} \mathbb{Z} \subset \Gamma
$$

To compute the value group of $\Gamma_{B}$, we proceed as follows. Consider a generating pair $(i, j)$ of $[b, c)_{F^{\prime}}$ and a generating pair $(k, \ell)$ of $[c, d)_{F^{\prime}}$ with $i^{2}+i=b, j^{2}=c$, $i j=j(i+1)$, and similarly $k^{2}+k=c, \ell^{2}=d$ and $k \ell=\ell(k+1)$. Using those relations, one may easily check that $v_{B}(i)=\left(0,0,-\frac{1}{2}, 0\right), v_{B}(j)=\left(0,-\frac{1}{2}, 0,0\right)=v_{B}(k)$ and $v_{B}(\ell)=\left(-\frac{1}{2}, 0,0,0\right)$. Moreover, since $j$ and $k$ commute in $B$, we have $(j+k)^{2}=k$, hence $v_{B}(j+k)=\left(0,-\frac{1}{4}, 0,0\right)$. Since $B$ has degree 4 , it follows that $B$ is unramified and

$$
\Gamma_{B} \simeq \frac{1}{2} \mathbb{Z} \times \frac{1}{4} \mathbb{Z} \times \frac{1}{2} \mathbb{Z} \times \mathbb{Z} \subset \Gamma
$$

The assertion on $v(\mu)$ now follows by a direct computation.
