# Pick's Theorem in Two-Dimensional Subspace of $\mathbb{R}^{3}$

#### Abstract

In this note, we given a version of Pick's theorem for the simple lattice polygon in two-dimensional subspace of $\mathbb{R}^{3}$.

## 1. Introduction

In the Euclidean plane $\mathbb{R}^{2}$, a lattice point is one whose coordinates are both integers. A lattice polygon is a polygon with all vertices on integer coordinates. The area $A(P)$ of a simple lattice polygon $P$ can be given by the celebrated Pick's theorem[5]

$$
A(P)=I(P)+\frac{1}{2} B(P)-1,
$$

where $B(P)$ is the number of lattice points on the boundary of $P$ and $I(P)$ is the number of lattice points in the interior of $P$.

Pick's formula can be used to compute the area of a lattice polygon conveniently.
For example, on Figure 1, $I(P)=60, B(P)=15$. Then, the area of the polygon is $A(P)=60+15-1=74$.

There are many papers concerning Pick's theorem and it's generalizations[1,2,3,4], which mostly be discussed in two dimension.

Unfortunately, Pick theorem is failed in three dimensions. In 1957, John Reeve found a class of tetrahedra, named as Reeve tetrahedra later, whose vertices are

$$
(0,0,0)^{T},(1,0,0)^{T},(0,1,0)^{T},(1,1, r)^{T}
$$

where $r$ is a positive integer.
All Reeve tetrahedra contain the same number of lattice points, but their volumes are different.

In this note, we discussed Pick's theorem in two-dimensional subspace of $\mathbb{R}^{3}$. For any $(a, b, c)^{T} \in \mathbb{Z}^{3}$ with $(a, b, c)=1$, i.e. the greatest common factor of $a, b, c$ is one, denote by $K, a x+b y+c z=0$, the two-dimensional subspace of $\mathbb{R}^{3}$. Then we established the following theorem.

Theorem. If $P$ is simple lattice polygon in the $K$, then the area of $P$ is

$$
k\left(I(P)+\frac{1}{2} B(P)-1\right)
$$

where $B(P)$ is the number of lattice points on the boundary of $P$ in $\mathbb{Z}^{3}, I(P)$ is the number of lattice points in the interior of $P$ in $\mathbb{Z}^{3}$ and $k$ is the constant $\left(a^{3}+a b^{2}\right) \sqrt{a^{2}+b^{2}+c^{2}}$.
Remark. Although the simple lattice polygon $P$ is in the two-dimensional subspace $K$, the lattice points in $P$ belong to $\mathbb{Z}^{3}$.

Let $(a, b, c)^{T}=(1,0,0)^{T}$ in the Theorem, then we can get Pick's theorem in some coordinate plane of $\mathbb{R}^{3}$.
Corollary. If $P$ is simple lattice polygon in the $K$, whose normal vector is $(1,0,0)^{T}$, then the area of $P$ is

$$
I(P)+\frac{1}{2} B(P)-1
$$

## 2. Proof of Main Result

For any $(a, b, c)^{T} \in \mathbb{Z}^{3}$ with $(a, b, c)=1$, there is two-dimensional subspace of $\mathbb{R}^{3}$

$$
\begin{equation*}
a x+b y+c z=0, \tag{1}
\end{equation*}
$$

whose normal vector is just $(a, b, c)^{T}$. We denote this two-dimensional subspace by $K$.
By the theory of linear equations system, $(-b, a, 0)^{T}$ and $(-c, 0, a)^{T}$ are two linearly independent solutions of (1). We denote $(-b, a, 0)^{T}$ by $\alpha$ and $(-c, 0, a)^{T}$ by $\beta$. Obviously, $\alpha$ and $\beta$ are also the basis of $K$.
Lemma 1. For any $(a, b, c)^{T} \in \mathbb{Z}^{3}$ with $(a, b, c)=1$, there exists the lattice basis with the minimal area in the two-dimensional subspace $K$.
Proof. The area of parallelogram generated by $\alpha$ and $\beta$ is

$$
\frac{1}{\sqrt{a^{2}+b^{2}+c^{2}}}\left|\begin{array}{ccc}
a & -b & -c \\
b & a & 0 \\
c & 0 & a
\end{array}\right|=\frac{a^{3}+a b^{2}+a c^{2}}{\sqrt{a^{2}+b^{2}+c^{2}}}=a \sqrt{a^{2}+b^{2}+c^{2}}
$$

Denote $(a, b, c)^{T}$ by $n$. For any lattice basis in $K, k_{1} \alpha+k_{2} \beta$ and $l_{1} \alpha+l_{2} \beta$, where $k_{i}, l_{i} \in \mathbb{Z}(i=1,2)$ and $\left|\begin{array}{ll}k_{1} & l_{1} \\ k_{2} & l_{2}\end{array}\right|=0$. The area of parallelogram generated by $k_{1} \alpha+k_{2} \beta$ and $l_{1} \alpha+l_{2} \beta$ is
$\frac{1}{\sqrt{a^{2}+b^{2}+c^{2}}}\left|n \quad \vdots \quad k_{1} \alpha+k_{2} \beta \quad \vdots \quad l_{1} \alpha+l_{2} \beta\right|=\frac{1}{\sqrt{a^{2}+b^{2}+c^{2}}}\left|(n, \alpha, \beta) \times\left(\begin{array}{ccc}1 & 0 & 0 \\ 0 & k_{1} & l_{1} \\ 0 & k_{2} & l_{2}\end{array}\right)\right|$, where $\left|n \vdots k_{1} \alpha+k_{2} \beta \quad \vdots \quad l_{1} \alpha+l_{2} \beta\right|$ denote the determinant of $n, k_{1} \alpha+k_{2} \beta$ and $l_{1} \alpha+l_{2} \beta$.

Thus the lattice basis $k_{1} \alpha+k_{2} \beta$ and $l_{1} \alpha+l_{2} \beta$ have the minimal area if and only if $\left|\begin{array}{ll}k_{1} & l_{1} \\ k_{2} & l_{2}\end{array}\right|=1$.

Let $k_{1}=1, k_{2}=0, l_{1}=0, l_{2}=1, \alpha, \beta$ are the lattice basis with the minimal area in the two-dimensional subspace $K$.

Lemma 2. For any $(a, b, c)^{T} \in \mathbb{Z}^{3}$ with $(a, b, c)=1$, there exists the orthogonal lattice basis in the two-dimensional subspace $K$.

Proof. By Lemma 1, $\alpha, \beta$ are the lattice basis with the minimal area in the twodimensional subspace $K$. By Schmidt orthogonalization, let

$$
\begin{aligned}
\gamma_{1} & =\alpha=(-b, a, 0)^{T} \\
\gamma_{2} & =\beta-\frac{\left(\beta, \gamma_{1}\right)}{\left(\gamma_{1}, \gamma_{1}\right)} \\
& =(-c, 0, a)^{T}-\frac{b c}{a^{2}+b^{2}} \gamma_{1} \\
& =(-c, 0, a)^{T}-\left(\frac{-b^{2} c}{a^{2}+b^{2}}, \frac{a b c}{a^{2}+b^{2}}, 0\right)^{T} \\
& =\left(\frac{-a^{2} c}{a^{2}+b^{2}}, \frac{-a b c}{a^{2}+b^{2}}, \frac{a^{3}+a b^{2}}{a^{2}+b^{2}}\right)^{T},
\end{aligned}
$$

where $\left(\beta, \gamma_{1}\right)$ denote the usual inner product of $\beta, \gamma_{1}$ in $\mathbb{R}^{3}$.
Thus

$$
\begin{aligned}
\eta_{1}=\gamma_{1} & =\alpha=(-b, a, 0)^{T} \\
\eta_{2}=\left(a^{2}+b^{2}\right) \gamma_{2} & =\left(-a^{2} c,-a b c, a^{3}+a b^{2}\right)^{T}
\end{aligned}
$$

are the orthogonal lattice basis in the two-dimensional subspace K.
Proof of Theorem By Lemma 2, $\eta_{1}, \eta_{2}$ are the orthogonal lattice basis in the twodimensional subspace $K$.

The area of parallelogram generated by $\eta_{1}, \eta_{2}$ is

$$
\begin{aligned}
& \frac{1}{\sqrt{a^{2}+b^{2}+c^{2}}}\left|\begin{array}{ccc}
a & -b & -a^{2} c \\
b & a & -a b c \\
c & 0 & a^{3}+a b^{2}
\end{array}\right| \\
= & \frac{a^{5}+a^{3} b^{2}+a b^{2} c^{2}+a^{3} c^{2}+a^{3} b^{2}+a b^{4}}{\sqrt{a^{2}+b^{2}+c^{2}}} \\
= & \frac{a\left(a^{4}+2 a^{2} b^{2}+b^{4}+\left(a^{2}+b^{2}\right) c^{2}\right)}{\sqrt{a^{2}+b^{2}+c^{2}}} \\
= & \frac{a\left(a^{2}+b^{2}\right)\left(a^{2}+b^{2}+c^{2}\right)}{\sqrt{a^{2}+b^{2}+c^{2}}} \\
= & \left(a^{3}+a b^{2}\right) \sqrt{a^{2}+b^{2}+c^{2}},
\end{aligned}
$$

which just is the constant $k$ in the Theorem.
