# THE GENERALIZED HOPF INVARIANT AND FOUR-FOLD TODA BRACKETS 

HIDEAKI ŌSHIMA AND KATSUMI ŌSHIMA


#### Abstract

We give two formulas for the generalized Hopf invariant and 4-fold Toda brackets which are useful in computations of homotopy groups of spheres.


## 1. Introduction

In OO4, Corollary 1.2], we have given a formula for the generalized Hopf invariant (alias James-Hopf invariant) $H$ and $n$-fold Toda brackets $\left\{\alpha_{n}, \ldots, \alpha_{1}\right\}_{\left(m_{n}, \ldots, m_{1}\right)}^{\left(\ddot{s}_{t}\right)}$ for all $n \geq 4$. In this paper we restrict our attention to some other 4 -fold Toda brackets and we modify and improve partially works of Ôguchi $\mathbf{O g}$ and Mimura [M1, M2.

We will work in TOP*, the category of pointed spaces and pointed maps, and we will use freely notations in OO1 except the order in numbering of spaces and maps. In particular $E^{n}$ denotes the $n$-fold reduced suspension, that is $E^{n} X=X \wedge S^{n}$. We will also use symbols of elements of homotopy groups of spheres in $\mathbf{T}$.

Our main results are 1.1-1.4 below.

Theorem 1.1. If a quadruple of homotopy classes $\alpha_{k} \in\left[E^{m_{k}} X_{k}, X_{k+1}\right](1 \leq k \leq 4)$ satisfies

then the 4-fold Toda bracket $\left\{E \alpha_{4}, \alpha_{3}, \alpha_{2}, \alpha_{1}\right\}_{\left(1+m_{4}, m_{3}, m_{2}, m_{1}\right)}^{(2)}$ (see §2.1 for definition) is not empty and

Here $\widetilde{\Delta}_{n_{5}}$ is a homomorphism from a subgroup of $\pi_{n_{3}+m_{3}+m_{4}+2}\left(\mathrm{~S}^{2 n_{5}+1}\right)$ to a quotient group of $\pi_{n_{3}+m_{3}+m_{4}}\left(\mathrm{~S}^{n_{5}}\right)$ (see §2.4) which relates with $\Delta$ of the $E H \Delta$-sequence of Toda, and $\left[\alpha_{4} \circ\right.$ $E^{m_{4}} \alpha_{3}$ ] is the element represented by $\alpha_{4} \circ E^{m_{4}} \alpha_{3}$.

Corollary 1.2. $H\left\{E \nu_{4}, 2 \nu_{7}, \eta_{10} \circ \sigma_{11}, \sigma_{18}\right\}_{(1,0,0,0)}^{(2)}=\bar{\sigma}_{9}$.
Theorem 1.3. Suppose that a sequence $\overrightarrow{\boldsymbol{\alpha}}=\left(\alpha_{4}, \alpha_{3}, \alpha_{2}, \alpha_{1}\right)$ of homotopy classes $\alpha_{k} \in$ $\left[X_{k}, X_{k+1}\right]$ is quasi-admissible (see §3.1 for definition), $X_{k}=S^{n_{k}}(k=1,2,5)$ with $n_{5} \geq 1$, $X_{\ell}(\ell=3,4)$ is a $C W$ complex with a vertex as the base point, and

where $\operatorname{conn}(Y)$ denotes the connectivity of the space $Y$. Then $\{\overrightarrow{\boldsymbol{\alpha}}\}^{(2)^{\prime}}$ (see §3.1 for definition) is not empty and

where $\Delta^{-1}(B)=\phi_{\mathrm{S}^{2 n_{5}}} h_{n_{5} *} \partial^{-1}(B)$ for $B \subset \pi_{n_{2}+1}\left(\mathrm{~S}^{n_{5}}\right)$. Here see §2.3 and §2.4 for notations:

Corollary 1.4. (1) $\left(\sigma_{12}, \nu_{19}, 2 \nu_{22}, \nu_{25}\right)$ is not admissible (see §2.1 for definition) but quasi-admissible.
(2) $H\left\{\sigma_{12}, \nu_{19}, 2 \nu_{22}, \nu_{25}\right\}^{(2)^{\prime}}=\nu_{25}^{2}$.
(3) If $\lambda_{0} \in\left\{\sigma_{12}, \nu_{19}, 2 \nu_{22}, \nu_{25}\right\}^{(2)^{\prime}}$, then $2\left(\lambda_{0} \circ \nu_{31}\right) \equiv \sigma_{13} \circ \kappa_{20} \bmod \sigma_{13}^{3}$ and the order of $\lambda_{0} \circ \nu_{31}$ is four.

A similar formula to Theorem 1.1 was given by Oguchi $\mathbf{O g}$ (7.18)] for his compositions $\left\{\alpha_{4}, E^{n} \alpha_{3}, E^{n} \alpha_{2}, E^{n} \alpha_{1}\right\}_{n}$. While the paper $\mathbf{O g}$ is difficult to read because of a few of errors and gaps (see for example the last paragraph of Section 4 of [OO1), the definition of his composition is good and complicated (cf., OO1). His compositions are generally subsets of 4 -fold Toda brackets $\{\overrightarrow{\boldsymbol{\alpha}}\}_{\overrightarrow{\boldsymbol{m}}}^{(2)}$ (see $\S 2.1$ for definition) which are easily defined and may be alternatives to his compositions. Mimura, Mori and Oda MMO, p.20] had the equality $H\left\{\nu_{5}, E\left(2 \nu_{7}\right), E\left(\eta_{10} \circ \sigma_{11}\right), E\left(\sigma_{18}\right)\right\}_{1}=\bar{\sigma}_{9}$ from $\mathbf{O g}$, (7.18)] and used it to compute $\pi_{28}\left(S^{5}\right)$. We prefer the equality in Corollary 1.2 to their equality because of the reason stated above.

Mimura [M1, p.175] defined 4-fold brackets and named them the higher compositions. His definition is incomplete (see for example lines $3-5$ on p. 57 of [OO1) and so some of his assertions are not effective. By the aid of his 4-fold brackets he made assertions similar to our

Corollary $1.4(2),(3)$ in M2, p.308] and used them to compute $\pi_{n+21}\left(\mathrm{~S}^{n}\right)$. By using Corollary 1.4 instead of his discussion [M2, p.308] we can follow his observation about the quadruple $\left(\sigma_{12}, \nu_{19}, 2 \nu_{22}, \nu_{25}\right)$ which is needed for Theorem A of M2]. We should remark that there is a non-serious gap in the proof of the equality $\eta_{6} \circ \bar{\kappa}_{7}=E \alpha$ on [M2, p.306]. Mimura proved it from [M1, Lemma 6.1] where he asserted $\eta_{7} \circ \bar{\kappa}_{8} \in\left\{\nu_{7}^{2}, 2 \iota_{13}, \kappa_{13}\right\}$ without proof. Nevertheless we can fill the gap with a correct proof which is typical and may be known for experts (cf., $\mathbf{O s}$ ).

Section 2 consists of four subsections $\S 2.1$ - $\S 2.4$. We recall the definition of the 4 -fold Toda bracket $\left\{\alpha_{4}, \alpha_{3}, \alpha_{2}, \alpha_{1}\right\}_{\vec{m}}^{(2)}$ in $\S 2.1$ and the adjoint bijection $\left[X, \Omega^{n} Y\right] \rightarrow\left[E^{n} X, Y\right]$ in $\S 2.2$. In §2.3, we recall the definition of the generalized Hopf invariant and give a sufficient condition on a quadruple of maps to be admissible. In $\S 2.4$, we prove Theorem 1.1 and Corollary 1.2. Section 3 consists of two subsections $\S 3.1$ and $\S 3.2$. In $\S 3.1$ we define $\left\{\alpha_{4}, \alpha_{3}, \alpha_{2}, \alpha_{1}\right\}^{(2)^{\prime}}$ and prove Theorem 1.3. In $\S 3.2$ we prove Corollary 1.4. In Appendix A we give an easy proof of OO1, Theorem 4.9] which says that $\{\overrightarrow{\boldsymbol{\alpha}}\}_{\overrightarrow{\boldsymbol{m}}}^{(2)}$ is not empty if $\overrightarrow{\boldsymbol{\alpha}}$ is admissible.

## 2. 4-FOLD TodA Brackets $\{\overrightarrow{\boldsymbol{\alpha}}\}_{\overrightarrow{\boldsymbol{m}}}^{(2)}$ And The generalized Hopf invariant

First we recall the notation of the classical Toda bracket. Given a triple ( $\alpha_{3}, \alpha_{2}, \alpha_{1}$ ) of homotopy classes $\alpha_{k} \in\left[E^{m_{k}} X_{k}, X_{k+1}\right]$, where $m_{k}$ are non negative integers, we denote by both $\left\{\alpha_{3}, \alpha_{2}, \alpha_{1}\right\}_{\left(m_{3}, m_{2}, m_{1}\right)}$ and $\left\{\alpha_{3}, \alpha_{2}, E^{m_{2}} \alpha_{1}\right\}_{m_{3}}$ the classical Toda bracket of which the original notation in $[\mathbf{T}]$ is $\left\{\alpha_{3}, E^{m_{3}} \alpha_{2}, E^{m_{3}} E^{m_{2}} \alpha_{1}\right\}_{m_{3}}\left(\subset\left[E E^{m_{3}} E^{m_{2}} E^{m_{1}} X_{1}, X_{4}\right]\right)$.
2.1. Definition of $\left\{\alpha_{4}, \alpha_{3}, \alpha_{2}, \alpha_{1}\right\}_{\left(m_{4}, m_{3}, m_{2}, m_{1}\right)}^{(2)}$. Suppose that a sequence of non negative integers $\overrightarrow{\boldsymbol{m}}=\left(m_{4}, m_{3}, m_{2}, m_{1}\right)$, five pointed spaces $X_{k}(5 \geq k \geq 1)$, and a quadruple $\overrightarrow{\boldsymbol{\alpha}}=$ $\left(\alpha_{4}, \alpha_{3}, \alpha_{2}, \alpha_{1}\right)$ of homotopy classes $\alpha_{k} \in\left[E^{m_{k}} X_{k}, X_{k+1}\right]$ are given. We use the notations: $|\overrightarrow{\boldsymbol{m}}|=\sum_{k} m_{k}$ and $E^{m_{[k, \ell]}}=E^{m_{k}} E^{m_{k-1}} \cdots E^{m_{\ell}}$ for $4 \geq k>\ell \geq 1$. We call $\boldsymbol{\boldsymbol { \alpha }}$ (or precisely $\left.\overrightarrow{\boldsymbol{\alpha}}_{\overrightarrow{\boldsymbol{m}}}\right)$ a null quadruple if $\alpha_{k+1} \circ E^{m_{k+1}} \alpha_{k}=0(k=3,2,1)$, and admissible if there exist a representative $\overrightarrow{\boldsymbol{f}}=\left(f_{4}, f_{3}, f_{2}, f_{1}\right)$ (or precisely $\left.\overrightarrow{\boldsymbol{f}}_{\overrightarrow{\boldsymbol{m}}}\right)$ of $\overrightarrow{\boldsymbol{\alpha}}$, that is, $f_{k}$ represents $\alpha_{k}$, and null homotopies $A_{k}: f_{k+1} \circ E^{n_{k+1}} f_{k} \simeq *(k=1,2,3)$ such that

In the last case, we call $\overrightarrow{\boldsymbol{A}}=\left(A_{3}, A_{2}, A_{1}\right)$ (or precisely $\overrightarrow{\boldsymbol{A}_{\boldsymbol{m}}}$ ) an admissible triple for $\overrightarrow{\boldsymbol{f}}$, and we define

which is a non-empty subset of the abelian group $\left[E^{2} E^{m_{[4,1]}} X_{1}, X_{5}\right]$ by Proposition A. 2 below. Frequently we abbreviate $\{\overrightarrow{\boldsymbol{f}} ; \overrightarrow{\boldsymbol{A}}\}_{\overrightarrow{\boldsymbol{m}}}^{(2)}$ to $\{\overrightarrow{\boldsymbol{A}}\}_{\overrightarrow{\boldsymbol{m}}}^{(2)}$. For any $\delta \in\{\overrightarrow{\boldsymbol{A}}\}_{\overrightarrow{\boldsymbol{m}}}^{(2)}$ we have

Hence, as seen on [001, p.35],

We define

where the union $\bigcup$ is taken over all admissible triples $\overrightarrow{\boldsymbol{A}}$ for $\overrightarrow{\boldsymbol{f}}$. If $\overrightarrow{\boldsymbol{\alpha}}$ is admissible, then for any representative $\overrightarrow{\boldsymbol{f}}$ of $\overrightarrow{\boldsymbol{\alpha}}$ there exists an admissible triple for $\overrightarrow{\boldsymbol{f}}$ by [OO1, Proposition 2.11] and $\{\overrightarrow{\boldsymbol{f}}\}_{\overrightarrow{\boldsymbol{m}}}^{(2)}$ depends only on $\overrightarrow{\boldsymbol{\alpha}}$ by OO1, (2.7), Lemma 2.9, Lemma 2.10]. Therefore we can denote $\{\overrightarrow{\boldsymbol{f}}\}_{\overrightarrow{\boldsymbol{m}}}^{(2)}$ by $\{\overrightarrow{\boldsymbol{\alpha}}\}_{\overrightarrow{\boldsymbol{m}}}^{(2)}$. If $\overrightarrow{\boldsymbol{\alpha}}$ is not admissible, $\{\overrightarrow{\boldsymbol{\alpha}}\}_{\overrightarrow{\boldsymbol{m}}}^{(2)}$ denotes the empty set. When $m_{k}=0$ for all $k$, we abbreviate $\{\overrightarrow{\boldsymbol{f}} ; \overrightarrow{\boldsymbol{A}}\}_{\overrightarrow{\boldsymbol{m}}}^{(2)},\{\overrightarrow{\boldsymbol{A}}\}_{\overrightarrow{\boldsymbol{m}}}^{(2)},\{\overrightarrow{\boldsymbol{f}}\}_{\overrightarrow{\boldsymbol{m}}}^{(2)}$ and $\{\overrightarrow{\boldsymbol{\alpha}}\}_{\overrightarrow{\boldsymbol{m}}}^{(2)}$ to $\{\overrightarrow{\boldsymbol{f}} ; \overrightarrow{\boldsymbol{A}}\}^{(2)},\{\overrightarrow{\boldsymbol{A}}\}^{(2)},\{\overrightarrow{\boldsymbol{f}}\}^{(2)}$ and $\{\overrightarrow{\boldsymbol{\alpha}}\}^{(2)}$ respectively.

Lemma 2.1.1. Let $\overrightarrow{\boldsymbol{f}}=\left(f_{4}, \ldots, f_{1}\right)$ be an admissible sequence of maps $f_{k}: E^{m_{k}} X_{k} \rightarrow$ $X_{k+1}(1 \leq k \leq 4)$ and $\left(A_{3}, A_{2}, A_{1}\right)$ an admissible triple for $\overrightarrow{\boldsymbol{f}}$. Then, given a map $h: X_{5} \rightarrow$ $X_{5}^{\prime}$, we have

Proof. Suppose that $\overrightarrow{\boldsymbol{A}}=\left(A_{3}, A_{2}, A_{1}\right)$ is an admissible triple for $\overrightarrow{\boldsymbol{f}}$. Then, as is easily seen, $\left(h \circ A_{3}, A_{2}, A_{1}\right)$ is an admissible triple for $\left(h \circ f_{4}, f_{3}, f_{2}, f_{1}\right)$ and $\left(\widetilde{E} A_{3}, A_{2}, A_{1}\right)$ is an admissible triple for $\left(E f_{4}, f_{3}, f_{2}, f_{1}\right)$. We have

& =\left\{h \circ f_{4},\left[f_{3}, A_{2}, E^{m_{3}} f_{2}\right],\left(E^{m_{3}} f_{2}, \widetilde{E}^{m_{3}} A_{1}, E^{m_{[3,2]}} f_{1}\right)\right\}_{m_{4}} \\
& \cap\left\{\left[h \circ f_{4}, h \circ A_{3}, E^{m_{4}} f_{3}\right] \circ\left(\psi_{f_{3}}^{m_{4}}\right)^{-1},\left(f_{3}, A_{2}, E^{m_{3}} f_{2}\right),-E E^{m_{[3,2]}} f_{1}\right\}_{m_{4}} \\
& =\left\{h \circ A_{3}, A_{2}, A_{1}\right\}_{\vec{m}}^{(2)} .

Hence the containment is proved. Suppose that $h$ is a homotopy equivalence and let $h^{-1}$ be a homotopy inverse of $h$. We have

If $\overrightarrow{\boldsymbol{\alpha}}$ is admissible, then two Toda brackets $\left\{\alpha_{4}, \alpha_{3}, E^{m_{3}} \alpha_{2}\right\}_{m_{4}}$ and $\left\{\alpha_{3}, \alpha_{2}, E^{m_{2}} \alpha_{1}\right\}_{m_{3}}$ contain 0. A sufficient condition that a null quadruple is admissible was given by Oguchi Og, (6.3)] (cf. OO1, Proposition 4.1]). A particular case remarked by Mimura [M1, p.174] (cf. OO1, Proposition 4.4]) is that if (i) or (ii) below holds, then $\boldsymbol{\alpha}$ is admissible.

It follows from OO4 Proposition 5.2] that if $X_{k}$ is well pointed for all $k$ then $\{\overrightarrow{\boldsymbol{f}}\}_{\overrightarrow{\boldsymbol{m}}}^{(2)} \subset$ $(-1)^{m_{4}}\{\overrightarrow{\boldsymbol{f}}\}_{\overrightarrow{\boldsymbol{m}}}^{(\stackrel{s}{t}}$ (see OO3 or OO4 for the definition of $\{\overrightarrow{\boldsymbol{f}}\}_{\overrightarrow{\boldsymbol{m}}}^{(\stackrel{s}{t})}$ ).
2.2. Adjoint $\Theta_{(X, Y)}^{n}:\left[X, \Omega^{n} Y\right] \cong\left[E^{n} X, Y\right]$. We denote by $Y^{X}$ the space of maps from $X$ to $Y$ with the compact open topology. Set $\Omega^{n} Y=Y^{\mathrm{S}^{n}}$, where $\mathrm{S}^{n}=\left\{\left(x_{1}, \ldots, x_{n+1}\right) \in\right.$ $\left.\mathbb{R}^{n+1} \mid \sum x_{i}^{2}=1\right\}$ with $*=(1,0, \ldots, 0)$ the base point. We defined the identifications

For $n \geq 2$, let $\psi_{n}:\left(I^{n}, \partial I^{n}\right) \rightarrow\left(\mathrm{S}^{n}, *\right)$ be any but fixed relative homeomorphism for each $n$, for example, define it as in [T, p.5]. We identify $I^{n} / \partial I^{n}$ with $\mathrm{S}^{n}$ by the homeomorphism induced from $\psi_{n}$ for $n \geq 1$. We identify $\mathrm{S}^{n}$ with $\underbrace{S^{1} \wedge \cdots \wedge S^{1}}_{n}$ by the homeomorphism $h_{n}$ making the following diagram commutative.


We identify $S^{n_{1}} \wedge \cdots \wedge S^{n_{k}}$ with $S^{n_{1}+\cdots+n_{k}}$ for $n_{i} \geq 1$ as follows.

2.3. Generalized Hopf invariant. Let $Y$ be a special complex, namely, $Y$ is a countable CW-complex with only one vertex, say $y_{0}$, and let $Y_{\infty}$ be the reduced product complex of $Y$ J1]. By definition, $Y_{\infty}$ is algebraically a free semi group generated by $Y-\left\{y_{0}\right\}$ i.e. it is the set of all ordered finite sequences of elements in $Y-\left\{y_{0}\right\}$ and the empty sequence is the left and right identity which is denoted by $y_{0}$. Let $Y_{m}$ be the set of sequences in $Y-\left\{y_{0}\right\}$ which have not more than $m$ terms, with the identification topology determined by $p_{m}: Y^{m} \rightarrow Y_{m},\left(a_{1}, \ldots, a_{m}\right) \mapsto a_{1} \cdots a_{m}$, of course if $a_{i}=y_{0}$ then $p_{m}\left(a_{1}, \ldots, a_{m}\right)=$ $a_{1} \cdots a_{i-1} a_{i+1} \cdots a_{m}$. Thus $Y_{0}=\left\{y_{0}\right\}, Y_{1}=Y$, and $Y_{m} \subset Y_{m+1}$. As a topological space $Y_{\infty}=\lim _{m \rightarrow \infty} Y_{m}$. Then $Y_{\infty}$ is also a special complex. Let $i: Y \rightarrow Y_{\infty}$ and $i_{Y}: Y \rightarrow \Omega E Y$ be the canonical injections, that is, $i: Y_{1} \subset Y_{\infty}$ and $i_{Y}(y)(\bar{t})=y \wedge \bar{t}$. Let $\Phi_{Y}: Y_{\infty} \rightarrow \Omega E Y$ be the canonical map J1] which is the identity on $Y$, that is, $\Phi_{Y} \circ i=i_{Y}$, and so

We have $\operatorname{Indet}\left\{\nu_{9}, \eta_{11} \circ \sigma_{12}, \sigma_{19}\right\}_{1}=\pi_{21}^{9} \circ \sigma_{21}+\nu_{9} \circ E \pi_{27}^{11}=\{0\}$ so that $\bar{\sigma}_{9}=E^{3} \bar{\sigma}_{6}=$ $\left\{\nu_{9}, \eta_{11} \circ \sigma_{12}, \sigma_{19}\right\}_{1}$. As is easily seen, $\left\{k \nu_{9}, \eta_{11} \circ \sigma_{12}, \sigma_{19}\right\}_{1}=\bar{\sigma}_{9}$ for $k=1,3,5,7$. Hence $H\left\{E \nu_{4}, 2 \nu_{7}, \eta_{10} \circ \sigma_{11}, \sigma_{18}\right\}_{(1,0,0,0)}^{(2)}=\bar{\sigma}_{9}$. This ends the proof of Corollary 1.2.
3. 4-FOLD Toda brackets $\{\overrightarrow{\boldsymbol{\alpha}}\}^{(2)^{\prime}}$ and the generalized Hopf invariant
3.1. Definition of $\{\overrightarrow{\boldsymbol{\alpha}}\}^{(2)^{\prime}}$. Suppose that homotopy classes $\alpha_{k} \in\left[X_{k}, X_{k+1}\right](1 \leq k \leq 4)$ are given. We call the sequence $\overrightarrow{\boldsymbol{\alpha}}=\left(\alpha_{4}, \alpha_{3}, \alpha_{2}, \alpha_{1}\right)$ quasi-admissible if $\alpha_{k+1} \circ \alpha_{k}=0(1 \leq k \leq 3)$ and there exist a representative $\overrightarrow{\boldsymbol{f}}$ of $\overrightarrow{\boldsymbol{\alpha}}$ and a sequence $\overrightarrow{\boldsymbol{A}}=\left(A_{3}, A_{2}, A_{1}\right)$ of null homotopies $A_{k}: f_{k+1} \circ f_{k} \simeq *(1 \leq k \leq 3)$ such that $\widetilde{E} \overrightarrow{\boldsymbol{A}}=\left(\widetilde{E} A_{3}, \widetilde{E} A_{2}, \widetilde{E} A_{1}\right)$ is an admissible triple for $E \overrightarrow{\boldsymbol{f}}=\left(E f_{4}, E f_{3}, E f_{2}, E f_{1}\right)$ and so $E \overrightarrow{\boldsymbol{\alpha}}$ is admissible. In the last case we call $\overrightarrow{\boldsymbol{A}}$ a quasiadmissible triple for $\overrightarrow{\boldsymbol{f}}$. If $\overrightarrow{\boldsymbol{\alpha}}$ is quasi-admissible and $\overrightarrow{\boldsymbol{f}}^{\prime}$ is any representative of $\overrightarrow{\boldsymbol{\alpha}}$, then there exists a quasi-admissible triple for $\overrightarrow{\boldsymbol{f}}^{\prime}$. In fact

Lemma 3.1.1. Suppose that $\overrightarrow{\boldsymbol{A}}$ is a quasi-admissible triple for $\overrightarrow{\boldsymbol{f}}$ and $H_{k}: f_{k} \simeq f_{k}^{\prime}(1 \leq$ $k \leq 4)$. If we set $A_{k}^{\prime}=A_{k} \bullet\left(\left(-H_{k+1}\right) \bar{o}\left(-H_{k}\right)\right)$, then $\overrightarrow{\boldsymbol{A}^{\prime}}=\left(A_{3}^{\prime}, A_{2}^{\prime}, A_{1}^{\prime}\right)$ is a quasi-admissible triple for $\overrightarrow{\boldsymbol{f}^{\prime}}=\left(f_{4}^{\prime}, f_{3}^{\prime}, f_{2}^{\prime}, f_{1}^{\prime}\right)$ and

\end{align*}

where $\bigcup_{\overrightarrow{\boldsymbol{A}}}$ and $\bigcup_{\overrightarrow{\boldsymbol{B}}^{\prime}}$ are unions taken over all quasi-admissible triples $\overrightarrow{\boldsymbol{A}}$ and $\overrightarrow{\boldsymbol{B}^{\prime}}$ for $\overrightarrow{\boldsymbol{f}}$ and $\overrightarrow{\boldsymbol{f}}^{\prime}$ respectively.

Proof. The equality (3.1.1) holds by [OO1, Proposition 2.11]. Hence $\bigcup_{\overrightarrow{\boldsymbol{A}}}\{E \overrightarrow{\boldsymbol{f}} ; \widetilde{E} \overrightarrow{\boldsymbol{A}}\}^{(2)} \subset$ $\bigcup_{\overrightarrow{\boldsymbol{B}^{\prime}}}\left\{E \overrightarrow{\boldsymbol{f}^{\prime}} ; \widetilde{E} \overrightarrow{\boldsymbol{B}}^{\prime}\right\}^{(2)}$. Interchanging $\overrightarrow{\boldsymbol{f}}$ and $\overrightarrow{\boldsymbol{f}^{\prime}}$ each other we obtain the opposite containment. Hence (3.1.2) holds. This ends the proof.

As is easily seen, if $\overrightarrow{\boldsymbol{\alpha}}$ is admissible, then it is quasi-admissible. As shall be proved in Corollary 1.4, quasi-admissible does not imply admissible in general. Another example is

Example 3.1.2. $\left(2 \iota_{2}, \eta_{2}^{2}, 2 \iota_{4}, \eta_{4}\right)$ is not admissible but quasi-admissible.

We omit a proof of the above example because we do not use it in this note.
Suppose that $\overrightarrow{\boldsymbol{\alpha}}$ is quasi-admissible. For a quasi-admissible triple $\overrightarrow{\boldsymbol{A}}$ for a representative $\overrightarrow{\boldsymbol{f}}$ of $\boldsymbol{\boldsymbol { \alpha }}$, we defined, in $\S 2.1$,

which is a non-empty subset of $\left[E^{3} X_{1}, E X_{5}\right]$ by Proposition A.2. We define $\{\overrightarrow{\boldsymbol{f}}\}^{(2)^{\prime}}=$ $\bigcup\{E \overrightarrow{\boldsymbol{f}} ; \widetilde{E} \overrightarrow{\boldsymbol{A}}\}^{(2)}$, where the union $\bigcup$ is taken over all quasi-admissible triples $\overrightarrow{\boldsymbol{A}}$ for $\overrightarrow{\boldsymbol{f}}$. Since $\{\overrightarrow{\boldsymbol{f}}\}^{(2)^{\prime}}$ depends only on homotopy classes of $f_{k}$ by Lemma 3.1.1, we denote $\{\overrightarrow{\boldsymbol{f}}\}^{(2)^{\prime}}$ by $\{\overrightarrow{\boldsymbol{\alpha}}\}^{(2)^{\prime}}$, that is,

Hence $\lambda_{0} \circ 2 \nu_{31} \equiv \sigma_{13} \circ \kappa_{20} \bmod \sigma_{13}^{3}$. As seen in [M2, p.308], $\pi_{34}^{13}$ contains $\mathbb{Z}_{2}\left\{\sigma_{13} \circ \kappa_{20}\right\} \oplus$ $\mathbb{Z}_{2}\left\{\sigma_{13}^{3}\right\}$. Hence the order of $\lambda_{0} \circ \nu_{31}$ is four. This proves Corollary 1.4(3).

In the rest of the subsection we will prove three lemmas.

## Appendix A. An easy proof of [OO1, Theorem 4.9]

As an introduction to the definition of Ôguchi's 4-fold bracket, we proved Theorem 4.9 of 001 by a slightly difficult method. We should note that the main part of the theorem itself is an easy consequence of elementary properties of Toda brackets. We will explain it. First we prove

(3) If $X_{k}=X_{k}^{\prime}$ and $a_{k}=1_{X_{k}}$ for $k=1,4$, then $\left\{f_{3}, f_{2}, f_{1}\right\}_{n}$ and $\left\{f_{3}^{\prime}, f_{2}^{\prime}, f_{1}^{\prime}\right\}_{n}$ have a common element.

We have $\left\{f_{3}^{\prime}, f_{2}^{\prime} \circ a_{2}, f_{1}\right\}_{n} \supset\left\{f_{3}^{\prime}, f_{2}^{\prime}, a_{2} \circ f_{1}\right\}_{n}=\left\{f_{3}^{\prime}, f_{2}^{\prime} \circ a_{2} \circ a_{2}^{-1}, a_{2} \circ f_{1}\right\}_{n} \supset\left\{f_{3}^{\prime}, f_{2}^{\prime} \circ a_{2}, f_{1}\right\}_{n}$ and so $\left\{f_{3}^{\prime}, f_{2}^{\prime} \circ a_{2}, f_{1}\right\}_{n}=\left\{f_{3}^{\prime}, f_{2}^{\prime}, a_{2} \circ f_{1}\right\}_{n}$. We have $\left\{f_{3}^{\prime}, f_{2}^{\prime}, f_{1}^{\prime} \circ a_{1}\right\}_{n} \supset\left\{f_{3}^{\prime}, f_{2}^{\prime}, f_{1}^{\prime}\right\}_{n} \circ E^{n+1} a_{1}=$ $\left\{f_{3}^{\prime}, f_{2}^{\prime}, f_{1}^{\prime} \circ a_{1} \circ a_{1}^{-1}\right\}_{n} \circ E^{n+1} a_{1} \supset\left\{f_{3}^{\prime}, f_{2}^{\prime}, f_{1}^{\prime} \circ a_{1}\right\}_{n}$ and so $\left\{f_{3}^{\prime}, f_{2}^{\prime}, f_{1}^{\prime} \circ a_{1}\right\}_{n}=\left\{\overrightarrow{\boldsymbol{f}^{\prime}}\right\}_{n} \circ E^{n+1} a_{1}$. This proves (2).
(3) Suppose that $X_{i}=X_{i}^{\prime}$ and $a_{i}=1_{X_{i}}$ for $i=1,4$. Take $\alpha \in\left\{f_{3}, f_{2}, f_{1}\right\}_{n}$ and $\alpha^{\prime} \in$ $\left\{f_{3}^{\prime}, f_{2}^{\prime}, f_{1}^{\prime}\right\}_{n}$ arbitrarily. Then we have

$$
\begin{aligned}
& \left\{f_{3}, f_{2}, f_{1}\right\}_{n}=\left[E^{n+1} X_{2}, X_{4}\right] \circ E^{n+1} f_{1}+\alpha+f_{3} \circ E^{n}\left[E X_{1}, X_{3}\right] \\
& \left\{f_{3}^{\prime}, f_{2}^{\prime}, f_{1}^{\prime}\right\}_{n}=\left[E^{n+1} X_{2}^{\prime}, X_{4}\right] \circ E^{n+1} f_{1}^{\prime}+\alpha^{\prime}+f_{3}^{\prime} \circ E^{n}\left[E X_{1}, X_{3}^{\prime}\right]
\end{aligned}
$$

Since $a_{2} \circ f_{1} \simeq f_{1}^{\prime}$ and $f_{3} \simeq f_{3}^{\prime} \circ E^{n} a_{3}$, we have $\left[E^{n+1} X_{2}, X_{4}\right] \circ E^{n+1} f_{1} \supset\left[E^{n+1} X_{2}^{\prime}, X_{4}\right] \circ E^{n+1} f_{1}^{\prime}$ and $f_{3} \circ E^{n}\left[E X_{1}, X_{3}\right] \subset f_{3}^{\prime} \circ E^{n}\left[E X_{1}, X_{3}^{\prime}\right]$. It follows from (1) that we have

$$
\begin{aligned}
& {\left[E^{n+1} X_{2}, X_{4}\right] \circ E^{n+1} f_{1}+\alpha+f_{3}^{\prime} \circ E^{n}\left[E X_{1}, X_{3}^{\prime}\right]} \\
& =\left[E^{n+1} X_{2}, X_{4}\right] \circ E^{n+1} f_{1}+\alpha^{\prime}+f_{3}^{\prime} \circ E^{n}\left[E X_{1}, X_{3}^{\prime}\right]
\end{aligned}
$$

so that $\alpha^{\prime}=\beta+\alpha+\gamma$ for some $\beta \in\left[E^{n+1} X_{2}, X_{4}\right] \circ E^{n+1} f_{1}$ and $\gamma \in f_{3}^{\prime} \circ E^{n}\left[E X_{1}, X_{3}^{\prime}\right]$. Then $\beta+\alpha$ is contained in both $\left\{f_{3}, f_{2}, f_{1}\right\}_{n}$ and $\left\{f_{3}^{\prime}, f_{2}^{\prime}, f_{1}^{\prime}\right\}_{n}$. This proves (3).

Now we rewrite the main part of Theorem 4.9 of OO1. Suppose that the following data are given: five spaces $X_{k}(1 \leq k \leq 5)$, four non-negative integers $m_{k}(1 \leq k \leq 4)$ (usually we take $m_{1}=m_{2}=0$ because it does not injure the generality as shall be shown on the end of this appendix), four maps $f_{k}: E^{m_{k}} X_{k} \rightarrow X_{k+1}(1 \leq k \leq 4)$, and three null homotopies $A_{k}: f_{k+1} \circ E^{m_{k+1}} f_{k} \simeq *(1 \leq k \leq 3)$ such that

$$
\left[f_{k+2}, A_{k+1}, E^{m_{k+2}} f_{k+1}\right] \circ\left(E^{m_{k+2}} f_{k+1}, \widetilde{E}^{m_{k+2}} A_{k}, E^{m_{k+2}} E^{m_{k+1}} f_{k}\right) \simeq *(k=1,2)
$$

Then the main part of Theorem 4.9 of $\mathbf{O O 1}$ is

Proposition A.2. The Toda brackets $\left\{f_{4},\left[f_{3}, A_{2}, E^{m_{3}} f_{2}\right],\left(E^{m_{3}} f_{2}, \widetilde{E}^{m_{3}} A_{1}, E^{m_{[3,2]}} f_{1}\right)\right\}_{m_{4}}$ and $\left\{\left[f_{4}, A_{3}, E^{m_{4}} f_{3}\right] \circ\left(\psi_{f_{3}}^{m_{4}}\right)^{-1},\left(f_{3}, A_{2}, E^{m_{3}} f_{2}\right),-E E^{m_{[3,2]}} f_{1}\right\}_{m_{4}}$ have a common element.

Proof. Consider the following homotopy commutative diagrams.


Since

$$
\left(f_{3}, A_{2}, E^{m_{3}} f_{2}\right) \circ\left(-E E^{m_{[3,2]}} f_{1}\right) \simeq i_{f_{3}} \circ\left[f_{3}, A_{2}, E^{m_{3}} f_{2}\right] \circ\left(E^{m_{3}} f_{2}, \widetilde{E}^{m_{3}} A_{1}, E^{m_{[3,2]}} f_{1}\right) \simeq *
$$

we can apply Lemma A.1(3) to the above diagrams and we obtain the assertion.
Given $\overrightarrow{\boldsymbol{\alpha}}=\left(\alpha_{4}, \alpha_{3}, \alpha_{2}, \alpha_{1}\right)$ with $\alpha_{k} \in\left[E^{m_{k}} X_{k}, X_{k+1}\right](1 \leq k \leq 4)$, let $\overrightarrow{\boldsymbol{f}}=\left(f_{4}, f_{3}, f_{2}, f_{1}\right)$ be a representative of $\overrightarrow{\boldsymbol{\alpha}}$. Set

$$
X_{k}^{*}=\left\{\begin{array}{ll}
E^{m_{[2,1]} X_{1}} & k=1 \\
E^{m_{2}} X_{2} & k=2 \\
X_{k} & 3 \leq k \leq 5
\end{array} \quad, \quad m_{k}^{*}=\left\{\begin{array}{ll}
0 & k=1,2 \\
m_{k} & k=3,4
\end{array}, \quad f_{k}^{*}= \begin{cases}E^{m_{2}} f_{1} & k=1 \\
f_{k} & 2 \leq k \leq 4\end{cases}\right.\right.
$$

Suppose $\overrightarrow{\boldsymbol{\alpha}}$ is admissible. Let $\overrightarrow{\boldsymbol{A}}=\left(A_{3}, A_{2}, A_{1}\right)$ be an admissible triple for $\overrightarrow{\boldsymbol{f}}$. Then $\overrightarrow{\boldsymbol{A}}$ is also an admissible triple for $\overrightarrow{\boldsymbol{f}^{*}}$. It follows that $\{\overrightarrow{\boldsymbol{f}}\}_{\overrightarrow{\boldsymbol{m}}}^{(2)}=\left\{\overrightarrow{\boldsymbol{f}^{*}}\right\}_{\overrightarrow{\boldsymbol{m}}^{*}}^{(2)}$. Hence we can denote $\{\overrightarrow{\boldsymbol{f}}\}_{\overrightarrow{\boldsymbol{m}}}^{(2)}$ by $\{\overrightarrow{\boldsymbol{\alpha}}\}_{\overrightarrow{\boldsymbol{m}}}^{(2)}$ and $\left\{\alpha_{4}, \alpha_{3}, \alpha_{2}, E^{m_{2}} \alpha_{1}\right\}_{\left(m_{4}, m_{3}\right)}^{(2)}$.
