# Three-color Ramsey number of an odd cycle versus bipartite graphs with small bandwidth *

#### Abstract

A graph $\mathcal{H}=\left(W, E_{\mathcal{H}}\right)$ is said to have bandwidth at most $b$ if there exists a labeling of $W$ as $w_{1}, w_{2}, \ldots, w_{n}$ such that $|i-j| \leq b$ for every edge $w_{i} w_{j} \in E_{\mathcal{H}}$. We say that $\mathcal{H}$ is a balanced $(\beta, \Delta)$-graph if it is a bipartite graph with bandwidth at most $\beta|W|$ and maximum degree at most $\Delta$, and it also has a proper 2-coloring $\chi: W \rightarrow[2]$ such that $\left\|\chi^{-1}(1)\left|-\left|\chi^{-1}(2) \| \leq \beta\right| \chi^{-1}(2)\right|\right.$.

In this paper, we prove that for every $\gamma>0$ and every natural number $\Delta$, there exists a constant $\beta>0$ such that for every balanced $(\beta, \Delta)$-graph $\mathcal{H}$ on $n$ vertices we have $$
R\left(\mathcal{H}, \mathcal{H}, C_{n}\right) \leq(3+\gamma) n
$$ for all sufficiently large odd $n$. The upper bound is sharp for several classes of graphs. Let $\theta_{n, t}$ be the graph consisting of $t$ internally disjoint paths of length $n$ all sharing the same endpoints. As a corollary, for each fixed $t \geq 1, R\left(\theta_{n, t}, \theta_{n, t}, C_{n t+\lambda}\right)=(3 t+o(1)) n$, where $\lambda=0$ if $n t$ is odd and $\lambda=1$ if $n t$ is even. In particular, we have $R\left(C_{2 n}, C_{2 n}, C_{2 n+1}\right)=(6+o(1)) n$, which is a special case of a result of Figaj and Łuczak (2018).

## 1 Introduction

For graphs $G$ and $G_{1}, G_{2}, \ldots, G_{k}$ we write $G \rightarrow\left(G_{1}, G_{2}, \ldots, G_{k}\right)$ if for every $k$-edge-coloring of $G$, there is a monochromatic copy of $G_{i}$ for some $i \in[k]$, where $[k]=\{1,2, \ldots, k\}$. The multicolor Ramsey number $R\left(G_{1}, G_{2}, \ldots, G_{k}\right)$ is defined to be the smallest integer $N$ such that $K_{N} \rightarrow\left(G_{1}, G_{2}, \ldots, G_{k}\right)$. We denote $R_{k}(G)$ instead of $R\left(G_{1}, G_{2}, \ldots, G_{k}\right)$ when $G_{i}=G$ for $1 \leq i \leq k$.

Let $P_{n}$ (resp. $C_{n}$ ) be the path (resp. cycle) on $n$ vertices. For the Ramsey numbers of $R\left(C_{m}, C_{n}\right)$, it has been studied and completely determined in Bondy and Erdős [7], Faudree and Schelp [19], and Rosta [42]. Later, Erdős, Faudree, Rousseau and Schelp [16] obtained the exact value of $R\left(C_{\ell}, C_{m}, C_{n}\right)$ for sufficiently large $n$. In 1999, by using the regularity lemma, Luczak [36] proved that $R\left(C_{n}, C_{n}, C_{n}\right)=(4+o(1)) n$ for all large odd integer $n$, and some years later Kohayakawa, Simonovits and Skokan [33] determined the exact value of it for all large odd $n$. In [36], Łuczak introduced a technique that uses the regularity lemma to reduce problems

[^0]about paths and cycles to problems about connected matchings, which are matchings that are contained in a connected component. This technique has become fairly standard. The following papers were based on this technique. For large even cycle, Figaj and Łuczak [21] obtained that $R\left(C_{n}, C_{n}, C_{n}\right)=(2+o(1)) n$, and Benevides and Skokan [5] obtained the exact value. Furthermore, Figaj and Łuczak [21, 22] determined the asymptotic values of $R\left(C_{\ell}, C_{m}, C_{n}\right)$ when $\ell, m$, and $n$ are large integers with same order. In particular, Figaj and Łuczak [22] determined
$$
R\left(C_{2 n}, C_{2 n}, C_{2 n+1}\right)=(6+o(1)) n
$$

Furthermore, Ferguson [23, 24, 25] obtained exact Ramsey numbers for the three-color cases of mixed parity cycles. Recently, Jenssen and Skokan [31] established that

$$
R_{k}\left(C_{n}\right)=2^{k-1}(n-1)+1
$$

for each fixed $k \geq 2$ and large odd $n$, which confirms a conjecture of Bondy and Erdős [7]. For more multicolor Ramsey numbers involving large cycles, we refer the reader to [1, 16, 37, 43], etc.

The Ramsey numbers of paths are also fruitful. A well-known result of Gerencsér and Gyárfás [27] states that $R\left(P_{m}, P_{n}\right)=n+\left\lfloor\frac{m}{2}\right\rfloor$ for all $n \geq m \geq 1$. Faudree and Schelp [20] determined $R\left(P_{n_{0}}, P_{n_{1}}, P_{n_{2}}\right)$ for $n_{0} \geq 6\left(n_{1}+n_{2}\right)^{2}$, and they also conjectured that

$$
R\left(P_{n}, P_{n}, P_{n}\right)= \begin{cases}2 n-1, & n \text { is odd }  \tag{1}\\ 2 n-2, & n \text { is even }\end{cases}
$$

Gyárfás, Ruszinkó, Sárközy and Szemerédi [29] confirmed this conjecture for large $n$. For Ramsey numbers of cycles versus paths, Faudree, Lawrence, Parsons and Schelp [18] obtained the Ramsey numbers for all path-cycle pairs. In 2009, Dzido and Fidytek [15] (independently by Bielak [6]) obtained that if $m \geq 3$ is odd, $n \geq m$ and $n>\frac{3 t^{2}-14 t+25}{4}$ when $t$ is odd, and $n>\frac{3 t^{2}-10 t+20}{8}$ when $t$ is even, then $R\left(P_{t}, P_{n}, C_{m}\right)=2 n+2\left\lfloor\frac{t}{2}\right\rfloor-3$. In [45], Shao, Xu, Shi and Pan proved that $R\left(P_{4}, P_{5}, C_{n}\right)=n+2$ for $n \geq 23$ and $R\left(P_{4}, P_{6}, C_{n}\right)=n+3$ for $n \geq 18$. Omidi and Raeisi [40] determined $R\left(P_{4}, P_{n}, C_{4}\right)=R\left(P_{5}, P_{n}, C_{4}\right)=n+2$ for $n \geq 5$.

We say that a graph $\mathcal{H}=\left(W, E_{\mathcal{H}}\right)$ has bandwidth at most $b$ if there is a labeling of $W$ as $w_{1}, w_{2}, \ldots, w_{n}$ such that $|i-j| \leq b$ for every edge $w_{i} w_{j} \in E_{\mathcal{H}}$ (see, e.g., [10]). We say $\mathcal{H}=\left(W, E_{\mathcal{H}}\right)$ is a balanced $(\beta, \Delta)$-graph if it is a bipartite graph with bandwidth at most $\beta|W|$ and maximum degree at most $\Delta$, and furthermore it has a proper 2 -coloring $\chi: W \rightarrow[2]$ such that $\| \chi^{-1}(1)\left|-\left|\chi^{-1}(2)\right|\right| \leq \beta\left|\chi^{-1}(2)\right|$. In [38], Mota, Sárközy, Schacht and Taraz determined asymptotically the three color Ramsey number $R(\mathcal{H}, \mathcal{H}, \mathcal{H}) \leq(2+o(1)) n$, which implies that

$$
R\left(C_{n}, C_{n}, C_{n}\right)=(2+o(1)) n
$$

for all large even $n$.
In this paper, we are concerned with the asymptotic behavior of the Ramsey number $R\left(\mathcal{H}, \mathcal{H}, C_{n}\right)$ when $n$ is odd and every balanced $(\beta, \Delta)$-graph $\mathcal{H}$ on $n$ vertices.

Theorem 1.1 For any sufficiently small $\gamma$ and every natural number $\Delta$, there exists a constant $\beta>0$ such that for every balanced $(\beta, \Delta)$-graph $\mathcal{H}$ on $n$ vertices we have

$$
R\left(\mathcal{H}, \mathcal{H}, C_{n}\right) \leq(3+\gamma) n
$$

for all sufficiently large odd $n$.

Let $\theta_{n, t}$ be the graph consisting of $t$ internally disjoint paths of length $n$ all sharing the same endpoints. In particular, $\theta_{n, 2}=C_{2 n}$, i.e. the even cycle on $2 n$ vertices. Observe that $\theta_{n, t}$ is a bipartite graph with $(n-1) t+2$ vertices, and $\theta_{n, t}$ is a balanced $(\beta, t)$-graph with $\beta \leq \frac{2}{n}$.

The following result is clear from Theorem 1.1.
Corollary 1.1 For each fixed $t \geq 1$,

$$
R\left(\theta_{n, t}, \theta_{n, t}, C_{n t+\lambda}\right)=(3 t+o(1)) n,
$$

where $\lambda=0$ if $n t$ is odd and $\lambda=1$ if $n t$ is even. In particular, we have that $R\left(P_{2 n}, P_{2 n}, C_{2 n+1}\right) \sim$ $R\left(C_{2 n}, C_{2 n}, C_{2 n+1}\right)=(6+o(1)) n$.

Let us point out that the result $R\left(C_{2 n}, C_{2 n}, C_{2 n+1}\right)=(6+o(1)) n$ and $R\left(P_{2 n}, P_{2 n}, C_{2 n+1}\right)=$ $(6+o(1)) n$ follow from the work of Figaj and Luczak [22] and have been strengthened by Ferguson [23].

## 2 Preliminaries

In this paper, we shall omit all floors and ceilings since it will not affect our argument. For a graph $G$, let $V(G)$ and $E(G)$ denote its vertex set and edge set, respectively. Let $|E(G)|=e(G)$ and $|V(G)|=v(G)$. For $v \in V$, we let $N_{G}(v)$ denote the neighborhood of $v$ in $G$, and $\operatorname{deg}_{G}(v)=$ $\left|N_{G}(v)\right|$ which is the degree of a vertex $v \in V(G)$. We denote by $\delta(G)$ and $\triangle(G)$ the minimum and maximum degrees of the vertices of $G$. For any subset $U \subseteq V$, we use $G[U]$ to denote the subgraph induced by the vertex set $U$ in $G$. For a vertex $v \in V$ and $U \subset V$, we write $N_{G}(v, U)$ for the neighbors of $v$ in $U$ in graph $G$ and $\operatorname{deg}(v, U)=\left|N_{G}(v, U)\right|$.

### 2.1 The regularity method

For disjoint vertex sets $A, B \subseteq V$, let $e_{G}(A, B)$ denote the number of edges of $G$ with one endpoint in $A$ and the other in $B$, and the density between $A$ and $B$ is

$$
d_{G}(A, B)=\frac{e_{G}(A, B)}{|A||B|} .
$$

We always omit the subscript when there is no confusion.
Definition 2.1 ( $\epsilon$-regular) A pair $(A, B)$ is $\epsilon$-regular if for all $X \subseteq A$ and $Y \subseteq B$ with $|X|>\epsilon|A|$ and $|Y|>\epsilon|B|$ we have $|d(X, Y)-d(A, B)|<\epsilon$.

Definition 2.2 ( $(\epsilon, d)$-regular) For $\epsilon>0, d \leq 1$, a pair $(A, B)$ is said to be $(\epsilon, d)$-regular if it is $\epsilon$-regular and $d(A, B) \geq d$.

Definition 2.3 ( $(\epsilon, d)$-super-regular) $A$ pair $(A, B)$ is said to be $(\epsilon, d)$-super-regular if it is $\epsilon$-regular and $\operatorname{deg}(u, B)>d|B|$ for all $u \in A$ and $\operatorname{deg}(v, A)>d|A|$ for all $v \in B$.

We have a property that any regular pair has a large subgraph which is super-regular, and we include a proof for completeness.

Fact 2.1 For $0<\epsilon<1 / 2$ and $d \leq 1$, if $(A, B)$ is $(\epsilon, d)$-regular with $|A|=|B|=m$, then there exist $A_{1} \subseteq A$ and $B_{1} \subseteq B$ with $\left|A_{1}\right|=\left|B_{1}\right| \geq(1-\epsilon) m$ such that $\left(A_{1}, B_{1}\right)$ is $(2 \epsilon, d-2 \epsilon)$-superregular.

Proof. Let $X \subseteq A$ consist of vertices with at most $(d-\epsilon)|B|$ neighbors in $B$. Accounting for $e(X, B) \leq|X| \cdot(d-\epsilon)|B|$, we have $|d(X, B)-d| \geq \epsilon$. Due to the definition of $\epsilon$-regular, it follows that $|X| \leq \epsilon m$. Similarly, assume that $Y \subseteq B$ consists of vertices with at most $(d-\epsilon)|A|$ neighbors in $A$, then we obtain $|Y| \leq \epsilon m$. Take $A_{1} \subseteq A \backslash X$ and $B_{1} \subseteq B \backslash Y$ with $\left|A_{1}\right|=\left|B_{1}\right|=(1-\epsilon) m$. Thus for any vertex $u \in A_{1}, \operatorname{deg}\left(u, B_{1}\right) \geq(d-2 \epsilon) m$. Also, $\operatorname{deg}\left(w, A_{1}\right) \geq(d-2 \epsilon) m$ for any $w \in B_{1}$.

Now, for any subsets $S \subseteq A_{1}$ and $T \subseteq B_{1}$, if $|S|>2 \epsilon\left|A_{1}\right|$ and $|T|>2 \epsilon\left|B_{1}\right|$, then clearly $|S|>\epsilon m$ and $|T|>\epsilon m$. Since $(A, B)$ is $(\epsilon, d)$-regular, it follows that

$$
\left|d(S, T)-d\left(A_{1}, B_{1}\right)\right| \leq|d(S, T)-d(A, B)|+\left|d\left(A_{1}, B_{1}\right)-d(A, B)\right|<2 \epsilon
$$

We have thus proved the fact.
In this paper, we will use the following three-color version of the regularity lemma. For many applications, we refer the reader to surveys $[32,41]$ and many recent references $[2,11,12,13$, $14,26,35,39,47]$, etc.

Lemma 2.1 (Szemerédi [46]) For every $\epsilon>0$ and integer $t_{0} \geq 1$, there exists $T_{0}=T_{0}\left(\epsilon, t_{0}\right) \geq$ $t_{0}$ such that the following holds. For all graphs $G_{1}, G_{2}$ and $G_{3}$ with the same vertex set $V$ and $|V| \geq t_{0}$, there exists a partition $V=\cup_{i=0}^{t} V_{i}$ satisfying $t_{0} \leq t \leq T_{0}$ and
(1) $\left|V_{0}\right|<\epsilon n,\left|V_{1}\right|=\left|V_{2}\right|=\ldots=\left|V_{t}\right|$;
(2) all but at most $\epsilon\binom{t}{2}$ pairs $\left(V_{i}, V_{j}\right), 1 \leq i \neq j \leq t$, are $\epsilon$-regular for $G_{1}, G_{2}$ and $G_{3}$.

The next lemma by Benevides and Skokan [5] is a slightly stronger version compared to the original one established by Łuczak [36, Claim 3].

Lemma 2.2 (Benevides and Skokan [5]) For every $0<\beta_{0}<1$, there exists an $n_{0}$ such that for every $n>n_{0}$ the following holds: If $\left(V_{1}, V_{2}\right)$ is $\epsilon$-regular with $\left|V_{1}\right|=\left|V_{2}\right|=n$ and density at least $\beta_{0} / 4$ for some $\epsilon$ satisfying $0<\epsilon<\beta_{0} / 100$, then for every $\ell, 1 \leq \ell \leq n-5 \epsilon n / \beta_{0}$, and for every pair of vertices $v^{\prime} \in V_{1}, v^{\prime \prime} \in V_{2}$ satisfying $\operatorname{deg}\left(v^{\prime}, V_{2}\right), \operatorname{deg}\left(v^{\prime \prime}, V_{1}\right) \geq \beta_{0} n / 5, G$ contains a path of length $2 \ell+1$ connecting $v^{\prime}$ and $v^{\prime \prime}$.

Let $\mathcal{H}=\left(W, E_{\mathcal{H}}\right)$ be a graph, for $S \subseteq W$, denote $N_{\mathcal{H}}(S)=\left[\cup_{v \in S} N_{\mathcal{H}}(v)\right] \backslash S$. For a graph $G=(V, E)$, a partition $\cup_{i=1}^{k} V_{i}$ of $V$ is said to be $(\epsilon, d)$-regular on a reduced graph $H$ with vertex set contained in $[k]$ if the pair $\left(V_{i}, V_{j}\right)$ is $(\epsilon, d)$-regular whenever $i j \in E(H)$.

When applying the regularity lemma, we will indeed find a partition of a monochromatic subgraph $G$ of $K_{N}$ with corresponding reduced graph containing a tree $T$ that contains a "large" matching $M$, where the bipartite subgraphs of $G$ corresponding to the matching are super-regular pairs. The following definition of $\epsilon$-compatible is due to Mota, Sárközy, Schacht and Taraz [38].

Definition 2.4 ( $\epsilon$-compatible) Let $\mathcal{H}=\left(W, E_{\mathcal{H}}\right)$ and $T=\left([t], E_{T}\right)$ be graphs. Let $M=$ $\left([t], E_{M}\right)$ be a subgraph of $T$ where $E_{M}$ is a matching. Given a partition $W=\cup_{i=1}^{t} W_{i}$, let $U_{i}$, for $i \in[t]$, be the set of vertices in $W_{i}$, with neighbors in some $W_{j}$ with $i j \in E_{T} \backslash E_{M}$. Set $U=\cup U_{i}$ and $U_{i}^{\prime}=N_{\mathcal{H}}(U) \cap\left(W_{i} \backslash U\right)$.

We say that $W=\cup_{i=1}^{t} W_{i}$ is $(\epsilon, T, M)$-compatible with a vertex partition $\cup_{i=1}^{t} V_{i}$ of a graph $G=(V, E)$ if the following holds.
(1) $\left|W_{i}\right| \leq\left|V_{i}\right|$ for $i \in[t]$.
(2) $x y \in E_{\mathcal{H}}$ for $x \in W_{i}, y \in W_{j}$ implies $i j \in E_{T}$ for all distinct $i, j \in[t]$.
(3) $\left|U_{i}\right| \leq \epsilon\left|V_{i}\right|$ for $i \in[t]$.
(4) $\left|U_{i}^{\prime}\right|,\left|U_{j}^{\prime}\right| \leq \epsilon \min \left\{\left|V_{i}\right|,\left|V_{j}\right|: i j \in E_{M}\right\}$.

The following corollary of the Blow-up Lemma (see Böttcher, Heinig and Taraz [8, 9]) asserts that in the setup of Definition 2.4 graphs $\mathcal{H}$ of bounded degree can be embedded into $G$, if $G$ admits a partition being sufficiently regular on $T$ and super-regular on $M$.

Lemma 2.3 (Embedding Lemma [8, 9]) For all $d, \Delta>0$ there is a constant $\epsilon=\epsilon(d, \Delta)>0$ such that the following holds. Let $G=(V, E)$ be an $N$-vertex graph that has a partition $\cup_{i=1}^{t} V_{i}$ with $(\epsilon, d)$-reduced graph $T$ on $[t]$ which is $(\epsilon, d)$-super-regular on a graph $M \subset T$. Further, let $\mathcal{H}=\left(W, E_{\mathcal{H}}\right)$ be an n-vertex graph with maximum degree $\Delta(\mathcal{H}) \leq \Delta$ and $n \leq N$ that has a vertex partition $\cup_{i=1}^{t} W_{i}$ of $W$ which is $(\epsilon, T, M)$-compatible with $\cup_{i=1}^{t} V_{i}$. Then $\mathcal{H} \subseteq G$.

For a graph $\mathcal{H}=\left(W, E_{\mathcal{H}}\right)$ with $W=\left\{w_{1}, w_{2}, \ldots, w_{n}\right\}$, where $w_{i}$ is a labeling of the vertices, let $\chi: W \rightarrow[2]$ be a 2-coloring. For $W^{\prime} \subseteq W$, denote $C_{i}\left(W^{\prime}\right)=\left|\chi^{-1}(i) \cap W^{\prime}\right|$ for $i=1,2$. We know that $\chi$ is a $\beta$-balanced coloring of $W$ if $1-\beta \leq \frac{C_{1}(W)}{C_{2}(W)} \leq 1+\beta$. A set $I \subseteq W$ is called an interval if there exists $p<q$ such that $I=\left\{w_{p}, w_{p+1}, \ldots, w_{q}\right\}$. Finally, let $\sigma:[\ell] \rightarrow[\ell]$ be a permutation, and for a partition $\left\{I_{1}, I_{2}, \ldots, I_{\ell}\right\}$ of $W$, where $I_{1}, \ldots, I_{\ell}$ are intervals, let $C_{i}(\sigma, a, b)=\sum_{j=a}^{b} C_{i}\left(I_{\sigma(j)}\right)$ for $i=1,2$.

Lemma 2.4 (Mota et al. [38]) For every $\xi>0$ and every integer $\ell \geq 1$ there exists $n_{0}$ such that if $\mathcal{H}=\left(W, E_{\mathcal{H}}\right)$ is a graph on $W=\left\{w_{1}, w_{2}, \ldots, w_{n}\right\}$ with $n \geq n_{0}$, then for every $\beta$-balanced 2-coloring $\chi$ of $W$ with $\beta \leq 2 / \ell$, and every partition of $W$ into intervals $I_{1}, I_{2}, \ldots, I_{\ell}$ with $\left|I_{1}\right| \leq\left|I_{2}\right| \leq \cdots \leq\left|I_{\ell}\right| \leq\left|I_{1}\right|+1$ there exists a permutation $\sigma:[\ell] \rightarrow[\ell]$ such that for every pair of integers $1 \leq a<b \leq \ell$ with $b-a \geq 7 / \xi$, we have $\left|C_{1}(\sigma, a, b)-C_{2}(\sigma, a, b)\right| \leq \xi C_{2}(\sigma, a, b)$.

### 2.2 Structure

Recall that a set $M$ of independent edges in a graph $G=(V, E)$ is called a matching. The size of a connected matching corresponds to the number of edges in the matching. The structure of graphs without large connected matchings play an important role in this paper. As a path on $n$ vertices contains a connected matching on $\lfloor n / 2\rfloor$ edges, extremal results for paths directly give an upper bound for connected matchings.

The following is the well-known extremal result for paths.
Lemma 2.5 (Erdős and Gallai [17]) If $G$ is a graph of order $N$ which contains no $P_{n}$, then

$$
e(G) \leq \frac{n-2}{2} N
$$

The following result describes the structure of a graph without a large matching.
Lemma 2.6 (Knierim and Su [34]) For every connected graph $G=(V, E)$ which contains no matching of size $n / 2$, there is a partition $S_{G} \cup Q_{G} \cup I_{G}$ of the vertex set $V$ such that
(i) $\left|Q_{G}\right|+2\left|S_{G}\right|=\min \{v(G), n-1\}$,
(ii) $I_{G}$ is an independent set; additionally, if $v(G) \leq n-1$, then $I_{G}=\emptyset$,
(iii) every vertex in $Q_{G}$ has at most one neighbor in $I_{G}$,
(iv) every vertex in $I_{G}$ has degree less than $n / 2$.

We will also use the following lemmas. Let us begin with a result due to Luczak [36] which gives a description of the structure of a graph that contains no large odd cycle as a subgraph.

Lemma 2.7 (Luczak [36]) For every $0<\delta<10^{-15}, \alpha \geq 2 \delta$ and $t \geq \exp \left(\delta^{-16} / \alpha\right)$ the following holds. Each graph $H$ on $t$ vertices which contains no odd cycles longer than $\alpha$ contains subgraphs $H^{\prime}$ and $H^{\prime \prime}$ such that:
(i) $V\left(H^{\prime}\right) \cup V\left(H^{\prime \prime}\right)=V(H), V\left(H^{\prime}\right) \cap V\left(H^{\prime \prime}\right)=\emptyset$ and each of the sets $V\left(H^{\prime}\right)$ and $V\left(H^{\prime \prime}\right)$ is either empty or contains at least $\alpha \delta t / 2$ vertices;
(ii) $H^{\prime}$ is bipartite;
(iii) $H^{\prime \prime}$ contains no more than $\alpha t\left|V\left(H^{\prime \prime}\right)\right| / 2$ edges;
(iv) all except no more than $\delta t^{2}$ edges of $H$ belong to either $H^{\prime}$ or $H^{\prime \prime}$.

The following result due to Gyárfás, Ruszinkó, Sárközy and Szemerédi [29] states that a graph with high density always contains a dense subgraph.

Fact 2.2 (Gyárfás et al. [29]) Let $\epsilon>0$ be sufficiently small and let $H$ be a graph with $v(H)$ vertices. If $e(H) \geq\binom{ v(H)}{2}-\epsilon\binom{t}{2}$, then $H$ has a subgraph $H^{\prime}$ with at least $v(H)-\sqrt{\epsilon} t$ vertices and $\delta\left(H^{\prime}\right) \geq v(H)-2 \sqrt{\epsilon} t$.

A spanning subgraph of a graph $G$ is a subgraph obtained by edge deletions only, in other words, a subgraph whose vertex set is the entire vertex set of $G$. We also need the following simple result.

Lemma 2.8 For any $\epsilon>0$, if $H^{\prime}$ is a spanning subgraph of $H$ with $e\left(H^{\prime}\right) \geq e(H)-\epsilon\binom{t}{2}$, then there exists a induced subgraph $H^{\prime \prime} \subset H$ with at least $v(H)-\sqrt{\epsilon} t$ vertices and $\operatorname{deg}_{H^{\prime \prime}}(u)<$ $\operatorname{deg}_{H^{\prime}}(u)+\sqrt{\epsilon}$ for any vertex $u \in V\left(H^{\prime \prime}\right)$.

Proof. Let $X=\left\{u \in V(H) \mid \operatorname{deg}_{H}(u)-\operatorname{deg}_{H^{\prime}}(u) \geq \sqrt{\epsilon} t\right\}$. Clearly, $e(H)-e\left(H^{\prime}\right) \geq \frac{\sqrt{\epsilon} t|X|}{2}$. Thus we have

$$
\frac{\sqrt{\epsilon} t|X|}{2} \leq \epsilon\binom{t}{2},
$$

implying that $|X|<\sqrt{\epsilon}$ t. Denote $H^{\prime \prime}=H-X$, i.e. the subgraph obtained from $H$ by deleting all vertices of $X$ and all edges incident to some vertices of $X$. Thus for any $u \in V\left(H^{\prime \prime}\right)$,

$$
\operatorname{deg}_{H^{\prime \prime}}(u)=\operatorname{deg}_{H}(u)-\operatorname{deg}_{H}(u, X)<\left(\operatorname{deg}_{H^{\prime}}(u)+\sqrt{\epsilon} t\right)-\operatorname{deg}_{H}(u, X) \leq \operatorname{deg}_{H^{\prime}}(u)+\sqrt{\epsilon} t,
$$

completing the proof.

### 2.3 Monochromatic components

In [44], Schelp conjectured that if $G$ is a graph on $3 n-1$ vertices with minimum degree at least $3|V(G)| / 4$, then $G \rightarrow\left(P_{2 n}, P_{2 n}\right)$ provided $n$ sufficiently large. Gyárfás and Sárközy [30] and independently Benevides, Łuczak, Scott, Skokan and White [4] confirmed this conjecture asymptotically. Recently, Balogh, Kostochka, Lavrov and Liu [3] obtain the following result and thus confirm this conjecture thoroughly.

Lemma 2.9 (Balogh et al. [3]) Let $G$ be a graph on $3 n-1$ vertices with minimum degree at least $(3|V(G)|-1) / 4$. If $n$ is sufficiently large, then $G \rightarrow\left(P_{2 n}, P_{2 n}\right)$.

Erdős and Rado remarked that any 2-colored complete graph contains a monochromatic spanning tree, see [28]. We will apply the following result due to Gyárfás and Sárközy [30] to get a large monochromatic component for every 2-coloring of the edges of graph $G$ with large minimum degree.

Lemma 2.10 (Gyárfás and Sárközy [30]) For any 2-coloring of edges of a graph $G$ with minimum degree $\delta(G) \geq \frac{3|V(G)|}{4}$, there is a monochromatic component of order larger than $\delta(G)$. This estimate is sharp.

## 3 Proof of Theorem 1.1

Let $N=(3+\gamma) n$, where $\gamma>0$ is a sufficiently small real number and $n$ is a sufficiently large odd integer. Consider a 3 -edge coloring of $K_{N}$ on vertex set $V$, and let $G_{i}(i=1,2,3)$ be the graph induced by the edges in the $i$ th color. We shall show that either $G_{i}$ contains a copy of $\mathcal{H}$ for some $i=1,2$, or $G_{3}$ contains an odd cycle $C_{n}$. On the contrary, we suppose that $G_{i}$ contains no $\mathcal{H}$ for $i=1,2$, and $G_{3}$ contains no odd cycle $C_{n}$. We aim to find a contradiction.

We write $a \ll b$ if $a$ is much smaller than $b$. Let $\gamma>0$ and $\Delta \geq 1$ be given. We apply Lemma 2.3 to $G_{1}$ (or $G_{2}$ ) with $d=1 / 4$ and $\Delta$ to get $\epsilon_{1}$. We set $\eta, \epsilon, \delta$ and $\beta$ such that

$$
\begin{equation*}
\eta=\frac{\gamma}{15}, \quad \delta=\min \left\{10^{-16}, \frac{\eta^{2}}{100}\right\} \quad \epsilon=\min \left\{\frac{\delta}{1296}, \epsilon_{1}\right\} \quad \text { and } 0<\beta \ll \epsilon \tag{2}
\end{equation*}
$$

Moreover, set

$$
\begin{equation*}
t_{0}=\max \left\{\frac{1}{\epsilon}, \exp \left(\frac{3(1+\eta)}{\delta^{16}}\right)\right\} . \tag{3}
\end{equation*}
$$

We apply the regularity lemma (Lemma 2.1) to $G_{1}, G_{2}$ and $G_{3}$ with $\epsilon, t_{0}$ to obtain a $T_{0}=$ $T_{0}\left(\epsilon, t_{0}\right)$ such that there exists a partition of the vertex set $V$ into $t+1$ classes $V=V_{0} \cup V_{1} \cup \cdots \cup V_{t}$ satisfying $t_{0} \leq t \leq T_{0}$ and (1) $\left|V_{0}\right|<\epsilon n,\left|V_{1}\right|=\left|V_{2}\right|=\ldots=\left|V_{t}\right|$; (2) all but at most $\epsilon\binom{t}{2}$ pairs $\left(V_{i}, V_{j}\right), 1 \leq i \neq j \leq t$, are $\epsilon$-regular for $G_{1}, G_{2}$ and $G_{3}$. We construct the reduced graph $H$ with vertex set $\left\{v_{1}, v_{2}, \ldots, v_{t}\right\}$ and the edge set formed by pairs $\left\{v_{i}, v_{j}\right\}$ for which $\left(V_{i}, V_{j}\right)$ is $\epsilon$-regular with respect to $G_{1}, G_{2}$ and $G_{3}$. In which $v_{i}$ and $v_{j}$ are non-adjacent in $H$ if the pairs $\left(V_{i}, V_{j}\right)$ is not $\epsilon$-regular for some $G_{i}$. Thus we obtain a bijection $f: v_{i} \rightarrow V_{i}$ between the vertices of $H$ and the clusters of the partition.

Clearly, $e(H) \geq(1-\epsilon)\binom{t}{2}$ from Lemma 2.1. Accordingly, we assign color $i(i \in[3])$ to an edge of $H$ if and only if $i$ is the minimum integer for which

$$
d_{G_{i}}\left(V_{i}, V_{j}\right) \geq 1 / 3
$$

Let $H_{i}\left(F_{i}\right)$ be the spanning subgraph of $H(F)$ induced by all edges that have received color $i$.
Overview of the remaining proof: The remaining part of the proof is straightforward but rather rich in technical details, so we shall briefly outline it first. From the assumption that $G_{3}$ contains no odd cycle $C_{n}$, we will show that the reduced subgraph $H_{3}$ contains no odd cycle of length at least $\frac{(1+0.1 \eta) t}{3(1+\eta)}$. Since $G_{i}$ contains no $\mathcal{H}$ for $i=1$ or 2 , we shall get that $H_{i}$ contains no connected matching on more than $\left(\frac{1}{3}-0.2 \eta\right) t$ vertices for $i=1$ or 2 . Then, we can easily get that $e\left(H_{3}\right) \geq e(H) / 3 \geq\left(\frac{1}{6}-\epsilon / 3\right) t^{2}$. Now, since $H_{3}$ contains no odd cycle of length at least $\frac{(1+0.1 \eta) t}{3(1+\eta)}$, we apply Lemma 2.7 to graph $H_{3}$ with $\alpha=\frac{(1+0.1 \eta)}{3(1+\eta)}$ to deduce that $H_{3}$ contains subgraphs $H_{3}^{\prime}$ which is bipartite and $H_{3}^{\prime \prime}$ such that the desired properties hold. Let $A$ and $B$ be the color classes of the bipartition of $H_{3}^{\prime}$, and let $X=V\left(H_{3}^{\prime \prime}\right)$. We will show that $|X|<(1 / 3-\eta / 5) t$ and $\max \{|A|,|B|\}<\left(\frac{1}{2}-\sqrt{\delta} / 2\right) t$.

Combining with the above desired properties and Lemma 2.8, we can deduce that the reduced graph $H$ contains a subgraph $F$ on at least $\left(1-\frac{3}{2} \sqrt{\delta}\right) t$ vertices such that $\delta(F)>v(F)-\sqrt{\delta} t / 2$ and $\operatorname{deg}_{F_{3}}(u)<\left(\frac{1}{2}+\sqrt{\delta}\right) t$ for any vertex $u \in V(F)$. Since $F \subset H$ and $H_{i}$ contains no connected matching on more than $\left(\frac{1}{3}-0.2 \eta\right) t$ vertices for $i=1$ or 2 , we conclude that $F_{i}$ contains no connected matching on more than $\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F)$ vertices for $i=1,2$. Moreover, by Lemma 2.6 , the order of the largest component of $F_{i}(i=1,2)$ must be less than $\frac{1}{3} v(F)$. By noting $|X|<(1 / 3-\eta / 5) t$ and Fact 2.2 , we obtain a vertex set $B^{\prime \prime} \subseteq B \cap V(F)$ such that each vertex of $B^{\prime \prime}$ is adjacent to at least $\max \left\{v(F) / 3,(1-\sqrt{\delta} / 4)\left|B^{\prime \prime}\right|\right\}$. Now we apply Lemma 2.10 to $H\left[B^{\prime \prime}\right]$ to conclude that $H\left[B^{\prime \prime}\right]$ contains a monochromatic component in color 1 or 2 of order larger than $\frac{1}{3} v(F)$. Then $F_{i}(\mathrm{i}=1,2)$ contains a monochromatic component in color 1 or 2 of order at least
$\frac{1}{3} v(F)$, which will leads to a contradiction.
Details of the remaining proof: We will have the following claims at first.
Claim 3.1 $H_{3}$ contains no odd cycle of length at least $\frac{(1+0.1 \eta) t}{3(1+\eta)}$.
Proof of Claim 3.1. On the contrary, let $C$ be an odd cycle of length $s \geq \frac{(1+0.1 \eta) t}{3(1+\eta)}$. Without loss of generality, assume that its vertex set is $[s]$. Thus we have that for $i=1,2, \ldots, s,\left(V_{i}, V_{i+1}\right)$ is $\epsilon$-regular and $d_{G_{3}}\left(V_{i}, V_{i+1}\right) \geq 1 / 3$, where the indices take modula on $s$. By Fact 2.1, for odd $i=1,3, \ldots, s-2$, we can take $V_{i}^{\prime} \subseteq V_{i}$ with $\left|V_{i}^{\prime}\right| \geq(1-\epsilon)\left|V_{i}\right|$ and $\left|V_{i+1}^{\prime}\right| \geq(1-\epsilon)\left|V_{i+1}\right|$ such that $\left(V_{i}^{\prime}, V_{i+1}^{\prime}\right)$ is $(2 \epsilon, 1 / 3-2 \epsilon)$-super-regular. From the property of $\epsilon$-regularity pairs, we can find an odd cycle $u_{1} u_{2} \ldots u_{s} u_{1}$ such that $u_{i} \in V_{i}^{\prime}$ for $i=1,2, \ldots, s-1$. We apply the techniques used by Luczak [36] and Lemma 2.2 to show that the $G_{3}$ contains a $C_{n}$.

Let $m=(1-\epsilon)^{2} \frac{N}{t}, \epsilon^{\prime}=2 \epsilon$ and $\beta_{0}=1-6 \epsilon$. Thus we have that every pair of vertices $v_{i} \in V_{i}^{\prime}$, $v_{i+1} \in V_{i+1}^{\prime}$ satisfies $\operatorname{deg}_{G_{3}}\left(v_{i}, V_{i+1}^{\prime}\right) \geq(1 / 3-2 \epsilon)\left|V_{i+1}^{\prime}\right|>\beta_{0} m / 5$, and $\operatorname{deg}_{G_{3}}\left(v_{i+1}, V_{i}^{\prime}\right)>\beta_{0} m / 5$. Therefore, by Lemma 2.2, for every $\ell, 1 \leq \ell \leq m-5 \epsilon m / \beta_{0}$, and for every pair of vertices $u_{i} \in V_{i}^{\prime}$ and $u_{i+1} \in V_{i+1}^{\prime}$ and odd $i=1,3, \ldots, s-2, G_{3}$ contains a path of length $2 \ell+1$ connecting $u_{i}$
and $u_{i+1}$. Thus, there are odd cycles of all lengths from $s$ to $(s-1)\left(m-5 \epsilon m / \beta_{0}\right)$. Since

$$
\begin{aligned}
(s-1)\left(m-5 \epsilon m / \beta_{0}\right) & \geq\left(\frac{(1+0.1 \eta) t}{3(1+\eta)}-1\right)\left(1-\frac{5 \epsilon}{1-6 \epsilon}\right)(1-\epsilon)^{2} \frac{N}{t} \\
& \stackrel{(3)}{>} \frac{t}{3(1+\eta)}(1-10 \epsilon) \frac{(3+\gamma) n}{t} \stackrel{(2)}{\geq} \frac{1+5 \eta}{1+\eta}(1-10 \epsilon) n,
\end{aligned}
$$

which is at least $n$ again by noting (2). So $G_{3}$ contains an odd cycle $C_{n}$ as desired.
A connected matching in a graph $G$ is a matching $M$ such that all edges of $M$ are in the same connected component of $G$. By the assumption of $G_{i}$ contains no $\mathcal{H}$ for $i=1,2$, we have the following claim.

Claim 3.2 For $i=1,2, H_{i}$ contains no connected matching on more than $\left(\frac{1}{3}-0.2 \eta\right) t$ vertices.
Proof of Claim 3.2. On the contrary, without loss of generality, suppose that $H_{1}$ contains a connected matching $M$ on at least $\left(\frac{1}{3}-0.2 \eta\right) t$ vertices that is contained in a tree $T \subset H_{1}$. Suppose that the vertex set of $T$ is $\left\{x_{1}, \ldots, x_{l}, x_{l+1}, \ldots, x_{2 l}, x_{2 l+1}, \ldots, x_{2 l+l^{\prime}}\right\}$, and the matching $M$ has edge set $E_{M}=\left\{x_{i} x_{l+i}: i=1, \ldots, l\right\}$.

We will prove that there exists a copy of $\mathcal{H}$ in $G_{1}$, contradicting the assumption that $G_{1}$ contains no $\mathcal{H}$. Since the proof is similar as in [38, Theorem 1.3], we only give a sketch of the proof as follows.

Firstly, we shall apply Fact 2.1 to get a subgraph $G_{P}$ of $G_{1}$ with classes

$$
A_{1}, \ldots, A_{l}, A_{l+1}, \ldots, A_{2 l}, A_{2 l+1}, \ldots, A_{2 l+l^{\prime}}
$$

which corresponds to the vertices $x_{1}, \ldots, x_{l}, x_{l+1}, \ldots, x_{2 l}, x_{2 l+1}, \ldots, x_{2 l+l^{\prime}}$, and each of those sets has size at least $(1-2 \epsilon) N / t$ and the bipartite graphs induced by $A_{i}$ and $A_{l+i}$ are $(2 \epsilon, 1 / 3-\epsilon)$ -super-regular for $i \in[l]$ and the bipartite graphs induced by all the other pairs are $(2 \epsilon, 1 / 3-\epsilon)$ regular. It is clear that these dense super-regular pairs covering $(1+o(1)) n$ vertices.

Secondly, we partition the vertices of $\mathcal{H}$ and, since $\mathcal{H}=\left(W, E_{\mathcal{H}}\right)$ has small bandwidth, we can apply Lemma 2.4 to obtain a partition of $W$ which will be composed of clusters

$$
W_{1}, \ldots, W_{l}, W_{l+1} \ldots, W_{2 l}, W_{2 l+1}, \ldots, W_{2 l+l^{\prime}}
$$

Fix $1 \leq j \leq 2 l+l^{\prime}$, we define $U_{j}$ as the set of vertices of $W_{j}$ with neighbors in some $W_{k}$ with $j \neq k$ and $\left\{x_{j} x_{k}\right\} \notin M$. Define the set $U_{j}^{\prime}=N_{H}(U) \cap\left(W_{j} \backslash U\right)$, where $U=\bigcup_{I=1}^{2 l+l^{\prime}} U_{i}$.

Then, we can verify that all of the four conditions of Definition 2.4 hold, i.e.,
(1) $\left|W_{i}\right| \leq\left|A_{i}\right|$ for $i \in\left[2 l+l^{\prime}\right]$.
(2) $x y \in E_{\mathcal{H}}$ for $x \in W_{i}, y \in W_{j}$ implies $x_{i} x_{j} \in E_{T}$ for all distinct $i, j \in\left[2 l+l^{\prime}\right]$.
(3) $\left|U_{i}\right| \leq \epsilon\left|A_{i}\right|$ for $i \in\left[2 l+l^{\prime}\right]$.
(4) $\left|U_{i}^{\prime}\right|,\left|U_{j}^{\prime}\right| \leq \epsilon \min \left\{\left|A_{i}\right|,\left|A_{j}\right|: x_{i} x_{j} \in E_{M}\right\}$.

Thus, the partition $\left\{W_{1}, \ldots, W_{2 l+l^{\prime}}\right\}$ of $W$ is $(2 \epsilon, T, M)$-compatible with $\left\{A_{1}, \ldots, A_{2 l+l^{\prime}}\right\}$, which is a partition of $V\left(G_{P}\right)$.

Finally, we can find a copy of $\mathcal{H}$ in $G_{P}$ by the Embedding Lemma (Lemma 2.3), completing the proof.

Claim 3.3 $e\left(H_{3}\right) \geq e(H) / 3 \geq\left(\frac{1}{6}-\epsilon / 3\right) t^{2}$.
Proof of Claim 3.3. On the contrary, suppose that $e\left(H_{3}\right)<e(H) / 3$. Thus, without loss of generality, suppose that

$$
\begin{equation*}
e\left(H_{1}\right)>e(H) / 3 \geq \frac{1}{3}(1-\epsilon)\binom{t}{2} \geq\left(\frac{1}{6}-\epsilon / 3\right) t^{2} . \tag{4}
\end{equation*}
$$

However, Claim 3.2 implies that $H_{1}$ contains no path with more than $\left(\frac{1}{3}-0.2 \eta\right) t+1$ vertices, it follows by Lemma 2.5 that

$$
e\left(H_{1}\right) \leq \frac{\left(\frac{1}{3}-0.2 \eta\right) t-1}{2} \cdot t<\left(\frac{1}{6}-0.1 \eta\right) t^{2} .
$$

This contradicts (4) by noting (2).
By Claim 3.1, $H_{3}$ contains no odd cycle of length at least $\frac{(1+0.1 \eta) t}{3(1+\eta)}$. Now we apply Lemma 2.7 to graph $H_{3}$ with $\alpha=\frac{(1+0.1 \eta)}{3(1+\eta)}$ to deduce that $H_{3}$ contains subgraphs $H_{3}^{\prime}$ and $H_{3}^{\prime \prime}$ such that
(i) $V\left(H_{3}^{\prime}\right) \cup V\left(H_{3}^{\prime \prime}\right)=V\left(H_{3}\right), V\left(H_{3}^{\prime}\right) \cap V\left(H_{3}^{\prime \prime}\right)=\emptyset$ and each of the sets $V\left(H_{3}^{\prime}\right)$ and $V\left(H_{3}^{\prime \prime}\right)$ is either empty or contains at least $\alpha \delta t / 2$ vertices;
(ii) $H_{3}^{\prime}$ is bipartite;
(iii) $H_{3}^{\prime \prime}$ contains no more than $\alpha t\left|V\left(H_{3}^{\prime \prime}\right)\right| / 2$ edges;
(iv) all except no more than $\delta t^{2}$ edges of $H_{3}$ belong to either $H_{3}^{\prime}$ or $H_{3}^{\prime \prime}$.

Let $A$ and $B$ be the sets of the bipartition of $H_{3}^{\prime}$, and let $X=V\left(H_{3}^{\prime \prime}\right)$. From Claim 3.3 and the property of $H_{3}$ (see (iv)), we have

$$
\begin{equation*}
e\left(H_{3}^{\prime}\right)+e\left(H_{3}^{\prime \prime}\right) \geq e\left(H_{3}\right)-\delta t^{2} \geq\left(\frac{1}{6}-\epsilon / 3\right) t^{2}-\delta t^{2} \stackrel{(2)}{>}\left(\frac{1-7 \delta}{6}\right) t^{2} . \tag{5}
\end{equation*}
$$

Claim 3.4 $|X|<(1 / 3-\eta / 5) t$.
Proof of Claim 3.4. Let us put $|X|=\lambda t$ and $|A \cup B|=(1-\lambda) t$. By Lemma 2.7 (iii),

$$
\begin{align*}
e\left(H_{3}^{\prime}\right)+e\left(H_{3}^{\prime \prime}\right) & \leq e\left(H_{3}^{\prime}\right)+\frac{\alpha t\left|V\left(H_{3}^{\prime \prime}\right)\right|}{2} \leq \frac{\left|V\left(H_{3}^{\prime}\right)\right|^{2}}{4}+\frac{\alpha t\left|V\left(H_{3}^{\prime \prime}\right)\right|}{2} \\
& \leq \frac{(1-\lambda)^{2}}{4} t^{2}+\frac{\lambda(1+0.1 \eta)}{6(1+\eta)} t^{2}, \tag{6}
\end{align*}
$$

which together with (5) yield that

$$
\frac{(1-\lambda)^{2}}{4}+\frac{\lambda(1-0.8 \eta)}{6}>\frac{(1-\lambda)^{2}}{4}+\frac{\lambda(1+0.1 \eta)}{6(1+\eta)} \geq \frac{1}{6}-\frac{7 \delta}{6}
$$

from which we obtain that $3 \lambda^{2}-(4+1.6 \eta) \lambda+(1+14 \delta)>0$. Since $\lambda \leq 1$, it follows that

$$
\lambda<\frac{1}{6}\left(4+1.6 \eta-\sqrt{(4+1.6 \eta)^{2}-12(1+14 \delta)}\right)<\frac{1}{3}(2+0.8 \eta-\sqrt{1+3 \eta})<\frac{1}{3}-\frac{\eta}{5}
$$

provided $\eta$ is sufficiently small and by noting (2).

Claim $3.5 \max \{|A|,|B|\}<\left(\frac{1}{2}-\sqrt{\delta} / 2\right) t$.
Proof of Claim 3.5. On the contrary, suppose that $|A| \geq\left(\frac{1}{2}-\sqrt{\delta} / 2\right) t$ without loss of generality. Let $H[A]$ be the subgraph of $H$ induced by $A$. Note that $H[A]$ only contains edges in color 1 or color 2 as $H_{3}^{\prime}$ is bipartite. Note also that $e(H[A]) \geq\binom{|A|}{2}-\epsilon\binom{t}{2}$. By Fact 2.2, $H[A]$ contains a subgraph $H\left[A^{\prime}\right]$ such that $\left|A^{\prime}\right| \geq\left(\frac{1}{2}-\sqrt{\delta} / 2\right) t-\sqrt{\epsilon} t>\left(\frac{1}{2}-\sqrt{\delta}\right) t$ and

$$
\delta\left(H\left[A^{\prime}\right]\right) \geq\left|A^{\prime}\right|-2 \sqrt{\epsilon} t>\left|A^{\prime}\right|-6 \sqrt{\epsilon}\left|A^{\prime}\right| \stackrel{(2)}{>}(1-\sqrt{\delta})\left|A^{\prime}\right|,
$$

the second inequality due to $t<\frac{\left|A^{\prime}\right|}{(1 / 2-\sqrt{\delta})}$ and $\delta$ is sufficiently small. Now we apply Lemma 2.9 with graph $H\left[A^{\prime}\right]$ and $n=\frac{(1 / 2-\sqrt{\delta}) t+1}{3}$ to conclude that $H\left[A^{\prime}\right]$ contains a monochromatic path $P_{\frac{(1-2 \sqrt{\delta}) t}{3}}$ in color 1 or color 2 . As $\frac{(1-2 \sqrt{\delta}) t}{3}>\left(\frac{1}{3}-0.2 \eta\right) t+1$ from (2), we have that either $G_{1}$ or $G_{2}$ must contain a copy of $\mathcal{H}$ by Claim 3.2, a contradiction.

For graphs $P$ and $Q$, we use $P \cup Q$ to denote the graph defined on $V(P) \cup V(Q)$ whose edge set is $E(P) \cup E(Q)$. From Claims 3.4-3.5 noting that $V\left(H_{3}^{\prime}\right) \cup V\left(H_{3}^{\prime \prime}\right)=V\left(H_{3}\right)=V(H)$ and $V\left(H_{3}^{\prime}\right) \cap V\left(H_{3}^{\prime \prime}\right)=\emptyset$, we have that for any vertex $u \in V(H)$,

$$
\begin{equation*}
\operatorname{deg}_{H_{3}^{\prime} \cup H_{3}^{\prime \prime}}(u)<\left(\frac{1}{2}-\frac{\sqrt{\delta}}{2}\right) t . \tag{7}
\end{equation*}
$$

For an edge-colored graph $F$, we use $F_{i}$ to denote the subgraph induced by edges in color $i$ in $F$.

Claim 3.6 $H$ has a subgraph $F$ with at least $\left(1-\frac{3}{2} \sqrt{\delta}\right)$ t vertices such that $\delta(F)>v(F)-\sqrt{\delta} t / 2$ and $\operatorname{deg}_{F_{3}}(u)<\left(\frac{1}{2}+\sqrt{\delta}\right)$ t for any vertex $u \in V(F)$.

Proof of Claim 3.6. We know that all but at most $\delta t^{2}$ edges of $H_{3}$ are contained in $H_{3}^{\prime} \cup H_{3}^{\prime \prime}$. By Lemma 2.8, there exists an induced subgraph $H_{3}^{0}$ of $H_{3}$ such that $v\left(H_{3}^{0}\right) \geq v(H)-\sqrt{2 \delta t}$ and

$$
\begin{equation*}
\operatorname{deg}_{H_{3}^{0}}(u)<\operatorname{deg}_{H_{3}^{\prime} \cup H_{3}^{\prime \prime}}(u)+\sqrt{2 \delta} t \stackrel{(7)}{<}\left(\frac{1}{2}-\sqrt{\delta} / 2\right) t+\sqrt{2 \delta} t<\left(\frac{1}{2}+\sqrt{\delta}\right) t \tag{8}
\end{equation*}
$$

for any vertex $u \in V\left(H_{3}^{0}\right)$.
Note that $e\left(H\left[V\left(H_{3}^{0}\right)\right]\right) \geq\left(\begin{array}{c}v\left(H_{3}^{0}\right)\end{array}\right)-\epsilon\binom{t}{2}$, it follows from Fact 2.2 that $H\left[V\left(H_{3}^{0}\right)\right]$ contains a subgraph $F$ such that

$$
\begin{equation*}
v(F) \geq v\left(H_{3}^{0}\right)-\sqrt{\epsilon} t \geq v(H)-\sqrt{2 \delta} t-\sqrt{\epsilon} t \stackrel{(2)}{>}\left(1-\frac{3}{2} \sqrt{\delta}\right) t \tag{9}
\end{equation*}
$$

and

$$
\begin{equation*}
\delta(F) \geq v\left(H_{3}^{0}\right)-2 \sqrt{\epsilon} t>v(F)-\sqrt{\delta} t / 2 . \tag{10}
\end{equation*}
$$

Since $F_{3} \subset H_{3}^{0}$, by noting (8), we obtain that for any $u \in V(F)$,

$$
\begin{equation*}
\operatorname{deg}_{F_{3}}(u) \leq \operatorname{deg}_{H_{3}^{0}}(u)<\left(\frac{1}{2}+\sqrt{\delta}\right) t \tag{11}
\end{equation*}
$$

completing the proof.
According to (10) and (11), we obtain that for any vertex $u \in V(F)$,

$$
\begin{align*}
\operatorname{deg}_{F_{1} \cup F_{2}}(u) & =\operatorname{deg}_{F_{1}}(u)+\operatorname{deg}_{F_{2}}(u) \geq \delta(F)-d_{F_{3}}(u) \geq v(F)-\sqrt{\delta} t / 2-\left(\frac{1}{2}+\sqrt{\delta}\right) t \\
& \stackrel{(9)}{>}\left(1-\frac{\frac{1}{2}+\frac{3}{2} \sqrt{\delta}}{1-\frac{3}{2} \sqrt{\delta}}\right) v(F)>\left(\frac{1}{2}-3 \sqrt{\delta}\right) v(F) \tag{12}
\end{align*}
$$

Recall that a connected matching in a graph $G$ is a matching $M$ such that all edges of $M$ are in the same connected component of $G$.

Claim 3.7 For $i=1,2, F_{i}$ contains no connected matching on more than $\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F)$ vertices.

Proof of Claim 3.7. Note that since $F \subset H$, by Claim 3.2, $F_{i}$ contains no connected matching on more than $\left(\frac{1}{3}-0.2 \eta\right) t$ vertices for $i=1,2$. Since

$$
\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F) \stackrel{(9)}{>}\left(\frac{1}{3}-3 \sqrt{\delta}\right)\left(1-\frac{3 \sqrt{\delta}}{2}\right) t>\left(\frac{1}{3}-\frac{7 \sqrt{\delta}}{2}\right) t \stackrel{(2)}{>}\left(\frac{1}{3}-0.2 \eta\right) t
$$

Thus $F_{i}(i=1,2)$ contains no connected matching on more than $\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F)$ vertices.
Claim 3.8 For $i=1,2$, the largest component of $F_{i}$ has order less than $\frac{1}{3} v(F)$.
Proof of Claim 3.8. Let $R_{1}, \ldots, R_{r}$ be the components of $F_{1}$ and let $B_{1}, \ldots, B_{b}$ be the components of $F_{2}$. Without loss of generality, suppose that $\left|V\left(R_{i}\right)\right| \geq\left|V\left(R_{i+1}\right)\right|$ for all $1 \leq i \leq$ $r-1$, and $\left|V\left(B_{j}\right) \geq\left|V\left(B_{j+1}\right)\right|\right.$ for all $1 \leq j \leq b-1$. Let $r^{\prime}, 0 \leq r^{\prime} \leq r$, be the maximum integer such that $\left|V\left(R_{r^{\prime}}\right)\right| \geq\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F)$. Similarly, let $b^{\prime}, 0 \leq b^{\prime} \leq b$, be the maximum integer such that $\left|V\left(R_{b^{\prime}}\right)\right| \geq\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F)$. We aim to show that $r^{\prime}=b^{\prime}=0$.

By Claim 3.7, $F_{1}$ and hence each $R_{i}$ contains no connected matching on more than ( $\frac{1}{3}-$ $3 \sqrt{\delta}) v(F)$ vertices. Thus Lemma 2.6 implies that each $R_{i}$ has a partition $S_{R_{i}} \cup Q_{R_{i}} \cup I_{R_{i}}$ satisfying

$$
\begin{equation*}
\left|Q_{R_{i}}\right|+2\left|S_{R_{i}}\right|=\min \left\{\left|V\left(R_{i}\right)\right|,\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F)-1\right\} \tag{13}
\end{equation*}
$$

Proposition 3.1 For $i>r^{\prime}, I_{R_{i}}=\emptyset$ and $S_{R_{i}}=\emptyset$; similarly, for $j>b^{\prime}, I_{B_{j}}=\emptyset$ and $S_{B_{j}}=\emptyset$.
Proof. For $i>r^{\prime},\left|V\left(R_{i}\right)\right| \leq\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F)-1$, implying that $\left|Q_{R_{i}}\right|+2\left|S_{R_{i}}\right|=\left|V\left(R_{i}\right)\right|$ and $I_{R_{i}}=\emptyset$ by (13). Thus $\left|Q_{R_{i}}\right|+\left|S_{R_{i}}\right|=\left|V\left(R_{i}\right)\right|$, and $S_{R_{i}}=\emptyset$ follows. The second assertion is similar.

According to Lemma 2.6 and (13), we obtain that for $1 \leq i \leq r$,

$$
\begin{equation*}
\left|S_{R_{i}}\right|<\frac{1}{2}\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F), \quad\left|Q_{R_{i}}\right|+2\left|S_{R_{i}}\right|<\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F), \tag{14}
\end{equation*}
$$

and

$$
\begin{align*}
\left|I_{R_{i}}\right|=\left|V\left(R_{i}\right) \backslash\left(Q_{R_{i}} \cup S_{R_{i}}\right)\right| & =\left|V\left(R_{i}\right)\right|+\left|S_{R_{i}}\right|-\left(\left|Q_{R_{i}}\right|+2\left|S_{R_{i}}\right|\right) \\
& >\left|V\left(R_{i}\right)\right|+\left|S_{R_{i}}\right|-\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F) \tag{15}
\end{align*}
$$

Note that for any $B_{j}$, similar sets $S_{B_{j}}, I_{B_{j}}$ and $Q_{B_{j}}$ can be defined, with analogues of the above bounds. In particular, $\left|I_{B_{j}}\right| \geq\left|V\left(B_{j}\right)\right|+\left|S_{B_{j}}\right|-\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F)$.

By Lemma $2.6(i v)$, for $1 \leq i \leq r$, any vertex $u \in I_{R_{i}}$ satisfies that $\operatorname{deg}_{F_{1}}(u) \leq \frac{1}{2}\left(\frac{1}{3}-\right.$ $3 \sqrt{\delta}) v(F)$. Similarly, for $1 \leq j \leq b$, any vertex $u \in I_{B_{j}}$ satisfies that $\operatorname{deg}_{F_{2}}(u) \leq \frac{1}{2}\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F)$.

Note that for $1 \leq i \leq r$, each vertex in $Q_{R_{i}}$ has at most one neighbor in $I_{R_{i}}$ in $F_{1}$ by Lemma 2.6 (iii). Hence, any vertex $u \in Q_{R_{i}}$ satisfies that $\operatorname{deg}_{F_{1}}(u) \leq\left|\left(Q_{R_{i}} \cup S_{R_{i}}\right) \backslash\{u\}\right|+1$, which is less than $\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F)$ by noting (14). Similarly, for $1 \leq j \leq b$, any vertex $u \in Q_{B_{j}}$ satisfies that $\operatorname{deg}_{F_{2}}(u)<\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F)$.

Proposition 3.2 $I_{R_{i}} \cap\left(I_{B_{j}} \cup Q_{B_{j}}\right)=\emptyset$.
Proof. Indeed, if there is a vertex $u \in I_{R_{i}} \cap\left(I_{B_{j}} \cup Q_{B_{j}}\right)$, then from the above observation,

$$
\operatorname{deg}_{F_{1} \cup F_{2}}(u)=\operatorname{deg}_{F_{1}}(u)+\operatorname{deg}_{F_{2}}(u)<\frac{1}{2}\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F)+\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F)
$$

which is less than $\left(\frac{1}{2}-4 \sqrt{\delta}\right) v(F)$, contradicting (12).
Therefore, for $1 \leq i \leq r$, the set $I_{R_{i}} \subseteq \bigcup_{1 \leq j \leq b} S_{B_{j}}$ due to Proposition 3.2. Since $S_{B_{j}}=\emptyset$ for $j>b^{\prime}$ by Proposition 3.1, we have that $I_{R_{i}} \subseteq \bigcup_{1 \leq j \leq b^{\prime}} S_{B_{j}}$. Similarly, for $1 \leq j \leq b$, $I_{B_{j}} \subseteq \bigcup_{1 \leq i \leq r^{\prime}} S_{R_{i}}$. Consequently, again by Proposition $3.1, I_{R_{i}}=\emptyset$ for $i>r^{\prime}$ and $I_{B_{j}}=\emptyset$ for $j>b^{\prime}$, we obtain that

$$
\begin{equation*}
\sum_{i=1}^{r^{\prime}}\left|I_{R_{i}}\right|=\sum_{i=1}^{r}\left|I_{R_{i}}\right| \leq \sum_{j=1}^{b^{\prime}}\left|S_{B_{j}}\right|, \quad \text { and } \sum_{j=1}^{b^{\prime}}\left|I_{B_{j}}\right| \leq \sum_{i=1}^{r^{\prime}}\left|S_{R_{i}}\right| \tag{16}
\end{equation*}
$$

which together with (15) yield that

$$
\begin{align*}
0 & \geq \sum_{j=1}^{b^{\prime}}\left|I_{B_{j}}\right|-\sum_{i=1}^{r^{\prime}}\left|S_{R_{i}}\right| \\
& \geq \sum_{j=1}^{b^{\prime}}\left(\left|V\left(B_{j}\right)\right|+\left|S_{B_{j}}\right|-\left(\frac{1}{3}-3 \sqrt{\delta}\right) t\right)-\sum_{i=1}^{r^{\prime}}\left|S_{R_{i}}\right| \\
& \stackrel{(16)}{\geq} \sum_{j=1}^{b^{\prime}}\left(\left|V\left(B_{j}\right)\right|-\left(\frac{1}{3}-3 \sqrt{\delta}\right) t\right)+\sum_{i=1}^{r^{\prime}}\left|I_{R_{i}}\right|-\sum_{i=1}^{r^{\prime}}\left|S_{R_{i}}\right| \\
& \stackrel{(15)}{>} \sum_{j=1}^{b^{\prime}}\left(\left|V\left(B_{j}\right)\right|-\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F)\right)+\sum_{i=1}^{r^{\prime}}\left(\left|V\left(R_{i}\right)\right|-\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F)\right) \tag{17}
\end{align*}
$$

which implies that $r^{\prime}=b^{\prime}=0$ since $\left|V\left(R_{i}\right)\right| \geq\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F)$ and $\left|V\left(B_{j}\right)\right| \geq\left(\frac{1}{3}-3 \sqrt{\delta}\right) v(F)$ for $1 \leq i \leq r^{\prime}$ and $1 \leq j \leq b^{\prime}$. This completes Claim 3.8.

By noting Claim 3.4 and $A \cup B \cup X=V\left(H_{3}\right)=V(H)$ and $F \subseteq H$, we obtain that

$$
\begin{aligned}
|(A \cup B) \cap V(F)| & \geq|V(F)|-|X|>v(F)-\left(\frac{1}{3}-\frac{1}{5} \eta\right) t \stackrel{(9)}{>} v(F)-\frac{\frac{1}{3}-\frac{1}{5} \eta}{1-\frac{3}{2} \sqrt{\delta}} v(F) \\
& \stackrel{(2)}{>} v(F)-\frac{1}{3}(1-\sqrt{\delta} / 2) v(F)=\left(\frac{2}{3}+\frac{1}{6} \sqrt{\delta}\right) v(F)
\end{aligned}
$$

Thus, one of $|A \cap V(F)|$ and $|B \cap V(F)|$ must be at least $\left(\frac{1}{3}+\frac{1}{12} \sqrt{\delta}\right) v(F)$. Without loss of generality, we suppose that $B^{\prime} \subseteq B \cap V(F)$ satisfies

$$
\begin{equation*}
\left|B^{\prime}\right|=\left(\frac{1}{3}+\frac{1}{12} \sqrt{\delta}\right) v(F) \tag{18}
\end{equation*}
$$

Note that $e\left(H\left[B^{\prime}\right]\right) \geq\binom{\left|B^{\prime}\right|}{2}-\epsilon\binom{t}{2}$. Therefore, by deleting at most $\sqrt{\epsilon} t$ vertices from $B^{\prime}$ we obtain a vertex set $B^{\prime \prime} \subseteq B^{\prime}$ such that each vertex of $B^{\prime \prime}$ is adjacent to at least $\left|B^{\prime}\right|-2 \sqrt{\epsilon} t$ in $H\left[B^{\prime \prime}\right]$ from Fact 2.2. We obtain that

$$
\begin{equation*}
\delta\left(H\left[B^{\prime \prime}\right]\right) \geq\left|B^{\prime}\right|-2 \sqrt{\epsilon} t \stackrel{(18),(9)}{>}\left(\frac{1}{3}+\frac{1}{12} \sqrt{\delta}\right) v(F)-\frac{2 \sqrt{\epsilon}}{1-\frac{3}{2} \sqrt{\delta}} v(F) \stackrel{(2)}{\geq} \frac{1}{3} v(F) \tag{19}
\end{equation*}
$$

By noting (18),

$$
\delta\left(H\left[B^{\prime \prime}\right]\right)>\frac{1}{3} v(F)=\frac{\left|B^{\prime}\right|}{1+\sqrt{\delta} / 4} \geq \frac{\left|B^{\prime \prime}\right|}{1+\sqrt{\delta} / 4}>\left(1-\frac{\sqrt{\delta}}{4}\right)\left|B^{\prime \prime}\right|
$$

Note that all edges of $H\left[B^{\prime \prime}\right]$ are colored only with color 1 or 2 since $B^{\prime \prime} \subseteq B$ and $B$ is one of parts of the bipartite graph $H_{3}^{\prime}$. Now we apply Lemma 2.10 to $H\left[B^{\prime \prime}\right]$ to conclude that $H\left[B^{\prime \prime}\right]$ contains a monochromatic component in color 1 or 2 of order larger than $\delta\left(H\left[B^{\prime \prime}\right]\right)$, which is at least $\frac{1}{3} v(F)$ according to (19). Since $H\left[B^{\prime \prime}\right] \subseteq F$, it follows that $F$ contains a monochromatic component in color 1 or 2 of order at least $\frac{1}{3} v(F)$. This contradicts Claim 3.8.

In conclusion, the proof of Theorem 1.1 is complete.
