# On the global behavior of solutions of the Beltrami equations

#### Abstract

In this paper, the estimate for growth of homeomorphic solutions of the Beltrami equation at infinity is obtained, provided that the dilatation quotient has a global finite mean oscillation.

## 1 Introduction

Let $D$ be a domain in the complex plane $\mathbb{C}$, i.e., a connected and open subset of $\mathbb{C}$, and let $\mu: D \rightarrow \mathbb{C}$ be a measurable function with $|\mu(z)|<1$ a.e. (almost everywhere) in $D$. The Beltrami equation is the equation of the form

f_{\bar{z}}=\mu(z) f_{z} \tag{1.1}
\end{equation*}
$$

where $f_{\bar{z}}=\bar{\partial} f=\left(f_{x}+i f_{y}\right) / 2, f_{z}=\partial f=\left(f_{x}-i f_{y}\right) / 2, z=x+i y$, and $f_{x}$ and $f_{y}$ are partial derivatives of $f$ in $x$ and $y$, correspondingly. The function $\mu$ is called the complex coefficient and

K_{\mu}(z)=\frac{1+|\mu(z)|}{1-|\mu(z)|} \tag{1.2}
\end{equation*}

the dilatation quotient for the equation (1.1). The Beltrami equation (1.1) is said to be degenerate if ess $\sup K_{\mu}(z)=\infty$. The existence theorem for homeomorphic $W_{\text {loc }}^{1,1}$ solutions was established to many degenerate Beltrami equations, see, e.g., related references in the recent monographs [3], [10], [7]; cf. also [6], [14] - [18].

Recall that the (conformal) modulus of a family $\Gamma$ of curves $\gamma$ in $\mathbb{C}$ is the quantity

M(\Gamma)=\inf _{\rho \in \operatorname{adm} \Gamma} \int_{\mathbb{C}} \rho^{2}(z) d x d y \tag{1.3}
\end{equation*}

where a Borel function $\rho: \mathbb{C} \rightarrow[0, \infty]$ is admissible for $\Gamma$, write $\rho \in$ $\operatorname{adm} \Gamma$, if

\end{equation*}

where $s$ is a natural parameter of the length on $\gamma$.
Throughout this paper,

& B\left(z_{0}, r\right)=\left\{z \in \mathbb{C}:\left|z-z_{0}\right|<r\right\}, \\
& S\left(z_{0}, r\right)=\left\{z \in \mathbb{C}:\left|z-z_{0}\right|=r\right\},
\end{aligned}
$$

and

\mathbb{A}\left(z_{0}, r_{1}, r_{2}\right)=\left\{z \in \mathbb{C}: r_{1}<\left|z-z_{0}\right|<r_{2}\right\} .
$$

Let $E, F \subset \overline{\mathbb{C}}$ be arbitrary sets. Denote by $\Delta(E, F, D)$ a family of all curves $\gamma:[a, b] \rightarrow \overline{\mathbb{C}}$ joining $E$ and $F$ in $D$, i.e., $\gamma(a) \in E, \gamma(b) \in F$ and $\gamma(t) \in D$ as $t \in(a, b)$.

Here a condenser is a pair $\mathcal{E}=(A, C)$ where $A \subset \mathbb{C}$ is open and $C$ is a non-empty compact set contained in $A$. $\mathcal{E}$ is a ringlike condenser if $B=$ $A \backslash C$ is a ring, i.e., if $B$ is a domain whose complement $\overline{\mathbb{C}} \backslash B$ has exactly two components where $\overline{\mathbb{C}}=\mathbb{C} \cup\{\infty\}$ is the one-point compactification of $\mathbb{C}$. $\mathcal{E}$ is a bounded condenser if $A$ is bounded. A condenser $\mathcal{E}=(A, C)$ is said to be in a domain $G$ if $A \subset G$.

The following lemma is immediate.
Lemma 1. If $f: G \rightarrow \mathbb{C}$ is open and $\mathcal{E}=(A, C)$ is a condenser in $G$, then $(f A, f C)$ is a condenser in $f G$.

In the above situation we denote $f \mathcal{E}=(f A, f C)$.
Let $\mathcal{E}=(A, C)$ be a condenser. We set

\operatorname{cap} \mathcal{E}=\operatorname{cap}(A, C)=\inf _{u \in W_{0}(\mathcal{E})} \int_{A}|\nabla u|^{2} d x d y
$$

and call it the capacity of the condenser $\mathcal{E}$. The set $W_{0}(\mathcal{E})=W_{0}(A, C)$ is the family of nonnegative functions $u: A \rightarrow \mathbb{R}$ such that $u \in C_{0}(A)$, $u(z) \geqslant 1$ for $z \in C$, and $u$ is absolutely continuous on lines (ACL). In the above formula

|\nabla u|=\sqrt{\left(\frac{\partial u}{\partial x}\right)^{2}+\left(\frac{\partial u}{\partial y}\right)^{2}}
$$

We mention some properties of the capacity of a condenser. It was proven in ([20], Theorem 1) that

\operatorname{cap} \mathcal{E}=M(\Delta(\partial A, \partial C ; A \backslash C)), \tag{1.5}
\end{equation*}
$$

where $\Delta(\partial A, \partial C ; A \backslash C)$ denotes the set of all continuous curves joining the boundaries $\partial A$ and $\partial C$ in $A \backslash C$.

Moreover, the following estimate is known:

\operatorname{cap} \mathcal{E} \geqslant \frac{4 \pi}{\log \frac{m(A)}{m(C)}} \tag{1.6}
\end{equation*}
$$

(see, e.g., (8.8) in [11]).
The following notion is motivated by the ring definition of Gehring for quasiconformal mappings, see, e.g., [5], introduced first in the plane, see [17], and extended later on to the space case in [13], see also Chapters 7 and 11 in [10], cf. [1], [2], [4], [12].

Given a domain $D$ in $\mathbb{C}$, a (Lebesgue) measurable function $Q: D \rightarrow$ $[0, \infty], z_{0} \in D$, a homeomorphism $f: D \rightarrow \overline{\mathbb{C}}$ is said to be a ring $Q^{-}$ homeomorphism at the point $z_{0}$ if

M\left(f\left(\Delta\left(S_{1}, S_{2}, \mathbb{A}\left(z_{0}, r_{1}, r_{2}\right)\right)\right)\right) \leqslant \int_{\mathbb{A}\left(z_{0}, r_{1}, r_{2}\right)} Q(z) \cdot \eta^{2}\left(\left|z-z_{0}\right|\right) d x d y \tag{1.7}
\end{equation*}
$$

for every ring $\mathbb{A}\left(z_{0}, r_{1}, r_{2}\right)$ and the circles $S_{i}=S\left(z_{0}, r_{i}\right), i=1,2$, where $0<r_{1}<r_{2}<r_{0}:=\operatorname{dist}\left(z_{0}, \partial D\right)$, and every measurable function $\eta:\left(r_{1}, r_{2}\right) \rightarrow[0, \infty]$ such that

\int_{r_{1}}^{r_{2}} \eta(r) d r=1
$$

$f$ is called a ring $Q$-homeomorphism in the domain $D$ if $f$ is a ring $Q$-homeomorphism at every point $z_{0} \in D$.

The following statement was first proved in [9], Theorem 3.1, cf. also Corollory 3.1 in [19].

Proposition 1. Let $f$ be a homeomorphic $W_{\text {loc }}^{1,1}$ solution of the Beltrami equation (1.1). Then $f$ is a ring $Q$-homeomorphism at each point $z_{0} \in D$ with $Q(z)=K_{\mu}(z)$.

## 2 GFMO functions

Similarly to [8] (cf. also [14], [16]), we say that a function $\varphi: \mathbb{C} \rightarrow \mathbb{R}$ has global finite mean oscillation at a point $z_{0} \in \mathbb{C}$, abbr. $\varphi \in \operatorname{GFMO}\left(z_{0}\right)$, if

\begin{equation*}
\limsup _{R \rightarrow \infty} \frac{1}{m\left(B\left(z_{0}, R\right)\right)} \int_{B\left(z_{0}, R\right)}\left|\varphi(z)-\bar{\varphi}_{R}\right| d x d y<\infty, \tag{2.1}
\end{equation*}
$$

where

$$
\bar{\varphi}_{R}=\frac{1}{m\left(B\left(z_{0}, R\right)\right)} \int_{B\left(z_{0}, R\right)} \varphi(z) d x d y
$$

is the mean value of the function $\varphi(z)$ over $B\left(z_{0}, R\right), R>0$. Here $B\left(z_{0}, R\right)=\left\{z \in \mathbb{C}:\left|z-z_{0}\right|<R\right\}$, and condition (2.1) includes the assumption that $\varphi$ is integrable in $B\left(z_{0}, R\right)$ for $R>0$.

Proposition 2. If, for some collection of numbers $\varphi_{R} \in \mathbb{R}, R \in$ $\left[r_{0},+\infty\right), r_{0}>0$,

\limsup _{R \rightarrow \infty} \frac{1}{m\left(B\left(z_{0}, R\right)\right)} \int_{B\left(z_{0}, R\right)}\left|\varphi(z)-\varphi_{R}\right| d x d y<\infty,
$$

then $\varphi$ has global finite mean oscillation at $z_{0}$.
Proof. Indeed, by the triangle inequality,

$$
\begin{gathered}
\frac{1}{m\left(B\left(z_{0}, R\right)\right)} \int_{B\left(z_{0}, R\right)}\left|\varphi(z)-\bar{\varphi}_{R}\right| d x d y \leqslant \\
\leqslant \frac{1}{m\left(B\left(z_{0}, R\right)\right)} \int_{B\left(z_{0}, R\right)}\left|\varphi(z)-\varphi_{R}\right| d x d y+\left|\varphi_{R}-\bar{\varphi}_{R}\right| \leqslant \\
\leqslant \frac{2}{m\left(B\left(z_{0}, R\right)\right)} \int_{B\left(z_{0}, R\right)}\left|\varphi(z)-\varphi_{R}\right| d x d y .
\end{gathered}
$$

Corollary 1. If, for a point $z_{0} \in \mathbb{C}$,

$$
\limsup _{R \rightarrow \infty} \frac{1}{m\left(B\left(z_{0}, R\right)\right)} \int_{B\left(z_{0}, R\right)}\left|\varphi(z)-\varphi\left(z_{0}\right)\right| d x d y<\infty,
$$

then $\varphi$ has global finite mean oscillation at $z_{0}$.

Corollary 2. If, for a point $z_{0} \in \mathbb{C}$,

$$
\limsup _{R \rightarrow \infty} \frac{1}{m\left(B\left(z_{0}, R\right)\right)} \int_{B\left(z_{0}, R\right)}|\varphi(z)| d x d y<\infty,
$$

then $\varphi$ has global finite mean oscillation at $z_{0}$.
Lemma 2. Let $z_{0} \in \mathbb{C}$. If a nonnegative function $\varphi: \mathbb{C} \rightarrow \mathbb{R}$ has global finite mean oscillation at $z_{0}$ and $\varphi$ is integrable in $B\left(z_{0}, e\right)$, then, for $R>e^{e}$,

\int_{\mathbb{A}\left(z_{0}, e, R\right)} \frac{\varphi(z) d x d y}{\left(\left|z-z_{0}\right| \log \left|z-z_{0}\right|\right)^{2}} \leqslant C \cdot \log \log R,
$$

where

$$
C=\frac{\pi}{6}\left(\left(24+\pi^{2}\right) e^{2} \delta_{\infty}+2 \pi^{2} \varphi_{0}\right),
$$

$\varphi_{0}$ is the mean value of $\varphi$ over the disk $B\left(z_{0}, e\right)$ and

$$
\delta_{\infty}=\delta_{\infty}(\varphi)=\sup _{R \in\left(e^{e},+\infty\right)} \frac{1}{m\left(B\left(z_{0}, R\right)\right)} \int_{B\left(z_{0}, R\right)}\left|\varphi(z)-\bar{\varphi}_{R}\right| d x d y
$$

is the maximal dispersion of $\varphi$.
Proof. Let $R>e^{e}, r_{k}=e^{k}, \mathbb{A}_{k}=\left\{z \in \mathbb{C}: r_{k} \leqslant\left|z-z_{0}\right|<r_{k+1}\right\}$. Clearly,

$$
\delta_{\infty}=\sup _{R \in\left(e^{e},+\infty\right)} \frac{1}{m\left(B\left(z_{0}, R\right)\right)} \int_{B\left(z_{0}, R\right)}\left|\varphi(z)-\bar{\varphi}_{R}\right| d x d y<\infty,
$$

$B_{k}=B\left(z_{0}, r_{k}\right)$ and let $\varphi_{k}$ be the mean value of $\varphi(z)$ over $B_{k}, k=1,2, \ldots$. Take a natural number $N$ such that $R \in\left[r_{N}, r_{N+1}\right)$.

Then $\mathbb{A}\left(z_{0}, e, R\right) \subset \Delta(R)=\bigcup_{k=1}^{N} \mathbb{A}_{k}$ and

$$
\begin{gathered}
I(R)=\int_{\Delta(R)} \varphi(z) \alpha\left(\left|z-z_{0}\right|\right) d x d y \leqslant\left|S_{1}(R)\right|+S_{2}(R) \\
\alpha(t)=\frac{1}{(t \log t)^{2}} \\
S_{1}(R)=\sum_{k=1}^{N} \int_{\mathbb{A}_{k}}\left(\varphi(z)-\varphi_{k+1}\right) \alpha\left(\left|z-z_{0}\right|\right) d x d y
\end{gathered}
$$

and

$$
S_{2}(R)=\sum_{k=1}^{N} \varphi_{k+1} \int_{\mathbb{A}_{k}} \alpha\left(\left|z-z_{0}\right|\right) d x d y
$$

Since $\mathbb{A}_{k} \subset B_{k+1}, \frac{1}{\left|z-z_{0}\right|^{2}} \leqslant \frac{\pi e^{2}}{m\left(B_{k+1}\right)}$ for $z \in \mathbb{A}_{k}$ and $\log \left|z-z_{0}\right|>k$ in $\mathbb{A}_{k}$, then

\begin{aligned}
\left|S_{1}(R)\right| & \leqslant \pi e^{2} \sum_{k=1}^{N} \frac{1}{k^{2}} \cdot \frac{1}{m\left(B_{k+1}\right)} \int_{B_{k+1}}\left|\varphi(z)-\varphi_{k+1}\right| d x d y \leqslant \\
& \leqslant \pi e^{2} \delta_{\infty} \sum_{k=1}^{N} \frac{1}{k^{2}} \leqslant \pi e^{2} \delta_{\infty} \sum_{k=1}^{\infty} \frac{1}{k^{2}}=\frac{\pi^{3} e^{2} \delta_{\infty}}{6} .
\end{aligned}
$$

Now,

$$
\int_{\mathbb{A}_{k}} \alpha\left(\left|z-z_{0}\right|\right) d x d y \leqslant \frac{1}{k^{2}} \int_{\mathbb{A}_{k}} \frac{d x d y}{\left|z-z_{0}\right|^{2}}=\frac{2 \pi}{k^{2}} .
$$

Moreover,

$$
\begin{aligned}
& \left|\varphi_{k-1}-\varphi_{k}\right|=\left|\frac{1}{m\left(B_{k-1}\right)} \int_{B_{k-1}} \varphi(z) d x d y-\frac{1}{m\left(B_{k-1}\right)} \int_{B_{k-1}} \varphi_{k} d x d y\right| \leqslant \\
& \leqslant \frac{1}{m\left(B_{k-1}\right)} \int_{B_{k-1}}\left|\varphi(z)-\varphi_{k}\right| d x d y \leqslant \frac{e^{2}}{m\left(B_{k}\right)} \int_{B_{k}}\left|\varphi(z)-\varphi_{k}\right| d x d y \leqslant e^{2} \delta_{\infty},
\end{aligned}
$$

and by the triangle inequality, for $k \geqslant 1$

$$
\begin{aligned}
& \varphi_{k+1}=\left|\varphi_{k+1}\right|=\left|\varphi_{1}+\sum_{l=2}^{k+1}\left(\varphi_{l}-\varphi_{l-1}\right)\right| \leqslant \\
& \leqslant\left|\varphi_{1}\right|+\sum_{l=2}^{k+1}\left|\varphi_{l}-\varphi_{l-1}\right| \leqslant\left|\varphi_{1}\right|+e^{2} \delta_{\infty} k .
\end{aligned}
$$

Hence,

$$
\begin{gathered}
S_{2}(R)=\left|S_{2}(R)\right| \leqslant 2 \pi \sum_{k=1}^{N} \frac{\varphi_{k+1}}{k^{2}} \leqslant 2 \pi \sum_{k=1}^{N} \frac{\varphi_{1}+e^{2} \delta_{\infty} k}{k^{2}} \leqslant \\
\leqslant 2 \pi \varphi_{1} \sum_{k=1}^{\infty} \frac{1}{k^{2}}+2 \pi e^{2} \delta_{\infty} \sum_{k=1}^{N} \frac{1}{k}=
\end{gathered}
$$

$$
=\frac{\pi^{3} \varphi_{1}}{3}+2 \pi e^{2} \delta_{\infty} \sum_{k=1}^{N} \frac{1}{k} .
$$

But

$$
\sum_{k=2}^{N} \frac{1}{k}<\int_{1}^{N} \frac{d t}{t}=\log N
$$

and, for $R>r_{N}$,

$$
N=\log r_{N}<\log R
$$

Consequently,

$$
\sum_{k=1}^{N} \frac{1}{k}<1+\log \log R
$$

and thus, for $R \in\left(e^{e},+\infty\right)$

$$
\begin{gathered}
I(R) \leqslant \frac{\pi^{3} e^{2} \delta_{\infty}}{6}+\frac{\pi^{3} \varphi_{1}}{3}+2 \pi e^{2} \delta_{0}(1+\log \log R)= \\
=\left(\frac{\pi^{3} e^{2} \delta_{\infty}+12 \pi e^{2} \delta_{\infty}+2 \pi^{3} \varphi_{1}}{6 \log \log R}+2 \pi e^{2} \delta_{\infty}\right) \log \log R \leqslant \\
\leqslant \frac{\pi}{6}\left(\left(24+\pi^{2}\right) e^{2} \delta_{\infty}+2 \pi^{2} \varphi_{1}\right) \log \log R
\end{gathered}
$$

Finally,

$$
\begin{aligned}
& \int_{\mathbb{A}\left(z_{0}, e, R\right)} \frac{\varphi(z) d x d y}{\left(\left|z-z_{0}\right| \log \left|z-z_{0}\right|\right)^{2}} \leqslant I(R) \leqslant \\
& \leqslant \frac{\pi}{6}\left(\left(24+\pi^{2}\right) e^{2} \delta_{\infty}+2 \pi^{2} \varphi_{1}\right) \log \log R
\end{aligned}
$$

## 3 The behavior of homeomorphic solutions of the Beltrami equations at infinity

Set

$$
\begin{gathered}
l_{f}\left(z_{0}, e\right)=\min _{\left|z-z_{0}\right|=e}\left|f(z)-f\left(z_{0}\right)\right| \\
\delta_{\infty}=\delta_{\infty}\left(K_{\mu}, z_{0}\right)= \\
=\sup _{R \in\left(e^{e},+\infty\right)} \frac{1}{m\left(B\left(z_{0}, R\right)\right)} \int_{B\left(z_{0}, R\right)}\left|K_{\mu}(z)-K_{\mu, z_{0}}(R)\right| d x d y \\
K_{\mu, z_{0}}(R)=\frac{1}{m\left(B\left(z_{0}, R\right)\right)} \int_{B\left(z_{0}, R\right)} K_{\mu}(z) d x d y, \quad k_{0}=K_{\mu, z_{0}}(e)
\end{gathered}
$$

Theorem 1. Let $\mu: \mathbb{C} \rightarrow \mathbb{C}$ be a measurable function with $|\mu(z)|<1$ a.e. and $f: \mathbb{C} \rightarrow \mathbb{C}$ be a homeomorphic $W_{\mathrm{loc}}^{1,1}$ solution of the Beltrami equation (1.1). If $K_{\mu} \in \operatorname{GFMO}\left(z_{0}\right), z_{0} \in \mathbb{C}$, then

$$
\begin{equation*}
\liminf _{R \rightarrow \infty} \frac{\max _{\left|z-z_{0}\right|=R}\left|f(z)-f\left(z_{0}\right)\right|}{(\log R)^{\frac{2 \pi}{C}}} \geqslant l_{f}\left(z_{0}, e\right) \tag{3.1}
\end{equation*}
$$

where $C=\frac{\pi}{6}\left(\left(24+\pi^{2}\right) e^{2} \delta_{\infty}+2 \pi^{2} k_{0}\right)$.
Proof. Consider the ring $\mathbb{A}(R)=\mathbb{A}\left(z_{0}, e, R\right)$, with $R>e^{e}$. Set $\mathcal{E}=$ $\left(B\left(z_{0}, R\right), \overline{B\left(z_{0}, e\right)}\right)$. Then, by lemma $1 f \mathcal{E}=\left(f B\left(z_{0}, R\right), f \overline{B\left(z_{0}, e\right)}\right)$ is a condenser in $\mathbb{C}$, according (1.5),

\operatorname{cap}\left(f B\left(z_{0}, R\right), f \overline{B\left(z_{0}, e\right)}\right)=M\left(\Delta\left(\partial f B\left(z_{0}, e\right), \partial f B\left(z_{0}, R\right) ; f \mathbb{A}(R)\right)\right)
$$

and, in view of the homeomorphism of $f$,

$$
\Delta\left(\partial f B\left(z_{0}, e\right), \partial f B\left(z_{0}, R\right) ; f \mathbb{A}(R)\right)=f \Delta\left(\partial B\left(z_{0}, e\right), \partial B\left(z_{0}, R\right) ; \mathbb{A}(R)\right)
$$

By Proposition $1 f$ is a ring $Q$-homeomorphism with $Q=K_{\mu}(z)$

$$
\begin{equation*}
\operatorname{cap}\left(f B\left(z_{0}, R\right), f \overline{B\left(z_{0}, e\right)}\right) \leqslant \int_{\mathbb{A}(R)} K_{\mu}(z) \eta^{2}\left(\left|z-z_{0}\right|\right) d x d y \tag{3.2}
\end{equation*}
$$

for every measurable function $\eta:(e, R) \rightarrow[0,+\infty]$ such that

$$
\int_{e}^{R} \eta(t) d t=1
$$

Choosing in (3.2) $\eta(t)=\frac{1}{t \log t \cdot \log \log R}$, we obtain

$$
\operatorname{cap}\left(f B\left(z_{0}, R\right), f \overline{B\left(z_{0}, e\right)}\right) \leqslant \frac{1}{(\log \log R)^{2}} \cdot \int_{\mathbb{A}(R)} \frac{K_{\mu}(z) d x d y}{\left(\left|z-z_{0}\right| \log \left|z-z_{0}\right|\right)^{2}}
$$

Since $K_{\mu} \in G F M O\left(z_{0}\right)$, then by lemma 2

$$
\begin{equation*}
\operatorname{cap}\left(f B\left(z_{0}, R\right), f \overline{B\left(z_{0}, e\right)}\right) \leqslant \frac{C}{\log \log R} \tag{3.3}
\end{equation*}
$$

where $C=\frac{\pi}{6}\left(\left(24+\pi^{2}\right) e^{2} \delta_{\infty}+2 \pi^{2} k_{0}\right)$. On the other hand, by (1.6), we have

\begin{equation*}
\operatorname{cap}\left(f B\left(z_{0}, R\right), f \overline{B\left(z_{0}, e\right)}\right) \geqslant \frac{4 \pi}{\log \frac{m\left(f B\left(z_{0}, R\right)\right)}{m\left(f \overline{B\left(z_{0}, e\right)}\right)}} \tag{3.4}
\end{equation*}
$$

Combining (3.3) and (3.4), we obtain

$$
\frac{4 \pi}{\log \frac{m\left(f B\left(z_{0}, R\right)\right)}{m\left(f \overline{B\left(z_{0}, e\right)}\right)}} \leqslant \frac{C}{\log \log R}
$$

This gives

$$
m\left(\overline{B\left(z_{0}, e\right)}\right) \leqslant \frac{m\left(f B\left(z_{0}, R\right)\right)}{(\log R)^{\frac{4 \pi}{C}}}
$$

Using the inequalities

$$
\begin{aligned}
& \pi\left(\min _{\left|z-z_{0}\right|=e}\left|f(z)-f\left(z_{0}\right)\right|\right)^{2} \leqslant m\left(f \overline{B\left(z_{0}, e\right)}\right) \leqslant \\
& \leqslant m\left(f B\left(z_{0}, R\right)\right) \leqslant \pi\left(\max _{\left|z-z_{0}\right|=R}\left|f(z)-f\left(z_{0}\right)\right|\right)^{2}
\end{aligned}
$$

we obtain

$$
\begin{equation*}
\min _{\left|z-z_{0}\right|=e}\left|f(z)-f\left(z_{0}\right)\right| \leqslant \frac{\max _{\left|z-z_{0}\right|=R}\left|f(z)-f\left(z_{0}\right)\right|}{(\log R)^{\frac{2 \pi}{C}}} \tag{3.5}
\end{equation*}
$$

Set

$$
l_{f}\left(z_{0}, e\right)=\min _{\left|z-z_{0}\right|=e}\left|f(z)-f\left(z_{0}\right)\right| .
$$

Passing to the lower limit as $R \rightarrow \infty$ in (3.5), we obtain relation (3.1).
