# DUALITY FOR $p$-ADIC ÉTALE TATE TWISTS WITH MODULUS 

KENTO YAMAMOTO


#### Abstract

In this paper, we define $p$-adic étale Tate twists for a modulus pair $(X, D)$, where $X$ is a regular semi-stable family and $D$ is an effective Cartier divisor on $X$ which is flat over a base scheme. The main result of this paper is an arithmetic duality of $p$-adic étale Tate twists for proper modulus pairs $(X, D)$, which holds as a pro-system with respect to the multiplicities of the irreducible components of $D$.

## 1. Introduction

Let $p$ be a prime number. Let $K$ be a $p$-adic field and let $\mathscr{O}_{K}$ be its valuation ring with $k$ the residue filed. In recent years, theory of motives and the (higher) Chow group has been studied for a modulus pair $(X, D)$ (KMSYI], KMSYII], [KMSYIII], [BS], and [RS] etc.). One of the important question with respect to the

[^0]theory of motives with modulus is $p$-adic realization of it. In [Sat2] Conjecture 1.4.1 and [Sat3] Remark 7.2 imply that $p$-adic étale Tate twists have a deeply relation with motivic complexes.

In this paper, we introduce $p$-adic étale Tate twists $\mathfrak{T}_{n}(r)_{X \mid D}$ for a modulus pair $(X, D)$, where $X$ is a regular semi-stable family over $\mathscr{O}_{K}$ and $D$ is an effective Cartier divisor on $X$ (we assume that $D$ is flat over $\mathscr{O}_{K}$ ). The object $\mathfrak{T}_{n}(r)_{X \mid D}$ is a generalization of $p$-adic étale Tate twists (cf. [Sch], Sat2]). We prove arithmetic duality of $\mathfrak{T}_{n}(r)_{X \mid D}$ for proper modulus pairs $(X, D)$, where $X$ is a regular semi-stable family and proper over $\mathscr{O}_{K}$.

We proved the following result in this paper:
Theorem 1.1. Let $r \leq p-2$ and $\zeta_{p} \in K$. We put $Y^{0}$ a set of generic points of $Y$. We assume that $X$ is a semi-stable family and proper over $\mathscr{O}_{K}$ and $|D| \cap Y^{0}=\emptyset$. The pairing
is a non-degenerate pairing for any $i \geq 0$ and $n \geq 0$.
When $D=\emptyset$ in Theorem[1.1, we have Theorem 1.2.2 in [Sat2]. Here $\mathfrak{T}_{n}(d-r)_{U}$ is $p$-adic étale Tate twists, which is defined in [Sat2]. We prove Theorem 1.1 along the strategy of Theorem 1.2 .2 in [Sat2]. The key idea of the construction of pairing in Theorem 1.1 is a Milne's pairing (a pairing of two-term complexes) in [Mil2], p. 175 or [Mil1], p.217. This construction idea is also applied to the proof of Theorem4.1.4 in JSZ]. We construct the pairing in Theorem 1.1 by extending Milne's pairing to a pairing of multiple-term complexes. We introduce some logarithmic Hodge-Witt type sheaves for modulus pairs $(X, D)$ to show Theorem 1.1 and show its duality property.

An application of Theorem 1.1, we have the following Corollary (Take $i=2 d$ and $r=d$ in Theorem 1.1):
Corollaly 1.2. (cf. JSZ]) Under the same assumption of Theorem 1.1, we obtain a natural isomorphism

Here $\pi_{1}^{a b}(U)$ is the abelianized fundamental group of $U$.

## Notation and Conventions.

(i) Let $K$ be a $p$-adic field, $\mathscr{O}_{K}$ denotes the integer ring of $K$, and $\pi_{K}$ denotes the prime element of $\mathscr{O}_{K}$. We denote $k$ the residue field of $\mathscr{O}_{K}$ which is a perfect field of characteristic $p$.
(ii) Let $p$ be a prime number, and let $\zeta_{p}$ be a primitive $p$-the roots of unity.
(iii) Unless indicated otherwise, all cohomology groups of schemes are taken over the étale topology. For a scheme $X$ and an integer $n \geq 2, D\left(X_{\text {ét }}, \mathbb{Z} / n\right)$ (resp. $\left.D^{b}\left(X_{\text {ét }}, \mathbb{Z} / n\right)\right)$ denotes the derived category of (resp. bounded) complexes of étale $\mathbb{Z} / n$-sheaves on $X_{\text {ét }}$.
(iv) Throughout this paper, we assume that a scheme $X$ is always separated over $\mathscr{O}_{K}$.
(v) Let $p$ be a prime number. For a scheme $X$, we put $X_{n}:=X \otimes \mathbb{Z} / p^{n} \mathbb{Z}$.
(vi) Let $k$ be a field, and let $X$ be a pure-dimensional scheme which is of finite type over $\operatorname{Spec}(k)$. We call $X$ a normal crossing scheme over $\operatorname{Spec}(k)$, if it is evrywhere étale locally isomorphic to

for some integer $a$ with $0 \leq a \leq N:=\operatorname{dim}(X)$.
(vii) Let $X$ be a pure-dimensional scheme which is flat of finite type over $\operatorname{Spec}\left(\mathscr{O}_{K}\right)$. We call X be a regular semistable family over $\operatorname{Spec}\left(\mathscr{O}_{K}\right)$, if it is regular and evrywhere étale locally isomorphic to

for some $a$ such that $0 \leq a \leq d:=\operatorname{dim}\left(X / \mathscr{O}_{K}\right)$.
(viii) For a positive integer $n$ invertible on a scheme $X, \mu_{n}$ denotes the étale sheaf of $n$-th roots of unity.

We assume the following situation ( $\boldsymbol{\rho}$ ) :

- Let $X$ be a regular semistable family over $\operatorname{Spec}\left(\mathscr{O}_{K}\right)$. We denote $Y:=X \otimes_{\mathscr{O}_{K}} k$ and $X_{K}:=X \otimes_{\mathscr{O}_{K}} K$. Let $D \subset X$ be an effective Cartier divisor on $X$ which is flat over $\operatorname{Spec}\left(\mathscr{O}_{K}\right)$ and $Y \cup D_{\text {red }}$ has normal crossings on $X$.
- Let $M_{X}$ be a logarithmic structure on $X$ associated with $D_{\text {red }} \cup Y$. Let $M_{D}$ be a logarithmic structure on $D$ induced by the inverse image of $M_{X}$. For $n \geq 1$, we write $M_{X_{n}}$ for the inverse image of $\log$ structure of $M_{X}$ into $X_{n}$. Let $\left(Y, M_{Y}\right)$ be the reduction of $\bmod \pi$ of $\left(X, M_{X}\right)$.
Put $U:=X-D, V:=Y-(Y \cap D), U_{K}:=X-(Y \cup D)$, and $V_{X}:=X-Y$, and we consider a diagram of immersions.



### 1.1. Logarithmic Hodge-Witt type sheaves ([Sat1], Sat2], (Sat3]).

Throughout this subsection, $n$ denotes a non-negative integer and $r$ denotes a positive integer. Let $k$ be a perfect field of positive characteristic $p$. Let $X$ be a pure-dimensional scheme of finite type over $\operatorname{Spec}(k)$. We define the étale sheaves $\nu_{X, r}^{n}$ and $\lambda_{X, r}^{n}$ on $X$ as follows:

\lambda_{X, r}^{n}:=\operatorname{Im}\left(\left(\mathbb{G}_{m, X}\right)^{\otimes n} \xrightarrow{\text { dlog }} \bigoplus_{x \in X^{0}} i_{x *} W_{r} \Omega_{x, \log }^{n}\right) \tag{1.2}
\end{equation*}

where $i_{x}$ denote the canonical map $x \hookrightarrow X$ for a point $x \in X$ and $\partial^{\text {val }}$ denote the sum of $\partial^{\mathrm{val}}{ }_{y, x}$ 's with $y \in X^{0}$ and $x \in X^{1}$ (see [Sat2], §1.8). Here $W_{r} \Omega_{X, \log }^{n}$ denotes the étale subsheaf of $W_{r} \Omega_{X}^{n}$, which defined in [B] and [I] for a smooth variety over $\operatorname{Spec}(K)$. It is obvious that $\lambda_{X, r}^{n}$ is a subsheaf of $\nu_{X, r}^{n}$. If $X$ is smooth then both $\nu_{X, r}^{n}$ and $\lambda_{X, r}^{n}$ agree with the sheaf $W_{r} \Omega_{X, \text { log. We next review }}^{n}$ the duality result in Sat1]. For integers $m, n \geq 0$, there is a natural pairing of sheaves

(see loc. cit.,3.1.1).
Theorem 1.3. (Duality, loc. cit., 1.2.2). Let $k$ be a finite field, and let $X$ be a normal crossing scheme of dimension $N$ which is proper over $\operatorname{Spec}(k)$. Then for integers $q$ and $n$ with $0 \leq n \leq N$, the natural mapping

H^{q}\left(X, \nu_{X, r}^{n}\right) \times H^{N+1-q}\left(X, \lambda_{X, r}^{N-n}\right) \longrightarrow H^{N+1}\left(X, \nu_{X, r}^{n}\right) \xrightarrow{\operatorname{tr}_{X}} \mathbb{Z} / p^{r} \mathbb{Z} \tag{1.4}
\end{equation*}

is non-degenerate pairing of finite $\mathbb{Z} / p^{r} \mathbb{Z}$-modules.
Here trace map $\operatorname{tr}_{X}$ is constructed in [Sat1], Proposition 2.5.9 and Corollary 2.5.11. In [Sat3], Sato have introduced a following two new logarithmic sheaves under the condition "with Cartier divisor $D^{\prime}$ ":
Definition 1.4. (Sat3], §2, Definition 2.1)

& \lambda_{(Y, Y \cap D), n}^{q}:=\operatorname{Im}\left(d \log :\left(\alpha_{*}^{\prime} \mathscr{O}_{V}\right)^{\times} \longrightarrow \bigoplus_{y \in V^{0}} i_{y_{*}} W_{n} \Omega_{x, \log }^{q}\right) . \tag{1.6}

Here $V:=Y-(Y \cap D)$ and $i_{y}: y \rightarrow Y(y \in Y)$ denotes the composite map $y \hookrightarrow V \hookrightarrow Y$.

We will introduce a new logarithmic sheaves as a subsheaf of these sheaves in section below.

Definition 1.5. (p-adic étale Tate twist [Sat2], Definition 4.2.4)
Sato have defined the $p$-adic étale Tate twist $\mathfrak{T}_{n}(r)_{X}$ by the following distinguished triangle:

in $D^{b}\left(X_{e ́ t}, \mathbb{Z} / p^{n} \mathbb{Z}\right)$.
The $p$-adic étale Tate twist $\mathfrak{T}_{n}(r)_{X}$ has some good properties (trivialization, acyclicity, purity, compatibility, product structure, etc.). See [Sat2] for the details of properties of $p$-adic étale Tate twist.
2. $p$-adic étale Tate twists with modulus

We assume that $0 \leq r \leq p-2$ and $X$ is in the setting (\%). The aim of this section is to construct $p$-adic étale Tate twists with modulus $\mathfrak{T}_{n}(r)_{X \mid D} \in$ $D^{b}\left(Y_{\text {ét }}, \mathbb{Z} / p^{n} \mathbb{Z}\right)$. We first review the definition of the syntomic complexes with modulus $s_{n}(r)_{X \mid D} \in D^{b}\left(Y_{\text {ét }}, \mathbb{Z} / p^{n} \mathbb{Z}\right)$, which is constructed in $[\mathrm{Y}]$. To define the syntomic complex with modulus in local situation, we assume the existence of the following four datas:

## Assumption 2.1. - There exists exact closed immersions

$\beta_{n}:\left(X_{n}, M_{X_{n}}\right) \hookrightarrow\left(Z_{n}, M_{Z_{n}}\right)$ and $\beta_{n, D}:\left(D_{n}, M_{D_{n}}\right) \hookrightarrow\left(\mathscr{D}_{n}, M_{\mathscr{D}_{n}}\right)$
of log schemes for $n \geq 1$ such that $\left(Z_{n}, M_{Z_{n}}\right)$ and $\left(\mathscr{D}_{n}, M_{\mathscr{D}_{n}}\right)$ are smooth over $W:=W(k)$, and such that the following diagram is cartesian :


- There exist a compatible system of liftings of Frobenius endomorphisms $\left\{F_{Z_{n}}\right.$ : $\left.\left(Z_{n}, M_{Z_{n}}\right) \rightarrow\left(Z_{n}, M_{Z_{n}}\right)\right\}$ and $\left\{F_{\mathscr{D}_{n}}:\left(\mathscr{D}_{n}, M_{\mathscr{D}_{n}}\right) \rightarrow\left(\mathscr{D}_{n}, M_{\mathscr{D}_{n}}\right)\right\}$ for each $n \in \mathbb{N}([$ Tsu1 $, ~ p .71, ~(2.1 .1)-(2.1 .3)])$.
- The systems $\left\{F_{Z_{n}}:\left(Z_{n}, M_{Z_{n}}\right) \rightarrow\left(Z_{n}, M_{Z_{n}}\right)\right\}$ and $\left\{F_{\mathscr{D}_{n}}:\left(\mathscr{D}_{n}, M_{\mathscr{D}_{n}}\right) \rightarrow\right.$ $\left.\left(\mathscr{D}_{n}, M_{\mathscr{D}_{n}}\right)\right\}$ fit into the following commutative diagram for for each $n \in \mathbb{N}$ :

- $\mathscr{D}_{n}$ is an effective Cartier divisor on $Z_{n}$ such that $\beta_{D, n}^{*} \mathscr{D}_{n}=D_{n}$ and $F_{Z_{n}}$ which induces a morphism $\mathscr{D}_{n} \longrightarrow \mathscr{D}_{n}$.

In [Y], the following complex was defined for a modulus pair $(X, D)$ :
Definition 2.2. (Definition2.11, $[\mathrm{Y}]$ syntomic complex with modulus)
We assume $r \leq p-1$. We define
$s_{n}(r)_{X \mid D,\left(Z_{n}, M_{Z_{n}}\right),\left(\mathscr{D}_{n}, M_{\mathscr{D}_{n}}\right)}:=\operatorname{Cone}\left(1-\varphi_{r}: J_{\mathscr{E}_{n}}^{[r-\cdot]^{Q_{\mathscr{O}_{n}}}} \omega_{Z_{n} \mid \mathscr{D}_{n}} \rightarrow \mathscr{O}_{\mathscr{E}_{n}} \otimes_{\mathscr{O}_{Z_{n}}} \omega_{Z_{n} \mid \mathscr{D}_{n}}\right)[-1]$,
where $\varphi_{r}=\varphi_{r-q} \otimes \wedge^{q} \frac{d \varphi}{p}$ in degree $q$. We denote this complex by $s_{n}(r)_{X \mid D}$ for simplicity. We put $\omega_{Z_{n}}^{q}:=\Omega_{Z_{n} / W_{n}}^{q}\left(\log M_{Z_{n}}\right)$ and put $\omega_{Z_{n} \mid \mathscr{D}_{n}}^{q}:=\omega_{Z_{n}}^{q} \otimes_{\mathscr{O}_{Z_{n}}}$ $\mathscr{O}_{Z_{n}}\left(-\mathscr{D}_{n}\right)(q \geq 0)$ which are locally free $\mathscr{O}_{Z_{n}}$-modules.

When we consider the global situation of the syntomic complex with modulus, we can patch the another complex $\mathscr{S}_{n}(q)_{X \mid D}^{l o c}$, which is quasi-isomorphic to $s_{n}(r)_{X \mid D}$ in local situation (see [Y], Lemma 2.12). There is a product structure of syntomic complex $s_{n}(r)_{X \mid D}$ :
Definition 2.3. (Product structure of $s_{n}(r)_{X \mid D}$, cf. §2.2 [Tsu2]) For $q, q^{\prime} \geq 0$, we define a product morphism in $D^{-}\left(Y_{\text {ét }}, \mathbb{Z} / p^{n} \mathbb{Z}\right)$ as follows:

and

\left(x^{\prime}, y^{\prime}\right) \in s_{n}^{j^{\prime}}\left(q^{\prime}\right)_{X \mid D}\left(J_{\mathscr{E}_{n}}^{\left[q^{\prime}-j^{\prime}\right]} \otimes_{\mathscr{O}_{Z_{n}}} \omega_{Z_{n} \mid \mathscr{O}_{n}}^{j^{\prime}}\right) \oplus\left(\mathscr{O}_{\mathscr{E}_{n}} \otimes_{\mathscr{O}_{Z_{n}}} \omega_{Z_{n} \mid \mathscr{O}_{n}}^{j^{\prime}-1}\right) .

We define the following logarithmic Hodge-Witt type sheaf for a modulus pair $(X, D)$, which plays an important role in the proof of main result of this paper.

Definition 2.4. For $q \geq 1$, we define

Here morphism $\theta$ is induced by the map $s_{n}(q)_{X \mid D} \longrightarrow \mathcal{S}_{n}(q)_{\left(X, M_{X}\right)}$ and the map $\sigma_{(X, D)}$ is defined in Sat3].
Remark 2.5. When $D_{s}=\emptyset$, we have $\nu_{Y \mid D, n}^{r-1}=\nu_{Y, n}^{r-1}$, which is considered in Sato's paper [Sat1]. The last morphism $\sigma_{(X, D)}$ is surjective by [Sat3], Theorem 3.4. When $Y \subset D_{s}$, we have $\nu_{Y \mid D, n}^{q-1}=0$.
Let $\sigma_{X \mid D, n}^{r}$ be the morphism $s_{n}(r)_{X \mid D} \longrightarrow \nu_{Y \mid D, n}^{r-1}[-r]$ in $D^{b}\left(Y_{e ́ t}, \mathbb{Z} / p^{n} \mathbb{Z}\right)$, which naturally induced by the definition of $\nu_{Y \mid D}^{r-1}$. This is an analogue of the $\operatorname{map} \sigma_{X, n}^{r}$ in (3.2.5), Sat2].
Lemma 2.6. Suppose $r \geq 1$, and let

be a distinguished triangle in $D^{b}\left(Y_{\text {ét }}, \mathbb{Z} / p^{n} \mathbb{Z}\right)$. Then $\mathcal{K}$ is concentrated in $[0, r]$, the triple ( $\mathcal{K}, t, g$ ) is unique up to a unique isomorphism and $g$ is determined by the pair ( $\mathcal{K}, t$ ).
Proof. The map $\sigma_{X \mid D, n}(r)$ is surjective by the definition of $\nu_{Y \mid D, n}^{r-1}$. Since $\mathcal{K}$ is acyclic outside of $[0, r]$, by using Lemma 2.1.1 in [Sat2], we can compute $\operatorname{Hom}_{D^{b}\left(Y_{e t}, \mathbb{Z} / p^{n} \mathbb{Z}\right)}\left(\mathcal{K}, \nu_{Y \mid D, n}^{r-1}[-r-1]\right)=0$. Then there is no non-zero morphism from $\mathcal{K}$ to $\nu_{Y \mid D, n}^{r-1}[-r-1]$. The uniqueness assertion follows from this fact and Lemma 2.12 (3) in [Sat2].

Definition 2.7. For $r \geq 1$, we fix a pair $(\mathcal{K}, t)$ fitting into a distinguished triangle of the form (2.6) and define $\mathcal{K}=: \mathfrak{T}_{n}(r)_{X \mid D}^{s y n}$.
Lemma 2.8. (Product structure of $\mathfrak{T}_{n}(r)_{X \mid m D}^{s y n}$, cf. [Sat2]) For $r, r^{\prime} \geq 0$, there is a unique morphism
$\left\{\mathfrak{T}_{n}(r)_{X \mid m D}^{s y n}\right\}_{m} \otimes^{\mathbb{L}}\left\{\mathfrak{T}_{n}\left(r^{\prime}\right)_{X \mid m D}^{s y n}\right\}_{m} \longrightarrow\left\{\mathfrak{T}_{n}\left(r+r^{\prime}\right)_{X \mid m D}^{s y n}\right\}_{m} \quad$ in $D^{-}\left(Y_{\text {ét }}, \mathbb{Z} / p^{n} \mathbb{Z}\right)$
Proof. We show the assertion by the same argument in Prop 4.2.6 in [Sat2]. Put $\mathfrak{P}:=\mathfrak{T}_{n}(r)_{X \mid m D}^{s y n} \otimes^{\mathbb{L}} \mathfrak{T}_{n}\left(r^{\prime}\right)_{X \mid m D}^{s y n}$. By definition of $\mathfrak{T}_{n}\left(r+r^{\prime}\right)_{X \mid m D}^{s y n}$ and Lemma 2.1.2 (1) in [Sat2], it suffices to show that the following composite morphism is zero in $D^{-}\left(Y_{\text {ét }}, \mathbb{Z} / p^{n} \mathbb{Z}\right)$ :
$\mathfrak{P} \rightarrow s_{n}(r)_{X \mid m D} \otimes^{\mathbb{L}} s_{n}\left(r^{\prime}\right)_{X \mid m D} \rightarrow s_{n}\left(r+r^{\prime}\right)_{X \mid m D} \xrightarrow{\sigma_{X \mid D, n}\left(r+r^{\prime}\right)} \nu_{Y \mid D, n}^{r+r^{\prime}-1}\left[-r-r^{\prime}\right]$,
where the second arrow is product structure of $s_{n}(r)_{X \mid m D}$ (Lemma 2.3). Because $\mathfrak{P}$ is concentrated in degrees $\left[0, r+r^{\prime}\right]$, this composite morphism is determined by the composite map of the $\left(r+r^{\prime}\right)$-th cohomology sheaves(Lemma 2.1.1 in [Sat2]). Then we consider the following composition map:
(2.5)
$\mathcal{H}^{r+r^{\prime}}(\mathfrak{P}) \rightarrow \mathcal{H}^{r}\left(s_{n}(r)_{X \mid m D}\right) \otimes \mathcal{H}^{r^{\prime}}\left(s_{n}\left(r^{\prime}\right)_{X \mid m D}\right) \rightarrow \mathcal{H}^{r+r^{\prime}}\left(s_{n}\left(r+r^{\prime}\right)_{X \mid m D}\right) \xrightarrow{\sigma_{X \mid D, n}\left(r+r^{\prime}\right)} \nu_{Y \mid D, n}^{r+r^{\prime}-1}$.
The image of $\mathcal{H}^{r+r^{\prime}}(\mathfrak{P})\left(\cong F \mathscr{M}_{m}^{r} \otimes F \mathscr{M}_{m}^{r^{\prime}}\right)$ into $\mathcal{H}^{r+r^{\prime}}\left(s_{n}\left(r+r^{\prime}\right)_{X \mid m D}\right)$ is contained in $F \mathscr{M}_{m}^{r+r^{\prime}}$. Hence this composite map is zero by (b) in Theorem 3.1 below.

We define a $p$-adic étale Tate twist for a modulus pair $(X, D)$ :
Definition 2.9. ( $p$-adic étale Tate twist with modulus)
We define $\mathfrak{T}_{n}(r)_{X \mid D}$ by the following homotopy square:

where the right vertical morphism is composite adjunction morphism and isomorphism in [Tsu3] (here we use the assumpution $0 \leq r \leq p-2$ ):

Note that by the definition of $\mathfrak{T}_{n}(r)_{X \mid D}$, there is a distinguished triangle:

\mathfrak{T}_{n}(r)_{X \mid D} \rightarrow i_{*} \mathfrak{T}_{n}(r)_{X \mid D}^{s y n} \oplus \tau_{\leq r} R \psi_{*} \mu_{p^{n}}^{\otimes r} \rightarrow i_{*} \mathcal{S}_{n}(r)_{\left(X, M_{X}\right)} \rightarrow \mathfrak{T}_{n}(r)_{X \mid D}[1] \tag{2.6}
\end{equation*}

When $D=\emptyset$, we write $\mathfrak{T}_{n}(r)_{X}$ for $\mathfrak{T}_{n}(r)_{X \mid \emptyset}$, which agrees with that in [Sat2] $\S 4$. We call $\mathfrak{T}_{n}(r)_{X \mid D}$ a $p$-adic étale Tate twist with modulus.

We have the cohomology sheaf of $\mathfrak{T}_{n}(r)_{X \mid D}^{s y n}$ :

$\mathcal{H}^{q}\left(\mathfrak{T}_{n}(r)_{X \mid D}^{s y n}\right) \cong \begin{cases}\mathcal{H}^{q}\left(s_{n}(r)_{X \mid D}\right) & (0 \leq q \leq r-1), \\ \operatorname{Ker}\left(\mathcal{H}^{r}\left(s_{n}(r)_{X \mid D}\right) \xrightarrow{\mathcal{H}^{r}\left(\sigma_{X \mid D, n}^{r}\right)} \nu_{Y \mid D, n}^{r-1}\right) & (q=r) .\end{cases}$
Proof. This follows form the long exact sequence of cohomology sheaves associated with a distingished triangle (2.6). The details are streightforward and left to reader.

## 3. Structure of $\operatorname{Ker}\left(\sigma_{X \mid m D, n}^{r}\right)$

In $[\mathbf{Y}]$, Theorem 3.5, we have the theorem on the structure of $\mathcal{H}^{r}\left(s_{n}(r)_{X \mid m D}\right)$. We put $\mathscr{M}_{n, m}^{r}:=\mathcal{H}^{r}\left(s_{n}(r)_{X \mid m D}\right)$. We define the étale subsheaf $F \mathscr{M}_{n, m}^{r}$ of $\mathscr{M}_{n, m}^{r}$ as the part generated by the image of $U^{1} \mathscr{M}_{n, m}^{r}$ and $i^{*}\left(1+\mathscr{O}_{X}(-m D)\right)^{\times} \otimes$ $i^{*}\left(\alpha_{*} \mathscr{O}_{U}^{\times}\right)^{\otimes r-1}$. Here $U^{1} \mathscr{M}_{n, m}^{r}$ is defined in Definition 3.1, [Y] as for [Tsu2].

Theorem 3.1. (cf. Theorem 3.4.2, (Sat2]) The map $\sigma_{X \mid m D, n}^{r}$ induces an isomorphism

that is, $\left\{F \mathscr{M}_{n, m}^{r}\right\}_{m}=\left\{\operatorname{Ker}\left(\sigma_{X \mid m D, n}^{r}\right)\right\}_{m}$. Furthermore there is an exact sequence

0 \longrightarrow\left\{U^{1} \mathscr{M}_{n, m}^{r}\right\}_{m} \longrightarrow\left\{F \mathscr{M}_{n, m}^{r}\right\}_{m} \longrightarrow\left\{\lambda_{Y \mid m D}^{r}\right\}_{m} \longrightarrow 0,
$$

i.e. (bb) $\left\{F \mathscr{M}_{n, m}^{r} / U^{1} \mathscr{M}_{n, m}^{r}\right\}_{m} \stackrel{\cong}{\rightrightarrows}\left\{\lambda_{Y \mid m D}^{r}\right\}_{m}$.

Proof. By the Theorem 3.7 and 3.8 in $\left[\bar{Y}\right.$, we have $U^{0} \mathscr{M}_{n, m}^{r}=\mathscr{M}_{n, m}^{r}$ and a short exact sequence

0 \longrightarrow\left\{\operatorname{gr}_{1}^{0} \mathscr{M}_{n, m}^{r}\right\}_{m} \longrightarrow\left\{\operatorname{gr}_{U}^{0} \mathscr{M}_{n, m}^{r}\right\}_{m} \longrightarrow\left\{\operatorname{gr}_{0}^{0} \mathscr{M}_{n, m}^{r}\right\}_{m} \longrightarrow 0
$$

as a pro-system. Then we have the natural adjunction map

\left\{\mathscr{M}_{n, m}^{r} / U^{1} \mathscr{M}_{n, m}^{r}\right\}_{m} \longrightarrow\left\{\bigoplus_{y \in Y^{0}} i_{y *} i_{y}{ }^{*}\left(\mathscr{M}_{n, m}^{r} / U^{1} \mathscr{M}_{n, m}^{r}\right)\right\}_{m}
$$

as a pro-system which is injective. We consider the following commutative diagram:


Here the bottom horizontal row induced by the direct decomposition $\left\{\mathscr{M}_{n, m}^{r} / U^{1} \mathscr{M}_{n, m}^{r}\right\}_{m} \cong$ $\left\{\Omega_{Y \mid m D_{s}, \log }^{r} \oplus \Omega_{Y \mid m D_{s}, \log }^{r-1}\right\}_{m}$ by Theorem 3.8 in $[\mathrm{Y}]$ under the assumption Y is smooth over $\operatorname{Spec}(k)$. Since the central map is an injective, the map $\tau_{D}$ is also. We next prove that the image of the map $\tau_{D}$ is contained in $\lambda_{Y \mid D}^{r}$. Here, we define the sheaf

\lambda_{Y \mid D, n}^{r}:=\operatorname{Im}\left(\left(1+\mathscr{O}_{Y}\left(-D_{s}\right)\right)^{\times} \otimes\left(\alpha_{*}^{\prime} \mathscr{O}_{V}^{\times}\right)^{\otimes r-1} \xrightarrow{\mathrm{~d} \log } \bigoplus_{y \in V^{0}} W_{n} \Omega_{y, \log }^{r}\right) .
$$

The exact sequence ( $\mathfrak{V} 2$ ) in Proposition below, we have an isomorphism

$$
\lambda_{Y \mid m D_{s}}^{r} \cong \operatorname{Ker}\left(a_{1 *} \Omega_{Y^{(1)} \mid m D_{s}^{(1)}}^{r} \rightarrow a_{2 *} \Omega_{Y^{(2)} \mid m D_{s}^{(2)}}^{r}\right) .
$$

We consider the following commutative diagram as a pro-system :


Here the bottom horizontal row induced by Theorem in [Sat3], which is a zero map. Since the right vertical map is injective, the upper horizontal row is zero map. Therefore we have an inclusion $\operatorname{Im}\left(\tau_{D}\right) \subset \lambda_{Y \mid D_{s}}^{r}$. Finally, we show that the isomorphisms (b) and (bb). We have the following injective maps:

$$

The sheaf $F \mathscr{M}_{n, m}^{r} / U^{1} \mathscr{M}_{n, m}^{r}$ is generated by symbols which form $i^{*}\left(1+\mathscr{O}_{X}(-m D)\right)^{\times} \otimes$ $i^{*}\left(\alpha_{*} \mathscr{O}_{U}^{\times}\right)^{\otimes r-1}$. Since $\lambda_{Y \mid D_{s}}^{r}$ is generated by a symbol form $\left(1+\mathscr{O}_{Y}\left(-D_{s}\right)\right)^{\times} \otimes$ $\left(\alpha_{*}^{\prime} \mathscr{O}_{V}^{\times}\right)^{\otimes r-1}$, the two maps are bijective. Thus we have $\left\{F \mathscr{M}_{n, m}^{r}\right\}_{m}=\left\{\operatorname{Ker}\left(\sigma_{X \mid m D}\right)\right\}_{m}$. This completes the proof.

Remark 3.2. When $D=\emptyset$ in Theorem, we have Theorem 3.4.2, [Sat2].

## 4. Logarithmic Hodge-Witt type sheaves with modulus

In this section, we prove the structure and the duality theorem of $\nu_{Y \mid D_{s}, n}^{r-1}$ and introduce a sheaf $\lambda_{Y, n}^{r}$. The duality of $\nu_{Y \mid D_{s}, n}^{r-1}$ and $\lambda_{Y, n}^{r}$ plays an important role in our proof of the main result(see §below).

Lemma 4.1. If $Y$ is smooth, we have $\nu_{Y \mid D_{s}, n}^{r-1} \cong W_{n} \Omega_{Y \mid D_{s}, \log }^{r-1}$ with respect to the multiplicity of the irreducible components of $D$.

Proof. We consider the following commutative diagram (as a pro-system):


Here maps $\phi_{3}$ is obtained in Theorem in [Sat3] (under the assumption $Y$ is smooth). The map $\phi_{3}^{\prime}$ is surjective by the induction on $n$ with applying Theorem 3.8 (1) in [Y]. By the definition, we have $\operatorname{Im}\left(\phi_{3} \circ \phi_{2} \circ \phi_{1}\right)=\nu_{Y \mid D_{s}, n}^{r-1}$. The image of the map $\phi_{1}^{\prime} \circ \phi_{3}^{\prime} \circ \phi_{2}^{\prime}$ is $W_{n} \Omega_{Y \mid D_{s}, \text { log }}^{r-1}$. Then we obtain the assertion.

Proposition 4.2. Assume that $|D| \cap Y^{0}=\emptyset$. We have a short exact sequence

$$
0 \longrightarrow \nu_{Y \mid D_{s}, n}^{r-1} \longrightarrow \nu_{Y, n}^{r-1} \longrightarrow \beta_{*}^{\prime} \nu_{D_{s}, n}^{r-1} \longrightarrow 0 .
$$

Here the last map is a restriction.
Proof. We put $\mathcal{K}_{Y \mid D_{s}}^{r-1}:=\operatorname{Ker}\left(\nu_{Y, n}^{r-1} \longrightarrow \beta_{*}^{\prime} \nu_{D_{s}, n}^{r-1}\right)$. By the definiton of $\nu_{Y \mid D_{s}, n}^{r-1}$ and the assumption of $|D| \cap Y^{0}=\emptyset$, we have $\nu_{(Y,|D| \cap Y), n}^{r-1}=\nu_{Y, n}^{r-1}$. Let $Y^{\text {sing }}$ be the singular locus of $Y$ and let $\tilde{j}: \tilde{Y}:=Y \backslash Y^{\text {sing }} \hookrightarrow Y$ be the open immersion. We define $\tilde{D}_{s}:=D_{s} \times_{Y} \tilde{Y}$. There is a commutative diagram of exact rows:


Here the injectivity of the middle vertical (embedded) map and the right vertical map are due to [Satl]. Then we have a relation ( $\star$ ) $\mathcal{K}_{Y \mid D_{s}}^{r-1}=\nu_{Y, n}^{r-1} \cap$ $j_{2 *} W_{n} \Omega_{\tilde{Y} \mid \tilde{\tilde{D}}_{s}, \log }^{r-1} \supset \nu_{Y \mid D_{s}, n}^{r-1} \cap j_{2 *} W_{n} \Omega_{\tilde{Y} \mid \tilde{D}_{s}, \log }^{r-1}=\nu_{Y \mid D_{s}, n}^{r-1}$ by using the embedding $(* 1)$ in Definition 4.3 below. There is a commutative diagram:


Here we define $\theta:=g \circ f$. The upper horizontal exact row is from Theorem 3.4 .2 in [Sat2]. By this diagram, we have a short exact sequence

$$
0 \longrightarrow \lambda_{Y . n}^{r} \longrightarrow \operatorname{Ker}(\theta) \longrightarrow \nu_{Y \mid D_{s}, n}^{r-1} \longrightarrow 0
$$

We consider the following commutative diagram of exact sequences:


The map $f^{\prime}$ is defined as the composition $\nu_{Y, n}^{r-1} / \nu_{Y \mid D_{s}, n}^{r-1} \longrightarrow \nu_{Y, n}^{r-1} / \mathcal{K}_{Y \mid D_{s}}^{r-1} \cong$ $\beta_{*}^{\prime} \nu_{D_{s}, n}^{r-1}$. The well-definedness of this map is from $(\boldsymbol{\star})$. By the fact that $\operatorname{Ker}(\tau) \cong \lambda_{Y, n}^{r}$, we have $\mathcal{K}_{Y \mid D_{s}}^{r-1}=\nu_{Y \mid D_{s}, n}^{r-1}$.

We will investigate the sheaf $\nu_{Y \mid D_{s}, n}^{r-1}$ by embedding into a differential module of a smooth variety as $\S 2.5$ in [Sat1].

Definition 4.3. We have a composite map:

\text { (*1) } \quad \nu_{Y \mid D_{s}, 1}^{r} \hookrightarrow \tilde{j}_{*} \tilde{j}^{-1} \nu_{Y \mid D_{s}, 1}^{r}=\tilde{j}_{*} \Omega_{\tilde{Y} \mid \tilde{D}_{s}, \log }^{r} \hookrightarrow \tilde{j}_{*} \Omega_{\tilde{Y} \mid \tilde{D}_{s}}^{r} .
$$

By this embedding map (*1), we define the étale sheaf $\Xi_{Y \mid D_{s}}^{r}$ on $Y$ as the $\mathscr{O}_{Y}$ submodule of $\tilde{j}_{*} \Omega_{\tilde{Y} \mid \tilde{D}_{s}}^{r}$ generated by local sections of $\nu_{Y \mid D_{s}, 1}^{r}$. When $D_{s}=\emptyset$, the étale sheaf $\Xi_{Y \mid \emptyset}^{r}$ is the same as Sato's differential module $\Xi_{Y}^{r}$ of Definiton 2.5.1 in [Sat1].

Lemma 4.4. (cf. Lemma 2.4.6, [Satl]) We define

\mathcal{Z}_{\mathscr{Y} \mid \mathscr{D}}^{r+1}(\log Y):=\operatorname{Ker}\left(d: \Omega_{\mathscr{Y} \mid \mathscr{D}}^{r+1}(\log Y) \rightarrow \Omega_{\mathscr{Y} \mid \mathscr{D}}^{r+2}(\log Y)\right) .
$$

Then there exists a short exact sequence on $\mathscr{Y}_{\text {ét }}$ :

Here we put $\mathscr{U}:=\mathscr{Y} \backslash Y$.

Proof. We have a commutative diagram with exact sequences:


Here the two lower rows are from Lemma 2.4.6 in [Sat1]. Since $\beta_{*} j_{D *} \Omega_{\mathscr{D} \backslash D_{s}, \log }^{r+1} \cong$
 tion.

Proposition 4.5. (cf. Sat1], Lemma 2.5.3) Let $Y$ be a simple and embedded into a smooth variety $\mathscr{Y}$ over $\operatorname{Spec}(k)$ as a simple normal crossing divisor. Let $\iota: Y \hookrightarrow \mathscr{Y}$ the closed immersion. Then we have an $\iota^{-1} \mathscr{O} y$-linear isomorphism

which induced by the Poincaré residue map

Proof. We prove this Proposition by the same way as Lemma 2.5.3 in [Sat1]. We have a short exact sequences

by [Sat3], p.200. Then we have a short exact sequence

0 \longrightarrow \Omega_{\mathscr{Y} \mid \mathscr{D}, \log }^{r} \longrightarrow j_{*} \Omega_{\mathscr{U} \mid\left(\mathscr{D} \mid D_{s}\right), \log }^{\stackrel{r}{r}} \iota_{*} \nu_{Y \mid D_{s}, 1}^{r-1} \longrightarrow 0 . \tag{*1}
\end{equation*}

Here $j: \mathscr{U}:=\mathscr{Y} \backslash Y \hookrightarrow \mathscr{Y}$. We prove that $\operatorname{Im}\left(\mathfrak{P}_{Y \mid D_{s}}\right)=\iota_{*} \Xi_{Y \mid D_{s}}^{n}$. We consider the following anti-commutative diagram which considered in [Satl] under no
modulus condition $(D=\emptyset)$ :

\downarrow \\
\iota^{-1} \Omega_{\mathscr{Y} \mid \mathscr{D}}^{r+1}(\log Y) \xrightarrow{\iota^{-1}\left(\mathfrak{P}_{Y \mid D_{s}}\right)} \longrightarrow j_{2 *} \Omega_{Y \mid D_{s}}^{r} .
\end{gathered}

We denote by $\bar{\alpha}$ the residue class of $\alpha \in \iota^{-1} \mathscr{O} \mathscr{y}$. The upper horizontal map $\mathfrak{R}$ is defined by sending a local section $\alpha \otimes \beta$ to $\bar{\alpha} \otimes \mathfrak{r}(\beta)$, which is surjective. Lemma 4.4 induces the left vertical map. The right vertical map is a product map. The image of this product map is $\Xi_{Y \mid D_{s}}^{n}$. By the surjectivity of the top horizontal map and left vertical map, we have $\operatorname{Im}\left(\mathfrak{P}_{Y \mid D_{s}}\right) \cong \iota_{*} \Xi_{Y \mid D_{s}}^{n}$. One can show that the invectivity of the map ( $\mathbb{\Pi})$ by the same way as Lemma 2.5.3 in [Satl].

We next introduce a differential sheaf which is defined for a modulus pair ( $X, D$ ).

## Definition 4.6. We define

\lambda_{Y \mid D_{s}, n}^{r}:=\operatorname{Im}\left(\left(1+\mathscr{O}_{Y}\left(-D_{s}\right)\right)^{\times} \otimes\left(\alpha_{*}^{\prime} \mathscr{O}_{V}^{\times}\right)^{\otimes r-1} \xrightarrow{d \log } \bigoplus_{y \in V^{0}} W_{n} \Omega_{y, \log }^{r}\right)
$$

We denote by $\mathbb{G}_{m, Y \mid D_{s}}^{\otimes r}:=\left(1+\mathscr{O}_{Y}\left(-D_{s}\right)\right)^{\times} \otimes\left(\alpha_{*}^{\prime} \mathscr{O}_{V}^{\times}\right)^{\otimes r-1}$ for simplycity.

We first consider the structure of $\lambda_{Y \mid D_{s}}^{r}$. We apply Lemma 3.2.2 in [Sat1] to the sheaf $\left.\mathcal{F}=W_{n} \Omega_{\bullet}^{r} \mid \bullet \times D_{s}\right)$, log,$Z=\mathscr{Y}$, we obtain an exact sequence by using the fact that $W_{n} \Omega_{Y^{(q), \log }}^{r}=0$ for $q>d+1-r$ :

By taking the cohomology of this morphism, we have a pairing (4.3): $\underset{m}{\lim _{m}} H_{e t t}^{i}\left(Y, \nu_{Y \mid m D_{s}, 1}^{r}\right) \times$ $H_{e ́ t}^{d+1-i}\left(Y, \alpha_{*}^{\prime} \lambda_{V, 1}^{d-r}\right) \longrightarrow H^{d+1}\left(Y, \nu_{Y, 1}^{d}\right) \xrightarrow{\operatorname{tr}} \mathbb{Z} / p^{n} \mathbb{Z}$. Thus we obtain the lower horizontal row, which is an exact. We next prove the assertion (2). Since the problem are étale local on $Y$, we may assume that $Y$ is simple. By the definition of $\lambda_{Y \mid D_{s}}^{r}$ and $\Lambda_{Y \mid D_{s}}^{r}$, we have $\Lambda_{Y \mid D_{s}}^{r}=\operatorname{Im}\left(\iota^{-1} \Omega_{\mathscr{V} \mid \mathscr{D}} \xrightarrow{\iota^{*}} a_{1 *} \Omega_{Y^{(1)} \mid D_{s}^{(1)}}\right)$. Remark 4.14. When $Y$ is smooth in Theorem 4.12, we obtain the Theorem 4.1.4 in [JSZ].

## 5. Explicit formula for $\mathscr{M}_{m}^{r}$

In this section we construct a canonical pairing ( $\mathfrak{H}$ ) below and prove an explicit formula for that pairing, which will be used in the proof of 1.1 In this section, we use a Sato's arguments of $\S 8$ in [Sat2].
5.1. Setting. We put $\nu_{Y}^{r}:=\nu_{n, 1}^{r}, \mu^{\prime}:=i^{*} \psi_{*} \mu_{p}$ and $\mu:=\mu_{p}(K)$ for simplicity. Put $\mathscr{M}^{q}:=\mathscr{M}_{1}^{q}=\mathcal{H}^{q}\left(s_{1}(q)_{X \mid D}\right), M_{Y}^{q}=i^{*} R^{q} j_{*} \mu_{p}^{\otimes q}, M_{V}^{q}=i^{*} R^{q} j_{*}^{\prime} \mu_{p}^{\otimes q}$, and let $U^{\bullet}$ be the filtration on $\mathscr{M}^{q}$ defined in [Sat2]. The purpose of this section is to construct a morphism in $D^{b}\left(Y_{\text {ét }}, \mathbb{Z} / p \mathbb{Z}\right)$ :

We also consider the following distinguished triangle which is induced by [Sat2]:

5.3. Explicit formula for $\Theta_{D}^{r}$. We calculate the morphism $\Theta_{D}^{r}$ explicitly below. We use the idea of the construction of maps of [Sat2]. Let $n$ and $q$ satisfy $1 \leq n \leq d$ and $1 \leq q \leq e^{\prime}-1$. We put $n^{\prime}:=d+1-n$. We define

We denote $Y^{\text {sing }}$ the singular locus of $Y$, and let $j_{Y}$ be the open immersion $Y-Y^{\text {sing }} \hookrightarrow Y$. Since $\omega_{Y}^{N} / \mathcal{B}_{Y}^{N}$ is a locally free $\left(\mathscr{O}_{Y}\right)^{p}$-module, we may assume that $Y$ is smooth over $s(=\operatorname{Spec}(k))$. as $w \otimes(-1)^{N+n} F_{m, D}^{\tilde{q}, r}$. Here $\underline{k}$ is the constant sheaf on $Y_{\text {ét }}$ associated with $k$. We regard $w \in \mu \otimes k$ as a global section of $\mu^{\prime} \otimes \underline{k}$, and $F_{m, D}^{\tilde{q} r}$ denotes the map induced by $F_{m, D}^{q, r}$. The map $f_{m, D}^{q, r}$ is independent of the choice of $\pi$ by the definition of $w$ and $F_{m, D}^{\tilde{q}, r}$.

We state the main result of this section.

Theorem 5.4. (Explicit reciprocity law, cf.Theorem 8.3.8, [Sat2]) We have the following commutative square of pro-systems in $D^{b}\left(Y_{\text {ét }}, \mathbb{Z} / p^{n} \mathbb{Z}\right)$

for $(q, r)$ with $1 \leq q \leq e^{\prime}-1$ and $1 \leq r \leq d$. Here $\chi$ is defined in $§ 8.3$, [Sat2].
We will prove Theorem 5.4 in two steps below by the same arguments as for the proof of Theorem 8.3.8, Sat2].
I. Reduction to cohomology groups(cf. §8.4, [Sat2]) :

Without loss of generality, we may assume that $X$ is connected. Thus by Proposition 8.4.1, [Sat2] for $i=N$, we have

IId. Reduction to higher local fileds(cf. §8.5, [Sat2]) :
In this subsection, we reduce $(\circledast 1)$ to $(\circledast 2)$ below by Sato's trick used in $\S 8.5$, [Sat2]. For $\mathcal{K} \in D^{b}\left(Y_{\text {ét }}, \mathbb{Z} / p\right)$, we can consider the map

5.4. Proof of $(\circledast 2)$. We begin the proof of the $(\circledast 2)$ by the same manner of the proof of (8.5.3) in §8.7, [Sat2]. We fix an arbitrary chain $\left(y_{0}, y_{1}, \cdots, y_{N}\right) \in$ $\operatorname{Ch}(Y)$. Put $F_{N}:=\kappa\left(y_{N}\right)$ and $L_{N+1}:=\operatorname{Frac}\left[\left(\cdots\left(\left(\mathscr{O}_{X, y_{0}}^{h}\right)_{y_{1}}^{h}\right) \cdots\right)_{y_{N}}^{h}\right]$ which is a henselian discrete valuation field of characteristic 0 with residue field $F_{N}$. Let $F / F_{N}$ be a finite separable field extension. We put $y:=\operatorname{Spec}(F)$ and

Thus we obtain the $(\circledast 3)$ by the same argument as for $\S 8.5$ in [Sat2]. This completes the proof of Theorem 5.4

## 6. Duality for $\mathscr{M}_{m}^{r}$

In this section, we prove the following Theorem 6.1 which will be used in $\S 8$.
Theorem 6.1. (cf. Theorem 9.1.1, [Sat2])Let $r$ be $1 \leq r \leq d$. Then for an integer $i$, the following pairing induced by $\Theta_{m, D}^{r}$ and $\operatorname{tr}_{Y}$ :

We will calculate the $\operatorname{map} f_{m}^{q, r}$ constructed in $\S 5$. We recall and define some filtrations on $M_{n, Y}^{d-r+1}$ and $\mathscr{M}_{m}^{r}$.

From the definition, we have $U^{q+1} \subset V^{q} \subset T^{q} \subset U^{q}$ for $M_{Y, m^{\prime} D}^{r}$ and $\mathscr{M}_{m}^{r}$ respectively. For $q \geq 1$, we put

### 6.1. Proof of Theorem 6.1.

In this subsection, we prove Theorem 6.1 by a similar arguments as for $\S 9.2$, [Sat2]. Since the sheaves $U^{1} \mathscr{M}_{m}^{r}$ and $U^{1} M_{Y, m^{\prime} D}^{d-r+1}$ are finitely sucessive extension of coherent $\left(\mathscr{O}_{Y}\right)^{p}$-modules, then we have the finiteness of the groups in the pairing in Theorem6.1 for each $m$. We introduce a descending filtration $Z^{\bullet} \mathscr{M}_{m}^{q}$ on $U^{1} \mathscr{M}_{m}^{q}$ and $Z^{\bullet} M_{Y, m^{\prime} D}^{q}$ on $U^{1} M_{Y, m^{\prime} D}^{q}$ defined as follows:

where the left square commutes by Theorem 5.4 and the right square commutes by Remark 2.2.6(4), [Sat2] and 3.4.1, Sat1]. The morphism (*) is given by the same arguments as for Lemma 9.2.1 (2), Sat2]. This completes the proof of Lemma and Theorem 6.1.

## 7. Proof of Theorem 1.1

for all $n \geq 0, x_{i} \in \mathscr{F}^{i}$, and $y_{j} \in \mathscr{G}^{j}$.
Remark 7.2. Milne defines a pairing of two term complexes in [Mil2], p. 175 or [Mill], p.217. In [JZZ, they have used Milne's two-term pairing to prove their results.
The aim of this section is to construct the following pairing
which is equivalent to giving the following pairing by the proper base change theorem:

We have $R i^{!} R \alpha_{*} \mathfrak{T}_{n}(d-r)_{U}=R \alpha_{*}^{\prime} R i^{\prime!} \mathfrak{T}_{n}(d-r)_{U}$ since the diagram in Setting ( $\left.\boldsymbol{\ell}\right)$ is commutative. There is a spectral sequence $E_{2}^{p, q}=R^{p} \alpha_{*}^{\prime} \mathcal{H}^{q}\left(R i^{\prime!} \mathfrak{T}_{n}(d-r)_{U}\right) \Longrightarrow$ $\mathcal{H}^{p+q} R \alpha_{*}^{\prime} R i^{\prime!} \mathfrak{T}_{n}(d-r)_{U}$ and we have $E_{2}^{p, q}=0$ for all $p \geq 2$. We introduce an augmented complex $s_{n}(q)_{X \mid m^{\prime} D}^{\vee, \bullet}$ to construct a pairing $(\Upsilon)$ :

We define a complex $s_{n}(q)_{X \mid m^{\prime} D}^{\vee, \bullet}$, which degree $i$-part defined by

Its differential is given by $d^{i}(x, y):=\left(d x,\left(1-\varphi_{q}\right) x-d y\right)$. Here we take $m^{\prime}$ satisfies $m^{\prime}+i-m \leq 0$.

Here the first term of $\mathscr{G}_{m^{\prime}}^{\bullet}$ is a degree $d-r+1$. The transition map of $\mathscr{G}_{m^{\prime}}^{\bullet}$ is a differential $d$ of $s_{n}(d-r)_{X \mid m^{\prime} D}^{\vee \bullet}$. We check the well-definedness of the map
$\mathfrak{d}$. It is easy to see that the map $d^{d-r}$ induces $\operatorname{Coker}\left(s_{n}(d-r)_{X \mid m^{\prime} D}^{\vee{ }^{d} D} \longrightarrow\right.$ $\left.s_{n}(d-r)_{X \mid m^{\prime} D}^{\vee d-r}\right) \longrightarrow s_{n}(d-r)_{X \mid m^{\prime} D}^{\vee d-1}$. Then we obtain the following representation (quasi-isomorphism) of $R \alpha_{*}^{\prime} R i^{\prime!} \cdot \mathfrak{T}_{n}(d-r)_{U}$ by using the calculation of the cohomology sheaf of $R i^{\prime!} \mathfrak{T}_{n}(d-r)_{U}$ in [Sat2]:

Here $\mathcal{S}_{n}(d)_{\left(X, M_{X}\right)}^{\bullet}$ is syntomic complex defined by Tsuji (see [Tsu1], [Tsu2] and [Tsu3]). The pairing $\langle\cdot, \cdot\rangle: \mathscr{F}_{m} \times \mathscr{G}_{m^{\prime}} \longrightarrow \mathscr{H}$ is a product map of syntomic complexes defined in Definition. We have to check the pairing $\langle, \cdot, \cdot\rangle: \mathscr{F}_{m} \times$ $\mathscr{G}_{m^{\prime}} \longrightarrow \mathscr{H}$ satisfies the relation $(\diamond)$ for each $m$. It is enough to show that the equation

This relation follows from straightforward computations. ## 8. Proof of non-degeneracy of the pairing in Theorem 1.1

We start the proof of Theorem [1.1]2) by the same strategy of [Sat2] in §10. We can reduce the problem to the case $n=1$ by the distinguished triangle in Proposition.
8.1. Descending induction on $r$. We assume that $\zeta_{p} \in K$. We obtain the following Lemma by the same arguments as in [Sat2], Proposition 4.3 .1 (3), and by Lemma 4.8

Lemma 8.1. (Bockstein triangle, cf. [Sat2], Proposition 4.3 .1 (3)) There is a distinguished triangle as a projective system with respect to the multiplicities of an irreducible components of $D$.

Note that $\mu^{\prime}$ is the constant étale sheaf on $Y$ associated with the abstract group $\mu(\cong \mathbb{Z} / p \mathbb{Z})$. We define the morphism

The above diagram ( $\mathfrak{D i a g}$ ) commutes by using the commutativity of (CSO) (the upside of the right square). Then we obtain the middle commutative square of (8.14).

## proof of the main result Theorem 1.1(2):

In Lemma 8.8, since morphisms $\mathfrak{f}_{1}$ and $\mathfrak{f}_{3}$ are isomorphisms, the morphism $\mathfrak{f}_{2}$ is an isomorphism by Theorem and. Thus in Lemma 8.6, the morphism (1) is an isomorphism. This completes the proof of the main result Theorem 1.1(2). $\square$
Take $i=2 d, r=d$ in Theorem 1.1 we obtain the following:
