# An inequality concerning Radon transform and non-radiative linear waves via a geometric method

#### Abstract

In this work we consider the operator $$
(\mathbf{T} G)(x)=\int_{\mathbb{S}^{2}} G(x \cdot \omega, \omega) d \omega, \quad x \in \mathbb{R}^{3}, G \in L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)
$$


This is the adjoint operator of the Radon transform. We manage to give an optimal $L^{6}$ decay estimate of $\mathbf{T} G$ near the infinity by a geometric method, if the function $G$ is compactly supported. As an application we give decay estimate of non-radiative solutions to the 3D linear wave equation in the exterior region $\left\{(x, t) \in \mathbb{R}^{3} \times \mathbb{R}:|x|>R+|t|\right\}$. This kind of decay estimate is a key element of the channel of energy method for wave equations.

## 1 Introduction

### 1.1 Background and topics

In this article we consider an operator

$$
\begin{equation*}
(\mathbf{T} G)(x)=\int_{\mathbb{S}^{2}} G(x \cdot \omega, \omega) d \omega, \quad x \in \mathbb{R}^{3}, G \in L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right) \tag{1}
\end{equation*}
$$

This operator is exactly the adjoint of the Radon transform defined by (Here $d S$ is the usual measure of the plane $\omega \cdot x=s$.)

$$
(\mathcal{R} f)(s, \omega)=\int_{\omega \cdot x=s} f(x) d S(x), \quad(s, \omega) \in \mathbb{R} \times \mathbb{S}^{2}
$$

Namely we always have $\langle f, \mathbf{T} G\rangle=\langle\mathcal{R} f, G\rangle$ for suitable functions $f(x)$ and $G(s, \omega)$. The angled brackets here are the corresponding pairing in the spaces $\mathbb{R}^{3}$ and $\mathbb{R} \times \mathbb{S}^{2}$, respectively. The application of the Radon transform includes partial differential equations, X-ray technology and radio astronomy. More details about the Radon transforms can be found in in Helgason [13, 14 and Ludwig [17. In this work we are mainly interested in the application of the operator $\mathbf{T}$ on the wave equations. This operator helps solve the free waves, i.e. the solutions to homogenous linear wave equation $\partial_{t}^{2} u-\Delta u=0$, from their corresponding radiation fields.

Radiation field Let us first give a brief introduction of the radiation fields. The conception of radiation field dates back to 1960's, see Friedlander [9, 11]. Generally speaking, radiation fields discuss the asymptotic behaviours of free waves as time goes to infinity. The following version of statement can be found in Duyckaerts-Kenig-Merle 6.

Theorem 1.1 (Radiation field). Assume that $d \geq 3$ and let $u$ be a solution to the free wave equation $\partial_{t}^{2} u-\Delta u=0$ with initial data $\left(u_{0}, u_{1}\right) \in \dot{H}^{1} \times L^{2}\left(\mathbb{R}^{d}\right)$. Then ( $u_{r}$ is the derivative in the radial direction)

$$
\lim _{t \rightarrow \pm \infty} \int_{\mathbb{R}^{d}}\left(|\nabla u(x, t)|^{2}-\left|u_{r}(x, t)\right|^{2}+\frac{|u(x, t)|^{2}}{|x|^{2}}\right) d x=0
$$

and there exist two functions $G_{ \pm} \in L^{2}\left(\mathbb{R} \times \mathbb{S}^{d-1}\right)$ so that

$$
\begin{aligned}
& \lim _{t \rightarrow \pm \infty} \int_{0}^{\infty} \int_{\mathbb{S}^{d-1}}\left|r^{\frac{d-1}{2}} \partial_{t} u(r \theta, t)-G_{ \pm}(r \mp t, \theta)\right|^{2} d \theta d r=0 \\
& \lim _{t \rightarrow \pm \infty} \int_{0}^{\infty} \int_{\mathbb{S}^{d-1}}\left|r^{\frac{d-1}{2}} \partial_{r} u(r \theta, t) \pm G_{ \pm}(r \mp t, \theta)\right|^{2} d \theta d r=0
\end{aligned}
$$

In addition, the maps $\left(u_{0}, u_{1}\right) \rightarrow \sqrt{2} G_{ \pm}$are bijective isometries from $\dot{H}^{1} \times L^{2}\left(\mathbb{R}^{d}\right)$ to $L^{2}(\mathbb{R} \times$ $\mathbb{S}^{d-1}$ ).

Explicit formula We call the functions $G_{ \pm}$radiation profiles in this work. They can be viewed as the "initial data" of free waves at the time $t= \pm \infty$. We may give an explicit formula for the one-to-one map from radiation fields $G_{-}(s, \omega)$ back to the initial data $\left(u_{0}, u_{1}\right)$ in dimension 3 :

$$
\begin{aligned}
& u_{0}(x)=\frac{1}{2 \pi} \int_{\mathbb{S}^{2}} G_{-}(x \cdot \omega, \omega) d \omega ; \\
& u_{1}(x)=\frac{1}{2 \pi} \int_{\mathbb{S}^{2}} \partial_{s} G_{-}(x \cdot \omega, \omega) d \omega .
\end{aligned}
$$

A similar formula has been known for many years, see Friedlander [10]. One may also refer to Li-Shen-Wei [16] for an explicit formula for all dimensions $d \geq 2$. This map between initial data and radiation profiles can also be given in term of their Fourier transforms, as given in a recent work Côte-Laurent [1]. A formula of free waves in term of the radiation fields $G_{-}$immediately follows by a time translation

$$
\begin{equation*}
u(x, t)=\frac{1}{2 \pi} \int_{\mathbb{S}^{2}} G_{-}(x \cdot \omega+t, \omega) d \omega . \tag{2}
\end{equation*}
$$

We recall that the map from the radiation fields $G_{-}$to initial data $\left(u_{0}, u_{1}\right)$ is an isometry from $L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)$ to $\dot{H}^{1} \times L^{2}\left(\mathbb{R}^{3}\right)$. Thus the formula $u_{0}=(1 / 2 \pi) \mathbf{T} G_{-}$implies that the operator $\mathbf{T}$ is a bounded linear operator from $L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)$ to $\dot{H}^{1}\left(\mathbb{R}^{3}\right)$. We may combine this with the Sobolev embedding $\dot{H}^{1}\left(\mathbb{R}^{3}\right) \hookrightarrow L^{6}\left(\mathbb{R}^{3}\right)$ and obtain that $\mathbf{T}$ is also a bounded operator from $L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)$ to $L^{6}\left(\mathbb{R}^{3}\right)$.

Non-radiative solutions In this work we are particularly interested in the case when $G$ is compactly supported $\left(b \in \mathbb{R}^{+}\right)$

$$
\text { Supp } G \subseteq[-b, b] \times \mathbb{S}^{2}
$$

These radiation profiles correspond to the non-radiative solutions of the linear wave equation. More precisely, $G$ is a radiation profile with compact support as above, if and only if the corresponding free wave $u(x, t)$ given by (2) satisfies (see Li-Shen-Wei [16], for example)

$$
\begin{equation*}
\lim _{t \rightarrow \pm \infty} \int_{|x|>b+|t|}\left|\nabla_{t, x} u(x, t)\right|^{2} d x=0 \tag{3}
\end{equation*}
$$

These solutions are usually called non-radiative solutions, or more precisely, $b$-weakly nonradiative solutions. They play an important role in the channel of energy method, which becomes
a powerful tool in the study of asymptotic behaviour of solutions in the past decade. Generally speaking, channel of energy method discusses the energy of solutions to the linear and/or non-linear wave equation in the exterior region $\{x:|x|>R+|t|\}$ for a constant $R$ as $t \rightarrow \pm \infty$. The basic theory of this method can be found in Côte-Kenig-Schlag [2], Duyckaerts-Kenig-Merle [3, 7] and Kenig-Lawrie-Schlag [15], for example. The application of channel of energy method includes proof of the soliton resolution conjecture for radial solutions to focusing, energy critical wave equation in all odd dimensions $d \geq 3$ by Duyckaerts-Kenig-Merle [4, 8] and the nonexistence of soliton-like minimal blow-up solution in the energy super-critical or sub-critical case by Duyckaerts-Kenig-Merle [5] and Shen [18], for instance.

Decay estimate One important part of channel of energy theory is to show that if $u$ is a non-radiative solution to a suitable non-linear wave equation, then the asymptotic behaviour of its initial data as $x \rightarrow+\infty$ is similar to that of non-radiative free waves. (see Duyckaerts-Kenig-Merle [7, for example) The idea is to show that the nonlinear term gradually becomes negligible in the exterior region $\left\{(x, t) \in \mathbb{R}^{3} \times \mathbb{R}:|x|>R+|t|\right\}$ as $R \rightarrow+\infty$. As a result, this argument depends on suitable decay estimates of linear non-radiative free waves in the exterior region $\{(x, t):|x|>|t|+R\}$. Most previously known results of this kind depends on the radial assumption on the solutions. This work is an attempt to give a decay estimate as mentioned above in the non-radial case. This decay estimate is used in an accompanying paper to give the asymptotic behaviour of weakly non-radiative solutions to a wide range of non-linear wave equations, without the radial assumption.

Topics The main topic of this work is to find a good upper bound of the integral

$$
\int_{|x|>R}|\mathbf{T} G(x)|^{6} d x
$$

when the radiation profile $G$ is compactly supported. This immediately gives a decay estimate of non-radiative linear waves.

Remark 1.2. Strictly speaking, Li-Shen-Wei [16] only gives proof of (2) for smooth and compactly supported radiation fields $G_{-}$. But the same formula holds for any radiation profiles $G_{-} \in L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)$. More precisely, given any time $t$, the integral

$$
u(x, t)=\frac{1}{2 \pi} \int_{\mathbb{S}^{2}} G_{-}(x \cdot \omega+t, \omega) d \omega
$$

is defined for almost everywhere $x \in \mathbb{R}^{3}$ so that $u(x, t)$ is a linear free wave with radiation field $G_{-}$. In order to prove this we only need to use the result for smooth and compactly supported radiation fields and apply the classic approximation techniques of real analysis.

### 1.2 Main results

Now we give the statement of our main results.
Proposition 1.3. The linear operator $\mathbf{T}$ defined in (1) satisfies
(a) Assume $b>a>0$ with $b / a \leq 2$. If $G \in L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)$ is supported in $([-b,-a] \cup[a, b]) \times \mathbb{S}^{2}$, then we have

$$
\begin{aligned}
\int_{|x|>R}|\mathbf{T} G(x)|^{6} d x & \lesssim \frac{(a / R)^{2}(1-a / b)^{3}}{1-a / R}\|G\|_{L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)}^{6}, \quad \forall R \geq b \\
\int_{\mathbb{R}^{3}}|\mathbf{T} G(x)|^{6} d x & \lesssim(1-a / b)^{2}\|G\|_{L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)}^{6}
\end{aligned}
$$

(b) Assume $R \geq b>0$. If $G \in L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)$ is supported in $([-b, b]) \times \mathbb{S}^{2}$, then

$$
\int_{|x|>R}|\mathbf{T} G(x)|^{6} d x \lesssim(b / R)^{2}\|G\|_{L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)}^{6} .
$$

We may utilize Proposition 1.3 and conduct a detailed discussion of various choices of parameters $a, b$ to obtain the following decay estimate

Corollary 1.4. If $G \in L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)$ is supported in $[a, b] \times \mathbb{S}^{2}$, then

$$
\int_{|x|>R}|\mathbf{T} G(x)|^{6} d x \lesssim \frac{(b-a)^{2}}{R^{2}}\|G\|_{L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)}^{6} .
$$

Remark 1.5. The decay rate $\|\mathbf{T} G\|_{L^{6}(\{x:|x|>R\})} \lesssim R^{-1 / 3}\|G\|_{L^{2}}$ given above is optimal. We define $\left(\omega=\left(\omega^{1}, \omega^{2}, \omega^{3}\right) \in \mathbb{S}^{2}\right)$

$$
G(s, \omega)= \begin{cases}1, & \text { if } s \in[-1,1], 0<\omega^{3}<\frac{1}{6 R} \\ 0, & \text { otherwise }\end{cases}
$$

A basic calculation shows that $\|G\|_{L^{2}} \simeq R^{-1 / 2}$. In addition, we have $|x \cdot \omega| \leq 1$ if $\left|x_{3}\right|<2 R$, $x_{1}^{2}+x_{2}^{2}<1 / 9$ and $\omega^{3} \in(0,1 / 6 R)$. Therefore

$$
\mathbf{T} G(x)=\int_{\omega \in \mathbb{S}^{2}, 0<\omega^{3}<1 / 6 R} G(x \cdot \omega, \omega) d \omega \simeq R^{-1}, \quad\left|x_{3}\right|<2 R, x_{1}^{2}+x_{2}^{2}<1 / 9 .
$$

Therefore we have $\|\mathbf{T} G\|_{L^{6}(\{x:|x|>R\})} \gtrsim R^{-5 / 6} \simeq R^{-1 / 3}\|G\|_{L^{2}}$.
The $L^{6}$ decay estimates of $\mathbf{T} G$ given above can be used to give decay estimate of non-radiative solutions in the exterior region
Proposition 1.6. Let $u(x, t)$ be a solution to the 3-dimensional linear wave equation $\partial_{t}^{2} u-\Delta u=$ 0 with a finite energy $E$ so that

$$
\lim _{t \rightarrow \pm \infty} \int_{|x|>r+|t|}\left|\nabla_{t, x} u(x, t)\right|^{2} d x=0
$$

Then the following inequalities hold

$$
\|u\|_{L_{t}^{\infty} L^{6}(\mathbb{R} \times\{x:|x|>R\})} \lesssim(r / R)^{1 / 3} E^{1 / 2}, R \geq r ; \quad\|u(\cdot, t)\|_{L^{6}\left(\mathbb{R}^{3}\right)} \lesssim(r /|t|)^{1 / 3} E^{1 / 2}
$$

In addition, we have the decay of Strichartz norm in the exterior region

$$
\|u\|_{L_{t}^{p} L^{q}(\mathbb{R} \times\{x:|x|>R\})} \lesssim_{p, q, \kappa}(r / R)^{\kappa} E^{1 / 2}, \quad R \geq r
$$

as long as the constants $p, q \in(2,+\infty)$ and $\kappa>0$ satisfy $1 / p+3 / q=1 / 2$ and $\kappa<2 / q$.

### 1.3 The idea

The proof of our main result, Proposition [1.3, consists of four steps.
Step 1 We temporarily assume $\operatorname{Supp} G \subset[a, b] \times \mathbb{S}^{2}$ with $b>a>0$ and $b / a<2$. Other cases are direct consequences. We recall

$$
u(x, t)=\int_{\mathbb{S}^{2}} G(x \cdot \omega+t, \omega) d \omega \in C\left(\mathbb{R}_{t} ; \dot{H}^{1}\left(\mathbb{R}^{3}\right)\right) \hookrightarrow C\left(\mathbb{R}_{t} ; L^{6}\left(\mathbb{R}^{3}\right)\right)
$$

Thus we may rewrite

$$
\mathbf{T} G=\lim _{\delta \rightarrow 0^{+}} \frac{1}{\delta} \int_{0}^{\delta} \int_{\mathbb{S}^{2}} G(x \cdot \omega+t, \omega) d \omega d t
$$

and consider the upper bound of

$$
\int_{|x|>R}\left|\frac{1}{\delta} \int_{0}^{\delta} \int_{\mathbb{S}^{2}} G(x \cdot \omega+t, \omega) d \omega d t\right|^{6} d x
$$

A careful calculation gives an upper bound

$$
\begin{equation*}
K_{\delta}=\frac{1}{\delta^{6}} \int_{\left(\mathbb{S}^{2} \times I\right)^{6}}\left(\prod_{k=1}^{6}\left|G\left(s_{k}, \omega_{k}\right)\right|\right)\left|A_{1} \cap A_{2} \cap \cdots \cap A_{6}\right|(d \omega d s)^{6} . \tag{4}
\end{equation*}
$$

Here $I=[a, b], A_{k}=\left\{x \in \mathbb{R}^{3}: s_{k}-\delta<x \cdot \omega_{k}<s_{k},|x|>R\right\}$ and

$$
(d \omega d s)^{6}=\prod_{k=1}^{6} d \omega_{k} d s_{k}
$$

Step 2 In order to prove Proposition [1.3, we need to show $K_{\delta} \leq C\|G\|_{L^{2}}^{6}$ and determine the best constant $C$. The right hand side $\|G\|_{L^{2}}^{6}$ can be rewritten in the form

$$
\|G\|_{L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)}^{6}=\int_{\left(\mathbb{S}^{2} \times I\right)^{3}}\left|G\left(s_{1}, \omega_{1}\right)\right|^{2}\left|G\left(s_{2}, \omega_{2}\right)\right|^{2}\left|G\left(s_{3}, \omega_{3}\right)\right|^{2} d s_{123} d \omega_{123} .
$$

Here $d s_{i j k}=d s_{i} d s_{j} d s_{k}, d \omega_{i j k}=d \omega_{i} d \omega_{j} d \omega_{k}$. A comparison of this identity with (4) indicates that a Cauchy-Schwartz inequality might do the job. One could try to write (we define $A_{i j k}=$ $A_{i} \cap A_{j} \cap A_{k}$ and $\left.A_{123456}=A_{1} \cap \cdots \cap A_{6}\right)$

$$
\begin{aligned}
K_{\delta} \leq & \frac{1}{2 \delta^{6}} \int_{\left(\mathbb{S}^{2} \times I\right)^{6}} \frac{\left|A_{456}\right| \cdot\left|A_{123456}\right|}{\left|A_{123}\right|}\left|G\left(s_{1}, \omega_{1}\right)\right|^{2}\left|G\left(s_{2}, \omega_{2}\right)\right|^{2}\left|G\left(s_{3}, \omega_{3}\right)\right|^{2}(d s d \omega)^{6} \\
& +\frac{1}{2 \delta^{6}} \int_{\left(\mathbb{S}^{2} \times I\right)^{6}} \frac{\left|A_{123}\right| \cdot\left|A_{123456}\right|}{\left|A_{456}\right|}\left|G\left(s_{4}, \omega_{4}\right)\right|^{2}\left|G\left(s_{5}, \omega_{5}\right)\right|^{2}\left|G\left(s_{6}, \omega_{6}\right)\right|^{2}(d s d \omega)^{6} \\
\leq & \frac{1}{\delta^{6}} \int_{\left(\mathbb{S}^{2} \times I\right)^{6}} \frac{\left|A_{456}\right| \cdot\left|A_{123456}\right|}{\left|A_{123}\right|}\left|G\left(s_{1}, \omega_{1}\right)\right|^{2}\left|G\left(s_{2}, \omega_{2}\right)\right|^{2}\left|G\left(s_{3}, \omega_{3}\right)\right|^{2}(d s d \omega)^{6} \\
\leq & \int_{\left(\mathbb{S}^{2} \times I\right)^{3}} J\left(s_{123}, \omega_{123}\right)\left|G\left(s_{1}, \omega_{1}\right)\right|^{2}\left|G\left(s_{2}, \omega_{2}\right)\right|^{2}\left|G\left(s_{3}, \omega_{3}\right)\right|^{2} d s_{123} d \omega_{123} ;
\end{aligned}
$$

with

$$
J\left(s_{123}, \omega_{123}\right)=\frac{1}{\delta^{6}\left|A_{123}\right|} \int_{\left(\mathbb{S}^{2} \times I\right)^{3}}\left|A_{456}\right| \cdot\left|A_{123456}\right| d \omega_{456} d s_{456}
$$

Here we put the weights $\left|A_{456}\right| /\left|A_{123}\right|$ for the purpose of balance, because without the weights the coefficient $J\left(s_{123}, \omega_{123}\right)$ would become

$$
\frac{1}{\delta^{6}} \int_{\left(\mathbb{S}^{2} \times I\right)^{3}}\left|A_{123456}\right| d s_{456} d \omega_{456}
$$

which seems to be proportional to $\left|A_{123}\right|$. Now we need to find an upper bound of

$$
\sup _{\omega_{123}, s_{123}} J\left(s_{123}, \omega_{123}\right)=\sup _{\omega_{123}, s_{123}} \frac{1}{\left|A_{123}\right|} \int_{A_{123}}\left(\frac{1}{\delta^{6}} \int_{\left(\mathbb{S}^{2} \times I\right)^{3}}\left|A_{456}\right| \chi_{A_{456}}(x) d \omega_{456} d s_{456}\right) d x
$$

A reasonable upper bound can be found

$$
\begin{aligned}
\sup _{x} \frac{1}{\delta^{6}} \int_{\left(\mathbb{S}^{2} \times I\right)^{3}}\left|A_{456}\right| \chi_{A_{456}}(x) d \omega_{456} d s_{456} & =\sup _{x} \frac{1}{\delta^{6}} \int_{\left(\mathbb{S}^{2} \times I\right)^{3}, x \in A_{456}}\left|A_{456}\right| d \omega_{456} d s_{456} \\
& \leq \sup _{x} \int_{\Omega^{3}(x)} \frac{1}{\left|\left(\omega_{4} \times \omega_{5}\right) \cdot \omega_{6}\right|} d \omega_{456}
\end{aligned}
$$

Here $\Omega(x)=\left\{\omega \in \mathbb{S}^{2}: a-\delta<x \cdot \omega<b\right\}$. We use the following facts in the inequality above

- $x \in A_{k} \Rightarrow \omega_{k} \in \Omega(x)$;
- $A_{456} \leq \delta^{3} /\left|\left(\omega_{4} \times \omega_{5}\right) \cdot \omega_{6}\right| ;$
- Given $x$ and $\omega_{k}$, then $\left\{s_{k} \in[a, b]: x \in A_{k}\right\}$ is an interval whose length is no more than $\delta$.

Finally we need to find an upper bound of

$$
\sup _{x} \int_{\Omega^{3}(x)} \frac{1}{\left|\left(\omega_{4} \times \omega_{5}\right) \cdot \omega_{6}\right|} d \omega_{456}
$$

Unfortunately we have

$$
\int_{\Omega} \frac{1}{\left|\left(\omega_{4} \times \omega_{5}\right) \cdot \omega_{6}\right|} d \omega_{456}=+\infty
$$

for any open region $\Omega \subset \mathbb{S}^{2}$. As a result, the argument above has to be improved in some way. The key observation here is that we have many different ways to split the product of $G\left(s_{k}, \omega_{k}\right)$ into two triples when we apply the Cauchy-Schwartz. In order to avoid too small value of $\left|\left(\omega_{i} \times \omega_{j}\right) \cdot \omega_{k}\right|$, which appears in the denominator in the integral given above, given $\omega_{1}, \omega_{2}, \cdots, \omega_{6} \in \mathbb{S}^{2}$, we split them into two group of three, i.e. $\left(\omega_{k_{1}}, \omega_{k_{2}}, \omega_{k_{3}}\right)$ and $\left(\omega_{k_{4}}, \omega_{k_{5}}, \omega_{k_{6}}\right)$, so that the product

$$
\left|\left(\omega_{k_{1}} \times \omega_{k_{2}}\right) \cdot \omega_{k_{3}}\right| \cdot\left|\left(\omega_{k_{4}} \times \omega_{k_{5}}\right) \cdot \omega_{k_{6}}\right|
$$

gets its maximum value among all possible grouping method. In this work we call these kind of triples reciprocal triples. Following a similar argument as above but using reciprocal triples instead in the Cauchy Schwartz

$$
\begin{gathered}
\left(\prod_{k=1}^{6}\left|G\left(s_{k}, \omega_{k}\right)\right|\right) \leq \\

Here $B^{c}=\{x:|x|>R\}$ and $\Sigma\left(\omega_{123}\right) \subseteq\left(\mathbb{S}^{2}\right)^{3}$ consists of all reciprocal triples of $\omega_{123}$. The reciprocal condition above significantly restricts the location, size and/or shape of the surface triangles $\left(\omega_{4}, \omega_{5}, \omega_{6}\right)$ thus leads to a finite least upper bound. The remaining work is to figure out this least upper bound.

Step 3 We then apply a central projection $\mathbf{P}: \mathbb{S}_{+}^{2} \rightarrow \mathbb{R}^{2}$ defined by $\mathbf{P}\left(x_{1}, x_{2}, x_{3}\right)=\left(x_{1} / x_{3}, x_{2} / x_{3}\right)$ and rewrite the least upper bound (5) in the form of an integral in Euclidean space $\mathbb{R}^{2}$ :

Here reciprocal triangles in $\mathbb{R}^{2}$ are defined in a similar way to reciprocal triples in $\mathbb{S}^{2}$.

### 1.4 Notations and Structure of this work

Notations In this work the notation $A \lesssim B$ means that there exists a constant $c$ so that $A \leq c B$. In this work these explicit constants are absolute constants, i.e. depends on nothing, unless stated otherwise. The notation $\gtrsim$ is similar. The meaning of $\ll$ is similar to $\lesssim$, i.e. there exists a constant $c$, so that $A \leq c B$. But in this case we additionally assume $c<1$ is very small. The meaning of $\gg$ is similar. We may add subscripts to these notations to indicate that the explicit constants depend on these subscripts but nothing else. Throughout this work we use the notation $\chi$ for characteristic functions and $|\Omega|$ for the Lebesgue measure of a subset $\Omega$ of the Euclidean spaces or the sphere $\mathbb{S}^{2}$.

Structure of this work In Section 2 we first reduce the proof of Proposition 1.3 to a geometric inequality. Section 3 is devoted to the proof of some basic geometric properties regarding reciprocal triangles and circular annulus regions, which are the preparation work for the proof of the geometric inequality (6). Next in Section 4 we prove the geometric inequality by considering reciprocal triangles with different sizes and angles separately. In Section 5 we combine all results from previous sections to finish the proof of Proposition 1.3 and then give an application on the decay estimate of non-radiative solutions. Finally we give an estimate of Radon transform in the two or three dimensional space, as another application of our main result.

## 2 Transformation to a Geometric Inequality

In this section we reduce the proof of Proposition 1.3 to a geometric inequality. Let us temporarily assume $G(s, \omega)$ is supported in $[a, b] \times \mathbb{S}^{2}$. Here $a, b>0$ so that $b / a \leq 2$. We recall that the function defined by

We define $Y_{k}=\mathbf{P} \omega_{k} \in \mathbb{R}^{2}$ and use notation $\vec{y}_{k}$ for the vector $O Y_{k} \in \mathbb{R}^{3}$. If $\omega_{k}=\left(\omega_{k, 1}, \omega_{k, 2}, \omega_{k, 3}\right) \in$ $\Omega_{\delta_{0}}(x)$, then

$$
\begin{equation*}
\vec{y}_{k}=\omega_{k, 3}^{-1} \omega_{k}, \quad \frac{h}{b}<\omega_{k, 3}^{-1}<\frac{h}{a-\delta_{0}} . \tag{10}
\end{equation*}
$$

Since the distance of $O$ to the plane $x_{3}=1$ is 1 , the volume $V$ of tetrahedron $O Y_{i} Y_{j} Y_{k}$ is one third of the area of triangle $Y_{i} Y_{j} Y_{k}$. Thus (please see figure 2)

$$
\frac{1}{3}\left|\triangle Y_{i} Y_{j} Y_{k}\right|=V=\frac{1}{6}\left|\left(\vec{y}_{i} \times \vec{y}_{j}\right) \cdot \vec{y}_{k}\right| .
$$

We may combine this with (10) and obtain


Figure 2: Illustration of volume

$$
\begin{equation*}
\frac{\left|\triangle Y_{i} Y_{j} Y_{k}\right|}{\left|\left(\omega_{i} \times \omega_{j}\right) \cdot \omega_{k}\right|}=\frac{\left|\left(\vec{y}_{i} \times \vec{y}_{j}\right) \cdot \vec{y}_{k}\right|}{2\left|\left(\omega_{i} \times \omega_{j}\right) \cdot \omega_{k}\right|}=\frac{1}{2 \omega_{i, 3} \cdot \omega_{j, 3} \cdot \omega_{k, 3}} \in\left(\frac{h^{3}}{2 b^{3}}, \frac{h^{3}}{2\left(a-\delta_{0}\right)^{3}}\right) \tag{11}
\end{equation*}
$$

Therefore we may use the reciprocal assumption on triples $\omega_{123}$ and $\omega_{456}$, as well as the assumption $b / a \leq 2$ to deduce (as long as $\delta_{0}>0$ is sufficiently small)

$$
\begin{aligned}
\left|\triangle Y_{1} Y_{2} Y_{3}\right| \cdot\left|\triangle Y_{4} Y_{5} Y_{6}\right| & \geq \frac{\left(a-\delta_{0}\right)^{6}}{b^{6}} \max _{j_{1}, j_{2}, \cdots, j_{6}}\left|\triangle Y_{j_{1}} Y_{j_{2}} Y_{j_{3}}\right| \cdot\left|\triangle Y_{j_{4}} Y_{j_{5}} Y_{j_{6}}\right| \\
& \geq \frac{1}{65} \max _{j_{1}, j_{2}, \cdots, j_{6}}\left|\triangle Y_{j_{1}} Y_{j_{2}} Y_{j_{3}}\right| \cdot\left|\triangle Y_{j_{4}} Y_{j_{5}} Y_{j_{6}}\right|
\end{aligned}
$$

Here again the maximum is taken for all possible permutations of $1,2, \cdots, 6$. We still call these two triangles $\triangle Y_{1} Y_{2} Y_{3}$ and $Y_{4} Y_{5} Y_{6}$ (weakly) reciprocal to each other and use the notation

$$
\Sigma\left(Y_{123}\right)=\left\{\left(Y_{4}, Y_{5}, Y_{6}\right) \in\left(\mathbb{R}^{2}\right)^{3}:\left(Y_{1}, Y_{2}, Y_{3}\right),\left(Y_{4}, Y_{5}, Y_{6}\right) \text { are reciprocal }\right\}
$$

We apply change of variables on the integral in (9), utilize (11) and obtain

$$
\begin{aligned}
C_{I, \delta_{0}}(x) & =\sup _{\omega_{123} \in \Omega_{\delta_{0}}^{3}(x)} \int_{\mathbf{P}\left(\Sigma\left(\omega_{123}\right) \cap \Omega_{\delta_{0}}^{3}(x)\right)} \frac{\omega_{4,3}^{2} \omega_{5,3}^{2} \omega_{6,3}^{2}}{2} \cdot \frac{1}{\left|\triangle Y_{4} Y_{5} Y_{6}\right|} d Y_{456} \\
& \leq \frac{b^{6}}{2 h^{6}} \sup _{Y_{123} \in\left(\Omega_{\delta_{0}, h}^{*}\right)^{3}} \int_{\Sigma\left(Y_{123}\right) \cap\left(\Omega_{\delta_{0}, h}^{*}\right)^{3}} \frac{1}{\left|\triangle Y_{4} Y_{5} Y_{6}\right|} d Y_{456} .
\end{aligned}
$$

In summary we have
Lemma 2.1. Assume that $b>a>0$ with $b / a \leq 2$. Let $G(s, \omega) \in L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)$ be supported in the region $[a, b] \times \mathbb{S}^{2}$. Then the function

$$
\mathbf{T} G(x)=\int_{\mathbb{S}^{2}} G(x \cdot \omega, \omega) d \omega, \quad x \in \mathbb{R}^{3}
$$

satisfies the following inequality for all sufficiently small $\delta>0$ :

$$
\int_{|x|>R}|\mathbf{T} G(x)|^{6} d x \leq\left(\sup _{h>\max \{R, a-\delta\}} C_{a, b, \delta}(h)\right)\|G\|_{L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)}^{6}
$$

The constant $C_{a, b, \delta}(h)$ is defined by

$$
C_{a, b, \delta}(h)=\frac{5 b^{6}}{h^{6}} \sup _{Y_{1}, Y_{2}, Y_{3} \in \Omega_{\delta, h}^{*}} \int_{\Sigma\left(Y_{1} Y_{2} Y_{3}\right) \cap\left(\Omega_{\delta, h}^{*}\right)^{3}} \frac{1}{\left|\triangle Y_{4} Y_{5} Y_{6}\right|} d Y_{4} d Y_{5} d Y_{6}
$$

Here $\Omega_{\delta, h}^{*}$ is an annulus (or disk) region in $\mathbb{R}^{2}$ defined by

$$
\begin{array}{ll}
\Omega_{\delta, h}^{*} \doteq\left\{Y \in \mathbb{R}^{2}: \frac{\sqrt{h^{2}-b^{2}}}{b}<|Y|<\frac{\sqrt{h^{2}-(a-\delta)^{2}}}{a-\delta}\right\}, & h \geq b \\
\Omega_{\delta, h}^{*} \doteq\left\{Y \in \mathbb{R}^{2}:|Y|<\frac{\sqrt{h^{2}-(a-\delta)^{2}}}{a-\delta}\right\}, & h \in(a-\delta, b)
\end{array}
$$

And $\Sigma\left(Y_{1} Y_{2} Y_{3}\right)$ consists of all (weakly) reciprocal triples of $\left(Y_{1}, Y_{2}, Y_{3}\right)$ in $\mathbb{R}^{2}$ :
$\Sigma\left(Y_{1} Y_{2} Y_{3}\right)=\left\{\left(Y_{4}, Y_{5}, Y_{6}\right):\left|\triangle Y_{1} Y_{2} Y_{3}\right| \cdot\left|\triangle Y_{4} Y_{5} Y_{6}\right| \geq \frac{1}{65} \max _{j_{1}, j_{2}, \cdots, j_{6}}\left|\triangle Y_{j_{1}} Y_{j_{2}} Y_{j_{3}}\right| \cdot\left|\triangle Y_{j_{4}} Y_{j_{5}} Y_{j_{6}}\right|\right\}$.
Here the maximum is taken for all possible permutations of $1,2, \cdots, 6$.

## 3 Geometric Observations

In this section we make some geometric observations. We first give a few geometric characteristics of (weakly) reciprocal triangles in $\mathbb{R}^{2}$ and then a few properties an annulus region satisfies. Many of the following results are simple geometric observations and might have been previously known. Here we still give their proof for the reason of completeness. In this section we say that a triangle $\triangle A B C$ is of size $L$ if and only if $L \leq \max \{|A B|,|B C|,|C A|\}<2 L$.

### 3.1 Reciprocal triangles

In this subsection, we consider (weakly) reciprocal triangles in $\mathbb{R}^{2}$, as defined in the previous section.

Lemma 3.1. Let $\triangle A B C$ be of size $L$ and $D \in \mathbb{R}^{2}$ satisfy $d=d(D, \triangle A B C) \gg L$. Then either $|\triangle D A B| \gtrsim(d / L)|\triangle A B C|$ or $|\triangle D A C| \gtrsim(d / L)|\triangle A B C|$.

Proof. We always have $\max \{\sin \angle D A C, \sin \angle D A B\} \geq(1 / 2) \sin \angle B A C$. Thus

$$
\begin{aligned}
\max \{|\triangle D A C|,|\triangle D A B|\} & \gtrsim \max \{|D A| \cdot|A C| \sin \angle D A C,|D A| \cdot|A B| \sin \angle D A B\} \\
& \gtrsim(d / L)|A B| \cdot|A C| \max \{\sin \angle D A C, \sin \angle D A B\} \\
& \gtrsim(d / L)|A B| \cdot|A C| \sin \angle B A C \\
& \gtrsim(d / L)|\triangle B A C| .
\end{aligned}
$$

This immediately gives
Corollary 3.2. Let $\triangle A B C$ be of size $L$ and $D \in \mathbb{R}^{2}$ satisfy $d=d(D, \triangle A B C) \gg L$. Then at least two of the following inequalities holds

$$
|\triangle D A B| \gtrsim(d / L)|\triangle A B C| ; \quad|\triangle D B C| \gtrsim(d / L)|\triangle A B C| ; \quad|\triangle D C A| \gtrsim(d / L)|\triangle A B C| .
$$

Proposition 3.3. Let $\triangle A B C, \triangle D E F \subset \mathbb{R}^{2}$ be reciprocal and of sizes $L \ll M$, respectively. Then there exists a vertex of $\triangle D E F$ (say $D$ ) so that $|A D|,|B D|,|C D| \lesssim L$.

Proof. Let us prove Proposition 3.3 by contradiction. We assume

$$
|A D|,|A E|,|A F|,|B D|,|B E|,|B F|,|C D|,|C E|,|C F| \gg L .
$$

Without loss of generality we also assume $|D F| \geq|E F| \geq|D E|$. Thus $|D F|,|E F| \simeq M$. We consider two cases: case $1, \triangle A B C$ is close to the vertex $F$; case $2, \triangle A B C$ is far away from the vertex $F$.

Case 1 If $|A F|,|B F|,|C F| \ll M$. We apply Corollary 3.2 on $\triangle A B C$ and $F$, at least two of the following holds

$$
|\triangle F A B| \gg|\triangle A B C| ; \quad|\triangle F B C| \gg|\triangle A B C| ; \quad|\triangle F C A| \gg|\triangle A B C|
$$

Similarly at least two of the following inequalities holds

$$
|\triangle E A B| \gg|\triangle A B C| ; \quad|\triangle E B C| \gg|\triangle A B C| ; \quad|\triangle E C A| \gg|\triangle A B C|
$$

Thus we may find two vertices from $\triangle A B C$, say $A B$, so that we have

$$
|\triangle F A B|,|\triangle E A B| \gg|\triangle A B C| .
$$

Next we show that either $|\triangle C D E| \gtrsim|\triangle D E F|$ or $|\triangle C D F| \gtrsim|\triangle D E F|$ holds. This immediately gives a contradiction to our reciprocal assumption. In fact, if the first inequality fails, i.e. $|\triangle C D E| \ll|\triangle D E F|$, then we have

$$
d(C, D E) \ll d(F, D E)
$$

Our assumption $|C F| \ll M$ guarantees that $|C D| \simeq M \simeq|D F|$, thus we have

$$
\sin \angle C D E=\frac{d(C, D E)}{|C D|} \ll \frac{d(F, D E)}{|D F|}=\sin \angle F D E .
$$

It immediately follows that $\sin \angle F D C \simeq \sin \angle F D E$. Thus

$$
|\triangle C D F|=|C D| \cdot|D F| \sin \angle F D C \gtrsim|D E| \cdot|D F| \sin \angle F D E=|\triangle D E F| .
$$

This finishes the argument in case one. Please see figure 3 for an illustration of the proof.


Figure 3: Illustration of case 1

Case 2 In this case $|A F|,|B F|,|C F| \gtrsim M$. Given any vertex $X \in\{A, B, C\}$, we have either $\sin \angle X F E \geq(1 / 2) \sin \angle D F E$ or $\sin \angle X F D \geq(1 / 2) \sin \angle D F E$. As a result, we may find one vertex from $\{D, E\}$ (say $D$ ) and two vertices from $\{A, B, C\}$ (say $A, B$ ) so that

$$
\sin \angle A F D \geq(1 / 2) \sin \angle D F E ; \quad \sin \angle B F D \geq(1 / 2) \sin \angle D F E
$$

Combining these angles with our assumptions $|A F|,|B F| \gtrsim M$ and $|D F|,|E F| \simeq M$, we obtain

$$
\begin{equation*}
|\triangle A F D| \gtrsim|\triangle D E F| ; \quad|\triangle B F D| \gtrsim|\triangle D E F| . \tag{12}
\end{equation*}
$$

Finally we apply Lemma 3.1 on $\triangle C A B$ and $E$ to conclude that either $|\triangle E B C| \gg|\triangle A B C|$ or $|\triangle E C A| \gg|\triangle A B C|$ holds. A combination of this with (12) immediately gives a contradiction. Please see figure 4 for an illustration of this case. Combining case 1 and 2, we finish the proof of Proposition 3.3

Corollary 3.4. Let $\triangle A B C, \triangle D E F \subset \mathbb{R}^{2}$ be reciprocal of sizes $L, M$, respectively. Then they can not be too far away from each other. Namely we always have

$$
d(\triangle A B C, \triangle D E F) \lesssim \min \{L, M\}
$$

Proof. This corollary clearly holds if the size of one triangle is much larger than that of the other, thanks to Proposition 3.3. Thus we only need to consider the case $L \simeq M$. If the corollary failed, we would have

$$
d(\triangle A B C, \triangle D E F) \gg L, M
$$



Figure 4: Illustration of case 2

We may apply Corollary 3.2 on the triangle $D E F$ and the point $A$, then on the same triangle and the point $B$. This enable us to find two vertices from $D E F$ (say $D E$ ) so that

$$
|\triangle A D E| \gg|\triangle D E F| ; \quad|\triangle B D E| \gg|\triangle D E F|
$$

We then apply Lemma 3.1 on the triangle $C A B$ and the point $F$, then conclude that at least one of the following holds

$$
|\triangle B C F| \gg|\triangle A B C| ; \quad|\triangle A C F| \gg|\triangle A B C|
$$

Either of these contradicts our reciprocal assumption.
Proposition 3.5 (Classification). Let $\triangle A B C$ and $\triangle D E F$ be two reciprocal triangles of sizes $L \ll M$, respectively. Without loss of generality we also assume $|B C|$ and $|D E|$ are the shortest edge in the corresponding triangles. Then the location of smaller triangle $A B C$ satisfies either of the following
(I) $|A F|,|B F|,|C F| \lesssim L$;
(IIa) $|A D|,|B D|,|C D| \lesssim L$ so that $\max \{|\triangle B E F|,|\triangle C E F|\} \gtrsim|\triangle D E F|$;
(IIb) $|A E|,|B E|,|C E| \lesssim L$ so that $\max \{|\triangle B D F|,|\triangle C D F|\} \gtrsim|\triangle D E F|$.
We call these triangles Type I reciprocal if they satisfies (I) and call them Type II reciprocal if they satisfies either (IIa) or (IIb). Please see figure 5 .

Proof. Proposition 3.3 guarantees that if (I) fails, then we have either $|A D|,|B D|,|C D| \lesssim L$ or $|A E|,|B E|,|C E| \lesssim L$. Without loss of generality, we assume $|A D|,|B D|,|C D| \lesssim L$ and show that either (IIa) or (IIb) holds. Because $|F B|,|F D|,|F E| \simeq M$, we may conclude that either $|\triangle B F D| \gtrsim|\triangle D E F|$ or $|\triangle B E F| \gtrsim|\triangle D E F|$ holds by considering the angles $\angle B F D$ and $\angle B F E$. If the latter holds, $\triangle A B C$ satisfies (IIa). Thus we only need to consider the first case. Similarly we may assume $|\triangle C F D| \gtrsim|\triangle D E F|$. Now we claim that $|A E|,|B E|,|C E| \lesssim L$ thus (IIb) holds. Otherwise we may apply Lemma 3.1 and conclude that either $|\triangle A B E| \gg|\triangle A B C|$ or $|\triangle A C E| \gg|\triangle A B C|$. This means

$$
\max \{|\triangle B F D| \cdot|\triangle A C E|,|\triangle C F D| \cdot|\triangle A B E|\} \gg|\triangle A B C| \cdot|\triangle D E F|,
$$

thus contradicts the reciprocal assumption.


Figure 5: Classification of reciprocal triangles

### 3.2 About annulus

In this subsection we give a few geometric properties of a circular annulus region. We consider a circular annulus region $\Omega^{*} \subset \mathbb{R}^{2}$, whose outer radius is $r$, inner radius is $r-w$ and width is $w$. We will also use the notation $O$ for the center of $\Omega^{*}$.

Lemma 3.6. Assume $A, B \in \Omega^{*}$ and $A C \perp O A$. Then

$$
\sin \angle B A C \leq \max \left\{\frac{2 w}{|A B|}, \frac{2|A B|}{r}\right\}
$$



Figure 6: Illustration of proof
Proof. First of all, if $|A B| \geq r / 2$ or $|A B| \leq 2 w$, then the right hand side is greater or equal to 1 , thus the inequality holds. We now assume $2 w<|A B|<r / 2$ thus $w<r / 4$. Let $D$ be the point on the ray $O B$ so that $|O D|=|O A|$. We have

$$
\sin \angle C A D=\frac{|A D|}{2|O A|} \leq \frac{|A B|+w}{2(r-w)} \leq \frac{3|A B| / 2}{3 r / 2}=\frac{|A B|}{r} .
$$

We also have

$$
\sin \angle B A D=\frac{|B D| \sin \angle B D A}{|A B|} \leq \frac{w}{|A B|}
$$

Finally we have

$$
\sin \angle B A C \leq \sin \angle C A D+\sin \angle B A D \leq \frac{|A B|}{r}+\frac{w}{|A B|} \leq \max \left\{\frac{2 w}{|A B|}, \frac{2|A B|}{r}\right\}
$$

Corollary 3.7. Assume $L \leq r$ and $A \in \Omega^{*}$. Then
(a) $\mid\left\{\Theta \in \mathbb{S}^{1}: \exists l \in[L / 2,2 L]\right.$, s.t. $\left.A+l \Theta \in \Omega^{*}\right\} \mid \leq 8 \pi \max \{w / L, L / r\}$. Here $A+l \Theta$ is the terminal point of the vector in $\mathbb{R}^{2}$ with starting point $A$, length $l$ and direction $\Theta$.
(b) If $B, C \in \Omega^{*}$ so that $L / 2 \leq|A B|,|A C| \leq 2 L$, then we have

$$
\sin \angle B A C \leq 8 \max \{w / L, L / r\}
$$

Proof. Let $A D \perp O A$ and $E=A+l \Theta \in \Omega^{*}, l \in[L / 2,2 L]$. By Lemma 3.6 we have

$$
\sin \angle E A D \leq 4 \max \{w / L, L / r\}
$$

We observe $(z \in[0,1])$

$$
\sin \angle E A D \leq z \quad \Leftrightarrow \angle E A D \in[0, \arcsin z] \cup[\pi-\arcsin z, \pi] ; \quad \arcsin z \leq \pi z / 2
$$

Thus the subset of $\mathbb{S}^{1}$ consisting all possible directions of $A E$ has a measure smaller or equal to $8 \pi \max \{w / L, L / r\}$. This proves part (a). For part (b), a similar argument shows

$$
\sin \angle D A B, \sin \angle D A C \leq 4 \max \{w / L, L / r\}
$$

Thus

$$
\sin \angle B A C \leq \sin \angle D A B+\sin \angle D A C \leq 8 \max \{w / L, L / r\}
$$

Lemma 3.8. Let $A, B, C \in \Omega^{*}$ so that $|A B|,|A C| \geq 3 \sqrt{w r}$. Then we have

$$
2 r \sin \angle B A C-2 \sqrt{w r}-2 w<|B C|<2 r \sin \angle B A C+2 \sqrt{w r} .
$$

Proof. First of all, we claim that the line $A B$ must intersect the inner boundary of $\Omega^{*}$ at two different points, otherwise the length $|A B|$ can never exceed $2 \sqrt{w(2 r-w)}$. Let $D, E, F, G$ be the intersection points of the line $A B$ with the boundary of $\Omega^{*}$, as shown in figure 7 so that $A$ is on the line segment $D E$. We have $|D G|>|A B| \geq 3 \sqrt{w r}$. In addition

$$
(|D G|-|F G|) \cdot|F G|=|D F| \cdot|F G|=w(2 r-w)<2 w r, \quad|F G| \leq|D G| / 2
$$

This immediately gives $|D E|=|F G|<\sqrt{w r}$. As a result, $B$ must be on the line segment $F G$. Let $B^{*}$ be the point on the line segment $F G$ so that $|O A|=\left|O B^{*}\right|$. We always have $\left|B B^{*}\right|<|F G|<\sqrt{w r}$. We may define $C^{*}$ in a similar way, as shown in figure 7 Again we have $\left|C C^{*}\right|<\sqrt{w r}$. Since $A, B^{*}, C^{*}$ is on the same circle of radius $|O A| \in(r-w, r)$, we have

$$
2(r-w) \sin \angle B A C<\left|B^{*} C^{*}\right|<2 r \sin \angle B A C .
$$

Therefore
$|B C| \leq\left|B B^{*}\right|+\left|B^{*} C^{*}\right|+\left|C^{*} C\right|<2 r \sin \angle B A C+2 \sqrt{w r} ;$
$|B C| \geq\left|B^{*} C^{*}\right|-\left|B B^{*}\right|-\left|C^{*} C\right|>2(r-w) \sin \angle B A C-2 \sqrt{w r} \geq 2 r \sin \angle B A C-2 \sqrt{w r}-2 w$.


Figure 7: estimate of $|B C|$

Corollary 3.9. Let $A, B, C \in \Omega^{*}$ so that $|A B|,|B C|,|C A| \geq 4 \sqrt{w r}$. Then
(a) $r \sin \angle B A C<|B C|<4 r \sin \angle B A C$;
(b) $|\triangle A B C| \simeq|A B| \cdot|B C| \cdot|C A| / r$.

Proof. We may rewrite the conclusion of Lemma 3.8 in the form of

$$
|B C|-2 \sqrt{w r}<2 r \sin \angle B A C<|B C|+2 \sqrt{w r}+2 w .
$$

We then combine this inequality with the assumption $|B C| \geq 4 \sqrt{w r}$

$$
\frac{1}{2}|B C|<2 r \sin \angle B A C<2|B C| .
$$

This proves part (a). Part (b) immediately follows part (a) and the basic formula

$$
|\triangle A B C|=\frac{1}{2}|A B| \cdot|A C| \sin \angle B A C .
$$

Corollary 3.10. Let $A, B, C \in \Omega^{*}$ so that $|A B|,|A C| \geq 4 \sqrt{w r}$. Then

$$
|\triangle A B C| \lesssim \frac{|A B| \cdot|A C| \cdot \max \{|B C|, \sqrt{w r}\}}{r}
$$

Proof. If $|B C| \geq 4 \sqrt{w r}$, then we may apply Corollary 3.9 and finish the proof. If $|B C|<4 \sqrt{w r}$, then Lemma 3.8 implies

$$
2 r \sin B A C<|B C|+2 \sqrt{w r}+2 w<8 \sqrt{w r} \quad \Rightarrow \quad \sin B A C<4 \sqrt{w r} / r .
$$

This immediately gives

$$
|\triangle A B C|=\frac{1}{2}|A B| \cdot|A C| \sin \angle B A C \leq \frac{|A B| \cdot|A C| \cdot 2 \sqrt{w r}}{r}
$$

Lemma 3.11 (Area by angle). Let $A \in \Omega^{*}$ and $K \subset \mathbb{S}^{1}$ be measurable. Then

$$
\left|\Omega^{*} \cap\left\{A+l \Theta \in \mathbb{R}^{2}: l \in \mathbb{R}^{+}, \Theta \in K\right\}\right| \leq 4 w r|K| .
$$

Proof. It suffices to consider the case $K=(\theta, \theta+d \theta)$. Here we slightly abuse the notation, the angle $\theta$ actually represent the direction $\Theta=(\cos \theta, \sin \theta) \in \mathbb{S}^{1}$. Let $B$ (or $\left.B^{*}\right)$ be the point where the ray $A+l \Theta$ meets the outer boundary of the annulus $\Omega^{*}$. We consider two cases. Case 1 , if $\left|A B^{*}\right| \leq 2 \sqrt{2 w r}$ is relatively short, then we have

$$
d S \leq \frac{1}{2}\left|A B^{*}\right|^{2} d \theta \leq 4 w r d \theta
$$

Case 2, if $|A B|>2 \sqrt{2 w r}$ is long, then we claim that the segment $A B$ must intersect with the inner boundary of $\Omega^{*}$ at two different points. Otherwise the length $|A B|$ can never exceed $2 \sqrt{w(2 r-w)}$. Let $E, F, C, B$ be the intersection points of line $A B$ with the boundary circles of $\Omega^{*}$, as shown in figure 8 We have

$$
|E C| \cdot|B C|=w(2 r-w)
$$

Thus we have $(|A F| \leq|E F|=|B C| \leq|E C|)$

$$
d S=\left[\left(|A C|+\frac{1}{2}|B C|\right)|B C|+\frac{1}{2}|A F|^{2}\right] d \theta \leq(|E C|+|E F|)|B C| d \theta \leq 4 w r d \theta
$$



Figure 8: Area by angle

Corollary 3.12. Let $A \in \Omega^{*}, B \in \mathbb{R}^{2} \backslash\{A\}$ and $z \in \mathbb{R}^{+}$. Then

$$
\left|\left\{C \in \Omega^{*}: \sin \angle B A C \leq z\right\}\right| \leq 8 \pi z w r
$$

Proof. If $z \geq 1$, then the inequality is trivial since $\left|\Omega^{*}\right| \leq 2 \pi w r$. If $z \in(0,1)$, then

$$
\sin \angle B A C \leq z \quad \Leftrightarrow \quad \angle B A C \in[0, \arcsin z] \cup[\pi-\arcsin z, \pi] .
$$

We then utilize the inequality $\arcsin z \leq \pi z / 2$ and apply Lemma 3.11 to complete the proof.
Remark 3.13. The following will also be used in the subsequent section: Assume $A, B \in \mathbb{R}^{2}$, $L, z \in \mathbb{R}^{+}$. Let $K \subset \mathbb{S}^{1}$ be measurable. Then we have

$$
\begin{aligned}
\left|\left\{A+l \Theta \in \mathbb{R}^{2}: l \in(0, L), \Theta \in K\right\}\right| & \leq \frac{1}{2} L^{2}|K| \\
\left|\left\{C \in \mathbb{R}^{2}:|C A| \leq L, \sin \angle B A C \leq z\right\}\right| & \leq \pi L^{2} z
\end{aligned}
$$

Lemma 3.14 (Area by distance). Let $A \in \Omega^{*}$ and $L>0$. Then

$$
\left|\Omega^{*} \cap B(A, L)\right| \leq 2 \pi L w
$$

Here $B(A, L)$ is the disk of radius $L$ centered at $A$.
Proof. This is trivial if $L<2 w$ because in this case $2 \pi L w>\pi L^{2}=|B(A, L)|$. Let us assume $L \geq 2 w$. Given any point $B \in B(A, L) \cap \Omega^{*}$, let $C, D$ be the intersection points of the rays $O A$, $O B$ with the outer boundary of $\Omega^{*}$, as shown in figure 9 We have

$$
2 r \sin \frac{\angle A O B}{2}=|C D| \leq|A B|+|A C|+|B D| \leq L+2 w \leq 2 L
$$

Thus $\angle A O B \leq \pi L / r$. This immediately gives

$$
\left|\Omega^{*} \cap B(A, L)\right| \leq \frac{2 \pi L}{r} \cdot w r=2 \pi L w .
$$

## 4 Proof of Geometric Inequality

In this section we prove
Proposition 4.1. Let $\Omega^{*} \subset \mathbb{R}^{2}$ be a circular annulus region with outer radius $r$ and width $w$. Here $w \leq r$. Then

$$
\sup _{D, E, F \in \Omega^{*}} \int_{\Sigma(D E F) \cap\left(\Omega^{*}\right)^{3}} \frac{1}{|\triangle X Y Z|} d X d Y d Z \lesssim w^{3} r
$$

Here $\Sigma(D E F)$ is the set of all reciprocal triples of $(D, E, F)$ in $\mathbb{R}^{2}$, as defined in Lemma 2.1.
Remark 4.2. The upper bound given above is optimal. We choose three angles $\theta_{1}=0, \theta_{2}=$ $2 \pi / 3, \theta_{3}=4 \pi / 3$, and three regions accordingly by polar coordinates ( $\varepsilon_{1}$ is a small constant)

$$
\Omega_{k}=\left\{(\rho \cos \theta, \rho \sin \theta): r-\min \left\{w, \varepsilon_{1} r\right\}<\rho<r, \theta_{k}-\varepsilon_{1}<\theta<\theta_{k}+\varepsilon_{1}\right\}
$$

as show in figure 10. If we choose triples $(D, E, F),(X, Y, Z) \in \Omega_{1} \times \Omega_{2} \times \Omega_{3}$, then $\triangle D E F$ and $\triangle X Y Z$ are reciprocal to each other, as long as the constant $\varepsilon_{1}$ is sufficiently small. It is because these triangles are among the biggest triangles in the disk of radius $r$. This implies if we fix $(D, E, F) \in \Omega_{1} \times \Omega_{2} \times \Omega_{3}$, then

$$
\int_{\Sigma(D E F) \cap\left(\Omega^{*}\right)^{3}} \frac{d X d Y d Z}{|\triangle X Y Z|} \gtrsim \int_{\Omega_{1} \times \Omega_{2} \times \Omega_{3}} \frac{d X d Y d Z}{|\triangle X Y Z|} \gtrsim \frac{\left(\varepsilon_{1} r \min \left\{w, \varepsilon_{1} r\right\}\right)^{3}}{r^{2}} \gtrsim w^{3} r .
$$

Sizes and angles In order to take advantage of the geometric properties of reciprocal triangles, we sort all reciprocal triangles $\triangle X Y Z$ by their sizes and angles. We choose dyadic sequences of sizes:

$$
L \in\{r, r / 2, r / 4, \cdots\} .
$$

We say that $\triangle X Y Z$ is of size $L$ if and only if $L \leq \max \{|X Y|,|X Z|,|Y Z|\}<2 L$. Without loss of generality we also assume that $\angle Y X Z$ is the smallest among the three angles of $\triangle X Y Z$. Thus we have $|Y Z|=\min \{|X Y|,|X Z|,|Y Z|\}$. If $\triangle X Y Z$ is of size $L$, then $L / 2 \leq|X Y|,|X Z|<2 L$. As a result, we define (the upper bound of $\phi_{L}$ can be determined by Lemma 3.7)

$$
\phi_{L} \doteq \sup \left\{\sin \angle Y X Z: X, Y, Z \in \Omega^{*}, L / 2 \leq|X Y|,|X Z|<2 L\right\} \lesssim \max \{w / L, L / r\}
$$

and

$$
\Phi_{n}^{L}=\left\{\theta \in(0, \pi): 2^{-n-1} \phi_{L}<\sin \theta \leq 2^{-n} \phi_{L}\right\}, \quad n \geq 0 .
$$

We always have

$$
\begin{equation*}
\left|\Phi_{n}^{L}\right| \lesssim 2^{-n} \phi_{L} \tag{13}
\end{equation*}
$$

We then sort all reciprocal triangles $\triangle X Y Z$ of a given triangle $\triangle D E F$ by their sizes and angles. We define

$$
\Omega_{L, n}=\left\{(X, Y, Z) \in\left(\Omega^{*}\right)^{3}: \begin{array}{c}
\triangle X Y Z \text { is a reciprocal triangle of } \triangle D E F \text { whose size is } L \\
\text { and whose smallest interior angle } \angle Y X Z \text { is in } \Phi_{n}^{L}
\end{array}\right\} .
$$

We immediately have for a fixed triangle $\triangle D E F$

$$
\begin{equation*}
\int_{\Sigma(D E F) \cap\left(\Omega^{*}\right)^{3}} \frac{1}{|\triangle X Y Z|} d X d Y d Z \leq 3 \sum_{L, n} \int_{\Omega_{L, n}} \frac{1}{|\triangle X Y Z|} d X d Y d Z \tag{14}
\end{equation*}
$$

For convenience we also assume that the size of $\triangle D E F$ is $M$ and the smallest angle of $\triangle D E F$ is $\angle E F D$. We split the big sum in the right hand side into three parts: large sizes $L \gg M$, small sizes $L \ll M$ and comparable sizes $L \simeq M$.

### 4.1 Large sizes

We first consider the case that the size $L$ of $\triangle X Y Z$ is much larger than that of $\triangle D E F$. According to our classification of reciprocal triangles, we consider two cases, i.e. Type I reciprocal triangles and Type II reciprocal triangles. We write

$$
\Omega_{L, n}=\Omega_{L, n}^{1} \cup \Omega_{L, n}^{2}
$$

Here

$$
\begin{aligned}
& \Omega_{L, n}^{1}=\left\{(X, Y, Z) \in \Omega_{L, n}: \triangle X Y Z \text { and } \triangle D E F \text { are Type I reciprocal }\right\} \\
& \Omega_{L, n}^{2}=\left\{(X, Y, Z) \in \Omega_{L, n}: \triangle X Y Z \text { and } \triangle D E F \text { are Type II reciprocal }\right\}
\end{aligned}
$$

Type I In this case we have $|D Y|,|E Y|,|F Y| \simeq L \gg M$. According to Lemma 3.1, we have either $|\triangle F D Y| \gtrsim(L / M)|\triangle D E F|$ or $|\triangle F E Y| \gtrsim(L / M)|\triangle D E F|$. Without loss of generality let us assume the latter one ${ }^{11}$ A combination of this and the reciprocal assumption implies

$$
|\triangle D X Z| \lesssim(M / L)|\triangle X Y Z| \quad \Rightarrow \quad|D X| \cdot|X Z| \sin \angle D X Z \lesssim(M / L)|X Y| \cdot|X Z| \sin \angle Y X Z
$$

Thus we have

$$
|D X| \sin \angle D X Z \lesssim M \sin \angle Y X Z \simeq M \cdot 2^{-n} \phi_{L} .
$$

This means that if $(X, Y, Z) \in \Omega_{L, n}^{1}$, then at least one of the following holds (see figure (11)

- $|D X| \lesssim 2^{-n / 2} r^{1 / 2} M^{1 / 2} \phi_{L}^{1 / 2} ;$
- $\sin \angle D X Z \lesssim 2^{-n / 2} r^{-1 / 2} M^{1 / 2} \phi_{L}^{1 / 2}$.

We may write $\Omega_{L, n}^{1}=\Omega_{L, n}^{1,1} \cup \Omega_{L, n}^{1,2}$ as a union of two parts accordingly. Here we define

$$
\begin{aligned}
& \Omega_{L, n}^{1,1}=\left\{(X, Y, Z) \in \Omega_{L, n}^{1}:|D X| \lesssim 2^{-n / 2} r^{1 / 2} M^{1 / 2} \phi_{L}^{1 / 2}\right\} \\
& \Omega_{L, n}^{1,2}=\left\{(X, Y, Z) \in \Omega_{L, n}^{1}: \sin \angle D X Z \lesssim 2^{-n / 2} r^{-1 / 2} M^{1 / 2} \phi_{L}^{1 / 2}\right\}
\end{aligned}
$$

Now we are ready to find the upper bounds of the integrals $(k=1,2)$

\int_{\Omega_{L, n}^{1, k}} \frac{1}{|\triangle X Y Z|} d X d Y d Z
$$

Let us first consider the case $L \geq \sqrt{w r}$ and $k=1$. It is clear that

$$
\int_{\Omega_{L, n}^{1,1}} \frac{1}{|\triangle X Y Z|} d X d Y d Z \lesssim \frac{\left|\Omega_{L, n}^{1,1}\right|}{2^{-n} L^{2} \phi_{L}}
$$

Next we give an upper bound of the measure of $\Omega_{L, n}^{1,1}$. First of all, we observe

$$
\Omega_{L, n}^{1,1} \subset \tilde{\Omega} \doteq\left\{(X, Y, Z) \in\left(\Omega^{*}\right)^{3}:|D X| \lesssim 2^{-n / 2} r^{1 / 2} M^{1 / 2} \phi_{L}^{1 / 2},|X Y|<2 L, \angle Z X Y \in \Phi_{n}^{L}\right\}
$$

Thus we may find an upper bound of the measure of $\tilde{\Omega}$ instead. According to Lemma 3.14 the area of region $\left\{X \in \Omega^{*}:|D X| \lesssim 2^{-n / 2} r^{1 / 2} M^{1 / 2} \phi_{L}^{1 / 2}\right\}$ is dominated by $2^{-n / 2} w r^{1 / 2} M^{1 / 2} \phi_{L}^{1 / 2}$ (up to a constant multiple). Furthermore, given such a point $X$, we may apply Lemma 3.14 again and obtain that the area of the region $\left\{Y \in \Omega^{*}:|X Y|<2 L\right\}$ is dominated by $w L$. Finally, given a pair $(X, Y)$ as above, the area of the region $\left\{Z \in \Omega^{*}: \angle Z X Y \in \Phi_{n}^{L}\right\}$ is dominated by $\operatorname{wr}\left(2^{-n} \phi_{L}\right)$, thanks to Corollary 3.12, A product of the three upper bounds above gives the upper bound of $|\tilde{\Omega}|$. In summary we always have

$$
\left|\Omega_{L, n}^{1,1}\right| \lesssim 2^{-n / 2} w r^{1 / 2} M^{1 / 2} \phi_{L}^{1 / 2} \cdot w L \cdot 2^{-n} w r \phi_{L} \lesssim 2^{-3 n / 2} w^{3} r^{3 / 2} M^{1 / 2} L \phi_{L}^{3 / 2}
$$

Thus we have (In this case $\phi_{L} \lesssim L / r$ )

$$
\int_{\Omega_{L, n}^{1,1}} \frac{1}{|\triangle X Y Z|} d X d Y d Z \lesssim 2^{-n / 2} w^{3} r^{3 / 2} M^{1 / 2} L^{-1} \phi_{L}^{1 / 2} \lesssim 2^{-n / 2} w^{3} r M^{1 / 2} L^{-1 / 2}
$$

If $L \geq \sqrt{w r}$, the case $k=2$ can be dealt with in the same way. We observe

$$
\Omega_{L, n}^{1,2} \subset\left\{(X, Y, Z) \in\left(\Omega^{*}\right)^{3}:|D X| \lesssim M, \sin \angle D X Z \lesssim 2^{-n / 2} r^{-1 / 2} M^{1 / 2} \phi_{L}^{1 / 2}, \angle Z X Y \in \Phi_{n}^{L}\right\}
$$

We first choose an $X$ with $|D X| \lesssim M$, then determine the region containing all possible $Z$ 's by the angle $\angle D X Z$, and finally determine the region of $Y$ by the angle $\angle Z X Y$. This gives an upper bound

$$
\begin{aligned}
\int_{\Omega_{L, n}^{1,2}} \frac{1}{|\triangle X Y Z|} d X d Y d Z & \lesssim \frac{(w M) \cdot\left(w r \cdot 2^{-n / 2} r^{-1 / 2} M^{1 / 2} \phi_{L}^{1 / 2}\right) \cdot\left(w r \cdot 2^{-n} \phi_{L}\right)}{L^{2} \cdot 2^{-n} \phi_{L}} \\
& \lesssim 2^{-n / 2} w^{3} r M^{3 / 2} L^{-3 / 2}
\end{aligned}
$$

We may deal with the case $M \ll L<\sqrt{w r}$ in exactly the same way by using Remark 3.13, Lemma 3.14 and $\phi_{L} \lesssim w / L$. The upper bounds are given by

$$
\begin{aligned}
\int_{\Omega_{L, n}^{1,1}} \frac{1}{|\triangle X Y Z|} d X d Y d Z & \lesssim \frac{\left(w \cdot 2^{-n / 2} r^{1 / 2} M^{1 / 2} \phi_{L}^{1 / 2}\right) \cdot(w L) \cdot\left(L^{2} \cdot 2^{-n} \phi_{L}\right)}{L^{2} \cdot 2^{-n} \phi_{L}} \\
& \lesssim 2^{-n / 2} w^{5 / 2} r^{1 / 2} M^{1 / 2} L^{1 / 2} ; \\
\int_{\Omega_{L, n}^{1,2}} \frac{1}{|\triangle X Y Z|} d X d Y d Z & \lesssim \frac{(w M) \cdot\left(L^{2} \cdot 2^{-n / 2} r^{-1 / 2} M^{1 / 2} \phi_{L}^{1 / 2}\right) \cdot\left(L^{2} \cdot 2^{-n} \phi_{L}\right)}{L^{2} \cdot 2^{-n} \phi_{L}} \\
& \lesssim 2^{-n / 2} w^{3 / 2} r^{-1 / 2} M^{3 / 2} L^{3 / 2}
\end{aligned}
$$

We may combine all the upper bounds above and conclude

$$
\sum_{L \gg M, n \geq 0} \int_{\Omega_{L, n}^{1}} \frac{1}{|\triangle X Y Z|} d X d Y d Z \lesssim w^{3} r .
$$

Type II We may further write $\Omega_{L, n}^{2}=\Omega_{L, n}^{2 a} \cup \Omega_{L, n}^{2 b}$ with

$$
\begin{aligned}
& \Omega_{L, n}^{2 a}=\left\{(X, Y, Z) \in \Omega_{L, n}^{2}:|Z D|,|Z E|,|Z F| \lesssim M\right\} \\
& \Omega_{L, n}^{2 b}=\left\{(X, Y, Z) \in \Omega_{L, n}^{2}:|Y D|,|Y E|,|Y F| \lesssim M\right\}
\end{aligned}
$$

These two cases can be dealt with in exactly the same way. Let us consider the Type IIa reciprocal triangles, for instance. In this case

$$
|X Y|,|X Z|,|X D|,|X E|,|X F| \simeq L
$$

By our reciprocal assumption, we have (see figure 12)

$$
|\triangle F D Z| \cdot|\triangle E X Y| \lesssim|\triangle D E F| \cdot|\triangle X Y Z|
$$

That is
$(|D Z| \cdot|D F| \sin \angle F D Z)(|X E| \cdot|X Y| \sin \angle E X Y) \lesssim(|D F| \cdot|F E| \sin \angle D F E)(|X Y| \cdot|X Z| \sin \angle Y X Z)$.
Canceling $|D F|,|X Y|$ and plugging $|F E| \simeq M,|X Z|,|X E| \simeq L$ in, we have

$$
|D Z|(\sin \angle F D Z)(\sin \angle E X Y) \lesssim M(\sin \angle D F E) \sin \angle Y X Z \lesssim M \phi_{M} \sin \angle Y X Z
$$

Following the same argument as in the Type I case, we may write $\Omega_{L, n}^{2 a}=\Omega_{L, n}^{2 a, 1} \cup \Omega_{L, n}^{2 a, 2} \cup \Omega_{L, n}^{2 a, 3}$. Here we define

$$
\begin{aligned}
& \Omega_{L, n}^{2 a, 1}=\left\{(X, Y, Z) \in \Omega_{L, n}^{2 a}:|D Z| \lesssim 2^{-n / 3} r^{2 / 3} M^{1 / 3} \phi_{M}^{1 / 3} \phi_{L}^{1 / 3}\right\} \\
& \Omega_{L, n}^{2 a, 2}=\left\{(X, Y, Z) \in \Omega_{L, n}^{2 a}: \sin \angle F D Z \lesssim 2^{-n / 3} r^{-1 / 3} M^{1 / 3} \phi_{M}^{1 / 3} \phi_{L}^{1 / 3}\right\} ; \\
& \Omega_{L, n}^{2 a, 3}=\left\{(X, Y, Z) \in \Omega_{L, n}^{2 a}: \sin \angle E X Y \lesssim 2^{-n / 3} r^{-1 / 3} M^{1 / 3} \phi_{M}^{1 / 3} \phi_{L}^{1 / 3}\right\} .
\end{aligned}
$$

We then give upper bounds of the integrals below as in the Type I case: If $L \geq \sqrt{w r}$, then

$$
\begin{aligned}
\int_{\Omega_{L, n}^{2 a, k}} \frac{1}{|\triangle X Y Z|} d X d Y d Z & \lesssim \frac{\left(w \cdot 2^{-n / 3} r^{2 / 3} M^{1 / 3} \phi_{M}^{1 / 3} \phi_{L}^{1 / 3}\right) \cdot(L w) \cdot\left(w r \cdot 2^{-n} \phi_{L}\right)}{L^{2} \cdot 2^{-n} \phi_{L}} \\
& \lesssim 2^{-n / 3} w^{3} r^{4 / 3} L^{-2 / 3}\left(M \phi_{M}\right)^{1 / 3} .
\end{aligned}
$$

On the other hand, if $M \ll L<\sqrt{w r}$, then

$$
\begin{aligned}
\int_{\Omega_{L, n}^{2 a, k}} \frac{1}{|\triangle X Y Z|} d X d Y d Z & \lesssim \frac{\left(w \cdot 2^{-n / 3} r^{2 / 3} M^{1 / 3} \phi_{M}^{1 / 3} \phi_{L}^{1 / 3}\right) \cdot(L w) \cdot\left(L^{2} \cdot 2^{-n} \phi_{L}\right)}{L^{2} \cdot 2^{-n} \phi_{L}} \\
& \lesssim 2^{-n / 3} w^{8 / 3} r^{2 / 3} L^{2 / 3}
\end{aligned}
$$

Finally we recall $M \phi_{M} \lesssim M^{2} / r$ if $M \geq \sqrt{w r}$ and $M \phi_{M} \lesssim w$ if $M \leq \sqrt{w r}$, then take a sum for all $L \gg M$ and $n \geq 0$.

$$
\sum_{L \gg M, n \geq 0} \int_{\Omega_{L, n}^{2 a}} \frac{1}{|\triangle X Y Z|} d X d Y d Z \lesssim w^{3} r .
$$

A similar inequality holds for Type IIb reciprocal triangles.

Summary We may combine Type I and II cases and obtain that for any given $\triangle D E F$, we have

$$
\sum_{L \gg M, n \geq 0} \int_{\Omega_{L, n}} \frac{1}{|\triangle X Y Z|} d X d Y d Z \lesssim w^{3} r .
$$

Please note that the implicit constant in the inequality is an absolute constant, i.e. independent of $\triangle D E F$.

### 4.2 Small sizes

We assume the size $L$ of $\triangle X Y Z$ is much smaller than that of $\triangle D E F$, i.e. $L \ll M$. Again we consider Type I and II reciprocal triangles separately. We define

$$
\begin{aligned}
& \Omega_{L, n}^{1}=\left\{(X, Y, Z) \in \Omega_{L, n}: \triangle X Y Z \text { and } \triangle D E F \text { are Type I reciprocal }\right\} \\
& \Omega_{L, n}^{2}=\left\{(X, Y, Z) \in \Omega_{L, n}: \triangle X Y Z \text { and } \triangle D E F \text { are Type II reciprocal }\right\}
\end{aligned}
$$

Type I By our reciprocal assumption we always have (please see figure 13)

$$
|\triangle X D Y| \cdot|\triangle Z E F| \lesssim|\triangle X Y Z| \cdot|\triangle D E F|
$$

Thus

$$
(|D Y| \cdot|D X| \sin \angle X D Y)(|E Z| \cdot|E F| \sin \angle Z E F) \lesssim\left(L^{2} \sin \angle Y X Z\right)|\triangle D E F|
$$

Our assumption implies $|D X|,|D Y|,|E Z|,|E F| \simeq M$. Thus if $(X, Y, Z) \in \Omega_{L, n}^{1}$, we have

$$
(\sin \angle X D Y)(\sin \angle Z E F) \lesssim 2^{-n} M^{-4} L^{2} \phi_{L}|\triangle D E F|
$$

Thus we have $\Omega_{L, n}^{1}=\Omega_{L, n}^{1,1} \cup \Omega_{L, n}^{1,2}$ with

$$
\begin{aligned}
& \Omega_{L, n}^{1,1}=\left\{(X, Y, Z) \in \Omega_{L, n}^{1}: \sin \angle X D Y \lesssim 2^{-n / 2} M^{-2} L \phi_{L}^{1 / 2}|\triangle D E F|^{1 / 2}\right\} \\
& \Omega_{L, n}^{1,2}=\left\{(X, Y, Z) \in \Omega_{L, n}^{1}: \sin \angle Z E F \lesssim 2^{-n / 2} M^{-2} L \phi_{L}^{1 / 2}|\triangle D E F|^{1 / 2}\right\}
\end{aligned}
$$

If $M \gg L \geq \sqrt{r w}$, then we have (please note that $|X F| \lesssim L, \phi_{L} \lesssim L / r$ and $|\triangle D E F| \lesssim M^{3} / r$ )

$$
\begin{aligned}
\int_{\Omega_{L, n}^{1, k}} \frac{1}{|\triangle X Y Z|} d X d Y d Z & \lesssim \frac{(L w) \cdot\left(w r \cdot 2^{-n / 2} M^{-2} L \phi_{L}^{1 / 2}|\triangle D E F|^{1 / 2}\right) \cdot\left(w r \cdot 2^{-n} \phi_{L}\right)}{L^{2} \phi_{L} 2^{-n}} \\
& \lesssim \frac{2^{-n / 2} w^{3} r L^{1 / 2}}{M^{1 / 2}} .
\end{aligned}
$$



Figure 13: Small size, Type I reciprocal triangles

If $L<\sqrt{r w} \leq M$, then we have $\left(\phi_{L} \lesssim w / L\right)$

$$
\begin{aligned}
\int_{\Omega_{L, n}^{1, k}} \frac{1}{|\triangle X Y Z|} d X d Y d Z & \lesssim \frac{(L w) \cdot\left(w r \cdot 2^{-n / 2} M^{-2} L \phi_{L}^{1 / 2}|\triangle D E F|^{1 / 2}\right) \cdot\left(L^{2} \cdot 2^{-n} \phi_{L}\right)}{L^{2} \cdot 2^{-n} \phi_{L}} \\
& \lesssim \frac{2^{-n / 2} w^{5 / 2} r^{1 / 2} L^{3 / 2}}{M^{1 / 2}} .
\end{aligned}
$$

Finally, if $L \ll M \leq \sqrt{w r}$, then we have $\left(\phi_{L} \lesssim w / L ;|Z E|,|D Y| \lesssim M\right.$ and $\left.|\triangle D E F| \lesssim M w\right)$

$$
\begin{aligned}
\int_{\Omega_{L, n}^{1, k}} \frac{1}{|\triangle X Y Z|} d X d Y d Z & \lesssim \frac{(L w) \cdot\left(M^{2} \cdot 2^{-n / 2} M^{-2} L \phi_{L}^{1 / 2}|\triangle D E F|^{1 / 2}\right) \cdot\left(L^{2} \cdot 2^{-n} \phi_{L}\right)}{L^{2} \cdot 2^{-n} \phi_{L}} \\
& \lesssim 2^{-n / 2} w^{2} M^{1 / 2} L^{3 / 2}
\end{aligned}
$$

Collecting the upper bounds above and taking a sum, we always have

$$
\sum_{L \ll M, n \geq 0} \int_{\Omega_{L, n}^{1}} \frac{1}{|\triangle X Y Z|} d X d Y d Z \lesssim w^{3} r .
$$

Type II Now we consider small, type II reciprocal triangles of a given triangle $\triangle D E F$. This is the most difficult case. Let $\triangle X Y Z$ of size $L$ be a Type II reciprocal triangle of $D E F$. Let us first give an upper bound of the integral

$$
\int_{\Omega_{L, n}^{2}} \frac{1}{|\triangle X Y Z|} d X d Y d Z
$$

for given $L \ll M, n \geq 0$. Without loss of generality, let us assume ${ }^{2}$

$$
|D X|,|D Y|,|D Z| \lesssim L ; \quad|\triangle Z E F| \gtrsim|\triangle D E F|
$$

Thus by reciprocal assumption we immediately have

$$
|\triangle D X Y| \lesssim|\triangle X Y Z|
$$

Since $|X Y| \simeq L$ and $|D X|,|D Y| \lesssim L$, at least one of the following holds (see figure 14)

- $|D X| \simeq L$. By comparing the area of $\triangle D X Y$ with that of $\triangle X Y Z$ we have

$$
|D X| \cdot|X Y| \sin \angle D X Y \lesssim|X Y| \cdot|X Z| \sin \angle Y X Z \Rightarrow \sin \angle D X Y \lesssim \sin \angle Y X Z
$$



Figure 14: Small size, Type II reciprocal triangles

- $|D Y| \simeq L$. By considering the area of $\triangle D X Y$ we have $\sin \angle D Y X \lesssim \sin \angle Y X Z$.

Thus the region $\Omega_{L, n}^{2}$ is the union of two parts:

$$
\begin{aligned}
& \Omega_{L, n}^{2,1}=\left\{(X, Y, Z) \in \Omega_{L, n}^{2}: \sin \angle D X Y \lesssim 2^{-n} \phi_{L}\right\} \\
& \Omega_{L, n}^{2,2}=\left\{(X, Y, Z) \in \Omega_{L, n}^{2}: \sin \angle D Y X \lesssim 2^{-n} \phi_{L}\right\}
\end{aligned}
$$

If $L \geq \sqrt{w r}$, we may find an upper bound of the integrals $\left(k=1,2, \phi_{L} \lesssim L / r\right)$

$$
\begin{equation*}
\int_{\Omega_{L, n}^{2, k}} \frac{1}{|\triangle X Y Z|} d X d Y d Z \lesssim \frac{(L w) \cdot\left(w r \cdot 2^{-n} \phi_{L}\right) \cdot\left(w r \cdot 2^{-n} \phi_{L}\right)}{L^{2} \cdot 2^{-n} \phi_{L}} \lesssim 2^{-n} w^{3} r^{2} L^{-1} \phi_{L} \lesssim 2^{-n} w^{3} r \tag{15}
\end{equation*}
$$

Similarly if $L<\sqrt{w r}$, then we have $\left(\phi_{L} \lesssim w / L\right)$

$$
\begin{equation*}
\int_{\Omega_{L, n}^{2, k}} \frac{1}{|\triangle X Y Z|} d X d Y d Z \lesssim \frac{(L w) \cdot\left(L^{2} \cdot 2^{-n} \phi_{L}\right) \cdot\left(L^{2} \cdot 2^{-n} \phi_{L}\right)}{L^{2} \cdot 2^{-n} \phi_{L}} \lesssim 2^{-n} w^{2} L^{2} \tag{16}
\end{equation*}
$$

We may collect the upper bounds above and obtain

$$
\sum_{L \ll M, L \leq 32 \sqrt{w r}} \sum_{n \geq 0} \int_{\Omega_{L, n}^{2}} \frac{1}{|\triangle X Y Z|} d X d Y d Z \lesssim w^{3} r
$$

and

$$
\begin{aligned}
\sum_{32 \sqrt{w r}<L \ll M}\left(\sum_{n>\log _{2} \frac{\phi_{L} r^{1 / 2}}{8 w^{1 / 2}}} \int_{\Omega_{L, n}^{2}} \frac{d X d Y d Z}{|\triangle X Y Z|}\right) & \lesssim \sum_{32 \sqrt{w r}<L \ll M}\left(\sum_{n>\log _{2} \frac{\phi_{L} r^{1 / 2}}{8 w^{1 / 2}}} 2^{-n} w^{3} r^{2} L^{-1} \phi_{L}\right) \\
& \lesssim \sum_{32 \sqrt{w r}<L \ll M} w^{7 / 2} r^{3 / 2} L^{-1} \\
& \lesssim w^{3} r .
\end{aligned}
$$

[^1]Thus it suffices to consider $(X, Y, Z) \in \Omega_{L, n}^{2}$ with $32 \sqrt{w r}<L \ll M$ and $n \leq \log _{2}\left(\phi_{L} r^{1 / 2} / 8 w^{1 / 2}\right)$. We apply Lemma 3.8 and obtain

$$
\begin{align*}
& |Y Z| \geq 2 r \sin \angle Y X Z-2 \sqrt{w r}-2 w \geq 2 r \phi_{L} 2^{-n-1}-4 \sqrt{w r} \geq 4 \sqrt{w r}  \tag{17}\\
& |Y Z| \leq 2 r \sin \angle Y X Z+2 \sqrt{w r} \leq 2 r \phi_{L} 2^{-n}+2 \sqrt{w r} \leq 3 r \phi_{L} 2^{-n} \tag{18}
\end{align*}
$$

Next we first prove
Lemma 4.3. Let $(X, Y, Z) \in \Omega_{L, n}^{2}$ with $32 \sqrt{w r}<L \ll M$. In addition, we assume $|Y Z| \geq$ $4 \sqrt{w r}$. Then there exists an ansolute constant $c_{1}>0$ so that at least one of the following holds
(a) $c_{1}|D E| \leq L \leq 8|D E|$;
(b) $L>8|D E|$ and $\sin \angle E Y X \lesssim 2^{-n} r^{-1} \max \{|D E|, \sqrt{w r}\}$;
(c) $L>8|D E|$ and

$$
\min \{|D Y|,|D Z|,|E Y|,|E Z|\} \lesssim \min \{|Y Z|, \max \{|D E|, \sqrt{w r}\}\}
$$

Proof. The proof consists of three steps.
Step 1 We first show that $|D E| \lesssim L$. Without loss of generality we assume $|D X|,|D Y|,|D Z| \lesssim$ $L$ and $|X Y| \geq L$. If $|D E| \gg L$, then we would have

$$
|E X|,|E Y|,|E Z| \simeq|D E| \gg L>32 \sqrt{w r}
$$

Since $|X Y| \geq L$, we have either $|D X| \geq L / 2$ or $|D Y| \geq L / 2$. We consider these two cases separately. If $|D X| \geq L / 2$, then our reciprocal assumption implies

$$
|\triangle D E X| \cdot|\triangle Y Z F| \lesssim|\triangle D E F| \cdot|\triangle X Y Z|
$$

According to Corollary 3.9, the inequality above implies

$$
\frac{|D E| \cdot|E X| \cdot|D X|}{r} \cdot \frac{|Y Z| \cdot|Y F| \cdot|Z F|}{r} \lesssim \frac{|D E| \cdot|E F| \cdot|D F|}{r} \cdot \frac{|X Y| \cdot|X Z| \cdot|Y Z|}{r}
$$

We cancel $|Y Z|,|D E|$, recall the facts

$$
|E X| \simeq|D E|, \quad|D X|,|X Y|,|X Z| \simeq L, \quad|Y F|,|Z F|,|E F|,|D F| \simeq M
$$

and obtain $|D E| \lesssim L$. This is a contradiction. On the other hand, if $|D Y| \geq L / 2$, then we may follow a similar argument as above by considering $\triangle D E Y, \triangle X Z F$, and obtain

$$
\frac{|D E| \cdot|E Y| \cdot|D Y|}{r} \cdot \frac{|X Z| \cdot|X F| \cdot|Z F|}{r} \lesssim \frac{|D E| \cdot|E F| \cdot|D F|}{r} \cdot \frac{|X Y| \cdot|X Z| \cdot|Y Z|}{r}
$$

This gives $|D E| \simeq|E Y| \lesssim|Y Z| \lesssim L$. Again this is a contradiction. As a result we obtain $|D E| \lesssim L$. It immediately follows that

$$
|D X|,|D Y|,|D Z|,|E X|,|E Y|,|E Z| \lesssim L
$$

Please refer to figure 15 for an illustration of the proof. Our remaining task is to show that if $|D E|<L / 8$, then either (b) or (c) holds.


Figure 15: Large reciprocal triangles

Step 2 Now we assume $|D E|<L / 8$, there are two cases: $D, E$ are either both close to the point $X$ or both far away from $X$. In this step we assume $|D X|,|X E| \leq L / 4$. Since $|X Y|,|X Z|>L / 2$ we also have

$$
|D Y|,|E Y|,|D Z|,|E Z| \geq L / 4>8 \sqrt{w r}
$$

We consider the triangles $\triangle E X Y$ and $\triangle D Z F$. The reciprocal assumption immediately gives

$$
|\triangle E X Y| \cdot|\triangle D Z F| \lesssim|\triangle D E F| \cdot|\triangle X Y Z| .
$$

Thus we may apply Corollary 3.10 and obtain

$$
\begin{gathered}
\left(L^{2} \sin \angle E Y X\right) \cdot \frac{L M^{2}}{r} \lesssim \frac{M^{2} \max \{|D E|, \sqrt{w r}\}}{r} \cdot\left(L^{2} \cdot 2^{-n} \phi_{L}\right) \\
\Rightarrow \sin \angle E Y X \lesssim 2^{-n} r^{-1} \max \{|D E|, \sqrt{w r}\} .
\end{gathered}
$$

In other words, (b) holds. Please see the upper half of figure 16


Figure 16: Type II reciprocal triangles of a narrow triangle

Step 3 Finally we assume $|D E|<L / 8$ and $\max \{|D X|,|E X|\}>L / 4$. This implies that $|D X|,|E X| \geq L / 8>4 \sqrt{w r}$. If we have

$$
\min \{|D Y|,|D Z|,|E Y|,|E Z|\} \leq 4 \sqrt{w r}
$$

then our assumption on $|Y Z|$ automatically guarantees (c) holds. Therefore we may additionally assume

$$
\min \{|D Y|,|D Z|,|E Y|,|E Z|\}>4 \sqrt{w r} .
$$

Without loss of generality, we assume

$$
|D Z|=\max \{|D Y|,|D Z|,|E Y|,|E Z|\}
$$

We have

$$
2|D Z| \geq|D Z|+|D Y| \geq|Y Z| ; \quad 2|D Z| \geq|D Z|+|E Z| \geq|D E|
$$

Thus $|D Z| \geq|Y Z| / 2,|D Z| \geq \max \{|D E|, \sqrt{w r}\} / 2$. We next apply Corollary 3.9 and obtain

$$
|\triangle X D Z| \gtrsim|\triangle X Y Z| ; \quad|\triangle F D Z| \gtrsim|\triangle D E F|
$$

The reciprocal assumption then gives

$$
|\triangle E F Y| \lesssim|\triangle D E F| ; \quad|\triangle E X Y| \lesssim|\triangle X Y Z|
$$

We then apply Corollary 3.9 again and conclude (please refer to lower half of figure 16)

$$
|E Y| \lesssim \max \{|D E|, \sqrt{w r}\} ; \quad|E Y| \lesssim|Y Z|
$$

Thus (c) holds.
Completion of type II case First of all, we recall that it suffices to consider $(X, Y, Z) \in \Omega_{L, n}^{2}$ with $32 \sqrt{w r}<L \ll M$ and $n \leq \log _{2}\left(\phi_{L} r^{1 / 2} / 8 w^{1 / 2}\right)$. According to Lemma 4.3, the set $\Omega_{L, n}^{2}$ of this kind is empty unless $L \geq c_{1}|D E|$. Thus we may further assume $L \geq c_{1}|D E|$. We recall the upper bounds given in (15), (16) and obtain

$$
\sum_{c_{1}|D E| \leq L \leq 8|D E|} \sum_{n \geq 0} \int_{\Omega_{L, n}^{2}} \frac{1}{|\triangle X Y Z|} d X d Y d Z \lesssim w^{3} r .
$$

Therefore we only need to deal with $\Omega_{L, n}^{2}$ with $\max \{32 \sqrt{w r}, 8|D E|\}<L \ll M$ and $n \leq$ $\log _{2}\left(\phi_{L} r^{1 / 2} / 8 w^{1 / 2}\right)$. For convenience we use the notation $K=\max \{|D E|, \sqrt{w r}\}$. We recall (17), (18) and obtain that $(X, Y, Z) \in \Omega_{L, n}^{2}$ must satisfy $|Y Z| \geq 4 \sqrt{w r}$ and

$$
\min \{|Y Z|, \max \{|D E|, \sqrt{w r}\}\} \leq|Y Z|^{1 / 2} K^{1 / 2} \lesssim 2^{-n / 2} r^{1 / 2} \phi_{L}^{1 / 2} K^{1 / 2}
$$

According to Lemma 4.3, we may write

$$
\Omega_{L, n}^{2}=\bigcup_{k=1}^{5} \Omega_{L, n}^{2, k}
$$

Here we define

$$
\begin{aligned}
& \Omega_{L, n}^{2,1}=\left\{(X, Y, Z) \in \Omega_{L, n}^{2}: \sin \angle E Y X \lesssim 2^{-n} r^{-1} K\right\} ; \\
& \Omega_{L, n}^{2,2}=\left\{(X, Y, Z) \in \Omega_{L, n}^{2}:|D Y| \lesssim 2^{-n / 2} r^{1 / 2} \phi_{L}^{1 / 2} K^{1 / 2}\right\} ; \\
& \Omega_{L, n}^{2,3}=\left\{(X, Y, Z) \in \Omega_{L, n}^{2}:|D Z| \lesssim 2^{-n / 2} r^{1 / 2} \phi_{L}^{1 / 2} K^{1 / 2}\right\} ; \\
& \Omega_{L, n}^{2,4}=\left\{(X, Y, Z) \in \Omega_{L, n}^{2}:|E Y| \lesssim 2^{-n / 2} r^{1 / 2} \phi_{L}^{1 / 2} K^{1 / 2}\right\} ; \\
& \Omega_{L, n}^{2,5}=\left\{(X, Y, Z) \in \Omega_{L, n}^{2}:|E Z| \lesssim 2^{-n / 2} r^{1 / 2} \phi_{L}^{1 / 2} K^{1 / 2}\right\} .
\end{aligned}
$$

We then apply Lemma 3.14 Corollary 3.12 and obtain $(k=2,3,4,5)$

$$
\begin{aligned}
\int_{\Omega_{L, n}^{2,1}} \frac{1}{|\triangle X Y Z|} d X d Y d Z & \lesssim \frac{(w L) \cdot\left(w r \cdot 2^{-n} r^{-1} K\right) \cdot\left(w r \cdot 2^{-n} \phi_{L}\right)}{L^{2} \cdot 2^{-n} \phi_{L}} \lesssim 2^{-n} w^{3} r L^{-1} K \\
\int_{\Omega_{L, n}^{2, k}} \frac{1}{|\triangle X Y Z|} d X d Y d Z & \lesssim \frac{\left(w \cdot 2^{-n / 2} r^{1 / 2} \phi_{L}^{1 / 2} K^{1 / 2}\right) \cdot(w L) \cdot\left(w r \cdot 2^{-n} \phi_{L}\right)}{L^{2} \cdot 2^{-n} \phi_{L}} \\
& \lesssim 2^{-n / 2} w^{3} r K^{1 / 2} L^{-1 / 2}
\end{aligned}
$$

Thus

$$
\sum_{\max \{32 \sqrt{w r}, 8|D E|\}<L \ll M}\left(\sum_{n \leq \log _{2} \frac{\phi_{L} r^{1 / 2}}{8 w^{1 / 2}}} \int_{\Omega_{L, n}^{2}} \frac{1}{|\triangle X Y Z|} d X d Y d Z\right) \lesssim w^{3} r .
$$

In summary we have

$$
\sum_{L \ll M, n \geq 0} \int_{\Omega_{L, n}^{2}} \frac{1}{|\triangle X Y Z|} d X d Y d Z \lesssim w^{3} r
$$

Summary We may combine Type I and II cases and obtain that

$$
\sum_{L \ll M, n \geq 0} \int_{\Omega_{L, n}} \frac{1}{|\triangle X Y Z|} d X d Y d Z \lesssim w^{3} r .
$$

### 4.3 Comparable Sizes

Finally let us the consider the case when $\triangle X Y Z$ and $\triangle D E F$ are about of the same size, i.e. $L \simeq M$. This eliminate the need to take a sum in $L$. In this subsection we prove that if $L \simeq M$, then

$$
\sum_{n \geq 0} \int_{\Omega_{L, n}} \frac{1}{|\triangle X Y Z|} d X d Y d Z \lesssim w^{3} r
$$

The argument is similar to the case $L \gg M$, Type II. Now we have less information on the relative location of two triangles available. Nevertheless, Corollary 3.4 guarantees that $d(\triangle X Y Z, \triangle D E F) \lesssim L \simeq M$. By reciprocal assumption, we have (please refer to figure 17)

$$
|\triangle F D Z| \cdot|\triangle E X Y| \lesssim|\triangle D E F| \cdot|\triangle X Y Z|
$$

That is
$(|D Z| \cdot|D F| \sin \angle F D Z)(|X E| \cdot|X Y| \sin \angle E X Y) \lesssim(|D F| \cdot|F E| \sin \angle D F E)(|X Y| \cdot|X Z| \sin \angle Y X Z)$.
Canceling $|D F|,|X Y|$ and plugging $|F E|,|X Z| \simeq M$ in, we have

$$
\begin{aligned}
|D Z|(\sin \angle F D Z)|X E|(\sin \angle E X Y) & \lesssim M^{2}(\sin \angle D F E) \sin \angle Y X Z \\
& \lesssim M^{2} \phi_{M} \cdot 2^{-n} \phi_{L} \\
& \lesssim 2^{-n} K_{M}^{2}
\end{aligned}
$$

Here the notation $K_{M}$ represents

$$
K_{M}= \begin{cases}M^{2} / r, & \text { if } M \geq \sqrt{w r} \\ w, & \text { if } M<\sqrt{w r} .\end{cases}
$$

Therefore we may write $\Omega_{L, n}=\Omega_{L, n}^{0,1} \cup \Omega_{L, n}^{0,2} \cup \Omega_{L, n}^{0,3} \cup \Omega_{L, n}^{0,4}$. Here

$$
\begin{aligned}
& \Omega_{L, n}^{0,1}=\left\{(X, Y, Z) \in \Omega_{L, n}:|D Z| \lesssim 2^{-n / 4} r^{1 / 2} K_{M}^{1 / 2}\right\} \\
& \Omega_{L, n}^{0,2}=\left\{(X, Y, Z) \in \Omega_{L, n}: \sin \angle F D Z \lesssim 2^{-n / 4} r^{-1 / 2} K_{M}^{1 / 2}\right\} \\
& \Omega_{L, n}^{0,3}=\left\{(X, Y, Z) \in \Omega_{L, n}:|X E| \lesssim 2^{-n / 4} r^{1 / 2} K_{M}^{1 / 2}\right\} \\
& \Omega_{L, n}^{0,4}=\left\{(X, Y, Z) \in \Omega_{L, n}: \sin \angle E X Y \lesssim 2^{-n / 4} r^{-1 / 2} K_{M}^{1 / 2}\right\}
\end{aligned}
$$

This immediately gives the upper bounds: if $M \geq \sqrt{w r}$, then

$$
\int_{\Omega_{L, n}^{0, k}} \frac{1}{|\triangle X Y Z|} d X d Y d Z \lesssim \frac{\left(w \cdot 2^{-n / 4} r^{1 / 2} K_{M}^{1 / 2}\right) \cdot(L w) \cdot\left(w r \cdot 2^{-n} \phi_{L}\right)}{L^{2} \cdot 2^{-n} \phi_{L}} \lesssim 2^{-n / 4} w^{3} r
$$

If $M \leq \sqrt{w r}$, then

$$
\begin{aligned}
\int_{\Omega_{L, n}^{0, k}} \frac{1}{|\triangle X Y Z|} d X d Y d Z & \lesssim \frac{\left(w \cdot 2^{-n / 4} r^{1 / 2} K_{M}^{1 / 2}\right) \cdot(L w) \cdot\left(L^{2} \cdot 2^{-n} \phi_{L}\right)}{L^{2} \cdot 2^{-n} \phi_{L}} \\
& \lesssim 2^{-n / 4} w^{5 / 2} r^{1 / 2} L \lesssim 2^{-n / 4} w^{3} r .
\end{aligned}
$$

In either case we may take a sum and obtain that if $L \simeq M$, then

$$
\sum_{n \geq 0} \int_{\Omega_{L, n}} \frac{1}{|\triangle X Y Z|} d X d Y d Z \lesssim w^{3} r
$$

### 4.4 Summary

Collecting all cases discussed above, we prove that the inequality

$$
\int_{\Sigma(D E F) \cap\left(\Omega^{*}\right)^{3}} \frac{1}{|\triangle X Y Z|} d X d Y d Z \lesssim w^{3} r
$$

holds for all $D, E, F \in \Omega^{*}$. The implicit constant here is an absolute constant. Thus we finish the proof of Proposition 4.1

## 5 Applications of Geometric Inequalities

In this section we prove the main results given in Section 1

### 5.1 Proof of Proposition 1.3

Part (a) Let us temporally assume $G$ is supported in $[a, b] \times \mathbb{S}^{2}$. We apply Proposition 4.1 and obtain an upper bound of $C_{a, b, \delta}$ defined in Proposition 2.1. (A disk of radius $r$ can be viewed as an annulus of outer radius $r$ and width $r$ )

$$
C_{a, b, \delta}(h) \lesssim \begin{cases}(b / h)^{6} \cdot w^{3} r, & h \geq b ; \\ (b / h)^{6} \cdot r^{4}, & h \in(a-\delta, b) .\end{cases}
$$

Here

$$
\begin{aligned}
& r=\frac{\sqrt{h^{2}-(a-\delta)^{2}}}{a-\delta} \\
& w=\frac{\sqrt{h^{2}-(a-\delta)^{2}}}{a-\delta}-\frac{\sqrt{h^{2}-b^{2}}}{b} .
\end{aligned}
$$

We plug $r, w$ and obtain that if $h \geq b$, then (recall that $b / a \leq 2$ and $\delta>0$ is small)

$$
C_{a, b, \delta}(h) \lesssim \frac{b^{6}[1 /(a-\delta)-1 / b]^{3}}{h^{2}(a-\delta)^{2}[1 /(a-\delta)-1 / h]} \lesssim \frac{a^{4}[1 /(a-\delta)-1 / b]^{3}}{h^{2}[1 /(a-\delta)-1 / h]}
$$

And if $h \in(a-\delta, b)$, then (in this case $a-\delta \simeq b \simeq h$ )

$$
C_{a, b, \delta}(h) \lesssim h^{2}[1 /(a-\delta)-1 / h]^{2} .
$$

This upper bound of $C_{a, b, \delta}(h)$ is an increasing function of $h$ in the interval $(a-\delta, b)$ and a decreasing function of $h$ in the interval $[b,+\infty)$. Thus we have

$$
\begin{array}{lll}
\sup _{h>\max \{a-\delta, R\}} C_{a, b, \delta}(h) \lesssim \frac{a^{4}[1 /(a-\delta)-1 / b]^{3}}{R^{2}[1 /(a-\delta)-1 / R]}, & & R \geq b ; \\
\sup _{h>\max \{a-\delta, R\}} C_{a, b, \delta}(h) \lesssim b^{2}[1 /(a-\delta)-1 / b]^{2}, & R<b
\end{array}
$$

We plug this upper bound in Proposition 2.1, make $\delta \rightarrow 0^{+}$and obtain

$$
\int_{|x|>R}|\mathbf{T} G(x)|^{6} d x \lesssim \frac{a^{4}(1 / a-1 / b)^{3}}{R^{2}(1 / a-1 / R)}\|G\|_{L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)}^{6}=\frac{(a / R)^{2}(1-a / b)^{3}}{1-a / R}\|G\|_{L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)}^{6}
$$

for all $L^{2}$ functions $G$ supported in $[a, b] \times \mathbb{S}^{2}$ and $R \geq b$. Similarly we may choose $R=0$, recall $1<b / a \leq 2$ and obtain

$$
\int_{\mathbb{R}^{3}}|\mathbf{T} G(x)|^{6} d x \lesssim(1-a / b)^{2}\|G\|_{L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)}^{6} .
$$

By the identity

$$
\mathbf{T}(G(-s, \omega))(x)=(\mathbf{T} G(s, \omega))(-x)
$$

The same inequalities as above also hold for $G$ supported in $[-b,-a] \times \mathbb{S}^{2}$. We then use the linearity of $\mathbf{T}$ to finish the proof.

Part (b) Now let us assume $G \in L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)$ is supported in $[-b, b] \times \mathbb{S}^{2}$. We may break $G$ into pieces

$$
G(s, \omega)=\sum_{k=0}^{\infty} G_{k}(s, \omega)
$$

so that

$$
G_{k}(s, \omega)= \begin{cases}G(s, \omega), & 2^{-k-1} b<|s| \leq 2^{-k} b \\ 0, & \text { otherwise }\end{cases}
$$

It immediately gives a convergence in $L^{6}\left(\mathbb{R}^{3}\right)$ :

$$
\mathbf{T} G=\sum_{k=0}^{\infty} \mathbf{T} G_{k}=\sum_{k=0}^{\infty} \int_{\mathbb{S}^{2}} G_{k}(x \cdot \omega, \omega) d \omega
$$

We then apply the conclusion of part (a) on the radiation profiles $G_{k}$ and obtain

$$
\int_{|x|>R}\left|\mathbf{T} G_{k}(x)\right|^{6} d x \lesssim \frac{\left(\frac{2^{-k-1} b}{R}\right)^{2}\left(1-\frac{2^{-k-1} b}{2^{-k} b}\right)^{3}}{1-\frac{2^{-1-k} b}{R}}\left\|G_{k}\right\|_{L^{2}}^{6} \lesssim \frac{2^{-2 k} b^{2}}{R^{2}}\|G\|_{L^{2}}^{6}
$$

Therefore

$$
\|\mathbf{T} G\|_{L^{6}(\{x:|x|>R\})} \leq \sum_{k=0}^{\infty}\left\|\mathbf{T} G_{k}\right\|_{L^{6}(\{x:|x|>R\})} \lesssim(b / R)^{1 / 3}\|G\|_{L^{2}}
$$

This finishes the proof of part (b).

### 5.2 Proof of Corollary 1.4

Since we always have $\|\mathbf{T} G\|_{L^{6}\left(\mathbb{R}^{3}\right)} \lesssim\|G\|_{L^{2}}$, we may assume $R>2(b-a)$, without loss of generality. Let $c=\max \{|a|,|b|\}$ thus we have $\operatorname{Supp} G \subset[-c, c]$. There are two cases

- If $b-a \geq c / 2$, then we apply part (b) of Proposition 1.3 and obtain

$$
\int_{|x|>R}|\mathbf{T} G(x)|^{6} d x \lesssim(c / R)^{2}\|G\|_{L^{2}}^{6} \lesssim\left(\frac{b-a}{R}\right)^{2}\|G\|_{L^{2}}^{6}
$$

- If $b-a<c / 2$, then we have either $2 a>b>a>0$ or $2 b<a<b<0$. Let us consider the first situation since the second one can be dealt with by symmetry. We apply Part (a) of Proposition 1.3 and obtain

$$
\begin{array}{ll}
\int_{|x|>R}|\mathbf{T} G(x)|^{6} d x \lesssim(1-a / b)^{2}\|G\|_{L^{2}}^{6} \leq\left(\frac{b-a}{R}\right)^{2}\|G\|_{L^{2}}^{6}, & R \leq b ; \\
\int_{|x|>R}|\mathbf{T} G(x)|^{6} d x \lesssim \frac{(a / R)^{2}(1-a / b)^{3}}{1-a / R}\|G\|_{L^{2}}^{6} \lesssim\left(\frac{b-a}{R}\right)^{2}\|G\|_{L^{2}}^{6}, & R>b .
\end{array}
$$

### 5.3 Proof of Proposition 1.6

The $L^{6}$ estimates Let $G$ be the radiation profile associated to the linear free wave $u$. By isometric property we have $E=2\|G\|_{L^{2}}^{2}$. The non-radiative assumption implies that $G$ is supported in $[-r, r] \times \mathbb{S}^{2}$. We may define $G^{(t)}(s, \omega)=G(s+t, \omega)$ and rewrite

$$
u(x, t)=\frac{1}{2 \pi} \int_{\mathbb{S}^{2}} G(x \cdot \omega+t, \omega) d \omega=\frac{1}{2 \pi} \int_{\mathbb{S}^{2}} G^{(t)}(x \cdot \omega, \omega) d \omega
$$

We have

$$
\operatorname{Supp} G^{(t)}(s, \omega) \subseteq[-t-r,-t+r] \times \mathbb{S}^{2} ; \quad\left\|G^{(t)}\right\|_{L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)}=\|G\|_{L^{2}\left(\mathbb{R} \times \mathbb{S}^{2}\right)}
$$

We then apply Corollary 1.4 and obtain

$$
\|u(\cdot, t)\|_{L^{6}(\{x:|x|>R\})} \lesssim(2 r / R)^{1 / 3}\left\|G^{(t)}\right\|_{L^{2}} \lesssim(r / R)^{1 / 3}\|G\|_{L^{2}}
$$

Therefore we have

$$
\|u\|_{L^{\infty} L^{6}(\mathbb{R} \times\{x:|x|>R\})} \lesssim(r / R)^{1 / 3}\|G\|_{L^{2}} \simeq(r / R)^{1 / 3} E^{1 / 2}
$$

The decay $\|u(\cdot, t)\|_{L^{6}\left(\mathbb{R}^{3}\right)} \lesssim(r /|t|)^{1 / 3} E^{1 / 2}$ immediately follows Proposition 1.3 part (a), as long as $|t|>3 r$

$$
\|u(\cdot, t)\|_{L^{6}\left(\mathbb{R}^{3}\right)} \lesssim\left(1-\frac{|t|-r}{|t|+r}\right)^{1 / 3}\left\|G^{(t)}\right\|_{L^{2}} \lesssim(r /|t|)^{1 / 3} E^{1 / 2}
$$

The case $|t| \leq 3 r$ is trivial.

The $L^{p} L^{q}$ estimates We recall the Strichartz estimates given in Ginibre-Velo [12]: if $p_{1}, q_{1}>0$ satisfies $1 / p_{1}+3 / q_{1}=1 / 2$ and $6 \leq q_{1}<+\infty$, then any finite-energy linear free wave $u$ satisfies

$$
\begin{equation*}
\|u\|_{L^{q_{1}} L^{q_{1}}\left(\mathbb{R} \times \mathbb{R}^{3}\right)} \lesssim_{p_{1}, q_{1}} E^{1 / 2} \tag{19}
\end{equation*}
$$

As a result, the $(r / R)^{\kappa}$ decay of the norm $\|u\|_{L^{p} L^{q}(\mathbb{R} \times\{x:|x|>R\})}$ follows an interpolation between the decay estimate

$$
\|u\|_{L^{\infty} L^{6}(\mathbb{R} \times\{x:|x|>R\})} \lesssim(r / R)^{1 / 3} E^{1 / 2}
$$

and the regular Strichartz estimate (19) with $p_{1}=2^{+}$and $q_{1}=\infty^{-}$in the whole space. Please note that the choice $\left(p_{1}, q_{1}\right)=(2,+\infty)$ is forbidden in the Strichartz estimates.

## 6 Two dimensional case and application on Radon transform

Since $\mathbf{T}$ is the adjoint operator of Radon transform $\mathcal{R}$, a corollary immediately follows Proposition 1.3. If $f$ is supported in the region $\{x:|x|>R\}$, then

$$
\|\mathcal{R} f\|_{L^{2}\left([-b, b] \times \mathbb{S}^{2}\right)} \lesssim(b / R)^{1 / 3}\|f\|_{L^{6 / 5}\left(\mathbb{R}^{3}\right)}, \quad \forall b \in(0, R) .
$$

We are also interested in its 2-dimensional analogue, since 2-dimensional Radon transform is more frequently used in some applications, for example, X-ray technology. Our 2-dimensional result is

Proposition 6.1. We consider the 2-dimensional Radon transform ( $d L$ is the line measure of a straight line on $\mathbb{R}^{2}$ )

$$
\mathcal{R} f(s, \omega)=\int_{\omega \cdot x=s} f(x) d L(x), \quad(s, \omega) \in \mathbb{R} \times \mathbb{S}^{1}
$$

and its adjoint

$$
\mathcal{R}^{*} G(x)=\int_{\mathbb{S}^{1}} G(x \cdot \omega, \omega) d \omega, \quad x \in \mathbb{R}^{2}
$$

Then we have
(a) Assume that $b>a>0$ with $b / a \leq 2$. If $G$ is supported in $([-b,-a] \cup[a, b]) \times \mathbb{S}^{1}$, then

$$
\begin{aligned}
\int_{|x|>R}\left|\mathcal{R}^{*} G(x)\right|^{4} d x & \lesssim \frac{(a / R)(1-a / b)}{(1-a / R)^{1 / 2}}\|G\|_{L^{2}\left(\mathbb{R} \times \mathbb{S}^{1}\right)}^{4}, \quad \forall R>b ; \\
\int_{\mathbb{R}^{2}}\left|\mathcal{R}^{*} G(x)\right|^{4} d x & \lesssim(1-a / b)^{1 / 2}\|G\|_{L^{2}\left(\mathbb{R} \times \mathbb{S}^{1}\right)}^{4} .
\end{aligned}
$$

(b) Assume that $R \geq b>0$. If $G$ is supported in $([-b, b]) \times \mathbb{S}^{1}$, then

$$
\int_{|x|>R}\left|\mathcal{R}^{*} G(x)\right|^{4} d x \lesssim \frac{b}{R}\|G\|_{L^{2}\left(\mathbb{R} \times \mathbb{S}^{1}\right)}^{4} .
$$

(c) If $f(x)=0$ for all $|x|<R$, then we have

$$
\|\mathcal{R} f\|_{L^{2}\left([-b, b] \times \mathbb{S}^{1}\right)} \lesssim(b / R)^{1 / 4}\|f\|_{L^{4 / 3}\left(\mathbb{R}^{2}\right)}
$$

Proof. The general idea is exactly the same as in the 3-dimensional case. Part (b) follows part (a) and a decomposition of $G$. Part (c) follows a basic property of adjoint operators. Let us stretch the proof of part (a) only. Following the same argument as in Section 2 we obtain ( $\delta>0$ is sufficiently small)

$$
\int_{|x|>R}|\mathbf{T} G(x)|^{4} d x \leq\left(\sup _{h>\max \{R, a-\delta\}} C_{a, b, \delta}(h)\right)\|G\|_{L^{2}\left(\mathbb{R} \times \mathbb{S}^{1}\right)}^{4}
$$

Here the constant $C_{a, b, \delta}(h)$ is defined by

$$
C_{a, b, \delta}(h)=\frac{3 b^{2}}{h^{2}} \sup _{x_{1}, x_{2} \in \Omega_{\delta, h}^{*}} \int_{\Sigma\left(x_{1}, x_{2}\right) \cap \Omega_{\delta, h}^{*}} \frac{1}{\left|x_{3}-x_{4}\right|} d x_{3} d x_{4}
$$

Here $\Omega_{\delta, h}^{*}$ is defined by

$$
\begin{array}{ll}
\Omega_{\delta, h}^{*}=\left(-\frac{\sqrt{h^{2}-(a-\delta)^{2}}}{a-\delta},-\frac{\sqrt{h^{2}-b^{2}}}{b},\right) \cup\left(\frac{\sqrt{h^{2}-b^{2}}}{b}, \frac{\sqrt{h^{2}-(a-\delta)^{2}}}{a-\delta}\right) \cdot & h \geq b \\
\Omega_{\delta, h}^{*}=\left(-\frac{\sqrt{h^{2}-(a-\delta)^{2}}}{a-\delta}, \frac{\sqrt{h^{2}-(a-\delta)^{2}}}{a-\delta}\right), & h \in(a-\delta, b)
\end{array}
$$

and $\Sigma\left(x_{1}, x_{2}\right)$ is the set consisting of reciprocal pairs of $\left(x_{1}, x_{2}\right)$. We call $\left(x_{1}, x_{2}\right)$ and $\left(x_{3}, x_{4}\right)$ are reciprocal pairs if and only if

$$
\left|x_{1}-x_{2}\right| \cdot\left|x_{3}-x_{4}\right| \geq \frac{1}{17} \max _{\left\{j_{1}, j_{2}, j_{3}, j_{4}\right\}=\{1,2,3,4\}}\left|x_{j_{1}}-x_{j_{2}}\right| \cdot\left|x_{j_{3}}-x_{j_{4}}\right|
$$

We claim that if $\Omega=(-r,-r+w) \cup(r-w, r)$ with $r \geq w>0$, then

$$
\begin{equation*}
\sup _{x_{1}, x_{2} \in \Omega} \int_{\Sigma\left(x_{1}, x_{2}\right) \cap \Omega^{2}} \frac{1}{\left|x_{3}-x_{4}\right|} d x_{3} d x_{4} \lesssim w . \tag{20}
\end{equation*}
$$

We then plug this upper bound in the expression of $C_{a, b, \delta}(h)$, take the least upper bound, then make $\delta \rightarrow 0^{+}$to finish the proof of part (a). Finally we need to verify (20). First of all, if ( $x_{1}, x_{2}$ ) and $\left(x_{3}, x_{4}\right)$ are reciprocal pairs, then we claim

$$
\begin{equation*}
\min \left\{\left|x_{1}-x_{3}\right|,\left|x_{1}-x_{4}\right|,\left|x_{2}-x_{3}\right|,\left|x_{2}-x_{4}\right|\right\} \leq 34 \min \left\{\left|x_{1}-x_{2}\right|,\left|x_{3}-x_{4}\right|\right\} . \tag{21}
\end{equation*}
$$

In fact, we may assume $\left|x_{3}-x_{4}\right| \geq\left|x_{1}-x_{2}\right|$ without loss of generality. The triangle inequality implies that we have either $\left|x_{1}-x_{3}\right| \geq\left|x_{3}-x_{4}\right| / 2$ or $\left|x_{1}-x_{4}\right| \geq\left|x_{3}-x_{4}\right| / 2$. By our reciprocal assumption we have either $\left|x_{2}-x_{4}\right| \leq 34\left|x_{1}-x_{2}\right|$ or $\left|x_{2}-x_{3}\right| \leq 34\left|x_{1}-x_{2}\right|$. This verifies (21). Now we are ready to prove (20). Let us fix $x_{1}, x_{2} \in \Omega$. We define $\Omega_{L}$ to be the set of all reciprocal pairs of size $L$ :

$$
\Omega_{L}=\left\{\left(x_{3}, x_{4}\right) \in \Sigma\left(x_{1}, x_{2}\right) \cap \Omega^{2}: L \leq\left|x_{3}-x_{4}\right|<2 L\right\}, \quad L \in\{r, r / 2, r / 4, \cdots\} .
$$

We also assume that the size of $\left|x_{1}-x_{2}\right|$ is $M$, i.e. $M \in\{r, r / 2, r / 4, \cdots\}$ so that $M \leq\left|x_{1}-x_{2}\right|<$ $2 M$. There are two cases: Case 1 , if $L \ll M \leq r$, then we must have either $L \leq w$ or $\Omega_{L}=\varnothing$. In addition (21) implies that if $\left(x_{3}, x_{4}\right) \in \Omega_{L}$, then either $\left|x_{4}-x_{1}\right|,\left|x_{3}-x_{1}\right| \lesssim L$ or $\left|x_{4}-x_{2}\right|,\left|x_{3}-x_{2}\right| \lesssim L$ holds, thus $\left|\Omega_{L}\right| \lesssim L^{2}$. This implies

$$
\int_{\Omega_{L}} \frac{1}{\left|x_{3}-x_{4}\right|} d x_{3} d x_{4} \lesssim L^{-1}\left|\Omega_{L}\right| \lesssim L
$$

Case 2, if $L \gtrsim M$, then we have either $\left|x_{3}-x_{1}\right| \lesssim M$ or $\left|x_{4}-x_{1}\right| \lesssim M$ by (21), thus $\left|\Omega_{L}\right| \lesssim M w$. (Please note that $|\Omega|=2 w$ ) Therefore we have

$$
\int_{\Omega_{L}} \frac{1}{\left|x_{3}-x_{4}\right|} d x_{3} d x_{4} \lesssim M w L^{-1}
$$

In summary

$$
\int_{\Sigma\left(x_{1}, x_{2}\right) \cap \Omega^{2}} \frac{d x_{3} d x_{4}}{\left|x_{3}-x_{4}\right|} \leq \sum_{L} \int_{\Omega_{L}} \frac{d x_{3} d x_{4}}{\left|x_{3}-x_{4}\right|} \lesssim \sum_{L \ll M, L \leq w} L+\sum_{L \gtrsim M} M w L^{-1} \lesssim w .
$$

This finishes the proof.
