# NATURAL ALMOST HERMITIAN STRUCTURES ON CONFORMALLY FOLIATED 4-DIMENSIONAL LIE GROUPS WITH MINIMAL LEAVES

#### Abstract

Let $(G, g)$ be a 4-dimensional Riemannian Lie group with a 2-dimensional left-invariant, conformal foliation $\mathcal{F}$ with minimal leaves. Let $J$ be an almost Hermitian structure on $G$ adapted to the foliation $\mathcal{F}$. We classify such structures $J$ which are almost Kähler $(\mathcal{A K})$, integrable $(\mathcal{I})$ or Kähler ( $\mathcal{K}$ ). Hereby we construct several new multi-dimensional examples in each class.


## 1. Introduction

The theory of harmonic morphisms was initiated by Jacobi, in the 3dimensional Euclidean geometry, with his famous paper [8] from 1848. In the late 1970s this was then generalised to Riemannian geometry in [3] and [7 by Fuglede and Ishihara, independently. This has lead to a vibrant development which can be traced back in the standard reference [2], by Baird and Wood, and the regularly updated online bibliography [6], maintained by the second author. The following result of Baird and Eells gives the theory of harmonic morphisms, with values in a surface, a strong geometric flavour.

Theorem 1.1. [1] Let $\phi:\left(M^{m}, g\right) \rightarrow\left(N^{2}, h\right)$ be a horizontally conformal submersion from a Riemannian manifold to a surface. Then $\phi$ is harmonic if and only if $\phi$ has minimal fibres.

In their work [5], the authors classify the 4-dimensional Riemannian Lie groups $(G, g)$ equipped with a 2 -dimensional, conformal and left-invariant foliation $\mathcal{F}$ with minimal leaves. Such a foliation is locally given by a submersive harmonic morphism into a surface. For such a Riemannian Lie group there exist natural almost Hermitian structures $J$ adopted to the foliation structure.

The purpose of this work is to classify these structures which are almost Kähler $(\mathcal{A K})$, integrable $(\mathcal{I})$ or Kähler $(\mathcal{K})$, see [4. Our classification result is the following.

Theorem 1.2. Let $(G, g, J)$ be a 4-dimensional almost Hermitian Lie group equipped with a 2 -dimensional, conformal and left-invariant foliation $\mathcal{F}$ with

[^0]minimal leaves. If a natural Hermitian structure $J$, adapted to the foliation $\mathcal{F}$, is almost Kähler $(\mathcal{A K})$, integrable $(\mathcal{I})$ or Kähler $(\mathcal{K})$, then the corresponding Lie algebra $\mathfrak{g}_{k}^{\mathcal{A}}, \mathfrak{g}_{k}^{\mathcal{I}}$ or $\mathfrak{g}_{k}^{\mathcal{K}}$ of $G$ is one of those given below ( $k=1,2 \ldots, 20$ ).

## 2. Two Dimensional Conformal Foliations $\mathcal{F}$ on $\left(G^{4}, g\right)$

Let $(M, g)$ be a Riemannian manifold, $\mathcal{V}$ be an integrable distribution on $M$ and denote by $\mathcal{H}$ its orthogonal complementary distribution. As customary, we shall also by $\mathcal{V}$ and $\mathcal{H}$ denote the orthogonal projections onto the corresponding subbundles of the tangent bundle $T M$ of $M$ and denote by $\mathcal{F}$ the foliation tangent to $\mathcal{V}$. Then the second fundamental form for $\mathcal{V}$ is given by

$$
B^{\mathcal{V}}(Z, W)=\frac{1}{2} \mathcal{H}\left(\nabla_{Z} W+\nabla_{W} Z\right) \quad(Z, W \in \mathcal{V})
$$

while the second fundamental form for $\mathcal{H}$ satisfies

$$
B^{\mathcal{H}}(X, Y)=\frac{1}{2} \mathcal{V}\left(\nabla_{X} Y+\nabla_{Y} X\right) \quad(X, Y \in \mathcal{H})
$$

The foliation $\mathcal{F}$ tangent to $\mathcal{V}$ is said to be conformal if there exits a vector field $V \in \mathcal{V}$ such that the second fundamental form $B^{\mathcal{H}}$ satisfies

$$
B^{\mathcal{H}}=g \otimes V
$$

and $\mathcal{F}$ is said to be Riemannian if $V=0$. Furthermore, $\mathcal{F}$ is said to be minimal if trace $B^{\mathcal{V}}=0$ and totally geodesic if $B^{\mathcal{V}}=0$. This is equivalent to the leaves of $\mathcal{F}$ being minimal or totally geodesic submanifolds of $M$, respectively.

It is well-known that the fibres of a horizontally conformal map (resp. Riemannian submersion) give rise to a conformal foliation (resp. Riemannian foliation). Conversely, the leaves of any conformal foliation (resp. Riemannian foliation) are locally the fibres of a horizontally conformal (resp. Riemannian) submersion, see [2].

Let $(G, g)$ be a 4-dimensional Lie group equipped with a left-invariant Riemannian metric $g$ and $K$ be a 2 -dimensional subgroup of $G$. Let $\mathfrak{k}$ and $\mathfrak{g}$ be the Lie algebras of $K$ and $G$, respectively. Let $\mathfrak{m}$ be the two dimensional orthogonal complement of $\mathfrak{k}$ in $\mathfrak{g}$ with respect to the Riemannian metric $g$ on $G$. By $\mathcal{V}$ we denote the integrable distribution generated by $\mathfrak{k}$ and by $\mathcal{H}$ its orthogonal distribution given by $\mathfrak{m}$. Further let $\mathcal{F}$ be the foliation of $G$ tangent to $\mathcal{V}$. Let the set

$$
\mathcal{B}=\{X, Y, Z, W\}
$$

be an orthonormal basis for the Lie algebra $\mathfrak{g}$ of $G$, such that $Z, W$ generate the subalgebra $\mathfrak{k}$ and $[W, Z]=\lambda W$ for some $\lambda \in \mathbb{R}$. The elements $X, Y \in \mathfrak{m}$ can clearly be chosen such that $\mathcal{H}[X, Y]=\rho X$ for some $\rho \in \mathbb{R}$.

If the 2 -dimensional foliation $\mathcal{F}$ is conformal with minimal leaves then, following [5], the Lie bracket relations of $\mathfrak{g}$ take the following form

$$
\begin{align*}
{[W, Z] } & =\lambda W \\
{[Z, X] } & =\alpha X+\beta Y+z_{1} Z+w_{1} W \\
{[Z, Y] } & =-\beta X+\alpha Y+z_{2} Z+w_{2} W  \tag{2.1}\\
{[W, X] } & =a X+b Y+z_{3} Z-z_{1} W \\
{[W, Y] } & =-b X+a Y+z_{4} Z-z_{2} W, \\
{[Y, X] } & =r X+\theta_{1} Z+\theta_{2} W,
\end{align*}
$$

with real structure coefficients. To ensure that these equations actually define a Lie algebra they must satisfy the Jacobi equations. These are equivalent to a system of 14 second order homogeneous polynomial equations in 14 variables, see Appendix A. This has been solved in [5] and the solutions give a complete classifications of such Lie algebras. They form 20 multi-dimensional families which can be found therein.

For the foliation $\mathcal{F}$ we state the following easy result describing the geometry of the situation.

Proposition 2.1. Let $(G, g)$ be a 4-dimensional Lie group with Lie algebra $\mathfrak{g}$ as above. Then
(i) $\mathcal{F}$ is totally geodesic if and only if $z_{1}=z_{2}=z_{3}+w_{1}=z_{4}+w_{2}=0$,
(ii) $\mathcal{F}$ is Riemannian if and only if $\alpha=a=0$, and
(iii) $\mathcal{H}$ is integrable if and only if $\theta_{1}=\theta_{2}=0$.

## 3. The Adapted Almost Hermitian Structures

Let $(G, g)$ be a 4-dimensional Riemannian Lie group as above. Further, let $J$ be a left-invariant almost Hermitian structure on the tangent bundle $T G$ adapted to the decomposition $T G=\mathcal{V} \oplus \mathcal{H}$ i.e. a bundle isomorphism $J: T G \rightarrow T G$ such that

$$
J^{2}=-\mathrm{id}, \quad J(\mathcal{V})=\mathcal{V} \text { and } J(\mathcal{H})=\mathcal{H} .
$$

The almost Hermitian structure $J$ is left-invariant and can therefore be fully described by its action on the orthonormal basis

$$
\mathcal{B}=\{X, Y, Z, Y\}
$$

of the Lie algebra $\mathfrak{g}$ of $G$. Here the vector fields $X, Y \in \mathcal{H}$ and $Z, W \in \mathcal{V}$ can be chosen such that

$$
\begin{equation*}
J(X)=Y \quad \text { and } \quad J(Z)=W \tag{3.1}
\end{equation*}
$$

Lemma 3.1. Let $(G, g, J)$ be a 4-dimensional almost Hermitian Lie group as above. Then the structure $J$ is almost Kähler $(\mathcal{A K})$ if and only if

$$
\theta_{1}=2 a \quad \text { and } \quad \theta_{2}=-2 \alpha
$$

Proof. The Kähler form $\omega$ satisfies $\omega(E, F)=g(J E, F)$ for all $E, F \in \mathfrak{g}$. It is well known that $J$ is almost Kähler if and only if the corresponding Kähler form $\omega$ is closed i.e. $d \omega=0$.

$$
\begin{aligned}
d \omega(X, Y, Z)= & -g(J[X, Y], Z)-g(J[Y, Z], X)-g(J[Z, X], Y) \\
= & -g\left(J\left(-r X-\theta_{1} Z-\theta_{2} W\right), Z\right) \\
& -g\left(J\left(\beta X-\alpha Y-z_{2} Z-w_{2} W\right), X\right) \\
& -g\left(J\left(\alpha X+\beta Y+z_{1} Z+w_{1} W\right), Y\right) \\
= & -g\left(-r Y-\theta_{1} W+\theta_{2} Z, Z\right) \\
& -g\left(\beta Y+\alpha X-z_{2} W+w_{2} Z, X\right) \\
& -g\left(\alpha Y-\beta X+z_{1} W-w_{1} Z, Y\right) \\
= & -\theta_{2}-2 \alpha .
\end{aligned}
$$

The statement is then easily obtained by performing the corresponding computations in the other cases $d \omega(W, X, Y), d \omega(Z, W, X)$ and $d \omega(Y, Z, W)$.

Lemma 3.2. Let $(G, g, J)$ be a 4-dimensional almost Hermitian Lie group as above. Then the almost complex structure $J$ is integrable ( $\mathcal{I}$ ) if and only if

$$
2 z_{1}-z_{4}-w_{2}=0 \text { and } 2 z_{2}+z_{3}+w_{1}=0 .
$$

Proof. It is well known that $J$ is integrable if and only if the corresponding skew-symmetric Nijenhuis tensor $N$ vanishes i.e. if

$$
N(E, F)=[E, F]+J[J E, F]+J[E, J F]-[J E, J F]=0,
$$

for all $E, F \in \mathfrak{g}$. It is obvious that $N(X, Y)=N(Z, W)=0$. Now

$$
\begin{aligned}
N(X, Z)= & {[X, Z]+J[J X, Z]+J[X, J Z]-[J X, J Z] } \\
= & {[X, Z]+J[Y, Z]+J[X, W]-[Y, W] } \\
= & -\alpha X-\beta Y-z_{1} Z-w_{1} W+J\left(\beta X-\alpha Y-z_{2} Z-w_{2} W\right) \\
& -J\left(a X+b Y+z_{3} Z-z_{1} W\right)-b X+a Y+z_{4} Z-z_{2} W \\
= & -\alpha X-\beta Y-z_{1} Z-w_{1} W+\beta Y+\alpha X-z_{2} W+w_{2} Z \\
& -a Y+b X-z_{3} W-z_{1} Z-b X+a Y+z_{4} Z-z_{2} W \\
= & -\left(2 z_{1}-z_{4}-w_{2}\right) Z-\left(2 z_{2}+z_{3}+w_{1}\right) W .
\end{aligned}
$$

Similar calculations for $N(X, W), N(Y, Z)$ and $N(Y, W)$ easily provide the result.

Corollary 3.3. Let $(G, g, J)$ be a 4-dimensional almost Hermitian Lie group as above. Then the structure $J$ is Kähler $(\mathcal{K})$ if and only if

$$
2 z_{1}-z_{4}-w_{2}=0, \quad 2 z_{2}+z_{3}+w_{1}=0, \quad \theta_{1}=2 a \quad \text { and } \quad \theta_{2}=-2 \alpha .
$$

Proof. The almost Hermitian structure $J$ is Kähler if and only if it is almost Kähler and integrable. Hence the statement is an immediate consequence of Lemmas 3.1 and 3.2.

Remark 3.4. The 2-dimensional Lie algebra $\mathfrak{k}$ of the subgroup $K$ of $G$ has orthonormal basis $\{Z, W\}$, satisfying $[W, Z]=\lambda W$. This means that its simply connected universal covering group $\widetilde{K}$ has constant Gaussian curvature $\kappa=-\lambda^{2}$. Thus it is either a hyperbolic disk $H_{\lambda}^{2}$ or the flat Euclidean plane $\mathbb{R}^{2}$.

The 4 -dimensional Riemannian Lie groups $(G, g)$, with a left-invariant conformal foliation $\mathcal{F}$ with minimal leaves, were classified in [5]. The purpose of this work is to in investigate their adapted almost Hermitian structure $J$, given by (3.1), in each case. Here we adopt the notation introduced in 5 .

$$
\text { 4. } \operatorname{CASE}(\mathrm{A})-\left(\lambda \neq 0 \text { AND }(\lambda-\alpha)^{2}+\beta^{2} \neq 0\right)
$$

Example $4.1\left(\mathfrak{g}_{1}\left(\lambda, r, w_{1}, w_{2}\right)\right)$. This is a 4-dimensional family of solvable Lie algebras obtained by assuming that $r \neq 0$, see [5]. The Lie bracket relations are given by

$$
\begin{aligned}
{[W, Z] } & =\lambda W \\
{[Z, X] } & =w_{1} W \\
{[Z, Y] } & =w_{2} W \\
{[Y, X] } & =r X+\frac{r w_{1}}{\lambda} W .
\end{aligned}
$$

$(\mathcal{A K})$ : According to Lemma 3.1, the adapted almost Hermitian structure $J$ is almost Kähler if and only if $\theta_{1}=2 a$ and $\theta_{2}=-2 \alpha$. We see from the bracket relations that $a=\theta_{1}=\alpha=0$, hence $\theta_{2}=0$. But $\lambda \theta_{2}=r w_{1}$ which implies that $r w_{1}=0$. Since $r \neq 0$ we conclude that the family is in the almost Kähler class if and only if $w_{1}=0$. This provides the 3 -dimensional family $\mathfrak{g}_{1}^{\mathcal{A K}}\left(\lambda, r, w_{2}\right)$, given by

$$
\begin{aligned}
{[W, Z] } & =\lambda W \\
{[Z, Y] } & =w_{2} W \\
{[Y, X] } & =r X
\end{aligned}
$$

Here the corresponding simply connected Lie groups are semidirect products $H_{r}^{2} \ltimes H_{\lambda}^{2}$ of hyperbolic disks, see Remark 3.4. $(\mathcal{I})$ : According to Lemma 3.2 the structure $J$ is integrable if and only if

$$
2 z_{2}+z_{3}+w_{1}=0 \text { and } 2 z_{1}-z_{4}-w_{2}=0
$$

Because $z_{1}=z_{2}=z_{3}=z_{4}=0$ we conclude that $w_{1}=w_{2}=0$. From this we yield the 2 -dimensional family $\mathfrak{g}_{1}^{\mathcal{I}}(\lambda, r)$ satisfying

$$
\begin{aligned}
{[W, Z] } & =\lambda W \\
{[Y, X] } & =r X .
\end{aligned}
$$

$(\mathcal{K})$ : The family $\mathfrak{g}_{1}^{\mathcal{K}}(\lambda, r)=\mathfrak{g}_{1}^{\mathcal{I}}(\lambda, r)$ is contained in $\mathfrak{g}_{1}^{\mathcal{A} \mathcal{K}}\left(\lambda, r, w_{2}\right)$ and thus Kähler, according to Corollary 3.3. Here the corresponding simply connected Lie groups are direct products $H_{r}^{2} \ltimes H_{\lambda}^{2}$ of hyperbolic disks.

Example $4.2\left(\mathfrak{g}_{2}\left(\lambda, \alpha, \beta, w_{1}, w_{2}\right)\right)$. Here we have the 5 -dimensional family of solvable Lie algebras with the bracket relations

$$
\begin{aligned}
{[W, Z] } & =\lambda W \\
{[Z, X] } & =\alpha X+\beta Y+w_{1} W \\
{[Z, Y] } & =-\beta X+\alpha Y+w_{2} W
\end{aligned}
$$

$(\mathcal{A K})$ : Since $\theta_{1}=\theta_{2}=a=0$, the family $\mathfrak{g}_{2}$ is almost Kähler if and only if $\alpha=0$. This yields a 4 -dimensional family $\mathfrak{g}_{2}^{\mathcal{A} \mathcal{K}}\left(\lambda, \beta, w_{1}, w_{2}\right)$ with the Lie bracket relations

$$
\begin{aligned}
{[W, Z] } & =\lambda W \\
{[Z, X] } & =\beta Y+w_{1} W \\
{[Z, Y] } & =-\beta X+w_{2} W .
\end{aligned}
$$

$(\mathcal{I})$ : Because $z_{1}=z_{2}=z_{3}=z_{4}=0$, the structure $J$ is integrable if and only if $w_{1}=w_{2}=0$. This provides us with a 3 -dimensional family $\mathfrak{g}_{2}^{\mathcal{I}}(\lambda, \alpha, \beta)$ given by

$$
\begin{aligned}
{[W, Z] } & =\lambda W \\
{[Z, X] } & =\alpha X+\beta Y \\
{[Z, Y] } & =-\beta X+\alpha Y
\end{aligned}
$$

The corresponding simply connected Lie group is clearly a semidirect product $H_{\lambda}^{2} \ltimes \mathbb{R}^{2}$.
$(\mathcal{K})$ : The family $\mathfrak{g}_{2}$ is Kähler if and only if it is both almost Kähler and integrable i.e. if $\alpha=w_{1}=w_{2}=0$. Here we obtain the 2-dimensional family $\mathfrak{g}_{2}^{\mathcal{K}}(\lambda, \beta)$ given by

$$
\begin{aligned}
{[W, Z] } & =\lambda W \\
{[Z, X] } & =\beta Y, \\
{[Z, Y] } & =-\beta X .
\end{aligned}
$$

Here the corresponding simply connected Lie group is a semidirect product $H_{\lambda}^{2} \ltimes \mathbb{R}^{2}$.
Example $4.3\left(\mathfrak{g}_{3}\left(\alpha, \beta, w_{1}, w_{2}, \theta_{2}\right)\right)$. This is a 5 -dimensional family of solvable Lie algebras with $r=\theta_{1}=0, \theta_{2} \neq 0$ and $\lambda=-2 \alpha$. The bracket relations are given by

$$
\begin{aligned}
{[W, Z] } & =-2 \alpha W \\
{[Z, X] } & =\alpha X+\beta Y+w_{1} W \\
{[Z, Y] } & =-\beta X+\alpha Y+w_{2} W \\
{[Y, X] } & =\theta_{2} W
\end{aligned}
$$

$(\mathcal{A K})$ : Here $a=\theta_{1}=0, \lambda=-2 \alpha \neq 0$ and $\theta_{2} \neq 0$. Thus, the family $\mathfrak{g}_{3}$ is almost Kähler if and only if $\theta_{2}=-2 \alpha=\lambda \neq 0$, which gives the 4-dimensional family $\mathfrak{g}_{3}^{\mathcal{A} \mathcal{K}}\left(\alpha, \beta, w_{1}, w_{2}\right)$ with

$$
[W, Z]=-2 \alpha W
$$

$$
\begin{aligned}
{[Z, X] } & =\alpha X+\beta Y+w_{1} W \\
{[Z, Y] } & =-\beta X+\alpha Y+w_{2} W \\
{[Y, X] } & =-2 \alpha W
\end{aligned}
$$

$(\mathcal{I})$ : Because $z_{1}=z_{2}=z_{3}=z_{4}=0$, we see that the structure $J$ is integrable if and only if $w_{1}=w_{2}=0$, and obtain the family $\mathfrak{g}_{3}^{\mathcal{I}}\left(\alpha, \beta, \theta_{2}\right)$ with

$$
\begin{aligned}
{[W, Z] } & =-2 \alpha W \\
{[Z, X] } & =\alpha X+\beta Y \\
{[Z, Y] } & =-\beta X+\alpha Y \\
{[Y, X] } & =\theta_{2} W
\end{aligned}
$$

$(\mathcal{K})$ : The family $\mathfrak{g}_{3}$ is Kähler if and only if $\theta_{2}=-2 \alpha \neq 0$ and $w_{1}=w_{2}=0$. This provides $\mathfrak{g}_{3}^{\mathcal{K}}(\alpha, \beta)$ with

$$
\begin{aligned}
{[W, Z] } & =-2 \alpha W \\
{[Z, X] } & =\alpha X+\beta Y \\
{[Z, Y] } & =-\beta X+\alpha Y \\
{[Y, X] } & =-2 \alpha W
\end{aligned}
$$

5. $\operatorname{CASE}(\mathrm{B})-\left(\lambda \neq 0 \operatorname{AND}(\lambda-\alpha)^{2}+\beta^{2}=0\right)$

Example $5.1\left(\mathfrak{g}_{4}\left(\lambda, z_{2}, w_{1}, w_{2}\right)\right)$. Here we have the 4-dimensional family of solvable Lie algebras with the bracket relations

$$
\begin{aligned}
{[W, Z] } & =\lambda W \\
{[Z, X] } & =\lambda X+w_{1} W \\
{[Z, Y] } & =\lambda Y+z_{2} Z+w_{2} W \\
{[W, Y] } & =-z_{2} W \\
{[Y, X] } & =-z_{2} X-\frac{z_{2} w_{1}}{\lambda} W
\end{aligned}
$$

$(\mathcal{A K}):$ From $\theta_{1}=2 a=0, \alpha=\lambda \neq 0$ and $\lambda \theta_{2}=-z_{2} w_{1}$, we see that $\mathfrak{g}_{4}$ is almost Kähler if and only if $\theta_{2}=-2 \alpha=-2 \lambda$. This implies that $2 \lambda^{2}=w_{1} z_{2} \neq 0$ and we yield the 3 -dimensional $\mathfrak{g}_{4}^{\mathcal{A K}}\left(\lambda, z_{2}, w_{2}\right)$ with the following Lie bracket relations

$$
\begin{aligned}
{[W, Z] } & =\lambda W \\
{[Z, X] } & =\lambda X+\frac{2 \lambda^{2}}{z_{2}} W \\
{[Z, Y] } & =\lambda Y+z_{2} Z+w_{2} W \\
{[W, Y] } & =-z_{2} W \\
{[Y, X] } & =-z_{2} X-2 \lambda W
\end{aligned}
$$

$(\mathcal{I})$ : Because $z_{1}=z_{3}=z_{4}=0$, the structure $J$ is integrable if and only if $2 z_{2}+w_{1}=w_{2}=0$. This gives a 2-dimensional family $\mathfrak{g}_{4}^{\mathcal{I}}\left(\lambda, z_{2}\right)$ with bracket
relations

$$
\begin{aligned}
{[W, Z] } & =\lambda W, \\
{[Z, X] } & =\lambda X-2 z_{2} W, \\
{[Z, Y] } & =\lambda Y+z_{2} Z, \\
{[W, Y] } & =-z_{2} W, \\
{[Y, X] } & =-z_{2} X+\frac{2 z_{2}^{2}}{\lambda} W .
\end{aligned}
$$

$(\mathcal{K})$ : Here the Kähler condition is never satisfied. This requires $\lambda^{2}+z_{2}^{2}=0$, which clearly has no real solutions for $\lambda \neq 0$. Hence $\mathfrak{g}_{4}^{\mathcal{K}}=\{0\}$.
6. CASE $(\mathrm{C})-(\lambda=0, r \neq 0$ AND $(a \beta-\alpha b) \neq 0)$

Example $6.1\left(\mathfrak{g}_{5}(\alpha, a, \beta, b, r)\right)$. This is the 5 -dimensional family of solvable Lie algebras satisfying the bracket relations

$$
\begin{aligned}
{[Z, X] } & =\alpha X+\beta Y-\frac{r(\beta b-\alpha a)}{2(\alpha b-a \beta)} Z-\frac{r\left(\alpha^{2}-\beta^{2}\right)}{2(\alpha b-a \beta)} W, \\
{[Z, Y] } & =-\beta X+\alpha Y-\frac{r(\alpha b+\beta a)}{2(\alpha b-a \beta)} Z+\frac{r \alpha \beta}{(\alpha b-a \beta)} W, \\
{[W, X] } & =a X+b Y-\frac{r\left(b^{2}-a^{2}\right)}{2(\alpha b-a \beta)} Z-\frac{r(\alpha a-\beta b)}{2(\alpha b-a \beta)} W, \\
{[W, Y] } & =-b X+a Y-\frac{r a b}{(\alpha b-a \beta)} Z+\frac{r(\alpha b+\beta a)}{2(\alpha b-a \beta)} W, \\
{[Y, X] } & =r X+\frac{a r^{2}}{2(\alpha b-a \beta)} Z-\frac{\alpha r^{2}}{2(\alpha b-a \beta)} W
\end{aligned}
$$

$(\mathcal{A K})$ : In this case we have the two relations

$$
\theta_{1}=\frac{a r^{2}}{2(\alpha b-a \beta)} \text { and } \theta_{2}=-\frac{\alpha r^{2}}{2(\alpha b-a \beta)}
$$

They imply that the structure $J$ is almost Kähler if and only if

2 a=\frac{a r^{2}}{2(\alpha b-a \beta)} \text { and } 2 \alpha=\frac{\alpha r^{2}}{2(\alpha b-a \beta)} .
$$

The condition $a \beta-\alpha b \neq 0$ shows that not both $a$ and $\alpha$ can be zero, which implies that $r^{2}=4(\alpha b-a \beta)>0$. If we substitute this into the above system, we then yield the following two solutions

\begin{aligned}
& {[W, Y]=-b X+a Y \mp \frac{2 a b}{\sqrt{\alpha b-a \beta}} Z \pm \frac{(\alpha b+\beta a)}{\sqrt{\alpha b-a \beta}} W,} \\
& {[Y, X]= \pm 2 \sqrt{\alpha b-a \beta} X+2 a Z-2 \alpha W .}
\end{aligned}
$$

Here we have obtained two 4-dimensional families $\mathfrak{g}_{5}^{\mathcal{A} \mathcal{K}}(\alpha, a, \beta, b)^{ \pm}$satisfying the almost Kähler condition.
$(\mathcal{I})$ : Here we are assuming that $r \neq 0, a \beta-\alpha b \neq 0$ and have

& z_{4}=-\frac{2 r a b}{2(\alpha b-a \beta)}, \quad w_{1}=-\frac{r\left(\alpha^{2}-\beta^{2}\right)}{2(\alpha b-a \beta)}, \quad w_{2}=\frac{2 r \alpha \beta}{2(\alpha b-a \beta)} .
\end{aligned}

From this we observe that $J$ is integrable if and only if

A simple calculation shows that $J$ is integrable if and only if $a=\beta$ and $b=-\alpha$. This provides us with the 3-dimensional family $\mathfrak{g}_{5}^{\mathcal{T}}(\alpha, \beta, r)$ fulfilling the bracket relations

$(\mathcal{K})$ : Combining the observations $r^{2}=4(\alpha b-a \beta)>0$ from $(\mathcal{A K})$ and $a=\beta, b=-\alpha$ from $(\mathcal{I})$ we see that the Kähler condition is never satisfied for the Lie algebra $\mathfrak{g}_{5}$, so $\mathfrak{g}_{5}^{\mathcal{K}}=\{0\}$.

Example $7.1\left(\mathfrak{g}_{6}\left(z_{1}, z_{2}, z_{3}, r, \theta_{1}, \theta_{2}\right)\right)$. Here we have a 6 -dimensional family of solvable Lie algebras with $z_{1}^{2}=-w_{1} z_{3} \neq 0$,

$(\mathcal{A K})$ : Because $a=\alpha=0$, the structure $J$ is almost Kähler if and only if $\theta_{1}=\theta_{2}=0$. This provides the 4 -dimensional family $\mathfrak{g}_{6}^{\mathcal{A} \mathcal{K}}\left(z_{1}, z_{2}, z_{3}, r\right)$ with the bracket relations

Here the corresponding simply connected Lie group is a semidirect product $H_{r}^{2} \ltimes \mathbb{R}^{2}$.
(I) : We note that

z_{1} \neq 0, \quad z_{4}=\frac{z_{3}\left(r+2 z_{2}\right)}{2 z_{1}}, \quad w_{1}=-\frac{z_{1}^{2}}{z_{3}} \text { and } w_{2}=\frac{z_{1}\left(r-2 z_{2}\right)}{2 z_{3}} .
$$

Here the structure $J$ is integrable if and only if

z_{1}^{2}=\left(2 z_{2}+z_{3}\right) z_{3} \quad \text { and } z_{1}^{2}\left(4 z_{3}-r+2 z_{2}\right)=z_{3}^{2}\left(r+2 z_{2}\right)

By multiplying the first equation by $\left(4 z_{3}-r+2 z_{2}\right)$, we see that these two conditions imply

$(\mathcal{I}):$ We have $z_{1}=z_{3}=z_{4}=0$. Thus the structure $J$ is integrable if and only if $2 z_{2}+w_{1}=w_{2}=0$ and we yield a 3 -dimensional family $\mathfrak{g}_{7}^{\mathcal{I}}\left(z_{2}, \theta_{1}, \theta_{2}\right)$ given by

Example $7.3\left(\mathfrak{g}_{8}\left(z_{2}, z_{4}, w_{2}, r, \theta_{1}, \theta_{2}\right)\right)$. Here we have the 6-dimensional family of solvable Lie algebras with bracket relations

$(\mathcal{A K})$ : Since $\alpha=a=0$, the family is almost Kähler if and only if $\theta_{1}=\theta_{2}=$ 0 , giving the 4 -dimensional family $\mathfrak{g}_{8}^{\mathcal{A K}}\left(z_{2}, z_{4}, w_{2}, r\right)$ with

Here the corresponding simply connected Lie group is a semidirect product $H_{r}^{2} \ltimes \mathbb{R}^{2}$.
(I) : We have $z_{1}=z_{3}=w_{1}=0$, so $J$ is integrable if and only if $z_{2}=$ $z_{4}+w_{2}=0$, so we yield the family $\mathfrak{g}_{8}^{\mathcal{I}}\left(w_{2}, r, \theta_{1}, \theta_{2}\right)$ with

{[W, Y] } & =-w_{2} Z \\
{[Y, X] } & =r X+\theta_{1} Z+\theta_{2} W
\end{aligned}

$(\mathcal{K})$ : The family is Kähler if and only if $\theta_{1}=\theta_{2}=z_{2}=z_{4}+w_{2}=0$. We get the 2 -dimensional family $\mathfrak{g}_{8}^{\mathcal{K}}\left(w_{2}, r\right)$ with

{[Z, Y] } & =w_{2} W \\
{[W, Y] } & =-w_{2} Z
\end{aligned}
$$

$$
[Y, X]=r X .
$$

The corresponding simply connected Lie group is clearly a semidirect product $H_{r}^{2} \ltimes \mathbb{R}^{2}$
Example $7.4\left(\mathfrak{g}_{9}\left(z_{2}, z_{3}, z_{4}, \theta_{1}, \theta_{2}\right)\right)$. This is the 5 -dimensional family of solvable Lie algebras with $z_{3} \neq 0$ and bracket relations

\begin{aligned}
{[Z, Y] } & =z_{2} Z \\
{[W, X] } & =z_{3} Z \\
{[W, Y] } & =z_{4} Z-z_{2} W \\
{[Y, X] } & =-2 z_{2} X+\theta_{1} Z+\theta_{2} W
\end{aligned}
$$

$(\mathcal{A K})$ : Because $\alpha=a=0$, we see that the family is in the almost Kähler class if and only if $\theta_{1}=\theta_{2}=0$, providing $\mathfrak{g}_{9}^{\mathcal{A}}\left(z_{2}, z_{3}, z_{4}\right)$ with

\text { 8. CASE }(\mathrm{E})-(\lambda=0, r=0 \text { AND } \alpha b-a \beta \neq 0)
$$

Example $8.1\left(\mathfrak{g}_{10}(\alpha, a, \beta, b)\right)$. Here we have the 4 -dimensional family of solvable Lie algebras with the bracket relations

\begin{aligned}
{[Z, X] } & =\alpha X+\beta Y \\
{[Z, Y] } & =-\beta X+\alpha Y \\
{[W, X] } & =a X+b Y \\
{[W, Y] } & =-b X+a Y
\end{aligned}
$$

Here the corresponding simply connected Lie group is a semidirect product $\mathbb{R}^{2} \ltimes \mathbb{R}^{2}$.
$(\mathcal{A K})$ : Since $\theta_{1}=\theta_{2}=0$, we see that the family is almost Kähler if and only if $a=\alpha=0$. But then the requirement $\alpha b-a \beta \neq 0$ is not true, so this family can not be almost Kähler, so $\mathfrak{g}_{10}^{\mathcal{A}}=\{0\}$.
$(\mathcal{I})$ : Because $z_{1}=z_{2}=z_{3}=z_{4}=w_{1}=w_{2}=0$, we can see that the structure $J$ is always integrable in this family, therefore $\mathfrak{g}_{10}^{\mathcal{I}}=\mathfrak{g}_{10}(\alpha, a, \beta, b)$. $(\mathcal{K})$ : The Lie algebra $\mathfrak{g}_{10}$ is never in the Kähler class, hence $\mathfrak{g}_{10}^{\mathcal{K}}=\{0\}$.
9. Case (F) - $(\lambda=0, r=0$ And $\alpha b-a \beta=0)$

In this case our analysis divides into disjoint cases parametrized by $\Lambda=$ $(\alpha, a, \beta, b)$. The variables are assumed to be zero if and only if they are marked by 0 . For example, if $\Lambda=(0, a, \beta, 0)$ then the two variable $\alpha$ and $b$ are assumed to be zero and $a$ and $\beta$ to be non-zero.

Example $9.1\left(\mathfrak{g}_{11}\left(z_{1}, z_{2}, z_{3}, w_{1}, \theta_{1}, \theta_{2}\right)\right)$. This is a 6 -dimensional family of solvable Lie algebras. Here $\Lambda=(0,0,0,0)$ and $z_{1} \neq 0$, giving the Lie bracket relations

{[Z, X] } & =z_{1} Z+w_{1} W, \\
{[Z, Y] } & =z_{2} Z+\frac{z_{2} w_{1}}{z_{1}} W, \\
{[W, X] } & =z_{3} Z-z_{1} W, \\
{[W, Y] } & =\frac{z_{2} z_{3}}{z_{1}} Z-z_{2} W, \\
{[Y, X] } & =\theta_{1} Z+\theta_{2} W .
\end{aligned}

$(\mathcal{A K})$ : Because $\alpha=a=0$, we see that $\mathfrak{g}_{11}$ is in the almost Kähler class if and only if $\theta_{1}=\theta_{2}=0$. This gives a 4-dimensional family $\mathfrak{g}_{11}^{\mathcal{A}}\left(z_{1}, z_{2}, z_{3}, w_{1}\right)$ with

{[Z, X] } & =z_{1} Z+w_{1} W, \\
{[Z, Y] } & =z_{2} Z+\frac{z_{2} w_{1}}{z_{1}} W, \\
{[W, X] } & =z_{3} Z-z_{1} W, \\
{[W, Y] } & =\frac{z_{2} z_{3}}{z_{1}} Z-z_{2} W .
\end{aligned}
$$

Here the corresponding simply connected Lie group is a semidirect product $\mathbb{R}^{2} \ltimes \mathbb{R}^{2}$.
(I) : From the relations

$$
z_{1} \neq 0, \quad z_{4}=\frac{z_{2} z_{3}}{z_{1}} \quad \text { and } \quad w_{2}=\frac{z_{2} w_{1}}{z_{1}}
$$

we see that the structure $J$ is integrable if and only if

z_{3}+w_{1}=-2 z_{2} \quad \text { and } 2 z_{1}^{2}-z_{2}\left(z_{3}+w_{1}\right)=0
$$

This implies the impossible $z_{1}^{2}+z_{2}^{2}=0$, so the structure $J$ is never integrable, therefore $\mathfrak{g}_{11}^{\mathcal{K}}=\{0\}$.
$(\mathcal{K})$ : This family $\mathfrak{g}_{11}$ is never in the Kähler class, so $\mathfrak{g}_{11}^{\mathcal{K}}=\{0\}$.

and the Lie bracket relations

{[Z, Y] } & =w_{2} W \\
{[W, X] } & =z_{3} Z \\
{[W, Y] } & =\frac{z_{3} w_{2}}{w_{1}} Z, \\
{[Y, X] } & =\theta_{1} Z+\theta_{2} W .
\end{aligned}
$$

$(\mathcal{A K})$ : Since $\alpha=a=0$, this family is almost Kähler if and only if $\theta_{1}=\theta_{2}=$ 0 . This yields the 3 -dimensional family $\mathfrak{g}_{12}^{\mathcal{A} \mathcal{K}}\left(z_{3}, w_{1}, w_{2}\right)$ with the relations

{[Z, Y] } & =w_{2} W \\
{[W, X] } & =z_{3} Z \\
{[W, Y] } & =\frac{z_{3} w_{2}}{w_{1}} Z
\end{aligned}

Here the corresponding simply connected Lie group is a semidirect product $\mathbb{R}^{2} \ltimes \mathbb{R}^{2}$.
(I) : For $\mathfrak{g}_{12}$ we have

z_{1}=z_{2}=0, \quad z_{4}=\frac{z_{3} w_{2}}{w_{1}} \text { and } w_{1} \neq 0
$$

We see that the structure $J$ is integrable if and only if

$$
z_{3}+w_{1}=\frac{z_{3} w_{2}}{w_{1}}+w_{2}=0
$$

or equivalently, $z_{3}=-w_{1} \neq 0$. Here we yield the 4 -dimensional family $\mathfrak{g}_{12}^{\mathcal{I}}\left(w_{1}, w_{2}, \theta_{1}, \theta_{2}\right)$ which has the Lie bracket relations

$(\mathcal{K})$ : The family is Kähler if and only if $\theta_{1}=\theta_{2}=0$ and $z_{3}=-w_{1} \neq 0$, which gives the 2 -dimensional family $\mathfrak{g}_{12}^{\mathcal{K}}\left(w_{1}, w_{2}\right)$ with relations

{[Z, Y] } & =w_{2} W \\
{[W, X] } & =-w_{1} Z \\
{[W, Y] } & =-w_{2} Z
\end{aligned}

The corresponding simply connected Lie group is clearly a semidirect product $\mathbb{R}^{2} \ltimes \mathbb{R}^{2}$.

Example $9.3\left(\mathfrak{g}_{13}\left(z_{3}, z_{4}, \theta_{1}, \theta_{2}\right)\right)$. This is a 4-dimensional family of nilpotent Lie algebras. Here $\Lambda=(0,0,0,0), z_{1}=w_{1}=0$ and $z_{3} \neq 0$, which gives $z_{2}=w_{2}=0$ and the solutions

\begin{aligned}
{[W, X] } & =z_{3} Z \\
{[W, Y] } & =z_{4} Z \\
{[Y, X] } & =\theta_{1} Z+\theta_{2} W
\end{aligned}
$$

$(\mathcal{A K}):$ Because $\alpha=a=0$, we see that $\mathfrak{g}_{13}$ family is in the almost Kähler class if and only if $\theta_{1}=\theta_{2}=0$. We get the 2-dimensional family $\mathfrak{g}_{13}^{\mathcal{A K}}\left(z_{3}, z_{4}\right)$ with

\begin{aligned}
{[W, X] } & =z_{3} Z \\
{[W, Y] } & =z_{4} Z
\end{aligned}
$$

Here the corresponding simply connected Lie group is a semidirect product $\mathbb{R}^{2} \ltimes \mathbb{R}^{2}$ 。
$(\mathcal{I})$ : The condition $z_{1}=z_{2}=w_{1}=w_{2}=0$ gives that $J$ is integrable if and only if $z_{3}=z_{4}=0$, contradicting $z_{3} \neq 0$. Hence $\mathfrak{g}_{13}^{\mathcal{I}}=\{0\}$
$(\mathcal{K})$ : This family $\mathfrak{g}_{13}$ is never in the Kähler class, so $\mathfrak{g}_{13}^{\mathcal{K}}=\{0\}$.
Example $9.4\left(\mathfrak{g}_{14}\left(z_{2}, z_{4}, w_{2}, \theta_{1}, \theta_{2}\right)\right)$. Here we have the 5 -dimensional family of solvable Lie algebras with $\Lambda=(0,0,0,0)$ and $z_{1}=z_{3}=w_{1}=0$ and the bracket relations

$$
\begin{aligned}
{[Z, Y] } & =z_{2} Z+w_{2} W \\
{[W, Y] } & =z_{4} Z-z_{2} W \\
{[Y, X] } & =\theta_{1} Z+\theta_{2} W
\end{aligned}
$$

$(\mathcal{A K})$ : The condition $\alpha=a=0$ implies that this family is almost Kähler if and only if $\theta_{1}=\theta_{2}=0$. We get the 3 -dimensional family $\mathfrak{g}_{14}^{\mathcal{A K}}\left(z_{2}, z_{4}, w_{2}\right)$ given by

{[Z, Y] } & =z_{2} Z+w_{2} W \\
{[W, Y] } & =z_{4} Z-z_{2} W
\end{aligned}
$$

Here the corresponding simply connected Lie group is a semidirect product $\mathbb{R}^{2} \ltimes \mathbb{R}^{2}$ 。
$(\mathcal{I}):$ From $z_{1}=z_{3}=w_{1}=0$ we see that $J$ is integrable if and only if $z_{2}=0$ and $z_{4}+w_{2}=0$. This gives a 3-dimensional family $\mathfrak{g}_{14}^{\mathcal{I}}\left(w_{2}, \theta_{1}, \theta_{2}\right)$ with Lie bracket relations

$$
\begin{aligned}
{[Z, Y] } & =w_{2} W \\
{[W, Y] } & =-w_{2} Z \\
{[Y, X] } & =\theta_{1} Z+\theta_{2} W
\end{aligned}
$$

$(\mathcal{K})$ : The family is Kähler if and only if $\theta_{1}=\theta_{2}=0, z_{2}=0$ and $z_{4}+w_{2}=0$. We get a 1 -dimensional family $\mathfrak{g}_{14}^{\mathcal{K}}\left(w_{2}\right)$ with

{[Z, Y] } & =w_{2} W \\
{[W, Y] } & =-w_{2} Z
\end{aligned}
$$

The corresponding simply connected Lie group is clearly a semidirect product $\mathbb{R}^{2} \ltimes \mathbb{R}^{2}$.

Example $9.5\left(\mathfrak{g}_{15}\left(\alpha, w_{1}, w_{2}\right)\right)$. This is a 3 -dimensional family of solvable Lie algebras with $\Lambda=(\alpha, 0,0,0)$, which gives

$$
z_{1}=z_{2}=z_{3}=z_{4}=\theta_{1}=\theta_{2}=0
$$

and

$$
\begin{aligned}
{[Z, X] } & =\alpha X+w_{1} W \\
{[Z, Y] } & =\alpha Y+w_{2} W
\end{aligned}
$$

$(\mathcal{A K}):$ Here, $a=\theta_{1}=\theta_{2}=0$ and $\alpha \neq 0$, so we see that the almost Kähler is never fulfilled, hence $\mathfrak{g}_{15}^{\mathcal{A}}=\{0\}$.
$(\mathcal{I})$ : The conditions $z_{1}=z_{2}=z_{3}=z_{4}=0$ imply that $J$ is integrable if and only if $w_{1}=w_{2}=0$. We yield a 1-dimensional family $\mathfrak{g}_{15}^{\mathcal{I}}(\alpha)$ with

{[Z, Y] } & =\alpha Y
\end{aligned}
$$

Here the corresponding simply connected Lie group is a semidirect product $\mathbb{R}^{2} \ltimes \mathbb{R}^{2}$.
$(\mathcal{K})$ : Here the Kähler condition is never satisfied, so $\mathfrak{g}_{15}^{\mathcal{K}}=\{0\}$.
Example $9.6\left(\mathfrak{g}_{16}\left(\beta, w_{1}, w_{2}, \theta_{1}, \theta_{2}\right)\right)$. Here we have a 5 -dimensional family of Lie algebras. They are not solvable in general. Here $\Lambda=(0,0, \beta, 0)$, which implies $z_{1}=z_{2}=z_{3}=z_{4}=0$. This gives

\begin{aligned}
{[Z, X] } & =\beta Y+w_{1} W \\
{[Z, Y] } & =-\beta X+w_{2} W \\
{[Y, X] } & =\theta_{1} Z+\theta_{2} W
\end{aligned}
$$

$(\mathcal{A K}):$ We have $\alpha=a=0$, so this family is almost Kähler if and only if $\theta_{1}=\theta_{2}=0$. We get the 3 -dimensional family $\mathfrak{g}_{16}^{\mathcal{A K}}\left(\beta, w_{1}, w_{2}\right)$ with

{[Z, X] } & =\beta Y+w_{1} W \\
{[Z, Y] } & =-\beta X+w_{2} W
\end{aligned}
$$

$(\mathcal{I})$ : We have $z_{1}=z_{2}=z_{3}=z_{4}=0$, so $J$ is integrable if and only if $w_{1}=w_{2}=0$, giving the 3-dimensional family $\mathfrak{g}_{16}^{\mathcal{I}}\left(\beta, \theta_{1}, \theta_{2}\right)$ with

\begin{aligned}
{[Z, X] } & =\beta Y \\
{[Z, Y] } & =-\beta X \\
{[Y, X] } & =\theta_{1} Z+\theta_{2} W
\end{aligned}
$$

$(\mathcal{K})$ : The family $\mathfrak{g}_{16}$ is Kähler if and only if $\theta_{1}=\theta_{2}=0$ and $w_{1}=w_{2}=0$. We obtain the 1-dimensional family $\mathfrak{g}_{16}^{\mathcal{K}}(\beta)$ with Lie bracket relations

\begin{aligned}
{[Z, X] } & =\beta Y \\
{[Z, Y] } & =-\beta X
\end{aligned}
$$

The corresponding simply connected Lie group is clearly a semidirect product $\mathbb{R}^{2} \ltimes \mathbb{R}^{2}$.

Example 9.7 $\left(\mathfrak{g}_{17}\left(\alpha, a, w_{1}, w_{2}\right)\right)$. This is a 4-dimensional family of solvable Lie algebras $\Lambda=(\alpha, a, 0,0)$, which gives

z_{1}=-\frac{a w_{1}}{\alpha}, \quad z_{2}=-\frac{a w_{2}}{\alpha}, \quad z_{3}=-\frac{a^{2} w_{1}}{\alpha^{2}}, \quad z_{4}=-\frac{a^{2} w_{2}}{\alpha^{2}}, \quad \theta_{1}=0, \quad \theta_{2}=0
$$

Thus the bracker relations are

{[Z, X] } & =\alpha X-\frac{a w_{1}}{\alpha} Z+w_{1} W \\
{[Z, Y] } & =\alpha Y-\frac{a w_{2}}{\alpha} Z+w_{2} W \\

{[W, Y] } & =a Y-\frac{a^{2} w_{2}}{\alpha^{2}} Z+\frac{a w_{2}}{\alpha} W
\end{aligned}

$(\mathcal{A K})$ : Because $\theta_{1}=\theta_{2}=0, \alpha \neq 0$ and $a \neq 0$, the almost Kähler condition is never satisfied, hence $\mathfrak{g}_{17}^{\mathcal{A K}}=\{0\}$.
$(\mathcal{I})$ : From

$$
z_{1}=-\frac{a w_{1}}{\alpha}, \quad z_{2}=-\frac{a w_{2}}{\alpha}, \quad z_{3}=-\frac{a^{2} w_{1}}{\alpha^{2}} \quad \text { and } \quad z_{4}=-\frac{a^{2} w_{2}}{\alpha^{2}}
$$

we see that the structure $J$ is integrable if and only if

$$
\begin{equation*}
\left(\alpha^{2}-a^{2}\right) w_{1}=2 a \alpha w_{2} \quad \text { and } \quad\left(\alpha^{2}-a^{2}\right) w_{2}=-2 a \alpha w_{1} \tag{9.1}
\end{equation*}
$$

Since $2 a \alpha \neq 0$, we can divide and get

w_{2}=\frac{\alpha^{2}-a^{2}}{2 a \alpha} w_{1}=-\frac{\left(\alpha^{2}-a^{2}\right)^{2}}{4 a^{2} \alpha^{2}} w_{2}

If $w_{2} \neq 0$, then we yield the impossible $\left(\alpha^{2}+a^{2}\right)^{2}=0$. Thus $J$ is integrable if and only if $w_{1}=w_{2}=0$. This gives the 2-dimensional family $\mathfrak{g}_{17}^{\mathcal{H}}(\alpha, a)$ with

\end{aligned}

$$
\begin{aligned}
{[W, X] } & =a X, \\
{[W, Y] } & =a Y .
\end{aligned}

Here the corresponding simply connected Lie group is a semidirect product $\mathbb{R}^{2} \ltimes \mathbb{R}^{2}$.
$(\mathcal{K})$ : The family $\mathfrak{g}_{17}$ never satisfies the Kähler condition, so $\mathfrak{g}_{17}^{\mathcal{A} \mathcal{K}}=\{0\}$.
Example $9.8\left(\mathfrak{g}_{18}\left(\beta, b, z_{3}, z_{4}, \theta_{1}, \theta_{2}\right)\right)$. Here we have a 6 -dimensional family of Lie algebras. They are not solvable in general. Here $\Lambda=(0,0, \beta, b)$, which gives

$$
z_{1}=\frac{\beta z_{3}}{b}, \quad z_{2}=\frac{\beta z_{4}}{b}, \quad w_{1}=-\frac{\beta^{2} z_{3}}{b^{2}} \text { and } w_{2}=-\frac{\beta^{2} z_{4}}{b^{2}} .
$$

The bracket relations satisfy

$$
\begin{aligned}
{[Z, X] } & =\beta Y+\frac{\beta z_{3}}{b} Z-\frac{\beta^{2} z_{3}}{b^{2}} W \\
{[Z, Y] } & =-\beta X+\frac{\beta z_{4}}{b} Z-\frac{\beta^{2} z_{4}}{b^{2}} W \\
{[W, X] } & =b Y+z_{3} Z-\frac{\beta z_{3}}{b} W \\
{[W, Y] } & =-b X+z_{4} Z-\frac{\beta z_{4}}{b} W \\
{[Y, X] } & =\theta_{1} Z+\theta_{2} W
\end{aligned}
$$

$(\mathcal{A K})$ : Since $a=\alpha=0$, this family is almost Kähler if and only if $\theta_{1}=\theta_{2}=$ 0 . We get the 4 -dimensional family $\mathfrak{g}_{18}^{\mathcal{A} \mathcal{K}}\left(\beta, b, z_{3}, z_{4}\right)$ with

\begin{aligned}
{[Z, X] } & =\beta Y+\frac{\beta z_{3}}{b} Z-\frac{\beta^{2} z_{3}}{b^{2}} W \\
{[Z, Y] } & =-\beta X+\frac{\beta z_{4}}{b} Z-\frac{\beta^{2} z_{4}}{b^{2}} W \\
{[W, X] } & =b Y+z_{3} Z-\frac{\beta z_{3}}{b} W \\
{[W, Y] } & =-b X+z_{4} Z-\frac{\beta z_{4}}{b} W
\end{aligned}
$$

$(\mathcal{I})$ : For the family $\mathfrak{g}_{18}$ we have

z_{1}=\frac{\beta z_{3}}{b}, \quad z_{2}=\frac{\beta z_{4}}{b}, \quad w_{1}=-\frac{\beta^{2} z_{3}}{b^{2}} \text { and } w_{2}=-\frac{\beta^{2} z_{4}}{b^{2}}
$$

and we can easily see that $J$ is integrable if and only if

\left(\beta^{2}-b^{2}\right) z_{3}=2 \beta b z_{4} \text { and }\left(\beta^{2}-b^{2}\right) z_{4}=-2 \beta b z_{3}
$$

We notice that this system has the same form as that of (9.1). Thus the structure $J$ is integrable if and only if $z_{3}=z_{4}=0$. Here we yield the 4 -dimensional family $\mathfrak{g}_{18}^{\mathcal{I}}\left(\beta, b, \theta_{1}, \theta_{2}\right)$, where

{[Z, Y] } & =-\beta X,
\end{aligned}
$$

$$
\begin{aligned}
{[W, X] } & =b Y, \\
{[W, Y] } & =-b X \\
{[Y, X] } & =\theta_{1} Z+\theta_{2} W
\end{aligned}
$$

$(\mathcal{K})$ : The family is Kähler if and only if $\theta_{1}=\theta_{2}=0$ and $z_{3}=z_{4}=0$. Hence we obtain the 2 -dimensional family $\mathfrak{g}_{18}^{\mathcal{K}}(\beta, b)$ with

\begin{aligned}
{[Z, X] } & =\beta Y, \\
{[Z, Y] } & =-\beta X, \\
{[W, X] } & =b Y, \\
{[W, Y] } & =-b X .
\end{aligned}
$$

The corresponding simply connected Lie group is clearly a semidirect product $\mathbb{R}^{2} \ltimes \mathbb{R}^{2}$.

Example $9.9\left(\mathfrak{g}_{19}\left(\alpha, \beta, w_{1}, w_{2}\right)\right)$. This is a 4-dimensional family of solvable Lie algebras. Here $\Lambda=(\alpha, 0, \beta, 0)$, which implies that

$$
z_{1}=z_{2}=z_{3}=z_{4}=\theta_{1}=\theta_{2}=0
$$

and the bracket relations are

$$
\begin{aligned}
{[Z, X] } & =\alpha X+\beta Y+w_{1} W \\
{[Z, Y] } & =-\beta X+\alpha Y+w_{2} W .
\end{aligned}
$$

$(\mathcal{A K})$ : Here the almost Kähler condition is never satisfied since $\alpha \neq 0$ and $\theta_{2}=0$, hence $\mathfrak{g}_{19}^{\mathcal{A} \mathcal{K}}=\{0\}$.
(I) : Because $z_{1}=z_{2}=z_{3}=z_{4}=0$, the structure $J$ is integrable if and only if $w_{1}=w_{2}=0$. We yield the 2-dimensional family $\mathfrak{g}_{19}^{\mathcal{H}}(\alpha, \beta)$ given by

\begin{aligned}
{[Z, X] } & =\alpha X+\beta Y \\
{[Z, Y] } & =-\beta X+\alpha Y .
\end{aligned}
$$

Here the corresponding simply connected Lie group is a semidirect product $\mathbb{R}^{2} \ltimes \mathbb{R}^{2}$.
$(\mathcal{K})$ : The Kähler condition is never satisfied, so $\mathfrak{g}_{19}^{\mathcal{K}}=\{0\}$.
Example $9.10\left(\mathfrak{g}_{20}\left(\alpha, a, \beta, w_{1}, w_{2}\right)\right)$. Here we have a 5 -dimensional family of solvable Lie algebras. Now $\Lambda=(\alpha, a, \beta, b)$, which gives

$$
\begin{aligned}
z_{1}=-\frac{a w_{1}}{\alpha}, \quad z_{2} & =-\frac{a w_{2}}{\alpha}, \quad z_{3}=-\frac{a^{2} w_{1}}{\alpha^{2}}, \quad z_{4}=-\frac{a^{2} w_{2}}{\alpha^{2}} \\
b & =\frac{\beta a}{\alpha}, \quad \theta_{1}=0, \quad \theta_{2}=0 .
\end{aligned}
$$

The bracket relations fulfill

$$
\begin{aligned}
{[Z, X] } & =\alpha X+\beta Y-\frac{a w_{1}}{\alpha} Z+w_{1} W \\
{[Z, Y] } & =-\beta X+\alpha Y-\frac{a w_{2}}{\alpha} Z+w_{2} W
\end{aligned}
$$

$$
\begin{aligned}
{[W, X] } & =a X+\frac{\beta a}{\alpha} Y-\frac{a^{2} w_{1}}{\alpha^{2}} Z+\frac{a}{\alpha} w_{1} W, \\
{[W, Y] } & =-\frac{\beta a}{\alpha} X+a Y-\frac{a^{2} w_{2}}{\alpha^{2}} Z+\frac{a}{\alpha} w_{2} W .
\end{aligned}
$$

$(\mathcal{A K})$ : Since $\theta_{1}=\theta_{2}=0, \alpha \neq 0$ and $a \neq 0$, the almost Kähler condition is never satisfied, hence $\mathfrak{g}_{20}^{\mathcal{A K}}=\{0\}$.
$(\mathcal{I}):$ Here the coefficients $z_{1}, \ldots, z_{4}, w_{1}$ and $w_{2}$ are the same as for the family $\mathfrak{g}_{17}$. Thus the structure $J$ is integrable if and only if $w_{1}=w_{2}=0$. This gives the 3 -dimensional family $\mathfrak{g}_{20}^{\mathcal{I}}(\alpha, a, \beta)$ with

\begin{aligned}
{[Z, X] } & =\alpha X+\beta Y \\
{[Z, Y] } & =-\beta X+\alpha Y, \\
{[W, X] } & =a X+\frac{\beta a}{\alpha} Y, \\
{[W, Y] } & =-\frac{\beta a}{\alpha} X+a Y .
\end{aligned}
$$

Here the corresponding simply connected Lie group is a semidirect product $\mathbb{R}^{2} \ltimes \mathbb{R}^{2}$.
$(\mathcal{K})$ : The Kähler condition is never satisfied, therefore $\mathfrak{g}_{20}^{\mathcal{K}}=\{0\}$.

## Appendix A. The Homogeneous Second Order System

In Section 2 we presented the general bracket relations (2.1). To ensure that these actually define a Lie algebra they must satisfy the Jacobi equation. A standard computation shows that this is equivalent to the following system of 14 second order homogeneous polynomial equations in the 14 variables involved

& 0=\lambda \theta_{1}-w_{1} z_{4}+w_{2} z_{3}-2 a \theta_{2}-r z_{1}, \\
& 0=-\lambda \theta_{2}+2 z_{1} w_{2}-2 z_{2} w_{1}-2 \alpha \theta_{2}+r w_{1}, \\
& 0=-w_{2} a-w_{1} b-z_{2} \alpha-z_{1} \beta-\alpha r, \\
& 0=-w_{2} b+w_{1} a-z_{2} \beta+z_{1} \alpha+r \beta, \\
& 0=\lambda z_{1}-w_{2} b-z_{2} \beta-w_{1} a-z_{1} \alpha, \\
& 0=z_{2} a+z_{1} b-z_{4} \alpha-z_{3} \beta-a r, \\
& 0=z_{2} b-z_{1} a-z_{4} \beta+z_{3} \alpha+r b, \\
& 0=\lambda z_{2}-w_{2} a-z_{2} \alpha+w_{1} b+z_{1} \beta .
