# APPROXIMATION OF THE ELASTIC DIRICHLET-TO-NEUMANN MAP

#### Abstract

We study the Dirichlet-to-Neumann map for the stationary linear equation of elasticity in a bounded domain in $\mathbb{R}^{d}, d \geq 2$, with smooth boundary. We show that it can be approximated by a pseudodifferential operator on the boundary with a matrix-valued symbol and we compute the principal symbol modulo conjugation by unitary matrices.

Key words: linear equation of elasticity, Dirichlet-to-Neumann map.


## 1. Introduction

Let $\Omega \subset \mathbb{R}^{d}, d \geq 2$, be a bounded, connected domain with a $C^{\infty}$ smooth boundary $\Gamma=\partial \Omega$, and consider the stationary isotropic linear equation of elasticity

\left(\Delta_{\lambda, \mu}+\tau^{2} n(x)\right) u=0 \quad \text { in } \Omega,  \tag{1.1}\\
u=f \text { on } \Gamma,
\end{array}\right.
$$

where $\tau \in \mathbb{C}, \operatorname{Re} \tau>0,|\tau| \gg 1, u=\left(u_{1}, \ldots, u_{d}\right), f=\left(f_{1}, \ldots, f_{d}\right)$, and $\Delta_{\lambda, \mu}$ denotes the elastic Laplacian defined by

$$

where

$$
\sigma_{i j}(u)=\lambda \operatorname{div} u \delta_{i j}+\mu\left(\frac{\partial u_{i}}{\partial x_{j}}+\frac{\partial u_{j}}{\partial x_{i}}\right)
$$

is the stress tensor, $\delta_{i j}=1$ if $i=j, \delta_{i j}=0$ if $i \neq j$. Here $\lambda, \mu \in C^{\infty}(\bar{\Omega})$ are scalar real-valued functions called Lamé parameters supposed to satisfy the condition

\mu(x)>0, \quad \lambda(x)+\mu(x)>0, \quad \forall x \in \bar{\Omega} . \tag{1.2}

The scalar function $n \in C^{\infty}(\bar{\Omega})$ in (1.1) is the density and is supposed to be strictly positive. It is easy to see that the elastic Laplacian can be written in the form

\Delta_{\lambda, \mu} u=\mu \Delta u+(\lambda+\mu) \nabla(\nabla \cdot u)

modulo a first-order matrix-valued differential operator, where $\Delta$ and $\nabla$ denote the Euclidean Laplacian and gradient, respectively.

The natural Neumann boundary condition for the elastic equation is $B_{\lambda, \mu} u=0$, where

$\nu=\left(\nu_{1}, \ldots, \nu_{d}\right)$ being the Euclidean unit normal to $\Gamma$. We define the elastic Dirichlet-to-Neumann map

N(\tau): H^{1}\left(\Gamma ; \mathbb{C}_{1}^{d}\right) \rightarrow L^{2}\left(\Gamma ; \mathbb{C}^{d}\right)
$$

by

$$
N(\tau) f=\left.B_{\lambda, \mu} u\right|_{\Gamma}
$$

where $u$ and $f$ satisfy the equation (1.1).
The equation (1.1) describes the propagation of elastic waves in $\Omega$ with a frequency $\tau$. It is well-known that the elastic waves are superpositions of two waves, called $S$ and $P$ waves, mooving with speeds $\sqrt{\frac{\mu}{n}}$ and $\sqrt{\frac{2 \mu+\lambda}{n}}$, respectively. From purely mathematical point of view, this is explained by the fact that the principal symbol, $P$, of the operator $-\Delta_{\lambda, \mu}$ can be decomposed as

where $c_{s}=\mu, c_{p}=2 \mu+\lambda, \Pi_{s}(\xi)+\Pi_{p}(\xi)=\xi^{2} I_{d}, I_{d}$ being the identity $d \times d$ matrix, and $\Pi_{p}(\xi)=$ $\xi \otimes \xi$. Throughout this paper, given two vectors $\xi=\left(\xi_{1}, \ldots, \xi_{d}\right) \in \mathbb{C}^{d}, \eta=\left(\eta_{1}, \ldots, \eta_{d}\right) \in \mathbb{C}^{d}$, we will denote by $\xi \otimes \eta$ the matrix defined by

(\xi \otimes \eta) g=\langle\xi, g\rangle \eta, \quad g \in \mathbb{C}^{d}
$$

Hereafter, $\langle\xi, g\rangle:=\xi_{1} g_{1}+\ldots+\xi_{d} g_{d}$ and $\xi^{2}:=\langle\xi, \xi\rangle$.
Note that the existance of two different speeds implies that the boundary value problem (1.1) has two disjoint glancing regions $\Sigma_{s}$ and $\Sigma_{p}$ defined by

& \Sigma_{s}=\left\{\left(x^{\prime}, \xi^{\prime}\right) \in T^{*} \Gamma: c_{s, 0}\left(x^{\prime}\right) r_{0}\left(x^{\prime}, \xi^{\prime}\right)-n_{0}\left(x^{\prime}\right)=0\right\}, \\
& \Sigma_{p}=\left\{\left(x^{\prime}, \xi^{\prime}\right) \in T^{*} \Gamma: c_{p, 0}\left(x^{\prime}\right) r_{0}\left(x^{\prime}, \xi^{\prime}\right)-n_{0}\left(x^{\prime}\right)=0\right\},
\end{aligned}
$$

where $c_{s, 0}=\left.c_{s}\right|_{\Gamma}, c_{p, 0}=\left.c_{p}\right|_{\Gamma}, n_{0}=\left.n\right|_{\Gamma}$, and $r_{0} \geq 0$ is the principal symbol of the operator $-\Delta_{\Gamma}$. Here $\Delta_{\Gamma}$ denotes the negative Laplace-Beltrami operator on $\Gamma$ with Riemannian metric induced by the Euclidean one. Set $h=(\operatorname{Re} \tau)^{-1}$ if $\operatorname{Re} \tau \geq|\operatorname{Im} \tau|$ and $h=|\operatorname{Im} \tau|^{-1}$ if $|\operatorname{Im} \tau| \geq \operatorname{Re} \tau$, $z=h \tau$ and $\theta=|\operatorname{Im} z| \leq 1$. Clearly, in the first case we have $z=1+i \theta$, while in the second case we have $\theta=1$. When $\theta>0$ we introduce the functions

\rho_{s}\left(x^{\prime}, \xi^{\prime}, z\right)=\sqrt{-r_{0}\left(x^{\prime}, \xi^{\prime}\right)+z^{2} n_{0}\left(x^{\prime}\right) / c_{s, 0}\left(x^{\prime}\right)}, & \operatorname{Im} \rho_{s}>0, \\
\rho_{p}\left(x^{\prime}, \xi^{\prime}, z\right)=\sqrt{-r_{0}\left(x^{\prime}, \xi^{\prime}\right)+z^{2} n_{0}\left(x^{\prime}\right) / c_{p, 0}\left(x^{\prime}\right)}, & \operatorname{Im} \rho_{p}>0 .
\end{array}
$$

Our goal in the present paper is to approximate the operator

$$
\mathcal{N}(z, h):=-i h N(z / h)
$$

by a matrix-valued $h-\Psi$ DO similarly to the Dirichlet-to-Neumann operator associated to the Helmholtz equation (see [6] [7]) or that one associated to the Maxwell equation (see [8]). We also compute the principal symbol in terms of the functions $\rho_{s}, \rho_{p}$ (see Lemma 5.5). Denote by $M_{2}$ the $2 \times 2$ matrix with entries $M_{i j}$ given by

& -M_{21}=M_{12}=-2 \mu_{0} \sqrt{r_{0}}+\frac{z^{2} n_{0} \sqrt{r_{0}}}{r_{0}+\rho_{s} \rho_{p}},
\end{aligned}

where $\mu_{0}=\left.\mu\right|_{\Gamma}=c_{s, 0}$. When $d \geq 3$ we set

$$
M_{d}=\widetilde{M}_{2}+\mu_{0} \rho_{s}\left(I_{d}-\widetilde{I}_{2}\right)
$$

Throughout this paper, given a $2 \times 2$ matrix $M$ with entries $M_{i j}$, we denote by $\widetilde{M}$ the $d \times d$ matrix with entries $\widetilde{M}_{i j}=M_{i j}$ if $1 \leq i, j \leq 2, \widetilde{M}_{i j}=0$ otherwise. Given a partition of the unity $\kappa_{\ell} \in C^{\infty}\left(T^{*} \Gamma \backslash 0\right), 0 \leq \kappa_{\ell} \leq 1, \ell=1, \ldots, L, \sum_{\ell=1}^{L} \kappa_{\ell}=1$, introduce the function

\end{equation*}

where $J_{\ell}\left(x^{\prime}, \xi^{\prime}\right) \in C^{\infty}\left(T^{*} \Gamma \backslash 0\right)$ are matrix-valued functions, homogeneous of order zero in $\xi^{\prime}$, and such that $J_{\ell}^{-1}=J_{\ell}^{t}$. Our main result is the following

Theorem 1.1. Let $\theta \geq h^{2 / 5-\epsilon}$ and $0<h \ll 1$, where $0<\epsilon \ll 1$ is arbitrary. Then for every $f \in H^{3}\left(\Gamma ; \mathbb{C}^{d}\right)$ we have the estimate

\left\|\mathcal{N}(z, h) f-\operatorname{Op}_{h}\left(m_{d}\right) f\right\|_{L^{2}\left(\Gamma ; \mathbb{C}^{d}\right)} \lesssim h \theta^{-2}\left(1+(d-2) \theta^{-1 / 2}\right)\|f\|_{H_{h}^{3}\left(\Gamma ; \mathbb{C}^{d}\right)} \tag{1.4}
\end{equation*}
$$

where $m_{d} \in C^{\infty}\left(T^{*} \Gamma\right)$ is of the form (1.3) with a suitable partition of the unity $\kappa_{\ell}$ and matrixvalued functions $J_{\ell}$ independent of $\lambda, \mu$ and $n$. When $d=2$ the functions $J_{\ell}$ do not depend on the variable $\xi^{\prime}$.

Hereafter the Sobolev spaces are equipped with the $h$-semiclassical norm. Note that much better estimates for the Dirichlet-to-Neumann operator associated to the Helmholtz equation are proved in [6], [7]. This is due to the fact that one can construct a much better parametrix near the boundary for the Helmholtz equation than that one for the equation (1.1) we construct in the present paper. Indeed, such a parametrix is built in [6, [7] in the form of an oscilatory integral with a complex-valued phase function and an amplitude satisfying the eikonal and transport equations $\bmod \mathcal{O}\left(x_{1}^{N}\right)$, respectively, where $N \gg 1$ is arbitrary and $0<x_{1} \ll 1$ denotes the normal variable near the boundary, that is, the distance to $\Gamma$. Thus the parametrix satisfies the Helmholtz equation modulo an error term which is given by an oscilatory integral with amplitude of the form $\mathcal{O}\left(x_{1}^{N}\right)+\mathcal{O}\left(h^{N}\right)$. In the case of the equation (1.1), however, it is very hard to solve the transport equations, especially when the boundary data $f$ is microlocally supported in a neighbourhood of the glancing regions. That is why we build in the present paper a less accurate parametrix for the equation (1.1) which does not require to solve transport equations. In this case the parametrix is a sum of two oscilatory integrals with two complex-valued phase functions corresponding to the two speeds of propagation of the elastic waves. Each of these phase functions satisfies the same eikonal equation as in the case of the Helmholtz equation solved in [6]. The parametrix satisfies the equation (1.1) modulo an error term which is given by a sum of two oscilatory integrals with amplitudes of the form $\mathcal{O}\left(x_{1}^{N}\right)+\mathcal{O}(h)$. To estimate the difference between the exact solution to equation (1.1) and its parametrix we use the a priori estimate (4.2). Most probably, the estimate (1.4) is not optimal and could be improved if one manages to build a better parametrix. In particular, for some applications it is better to have the $L^{2}$ norm in the right-hand side of (1.4) instead of the $H_{h}^{3}$ one. To do so, one needs to construct a better parametrix in the deep elliptic region, only, that is, in $\left\{r_{0} \gg 1\right\}$. Recall that the approximation of the Dirichlet-to-Neumann map is usually used to get parabolic regions free of transmission eigenvalues (see [6, [7, [8]).

Note that microlocal parametrices have been recently constructed in [2, [3], [9] for the wave elastic equation in the case $d=3$. All these parametrices, however, are very different from the parametrix we construct in the present paper. In particular, they are not valid near the glancing regions. In contrast, our parametrix remains valid even when the boundary data is microlocally supported near $\Sigma_{s}$ and $\Sigma_{p}$, provided $\theta \geq h^{2 / 5-\epsilon}$. In [9] the principal symbol of the DN map has been computed explicitly still in the context of the wave elastic equation and $d=3$. Note that
the formula in [9] agrees with that one we get in the present paper modulo a conjugation by a unitary matrix and after making a suitable change in the notations. In [4] a full parametrix was constructed for the stationary elastic equation in the exterior of a strictly convex body when $d=3$ and the Lamé parameters being constants. In this case the parametrix for the elastic equation can be expressed in terms of the parametrix for the Helmholtz equation, which in turn is well-known. Similarly, one can construct a parametrix in the elliptic region for the stationary elastic equation in the exterior of an arbitrary compact body (see [5]).

## 2. Preliminaries

Throuhout this paper we will denote by $e_{1}, e_{2}, \ldots, e_{d} \in \mathbb{R}^{d}$ the vectors $(1,0, \ldots, 0),(0,1, \ldots, 0)$, $\ldots,(0,0, \ldots, 1)$, respectively. Given $\xi=\left(\xi_{1}, \xi_{2}, \ldots, \xi_{d}\right) \in \mathbb{C}^{d}$, introduce the $d \times d$ matrix

U_{0}(\xi)=\xi_{1} I_{d}+\sum_{j=2}^{d} \xi_{j}\left(e_{j} \otimes e_{1}-e_{1} \otimes e_{j}\right)
$$

Set $\xi^{2}=\sum_{j=1}^{d} \xi_{j}^{2}$ and $|\xi|^{2}=\sum_{j=1}^{d}\left|\xi_{j}\right|^{2}$. In this section we will prove the next two lemmas.
Lemma 2.1. The matrix $U_{0}$ satisfies

$$
\begin{equation*}
U_{0}(\xi) \xi=\xi^{2} e_{1} \tag{2.1}
\end{equation*}
$$

Moreover, the matrices $e_{1} \otimes e_{1}$ and $Z_{0}(\xi):=U_{0}(\xi) U_{0}^{t}(\xi)$ commute.
Proof. We have

$$
\begin{aligned}
& U_{0}(\xi) \xi=\xi_{1} \xi+\sum_{j=2}^{d} \xi_{j}\left(\left\langle e_{j}, \xi\right\rangle e_{1}-\left\langle e_{1}, \xi\right\rangle e_{j}\right) \\
& =\sum_{j=1}^{d} \xi_{1} \xi_{j} e_{j}+\sum_{j=2}^{d} \xi_{j}\left(\xi_{j} e_{1}-\xi_{1} e_{j}\right)=\sum_{j=1}^{d} \xi_{j}^{2} e_{1}
\end{aligned}
$$

which proves (2.1). Set $\widetilde{\xi}=\left(0, \xi_{2}, \ldots, \xi_{d}\right)$. Then $U_{0}^{t}(\widetilde{\xi})=-U_{0}(\widetilde{\xi})$ and hence

Z_{0}(\xi)=\xi_{1}^{2} I_{d}-U_{0}(\widetilde{\xi})^{2}
$$

On the other hand, it is easy to see that

$$
\begin{aligned}
U_{0}(\widetilde{\xi})\left(e_{1} \otimes e_{1}\right) & =-\sum_{j=2}^{d} \xi_{j} e_{1} \otimes e_{j} \\
\left(e_{1} \otimes e_{1}\right) U_{0}(\widetilde{\xi}) & =\sum_{j=2}^{d} \xi_{j} e_{j} \otimes e_{1}
\end{aligned}
$$

Thus we get

$$
\left(e_{1} \otimes e_{1}\right) U_{0}(\widetilde{\xi})^{2}=-\widetilde{\xi}^{2} e_{1} \otimes e_{1}=U_{0}(\widetilde{\xi})^{2}\left(e_{1} \otimes e_{1}\right)
$$

and hence $Z_{0}(\xi)$ and $e_{1} \otimes e_{1}$ commute.
Given a matrix $A$ with entries $A_{i j}$, define its norm by $\|A\|=\max _{i j}\left|A_{i j}\right|$.

Lemma 2.2. Given any $\eta_{1} \in \mathbb{C}$ we have the formula

\operatorname{det}\left(U_{0}(\xi)+\eta_{1} e_{1} \otimes e_{1}\right)=\left(\xi^{2}+\xi_{1} \eta_{1}\right) \xi_{1}^{d-2} \tag{2.2}

When $d \geq 3$ suppose that $\xi_{1} \in \mathbb{C}, \xi_{1} \neq 0$, and $\xi_{k} \in \mathbb{R}, k=2, \ldots, d$. Then, if $\xi^{2}+\xi_{1} \eta_{1} \neq 0$, we have the estimate

\left\|\left(U_{0}(\xi)+\eta_{1} e_{1} \otimes e_{1}\right)^{-1}\right\| \lesssim\left(|\xi|+\left|\eta_{1}\right|\right)\left|\xi^{2}+\xi_{1} \eta_{1}\right|^{-1}+(d-2)\left|\xi_{1}\right|^{-1} \tag{2.3}
\end{equation*}

Proof. Denote the matrix $U_{0}(\xi)+\eta_{1} e_{1} \otimes e_{1}$ by $\mathcal{M}_{d}\left(\xi_{1}, \ldots, \xi_{d}, \eta_{1}\right)$. The lemma is very easy to prove when $d=2$. Indeed, in this case we have

\mathcal{M}_{2}\left(\xi_{1}, \xi_{2}, \eta_{1}\right)=\left(\begin{array}{cc}
\xi_{1}+\eta_{1} & \xi_{2} \\
-\xi_{2} & \xi_{1}
\end{array}\right)

and hence $\operatorname{det} \mathcal{M}_{2}=\xi^{2}+\xi_{1} \eta_{1}$. Moreover, if $\xi^{2}+\xi_{1} \eta_{1} \neq 0$, we have

\mathcal{M}_{2}^{-1}\left(\xi_{1}, \xi_{2}, \eta_{1}\right)=\left(\xi^{2}+\xi_{1} \eta_{1}\right)^{-1}\left(\begin{array}{cc}
\xi_{1} & -\xi_{2} \\
\xi_{2} & \xi_{1}+\eta_{1}
\end{array}\right)
$$

and (2.3) in this case is obvious. When $d \geq 3$ the formula (2.2) can be proved by induction. Indeed, we have

\operatorname{det} \mathcal{M}_{d}\left(\xi_{1}, \ldots, \xi_{d}, \eta_{1}\right)=\xi_{1} \operatorname{det} \mathcal{M}_{d-1}\left(\xi_{1}, \ldots, \xi_{d-1}, \eta_{1}\right)+(-1)^{d} \xi_{d} \operatorname{det} \mathcal{P}_{d-1}\left(\xi_{1}, \ldots, \xi_{d}\right)
$$

where $\mathcal{P}_{d-1}$ denotes the $(d-1) \times(d-1)$ matrix with lines $\left(\xi_{2}, \ldots, \xi_{d}\right),\left(0, \xi_{1}, 0, \ldots, 0\right), \ldots,\left(0, \ldots, \xi_{1}, 0\right)$. Hence

$$
\begin{aligned}
& \operatorname{det} \mathcal{P}_{d-1}\left(\xi_{1}, \xi_{2}, \ldots, \xi_{d}\right)=\xi_{1}^{d-2} \operatorname{det} \mathcal{P}_{d-1}\left(1, \xi_{2}, \ldots, \xi_{d}\right) \\
& \quad=\xi_{1}^{d-2} \operatorname{det} \mathcal{P}_{d-1}\left(1,0, \ldots, 0, \xi_{d}\right)=(-1)^{d} \xi_{d} \xi_{1}^{d-2}
\end{aligned}
$$

Thus we get

$$
\operatorname{det} \mathcal{M}_{d}\left(\xi_{1}, \ldots, \xi_{d}, \eta_{1}\right)=\xi_{1} \operatorname{det} \mathcal{M}_{d-1}\left(\xi_{1}, \ldots, \xi_{d-1}, \eta_{1}\right)+\xi_{d}^{2} \xi_{1}^{d-2}
$$

It is clear now that if (2.2) holds for $\operatorname{det} \mathcal{M}_{d-1}$, it holds for $\operatorname{det} \mathcal{M}_{d}$, as well. Thus we conclude that (2.2) holds for all $d$.

The proof of (2.3) when $d \geq 3$ is more delicate. Set $\widetilde{\xi}=\left(0, \xi^{\prime}\right) \in \mathbb{R}^{d}$, where $\xi^{\prime}=\left(\xi_{2}, \ldots, \xi_{d}\right) \in$ $\mathbb{R}^{d-1}$, and suppose that there exists a $d \times d$ matrix $\Theta\left(\xi^{\prime}\right)$, homogeneous of order zero, such that $\Theta\left(\xi^{\prime}\right) e_{1}=e_{1}, \Theta\left(\xi^{\prime}\right) \widetilde{\xi}=\left|\xi^{\prime}\right| e_{2}, \Theta\left(\xi^{\prime}\right)^{-1}=\Theta^{t}\left(\xi^{\prime}\right)$ and $\left\|\Theta\left(\xi^{\prime}\right)\right\| \leq C$ with a constant $C>0$ independent of $\xi^{\prime}$. Then, given any $g \in \mathbb{C}^{d}$, we have

U_{0}(\widetilde{\xi}) \Theta^{t}\left(\xi^{\prime}\right) g=\left\langle\Theta\left(\xi^{\prime}\right) \widetilde{\xi}, g\right\rangle e_{1}-\left\langle\Theta\left(\xi^{\prime}\right) e_{1}, g\right\rangle \widetilde{\xi}=\left|\xi^{\prime}\right|\left\langle e_{2}, g\right\rangle e_{1}-\left\langle e_{1}, g\right\rangle \widetilde{\xi}
$$

Hence

$$
\begin{gathered}
\Theta\left(\xi^{\prime}\right) U_{0}(\widetilde{\xi}) \Theta^{t}\left(\xi^{\prime}\right) g=\left|\xi^{\prime}\right|\left\langle e_{2}, g\right\rangle \Theta\left(\xi^{\prime}\right) e_{1}-\left\langle e_{1}, g\right\rangle \Theta\left(\xi^{\prime}\right) \widetilde{\xi} \\
=\left|\xi^{\prime}\right|\left\langle e_{2}, g\right\rangle e_{1}-\left|\xi^{\prime}\right|\left\langle e_{1}, g\right\rangle e_{2}=U_{0}\left(\left|\xi^{\prime}\right| e_{2}\right) g,
\end{gathered}
$$

which implies

U_{0}(\xi)=\Theta^{t}\left(\xi^{\prime}\right) U_{0}\left(\xi_{1} e_{1}+\left|\xi^{\prime}\right| e_{2}\right) \Theta\left(\xi^{\prime}\right)
$$

Since $\Theta^{t}\left(\xi^{\prime}\right)\left(e_{1} \otimes e_{1}\right) \Theta\left(\xi^{\prime}\right)=\left(e_{1} \otimes e_{1}\right)$, we obtain

\left(U_{0}(\xi)+\eta_{1} e_{1} \otimes e_{1}\right)^{-1}=\Theta\left(\xi^{\prime}\right)\left(U_{0}\left(\xi_{1} e_{1}+\left|\xi^{\prime}\right| e_{2}\right)+\eta_{1} e_{1} \otimes e_{1}\right)^{-1} \Theta^{t}\left(\xi^{\prime}\right) \tag{2.4}
\end{equation*}
$$

This implies

$$
\begin{equation*}
\left\|\left(U_{0}(\xi)+\eta_{1} e_{1} \otimes e_{1}\right)^{-1}\right\| \lesssim\left\|\left(U_{0}\left(\xi_{1} e_{1}+\left|\xi^{\prime}\right| e_{2}\right)+\eta_{1} e_{1} \otimes e_{1}\right)^{-1}\right\| \tag{2.5}
\end{equation*}
$$

On the other hand,

\begin{equation*}
\left(U_{0}\left(\xi_{1} e_{1}+\left|\xi^{\prime}\right| e_{2}\right)+\eta_{1} e_{1} \otimes e_{1}\right)^{-1}=\widetilde{\mathcal{M}_{2}^{-1}}\left(\xi_{1},\left|\xi^{\prime}\right|, \eta_{1}\right)+\xi_{1}^{-1} \sum_{j=3}^{d} e_{j} \otimes e_{j} \tag{2.6}
\end{equation*}
$$

It follows from (2.6) that

\left\|\left(U_{0}\left(\xi_{1} e_{1}+\left|\xi^{\prime}\right| e_{2}\right)+\eta_{1} e_{1} \otimes e_{1}\right)^{-1}\right\| \leq\left\|\mathcal{M}_{2}^{-1}\left(\xi_{1},\left|\xi^{\prime}\right|, \eta_{1}\right)\right\|+\left|\xi_{1}\right|^{-1} \tag{2.7}
\end{equation*}
$$

Clearly, in this case (2.3) follows from (2.5) and (2.7).
It remains to see that such a matrix $\Theta\left(\xi^{\prime}\right)$ exists. When $d=3$ it is easy to see that the matrix

0 & \xi_{2} /\left|\xi^{\prime}\right| & \xi_{3} /\left|\xi^{\prime}\right| \\
0 & -\xi_{3} /\left|\xi^{\prime}\right| & \xi_{2} /\left|\xi^{\prime}\right|
\end{array}\right)
$$

has the desired properties. When $d \geq 4$, however, it is hard (and probably impossible) to find only one global matrix $\Theta\left(\xi^{\prime}\right)$ with these properties. Such a matrix, however, exists locally. Indeed, let $\mathcal{U} \subset \mathbb{S}^{d-2}$ be a small open domain in the unit sphere of dimension $d-2$. Then there exists a smooth $(d-1) \times(d-1)$ matrix-valued function $V(w), w \in \mathcal{U}$, depending on $\mathcal{U}$, such that $V^{-1}(w)=V^{t}(w)$ and $V(w) w=\widetilde{e}_{1}=(1,0, \ldots, 0) \in \mathbb{R}^{d-1}$. Then we define the matrix $\Theta\left(\xi^{\prime}\right)$ for $\xi^{\prime} /\left|\xi^{\prime}\right| \in \mathcal{U}$ by

\Theta\left(\xi^{\prime}\right)=\left(\begin{array}{cc}
1 & 0 \\
0 & V\left(\xi^{\prime} /\left|\xi^{\prime}\right|\right)
\end{array}\right)
$$

It is easy to see that $\Theta\left(\xi^{\prime}\right)$ has the desired properties as long as $\xi^{\prime} /\left|\xi^{\prime}\right| \in \mathcal{U}$. Thus we can cover $\mathbb{S}^{d-2}$ by a finite number of open sets $\mathcal{U}_{k}, k=1, \ldots, K$, so that to each $\mathcal{U}_{k}$ we can associate a matrix-valued function $\Theta_{k}\left(\xi^{\prime}\right)$ having the desired properties for $\xi^{\prime} /\left|\xi^{\prime}\right| \in \mathcal{U}_{k}$. Then the identity (2.4) remains valid with $\Theta\left(\xi^{\prime}\right)$ replaced by $\Theta_{k}\left(\xi^{\prime}\right)$ as long as $\xi^{\prime} /\left|\xi^{\prime}\right| \in \mathcal{U}_{k}$. This implies the bounds (2.5) and (2.7) for $\xi^{\prime} /\left|\xi^{\prime}\right| \in \mathcal{U}_{k}, k=1, \ldots, K$, and hence for all $\xi^{\prime} /\left|\xi^{\prime}\right| \in \mathbb{S}^{d-2}$.

## 3. Some properties of the $h-\Psi$ DOs

We will first introduce the spaces of symbols which will play an important role in our analysis and will recall some basic properties of the $h-\Psi D O s$. Given $k \in \mathbb{R}, \delta_{1}, \delta_{2} \geq 0$, we denote by $S_{\delta_{1}, \delta_{2}}^{k}$ the space of all functions $a \in C^{\infty}\left(T^{*} \Gamma\right)$, which may depend on the semiclassical parameter $h$, satisfying

\left|\partial_{x^{\prime}}^{\alpha} \partial_{\xi^{\prime}}^{\beta} a\left(x^{\prime}, \xi^{\prime}, h\right)\right| \leq C_{\alpha, \beta}\left\langle\xi^{\prime}\right\rangle^{k-\delta_{1}|\alpha|-\delta_{2}|\beta|}
$$

for all multi-indices $\alpha$ and $\beta$, with constants $C_{\alpha, \beta}$ independent of $h$. More generally, given a function $\omega>0$ on $T^{*} \Gamma$, we denote by $S_{\delta_{1}, \delta_{2}}^{k}(\omega)$ the space of all functions $a \in C^{\infty}\left(T^{*} \Gamma\right)$, which may depend on the semiclassical parameter $h$, satisfying

\left|\partial_{x^{\prime}}^{\alpha} \partial_{\xi^{\prime}}^{\beta} a\left(x^{\prime}, \xi^{\prime}, h\right)\right| \leq C_{\alpha, \beta} \omega^{k-\delta_{1}|\alpha|-\delta_{2}|\beta|}
$$

for all multi-indices $\alpha$ and $\beta$, with constants $C_{\alpha, \beta}$ independent of $h$ and $\omega$. Thus $S_{\delta_{1}, \delta_{2}}^{k}=$ $S_{\delta_{1}, \delta_{2}}^{k}\left(\left\langle\xi^{\prime}\right\rangle\right)$. Given a matrix-valued symbol $a$, we will say that $a \in S_{\delta_{1}, \delta_{2}}^{k}$ if all entries of $a$ belong to $S_{\delta_{1}, \delta_{2}}^{k}$. Also, given $k \in \mathbb{R}, 0 \leq \delta<1 / 2$, we denote by $\mathcal{S}_{\delta}^{k}$ the space of all functions $a \in C^{\infty}\left(T^{*} \Gamma\right)$, which may depend on the semiclassical parameter $h$, satisfying

$$
\left|\partial_{x^{\prime}}^{\alpha} \partial_{\xi^{\prime}}^{\beta} a\left(x^{\prime}, \xi^{\prime}, h\right)\right| \leq C_{\alpha, \beta} h^{-\delta(|\alpha|+|\beta|)}\left\langle\xi^{\prime}\right\rangle^{k-|\beta|}
$$

for all multi-indices $\alpha$ and $\beta$, with constants $C_{\alpha, \beta}$ independent of $h$. Again, given a matrixvalued symbol $a$, we will say that $a \in \mathcal{S}_{\delta}^{k}$ if all entries of $a$ belong to $\mathcal{S}_{\delta}^{k}$. The $h-\Psi$ DO with a symbol $a$ is defined by

\left(\mathrm{Op}_{h}(a) f\right)\left(x^{\prime}\right)=(2 \pi h)^{-d+1} \iint e^{-\frac{i}{h}\left\langle x^{\prime}-y^{\prime}, \xi^{\prime}\right\rangle} a\left(x^{\prime}, \xi^{\prime}, h\right) f\left(y^{\prime}\right) d \xi^{\prime} d y^{\prime}
$$

If $a \in S_{0,1}^{k}$, then the operator $\mathrm{Op}_{h}(a): H_{h}^{k}(\Gamma) \rightarrow L^{2}(\Gamma)$ is bounded uniformly in $h$, where

\|u\|_{H_{h}^{k}(\Gamma)}:=\left\|\operatorname{Op}_{h}\left(\left\langle\xi^{\prime}\right\rangle^{k}\right) u\right\|_{L^{2}(\Gamma)}
$$

It is also well-known (e.g. see Section 7 of [1) that, if $a \in \mathcal{S}_{\delta}^{0}, 0 \leq \delta<1 / 2$, then $\operatorname{Op}_{h}(a)$ : $H_{h}^{s}(\Gamma) \rightarrow H_{h}^{s}(\Gamma)$ is bounded uniformly in $h$. More generally, we have the following
Proposition 3.1. Let $h^{1 / 2-\epsilon} \leq \theta \leq 1, \ell \geq 0$, and let

a \in S_{1,1}^{-\ell}(\theta)+S_{0,1}^{k} \subset \theta^{-\ell} \mathcal{S}_{1 / 2-\epsilon}^{k} .
$$

Then we have

Let $\eta \in C^{\infty}\left(T^{*} \Gamma\right)$ be such that $\eta=1$ for $r_{0} \leq C_{0}, \eta=0$ for $r_{0} \geq 2 C_{0}$, where $C_{0}>0$ does not depend on $h$. Let $\rho$ denote either $\rho_{s}$ or $\rho_{p}$. It is easy to see (e.g. see Lemma 3.1 of [6]) that taking $C_{0}$ big enough we can arrange

C_{1} \theta^{1 / 2} \leq|\rho| \leq C_{2}, \quad \operatorname{Im} \rho \geq C_{3}\left|\theta \||\rho|^{-1} \geq C_{4}\right| \theta \mid
$$

for $\left(x^{\prime}, \xi^{\prime}\right) \in \operatorname{supp} \eta$, and

$$
|\rho| \geq \operatorname{Im} \rho \geq C_{5}\left|\xi^{\prime}\right|
$$

for $\left(x^{\prime}, \xi^{\prime}\right) \in \operatorname{supp}(1-\eta)$ with some constants $C_{j}>0$. We will say that a function $a \in C^{\infty}\left(T^{*} \Gamma\right)$ belongs to $S_{\delta_{1}, \delta_{2}}^{k_{1}}\left(\omega_{1}\right)+S_{\delta_{3}, \delta_{4}}^{k_{2}}\left(\omega_{2}\right)$ if $\eta a \in S_{\delta_{1}, \delta_{2}}^{k_{1}}\left(\omega_{1}\right)$ and $(1-\eta) a \in S_{\delta_{3}, \delta_{4}}^{k_{2}}\left(\omega_{2}\right)$. It is shown in Section 3 of [6] (see Lemma 3.2 of [6]) that

as long as $\theta \geq h^{1 / 2-\epsilon}$, uniformly in $\theta$ and $h$, where $\widetilde{k}=0$ if $k \geq 0, \widetilde{k}=-k$ if $k \leq 0$ and $N \gg 1$ is arbitrary.

## 4. A priori estimates

In this section we will prove a priori estimates for the solution to the equation

More precisely, we will prove the following
Theorem 4.1. Let $\theta \geq h$ and $0<h \ll 1$. Let $u \in H^{2}\left(\Omega ; \mathbb{C}^{d}\right)$ satisfy equation 4.1). Then the function $g=\left.h B_{\lambda, \mu} u\right|_{\Gamma}$ satisfies the estimate

Proof. We will first prove the following
Lemma 4.2. We have the estimate

Proof. The analog of the Green formula for the elastic Laplacian applied to the solution $u$ of (4.1) takes the form

E(u)=\lambda \sum_{j=1}^{d}\left|\frac{\partial u_{j}}{\partial x_{j}}\right|^{2}+\frac{\mu}{2} \sum_{1 \leq i, j \leq d}\left|\frac{\partial u_{i}}{\partial x_{j}}+\frac{\partial u_{j}}{\partial x_{i}}\right|^{2} \\
=(\lambda+2 \mu) \sum_{j=1}^{d}\left|\frac{\partial u_{j}}{\partial x_{j}}\right|^{2}+\frac{\mu}{2} \sum_{i \neq j}\left|\frac{\partial u_{i}}{\partial x_{j}}+\frac{\partial u_{j}}{\partial x_{i}}\right|^{2} \\
\quad \geq C_{1} \sum_{1 \leq i, j \leq d}\left|\frac{\partial u_{i}}{\partial x_{j}}+\frac{\partial u_{j}}{\partial x_{i}}\right|^{2}
\end{gathered}
$$

with some constant $C_{1}>0$. On the other hand, since $u=0$ on $\Gamma$, by Korn's inequality we have

\int_{\Omega} \sum_{1 \leq i, j \leq d}\left|\frac{\partial u_{i}}{\partial x_{j}}\right|^{2} \leq C_{2} \int_{\Omega} \sum_{1 \leq i, j \leq d}\left|\frac{\partial u_{i}}{\partial x_{j}}+\frac{\partial u_{j}}{\partial x_{i}}\right|^{2}
$$

with some constant $C_{2}>0$. Combining the above inequalities with (4.4) we obtain the coercive estimate

\end{equation*}

with some constant $C>0$. The Green formula (4.4) also gives the identity

\operatorname{Im}\left(z^{2}\right)\left\|n^{1 / 2} u\right\|_{L^{2}\left(\Omega ; \mathbb{C}^{d}\right)}^{2}=\operatorname{Im}\langle h v, u\rangle_{L^{2}\left(\Omega ; \mathbb{C}^{d}\right)}

which implies

\|u\|_{L^{2}\left(\Omega ; \mathbb{C}^{d}\right)} \lesssim h \theta^{-1}\|v\|_{L^{2}\left(\Omega ; \mathbb{C}^{d}\right)} \tag{4.6}
\end{equation*}
$$

On the other hand, we have

\left\langle-h^{2} \Delta_{\lambda, \mu} u, u\right\rangle_{L^{2}\left(\Omega ; \mathbb{C}^{d}\right)}=\operatorname{Re}\left(z^{2}\right)\langle n u, u\rangle_{L^{2}\left(\Omega ; \mathbb{C}^{d}\right)}-\operatorname{Re}\langle h v, u\rangle_{L^{2}\left(\Omega ; \mathbb{C}^{d}\right)} \\
\lesssim\|u\|_{L^{2}\left(\Omega ; \mathbb{C}^{d}\right)}^{2}+h^{2}\|v\|_{L^{2}\left(\Omega ; \mathbb{C}^{d}\right)}^{2}
\end{gathered}
$$

which combinned with (4.5) leads to the estimate

\int_{\Omega} \sum_{1 \leq i, j \leq d} h^{2}\left|\frac{\partial u_{i}}{\partial x_{j}}\right|^{2} \lesssim\|u\|_{L^{2}\left(\Omega ; \mathbb{C}^{d}\right)}^{2}+h^{2}\|v\|_{L^{2}\left(\Omega ; \mathbb{C}^{d}\right)}^{2} \tag{4.7}
\end{equation*}
$$

Clearly, (4.3) follows from (4.6) and (4.7).
Let $\mathcal{V} \subset \mathbb{R}^{d}$ be a small open domain such that $\mathcal{V}^{0}:=\mathcal{V} \cap \Gamma \neq \emptyset$. Let $\left(x_{1}, x^{\prime}\right) \in \mathcal{V}^{+}:=\mathcal{V} \cap \Omega$, $0<x_{1} \ll 1, x^{\prime}=\left(x_{2}, \ldots, x_{d}\right) \in \mathcal{V}^{0}$, be the local normal geodesic coordinates near the boundary. Recall (e.g. see Section 2 of [8]) that the Euclidean gradient $\nabla$ can be written in the coordinates $x=\left(x_{1}, x^{\prime}\right)$ as

where $\gamma$ is a smooth matrix-valued function such that $\gamma(x) e_{1}=\nu\left(x^{\prime}\right), \gamma(x) e_{k}$ satisfy

Let $\xi=\left(\xi_{1}, \xi^{\prime}\right)$ be the dual variable of $x=\left(x_{1}, x^{\prime}\right)$. Then the symbol of the operator $-i \nabla$ in the coordinates $(x, \xi)$ takes the form $\xi_{1} \nu\left(x^{\prime}\right)+\beta\left(x, \xi^{\prime}\right)$, where

Note that (4.8) implies the identity

Thus we get that the principal symbol of $-\Delta$ is equal to $\xi_{1}^{2}+r\left(x, \xi^{\prime}\right)$, where $r=\langle\beta, \beta\rangle$. Therefore, the principal symbol of the positive Laplace-Beltrami operator on $\Gamma$ is equal to $r_{0}\left(x^{\prime}, \xi^{\prime}\right)=$ $r\left(0, x^{\prime}, \xi^{\prime}\right)=\left\langle\beta_{0}, \beta_{0}\right\rangle$, where $\beta_{0}=\left.\beta\right|_{x_{1}=0}$. Clearly, there exist constants $C_{1}, C_{2}>0$ such that $C_{1}\left|\xi^{\prime}\right|^{2} \leq r_{0} \leq C_{2}\left|\xi^{\prime}\right|^{2}$.

Let $\mathcal{V}_{1} \subset \mathcal{V}$ be a small open domain such that $\mathcal{V}_{1}^{0}:=\mathcal{V}_{1} \cap \Gamma \neq \emptyset$. Choose a function $\psi \in C_{0}^{\infty}(\mathcal{V})$, $0 \leq \psi \leq 1$, such that $\psi=1$ on $\mathcal{V}_{1}$. Then the function $u^{b}:=\psi u$ satisfies the equation

\left(h^{2} \Delta_{\lambda, \mu}+z^{2} n\right) u^{b}=h v^{b} \quad \text { in } \quad \Omega,  \tag{4.10}\\
u^{b}=0 \text { on } \Gamma,
\end{array}\right.
$$

where $v^{b}=\psi v+h\left[\Delta_{\lambda, \mu}, \psi\right] u$ satisfies

$$
\begin{equation*}
\left\|v^{b}\right\|_{L^{2}\left(\Omega ; \mathbb{C}^{d}\right)} \lesssim\|v\|_{L^{2}\left(\Omega ; \mathbb{C}^{d}\right)}+\|u\|_{H_{h}^{1}\left(\Omega ; \mathbb{C}^{d}\right)} \tag{4.11}
\end{equation*}
$$

We will now write the elastic Laplacian in the coordinates $x=\left(x_{1}, x^{\prime}\right)$. To this end, we will write the principal symbol of $-\Delta_{\lambda, \mu}$ in the coordinates $(x, \xi)$. We have

& =\xi_{1}^{2} Q_{0}(x)+\xi_{1} Q_{1}\left(x, \xi^{\prime}\right)+Q_{2}\left(x, \xi^{\prime}\right),
\end{aligned}
$$

where

\begin{gathered}
Q_{0}=c_{s} \Pi_{s}\left(e_{1}\right)+c_{\mu} \Pi_{p}\left(e_{1}\right), \\
Q_{1}=(\lambda+\mu) \gamma\left(e_{1} \otimes \xi^{\prime}+\xi^{\prime} \otimes e_{1}\right) \gamma^{t}, \\
Q_{2}=\mu r\left(x, \xi^{\prime}\right) I_{d}+(\lambda+\mu) \gamma\left(\xi^{\prime} \otimes \xi^{\prime}\right) \gamma^{t}
\end{gathered}
$$

are symmetric matrices. Denote $\mathcal{D}_{x_{j}}=-i h \partial_{x_{j}}$. We can write

-h^{2} \Delta_{\lambda, \mu}=Q_{0}(x) \mathcal{D}_{x_{1}}^{2}+\mathcal{Q}_{1} \mathcal{D}_{x_{1}}+\mathcal{Q}_{2}+h \mathcal{R}\left(x, \mathcal{D}_{x}\right) \tag{4.12}
\end{equation*}
$$

where $\mathcal{R}$ is a first-order matrix-valued differential operator, and

\mathcal{Q}_{j}=\frac{1}{2}\left(Q_{j}\left(x, \mathcal{D}_{x^{\prime}}\right)+Q_{j}\left(x, \mathcal{D}_{x^{\prime}}\right)^{*}\right)=Q_{j}\left(x, \mathcal{D}_{x^{\prime}}\right)+h \mathcal{R}_{j-1}\left(x, \mathcal{D}_{x^{\prime}}\right), \quad j=1,2,
$$

are self-adjoint operators on $L^{2}\left(\Gamma ; \mathbb{C}^{d}\right)$. Here $Q^{*}$ denotes the adjoint of $Q$ with respect to the scalar product, $\langle\cdot, \cdot\rangle_{0}$, in $L^{2}\left(\Gamma ; \mathbb{C}^{d}\right)$, and $\mathcal{R}_{j-1}$ is a $j-1$-order matrix-valued differential operator. Introduce the function

with some constant $C>0$, where $\|\cdot\|_{0}$ denotes the norm in $L^{2}\left(\Gamma ; \mathbb{C}^{d}\right)$. On the other hand,

for some constant $\delta>0$, where $F^{\prime}$ denotes the first derivative with respect to $x_{1}$. We will now use (4.14) to bound $F(0)$ from above. To this end we will compute $F^{\prime}\left(x_{1}\right)$ using that $u^{b}$ satisfies (4.10) together with (4.12). We have

=2 h^{-1} \operatorname{Im}\left\langle\left(h^{2} \Delta_{\lambda, \mu}+\operatorname{Re}\left(z^{2}\right) n\right) u^{b}, \mathcal{D}_{x_{1}} u^{b}\right\rangle_{0}+2 h^{-1} \operatorname{Im}\left\langle\left(Q_{1} \mathcal{D}_{x_{1}}+h \mathcal{R}\right) u^{b}, \mathcal{D}_{x_{1}} u^{b}\right\rangle_{0} \\
+\left\langle Q_{0}^{\prime} \mathcal{D}_{x_{1}} u^{b}, \mathcal{D}_{x_{1}} u^{b}\right\rangle_{0}-\left\langle\left(\mathcal{Q}_{2}^{\prime}-\operatorname{Re}\left(z^{2}\right) n^{\prime}\right) u^{b}, u^{b}\right\rangle_{0} \\
=2 \operatorname{Im}\left\langle\left(v^{b}-i h^{-1} \operatorname{Im}\left(z^{2}\right) n u^{b}\right), \mathcal{D}_{x_{1}} u^{b}\right\rangle_{0}+2 \operatorname{Im}\left\langle\mathcal{R} u^{b}, \mathcal{D}_{x_{1}} u^{b}\right\rangle_{0} \\
+\left\langle Q_{0}^{\prime} \mathcal{D}_{x_{1}} u^{b}, \mathcal{D}_{x_{1}} u^{b}\right\rangle_{0}-\left\langle\left(\mathcal{Q}_{2}^{\prime}-\operatorname{Re}\left(z^{2}\right) n^{\prime}\right) u^{b}, u^{b}\right\rangle_{0}
\end{gathered}

Since $\Gamma$ is compact, there exist a finite number of smooth functions $\psi_{i}, 0 \leq \psi_{i} \leq 1, i=1, \ldots, I$, such that $1=\sum_{i=1}^{I} \psi_{i}$ and (4.16) holds with $\psi_{0}$ replaced by each $\psi_{i}$. Therefore, the estimate (4.2) is obtained by summing up all such estimates (4.16).

## 5. Parametrix construction

We keep the notations from the previous sections and will suppose that $\theta \geq h^{2 / 5-\epsilon}, 0<\epsilon \ll 1$. It suffices to build the parametrix locally since the global parametrix can be obtained by using a suitable partition of the unity and summing up the corresponding local parametrices. Let the function $\phi_{0} \in C_{0}^{\infty}(\mathbb{R})$ be such that $\phi_{0}(\sigma)=1$ for $|\sigma| \leq 1, \phi_{0}(\sigma)=0$ for $|\sigma| \geq 2$. Let $\left(x_{1}, x^{\prime}\right) \in \mathcal{V}^{+}$ be the local normal geodesic coordinates near the boundary. Take a function $\chi \in C^{\infty}\left(T^{*} \Gamma\right)$, $0 \leq \chi \leq 1$, such that $\pi_{x^{\prime}}(\operatorname{supp} \chi) \subset \mathcal{V}^{0}$, where $\pi_{x^{\prime}}: T^{*} \Gamma \rightarrow \Gamma$ denotes the projection $\left(x^{\prime}, \xi^{\prime}\right) \rightarrow x^{\prime}$. Moreover, we require that either $\chi$ is of compact support or $\chi \in S_{0,1}^{0}$ with $\operatorname{supp} \chi \subset \operatorname{supp}(1-\eta)$. When $\chi$ is of compact support we require that supp $\chi$ has common points with at most one glancing region. Let $f \in H^{3}\left(\Gamma ; \mathbb{C}^{d}\right)$. We will be looking for a parametrix of the solution to equation (1.1) in the form

&+(2 \pi h)^{-d+1} \iint e^{\frac{i}{h}\left(\left\langle y^{\prime}, \xi^{\prime}\right\rangle+\varphi_{p}\left(x, \xi^{\prime}, z\right)\right)} \Psi\left(x, \xi^{\prime}\right) A_{p}\left(x, \xi^{\prime}, z\right) \chi\left(x^{\prime}, \xi^{\prime}\right) f\left(y^{\prime}\right) d \xi^{\prime} d y^{\prime}
\end{aligned}

where

$0<\delta \ll 1$ being a parameter independent of $h$ and $\theta$ to be fixed in Lemma 5.1. We require that $\widetilde{u}$ satisfies the boundary condition $\widetilde{u}=\mathrm{Op}_{h}(\chi) f$ on $x_{1}=0$. The phase functions are of the form

$N \gg 1$ being an arbitrary integer, and satisfy the eikonal equations $\bmod \mathcal{O}\left(x_{1}^{N}\right)$ :

where $\Phi_{s}, \Phi_{p}$ are smooth functions up to the boundary $x_{1}=0$. One can solve the eikonal equations above in the same way as in [6. The functions $\varphi_{s, k}, \varphi_{p, k}, k \geq 2$, are determined uniquely, independent of $x_{1}$, and have the following properties (see Section 4 of [6]).

Lemma 5.1. For $0 \leq x_{1} \leq 2 \delta \min \left\{1,\left|\rho_{s}\right|^{3}\right\}$ with $\delta>0$ small enough, we have

Set $\widetilde{\varphi}_{s}=\varphi_{s}-\varphi_{s, 0}, \widetilde{\varphi}_{p}=\varphi_{p}-\varphi_{p, 0}$. The next lemma is proved in Section 4 of [8].

for $0 \leq x_{1} \leq 2 \delta \min \left\{1,\left|\rho_{s}\right|^{3}\right\}$ and all multi-indices $\alpha$ and $\beta$ with constants $C_{\alpha, \beta}>0$ independent of $x_{1}, \theta, z$ and $h$. Similar bounds hold for $\widetilde{\varphi}_{p}$ as well.

The amplitudes $A_{s}$ and $A_{p}$ are matrix-valued functions which will be chosen so that on supp $\chi$ we have

If $\mathcal{V}^{0}$ is small enough, there exists a matrix-valued function $\Lambda\left(x^{\prime}\right) \in C^{\infty}\left(\mathcal{V}^{0}\right)$ such that $\Lambda\left(x^{\prime}\right) \nu\left(x^{\prime}\right)=$ $e_{1}$ and $\Lambda^{t}=\Lambda^{-1}$ in $\mathcal{V}^{0}$. Set

where $U_{0}$ is the matrix introduced in Section 2. It follows from (2.2) that $U(\xi)$ is invertible if $\langle\xi, \nu\rangle \neq 0$. Clearly, $U(\nu)=I_{d}$. Moreover, by Lemma 2.1 we have $U(\xi) \xi=\xi^{2} \nu$. Therefore,

A_{p}=U^{-1}\left(\gamma \nabla_{x} \varphi_{p}\right) Z\left(\gamma \nabla_{x} \varphi_{p}\right) \Pi_{p}(\nu) T=U^{-1}\left(\gamma \nabla_{x} \varphi_{p}\right) \Pi_{p}(\nu) Z\left(\gamma \nabla_{x} \varphi_{p}\right) T \\
=\left(\gamma \nabla_{x} \varphi_{p}\right)^{-4} \Pi_{p}\left(\gamma \nabla_{x} \varphi_{p}\right) Z\left(\gamma \nabla_{x} \varphi_{p}\right) T,
\end{gathered}

which imply (5.8). We will now find the matrix $T$ so that $W T=I_{d}$ with

On the other hand, there is a constant $C_{2}>0$ such that $\operatorname{Im} \rho_{s} \geq$ $C_{2} \sqrt{r_{0}+1}$ on $\operatorname{supp}(1-\eta), \operatorname{Im} \rho_{s} \geq C_{2} \theta$ on supp $\eta$, and similarly for $\rho_{p}$ (see Section 3). Therefore, (5.13) follows from (5.16) when either $\left(x^{\prime}, \xi^{\prime}\right) \in \operatorname{supp}(1-\eta)$ or $\left(x^{\prime}, \xi^{\prime}\right) \in \operatorname{supp} \eta$ and $\theta \geq \theta_{0}>0$. Thus, it remains to prove (5.13) when $\left(x^{\prime}, \xi^{\prime}\right) \in \operatorname{supp} \eta$ and $\theta \ll 1$. In this case we have that $\left|\rho_{s}\right|$ and $\left|\rho_{p}\right|$ are uniformly bounded from above by a constant and $z^{2}=1+\mathcal{O}(\theta)$. We will make use of the identity

\left\|\mathcal{N}(z, h) \mathrm{Op}_{h}(\chi) f+\left.i h B_{\lambda, \mu} \widetilde{\mu}\right|_{x_{1}=0}\right\|_{L^{2}\left(\Gamma ; \mathbb{C}^{d}\right)} \lesssim h^{1 / 2} \theta^{-1 / 2}\|\widetilde{v}\|_{L^{2}\left(\Omega ; \mathbb{C}^{d}\right)} . \tag{5.27}
\end{equation*}
$$

Theorem 1.1 follows from (5.27) together with Lemma 5.5 and the following
Lemma 5.6. For $N$ big enough depending on $\epsilon$ and $\varepsilon$ we have the estimates

$$
\begin{gather*}
\left\|\mathrm{Op}_{h}(\chi q) f\right\|_{L^{2}\left(\Gamma ; \mathbb{C}^{d}\right)} \lesssim \theta^{-1 / 2-\ell}\|f\|_{H_{h}^{2}\left(\Gamma ; \mathbb{C}^{d}\right)},  \tag{5.28}\\
\|\widetilde{v}\|_{L^{2}\left(\Omega ; \mathbb{C}^{d}\right)} \lesssim h^{1 / 2} \theta^{-3 / 2-\ell}\|f\|_{H_{h}^{3}\left(\Gamma ; \mathbb{C}^{d}\right)} . \tag{5.29}
\end{gather*}
$$

Indeed, we have

$$
\begin{equation*}
\left\|\mathcal{N}(z, h) \mathrm{Op}_{h}(\chi) f-\operatorname{Op}_{h}\left(\chi m_{d}\right) f\right\|_{L^{2}\left(\Gamma ; \mathbb{C}^{d}\right)} \lesssim h \theta^{-2-\ell}\|f\|_{H_{h}^{3}\left(\Gamma ; \mathbb{C}^{d}\right)} . \tag{5.30}
\end{equation*}
$$

We can now take a partition of the unity $\chi_{j}, j=1, \ldots, J, 0 \leq \chi_{j} \leq 1, \sum_{j=1}^{J} \chi_{j}=1$, such that (5.30) holds with $\chi$ replaced by each $\chi_{j}$. Moreover, to each $\chi_{j}$ we can associate a smooth
matrix-valued function $\Lambda_{j}\left(x^{\prime}\right)$ such that $\Lambda_{j}\left(x^{\prime}\right) \nu\left(x^{\prime}\right)=e_{1}$ and $\Lambda_{j}^{-1}\left(x^{\prime}\right)=\Lambda_{j}^{t}\left(x^{\prime}\right)$ in $\pi_{x^{\prime}}\left(\operatorname{supp} \chi_{j}\right)$. Thus, summing up all estimates (5.30) leads to (1.4) with

$$
m_{d}=\sum_{j=1}^{J} \chi_{j} m_{d}=\sum_{j=1}^{J} \sum_{k=1}^{K} \chi_{j} \phi_{k, j} \mathcal{J}_{k, j} M_{d} \mathcal{J}_{k, j}^{-1}
$$

where

$$
\begin{gathered}
\phi_{k, j}\left(x^{\prime}, \xi^{\prime}\right)=\phi_{k}\left(-\Lambda_{j}\left(x^{\prime}\right) \beta_{0}\left(x^{\prime}, \xi^{\prime}\right) / \sqrt{r_{0}\left(x^{\prime}, \xi^{\prime}\right)}\right), \\
\mathcal{J}_{k, j}\left(x^{\prime}, \xi^{\prime}\right)=\Lambda_{j}\left(x^{\prime}\right)^{-1} \Theta_{k}\left(-\Lambda_{j}\left(x^{\prime}\right) \beta_{0}\left(x^{\prime}, \xi^{\prime}\right)\right) .
\end{gathered}
$$

## 6. Proof of Lemma 5.6

In view of (3.2), we have

$$
\nabla_{x^{\prime}} \rho_{s} \in S_{2,2}^{-1}\left(\left|\rho_{s}\right|\right)+S_{0,1}^{1} \subset S_{1,1}^{-1 / 2}(\theta)+S_{0,1}^{1}
$$

and similarly for $\rho_{p}$. Therefore, we have

$$
U^{t}\left(\gamma \widetilde{\nabla}_{x^{\prime}}\left(\rho_{p}-\rho_{s}\right)\right) \in S_{1,1}^{-1 / 2}(\theta)+S_{0,1}^{1}
$$

which together with (5.11) yield

$$
\begin{equation*}
\chi q \in S_{1,1}^{-1 / 2-\ell}(\theta)+S_{0,1}^{2} . \tag{6.1}
\end{equation*}
$$

Now (5.28) follows from (6.1) and Proposition 3.1. Furthermore, it is easy to see that (5.29) is a consequence of the following

Lemma 6.1. For $N$ big enough depending on $\epsilon$ and $\varepsilon$ we have the estimate

$$
\begin{equation*}
\left\|\operatorname{Op}_{h}\left(e^{i \widetilde{\varphi}_{s} / h} B_{s}\right)\right\|_{H_{h}^{3}\left(\Gamma ; \mathbb{C}^{d}\right) \rightarrow L^{2}\left(\Gamma ; \mathbb{C}^{d}\right)} \lesssim h+\theta^{-1-\ell} e^{-C x_{1} \theta / h} \tag{6.2}
\end{equation*}
$$

and similarly for $e^{i \widetilde{\varphi}_{p} / h} B_{p}$, where $C>0$ is the same constant as in Lemma 5.2.
Indeed, we have

$$
\begin{gathered}
\|\widetilde{v}\|_{L^{2}\left(\Omega ; \mathbb{C}^{d}\right)}^{2} \lesssim h^{2}\|f\|_{H_{h}^{3}\left(\Gamma ; \mathbb{C}^{d}\right)}^{2}+\theta^{-2-2 \ell}\|f\|_{H_{h}^{3}\left(\Gamma ; \mathbb{C}^{d}\right)}^{2} \int_{0}^{\infty} e^{-2 C x_{1} \theta / h} d x_{1} \\
\lesssim h \theta^{-3-2 \ell}\|f\|_{H_{h}^{3}\left(\Gamma ; \mathbb{C}^{d}\right)}^{2} .
\end{gathered}
$$

Proof of Lemma 6.1. Observe first that by (3.2) we have

$$
\begin{equation*}
\phi_{0}\left(x_{1} /\left|\rho_{s}\right|^{3} \delta\right) \phi_{0}\left(x_{1}\left\langle\xi^{\prime}\right\rangle^{\varepsilon} / \delta\right) \in S_{2,2}^{0}\left(\left|\rho_{s}\right|\right)+S_{0,1}^{0} \subset S_{1,1}^{0}(\theta)+S_{0,1}^{0} \tag{6.3}
\end{equation*}
$$

uniformly in $x_{1}$, and similarly with $\left|\rho_{s}\right|$ replaced by $\left|\rho_{p}\right|$. In view of the choice of the function $\chi$, it is easy to see that (6.3) implies

$$
\begin{equation*}
\chi \Psi \in S_{1,1}^{0}(\theta)+S_{0,1}^{0} \tag{6.4}
\end{equation*}
$$

uniformly in $x_{1}$. On the other hand, by Lemma 5.2,

$$
\begin{equation*}
e^{C x_{1} \theta / h} e^{i \widetilde{\varphi}_{s} / h} \in S_{1,1}^{0}(\theta)+S_{0,1}^{0} \tag{6.5}
\end{equation*}
$$

on supp $\Psi$, uniformly in $x_{1}$, and similarly with $\widetilde{\varphi}_{s}$ replaced by $\widetilde{\varphi}_{p}$. By (6.4) and (6.5),

$$
\begin{equation*}
e^{C x_{1} \theta / h} e^{i \widetilde{\varphi}_{s} / h} \chi \Psi \in S_{1,1}^{0}(\theta)+S_{0,1}^{0} \tag{6.6}
\end{equation*}
$$

uniformly in $x_{1}$. Furthermore, it is easy to see that Lemma 5.1 yields

$$
\begin{gather*}
\partial_{x^{\prime}}^{\alpha} \varphi_{s} \in S_{2,2}^{0}\left(\left|\rho_{s}\right|\right)+S_{0,1}^{1} \subset S_{1,1}^{0}(\theta)+S_{0,1}^{1}, \quad 1 \leq|\alpha| \leq 2,  \tag{6.7}\\
\partial_{x_{1}}^{k} \varphi_{s} \in S_{2,2}^{4-3 k}\left(\left|\rho_{s}\right|\right)+S_{0,1}^{1} \subset \begin{cases}S_{1,1}^{0}(\theta)+S_{0,1}^{1} & \text { if } \quad k=1, \\
S_{1,1}^{2-3 k / 2}(\theta)+S_{0,1}^{1} & \text { if } \quad k \geq 2,\end{cases} \tag{6.8}
\end{gather*}
$$

on $\operatorname{supp} \Psi$, uniformly in $x_{1}$, and similarly with $\varphi_{s}$ replaced by $\varphi_{p}$. By (6.8),

$$
\partial_{x_{1}}^{k} U^{t}\left(\gamma \nabla_{x} \varphi_{s}\right), \partial_{x_{1}}^{k} U^{t}\left(\gamma \nabla_{x} \varphi_{p}\right) \in\left\{\begin{array}{l}
S_{1,1}^{0}(\theta)+S_{0,1}^{1} \quad \text { if } \quad k=0,  \tag{6.9}\\
S_{1,1}^{(1-3 k) / 2}(\theta)+S_{0,1}^{1} \quad \text { if } \quad k \geq 1,
\end{array}\right.
$$

on $\operatorname{supp} \Psi$, uniformly in $x_{1}$. By (6.9) and (5.11),

$$
\partial_{x_{1}}^{k} A_{s}, \partial_{x_{1}}^{k} A_{p} \in\left\{\begin{array}{l}
S_{1,1}^{-\ell}(\theta)+S_{0,1}^{2} \quad \text { if } \quad k=0  \tag{6.10}\\
S_{1,1}^{-\ell+(1-3 k) / 2}(\theta)+S_{0,1}^{2} \quad \text { if } \quad k \geq 1,
\end{array}\right.
$$

on $\operatorname{supp} \Psi$, uniformly in $x_{1}$. It is easy to see that (6.4), (6.8) and (6.10) imply

$$
\begin{gather*}
\Psi L\left(\varphi_{s}, A_{s}\right), \Psi L\left(\varphi_{p}, A_{p}\right) \in S_{1,1}^{-1-\ell}(\theta)+S_{0,1}^{3},  \tag{6.11}\\
\Psi G\left(A_{s}\right), \Psi G\left(A_{p}\right) \in S_{1,1}^{-5 / 2-\ell}(\theta)+S_{0,1}^{2} . \tag{6.12}
\end{gather*}
$$

By (6.6), (6.11) and (6.12) we conclude

$$
\begin{equation*}
e^{C x_{1} \theta / h} e^{i \widetilde{\varphi}_{s} / h} \Psi\left(L\left(\varphi_{s}, A_{s}\right)+h G\left(A_{s}\right)\right) \in S_{1,1}^{-1-\ell}(\theta)+S_{0,1}^{3} \tag{6.13}
\end{equation*}
$$

as long as $\theta \geq h^{2 / 5-\epsilon}$. Thus, by (6.13) and Proposition 3.1 we obtain

$$
\begin{equation*}
\left\|\operatorname{Op}_{h}\left(e^{i \widetilde{\varphi}_{s} / h} \Psi\left(L\left(\varphi_{s}, A_{s}\right)+h G\left(A_{s}\right)\right)\right)\right\|_{H_{h}^{3}\left(\Gamma ; \mathbb{C}^{d}\right) \rightarrow L^{2}\left(\Gamma ; \mathbb{C}^{d}\right)} \lesssim \theta^{-1-\ell} e^{-C x_{1} \theta / h} . \tag{6.14}
\end{equation*}
$$

Furthermore, since

$$
x_{1}^{N} e^{-C x_{1} \theta / h} \lesssim h^{N} \theta^{-N}, \quad x_{1}^{N} e^{-C x_{1}\left|\xi^{\prime}\right| / h} \lesssim h^{N}\left|\xi^{\prime}\right|^{-N}
$$

we deduce from Lemma 5.2 that

$$
\begin{equation*}
h^{-N} x_{1}^{N} e^{i \widetilde{\varphi}_{s} / h} \in S_{1,1}^{-N}(\theta)+S_{0,1}^{-N} \tag{6.15}
\end{equation*}
$$

uniformly in $x_{1}$ and $h$. By (6.15) and (5.3),

$$
\begin{equation*}
h^{-N} x_{1}^{N} e^{i \widetilde{\varphi}_{s} / h} \Phi_{s} \in S_{1,1}^{1-5 N / 2}(\theta)+S_{0,1}^{2-N} \tag{6.16}
\end{equation*}
$$

on supp $\Psi$, uniformly in $x_{1}$ and $h$. On the other hand, it follows from (6.7) and (6.8) that

$$
\begin{equation*}
\Pi_{s}\left(\gamma \nabla_{x} \varphi_{s}\right) \in S_{1,1}^{0}(\theta)+S_{0,1}^{2} \tag{6.17}
\end{equation*}
$$

on supp $\Psi$. Taking $N$ big enough, depending on $\varepsilon$, and $\delta$ small enough, we can arrange

$$
\left|z^{2} n+x_{1}^{N} \Phi_{s}\right| \geq C-x_{1}^{N}\left|\Phi_{s}\right| \geq C-\mathcal{O}(\delta) \geq C / 2
$$

on supp $\Psi$, with some constant $C>0$. Therefore, using the eikonal equation (5.1) we can write

$$
\left(\gamma \nabla_{x} \varphi_{s}\right)^{-2}=c_{s}\left(z^{2} n+x_{1}^{N} \Phi_{s}\right)^{-1} .
$$

In view of (5.3) we have

$$
z^{2} n+x_{1}^{N} \Phi_{s} \in S_{1,1}^{0}(\theta)+S_{0,1}^{0}
$$

on supp $\Psi$. Thus we obtain

$$
\begin{equation*}
\left(\gamma \nabla_{x} \varphi_{s}\right)^{-2} \in S_{1,1}^{0}(\theta)+S_{0,1}^{0} \tag{6.18}
\end{equation*}
$$

on $\operatorname{supp} \Psi$. By (6.10), (6.16), (6.17) and (6.18) we conclude

$$
\begin{equation*}
h^{-N} x_{1}^{N} e^{i \widetilde{\varphi}_{s} / h} \Phi_{s} \Psi\left(\gamma \nabla_{x} \varphi_{s}\right)^{-2} \Pi_{s}\left(\gamma \nabla_{x} \varphi_{s}\right) \chi A_{s} \in S_{1,1}^{-5 N / 2}(\theta)+S_{0,1}^{0} \tag{6.19}
\end{equation*}
$$

provided $N \geq 6$. It follows from (6.19) and Proposition 3.1 that

$$
\begin{gather*}
\left\|\operatorname{Op}_{h}\left(h^{-1} x_{1}^{N} e^{i \widetilde{\varphi}_{s} / h} \Phi_{s} \Psi\left(\gamma \nabla_{x} \varphi_{s}\right)^{-2} \Pi_{s}\left(\gamma \nabla_{x} \varphi_{s}\right) \chi A_{s}\right)\right\|_{L^{2}\left(\Gamma ; \mathbb{C}^{d}\right) \rightarrow L^{2}\left(\Gamma ; \mathbb{C}^{d}\right)} \\
\lesssim h^{N-1} \theta^{-5 N / 2} \lesssim h^{5 \epsilon N / 2-1} \lesssim h \tag{6.20}
\end{gather*}
$$

as long as $\theta \geq h^{2 / 5-\epsilon}$ and $N \geq 4 / 5 \epsilon$. Let $\chi$ be of compact support and suppose that supp $\chi \cap \Sigma_{s} \neq$ $\emptyset$, supp $\chi \cap \Sigma_{p}=\emptyset$. Then $\left[\Delta_{\lambda, \mu}, \Psi\right] \chi=0$ for $x_{1} \leq \delta_{1}\left|\rho_{s}\right|^{3}$ for some constant $\delta_{1}>0$. Therefore, on $\operatorname{supp}\left[\Delta_{\lambda, \mu}, \Psi\right] \chi$ we have the bounds

$$
e^{-C x_{1} \theta / h} \leq e^{-C \delta_{1}\left|\rho_{s}\right|^{3} \theta / h} \leq e^{-\widetilde{C} \theta^{5 / 2} / h} \lesssim h^{N} \theta^{-5 N / 2}
$$

Clearly, we have similar bounds when supp $\chi \cap \Sigma_{p} \neq \emptyset$, supp $\chi \cap \Sigma_{s}=\emptyset$. When supp $\chi \cap \Sigma_{s}=\emptyset$, $\operatorname{supp} \chi \cap \Sigma_{p}=\emptyset$, then $\left[\Delta_{\lambda, \mu}, \Psi\right] \chi=0$ for $x_{1} \leq \delta_{2}$ for some constant $\delta_{2}>0$. So, in this case the above bounds still hold. Let now $\chi \in S_{0,1}^{0}$ be such that $\operatorname{supp} \chi \subset \operatorname{supp}(1-\eta)$. Then $\left[\Delta_{\lambda, \mu}, \Psi\right] \chi=0$ for $x_{1} \leq \delta_{3}\left\langle\xi^{\prime}\right\rangle^{-\varepsilon}$ for some constant $\delta_{3}>0$. Hence, on $\operatorname{supp}\left[\Delta_{\lambda, \mu}, \Psi\right] \chi$ we have the bounds

$$
e^{-C x_{1}\left|\xi^{\prime}\right| / h} \leq e^{-\widetilde{C}\left|\xi^{\prime}\right|^{1-\varepsilon} / h} \lesssim h^{N}\left|\xi^{\prime}\right|^{-N(1-\varepsilon)} .
$$

Therefore, by Lemma 5.2 and (6.10) we get

$$
\begin{equation*}
h^{-N} e^{i \widetilde{\varphi}_{s} / h}\left[\Delta_{\lambda, \mu}, \Psi\right] \chi A_{s} \in S_{1,1}^{-\ell-1-5 N / 2}(\theta)+S_{0,1}^{0} \tag{6.21}
\end{equation*}
$$

for $N$ big enough. It follows from (6.21) and Proposition 3.1 that

$$
\begin{align*}
& \left\|\operatorname{Op}_{h}\left(h e^{i \widetilde{\varphi}_{s} / h}\left[\Delta_{\lambda, \mu}, \Psi\right] \chi A_{s}\right)\right\|_{L^{2}\left(\Gamma ; \mathbb{C}^{d}\right) \rightarrow L^{2}\left(\Gamma ; \mathbb{C}^{d}\right)} \\
& \lesssim h^{N+1} \theta^{-\ell-1-5 N / 2} \lesssim h^{5 \epsilon N / 2+1-(\ell+1)(2 / 5-\epsilon)} \lesssim h \tag{6.22}
\end{align*}
$$

as long as $\theta \geq h^{2 / 5-\epsilon}$ and $N$ big enough. Now the estimate (6.2) follows from (6.14), (6) and (6).
