THE DIRICHLET PROBLEM FOR MIXED HESSIAN EQUATIONS ON HERMITIAN MANIFOLDS

ABSTRACT. In this paper we study the Dirichlet problem for a class of Hessian type equation with its structure as a combination of elementary symmetric functions on Hermitian manifolds. Under some conditions with the initial data on manifolds and admissible subsolutions, we derive a priori estimates for this complex mixed Hessian equation and solvability of the corresponding Dirichlet problem.

1. INTRODUCTION

Let (M, ω) be a closed Hermitian manifold of complex dimension $n \geq 2$ with smooth boundary ∂M and $\overline{M} = M \cup \partial M$, fix a real smooth closed (1,1)-form χ_0 on M. For any C^2 function $u: M \to \mathbb{R}$, we can obtain a new real (1,1)-form

$$\chi_u = \chi_0 + \frac{\sqrt{-1}}{2} \partial \overline{\partial} u.$$

We consider the following Dirichlet problem of Hessian type equation on (M, ω)

(1.1)
$$\begin{cases} \chi_u^k \wedge \omega^{n-k} = \sum_{l=0}^{k-1} \alpha_l(z) \chi_u^l \wedge \omega^{n-l}, & in \ M, \\ u = \varphi & on \ \partial M, \end{cases}$$

where $1 < k \leq n$, $\alpha_l(z)$ and φ are real smooth functions on M and ∂M , respectively. Note that this is a class of fully nonlinear equation with its structure as a combination of elementary symmetric functions on Hermitian manifolds. In order to keep the ellipticity of equation (1.1), we require the eigenvalues of (1, 1)-form χ_u with respect to ω belong to the Gårding's cone Γ_{k-1} . Hence we introduce the following definition.

Definition 1.1. A function $u \in C^2(M)$ is called k-admissible if $\chi_u \in \Gamma_k(M)$ for any $z \in M$, where $\Gamma_k(M)$ is the Gårding cone

$$\Gamma_k(M) = \{ \chi \in \mathcal{A}^{1,1}(M) : \sigma_i(\lambda[\chi]) > 0, \ \forall \ 1 \le i \le k \}.$$

The equation in (1.1)

(1.2)
$$\chi_u^k \wedge \omega^{n-k} = \sum_{l=0}^{k-1} \alpha_l(z) \chi_u^l \wedge \omega^{n-l}$$

includes some of the most partial differential equations in complex geometry and analysis. When k = n and $\alpha_1 = \cdots = \alpha_{n-1} = 0$, the equation becomes the complex Monge-Ampère equation $\chi_u^n = \alpha_0 \omega^n$, which was solved by Yau [41] on closed Kähler manifolds in the resolution of the Calabi conjecture. Then Tosatti-Weinkove [40, 39] have solved the analogous problem for the equation on closed Hermitian manifolds. The corresponding Dirichlet problems on manifolds were studied by Cherrier-Hanani [9] and Guan-Li [16, 17, 18].

In fact, the Hessian equation $\chi_u^k \wedge \omega^{n-k} = \alpha_0 \omega^n$ and the Hessian quotient equation $\chi_u^k \wedge \omega^{n-k} = \alpha_l(z)\chi_u^l \wedge \omega^{n-l}$ are also the special case of (1.2). For equation $\chi_u^k \wedge \omega^{n-k} = \alpha_0 \omega^n$, Hou-Ma-Wu [22] established the second order estimates for the equation without boundary on Kähler manifold, and then Dinew-Kolodziej [12] solved the equation by combining the Liouville theorem and Hou-Ma-Wu's results. Zhang [42] and Székelyhidi [30] have solved the equation without boundary on Hermitian manifolds. The corresponding Dirichlet problem on manifolds has also attracted the interest of many researchers, such as Gu-Nguyen [15] were able to obtain continuous solutions to the equation with boundary on Hermitian manifolds, and Collins-Picard [11] solved the problem under the existence of a subsolution. For (k, l)-Hessian quotient equation $\chi_u^k \wedge \omega^{n-k} = \alpha_l(z)\chi_u^l \wedge \omega^{n-l}$, the (n, n-1)-Hessian quotient equation have appeared in a problem proposed by Donaldson in the setting of moment maps and was solved by Song-Weinkove [32]. Then (n, l)-Hessian quotient equation was considered by Fang-Lai-Ma [13] on Kähler manifold, and by Guan-Li [17], Guan-Sun [20] on Hermitian manifolds. The general (k, l)-Hessian quotient equation with k < n without boundary on Hermitian manifolds was studied by Székelyhidi [30] for constants α_l and by Sun [34] for functions α_l . The corresponding Dirichlet problem on Hermitian manifolds was studied by Feng-Ge-Zheng [14], since they can only obtain the gradient estimates in some special cases, the existence of solution can be solved in these kinds of special cases.

When k = n and $\alpha_l \in \mathbb{R}$, equation (1.2) was raised as a conjecture by Chen [8] in the study of Mabuchi energy. The conjecture was solved by Collins-Székelyhidi [10] for some special constant α_l . Later, Phong-Tô [29] generalized Collins-Székelyhidi's result for nonnegative constants α_l . Moreover, a generalized equation of Chen's problem was studied by Sun [35, 36] and Pingali [26, 27, 28]. The initial motivation of our work is the following: As an important example for the applications of the general notion of fully nonlinear elliptic equations, Krylov [24] studied the Dirichlet problem of the equation

(1.3)
$$\sigma_k(D^2u) = \sum_{l=0}^{k-1} \alpha_l(x)\sigma_l(D^2u)$$

in a (k-1)-convex domain in \mathbb{R}^n with $\alpha_l > 0$ ($0 \le l \le k-1$). Recently, Guan-Zhang [21] observed that equation (1.3) can be rewritten as the following equation

(1.4)
$$\frac{\sigma_k}{\sigma_{k-1}}(D^2u) - \sum_{l=0}^{k-2} \alpha_l(x) \frac{\sigma_l}{\sigma_{k-1}}(D^2u) = -\alpha_{k-1}.$$

Actually, the equation is elliptic and concave in Γ_{k-1} . Then they obtained a priori C^2 estimate of the (k-1)-admissible solution of equation (1.4) without sign requirement for α_{k-1} and solved the Dirichlet problem for the corresponding equation. Later the corresponding Neumann problem and prescribed curvature equations were also discussed in [4, 5, 45, 7]. Recently, Zhang [43] cosidered the Dirichlet problem for (1.3) on complex domains in \mathbb{C}^n , which can be seen as the extension of Guan-Zhang's result. Chen [6] and Zhou [44] provide a sufficient and necessary condition for the solvability of the mixed hessian equation on Kähler manifold without boundary. A natural problem is raised whether we can consider the Dirichlet problem for equation (1.3) on complex manifolds. The following is our main result.

Theorem 1.1. Let (M, ω) be a closed Hermitian manifold of complex dimension $n \geq 2$, $\chi_0 \in \Gamma_{k-1}(M)$ be a (1, 1)-form, $\alpha_{k-1}(z), \varphi(z), \alpha_l$ be smooth functions and $\alpha_l(z) > 0$ for $l = 0, 1, \dots, k-2$. Suppose there exists an (k-1)-admissible subsolution $\underline{u} \in C^2(\overline{M})$ such that

(1.5)
$$\begin{cases} \chi_{\underline{u}}^{k} \wedge \omega^{n-k} \geq \sum_{l=0}^{k-1} \alpha_{l}(z) \chi_{\underline{u}}^{l} \wedge \omega^{n-l}, & in \ M, \\ \underline{u} = \varphi & on \ \partial M \end{cases}$$

Then there exists a unique (k-1)-admissible solution $u \in C^{\infty}(\overline{M})$ of Dirichlet problem (1.1). Moreover, we have

$$||u||_{C^2(\bar{M})} \le C,$$

where the constant C depends on $M, \omega, \chi_0, \varphi$, $\|\underline{u}\|_{C^2}$, $\inf_{\overline{M}} \alpha_l$ with $0 \leq l \leq k-2$ and $\|\alpha_l\|_{C^2}$ with $0 \leq l \leq k-1$.

Note that, equation (1.1) can be seen a class of fully nonlinear elliptic equations and there is no sign requirement of the coefficient function α_{k-1} . Using some notaions on Hermitian manifolds, equation (1.1) can be rewritten as a combination of elementary symmetric functions on Hermitian manifolds, which is similar to equation (1.4). Therefore, we will construct barrier functions to obtain a prior estimates for equation (1.1) and solve the Dirichlet problem. However, compared with the classical method, we apply a blow-up argument and Liouville-type theorem due to Dinew-Kolodziej [12] to obtain the gradient estimate. For this purpose, we follow a technique of Hou-Ma-Wu [22] (also see [11]) to derive a second derivative bound of the form

$$\sup_{\bar{M}} |\partial \bar{\partial} u| \le C(1 + \sup_{M} |\nabla u|^2).$$

The organization of the paper is as follows. In Section 2 we start with some preliminaries. In Section 3 we prove C^0 estimates and second order derivative interior estimates. Boundary second order derivative estimates are given in Section 4 and 5. In Section 6, we use a blow-up argument and Liouville-type theorem to obtain gradient estimates and Theorem 1.1 is proved by the standard continuity method.

2. Preliminaries

In this section, we give some basic properties of elementary symmetric functions, which could be found in [25, 33], and establish some key lemmas. Throughout this paper, repeated indices will be summed unless otherwise stated.

2.1. Basic properties of elementary symmetric functions. For $\lambda = (\lambda_1, ..., \lambda_n) \in \mathbb{R}^n$, the k-th elementary symmetric function is defined by

$$\sigma_k(\lambda) = \sum_{1 \le i_1 < i_2 < \dots < i_k \le n} \lambda_{i_1} \lambda_{i_2} \cdots \lambda_{i_k}.$$

We also set $\sigma_0 = 1$ and denote by $\sigma_k(\lambda | i)$ the k-th symmetric function with $\lambda_i = 0$. The generalized Newton-MacLaurin inequality and some well-known result (See [1]) are as follows, which will be used later.

Proposition 2.1. For $\lambda \in \Gamma_k := \{\lambda \in \mathbb{R}^n : \sigma_i(\lambda) > 0, \forall 1 \le i \le k\}$ and $n \ge k > l \ge 0, r > s \ge 0, k \ge r, l \ge s$, we have

(2.1)
$$\left[\frac{\sigma_k(\lambda)/C_n^k}{\sigma_l(\lambda)/C_n^l}\right]^{\frac{1}{k-l}} \le \left[\frac{\sigma_r(\lambda)/C_n^r}{\sigma_s(\lambda)/C_n^s}\right]^{\frac{1}{r-s}}$$

Proposition 2.2. Let $A = (a_{ij})$ be a Hermitian matrix, $\lambda(A) = (\lambda_1, \dots, \lambda_n)$ be the eigenvalues of A and $F = F(A) = f(\lambda(A))$ be a symmetric function of $\lambda(A)$. Then for any Hermitian matrix $B = (b_{ij})$, we have

(2.2)
$$\frac{\partial^2 F}{\partial a_{ij} \partial a_{st}} b_{ij} b_{st} = \frac{\partial^2 f}{\partial \lambda_p \partial \lambda_q} b_{pp} b_{qq} + 2 \sum_{p < q} \frac{\frac{\partial f}{\partial \lambda_p} - \frac{\partial f}{\partial \lambda_q}}{\lambda_p - \lambda_q} b_{pq}^2$$

In addition, if f is concave and $\lambda_1 \leq \lambda_2 \leq ... \leq \lambda_n$, then we have

$$(2.3) f_1 \ge f_2 \ge \dots \ge f_n,$$

where $f_i = \frac{\partial f}{\partial \lambda_i}$.

Proposition 2.3. Let $W = W_{ij}$ be an $n \times n$ symmetric matric and $\lambda(W) = (\lambda_1, \lambda_2, \dots, \lambda_n)$ be the eigenvalues of the symmetric matric W. Suppose that $W = W_{ij}$ is diagonal and $\lambda_i = W_{ii}$, then we have

(2.1.5)
$$\frac{\partial \lambda_i}{\partial W_{ii}} = 1, \quad \frac{\partial \lambda_k}{\partial W_{ij}} = 0 \quad otherwise,$$

(2.1.6)
$$\frac{\partial^2 \lambda_i}{\partial W_{ij} \partial W_{ji}} = \frac{1}{\lambda_i - \lambda_j} \quad for \ i \neq j \quad and \quad \lambda_i \neq \lambda_j$$

(2.1.7)
$$\frac{\partial^2 \lambda_i}{\partial W_{kl} \partial W_{pq}} = 0 \quad otherwise.$$

Lemma 2.1. Let $\lambda(z) \in C^0(M, \mathbf{R}^n) \cap \Gamma_{k-1}$ satisfy

(2.4)
$$f(\lambda(z), z) := \frac{\sigma_k(\lambda(z))}{\sigma_{k-1}(\lambda(z))} - \sum_{l=0}^{k-1} \beta_l(z) \frac{\sigma_l(\lambda(z))}{\sigma_{k-1}(\lambda(z))} = \beta(z),$$

where β_l, β are smooth function with $\beta_l \geq 0$, then

(2.5)
$$\sum_{i=1}^{n} f_i(\lambda)\mu_i \ge f(\mu) + (k-l)\sum_{l=0}^{k-2} \beta_l \frac{\sigma_l(\lambda)}{\sigma_{k-1}(\lambda)}.$$

Proof. Since f is concave in Γ_{k-1} , we have

$$f(\mu) \le \sum_{i=1}^{n} f_i(\lambda)(\mu_i - \lambda_i) + f(\lambda),$$

which implies

$$\sum_{i=1}^{n} f_i(\lambda)\mu_i \ge f(\mu) + \sum_{l=0}^{k-2} (k-l)\beta_l \frac{\sigma_l(\lambda)}{\sigma_{k-1}(\lambda)}.$$

So, the proof is completed.

Lemma 2.2. Let $\lambda(z) \in C^0(M, \mathbb{R}^n) \cap \Gamma_{k-1}$ satisfy (2.4) and β_l, β be smooth function with $\beta_l \geq 0$. Assume $\mu \in C^0(M, \mathbb{R}^n) \cap \Gamma_{k-1}$ satisfy

(2.6)
$$\frac{\sigma_{k-1}(\mu|i)}{\sigma_{k-2}(\mu|i)} - \sum_{l=1}^{k-2} \beta_l(z) \frac{\sigma_{l-1}(\mu|i)}{\sigma_{k-2}(\mu|i)} > \beta(z) \quad \forall z \in M.$$

Then there exist constants $N, \theta > 0$ depending on $\|\mu\|_{C^0(M)}$, $\|\beta\|_{C^0(M)}$ and $\|\beta_l\|_{C^0(M)}$ such that if

$$\lambda_{\max}(z) := \max_{1 \le i \le n} \{\lambda_i(z)\} \ge N$$

we have at z

(2.7)
$$\sum_{i} f_{i}(\lambda)(\mu_{i} - \lambda_{i}) \ge \theta + \theta \sum_{i} f_{i}(\lambda)$$

(2.8)
$$f_{max}\lambda_{\max} \ge \theta,$$

where $f_{\max} = \frac{\partial f}{\partial \lambda_{\max}}$.

Proof. The proof can be seen in [6, Lemma 2.7].

Let $\mathcal{A}^{1,1}(M)$ be the space of real smooth (1,1)-forms on the Hermitian manifold (M, ω) . For any $\chi \in \mathcal{A}^{1,1}(M)$, we write in a local coordinate chart $(z^1, ..., z^n)$

$$\omega = \frac{\sqrt{-1}}{2} g_{i\overline{j}} dz^i \wedge d\overline{z}^j$$

and

or

$$\chi = \frac{\sqrt{-1}}{2} \chi_{i\overline{j}} dz^i \wedge d\overline{z}^j.$$

In particular, in a local normal coordinate system $g_{i\overline{j}} = \delta_{i\overline{j}}$, the matrix $(\chi_{i\overline{j}})$ is a Hermitian matrix. We denote $\lambda(\chi_{i\overline{j}})$ by the eigenvalues of the matrix $(\chi_{i\overline{j}})$. We define $\sigma_k(\chi)$ with respect to ω as

$$\sigma_k(\chi) = \sigma_k(\lambda(\chi_{i\overline{i}})),$$

and the Gårding's cone on ${\cal M}$ is defined by

 $\Gamma_k(M) = \{ \chi \in \mathcal{A}^{1,1}(M) : \sigma_i(\chi) > 0, \ \forall \ 1 \le i \le k \}.$

In fact, the definition of $\sigma_k(\chi)$ is independent of the choice of local normal coordinate system, and it can be defined without the use of local normal coordinate by

$$\sigma_k(\chi) = C_n^k \frac{\chi^k \wedge \omega^{n-k}}{\omega^n},$$

where $C_n^k = \frac{n!}{(n-k)!k!}$.

Using the above notation, we can rewrite equation (1.1) as the following local form:

(2.9)
$$\begin{cases} \frac{\sigma_k(\chi_u)}{\sigma_{k-1}(\chi_u)} - \sum_{l=0}^{k-2} \beta_l(z) \frac{\sigma_l(\chi_u)}{\sigma_{k-1}(\chi_u)} = \beta(z), & \text{in } M, \\ u = \varphi & \text{on } \partial M \end{cases}$$

where $\beta_l(z) = \frac{C_n^k}{C_n^l} \alpha_l(z)$ for $0 \le l \le k-2$ and $\beta(z) = \frac{C_n^k}{C_n^{k-1}} \alpha_{k-1}(z)$.

According to an important observation by Guan-Zhang in [21], we know that

Proposition 2.4. If $u \in C^2(M)$ with $\chi_u \in \Gamma_{k-1}(M)$ and $\beta_l(z) \ge 0$ for $0 \le l \le k-2$, then the operator

(2.10)
$$G(\chi_u) = \frac{\sigma_k(\chi_u)}{\sigma_{k-1}(\chi_u)} - \sum_{l=0}^{k-2} \beta_l(z) \frac{\sigma_l(\chi_u)}{\sigma_{k-1}(\chi_u)}$$

is elliptic and concave.

For the convenience of notations, we will denote

$$G(\chi) := \frac{\sigma_k(\chi)}{\sigma_{k-1}(\chi)} - \sum_{l=0}^{k-2} \beta_l(z) \frac{\sigma_l(\chi)}{\sigma_{k-1}(\chi)},$$
$$G_k(\chi) := \frac{\sigma_k(\chi)}{\sigma_{k-1}(\chi)}, \quad G_l(\chi) := -\frac{\sigma_l(\chi)}{\sigma_{k-1}(\chi)},$$

and

$$G^{i\bar{j}} := \frac{\partial G}{\partial \chi_{i\bar{j}}}, G^{i\bar{j},r\bar{s}} := \frac{\partial^2 G}{\partial \chi_{i\bar{j}}\partial \chi_{r\bar{s}}}, G^{i\bar{j}}_l := \frac{\partial G_l}{\partial \chi_{i\bar{j}}}, G^{i\bar{j},r\bar{s}}_l := \frac{\partial^2 G_l}{\partial \chi_{i\bar{j}}\partial \chi_{r\bar{s}}}$$

for any $1 \le i, j, r, s \le n$ and $0 \le l \le k - 2$.

Lemma 2.3. If $u \in C^2(M)$ with $\chi_u \in \Gamma_{k-1}(M)$ satisfy $G(\chi_u) = \beta$, in M,

where $\beta_l > 0$ for $0 \le l \le k - 2$. Then

(2.11)
$$0 < \frac{\sigma_l}{\sigma_{k-1}} \left(\lambda(\chi_u) \right) \le C(n, k, \inf_M \beta_l, \sup_M |\beta|), \quad 0 \le l \le k-2;$$

(2.12)
$$-\sup_{M} |\beta| < \frac{\sigma_k}{\sigma_{k-1}} \left(\lambda(\chi_u)\right) \le C(n,k,\sum_{l=0}^{k-1} \sup_{M} |\beta_l|);$$

(2.13)
$$\frac{n-k+1}{k} \le \sum_{i} G^{i\overline{i}} \le n-k-1 + \frac{(n-k+2)\sigma_{k-2}}{\sigma_{k-1}} \left(\lambda(\chi_u)\right)\beta;$$

(2.14)
$$\sum_{i} G^{i\overline{i}}\lambda_{i}(\chi_{u}) = \beta + \sum_{l=0}^{k-2} (k-l)\beta_{l} \frac{\sigma_{l}}{\sigma_{k-1}} \left(\lambda(\chi_{u})\right).$$

Proof. The proofs of Lemma are quite similar to that given for [6, Lemma 2.8, 2.9] and so they are omitted. \Box

3. C^0 estimates and Second order interior estimates

3.1. C^0 estimates.

Theorem 3.1. Let $u \in C^{\infty}(\overline{M})$ be an (k-1)-admissible solution for equation (1.1). Under the assumptions mentioned in Theorem 1.1, then there exists a positive constant C depending only on $(M, \omega), \chi_0, \alpha_l, \varphi$ and the subsolution \underline{u} such that

$$\sup_{\bar{M}} |u| \le C.$$

Proof. On the one hand, we know that the subsolution $\underline{u} \in C^2(\overline{M})$ satisfies $G(\chi_{\underline{u}}) - G(\chi_u) \geq 0$ in M and $\underline{u} - u = 0$ on ∂M . By the ellipticity of G and the maximum principle,

$$\underline{u}(z) \le u(z), \quad \forall z \in \bar{M}.$$

On the other hand, let v be a function satisfying

$$\omega^{ik} \left((\chi_0)_{\bar{k}i} + \partial_i \partial_{\bar{k}} v \right) = 0 \quad \text{in } M; \quad v = \varphi \quad \text{on } \partial M.$$

Note that $\chi_u \in \Gamma_k(M) \subset \Gamma_1(M)$. By the comparison principle,

$$u(z) \le v(z), \quad \forall z \in \overline{M}.$$

According to the proof of Theorem 3.1, we know that u - v and $\underline{u} - u$ attain their maximums on the boundary. Combining with the Hopf lemma, we obtain

(3.1)
$$\sup_{z \in \partial M} |\nabla u| \le C,$$

where C depends on $(M, \omega), \chi_0, \alpha_l$ and <u>u</u>.

3.2. Notations and some lemmas. In local complex coordinates $(z^1, ..., z^n)$, the subscripts of a function u always denote the covariant derivatives of u with respect to ω in the directions of the local frame $\frac{\partial}{\partial z^1}, ..., \frac{\partial}{\partial z^n}$. Namely,

$$u_i = \nabla_{\frac{\partial}{\partial z^i}} u, \quad u_{i\overline{j}} = \nabla_{\frac{\partial}{\partial \overline{z^j}}} \nabla_{\frac{\partial}{\partial z^i}} u, \quad u_{i\overline{j}k} = \nabla_{\frac{\partial}{\partial z^k}} \nabla_{\frac{\partial}{\partial \overline{z^j}}} \nabla_{\frac{\partial}{\partial z^i}} u$$

But, the covariant derivatives of a (1,1)-form χ with respect to ω will be denoted by indices with semicolons, e.g.,

$$\chi_{i\overline{j};k} = \nabla_{\frac{\partial}{\partial z^k}} \chi(\frac{\partial}{\partial z^i}, \frac{\partial}{\partial \overline{z}^j}), \quad \chi_{i\overline{j};k\overline{l}} = \nabla_{\frac{\partial}{\partial \overline{z}^l}} \nabla_{\frac{\partial}{\partial z^k}} \chi(\frac{\partial}{\partial z^i}, \frac{\partial}{\partial \overline{z}^j})$$

We recall the following commutation formula on Hermitian manifolds (M, ω) [22, 16, 17].

Lemma 3.1. For $u \in C^4(M)$, we have

$$\begin{split} u_{i\overline{j}k} - u_{k\overline{j}i} &= T_{ik}^l u_{l\overline{j}}, \\ u_{i\overline{j}\overline{k}} - u_{i\overline{k}\overline{j}} &= \overline{T_{jk}^l} u_{i\overline{l}}, \\ u_{i\overline{j}k} &= u_{ik\overline{j}} - R_{k\overline{j}i\overline{m}} g^{\overline{m}l} u_l, \end{split}$$

$$\begin{split} u_{i\overline{j}k\overline{l}} - u_{k\overline{l}i\overline{j}} &= g^{p\overline{q}} (R_{k\overline{l}i\overline{q}} u_{p\overline{j}} - R_{i\overline{j}k\overline{q}} u_{p\overline{l}}) + T^p_{ik} u_{p\overline{j}\overline{l}} + \overline{T^q}_{jl} u_{i\overline{q}k} - T^p_{ik} \overline{T^q}_{jl} u_{p\overline{q}}, \\ where R is the curvature tensor of <math>(M, \omega). \end{split}$$

Theorem 3.2. Let $u \in C^{\infty}(\overline{M})$ be an (k-1)-admissible solution for equation (1.1). Under the assumptions mentioned in Theorem 1.1, then there exists a positive constant C depending only on $(M, \omega), \chi_0, \alpha_l, \varphi$ and the subsolution \underline{u} such that

$$\sup_{M} |\sqrt{-1}\partial\bar{\partial}u| \le C\left(K + \sup_{\partial M} |\sqrt{-1}\partial\bar{\partial}u|\right),\,$$

where $K := 1 + \sup_M |\nabla u|^2$, and C depending on $(M, \omega), \chi_0, \alpha_l, \varphi$ and the subsolution \underline{u} .

3.3. The proof of Theorem 3.2. In order to study the second order interior estimate of (2.9) (or (1.1)), it is sufficient to consider the following equation

where $\widetilde{\chi}_u := \widetilde{\chi}_0 + u$ and $\widetilde{\chi}_0 = \chi_0 + \frac{\sqrt{-1}}{2} \partial \overline{\partial} \underline{u}$. It is clear that 0 is an admissible subsolution to (3.2). Without causing confusion, we denote $\widetilde{\chi}_u$ by χ and $\widetilde{\chi}_0$ by χ_0 .

Following the work of Hou-Ma-Wu [22], we define a function W on M as

where $\lambda_1 : M \to \mathbb{R}$ is the largest eigenvalue of the matrix $A = \omega^{i\bar{l}} \chi_{\bar{l}j}$ at each point with ω . Since λ_1 is not a smooth function, we will perturb A slightly as in [31, 30]. There are also other methods to deal with this issue: one is to use a viscosity type argument as in [37], another is to replace λ_1 by a carefully chosen quadratic function of $\chi_{i\bar{j}}$ as in [38].

The function W must achieve its maximum at the interior point $z_0 \in M$. Around z_0 , we choose a normal chart such that A is diagonal with eigenvalues

Since $\sum_i \lambda_i > 0$, we can choose *B* sufficient small such that $\sum_i \tilde{\lambda}_i > 0$. Thus, $|\tilde{\lambda}_i| < (n-1)\lambda_1$, which gives

Now, we divide our proof into two cases separately, depending on whether $\chi_{n\overline{n}} < -\delta \chi_{1\overline{1}}$ or not, for a small δ to be chosen later.

Case 1. $\chi_{n\overline{n}} < -\delta\chi_{1\overline{1}}$. In this case, it follows that $\chi^2_{1\overline{1}} \leq \frac{1}{\delta^2}\chi^2_{n\overline{n}}$. So, we only need to bound $\chi^2_{n\overline{n}}$. Clearly, we can obtain if we throw some positive terms in (3.19)

$$(3.20) + 2\varphi'\sum_{p}\operatorname{Re}\{(\beta)_{p}u_{\overline{p}}\} - C\sum_{i}G^{i\overline{i}} - C.$$

From (2.5), we obtain

$$-\psi' \sum_{i} G^{i\bar{i}} u_{i\bar{i}} = -\psi' \sum_{i} G^{i\bar{i}} \Big[\chi_{i\bar{i}} - ((\chi_{0})_{i\bar{i}} - \tau) - \tau \Big]$$

$$= -\psi' \Big[\beta + \sum_{l=0}^{k-2} (l-k) \beta_{l} G_{l} - \sum_{i} G^{i\bar{i}} (\chi_{0i\bar{i}} - \tau) - \tau \sum_{i} G^{i\bar{i}} \Big]$$

(3.21)
$$\leq C\Lambda - \tau \Lambda \sum_{i} G^{i\bar{i}}.$$

Plugging (3.21) into (3.20) and choosing Λ large enough,

(3.22)
$$\varphi'' G^{i\bar{i}} |\nabla_i (|\nabla u|^2)|^2 + \frac{\varphi'}{8} G^{i\bar{i}} |\chi_{i\bar{i}}|^2$$

$$\leq (1+\delta^4) G^{i\bar{i}} \frac{|\chi_{1\bar{1};i}|^2}{\chi_{1\bar{1}}^2} - 2\varphi' \sum_p \operatorname{Re}\{(\beta)_p u_{\overline{p}}\} + C(1+\Lambda).$$

Note that we get from (3.13)

$$(1+\delta^{4})\sum_{i}\frac{G^{i\bar{i}}|\chi_{1\bar{1};i}|^{2}}{\chi_{1\bar{1}}^{2}} = (1+\delta^{4})\sum_{i}G^{i\bar{i}}|\varphi'\nabla_{i}(|\nabla u|^{2}) + \psi'u_{i}|^{2}$$

$$\leq 2(\varphi')^{2}\sum_{i}G^{i\bar{i}}|\nabla_{i}(|\nabla u|^{2})|^{2} + \frac{8(1+\delta^{4})}{1-\delta^{4}}\Lambda^{2}K\sum_{i}G^{i\bar{i}}$$

$$(3.23) \leq 2(\varphi')^{2}\sum_{i}G^{i\bar{i}}|\nabla_{i}(|\nabla u|^{2})|^{2} + 16\Lambda^{2}K\sum_{i}G^{i\bar{i}},$$

where we choose $\delta \leq 3^{-\frac{1}{4}}$. In fact,

(3.24)
$$\sum_{i} G^{i\overline{i}}\chi_{i\overline{i}}^{2} \ge G^{n\overline{n}}\chi_{n\overline{n}}^{2} \ge \frac{1}{n}\chi_{n\overline{n}}^{2}\sum_{i} G^{i\overline{i}}.$$

Substituting (3.23) and (3.24) into (3.22), we get

$$\frac{1}{32nK}\chi_{n\overline{n}}^2\sum_i G^{i\overline{i}} \le 16\Lambda^2 K\sum_i G^{i\overline{i}} + C(1+\Lambda).$$

Combining with (2.13), it is easy to derive that

$$\chi_{1\overline{1}} \le CK.$$

Case 2. $\chi_{n\overline{n}} \ge -\delta\chi_{1\overline{1}}$. Define

$$I = \left\{ i \in \{1, 2, ..., n\} : G^{i\overline{i}} > \delta^{-1} G^{1\overline{1}} \right\}.$$

It follows from (2.2)

$$\frac{-\frac{1}{\chi_{1\overline{1}}}G^{i\overline{j},r\overline{s}}\chi_{i\overline{j};1}\chi_{r\overline{s};\overline{1}}}{2} \geq \frac{1-\delta}{1+\delta}\frac{1}{\chi_{1\overline{1}}^{2}}\sum_{i\in I}G^{i\overline{i}}|\chi_{i\overline{1};1}|^{2} \\
(3.25) \geq \frac{1-\delta}{1+\delta}\frac{1}{\chi_{1\overline{1}}^{2}}\sum_{i\in I}G^{i\overline{i}}\left(|\chi_{1\overline{1};i}|^{2}+2\operatorname{Re}\{\chi_{1\overline{1};i}\overline{e_{i}'}\}\right),$$

where $e'_i = T^p_{i1}u_{p\overline{1}} + (\chi_0)_{i\overline{1};1} - (\chi_0)_{\overline{1}1;i}$. Note that $\varphi'' = 2(\varphi')^2$, using (3.13), we get

$$(3.26) \qquad \varphi'' \sum_{i \in I} G^{i\overline{i}} |\nabla_i(|\nabla u|^2)|^2 \ge 2 \sum_{\substack{i \in I \\ 15}} G^{i\overline{i}} \left(\delta \left| \frac{\chi_{1\overline{1};i}}{\chi_{1\overline{1}}} \right|^2 - \frac{\delta}{1-\delta} |\psi' u_i|^2 \right).$$

Choosing $\delta \leq \min\{\frac{1}{2A+1}, 3^{-\frac{1}{4}}\}$ and hence $\psi'' \geq \frac{2\delta}{1-\delta}(\psi')^2$. Combining (3.25) with (3.26),

$$(3.27) \qquad (1+\delta^4) \sum_{i \in I} \frac{G^{i\overline{i}} |\chi_{1\overline{1};i}|^2}{\chi_{1\overline{1}}^2} - \frac{1-\delta^2}{\chi_{1\overline{1}}} G^{i\overline{j},r\overline{s}} \chi_{i\overline{j};1} \chi_{r\overline{s};\overline{1}} + \varphi'' \sum_{i \in I} G^{i\overline{i}} |\nabla_i(|\nabla u|^2)|^2 + \psi'' \sum_{i \in I} G^{i\overline{i}} |u_i|^2 \\ \geq \frac{\delta^2}{2} \sum_{i \in I} \frac{G^{i\overline{i}} |\chi_{1\overline{1};i}|^2}{\chi_{1\overline{1}}^2} + 2(1-\delta)^2 \frac{1}{\chi_{1\overline{1}}^2} \sum_{i \in I} G^{i\overline{i}} \operatorname{Re}\{\chi_{1\overline{1};i}\overline{e_i'}\} \\ \geq \frac{\delta^2}{4} \sum_{i \in I} \frac{G^{i\overline{i}} |\chi_{1\overline{1};i}|^2}{\chi_{1\overline{1}}^2} - C_\delta \frac{1}{\chi_{1\overline{1}}^2} \sum_{i \in I} G^{i\overline{i}} \lambda_i^2 \\ \leq \frac{\delta^2}{4} \sum_{i \in I} \frac{G^{i\overline{i}} |\chi_{1\overline{1};i}|^2}{\chi_{1\overline{1}}^2} - C \sum_{i \in I} G^{i\overline{i}}, \end{cases}$$

where we choose $\chi_{1\overline{1}}$ large enough to get the last inequality.

For the terms without an index in I, by (3.23) and the fact $1 \notin I$, it follows that

(3.28)
$$-(1+\delta^4) \sum_{i \notin I} \frac{G^{i\bar{i}} |\chi_{1\bar{1};i}|^2}{\chi_{1\bar{1}}^2} + \varphi'' \sum_{i \notin I} G^{i\bar{i}} |\nabla_i(|\nabla u|^2)|^2$$
$$\geq -\frac{16n\Lambda^2 K}{\delta} G^{1\bar{1}}.$$

Substituting (3.27) and (3.28) into (3.19),

$$(3.29) C\sum_{i} G^{i\overline{i}} + C + \frac{16n\Lambda^2 K}{\delta} G^{1\overline{1}} \geq \frac{1}{8K} G^{i\overline{i}} \chi^2_{i\overline{i}} + \psi' G^{i\overline{i}} u_{i\overline{i}}.$$

Note that $\mu := \lambda(\chi_0 + \frac{\sqrt{-1}}{2}\partial \bar{\partial}\underline{u})$ satisfies the condition (2.6) since (1.5). Without loss of generality we assume that $\chi_{1\bar{1}} \geq N$. From Lemma 2.2, we will divide the following argument into two case:

Case 2.1:

$$\sum_{i} G^{i\overline{i}} u_{i\overline{i}} \leq -\theta - \theta \sum_{i} G^{i\overline{i}}.$$

It implies that

We can choose Λ large enough, then (3.30) gives

$$\frac{1}{8K}G^{1\overline{1}}\chi^{2}_{1\overline{1}} \le \frac{1}{8K}G^{i\overline{i}}\chi^{2}_{i\overline{i}} \le \frac{16n\Lambda^{2}K}{\delta}G^{1\overline{1}}.$$

 So

$$|\chi_{1\bar{1}}| \le 8\Lambda K \sqrt{\frac{2n}{\delta}}.$$

Case 2.2:

 $(3.31) G^{1\bar{1}}\chi_{1\bar{1}} \ge \theta.$

From (3.21), we can absorb the last term of (3.29) into $\tau \Lambda \sum_{i} G^{ii}$,

$$C(1+\Lambda) + C\sum_{i} G^{i\overline{i}} + \frac{16n\Lambda^2 K}{\delta} G^{1\overline{1}} \ge \frac{1}{8K} G^{1\overline{1}} \chi_{1\overline{1}}^2 + \tau\Lambda \sum_{i} G^{i\overline{i}}.$$

Choosing Λ large enough, it follows that

(3.32)
$$C(1+\Lambda) + \frac{16n\Lambda^2 K}{\delta} G^{1\overline{1}} \ge \frac{1}{8K} G^{1\overline{1}} \chi^2_{1\overline{1}}.$$

Using (3.31), we choose $\chi_{1\overline{1}}$ large enough such that

$$\frac{1}{16K}G^{1\overline{1}}\chi^2_{1\overline{1}} \geq \frac{\theta}{16K}\chi_{1\overline{1}} \geq C(1+\Lambda)$$

Taking the above inequality into (3.32), we arrive

$$\chi_{1\overline{1}} \le 16\sqrt{\frac{n}{\delta}}\Lambda K.$$

So, we complete the proof.

4. Boundary mixed tangential-normal estimates

The goal of this section is to prove an estimate for the boundary mixed tangential-normal derivatives. For $p \in \partial M$, we choose a coordinate $z = (z^1, ..., z^n)$ such that p corresponds to the origin and $g_{i\overline{j}} = \delta_{ij}$. We denote $z^i = x^i + \sqrt{-1}y^i$ and

$$t^{1} = y^{1}, t^{2} = y^{2}, ..., t^{n} = y^{n}, t^{n+1} = x^{1}, ..., t^{2n-1} = x^{n-1}.$$

Let ρ be the distance function to 0, i.e.,

$$\rho(z) =: dist_{g_0}(z, 0), \quad x \in M$$

and set

$$M_{\delta} = \{ z \in M : \rho(z) < \delta \} \quad \text{for} \quad \delta > 0.$$

Let d be the distance function to the boundary ∂M with respect to the background metric g

$$d(z) =: dist_{g_0}(z, \partial M), \quad z \in M.$$
17

Since ∂M is smooth and $|\nabla d| = 1$ on ∂M , we can choose $\delta > 0$ sufficiently small so that d is smooth,

(4.1)
$$\frac{1}{2} \le |\nabla d| \le 2 \quad \text{in} \quad M_{\delta}$$

and

(4.2)
$$C_2 \le |\nabla^2 d| \le C_1 \quad \text{in} \quad M_\delta,$$

where the constants C_1 and C_2 are independent of δ .

Suppose near the origin, the boundary ∂M is represented by

$$\rho(z) = 0$$

and $d\rho \neq 0$ on ∂M . Then, there exists a function $\zeta(t)$ such that

$$\rho(t,\zeta(t)) = 0$$

Differentiating the boundary condition $(u - \underline{u})(t, \zeta(t)) = 0$, we derive the relation on $\partial M \cap \overline{M_{\delta}}$

(4.3)
$$\partial_{t^{\alpha}}(u-\underline{u}) = -\partial_{x^{n}}(u-\underline{u})\partial_{t^{\alpha}}\zeta$$

for any $\alpha = 1, \dots, 2n-1$. Moreover, differentiating the boundary condition again gives

(4.4)
$$\partial_{t^{\alpha}}\partial_{t^{\gamma}}(u-\underline{u})(0) = -\partial_{x^{n}}(u-\underline{u})(0)\partial_{t^{\alpha}}\partial_{t^{\gamma}}\zeta(0),$$

which implies that

$$(4.5) |\partial_{t^{\alpha}}\partial_{t^{\gamma}}u(0)| \le C$$

for any $\alpha, \gamma = 1, \cdots, 2n - 1$.

To derive the boundary tangential-normal estimates, we use the following locally defined auxiliary function in M_{δ}

$$\Psi = A\sqrt{K}v + B\sqrt{K}|z|^2 - \frac{1}{\sqrt{K}}\sum_{p=1}^n \left[\partial_{y^p}(u-\underline{u})\right]^2 - \frac{1}{\sqrt{K}}\sum_{a=1}^{n-1} |\nabla_a(u-\underline{u})|^2 + T_\alpha(u-\underline{u}),$$

where $A, B \gg 1$ are constants to be determined. Here,

$$v = u - \underline{u} + td - \frac{N}{2}d^2,$$

introduced by Guan in [19], and t and N will be determined later.

Lemma 4.1. There exist uniform positive constants t, δ, ε small enough and N >> 1 such that v astisfies

(4.6)
$$\begin{cases} G^{i\overline{j}}v_{i\overline{j}} \leq -\frac{\varepsilon}{4}\left(1+\sum_{i=1}^{n}G^{i\overline{i}}\right), & in \ M_{\delta}, \\ v \geq 0 & on \ \partial M_{\delta}, \end{cases}$$

Proof. The proof is quite similar to that given for [43, Lemma 2.4] and so they are omitted. \Box

4.1. Estimates of tangential derivatives $T_{\alpha}(u-\underline{u})$. For $\alpha \in \{1, 2, ..., 2n-1\}$, we define the real vector fields

$$T_{\alpha} = \frac{\partial}{\partial t^{\alpha}} - \frac{\rho_{t^{\alpha}}}{\rho_{x^{n}}} \frac{\partial}{\partial x^{n}},$$

which are clearly tangential vector on ∂M . Then, we have

Lemma 4.2.

$$\left| G^{i\overline{j}}\partial_{i}\partial_{\overline{j}}T_{\alpha}(u-\underline{u}) \right| \leq \frac{1}{\sqrt{K}}G^{i\overline{j}}\partial_{i}\partial_{y^{n}}(u-\underline{u})\partial_{\overline{j}}\partial_{y^{n}}(u-\underline{u}) + C\sum_{i=1}^{n}(1+G^{i\overline{i}}|\lambda_{i}|) + C(1+\sqrt{K})\sum_{i=1}^{n}G^{i\overline{i}}.$$

$$(4.7)$$

Proof. We start with the following computation

$$(4.8) \qquad G^{i\overline{j}}\partial_i\partial_{\overline{j}}T_{\alpha}(u-\underline{u}) = G^{i\overline{j}}\partial_i\partial_{\overline{j}}\partial_{t^{\alpha}}(u-\underline{u}) - \frac{\rho_{t^{\alpha}}}{\rho_{x^n}}G^{i\overline{j}}\partial_i\partial_{\overline{j}}\partial_{x^n}(u-\underline{u}) \\ -2\operatorname{Re}\left[G^{i\overline{j}}\left(\partial_i\frac{\rho_{t^{\alpha}}}{\rho_{x^n}}\right)\partial_{\overline{j}}\partial_{x^n}(u-\underline{u})\right] - G^{i\overline{j}}\left(\partial_i\partial_{\overline{j}}\frac{\rho_{t^{\alpha}}}{\rho_{x^n}}\right)\partial_{x^n}(u-\underline{u}).$$

Differentiating the equation (2.9) once, we have

(4.9)
$$G^{i\overline{j}}\nabla_{t^{\alpha}}\nabla_{i}\nabla_{\overline{j}}u + G^{i\overline{j}}\nabla_{t^{\alpha}}(\chi_{0})_{\overline{j}i} = \nabla_{t^{\alpha}}\beta - \sum_{l=0}^{k-2} (\nabla_{t^{\alpha}}\beta_{l})G_{l}.$$

Note that

$$\frac{\partial}{\partial t^{\alpha}} = \frac{1}{\sqrt{-1}} \left(\frac{\partial}{\partial z^{\alpha}} - \frac{\partial}{\partial \overline{\overline{z}}^{\alpha}} \right) \quad \text{for} \quad 1 \le \alpha \le n,$$

and

$$\frac{\partial}{\partial t^{\alpha}} = \left(\frac{\partial}{\partial z^{\alpha-n}} + \frac{\partial}{\partial \overline{z}^{\alpha-n}}\right) \quad \text{for} \quad n+1 \le \alpha \le 2n-1.$$

Then, we can convert covariant derivatives to partial derivatives for $n+1 \leq \alpha \leq 2n-1$

(4.10)
$$\nabla_{t^{\alpha}} \nabla_{\overline{j}} u = \nabla_{\alpha} \nabla_{\overline{j}} \nabla_{\overline{j}} u + \nabla_{\overline{\alpha}} \nabla_{\overline{j}} \nabla_{\overline{j}} u$$
$$= \partial_{i} \partial_{\overline{j}} \partial_{t^{\alpha}} u - \Gamma^{r}_{\alpha i} u_{\overline{j}r} - \overline{\Gamma^{r}_{\alpha j}} u_{\overline{r}i}.$$

Substituting (4.10) into (4.9) gives

(4.11)
$$G^{i\overline{j}}\partial_{i}\partial_{\overline{j}}\partial_{t^{\alpha}}u = -G^{i\overline{j}}\nabla_{t^{\alpha}}(\chi_{0})_{\overline{j}i} + \nabla_{t^{\alpha}}\beta - \sum_{l=0}^{k-2} (\nabla_{t^{\alpha}}\beta_{l})G_{l} + G^{i\overline{j}}\Gamma_{\alpha i}^{r}u_{\overline{j}r} + G^{i\overline{j}}\overline{\Gamma_{\alpha j}^{r}}u_{\overline{r}i}.$$

It follows that for $n+1 \leq \alpha \leq 2n-1$

(4.12)
$$\left| G^{i\overline{j}}\partial_i\partial_{\overline{j}}\partial_{t^{\alpha}}u \right| \leq CG^{i\overline{i}}(1+|\lambda_i|) + C(|\nabla\beta| + \sum_{l=0}^{k-2} |\nabla\beta_l|).$$

Similarly, we can get the estimate (4.12) for $1 \le \alpha \le n$. Thus, the estimate (4.12) holds for all $1 \le \alpha \le 2n-1$. Moreover, we also have a similar estimate

$$(4.13) \quad |G^{i\overline{j}}\partial_i\partial_{\overline{j}}\partial_{x^n}u| \le CG^{i\overline{i}}(1+|\lambda_i|) + C(|\nabla\beta| + \sum_{l=0}^{k-2} |\nabla\beta_l|).$$

Plugging (4.12) and (4.13) into (4.8), it yields

$$G^{i\overline{j}}\partial_{i}\partial_{\overline{j}}T_{\alpha}(u-\underline{u}) \leq -2\operatorname{Re}\left[G^{i\overline{j}}\left(\partial_{i}\frac{\rho_{t^{\alpha}}}{\rho_{x^{n}}}\right)\partial_{\overline{j}}\partial_{x^{n}}(u-\underline{u})\right] + \sqrt{K}\sum_{i=1}^{n}G^{i\overline{i}}$$

$$(4.14) + CG^{i\overline{i}}(1+|\lambda_{i}|) + C.$$

The first term on the right hand side of (4.14) can be written as

$$\begin{aligned} G^{i\overline{j}}\left(\partial_{i}\frac{\rho_{t^{\alpha}}}{\rho_{x^{n}}}\right)\partial_{\overline{j}}\partial_{x^{n}}(u-\underline{u}) &= 2G^{i\overline{j}}\left(\partial_{i}\frac{\rho_{t^{\alpha}}}{\rho_{x^{n}}}\right)\partial_{\overline{j}}\partial_{n}(u-\underline{u}) \\ &+\sqrt{-1}G^{i\overline{j}}\left(\partial_{i}\frac{\rho_{t^{\alpha}}}{\rho_{x^{n}}}\right)\partial_{\overline{j}}\partial_{y^{n}}(u-\underline{u}),\end{aligned}$$

it follows from the Cauchy-Schwarz inequality that

$$|G^{i\overline{j}}\left(\partial_{i}\frac{\rho_{t^{\alpha}}}{\rho_{x^{n}}}\right)\partial_{\overline{j}}\partial_{x^{n}}(u-\underline{u})| \leq \frac{1}{2\sqrt{K}}G^{i\overline{j}}\partial_{i}\partial_{y^{n}}(u-\underline{u})\partial_{\overline{j}}\partial_{y^{n}}(u-\underline{u})$$

$$+C(\sum_{i=1}^{n}G^{i\overline{i}}|\lambda_{i}|+1)+C(1+\sqrt{K})\sum_{i=1}^{n}G^{i\overline{i}}.$$

$$(4.15)$$

Combining (4.14) and (4.15) gives (4.7).

4.2. Estimates of $K^{-\frac{1}{2}} \sum_{p=1}^{n} \left[\partial_{y^{p}}(u - \underline{u}) \right]^{2}$. Differentiating the boundary condition $(u - \underline{u})(t, \zeta(t)) = 0$, we have

$$\partial_{y^p}(u-\underline{u}) = -\partial_{x^n}(u-\underline{u})\partial_{y^p}\zeta, \text{ on } \partial M \cap \overline{M_\delta}.$$

Note that $|\partial_{y^p}\zeta| \leq C|t|$ in view of $\partial_{y^p}\zeta(0) = \partial_{y^p}\rho(0) = 0$, hence

$$(\partial_{y^p}(u-\underline{u}))^2 \le C|z|^2$$
 on $\partial M \cap \overline{M_\delta}$.

Combining with (4.12), we can obtain

$$(4.16) \frac{1}{\sqrt{K}} G^{i\overline{j}} \partial_i \partial_{\overline{j}} \Big[\partial_{y^p} (u - \underline{u}) \Big]^2$$

$$= \frac{2}{\sqrt{K}} G^{i\overline{j}} \partial_i \partial_{y^p} (u - \underline{u}) \partial_{\overline{j}} \partial_{y^p} (u - \underline{u}) + \frac{2}{\sqrt{K}} \partial_{y^p} (u - \underline{u}) G^{i\overline{j}} \partial_i \partial_{\overline{j}} \partial_{y^p} (u - \underline{u})$$

$$\geq \frac{2}{\sqrt{K}} G^{i\overline{j}} \partial_i \partial_{y^p} (u - \underline{u}) \partial_{\overline{j}} \partial_{y^p} (u - \underline{u}) - C |G^{i\overline{j}} \partial_i \partial_{\overline{j}} \partial_{y^p} u| - C \sum_{i=1}^n G^{i\overline{i}}$$

$$\geq \frac{2}{\sqrt{K}} G^{i\overline{j}} \partial_i \partial_{y^p} (u - \underline{u}) \partial_{\overline{j}} \partial_{y^p} (u - \underline{u}) - C G^{i\overline{i}} (1 + |\lambda_i|) - C \sum_i G^{i\overline{i}} - C.$$

4.3. Estimates of $\frac{1}{\sqrt{K}} \sum_{a=1}^{n-1} |\nabla_a(u-\underline{u})|^2$. For each $a \in \{1, 2, ..., n-1\}$, we define local sections of $T^{1,0}M$ around the origin

$$E_a(0) = \frac{\partial}{\partial z^a} - \left[\frac{\partial_{z^a}\rho}{\partial z^n\rho}\right]\frac{\partial}{\partial z^n}, \quad \text{for} \quad 1 \le a \le n-1.$$

Clearly, those are tangential to ∂M . Using the metric ω , we perform the Gram-Schmidt process to obtain a local orthonormal frame $\{e_a\}_{a=1}^{n-1}$ of $T^{1,0}M$. Thus, $\{e_a\}_{a=1}^{n-1}$ are tangential to ∂M , $\omega(e_a, \overline{e}_b) = \delta_{ab}$ and

$$e_a(0) = \frac{\partial}{\partial z^a}, \quad \text{for} \quad 1 \le a \le n-1.$$

Furthermore, let

$$e_n = \frac{E_n}{|E_n|_{\omega}}, \quad E_n = \frac{\partial}{\partial z^n} - \sum_{a=1}^{n-1} \omega(\partial_n, \overline{e}_a) e_a.$$

Thus,

$$\frac{1}{\sqrt{K}}G^{i\overline{j}}\partial_{i}\partial_{\overline{j}}|\nabla_{a}(u-\underline{u})|^{2} = \frac{1}{\sqrt{K}}G^{i\overline{j}}\partial_{i}\partial_{\overline{j}}\nabla_{a}(u-\underline{u})\overline{\nabla_{a}(u-\underline{u})} \\
= \frac{1}{\sqrt{K}}G^{i\overline{j}}\partial_{i}\partial_{\overline{j}}\left[e_{a}^{p}\overline{e_{a}^{q}}\partial_{p}(u-\underline{u})\partial_{\overline{q}}(u-\underline{u})\right] \\
\geq \frac{1}{\sqrt{K}}G^{i\overline{j}}e_{a}^{p}\partial_{\overline{j}}\partial_{p}(u-\underline{u})\overline{e_{a}^{q}}\partial_{\overline{q}}\partial_{i}(u-\underline{u}) \\
+ \frac{1}{\sqrt{K}}G^{i\overline{j}}e_{a}^{p}\partial_{i}\partial_{p}(u-\underline{u})\overline{e_{a}^{q}}\partial_{\overline{j}}\partial_{\overline{q}}(u-\underline{u}) \\
+ \frac{2}{\sqrt{K}}\operatorname{Re}\left(G^{i\overline{j}}\partial_{\overline{j}}(e_{a}^{p}\overline{e_{a}^{q}})\partial_{p}\partial_{i}(u-\underline{u})\partial_{\overline{q}}(u-\underline{u})\right) \\$$
(4.17)
$$-CG^{i\overline{i}}(1+|\lambda_{i}|) - C(1+\sqrt{K})\sum_{i=1}^{n}G^{i\overline{i}} - C.$$

We deal with the first term on the right side of the inequality (4.17) by

$$(4.18) \qquad G^{i\overline{j}}e^p_a\partial_{\overline{j}}\partial_p(u-\underline{u})\overline{e^q_a}\partial_i\partial_{\overline{q}}(u-\underline{u}) = G^{i\overline{j}}(\chi-\chi_{\underline{u}})_{\overline{j}a}(\chi-\chi_{\underline{u}})_{\overline{a}i}$$
$$\geq \frac{1}{2}G^{i\overline{j}}\chi_{\overline{j}a}\chi_{\overline{a}i} - C\sum_{i=1}^n G^{i\overline{i}}.$$

Next, we can rewrite the third term on the right side of the inequality (4.17) as

$$\frac{2}{\sqrt{K}}G^{i\overline{j}}\partial_{\overline{j}}(e^p_a\overline{e^q_a})\partial_p\partial_i(u-\underline{u})\partial_{\overline{q}}(u-\underline{u}) = \frac{2}{\sqrt{K}}G^{i\overline{j}}\partial_{\overline{j}}(e^p_a\overline{e^q_a})\partial_{\overline{p}}\partial_i(u-\underline{u})\partial_{\overline{q}}(u-\underline{u})
(4.19) -\sqrt{-1}\frac{2}{\sqrt{K}}G^{i\overline{j}}\partial_{\overline{j}}(e^p_a\overline{e^q_a})\partial_{y^p}\partial_i(u-\underline{u})\partial_{\overline{q}}(u-\underline{u}),$$

where we used the relation $\frac{\partial}{\partial z^p} = \frac{\partial}{\partial \overline{z}^p} - \sqrt{-1} \frac{\partial}{\partial y^p}$. Note that

$$\frac{2}{\sqrt{K}} \sum_{p,q} \left| G^{i\overline{j}} \partial_{\overline{j}} (e_a^p \overline{e_a^q}) \partial_{y^p} \partial_i (u - \underline{u}) \partial_{\overline{q}} (u - \underline{u}) \right| \\
\leq 2 \sum_{p,q} \left[G^{i\overline{j}} \partial_i \partial_{y^p} (u - \underline{u}) \partial_{\overline{j}} \partial_{y^p} (u - \underline{u}) \right]^{\frac{1}{2}} \left[G^{i\overline{j}} \partial_i (\overline{e_a^p} e_a^q) \partial_{\overline{j}} (e_a^p \overline{e_a^q}) \right]^{\frac{1}{2}} \\
\leq \frac{1}{\sqrt{K}} \sum_i G^{i\overline{j}} \partial_i \partial_{y^p} (u - \underline{u}) \partial_{\overline{j}} \partial_{y^p} (u - \underline{u}) + C\sqrt{K} \sum_{i=1}^n G^{i\overline{i}}.$$

Substituting (4.18) and (4.19) into (4.17), dropping the second term on the right side of the inequality (4.17), we can obtain

$$\frac{1}{\sqrt{K}}G^{i\overline{j}}\partial_{i}\partial_{\overline{j}}|\nabla_{a}(u-\underline{u})|^{2} \geq \frac{1}{2\sqrt{K}}G^{i\overline{j}}\chi_{\overline{j}a}\chi_{\overline{a}i} - \frac{1}{\sqrt{K}}G^{i\overline{j}}\partial_{i}\partial_{y^{p}}(u-\underline{u})\partial_{\overline{j}}\partial_{y^{p}}(u-\underline{u})$$

$$(4.20) \qquad -C\sum_{i=1}^{n}G^{i\overline{i}}(1+|\lambda_{i}|) - C(1+\sqrt{K})\sum_{i=1}^{n}G^{i\overline{i}} - C.$$

By the Lemma 2.7 in [14], there exists an index r such that

$$G^{i\overline{j}}\chi_{\overline{j}a}\chi_{\overline{a}i} \ge \frac{1}{2}\sum_{i\neq r}G^{i\overline{i}}\lambda_i^2.$$

Going back to (4.20), we get

$$(4.21) \qquad \frac{1}{\sqrt{K}} G^{i\overline{j}} \partial_i \partial_{\overline{j}} |\nabla_a(u-\underline{u})|^2 \\ \geq \frac{1}{4\sqrt{K}} \sum_{i \neq r} G^{i\overline{i}} \lambda_i^2 - \frac{1}{\sqrt{K}} \sum_{p=1}^n G^{i\overline{j}} \partial_i \partial_{y^p}(u-\underline{u}) \partial_{\overline{j}} \partial_{y^p}(u-\underline{u}) \\ - C \sum_i G^{i\overline{i}} |\lambda_i| - C(1+\sqrt{K}) \sum_{i=1}^n G^{i\overline{i}} - C.$$

4.4. Mixed tangential-normal estimates. Combining with (4.6), (4.7), (4.16) and (4.21), we obtain

$$\begin{split} G^{i\overline{j}}\partial_{i}\partial_{\overline{j}}\Psi &\leq -\frac{1}{\sqrt{K}}\sum_{p=1}^{n-1}G^{i\overline{j}}\partial_{i}\partial_{y^{p}}(u-\underline{u})\partial_{\overline{j}}\partial_{y^{p}}(u-\underline{u}) - \frac{1}{4\sqrt{K}}\sum_{i\neq r}G^{i\overline{i}}\lambda_{i}^{2} \\ &\quad -\frac{\varepsilon}{4}A\sqrt{K}\left(1+\sum_{i=1}^{n}G^{i\overline{i}}\right) + B\sqrt{K}\sum_{i=1}^{n}G^{i\overline{i}} \\ &\quad +C(1+\sum_{i}G^{i\overline{i}}|\lambda_{i}|) + C(1+\sqrt{K})\sum_{p=1}^{n}G^{p\overline{p}} \\ &\leq -\frac{\varepsilon}{4}A\sqrt{K}\left(1+\sum_{i=1}^{n}G^{i\overline{i}}\right) + B\sqrt{K}\sum_{i=1}^{n}G^{i\overline{i}} + C(1+\sqrt{K})\sum_{i=1}^{n}G^{i\overline{i}} + C \\ &\quad -\frac{1}{4\sqrt{K}}\sum_{i\neq r}G^{i\overline{i}}\lambda_{i}^{2} + CG^{i\overline{i}}|\lambda_{i}|. \end{split}$$

Choosing $\frac{\varepsilon}{4}A \ge B + 2C + A_0$ with A_0 large enough, we have

$$(4.22)G^{i\overline{j}}\partial_i\partial_{\overline{j}}\Psi \leq -A_0\sqrt{K}\sum_{i=1}^n G^{i\overline{i}} - \frac{1}{4\sqrt{K}}\sum_{i\neq r}G^{i\overline{i}}\lambda_i^2 + C\sum_i G^{i\overline{i}}|\lambda_i|.$$

By [19, Corollary 2.8], for any $\varepsilon_0 > 0$, we have

(4.23)
$$\sum_{i} G^{i\overline{i}} |\lambda_{i}| \leq \varepsilon_{0} \sum_{i \neq r} G^{i\overline{i}} \lambda_{i}^{2} + C_{1} (1 + \frac{1}{\varepsilon_{0}}) \sum_{i} G^{i\overline{i}}.$$

Choosing $\varepsilon_0 = \frac{1}{4C\sqrt{K}}$ and substituting the above inequality into (4.22), choosing A_0 sufficiently large results in

$$G^{ij}\partial_i\partial_{\bar{i}}\Psi \leq 0.$$

Lastly, we consider the boundary value for Ψ which consists of two pieces. First, on $\partial M \cap M_{\delta}$, if we take B large enough, we have

(4.24)
$$\Psi \ge A\sqrt{K}v + B\sqrt{K}|z|^2 - C|z|^2 \ge 0$$

Secondly, on $\partial M_{\delta} \cap M$, if we take B large enough, we have

(4.25)
$$\Psi \ge A\sqrt{K}v + B\sqrt{K}\delta^2 - C\sqrt{K} \ge 0,$$

combining (4.24) and (4.25) gives

$$\Psi \geq 0$$
 on ∂M_{δ} .

Then, applying the maximum principle, we get

$$\Psi \geq 0$$
 in M_{δ} .

Note that $\Psi(0) = 0$, it yields

$$\partial_{x^n} \Psi(0) \ge 0.$$

It follows that

$$0 \le A\sqrt{K}\partial_{x^n}v(0) - (\partial_{x^n}\frac{\rho_{t^{\alpha}}}{\rho_{x^n}})(0)\partial_{x^n}(u-\underline{u})(0) + \partial_{x^n}\partial_{t^{\alpha}}(u-\underline{u}).$$

Since $|\partial_{x^n} v| \leq C$ on ∂M , we conclude

$$\partial_{x^n} \partial_{t^\alpha} u(0) \ge -C\sqrt{K}.$$

We can apply the same argument to the function

$$\widetilde{\Psi} := A\sqrt{K}v + B\sqrt{K}|z|^2 - \frac{1}{\sqrt{K}}\sum_{i=1}^n \left[\partial_{y^i}(u-\underline{u})\right]^2 - \frac{1}{\sqrt{K}}\sum_{i=1}^{n-1} |\nabla_i(u-\underline{u})|^2$$
(4.26) $-T_{\alpha}(u-\underline{u}).$

It follows that

$$\partial_{x^n} \partial_{t^\alpha} u(0) \le C\sqrt{K}.$$

Thus,

$$\chi_{\alpha'\overline{n}}|(0) \le C\sqrt{K} \quad \forall \alpha' \in \{1, 2, \cdots, n-1\}.$$

5. Boundary double normal estimate

For $p \in \partial M$, we choose coordinates $z = (z^1, ..., z^n)$ such that z(p) = 0 and $g_{i\overline{j}} = \delta_{ij}$. We denote $z^i = x^i + \sqrt{-1}y^i$ and rotate the coordinates such that $\frac{\partial}{\partial x^n}$ is the unit inner normal vector at p. Then, we perform an orthogonal change of coordinates in the tangential directions to arrange that

$$\chi_{i\overline{j}} = (\chi_0)_{i\overline{j}} + u_{i\overline{j}} = \lambda'_i \delta_{ij} \quad \text{for} \quad 1 \le i, j \le n-1.$$

Since $\chi \in \Gamma_{k-1}(M)$, we have

$$\chi_{n\overline{n}} + \sum_{i=1}^{n-1} \lambda'_i \ge 0,$$

which implies

$$\chi_{n\overline{n}} \ge -C.$$

Thus, it remains to estimate $\chi_{n\overline{n}}$ from above. We give the following lemma before starting the estimate.

Lemma 5.1. Let $A = (a_{i\bar{j}})$ be a $n \times n$ Hermitian matrix and $A' = (a_{i\bar{j}})_{1 \leq i,j \leq n-1}$ be the $(n-1) \times (n-1)$ Hermitian matrix. Suppose that $\lambda_1(A) \leq \cdots \leq \lambda_n(A)$ are the eigenvalues of A and $\lambda'_1(A') \leq \cdots \leq \lambda'_{n-1}(A')$ are the eigenvalues of A'. Then we have

(5.1)
$$\lambda_j(A) \le \lambda'_j(A') \le \lambda_{j+1}(A), \quad 1 \le j \le n-1,$$

and

(5.2)
$$\begin{cases} \lambda_j(A) = \lambda'_j(A') + o(1), & 1 \le j \le n-1, \\ a_{n\bar{n}} \le \lambda_n(A) \le a_{n\bar{n}} \left(1 + O(\frac{1}{a_{n\bar{n}}})\right). \\ 24 \end{cases}$$

as $|a_{n\bar{n}}| \to +\infty$.

Proof. (5.1) can be obtained by the Cauchy's interlace inequality (see for example [23]) and (5.2) is follows from [3, Lemma 1.2] \Box

We set

$$\Gamma_{\infty} := \{ (\lambda_1, \cdots, \lambda_{n-1}) \mid ((\lambda_1, \cdots, \lambda_{n-1}, \lambda_n) \in \Gamma_{k-1} \text{ for some } \lambda_n) \},\$$

and

$$f(\lambda(z)) := \frac{\sigma_k(\lambda(z))}{\sigma_{k-1}(\lambda(z))} - \sum_{l=0}^{k-1} \beta_l(z) \frac{\sigma_l(\lambda(z))}{\sigma_{k-1}(\lambda(z))}$$

for any continuous function λ . For any $(n-1) \times (n-1)$ Hermitian matrix E with $\lambda'(E) \in \Gamma_{\infty}$, we define

$$\widetilde{G}(E) = f_{\infty}(\lambda'(E)) := \lim_{\lambda_n \to \infty} f(\lambda'_1(E), \cdots, \lambda'_{n-1}(E), \lambda_n).$$

The upper bound estimate of $\chi_{n\overline{n}}$. For simplicity, we denote by $\lambda = \lambda(\chi_u(z))$ and $\lambda' = \lambda((\chi'_u(z)))$, where $\chi'_u(z) = ((\chi_u)_{i\overline{j}})_{1 \le i,j \le n-1}$. The proof is devided into two claims:

Claim 1:

(5.3)
$$P_{\infty} := \min_{z \in \partial M} \left(\widetilde{G}(\chi'_u(z)) - \beta(z) \right) > c_0$$

for some uniform constant c_0 .

We assume that $P_{\infty} = \widetilde{G}(\chi'_u(z_0)) - \beta(z_0)$ at point $z_0 \in \partial M$. Since $\lambda(\chi_u) \in \Gamma_{k-1}$ and $\sigma_k(\lambda) = \lambda_n \sigma_{k-1}(\lambda \mid i) + \sigma_k(\lambda \mid i)$, then

$$\widetilde{G}(\chi'_u(z)) = \frac{\sigma_{k-1}}{\sigma_{k-2}}(\lambda'_1, \cdots, \lambda'_{n-1}) - \sum_{l=1}^{k-2} \beta_l(z) \frac{\sigma_{l-1}}{\sigma_{k-2}}(\lambda'_1, \cdots, \lambda'_{n-1}).$$

Denote $\widetilde{G}_0^{i\overline{j}} := \frac{\partial \widetilde{G}}{\partial(\chi'_u)_{i\overline{j}}}(\chi'_u(z_0))$ for $1 \le i, j \le n-1$. By the concavity of G and \widetilde{G} , we have

$$\begin{split} \widetilde{G}_{0}^{i\overline{j}}((\chi'_{u})_{i\overline{j}}(z) - (\chi'_{u})_{i\overline{j}}(z_{0})) \\ &= \left(\frac{\sigma_{k-1}}{\sigma_{k-2}}\right)^{i\overline{j}}|_{z_{0}}((\chi'_{u})_{i\overline{j}}(z) - (\chi'_{u})_{i\overline{j}}(z_{0})) + \sum_{l=1}^{k-2}\beta_{l}(z_{0})\left(-\frac{\sigma_{l-1}}{\sigma_{k-2}}\right)^{i\overline{j}}((\chi'_{u})_{i\overline{j}}(z) - (\chi'_{u})_{i\overline{j}}(z_{0})) \\ &\geq \frac{\sigma_{k-1}}{\sigma_{k-2}}(\chi'_{u}(z)) - \frac{\sigma_{k-1}}{\sigma_{k-2}}(\chi'_{u}(z_{0})) + \sum_{l=1}^{k-2}\beta_{l}(z_{0})\left(-\frac{\sigma_{l-1}}{\sigma_{k-2}}(\chi'_{u}(z)) + \frac{\sigma_{l-1}}{\sigma_{k-2}}(\chi'_{u}(z_{0}))\right) \\ &\geq \widetilde{G}(\chi'_{u}(z)) - \widetilde{G}(\chi'_{u}(z_{0})) - C\sum_{l=1}^{k-2}|\beta_{l}|_{C^{1}}|z - z_{0}|, \end{split}$$

and

(5.4)

$$\widetilde{G}_{0}^{i\overline{j}}(\chi'_{u})_{i\overline{j}}(z) - \beta(z) - \widetilde{G}_{0}^{i\overline{j}}(\chi'_{u})_{i\overline{j}}(z_{0}) + \beta(z_{0}) \\
\geq \widetilde{G}(\chi'_{u}(z)) - \beta(z) - c_{0} - C\sum_{l=1}^{k-2} |\beta_{l}|_{C^{1}} |z - z_{0}| \\
\geq -C\sum_{l=1}^{k-2} |\beta_{l}|_{C^{1}} |z - z_{0}|.$$

Note that

(5.5)
$$c_{\infty} := \min_{z \in \partial M} \left(\widetilde{G}(\chi'_{\underline{u}}(z)) - G(\chi_{\underline{u}}(z)) \right) > 0.$$

Using (4.4), we have

$$(\chi_u)_{i\overline{j}}(z_0) = (\chi_{\underline{u}})_{i\overline{j}}(z_0) - \partial_{x^n}(u - \underline{u})(z_0)\zeta_{i\overline{j}}(z_0)$$

for any $1 \le i, j \le n - 1$. Then

$$(5.6) \partial_{x^{n}}(u-\underline{u})(z_{0}) \sum_{i,j=1}^{n-1} \zeta_{i\overline{j}}(z_{0}) \widetilde{G}_{0}^{i\overline{j}}(z_{0}) = \widetilde{G}_{0}^{i\overline{j}} \left((\chi_{\underline{u}}')_{i\overline{j}}(z_{0}) - (\chi_{u}')_{i\overline{j}}(z_{0}) \right)$$

$$\geq \widetilde{G}(\chi_{\underline{u}}(z_{0})) - \widetilde{G}(\chi_{u}(z_{0}))$$

$$= \widetilde{G}(\chi_{\underline{u}}(z_{0})) - \beta(z_{0}) - c_{0}$$

$$\geq \widetilde{G}(\chi_{\underline{u}}(z_{0})) - G(\chi_{\underline{u}}(z_{0})) - c_{0}$$

$$\geq c_{\infty} - c_{0}.$$

Consequently, if $\partial_{x^n}(u-\underline{u})(z_0)\sum_{i,j=1}^{n-1}\zeta_{i\overline{j}}(z_0)\widetilde{G}_0^{i\overline{j}}(z_0) \leq \frac{c_\infty}{2}$, then $c_0 \geq \frac{c_\infty}{2}$ and we are done.

Suppose now that

$$\partial_{x^n}(u-\underline{u})(z_0)\sum_{i,j=1}^{n-1}\zeta_{i\overline{j}}(z_0)\widetilde{G}_0^{i\overline{j}}(z_0) \ge \frac{c_\infty}{2}.$$

Let $\eta(z) = \sum_{i,j=1}^{n-1} \zeta_{i\bar{j}}(z) \widetilde{G}_0^{i\bar{j}}(z)$. Note that

$$\eta(z_0) \ge \frac{c_{\infty}}{2\partial_{x^n}(u - \underline{u})(z_0)} \ge 2\epsilon_1 c_{\infty}$$

for some uniform $\epsilon_1 > 0$ since (3.1). We may assume that

$$\eta \ge \epsilon_1 c_{\infty} \quad on \ \bar{M}_{\delta}(z_0)$$

by requiring δ small, where $M_{\delta}(z_0) := \{z \in M \mid \text{dist}_{g_0}(z, z_0) < \delta\}$. We consider the function

$$\Phi(z) = -\partial_{x^{n}}(u-\underline{u})(z) + \frac{1}{\eta(z)} \sum_{i,j=1}^{n-1} \widetilde{G}_{0}^{i\overline{j}} \left((\chi'_{\underline{u}})_{i\overline{j}}(z) - (\chi'_{u})_{i\overline{j}}(z_{0}) \right) - \frac{\beta(z) - \beta(z_{0})}{\eta(z)} + \frac{C}{\eta(z)} \sum_{l=1}^{k-2} |\beta_{l}|_{C^{1}} |z-z_{0}|.$$

We deduce from (5.4) and the fact $(\chi_u)_{i\bar{j}}(z) = (\chi_{\underline{u}})_{i\bar{j}}(z) - \partial_{x^n}(u - \underline{u})(z)\zeta_{i\bar{j}}(z)$ on $\partial M \cap \overline{M}_{\delta}(z_0)$ that

$$\Phi(z_0) = 0, \quad \Phi(z) \ge 0 \quad \forall z \in \partial M \cap M_{\delta}(z_0),$$

while by (4.7) and (4.13),

$$G^{i\bar{j}}\Phi_{i\bar{j}} \leq C\sqrt{K}(1+\sum_{i}G^{i\bar{i}}) + C\sum_{i}G^{i\bar{i}}|\lambda_{i}(\chi_{u})|^{2}).$$

Consider the function Ψ defined in (4.26), it follows from (4.6), (4.7), (4.16), (4.21) and (4.22) that

$$\begin{cases} G^{ij}(\Phi + \widetilde{\Psi})_{i\overline{j}} \leq 0, & in \ M_{\delta}(z_0), \\ \Phi + \widetilde{\Psi} \geq 0 & on \ \partial M_{\delta}(z_0). \end{cases}$$

The maximum principle yields that $\Phi + \widetilde{\Psi} \geq 0$ in $\partial M_{\delta}(z_0)$, and then $\partial_{x_n} \Phi(z_0) = -\phi_{\nu}(z_0) \geq \widetilde{\Psi}_{\nu}(z_0)$. This, together with the difinition of Φ , yields that

$$\partial_{x^n} \partial_{x^n} u(z_0) \le CK.$$

Since

$$u_{\bar{n}n} = \frac{1}{4} \left(\frac{\partial}{\partial x^n} + \sqrt{-1}\frac{\partial}{\partial y^n}\right) \left(\frac{\partial}{\partial x^n} - \sqrt{-1}\frac{\partial}{\partial y^n}\right) u,$$

it follows that $\lambda(\chi_u)(z_0)$ is contained in a compact subset of Γ . Therefore

$$P_{\infty} \ge f(\lambda'(\chi'_u)(z_0), R) - \beta(z_0) > 0$$

for R sufficiently large since $f_i > 0$, which yields (5.3).

Claim 2: There holds

(5.7)
$$\chi_{n\overline{n}}(z) \le CK \quad z \in \partial M$$

for some constant C.

Let $z \in \partial M$, we suppose that $\lambda_1 \leq \cdots \leq \lambda_n$ and $\lambda'_1 \leq \cdots \leq \lambda'_{n-1}$. From the boundary tangential-tangential and tangential-normal estimates, it follows that $\lambda'(\chi'_u)$ lies in a compact set $L \subset \Gamma_{\infty}$. Combining with (5.3), we know that there exist uniform positive constant c_0 and R_0 depending on the range of $\lambda'(\chi'_u)$ such that for any $R > R_0$

$$f(\lambda', R) > \sup_{\substack{M \\ 27}} \beta + c_0,$$

which implies

(5.8)
$$f(\widetilde{\lambda}, R) > \sup_{M} \beta + \frac{c_0}{2}$$

for any $\widetilde{\lambda} \in U_L$ and $R > R_0$, where U_L is the neighborhood of L.

Assuming that there exists a constant $R_1 > R_0$ such that $\chi_{n\bar{n}}(z) \ge R_1$. According to (5.1) and (5.2), it is easy to see that

 $\lambda_n \ge \chi_{n\bar{n}}(z) \ge R_0, \quad \lambda_j \in U_L, \quad 1 \le j \le n-1.$

Combining with (5.8), we know that $G(\chi_u(z)) = f(\lambda) > \beta(z) + \frac{c_0}{2}$, This contradicts with the equation (2.9), and hence (5.7) holds.

Combining this with the second order interior estimate, i.e., Theorem 3.2, we have

Theorem 5.1. Let $u \in C^{\infty}(\overline{M})$ be an (k-1)-admissible solution for equation (1.1). Under the assumptions mentioned in Theorem 1.1, then there exists a positive constant C depending only on $(M, \omega), \chi_0, \alpha_l, \varphi$ and the subsolution \underline{u} such that

$$\sup_{\bar{M}} |\sqrt{-1}\partial\bar{\partial}u| \le CK,$$

where $K := 1 + \sup_M |\nabla u|^2$.

6. Gradient estimates

In this section, we combine the second derivative estimate with a blow-up argument and Liouville type theorem due to Dinew-Kolodziej [12] to obtain gradient estimates.

Theorem 6.1. Let $u \in C^{\infty}(\overline{M})$ be an (k-1)-admissible solution for equation (1.1). Under the assumptions mentioned in Theorem 1.1, then there exists a positive constant C depending only on $(M, \omega), \chi_0, \alpha_l, \varphi$ and the subsolution \underline{u} such that

$$\sup_{M} |\nabla u| \le C.$$

Proof. Suppose that there exists a sequence of function $u_m \in C^4(\overline{M})$ to the equation (1.1) such that

$$N_m = \sup_M |\nabla u_m| \to +\infty \quad \text{as } m \to +\infty.$$

Hence

(6.1)
$$\chi_{u_m}^k \wedge \omega^{n-k} = \sum_{l=0}^{k-1} \alpha_l(z) \chi_{u_m}^l \wedge \omega^{n-l}, \quad u = \varphi \text{ on } \partial M.$$

For any m, we assume that $|\nabla u_m|$ attains its maximum vulue at $z_m \in M$. Then, after passing a subsequence we may assume that $z_m \to z'$ for some point $z' \in \overline{M}$. By Theorem 5.1 we have

(6.2)
$$\sup_{M} |\sqrt{-1}\partial \bar{\partial} u_{m}| \leq C(1+N_{m}^{2}),$$

where the constant independs of m. we divide our proof into two cases separately.

Case 1: $z' \in M$.

Choosing a small coordinate ball centered at z', which we identify with an open set in \mathbb{C}^n with coordinates (z^1, \dots, z^n) , and such that $\omega(0) = \omega_0 = \frac{\sqrt{-1}}{2} \delta_{ij} dz^i \wedge d\bar{z}^j$. We can assume that all z_m are within this coordinate ball. Let R > 0, we define

$$v_m(z) := u_m(\frac{z}{N_m} + z_m), \quad \forall z \in B_R(0),$$

which is well-defined for any m such that N_m is large enough. Clearly,

$$|\nabla v_m(0)| = 1, \quad |v_m|_{C^2(B_R(0))} \le C.$$

Let $R \to +\infty$ and taking a diagonal subsequence again, we can assume that $v_m \to v$ in $C_{\text{loc}}^{1,\frac{\gamma}{2}}(\mathbb{C}^n)$ with $\nabla v(0) = 1$. Then we have from (6.1)

$$\left[\chi_0(\frac{z}{N_m} + z_m) + N_m^2 \frac{\sqrt{-1}}{2} \partial \bar{\partial} v_m \right]^k \wedge \left[\omega(\frac{z}{N_m} + z_m) \right]^{n-k}$$

$$= \sum_{l=0}^{k-1} \alpha_l(\frac{z}{N_m} + z_m) \left[\chi_0(\frac{z}{N_m} + z_m) + N_m^2 \frac{\sqrt{-1}}{2} \partial \bar{\partial} v_m \right]^l \wedge \left[\omega(\frac{z}{N_m} + z_m) \right]^{n-l}$$

We can take a limit of the equation and obtian

$$\left(\sqrt{-1}\partial\bar{\partial}v\right)^k \wedge \omega_0^{n-k} = 0$$

which is in the pluripotential sense. Moreover, we have for any $1 \le l \le k-1$ by a similar reasoning

$$\left(\sqrt{-1}\partial\bar{\partial}v\right)^l\wedge\omega_0^{n-l}\geq 0.$$

Combining with the result of Blocki [2], we know that v is a maximal k-subharmonic function in \mathbb{C}^n . Then the Liouville thereom in [12] implies that v is a constant, which contradicts the fact $\nabla v(0) = 1$.

Case 2: $z' \in \partial M$.

Let $\Omega \subset M$ be a coordinate chart centered at z'. Then there exists a smooth function $\rho: B_{2s} \to \mathbb{R}$ such that

$$\partial M \cap \Omega = \{ \rho = 0 \}, \quad M \cap \Omega \subset \{ \rho \le 0 \}.$$

Where $B_{2s} \subset \mathbb{C}^{2n}$ is the ball of radius 2s at 0 = z'. Without loss of generality, we may assume $z_m \in \Omega$ with $|z_m| < s$ in local coordinates and

$$r_m := \operatorname{dist}(z_m, \partial M \cap \Omega) = |z_m - y_m|$$

for a unique point $y_m \in \partial M \cap \Omega$. Clearly, $y_m \to z$ as $m \to +\infty$. Set

$$v_m(z) := u_m(\frac{z}{N_m} + z_m), \quad z \in \Omega_m,$$

where $\Omega_m := \{ z \in \Omega \mid \frac{z}{M_m} + z_m \in B_{2s} \cap \{ \rho \le 0 \} \}.$ Therefore

$$|\nabla v_m(0)| = 1, \quad |u_m|_{C^2(\Omega_m)} \le C$$

Let $\rho_m := \rho(\frac{z}{N_m} + z_m)$, then $B_{sN_m} \cap \{\rho_m \leq 0\} \subset \Omega_i$ since $|z_m| < s$. By the standard elliptic theory, we know that

(6.3)
$$|v_m|_{C^{2,\gamma}\left(B_{\underline{sNm}}\cap\{\rho_m\leq 0\}\right)} \leq C.$$

Then we divide the proof into the following two sub-cases Case 2.1

$$\liminf_{m \to \infty} N_m r_m = +\infty.$$

After passing to a subsequence v_m converges in $C^{2,\gamma}$ on compact sets to $v \in C^{2,\gamma}(\mathbb{C}^n)$ since $N_m r_m \to \infty$ as $m \to \infty$. Similar to Case 1, we know that v is a constant, which contradicts the fact $\nabla v(0) = 1$.

Case 2.2

$$\liminf_{m \to \infty} N_m r_m = L \in [0, \infty).$$

The proof for Case 2.2 is quite similar to that given for Case 2b in [11, Proposition 6.1], and so they are omitted. $\hfill \Box$

Last we apply the standard continuity method to solve the Dirichlet problem 1.1.

Proof of Theorem 1.1. For any $t \in [0, 1]$, we consider the equation

(6.4)
$$\begin{cases} G(\chi_{u_t}) = t\beta + (1-t)G(\chi_{\underline{u}}), & \text{in } \bar{M}, \\ u_t = \varphi & \text{on } \partial M, \end{cases}$$

where

$$G(\chi_{u_t}) = \frac{\sigma_k(\chi_{u_t})}{\sigma_{k-1}(\chi_{u_t})} - \sum_{l=0}^{k-2} \beta_l(z) \frac{\sigma_l(\chi_{u_t})}{\sigma_{k-1}(\chi_{u_t})}$$

Set

$$\mathbf{S} = \{ t \in [0,1] \mid \text{there exists } u_t \in C^{4,\alpha}(\bar{M}) \text{ with } \lambda(\chi_{u_t}) \in \Gamma_{k-1} \ solving(6.4) \}.$$

Clearly the set **S** is non-empty since \underline{u} solve the equation (6.4) for t = 0. On the one hand, by the generalized Newton-MacLaurin inequality, we have

$$\sigma_{k-1}(\chi_{u_t}) \ge C,$$

which implies that the equation (6.4) is uniformly elliptic. Therefore **S** is an open set by the implicit function theorem.

On the other hand, let u_{t_i} be the solution of (6.4) for $t_i \in [0,1]$ with $t_i \to t_0$. From (3.1), theorem 3.1, 5.1 and 6.1, we know that

$$|u_{t_i}|_{C^2(M)} \le C$$

for some uniformly constants. Then, higher-order estimates follow from the Evan-Krylov theorem and the Schauder estimate, i.e.,

$$|u_{t_i}|_{C^{4,\alpha}(M)} \le C.$$

We can take convergent subsequence to a limiting function $\tilde{u} \in C^{4,\alpha}$ which solves the equation (6.4) for t_0 . Hence **S** is also closed and we complete the proof of Theorem 1.1.
