# MIN-MAX MINIMAL HYPERSURFACES WITH HIGHER MULTIPLICITY 

ZHICHAO WANG AND XIN ZHOU


#### Abstract

We exhibit the first set of examples of non-bumpy metrics on the $(n+1)$-sphere $(2 \leq n \leq 6)$ in which the varifold associated with the two-parameter min-max construction must be a multiplicity-two minimal $n$-sphere. This is proved by a new area-and-separation estimate for certain minimal hypersurfaces with Morse index two inspired by an early work of Colding-Minicozzi. We also construct non-bumpy projective spaces in which the first minmax hypersurfaces are one-sided, and non-bumpy balls in which the free boundary min-max hypersurfaces are improper.


## 1. Introduction

In the past decade, we have witnessed many important advancement in the development for minimal hypersurfaces, including the solution of Yau conjecture on minimal surfaces by MarquesNeves [20], and Song [30], and the establishment of a Morse theory for the area functional by Marques-Neves [19, 21]. One key challenge in these works is the a priori existence of integer multiplicity of the varifolds produced by the Almgren-Pitts min-max theory [1,2,22] (see also [4, 6]). Now we have very well understanding of the multiplicity when the ambient manifold has a bumpy metric ([35]) thanks to the solution of the Multiplicity One Conjecture [38]; (see also [3]). For non-bumpy metrics, there are known trivial examples where some min-max varifolds have higher multiplicities, while some others have multiplicity one. For instance, on a thin and long flat torus, the min-max varifold can be two identical copies of the cross section, but one can move one copy parallelly away to obtain a multiplicity one varifold of the same mass. This made it tempting to conjecture that for any metric there always exists a min-max varifold of multiplicity one. However, in this paper, we will disprove this conjecture by constructing the first set of nontrivial and non-bumpy examples, where the varifold associated with the two-parameter min-max construction must have multiplicity two.
Theorem 1.1. The $(n+1)$-sphere $S^{n+1}$ of dimension $3 \leq(n+1) \leq 7$ admits metrics $g$ with nonnegative Ricci curvature so that the second volume spectrum $\omega_{2}\left(S^{n+1}, g\right)$ can only be achieved by a degenerate minimal $n$-sphere with multiplicity 2.

Here $\left\{\omega_{k}\right\}$ is the volume spectrum of $M$ defined by Gromov [9, Guth [11, and Marques-Neves [17] as a sequence of non-decreasing positive numbers

$$
0<\omega_{1}(M, g) \leq \omega_{2}(M, g) \leq \cdots \leq \omega_{k}(M, g) \rightarrow \infty
$$

depending only on $M$ and $g$; see also [16] [8] [33] for further studies.
Our proof relies on a new area comparison argument. Roughly speaking, we show that if a connected multiplicity-one minimal hypersurface $\Sigma$ is sufficiently close to a multiplicitytwo degenerate stable hypersurface $S_{0}^{n}$, then the area of $\Sigma$ is strictly greater than that of $S_{0}^{n}$. Similar area comparison arguments have played essential roles in the study of Morse index and
multiplicity of min-max minimal hypersurfaces (see [14, 18, 36, 37]), but in a reserve way. In particular, the catenoid estimates by Ketover-Marques-Neves 14 imply that if $S_{0}^{n}$ is unstable, then by pushing away the two copies of $S_{0}^{n}$ and then adding a catenoid type neck therein, one can strictly decrease the area. More precisely, the area-decrease by pushing away the two copies of $S_{0}^{n}$ dominates the area-increase by adding the catenoid neck, when $S_{0}^{n}$ is unstable. This idea has been further extended by Haslhofer-Ketover [13] (see also [7]) to construct the second minimal 2-sphere in $S^{3}$ with a bumpy metric associated with the second width. In our situation, we will show the reverse phenomenon when $S_{0}^{n}$ is degenerate stable. A crucial ingredient is to bound the area difference between $\Sigma$ and $2 S_{0}^{n}$ away from the neck region. To do so, we need a new distance-separation estimate between $\Sigma$ and $S_{0}^{n}$ in terms of the size of the neck region; see Theorem 4.6 and 4.9. This part is inspired by an early work of Colding-Minicozzi [5; see the part on idea of proof for more details.

The Multiplicity One Theorem also implies that for bumpy metrics, the min-max minimal hypersurfaces can only be two-sided. However, our method can also be used to construct nonbumpy metrics on the projective spaces in which the first width must be achieved by one-sided hypersurfaces.

Corollary 1.2. The $(n+1)$-projective space $\mathbb{R}^{n+1}$ with $3 \leq(n+1) \leq 7$ admits metrics $g$ so that the first volume spectrum $\omega_{1}\left(\mathbb{R}^{\mathbb{P}^{n+1}}, g\right)$ can only be achieved by a one-sided $\mathbb{R}^{n}$ with multiplicity 2.

In [15, Li-Zhou developed a free boundary min-max theory for compact manifolds with boundary $(M, \partial M)$. The minimal hypersurface $\Sigma$ constructed therein may not be properly embedded, i.e. it may have interior touching with the boundary $\operatorname{int}(\Sigma) \cap \partial M \neq \emptyset$. The touching phenomenon had caused major challenges in the application of this theory, e.g. [10,31,34. It has been conjectured that the touching could happen even for Euclidean domains [15, Conjecture 1.5]. Here we exhibit examples where the touching phenomenon does happen.

Corollary 1.3. $B^{n+1}$ admits a metric with minimal boundary and non-negative Ricci curvature so that its first volume spectrum can only be achieved by its boundary with multiplicity one.

Proof. Let $\left(S^{n+1}, g\right)$ be as in Theorem [1.1. Then the round $S_{0}^{n}$ divides the $(n+1)$-sphere into two connected components, denoted by $M_{+}$and $M_{-}$; see Section 3 for explicit description. Note that $\left(M_{+}, g\right)$ is an $(n+1)$-ball that has positive Ricci curvature away from its boundary. By [31, $\omega_{1}\left(M_{+}, g\right)$ is realized by a free boundary minimal hypersurface $\Sigma$ with multiplicity one, whose index is bounded by one from above. Then by reflection along $S_{0}^{n}$, one can obtain a smoothly embedded minimal hypersurface $\widetilde{\Sigma} \subset\left(S^{n+1}, g\right)$ with index less than or equal to 2 . Clearly, $\omega_{1}\left(M_{+}, g\right) \leq \operatorname{Area}\left(S_{0}^{n}\right)$. It follows that

$$
\operatorname{Area}(\widetilde{\Sigma}) \leq 2 \operatorname{Area}\left(S_{0}^{n}\right)
$$

Then by Theorem [1.1, $\widetilde{\Sigma}$ can only be the $S_{0}^{n}$ with multiplicity two, which implies that $\Sigma$ is the boundary of $M_{+}$.
Idea of the proof. We construct a sequence of Riemannian $(n+1)$-spheres $M_{k}$ (isometrically embedded in $\mathbb{R}^{n+2}$ ) that converges locally smoothly to $S_{0}^{n} \times \mathbb{R}$ (see Section 3 for details), where $S_{0}^{n}$ is a round $n$-sphere in $\mathbb{R}^{n+1}$ and embedded in $M_{k}$ as the unique degenerate stable minimal hypersurface for each $k$. Moreover, for each $k$, the level sets (denoted by $\left\{S_{t}\right\}$ ) of the distance function to $S_{0}^{n}$ have area lower bound $\Omega_{n}\left(1-|t|^{n+1}\right)$, where $\Omega_{n}$ is the volume of the unit $n$-sphere.

Suppose on the contrary that each $\omega_{2}\left(M_{k}\right)$ is realized by a minimal hypersurface $\Sigma_{k}$ that is not $S_{0}^{n}$. Then by our construction, $\Sigma_{k}$ has to be connected, unstable, of index less than or equal to 2 (by [19]) and multiplicity one ([38]). Then the compactness [27] gives that $\Sigma_{k}$ converges locally smoothly to an embedded minimal hypersurface with integer multiplicity in $S_{0}^{n} \times \mathbb{R}$. By the lower bounds for $\omega_{2}(M)$, the limit of $\Sigma_{k}$ is exactly $S_{0}^{n}$ with multiplicity 2 . Moreover, by the classification of embedded minimal hypersurfaces with two ends ([26]), after suitable scaling, the blowup around each singular point is a standard catenoid. Let $r_{k}$ denote the "radius" of link of the small catenoid in $\Sigma_{k}$, i.e. the distance of the small catenoid to the center point. First, the Hausdorff distance between $\Sigma_{k}$ and $S_{0}^{n}$ is bounded from above by $10 r_{k}\left|\log r_{k}\right|$ (to be discussed next). After replacing the annuli in neck regions of $\Sigma_{k}$ by two minimizing $n$-disks, by using the one-sided minimizing property of $\left\{S_{t}\right\}$, the area of the new hypersurface is at least $2\left|S_{0}^{n}\right|-\mathcal{O}\left(r_{k}^{n+1}\left|\log r_{k}\right|^{n+1}\right)$; see (3.4). On the other hand, the neck regions of $\Sigma_{k}$ contribute at least $c(n) r_{k}^{n}$ amount of area more than that of the $n$-disks; see (3.2). Therefore, $\left|\Sigma_{k}\right|-2\left|S_{0}^{n}\right| \geq c(n) r_{k}^{n}-\mathcal{O}\left(r_{k}^{n+1}\left|\log r_{k}\right|^{n+1}\right)>0$, contradicting $\omega_{2}\left(M_{k}\right) \leq 2 \omega_{1}\left(M_{1}\right) \leq 2 \operatorname{Area}\left(S_{0}^{n}\right)$.

To bound the Hausdorff distance $d_{H}\left(\Sigma_{k}, S_{0}^{n}\right)$, the key challenge arises from intermediate annuli regions $A\left(y_{k}, R_{k}, \epsilon ; M_{k}\right)$, where $y_{k}$ is a singular point, $R_{k} / r_{k} \nearrow \infty, R_{k} \searrow 0$. In fact, $\Sigma_{k}$ is close in smooth topology to the catenoid of radius $r_{k}$ inside $B\left(y_{k}, R_{k} ; M_{k}\right)$ and to $2 S_{0}^{n}$ outside $B\left(y_{k}, \epsilon ; M_{k}\right)$ by smooth convergence. However, $\Sigma_{k}$ may not be a 2 -sheeted graph over $S_{0}^{n}$ inside $A\left(y_{k}, R_{k}, \epsilon ; M_{k}\right.$ ), and we are forced to write one component $\Sigma_{k}^{2}$ (of $\Sigma_{k}$ ) as a graph over the other $\Sigma_{k}^{1}$. First, $d_{H}\left(\Sigma_{k}^{1}, \Sigma_{k}^{2}\right)$ when restricted to $\partial B\left(y_{k}, R_{k} ; M_{k}\right)$ is at most $3 r_{k} \log \frac{R_{k}}{r_{k}}$; see (4.19). We need to prove that this bound keeps roughly at the order $r_{k} \log \frac{s}{r_{k}}$ on $\partial B\left(y_{k}, s ; M_{k}\right)$ when $s \nearrow \epsilon$. Our proof relies on several new monotonicity formulas inspired by Colding-Minicozzi [5]. In particular, we study carefully the evolution of the averages of the height function $w_{k}$ (between $\left.\Sigma_{k}^{1}, \Sigma_{k}^{2}\right): s \mapsto f_{\Sigma_{k}^{1} \cap \partial B\left(y_{k}, s ; M_{k}\right)} w_{k}$; see Proposition 4.4 and compare with [5, Lemma 2.1]. The main new challenge as compared with [5] is that $w_{k}$ is not a graph function over a fixed hypersurface, and this causes many higher-order terms in our monotonicity formulas, particularly as the height function $w_{k}$ only satisfies a highly nonlinear PD-inequality (4.6). Note that some extra care is needed when the two singular points are not too far from each other; see Proposition 4.5.

Outline. In Section 2, we will classify the limit cones of the singular set arising from the compactness of minimal hypersurfaces. In Section 3, we describe the concrete constructions and prove our main results by assuming the key Hausdorff distance upper bound estimates, which will be proved in Section 4. Finally in Appendix A, we derive a general inequality for minimal graphs over another minimal hypersurface. Then we list some basic results of catenoids in Appendix B

## 2. Blowing-up analysis

Let $\left\{M_{k}\right\}$ be a sequence of $(n+1)$-spheres embedded in $\mathbb{R}^{n+2}=\mathbb{R}^{n+1} \times \mathbb{R}$. Denote by $S_{0}^{n}$ the unit sphere in $\mathbb{R}^{n+1}$. Let $\Sigma_{k}$ be a closed embedded connected minimal hypersurface in $M_{k}$. We use $B_{r}(p)$ and $B\left(p, r ; M_{k}\right)$ to denote the geodesic ball in $\mathbb{R}^{n+1}$ and $M_{k}$, respectively. In this section, $M_{k}$ and $\Sigma_{k}$ always satisfy the following requirements.
(1) For each $k, S_{0}^{n}$ is a stable minimal hypersurface in $M_{k}$ with constant Jacobi fields;
(2) $M_{k}$ locally smoothly converges to $S_{0}^{n} \times \mathbb{R}$ in $\mathbb{R}^{n+2}$ as $k \rightarrow \infty$;
(3) $\Sigma_{k}$ converges to twice of $S_{0}^{n}$ in the sense of varifolds;
(4) $\Sigma_{k}$ has Morse index less than or equal to 2 .

Example 1. Let $M_{k}$ be the $(n+1)$-sphere given by

$$
x_{1}^{2}+x_{2}^{2}+\cdots+x_{n+1}^{2}+\frac{x_{n+2}^{2 n}}{k^{2 n}}=1 .
$$

Suppose that $M_{k}$ contains an embedded minimal hypersurface $\Sigma_{k}$ with index less than or equal to 2 and

$$
\operatorname{Area}\left(S_{0}^{n}\right)+\delta \leq \operatorname{Area}\left(\Sigma_{k}\right) \leq 3 \operatorname{Area}\left(S_{0}^{n}\right)-\delta
$$

for some $\delta>0$. Then $\left\{\Sigma_{k}\right\}$ and $\left\{M_{k}\right\}$ satisfy our requirements in this section.
By compactness [27], $\Sigma_{k}$ locally smoothly converges to $S_{0}^{n}$ with multiplicity two away from a set $\mathcal{W}$ consisting of one or two points. Let $p \in \mathcal{W}$. Then we can take a positive constant $\epsilon<10^{-1000}$ small enough such that the convergence for $\Sigma_{k}$ is locally smooth in $B_{2 \epsilon}(p) \backslash\{p\}$, and

$$
\begin{equation*}
\operatorname{Area}\left(B\left(p, 2 \epsilon ; M_{k}\right) \cap \Sigma_{k}\right) \leq \frac{5}{2} \cdot \frac{\Omega_{n-1}}{n}(2 \epsilon)^{n}, \tag{2.1}
\end{equation*}
$$

where $\Omega_{m}$ is the volume of unit $m$-spheres. Choose $p_{k} \in \Sigma_{k}$ so that

$$
\left|A^{\Sigma_{k}}\left(p_{k}\right)\right|=\max _{\Sigma_{k} \cap B\left(p, \epsilon ; M_{k}\right)}\left|A^{\Sigma_{k}}(x)\right| .
$$

Clearly, $\left|A^{\Sigma_{k}}\left(p_{k}\right)\right| \rightarrow \infty$ as $k \rightarrow \infty$. In the following, we classify the limit cones of $\left\{\Sigma_{k}\right\}$ at $p$, which is either a hyperplane with multiplicity or a catenoid.

Proposition 2.1 (Classification of limit cones). Let $\left\{c_{k}\right\}$ be a sequence of positive numbers with $c_{k} \rightarrow \infty$.
(1) If $\lim _{k \rightarrow \infty}\left|A^{\Sigma_{k}}\left(p_{k}\right)\right| / c_{k}=\ell>0$, then $c_{k}\left(\Sigma_{k}-p_{k}\right)$ locally smoothly converges to a catenoid contained in $\mathbb{R}^{n+1}$;
(2) If $\lim _{k \rightarrow \infty}\left|A^{\Sigma_{k}}\left(p_{k}\right)\right| / c_{k}=0$, then $c_{k}\left(\Sigma_{k}-p_{k}\right)$ locally smoothly converges to a hyperplane contained in $\mathbb{R}^{n+1}$;
(3) If $\lim _{k \rightarrow \infty}\left|A^{\Sigma_{k}}\left(p_{k}\right)\right| / c_{k}=\infty$, then $c_{k}\left(\Sigma_{k}-p_{k}\right)$ converges to a multiplicity-two hyperplane contained in $\mathbb{R}^{n+1}$. Moreover, the convergence is locally smooth away from at most two points including 0.
Proof. Note that $c_{k}\left(\Sigma_{k}-p_{k}\right)$ is always a minimal hypersurface in $c_{k}\left(M_{k}-p_{k}\right)$ with index $\leq 2$. By the monotonicity formula and (2.1),

$$
\begin{equation*}
\lim _{k \rightarrow \infty} \operatorname{Area}\left(B_{r}(0) \cap c_{k}\left(\Sigma_{k}-p_{k}\right)\right) \leq \frac{5}{2} \cdot \frac{\Omega_{n-1}}{n} r^{n} \tag{2.2}
\end{equation*}
$$

Clearly, $c_{k}\left(M_{k}-p_{k}\right)$ converges locally smoothly to $\mathbb{R}^{n+1}$. Thus $c_{k}\left(\Sigma_{k}-p_{k}\right)$ converges to an embedded minimal hypersurface with integer multiplicity in $\mathbb{R}^{n+1}$ with index $\leq 2$. By the work of Tysk [32], the limit minimal hypersurface, which has finite Morse index and polynomial volume growth (2.2), must have a unique tangent cone at infinity; therefore using the work of Schoen [26, Theorem 3] (see also [12, Theorem 1.3]), the limit minimal hypersurface is either a catenoid or a hyperplane.

If $\lim _{k \rightarrow \infty}\left|A^{\Sigma_{k}}\left(p_{k}\right)\right| / c_{k}=\ell<\infty$, then for any compact set $\Omega \subset \mathbb{R}^{n+2}, c_{k}\left(\Sigma_{k}-p_{k}\right) \cap \Omega$ has uniformly bounded second fundamental form, and this implies that the convergence is locally
smooth. When $\ell>0$, the limit hypersurface has at least one point that has non-zero curvature. Thus the limit is a catenoid. When $\ell=0$, the limit hypersurface is flat and hence is a hyperplane.

If $\lim _{k \rightarrow \infty}\left|A^{\Sigma_{k}}\left(p_{k}\right)\right| / c_{k}=\infty$, then the convergence is non-smooth. By Allard's Regularity Theorem [28, Theorem 24.2], the multiplicity of the convergence is larger than or equal to two. Thus the limit is a stable minimal hypersurface in $\mathbb{R}^{n+1}$ with polynomial (degree $n$ ) area growth, which can only be a hyperplane by Schoen-Simon [24] and Schoen-Simon-Yau [25]. Since the index of $\Sigma_{k}$ is bounded from above by 2 , the convergence is locally smooth away from at most two points. Together with (2.2), we also have that the multiplicity of the convergence is exactly 2. Hence Proposition 2.1 is proved.

Remark 2.2. Let $x_{k} \in \Sigma_{k}$ and $c_{k} \rightarrow \infty$. Then $c_{k}\left(\Sigma_{k}-x_{k}\right)$ converges to a multiplicity-one catenoid or hyperplane with multiplicity one or two in the sense of varifold. Suppose that the convergence is not locally smooth. Then the limit is a multiplicity-two hyperplane.

Denote by $r_{k, 1}=\sqrt{n(n-1)}\left|A^{\Sigma_{k}}\left(p_{k}\right)\right|^{-1}$. Take $y_{k, 1} \in \Sigma_{k}$ so that $r_{k, 1}^{-1}\left(\Sigma_{k}-y_{k, 1}\right)$ converges to a standard catenoid $\mathcal{C}$ in $\mathbb{R}^{n+1}$; see Appendix B for several properties of the geometry of $\mathcal{C}$. In the remaining of this section, we are going to find a sequence of "bad balls", in which $\Sigma_{k}$ is not flat enough even after rescaling.

So long as

$$
\max _{x \in B\left(y_{k, 1}, \epsilon ; M_{k}\right) \cap \Sigma_{k}}\left|A^{\Sigma_{k}}(x)\right|\left|x-y_{k, 1}\right|<2 \sqrt{n(n-1)}
$$

we let $y_{k, 2}:=y_{k, 1}$. Otherwise, take $y_{k, 2}^{\prime} \in \Sigma_{k}$ so that

$$
\max _{x \in B\left(y_{k}, \epsilon ; M_{k}\right) \cap \Sigma_{k}}\left|A^{\Sigma_{k}}(x)\right| x-y_{k}\left|=\left|A^{\Sigma_{k}}\left(y_{k, 2}^{\prime}\right)\right|\right| y_{k, 2}^{\prime}-y_{k, 1} \mid \geq 2 \sqrt{n(n-1)}
$$

Then by Proposition [2.1, $\left|A^{\Sigma_{k}}\left(y_{k, 2}^{\prime}\right)\right|\left(\Sigma_{k}-y_{k, 2}^{\prime}\right)$ converges locally smoothly to a catenoid in $\mathbb{R}^{n+1}$. Then we can take $y_{k, 2}$ around $y_{k, 2}^{\prime}$ and $r_{k, 2}>0$ so that $r_{k, 2}^{-1}\left(\Sigma_{k}-y_{k, 2}\right)$ converges locally smoothly to a standard catenoid. Let

$$
r_{k}=\max \left\{r_{k, 1}, r_{k, 2}\right\} .
$$

Denote by

$$
\begin{equation*}
b_{k}:=\left|y_{k, 1}-y_{k, 2}\right| . \tag{2.3}
\end{equation*}
$$

By the locally smooth convergence of $\Sigma_{k}$ in $B_{\epsilon}(p) \backslash\{p\}$, we know that

$$
b_{k} \rightarrow 0, \text { as } k \rightarrow \infty .
$$

Note that in a standard catenoid (see Appendix $\overline{\mathrm{B}}$ ), we have $|x| \cdot|A(x)| \leq \sqrt{n(n-1)}$. Therefore, we also have that

$$
b_{k} / r_{k} \rightarrow \infty, \text { if } y_{k, 1} \neq y_{k, 2} .
$$

For simplicity, denote by $A\left(p, r, s ; M_{k}\right)=B\left(p, s ; M_{k}\right) \backslash B\left(p, r ; M_{k}\right), \mathcal{W}_{k}=\left\{y_{k, 1}, y_{k, 2}\right\}$ and

$$
\begin{equation*}
d_{k}(x)=\operatorname{dist}_{M_{k}}\left(x, \mathcal{W}_{k}\right) \tag{2.4}
\end{equation*}
$$

We now claim that for all sufficiently large $k$,

$$
\begin{equation*}
\max _{x \in B\left(p, \epsilon ; M_{k}\right) \cap \Sigma_{k}}\left|A^{\Sigma_{k}}(x)\right| d_{k}(x)<2 \sqrt{n(n-1)} . \tag{2.5}
\end{equation*}
$$

Suppose not, then one can find $y_{k, 3}$ and another small cantenoid. Observe that each small catenoid will contribute index 1 . This contradicts that $\Sigma_{k}$ has index less than or equal to 2 .

From now on, let $\Sigma_{k}^{1}$ and $\Sigma_{k}^{2}$ be the two connected components of $\Sigma_{k} \backslash \cup_{j} B\left(y_{k, j}, 2 r_{k, j} ; M_{k}\right)$. Without loss of generality, outside $B\left(p, \epsilon ; M_{k}\right)$, we choose the unit normal vector field of $\Sigma_{k}^{1}$ pointing towards $\Sigma_{k}^{2}$.
Proposition 2.3. Given $\delta>0$, there exists $K>0$ such that for all $k \geq K$, the following statements hold true.
(1) The second fundamental forms satisfy for $x \in \Sigma_{k} \backslash \cup_{j=1}^{2} B\left(y_{k, j}, K r_{k, j} ; M_{k}\right)$,

$$
\begin{equation*}
d_{k} \cdot\left|A^{\Sigma_{k}}(x)\right|+d_{k}^{2} \cdot\left|\nabla A^{\Sigma_{k}}(x)\right|<\delta . \tag{2.6}
\end{equation*}
$$

Moreover, $\Sigma_{k}^{1}$ is a minimal graph over $\Sigma_{k}^{2}$. Denote by $w_{k}$ the graph function.
(2) For every $x \in \Sigma_{k}^{1} \backslash \cup_{j=1}^{2} B\left(y_{k, j}, K r_{k, j} ; M_{k}\right)$,

$$
\begin{equation*}
d_{k}^{2} \frac{\left|\nabla^{2} w_{k}\right|}{w_{k}}(x)+d_{k} \frac{\left|\nabla w_{k}\right|}{w_{k}}+\frac{w_{k}}{d_{k}}<\delta . \tag{2.7}
\end{equation*}
$$

(3) For any $s>K r_{k}$ and $x, y \in \Sigma_{k}^{1} \cap A\left(y_{k}, s, 4 s ; M_{k}\right) \backslash B\left(z_{k}, s / 4 ; M_{k}\right)$,

$$
w_{k}(x) \leq(1+\delta) w_{k}(y)
$$

Proof. Note that by Remark [2.2, the limit of $d_{k}^{-1}\left(x_{k}\right)\left(\Sigma_{k}-x_{k}\right)$ can only be a multiplicitytwo hyperplane if $d_{k}\left(x_{k}\right) / r_{k, j} \rightarrow \infty$. Then the first item follows from standard blowup and contradiction arguments. Observe the third one follows directly from the second one. Hence it suffices to prove the second item.

Suppose on the contrary that there exists $\delta>0$ and $\alpha_{k} \rightarrow \infty$ such that for a subsequence of $k \geq \alpha_{k}$, there exists $x_{k} \in \Sigma_{k} \backslash \cup_{j=1}^{2} B\left(y_{k, j}, \alpha_{k} r_{k, j} ; M_{k}\right)$ violating (2.7). So long as $\lim _{k \rightarrow \infty} d_{k}\left(x_{k}\right) \neq 0$, after renormalizations, the sequence, still denoted by $\left\{w_{k}\right\}$, will converge locally smoothly to a Jacobi field of $S_{0}^{n}$ away from at most two points (see [29]), which is a constant function. This will give the desired contradiction.

It remains to consider the situation $d_{k} \rightarrow 0$ and $d_{k} / r_{k, j} \geq \alpha_{k} \rightarrow \infty$. By Remark [2.2, $d_{k}^{-1}\left(\Sigma_{k}-x_{k}\right)$ converges to a hyperplane with multiplicity two. Then the normalizations of $\left\{w_{k}\right\}$ will converge locally smoothly to a positive Jacobi field of the hyperplane, which is also a constant function. This will also give a contradiction.


Figure I. Structure of $\Sigma_{k}$.

Remark 2.4. For $\left\{\Sigma_{k}\right\}$ satisfying the requirements at the beginning of this section, we summarize the properties of $\Sigma_{k}$ (see Figure (I) for large $k$ :
(1) there exists $\left\{y_{k, j}\right\}$ containing one or two points such that for each $j, \Sigma_{k}$ has a small catenoid with radius $r_{k, j}$ around $y_{k, j}$;
(2) $\Sigma_{k}$ has exactly two connected components (denoted as $\Sigma_{k}^{1}$ and $\Sigma_{k}^{2}$ ) after removing such two (possibly one) small catenoids;
(3) $\Sigma_{k}^{2}$ is a graph over $\Sigma_{k}^{1}$ and the graph function satisfies Proposition 2.3.

## 3. Proof of the main theorem

For any $a \geq 1$ and $3 \leq(n+1) \leq 7$, let $M_{a}$ be the embedded $(n+1)$-sphere in $\mathbb{R}^{n+2}$ given by

$$
x_{1}^{2}+x_{2}^{2} \cdots+x_{n+1}^{2}+\frac{x_{n+2}^{2 n}}{a^{2 n}}=1 .
$$

For simplicity, let $S_{t}:=\left\{x_{n+2}=t\right\} \cap M_{a}$, where we omit the $a$ without ambiguity. These ( $n+1$ )-spheres satisfy the following properties:
(A) it has non-negative Ricci curvature;
(B) $S_{0}^{n}=S_{0}$ is the unique stable minimal hypersurface for each $a \geq 1$; it follows that each minimal hypersurface is two-sided;
(C) $M_{a} \rightarrow S_{0}^{n} \times \mathbb{R}$ locally smoothly as $a \rightarrow \infty$;
(D) $\left\{S_{t}\right\}_{t=-a}^{a}$ forms a foliation of $M_{a}$ and $\left\{x_{n+2}=t\right\}$ is an embedded $n$-sphere with mean curvature vector pointing away from $S_{0}$ for $0<|t|<a$. In particular, any two embedded minimal hypersurfaces in $M_{a}$ intersect each other;
(E) the area of $S_{t} \subset M_{a}$ satisfies that for all $t$,

$$
\begin{equation*}
\operatorname{Area}\left(S_{t}\right)=\Omega_{n}\left(1-\frac{t^{2 n}}{a^{2 n}}\right) \geq \Omega_{n}\left(1-|t|^{2 n}\right) \tag{3.1}
\end{equation*}
$$

(F) for each $t$ with $0<|t|<a$,

$$
|t| \leq \operatorname{dist}_{M_{a}}\left(S_{0}, S_{t}\right) \leq 2|t| .
$$

Before stating our main results, we introduce the key height estimates, which will be proved in the next section (Theorem 4.6 and 4.9).
Theorem 3.1. Let $\Sigma_{k} \subset M_{k}^{n+1}$ be a sequence of embedded minimal hypersurfaces with index $\leq 2$ and

$$
\operatorname{Area}\left(\Sigma_{k}\right) \leq 3 \operatorname{Area}\left(S_{0}^{n}\right)-\delta
$$

for some $\delta>0$. Then for all sufficiently large $k$,

$$
\max _{\Sigma_{k}} \operatorname{dist}_{M_{k}}\left(x, S_{0}^{n}\right) \leq 8 r_{k}\left|\log r_{k}\right|
$$

Remark 3.2. Note that the estimates are sharp for dimension $n+1=3$ (Theorem4.6). In higher dimensions $4 \leq n+1 \leq 7$, the height estimates are much better (Theorem 4.9).

In the following, we prove a rigidity theorem for minimal hypersurfaces with low index and area. This will be useful to identify the min-max solutions that realize the second width.

Theorem 3.3. Suppose that $\Sigma_{k}$ is a closed embedded minimal hypersurface in $M_{k}$ with index $\leq 2$ and

$$
\operatorname{Area}\left(\Sigma_{k}\right) \leq 2 \operatorname{Area}\left(S_{0}^{n}\right)
$$

Then for sufficiently large $k, \Sigma_{k}$ is exactly $S_{0}^{n}$.

Proof. Suppose not, then $\Sigma_{k}$ converges to a closed minimal hypersurface (with multiplicity) in $S_{0}^{n} \times \mathbb{R}$. By the monotonicity formula, the limit is $S_{0}^{n} \times\{0\}$ with multiplicity less than or equal to 2 . We claim the multiplicity has to be two. So long as the the convergence has multiplicity one, the normalization of the difference between $S_{0}^{n}$ and $\Sigma_{k}$ converges to a non-trivial Jacobi field on $S_{0}^{n}$ (see [29]). Note that such a Jacobi field is a constant. Thus $\Sigma_{k}$ lies on one side of $S_{0}^{n}$, which contradicts (D) at the beginning of this section. Therefore, $\Sigma_{k}$ converges to $\Sigma$ with multiplicity two.

By [27], the convergence is smooth away from a set $\mathcal{W}$ containing at most two points since the index of $\Sigma_{k}$ is less than or equal to 2 . Then $\left\{\Sigma_{k}\right\}$ and $\left\{M_{k}\right\}$ satisfy the conditions in Section 2(see Example 1). Let $p \in \mathcal{W}$. By the argument therein, we can find $y_{k}\left(\in M_{k}\right) \rightarrow p$ and $r_{k}>0$ such that $r_{k}^{-1}\left(\Sigma_{k}-y_{k}\right)$ locally smoothly converges to a standard catenoid $\mathcal{C} \subset \mathbb{R}^{n+1}$, i.e. it has the center at 0 and

$$
\max _{x \in \mathcal{C}}|A(x)|=\sqrt{n(n-1)} .
$$

By Remark 2.4, here we have three possibilities:
(1) $\mathcal{W}=\{p, q\}$ consists of two different points. In this case, there exists $z_{k} \rightarrow q$ and $\widetilde{r}_{k}$ such that $\widetilde{r}_{k}^{-1}\left(\Sigma_{k}-z_{k}\right)$ locally smoothly converges to a standard catenoid. Without loss of generality, we assume that $r_{k} \geq \widetilde{r}_{k}$ for all large $k$.
(2) $\mathcal{W}=\{p\}$ consists of only one point and $b_{k}$ described in Proposition 2.3 is equal to 0 . It follows that $\Sigma_{k} \backslash B\left(y_{k}, 2 r_{k} ; M_{k}\right)$ has exactly two connected components. In this case, we let $\widetilde{r}_{k}=0$.
(3) $\mathcal{W}=\{p\}$ consists of only one point and $b_{k}$ described in Proposition 2.3 is not 0, i.e. there exists $z_{k} \rightarrow p,\left|z_{k}-y_{k}\right| / r_{k} \rightarrow \infty$ and $\widetilde{r}_{k}>0$ such that $\widetilde{r}_{k}^{-1}\left(\Sigma_{k}-z_{k}\right)$ locally smoothly converges to a standard catenoid. Without loss of generality, we assume that $r_{k} \geq \widetilde{r}_{k}$ for large $k$.
Above all, outside two small balls with radii $r_{k}$ and $\widetilde{r}_{k}, \Sigma_{k}$ has exactly two connected components; see Remark [2.4. Moreover, we can take $R_{k} \rightarrow 0$ with $R_{k} / r_{k} \rightarrow \infty, r_{k}^{-1}\left(\Sigma_{k}-y_{k}\right) \cap B_{R_{k} / r_{k}}(0)$ is arbitrarily smoothly close to a standard catenoid $\mathcal{C} \cap B_{R_{r} / r_{k}}(0)$; if $z_{k}$ exists, we can also take $\widetilde{R}_{k} \rightarrow 0$ with $\widetilde{R}_{k} / \widetilde{r}_{k} \rightarrow \infty$ so that $\widetilde{r}_{k}^{-1}\left(\Sigma_{k}-z_{k}\right) \cap B_{R_{k} / r_{k}}(0)$ is arbitrarily close to a standard catenoid $\mathcal{C} \cap B_{R_{k} / r_{k}}(0)$.

Denote by $\gamma_{k}^{1}$ and $\gamma_{k}^{2}$ the two components of $\Sigma_{k} \cap \partial B\left(y_{k}, R_{k} ; M_{k}\right)$. Then each $\gamma_{k}^{j}(j=1$ or 2) bounds an area minimizing $n$-disk $\mathcal{D}_{k}^{j}$ in $M_{k}$. By Proposition (B.3),

$$
\begin{equation*}
\operatorname{Area}\left(B\left(y_{k}, R_{k} ; M_{k}\right) \cap \Sigma_{k}\right)-\sum_{j} \operatorname{Area}\left(\mathcal{D}_{k}^{j}\right) \geq \frac{\mathcal{A}_{n}}{2} r_{k}^{n}>0 \tag{3.2}
\end{equation*}
$$

Here $\mathcal{A}_{n}(n \geq 3)$ is defined by (B.2) and $\mathcal{A}_{2}$ can be any fixed real numbers because of (B.3). Similarly, in Case (11) or (3), there exist $\widetilde{\gamma}_{k}^{j} \subset \Sigma_{k}(j=1,2)$ surrounding $z_{k}$ such that each $\widetilde{\gamma}_{k}^{j}$ bounds an area minimizing $n$-disk $\widetilde{\mathcal{D}}_{k}^{j}$ in $M_{k}$ with

$$
\begin{equation*}
\operatorname{Area}\left(B\left(z_{k}, \widetilde{R}_{k} ; M_{k}\right) \cap \Sigma_{k}\right)-\sum_{j} \operatorname{Area}\left(\widetilde{\mathcal{D}}_{k}^{j}\right) \geq \frac{\mathcal{A}_{n}}{2} \widetilde{r}_{k}^{n}>0 \tag{3.3}
\end{equation*}
$$

Then we cut off $\Sigma_{k} \cap B\left(y_{k}, R_{k} ; M_{k}\right)$ and $\Sigma_{k} \cap B\left(z_{k}, \widetilde{R}_{k} ; M_{k}\right)$, which are close to a standard catenoid after scaling. After that, we add the $n$-disks $\left\{\mathcal{D}_{k}^{j}\right\}$ and $\left\{\widetilde{\mathcal{D}}_{k}^{j}\right\}$ to the new hypersurface; see Figure IIT. This yields a closed hypersurface with two connected components $\Gamma_{1}$ and $\Gamma_{2}$ which are both homologous to $S_{0}^{n}$ in $M_{k}$.


Figure II. Replacing the catenoids by two $n$-disks.

Note that Theorem 3.1 can be applied to obtain

$$
\max _{x \in \Sigma_{k}} \operatorname{dist}_{M_{k}}\left(x, S_{0}^{n}\right) \leq 8 r_{k}\left|\log r_{k}\right| ;
$$

together with a standard minimal foliation argument (applied to $B\left(y_{k}, \epsilon ; M_{k}\right)$ ), this implies that

$$
\max _{x \in \Gamma_{j}} \operatorname{dist}_{M_{k}}\left(x, S_{0}^{n}\right) \leq 10 r_{k}\left|\log r_{k}\right| .
$$

Let $\mathfrak{d}_{k}:=10 r_{k}\left|\log r_{k}\right|$. Then by the one-sided minimizing property of $S_{\mathfrak{D}_{k}}$ and $S_{-_{\mathfrak{o}_{k}}}$,

$$
\operatorname{Area}\left(\Gamma_{j}\right)+\operatorname{Area}\left(S_{0}^{n}\right)>\operatorname{Area}\left(S_{\mathfrak{D}_{k}}\right)+\operatorname{Area}\left(S_{-\mathfrak{o}_{k}}\right)
$$

By (3.1),

$$
\operatorname{Area}\left(S_{\mathfrak{o}_{k}}\right) \geq \operatorname{Area}\left(S_{0}^{n}\right)-\Omega_{n}\left|\mathfrak{o}_{k}\right|^{2 n} \quad \text { and } \quad \operatorname{Area}\left(S_{-\mathfrak{o}_{k}}\right) \geq \operatorname{Area}\left(S_{0}^{n}\right)-\Omega_{n}\left|\mathfrak{d}_{k}\right|^{2 n}
$$

these imply that

$$
\begin{equation*}
\operatorname{Area}\left(\Gamma_{1}\right)+\operatorname{Area}\left(\Gamma_{2}\right)>2 \operatorname{Area}\left(S_{0}^{n}\right)-4 \Omega_{n} \mathfrak{\partial}_{k}^{2 n} \tag{3.4}
\end{equation*}
$$

By the construction of $\Gamma_{j}$,

$$
\begin{aligned}
\operatorname{Area}\left(\Sigma_{k}\right)= & \sum_{j=1}^{2}\left(\operatorname{Area}\left(\Gamma_{j}\right)-\operatorname{Area}\left(\mathcal{D}_{k}^{j}\right)-\operatorname{Area}\left(\widetilde{\mathcal{D}}_{k}^{j}\right)\right)+\operatorname{Area}\left(B\left(y_{k}, R_{k} ; M_{k}\right) \cap \Sigma_{k}\right) \\
& +\operatorname{Area}\left(B\left(z_{k}, \widetilde{R}_{k} ; M_{k}\right) \cap \Sigma_{k}\right) \\
& \geq \sum_{j=1}^{2}\left(\operatorname{Area}\left(\Gamma_{j}\right)-\operatorname{Area}\left(\mathcal{D}_{k}^{j}\right)\right)+\operatorname{Area}\left(B\left(y_{k}, R_{k} ; M_{k}\right) \cap \Sigma_{k}\right) \\
& >2 \operatorname{Area}\left(S_{0}^{n}\right)-10^{2 n} r_{k}^{2 n-1} \cdot\left(4 \Omega_{n} r_{k}\left|\log r_{k}\right|^{2 n}\right)+\frac{\mathcal{A}_{n}}{2} r_{k}^{n} \\
& >2 \operatorname{Area}\left(S_{0}^{n}\right)+\frac{\mathcal{A}_{n}}{4} r_{k}^{n}
\end{aligned}
$$

Here the first inequality is from (3.3); we used (3.2) and (3.4) in the second one; the last one follows from the fact that $r_{k}\left|\log r_{k}\right|^{2 n} \rightarrow 0$ as $k \rightarrow \infty$. This gives a contradiction and we finish the proof of Theorem 3.3.

Now we are going to prove our main results.
Theorem 3.4. For sufficiently large $k$, the second width $\omega_{2}\left(M_{k}\right)$ can only be realized by $S_{0}^{n}$ with multiplicity two.

Proof. By the work of Marques-Neves [19], together with the Frankel's property (D), $\omega_{2}\left(M_{k}\right)$ is realized by the area of a connected, closed, embedded, minimal hypersurface $\Sigma_{k}$ with integer multiplicities and index $\left(\Sigma_{k}\right) \leq 2$. Observe that

$$
\begin{equation*}
\lim _{k \rightarrow \infty} \omega_{2}\left(M_{k}\right)=\omega_{2}\left(S_{0}^{n} \times \mathbb{R}\right)=2 \operatorname{Area}\left(S_{0}^{n}\right) \tag{3.5}
\end{equation*}
$$

We first prove that $\Sigma_{k}$ is $S_{0}^{n}$. Suppose not, then $\Sigma_{k}$ is unstable by Property (B); therefore using the direct corollary of the Multiplicity One Theorem in [38, $\Sigma_{k}$ has multiplicity one, i.e. $\omega_{2}\left(M_{k}\right)=\operatorname{Area}\left(\Sigma_{k}\right)$. On the other hand, by the construction of optimal 1-sweepouts (c.f. [36]), $\omega_{1}\left(M_{k}\right)=\operatorname{Area}\left(S_{0}^{n}\right)$. Then it follows that (c.f. [20, Proof of Theorem 5.1]).

$$
\begin{equation*}
\omega_{2}\left(M_{k}\right) \leq 2 \omega_{1}\left(M_{k}\right)=2 \operatorname{Area}\left(S_{0}^{n}\right) \tag{3.6}
\end{equation*}
$$

By Theorem 3.3, $\Sigma_{k}$ has to be identical to $S_{0}^{n}$, but this contradicts (3.5). Thus we conclude that $\Sigma_{k}$ has to be $S_{0}^{n}$. Then the multiplicity follows from (3.5).

Therefore, $\omega_{2}\left(M_{k}\right)$ can only be realized by $S_{0}^{n}$ with multiplicity two.
Let $M_{k}$ be the Riemannian $(n+1)$-sphere in Theorem 3.4. Denote by $N_{k}$ and $\mathbb{R} \mathbb{P}_{0}^{n}$ the quotient spaces $M_{k} /\{x \sim-x\}$ and $S_{0}^{n} /\{x \sim-x\}$, respectively. Then we have the following properties:
(1) for each $k, N_{k}$ satisfies the Frankel's property, i.e. any two embedded minimal hypersurfaces intersect;
(2) $\mathbb{R} \mathbb{P}_{0}^{n}$ is a one-sided embedded minimal hypersurface in $N_{k}$;
(3) as $k \rightarrow \infty, N_{k}$ locally smoothly converges to $S_{0}^{n} \times \mathbb{R} /\{x \sim-x\}$;
(4) $\omega_{1}\left(S_{0}^{n} \times \mathbb{R} /\{x \sim-x\}\right)=\operatorname{Area}\left(S_{0}^{n}\right)=2 \operatorname{Area}\left(\mathbb{R} \mathbb{P}_{0}^{n}\right)$.

Here the first three items follow from the Properties (A)D) of $M_{k}$ at the beginning of this section. For the last one, since $S_{0}^{n} \times \mathbb{R} /\{x \sim-x\}$ has a minimal foliation, it follows that

$$
\omega_{1}\left(S_{0}^{n} \times \mathbb{R} /\{x \sim-x\}\right) \leq \operatorname{Area}\left(S_{0}^{n}\right)=2 \operatorname{Area}\left(\mathbb{R} \mathbb{P}_{0}^{n}\right)
$$

On the other hand, as the limit contains $S_{0}^{n} \times(0, \infty)$, it follows that

$$
\omega_{1}\left(S_{0}^{n} \times \mathbb{R} /\{x \sim-x\}\right) \geq \omega_{1}\left(S_{0}^{n} \times \mathbb{R}\right)=\operatorname{Area}\left(S_{0}^{n}\right)
$$

Hence the last property is proved.
The following result directly implies Corollary 1.2 ,
Corollary 3.5. For sufficiently large $k$, the first width $\omega_{1}\left(N_{k}\right)$ can only be realized by $\mathbb{R}_{0}^{n}$ with multiplicity two.

Proof. Notice that $N_{k}$ also satisfies the Frankel's property. Then by Marques-Neves [19], $\omega_{1}\left(N_{k}\right)$ is realized by the area of a connected, closed, embedded, minimal hypersurface $\Gamma_{k}$ with integer multiplicity $m_{k}$ and index $\left(\Gamma_{k}\right) \leq 1$. Observe that

$$
\begin{equation*}
\lim _{k \rightarrow \infty} \omega_{1}\left(N_{k}\right)=\omega_{1}\left(S_{0}^{n} \times \mathbb{R} /\{x \sim-x\}\right)=2 \operatorname{Area}\left(\mathbb{R} \mathbb{P}_{0}^{n}\right) \tag{3.7}
\end{equation*}
$$

It follows that $\operatorname{Area}\left(\Gamma_{k}\right)$ is uniformly bounded. Then by compactness [27], $\Gamma_{k}$ converges to an embedded minimal hypersurface $\Gamma \subset S_{0}^{n} \times \mathbb{R} /\{x \sim-x\}$. Notice that such a space is foliated by minimal hypersurfaces. Thus $\Gamma$ is $S_{0}^{n} \times\{t\}$ or $\mathbb{R}_{0}^{n}$. Recall that $\Gamma_{k}$ intersects $\mathbb{R P}_{0}^{n}$. Hence we conclude that the limit is $\mathbb{R} \mathbb{P}_{0}^{n}$. Together with (3.7), we then have that $m_{k} \leq 2$.
Case I: $m_{k}=1$.
Then $\Gamma_{k}$ locally smoothly converges to $2 \mathbb{R} \mathbb{P}_{0}^{n}$ away from at most one point. Then by the same argument as in Theorem 3.3,

$$
\operatorname{Area}\left(\Gamma_{k}\right)>2 \operatorname{Area}\left(\mathbb{R}_{\mathbb{P}_{0}^{n}}^{n}\right)
$$

which contradicts $\omega_{1}\left(N_{k}\right) \leq 2 \operatorname{Area}\left(\mathbb{R} \mathbb{P}_{0}^{n}\right)$.
Case II: $m_{k}=2$.
Then $\Gamma_{k}$ converges to $\mathbb{R P}_{0}^{n}$ with multiplicity one. By Allard's regularity, the convergence is smooth. Let $\widetilde{\Gamma}_{k} \in M_{k}$ be the double cover of $\Gamma_{k}$. Then $\widetilde{\Gamma}_{k}$ smoothly converges to $S_{0}^{n}$. This implies that $\widetilde{\Gamma}_{k}$ is identical to $S_{0}^{n}$. Hence $\Gamma_{k}$ is identical to $\mathbb{R} \mathbb{P}_{0}^{n}$. This completes the proof of Corollary 3.5.

## 4. Upper bounds for the Hausdorff distance

We use the notation in Section 2, Recall that $\Sigma_{k} \subset M_{k}^{n+1}$ is a closed embedded minimal hypersurface such that the Morse index is bounded above by two and the area is uniformly bounded independent of $k \in \mathbb{N}$. As $k \rightarrow \infty, M_{k}$ converges locally smoothly to the product space $S_{0}^{n} \times \mathbb{R}$, and $\Sigma_{k}$ converges to a minimal $n$-sphere in the limit space of $M_{k}$, namely $S_{0}^{n} \times \mathbb{R}$. The convergence of $\Sigma_{k}$ is locally smooth away from at most two points according to the Morse index and area bounds. At a point near which the convergence is not smooth, the limit cones are either planes or catenoids by Proposition 2.1. For simplicity, we use $A$ for $A^{\Sigma_{k}}$ and sometimes omit the subscription $k$ when there is no ambiguity. Denote by $\nabla$ and $\widetilde{\nabla}$ the Levi-Civita connections of $\Sigma_{k}$ and $M_{k}$, respectively.

In this section, we prove the key height estimates, which says that the Hausdorff distance between $\Sigma_{k}$ and $S_{0}^{n}$ is bounded by a quantity associated with the catenoids arising from blowups. This result is essentially used in the previous section (see Theorem 3.1).

Recall that by Remark [2.4, $\Sigma_{k}$ has two connected components (denoted by $\Sigma_{k}^{1}$ and $\Sigma_{k}^{2}$ ) by removing one or two small catenoids. Denote by $y_{k}, z_{k}$ the centers and $r_{k}, \widetilde{r}_{k}$ the radii of links of such catenoids (we used $y_{k, j}$ and $r_{k, j}$ in Section 2 for general cases). Without loss of generality, we assume that $r_{k} \geq \widetilde{r}_{k}$.

Then by Proposition 2.3, $\Sigma_{k}^{2}$ is a minimal graph over $\Sigma_{k}^{1}$. Let $\mathbf{n}$ be the unit normal vector field of $\Sigma_{k}^{1}$, and let $\rho$ and $\widetilde{\rho}$ be the distance functions to $y_{k}$ and $z_{k}$ in $M_{k}$. Denote by

\boldsymbol{\eta}=\nabla \rho /|\nabla \rho|, \quad \widetilde{\boldsymbol{\eta}}=\nabla \widetilde{\rho} /|\nabla \widetilde{\rho}| ; \quad \phi=|\nabla \rho|, \quad \widetilde{\phi}=|\nabla \widetilde{\rho}| . \tag{4.1}
\end{equation*}
$$

Recall that $b_{k}$, defined in (2.3), is the distance between the two blowup points $y_{k}, z_{k}$. For any

In the remaining part of this section, we assume that $R_{k}, \widetilde{R}_{k} \rightarrow 0$ are two sequence of real numbers satisfying $R_{k} / r_{k} \rightarrow \infty$ and $\widetilde{R}_{k} / \widetilde{r}_{k} \rightarrow \infty$. Moreover, we can also assume $r_{k}^{-1}\left(\Sigma_{k} \cap\right.$ $\left.B\left(y_{k}, R_{k} ; M_{k}\right)-y_{k}\right)$ (resp. $\left.\widetilde{r}_{k}^{-1}\left(\Sigma_{k} \cap B\left(z_{k}, \widetilde{R}_{k} ; M_{k}\right)-y_{k}\right)\right)$ is arbitrarily close to the catenoid
$\mathcal{C} \cap B_{R_{k} / r_{k}}(0)$ (resp. $\left.\mathcal{C} \cap B_{\widetilde{R}_{k} / \widetilde{r}_{k}}(0)\right)$ in the smooth topology. By Proposition 2.1, for sufficiently large $k, s^{-1}\left(\gamma_{s}-y_{k}\right)$ is very close to the unit $(n-1)$-sphere in the smooth topology. In particular, we have

(1) for all large $k$ and $x \in \Sigma_{k}^{1} \cap A\left(y_{k}, R_{k}, \epsilon ; M_{k}\right) \backslash B\left(z_{k}, b_{k} / 2 ; M_{k}\right)$,

\Delta w_{k} \leq w_{k}+\frac{1}{8} \cdot \frac{w_{k}^{3}}{|\rho(x)|^{4}} \tag{4.6}
\end{equation*}
$$

(2) for all large $k$ and $x \in \Sigma_{k}^{1} \cap A\left(z_{k}, R_{k}, b_{k} / 2 ; M_{k}\right)$,

$$
\Delta w_{k} \leq w_{k}+\frac{1}{8} \cdot \frac{w_{k}^{3}}{|\widetilde{\rho}(x)|^{4}}
$$

Proof. By Proposition [2.3, $\left|A^{\Sigma_{k}}\right|$ has an upper bound over $\Sigma_{k}^{1} \cap A\left(y_{k}, s, 2 s ; M_{k}\right) \backslash B\left(z_{k}, b_{k} / 2 ; M_{k}\right)$, so the level sets of the distance to $\Sigma_{k}^{1}$ will form a desired foliation as in Appendix A. By the Cauchy-Schwartz inequality, we have

By plugging (2.6), (2.7) and (4.7) into (A.3) in Appendix A. we can show that

Here in (A.3), we deal with the first and third terms by (4.7); for the second term in (A.3), we used $|A| w_{k} \leq d_{k}|A| \cdot \frac{w_{k}}{d_{k}}<\delta^{2}$; in the fourth term, we used $w_{k}+\left|\nabla w_{k}\right|+\left|\nabla w_{k}\right|^{3}<3 \delta$ by (2.7); the others can be bounded similarly; for instance, we have

Inspired by Colding-Minicozzi [5, (2.1)], we define

\end{gather*}

where $\phi=|\nabla \rho|$ is defined in (4.1). Compared with [5], we introduce the weight $\phi=|\nabla \rho|$ in $\mathcal{I}_{k}$ as $\Sigma_{k}^{1}$ is not flat. Note that by Proposition B.1.

\lim _{k \rightarrow \infty} \frac{\tau_{k}\left(R_{k}\right)}{r_{k}^{n-1}}=2 \tag{4.11}
\end{equation*}

4.1. Inequalities for the first derivatives. In this subsection, we take the derivative for the averages of the height functions between two sheets. The coefficients of leading terms are the functions $\tau_{k}$ defined above.
Proposition 4.2. Using above notations, we then have

& \leq \frac{n}{\Omega_{n-1} s^{n}} \int_{\gamma_{s}}\left(\phi^{-1}-\phi\right) w_{k}+C_{0} s \mathcal{I}_{k}(s),
\end{aligned}
$$

where $C_{0}$ is a constant depending only on $n$ and can be changed from line to line.
Proof. Recall that $\phi=|\nabla \rho|$. A direct computation gives that

Here we used that $\left\langle\nabla_{\boldsymbol{\eta}} \boldsymbol{\eta}, \boldsymbol{\eta}\right\rangle=0$ in the first equality; and the last one follows from the minimality of $\Sigma_{k}$. Then by noting that $\frac{\partial}{\partial s}=\frac{\nabla \rho}{|\nabla \rho|^{2}}=\frac{\eta}{\phi}$, we have

& =\frac{1-n}{\Omega_{n-1} s^{n}} \int_{\gamma_{s}} w_{k} \phi d \mathcal{H}^{n-1}+\frac{1}{\Omega_{n-1} s^{n-1}} \int_{\gamma_{s}}\left\langle\nabla w_{k}, \boldsymbol{\eta}\right\rangle+w_{k}\left[\left\langle\nabla \phi, \frac{\boldsymbol{\eta}}{\phi}\right\rangle+\operatorname{div}_{\gamma_{s}} \boldsymbol{\eta}\right] d \mathcal{H}^{n-1} \\
& =\frac{1-n}{\Omega_{n-1} s^{n}} \int_{\gamma_{s}} w_{k} \phi d \mathcal{H}^{n-1}+\frac{1}{\Omega_{n-1} s^{n-1}} \int_{\gamma_{s}}\left\langle\nabla w_{k}, \boldsymbol{\eta}\right\rangle+w_{k} \phi^{-1} \operatorname{div}_{\Sigma_{k}} \widetilde{\nabla} \rho d \mathcal{H}^{n-1},
\end{aligned}
$$

where the last equality is from (4.12). Then we are going to prove the inequality. Recall that when restricting to $T\left(\partial B\left(p, s ; M_{k}\right)\right)$, we have

& =\frac{n}{s}+\mathcal{O}(s)-\left\langle\widetilde{\nabla}_{E} \widetilde{\nabla} \rho, E\right\rangle\langle\mathbf{n}, E\rangle^{2} \\
& \leq \frac{1}{s}\left(n-\phi^{2}\right)+C_{0} s .
\end{align*}
$$

In the above calculation, we used $E$ for the following expression,

E:=\frac{\mathbf{n}-\langle\mathbf{n}, \widetilde{\nabla} \rho\rangle \widetilde{\nabla} \rho}{\sqrt{1-\langle\mathbf{n}, \widetilde{\nabla} \rho\rangle^{2}}}

this is the unit projection of $\mathbf{n}$ to $T\left(\partial B\left(p, s ; M_{k}\right)\right)$. This finishes the proof of Proposition4.2,
In the next subsection, we will use the inequality in Proposition 4.2 to bound $\mathcal{I}_{k}$, which requires the following results for $F_{k}(t)$.
Proposition 4.3. Suppose that $[R, s] \subset\left[R_{k}, b_{k} / 2\right]$ or $\left[2 b_{k}, \epsilon\right]$. Then

$$

For all sufficiently large $k$,

\int_{R_{k}}^{b_{k} / 2} F_{k}(t) d t+\int_{2 b_{k}}^{\epsilon} F_{k}(t) d t<\epsilon
$$

Proof. By the divergence theorem,

\int_{A\left(y_{k}, R, s ; M_{k}\right) \cap \Sigma_{k}^{1}} \Delta \rho^{2}=\int_{\gamma_{s}} 2 s \phi-\int_{\gamma_{R}} 2 R \phi . \tag{4.15}

Since $\Delta \rho^{2}=2 n+\mathcal{O}\left(\rho^{2}\right)$, we have

& -\frac{1}{\Omega_{n-1} R_{k}^{n-1}} \int_{\gamma_{R_{k}}} \phi+C_{0} b_{k}^{2} .
\end{aligned}
$$

Recall that by (4.4), for all sufficiently large $k$, we have

\leq & \frac{n}{\Omega_{n-1}\left(b_{k} / 2\right)^{n}} \cdot \Omega_{n-1}\left[\int_{R_{k}}^{b_{k} / 2}\left(1+\frac{\epsilon}{10}\right) s^{n-1} d s+\frac{R_{k}}{n}\left(1+\frac{\epsilon}{10}\right) R_{k}^{n-1}\right]=1+\frac{\epsilon}{10} .
\end{aligned}
$$

On the other hand,

\frac{1}{\Omega_{n-1} R_{k}^{n-1}} \int_{\gamma_{R_{k}}} \phi \geq 1-\frac{\epsilon}{5} .

Combining them together, we then have

Hence Proposition 4.3 is proved.
4.2. Hausdorff distance upper bounds in dimension three. In this part, we focus on the case $n=2$ and prove the upper bounds of the Hausdorff distance between $\Sigma_{k}$ and $S_{0}^{2}$. Recall that $\Sigma_{k}^{1}$ and $\Sigma_{k}^{2}$ are jointed by one or two small catenoids with radii $r_{k}$ and $\widetilde{r}_{k}$; see Remark 2.4. Without loss of generality, we assume that $r_{k} \geq \widetilde{r}_{k}$. Recall that $\Sigma_{k}^{2}$ is a graph over $\Sigma_{k}^{1}$ with graph function $w_{k}$.

To prove the desired bound, we will derive several monotonicity formulas associated with the average of $w_{k}$. Then the smooth convergence on $\partial B\left(p, \epsilon ; M_{k}\right)$ will give the desired upper bound.

Now let

$$
\begin{gather*}
\widetilde{\mathcal{I}}_{k}(s)=\mathcal{I}_{k}(s)-3 r_{k} \log \frac{s}{r_{k}}-2 s r_{k} \log \frac{s}{r_{k}}-10\left(\int_{\left[R_{k}, s\right] \backslash\left[b_{k} / 2,2 b_{k}\right]} F_{k}(t) d t\right) \cdot r_{k} \log \frac{s}{r_{k}} ;  \tag{4.16}\\
\widetilde{\tau}_{k}(s)=\tau_{k}(s)+\frac{r_{k}^{2}}{2 s}-s r_{k} \log \frac{s}{r_{k}} . \tag{4.17}
\end{gather*}
$$

Then by Proposition 4.3,

$$
\begin{equation*}
\mathcal{I}_{k}(s)<\widetilde{\mathcal{I}}_{k}(s)+4 r_{k} \log \frac{s}{r_{k}} . \tag{4.18}
\end{equation*}
$$

Recall that $R_{k} / r_{k} \rightarrow+\infty$ and $r_{k}^{-1}\left(\Sigma_{k} \cap B\left(y_{k}, R_{k} ; M_{k}\right)-y_{k}\right)$ is arbitrarily close to the catenoid $\mathcal{C} \cap B_{R_{k} / r_{k}}(0)$ in the smooth topology. Then by Item (1)in Appendix B,

\begin{equation*}
\mathcal{I}_{k}\left(R_{k}\right) \leq\left(1+\frac{1}{100}\right) \cdot 2 r_{k} \int_{1}^{R_{k} / r_{k}} \frac{d s}{\sqrt{s^{2}-1}}<\left(1+\frac{1}{100}\right) \cdot 2 r_{k} \log \frac{2 R_{k}}{r_{k}}<3 r_{k} \log \frac{R_{k}}{r_{k}} . \tag{4.19}
\end{equation*}
$$

Then by (4.11), (4.16) and (4.19),

$$
\begin{equation*}
\widetilde{\mathcal{I}}_{k}\left(R_{k}\right)<0, \quad \tau_{k}\left(R_{k}\right)<\left(2+\frac{1}{10}\right) r_{k} \tag{4.20}
\end{equation*}
$$

Now we are ready to show that $\widetilde{\mathcal{I}}_{k}(s)$ is decreasing.
Proposition 4.4. $\widetilde{\mathcal{I}}_{k}(s)$ and $\widetilde{\tau}_{k}(s)$ are decreasing on $\left[R_{k}, b_{k} / 2\right]$ (resp. $\left[R_{k}, \epsilon\right]$ ) if $b_{k} \neq 0$ (resp. $b_{k}=0$ ). It follows that

\mathcal{I}_{k}(s)<4 r_{k} \log \frac{s}{r_{k}}, \quad \tau_{k}(s)<3 r_{k}-\frac{r_{k}^{2}}{2 s}+s r_{k} \log \frac{s}{r_{k}} \quad \text { for } s \in\left[R_{k}, b_{k} / 2\right]
$$

Proof. We first assume that $b_{k} \neq 0$. To prove that $\widetilde{\mathcal{I}}_{k}$ and $\widetilde{\tau}_{k}$ are decreasing on $\left[R_{k}, b_{k} / 2\right]$, let

s_{1}:=\sup \left\{s \in\left(R_{k}, b_{k} / 2\right): \widetilde{\tau}_{k}^{\prime}(t) \leq 0, \widetilde{\mathcal{I}}_{k}^{\prime}(t) \leq 0 \text { for all } t \in\left[R_{k}, s\right)\right\}
$$

We claim that $s_{1}=b_{k} / 2$. Suppose on the contrary that $s_{1}<b_{k} / 2$. Then $\widetilde{\mathcal{I}}_{k}$ and $\widetilde{\tau}_{k}$ are decreasing on $\left[R_{k}, s_{1}\right]$, which together with (4.20) implies that

By (4.17) and (4.18), it follows that

\mathcal{I}_{k}\left(s_{1}\right)<\widetilde{\mathcal{I}}_{k}\left(s_{1}\right)+4 r_{k} \log \frac{s_{1}}{r_{k}}<4 r_{k} \log \frac{s_{1}}{r_{k}} \\
\tau_{k}\left(s_{1}\right)=\widetilde{\tau}_{k}\left(s_{1}\right)-\frac{r_{k}^{2}}{2 s_{1}}+s_{1} r_{k} \log \frac{s_{1}}{r_{k}}<3 r_{k}-\frac{r_{k}^{2}}{2 s_{1}}+s_{1} r_{k} \log \frac{s_{1}}{r_{k}} .
\end{gathered}
$$

Then by Proposition 4.2,

\begin{aligned}
\mathcal{I}_{k}^{\prime}\left(s_{1}\right) & <\frac{\tau_{k}\left(s_{1}\right)}{s_{1}}+5 r_{k} \log \frac{s_{1}}{r_{k}} \cdot F_{k}\left(s_{1}\right)+C_{0} s_{1} r_{k} \log \frac{s_{1}}{r_{k}} \\
& <\frac{3 r_{k}}{s_{1}}+2 r_{k} \log \frac{s_{1}}{r_{k}}+5 r_{k} \log \frac{s_{1}}{r_{k}} \cdot F_{k}\left(s_{1}\right) .
\end{aligned}

Here in the first inequality, we used that by Proposition 2.3 (3) and (4.4), for $x \in \gamma_{s_{1}}$,

& <2 s_{1} \cdot\left(5 r_{k} \log \frac{s_{1}}{r_{k}}+\frac{1}{8 s_{1}^{4}} 5^{3} r_{k}^{3}\left(\log \frac{s_{1}}{r_{k}}\right)^{3}\right)<r_{k} \log \frac{s_{1}}{r_{k}}+\frac{r_{k}^{2}}{2 s_{1}^{2}}
\end{align*}
$$

Here the first inequality follows from (4.6); the second one follows from (4.21), (4.4) and $\left.\phi^{-1}\right|_{{s_{1}}_{1}} \leq 1+\epsilon$; in the last one, we used that as $k \rightarrow \infty$,

Note that $\mathcal{I}_{k}(s)$ is not well-defined in a small neighborhood of $b_{k}$. Here we use Proposition 2.3 and the divergence theorem to jump over such a small interval.

Proposition 4.5. Suppose that $b_{k} \neq 0$. Then $\widetilde{\mathcal{I}}_{k}-3 r_{k} \log \frac{s}{r_{k}}$ and $\widetilde{\tau}_{k}$ are decreasing on $\left[2 b_{k}, \epsilon\right]$. It follows that

& \leq \frac{1}{2 \pi} \int_{\Sigma_{k}^{1} \cap A\left(y_{k}, b_{k} / 2,2 b_{k} ; M_{k}\right) \backslash B\left(z_{k}, b_{k} / 4 ; M_{k}\right)} w_{k}+\frac{w_{k}^{3}}{8 \rho^{4}} d x \\
& <10 b_{k}^{2} r_{k} \log \frac{b_{k}}{r_{k}}+\frac{5^{3} r_{k}^{3}}{b_{k}^{2}}\left(\log \frac{b_{k}}{r_{k}}\right)^{3} \\
& <\frac{1}{4} b_{k} r_{k} \log \frac{b_{k}}{2 r_{k}}+\frac{r_{k}^{2}}{2 b_{k}} .
\end{aligned}
$$

Here we used the notation

The first inequality is from (4.6); we used (4.24) in the second one, and the area upper bound of $\Sigma_{k}^{1} \cap A\left(y_{k}, b_{k} / 2,2 b_{k} ; M_{k}\right) \backslash B\left(z_{k}, b_{k} / 4 ; M_{k}\right)$ is from the fact that $b_{k}^{-1}\left(\Sigma_{k}^{1}-y_{k}\right)$ is very close to a hyperplane. Recall that $\Sigma_{k}$ is very close to a catenoid with radius $\widetilde{r}_{k} \leq r_{k}$ around $z_{k}$. Then by the same argument as in Proposition 4.4, we also have

& <3 r_{k}-\frac{r_{k}^{2}}{b_{k}}+\frac{1}{2} b_{k} r_{k} \log \frac{b_{k}}{2 r_{k}}+3 r_{k}+\frac{1}{4} b_{k} r_{k} \log \frac{b_{k}}{4 r_{k}}+\frac{1}{4} b_{k} r_{k} \log \frac{b_{k}}{2 r_{k}}+\frac{r_{k}^{2}}{2 b_{k}} \\
& <6 r_{k}-\frac{r_{k}^{2}}{4 b_{k}}+b_{k} r_{k} \log \frac{b_{k}}{r_{k}} .
\end{align*}

In the next, we are going to prove that $\widetilde{\mathcal{I}}_{k}(s)-3 r_{k} \log \frac{s}{r_{k}}$ and $\widetilde{\tau}_{k}$ are decreasing. Let

\end{gathered}
$$

Together with (4.18) and (4.17), we then have

\end{gather*}

Recall that by Proposition 4.2,

& \leq 4 s_{2} \cdot 9 r_{k} \log \frac{s_{2}}{r_{k}}+9^{3} \frac{r_{k}^{3}}{s_{2}^{3}}\left(\log \frac{s_{2}}{r_{k}}\right)^{3}<r_{k} \log \frac{s_{2}}{r_{k}}+\frac{r_{k}^{2}}{2 s_{2}^{2}}
\end{aligned}
$$

Here the first inequality is from (4.6); the second one follows from (4.27), (4.28), (4.4) and $\left.\phi^{-1}\right|_{\gamma_{s_{1}}} \leq 1+\epsilon$; in the last one, we used that as $k \rightarrow \infty$,

Then the bound of $w_{k}$ on $\Sigma_{k}^{1} \cap \partial B\left(y_{k}, \epsilon ; M_{k}\right)$ follows from Proposition [2.3(3). Hence Proposition 4.5 is proved.

Recall that $\Sigma_{k}$ smoothly converges to $2 S_{0}^{2}$ outside at most two balls. In particular, $\Sigma_{k}^{1}$ and $\Sigma_{k}^{2}$ are graphs over $S_{0}^{2}$ outside such two balls; see Remark 2.4. Observe that the normalization of graph functions of $\Sigma_{k}^{1}$ and $\Sigma_{k}^{2}$ can both give bounded Jacobi fields, which would be smooth across the singularities. Then $w_{k}$ are equivalent to the difference of the two graph functions. By the maximum principle, such two graph functions should have opposite signs. Then the upper bound for $w_{k}$ implies the Hausdorff distance between $\Sigma_{k}$ and $S_{0}^{2}$.

Theorem 4.6. For all sufficiently large $k$,

\max _{\Sigma_{k}} \operatorname{dist}_{M_{k}}\left(x, S_{0}^{2}\right) \leq 8 r_{k}\left|\log r_{k}\right|
$$

Proof. Recall that $\Sigma_{k}$ locally smoothly converges locally smoothly to $2 \cdot S_{0}^{2}$ away from $\mathcal{W}$ which contains at most two points. Then for any compact set $\Omega \subset S_{0}^{2} \backslash \mathcal{W}, \Sigma_{k}$ can be decomposed into two minimal graph functions in the neighborhood of $\Omega$ for sufficiently large $k$. Denote by $u_{k}^{1}$ and $u_{k}^{2}$ the graph functions. Note that $u_{k}^{1}$ and $u_{k}^{2}$ are defined on any compact domain in $S_{0}^{2} \backslash \mathcal{W}$ by taking large $k$. Denote by

\lambda_{k}(x, s)=\max _{\partial B_{s}(x) \cap S_{0}^{2}}\left\{-u_{k}^{1}, u_{k}^{2}\right\} \quad \text { and } \quad \Lambda_{k, s}=\max _{x \in \mathcal{W}} \lambda_{k}(x, s) .
$$

Then by a standard argument (see [29]), $u_{k}^{1} / \Lambda_{k, \epsilon}$ and $u_{k}^{2} / \Lambda_{k, \epsilon}$ locally smoothly converges to $c_{1}$ and $c_{2}$, which are Jacobi fields of $S_{0}^{2} \backslash \mathcal{W}$. By the minimal foliation argument, $c_{1}$ and $c_{2}$ are bounded, which implies that they can be extended smoothly across $\mathcal{W}$. Therefore, $c_{1}$ and $c_{2}$ are constants. Moreover, by the definition of $\Lambda_{k, \epsilon}, c_{1}=-1$ or $c_{2}=1$. Without loss of generality, we assume that $c_{2}=1$. Note that $\Sigma_{k}$ does not lie in one side of $S_{0}^{2}$, which implies that $c_{1} \leq 0$. Then by the smooth convergence of $\Sigma_{k}$ in $B_{2 \epsilon}(\mathcal{W}) \backslash B_{\epsilon / 2}(\mathcal{W})$, for sufficiently large $k$,

\lim _{k \rightarrow \infty} \max _{\Sigma_{k}^{1} \cap B_{\epsilon}(\mathcal{W})} \frac{w_{k}}{\Lambda_{k, \epsilon}}=\lim _{k \rightarrow \infty} \max _{\partial B_{\epsilon}(\mathcal{W}) \cap \Sigma} \frac{u_{k}^{2}-u_{k}^{1}}{\Lambda_{k, \epsilon}}=1-c_{1} \geq 1 .
$$

By Propositions 4.4 and 4.5, for sufficiently large $k$,

4.3. Upper bounds for Hausdorff distance in high dimensions. In this part, we restrict $3 \leq n \leq 6$ and prove the upper bounds of the Hausdorff distance between $\Sigma_{k}$ and $S_{0}^{n}$. Recall that $\Sigma_{k}^{1}$ and $\Sigma_{k}^{2}$ are jointed by one or two small catenoids with radii $r_{k}$ and $\widetilde{r}_{k}$; see Remark 2.4. Without loss of generality, we assume that $r_{k} \geq \widetilde{r}_{k}$. Recall that $\Sigma_{k}^{2}$ is a graph over $\Sigma_{k}^{1}$ with graph function $w_{k}>0$.

To prove the desired bound, we start at one catenoid and derive new monotonicity formulas. Then the smooth convergence on $\partial B\left(p, \epsilon ; M_{k}\right)$ will give the desired upper bound. Now let

\widetilde{\mathcal{I}}_{k}(s)=\mathcal{I}_{k}(s)+4 s^{-\frac{1}{2}} r_{k}^{\frac{3}{2}}-s r_{k}-10 r_{k} \int_{\left[R_{k}, s\right] \backslash\left[b_{k} / 2,2 b_{k}\right]} F_{k}(t) d t ;  \tag{4.30}\\
\widetilde{\tau}_{k}(s)=\tau_{k}(s)-9 s^{n} r_{k}-r_{k}^{\frac{3}{2}} s^{n-\frac{5}{2}} . \tag{4.31}
\end{gather*}
$$

Then by (4.3),

\mathcal{I}_{k}(s) \leq \widetilde{\mathcal{I}}_{k}(s)+\frac{r_{k}}{20}, \tag{4.32}
\end{equation*}
$$

Recall that $R_{k} / r_{k} \rightarrow 0$ and $r_{k}^{-1}\left(\Sigma_{k} \cap B\left(y_{k}, R_{k} ; M_{k}\right)-y_{k}\right)$ is arbitrarily close to the catenoid $\mathcal{C} \cap B_{R_{k} / r_{k}}(0)$ in the smooth topology. Then by Item (1) in Appendix B

Now we are ready to show that $\widetilde{\mathcal{I}}_{k}(s)$ is decreasing in two disjoint intervals.
Proposition 4.7. $\widetilde{\mathcal{I}}_{k}(s)$ and $\widetilde{\tau}_{k}(s)$ are decreasing on $\left[R_{k}, b_{k} / 2\right)$ (resp. $\left[R_{k}, \epsilon\right]$ ) if $b_{k} \neq 0$ (resp. $b_{k}=0$ ). It follows that

Proof of Proposition 4.7. Suppose $b_{k} \neq 0$. To prove that $\widetilde{\mathcal{I}}_{k}$ and $\widetilde{\tau}_{k}$ are decreasing on $\left[R_{k}, b_{k} / 2\right]$, we let

We claim that $s_{1}=b_{k} / 2$. Suppose on the contrary that $s_{1}<b_{k} / 2$. Then it follows that $\widetilde{\mathcal{I}}_{k}(s)$ and $\widetilde{\tau}_{k}(s)$ are decreasing on $\left[R_{k}, s_{1}\right]$. Hence by (4.34),

$$

Together with (4.32) and (4.31), we have that

\mathcal{I}_{k}\left(s_{1}\right) \leq \widetilde{\mathcal{I}}_{k}\left(s_{1}\right)+\frac{r_{k}}{20}<\frac{29 r_{k}}{10}  \tag{4.35}\\
\tau_{k}\left(s_{1}\right)=\widetilde{\tau}_{k}\left(s_{1}\right)+9 s_{1}^{n} r_{k}+s_{1}^{n-\frac{5}{2}} r_{k}^{\frac{3}{2}}<\frac{5}{2} r_{k}^{n-1}+9 s_{1}^{n} r_{k}+s_{1}^{n-\frac{5}{2}} r_{k}^{\frac{3}{2}}
\end{gather*}
$$

Note that the first inequality together with (4.4) and Proposition (2.3 (3) implies that for $x \in \gamma_{s_{1}}$,

$$
\begin{equation*}
w_{k}(x) \leq(1+1 / 100) \mathcal{I}_{k}\left(s_{1}\right)<3 r_{k} . \tag{4.36}
\end{equation*}
$$

Then by Proposition 4.2,

$$
\begin{aligned}
\mathcal{I}_{k}^{\prime}\left(s_{1}\right) & \leq \frac{\tau_{k}\left(s_{1}\right)}{s_{1}^{n-1}}+\frac{n}{\Omega_{n-1} s_{1}^{n}} \int_{\gamma_{s_{1}}}\left(\phi^{-1}-\phi\right) w_{k}+C_{0} s_{1} \mathcal{I}_{k}\left(s_{1}\right) \\
& \leq \frac{5}{2}\left(\frac{r_{k}}{s_{1}}\right)^{n-1}+9 s_{1} r_{k}+s_{1}^{-\frac{3}{2}} r_{k}^{\frac{3}{2}}+3 r_{k} F_{k}\left(s_{1}\right)+C_{0} s_{1} \cdot 3 r_{k} \\
& <2\left(\frac{r_{k}}{s_{1}}\right)^{\frac{3}{2}}+r_{k}+3 r_{k} F_{k}\left(s_{1}\right),
\end{aligned}
$$

where the second inequality is from (4.36); the last one follows from $n-1 \geq 2, s_{1} \rightarrow 0$ and $r_{k} / s_{k} \rightarrow 0$ as $k \rightarrow \infty$. Together with (4.30), we then have

$$
\begin{equation*}
\widetilde{\mathcal{I}}_{k}^{\prime}\left(s_{1}\right)=\mathcal{I}_{k}^{\prime}\left(s_{1}\right)-2\left(\frac{r_{k}}{s_{1}}\right)^{\frac{3}{2}}-r_{k}-10 r_{k} F_{k}\left(s_{1}\right)<0 . \tag{4.37}
\end{equation*}
$$

On the other hand, by the divergence theorem and the co-area formula,

$$
\begin{aligned}
\tau_{k}^{\prime}\left(s_{1}\right)=\frac{1}{\Omega_{n-1}} \int_{\gamma_{s_{1}}} \phi^{-1} \Delta w_{k} & \leq \frac{1}{\Omega_{n-1}} \int_{\gamma_{s_{1}}} \phi^{-1}\left(w_{k}+\frac{w_{k}^{3}}{8 s_{1}^{4}}\right) \\
& <\left(1+\frac{1}{100}\right)^{2} \cdot \frac{29}{10} s_{1}^{n-1} r_{k}+\frac{3^{3}}{8} \cdot 4 s_{1}^{n-5} r_{k}^{3} \\
& <3 s_{1}^{n-1} r_{k}+r_{k}^{2} s_{1}^{n-4} .
\end{aligned}
$$

Here the first inequality follows from (4.6); in the second one, we used (4.4), (4.35), (4.36) and $\left.\phi^{-1}\right|_{\gamma_{s_{1}}}<1+\frac{1}{100}$; the last one is from $r_{k} / s_{1} \rightarrow 0$. Together with (4.31),

$$
\widetilde{\tau}_{k}^{\prime}\left(s_{1}\right)=\tau_{k}^{\prime}\left(s_{1}\right)-9 n s_{1}^{n-1} r_{k}-\left(n-\frac{5}{2}\right) r_{k}^{\frac{3}{2}} s_{1}^{n-\frac{7}{2}}<0
$$

Combining with (4.37), this contradicts the choice of $s_{1}$.
If $b_{k}=0$, then the same argument above gives that $\widetilde{\mathcal{I}}_{k}$ and $\widetilde{\tau}_{k}$ are decreasing on $\left[R_{k}, \epsilon\right]$. Hence Proposition 4.7 is proved.

Note that $\mathcal{I}(s)$ is not well-defined in a small neighborhood of $b_{k}$. Here we use Proposition 2.3 and the divergence theorem to jump over such a small interval.

Proposition 4.8. Suppose that $b_{k} \neq 0$. Then $\widetilde{\mathcal{I}}_{k}$ and $\widetilde{\tau}_{k}$ are decreasing on $\left[2 b_{k}, \epsilon\right]$. It follows that

\mathcal{I}_{k}(s)<4 r_{k}, \quad \tau_{k}(s)<6 r_{k}^{n-1}+9 s^{n} r_{k}+r_{k}^{\frac{3}{2}} s^{n-\frac{5}{2}} \quad \text { for } \quad s \in\left[2 b_{k}, \epsilon\right] .
$$

In particular, we conclude that for sufficiently large $k$,

\max _{x \in \Sigma_{k}^{1} \cap \partial B\left(y_{k}, \epsilon ; M_{k}\right)} w_{k}<\frac{9}{2} r_{k} .
$$

Proof. By applying Proposition 2.3 (3), and then Proposition 4.7 , together with (4.4), we have

\max \left\{w_{k} ; x \in \Sigma_{k}^{1} \cap A\left(y_{k}, b_{k} / 2,2 b_{k} ; M_{k}\right) \backslash B\left(z_{k}, b_{k} / 4 ; M_{k}\right)\right\} \leq(1+\delta) \mathcal{I}_{k}\left(\frac{b_{k}}{2}\right) \leq \frac{10}{3} r_{k}, \tag{4.38}
\end{equation*}
$$

as well as

$$
\begin{equation*}
\mathcal{I}_{k}\left(2 b_{k}\right)<\frac{11 r_{k}}{3} \tag{4.39}
\end{equation*}
$$

Moreover, by the divergence theorem and (4.6),

$$
\begin{aligned}
& \tau_{k}\left(2 b_{k}\right)-\tau_{k}\left(b_{k} / 2\right)-\tau_{k}\left(b_{k} / 4 ; z_{k}\right)=\frac{1}{\Omega_{n-1}} \int_{\Sigma_{k}^{1} \cap A\left(y_{k}, b_{k} / 2,2 b_{k} ; M_{k}\right) \backslash B\left(z_{k}, b_{k} / 4 ; M_{k}\right)} \Delta w_{k} d x \\
\leq & \frac{1}{\Omega_{n-1}} \int_{\Sigma_{k}^{1} \cap A\left(y_{k}, b_{k} / 2,2 b_{k} ; M_{k}\right) \backslash B\left(z_{k}, b_{k} / 4 ; M_{k}\right)}\left(w_{k}+\frac{w_{k}^{3}}{8 \rho^{4}}\right) d x \\
< & \frac{10}{3} r_{k} \cdot\left(1+\frac{1}{100}\right)\left(2 b_{k}\right)^{n}+\left(1+\frac{1}{100}\right)\left(\frac{10}{3}\right)^{3} \cdot \frac{1}{8} r_{k}^{3}\left(2 b_{k}\right)^{n-4}<4 r_{k}\left(2 b_{k}\right)^{n}+r_{k}^{2}\left(2 b_{k}\right)^{n-3} .
\end{aligned}
$$

Here

$$
\tau_{k}\left(s ; z_{k}\right)=\frac{1}{\Omega_{n-1}} \int_{\Sigma_{k}^{1} \cap \partial B\left(z_{k}, s, M_{k}\right)}\left\langle\nabla w_{k}, \boldsymbol{\eta}_{z}\right\rangle,
$$

and $\boldsymbol{\eta}_{z}$ is the unit normal to $\partial B\left(z_{k}, s ; M_{k}\right) \cap \Sigma_{k}^{1}$. The first inequality is from (4.6); we used (4.38) in the second one, and the area upper bound is from the fact that $b_{k}^{-1}\left(\Sigma_{k}^{1}-y_{k}\right)$ is very close to a hyperplane. Recall that $\Sigma_{k}$ is very close to a catenoid with radius $\widetilde{r}_{k} \leq r_{k}$ around $z_{k}$. Then by the same argument as in Proposition 4.7, we also have

$$
\tau_{k}\left(b_{k} / 4 ; z_{k}\right)<3 \widetilde{r}_{k}^{n-1}+9\left(\frac{b_{k}}{4}\right)^{n} \widetilde{r}_{k}+\left(\frac{b_{k}}{4}\right)^{n-\frac{5}{2}} \widetilde{r}_{k}^{\frac{3}{2}} \leq 3 r_{k}^{n-1}+9\left(\frac{b_{k}}{4}\right)^{n} r_{k}+\left(\frac{b_{k}}{4}\right)^{n-\frac{5}{2}} r_{k}^{\frac{3}{2}}
$$

It follows that

$$
\begin{aligned}
\tau_{k}\left(2 b_{k}\right) & <\tau_{k}\left(b_{k} / 2\right)+\tau_{k}\left(b_{k} / 4 ; z_{k}\right)+4 r_{k}\left(2 b_{k}\right)^{n}+r_{k}^{2}\left(2 b_{k}\right)^{n-3} \\
& <6 r_{k}^{n-1}+9\left(\frac{b_{k}}{2}\right)^{n} r_{k}+\left(\frac{b_{k}}{2}\right)^{n-\frac{5}{2}} r_{k}^{\frac{3}{2}}+9\left(\frac{b_{k}}{4}\right)^{n} r_{k}+\left(\frac{b_{k}}{4}\right)^{n-\frac{5}{2}} r_{k}^{\frac{3}{2}}+4 r_{k}\left(2 b_{k}\right)^{n}+r_{k}^{2}\left(2 b_{k}\right)^{n-3} \\
& <6 r_{k}^{n-1}+9\left(2 b_{k}\right)^{n} r_{k}+\left(2 b_{k}\right)^{n-\frac{5}{2}} r_{k}^{\frac{3}{2}},
\end{aligned}
$$

which implies that

$$
\widetilde{\tau}_{k}\left(2 b_{k}\right)=\tau_{k}\left(2 b_{k}\right)-9\left(2 b_{k}\right)^{n} r_{k}-r_{k}^{\frac{3}{2}}\left(2 b_{k}\right)^{n-\frac{5}{2}}<6 r_{k}^{n-1} .
$$

Then one can prove that $\widetilde{\mathcal{I}}_{k}(s)$ and $\widetilde{\tau}_{k}(s)$ are decreasing on $\left[2 b_{k}, \epsilon\right]$ by the same argument as in Proposition 4.7.

Applying Proposition 2.3(3) and (4.4) again,

$$
\max _{x \in \Sigma_{k}^{1} \cap \partial B\left(y_{k}, \epsilon ; M_{k}\right)} w_{k} \leq(1+1 / 10) \mathcal{I}_{k}(\epsilon) \leq \frac{9}{2} r_{k} .
$$

This completes the proof of Proposition 4.7,
Then using the same argument as Theorem 4.6, one can prove the Hausdorff distance upper bounds between $\Sigma_{k}$ and $S_{0}^{n}$. The only modification is to replace Propositions 4.4 and 4.5 by Propositions 4.7 and 4.8.

Theorem 4.9. For all sufficiently large $k$,

\max _{\Sigma_{k}} \operatorname{dist}_{M_{k}}\left(x, S_{0}^{n}\right)<5 r_{k}
$$

## Appendix A. Minimal graphs

Let $\mathcal{N} \subset M$ be a two-sided minimal hypersurface in $\left(M^{n+1}, g\right)$ with a chosen unit normal vector field $\mathbf{n}$. Let $d$ be the oriented distance function to $\mathcal{N}$, and $\mathcal{N}_{s}$ be the level set of $d$. Then for some small $\mathfrak{d}>0,\left\{\mathcal{N}_{t}\right\}_{t \in(-\mathfrak{d}, \mathfrak{d})}$ forms a foliation of a neighborhood of $\mathcal{N}$. Denote by $\widetilde{\nabla}$ and $\nabla$ the Levi-Civita connections of $M$ and $\mathcal{N}_{s}$ respectively. Then $\widetilde{\nabla} d$ is the unit normal vector field on $\mathcal{N}_{s}$. In this section, we always assume that $M$ and $\mathcal{N}$ satisfy the following conditions:

$$
\begin{equation*}
|A|_{\mathcal{N}}<\epsilon / \mathfrak{d}, \quad|R| \leq 1, \quad|\widetilde{\nabla} R|<C(n) \tag{A.1}
\end{equation*}
$$

Here $R$ is the Riemannian curvature tensor of $M ; \epsilon$ is a small constant depending only on $n$, e.g. $\epsilon=10^{-1000 n} ; C(n)>1$ is a constant that can be changed from line to line.

Let $\Sigma$ be a minimal graph over $\mathcal{N}$ with

$$
\max _{x \in \Sigma} \operatorname{dist}_{M}(x, \mathcal{N})<\mathfrak{d} .
$$

Denote by $u$ the graph function. Then such a function can be extended to a neighborhood of $\mathcal{N}$ by taking

$$
u(p, s)=u(p)-s
$$

When restricted to $\mathcal{N}_{s}, u$ is the graph function of $\Sigma$ over $\mathcal{N}_{s}$. Moreover, $u=0$ when restricted to $\Sigma$, and hence $\left.\widetilde{\nabla} u\right|_{\Sigma}$ is the normal vector field on $\Sigma$ and is non-zero everywhere.

For $p \in \Sigma \cap \mathcal{N}_{s}$, let $\left\{e_{i}\right\}$ be an orthonormal basis of $T_{p} \mathcal{N}_{s}$. Let $A$ and $H$ denote respectively the second fundamental form and mean curvature of $\mathcal{N}_{s}$ with respect to $\widetilde{\nabla} d$. A direct computation gives that

$$
\begin{gathered}
\frac{\partial}{\partial s} H=-\operatorname{Ric}(\widetilde{\nabla} d, \widetilde{\nabla} d)-|A|^{2} ; \\
\widetilde{\nabla}_{\widetilde{\nabla} d} \widetilde{\nabla} u=\widetilde{\nabla}_{\widetilde{\nabla} d} \nabla u=-A(\nabla u) ; \quad \frac{\partial}{\partial s}|\widetilde{\nabla} u|^{2}=-2 A(\nabla u, \nabla u) ; \\
\operatorname{div}_{M} A(\nabla u)=\operatorname{div}_{\mathcal{N}_{s}} A(\nabla u)=\left\langle\nabla^{2} u, A\right\rangle+\operatorname{Ric}(\nabla u, \widetilde{\nabla} d)+\langle\nabla u, \nabla H\rangle ; \\
\frac{\partial}{\partial s} \operatorname{div}_{M} \widetilde{\nabla} u=-\operatorname{Ric}(\widetilde{\nabla} d, \widetilde{\nabla} u+\nabla u)+|A|^{2}-2\left\langle\nabla^{2} u, A\right\rangle-\langle\nabla u, \nabla H\rangle ; \\
\frac{\partial}{\partial s}|\nabla H|^{2}=-2\left\langle\nabla\left(\operatorname{Ric}(\widetilde{\nabla} d, \widetilde{\nabla} d)+|A|^{2}\right), \nabla H\right\rangle-2 A(\nabla H, \nabla H) ; \\
\frac{\partial}{\partial s}|A|^{2}=2 R\left(\widetilde{\nabla} d, e_{i}, \widetilde{\nabla} d, e_{j}\right) A\left(e_{i}, e_{j}\right)-2 A\left(e_{i}, e_{j}\right) A\left(e_{j}, e_{k}\right) A\left(e_{k}, e_{i}\right) ; \\
\frac{\partial}{\partial s}|\nabla A|^{2}=2 R_{s j s k, i} A_{j k, i}+4 R_{s i l k} A_{j l} A_{k i, j}+4 R_{s i l j} A_{k l} A_{j k, i}-2 A_{j k, i} A_{j k, l} A_{l i}-4 A_{i k, j} A_{l k, j} A_{i l} ; \\
\frac{\partial}{\partial s}\left|\nabla^{2} u\right|^{2}=-2 A_{k j, i} u_{k} u_{i j}+2 R_{s i k j} u_{k} u_{i j}-4 u_{i j} u_{k j} A_{i k}
\end{gathered}
$$

We pause to state a standard differential inequality, whose proof is left to readers.
Lemma A.1. Let $f:[0, \mathfrak{d}] \rightarrow \mathbb{R}$ be a non-negative differentiable function. Suppose that

$$
f^{\prime}(t) \leq a+b f(t)
$$

for real numbers $a$ and $b$. Then for each $t \in[0, \mathfrak{d}]$,

$$
f(t) \leq e^{b t} f(0)+\frac{a}{b}\left(e^{b t}-1\right)
$$

Now Lemma A. 1 can be applied to bound those terms on $\mathcal{N}_{s}$ by their restriction on $\mathcal{N}$.

## Lemma A.2.

$$
\begin{gathered}
|\nabla u(x, t)| \leq 2|\nabla u(x)| ; \quad|A(x, t)| \leq 2|A(x)|+2 t ; \\
\left||A(x, t)|^{2}-|A(x)|^{2}\right| \leq C(n)\left(|A(x)| t+t+|A(x)|^{3} t\right) ; \\
|\nabla A(x, t)| \leq C(n)(|\nabla A(x)|+t(|A(x)|+1)) ; \\
|\nabla H(x, t)| \leq C(n)\left(t+t(|A(x)|+t)|\nabla A(x)|+|A(x)|^{2} t^{2}\right) ; \\
\left|\nabla^{2} u(x, t)\right| \leq C(n)\left(\left|\nabla^{2} u(x)\right|+t(1+|\nabla A(x)|)|\nabla u(x)|\right)
\end{gathered}
$$

Proof. Note that $\frac{\partial}{\partial s}|A|^{2} \leq 2|A|+2|A|^{3}$. Then by classical OD-inequalities, we have

\arctan |A(x, t)| \leq \arctan |A(x)|+t
$$

Since $|t A(x)| \leq \delta|A(x)|<\epsilon$,

|A|(x, t) \leq 2|A(x)|+2 t \tag{A.2}

The others can be derived similarly as follows: note that

\frac{\partial}{\partial s}|\nabla A|^{2} \leq C(n)\left(|\nabla A(x, t)|+|A(x, t)||\nabla A(x, t)|+|A(x, t)||\nabla A(x, t)|^{2}\right)
$$

Fix $x \in \mathcal{N}$. Now let $f(t)=\sqrt{1+|\nabla A(x, t)|^{2}}$. It follows that

f^{\prime}(t) \leq C(n)(1+|A(x, t)|+|A(x, t)| f) \leq C(n)(1+|A(x)|+(1+|A(x)|) f(t))
$$

Here the second inequality comes from (A.2). Then Lemma (A.1) can be applied to obtain

|\nabla A(x, t)|+1 \leq e^{C(n)(1+|A(x)|) t}(1+|\nabla A(x)|)+e^{C(n)(1+|A(x)|) t}-1,
$$

which yields

Here we used the condition that $C(n)|A(x)| t \leq C(n)|A(x)| \mathfrak{d} \ll 1$ by (A.1).
Now we are ready to derive our inequality for $u$. Indeed, by the minimality of $\Sigma$,

0=\operatorname{div}_{\Sigma} \widetilde{\nabla} u & =\operatorname{div}_{M} \widetilde{\nabla} u-\widetilde{\nabla}^{2} u\left(\frac{\widetilde{\nabla} u}{|\widetilde{\nabla} u|}, \frac{\widetilde{\nabla} u}{|\widetilde{\nabla} u|}\right) \\
& =\operatorname{div}_{M} \widetilde{\nabla} u-\left(A+\nabla^{2} u\right)\left(\frac{\nabla u}{|\widetilde{\nabla} u|}, \frac{\nabla u}{|\widetilde{\nabla} u|}\right) .
\end{aligned}
$$

It follows that

$$
\begin{aligned}
\frac{\left(A+\nabla^{2} u\right)(\nabla u, \nabla u)}{1+|\nabla u|^{2}} & =\operatorname{div}_{\mathcal{N}} \nabla u+\int_{0}^{s} \frac{\partial}{\partial t} \operatorname{div}_{M} \widetilde{\nabla} u \\
& =\Delta_{\mathcal{N}} u+\int_{0}^{s}-\operatorname{Ric}(\widetilde{\nabla} d, \widetilde{\nabla} u+\nabla u)+|A|^{2}-2\left\langle\nabla^{2} u, A\right\rangle-\langle\nabla u, \nabla H\rangle d t .
\end{aligned}
$$

Since $\widetilde{\nabla} u=\nabla u-\widetilde{\nabla} d$, then

$$
\operatorname{Ric}(\widetilde{\nabla} d, \tilde{\nabla} u+\nabla u)=-\operatorname{Ric}(\widetilde{\nabla} d, \tilde{\nabla} d)+2 \operatorname{Ric}(\widetilde{\nabla} d, \nabla u)
$$

It follows that

$$
\begin{aligned}
(\Delta u & \left.+|A|^{2} u\right)(x, 0)+\int_{0}^{s} \operatorname{Ric}(\widetilde{\nabla} d, \widetilde{\nabla} d) d t \\
& \leq\left(|A|+\left|\nabla^{2} u\right|\right)|\nabla u|^{2}(x, s)+\int_{0}^{s} 2 n|\nabla u|+\left||A(x)|^{2}-|A(x, t)|^{2}\right|+2\left|\nabla^{2} u\right||A|+|\nabla u||\nabla H| d t .
\end{aligned}
$$

Combining all of them, we conclude that

$$
\Delta_{\mathcal{N}} u+|A|_{\mathcal{N}}^{2} u+\int_{0}^{u(x)} \operatorname{Ric}(\widetilde{\nabla} d, \widetilde{\nabla} d) d t
$$

$$
\begin{align*}
& \leq 8|A|_{\mathcal{N}}|\nabla u|^{2}+|A|_{\mathcal{N}}^{3} u^{2}+\left|\nabla^{2} u\right||A|_{\mathcal{N}} u+C(n)\left(u+|\nabla u|+|\nabla u|^{3}\right) u+  \tag{A.3}\\
& +C(n)\left\{|\nabla u(x)|^{2}\left|\nabla^{2} u\right|+|\nabla u|^{3}|\nabla A| u+|A| u^{2}(1+|\nabla u|)+\left|\nabla^{2} u\right| u^{2}+\right. \\
& \left.+|\nabla A||\nabla u| u^{2}(|A|+u)+|\nabla u| u^{2}\left(1+|A||\nabla u|+|\nabla A| u+|A|^{2} u\right)\right\}_{\mathcal{N}} .
\end{align*}
$$

## Appendix B. Catenoids

In this section, we collect some basic results for the catenoids. In $\mathbb{R}^{n+1}$, given $r>0$, there is an associated catenoid given by

$$
\left|x_{n+1}\right|=\int_{r}^{t} \frac{d s}{\sqrt{(s / r)^{2(n-1)}-1}}, \quad t=\sqrt{x_{1}^{2}+x_{2}^{2}+\cdots x_{n}^{2}}
$$

Here $r$ is called the radius. When $r=1$, this catenoid is said to be standard. Let $t, h, R$ be the solutions of

$$
\begin{equation*}
t^{2}+h^{2}=R^{2} \quad \text { and } \quad|h|=\int_{1}^{t} \frac{d s}{\sqrt{s^{2(n-1)}-1}} \tag{B.1}
\end{equation*}
$$

For a standard catenoid $\mathcal{C}$, we have that
(1) for $n=2, \log t<|h|<\log (2 t)$ and for $n \geq 3,|h|<1.31103$;
(2) $|A(x)| \leq \sqrt{n(n-1)}$ and $|x||A| \rightarrow 0$ as $|x| \rightarrow \infty$;
(3) for each connected component $\gamma$ of $\partial B_{R}(0) \cap \mathcal{C}$, it bounds an $n$-dimensional ball $D$ with area $\frac{\Omega_{n-1}}{n} t^{n}$, where $\Omega_{n-1}$ is the area of unit ( $n-1$ )-sphere;
(4) for $4 \leq(n+1) \leq 7$,

$$
\begin{equation*}
\mathcal{A}_{n}:=\lim _{R \rightarrow \infty} \operatorname{Area}\left(\mathcal{C} \cap B_{R}(0)\right)-2 \cdot \frac{\Omega_{n-1}}{n} t^{n}>0 ; \tag{B.2}
\end{equation*}
$$

(5) for $n=2$,

$$
\begin{equation*}
\operatorname{Area}\left(\mathcal{C} \cap B_{R}(0)\right)-2 \operatorname{Area}(D)=2 \pi\left(|h|+t \sqrt{t^{2}-1}\right)-2 \pi t^{2}>2 \pi(\log R-1) \tag{B.3}
\end{equation*}
$$

Note that outside $B_{2}(0), \mathcal{C}$ has two connected components $\Sigma^{1}$ and $\Sigma^{2}$. Here we assume $\Sigma^{1} \subset$ $\left\{x_{n+1}<0\right\}$. Then $\Sigma^{2}$ is a graph over $\Sigma^{1}$. Let $w$ denote the graph function. Denote by $\boldsymbol{\eta}$ the unit outward normal to $\partial B_{R}(0) \cap \Sigma^{1}$ of $B_{R}(0) \cap \Sigma^{1}$.

Proposition B.1.

$$
\lim _{R \rightarrow \infty} \frac{1}{\Omega_{n-1}} \int_{\Sigma_{k}^{1} \cap \partial B_{R}(0)}\langle\nabla w, \boldsymbol{\eta}\rangle=2 .
$$

Proof of Proposition B.1. By computation,

$$
\partial_{h}=\left(-\sqrt{t^{2 n-2}-1} Y, 1\right)
$$

where $Y=\left(y_{1}, y_{2}, \cdots, y_{n}\right)$ with $|Y|=1$. Then the normal line at $(t Y, h)$ intersects $\mathcal{C}$ at another point

$$
P=\left(t_{h} Y, z_{h}\right),
$$

where $z_{h}>0$ is given by

$$
\begin{equation*}
z_{h}=h+\left(t_{h}-t\right) \sqrt{t^{2 n-2}-1} . \tag{B.4}
\end{equation*}
$$



Figure III. The normal line of a catenoid.

Observe that $z_{h}>0$ and $h<0$. Then by (B.4), $t_{h}>t$. By (B.1), $z_{h}<2 \log t_{h}<t_{h}$ and $|h|<2 \log t<t$ for large $t$. Plugging them into (B.4), it follows that

$$
t_{h}+t>z_{h}-h=\left(t_{h}-h\right) \sqrt{t^{2 n-2}-1} \geq 3\left(t_{h}-t\right)
$$

which implies that $t_{h}<2 t$. Plugging it back into (B.4) again,

$$
2 \log (2 t)+2 \log t>z_{h}-h=\left(t_{h}-t\right) \sqrt{t^{2 n-2}-1}>\left(t_{h}-t\right)(t-1) .
$$

It follows that $t<t_{h}<t+1$ for large $t$. Observe that by (B.1),

$$
\partial_{h} t_{h}=\partial_{h} z_{h} \cdot \sqrt{t_{h}^{2 n-2}-1} ; \quad \partial_{h} t=-\sqrt{t^{2 n-2}-1}
$$

Differentiating both sides in ( $\overline{\mathrm{B} .4})$, we then have

$$
\partial_{h} t_{h}=1+\left(\partial_{h} t_{h}+\partial_{h} t\right) \sqrt{t^{2 n-2}-1}+\left(t_{h}-t\right)(n-1) \frac{t^{2 n-3} \cdot \partial_{h} t}{\sqrt{t^{2 n-2}-1}} .
$$

Combining them together, it follows that

$$
\partial_{h} z_{h}=\frac{t^{2 n-2}-\left(t_{h}-t\right)(n-1) t^{2 n-3}}{1-\sqrt{\left(t_{h}^{2 n-2}-1\right)\left(t^{2 n-2}-1\right)}} \rightarrow-1 \quad \text { as } \quad h \rightarrow-\infty .
$$

Note that

$$
w^{2}=\left(t_{h}-t\right)^{2}+\left(z_{h}-h\right)^{2} .
$$

Then by computation,

$$
\begin{aligned}
\partial_{h} w^{2} & =2\left(t_{h}-t\right)\left(\sqrt{t_{h}^{2 n-2}-1} \partial_{h} z_{h}+\sqrt{t^{2 n-2}-1}\right)+2\left(z_{h}-h\right)\left(\partial_{h} z_{h}-1\right) \\
& =2 \cdot\left(\frac{\sqrt{t_{h}^{2 n-2}-1}}{\sqrt{t^{2 n-2}-1}}+1\right) \cdot\left(z_{h}-h\right) \partial_{h} z_{h}
\end{aligned}
$$

which implies that

$$
\lim _{h \rightarrow-\infty} \partial_{h} w=\lim _{h \rightarrow-\infty}-\frac{2\left(z_{h}-h\right)}{w}=\lim _{h \rightarrow-\infty}-2 \cdot \frac{\left(t_{h}-t\right) \sqrt{t^{2 n-2}-1}}{t^{n-1}\left(t_{h}-t\right)}=-2 .
$$

On the other hand,

$$
\frac{1}{\Omega_{n-1}} \int_{\Sigma \cap\left\{x_{n+1}=h\right\}}\langle\nabla w, \boldsymbol{\eta}\rangle=\frac{1}{\Omega_{n-1}} \int_{\Sigma \cap\{z=h\}} \frac{-\partial_{h} w}{t^{n-1}}=-\partial_{h} w
$$

This finishes the proof of Proposition B.1.
