# Boundary concentration of peak solutions for fractional Schrödinger-Poisson system

#### Abstract

The goal of this paper is to study the existence of peak solutions for the following fractional Schrödinger-Poisson system: $$
\begin{cases}\varepsilon^{2 s}(-\Delta)^{s} u+u+\phi u=u^{p}, & \text { in } \Omega, \\ (-\Delta)^{s} \phi=u^{2}, & \text { in } \Omega, \\ u=\phi=0, & \text { in } \mathbb{R}^{N} \backslash \Omega,\end{cases}
$$ where $s \in(0,1), N>2 s, p \in\left(1, \frac{N+2 s}{N-2 s}\right), \Omega$ is a bounded domain in $\mathbb{R}^{N}$ with Lipschitz boundary, and $(-\Delta)^{s}$ is the fractional Laplacian operator, $\varepsilon$ is a small positive parameter. By using the Lyapunov-Schmidt reduction method, we construct a single peak solution $\left(u_{\varepsilon}, \phi_{\varepsilon}\right)$ such that the peak of $u_{\varepsilon}$ is in the domain but near the boundary. In order to characterize the boundary concentration of solutions, which concentrates at an approximate distance $\varepsilon^{2 / 3}$ away from the boundary $\partial \Omega$ as $\varepsilon$ tends to 0 , some new estimates and analytic technique are used.

Keywords: Fractional Schrödinger-Poisson system; Peak solutions; Boundary concentration; Lyapunov-Schmidt reduction.

## 1 Introduction

Let $\Omega$ be a bounded domain in $\mathbb{R}^{N}$ with Lipschitz boundary, we consider the following fractional Schrödinger-Poisson system

$$
\begin{cases}\varepsilon^{2 s}(-\Delta)^{s} u+u+\phi u=u^{p}, & \text { in } \Omega  \tag{1.1}\\ (-\Delta)^{s} \phi=u^{2}, & \text { in } \Omega, \\ u=\phi=0, & \text { in } \mathbb{R}^{N} \backslash \Omega\end{cases}
$$

where $s \in(0,1), p \in\left(1, \frac{N+2 s}{N-2 s}\right), N>2 s, \varepsilon$ is a small positive parameter, and $(-\Delta)^{s}$ is the fractional Laplacian operator defined by

$$
(-\Delta)^{s} w(x):=C_{N, s} \text { P.V. } \int_{\mathbb{R}^{N}} \frac{w(x)-w(y)}{|x-y|^{N+2 s}} d y=2 \lim _{\epsilon \rightarrow 0^{+}} \int_{\mathbb{R}^{N} \backslash B_{\epsilon}(x)} \frac{w(x)-w(y)}{|x-y|^{N+2 s}} d y
$$

where $C_{N, s}=2^{2 s-1} \pi^{-\frac{N}{2}} \frac{\Gamma\left(\frac{N+2 s}{2 s}\right)}{\Gamma(-s)}$. From the definition of $(-\Delta)^{s}$, we can know that the fractional Laplacian problems are nonlocal. The fractional spaces and the corresponding nonlocal equations have many important applications in various fields of science and engineering, we refer to [23] and references therein.

This paper deals with the semiclassical limit of system (1.1), i.e. it is concerned with the problem of finding nontrivial solutions and studying their asymptotic behavior when $\varepsilon \rightarrow 0^{+}$; hence such solutions are usually referred to as semiclassical ones. The analysis of the SchrödingerPoisson equations in the limit $\varepsilon \rightarrow 0^{+}$is not only a challenging mathematical task, but also of some relevance for understanding of a wide class of quantum phenomena. Indeed, according to the correspondence principle, letting $\varepsilon$ tends to zero in the Schrödinger equation formally describes the transition from quantum mechanics to classical mechanics; it is therefore interesting to study which kind of semiclassical phenomena system (1.1) exhibits.

When $s=1$ and $\Omega=\mathbb{R}^{3}$, (1.1) has been investigated by [59] and also [53] for $\Omega=\mathbb{R}^{N}(3 \leq$ $N \leq 6$ ), and $[10,36,39,40,62]$ for different potentials. When $s \in(0,1)$ and $\Omega=\mathbb{R}^{3}$, (1.1) has received much attentions, see $[38,46,47,48,49,50,51,54]$ and references therein. The previous results are constructing single or multiply peak solutions whose peaks concentrate near the critical points of potentials.

When $s=1, \Omega \subset \mathbb{R}^{3}$ and $V \equiv 1$, the system (1.1) is related to the follwoing MaxwellSchrödinger system

$$
\begin{cases}-\varepsilon^{2} \Delta u+u+\omega \phi u=\gamma u^{p}, & \text { in } \Omega  \tag{1.2}\\ -\Delta \phi=4 \pi \omega u^{2}, & \text { in } \Omega \\ u=\phi=0, & \text { on } \partial \Omega\end{cases}
$$

where $\varepsilon=\frac{\hbar}{\sqrt{2 m}}>0, m$ is the mass of the particle and $\hbar$ is the Planck's constant, $\omega>0$ denotes the electric charge of the partial and $\gamma>0, p>1$. This system arises in Quantum Mechanics:
in 1998 Benci and Fortunato [5] have proposed it as a model describing the interaction of a changed partial with the electrostatic field. The unknowns of the system are the wave function $u$ associated to the partial and the electric potential $\phi$. The presence of the nonlinear term in (1.2) simulates the interaction effect among many partial. See [55] for a deeper analysis on the physical motivation of this system.

The study of the semiclassical limit for Schrödinger-Poisson system has been considered, such as $[11,12,13,14,58]$ with $\gamma=\varepsilon^{(p-1) / 2}$ and $1<p<\frac{11}{7}$. In such papers problem (1.2) is studied and it is proved that the radial solutions exhibit some kind of notable concentration behavior: their form consists of very sharp peaks which become highly concentrated when $\varepsilon$ is small. More precisely, when $\Omega=\mathbb{R}^{3}$, problem (1.2) is know to have clustered solutions, i.e. a combination of several interacting peaks concentrating at the same point as $\varepsilon \rightarrow 0^{+}[11,13,58]$. When $\Omega$ is the unit ball $B_{1}$ of $\mathbb{R}^{3}$, D'Aprile and Wei [12] constructed a radial solution $\left(u_{\varepsilon}, \phi_{\varepsilon}\right)$ such that $u_{\varepsilon}$ concentrates at a distance $(\varepsilon / 2)|\log \varepsilon|$ away from the boundary $\partial B_{1}$ as $\varepsilon \rightarrow 0^{+}$, and with additional conditions about $\omega$, D'Aprile and Wei [14] also have constructed a radial solution $\left(u_{\varepsilon}, \phi_{\varepsilon}\right)$ such that $u_{\varepsilon}$ concentrates on a sphere in the interior of $B_{1}$ as $\varepsilon \rightarrow 0^{+}$. Moreover, in [16] clusters are proved to exist for (1.2) with general nonlinearities in a bounded and smooth domain $\Omega \subset \mathbb{R}^{3}$ and the location of the peaks is identified asymptotically in the terms of the Robin's function of $\Omega$. What's more, when $\Omega \subset \mathbb{R}^{3}$ is a smooth and bounded domain and $\gamma=\omega=1$ with general nonlinearities, in [15] D'Aprile and Wei have proved that (1.2) has a least-energy solution $u_{\varepsilon}$ which develops, as $\varepsilon \rightarrow 0^{+}$, a single spike layer located near the boundary. And when $\Omega=\mathbb{R}^{N}(3 \leq N \leq 6)$ and $\gamma=\omega=1$ with general nonlinearities, in [41] Ianni and Vaira have constructed infinite non-radial and sign-changing peak solutions for system (1.2) and the peaks are displaced in suitable symmetric configurations and collapse to the same point as $\varepsilon \rightarrow 0^{+}$. For more results about systems, such as FitzHugh-Nagumo type, see [27, 29, 30, 31, 32, 33, 65].

On the other hand, consider the following Schrödinger equation

$$
\begin{equation*}
\varepsilon^{2 s}(-\Delta)^{s} u+V(x) u=u^{p} \quad \text { in } \quad \Omega \subset \mathbb{R}^{N} \tag{1.3}
\end{equation*}
$$

with Dirichlet or Neumann boundary conditions, where $s \in(0,1], 1<p<\frac{N+2 s}{N-2 s}$ if $N>2 s$ and $1<p<\infty$ if $N \leq 2 s$, and $V: \Omega \rightarrow \mathbb{R}$ is an assigned potential, in order to understand where concentration occurs and what the profile of the solutions should be. When $s=1$, there exist solutions with an arbitrary large number of interior peaks near the critical points of $V$ (see $[3,4,19,20,21,42,43])$ or, in the case $V \equiv$ constant, near the critical points of the distance from the boundary (see $[26,37,56,63]$ ), while spikes at the boundary are founded at the critical points of the mean curvature (see e.g. [22, 44, 64]), and there is an interesting result that if $\mathbb{R}^{N} \backslash \Omega$ is a bounded open set, i.e. $\Omega$ is an unbounded closed domain, Dancer and Yan [28] proved that (1.3) has at least one two-peak solution. Moreover, they also showed if $\mathbb{R}^{N} \backslash \Omega$ is convex, then both of the peaks of any two-peak solution for (1.3) must tend to infinity as $\varepsilon \rightarrow 0$, and (1.3) has no single peak solution if $\mathbb{R}^{N} \backslash \Omega$ is convex. When $s \in(0,1)$ with zero Dirichlet datum, there exist single or multiply peak solutions or cluster solutions which concentrate at the non-degenerate critical points or local extreme points of $V$ (see $[7,8,18,52,61]$ ) or, in the case $V \equiv$ constant. However, there are few literatures about peak solutions for standard equation (1.3), Dávila et al. [17] constructed a single peak solution whose peak is strictly in the domain, and see $[9,57]$ with Neumann type boundary condition.

Now, let us go on stating our problem. It's well known that when $N \leq 6 s$ (see Section 2), for each $\varphi, \psi$, let $\Phi[\varphi \psi]$ be the unique solution of the the following problem

$$
\begin{cases}(-\Delta)^{s} \phi=\varphi \psi & \text { in } \Omega  \tag{1.4}\\ \phi=0 & \text { in } \mathbb{R}^{N} \backslash \Omega\end{cases}
$$

Then we can see that (1.1) is equivalent to the following fractional Schrödinger problem

$$
\begin{cases}\varepsilon^{2 s}(-\Delta)^{s} u+u+\Phi\left[u^{2}\right] u=u^{p} & \text { in } \Omega  \tag{1.5}\\ u=0 & \text { in } \mathbb{R}^{N} \backslash \Omega\end{cases}
$$

Let us consider the following limiting problem:

$$
\begin{equation*}
(-\Delta)^{s} U+U=U^{p} \text { in } \mathbb{R}^{N}, \quad U \in H^{s}\left(\mathbb{R}^{N}\right), \quad U(0)=\max _{y \in \mathbb{R}^{N}} U(y) \tag{1.6}
\end{equation*}
$$

The uniqueness, decaying behavior and non-degeneration of the positive solutions to problem (1.6) was first obtained by Frank, Lenzmann [34] in $\mathbb{R}$. Later, Frank, Lenzmann and Silvestre [35] obtained the following important result.
Theorem A. When $p \in\left(1, \frac{N+2 s}{N-2 s}\right)$ for $N>2 s$ or $p \in(1, \infty)$ for $N \leq 2 s$, problem (1.6) has a unique (up to translation) positive solution $U$ which is radial and strictly decreasing in $|x|$. Moreover, there exist $0<\alpha \leq \beta$ such that

$$
\begin{equation*}
\frac{\alpha}{1+|x|^{N+2 s}} \leq U(x) \leq \frac{\beta}{1+|x|^{N+2 s}}, \quad \forall x \in \mathbb{R}^{N} . \tag{1.7}
\end{equation*}
$$

Furthermore, $U$ is non-degenerate in the sense that the linear operator defined by

$$
L:=(-\Delta)^{s}+U-p U^{p-1}
$$

satisfies

$$
\begin{equation*}
\operatorname{ker} L \cap L^{2}\left(\mathbb{R}^{N}\right)=\operatorname{Span}\left\{\frac{\partial U}{\partial x_{1}}, \frac{\partial U}{\partial x_{2}}, \ldots, \frac{\partial U}{\partial x_{N}}\right\} \tag{1.8}
\end{equation*}
$$

Then, we begin to construct the approximate solution as follows: denote $U_{\varepsilon, \xi}(x)=U\left(\frac{x-\xi}{\varepsilon}\right)$ and let $P_{\varepsilon, \Omega} U_{\varepsilon, \xi}$ be the solution of

$$
\begin{cases}\varepsilon^{2 s}(-\Delta)^{s} u+u=U_{\varepsilon, \xi}^{p} & \text { in } \Omega  \tag{1.9}\\ u=0 & \text { in } \mathbb{R}^{N} \backslash \Omega\end{cases}
$$

Our main result of this paper can be stated as following.

Theorem 1.1. Suppose that $s \in(0,1), 2 s<N \leq 6 s$ and $p \in\left(1, \frac{N+2 s}{N-2 s}\right)$. Then there exists $\varepsilon_{0}>0$ such that for each $\varepsilon \in\left(0, \varepsilon_{0}\right)$, problem (1.5) has a solution $u_{\varepsilon}$ of the form

$$
\begin{equation*}
u_{\varepsilon}=P_{\varepsilon, \Omega} U_{\varepsilon, \xi_{\varepsilon}}+\omega_{\varepsilon, \xi_{\varepsilon}} \tag{1.10}
\end{equation*}
$$

where $\xi_{\varepsilon} \in \Omega$ satisfies $d\left(\xi_{\varepsilon}, \partial \Omega\right) \rightarrow 0, \frac{d\left(\xi_{\varepsilon}, \partial \Omega\right)}{\varepsilon} \rightarrow+\infty$, and $\omega_{\varepsilon, \xi_{\varepsilon}}$ satisfies

$$
\int_{\Omega}\left(\varepsilon^{2 s}\left|(-\Delta)^{\frac{s}{2}} \omega_{\varepsilon, \xi_{\varepsilon}}\right|^{2}+\omega_{\varepsilon, \xi_{\varepsilon}}^{2}\right)=\varepsilon^{N} o\left(\varepsilon^{\frac{N+4 s}{3}}\right)
$$

More precisely, $d\left(\xi_{\varepsilon}, \partial \Omega\right) \in\left(\varepsilon^{\frac{2}{3}+\theta}, \varepsilon^{\frac{2}{3}-\theta}\right)$ for any small $\theta>0$.
Remark 1.1. We remark that the existence of peak solutions for (1.5) with $s=1$ and more general nonlinearities, has been obtained by D'Aprile and Wei [15], and our proof is mainly inspired by their work, and also [28, 29]. In contrast to previous literatures for the Laplace case, the fractional Laplacian $(-\Delta)^{s}$ with $0<s<1$ on $\mathbb{R}^{N}$ is nonlocal, standard techniques for Laplacian may not be carried out directly. Actually, the fractional Laplacian has some features which are essentially different from the Laplacian. For example, the ground state for (1.6) with $0<s<1$ decays algebraically at infinity, while that of Laplace problems decays exponentially at infinity. Hence, in deal with the fractional Laplacian, new techniques are needed to be developed. In particular, thanks to the work of the authors of [24] who have established the Green's formula corresponding to fractional Laplacian $(-\Delta)^{s}$, we will establish new basic estimates and give a precise estimation of the energy functional at the approximate solutions.

This paper is arranged as follows. In Section 2, we give the necessary functional settings in order to treat our problem and introduce the Lyapunov-Schmidt reduction method as clearly as possible. In Section 3, we give some preliminary estimates particularly for $\Phi\left[U_{\varepsilon, \xi}^{2}\right]$. As we will see that the main contributions to the energy functional of (1.5) are from the term $\int_{\Omega} U_{\varepsilon, \xi}^{2} \Phi\left[U_{\varepsilon, \xi}^{2}\right]$ as well as the geometry of the domain. In Section 4, we will calculate the energy functional $J_{\varepsilon}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)$ associated to (1.5), particularly for the estimate of $\int_{\Omega}\left(U_{\varepsilon, \xi}\right)^{p}\left(U_{\varepsilon, \xi}-P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)$. Then, in Section 5, we prove some technical lemmas and develop the reduction. Finally, in Section 6, we will prove Theorem 1.1 and give some remarks.

Notation. The symbols $c, C$ will denote positive constants whose exact value may change from line to line still being independent of $\varepsilon$.

## 2 Functional setting and the reduction method

In this section, we first recall some useful information of the fractional order Sobolev spaces. We refer to $[1,23,60,8]$ for more details. Consider the Schwartz space $\mathcal{W}$ of rapidly decaying $C^{\infty}$ functions on $\mathbb{R}^{N}$. The topology of this space is generated by the seminorms

$$
P_{k}(\varphi)=\sup _{x \in \mathbb{R}^{N}}\left(1+|x|^{k}\right) \sum_{|\nu| \leq k}\left|D^{\nu} \varphi(x)\right|, \quad k=0,1,2 \ldots
$$

where $\varphi \in \mathcal{W}$. Let $\mathcal{W}^{\prime}$ be the set of all tempered distributions, which is the topological dual of $\mathcal{W}$. As usual, for any $\varphi \in \mathcal{W}$, we denote by

$$
\mathcal{F} \varphi(\rho)=(2 \pi)^{-\frac{N}{2}} \int_{\mathbb{R}^{N}} e^{-i \rho \cdot x} \varphi(x) d x
$$

the Fourier transformation of $\varphi$ and we recall that one can extend $\mathcal{F}$ from $\mathcal{W}$ to $\mathcal{W}^{\prime}$.
We define the classical fractional Sobolev space $H^{s}\left(\mathbb{R}^{N}\right)$,

\begin{aligned}
H^{s}\left(\mathbb{R}^{N}\right): & =\left\{u \in L^{2}\left(\mathbb{R}^{N}\right): \int_{\mathbb{R}^{N}}\left(1+|\rho|^{2 s}\right)|\mathcal{F} u(\rho)|^{2} d \rho<\infty\right\} \\
& =\left\{u \in L^{2}\left(\mathbb{R}^{N}\right): \frac{|u(x)-u(y)|}{|x-y|^{\frac{N}{2}+s}} \in L^{2}\left(\mathbb{R}^{N} \times \mathbb{R}^{N}\right)\right\},
\end{aligned}
$$

endowed with the norm

$$
\|u\|_{H^{s}\left(\mathbb{R}^{N}\right)}^{2}=\|u\|_{L^{2}\left(\mathbb{R}^{N}\right)}^{2}+\frac{C_{N, s}}{2} \iint_{\mathbb{R}^{N} \times \mathbb{R}^{N}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{N+2 s}} d x d y .
$$

It is clear that $H^{s}\left(\mathbb{R}^{N}\right)$ is a Hilbert space. We define also the $H_{0}^{s}(\Omega)$ space,

$$
\begin{equation*}
H_{0}^{s}(\Omega):=\left\{u \in H^{s}\left(\mathbb{R}^{N}\right): u=0 \text { in } \mathbb{R}^{N} \backslash \Omega\right\} \tag{2.1}
\end{equation*}
$$

endowed with the norm

$$
\|u\|_{H_{0}^{s}(\Omega)}^{2}=\|u\|_{L^{2}(\Omega)}^{2}+\iint_{\mathcal{D}_{\Omega}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{N+2 s}} d x d y
$$

where the set $\mathcal{D}_{\Omega}$ is given by $\mathcal{D}_{\Omega}:=\left(\mathbb{R}^{N} \times \mathbb{R}^{N}\right) \backslash(\mathcal{C} \Omega \times \mathcal{C} \Omega), \quad \mathcal{C} \Omega=\mathbb{R}^{N} \backslash \Omega$. Denote

$$
\begin{equation*}
\langle u, v\rangle_{\varepsilon}=\int_{\mathbb{R}^{N}}\left(\varepsilon^{2 s}(-\Delta)^{\frac{s}{2}} u(-\Delta)^{\frac{s}{2}} v+u v\right) d x \tag{2.2}
\end{equation*}
$$

and $\|u\|_{\varepsilon}^{2}=\langle u, u\rangle_{\varepsilon}$. Let $\mathbb{H}$ be the completion of the space $C_{0}^{\infty}(\Omega)$ with respect to the norm $\|\cdot\|_{\varepsilon}$ defined as previous. Noticing that for all $u, v \in \mathbb{H}$, we have

$$
\int_{\Omega}\left(\varepsilon^{2 s} v(-\Delta)^{s} u+u v\right) d x=\int_{\mathbb{R}^{N}}\left(\varepsilon^{2 s}(-\Delta)^{\frac{s}{2}} u(-\Delta)^{\frac{s}{2}} v+u v\right) d x
$$

Thus

$$
\begin{equation*}
\|u\|_{\varepsilon}^{2}=\int_{\Omega}\left(\varepsilon^{2 s}\left|(-\Delta)^{\frac{s}{2}} u\right|^{2}+u^{2}\right) d x \tag{2.3}
\end{equation*}
$$

that justify in some sense our choice of the norm $\|\cdot\|_{\varepsilon}$. Since the embedding $H_{0}^{s}\left(\Omega_{\varepsilon, \xi}\right) \hookrightarrow L^{q}\left(\Omega_{\varepsilon, \xi}\right)$ is continuous for $2 \leq q \leq \frac{2 N}{N-2 s}$, then for each $u \in \mathbb{H}$, and denote $\tilde{u}(x)=u(\varepsilon x+\xi)$, we have

$$
\begin{align*}
\int_{\Omega}|u|^{q} d x & =\varepsilon^{N} \int_{\Omega_{\varepsilon, \xi}}|\tilde{u}|^{q} d x \leq C \varepsilon^{N}\left(\int_{\Omega_{\varepsilon, \xi}}\left(\left|(-\Delta)^{\frac{s}{2}} \tilde{u}\right|^{2}+|\tilde{u}|^{2}\right) d x\right)^{\frac{q}{2}}  \tag{2.4}\\
& =C \varepsilon^{N}\left(\varepsilon^{-N} \int_{\Omega}\left(\varepsilon^{2 s}\left|(-\Delta)^{\frac{s}{2}} u\right|^{2}+|u|^{2}\right) d x\right)^{\frac{q}{2}}=C \varepsilon^{\left(1-\frac{q}{2}\right) N}\|u\|_{\varepsilon}^{q}
\end{align*}
$$

that is, $|u|_{q} \leq C \varepsilon^{\left(\frac{1}{q}-\frac{1}{2}\right) N}\|u\|_{\varepsilon}$ for all $2 \leq q \leq \frac{2 N}{N-2 s}$. Moreover, $|u|_{q} \leq C\|u\|_{\varepsilon}$ for all $q \in(1,2]$.
For $\varphi, \psi \in H^{s}\left(\mathbb{R}^{N}\right)$, the linear functional $\mathcal{L}_{\varphi, \psi}$ defined in $\mathbb{H}$ by

$$
\mathcal{L}_{\varphi, \psi}(v)=\int_{\Omega} \varphi \psi v d x
$$

By the Hölder's inequality, we have

$$
\begin{align*}
\left|\mathcal{L}_{\varphi, \psi}(v)\right| & \leq\left(\int_{\Omega}|\varphi \psi|^{\frac{2 N}{N+2 s}} d x\right)^{\frac{N+2 s}{2 N}}\left(\int_{\Omega}|v|^{\frac{2 N}{N-2 s}} d x\right)^{\frac{N-2 s}{2 N}} \\
& \leq\left(\int_{\Omega}|\varphi|^{\frac{4 N}{N+2 s}} d x\right)^{\frac{N+2 s}{4 N}}\left(\int_{\Omega}|\psi|^{\frac{4 N}{N+2 s}} d x\right)^{\frac{N+2 s}{4 N}}\left(\int_{\Omega}|v|^{\frac{2 N}{N-2 s}} d x\right)^{\frac{N-2 s}{2 N}}  \tag{2.5}\\
& \leq C \varepsilon^{-s}\|\varphi\|_{H^{s}\left(\mathbb{R}^{N}\right)}\|\psi\|_{H^{s}\left(\mathbb{R}^{N}\right)}\|v\|_{\varepsilon},
\end{align*}
$$

where we used (2.4) for $\frac{4 N}{N+2 s} \leq \frac{2 N}{N-2 s}$, i.e. $N \leq 6 s$. Hence, by the Lax-Milgram theorem, there exists a unique $\Phi[\varphi \psi] \in \mathbb{H}$ such that

$$
\begin{equation*}
\int_{\Omega}(-\Delta)^{\frac{s}{2}} \Phi[\varphi \psi](-\Delta)^{\frac{s}{2}} v d x=\int_{\Omega} \varphi \psi v d x, \quad v \in \mathbb{H} \tag{2.6}
\end{equation*}
$$

that is $\Phi[\varphi \psi]$ is a weak solution of

$$
(-\Delta)^{s} \phi=\varphi \psi \quad \text { in } \quad \Omega, \quad \phi \in \mathbb{H} .
$$

From (2.5) and (2.6), we have that for each $u \in \mathbb{H}$,

$$
\left\|\Phi\left[u^{2}\right]\right\|_{\varepsilon}^{2} \leq C \int_{\Omega}\left|(-\Delta)^{\frac{s}{2}} \Phi\left[u^{2}\right]\right|^{2} d x=C \int_{\Omega} \Phi\left[u^{2}\right] u^{2} d x \leq C \varepsilon^{-\frac{N}{2}}\|u\|_{\varepsilon}^{2}\left\|\Phi\left[u^{2}\right]\right\|_{\varepsilon},
$$

that is

$$
\left\|\Phi\left[u^{2}\right]\right\|_{\varepsilon} \leq C \varepsilon^{-\frac{N}{2}}\|u\|_{\varepsilon}^{2}, \quad \text { if } \quad N \leq 6 s
$$

Thus

$$
\begin{equation*}
\int_{\Omega} \Phi\left[u^{2}\right] u^{2} d x \leq C \varepsilon^{-N}\|u\|_{\varepsilon}^{4}, \quad \text { if } \quad N \leq 6 s \tag{2.7}
\end{equation*}
$$

Moreover, let us consider the problem

$$
(-\Delta)^{s} W=\varphi \psi \quad \text { in } \quad \mathbb{R}^{N}, \quad W \in H^{s}\left(\mathbb{R}^{N}\right)
$$

then by the representation formula holds

$$
\begin{equation*}
W[\varphi \psi](x)=c_{N, s} \int_{\mathbb{R}^{N}} \frac{\varphi(y) \psi(y)}{|x-y|^{N-2 s}} d y, \quad x \in \mathbb{R}^{N}, \tag{2.8}
\end{equation*}
$$

which is called $s$-Riesz potential, where $c_{N, s}$ is a constant depending only on $N$ and $s$. Thus, by the comparison theorem, we have

\Phi[\varphi \psi] \leq \Phi[|\varphi \psi|] \leq W[|\varphi \psi|] \quad \text { for all } \quad \varphi, \psi \in H^{s}\left(\mathbb{R}^{N}\right) \tag{2.9}
\end{equation*}
$$

Proposition 2.1. (Hardy-Littlewood-Sobolev inequality [45]) Let $r, t>1$ and $0<\mu<N$ with $\frac{1}{r}+\frac{1}{t}+\frac{\mu}{N}=2, u \in L^{r}\left(\mathbb{R}^{N}\right)$ and $v \in L^{t}\left(\mathbb{R}^{N}\right)$. There exists a sharp constant $C(r, t, \mu, N)$, independent of $u$ and $v$, such that

\int_{\mathbb{R}^{N}}\left[\frac{1}{|x|^{\mu}} * u(x)\right] v(x) d x \leq C(r, t, \mu, N)|u|_{r}|v|_{t}
$$

Thus, by the above inequality and (2.4), (2.9), we get that when $N \leq 6 s$, for all $u \in \mathbb{H}$,

\int_{\Omega} \Phi\left[u^{2}\right] u^{2} d x & \leq \int_{\Omega} W\left[u^{2}\right] u^{2} d x=c_{N, s} \int_{\Omega} \int_{\Omega} \frac{u^{2}(y) u^{2}(x)}{|x-y|^{N-2 s}} d y d x \\
& \leq c_{N, s}\left(\int_{\Omega} u^{\frac{4 N}{N+2 s}} d x\right)^{\frac{N+2 s}{N}} \leq C \varepsilon^{2 s-N}\|u\|_{\varepsilon}^{4} \tag{2.10}
\end{align*}
$$

Substituting $\Phi\left[u^{2}\right]$ in (1.1), then we can see that (1.1) with $V \equiv 1$ is equivalent to the following fractional Schrödinger problem:

\begin{cases}\varepsilon^{2 s}(-\Delta)^{s} u+u+\Phi\left[u^{2}\right] u=u^{p} & \text { in } \Omega \\ u=0 & \text { in } \mathbb{R}^{N} \backslash \Omega\end{cases}
$$

The energy functional associated with (1.5) is

\begin{align*}
J_{\varepsilon}(u) & =\frac{\varepsilon^{2 s} C_{N, s}}{2} \iint_{\mathcal{D}_{\Omega}} \frac{|u(x)-u(y)|^{2}}{|x-y|^{N+2 s}} d x d y+\frac{1}{4} \int_{\Omega} \Phi[u] u^{2} d x-\int_{\Omega}\left(\frac{u^{p+1}}{p+1}-\frac{u^{2}}{2}\right) d x  \tag{2.11}\\
& =\frac{1}{2}\|u\|_{\varepsilon}^{2}+\frac{1}{4} \int_{\Omega} \Phi\left[u^{2}\right] u^{2} d x-\frac{1}{p+1} \int_{\Omega} u^{p+1} d x
\end{align*}
$$

Define

$$
\begin{equation*}
E_{\varepsilon, \xi}:=\left\{\omega \in \mathbb{H}:\left\langle\omega, \frac{\partial P_{\varepsilon, \Omega} U_{\varepsilon, \xi}}{\partial \xi_{i}}\right\rangle_{\varepsilon}=0, i=1,2, \ldots, N\right\} \tag{2.12}
\end{equation*}
$$

where $\xi=\left(\xi_{1}, \ldots, \xi_{N}\right) \in \mathbb{R}^{N}$. Let $D_{\varepsilon, R}:=\{\xi: \xi \in \Omega, R \varepsilon \leq d(\xi, \partial \Omega) \leq 1 / R\}$, where $R>0$ is a large constant. In Section 6, we will choose $\xi \in D_{\varepsilon, R}$ for suitable domain $D_{\varepsilon, R}$ such that $\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}+\omega_{\varepsilon, \xi}\right)$ is a solution of (1.5). Let

K(\xi, \omega)=J_{\varepsilon}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}+\omega\right), \xi \in D_{\varepsilon, R}, \omega \in E_{\varepsilon, \xi}
$$

We expand $K(\xi, \omega)$ near $\omega=0$ as

K(\xi, \omega)=K(\xi, 0)+L_{\varepsilon, \xi}(\omega)+\frac{1}{2} Q_{\varepsilon, \xi}(\omega, \omega)+R_{\varepsilon}(\omega)
$$

where

$$
\begin{equation*}
L_{\varepsilon, \xi}(\omega)=\left\langle P_{\varepsilon, \Omega} U_{\varepsilon, \xi}, \omega\right\rangle_{\varepsilon}+\int_{\Omega} \Phi\left[P_{\varepsilon, \Omega}^{2} U_{\varepsilon, \xi}\right] P_{\varepsilon, \Omega} U_{\varepsilon, \xi} \omega d x-\int_{\Omega}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)^{p} \omega d x \tag{2.13}
\end{equation*}
$$

$$
\begin{align*}
Q_{\varepsilon, \xi}(\omega, \eta)= & \langle\omega, \eta\rangle_{\varepsilon}-p \int_{\Omega}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)^{p-1} \omega \eta d x+\int_{\Omega} \Phi\left[P_{\varepsilon, \Omega}^{2} U_{\varepsilon, \xi}\right] \omega \eta d x  \tag{2.14}\\
& +2 \int_{\Omega} \Phi\left[\omega P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right] P_{\varepsilon, \Omega} U_{\varepsilon, \xi}(x) \eta(x) d x, \quad \forall \omega, \quad \eta \in \mathbb{H},
\end{align*}
$$

and

$$
\begin{align*}
R_{\varepsilon}(\omega)= & \int_{\Omega} \Phi\left[\omega^{2}\right] P_{\varepsilon, \Omega} U_{\varepsilon, \xi} \omega d x+\frac{1}{4} \int_{\Omega} \Phi\left[\omega^{2}\right] \omega^{2} d x-\frac{1}{p+1} \int_{\Omega}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}+\omega\right)^{p+1} d x  \tag{2.15}\\
& +\frac{1}{p+1} \int_{\Omega}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)^{p+1} d x+\int_{\Omega}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)^{p} \omega d x+\frac{p}{2} \int_{\Omega}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)^{p-1} \omega^{2} d x .
\end{align*}
$$

We will prove in Lemma 5.1 that $L_{\varepsilon, \xi}: E_{\varepsilon, \xi} \rightarrow \mathbb{R}$ is a bounded linear operator. In particular, by the Riesz representation theorem there is an $l_{\varepsilon, \xi} \in E_{\varepsilon, \xi}$ such that $\left\langle l_{\varepsilon, \xi}, \omega\right\rangle_{\varepsilon}=L_{\varepsilon, \xi}(\omega)$. In Lemma 5.2, we will prove

$$
\left|Q_{\varepsilon, \xi}(\omega, \omega)\right| \leq C\|\omega\|_{\varepsilon}^{2}
$$

where $C$ is a constant independent of $\varepsilon$. In particular, there is a bounded linear operator $\mathcal{A}_{\varepsilon, \xi}: E_{\varepsilon, \xi} \rightarrow E_{\varepsilon, \xi}$ such that $\left\langle\mathcal{A}_{\varepsilon, \xi} \omega, \eta\right\rangle_{\varepsilon}=Q_{\varepsilon, \xi}(\omega, \eta)$. Thus, finding a critical point for $K(\xi, \omega)$ in $E_{\varepsilon, \xi}$ is equivalent to solving the following problem in $E_{\varepsilon, \xi}$ :

$$
\begin{equation*}
l_{\varepsilon, \xi}+\mathcal{A}_{\varepsilon, \xi} \omega+R_{\varepsilon}^{\prime}(\omega)=0 . \tag{2.16}
\end{equation*}
$$

We will prove in Lemma 5.3 that the operator $\mathcal{A}_{\varepsilon, \xi}$ is invertible in $E_{\varepsilon, \xi}$. So we see that $l_{\varepsilon, x}+$ $\mathcal{A}_{\varepsilon, x} \omega=0$ has a unique solution in $E_{\varepsilon, \xi}$ for each fixed $\xi \in D_{\varepsilon, R}$. In Lemma 5.1, we will prove that if $\omega$ belongs to a suitable set, the term $R_{\varepsilon}^{\prime}(\omega)$ is a small perturbation term in (2.16). Thus, we can use the contraction mapping theorem to prove that (2.16) has a unique solution for each fixed $\xi \in D_{\varepsilon, R}$.

## 3 Some preliminary estimates

In this section, we will give some preliminary estimates which are crucial for our result.
Firstly, let us analysis the properties of $U_{\varepsilon, \xi}$ and $P_{\varepsilon, \Omega} U_{\varepsilon, \xi}$. Fix $\xi \in D_{\varepsilon, R}, \xi=\left(\xi_{1}, \xi_{2}, \ldots, \xi_{N}\right)$. From (1.7), we have

$$
\begin{equation*}
U_{\varepsilon, \xi}(x) \leq C\left(\frac{\varepsilon}{d(\xi, \Omega)}\right)^{N+2 s}, \quad \forall x \in \mathbb{R}^{N} \backslash \Omega \tag{3.1}
\end{equation*}
$$

for some $C>0$. Let $\eta_{\varepsilon, \xi}=U_{\varepsilon, \xi}-P_{\varepsilon, \Omega} U_{\varepsilon, \xi}$, then from (1.9) we have

$$
\begin{cases}\varepsilon^{2 s}(-\Delta)^{s} \eta_{\varepsilon, \xi}+\eta_{\varepsilon, \xi}=0 & \text { in } \Omega  \tag{3.2}\\ \eta_{\varepsilon, \xi}=U_{\varepsilon, \xi} & \text { in } \mathbb{R}^{N} \backslash \Omega\end{cases}
$$

Lemma 3.1. There exists a positive constant $C$ such that for any $x \in \mathbb{R}^{N}$, it holds that

$$
\begin{equation*}
0 \leq \eta_{\varepsilon, \xi} \leq C\left(\frac{\varepsilon}{d(\xi, \Omega)}\right)^{N+2 s} \tag{3.3}
\end{equation*}
$$

Proof. By using the estimation (3.1), we have that $\eta_{\varepsilon, \xi} \leq U_{\varepsilon, \xi} \leq C\left(\frac{\varepsilon}{d(\xi, \Omega)}\right)^{N+2 s}$ in $\mathbb{R}^{N} \backslash \Omega$. Hence, by the maximum principle, we can directly get (3.3).

Lemma 3.2. There is $C>0$ such that for every $x \in \mathbb{R}^{N}$,

$$
\begin{equation*}
\Phi\left[U_{\varepsilon, \xi}^{2}\right](x) \leq \frac{C \varepsilon^{2 s}}{1+\left|\frac{x-\xi}{\varepsilon}\right|^{N-2 s}}, \tag{3.4}
\end{equation*}
$$

and

$$
\begin{equation*}
\Phi\left[U_{\varepsilon, \xi}\right](x) \leq \frac{C \varepsilon^{2 s}}{1+\left|\frac{x-\xi}{\varepsilon}\right|^{N-2 s}} \tag{3.5}
\end{equation*}
$$

Proof. We only prove (3.4), and the proof of (3.5) is similar. Noticing that $\Phi\left[U_{\varepsilon, \xi}^{2}\right](\varepsilon x+\xi)=$ $\varepsilon^{2 s} v_{\varepsilon}(x)$ and $v_{\varepsilon}$ satisfies

$$
\begin{cases}(-\Delta)^{s} v_{\varepsilon}=U^{2} & x \in \Omega_{\varepsilon, \xi}, \\ v_{\varepsilon}=0 & x \in \mathbb{R}^{N} \backslash \Omega_{\varepsilon, \xi}\end{cases}
$$

Let $W$ be the solution of the following equation

$$
\begin{equation*}
(-\Delta)^{s} W=U^{2}, \quad W \in H^{s}\left(\mathbb{R}^{N}\right) \tag{3.6}
\end{equation*}
$$

It is well known that

$$
\begin{equation*}
W(x)=c_{N, s} \int_{\mathbb{R}^{N}} \frac{U^{2}(y)}{|y-x|^{N-2 s}} d y, \quad x \in \mathbb{R}^{N} \tag{3.7}
\end{equation*}
$$

where $c_{N, s}$ is a constant depending only on $N$ and $s$. From [17, Lemma 5.1], we have

$$
\begin{equation*}
\frac{C_{1}}{1+|x|^{N-2 s}} \leq W(x) \leq \frac{C_{2}}{1+|x|^{N-2 s}}, \tag{3.8}
\end{equation*}
$$

for some $C_{2} \geq C_{1}>0$. Thus

$$
\begin{aligned}
W(0) & =c_{N, s} \int_{\mathbb{R}^{N}} \frac{U^{2}(y)}{|y|^{N-2 s}} d y \\
& \leq \int_{\mathbb{R}^{N}} \frac{C}{|y|^{N-2 s}\left(1+|y|^{N+2 s}\right)^{2}} d y \\
& =\int_{B_{1}(0)} \frac{C}{|y|^{N-2 s}\left(1+|y|^{N+2 s}\right)^{2}} d y+\int_{\mathbb{R}^{N} \backslash B_{1}(0)} \frac{C}{|y|^{N-2 s}\left(1+|y|^{N+2 s}\right)^{2}} d y \\
& \leq \int_{B_{1}(0)} \frac{C}{|y|^{N-2 s}} d y+\int_{\mathbb{R}^{N} \backslash B_{1}(0)} \frac{C}{\left(1+|y|^{N+2 s}\right)^{2}} d y \leq C^{\prime},
\end{aligned}
$$

and also we can get $W(0) \geq C$. Then fix $x \in \mathbb{R}^{N}$ for $|x| \geq 2$ large and $t:=|x| / 2$, and observe that if $y \in B_{t}(x)$ then $|y| \geq|x|-|x-y| \geq|x|-t=\frac{|x|}{2}$. As a consequence,

$$
\begin{aligned}
\int_{B_{t}(x)} \frac{U^{2}(y)}{|y-x|^{N-2 s}} d y & \leq \int_{B_{t}(x)} \frac{C}{|y-x|^{N-2 s}\left(1+|y|^{N+2 s}\right)^{2}} d y \\
& \leq \int_{B_{t}(x)} \frac{C}{|y-x|^{N-2 s}\left(1+(|x| / 2)^{N+2 s}\right)^{2}} d y \\
& \leq \frac{C}{1+|x|^{2(N+2 s)}} \int_{B_{t}(0)} \frac{1}{|z|^{N-2 s}} d z \\
& \leq \frac{C^{\prime}|t|^{2 s}}{1+|x|^{2(N+2 s)}} \leq \frac{C^{\prime \prime}}{1+|x|^{2 N+2 s}} .
\end{aligned}
$$

Moreover, if $y \in \mathbb{R}^{N} \backslash B_{t}(x)$ then $|y-x| \geq t=\frac{|x|}{2}$, thus

$$
\begin{aligned}
\int_{\mathbb{R}^{N} \backslash B_{t}(x)} \frac{U^{2}(y)}{|y-x|^{N-2 s}} d y & \leq \int_{\mathbb{R}^{N} \backslash B_{t}(x)} \frac{C}{(|x| / 2)^{N-2 s}\left(1+|y|^{N+2 s}\right)^{2}} d y \\
& \leq \frac{C^{\prime}}{|x|^{N-2 s}} \int_{\mathbb{R}^{N}} \frac{1}{\left(1+|y|^{N+2 s}\right)^{2}} d y \\
& \leq \frac{C^{\prime \prime}}{1+|x|^{N-2 s}}
\end{aligned}
$$

Furthermore, if $y \in B_{t}(0)$ then $\frac{3|x|}{2}=3 t \geq|y-x| \geq t=\frac{|x|}{2}$, thus

$$
\begin{aligned}
\int_{B_{t}(0)} \frac{U^{2}(y)}{|y-x|^{N-2 s}} d y & \geq \int_{B_{t}(0)} \frac{C}{(3|x| / 2)^{N-2 s}\left(1+|y|^{N+2 s}\right)^{2}} d y \\
& \geq \frac{C^{\prime}}{|x|^{N-2 s}} \int_{B_{1}(0)} \frac{1}{\left(1+|y|^{N+2 s}\right)^{2}} d y \\
& \geq \frac{C^{\prime \prime}}{1+|x|^{N-2 s}}
\end{aligned}
$$

Thus, (3.8) holds. By the comparison theorem, we have $0<v_{\varepsilon} \leq W$. Thus we have the following estimation of $v_{\varepsilon}$ :

$$
v_{\varepsilon}(x) \leq \frac{C}{1+|x|^{N-2 s}}, \quad \forall x \in \mathbb{R}^{N}
$$

i.e., there exists $C>0$ such that (3.4) holds.

Finally, at the end of this section, let us make a more accurate estimation of $\Phi\left[U_{\varepsilon, \xi}^{2}\right]$.
Lemma 3.3. We have

$$
\Phi\left[U_{\varepsilon, \xi}^{2}\right](x)=\varepsilon^{2 s} W\left(\frac{x-\xi}{\varepsilon}\right)-\varepsilon^{N} B H(\xi, x)+O\left(\mu_{\varepsilon, \xi}\right)
$$

where $W$ is given in (3.7), $B=\int_{\mathbb{R}^{N}} U^{2}, H(\xi, x)$ is the regular part of the Green function of the operator $(-\Delta)^{s}$ with the Dirichlet boundary condition, and $\mu_{\varepsilon, \xi}$ will be defined in (3.13).

Proof. Let $S(x, \xi)$ be the solution of

$$
\begin{cases}(-\Delta)^{s} S=\delta_{\xi} & \text { in } \mathbb{R}^{N}  \tag{3.9}\\ S(x, \xi) \rightarrow 0 & \text { as }|x| \rightarrow \infty\end{cases}
$$

where $\delta_{\xi}$ is the Dirac measure. By a direct calculation, we know that $S(x, \xi)$ behaves like $\frac{1}{|x-\xi|^{N-2 s}}$, i.e.

$$
S(x, \xi) \simeq \frac{C}{|x-\xi|^{N-2 s}}
$$

Then

$$
\Phi\left[U_{\varepsilon, \xi}^{2}\right](x)=\int_{\Omega}(S(y, x)-H(y, x)) U_{\varepsilon, \xi}^{2}(y) d y
$$

Since $H(x, \xi)$ is the regular part of the Green function of the operator $(-\Delta)^{s}$ with the Dirichlet boundary condition, i.e.

$$
\begin{cases}(-\Delta)_{x}^{s} H(x, \xi)=0 & \text { in } \Omega  \tag{3.10}\\ H(x, \xi)=S(x, \xi) & \text { in } \mathbb{R}^{N} \backslash \Omega\end{cases}
$$

we have

$$
\begin{equation*}
\left|D_{x}^{l} H(x, \xi)\right| \leq \frac{C}{d(\xi, \partial \Omega)^{N-2 s+l}}, \quad l=0,1,2 . \tag{3.11}
\end{equation*}
$$

By using the mean value theorem, we have

$$
\begin{align*}
& \int_{\Omega} H(y, x) U_{\varepsilon, \xi}^{2}(y) d y \\
= & \varepsilon^{N} \int_{\Omega_{\varepsilon, \xi}} H(\varepsilon z+\xi, x) U^{2}(z) d z \\
= & \varepsilon^{N} \int_{\Omega_{\varepsilon, \xi}}\left[H(\xi, x)+\sum_{k=1}^{N} \varepsilon D_{k} H(\xi, x) \cdot z_{k}+O\left(\sum_{i, j>0}^{N} \varepsilon^{2} D_{i j} H(\xi, x) \cdot z_{i} z_{j}\right)\right] U^{2}(z) d z \\
= & \varepsilon^{N} H(\xi, x)\left(B-\int_{\mathbb{R}^{N} \backslash \Omega_{\varepsilon, \xi}} U^{2}(z) d z\right)+\varepsilon^{N+1} \sum_{k=1}^{N} D_{k} H(\xi, x) \int_{\Omega_{\varepsilon, \xi}} z_{k} U^{2}(z) d z \\
& +O\left(\varepsilon^{N+2} \sum_{i, j>0}^{N} D_{i j} H(\xi, x) \int_{\Omega_{\varepsilon, \xi}} z_{i} z_{j} U^{2}(z) d z\right) \tag{3.12}
\end{align*}
$$

where $\Omega_{\varepsilon, \xi}=\{x: \varepsilon x+\xi \in \Omega\}$. Since $B_{\frac{d(\xi, \partial \Omega)}{\varepsilon}}(0) \subset \Omega_{\varepsilon, \xi}$ and by the behavior of $U$, we obtain

\int_{\mathbb{R}^{N} \backslash \Omega_{\varepsilon, \xi}} U^{2}(z) d z & \leq \int_{\mathbb{R}^{N} \backslash B_{\frac{d(\xi, \partial \Omega)}{\varepsilon}}(0)} U^{2}(z) d z \\
& \leq C \int_{\mathbb{R}^{N} \backslash B_{\frac{d(\xi, \partial \Omega)}{\varepsilon}}(0)} \frac{1}{\left(1+|z|^{N+2 s}\right)^{2}} d z \\
& =O\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{N+4 s}
\end{aligned}
$$

Since $U(z)=U(|z|)$ and

$$
\left|\sum_{k=1}^{N} z_{k}\right| \leq N\left|\sum_{k=1}^{N} z_{k}^{2}\right|^{1 / 2}=N|z|, \quad \forall z=\left(z_{1}, \ldots, z_{N}\right) \in \mathbb{R}^{N}
$$

we obtain

$$
\begin{aligned}
\left|\varepsilon^{N+1} \sum_{k=1}^{N} D_{k} H(\xi, x) \int_{\Omega_{\varepsilon, \xi}} z_{k} U^{2}(z) d z\right| & =\left|\varepsilon^{N+1} \sum_{k=1}^{N} D_{k} H(\xi, x) \int_{\Omega_{\varepsilon, \xi \backslash B_{\frac{d(\xi, \partial \Omega)}{\varepsilon}}}(0)} z_{k} U^{2}(z) d z\right| \\
& \leq \frac{C \varepsilon^{N+1}}{d(\xi, \partial \Omega)^{N-2 s+1}} \int_{\Omega_{\varepsilon, \xi \backslash \xi}} \frac{|z|}{} \frac{B_{\frac{d(\xi, \partial \Omega)}{\varepsilon}}(0)}{} \frac{\left.|z|^{N+2 s}\right)^{2}}{} d z \\
& =O\left(\frac{\varepsilon^{2 N+4 s}}{d(\xi, \partial \Omega)^{2 N+2 s}}\right)
\end{aligned}
$$

Moreover, since $\Omega \subset \mathbb{R}^{N}$ is bounded, we can choose $r>0$ which is independent of $\varepsilon$ such that $\Omega_{\varepsilon, \xi} \subset B_{\frac{r}{\varepsilon}}(0)$, then we have

\begin{aligned}
\varepsilon^{N+2} \sum_{i, j>0}^{N} D_{i j} H(\xi, x) \int_{\Omega_{\varepsilon, \xi}} z_{i} z_{j} U^{2}(z) d z & \leq \frac{C \varepsilon^{N+2}}{d(\xi, \partial \Omega)^{N-2 s+2}} \int_{\Omega_{\varepsilon, \xi}} \frac{|z|^{2}}{\left(1+|z|^{N+2 s}\right)^{2}} d z \\
& \leq \frac{C \varepsilon^{N+2}}{d(\xi, \partial \Omega)^{N-2 s+2}} \int_{B_{\frac{r}{\varepsilon}}(0)} \frac{|z|^{2}}{1+|z|^{2 N+4 s}} d z \\
& =O\left(\frac{\varepsilon^{N+2}|\log \varepsilon|}{d(\xi, \partial \Omega)^{N-2 s+2}}\right)
\end{aligned}
$$

if $N+4 s-2 \geq 0$ i.e. $N \geq 2, s \in(0,1)$ or $N=1, s \in\left[\frac{1}{4}, \frac{1}{2}\right)$. Otherwise, if $N+4 s-2<0$ i.e. $N=1, s \in\left(0, \frac{1}{4}\right)$, we have

Define

\mu_{\varepsilon, \xi}= \begin{cases}\frac{\varepsilon^{N+2}|\log \varepsilon|}{d(\xi, \partial \Omega)^{N-2 s+2}}, & \text { if } N+4 s-2 \geq 0  \tag{3.13}\\ \frac{\varepsilon^{2 N+4 s}}{d(\xi, \partial \Omega)^{N-2 s+2}}, & \text { if } N+4 s-2<0 .\end{cases}
$$

Therefore,

\begin{align*}
\varepsilon^{N} H(\xi, x) \int_{\mathbb{R}^{N} \backslash \Omega_{\varepsilon, \xi}} U^{2}(z) d z=O\left(\frac{\varepsilon^{2 N+4 s}}{d(\xi, \partial \Omega)^{2 N+2 s}}\right) & =O\left(\mu_{\varepsilon, \xi}\right), \\
\varepsilon^{N+1} \sum_{k=1}^{N} D_{k} H(\xi, x) \int_{\Omega_{\varepsilon, \xi}} z_{k} U^{2}(z) d z & =O\left(\mu_{\varepsilon, \xi}\right),  \tag{3.14}\\
\varepsilon^{N+2} \sum_{i, j}^{N} D_{i j} H(\xi, x) \int_{\Omega_{\varepsilon, \xi}} z_{i} z_{j} U^{2}(z) d z & =O\left(\mu_{\varepsilon, \xi}\right) .
\end{align*}
$$

On the other hand,

$$
\begin{align*}
\int_{\Omega} S(y, x) U_{\varepsilon, \xi}^{2}(y) d y & =\varepsilon^{N} \int_{\Omega_{\varepsilon, \xi}} S(\varepsilon z+\xi, x) U^{2}(z) d z \\
& =\varepsilon^{N} \int_{\mathbb{R}^{N}} S(\varepsilon z+\xi, x) U^{2}(z) d z+O\left(\frac{\varepsilon^{2 N+4 s}}{d(\xi, \partial \Omega)^{2 N+2 s}}\right)  \tag{3.15}\\
& =\varepsilon^{N} \int_{\mathbb{R}^{N}} S(\varepsilon z+\xi, x) U^{2}(z) d z+O\left(\mu_{\varepsilon, \xi}\right) .
\end{align*}
$$

But $\varepsilon^{N-2 s} S(\varepsilon z+\xi, x)$ is a solution of

\begin{cases}(-\Delta)^{s} w=\delta_{(x-\xi) / \varepsilon} & \text { in } \mathbb{R}^{N} \\ w(x) \rightarrow 0 & \text { as }|x| \rightarrow \infty\end{cases}

As a result,

\varepsilon^{N-2 s} \int_{\mathbb{R}^{N}} S(\varepsilon z+\xi, x) U^{2}(z) d z=W\left(\frac{x-\xi}{\varepsilon}\right), \tag{3.16}
\end{equation*}
$$

where $W$ is given in (3.7). Thus the result holds.

## 4 Calculations of the error term

Recall that we are looking for a solution of (1.5) in the form

$$
u_{\varepsilon}=P_{\varepsilon, \Omega} U_{\varepsilon, \xi_{\varepsilon}}+\omega_{\varepsilon, \xi_{\varepsilon}},
$$

for suitable $\omega_{\varepsilon, \xi_{\varepsilon}} \in E_{\varepsilon, \xi}$. We need to estimate the error term $J_{\varepsilon}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)$. Now, let us give more accurate information of $D_{\varepsilon, R}$, that is

$$
\begin{equation*}
D_{\varepsilon, R}=\left\{\xi \in \Omega: \varepsilon R \leq \varepsilon^{1-\varpi} \leq d(\xi, \partial \Omega) \leq 1 / R\right\} \tag{4.1}
\end{equation*}
$$

as $\varepsilon$ is small, where

\begin{equation*}
\frac{N-2 s}{3(N+2 s)}<\varpi<\frac{1}{3} \tag{4.2}
\end{equation*}
$$

and in the rest of this paper, we will give more information about $\varpi$.
Proposition 4.1. If $\varepsilon>0$ is small, we have

J_{\varepsilon}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)= & \varepsilon^{N} A_{1}+\frac{1}{4} \varepsilon^{N+2 s} A_{2}-\frac{1}{4} \varepsilon^{2 N} B^{2} H(\xi, \xi)+\frac{1}{2} \tau_{\varepsilon, \xi} \\
& +\varepsilon^{N} O\left(\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{(1+p)(N+2 s)-N}+\mu_{\varepsilon, \xi}+\varepsilon^{2 s+\zeta_{0}(N-2 s)}\right) \tag{4.3}
\end{align*}
$$

where $\zeta_{0} \in\left(\frac{1}{3}, 1\right)$ closes to $\frac{1}{3}, \mu_{\varepsilon, \xi}$ is given in (3.13) and

$$
\begin{align*}
A_{1} & =\left(\frac{1}{2}-\frac{1}{p+1}\right) \int_{\mathbb{R}^{N}} U^{p+1}, \quad A_{2}=\int_{\mathbb{R}^{N}} U^{2} W=c_{N, s} \int_{\mathbb{R}^{N}} \frac{U^{2}(y) U^{2}(x)}{|y-x|^{N-2 s}} d y d x  \tag{4.4}\\
B & =\int_{\mathbb{R}^{N}} U^{2}, \quad \tau_{\varepsilon, \xi}=\int_{\Omega}\left(U_{\varepsilon, \xi}\right)^{p}\left(U_{\varepsilon, \xi}-P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)
\end{align*}
$$

Proof. Recalling the definition of $J_{\varepsilon}$ and using $P_{\varepsilon, \Omega} U_{\varepsilon, \xi}$ as a text function in (1.9), we get

J_{\varepsilon}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)= & \frac{1}{2} \int_{\mathbb{R}^{N}}\left(\varepsilon^{2 s}\left|(-\Delta)^{\frac{s}{2}} P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right|^{2}+\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)^{2}\right) d x \\
& -\frac{1}{p+1} \int_{\Omega}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)^{p+1} d x+\frac{1}{4} \int_{\Omega} P_{\varepsilon, \Omega}^{2} U_{\varepsilon, \xi} \Phi\left[P_{\varepsilon, \Omega}^{2} U_{\varepsilon, \xi}\right] d x \\
= & \frac{1}{2} \int_{\Omega}\left(U_{\varepsilon, \xi}\right)^{p} P_{\varepsilon, \Omega} U_{\varepsilon, \xi}-\frac{1}{p+1} \int_{\Omega}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)^{p+1} d x  \tag{4.5}\\
& +\frac{1}{4} \int_{\Omega} P_{\varepsilon, \Omega}^{2} U_{\varepsilon, \xi} \Phi\left[P_{\varepsilon, \Omega}^{2} U_{\varepsilon, \xi}\right] d x \\
= & : J_{\varepsilon}^{1}+J_{\varepsilon}^{2}
\end{align*}
$$

Firstly, we estimate $J_{\varepsilon}^{1}$. From (3.3) we know that as $\varepsilon \rightarrow 0$,

$$
\left|U_{\varepsilon, \xi}-P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right| \leq C\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{N+2 s} \rightarrow 0
$$

thus for any $l>0$, it holds that

\begin{aligned}
\int_{\Omega}\left(U_{\varepsilon, \xi}\right)^{p-l}\left(U_{\varepsilon, \xi}-P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)^{l+1} & \leq\left|\frac{U_{\varepsilon, \xi}-P_{\varepsilon, \Omega} U_{\varepsilon, \xi}}{U_{\varepsilon, \xi}}\right|_{\infty}^{l} \int_{\Omega}\left(U_{\varepsilon, \xi}\right)^{p}\left(U_{\varepsilon, \xi}-P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right) \\
& =o(1) \int_{\Omega}\left(U_{\varepsilon, \xi}\right)^{p}\left(U_{\varepsilon, \xi}-P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)
\end{aligned}
$$

By using Taylor's expansion for $\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)^{p+1}$ at $U_{\varepsilon, \xi}$, we have

J_{\varepsilon}^{1}= & \frac{1}{2} \int_{\Omega}\left(U_{\varepsilon, \xi}\right)^{p}\left(U_{\varepsilon, \xi}-\left(U_{\varepsilon, \xi}-P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)\right)-\frac{1}{p+1} \int_{\Omega}\left(U_{\varepsilon, \xi}+\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}-U_{\varepsilon, \xi}\right)\right)^{p+1} \\
= & \frac{1}{2} \int_{\Omega}\left(U_{\varepsilon, \xi}\right)^{p+1}-\frac{1}{2} \int_{\Omega}\left(U_{\varepsilon, \xi}\right)^{p}\left(U_{\varepsilon, \xi}-P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right) \\
& -\int_{\Omega}\left(\frac{\left(U_{\varepsilon, \xi}\right)^{p+1}}{p+1}+\left(U_{\varepsilon, \xi}\right)^{p}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}-U_{\varepsilon, \xi}\right)\right)+o(1) \int_{\Omega}\left(U_{\varepsilon, \xi}\right)^{p}\left(U_{\varepsilon, \xi}-P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right) \\
= & \left(\frac{1}{2}-\frac{1}{p+1}\right) \int_{\Omega}\left(U_{\varepsilon, \xi}\right)^{p+1}+\left(\frac{1}{2}+o(1)\right) \int_{\Omega}\left(U_{\varepsilon, \xi}\right)^{p}\left(U_{\varepsilon, \xi}-P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)  \tag{4.6}\\
= & \varepsilon^{N}\left(\frac{1}{2}-\frac{1}{p+1}\right) \int_{\Omega_{\varepsilon, \xi}} U^{p+1}+\frac{1}{2} \int_{\Omega}\left(U_{\varepsilon, \xi}\right)^{p}\left(U_{\varepsilon, \xi}-P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right) \\
= & \varepsilon^{N} A+\frac{1}{2} \tau_{\varepsilon, \xi}-\varepsilon^{N}\left(\frac{1}{2}-\frac{1}{p+1}\right) \int_{\mathbb{R}^{N} \backslash \Omega_{\varepsilon, \xi}} U^{p+1} .
\end{align*}
$$

Noting that $U$ is small in $\mathbb{R}^{N} \backslash \Omega_{\varepsilon, \xi}$ if $\varepsilon$ is small, then we have

$$
\begin{align*}
\int_{\mathbb{R}^{N} \backslash \Omega_{\varepsilon, \xi}} U^{p+1} & \leq C \int_{\frac{d(\xi, \partial \Omega)}{\varepsilon}}^{+\infty} \frac{t^{N-1}}{\left(1+t^{N+2 s}\right)^{p+1}} d t \\
& =O\left(\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{(1+p)(N+2 s)-N}\right) \tag{4.7}
\end{align*}
$$

So it remains to estimate $J_{\varepsilon}^{2}$. We have

J_{\varepsilon}^{2}= & \frac{1}{4} \int_{\Omega}\left(U_{\varepsilon, \xi}+\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}-U_{\varepsilon, \xi}\right)\right)^{2} \Phi\left[\left(U_{\varepsilon, \xi}+\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}-U_{\varepsilon, \xi}\right)\right)^{2}\right] d x \\
= & \frac{1}{4} \int_{\Omega} U_{\varepsilon, \xi}^{2} \Phi\left[U_{\varepsilon, \xi}^{2}\right] d x \\
& +\int_{\Omega}\left[U_{\varepsilon, \xi}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}-U_{\varepsilon, \xi}\right) \Phi\left[U_{\varepsilon, \xi}^{2}\right]+U_{\varepsilon, \xi}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}-U_{\varepsilon, \xi}\right) \Phi\left[\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}-U_{\varepsilon, \xi}\right)^{2}\right]\right.  \tag{4.8}\\
& +U_{\varepsilon, \xi}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}-U_{\varepsilon, \xi}\right) \Phi\left[U_{\varepsilon, \xi}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}-U_{\varepsilon, \xi}\right)\right]+\frac{1}{2}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}-U_{\varepsilon, \xi}\right)^{2} \Phi\left[U_{\varepsilon, \xi}^{2}\right] \\
& \left.+\frac{1}{4}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}-U_{\varepsilon, \xi}\right)^{2} \Phi\left[\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}-U_{\varepsilon, \xi}\right)^{2}\right]\right] d x \\
:= & J_{\varepsilon}^{21}+J_{\varepsilon}^{22} .
\end{align*}
$$

From Lemma 3.3, we obtain that

$$
\begin{align*}
4 J_{\varepsilon}^{21}= & \int_{\Omega} U_{\varepsilon, \xi}^{2} \Phi\left[U_{\varepsilon, \xi}^{2}\right] d x \\
= & \varepsilon^{2 s} \int_{\Omega} U_{\varepsilon, \xi}^{2} W\left(\frac{x-\xi}{\varepsilon}\right) d x-\varepsilon^{N} B \int_{\Omega} U_{\varepsilon, \xi}^{2} H(x, \xi) d x+\int_{\Omega} U_{\varepsilon, \xi}^{2} O\left(\mu_{\varepsilon, \xi}\right) d x \\
= & \varepsilon^{N+2 s} \int_{\Omega_{\varepsilon, \xi}} U^{2} W d z-\varepsilon^{2 N} B H(\xi, \xi) \int_{\Omega_{\varepsilon, \xi}} U^{2} d z+\varepsilon^{N} O\left(\mu_{\varepsilon, \xi}\right) \int_{\Omega_{\varepsilon, \xi}} U^{2} d z  \tag{4.9}\\
= & \varepsilon^{N+2 s} \int_{\mathbb{R}^{N}} U^{2} W d z-\varepsilon^{2 N} B H(\xi, \xi) \int_{\mathbb{R}^{N}} U^{2} d z+O\left(\frac{\varepsilon^{3 N+4 s}}{d(\xi, \partial \Omega)^{2 N+2 s}}\right) \\
& +\varepsilon^{N} O\left(\mu_{\varepsilon, \xi}\right) \int_{\Omega_{\varepsilon, \xi}} U^{2} d z \\
= & \varepsilon^{N+2 s} A_{2}-\varepsilon^{2 N} B^{2} H(\xi, \xi)+\varepsilon^{N} O\left(\mu_{\varepsilon, \xi}\right) .
\end{align*}
$$

On the other hand, since $P_{\varepsilon, \Omega} U_{\varepsilon, \xi} \leq U_{\varepsilon, \xi}$ and by the behavior of $\Phi\left[U_{\varepsilon, \xi}^{2}\right]$ as shown in Lemma 3.2, we have

\left|J_{\varepsilon}^{22}\right| & \leq C \int_{\Omega} U_{\varepsilon, \xi}\left|P_{\varepsilon, \Omega} U_{\varepsilon, \xi}-U_{\varepsilon, \xi}\right| \Phi\left[U_{\varepsilon, \xi}^{2}\right] d x \\
& \leq C\left|P_{\varepsilon, \Omega} U_{\varepsilon, \xi}-U_{\varepsilon, \xi}\right|_{\infty} \int_{\Omega} U_{\varepsilon, \xi} \Phi\left[U_{\varepsilon, \xi}^{2}\right] d x \\
& \leq C\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{N+2 s} \varepsilon^{2 s} \varepsilon^{N} \int_{\Omega_{\varepsilon, \xi}} \frac{1}{\left(1+|x|^{N-2 s}\right)\left(1+|x|^{N+2 s}\right)} d x \\
& \leq C \varepsilon^{N+2 s+\infty(N+2 s)} .
\end{aligned}
$$

From (4.2), we deduce that

N+2 s+\varpi(N+2 s)>\frac{4 N+4 s}{3}
$$

then we can choose $\zeta_{0} \in\left(\frac{1}{3}, 1\right)$ closes to $\frac{1}{3}$ which is same as in Lemma 5.1, such that

Thus the result holds.
Now, let us estimate $\tau_{\varepsilon, \xi}$ which is defined in (4.4). In order to obtain a proper result, we will introduce a new "nonlocal normal derivative" which is simply and helpful for this estimation. It is well known the Green's formula for classical Laplacian $\Delta$ that

In [24], Dipierro, Ros-oton and Valdinoci have established a new "nonlocal normal derivative" $\mathcal{N}_{s}$ which is defined as

\mathcal{N}_{s} u(x):=C_{N, s} \int_{\Omega} \frac{u(x)-u(y)}{|x-y|^{N+2 s}} d y, \quad x \in \mathbb{R}^{N} \backslash \bar{\Omega}, \tag{4.11}
\end{equation*}
$$

and they get the Green's formula corresponding to fractional Laplacian $(-\Delta)^{s}$,

\frac{C_{N, s}}{2} \int_{\mathcal{D}_{\Omega}} \frac{(u(x)-u(y))(v(x)-v(y))}{|x-y|^{N+2 s}} d x d y=\int_{\Omega} v(-\Delta)^{s} u+\int_{\mathbb{R}^{N} \backslash \Omega} v \mathcal{N}_{s} u \tag{4.12}
\end{equation*}
$$

Following the proof of [28, Lemma 2.1], we have:
Lemma 4.1. If $\varepsilon$ is small, then there are $0<c_{1} \leq c_{2}$ such that

c_{1} \varepsilon^{N}\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{N+4 s} \leq \tau_{\varepsilon, \xi} \leq c_{2} \varepsilon^{N}\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{N+4 s} \tag{4.13}
\end{equation*}
$$

Proof. Multiplying (3.2) by $U_{\varepsilon, \xi}, \eta_{\varepsilon, \xi}$ respectively and integrating, we get

\varepsilon^{2 s} \int_{\Omega} U_{\varepsilon, \xi}(-\Delta)^{s} \eta_{\varepsilon, \xi}+\int_{\Omega} U_{\varepsilon, \xi} \eta_{\varepsilon, \xi} & =0  \tag{4.14}\\
\varepsilon^{2 s} \int_{\Omega} \eta_{\varepsilon, \xi}(-\Delta)^{s} \eta_{\varepsilon, \xi}+\int_{\Omega} \eta_{\varepsilon, \xi} \eta_{\varepsilon, \xi} & =0 \tag{4.15}
\end{align*}
$$

Then multiplying (1.9) by $\eta_{\varepsilon, \xi}$ and integrating by parts, we obtain

\tau_{\varepsilon, \xi} & =\int_{\Omega}\left(U_{\varepsilon, \xi}\right)^{p}\left(U_{\varepsilon, \xi}-P_{\varepsilon, \xi} U_{\varepsilon, \xi}\right) \\
& =\varepsilon^{2 s} \int_{\Omega} \eta_{\varepsilon, \xi}(-\Delta)^{s} P_{\varepsilon, \Omega} U_{\varepsilon, \xi}+\int_{\Omega} \eta_{\varepsilon, \xi} P_{\varepsilon, \Omega} U_{\varepsilon, \xi} \\
& =\varepsilon^{2 s} \int_{\Omega} \eta_{\varepsilon, \xi}(-\Delta)^{s}\left(U_{\varepsilon, \xi}-\eta_{\varepsilon, \xi}\right)+\int_{\Omega} \eta_{\varepsilon, \xi}\left(U_{\varepsilon, \xi}-\eta_{\varepsilon, \xi}\right) \\
& =\varepsilon^{2 s} \int_{\Omega} \eta_{\varepsilon, \xi}(-\Delta)^{s} U_{\varepsilon, \xi}+\int_{\Omega} \eta_{\varepsilon, \xi} U_{\varepsilon, \xi}-\left(\varepsilon^{2 s} \int_{\Omega} \eta_{\varepsilon, \xi}(-\Delta)^{s} \eta_{\varepsilon, \xi}+\int_{\Omega} \eta_{\varepsilon, \xi} \eta_{\varepsilon, \xi}\right) \\
& =\varepsilon^{2 s} \int_{\Omega} \eta_{\varepsilon, \xi}(-\Delta)^{s} U_{\varepsilon, \xi}-\varepsilon^{2 s} \int_{\Omega} U_{\varepsilon, \xi}(-\Delta)^{s} \eta_{\varepsilon, \xi} \\
& =\varepsilon^{2 s} \int_{\mathbb{R}^{N} \backslash \Omega} U_{\varepsilon, \xi} \mathcal{N}_{s} \eta_{\varepsilon, \xi}-\varepsilon^{2 s} \int_{\mathbb{R}^{N} \backslash \Omega} \eta_{\varepsilon, \xi} \mathcal{N}_{s} U_{\varepsilon, \xi} \\
& =\varepsilon^{2 s} \int_{\mathbb{R}^{N} \backslash \Omega} U_{\varepsilon, \xi} \mathcal{N}_{s} \eta_{\varepsilon, \xi}-\varepsilon^{2 s} \int_{\mathbb{R}^{N} \backslash \Omega} U_{\varepsilon, \xi} \mathcal{N}_{s} U_{\varepsilon, \xi} .

Besides, using the Green's formula (4.12) for (4.15), we obtain

We can choose small $\varrho>0$ which is independent of $\varepsilon$ such that there exists $c>0$ such that $U(y)-U(x) \geq c U(y), \forall x \in \mathbb{R}^{N} \backslash \Omega_{\varepsilon, \xi}, \forall y \in B_{\underline{\underline{o d(\xi, \partial \Omega)}}}^{\varepsilon}(0)$. Define

\mathcal{S}=\left\{x \in \mathbb{R}^{N} \backslash \Omega_{\varepsilon, \xi}: \varrho d(\xi, \partial \Omega) / \varepsilon \leq d\left(x, \partial \Omega_{\varepsilon, \xi}\right) \leq 3 \varrho d(\xi, \partial \Omega) / \varepsilon\right\}
$$

Then we can find a suitable $\xi^{1} \in \mathcal{S}$ such that $B_{\underline{\underline{o d}(\xi, \partial \Omega)}}^{\varepsilon}\left(\xi^{1}\right) \subset \mathcal{S}$ and for all $x \in B_{\underline{\underline{o d}(\xi, \partial \Omega)}}^{\varepsilon}\left(\xi^{1}\right)$, $(1+\varrho) d(\xi, \partial \Omega) / \varepsilon \leq|x| \leq(1+3 \varrho) d(\xi, \partial \Omega) / \varepsilon$. Then $\forall x \in B_{\frac{\varrho d(\xi, \partial \Omega)}{\varepsilon}}\left(\xi^{1}\right), \forall y \in B_{\underline{\underline{\rho d}(\xi, \partial \Omega)}}^{\varepsilon}(0)$, it holds that

& \geq C_{2} \varepsilon^{N} \int_{B_{\underline{\underline{o d}(\xi, \partial \Omega)}}^{\varepsilon}\left(\xi^{1}\right)} U(x) \int_{B_{\underline{\underline{o d}(\xi, \partial \Omega)}}^{\varepsilon}(0)} \frac{U(y)}{|y-x|^{N+2 s}} d y d x \\
& \geq C_{3} \varepsilon^{N}\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{N+2 s}\left(\frac{d(\xi, \partial \Omega)}{\varepsilon}\right)^{N}\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{N+2 s} \int_{B_{\underline{\underline{o d}(\xi, \partial \Omega)} \varepsilon}^{\varepsilon}(0)} U(y) d y  \tag{4.19}\\
& \geq C_{4}\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{N+4 s} \int_{B_{R}(0)} U(y) d y \\
& \geq C_{5} \varepsilon^{N}\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{N+4 s} \text {. }
\end{align*}

= & C_{N, s} \varepsilon^{2 s} \int_{\mathbb{R}^{N} \backslash \Omega} U_{\varepsilon, \xi}(x) \int_{\Omega} \frac{P_{\varepsilon, \Omega} U_{\varepsilon, \xi}(y)-P_{\varepsilon, \Omega} U_{\varepsilon, \xi}(x)}{|y-x|^{N+2 s}} d y d x \\
= & C_{N, s} \varepsilon^{2 s} \int_{\mathbb{R}^{N} \backslash \Omega} U_{\varepsilon, \xi}(x) \int_{\Omega} \frac{P_{\varepsilon, \Omega} U_{\varepsilon, \xi}(y)}{|y-x|^{N+2 s}} d y d x \\
& -C_{N, s} \varepsilon^{2 s} \int_{\mathbb{R}^{N} \backslash \Omega} U_{\varepsilon, \xi}(x) P_{\varepsilon, \Omega} U_{\varepsilon, \xi}(x) \int_{\Omega} \frac{1}{|y-x|^{N+2 s}} d y d x  \tag{4.20}\\

& \leq \frac{C_{6}}{1+|x|^{N+2 s}} \int_{\Omega_{\varepsilon, \xi}}\left(\frac{1}{1+|y|^{N+2 s}}+\frac{1}{\left||x|^{N+2 s}-|y|^{N+2 s}\right|}\right) d y

& +C_{6} \varepsilon^{N} \int_{\mathbb{R}^{N} \backslash \Omega_{\varepsilon, \xi}} \frac{1}{\left(1+|x|^{N+2 s}\right)^{2}} \int_{\Omega_{\varepsilon, \xi}} \frac{1}{\left.| | x\right|^{N+2 s}-|y|^{N+2 s \mid}} d y d x \\
\leq & C_{7} \varepsilon^{N}\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{N+4 s} \\
& +C_{6} \varepsilon^{N} \int_{\mathbb{R}^{N} \backslash \Omega_{\varepsilon, \xi}} \frac{1}{\left(1+|x|^{N+2 s}\right)^{2}} \int_{\Omega_{\varepsilon, \xi}} \frac{1}{\left.| | x\right|^{N+2 s}-|y|^{N+2 s \mid}} d y d x .
\end{aligned}

\leq & \frac{1}{\left(1+|x|^{N+2 s}\right)^{2}} \int_{\Omega_{\varepsilon, \xi}} \frac{1}{\left.| | x\right|^{N}-|y|^{N} \mid\left(|x|^{2 s}+|y|^{2 s}\right)} d y d x  \tag{4.23}\\
\leq & \int_{\mathbb{R}^{N} \backslash \Omega_{\varepsilon, \xi}} \frac{1}{\left(1+|x|^{N+2 s}\right)^{2}} \frac{1}{|x|^{2 s}} \int_{\Omega_{\varepsilon, \xi}} \frac{1}{\left.| | x\right|^{N}-|y|^{N} \mid} d y d x \\
= & o\left(\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{N+4 s}\right)
\end{align*}

thus we have

Thus the result follows by (4.19) and (4.24).
Remark 4.1. We remark that the integral

is integrable for each $R>0$, moreover, this integral value is decreasing for large $R>0$. Indeed,

= & C \int_{R}^{+\infty} \frac{t^{N-1-2 s}}{\left(1+t^{N+2 s}\right)^{2}} \int_{0}^{R} \frac{r^{N-1}}{t^{N}-r^{N}} d r d t \\
= & C \int_{R}^{+\infty} \frac{t^{N-1-2 s} \log \left(\frac{t^{N}}{t^{N}-R^{N}}\right)}{\left(1+t^{N+2 s}\right)^{2}} d t \\
= & C^{\prime} \int_{1}^{+\infty} \frac{(\log r) R^{N-2 s}}{(r-1)^{2-\frac{2 s}{N}} r^{\frac{2 s}{N}}\left[1+\left(\frac{r}{r-1}\right)^{\frac{N+2 s}{N}} R^{N+2 s}\right]^{2}} d r \\
= & C^{\prime} \int_{1}^{+\infty} \frac{(\log r)\left(\frac{r-1}{r}\right)^{\frac{N+6 s}{N}}}{(r-1)^{\frac{2 s}{N}}\left[(r-1)^{1-\frac{2 s}{N}} r\right]\left[\left(\frac{r-1}{r}\right)^{\frac{N+2 s}{N}} R^{-\frac{N-2 s}{2}}+R^{\frac{N+6 s}{2}}\right]^{2}} d r
\end{aligned}

since $\log r \leq(r-1)^{\frac{2 s}{N}}$ for all $r \geq 1$ and $N>2 s$, we can know the above integral is integrable for each $R>0$ and the integral value is decreasing for large $R>0$. Therefore, we have

& \leq \int_{\mathbb{R}^{N} \backslash B_{\frac{d(\xi, \partial \Omega)}{\varepsilon}}(0)} \frac{1}{\left(1+|x|^{N+2 s}\right)^{2}} \frac{1}{|x|^{2 s}} \int_{\frac{B_{\frac{d(\xi, \partial \Omega)}{\varepsilon}}^{\varepsilon}}{}(0)} \frac{1}{\left.| | x\right|^{N}-|y|^{N \mid} \mid} d y d x \\
& \leq C\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{N+6 s} \int_{1}^{+\infty} \frac{1}{(r-1)^{1-\frac{2 s}{N} r} d r} \\
& \leq C^{\prime}\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{N+6 s}=o\left(\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{N+4 s}\right)
\end{aligned}
$$

Thus (4.23) holds.

## 5 The reduction

In this section, we will calculate $L_{\varepsilon, \xi}, Q_{\varepsilon, \xi}, R_{\varepsilon}$ and develop the reduction. Here, we take $\varpi$ for $D_{\varepsilon, R}$ in (4.1) as

$$
\begin{equation*}
\max \left\{\frac{N+4 s}{6[p(N+2 s)-N / 2]}, \frac{N+4 s}{6(N+2 s)}\right\}<\varpi<\frac{1}{3}, \tag{5.1}
\end{equation*}
$$

in which $N<8 s$. Firstly, we prove the following lemma.
Lemma 5.1. As defined in (2.13), we have $L_{\varepsilon, \xi}$ is a bounded linear operator from $E_{\varepsilon, \xi}$ into $\mathbb{R}$. Moreover, for all $\omega \in E_{\varepsilon, \xi}$, we have

L_{\varepsilon, \xi}(\omega)=O\left(\varepsilon^{\frac{(N+2 s)+\zeta_{0}(N-2 s)}{2}}\right)\|\omega\|_{\varepsilon} \tag{5.2}
\end{equation*}

for some $\zeta_{0} \in\left(\frac{1}{3}, \frac{2 s}{N-2 s}\right)$ closes to $\frac{1}{3}$. In particular there is $l_{\varepsilon, \xi} \in E_{\varepsilon, \xi}$ such that

& =\int_{\Omega}\left(\left(U_{\varepsilon, \xi}\right)^{p}-\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)^{p}\right) \omega d x+\int_{\Omega} \Phi\left[P_{\varepsilon, \Omega}^{2} U_{\varepsilon, \xi}\right] P_{\varepsilon, \Omega} U_{\varepsilon, \xi} \omega d x \\
& =L_{\varepsilon, \xi}^{1}+L_{\varepsilon, \xi}^{2}
\end{aligned}
$$

where

$$
L_{\varepsilon, \xi}^{1}=\int_{\Omega}\left(\left(U_{\varepsilon, \xi}\right)^{p}-\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)^{p}\right) \omega d x, \quad L_{\varepsilon, \xi}^{2}=\int_{\Omega} \Phi\left[P_{\varepsilon, \Omega}^{2} U_{\varepsilon, \xi}\right] P_{\varepsilon, \Omega} U_{\varepsilon, \xi} \omega d x
$$

Then, using Taylor's expansion for $\left(U_{\varepsilon, \xi}\right)^{p}$ at $P_{\varepsilon, \Omega} U_{\varepsilon, \xi}$ and from (3.3), we get

& \quad \leq C^{\prime}\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{N+2 s}\left(\varepsilon^{N} \int_{\Omega_{\varepsilon, \xi}}\left(\frac{1}{1+|x|^{N+2 s}}\right)^{2(p-1)} d x\right)^{\frac{1}{2}}\left(\int_{\Omega}|\omega|^{2} d x\right)^{\frac{1}{2}} \\
& \leq C^{\prime \prime} \varepsilon^{\frac{N}{2}}\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{N+2 s}\|\omega\|_{\varepsilon}\left(\int_{0}^{\frac{r}{\varepsilon}} \frac{t^{N-1}}{\left(1+t^{N+2 s}\right)^{2(p-1)}} d x\right)^{\frac{1}{2}}
\end{aligned}
$$

where $r=\max _{x, y \in \Omega}|x-y|$. By a simple calculation, it holds that

\int_{0}^{\frac{r}{\varepsilon}} \frac{t^{N-1}}{\left(1+t^{N+2 s}\right)^{2(p-1)}} d x= \begin{cases}O\left(\varepsilon^{2(p-1)(N+2 s)-N}\right), & \text { if } 1<p<1+\frac{N}{2(N+2 s)} \\ O(|\ln \varepsilon|), & \text { if } p=1+\frac{N}{2(N+2 s)} \\ O(1), & \text { if } 1+\frac{N}{2(N+2 s)}<p<\frac{N+2 s}{N-2 s} .\end{cases}
$$

Moreover, if $1<p<1+\frac{N}{2(N+2 s)}$, taking $q=1+\frac{N}{2(N+2 s)}-p$ then

& \leq C^{\prime}\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{(1-q)(N+2 s)}\left(\varepsilon^{N} \int_{\Omega_{\varepsilon, \xi}}\left(\frac{1}{1+|x|^{N+2 s}}\right)^{2(p-1)+2 q} d x\right)^{\frac{1}{2}}\left(\int_{\Omega}|\omega|^{2} d x\right)^{\frac{1}{2}} \\
& \leq C^{\prime \prime} \varepsilon^{\frac{N}{2}}\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{(1-q)(N+2 s)}\|\omega\|_{\varepsilon}\left(\int_{0}^{\frac{r}{\varepsilon}} \frac{t^{N-1}}{1+t^{N}} d x\right)^{\frac{1}{2}} \\
& \leq C^{\prime \prime \prime} \varepsilon^{\frac{N}{2}}\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{p(N+2 s)-N / 2}|\ln \varepsilon|^{\frac{1}{2}}\|\omega\|_{\varepsilon}
\end{aligned}

R_{\varepsilon}(\omega)= & \int_{\Omega} \frac{\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)^{p+1}-\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}+\omega\right)^{p+1}}{p+1} d x+\int_{\Omega}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)^{p} \omega d x+\frac{p}{2} \int_{\Omega}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)^{p-1} \omega^{2} d x \\
& +\int_{\Omega} \Phi\left[\omega^{2}\right] P_{\varepsilon, \Omega} U_{\varepsilon, \xi} \omega d x+\frac{1}{4} \int_{\Omega} \Phi\left[\omega^{2}\right] \omega^{2} d x \\
:= & R_{1, \varepsilon}(\omega)+R_{2, \varepsilon}(\omega) .
\end{aligned}
$$

Then we can obtain that

One the one hand, if $1<p<2$, from (2.4) we can get

\left|R_{1, \varepsilon}^{\prime}(\omega) \eta\right| \leq C \int_{\Omega}|\omega|^{p}|\eta| d x \leq C\left(\int_{\Omega}|\omega|^{p+1} d x\right)^{\frac{p}{p+1}}\left(\int_{\Omega}|\eta|^{p+1} d x\right)^{\frac{1}{p+1}} \leq C \varepsilon^{\left(1-\frac{p}{2}\right) N}\|\omega\|_{\varepsilon}^{p}\|\eta\|_{\varepsilon}
$$

moreover

$$
\begin{aligned}
\left|R_{1, \varepsilon}^{\prime \prime}(\omega)\left(\eta_{1}, \eta_{2}\right)\right| & \leq C \int_{\Omega}|\omega|^{p-1}\left|\eta_{1}\right|\left|\eta_{2}\right| d x \\
& \leq C\left(\int_{\Omega}|\omega|^{p+1} d x\right)^{\frac{p-1}{p+1}}\left(\int_{\Omega}\left|\eta_{1}\right|^{p+1} d x\right)^{\frac{1}{p+1}}\left(\int_{\Omega}\left|\eta_{2}\right|^{p+1} d x\right)^{\frac{1}{p+1}} \\
& \leq C \varepsilon^{\left(1-\frac{p}{2}\right) N}\|\omega\|_{\varepsilon}^{p-1}\left\|\eta_{1}\right\|_{\varepsilon}\left\|\eta_{2}\right\|_{\varepsilon}
\end{aligned}
$$

On the other hand, for the case $p>2$, we also can obtain that

$$
\begin{aligned}
\left|R_{1, \varepsilon}(\omega)\right| & \leq C \varepsilon^{-\frac{N}{2}}\|\omega\|_{\varepsilon}^{3} \\
\left|R_{1, \varepsilon}^{\prime}(\omega) \eta\right| & \leq C \varepsilon^{-\frac{N}{2}}\|\omega\|_{\varepsilon}^{2}\|\eta\|_{\varepsilon} \\
\left|R_{1, \varepsilon}^{\prime \prime}(\omega)\left(\eta_{1}, \eta_{2}\right)\right| & \leq C \varepsilon^{-\frac{N}{2}}\|\omega\|_{\varepsilon}\left\|\eta_{1}\right\|_{\varepsilon}\left\|\eta_{2}\right\|_{\varepsilon}
\end{aligned}
$$

Then by using (HLS) inequality and (2.4), (2.10), we obtain that

R_{2, \varepsilon}(\omega) & =\int_{\Omega} \Phi\left[\omega^{2}\right] P_{\varepsilon, \Omega} U_{\varepsilon, \xi} \omega d x+\frac{1}{4} \int_{\Omega} \Phi\left[\omega^{2}\right] \omega^{2} d x \\
& \leq C\left(\int_{\Omega}|\omega|^{\frac{4 N}{N+2 s}}\right)^{\frac{N+2 s}{2 N}}\left(\int_{\Omega}\left(\omega P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)^{\frac{2 N}{N+2 s}}\right)^{\frac{N+2 s}{2 N}}+C \varepsilon^{2 s-N}\|\omega\|_{\varepsilon}^{4} \\
& \leq C\left(\int_{\Omega}|\omega|^{\frac{4 N}{N+2 s}}\right)^{\frac{N+2 s}{2 N}}\left(\int_{\Omega}|\omega|^{2}\right)^{\frac{1}{2}}\left(\int_{\Omega} \left\lvert\, P_{\varepsilon, \Omega} U_{\varepsilon, \xi} \xi^{\frac{N}{s}}\right.\right)^{\frac{s}{N}}+C \varepsilon^{2 s-N}\|\omega\|_{\varepsilon}^{4} \\
& =O\left(\varepsilon^{2 s-\frac{N}{2}}\|\omega\|_{\varepsilon}^{3}+\varepsilon^{2 s-N}\|\omega\|_{\varepsilon}^{4}\right) .
\end{aligned}
$$

Similarly,

$$
\begin{aligned}
\left|R_{2, \varepsilon}^{\prime}(\omega) \eta\right| & =O\left(\varepsilon^{2 s-\frac{N}{2}}\|\omega\|_{\varepsilon}^{2}\|\eta\|_{\varepsilon}+\varepsilon^{2 s-N}\|\omega\|_{\varepsilon}^{3}\|\eta\|_{\varepsilon}\right) \\
\left|R_{2, \varepsilon}^{\prime \prime}(\omega) \eta_{1} \eta_{2}\right| & =O\left(\varepsilon^{2 s-\frac{N}{2}}\|\omega\|_{\varepsilon}\left\|\eta_{1}\right\|_{\varepsilon}\left\|\eta_{2}\right\|_{\varepsilon}+\varepsilon^{2 s-N}\|\omega\|_{\varepsilon}^{2}\left\|\eta_{1}\right\|_{\varepsilon}\left\|\eta_{2}\right\|_{\varepsilon}\right)
\end{aligned}
$$

Consequently,

\begin{aligned}
\left\|R_{\varepsilon}^{(i)}(\omega)\right\|_{\varepsilon} & \leq\left\|R_{1, \varepsilon}^{(i)}(\omega)\right\|_{\varepsilon}+\left\|R_{2, \varepsilon}^{(i)}(\omega)\right\|_{\varepsilon} \\
& \leq C\left(\varepsilon^{2 s-\frac{N}{2}}\|\omega\|_{\varepsilon}^{3-i}+\varepsilon^{2 s-N}\|\omega\|_{\varepsilon}^{4-i}+\varepsilon^{-\frac{N}{2} \min \{1, p-1\}}\|\omega\|_{\varepsilon}^{\min \{3-i, p+1-i\}}\right)
\end{aligned}
$$

for $i=0,1,2$.
Next we prove:
Proposition 5.1. There is an $\varepsilon_{0}>0$ such that for each $\varepsilon \in\left(0, \varepsilon_{0}\right]$, there exists a unique $C^{1}$-map $\omega_{\varepsilon, \xi}: D_{\varepsilon, R} \rightarrow E_{\varepsilon, \xi}$ such that $J_{\varepsilon}^{\prime}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}+\omega_{\varepsilon, \xi}\right) \in E_{\varepsilon, \xi}^{\perp}$, that is

\begin{equation*}
\left\langle\frac{\partial J_{\varepsilon}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}+\omega_{\varepsilon, \xi}\right)}{\partial \omega}, \eta\right\rangle_{\varepsilon}=0, \quad \forall \eta \in E_{\varepsilon, \xi} \tag{5.18}
\end{equation*}
$$

where $J_{\varepsilon}$ is defined in (2.11). Moreover, we have

\begin{equation*}
\left\|\omega_{\varepsilon, \xi}\right\|_{\varepsilon}=\varepsilon^{\frac{N}{2}} O\left(\varepsilon^{\kappa}\right), \quad \forall \xi \in D_{\varepsilon, R} \tag{5.19}
\end{equation*}
$$

where $\kappa=\frac{2 s+\zeta_{0}(N-2 s)}{2}$ and $\zeta_{0}$ is given in Lemma 5.1.
Proof. This proof is shown in [2, Proposition 4.18]. As stated in Section 2, let

K(\xi, \omega)=J_{\varepsilon}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}+\omega\right), \xi \in D_{\varepsilon, R}, \omega \in E_{\varepsilon, \xi}

Expanding $K$ near $\omega=0$, it holds

$$

Then, (5.18) is equivalent to find a critical point of $K(\xi, \cdot)$ in $E_{\varepsilon, \xi}$. Using Lemma 5.3, we see that $\mathcal{A}_{\varepsilon, \xi}$ is invertible in $E_{\varepsilon, \xi}$ and there exists a constant $C$ independent of $\varepsilon$ and $\xi$, such that

Thus finding critical point for $K(\xi, \cdot)$ in $E_{\varepsilon, \xi}$ is equivalent to solving

Rewrite (5.20) as $\omega=-\mathcal{A}_{\varepsilon, \xi}^{-1}\left(l_{\varepsilon, \xi}+R_{\varepsilon}^{\prime}(\omega)\right)$ and let

G(\omega)=-\mathcal{A}_{\varepsilon, \xi}^{-1}\left(l_{\varepsilon, \xi}+R_{\varepsilon}^{\prime}(\omega)\right), \quad \xi \in D_{\varepsilon, R}, \quad \omega \in E_{\varepsilon, \xi}
$$

Hence, the problem reduces to finding a fixed point of the map $G$. For any $\omega_{1}, \omega_{2} \in E_{\varepsilon, \xi}$ with $\left\|\omega_{1}\right\|_{\varepsilon},\left\|\omega_{2}\right\|_{\varepsilon} \leq \varepsilon^{\frac{N}{2}+\kappa}$ and $\left|\omega_{1}\right|,\left|\omega_{2}\right| \leq\left|P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right|$. Then by Lemma 5.4, we get

\left\|G\left(\omega_{1}\right)-G\left(\omega_{2}\right)\right\|_{\varepsilon} & \leq C\left\|R_{\varepsilon}^{\prime}\left(\omega_{1}\right)-R_{\varepsilon}^{\prime}\left(\omega_{2}\right)\right\|_{\varepsilon} \\
& \leq C_{1}\left\|\int_{0}^{1} R_{\varepsilon}^{\prime \prime}\left(t \omega_{1}+(1-t) \omega_{2}\right)\left(\omega_{1}-\omega_{2}\right) d t\right\|_{\varepsilon} \\
& \leq C_{1} \max _{t \in[0,1]}\left\|R_{\varepsilon}^{\prime \prime}\left(t \omega_{1}+(1-t) \omega_{2}\right)\right\|_{\varepsilon}\left\|\omega_{1}-\omega_{2}\right\|_{\varepsilon} \\
& \leq C_{2}\left[\varepsilon^{2 s+\kappa}+\varepsilon^{2 s+2 \kappa}+\varepsilon^{N\left(1-\frac{\min \{p+1,3\}}{2}\right)} \varepsilon_{\left.\varepsilon^{\left(\frac{N}{2}+\kappa\right) \min \{p-1,1\}}\right]\left\|\omega_{1}-\omega_{2}\right\|_{\varepsilon}}\right. \\
& \leq C_{3} \varepsilon^{\kappa \min \{p-1,1\}}\left\|\omega_{1}-\omega_{2}\right\|_{\varepsilon} .
\end{aligned}
$$

Using the fact that $\kappa \min \{p-1,1\}>0$, we can choose $0<\nu<1$ such that

$$
\begin{equation*}
\left\|G\left(\omega_{1}\right)-G\left(\omega_{2}\right)\right\|_{\varepsilon} \leq C_{4} \varepsilon^{\nu}\left\|\omega_{1}-\omega_{2}\right\|_{\varepsilon} \tag{5.21}
\end{equation*}
$$

so $G$ is a contraction map. On the other hand, for any $\omega \in E_{\varepsilon, \xi}$ with $\|\omega\|_{\varepsilon} \leq \varepsilon^{\frac{N}{2}+\kappa}$ and $|\omega| \leq\left|P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right|$, it holds that

$$
\begin{aligned}
\|G(\omega)\|_{\varepsilon} & \leq C\left\|l_{\varepsilon, \xi}\right\|_{\varepsilon}+C\left\|R_{\varepsilon}(\omega)\right\|_{\varepsilon} \\
& \leq C\left\|l_{\varepsilon, \xi}\right\|_{\varepsilon}+C_{5}\left[\varepsilon^{2 s-\frac{N}{2}}\|\omega\|_{\varepsilon}^{3}+\varepsilon^{2 s-N}\|\omega\|_{\varepsilon}^{4}+\varepsilon^{N\left(1-\frac{\min \{p+1,3\}}{2}\right)}\|\omega\|_{\varepsilon}^{\min \{p, 2\}}\right] \\
& \leq C\left\|l_{\varepsilon, \xi}\right\|_{\varepsilon}+C_{6}\left[\varepsilon^{N+2 s+3 \kappa}+\varepsilon^{N+2 s+4 \kappa}+\varepsilon^{N\left(1-\frac{\min \{p+1,3\}}{2}\right)} \varepsilon^{\min \{p, 2\}\left(\frac{N}{2}+\kappa\right)}\right] \\
& =C\left\|l_{\varepsilon, \xi}\right\|_{\varepsilon}+C_{6}^{\prime} \varepsilon^{\frac{N}{2}+\kappa \min \{p, 2\}} .
\end{aligned}
$$

Hence, using Lemma 5.1 and the fact $\min \{p, 2\}>1$, we get

\|G(\omega)\|_{\varepsilon} \leq C_{7} \varepsilon^{\frac{N}{2}+\kappa} \tag{5.22}
\end{equation*}
$$

Combining (5.21) and (5.22), we see that $G$ is a contraction map from $E_{\varepsilon, \xi} \cap B\left(0, \varepsilon^{\frac{N}{2}+\kappa}\right)$ into itself. By the contraction mapping Theorem, we get the existence of unique $\omega_{\varepsilon, \xi} \in E_{\varepsilon, \xi} \cap B\left(0, \varepsilon^{\frac{N}{2}+\kappa}\right)$ such that

Furthermore from (5.22), we get

We prove now that $\xi \rightarrow \omega_{\varepsilon, \xi}$ is $C^{1}$. In order to do that, let us denote

Then, $\Psi\left(\varepsilon, \xi, \omega_{\varepsilon, \xi}\right)=0$. On the other hand,

\partial_{\omega} \Psi(\varepsilon, \xi, 0)(\eta)=\eta+\mathcal{A}_{\varepsilon, \xi}^{-1}\left(R_{\varepsilon}^{\prime \prime}(\omega) \eta\right)

Using Lemma 5.3 and Lemma 5.4, we conclude that $\partial_{\omega} \Psi(\varepsilon, \xi, 0)$ is, for $\varepsilon$ small, invertible as a small perturbation of the identity. Thus the result follows by the implicit function Theorem.

## 6 Proof of main result

## Proof of Theorem 1.1.

Considering $s \in(0,1), 2 s<N \leq 6 s$ and $p \in\left(1, \frac{N+2 s}{N-2 s}\right)$ for our problem (1.5). Then we define

where $\varpi, \mu$ are fixed two positive constants satisfying

1>\mu>\frac{1}{3}>\varpi>\max \left\{\frac{N+4 s}{6(N+2 s)}, \frac{N+4 s}{3[(1+p)(N+2 s)-N]}, \frac{N-2 s}{3(N+2-2 s)}, \frac{6-2 N-14 s}{3(N+2-2 s)}\right\} . \tag{6.1}
\end{equation*}
$$

Consider $\inf _{\xi \in D_{\varepsilon}} M_{\varepsilon}(\xi)$, where

M_{\varepsilon}(\xi)=J_{\varepsilon}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}+\omega_{\varepsilon, \xi}\right)
$$

Let $\xi_{\varepsilon} \in D_{\varepsilon}$ be a minimum point of $M_{\varepsilon}(\xi)$ in $D_{\varepsilon}$. In order to prove that $P_{\varepsilon, \Omega} U_{\varepsilon, \xi_{\varepsilon}}+\omega_{\varepsilon, \xi_{\varepsilon}}$ is a solution of (1.5), it's well known that as is shown in [17, Lemma 7.16] and also [2, Lemma 4.19], we only need to prove that $\xi_{\varepsilon}$ is an interior point of $D_{\varepsilon}$. It follows from Lemmas 5.1, 5.2, 5.4, and Propositions 4.1, 5.1, that

M_{\varepsilon}(\xi)= & J_{\varepsilon}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)+O\left(\left\|l_{\varepsilon, \xi}\right\|_{\varepsilon}\left\|\omega_{\varepsilon, \xi}\right\|_{\varepsilon}+\left\|\omega_{\varepsilon, \xi}\right\|_{\varepsilon}^{2}+R_{\varepsilon}\left(\omega_{\varepsilon, \xi}\right)\right) \\
= & J_{\varepsilon}\left(P_{\varepsilon, \Omega} U_{\varepsilon, \xi}\right)+O\left(\varepsilon^{N+2 s+\zeta_{0}(N-2 s)}\right) \\
= & \varepsilon^{N} A_{1}+\frac{1}{4} \varepsilon^{N+2 s} A_{2}+\frac{1}{2} \tau_{\varepsilon, \xi}-\frac{1}{4} \varepsilon^{2 N} B^{2} H(\xi, \xi)+O\left(\varepsilon^{N+2 s+\zeta_{0}(N-2 s)}\right)  \tag{6.2}\\
& +\varepsilon^{N} O\left(\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{(1+p)(N+2 s)-N}+\mu_{\varepsilon, \xi}\right),
\end{align*}
$$

where $\zeta_{0}$ is given in Lemma 5.1 and $\mu_{\varepsilon, \xi}$ is given in (3.13). Then from (6.1), we obtain

$$
\begin{equation*}
M_{\varepsilon}(\xi)=\varepsilon^{N} A_{1}+\frac{1}{4} \varepsilon^{N+2 s} A_{2}+\frac{1}{2} \tau_{\varepsilon, \xi}-\frac{1}{4} \varepsilon^{2 N} B^{2} H(\xi, \xi)+o\left(\varepsilon^{N+2 s+\zeta(N-2 s)}\right), \tag{6.3}
\end{equation*}
$$

where $\zeta$ is a fixed constant with $\frac{1}{3}<\zeta<\min \left\{\zeta_{0}, \mu\right\}$ and closes to $\frac{1}{3}$.
Let $\xi^{*} \in D_{\varepsilon}$ with $d\left(\xi^{*}, \partial \Omega\right)=\varepsilon^{1-\zeta}$. Noting that $H\left(\xi^{*}, \xi^{*}\right) \sim \frac{1}{d\left(\xi^{*}, \partial \Omega\right)^{N-2 s}}$ as $d\left(\xi^{*}, \partial \Omega\right) \rightarrow 0$ (for similar result to Laplacian, see [6, Proposition 6.7.1.]), then we obtain from Lemma 4.1 that

\begin{align*}
M_{\varepsilon}\left(\xi^{*}\right) & \leq \varepsilon^{N} A_{1}+\frac{1}{4} \varepsilon^{N+2 s} A_{2}+C_{1} \varepsilon^{N+\zeta(N+4 s)}-C_{2} \varepsilon^{N+2 s+\zeta(N-2 s)}+o\left(\varepsilon^{N+2 s+\zeta(N-2 s)}\right) \\
& \leq \varepsilon^{N} A_{1}+\frac{1}{4} \varepsilon^{N+2 s} A_{2}-C_{3} \varepsilon^{N+2 s+\zeta(N-2 s)} . \tag{6.4}
\end{align*}
$$

Next, for any $\xi^{\prime} \in \Omega$ with $d\left(\xi^{\prime}, \partial \Omega\right)=\varepsilon^{1-\varpi}$, we get

$$
\begin{align*}
M_{\varepsilon}\left(\xi^{\prime}\right) & \geq \varepsilon^{N} A_{1}+\frac{1}{4} \varepsilon^{N+2 s} A_{2}+C_{1} \varepsilon^{N+\varpi(N+4 s)}-C_{2} \varepsilon^{N+2 s+\varpi(N-2 s)}+o\left(\varepsilon^{N+2 s+\zeta(N-2 s)}\right) \\
& \geq \varepsilon^{N} A_{1}+\frac{1}{4} \varepsilon^{N+2 s} A_{2}+o\left(\varepsilon^{N+2 s+\zeta(N-2 s)}\right), \tag{6.5}
\end{align*}
$$

where $\varrho>0$ is small. Combining (6.4) and (6.5), we see that if $\varepsilon>0$ is small enough, $M_{\varepsilon}(\xi)$ can not attain its minimum on $\left\{\xi: \xi \in \Omega, d(\xi, \partial \Omega)=\varepsilon^{1-\varpi}\right\}$.

On the other hand, for any $\xi^{\prime \prime} \in \Omega$ with $d\left(\xi^{\prime \prime}, \partial \Omega\right)=\varepsilon^{1-\mu}$, we get

M_{\varepsilon}\left(\xi^{\prime \prime}\right) & \geq \varepsilon^{N} A_{1}+\frac{1}{4} \varepsilon^{N+2 s} A_{2}+C_{1} \varepsilon^{N+\mu(N+4 s)}-C_{2} \varepsilon^{N+2 s+\mu(N-2 s)}+o\left(\varepsilon^{N+2 s+\zeta(N-2 s)}\right) \\
& \geq \varepsilon^{N} A_{1}+\frac{1}{4} \varepsilon^{N+2 s} A_{2}+o\left(\varepsilon^{N+2 s+\zeta(N-2 s)}\right) . \tag{6.6}
\end{align*}
$$

Combining (6.4) and (6.6), we see that $\varepsilon>0$ is small enough, $M_{\varepsilon}(\xi)$ also can not attain its minimum on $\left\{\xi: \xi \in \Omega, d(\xi, \partial \Omega)=\varepsilon^{1-\mu}\right\}$.

Thus we have proved that $\xi_{\varepsilon}$ is an interior point of $D_{\varepsilon}$. Since $\varpi<\frac{1}{3}$ can be chosen sufficiently close to $\frac{1}{3}$ and $1>\mu>\frac{1}{3}$ is arbitrary, we can obtain $d\left(\xi_{\varepsilon}, \partial \Omega\right) \in\left(\varepsilon^{\frac{2}{3}+\theta}, \varepsilon^{\frac{2}{3}-\theta}\right)$ for any small $\theta>0$ and the proof of Theorem 1.1 is complete.
Remark 6.1. In fact, taking $\varpi$ as in (6.1), then by a simply calculation, it holds that

$$
\begin{aligned}
2 N+2-(1-\varpi)(N-2 s+2) & >\frac{4}{3}(N+s), \\
3 N+4 s-(1-\varpi)(N-2 s+2) & >\frac{4}{3}(N+s), \\
N+\varpi[(1+p)(N+2 s)-N] & >\frac{4}{3}(N+s) .
\end{aligned}
$$

then we can choose $\frac{1}{3}<\zeta<\min \left\{\zeta_{0}, \mu\right\}$ closes to $\frac{1}{3}$ where $\zeta_{0}$ is given in Lemma 5.1, such that

$$
\begin{aligned}
\varepsilon^{N} O\left(\mu_{\varepsilon, \xi}\right) & =o\left(\varepsilon^{N+2 s+\zeta(N-2 s)}\right), \\
\varepsilon^{N} O\left(\left(\frac{\varepsilon}{d(\xi, \partial \Omega)}\right)^{(1+p)(N+2 s)-N}\right) & =o\left(\varepsilon^{N+2 s+\zeta(N-2 s)}\right),
\end{aligned}
$$

then (6.3) follows. Moreover,

$$
\frac{N+4 s}{6(N+2 s)}>\frac{N-2 s}{3(N+2 s)} \Leftrightarrow N<8 s
$$

and

$$
\frac{N+4 s}{3[(1+p)(N+2 s)-N]}>\frac{N+4 s}{6[p(N+2 s)-N / 2]} \Leftrightarrow p>1
$$

thus (6.1) contains (4.2) and (5.1) when $N<8 s$ and $p>1$.
Remark 6.2. We remark that it is essential to compare between $\tau_{\varepsilon, \xi}$ and $\varepsilon^{2 N} B^{2} H(\xi, \xi)$. Noticing the facts that $N+\frac{1}{3}(N+4 s)=N+2 s+\frac{1}{3}(N-2 s)=\frac{4}{3}(N+s)$ and

$$
\begin{array}{ll}
N+\wp(N+4 s)>N+2 s+\wp(N-2 s), & \text { for any } \wp>\frac{1}{3}  \tag{6.7}\\
N+\wp(N+4 s)<N+2 s+\wp(N-2 s), & \text { for any } \wp<\frac{1}{3}
\end{array}
$$

thus (6.4), (6.5) and (6.6) hold.
From (6.1),

$$
\begin{aligned}
\frac{N+4 s}{3[(1+p)(N+2 s)-N]} & <\frac{1}{3} \Leftrightarrow p>1, \\
\frac{6-2 N-14 s}{3(N+2-2 s)} & <\frac{1}{3} \Leftrightarrow 3 N+12 s-4>0 .
\end{aligned}
$$

Moreover, in Lemma 5.1,

$$
\frac{N}{2}+2 s>\frac{2 N+2 s}{3} \Leftrightarrow N<8 s
$$

Furthermore, in Section 2, we have stated that only for $N \leq 6 s$, the energy functional associated to our problem is well defined. Combining above conditions with the initial condition $N>2 s$, we can conclude that $N$ and $s$ are required satisfying

$$
s \in(0,1) \quad \text { and } \quad 2 s<N \leq 6
$$

i.e.,

$$
2 \leq N \leq 5, \frac{N}{6} \leq s<1 \quad \text { or } \quad N=1, \frac{1}{6} \leq s<\frac{1}{2}
$$
