# THE $K(\pi, 1)$-CONJECTURE IMPLIES THE CENTER CONJECTURE FOR ARTIN GROUPS

#### Abstract

In this note, we prove that the $K(\pi, 1)$-conjecture for Artin groups implies the center conjecture for Artin groups. Specifically, every Artin group without a spherical factor that satisfies the $K(\pi, 1)$-conjecture has a trivial center.


## 1. Introduction

A Coxeter system $(W, S)$ consists of a group $W$ and a generating set $S$ where $W$ is given by a presentation

$$
W=\left\langle s \in S \mid s^{2}=(s t)^{m_{s t}}=1\right\rangle
$$

where $m_{s t} \in\{2,3, \ldots\} \cup\{\infty\}$. The associated Artin group $A$ is given by the presentation

$$
A=\langle s \in S \mid \underbrace{s t s \cdots}_{m_{\text {st terms }}}=\underbrace{\text { tst } \cdots}_{m_{\text {st terms }}}\rangle .
$$

An Artin group $A$ is spherical if the corresponding Coxeter group is finite, and otherwise $A$ is infinite type. The Coxeter diagram $\Gamma_{S}$ is a graph with vertices corresponding to $S$ and where two vertices are joined by an edge if and only if $m_{s t}>2$. If $m_{s t} \geq 4$ we label the edge with $m_{s t}$. A special subgroup of $A$ is a subgroup generated by some subset of $S$. Each special subgroup is itself an Artin group vdL83. Each Artin group with standard generating set admits (a possibly trivial) decomposition $A=A_{T_{1}} \times \cdots \times A_{T_{n}}$ where each $T_{i} \subseteq S$ defines a connected component of the Coxeter graph $\Gamma_{S}$. An Artin group $A$ is irreducible if its Coxeter diagram is connected. We say $A_{T_{i}}$ is a spherical factor of $A$ if $A_{T_{i}}$ is spherical. Every irreducible spherical Artin group has an infinite cyclic center [Del72, BS72]. Conjecturally, those are the only irreducible Artin groups with nontrivial center.

Conjecture 1 (The Center Conjecture). Every Artin group without a spherical factor has trivial center.

The center conjecture holds for FC-type Artin groups and 2-dimensional Artin groups [GP12]. Charney and Morris-Wright have shown the center conjecture holds for Artin groups whose defining graphs are not stars of a single vertex CMW19. Godelle and Paris further showed that if all Artin groups with $m_{s t} \neq \infty$ for all $s, t \in S$ satisfy the center conjecture, then all Artin groups satisfy the center conjecture GP12.

The FC-type and 2-dimensional Artin groups also satisfy the $K(\pi, 1)$-conjecture CD95.

Conjecture 2 (The $K(\pi, 1)$-conjecture). The orbit space $\mathcal{H}(W) / W$ of a complexified hyperplane arrangement associated to a Coxeter system $(W, S)$ is a $K(\pi, 1)$ for the Artin group $A$ associated to $W$.

For a precise definition of $\mathcal{H}(W)$ and more background, see e.g. the survey paper Par14. It is known that the fundamental group of $\mathcal{H}(W) / W$ is equal to $A$, so the conjecture is about the asphericity of $\mathcal{H}(W) / W$. In this note, we prove the following:

Theorem 3. Every Artin group without a spherical factor that satisfies the $K(\pi, 1)$-conjecture has trivial center.

In fact, we only need the following consequence of the $K(\pi, 1)$-conjecture: an Artin group $A$ which satisfies the $K(\pi, 1)$-conjecture has finite cohomological dimension which is realized by a spherical subgroup, i.e. $\operatorname{cd}(A)=\operatorname{cd}\left(A_{T}\right)=|T|$ for some spherical subset $T$. See Theorem 12 for the more general statement of our main theorem.

For example, in McC17] McCammond mentions that the center conjecture is unknown for the Artin group $A$ with the Coxeter diagram as in Figure 1. The group $A$ is given by the presentation

$$
\langle a, b, c, d \mid a b a=b a b, b c b=c b c, c d c=d c d, d a d=a d a, b d b=d b d, a c=c a\rangle .
$$

The $K(\pi, 1)$-conjecture holds for $A$ by a theorem of Charney [Cha04]. That allows us to answer the question of McCammond.

Corollary 4. The Artin group with the Coxeter diagram as in Figure has trivial center.
Another class of Artin groups which satisfy the $K(\pi, 1)$-conjecture are the locally reducible Artin groups, where all irreducible spherical subgroups are of rank $\leq 2$ Cha00. There are many of these with $m_{s t} \neq \infty$ for each $s, t \in S$, and as far as we know the center conjecture was open here.

Corollary 5. Every locally reducible Artin group without spherical factor has trivial center.

## 2. Representations of Artin groups in mapping class groups

An Artin group $A$ with standard generating set $S$ has small type if $m_{s t} \in\{2,3\}$ for all $s, t \in S$. In this section we recall a representation of small type Artin groups in mapping class groups, due to Crisp-Paris CP01, and analyze where certain elements of $A$ are mapped.

Let $\Sigma$ be a surface. A multicurve is a collection of pairwise disjoint simple closed curves on $\Sigma$. We say that two multicurves are disjoint if their isotopy classes have disjoint representatives. A multitwist about a multicurve $\gamma$ is a product of non-trivial powers of Dehn

twists about simple closed curves in $\gamma$ (the powers can be different for different curves). We shall need the following lemma about commuting multitwists about multicurves.
Lemma 6. Let $\gamma$ and $\gamma^{\prime}$ be essential multicurves on $\Sigma$ that do not share a simple closed curve. Let $T_{\gamma}$ and $T_{\gamma^{\prime}}$ be the associated multitwists along $\gamma$ and $\gamma^{\prime}$. Then $T_{\gamma}$ and $T_{\gamma^{\prime}}$ commute if and only $\gamma$ and $\gamma^{\prime}$ are disjoint.
Proof. The if direction is clear, so suppose $T_{\gamma}$ and $T_{\gamma^{\prime}}$ commute. Then $T_{\gamma}^{N}$ and $T_{\gamma^{\prime}}^{N}$ commute for all $N$. By a theorem of Koberda [Kob12], the group generated by large powers of Dehn twists of all curves in $\gamma \cup \gamma^{\prime}$ is a right-angled Artin group. Therefore, we have two words $w$ and $w^{\prime}$ in a RAAG, where $w$ and $w^{\prime}$ are nontrivial powers of commuting generators. It follows from the normal form for RAAG's that these commute exactly when each generator in $w$ commutes with each generator of $w^{\prime}$ HM95. Therefore, the curves in $\gamma$ can be isotoped to be disjoint from the curves in $\gamma^{\prime}$.

Let $A_{S}$ be a small type Artin group with standard generating set $S$. We can build an associated surface

$$
\Sigma_{S}=\bigcup_{s \in S} A n_{s}
$$

where each $A n_{s}$ is an annulus. We denote the meridian of $A n_{s}$ by $\gamma_{s}$. If $m_{s t}=3$, then we arrange that the annuli $A n_{s}, A n_{t}$ intersect in a single square so that $\gamma_{s}, \gamma_{t}$ intersect transversely at one point, and any triple intersection of annuli is empty. If $m_{s t}=2$, then $A n_{s}, A n_{t}$ will be disjoint. See Figure 2 for an example. There is a representation of $A_{S}$ in the mapping class group of $\Sigma_{S}$ where each generator $s \in S$ is mapped to the Dehn twist about the simple closed curve $\gamma_{s}$ (see Proposition (9). Full details can be found in CP01. Each subset $T$ of $S$ has an associated subsurface $\Sigma_{T}$ of $\Sigma_{A}$. By construction, the subsurface $\Sigma_{T}$ for an irreducible spherical subset $T \subseteq S$ and the induced homomorphism $\rho_{T}: A_{T} \rightarrow \operatorname{Mod}\left(\Sigma_{T}\right)$ are exactly the Perron-Vannier representation of small type spherical Artin groups [PV96] (see also [JS20]). For every spherical subset $T$, the generator of the center of the group $A_{T}$ is denoted by $z_{T}$. By [LP01, Prop 2.12] $\rho\left(z_{T}^{4}\right)$ is a multitwist about the boundary of $\Sigma_{T}$. We denote that multicurve by $\Gamma_{T}$.

Let $K_{S}$ be the graph that is the union $\bigcup_{s \in S} \gamma_{s} \subseteq \Sigma_{S}$. By construction, there is a deformation retraction $r: \Sigma_{S} \rightarrow K_{S}$. Thus $H_{1}\left(\Sigma_{S}\right)=H_{1}\left(K_{S}\right)$, and in particular if $S$ is spherical then $H_{1}\left(\Sigma_{S}\right)=\mathbb{Z}^{S}$. For any $S^{\prime} \subset S$, the map $H_{1}\left(\Sigma_{S^{\prime}}\right) \rightarrow H_{1}\left(\Sigma_{S}\right)$ induced by the inclusion $\Sigma_{S^{\prime}} \hookrightarrow \Sigma_{S}$ is injective and $H_{1}\left(\Sigma_{S^{\prime}}\right) \subsetneq H_{1}\left(\Sigma_{S}\right)$.

Every closed path in a graph is homotopic to a cycle (i.e. a closed path without backtracks). In particular, every homotopy class of a simple closed curve in $\Sigma_{S}$ can be realized as a cycle in $K_{S}$. We will now view all the simple closed curves in $\Sigma_{S}$ as cycles in $K_{S}$. In particular, we view components of $\gamma_{T}$ for any spherical subset $T \subseteq S$ as cycles in $K_{S}$.

Lemma 7. Let $T \subseteq S$ be an irreducible spherical subset, and $s \in S-T$. Then $\gamma_{s}$ intersects $\gamma_{T}$ if and only if $\gamma_{s}$ intersects $\gamma_{t}$ for some $t \in T$.

Proof. If $\gamma_{s}$ does not intersect any $\gamma_{t}$ for $t \in T$, then $\rho(s)$ commutes with $\rho(t)$ for all $t \in T$. Then $\rho(s)$ must also commute with $\rho\left(z_{T}^{2}\right)$, and by Lemma $6 \gamma_{s}$ and $\gamma_{T}$ are disjoint.

Now suppose that $\gamma_{s}$ intersects $\gamma_{t}$ for some $t \in T$. By construction $\gamma_{s}, \gamma_{t}$ intersect exactly once. Suppose $\gamma_{s}$ can be isotoped in $\Sigma_{S}$ to be disjoint from $\partial \Sigma_{T}$. Then $\gamma_{s} \subseteq \Sigma_{T}$, since $\gamma_{s}, \gamma_{t}$ still must intersect. In particular, $\left[\gamma_{s}\right] \in H_{1}\left(\Sigma_{T}\right)=H_{1}\left(K_{T}\right)$. This is a contradiction, since $H_{1}\left(K_{T}\right) \subsetneq H_{1}\left(K_{T \cup\{s\}}\right)$.

Lemma 8. Let $T_{1}, T_{2} \subseteq S$ be two disjoint, irreducible, spherical subsets. Then any component of $\gamma_{T_{1}}$ and any component of $\gamma_{T_{2}}$ are non-isotopic and disjoint in $\Sigma_{S}$.

Proof. Since $T_{1}, T_{2} \subseteq S$ are disjoint, by construction, the subgraphs $K_{T_{1}}, K_{T_{2}} \subseteq K_{S}$ are disjoint. Every connected component of $\gamma_{T_{i}}$ can be realized as a cycle contained in $K_{T_{i}}$. Any two disjoint cycles in a graph are non-isotopic. The conclusion follows.

Proposition 9 ([CP01]). For every small type Artin group $A$ with the standard generating set $S$, there exists a surface with boundary $\Sigma_{S}$ and a homomorphism $\rho: A \rightarrow \operatorname{Mod}\left(\Sigma_{S}\right)$ where
(a) for each $s \in S, \rho(s)$ is the Dehn twist about a simple closed curve $\gamma_{s}$,
(b) the simple closed curves $\gamma_{s}, \gamma_{t}$ are disjoint $\Longleftrightarrow m_{s t}=2$,
(c) the simple closed curves $\gamma_{s}, \gamma_{t}$ intersect exactly once $\Longleftrightarrow m_{s t}=3$.

Moreover,
(d) for every irreducible spherical subset $T \subseteq S, \rho\left(z_{T}^{2}\right)$ is the multitwist about a multicurve $\gamma_{T}$ which is the boundary of the subsurface $\Sigma_{T}$, and
(e) for every irreducible spherical $T \subseteq S$ and $s \in S-T$, the simple closed curve $\gamma_{s}$ and the multicurve $\Gamma_{T}$ are disjoint if and only if $[s, t]=1$ for all $t \in T$.

Proof. The fact that $\rho$ is a homomorphism follows from standard relations between Dehn twists, see [CP01, Prop 4]. The parts (a), (b), (c) follow from [CP01] as well. Part (d) follows from [LP01] (see discussion above). Finally part (e) is a consequence of Lemma 7 and Lemma 6 .

Let $A$ be an Artin group with standard generating set $S$. We say $A$ is free-of-infinity if $m_{s t}<\infty$ for all $s, t \in S$.

Proposition 10 ([CP01]). Let $A$ be a free-of-infinity Artin group. Then there exists a small type Artin group $\widetilde{A}$ with standard generating set $\widetilde{S}$ and a homomorphism $\phi: A \rightarrow \widetilde{A}$ such that

- there exists a partition $\bigsqcup_{s \in S} I(s)$ of $\widetilde{S}$ such that the elements of $I(s)$ pairwise commute and $\phi(s)=\prod_{r \in I(s)} r$,
- $m_{s t}=2$ if and only if every element of $I(s)$ and every element of $I(t)$ commute, and
- if $m_{s t} \geq 3$ then the subgroup generated by $I(s) \cup I(t)$ is a direct product of braid groups on $m_{s t}$ strands.
Let $\rho \circ \phi: A \rightarrow \operatorname{Mod}\left(\Sigma_{\widetilde{A}}\right)$ be the composition of the homomorphism $\phi$ with the homomor$\operatorname{phism} \rho: \widetilde{A} \rightarrow \operatorname{Mod}\left(\Sigma_{\widetilde{A}}\right)$ from Proposition 9, Then
(a) for each $s \in S, \rho \circ \phi(s)$ is a multitwist about a multicurve $\gamma_{s}=\bigcup_{r \in I(s)} \gamma_{r}$,
(b) $m_{s t}=2$ if and only if every component of $\gamma_{s}$ and every component of $\gamma_{t}$ are disjoint,
(c) for every spherical subset $T \subset S, \rho\left(z_{T}^{2}\right)$ is the multitwists about a multicurve $\gamma_{T}$, and
(d) for every $T \subseteq S$ and $s \in S-T$, the multicurve $\gamma_{s}$ and the multicurve $\gamma_{T}$ are disjoint if and only if $[s, t]=1$ for all $t \in T$.

Proof. The homomorphism $\phi$ is described in Cri99] and also in CP01. Parts (a) and (b) follow directly from the construction. Part (c) is proven in [JS20, Lem 6.1]. Part (d) follows from Lemma 7 and Lemma 6.

## 3. The main theorem

We will need the following lemma.
Lemma 11. Let $A_{S}$ be an Artin group which splits as a product $A_{S}=A_{U} \times A_{V}$ where $A_{U}$ is the maximal spherical factor. Suppose that $\operatorname{cd} A_{S}<\infty$. Then $\operatorname{cd} A_{S}=\operatorname{cd} A_{U}+\operatorname{cd} A_{V}$.

Proof. By [Bie81, Thm 5.5] a group $G=N \times Q$ has $\operatorname{cd} G=\operatorname{cd} N+\operatorname{cd} Q$ provided that

- $\operatorname{cd} Q<\infty$, and
- $N$ is of type FP and $H^{n}(N, \mathbb{Z} N)$ is free for $n=\operatorname{cd} N$.

Clearly cd $A_{V}<\infty$ since cd $A_{S}<\infty$. Since $A_{U}$ is a spherical Artin group, $A_{U}$ has type $F P$. By Squ94, Thm B] (see also Bes99]) $A_{U}$ is a duality group, so $H^{n}\left(A_{U}, \mathbb{Z} A_{U}\right)$ is free. The conclusion follows.

Theorem 12. Let $A_{S}$ be an Artin group of infinite type with the standard generating set $S$ such that $A_{S}$ has no spherical factors. If $\mathrm{cd} A=\operatorname{cd} A_{T}=|T|$ for some spherical subset $T \subseteq S$, then $A_{S}$ has trivial center. In particular if $A_{S}$ satisfies the $K(\pi, 1)$-conjecture, then $A_{S}$ has trivial center.

Proof for free-of-infinity case. First suppose that $A_{S}$ is free-of-infinity. Let $T \subseteq S$ be a maximal spherical subset such that $\mathrm{cd} A_{S}=\operatorname{cd} A_{T}$. Let $T_{1} \sqcup T_{2} \sqcup \cdots \sqcup T_{n}$ be the decomposition of $T$ into irreducible spherical subsets inducing the decomposition $A_{T}=A_{T_{1}} \times \cdots \times A_{T_{n}}$. Since $A_{S}$ has no spherical factors for each $i=1, \ldots, n$ there exists $s_{i} \in S-T$ such that $\left[s_{i}, z_{T_{i}}\right] \neq 1$ as otherwise $A_{T_{i}}$ would be a spherical factor of $A_{S}$. In particular, for each $i=1, \ldots, n$, there exists $t_{i} \in T_{i}$ such that $\left[s_{i}, t_{i}\right] \neq 1$.

Consider the representation of $\rho: A_{S} \rightarrow \operatorname{Mod}\left(\Sigma_{S}\right)$ from Proposition 10. By Proposition 10, $\rho\left(s_{i}\right)$ and $\rho\left(z_{T_{i}}\right)$ are the Dehn twists about multicurves $\gamma_{s_{i}}$ and $\gamma_{T_{i}}$ respectively, where $\gamma_{s_{i}}$ and $\gamma_{T_{i}}$ intersect.

Suppose that $A_{S}$ has nontrivial center and let $y \in Z\left(A_{S}\right)$ with $y \neq e$. Note that $y$ has infinite order since $A_{S}$ is torsion-free, as cd $A_{S}<\infty$. If $y^{k} \notin A_{T}$ for any $k \neq 0$, then $\left\langle A_{T}, y\right\rangle \simeq A_{T} \times \mathbb{Z}$ is a subgroup of $\operatorname{cd} A+1$, which is a contradiction. Thus there exists $k \in \mathbb{N}$ such that $y^{k} \in A_{T}$. Then $y^{k} \in Z\left(A_{T}\right)$, i.e. $y^{m}=\prod_{i=1}^{n} z_{T_{i}}^{m_{i}}$ for some $m>0$ and at least one of $m_{1}, \ldots, m_{n}$, say $m_{1}$, is non-zero. By Lemma $\mathbb{B}, \rho\left(y^{m}\right)$ is a multitwist about a multicurve $\gamma=\sqcup \gamma_{T_{i}}$ in $\Sigma$ where the union is taken over all $i$ such that $m_{i} \neq 0$. In particular, $\gamma$ intersects $\gamma_{s_{1}}$. By Lemma [6, $\left[\rho\left(y^{m}\right), \rho\left(s_{1}\right)\right] \neq 1$. Thus $\left[y, s_{1}\right] \neq 1$. This contradicts the fact that $y$ is a central element of $A$.

Proof for general case. The general case is induction on the cardinality of $S$. Suppose $\operatorname{cd} A_{S}=\operatorname{cd} A_{T}$ where $T \subseteq S$ is a spherical subset. Suppose there exist generators $v, w \in S$ such that $m_{v w}=\infty$. The group $A_{S}$ splits as an amalgamated product $A_{S \backslash\{v\}} *_{A_{S \backslash\{v, w\}}} A_{S \backslash\{w\}}$. Since $T$ cannot contain both $v$ and $w$, we have $T \subseteq S \backslash\{v\}$ or $T \subseteq S \backslash\{w\}$. Without loss of generality we assume that $T \subseteq S \backslash\{v\}$. It follows that $\mathrm{cd} A_{S \backslash\{v\}}=\operatorname{cd} A_{T}$, as $\operatorname{cd} A_{S \backslash\{v\}} \leq \operatorname{cd} A_{S}$. If $A_{S \backslash\{v\}}$ has no spherical factor, then by induction $A_{S \backslash\{v\}}$ has trivial center. By [GP12, Lem 3.2] the center of the amalgamated product $A$ is also trivial.

Now suppose that $A_{S \backslash\{v\}}$ has a nontrivial spherical factor. Let

$$
A_{U_{1}} \times \cdots \times A_{U_{p}} \times A_{V_{1}} \times \cdots \times A_{V_{q}}
$$

be the decomposition of $A_{S \backslash\{v\}}$ into irreducible factors where each $A_{U_{i}}$ is spherical and each $A_{V_{j}}$ has infinite type. Let $A_{V}=A_{V_{1}} \times \cdots \times A_{V_{q}}$. By maximality $U_{i} \subseteq T$ for all $i=1, \ldots, p$. Let $T^{\prime}=V \cap T$. Then $\operatorname{cd} A_{V}=\operatorname{cd} A_{T^{\prime}}$. Indeed by Lemma 11,

$$
\operatorname{cd} A_{V}=\operatorname{cd} A_{S \backslash\{v\}}-\sum_{i=1}^{p} \operatorname{cd} A_{U_{i}}=\operatorname{cd} A_{T}-\sum_{i=1}^{p} \operatorname{cd} A_{U_{i}}=A_{T^{\prime}}
$$

By the inductive assumption $Z\left(A_{V}\right)=\{1\}$, and thus $Z\left(A_{S \backslash\{v\}}\right) \subseteq\left\langle z_{U_{1}}\right\rangle \times \cdots \times\left\langle z_{U_{n}}\right\rangle$.
Since $A_{S}$ does not have a spherical factor, for every $i=1, \ldots, n$ we have $\left[v, z_{U_{i}}\right] \neq 1$. In particular, each set $U_{i}$ contains a standard generator $u_{i}$ such that $m_{v u_{i}} \geq 3$. Since $Z\left(A_{S \backslash\{v\}}\right) \subseteq A_{T}$ and by [GP12, Lem 3.2] $Z(A) \subseteq Z\left(A_{S \backslash\{v\}}\right)$, it suffices to prove that $v$ does not commute with any nontrivial element of $Z\left(A_{T}\right)=\left\langle z_{T_{1}}, \ldots, z_{T_{n}}\right\rangle$. By maximality of $T$, $A_{T \cup\{v\}}$ is not spherical. By the discussion above, $A_{T \cup\{v\}}$ is irreducible, and in particular it has no spherical factors. If $A_{T \cup\{v\}}$ is free-of-infinity, we are done.

We now assume that $A_{T \cup\{v\}}$ is not free-of-infinity. Consider the quotient homomorphism $\phi: A_{T \cup\{v\}} \rightarrow A_{\bar{T} \cup\{\bar{v}\}}$, where for every $t \in T$ such that $m_{t v}=\infty$ the corresponding generators $\bar{t}, \bar{v} \in \bar{T} \cup\{\bar{v}\}$ have $m_{\bar{t} \bar{v}}=7$. The group $A_{\bar{T} \cup\{\bar{v}\}}$ is irreducible. The only irreducible spherical Artin group containing label 7 is the dihedral Artin group. If $A_{\bar{T} \cup\{\bar{v}\}}$ is the dihedral Artin group, then $A_{T \cup\{v\}}=F_{2}$ and so $c d A_{S}=1$, i.e. $A_{S}=F(S)$. Then clearly, $A_{S}$ has trivial center. Otherwise $A_{\bar{T} \cup\{\bar{v}\}}$ is irreducible and has infinite type. Also $\operatorname{cd} A_{\bar{T} \cup\{\bar{v}\}}=\operatorname{cd} A_{\bar{T}}$. By the free-of-infinity case, $[\bar{v}, \bar{y}] \neq 1$ for any nontrivial $\bar{y} \in\left\langle z_{\bar{T}_{1}}, \ldots, z_{\bar{T}_{n}}\right\rangle$, as otherwise $y$ would be a central element of $A_{\bar{T} \cup\{\bar{v}\}}$. Thus $[v, y] \neq 1$ for any nontrivial $y \in\left\langle z_{T_{1}}, \ldots, z_{T_{n}}\right\rangle$. This completes the proof.
