# MAGNETIC SLOWDOWN OF TOPOLOGICAL EDGE STATES 

G. BAL, S. BECKER, AND A. DROUOT


#### Abstract

We study the propagation of wavepackets along curved interfaces between topological, magnetic materials. Our Hamiltonian is a massive Dirac operator with a magnetic potential. We construct semiclassical wavepackets propagating along the curved interface as adiabatic modulations of straight edge states under constant magnetic fields. While in the magnetic-free case, the wavepackets propagate coherently at speed one, here they experience slowdown, dispersion, and Aharonov-Bohm effects. Several numerical simulations illustrate our results.


## 1. Introduction

This paper analyzes wavepackets propagating along an interface between two topologically distinct materials, in the presence of an external magnetic field. It extends constructions carried out in $\left[\mathrm{BBD}^{+} 21\right]$ for magnetic-free models. We represent here the electron dynamics via a two-dimensional Dirac equation:

\left(\varepsilon D_{t}+\not D\right) \Psi(t, x)=0, \quad(t, x) \in \mathbb{R} \times \mathbb{R}^{2} \tag{1.1}
\end{equation*}

In (1.1), $\not D$ denotes a Dirac operator with sign-changing mass and magnetic field:

$$
\not D=\left(\varepsilon D_{1}-A_{1}(x)\right) \sigma_{1}+\left(\varepsilon D_{2}-A_{2}(x)\right) \sigma_{2}+\kappa(x) \sigma_{3}, \quad \text { where: }
$$

- $\varepsilon>0$ is a small semiclassical parameter and $\varepsilon D_{t}=-i \varepsilon \partial_{t}, \varepsilon D_{j}=-i \varepsilon \partial_{j}$ denote the self-adjoint semiclassical derivatives;
- $A=\left(A_{1}, A_{2}\right)^{t} \in C^{\infty}\left(\mathbb{R}^{2}, \mathbb{R}^{2}\right)$ is a magnetic potential with $\nabla A \in C_{b}^{\infty}$ (i.e. smooth with all derivatives uniformly bounded), inducing the magnetic field $B=\partial_{1} A_{2}-\partial_{2} A_{1}$;
- $\kappa \in C^{\infty}\left(\mathbb{R}^{2}, \mathbb{R}\right)$ has varying sign and satisfies $\nabla \kappa \in C_{b}^{\infty}$;
- $\sigma_{1}, \sigma_{2}, \sigma_{3}$ are the standard $2 \times 2$ Pauli matrices.

The sign of the domain wall $\kappa$ characterizes the topological phase of the material. Specifically, under the transversality condition

\kappa(y)=0 \quad \Rightarrow \quad \nabla \kappa(y) \neq 0 \tag{1.2}
\end{equation*}
$$

the interface $\Gamma=\kappa^{-1}(0)$ separates regions of distinct local topology [Bal19a, $\left.\mathrm{BBD}^{+} 21\right]$. For analytic reasons, we consider here a uniform version of (1.2):

$$
\inf \{|\nabla \kappa(x)|: x \in \Gamma\}>0
$$

The bulk-edge correspondence for Dirac operators [Bal19a] predicts that a tubular neighborhood of $\Gamma=\kappa^{-1}(0)$ supports asymmetric currents, hence (some analogue of) edge states for small $\varepsilon$. For vanishing magnetic potentials, we constructed in $\left[\mathrm{BBD}^{+} 21\right]$ long-lived solutions to (1.1). These were confined and propagating at speed one along $\Gamma$. We referred to
them as dynamical edge states, since we derived them as time-dependent adiabatic modulations of straight edge states. This paper extends the construction to the magnetic case. A non-zero magnetic field induces several new phenomena for dynamical edge states:
(i) A systematic slowdown, see Figure 1;
(ii) A large phase-shift, generating a Aharonov-Bohm effect when $\Gamma$ is a loop;
(iii) In general, a mesoscopic dispersion along $\Gamma$.

We set a few notations in $\S 1.1$, state a simplified main result in $\S 1.2$, and detail the effects (i)-(iii) in §1.3.

1.1. Notations. We first define the normal and tangent vector fields to the level sets of $\kappa$ :

$$
n(x)=\frac{\nabla \kappa(x)}{|\nabla \kappa(x)|}, \quad \tau(x)=\operatorname{Jn}(x), \quad J=\left[\begin{array}{cc}
0 & -1 \\
1 & 0
\end{array}\right] .
$$

Given $y_{0} \in \Gamma$, we let $y_{t}$ be the solution of the ODE

$$
\begin{equation*}
\dot{y}_{t}=c\left(y_{t}\right) \tau\left(y_{t}\right), \quad c(y):=\frac{|\nabla \kappa(y)|}{\sqrt{|\nabla \kappa(y)|^{2}+B(y)^{2}}}, \tag{1.3}
\end{equation*}
$$

where $B=\nabla \times A$ is the magnetic field. Note that $\partial_{t} \kappa\left(y_{t}\right)=0$ since $\nabla \kappa(x) \cdot \tau(x)=0$, hence $y_{t} \in \Gamma$ for any $t \in \mathbb{R}$. We then define the quantities

$$
B_{t}=B\left(y_{t}\right), \quad n_{t}=\frac{\nabla \kappa\left(y_{t}\right)}{\left|\nabla \kappa\left(y_{t}\right)\right|}, \quad r_{t}=\left|\nabla \kappa\left(y_{t}\right)\right|, \quad \rho_{t}=\sqrt{r_{t}^{2}+B_{t}^{2}}, \quad \gamma_{t}=\frac{B_{t}}{\rho_{t}^{2}}
$$

To capture the local geometry of the interface near $y_{t}$, we define two smoothly varying angles $\varphi_{t}$ and $\theta_{t}$ (and the corresponding clockwise rotation $R_{\theta_{t}}$ ) by

\cos \varphi_{t}=\frac{r_{t}}{\rho_{t}}:=c_{t}, \quad \sin \varphi_{t}=\frac{B_{t}}{\rho_{t}}:=s_{t}, \quad R_{\theta_{t}}=\left[\begin{array}{cc}
\cos \theta_{t} & \sin \theta_{t}  \tag{1.4}\\
-\sin \theta_{t} & \cos \theta_{t}
\end{array}\right]
$$

see Figure 2; we assume $\varphi_{0}$ and $\theta_{0}$ belong to $[0,2 \pi)$ for concreteness. With these notations, $R_{\theta_{t}} n_{t}=e_{2}$ and $\dot{y_{t}}=c_{t} \tau_{t}$ with $\tau_{t}=J n_{t}$. Differentiating the equation defining $\theta_{t}$, we observe that $\dot{n}_{t}+\dot{\theta}_{t} \tau_{t}=0$. Since $\dot{y}_{t}=c_{t} \tau_{t}$, we deduce that $\dot{\theta}_{t}=-c_{t}\left(\tau \cdot \partial_{\tau} n\right)\left(y_{t}\right)$. In particular, $\left|\dot{\theta}_{t}\right|=c_{t} K_{t}$ where $K_{t}$ is the curvature of the curve $\Gamma$ at $y_{t}$.

We also introduce the unitary pullback operator $\mathcal{R}_{\theta_{t}}$ by $R_{\theta_{t}}$ as $\mathcal{R}_{\theta_{t}} g(z)=g\left(R_{\theta_{t}} z\right)$. Associated to $\theta_{t}$ and $\varphi_{t}$ are two spinorial rotations,

U_{2, \varphi_{t}}=e^{-i \frac{\varphi_{t}}{2} \sigma_{2}}, \quad U_{3, \theta_{t}}=e^{-i \frac{\theta_{t}}{2} \sigma_{3}}
$$

1.2. Simplified main result. For the sake of simplicity, we consider a restricted setup: the domain wall satisfies a geometric condition and the magnetic field is constant. Our main result, 6.2, takes then a clearer form.

The aforementioned assumptions are:

- $\kappa \in C^{\infty}\left(\mathbb{R}^{2}, \mathbb{R}\right)$ with $\nabla \kappa \in C_{b}^{\infty}$ satisfies

$$
\begin{equation*}
y \in \kappa^{-1}(0) \quad \Rightarrow \quad|\nabla \kappa(y)|=1, \quad \Delta \kappa(y)=0 \tag{1.5}
\end{equation*}
$$

- The magnetic field $B$ is constant.

While (1.5) is analytically restrictive, it is not geometrically restrictive: any one-dimensional submanifold of $\mathbb{R}^{2}$ is the zero set of a function $\kappa$ satisfying (1.5). For instance, for the straight edge $\Gamma=\mathbb{R} e_{2}$, we can choose $\kappa(y)=y_{2}$ while for the unit circle $\Gamma=\mathbb{S}^{1}$ we can choose $\kappa(y)=\ln |y|$ (near $|y|=1$ ). When the two above conditions hold, the quantities $r_{t}, B_{t}, \rho_{t}, \gamma_{t}, \varphi_{t}, c_{t}$ and $s_{t}$ do not depend on $t$, and we omit the subscript $t$.

The most elementary setup with these two conditions consists of $\kappa(x)=x_{2}$ and $A=$ $-B x_{2} e_{1}$. The corresponding Dirac operator is:

\begin{equation*}
\not D_{0, B}:=\left(\varepsilon D_{1}+B x_{2}\right) \sigma_{1}+\varepsilon D_{2} \sigma_{2}+x_{2} \sigma_{3} . \tag{1.6}
\end{equation*}
$$

We remark that the magnetic potential vanishes along the interface $\mathbb{R} e_{1}$ and is parallel to it. The equation $\left(\varepsilon D_{t}+D_{0, B}\right) \Psi=0$ admits an explicit family of non-dispersive wavepacket solutions that propagate along $\Gamma$ at speed $c=\left(1+B^{2}\right)^{-1 / 2}$ :

\Psi_{0, B}(x):=\frac{1}{\sqrt{\varepsilon}} \psi_{0, B}\left(\frac{x-c t e_{1}}{\sqrt{\varepsilon}}\right), \quad \psi_{0, B}(z):=\int_{\mathbb{R}} e^{i \xi z_{1}-\frac{1}{2} \rho\left(z_{2}+\gamma \xi\right)^{2}} \hat{f}(\xi) d \xi \cdot U_{2, \varphi}\left[\begin{array}{c}
1  \tag{1.7}\\
-1
\end{array}\right],
$$

where $\hat{f}$ is any Schwartz-class function, $\rho=\sqrt{1+B^{2}}, \gamma=\frac{B}{1+B^{2}}$, and $\varphi=\arctan B$.
We extend this statement to interfaces tilted by an angle $\theta \in \mathbb{R}$. Let $\Phi_{\theta, B}$ be the Dirac operator with domain wall and magnetic potential

$$
\kappa(x)=n \cdot x, \quad A(x)=B \kappa(x) \tau, \quad n=\left[\begin{array}{c}
-\sin \theta \\
\cos \theta
\end{array}\right], \quad \tau=-\left[\begin{array}{c}
\cos \theta \\
\sin \theta
\end{array}\right] .
$$

The equation $\left(\varepsilon D_{t}+\not D_{\theta, B}\right) \Psi=0$ is unitarily equivalent to the case $\theta=0$ and admits a family of solutions constructed from $\Psi_{0, B}$ :

$$
\Psi_{\theta, B}(x):=\frac{1}{\sqrt{\varepsilon}} \psi_{\theta, B}\left(\frac{x-c t \tau}{\sqrt{\varepsilon}}\right), \quad \psi_{\theta, B}(z):=U_{3, \theta} \mathcal{R}_{\theta} \psi_{0, B}(z)
$$

Our main result produces approximate solutions to $\left(\varepsilon D_{t}+\not D\right) \Psi=0$ as modulations of $\psi_{\theta, B}$. To state it, we need the distribution $g_{t}$ on $\mathbb{R}^{2}$ defined by:

$$
\begin{equation*}
g_{t}(z):=\int_{\mathbb{R}^{2}} e^{i \zeta z+i \gamma\left(\theta_{t}-\theta_{0}\right) \zeta_{1}^{2}} d \zeta=\frac{e^{-i \pi / 4}}{\left|2 \pi \gamma\left(\theta_{t}-\theta_{0}\right)\right|^{1 / 2}} e^{i \frac{-z_{1}^{2}}{4 \gamma\left(\theta_{t}-\theta_{0}\right)}} \cdot \delta_{0}\left(z_{2}\right) \tag{1.8}
\end{equation*}
$$

The second equality is valid for $\theta_{t} \neq \theta_{0}$ and should be replaced by a Dirac mass when $\theta_{t}=\theta_{0}$. Our simplified theorem for constant magnetic fields reads then as follows.

Theorem 1.1. Assume that $\kappa$ satisfies the condition (1.5) and that $B$ is constant. For any $\mathrm{T}>0$, the equation $\left(\varepsilon D_{t}+\not D\right) \Psi=0$ admits solutions that satisfy, uniformly for $t \in[-\mathrm{T}, \mathrm{T}]$ and $x \in \mathbb{R}^{2}$ :

\begin{align*}
& \Psi(t, x)=\frac{e^{\frac{i}{\varepsilon} \chi(t, x)}}{\sqrt{\varepsilon}} \psi\left(t, \frac{x-y_{t}}{\sqrt{\varepsilon}}\right)+O_{L^{2}}\left(\varepsilon^{1 / 2}\right), \quad \text { where } \quad \psi(t, z):=\left(\mathcal{R}_{\theta_{t}} g_{t}\right) * \psi_{\theta_{t}, B}(z),  \tag{1.9}\\
& \text { and } \quad \chi(t, x)=\int_{0}^{t} \dot{y_{s}} \cdot A\left(y_{s}\right) d s+A\left(y_{t}\right) \cdot\left(x-y_{t}\right)+\left(x-y_{t}\right) \cdot\left(\nabla A\left(y_{t}\right)^{\top}-B n_{t} \tau_{t}^{\top}\right)\left(x-y_{t}\right) .
\end{align*}
$$

The leading order term in (1.9):
(i) Propagates at speed $c=\left(1+B^{2}\right)^{-1 / 2}$ along $\Gamma$, in the prescribed direction $\tau$.
(ii) Is semiclassically localized at the phase-space point $\left(y_{t}, A_{t}\right)$ with $A_{t}=A\left(y_{t}\right)$. This is where the eigenvalues of the symbol of $\not D$ are degenerate. While the rapid oscillations generated by $A_{t}$ can be locally gauged away, they cannot be globally neglected when $\Gamma$ is a closed loop: this is the Aharonov-Bohm effect.
(iii) Disperses along $\Gamma$ at rate prescribed by the difference $\theta_{t}-\theta_{0}$ :

$$
\begin{equation*}
|\psi(t, z)| \leq \frac{C}{1+\left|\theta_{t}-\theta_{0}\right|^{1 / 2}} \sup _{z \in \mathbb{R}^{2}}|\psi(0, z)| . \tag{1.10}
\end{equation*}
$$

In particular, the leading part in (1.9) is controlled by $\varepsilon^{-1 / 2}\left|\theta_{t}-\theta_{0}\right|^{-1 / 2}$. This is a relatively weak dispersion as it comes from dispersion of the wave envelop $\mathbb{R}_{\theta_{t} g_{t}} \star \psi_{\theta_{t}, B}$ rather than dispersive relations of plane waves. It produces effects for times of order one, in contrast with dispersion in e.g. the semiclassical Schrödinger equation which arises at time $\varepsilon$.
We detail these three effects in $\S 1.3$. Theorem 6.2 will extend the result of Theorem 1.1 to cover varying magnetic fields, general domain walls and longer times of validity. The corresponding wavepackets will more generally have a variable speed, given by the ODE (1.3); a phase with properties identical to (ii) above; and a more complicated rate of dispersion.
1.3. Effects of the magnetic field. We comment here on the structure of the wavepacket (1.7), when $B$ is constant and $\kappa$ satisfies (1.5); and detail how things change when these conditions are relaxed (see Theorem 6.2).

Turning on a magnetic field systematically slows down the propagation. In the general setup of Theorem 6.2, the wavepackets move at speed $\left(1+B_{t}^{2}\right)^{-1 / 2}$, which is smaller than 1 whenever the magnetic field does not vanish.

The wavepacket is semiclassically localized at $\left(y_{t}, A_{t}\right)$. This point lies in the crossing set of the semiclassical symbol

$$
\not D(x, \xi)=\left(\xi_{1}-A_{1}(x)\right) \sigma_{1}+\left(\xi_{2}-A_{2}(x)\right) \sigma_{2}+\kappa(x) \sigma_{3}
$$

that is, the eigenvalues of $\not D\left(y_{t}, A_{t}\right)$ are repeated. Hence, $\left(y_{t}, A_{t}\right)$ is an exotic semiclassical trajectory, in the sense that it is not among those predicted by standard propagation of singularity, such as [DH72].

The semiclassical action $\dot{y_{t}} \cdot A_{t}$ generates a large phase-shift $e^{\frac{i}{\varepsilon} \int_{0}^{t} \dot{y}_{s} \cdot A_{s} d s}$ that can be locally - but not globally - gauged away. When $\Gamma$ is a loop, after a full revolution the phase shift

relates to the magnetic flux $\Phi=\int_{\Gamma} A$ : it is $e^{\frac{i}{\varepsilon} \Phi}$, see Figure 3 for the case of the circle. This is the Aharonov-Bohm effect.

The envelop of the wavepacket typically disperses along $\Gamma$. Under the geometric condition (1.5), the rate of change of dispersion is $\left|\theta_{t}-\theta_{0}\right|^{-1 / 2}$. Indeed, writing $\psi$ in terms of $g_{t}$ and $\psi_{0, B}$, and using the formula (1.8), we have for $\left|\theta_{t}-\theta_{0}\right| \geq 1$ :

\begin{align*}
\sup _{z \in \mathbb{R}^{2}}|\psi(t, z)|=\sup _{z \in \mathbb{R}^{2}}\left|g_{t} * \psi_{0, B}(z)\right| & \leq \frac{1}{\sqrt{2 \pi \gamma\left|\theta_{t}-\theta_{0}\right|}} \sup _{z_{2} \in \mathbb{R}} \int_{\mathbb{R}}\left|\psi\left(y_{1}, z_{2}\right)\right| d y_{1} \\
& \leq \frac{C}{\sqrt{\gamma\left|\theta_{t}-\theta_{0}\right|}}=\frac{C^{\prime}}{\sqrt{\gamma\left|\theta_{t}-\theta_{0}\right|}} \sup _{z \in \mathbb{R}^{2}}|\psi(0, z)| \tag{1.11}
\end{align*}
$$

This yields (1.10). While the rate of change of dispersion $\left|\theta_{t}-\theta_{0}\right|^{-1 / 2}$ is bounded above if $\Gamma$ is asymptotically flat, it can be as small as $t^{-1 / 2}$ when $\Gamma$ is a loop or a spiral. In these cases, the wavepacket loses coherence over long times as displayed in Figure 4; it should be noted however that larger magnetic fields do not necessarily give rise to larger dispersion. In the general setup of Theorem 6.2, the rate of dispersion $\nu_{t}$ takes a more complicated form: see Lemma 5.3, (5.3) and (3.21). We comment that dispersion can have long-time effects. When the dispersion is strongest, $\nu_{t} \sim t$ and our construction holds up to times $\mathrm{T} \ll \varepsilon^{-1 / 8}$; when it is weakest, $\nu_{t}=O(1)$ and we recover the time of validity $\mathrm{T} \ll \varepsilon^{-1 / 2}$ of $\left[\mathrm{BBD}^{+} 21\right]$.

When $B$ or $|\nabla \kappa|$ vary along $\Gamma$ (that is, outside the setup of Theorem 1.1), an additional effect emerges: time-dependent anisotropic compression/stretching in the normal and tangent directions of $\Gamma$. We refer the reader to the formula (5.6) and Theorem 6.2. The compression factors, $\sqrt{\rho_{t}}$ (in the normal direction) and $c_{0}^{2} / c_{t}^{2}$ (in the tangent direction), remain bounded above and below in the limit $t \rightarrow \infty$. This contrasts with the parameter $\nu_{t}$ that controls the dispersion, which can grow like $t$.
1.4. Strategy of proof. Conceptually speaking, our approach consists in constructing successive transformations of $\not D$ that bring us closer to the flat Dirac operator $D_{0, B}$ of (1.6). The main steps are as follows:

1. In $\S 2$, we conjugate $\not D$ by a gauge transform $e^{i \chi(t, x) / \varepsilon}$, cooked up so that the resulting magnetic potential $A-\nabla \chi$ vanishes along $\Gamma$ and is tangent to the level sets of $\kappa$. These are shared features with the flat Dirac operator $D_{0, B}$. The expansion of the gauge term $e^{i \chi(t, x) / \varepsilon}$ near $y_{t}$ produces the large oscillatory phase of (1.9).
2. In $\S 3.1$ we look for solutions to the gauge-modified Dirac equation $\left(\varepsilon D_{t}+\tilde{D}\right) \tilde{\Psi}=0$ as semiclassical wavepackets localized at $\left(y_{t}, 0\right)$. A formal Taylor expansion produces a hierarchy of equations for the envelops.
3. In $\S 3.2$, we perform a series of spatial and spinorial rotations on the leading equation. The first two rotations (which already appear in $\left[\mathrm{BBD}^{+} 21\right]$ ) flatten the interface; the last is magnetically induced and is among the new ingredients. The result is the leading equation that one would get starting from $D_{0, B}$.
4. Up to a partial shifted Fourier transform, the leading operator takes the same form as in the absence of magnetic fields $\left[\mathrm{BBD}^{+} 21\right]$. In $\S 4$, we compute explicitly its kernel and prove stability estimates - later needed for the subleading transport equation.
5. In $\S 5$ we explicitly integrate the transport equation. In Fourier variables, the solutions have a quadratic phase with Hessian $\theta_{t}-\theta_{0}$ (in the setup of $\S 1.2$ ). In physical space, this transfers to dispersion at rate $\left|\theta_{t}-\theta_{0}\right|^{-1 / 2}$.
6. Higher-order approximations are constructed iteratively in $\S 6$. Combining them with the unitarity of $e^{-i t \not D}$ and a Duhamel argument, we obtain our main result, Theorem 6.2. It gives an approximate solution to $\left(\varepsilon D_{t}+\not D\right) \Psi=0$ that propagates along $\Gamma$, slowed down by the magnetic field, and explicitly expressed through the above transformations.

We then illustrate our findings with a series of numerical simulations in $\S 7$.
1.5. Related literature. For systems of semiclassical PDEs, the symbols that govern the macroscopic transport are the eigenvalues of the (matrix-valued) symbol. A symbolic diagonalization argument shows that their Hamiltonian flow governs the leading-order dynamics. When the eigenvalues of the symbol are degenerate, the classical equations of motion break down. The situation studied here is among the simplest such cases. Our analysis show that the phase-space crossing set $\{(x, A(x)), x \in \Gamma\}$ support wavepackets with the dynamics (1.3). As mentioned above, (1.3) is an exotic semiclassical trajectory not predicted by the standard results on propagation of singularities [DH72]. In other setups, wavepackets may e.g. start away from the crossing set, reach it, and undergo a Landau-Zener transition; see e.g. [Hag94, HJ98, FKG03, CdV04].

From a physical point of a view, our motivation stems from the ubiquity of $\not D$ in the field of topological phases of matter [Wit16, MM21], and in particular one-particle models of topological insulators and topological superconductors [Vol89, Ber13, PSB16, Bal19a, Bal19b], which generically come with conical points [Dro21b]. The domain wall $\kappa(x)$ models the interface between two topologically distinct insulating phases [FLTW16, Dro19b, DW20]. This in turn generates an asymmetric transport along the interface $\Gamma$ by a principle called the bulk-interface correspondence; see e.g. [EG02, GP13, PSB16, Dro19a, Bal20, Bal21, Dro21a, BM22]. The wavepackets analyzed here encode this asymmetry; see $\left[\mathrm{BBD}^{+} 21, \S 1.4\right]$ for a discussion when $A=0$. The operator $\not D$ also emerges in the effective analysis of graphene and its pseudomagnetic (strained) analogues, see for instance [GRW21].

Note that the magnetic field is essential in the integer quantum Hall effect [TKNdN82, ASS94, BvESB94], which was the first observed example of topologically non-trivial state of matter. There, the insulating gaps are obtained from the degenerate Landau levels associated to a constant magnetic field. This contrasts with the situation considered here: the nontrivial topology imposed by the domain wall is stable against magnetic contributions; see [Bal21]. This means that the magnetic field does not influence the existence of edge states. It however affect their quantitative features, see §1.3.

Our results in Theorems 1.1 and 6.2 concern weakly dispersive wavepackets with a macroscopic center $y_{t}$ propagating along $\Gamma=\kappa^{-1}(0)$. Changing the metric (i.e. replacing $D$ by $\left.\left(D_{j}+\Gamma_{j}(x)\right) g^{j k}(x)\right) \sigma_{k}$ ) would likely preserve this structure. However, adding an electric potential $V(x)$ to $\not D$ modifies the energy landscape, hence the interface $\Gamma=\kappa^{-1}(0)$ between the two topological media cannot properly support wavepackets. These are likely to propagate instead within a thicker strip close to $\Gamma$, with splitting according to Landau-Zener transition rules.

## 2. GAUGE TRANSFORMATION

This section constructs a gauge function that reduces $I D$ to an operator with magnetic properties closer to those of the model operator (1.6).
2.1. Equivalent tangent magnetic potential. We construct first a magnetic potential $\tilde{A}$ on $\mathbb{R}^{2}$ such that $\nabla \times \tilde{A}=B$ near $\Gamma$, and $\tilde{A}$ vanishes along $\Gamma=\kappa^{-1}(0)$ and is carried by the vector field $\tau$. In particular, the operator

$$
\begin{equation*}
\tilde{D}=\left(\varepsilon D_{1}-\tilde{A}_{1}(x)\right) \sigma_{1}+\left(\varepsilon D_{2}-\tilde{A}_{2}(x)\right) \sigma_{2}+\kappa(x) \sigma_{3} \tag{2.1}
\end{equation*}
$$

will share many of the characteristics of the model (1.6): the magnetic potential is tangent to $\Gamma$ and vanishes along $\Gamma$. Moreover, from magnetic equivalence between $A$ and $\tilde{A}, \not D$ and $\tilde{D}$ are locally conjugated. We use below the notation (with Euclidean distance $d$ )

$$
U_{\eta}=\left\{x \in \mathbb{R}^{2}: d(x, \Gamma)<\eta\right\} .
$$

Lemma 2.1. There exist $\eta>0$ and a function $\beta \in C^{\infty}\left(\mathbb{R}^{2}, \mathbb{R}\right)$ vanishing on $\mathbb{R}^{2} \backslash U_{2 \eta}$ such that, defining $\tilde{A}:=\beta \kappa \tau$, we have

$$
\begin{equation*}
\nabla \times(A-\tilde{A})=\nabla \times(A-\beta \kappa \tau)=0 \quad \text { on } U_{\eta} ; \quad \beta=\frac{B}{|\nabla \kappa|} \quad \text { on } \Gamma . \tag{2.2}
\end{equation*}
$$

Proof. We first note that it suffices to construct $\beta$ on $U_{\eta}$ and extend it to $\mathbb{R}^{2}$ as a smooth function with support in $U_{2 \eta}$. For $f$ a smooth function, we observe that

$$
\begin{equation*}
\nabla \times(f \tau)=\nabla f \times \tau+f \nabla \times \tau=\partial_{n} f+f \nabla \times \tau \tag{2.3}
\end{equation*}
$$

where we used $\nabla f \times \tau=\partial_{1} f \tau_{2}-\partial_{2} f \tau_{1}=\partial_{n} f$. Let $B=\nabla \times A$. To find $\beta$ such that $B=\nabla \times(\beta \kappa \tau)$, we first solve

$$
\begin{equation*}
\partial_{n} f+f \nabla \times \tau=B,\left.\quad f\right|_{\Gamma}=0 \tag{2.4}
\end{equation*}
$$

We note that the coefficients of $\partial_{n}$ are in $C_{b}^{\infty}$. In particular, the flow $e^{s \partial_{n}}(x)$ is defined for all times. We now define the map $\Phi: \Gamma \times \mathbb{R} \rightarrow \mathbb{R}^{2}$ by

$$
\Phi(x, s)=e^{s \partial_{n}}(x)
$$

If $f$ solves (2.4), then $\tilde{f}=f \circ \Phi$ solves

$$
\partial_{s} \tilde{f}+\tilde{f} \cdot(\nabla \times \tau) \circ \Phi=B \circ \Phi,\left.\quad \tilde{f}\right|_{\Gamma}=0
$$

This equation clearly admits a solution $\tilde{f} \in C^{\infty}(\Gamma \times \mathbb{R}, \mathbb{R})$. Moreover, note that $\partial_{n}$ is transverse to $\Gamma$; that $|\nabla \kappa|$ is uniformly bounded above and below; and that $\kappa \in C_{b}^{\infty}$, $\Phi$ is a diffeomorphism from $\Gamma \times(-\delta, \delta)$ to its range, which contains a neighborhood of the form $U_{\eta}$. Therefore, $\tilde{f}$ induces the solution $f=\tilde{f} \circ \Phi^{-1} \in C^{\infty}\left(U_{\eta}, \mathbb{R}\right)$ of (2.4).

Because $f$ vanishes on $\Gamma$ and $\kappa$ vanishes transversely on $\Gamma$ (with $|\nabla \kappa|$ bounded below), after potentially reducing $\eta$ we can write $f=\beta \kappa$ for some smooth function $\beta$ on $U_{\eta}$. From the equation (2.4) and the identity (2.3), we conclude that

$$
\nabla \times A=B=\partial_{n} f+f \nabla \times \tau=\nabla \times(f \tau)=\nabla \times(\beta \kappa \tau)
$$

Moreover, using that $f$ and $\kappa$ vanish on $\Gamma$, we have along $\Gamma$ :

$$
B=\partial_{n} f=\partial_{n}(\beta \kappa)=\beta \partial_{n} \kappa=\beta|\nabla \kappa| .
$$

This completes the proof.
Thanks to (2.2), $A$ and $\tilde{A}$ give rise to the same magnetic field on $U_{\eta}$, hence the difference $A-\tilde{A}$ is locally a gradient field:

Lemma 2.2. Let $\eta>0$ given by Lemma 2.1 and $U \subset U_{\eta}$ be a simply connected set. For any $\left(y_{0}, \eta_{0}\right) \in U \times \mathbb{R}$, there exists a unique $\chi_{0} \in C^{\infty}(U, \mathbb{R})$ such that

$$
\tilde{A}=A-\nabla \chi_{0} \quad \text { in } U ; \quad \text { and } \quad \chi_{0}\left(y_{0}\right)=\eta_{0}
$$

Proof of Lemma 2.2. Thanks to (2.2), we have $\nabla \times(A-\beta \kappa \tau)=0$ on $U_{\eta}$, hence on $U$. Since $U$ is simply connected, by Poincaré's lemma there exists a unique $\chi_{0} \in C^{\infty}(U, \mathbb{R})$ such that $\nabla \chi_{0}=A-\beta \kappa \tau$ and $\chi\left(y_{0}\right)=\eta_{0}$.

It follows from Lemma 2.2 that the operators $\not D$ and $\tilde{D}$ defined in (2.1) are locally conjugate: on open sets $U$ produced by Lemma 2.2, we have

$$
\begin{equation*}
e^{-i \chi_{0} / \varepsilon} \not D e^{i \chi_{0} / \varepsilon}=\tilde{D} \tag{2.5}
\end{equation*}
$$

2.2. Global gauge. When $\Gamma$ is simply connected, we can pick $U=U_{\eta}$ in Lemma 2.2, and the conjugation relation (2.5) holds on a full neighborhood of $\Gamma$. This however fails when $\Gamma$ is a loop: $\chi_{0}$ is only defined on part of $\Gamma$. We circumvent this obstacle by using instead a time-dependent gauge that follows the center of mass $y_{t}$ of our wavepacket, i.e. defined on a set of the form

$$
\Omega_{\delta}=\left\{(t, x), t \in \mathbb{R},\left|x-y_{t}\right|<\delta\right\} .
$$

Proposition 2.3. Let $\tilde{A}$ be as defined in Lemma 2.1. There exist $\delta>0$ and $\chi \in C^{\infty}(\mathbb{R} \times$ $\left.\mathbb{R}^{2}, \mathbb{R}\right)$ with support in $\Omega_{2 \delta}$ with $\chi\left(0, y_{0}\right)=0$ and such that for $(t, x) \in \Omega_{\delta}$ :

$$
\begin{equation*}
\tilde{A}(x)=A(x)-\nabla \chi(t, x), \quad \partial_{t} \chi(t, x)=0 \tag{2.6}
\end{equation*}
$$

Proof. As in the proof of Lemma 2.1, it suffices to construct $\chi$ on $\Omega_{\delta}$ and to extend it to $\mathbb{R}^{2}$ as a smooth function with support in $\Omega_{2 \delta}$. Without loss of generality, we can assume that $\Gamma$ is connected. If $\Gamma$ is also simply connected, then we simply take $\delta=\eta$ and $\chi(t, x)=\chi_{0}(x)$. If $\Gamma$ is not simply connected, then it is a loop; in particular it is compact.

Fix $t \in \mathbb{R}$. According to Lemma 2.2, there exists $\delta_{t}>0$ and a smooth function $\chi(t, \cdot)$ defined on the ball $B\left(y_{t}, \delta_{t}\right)$ such that

$$
\begin{equation*}
\tilde{A}(x)=A(x)-\nabla \chi(t, x), \quad x \in B\left(y_{t}, \delta_{t}\right) ; \quad \chi\left(t, y_{t}\right)=\int_{0}^{t} \dot{y}_{s} \cdot A\left(y_{s}\right) d s \tag{2.7}
\end{equation*}
$$

Since $\Gamma$ is compact, we can pick $\delta_{t}$ independent of $t$; we write below $\delta=\delta_{t}$. Varying $t$, we obtain a uniquely defined function $\chi$ on $\Omega_{\delta}$. We take time-derivative of both identities in (2.7). The first one yields $\nabla \partial_{t} \chi(t, x)=0$ for $x \in B\left(y_{t}, \delta\right)$. The second one gives

$$
\partial_{t} \chi\left(t, y_{t}\right)=\partial_{t}\left(\chi\left(t, y_{t}\right)\right)-\dot{y_{t}} \cdot \nabla \chi\left(t, y_{t}\right)=\dot{y_{t}} \cdot A\left(y_{t}\right)-\dot{y_{t}} \cdot A\left(y_{t}\right)=0
$$

where we used $\nabla \chi=\beta \kappa \tau-A$ hence $\nabla \chi\left(t, y_{t}\right)=A\left(y_{t}\right)$. From these identities, we deduce that $\partial_{t} \chi(t, x)=0$ for $x \in B\left(y_{t}, \delta\right)$; in particular $\partial_{t} \chi$ is smooth. Moreover, $\nabla \chi=A-\tilde{A}$ is also smooth. This implies that $\chi$ is smooth, which completes the proof.

Thanks to (2.6), we have the relation

$$
\begin{gather*}
e^{-i \chi / \varepsilon}\left(\varepsilon D_{t}+\not D\right) e^{i \chi / \varepsilon}=\varepsilon D_{t}+\tilde{D D}+R, \quad \text { where: }  \tag{2.8}\\
R=\partial_{t} \chi+\left(\partial_{1} \chi-A_{1}+\tilde{A}_{1}\right) \sigma_{1}+\left(\partial_{2} \chi-A_{2}+\tilde{A}_{2}\right) \sigma_{2} \tag{2.9}
\end{gather*}
$$

It follows from (2.8) that $\Psi$ solves (1.1) if and only if $\tilde{\Psi}=e^{-i \chi / \varepsilon} \Psi$ solves

$$
\begin{equation*}
\left(\varepsilon D_{t}+\tilde{D}+R\right) \tilde{\Psi}=0 \tag{2.10}
\end{equation*}
$$

While $R$ looks like a leading-order term, it will effectively be of order $\varepsilon^{\infty}$ because it vanishes on $\Omega_{\delta}$ - a domain where our wavepacket is concentrated. We will eventually treat it as a small source term in $\S 6$.
2.3. Gauge expansion. We conclude this section with an expansion of $\chi$ near $\left(t, y_{t}\right)$, which will serve to prove Theorem 1.1.

Lemma 2.4. We have:

$$
\begin{equation*}
\chi\left(t, y_{t}\right)=\int_{0}^{t} \dot{y_{s}} \cdot A_{s} d s ; \quad \nabla \chi\left(t, y_{t}\right)=A_{t} ; \quad \nabla^{2} \chi\left(t, y_{t}\right)=\nabla A^{\top}\left(y_{t}\right)-B_{t} n_{t} \tau_{t}^{\top} \tag{2.11}
\end{equation*}
$$

Proof. The first formula of (2.11) comes from the equation (2.7) defining $\chi$. The second one follows from

$$
\nabla \chi\left(t, y_{t}\right)=A\left(y_{t}\right)-\beta\left(y_{t}\right) \kappa\left(y_{t}\right) \tau\left(y_{t}\right)=A_{t}
$$

In order to see the last one, we notice that

$$
\begin{aligned}
\nabla^{2} \chi\left(t, y_{t}\right) & =\nabla \cdot\left(\nabla^{\top} \chi\right)\left(y_{t}\right)=\nabla\left(A^{\top}-\beta \kappa \tau^{\top}\right)\left(y_{t}\right) \\
& =\nabla A^{\top}\left(y_{t}\right)-\beta\left(y_{t}\right) \nabla \kappa\left(y_{t}\right) \tau^{\top}\left(y_{t}\right)=\nabla A^{\top}\left(y_{t}\right)-B_{t} n_{t} \tau_{t}^{\top}
\end{aligned}
$$

where we used $\beta_{t}=B_{t} / r_{t}$ on $\Gamma$, see (2.2). This completes the proof.

## 3. LOCAL NORMAL FORM

We now start our construction of approximate solutions to $\left(\varepsilon D_{t}+\tilde{D}\right) \tilde{\Psi}=0$. This section describes a series of transformations that allows us to explicitly invert an operator that governs the leading dynamics: a rescaling of $\tilde{\Psi}$ in natural coordinates, spatial and spinorial rotations, and finally a shifted partial Fourier transform.
3.1. Spatial rescaling. We first write the wavepacket in natural coordinates:

$$
\psi(t, z)=\varepsilon^{\frac{1}{2}} S \tilde{\Psi}(t, z)
$$

with the scaling transformation defined as

$$
\begin{equation*}
S f(z)=f\left(y_{t}+\sqrt{\varepsilon} z\right), \quad S^{-1} f(x)=f\left(\frac{x-y_{t}}{\sqrt{\varepsilon}}\right) \tag{3.1}
\end{equation*}
$$

We observe that $\varepsilon^{\frac{1}{2}} S$ is an isometry on $L^{2}\left(\mathbb{R}^{2}\right)$, while formally,

$$
\begin{equation*}
S f(z)=\sum_{\alpha} \frac{\varepsilon^{\frac{|\alpha|}{2}} z^{\alpha}}{\alpha!} \partial^{\alpha} f\left(y_{t}\right)=\sum_{j \geq 0} \varepsilon^{\frac{j}{2}} S_{j} f(z), \quad S_{j} f(z):=\sum_{|\alpha|=j} \frac{z^{\alpha}}{\alpha!} \partial^{\alpha} f\left(y_{t}\right) \tag{3.2}
\end{equation*}
$$

This scaling emerges from the following consideration. For $\kappa(x)=x_{2}$, the wavepacket is confined by a harmonic-like oscillator $\varepsilon D_{2} \sigma_{2}+x_{2} \sigma_{3}$ and hence comes with a natural
scale $\sqrt{\varepsilon} x_{2}$. This scale is then imposed to all directions when $\kappa$ admits more sophisticated variations, i.e. when $\Gamma$ is curved.

We then verify that $\psi(t, z)$ solves

$$
\begin{equation*}
L \psi=0 ; \quad L=\varepsilon^{-\frac{1}{2}} S\left(\varepsilon D_{t}+\tilde{D}\right) S^{-1}=\varepsilon^{\frac{1}{2}} D_{t}-\dot{y}_{t} \cdot D+\left(D+\varepsilon^{-\frac{1}{2}} S h(z)\right) \cdot \sigma \tag{3.3}
\end{equation*}
$$

with $D=\left(D_{1}, D_{2}, 0\right)^{t}$, $\sigma=\left(\sigma_{1}, \sigma_{2}, \sigma_{3}\right)^{t}$, and $h=\left(-\tilde{A}_{1},-\tilde{A}_{2}, \kappa\right)^{t}=(-\beta \kappa \tau, \kappa)^{t}$. We still use $\dot{y}_{t}$ for $\left(\dot{y}_{t}, 0\right)^{t} \in \mathbb{R}^{3}$. Using (3.2), we find formally $L=\sum_{j \geq 0} \varepsilon^{\frac{3}{2}} L_{j}$, where we observe that $L_{-1}=0$ since $\tilde{A}$ and hence $h$ vanish on $\Gamma=\kappa^{-1}(0)$, and

$$
\begin{align*}
L_{0} & =-\dot{y}_{t} \cdot D+D \cdot \sigma+S_{1} h \cdot \sigma  \tag{3.4}\\
L_{1} & =D_{t}+S_{2} h \cdot \sigma  \tag{3.5}\\
L_{j} & =S_{j+1} h \cdot \sigma=\sum_{|\alpha|=j+1} \frac{1}{\alpha!} z^{\alpha} \partial^{\alpha} h\left(y_{t}\right) \cdot \sigma, \quad j \geq 2 \tag{3.6}
\end{align*}
$$

Our next objective is to transform $L_{0}$ in an appropriate basis so that its infinite dimensional kernel and its inverse on the orthogonal complement may be written explicitly.
3.2. Rotations. We now introduce spatial and spinorial rotations already mentioned in the introduction. We define, for $1 \leq j \leq 3$ and $\theta \in \mathbb{R}$, the spinor rotation acting on $\mathbb{C}^{2}$ :

$$
U_{j, \theta}=e^{-i \frac{\theta}{2} \sigma_{j}}=\cos \left(\frac{\theta}{2}\right)-i \sin \left(\frac{\theta}{2}\right) \sigma_{j} .
$$

Associated to it is a standard three-dimensional rotation acting on $\mathbb{R}^{3}$ of angle $\theta$ about the $j$-axis (with usual orientation) $\tilde{R}_{j, \theta}$ such that for $c \in \mathbb{R}^{3}$ :

$$
\tilde{R}_{j, \theta} c \cdot \sigma=c \cdot U_{j, \theta}^{*} \sigma U_{j, \theta}, \quad U_{j, \theta}^{*} \sigma U_{j, \theta}=: \tilde{R}_{j, \theta}^{*} \sigma
$$

Note that

$$
U_{k, \theta}^{*} \sigma_{j} U_{k, \theta}=\delta_{j \neq k} \cos \theta \sigma_{j}+\epsilon_{j k l} \sin \theta \sigma_{l}+\delta_{j k} \sigma_{j} .
$$

From this, we deduce two formulas that we will use later:

$$
\tilde{R}_{2, \varphi_{t}}=\left[\begin{array}{ccc}
\cos \varphi_{t} & 0 & -\sin \varphi_{t}  \tag{3.7}\\
0 & 1 & 0 \\
\sin \varphi_{t} & 0 & \cos \varphi_{t}
\end{array}\right]=\left[\begin{array}{ccc}
c_{t} & 0 & -s_{t} \\
0 & 1 & 0 \\
s_{t} & 0 & c_{t}
\end{array}\right], \quad \tilde{R}_{3, \theta_{t}}=\left[\begin{array}{cc}
R_{\theta_{t}} & 0 \\
0 & 1
\end{array}\right]
$$

where $R_{\theta_{t}}$ is the spatial rotation defined in (1.4). We finally define the $L^{2}$-unitary transform related to the spatial rotations

$$
\mathcal{R}_{\theta_{t}} f=f \circ R_{\theta_{t}}
$$

and the operator

$$
\begin{equation*}
\mathrm{U}_{t}=U_{2, \varphi_{t}} U_{3, \theta_{t}} \mathcal{R}_{\theta_{t}} \tag{3.8}
\end{equation*}
$$

When $\varphi_{t} \equiv 0$ (i.e., when $B=0$ ), this transformation already appears in $\left[\mathrm{BBD}^{+} 21\right]$. We now compute the operators $\mathrm{U}_{t}^{*} L_{j} \mathrm{U}_{t}$. We start with preliminary relations:

Lemma 3.1. We find:

$$
\begin{gather*}
\mathrm{U}_{t}^{*}\left(-\dot{y}_{t} \cdot D\right) \mathrm{U}_{t}=c_{t} D_{1}, \quad \mathrm{U}_{t}^{*} D \cdot \sigma \mathrm{U}_{t}=\left(c_{t} \sigma_{1}+s_{t} \sigma_{3}\right) D_{1}+\sigma_{2} D_{2}  \tag{3.9}\\
\mathrm{U}_{t}^{*} D_{t} \mathrm{U}_{t}=D_{t}-\frac{\dot{\varphi}_{t}}{2} \sigma_{2}-\frac{\dot{\theta}_{t}}{2}\left(-s_{t} \sigma_{1}+c_{t} \sigma_{3}\right)-\dot{\theta}_{t}\left(z_{1} D_{2}-z_{2} D_{1}\right) \tag{3.10}
\end{gather*}
$$

Moreover $\mathrm{U}_{t}^{*} S_{j} h \cdot \sigma \mathrm{U}_{t}$ is a multiplication operator by a time-dependent homogeneous polynomial of degree $j$ in $z$; and for $j=1,2$ :

$$
\begin{equation*}
\mathrm{U}_{t}^{*} S_{1} h \cdot \sigma \mathrm{U}_{t}=\rho_{t} z_{2} \sigma_{3}, \quad \mathrm{U}_{t}^{*} S_{2} h \cdot \sigma \mathrm{U}_{t}=-r_{t} c_{t} z_{2}\left\langle z, \nabla \beta\left(y_{t}\right)\right\rangle+q_{t}(z) \cdot \sigma \tag{3.11}
\end{equation*}
$$

where $q_{t} \cdot \sigma$ is a matrix-valued quadratic form in $z$ carried by $\sigma_{2}, \sigma_{3}$.
Proof. 1. Space differentiation. We first observe that

$$
\begin{equation*}
\mathcal{R}_{\theta_{t}}^{*} D \mathcal{R}_{\theta_{t}}=\tilde{R}_{3, \theta_{t}}^{*} D, \quad \mathcal{R}_{\theta_{t}}^{*} D \cdot v \mathcal{R}_{\theta_{t}}=D \cdot \tilde{R}_{3, \theta_{t}} v . \tag{3.12}
\end{equation*}
$$

Applied to $v=-\dot{y}_{t}$ with $R_{\theta_{t}} \dot{y}_{t}=-c_{t} e_{1}$ by construction, we find $-\tilde{R}_{3, \theta_{t}} \dot{y}_{t} \cdot D=c_{t} D_{1}$. Since spinorial rotations commute with scalars, we obtain the first relation in (3.9).

We now apply (3.12) to $v=\sigma$ and find

$$
\left(\mathcal{R}_{\theta_{t}} U_{3, \theta_{t}}\right)^{*} D \cdot \sigma \mathcal{R}_{\theta_{t}} U_{3, \theta_{t}}=D \cdot \sigma .
$$

Therefore, using (3.7), we find

$$

$$

This proves the second identity in (3.9).
2. Time differentiation. We note that

& =D_{t}-\frac{\dot{\varphi}_{t}}{2} \sigma_{2}-\frac{\dot{\theta}_{t}}{2}\left(-s_{t} \sigma_{1}+c_{t} \sigma_{3}\right)-\dot{\theta}_{t}\left(z_{1} D_{2}-z_{2} D_{1}\right)
\end{aligned}
$$

This proves (3.10).
3. Multiplicative operators. We observe that $\mathcal{R}_{\theta_{t}}^{*} \operatorname{Sh} \mathcal{R}_{\theta_{t}}=h\left(y_{t}+\sqrt{\varepsilon} R_{\theta_{t}} z\right)$ as a multiplication operator so that

where we have defined the 3 -vectors $\nu_{\alpha}=\frac{1}{\alpha!} \tilde{R}_{2, \varphi_{t}} \tilde{R}_{3, \theta_{t}}\left(R_{-\theta_{t}} \nabla\right)^{\alpha} h\left(y_{t}\right)$. Indeed,

using multinomial coefficients. Therefore, $S_{j} h \cdot \sigma$ is a multiplicative operator by a homogeneous polynomial of degree $j$ depending on $t$; composing with rotations preserves this feature: $\mathrm{U}_{t}^{*} S_{j} h \cdot \sigma \mathrm{U}_{t}$ is also a homogeneous polynomial of degree $j$.

We now focus on $j=1$. Define $\tilde{h}=(-\beta \tau, 1)^{t}$ so that $h=\kappa \tilde{h}$. Since $\kappa\left(y_{t}\right)=0$, we have $S_{1} h=\tilde{h}\left(y_{t}\right) \cdot S_{1} \kappa$. Since spinorial rotations commute with the scalar $S_{1} \kappa$,

We now compute separately $\mathcal{R}_{\theta_{t}}^{*} S_{1} \kappa \mathcal{R}_{\theta_{t}}$ and $\mathrm{U}_{t}^{*} \tilde{h}\left(y_{t}\right) \cdot \sigma \mathrm{U}_{t}$ (note that $\mathcal{R}_{\theta_{t}}$ does not technically affect that last term since $\tilde{h}\left(y_{t}\right)$ does not depend on $\left.z\right)$. We have:

Moreover, since $B_{t}=\beta_{t} r_{t}$, we have $\tilde{h}\left(y_{t}\right)=\left(-r_{t}^{-1} B_{t} \tau_{t}, 1\right)^{t}$ hence $R_{3, \theta_{t}} \tilde{h}=\left(r_{t}^{-1} B_{t}, 0,1\right)$. We deduce

Using that $S_{2} \kappa$ is a scalar and $\tilde{h} \cdot \sigma$ does not depend on $z$ we have

where we used (3.15) in the last equality. This term is carried by $\sigma_{3}$.
We now focus on $\mathrm{U}_{t}^{*}\left(S_{1} \kappa\right)\left(S_{1} \tilde{h}\left(y_{t}\right) \cdot \sigma\right) \mathrm{U}_{t}$. Using (3.14) and that spinorial rotations commute with scalars, we obtain:

It remains to compute $\mathrm{U}_{t}\left(S_{1} \tilde{h}\right) \cdot \sigma \mathrm{U}_{t}$. We recall that $\tilde{h}=(-\beta \tau, 1)^{t}$. Moreover, $\tau$ has unit norm: $\langle\tau, \tau\rangle=1$. Taking derivatives of this expression shows that $\partial_{j} \tau$ is normal to $\tau$; we write $\partial_{j} \tau=\alpha_{j} n$ below. We deduce that

\end{aligned}

We observe that:

U_{3, \theta_{t}}^{*} n \cdot \sigma U_{3, \theta_{t}}=R_{3, \theta_{t}} n \cdot \sigma=\sigma_{2}, \quad U_{2, \varphi_{t}}^{*} \sigma_{2} U_{2, \varphi_{t}}=\sigma_{2} .
\end{aligned}

Therefore, the following equality is valid modulo terms carried by $\sigma_{2}, \sigma_{3}$ :

\end{align*}
$$

where $E_{1}$ is a multiplication operator by a polynomial of degree two and carried by $\sigma_{2}$ and $\sigma_{3}$ (we will see later that it does not contribute to leading order). The coefficients $j_{t}$ and $k_{t}$ are explicitly given in terms of $\beta$ :

Above, $\xi$ is the one-dimensional dual Fourier variable to $z_{1}$ while the one-dimensional variable $\zeta$ is a shift of $z_{2}$ given by $\zeta=z_{2}+\gamma_{t} \xi$. This shifted partial Fourier transform, which reduces to a partial Fourier transform in the first variable $z_{1} \rightarrow \xi$ when $B=0$ and introduces an additional shift $\gamma_{t} \xi$ to $z_{2}$ otherwise is reminiscent of the parametrization of Landau level eigenfunctions in a Landau gauge when $B \neq 0$. The construction of our wavepackets involves many functions of the form $a(t, \xi, \zeta)=f(t, \xi) \phi(\zeta)$, with $f$ describing the wavepacket profile along $\Gamma$ while $\phi$ describes the wavepacket profile across $\Gamma$.

The global transformation we need to consider is the composition of $\mathrm{U}_{t}$ introduced in the preceding section and $\mathcal{V}_{t}$ given above. We thus set $\mathfrak{U}_{t}=\mathrm{U}_{t} \mathcal{V}_{t}$. The operator in this new set of variables is $T:=\mathfrak{U}_{t}^{*} L \mathfrak{U}_{t}$ with $L$ defined in (3.3). We similarly define $T_{j}=\mathfrak{U}_{t}^{*} L_{j} \mathfrak{U}_{t}$ for $j \geq 0$. We will also be using $D_{\xi}=-i \partial_{\xi}$ and $D_{\zeta}=-i \partial_{\zeta}$.

In $T_{1}$, it will turn out that the terms carried by $\sigma_{2}$ or $\sigma_{3}$ and the terms that are odd in $\left(D_{\zeta}, \zeta\right)$ do not appear to leading order in our expansion. Therefore, we use the notation

if $P_{1}-P_{2}$ is a differential operator made of odd terms in $\left(\zeta, D_{\zeta}\right)$ and terms carried by $\sigma_{2}, \sigma_{3}$.

Moreover $T_{j}$ is a linear combination of differential operators of the form $\xi^{k} \zeta^{\ell} D_{\xi}^{m} D_{\zeta}^{j+1-k-\ell-m}$, with $k, l \geq 0$ and coefficients bounded with respect to $t$.

\mathcal{V}_{t}^{*}\left(z_{1} D_{2}-z_{2} D_{1}\right) \mathcal{V}_{t} & =-\left(D_{\xi}+\gamma_{t} D_{\zeta}\right) D_{\zeta}-\left(\zeta-\gamma_{t} \xi\right) \xi \equiv-\gamma_{t}\left(D_{\zeta}^{2}-\xi^{2}\right)
\end{aligned}

Moreover, we observe that

We deduce from (3.20) the expression for $T_{1}$ :

T_{1} \equiv D_{t}+\dot{\theta}_{t} \gamma_{t}\left(D_{\zeta}^{2}-\xi^{2}\right)+\left(\frac{\dot{\theta}_{t} s_{t}}{2}+j_{t} \gamma_{t}\left(D_{\xi} \xi-D_{\zeta} \zeta\right)+k_{t}\left(\zeta^{2}+\gamma_{t}^{2} \xi^{2}\right)\right) \sigma_{1}
$$

Finally, since $L_{j}$ is multiplication operator by a homogeneous polynomial of degree $j+1$, $T_{j}$ is a linear combination of differential operators of the form $\xi^{k} \zeta^{\ell} D_{\xi}^{m} D_{\zeta}^{j+1-k-\ell-m}$, with coefficients bounded with respect to $t$. This completes the proof.
3.4. Conjugation and asymptotic expansion. Introducing $a=\mathfrak{U}_{t}^{*} \psi$ and recalling that $T=\mathfrak{U}_{t}^{*} L \mathfrak{U}_{t}$, equation (3.3) is equivalent to $T a=0$. With $L_{j}$ given in (3.4)-(3.6) and $T_{j}=\mathfrak{U}_{t}^{*} L_{j} \mathfrak{U}_{t}$, we decompose $a$ as $a=\sum_{j \geq 0} \varepsilon^{\frac{j}{2}} a_{j}$ to reduce the equation $T a=0$ to the triangular system

$$
\begin{equation*}
T_{0} a_{0}=0, \quad T_{1} a_{0}+T_{0} a_{1}=0, \quad \sum_{k=0}^{j} T_{j-k} a_{k}=0, j \geq 2 \tag{3.29}
\end{equation*}
$$

In $\S 4$ we identify the kernel of $T_{0}$ and we produce explicit formula for its inverse on the orthogonal complement. We describe how to solve the subleading equation $T_{1} a_{0}+T_{0} a_{1}=0$ in $\S 5$. We finally present the higher-order asymptotic expansions and corresponding error estimates in $\S 6$.

## 4. Inversion of leading operator

To study the kernel of the operator

$$
T_{0}=c_{t}\left(1+\sigma_{1}\right) \xi+D_{\zeta} \sigma_{2}+\rho_{t} \zeta \sigma_{3}
$$

and invert it on the orthogonal complement, we first bring it to a normal form. Thanks to the change of variables $(\xi, \zeta) \mapsto\left(\rho_{t}^{1 / 2} c_{t}^{-1} \xi, \rho_{t}^{-1 / 2} \zeta\right)$, we can assume that $\rho_{t}=c_{t}=1$. Moreover, with $Q=Q^{*}=\frac{1}{\sqrt{2}}\left(\sigma_{1}+\sigma_{3}\right)$, we have

Q \sigma_{1} Q=\sigma_{3}, \quad Q \sigma_{2} Q=-\sigma_{2}, \quad Q \sigma_{3} Q=\sigma_{1}
$$

It suffices then to work with the model operator

$$
H=\xi\left(1+\sigma_{3}\right)+\sigma_{1} \zeta-D_{\zeta} \sigma_{2}=\left(\begin{array}{cc}
2 \xi & \mathfrak{a}_{\zeta} \\
\mathfrak{a}_{\zeta}^{*} & 0
\end{array}\right), \quad \mathfrak{a}_{\zeta}=\partial_{\zeta}+\zeta
$$

instead of $T_{0}$. Multiplication by $2 \xi$ may also be written as $\mathfrak{a}_{\xi}+\mathfrak{a}_{\xi}^{*}$ with $\mathfrak{a}_{\xi}=\partial_{\xi}+\xi$.
4.1. Functional setting. To study the operator $H$, we use the standard basis of Hermite functions on $L^{2}(\mathbb{R})$ given by

h_{0}(\zeta)=\pi^{-\frac{1}{4}} e^{-\frac{1}{2} \zeta^{2}}, \quad h_{n}(\zeta)=\frac{1}{2^{\frac{n}{2}} \sqrt{n!}}\left(\mathfrak{a}_{\zeta}^{*}\right)^{n} h_{0}(\zeta), n \geq 1
$$

They satisfy the relations

$$
\mathfrak{a}_{\zeta} h_{0}=0 ; \quad \mathfrak{a}_{\zeta} h_{n}=\sqrt{2 n} h_{n-1}, n \geq 1 ; \quad \mathfrak{a}_{\zeta}^{*} h_{n}=\sqrt{2 n+2} h_{n+1}, n \geq 0
$$

With the decomposition $L^{2}(\mathbb{R}) \ni \psi(\zeta)=\sum_{n \geq 0} \psi_{n} h_{n}(\zeta)$, we may then define

$$
\begin{array}{cl}
\mathfrak{a}_{\zeta}^{-1} \psi(\zeta)=\sum_{n \geq 1} \frac{1}{\sqrt{2 n}} \psi_{n-1} h_{n}(\zeta), & \psi \in L^{2}(\mathbb{R})  \tag{4.1}\\
\left(\mathfrak{a}_{\zeta}^{*}\right)^{-1} \psi(\zeta)=\sum_{n \geq 0} \frac{1}{\sqrt{2 n+2}} \psi_{n+1} h_{n}(\zeta), \quad \psi \in\left(\operatorname{Ker} \mathfrak{a}_{\zeta}\right)^{\perp}=\overline{\operatorname{Ran} \mathfrak{a}_{\zeta}^{*}}=\left\{\psi \in L^{2}(\mathbb{R}) ; \quad \psi_{0}=0\right\}
\end{array}
$$

A natural scale of Hilbert spaces for $p \in \mathbb{N}$ associated to this decomposition is $\mathcal{S}_{p}(\mathbb{R})=$ $\left\{\psi \in L^{2}(\mathbb{R}) ;\left(\mathfrak{a}_{\zeta}^{*}\right)^{p} \psi \in L^{2}(\mathbb{R})\right\}$ endowed with the norm

$$
\|\psi\|_{p}^{2}=\left\|\left(\mathfrak{a}_{\zeta}^{*}\right)^{p} \psi\right\|_{0}^{2} \cong\|\psi\|_{0}^{2}+\left\|D_{\zeta}^{p} \psi\right\|_{0}^{2}+\left\|\zeta^{p} \psi\right\|_{0}^{2}
$$

where $\|\cdot\|_{0}$ is the usual $L^{2}(\mathbb{R})$ - norm and where $a \cong b$ when there exists $C_{p}>0$ such that $C_{p}^{-1} a \leq b \leq C_{p} a$. That the two above expressions for the norm are equivalent may be obtained by induction from the classical result

\left\|\mathfrak{a}_{\zeta}^{*} \psi\right\|_{0}^{2}=\left\|D_{\zeta} \psi\right\|_{0}^{2}+\|\zeta \psi\|_{0}^{2}+\|\psi\|_{0}^{2}
$$

for $\psi \in \mathcal{S}_{1}(\mathbb{R})$. Note that $\mathcal{S}_{0}(\mathbb{R}) \equiv L^{2}(\mathbb{R})$.
With the decomposition $L^{2}\left(\mathbb{R}^{2}\right) \ni \psi(\xi, \zeta)=\sum_{m, n \geq 0} \psi_{m n} h_{m}(\xi) h_{n}(\zeta)$ in two-dimensional spaces, we similarly define $\mathcal{S}_{p}\left(\mathbb{R}^{2}\right)=\left\{\psi \in L^{2}\left(\mathbb{R}^{2}\right) ;\left(\mathfrak{a}_{\xi}^{\bar{*}}\right)^{p} \psi \in L^{2}\left(\mathbb{R}^{2}\right)\right.$ and $\left.\left(\mathfrak{a}_{\zeta}^{*}\right)^{p} \psi \in L^{2}\left(\mathbb{R}^{2}\right)\right\}$ endowed with the norms

$$
\|\psi\|_{p}^{2}=\sum_{j=0}^{p}\left\|\left(\mathfrak{a}_{\xi}^{*}\right)^{j}\left(\mathfrak{a}_{\zeta}^{*}\right)^{p-j} \psi\right\|_{0}^{2} \cong\left\|\left(1+|\xi|^{p}+|\zeta|^{p}\right) \psi\right\|_{0}^{2}+\left\|D_{\xi}^{p} \psi\right\|_{0}^{2}+\left\|D_{\zeta}^{p} \psi\right\|_{0}^{2}
$$

For vector-valued functions, we also define the spaces $\mathcal{S}_{p}\left(\mathbb{R}^{d}, \mathbb{C}^{q}\right)$ component-wise. Below we simply write $\mathcal{S}_{p}$ when the domain $\mathbb{R}^{d}$ and range $\mathbb{C}^{q}$ are clear and $\|\cdot\|_{p}$ the associated norm.
4.2. Inversion of model operator. As the lemma below demonstrates, the kernel $N \subset$ $L^{2}\left(\mathbb{R}^{2}, \mathbb{C}^{2}\right)$ of $H$ and its orthogonal complement are given by

N & =\left\{\psi(\xi, \zeta)=f(\xi) h_{0}(\zeta)\left[\begin{array}{l}
0 \\
1
\end{array}\right], f \in L^{2}(\mathbb{R})\right\} \\
N^{\perp} & =\left\{\psi \in L^{2}\left(\mathbb{R}^{2}, \mathbb{C}^{2}\right),\left(\psi_{2}(\xi, \cdot), h_{0}(\cdot)\right)_{2}=0, \forall \xi \in \mathbb{R}\right\}
\end{aligned}
$$

where $(\cdot, \cdot)_{2}$ is the standard $L^{2}(\mathbb{R})$-inner product in the second variable $\zeta$ and $\psi=\left(\psi_{1}, \psi_{2}\right)^{t}$.
Lemma 4.1. For $p \in \mathbb{N}$, we define the bounded linear operator $H^{-1}$ from $N^{\perp} \cap \mathcal{S}_{p+1}$ to $N^{\perp} \cap \mathcal{S}_{p}$ as

H^{-1}=\left[\begin{array}{cc}
0 & \left(\mathfrak{a}_{\zeta}^{*}\right)^{-1} \\
\mathfrak{a}_{\zeta}^{-1} & -\mathfrak{a}_{\zeta}^{-1} 2 \xi\left(\mathfrak{a}_{\zeta}^{*}\right)^{-1}
\end{array}\right] .
$$

All solutions $\psi \in \mathcal{S}_{p}$ of the equation $H \psi=g$ for $g \in N^{\perp} \cap \mathcal{S}_{p+1}$ are of the form $\psi=$ $H^{-1} g+\psi_{0}$ with $\psi_{0}$ arbitrary in $N \cap \mathcal{S}_{p}$. In particular Ker $H=N$ on $\mathcal{S}_{0}$.

Proof. The system $H \psi=g$ is equivalent to $\mathfrak{a}_{\zeta}^{*} \psi_{1}=g_{2}$ and $\mathfrak{a}_{\zeta} \psi_{2}+2 \xi \psi_{1}=g_{1}$. Using (4.1), we find for $\left(g_{2}, h_{0}(\zeta)\right)_{2}=0$, i.e., $g \in N^{\perp}$, that $\psi_{1}=\left(\mathfrak{a}_{\zeta}^{*}\right)^{-1} g_{2}$ and then $\psi_{2}=\mathfrak{a}_{\zeta}^{-1}\left(g_{1}-2 \xi \psi_{1}\right)$ and hence the above result. We then note that $\mathfrak{a}_{\zeta}^{-1}$ has range in $N^{\perp}$.

That $\psi \in \mathcal{S}_{p}$ when $g \in \mathcal{S}_{p+1}$ follows directly from the fact that the following operators are bounded: $\mathfrak{a}_{\zeta}^{-1}: \mathcal{S}_{p+1} \rightarrow \mathcal{S}_{p+1} \cap N^{\perp}$, $\left(\mathfrak{a}_{\zeta}^{*}\right)^{-1}: \mathcal{S}_{p+1} \cap N^{\perp} \rightarrow \mathcal{S}_{p+1}$, as well as $\xi: \mathcal{S}_{p+1} \rightarrow \mathcal{S}_{p}$.

Any function $\psi \in \mathcal{S}_{p}$ solution of $H \psi=g$ may be decomposed as $\psi_{0}+\psi_{1}$ with $\psi_{0} \in N$ and $\psi_{1} \in N^{\perp}$. Since $H \psi_{0}=0$ and hence $\psi_{1}=H^{-1} g, \psi_{0}$ is arbitrary in Ker $H=N$.
4.3. Microscopic balance. Our geometric assumptions impose that $C^{-1} \geq \rho_{t} \geq C>0$ and that $0<c_{0} \leq c_{t}<1$ for constants $C$ and $c_{0}$ independent of $t \geq 0$.

For a fixed time $t$, we now solve the equation $T_{0} a=b$. We introduce

$$
\phi_{t}(\zeta):=\left(\frac{\rho_{t}}{4 \pi}\right)^{\frac{1}{4}} e^{-\frac{\rho_{t}}{2} \zeta^{2}}\left[\begin{array}{c}
1  \tag{4.2}\\
-1
\end{array}\right], \quad N_{t}=\operatorname{Ker} T_{0}=\left\{f(\xi) \phi_{t}(\zeta) ; f \in \mathcal{S}_{0}(\mathbb{R} ; \mathbb{C})\right\}
$$

The normalization implies that $\left\|\phi_{t}\right\|_{L^{2}\left(\mathbb{R}, \mathbb{C}^{2}\right)}=1$. That $N_{t}$ is the kernel of $T_{0}$ comes from Lemma 4.1 and the change of variables given in the last section. We still denote by $\mathcal{S}_{p}\left(\mathbb{R}^{2}, \mathbb{C}^{2}\right)$ the spaces of functions in the $(\xi, \zeta)$ variables, which are equivalent to the corresponding spaces in the variables $\left(\rho_{t}^{-1} c_{t} \xi, \rho_{t}^{1 / 2} \zeta\right)$ by assumption on $\left(c_{t}, \rho_{t}\right)$.

The leading order equation is then solved as follows.
Lemma 4.2. Let $b \in N_{t}^{\perp} \cap \mathcal{S}_{p+1}$. The equation $T_{0} a=b$ admits a unique solution $T_{0}^{-1} b:=$ $a \in N_{t}^{\perp} \cap \mathcal{S}_{p}$ with inverse operator given explicitly by

0 & \left(\rho_{t} \zeta-\partial_{\zeta}\right)^{-1} \\
\left(\rho_{t} \zeta+\partial_{\zeta}\right)^{-1} & -2 \xi c_{t}\left(\rho_{t} \zeta+\partial_{\zeta}\right)^{-1}\left(\rho_{t} \zeta-\partial_{\zeta}\right)^{-1}
\end{array}\right] Q, \quad Q=\frac{1}{\sqrt{2}}\left(\sigma_{1}+\sigma_{3}\right)
$$

All solutions of that equation in $\mathcal{S}_{p}$ are of the form $a=T_{0}^{-1} b+f(\xi) \phi(\zeta)$ for arbitrary $f(\xi) \in \mathcal{S}_{p}(\mathbb{R}, \mathbb{C})$.

Proof. This is a corollary of Lemma 4.1 and the invertible transform from $T_{0}$ to $H$. The operator $T_{0}$ is thus invertible on the orthogonal complement of $\phi_{t}(\zeta)$ with $T_{0} a=b$ solvable if and only if $\left(b, \phi_{t}\right)_{2}=0$ in which case all solutions are given by $a=T_{0}^{-1} b+f(\xi) \phi_{t}$ for $f$ arbitrary in $\mathcal{S}_{p}$.

The solution to the leading equation $T_{0} a_{0}=0$ is therefore given by

a_{0}(t, \xi, \zeta)=f_{0}(t, \xi) \phi_{t}(\zeta) \tag{4.3}
\end{equation*}
$$

with $f_{0}(t, \xi)$ arbitrary at this level.

## 5. Transport equation

Lemma 4.2 states that the subleading equation in (3.29), $T_{0} a_{1}=-T_{1} a_{0}$, admits a solution if and only if $T_{1} a_{0}(t, \cdot) \in N_{t}^{\perp}$ for every $t$. From the expressions (4.3) of $a_{0}$ and (4.2) of $N_{t}$ and $\phi_{t}(\zeta)$, we deduce that $T_{0} a_{1}=-T_{1} a_{0}$ is solvable if and only if $\mathcal{T} f_{0}=0$, where

$$
\begin{equation*}
\mathcal{T} f(t, \xi):=\int_{\mathbb{R}} \phi_{t}(\zeta) \cdot T_{1}\left[f(t, \xi) \phi_{t}(\zeta)\right] d \zeta \tag{5.1}
\end{equation*}
$$

In this section we provide an explicit expression for $\mathcal{T}$ and for the solutions to $\mathcal{T} f_{0}=0$ and more generally $\mathcal{T} f_{0}=g$. We also provide a functional setting to analyze the map $g \rightarrow f_{0}$ when the dispersion is strongest.

### 5.1. Derivation of the transport operator.

Lemma 5.1. We have the identity

\mathcal{T}=D_{t}-\frac{k_{t}}{2 \rho_{t}}-j_{t} \gamma_{t} \frac{\xi D_{\xi}+D_{\xi} \xi}{2}-\left(\dot{\theta}_{t} \gamma_{t}+k_{t} \gamma_{t}^{2}\right) \xi^{2} \tag{5.2}
\end{equation*}
$$

Proof. We first observe that

\end{array}\right], \sigma_{j}\left[\begin{array}{c}
1 \\
-1
\end{array}\right]\right\rangle=-2 \delta_{1 j} .
$$

Therefore, the terms in $T_{1}$ that are carried by $\sigma_{2}, \sigma_{3}$ do not contribute to $\mathcal{T}$. Likewise, we observe that

$$
\int_{\mathbb{R}} \phi(\zeta) \cdot \zeta \phi(\zeta) d \zeta=\int_{\mathbb{R}} \phi(\zeta) \cdot D_{\zeta} \phi(\zeta) d \zeta=0
$$

Hence, for the purpose of computing $\mathcal{T}$, we can ignore terms in $T_{1}$ carried by $\sigma_{2}$ or $\sigma_{3}$, and terms linear in $\left(\zeta, D_{\zeta}\right)$. In other words, we can replace $T_{1}$ in (5.1) by the right hand side of (3.27):

D_{t}+\dot{\theta}_{t} \gamma_{t}\left(D_{\zeta}^{2}-\xi^{2}\right)+\left(\frac{\dot{\theta}_{t} s_{t}}{2}+j_{t} \gamma_{t}\left(D_{\xi} \xi-D_{\zeta} \zeta\right)+k_{t}\left(\zeta^{2}+\gamma_{t}^{2} \xi^{2}\right)\right) \sigma_{1}
$$

We note moreover that

$$
D_{\zeta} \zeta \phi=i\left(\rho_{t} \zeta^{2}-1\right) \phi, \quad D_{\zeta}^{2} \phi(\zeta)=\left(\rho_{t}-\rho_{t}^{2} \zeta^{2}\right) \phi(\zeta), \quad D_{t} \phi(\zeta)=i \frac{\dot{\rho}_{t}}{2} \zeta^{2} \phi(\zeta)-i \frac{\dot{\rho}_{t}}{4 \rho_{t}} \phi(\zeta)
$$

Therefore, we deduce that

$$
\begin{aligned}
\mathcal{T}= & \left(\frac{\rho_{t}}{\pi}\right)^{\frac{1}{2}} \int_{\mathbb{R}} e^{-\rho_{t} \zeta^{2}}\left(D_{t}+i \frac{\dot{\rho}_{t}}{2} \zeta^{2}-i \frac{1}{4} \frac{\dot{\rho}_{t}}{\rho_{t}}+\dot{\theta}_{t} \gamma_{t}\left(\rho_{t}-\rho_{t}^{2} \zeta^{2}-\xi^{2}\right)\right. \\
& \left.-\left(\frac{\dot{\theta}_{t} s_{t}}{2}+j_{t} \gamma_{t}\left(D_{\xi} \xi-i \rho_{t} \zeta^{2}+i\right)+k_{t}\left(\zeta^{2}+\gamma_{t}^{2} \xi^{2}\right)\right)\right) d \zeta .
\end{aligned}
$$

Furthermore, we have

$$
\left(\frac{\rho_{t}}{\pi}\right)^{\frac{1}{2}} \int_{\mathbb{R}} e^{-\rho_{t} \zeta^{2}} d \zeta=1, \quad\left(\frac{\rho_{t}}{\pi}\right)^{\frac{1}{2}} \int_{\mathbb{R}} \zeta^{2} e^{-\rho_{t} \zeta^{2}} d \zeta=\frac{1}{2 \rho_{t}}
$$

Hence, after performing the integration and realizing that the coefficients involving $\dot{\rho}_{t}$ cancel out, we obtain the formula

\begin{aligned}
\mathcal{T} & =D_{t}+\dot{\theta}_{t} \gamma_{t}\left(\frac{\rho_{t}}{2}-\xi^{2}\right)-\frac{\dot{\theta}_{t} s_{t}}{2}-j_{t} \gamma_{t}\left(D_{\xi} \xi+\frac{i}{2}\right)-k_{t}\left(\frac{1}{2 \rho_{t}}+\gamma_{t}^{2} \xi^{2}\right) \\
& =D_{t}-\dot{\theta}_{t} \gamma_{t} \xi^{2}-j_{t} \gamma_{t} \frac{\xi D_{\xi}+D_{\xi} \xi}{2}-k_{t}\left(\frac{1}{2 \rho_{t}}+\gamma_{t}^{2} \xi^{2}\right) \\
& =D_{t}-\frac{k_{t}}{2 \rho_{t}}-j_{t} \gamma_{t} \frac{\xi D_{\xi}+D_{\xi} \xi}{2}-\left(\dot{\theta}_{t} \gamma_{t}+k_{t} \gamma_{t}^{2}\right) \xi^{2},
\end{aligned}
$$

where in the second line we used $\gamma_{t} \rho_{t}=s_{t}$.
5.2. Solving the transport equation. To produce an explicit solution of the transport equation $\mathcal{T} f=0$ we define $\left(\lambda_{t}, \mu_{t}, \nu_{t}\right)$ such that

\lambda_{t}=\int_{0}^{t} \frac{k_{s}}{2 \rho_{s}} d s, \quad \nu_{t}=2 \int_{0}^{t} \frac{c_{0}^{2}}{c_{s}^{2}}\left(\dot{\theta}_{s} \gamma_{s}+k_{s} \gamma_{s}^{2}\right) d s, \quad e^{\mu_{t}}=\frac{c_{t}}{c_{0}} \tag{5.3}
\end{equation*}
$$

Lemma 5.2. The solution to $\mathcal{T} f=0$ is given by

$$
\begin{equation*}
f(t, \xi)=\exp \left(i \lambda_{t}+i \frac{\nu_{t}}{2}\left(e^{\mu_{t}} \xi\right)^{2}\right) e^{\frac{\mu_{t}}{2}} f\left(0, e^{\mu_{t}} \xi\right) \tag{5.4}
\end{equation*}
$$

Proof. 1. We recall that the self-adjoint operator $\frac{1}{2}\left(\xi D_{\xi}+D_{\xi} \xi\right)$ generates the semigroup of ( $L^{2}$-unitary) dilations; that is, for $F$ independent of $t$ :

We note that $e^{\mu_{0}}=1$; moreover, thanks to (3.21), we have $\dot{\mu}_{t}=\partial_{t} \ln \left(c_{t}\right)=j_{t} \gamma_{t}$. Therefore, by the chain rule and (5.5), we have

$$

2. We deduce, using $U_{\mu_{t}}^{-1} \xi^{2} U_{\mu_{t}}=e^{-2 \mu_{t}} \xi^{2}$, that

U_{\mu_{t}}^{-1} \mathcal{T} U_{\mu_{t}}=D_{t}-\frac{k_{t}}{2 \rho_{t}}-e^{-2 \mu_{t}}\left(\dot{\theta}_{t} \gamma_{t}+k_{t} \gamma_{t}^{2}\right) \xi^{2}=D_{t}-\dot{\lambda_{t}}-\frac{1}{2} \dot{\nu}_{t} \xi^{2}=e^{i \lambda_{t}+i \nu_{t} \frac{\xi^{2}}{2}} D_{t} e^{-i \lambda_{t}-i \nu_{t} \frac{\xi^{2}}{2}}
$$

where we used the relations (5.3) for $\lambda_{t}$ and $\nu_{t}$. For the formula (5.5) for $U_{\mu}$, we deduce that the solution to $\mathcal{T} f=0=\mathcal{T} U_{\mu_{t}} e^{i \lambda_{t}+i \frac{\nu_{t}}{2} \xi^{2}} g$ is $D_{t} g=0$ and hence

Since $e^{\mu_{t}}=c_{t} / c_{0}$, we conclude that

This completes the proof.
5.3. Dispersive estimate. In this section, we study the $L^{\infty}$-decay of the leading order solution of (3.3), $\psi_{0}=\mathfrak{U}_{t} a_{0}$, where $a_{0}$ takes the form prescribed by (4.3) and (5.4):

\end{array}\right], \quad \tilde{a}_{0}(t, \xi, \zeta)=\left(\frac{\rho_{t}}{4 \pi}\right)^{\frac{1}{4}} e^{\frac{\mu_{t}}{2}} \exp \left(i \frac{\nu_{t}}{2}\left(e^{\mu_{t}} \xi\right)^{2}-\frac{\rho_{t}}{2} \zeta^{2}\right) \hat{f}\left(e^{\mu_{t}} \xi\right)
$$

where $\hat{f}(\xi)$ denotes the Fourier transform of a function $f\left(z_{1}\right)$.
Lemma 5.3. (i) With $\psi_{0}=\mathfrak{U}_{t} a_{0}$ and $a_{0}$ given by (5.6), we have whenever $B_{t} \neq 0$ or $\nu_{t} \neq 0$ :

where $*_{1}$ denotes convolution with respect to the first variable and

G_{t}\left(e^{-\mu_{t}} z_{1}, e^{\mu_{t}} z_{2}\right)=\left(\frac{\rho_{t}}{4 \pi}\right)^{\frac{1}{4}}\left(\frac{e^{\mu_{t}}}{Q_{t}}\right)^{\frac{1}{2}} e^{-\frac{1}{2} \rho_{t} z_{2}^{2}} e^{-\frac{1}{2} Q_{t}^{-1}\left(z_{1}+i s_{t} z_{2}\right)^{2}}, \quad Q_{t}=s_{t} \gamma_{t}-i e^{2 \mu_{t}} \nu_{t} \tag{5.7}
\end{equation*}
$$

We recall that $s_{t}=\gamma_{t} \rho_{t}$.
(ii) In particular, there exists $C>0$ such that as long as $\nu_{t} \neq 0$ :

\mathcal{V}_{t} \tilde{a}_{0}\left(e^{\mu_{t}} z_{1}, \frac{z_{2}}{e^{\mu_{t}}}\right) & =\left(\frac{\rho_{t}}{4 \pi}\right)^{\frac{1}{4}} \int_{\mathbb{R}} e^{i e^{\mu_{t}} z_{1} \xi} \exp \left(i \frac{\nu_{t}}{2}\left(e^{\mu_{t}} \xi\right)^{2}-\frac{\rho_{t} e^{-2 \mu_{t}}}{2}\left(z_{2}+\gamma_{t} e^{\mu_{t}} \xi\right)^{2}\right) \hat{f}\left(e^{\mu_{t}} \xi\right) \frac{e^{\frac{\mu_{t}}{2}} d \xi}{\sqrt{2 \pi}} \\
& =\left(\frac{\rho_{t}}{4 \pi}\right)^{\frac{1}{4}} \int_{\mathbb{R}} e^{i z_{1} \xi} \exp \left(i \frac{\nu_{t}}{2} \xi^{2}-\frac{\rho_{t} e^{-2 \mu_{t}}}{2}\left(z_{2}+\gamma_{t} \xi\right)^{2}\right) \hat{f}(\xi) \frac{e^{-\frac{\mu_{t}}{2}} d \xi}{\sqrt{2 \pi}} . \tag{5.9}
\end{align*}

The left-hand side involves the inverse Fourier transform in $z_{1}$ of a product and may therefore be written as the convolution

where the Gaussian $G_{t}$ is given by

G_{t}(z)=\left(\frac{\rho_{t}}{4 \pi}\right)^{\frac{1}{4}} e^{\frac{-\mu_{t}}{2}} \int_{\mathbb{R}} e^{i z_{1} \xi} \exp \left(i \frac{\nu_{t}}{2} \xi^{2}-\frac{\rho_{t} e^{-2 \mu_{t}}}{2}\left(z_{2}+\gamma_{t} \xi\right)^{2}\right) \frac{d \xi}{\sqrt{2 \pi}}, \tag{5.11}
\end{equation*}
$$

so that

G_{t}\left(z_{1}, e^{\mu_{t}} z_{2}\right) & =\left(\frac{\rho_{t}}{4 \pi}\right)^{\frac{1}{4}} e^{\frac{-\mu_{t}}{2}} e^{-\frac{1}{2} \rho_{t} z_{2}^{2}} \int_{\mathbb{R}} e^{-\frac{1}{2} \tilde{Q}_{t} \xi^{2}} e^{i \xi\left(z_{1}+i \rho_{t} \gamma_{t} e^{-\mu_{t}} z_{2}\right)} \frac{d \xi}{\sqrt{2 \pi}}, \quad \tilde{Q}_{t}=\rho_{t} \gamma_{t}^{2} e^{-2 \mu_{t}}-i \nu_{t} \\
& =\left(\frac{\rho_{t}}{4 \pi}\right)^{\frac{1}{4}} e^{\frac{-\mu_{t}}{2}} e^{-\frac{1}{2} \rho_{t} z_{2}^{2}} \tilde{Q}_{t}^{-\frac{1}{2}} e^{-\frac{1}{2} \tilde{Q}_{t}^{-1}\left(z_{1}+i \rho_{t} \gamma_{t} e^{\left.-\mu_{t} z_{2}\right)^{2}}\right.} \tag{5.12}
\end{align*}
$$

as the Fourier transform of a Gaussian function when $\tilde{Q}_{t} \neq 0$. Since $Q_{t}=e^{2 \mu_{t}} \tilde{Q}_{t}$, we find (5.7). Then (5.6) follows from applying $\mathrm{U}_{t}$ to $\mathcal{V}_{t} a_{0}$ using (5.6) and (5.10).

To prove the second part of the lemma, we first take $L^{\infty}$-norms on both sides of (5.10) and we apply Young's $L^{1}-L^{\infty}$ convolution inequality (in the variable $z_{1}$ ). This produces:

\end{equation*}
$$

The Gaussian $\left|G_{t}\right|$ attains its maximum at $z=0$ because the real part of the quadratic form in $z$ in (5.7) satisfies

$$

as we verify by an elementary computation using $\rho_{t} \gamma_{t}=s_{t}$. Using (5.13), we find

\sup _{z \in \mathbb{R}}\left|\mathcal{V}_{t} \tilde{a}_{0}(z)\right| \leq\|f\|_{L^{1}}\left|G_{t}(0)\right|=\left(\frac{\rho_{t}}{4 \pi}\right)^{\frac{1}{4}}\left(\frac{e^{\mu_{t}}}{\left|Q_{t}\right|}\right)^{\frac{1}{2}}\|f\|_{L^{1}}
$$

From (5.9), we also obtain that $\sup _{z \in \mathbb{R}}\left|\mathcal{V}_{t} \tilde{a}_{0}(z)\right| \leq C\|\hat{f}\|_{L^{1}}$. To end up with (5.8), we observe that $\mathrm{U}_{t}$ preserves $L^{\infty}$-norms, that $\left|Q_{t}\right| \geq\left|\nu_{t}\right|$ and that $c_{t}$ is bounded above and below for all times $t$.

When $Q_{t}=0$, we have $\nu_{t}=0, c_{t}=1, \rho_{t}=r_{t}$ and the formulas (5.10) and (5.11) remain valid. But instead of being a Gaussian, $G_{t}$ is now a multiple of the Dirac mass, and

5.4. Dispersion-dependent functional setting. The solution of $\mathcal{T} f=0$ with given initial condition admits an explicit expression as we saw in Lemma 5.2. In the analysis of the asymptotic expansion of $\psi(t, z)$ in powers of $\varepsilon$, we need to solve transport equations of the form $\mathcal{T} f=g$ with time-dependent source terms. To quantify the stability of the inverse transport operators and that of other relevant transforms, we introduce the following functional setting.

We recall the functional spaces $\mathcal{S}_{p}$ were defined in section 4.1. To handle the timedependence for $t \in[0, \mathrm{~T}]$ of the wavepackets, we introduce the spaces for $p \in \mathbb{N}$ and $k=\left\lfloor\frac{p}{2}\right\rfloor \in \mathbb{N}$ (i.e., $p=2 k$ or $p=2 k+1$ ) defined for an interval $\mathrm{I} \subset \mathbb{R}$ by

\mathbb{S}_{p}\left(\mathrm{I}, \mathbb{R}^{d}, \mathbb{C}^{q}\right)=\cap_{r=0}^{k} C^{r}\left(\mathrm{I} ; \mathcal{S}_{p-2 r}\left(\mathbb{R}^{d}, \mathbb{C}^{q}\right)\right)
$$

with norm given by the sum of the natural norms for the above spaces (see (5.16) below). The spaces are constructed so that any derivative in time corresponds to a loss of order 2 in the remaining variable.

To quantify the effects of dispersion, we define

$$
\begin{equation*}
\langle\nu\rangle_{\mathrm{T}}=1+\sup _{0 \leq t \leq \mathrm{T}}\left|\nu_{t}\right| \quad \text { and } \quad \varsigma=\langle\nu\rangle_{\mathrm{T}}^{-\frac{1}{2}} \tag{5.14}
\end{equation*}
$$

We saw in Lemma 5.2 that dispersion resulted in a multiplication operator of the form $\phi_{t}(\xi)=e^{i \frac{1}{2} \nu(t) \xi^{2}}$. The operator $D_{t} \phi_{t}=\phi_{t}\left(D_{t}+\frac{1}{2} \nu^{\prime}(t) \xi^{2}\right)$. This explains why the spaces $\mathbb{S}_{p}$ are constructed so that both $\partial_{t}$ and $\xi^{2}$ map $\mathbb{S}_{p+2}$ to $\mathbb{S}_{p}$.

Similarly, $\partial_{\xi} \phi_{t}=\phi_{t}\left(\partial_{\xi}+i \nu(t) \xi\right)$, so that (the operator of multiplication by) $\phi_{t}$ is large as an operator on $\mathbb{S}_{1}$ when $\langle\nu\rangle_{\mathrm{T}}$ is. Yet clearly, $\phi_{t}^{2}$ is comparable to $\phi_{t}$ in the same sense. Since the construction of our wavepackets requires repeated application of operators of the form $\phi_{t}$, we introduce scaled metrics on $\mathcal{S}_{p}$ and $\mathbb{S}_{p}$ so that application of $\phi_{t}$ results in a bounded operation independent of $\langle\nu\rangle_{\mathrm{T}}$.

This is simply achieved by replacing $\mathfrak{a}_{\xi}^{*}=-\partial_{\xi}+\xi$ by $\mathfrak{a}_{\xi}^{*}=-\varsigma \partial_{\xi}+\varsigma^{-1} \xi$ and endowing the spaces $\mathcal{S}_{p}(\mathbb{R})$ and $\mathcal{S}_{p}\left(\mathbb{R}^{2}\right)$ respectively with the norms

\|\psi\|_{p \varsigma}^{2}=\left\|\left(\mathfrak{a}_{\xi \varsigma}^{*}\right)^{p} \psi\right\|_{0}^{2} \quad \text { and } \quad\|\psi\|_{p \varsigma}^{2}=\sum_{j=0}^{p}\left\|\left(\mathfrak{a}_{\xi \varsigma}^{*}\right)^{j}\left(\mathfrak{a}_{\zeta}^{*}\right)^{p-j} \psi\right\|_{0}^{2} . \tag{5.15}
\end{equation*}
$$

We call $\mathcal{S}_{p \varsigma}$ the spaces $\mathcal{S}_{p}$ endowed with these dispersion-scaled norms.
The space $\mathbb{S}_{p}\left(\mathrm{I}, \mathbb{R}^{d}, \mathbb{C}\right)$ are similarly endowed for $d=1,2$ with the norms (and called $\mathbb{S}_{p \varsigma}$ )

\begin{equation*}
\|\psi\|_{p \varsigma}^{2}=\sup _{t \in \mathrm{I}} \sum_{r=0}^{\left\lfloor\frac{p}{2}\right\rfloor}\left\|\left(\mathfrak{a}_{\xi \varsigma}^{*}\right)^{p-2 r} \partial_{t}^{r} \psi\right\|_{0}^{2} \text { and }\|\psi\|_{p \varsigma}^{2}=\sup _{t \in \mathrm{I}} \sum_{r=0}^{\left\lfloor\frac{p}{2}\right\rfloor} \sum_{j=0}^{p-2 r}\left\|\left(\mathfrak{a}_{\xi \varsigma}^{*}\right)^{j}\left(\mathfrak{a}_{\zeta}^{*}\right)^{p-2 r-j} \partial_{t}^{r} \psi\right\|_{0}^{2} . \tag{5.16}
\end{equation*}
$$

Spaces of vector-valued functions are similarly constructed componentwise.

Note that $\varsigma^{p}\|f\|_{p} \lesssim\|f\|_{p \varsigma} \lesssim \varsigma^{-p}\|f\|_{p}$. Here and below, we use the notation $a \lesssim b$ to mean the existence of a $\varsigma$-independent constant $C$ such that $a \leq C b$. Here is a number of dispersion-dependent estimates we will be using.

Lemma 5.4. All operator bounds below are meant to be $\varsigma$-independent bounds.
Any operator $B \in\left\{\varsigma D_{\xi}, \varsigma^{-1} \xi, D_{\zeta}, \zeta\right\}$ is bounded from $\mathcal{S}_{p+1, \varsigma}$ to $\mathcal{S}_{p \varsigma}$ and from $\mathbb{S}_{p+1, \varsigma}$ to $\mathbb{S}_{p \varsigma}$. The operator $\partial_{t}$ is bounded from $\mathbb{S}_{p+2, \varsigma}$ to $\mathbb{S}_{p \varsigma}$.

Let $\phi(\xi)=e^{i \frac{1}{2} \nu \xi^{2}}$ with $|\nu| \lesssim\langle\nu\rangle_{\mathrm{T}}$. Then the operator of multiplication by $\phi(\xi)$ is bounded from $\mathcal{S}_{p \varsigma}$ to itself.

Let $\phi(t, \xi)=e^{i \frac{1}{2} \nu(t) \xi^{2}}$ with $\sup _{t \in \mathrm{I}}|\nu(t)| \lesssim\langle\nu\rangle_{\mathrm{T}}$ and $\sup _{t \in \mathrm{I}}\left|\nu^{(j)}(t)\right| \leq C_{j}$ for $j \geq 1$. Then the operator of multiplication by $\phi(t, \xi)$ is bounded from $\mathbb{S}_{p \varsigma}$ to itself.

Proof. The first statement comes from the construction of the spaces since $\mathfrak{a}_{\xi \varsigma}^{*}$ controls $\varsigma \partial_{\xi}$ and $\varsigma^{-1} \xi$ in the sense that

\left\|\mathfrak{a}_{\xi \varsigma}^{*} \psi\right\|_{0}^{2}=\varsigma^{2}\left\|\partial_{\xi} \psi\right\|_{0}^{2}+\varsigma^{-2}\|\xi \psi\|_{0}^{2}+\|\psi\|_{0}^{2}
$$

One obtains from (5.16) for $p \geq 2$ that $\left\|\partial_{t} \psi\right\|_{p \varsigma}^{2} \lesssim\|\psi\|_{p-2, \varsigma}^{2}$ and hence the bound on $\partial_{t}$.
Consider now the operator of multiplication by $\phi(\xi)$ in one dimension $d=1$. We wish to show that

\|\phi \psi\|_{p \varsigma}^{2}=\left\|\left(\mathfrak{a}_{\xi \varsigma}^{*}\right)^{p}(\phi \psi)\right\|_{0}^{2} \lesssim\left\|\left(\mathfrak{a}_{\xi \varsigma}^{*}\right)^{p} \psi\right\|_{0}^{2}=\|\psi\|_{p \varsigma}^{2} .
$$

This holds when $p=0$. Assume it holds for $p-1 \geq 0$. Then

\|\phi \psi\|_{p \varsigma}^{2}=\left\|\left(\mathfrak{a}_{\xi \varsigma}^{*}\right)^{p-1}\left(\mathfrak{a}_{\xi \varsigma}^{*}\right)(\phi \psi)\right\|_{0}^{2}=\left\|\left(\mathfrak{a}_{\xi \varsigma}^{*}\right)^{p-1}\left(\phi \psi_{1}\right)\right\|_{0}^{2} \lesssim\left\|\psi_{1}\right\|_{p-1, \varsigma}^{2}
$$

by induction hypothesis, where $\psi_{1}(\xi)=\left(\mathfrak{a}_{\xi \varsigma}^{*}-i \varsigma \nu \xi\right) \psi$. By construction of the functional spaces and the above result for the operator $\varsigma^{-1} \xi$ knowing that $\varsigma|\nu| \lesssim \varsigma^{-1}$, we find $\left\|\psi_{1}\right\|_{p-1, \varsigma}^{2} \lesssim$ $\|\psi\|_{p, \varsigma}^{2}$ and the result is proved. The same proof applies in two dimensions $d=2$ as well using the norm for $\mathcal{S}_{p}\left(\mathbb{R}^{2}\right)$ in (5.15) and that the commutator $\left[\mathfrak{a}_{\zeta}^{*}, \phi\right]=0$.

The proof in the time-dependent setting uses that

$$
\partial_{t}^{r}(\phi \psi)=\phi\left(\partial_{t}+i \frac{1}{2} \nu^{\prime}(t) \xi^{2}\right)^{r} \psi=\phi \psi_{r}, \quad \psi_{r}=\left(\sum_{j=0}^{r} \nu_{j}(t) \xi^{2(r-j)} \partial_{t}^{j}\right) \psi
$$

for smooth and bounded functions $\nu_{j}(t)$ independent of $\langle\nu\rangle_{\mathrm{T}}$ by assumption on $\nu(t)$. Assume dimension $d=1$ as $d=2$ is treated similarly. Using that $\xi^{2(r-j)} \partial_{t}^{j}$ maps $\mathbb{S}_{p \varsigma}$ to $\mathbb{S}_{p-2 r, \varsigma}$ for each $0 \leq j \leq r$ and the bounds proved above in the time-independent setting, we find

\left\|\left(\mathfrak{a}_{\xi \varsigma}^{*}\right)^{p-2 r} \partial_{t}^{r} \phi \psi\right\|_{0}=\left\|\left(\mathfrak{a}_{\xi \varsigma}^{*}\right)^{p-2 r} \phi \psi_{r}\right\|_{0} \lesssim\left\|\psi_{r}\right\|_{p-2 r, \varsigma} \lesssim\|\psi\|_{p \varsigma} .
$$

The explicit expression of the norms in (5.16) and the above estimate conclude the proof of the lemma.
5.5. Stability of the transport and other operators. We then have the following stability result for the transport equation $\mathcal{T} f=g$. We recall that $\varsigma=\langle\nu\rangle_{\mathrm{T}}^{-\frac{1}{2}}$.
Lemma 5.5. Let $p \in \mathbb{N}$. The solution $f_{0}(t, \xi)$ of $\mathcal{T} f_{0}=g$ on $[0, \mathrm{~T}] \times \mathbb{R}$ with initial condition $f_{0}(0, \xi)=\hat{f}(\xi) \in \mathcal{S}_{p \varsigma}(\mathbb{R}, \mathbb{C})$ and source term $g \in \mathbb{S}_{p \varsigma}(\mathbb{R}, \mathbb{C})$ satisfies the estimate

$$
\left\|f_{0}\right\|_{p \varsigma} \leq C_{p}\left(\|\hat{f}\|_{p \varsigma}+\langle\mathrm{T}\rangle\|g\|_{p \varsigma}\right)
$$

where $\langle\mathrm{T}\rangle=1+\mathrm{T}$ and $C_{p}$ is independent of T .
Proof. We first adapt Lemma 5.2 to handle volume sources and define

$$
\lambda_{s, t}=\int_{s}^{t} \frac{k_{\tau}}{2 \rho_{\tau}} d \tau, \quad \tilde{\nu}_{s, t}=2 \int_{s}^{t} \frac{c_{t}^{2}}{c_{\tau}^{2}}\left(\dot{\theta}_{\tau} \gamma_{\tau}+k_{\tau} \gamma_{\tau}^{2}\right) d \tau, \quad e^{\mu_{s, t}}=\frac{c_{t}}{c_{s}}
$$

to obtain that the solution to $\mathcal{T} f=0$ with initial condition $f(s, \cdot)$ is given by

$$
\begin{equation*}
f(t, \xi)=\exp \left(i \lambda_{s, t}+i \frac{\tilde{\nu}_{s, t}}{2} \xi^{2}\right) e^{\mu_{s, t} / 2} f\left(s, e^{\mu_{s, t}} \xi\right) \tag{5.17}
\end{equation*}
$$

By an application of the Duhamel principle, the solution to $\mathcal{T} f=g$ for $0 \leq t \leq T$ with $f(0, \xi)=0$ is thus given explicitly by

$$
f(t, \xi)=i \int_{0}^{t} \exp \left(i \lambda_{s, t}+i \frac{1}{2} \tilde{\nu}_{s, t} \xi^{2}\right) e^{\mu_{s, t} / 2} g\left(s, e^{\mu_{s, t}} \xi\right) d s
$$

Consider the solution in (5.17) at a fixed time $s$ with the explicit time-dependence $\lambda(t)=$ $\lambda_{s, t}, e^{\mu(t)}=e^{\mu_{s, t}}$ and $\nu(t)=\tilde{\nu}_{s, t}$ to simplify notation. We prove the lemma for the operator

$$
f(t, \xi) \rightarrow e^{i \lambda(t)} e^{\frac{\mu(t)}{2}} e^{i \frac{1}{2} \nu(t) \xi^{2}} f\left(t, e^{\mu(t)} \xi\right)
$$

The term $e^{i \lambda(t)}$ generates a smooth in time modulation. Since $\mu(t)$ is smooth and bounded above and below by positive constants independent of $t, e^{\mu(t) / 2}$ is also smooth. The operator $f(t, \xi) \rightarrow e^{\frac{\mu(t)}{2}} e^{i \lambda(t)} f(t, \xi)$ is therefore bounded in the norms $\|\cdot\|_{p \zeta}$.

All other time dependent coefficients are smooth and uniformly bounded in time independent of T except for $\nu(t)$ that may grow linearly with $\nu^{\prime}(t)$ uniformly bounded. Consider the operator $f(t, \xi) \mapsto h(t, \xi)=f\left(t, e^{\mu(t)} \xi\right)$ with $\hat{f} \in \mathbb{S}_{p \varsigma}$. Plugging $h(t, \xi)$ into the definition of the norms (5.16), we directly obtain that $\|h\|_{p \varsigma} \lesssim\|f\|_{p \varsigma}$.

The final transformation (with $\nu(t)$ replaced by $\nu(t) e^{-2 \mu(t)}$ )

$$
f(t, \xi) \mapsto h(t, \xi)=f(t, \xi) e^{i \frac{1}{2} \nu(t) \xi^{2}}
$$

was analyzed in Lemma 5.4. This concludes the analysis of the map from $\hat{f}(\xi)$ to $f_{0}(t, \xi)$.
The volume source term $g(t, \xi)$ is treated similarly by the Duhamel principle, with an additional possible integration in time that provides the extra multiplication by $\langle\mathrm{T}\rangle$. This concludes the proof of the lemma.

We conclude this section with a summary of the operators we introduced to construct approximations of the Dirac equation and some estimates they satisfy.

The terms in $T_{0}$ and $T_{1}$ that contribute to the construction of the leading term $a_{0}(t, \xi, \zeta)$ in the formal expansion $a=\sum_{j \geq 0} \varepsilon^{\frac{j}{2}} a_{j}$ were given in Lemma 3.2. Constructing higher-order terms $a_{j}$ and proving convergence results require estimates on the operators $T_{j}$, which are constructed as in the proof of Lemma 3.2 and given explicitly by

T_{1}=D_{t}+\mathcal{A}+\tilde{T}_{1}, \quad T_{j}=\tilde{T}_{j}, \quad j \geq 2
$$

with $\mathfrak{U}_{t}^{*} D_{t} \mathfrak{U}_{t}=D_{t}+\mathcal{A}$ where

$$
\mathcal{A}:=-\frac{1}{2}\left(\dot{\varphi}_{t} \sigma_{2}+\dot{\theta}_{t}\left(-s_{t} \sigma_{1}+c_{t} \sigma_{3}\right)-\dot{\theta}_{t}\left(-D_{\xi} D_{\zeta}-\zeta \xi+\gamma_{t}\left(\xi^{2}-D_{\zeta}^{2}\right)\right)\right)+\dot{\gamma}_{t} \xi D_{\zeta}
$$

and for $j \geq 1$,

$$
\tilde{T}_{j}=\sum_{|\alpha|=j+1} \mathcal{V}_{t}^{*} z^{\alpha} \mathcal{V}_{t} \nu_{\alpha} \cdot \sigma, \quad \mathbb{C}^{3} \ni \nu_{\alpha}=\frac{1}{\alpha!} \tilde{R}_{2, \varphi_{t}} \tilde{R}_{3, \theta_{t}}\left(R_{-\theta_{t}} \nabla\right)^{\alpha} h\left(y_{t}\right)
$$

We verify for completeness that $\mathcal{V}_{t}^{*} z^{\alpha} \mathcal{V}_{t}=\left(\zeta-\gamma_{t} \xi\right)^{\alpha_{2}}(-1)^{\alpha_{1}}\left(D_{\zeta}+\gamma_{t} D_{\xi}\right)^{\alpha_{1}}$.
We recall that $\left(j_{t}, k_{t}\right)=\left(\nu_{111}, \nu_{021}\right)$ while $\nu_{201}=0$ was important to obtain an explicit expression for the transport solution since the transport operator involves no term of the form $D_{\xi}^{2}$. We now summarize the estimates we will be needing.

Lemma 5.6. We may write $T_{0}^{-1}=T_{01}^{-1}+T_{02}^{-1}$ and $T_{1}=T_{11}+T_{12}$ such that the following operators are bounded with $\langle\nu\rangle_{\mathrm{T}}$-independent bounds:

\begin{aligned}
\varsigma^{-1} T_{01}^{-1}: & N_{t}^{\perp} \cap \mathbb{S}_{p+1, \varsigma} \rightarrow \mathbb{S}_{p \varsigma}, & T_{02}^{-1}: & N_{t}^{\perp} \cap \mathbb{S}_{p \varsigma} \rightarrow \mathbb{S}_{p \varsigma}, \\
\varsigma T_{11}: & \mathbb{S}_{p+1, \varsigma} \rightarrow \mathbb{S}_{p \varsigma}, & T_{12}: & \mathbb{S}_{p+2, \varsigma} \rightarrow \mathbb{S}_{p \varsigma} \\
\varsigma^{j+1} T_{j}: & \mathbb{S}_{p+j+1, \varsigma} \rightarrow \mathbb{S}_{p \varsigma}, \quad j \geq 2, & \langle T\rangle^{-1} \mathcal{T}^{-1}: & \mathbb{S}_{p \varsigma} \rightarrow \mathbb{S}_{p \varsigma}
\end{aligned}
$$

Proof. From Lemma 4.2 and the decomposition

$$
T_{01}^{-1}=Q\left[\begin{array}{cc}
0 & 0 \\
0 & -2 \xi c_{t}\left(\rho_{t} \zeta+\partial_{\zeta}\right)^{-1}\left(\rho_{t} \zeta-\partial_{\zeta}\right)^{-1}
\end{array}\right] Q, \quad T_{02}^{-1}=T_{0}^{-1}-T_{01}^{-1}
$$

and Lemma 5.4, we obtain the above first two bounds.
We define $T_{1}=T_{11}+T_{12}$ with $T_{11}$ the contribution that is linear in $D_{\xi}$ while $T_{12}$ accounts for the rest (no contribution in $T_{1}$ is quadratic in $D_{\xi}$ ). The above corresponding bounds then follow from Lemma 5.4 for quadratic expressions in $D_{\xi}, D_{\zeta}, \xi$, and $\zeta$. The same lemma is used to bound $T_{j}$ for $j \geq 2$. The final estimate is a repeat of Lemma 5.5.

## 6. Asymptotic expansion and error estimates

We recall that our objective is to construct approximations of solutions $\Psi(t, x)$ of the Dirac equation (1.1). Our first step was to perform a gauge transformation $\tilde{\Psi}(t, x)=$ $e^{-i \chi(t, x) / \varepsilon} \Psi(t, x)$ replacing the Dirac operator $\not D$ by $\tilde{D}+R$ in (2.10). Since $R$ in (2.9) is a negligible perturbation to arbitrary order in $\varepsilon$, our second step was to look for wavepackets $\tilde{\Psi}(t, x)$ in the kernel of $\varepsilon D_{t}+\tilde{D}$.

Wavepackets in natural coordinates $\psi(t, z)=\varepsilon^{\frac{1}{2}} S \tilde{\Psi}(t, z)$ with the scaling $S$ defined in (3.1) then solve $L \psi=0$ in (3.3). Further transformations resulted in the definition of $a(\xi, \zeta)=$ $\mathfrak{U}_{t}^{*} \psi(\xi, \zeta)$, where $\mathfrak{U}_{t}=\mathrm{U}_{t} \mathcal{V}_{t}$ with $\mathrm{U}_{t}$ defined in (3.8) and $\mathcal{V}_{t}$ in (3.25). The problem $L \psi=0$ is then equivalent to $T a=0$ for $T=\mathfrak{U}_{t}^{*} L \mathfrak{U}_{t}$. Writing $L=\sum_{j \geq 0} \varepsilon^{\frac{j}{2}} L_{j}$ with $L_{j}$ presented in (3.4)-(3.6), we have a corresponding expansion $T=\sum_{j \geq 0} \varepsilon^{\frac{j}{2}} T_{j}$ with $T_{j}=\mathfrak{U}_{t}^{*} L_{j} \mathfrak{U}_{t}$.
6.1. Construction of the asymptotic wavepacket. Using the notation recalled above, we now construct approximations $a^{J}=\sum_{j=0}^{J} \varepsilon^{\frac{j}{2}} a_{j}$ of $a(t, \xi, \zeta)$ solution of $T a=0$. Plugging the expansion for $a^{J}$ in the equation $T a^{J}=0$, using $T=\sum_{j \geq 0} \varepsilon^{\frac{j}{2}} T_{j}$, and equating like
powers of $\varepsilon$ gives the sequence of equations (3.29), which we recall here:

$$
\begin{equation*}
\sum_{k=0}^{j} T_{k} a_{j-k}=0, \quad 0 \leq j \leq J \tag{6.1}
\end{equation*}
$$

We solve these equations in turn.
The leading order equation $T_{0} a_{0}=0$ combined with Lemma 4.2 shows that $a_{0}(t, \xi, \zeta)=$ $f_{0}(t, \xi) \phi_{t}(\zeta)$ with $\phi_{t}$ defined in (4.2). The compatibility condition for the next equation $T_{0} a_{1}=-T_{1} a_{0}$ implies $\mathcal{T} f_{0}=0$ with the transport operator $\mathcal{T}$ defined in Lemma 5.2. For a fixed initial condition $f_{0}(0, \xi)=\hat{f}(\xi)$, Lemma 5.5 provides a unique solution $f_{0}(t, \xi)$ of $\mathcal{T} f_{0}=0$ and a leading term $a_{0}(t, \xi, \zeta)=f_{0}(t, \xi) \phi_{t}(\zeta)$.

Consider next the construction of $a_{1}$, solution to $T_{0} a_{1}+T_{1} a_{0}=0$. It is given according to Lemma 4.2 by

$$
a_{1}=-T_{0}^{-1} T_{1} a_{0}+f_{1} \phi_{t}
$$

with $f_{1}$ arbitrary at this stage. We will consider regularity properties in a lemma below.
We now extend the construction to higher-order approximations. Let $j \geq 2$ and assume $a_{k}$ for $0 \leq k \leq j-1$ constructed except for $f_{j-1}$. In order to define $a_{j}$, we impose the compatibility condition

$$
\left(\sum_{k=1}^{j} T_{k} a_{j-k}, \phi_{t}\right)_{2}=0 \quad \text { or equivalently } \quad \mathcal{T} f_{j-1}=g_{j-1}, \quad g_{j-1}=-\left(\sum_{k=2}^{j} T_{k} a_{j-k}, \phi_{t}\right)_{2} .
$$

We recall that $(\cdot, \cdot)_{2}$ is the standard inner product in $L^{2}\left(\mathbb{R}, \mathbb{C}^{2}\right)$ in the $\zeta$ variable. By lemma 5.5 , this is a well-posed transport equation for $f_{j-1}$. Then, by lemma 4.2,

$$
a_{j}=T_{0}^{-1}\left(-\sum_{k=1}^{j} T_{k} a_{j-k}\right)+f_{j} \phi_{t}
$$

This constructs $a_{j}$ for $0 \leq j \leq J$ iteratively and we set $f_{J}=0$ for concreteness. This concludes the construction of the approximation

$$
a^{J}=\sum_{j=0}^{J} \varepsilon^{\frac{j}{2}} a_{j}
$$

of formal order $\varepsilon^{\frac{J+1}{2}}$ of $a$ solution of $T a=0$.
Note that the initial conditions for $a_{j}(0, \xi, \zeta)$ for $j \geq 1$ are defined implicitly by the above construction. Only $\hat{f}(\xi)$ in the initial condition $a_{0}(0, \xi, \zeta)=\hat{f}(\xi) \phi_{t}(\zeta)$ is prescribed. Our construction aims to propagate wavepackets that belong to an appropriate (non-dispersive) branch of continuous spectrum of $\tilde{D}$. The initial condition for $a^{J}$ ensures that the latter belongs to that branch with sufficient accuracy.

The terms of the above expansion satisfy the following estimate:
Lemma 6.1. Let $a_{j}$ be constructed as above for $0 \leq j \leq J$ (with $f_{J}=0$ ) and for $p \in \mathbb{N}$, let $\hat{f} \in \mathcal{S}_{p+3 J}$. Then we have the estimates for $0 \leq j \leq J-1$,

$$
\left\|a_{j}\right\|_{p} \leq C_{p J}\left(\langle\mathrm{~T}\rangle\langle\nu\rangle_{\mathrm{T}}^{3}\right)^{j}\langle\nu\rangle_{\mathrm{T}}^{p}\|\hat{f}\|_{p+3 j}, \quad\left\|a_{J}\right\|_{p} \leq C_{p J}\left(\langle\mathrm{~T}\rangle\langle\nu\rangle_{\mathrm{T}}^{3}\right)^{J-1}\langle\nu\rangle_{\mathrm{T}}^{p+1}\|\hat{f}\|_{p+3 J},
$$

with constants $C_{p J}$ independent of T and $\langle\nu\rangle_{\mathrm{T}}$.

Proof. Consider $0<j<J$. The estimate for $a_{J}$ is a bit different since $f_{J}=0$.
We first observe that by construction of the terms $a_{j}$ for $1 \leq j \leq J-1$,

$$
\begin{equation*}
a_{j}=-T_{0}^{-1} \sum_{k=0}^{j-1} T_{j-k} a_{k}-\phi_{t}(\zeta) \mathcal{T}^{-1} \sum_{k=0}^{j-1}\left(T_{j+1-k} a_{k}, \phi_{t}\right)_{2} \tag{6.2}
\end{equation*}
$$

We wish to prove by induction that

$$
\begin{equation*}
\left\|a_{j}\right\|_{p \varsigma} \lesssim\left(\langle T\rangle \varsigma^{-3}\right)^{j}\left\|a_{0}\right\|_{p+3 j, \varsigma}, \quad\left\|a_{J}\right\|_{p \varsigma} \lesssim\left(\langle T\rangle \varsigma^{-3}\right)^{J-1}\left(\varsigma\left\|a_{0}\right\|_{p+3 J, \varsigma}+\left\|a_{0}\right\|_{p+3 J-1, \varsigma}\right) \tag{6.3}
\end{equation*}
$$

Using that $\left\|a_{0}\right\|_{p \varsigma}=\left\|f_{0} \phi_{t}\right\|_{p \varsigma} \lesssim\|\hat{f}\|_{p \varsigma}$ thanks to Lemma 5.5, then $\varsigma^{p}\|f\|_{p} \lesssim\|f\|_{p \varsigma} \lesssim \varsigma^{-p}\|f\|_{p}$ and $\varsigma=\langle\nu\rangle_{\mathrm{T}}^{-\frac{1}{2}}$ thus provide the results stated in the lemma. It remains to verify (6.3).

From (6.2) for $j=1$, we obtain $a_{1}=-T_{0}^{-1} T_{1} a_{0}-\phi_{t} \mathcal{T}^{-1}\left(T_{2} a_{0}, \phi_{t}\right)_{2}$ so that using the result of Lemma 5.6, we find the second term to be the least regular and

$$
\left\|a_{1}\right\|_{p \varsigma} \lesssim\langle T\rangle \varsigma^{-3}\left\|a_{0}\right\|_{p \varsigma+3}
$$

so that (6.3) holds when $j=1$. Assume it holds for $j-1 \geq 1$. Then using (6.2) and Lemma 5.6, we find

$$
\left\|a_{j}\right\|_{p \varsigma} \lesssim\langle T\rangle \sum_{k=0}^{j-1} \varsigma^{-(j+2-k)}\left\|a_{k}\right\|_{p+j+2-k, \varsigma} \lesssim\langle T\rangle \sum_{k=0}^{j-1} \varsigma^{-(j+2-k)}\left(\langle T\rangle \varsigma^{-3}\right)^{k}\left\|a_{0}\right\|_{p+2 k+j+2, \varsigma}
$$

which is largest when $k=j-1$ and provides the sought estimate when $0 \leq j<J$. It remains to consider the term

$$
a_{J}=-T_{0}^{-1} \sum_{k=0}^{J-1} T_{J-k} a_{k}=-T_{0}^{-1} \Pi_{t} \sum_{k=0}^{J-1} T_{J-k} a_{k}=-T_{0}^{-1} \Pi_{t} T_{1} a_{J-1}-T_{0}^{-1} \Pi_{t} \sum_{k=0}^{J-2} T_{J-k} a_{k},
$$

by construction of the wavepackets, where $\Pi_{t}$ projects onto $N_{t}^{\perp}$. This operator has a smooth Schwartz kernel in $\left(t, \zeta, \zeta^{\prime}\right)$ that is independent of $\xi$. Therefore $\Pi_{t}$ is bounded from $\mathbb{S}_{p \varsigma}$ to itself with $\varsigma$-independent bound.

Since $T_{0}^{-1}$ is bounded from $N^{\perp} \cap \mathbb{S}_{p+1, \varsigma}$ to $\mathbb{S}_{p \varsigma}$, we find for $0 \leq k \leq J-2$

$$
\left\|T_{0}^{-1} \Pi_{t} T_{J-k} a_{k}\right\|_{p \varsigma} \lesssim\left\|a_{k}\right\|_{p+2+J-k, \varsigma} \lesssim\left(\langle\mathrm{~T}\rangle \varsigma^{-3}\right)^{k}\left\|a_{0}\right\|_{p+2+J+2 k, \varsigma} \lesssim\left(\langle\mathrm{~T}\rangle \varsigma^{-3}\right)^{J-1}\left\|a_{0}\right\|_{p+3 J-1, \varsigma}
$$

since $2+J+2 k \leq 3 J-1$.
It remains to consider $T_{0}^{-1} \Pi_{t} T_{1} a_{J-1}$. We decompose $T_{0}^{-1} \Pi_{t} T_{1}=A+B$ with $A=$ $T_{01}^{-1} \Pi_{t} T_{11}+T_{02}^{-1} \Pi_{t} T_{12}$ with bound $\langle T\rangle$ from $\mathbb{S}_{p+2, \varsigma} \rightarrow \mathbb{S}_{p \varsigma}$ and $B=T_{01}^{-1} \Pi_{t} T_{12}+T_{02}^{-1} \Pi_{t} T_{11}$ with bound $\langle T\rangle_{\varsigma}$ from $\mathbb{S}_{p+3, \varsigma} \rightarrow \mathbb{S}_{p \varsigma}$ as per Lemma 5.6. This implies

$$
\left\|a_{J}\right\|_{p \varsigma} \lesssim\left(\langle T\rangle \varsigma^{-3}\right)^{J-1}\left(\varsigma\left\|a_{0}\right\|_{p+3 J, \varsigma}+\left\|a_{0}\right\|_{p+3 J-1, \varsigma}\right)
$$

as was to be shown. Thus (6.3) holds and this concludes the proof of the lemma.
6.2. Main approximation result. We can now state our main result.

Theorem 6.2. Let $\Psi$ be the solution on $[0, T] \times \mathbb{R}^{2}$ of $\left(\varepsilon D_{t}+\not D\right) \Psi=0$ with initial condition $\Psi(0, x)=\Psi^{J}(0, x)$ where $\Psi^{J}(t, x)=e^{\frac{i}{\varepsilon} \chi(t, x)}\left(\varepsilon^{-\frac{1}{2}} S^{-1} \mathfrak{U}_{t} a^{J}\right)(t, x)$ with $a^{J}$ constructed in section 6.1 based on an initial condition $\hat{f}(\xi) \in \mathcal{S}_{3 J+2}(\mathbb{R}, \mathbb{C})$.

Then there exists $C_{J}>0$ independent of T such that for every $\varepsilon \in(0,1]$,

$$
\sup _{t \in[0, \mathrm{~T}]}\left\|\Psi-\Psi^{J}\right\|_{L^{2}\left(\mathbb{R}^{2}, \mathbb{C}^{2}\right)} \leq C_{J}\left(\langle\mathrm{~T}\rangle\langle\nu\rangle_{\mathrm{T}}^{3}\right)^{J} \varepsilon^{\frac{J}{2}}
$$

We recall that $\langle\nu\rangle_{\mathrm{T}}$ is defined in (5.14) and $\langle\mathrm{T}\rangle=1+\mathrm{T}$. In particular, the approximation error is controlled so long as $\varepsilon^{\frac{1}{2}}\langle T\rangle\langle\nu\rangle_{\mathrm{T}}^{3} \ll 1$. When $\langle\nu\rangle_{\mathrm{T}}$ is uniformly bounded, errors are controlled up to times $\mathrm{T} \ll \varepsilon^{-\frac{1}{2}}$ as in $\left[\mathrm{BBD}^{+} 21\right]$. However, when $\langle\nu\rangle_{\mathrm{T}}$ is of order T , then errors are controlled up to times $\mathrm{T} \ll \varepsilon^{-\frac{1}{8}}$.

Note that such results are qualitatively reasonable: in the presence of dispersion, it becomes more difficult to control spatial moments (necessitated by the Taylor expansion of the coefficients $h$ ) of the solution.

The rest of the section is devoted to the proof of this theorem. It is based on a similar approximation result in the local variables $z=\left(z_{1}, z_{2}\right)$, which we state as a result of independent interest.

Proposition 6.3. Let $\psi$ be the solution on $[0, \mathrm{~T}] \times \mathbb{R}^{2}$ of $L \psi=0$ with initial condition $\psi(0, z)=\psi^{J}(0, z)$ where $\psi^{J}(t, z)=\mathfrak{U}_{t} a^{J}(t, z)$ with $a^{J}$ constructed in section 6.1 based on an initial condition $\hat{f}(\xi) \in \mathcal{S}_{3 J+2}(\mathbb{R}, \mathbb{C})$.

Then there exists $C_{J}>0$ independent of T such that for every $\varepsilon \in(0,1]$,

$$
\sup _{t \in[0, \mathrm{~T}]}\left\|\psi-\psi^{J}\right\|_{L^{2}\left(\mathbb{R}^{2}, \mathbb{C}^{2}\right)} \leq C_{J}\left(\langle\mathrm{~T}\rangle\langle\nu\rangle_{\mathrm{T}}^{3}\right)^{J} \varepsilon^{\frac{J}{2}}
$$

Proof. Solutions of the local problems $L \psi=0$ and $T a=0$ are equivalent via the relation $\psi=\mathfrak{U}_{t} a$. We now show that $\psi^{J}=\sum_{j=0}^{J} \varepsilon^{\frac{j}{2}} \psi_{j}$ with $\psi_{j}=\mathfrak{U}_{t} a_{j}$ approximately solves $L \psi=0$ when $J \geq 1$. Define for $J \geq 1$ the remainder operator

$$
L_{\geq J}=\varepsilon^{-\frac{J}{2}}\left(L-\sum_{j=0}^{J-1} \varepsilon^{\frac{j}{2}} L_{j}\right)
$$

and the reduced operator $\tilde{L}_{\geq J}=L_{\geq J}-\delta_{1 J} D_{t}$ involving only the coefficients $h$.
We deduce from (6.1) that $\sum_{k=0}^{j} L_{k} \psi_{j-k}=0$ for $0 \leq j \leq J$ and hence

$$
L \psi^{J}=\sum_{j=0}^{J} \varepsilon^{\frac{j}{2}} L \psi_{j}=\sum_{j=0}^{J}\left(\sum_{k=0}^{J-j} \varepsilon^{\frac{j+k}{2}} L_{k} \psi_{j}+\varepsilon^{\frac{J+1}{2}} L_{\geq J+1-j} \psi_{j}\right)=\varepsilon^{\frac{J+1}{2}} \sum_{j=0}^{J} L_{\geq J+1-j} \psi_{j},
$$

since

$$
\sum_{j=0}^{J} \sum_{k=0}^{J-j} \varepsilon^{\frac{j+k}{2}} L_{k} \psi_{j}=\sum_{j=0}^{J} \sum_{l=j}^{J} \varepsilon^{\frac{l}{2}} L_{l-j} \psi_{j}=\sum_{l=0}^{J} \varepsilon^{\frac{l}{2}} \sum_{j=0}^{l} L_{l-j} \psi_{j}=0
$$

We thus obtain

$$
\begin{equation*}
L \psi^{J}=\varepsilon^{\frac{J+1}{2}}\left(D_{t} \psi_{J}+\sum_{j=0}^{J} \tilde{L}_{\geq J+1-j} \psi_{k}\right)=: r_{J} . \tag{6.4}
\end{equation*}
$$

We now derive a uniform bound in time of order $\varepsilon^{\frac{J+1}{2}}$ in $L^{2}\left(\mathbb{R}^{2}, \mathbb{C}^{2}\right)$ for $r_{J}$.
We observe that $\mathcal{V}_{t} \mathcal{S}_{p}\left(\mathbb{R}^{d} ; \mathbb{C}^{q}\right) \mathcal{V}_{t}^{*} \cong \mathcal{S}_{p}\left(\mathbb{R}^{d} ; \mathbb{C}^{q}\right)$ as spaces of functions (of $z$ for $d=2$ ). In other words, $\|g\|_{p} \cong\left\|\mathcal{V}_{t}^{*} g\right\|_{p}$ define equivalent norms for each $p$. The reason is that the above
spaces based on Hermite functions are invariant by conjugation by Fourier transforms as well as invariant under invertible linear transforms $\left(\xi, z_{2}\right) \mapsto\left(\xi, z_{2}+\gamma_{t} \xi\right)$ of the base variables (uniformly in time since $\gamma_{t}$ is bounded). Since $\gamma_{t}$ is smooth, we also obtain the equivalence of the norms of $\mathcal{V}_{t} \mathbb{S}_{p}\left(\mathbb{R}^{d} ; \mathbb{C}^{q}\right) \mathcal{V}_{t}^{*} \cong \mathbb{S}_{p}\left(\mathbb{R}^{d} ; \mathbb{C}^{q}\right)$. Note that there is no meaningful notion of anisotropic space $\mathbb{S}_{p \varsigma}$ in the variable $z$.

The regularity results of lemma 6.1 therefore apply to $\psi_{j}=\mathfrak{U}_{t} a_{j}$ since conjugation by $\mathrm{U}_{t}$ also preserves norms as the rotation angles $\theta_{t}$ and $\varphi_{t}$ are smooth in $t$. As a consequence,

$$
\begin{align*}
\left\|\psi_{J}\right\|_{2} & \lesssim\langle T\rangle^{J-1}\langle\nu\rangle_{\mathrm{T}}^{3 J}\|\hat{f}\|_{3 J+2}  \tag{6.5}\\
\left\|\psi_{j}\right\|_{J-j+2} & \lesssim\left(\langle T\rangle\langle\nu\rangle_{\mathrm{T}}^{3}\right)^{j}\langle\nu\rangle_{\mathrm{T}}^{J-j+2}\|\hat{f}\|_{J+2 j+2} \lesssim\langle T\rangle^{J-1}\langle\nu\rangle_{\mathrm{T}}^{3 J}\|\hat{f}\|_{3 J+2}
\end{align*}
$$

for $0 \leq j \leq J-1$.
Since $D_{t}$ is bounded from $\mathbb{S}_{p+2}$ to $\mathbb{S}_{p}$, we obtain that $\left\|D_{t} \psi_{J}\right\|_{0} \lesssim\langle T\rangle^{J-1}\|\hat{f}\|_{3 J+2}$.
Using Taylor expansions of the coefficients for $1 \leq j \leq J$,

$$
h\left(y_{t}+\sqrt{\varepsilon} z\right)=\sum_{|\alpha| \leq j} \frac{1}{\alpha!} \partial^{\alpha} h\left(y_{t}\right) \varepsilon^{\frac{|\alpha|}{2}} z^{\alpha}+\varepsilon^{\frac{j+1}{2}} \sum_{|\beta|=j+1} z^{\beta} R_{\beta}\left(y_{t}+\sqrt{\varepsilon} z\right),
$$

with smooth functions $R_{\beta}$ by regularity assumptions on $\kappa$ and $A$, we observe that $\tilde{L}_{\geq j}$ has the same regularity properties as $\tilde{L}_{j}$. In particular, it maps $\mathbb{S}_{p+j+1}$ to $\mathbb{S}_{p}$. Therefore, for $0 \leq j \leq J,\left\|\tilde{L}_{\geq J+1-j} \psi_{j}\right\|_{0} \lesssim\left\|\psi_{j}\right\|_{J+2-j} \lesssim\langle T\rangle^{J-1}\langle\nu\rangle_{T}^{3 J}\|\hat{f}\|_{3 J+2}$ thanks to (6.5).

By definition (6.4), this shows that

$$
\begin{equation*}
\left\|r_{J}\right\|_{0} \lesssim \varepsilon^{\frac{J+1}{2}}\langle T\rangle^{J-1}\langle\nu\rangle_{\mathrm{T}}^{3 J}\|\hat{f}\|_{3 J+2} \tag{6.6}
\end{equation*}
$$

Define $\tilde{L}=L-\varepsilon^{\frac{1}{2}} D_{t}$, which we verify is self adjoint [Tha92]. We thus observe that $L\left(\psi^{J}-\psi\right)=r^{J}$ is equivalent to

$$
\left(D_{t}+\varepsilon^{-\frac{1}{2}} \tilde{L}\right)\left(\psi^{J}-\psi\right)=\varepsilon^{-\frac{1}{2}} r_{J}
$$

By unitarity of the above Dirac operator [Tha92], we obtain an error on $\left\|\psi^{J}-\psi\right\|_{0}$ of order $\langle T\rangle \varepsilon^{-\frac{1}{2}}\left\|r_{J}\right\|_{0} \lesssim \varepsilon^{\frac{J}{2}}\langle T\rangle^{J}\langle\nu\rangle_{T}^{3 J}$. This concludes the proof of the proposition.

Proof. (Theorem 6.2) Let $\tilde{\Psi}$ be the solution of $\left(\varepsilon D_{t}+\tilde{D}\right) \tilde{\Psi}=0$ with initial conditions $\tilde{\Psi}(0, x)=\tilde{\Psi}^{J}(t, x)=\left(\varepsilon^{-\frac{1}{2}} S^{-1} \mathfrak{U}_{t} a^{J}\right)(t, x)$. Since $\tilde{\Psi}=\varepsilon^{-\frac{1}{2}} S^{-1} \psi$ and $\tilde{\Psi}^{J}=\varepsilon^{-\frac{1}{2}} S^{-1} \psi^{J}$ for $\varepsilon^{-\frac{1}{2}} S^{-1}$ an $L^{2}$-isometry, we directly deduce from Proposition 6.3 that

$$
\sup _{t \in[0, \mathrm{~T}]}\left\|\tilde{\Psi}-\tilde{\Psi}^{J}\right\|_{L^{2}\left(\mathbb{R}^{2}, \mathbb{C}^{2}\right)} \leq C_{J}\left(\langle\mathrm{~T}\rangle\langle\nu\rangle_{\mathrm{T}}^{3}\right)^{J} \varepsilon^{\frac{J}{2}}
$$

By construction, $\Psi^{J}(t, x)=e^{\frac{i}{\varepsilon} \chi(t, x)} \tilde{\Psi}^{J}(t, x)=e^{\frac{i}{\varepsilon} \chi(t, x)} \varepsilon^{-\frac{1}{2}} S^{-1} \psi^{J}(t, x)$ so that

$$
\left(\varepsilon D_{t}+\not D\right) \Psi^{J}=e^{\frac{i}{\varepsilon} \chi(t, x)}\left(\varepsilon D_{t}+\tilde{D} D+R\right) \tilde{\Psi}^{J}=e^{\frac{i}{\varepsilon} \chi(t, x)} \varepsilon^{-\frac{1}{2}} S^{-1}\left[\varepsilon^{\frac{1}{2}} r_{J}+\left(\varepsilon^{\frac{1}{2}} S R\right) \psi^{J}\right]
$$

where we used $\varepsilon D_{t}+\tilde{\mathscr{D}}=S^{-1} L \varepsilon^{\frac{1}{2}} S$ and where $r_{J}$ defined in (6.4) and estimated in (6.6).
By unitarity for $\left(\varepsilon D_{t}+\not D\right)$, the statement of the theorem follows if we show that $S R \psi^{J}(t, z)=$ $R\left(t, y_{t}+\sqrt{\varepsilon} z\right) \psi^{J}(t, z)$ satisfy a bound similar to $r_{J}$ as in (6.6).

Since $R$ vanishes on $\Omega_{\delta}$ and is uniformly bounded on $\mathbb{R} \times \mathbb{R}^{2}$ by construction, we find that for every $p \geq 0$,

$$
\left\|\left(1+|z|^{2}\right)^{\frac{p}{2}} R\left(t, y_{t}+\sqrt{\varepsilon} z\right)\right\|_{\infty} \lesssim \varepsilon^{\frac{p}{2}}
$$

Therefore, thanks to (6.5),

$$
\begin{aligned}
\left\|R\left(t, y_{t}+\sqrt{\varepsilon} z\right) \psi^{J}\right\|_{0} & \lesssim \sum_{j=0}^{J} \varepsilon^{\frac{j}{2}}\left\|R\left(t, y_{t}+\sqrt{\varepsilon} z\right) \psi_{j}\right\|_{0} \lesssim \sum_{j=0}^{J} \varepsilon^{\frac{J+1}{2}}\left\|\left(1+|z|^{2}\right)^{\frac{J-j+1}{2}} \psi_{j}\right\|_{0} \\
& \lesssim \varepsilon^{\frac{J+1}{2}} \sum_{j=0}^{J}\left\|\psi_{j}\right\|_{J-j+1} \lesssim \varepsilon^{\frac{J+1}{2}}\langle T\rangle^{J-1}\langle\nu\rangle_{\mathrm{T}}^{3 J}\|\hat{f}\|_{3 J+2}
\end{aligned}
$$

Thus, $S R \psi^{J}$ satisfies the same estimate (6.6) as $r_{J}$. Since $\not D$ is self-adjoint, we conclude the proof of Theorem 6.2 by the same unitarity principle as in Proposition 6.3.

Proof. (Theorem 1.1) The above result with $J=1$ also provides a proof of Theorem 1.1 when the gauge transformation is based on $\chi(t, x)$. Indeed, in this simplified setting with $B$ constant and $\Delta \kappa=0$, we observe that $a_{0}(t, \xi, \zeta)$ is given by (5.6) with $\lambda_{t}=0, e^{\mu_{t}}=1$, and $\tilde{\nu}_{t}=\nu_{t}=2 \gamma\left(\theta_{t}-\theta_{0}\right)$ with $\gamma=\frac{B}{1+B^{2}}$. This provides the expression for the kernel $g_{t}(z)$ in (1.8), which quantifies the dispersive effects while $\psi_{\theta_{t}, B}(z)$ captures all other effects in $\mathfrak{U}_{t} a_{0}(z)$ as one readily verifies.

An additional error in $\Psi^{1}(t, x)=e^{\frac{i}{\varepsilon} \chi(t, x)} \varepsilon^{-\frac{1}{2}} S^{-1} \psi^{1}(t, x)$ comes from replacing $\chi(t, x)$ by its quadratic expansion $\chi_{2}(t, x)$ (called $\chi(t, x)$ in Theorem 1.1) in (1.9). In the $z$ variables, we find

$$
e^{i \frac{1}{\varepsilon} \chi\left(y_{t}+\sqrt{\varepsilon} z\right)}=e^{i \frac{1}{\varepsilon} \chi_{2}\left(y_{t}+\sqrt{\varepsilon} z\right)}+O\left(\varepsilon^{\frac{1}{2}}\right)|z|^{3} .
$$

This term is multiplied by $\psi^{1}=\psi_{0}+\sqrt{\varepsilon} \psi_{1}$ and yields an error of order $\varepsilon^{\frac{1}{2}}$ in the $L^{2}$-sense for $\left(e^{\frac{i}{\varepsilon} \chi(t, x)}-e^{\frac{i}{\varepsilon} \chi_{2}(t, x)}\right) \varepsilon^{-\frac{1}{2}} S^{-1} \psi^{1}(t, x)$ when $\psi_{1} \in \mathbb{S}_{0}$ and when $|z|^{3} \psi_{0} \in \mathbb{S}_{0}$ as well. Both bounds hold as soon as $\psi_{0} \in \mathbb{S}_{3}$, and hence when $\hat{f} \in \mathcal{S}_{5}$ as required for $J=1$ in Theorem 6.2 with a bound

$$
\left\|\left[e^{i \frac{1}{\varepsilon} \chi\left(y_{t}+\sqrt{\varepsilon} z\right)}-e^{i \frac{1}{\varepsilon} \chi_{2}\left(y_{t}+\sqrt{\varepsilon} z\right)}\right] \psi^{1}\right\|_{\mathbb{S}_{0}} \leq C \varepsilon^{\frac{1}{2}} .
$$

We therefore obtain an overall bound on $\Psi-e^{\frac{i}{\varepsilon} \chi_{2}(t, x)} \varepsilon^{-\frac{1}{2}} S^{-1} \psi^{1}(t, x)$ growing as $C \varepsilon^{\frac{1}{2}}$ on an interval $[0, \mathrm{~T}]$ with T fixed. Since $\sqrt{\varepsilon} \psi_{1}$ is also of order $\varepsilon^{\frac{1}{2}}$, then so is $\Psi-e^{\frac{i}{\varepsilon} \chi_{2}(t, x)} \varepsilon^{-\frac{1}{2}} S^{-1} \psi_{0}(t, x)$. The construction performed on $[0, \mathrm{~T}]$ clearly holds on $[-\mathrm{T}, 0]$ as well. This completes the proof of Theorem 1.1.

## 7. Numerical simulations

In this section, we illustrate numerically the main effects of the magnetic field and the curved interface on the propagating wavepackets: (i) slowdown; (ii) Aharonov-Bohm phaseshift; (iii) dispersion.

The leading term in the asymptotic expansion provided by Theorem 6.2 is given by

$$
\begin{equation*}
\Psi_{0}(t, x)=\varepsilon^{-\frac{1}{2}} e^{\frac{i}{\varepsilon} \chi(t, x)}\left(\mathfrak{U}_{t} a_{0}\right)\left(t, \frac{x-y_{t}}{\sqrt{\varepsilon}}\right), \quad \text { where: } \tag{7.1}
\end{equation*}
$$

- $\mathfrak{U}_{t} a_{0}(t, z)=\mathrm{U}_{t} \mathcal{V}_{t} a_{0}(t, z)$ with $\mathrm{U}_{t}$ a spatial and spinorial rotation that does not quantitatively affect the amplitude landscape of the wavepacket;
- $\mathcal{V}_{t}$ is a Fourier-like transform given explicitly in (3.25).
- $a_{0}(t, \xi, \zeta)=f_{0}(t, \xi) \phi_{t}(\zeta)$ with $f_{0}(t, \xi)$ given respectively by (5.4) and (4.2).

For concreteness, we work below with the Gaussian initial condition $f_{0}(0, \xi)=e^{-\frac{1}{2} \sigma \xi^{2}}$ for $\sigma>0$. Thanks to (5.4) and (5.12), we obtain

$$
\mathcal{V}_{t} a_{0}(t, z)=\left(\frac{\rho_{t}}{4 \pi}\right)^{\frac{1}{4}} e^{\frac{1}{2} \mu_{t}}\left(Q_{\sigma}\right)^{-\frac{1}{2}} e^{i \lambda_{t}} e^{-\frac{1}{2} \rho_{t} z_{2}^{2}} e^{-\frac{1}{2} Q_{\sigma}^{-1}\left(z_{1}+i s_{t} z_{2}\right)^{2}}\left[\begin{array}{c}
1  \tag{7.2}\\
-1
\end{array}\right]
$$

with $Q_{\sigma}=e^{2 \mu_{t}} \sigma+s_{t} \gamma_{t}-i e^{2 \mu_{t}} \nu_{t}$. The various constants that appear in these formulas are collected as follows

$$
\begin{gathered}
r_{t}=\left|\nabla \kappa\left(y_{t}\right)\right|, \quad \rho_{t}=\sqrt{r_{t}^{2}+B_{t}^{2}}, \quad c_{t}=\frac{r_{t}}{\rho_{t}}, \quad s_{t}=\frac{B_{t}}{\rho_{t}}, \quad \gamma_{t}=\frac{B_{t}}{\rho_{t}^{2}}, \quad j_{t} \gamma_{t}=\frac{d \ln c_{t}}{d t} \\
k_{t}=\frac{c_{t}}{2}\left(\partial_{n} B\left(y_{t}\right)-B_{t} \frac{\Delta \kappa\left(y_{t}\right)}{r_{t}}\right), \quad \lambda_{t}=\int_{0}^{t} \frac{k_{s}}{2 \rho_{s}} d s, \quad e^{\mu_{t}}=\frac{c_{t}}{c_{0}}, \quad \nu_{t}=2 \int_{0}^{t} \frac{c_{0}^{2}}{c_{s}^{2}}\left(\dot{\theta}_{s} \gamma_{s}+k_{s} \gamma_{s}^{2}\right) d s
\end{gathered}
$$

and $n\left(y_{t}\right)$ and $\tau\left(y_{t}\right)$ are the normal and tangent vectors to $\Gamma$ at $y_{t}$.
The rate of change of dispersion $\dot{\nu}_{t}$ is, up to the multiplicative constant $2 \gamma_{t} e^{-2 \mu_{t}}$ given by the two contributions $\dot{\theta}_{t}+\gamma_{t} k_{t}$, which we write explicitly as

$$
\dot{\theta}_{t}+\gamma_{t} k_{t}=c_{t}\left(\epsilon_{t} K_{t}+\frac{1}{2} \frac{B \partial_{n} B-B^{2} r_{t}^{-1} \Delta \kappa}{B^{2}+r_{t}^{2}}\left(y_{t}\right)\right)
$$

with $\epsilon_{t}= \pm 1$ when $\{\mp \kappa>0\}$ is convex in a neighborhood of $y_{t}$. This provides an expression to assess how the geometry of $\kappa$ and that of $B$ combine to amplify or suppress dispersion.
7.1. Magnetic slowdown in constant B-field. The most visible impact of the magnetic field is the slowdown of the wavepacket: it propagates at speed $c_{t}=\left(1+B_{t}^{2}\right)^{-\frac{1}{2}}$, which is strictly less than 1 whenever $B_{t} \neq 0$. This is confirmed by the results shown in Figure 5 .

In this simulation, a constant magnetic field for a straight interface given by $\kappa(x)=x_{2}$ is modeled by $\tilde{A}=A=-B x_{2} e_{1}=B x_{2} \tau$ (with therefore $\chi=0$ and $\beta=B$ ). This implies $j_{t}=k_{t}=0$ so that $e^{\mu_{t}}=1$ and $\nu_{t}=0$. The terms $\rho=\sqrt{1+B^{2}}$ and $\gamma=\frac{B}{1+B^{2}}$ are constant. The wavepacket velocity is constant and given by

$$
\dot{y}_{t}=-\frac{1}{\sqrt{1+B^{2}}} e_{1}=-c e_{1} .
$$

The wavepacket in (7.2) takes the simpler form

$$
\mathcal{V}_{t} a_{0}(t, z)=\left(\frac{\rho}{4 \pi}\right)^{\frac{1}{4}}\left(\frac{1}{\sigma+\rho \gamma^{2}}\right)^{\frac{1}{2}} e^{-\frac{1}{2}\left(\rho z_{2}^{2}+\frac{1}{\sigma+\rho \gamma^{2}}\left(z_{1}+i s z_{2}\right)^{2}\right)}\left[\begin{array}{c}
1 \\
-1
\end{array}\right]
$$

The oscillations of the spinor components are clearly visible in Figure 5.
7.2. Aharonov-Bohm effect for a circular interface. This effect emerges in the phase $\chi(t, x) / \varepsilon$ in (7.1) when $\Gamma$ is a loop. Once $y_{t}$ completes an exact full rotation around $\Gamma$, the wavepacket acquires the phase shift

\begin{equation*}
\frac{\chi\left(t, y_{t}\right)}{\varepsilon}=\frac{1}{\varepsilon} \int_{0}^{t} \dot{y}_{s} A\left(y_{s}\right) d s=\frac{1}{\varepsilon} \int_{\Gamma} A, \tag{7.3}
\end{equation*}
$$

see (2.11). This is a gauge-independent quantity involving the magnetic flux $\Phi=\int_{\Gamma} A$ enclosed by $\Gamma$, and of order $1 / \varepsilon$.

Consider a magnetic vector potential with flux $\Phi>0$ given in polar coordinates by

$$
A(r, \theta)=\frac{\Phi}{2 \pi r} e_{\theta}
$$

and a circular interface $\Gamma$ given by $|x|=R>0$. Note that $B=\nabla \times A=\Phi \delta_{0}$ vanishes away from the origin and in particular in the vicinity of $\Gamma$. However, the wavepacket still feels a magnetic effect: after a full revolution around $\Gamma$, it acquires according to (7.3) a measurable phase-shift $\Phi / \varepsilon$ that cannot be gauged away. This is the Aharonov-Bohm effect.
7.3. Dispersive and phase effects in closed interfaces. The coefficient $Q_{\sigma}$ in (7.2) controls the dispersion. The only term there that can grow with $t$ is

$$
\nu_{t} e^{2 \mu_{t}}=2 \int_{0}^{t} \frac{c_{t}^{2}}{c_{s}^{2}}\left(\dot{\theta_{s}} \gamma_{s}+k_{s} \gamma_{s}^{2}\right) d s
$$

Consider now a circle of radius $R$ and a choice of domain wall $\kappa(x)=\frac{|x|^{m}-R^{m}}{m R^{m-1}}$ for $m>0$ with $|\nabla \kappa|=1=r$ and $\Delta \kappa=m|x|^{-1}$ equal to $m R^{-1}$ on $\Gamma$. Assume $B$ constant so that all

coefficients are independent of time and given by

$$
c=\frac{1}{\sqrt{1+B^{2}}}, \quad k=-\frac{c B m}{2 R}, \quad \dot{\theta}=\frac{c}{R}, \quad \dot{\theta}+\gamma k=\frac{c}{R}\left(1-\frac{m B^{2}}{2\left(1+B^{2}\right)}\right) .
$$

We thus observe that $\nu_{t}=2 t \gamma(\dot{\theta}+\gamma k)$ grows linearly in time provided that $\dot{\theta}+\gamma k \neq 0$. In this case, the resulting wavepacket decreases like $t^{-1 / 2}$, in a way depending on $B$ (higher magnetic fields, however, do not necessarily enhance dispersion). This was predicted in Lemma 5.3 and (7.2) and is numerically confirmed in Figure 7.

In the other hand, when $m=\frac{2\left(1+B^{2}\right)}{B^{2}}$, the resulting domain wall prevents dispersion; see Figure 8. This can be of interest in application where one wants to slow down propagation without losing on coherence.

In this scenario we can explicitly construct the local gauge $\chi$. We have $n=e_{r}$ and $\tau=-e_{\theta}$, by using the defining relations $\partial_{\tau} \chi=A_{\tau}$ on $\Gamma$ followed by $\partial_{n} \chi=A_{n}$ across it. We have

$$
A=B x_{1} e_{2}=\frac{B r}{2}\left((1+\cos 2 \theta) e_{\theta}+\sin 2 \theta e_{r}\right)
$$

so that integrating along $\Gamma$, then across $\Gamma$, we obtain

$$
\chi(R, \theta)=\frac{B R^{2}}{2}\left(\theta+\frac{\sin 2 \theta}{2}\right), \quad \chi(r, \theta)=B R^{2} \frac{\theta}{2}+B r^{2} \frac{\sin 2 \theta}{4} .
$$

This shows that $\chi(r, \theta)$ is not globally defined as a continuous function on $\mathbb{R}^{2}$ : the term $B R^{2} \frac{\theta}{2}$ jumps after each revolution. The increment $\pi B R^{2}$ is the magnetic flux: we retrieve a Aharonov-Bohm effect.
7.4. Dispersive and (limited) compression effect in varying magnetic fields. We consider here the setting of a flat interface (with $\kappa(x)=x_{2}$ ) but with a varying magnetic field. We then observe compression and dispersive effects consistent with (7.2).

In Figure 9, the intensity of the magnetic field increases as the wavepacket propagates along $\Gamma$. We thus expect an increase in $\rho_{t}$ and as a result a compression of the wavepacket. This is confirmed by the numerical simulations of Figure 9.

We next consider the setting of a magnetic field that increases transversely to $\Gamma: B(x)=$ $1+4 B_{2} x_{2}$. Set $A=\tilde{A}=-\left(1+2 B_{2} x_{2}\right) x_{2} e_{1}$, resulting in $\beta=1+2 B_{2} x_{2}$; in particular $\partial_{n} \beta=2 B_{2}$ and $k=k_{t}=c B_{2}$ is constant. This shows that $\nu_{t}$ grows linearly with time. The wavepacket decays like $t^{-1 / 2}$, as confirmed numerically in Figure 10.

The amplitude drop generated by dispersion is, however, reversible. For instance, the magnetic field $B(x)=1+4 \cos \left(2 \pi x_{1} / 15\right) x_{2}$ generates time-dependent oscillations in $\nu_{t}$ : this

coefficient is proportional to $\sin (2 \pi t / 15)$. There is no dispersion for $t \in 15 \mathbb{Z}$, as shown in Figure 11.
