# BRAID GROUPS AND SYMPLECTIC STEINBERG GROUPS

#### Abstract

We construct a homomorphism $f$ from the braid group $B_{2 n+2}$ on $2 n+2$ strands to the Steinberg group $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ associated with the Lie type $C_{n}$ and with integer coefficients. This homomorphism lifts the well-known symplectic representation (aka the integral Burau representation) of the braid group. We also describe the image and the kernel of $f$.


## 1. Introduction

In this article we provide a connection between low-dimensional topology and algebraic $K$-theory. More precisely, let $B_{2 n+2}$ be the braid group on $2 n+2$ strands ( $n \geq 2$ ). In [17], following work by Arnold, Magnus \& Peluso, Birman, A'Campo et al. (see [1, 2, 4, 5, 21]), the second-named author investigated an action of $B_{2 n+2}$ on the free group $F_{2 n}$ on $2 n$ generators obtained by viewing a twice-punctured surface of genus $n$ as a double covering of the disk via an hyperelliptic involution. Linearizing this action, one obtains a homomorphism $\bar{f}: B_{2 n+2} \rightarrow \mathrm{Sp}_{2 n}(\mathbb{Z})$ from the braid group to the symplectic modular group $\mathrm{Sp}_{2 n}(\mathbb{Z})$. This symplectic representation was shown by Gambaudo and Ghys to be the Burau representation specialized at $t=-1$ (see [16, Prop. 2.1]).

Now $\operatorname{Sp}_{2 n}(\mathbb{Z})$ is a Chevalley group of Lie type $C_{n}$. By $[24,25,26]$ it has a natural extension, its Steinberg group $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$, which is defined by means of a presentation by generators and relations. (Steinberg groups are basic ingredients in algebraic $K$-theory; see for instance [23].)

Our main observation is that the symplectic representation $\bar{f}$ (aka the integral Burau representation mentioned above) can be lifted to a homomorphism

$$
f: B_{2 n+2} \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)
$$

from the braid group to the Steinberg group.
When $n \geq 3$ the lifting $f$ is not surjective; we shall describe its image. We also show how to extend $f$ to a surjective homomorphism with a bigger Artin group as domain.

We further describe the kernel of $f$. As an application we obtain a simple braid-like presentation of the image of $f$ (resp. of the image of $\bar{f}$ ), which is a subgroup of finite index of $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ (resp. of $\mathrm{Sp}_{2 n}(\mathbb{Z})$ ).

[^0]The paper is a continuation of [18], which dealt with the case $n=2$. It is organized as follows. In Section 2 we give a presentation of the Steinberg group $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ and list a few properties of the special elements $w_{\gamma}$. In Section 3 we construct the lifting $f$ from the braid group to the Steinberg group. In Section 4 we determine its image (see Theorem 4.1). Section 5 is devoted to a description of the kernel of $f$ : we highlight a braid $\alpha_{n} \in B_{2 n+2}$ which together with two other braids generate the kernel of $f$ as a normal subgroup (see Theorem 5.8). In Section 6 we extend $f$ to an epimorphism $\widehat{f}: \widehat{B}_{2 n+2} \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)$, where $\widehat{B}_{2 n+2}$ is an Artin group (see Theorem 6.1) slightly bigger than the braid group $B_{2 n+2}$.

## 2. The Steinberg group $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$

With any irreducible root system $\Phi$ Steinberg [25, 26] associated the socalled Steinberg group, which is an extension of the simple complex algebraic group of type $\Phi$. Later Stein [24] extended Steinberg's construction over any commutative ring $R$, thus leading to the Steinberg group $\operatorname{St}(\Phi, R)$. We are interested in the case when the root system $\Phi$ is of type $C_{n}(n \geq 2)$ and $R=\mathbb{Z}$ is the ring of integers. The corresponding Steinberg group $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ is an extension of the symplectic modular group $\operatorname{Sp}_{2 n}(\mathbb{Z})$.
2.1. The symplectic modular group $\mathrm{Sp}_{2 n}(\mathbb{Z})$. Let $n$ be an integer $\geq 2$. Recall that $\mathrm{Sp}_{2 n}(\mathbb{Z})$ is the group of $2 n \times 2 n$ matrices $M$ with integral entries satisfying the relation $M^{T} J_{2 n} M=J_{2 n}$, where $M^{T}$ is the transpose of $M$,

J_{2 n}=\left(\begin{array}{cc}
0 & \mathrm{Id}_{n} \\
-\mathrm{Id}_{n} & 0
\end{array}\right)
$$

and $\operatorname{Id}_{n}$ is the identity matrix of size $n$.
Let $\left\{\varepsilon_{1}, \ldots, \varepsilon_{n}\right\}$ be the canonical basis of the free abelian group $\mathbb{Z}^{n}$. In Bourbaki's notation the root system of type $C_{n}$ consists of the following elements (see [8, Chap. VI, § 4.6]): the elements $\pm \varepsilon_{i} \pm \varepsilon_{j}(1 \leq i, j \leq n$, $i \neq j)$ are the short roots and $\pm 2 \varepsilon_{i}(1 \leq i \leq n)$ are the long roots.

Denote by $E_{i, j}$ the $2 n \times 2 n$ matrix which has all entries equal to 0 except the $(i, j)$-entry which is equal to 1 . The group $\operatorname{Sp}_{2 n}(\mathbb{Z})$ is generated by the following matrices (see [9]):

- $X_{i, j}=\operatorname{Id}_{2 n}+E_{i, j}-E_{j+n, i+n}$ for $1 \leq i, j \leq n, i \neq j$,
- $Y_{i, j}=\operatorname{Id}_{2 n}+E_{i, j+n}+E_{j, i+n}$ for $1 \leq i, j \leq n, i \neq j$,
- $Y_{i, j}^{\prime}=Y_{i, j}^{T}$ for $1 \leq i, j \leq n, i \neq j$,
- $Z_{i}=\mathrm{Id}_{2 n}+E_{i, i+n}$ for $1 \leq i \leq n$,
- $Z_{i}^{\prime}=Z_{i}^{T}$ for $1 \leq i \leq n$.

Note that $Y_{i, j}=Y_{j, i}$ and $Y_{i, j}^{\prime}=Y_{j, i}^{\prime}$.
Each of these matrices generates a root subgroup corresponding to a root in the following way: $X_{i, j}$ corresponds to the root $\varepsilon_{i}-\varepsilon_{j}, Y_{i, j}$ to the root $\varepsilon_{i}+\varepsilon_{j}, Y_{i, j}^{\prime}$ to $-\varepsilon_{i}-\varepsilon_{j}, Z_{i}$ to $2 \varepsilon_{i}$, and $Z_{i}^{\prime}$ to $-2 \varepsilon_{i}$.

We now list the commutation relations between pairs of these matrices corresponding to non-opposite roots. In the following relations, the indices $i, j$ and $k$ are pairwise distinct and run over $\{1, \ldots, n\}$ :

{\left[X_{i, j}, Y_{i, j}\right]=Z_{i}^{2}, } & {\left[X_{i, j}, Y_{i, j}^{\prime}\right]=Z_{j}^{\prime-2}, } \\
{\left[X_{i, j}, Z_{j}\right]=Z_{i} Y_{i, j}=Y_{i, j} Z_{i}, } & {\left[X_{i, j}, Z_{i}^{\prime}\right]=Z_{j}^{\prime} Y_{i, j}^{\prime-1}=Y_{i, j}^{\prime-1} Z_{j}^{\prime}, } \\
{\left[Y_{i, j}, Z_{i}^{\prime}\right]=X_{j, i} Z_{j}^{-1}=Z_{j}^{-1} X_{j, i}, } & {\left[Y_{i, j}^{\prime}, Z_{i}\right]=X_{i, j}^{-1} Z_{j}^{\prime-1}=Z_{j}^{\prime-1} X_{i, j}^{-1} . }
\end{aligned}

The matrices commute for all other pairs of generators, except for $\left(X_{i, j}, X_{j, i}\right)$, $\left(Y_{i, j}, Y_{i, j}^{\prime}\right)$ and ( $Z_{i}, Z_{i}^{\prime}$ ), which are pairs corresponding to opposite roots.
2.2. A presentation of the Steinberg group. By [3, Sect. 3] and [24] the Steinberg group $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ has a presentation with the same generators and relations as above, namely with generators $x_{i, j}, y_{i, j}, y_{i, j}^{\prime}(1 \leq i, j \leq n$ and $i \neq j), z_{i}, z_{i}^{\prime}(1 \leq i \leq n)$ subject to the following relations (where $i, j, k \in\{1, \ldots, n\}$ are pairwise distinct):

and all remaining pairs of generators commuting, except the pairs ( $x_{i, j}, x_{j, i}$ ), $\left(y_{i, j}, y_{i, j}^{\prime}\right)$ and $\left(z_{i}, z_{i}^{\prime}\right)$ for which we do not prescribe any relation.

Note that in view of (2.9) and (2.10) the generators $x_{i, j}$ and $y_{i, j}^{\prime}$ can be expressed in terms of the other generators.

By construction there is a surjective homomorphism

$$
\pi: \operatorname{St}\left(C_{n}, \mathbb{Z}\right) \rightarrow \mathrm{Sp}_{2 n}(\mathbb{Z})
$$

sending each generator of $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ represented by a lower-case letter to the symplectic matrix represented by the corresponding upper-case letter.

By [22, Th.6.3] and [3, Kor.3.2] the kernel of the epimorphism $\pi$ : $\mathrm{St}\left(C_{n}, \mathbb{Z}\right) \rightarrow \mathrm{Sp}_{2 n}(\mathbb{Z})$ is infinite cyclic generated by $\left(x_{2 \varepsilon_{i}} x_{-2 \varepsilon_{i}}^{-1} x_{2 \varepsilon_{i}}\right)^{4}$, where $x_{2 \varepsilon_{i}}$ (resp. $x_{-2 \varepsilon_{i}}$ ) is the generator corresponding to the long root $2 \varepsilon_{i}$ (resp. to $-2 \varepsilon_{i}$ ); this generator is independent of $i$ and central (see Lemma 2.1 below; see also [20]).
2.3. The elements $w_{\gamma}$. For a root $\gamma$ let $x_{\gamma}$ be the generator of the Steinberg group corresponding to $\gamma$. Set

w_{\gamma}=x_{\gamma} x_{-\gamma}^{-1} x_{\gamma} \in \operatorname{St}\left(C_{n}, \mathbb{Z}\right) \tag{2.12}
\end{equation*}
$$

In particular, we have

$$
\begin{equation*}
w_{2 \varepsilon_{i}}=z_{i} z_{i}^{\prime-1} z_{i} \quad \text { and } \quad w_{-2 \varepsilon_{i}}=z_{i}^{\prime} z_{i}^{-1} z_{i}^{\prime} \tag{2.13}
\end{equation*}
$$

For simplicity we write $w_{i}$ for $w_{2 \varepsilon_{i}}$. Since $z_{i}$ commutes with $z_{j}$ and with $z_{j}^{\prime}$ when $i \neq j$, we have $w_{i} w_{j}=w_{j} w_{i}$ for all $(i, j) \in\{1, \ldots, n\}^{2}$.

The following equality holds for all roots $\gamma$ :

w_{\gamma}=w_{-\gamma}^{-1} \tag{2.14}
\end{equation*}
$$

(for a proof, see [18, Lemma 2.2]). As a consequence, we have

$$
\begin{equation*}
w_{\gamma} x_{\gamma} w_{\gamma}^{-1}=w_{-\gamma}^{-1} x_{\gamma} w_{\gamma}^{-1}=x_{-\gamma}^{-1} x_{\gamma} x_{-\gamma}^{-1} x_{\gamma} x_{\gamma}^{-1} x_{-\gamma} x_{\gamma}^{-1}=x_{-\gamma}^{-1} . \tag{2.15}
\end{equation*}
$$

Similarly,

$$
\begin{equation*}
w_{\gamma} x_{-\gamma} w_{\gamma}^{-1}=x_{\gamma}^{-1} \tag{2.16}
\end{equation*}
$$

It follows from (2.15) and (2.16) that the square $w_{\gamma}^{2}$ commutes with $x_{\gamma}$ and with $x_{-\gamma}$ for all roots $\gamma$.

We also need the subsequent relation between an element $w_{\gamma}$ and the generator $x_{\delta}$ associated with a root $\delta$ such that $\gamma+\delta \neq 0$, namely

w_{\gamma} x_{\delta} w_{\gamma}^{-1}=x_{\delta^{\prime}}^{c} \tag{2.17}
\end{equation*}
$$

where $\delta^{\prime}$ is the image of $\delta$ under the reflection $s_{\gamma}$ in the hyperplane orthogonal to $\gamma$ and $c= \pm 1$ (see Relation (R7) in [26, Chap. 3, p. 23]). Recall that $s_{\gamma}$ is given by

$$
s_{\gamma}(\delta)=\delta-2 \frac{(\gamma, \delta)}{(\gamma, \gamma)} \gamma
$$

where $(-,-)$ is the inner product of the Euclidean vector space of which the set $\left\{\varepsilon_{1}, \ldots, \varepsilon_{n}\right\}$ forms an orthonormal basis. To determine the sign $c$ (and the root $\left.\delta^{\prime}\right)$ in (2.17) it is enough to compute the image $\pi\left(w_{\gamma} x_{\delta} w_{\gamma}^{-1}\right)$ in $\mathrm{Sp}_{2 n}(\mathbb{Z})$.

In particular, for any long root $2 \varepsilon_{i}$ the element $w_{i}=w_{2 \varepsilon_{i}}$ commutes with all generators $x_{k, \ell}, y_{k, \ell}$ and $y_{k, \ell}^{\prime}$ such that $k \neq i \neq \ell$. By contrast we have the non-trivial relations $(i \neq j)$

w_{i} y_{i, j} w_{i}^{-1}=x_{j, i}, \quad w_{i} x_{j, i} w_{i}^{-1}=y_{i, j}^{-1} \tag{2.18}
\end{equation*}
$$

and

$$
\begin{equation*}
w_{i} y_{i, j}^{\prime} w_{i}^{-1}=x_{i, j}, \quad w_{i} x_{i, j} w_{i}^{-1}=y_{i, j}^{\prime-1} \tag{2.19}
\end{equation*}
$$

in the Steinberg group $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$. Hence, the conjugation by the square $w_{i}^{2}$ turns each generator $x_{i, j}, x_{j, i}, y_{i, j}, y_{i, j}^{\prime}$ into its inverse, namely

\begin{equation*}
w_{i}^{2} y_{i, j} w_{i}^{-2}=y_{i, j}^{-1}, \quad w_{i}^{2} x_{j, i} w_{i}^{-2}=x_{j, i}^{-1} \tag{2.20}
\end{equation*}
$$

and

$$
\begin{equation*}
w_{i}^{2} y_{i, j}^{\prime} w_{i}^{-2}=y_{i, j}^{\prime-1}, \quad w_{i}^{2} x_{i, j} w_{i}^{-2}=x_{i, j}^{-1} \tag{2.21}
\end{equation*}
$$

The following lemma will be used in the sequel.

Lemma 2.1. For each $i=1, \ldots, n$ the element $w_{i}^{4}$ is central in $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ and we have $w_{i}^{4}=w_{1}^{4}$.

Proof. The centrality of $w_{i}^{4}$ follows from (2.15), (2.16), (2.20) and (2.21). Now all elements $w_{i}$ are conjugate as a consequence of the following special cases of (2.17), where $i \neq j$ :

w_{\varepsilon_{i}-\varepsilon_{j}} z_{i} w_{\varepsilon_{i}-\varepsilon_{j}}^{-1}=z_{j} \quad \text { and } \quad w_{\varepsilon_{i}-\varepsilon_{j}} z_{i}^{\prime} w_{\varepsilon_{i}-\varepsilon_{j}}^{-1}=z_{j}^{\prime}
$$

The conclusion follows.

## 3. From the braid group to the Steinberg group

Let $B_{2 n+2}$ be the braid group on $2 n+2$ strands, where $n \geq 2$ is a fixed integer. It has a standard presentation with $2 n+1$ generators $\sigma_{1}, \sigma_{2}, \ldots, \sigma_{2 n+1}$ and the following relations $(1 \leq i, j \leq 2 n+1)$ :

\begin{equation*}
\sigma_{i} \sigma_{j} \sigma_{i}=\sigma_{j} \sigma_{i} \sigma_{j} \quad \text { if }|i-j|=1 \tag{3.1}
\end{equation*}
$$

and

$$
\begin{equation*}
\sigma_{i} \sigma_{j}=\sigma_{j} \sigma_{i} \quad \text { otherwise } \tag{3.2}
\end{equation*}
$$

Let us now construct a homomorphism from $B_{2 n+2}$ to the symplectic Steinberg group $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$.

Theorem 3.1. There exists a homomorphism $f: B_{2 n+2} \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ such that

$$
\begin{array}{cc}
f\left(\sigma_{1}\right)=z_{1}, & f\left(\sigma_{2 n+1}\right)=z_{n} \\
f\left(\sigma_{2 i}\right)=z_{i}^{\prime-1} & \text { for } i=1, \ldots, n \\
f\left(\sigma_{2 i+1}\right)=z_{i} z_{i+1} y_{i, i+1}^{-1} & \text { for } i=1, \ldots, n-1
\end{array}
$$

The homomorphism $f$ is surjective if and only if $n=2$.
Remarks 3.2. (a) By [17] the homomorphism $\bar{f}: B_{2 n+2} \rightarrow \mathrm{Sp}_{2 n}(\mathbb{Z})$ mentioned in the introduction is defined on the generators $\sigma_{i}$ by

$$
\begin{gathered}
\bar{f}\left(\sigma_{1}\right)=Z_{1}, \quad \bar{f}\left(\sigma_{2 n+1}\right)=Z_{n} \\
\bar{f}\left(\sigma_{2 i}\right)=Z_{i}^{\prime-1} \quad \text { for } i=1, \ldots, n \\
\bar{f}\left(\sigma_{2 i+1}\right)=Z_{i} Z_{i+1} Y_{i, i+1}^{-1} \quad \text { for } i=1, \ldots, n-1,
\end{gathered}
$$

where $Y_{i, i+1}, Z_{i}$ and $Z_{i}^{\prime}$ are the symplectic matrices defined in Section 2.1. It follows from these formulas and from the definition of $f$ in Theorem 3.1 that the latter is a natural lifting of $\bar{f}$, i.e. we have $\bar{f}=\pi \circ f$, where $\pi: \operatorname{St}\left(C_{n}, \mathbb{Z}\right) \rightarrow \operatorname{Sp}_{2 n}(\mathbb{Z})$ is the natural projection.
(b) By definition of $f$ and of $w_{1}=w_{2 \varepsilon_{1}}$ (see (2.13)) we have

$$
\begin{equation*}
w_{1}=f\left(\sigma_{1} \sigma_{2} \sigma_{1}\right) \tag{3.3}
\end{equation*}
$$

It follows from this equality and the remark at the end of Section 2.2 that the kernel of $\pi: \operatorname{St}\left(C_{n}, \mathbb{Z}\right) \rightarrow \mathrm{Sp}_{2 n}(\mathbb{Z})$, which is generated by $w_{1}^{4}$, belongs to the image of $f$. We thus recover the known fact that the integral Burau representation is not injective.
(c) Note that all three factors in the product $z_{i} z_{i+1} y_{i, i+1}^{-1} \operatorname{expressing} f\left(\sigma_{2 i+1}\right)$ commute.

Proof. It suffices to check that the values of $f\left(\sigma_{i}\right)(1 \leq i \leq 2 n+1)$ in the Steinberg group $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ satisfy the braid relations (3.1) and (3.2).
(i) Let us first check the trivial commutation relations (3.2).

- Commutation of $f\left(\sigma_{1}\right)$ with $f\left(\sigma_{2 n+1}\right)$. This follows from the fact that $z_{1}$ and $z_{n}$ commute.
- Commutation of $f\left(\sigma_{1}\right)$ with $f\left(\sigma_{2 i}\right)$ when $i \geq 2$. Indeed, $z_{1}$ commutes with $z_{i}^{\prime}$ when $i \neq 1$.
- Commutation of $f\left(\sigma_{1}\right)$ with all $f\left(\sigma_{2 i+1}\right)$. This is implied by the commuting of $z_{1}$ with the other $z_{i}$ and with the generators $y_{i, j}$.
Similarly for the trivial braid relations involving $f\left(\sigma_{2 n+1}\right)=z_{n}$.
- Commutation of $f\left(\sigma_{2 i}\right)$ with $f\left(\sigma_{2 j}\right)$. This follows from the fact that the generators $z_{i}^{\prime}$ commute with one another.
- Commutation of $f\left(\sigma_{2 i+1}\right)$ with $f\left(\sigma_{2 j+1}\right)$. Indeed, the $z_{i}$ 's commute with one another, as do the $y_{i, j}$ 's. Moreover, the $z_{i}$ 's commute with the $y_{i, j}$ 's.
- Commutation of $f\left(\sigma_{2 i}\right)$ with $f\left(\sigma_{2 j+1}\right)$ when $i \notin\{i-1, i\}$. This is implied by the facts that $z_{i}^{\prime}$ commutes with $y_{j, j+1}$ when $i \neq j$ and that $z_{i}^{\prime}$ commutes with $z_{j} z_{j+1}$ when $j \notin\{i-1, i\}$.
(ii) The relation $f\left(\sigma_{1}\right) f\left(\sigma_{2}\right) f\left(\sigma_{1}\right)=f\left(\sigma_{2}\right) f\left(\sigma_{1}\right) f\left(\sigma_{2}\right)$ reads as

$$
z_{1} z_{1}^{\prime-1} z_{1}=z_{1}^{\prime-1} z_{1} z_{1}^{\prime-1}
$$

which is equivalent to $w_{2 \varepsilon_{1}}=w_{-2 \varepsilon_{1}}^{-1}$, where we use the notation of Section 2.3. The latter equality holds by (2.14).
(iii) The relation $f\left(\sigma_{2 i}\right) f\left(\sigma_{2 i+1}\right) f\left(\sigma_{2 i}\right)=f\left(\sigma_{2 i+1}\right) f\left(\sigma_{2 i}\right) f\left(\sigma_{2 i+1}\right)$ reads for $1 \leq i \leq n-1$ as

$$
z_{i}^{\prime-1} z_{i} z_{i+1} y_{i, i+1}^{-1} z_{i}^{\prime-1}=z_{i} z_{i+1} y_{i, i+1}^{-1} z_{i}^{\prime-1} z_{i} z_{i+1} y_{i, i+1}^{-1}
$$

Let LHS (resp. RHS) be the element of $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ represented by the lefthand (resp. right-hand) side of the previous equation.

Since $z_{i}$ commutes with $y_{i, i+1}$ and with $z_{i+1}$, and the latter with $z_{i}^{\prime}$, we have

$$
\mathrm{LHS}=z_{i+1} z_{i}^{\prime-1} y_{i, i+1}^{-1} z_{i} z_{i}^{\prime-1}
$$

By (2.13), (2.10), (2.14) and the trivial commutation relations we obtain

$$
\begin{aligned}
\mathrm{LHS} & =z_{i+1} z_{i}^{\prime-1} y_{i, i+1}^{-1} z_{i}^{\prime} w_{-2 \varepsilon_{i}}^{-1} \\
& =z_{i+1} y_{i, i+1}^{-1} z_{i}^{\prime-1} z_{i+1} x_{i+1, i}^{-1} z_{i}^{\prime} w_{i} \\
& =z_{i+1} y_{i, i+1}^{-1} z_{i+1} x_{i+1, i}^{-1} w_{i} \\
& =z_{i+1}^{2} y_{i, i+1}^{-1} x_{i+1, i}^{-1} w_{i} .
\end{aligned}
$$

Let us now deal with RHS. Since $z_{i}$ commutes with $y_{i, i+1}$, and $z_{i+1}$ with $z_{i}, z_{i}^{\prime}$ and $y_{i, i+1}$, we have

$$
\begin{aligned}
\mathrm{RHS} & =z_{i+1}^{2} y_{i, i+1}^{-1} z_{i} z_{i}^{\prime-1} z_{i} y_{i, i+1}^{-1}=z_{i+1}^{2} y_{i, i+1}^{-1} w_{i} y_{i, i+1}^{-1} \\
& =z_{i+1}^{2} y_{i, i+1}^{-1} x_{i+1, i}^{-1} w_{i}=\mathrm{LHS} .
\end{aligned}
$$

For the third equality we have used (2.18).
(iv) Applying the automorphism $\sigma_{i} \mapsto \sigma_{2 n+2-i}$ of $B_{2 n+2}$, we reduce the relations $f\left(\sigma_{2 i-1}\right) f\left(\sigma_{2 i}\right) f\left(\sigma_{2 i-1}\right)=f\left(\sigma_{2 i}\right) f\left(\sigma_{2 i-1}\right) f\left(\sigma_{2 i}\right)(2 \leq i \leq n)$ and $f\left(\sigma_{2 n}\right) f\left(\sigma_{2 n+1}\right) f\left(\sigma_{2 n}\right)=f\left(\sigma_{2 n+1}\right) f\left(\sigma_{2 n}\right) f\left(\sigma_{2 n+1}\right)$ to the previous cases.
(v) The surjectivity for $n=2$ was established in [18]. Let us now prove that $f$ is not surjective when $n \geq 3$. We remark that under the composition $B_{2 n+2} \rightarrow \operatorname{Sp}_{2 n}(\mathbb{Z}) \rightarrow \operatorname{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$ of $\bar{f}$ with the reduction modulo 2 the images of the generators $\sigma_{i}$ of $B_{n+2}$ have order 2 . Hence this morphism factors through the symmetric group $\mathfrak{S}_{2 n+2}$ of all permutations of the set $\{1, \ldots, 2 n+2\}$. If $f$ is surjective, then $\bar{f}$ is surjective too and we obtain a surjective morphism $\mathfrak{S}_{2 n+2} \rightarrow \operatorname{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$ since the reduction modulo 2 is surjective. Now for $n \geq 2$ the symmetric group $\mathfrak{S}_{2 n+2}$ has no non-commutative proper quotient, which implies that the map $\mathfrak{S}_{2 n+2} \rightarrow \operatorname{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$ is an isomorphism. But this is impossible as $\operatorname{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$ is a simple group when $n \geq 3$ and $\mathfrak{S}_{2 n+2}$ is not. (See also [2, Proof of Statement B].)

## 4. The image of the homomorphism $f$

As noted in Theorem 3.1, the homomorphism $f: B_{2 n+2} \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ is not surjective when $n \geq 3$. We can nevertheless determine its image $f\left(B_{2 n+2}\right)$ inside $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$.

Consider the level 2 congruence subgroup $\mathrm{Sp}_{2 n}(\mathbb{Z})[2]$ defined as the kernel of the homomorphism $\mathrm{Sp}_{2 n}(\mathbb{Z}) \rightarrow \mathrm{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$ induced by reduction modulo 2 . We lift $\mathrm{Sp}_{2 n}(\mathbb{Z})[2]$ to the Steinberg group by taking its preimage

$$
\begin{equation*}
\operatorname{St}\left(C_{n}, \mathbb{Z}\right)[2]=\pi^{-1}\left(\operatorname{Sp}_{2 n}(\mathbb{Z})[2]\right) \tag{4.1}
\end{equation*}
$$

under the canonical projection $\pi: \operatorname{St}\left(C_{n}, \mathbb{Z}\right) \rightarrow \operatorname{Sp}_{2 n}(\mathbb{Z})$. Thus $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)[2]$ is the kernel of the composition

$$
\operatorname{St}\left(C_{n}, \mathbb{Z}\right) \xrightarrow{\pi} \operatorname{Sp}_{2 n}(\mathbb{Z}) \longrightarrow \operatorname{Sp}_{2 n}\left(\mathbb{F}_{2}\right)
$$

The group $\operatorname{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$ being finite, $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)[2]$ is of finite index in $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$.
Since by [3, Kor. 3.2] the kernel of the projection $\pi: \operatorname{St}\left(C_{n}, \mathbb{Z}\right) \rightarrow \operatorname{Sp}_{2 n}(\mathbb{Z})$ is the infinite cyclic group $\left\langle w_{1}^{4}\right\rangle$ generated by $w_{1}^{4}$, we have the short exact sequence

$$
1 \rightarrow\left\langle w_{1}^{4}\right\rangle \longrightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)[2] \xrightarrow{\pi} \operatorname{Sp}_{2 n}(\mathbb{Z})[2] \rightarrow 1
$$

Recall the surjective homomorphism $p: B_{2 n+2} \rightarrow \mathfrak{S}_{2 n+2}$ sending each generator $\sigma_{i}$ of $B_{2 n+2}$ to the simple transposition $s_{i} \in \mathfrak{S}_{2 n+2}$, where $s_{i}$ permutes $i$ and $i+1$ and leaves the remaining elements of $\{1, \ldots, 2 n+2\}$ fixed. The kernel of $p$ is the pure braid group $P_{2 n+2}$.

Theorem 4.1. Assume $n \geq 2$. (a) The images under $f$ of the pure braid groups $P_{2 n+2}$ and $P_{2 n+1}$ are both equal to $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)[2]$ :

$$
f\left(P_{2 n+2}\right)=f\left(P_{2 n+1}\right)=\operatorname{St}\left(C_{n}, \mathbb{Z}\right)[2] .
$$

(b) The image of the full braid group $B_{2 n+2}$ fits into the short exact sequence

$$
1 \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)[2] \longrightarrow f\left(B_{2 n+2}\right) \longrightarrow \mathfrak{S}_{2 n+2} \rightarrow 1
$$

When $n=2$ the homomorphism $f$ is surjective, that is $f\left(B_{6}\right)=\operatorname{St}\left(C_{2}, \mathbb{Z}\right)$. One recovers in this way the well-known isomorphism $\operatorname{Sp}_{4}\left(\mathbb{F}_{2}\right) \cong \mathfrak{S}_{6}$.

In general $f\left(B_{2 n+2}\right)$ is of finite index in $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ with index $i_{n}$ equal to

$$
i_{n}=\frac{\operatorname{card} \operatorname{Sp}_{2 n}\left(\mathbb{F}_{2}\right)}{\operatorname{card} \mathfrak{S}_{2 n+2}}=2^{n^{2}} \frac{\prod_{i=1}^{n}\left(2^{2 i}-1\right)}{(2 n+2)!}
$$

(see [12, p. 64]). The values of $i_{n}$ grow very rapidly; for low subscripts they are: $i_{2}=1, i_{3}=36, i_{4}=13056, i_{5}=51806208, i_{6}=2387230064640$.
Proof. By Remark $3.2(\mathrm{~b})$ the kernel $\left\langle w_{1}^{4}\right\rangle$ of $\pi: \operatorname{St}\left(C_{n}, \mathbb{Z}\right) \rightarrow \operatorname{Sp}_{2 n}(\mathbb{Z})$ is in the image of $f$. Therefore, in view of the definitions of $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)[2]$ and of $P_{2 n+2}$ it is enough to check that the image of $\bar{f}=\pi \circ f: B_{2 n+2} \rightarrow \mathrm{Sp}_{2 n}(\mathbb{Z})$ satisfies the following two properties: (i) $\bar{f}\left(P_{2 n+2}\right)=\bar{f}\left(P_{2 n+1}\right)=\operatorname{Sp}_{2 n}(\mathbb{Z})[2]$ and (ii) there is an isomorphism $\bar{f}\left(B_{2 n+2}\right) / \operatorname{Sp}_{2 n}(\mathbb{Z})[2] \cong \mathfrak{S}_{2 n+2}$.

As we observed in Part (v) of the proof of Theorem 3.1, the composition $B_{2 n+2} \xrightarrow{\bar{f}} \operatorname{Sp}_{2 n}(\mathbb{Z}) \longrightarrow \operatorname{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$ factors through $\mathfrak{S}_{2 n+2}$. Hence we have the inclusions $\bar{f}\left(P_{2 n+1}\right) \subset \bar{f}\left(P_{2 n+2}\right) \subset \operatorname{Sp}_{2 n}(\mathbb{Z})[2]$.

The induced morphism $\mathfrak{S}_{2 n+2} \rightarrow \mathrm{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$ (which is non-trivial since the image of $\sigma_{1}$ in $\mathrm{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$ is not the identity) is injective since the images of $\sigma_{1}$ and $\sigma_{2}$ do not commute and $\mathfrak{S}_{2 n+2}$ has no non-commutative proper quotient when $n \geq 2$. This implies that Property (ii) above follows from (i). Let us now prove the latter.

In order to establish the opposite inclusion $\bar{f}\left(P_{2 n+1}\right) \supset \mathrm{Sp}_{2 n}(\mathbb{Z})[2]$, it is sufficient to prove $\bar{f}\left(B_{2 n+1}\right) \supset \operatorname{Sp}_{2 n}(\mathbb{Z})[2]$. We appeal to [1]. In loc. cit. A'Campo considers the monodromy representation of $B_{2 n+1}$ in the free $\mathbb{Z}$ module $V$ with basis $\left\{\delta_{i}, i=1, \ldots, 2 n\right\}$, endowed with an alternating form $I$ satisfying $I\left(\delta_{i}, \delta_{i+1}\right)=1$ for $i=1, \ldots, 2 n-1$. This form is non-degenerate. The monodromy representation maps each generator $\sigma_{i}$ of $B_{2 n+1}$ to the automorphism $T_{i}$ of $V$ defined by

$$
T_{i}\left(\delta_{j}\right)= \begin{cases}\delta_{j} & \text { if } j \neq i-1, i+1 \\ \delta_{j}+\delta_{i} & \text { if } j=i-1 \\ \delta_{j}-\delta_{i} & \text { if } j=i+1\end{cases}
$$

One thus obtains a representation of $B_{2 n+1}$ in the symplectic group $\mathrm{Sp}_{2 n}(\mathbb{Z})$.
Now by [1, Th. $1(2)]$ the image of this monodromy representation contains the congruence subgroup $\mathrm{Sp}_{2 n}(\mathbb{Z})[2]$. To conclude, it suffices to check that this representation is isomorphic to our $\bar{f}$. Indeed, If we take

$$
\left\{\delta_{1}, \delta_{1}+\delta_{3}, \ldots, \delta_{1}+\delta_{3}+\cdots+\delta_{2 n-1}, \delta_{2}, \delta_{4}, \ldots, \delta_{2 n}\right\}
$$

as a basis of $V$, the matrix of the form $I$ becomes in $V \cong \mathbb{Z}^{2 n}$ the matrix $J_{2 n}$ considered in $\S 2.1$. One easily checks that in this new basis the matrix of $T_{i}$ is equal to that of $\bar{f}\left(\sigma_{i}\right)$ for $i=1, \ldots, 2 n$.

Remark 4.2. As noted by a referee, Conditions (i)-(ii) above may also be derived from recent results of Bloomquist, Patzt and Scherich (see [7]).

Remark 4.3. The squares of all the generators $x_{i, j}, y_{i, j}, y_{i, j}^{\prime}, z_{i}, z_{i}^{\prime}$ of the Steinberg group $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ lie in the image of $f$, and even in the image of the pure braid group $P_{2 n+2}$ since they are in $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)[2]$.

Remark 4.4. Given a prime $p$, the level $p$ congruence subgroup $\operatorname{Sp}_{2 n}(\mathbb{Z})[p]$ is defined as the kernel of the homomorphism $\operatorname{Sp}_{2 n}(\mathbb{Z}) \rightarrow \operatorname{Sp}_{2 n}\left(\mathbb{F}_{p}\right)$ induced
by reduction modulo $p$. By [15, Prop. 6.7] it is torsion-free when $p \neq 2$. Let $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)[p]$ be the kernel of the composite map $\operatorname{St}\left(C_{n}, \mathbb{Z}\right) \xrightarrow{\pi} \operatorname{Sp}_{2 n}(\mathbb{Z}) \rightarrow$ $\mathrm{Sp}_{2 n}\left(\mathbb{F}_{p}\right)$; it is of finite index in $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$. Now $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)[p]$ is an extension of the torsion-free group $\mathrm{Sp}_{2 n}(\mathbb{Z})[p]$ by the infinite cyclic group $\left\langle w_{1}^{4}\right\rangle$; therefore it is torsion-free as well $(p \neq 2)$. It follows that the Steinberg group $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ is virtually torsion-free, i.e. contains a finite-index torsion-free subgroup.

## 5. The kernel of $f$

In this section we determine the kernels of $\bar{f}: B_{2 n+2} \rightarrow \mathrm{Sp}_{2 n}(\mathbb{Z})$ and of $f: B_{2 n+2} \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)$.
5.1. The elements $\Delta_{k}$ and their images. We start with a few simplelooking elements of the kernel of $f$.

For $k \in\{2, \ldots, 2 n+2\}$ let $\Delta_{k} \in B_{k}$ be the longest reduced positive braid in the group $B_{k}$ of braids with $k$ strands. It is defined inductively by $\Delta_{2}=\sigma_{1}$ and $\Delta_{k+1}=\left(\sigma_{1} \sigma_{2} \cdots \sigma_{k}\right) \Delta_{k}$ for $k \geq 2$. It is well known (see [6] or [19, Sect. 1.3.3]) that its square $\Delta_{k}^{2}$ generates the center of $B_{k}$.

We now consider $\Delta_{k}$ as an element of $B_{2 n+2}$ under the natural inclusion $B_{k} \rightarrow B_{2 n+2}$ sending each generator $\sigma_{i} \in B_{k}(1 \leq i \leq k-1)$ to $\sigma_{i} \in$ $B_{2 n+2}$. We may thus look for the image of $\Delta_{k}$ under the homomorphism $f: B_{2 n+2} \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)$.
Let us first compute the image $f\left(\Delta_{k}^{2}\right)$ of the squares of some of the braids $\Delta_{k}$.
Proposition 5.1. Let $f: B_{2 n+2} \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ be the homomorphism defined in Theorem 3.1. For each $i \in\{1, \ldots, n\}$ we have

$$
f\left(\Delta_{2 i+1}^{2}\right)=\left(w_{1}^{4}\right)^{i(i-1) / 2} \prod_{j=1}^{i} w_{j}^{2} .
$$

Moreover,

$$
f\left(\Delta_{2 n+2}^{2}\right)=\left(w_{1}^{4}\right)^{n(n+1) / 2} .
$$

Remark 5.2. The element $\Delta_{2 n+2}^{2}$ generating the center of $B_{2 n+2}$ belongs to the kernel of $\bar{f}$; it does not belong to the kernel of $f$ since the order of $w_{1}^{4}$ is infinite in the Steinberg group $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ (see [22, Th. 6.3]).

The following consequence of Proposition 5.1 provides us with non-trivial elements of the kernel of $f$.

Corollary 5.3. (a) If $1 \leq i \leq n$, then

$$
f\left(\Delta_{2 i+1}^{4} \Delta_{3}^{-4 i^{2}}\right)=1
$$

(b) We also have

$$
f\left(\Delta_{2 n+2}^{2} \Delta_{3}^{-2 n(n+1)}\right)=1 .
$$

Proof. By Proposition 5.1 and Lemma 2.1 we have $f\left(\Delta_{2 i+1}^{4}\right)=\left(w_{1}^{4}\right)^{i^{2}}$. In the special case $i=1$ we obtain $f\left(\Delta_{3}^{4}\right)=w_{1}^{4}$. Therefore

$$
f\left(\Delta_{2 i+1}^{4}\right)=\left(w_{1}^{4}\right)^{i^{2}}=f\left(\Delta_{3}^{4 i^{2}}\right) .
$$

Similarly, $f\left(\Delta_{2 n+2}^{2}\right)=f\left(\Delta_{3}^{2 n(n+1)}\right)$.
To prove Proposition 5.1 we need two preliminary lemmas.
Lemma 5.4. We have

$$
f\left(\sigma_{1} \sigma_{2} \cdots \sigma_{2 i}\right)= \begin{cases}w_{1} z_{1}^{-1} & \text { if } i=1 \\ \left(\prod_{j=1}^{i} w_{j}\right)\left(x_{1,2} x_{2,3} \cdots x_{i-1, i}\right) z_{i}^{-1} & \text { if } 1<i \leq n\end{cases}
$$

and

$$
f\left(\sigma_{1} \sigma_{2} \cdots \sigma_{2 i+1}\right)= \begin{cases}z_{1} & \text { if } i=0, \\ w_{1} y_{1,2}^{-1} z_{2} & \text { if } i=1, \\ \left(\prod_{j=1}^{i} w_{j}\right)\left(x_{1,2} x_{2,3} \cdots x_{i-1, i}\right) y_{i, i+1}^{-1} z_{i+1} & \text { if } 1<i<n, \\ \left(\prod_{j=1}^{n} w_{j}\right)\left(x_{1,2} x_{2,3} \cdots x_{n-1, n}\right) & \text { if } i=n .\end{cases}
$$

Proof. We proceed by induction on the length $k$ of the braid word $\sigma_{1} \cdots \sigma_{k}$. For $k=1,2$ we have $f\left(\sigma_{1}\right)=z_{1}$ and $f\left(\sigma_{1} \sigma_{2}\right)=z_{1} z_{1}^{\prime-1}=w_{1} z_{1}^{-1}$ by definition of $f$ and of $w_{1}$.

For $k \geq 3$, using the induction and (2.18), we obtain

$$
\begin{aligned}
f\left(\sigma_{1} \cdots \sigma_{2 i}\right) & =f\left(\sigma_{1} \cdots \sigma_{2 i-1}\right) f\left(\sigma_{2 i}\right) \\
& =\left(\prod_{j=1}^{i-1} w_{j}\right)\left(x_{1,2} x_{2,3} \cdots x_{i-2, i-1}\right) y_{i-1, i}^{-1} z_{i} z_{i}^{\prime-1} \\
& =\left(\prod_{j=1}^{i-1} w_{j}\right)\left(x_{1,2} x_{2,3} \cdots x_{i-2, i-1}\right) y_{i-1, i}^{-1} w_{i} z_{i}^{-1} \\
& =\left(\prod_{j=1}^{i-1} w_{j}\right)\left(x_{1,2} x_{2,3} \cdots x_{i-2, i-1}\right) w_{i} x_{i-1, i} z_{i}^{-1} .
\end{aligned}
$$

Observing that $w_{i}$ commutes with the $x_{j, j+1}$ 's to its left, we obtain the desired formula.

To obtain the formula for $f\left(\sigma_{1} \cdots \sigma_{2 i+1}\right)$ it suffices to multiply the formula for $f\left(\sigma_{1} \cdots \sigma_{2 i}\right)$ on the right by $f\left(\sigma_{2 i+1}\right)$ which is equal to $z_{i}^{-1} z_{i} y_{i, i+1}^{-1} z_{i+1}$ if $1<i<n$ and to $z_{n}$ if $i=n$ and to cancel the product $z_{i}^{-1} z_{i}$.

A similar computation yields the following result.
Lemma 5.5. We have

$$
f\left(\sigma_{2 i} \cdots \sigma_{2} \sigma_{1}\right)= \begin{cases}z_{1}^{-1} w_{1} & \text { if } i=1 \\ z_{i}^{\prime-1} z_{i}\left(\prod_{j=1}^{i-1} w_{j}\right)\left(x_{i, i-1} \cdots x_{3,2} x_{2,1}\right) & \text { if } 1<i \leq n\end{cases}
$$

and
$f\left(\sigma_{2 i+1} \cdots \sigma_{2} \sigma_{1}\right)= \begin{cases}z_{i+1}\left(\prod_{j=1}^{i} w_{j}\right)\left(x_{i+1, i} x_{i, i-1} \cdots x_{3,2} x_{2,1}\right) & \text { if } 1 \leq i<n, \\ \left(\prod_{j=1}^{n} w_{j}\right)\left(x_{n, n-1} x_{n-1, n-2} \cdots x_{3,2} x_{2,1}\right) & \text { if } i=n .\end{cases}$

We can now prove Proposition 5.1.

Proof of Proposition 5.1. (a) For the first equality we argue by induction on $i$. For $i=1$ we have $f\left(\Delta_{3}^{2}\right)=f\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{2}=w_{1}^{2}$. The induction formula

$$
\begin{equation*}
\Delta_{k+1}^{2}=\Delta_{k}^{2}\left(\sigma_{k} \sigma_{k-1} \cdots \sigma_{2} \sigma_{1}\right)\left(\sigma_{1} \sigma_{2} \cdots \sigma_{k-1} \sigma_{k}\right) \tag{5.1}
\end{equation*}
$$

allows us to obtain $f\left(\Delta_{2 i+1}^{2}\right)$ from $f\left(\Delta_{2 i-1}^{2}\right)$ by multiplying the latter on the right by $f\left(\sigma_{2 i-1} \cdots \sigma_{1} \sigma_{1} \cdots \sigma_{2 i-1}\right) f\left(\sigma_{2 i} \cdots \sigma_{1} \sigma_{1} \cdots \sigma_{2 i}\right)$.

We first compute $f\left(\sigma_{2 i-1} \cdots \sigma_{1} \sigma_{1} \cdots \sigma_{2 i-1}\right)$. By Lemmas 5.4 and 5.5,

$$
\begin{aligned}
& f\left(\sigma_{2 i-1} \cdots \sigma_{1} \sigma_{1} \cdots \sigma_{2 i-1}\right) \\
= & z_{i}\left(\prod_{j=1}^{i-1} w_{j}\right) x_{i, i-1} x_{i-1, i-2} \cdots x_{3,2} x_{2,1}\left(\prod_{j=1}^{i-1} w_{j}\right) x_{1,2} x_{2,3} \cdots x_{i-2, i-1} y_{i-1, i}^{-1} z_{i}
\end{aligned}
$$

Using (2.18), we have $x_{k+1, k} w_{k} w_{k+1}=w_{k} w_{k+1} x_{k, k+1}^{-1}$ for all $k=1, \ldots, i-1$. These relations allow us to push all the $w_{j}$ 's to the left, yielding

$$
\begin{aligned}
f\left(\sigma_{2 i-1}\right. & \left.\cdots \sigma_{1} \sigma_{1} \cdots \sigma_{2 i-1}\right)= \\
= & z_{i}\left(\prod_{j=1}^{i-2} w_{j}^{2}\right) w_{i-1} x_{i, i-1} w_{i-1} \times \\
& \times\left(x_{i-2, i-1}^{-1} \cdots x_{2,3}^{-1} x_{1,2}^{-1} x_{1,2} x_{2,3} \cdots x_{i-2, i-1}\right) y_{i-1, i}^{-1} z_{i} \\
= & z_{i}\left(\prod_{j=1}^{i-1} w_{j}^{2}\right)\left(y_{i-1, i} y_{i-1, i}^{-1}\right) z_{i}=z_{i}\left(\prod_{j=1}^{i-1} w_{j}^{2}\right) z_{i}=\left(\prod_{j=1}^{i-1} w_{j}^{2}\right) z_{i}^{2}
\end{aligned}
$$

since $z_{i}$ commutes with the other $w_{j}{ }^{\prime}$ s.
In the same way we obtain

$$
\begin{aligned}
& f\left(\sigma_{2 i} \ldots \sigma_{1} \sigma_{1} \ldots \sigma_{2 i}\right)= \\
& \quad=z_{i}^{\prime-1} z_{i}\left(\prod_{j=1}^{i-1} w_{j}\right) x_{i, i-1} \cdots x_{3,2} x_{2,1}\left(\prod_{j=1}^{i} w_{j}\right) x_{1,2} \cdots x_{i-1, i} z_{i}^{-1} \\
& \quad=z_{i}^{\prime-1} z_{i}\left(\prod_{j=1}^{i-1} w_{j}^{2}\right) w_{i}\left(x_{i-1, i}^{-1} \cdots x_{2,3}^{-1} x_{1,2}^{-1} x_{1,2} \cdots x_{i-1, i}\right) z_{i}^{-1} \\
& \quad=z_{i}^{\prime-1} z_{i} z_{i}^{\prime}\left(\prod_{j=1}^{i-1} w_{j}^{2}\right) w_{i}
\end{aligned}
$$

the last equality resulting from (2.15) and the fact that $z_{i}^{\prime}$ commutes with $w_{j}$ when $j \neq i$.

Using the previous calculations, Equation (2.16) and Lemma 2.1, we deduce

$$
\begin{aligned}
f\left(\Delta_{2 i+1}^{2}\right) & =f\left(\Delta_{2 i-1}^{2}\right) f\left(\sigma_{2 i-1} \cdots \sigma_{1} \sigma_{1} \cdots \sigma_{2 i-1}\right) f\left(\sigma_{2 i} \cdots \sigma_{1} \sigma_{1} \cdots \sigma_{2 i}\right) \\
& =f\left(\Delta_{2 i-1}^{2}\right)\left(\prod_{j=1}^{i-1} w_{j}^{2}\right) z_{i}^{2} z_{i}^{\prime-1} z_{i} z_{i}^{\prime}\left(\prod_{j=1}^{i-1} w_{j}^{2}\right) w_{i} \\
& =f\left(\Delta_{2 i-1}^{2}\right)\left(\prod_{j=1}^{i-1} w_{j}^{4}\right) z_{i} w_{i} z_{i}^{\prime} w_{i}=f\left(\Delta_{2 i-1}^{2}\right)\left(\prod_{j=1}^{i-1} w_{j}^{4}\right) z_{i} z_{i}^{-1} w_{i}^{2} \\
& =f\left(\Delta_{2 i-1}^{2}\right)\left(\prod_{j=1}^{i-1} w_{j}^{4}\right) w_{i}^{2}=f\left(\Delta_{2 i-1}^{2}\right) w_{1}^{4(i-1)} w_{i}^{2} .
\end{aligned}
$$

Using the induction hypothesis, we obtain

$$
f\left(\Delta_{2 i+1}^{2}\right)=\left(w_{1}^{4}\right)^{(i-1)(i-2) / 2}\left(\prod_{j=1}^{i-1} w_{j}^{2}\right) w_{1}^{4(i-1)} w_{i}^{2}=\left(w_{1}^{4}\right)^{i(i-1) / 2} \prod_{j=1}^{i} w_{j}^{2},
$$

which is the desired formula.
(b) We now prove the second formula of Proposition 5.1. By Lemmas 5.4 and 5.5 we have

$$
\begin{aligned}
& f\left(\sigma_{2 n+1} \cdots \sigma_{1} \sigma_{1} \cdots \sigma_{2 n+1}\right) \\
& \quad=\left(\prod_{j=1}^{n} w_{i}\right)\left(x_{n, n-1} \cdots x_{2,1}\right)\left(\prod_{j=1}^{n} w_{i}\right)\left(x_{1,2} x_{2,3} \cdots x_{n-1, n}\right) .
\end{aligned}
$$

Pushing the $w_{i}$ 's to the left as above, we obtain

$$
f\left(\sigma_{2 n+1} \cdots \sigma_{1} \sigma_{1} \cdots \sigma_{2 n+1}\right)=\prod_{j=1}^{i=n} w_{j}^{2}
$$

Hence, by the induction formula, the first formula of the proposition for the case $i=n$, and Lemma 2.1 we have

$$
\begin{aligned}
f\left(\Delta_{2 n+2}^{2}\right) & =f\left(\Delta_{2 n+1}^{2}\right) f\left(\sigma_{2 n+1} \cdots \sigma_{1} \sigma_{1} \cdots \sigma_{2 n+1}\right) \\
& =\left(w_{1}^{4}\right)^{n(n-1) / 2}\left(\prod_{j=1}^{n} w_{j}^{2}\right)^{2}=\left(w_{1}^{4}\right)^{n(n-1) / 2} \prod_{j=1}^{n} w_{j}^{4} \\
& =\left(w_{1}^{4}\right)^{n(n-1) / 2}\left(w_{1}^{4}\right)^{n}=\left(w_{1}^{4}\right)^{n(n+1) / 2} .
\end{aligned}
$$

5.2. A special element of the kernel of $f$. Recall from [18] that for $n=2$ the kernel of $f: B_{6} \rightarrow \operatorname{St}\left(C_{2}, \mathbb{Z}\right)$ is the normal closure of the braid

$$
\begin{equation*}
\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{2}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right)\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{-2}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{5}\right) \tag{5.2}
\end{equation*}
$$

We now exhibit a similar element of the kernel of $f: B_{2 n+2} \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ when $n \geq 3$.

For any $n \geq 2$ set

$$
\begin{equation*}
\beta_{n}=\prod_{i=0}^{n} \sigma_{2 i+1}^{(-1)^{i}}=\sigma_{1} \sigma_{3}^{-1} \cdots \sigma_{2 n+1}^{(-1)^{n}} \in B_{2 n+2} \tag{5.3}
\end{equation*}
$$

For $n=2$, the braid $\beta_{2}$ is the element $\sigma_{1} \sigma_{3}^{-1} \sigma_{5}$ appearing in (5.2). Since by Relations (3.1) the odd-numbered generators $\sigma_{2 i+1}$ commute with one another, the product in (5.3) can be taken in any order. Observe also that the square $\beta_{n}^{2}$ of $\beta_{n}$, being the product of squares of generators of the braid group, belongs to the pure braid group $P_{2 n+2}$.

As the $z_{j}$ 's commute with one another and with the $y_{i, i+1}$ 's, for all $n \geq 2$ we obtain

$$
\begin{equation*}
f\left(\beta_{n}\right)=\prod_{i=1}^{n-1} y_{i, i+1}^{(-1)^{i+1}}=y_{1,2} y_{2,3}^{-1} \cdots y_{n-1, n}^{(-1)^{n}} \tag{5.4}
\end{equation*}
$$

Using the elements $\Delta_{k}$ introduced in Section 5.1, we set

$$
\begin{equation*}
\gamma_{n}=\prod_{i=1}^{n-1} \Delta_{2 i+1}^{2}=\Delta_{3}^{2} \Delta_{5}^{2} \cdots \Delta_{2 n-1}^{2} \in B_{2 n+2} \tag{5.5}
\end{equation*}
$$

We have $\gamma_{2}=\Delta_{3}^{2}=\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{2}$. It follows from the centrality of each $\Delta_{k}^{2}$ in the braid group $B_{k}$ that the product defining $\gamma_{n}$ can be taken in any order. Clearly, $\gamma_{n}$ is a pure braid for all $n \geq 2$. Actually, $\gamma_{n} \in P_{2 n-1} \subset P_{2 n+2}$.

By analogy with (5.2) we consider the element

$$
\begin{equation*}
\alpha_{n}=\gamma_{n} \beta_{n} \gamma_{n}^{-1} \beta_{n} \in B_{2 n+2} \tag{5.6}
\end{equation*}
$$

Note that $\alpha_{n}$ belongs to the pure braid group $P_{2 n+2}$ as it can be expressed as the product $\alpha_{n}=\gamma_{n}\left(\beta_{n} \gamma_{n}^{-1} \beta_{n}^{-1}\right) \beta_{n}^{2}$ of pure braids. Moreover, $\alpha_{n}$ is nontrivial since it is the product of $\left(\sigma_{2 n+1}^{2}\right)^{(-1)^{n}}$ with an element of $B_{2 n}$. Clearly, $\alpha_{2}$ is the braid appearing in (5.2).

Proposition 5.6. For all $n \geq 2$ we have $f\left(\alpha_{n}\right)=1$ in the Steinberg group $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$.

Proof. Since the conjugation by the central element $w_{1}^{4}$ is trivial, it follows from Proposition 5.1 that the conjugation by $f\left(\Delta_{2 i+1}^{2}\right)$ is equal to the conjugation by $w_{1}^{2} w_{2}^{2} \cdots w_{i}^{2}$. Therefore, the conjugation by $f\left(\gamma_{n}\right)$ is equal to the conjugation by $\prod_{k=1}^{n-1} w_{k}^{2(n-k)}$. In the previous product we may omit each factor whose exponent $2(n-k)$ is divisible by 4 . Thus the conjugation by $f\left(\gamma_{n}\right)$ is equal to the conjugation by $w_{n-1}^{2} w_{n-3}^{2} w_{n-5}^{2} \cdots$. Now the conjugation by $w_{n-2 k+1}^{2}$ is non-trivial only on the factors $y_{n-2 k, n-2 k+1}$ and $y_{n-2 k+1, n-2 k+2}$ of $f\left(\beta_{n}\right)$ and turns each of them into its inverse. Therefore, $f\left(\gamma_{n}\right) f\left(\beta_{n}\right) f\left(\gamma_{n}\right)^{-1}=f\left(\beta_{n}\right)^{-1}$, from which one deduces the desired result.

Question 5.7. Is there a geometric interpretation for the braid $\alpha_{n} \in B_{2 n+2}$, for instance in terms of Dehn twists?
5.3. The kernels of $\bar{f}$ and of $f$. We now state our main result on these kernels.

In case $n=2$ the kernel $\operatorname{Ker}(f)$ is the normal closure of $\alpha_{2}$ and $\operatorname{Ker}(\bar{f})$ is the normal closure of $\alpha_{2}$ and $\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{4}=\left(\sigma_{1} \sigma_{2}\right)^{6}=\Delta_{3}^{4}$ (see [18, Th. 4.1 and Cor. 4.2]).

We now turn to the general case. Note that by Part (v) of the proof of Theorem 3.1, the kernel of $\bar{f}$, hence also the kernel of $f$, is contained in the pure braid group $P_{2 n+2}$.
Theorem 5.8. Assume $n \geq 3$.
(a) The kernel of $\bar{f}: B_{2 n+2} \rightarrow \mathrm{Sp}_{2 n}(\mathbb{Z})$ is the normal closure of the set consisting of the three braids $\Delta_{3}^{4}, \Delta_{5}^{4}$ and $\alpha_{n}$.
(b) The kernel of $f: B_{2 n+2} \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ is the normal closure of the set consisting of the commutator $\left[\sigma_{3}, \Delta_{3}^{4}\right]$ and of the elements $\Delta_{5}^{4} \Delta_{3}^{-16}$ and $\alpha_{n}$.

As a consequence, the finite-index subgroup $\bar{f}\left(B_{2 n+2}\right)$ of $\mathrm{Sp}_{2 n}(\mathbb{Z})$ has a presentation with $2 n+1$ generators $\sigma_{1}, \sigma_{2}, \ldots, \sigma_{2 n+1}$ subject to the braid relations (3.1), (3.2) and the three additional relations

$$
\begin{equation*}
\Delta_{3}^{4}=\Delta_{5}^{4}=\alpha_{n}=1 \tag{5.7}
\end{equation*}
$$

Similarly, $f\left(B_{2 n+2}\right)$ has a presentation with the same generators subject to the braid relations and the relations $\left[\sigma_{3}, \Delta_{3}^{4}\right]=\Delta_{5}^{4} \Delta_{3}^{-16}=\alpha_{n}=1$.
Proof. (a) As we observed in the proof of Theorem 4.1, the restriction of $\bar{f}$ to the subgroup $B_{2 n+1}$ of $B_{2 n+2}$ is the monodromy representation considered in [1]. The kernel of this restriction is the hyperelliptic Torelli group $\mathcal{S I}_{n}^{1}$ investigated in [10]. In loc. cit. Brendle, Margalit, Putman prove that $\mathcal{S I}_{n}^{1}$ is isomorphic to a subgroup $\mathcal{B I}_{2 n+1}$ of the mapping class group of the disk with $2 n+1$ marked points. By Theorem C of [10] and the comments thereafter the subgroup $\mathcal{B I}_{2 n+1}$ is generated by squares of Dehn twists about curves in the disk surrounding exactly 3 or 5 marked points. Now under the standard identification of the mapping class group with the braid group $B_{2 n+1}$ (see e.g. [19, §1.6]), the square of a Dehn twist about a curve surrounding 3 (resp. 5) marked points corresponds in the braid group to a conjugate of the element $\Delta_{3}^{4}$ (resp. of $\Delta_{5}^{4}$ ). Thus, $\operatorname{Ker}(\bar{f}) \cap B_{2 n+1}=\operatorname{Ker}(\bar{f}) \cap P_{2 n+1}$ is the normal closure of $\Delta_{3}^{4}$ and $\Delta_{5}^{4}$.

To determine the whole kernel inside $P_{2 n+2}$, we use the fact that $P_{2 n+2}$ is the semi-direct product of a normal free group and of $P_{2 n+1}$ (see [19, §1.3]). This free group has $2 n+1$ generators $A_{i, 2 n+2}(i=1, \ldots, 2 n+1)$ defined by $A_{2 n+1,2 n+2}=\sigma_{2 n+1}^{2}$ and

$$
\begin{equation*}
A_{i, 2 n+2}=\left(\sigma_{2 n+1} \sigma_{2 n} \cdots \sigma_{i+1}\right) \sigma_{i}^{2}\left(\sigma_{2 n+1} \sigma_{2 n} \cdots \sigma_{i+1}\right)^{-1} \tag{5.8}
\end{equation*}
$$

when $1 \leq i \leq 2 n$. The following expression for $A_{i, 2 n+2}$ will be used in the sequel:
(5.9) $\quad A_{i, 2 n+2}=\left(\sigma_{2 n} \sigma_{2 n-1} \cdots \sigma_{i}\right)^{-1} \sigma_{2 n+1}^{2}\left(\sigma_{2 n} \sigma_{2 n-1} \cdots \sigma_{i}\right) . \quad(1 \leq i \leq 2 n)$

To derive (5.9) from (5.8) use the braid relations or draw a picture.
Recall the special element $\alpha_{n}=\gamma_{n} \beta_{n} \gamma_{n}^{-1} \beta_{n}$ given by (5.6). The element $\gamma_{n}$ belongs to $P_{2 n}$ and $\beta_{n}$ to $B_{2 n} \sigma_{2 n+1}^{ \pm 1}$. Since $\sigma_{2 n+1}$ commutes with $B_{2 n}$ we have $\alpha_{n} \in B_{2 n} \sigma_{2 n+1}^{ \pm 2} \cap P_{2 n+2}=P_{2 n} \sigma_{2 n+1}^{ \pm 2}$. Consequently, $A_{2 n+1,2 n+2}=\sigma_{2 n+1}^{2}$ belongs to $P_{2 n} \alpha_{n}^{ \pm 1}$.

Let us deal with $A_{i, 2 n+2}$ when $1 \leq i \leq 2 n$. Since $\sigma_{2 n} \sigma_{2 n-1} \cdots \sigma_{i}$ belongs to $B_{2 n+1}$, we see from (5.9) and what we established for $\sigma_{2 n+1}^{2}$ that $A_{i, 2 n+2}$ is conjugate under $B_{2 n+1}$ of an element of $P_{2 n} \alpha_{n}$ or of $P_{2 n} \alpha_{n}^{-1}$.

So, at the cost of adding $\alpha_{n}$, we have reduced $\operatorname{Ker}(\bar{f})$ to its intersection with $P_{2 n+1}$. In view of the above considerations, this completes the proof of Part (a).
(b) Let $N$ be the normal closure of $\left[\sigma_{3}, \Delta_{3}^{4}\right], \Delta_{5}^{4} \Delta_{3}^{-16}$ and $\alpha_{n}$. We have $N \subset \operatorname{Ker}(f)$ : this follows from the centrality of $f\left(\Delta_{3}^{4}\right)=w_{1}^{4}$, from Corollary 5.3 (a) applied to $i=2$, and from Proposition 5.6.

Let us next remark that $N$ contains the commutator $\left[\beta, \Delta_{3}^{4}\right]$ for each braid $\beta$. Indeed, since $\Delta_{3}^{4}$ is a product of $\sigma_{1}$ and $\sigma_{2}$, it commutes with all generators $\sigma_{i}$ and their inverses with $4 \leq i \leq 2 n+1$. On the other hand $\Delta_{3}^{4}$ is central in $B_{3}$; therefore it commutes with $\sigma_{1}$ and $\sigma_{2}$ and their inverses. Since by definition $N$ contains $\left[\sigma_{3}, \Delta_{3}^{4}\right]$ and we have $\left[\sigma_{3}^{-1}, \Delta_{3}^{4}\right]=\sigma_{3}^{-1}\left[\sigma_{3}, \Delta_{3}^{4}\right]^{-1} \sigma_{3}$, it contains all commutators of the form $\left[\sigma_{i}^{ \pm 1}, \Delta_{3}^{4}\right]$. Using the commutator identities

$$
\left[\beta_{1} \beta_{2}, \Delta_{3}^{4}\right]=\beta_{1}\left[\beta_{2}, \Delta_{3}^{4}\right] \beta_{1}^{-1}\left[\beta_{1}, \Delta_{3}^{4}\right]
$$

for $\beta_{1}, \beta_{2} \in B_{2 n+2}$, we conclude by induction on the length of expression of a braid in the generators $\sigma_{i}^{ \pm 1}$.

The kernels of $f$ and of $\bar{f}$ are connected by the short exact sequence

$$
\begin{equation*}
1 \rightarrow \operatorname{Ker}(f) \longrightarrow \operatorname{Ker}(\bar{f}) \xrightarrow{f}\left\langle w_{1}^{4}\right\rangle \rightarrow 1 . \tag{5.10}
\end{equation*}
$$

Indeed, clearly $\operatorname{Ker}(f)$ sits inside $\operatorname{Ker}(\bar{f})$ as a normal subgroup. If $\bar{f}(\beta)=1$, then $f(\beta)$ belongs to the kernel of $\pi: \operatorname{St}\left(C_{n}, \mathbb{Z}\right) \rightarrow \operatorname{Sp}_{2 n}(\mathbb{Z})$, which we know to be infinite cyclic generated by $w_{1}^{4}$. The homomorphism $f: \operatorname{Ker}(\bar{f}) \rightarrow\left\langle w_{1}^{4}\right\rangle$ is surjective since $w_{1}^{4}=f\left(\Delta_{3}^{4}\right)$ and $\bar{f}\left(\Delta_{3}^{4}\right)=1$. Moreover, since $\left\langle w_{1}^{4}\right\rangle \cong \mathbb{Z}$, the short exact sequence (5.10) is split with splitting $\left\langle w_{1}^{4}\right\rangle \rightarrow \operatorname{Ker}(\bar{f})$ given by $w_{1}^{4} \mapsto \Delta_{3}^{4}$.

The short exact sequence (5.10) induces the quotient short exact sequence

$$
1 \rightarrow \operatorname{Ker}(f) / N \longrightarrow \operatorname{Ker}(\bar{f}) / N \xrightarrow{f}\left\langle w_{1}^{4}\right\rangle \rightarrow 1 .
$$

To conclude that $\operatorname{Ker}(f)=N$, it suffices to check that $f: \operatorname{Ker}(\bar{f}) / N \rightarrow\left\langle w_{1}^{4}\right\rangle$ is injective.

Now, by Part (a) each element of $\operatorname{Ker}(\bar{f})$ is a product of conjugates of the braids $\Delta_{3}^{4}, \Delta_{5}^{4}, \alpha_{n}$ and their inverses. Since $\alpha_{n} \equiv 1$ and $\Delta_{5}^{4} \equiv\left(\Delta_{3}^{4}\right)^{4}$ modulo $N$, each element of $\operatorname{Ker}(\bar{f})$ is equal modulo $N$ to a product of conjugates of $\Delta_{3}^{4}$ and of its inverse. Since $\left[\beta, \Delta_{3}^{4}\right] \in N$ for any braid $\beta$, we have $\beta \Delta_{3}^{4} \beta^{-1} \equiv \Delta_{3}^{4}$ modulo $N$. Hence, $\operatorname{Ker}(\bar{f}) / N$ is generated by $\Delta_{3}^{4} \bmod N$. The image of $\Delta_{3}^{4}$ being $w_{1}^{4}$, the morphism $f: \operatorname{Ker}(\bar{f}) / N \rightarrow\left\langle w_{1}^{4}\right\rangle$ is an isomorphism.

Remark 5.9. As Benjamin Enriquez pointed out to us for $n=2$, the element $\alpha_{2}$ can be rewritten as $\alpha_{2}=\Delta_{3}^{4} \Delta_{4}^{-2} \sigma_{5}^{2}$. For $n \geq 3$ let us consider the element

$$
\alpha_{n}^{\prime}=\Delta_{3}^{2 n(n-1)} \Delta_{2 n}^{-2} \sigma_{2 n+1}^{2} \in B_{2 n+2}
$$

Using the computations of Section 5.1, it is easy to check that $\alpha_{n}^{\prime}$ belongs to the kernel of $f$. By its very definition $\alpha_{n}^{\prime}$ is in $P_{2 n} \sigma_{2 n+1}^{ \pm 2}$, which is an additional feature it shares with $\alpha_{n}$. Reasoning as in the previous proof, we
deduce that Theorem 5.8 also holds with $\alpha_{n}^{\prime}$ instead of $\alpha_{n}$. Accordingly, the relation $\alpha_{n}=1$ of (5.7) can be replaced by the relation $\sigma_{2 n+1}^{2}=\Delta_{2 n}^{2}$.
5.4. Restriction to $B_{2 n+1}$. We conclude this section with a result which ${ }^{\text {will }}$ be used in Section 6.2. We denote by $f_{2 n+1}: B_{2 n+1} \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ (resp. $\left.\bar{f}_{2 n+1}: B_{2 n+1} \rightarrow \mathrm{Sp}_{2 n}(\mathbb{Z})\right)$ the restriction of $f$ (resp. of $\left.\bar{f}\right)$ to $B_{2 n+1}$.
Proposition 5.10. The kernel of $f_{2 n+1}: B_{2 n+1} \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ is the normal closure of $\left[\sigma_{3}, \Delta_{3}^{4}\right]$ and $\Delta_{5}^{4} \Delta_{3}^{-16}$.
Proof. The normal closure $N^{\prime}$ of the proposition sits inside $\operatorname{Ker} f_{2 n+1}$. By [10] any element of $\operatorname{Ker} \bar{f}_{2 n+1}$ is a product of conjugates of $\Delta_{3}^{ \pm 4}$ and $\Delta_{5}^{ \pm 4}$. We have $\Delta_{5}^{4} \equiv \Delta_{3}^{16}$ modulo $N^{\prime}$. Reasoning as in the proof of Theorem 5.8 (b), we conclude that $\Delta_{3}^{4}$ is central modulo $N^{\prime}$. As above, there is a short exact sequence

$$
1 \rightarrow \operatorname{Ker} f_{2 n+1} \longrightarrow \operatorname{Ker}\left(\bar{f}_{2 n+1}\right) \longrightarrow\left\langle w_{1}^{4}\right\rangle \rightarrow 1
$$

The induced quotient short exact sequence is

$$
1 \rightarrow \operatorname{Ker} f_{2 n+1} / N^{\prime} \longrightarrow \operatorname{Ker}\left(\bar{f}_{2 n+1}\right) / N^{\prime} \longrightarrow\left\langle w_{1}^{4}\right\rangle \rightarrow 1 .
$$

As in the proof of Theorem $5.8(\mathrm{~b})$, the map onto $\left\langle w_{1}^{4}\right\rangle$ is bijective and we deduce that the kernel of $f_{2 n+1}$ is $N^{\prime}$.

## 6. Extending $f$ to an epimorphism

By Theorem 3.1 the homomorphism $f: B_{2 n+2} \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ is not surjective when $n \geq 3$. We shall now extend $f$ to a surjective homomorphism $\widehat{f}: \widehat{B}_{2 n+2} \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)$, which we define in the following subsection. Let us assume that $n$ is a fixed integer $\geq 3$.
6.1. The Artin groups $\widehat{B}_{k}$. For $k \geq 5$ let $\Gamma_{k}$ be the graph with $k$ vertices labeled $0,1, \ldots, k-1$ and with unique edges between the vertices labeled $i$ and $i+1$ for $i \in\{1, \ldots, k-2\}$ plus a unique edge between the vertices labeled 0 and 4.


Let $\widehat{B}_{k}$ be the Artin group (also called Artin-Tits group or generalized braid group) associated with the graph $\Gamma_{k}$; see [11, 13] or [19, Sect. 6.6]. It has a presentation with generators $\sigma_{0}, \sigma_{1}, \ldots, \sigma_{k-1}$ and with the standard braid relations (3.1) and (3.2) between $\sigma_{1}, \ldots, \sigma_{k-1}$ together with the following additional relations involving the generator $\sigma_{0}$ :

$$
\begin{equation*}
\sigma_{0} \sigma_{4} \sigma_{0}=\sigma_{4} \sigma_{0} \sigma_{4} \quad \text { and } \quad \sigma_{0} \sigma_{i}=\sigma_{i} \sigma_{0} \quad(i \neq 4) . \tag{6.1}
\end{equation*}
$$

The corresponding Coxeter groups are infinite unless $5 \leq k \leq 7$. They are finite of type $A_{5}$ if $k=5$, of type $D_{6}$ if $k=6$, and of type $E_{7}$ if $k=7$ (it is affine of type $\widetilde{E}_{7}$ if $k=8$ ).

In the same way as there are natural homomorphisms $B_{k} \rightarrow B_{k+1}$, there are natural (injective) homomorphisms $\widehat{B}_{k} \rightarrow \widehat{B}_{k+1}$ and $j: B_{k} \rightarrow \widehat{B}_{k}$. The latter is defined by $j\left(\sigma_{i}\right)=\sigma_{i}$ for all $i \in\{1, \ldots, k-1\}$.

Here is the reason why we introduce the Artin groups $\widehat{B}_{k}$.

Theorem 6.1. There exists a unique homomorphism $\widehat{f}: \widehat{B}_{2 n+2} \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ such that $\widehat{f}\left(\sigma_{0}\right)=z_{2}$ and $\widehat{f}\left(\sigma_{i}\right)=f\left(\sigma_{i}\right)$ for all $i=1, \ldots, 2 n+1$. The restriction of the homomorphism $\widehat{f}$ to $\widehat{B}_{2 n+1}$ is surjective.

Consequently, the homomorphism $\widehat{f}: \widehat{B}_{2 n+2} \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ is surjective as well. It extends the non-surjective homomorphism $f: B_{2 n+2} \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ in the sense that $f=\widehat{f} \circ j$.

Proof. (a) Let us first check that $\widehat{f}$ is well-defined. Since it extends $f$, we have only to deal with the relations (6.1) involving the additional generator $\sigma_{0}$. Now $\widehat{f}\left(\sigma_{0}\right)$ commutes with $\widehat{f}\left(\sigma_{i}\right)=f\left(\sigma_{i}\right)$ for all $i \neq 4$ in view of the defining relations of the Steinberg group (see Section 2.2). The image under $\widehat{f}$ of the relation $\sigma_{0} \sigma_{4} \sigma_{0}=\sigma_{4} \sigma_{0} \sigma_{4}$ in (6.1) is equivalent to $z_{2} z_{2}^{\prime-1} z_{2}=z_{2}^{\prime-1} z_{2} z_{2}^{\prime-1}$, which holds in $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$, as explained in the proof of Theorem 3.1.
(b) By definition of $\widehat{f}$ it suffices to establish that the image $f\left(B_{2 n+1}\right)$ of $f$ together with $z_{2}$ generates the Steinberg group $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$.

To this end, it is sufficient to prove that the images of $\bar{f}\left(B_{2 n+1}\right)$ and $z_{2}$ in $\mathrm{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$ generate the latter finite group. Indeed, by Theorem 4.1 the subgroup $H$ of $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ generated by $f\left(B_{2 n+1}\right)$ and $z_{2}$ contains the kernel $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)[2]$ of the surjective morphism $\operatorname{St}\left(C_{n}, \mathbb{Z}\right) \xrightarrow{\pi} \operatorname{Sp}_{2 n}(\mathbb{Z}) \rightarrow \operatorname{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$. Hence, if the image of $H$ is the whole group $\operatorname{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$, we obtain the equality $H=\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$.

Let us denote the images in $\operatorname{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$ of the generators $x_{i, j}, y_{i, j}, y_{i, j}^{\prime}, z_{i}$, $z_{i}^{\prime}$ of $\operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ by $\bar{x}_{i, j}, \bar{y}_{i, j}, \bar{y}_{i, j}^{\prime}, \bar{z}_{i}, \bar{z}_{i}^{\prime}$ respectively. Note that the latter generate $\operatorname{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$ and that each of them is of order 2 , hence equal to its inverse.

Define $E_{n}$ to be the set of the images of $\left\{\bar{f}\left(\sigma_{1}\right), \bar{f}\left(\sigma_{2}\right), \ldots, \bar{f}\left(\sigma_{2 n}\right)\right\}$ in $\operatorname{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$. We have

$$
E_{n}=\left\{\bar{z}_{1}, \bar{z}_{1}^{\prime}, \bar{z}_{1} \bar{z}_{2} \bar{y}_{1,2}, \bar{z}_{2}^{\prime}, \bar{z}_{2} \bar{z}_{3} \bar{y}_{2,3}, \bar{z}_{3}^{\prime}, \ldots, \bar{z}_{n}^{\prime}\right\}
$$

In order to prove Theorem 6.1, it is sufficient to check that $E_{n} \cup\left\{\bar{z}_{2}\right\}$ generates $\mathrm{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$. We will establish this assertion by induction on $n$.

Note that the assertion holds for $n=2$ : indeed, $z_{2}=\bar{f}\left(\sigma_{5}\right)$ so that the set $E_{2} \cup\left\{\bar{z}_{2}\right\}$ generates the image of $\bar{f}$, which by the surjectivity result of Theorem 3.1 is equal to the whole group $\operatorname{Sp}_{4}\left(\mathbb{F}_{2}\right)$.

We now prove the assertion for $n=3$.
Lemma 6.2. The set $E_{3} \cup\left\{\bar{z}_{2}\right\}$ generates $\operatorname{Sp}_{6}\left(\mathbb{F}_{2}\right)$.
Proof. Let $G_{3}$ be the subgroup of $\operatorname{Sp}_{6}\left(\mathbb{F}_{2}\right)$ generated by

$$
E_{3} \cup\left\{\bar{z}_{2}\right\}=\left\{\bar{z}_{1}, \bar{z}_{1}^{\prime}, \bar{z}_{1} \bar{z}_{2} \bar{y}_{1,2}, \bar{z}_{2}^{\prime}, \bar{z}_{2} \bar{z}_{3} \bar{y}_{2,3}, \bar{z}_{3}^{\prime}, \bar{z}_{2}\right\} .
$$

Obviously, $G_{3}$ contains $\bar{y}_{1,2}$ and $\bar{z}_{3} \bar{y}_{2,3}$. We have the following relations deduced from Equations (2.2), (2.3), (2.8) and (2.10):

$$
\begin{gathered}
{\left[\bar{y}_{1,2}, \bar{z}_{2}^{\prime}\right]=\bar{x}_{1,2} \bar{z}_{1}, \quad \text { whence } \bar{x}_{1,2} \in G_{3} ;} \\
{\left[\bar{x}_{1,2}, \bar{z}_{3} \bar{y}_{2,3}\right]=\left[\bar{x}_{1,2}, \bar{y}_{2,3}\right]=\bar{y}_{1,3}, \quad \text { whence } \bar{y}_{1,3} \in G_{3} ;} \\
{\left[\bar{y}_{1,3}, \bar{z}_{1}^{\prime}\right]=\bar{x}_{3,1} \bar{z}_{3}, \quad \text { whence } \bar{x}_{3,1} \bar{z}_{3} \in G_{3} ;} \\
{\left[\bar{y}_{1,2}, \bar{z}_{1}^{\prime}\right]=\bar{x}_{2,1} \bar{z}_{2}, \quad \text { whence } \bar{x}_{2,1} \in G_{3} ;}
\end{gathered}
$$

$$
\begin{gathered}
{\left[\bar{y}_{1,3}, \bar{z}_{3}^{\prime}\right]=\bar{x}_{1,3} \bar{z}_{1}, \quad \text { whence } \bar{x}_{1,3} \in G_{3} ;} \\
{\left[\bar{x}_{3,1} \bar{z}_{3}, \bar{x}_{1,2}\right]=\left[\bar{x}_{3,1}, \bar{x}_{1,2}\right]=\bar{x}_{3,2}, \quad \text { whence } \bar{x}_{3,2} \in G_{3} ;} \\
{\left[\bar{x}_{3,2}, \bar{x}_{2,1}\right]=\bar{x}_{3,1}, \quad \text { whence } \bar{x}_{3,1} \in G_{3}}
\end{gathered}
$$

Since $\bar{x}_{3,1}$ and $\bar{x}_{3,1} \bar{z}_{3}$ belong to $G_{3}$, so does $\bar{z}_{3}$. Now we know that all $\bar{y}_{i, j}, \bar{z}_{i}$ and $\bar{z}_{i}^{\prime}$ with $i, j \in\{1,2,3\}$ and $i \neq j$ belong to $G_{3}$. As follows from a remark in Section 2.2, these elements generate the whole group $\mathrm{Sp}_{6}\left(\mathbb{F}_{2}\right)$.

We resume Part (b) of the proof of Theorem 6.1. Assume that the assertion above holds for $n \geq 3$ and let us prove it for $n+1$.

Let $G_{n+1}$ be the subgroup of $\operatorname{Sp}_{2 n+2}\left(\mathbb{F}_{2}\right)$ generated by $E_{n+1} \cup\left\{\bar{z}_{2}\right\}$. By the induction hypothesis, since $E_{n}$ is a subset of $E_{n+1}$, the group $G_{n+1}$ contains $\mathrm{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$, viewed as the group of matrices in $\mathrm{Sp}_{2 n+2}\left(\mathbb{F}_{2}\right)$ with entries equal to 0 for the indices $(i, n+1)$ and $(n+1, i)$ with $i \neq n+1$ and for the indices $(i, 2 n+2)$ and $(2 n+2, i)$ with $i \neq 2 n+2$. In particular, $G_{n+1}$ contains $\bar{z}_{3}$ by Lemma 6.2.

Now consider the subgroup of $G_{n+1}$ generated by

$$
\left\{\bar{z}_{2}, \bar{z}_{2}^{\prime}, \bar{z}_{2} \bar{z}_{3} \bar{y}_{2,3}, \bar{z}_{3}^{\prime}, \bar{z}_{3} \bar{z}_{4} \bar{y}_{3,4}, \bar{z}_{4}^{\prime}, \ldots, \bar{z}_{n+1}^{\prime}\right\} \cup\left\{\bar{z}_{3}\right\} .
$$

Since $\bar{z}_{3} \in G_{n+1}$, this subgroup is a subgroup of $G_{n+1}$.
By the induction hypothesis applied to all subscripts increased by 1, this subgroup is isomorphic to the symplectic group $\operatorname{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$, now viewed as the group of matrices in $\operatorname{Sp}_{2 n+2}\left(\mathbb{F}_{2}\right)$ with entries equal to 0 for the indices $(i, 1)$ and $(1, i)$ with $i \neq 1$ and for the indices $(i, n+2)$ and $(n+2, i)$ with $i \neq n+2$.

It follows that all generators $\bar{x}_{i, j}, \bar{y}_{i, j}, \bar{y}_{i, j}^{\prime}, \bar{z}_{i}, \bar{z}_{i}^{\prime}$ of $\operatorname{Sp}_{2 n+2}\left(\mathbb{F}_{2}\right)$ belong to $G_{n+1}$, except possibly $\bar{x}_{1, n+1}, \bar{x}_{n+1,1}, \bar{y}_{1, n+1}$ and $\bar{y}_{1, n+1}^{\prime}$. But the latter also belong to $G_{n+1}$ in view of the commutator relations

$$
\begin{aligned}
& {\left[\bar{x}_{1, n}, \bar{x}_{n, n+1}\right]=\bar{x}_{1, n+1}, \quad\left[\bar{x}_{n+1, n}, \bar{x}_{n, 1}\right]=\bar{x}_{n+1,1},} \\
& {\left[\bar{x}_{1, n}, \bar{y}_{n, n+1}\right]=\bar{y}_{1, n+1}, \quad\left[\bar{x}_{n, 1}, \bar{y}_{n, n+1}^{\prime}\right]=\bar{y}_{1, n+1}^{\prime},}
\end{aligned}
$$

which follow from Relations (2.2)-(2.4).
6.2. Elements of the kernel of $\widehat{f}$. Let $\widehat{f}_{2 n+1}: \widehat{B}_{2 n+1} \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ be the restriction of $\widehat{f}$ to $\widehat{B}_{2 n+1}$. Recall the restrictions $f_{2 n+1}: B_{2 n+1} \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ and $\bar{f}_{2 n+1}: B_{2 n+1} \rightarrow \operatorname{Sp}_{2 n}(\mathbb{Z})$ defined in Section 5.4.

We consider the element

$$
\begin{equation*}
\alpha_{0}=\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{2}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{0}\right)\left(\sigma_{1} \sigma_{2} \sigma_{1}\right)^{-2}\left(\sigma_{1} \sigma_{3}^{-1} \sigma_{0}\right) \tag{6.2}
\end{equation*}
$$

of the Artin group $\widehat{B}_{2 n+1}$ of type $\Gamma_{2 n+1}$. This element lies in the kernel of $\widehat{f}_{2 n+1}$ since $\widehat{f}_{2 n+1}\left(\alpha_{0}\right)=w_{1}^{2} y_{1,2} w_{1}^{-2} y_{1,2}=y_{1,2}^{-2} y_{1,2}=1$.

Note that mapping $\sigma_{0}$ to $\sigma_{5}$ and $\sigma_{i}$ to $\sigma_{i}$ for $i=1, \ldots, 4$, we obtain an isomorphism $j$ from the subgroup $\widehat{B}_{5}$ of $\widehat{B}_{2 n+1}$ generated by $\left\{\sigma_{1}, \sigma_{2}, \sigma_{3}, \sigma_{4}, \sigma_{0}\right\}$ to the standard braid group $B_{6}$. The composed morphism

$$
\left\langle\sigma_{1}, \sigma_{2}, \sigma_{3}, \sigma_{4}, \sigma_{0}\right\rangle \xrightarrow{j} B_{6} \xrightarrow{f} \operatorname{St}\left(C_{2}, \mathbb{Z}\right)
$$

is equal to the restriction of $\widehat{f}_{2 n+1}$ and $j$ maps $\alpha_{0}$ to $\alpha_{2}$, which by Theorem 5.6 lies in the kernel of $f: B_{6} \rightarrow \operatorname{St}\left(C_{2}, \mathbb{Z}\right)$. We thus recover the fact that $\alpha_{0}$ belongs to $\operatorname{Ker}\left(\widehat{f}_{2 n+1}\right)$.

Theorem 6.3. The kernel of the restriction of $\widehat{f}_{2 n+1}$ to the pure Artin group $\widehat{P}_{2 n+1}$ of type $\Gamma_{2 n+1}$ is the normal closure of $\alpha_{0},\left[\sigma_{3}, \Delta_{3}^{4}\right]$ and $\Delta_{5}^{4} \Delta_{3}^{-16}$ in $\widehat{B}_{2 n+1}$.

Proof. It follows from Proposition 5.10 that

$$
\operatorname{Ker}\left(\widehat{f}_{2 n+1}\right) \cap P_{2 n+1}=\operatorname{Ker}\left(f_{2 n+1}\right) \cap P_{2 n+1}
$$

is the normal closure of $\left[\sigma_{3}, \Delta_{3}^{4}\right]$ and $\Delta_{5}^{4} \Delta_{3}^{-16}$ in $B_{2 n+1}$.
To determine the kernel in $\widehat{P}_{2 n+1}$ we apply [14, Corollary 8] (and its proof). This result states that if $\Gamma$ is a Coxeter graph and $i$ a vertex of $\Gamma$, the pure Artin group of type $\Gamma$ is the semi-direct product of a normal subgroup generated by conjugates of the squares $\sigma_{j}^{2}$ with $j \in \Gamma$ and of the pure Artin group of type $\Gamma \backslash\{i\}$.

We apply this to $\Gamma=\Gamma_{k}$ and $i=0$. All generators $\sigma_{j}$ are conjugate in $\widehat{B}_{2 n+1}$; in particular their squares are conjugate to $\sigma_{0}^{2}$. Consequently, $\widehat{P}_{2 n+1}$ is the semi-direct product of a normal subgroup generated by elements conjugate to $\sigma_{0}^{2}$ in $\widehat{B}_{2 n+1}$ and of $P_{2 n+1}$. Since $\alpha_{0}$ lies in $P_{4} \sigma_{0}^{2} \subset P_{2 n+1} \sigma_{0}^{2}$ (see the proof of Theorem 5.8) and $\alpha_{0} \in \operatorname{Ker} \widehat{f}_{2 n+1}$, we deduce the theorem.

Remark 6.4. By Theorem 6.1 the morphism $\widehat{f}_{2 n+1}: \widehat{B}_{2 n+1} \rightarrow \operatorname{St}\left(C_{n}, \mathbb{Z}\right)$ is surjective. Composing it with the natural surjections $\operatorname{St}\left(C_{n}, \mathbb{Z}\right) \rightarrow \mathrm{Sp}_{2 n}(\mathbb{Z}) \rightarrow$ $\mathrm{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$, we obtain a surjective morphism $\widehat{B}_{2 n+1} \rightarrow \mathrm{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$. The latter epimorphism factors through $W\left(\Gamma_{2 n+1}\right) \rightarrow \operatorname{Sp}_{2 n}\left(\mathbb{F}_{2}\right)$, where $W\left(\Gamma_{2 n+1}\right)$ is the Coxeter group associated with the graph $\Gamma_{2 n+1}$, since the image of each generator $\sigma_{i}$ has order 2 for $i=0, \ldots, 2 n$.

Remark 6.5. We can say a little more about the kernel of $\widehat{f}_{2 n+1}$ when $n=3$. In this case the Coxeter group $W\left(\Gamma_{7}\right)$ is of type $E_{7}$ and its center has order 2. Let $w_{0}$ be its non-trivial central element. Since the center of $\operatorname{Sp}_{6}\left(\mathbb{F}_{2}\right)$ is trivial, the element $w_{0}$ has to be in the kernel of the above surjective morphism $W\left(\Gamma_{7}\right) \rightarrow \operatorname{Sp}_{6}\left(\mathbb{F}_{2}\right)$. Since the order of $W\left(\Gamma_{7}\right)$ is twice the order of $\mathrm{Sp}_{6}\left(\mathbb{F}_{2}\right)$, this kernel is exactly $\left\{1, w_{0}\right\}$. We deduce that any element of $\operatorname{Ker} \widehat{f}_{7}$ is either in the pure Artin group $\widehat{P}_{7}$ of type $\Gamma_{7}$, or in the coset $\mathbf{w}_{0} \widehat{P}_{7}$, where $\mathbf{w}_{0}$ is a fixed preimage of $w_{0}$ in $\widehat{B}_{7}$.

Since we know $\operatorname{Ker} \widehat{f}_{7} \cap \widehat{P}_{7}$ by Theorem 6.3 , it remains to determine the intersection of $\operatorname{Ker} \widehat{f}_{7}$ with the coset $\mathbf{w}_{0} \widehat{P}_{7}$. A computation shows that the image of $\mathbf{w}_{0}$ in $\operatorname{Sp}_{6}(\mathbb{Z})$ is trivial. Thus $\widehat{f}_{7}\left(\mathbf{w}_{0}\right)=w_{1}^{4 k} \in \operatorname{St}\left(C_{3}, \mathbb{Z}\right)$ for some integer $k$. Consequently, $\mathbf{w}_{0} \Delta_{3}^{-4 k}$ belongs to $\operatorname{Ker} \widehat{f}_{7}$ and the full kernel $\operatorname{Ker} \widehat{f}_{7}: \widehat{B}_{7} \rightarrow \operatorname{St}\left(C_{3}, \mathbb{Z}\right)$ is the normal closure of $\alpha_{0},\left[\sigma_{3}, \Delta_{3}^{4}\right], \Delta_{5}^{4} \Delta_{3}^{-16}$ and $\mathbf{w}_{0} \Delta_{3}^{-4 k}$. We have not been able to determine the exponent $k$.
