Error Analysis for a Statistical Finite Element Method

Abstract


The recently proposed statistical finite element (statFEM) approach synthesises measurement data with finite element models and allows for making predictions about the true system response. We provide a probabilistic error analysis for a prototypical statFEM setup based on a Gaussian process prior under the assumption that the noisy measurement data are generated by a deterministic true system response function that satisfies a second-order elliptic partial differential equation for an unknown true source term. In certain cases, properties such as the smoothness of the source term may be misspecified by the Gaussian process model. The error estimates we derive are for the expectation with respect to the measurement noise of the L^2 -norm of the difference between the true system response and the mean of the statFEM posterior. The estimates imply polynomial rates of convergence in the numbers of measurement points and finite element basis functions and depend on the Sobolev smoothness of the true source term and the Gaussian process model. A numerical example for Poisson's equation is used to illustrate these theoretical results.

1 Introduction

The finite element method has become an indispensable tool for solving partial differential equations in engineering and applied sciences. Today, the design, manufacture and maintenance of most engineering products rely on mathematical models based on finite element discretised partial differential equations (PDEs). These models depend on a wide range of parameters, including material, geometry and loading, which are inevitably subject to (epistemic and aleatoric) uncertainties. Consequently, the response of the actual engineering product and the inevitably misspecified mathematical model often bear little resemblance to each other, resulting in inefficient designs and overtly cautious operational decisions. Fortunately, more and more engineering products are equipped with sensor networks providing operational measurement data (e.g., Febrianto et al., 2021). The recently proposed statistical finite element method (statFEM) allows us to infer the true system response by synthesising limited measurement data with the misspecified the finite element model (Girolami et al., 2021). By adopting a Bayesian approach, the prior probability measure of the finite element solution is obtained from the misspecified finite element model by solving a probabilistic forward problem. Although any parameters of the finite element model can be random, in this article, only the source term of the respective PDE is random and Gaussian so that the finite element solution is Gaussian. The assumed data-generating process for determining the likelihood of the measured data is additively composed of the random finite element solution, the known random measurement noise, and, possibly, an unknown random discrepancy component. The chosen prior and the likelihood ensure that the posterior finite element probability density (conditioned on the measurement data) is Gaussian and easily computable. Note that in contrast to conventional Bayesian treatment of inverse problems (Kaipio and Somersalo, 2006; Stuart, 2010), statFEM does not aim to infer the parameters of the finite element model.

More concretely, we consider in this article the following mathematical problem. Suppose that the system response u one believes generated the measurement data is given by the solution of

$$\mathcal{L}u = f \tag{1.1}$$






Figure 1: Left: Four translates $K(\cdot,x)$ of the Matérn covariance kernel in (2.5) with $\nu=1/2$ and $\sigma=\ell=1$. Right: Four translates $K_u(\cdot,x)$ of the corresponding kernel of the process u_{GP} for Poisson's equation with zero boundary conditions.

on a bounded domain Ω with Dirichlet boundary conditions. The *statistical* component of the statFEM solution arises from the placement of a stochastic process prior on the forcing term f and, possibly, the differential operator \mathcal{L} or some of its parameters. Doing this induces a stochastic process prior over the solution u. After hyperparameter estimation and inclusion of additional levels of statistical modelling (Kennedy and O'Hagan, 2002), which may account for various modelling discrepancies, one uses Bayesian inference to obtain a posterior distribution over the PDE solution given the measurement data. The posterior can then predict the system behaviour at previously unseen data locations and provide associated uncertainty quantification. See Girolami et al. (2021) and Duffin et al. (2021) for applications of this methodology to different types of PDEs and Abdulle and Garegnani (2021) for a somewhat different approach focusing on random meshes. In any non-trivial setting, computation of the prior for u from that placed on f requires solving the PDE (1.1). In statFEM the PDE is solved using *finite elements*. Due to their tractability, Gaussian processes (GPs) are often the method of choice for modelling physical phenomena. In our PDE setting Gaussian processes are particularly convenient because a GP prior, f_{GP} , on f induces a GP prior, u_{GP} , on uif the PDE is linear (see Figure 1). The induced prior u_{GP} has been studied in Owhadi (2015) and Cockayne et al. (2017, Section 3.1.2). Although u_{GP} is generally not available in closed form, it is straightforward to approximate its mean and covariance functions from those of f_{GP} by using finite elements.

In this article, we provide estimates of the predictive error for the GP-based statFEM when the data are noisy evaluations of some deterministic true system response function u_t which is assumed to be the solution of (1.1) for an unknown—but deterministic—true source term f_t . Due to the complexity and difficulty of analysing a full statFEM approach, we consider a prototypical version that consists of a GP prior on f and, possibly, a GP discrepancy term. Scaling and other parameters these processes may have are assumed fixed. Despite recent advances in understanding the behaviour of GP hyperparameters and their effect on the convergence of GP approximation (Karvonen et al., 2020; Teckentrup, 2020; Wynne et al., 2021), these results are either not directly applicable in our setting or too generic in that they assume that the parameter estimates remain in some compact sets, which has not been verified for commonly used parameter estimation methods, such as maximum likelihood. As mentioned, finite elements are needed for computation of the induced prior u_{GP} and the associated posterior. But why not simply use a readily available and explicit GP prior for u, such as one with a Matérn covariance kernel, instead of something that requires finite element approximations? The main reason (besides this being the first step towards analysing the full statFEM) is that a prior u_{GP} , for which $\mathcal{L}u_{GP} = f_{GP}$, satisfies the structural constraints imposed by the PDE model and can therefore be expected to yield more accurate point estimates and more reliable uncertainty quantification than a more arbitrary prior if the data are generated by a solution of (1.1) for some source term. We give a detailed description of the considered method in Section 2.

1.1 Contributions

Our contribution consists of a number of error estimates for the statFEM approach sketched above. Suppose that the measurements are $y_i = u_t(\mathbf{x}_i) + \varepsilon_i$ for n locations $\mathbf{x}_i \in \Omega \subset \mathbb{R}^d$ and independent Gaussian noises

 $\varepsilon_i \sim N(0, \sigma_\varepsilon^2)$. The regression error estimates we prove are of the form

$$\mathbb{E}\left[\|u_t - \widetilde{m}\|_{L^2(\Omega)}\right] \le C_1 n^{-1/2 + a} + C_2 \sigma_{\varepsilon}^{-1} n_{\text{FE}}^{-q} n^{3/2},\tag{1.2}$$

where \widetilde{m} is a posterior mean function obtained from statFEM and the expectation is with respect to the measurement noise. The constant $a \in (0,1/2)$ depends on the smoothness of f_t and q>0 is the dimension d dependent characteristic rate of convergence of the finite element approximation with $n_{\rm FE}$ elements. In (1.2) it is assumed that the points \boldsymbol{x}_i cover Ω sufficiently uniformly. In Section 4 we present error estimates for four different variants of statFEM, each of which corresponds to a different \widetilde{m} :

- Theorem 4.1 assumes that no finite element discretisation is required for computation of \widetilde{m} . In this case $C_1 > 0$ and $C_2 = 0$. It is required that f_t is at least as smooth as the prior f_{GP} .
- In Theorem 4.4, the more realistic assumption that \widetilde{m} is constructed via a finite element approximation is used. In this case $C_1, C_2 > 0$. It is required that f_t is at least as smooth as the prior f_{GP} .
- Theorems 4.6 and 4.7 concern versions which include a GP discrepancy term $v_{\rm GP}$ (i.e., the prior for u is $u_{\rm GP}+v_{\rm GP}$) and do not use or use, respectively, finite element discretisation to compute \widetilde{m} . These theorems allow the priors to *misspecify* the source term and system response smoothness as it is *not* required that f_t be at least as smooth as $f_{\rm GP}$ or that u_t be at least as smooth as $v_{\rm GP}$ or $v_{\rm GP}$.

The potential practical relevance of the bound (1.2) is that it suggests the heuristics that one should use approximately (and up to a constant) $n_{\rm FE} = n^{(2-a)/q}$ finite elements as this selection recovers the rate $n^{-1/2+a}$, which is the best possible rate in the number of measurements that can be obtained from (1.2). As discussed in Remark 4.2, this rate is likely slightly sub-optimal. Some numerical examples for the one-dimensional Poisson equation are given in Section 5.

The proofs of these results are based on reproducing kernel Hilbert space (RKHS) techniques which are commonly used to analyse approximation properties of GPs (van der Vaart and van Zanten, 2011; Cialenco et al., 2012; Cockayne et al., 2017; Karvonen et al., 2020; Teckentrup, 2020; Wang et al., 2020; Wynne et al., 2021). Our central tool is Theorem 3.7, which describes the RKHS associated to the prior $u_{\rm GP}$ under the assumptions that the RKHS for $f_{\rm GP}$ is a Sobolev space and $\mathcal L$ is a second-order elliptic differential operator. This result is used to "export" (a) regression error estimates in some of the aforementioned references and (b) bounds on the concentration function (Li and Linde, 1999; van der Vaart and van Zanten, 2011) from a "standard" GP prior $f_{\rm GP}$ (e.g., one specified by a Matérn covariance kernel) to the transformed prior $u_{\rm GP}$. When a finite element approximation is used, the regression error estimates are combined with a simple result (Proposition 4.3) which bounds the difference between GP posterior means for two different kernels in terms of the maximal difference of the kernels.

1.2 Related Work

Solving PDEs with kernel-based methods goes back at least to Kansa (1990); see Fasshauer (1996) and Franke and Schaback (1998) as well as Chapter 16 in Wendland (2005) for a more general treatment. In the language of GPs, this *radial basis function collocation* approach is essentially based on modelling u as a GP with a given covariance kernel and conditioning on the derivative observations $\mathcal{L}u(\boldsymbol{x}_i) = f(\boldsymbol{x}_i)$. Typically no synthesis of actual measurement data is present (though this could be easily included). For convergence results in a well-specified setting, see for example Theorem 16.15 in Wendland (2005). In a GP setting similar methods have been proposed and analysed in Graepel (2003); Cialenco et al. (2012); Cockayne et al. (2017); and Raissi et al. (2017). For some error estimates, see Lemma 3.4 and Proposition 3.5 in Cialenco et al. (2012). Priors and covariance kernels derived from Green's function have been considered by Fasshauer and Ye (2011, 2013) and Owhadi (2015). Furthermore, Papandreou et al. (2021) have recently derived bounds on the Wasserstein distance W_2 between the ideal prior and posterior (see Section 2.1 in the present article) and their finite element approximations.

2 Statistical Finite Element Methods

This section describes the statFEM approach that is analysed in Section 4 and discusses some extensions that are not covered by our analysis. We begin by defining the class of second-order elliptic PDE problems that are considered in this article.

Let $d \in \mathbb{N}$ and $\Omega \subset \mathbb{R}^d$ be an open and bounded set which has a Lipschitz boundary $\partial\Omega$ (i.e., the boundary is locally the graph of a Lipschitz function). Throughout this article we assume that Ω satisfies an interior cone condition, which prohibits the existence of "pinch" points (e.g., Wendland, 2005, Definition 3.6). Occasionally we also require an assumption that $\partial\Omega$ be C^k or $C^{k,\alpha}$, which means that its boundary can be interpreted locally as the graph of a function in $C^k(\mathbb{R}^{d-1})$ or in the Hölder space $C^{k,\alpha}(\mathbb{R}^d)$, for which see Section 3.1. Let $\mathcal L$ be a second-order partial differential operator of the form

$$\mathcal{L}u = -\sum_{i=1}^{d} \sum_{j=1}^{d} \partial_i (a_{ij}\partial_j u) + \sum_{i=1}^{d} b_i \partial_i u + cu$$
(2.1)

for coefficient functions a_{ij} , b_i and c which are bounded on the closure $\bar{\Omega}$. We further assume that $a_{ij} \in C^1(\Omega)$ and $a_{ij} = a_{ji}$ for all $i, j = 1, \ldots, d$. The differential operator is assumed to be uniformly elliptic, which is to say that there is a positive constant λ such that $\sum_{i=1}^d \sum_{j=1}^d a_{ij}(\boldsymbol{x}) z_i z_j \geq \lambda \|\boldsymbol{z}\|^2$ for any $\boldsymbol{x} \in \Omega$ and $\boldsymbol{z} \in \mathbb{R}^d$.

We consider the elliptic PDE

$$\mathcal{L}u = f \qquad \text{in } \Omega,$$

$$u = 0 \qquad \text{on } \partial\Omega$$
(2.2)

for some source term $f:\Omega\to\mathbb{R}$. Let $\mathcal{H}_{\mathcal{L}}(\Omega)$ be some space of functions defined on Ω such that the above PDE admits a unique classical (i.e., pointwise) solution $u:\bar{\Omega}\to\mathbb{R}$ for every $f\in\mathcal{H}_{\mathcal{L}}(\Omega)$. Therefore there is a linear operator $\mathcal{L}^{-1}\colon\mathcal{H}_{\mathcal{L}}(\Omega)\to C^2(\Omega)$ such that $u=\mathcal{L}^{-1}f$ is the unique solution of (2.2) for any $f\in\mathcal{H}_{\mathcal{L}}(\Omega)$. Suppose that there is a *true system response* u_t which is the unique solution of

$$\mathcal{L}u_t = f_t \qquad \text{in } \Omega,$$

$$u = 0 \qquad \text{on } \partial\Omega$$
(2.3)

for a certain true source term $f_t \in \mathcal{H}_{\mathcal{L}}(\Omega)$, which may be unknown, and that one has access to $n \in \mathbb{N}$ noisy observations $\mathbf{Y} = (y_1, \dots, y_n) \in \mathbb{R}^n$ of u_t at distinct data locations $X = \{\mathbf{x}_1, \dots, \mathbf{x}_n\} \subset \Omega$:

$$y_i = u_t(\boldsymbol{x}_i) + \varepsilon_i$$
 for independent $\varepsilon_i \sim N(0, \sigma_{\varepsilon}^2)$, (2.4)

where $\sigma_{\varepsilon} > 0$. The statFEM approach provides a means for predicting the value of the true system response, $u_t(\boldsymbol{x})$, at any point, \boldsymbol{x} , in the domain, as well as assigning an uncertainty estimates for these predictions, based on the observations, the differential operator \mathcal{L} and a prior which encodes, for example, assumptions on the smoothness of the true source term. We emphasise that here u_t and f_t are always assumed to be some fixed and deterministic functions. Although we use GPs to model them, the functions themselves are not considered stochastic processes. All expectations that occur in this article are with respect to the noise variables ε_i alone.

2.1 Gaussian Process Inference

Let $K \colon \Omega \times \Omega \to \mathbb{R}$ be any positive-semidefinite kernel. That is, for any $n \in \mathbb{N}$, $\alpha_1, \ldots, \alpha_n \in \mathbb{R}$, and $\mathbf{z}_1, \ldots, \mathbf{z}_n \in \Omega$ it holds that $\sum_{i=1}^n \sum_{j=1}^n \alpha_i \alpha_j K(\mathbf{z}_i, \mathbf{z}_j) \geq 0$. One of the most ubiquitous—as well as one which appears repeatedly in this article—classes of positive-semidefinite kernels is that of the Matérn kernels

$$K(\boldsymbol{x}, \boldsymbol{y}) = \sigma^{2} \frac{2^{1-\nu}}{\Gamma(\nu)} \left(\frac{\sqrt{2\nu} \|\boldsymbol{x} - \boldsymbol{y}\|}{\ell} \right)^{\nu} K_{\nu} \left(\frac{\sqrt{2\nu} \|\boldsymbol{x} - \boldsymbol{y}\|}{\ell} \right), \tag{2.5}$$

where $\nu>0$ is a smoothness parameter, $\ell>0$ a length-scale parameter, $\sigma>0$ a scaling parameter, Γ the Gamma function and K_{ν} the modified Bessel function of the second kind of order ν . These kernels are important because they induce Sobolev spaces; see Section 3.2. We model f_t as a Gaussian process $f_{\text{GP}} \sim \text{GP}(m,K)$ and assume that

(i)
$$m \in \mathcal{H}_{\mathcal{L}}(\Omega)$$
 and (ii) $K(\cdot, \boldsymbol{x}) \in \mathcal{H}_{\mathcal{L}}(\Omega)$ and $\mathcal{L}_{\boldsymbol{x}}^{-1}K(\cdot, \boldsymbol{x}) \in \mathcal{H}_{\mathcal{L}}(\Omega)$ for every $\boldsymbol{x} \in \Omega$, (2.6)

where the subscript denotes the variable with respect to which the linear operator is applied. These assumptions ensure that various functions that we are about to introduce are unique and pointwise well-defined.

Because \mathcal{L} is a linear differential operator, the above GP prior over f_t induces the prior $u_{\text{GP}} \sim \text{GP}(m_u, K_u)$ over u_t with the mean function $m_u = \mathcal{L}^{-1}m$ and the covariance kernel K_u which satisfies

$$\mathcal{L}_{\boldsymbol{x}}\mathcal{L}_{\boldsymbol{y}}K_{u}(\boldsymbol{x},\boldsymbol{y}) = K(\boldsymbol{x},\boldsymbol{y}) \tag{2.7}$$

for all $\boldsymbol{x}, \boldsymbol{y} \in \Omega$ as well as $\mathcal{L}K_u(\cdot, \boldsymbol{y}) = 0$ on $\partial\Omega$ for every $\boldsymbol{y} \in \bar{\Omega}$. The existence and uniqueness of the mean and covariance are guaranteed by the assumptions in (2.6). Using the Green's function $G_{\mathcal{L}}$ of the the PDE (2.2), these functions can be formally written as

$$m_u(\boldsymbol{x}) = \int_{\Omega} G_{\mathcal{L}}(\boldsymbol{x}, \boldsymbol{x}') m(\boldsymbol{x}') \, d\boldsymbol{x}' \text{ and } K_u(\boldsymbol{x}, \boldsymbol{y}) = \int_{\Omega} \int_{\Omega} G_{\mathcal{L}}(\boldsymbol{x}, \boldsymbol{x}') K(\boldsymbol{x}', \boldsymbol{y}') G_{\mathcal{L}}(\boldsymbol{y}, \boldsymbol{y}') \, d\boldsymbol{x}' \, d\boldsymbol{y}'.$$
(2.8)

To arrive at an idealised version of the GP-based statFEM we condition the GP $u_{\rm GP}$ on the measurement data in (2.4). This yields the conditional process

$$u_{\text{GP}} \mid \boldsymbol{Y} \sim \text{GP}(m_{u|\boldsymbol{Y}}, K_{u|\boldsymbol{Y}})$$

whose mean and covariance are

$$m_{u|\mathbf{Y}}(\mathbf{x}) = m_u(\mathbf{x}) + \mathbf{K}_u(\mathbf{x}, X)^{\mathsf{T}} (\mathbf{K}_u(X, X) + \sigma_{\varepsilon}^2 \mathbf{I}_n)^{-1} (\mathbf{Y} - \mathbf{m}_u(X)), \tag{2.9a}$$

$$K_{u|\mathbf{Y}}(\mathbf{x}, \mathbf{y}) = K_u(\mathbf{x}, \mathbf{y}) - \mathbf{K}_u(\mathbf{x}, X)^{\mathsf{T}} (\mathbf{K}_u(X, X) + \sigma_{\varepsilon}^2 \mathbf{I}_n)^{-1} \mathbf{K}_u(\mathbf{y}, X), \tag{2.9b}$$

where $K_u(X, X)$ is the $n \times n$ kernel matrix with elements $K_u(\mathbf{x}_i, \mathbf{x}_j)$, $K_u(\mathbf{x}, X)$ and $m_u(X)$ are n-vectors with elements $K_u(\mathbf{x}, \mathbf{x}_i)$ and $m_u(\mathbf{x}_i)$, respectively, and I_n is the $n \times n$ identity matrix. However, the mean function and covariance kernel in (2.8) cannot be solved in closed form in all but the simplest of cases. This necessitates replacing their occurrences in (2.9) with finite element approximations.

2.2 Finite Element Discretisation

Let

$$B(u,v) = \int_{\Omega} \left(\sum_{i=1}^{d} \sum_{j=1}^{d} a_{ij}(\boldsymbol{x}) [\partial_{i} u(\boldsymbol{x})] [\partial_{j} v(\boldsymbol{x})] + \sum_{i=1}^{d} b_{i}(\boldsymbol{x}) [\partial_{i} u(\boldsymbol{x})] v(\boldsymbol{x}) + c(\boldsymbol{x}) u(\boldsymbol{x}) v(\boldsymbol{x}) \right) d\boldsymbol{x}$$

be the bilinear form associated with the elliptic differential operator \mathcal{L} in (2.1) and let $\phi_1, \ldots, \phi_{n_{\text{FE}}}$ be $n_{\text{FE}} \in \mathbb{N}$ finite element basis functions. The finite element approximation u^{FE} of the solution u of (2.2) for any sufficiently regular f is

$$u^{\mathrm{FE}}(\boldsymbol{x}) = \sum_{i=1}^{n_{\mathrm{FE}}} u_i \phi_i(\boldsymbol{x}),$$

where the coefficient vector $\boldsymbol{u} = (u_1, \dots, u_{n_{\text{FE}}})$ is the solution of the linear system

$$\underbrace{\begin{pmatrix} B(\phi_1, \phi_1) & \cdots & B(\phi_{n_{\text{FE}}}, \phi_1) \\ \vdots & \ddots & \vdots \\ B(\phi_{n_{\text{FE}}}, \phi_1) & \cdots & B(\phi_{n_{\text{FE}}}, \phi_{n_{\text{FE}}}) \end{pmatrix}}_{=:\mathbf{A}} \begin{pmatrix} u_1 \\ \vdots \\ u_{n_{\text{FE}}} \end{pmatrix} = \begin{pmatrix} \int_{\Omega} f(\mathbf{x}) \phi_1(\mathbf{x}) \, d\mathbf{x} \\ \vdots \\ \int_{\Omega} f(\mathbf{x}) \phi_{n_{\text{FE}}}(\mathbf{x}) \, d\mathbf{x} \end{pmatrix}.$$

From this we obtain the approximations

$$m_u(\boldsymbol{x}) \approx m_u^{\text{FE}}(\boldsymbol{x}) = \boldsymbol{\mu}^{\mathsf{T}} \boldsymbol{A}^{-1} \boldsymbol{\phi}(\boldsymbol{x}) \quad \text{ and } \quad K_u(\boldsymbol{x}, \boldsymbol{y}) \approx K_u^{\text{FE}}(\boldsymbol{x}, \boldsymbol{y}) = \boldsymbol{\phi}(\boldsymbol{x})^{\mathsf{T}} \boldsymbol{A}^{-1} \boldsymbol{M} \boldsymbol{A}^{-1} \boldsymbol{\phi}(\boldsymbol{y}),$$

where $\boldsymbol{\phi}(\boldsymbol{x}) = (\phi_1(\boldsymbol{x}), \dots, \phi_{n_{\text{FE}}}(\boldsymbol{x}))$ and $\boldsymbol{\mu} = (\int_{\Omega} m(\boldsymbol{x})\phi_1(\boldsymbol{x}) \, \mathrm{d}\boldsymbol{x}, \dots, \int_{\Omega} m(\boldsymbol{x})\phi_{n_{\text{FE}}}(\boldsymbol{x}) \, \mathrm{d}\boldsymbol{x})$ and the matrix $\boldsymbol{M} \in \mathbb{R}^{n_{\text{FE}} \times n_{\text{FE}}}$ has the elements

$$(\boldsymbol{M})_{ij} = \int_{\Omega} \int_{\Omega} \phi_i(\boldsymbol{x}') K(\boldsymbol{x}', \boldsymbol{y}') \phi_j(\boldsymbol{y}') \, \mathrm{d}\boldsymbol{x}' \, \mathrm{d}\boldsymbol{y}'.$$




Figure 2: Graphical model of the statFEM approach considered in this article. Blue variables are known to the user while red variables are unknown. Orange variables represent parameters that the user can choose.

Substituting m_u^{FE} for m_u and K_u^{FE} for K_u yields the approximations

$$m_{u|\mathbf{Y}}^{\text{FE}}(\mathbf{x}) = m_u^{\text{FE}}(\mathbf{x}) + \mathbf{K}_u^{\text{FE}}(\mathbf{x}, X)^{\mathsf{T}} (\mathbf{K}_u^{\text{FE}}(X, X) + \sigma_{\varepsilon}^2 \mathbf{I}_n)^{-1} (\mathbf{Y} - \mathbf{m}_u^{\text{FE}}(X)),$$
(2.10a)

$$K_{u|\boldsymbol{Y}}^{\text{FE}}(\boldsymbol{x},\boldsymbol{y}) = K_{u}(\boldsymbol{x},\boldsymbol{y}) - \boldsymbol{K}_{u}^{\text{FE}}(\boldsymbol{x},X)^{\mathsf{T}} (\boldsymbol{K}_{u}^{\text{FE}}(X,X) + \sigma_{\varepsilon}^{2} \boldsymbol{I}_{n})^{-1} \boldsymbol{K}_{u}^{\text{FE}}(\boldsymbol{y},X)$$
(2.10b)

to the conditional moments in (2.9). In practice, it may be tedious or impossible to compute the elements of M in closed form. When the supports of ϕ_i are contained within small neighbourhoods of some nodes $x_i^{\text{FE}} \in \Omega$, one may treat the kernel as constant within these supports and employ the approximations

$$\int_{\Omega} \phi_i(\mathbf{x}') K(\mathbf{x}', \mathbf{y}') \phi_j(\mathbf{y}') \, d\mathbf{x}' \, d\mathbf{y}' \approx \left(\int_{\Omega} \phi_i(\mathbf{x}') \, d\mathbf{x}' \right) K(\mathbf{x}_i^{\text{FE}}, \mathbf{x}_j^{\text{FE}}) \left(\int_{\Omega} \phi_i(\mathbf{y}') \, d\mathbf{y}' \right). \tag{2.11}$$

The structure of the resulting statFEM approach is displayed in Figure 2.

Later we will use the following generic assumption on the error of the finite element approximations.

Assumption 2.1 (Finite element error). Let q > 0. There exist positive constants C_1 and C_2 , which do not depend on n_{FE} , such that

$$\sup_{\boldsymbol{x} \in \Omega} |m_u(\boldsymbol{x}) - m_u^{\text{FE}}(\boldsymbol{x})| \le C_1 n_{\text{FE}}^{-q} \quad \text{ and } \quad \sup_{\boldsymbol{x}, \boldsymbol{y} \in \Omega} |K_u(\boldsymbol{x}, \boldsymbol{y}) - K_u^{\text{FE}}(\boldsymbol{x}, \boldsymbol{y})| \le C_2 n_{\text{FE}}^{-q}$$

for all sufficiently large $n_{\text{FE}} \in \mathbb{N}$.

In the error analysis of finite element methods it is typical to express the bounds as functions of the mesh size instead of the number of elements as we have done in Assumption 2.1. However, in this article our focus is on the statistical component of the statFEM approach and we do not wish to introduce the machinery that is necessary for presenting the standard finite element error estimates. For these estimates we refer to Brenner and Scott (2008) and Lord et al. (2014). For example, in absence of numerical integration errors, the rate in Assumption 2.1 is q=2 for Poisson's equation on a univariate domain if ϕ_i are the piecewise linear finite elements on a quasi-uniform grid (Brenner and Scott, 2008, Chapter 0) and K and m are sufficiently smooth. An additional motivation for using such a generic assumption is the presence of integral approximations, such as that in (2.11).

2.3 The Discrepancy Term

It is often desirable to include a discrepancy term $v_{\rm GP} \sim {\rm GP}(m_d,K_d)$ which attempts to account for modelling errors. We do this by replacing the induced GP model $u_{\rm GP} \sim {\rm GP}(m_u,K_u)$ for u_t with $u_{\rm GP}+v_{\rm GP}$, so that the full GP model for u_t is

$$u_{GP} + v_{GP} \sim GP(m_u + m_d, K_u + K_d).$$

Unlike $u_{\rm GP}$, which is induced by the GP prior $f_{\rm GP}$ over f_t and is thus accessible only by solving the PDE (2.2), the discrepancy term is typically taken to be a GP with some standard covariance kernel, such as a Matérn in (2.5). Denote $m_{ud}=m_u+m_d$ and $K_{ud}=K_u+K_d$. When the discrepancy term is included, the exact conditional moments in (2.9) become

$$m_{d:u|\mathbf{Y}}(\mathbf{x}) = m_{ud}(\mathbf{x}) + \mathbf{K}_{ud}(\mathbf{x}, X)^{\mathsf{T}} (\mathbf{K}_{ud}(X, X) + \sigma_{\varepsilon}^{2} \mathbf{I}_{n})^{-1} (\mathbf{Y} - \mathbf{m}_{ud}(X)), \tag{2.12a}$$

$$K_{d;u|\mathbf{Y}}(\mathbf{x},\mathbf{y}) = K_{ud}(\mathbf{x},\mathbf{y}) - \mathbf{K}_{ud}(\mathbf{x},X)^{\mathsf{T}} (\mathbf{K}_{ud}(X,X) + \sigma_{\varepsilon}^{2} \mathbf{I}_{n})^{-1} \mathbf{K}_{ud}(\mathbf{y},X).$$
(2.12b)

When a finite element approximation is employed, we get

$$m_{d:u|\mathbf{Y}}^{\text{FE}}(\mathbf{x}) = m_{ud}^{\text{FE}}(\mathbf{x}) + \mathbf{K}_{ud}^{\text{FE}}(\mathbf{x}, X)^{\mathsf{T}} (\mathbf{K}_{ud}^{\text{FE}}(X, X) + \sigma_{\varepsilon}^{2} \mathbf{I}_{n})^{-1} (\mathbf{Y} - \mathbf{m}_{ud}^{\text{FE}}(X)), \tag{2.13a}$$

$$K_{d:u|\boldsymbol{Y}}^{\text{FE}}(\boldsymbol{x},\boldsymbol{y}) = K_{ud}^{\text{FE}}(\boldsymbol{x},\boldsymbol{y}) - \boldsymbol{K}_{ud}^{\text{FE}}(\boldsymbol{x},X)^{\mathsf{T}} (\boldsymbol{K}_{ud}^{\text{FE}}(X,X) + \sigma_{\varepsilon}^{2} \boldsymbol{I}_{n})^{-1} \boldsymbol{K}_{ud}^{\text{FE}}(\boldsymbol{y},X). \tag{2.13b}$$

where $m_{ud}^{\rm FE}=m_u^{\rm FE}+m_d$ and $K_{ud}^{\rm FE}=K_u^{\rm FE}+K_d.$

2.4 Extensions

In practice, a variety of additional levels of statistical modelling, or altogether a more complex PDE model, are typically used in statFEM (Girolami et al., 2021). These can include an additional factor on the left-hand side of (2.2) which is modelled as a GP, the standard example being Poisson's equation

$$-\nabla(e^{\mu}\nabla u) = f \tag{2.14}$$

in which a GP prior is placed on μ (and the exponential ensures positivity of the diffusion coefficient, e^{μ}) in addition to f, as done in this article, and estimation of various parameters present in model, such as parameters of the covariance kernel K (e.g., σ , ℓ and ν of a Matérn kernel). If GP priors are placed on μ and f in the model (2.14) or its generalisation of some form, the prior induced on u is no longer a GP. This would render most of the theoretical tools that we use inoperative, and this generalisation is not accordingly pursued here. While there is some recent theoretical work on parameter estimation in Gaussian process regression for deterministic data-generating functions and its effect on posterior rates of convergence and reliability (Karvonen et al., 2020; Teckentrup, 2020; Wang, 2021), the results that have been obtained are not yet sufficiently general to be useful in our setting. However, parameter estimation is an extension that we hope may be included in the analysis in the not-too-distant future.

3 Auxiliary Results

This section collects and derives a number of auxiliary results which are used to prove the error estimates in Section 4. These results are of four types: (i) standard regularity results for solutions of elliptic PDEs; (ii) results on the reproducing kernel Hilbert space of the kernel K_u ; (iii) sampling inequalities and (iv) results related to the concentration function and small ball probabilities of Gaussian measures. We use the notation $C = C(\theta_1, \ldots, \theta_p)$ to indicate that a constant C depends only on the parameters $\theta_1, \ldots, \theta_p$.

3.1 Regularity Results for Elliptic PDEs

Let $D^{\alpha}f$ denote the weak derivative of order $\alpha \in \mathbb{N}_0^d$ of any sufficiently regular function $f : \Omega \to \mathbb{R}$. Let $k \in \mathbb{N}_0$. The Sobolev space $H^k(\Omega)$ consists of functions for which $D^{\alpha}f$ exists for all $|\alpha| \le k$ and the norm

$$\|f\|_{H^k(\Omega)} = \left(\sum_{|\boldsymbol{\alpha}| \le k} \|\mathbf{D}^{\boldsymbol{\alpha}} f\|_{L^2(\Omega)}^2\right)^{1/2}$$

is finite. The Hölder space $C^{k,\alpha}(\Omega)$ consists of functions which are $k \in \mathbb{N}_0$ times differentiable on Ω and whose derivatives of order k are Hölder continuous with exponent $\alpha \in (0,1]$.

Certain standard regularity results and estimates play a crucial role in the derivation of our results. The following regularity theorem can be found in, for example, Evans (1998, Theorem 5 in Section 6.3).

Theorem 3.1. Consider the elliptic PDE in (2.2). Let $k \in \mathbb{N}_0$ and suppose that $\partial \Omega$ is C^{k+2} and $a_{ij}, b_i, c \in C^{k+1}(\bar{\Omega})$ for all $i, j = 1, \ldots, d$. If $f \in H^k(\Omega) \cap \mathcal{H}_{\mathcal{L}}(\Omega)$, then $u \in H^{k+2}(\Omega)$ and there is a constant $C = C(k, \Omega, \mathcal{L})$ such that

$$||u||_{H^{k+2}(\Omega)} \le C ||f||_{H^k(\Omega)}.$$

The following boundedness result is a combination of the a priori bound in Theorem 3.7 and the Schauder regularity result in Theorem 6.14 of Gilbarg and Trudinger (1983).

Theorem 3.2. Consider the elliptic PDE in (2.2). Suppose that $\partial\Omega$ is $C^{2,\alpha}$, $a_{ij}, b_i, c \in C^{0,\alpha}(\bar{\Omega})$ for all $i, j = 1, \ldots, d$ and some $\alpha \in (0,1)$ and $c \leq 0$. If $f \in C^{0,\alpha}(\bar{\Omega})$, then $u \in C^{2,\alpha}(\bar{\Omega})$ and there is a constant $C = C(\Omega, \mathcal{L})$ such that

$$||u||_{L^{\infty}(\Omega)} \leq C ||f||_{L^{\infty}(\Omega)}$$
.

The regularity assumptions of Theorem 3.1 will be used repeatedly in what follows. They are accordingly encapsulated in the following assumption, which, it is to be noted, is sufficient for Theorem 3.2 to hold whenever c < 0 because k > 0.

Assumption 3.3 (Regularity). For a given $k \in \mathbb{N}_0$, the boundary $\partial \Omega$ is C^{k+2} and $a_{ij}, b_i, c \in C^{k+1}(\bar{\Omega})$ for all $i, j = 1, \dots, d$

3.2 Reproducing Kernel Hilbert Spaces

By the classical Moore–Aronszajn theorem (Berlinet and Thomas-Agnan, 2004, p. 19) any positive-semidefinite kernel $K: \Omega \times \Omega \to \mathbb{R}$ induces a unique *reproducing kernel Hilbert space* (RKHS) $\mathcal{H}(K,\Omega)$ which consists of functions $f: \Omega \to \mathbb{R}$ and is equipped with an inner product $\langle \cdot, \cdot \rangle_K$ and norm $\|\cdot\|_K$. Two fundamental properties of this space are that (i) $K(\cdot, \boldsymbol{x})$ is an element of $\mathcal{H}(K,\Omega)$ for every $\boldsymbol{x} \in \Omega$ and (ii) the *reproducing property*

$$\langle f, K(\cdot, \boldsymbol{x}) \rangle_K = f(\boldsymbol{x}) \quad \text{for every} \quad f \in \mathcal{H}(K, \Omega) \text{ and } \boldsymbol{x} \in \Omega.$$
 (3.1)

Our results will use an assumption that $\mathcal{H}(K,\Omega)$ is norm-equivalent to a Sobolev space.

Definition 3.4 (Norm-equivalence). The RKHS $\mathcal{H}(K,\Omega)$ is *norm-equivalent* to the Sobolev space $H^k(\Omega)$, denoted $\mathcal{H}(K,\Omega) \simeq H^k(\Omega)$, if $\mathcal{H}(K,\Omega) = H^k(\Omega)$ as sets and there exist positive constants C_K and C_K' such that

$$C_K \|f\|_{H^k(\Omega)} \le \|f\|_K \le C_K' \|f\|_{H^k(\Omega)}$$
 (3.2)

for all $f \in \mathcal{H}(K,\Omega)$.

The RKHS of a Matérn kernel of smoothness ν in (2.5) is norm-equivalent to $H^{\nu+d/2}(\Omega)$. If k>d/2, the Sobolev embedding theorem ensures that any kernel which is norm-equivalent to $H^k(\Omega)$ is continuous and that all functions in its RKHS are continuous.

From now on we assume that $\mathcal{H}(K,\Omega)\subset\mathcal{H}_{\mathcal{L}}(K)$, which is to say that the PDE in (2.2) admits a unique classical solution for every $f\in\mathcal{H}(K,\Omega)$. The following lemma justifies the assumption in (2.6) that $\mathcal{L}_{\boldsymbol{x}}^{-1}K(\cdot,\boldsymbol{x})$ is an element of $\mathcal{H}(K,\Omega)\subset\mathcal{H}_{\mathcal{L}}(\Omega)$ for every $\boldsymbol{x}\in\Omega$. Let $\delta_{\boldsymbol{x}}$ be the point evaluation functional at $\boldsymbol{x}\in\Omega$ (i.e., $\delta_{\boldsymbol{x}}(f)=f(\boldsymbol{x})$). As earlier, whenever there is a risk of ambiguity we use subscripts to denote the variable to which a functional or an operator applies to. That is,

$$\mathcal{A} f(\boldsymbol{x}) = \mathcal{A}_{\boldsymbol{x}} f(\boldsymbol{x}) = (\delta_{\boldsymbol{x}} \circ \mathcal{A})_{\boldsymbol{x}'} f(\boldsymbol{x}')$$

for any operator A.

Lemma 3.5. Let k > d/2. Suppose that $\mathcal{H}(K,\Omega) \simeq H^k(\Omega)$ and that Assumption 3.3 holds. Then the functional $\delta_{\boldsymbol{x}} \circ \mathcal{L}^{-1}$ is bounded on $\mathcal{H}(K,\Omega)$ and $\mathcal{L}^{-1}_{\boldsymbol{x}}K(\cdot,\boldsymbol{x}) \in \mathcal{H}(K,\Omega)$ for every $\boldsymbol{x} \in \Omega$.

Proof. Let $\mathbf{x} \in \Omega$ and set $\ell_{\mathbf{x}} = \delta_{\mathbf{x}} \circ \mathcal{L}^{-1}$. Since $\mathcal{H}(K,\Omega)$ is norm-equivalent to $H^k(\Omega)$ and $H^{k+2}(\Omega)$ is continuously embedded in $C(\Omega)$, it follows from Theorem 3.1 that

$$|\ell_{\boldsymbol{x}}(f)| = |u(\boldsymbol{x})| \le ||u||_{L^{\infty}(\Omega)} \le C_1 ||u||_{H^{k+2}(\Omega)} \le C_1 C_2 ||f||_{H^k(\Omega)} \le C_1 C_2 C_K^{-1} ||f||_K$$

for any $f \in \mathcal{H}(K,\Omega)$ and constants $C_1 = C(k,\Omega)$ and $C_2 = C(k,\Omega,\mathcal{L})$. This proves that $\ell_{\boldsymbol{x}}$ is bounded on $\mathcal{H}(K,\Omega)$. Because $\ell_{\boldsymbol{x}}$ is bounded, it follows from the Riesz representation theorem that there exists a unique function $l_{\boldsymbol{x}} \in \mathcal{H}(K,\Omega)$ such that $\ell_{\boldsymbol{x}}(f) = \langle f, l_{\boldsymbol{x}} \rangle_K$ for every $f \in \mathcal{H}(K,\Omega)$. Setting $f = K(\cdot,\boldsymbol{y})$ and using the reproducing property (3.1) we get, for any $\boldsymbol{y} \in \Omega$,

$$\mathcal{L}_{\boldsymbol{x}}^{-1}K(\boldsymbol{y},\boldsymbol{x}) = \ell_{\boldsymbol{x}}(K(\boldsymbol{y},\boldsymbol{x})) = \langle K(\boldsymbol{y},\boldsymbol{x}), l_{\boldsymbol{x}} \rangle_K = l_{\boldsymbol{x}}(\boldsymbol{y}).$$

That is,
$$\mathcal{L}_{\boldsymbol{x}}^{-1}K(\cdot,\boldsymbol{x})=l_{\boldsymbol{x}}\in\mathcal{H}(K,\Omega).$$

Next we want to understand how the RKHS of the kernel K_u defined in (2.7) relates to that of K. We use the following general proposition about transformations of RKHSs. See Theorems 16.8 and 16.9 in Wendland (2005) or Section 5.4 in Paulsen and Raghupathi (2016) for similar results. A proof is included here for completeness and because our formulation differs slightly from those that we have found in the literature.

Proposition 3.6. Let K be a positive-semidefinite kernel on Ω and A an invertible linear operator on $\mathcal{H}(K,\Omega)$ such that the functional $\delta_{\boldsymbol{x}} \circ A$ is bounded on $\mathcal{H}(K,\Omega)$ for every $\boldsymbol{x} \in \Omega$. Then

$$R(\boldsymbol{x}, \boldsymbol{y}) = \mathcal{A}_{\boldsymbol{x}} \mathcal{A}_{\boldsymbol{y}} K(\boldsymbol{x}, \boldsymbol{y}) = (\delta_{\boldsymbol{x}} \circ \mathcal{A})^{\boldsymbol{x}'} (\delta_{\boldsymbol{y}} \circ \mathcal{A})^{\boldsymbol{y}'} K(\boldsymbol{x}', \boldsymbol{y}')$$

defines a positive-semidefinite kernel on Ω . Furthermore,

$$\mathcal{H}(R,\Omega) = \mathcal{A}(\mathcal{H}(K,\Omega)) = \{\mathcal{A}f \,:\, f \in \mathcal{H}(K,\Omega)\} \quad \text{ and } \quad \|\mathcal{A}f\|_{R} = \|f\|_{K} \text{ for every } f \in \mathcal{H}(K,\Omega).$$

Proof. Because the functional $\ell_{\pmb{y}} = \delta_{\pmb{y}} \circ \mathcal{A}$ is bounded on $\mathcal{H}(K,\Omega)$, the Riesz representation theorem implies that there exists a unique representer $l_{\pmb{y}} \in \mathcal{H}_K(\Omega)$ such that $\ell_{\pmb{y}}(f) = \langle f, l_{\pmb{y}} \rangle_K$ for every $f \in \mathcal{H}(K,\Omega)$. Therefore, by the reproducing property,

$$l_{\boldsymbol{y}}(\boldsymbol{x}) = \langle K(\boldsymbol{x},\cdot), l_{\boldsymbol{y}} \rangle_K = \ell_{\boldsymbol{y}}(K(\boldsymbol{x},\cdot)) = (\delta_{\boldsymbol{y}} \circ \mathcal{A})^{\boldsymbol{u}} K(\boldsymbol{x}, \boldsymbol{u})$$

for any $\boldsymbol{x}, \boldsymbol{y} \in \Omega$. Since $l_{\boldsymbol{y}}$ is an element of $\mathcal{H}(K, \Omega)$, $\ell_{\boldsymbol{x}}(l_{\boldsymbol{y}}) = \langle l_{\boldsymbol{x}}, l_{\boldsymbol{y}} \rangle_K$ and

$$\ell_{\boldsymbol{x}}(l_{\boldsymbol{y}}) = (\delta_{\boldsymbol{x}} \circ \mathcal{A})(l_{\boldsymbol{y}}) = (\delta_{\boldsymbol{x}} \circ \mathcal{A})^{\boldsymbol{v}}(\delta_{\boldsymbol{y}} \circ \mathcal{A})^{\boldsymbol{u}}K(\boldsymbol{v}, \boldsymbol{u}) = R(\boldsymbol{x}, \boldsymbol{y}),$$

from which it follows that R is a well-defined kernel. To verify that R is positive-semidefinite, compute

$$\sum_{i=1}^{N} \sum_{j=1}^{N} a_i a_j R(\boldsymbol{x}_i, \boldsymbol{x}_j) = \sum_{i=1}^{N} \sum_{j=1}^{N} a_i a_j \langle l_{\boldsymbol{x}_i}, l_{\boldsymbol{x}_j} \rangle_K = \left\langle \sum_{i=1}^{N} a_i l_{\boldsymbol{x}_i}, \sum_{i=1}^{N} a_i l_{\boldsymbol{x}_i} \right\rangle_K$$

$$= \left\| \sum_{i=1}^{N} a_i l_{\boldsymbol{x}_i} \right\|_K^2$$

$$> 0$$
(3.3)

for any $N \in \mathbb{N}$, $a_i \in \mathbb{R}$, and $\boldsymbol{x}_i \in \Omega$. To prove the claims related to $\mathcal{H}(R,\Omega)$ we use a classical characterisation (e.g., Paulsen and Raghupathi, 2016, Section 3.4) which states that $f \in \mathcal{H}(K,\Omega)$ if and only if there is c>0 such that

$$K_c(\boldsymbol{x}, \boldsymbol{y}) = c^2 K(\boldsymbol{x}, \boldsymbol{y}) - f(\boldsymbol{x}) f(\boldsymbol{y})$$
(3.4)

defines a positive-semidefinite kernel. The smallest constant for which K_c is positive-semidefinite equals the RKHS norm of f. Now, assuming that $f \in \mathcal{H}(K,\Omega)$ and applying \mathcal{A} twice on (3.4) yields the kernel

$$R_c(\boldsymbol{x}, \boldsymbol{y}) = c^2 R(\boldsymbol{x}, \boldsymbol{y}) - \mathcal{A}f(\boldsymbol{x})\mathcal{A}f(\boldsymbol{y}),$$

which, by the argument used in (3.3), is positive-semidefinite if K_c is. This establishes that $\mathcal{A}(\mathcal{H}(K,\Omega)) \subset \mathcal{H}(R,\Omega)$ and $\|\mathcal{A}f\|_R \leq \|f\|_K$. That these are indeed equalities follows directly from the invertibility of $\mathcal{A} \colon \mathcal{H}(K,\Omega) \to \mathcal{A}(\mathcal{H}(K,\Omega))$.

Applying Proposition 3.6 to $\mathcal{A}=\mathcal{L}^{-1}$ yields the following theorem.

Theorem 3.7. Let k > d/2 and consider the kernel K_u in (2.7). If $\mathcal{H}(K,\Omega) \simeq H^k(\Omega)$ and Assumption 3.3 holds, then

(i) The kernel K_u is positive-semidefinite on Ω and its RKHS is

$$\mathcal{H}(K_u, \Omega) = \{ u : u \text{ is a solution of (2.2) for some } f \in \mathcal{H}(K, \Omega) \}.$$
 (3.5)

Furthermore, $||u||_{K_n} = ||f||_K$.

(ii) It holds that $\mathcal{H}(K_u,\Omega) \subset H^{k+2}(\Omega)$ and there are constants $C_u = C(K,k,\Omega,\mathcal{L})$ and $C_u' = C(K,k,\Omega,\mathcal{L})$ such that

$$C_u \|u\|_{H^{k+2}(\Omega)} \le \|u\|_{K_u} \le C_u' \|u\|_{H^{k+2}(\Omega)}$$
 (3.6)

for all $u \in \mathcal{H}(K_u, \Omega)$.

Proof. Because $\mathcal{H}(K,\Omega)\subset\mathcal{H}_{\mathcal{L}}(\Omega)$, the linear operator $\mathcal{L}^{-1}\colon\mathcal{H}(K,\Omega)\to\mathcal{L}^{-1}(\mathcal{H}(K,\Omega))$ is invertible. Furthermore, by Lemma 3.5 the functionals $\delta\circ\mathcal{L}^{-1}$ are bounded on $\mathcal{H}(K,\Omega)$. Therefore the first claim follows by applying Proposition 3.6 to $\mathcal{A}=\mathcal{L}^{-1}$. To verify the second claim, observe that it now follows from the norm-equivalence $\mathcal{H}(K,\Omega)\simeq\mathcal{H}^k(\Omega)$ and Theorem 3.1 that, for a constant $C=C(k,\Omega,\mathcal{L})$,

$$||u||_{K_u} = ||f||_K \ge C_K ||f||_{H^k(\Omega)} \ge C_K C^{-1} ||u||_{H^{k+2}(\Omega)}$$

and

$$||u||_{K_u} = ||f||_K \le C_K' ||f||_{H^k(\Omega)} = C_K' ||\mathcal{L}u||_{H^k(\Omega)} \le C_K' C_{\mathcal{L}} ||u||_{H^{k+2}(\Omega)},$$

where $C_{\mathcal{L}} = C_{\mathcal{L}}(k, \Omega, \mathcal{L})$ and the last inequality follows from the fact that the differential operator \mathcal{L} is second-order and its coefficient functions are in $C^{k+1}(\bar{\Omega})$.

Finally, we will need the following result (e.g., Berlinet and Thomas-Agnan, 2004, p. 24) on the RKHS of a sum kernel to analyse statFEM when a discrepancy term is included (recall Section 2.3).

Theorem 3.8. Let K_1 and K_2 be two positive-semidefinite kernels on Ω . Then $R = K_1 + K_2$ is a positive-semidefinite kernel on Ω and its RKHS consists of functions which can be written as $f = f_1 + f_2$ for $f_1 \in \mathcal{H}(K_1, \Omega)$ and $f_2 \in \mathcal{H}(K_2, \Omega)$. The RKHS norm is

$$\|f\|_R^2 = \min \big\{ \|f_1\|_{K_1}^2 + \|f_2\|_{K_2}^2 : f = f_1 + f_2 \text{ s.t. } f_1 \in \mathcal{H}(K_1,\Omega), \ f_2 \in \mathcal{H}(K_2,\Omega) \big\}.$$

3.3 Sampling Inequalities

For a finite set of points $X \subset \Omega$ define the *fill-distance*

$$h_{X,\Omega} = \sup_{\boldsymbol{x} \in \Omega} \min_{i=1,...,n} \|\boldsymbol{x} - \boldsymbol{x}_i\|_2.$$

The points $\{x_i\}_{i=1}^{\infty}$ are said to be *quasi-uniform* if there exists a positive constant C_{qu} such that

$$h_{X,\Omega} \le C_{\mathsf{qu}} n^{-1/d} \tag{3.7}$$

for every $n \in \mathbb{N}$. Denote $(x)_+ = \max\{x, 0\}$ for $x \in \mathbb{R}$. The following *sampling inequality* is the main building block of our error estimates.

Theorem 3.9 (Arcangéli et al. 2007, Theorem 4.1). Let $p \in [1, \infty]$, k > d/2 and $\gamma = \max\{p, 2\}$. If $g \in H^k(\Omega)$, then there are constants $C_1 = C(k, p, \Omega)$ and $h_0 = C(k, \Omega)$ such that

$$\left\|g\right\|_{L^p(\Omega)} \leq C \Big(h_{X,\Omega}^{k-d(1/2-1/p)_+} \left\|g\right\|_{H^k(\Omega)} + h_{X,\Omega}^{d/\gamma} \left\|\boldsymbol{g}(X)\right\|_2 \Big)$$

whenever $h_{X,\Omega} \leq h_0$. If the points are quasi-uniform, then there are constants $C_2 = C(k, p, \Omega)$ and $n_0 = C(k, \Omega)$ such that

$$\|g\|_{L^p(\Omega)} \le C \Big(n^{-k/d + (1/2 - 1/p)_+} \|g\|_{H^k(\Omega)} + n^{-1/\gamma} \|g(X)\|_2 \Big)$$

if $n \geq n_0$.

See Wang et al. (2020); Karvonen et al. (2020); Teckentrup (2020); Wynne et al. (2021); and Wang (2021) for a variety of applications of this and related sampling inequalities to error analysis of GP regression.

3.4 The Concentration Function and Small Ball Probabilities

Final ingredients that we need are certain results on the concentration function and small ball probabilities of Gaussian measures. Given $u_0 = \mathcal{L}^{-1} f_0$ for some $f_0 \in \mathcal{H}_{\mathcal{L}}(\Omega)$, define the *concentration function*

$$\phi_{u_0}(\varepsilon) = \gamma_{u_n}(\varepsilon) + \beta(\varepsilon),$$

where

$$\gamma_{u_0}(\varepsilon) = \inf_{u \in \mathcal{H}(K_u, \Omega)} \left\{ \|u\|_{K_u} : \|u - u_0\|_{L^{\infty}(\Omega)} < \varepsilon \right\}$$

and

$$\beta(\varepsilon) = -\log \Pi_u (\{u : ||u||_{L^{\infty}(\Omega)} < \varepsilon\}).$$

Here Π_u denotes the Gaussian probability measure associated to the zero-mean Gaussian process with covariance kernel K_u .

Proposition 3.10. Let $k \geq r > d/2$. Suppose that $\mathcal{H}(K,\Omega) \simeq H^k(\Omega)$, that Assumption 3.3 holds and that $c \leq 0$. If there exists $f_0 \in H^r(\mathbb{R}^d) \cap C^r(\mathbb{R}^d)$ such that $u_0 = \mathcal{L}^{-1} f_0|_{\Omega}$, then there is a constant $C = C(f_0, K, k, r, \Omega, \mathcal{L})$ such that

$$\gamma_{u_0}(\varepsilon) \le C\varepsilon^{-2(k-r)/r}$$

when $\varepsilon < 1$.

Proof. Theorem 3.7 implies that

$$\gamma_{u_0}(\varepsilon) = \inf_{f \in \mathcal{H}(K,\Omega)} \{ \|f\|_K : \|u - u_0\|_{L^{\infty}(\Omega)} < \varepsilon \text{ for } u = \mathcal{L}^{-1}f \}.$$

By Theorem 3.2, whose assumptions are satisfied because $k \geq r \geq 1$, there is $C_1 = C(\Omega, \mathcal{L})$ such that $\|u - u_0\|_{L^{\infty}(\Omega)} \leq C_1 \|f - f_0|_{\Omega}\|_{L^{\infty}(\Omega)}$. Therefore $\|u - u_0\|_{L^{\infty}(\Omega)} < \varepsilon$ if $\|f - f_0|_{\Omega}\|_{L^{\infty}(\Omega)} < \varepsilon C_1^{-1}$, which implies that

$$\gamma_{u_0}(\varepsilon) \le \inf_{f \in \mathcal{H}(K,\Omega)} \{ \|f\|_K : \|f - f_0|_{\Omega}\|_{L^{\infty}(\Omega)} < \varepsilon/C_1 \}.$$

Lemma 4 in van der Vaart and van Zanten (2011) and Lemma 23 in Wynne et al. (2021) bound the right-hand side as

$$\inf_{f \in \mathcal{H}(K,\Omega)} \{ \|f\|_K : \|f - f_0|_{\Omega} \|_{L^{\infty}(\Omega)} < \varepsilon/C_1 \} \le C_2 C_1^{2(k-r)/r} \varepsilon^{-2(k-r)/r}$$

for $C_2 = C(f_0, K, k, r, \Omega)$. This completes the proof.

Let $\varepsilon > 0$. The *metric entropy* of a compact subset A of a metric space $(\mathcal{H}, d_{\mathcal{H}})$ is defined as $H_{\text{ent}}(A, d_{\mathcal{H}}, \varepsilon) = \log N(A, d_{\mathcal{H}}, \varepsilon)$ for the *minimum covering number*

$$N(A, d_{\mathcal{H}}, \varepsilon) = \min \left\{ n \ge 1 : \text{ there exist } x_1, \dots, x_n \in A \text{ s.t. } A \subset \bigcup_{i=1}^n B_{\varepsilon}^{\mathcal{H}}(x_i; \mathcal{H}, d_{\mathcal{H}}) \right\},$$

where $B_{\varepsilon}^{\mathcal{H}}(x;\mathcal{H},d_{\mathcal{H}})$ is the x-centered ε -ball in $(\mathcal{H},d_{\mathcal{H}})$. If $(\mathcal{H},d_{\mathcal{H}})$ is a normed space, we have the scaling identity (e.g., Giné and Nickl, 2015, Equation (4.171))

$$H_{\text{ent}}(\lambda A, d_{\mathcal{H}}, \varepsilon) = H_{\text{ent}}(A, d_{\mathcal{H}}, \varepsilon |\lambda|^{-1})$$
 (3.8)

for any $\lambda \neq 0$.

Lemma 3.11. Let k > d/2. Suppose that $\mathcal{H}(K,\Omega) \simeq H^k(\Omega)$, that Assumption 3.3 holds and that $c \leq 0$. Let B_1^u and B_1^k denote the unit balls of $(\mathcal{H}(K_u,\Omega),\|\cdot\|_{K_u})$ and $(H^k(\Omega),\|\cdot\|_{H^k(\Omega)})$, respectively. Then there is a constant $C = C(K,\Omega,\mathcal{L})$ such that

$$H_{\text{ent}}(B_1^u, \|\cdot\|_{L^{\infty}(\Omega)}, \varepsilon) \le H_{\text{ent}}(B_1^k, \|\cdot\|_{L^{\infty}(\Omega)}, C\varepsilon)$$
(3.9)

Proof. According to Theorem 3.2 and the Sobolev embedding theorem, there is $C_{\infty} = C(\Omega, \mathcal{L})$ such that $\|u\|_{L^{\infty}(\Omega)} \leq C_{\infty} \|f\|_{L^{\infty}(\Omega)}$ for every $f \in H^k(\Omega)$. Let $C_K > 0$ be the norm-equivalence constant in (3.2). Fix $\varepsilon > 0$ and denote $n_{\varepsilon} = N(B^k_{1/C_K}, \|\cdot\|_{L^{\infty}(\Omega)}, \varepsilon \, C_{\infty}^{-1})$ and let $f_1, \ldots, f_{n_{\varepsilon}} \in B^k_1$ be such that

$$B_{1/C_K}\left(0;H^k(\Omega),\left\|\cdot\right\|_{H^k(\Omega)}\right)\subset \bigcup_{i=1}^{n_\varepsilon}B_{\varepsilon/C_\infty}\left(f_i;H^k(\Omega),\left\|\cdot\right\|_{L^\infty(\Omega)}\right).$$

Then

$$\mathcal{L}^{-1}B_{1/C_K}\left(0; H^k(\Omega), \|\cdot\|_{H^k(\Omega)}\right) \subset \bigcup_{i=1}^{n_{\varepsilon}} \mathcal{L}^{-1}B_{\varepsilon/C_{\infty}}\left(f_i; H^k(\Omega), \|\cdot\|_{L^{\infty}(\Omega)}\right). \tag{3.10}$$

Because $\|u\|_{K_u} = \|f\|_K \ge C_K \|f\|_{H^k(\Omega)}$ by Theorem 3.7 and $\|u\|_{L^\infty(\Omega)} \le C_\infty \|f\|_{L^\infty(\Omega)}$, we have

$$B_1(0; \mathcal{H}(K_u, \Omega), \|\cdot\|_{K_u}) \subset \mathcal{L}^{-1}B_{1/C_K}(0; H^k(\Omega), \|\cdot\|_{H^k(\Omega)})$$

and

$$\mathcal{L}^{-1}B_{\varepsilon/C_{\infty}}(f_i; H^k(\Omega), \|\cdot\|_{L^{\infty}(\Omega)}) \subset B_{\varepsilon}(u_i; \mathcal{H}(K_u, \Omega), \|\cdot\|_{L^{\infty}(\Omega)}),$$

where $u_i = \mathcal{L}^{-1} f_i$. Applying these two inclusion relations to (3.10) and using the definition of metric entropy, together with (3.8), yields the claim.

Proposition 3.12. Let k > d/2. Suppose that $\mathcal{H}(K,\Omega) \simeq H^k(\Omega)$, that Assumption 3.3 holds and that $c \leq 0$. Let B_1^u denote the unit ball of $(\mathcal{H}(K_u,\Omega),\|\cdot\|_{K_u})$. Then there is a positive constant C, which does not depend on ε , such that

$$\beta(\varepsilon) < C\varepsilon^{-2d/(2k-d)}$$

for ε < 1.

Proof. It is a standard result that the metric entropy of the unit ball of $H^k(\Omega)$ in Lemma 3.11 satisfies

$$H_{\text{ent}}(B_1^k, \|\cdot\|_{L^{\infty}(\Omega)}, \varepsilon) \leq C_{\text{ent}} \varepsilon^{-d/k}$$

for a positive constant $C_{\rm ent}=C(k)$ and any $\varepsilon<1$. See, for instance, Theorem 4.3.36 in Giné and Nickl (2015), Theorem 3.3.2 in Edmunds and Triebel (1996), the proof of Lemma 3 in van der Vaart and van Zanten (2011) and Appendix F in Wynne et al. (2021). It follows from Equation (3.9) that

$$H_{\text{ent}}(B_1^u, \|\cdot\|_{L^{\infty}(\Omega)}, \varepsilon) \le C_{\text{ent}} \varepsilon^{-d/k}.$$
 (3.11)

According to Theorem 1.2 in Li and Linde (1999), the estimate (3.11) implies that

$$\beta(\varepsilon) \le C\varepsilon^{-2d/(2k-d)}$$

for a positive constant C which does not depend on ε .

A combination of Propositions 3.10 and 3.12 yields an estimate for $\phi_{u_0}(\varepsilon)$. Define the function

$$\psi_{u_0}(\varepsilon) = \frac{\phi_{u_0}(\varepsilon)}{\varepsilon^2}$$

and let $\psi_{u_0}^{-1}(n) = \sup\{\varepsilon > 0 : \psi_{u_0}(\varepsilon) \ge n\}$ denote its (generalised) inverse.

Theorem 3.13. Let $k \geq r > d/2$. Suppose that $\mathcal{H}(K,\Omega) \simeq H^k(\Omega)$, that Assumption 3.3 holds and that $c \leq 0$. If there exists $f_0 \in H^r(\mathbb{R}^d) \cap C^r(\mathbb{R}^d)$ such that $u_0 = \mathcal{L}^{-1} f_0|_{\Omega}$, then there is a positive constant C, which does not depend on ε , such that

$$\psi_{u_0}^{-1}(n) \le C n^{-\min\{r,k-d/2\}/(2k)}$$

for any sufficiently large n > 0.

Proof. By Propositions 3.10 and 3.12,

$$\psi_{u_0}(\varepsilon) \le C_1 \left(\varepsilon^{-2(k-r)/r-2} + \varepsilon^{-2d/(2k-d)-2} \right) \le C \varepsilon^{-2k/\min\{r,k-d/2\}}$$

whenever $\varepsilon<1.$ It follows from the definition of $\psi_{u_0}^{-1}$ that

$$\psi_{u_0}^{-1}(n) \le C_2 n^{-\min\{r,k-d/2\}/(2k)}$$

for
$$C_2 = C_1^{\min\{r, k - d/2\}/(2k)}$$
.

4 Error Estimates

This section contains the main results of this article. The results provide rates of contraction, as $n \to \infty$, of the expectation (with respect to the observation noise distribution) of the $L^2(\Omega)$ -norm between the true source term u_t and the GP conditional means in (2.9a), (2.10a) and (2.13a). Given an n-vector \mathbf{Z} , we employ the interpolation operator notation

$$I_X(\mathbf{Z})(\mathbf{x}) = \mathbf{K}_u(\mathbf{x}, X)^{\mathsf{T}} (\mathbf{K}_u(X, X) + \sigma_{\varepsilon}^2 \mathbf{I}_n)^{-1} \mathbf{Z}.$$
(4.1)

That is, the ideal conditional mean can be written as

$$m_{u|\mathbf{Y}} = m_u - I_X(\mathbf{m}_u(X)) + I_X(\mathbf{Y}). \tag{4.2}$$

4.1 Exact Posterior

Our first result concerns an idealised statFEM where no finite element discretisation is used. The relevant posterior moments are given in (2.9).

Theorem 4.1. Let k > d/2 and suppose that Assumption 3.3 holds and $c \leq 0$. If $\mathcal{H}(K,\Omega) \simeq H^k(\Omega)$, $m \in H^k(\Omega)$ and $f_t \in H^k(\Omega) \cap C^k(\Omega)$, then there are positive constants C_1 and h_0 , which do not depend on X, such that

$$\mathbb{E}\left[\|u_t - m_{u|\mathbf{Y}}\|_{L^2(\Omega)}\right] \le C_1 \left(h_{X,\Omega}^{k+2} \sqrt{n} + h_{X,\Omega}^{d/2} n^{d/(4k)}\right)$$
(4.3)

whenever $h_{X,\Omega} \leq h_0$. If the points are quasi-uniform, there are positive constant C_2 and n_0 , which do not depend on X, such that

$$\mathbb{E}[\|u_t - m_{u|\mathbf{Y}}\|_{L^2(\Omega)}] \le C_2 n^{-1/2 + d/(4k)}$$
(4.4)

if $n \geq n_0$.

Proof. By Theorems 3.1 and 3.7, $u_k, m_u \in \mathcal{H}(K_u, \Omega) \subset H^{k+2}(\Omega)$. Therefore it follows from Theorem 3.9 with p=2 and $g=u_t-m_{u|\mathbf{Y}}$ that there are constants C_1 and $h_0=C(k,\Omega)$, which do not depend on X, such that

$$\|u_{t} - m_{u|\mathbf{Y}}\|_{L^{2}(\Omega)} \le C_{1} \left(h_{X,\Omega}^{k+2} \|u_{t} - m_{u|\mathbf{Y}}\|_{H^{k+2}(\Omega)} + h_{X,\Omega}^{d/2} \|\mathbf{u}_{t}(X) - \mathbf{m}_{u|\mathbf{Y}}(X)\|_{2} \right)$$
(4.5)

whenever $h_{X,\Omega} \leq h_0$. The decomposition in (4.2) gives

$$\|u_t - m_{u|\mathbf{Y}}\|_{H^{k+2}(\Omega)} \le \|u_t - I_X(\mathbf{Y})\|_{H^{k+2}(\Omega)} + \|m_u - I_X(\mathbf{m}_u(X))\|_{H^{k+2}(\Omega)}.$$
 (4.6)

The triangle inequality and Lemma 17 in Wynne et al. (2021), in combination with (3.6), yield

$$||u_{t} - I_{X}(\boldsymbol{Y})||_{H^{k+2}(\Omega)} \leq C_{u}^{-1} C_{u}' (||u_{t}||_{H^{k+2}(\Omega)} + ||I_{X}(\boldsymbol{Y})||_{H^{k+2}(\Omega)})$$

$$\leq C_{u}^{-1} C_{u}' (2||u_{t}||_{H^{k+2}(\Omega)} + \sigma_{\varepsilon}^{-1} ||\boldsymbol{\varepsilon}||_{2}),$$
(4.7)

where $\boldsymbol{\varepsilon} = (\varepsilon_1, \dots, \varepsilon_n) \in \mathbb{R}^n$ is the noise vector. The second term in (4.6) has the bound

$$\|m_u - I_X(\mathbf{m}_u(X))\|_{H^{k+2}(\Omega)} \le 2C_u^{-1}C_u' \|m_u\|_{H^{k+2}(\Omega)},$$
 (4.8)

which is obtained in the same way as (4.7) but with ε set as the zero vector. From Theorem 22 in Wynne et al. (2021) and Theorem 3.13 with r=k and $f_0=f_t$ (i.e., $u_0=u_t$ and $\min\{r,k-d/2\}=k-d/2$) we get

$$\mathbb{E}\left[\|\boldsymbol{u}_{t}(X) - \boldsymbol{m}_{u|\boldsymbol{Y}}(X)\|_{2}\right] \leq C_{2}\sqrt{n}\psi_{u_{t}}^{-1}(n) \leq C_{2}C_{3}n^{d/(4k)}$$
(4.9)

for positive constants C_2 and C_3 which do not depend on X. Inserting the estimates (4.7)–(4.9) into (4.5) and using the bound $\sigma_{\varepsilon}^{-1}\mathbb{E}[\|\boldsymbol{\varepsilon}\|_2] \leq \sqrt{n}$, which follows from the Gaussianity of the noise terms, yields

$$\begin{split} \mathbb{E} \big[\left\| u_t - m_{u|\mathbf{Y}} \right\|_{L^2(\Omega)} \big] &\leq 2C_1 C_u^{-1} C_u' h_{X,\Omega}^{k+2} \big(\left\| u_t \right\|_{H^{k+2}(\Omega)} + \left\| m_u \right\|_{H^{k+2}(\Omega)} \big) \\ &\quad + C_1 C_u^{-1} C_u' h_{X,\Omega}^{k+2} \sigma^{-1} \left\| \boldsymbol{\varepsilon} \right\|_2 + C_1 C_2 C_3 h_{X,\Omega}^{d/2} n^{d/(4k)} \\ &\leq 2C_1 C_u^{-1} C_u' h_{X,\Omega}^{k+2} \big(\left\| u_t \right\|_{H^{k+2}(\Omega)} + \left\| m_u \right\|_{H^{k+2}(\Omega)} \big) \\ &\quad + C_1 C_u^{-1} C_u' h_{X,\Omega}^{k+2} \sqrt{n} + C_1 C_2 C_3 h_{X,\Omega}^{d/2} n^{d/(4k)}. \end{split}$$

This concludes the proof of (4.3) while (4.4) follows from $h_{X,\Omega} \leq C_{qu} n^{-1/d}$.

Remark 4.2. The mini-max optimal rate for regression in $H^k(\Omega)$ is $n^{-k/(2k+d)}$ (Tsybakov, 2009, Chapter 2). Since

$$\frac{1}{2} - \frac{d}{4k} \le \frac{1}{2} - \frac{d}{4k + 2d} = \frac{k}{2k + d},$$

the rate (4.4) that we have proved is slightly sub-optimal.

4.2 Finite Element Posterior

Next we turn to the analysis the effect of finite element discretisation and consider the posterior moments in (2.10). The following proposition allows us to make use of Assumption 2.1 on the error of the finite element discretisation. Although this basic proposition must have appeared several times and in various forms in the literature on scalable approximations for GP regression, we have not been able to locate a convenient reference for it.

Proposition 4.3. Let R_1 and R_2 be any positive-semidefinite kernels, $\sigma > 0$, and $\mathbf{Z} \in \mathbb{R}^n$. If

$$\sup_{oldsymbol{x},oldsymbol{y}\in\Omega}|R_1(oldsymbol{x},oldsymbol{y})-R_2(oldsymbol{x},oldsymbol{y})|=\delta$$

for some $\delta > 0$, then the functions

$$m_{|\mathbf{Z}}^{1}(\mathbf{x}) = \mathbf{R}_{1}(\mathbf{x}, X) (\mathbf{R}_{1}(X, X) + \sigma^{2} \mathbf{I}_{n})^{-1} \mathbf{Z},$$

 $m_{|\mathbf{Z}}^{2}(\mathbf{x}) = \mathbf{R}_{2}(\mathbf{x}, X) (\mathbf{R}_{2}(X, X) + \sigma^{2} \mathbf{I}_{n})^{-1} \mathbf{Z}.$

satisfy

$$\sup_{\boldsymbol{x} \in \Omega} |m_{|\boldsymbol{Z}}^{1}(\boldsymbol{x}) - m_{|\boldsymbol{Z}}^{2}(\boldsymbol{x})| \le ||\boldsymbol{Z}||_{2} (\delta + C\sigma^{-2})\sigma^{-2}\delta n, \tag{4.10}$$

where $C = \sup_{\boldsymbol{x}, \boldsymbol{y} \in \Omega} |R_2(\boldsymbol{x}, \boldsymbol{y})|$.

Proof. Write

$$\begin{split} |m_{|\boldsymbol{Z}}^{1}(\boldsymbol{x}) - m_{|\boldsymbol{Z}}^{2}(\boldsymbol{x})| \\ &= \left| \boldsymbol{Z}^{\mathsf{T}} \left[\left(\boldsymbol{R}_{1}(X, X) + \sigma^{2} \boldsymbol{I}_{n} \right)^{-1} \boldsymbol{R}_{1}(\boldsymbol{x}, X) - \left(\boldsymbol{R}_{2}(X, X) + \sigma^{2} \boldsymbol{I}_{n} \right)^{-1} \boldsymbol{R}_{2}(\boldsymbol{x}, X) \right] \right| \\ &\leq \left\| \boldsymbol{Z} \right\|_{2} \left\| \left(\boldsymbol{R}_{1}(X, X) + \sigma^{2} \boldsymbol{I}_{n} \right)^{-1} \boldsymbol{R}_{1}(\boldsymbol{x}, X) - \left(\boldsymbol{R}_{2}(X, X) + \sigma^{2} \boldsymbol{I}_{n} \right)^{-1} \boldsymbol{R}_{2}(\boldsymbol{x}, X) \right\|. \end{split}$$

Let $R(\pmb{x},\pmb{y})=R_1(\pmb{x},\pmb{y})-R_2(\pmb{x},\pmb{y})$ so that $\sup_{\pmb{x},\pmb{y}\in\Omega}|R(\pmb{x},\pmb{y})|=\delta$ and

$$\begin{split} &\| \big(\boldsymbol{R}_{1}(X,X) + \sigma^{2} \boldsymbol{I}_{n} \big)^{-1} \boldsymbol{R}_{1}(\boldsymbol{x},X) - \big(\boldsymbol{R}_{2}(X,X) + \sigma^{2} \boldsymbol{I}_{n} \big)^{-1} \boldsymbol{R}_{2}(\boldsymbol{x},X) \| \\ &= \left\| \big(\boldsymbol{R}_{2}(X,X) + \boldsymbol{R}(X,X) + \sigma^{2} \boldsymbol{I}_{n} \big)^{-1} (\boldsymbol{R}(\boldsymbol{x},X) + \boldsymbol{R}_{2}(\boldsymbol{x},X)) \\ &- \big(\boldsymbol{R}_{2}(X,X) + \sigma^{2} \boldsymbol{I}_{n} \big)^{-1} \boldsymbol{R}_{2}(\boldsymbol{x},X) \| \\ &\leq \left\| \left[\big(\boldsymbol{R}_{2}(X,X) + \boldsymbol{R}(X,X) + \sigma^{2} \boldsymbol{I}_{n} \big)^{-1} - \big(\boldsymbol{R}_{2}(X,X) + \sigma^{2} \boldsymbol{I}_{n} \big)^{-1} \right] \boldsymbol{R}_{2}(\boldsymbol{x},X) \| \\ &+ \left\| \big(\boldsymbol{R}_{2}(X,X) + \boldsymbol{R}(X,X) + \sigma^{2} \boldsymbol{I}_{n} \big)^{-1} \boldsymbol{R}(\boldsymbol{x},X) \| \\ &\leq \sqrt{n} C \| \left[\big(\boldsymbol{R}_{2}(X,X) + \boldsymbol{R}(X,X) + \sigma^{2} \boldsymbol{I}_{n} \big)^{-1} - \big(\boldsymbol{R}_{2}(X,X) + \sigma^{2} \boldsymbol{I}_{n} \big)^{-1} \| \\ &+ \sqrt{n} \delta \| \big(\boldsymbol{R}_{2}(X,X) + \boldsymbol{R}(X,X) + \sigma^{2} \boldsymbol{I}_{n} \big)^{-1} \| \, . \end{split}$$

Since $\mathbf{R}_1(X,X) = \mathbf{R}_2(X,X) + \mathbf{R}(X,X)$ is positive-semidefinite, the largest singular value of the matrix $(\mathbf{R}_2(X,X) + \mathbf{R}(X,X) + \sigma^2 \mathbf{I}_n)^{-1}$ is $(\sigma^2 + \lambda_{\min}(\mathbf{R}_1(X,X)))^{-1}$. Therefore

$$\sqrt{n}\delta \| (\mathbf{R}_2(X,X) + \mathbf{R}(X,X) + \sigma^2 \mathbf{I}_n)^{-1} \| = \sqrt{n}\delta (\sigma^2 + \lambda_{\min}(\mathbf{R}_1(X,X)))^{-1} \le \sqrt{n}\sigma^{-2}\delta.$$

Finally,

$$\begin{split} & \left\| \left(\boldsymbol{R}_{2}(\boldsymbol{X}, \boldsymbol{X}) + \boldsymbol{R}(\boldsymbol{X}, \boldsymbol{X}) + \sigma^{2} \boldsymbol{I}_{n} \right)^{-1} - \left(\boldsymbol{R}_{2}(\boldsymbol{X}, \boldsymbol{X}) + \sigma^{2} \boldsymbol{I}_{n} \right)^{-1} \right\| \\ & = \left\| \left(\boldsymbol{R}_{2}(\boldsymbol{X}, \boldsymbol{X}) + \boldsymbol{R}(\boldsymbol{X}, \boldsymbol{X}) + \sigma^{2} \boldsymbol{I}_{n} \right)^{-1} \boldsymbol{R}(\boldsymbol{X}, \boldsymbol{X}) \left(\boldsymbol{R}_{2}(\boldsymbol{X}, \boldsymbol{X}) + \sigma^{2} \boldsymbol{I}_{n} \right)^{-1} \right\| \\ & \leq \left\| \boldsymbol{R}(\boldsymbol{X}, \boldsymbol{X}) \right\| \left\| \left(\boldsymbol{R}_{2}(\boldsymbol{X}, \boldsymbol{X}) + \boldsymbol{R}(\boldsymbol{X}, \boldsymbol{X}) + \sigma^{2} \boldsymbol{I}_{n} \right)^{-1} \right\| \left\| \left(\boldsymbol{R}_{2}(\boldsymbol{X}, \boldsymbol{X}) + \sigma^{2} \boldsymbol{I}_{n} \right)^{-1} \right\| \\ & \leq \sqrt{n} \sigma^{-4} \delta. \end{split}$$

The claim follows by putting these estimates together.

A straightforward combination of Theorem 4.1 and Proposition 4.3 yields an error estimate that combines the errors from GP regression and finite element discretisation.

Theorem 4.4. Let k > d/2. Suppose that Assumptions 2.1 and 3.3 hold and that $c \le 0$. If $\mathcal{H}(K,\Omega) \simeq H^k(\Omega)$, $m \in H^k(\Omega)$, $f_t \in H^k(\Omega) \cap C^k(\Omega)$ and the points are quasi-uniform, then there are positive constant C and n_0 , which do not depend on X, such that

$$\mathbb{E}\left[\|u_{t} - m_{u|\mathbf{Y}}^{\text{FE}}\|_{L^{2}(\Omega)}\right] \le C\left(n^{-1/2 + d/(4k)} + \sigma_{\varepsilon}^{-1} n_{\text{FE}}^{-q} n^{3/2}\right)$$
(4.11)

if $n \geq n_0$.

Proof. The triangle inequality yields

$$\|u_t - m_{u|\mathbf{Y}}^{\text{FE}}\|_{L^2(\Omega)} \le \|u_t - m_{u|\mathbf{Y}}\|_{L^2(\Omega)} + \|m_{u|\mathbf{Y}} - m_{u|\mathbf{Y}}^{\text{FE}}\|_{L^2(\Omega)}.$$
 (4.12)

Theorem 4.1 bounds the expectation of the first term as

$$\mathbb{E}[\|u_t - m_{u|\mathbf{Y}}\|_{L^2(\Omega)}] \le C_1 n^{-1/2 + d/(4k)}$$
(4.13)

for a constant $C_1 > 0$, while Proposition 4.3 and Assumption 2.1 give

$$\left\|m_{u|\mathbf{Y}}-m_{u|\mathbf{Y}}^{\mathrm{FE}}\right\|_{L^{2}(\Omega)}\leq C_{2}\left\|\mathbf{Y}\right\|_{2}(n_{\mathrm{FE}}^{-q}+\sigma_{\varepsilon}^{-2})\sigma_{\varepsilon}^{-2}n_{\mathrm{FE}}^{-q}n\leq C_{2}(1+\sigma_{\varepsilon}^{-2})\sigma_{\varepsilon}^{-2}\left\|\mathbf{Y}\right\|_{2}n_{\mathrm{FE}}^{-q}n$$

for a constant $C_2 > 0$. Since

$$\mathbb{E}[\|\boldsymbol{Y}\|_{2}] \leq \|\boldsymbol{u}_{t}(X)\|_{2} + \mathbb{E}[\|\boldsymbol{\varepsilon}\|_{2}] \leq \|u_{t}\|_{L^{\infty}(\Omega)} + \sigma_{\varepsilon}\sqrt{n},$$

we obtain

$$\mathbb{E}\left[\left\|m_{u|\mathbf{Y}} - m_{u|\mathbf{Y}}^{\text{FE}}\right\|_{L^{2}(\Omega)}\right] \le C_{3}\sigma_{\varepsilon}^{-1}n_{\text{FE}}^{-q}n^{3/2} \tag{4.14}$$

for a constant $C_3 > 0$. Taking expectation of (4.12) and using the bounds (4.13) and (4.14) concludes the proof.

Remark 4.5. To obtain the best possible rate of convergence in terms of n in (4.11), we can set

$$n_{\rm FE} = n^{(2-d/(4k))/q}. (4.15)$$

This selection yields the error estimate

$$\mathbb{E}\left[\|u_t - m_{u|\mathbf{Y}}^{\text{FE}}\|_{L^2(\Omega)} \right] \le C\left(n^{-1/2 + d/(4k)} + \sigma_{\varepsilon}^{-1} n_{\text{FE}}^{-q} n^{3/2}\right) = C(1 + \sigma_{\varepsilon}^{-1}) n^{-1/2 + d/(4k)},$$

which is, up to a constant factor, equal to the bound in (4.4).

The relationship (4.15) between n and $n_{\rm FE}$ gives some guidance for selecting the number of finite elements given the measurement data. For example, in one dimension one has q=2 for Poisson's equation and piecewise linear finite elements on a regular grid so that $n_{\rm FE}$ should be approximately $n^{1-1/(8k)}$. Practical application of such guidelines is likely to be difficult because, while (4.15) yields the best possible polynomial rate in (4.11), what one would actually like to obtain is the smallest possible right-hand side in (4.11). But to set $n_{\rm FE}$ so that the right-hand side is minimised is not possible because the constant factors involved are rarely, if ever, available (e.g., some of them depend on the constant in the Sobolev embedding theorem).

4.3 Inclusion of a Discrepancy Term

Finally, we consider inclusion of a discrepancy term as described in Section 2.3. The following two theorems concern the posterior means in (2.12a) and (2.13a).

Theorem 4.6. Let $k_1 \ge r - 2 \ge k_2 > d/2$ and suppose that Assumption 3.3 holds with $k = k_1$ and $c \le 0$. If $\mathcal{H}(K,\Omega) \simeq H^{k_1}(\Omega)$, $\mathcal{H}(K_d,\Omega) \simeq H^r(\Omega)$, $m_d \in H^{k_2+2}(\Omega)$, $m \in H^{k_2}(\Omega)$ and $f_t \in H^{k_2}(\Omega) \cap C^{k_2}(\Omega)$, then there are positive constants C_1 and h_0 , which do not depend on X, such that

$$\mathbb{E}\left[\|u_t - m_{d;u|\mathbf{Y}}\|_{L^2(\Omega)}\right] \le C_1 \left(h_{X,\Omega}^{k_2+2} \rho_{X,\Omega}^{r-k_2-2} + \sqrt{n} h_{X,\Omega}^r + n^{\kappa(k_2,r)} h_{X,\Omega}^{d/2}\right)$$
(4.16)

whenever $h_{X,\Omega} \le h_0$. The constant $\kappa(k_2,r) \le 1/2$ is given in (4.18). If the points are quasi-uniform, there are positive constant C_2 and n_0 , which do not depend on X, such that

$$\mathbb{E}\left[\|u_t - m_{d;u|\mathbf{Y}}\|_{L^2(\Omega)}\right] \le C_2 \left(n^{-(k_2+2)/d} + n^{-r/d+1/2} + n^{-1/2+\kappa(k_2,r)}\right)$$
(4.17)

if $n \geq n_0$.

Proof. By Theorem 3.7, the norm-equivalence assumption and the assumption that $k_1+2\geq r$, it holds that $\mathcal{H}(K_u,\Omega)\subset H(K_d,\Omega)$. From this inclusion, Theorem 3.8 and (3.6) it follows that $\mathcal{H}(K_{ud},\Omega)\simeq H^r(\Omega)$. By Theorem 3.7 and our assumptions, the functions m_d , m_u and u_t are in $H^{k_2+2}(\Omega)$ and $r\geq k_2+2$. We can therefore apply Theorem 2 in Wynne et al. (2021) with

$$k = K_{ud}, \quad f = u_t, \quad \tau_k^- = \tau_k^+ = r, \quad \tau_f = k_2 + 2, \quad s = 0, \quad \text{ and } \quad q = 2.$$

This yields the estimate

$$\begin{split} \mathbb{E} \big[\left\| u_t - m_{d;u|\mathbf{Y}} \right\|_{L^2(\Omega)} \big] &\leq C h_{X,\Omega}^{d/2} \big(h_{X,\Omega}^{k_2 + 2 - d/2} \rho_{X,\Omega}^{r - k_2 - 2} + \sqrt{n} h_{X,\Omega}^{r - d/2} + n^{\kappa} \big) \\ &= C \big(h_{X,\Omega}^{k_2 + 2} \rho_{X,\Omega}^{r - k_2 - 2} + \sqrt{n} \, h_{X,\Omega}^{r} + n^{\kappa(k_2,r)} h_{X,\Omega}^{d/2} \big), \end{split}$$

where

$$\kappa(k_2, r) = \max\left\{\frac{1}{2} - \frac{k_2 + 2}{2r}, \frac{d}{4(k_2 + 2)}\right\} \le \frac{1}{2},$$
(4.18)

for a positive constant C, which does not depend on X, and any sufficiently small $h_{X,\Omega}$. This proves (4.16) while (4.17) follows from $h_{X,\Omega} \leq C_{\text{qu}} n^{-1/d}$ and the fact that the mesh ratio $\rho_{X,\Omega}$ is bounded for quasi-uniform points.

Theorem 4.7. Let $k_1 \geq r-2 \geq k_2 > d/2$. Suppose that Assumptions 2.1 and 3.3 (with $k=k_1$) hold and that $c \leq 0$. If $\mathcal{H}(K,\Omega) \simeq H^{k_1}(\Omega)$, $\mathcal{H}(K_d,\Omega) \simeq H^r(\Omega)$, $m_d \in H^{k_2+2}(\Omega)$, $m \in H^{k_2}(\Omega)$, $f_t \in H^{k_2}(\Omega) \cap C^{k_2}(\Omega)$ and the points are quasi-uniform, then there are positive constants C and n_0 , which do not depend on X, such that

$$\mathbb{E}\left[\|u_t - m_{d;u|\mathbf{Y}}^{\text{FE}}\|_{L^2(\Omega)}\right] \le C\left(n^{-(k_2+2)/d} + n^{-r/d+1/2} + n^{-1/2+\kappa(k_2,r)} + \sigma_{\varepsilon}^{-1}n_{\text{FE}}^{-q}n^{3/2}\right)$$
(4.19)

if $n \ge n_0$. The constant $\kappa(k_2, r) \le 1/2$ is given in (4.18).

Proof. The proof is identical to that of Theorem Theorem 4.4 expect that the bound (4.17) is used in place of (4.4).

Unlike the results in Sections 4.1 and 4.2, these theorems are valid also when the smoothness of the source term is *misspecified*. That is, in Theorems 4.6 and 4.7 it is possible that k_1 , the smoothness of the kernel K which specifies the prior for source term, is larger than the smoothness, k_2 , of the true source term f_t . Such misspecification results for GP regression in different settings can be found in, for example, Karvonen et al. (2020); Kanagawa et al. (2020); Teckentrup (2020); and Wynne et al. (2021).

5 Numerical Example

In this section we investigate the convergence of the posterior mean $m_{u|Y}^{\text{FE}}$ to the true system response u_t for different values of the kernel smoothness parameter k. We consider the one-dimensional Poisson's equation

$$-u'' = f$$
 in $\Omega = (0,1)$ and $u(0) = u(1) = 0.$ (5.1)




Figure 3: The statFEM conditional mean (blue) and 95% credible interval given some noisy data (red points). The dashed black line is the true system response.

The true source term is set as the constant function

$$f_t(x) = \frac{\pi^2}{5}\sin(\pi x) + \frac{49\pi^2}{50}\sin(7\pi x). \tag{5.2}$$

The respective true system response is given in closed form by

$$u_t(x) = \frac{1}{5}\sin(\pi x) + \frac{1}{50}\sin(7\pi x).$$

A similar example was used in Girolami et al. (2021).

For the source term, we use a zero-mean Gaussian prior $f_{GP} \sim GP(0, K)$ with the Matérn covariance kernel (2.5). The three kernel hyperparameters are chosen as

$$(\ell,\sigma^2) \in \left\{ (1/2,120), (1,100) \right\} \quad \text{ and } \quad \nu \in \left\{ \frac{1}{2}, \frac{3}{2}, \frac{5}{2}, \frac{7}{2} \right\}.$$

As explained in Section 3.2, the values of ν correspond to the values $k \in \{1,2,3,4\}$ of the RKHS smoothness parameter. The values for σ are selected such that the maximum of K_u is on average one (see Figure 1). For each k, the true source term in (5.2) is an element of the RKHS and of $C^k(\Omega)$. The selection of the hyperparameters can be automated by considering the marginal likelihood or cross-validation (Rasmussen and Williams, 2006, Chapter 5). For finite element analysis we use the standard piecewise linear basis functions centered at $n_{\rm FE} \in \{2048, 4096\}$ uniformly placed points on $\Omega = (0,1)$. To compute the conditional mean $m_{u|Y}^{\rm FE}$, we use the approximation in (2.11); see Girolami et al. (2021, Section 2.2) for more details. Observations of u_t at $n \in \{2^1-1, 2^2-1, \ldots, n_{\rm FE}-1\}$ uniformly placed points are corrupted by Gaussian noise with variance $\sigma_{\varepsilon}^2 = 10^{-6}$. The true system response and the finite element approximation to the conditional mean $m_{u|Y}^{\rm FE}$ and the corresponding 95% credible interval are shown in Figure 3 for $\nu = 1/2$, $\ell = 1/2$, $\sigma^2 = 100$, $n_{\rm FE} = 2048$, and n = 7.




Figure 4: L^2 -approximation errors predicted by Theorem 4.4 (where it is assumed that the second term is negligible) and their empirical approximations over 100 noise realisations for the Poisson's equation (5.1) with the true source term (5.2). Each plot depicts the decay of the L^2 -error as n, the number of observations, increases for fixed number of the FE points $n_{\rm FE}$ and kernel smoothness parameter ν . The green curves correspond to purely data-driven standard GP regression using a Matérn kernel and the orange curves to statFEM using the PDE induced kernel. For statFEM ν is the smoothness of the kernel of the prior for $f_{\rm GP}$ while for GP regression the Matérn prior for u_t has smoothness $\nu + 2$, scaling $\sigma_{\rm Matérn} = 1$ and $\ell_{\rm Matérn} = 1$.

Convergence results are depicted in Figure 4 and compared to the rate predicted by Theorem 4.4, assuming that the term $\sigma_{\varepsilon}^{-1} n_{\rm FE}^{-q} n^{3/2}$ can be neglected. Note that the values of σ and ℓ do not affect the rate predicted by the theorem but only the constants C and n_0 . In these results the L^2 -norm is approximated by numerical quadrature and the expectation by an average over 100 independent observation noise realisations. For each ν and $n_{\rm FE}$ we also plot the L^2 -error of standard GP regression when u_t is directly modelled as a purely data-driven GP whose kernel is a Matérn with smoothnes $\nu+2$ and parameters $\sigma_{\rm Matérn}=1$ and $\ell_{\rm Matérn}=1$. The selection of the smoothness parameter of the Matérn prior for u_t corresponds to the smoothness of the induced prior $u_{\rm GP}$ in statFEM. Furthermore, the choice of $\sigma^2 \in \{120, 100\}$ for $u_{\rm GP}$ in statFEM and $\sigma_{\rm Matérn}=1$ ensures that the respective priors have similar scaling. Being purely data-driven, this Matérn model for u_t does not incorporate the boundary conditions. In the present example the boundary conditions could be easily included by conditioning on the non-noisy data $u_t(0)=u_t(1)=1$, but in higher dimensions such an approach would not work.

From the convergence plots we observe that for well-chosen kernel parameters ($\ell=1/2$ and $\sigma^2=120$) statFEM can outperform the data-driven Matérn model. Even for $\ell=1$ and $\sigma^2=100$ statFEM outperforms the Matérn model when there are only few data points, which is not unexpected given that the Matérn model

does not encode any properties of the PDE. In practice, we expect, especially for higher dimensions, that the number of data points will be significantly smaller than the number of finite element nodes so that it will become even more important to encode the PDE and its boundary conditions. For $\nu=1/2$ and $\nu=3/2$ the convergence rate of the statFEM appears to be slightly faster than we have been able to prove (for $\nu=7/2$, $\ell=1$, and $\sigma^2=100$ it may be that $n_{\rm FE}$ and n are not sufficiently large for the correct convergence rate to manifest). It is clear that analysis of the effect of estimation of the hyperparameters σ and ℓ should be included in any future work.

6 Concluding Remarks

We have analysed a particular formulation of the statFEM approach in a *deterministic* setting with *generic* points and finite elements. A different set of assumptions could be equally well used—the practical relevance of these assumptions would likely depend much on the application and whether or not the user views the data-generating process as an actual Gaussian process or some unknown deterministic function. Settings that we believe could or could not be analysed using similar or related techniques as those in this article include the following:

- We have considered a "mixed" case in which a GP is used to model a deterministic function. But one could alternatively assume that f_t , and consequently u_t , is a GP (or some other stochastic process) and proceed from there. This is how statFEM is formulated in Girolami et al. (2021).
- Distribution of the points x_1, \ldots, x_n where the measurement data are obtained is quite generic in this article in that no reference is made to how these points might be selected or sampled and all results are formulated in terms of the fill-distance $h_{X,\Omega}$ or, in the quasi-uniform case, n. In applications the points may be sampled randomly from some distribution on Ω . We refer to Briol et al. (2019, Theorem 1) for a related result concerning random points.
- To remove the assumption that the measurement data are noisy is likely to be challenging if one is interested in including the effect of the finite element discretisation. It is straightforward to derive versions of Theorems 4.1 and 4.6 in the noiseless case, but no other result in Section 4 generalises readily. The reason is the presence of the factor σ^{-2} in (4.10) which is used to prove all theorems concerning finite element discretisations: if $\sigma = 0$, this bound is rendered meaningless.
- As already mentioned in Section 4.2, the bounds include a variety of non-explicit constants. We do not believe that the constants are computable in all but perhaps the simplest of special cases.
